# Lt Gen Manoj Pande to be next Army chief

NEW DELHI, April 18 (PTI): Lt Gen Manoj Pande will take the reins as the 29th chief of the Army Staff after incumbent Gen MM Naravane's tenure ends on April 30. Lt Gen Pande, currently serving as the vice chief, will become the first commander from the Corps of Engineers to take charge of the 1.3-million-strong force as the position has been held so far by officers from infantry, artillery and armoured regiments.

Before taking charge as the vice chief of the Army Staff on February 1, he was heading the Eastern Army Command tasked with guarding the Line of Actual Control (LAC) in the Sikkim and Arunachal Pradesh sectors. Officials said the Appointments

anti-terrorism court in Pakistan's Punjab province on Monday sentenced six people to death and nine others to life imprisonment for their involvement in the lynching of a Sri Lankan national over alleged blasphemy.

Anti-Terrorism Court Lahore Judge Natasha Nasim also handed down two-year rigorous imprisonment each to 72 accused persons, including nine juveniles. The judge, who held the trial

proceedings in-camera inside the high-security Kot Lakhpat Jail here on a day-to-day basis, sentenced one accused - Ali Asghar - to 5 years in jail while acquitted another suspect - identified as Bilal.

A mob of over 800 men including supporters of radical Islamist party Tehreek-e-Labbaik Pakistan allegedly attacked a garment fac-

ager Priyantha Kumara, 47, and burned his body over allegations of blasphemy on December 3, in Sialkot district, some 100 kms from provincial capital Lahore.

The incident saw widespread outrage and condemnation across Pakistan with politicians, scholars and civil society members calling for swift punishment to be meted out to the perpetrators.

"Of the total 89 suspects, the ATC today announced its verdict handing down death sentence to six, life imprisonment to nine and two years jail term each to remaining 72 accused for their involvement in lynching and burning the Sri Lankan national," a court official said in a statement issued to the media. ## Doctors' stir affects health services in Nagaland

KOHIMA, April 18 (PTI): Health services in government hospitals of Nagaland were affected on Monday as doctors started a three-day agitation demanding that their retirement age be increased by two years. Members of the Nagaland in-Ser-

vice Doctors' Association (NIDA) have taken mass casual leaves to press their demand for increase in the superannuation age of government medical practitioners from 60 to 62 years.

The NIDA's demand is under consideration by the state government but no final decision could be arrived at as there are oppositions to it from certain quarters, chief secretary J Alam told PTI.

The agitation has affected services in the Out Patients' Department (OPD) in government hospitals and health centres across the state, but the emergency department and ICUs were open, NIDA said in a statement. Senior doctors will be available round the clock to attend to any emergency during the period of agitation, it said adding that Covid-19 vaccination and tests were not affected.

The demand is in line with the promise Prime Minister Narendra Modi made in 2016, the NIDA said.

The organisation said it is forced to take this step as the state government has failed to solve the issue in a year. Doctors in Dimapur district hospital said they attended to emergency cases but not OPD patients.

The state government had earlier cautioned the agitating doctors that action would be taken against them. On the first day of the agitation, administrations of Kohima and Dimapur districts sought help of private practitioners for the treatment of patients, official sources said.

## Extreme poverty in India declined by 12.3 percentage points during 2011-19: WB paper

NEW DELHI, April 18 (PTI): Extreme poverty in India declined by 12.3 percentage points between 2011 and 2019, with rural areas doing better than urban centres, according to a working paper of the World Bank.

India has not released a new household consumption survey since the NSS from 2011. By extension, the country has not released any official estimates of poverty and inequality for over a decade now, added the paper coauthored by economists Sutirtha Sinha Roy and Roy van der Weide.

Earlier, a working paper of the International Monetary Fund (IMF) had said the Pradhan Mantri Garib Kalyan Yojana (PMGKAY), which provides free foodgrains to the poor, played a key role in keeping extreme poverty in India at the



lowest level of 0.8 per cent during the pandemic-hit 2020.

"We find that extreme poverty in India has declined by 12.3 percentage points between 2011 and 2019 but at a rate that is significantly lower than observed over the 20042011 period. "Poverty reduction rates in rural areas are higher than in urban areas," said the paper titled 'Poverty in India Has Declined

over the Last Decade But Not As Much As Previously Thought'. The authors further said urban poverty rose by 2 percentage points in 2016 during the demonetisation event and fell sharply thereafter. Rural poverty rose by 10 basis points in 2019 likely due to a growth slowdown.

"Our estimates of poverty for recent periods are more conservative than earlier projections based on consumption growth in national accounts and other survey data," the paper said.

The paper further said the extent of poverty reduction during 2015-2019 is estimated to be notably lower than earlier projections based on growth in private final consumption expenditure reported in national account statistics. The authors also said there was no evidence of rising consumption inequality in their analysis. The paper noted (CONTD. ON PAGE-9)

Sensex plunged 1,172 points while the Nifty crashed below the 17,200-level on Monday, hammered by robust selling in market heavyweights Infosys and HDFC Bank following their below-estimate results.

A weakening rupee and lacklustre macroeconomic data added to the woes, traders said.

Resuming trade after a two-day holiday last week, the BSE Sensex tumbled 1,172.19 points or 2.01 per cent to settle at 57,166.74 -- marking its fourth straight session of loss.

Similarly, the broader NSE Nifty plunged 302 points or 1.73 per cent to 17,173.65.

Infosys was the top loser in the Sensex pack, plummeting 7.27 per cent, after the country's second-largest software services company posted a 12 per cent rise in its March quarter net profit, missing market estimates.

HDFC Bank lost 4.74 per cent after the largest private sector lender on Saturday reported a 23 per cent jump in Q4 standalone net profit, led by lower provisions, even as other metrics like net interest income came in below expectations.

HDFC, Tech Mahindra, Wipro, TCS and HCL Tech were the other major laggards. In contrast, NTPC, Tata Steel, Maruti, Titan, HUL, M&M and Nestle India were among the gainers, spurting as much as 6.11 per cent.

The market breadth was negative, with 20 of the 30 Sensex constituents closing in the red.

"After a long weekend, we witnessed a huge fall of 2 per cent in the benchmark index. The fall was mainly on account of below estimated results of Infosys and HDFC Bank and the rising ten-

sion between Russia and Ukraine. "We expect further fall in markets in coming days considering the recent rise of Covid cases in back overseas.

NEW DELHI, April 18 (PTI): The wholesale price-based inflation spiked to a four-month high of 14.55 per cent in March on rising prices of crude oil and other commodities due to disruption in global supply chain in the wake of the Russia-Ukraine war, a development that may prompt the RBI to raise interest rates to contain price rise.

In February, WPI Inflation was at 13.11 per cent, while in March last year, it was 7.89 per cent.

WPI inflation has remained in double digits for the 12th consecutive month since April 2021.

In November 2021, it had touched a high of 14.87 per cent. The data released by the Commerce and Industry Ministry on

Monday, showed that crude oil prices were the biggest contributor to the rise in WPI inflation in March 2022, relative to February, followed by fuels and core items. Food articles witnessed some softening month-on-month led by

meat and the fish basket saw moderate increases during March. During March, inflation in food articles eased to 8.06 per cent, from 8.19 per cent in February.

India is dependent on imports to meet 85 per cent of its oil needs and so retail rates adjust accordingly to the global movement. In March, inflation in crude petroleum spiked to 83.56 per cent, from 55.17 per prices had mostly been on rise in March, after Russia started the invasion of Ukraine on February 24.

ICRA chief economist Aditi Nayar said even a normal monsoon may not be enough to douse the retail prices of items which are pushing up food inflation, such as edible oils. ICRA expects the WPI inflation to remain in the range of 13.5-15 per cent in the current month, partly depending on where crude oil prices settle in the rest of April 2022 and how much petrol and diesel prices are revised further.

"The broad-based nature of the rise in WPI inflation is likely to be of particular concern to the Monetary Policy Committee. We see a growing probability of the first repo hike being postponed to June 2022," Nayar said.

Acuité Ratings & Research chief analytics officer, Suman Chowdhury said the WPI data reinforces the presence of stronger inflationary pressures in the manufacturing and the services sector.

"Amidst increasing pressures on the profit margins of manufacturing companies and a pickup in consumption demand, Acuité expects a further pass through of input costs. We expect persistent

commodity prices to hold the core inflation at double-digit levels in

the near-term," Chowdhury said. Retail inflation, which is monitored by the RBI to fix interest rates, spiked to 6.95 per cent in March -- the third consecutive month that the consumer price index has breached the RBI's tolerance limit of 6 per cent, data released last week showed.

The Reserve Bank earlier this month kept its key repo rate - at which it lends short-term money to banks - unchanged for the 11th time in a row at 4 percent, to support growth.

## **UK India Business Council meets** M'laya minister James Sangma

GUWAHATI, April 18: The UK India Business Council met with the Government of Meghalaya Cabinet minister James Sangma and several UK businesses to discuss the online gaming and sports betting landscape in the state. It also launched the UKIBC's industry report: Gaming for Growth - India's Sports and Gaming Market Potential.

The UKIBC's Gaming Industry Index reveals Meghalaya to be the most gaming-friendly State in India. The Index measures the extent to which each state has legalised gaming and betting based on their stance on seven different games: lottery, horse racing, sports betting, poker, rummy, casino, and fantasy sports. Meghalaya scored 92.85 (on a scale of 0 to 100 where 100 is fully legalized) with licenses applicable in all seven games in both states.

UK India Business Council, through its report, reveals how a clearer approach to regulation would attract FDI; create jobs and growth; combat corruption; enhance the integrity of sport; increase the tax revenue in the state, and support the state's wider tourism sector. The report further proposes a series of recommendations to capture the large and growing opportunities for India to benefit from the sector's growth.

"We applaud the Government of Meghalaya on its forward-thinking approach to the license of games of chance in the state, which will help to contribute greater revenues and bring jobs to the state. A regulated market also provides safeguards and protection for players, safeguards that are not available in the unregulated sector. Both the unregulated and regulated gaming sectors in India will continue to grow significantly. There are therefore strong reasons to work towards this growth taking place under regulations. To do so, we recommend the Government of India adopt the Law Commission's 2018 recommendation that sports betting be regulated. Not least because it will attract FDI, stimulate domestic investment, create jobs, generate government revenue, tackle corruption, and enable responsible play-

In its report, the UKIBC makes several recommendations regarding the legalization and regulation of the gaming market across India in line with the Law Commission's 2018 recommendations. It also contends that the gaming market is regulated centrally to bring uniformity to the sector.

Each state can then decide whether it wants to be a state to allow gaming and to what extent, therefore UKIBC managing director, Kevin McCole, said, retaining a suitable degree of autonomy.

traditional fuels and benefit from ambitious energy-transition targets in India," Dangra added.

He said, "There are international borders in Barak Valley. Along the bordering areas, anti-national/seditious activities and smuggling take place from time to time. Under the dynamic leadership of Prime Minister Modiji and Home minister Amit Shah ji, I am certain that such antinational activities will be put to rest for good." The MP spoke about the Greenfield airport and



said, "A particular group has been constantly trying to derail this project for their own vested interests." He, however, made it clear that his government would not compromise with the development of this region.

It needs to be mentioned here that in the last state cabinet meeting, chief minister Himanta Biswa Sarma stated that the process of acquisition of land for the new airport (in Silchar) in Dolu had been completed and the land would be handed over to the civil aviation ministry by May 10. Dr Roy during the press briefing also highlighted the various germane issues raised by him during the recently concluded Budget Session of the Parliament. He informed that he has raised the issue of construction of flyovers in areas where there are still unmanned railway crossings. SILCHAR, April 18: In a grand achievement, Bongaigaon district has been selected for the Prime Minister's Award for Excellence in Public Administration, 2021 for its initiative 'Sampoorna' in the category 'Innovation-District'.

The project is aimed at reducing malnutrition among children in Bongaigaon district. It employs a decentralised, technology-based model using community participation and women empowerment as positive deviance factor to achieve the result and has successfully brought 95.6 percent malnourished children to normal state in just one year and the results are sustainable by way of empowerment of the mothers of the children.

There are some key aspects of Project Sampoorna. It assessed and identified 2,416 malnourished children and mothers. 95.6 percent of malnourished children became normal in just one year. Google live sheets and Whatsapp were used to update and monitor data captured. A simplified 6x6 vinyl printed WHO coated Growth (weight/height) for boys and girls was put up in each Anganwadi Centre. These centres assessed and identified Severe Acute Malnourished (SAM) and Moderate Acute Malnourished (MAM) children using WHO growth chart as compared to less effective underweight children being identified using the weight for age growth

chart used all over the country. Mothers

of these children were also identified. Each of them was tagged with the mother of a healthy child and each healthy mother was called Buddy Mother.

Buddy pairs were given questionnaires before the project started to assess their knowledge. The mothers were then given training on best practices including best indigenous food practices. The same questionnaire was given after six months to assess their present knowledge. To ensure children don't relapse into malnutrition again, a convergence between ICDS and National Rural Livelihood Mission was done by involving all mothers in Self-Help Groups. They ensured regular income through livelihood activities for empowerment of the mothers and sustenance of the efforts to avoid and manage malnutrition

After three months of active intervention using protein supplements, 88 per cent of SAM children became healthy and 96 per cent MAM children became healthy. By this 2,416 pairs of Buddy Mothers were created. Only 1,178 children were newly identified to be malnourished in September, 2021 as compared to 2,416 in September, 2020.

## India in US strategy against China


ome political commentators have argued that the stand taken by the Modi government on the conflict in Ukraine shows that t is wrong to consider India a subordinate ally of the United States. The fact that India has abstained on resolutions in the United Nations condemning Russia for its invasion of Ukraine and the decision of the government to buy small quantities of crude oil from Russia, notwithstanding the US stand that countries should not buy Russian oil or gas, is seen as an illustration of India's independent foreign policy and strategic autonomy. This is a superficial reading of the situation. India has over the last one and a half decades entered into a strategic alliance with the United States with the defense cooperation agreement as the centrepiece of this partnership. Under the Modi government, the military and strategic cooperation got cemented with the signing of the three so-called foundational agreements such as the logistics agreements (LEMOA) in 2016, the integration of communication network (COMCASA) in 2018, and the Basic Exchange and Cooperation Agreement (BECA) in 2020. The nature of these agreements is such as those the United States has signed with its closest military allies.

India also became part of the quadrilateral alliance forged by the United States to advance its Indo-Pacific strategy which consists also of Japan and Australia. It should be noted that the QUAD came into being much before the incidents on the Line of Actual Control in Ladakh in June 2020. The 2+2 ministerial forum which consists of the defense and foreign ministers of both sides was institutionalised and began its regular meetings in September 2018. It is in such a situation of growing proximity to the United States that the Indian stand on the Ukrainian conflict should be viewed. The United States is unhappy that India, a major non-NATO ally, has not joined the anti-Russia bandwagon. President Biden had remarked that the QUAD partners, Australia and Japan are fully on board but India is 'somewhat shaky" on the Ukraine issue. Since then, the United States has piled pressure on India to follow the sanctions imposed on Russia by the United States and the European Union and to stop buying oil. The United States is particularly incensed at the talk of a rupee-rouble exchange of payments for the trading in oil.

In the meeting between Defence minister Rajnath Singh and US secretary of Defence Lloyd Austin, they discussed ways to strengthen defense partnerships and advance the scope of bilateral defense cooperation. The statement issued after the meeting also stated that there would be closer collaboration between the defense industries. The United States will utilize this occasion, when India is asking for understanding for its continued reliance on Russian military supplies and spares, to commit India to buy more US weapons and defense equipment. The aggressive US stand against Russia in the Ukrainian conflict and the Indo-Pacific strategy are connected. They are both part of the US efforts to retain global hegemony in the face of its declining power to exercise such hegemony. India is important for this project especially as China is the ultimate US target. The quest to maintain India as a subordinate partner will not be given up, despite the friction over how to deal with Russia in the Ukrainian conflict. In the overall grand scheme of the United States, this is only a minor irritant.

## The regional economic and political developments may have near-immediate affect on the Indian economy, apart from the internal pressures

The recent regional economic and political crises in south Asia, most of themin immediate neighbours of India, have raised concern amongst the Indian establishment. The economic turbulence in Sri Lanka, Nepal and Maldives and the political turmoil in Pakistan may affect India manifold.

The economic impact of the various crises is expected to begin manifesting themselves soon, if governments of those countries fail to address the crises quickly.

To accord priority to India's neighbours in their international activities, programmes and projects, was stressed at the first ever Inter-Ministerial Coordination Group (IMCG) meeting organised on April 12 in

### Sri Lanka's economic woes

The economic turmoil in Sri Lanka is currently viewed as the most pressing foreign challenge by the MEA with diplomatic and trade ramifications

Over the years the Sri Lankan economy has failed to attract much foreign direct investment or spread its export basket, though it has transitioned into an upper-middle income country

For most part, Sri Lankan was sustained DEGREE OF THOUGHT growth through international sovereign bonds and expensive short-term external borrow-

ing. These funds were channelled into education, infrastructure, and healthcare, besides maintaining financial liquidity and promoting better macroeconomic policy.

However, by April 2021, Sri Lanka's external debt had touched \$35 billion. In March, inflation zoomed to 17.5%, the highest since 2015, and forex reserves dwindled to \$1.9 billion, enough only for a month's

Its debt-to-GDP ratio stands at an alarming 120%. Not surprisingly, on April 12, the government defaulted on all its outstanding foreign dues. The country has to repay \$4 billion in debt this year.

Deep political and economic mayhem has followed, as there is no money to pay for food and fuel imports. Protests have broken

out countrywide. While India is under pressure to continue supporting the island country through a series of lines of credit, political dialogue with the administration of Sri Lankan Prime Minister Mahinda Rajapaksa has not yielded results. While protests rock Sri Lanka demanding Rajapaksa's resignation, he has resisted both political as well as economic change by spurring plans of urgent economic reforms.

Nepal's economy falters Nepalese finance minister Janardan Sharma on 16 April asked fellow Nepalese citizens living abroad to deposit funds in domestic banks as part of efforts to ensure the financial system has enough liquidity and to preserve foreign exchange reserves. By depositing their

savings in Nepal, overseas Nepalese By: Asad Mirza would continue to

> maintain their link as well as benefit from 6 to 7 per cent interest" offered by Nepali banks, Sharma said.

> Though Sharma maintained that the Nepalese economy did not face a crisis and Nepal's situation could not be compared with Sri Lanka, the fact is that the Himalayan kingdom is facing its worst economic crisis in decades and increasing

> anti-government protests. In Nepal, remittances by overseas workers, which constitute nearly a quarter of the economy are crucial for external payments, they fell 3 per cent to US\$5.3 billion between mid-July to mid-March, compared with a 5 per cent increase in the same period

The political turmoil in Pakistan has caused a stir in India's MEA, yet many believe that it may prove to be a positive development. The country's new prime minister, like his elder brother and former prime minister, is essentially a businessman and he may try to salvage the ties between the two countries by boosting trade amongst them, as his brother tried in the past. Reports speak of a large section of the traders favouring reopening bilateral trade ties with India.

Pakistani importers, especially of cotton, textiles, pharmaceuticals and chemicals and exporters of dry fruits and handicrafts are keen on the border being open once more, officials said. They

with China as the main driver behind the crisis. This has been called "debt-trap diplomacy" by the However, in reality loans from China ac-

counted for only about 10 per cent of Sri Lanka's total foreign debt in 2020. In addition defaults over China's infrastructure-related loans to Sri Lanka, especially the financing of the Hambantota port, are being cited as factors contributing to the crisis.

But the facts don't add up. The Chinese Exim Bank financed the construction of the Hambantota port. As it was running in losses, the Sri Lankan government leased out the port for 99 years to the Chinese Merchant's Group, which paid Sri Lanka US\$1.12 billion. So in reality it actually bolstered Sri Lanka's foreign exchange reserves by US\$1.12 billion.

The situation turned bad due to two economic shocks in 2019. First, there was a series of bomb blasts in churches and luxury hotels in Colombo in April 2019. These led to a steep decline in tourist arrivals, a major source of foreign exchange earnings for the

Second, the new Gotabaya government carried out irrational tax reforms. About 2 per cent of the gross domestic product was lost in revenues because of these tax cuts.

Thirdly, ill thought out agricultural policies led to a drastic fall in agricultural production making more imports necessary. Due to lower export incomes, there was less money available to import food and food shortages arose.

Lastly, Sri Lanka might be forced to follow a deflationary fiscal policy, which may further limit the prospects of economic re-

Though the situation in every country may seem different, yet they may have a cumulative bearing on India in the near future. It might be looked up to, to act as a big brother by Sri Lanka and Nepal. As regards to Pakistan it may prove to be a case for caution both militarily and politically, but indeed the times ahead seem to be challenging for the Indian foreign policy deliverers.

Though the Indian economy overall seems resilient to the external forces, yet a word of caution to some Indian states. Some of these states may have the makings of a crisis, due to their populist policies. A recent report states that most of the non-BJP ruled states, such as Punjab, Andhra Pradesh and West Bengal may end up wrecking their economies, which are under strain due to the populist policies being implemented there.

# Sinking of Russian ship Moskva is a dangerous turning point in Ukraine war

he sinking of the flagship of Russia's Black Sea flotilla Moskva is a significant turning point in the Ukraine war and also a lesson for military planners across the world. Russia does not yield the point that Ukrainian missiles would have downed the ship and maintains that an accidental fire on board had damaged the structural balance of the ship which had tilted as a result in rough seas. The battleship now sunk was utilised for ill purposes by the Russians and had played a critical role in several piquant situations.

Maybe, in future the sinking of such a ship will be compared with the sinking of The Bismarck in course of the Second World War. "The Bismarck" was the vaunted emblem of German naval strength in the Sound

Close on eighty-one years, the Bismarck was sunk on May 27, 1941, by the British Navy which was driven to desperation by the depreciations of the Bismarck in association with another feared member of the German Navy, the Price of Oregon.

The Bismarck was able to dominate the north Atlantic sea routes which brought essential supplies to a beleaguered Britain. From food to munitions, the British was bringing their provisions from across the Em-

ships which were hunted down by German U-boats and the Bismarck being present to guard their opera-

What the Bismarck was able to do was to besmirch then reputation of the British Navy as the ultimate protector on the high seas for all allied vessels. So serious was the situation that from Winston Churchill to the first lord of the admiralty the top priority of the British was to track down the Bismarck in the vast north Atlantic waters and put her down.

Then in May, the British had despatched a series of reconnoitring missions to find out the exact locations of the Bismarck. British Navy's most prestigious ship, HMS Hood, had come far to face with Bismarck along with HMS Norfolk. For the British it was a shattering blow that the Hood, the invincible, received fire room the Bismarck and just split into two. However, Bismarck also was hit and its oil tank began to lose. That left a trail of Bismarck.

On the fateful day, the Bismarck met with HMS Rodney, an old battleship and the HMS King George Five, a brand new ship, which began pounding the Bismarck. They were soon joined by HMS Victoria, an aircraft carrier. The last did the ultimate trick and dropped bombs on the vulnerable upper decks which led to severe damages leading to the sinking

Such was the importance of the event that the Royal Navy celebrated the event and the first lord of the admiralty had immediately addressed the Navy fighters, admitting how powerful and great a ship Bismarck was. With the sinking of the Bismarck, the North Atlantic sea routes were again available to the Allied Forces.

The sudden sinking go the Black Sea fleet's flagship, Moskva, had dismayed the Russians. Moskva was so important that it could deployed only on orders of the Russian President. Picking up the strands after the sinking of the ship, the official Russian TV channels have stated that the Third World War has already begun.

Ukraine President, Vladimir Zelenskyy had stated in formal interviews that he did not discount a possible Russian pre-emptive nuclear strike. He urged the world to take note of the threat of nuclear attack. Russia has resumed hitting areas

around Kyiv with missiles. Ukraine expects Russia to substantially step up its attacks on Ukraine targets in the wake of the sinking of the flagship of Back Sea command.

No doubt, the loss of the ship is a deep dent on Russia's prestige and personally that of Vladimir Putin. The Russian autocrat will now try to seek revenge with redoubled attacks on Ukrainian positions.

Moskva, the 12,500 tonnes guided

missiles cruiser was a power statement for the Russian navy. The ship was earlier deployed during Russia's Syrian campaign for overseeing its security needs on the coast and for missiles use inland.

Later, an irate Vladimir Putin has sent the ship to Black Sea areas when Turkey had downed several Russian military aircraft. It moved along with a flotilla of other ships which together made a real presence in an area and capable of multifarious

torpedoes for use against submarines. It had a speed of 32 miles and it was 600 feet long. A ship of this class last destroyed was during the Falkland war off the coast of Argentina when HMS Destroyer had sunk the General Belgrade on May 2, 1982.

The ship had 510 crew onboard, and so far it is not clear how many might have perished along with the ship. Given the firepower of the ship, it would have a very large stockpile of explosives o board and the fire from a missiles strike could have ignited the anger part of the explosives. This could have altogether destroyed the ship.

To have sunk such a immensely costly military hardware, a floating fort, is a feather on Ukraine's operational capabilities. The ship was reportedly struck by a Neptune anti-ship missile of Ukraine. The ship had directed the missiles strikes on the coastal cities of Ukraine and had delivered heavy damages

Neptune class missiles have not so far been regarded as having adequate firepower. However, the sudden sinking of the massive ship really shot up the effective of the Neptune class missiles. Ironically enough, Moskva was built in Ukraine during the days of Soviet Union and entered service in early 1980s.

In their triumph, he Ukrainians Moskva was fitted with anti-ship, have said the sinking of this ship is a anti-aircraft missiles pads, apart from small retribution to Putin for killing Ukrainian children and women.

Questions are being raised that despite air defence and missiles defence systems on board how could the ship have been struck by a missile from the Ukrainians. These issues raise questions about deployment of such larger ships in war conditions.

Apparently, USA had moved some of their ships away from the Chinese coats where they come under the firing range of on shore anti-ship missiles bases of China. The reverberations of the Ukraine war are already been seen across the war. China is sending its latest jet fighters all over the disputed waters in the South China Sea. China is seeing its opportunity of asserting its authority when apparently USA and western allies are deeply engaged in meeting the threat from Russia. (IPA Service)

# Fire of hatred spreading faster dividing the nation

hat has been happening in Uttar Pradesh and Uttarakhand now is a clear indication that the fire of hatred is spreading faster than we can douse. It has become a political tool and the major beneficiary is the BJP which is not only ruling these states but also the country. Action is seldom taken against the hate mongers. Inaction on the part of the police and administration has become the general characteristics until they are compelled to take action after general condemnation of the incidents from across the country. What proof one need to believe that some sort of structural changes based on hatred have already been carried out in governance?

Hatred is one of the basic human emotions that have always been exploited for political purposes, especially to establish hegemony of one community over the other, which is politically translated into support for remaining in power or gaining it. In the meantime thousands of innocent people just perish in the fire of hatred. The history of the world is full of such incidents, and hence many people believe that it should not be allowed in India.

The Supreme Court of India is

hearing a number of petitions seeking investigation and action in hate speech cases, particularly in Uttarakhand and Uttar Pradesh. On April 13, the Supreme Court has even asked the Uttarakhand government to file a status report by April 22 in the case registered against hate speech in Haridwar. Appearing for the petitioners, the senior advocate Kapil Sibal has informed the Supreme Court that a similar event is going to be held in Himachal Pradesh on April 17. It is a matter of serious concern that over the last few months some Hindu hate mongers including some religious personalities have made outrageous hate speeches and even given open call to take arms against Muslims, rape Muslim women, and commit genocide against them. In majority of the cases, such hate speeches were delivered during such events where police and administrative officers were present, and no actions were taken against the violators committing such crimes against a community. Who is responsible if not the ruling establishment? If these blatant incidents cannot be stopped then who is going to stop the whisper campaign against a community. Take the example of the Haridwar

incident. In the so called religious congregation several saffron clad personalities claiming to be Hindu

saints, called Hindus to take arms against Muslims and resort to their genocide. No action was initially taken by the ruling establishment, which took action only after five former chiefs of staff of the armed forces and over a hundred other people including bureaucrats and prominent citizens wrote to the President Ram Nath Kovind and Prime Minister Narendra Modi calling upon them to protect the integrity and security of India. Yati Narasinghanand was made prime accused and arrested. However, he got out of jail on bail more than a month ago. The accused did not stop here. He again delivered a hate speech in Delhi reiterating the call for use of weapons against Muslims. The latest example is from Uttar Pradesh. This incident also involved a saffron clad so called saint. The head of Maharshi Shri Lakhman Das of Udasin Ashram in Khairabad, Sitapur, 100 km from state capital Lucknow, made a hate speech on April 2 threatening Muslim women with rape. The speech was made at an event, a religious procession, where police and administrative officials were present. No action was initially taken. Then a two-minute video of his speech went viral six days after on April 8. It drew sharp comment from the people and even from the National Commission of Women. The Com-

mission sought his arrest and said the police cannot be mute spectators to such comments. Only after that an FIR was registered against the accused under various sections of IPC related to making hate speech, making derogatory statements and sexual harassment.

These are only the much publicized examples of hate speeches made in public. There are numerous whisper campaigns doing rounds, in which Muslims as a community are demonized and dehumanized, as if there are no innocent or good people among them including their children and women. It is sheer madness of certain Hindus who have been running their hate campaigns only to consolidate Hindu votes in favour of the BJP. Such activities are being carried out and institutionalized through certain organizations who have nothing to do with religion but are primarily interested in establishing Hindu hegemony against all other religious communities. This is camouflaged under the name of patriotism, falsely implying that no one other than a Hindu can be patriotic in India. Even nationalism for them means nothing less than 'Hindu Nationalism'. They are no more talking 'Vasudhaiva Kutumbakam' (the whole world is our kith and kin) which was one of the fundamental

ocratic institutions are weakened. their spines are broken, and only a handful of officers have left with courage to take action against hate mongers who go on encouraging violence of one community against the other. Branding any community "enemy of the people" is wrong, since these activities are carried out either with a wish to harm the community in the grab of protecting other communities or with a wish to get political support for gaining or remaining in power. Unsuspecting Hindus must not allow themselves to be exploited by such Hindu hate mongers. There are also anti-Hindu hate mongers in the contemporary politics and people should equally beware of them.

# Has online education changed your kids?

uring the pandemic, students found their otherwise vibrant world crumbling as they found themselves limited to studying from home. Many lost the art of conversation. Many found it difficult to adjust to others as their tolerance limit reduced. Teachers noticed a new lethargy in their students.

Even after offline classes started, the attention span continued to be thin and short. Students found it difficult to comply with the set routine of school. Lack of physical activity, binge eating and watching television had resulted in obesity, muscle spasms and rigidity. Children were also suffering from Vitamin D and calcium deficiency as they were almost constantly indoors for nearly two years.

The sense of isolation and lack of physical interaction with friends has resulted in mental health issues among many youngsters.

An astrologer from the National Capital Region told me that he was increasingly having worried parents asking him about the future of their children who were showing serious behavioural changes like lack of tolerance towards others, shunning social interaction, and even violent behaviour. They were worried because they had never ever seen such traits in their children before the pandemic. He said that very small children who had never seen a school and had only experienced online education were uncomfortable going to schools when they reopened recently.


Online education has neither been authentic nor wholesome. Students found they gained little in terms of learning as attention spans plummeted.

They pined for offline classes where they could interact with their peers, have meaningful discussions and debates and get their teachers to guide them at every step.

Online teaching, with all its technological advantages, could not compete with traditional offline teaching as the sense of sharing and camaraderie that is crucial to the children's mental and emotional development was missing.

During offline classes, the students also soaked in varied experiences in the classroom. Their peers contributed to the broadening of their perspective and helped them see other points of view.

Teachers also got a raw deal. They felt they were talking to tiles as students switched off their cameras. There was a distinct disconnect between students and the teacher. There were few ques-



tions and discussions were rare.

Sometimes, when the teacher questioned a particular student, there was no answer as the student was not physically present. He or she had logged in to meet the attendance requirement and was then doing other things.

One cannot blame the students as staring at a laptop for six to seven hours a day can be torturous. The screen time was taxing their eyes. Sitting all the time was resulting in bad ergonomics, leading to backache and fibromyalgia pain.

An education ministry report released late last year indicated that between 40 to 70 per cent of school-going children in Gujarat, Madhya Pradesh, Bihar, Andhra Pradesh, Uttarakhand, Assam and Jharkhand did not have access to digital devices. As a result, they have been denied an education. It is frightening to estimate how much they have lost in these two years.

Many poor families invested in one phone as education went digital. But, with multiple children in the household, the others -- mainly girls -

were left out as the male child got the phone. While there is no formal report yet, there are fears that many girls have permanently dropped out of school. Many of the children who had digital devices suffered because of power cuts and

poor Internet connections. It is quite possible that many of them were sucked into doing jobs to keep kitchen fires burning

Surveys by the Hindustan Times showed that child labour had increased. So had underage marriages, trafficking of children and marginalisation of migrant child workers.

E-learning definitely has its advantages. It makes it possible to reach out to faculty abroad for virtual masterclasses and workshops.

A creative writing course conducted in Delhi for the last 10 years by the Sri Aurobindo Centre for Arts and Communication suddenly found global appeal after it went online.

Teachers quickly tried to adapt to the new technology so that they could continue to teach and evaluate their students as exams were also held online. A 2020 study by the Azim Premji University found that more than 90 per cent of the teachers felt no meaningful assessment of children's learning was possible through online classes.

Its 2021 study showed that 92 per cent of the students from Classes 2-6 had lost at least one specific language ability from the previous year. This included reading familiar words and writing simple sentences based on a picture.

The study found that more than 80 per cent had

In these circumstances, how are they going to make up for lost learning?

There is, clearly, cause for worry. Many fear they may never be able to catch up. It is only in the coming years that we will know what damage the pandemic has done to education.

For now, look at the damage the last two years have done to students and teachers.

Exams were a farce. Institutions conducted them just for the sake of compliance. Everyone passed. Many of them with flying colours. No prizes for guessing why.

There were instances where students got 100 percent marks in Multiple Choice Questions, thanks to the Internet. All they had to do was to tick the right answer out of the alternatives suggested. Actually, there was no exam in the real sense as the unrealistic marks eloquently show.

Teachers will tell you how students did extremely well as they just copied the right answers without understanding them.

Offline exams are a must as it reduces the unethical practices that were rampant during online exams, where many did not think twice before copying from textbooks or using the Internet to find the right answers.

The whole point of learning holistically and gaining an in-depth understanding of concepts and ideas was lost. It is definitely going to impact post-graduate and management school students when they start looking for jobs as employers will find them wanting. And, while many have found employment in recent weeks as the economy has started opening up, the real challenge will be retaining those jobs.

Imagine the plight of an engineering or medical student who has studied online for the last two years. Or is doing a course where practicals are crucial to understanding concepts

There has been a definite loss of learning. Any teacher will tell you that. Students agree as well. The offline mode will restore the sanctity of education but we cannot pretend that all is well now.

Much needs to be done to repair the damage caused in the last two years. The United Nations kept repeating during the pandemic that schools should be the last to shut

and the first to open. But, in India, different state governments acted differently depending on the political exigencies of the moment. They ignored the fact that education needs to be above political considerations.

A UNESCO report prepared during the pandemic made the following recommendations:

• Improve terms of employment of teachers in both public and private schools

• Increase the number of teachers and improve their working conditions.

• Recognise teachers as frontline workers. • Provide teachers with meaningful information

and communication technology training. The report also revealed that most teachers felt integrating technology with education during the

pandemic was time-consuming and they lacked professional skills required to do so effectively. The Economic Survey 2021-2022 said that rural children had shifted from private schools to government schools during the pandemic as it is mostly free. This is a clear signal that the govern-

ment needs to help government schools with additional financial resources, teachers, classrooms and learning materials so that they can effectively teach the new students they now have. The survey also said that the academic disruption since the last two years, and the switch to the

online mode of education, had aggravated the existing digital divide and access to education. The pandemic has given us a great opportunity

to improve our battered education system that is already wanting in many ways.

It is a wake-up call.

Ideally, the government needs to:

• Recognise that education -- just like the economy and health infrastructure -- has been seriously impacted and needs immediate attention.

• When the government talks about how opening up the economy is a crucial part of the process of getting back on track, it must also talk about education

• Track down dropouts and cajole them back. • Evolve methods to make up for lost time.

• Find a way to reinforce concepts, which are not strong due to online education.

• Strengthen the digital reach as hybrid systems will continue.

• Get education to become a part of the national conversation so that efforts are made to fix gaps.

 Create a strategy to recover the two years of learning that has been lost.

Unless this is done systematically by every state, students will lose the opportunity to learn, maybe forever.

At the moment, very little is happening on this front. We cannot let our children be victims of this tragedy. (Courtesy: Rediff.com)

# Law, break, and patch up in a pre-marital relationship

n India, the interaction between a boy and a girl is forbidden. Indian youth have friendships and premarital relationships. I have observed that couples living in big metro cities and have the privilege prefer live-in relationships.

It's not only the most intimate form of a relationship, but it also gives the sense of martial experience because couples living together are doing all sorts of tasks that a married couple will be doing.

These will include sorting out oills, taking care of groceries, laundry, cleaning, etc. Every individual can't afford to live together. There are so many cishet couples who might be the first generation to go to college or get a job coming from a socio-economically oppressed or a DBA (Dalit, Bahujan, and Adi-

vasi) community. So many of them might have their first love relationship. Adolescents engaging in a premarital relationship and sexual activity are at the same risk of violence as any married couple. Intimate partner violence between premarital couples is something no one wants to talk about, not even the victim them-

Why is intimate partner violence happening between these couples? They are young. They are in love, they have chosen their partner, they are the new generation with more accessibility to information.

The answer is deep-rooted, invisible patriarchy, but it's everywhere from our home to society, to State and Nation. Younger people, especially men and boys, fail to recognize the privilege given by society. They are raised in a way where they have seen themselves as superior, as a saviour, not only because of their parents. The media has equally participated in this.

### Role of media in intimate partner violence in premarital relationships

Media is the most harmlesslooking influencer we have had for many years. Especially Indian cinema, which glorifies intimate partner violence. It's not only to glorify it, but it's also to justify the violence. Young boys and girls also see these types of violent relationships in their homes, in society, and in cinema. The latest example of a very popular movie "Kabir Singh" (2019), where the cast had done an excellent job, the actors acted brilliantly, and this is the problem with these types of movies that from cinematography to acting perspective it's perfect but what is not perfect is the glorification of violence. The director of Kabir Singh has justified the relationship he had shown in the movie. His justification shows his patriarchal mindset.

The more dangerous part was the after-effects of this movie. Men cherish rowdyism and violence.



and society urges them to be like that. I am not saying that every movie has the same effect on society, but this is the point that "Thappad" didn't get the recognition and appreciation that "Kabir Singh" got.

Then why don't they just break up?

So, in a premarital relationship, why does a male partner think he now has the right to her female partner. We have seen so many relationships where suddenly there is a power dynamic as soon as a couple enters a premarital relationship. The relationship which was supposed to be equal, where did the idea of this power dynamics come from?

This comes from their family, where they have seen their male family members have control over the female family members. Their parents' relationship is the first love relationship they encounter in their life. They see the power dynamic, abuse (physical, emotional, economic), and how the mother tolerates everything without complaint.

This is what they learn, and suddenly the boy thinks that he is the saviour in this relationship and needs to take care of his partner. So in taking care of everything, he justifies his acts like checking her phone, 24 hours surveillance of her activity, slapping, kicking, emotional manipulation, gaslighting, etc. This is not a marriage where two families are involved, and the girl is living under pressure to live with the husband. This is the premarital relationship where the familv is not involved. Still, girls choose to stay in the relationship. Even if they break up, it takes a longer time. Why can't they just break up and go?

This is the premarital relationship where the family is not involved. Still, girls choose to stay in the relationship. They can't just break up because, for the first time, they have chosen someone to be with. They are in love. They have seen married couples in their life. and they think that if everyone is going through the same trauma and violence, then why not spend the time with someone you chose.

There are multiple reasons why a girl can't just leave an abusive relationship. One of them is a lack of emotional support from their fambility from another person. That person becomes extremely important because now they are emotionally dependent on them, and even the imagination of losing them just shook them from the core.

We often think that sex has nothing to do with the breakup factor. but the emotional and sexual intimacy make the other person so vulnerable that the situation becomes worst. We see the hook-up and onenight-stand culture everywhere in our society, but it is still a very elitist concept. You can mostly see these cultures in big metro cities among upper-class people.

It becomes challenging for women who come from the oppressed class and cast. They have the pressure to prove themselves. There is also morality attached to sex. When you are having sex before marriage, it is a massive thing for so many girls. They think they had sex, so they have to be with this person. Women live in a constant loop of what will people (who know about their relationship) say if she breaks up. What if he leaves her. The fear is uncontrollable.

It becomes challenging for women who come from the oppressed class and cast. They have the pressure to prove themselves.

It is not easy to fight with your family and society for your freedom and rights. The constitution already gives the rights to every individual, but women can't practice them because the family becomes more powerful than the State. Family is the first and most influential institution, so we first need to sensitize them. If a family will support their children and make a healthy environment for them, then there is a chance that the women will not hide their relationship and intimate partner violence. They will not be afraid of taking legal help. Right now, they are afraid of what their parents will find out. We don't have a law and data on premarital relationships.

# Why do people behave so badly on dating apps? An answer from psychology

There is no doubt that online dating and dating apps have transformed the way we initiate, form and end romantic relationships. We might also question whether the convenience of these apps has encouraged us to behave differently than we would in "real life". More specifically, do mobile dating apps breed bad or antisocial behaviour?

If you use dating apps, you have probably been "ghosted" on occasion (where someone withdraws all contact) - or maybe you have ghosted somebody yourself. Perhaps you have found out that someone you have been chatting to on an app was in a relationship. Or if you do not use these apps, you might have heard hor-

Let us take a look at some of the bad behaviours that we see most commonly - and how psychology can explain them.

One of the main themes is how common it is for people to be using dating apps while in relationships. Data from the US has shown some 42% of people with a Tinder profile were either in a relationship or married.

What research says In a study of American undergraduate students, around two-thirds revealed that they had seen someone on Tinder who they knew to be in a relationship. Further, 17% of participants said they had messaged someone on Tinder while in a committed relationship, with 7% engaging in a sexual relationship with someone they had met on Tinder while in a committed relationship. There is also evidence that people are using dating apps to keep up what we call "backburner" relationships. This is when someone on a dating app maintains contact with another person in the hope of some day pursuing something romantic or sexual.

Surprisingly, the authors of a 2018 study involving 658 undergraduate college students found that the number of backburners reported did not differ significantly between those who were single, casually dating or in a committed relationship. Around 73% of all respondents reported they had at least one backburner.

Online communication, of course, makes keeping in contact much easier. Researchers have suggested that relationship maintenance in a backburner relationship involves positivity (being compassionate to the other person and ensuring that interactions with them are fun and enjoyable), openness (disclosing personal information to them, maybe even sharing secrets) and assurances (demonstrating a wish for the relationship to be sustained over time).

Online dating has also made ghosting much easier. A 2019 study found that respondents had ghosted 29% of the people they had dated and had been ghosted by 25% of dates themselves. In addition, 74% of respondents said they believed that ghosting was an appropriate way to end a relationship. Participants in this study reported both instances of sudden ghosting (abruptly ceasing contact) and gradual ghosting (slowing down contact before disappearing altogether). Gradual ghosting increased the degree of uncertainty for the person being ghosted. Ghosting probably occurs so frequently because of the ease of ending a relationship in this way, particularly if the couple is yet to meet in person. The authors of the same study also highlight that online dating offers an abundance of possible partners and that people who "ghost" one partner may do so because they have moved on to someone new.

People do not just use dating apps for seeking a relationship or for sex - many people report using them simply for fun. As such, more genuine users of these apps may be easy targets for trolls, who merely wish to create conflict and cause distress to other online users for their own amusement. A 2017 study found that dating app trolls scored highly on measures of sadistic behaviour, showing a disregard for the pain or suffering inflicted on other people – and highly on dysfunctional impulsivity, characterised by not following up on promises.

Some general reasons

The convenience and abundance of choice in online dating perhaps encourage a culture of 'disposability" – being able to "trade up" in the dating market and abandon a current partner more easily. Personal mobile devices, equipped with a passcode or face recognition protection, allow for and might even encourage more surreptitious and secretive behaviour.

Online behaviour generally is often characterised by disinhibition – we are inclined to behave more freely online than we do in a face-to-face context. In part, this is because of the feeling of anonymity we have online.

Finally, the way people use dating apps is very much related to personality characteristics. For instance, people with open (open to experience, adventurous) and less agreeable (less caring and thoughtful towards others) personality styles are more likely to use dating apps in a more casual way.

If bad or dysfunctional behaviour now seems commonplace on dating apps, social media and online generally, the technology which has given rise to this behaviour is here to stay. We may need to adjust our expectations accordingly. (Courtesy: Scroll.in)

# Sitapur hate speech: Where Does Hate Reside in the Human Brain?

The recent news of Bajrang Muni Udasin of Sitapur issuing rape threats to Muslim women is one of several such speeches delivered by members of different communities against people they perceive to be 'others' History is replete with anecdotes in which hate expressed against a particular group subsequently avalanched to violence against

Hateful speeches, literature and media reports often paint a picture of 'other' groups in an effort to dehumanise their members. The targeted group is equated in language with 'animal' or subhuman behaviour. Using terms like "termites", "rats" and "bed bugs" for a community undermines their agency and paves the way for violence against their people to the extent that it won't provoke the sort of empathy that violence against other groups might. Adolf Hitler's campaign against Jews during World War II is the most wellknown example of such a cam-

As a neurobiologist, I have often wondered if we can locate regions

in the brain that contribute to hate towards and dehumanisation of a group of people in a manner that can be measured, and if we can elucidate its mechanism to the extent that we can ameliorate or even eliminate it before it goes over-

Gordon Allport, a pioneer of personality psychology and who taught at Harvard University, was the first to publish research on the psychology of hate speech and dehumanisation in his celebrated work The Nature of Prejudice (1954). He argued that prejudice against a group of people can be transmitted through language and proposed that hate speech, which he called "antilocution", results in extreme hostility that in turn gives rise to violence

In 2015, Gail and Richard Murrow, of the departments of neurology and neurosurgery, University of North Carolina, argued similarly: that hate speech results in dehumanisation, which in turn leads to unthinking acceptance of atrocities against the target group. "Dehumanization automatically reduces the pain empathy that emotionally underpins rightsbased attitudes and behavior," they

wrote. Now, a question arises: could the dehumanisation of one group of people have a neurobiological basis? Might some part of the brain be responsible for controlling this behaviour? In fact, it is an established fact

in neuroscience that different func-

tions - motor or sensory - are associated with particular regions within the brain. In 2006, Lasana Harris and Susan Fiske of the psychology department at Princeton University studied brain activity of humans when encountered with different social groups. They observed the blood-oxygen level dependent signals through MRI scans to understand which particular regions of the brain were associated with dehumanisation. The study found that emotions like pride, envy and pity were controlled by the medial prefrontal cortex

(mPFC) in the brain. In 2015, Murrow and Murrow proposed that "neural simulation mechanisms, whether in the form of mirror neurons or other neural mechanisms, do exist in the human brain, and that such neural simulation is the source of the pain empathy theorized to motivate prosocial and helping behavior".

They further argued that this human mirror neural system responds only to actions performed by other members of the same species, i.e. humans.

So if a group is dehumanised, our brains may not be able to empathise with its members.

As war, war crimes, extremism and terrorism demand our attention, neuroscientists around the world must start devoting more of their time and resources to understand the neurobiological basis of hate better, with support from governments and other stakeholders. Glaser himself had an optimistic vision in mind:

"if the hate center(s) is (are) inhibited, as by some yet-unknown medication targeting hate neurons, hate would be suppressed or removed, and the brain and the person would continue hate-free until the drug is discontinued. One might also suggest that there are other centers in the brain that connect to the hate center and are capable of reducing or inhibiting its activity. By modifying the activity of these centers, therefore. one could also increase or decrease the level of hatred.' (Courtesy: The Wire)

# Ukrainian mayor: Russian strikes kill at least 7 in Lviv

The overnight missile strike hits 3 military infrastructure facilities and a tire shop

LVIV, April 18 (AP): Russian missiles hit Lviv in western Ukraine on Monday, killing at least seven people, Ukrainian officials said, as Moscow's troops stepped up strikes on infrastructure in preparation for an all-out assault on the east.

Plumes of thick, black smoke rose over the city after a series of explosions shattered windows and started fires. Lviv and the rest of western Ukraine have seen only sporadic strikes during almost two months of war and have become a relative refuge for people from parts of the country where fighting has been more intense.

Ukrainian Prime Minister Denys Shmyhal, meanwhile, vowed to "fight absolutely to the end" in strategically vital Mariupol, where the last known pocket of resistance in a seven-week siege was holed up in a sprawling steel plant laced with tunnels. Russia has repeatedly urged forces there to lay down their arms, but those remaining ignored a surrender-or-die ultimatum on Sunday.

Lviv Mayor Andriy Sadovyi said seven people were killed and 12 wounded in overnight missile strikes. Lviv's regional governor, Maksym Kozytskyy, said the Russian strikes hit three military infrastructure facilities and a tire shop. He said the wounded included a child, and emergency teams were battling fires caused by the strikes

A hotel sheltering Ukrainians who had fled fighting farther east was among the buildings badly damaged in the attack, the mayor said. "The nightmare of war has



said Lyudmila Turchak, 47, who fled with two children from the eastern city Kharkiv. "There is no longer anywhere in Ukraine where

we can feel safe.' Military analysts say Russia is increasing its strikes on weapons factories, railways and other infrastructure targets across Ukraine to wear down the country's ability to resist a major ground offensive in the Donbas, Ukraine's mostly Russian-speaking eastern industrial heartland.

The Russian military said missiles struck more than 20 military targets in eastern and central Ukraine in the past day — including ammunition depots, command headquarters and groups of troops and vehicles. Meanwhile, it said artillery hit another 315 Ukrainian targets, and warplanes conducted 108 strikes on Ukrainian troops and military equipment. The claims couldn't be independently verified.

COLOMBO, April 18 (PTI): Beleaguered Sri Lankan President Gotabaya Rajapaksa on Monday appointed a new 17-member Cabinet that excluded his close relatives except Prime Minister Mahinda Rajapaksa, as he called for a "system change" amidst growing demand for his resignation over the worst economic crisis faced by the island nation.

Sri Lanka is grappling with unprecedented economic turmoil since independence from Britain in 1948. The crisis is caused in part by a lack of foreign currency, which has meant that the country cannot afford to pay for imports of staple foods and fuel, leading to acute shortages and very high

Earlier this month, Sri Lanka's entire Cabinet -- aside from President Gotabaya and his elder brother, Prime Minister Mahinda Rajapaksa -- resigned from their posts after thousands of people defied a countrywide state of emergency and curfew and joined street protests denouncing the govern-

make way for the president to form a unity cabinet with the Opposition

ever, has rejected the offer. Rajapaksa, 72, swore in a 17member Cabinet on Monday in addition to the three ministers he had earlier appointed.

That meant no place for the oldest member of the family Chamal Rajapaksa, Mahinda's son Namal Rajapaksa, both of whom were Cabinet ministers and the nephew Shasheendra who was a state min-

Both Gotabaya Rajapaksa and Mahinda Rajapaksa have separately addressed the nation in an apparent bid to placate the protesters. But calls for the president to

resign have only grown louder. Speaking to the new ministers. President Rajapaksa sought their support for an efficient, clean gov-

He said that he expects honest, efficient, and untainted governance from the new Cabinet.

"Today, most of the government institutions are under serious economic difficulties and it is absolutely essential to rectify it," Rajapaksa said, calling the crisis "an opportunity to bring about the system change that the people ex-

## **UK PM Johnson facing new 'partygate'** claims ahead of India visit

LONDON, April 18 (PTI): British Prime Minister Boris Johnson is facing new allegations on Monday around "partygate", the scandal surrounding government officials breaching coronavirus rules with illegal lockdown gatherings, and will be hoping to escape some of the heat when he leaves for India on Thursday.

Johnson has already been fined

for one such party, for his birthday in June 2020, when his wife Carrie brought a cake to the Cabinet Room and has also been fined along with UK Chancellor Rishi

However, according to UK media reports, Johnson is believed to have been linked with around six out of the 12 lockdown parties under police investigation.

'The Sunday Times' quoted a source as saying that a leaving drinks gathering for Number 10 Downing Street's outgoing director of communications, Lee Cain, in November 2020 was allegedly "instigated" by Johnson.

"He said he wanted to say a few words for Lee and started pouring drinks for people and drinking himself. He toasted him," the source was quoted as saying.

It has led to renewed Opposition calls for Johnson, 57, to step down. Labour Party Deputy Leader Angela Rayner said that "if the latest reports are true", it means "not only did the Prime Minister attend parties, but he had a hand in instigating at least one of them".

The conflict in Ukraine and his scheduled two-day visit to India, starting with Gujarat on Thursday, will be among the issues he is expected to focus on in Parliament.

"As we face threats to our peace and prosperity from autocratic states, it is vital that democracies and friends stick together. India, as a major economic power and the

world's largest democracy, is a highly valued strategic partner for the UK in these uncertain times," Johnson said, ahead of his visit from April 21 to 22.

"My visit to India will deliver on the things that really matter to the people of both our nations – from job creation and economic growth, to energy security and defence," he

The visit this week, Johnson's first as UK Prime Minister, will begin in Ahmedabad on Thursday with investment announcements in key industries in both the UK and

He will then proceed to New Delhi to meet Prime Minister Narendra Modi on Friday, when the focus will be on India-UK strategic defence and diplomatic and economic partnership. According to officials on both sides, Johnson will also use his India visit to drive progress in the ongoing Free Trade Agreement (FTA) negotia-

## Turkey launches new ground, air offensive in northern Iraq

ANKARA, April 18 (AP): Turkey has launched a new ground and air cross-border offensive against Kurdish militants in northern Iraq, Turkey's defense minister announced early Monday

Turkish jets and artillery struck targets belonging to the Kurdistan Workers' Party, or PKK, and commando troops - supported by helicopters and drones — then crossed into the region by land or were airlifted by helicopters, Defense Minister Hulusi Akar said in a video posted on the

Akar said the jets successfully struck shelters, bunkers, caves, tunnels, ammunition depots and headquarters belonging to the PKK. The group maintains bases in northern Iraq and has used the territory for attacks on Turkey. Turkey has conducted numerous cross-border aerial and ground operations against the PKK over the past decades. The latest offensive was centered in northern Iraq's Metina, Zap and Avashin-Basyan regions, Akar said.

"Our operation is continuing successfully, as planned. The targets that were set for the first phase have been achieved," Akar said. There was no information on the number of troops and jets involved in the latest incursion. "We are determined to save our noble nation from the terror misfortune that has plagued our country for 40 years," Akar said. "Our struggle will continue until the last terrorist is neutralized."

The Defense Ministry said later that the offensive, named "Operation Claw Lock," was launched after it was determined that the militants were regrouping and preparing for a "large-scale attack."

The offensive was carried out in coordination with Turkey's "friends and allies," the ministry added, but did not elaborate. Last week, Turkish President Recep Tayyip Erdogan met with Masrour Barzani, the prime minister of Iraq's autonomous Kurdish region which controls the areas that

# Shanghai reports first Covid deaths as China rules out relaxing measures

BEIJING, April 18 (PTI): Shanghai reported three deaths due to Covid-19, the first in the financial hub after it was hit by the Omicron variant last month, while a top official ruled out relaxing the curbs until the ruling Communist Party Congress met later this year to elect Chinese President Xi Jinping for a record 3rd term in power.

On Sunday, three Covid-19 deaths were reported in Shanghai.

The deceased were two females and one male, aged between 89 and 91. They suffered from comorbidities including coronary heart disease, diabetes and high blood pressure, the city's municipal health commission reported.

None of them was vaccinated against Covid-19 and was in severe condition after being admitted to the hospital and every effort was made to save their lives, it said. These are the first officially admitted fatalities after the city went into lockdown towards the end of last month.

According to China's National Health Commission, the Chinese mainland on Sunday reported 2,723 locally-transmitted confirmed Covid-19 cases, of which 2,417 were in Shanghai.

Shanghai also reported 19,831 locally-transmitted asymptomatic infections of the novel coronavirus Sunday, out of a total of 20,639 local asymptomatic carriers newly identified on the mainland, the Commission report said.

By the end of Sunday, Shanghai had 16 Covid-19 patients in severe condition receiving treatment in designated hospitals.

As the cases continued to spiral, health officials announced more Covid tests amid reports of growing anger and frustration of people about the continued lockdown for the third week.

Shanghai has seen a continuous decline of newly-reported cases in some areas while those under closed-off management will undergo nucleic acid testing once every day from Monday to Thursday, the local health commission said.

Meanwhile, as the Omicron continued to spread, China's health minister Ma Xiaowei on Monday pledged the toughest measures vet to prevent a major outbreak of Covid-19, ruling out any relaxations ahead of this year's 20th Communist Party Congress.



The once-in-five-year Congress of the CPC which is due to be held later this year has assumed significance as Xi, 68, is expected to get its endorsement for a third five-year tenure as the head of the Party, the military and the presidency.

The 3rd term is unprecedented as all his predecessors retired following the two-term norm for leaders. However, Xi is expected to continue power for life as he is conferred the title of a "core leader" like the Party founder Mao Zedong.

Vowing to continue the much-criticised Zero Covid policy, Ma in a front-page article published on Monday in party journal Study Times, urged the country to stick to the dynamic zero policy and take a clear-cut stand against "erroneous" thoughts of "coexisting with the virus".

The bottom line is to prevent a large-scale rebound in cases and consolidate the hard-won results of pandemic control to welcome the opening of the CPC Congress, he said.

Ma's article comes as domestic concerns have been raised over whether China's hardline dynamic zero policy is sustainable in the face of more transmissible but milder variants like Omicron, the Hong Kong-based South China Morning Post reported. The handling of the pandemic is widely seen as the political legacy of the party and Xi, who is expected to secure a third term at the Congress, the Post report said.

But discontent has been mounting in Shanghai. which is largely in lockdown as China grapples with its worst outbreak of the pandemic.

# Children with severe UAI are at risk of cardiac arrest from rapid-onset upper airway obstruction Shehbaz Sharif says his 'speedy

# Omicron more likely to cause upper airway infections among children: Study

Omicron is more likely than other coronavirus variants to cause upper airway infection (UAI) among children, putting them at risk of heart attack and other severe complications, according to a study.

The researchers from the University of Colorado, Northwestern University, and Stony Brook University in the US analysed data from the National Covid Cohort Collaborative pertaining to 18,849 children under age 19 who were hospitalised with Covid-19.

The study, published last week in the journal JAMA Pediatrics, also found that Omicron causes UAI in younger children with the mean age of hospitalised children falling from about four years and five months during the pre-Omicron pe-

WASHINGTON, April 18 (PTI): riod to about two years and one

month during the Omicron period. The researchers conducted the study to determine if cases of UAI among children increased when Omicron became the dominant SARS-CoV-2 variant in the US.

The proportion of children with

a pediatric complex chronic condition was not significantly different in the pre-Omicron period compared with the Omicron period, they said. Overall, 21.1 per cent of children hospitalised with both Covid-19 and UAI developed severe disease requiring measures like inserting a tube into the lungs to assist with breathing, known as intubation. "Children with severe UAI are at risk of cardiac arrest from rapid-onset upper airway obstruction. They may require thera-



care units, including frequent administration of nebulised racemic epinephrine, helium-oxygen mixtures, and intubation," the authors of the study study noted.

Nebulised racemic epinephrine

pies typically provided in intensive is typically reserved for patients in the hospital setting with moderateto-severe respiratory distress. "While the rate of SARS-CoV-2

pediatric UAI is not overwhelmingly high, understanding this new clinical phenotype and the potential

for acute upper airway obstruction may help guide therapeutic decision-making," they said.

The Omicron strain of SARS-CoV-2 became dominant in the US the week ending December 25, 2021. The higly transmissible variant is known to cause lower severity disease than the Delta variant, the researchers noted.

This may be because Omicron replicates less efficiently in lung cells and more efficiently in the conducting airways, they said.

The researchers acknowledged some limitation of this analysis, including that children who are still hospitalised are not represented in the study, and the frequency of severe disease observed in the Omicron period may underestimate.

The NESO, a conglomerate of eight students' bodies representing the seven states of the north eastern region, suggested that indigenous languages should be made compulsory in their native states till the 10th standard and Hindi should remain as an optional or elective subject, said the conglomerate student body.

On April 10, while chairing the 37th meeting of the Parliamentary Official Language Committee, Union minister Shah had said that Hindi should be accepted as an alternate language to English but not to local languages.

'The nine tribal communities of the Northeast have converted their dialects' scripts to Devanagari while all the eight states of the Northeast have agreed to make Hindi compulsory in schools up to Class 10. There is a need to give elementary knowledge of Hindi to students up to Class 9, and pay more attention to Hindi teaching examinations," the Home minister had reportedly said in the meeting

While the political parties in the northeastern region are divided on the Hindi learning issue, the linguistic experts and political commentators said that while teaching in English and Hindi, local and indigenous languages must be given equal propriety for their promotion and practical use.

# 40 Chinese booked by Mumbai EOW for fraudulently becoming directors of Indian firms

MUMBAI, April 18 (PTI): The Economic Offences Wing (EOW) of the Mumbai Police has registered 34 FIRs against 150 people, including 60 foreigners - 40 of them from China - for allegedly violating laws regarding the registration of new companies and for fraudulently becoming directors of Indian companies, a police official said on Monday

The official said the FIRs were registered between April 1 to 15 and added that four more First Information Reports will be registered till Tuesday.

Among the 60 foreigners against whom the cases are filed, 40 are from China and the rest from Singapore, the UK, Taiwan, the USA, Cyprus, the UAE, and South Korea.

As per the preliminary investigation, the accused had given false statements to the ROC (Registrar of Companies), Mumbai, an EOW official said.

In some cases, the communication addresses of the companies

"These weapons were openly flaunted and brandished during the procession. The police have stated that the procession had police permission. Did the police give permission to carry arms? In fact, the processionists who carried arms had clearly violated the Arms Act, which has stringent provisions of imprisonment for such violations," the letter read.

It also said from the police commissioner's statements to the media, it is unclear whether those carrying arms during the procession were identified or not. "If so, whether they have been arrested under the relevant provisions of law, including the Arms Act. It is also unclear from your statement whether there is any investigation into the role of the police.

"Who is accountable for allowing an armed procession to stop in front of a mosque, shouting provocative and aggressive slogans at the exact time when the prayers to break the Roza fast were scheduled to begin? Such deliberate acts of omission and commission by the police have directly resulted in the ensuing incidents," the letter written by the Left leaders read. While both the leaders raised the issue of injuries suffered by police personnel during the violence, they also asked if senior officers had followed due diligence in the matter.

...if adequate police arrangements had been made, if action had been taken against weapon-carrying processionists, if the procession had not been allowed to stop in front of the mosque -- the incidents would not have taken place. "You have stated that people from both communities have been arrested. We stand for the arrest and punishment of all those guilty. However, the overwhelming majority of arrests is from the minority community, whereas the course of events shows that the main provocations and planning for the incidents were done by the organisation which held the procession - an affiliate of the Bajrang Dal as stated by the police.

"The Crime Branch, to whom the investigation has been handed over, is under the overall jurisdiction of the very police force which in the case of the Jahangirpuri incident is responsible. It is for this reason that the CPI(M) has demanded a time-bound judicial inquiry or an impartial investigation. In the meanwhile, we request you to take action against the police responsible," the letter read.

made the wearing of a mask compulsory," he said.

The wearing of masks will be mandatory with immediate effect. Those not wearing a mask will be fined, he said.

"We are studying which areas in Gurugram are seeing a surge," said Vij while replying to a question.

Gurugram. He said the Health Department is fully prepared to tackle any situation.



# Pak terrorists using Aadhaar card to camouflage identity

## Jammu and Kashmir Police for stronger safety features

groups misusing Aadhaar card to camouflage the identity of their Pakistani cadres, the Jammu and Kashmir Police will request the Unique Identification Authority of India (UIDAI) to strengthen safety features of the biometric ID, officials have said.

The police force will also pitch for devising a mechanism for getting real-time information on an Aadhaar card being misused by terrorists.

The misuse of the biometric ID came to light following the recent killing of two Pakistani terrorists in Bishembhar Nagar, adjacent to the Dal Lake, in Srinagar.

The terrorists, who had been involved in the killing of CRPF jawans earlier this month, were identified as Mohammed Bhai alias Abu Qasim, who had been active in Kashmir Valley since 2019, and Abu Arsalan alias Khalid, who was present since 2021.

However, the recoveries from the encounter site included two Aadhaar cards bearing an ad-



Subsequently, the police carried out a thorough search and found that the Aadhaar numbers were genuine but the cards had their passport-sized pictures superimposed on them, an official said.

A genuine Aadhaar card contains picture clicked on webcam, he added. Such camouflaging attempts by the Pakistanare aimed at painting the terrorism in Kashmir Valley as an indigenous movement, the officials

Alarmed by the blatant misuse of Aadhaar cards, the Jammu and Kashmir Police has decided to write to UIDAI requesting it to include more safety features, the officials said.

Privacy guidelines of Aadhaar are very stringent, thereby preventing the law enforcement agencies from verifying any particular card. A basic check can only provide the age bracket of the card holder without revealing the exact identity, the officials said.

The police will also cite the case of Mohammed Ismal Alvi alias Lambu, one of the masterminds of the 2019 attack on the CRPF convoy that left 40 personnel dead. A forged Aadhaar card was recovered from the site of the encounter in which he was killed.

Several forged Aadhaar cards have also been found from various hideouts of terror groups in the past few months, the officials said.

## Police confirm first death in Khargone riots after man's body found in Indore hospital



KHARGONE (MP), April 18 (PTI): A 30year-old man who went missing during communal clashes in Madhya Pradesh's Khargone city on Ram Navami has become the first fatality of the violence but his death has raised allegations of a cover-up with his kin on Monday accusing the police of keeping his death under wraps for eight days.

The body of Ibresh Khan was kept at a government hospital in Indore, around 100km from here, for eight days after it was found in Khargone's Anand Nagar area as freezer facility was not available in the riot-hit city, police said. The state government, however, has claimed a case of murder was registered on April 11 itself, a day after the riots broke out in Khargone during Ram Navami celebrations, following a postmortem on the body.

A police officer said that Ibresh Khan died due to serious injuries to his head caused by stones. Communal clashes had broken out in Khargone city on April 10 during a Ram Navami procession, leading to arson and stone-pelting, and imposition of a curfew. Superintendent of Police Siddharth Choudhary had received a bullet injury during the vio-

"An unidentified body was found in the night of communal violence in the Anand Nagar area of Khargone," In-charge Superintendent of Police (SP) Rohit Kashwani told reporters. He said since there was no freezer facility available in Khargone, the body was kept at the Indore government hospital after a postmortem. Kashwani said the family members of Ibresh Khan registered a missing person complaint on April 14.

"Ibresh Khan's body was handed over to his family members on Sunday after they identified him", he said, adding further investigation was underway.

Kashwani said that Ibresh Khan died due to serious injuries to his head caused by stones. However, a kin of Ibresh Khan, a resident

of the Islampura area, alleged a cover-up by the police. Ibresh Khan's brother Ikhlaq Khan claimed that the deceased was seen in the custody of the police by some people on April 12. He alleged that the police informed him about Ibresh Khan's death and the whereabouts of his body only after he threatened to go to the media. Ikhlaq Khan alleged that Ibresh Khan had gone to provide food for 'Iftar' (evening meal eaten by Muslims during Ramadan fast-

### Ikhlaq Khan also claimed that Ibresh Khan was seen in the custody of the police by some people on April 12 but these witnesses were not ready to depose. "A policeman came to me on Sunday night and told me that Ibresh's body is kept in Indore," he said Ikhlaq Khan claimed that the condition of Ibresh Khan's body indicates that he was brutally attacked. Meanwhile, the curfew was relaxed for four hours on Monday - from 12 pm to 2 pm and from 3 pm to 5 pm - following improvement in the situation in Khargone, officials said.

Stores selling milk, vegetables, provisions and medicines, among others, were allowed to remain open during the curfew relaxation hours. Local residents were allowed to make purchases of essential items without using their vehicles, they said.

In a related development, a delegation of Muslim clerics on Monday called on Madhya Pradesh chief secretary Iqbal Singh Bains and submitted a memorandum demanding setting up of a high-level committee to look into alleged selective actions of the police and the district administration after the riots. The memorandum claimed some of about 200 people of the Muslim community, who were arrested in connection with the violence, have sustained fractures and their cause should be probed. The delegation claimed a local resident, who died "several years" ago, figures in one of the FIRs registered against the rioters. This raises questions over the police action,

# UNSC needs to be reformed, it plays limited role in maintaining global peace: Foreign secy

KOLKATA, April 18 (PTI): Foreign secretary Harsh Vardhan Shringla on Monday called for reforms in the United Nations Security Council (UNSC), claiming that it had not been able to fulfill responsibilities in maintaining global peace and security.

Shringla, speaking at a webinar organised by Bharat Chamber of Commerce here, also said that UNSC, formed after the World War-II, has always played a restricted role globally due to limited representation.

'UNSC has not been able to fulfill its responsibilities... Unless the United Nations (UN), particularly the UNSC, is reformed, the global body's role in maintaining peace and security will be limited due to lack of representation," Shringla

"Deadlock in the UNSC has surfaced in the context of the Ukraine-Russia conflict. The issue had to be taken to the UN General Assembly," he pointed out

Currently, UNSC has five permanent members - China, France, Russia, the UK and the US. India



is among the ten non-permanent members of the body. Only a permanent member has the power to veto any substantive resolution.

India has been at the forefront of the years-long efforts to reform the security council, saying it rightly deserved a place as a permanent

member. Shringla, during the session, said

that unilateral sanctions imposed by the West on Russia will have an impact on Indian trade and investments in that country.

The foreign secretary, however, did not elaborate further on the

Referring to the economic crisis in Sri Lanka, he said that the COVID-19 pandemic hit hard the

Tourism is the main source of revenue for Sri Lanka, he noted.

India had extended two lines of credit to Sri Lanka, whole the island country also approached the IMF for a bail-out, he said.

Talking about the recovery of the pandemic-hit economy in India, he said the country received USD 81 billion as FDI during 2020-21, while its GDP is expected to touch eight per cent this financial year.

According to Shringla, accelerated pace of reforms, stimulus packages and a massive vaccination drive have helped the country recover from the crisis caused by the pandemic. "Îndia is boosting its economic

the bail plea of the accused within a period of three months and held the presence of 'state' in the bail proceedings "does not tantamount to according a hearing to a 'victim' of the crime". It took note of the submissions of victims that they were not heard in the high court as the video connection of their lawyer was lost and said, "we are constrained to express our disappointment with the manner in which the high court failed to acknowledge the right of the victims." The verdict considered questions including whether a 'victim', as defined in the CrPC, is entitled to be heard at the stage of adjudication of bail application of an accused.

It also dealt with the issue whether high court overlooked relevant considerations while granting bail to Mishra and if so, should the apex court interfere. Analysing the submissions, the court said until recently, criminal law had been viewed on a dimensional plane in which courts were required to adjudicate between the accused and the state and the 'victim' had no participation in adjudicatory process and "was made to sit outside the Court as a mute spectator". The verdict then noted the evolution in law and said, "a 'victim' within the meaning of CrPC cannot be asked to await the commencement of trial for asserting his/her right to participate in the proceedings. "The victim has a legally vested right to be heard at every step post the occurrence of an offence."

On the first issue, it answered in the affirmative, and held that in the present case, the 'victims' have been denied a fair and effective hearing at the time of granting bail to the accused. "It cannot be gainsaid that the right of a victim under the amended Cr.P.C. are substantive, enforceable, and are another facet of human rights. The victim's right, therefore, cannot be termed or construed restrictively like a brutum fulmen(empty threat)," it said, adding such rights are "totally independent" of the State. The verdict said that while deciding the bail plea, a court "should refrain from evaluating or undertaking a detailed assessment of evidence, as the same is not a relevant consideration at the threshold stage.

A court may examine prima facie issues, including any reasonable grounds whether the accused committed an offence or the severity of the offence itself, an extensive consideration of merits which has the potential to prejudice either the case of the prosecution or the defence, is undesirable, it added. "Instead of looking into aspects such as the nature and gravity of the offence; severity of the punishment in the event of conviction; circumstances which are peculiar to the accused or victims; likelihood of the accused fleeing; likelihood of tampering with the evidence and witnesses and the impact that his release may have on the trial and the society at large; the high court has adopted a myopic view of the evidence on the record and proceeded to decide the

The high court had granted bail to Mishra after taking note of the submissions including that the FIR, which alleged fire arm injuries caused by the accused, was not corroborated by the forensic evidence and the postmortem report. "The High Court has taken into account several irrelevant considerations, whilst simultaneously ignoring judicial precedents and established parameters for grant of bail. It has been ruled on numerous occasions that a FIR cannot be treated as an encyclopaedia of events...," the top court said. While allegations in the FIR that the accused used his firearm and the subsequent post mortem and injury reports may have some limited bearing, there was no legal necessity to give undue weightage to the same, it said, adding that observations of high court may have bearings on the trial. It referred to the court's job to ensure that neither the right of an accused to seek bail pending trial is expropriated, nor the 'victim' or the state are denuded of their right to oppose such a prayer. The top court then remanded the bail plea of the accused for fresh consideration "in a fair, impartial and dispassionate manner, and keeping in view the settled parameters".

"Without knowing the real facts, the common gullible public is induced to join as members of the company and purchase products at exorbitant prices and are thus, losing their hard earned money," the federal agency said. The new members, it said, are not buying the products to use those, but to become rich by becoming members as showcased by the upline members. "The reality is that the commissions received by the upline members contribute enormously in hike of prices of the products," it said. The money-laundering probe found out that Amway brought ₹21.39 crore as share capital in India during 1996-97 and till the financial year 2020-21, it remitted a "huge" amount of ₹ 2,859.1 crore in the name of dividend, royalty and other payments to their investors and parent entities. Companies like Britt Worldwide India Private Limited and Network Twenty One Private Limited also played a "major role" in promoting Amway's pyramid scheme by conducting seminars for joining members under the guise of sale of goods by enrolment of members in the chain system, it alleged. "The promoters are conducting mega conventions and flaunted their lavish lifestyle and used social media to lure gullible investors," the ED said. The company spokesperson said the recent inclusion of direct selling under the Consumer Protection Act (Direct Selling) Rules, 2021 has brought in the much-needed legal and regulatory clarity for the industry, while again confirming Amway India's continuous compliance with the spirit and letter of all laws and regulations in India. "As the matter is sub-judice, we do not wish to comment further," the spokesperson said. The Centre had, in December 2021, banned direct-selling companies from promoting pyramid and money-circulation schemes as it notified new rules for the direct-selling industry.

The Sri Lankan Parliament, President Gotabaya Rajapaksa and Prime Minister Mahinda Rajapaksa had condemned the brutal killing and expressed hope that the Pakistan government would bring the guilty to justice. Pakistan has extremely strict blasphemy laws against defaming Islam, including the death penalty, and rights campaigners say they are often used to settle scores in the Muslim majority country.



## Chess: India's Gukesh wins La Roda Open; Pragg, Sadhwani among top 5

MUMBAI, April 18 (IANS): India's D Gukesh, the third youngest Grandmaster in the world, has won the 48th Open Ajedrez La Roda chess tournament at La Roda in Spain, overcominng the challenge of Israeli GM Victor Mikhalevski in the final round.

Gukesh, 15, who went into the final round with seven points, defeated Mikhalevski with white pieces to finish with 8.0 points from nine rounds to top a field comprising 193 players.

Armenian GM Haik M. Martirosvan finished second with 7.5 points while Indian GMs R Praggnanandhaa and Raunak Sadhwani finished joint third with three other players -- all five ending their campaigns with 7.0 points from nine rounds. Pragg finished third on tiebreak and Sadhwani was fourth.

This is the first Open title for the 15-year-old Gukesh and comes soon after he had lost to compatriot Praggnanandhaa in the final round of Revkiav k Open a few days back.

MUMBAI, April 18 (IANS): Former South Africa skipper Graeme Smith feels that Kolkata Knight Riders will need the spin combination of Sunil Narine and Varun Chakravarthy to get going against Rajasthan Royals at Brabourne Stadium on Monday.

A large chunk of Kolkata's success has been provided by the off-spin and mystery spin combination of Narine and Chakravarty stifling the opposition's batters and stemming the run-flow.

But in IPL 2022, the duo are yet to set the stage on fire. While Narine has picked four wickets with an average of 30 and economy rate of just five, Chakravarthy hasn't been at his controlling best, picking four scalps at a high average of 47.75

# Benzema rallies Madrid past Sevilla, closer to league title

MADRID, April 18 (AP): Karim Benzema came up big yet again.

He scored in second-half stoppage time on Sunday as Real Madrid rallied to a 3-2 win at Sevilla and moved closer to winning the Spanish league title for the second time in three seasons.

Madrid conceded two goals four minutes apart in the first half but came back after halftime to win and open a 15-point lead at the top of the standings with six rounds to

"Everyone is waiting for Madrid to stumble but Madrid doesn't stumble," Madrid coach Carlo Ancelotti said. "Madrid has heart, character and quality. It was a deserved win. The league is not over yet, there are several matches left, but it was a big push for us today.

Madrid's closest challenger is Barcelona, which has two games in hand, including against relegation-threatened Cádiz on Mon-

day.

Third-place Sevilla could have cut Madrid's gap to nine points with a win at its Ramón Sánchez-Pizjuán Stadium but instead saw its 15-game unbeaten streak at home this season come to an end.

Benzema scored his 15th goal in the last 10 matches with a shot from close range after a pass by Rodrygo two minutes into stoppage time.

The France striker is the Spanish league's leading scorer with 25 goals and is having one of his best seasons yet with Madrid. He had already been decisive in recent Champions League matches against Paris Saint-Germain and Chelsea, being crucial in Madrid's run to the semifinals.

Sevilla looked on its way to a comfortable victory after opening the scoring with Ivan Rakitic's low free kick in the 21st and adding to the lead with Erik Lamela's goal from inside the area in a breakaway in the

But Madrid dominated after that and pulled closer with Rodrygo's goal from



close range after a pass by Dani Carvajal in the 50th. Carvajal then set up Nacho Fernández's equalizer from inside the area in the 82nd, a few moments after Nacho had entered the match.

BERLIN, April 18 (AP): Bayern Munich won 3-0 at struggling Arminia Bielefeld on Sunday to take another step toward a record-extending 32nd German league title, moving nine points ahead of secondplace Borussia Dortmund with four games left.

The Bundesliga race could be decided when the teams meet in Munich next Saturday.

It was an expected but welcome win for Bayern after a surprise elimination by Spanish side Villarreal in the Champions League quarterfinals.

"In the end, the first 20 minutes were a good indicator of how we come out of this week," Bayern coach Julian Nagelsmann said. "It was a deserved win and important that we got the chance to seal the title against Dortmund.'

Bayern led after 11 minutes when Danish defender Jacob Barrett Laursen scored an owngoal under pressure from league top scorer Robert Lewandowski.

The goal was awarded following a video replay which confirmed Lewandowski was not offside when he went to meet Joshua Kimmich's pass.

Serge Gnabry scored the second goal — also awarded following a VAR review — in the eighth minute of first-half stoppage time from another pass by

The first half was delayed near the end when Arminia's Fabian Kunze was stretchered off injured after taking an elbow during an aerial challenge.

Bayern was rarely troubled by a side which has scored only 23 goals, nine less than Lewandowski has managed himself. Lewandowski, who has netted nearly 350 goals for the club overall, is in talks over a new contract, with his current deal expiring at the end of next sea-

He set up Jamal Musiala for the third goal in the 85th.

Arminia said that about 10 minutes from the end of the match a fan had to be "resuscitated" in the stands and was taken to the hospital after being stabilized.
