While ₹ 42.87 crore was allocated under the BIM for the India-China border in the Northeast in 2020-21, ₹ 249.12 has been allocated in 2021-22 for it, he said in a written reply to a

### Crimes by Russia no different than those carried out by ISIS: Zelenskyy tells UNSC

UNITED NATIONS, April 5 (PTI): Ukraine President Volodymyr Zelenskyy told the UN Security Council on Tuesday that the atrocities committed by Russian troops are no different from terrorists like the Islamic State extremists as he demanded immediate action to bring the Kremlin's forces to justice for "war crimes".

'Yesterday I returned from our city of Bucha, recently liberated from Russian troops not far from Kiev. There is not a single crime that they would not commit there. The Russian military searched for and purposefully killed anyone who served our country," Zelenskyy said in his first address to the UN Security Council.

Giving a detailed account of the brutalities conducted by the Russian forces, he said 'this is no different from other terrorists such as Daesh who occupied some territories. And here it is done by a member of the United Nations Security Council, destroying internal unity, borders and countries." "We are dealing with a state that is turning

the veto in the UN Security Council into the right to die," he said in his impassioned address to the UNSC. 'This undermines the whole architecture

of global security. It allows them to go unpunished."

He asserted that the UN system must be reformed immediately "so that the veto is not the right to die."

"The Russian military and those who gave them orders must be brought to justice immediately for war crimes in Ukraine," he said, adding that (CONTD. ON PAGE-9)

## Parliament passes accountancy bill

NEW DELHI, April 5 (PTI): Parliament on Tuesday passed a bill to revamp the functioning of the institutes of chartered accountants, cost accountants and company secretaries, with Union minister Nirmala Sitharaman asserting that the changes will usher in transparency and will not in any way impact the autonomy of these bodies.

Rajya Sabha passed the Chartered Accountants, the Cost and Works Accountants and the Company Secretaries (Amendment) Bill, 2022 with a voice vote after negating all amendments moved by the Opposition.

Lok Sabha had cleared the bill on March 30.

Replying to the discussion in the Upper House, Sitharaman asserted that the new legislation would facilitate India in creating homegrown world class institutions soon, comparable with the 'Big Four' in the audit and accountancy areas, and meet the global demands.

"This (bill) is with the intention of making the three institutions a lot more transparent in their disciplinary matters, and raise the quality of the disciplinary processes. Above all, I think this would also facilitate India to be able to support institutions and firms which can be encouraged by the council to create something (completely of India origin) similar to the Big Four, which we periodically talk about," she

Sitharaman, who is in charge of finance and corporate affairs ministries, noted that the bill has been envisaged after consulting various stakeholders and taking into account the findings of the Meenakshi Datta Ghosh committee. Stressing that India (CONTD. ON PAGE-9)

## Group announces plan to build world's largest church in Mizoram

AIZAWL, April 5 (PTI): A Christian group of Mizoram has claimed that it will build the world's largest church building in Serchhip district of the North-eastern

The proposed church building will be erected on a land measuring 23,809.52 square metres, 809.52 square metres more than the area occupied by St Peter's Basilica in Vatican City, which is currently the largest church in the world, the chief of the religious group said.

The 'Zofate Pathian Biakinpui' (Big church for all Mizos) will be set up at Thenzawl town, around 87 km from here, said Rev Dr Zaichhawna Hlawndo, who founded the Zoram Thar Zofate Lairelna Inpui, a non-denominational church, in February 2016.

Releasing the blueprint of the church

here on Monday, Hlawndo said the church will belong to all 'Zofate' (Mizo tribes across the world) and will be constructed through public donations and voluntary services.

The length and breadth of the church area will be 270 feet each and its height will be 177 feet, he said.

There will be 30,000 seats inside the building and its courtyard will be large enough to accommodate about 70,000 people, Hlawndo said.

The building can be used by any church or Christian group for worship or religious assembly, he said.

It will belong to all Mizo tribes, the Zoram Thar group leader said adding that land has been purchased for building it but construction work is yet to start.

The group members claim that they are

descendants of Joseph, one of the 12 sons f Biblical patriarch Jacob.

Hlawndo worked as a missionary under the Presbyterian Church of Mizoram in various parts of the world and has settled in the United Kingdom before he returned to the state in 2012. He floated

'Zoram Thar' four years later. He claimed that he received a 'divine call' to return to Mizoram while in transit

at Dubai airport. The group had contested 24 seats in the last assembly polls in 2018 but failed to win a seat. It had organised a religious conference of all Mizo tribes in December last year during which memorial stones for various Mizo tribes were erected. ## Shares of Tata Motors shift gear on firm sales volumes

NEW DELHI, April 5 (IANS): Shares of Tata Motors rose on Tuesday in an otherwise subdued broader market. The shares of the automaker gained 6 per cent in the past three trading days as the company reported healthy sales volumes -- for both passenger and electric vehicles -- in March and the entire FY22 fiscal. It reported the highest ever annual sales of its passenger and electric vehicles at 370,372 units in FY22, which was 67 per cent more than the offtake in FY21. In March, Tata Motors' total domestic sales volume grew 30 per cent year-on-year to 86,718 units as against 66,462 units reported in the same month last year. Tata Motors set several new records in a challenging year disrupted by two waves of Covid, semiconductor crisis and a steep increase in commodity prices globally.

## Recovering from Covid, hospitality sector finds hiring tough

CHENNAI, April 5 (IANS): With the Covid-19 restrictions being removed and international travel opening up, hoteliers in and around Chennai are expecting their till boxes ringing this fiscal, said industry officials.

In line with the expectations and also increased room occupancy and guest footfalls in their restaurants, the industry has started hiring processes.

However, hoteliers also say finding talent is difficult as many of those who had lost their jobs due to the pandemic have gone into other sectors and those who wanted to continue have found jobs in other properties. According to surveys, the travel and hos-

pitality sectors lead in hiring. "Room occupancies and restaurant footfalls are on the rise. Once international travel is opened up then the business will further improve," Yangya Prakash Chandran, founder and CEO, Crossway Hotels and Resorts, told IANS. Crossway Hotels manages the Days Hotel By Wyndham Chennai OMR.

According to Chandran, the hotel's restaurant NutCracker is getting higher footfalls during the weekend which shows people are wanting to go out and have food.



"Once the IT sector reverts to work from office instead of work from home then the restaurants in the OMR will gain good traction". While the CEO said he will start having food festivals once the business gains momentum, Mercure Chennai Sriperumbudur had one festival recently.

The 100-room property Mercure, part of French group Accor, is located in the Sriperumbudur-Oragadam industrial area.

Celebrating its fourth anniversary, Mercure Chennai organised the 'Art Brunch Fes-

tival' last month. The art exhibition was on the theme 'Here, There and Everywhere', depicting the history of transportation. The show traced the concept of mobility

starting from the Vahanas from ancient Indian mythology to the ancient modes of transportation using animals and log boats up to the technological marvels we see today.

According to Rahul Nama, general manager, Mercure Chennai Sriperumbudur, there is pent-up demand as domestic travel restrictions have been removed.

"The business and leisure travel sectors are picking up. As there is still work from home regime, there are guests who come with their family and do their office work," Amit Kumar, general manager of the luxury beach resort Sheraton Grand Chennai Resort and Spa told IANS.

According to Kumar, the domestic MICE (meetings, incentives, conferences and exhibitions) segment has picked up with several corporates from other parts of the country booking rooms at Sheraton Grand. "Sixty per cent of our room nights last month was from the corporate sector," Kumar added.

However, the window lead time for book-

ing for the MICE segment has come down,

Kumar also added that once international travel is opened up fully then the leisure travel within the country may stagnate as people would like to go overseas.

He said the 129-room Sheraton Grand had an occupancy ratio of about 75 per cent last month and the same levels are expected in April. Referring to the upcoming Chess Olympiad in Mahabalipuram near Chennai, Kumar said star hotels in the East Coast Road and Old Mahabalipuram Road (OMR) will be full from July 25 to August 9.

"As a result, people wanting to stay along the coast may go to Puducherry. The hotels in Puducherry may benefit then.

On hiring trends, Kumar said the hospitality sector is recruiting people but finding the right talent is tough. The industry is tapping into its database and contacting their old employees who had lost their jobs due to Covid-19 lockdown. "The people are not coming at pre-Covid costs. Pre-Covid the cost was different and now it is different. Further, people have changed their mindset as some do not want to come back to the sector.'

In his budget speech, he informed that the budget allocation for the year 2021-22 includes consolidated State Owned Priority Development (SOPD), Assistance to BTC for Infrastructure

In his speech after the approval



of the budget, the deputy chief of BTC Gabinda Chandra Basumatary said the BTC budget for 2022-23 was pragmatic and propeople as many new proposals have been included for the overall benefit of the people. He said important departments were given maximum priorities for sustainable development. Since it is the council budget, it is a minimum budget but an optimum to meet the target, he said adding that education, PWD, health and agriculture were given maximum importance for the larger interest

MCLA of UPPL Sanjay Swargiary said the budget is significant for new changes in the region. He said the budget had a target to cover at least 1000 km of road in the BTC region which is going to be a record. He also said there had been no connecting roads in Udalguri and UT road by previous government had not

#### Lanka eyeing change of guard?

confidence in their government. After the recent economic Crisis, the country has now also plunged into a political crisis. On Monday, news reports said that the entire Sri Lankan Cabinet has resigned. There were also rumours that Prime Minister Mahinda Rajapaksa had resigned or would resign soon but his office denied the rumours. Another rumour that India had sent its military personnel to help the Sri Lankan authorities maintain peace and order was also denied. Various rumours are doing the rounds in an environment where President Gotabaya Rajapaksa has imposed a state of emergency, banned people from coming out of their homes from Friday evening to Monday morning, and briefly suspended social media. Interestingly, Sri Lankan economic crisis and people's protests leading to a general emergency in the country have not found much coverage in the international media, which remains preoccupied with the Russia-Ukraine armed conflict.

As has been widely reported, members of the Rajapaksa family are occupying top positions in the country's political leadership. The President, the Prime Minister, and the finance minister are all brothers. There are more Rajapakshas in the government and the Sri Lankan Parliament. And, they have been there for a long time. For example, current Prime Minister Mahinda Rajapaksha who assumed power in 2019 had been the President from 2005 to 2015. During his tenure as the President. Sri Lanka waged a conclusive war on LTTE. Notably, his regime is marked by gross violations of human rights and in-fringement of press freedom. So far, the Rajapaksa family has been able to rule the country without much trouble as they were using the China card against India. All in all, the Rajapaksa brothers must share some blame for pushing the country into the deep economic mess that it finds itself today.

Navib Bukele, president of the fifth-poorest country in Central America El Salvador, last year announced the onboarding of bitcoin as the legal tender. To beat IMF's coercion for a USD 1 billion loan, Bukele announced USD 1 billion worth of bitcoin bonds. The point is a President or a Prime Minister has to act on behalf of the people and if it takes mocking the world or breaking a few taboos and glass ceilings, they are expected to do so, in a style that Bukele has illustrated by adopting bitcoin. ## The fall and fall of Mayawati in Uttar Pradesh since 2014 elections

degenerated ideology will ultimately give rise to a perverse electo-politi-Agive rise to a perverse electrical system and create a deviant political vacuum. Notwithstanding the BJP grabbing the power in Uttar Pradesh in the recent assembly election, the state suffers with an acute political vacuum. An insight into the nature of the political vacuum makes it obvious that there is little possibility getting this repaired in near future.

The saffron leaders claim that the shift of the dalit voters, especially the Jatavs, the committed support base of Mayawati, to the BJP had started in 2019. In this election, they moved in significant number. Though UP has dominance of the upper caste feudal lords, the Dalits and the anti-BJP forces dictated the politics till 2000.

The political decline of these two forces witnessed the resurrection of the feudal and junkers as the new ruling elites. During this period the feudal lords who formed the base of the Congress shifted their loyalty to the BJP. The Dalits too started shifting their allegiance to the BJP. Two antagonistic and inimical forces started coming closer.

During the last five years almost all the founder members of the BSP, those who were handpicked and inducted in the party by Kanshi Ram had to leave or expelled

from the party by Mayawati. In 2019 while some joined the BJP, in 2022 at least 12 senior Jatav and Dali leaders joined the Samajwadi

Throwing out these senior Jatav leaders from the BSP started in 2014 when Mayawti gave the call for united front of Dalits and Brahamans. The person who gave a shape to this slogan was none else that Satish Mishra the close confidant of Mayawati. Her call for unity of Brahmins and Dalits panicked the

After dictating the Uttar Pradesh politics for 40 years, BSP was completely washed out in 2022 assembly election. In 2017 it had won 19 seats in the assembly polls and had managed a vote share of over 21 per cent. But in 2022 the BSP was restricted to single digits with a vote share of 12.73 per cent.

It is quite intriguing to comprehend what made the BSP to perform so poor; a party which had bagged 206 seats and a vote share of 30.43 per cent and formed the government in 2007. It is an open secret that since 2014 Mayawati's core vote shifted towards SP and BJP. She failed to protect her vote base from drifting specifically for two factors. The Dalits, core voter of BSP felt that for the first time they have got some benefit



ment, secondly Mayawati refusing to open front against BJP and even demystifying opposition parties as enemies of the dalits, particularly the Samajwadi Party, disillusioned the core voters.

Most of prominent leaders who had strong mass base, like Indrajit Saroj, Lalji Verma, Ram Achal Rajbhar, Om Prakash Rajbhar and Tribhuvan Dutt, who DEGREE OF THOUGHT helped shape the BSP, this

time left the party for SP.

Experts feel that ED and CBI framing her brother at the instigation of the BJP scared her to take fight against BJP. Yet another reason for the shifting of loyalty has been her "hasty" step of breaking the alliance with the SP after the 2017 assembly election. Only a couple of days back, Mayawati accused the Muslims of betraying the BSP and no voting for it. But she refrained from accusing the Dalits for shifting their loyalty to the BJP. Nevertheless a question is being put to Mayawati that she must explain the reason why the Dalits and Jatav deserted the BSP, which they formed under

the leadership of Kanshi Ram. It is an open

secret that Maywati never supported the

Muslims and stood in their favour. She even

openly called upon Dalits to vote for BJP.

Her coming to power in 2007 witnessed her political eclipse. Expert feel that if she had not made a tactical shift and evolved the formula of social engineering to attract Brahmins to a party which had a massive Dalit base, she might not have faced the decline. The dalits felt betrayed and alienated. While they were scared of soft attitude towards the BJP, the party diluting its hard dalit ideological line was seen as endangerhave been dominant feudal caste in the state and they are known to perpetrate torture and atrocities on the Dalits

Uttar Pradesh, particularly the districts Deoria, Gorakhpur, Varanasi, Chandauli, Sonbhadra and Mirzapur located in the eastern region of the state had in the eighties and early nineties witnessed volatile left movement. It was during this period the state witnessed resurrection of Naxalite movement in

The left parties even in this caste dominated state won significant number of seats. But unfortunately the left succumbed to the caste cauldron. As in other states it became the victim of caste and failed to organise a peasant struggle though the eastern UP has been most fertile area. For such movement.

The Left parties had sought to join a broad anti-BJP alliance for the UP polls but that did not happen. Akhilesh Yadav abhorred them. Even a small seat sharing could have brought about significant change. They were left with no alternative. Despite deciding to go it alone now, they fielded candidates on a limited number of seats to avoid a division in anti-BJP votes as such a split would be to the disadvantage of the Opposition parties. CPI state secretary Girish said the Left parties had decided to go it alone after other po-litical parties did not respond to their overtures for the anti-BJP alliance.

The Left movement is said to have become weak in the post "mandal-kamandal" era and the left parties have ceased to make an electoral mark in the politics of the state since then. They failed to send a single candidate to the Vidhan Sabha in 2007, 2012 and 2017 assembly elections though the Left

The Left is contemplating to revive its dwindling fortunes in Uttar Pradesh. However, past election figures reveal that the Left parties in the state have been on a downward slide since the Ram Temple movement, which had polarised a large section of the Hindu votes. Communist Party of India has been participating in the UP poll since 1951 as a national party, while CPM made its electoral debut in UP in 1967. In 1951, CPI fielded its candidates from 43 assembly seats, and could not win a single seat. As many as 38 of its candidates were forced to forfeit their deposits.

It was 1974 assembly election that the Left parties took a giant leap forward and claimed 18 seats in all. Out of 40 candidates, fielded by the CPI, 16 romped home, and the vote share for the first time crossed 25% mark (25.57%). Udal retained his seat from Kolaslah, while two candidates of CPM out of 36 fielded by it also won. The 1977 assembly poll saw Mitrasen Yadav emerging on the political canvass of UP, as he won from Milkipur assembly seat in Faizabad on a CPI ticket.

The 1993 assembly election was the first to be held after the Ram Temple-Babri episode. The temple movement had polarised the votes in UP, and this was evident on the dipping numbers of the Left parties. While, CPI won three seats, the CPM could manage only a single seat. The CPI emerged victorious at Kolasla (Udal), Mohammadabad (Afzal Ansari) and Milkipur (Mitrasen Yadav). CPM's Ramswroop Singh defeated Rajender Prasad of the BJP by 5,912 votes in Najibabad in Bijnor district.

The downslide of both the parties continued even in 2002 assembly election, as CPI could not win even a single seat, while CPM won 2 seats out of six it contested from. The Left movement is struggling for survival in the face of a stiff challenge posed by communal and casteist politics in the state. The Left movement in the state has been marginalised with none of its members entering the portals of the Vidhan Sabha in 2007 and 2012 elections, as the Left parties faced a

Notwithstanding the reverses suffered in the last two elections, all the Left parties, including CPI, CPI-M, Revolutionary Socialist Party and Forward Bloc, have together fielded candidates on 140 seats of the total 403 Assembly constituencies in UP this time. Cultural backwardness, lack of understanding of political ideology and failure to identifying the class enemy have been primary reasons for the degeneration of the left forces and BSP in Uttar

miserably failed. There were many hurdles in the way, and chief among them was the faulty and unreasonable policies of the Centre itself. It resulted into a situation in which tomatoes were being sold at ₹ 3 per kg and ginger at ₹ 5 per kg, even leads the farmers not to pluck their produce as the plucking cost will be much more than the selling price.

This sad observation have been made by the Department related Parliamentary standing committee or Agriculture, Animal Husbandry and Food Processing in its recent report submitted in the Lok Sabha after discussion on the Demand for Grants. The Committee said that the same case happens with onion also. As these foods are the daily requirement of the citizens of the country, the committee felt that the Ministry should immediately establish cold chain by identifying the villages where there was a large production but the benefit of income does not reach the farmers as they are forced to sell at a cost which is very pa-

The committee observed that despite the production of large scale agriculture produce in India. Food Inflation and Food Security issue were major concerns since they affect the basic need for the citizen to have sufficient healthy and affordable food. It was pointed out in the report that the Harvest and Post-Harvest losses of major agricultural produce was estimated to be ₹ 92.651 crore at national level as per the study conducted by CIPHET, Ludhiana while most of the population in the country are under-nourished leading to several health issues as they are not able to get the food at affordable prices and this reveals loopholes in Post Production Process and Cold Chain Manage-

Though the Food Processing Industry Sector has reportedly been growing at an average Annual Growth Rate of 11.18 per cent and provides 12.38 per cent employment of all the registered factories in the country, the Ministry of Food Processing Industry did not spent the amount it was allocated in the last three years since

The Ministry had proposed an amount ₹ 2,200 crore (against the spending of ₹ 845.54 crore), ₹ 1,232.94 crore (against the spending of ₹1,152.68 crore) and ₹ 3,490.07 crore (against the spending of ₹ 862.60 crore), respectively but only an amount of ₹1,042.79 crore, ₹ 1,247.42 crore and ₹ 1,304.12 crore were allocated for the years 2019-20, 2020-21 and 2021-22, respectively. The Committee also noted that for the year 2022-23 ₹ 3,564.92 crore has been proposed whereas only ₹ 2,941.99 crore had been allocated. The committee therefore recommended that the Ministry should chalk out its Plan of Action in advance for cent percent utilization of scarce resources allocated and

look into the issues/challenges. With regard to all the plan Schemes, especially the Food storage and Warehousing and North-Eastern Areas, there has been consistently negative variation for the years 2019-20, 2020-21 and 2021-22, respectively, as compared to the previous years. The reason was, as per the reply of the Ministry, receipt of inadequate proposals under mandatory allocations like North-Eastern Region (NER), Schedule Cast Sub Plan

(SCSP) and Tribal Sub Plan (TSP), however the Committee found the reply unacceptable. The receipt of inodi's doubling farmers income by 2022 has adequate proposals is a recurring problem appearing agenda. This time it is about the inclusion of the year after year and the Ministry of Food Processing Industries is remaining only as a mute spectator, the Committee observed.

Though the Ministry of Food Processing Industries runs several schemes, all States and Union Territories are not covered. It is due to the fact that the schemes of the Ministry are Demand Driven and they are implemented from wherever demand is received. The committee has asked the government to chalk out the Plan of Action and be ever ready to implement its schemes in all States and Union Territories. The committee felt that if all the regions were developed, it would ultimately lead doubling of the farmer's income. Mega Food Park is one of the flagship programmes of the Centre which is being run since 2008. The committee was totally dissatisfied to find that only 41 Mega Food Parks had been sanctioned since its launch, and only 22 of them had become operational. This shows that the response for this scheme is not very much forthcoming in spite of 14 years of its launching and the decision of the Centre to supplant the scheme with Agro Processing Clusters. The Committee observed that the Project has become a white elephant for the Government.

Integrated Cold Chain and Value Addition Infrastructure scheme was also launched in 2008. In 2012, Dr Saumitra Chaudhary Committee had estimated that the country required Cold Storage for 61 million tonnes, while the gap was estimated to be 29 million tonnes. Further as per the Study carried out by National Centre for Cold Chain Development (NCCD) in August, 2015 the requirement of Cold Chain for Integrated Pack Houses was 70,000, Refer Trucks 62,000, Cold Store (Bulk & Distribution hub) 35 million tonnes and Ripening Chambers 9,000. The committee noted that the funds allocated for the purpose are underutilized.

The committee also noted underutilization in several other schemes, and many of them are suffering from sluggish implementation. The Ministry should stick to the time schedule and full utilization of funds allocated, the Committee observed. Infrastructure development for Agro Processing Clusters scheme was specifically mentioned in this regard which was launched in 2017. The Centre approved 68 projects but only 12 have been completed since inception of the scheme. This shows non-satisfactory planning by the Ministry as also the non-satisfactory implementation, it was observed. (IPA Service)



## Reawakening of the saffron roots

he Bharatiya Janata Party (BJP) once again

proved its uninterrupted and indubitable proximity towards what its political adver-Bhagavad Gita in the school syllabus in the party ruled state of Gujarat. Karnataka, another BJP ruled state recently witnessed upheavals in the name of Hijab. The Hijab controversy was scoffed at as a deliberate weapon that the BJP consciously brought out from its Hindutva casket, propelling an issue well before its bastion Uttar Pradesh went to polls. The issue remained in discussion for months until the appellants were told by the court to stop unnecessary commotions and directing them to fall in line with the democratic principles of the state. The Karnataka high court candidly made its observation enlightening the minority community, by pronouncing its verdict that the Hijab had never been an integral part of Islam. For the critics it is the BJP's saffron agenda but the party is unaffected by the hubbubs of the liberals on the streets and now it has come out with a different issue. The party steered another controversy by revamping the education system with the inclusion of the Gita which it probably thinks would bring about greater understanding among the children about India and its spiritual heritage. But the writing on the wall is incredulously indicative to a motivated push keeping an eye on the forthcoming state elections in Gujarat. A little dose of dharmic values to the young generation, according to the party, would do greater good to any society but a complexity such as India would reciprocate to everything with a deceptive note as it has deeply been entangled in the intricacies of secularism. And secularism, except for accepting different faiths with equal benchmarks, does everything that it can; to disregard, disorient and disproportionately demean everything that is part of human life. Concerns are genuine as to why the party that is in power is taking strides in the direction of genuinely appeasing a particular community and disregarding the emotions of the other, probably by hurting their sentiments and beliefs.

The country had witnessed aggression in the name of cow vigilantism by a bunch of transgressors vandalizing the spiritual ethos that India stood for generations. Dharma or righteousness is the core principle that the Gita exhorts through its seven hundred verses. The central idea of the Gita runs through an intense friendly conversation that happens between Lord Krishna and Arjuna in the middle of the battlefield. It envisages and urges the followers to take one among the three paths that it advocates, the Karma voga, Jnana Yoga and Bhakti Yoga which, if simply translated could be termed as the path of sincere work, knowledge and devotion. The paths to liberation or salvation or nirvana, according to Gita, is possible through choosing any one of the above three by following its principles diligently. The plight of Arjuna in the battlefield was terrible and disproportionate to his being, a warrior prince, and the discourse that Lord Krishna puts him through reveals the ways in which life should be lived and critically examines the folly of principles that manipulated


people's mind. India and Hinduism are defined as the essence of plurality and the strength it squeezes to survive is from the unity that the plurality ultimately aims at. The idea of pluralism is have an underhanded plan to infuse the social sudirectly indicating what monism stands for. Essentially, pluralism in India always maintained the impression that "ekam sat vipra bahudha vadanti", which means truth is one and people call it by different names. Semitic religions exhorted that there was one spiritual principle that was capable of awarding salvation, possibly discrediting the multiplicity that India offered with more freedom and liberty- undoubtedly, perplexity and animosity taking centerstage and skepticism becoming the villain.

By including the Gita in the syllabus, does the BJP plan to impose its version of Hinduism on others. Implementation to the level of gaining acceptance from all corners would define its purpose and the intention behind the initiative. As a country or a conglomeration of principalities, India remained and still remains to be one in essence and principle mainly due to the values that we propagated from the great epics the Ramayana and the Mahabharata. Nobody can deny the fact that the spiritual essence that India is gaining acceptance across the globe, is mainly due to the secular spiritual values that the Vedas and the Upanishads and the Epics that we have been handed over through generations. Our existence during the British period remained limited to the country of "Brown Sahibs" that Lord Macaulay wanted Indians to be transformed as. He wanted a new education system based on the English culture and spirit substituting the one that traditionally existed in India which taught the world," Vasudhaiva Kutumbakam", which means the world is one family. The BJP's experimentation, introducing the Gita in school curriculum should explain the manner in which it might complicate the indispensable cord of distrust that it was successful in tying the country with. The party must take sincere efforts to win the hearts of all the stakeholders convincing them the need of such an exercise through which the constitutional concomitance of multiplicity would be strengthened. This should also help to rediscover the spiritual essence of India which is inclusive-

ness in its purest form which nobody, even the immature standards of politics, should be capable of meddling with. Therefore, the party cannot premacy of a particular religion. This would lead to mistrust and friction further.

The Hindus believe in Karma, the focal factor that they think would determine the destiny and a key to rebirths. This is one of the main tenets that the Gita elaborates at length and an idea that people across the globe are giving attention to. The Biblical maxim "you reap what you sow" is in line with what Lord Krishna propounded to Arjuna saying that it is the Karma that determines what we are destined to land upon. Going further Krishna makes the point clear. He says if the Karma is performed with dedication, the result is bound to be good. The Gita holds the philosophical depth to transform young minds with clarity of vision and the ability to untie the complexity of life. The saffron political patronage of the BJP should not be jumping into making political dividends out of the initiative that it takes to implement the Gita in curriculum. It should handle a complex philosophy such as the Gita with meticulous care. Before the curriculum is revamped in a haste, there should be preparatory exercises by experts to dilute the philosophy into a digestible fashion for the children. With exam-driven minds, the children need proper guidance to deal with the philosophy of the text while the real secular message of the Gita holds the power to strengthen them. The dilemma and the discord that Arjuna went through could hit anyone's life and the Gita offers a solution to those who sincerely seek. The whole theme of practice by the government should not end as a political gimmick making nothing solid out of it. That would break the cohesiveness in the learning atmosphere of schools, making young minds offensive to the life-giving principles available in the holy text. # Air pollution is worsening reproductive health outcomes for women in India – and around the world

The pandemic is always on the back of Riya Gupta's mind. As a pregnant commuter in Delhi, one of the world's most densely populated cities, she worries about reports that Covid-19 can result in complications and affect her baby's development. But while the sense of urgency around the pandemic recedes, another source of concern looms larger: air pollution.

If Covid-19 is a "direct killer", Gupta, who works in public health communications, calls air pollution "the slow killer".

"I've been coming across research recently on how [air] pollution, specifically in Delhi, would have direct consequences for my child, both in terms of weight and increasing the risk of prematurity," said Gupta. "Given that I'm in my second trimester right now, all of this does scare me a

A global problem

Gupta's hometown Delhi is the world's most polluted capital, according to data from IQAir, a Swiss company that collects real-time air quality information. The problem is a truly global one as much as 99% of the world's population breathes in air with pollution levels higher than World Health Organisation's safe limits. But the highest levels are found in poor and developing countries, where most of the seven million annual deaths linked to air pollution are concentrated.

Public health officials have mostly focused so far on respiratory diseases and the impact on young children. With relatively little research available on the impact of air pollution on women's reproductive health, or the different ways in which men and women are exposed, the issue has mostly slipped under their radar.

"Exposure to air pollution during pregnancy is associated with complications or adverse events during pregnancy [e.g., preeclampsia, miscarriage, gestational diabetes, high blood pressure] and adverse birth outcomes such as pre-term birth, low birth weight or in some cases, stillbirth," said Pallavi Pant, a senior scientist at the fertility rates or depression among pregnant

It is not just outdoor air pollution - women in the densely-populated region are also disproportionately hit by high levels of poor-quality air indoors as they tend to be primarily responsible for cooking, and firewood continues to be widely used as a source of cooking fuel, emerging studies show. In India alone, an estimate finds that 0.61 million deaths were attributable to indoor air pollution, though the data was not segregated by gen-

"Lack of access to clean energy also means that women are often responsible for collection of fuelwood, and this takes time away from other productive or recreational tasks," said Pant, a key contributor to the State of the Global Air report, which provides annual analysis of global trends in air quality and its impact on health.

And as indoor air pollution also affects young children, women are saddled with the dual burden of caring for their own health as well as that of a

Much of this evidence has only emerged in recent years, as availability of data has improved. Climate gains of improving air quality

Pollution levels are significantly higher in much of the developing world. It is worst in South Asia, where in 2021, 18 of the world's 20 most polluted cities were spread across the Indo-Gangetic plain in India and Pakistan. Four of the 10 worst countries for air pollution according to IQAir are in South Asia: Bangladesh, Pakistan, India and Nepal.

Here, most people breathe air with pollution levels several dozen times higher than the WHO safe limits, according to the State of the Global Air report 2020 released this March. And not much appears to be changing. The report found that air quality in India and Nepal in particular had shown very little improvement over the past

Existing research estimates the current air pollution could shave off up to a decade from the life expectancy of people in the region. And some



modeling studies suggest improving air quality in South Asia alone would prevent 7% pregnancy losses in the region.

Many of the particulate pollutants that cause air pollution also contribute to the greenhouse effect and global temperature rise, according to the WHO, whose director for public health and environment Dr Maria Neira has, for the past few vears, been making the case that the solutions to cleaning up our air will also have clear climate

Benefits to women go beyond better air quality

Solutions to improve air quality would also have other benefits. Expanded access to clean cooking fuels reduces the need for time-consuming wood and biogas fuel gathering, usually done by women and girls, thus leading to gains in health and gender equality, said Pant.

hold cooking and lighting solutions, including more renewables such as solar electrification and biogas fuel, go hand in hand with expanding energy access, a key United Nations Sustainable Development Goal.

In the meantime, policy makers need to factor in gender differences in exposure levels, said Azra Khan, a programme manager with the cities and transport team at the think tank WRI-India.

Along with breathing in more polluted air in the home, women are in fact more likely to be exposed to air pollution outdoors, she said. One pilot study in India's Bhopal city found women were more likely to walk to work and hence breathe in higher levels of outdoor air pollution during their daily journeys to and from home.

Women engaged in low-paying jobs such as street sweeping, construction and street vending also face high levels of exposure, said Khan, observing that most data on gender inequalities in

air pollution exposures are mainly focused on household air pollution. "But what beyond that, and how is it [air pollution] contributing to their overall health outside of their caregiving responsibilities?" Khan asked. "That data is not there."

Authorities don't factor gender into solutions Authorities do not currently factor gender in their solutions. Tanushree Ganguly, an air quality researcher at the Council of Energy, Environment and Water, and her collaborators examined 102 air cleaning plans for Indian cities. She pointed out that though India's National Clean Air Programme refers to the impact of indoor pollution on women and children, the city-level plans do not explicitly look at gender.

"[If] I'm undertaking actions which are aimed at reducing air pollution, they all impact the residents of the city, which of course includes women and children," Ganguly observed.

One of the few initiatives that targets women is a flagship government program on household air pollution. Called Pradhan Mantri Ujiwala Yoiana, it aims to enable rural and poor households to transition to cleaner cooking fuels by providing them with cooking gas cylinders, but has met with limited success and gaps remain.

In terms of ambient air pollution issues, localised strategies such as the erection of smog towers in Delhi also have failed to make an impact. Large scale initiatives supporting transitioning to renewable energy is promising but so far hasn't helped significantly reduce air pollution as the country still heavily relies on coal fuelled thermal power plants.

While people can limit their exposure to air pollution by using air purifiers when indoors, there is not much they can do when outdoors, said Ganguly. Cities will have to find ways to promote clean transportation, improve waste management and reduce dust.

Gupta, who grew up in Delhi, is resigned to breathing in polluted air, saying that even after installing indoor air purifiers there is only so much control she has over her immediate environment. "I have to travel to work. No matter what I do, I am exposed," she said. (Courtesy: Scroll.in)

#### Trauma of Ukraine's women refugees: Does the Muslim woman today Rape, trafficking & Poland's sexist laws have the right to chase her dreams?

leksandra (name changed), a Ukrainian volunteer in Poland's capital city Warsaw, is confident that the cases of rape and sexual assault by Russian soldiers against Ukrainian women are 'massively underreported'.

"We've attended to tens and thousands of refugees in the past four weeks. It's too early to estimate how many of them were subjected to sexual violence but the numbers are high," she tells The Quint, claiming that she has met at least a dozen rape survivors since efugees started coming it

Narrating a survivor's account, she says, "I met 29-year-old Olga (name changed) at the Hrebenne border crossing between Ukraine and Poland. She opened up to me when I spoke to her in Ukrainian."

Olga was allegedly sexually assaulted at gunpoint by two Russian soldiers at her home on the outskirts of Kviv.

"As a native of Kharkiv, she spoke Russian fluently. After pleading with them to let her go, in Russian, she was left alone. Fearing they would come back, she left her home within minutes. She spent a harrowing 72 hours at a petroleum station until a group of volunteers helped her reach the Hrebenne border crossing."

She adds that the woman's thighs were still bruised when she first met her.

A single mother, Olga's sevenyear-old son is living with her parents in western Ukraine's Uzhhorod.

Trauma faced by Ukraine's women refugees

Since Russia's invasion of Ukraine on 24 February, the number of cases of women being sexually assaulted in cities and towns across the country is on the rise. On 27 March, Ukrainian MP with Sky News, cited a case from the capital city of Kyiv, where a Russian soldier had allegedly raped a Ukrainian woman in front of her child.

It is along the Ukrainian-Polish borders, however, that the stories of sexual assault are coming to the fore. It is important to note that rape, during a war, is considered a

Julia, a mother of two, and a native of Kyiv, who had fled the country two weeks ago along with her 71-year-old mother, too, narrated a rape survivor's account to The Quint. On 15 March, she arin the 'priority line', which first let the elderly, people with disabilities, and women with young chil-

dren across the Polish border. "I was standing next to a woman for two hours at the Medyka border, crossing between Poland and Ukraine. She did not speak a word till we reached the reception centre. She told me that Russian soldiers had raped her. She was from Irpin, and has two children. She didn't want to accept help from humanitarian groups in Poland because she was too traumatised,"

says Julia. 'When humanitarian workers tried to help her, she insisted that only female volunteers attended to her, and not the men. The sight of men scared her, not only for herself but also for her five-year-old daughter," claims Julia.

Apart from the trauma that comes with their homes and cities being bombed, staying hidden in bunkers for days and weeks, and leaving behind male members of their families who must fight the war, many Ukrainian women refugees are dealing with the trauma of being sexually assaulted. Polish doctors, volunteers pre-

scribing morning-after pills to rape

laws and the unavailability of morning-after pills along the Ukrainian-Polish border are pushing doctors and volunteers to mobilise and secretly distribute pills to survivors of rape – at the risk of being imprisoned.

In the past few years, Poland has witnessed massive uproars over its near-complete ban on abortions in the country - one of the most restrictive laws in Europe. Doctors who defy the law face a jail term of three years if they perform an abortion with a pregnant woman's

Trauma of Ukraine's women Volunteers, NGOs Poland's sexist laws

"We're taking a colossal risk by making these pills available to survivors of rape. In Poland, these pills are only legal when there's a prescription. It's next to impossible for Ukrainian women refugees to get that prescription. Abortion is illegal in Poland," reveals a Polandbased gynaecologist who works with trusted volunteers to prescribe and distribute the morning-after

"At first, we decided to provide these pills to Ukrainian refugees here in Poland but we've now sent the pills to victims still stuck in Ukraine, surrounded by Russians,"

He confirms that it's getting harder for them to distribute these pills as the border control has tightened. He fears that unless the Polish government makes an exception of making these pills available to survivors of rape, there will be long-lasting consequences for these women.

In an exclusive interview with The Quint, Polish MP Joanna Kluzik-Rostkowska, says, "We have received reports of women being raped across the Ukrainian border by Russian soldiers. The women are scared, even after

Oleksandra, who has been helping in the distribution of the morning-after pill, says, "In Poland. with abortion not being an option for survivors of rape, it's clear that the lives of women don't matter as much as a cell that hasn't even developed into a foetus yet. It's a huge risk that we're all taking but in the absence of a government that cares for cases like these, the survivors are only left with secret groups like ours who can help."

Polish govt's inaction apparent, lack of coordination at borders:

million refugees from Ukraine and the country has been reeling under the pressure of handling this influx. With Ukrainian men staving back to defend their country, most of the refugees are women, children, and the elderly.

"You can imagine what will happen when two million people come to Poland. I see two related problems: the first is abandoned children. We are preparing special programmes for them. The second problem is trafficking," Polish MP Kluzik-Rostkowska tells The

An organisation that is working along the Polish-Ukrainian border is Fundacja Ocalenie, a Warsawbased NGO. Kalina, a humanitarian worker from the NGO, narrates how when her team went to the border, they saw that there was no system in place.

"All the work to assist the refugees was done by volunteers and NGOs, not the government, I fear that with this lack of coordination between agencies and no plan in place, the risk of human trafficking is growing, especially for single mothers. We are dealing with a multitude of issues, such as sexual violence and racial discrimination, among others," she says. Polish MP Kluzik-Rostkowska

confirmed that the government was working with law enforcement agencies to help Ukrainian victims of rape. She says, "This is not just a Polish problem because some of these women are going to other EU countries, and they need all the help the EU can offer.' Mirroring MP Kluzik-Ros-

tkowska's comments, Kalina says she hopes they would find a solution for the survivors. On the other hand, the gynaecologist, Oleksandra, and the volunteers are working round the clock to procure not only the morning-after pills but also to set up a team that can deliver lifesaving medical equipment to the frontlines in the capital, Kyiv.

"If this government poses a problem in distributing the morning-after pills to the victims of rape in Ukraine, we will continue to provide them to women here in Poland, a problem no one is speaking about," says Oleksandra. (Courtesy: The Quint)

am no scholar of the Quran or the Hadees; I am just an ordinary Muslim woman who had the good fortune of having parents who believed in putting their children, whether male or female, in the best educational institutions they could afford and in allowing them to abide by the prescribed curriculum and uniform (if there So much for my parents' role,

but as a student, I also had the good fortune to have governments in power which never interfered with school uniforms and curriculums. So I don't take any credit for having made, at the end of the 1960s, a career which allowed me to earn my own bread and butter, in addition to leaving a substantial amount for my other responsibilities. But there were girls in co-education colleges and universities, even in those days, who wore fulllength Burgas which covered their faces. No one interfered, least of all the university management or the government. Some fellow students may have laughed at them or passed an odd remark, but never in had taste. Some of these girls reached great heights and many were able to realise their dreams after completing their studies in

I shudder to imagine myself in today's age and times, when governments are putting dress restrictions on girls who wish to go ahead with education; to make a better life for themselves than that of chattel.

I am sure that in the present times, I would not have been able to pursue any education worth its name and would have ended up chained to the commands of some male or other; or left at the mercy of a better-placed woman relative. with no rights over my movements, my dreams and desires, god forbid. And god be thanked that I was born decades earlier.

As a little girl in the early 50s, I remember watching on from my balcony as older girls went to school in thickly-curtained wagons. Educational institutions from the British times – or those set up on their patterns - still existed then, for the education of daughters of middle and lower-middleclass parents. Apart from the missionary schools, there were high-walled schools for girls, both Hindu and Muslim, run by the government and municipalities. with good standards of education.

The wagons with thick curtains covering their windows were arranged by these schools so that Muslim parents, who were particular about their daughters being in purdah, had no excuse to keep them away from school. Many girls from strict Hindu families, too, opted for seats in such wagons. These conveyances were



called thelas and had two kahar men pushing them from the rear and two pulling them from the front. The British – and later, the governments of Independent India wanted to make education available to girls of all sections of society, while still in deference to their social and religious norms. By no means did purdah and the

seclusion of women enter India through Islam. It had been here since ancient times, though it was intensified with the arrival of Islam in the northern part of our subcon-

Burqa was a normal sight during my childhood, but I must admit, I saw no one in a hijab, nor did I hear the word in those years. It is a garment recently evolved; perhaps. after young Muslims got greater exposure due to more travel and job opportunities in other coun-

Immigration has also played a

role which, in recent decades, has forced people to enter into unfamiliar regions and live with 'unfriendly' neighbours. Above all, Islamophobia, in India and all over the world, has made young Muslim girls aware of the fact that they can enter the domain of decisionmaking only through modern education. The Burqa was an unwieldy garment to wear while entering into the arena of competition and success. The dream of these young Muslim women was to attain a higher socio-economic status and prestige, but without having to leave purdah behind.

In my opinion – which many may not agree with - young, ambitious Muslim women opted for the hijab because it is a less cumbersome replacement to the burga or aba (a gown covering the whole body). The hijab is easy to wear and covers only the head and hair. Haj, where women do not have to cover their face but only their head and hair with a scarf, may have showed the way to women for limiting their purdah to a head scarf.

The word 'hijab' means honour, prestige, dignity and, above all, modesty. For this reason, the scarf covering the head and hair came to be called 'hijab' in the first place and became a symbol of all these things for young, modern Muslim women. It served as a tool for empowerment and as an identity cum admission card, through which young girls could exercise their right to accessibility of public spaces for education and economic independence.

Many hijab-clad women have since proved that they are not just capable of taking giant strides, but leaps towards excellence, like Bushra Mateen, a civil engineer from Raichur. Bushra ran up the podium of her university, headscarf in place, and came back to her seat, her 16 gold medals jingling all the way as the compere went on, breathlessly, reading her extraordinary achievements. And Bushra is just one example.

Modesty in clothes worn by students in a place imparting education creates an atmosphere which is conducive for learning in a smoother and more natural way than uniforms can. If uniformity 'suddenly' acquired greater importance in the eyes of lawmakers, then orders for the colour of the hijab to be exactly that of the uniform could have been issued. Banning the hijab, which a woman wears for her modesty and for dignity, is nothing less than disrobing her. It raises many questions and doubts, and gives occasion for fingers to be pointed at lawmakers.

What were their intentions (of the lawmakers), god knows better. But in the midst of the raging hijab furore, when law and order was put on a long pause and saffron clad louts were let loose, one single young Burqa clad girl, defied their threats all by herself. Television channels helped the world watch, in utter disbelief, the fearlessness and daring of Muslim womanhood. (Courtesy: The Wire)

## Lanka economic crisis: Rajapaksa's grip on power weakens; Fin Min resigns within 24 hrs of appointment

COLOMBO, April 5 (PTI): Sri Lanka's ruling coalition headed by President Gotabaya Rajapaksa on Tuesday faced more trouble after the newly-appointed Finance Minister Ali Sabry resigned even as dissident lawmakers, led by former president Maithripala Sirisena, were planning to quit the government against the backdrop of nationwide protests over the country's worst economic crisis.

President Rajapaksa had appointed Sabry after sacking his brother Basil Rajapaksa, who was at the centre of anger within the ruling Sri Lanka Podujana Peramuna (SLPP) coalition.

In a letter to the President, Sabri said that he took up the job as part of a temporary measure.

"However, after much reflection and deliberation and taking into consideration the current situation, I am now of the view for Your Excellency to make suitable interim arrangement to navigate the unprecedented crisis fresh and proactive, and unconventional steps needs to be taken including the appointment of a new finance minister," Sabry said in the letter.

He was among the four new ministers appointed by the President on Monday after the resignation of all Cabinet ministers a day ear-

When the Parliament convened on Tuesday, several government allies expressed their decision to stay neutral. It was the first session since a state of emergency was declared by President



The ruling coalition, which had won 150 seats in the 2020 general elections and went on to increase its numbers through defections from the Opposition, appeared to lose the support of at least 41 MPs.

It now appears to have 109 seats, five less than the 113 seats required for simple majority in the 225-member Parliament.

The government, however, claimed that it commands the simple majority.

Sri Lanka is currently experiencing its worst economic crisis in history. With long lines for fuel, cooking gas, essentials in short supply and long hours of power cuts, the public has been suffering for months.

The dissidents, led by former president Sirisena's Sri Lanka Freedom Party (SLFP), would leave the ruling SLPP coalition with its 14 Members of Parliament, party sources said

after their meeting with the President on Mon-

The coalition, which commanded 157 votes out of 225 at the last vote held on the government budget, is bound to lose between 50-60 members, Udaya Gammanpila, a dissident lawmaker told reporters on Monday.

As a result, the government would not only be denied its two-thirds but even the simple majority of 113 members, he said.

However, Rohitha Abeygunawardena, a SLPP lawmaker, said that the government was rock solid with 138 members backing it.

The dissidents said that in addition to 14 members of Sirisena, 16 more from the other 11 members of the coalition would defect to be an independent group. They expect at least 20 from the SLPP to join their ranks. On Monday, there were storming of houses

## THC, CBD exposure in womb linked to childhood obesity: Study

NEW YORK, April 5 (IANS): Pregnant women who were exposed to cannabis products that contained THC and CBD were more likely to have children with increased fat mass and blood sugar levels at age 5, a new pilot study

Study author Brianna Moore, an assistant professor at the Colorado School of Public Health in Aurora, Colorado, said that "there is this misconception that cannabis is safe," reports CNN.

"So some women may use it in pregnancy, thinking that it's a safe alternative to other medicines, even prescribed medications," Moore said.

"Yet studies show connections between marijuana use during pregnancy and low-birth weight in babies and behavioural problems later in childhood, and there may



be links to glucose and weight issues as well," Moore added.

Past studies have shown the use of cannabis during pregnancy is linked to abnormal neurological development, autism and hyperactivity, attention issues, and other cognitive and behavioural issues in children, according to the US Centers for Disease Control and Prevention (CDC).

Expectant mothers in the study, published in The Journal of Clinical Endocrinology and Metabo-

sm, were recruited in Colorado through Healthy Start, a national programme designed to improve health outcomes before, during and after pregnancy.

Of the 103 women who were tested during pregnancy, 15 per cent had detectable levels of various cannabinoids in their urine, including

(tetrahydrocannabinol), a chemical in the marijuana plant that has psychoactive properties, creating a

Levels of CBD (cannabidiol) were also found. The chemical CBD is marketed over the counter and online as being "nonpsychoactive" and a safe option for anxiety, depression, sleep, pain, nausea and more. Many CBD products are made from industrial hemp, a type of cannabis plant that has little THC.

## Kuwait's government resigns as political crisis intensifies

DUBAI, April 5 (AP): Kuwait's government resigned on Tuesday, just months after its formation, opening up new uncertainty as the tiny country grapples with a worsening political crisis that has blocked critical economic and social reforms.

Kuwaiti Prime Minister Sheikh Sabah Al-Khaled Al Hamad Al Sabah submitted the cabinet's resignation to the crown prince, state-run KUNA news agency reported, ahead of a no-confidence vote in Parliament later this week that sought to remove him from office.

It marks Kuwait's third collective government resignation in the past year and a half. A host of new faces, including some picks to appease opposition blocs, had been appointed to ministerial posts as recently as December, with their resignation now reflecting their failure to make reforms. Opposition has been mounting against Sheikh Sabah. Angry lawmakers hauled him in for extensive interrogations last week over his alleged corruption and mismanagement. They publicly declared him "unsuitable" and called for a new prime minister to tackle the country's problems and secure badly needed reforms.

Cabinet's resignation comes after the defense and interior ministers submitted their resignations earlier this year. Exasperated, the two senior ministers decried their inability to make anything happen in oil-rich Kuwait because of Parliament's rowdy opposition. Lawmakers increasingly in recent months have expressed their political frustrations and mistrust by questioning various unpopular ministers and stalling major



Although soaring oil prices amid Russia's war in Ukraine have recently created a windfall for Kuwait, they've also served as a reminder of the nation's utter dependence on oil revenues and need to diversify. Even if the International Monetary Fund now expects Kuwait to run a budget surplus after years in the red and see its gross domestic product increase by 2.7%, it remains politically stuck.

Years of low oil prices, coupled with the coronavirus pandemic, pushed the country's account deficit to 16.6% of its GDP last year. As financial stress worsened, the government couldn't draw from Kuwait's flush sovereign wealth fund or issue debt because lawmakers have blocked a public debt law.

#### Meghalaya: Two killed, houses washed away in rain-triggered landslides



SHILLONG, April 5 (PTI): At least two people have been killed and several houses and vehicles washed away in rain-triggered landslides in Meghalaya, officials said on Tuesday. As many as seven landslides were reported across the state in the last 24 hours, they said. Two people, identified as Rohit Kshiar (14) and Dilibon Tangsang (35), were killed in a landslide in Mawlat village in East Khasi Hills district, an official of the state disaster management authority said. Two houses and two shops were washed away in another landslide in Umblai village. A portion of the Thangbnai-Mawlyngot road was damaged and a vehicle was washed away. Work was underway to clear the road, he said. Five houses were destroyed and one person sustained minor injuries in a landslide in Lyngshing village. A portion of the road was eroded due to a landslide near Wahumkhrah River in Wahingdoh. Traffic was affected due to landslides on Mawphlang Balat Road in Mawsynram Block and NH 40 (Shillong-Dawki Road). Students appearing for board examinations were stranded but police assisted them in reaching their centres on time. Officials rushed to the locations and foodgrain, blankets and other essential items were distributed among those affected. Deputy chief minister Prestone Tynsong asked executive engineers to remain alert.

## AFSPA will be re-imposed if law and order not under control: Nagaland CM

KOHIMA, April 5 (IANS): Nagaland chief minister Neiphiu Rio on Monday said that if law and order situation in the state cannot be controlled, the Armed Forces (Special Power) Act, 1958 (AFSPA) might be re-imposed in the state. In his address at a crucial consultative meeting with tribal Hohos and organisations on AFSPA, he said that all stakeholders had appealed for abolition of the draconian law and the Central government had finally heard the appeals of the people.

He appealed for co-operation with the government to ensure that no untoward incidents occur and urged all the stakeholders to seriously ponder how to properly maintain law and order in the state.

As the Naga solution is for all the Nagas, he stressed that the Nagas should harbour a sense of unity and oneness and not be selfish in their demands.

Rio thanked the civil society organisations, tribal leaders, and student bodies for cooperating and supporting the government. He said that the state government had formed a 22-member Special Investigation Team (SIT) to probe



the Oting incident in Mon district where 14 people were killed and 30 others were injured by the security forces in December last year.

Congratulating the SIT members for their prompt investigation and submission of their preliminary reports, he said that once the final report is submitted and a case is filed, it would be made known to the public. The Centre had also formed a SIT and they have also submitted their report, he added.

United Democratic Alliance chairman TR Zeliang also aplice would be handicapped without the peoples' support.

State chief secretary J. Alam said that after almost three decades, AFSPA was removed completely in three districts and partially lifted in four other districts and hoped that further progress will be seen in the days to come. #### Methamphetamine tablets worth ₹30 crore seized

AIZAWL, April 5 (PTI): In a major drug haul, a CID team seized one lakh tablets of methamphetamine, also known as party drugs, worth ₹ 30 crore in Aizawl, police said on Tuesday. At least five persons, including a Myanmar national, were arrested in connection with the seizures.

#### Meghalaya HC raps chief secy for inaction against officials involved in illegal coal mining



SHILLONG, April 5 (PTI): The Meghalaya High Court rapped the chief secretary on Monday for failing to take action against government officials who "looked the other way" and "actively aided" illegal coal mining in the state. Hearing a suo motu PIL, the three-member full-bench of the high court said the time frame set to dispose of the previously mined coal was not been adhered to, leading to fresh illegal mining of coal, which was attempted to be passed off as coal that was mined earlier. "This could not have happened without the active connivance of the local administration. There has to be accountability and this aspect of the matter has to be immediately focussed so that a message is sent loud and clear that the watchdogs would be proceeded against if anything remiss is found under their watch," the court said. The court said that the report filed by chief secretary RV Suchiang on the issue singularly lacks in indicating actions taken against local officials "who not only looked the other way while the illegal mining thrived, but may have actively aided therein". Maintaining that the PIL is not to inquire afresh into the matter already covered by the Supreme Court, the bench said the present exercise is limited to ensuring that all the directions issued by the apex court and NGT are followed and implemented. The court also suggested that a committee be set up to ensure better compliance with the directions and detect the failures of the administration. In the report filed on April 1, the chief secretary had said that more than 3,500 trucks were seized for violating the NGT order, banning the transportation of coal. On this, the court said there 'appears' to be that some action was taken, though it is not clear from the report as to whether all the directions by the Supreme Court and the NGT have been complied with.

## Nagalim 'invaded' by India, Myanmar, claims NSCN-IM supremo Muivah

KOHIMA, April 5 (IANS): 'Nahad been 'invaded' by India and Myanmar and the Nagas have neither been a part of either by consent or by conquest, NSCN-IM general secretary Thuingaleng Muivah has said, the group announced on Mon-

Addressing the General Assembly of Unrepresented Nations and People's Organisations (UNPO) in Washington DC, he said that the Nagas had been living in their own free country till the British forces occupied a part of it in 1832 while the rest called the free Naga area remained as free as ever.

"On the eve of the departure of the British, the Nagas of the British-occupied Naga territory declared their independence on August 14, 1947 and joined with their brothers in the free Naga area. In 1950, the Indian Constituent Assembly invited the Nagas to join the Union of India, but it was rejected by the Naga people," the Isak-Muivah faction of the National Socialist Council of Nagalim leader said.

He alleged that with a view to legalising its military occupation of 'Nagalim', the Indian government "imposed its will" upon the Nagas



in the form of the so-called 16point agreement in 1960. However, it was rejected outrightly by the Naga people. Muivah reportedly delivered the address at the UNPO, a 44-member organisation, last week, but the speech was released to the media by the NSCN-IM on Monday. The Naga leader said that realising that seeking a military solution to the political problem is a futile exercise, the Indian government invited the NSCN leadership for political talks leading to a cease-fire agreement between the government and the NSCN signed in August, 1997.

"After 22 years long intensive negotiations with the government involving six Prime Ministers, the historic Framework Agreement

the presence of the Prime Minister (Narendra Modi).' Muivah claimed that the government also recognises the legitimate

right of the Nagas to territorial integration of all Naga areas under one political roof. "Since the unique history of the Nagas and the sovereign right of the Nagas are recognised, it is understood that the Naga flag and constitution are ingredients of their sovereignty," he stated. However, the former government interlocutor and then Nagaland Governor, RN Ravi, currently Tamil Nadu Governor, had, on a number of occasions, rejected the separate Naga flag and constitution. On this, Muivah said that in spite of all facts, commitments and agreements, the Indian government has started misinterpreting what has been mutually agreed upon and going back on its word. "In the event of breaking down the current negotiations, we foresee serious human rights violations again in Nagalim." Muivah also told the UNPO "to look into the fragile situation of the Indo-Naga political talks and take a positive role from your end so that the current peace process is brought to a logical conclusion".

## Torrential rain triggers landslides in Arunachal, throws life out of gear

ITANAGAR, April 5 (PTI): Early monsoon rains have triggered landslides in various parts of Arunachal Pradesh, snapping surface communication and disrupting normal life, officials said on Tuesday.

Moderate to heavy rainfall has been recorded at several places in the northeastern state in the last five days, and the weather office has forecast more downpour for the next 48 hours, they said. Arunachal Pradesh received over 15 cm rainfall over the past few days, the Met department said.

The incessant rainfall has triggered a series of landslides at different locations across state capital Itanagar, posing a threat



to vulnerable buildings. Capital deputy commissioner Talo Porom has urged people living in areas at risk to shift to safety. He also expressed concern over illegal earth-cutting activities that are carried out near the national and state high-

# On BJP foundation day eve, PM Modi asks MPs to dedicate themselves to 'seva'

NEW DELHI, April 5 (PTI): Urging BJP MPs to dedicate themselves to 'seva' (service) as the party embarks on a "samajik nyay pakhwada" from April 7, Prime Minister Narendra Modi on Tuesday laid down a detailed programme for them for every day during the 14-day long exercise.

Speaking at the BJP parliamentary meeting a day ahead of the party's foundation day, Modi cited a number of welfare schemes of the government targeting different segments of society and asked MPs to reach out to people with their details. Modi is also scheduled to address BJP members on Wednesday virtually. BJP president J P Nadda underlined the party's rise in the Northeast, where it is either in power on its own or is part of a coalition government, with the first woman MP from Nagaland, Phangnon Konyak, who was elected recently, attending the meeting.

Sources said Nadda noted that the party has achieved the feat of having 100 MPs in Rajya Sabha for the first time.

Parliamentary Affairs minister Pralhad Joshi told reporters that Modi asked the MPs to actively participate in the programmes. "They should dedicate themselves to service," he quoted him as saying. MPs were given orange caps emblazoned with the party's name or symbol, like the one which was sported by the prime minister recently during his road show in Gujarat. Some MPs were also sporting caps carrying a photo of Modi.

They will sport the cap during Modi's address on the foundation day from Parliament Annexe. Party MPs and other members will be highlighting the impact of health insurance programme 'Ayushman Bharat' and 'Jan Aushadhi Kendra', where medicines are sold at a subsidised rate, on April 7. The schemes to build houses for the poor and to reach piped water to every household will be at the centre of the campaign on April 8 and April 9 respectively, Joshi said.

### ED attaches assets of family, firms linked to Delhi minister Satyendar Jain

NEW DELHI, April 5 (PTI): Assets worth Rs 4.81 crore of the family and companies "beneficially owned and controlled" by Delhi minister and AAP leader Satvendar Jain have been provisionally attached in connection with a moneylaundering probe against him, the Enforcement Directorate said on Tuesday. Jain, 57, is the minister for health, power, home, PWD, industries, urban development, flood, irrigation and water in the Arvind Kejriwal-led government. The ED had in 2018 questioned the AAP MLA from Shakur Basti in connection with the case. He had worked in the Central Public Works Department and later quit his job to set up an architectural consultancy firm.

In a statement, the ED said it has issued a provisional order under the Prevention of Money Laundering Act (PMLA) for the attachment of the assets. The "attached immovable properties worth Rs 4.81 crore belong to Akinchan Developers Pvt. Ltd., Indo Metal Impex Pvt Ltd, Paryas Infosolutions Pvt. Ltd., Manglayatan Projects Pvt. Ltd., J.J. Ideal Estate Pvt. Ltd., Swati Jain, wife of Vaibhav Jain, Sushila Jain, wife of Ajit Prasad Jain, and Indu Jain, wife of Sunil Jain."

The probe found that "during the period 2015-16, when Satyendar Kumar Jain was a public servant, the companies beneficially owned and controlled by him received accommodation entries to the tune of Rs 4.81 crore from shell (paper) companies against cash transferred to Kolkata-based entry operators

through the hawala route. "These amounts were utilised for direct purchase of land or for repayment of loan taken for the purchase of agricultural land in and around Delhi," the ED said. According to the officials, the named persons in the attachment order are associates and family

members of Jain. The money laundering case against the AAP minister stems from an August 2017 FIR filed by the CBI against him and others on charges of alleged possession of disproportionate assets.

The CBI has claimed that Jain purchased 200 bighas of agricultural land in the names of companies controlled by him in Delhi in five years preceding 2018 and "laundered black money" to the tune of several crores of rupees. It had alleged that Jain controlled these companies in the past either in the form of being one of the directors or by holding one-third of shares of these companies in his name or in the names of his family members or others. The laundered funds were allegedly used to purchase over 200 bighas of land in Auchandi, Bawana, Karala and Mohammed Mazvi villages in Delhi between 2010-16, the CBI had said.

The Income Tax department too had probed these transactions and issued an order attaching 'benami assets' allegedly linked to Jain.

Kejriwal in February had said that he has learnt from sources the ED was going to arrest Satyendar Jain just before the Punjab assembly elections and accused the Centre of targeting the Aam Aadmi Party after realising the BJP "would lose" the polls.

The AAP won the Punjab assembly polls in March and has formed its government in the border state with Bhagwant Mann as the chief

#### Parliament nod to bill for unification of 3 Delhi municipal corporations



NEW DELHI, April 5 (PTI): Parliament on Tuesday passed the Delhi Municipal Corporation (Amendment) Bill-2022 to unify three civic bodies in the national capital, with the Rajya Sabha giving its nod through a voice vote after negating all amendments sought by the opposition.

According to the bill, passed by Lok Sabha last week, the unification of the municipal corporations will ensure synergised and strategic planning and optimal utilisation of resources.

Replying to the discussion on the bill, Home minister Amit Shah said it has been necessitated after the AAP-led Delhi government meted out step-motherly treatment to the civic bodies. Shah said that it was a mistake to trifurcate the Mu-

nicipal Corporation of Delhi (MCD) into three bodies in 2012 but added that they could still have functioned normally, had the AAP-led Delhi government not treated them in such a manner. "This bill is in no way an attack on the federal struc-

ture," Shah said, allaying concerns raised by some opposition members. Delhi is only a Union Territory and not a full state, he said, adding that Parliament has competence to frame laws for Delhi and that is why it has brought this bill.

Dismissing the Opposition charge that the ruling dispensation at the Centre brought in the bill out of fear of losing the civic elections. Shah said the BJP has no such phobia and is ready to contest the polls soon after delimitation.

"It is being alleged that the bill has been brought due to fear of losing elections. But if elections are held after six months, will you lose," he asked Opposition

He said the BJP has no fear of losing or arrogance of victory and is fully geared up to contest the polls.

## 4-5 per cent of ₹ 1.25 lakh cr spent on CSR funds in past 7 yrs went to PM Cares: Govt

spent on CSR in the last seven years, only 4 to 5 per cent funds have gone to the PM Cares Fund and that too during the last two years amid Covid-19, minister of state for Corporate Affairs Rao Inderjit Singh told the Rajya Sabha on Tuesday. Replying to supplementaries during Question Hour, the minister also informed the members that there was an attempt initially to include Chief Minister's Relief fund for spending CSR funds but it was disallowed by the government

"Out of the Rs 1.25 lakh crore that have been spent on CSR over the last seven years. not more than 4 to 5 per cent has gone to the PM Cares fund. Most of that money has gone during Covid in two years," Singh said. He said prior to that, companies by themselves have been able to spend on all those activities that have been enumerated under the CSR pattern under Section 135

of Companies Act. "There were attempts to make CSR funds go to the Chief Minister's Fund, but it was not accepted by the government of India. Because then, in whichever state the chief minister is then the funds from these companies will only go to the direction given by the chief minister. We don't want to have that," Singh said.

"The basic idea of spending



CSR is to do the best you can 
India is for companies to not for the public good. And it cannot necessarily be that only one person can think about and not the chief minister alone,' he said responding to a query by Prasanna Acharya (BJD) on whether the chief minister's fund would be included in

CSR spending. Singh said it is a broadbased activity that the Board undertakes and we give general guidelines and the Board implements it.

It is an activity pan-India, no matter where the company comes from, he said.

The minister also said that Section 135 of the Companies Act provides the framework for the CSR spending and the first proviso to this is that where the company is established, it should first endeavour to spend CSR funds.

"But, this is not mandatory, it is directory," he said.

The attached properties are in form of lands held by Pravin M Raut, former director of Guru Ashish Construction Pvt Ltd. in Palghar and Thane districts, a flat in Mumbai's suburban Dadar area of Sanjay Raut's wife Varsha Raut and eight plots at Kihim beach in Alibaug jointly held by Varsha Raut and Swapna Patkar, the agency said in a statement.


Swapna Patkar is the wife of Sujit Patkar who, according to the ED, is a close associate of Sanjay Raut, Shiv Sena's Rajya Sabha MP and party spokesperson.

In the Alibaug land deal, apart from the registered value, "cash" payments were made to the sellers, the agency found. It said the total value of the attached assets is Rs 11,15,56,573.

The ED action linked to alleged irregularities in the re-development of a Mumbai 'chawl' and other similar instances, comes in the backdrop of several leaders of the Sharad Pawar-led Nationalist Congress Party (NCP) also facing the heat from the central agency. The Shiv Sena, NCP and Congress are part of the Maha Vikas Aghadi (MVA) government in Maharashtra.

## Govt orders blocking of 18 Indian, four Pakistani YouTube-based news channels

NEW DELHI, April 5 (PTI): The Ministry of Information and Broadcasting has directed the blocking of 22 YouTube-based news channels, of which four are from Pakistan, alleging that they were spreading fake news that could impact national security, foreign relations and public

This is the first time that action has been taken against the Indian YouTube-based news publishers since the notification of the IT Rules, 2021 in February last year, it said. Union minister Anurag Thakur asserted that the government will not shy away from taking such action in the future as well. In an official statement, the ministry said it issued an order on Monday to block 22 YouTube channels, three Twitter accounts, one Facebook account and one news website.

With this action, the ministry has, since December 2021, issued directions for blocking 78 YouTubebased news channels and several other social media accounts on grounds related to national security, sovereignty and integrity of India, public order, etc.

"Out of the 22 YouTube channels which were blocked, 18 are from India and four from Pakistan.

"The total views were 262 crores. They were involved in the misinformation against India which could impact the sovereignty and integrity of the country and also the national security and India's relations with other nations," the Information and Broadcasting minister said.

"They were spreading misinfor-



mation on the Ukraine-Russia conflict, on the Covid-19 news and other such issues which were directly impacting India. As I promised earlier as well, whether the channels are operating from foreign soil or from India, we'll take action. We won't shy away from taking such a decision in the future as well in the interest of India " Thakur said.

The blocked YouTube channels had a cumulative viewership of over 260 crore, the ministry earlier said, adding that they were spreading fake news and coordinated disinformation over social media, on subjects sensitive from the perspective of national security, India's foreign relations, and public order. According to the ministry, multiple YouTube channels were used to post "fake news on various subjects such as the Indian Armed Forces. Jammu and Kashmir, etc.

"The content ordered to be

blocked also included certain anti-India content posted from multiple social media accounts operated in a coordinated manner from Pakistan. "It was observed that a significant amount of false content was published by the Indian YouTube channels related to the ongoing situation in Ukraine, and aimed at jeopardising India's foreign relations with other countries," it said.

After his address, he asked for a video to be played in the Security Council that showed horrific images of corpses lying on the streets, charred bodies and pictures of mass graves across various Ukrainian cities. Some of the dead had their hands tied behind their backs and mouths gagged, including children. In his nearly 20-minute video address to the Council meeting on Ukraine, being attended by UN Secretary General Antonio Guterres, Zelenskyy questioned that where is the security that the Security Council needs to guarantee. "It's not there, although there is a Security Council" but where is the peace, he said. He demanded maximum access for journalists and involvement of the International Criminal Court for complete truth and full accountability to ensure that the war crimes do not go unpunished. "Those who consider themselves privileged and believe that they can get away with anything," he said, adding that all the other potential war criminals in the world should be shown how they will be punished. "If the biggest one is punished, then everyone is punished."

Demanding reform of the Council, he said it is obvious that the key institution of the world that must ensure international peace and security "simply cannot work effectively." He said if the war and brutality continues, then nations will rely only on the power of their own arms to ensure their security and not on international law and institutions. "The United Nations can be simply closed. Are you ready to close the UN? Do you think that the time of international law is gone? If your answer is no, then you need to act immediately. The UN Charter must be restored immediately," he said. He said the massacre being witnessed in Bucha is "unfortunately only one of many examples of what the occupiers have been doing on our land for the past 41 days.'

The Ukrainian leader said he knows that Russia will "blame everyone just to justify their own actions" and even say that the videos showing corpses strewn across the streets in Bucha are "staged" but this is 2022 and there is "conclusive evidence, satellite images, and we can conduct full and transparent investigation." He asserted that it is time to transform the system, the United Nations and proposed to convene a global conference in Kiev "to determine how we are going to reform the world security system." "It is now clear that the goals set in San Francisco in 1945 for the creation of a global security international organization have not been achieved, and it is impossible to achieve them without reform," he said. Zelenskyy asserted that "we need decisions from the Security Council for peace in Ukraine.

#### Parliament passes accountancy bill

has witnessed rapid changes in the way the economy is being profiled, the finance minister said, "at this time, the sanctity of the audited financial statement which is where the role of CAs come into play has got to be maintained, has got to be given its due position and we need to have audit and certification quality. We also need to have a favourable investment climate being brought in." Citing the examples of Satyam and the IL&FS scandals, she said, "we have repeatedly been questioned about the number of failings of the CAs who did not deliver as per the expectations." Reiterating the need to bring the bill, Sitharaman said the corporate governance system needs to be robust in order to meet the global investment expectations. Besides, she said there is a need to bring greater robustness and accountability in India's standards of audit and how audit certificates are being given. Dispelling apprehensions expressed by certain members regarding the autonomy of the three institutes, she said their functioning continue to be governed by their respective three Acts.

"This one Act which is going to have an impact on each of these Acts only to a limited extent of bringing in greater transparency in the disciplinary processes with which these institutes function," Sitharaman asserted.

The three institutes - Institute of Chartered Accountants of India (ICAI), Institute of Cost Accountants of India (formerly known as ICWAI), and Institute of Company Secretaries of India (ICSI) -- will continue to have the authority for qualifying and licensing of people and regulation of their conduct as was done before, she said. The finance minister said that in the last few years, there has been an increase in the number of entities wanting to register as LLPs after steps taken by Prime Minister Narendra Modi to promote startups and smaller entrepreneurs across the country. With this, she said these firms are "bringing a new kind of environment and we also see that the requirement for regulating them also needs to be robust". The bill amends the Chartered Accountants Act, 1949, the Cost and Works Accountants Act, 1959, and the Company Secretaries Act, 1980. Among other things, the bill provides for the setting up of a coordination committee headed by the Secretary of the Ministry of Corporate Affairs. It will have representations from the three institutes. The bill also provides for registration of firms with the institutes and it will help in paving the way for Indian accountancy firms to grow big, she said. It also proposes to enhance the quantum of fines for partners and firms found guilty of misconduct. The legislation also seeks to appoint non-Chartered Accountant (CA), non-cost accountant and noncompany secretary as the presiding officer of the disciplinary committees of the respective institutes. The Congress, TMC, DMK, CPI (M) and YSRCP opposed the bill, citing "infirmities" and alleging that it was a blatant attack on professional autonomy. Neeraj Dangi of Congress accused the government of trying to control everyone, be it businessmen, doctors, industrialists, teachers, government employees or students and the bill is one such example of doing it to control chartered accountants.



## World No. 2 Medvedev could be banned from playing in Wimbledon this year: Report

LONDON, April 5 (IANS): Wimbledon could ban Russian tennis player and current world No. 2 Daniil Medvedev from competing in the tournament this year over fears that a win could "boost (President) Vladimir Putin's regime amid the invasion of Ukraine," according to a report in mirror.co.uk.

While Russian players are allowed to compete without flags or anthems in the wake of Russia's aggression in Ukraine, the report said that the All England Club could likely impose stricter measures on Russian tennis players, including Medvedev.

The report added that the All England Club had been advised that its independent tournament status means it

"could implement a ban on Russian players that fail to condemn the actions of Putin -- and not face legal repercus-

As with other tournaments on the tour, including the three other majors, which have remained neutral "due to fears they could be taken to court", Wimbledon can take stricter measures as the tournament "possesses a different status", the report added.

A spokesperson for the All England Lawn Tennis and Croquet Club (AELTC) appears to have confirmed the Championships may ask Russian athletes to go a step further and maybe sign a form condemning Putin's action in order to compete at Wimbledon, according to the report.



"Private member clubs have more discrimination laws as the tours," the freedom as to who to allow in or not, so spokesman was quoted as saying in the they wouldn't be subject to the same report on Monday evening.

"If you are running the main tennis tour, you have the freedom to ban players -- if they have been found guilty of match-fixing or doping, for instance -but you have to be able to show that this course of action is reasonable.

"In this instance, if the tours took strong action, Russians players could argue that they are being prevented from making a living through no fault of their own. That is not so much of an issue for Wimbledon, however," the spokesman said.

The AELTC will likely release their policy next month before the deadline for the entries ends, said the report. "It would allow impacted players to know what is expected of them if they hope to play at the grass-court grand slam,"

UK sports minister Nigel Huddleston recently declared that Putin must not be allowed to take political advantage of any Russian athletes and their achievements in Britain, according to the re-

He has suggested that "Medvedev and Belarusian world No. 5 Aryna Sabalenka should only be allowed to participate in major sporting events in the UK as long as they sign a form denouncing Putin and his actions".

"We wish to get assurance in a written declaration that they are not receiving money from Putin, Russia or Belarus (and) that they will not be making supportive comments of Putin, Russia or Belarus," Huddleston said.


## Alcaraz leapfrogs to second in ATP Race To Turin after Miami title triumph

The ATP Race To Turin determines which eight players and doubles teams make it to the elite Nitto ATP Finals in Turin, which is tennis' grand finale. The Nitto ATP Finals this year will be held from November 13-

The 32-year-old Healy has climbed to the top of the rankings for batters after her phenomenal 170 in the final, which Australia won by 71 runs to claim their seventh World Cup title. Healy's superb knock sent her soaring into the No.1 spot, ending South African opener Laura Wolvaardt's brief stay at the summit.

Healy smashed 509 runs -- including two hundreds and two half-centuries -- across her nine matches at the World Cup, and at an amazing strike rate of 103.66. The haul meant Healy finished
