NEW DELHI, March 25 (PTI): Union home minister Amit Shah on Saturday said Prime Minister Narendra Modi-led government has once again decided to decrease the jurisdiction of "disturbed areas" declared under the Armed Forces (Special Powers) Act, 1958 (AFSPA) in Nagaland, Assam and Manipur.

In a series of tweets, Shah said this decision has been taken on account of significant improvement in the security situation in the northeastern region.

"A historic day for the Northeast! PM @narendramodi led GoI has once again decided to decrease the disturbed areas in Nagaland, Assam and Manipur under the AFSPA. This decision has been taken on account of significant improvement in the security situation in North-East India," he said.

Shah said for the first time in India's history, Modi prioritised security, peace and development in the northeast and as a result of it, the region is now rapidly heading on the path of peace and devel-

Rahul could have apologised: Himanta

Rahul Gandhi could have apologised or withdrawn the comments for which he was sentenced by a Surat court, Assam chief minister Himanta Biswa Sarma said on Saturday. A slip of tongue sometimes happens and "we have experienced it too, but we issue a statement apologising, saying it was unintentional. Gandhi could have done the same and the matter would have ended there", Sarma said on the sidelines of a programme here.

Gandhi, however, did not apologise nor withdraw the comments over the last five years which goes to "show that it was intentional and made to abuse the OBC community," Sarma claimed, referring to the Surat court's verdict convicting Gandhi in a defamation case and subsequent disqualification as a Lok Sabha MP.

Other chief ministers in the eastern region, many ruled by opposition parties, have however come out against the disqualification.

West Bengal chief minister Mamata Banerjee on Friday without naming Congress leader Rahul Gandhi, said the country is witness-

"In PM Modi's New India, Opposition leaders have become the prime target of BJP! While BJP leaders with criminal antecedents are inducted into the cabinet, opposition leaders are disqualified for their speeches," the fiery TMC Supremo said in a tweet.

Similarly, Jharkhand chief minister Hemant Soren too on Friday attacked the BJP-led government at the Centre, termin the disqualification 'Aapat Kaal' (emergency) for the nation. "In today's 'Amrit Kaal' Opposition leaders are being coerced and silenced by using every tool of power by BJP and the Centre," Soren said in a tweet. FM reviews PSBs performance amid stress in US fin systems

NEW DELHI, March 25 (PTI): Finance minister Nirmala Sitharaman on Saturday reviewed the performance of public sector banks (PSBs) on various financial health parameters and their resilience in the wake of the current global financial scenario emanating from the failure of some international banks in the US and Europe.

She urged the banks to remain vigilant about the interest rate risks and regularly undertake stress tests. During the two hours meeting with MDs and CEOs of PSBs, an open discussion was held on the global scenario amid the failure of the Silicon Valley Bank (SVB) and Signature Bank (SB), along with the issues leading to the crisis in Credit Suisse.

The meeting was also attended by Minister of State for Finance Bhagwat Karad, Financial Services Secretary Vivek Joshi and other senior officials, an official statement said.

She also discussed the developing and immediate external global financial stress from both short and long-term perspectives.

planters body Indian Tea Association (ITA) said climate change is threatening the industry globally which is resulting in lower yields and rise in production costs.

A spokesman of ITA said climate change is also threatening the long-term viability of tea industry, which is also causing increasing pest infestations making pesticide residue management surfacing as a major

To mitigate this, ITA said that the industry needs to adopt a multi-faceted approach to address the climate change issue by way of sustainable farming practices and reduction in carbon footprint.

In this context, the association maintained



the industry involving all the stakeholders to invest in research to come out with miti-

gating solutions. There has also been a decline in rainfall and increase in temperature in the tea cultivating regions for the last several years, ITA said.

According to the association, future projections indicate a substantial reduction in suitability in tea cultivation in areas where the crop is grown.

The other major area where work is needed to be done by the industry is that optimisation in the use of chemical fertilisers and greater use of renewable energy.

In the latest data compiled by Tea Board, production in January 2023 in the country was 13.43 million kilogramme as against 16.22 million kilogramme in the same month of last calendar year.

G20 2nd FWG emphasises on need to manage global inflation and remain vigilant to emerging risks

CHENNAI, March 25 (PTI): The second G20 Framework Working Group which met here over the last two days emphasised on the need to step up efforts to manage global inflation and remain vigilant towards emerging financial risks.

The Framework Working Group meeting which began on Friday was chaired by Chief Economic Advisor V Anantha Nageswaran along with the co-chair United Kingdom Chief Economic Advisor to the Treasury, Clare Lom-

Around 87 delegates from G20 member countries, invitees, representatives from international organisations attended the meeting.

During the two day meet, members discussed and agreed on the way forward for important deliverables for the year including those on macro-economic consequences of food and energy insecurity and climate change, an official release said.



"The discussion on the global economic outlook and risks emphasised on the need to continue efforts to manage global inflation and remain vigilant to emerging financial risks." it said.

The visiting members deliberated on how food and energy prices remain elevated in many economies affecting vulnerable

countries. Ensuring availability and accessibility of critical minerals to facilitate smoother transition as well as generating domestic savings to meet investment needs to boost economic growth was also discussed during the event

A panel discussion on the 'macro-economic impact of climate change and transition pathways' was organised in collaboration with the United Arab Emirates. The session aimed to develop a collective understanding of the challenges facing countries during the climate transition and initiate a discussion on the macroeconomics around climate policy action and transition pathways, the release said.

A financial literacy programme for farmer-producer organisations, farmers and self-help groups was also organised by the Reserve Bank of India, the release said.

is notified as a disturbed area under the AFSPA to facilitate the operations of the armed forces. In Assam, the disturbed area notification has been in force since 1990. Officials said as a result of the remarkable improvement in the security situation during the Modi government's rule, the disturbed area tag, imposed under the AFSPA, was removed from the entire state of Assam, except nine districts and one sub-division of one dis-

Now, it has been limited to only eight districts in Assam. In Manipur, except the Imphal municipality area, the entire state was declared a "disturbed area" in 2004 and it has been in force since then. On April 1, 2022, 15 police station areas of six districts were freed from the ambit of the AFSPA. Now, with the removal of the AFSPA from areas falling under four other police station areas with effect from April 1, 2023, the disturbed

area tag was removed from a total of 19 police station areas in seven districts of the state, the officials said. The AFSPA has been in force in Nagaland since 1995. It was removed from 15 police station areas of seven districts from April 1, 2022. Following a recommendation of a government-appointed committee, the AFSPA was removed from three other police station areas with effect from April 1, 2023, the officials said. With this, the disturbed area tag has been removed from a total of 18 police station areas in eight districts of Nagaland.

Surprisingly, a man Political Rabha (25 years old) survived a wild elephant attack at Mousuwa village (along the Assam- Meghalaya border) under Hahim beat office of Singra Forest Range Office in West Kamrup Divisional Forest Office.

According to Rabha's neighbour, Ajay Rabha on Saturday morning a herd of wild elephants including babies crossed their village Mousuwa and later in the afternoon one male, one female and a baby elephant also tried to cross their village. Meanwhile, they entered a banana garden and started feeding and destroying.

"So, along with other villagers, Political Rabha went to chase the elephants. But, the female elephant chased him back and Rabha was almost trampled by the elephant. But surprisingly, Political Rabha survived the attack", added Ajay Rabha. He also added, "We are now used to elephant raids. Most of the time they have entered this area and damaged gardens, houses and other things, many people also died already." Asking about Political Rabha's physical condition, Ajay Rabha said, "He was injured partially, but without any medical check-ups we cannot say about his health condition. He is a very poor guy, so he didn't even visit the hospital despite our request. Now he is taking rest in his house only.'

Death to Imperialism!" Read Shaheed Bhagat Singh, wearing a red scarf, from a telegram message that was to be sent to the Third International on the occasion of Lenin's death anniversary in 1930. systemic contradiction of capitalism

There is nothing mysterious about the reasons for the collapse of the Silicon Valley Bank and the Signature Bank in the United States. There is also nothing mysterious about why the entire banking system of the capitalist world has come under a cloud: once some part of the system the other parts of it get saddled wi which are nothing else but the liabilities of the collapsed part of the system, and hence become subject to a "domino effect". The real issue is: how did US capitalism get into a situation where its banking system came under such severe strain? Since the collapse of these banks, especially of the SVB, is not an internal phenomenon but is reflective of a systemic contradiction, what exactly is this contradiction?

The obvious proximate factor behind the collapse of both banks is the rise in interest rates. We shall however confine ourselves here to the case of the SVB alone, since it highlights the systemic contradiction more clearly: the case of the Signature Bank is rather a typical since it was dealing with crypto-currencies that are notoriously unstable.

Any rise in interest rates ipso facto lowers bond prices: the price of a bond is simply the stream of its earnings over its life-time, discounted at the going interest rate; and if the going interest rate rises then the same nominal stream of earnings gives a lower price for the bond. Now, all banks hold a range of assets among which bonds are quite prominent. A rise in interest rates therefore, by lowering bond prices, reduces the value of a bank's assets relative to its liabilities, which puts the bank under strain.

Any effort made by the bank to overcome this strain amounts to an open admission before the world that it is under strain, and acts as a signal for the public to desert that bank; the value of its equity falls and this in turn makes depositors panicky who then withdraw their funds from it. This is what causes a run on the bank and brings about its collapse. The thing to note is that when a bank comes under such strain, it faces bleak prospects, no matter what it does: if it does not attempt any corrective measures then it is in effect opting to face a collapse; and if it does attempt some corrective measures then too there are strong chances that it may face a collapse. Its collapse under such circumstances therefore cannot be laid at the door of the bank itself: it has to be explained by macroeconomic factors external to it.

The foregoing argument may suggest that any rise in interest rates would trigger a bank collapse, but this obviously is not true. Interest rate movements decreed by the Central Bank normally occur as small changes at the margin; and in case of a small rise in the interest rate the strain on the banks is manageable. Banks can manage this strain without creating much panic in the "market". But when the interest rate decreed by the Central Bank is suddenly increased by a substantial margin, then banks are denied the opportunity to manage any asset-liability mismatch in a quiet and orderly manner.

And the US interest rate has been jacked up quite substantially of late. The Federal Funds Rate increased from 0.25 per cent in February 2022 to 4.75 per cent in February 2023. Such a massive increase in such a short time makes it impossible for banks to manage their balance sheets smoothly. The real question therefore is: why has the Federal Reserve Board (the equivalent of the US central bank) been jacking up interest rates in this manner?

The basic answer is that under neoliberalism, the only weapon available for State intervention in the economy is monetary policy. Fiscal policy which for a long period after the Second World War was the primary instrument of intervention, recedes to the background under neoliberalism. Governments are forced by globally mobile finance capital to put a ceiling on their fiscal deficits relative to the GDP; and since any taxation of capitalists and the rich in general is taboo for the same reason, namely that it incurs the displeasure of glob-

ally mobile finance capital, the effort to stimulate activity in the economy takes the form exclusively of lowering interest rates. True, the US has no "fiscal responsibility" legislation and is not constrained, either legally or because of any practical fear of a financial flight (for such a flight can scarcely occur from a safe base like the US), to keep its fiscal deficit in check; but, for the US to increase its fiscal deficit to stimactivity amounts to creating jobs abroad (sin part of domestic US expenditure "leaks" out as demand for goods and services produced abroad), while increasing its foreign debt. The US did of course enlarge its fiscal deficit massively during the pandemic, a fact to which some attribute the current US inflation; but that was only under the shadow of a pandemic. For a very long period after the collapse of the housing bubble, the primary instrument used for stimulating the economy was the pushing down of the interest rate to exceedingly low levels, in fact to levels close to zero.

The housing bubble collapsed in 2008. From late 2009, right until 2022, it remained stuck more or less at 0.25 per cent other than a brief interlude between 2016 and 2020 when the Federal Funds Rate was increased by stages to a maximum of about 2 per cent. This extraordinarily long period of extraordinarily cheap money, by reducing the risks for the US oligopolists of raising profit-margin and prices, certainly contributed to the current inflation; but it still did not push the US economy anywhere close to a high enough level of em-

True, the official US unemployment rate fell to a low of 4 per cent, but there was simultaneously a reduction in the labour force participation rate: the unemployment rate calculated by assuming that the labour force participation rate continued at the same level as in mid-2008, remained high throughout the period after 2008. And when inflation struck, the interest rate was jacked up hugely all of a sudden. The reason for this apparently irrational fluctuation in monetary policy, this yo-yo movement in the interest rate, lies therefore in the fact that under the hegemony of globally mobile finance, there is scarcely any alternative. In short, this apparent irrationality arises not because of any whimsicality on the part of the government; it arises because of the hegemony of global finance.

The adverse impact of such wild fluctuations is aggravated by a second factor. When the interest rate falls and bond prices increase, whether or not this has any stimulating impact on the economy, it does not at least pose any threat to the banking system. An increase in the value of a bank's assets does not undermine it in anyway. But when the interest rate rises and bond prices fall, the value of a bank's assets falls relative to the value of its liabilities: this triggers reactions in the "market" that may push the bank into unviability. This asymmetry between the effect on a bank of a fall in the interest rate and that of a rise, acts further to undermine the bank-

It is not just the American banking system but the banking system of the entire capitalist world that is threatened by the sharp increase in the interest rate that is occurring everywhere as the official policy response to inflation. Even such a wellknown bank as Credit Suisse has also of late faced a collapse in its equity prices and is being taken over by its rival UBS.

What is more, the threat to the banking system of the capitalist world has by no means reached a plateau. The Federal Reserve Board was planning earlier to raise interest rates even further for countering inflation; it may go a bit slower now because of the collapse of the two US banks. But it has no option other than raising interest rates as inflation continues to persist, since the only way that inflation is fought under capitalism is by generating unemployment; and this is typically effected these days by a rise in interest rates. As capitalism flounders in crisis, demonstrations by workers all over Europe are further underscoring the dead-end that it has reached in its neoliberal phase. (IPA Service)

Collapse of US banks is reflective of *Financial institutions like Silicon Valley* Bank fund the US weapons industry

The collapse of Silicon Valley Bank last week sparked a number of debates. Was SVB "too big to fail?" Was the Biden administration response a "bailout?" Are the libertarian-leaning tech CEOs hypcrites? Is this a sign that the Fed's rate hikes should come to an end?

But one element of the SVB collapse has been lost in all the discussion of naive tech bros and their questionable banking habits: the importance of the bank, of the tech industry, and of finance to the project of US global power.

As Fortune put it, SVB was the "central artery for financing the startup ecosystem." Nearly all of the bank's depositors were young tech firms backed by speculative venture capital — and the bank's collapse threatened the very survival of both the tech and VC industries. While many have been rightly focused the potential fallout of the collapse for the US banking system, the geopolitical dynamics of these events have mostly flown under the radar.

The Financial Times reports that "amid fears the government was prepared to let SVB and its uninsured depositors go to the wall, venture capitalists launched a concerted lobbying effort" via their industry group, the National Venture Capital Association (NVCA). The lobbyists argued that the failure of SVB "would not only have big economic repercussions, with companies struggling to write paycheques, but also that an outright failure would have geopolitical ramifications.'

As one participant in the lobbying meetings told the Financial Times: "The theme was: 'this is not a bank.'... This is the innovation economy. This is the US versus China. You can't kill these innovative companies." Leaning into the US-China rivalry is not just deft lobbying from NVCA. And posing this as a threat to the "innovation economy" is not simply a reflection of an ideology that sets venture capital-backed start-ups on the new frontiers of capitalism. Indeed, while every facet of the US economy in the twentyfirst century — from manufacturing to consumption — is dependent on access to credit, the peculiarities of SVB bring the relationship between this type of finance and the US military-industrial complex into stark relief. On the list of major firms that was set to lose about \$5 billion in SVB deposits (alongside start-ups in the media. software, and pharmaceutical industries) was at least one semiconductor producer and two aerospace and defence firms. One of them, Rocket Lab, has recently been in the news for "weaponizing space," while the other, Astra, works closely with Defense Advanced Research Projects Agency (DARPA) on a number of projects.

These firms' military ties are not unique. Silicon Valley has a long history of collaboration with the US military. Indeed, the first initial public offering in Silicon Valley

was for Varian in 1956, which sold microwave tubes for military uses. In the 1960s, Fairchild Semiconductor, considered one of the pioneers of today's Silicon Valley, started its business through military contracts. These links have evolved to include technologies from microchips to ley historian Leslie Berlin notes: "All of modern high tech has the U. S. Department of Defense to thank at its core.'

But more than that, the venture capital supporting these start-ups has become increasingly enmeshed with military procurement in recent years, as the Pentagon has turned to private financing to direct military research and development.

This is simply the latest form of a decades-old relationship. Starting in the 1990s, private equity became an important player in the merger boom of armaments firms. This merger boom was key in the transition of the defence industry from a medley of hundreds of small- and medium-sized industrial firms into the handful of massive, publicly traded companies that we know today.

This boom was facilitated by the US government, in an effort to increase efficiency and cut costs during the post-Cold War defence drawdown. But if it was the government pushing the mergers, it was the financial institutions that facilitated them — and reaped the rewards.

Searching for profitable investments in the wake of the savings and loan crisis of the early 1990s, many financial institutions turned to the defence industry as a possible boon. Few in the industry expected the post-Cold War drawdown to last, and investors bet that an industry backed by US federal military spending would be a safe investment.

Big banks, such as JP Morgan, provided funding for a number of major mergers, such as Lockheed Martin's \$9.1-billion acquisition of Loral Corporation in 1996. In addition to big banks, the defence industry piqued the interest of a number of private equity groups, and institutions like the Carlyle Group and the Vanguard Group became specialists in investing in military firms. Underwriting the merger boom, these bankers and venture capitalists reaped the benefits of the extraordinary growth in military firm profits in the coming decades, as the United States' wars in the twenty-first century meant a boom in the aerospace and defence sectors.

Today private equity has taken on an even wider role in the armaments industry than in the 1990s, responsible for thousands of investments in aerospace and defence firms. The Pentagon has even established an office dedicated to facilitating the linkages between start-ups with military potential and venture capitalists. Industry leaders thus unsurprisingly see private equity and venture capital as the future of military innovation.

So when the lobbyists argued that the

SVB collapse wasn't just threatening the individual depositors, but also that it was a possible "extinction-level event" for Silicon Valley — and that the VC business model itself was in danger — they were correct to point out that a collapse of these industries would disrupt the military-industrial ecosystem at a time of escal conflict with Russia and mounting rivalry with China. While SVB's heavy concentration of VC-backed tech firms makes it a particularly clear example of these industries' ties with the US military-industrial complex, it is not unique. Indeed, the US financial system writ large is intertwined with US war-making in the twenty-first century — creating a dangerous situation for the world. Decades of endless war have dramati-

cally increased the opportunities for militarized profit-making — making military industries an ideal investment for financial capital — and a growing number of financial firms are expanding their military sector investments. This draws the interests of financial capitalists together with those of military-industrial firms and hawkish officials. As Shana Marshall notes, the interlocking interests of financiers and military leaders in the pursuit of war "ensures a steady delivery of investment in militarized technologies and high returns for finance capital from continued US commitment to a highly militaristic foreign policy." In other words, this financial permeation of the military-industrial complex has yielded a vicious circle: Expanding war yields greater profits for armaments firms, which enhance their capacity to attract financial investors. Firms and their financial backers use these profits to lobby for war, to finance pro-war think tanks and research, and to influence media coverage of world problems.

This has created a dangerous state of affairs, where militarism and militarization are the go-to solution to every challenge. The entire project of restoring US global primacy rests on its military power — its ability to effectively challenge rivals through force. Over the past few decades, finance has become increasingly incorporated into that project. So while SVB may not have been "too big to fail," it was certainly "too important to fail" — not only to the banking system, but to the project of US world power. The VC lobbyists undoubtedly found a sympathetic ear from administration officials concerned with the "national security" ramifications of the collapse. But from the geopolitical perspective, the SVB rescue does little to promote stability. It ultimately preserves the status quo of deeply intertwined military and financial systems, reinforces the rhetoric of US-China rivalry, and has angered Western allies who saw the decision to cover all deposits as an unnecessary and hypocritical breaking of international banking rules — rules that the US pushed for in the first place. SALIVA: The Next Frontier in Cancer Detection

n the late 1950s, dentist and US Navy Captain Kirk C. Hoerman, then a young man in his 30s, Lattempted to answer a bold question: Might the saliva of prostate cancer patients have different characteristics from that of healthy people? Could it contain traces of a disease that's so far away

Without wasting more of their own saliva on elaborate discussion, Hoerman and his colleagues from the department of dental research at the Naval Training Center in Great Lakes, Illinois, got down to work. They analysed samples from more than 200 patients and healthy controls, and found that the saliva of patients with untreated prostate cancer showed a significant increase in the levels of enzymes called acid phosphatases.

Writing in 1959 in the journal Cancer, the researchers then made a prescient reflection: that it may be valuable to observe discrete biochemical changes in tissues distant from the site of tumor

More than 60 years later, the idea that saliva analysis can be used to detect different types of cancer is gaining traction in the scientific community. In the specialised literature, papers containing the keywords "diagnosis," "cancer" and "saliva" grew more than tenfold over the past two decades, from 26 in 2001 to 117 in 2011, 183 in 2016 and 319 in 2021, according to the PubMed database, a search engine for biomedical research articles.

The appeal of this approach is obvious. Although cancer can be diagnosed through tissue biopsy, that requires trained physicians wielding long needles, scalpels, endoscopes or other tools to pry into the body to take samples. Liquid biopsy, which looks for traces of tumor components in fluids such as blood, urine, cerebrospinal fluid, semen or saliva, is a less invasive alternative. Of these, the simplest sample to collect is undoubtedly saliva.

The approach has already paid off: In 2021, the US Food and Drug Administration gave an innovative device designation to a saliva-based oral and throat cancer prediagnostic tool developed by the US company Viome. (Such designations are granted to novel medical devices that have the potential to provide more effective treatment or diagnosis of life-threatening diseases.) Based on artificial intelligence and machine learning, the tool analyses a saliva sample for the activity of genes (in particular, messenger RNA) belonging to the bacterial community housed in the mouth. For unknown reasons, this community is modified when a tumor develops on the lips, tongue, throat

"For decades, saliva was considered a stepchild

who spent a decade working on Viome's saliva diagnostic test. Now at Griffith University in Australia, she is lead author of a 2021 study describing the test's development in NPJ Genomic Medicine. But that view of saliva as an afterthought could begin to change in the coming years as techniques to analyse it advance and a better understanding develops of what information it can hold. "Because saliva can be collected noninvasively, an empowered patient could take multiple samples and become a steward of his or her own diagnostic tests," Punyadeera predicts.

The treasure contained in saliva

Every day, the salivary glands of an average adult produce between 500 and 1,500 millilitres of saliva to aid digestion and preserve oral health. In addition to enzymes, hormones, antibodies, inflammatory mediators, food debris and microorganisms, saliva has been found to contain traces of DNA and RNA or proteins from tumors.

"The goal of saliva diagnostics is to develop rapid, noninvasive detection of oral and systemic diseases," write dental scientists Taichiro Nonaka of Louisiana State University and David T.W. Wong of the University of California, Los Angeles, in an article on saliva diagnostics published in the 2022 Annual Review of Analytical Chemistry. The field is developing rapidly due to the progress of "omics sciences" that analyse large collections of molecules involved in the functioning of an organism – such as genomics (genomes), proteomics (proteins) or metabolomics (metabolites) – as well as methods for analysing large quantities of data. For example, the proteome of saliva – an exhaustive catalogue of the proteins present in this fluid - is already available, and it is known that between 20-30% of the saliva proteome overlaps with that

But "the study of diagnostics through saliva is a relatively new field," says Nonaka. It wasn't until the last decade, he says, that it became known that salivary glands - parotid, submandibular, and sublingual, as well as other minor glands, in close proximity to blood vessels transfer molecular information.

Today, in saliva – and also in blood – scientists are beginning to look for and find circulating tumor DNA (ctDNA), which is DNA that is shed from cancer cells when a tumor is present in the body. Multiple studies have identified biomarkers such as proteins that are produced in higher quantities in cancer cells or genetic changes that occur in tumor cells – that could be used to detect tumors of the head and neck, breast, oesophagus, lung, pancreas and ovary, as well as to monitor the patient's response to therapies.

For example, in 2015 Chinese researchers published that the identification of two fragments of of blood," says chemist ChamindiePunyadeera, an RNA strand (microRNA) in saliva allowed the



detection of malignant pancreatic cancer in 7 out of 10 patients with the disease. A more recent review of 14 studies involving more than 8.000 participants estimated that breast cancer patients were 2.58 times more likely to have certain saliva-detectable biomarkers - although 39% of the negative test results were in patients who actually had breast cancer. The research in the field is promising, but will require further prospective studies to determine its clinical applicability, Nonaka says.

"A great advantage of liquid biopsies is that they can sweep for up to 50 types of cancers in early stages at once, when they can be surgically treated or are candidates for short, targeted treatments," says biologist Marina Simián, a researcher at Argentina's National Scientific and Technical Research Council at the Nanosystems Institute of the National University of San Martín, in Buenos Aires. Simián is also co-founder of the company Oncoliq, which aims for the early detection of breast, prostate and other tumors from a blood

"With today's tools, very few organs are screened for cancer," says Simián. Common screens include ones for prostate, breast, cervix, colon after the age of 50, and the lungs for those who have smoked heavily. And in the world, she says, only half of these people undergo these tests, and in many countries, not even 10%. The hope is to add many more tests that can be done on a single blood or saliva sample.

It is possible that in the future, testing of both

blood and saliva will be the norm. Although there is still a long way to go, Nonaka believes that, except for oral cancers, saliva testing should most likely be supplemented with liquid biopsies in blood or urine, plus other parameters to increase

sensitivity and practical utility. In pursuit of exosomes

One particularly promising type of component to look for in saliva is the exosome. Exosomes are tiny lipid-wrapped vesicles that are present in almost all types of body fluids. They are transporters or messengers that travel from one cell to another even to those in very distant organs. They carry a cargo of genetic material and proteins, which is taken up by a recipient cell in an organ and plays important roles in cell-to-cell signaling. But exosomes also have an important role in cancer. "They are key players," says Punyadeera. Released by cancer cells, they pass into the blood and from there, can reach the salivary glands. The exosomes are thus dumped into the saliva, from which they can be collected.

Exosomes from tumor cells have a specific composition and are suspected of contributing to the spread of cancer to other organs or tissues. But from a diagnostic perspective, one of their main advantages is that they package and protect the cargo – in other words, they do not mix with the other components of saliva. In this way, they provide "more stable and accurate clinically relevant information for disease detection," Nonaka ex-

For example, for squamous cell oesophagal cancer, scientists have found two signatures or signals in salivary exosomes that allow detection of this disease with a sensitivity and specificity of more than 90%, in addition to providing guidance on prognosis and treatment, as reported in January 2022 in Molecular Cancer.

Factors such as the concentration or appearance of exosomes under the microscope can also be revealing. Patients with oral cancer, for example, have exosomes with different shapes and sizes than those found in healthy individuals.

However, the techniques available so far to isolate and study the exosome content of saliva are expensive and laborious. In response to this challenge, a new method known as electric field-induced release and measurement, or EFIRM, has emerged; it integrates electrochemical sensors and magnetic fields to elegantly capture minute amounts of circulating tumor DNA and other molecules – biomarkers – that indicate the presence of cancer. This technique has already shown encouraging results in the early detection of nonsmall cell lung cancer and could also be used to assess response to treatment.

The US company Liquid Diagnostic LLC, in which Wong has a stake, already offers this technology, having christened it Amperial and promising "the highest specificity and sensitivity for early stage cancers" and at "much lower cost." Those most enthusiastic about the technology propose a world where a routine visit to the dentist saves lives and it is not necessary to draw blood to check if someone is ill. But experts agree that, for that dream to become a reality on a large scale, more studies are still needed.

"To achieve the translation of salivary biomarkers to the clinic, it is necessary, on the one hand, to develop standardised protocols and, on the other, to carry out large multicenter studies in which the influence of different confounding variables such as age, sex or lifestyle is analysed," says dental scientist OscarRapado González, of the Health Research Institute of Santiago de Compostela, in Spain, where he is investigating the use of saliva samples for the detection of head and neck cancers, as well as colorectal tumors.

The identification in saliva or other fluids of molecules directly or indirectly related to tumors has potential apart from early detection, says Rapado González. It might make it possible to assess individual risk of developing cancer, predict how a tumor will evolve or monitor the therapeutic response in a noninvasive way, allowing the development of personalised medicine.

"Undoubtedly," Rapado González says, "more research in this field will drive progress toward the applicability of saliva in precision oncology in the coming years." (Courtesy: The Wire)

The questions ChatGPT will not answer for you

Thile experimental, Artificial Intelligence chatbots like ChatGPT, look like fascinating, useful, free tools instantly answering all queries based on the prompts that users give it, it poses serious security risks that legal regulations don't address. They are disrupting the way we work, such national security threats without the necessary safeguards being set in place?

AI opens a new front in cyber arms race Artificial Intelligence (AI) arms race is disrupting our lives. A paradigm shift in technology fuels the battle for supremacy between man, machine, and nations. So, what does it mean to be human? Can machines think? Can machines trump human creativity? Does AI pose an existential risk to humans? Will your brain become vestigial due to a growing dependency on AI? No one truly knows the answers. And, a few who may know the answers aren't going to share, as the stakes are too

With the advent of AI systems endowed with perception, cognition, and decision-making, the AI application layer has increasingly turned vast, deeply impacting our lives. For instance, OpenAI's ChatGPT, backed by Microsoft and Google's Bard, are experimental, conversational. AI chat services that use online information to give replies to your 'questions'. But asking questions means providing personal data to the AI bots.


Unregulated risks of global experiments Functionally an advanced search, these AI systems are massive global AI experiments driven by AI bots, without the subjects' explicit consent. The goal of such experimental research is to thrive on user data freely to refine products for profit while claiming to advance AI to benefit humanity. As renowned linguist Noam Chomsky says, "AI could significantly impact people's capacity for independent thought and creation.'

Your questions and inputs are used as 'training data' for refining these bots, and the individual outputs become part of collective intelligence. A responsible firm committed to benefitting humanity would not have released an unfinished technology to the public with risks, be it privacy intrusion, plagiarism, nonexplainability, algorithmic biases or harm to social info-ecosystems.

The problem is while AI firms say humanity is not far from potentially scary AI, they still release AI technology publicly, even before the rules are laid. This will open the doors to a few Big Tech companies to gain control over our lives and society. Thus, there is a need to protect people from corporates using AI for profit, with no accountability. Employees are feeding sensitive business data as training data into AI-driven ChatGPT, leading to growing security concerns and the risk of leakage of proprietary information or trade secrets strategy, approach, business models, and tech contains confidential information. Owing to privacy, many companies, including Amazon, Walmart, JPMorgan, Verizon, Goldman Sachs, and KPMG are curbing the use of ChatGPT

by employees and evaluating safer pathways. From New York to China, schools, colleges, universities and regulators are banning Chat-GPT amid serious security fears. America's Federal Trade Commission has warned Silicon Valley against false AI claims, urging truth, fairness, equity in the usage of AI tools.

India needs to wake up to the threat and act now. The real challenge facing people is the of the data used by the AI systen



and its accuracy, reliability, and consistency. More so, as existing human bias is too often transferred to AI. And, the latest AI bots work well upon having access "lots of data" to mimic your intelligence without revealing how it will be used. Data labelling, network portability, data portability and interoperability of data will help us tame AI-powered systems.

Let's ask: Who owns the content generated by ChatGPT? What can the owner do with the content? Does it infringe copyright? Is it "openly" plagiarised? Can the content generated be copyrighted? Does the content violate intellectual property rights and privacy? Will the platform or owner be liable for risks?

Need for stricter AI regulations

The limitations of above questions are, by design, to steer the evolution of AI to benefit a select few. EU Industry Chief has demanded stricter AI regulations. Even OpenAI's Founder, Sam Altman, says relying on chatbots for anything important right now is a mistake. The directive has been largely ignored, which may lead to unintended consequences.

Tech news site CNET used AI for writing articles that were found to have serious errors, denting its publication. Tech publication WIRED doesn't publish stories with text generated or edited by AI, except for new headlines or text for short social media posts. brainstorming story ideas, or using AI more like a search engine. Interestingly, it vowed not to publish stories with text generated by AI, except for headlines or text for short social media posts, story ideas, or using it like a search engine. AI failure also carries high reputational risks. As the incidences are likely to increase, preventing 'data creep, scope creep, and the use of biased training data' will make AI more responsible. AI stakeholders, the policymaking community, and governments should invest in building social norms, public policy, and educational initiatives to prevent machine-generated disinformation. Mitigation will require effective policy and partnerships across the ecosystem.

Research indicates an over-reliance on AI, which may help generative AI become smart, but humans become dumber by losing their unique knowledge and diversity of thought. When humans start mimicking AI output and stop taxing their brains, it may stunt their ability to think with little unique knowledge, leading to suboptimal collective performance detrimental to innovations. As human choices converge toward similar responses, increasing human accuracy but reducing unique human understanding. While the AI arms race intensifies, India needs to invest more in R&D and swiftly work on the AI systems governance, responsibility, and accountability to protect privacy, safety, and unintended consequences. No laws in the nation prevent AI from infringing on human rights, or scooping the human brain without consent as technology continues to refine itself.

An algorithm has no feelings. Yet, the way the programme 'trains itself', AI can reinforce social biases and prejudices by maximising its designated outcome. Humans must be clear in how we envisage AI to shape our future: Do we want AIs to maximise narrow goals while producing negative externalities? Or, training AI to evolve a smarter planet (eliminating harmful biases)?

Growing self-reliance on AI

Being part of the Global Partnership on Artificial Intelligence (GPAI) floated by G7. India should critically nurture equitable rules for data governance, safety, and trust around AI rooted in collaborative research and set up global Centres of Excellences (COEs) fostering human rights, inclusion, diversity, innovation, and growth. Interestingly, China shuns the US-led GPAI, but is eyeing global AI leadership by 2030. Initiatives like Make AI in India and Make AI work for India will yield limited impact unless the nation balances the trade off with whom it wants to work as a trusted partner or takes bold steps to develop self-reliance like China.

GCHQ, the global cybersecurity agency, warns that ChatGPT and rival chatbots are security threats. Technologies powering Chat-GPT may also span geopolitical tools like propaganda, cyberattacks, synthetic biology or autonomous-fighter jets that give huge economic leverage. As AI expands in people's lives even in useful ways, these systems may diminish individuals' ability to control their choices. Yet, if AI isn't kept in check, we may expect an Orwellian future. As the Federal Trade Commission warns, policymakers need to exercise caution in using AI

So, how can humans future-proof themselves? AI is just a tool, and shouldn't define humankind. We still need thinking, curiosity adaptability, empathy, judgement, creativity, and skills that oversee, fix, and create these technologies. Living with AI means asking the right questions, questioning answers, and learning to explain why you accept an output. (Courtesy: ORF)

Eric Garcetti sworn in as US **Ambassador to India**



WASHINGTON, March 25 (PTI): Eric Garcetti, President Joe Biden's close aide, was officially sworn in as the US Ambassador to India by Vice President Kamala Harris, ending over two years of delay to fill one of Washington's most critical diplomatic positions.

Garcetti's daughter Maya held the Hebrew Bible during the swearing-in ceremony on Friday, which was presided over by Vice President Harris.

Garcetti raised his right hand while Harris performed the ceremony, and family members cheered when the two longtime friends shook hands.

The ceremony was attended by his close family members, including wife Amy Wakeland, father Gil Garcetti, mother Sukey Garcetti and mother-in-law Dee Wakeland.

"It feels great. Can't wait to serve," Garcetti, 52, said when asked about his new diplomatic assignment.

"I'm so honoured the vice president did this," he said.

Second Gentleman Doug Emhoff also attended the event.

Former Mayor of Los Angeles Garcetti's nomination was pending before the US Congress since July 2021 when he was nominated by President Biden.

The Senate voted 52 to 42 to confirm Garcetti earlier this month after his nomination stalled amid concerns by some lawmakers that he had not adequately handled allegations of sexual assault and harassment against a former senior adviser. India's envoy here Taranjit Singh Sandhu met Garcetti soon after his swearing-in ceremony.

"Congratulated @ericgarcetti on his swearing-in as the Ambassador of America to India," Indian Ambassador to Washington Sandhu tweeted after the meeting on Friday. "As he prepares to depart for India, we discussed some immediate priorities in deepening the bilateral partnership, in line with our Leaders' vision," Sandhu said.

He said he looked forward to working with Garcetti. Garcetti's nomination was not brought to the Senate floor for a vote during the last Congress as the ruling Democratic Party did not have enough support to get him

President Biden renominated him to the same position in January this year.

The US Embassy in India has been without an ambassador since January 2021, the longest stretch in the history of US-India relations that the post has sat vacant since Kenneth Juster, the last US envoy in New Delhi, stepped down after the change of government in America.

Biden has sought to bolster economic ties with India as he looks to counter China's growing influence in the region and shore up support for Ukraine against contin-

ued Russian aggression. India has not explicitly condemned Russia's invasion and has continued to buy cheap gas from Moscow.

Asked when he plans to travel to India, Garcetti said: "Hopefully as soon as I can."

The ceremony in Harris' office also marked a personal moment between two politicians who ascended the California political world together. Harris and Garcetti's relationship spans more than 15 years, during which she served as California's attorney general and later as a US senator for the state, the Los Angeles Times said. He has also spoken about their bond over being mixed race: Harris is of Indian and Jamaican descent and Garcetti is Jewish and Mexican American.

Coroner: 13 dead in tornado that ripped through US South

A powerful tornado tore through rural Mississippi and Alabama on Friday night, killing at least 13 people, destroying buildings and knocking out power as severe weather that produced hail the size of golf balls moved through several southern states and prompted authorities to warn some in its path that they were in a "life-threatening situation."

The National Weather Service confirmed a tornado caused damage about 60 miles (96 kilometers) northeast of Jackson, Mississippi. The rural towns of Silver City and Rolling Fork were reporting destruction as the tornado continued sweeping northeast at 70 mph (113 kph) without weakening, racing towards Alabama through towns including Winona and Amory into the night.

Sharkey County Coroner Angelia Easton told ABC News that 13 people were killed by the tornado in Mississippi. Rolling Fork is located in Sharkey County.

ABC News early Saturday reported an additional six deaths, including three in Carroll County, two in Monroe County and one in Humphreys County, citing the county coroners and a Mississippi Highway Patrol trooper. The Associated Press was not immediately able to confirm those fatalities.

The National Weather Service issued an alert as the storm was hitting that didn't mince words: "To protect your life, TAKE COVER NOW!" "You are in a life-threatening situation," it warned. "Flying debris may be deadly to those caught without shelter. Mobile homes will be destroyed. Considerable damage to homes, businesses, and vehicles is likely and complete destruction is people to hospitals. He did not immediately



possible." Cornel Knight told The Associated Press that he, his wife and their 3-year-old daughter were at a relative's home in Rolling Fork when the tornado struck. He said the sky was dark but "you could see the direction from every transformer that blew."

He said it was "eerily quiet" as that happened. Knight said he watched from a doorway until the tornado was, he estimated, less than a mile away. Then he told everyone in the house to take cover in a hallway.

He said the tornado struck another relative's home across a wide corn field from where he was. A wall in that home collapsed and trapped several people inside. As Knight spoke to AP by phone, he said he could see lights from emergency vehicles at the partially collapsed home.

Rolling Fork mayor Eldridge Walker told WLBT-TV he was unable to get out of his damaged home soon after the tornado hit because power lines were down. He said emergency responders were trying to take injured

know how many people had been hurt. A former mayor of Rolling Fork, Fred Miller, told the television station a tornado blew the windows out of the back of his house.

Storm chaser Reed Timmer posted on Twitter that Rolling Fork was in immediate need of emergency personnel and that he was heading with injured residents of the town to a Vicksburg hospital.

The Sharkey-Issaquena Community Hospital on the west side of Rolling Fork was damaged, WAPT reported.

The Sharkey County Sheriff's Office in Rolling Fork reported gas leaks and people trapped in piles of rubble, according to the Vicksburg News. Some law enforcement units were unaccounted for in Sharkey, according to the newspaper.

Rolling Fork and the surrounding area has wide expanses of cotton, corn and soybean fields and catfish farming ponds. More than a half-dozen shelters were opened in the state by emergency officials.

New Yorkers cautious ahead of Trump's UN head says survival depends on how people manage water likely indictment in hush money case

NEW YORK, March 25 (PTI): New Yorkers are voicing mixed feelings amid the possibility of Donald Trump's indictment, with some expressing confidence that law enforcement agencies will be able to maintain order in the city while others are apprehensive of how the situation will unfold if criminal charges are brought against the former US president.

A grand jury is weighing whether to indict Trump, 76, over hush money payments made to a porn star to keep quiet about an alleged affair during the 2016 presidential campaign.

Barricades have come up at several points near the courthouses in Lower Manhattan as well as outside the office of Manhattan District Attorney Alvin Bragg where police personnel are manning the premises as it was expected that Trump could be indicted by a Manhattan grand jury this past week.

"Barricades are being set up around Manhattan Criminal Court – as our nation awaits an announcement on whether President Donald J. Trump will be INDICTED despite having committed NO CRIME," a Trump email said.

serted look Friday as the week wrapped up without the grand jury indictment that could charge Trump. While Trump has called on his supporters to protest against the indictment, there were no demonstrators outside the courthouses as the week concluded.

Secretary-General Antonio Guterres said Friday at the end of a three-day conference on global water resources during which developing nations made urgent calls for help with cleaner drinking water and better sanitation. "All of humanity's hopes for the future depend, in some way, on charting a new course to sustainably manage and conserve water," Guterres said in his closing re-

This includes rational use of water for agriculture and more aggressive action against climate change, he said, and water "needs to be at the center of the global political agenda." The U.N. World Water Development Report, issued on the eve of the conference, says



2 billion people — don't have access to safe drinking water and 46% — 3.6 billion people — lack access to basic sanitation. U.N. research also shows that almost half the world's people will suffer severe water stress by 2030. The conference included many verbal pledges to improve water supplies, but fewer detailed commitments translating ambition into improved daily life for ordinary people.

"We have such beautiful, ambitious policies, but in a way they are unfeasible," said Lina Taing, senior researcher at the global think

She said when it comes to getting people clean water and sanitation, 'we know that we are completely off track." Taing said the world needs to increase its actions "four times." Throughout the conference, water-stressed nations, particularly those in the developing world, told U.N. members of their need for international aid to provide their people with drinking

water and sanitation systems. "Waging a war on two fronts simultaneously, to address water issues and climate change, is no mean feat, especially for a small island nation like Kiribati which has very limited resources at its disposal, said Teburoro Tito, U.N. representative from the island nation of fewer than 200,000 people in the middle of the Pacific. He said Kiribati was particularly ill-equipped to respond to natural disasters.

Moore became Intel's chief executive in 1975

Intel co-founder, philanthropist Gordon Moore dies at 94


SAN FRANCISCO, March 25 (AP): Gordon Moore, the Intel Corp. cofounder who set the breakneck pace of progress in the digital age with a simple 1965 prediction of how quickly engineers would boost the capacity of computer chips, has died. He was 94.

Moore died Friday at his home in Hawaii, according to Intel and the Gordon and Betty Moore Foundation.

Moore, who held a PhD in chemistry and physics, made his famous observation — now known as "Moore's Law" – three years before he helped start Intel in 1968. It appeared among a number of articles about the future written for the now-defunct Electronics magazine by experts in various fields.

The prediction, which Moore said he plotted out on graph paper based on what had been happening with chips at the time, said the capacity and complexity of integrated circuits would double every

Strictly speaking, Moore's observation



referred to the doubling of transistors on a semiconductor. But over the years, it has been applied to hard drives, computer monitors and other electronic devices, holding that roughly every 18 months a new generation of products makes their predecessors obsolete.

It became a standard for the tech in-

"It's the human spirit. It's what made Silicon Valley," Carver Mead, a retired California Institute of Technology com-

puter scientist who coined the term 'Moore's Law" in the early 1970s, said in 2005. "It's the real thing." Moore later became known for his philanthropy when he and his wife established the Gordon and Betty Moore

Foundation, which focuses on environmental conservation, science, patient care and projects in the San Francisco Bay area. It has donated more than USD 5.1 billion to charitable causes since its founding in 2000.

Those of us who have met and worked with Gordon will forever be inspired by his wisdom, humility and generosity," foundation president Harvey Fineberg said in a statement.

Moore was born in California in 1929. As a boy, he took a liking to chemistry sets. After getting his PhD from the California University of Technology in

1954, he worked briefly as a researcher at Johns Hopkins University. His entry into microchips began when he went to work for William Shockley, who in 1956 shared the Nobel Prize for physics for his work inventing the transistor. Less than two years later, Moore and seven colleagues left Shockley Semiconductor Laboratory after growing tired of its namesake's management practices.

The defection by the "traitorous eight," as the group came to be called, planted the seeds for Silicon Valley's renegade culture, in which engineers who disagreed with their colleagues didn't hesitate to become competitors.

The Shockley defectors in 1957 created Fairchild Semiconductor, which became one of the first companies to manufacture the integrated circuit, a refinement of the transistor. Fairchild supplied the chips that went

into the first computers that astronauts used aboard spacecraft.

In 1968, Moore and Robert Noyce,

one of the eight engineers who left Shockley, again struck out on their own. With USD 500,000 of their own money and the backing of venture capitalist Arthur Rock, they founded Intel, a name based on joining the words "integrated" and "electronics.

Moore became Intel's chief executive in 1975. His tenure as CEO ended in 1987, though he remained chairman for another 10 years. He was chairman emeritus from 1997 to 2006.

He received the National Medal of Technology from President George H.W. Bush in 1990 and the Presidential Medal of Freedom from President George W.

Bush in 2002. Despite his wealth and acclaim, Moore remained known for his modesty. In 2005, he referred to Moore's Law as "a lucky guess that got a lot more publicity

than it deserved. He is survived by his wife of 50 years, Betty, sons Kenneth and Steven, and four grandchildren.

New Zealand tells China its concern on lethal aid to Russia

BEIJING, March 25 (AP): New Zealand foreign minister Nanaia Mahuta has expressed concern to China over any provision of lethal aid to support Russia in its war against Ukraine during a meeting with her Chinese counterpart. Her press office on Saturday detailed Mahuta's cautionary remarks in Beijing, days after Chinese President Xi Jinping concluded his trip to Moscow, a warm affair in which Xi and Russian President Vladimir Putin praised each other and spoke of a profound friendship. Mahuta's four-day trip, which began Wednesday, was the first made by a New Zealand foreign minister to Beijing since 2018 but it came at an awkward time as Xi visited Moscow the same week to give Putin a diplomatic boost after the International Criminal Court said it wants to put him on trial for alleged war crimes. On the Ukraine war, Mahuta reiterated her government's condemnation of Moscow's "illegal invasion" to her counterpart Qin Gang.

Plea in SC challenging automatic disqualification of lawmakers

Members of Parliament are the voice of people and they uphold the right to freedom of speech and expression of millions of those who have elected them

NEW DELHI, March 25 (PTI): A plea has been filed in the Supreme Court challenging the "automatic disqualification" of lawmakers upon their conviction and being sentenced to a jail term for two years or more according to section 8(3) of the Representation of the People Act.

The plea, filed by a Kerala-based social activist, said the immediate reason for approaching the apex court was a recent development related to Congress leader Rahul Gandhi's disqualification as a member of Parliament from the Wayanad Lok Sabha constituency, after he was convicted by a court in Gujarat's Surat in a 2019 criminal defamation case. The petitioner, Aabha Muralidharan, has sought a declaration that the automatic disqualification under section 8(3) of the Representation of the People Act, 1951 is ultra vires the Constitution for being "arbitrary" and "illegal".

The petition has claimed that an automatic disqualification of people's representatives of elected legislative bodies restrains them from "freely discharging their duties cast



upon them by the voters of their respective constituencies, which is against the principles of democracy". "The present scenario provides a blanket disqualification, irrespective of the nature, gravity and seriousness of the offences, allegedly against the concerned member, and provides for an 'automatic' disqualification, which is against the principles of natural justice since various convictions are reversed at the appellate stage and under such circumstances, the valuable time of a member, who is discharging his duties towards the public at large, shall be rendered futile," the plea, filed through advocate Deepak Prakash, said. Regarding Gandhi's disqualification, the plea said the conviction has been challenged, but in light of the operations of the present disqualification rules under the 1951 Act, the stage of appeal, the nature of the offences, the gravity of the offences and the impact of the same over the society and the country are not being considered, and in a blanket manner, an automatic disqualification has been ordered.

It said members of Parliament are the voice of people and they uphold the right to freedom of speech and expression of millions of their supporters who have elected them. "All that the petitioner and the petition wish to establish is that the right under Article 19(1)(a) enjoyed by a member of Parliament is an extension of the voice of millions of his supporters," it said. The plea said the provision ignores the first schedule of the Code of Criminal Procedure (CrPC) on "classification of offences", which can be categorised under two headings -- cognisable and non-cognisable and bailable and non-bailable. The plea said the grounds for

disqualification ought to be specific with the nature of offences as specified under the CrPC and not in a "blanket form", as is currently in force according to section 8(3) of the 1951 Act. It said the apex court had, in the case of Lily Thomas versus Union of India, declared as ultra vires the Constitution section 8(4) of the 1951 Act, which said the disqualification of a lawmaker on conviction shall not take effect until three months have elapsed from the date or, if within that period an appeal or application for revision is brought in respect of the conviction or sentence, until that appeal or application is disposed of by a court.

The plea alleged that the Lily Thomas verdict is being "blatantly misused for wreaking personal vengeance by political parties".

The petition said if the offence of defamation under the Indian Penal Code (IPC), which attracts a maximum punishment of two years in jail, is not removed singularly from the sweeping effect of the Lily Thomas judgement, it will have a "chilling effect on the right of representation of the citizens".

There are bound to be certain differences in terms of some outlook but you can't have conflicting positions. This doesn't mean confrontation. We are the largest democracy in the world."

The Centre would support the Indian judiciary to be independent, he said, and called upon the bench and the bar -- being two sides of the same coin -- to work together to ensure that the court complex is not divided. "One can't exist without the other. Court must have proper decorum and conducive atmosphere."



He further said, "Everybody can't think alike."

"We are not ruled by a dictatorial king, so the difference of opinion can't be termed as a crisis in Indian democracy. We can criticise each other but when it comes to national interest we must be one," he stressed.

His ministry was involved in developing a common core vocabulary where Indian languages will have certain common usages, purely technical in nature, soon, to ensure that common people receive orders in their respective languages.

Lauding the courts in Tamil Nadu for their excellent performance during the pandemic in delivering justice to the people, he said judicial infrastructure in Tamil Nadu was comparatively better than in many States in India. Recently, he visited Puducherry and found

There may be separation of powers between the executive and the judiciary but that did not mean they shouldn't work together, the Law Minister asserted. "We should work as a team to identify and

ensure that challenges like pendency of cases are tackled," he said, adding, "In India, every judge is handling 50-60 cases every day. If I had to deal with so many cases, the mental pressure would be tremendous. That is why sometimes there is constant criticism that judges are unable to deliver justice, which is not true."

Countdown for OneWeb India-2 mission begins

SRIHARIKOTA, March 25 (PTI): The countdown for the launch of 36 satellites on-board LVM3-M3/OneWeb India-2 mission has commenced, the Indian Space Research Organisation (ISRO) said on Saturday. Network Access Associates Ltd, United Kingdom (OneWeb Group Company) has signed an agreement with ISRO's commercial arm NewSpace India Ltd to launch 72 satellites into Low-Earth orbits (LEO). The first set of 36 satellites for OneWeb Group company was launched on October 23, 2022.

OneWeb is a global communication network powered from the space, enabling connectivity for governments and businesses. The company which has Bharti Enterprises as a major investor, is implementing the constellation of low earth orbit satellites

In a notification on Saturday, ISRO said, "LVM3-M3/OneWeb India-2 mission. The countdown has commenced."

According to OneWeb, Sunday's launch would



would be completing the first generation of LEO (Low Earth Orbit) constellation. For ISRO this would be the second launch in 2023 after the successful launch of SSLV-D2/EOS07 mission in

OneWeb said, "17 launches completed. One pivotal launch remains - OneWeb Launch 18. As we launch another 36 satellites with our colleagues at ISRO and NewSpace India Ltd this weekend (March 26), we will reach 616 satellites in-orbit more than enough satellites to launch

Cong says it will launch 'Jan-Andolan' across country

NEW DELHI, March 25 (PTI): The Contation against Rahul Gandhi's disqualification from Lok Sabha, alleging that the government acted with lightning speed to "gag" him, and called for taking forward the opposition unity in a systematic manner.

Soon after Gandhi's disqualification by the Lok Sabha Secretariat, the Congress leadership got into a huddle at the party headquarters and deliberated on the way forward.

Top Congress leaders, including former AICC chief Sonia Gandhi, party president Mallikarjun Kharge, general secretaries Priyanka Gandhi Vadra, K C Venugopal, Jairam Ramesh, Rajiv Shukla and Tariq Anwar, and senior leaders P Chidambaram, Anand Sharma, Ambika Soni, Mukul Wasnik, Salman Khurshid and Pawan Kumar Bansal among others attended the meeting where the party decided to take this forward into a "Jan Andolan".

Congress general secretary Ramesh said, We will go all over the country as Rahul Gandhi was deliberately disqualified for raising his voice against the Modi government on the Adani issue, on the government's foreign policy and the clean chit given to China for incursions at the border."

Ramesh said the BJP was rattled with the success of the Bharat Jodo Yatra, which, he said, became a movement.

The Congress leadership has welcomed the statements of support of all opposition leaders, he said, and asserted that "we should now take the issue of opposition unity forward in a systematic way". "It was noted today that many opposition parties have condemned the action taken unilaterally with such lightning speed to disqualify Rahul Gandhi," he said.

"Yes, there was a consensus that we should now take the job of building opposition unity in a systematic way. Every day Leader of Opposition in Rajya Sabha Mallikarjun Kharge has been meeting floor leaders of Lok Sabha and Rajya Sabha. So we are coordinating in Parliament and now coordination has to be outside Parliament," he said.

"It is also heartening to note that parties which were not part of this floor coordination have now issued public statements condemning this action of disqualification of Rahul Gandhi," Ramesh said.

The Congress' state units and frontal organisations will launch programmes across the country and they will begin from Monday with a countrywide agitation, he said.

"We will go all over the country saying that Rahul Gandhi has been deliberately disqualified as he has been raising his voice against the Modi government on various issues, including demonetisation, GST, foreign policy, and the government's intentions and policies," Ramesh said.

India to discuss its indigenous medicinal knowledge in G20 summit

NEW DELHI, March 25 (PTI): In a bid to bolster the fight against future pandemics, India's top scientific advisor Prof Ajay Kumar Sood has urged G20 countries to collaborate in developing vaccine platforms by cooperating with each other in the pre-competitive research and development phase.

In a video interview with PTI, Sood, who will chair the Chief Scientific Advisors' Roundtable (CSAR) of G20 countries next week, said India will also present its traditional systems of medicine and seek to harness the knowledge of indigenous communities of different

Making a strong pitch for collaboration among G20 nations in drug development, Sood, the principal scientific advisor to the government, said there is enormous scope for cooperation in the pre-competitive research and develop-

"Once it reaches a certain level of maturity, of course different countries will have their take. But pre-competitive R&D (research and development) space is what we think should be something where we should work," he said.



Sood identified emerging technologies for environmental surveillance as

another area for cooperation. "This is something which has to be done by all countries. A lot of it is happening but there are many other countries which will need a helping hand. So, we should be ready to take everyone along," he said.

Pre-competitive collaboration involves two or more companies operating within the same industry coming together to address a shared problem or pain point that doesn't impact direct business competition or contribute to unfair advantage.

"When there is a pandemic, you cannot live in isolation. We have seen it in together and it has to be eradicated or controlled at all places. If it does not, then it will linger on and that is what you are seeing for Covid," Sood said. He said the CSAR meeting in Uttarak-

hand's Ramnagar from March 28-30 will also focus on harnessing the benefits of traditional knowledge in healthcare. "Traditional medicine has a very im-

portant role to play but it should be put in scientific context. All that work has to be done. When you have traditional medicines, how can we put it on a platform where it meets the acceptance of science," he said.

Sood said India has a very rich tradition of Ayurveda, Siddha and Unani and all of them have a role to play. It could be to build up immunity or strength or to address the symptoms of a disease, adding "...whatever you think, it is possible". "We should not try to limit ourselves to only what we call modern medicine," he said, making a strong pitch for diversity in various systems of medicine. Sood also talked about harnessing the knowledge repositories of indigenous communities in G20 coun-

"These are very, very old traditions. The goal should be, what we call traditional knowledge, it is really tested over centuries. It is very important that we take this traditional knowledge along with the other streams." Sood said. Sood said the Ayush ministry is work-

ing on scientific validation of traditional systems of medicine. "The Ayush ministry is doing that. This word was coined a few years back -- ayurvedic biology -- to address the issue of scientific validity. I am sure that in other countries there are parallel efforts. Because these tribal, traditional things are also very important and we need to learn from them," Sood said. The three-day meeting in Ramnagar will focus on four broad themes --Opportunities in One Health for better disease control and pandemic preparedness; Synergising global efforts to expand the access to scholarly scientific knowledge; Diversity, equity, inclusion and accessibility in science and technology (S&T); and an Institutional mechanism for inclusive, continuous and action-oriented global S&T policy dialogue.

New Zealand beat Sri Lanka by 198 runs in 1st one-day match

:Harry Shipley took 5-31 as Sri Lanka was bowled out for 76 on Saturday to lose the first one-day international against New Zealand by 198 runs.

New Zealand made 274 batting first on a drop-in pitch at Eden Park and Sri Lanka was dismissed for its lowest-ever ODI total against New Zealand, its fifthlowest in all one-day internation-

Sri Lanka lost its first two wickets at 14, its third at 20 and its fourth and fifth at 31 as its innings unraveled inside the first 10

When a break was taken after 14.2 overs to honor victims, rescuers and recovery workers involved in Cyclone Gabrielle which battered New Zealand's North Island on Feb. 14, Sri Lanka was 49-7.

Wickets continued to fall steadily and when Sri Lanka was all out after only 19.5 overs, it was for the second lowest oneday international total at Eden Park. Angelo Mathews, who was playing his first ODI in two years, was one of only three Sri Lanka batsmen to reach double figures.

Sri Lanka's first wicket fell to a runout in the sixth over. Shipley took his first wicket in spectacular style when his angled delivery



jagged back through the batter's shot and uprooted his leg stump. He also dismissed Kusal Mendis (0), Charith Asalanka (9), Chamika Karunaratne 11 and cap-

tain Dasun Shanaka for a first-

ball duck. Shipley was playing

his first match for New Zealand in New Zealand after making his debut in India late last year.

"It was pretty cool, not what I was expecting to do when I came to the ground," Shipley said. "The

board was going to be tricky so that gave us confidence to go out there and do that."

Shanaka said his team went out to bat confident that New Zealand's total was "chaseable" at Eden Park which is noted for its short boundaries.

'The way we started, I thought it was going to be a very good game," he said. "The way Shipley bowled, the movement he got and the bounce was responsible for the things that happened tonight so credit should be given to him."

New Zealand wouldn't have been confident when its innings ended at 274, not a massive score by Eden Park standards. Finn Allen top-scored with 51 and Rachin Ravindra made 49 on debut as New Zealand posted what seemed a moderate total.

South Africa-born opener Chad Bowes, on debut at 30, struck the first ball of the match and his international career for four to announce that intention. But after reaching 108-2 in the 19th over, New Zealand lost three wickets for 44 runs, its momentum slowed and couldn't be entirely recovered. After Allen, whose fifth ODI half century came from 47 balls, several New Zealand batters made starts but couldn't go on to produce innings which carried New Zealand to a higher total.

Manu Bhaker wins India's sixth medal, China claims sixth Gold

BHOPAL, March 25 (PTI): Olympian shooter Manu Bhaker clinched the 25m pistol bronze medal at the ISSF Pistol/Rifle World Cup to take India's medal tally to seven, including a gold, here on Saturday

Bhaker, the multiple World Cup medal winner, had shot 290 in the precision round on Friday and entered the second day of the competition well placed for the rapid

In the rapid round on Saturday, she again shot three superb series of 98, 99 and 97 to aggregate 294 and advance to the ranking round placed

Another Indian, Esha Singh, who had shot 292 in precision, scored 289 in rapid to aggregate 581 and advance to the ranking round placed

In the ranking match 1, Bhaker qualified for the medal round as the third qualifier with an aggregate of 14 points, along with Germany's Doreen Vennekamp (14 points), while Esha was eliminated.

Two shooters from ranking match -- China's Ziyue Du and Yaxuan Xiong -- qualified for the medal round with 12 points each, to make up the quartet vying for the top position. In a tough medal match, Bhaker was no match for Doreen (30 points) and Ziyue Du (29 points) who won the gold and silver, while the Indian could aggregate only 20 points to finish her campaign with a bronze.

This is the first medal in the ongoing World Cup for Bhaker, who had failed to impress in her favourite event, air pistol, on the opening day of the competition, finishing 16th with 568 points.

China continued their domination in the tournament, winning a sixth gold medal out of the eight decided so far. The final competition day comes up on Sunday with two more finals left to be played -- the women's 3P and the men's 25m rapid fire pistol.

Aishwary finishes fourth Du Linshu won the first medal event of competition on day four, defeating Hungary's Istvan Peni 16-10 in the men's 3P gold medal clash.

Seasoned Swiss 3P specialist Jan Lochbihler won the bronze when he edged out home favourite Aishwary Tomar in the top eight ranking

He finished the 40-shot round with a score of 407.4 while Aishwary, courtesy three five-shot series in the 40s in the final standing position, finished with a score of

Du topped the round with 410.7 while Istvan was second with 408.2. The Indian had earlier topped the 60-shot qualification round with a

score of 591. China now has 10 medals -- six gold, two silver and two bronze. India is placed second with the lone gold won by Sarabjot Singh in the men's 10m air pistol and one silver and four bronze medals

SHARJAH, March 25 (AP): Afghanistan defeated Pakistan in a Twenty20 for the first time on Friday after the latter was restricted to 92-9.

Pakistan, without five rested frontline players including captain Babar Azam, struggled on a slow and low pitch at Sharjah Cricket Stadium against the Afghans, whose six bowlers shared all nine wick-

Afghanistan overcame falling to 45-4 in the 10th over to cruise home at 98-4 and win by six wickets with more than two overs to spare.

Mohammad Nabi raised Afghanistan's first victory over Pakistan in five attempts over the past decade with a straight six over long off.

When Azam Khan was also out for a duck on debut, Pakistan was 41-5 in the eighth

Pakistan was in danger of its lowest T20 total of 74 in 2012 against Australia at Dubai but Imad Wasim top-scored with 18. "Sometimes this can happen due to youngsters being nervous, but they need to be given chances," interim captain Shadab Khan said. "As professionals, we can't give excuses regarding conditions, we have to learn from the loss

Pakistan fast bowling debutant Ihsanullah got two wickets in his first over with shortpitched deliveries.
