Preservation of 'Assam Type' houses need of the hour: Experts

structures mushrooming all over this northeastern state, some areas are still dotted with historically and aesthetically beautiful buildings known as 'Assam Type' houses, which heritage lovers and

experts assert require preservation and restoration. Sloping roofs, louvres, gables, awnings, skylights, bay windows and a porch are some of the features that make them distinctive, along with their sustainability and resilience to withstand earthquakes, experts point out.

"Architecturally, a typical Assam Type house has features which are aesthetically soothing and at the same time sturdy enough to withstand the vagaries of nature," former chief secretary of the state, Jishnu Barua, said. This type of architecture is a style developed during the late 19th century and is primarily found in Assam and other Northeastern states along with Sylhet in Bangladesh, Barua, who has a keen interest in the heritage and preservation of these structures, said.

"These fascinating houses are disappearing fast

the architectural landscape of the state, and there is an urgent need to document, preserve and, where necessary, restore the buildings," heritage activist Nandinee Kalita told PTI.

Upkeep of the structures is necessary for which considerable effort, time, skill and finance are required, Kalita said. "We have attempted to document the history of these houses, its architectural significance, cultural tradition and sociological evolution in a coffee-table book titled 'Aaakriti' which covers a wide spectrum of over 100 houses across the state, ranging from simple family homes to opulent bungalows, government residences and public institutions," she said.

Some of these houses are almost 150 to 200 years old and have gone through extraordinary journeys which "we attempted to highlight through literary and photographic accounts", she said. It was the 1897 earthquake of 8.1 magnitude that struck the Shillong plateau, causing considerable damage to the houses, (CONTD ON PAGE-2)

ISRO's LVM3 successfully injects 36 satellites into intended orbits

March 26 (PTI): The Indian Space Research Organisation's heaviest LVM3 rocket on Sunday successfully placed 36 internet satellites of UK-based OneWeb group company into intended orbits.

The 43.5 metre tall rocket blasted off at a prefixed time of 9 am on Sunday, from the second launch pad of Satish Dhawan Space Centre here, about 135 kms from Chennai, at the end of a 24.30 hour countdown. This is the second dedicated mission of New-Space India Ltd (NSIL), the commercial arm of Indian Space Research Organisation.

ISRO had signed an agreement with Network Access Associates Ltd, United Kingdom, a OneWeb Group Company, for the launch of 72 satellites into Low-Earth orbits (LEO). The first batch of 36 satellites were launched on October 23, 2022 by ISRO, and the second batch on Sunday. OneWeb is a global communication network powered from space, enabling connectivity for governments and



rocket sequentially deployed the satellites into multiple orbits. While the first set of 16 satellites were injected around 20 minutes after lift-off, the remaining satellites were placed into intended orbits later.

ISRO said, "LVM3-M3/OneWeb India-2 mission is accomplished. All 36 OneWeb Gen-1 Satellites injected into the intended orbits." "In its sixth consecutive successful flight, LVM3 carried 5,805 kgs of payload to Low Earth Orbit," the space agency said on its official social media account.

The launch vehicle took off Soon after takeoff, the with a total payload of 5,805

kg at 0900 hrs and gained the required altitude of 450 km in about nine minutes of flight, and achieved satellite injection conditions, ISRO said in a statement. OneWeb confirmed the acquisition of signals from all 36 satellites, it said.

ISRO chairman S Somanath congratulated NSIL, ISRO and OneWeb for the successful launch of the mission.

"As we know today the first 16 satellites of the series are already placed into the right orbit. And now it has gone into the far south of the Earth and we will be getting confirmation of the remaining spacecraft separation soon, once the

onboard storage data is acquired by our Indian ground stations," he said, addressing scientists at the Mission Control Centre. The launch was the 18th for OneWeb while for ISRO, it would be the second mission in 2023 after the successful launch of the SSLV/D2-EOS07 undertaken in February. "Till now, based on observations, the vehicle has done extremely well, it went up to the right orbit and placed the spacecraft at the right orbit and also with very minimal disturbances to it," Somanath noted.

Somanath expressed gratitude to NSIL for its support and also for the confidence that the OneWeb India team reposed in ISRO for building the rocket. Union minister Jitendra Singh lauded ISRO for Sunday's successful launch.

Govt caps maximum GST cess rate on pan masala, tobacco; links rate to retail sale price

The capping of the cess rate was brought in as part of the amendments to the finance bill, 2023

The government has capped the maximum rate of GST compensation cess that would be levied on pan masala, cigarettes and other forms of tobacco and linked the highest rate to their retail sale

The capping of the cess rate was brought in as part of the amendments to the Finance Bill, 2023, which was passed by the Lok Sabha last Friday.

As per the amendment, the maximum GST compensation cess rate for pan masala will be 51 per cent of the retail sale price per unit. In the current regime, the cess is charged at 135 per cent ad val-

The rate for tobacco has been fixed at Rs 4,170 per thousand sticks plus 290 per cent ad valorem or 100 per cent of the retail sale price per unit.

So far, the highest rate was ₹



per cent ad valorem.

The cess is levied over and above the highest Goods and Services Tax (GST) rate of 28 per cent.

Changes in schedule-I of GST compensation cess Act, brought in via amendment in Finance Bill. has capped the maximum cess that can be charged on Pan masala and

tobacco products.

Tax experts, however, said to ascertain the exact compensation cess applicable following this change, the GST council will need to issue a notification.

AMRG & Associates Senior Partner Rajat Mohan said the latest sation cess law is an enabler that will permit the GST council to introduce applicable tax rates through a notification.

This change marks a significant shift in taxation policy for pan masala and tobacco-supplying companies. Though this policy will arrest tax evasion to a great extent in this sector, it still may prove to be a regressive plan from an economic standpoint," Mohan said.

In February, the GST Council chaired by Union Finance Minister Nirmala Sitharaman and comprising state counterparts, had approved the report of a panel of state finance ministers on plugging tax evasion in pan masala and gutkha businesses

The GoM had recommended that the mechanism for levy of compensation cess on pan masala and chewing tobacco be changed from ad valorem to a specific ratebased levy to boost the first stage collection of the revenue

Bangladesh MP bats for 'border hospitals' on lines of 'border haats'

AGARTALA, March 26 (PTI): Taking a cue from the 'border haats' on 'No Man's Land' between the India-Bangladesh boundary, an MP and noted doctor of the neighbouring country has floated the idea of setting up 'border hospitals' to render quality healthcare services to people living along the stretch.

Dr Prangopal Datta, MP of Cumilla and former vice-chancellor of Bangabandhu Sheikh Mujib Medical University in Dhaka, who was here to attend a seminar, said the areas of cooperation in the medical sector should be further enhanced between the two

"The 'border haats' between the two countries for trade of local products, has emerged as a successful model. I think the concept of border hospitals will also be a success. Both the governments can start work on it. I have proposed this idea in different forums of India and Bangladesh," he told PTI.

"People in the border areas of both countries are poverty-stricken and they would be the ones most benefited. Besides, it would also enhance people to people relations between the two neighbouring countries," he said.

Datta said both India and Bangladesh can invest in the proposed project, and the administrative control should remain with the government officials of the two countries.

When contacted, Dr Ashok Sinha, the vice-chairman of the state's Planning Board said, "We are considering setting up such hospitals. I think it's a feasible project, and would be a dream-come-true if successful.

Sinha said a special medical visa could also be introduced for the purpose.

India's highways infra to match US by 2024: Gadkari

The work in 'time bound mission mode' includes construction of green expressways and rail over bridges across the country

RANCHI, March 26 (PTI): India's highways infrastructure will match that of the US by 2024 for which work in time bound 'mission mode' is on including construction of green expressways and rail over bridges, Union Road Transport and Highways Minister Nitin Gadkari said.

He said cabinet nod to 'Bharatmala 2' is likely soon and once obtained it will meet the requirements of a robust infrastructure in the country.

"I am confident that India's highways will be on par with that of the US by 2024. Work in a time bound mission mode is on to build a robust infrastructure including a network of green expressways across the length and breadth of India," Gadkari told PTI in an interview.

The Road Transport and Highways Minister said in this year railway over bridges are being constructed at a cost of ₹ 16,000 crore which will be increased to ₹50,000 crore in five years.



On Bharatmala Phase 2, the minister said: "Nod is likely soon to Bharatmala Phase 2 that will further accelerate the making of highways."



About 5,000 km of highway network is en-

visaged under phase 2 initially Bharatmala Pariyojana is India's largest infrastructure programme to develop about 35.000 km of National Highway corridors, connecting over 580 districts in the nation. The programme signalled a paradigm shift to corridor approach of infrastructure develop-

The overall network of the nation was reimagined through scientific studies including, Origin - Destination study of freight movement across 600 districts and crow-flight alignment for optimised routes to reduce transit time.

"In Jharkhand, work of seven greenfield expressways, economic corridor and inter corridor is being done at a cost of ₹70,000 crore," Gad-kari told PTI.

Besides work worth ₹ 50,000 crore is being done for better connectivity with states like Odisha, Chhattisgarh, West Bengal, Bihar and Uttar Pradesh, he said.

Providing details of the projects, the minister said 4-lane inter corridor work is being done at a cost of ₹ 6,200 crore for Ranchi-Varanasi Inter Corridor which will reduce the travel time significantly between Ranchi and Varanasi.

Likewise, the 635 km Raipur-Dhanbad economic corridor is being constructed at a cost of ₹ 15.000 crore and would ensure faster movement of coal, steel, cement and minerals, he The other projects included ₹ 22,000 crore

Varanasi-Ranchi-Howrah 620 km access-controlled green expressway and ₹ 6,300 crore Ranchi-Sambalpur greenfield economic corridor for 230 km. Apart from these Varanasi-Chordaha (Jhark-

hand-Bihar border) 6-lane 262 km economic corridor being built on completion will provide excellent hassle free connectivity to Kolkata. Assam, Sikkim, Bhutan, Nepal and Bangladesh from Jharkhand, he added. Other projects, the minister said include the

5,000 crore Ranchi Ring Road and added that the detailed project report for this 194 km highway will be completed in May 2023.

The preliminary work to start the exercise has begun and the final job will commence after the CEC's visit, a senior official at the Office of the CEO had told PTI earlier. Chief minister Himanta Biswa Sarma had said in the state Assembly earlier this month that the re-drawing of constituencies was stalled as the then-Congress government had written to the delimitation commission that law and order situation was "not conducive" for the exercise.

"When we were asked if it can be done now, we said the situation has improved now," he added. On December 31, 2022, the Assam Cabinet decided to merge four districts with the ones from which they were carved out and made separate districts. Biswanath was merged with Sonitpur, Hojai with Nagaon, Tamulpur with Baksa and Bajali with Barpeta. The decisions to merge the districts were taken just a day before the Election Commission's ban on creating new administrative units in Assam from January 1, 2023, as the poll panel would undertake the delimitation exercise in the state, came into force. The administrative jurisdiction of some villages and a few towns were also changed at the state Cabinet meeting, held in New Delhi. In March this year, the Gauhati High Court issued two notices to the Assam government asking it to explain within four

that led the British government to set up an expert committee for the construction of buildings suited to the region, engineer Ochintya Sarma, involved in documenting the buildings, said. British engineers and experts studied the environment and locally available building materials and suggested a construction system more

suited to withstand the vagaries of nature, he said. The architectural intervention suggested steep roofs, walls constructed of 'ikora' (elephant grass), vertical and lateral timber frames, high ceilings, and finishing of mud and whitewash. "Strength and insulation from the impact of seasonal changes were the key consideration with local sources mostly used as building materials but zamindars, aristocrats, tea planters, professionals like doctors and lawyers sourced materials from as far as England, Poland, Belgium and Ireland," he pointed out. Teak wood for the pillars, doors, windows and ventilators were brought from Burma and Naga Hills and when the devastating earthquake of 1950 struck the state, the houses were able to stay standing, validating the resilience of its distinctive construction style, Sarma added.

The managing director of Topcem Cements, Bajrang Lohia, pointed out that being in the construction business 'we know that the technique behind the construction of these houses are environmentally sustainable, evolving over the years to adapt to the terrain, climate and availability of raw materials in the region". Times have, however, changed and with pressure on land, many of these structures have given way to concrete structures though there are some who still hold on to their heritage with pride.

For 86-year-old Hironmoyee Goswami, her Assam-type abode is an oasis of peace and "though there has been pressure from many family members that we build a three-storied concrete house as these types of houses are difficult to maintain. I refuse to give in and will spend the last few years of my life in my sprawling home". In recent years, due to renewed awareness and public goodwill, many such dilapidated buildings have been re-

stored by experts, a government official pointed out. Some of the iconic buildings restored are Jorhat's Assam Sahitya Sabha office, Dibrugarh's Berry White Medical College, Guwahati's Cotton University, Christ Church and the former bungalow of the Kamrup deputy commissioner (renamed as the Brahmaputra Heritage Centre), he added.

Hiren Gohain, Akhil extend

The disqualification will bar Gandhi, a four-time MP, from contesting polls for eight years unless a high court stays his conviction. Terming the actions against Gandhi as an "attempt to kill democracy" Saikia said, "Our democracy is such that it allows all political parties to function together. But this BJP-led government is trying to kill this very spirit of our democracy." One alleged that the BJP is digging out 20-30 year old cases against opposition leaders and using agencies like the CBI and ED to "intimidate" them.

Gandhi was disqualified from the Lok Sabha on Friday, a day after a court in Gujarat's Surat convicted him in a 2019 defamation case. The disqualification will prevent Gandhi (52), a four-time MP, from contesting elections for eight years unless a higher court upholds the conviction.



RaGa's disqualification

ncumbent ruling dispensations disenfranchising former rulers and banning them for life from contesting elections is something that one often associated with countries with fragile democracies. Indians are used to news about politicians losing their seats in parliament and being debarred from contesting elections on account of corruption and other offences from across the border rather than in their own country, where such instances are rare if not non-existent. Rahul Gandhi losing his parliament seat and being disqualified from contesting elections for six years in view of his conviction in the defamation case has in the eyes of the world lowered India's prestige as the world's largest democracy. Within hours of Rahul Gandhi's conviction and his unseating from parliament along with a ban of six years in contesting elections, western media put out stories about how Indian democracy has been losing sheen over the years. A Bloomberg report said India is facing the risk of losing its label as the world's largest democracy under Prime Minister Narendra Modi's rule. It made a special mention of the fact that the decision to disqualify the Congress leader from parliament has been taken by the Indian parliament controlled by Modi's party.

BBC recalled how politicians including Rahul Gandhi had moved the Supreme Court for decriminalising defamation, which is based on the British era law and pointed out that charge by free speech advocates that politicians have been using the law to silence their critics. The Economist, also, recently carried an article on India's 'democratic drift', saying parliament was becoming increasingly irrelevant under the Modi administration as laws are passed without scrutiny and debate. It pointed out that the proportion of bills referred to standing committees in the lower house, the Lok Sabha has dropped from around 60-70 percent under the previous government to 27 percent in Mr Modi's first term and just 13 percent in his second. Attendance records in committee meetings in both houses for the past three years reveal a meagre average of 46 percent. Of the 15 bills rushed into law during the monsoon session last year, not one had been deliberated in committee, and many were passed by perfunctory voice votes, it said.

It may appear to be somewhat ironic that the BJP which is celebrating Rahul Gandhi's conviction and his unseating from parliament has been opposing a ban on tainted politicians from contesting elections, which the Election Commission of India has been proposing. While the poll panel favoured a ban, the law ministry opposed the move lock, stock and barrel. In fact, on a petition filed by activist lawyer and BJP supporter Ashwini Kumar Upadhyay seeking a lifetime ban on tainted politicians in a bid to check rising criminalisation of the polity and greater number of tainted politicians in elected houses, the Modi government responded saying the existing laws have several provisions which adequately dealt with this issue. A Law Commission report had recommended disqualification of persons against whom charges have been framed at least one year before the date of scrutiny of nominations for an offence punishable with a sentence of five years or more. The Supreme Court has time and again expressed itself in favour of decriminalising politics, but at the same time pointed out its inability to push ahead with the idea due to lack of legislative mandate.

Indian economy is still in a position to insulate itself from global turmoil

have all raised their policy interest rates to fight inflation, there might be further flutters in the financial sector and several other banks might be nervous about the future. However, the central bankers have flatly stated that their primary responsibility was to fight inflation and preserve price stability. Jerome Powell of the US Federal Reserve has stated that the economy could not function with high inflation rates. The Bank of England chief on the other hand felt more optimistic about the British economy after introducing the necessary rate

What should be the prospect for the Indian economy. With rate hikes in most developed economies, it might be almost sure that there will be a period of turmoil in the financial markets. As the global financial players adjust to the higher and high rates of interest, they would redraw their plans for deployment of funds. Generally, it can be fairly expected that some funds would be withdrawn from the emerging market economies and thus these markets should come under pressure. It is not as if we have not seen such concomitant instabilities in the financial markets when the developed economies make major adjustments

During the time of Ben Bernanke's so-called "taper tantrums" when after years of quantitative expansion to meet the after effect of the global financial meltdown, these measures were being reversed, emerging markets went through a period of severe storms. Many of these economies were facing serious balance of payments crisis, steep fall in their exchange rates and tanking stocks markets. This time around, the emerging markets might face some adverse winds. Those accustomed to steady flows from overseas will certainly face problems and insta-

India must ring fence itself from these adverse global head winds. The most likely intrusion of these would be through the financial markets. Already, the stock markets have turned extremely volatile and in step the foreign exchange rate is under pressure. The rupee

has lost ground against the US dollar. The RBI would have to tread a Tow that the Federal Re- cautious pathway. The Indian eqserve, European Central uity market has already been under events. The Hindenburg report on Adani Group has sparked off a downward cycle. The follow up demand of parliamentarians on the Adani Group has not helped sentiment. But, fortunately, the worst on this looks like being over and prices have been discounted.

The major banks' share prices had been affected in sync with the general global melt down in bank shares. But it should be clear the Indian banks are insulated from these global trends and appear well-capitalised. There is no immediate cause for fear about their prospects.

But, as many of the overseas institutional investors are doing some of their calculations, outflow of funds could be real. And that would mean a further fall in Indian rupee exchange rate. This could have a direct link with the price line as imported items, most importantly oil, could see some further rise. The silver lining is of course the price of oil itself. In the wake of the financial turmoil and bank failures, oil prices went down. International oil market experts are now almost certain that prices should see southward movement. Thus, despite exchange rate loss, domestic prices of oil need not be too volatile. But, general concern over inflation is still very strong. While like elsewhere in the world. India is also witnessing rising price line, the Reserve Bank should apply its judgement in embarking on fresh rate hikes. Consumer price inflation normally shows a spike in the summer months based on the prices of food

The emphasis on inflation containment should be more on supply management in our country than demand management through interest rate manipulation. That should encourage overall growth momentum of the economy than put a brake on economic activity.

Indian monetary policy has most often struck its own direction even when the world's leading central banks have pursued their own chosen track. All said, Indian economy is not as much integrated with the global one and can still remain insulated. This is what might be the lesson for now. (IPA Service)

China has to go beyond tokenism to ensure return of Rohingya to Myanmar

he lights are dim at the end of the tunnel in case of repatriation of Rohingya refugees living in squalid camps in the coastal district of Cox's Bazar in Bangladesh. The country hosts nearly 1.2 million Muslim Rohingya people who have fled ethno religious strife in neighbouring Myanmar during a military genocidal campaign, which killed at least 9,000 people in 2017.

The Tatmadaw (Myanmar military) backed campaign that the United Nations labelled a "textbook example of ethnic cleansing" saw hundreds of thousands of Rohingya driven across the border into Bangladesh in September 2017. More than a million refugees are crammed in tens of thousands of makeshift huts made of bamboo, thin plastic sheets and corrugated tin roofs and the living conditions in the nauseating camps are dangerous. Often, fires blaze through the camps leaving thousands without shelter. Last week, a 17member delegation from Myanmar's immigration and population ministries crossed into Bangladesh in mid-March and interviewed 480 Rohingya in Cox's Bazar as part of a plan for possible repatriation to their country. The Myanmar delegation, led by Aung Myo, the social welfare minister for Rakhine State, was selecting members for a pilot 'family-based repatriation' project.

The Myanmar delegation's visit to the camps is believed to be brokered by China and facilitated by the UNHCR.

The Refugee Relief And Repatriation Commissioner (RRRC) in Cox's Bazar, Mohammed Mizanur Rahman, said the Myanmar junta officials cleared 711 Rohingyas out of 1,140 recommended by Bangladesh. The newborn and newly married couples have been excluded from verification.

When journalists asked when the repatriation is expected to start, Rahman said that the "Myanmar delegation did not have the power to commit to a possible repatriation date." Before the visit of the delegation, the Myanmar junta for the first time since the 2017 crackdown, allowed diplomats from Bangladesh, India, China, and five other

countries to tour the restive Rakhine State. It was only then, the officials expressed the military junta's plan to begin Rohingya



repatriation under the pilot project.

Earlier, Bangladesh formally sought cooperation from China to repatriate Rohingya refugees to Myanmar during a visit by Foreign Minister Wang Yi and also China's State Councillor promised to resolve a political solution to the Rohingya crisis. China had used its influence in Myanmar to broker a November 2017 agreement to repatriate Rohingyas. China's ambassador to Bangladesh

would be repatriated to Myanmar soon while China continued its role as mediator, the official news agency Bangladesh Sangbad Sangstha reported. On 17 March 2023, Bangladesh Foreign Minister Dr AK Abdul Momen also urged the Organisation of Islamic Cooperation (OIC) member states to take collective

responsibility to ensure a safe and dignified

return of the most persecuted Rohingyas to

their homeland, Myanmar. Indeed, OIC backed Gambia to file a genocide case with the International Court of Justice (ICJ). Only Turkey has a visible presence at the Rohingya camps in Cox's Bazar. India also launched "Operation Insaniyat" to provide relief assistance in response to the humanitarian crisis faced by a

large influx of Rohingya refugees into

Bangladesh from Myanmar. Bangladesh and Myanmar began the negotiation for repatriation, but since 2018 none has returned so far and recent verification of a few hundred potential returnees for a pilot repatriation project remains unclear when they would be going home. Despite attempts to send them back, the refugees refused, fearing insecurity in Myanmar, which was exacerbated by the military takeover last year. Amid the situa-

The Rohingya issue must be addressed by China, a country [Myanmar] over which it has significant influence. Only China can make conclusive negotiations on the safe return of the Rohingyas, writes security analyst Samina Akhter in Modern Diplomacy.

Bangladesh and China have close political and military relations in addition to the fact that China is Bangladesh's top trading and development partner, Last week, Bangladesh has inaugurated a naval base in Cox's Bazar with two conventional diesel-electric powered refurbished Chinese submarines bought for \$205 million in 2016 to enhance Bangladesh's naval capacity, after the demarcation of its maritime boundary with India and Myanmar. It is equally true, that Myanmar's military junta, which took power in a coup two years ago, has demonstrated no intention to take back any refugees.

Most importantly, the Rohingya refugee groups based in Bangladesh said for sustainable and dignified repatriation will only be possible when the Myanmar regime recognises the Rohingya as an ethnic community; provide legal citizenship which was stripped in 1982; school education; healthcare services; freedom of movement and livelihood.

Rohingya's human rights groups believe the face-saving exercise to repatriate refugees happened after the Chinese exerted pressure on the Myanmar military junta to demonstrate a "feel good policy" otherwise face the compliance declared by the International Court of Justice (ICJ). The genocide case is resuming at ICJ on 24 April. "Taking back a few refugees, even if it is less than one percent of the population, shall allow Myanmar to come up with a counterargument under the very false pretence they are sincere about the return of refugees," the Arakan Rohingya National Alliance (ARNA) said in a statement. Arab plan for Syria puts Europe and America in a bind

The effort spearheaded by the United Arab Emirates, and supported by Saudi Arabia, Egypt, and Jordan, demonstrates that the expected restoration of diplomatic relations between the kingdom and the Islamic republic has done nothing to reduce geopolitical jockeying and rebuild trust. At best, the Chinese-mediated agreement establishes guardrails to prevent regional rivalries from spinning out of control, a principle of Chinese policy towards the Middle East.

The Saudi-Iran agreement also is an exercise in regime survival. It potentially allows the two countries to pursue their economic goals unfettered by regional tensions. For Saudi Arabia, that means diversification and restructuring of the kingdom's economy, while Iran seeks to offset the impact of harsh US sanctions. The goal of countering Iran in Syria is upfront in the Arab proposal for returning Syrian President Bashar al-Assad to the Arab and international fold.

If accepted by Syria, the United States, and Europe, it would initiate a political process that could produce a less sympathetic Syrian government to Iran. It would also establish an Arab military presence in Syria designed to prevent Iran from extending its influence under the guise of securing the return of refugees. For Al-Assad, the carrot is tens of billions of dollars needed to rebuild his war-ravaged country and alleviate the humanitarian fallout of last month's devastating earthquakes in northern Syria. Hampered by sanctions, Al-Assad's Russian and Iranian backers don't have the economic or political wherewithal to foot the bill.

Nevertheless, potential Gulf investment is likely to encounter obstacles. The US sanctions that hamper Russia and Iran, also erect barriers for Saudi Arabia and the UAE that will limit the degree to which they want to be seen as sanctions busters. Moreover, countering Iranian influence in Syria would have to go beyond trade and investment in physical reconstruction. Iran has over the years garnered substantial soft power by focusing on embedding itself in Syrian culture and education, providing social services, and reli-

gious proselytization. Meanwhile, China has made clear that its interests are

commercial and further limited to aspects of Syrian reconstruction that serve its geopolitical and geoeconomic goals. Al-Assad was in Moscow last week to discuss trade and humanitarian aid. The Syrian president's rejection of a Russian request that he meets his Turkish counterpart, Recep Tayyip Erdogan, suggests that Al-Assad will be equally opposed to key elements of the Arab proposal.

The Syrian president said he would only meet Erdogan once Turkey withdraws its troops from rebel-held areas of northern Syria. Even so, the Arab push potentially offers the United States and Europe the ability to strike a reasonable balance between their lofty moral, ethical, and human rights principles and the less savoury contingencies of realpolitik.

The terms of the Arab proposal to allow Syria back into the international fold after a decade of brutal civil war that killed some 600,000 people, displaced millions more, and significantly enhanced Iran's regional footprint appears to take that into account. While Al-Assad rejects the principle of political reform and the presence of more foreign troops on Syrian territory, legitimizing the regime of a man accused of war crimes, including using chemical weapons against civilians, is a hard pill to swallow for the United States and Europe.

However, it is easy to claim the moral high ground on the backs of thousands trying to pick up the pieces in the wake of the earthquakes. The same is true for the plight of the millions of refugees from the war whose presence in Turkey and elsewhere is increasingly precarious because of mounting anti-migrant sentiment. That is not to say that Al-Assad should go scot-free. Nonetheless, the failure to defeat the Syrian regime, after 12 years in which it brutally prosecuted a war with the backing of Russia and Iran, suggests the time has come to think out of the box. The alternative is maintaining a status quo that can claim the moral high ground but holds out no prospect of change or alleviation of the plight of millions of innocent people.

To be sure, morality is not a concern of Arab regimes seeking to bring Al-Assad in from the cold. However, countering Iran and managing regional conflicts to prevent them from spinning out of control is. Even so, the Arab proposition potentially opens a way out of a quagmire.

It would enhance the leverage of the United States and Europe to ensure that political reform is the cornerstone of Al-Assad's engagement with elements of the Syrian opposition. In other words, rather than rejecting any solution that does not involve Mr. Al-Assad's removal from power, the United States and Europe could lift sanctions contingent on agreement and implementation of reforms. Similarly, the US and Europe could make sanctions relief contingent on a safe, uninhibited, and orderly return of refugees.

However, there would be questions about the ability and willingness of Arab forces loyal to autocratic regimes to safeguard that process impartially.US and European engagement with Arab proponents of dealing with Al-Assad would potentially also give them a seat on a train that has already left the station despite their objections.

Ali Shamkani, the Iranian national security official who negotiated the deal with Saudi Arabia in Beijing, was in the UAE last week to meet President Mohammed bin Zayed. There is little doubt that Syria was on the two men's agenda Al-Assad met with Bin Zayed in Abu Dhabi for the second time in a year and travelled to Oman for talks with Sultan Haitham bin Tariq last month.

The Jordanian and Egyptian foreign ministers recently trekked separately to Damascus for the first time since the civil war in Syria erupted in 2011. Perhaps; the most fundamental obstacle to the Arab proposition is not the fact that Syria, the United States, and Europe would have to swallow bitter pills. The prime obstacle is likely to be the Arab proponents of the plan. The UAE, Saudi Arabia, Egypt, and Jordan are unlikely to stick to their guns in presenting the plan as a package. Having taken the lead in cozying up to Al-Assad, the UAE has since last year demonstrated that it is willing to coax the Syrian leader to back away from Iran at whatever cost to prospects for reform or alleviation of the plight of his victims.

Saudi Arabia, like Qatar and several other Arab countries, initially opposed reconciliation but the kingdom has since embraced the notion of rehabilitation of Al-Assad. In early March, Saudi Foreign Minister Faisal bin Farhan Al Saud noted "that there is a consensus building in the Arab world, that the status quo is not tenable. And that means we have to find a way to move beyond that status quo.'

Much of the Arab proposition is about enticing the United States and Europe to be more accommodating and more inclined to a conditioned lifting of sanctions. A speedy in principle US and European embrace of the Arab proposition would hold Emirati and Saudi feet to the fire and put Al-Assad on the back foot. (IPA Service)

n our ancient texts and writings, girls and women are placed on a high pedestal. They are worshipped as kanyas (girls), as grihalaxmi (wives), and as mothers. Our Vedic scriptures and hymns glorify the dignity of women. As quoted, where women are honoured, there the deities are pleased.

With a population of more than 1.3 billion people, India is a large and diverse nation. India's population is around 50% female, and women are very important to Indian society. Yet, depending on a variety of elements like social status, location, religion, and caste, being a woman in India might be very different from place to place. In India, awareness of the significance of women's rights and gender equality has grown in recent years. Women have achieved great advancements in fields like politics, healthcare, and education. Women in India still suffer a variety of difficulties, including prejudice, gender-based violence, and unequal access to opportunities and resources. A clear example of one such disparity is found in the field of access to organ transplantation.

The only treatment that can save the lives of patients with end-organ failure is transplantation. Access to this therapeutic option has always been restricted by the lack of available organs; hence, much research has been done on how to fairly allocate these priceless national resources; hence, much re-

search has been done on how to fairly allocate this priceless national resource. Regrettably, gender and sex-based inequities exist and have done so for many years despite the transplant community's knowledge of this injustice. Crucially, the unequal access to transplantation that women experience disproportionately has not been addressed by legislation or allocation policies. In addition, although they make up the majority of living kidney donors, women with renal disease are continuously less likely to be referred for transplant evaluation and subsequently less likely to receive a kidney transplant. According to a survey, all sexes had comparable reasons for donating organs, although women were noticeably more likely than men to do it for a relative.

Men and women may not have the same intentions when it comes to organ donation, so it is important to clarify these intentions with close family members. Among the pool of live and deceased organ donors, there are still gender differences. Women make up the majority of living organ donors (60%) but make up less than half of deceased organ donors (40%) as well. These gender disparities in organ donation have persisted for more than 25 years, and the incidence of donation refusal may have an impact. According to a 2013 study, 11.1% of family members who were considering refusing to donate a recently deceased person's organ actually did so. The majority of family memnation were women. This is problematic because sex disparities in organ donation contribute to sex mismatch in transplant recipients, which is associated with worse outcomes among transplant recipients. Women represent more than 40% of the candidates awaiting the many organs available through deceased organ donation. Thus, achieving an equitable gender distribution in the deceased donor pool is a priority. Understanding the reasons behind organ donor registration can contribute to strategies to diversify the donor pool. A 2014 study suggested that organ donors registered. Ethical Principles in the Allocation of Human Organs from the OPTN include "respect for persons," where programs must respect the decisions of potential donors and those that do not consent to donate, and transparency must be maintained throughout the process. In addition, international consensus was convened under the World Health Organization, which details "Guiding Principles on Human Organ Transplantation" that also share the necessity of consent to proceed with organ procurement. Improved public dissemination of these ethical policies may restore trust in the medical system. Implementation studies led by patient stakeholders may be an appropriate next step toward achieving equity in donor registration by sex. (Erika Yee et al). A total of 557 kidney transplants were analyzed, with women having 78.5% higher in-

bers that refused donation for cadaveric do-

cidence of donation (P < .001). Among them, parents (72.20% mothers), spouses (87.20% wives), siblings (47.50% sisters), and children (44.44% daughters) were the major participants. In India, the data from National Organ & Tissue Transplant Organization (NOTTO) for 2019 reveal that there was 12625 total organ transplants out of which 72.4% recipients were men. Among the living organ recipients in the previous year 70.6% were men. In a study done in Gujarat at IKDRC among couples,90% donors were female-the ratio was 78% for grandparents' donors and 75% for parents. It has been a socio-economic issue that has continued for the past several decades.

In India, I feel there is a great need to create a gender-neutral society. Although the goal is far away but our persistent efforts in increasing awareness regarding living or deceased organ donation, creating a gender-neutral status will be rewarding and will increase our donor pool. Also, we need to emphasize the concept of age matched, gender matched donation as the best for the organ recipient and transplant outcomes. A society only gets respect where all individuals are treated as equal although I might sound utopian but a small step by each of us including government & law makers along with public participation might help achieve a respectful place for all citizens. ver 55 million people globally have dementia. By 2050, this figure is expected to increase to 139 million people. Studies have suggested a link between bone mineral density and dementia. While it remains unknown whether the two are causally linked, bone mineral density is an important predictor of fracture, which can lead to loss of independence among those with dementia.

Knowing more about the extent to which bone loss exists before dementia onset could aid the development of preventive strategies that optimize the health and care of dementia patients. Recently, researchers examined the link between bone mineral density and dementia incidence. They found that people with low bone mineral density were more likely to develop dementia. The study appears in Neurology, the medical journal of the American Academy of Neurology.

Poor bone health linked to higher dementia risk

For the study, the researchers examined healthcare data from 3, 651 dementia-free participants who underwent X-rays to assess their bone health between 2002 and 2005.

The researchers also included demographic data in their analysis, including education level, smoking status, cholesterol levels, risk of comorbidities, and genetic risk data, among others.

Patients were around 72 years old on average, and 57.9% were women. They were followed for around 11 years.

During the follow-up, 18.8% of participants developed dementia, of whom 76.7% developed Alzheimer's disease.

They noted, however, that their findings contrast earlier research as they do not support a link between dementia risk and lumbar spine bone mineral density — the five bones in the lower spine.

Also, contrasting prior studies, they found that low bone mineral density increased dementia risk in males but not females.

How bone density affects brain health

When asked what might explain the link between low bone density and dementia risk, Dr. Nahid Rianon, professor of family medicine with McGovern Medical School at UTHealth Houston, not involved in the study, told Medical News Today:

Dr. Robert Wiggins, a neurologist at Novant Health, also not involved in the study, agreed that it is difficult to know how bone density may be linked to dementia. Dr. Wiggins said:

"Bone and brain health are both dependent on a complex interaction between hormonal, nutritional, genetic, and other external, environmental factors. What we know though, is that things like a nutritious diet and active lifestyle will lead to both improved bone and brain health. Future research will investigate whether there is something inherent about low bone density that causes the increased dementia risk. or if a factor common to both bone and brain health is causing this as-

Dr. Andrew Evans, a neurologist with Novant Health, not involved in the study, also told MNT that low bone density and dementia may occur coincidentally from common causes. Dr. Evans noted:

"Both low bone density and dementia can be influenced by diet and exercise. With dementia, it is proven that these activities and behaviors can effect our cognitive health. Similarly, a person with poor nutrition and exercise habits may have lower bone density.'

Study limitations and implications

Dr. Wiggins said that as most of the patients included in this study were in their 70s and of European descent, they may not apply to other populations, even though other studies have described similar associations. "Given this study shows only an association between bone and brain health, we have to be careful not to assume that decreased bone density itself causes dementia," he noted.

"The implications of this study are that people who have low bone density may be at higher risk for developing dementia. This study adds to the compelling body of research that suggests that maintaining bone health integrity is an important part of success aging," Dr. Sullivan noted. "Evidence-based strategies for optimizing bone health after age 50 include prioritizing high-quality animal/plant protein, polyunsaturated fatty acids, fruits and vegetables high in potassium, fiber, and foods high in calcium and vitamin D having the most research support. Weight-loading and resistance exercises on a regular basis are also needed to keep bones strong and healthy as we grow older," she concluded. (Courtesy: MNT)

Heart treatment: Alternative to stents

n the recent days a lot of doubts have been created about stents excessive cost, unnecessary use and dubious quality. More than 6 Llacs stents have been implanted in the year 2021 netting a Rs. 6000 crores extra/ill gotten money to the cardiologists and heart Hospitals. The excess of anything ultimately gets caught. The Government took a decision to reduce the cost of stents by 85%. Even after this it will still make money for the heart hospitals. The basic question that remains still now is- were these stents needed? Is this a only way to treat heart patients? Why the number of heart disease patients increasing? What may the more appropriate treatment of heart disease?

'I love sleep. My life has the tendency to fall apart when I'm awake, you know.' This quote is popularly attributed to novelist Ernest Hemingway.

Did he actually say it? We don't know. What we do know is that we become irritable and crabby

and impatient when we do not sleep enough. Or if we spend the night in disturbed sleep.

What you need to know about sleep? For centuries after human life originated on earth, our living pattern was dependent on the environment around

Have you heard about the Circadian rhythm? It's the 24 hour internal clock in our brain that regulates alertness and sleep as per the changes in the environment around us.

Our brain is tuned to rest when it is dark and remain alert when there is light.

Forcibly altering this sleep cycle does not agree with various internal functions of the body, which can lead to numerous health issues. Inadequate sleep at night can leave one feeling sleepy

during the day. This leads to lack of concentration at work, feeling tired easily, judgement errors, etc.

In the long term it may lead, among other health issues, to diabetes, hypertension, obesity, depression and coronary artery disease.

One should try to find out the possible reason/s for not able to sleep and correct them rather than take sleeping

If you are suffering from insomnia, please talk to your health care provider and discuss your sleep-related issues. The health care provider will prescribe a sleeping pill only if she or he feels it is absolutely necessary. How much sleep do you need?

Ideally, go to sleep at around 10 pm and say good morning to the world at around 5 am or 6 am.

If you follow this pattern, your deepest sleep will be around 2 am to 4 am.

You need eight to 10 hours of healthy sleep every night. Otherwise, your life and heart tend to fall apart.

Chronic sleep deprivation can wreak havoc on the mental and physical well-being of a person.

Why are we not able to sleep? Well, much of this damage is self-inflicted.

So much so that what we call the teenage syndrome -including the moodiness, the constant battles and the reckless, impulsive and careless behaviour -- may have a lot to do with not getting enough sleep at night.

Some believe that variations of such behavioural patterns caused by lack of or inadequate sleep are visible all the way upto 45 years of age, when the onset of an illness demands course correction.

Self-inflicted bad habits Here are a few self-defeating habits across age groups that you can begin correcting right away.

1. Social jetlag: Most parents believe that going to bed and waking up late on the weekends is no big deal for adolescents, as long as they get enough sleep during that time. This goes against the body's natural clock and is one

Parents themselves are guilty of imagining themselves

to be superheroes, partying late at night and then sleeping it off during the daytime.

2. Blue light syndrome: Use of mobile/laptops late at night causes exposure to blue light which restrains the production of melatonin (a hormone that controls the sleepwake cycle).

This makes it difficult to fall asleep.

3. Late night eating: Staying awake late at night, for whatever reason, disrupts your eating pattern.

Untimely dinners or eating too much during dinner can make you physically uncomfortable while lying down, which may keep you awake.

4. Late night caffeine: Drinking excessive caffeinated drinks late in the afternoon or in the evening can keep you from falling asleep at night. 5. The alcohol/smoking myth: Many people argue that

alcohol helps them fall asleep. Nothing could be further from the truth. Others believe that smoking makes them eat less.

What both actually do is prevent deeper stages of sleep. They often disturb your sleep and cause you to awaken in the middle of the night.

There's no two ways about it: Alcohol consumption and smoking are bad for you. All of these are self-inflicted bad habits.

They are not the result of work-related activities like working in shifts or having to adjust working with colleagues in different time zones. Nor are they caused but the stress inflicted by natural calamities.

In short, they are habits that can be avoided.

Habits you can change Once these habits are ingrained in your system, there is

only one way to get rid of them. You have to decide to break them and you have to be determined that you are ogist. (Courtesy: Rediff.com)

People with certain health conditions never take a step back from the rituals and take part in the Navratri Vrat the same way as others. But we must know that conditions like diabetes can be challenging to manage while fasting. Here are a few easy and quick recipes along with a few tips to keep your health in check. **Navratri Fasting Tips for Diabetics**

eat certain foods, make sure to eat every 2-3 hours instead of taking three 2. Plan your diet with a mix of fats, carbs and protein so that you have the required energy during the entire day. Do not have high carbs diet

1. Don't stay hungry for too long. Since Navratri fasting allows you to

since it can lead to spike in sugar levels and unwanted weight gain. 3. Stay hydrated during the day, Unlike the Ramadan fast, Navratri fast does not require abstaining from liquids. Thus, drink enough water, fruit nices, coconut water and stay away from caffeinated drinks like tea.

4. Use healthy methods of cooking like baking, grilling, air frying, sautéing instead of deep frying or using lots of oil in making Tikkis or

5. Keep testing your glucose levels more often than you usually do since fasting may result in low glucose levels. Take your insulin and medications in time. Discuss the precautions and plan of action with your doctor in advance.

6. In case of feeling dizzy, disoriented or sweaty, break your fast immediately. Consume glucose tablets, sugary things followed by a meal like a sandwich or a bowl of cereals.

Navratri Fasting Recipes for Diabetic Patients

1. Roasted Makhanas or foxnuts are the healthiest snacks for the people observing Navratri fast. They are low in calories and you can always roast some peanuts along with them in a tablespoon of ghee and add the vrat

2. Makhana kheer is another recipe that can be consumed during the Navratri fast and is healthy for you. You can boil milk and add your roasted makhanas along with handful of dry fruits like cashews, almonds, raisins, etc. Avoid adding sugar. You can enjoy it warm or after it cools down as a dessert.

3. Apple smoothie is another good option for Navratri breakfast or snack options. It is rich in calcium, vitamin-A, vitamin-C, protein, antioxidants, potassium, fiber, and iron. You can blend the fruit with milk, yogurt, cinnamon, ice cubes, and dry fruits.

4. Sabudana Khichdi is a great option for the Navratri meal at night. You will have to mix the overnight soaked and drained sabudana, peanuts, salt, and chilli powder such that the tapioca pearls are coated with the masalas. Heat the ghee, add cumin seeds, red chilli, and curry leaves in the pan, add the Sabudana mixture and let the mixture stay for a bit on the low flame. You can also add lemon juice, and peanuts with coriander leaves and green chillies.

Ukraine official: Putin taking Belarus as 'nuclear hostage'



KYIV, March 26 (AP): Ukraine's top security official on Sunday denounced the Kremlin's plans to station tactical atomic weapons in Belarus, saying that Russia was taking its ally as a "nuclear hostage." But Moscow said it was making the move in response to the West's increasing military support for Ukraine. Russian President Vladimir Putin announced the plan in a television interview that aired on Saturday, saying it was triggered by a UK decision this past week to provide Ukraine with armour-piercing rounds containing depleted uranium. Putin argued that by deploying its tactical nuclear weapons in Belarus, Russia was following the lead of the United States. He noted that Washington has nuclear weapons based in Belgium, Germany, Italy, the

Netherlands and Turkey. "We are doing what they have been doing for decades, stationing them in certain allied countries, preparing the launch platforms and

training their crews," he said. Oleksiy Danilov, the secretary of Ukraine's National Security and Defense Council, tweeted Sunday that Putin's announcement was "a step towards internal destabilisation" of Belarus that maximized "the level of negative perception

Putin in Belarusian society.

The Kremlin, Danilov added, 'took Belarus as a nuclear hostage.' On Saturday, Putin argued that Belarusian President Alexander Lukashenko has long asked to have nuclear weapons in his country again to counter NATO. Belarus shares borders with three NATO members — Latvia, Lithuania and Poland — and Russia used Belarusian territory as a staging ground to send troops into neighboring Ukraine on February 24, 2022.

Both Lukashenko's support of

the war and Putin's plans to station tactical nuclear weapons in Belarus has been denounced by the Belarusian opposition. Tactical nuclear weapons are intended for use on the battlefield and have a short range and a low yield compared with much more powerful nuclear warheads fitted to long-range missiles. Russia plans to maintain control over the ones it sends to Belarus, and construction of storage facilities for them will be completed by July 1, Putin said. Russia has stored its tactical nuclear weapons at dedicated depots on its territory, and moving part of the arsenal to a storage facility in Belarus would up the ante in the Ukrainian conflict by placing them closer to Russian aircraft

in Washington; Secret Service, police foil their bid WASHINGTON, March 26 (PTI): A group of Khalistan supporters held a protest in front of the

Indian Embassy here and tried to incite violence and even threatened the country's envoy, but timely intervention by law enforcement agencies prevented them from vandalising the property.

The protesters also verbally intimidated and physically assaulted the PTI journalist covering the event on Saturday.

Separatist Sikhs hurled abusive language and openly threatened Indian Ambassador to the US, Taranjit Singh Sandhu. Sandhu was not in the embassy at the time of the

In their speeches, most of the protestors were seen trying to incite violence not only in India but here as well, including physical damage to the Indian Embassy

Some of the speakers were seen inciting fellow protestors to indulge in violence and break the windows and glasses of the building across the road.

Sensing that things might go out of control, the US Secret Service and the local police quickly brought in reinforcements and more forces were deployed in the area. At least three police vans were placed in front of the Em-

At one point, five protesters quickly crossed the road and were about to break into the temporary marker of the embassy property near the pole unfurling the tricolour before they were asked to

Secret Service personnel, who were closely watching this, in no time rushed to the spot and asked the protesters to go back to the designated protest area, before any untoward incident could happen.

It appeared that the protesters and missiles already stationed there. came prepared to do something



similar like damaging Indian properties at the Indian Consulate in San Francisco and the Indian High Commission in London.

After the attack on the Indian consulate in San Francisco by pro-Khalistan protesters last Sunday, India registered its "strong protest" with the US Charge d'Affaires in New Delhi over the incident and asked the American government to take appropriate measures to prevent the recurrence of such inci-

During the protest by Khalistan supporters at the Indian Embassy in Washington, Lalit K Jha - the US correspondent of the Press Trust of India - saw separatists bringing two bundles of wooden sticks that were kept in the park that has the statue of Mahatma Gandhi in front of the embassy.

The wooden sticks were similar to those which were used to break the door and windows and smash the glasses of the Indian Consulate in San Francisco. While one bundle was used to display the separatist flag, the other bundle of about 20 sticks was kept aside.

Organisers of the protest had a very hostile approach towards the

They not only obstructed this reporter by coming in front of the camera and placing the Khalistan flag on his face, kept pushing him, but also threatened dire conse-

Khalistan supporters try to incite violence at Indian Embassy

The reporter, apprehending physical harm, called 911 and ran towards the other side of the road for safety, looking for a police van. One of the protesters abused the reporter and was asking questions like you have to tell me what are

you going to report? The organiser backed off as the reporter complained to the police about the potentially harmful activities of the protesters.

Sometime later, two of the protesters came towards the reporters, who were standing near the Secret Service personnel. One of them told the Secret Service that the reporter be asked to leave "my land" which is federal property.

They warned that if there is any violence and the reporter is physically harmed, they should not be blamed for this. Immediately the other protesters hurled abuse against the reporter, used unparliamentary words, and moved the two Khalistan flags that he had in his Indian mission said in a statement.

hit the reporter's left ear with a

The Secret Service personnel asked the reporter if he was ok and if he wanted to lodge a complaint. The journalist said he did not intend to lodge a complaint.

The Secret Service warned the protester that this should not be repeated, and sought additional reinforcement from police personnel.

The law enforcement official told the protestors that this was public land, and the reporter was all within his right to stand there and cover their protest.

In their speeches, the protesters repeatedly pointed fingers towards the two reporters and used abusive words against them.

While they prevented the journalists from doing their work, a group of protesters filmed the reporter covering their protest, took pictures and asked provocative questions. The separatists left the area around after 3 pm and one of them was seen keeping the bundle of wooden sticks in the trunk of the

tweeted.

"We have seen disturbing visuals of a senior Indian journalist from the Press Trust of India being abused, threatened & assaulted physically while covering the socalled 'Khalistan protest' in Washington DC earlier today," the

"We understand that the journalist was first verbally intimidated, then physically assaulted, and fearing for his personal safety and well-being, had to call in law enforcement agencies, who responded promptly," the statement

The mission said it condemns such a grave and unwarranted attack on a senior journalist.

"Such activities only underscore the violent and antisocial tendencies of the so-called 'Khalistani protestors' and their supporters, who routinely engage in wanton violence and vandalism," it said.

It thanked the law enforcement agencies for their prompt response in the matter.

"This violence against @lalitkjha is outrageous and an assault on journalism. I condemn it in the strongest terms. Lalit is one of the fairest and most thoughtful journalists. Thank you to our security for protecting Lalit and the diplomats and consulate," prominent Indian-American Congressman Ro Khanna tweeted

Ajay Bhutoria, a community leader, also condemned the attack on the journalist.

"I condemn in the strongest terms the violence against senior journalist Lalit Jha. It is an outrageous assault on journalism, and we stand in solidarity with him during this difficult time," he said.

"Lalit ji is known for his fair and thoughtful reporting and has contributed significantly to the field of journalism and connecting and deepening the US-India relation-

He thanked the security personnel for their efforts in protecting the Indian journalist as the diplomats and consulate.

Imran Khan unveils 10-point roadmap to revive cash-strapped Pakistan

LAHORE, March 26 (PTI): Pakistan's ousted Prime Minister Imran Khan held a massive rally here on Sunday and presented his party's 10point roadmap for the cash-strapped country's economic recovery, including sops for the diaspora. Addressing the public rally at Minar-i-Pakistan in the early hours of Sunday, the Pakistan Tehreek-e-Insaf (PTI) chairman challenged the country's ruling party to put forward a plan to rescue Pakistan from the many crises it finds itself mired in.

"I challenge that the incumbent rulers don't have the ability or the intention [to save the country]," he said. Khan, 70, said he would happily step aside if the establishment tells him they have a plan. "I know what the programme is...there is no programme," he was quoted as saying by the

Announcing the 10-point programme, Khan said that overseas Pakistanis will be motivated to invest in Pakistan to attract foreign direct investments to avoid going to the IMF again and again. "We will facilitate all those who would export and bring dollars into the country," he added. Pakistan, which is in dire need of funds as it battles a wrenching economic crisis, has received economic assistance from the IMF in the past. The country is in discussions with a global lender to resume its loan programme.

Khan asserted that the country needs to take difficult decisions to improve its tax collections and exports.

"A major surgery is needed to put our house in order. Overseas Pakistanis will bring their dollars to the country provided they are given incentives," he said, adding that only 2.5 million Pakistanis out of 220 million pay taxes.

"There is a need to increase the tax base to achieve progress," he said and also proposed giving loans to young people to start businesses and reviving the mortgage scheme.

Khan said his government would promote tourism, adding that the minerals sector would be focused on generating revenue.

The ex-premier said after coming to power his government would increase agriculture produc-



tivity with the cooperation of China.

The government would take measures to stop money laundering, he said, adding that the current account deficit would be curtailed as well. Khan, who is facing threats to his life, ad-

dressed the rally from a bullet-proof glass container. Pakistan's broadcast media blacked out the coverage of the event under the 'pressure' of the PML-N-led government backed by the powerful military establishment.

The authorities appeared so desperate to fail the Khan's power show that all major roads leading to Minar-i-Pakistan were blocked by police with containers and barricades.

The internet services were snapped in parts of Lahore, especially at the rally site.

The people reached the venue on foot after covering long distances.

Lashing out at the PML-N-led government and its handlers (a reference to the military establishment) for arresting and torturing over 2,000 of his party workers ahead of this rally, Khan said, "one thing is clear, whoever is in power, they will get a message today that people's passion cannot be curbed via hurdles and

"The way the powerful circles are behaving in Pakistan today it seems that Imran Khan is the only problem of the country," he said.

Khan said a cabal of thieves was imposed on the nation after the toppling of his government

"I have completed a century of cases. I may cross 150. Poor spend their entire lives fighting

false cases in this country. Pakistan has no future if there is no rule of law," he said and added that 'real freedom' will only come if rule of law prevails in the country.

He slammed Prime Minister Shehbaz Sharif for begging around the world but still failing to

Taking a jibe at Prime Minister Shehbaz, Khan said: "Former army chief Gen Qamar Javed Bajwa said he used to scold Shehbaz for 40 minutes and he would not react and listen patiently. This happens when you (Shehbaz) come to power through the backdoor".

The cricketer-turned-politician said for the first time in his life he felt what the people in Palestine feel

"Police attacked my house as they wanted to arrest me in false cases. The people supported me during the clash with the police as they knew I was right. They have booked me in 40 terrorism cases...will the nation accept that Imran Khan is a terrorist?" he asked.

He said despite Supreme Court's orders, the Election Commission of Pakistan delayed the April 30 elections of the Punjab Assembly for October 8 on the pretext of security and financial constraints.

"Who will guarantee that the elections will be held even in October? The government and its handlers have only one-point agenda - how to stop me from returning to power," he said.

Khan said all eyes were on the Supreme Court to establish rule of law by holding elections in Punjab and Khyber Pakhtunkhwa in 90 days Earlier on Saturday, the Lahore ATC granted Khan interim bail till April 4 in three cases filed

Khan has been in the dock for buying gifts, including an expensive Graff wristwatch, which he had received as the premier at a discounted price from the state depository called Toshakhana, and selling them for profit.

BERLIN, March 26 (AP): An increased number of travellers in Germany boarded trains and planes on Sunday, a day before a major one-day strike that aims to bring the country's transportation system to a standstill. But even advance travel was met with disruption in some places as Munich airport already shut down because of the impending strike on Monday, and technical problems affecting German airline Lufthansa in Frankfurt led to flight delays and cancellations at the country's biggest airport. Munich Airport, the country's second-busiest, said that the ver.di union was hitting it with two days of strikes and it has no regular passenger or cargo flights on either Sunday or Monday. A total of around 1,500 connections were affected, and takeoffs and landings were only possible for emergency humanitarian flights, German news agency dpa reported. Hindus among healthiest, Sikhs most likely to own homes: UK census data shows

dus living in the UK are among the healthiest and well qualified religious groups and Sikhs are most likely to own their homes, according to latest census data for England and Wales.

The UK's Office for National Statistics (ONS) has been analysing census statistics to release information across various subcategories for the country's population based on the responses of the online census conducted in March 2021.

In its latest release entitled 'Religion by housing, health, employment and education' this week, the ONS finds that life outcomes for religious groups varied consider-

"In 2021, those who identified as 'Hindu' had the highest percentage of their population reporting either 'very good' or 'good' health 82.0 per cent of the overall population," the ONS finds, adding that the Hindus also reported the "lowest prevalence of disability"

"People who identified as 'Hindu' had the highest percentage with a 'Level 4 or above' [certificate-level] qualification (54.8 per cent), compared with the overall population (33.8 per cent)," it noted. "People who identified as 'Sikh' were more likely to live in households that owned their home... 77.7 per cent of those who identified as 'Sikh' lived in households that owned their home," the ONS said. The religion question is voluntary in the census and in 2021, 94 per cent of the overall population in England and Wales of 56 million chose to answer the

The ONS said that many of the life outcomes discussed in its analysis may be influenced by the differing age and sex profiles of religious groups "In 2021, people who identified

as 'Muslim' were nearly four times more likely to live in overcrowded homes than the overall population of England and Wales," the statistics show.

"In 2021, people who identified as 'Muslim' had the lowest percentage of people aged 16 to 64 years in employment (51.4 per cent compared with 70.9 per cent of the overall population); this resulted from the high percentages of people who were students or looking after home or family in this group," it said.

The ONS pointed out that life outcomes for religious groups often overlap, as people in poor health or caring for others may be less able to work or gain education. Income, where people live, and cultural background, also have an influence on outcomes. The analysis reveals that those who identified as "Christian" had

an older age profile and reported poorer health than the overall pop-"People who identified as 'Christian' were most likely to live



Israel's defence minister calls govt to halt 'judicial reforms' in big jolt to Netanyahu JERUSALEM, March 26 (PTI):

Israeli defence minister Yoav Gal-

lant has called upon the government

to stop the controversial judicial

overhaul legislation that has

sparked protests across the country, sticking his neck out amid Prime Minister Benjamin Netanyahu's insistence to go ahead with the proposed "reforms". His intervention came as Israelis opposed to the changes held mass rallies across the country for the twelfth week in a row. "The security of the State of Israel is my life's mission. Over the course of my entire adult life, I have dealt with Israel's security day in and day out," Gallant, Netanyahu's close aide, said on Saturday. He said that he still supported the need to revamp the court system, but acknowledged that "unprecedented feelings of anger, pain and disappointment have risen" within the military over the proposed changes to Israel's balance of power. The revamp includes enabling Parliament to overrule decisions made by the Supreme Court - a move that critics say will undermine the independence of the judiciary and could be used for political ends. "Clothed in the IDF's (Israel Defence Forces) uniform, I have risked my life dozens of times for the State of Israel. And at this time, for the sake of our country, I am willing to take any risk and pay any price," Gallant said in a televised speech. "I declare loudly and publicly, for the sake of Israel's security, for the sake of our sons and daughters – the legislative process should be stopped," he asserted, pointing to the visible diminishing morale of the Army he could sense that is endangering Israel's security and unity.

India summons Canadian envoy over Khalistan protests



NEW DELHI, March 26 (PTI): India has summoned Canadian high commissioner Cameron MacKay and conveyed its strong concerns about the actions by pro-Khalistani extremist elements against its diplomatic missions in Canada recently

MacKay was summoned by the external affairs ministry on Saturday and sought an explanation on how "separatist and extremist elements" were allowed to breach the security of its diplomatic mission and consulates despite the presence of police, the Ministry of External Affairs said in a statement.

On Sunday last, India's high commissioner to Canada Sanjay Kumar Verma was forced to skip an event in British Columbia province after a violent protest by Khalistan supporters.

Indian-origin journalist Sameer Kaushal, who was at the venue to cover the protest, was also as-

Canada was reminded of its obligations under the Vienna Convention and asked to arrest and prosecute the individuals who have already been identified as being involved in such acts, the ministry

It said it expected the Canadian government to take all steps needed to ensure security of its diplomatic premises and the safety of its diplomats so that they are able to fulfil their normal diplomatic functions.

Canada has seen a rise in anti-India activities recently by Khalissupporters who have vandalised some Hindu temples.

Earlier this month, pro-Khalistan supporters had attacked the Indian High Commission in London and vandalised the Indian consulate in San Francisco.

The external affairs ministry had summoned the Charge d'affaires of Britain and the US to voice strong protests against the developments

Cong's Priyanka Gandhi Vadra takes charge of Sankalp Satyagraha

NEW DELHI, March 26 (PTI): Congress general secretary Priyanka Gandhi Vadra on Sunday said a martyred Prime Minister's son who walked thousands of kilometres for national unity can never insult the country as the Congress held a nationwide protest against the disqualification of Rahul Gandhi from the Lok Sabha

Priyanka Gandhi was addressing the 'Sankalp Satyagraha' at Rajghat -- the memorial of Mahatma Gandhi -- here to protest against Rahul Gandhi's conviction in a 2019 defamation case and his subsequent disqualification from the Lok Sabha.

She said the time had come to raise a voice against an "arrogant government" as barring Rahul Gandhi from contesting elections does not bode well for the country and its democracy.

The Congress has launched a day-long satyagraha at all states and district headquarters to protest against Gandhi's conviction in a 2019 defamation case and his subsequent disqualification from the Lok Sabha.

Gandhi was disqualified from the Lok Sabha on Friday, a day after a court in Gujarat's Surat convicted him in the defamation case. The disqualification will prevent Gandhi (52), a four-time MP, from contesting elections for eight years unless a higher court stays the conviction.

The Congress leader alleged that Rahul Gandhi was disqualified for questioning the prime minister on industrialist Gautam Adani and people will give a befitting reply to those behind the action

"My family's blood has nurtured democracy in this country. We are ready to do any-



thing for this country's democracy. Great leaders of the Congress laid the foundation of democracy in this country. If they think they can scare us, they are wrong. We will not be scared.

"Time has come and we are not the ones who will remain silent anymore," she told the outside Rajghat.

Asking if a martyred prime minister's son can insult the country, Priyanka Gandhi said, "This is an insult to that prime minister who gave his life."

"You have called a martyr's son anti-national, Mir Jafar, insulted his mother in Parliament. The Prime Minister in Parliament asks why this family does not use the 'Nehru' surname. You insult the entire family and the case against you. You don't get a case or a two-year term and no one disqualifies you. Why?" she asked.

Priyanka Gandhi said till today, they have been insulting "our family and we remained silent but not anymore"

"How much will you insult one person?" she said and asked if Lord Ram, who was sent into exile, was a "parivaarwadi".

The Congress leader, who alleged that the country's wealth was being looted and given to one person, said this wealth belongs to the people and no one can take it away.

"When arrogant dictators are unable to answer the questions raised, they try to suppress those who ask the questions.

This entire Cabinet, government and MPs are trying to save one person and are not holding an inquiry. Who is this Adani in whose support everyone comes the moment

his name crops up?" she asked. Questioning if this was the "mother of democracy", she asked why people are still unemployed if the economy is doing so well.

Noting that lakhs of people joined Rahul Gandhi on his Bharat Jodo Yatra when he walked from Kanyakumari to Kashmir, Priyanka Gandhi said, "When a person who walks from Kanyakumari to Kashmir to unite the country, can this person insult the country?'

Coming out in support of her brother, she asserted that Rahul Gandhi wants the poor. youth and the women to get their rights and what belongs to them should go into their hands and not to someone who is a big man and the Prime Minister's "friend".

She said Rahul Gandhi studied at Harvard and Cambridge -- the best universities in the world -- but still they call him a "Pappu".

"When they came to know that he is not Pappu and lakhs of people are walking with him, they got disturbed over the questions he raised in Parliament to which they don't have answers. They have to do all this to stop just one person.

This country's Prime Minister is a coward. Take me to jail but the truth is this country's Prime Minister is a coward. He is hiding behind his power and (he) is arrogant. But this country's tradition is that people reply to an arrogant king. This country recognises an arrogant king. This country knows the truth," she said.

Centre notifies revised MGNREGA wage rates

The wage hikes, which range from ₹7 to ₹26, will come into effect from April 1

NEW DELHI, March 26 (PTI): The Centre has notified a hike in wage rates under the rural job guarantee programme for the 2023-24 financial year with Haryana having the highest daily wage at ₹ 357 per day and Madhya Pradesh and Chhattisgarh the lowest at ₹ 221.

The union ministry of rural development issued a notification on the change in wage rates under the Mahatma Gandhi National Rural Employment Guarantee Scheme on March 24.

The notification was issued under Section 6 (1) of the Mahatma Gandhi National Rural Em-Guarantee plovment Act (MGNREGA), 2005, that says the Centre may, by notification, specify the wage rate for its beneficiar-

The wage hikes, which range from ₹7 to ₹26, will come into effect from April 1.

Compared to last year's rates, Rajasthan registered the highest percentage increase in wages. The revised wage for Rajasthan is ₹ 255 per day, up from ₹ 231 in



Bihar and Jharkhand have registered a percentage increase of around eight from last year. Last year, the daily wage for a MN-REGA worker in these two states was ₹210. It has now been revised

For Chhattisgarh and Madhya Pradesh, which have the lowest daily wages at ₹ 221, the percentage increase from last year was recorded at 17. In 2022-23, the two states had a

daily wage of ₹ 204.

UP police reaches Sabarmati jail Atiq Ahmed to Prayagraj for court order

AHMEDABAD, March 26 (PTI): A team of the Uttar Pradesh police reached Sabarmati central jail in Gujarat's Ahmedabad on Sunday to take gangster-turned-politician Atiq Ahmed to Prayagraj, where he will be produced before a court that is scheduled to pass an order on Tuesday in a kidnapping case in which he is an accused, officials said.

Ahmed, a former Samajwadi Party leader, has been lodged in Sabarmati jail since June 2019 where he was shifted from his home state as per the Supreme Court orders in April that year,

"A team of police from Prayagraj is at the Sabarmati jail to take Atiq Ahmed to their state, where he will be produced in a court. Formalities for the same are underway," Superintendent of Police (Sabarmati jail) JS Chavda said.

A court in Prayagraj has set March 28 as the date to pass its order in a kidnapping case in which Ahmed is an accused, Prayagraj Police Commissioner Ramit Sharma said in the Uttar Pradesh city. Sharma said that a team of the Prayagraj police was sent to bring Ahmed and produce him to the court there on

the given date. "As part of the procedure, all the accused are to be produced before the court on the date of the judgment and then sent back to their respective jails. A team of police has been sent to Sabarmati jail for mafia Atiq Ahmed as he has to be produced in the court on the given date," the police officer said

Atiq has been lodged in Sabarmati jail since June 2019 after the Supreme Court had in April that year directed that the former MP from Phulpur in UP be shifted to a high-security jail in Gujarat after he was accused of orchestrating the kidnapping and assault of a real estate businessman Mohit Jaiswal while in jail. He is named in more than 100 criminal cases, including the recent Umesh Pal murder case, police said.

Assess reason for candidates low turnout: Parl Panel to UPSC

15 months long recruitment process wastes candidates 'prime years' besides taking a heavy toll on their physical and mental health

NEW DELHI, March 26 (PTI): As- ceed six months as long and proserting that the nearly 15 months long recruitment process wastes candidates' prime years besides taking a heavy toll on their physical and mental health, a Parliamentary Committee has asked the UPSC to reduce the civil services examination's selection cycle. In its latest report, the panel also asked the Union Public Service Commission to examine the reasons for the low turnout of candidates in the civil services examination.

The examination is conducted annually by the UPSC in three stages -preliminary, main and interview -- to select officers of the Indian Administrative Service (IAS), Indian Foreign Service (IFS) and Indian Police Service (IPS) among others. The Department-related Parliamen-

tary Standing Committee on Personnel, Public Grievances, Law and Justice said according to the data provided by the UPSC, the average time taken for civil services examination from the date of issue of notification to the date of declaration of the final result is nearly 15 months.


"The Committee is of the opinion that the duration of any recruitment examination should not ordinarily ex-

tracted recruitment cycles waste prime years of a candidates' life besides taking a heavy toll on their physical and mental health. The Committee, accordingly, recommends that UPSC should take steps to reduce the duration of the recruitment cycle significantly without compromising the quality," the report said. On the low turnout, it said out of approximately, 32.39 lakh candidates who had applied for examinations conducted by UPSC in 2022-23, only 16.82 lakh candidates, (51.95 per cent) actually appeared for examinations. For instance, 11.35 lakh candidates applied for the civil services examination in 2022 but only 5.73 lakh candidates (50.51 per cent) actually appeared for the examination. The Committee recommended

UPSC furnish the details of examination fees collected from the candidates during the last five years.

"The Commission may also provide the details of expenditure incurred by it on the conduct of the examinations for the same period. The Committee also recommends UPSC to examine the reasons for low turnout of candidates and share the findings



"This practice not only demoralises the candidates but also compromises the validity and fairness of the examination process. Although recruiting agencies exercise utmost caution to ensure that the answer key is foolproof, the possibility of errors cannot be ruled out.

Super Sunday: Nikhat, Lovlina win World Championships title

Nikhat Zareen continued to grow in stature as she added a second World title to her swelling trophy cabinet while Lovlina Borgohain broke her 'bronze jinx' to claim her maiden gold medal at the marquee event here on Sunday.

Nikhat upstaged two-time Vietnam's Asian champion Nguyen Thi Tam by a 5-0 verdict to take the light flyweight title infront of a packed KD Jadhav Indoor Hall.

Two-time bronze medallist Lovlina, on the other hand, defeated Caitlin Parker of Australia 5-2 to win her maiden World title.

With the win, Nikhat becomes only the second Indian after the legendary MC Mary Kom to win the title of the prestigious tournament twice. 
