Assam Sema Naga Council has condemned the lyrics used for the live performance during 14th April Bihu Programme held at Sarusajai Stadium, Guwahati.

Mercury soars across India

NEW DELHI, April 18 (PTI): Heatwave conditions continued unabated as temperature hovered in the range of 40 to 44 degrees Celsius over most parts of the country on Tuesday, with Hamirpur and Prayagraj in Uttar Pradesh sizzling at 44.2 degrees Celsius.

Delhi's primary weather station, the Safdarjung Observatory, registered a maximum temperature of 40.4 degrees Celsius, four notches higher than normal. This is the fourth consecutive day that the maximum temperature settled above 40 degrees Celsius here.

BOKAJAN: Responding to a tip off, the police set up a naka under Borpathar Police Station on Tuesday. # Assam-Arunachal border pact shortly

MoU to be signed in presence of Amit Shah: Atul Bora

GUWAHATI, April 18 (PTI): Assam and Arunachal Pradesh governments are likely to sign a memorandum of understanding this month to resolve the longstanding border disputes between the two states, Assam minister Atul Bora said.

Assam has finalised the draft MoU on its part and will forward it to the neighbouring state for its approval, he said.

"The draft of the MoU was discussed threadbare and given the final shape. The copy will now be shared with them, and if they are agreeable, we expect it to be signed by as early as April 20 or at least within this month," Bora said here after a meeting, chaired by chief minister Himanta Biswa Sarma

He said the MoU will be signed by the two states in presence of union home minister Amit Shah.

"However, we cannot say that the MoU will be the final solution. The court and Parliament are also there," Bora, the minister for border area protection and development, said. Members of 12 regional committees of Assam, local MLAs, MPs and district administration officials were present at the meeting to finalise the draft MoU.

The two states have been engaging in discussions to resolve the border disputes with Sarma and his Arunachal counterpart Pema Khandu signing the Namsai Declaration on July 15 last year wherein they had pledged to find solutions soon.

The two northeastern states had decided to restrict the number of 'disputed villages' to 86, instead of the previous 123.

Regional committees dealing with specific areas were formed last year, comprising ministers, local MLAs and officials from both sides to take the discussion forward.

The two states share a border of approximately 804.1 km. The grievance of Arunachal Pradesh, which was made a union territory in 1972, is that several forested tracts in the plains that had traditionally belonged to hill tribal chiefs and communities were unilaterally transferred to Assam.

After Arunachal Pradesh achieved statehood in 1987, a tripartite committee was appointed, which recommended that certain territories be transferred from Assam to Arunachal Pradesh.

Assam contested this and the matter is in the Supreme Court.

GUWAHATI, April 18 (PTI): Assam Youth Congress president Angkita Dutta on Tuesday accused the unit's national chief Srinivas B V of being "sexist and chauvinistic", and discriminating against her based on gender. She also claimed of informing the matter to Congress leader Rahul Gandhi.

"How can a sexist and chauvinistic leader @IYC torture and demean a woman every single time. What happened to @priyankagandhi ladki hoon ladk Shakti hoon (sic)," the daughter of former Congress minister, Anjan Dutta, said in a series of tweets tagging Rahul and Priyanka Gandhi, among others. She alleged that Srinivas has continually harassed her and was "discriminating on the basis of my gender". "My values and education doesn't allow me anymore. # Cook launches Apple's first India store in Mumbai 3-screen multiplex in Guwahati

The store comes 25 years after the company started selling its products in the country through partners

MUMBAI, April 18 (PTI): Apple's chief executive Tim Cook on Tuesday launched the iconic consumer technology company's first retail store in India, welcoming customers into the facility inside a mall in suburban BKC.

"The energy, creativity, and passion in Mumbai is incredible! We are so excited to open Apple BKC - our first store in India," Cook, who opened the doors of the store for customers, tweeted, Hundreds of customers had queued up since last night to be among the first ones to shop or get a feel of the store, which comes 25 years after the company first started selling its products and services in the country through partners.

Dressed in a black-t and grey pants and accompanied by the company's senior vice president for retail Deirdre O'Brien, Cook opened the doors of the store to walk into a crowded foyer to pose for the media, and then started welcoming customers into the store. Customers took selfies with Cook, sought autographs and exchanged pleasantries before going in. One among them, a designer from Mumbai, carried his nearly four-decade-old Mac, a product which revolutionised personal computing and established Apple as a strong brand with a design focus, with him

tional alcoholic beverage company Diageo, which owns United Spirits Ltd here, and some other domestic manufacturers. Pernod Ricard is the world's second-largest wine and spirits organisation and its portfolio comprises over 200 premium brands, including 100 Pipers, Chivas Regal, The Glenlivet, Absolut, Havana Club and Jacob's Creek

It also owns Indian brands such as Blenders Pride and Royal Stag. Pernod Ricard India is alleged to have financially supported some of its Delhi retailers to stock more of its brands. For this, some officials from the liquor firm allegedly provided bank guarantees.

NEW DELHI, April 18 (PTI): Social media platform Twitter will allow freedom of speech but not "freedom of reach" as it will restrict visibility of tweets that violate its rules, the company said in its policy update. Twitter will initially apply the visibility filter on tweets that are found violating hateful conduct rules and expand it to other domains later. The social media firm said that Twitter users have the right to express their opinions and ideas without fear of censorship. "We also believe it is our responsibility to keep users on our platform safe from content violating our rules. These beliefs are the foundation of freedom of speech, not freedom of reach -- our enforcement philosophy which

In the international markets, gold and silver were quoting lower at USD 2,003 per ounce and USD 25.15 per ounce, respectively.



Wipro, Maruti, Larsen & Toubro and Asian Paints were among the gainers. "The banking stocks pared the performance during the day while the market was grappling with the sell-off in the IT sector. However, the IT sector experienced a marginal relief rally, aided by bottom fishing, as the recent correction has made the sector attractive for longterm investment," said Vinod Nair, Head of Research at Geojit Financial Services. Global markets struggled to

make much headway on Tuesday as investors weighed Chinese data that pointed to an uneven recovery, as well as the possibility of further policy tightening by the Federal Reserve and other central banks, said Deepak Jasani, Head of Retail Research at HDFC Securities. In the broader market, the BSE midcap gauge climbed 0.52 per cent and smallcap index gained 0.22 per cent. Among indices, utilities fell 0.81 per cent, power went lower by 0.76 per cent, telecommunication declined by 0.71 per cent, con-sumer durables (0.62 per cent) and commodities (0.18 per cent). Twitter said that authors will be able to submit feedback on the label, if they think "we incorrectly limited their tweet's visibility.

"Currently, submitting feedback does not guarantee you will receive a response or that your tweet's reach will be restored. We are working on allowing authors to appeal our decision," it said.

### Maruti, Hyundai see drop in retail sale market share last fiscal: FADA

NEW DELHI, April 18 (PTI): Passenger vehicle leaders Maruti Suzuki India and Hyundai Motor saw their market share dip in FY23 as compared with FY22 as they struggled with shortage of electronic components, according to automobile dealers' body FADA. Tata Motors, Mahindra & Mahindra and Kia India on the other hand witnessed an increase in their market share based on the retail sales last fiscal. As per the Federation of Automobile Dealers Associations (FADA), the retail sales of country's largest carmaker Maruti Suzuki India rose to 14,79,221 units in 2022-23 fiscal, attaining a market share of 40.86 per

cent. It had retailed 12,39,688 units in 2021-22 and grabbed a market share of 42.13 per cent.

Earlier, the auto major had stated that it faced shortage of electronic components last fiscal with an order backlog of around 3.8 lakh units. Similarly, Hyundai Motor India saw an increase in retail sales at 5,25,088 units last fiscal, however its market share dropped to 14.51 per cent.

It had sold 4,79,027 units in the domestic market in FY22 and its market share was 16.28 per cent during the same period, as per the FADA data. Tata Motors on the other hand saw its market share rise to 13.39 per cent in FY23 from 11.27 per cent in 2021-22 fiscal. It retailed 4,84,843 passenger vehicles last fiscal as against 3,31,637 units in 2021-22 fiscal.

Mahindra & Mahindra sold 3,23,691 passenger vehicles last fiscal to log in a market share of 8.94 per cent. It had retailed 1,99,125 units in FY22 to record a market share of 6.77 per cent, FADA said.

Kia India also witnessed a rise in market share at 6.42 per cent in FY23 from 5.3 per cent in 2021-22. Its retail sales rose to 2,32,570 units last fiscal from 1,56,021 units in FY22. Toyota Kirloskar Motor and Skoda Auto Volkswagen Group also saw a rise in market share in FY23. FADA said it gathered registration data of vehicles from 1,349 out of 1,435 RTOs across the country.

### **Finding alternative USD**

The United States proclaimed the Monroe Doctrine 200 years ago and ever since has arranged Latin American and Caribbean affairs to its advantage. Nevertheless, struggles for national and regional independence did continue, and the poor and marginalised classes did resist. Eventually, there would be indigenous movements, labor mobilisations, and progressive and socialist-inclined governments. Cuba's revolutionary government, for instance, has endured for 63 years. The US political hold may have weakened, but US control over the region's economies remains strong; after World War II it extended worldwide. Now, cracks are showing up. In particular, the US dollar's role as the world economy's dominant currency may have run its course. In 1944, 44 Allied nations determined that the value of their various currencies would correlate with the value of the US dollar instead of the value of gold. The nations since then have relied on the US dollar for their reserve currencies, foreign trade, and banking transactions. There seemed to be a good reason. The United States was supreme in producing and marketing goods and so, presumably, the dollar's value would remain stable and predictable.

The United States has benefited. In currency exchanges involving the dollar, US companies and individuals experience only minor addon costs. US importers know that the more the dollar strengthens in value, the less expensive will be products they buy abroad. US borrowing costs overseas are relatively low because US bonds, and the investments they represent in dollars, are appealing abroad, for a variety of reasons. Dollar dominance has caused pain abroad, however. Exporters to the United States take a hit when the exchange value of the dollar weakens. Importers of US goods are hurt when the dollar strengthens. Most importantly, the US government gains an opening to punish enemy countries through their use of dollars in international transactions. It imposes economic sanctions requiring that dollars not be used in a targeted country's overseas transactions. The US Treasury Department penalizes foreign banks and companies that disobey. Sanctioned nations have included Cuba, Iran, North Korea, Syria, Venezuela, Nicaragua, and more recently, China and Russia.

Former Brazilian President Dilma Rousseff is the recently named head of the New Development Bank which, headquartered in Shanghai, serves the BRICS nations (Brazil, Russia, India, China, and South Africa). The bank represents an alternative to the US - dominated International Monetary Fund and the World Bank. The shift away from dollar dependency is evident elsewhere. At a Russian-Indian "Strategic Partnership Forum" recently, a Russian official announced that the BRICS states would be creating a new currency and that the formal announcement would be made at the BRICS summit meeting in Durban, South Africa, in August. At their summit in March, Russian and Chinese leaders reiterated their intention to expand bilateral trade and utilise their currencies. China increasingly is using its currency in transactions with Asian, African, and Latin American countries. The yuan "has become the world's fifth-largest payment currency, third-largest currency in trade settlement and fifth-largest reserve currency," according to Global Times. Saudi Arabia is on the verge of selling oil and natural gas in currencies other than the dollar, and China occasionally pays Arabian Gulf nations in yuan for those products.

#### Deledging inflated stocks to borrow big from India's public sector banks seems to have become a routine practice in India. Surprisingly, the Reserve Bank (RBI), the banking regulator, and the government, are doing little to control such practices by holding bank management as responsible as those adventurous borrowers. There are reasons to be worried about the growing financial frauds. RBI's mind-boggling admission that India lost ₹ 100 crore to bank fraud every day over the past seven years under the present government hides more than it reveals on how the practice has been gaining ground year after year right under the nose of the regulator. From April 2015-December 2021, a total of ₹ 2.5-lakh crore worth financial frauds was detected in India.

In the case of listed companies involved in such frauds, were the lenders fully satisfied with the real value of stocks or assets which were pledged with them at the time of borrowing funds? Did the lenders follow the industry-specific debt-to-equity norm before granting large loans to companies? Most of the large bank frauds in the past were due to wrong assessments of the borrowers' assets quality.

Fraud-hit banks have been lending recklessly to certain aggressive borrowers ignoring the consequences of such actions. This gives rise to the question of a possibility of an unholy bank-borrower alliance. A debate on the subject is relevant in the context of growing cases of bank frauds in the country. For instance, the price-to-earning (P/E) ratios of a whole lot of listed companies, led by some of the Adani firms, are uncomfortably high. Advancing loans on the basis of such stock prices can become highly risky. Are the lending banks concerned? Probably not. Acceptance of highly inflated stocks as mortgages to sanction large loans often made banks get stuck with sticky assets in due course. The proper stock valuation is important for all investors, including lenders. Also, banks are supposed to consider industry-linked debt-to-equity ratios to provide fresh loans to companies. Of the country's 18 listed firms having

P/E ratio above 70, Adani Green Energy ranks No.1 boasting 254. Three other Adani stocks — Adani Total Gas, Adani Enterprises and Adani Transmission — have P/E ratios in the 100-200 range. Adani Wilmar has a P/E ratio of around 79. The only non-Adani company under this range is Bajaj

Holdings. The P/E ratios of DLF, Tata Power, Avenue Supermarkets, Pidilite Industries, ABB India, ICICI Prudential Life Insurance, Siemens, Nestle, HDFC Life, Titan, Apollo Hospitals and Asian

Paints are in the bracket of between 70 and 90. Interestingly, Adani companies rank mostly at the bottom when it comes to dividend payout ratio. The dividend payout ratio of Adani Green, Adani the depressed earning

Transmission and Adani Wilmar is 0.0 as against Adani Total Gas 5.4 and Adani Enterprises 23.1. Compare them with the dividend payout ratio of DLF (88.0), Pidilite Industries (42.1), Nestle (88.7), Asian Paints (60.2), Titan (30.3), Siemens (28.2) and Bajaj Holdings (31.6). Yet, Adani firms such as Adani Green, Adani Transmission and Adani Power are rated as blue eyed borrow-

ers by certain lenders. Such lenders' logic may not be easy to understand by many. It may be noted that a majority of the firms with high P/E ratio are not even big borrowers.

The P/E ratio is one of the most widely accepted metrics used by investors and analysts to determine stock valuation and help judge if the stock of a company is undervalued or overvalued, along with the comparison of the valuation with the benchmark or industry peers. It suggests if a stock is trad-

US, the P/E ratio reached a staggering 123.73x in May 2009, the highest in its history, mainly because of the depressed earnings during the "great recession" and has been the only instance since 1970 in which the P/E ratio reached triple digits.

High P/E ratios and debt-to-equity ratios normally make lenders and stock investors cautious about betting on such firms. However, Adani firms seem to challenge the concept. Adani Green's debt-to equity ratio is as high as 45 against a generally accepted limit of 2. The state-controlled LIC of India, the country's largest investor in public markets, finds investment in Adani stocks rewarding at a time when mutual funds are trimming their exposure in Adani shares. LIC raised its stakes in four of the six listed Adani group companies in the last March quarter. According to a report, LIC's combined investment in Adani group stocks plunged to ₹ 62,621 crore on January 27, 2023 from ₹ 81,268 crore on January 24, 2023, indicating a notional loss of ₹ 18,647 crore.

Last year, a junior finance minister stated in Parliament that banks have written off ₹ 11.17 lakh crore bad loans from their books in the last six years till the financial year 2021-22. Union Finance Minister Nirmala Sitharaman herself stated that loans amounting to over ₹ 10.09 lakh crore were written off by scheduled commercial banks in the past five financial years. Little is known about those systematic bank defaulters or robbers. Minister of State for Finance Bhagwat Kishanrao Karad said that as per RBI guidelines, names of loan defaulters could be disclosed only once their assets were put up for auction. The banking regulator or the government could at least mention how the banks are systematically robbed by borrowers year after year although most defaulters, wilful or not, follow their own modus operandi. Few will be surprised if bank management are involved in the operation.

More often than not, most large bank frauds seem to invariably involve public sector banks, especially in terms of value. Yet, the state sector bank management at the top level would appear to stay more insulated against penal action than its counterpart in the private sector. The value of frauds is much lower at private sector banks. Lately, the Central Bureau of Investigation (CBI) had arrested and chargesheeted Yes Bank cofounder Rana Kapoor in a ₹ 466.51 crore bank fraud case. In another private sector loan fraud case, former ICICI Bank managing director and CEO Chanda Kochhar, her husband Deepak Kochhar, and Videocon Group Chairman Venugopal Dhoot were arrested by CBI.

It may be time that the services of CBI and Enforcement Directorate are used to detect the involvement of top public sector bank management in big bank fraud cases before fund embezzlers manage to escape from the country. As of now, over 30 financial fugitives are hiding abroad. They include Vijay Mallya, Nirav Modi, Neeshal Modi, Mehul Choksi, Nitin J Sandesara and Dipti Chetankumar. They flouted all established norms to borrow large funds from public sector banks or bank consortiums. Little is known about the involvement of top level bank management in such public fund swindles. # AIIMS Guwahati: A new healthcare milestone in the NE

The All India Institute of Medical Sciences, also known as AIIMS, is India's premier medical research and treatment facility. First health minister of India Rajkumari Amrit Kaur came up with the idea and introduced a bill to the Lok Sabha in 1956. She had the idea after reading a 1946 report on a national health survey that had confirmed the need for such an institution. She stated in her passionate and forward-thinking speech in the Lok Sabha that she had long wished for the establishment of such an institution that could uphold the high standards of medical education and post-graduate training so that young Indian doctors could complete their post-graduate studies in their own country. She even contributed a portion of her ancestral estates to the effort in order to support the creation of the first AIIMS in New Delhi, the nation's capital. With time, AIIMS New Delhi cemented its place as the apex of the Indian healthcare system by providing aid to millions of those in need and training up-and-coming doctors to the highest standards. The fact that AIIMS was the first hospital in Asia to prohibit its doctors from working in private practice so they could devote their time to advancing the crucial cause envisioned by Rajkumari Kaur is significant. However, there has been a significant change in India's health care system since before independence. Despite a twofold increase in life expectancy, a large number of people continue to experience malnutrition and high rates of infant and maternal mortality. It is estimated that poor access to healthcare and inadequate care delivery cause about a million Indians to die each year. Furthermore, according to statistics, 78 percent of all medical costs in India are covered out of pocket by patients, adding to the cost of healthcare in the nation. In order to provide all citizens with topnotch tertiary-level medical care at a fair price, it was urgently necessary to upgrade India's infrastructure. This goal drove the development of the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), which was conceived in 2003 and launched in 2006. One of PMSSY's goals has been to assist with the national establishment of new AIIMS. These new AIIMS created through PMSSY are now able to function independently under the Ministry of Health and Family Welfare after being recognized as institutes of national importance by the Indian government under the AIIMS Act. Other major objectives of these new AIIMS include conducting research on medical and health issues specific to particular geographic areas and providing the highest caliber undergraduate and graduate instruction in all important healthcare-related activities. This is in addition to offering the general public advanced tertiary healthcare. As part of the PMSSY initiative's various phases, 22 new AIIMS have already been planned or constructed. They were the first AIIMS to be established as part of Phase-I of PMSSY, and six of themlocated in Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur, and Rishikesh-are currently fully operational. The remaining new AIIMS are scattered across the country and are in varying stages of development and operation. The cornerstone for the AIIMS Guwahati was laid on May 26, 2017, by Indian Prime Minister Narendra Modi. A total earmarked budget of 1,123 crore rupees was approved for AIIMS Guwahati's construction on May 24, 2017, as part of PMSSY Phase-V. It is a 750bed elite, state-of-the-art healthcare facility that offers specialist and superspecialist care, education, and a

Concern has been expressed recently in the North Bengal-based mass media about an influx of unemployed migrant Nepali youths taking up temporary odd jobs in local tea migrants talking about the recent closure of a few manufacturing units and large shops in the jewellery and general merchandise sectors because of dwindling demand. Mostly jobless youths have been trying to secure informal work in the local tea plantations, where they also can find accommodation. Some are helped by their relatives already settled in the North Bengal towns for a time. Such influx tends to push down the level of local wages which

According to sources, the increase in Nepali population in and around Darjeeling between 1951 and 2001 has been exceptionally high. The Nepali-speaking population increased by a whopping 875% during these decades, whereas India's national population growth was around

The first Executive Director of AIIMS Guwahati was chosen to lead the organization and appointed on July 10, 2022. Prof (Col) Ashok Kumar Puranik is a renowned trauma care surgeon with years of experience in the Indian Armed Forces. He previously served as the AIIMS Jodhpur's surgical department head.

On January 12, 2021, the institute started its academic journey with 50 MBBS students living on a temporary campus on Guwahati's Narakasur Hill. The departments of community and family medicine were included, as well as those of anatomy, physiology, and biochemistry. The designated campus in the rural districts of Silbharal, Changsari, and Kamrup has been the center of the institute's operations since March 2022. For various other specialization and superspecialization departments, faculty recruitment took place between April and June 2022; as of the time of writing, there are more than 80 faculty members on staff. The third and most recent batch of MBBS students enrolled a total of 100 individuals in November 2022. Currently, telemedicine and temporary OPD services are provided by the departments of general medicine, surgery, obstetrics and gynaecology, paediatrics, oncology, and other specialties. From September 2022 onwards, in the AYUSH building of the institute the trauma and emergency services building, the outpatient department (OPD), and the residence halls at the medical and nursing colleges are all in use. Under the competent direction of Executive Director Dr. Puranik and his administrative staff, the institute is steadily advancing toward its objective of providing the local population with top-notch healthcare services.

On March 23, 2023, Chief Minister Himanta Biswa Sarma announced that Prime Minister Modi would dedicate the prestigious institute to the people of Assam from its premises on April 14, 2023, as he reviewed infrastructure development. This information should please the people of Assam and North East India, who need to have access to first-rate tertiary healthcare in all specialties.

As the adage goes, "Rome was not built in a day," it will take some time for AIIMS Guwahati to match the high standards of AIIMS New Delhi or any other prestigious Indian medical institution. It's crucial to comprehend the extensive infrastructure, logistics, and workforce training required to raise the institute to the top. However, with public support and capable leadership, AIIMS Guwahati will quickly become the best healthcare delivery, education, and research institution in North East India and Southeast Asia. Nepalese authorities have been trying hard in the post Covid period to rev up the economy. The number of tourist arrivals has gone up steadily .The outlook has improved somewhat for the tourism sector and related activities.

But the deep post covid 19 Pandemic economic downturn continues. Reports from Kathmandu confirm that fresh job creation still remains a major challenge for the Government. Nepalese officials admit that there is a steady exodus of aspirant educated Nepali youths to India, West Asian countries, Malaysia, the EU countries among other destinations, of late.

For a country with a relatively small population of just over 30 million people, the diaspora of Nepali youths to other countries in recent times has been impressive in terms of size. Several factors have worked against the creation of new jobs in the long term for Nepal: there is little interest among foreign or even local investors to launch major manufacturing projects because of the small domestic market and the natural difficulties involved in setting up even small industries in the high hills. In addition, there are problems in the transportation of goods and the nature of climate.

No wonder even the normally flourishing tourism sector cannot be expected to accommodate hundreds of new job seekers, many of them educated, on an annual basis. Of late there has been some growth in the strong hydropower generation sector, but mass recruitments generally cease once a project is completed.

North Bengal papers published from Siliguri and other centres have quoted jobless Nepali

breeds resentment among local non Nepali workers. Local media reports suggest that some people also help the migrants secure Aadhaar card and other documents to avoid detection by the police and civic authorities. There is an undercurrent of tension among non Nepali people regarding such emergent trends in the area, especially in the larger context of the simmering agitation for a Gorkhaland state.

In part the generally lackadaisical attitude of the Bengal government towards the problem of illegal infiltration, whether from Bangladesh or other countries, also contributes to a general worsening of the law and order in parts of North Bengal. Despite recent tensions between Nepal and India, vigil along the 1751 kilometre long international border remains slack. Further, Bengal -based political parties regardless of affiliation have not really opposed the steady influx of Nepalis into Darjeeling, Kalimpong and Siliguri areas in recent times. Most of the Nepali agitators driven out by Bhutanese authorities some years ago for disturbing law and order, came over to settle down in Siliguri and nearby areas. At one stage, they staged daily demonstrations against GOI, urging upon Delhi to take up the question of their return to Bhutan! No local political party spoke against such in-

filtration, because of consideration of vote bank politics. Instead, locals helped them in secure jobs and official documents to make their position more secure legally.

At least one HR group Janachetana, some years ago, reported on the changing demography of the region, referring to the growing Nepali influx. It also highlighted how migrants

At present most Nepalis and Gorkhas live within the areas controlled by the autonomous Gorkha tribal organisations in North Bengal.

However, most Gorkha/Nepali groups have now rejected the Gorkha Territorial Authority (GTA) as an organisation representing their interests, although their community leaders had signed tripartite agreements with the state and central Governments some years ago to set it up in the first place. Once more, they are planning to revive the demand for a separate Gorkhaland state. Such moves are nothing new. Just as now the GTA is being sabotaged, the Gorkha National Liberation Front (GNLF) organisation that sponsored the Gorkha agitation for autonomy had been initially supported and then rejected in favour of the GTA, by the more militant sections of Gorkha leadership, earlier.

Given the present stand taken by the ruling Trinamool Congress (TMC) towards the often violent Gorkhaland agitation and the Bharatiya Janata Party's (BJP) equivocation on the issue, there is no certainty that fresh violence may not return to the hills in the months ahead.

This is a major reason why the fresh influx from Nepal, unchecked so far, continues to raise concerns among major sections of Non-Nepali citizens ion North Bengal. Incidentally, although Gorkha/Nepali agitationists usually claim Siliguri town and nearby areas as part of a new proposed Gorkha territory, the Nepali speaking population is only around 4.66% in those areas, whereas 25.24% of the people according to the 2011 census figures, are Hindi speakers and over 60% of the people declared themselves as Bengalis. ## What days can you get pregnant?

emales are most fertile within a day or two of ovulation, which is when the ovaries release an egg. But, it is possible to get pregnant in the days leading up to ovulation, as sperm can survive for several days inside the female body.

The days during the menstrual cycle when a person is least likely to get pregnant are known as the 'safe period.

This article describes how to calculate the fertile window to aid or avoid conception. Was this helpful?

#### The menstrual cycle

The average person's menstrual cycle is between 28–32 days. Some people have shorter cycles, while others have much longer ones.

The first day of a person's period is considered the first day of their menstrual cycle. Their period then typically lasts 3-7 days.

Variations in the menstrual cycle usually happen in the follicular phase that occurs before ovulation

The luteal phase, which occurs from ovulation to the next period, is typically 14 days long. **Ovulation and conception** 

Ovulation occurs when one of the ovaries releases an egg. After release, the egg moves to the fallopian tube, where it will travel to the uterus, which takes about 24 hours.

Pregnancy occurs if sperm travels to the fallopian tube and fertilizes the egg. If sperm does not fertilize the egg, the egg moves to the uterus and breaks down, ready to leave the body during the next menstrual period.

#### **Calculating ovulation**

According to the American College of Obstetricians and Gynecologists, ovulation occurs around 14 days before a person expects to have their next period if their monthly cycle is 28 days. Most people ovulate between days 11-21 of their cycle. The first day of their last menstrual period (LMP) is day 1 of the cycle. Ovulation does not always occur on the same day every month and can vary by a day or more on either side of the expected date. Doctors call the part of the cycle around ovulation the fertile window because the chance of pregnancy is highest at this time. For example, if ovulation occurs on day 14, a person can conceive on that day or within the following 24 hours.

However, their fertile window begins a few days before ovulation because sperm can survive for up to 5 days inside the female body. So, even if a person does not have sex on day 14 or 15, it is still possible to become pregnant if they had sex without using contraception on days 9-13.

According to research from 2018, the likelihood of conception rises from day 8, reaching its maximum on day 13 and decreasing to zero by day 30.

However, it is essential to note that these findings should only act as a guideline. Every person and every cycle is different.

It can be helpful for a person to chart their

monthly cycle and take note of the signs of ovulation to help pinpoint the exact day of ovulation each month

Signs of ovulation Tracking the signs of ovulation can help someone determine the precise day they ovulate each month

#### Signs include:

• Mild cramping in the lower abdomen • Wetter, clearer, and more slippery vaginal discharge similar to egg white

• A small increase in basal body temperature A higher sex drive Some of these signs, such as basal body tem-

perature, will continue to change after ovulation. For this reason, a person should not use temperature to predict the fertile window.

It may be helpful for someone to track the signs over a few months to get an idea of what is typical for their body.

But they should keep in mind that there are several variables, and the timing of ovulation can change, month-to-month.

Another option is to use an ovulation predictor kit or fertility monitor. Fertility aids measure the levels of specific

hormones in the urine to determine the ovulation day each month. Some devices also identify days of peak fertility.

Using a combination of these methods may provide an individual with the best accuracy. The following table, based on research from 2015, summarizes a typical menstrual cycle and how fertile a person is likely to be at each stage:

To get a more specific range of highest fertility windows based on the day of ovulation, a person can track the first day of their last period in a pregnancy calculator.

Maximizing fertility and chances of conception

To maximize the chances of becoming pregnant, a person should time sexual intercourse to occur during the 2-3 days leading up to, and including, ovulation. Having sexual intercourse on any of these days may provide a 20-30% chance of pregnancy

Other tips to improve the chances of conception include:

Have regular sexual intercourse. Pregnancy rates are highest among partners who have sex every 2 or 3 days throughout the month. Avoid smoking. Smoking tobacco reduces fertility and impacts the health of a developing

fetus. Limit alcohol intake. Alcohol intake can reduce fertility in males and females and harm a fetus. Maintain a moderate weight. People who have overweight or underweight are more

sperm cannot move as efficiently to reach the egg. There are a variety of medical conditions that can cause any of these problems with male fertility, including a hormonal imbalance, infection or injury to the testicles, surgery in the area, and diseases such as cancer.

Avoiding pregnancy

Some people may wish to track their fertility to prevent pregnancy. This is known as the fertility awareness method.

The Centers for Disease Control and Prevention (CDC) charts fertility awareness-based methods of contraception as having a 24% failure rate with typical use. The chances of pregnancy are lowest during a person's period and on the days on either side of the period.

However, they may still become pregnant if they have ovulated early or late in their cycle, as sperm can survive in the body for several days. pill with typical use.

Females who track their fertile window with the aim of getting pregnant should see their doctor for preconception planning.

As well as identifying barriers to conceiving, a doctor can advise on the use of folic acid or prenatal supplements to encourage a safe pregnancy. Most couples who have fre-

quent sex without contraception will conceive within 12 months. Women under 35 years of age should see their doctor if they do not conceive after a year of trying. Those over 35 years of age should seek medical advice after 6 months of trying to conceive. Anyone who has irregular cy-

cles or does not appear to ovulate should also speak with their doctor. There may be an underlying medical cause that is pre-

Intermenstrual bleeding can occur between periods. To pinpoint the start of a menstrual cycle, a female must correctly identify their actual period. Each person's menstrual cycle is different. Generally, it lasts 28-32 days. A person is at their most fertile during ovulation, which occurs around days 10-14.

A person can calculate the exact days of ovulation each month by counting from the first day of their period.

## Breastfeeding myths & facts: Busting common myths about breastfeeding

Whatever I learn in school is the opposite of the reality in my home." Priya is a 16-yearold schoolgirl from the Rajput community in the mountain state of Uttarakhand. She is speaking about the



#### rest of the house.

While living in Jhankat village of Khatima block, Lata abided by these rules as she was living with her husband's extended family. She stopped briefly only when she and her husband moved out. "The last few years, we have started believing in these traditions again." says Lata, who holds a master's degree in Politics. "If a menstruating woman falls ill, it is said that gods have become unhappy. All problems [in the family and village] are attributed to the non-compliance of these practices," she says in an attempt to explain her compliance. No one in the village will accept even a glass of water from the hands of a family in which there is a newborn child. The entire family is considered 'impure' and the sex of the child changes nothing. Anyone who touches the woman or the newborn baby is purified by sprinkling gau mutra. Usually, on the eleventh day, the woman and the baby are bathed and washed with gau mutra, following which the naming ceremony takes place. Savita, Lata's 31-year old sister-in-law. was married when she was 17 and forced to follow these customs. She recalls how in the first year of her marriage she had to eat with only a sari to cover herself - the custom of no undergarments had to be strictly followed. "After the birth of my first child I stopped that," she says, but admitted that she later reverted to sleeping on the floor when she got her periods. Growing up in homes where such practices are followed, boys in the area are not quite sure what to think. Nikhil is a young boy from Barkidandi village who is studying in Class 10. He says he read about menstruation last year and didn't quite understand it but, "I still thought the idea of keeping women separate is unreasonable.' However he says if he talks about this at home he will be scolded by the adults in the family. This is a fear that Divyansh also shares. A 12-year-old schoolboy from Sunkhari village, he has been watching his mother sit apart for five days in a month but never understood why. "It is so normal for me that I think that this happens to all women and girls. But now I don't feel it is right. When I grow up will I go along with the custom or can I stop it?," he wonders. No such conflict is felt by an elder in the village who stated, "Uttaranchal [Uttarakhand's old name] is the abode of the gods. So [these] customs are important here,' says Narender. He says girls in their community used to be married off at 9-10 years, before they began menstruating. "If she started menstruating, how would we do kanyadaan?" he says, speaking about the marital custom of 'gifting' a girl to her husband. "Now the government has changed the age of marriage to 21. Since then, the government and us have different rules." (Courtesy: The Wire)

reastfeeding is not an easy journey; it is full of ups and downs. A woman is usually not used to the practice and a delay by the baby often makes the new mothers anxious. But there are various other myths around the breastfeeding journey and too much information or misconceptions can result in restlessness and overthinking among the mothers which is unwanted. unhealthy and not needed.

Problems relating to breastfeeding is common and few of them are low milk production, confusion with the diet, frequency of breastfeeding, etc. Today, we are here to tackle the myths and misconceptions and replace these with facts and truths so that you know better and are well prepared for your breastfeeding journey.

Myth 1: It is normal for breastfeeding to hurt

According to WHO, many women experience discomfort in the first few days of their breastfeeding journey since they are new to it and it takes some time for them to learn the process. But if they have

the right support and position their baby correctly, making sure their baby is correctly attached to the breast; the problem of sore nipples can be prevented. If you think you do everything right yet face issues regarding lactation, it's best to consult a lactation specialist.

#### Myth 2: You need to wash your nipples before breastfeeding

No, this is the wrong information and a big misconception. You don't need to wash your nipples before breastfeeding isn't necessary. When babies are born, they recognize their mothers by their smell and touch thus they are already used to the mother's smells and sounds. The nipples produce a substance that has good bacteria and is recognized by the baby due to its smell. It is only beneficial for the baby since it helps them to build babies'

healthy immune system for life. Myth 3: Breastfeeding mothers can't take medicines

There is no such thing that breastfeeding mothers can't take medicines. The main criteria is to just inform your doctor that you are breastfeeding and make sure to read the instructions on the medicines if you are buying over the counter medicines. Make sure to take medications at a specific time and in a specific dosage.

#### Myth 4: You can't breastfeed while you are sick

The mothers can and cannot breastfeed their child while they are sick and the answer depends on the type of sickness or disease the mothers are suffering from. Make sure to get the right treatment, eat right, and drink plenty of fluids. There are few diseases in which the antibodies produced in the mother's body is passed on to the baby thus it is better to take

an advice from the doctor. Myth 5: Many mothers can't produce enough milk Almost all mothers produce the right amount of milk for their babies. Breastmilk production depends on the fact that how well the baby is latched on

to the breast, the frequency of breastfeeding and how well the baby is feeding on the milk while breastfeeding. During breastfeeding, mothers need support and guidance from their health care providers, help at home, and need to stay healthy by eating right and drinking more fluids.

#### Myth 6: Breastfeeding mothers should only eat plain food

There's no such thing that breastfeeding mothers need to eat plain food but yes, you need to consume a balanced diet if you are breastfeeding. No change is required in the eating habits and diet of a mother as long as it is healthy. According to WHO, babies are habituated to their mothers' food preferences from the time they are in the womb so you do not need to worry about the baby's response. (Courtesy: The **Ouint**)

strict and clearly laid-out rules she is forced to follow when she is menstruating. 'It is almost like living in two different worlds. At home I am made to isolate myself and follow all the customs and restrictions, and in school I am taught that women are equal to men," she says.

A student of Class 11, Priya's school is in Nanakmatta town, seven kilometres from her home in the village. She cycles there and back every day. A good student, she initially tried educating herself on the subject. "I read books and I thought I would do this and that; I would change the world. But I was not able to convince my family that these customs have no meaning. I live with them day and night but I am unable to make them understand that these restrictions have no meaning," she says. Her initial unease and discomfort at the rules and regulations has not diminished but she just goes along with her parents' thinking now.

Priya and her family live in the terai (lowland) region, the highest yielding agricultural region in the state (Census 2011). The region has three harvests kharif, rabi and zaid - and most of the population is engaged in agriculture and keeps livestock, mostly cows and buffaloes

Photo: Kriti Atwal/People's Archive of Rural India In another Rajput home close by, Vidha describes her living arrangements when she is menstruating: "For the next six days, I will be confined to my room. I have been told [by her mother and paternal grandmother] not to roam around. My mother will bring me whatever I need.'

The room has two beds, a dressing table and almirah. The 15-year-old Vidha will not sleep on her regular wooden bed but on a flimsy cot covered with a sheet that she says gives her a backache, but she does it for "my family's peace of mind."

During this strictly mandated isolation, Vidha is allowed to go to school, but must come straight back to this room in her home in Nagala village in Sitarganj block. Her mother's phone and some books help the Class 11 student pass the time.

When a woman begins to sit separately from others in the family and moves her things to one side it's a signal to everyone that she is menstruating. Vidha resents the fact that who is menstruating and who is not, is public knowledge. She says, "everyone gets to know and discusses it. She [the menstruating person] is not al-



lowed to touch the animals and fruit-bearing trees, or cook and serve food, and even accept offerings from the temple.'

This view of women as 'impure' and 'inauspicious' is reflected in Udham Singh Nagar's demographics which show a poor sex ratio of 920 females per 1,000 males, lower than the state average of 963. Also, the literacy rate at 65 per cent is for women is significantly lower than among men – 82 per cent (Census 2011).

Below Vidha's bed is a thaali, a bowl, steel tumbler and spoon that she must use to eat during this time. On the fourth day she wakes up early to wash and dry these utensils in the sun. "Then my mother sprays gau mutra [cow urine] on the dishes, washes them again and places them back in the kitchen. I am given different utensils for the next two days," she says, detailing the elaborate procedures that she has to follow. She is prohibited from moving around outside the house and wearing clothes "other than what my mother has given me to wear during those days," she adds. The two pairs of clothes she wears must be washed and hung at the back of the house to dry and are not to be mixed with other clothes.

Vidha's father is in the army and it's her mother who manages the household of 13 people. Isolating in such a large family is awkward for her, especially explaining it to her young brothers: "My family members have told them that this is an illness for which girls have to live in isolation from others. If someone unknowingly touches me, then they are also considered 'impure', and only after they have been sprayed with gau mutra will they be 'clean'. During those six days, everything that comes into contact with Vidha is sprayed with gau mutra. It helps that the family owns four cows so their urine is readily available.

The community has relaxed a few practices, but marginally. So while in 2022 Vidha gets a separate bed to lie on, Beena, in her 70s, from the same village, recounts how she had to stay in a cattle pen when she menstruated. "We would spread pine leaves on the floor to sit," she recalls.

->

Another older woman remembers a time when," I would be given pheekhi [sugarless] chai along with dry rotis . Or we would get rotis made of coarse grain such as that given to animals. Sometimes they would forget about us and we would stay hungry." Many women and men believe that these practices are ordained in religious texts and so cannot be questioned. Some women did say they are embarrassed but they also added that they believe the gods will be displeased if they don't isolate themselves. As a young man in the village, Vinay agrees that he rarely meets or comes face-to-face with menstruating women. Growing up he heard the phrase, 'Mummy achoot ho gayi hai [Mummy has become untouchable now]'. The 29-vear-old lives with his wife in a rented room in Nanakmatta town. Originally from Champawat district of Uttarakhand, he moved here a decade ago when he began teaching in a private school. "We are never told that it is a natural process. If we stop following these restrictions from childhood, men will not look down upon any girl or woman when she gets her periods,' he says.

Purchasing and later disposing sanitary pads is a challenge. The solitary shop in the village may or may not stock them and then young girls like Chhavi say they get strange looks from the shopkeeper when they ask. Going home, they are forced to hide their purchases from prying eyes. Finally, disposing of the pads calls for a walk to a canal 500 metres away, a quick look around to check nobody's watching before it's flung in.

Giving birth invites yet more isolation The idea of 'impurity' extends to those who have just given birth as well. Lata has teenage children but she remembers her time well: "Instead of 4 to 6 days [for menstruating girls], new mothers are kept apart from the rest of the household for 11 days. Sometimes this may even be 15 days, that is, until the naming ceremony of the child is done." Lata is mother to a 15year-old girl and 12-year-old boy and says a line of cow dung is drawn to demarcate the bed the new mother sleeps on from the

### Putin visits Russian troops in occupied Ukraine Putin's trips to the military headquarters come as Ukraine is preparing for a new counteroffensive to reclaim the occupied territories

KYIV, April 18 (AP): Russian President Vladimir Putin visited the headquarters of Russian troops fighting in Ukraine early on Tuesday, his second trip to the Russianheld territories there since March.

A video released by the Kremlin and broadcast by Russian state television showed Putin visiting the command post for Russian forces in the southern Kherson region. It showed Putin arriving by helicopter to receive reports from the top military brass about the combat situation.

The Russian leader then moved by helicopter to the headquarters of the Russian National Guard of the eastern Luhansk region to hear a report from commanders.

In both locations, Putin congratulated the military on Orthodox Easter, which was celebrated on Sunday and presented them with icons. Russia annexed the Kherson and Luhansk regions along with the Donetsk and Zaporizhzhia regions in September in a move that was rejected by much of the world as illegal. It was impossible to

independently verify the footage of Putin's visits to the two regions that was released by the Kremlin. The trip marked a second visit by the Russian leader to the areas that Russia occupied in Ukraine in as many months. Last month. Putin visited the Russian-held Sea of Azov port city of Mariupol, which was captured by Russian troops in May after two months of fierce fighting. The locations of the military headquarters in the Kherson and

Luhansk regions weren't disclosed, so it wasn't possible to assess how close they are to the front line. Putin's trips to the military headquarters come as Ukraine is preparing for a new counteroffensive to reclaim the occupied territories.

Russia's war in Ukraine has turned into a stalemate amid heavy fighting in the country's east, particularly around the town of Bakhmut. which for 81/2 months has been the stage for the war's longest and

Ukrainian officials have said they're buying time by depleting Russian forces in the battle while Kyiv prepares a counteroffensive. Ukrainian President Volodymyr Zelenskyy has argued that if Russia wins the Bakhmut battle, it could allow Putin to begin building international support for a deal that would require Ukraine to make unacceptable compromises to end the war. Oleksiy Danilov, the secretary of Ukraine's National Security and Defense Council, told The Associated Press in an interview in Kyiv that Ukraine's allies are helping the government to achieve the level of technical equipment necessary to launch the attack, delivering heavy armoured vehicles and ammunition. He expressed confidence that Ukraine will be able to return all its occupied territories.

KARUIZAWA, April 18 (AP): Top diplomats from the Group of Seven wealthy democracies vowed a unified front against Russia's war of aggression in Ukraine, saying at the close of their meetings on Tuesday that they were committed to boosting and enforcing tough sanctions against Moscow.

The G-7 communique laying out their commitments also included strong words meant to curb what the ministers see as increasing Chinese and North Korean aggressiveness in Northeast Asia.

But it was Russia's invasion of Ukraine that highlighted the threeday summit in this hot spring resort town.

"There can be no impunity for war crimes and other atrocities such as Russia's attacks against civilians and critical civilian infrastructure," the ministers said.

'We remain committed to intensifying sanctions against Russia, coordinating and fully enforcing them," the communique said, and would support "for as long as it takes" Ukraine as it defends itself. The foreign ministers' document

was prepared as a template for global leaders to use at a G-7 summit that will be held in Hiroshima next month, and included language about Iran, Myanmar, Afghanistan, nuclear proliferation and other "grave threats."

But two crises stood out: China's

increasing assertiveness against, and military maneuvers around, Taiwan, the self-governing democracy that Beijing claims as its own, and Russia's invasion of Ukraine. Russia's current offensive is largely stalled and Ukraine is preparing a counteroffensive, but there's widespread global worry about the Russian leader's repeated threats to use tactical nuclear weapons.

"Russia's irresponsible nuclear rhetoric and its threat to deploy nuclear weapons in Belarus are unac-

ceptable," the ministers said. The G-7 envoys from Japan, the United States, the United Kingdom, France, Germany, Canada,

### **UN says leaving** Afghanistan would be 'heartbreaking' UNITED NATIONS, April 18 (AP): The United Nations is ready to take the "heartbreaking" decision to pull out of Afghanistan in May if it can't persuade the Taliban to let local women work for the organisation, the head of the UN Development Program said.

UN officials are negotiating with the Islamist government in the hope that it will make exceptions to an edict this month barring local women from working for the organisation, UNDP Administrator Achim Steiner told The Associated Press

### Suspected shooting attack in Jerusalem wounds 2 Israeli men JERUSALEM, April 18 (AP): A

suspected shooting attack by a Palestinian gunman in Jerusalem on Tuesdav left two Israeli men wounded, police said. It was the latest in a yearlong cycle of violence that shows no sign of abating after weeks of heightened tensions around Jerusalem during the overlap of the Jewish holiday of Passover and the Muslim holy month of Ramadan.

Israeli police were searching for the suspected attacker who fled the scene in the east Jerusalem neighborhood of Sheikh Jarrah.

The two wounded, who were shot while inside a vehicle, were treated for moderate gunshot wounds. Tensions in Israel and the occupied West Bank soared weeks after an Israeli police raid on Jerusalem's most sensitive holy site, the compound home to the Al-Aqsa mosque. The mosque sits on a contested hilltop known to Jews as the Temple Mount and to Muslims as the Noble Sanctuary, revered as the third-holiest site in Islam and the holiest site in Judaism.

Earlier this month, the Israeli military struck sites linked to the Palestinian group Hamas in southern Lebanon and the Gaza Strip after militants in the two territories fired salvos of rockets at Israel.

### Tunisian Islamist

KHARTOUM, April 18 (AP): As explosions and gunfire thundered outside, Sudanese in the capital Khartoum and other cities huddled in their homes for a third day on Monday, while the army and a powerful rival force battled in the streets for control of the country.

At least 185 people have been killed and over 1,800 wounded since the fighting erupted, UN envoy Volker Perthes told reporters. The two sides are using tanks, artillery and other heavy weapons in densely populated areas. Fighter jets swooped overhead and anti-aircraft fire lit up the skies as darkness fell. The toll could be much higher because there are many bodies in the streets around central Khartoum that no one can reach because of the clashes

There has been no official word on how many civilians or combatants have been killed. A doctors' group earlier put the number of civilian deaths at 97.

The sudden outbreak of violence over the weekend between the nation's two top generals, each backed by tens of thousands of heavily armed fighters, trapped millions of people in their homes or wherever they could find shelter, with supplies running low and several hospitals forced to shut down.

Top diplomats on four continents scrambled to broker a truce, and the UN Security Council was set to discuss the crisis.

### leader Ghannouchi detained amid tensions

TUNIS, April 18 (AP): Influential Tunisian Islamist leader Rached Ghannouchi was detained on Monday after a police search, according to his lawyer, in a move denounced by his supporters as a stepped-up effort by the president to quash Tunisia's opposition.

The move against the 81-year-old former parliament speaker comes amid growing social tensions and deepening economic troubles in Tunisia, the birthplace of the Arab Spring pro-democracy movement more than a decade ago.

Ghannouchi, head of the Ennahdha party, is the most prominent critic of Tunisian President Kais Saied. While he has been detained for questioning in the past and released, his supporters described Monday's action as a more serious

Police entered his house for a lengthy search and brought him to the El Aouina jail in the east of the capital, his lawyer Nejib Chebbi told The Associated Press.

Ennahdha called for his release. saying in a statement that it it "condemns this very dangerous development." Tunisia's official TAP news agency reported that he was detained on a warrant by counterterrorism prosecutors as part of an investigation into recent "provocative" comments. It did not elaborate.

Other Tunisian media reported that Ghannouchi was to be questioned over a video circulating online in which he purportedly says that the president's perceived efforts to "eradicate" Islamist opposition threaten to unleash civil war.

Ghannouchi has been detained before for questioning on suspicion of money laundering and terrorism financing through a charity. He has denied wrongdoing and his party says the accusations are politically driven. His daughter Yusra said her father had cooperated with police during past detentions, and lamented that the president "ordered a raid on his house and his arrest after sundown during the most holy night of Ramadan.'

"Gunfire and shelling are everywhere," Awadeya Mahmoud Koko, head of a union for thousands of tea vendors and other food workers, said from her home in a southern district of Khartoum.

She said a shell stuck a neighbour's house Sunday, killing at least three people. "We couldn't take them to a hospital or bury them."

In central Khartoum, sustained gunfire erupted and white smoke rose near the main military headquarters, a major battlefront.

Nearby, at least 88 students and staffers have been trapped in the engineering college library at Khartoum University since the start of fighting, one of the students said in a video posted online Monday. One student was killed during clashes outside and another wounded, he said.

SEOUL, April 18 (AP): J-Hope, a member of K-pop sensation BTS, entered a South Korean boot camp Tuesday to start his 18-month compulsory military service, becoming the group's second member to join

the country's army. There was heated public debate in 2022 over whether to offer special exemptions of mandatory military service for BTS members, until the group's management agency announced in October that all seven members would fulfill their duties.

In December, Jin, 30 and the oldest member of BTS, became the band's first member to enter the army after revoking his request to

delay his conscription. South Korean TV footage on Tuesday afternoon showed what they called a black minivan likely carrying J-Hope moving into the boot camp in Wonju, about 90 kilometers (55 miles) east of Seoul. Hybe Corp., the parent company of BTS' management agency Big Hit

buses wrapped with large photos of J-Hope and words hoping for his safe service. Authorities mobilized soldiers and police officers to maintain order, and there were no immediate reports of safety-related accidents. Big Hit Music had pleaded with fans, who call themselves the "Army," not to come to the site due to safety reasons.

### 'Mangrove Man' in Kerala fights to salvage sinking shores

KOCHI, April 18 (PTI/AP): On the receding shorelines of low-lying Vypin Island off Kerala's coast, T. P. Murukesan fixed his eyes on the white paint peeling off the damp walls of his raised home and recounted the most recent floods.

"The floods are occurring more frequently and lasting longer," he said. The last flood was chest-high for his young grandson. "Every flood brings waters this high, we just deal with it.'

Sea level rise and severe tidal floods have forced many families in Murukesan's neighborhood to relocate to higher grounds over the years. But the retired fisherman has almost single-handedly been buffering the impacts of the rising waters on his home and in his community

Known locally as "Mangrove Man," Murukesan has turned to planting the trees along the shores of Vypin and the surrounding areas in the Kochi region of Kerala state to counter the impacts of rising waters on his home.

Tidal flooding occurs when sea level rise combines with local factors to push water levels above the normal levels. Mangroves can provide natural coastal defenses against sea level rise, tides and storm surges, but over the course of his life forest cover in the state has dwindled.

Murukesan said he grew up surrounded by beautiful, abundant mangroves that separated islands from the sea. Now, only fragmented patches of mangroves can be seen in Kochi, the state's financial capital.

"They protected our houses against floods, sea erosion, and storms, used to be an inseparable part of our life, our ecosystem," he said. "Only these can save us.'

Murukesan said he has planted over 1,00,000 mangroves. He plants saplings on alternate days and does most of the work himself. Some help comes in the form of saplings from the M S Swaminathan Research Foundation, a non-government organisation based in Chennai. His efforts come up against a strong

"I have to travel a lot to collect seeds. My wife helps me in the nursery as much as she can. I am tired but I cannot stop," he said.

Geetha said they do the tough work "for our children," preserving the forest for decades to come.

"It keeps us going," she said. Vypin is at high-risk for tidal flooding, said Abhilash S, director of the Advanced Centre for Atmospheric Radar Research at the Cochin University of Science and Technology.

"The sea level has risen and has damaged freshwater supplies. Sea erosion and spring tides have worsened. Coastal flooding is a common occurrence now," he said. "The carrying capacity of the backwaters has reduced due to sediment deposition and encroachment, and the rainwater enters residential areas during the monsoon season."

Backwaters in Kerala are networks of canals, lagoons and lakes parallel to coastal areas, unique ecosystems that help provide a buffer to rising sea levels. According to the World Meteorological Organization, global mean sea level

rose by 4.5 millimetres per year between 2013 and 2022. It's a major threat for countries like India, China, the Netherlands and Bangladesh, which comprise large coastal populations.

NASA projections show that Kochi might experience a sea level rise of 0.22 metres by 2050, and over half a meter by 2100 in a middle-of-the-road climatewarming scenario.

"Many families have left," Murukesan said.

Fishing families living within 50 metres of the shore get a financial assistance of ₹ 10 lakh through a rehabilitation scheme run by the Kerala government. Only few of those not covered under it have means to relocate to safer places.

Some fishing families shift to government shelters in the monsoon season and return after it ends. A few have built stilt houses that stand on columns to fight tidal floods.

Murukesan knows the sea is rising, but it's the backwaters that make him more anxious. The backwaters have become shallow due to the silt deposited by heavy floods. During heavy rain events, the water inundated the island.

"We are caught between the sea and the backwaters. They are likely to swallow the island in some years, but I am not going anywhere," Murukesan said. was born here, and I will die here."

### Need to break cycle of panic, not let fatigue diminish efforts on pandemic preparedness: Mandaviya

NEW DELHI, April 18 (PTI): Union health minister Mansukh Mandaviya on Tuesday stressed on collectively breaking the cycle of panic and not letting pandemic fatigue diminish the country's efforts of preparedness against the coronavirus situation.

In his keynote address at the concluding session of the second G20 Health Working Group Meeting, he said India's G20 Presidency plans to continue the momentum brought during Italy and Indonesian presidency and consolidate the efforts made so far towards health emergencies preparedness, prevention and response.

About the impact of the Covid-19 pandemic on the healthcare systems around the world, the Union minister said, "It is essential for us to collectively break the cycle of panic and neglect and not let the phenomenon of pandemic fatigue diminish our ongoing efforts on pandemic preparedness, prevention and response.'

He also highlighted the need for a formal global coordination mechanism for medical countermeasures and noted that India has proposed the agenda of digital health and innovation to promote the use of technology in health service delivery, bridging the digital divide across the world and promoting digital public good.

"As G20 Health Working Group, we are heading in the right

### Demands for caste census, removal of reservation cap: Opposition's 'Brahmastra' against BJP in 2024?

NEW DELHI, April 18 (PTI): The opposition parties are yet to firm up an alliance for the 2024 Lok Sabha elections, but their unanimous demands for a caste census and the removal of reservation cap could be a binding factor and hand them what a section of leaders feels the "Brahmastra" to counter the BJP and its Hindutva plank.

The issues of caste census and reservation not only put all opposition parties on the same page but leaders feel it could also help them win back many backward classes who have veered towards the BJP in the recent past.

At a DMK-convened conference, RJD leader and Bihar deputy chief minister Tejashwi Yadav summed it up for opposition parties when he had said that the best way to beat the BJP's politics of "polarisation" was through social justice-based politics.

This formula has been adopted by the Congress with much enthusiasm with Rahul Gandhi making an aggressive pitch for a caste-based census and the removal of 50 per cent cap on reservation in his recent speech in Karnataka's Kolar, in a bid to turn the tables on the BJP that had been gunning for him over his 2019 "Modi surname" remarks alleging that he insulted OBCs.

The BJP has hit back at Gandhi for his remarks, alleging that he is being "disingenuous" with his claim on the issue of social justice when the erstwhile Siddaramaiah-led Congress government in Karnataka did nothing to address long-pending demands of Scheduled Castes (SCs), Scheduled Tribes (STs) and Other Backward Classes (OBCs). The Opposition has spoken with unanim-

ity on general issues such as inflation and rising employment but lacked cohesiveness on specific issues like the Adani matter.

However, with the issues of caste-based census and removal of reservation cap, opposition parties have found an arrow with which they can hit multiple targets at one go

-- it forges instant unity in the opposition ranks, puts the BJP on the back foot as it is yet to spell out its stance on them categorically, and prepares a counter for the Hin-



dutva push expected closer to the polls. With the Congress aggressively taking up the issue, it is likely to endear the party to regional outfits which have till now been cir-

cumspect of the grand old party fearing that it may play the "big brother" by superseding their agenda with issues of its own.

Asked about the Congress' strong pitch, Congress general secretary Jairam Ramesh told PTI, "The demand for a caste-based census was articulated forcefully by many civil society groups to Rahul Gandhi during Bharat Jodo Yatra. The Congress is following through on that demand.

A socio-economic caste census was conducted by the end of 2012 covering some 25 crore households but the data could not be published for various reasons, he pointed out. An example of how the issue of castebased census could be the glue for the Opposition unity is how even the Aam Aadmi Party which does not see eye-to-eye with the Congress on most issues has joined the caste-based census chorus.

The JD(U) and the RJD, which are part of the ruling 'Mahagathbandhan' alliance in Bihar, the Samajwadi Party (SP) and the Bahujan Samaj Party (BSP) have also been vociferously demanding caste-based census for a long time.

The caste census and the removal of the cap on reservation are also likely to put the BJP in a quandary and test its own outreach to the backward classes.

The BJP unit in Bihar had supported a resolution at an all-party meeting convened by Nitish Kumar and later a unanimous resolution was passed in the Bihar Assembly on caste census. However, the BJP's central leadership is yet to respond to the demand for a socio-economic and caste census.

Rajya Sabha MP Kapil Sibal said the "doublespeak" of the BJP is clear from its "ambivalent position" on the Opposition demand for publishing the figures of the castebased census of 2011.

"It (BJP) seeks the votes of the forward classes while it engages in doublespeak on backward classes," he alleged

Sibal added that just being on the same page on this issue was not enough and that the Opposition unity requires much more than this. RJD MP Manoj Jha, another prominent voice in the Opposition ranks, also underlined the importance of the castebased census issue.

"We have been demanding caste-based census, it started in 2010-11 when Lalu ji, Sharad ji and Mulayam ji raised this question and the then UPA government agreed to it. Subsequently, 2014 heralded (Narendra) Modi ji's victory and myself and other MPs raised the question as to what happened to the data and we were told that the data got corrupted. Don't know whether the corruption was of the data or somewhere else," Jha told PTI.

"The Kolar speech of Rahul ji provided a

further impetus to the demand made by several state governments and leaders from diverse political parties. It is important to see that it is not a political issue, it involves deepening of democracy, who would not want deepening of democracy, it involves psychological, social and political empowerment of communities, it involves ensuring representation in accordance with their population," the RJD leader said.

Having said that, it is important to collectively raise this issue and tell the prime minister and his party that politics cannot be rhetorical, one has to come down to the ground and look at what are the critical issues, he said.

"The critical issue is that in the governance structure and bureaucracy, the representation of SCs, STs and OBCs is negligible. Can a democracy live with such anomalies? That is our question and that is how we will take it up forward," he asserted.

Political commentator Sanjay Jha, who was once a spokesperson for the Congress party, alleged that India has been devastated by a double whammy -- unemployment crisis and extreme inequality -- under the current government.

'The biggest sufferers are those from underprivileged communities and the backward classes. No amount or number of social welfare programmes being propagated by the BJP can neutralize the deprivation and the economic destitution of millions of Indians. Therefore the Opposition is completely justified in focusing on social justice as its key political message," he told PTI.

That's why a nervous BJP is prevaricating on the caste census, as at core, it remains an upper caste party. Further, it is a party of the rich, by the rich, for the rich," he claimed

A leader on condition of anonymity said that with the BJP likely to use its Hindutva plank to consolidate its vote bank, the demands for a caste-based census and the removal of reservation cap could be the Opposition's "Brahmastra" ahead of the 2024 elections.

# Will not go into personal laws, says SC while hearing pleas for legal validation for same-sex marriages

NEW DELHI, April 18 (PTI): The Supreme Court on Tuesday made it clear that it will not go into the personal laws governing marriages while deciding the pleas seeking legal validation for samesex marriages and asked the lawyers to advance arguments on the Special Marriage Act.

A five-judge constitution bench headed by Chief Justice D Y Chandrachud termed the issue involving the pleas "complex" and said the very notion of a man and a woman, as referred to in the Special Marriage Act, is not "an absolute based on genitals"

"It is not the question of what your genitals are. It is far more complex, that's the point. So, even when the Special Marriage Act says man and woman, the very notion of a man and a woman is not an absolute based on genitals," said the bench, which also comprised Justices S K Kaul, S R Bhat, Hima Kohli and P S Narasimha.

On being pointed out the difficulties and ramifications for the Hindu Marriage Act and personal laws of various religious groups if the apex court were to hold samesex marriages valid, the bench said, "Then we can keep the personal laws out of the equation and all of you (lawyers) can address us on the Special Marriage Act (a religion neutral marriage law).'

The Special Marriage Act, 1954 is a law that provides a legal framework for the marriage of people belonging to different religions or castes. It governs a civil marriage where the state sanctions the marriage rather than the religion. Solicitor General Tushar Mehta,

NEW DELHI, April 18 (PTI): The Centre and the Gujarat government on Tuesday told the Supreme Court that they may file a plea seeking a review of its March 27 order asking them to be ready with original files on the grant of remission to the convicts in the Bilkis Bano case.

A bench of Justices K M Joseph and B V Nagarathna questioned the parole granted to 11 convicts during their incarceration period and said the gravity of the offence could have been considered by the state. It said, "A pregnant woman was gang-raped and several people were killed. You cannot compare the victim's case with standard sec-

appearing for the Centre, referred to the laws on transgenders and said there are several rights such as the right to choose partners, privacy right, right to choose sexual orientation, and any discrimination is criminally prosecutable.

cation under the RTI Act seeking background notes" of the Centre 2006 Mumbai and reports of state governments of Gujarat, Delhi and Andhra Pradesh in relation to the ban on the organisation, which was stated to have carried out the blast.

The outfit was proscribed under the stringent anti-terror law Unlawful Activities(Prevention) Act (UAPA). The petitioner challenged in the high court an order

passed by the Chief Information Commissioner (CIC) on June 13, 2019 denying him the information on the ground that it was covered under the exemptions provided in the RTI Act.

While refusing to interfere with the CIC's decision. Justice Prathiba M Singh said the information sought by the petitioner has far reaching consequences and has to be seen from the "larger issue of safety and security of the public and the nation". It said the information Siddique has sought, if provided, will have a bearing on sovereignty and security of the country.

"A perusal of the information shows that the same has far reaching consequences. The same organisation is stated to be involved in various unfortunate incidents since 2005, some resulting in severe loss of life and property," said the court.

It observed that the disclosure of the information sought by the petitioner can "jeopardize the sources" of the government in relation to the ban on Indian Mujahideen and the CIC's opinion that sharing the information would endanger the sources is "correct and

"In view of the above, the writ petition is devoid of merit and is dismissed," ruled the court. Advocate Arpit Bhargava, representing the petitioner, contended the information sought in the RTI application was needed to prove the innocence of the petitioner in the

criminal case and there was no further need to maintain confidentiality in relation to the "background notes" and the reports of the states as Indian Mujahideen has already been declared a banned organisation under UAPA.

The counsel for the Centre said the information in question cannot be disclosed as it is confidential and disclosure will be against public interest.

Siddique was awarded capital punishment for the July 11, 2006 serial blasts when seven bombs packed with RDX ripped through many western line local trains in Mumbai killing 189 people and injuring 829. The petitioner, currently lodged in a prison, claimed in his plea he was falsely implicated by the Anti-Ter-

rorism Squad of Mumbai in the train blasts case. The trial court's order of sentence is still pending confirmation by the Bombay High Court and the reports of the state governments and the Centre's background notes would prove the innocence of the petitioner as well as violation of his human rights, the plea said. Last year, the high court had dismissed another petition by Siddique challenging a CIC order denying disclosure of certain information pertaining to the sanction granted by the Maharashtra government for his prosecution under UAPA.

The high court had earlier this year rejected his petition seeking reports submitted by the Maharashtra and Andhra Pradesh governments regarding investigation into the train bombings.

### Supreme Court grants bail

Gogoi was the only one whose bail was rejected by the court and he was released after spending 567 days in iail once Special NIA Judge Pranial Das cleared him along with the three others of all charges

The NIA is investigating two cases against Gogoi related to anti-CAA protests. In one of those, the special NIA court had granted him bail, which was upheld by the Gauhati High Court too in April 2021 after the probe agency challenged it. The RTI activist continued to be in judicial custody as he was rejected bail in the second case related to anti-CAA violence and was being investigated by the NIA.

Later, the special NIA court on July 1, 2021 released Gogoi and his three associates for their alleged role in the violent anti-Citizenship (Amendment) Act stir in the state in December 2019 and observed there was nothing to indicate that the "talk of blockade" threatened the country's economic security or was "a terrorist act."

The NIA then moved the Gauhati High Court appealing it to allow the agency to frame charges under various sections, including sedition, of the IPC and the Unlawful Activities (Prevention) Act, 1967.

Our Correspondent adds: Speaking to this reporter in Sivasagar, Gogoi said that he felt much strengthened now to fight boldly for the people of the state without compromising on any issue. Gogoi said that the Centre and the state government had tried their best to put him in 'Chakrabyuehu' (in a tight corner), but the Supreme Court has granted him bail till the Lower Court completes the formalities, if any, to proceed further.

### World Heritage Day: Residents, experts lament shrinking architectural legacy of Patna

PATNA, April 18 (PTI): For 26-year-old conservation architect Diptanshu Sinha, the razing of the Dutch and British-era Patna Collectorate also led to demolition of whatever hopes he had for the revival and redemption of the historic city's "dying heritage". Heartbroken, he quit his job at an NGO that works on conservation of heritage structures, and moved to Gurugram.

"Every person has a breaking point. I couldn't take the razing of the collectorate building which had preceded a wave of demolition since 2010. The last structure in the collectorate campus to go down was the frontage of its famed Dutch-era Record Room which had magnificent columns, and carried within its wide walls, centuries of history of urban evolution of Patna," Sinha said.

Patna Collectorate -- the headquarters of the district administration -- consisted of a cluster of buildings, including the 17th-century Record Room and old District Engineer's Office, both from the Dutch era; and the British-era DM Office Building and the iconic District Board Patna Building of 1938. According to him, what the centuries-old collectorate building needed was a "human touch of restoration" and instead it got the "cold claws of bulldozers"

Sinha claimed that Patna gets excited about the opening of a new mall. But heritage is not on its agenda, and World Heritage Day is rather alien to them, he said. World Heritage Day is celebrated on April 18 every year to raise people's awareness about the diversity of cultural heritage and the efforts that are required to protect and conserve it. "The city has become ruthless when it comes to heritage. The government destroys old buildings in the name of development and people look the other way without any



guilt," Sinha alleged. He was a part of the citizen-led movement 'Save Historic Patna Collectorate' that fought for six years to save the landmark, which featured in the Oscar-winning film "Gandhi", from demolition.

The Supreme Court on May 13 last year rejected a plea by INTACH to save the landmark. and bulldozers rolled in the next day. The cluster of buildings in the 12-acre Patna Collectorate campus were razed in phases, the last demolition taking place in late December.

Prior to this, over a century-old Gole Market was dismantled in 2019 to make way for a smart city project, the 1885-built Anjuman Islamia Hall was razed in 2018, Bankipore Central Jail in 2010, and a range of other heritage buildings in the last 13 years, including the City SP Bungalow, Civil Surgeon's Bungalow, District and Sessions Judge Bungalow, New Police Line Building, among others. Many historians and architects have criticised the razing of the historic Patna Medical College and Hospital buildings in a phased manner for a redevelopment project. The 100-year-old Sultan Palace has also been facing the threat of demolition since June last year.

"They want to give new projects to people. There is nothing wrong with that but it is happening at the cost of our heritage. Recently, a major portion of the historic Cancer Block of the PMCH was dismantled for a Patna Metro corridor and PMCH station. Given the maniacal pace of insensitive development, everything old will be erased in a few years," rued 19-year-old Aman Lal. Lal, a student of Patna College, claimed the city was under a "development overdrive" with "scant regard for old buildings and other heritage structures"

Mumbai-based conservation architect Abha Narain Lambah, who has worked on conservation projects in many cities, some of which have won UNESCO awards, said demolition of old buildings "denudes the character" of historic cities. "What separates Patna from Delhi, Mumbai from Lucknow, Noida from Calcutta, are the old buildings. These structures are part of our composite urban fabric and should not be treated as a burden or a liability, but an asset," she told PTI. "Demolition of old buildings leads to erasing tangible heritage and collective memories of a city. Patna should act wisely when it comes to its heritage buildings," Lambah said.

On World Heritage Day, many other experts also pitched for preserving the past while building a future in Patna, saying that "restoration and not demolition is the way forward". Kamalika Bose, a conservation architect from Mumbai who recently visited Patna, said, "The lament and criticism over the loss of built heritage were evident while interacting with longtime residents and old-timers." "While much may be lost, it is never too late for a turnaround A concerted effort to safeguard, restore and reuse what remains is most essential," she said.

### Mercury soars across India

respectively. Cloudy weather and light rain may provide some relief from the heat in the city on Wednesday, the India Meteorological Department (IMD) said. The IMD said a western disturbance active over the western Himalayan region is predicted to bring light rain in the northwestern plains starting Tuesday.

Earlier this month, the MeT office predicted above-normal maximum temperatures for most parts of the country from April to June, except parts of the northwest and the peninsular regions. Above-normal heatwave days are expected in most parts of central, east, and northwest India during this period. The meteorological department has issued an 'orange' alert with a warning of severe heatwave conditions for two days from Tuesday in Patna, Banka, Jamui, Nawada, Aurangabad, Supaul and several other districts of Bihar.

Besides, a 'yellow' warning has also been sounded in Begusarai, Nalanda, Gaya, Arwal, Bhojpur, Rohtas, Buxar, Khagaria and Munger regions of the state. The meteorological department uses four colour codes - green (no action needed), yellow (watch and stay updated), orange (be prepared) and red (take action) - for weather warning. "People are advised to avoid heat exposure and dehydration," a senior official of the Bihar Disaster Management Department said. In West Bengal, Bankura recorded the highest temperature at 43.7 degrees Celsius, while capital city Kolkata's maximum was 40 degrees Celsius.

Hot weather conditions continued to prevail in Haryana and Punjab with the maximum temperature settling above the 40 degree-mark in most parts of the two states.

In Haryana, sizzling heat swept across Hisar as the mercury settled at 41.4 degrees Celsius, according to a report of the meteorological department here. Karnal also experienced a hot day recording a high of 40.7 degrees Celsius. Ambala recorded a high of 39.7 degrees Celsius, Narnaul recorded a high of 40.2 deg C while Bhiwani registered a high of 39.6 degrees Celsius. Bathinda in Punjab recorded a maximum temperature of 41 degrees Celsius. The mercury settled at 36.6 degrees Celsius in Amritsar and at 41.2 degrees Celsius in Patiala. Chandigarh, the common capital of the two states, recorded a high of 39.4 degrees Celsius.

Prayagraj and Hamirpur in Uttar Pradesh were the hottest at 44.2 degrees Celsius, with the weather department predicting rain/thundershower at isolated places over western parts of the state. Lucknow recorded the maximum temperature of 41.3 degrees Celsius and a minimum of 24.5 degree Celsius.

The desert state of Rajasthan also saw the temperature rising with Chittorgarh recording 43.2 degrees Celsius followed by Kota (42.8 degrees), Banswara (42.7 degrees), Phalodi (42.2 degrees), Dholpur (42 degrees), Alwar and Sawai Madhopur (41.7 degrees each), Tonk (41.6 degrees), Churu and Pilani (41.4 degrees each), Barmer (41.2 degrees) and Jaipur (40 degrees Celsius).

However, the MeT has predicted light rain and thunderstorm in Jodhpur and Bikaner divisions and in Jaipur, Ajmer and Bharatpur divisions on April 19 and 20. It has also predicted a fall in temperatures by 2-3 degrees in the next two days. Reeling under the scorching sun, people in lower hills of Himachal had some relief as maximum temperatures dropped by few notches following light rains at several places. Una recorded a high of 37.4 degrees, while Dhaulakuan was hottest in the region with a maximum temperature of 38.7 degrees.

The popular tourist destinations of Shimla, Manali, Dharamsala and Narkanda posted a high of 25.4 degrees, 21 degrees, 28.2 degrees and 19.2 degrees Celsius, respectively.

The Andhra Pradesh State Disaster Management Authority (APSDMA) forecast severe heat wave conditions in one mandal and heat wave conditions in 117 more across the state on Tuesday.

"While the heat wave is expected to hit seven mandals in Alluri Sitarama Raju district, 16 in Anakapalli, four in East Godavari, two each in Eluru, Palnadu, Visakhapatnam and Nandyala, six in Gunturu and 10 in Krishna," the disaster management department said in a statement.



he added. Dhulia remembers watching Ramesh Sippy's 1975 classic "Sholay" at the age of eight, which left a huge impact on him. He also loved watching Westerns such as George Roy Hill's "Butch Cassidy and the Sundance Kid" and 'The Cowboys', among others.

"I was amazed with the visuals 'Sholay' had, I had not seen something like this before, even the characters, the shot taking... I had no knowledge about shot taking but it was all making an impact on me. I would like Westerns, war films, so (all) these films I have loved watching, they have had an influence on me," Dhulia added.

"Garmi" revolves around a young man who moves out of his hometown with aspirations of becoming a civil servant but stumbles into the world of college politics, powerplay and crime.

"I started digging into it long back, my first film ('Haasil') was on student politics. I wanted to revisit this part of society. It's been 20 years and it was interesting to explore the world after 20 years, like what has happened in society.

"The world is volatile, exciting. It is about a boy and they are all young, 22 or 23-year-old and how politics affects them. I wanted to revisit that area again, how society has changed. It (subject) is very close to me, my first movie," Dhulia said.

Liverpool hadn't tasted victory in more than six weeks, since routing Manchester United 7-0.

But after Cody Gakpo's opener and Mohamed Salah's quickfire addition for a 2-0 halftime leadon Monday, Liverpool tore apart Leeds in the second half. Salah and Diogo Jota finished with a pair each, and Darwin Nunez came off the bench to score late.

Leeds halved the deficit two minutes after the break when Ibrahima Konate was caught in possession by Luis Sinisterra, who lifted his effort over goalkeeper Alisson to make it 2-1.

But the Leeds defense collapsed in familiar fashion, suffering consecutive heavy home defeats eight days after losing to Crystal Palace 5-1. Leeds has conceded 60 league goals, more than any other side,

Liverpool remained eighth in the standings, two points behind Brighton. Leeds' survival hopes were dealt another big blow by staying 16th, two points above the drop zone.

The sport's national governing body said it assessed the eligibility of prospective transgender players on a case-by-case basis at the professional and semiprofessional levels.

"We acknowledge we're still on a path of education and understanding," Basketball Australia said.

"To aid us in developing our framework, Lexi will provide feedback and advice from her experiences. "The balance of inclusivity, fairness and the competitive nature of sport will always be a complex area to navigate." Rodgers responded by saying she still hoped to play at the elite level in future and "I

to play in the NBL1 this season. hope Basketball Australia understands that this is not the end of my journey as an athlete and that it must not miss future opportunities to demonstrate its values."

"I am sad about the potential message this decision sends to trans and gender diverse people everywhere," Rodgers wrote in an Instagram post.

"I hope that one day basketball's governing body can replithe inclusion and cate acceptance I have found on the court with my teammates."

Suzy Batkovic, a three-time Olympian and member of Basketball Australia's expert panel, thanked Rodgers for cooperating in a process that is a "complex space that continues to evolve."

"As we continue to develop our own framework for sub-elite and elite competitions, we understand the need to have a clear process and continual education within all layers of the sport so we can best support players, coaches, clubs, associations and the wider basketball community," Batkovic said.

Last month, t rack and field banned transgender athletes who have transitioned to female from elite women's international competition

The World Athletics Council adopted the same rules as swimming did last year in deciding to bar athletes who have transitioned from male to female and have gone through male puberty.

### **Boston Marathon** sweep for Kenya, but not favorite **Kipchoge**

fending Boston Marathon champion Evans Chebet wasn't focused on beating Eliud Kipchoge, the world record holder considered the greatest marathoner of all time.

Conquering the course was the goal. Chebet won the world's oldest and most prestigious marathon on Monday for the second year in a row, leaving Kipchoge behind at Heartbreak Hill to spoil the two-time Olympic gold medalist's muchanticipated debut and win in 2

hours, 5 minutes, 54 seconds. Gabriel Geay of Tanzania won a footrace for second, finishing 10 seconds behind the winner and two seconds ahead of Kenyan Benson Kipruto. Kipchoge finished sixth — just his third major marathon loss to go with 12 victories.

"When we race, we don't race against an individual," said Kipruto, the 2021 winner and Chebet's training partner. "When we woke up this morning, we were going for a race, not for an individual. ... And that's what happened." Hellen Obiri, a twotime Olympic silver medalist in the 5,000 meters, won the women's race in 2:21:38 to complete the Kenyan sweep. Amane Beriso of Ethiopia was second, 12 seconds back, followed seven seconds later by Israeli Lonah Salpeter. "I tried to be patient and wait for the right time to happen," said Obiri, who fin-

BOSTON, April 18 (AP): De- ished sixth last fall in New York in her marathon debut. "Today was my time." It was the third straight Kenyan sweep. Obiri is the 15th Kenyan to win the distaff division since 1966. Chebet is the 25th Kenyan men's champion and fourth in a row; he is the first man to defend his Boston title since Robert Kipkoech Cheruiyot won three in a

row from 2006-08. Chebet's time was the sixthfastest in course history. Kipchoge finished in 2:09:23, the slowest marathon of his career.

"In a marathon anything can happen," Obiri said of the men's race. "It was a strong field, and everybody was there to race."

Chebet was in a lead pack that dropped Kipchoge around Mile 20, shortly after he missed his bottle at a water station. Geay, Kipruto and Chebet pulled away with about three miles left, and Chebet made his move in the final mile. "Most of them blew up. Even Eliud Kipchoge blew up," said Scott Fauble, who finished seventh and was the top American. "I almost caught him." Kipchoge had been hoping to add a Boston Marathon victory to his unprecedented running resume. The 38-yearold has won four of the six major marathons; Boston is the only one he has competed in and failed to win. (He has never run New York.) He also broke 2 hours in an exhibition in a Vienna park.

### Kohli fined 10 % of match fee for IPL code of conduct violation

BENGALURU, April 18 (PTI): Royal Challengers Bangalore (RCB) batter Virat Kohli has been fined 10 per cent of his match fee for breaching the Indian Premier League (IPL) Code of Conduct during the team's eight-run loss to Chennai Super Kings (CSK) at the Chinnaswamy Stadium. A statement said that Kohli had breached the rules under Article 2.2 of the IPL Code of Conduct. While the IPL statement did not go into details about the incident, which attracted the code of conduct violation, it could have been due to the former RCB skipper's over-the-top celebration following CSK middle-order batter Shivam Dube's dismissal off the bowling of Wayne Parnell on Monday. Dube struck a 27-ball 52 in CSK's mammoth 226 for 6 in the 'Southern Derby' as Mahendra Singh Dhoni's team won by eight runs. ### Inter coach Inzaghi under pressure ahead of Benfica match

MILAN, April 18 (AP): Winning the Champions League may be Inter Milan coach Simone Inzaghi's only chance to keep his job.

Inter has had success this season, winning the Italian Super Cup and reaching the semifinals of the Italian Cup. And the team can reach the last four of the Champions League on Wednesday when it faces Benfica at San Siro in the second leg of the quarterfinals with a 2-0 lead from the first match. But it's in Serie A where Inter has been struggling, and Inzaghi is feeling the pressure because of it. Saturday's 1-0 loss to Monza was Inter's 11th league defeat in 30 matches and left the team in fifth place in Serie A. two points behind fourth-place AC Milan. "I don't find it strange," Inzaghi said of his situation on Tuesday. "I'm used to it. It's better that they criticize me rather than my players. This criticism gives us the motivation to work even harder. "We haven't been good enough in the league. We haven't had an 'Inter' season. Like other teams, we've had our issues, but there's still time. We now need to focus on giving our fans a great evening that would see us go through to the quarterfinals. It would be a massive milestone." Inter has only won one of its past eight matches in all competitions - although that was last week's victory at Benfica. "We know what we've done in the cups and that our standings in the league table aren't what we wanted but our only focus now is Benfica," Inzaghi said. "We know that we have the lead but we'll need to be at our best against a team that hasn't been getting results lately but is still really dangerous." If Inter prevails against Benfica it will face an Italian team in the semifinals — either AC Milan and Napoli.

**BENGALURU, April 18 (PTI):** Royal Challengers Bangalore allrounder Glenn Maxwell feels Chennai Super Kings' left-handers did the trick for the four-time champions by exploiting the shorter boundaries to the hilt to earn a crucial eight-run win in their IPL clash here. CSK won the high-scoring 'Southern Derby' on Monday, with three of their left-handers -- opener Devon Conway (83 off 45 balls), middle-order bat Shivam Dube (52 off 27) and Moeen Ali (19 not out off 9) -- helping them amass 226 for 6, which proved to be a winning total. "I think with short boundaries (at the Chinnaswamy Stadium), they played heavy left-handers. Devon Conway batted for a long period in that innings," said Maxwell, who could have taken the match away from MS Dhoni's side had he remained at the crease for a little bit longer. The Australian all-rounder, who struck his second half-century in this IPL, added that bringing in left-arm spinner Shahbaz Ahmed to bowl to left-handers would have

been a risky proposition. "I think, it would have been a risk to bowl Shahbaz Ahmed to those guys," said Maxwell, though he added that the 28-year-old all-

I've generally played well. I think the pressure, the new ball swinging, it's a pretty familiar role that I played (against CSK). Especially for Australia, I've played that role many a times. Even at this ground in international cricket, when it comes to mind, it's not something that is foreign to me chasing big totals." he added.

Maxwell said Faf took the pressure off him early on in the innings and helped him to build the momentum later on in powerplay.

"I think I have a really clear mindset, the role that I have to play. I think together with Faf, he took a lot of pressure off me early on in my innings. I was able to take that momentum going towards the

GALLE, April 18 (AP): Sri Lanka defeated Ireland by an innings and 280 runs inside three days of the first test and recorded its biggest victory margin on Tuesday. Ireland lost 13 wickets on the day to be all out for 143 and 168 in reply to Sri Lanka's 591-6 declared.

Slow left-armer Prabath Jayasuriya led the Sri Lankans with a 10-wicket haul, taking the last wicket of the match when he trapped Ben White for 1 soon after tea. Jayasuriya took 3-56 in the second innings after a career-best 7-52 in the first. Spin bowling partner Ramesh Mendis had the best figures in the second innings of 4-76 and a match haul of five wickets. Mendis equalled Dilruwan Perera in becoming the fastest Sri Lankan to 50 test wickets in 11 matches. Seamer Vishwa Fernando took the other four Irish wickets, including opener Murray Commins for a pair. The win surpassed Sri Lanka's previous highest victory margin of an innings and 254

nings was built on centuries by Karunaratne (179), Kusal Mendis (140), Dinesh Chandimal (102) and Sadeera Samarawickrama (104). Ireland began day three on 117-7 and lost its last three wickets all on 143. Lorcan Tucker made a team-high 45 when he tried to sweep Jayasuriya and missed. Mark Adair was stumped off Jayasuriya and Ramesh Mendis finished the innings. Forced to follow on 448 runs in arrears, Ireland was 41-5 by lunch. While the bowlers were pinning down Ireland, Nishan Madushka was also outstanding in the field. His sharp low grab at short leg removed Peter Moor minutes before lunch, and his anticipation of a paddle sweep ended the 60-run resistance between Curtis Campher and Harry Tector. Tector was dismissed shortly after, run out for 42 after slipping while trying to return to his crease and losing his bat. Ireland was 108-7 and lasted 15 more overs. Ireland played only its fifth test, and was involved in its first test series. The second and last test starts at the same venue on Monday. "Sri Lanka at home are a daunting prospect for any team, never mind a team that haven't played a lot of test cricket," Ireland captain Andrew Balbirnie said.

### CSK batters targetting 200-plus strike rate; tech shouldn't interfere with game: Conway

BENGALURU, April 18 (PTI): Chennai Super Kings opener Devon Conway has sounded an ominous warning to his team's opponents, saying his side has been aiming for 200-plus strike rates on good batting surfaces to put up imposing totals, which give them better chances of winning matches.

Monday was one such day when the four-time champions scored a mammoth 226 for 6 at the Chinnaswamy Stadium, and despite the onslaught from Royal Challengers Bangalore (RCB) skipper Faf du Plessis (62 off 33 balls) and Australian all-rounder Glenn Maxwell (76 off 36balls), CSK still managed to win by eight runs.

Conway (83), Ajinkya Rahane and Shivam Dube played a pivotal role with the bat, scoring at a strike rate of more than 180 to help CSK post the big total.

"Tonight (Monday) was a really good surface to bat on, so for us to get those big totals it's about trying to create a strike rate of around 200-plus," said Conway at the post-match press conference.

The New Zealander said that though he was some way off the 200-plus strike rate, he was happy Rahane (37 runs, 185 strike rate), Dube (52, 192.59), Ambati Rayudu (14, 233.33) and Moeen Ali (19 not out, 211.11), had brilliant strike rates. "I didn't manage to achieve that (200-

plus rate) but some of the work done by the other players, like Ajinkya, Dube, Rayudu and Moeen Ali in the end, they all chipped in with really good strike rates and that's what got us to a very competitive total.

"That's probably the method on this kind of wicket where it's really good to bat," added Conway, who scored at a strike rate of 184.44.

The 31-year-old left-hand batter had a lot of appreciation for skipper Mahendra Singh Dhoni for holding on to the two skiers behind the stumps to dismiss the two most dangerous batters Du Plessis and Maxwell.

The New Zealander said he was confident someone like Dhoni would never fluff those skiers -- one of the toughest catches to take in night games.

"Those (Faf and Maxwell) were very tough catches because it is not easy to catch balls that go straight up in the dark



night. I was very lucky to have MS (Dhoni) with the gloves on because if there is any person you want to take those tough chances, he's probably your guy. it was good for us (to) break the momentum of the innings and ultimately helped us win the match," added Conway. Conway indicated CSK players could

have come under pressure while defending the big total, which probably led them to drop a couple of catches.

"No one tries to drop catches on purpose, these things happen. I don't know if there was pressure on the fielders or what it was. Thankfully, it wasn't costly for us but we've got to keep practicing under pressure, take those half opportunities. Thankfully, we bowled well and that helped repair (the damage from) those dropped catches. "Before we went on to the field, MS said we are going to be put under pressure at times. The momentum that they (RCB) had was brilliant. Faf and Glenn put us under pressure but we always felt that by having 200plus on the board, if we get a couple of wickets we could always bounce back.

"So, for our bowlers it was clear -- be patient and when the opportunity comes you just take them with both hands."

Conway indicated it wasn't easy for players to go about their job seamlessly with the shadow of the hovering spider cam causing problems. He added that things shouldn't come to a point where technology interferes with the game.

"It (interference) happened a couple of times where the ball had got very close to the spider cam as well as the wires, that can obviously put a fielder off. I thing Faf stepped away a couple of times because the shadows of the spider cam was in his way. It's obviously a little bit testing for guys.

"It's nice to have that technology to show different angles of the game but there come a point where (it) can't get too involved and interfere with the game. MS (Dhoni) was probably trying to speak to the umpires, saying 'don't get too close to the action and try to avoid too much (of what's) going on,"said Conway.

Conway praised young Sri Lankan bowler Matheesha Pathirana's efforts in winning the match for CSK.

Pathirana's superb bowling in the 18th and 20th overs -- he dismissed Shahbaz Ahmed (18th over) and gave away just 10 runs in the last over besides taking the wicket of SS Prabhudessai -- helped CSK stall RCB's charge.

"Yes, I think a special effort from Matheesha to come into the team and a first game for him this year in the IPL and execute (his plan) under pressure like that. It was brilliant.

"He is very unorthodox and I personally haven't faced a ball from him, haven't faced him at the nets. It was very crucial to have him with us tonight and execute his plans that ultimately got us the win."
