

NEW DELHI, June 8 (PTI): India has successfully carried out a night launch of new generation nuclear capable ballistic missile 'Agni Prime' from the Abdul Kalam Island off the coast of Odisha, marking a boost to the country's strategic weaponry.

The first pre-induction night launch of the missile with a strike range of 1,000 to 2,000 km was carried out on Wednesday by the Defence Research and Development Organisation (DRDO) and the elite strategic forces command, officials said.

The defence ministry said the test-firing met all the desired objectives and that it paved the way for induction of the system into the armed forces

The test-firing of the missile came amid India's lingering border row with China

"New generation ballistic missile 'Agni Prime' was successfully flight-tested by Defence Research and Development Organisation (DRDO) from Dr APJ Abdul Kalam Island off the coast of Odisha on June 7," the ministry

"This was the first pre-induction night launch conducted by the users after three successful developmental trials of the missile, validating the accuracy and reliability of the system," it said in a state-

Defence Minister Rajnath Singh congratulated the DRDO and the armed forces for the success as well as the "copy-book" performance of the new generation ballistic

The ministry said "range instrumentation like radar, telemetry and electro optical tracking systems were deployed at different locations, including two down-range ships, at the terminal point to capture flight data covering the entire trajectory of the vehicle"

"Senior officials from the DRDO and Strategic Forces Command witnessed the successful flight-test, which has paved the way for induction of the system into the Armed Forces," it said.

MUMBAI, June 8 (PTI): Equity benchmarks Sensex and Nifty surrendered early gains to close with losses on Thursday, snapping their four-day winning streak as investors pared exposure to auto, bank and IT stocks after the RBI left its key interest rate unchanged.

After remaining in the positive territory for most of the session, the 30-share BSE Sensex fell 294.32 points or 0.47 per cent to settle at 62,848.64. During the day, it tumbled 353.23 points or 0.55 per cent to 62,789.73. The NSE Nifty declined 91.85 points or 0.49 per cent to end at 18,634.55.

"Investor sentiment took a downturn following the in-line monetary policy announcement by the RBI, as the market had higher expectations for a more optimistic revision in the inflation outlook, taking into account the recent easing of inflation data.

"The RBI's decision to lower the inflation rate by only 10 bps suggests a cautious stance due to geopolitical uncertainties, the potential impact of El Nino and the increase in Minimum Support Price, Vinod Nair, head of research at Geojit Financial Services, said.

Kotak Mahindra Bank was the biggest loser in the Sensex pack,

MUMBAI, June 8 (PTI): The Reserve Bank of India crore in June. It decided 5:1 to retain the policy stance focused on "withdrawal of accommodation", which was introduced in April last year.

While consumer price inflation eased during March-April 2023 and moved into the tolerance band, headline inflation is still above the target of 4 per cent and is expected to remain so during the rest of the current fiscal, RBI governor Shaktikanta Das said announcing the monetary policy deci-

"Therefore, close and continued vigil on the evolving inflation outlook is absolutely necessary, especially as the monsoon outlook and the impact of El Nino remain uncertain," he said. "Our goal is to achieve the inflation target of 4 per cent and keeping inflation within the comfort band of 2-6 per cent is not enough.

The central bank kept its GDP growth projections for the current fiscal (April 2023 to March 2024) unchanged at 6.5 per cent while marginally lowering the retail inflation expectation to 5.1 per cent from the previous 5.2 per cent. India grew by 7.2 per cent in the previous fiscal, making it one of the fastest-growing nations in the world.

The fuller impact of a cumulative 250 basis point increase in repo rate prior to the pause since April, will be evident in the coming months, Das said.

While most global central banks have paused on rate hikes as commodity prices ease, Autralia and Canada have surprised markets this week by resuming rate hikes to combat stubbornly high inflation.

The decision to keep the stance as withdrawal of accommodation was driven by liquidity conditions easing with daily system liquidity averaging at ₹ 2.3 lakh

to a significant rise in government expenditure and a decline in currency in circulation.

The RBI reiterated its "watchful stance" to emerging risks and a commitment to maintain price stability

With the Reserve Bank of India pausing its rate hike cycle, IIFL remains optimistic about raising the entire ₹ 1,500 crore in this tranche of issues with an attractive 9 per cent coupon rate.

"We expect to raise the full subscription amount in this issue due to the attractive coupon rates. Credit growth is robust after the Covid-19 pandemic," IIFL director Gaurav Mishra said. The IIFL bonds offer a coupon rate starting at 8.35 per cent for 24 months and the highest effective yield of 9 per cent per annum for a tenor of 60 months. IIFL has kept the highest coupon rate at 9 per cent, the same as its last NCD issue in January, in which it announced raising up to ₹ 1,000

RBI retains FY24 GDP growth forecast at 6.5 pc MUMBAI, June 8 (PTI): The Reserve Bank on

Thursday retained the GDP growth projection for current fiscal year at 6.5 per cent, on the back of supportive domestic demand conditions.

In April, the central bank had marginally revised upwards the 2023-24 GDP growth projection to 6.5 per cent, from its earlier forecast of 6.4 per cent.

Domestic demand condition remains supportive of growth and also the demand in rural areas is on the revival path, RBI governor Shaktikanta Das said while announcing the 2nd bi-monthly policy for

₹ 2,000 notes worth ₹ 1.80 lakh crore have come back in banks so far: RBI Governor

MUMBAI, June 8 (PTI): Reserve bi-monthly monetary policy here. Bank governor Shaktikanta Das on Thursday said about 50 per cent of ₹ 2,000 notes in circulation has come back in the banking system since the RBI announced withdrawal of the highest denomination currency last month. As on March 31, 2023, he said, ₹ 2,000 notes worth ₹ 3.62 lakh crore were in circulation. "So far, ₹ 1.80 lakh crore have come back after the announcement," he said during an interaction with media after releasing the

About 85 per cent of ₹ 2,000 notes

are coming as deposits in bank accounts and this is in line with expectation, he said. On May 19, the Reserve Bank of India (RBI) announced the withdrawal of ₹ 2,000 denomination banknotes as part of its currency management and permitted the exchange of such notes (up to ₹ 20,000 in one go) from May 23 onwards. The exchange or deposit window is available till September 30, 2023.

We are only pausing on rates, too early to call on inflation fight: Das

Future policy actions will purely be data-dependent


MUMBAI, June 8 (PTI): After unanimously pausing for the second time in a row, the Reserve Bank on Thursday reiterated that leaving the key rates and the stance unchanged "is not a pivot but only a pause" and that future policy actions will purely be data-dependent as a durable fall in inflation is still a long way.

Earlier in the day, the RBI governor-led rate-setting panel MPC unanimously left the repo rate unchanged at 6.50 per cent and maintained that they will continue to work towards withdrawing policy accommodation.

The six-member panel also reiterated continuing measures to bring inflation under the target in a durable While consumer price index -based

inflation eased in March and April and moved into the tolerance band, headline inflation is still above the mandated target of 4 per cent and is expected to remain so during the rest of the current fiscal, said governor Shaktikanta Das announcing the mon-

"Therefore, close and continued vigil on the evolving inflation outlook is absolutely necessary, especially as the monsoon outlook and the impact of El Nino remain uncertain. Our goal is to achieve the inflation target of 4



per cent in a durable manner and not just keeping inflation within the comfort band of 2-6 per cent," Das told reporters at a post-policy presser.

The governor parried repeated questions from the media about what holds back the MPC and RBI from uttering the words 'end of rate hikes' or the beginning of a neutral or accommodative policy stance.

"It is not a pivot; I reiterate this is only a pause, which is the second one in two successive reviews. Our future policy actions will purely be dependent on evolving situations. Because even though the recent fall in headline inflation to within the target band (led mainly by the cooling core inflation), we need to ensure that it is durable, and therefore there is no room for

complacency on inflation," Das said. Explaining that RBI is only on a pause and that there is no change to a neutral/accommodative stance, Das said, "our objective is to ensure that inflation aligns with the mandated target on a durable basis and not a one-

"I wish to emphasise that we will do whatever is necessary to ensure that long-term inflation expectations remain firmly anchored. The Reserve Bank will remain watchful and proactive in dealing with emerging risks to price and financial stability"

"Therefore, given the uncertainties, we need to maintain 'Arjuna's eye' on the evolving inflation scenario. Let me re-emphasise that headline inflation still remains above the target and being within the tolerance band is not enough. Our goal is to achieve the target of 4 per cent, going forward," the governor said, adding it is always the last leg of the journey that's the

His deputy and the head of the monetary policy department at the central bank, Michael Patra said the policy stance and inflation forecast for the year wherein they expect the prices index to hover around 5.1 per cent for the year, the impact of the MSP hike for paddy (10-12 bps) and

the likely impact of the El Nino on the monsoon are factored in.

This forecast, it can be noted is a marginal improvement from the April forecast, when it had projected the prices to average at 5.2 per cent during FY24. Retail inflation fell sharply to 4.7 per cent in April from 6.4 per cent in February, on the back of favourable base effects, with softening observed across all the three major groups. In March, it fell to 5.67 per cent from 7.79 per cent in Febru-

The MPC retained the growth projections for the fiscal at 6.5 per cent. The economy grew 7.2 per cent in the previous fiscal. On growth, Das said higher rabi crop production, expected normal monsoons, continued buoyancy in services and softening inflation should support household consumption. On the other hand, given the healthy twin balance sheets of banks and corporates, supply chain normalisation and declining uncertainty, conditions are favourable for

the capex cycle to gain momentum. Robust government capital expenditure is also expected to nurture investment and manufacturing activity. RBI had since May 2022, cumulatively raised the repo rate by 250 basis

Balasore mishap an eye-opener

The recent horrific train crash in Balasore district, Odisha has sent shockwaves throughout the country and beyond. With 288 lives lost and over 1100 injured, the collision between a speeding train and a stationary goods train has highlighted the pressing need to address the safety concerns in India's railway system. While the government had been promoting Indian Railways as a smart and modern transport system, the Balasore incident has shattered this illusion, prompting a demand for a thorough investigation into the root causes of the tragedy. The Modi government's emphasis on transforming Indian Railways into a speedy and technologically advanced system, exemplified by the inauguration of Vande Bharat trains and a substantial budget allocation of over INR 2.4 lakh crore, has created an atmosphere of hype. However, the Balasore crash serves as a heart-rending wake-up call, exposing the reality that all is not well within this massive transportation network. This tragic incident is not an isolated occurrence but rather a symptom of systemic issues within Indian Railways. A recent Performance Audit report by the Comptroller and Auditor General (CAG) reveals alarming deficiencies. Inspections conducted by track recording cars, which assess the structural and geometrical features of rail tracks, suffered from a shortfall of 30-100 percent. Of the 1129 derailments during the period of 2017-21, 422 were attributed to engineering problems, including inadequate track maintenance and deviation beyond permissible limits.

The CAG report also highlights a funding shortage for necessary safety measures. Since 2017-18, safety-related works were brought under the Rashtriya Rail Samraksha Kosh (RRSK), with the railways expected to generate 20 percent of the allocated funds from their internal resources. However, due to the government's cost-cutting policies, which require institutions to generate their own funds, the railways struggled to meet the financial burden. Consequently, the spending from RRSK declined, particularly for Priority 1 works addressing derailments and level crossings. Compounding these safety concerns is the severe shortage of manpower in the railways. The existence of nearly three lakh vacant non-gazetted posts has been acknowledged by the railway minister himself. The overworked loco staff, facing a shortage of 471 out of 5229 sanctioned positions in the south zone, are often forced to work for more than 12 hours consecutively. Such a critical shortage of personnel compromises the safety and well-being of both railway employees and passengers.

Prime Minister Modi and his government must demonstrate a commitment to accountability and responsible governance by holding themselves answerable for this devastating disaster. It is high time that the Modi government takes immediate action to address the deep-rooted safety concerns plaguing Indian Railways. A comprehensive assessment of the railway system's infrastructure, track maintenance, signaling systems, and human resource requirements is imperative. Adequate funding, strict adherence to safety protocols, and transparent decision-making processes must be prioritized to prevent such tragic accidents in the future. The Balasore train crash should serve as a wake-up call for the nation and a catalyst for transformative change within Indian Railways. The lives lost and the lessons learned from this tragedy must not be forgotten. The government, the railway authorities, and the public at large must unite in their efforts to rebuild and restore trust in the railway system, ensuring that the safety and well-being of passengers remain paramount. Only then can Indian Railways truly become a safe, efficient, and reliable mode of transportation for all.

AI can avert train accidents

The drastic collision of three trains in Odisha's Balasore brought the issue of railway safety to the fore. With the tragic death of nearly 288 passengers, it is one of the biggest train accidents in India. The results of the detailed investigation will come later, but initially, it is feared that a wrong signal, technical fault. human error, or some 'manual tinkering' could be the possible reason for this unfortunate accident. In the mishap, the Chennai-bound Coromandel Express rammed into a goods train, following which the Howrah-bound Yesvantpur Express slammed into damaged compartments four minutes later. I have been keenly interested in rail technology since childhood. While

studying at Govt Inter College, Budaun (UP), I was rewarded by the Uttar Pradesh government for making a New Type of Rail Joint in the early 80s. I had proposed joining the ends

of two rails, having a 45-degree angle cut, which was widely appreciated in the media and Bharatiya Rail as well. The innovative theory was examined by the Research Design and Standards Organisation (RDSO) Lucknow, which works under the Ministry of Railways. Later, more advanced techniques came into practice for the rail joints.

the rail joints.

What I feel now is that safety in railways can be improved to a great extent by applying Artificial Intelligence (AI) in the technical systems of the railway. AI has the ability to rapidly process large amounts of data and information, resulting in early warnings about critical equipment failures and potential outages. AI has introduced

several new dimensions to ensure safety in the railways. By analyzing data in real-time, the system can detect potential hazards, such as AI-powered cameras monitoring track conditions and alerting crews if anything unusual is detected, which could lead to a train derailment. Thus it can reduce the probability of accidents.

By analyzing passenger numbers, demand, schedules, and availability of tracks with the help of AI, efficient use of resources can be determined. This will reduce the problem of late running of trains and also improve the overall passenger experience. AI can predict passenger demand by analyzing passenger behavioural data. This will make it possible to optimize the train schedule and make sure that the trains are run

on time. AI can improve operational efficiency in the rail industry by analyzing potential delays. These are just some of the ways AI is already benefiting the

railways. Smart technology can make train journeys safer, more efficient, and more comfortable.

Ever since the practice of digital payment and UPI payment has grown in India, each and every paisa is automatically calculated at a fraction of a second. Transactions worth millions of rupees are being done round the clock with absolute efficiency and trust. This development has ended the dependence on banks or calculators to a great extent. Be it the stock markets or the consumer markets, everywhere all the calculations are done in the blink of an eye. More Russian oil is making backdoor entry into NATO nations via Saudi Arabia, UAE

The cat is out of the bag. India is not the only country using imported Russian oil to export processed petroproducts. West Asian oil giants, led by Saudi Arabia, are buying millions of barrels of Russian diesel oil, which is banned in Europe, to sell the product to buyers in the European Union (EU). Saudi Arabia and the United Arab Emirates (UAE) are importing low priced Russian oil to jack up oil exports at higher prices to Europe. Earlier, reports suggested that India, the world's third largest consumer and importer of crude oil, was exporting Russian oil, after refining, to countries in Europe and Asia.

These reports are only partly true as India has been exporting refined oil products for many years. India has been importing crude oil from a number of countries. Lately, India has substantially raised its crude oil imports from the US, with the country's share in India's crude basket hitting a record 14.3 percent in December. While Russia has become the top source of crude oil with a share of 21.2 percent in December, India reduced its dependence on Iraq (16.9 percent), UAE (6 percent) and Kuwait (4.2 percent) to accommodate more crude imports from the US. In December, crude oil imports from the US shot up 93 per cent to 3.9 million MT.

India hardly imported crude oil from Russia till 2021. Huge transportations costs made Russian crude oil very expensive compared to India's nearby import sources from West Asia. Incidentally, India's first greenfield private sector refinery at Jamnagar in Gujarat, put up by Reliance Industries (RIL), was granted export-oriented status as early as in April, 2007. It used imported crude oil, mostly from West Asian suppliers, to make refined products for the purpose of export. The RIL refinery has an installed capacity of 1.24 million barrels per day, making it the world's largest refinery.

The situation changed after the Russia-Ukraine war began in February, last year. The western trade and financial embargo on Russia forced the latter to sell its oil and other products at large discounts. Oil imports suddenly became much cheaper from Russia. This made India go for Russian



crude oil as the country's energy market is 87 percent dependent on imported oil. Till 2020-21, India's purchase of crude oil from Russia was less than one percent of its total oil imports. India bought only 419,000 tonnes of crude oil from Russia in the first 10 months of 2020-21, which was 0.2 per cent of the total import of 175.9 million tonnes. India exported refined petroleum products worth US\$49 billion in 2021, making the country the world's third largest refined petroleum exporter. The main export destinations were Singapore (\$4.59 billion), the US (\$3.56 billion), the Netherlands

India's fastest growing export markets for refined petroleum during 2020 and 2021, well before the Russia-Ukraine war, were the US, Australia and Togo.

Thanks to cheaper Russian crude oil and higher export demand for refined products since the outbreak of the Russia-Ukraine war, India's refined petro-products exports are going up. However, it should be noted that India's total annual refined fuel exports in 2022-23 were actually lower than a year earlier as some refiners shut units for maintenance in the later half of 2022. The country's domestic consumption of petro-products during the last financial year

rose over 10 percent year-on-year to a record 222.3 million tonnes. The value of India's crude oil imports in the last fiscal was estimated at \$158.3 billion, up from \$120.7 billion in the previous year. Last year, Russia became the top crude oil supplier to India, displacing Iraq for the first time. Interestingly, Russia has also overtaken Saudi Arabia as China's top oil supplier.

In contrast, Saudi Arabia, boasting one of the world's largest oil reserves and making billions of dollars from oil exports every year, has overnight become a big importer

rich Gulf countries are capitalising on cutrate Russian oil prices. Saudi Arabia's annual crude petroleum exports would be worth \$140 billion. In addition, it has been exporting refined petroleum, ethylene and propylene polymers, and acyclic alcohols. It exports mostly to China, India, Japan, South Korea and the UAE. The only reason behind the Arab kingdom's sudden large imports from Russia is to capitalise on the price difference. Over the past several months, Saudi Arabia has been importing record volumes of oil from Russia. Saudi Arabia and the UAE are buying large quan-

tities of Russian oil at low prices to export at high prices to Europe with the US watching helplessly. Russian oil is getting a backdoor entry to the EU via Saudi Arabia and the UAE, America's two reliable West Asian allies.

According to reports, Saudi Arabia imported 174,000 barrels a day of diesel and gas-oil from Russia in April and even more during last month, as per data compiled by Bloomberg from analytics firm Kpler. The Saudi kingdom became Europe's top supplier. Record volumes of Russian diesel poured into West Asia in March as traders cashed in on low prices to stock up the fuel at the UAE's Fujairah hub and in Saudi Arabia. West Asia has quickly become a major supplier of the industrial fuel to Europe and Africa. Russian oil is helping higher output from Saudi and Kuwaiti refineries. The West Asian region took up over 10 percent of Russia's exports in February and March.

The backdoor trade of Russian oil to the EU by some of the diplomatic allies of the US in West Asia shows how futile and ill conceived the US and NATO sanctions on Russia, especially those covering the energy sector. Western nations are unsuccessfully trying to cut Russian income from oil and gas. The EU and G7 countries had set a maximum price of \$60 per barrel for Russian crude. Notably, the EU did not impose sanctions on Russian gas as Europe is heavily dependent on Russian supplies to meet around 40 percent of its gas needs. Overall, the US-led western trade and financial sanctions have hardly impacted Russia.

Thanks to its good friends such as China, India, Saudi Arabia, the UAE, and Iran, Russia posted a record current account surplus of \$227 billion in 2022. As imports fell, Russia's trade balance swelled to \$282.3 billion, last year, from \$170.1 billion the previous year. Ironically, Russia seems to be enjoying the western trade sanctions. More than a year after Russia's invasion of Ukraine, European governments are now questioning the impact of sanctions on Russia. The NATO-backed Ukraine war is escalating with the time, putting increasing pressure on European economies. (IPA Service)

Uptick in Q4 GDP growth is positive but challenges remain in current fiscal

here is jubilation in Indian government as uptick in last quarter lifted India's GDP growth in fiscal 2023 to 7.2 per cent belying expectations of less than 7 per cent growth this year. After slowing GDP growth of 4.5 per cent in third quarter, there were fears that fourth quarter performance will not be that good and growth will slide to 4.2 per cent in fourth quarter on the back of slowing world economy and monetary tightening by RBI due to stubborn domestic inflation.

stubborn domestic inflation.

India's real GDP growth rose sharply to 6.1% on-year in the fourth quarter of fiscal 2023 compared with 4.5% in the third quarter. The growth surpassed the number factored in the National Statistics Office's (NSO) second advance estimate of February. Annual growth for fiscal 2023 was revised up to 7.2% (provisional estimate) from 7.0% in the second advance estimate. According to CRISIL,

Fourth-quarter growth was primarily driven by investment and net exports, with the latter less of a drag given rising exports and slowing imports. Fixed investment turned in the strongest growth on the demand side while private consumption growth was more subdued onquarter. Manufacturing and agriculture growth improved on-quarter on the supply side even as services growth remained strong, albeit slowing a tad relative to the previous quarter. The provisional estimate of 7.2% comes on top of 9.1% expansion in fiscal 2022. This suggests strong growth momentum, which was propelled by domestic demand through the year, both from in-

vate consumption rose to an 18-year high of 58.5% in fiscal 2023.

However, nominal GDP growth tapered to 10.4% on-year in the fourth quarter compared with 11.4% in the third. This was primarily due to the price-effect, since the GDP deflator slowed to 4.1% from 6.6%. The deflator is significantly influenced by inflation based on wholesale price index (WPI), which halved to 3.3% from 6.6%. The gap between nominal and real growth is likely to reduce further, with inflation expected falling this fiscal.

While the growth momentum was strong in fiscal 2023, the current 2023-24 fiscal will feel the lagged impact of rate hikes of central banks over the past 15 months, Crisil emphasised and said external demand is likely to be a bigger hindrance to growth with western advanced economies staring at a sharp slowdown in the coming quarters, whipping up a headwind for exports. While domestic demand will also

weaken, hit by rising lending rates, softening inflation and government capex will offer support. Monsoon and El Nino risks remain a swing factor. Overall, we expect India's real GDP growth to slow to 6.0% in this fiscal 2024 from 7.2% in the previous fiscal.

This detailed analysis indicate that India is not yet out of the woods despite the higher than expected growth in fourth quarter. The current year growth expected at 6 per cent is nothing to cheer India is yet nowhere near getting back to high growth trajectory of 8 per cent plus annually. Economists are still wary of India growing to its potential. Construction and infrastructure have done well in the fourth quarter but there is still joblessness in the economy and demand is muted. Car sales have gone up but two-wheeler sales is still not back to the desired level. Even in car sales, the low end models pickup is muted. That means the middle class and lower middle

class are still not comfortable in spending besides rural distress. These have to be fixed. GDP growth at 7.2% for fiscal 2023 indicates the economy has done better than expected. Importantly, this growth comes on a higher base – due to upward revision of fiscal 2022 data.

According to CRISIL chief economist Dharmakiriti Joshi, "We expect the economy to slow to 6% this fiscal due to spill-over to exports from a slowing world and some impact of interest rate hikes on interest sensitive segments." Even at 6%, India will be the fastest growing G-20 economy this fiscal, but that is not enough to take advantage of the India's demographic dividend that government boosts off.

As for agriculture output and prices, the eyes are riveted on monsoon; Joshi said indicating we have to keep our fingers crossed over early pick up rural demand. Higher than expected growth in 2022-23 is no doubt a pleasant surprise, but analysts warned of an uneven terrain ahead. Government and private capital spending have improved but private consumption is still sluggish. There was decline in both exports and imports, which clouds economic outlook. Private consumption accounted for nearly 60 per cent of the economy and its growth was merely 2.8 per cent in the fourth quarter of 2022-23 and this is not encouraging.

Surprisingly high growth in the fourth quarter has brought about some optimism to India's growth story but there are still risks. In such a situation there is need to vigorously pursue structural reforms instead of indulging in only chest-thumping. More importantly jobless growth needed to be tackled to ensure private consumption picked up to the desired level. (IPA Service)

Amlo's party wins in Mexico's most populous state for the first time

exico's most populous state turned its back on decades of single-party rule, deciding to move forward with President Andres Manuel Lopez Obrador's ruling Morena party over the long-dominant Institutional Revolutionary Party (PRI).

Results from electoral authorities on Sunday night indicated a victory for Delfina Gomez in the State of Mexico that was confirmed a short time later by Alejandra del Moral's concession speech. The result was a new low for the PRI, which governed Mexico uninterrupted for 71 years until losing power in 2000 and had ruled the State of Mexico for even longer until its loss Sunday.

A representative sampling of voting stations just hours after polls closed indicated Ms Gomez was likely to win between 52.1 per cent and 54.2 per cent of the ballots, compared with 43 per cent to 45.2 per cent for del Moral, according to the National Electoral Institute.

"There is going to be a different governance," Gomez said late on Sunday night before cheering supporters in the state capital of Toluca. The state's first female governor elect stressed her commitment to the mothers of missing people and victims of femicide, and called for the public to denounce corruption.

However, the PRI-led coalition appears to have held onto the governorship in the sparsely populated northern border state of Coahuila. At the time of writing, with most votes counted, the PRI coalition candidate Manolo Jimenez led by a massive 35 points over the Morena challenger. But losing the State of Mexico was a heavy blow to the political fortunes of the PRI.

The contest was closely watched, too, because of its potential implications for next year's presidential elections. Even without having selected its nominee yet, Morena is considered the frontrunner in that national election, more so now with control of the State of Mexico.

of Mexico.

The State of Mexico hugs Mexico City on three sides, encompassing urban sprawl and rural ranches, as well as stunning inequality, violence and corruption. For decades it has been the heart of the PRI. The loss of the State of Mexico is a stunning reversal for a party that ruled Mexico uninterrupted for seven decades even though turnout was only about half of eligible voters in the State of Mexico.

Adair Ortiz Herrera, an information systems student from Coyotepec, a rural area in the northern part of the state, said before the results were announced Sunday that he was sure "a new direction" was coming.

The result was a new low for the PRI, which held Mexico's presidency uninterrupted for 71 years until losing power in the 2000 elections; the party had governed the State of Mexico and its 17 million inhabitants for 94 years until its loss Sunday.

The PRI managed to hold on to the governorship of the sparsely populated northern border state of Coahuila, and governs the neighbouring state of Durango in coalition with other opposition parties. But the PRI is now a shadow of the old days when it ruled Mexico with a combination of hand-out programs and corruption.

PRI party leader Alejandro Moreno said Monday that speculation about the PRI's demise was wrong and that the party would survive, but as part of a broad opposition coalition of left, right and centre groups that will seek to field an alliance candidate in the presidential elections a year from now.

"Elections are won with total votes across the country, not with governorships," Moreno said, although state governments in Mexico historically have been a base to mobilize power and cash that can play a key role in federal elections.

The Morena party now governs 22 of Mexico's 32 states, propelled by López Obrador's personal popularity — and more generous payments to the elderly and students than the PRI offered. The conservative National Action party governs five states, the Morena-allied Green party governs one and the small Citizens Movement holds two large states.

Citizens Movement party leader Dante Delgado dashed any hopes Monday that his centrist group would join the PRI coalition, comparing it a sinking ship, and calling Moreno, the PRI leader, "the one who dug the grave of the PRI."

López Obrador said he was pleased with Sunday's election results, but struck a magnanimous tone Monday, saying his administration would deal fairly with governors from all parties."We have to serve all citizens, whatever party they belong to, that is our responsibility," the president said.

the president said.

Gómez celebrated her victory as the first woman to serve as governor in the State of Mexico. "This is a victory for working families, this is a victory for us women, who have fought for years for the recognition of our rights," Gómez said in a victory speech late Sunday. The state has been plagued by a bloody series of killings of women in recent years, and widespread poverty among femaleheaded households. (IPA Service)

Why the law fails to ensure politicians don't ask for votes in the name of religion

ost recently, Prime Minister Narendra Modi in a public meeting during the Lelection campaign in Karnataka asked voters to chant the slogans of 'Bajrang Bali' and teach a lesson to the Congress.

The significant blurring of the distinction between religion and politics in modern India not only raises the questions on the constitutional role of the institutions meant to maintain it but also the individuals governing it. Although these amount to egregious violations of the Model Code of Conduct, whether the Election Commission will take action is anybody's

Elections in India are regulated under the Representation of People Act, 1951.

To ensure that people of high ethical values are elected as representatives of the people of India, the RPA has laid down certain rules of electoral morality and prohibited certain acts which denigrate the purity of the elections.

Part VII of the RPA classifies condemnable acts committed during elections into two categories: a) corrupt practices and b) electoral offences. The principal distinction between these two categories of prescribed acts is that while a wrong committed under corrupt practice can be brought before the courts only at the end of elections by way of an election petition filed in accordance with the provisions of Article 329(b) of the constitution of India and Part VI of the RPA, an electoral offence can be taken cognisance of and proceeded with as soon as the offence is committed as per the provisions of the Criminal Procedure Code, 1973.

Further, while conviction for a corrupt practice entails civil disabilities like disqualification from voting and contesting elections for a certain period, conviction for electoral offence attracts criminal liability like imprisonment for a term which may extend to three years, or with



In the realm of the religious electoral speech debate in India, the relevant provisions of the RPA are section 123(3) 123(3A) and 125.

As per 123 (3), appeal in the name of religion, caste, community or language is a corrupt practice. Further, promotion or attempt to promote enmity and hatred amongst different groups of people is both a corrupt practice under section 123(3A) and an electoral offense under section

The necessity of the provision under section 123 (3) is explained by the apex court in the case of Ramesh Yeshwant Prabhoo (Dr) v Prabhakar Kashinath Kunte. The court observed that it is necessary "to ensure that no candidate at an election gets votes only because of his religion and no candidate is denied any votes on the ground of his religion." This will keep the secular ethos of the Indian polity intact.

The Supreme Court further held that the restriction imposed in Section 123(3) is in the interest of decency in a secular polity is thus a reasonable restriction within the meaning of Article 19(2) and not violative of the fundamental right of speech and expression under Article 19

The apex court in the case of Abhiram Singh vs CD Commachen held and reaffirmed this view that "seeking or asking votes in the name of the religion is a corrupt practice". An election is a secular exercise and an appeal made in the name of religion, caste, or race is not allowed under the law, it said.

Despite the court ruling and the legal remedy, the appeal in the name of religion has emerged as a challenge for both polity and law.

Constitutional and legal recourse Democratic values are enshrined by the functioning of constitutional and legal institutions. The Election Commission of India is the designated body that controls the use of religious speech, symbols and invocations in elections. The model code of conduct lays down the

guidelines on the behaviour of political parties during elections. For the first four decades of its existence, the observance of MCC was largely left to the good sense of political parties. It remained a passive document providing general guidelines. The MCC was intended to be followed voluntarily by political parties so as to keep election cam-

order during the campaign period. As long as the MCC remained on paper and was not strictly enforced, there was no opposi-

paigns on healthy lines to ensure peace and

its power to enforce the MCC by taking stringent action ranging from censuring candidates to canceling by-elections for violation of MCC provisions, it was met by stiff resistance. The validity of the MCC and the legitimacy of actions taken under it were questioned. In recent times, the role of the Election Commission in selectively choosing to enforce the rules has been questioned.

The limitations of legal recourse to this mixing of religion and politics, tell us that we need to look for a solution beyond the law.

The initial years of the Indian republic witnessed a constitutional vision that the state would be equidistant from religion.

India's first prime minister, Jawaharlal Nehru, had said in a radio address on December 1, 1947, "We must constantly remind ourselves that whatever our religion or creed, we are all people.

India-Nepal relations soar high

visiting China in 2008, Pushpa Kamal Dahal, also called Prachanda, became the first Prime Minister to break the tradition of Nepalese premiers choosing India as their maiden destination of visit. Fast forward to June 2023, Mr Prachanda not only chose India to be his first destination but also expressed contentment with his four-day visit, dubbing it an "astounding success". The recent visit indicates that India and Nepal are moving beyond their fraught phase and taking this "hit" relationship to "Himalayan Heights." During these four days, both countries prioritised convergences over divergences – they signed five projects and six MoUs. Areas such as hydropower electricity, connectivity, and people-to-people relations remained the centre of this fruitful engagement.

Hydropower cooperation was at the top of the agenda. In recent years, India has taken the lead in accelerating this win-win partnership. In November 2021, India began to pur chase Nepal's hydropower electricity and permitted it to export 452 MW. As a result, in 2022 alone, Nepal's hydropower electricity exports generated a revenue of ~12 billion. Building on this momentum, India and Nepal have now agreed to increase the latter's hydropower export quota to 10,000 MW over the next 10 years. They also signed new MoUs for Indian firms to develop Arun and Karnali hydropower projects and agreed to act swiftly on the detailed report of the Pancheswar Multipurpose Project. Additionally, India also agreed to facilitate Nepal's hydropower exports to Bangladesh.

Connectivity, trade, and people-to-people contacts also took precedence during the visit. Both countries signed MoUs for a crossborder petroleum pipeline, cross-border payments, infrastructure development for check posts, and cooperation between foreign service institutes. They also renewed the Transit Treaty, virtually inaugurated integrated check posts, and flagged the inaugural run of a cargo train from India to Nepal.



Throughout the visit, the two leaders focussed on areas of convergence that are mutually beneficial rather than attempting to resolve contentious and sensitive issues. Although both sides agreed to settle the border dispute, there was no in-depth engagement on the same. This finite focus on mutually beneficial areas is due to India's neighbourhood policy, Nepal's domestic developments, and geopolitics. Following the alleged 2015 Nepal block-

ade, India has focussed on perception management and has shied away from commenting on Nepal's domestic develop ments. Its Neighbourhood First policy has prioritised accommodating its neighbours' interests, economic needs and aspirations through economic integration and connectivity. This is despite increasing criticism of India's foreign policy from Opposition parties. Domestically, Nepal continues to be politically unstable. The lack of a clear majority in parliament and the recent unveiling of the Bhutanese refugee scam have kept Mr Prachanda's fragile alliance on its toes. The domestic environment limits his ability to seek a non-partisan consensus on solving Nepal's major issues with India. It is also likely that Mr Prachanda focussed on mutually beneficial areas, as discussing contentious issues would have triggered criticism from different political parties based on their partisan policies.

Nepal's economy is in bad shape as well. It is facing food and fuel inflation, shortage of essential commodities, and depleting foreign reserves. Kathmandu is experiencing a recession with an increasing trade deficit, In-

flation, unemployment and declining foreign direct investments. Currently, Nepal is also seeking assistance from an Extended Credit Facility offered by the International Monetary Fund. Thereby, its immediate focus is on containing inflation, maintaining foreign exchange reserves, raising capital, and reducing the trade deficit, in which trade and economic integration with India is crucial.

Geopolitically, despite China's infrastructure and assistance, Beijing has fallen short of Kathmandu's expectations. Border infrastructure remains underdeveloped, and the trade deficit with China has grown disproportionately. Beijing has continued to turn a blind eye to Nepal's request for grants to proceed with the Belt and Road Initiative (BRI) projects. As such, none of the nine projects have been implemented to date. China has also begun to intervene in Nepal's internal politics to further its interests. A desperate China is even propagating Pokhara International Airport as part of its BRI, though Nepal has denied the claim. China's limitations in being a viable alternative to Kathmandu have thus compelled the country to focus on bene-

ficial Indian projects and partnerships. That said. India-Nepal relations are not free from irritants. Nepal continues to urge India to amend the 1950 treaty. It has requested India to open new air routes, reverse antidumping measures, and resolve boundary issues. Adding to Nepal's anxiety, India has also restricted its markets to Chinese-assisted Nepali infrastructure projects, hydropower plants, and airports. While both countries have no choice but to resolve these issues, engagements on such contentious matters require more trust and an opportune time.

The success of the recent visit, however, illustrates that both India and Nepal are increasingly realising the mutual benefits of their partnership and cooperation. They recognise the strategic importance of each other in the evolving global order and have maintained a positive momentum despite some political challenges and divergences. It is only through such sustained engagement that they will be able to address their mutual suspicions and build trust. (Courtesy: ORF)

Defence, dialogue, AI: The roadmap for India-US strategic ties



S Defence Secretary Lloyd Austin was in India for two days beginning 4 June to discuss ways to further expand the bilateral strategic engagement with India. The visit came ahead of Prime Minister Narendra Modi's trip to

Washington two weeks later. This is General Austin's second visit to India. His previous trip was in March 2021. The India-US defence and strategic ties have been on an upswing in the last few years. Following bilateral discussions on 5 June, Defence Minister Rajnath Singh and the US Defence Secretary concluded a roadmap for Indo-US "Defence Industrial Cooperation" which will provide policy guidance on the issues relating to the defence industrial collaboration between the two countries in the coming years. They also finalised a number of new defence cooperation projects that are set to be unveiled after Mr Modi's talks with US President Joe Biden in Washington. Among these, is the licensed production of the General Electric 414 turbofan engines for India's Tejas

Mk 2 fighter which is under development. **Indo-US Defence Deal**

A Defence Ministry statement was silent on the GE 414 issue, but noted that the two ministers "explored ways of building resilient supply chains." Adding that now both sides "will identify opportunities for co-development of new technologies and co-production of existing and new systems and facilitate increased collaboration between defence start-up ecosystems of the two countries.'

These are likely to be under the rubric of the INDUS-X platform for start-ups and enterprises of both countries to identify collaborations for hightech innovations within the ambit o the Initiative on Critical and Emerging Technologies (iCET). The INDUS-X which will also be launched during the PM's visit to Washington is being helmed by the

US-India Business Council. iCET had been announced in May 2022 and its first round of talks took place between NSA Ajit Doval and his American counterpart Jake Sullivan in January this year. Its aim is to elevate and expand bilateral strategic technology partnership and industrial cooperation between the two countries involving governments, businesses, and academic institutions. The current round of talks between the ministers and officials of the two countries comes after they have signed key defence and security pacts over the last few years, including the Logistics Exchange Memorandum of Agreement (LEMOA) in 2016 that allows their militaries to use each other's bases for repair and replenishment of supplies. They also signed the COMCASA (Communications Compatibility and Security Agreement) in 2018, which provides for interoperability between the two militaries and the sale of high-end technology from the United States to India.

Space and AI Co-operation

In October 2020, India and the US sealed the BECA (Basic Exchange and Cooperation Agreement) to further boost bilateral defence ties. The

act provides for the sharing of high-end military technology, logistics, and geospatial maps between

the two countries. In their talks on Monday, Austin and Singh also reviewed the ongoing bilateral defence cooperation activities and said they would maintain its momentum. They referred in particular to the recent dialogue focusing on cooperation in the areas of space and AI. On 23 May, the inaugural US-India Advanced Domains Defence Dialogue (AD3) was held in New Delhi with the US represented by Principal Deputy Assistant Secretary of Defence and Space Policy, Vipin Narang, and Michael Horowitz, Director of the Emerging Capabilities Policy Office of the US. The dialogue which was agreed to in the last 2+2 Ministerial Dialogue in 2022, was aimed at deepening collaboration on "evolving new defence domains with an emphasis on defence space and Artificial Intelligence.

Among other issues at play currently are India's plans to purchase 18 MQ-9B Predator armed drones from General Atomics. The US would also like India to consider buying its F-35 or FA18 Super Hornet fighters as well. Some discussions took place during the visit of US Air Force Secretary Frank Kendall during his visit to India in March when he met NSA Ajit Doval and External Affairs Minister S Jaishankar. At the time, Kendall had announced that the US was willing to go for the full transfer of jet engine technology to India.

Kendall had also spoken of the early discussions between the two sides on an Air Information Sharing Agreement whose details have not been revealed, but it is believed that it will involve the sharing of a wide range of data on weather, light plans, and other areas which can enhance aerial operations and situational awareness.

What Can Be Expected of Modi's US Visit in India's Defence Sector

At present, the focus is on the license manufacture of the GE-414 turbofan jet engine which will power India's LCA-Mk2 fighter. Its predecessor, the GE-404 powers the Mk 1 version of the aircraft. In January, the White House said that it had received an application from GE to jointly make engines here in India. The deal for the license manufacture of the GE 414 is now expected to be announced during the Modi visit.

China's aggressive behaviour in the Indo-Pacific region as well as along the Line of Actual Control (LAC) and ways to combat the threat of terrorism also figured in the talks between Singh and Austin.

Austin had arrived in India following his participation at the Shangri La Dialogue in Singapore. The highlight of that event was that he was able to shake hands with his Chinese counterpart Li Shangfu who has refused to formally meet him because he is under a US embargo for arms sales to Russia since 2018.

In his speech to the Shangri La Dialogue, Austin had called for greater communication between the Chinese and American militaries, even as he warned China against "coercion and bullying" of its allies and partners. (Courtesy: The Quint)

Zelenskyy visits area flooded by destroyed dam as five reported dead in Russian-occupied city

KHERSON, June 8 (AP): Five residents of a Russian-occupied city next to a breached dam have died in massive flooding triggered by the catastrophe, its Kremlin-appointed mayor said on Thursday, the first official report of deaths from one of the largest environmental crises since Russia's invasion of Ukraine more than 15 months ago.

Vladimir Leontyev, the Russianappointed mayor of Nova Kakhovka, told Russian state TV that two other people who had gone missing after Tuesday's dam breach had been found, and efforts were underway to evacuate them.

Officials say more than 6,000 people have been evacuated from dozens of inundated cities, towns and villages on both the Russian and Ukrainian-controlled sides of the Dnieper river, which has become part of the front line between the fighting forces.

The collapse of the Kakhovka hydroelectric dam and emptying of its reservoir on the river have added to the misery that the region has suffered for more than a year from artillery and missile attacks.

Rescue workers fanned out to get drinking water to beleaguered locals, warning that contaminated water could cause illness.

Thousands of people have been left homeless, cropland has been



ruined, access to electricity and mobile phone networks has been limited or cut off entirely, and land mines have been displaced by the

surging waters, officials say. On the Ukrainian-controlled western bank, President Volodymyr Zelenskyy arrived on Thursday to evaluate the response to damage caused by the dam breach, including efforts to evacuate civilians and provide them with drinking water and other support.

After visiting an aid distribution point and a medical facility, Zelenskyy ordered Ukrainian officials to provide a "fair valuation" of flood damages and develop a scheme to compensate residents whose property was damaged or whose businesses had to relocate, his office said in an online update. In areas that they administer, Russian-appointed authorities said nearly two dozen people have been hospitalised, 4,280 people have been evacuated and some 14,000 buildings have been flooded.

Russian officials say the destruction of the dam, which created a giant reservoir of water used for irrigation and drinking water, will eventually halt fresh water supplies to Russian-controlled Crimea, even though the peninsula has enough fresh water for now — with its reservoirs 80 per cent full.

Ukrainian authorities cut off fresh water supplies to Crimea after Moscow's illegal annexation of the peninsula in 2014, and Russian President Vladimir Putin cited the

main reasons for his decision to in-

Regional Governor Oleksandr Prokudin said the average level of flooding on Thursday morning in the region was more than 5.6 metres (18 feet) and roughly 600 square kilometres (231 square miles) of the region were submerged — more than two-thirds of that on the Russian-controlled east-

He said nearly 2,000 people had been evacuated from Ukraine-controlled areas, and the operations were continuing despite constant shelling from Russian forces across the river. "People are tired ... (they) have no desire to flee to other regions of Ukraine," Prokudin said.

The true scale of the disaster is yet to emerge in an affected area that was home to more than 60,000

French President Emmanuel Macron tweeted that the destruction of the dam was an "attack" and an "atrocious act," without saying who is to blame. Paris said it was rushing aid including water purifiers, 500,000 water purification tablets and hygiene kits to help people displaced by the disaster.

Ukrainian officials have accused Russia of purposely destroying the dam, which is located in an area

Russia says top UN court should dismiss Ukraine's case over Crimea and terrorism funding

THE HAGUE, June 8 (AP): Russia urged judges at the United Nations' highest court on Thursday to throw out a case brought by Ukraine against Moscow over the 2014 annexation of the Crimean Peninsula and the arming of rebels in eastern Ukraine before Russia's full-scale invasion in February 2022. "We appear before you today in order to demonstrate that Ukraine's application must be dismissed because it is without any legal foundation. Nor does it have any factual evidence to back it," Russian Ambassador to the Netherlands Alexander Shulgin told judges at the International Court of Justice.

Lawyers for Ukraine said as hearings in the case opened on Tuesday that Russia bankrolled a "campaign of intimidation and terror" by rebels in eastern Ukraine starting in 2014 and sought to replace Crimea's multiethnic community with "discriminatory Russian nationalism."

Ukraine filed the case in 2017, asking the world court to order Moscow to pay reparations for attacks and crimes such as the shooting down of Malaysia Airlines flight MH17 by a Russian missile fired from territory controlled by Moscow-backed rebels on July 17, 2014, killing all 298 passengers

The Ukrainian government alleges that Russia breached two treaties: the International Convention for the Suppression of the Financing of Terrorism and the



Elimination of All Forms of Racial Discrimination.

Addressing the terrorism funding allegation, Michael Swainston, a British lawyer representing Russia, said Ukraine's legal team failed to establish that actions by pro-Moscow rebels in eastern Ukraine could be considered terrorism.

"It is imperative to distinguish between terrorists who deliberately target civilians and soldiers who foresee that civilians will be killed as collateral damage while striking a military target," Swainston said. The former is a war crime, while the latter represents lawful conduct. And of course, soldiers also make mistakes."

He also disputed that the downing of MH17 could be considered an act of terrorism and sought to undermine findings by a Dutch court that last year convicted two Russians and a pro-Moscow

their roles in downing the Amsterdam-to-Kuala Lumpur flight.

The Hague District Court ruled after months of hearings and years of international investigations that the Boeing 777 was shot down by a Buk surface-to-air missile system brought into Ukraine from a Russian military base and later returned to the base.

'There was no Russian Buk. No Buk came from Russia. No crew for a Buk came from Russia." Swainston said, calling evidence that the Dutch court relied on in its verdicts "unsourced digital non-

Another member of the Russian legal team, Kirill Udovichenko, told the court that it was "undisputed" that the conflict in Ukraine had "led to a loss of civilian life. However, none of these tragic events create a plausible case for terrorism or terrorism financing"

EU launches legal action against Poland over new Russian influence law



BRUSSELS, June 8 (AP): The European Union on Thursday launched legal action against member country Poland over a contentious new law that the nationalist government claims is meant to combat Russian influence but which critics say could be used to persecute opposition politicians. The European Commission said it believes that the new law "unduly interferes with the democratic process," and that it "violates the principle of democracy," and "rights to effective judicial protection." The EU's executive branch supervises respect of the bloc's laws.

The law was passed in May, ahead of expected general elections in autumn, and allows for the creation of a committee to investigate Russian inluence in Poland. Critics argue that it would have unconstitutional powers. including the capacity to exclude officials from public life for a decade.

It appears to have galvanised public support for the opposition. Over the weekend, around 500,000 people took part in a huge anti-government protest, according to organisers. Citizens travelled from across the country to voice their anger at officials who they say have eroded democratic norms and created fears that the nation is following Hungary and Turkiye down the path to autocracy. The protest was led by the main opposition leader. Donald Tusk, a former top EU official. It was possibly the largest demonstration in decades in Poland, although state television said there were no more than 150,000 people. The broadcaster, TVP, was accused of sorely underestimating the turnout.

The march was held on the anniversary of a crucial moment in Poland's history, the partly free election on June 4, 1989, which paved the way for the end of communist rule. It took place about five months before the elections, in which the ruling Law and Justice party is fighting for a third term. As a first step in its legal action, the EU commission has sent the government in Warsaw a "letter of formal notice" outlining its grievances. Poland has 21 days to respond to the letter, and after more exchanges, the government could face hefty fines if it fails to comply. Brussels is concerned that the law contains a broad and unspecified definition of "Russian influence" and "activities." It considers that the law "violates the principles of legality and non-retroactivity," because it could exclude officials from office for a decade for behaviour that was legal in the past.

Very young children among 3 people critically wounded in French Alps knife attack

PARIS, June 8 (AP): As bystanders screamed for help, a man with a knife stabbed several very young children, including at least one in a stroller, and also assaulted adults in a lakeside park in the French Alps on Thursday. The savagery left at least two children and one adult with life-threatening injuries, authorities said.

A suspect, identified by police as a 31-year-old Syrian asylumseeker, was detained. Video appearing to show the attack in a children's play park in the Alpine and lakeside town of Annecy was posted on social media. The horrific scenes showed a man in dark glasses and with a blue scarf covering his head brandishing a knife, as people screamed for help.

The man appeared to shout "on name of Jesus Christ" as he waved his knife in the air, while people around could be screaming: "Police! Police!" He slashed at a man carrying rucksacks who tried to approach him, seemingly trying to stop the attack. Inside the enclosed play park itself, a panicked woman frantically pushed a stroller as the attacker approached, yelling "Help! Help!" and ramming the stroller into the park's barriers in

She tried to fend off the attacker but couldn't keep him from leaning over the stroller and stabbing downward repeatedly. The shrill cries of a child followed. The man strolled almost casually out of the park, letting himself out through a gate, with the man carrying two

rucksacks still chasing after him. French President Emmanuel Macron described the assault as an 'attack of absolute cowardice."

Pak HC grants Imran protective bail in SC lawyer's murder case

ISLAMABAD, June 8 (PTI): A Pakistan high court on Thursday granted protective bail to former premier Îmran Khan in a case registered against him for the murder of a senior lawyer and reserved its verdict on bail petitions filed by Khan in eight other cases.

Khan, 70, was named in the killing of Supreme Court lawyer Abdul Razzaq Shar, who was shot dead in Quetta on June 6 by unknown gunmen. The Pakistan Tehreek-e-Insaf (PTI) party chief filed a petition in the Islamabad High Court (IHC), where a division bench comprising IHC Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb heard

Shar's son accused his father was killed at Khan's behest as the lawyer had filed a case against the former premier in the Balochistan

The federal government and Khan's PTI party had traded blame over the incident, with both sides accusing the other of having a role in the killing.

After an initial argument, the bench granted Khan a two-week protective bail

A video posted on his party's official Twitter account showed the PTI chief's black SUV entering the premises of the court as his security personnel stood guard with bulletproof shields.

Pope in 'good general condition' after surgery

ROME, June 8 (AP): Pope Francis' was in "good general condition" on Thursday, alert and breathing on his own following a three-hour operation to remove intestinal scar tissue and repair a hernia in his abdominal wall, the Vatican said.

The 86-year-old Francis rested "extensively" during a peaceful night and was spending his first day after the surgery observing the "necessary post-operative rest," the Vatican said in a statement.

"The pope is informed of the messages of closeness and affection that have come in the last few hours and expresses his gratitude, while asking for continued prayers for him," the statement said.

Francis was admitted to Rome's Gemelli hospital on Wednesday for his second major abdominal operation in two years, following a 2021 procedure to remove part of his colon.

ation, Francis had undergone previous abdominal surgeries sometime before 2013 in his native Argentina, which had also caused intestinal scarring.

During the operation on Wednesday, doctors removed adhesions, or internal scarring, on the intestine that had caused a partial blockage. To repair a hernia that had formed over a previous scar, a prosthetic mesh was also placed in the abdominal wall. Dr. Sergio Alfieri, director of abdominal and en-

docrine sciences who performed the surgery, said the operation was a success and that Francis was suffering from no other pathologies, that the tissue removed was benign and that after he recovers, he should be fine. A feared protrusion, or bulging of the intestine

through the hernia tear, was apparently not found. Alfieri, who also removed part of Francis' colon in 2021, told an evening press conference that the pope

Canada urges border agency to stop deporting Indian students caught in fake admission letter

TORONTO, June 8 (PTI): A Canadian parliamentary committee has voted unanimously to urge the border services agency to stop the deportation of nearly 700 Indian students who were duped by unscrupulous education consultants in India to enter the country with "fraudulent college admission letters.'

The Indian students, mostly from Punjab, face deportation from Canada after the authorities here found their "admission offer letters" to educational institutions fake. The matter came to light in March when these students applied for permanent residency in Canada.

In a symbolic move, the all-party immigration committee voted unanimously on Wednesday to call on the Canada Border Services Agency (CBSA) to waive the inadmissibility of the affected students, The Toronto Star newspaper reported. The committee also asked the CBSA to provide the students, as many as 700 from India, with an alternative pathway to permanent residence on humanitarian grounds or through a "regularisation" programme, the report said.

Calling the students victims of fraud, Jenny Kwan, a lawmaker who tabled the motion said, "So as a first step, this is absolutely essential and necessary. The students are victims of fraud and should not be penalised.' "These students, I've met with many of them, now are just in such a terrible state. They've lost money, and they are stuck in a terrible situation.

And some of them have deportation orders. Others have pending meetings with CBSA," the newspaper quoted Kwan as saying. 'We need to have empathy for those students, and we should not exploit the situation and play politics on this issue of those innocent students," Liberal MP Shafqat Ali said. NEW YORK, June 8 (AP): On air quality maps, purple signifies the worst of it. In reality, it's a thick, hazardous haze that's disrupting daily life for millions of people across the U.S. and Canada, blotting out skylines and turning skies

And with weather systems expected to hardly budge, the smoky blanket billowing from wildfires in Quebec and Nova Scotia and sending plumes of fine particulate matter as far away as North Carolina and northern Europe should persist into Thursday and possibly the weekend.

That means at least another day, or more, of a dystopian-style detour that's chased players from ballfields, actors from Broadway stages, delayed thousands of flights and sparked a resurgence in mask wearing and remote work — all while raising concerns about the health effects of prolonged exposure to such bad air. The weather system that's driving the great Canadian-American smoke out a low-pressure system over Maine and Nova Scotia — "will probably be hanging around at least for the next few days," U.S. National Weather Service meteorologist Bryan Ramsey said.

"Conditions are likely to remain unhealthy, at least until the wind direction changes or the fires get put out," Ramsey said. "Since the fires are raging — they're really large they're probably going to continue for weeks. But it's really just going be all about the wind shift."

Across the eastern U.S., officials warned residents to stay inside and limit or avoid outdoor activities again Thursday, extending "Code Red" air quality alerts in some places for a third-straight day as forecasts showed winds continuing to push smoke-filled air south.

The smoke has moved over Greenland and Iceland since June 1, and was expected to reach Norway on Thursday, the Norwegian Climate and Environmental Research Institute said, but wasn't expected to be a health concern.

In Washington, D.C., Mayor Muriel Bowser ordered schools to cancel outdoor recess, sports and field trips Thursday. In suburban Philadelphia, officials set up an emergency shelter so people living

"I can taste the air," Dr. Ken Strumpf said in a Facebook post from Syracuse, New York, where the sky took on the colorful nickname of the local university: Orange.

The smoke was so thick in Canada's capital, Ottawa, that office towers just across the Ottawa River were barely visible. In Toronto, Yili Ma said her hiking group cancelled a planned hike this week, and she was forgoing the restaurant patios that are a beloved summer tradition in a nation known for hard winters. "I put my mask away for over a year, and now I'm putting on my mask since yesterday," Ma lamented.

Punjabi Lane residents agree to relocation: Meghalaya govt to HC

Meghalaya government informed the high court that the residents of Punjabi Lane in Shillong have accepted in principle the blueprint prepared by the state government to relocate at least 342 families.

The government had come up with a blueprint after rejecting the Harijan Panchayat Committee demand that 200 square meters of land be provided to each of the 342 families of Punjab lane within the European ward besides bearing the cost of construction of their homes.

"Learned Advocate-General reports that Counsel for the Harijan Panchayat Committee has agreed, in principle, to the blueprint prepared by the government but has made some suggestions for modification in certain areas," a bench headed by Chief Justice Sanjib Banerjee and Justice W Diengdoh





IMPHAL, June 8 (NNN): Even as communal violence continues in Manipur since May 3, the United Naga Council (UNC) has appealed to both the "warring communities" for paving a way forward in a peaceful manner.

The UNC recently stated that the Naga body "is perturbed to witness the continuous act of vengeance and the perpetual cycle of violence with no end in sight from the warring communities"

In a statement issued to Newmai News Network, the Naga body said that despite repeated appeals for the restoration of normalcy in the state, there are occurrences of gunfights in the peripheries of the hill districts and torching of villages in the foothills, leaving other communities at ransom. "It is easier said than done, and perhaps echoing for peace may be a hard thing for the affected people to take when so many lives were lost and properties destroyed beyond measure. However, the UNC, as an apex body representing more than 20 Naga tribes of the present Manipur state, feels the urgency to express our opinion that, coming to terms democratically for a peaceful settlement is the only solution", the UNC stated.

The Naga body then said that, any citizen, big or small, is vulnerable and can be a victim of the strife torn Manipur state due to the fact that all the ethnic communities in the state are living in close proximity to one another, both in the valley and the hills, and there are high chances of senseless violence as and when other communities are provoked or mishandled. As such. the Naga body reminded "both the communities for paving a way forward in a peaceful manner to ensure that the spark of this communal flare up is not ignited further to other communities as a consequence, as involving other communities will be too costly".

Coal miner dies in tragic incident at Ledo Colliery

Cong party comes up with five-point agenda to restore normalcy in Manipur

IMPHAL, June 8 (NNN): The Congress party in Manipur on Thursday came up with a five-point agenda for restoration of peace and normalcy in the trouble-ridden Manipur. The five-point agenda included, among others, confinement of cadres of the militants under Suspension of Operation (SoO) truce at their designated camps, ensuring the protection of Manipur's territorial, administrative, and socio-economic integrity, taking immediate action against poppy planters, financiers and drug lords, implementing relief measures promptly and initiating the identification and deportation of illegal immigrants within a specified timeframe

Speaking to reporters at Congress Bhavan here on Thursday, Manipur Pradesh Congress Committee (MPCC) vice president Hareshowre Goshwami stated that the current scenario of the state is "full of terror and commotion" while terming it as the first time ever witnessed in the history of Manipur. He alleged that negligence on the part of chief minister N Biren Singh in dealing with the tensions in Churachandpur in the aftermath of torching of an open gym scheduled to be inaugurated by him and vandalism at the function venue on April 27 was the flash point for the eruption of the large scale violence in the state.

"The narco-terrorism and the presence of Myanmar-based People's Defence Force (PDF) militants who infiltrated into the state through the porous Indo-Myanmar border after the crackdown in Myanmar were the immediate factors contributing to the ongoing conflict," the Congress leader alleged. The drug cartel in the state is yet to be controlled as many of the drug-lords are holding powerful positions in the state while citing Lukhoisei Zou's case and the Loyangamba Ithocha International Drug cartel case as examples.

The vice president of MPCC also alleged that allowing the entry of Myanmar based PDF in Manipur is also one of the main reasons for this problem in Manipur. Alleging that there were signs of a large cadres of the Myanmar based insurgent group founded only in 2021 infiltrated into the state, the Congress leader asked how the security forces allowed penetration of such insurgents in Manipur. Why is PM still silent on Manipur, asks Cong



NEW DELHI, June 8 (PTI): The Congress on Wednesday asked why Prime Minister Narendra Modi was "still silent" on the violence in Manipur and why he doesn't visit the state and make

an appeal for reconciliation. The Congress also alleged that Manipur was one of the biggest law and order failures in independent India and the situation was turning dangerous in the eastern border state which is surrounded by countries like China.

Congress general secretary Jairam Ramesh asked why the prime minister does not encourage an all-party delega-

tion to visit Manipur. "There appears to be no letting up in the enormous disaster that has engulfed Manipur for the past seven weeks. The home minister visited belatedly after a month and the nation must be thankful for small mer-

cies," Ramesh said on Twitter. "But why is the Prime Minister still silent? Why doesn't he visit the state and make an appeal for reconciliation between communities? Why can't he at least encourage an all-Party delegation

to go to Manipur?" he also asked. When sought a comment on the continuing violence in Manipur even after Home Minister Amit Shah's visit, Congress spokesperson Ajoy Kumar questioned Modi's silence.

He said, while the prime minister had all the time to tweet about the national days of other countries and birthdays of people, he had no words for the people of Manipur. "Not a tweet, not a word, not a regret," Kumar said.

"The prime minister has to answer why he has not even tweeted. The prime minister has not said a word on the death of hundreds of people in Manipur," he said.

Referring to the situation in Manipur, Kumar said, "It is a situation which is amounting to the most dangerous situation in this country. It is a border state and Modi Ji is brilliantly silent, not a tweet, not a word, not a regret, nothing."

"Manipur is one of the biggest law and order failures in the history of Independent India, history of Independent India, mark my words," the Congress leader noted.

The Congress has blamed the BJF and its "divisive politics" for the current situation in Manipur and have demanded that steps be taken immediately to bring normalcy in the border state as the situation might turn out of control if such steps are not taken.

India hits out at Canada for giving space to separatists elements

NEW DELHI, June 8 (PTI): India on Thursday hit out at Canada for giving space to separatists and extremists elements after visuals surfaced on social media of a float in the Canadian city of Brampton that reportedly celebrated the assassination of for-

mer Prime Minister Indira Gandhi. At a media briefing, external affairs minister S Jaishankar said Canada allowing anti-India elements to operate from its soil is not good for the bilateral relationship as well as for itself.

"I think there is a bigger issue involved. And the bigger issue involved really is the space that Canada has continuously and frankly we are at a loss to understand other than the requirements of vote bank politics, why anybody would do this," he said.

"Because if you look at their history, you would imagine that they learn from history and they would not like to repeat that history. It is not only one incident, however, egregious it may be," Jaishankar

"I think there is a larger underlying issue about the space which is given to separatists, to extremists, to people who advocate violence and I think it is not good for relationships and not good for Canada," he added.

A video has emerged on social media that showed a float depicting the assassination of Indira Gandhi. It was reportedly part of a



parade that was organised by some Khalistani elements in Brampton. Canadian High Commissioner in India Cameron MacKay tweeted

that there is no place in Canada for "hate or for the glorification of vi-

"I am appalled by reports of an event in Canada that celebrated the assassination of late Indian Prime Minister Indira Gandhi. There is no place in Canada for hate or for the glorification of violence. I categorically condemn these activities," he said.

On some Indian students facing difficulties in Canada over charges that they did not study in the colleges they applied for, Jaishankar said India has taken up the issue with Canadian authorities.

"If there were people who misled them (the students), the culpable parties should be acted upon. It is unfair to punish a student who undertook education in good faith," he said.

The external affairs minister said the Canadian prime minister has also made a statement in the House of Commons on the issue.



Tension gripped the city on Tuesday after two men allegedly put 18th-century Mysore ruler Tipu Sultan's image along with an offensive audio message as their social media "status".

Wielding lathis, police on Wednesday dispersed hundreds of protesters after they hurled stones during a demonstration at Shivaji Chowk against the alleged use of Tipu Sultan's image.

The situation was brought under control on Wednesday afternoon, and district guardian minister Deepak Kesarkar held a meeting of a peace committee in the evening, Kolhapur Superintendent of Police Mahendra Pandit said.

Members from various organisations and communities pledged to maintain peace in the

'Precautionary measures have been taken, with police deployment in sensitive areas of the city and district along with the ongoing pa-

Asked about the situation in the city, Pandit said, "The situation is gradually returning to normal. Shops in the main market area have started reopening.

He said three cases have been registered in connection with the riots that took place on Wednesday. So far, 36 people have been arrested in connection with the violence, the official said. Additionally, five cases have been registered by police in the district pertaining to objectionable posts. Five persons, including juveniles, have been detained in two of these

cases, the police said. Minister Kesarkar has instructed the administration to set up separate peace committees comprising members of all communities to ensure peaceful celebration of all festivals in Kolhapur, as per a release of the district administration

He has also directed for the formation of an independent committee to prevent any communal discord in the city, the release said.

ED questions TMC leader Abhishek's wife in coal case

ED's action was part of a political vendetta by the BJP: TMC



KOLKATA, June 8 (PTI): Senior TMC leader Abhishek Banerjee's wife Rujira was grilled by the Enforcement Directorate (ED) on Thursday for nearly four hours in connection with the coal pilferage case, officials said. The investigators had a three-page questionnaire for Rujira, who reached the ED office at CGO Complex around 12.40 pm.

"She (Rujira) was asked questions about certain accounts in foreign banks. Her statements were recorded," an ED official told PTI. Asked about Rujira's questioning by the ED sleuths, West Bengal chief minister Mamata Banerjee declined to comment, stating that Rujira would speak in case she felt there was any need. "Please, (since) it's my family matter and I do not want to talk about it. Rujira is a mature girl. If needed she will talk about it," Banerjee told reporters at the state secretariat.

Rujira was stopped at the Kolkata airport on Monday when she attempted to board a flight to UAE with her two children. She was then served summons to appear before the agency at 11 am on June 8. However, she reached the CGO Complex around 12.40 pm along with her lawyer. She left the ED office around 4.20 pm following her questioning. Abhishek, the chief minister's nephew has alleged the questioning was an attempt at "harassing" his family and was aimed at halting his mass outreach campaign ahead of the panchayat elections in the state. Tight security arrangements were made around the CGO Complex to prevent any untoward incident, a senior police officer said. Both CBI and the ED have earlier questioned Rujira in the coal case.

The CBI is probing allegations of illegal-mining of coal from abandoned mines of Eastern Coalfields, estimated to be worth thousands of crores of rupees, officials said. The ED is probing the money trail related to the case. The Trinamool Congress (TMC) alleged that the ED's action was part of a political vendetta by the BJP. "Whenever Abhishek Banerjee was summoned, he cooperated. However, the way his family is being harassed is shameful. This is nothing but political vendetta by the BJP," TMC's state general secretary Kunal Ghosh said. "The BJP is afraid of the TMC's 'Nabojowar' campaign ahead of the panchayat polls, and also wants to divert the attention from the train accident," he claimed.

The state BJP said the CBI and ED were independent agencies, and no political influence has been brought on them. "The BJP has nothing to do with the investigation. The allegations are baseless, and if TMC has any complaints, let the party move court,' state BJP president Sukanta Majumdar said.

Bihar: Efforts on to rescue boy trapped behind bridge pillar in Rohtas



ROHTAS (BIHAR), June 8 (PTI): Efforts are on to rescue an 11-year-old boy trapped between a pillar and a slab of a bridge, built over the Son River, in Atimi village in Bihar's Rohtas district.

The boy, Ranjan Kumar, 11, is being given oxygen while attempts are being made by disaster relief workers

He was found trapped at the Nasriganj-Daudnagar bridge, on Wednesday. Shatrughan Prasad, the boy's father had earlier informed local authorities that his son who was mentally unsound had gone missing two days ago. Later the child was discovered trapped by a woman.

Talking to reporters, Jaffar Imam, Block Development Officer (BDO) of Nasrigani, said, "The incident took place yesterday when the boy somehow got trapped between the pillar and a slab of the Nasriganj-Daudnagar Bridge.

An expert team from the National Disaster Response Force (NDRF) and state disaster response force were immediately called and they have "been busy in the rescue operation since yesterday evening", he added.

"Oxygen is being supplied to the trapped boy through pipes till he is pulled out," he added.

Live-in partner in police custody till June 16 after woman's chopped body found in flat

THANE, June 8 (PTI): A 56-year-old man was arrested after the chopped body parts of his live-in partner were recovered from a flat in Maharashtra's Thane district, an official said on Thursday. A court has remanded the man, identified as Manoj Sane, in police custody till June 16, he said. Victim Saraswati Vaidya (36) was in a live-in relationship with Sane and the couple resided in a flat on the seventh floor of a building in the Mira-Bhayandar area for the past three years, the official said.

Police on Wednesday were alerted by local residents about a foul smell emanating from the flat, said an official from Naya Nagar police station.

A team rushed to the spot and found the decomposed body of the woman which was cut into several pieces, said the official. She was later identified as Vaidya. The crime also sparked a war of words between the Opposition and the BJP, a ruling partner in the state. Nationalist Congress Party (NCP) leader Supriya Sule described the murder as "extremely horrific and outrageous" and alleged that crimes against women were on the rise in the state as criminals have no fear of law.

"A woman was killed by her live-in partner in Mira Road area. The accused tried to dispose of the body by cutting it into pieces, which he crushed in a mixer and boiled in a pressure cooker. This incident is extremely horrific, inhuman and outrageous," tweeted the NCP Member of Parliament

She also said that Deputy Chief Minister Devendra Fadnavis, who handles the home portfolio, should concentrate



Wagh, state BJP women's wing chief, hit out at Sule saying she was shedding crocodile tears. "Fadnavis is capable enough to take action in the Mira Road case. But you did not feel like speaking out when a minor girl at Manchar in Pune district was kidnapped by a Muslim boy, when the Maha Vikas Aghadi (MVA) was in power, and was not found for two-and-a-half years. Had the MVA government intervened, then Shraddha Walkar would not have been cut into pieces," she said.

"Even a chameleon will feel ashamed to see how you change colours," Wagh alleged. Shraddha Walkar was allegedly strangled to death by her live-in partner Aaftab Poonawala on May 18 last year. The accused sawed her body into several pieces, which he kept in a refrigerator for almost three weeks at his residence in south Delhi's Mehrauli.

Court asks RS Secretariat to not evict Chadha from official bungalow

NEW DELHI, June 8 (PTI): In an interim relief to AAP MP Raghav Chadha, a Delhi court has directed the Rajya Sabha secretariat to not dispossess him of a Type-7 bungalow in Lutyens' Delhi, which is usually allotted to lawmakers who are former ministers, chief ministers or governors, till the pendency of his application and without following the due process of law.

The court will now decide the maintainability of Chadha's application against the March 3, 2023 order of the Rajya Sabha secretariat cancelling the allotment of the bungalow to him on July 10.

Nobody from the Rajya Sabha secretariat was immediately available for comments on the judicial order and the MP's petition. During the proceedings, the

counsel for the RS secretariat objected to the maintainability of the application. Additional district judge Sudhanshu Kaushik had on June 1,

after hearing the arguments from

both sides on the issue of maintain-

ability, fixed the matter for July 10 for order. The court had in April directed the secretariat not to dispossess Chadha of the bungalow till the pendency of the application "with-

out due process of law". "At this stage, I do not deem it expedient to comment on the arguments raised by the plaintiff that the allotment once made by the secretariat cannot be cancelled under any circumstances during the entire tenure of a Member of

Parliament," the judge had said. However, I do find force in the second limb of the argument advanced on behalf of the plaintiff that a person cannot be dispos-



sessed except by following the due process of law, the judge said.

"Since, the plaintiff (Chadha) is occupying an accommodation. which falls under the category of public premises, the defendant (Rajya Sabha Secretariat) is obligated to follow the due process of law," he said.

The judge noted Chadha's submission that the secretariat was acting in "haste" and there was a strong likelihood that he might be dispossessed without following the due process of law.

"In view of these circumstances. a prima-facie case is made out for issuing directions to the effect that the plaintiff shall not be dispossessed from the bungalow... without due process of law," the judge said. He observed that the balance of convenience also was in favour of Chadha as he was residing in the accommodation along with his

"Plaintiff would indeed suffer irreparable injury, in case he is dispossessed without the due process of law. Accordingly, till the next date of hearing, the defendant is directed not to dispossess the plaintiff from bungalow... without due process of law," the judge said.

Cong asks Jaishankar to take up 'Indira J&K: Students denied entry to school assassination float' in Brampton parade

NEW DELHI, June 8 (PTI): The Congress on Thursday urged external affairs minister S Jaishankar to take up strongly with Canadian authorities the issue of a float depicting the assassination of former prime minister Indira Gandhi in a parade in Brampton. Asked about it at a press conference, Jaishankar hit out at Canada, saying there was a larger underlying issue about the space which is given to separatists, extremists and people who advocate violence. Earlier, Canadian High Commissioner to India Cameron Mackay said he was "appalled" by the reports of the event in his country that "celebrated" the assassination of the Indian prime minister. "There is no place in Canada for hate or for the glorification of violence. I categorically condemn these activities," he said in a tweet. Congress leader and former Union minister Milind Deora shared a purported video, which is doing the

rounds on social media, of a float at a recent parade in Brampton depicting Gandhi's assassination.

"As an Indian, I'm appalled by the 5 km-long parade which took place in the city of Brampton, Canada, depicting the assassination of Indira Gandhi," he tweeted. "It's not about taking sides, it's about respect for a nation's history and the pain caused by its Prime Minister's assassination," Deora said. This extremism deserves universal condemnation and a united response, the Congress leader asserted. Tagging Deora's tweet, Congress general secretary Jairam Ramesh said, "I entirely agree! This is despicable and Dr S Jaishankar should take it up strongly with the Canadian authorities." Responding to Deora's tweet, senior Congress leader Shashi Tharoor said, "You are completely right...There should be no politics in condemning this despicable act across party lines."

for wearing 'abaya', stage protest

SRINAGAR, June 8 (PTI): Several female students of Vishwa Bharti Higher Secondary School here staged a protest against its administration on Thursday, alleging that they were denied entry to the institute for wearing abaya. A loose-fitting, fulllength robe, Abaya is a worn by Muslim women. "We are told we should go to a Madrassa if we want to wear an Abaya. We were not allowed inside the school," said one of the protesting students. The students alleged the school administration told them they were "ruining the atmosphere of the school" by wearing 'abaya'. School principal Memroz Shafi said the students have been told that they can wear abaya from home to school, but they should take it off inside the school premises. "We told them to wear a long white-coloured Hijab or a large dupatta as that is part of the school uniform. They come wearing colourful abayas, with different designs which is not part of the uniform," he said. The principal said the students should follow a proper dress code in order to maintain decorum in the school. National Conference (NC) chief spokesperson Tanyir Sadig said it was unfortunate to witness such incidents in Muslim-majority Jammu and Kashmir. "Wearing a Hijab should be a personal choice, and there should be no interference in matters of religious attire. It is unfortunate to witness such incidents in a Muslim-majority Jammu and Kashmir," Sadiq said in a tweet.

IMD declares monsoon onset over Kerala

Cyclone 'Biparjoy' had been impacting the intensity of the monsoon would be 'mild'

NEW DELHI, June 8 (PTI): The southwest monsoon hit India on Thursday with its onset over Kerala, a week later than normal, the India Meteorological Department (IMD) announced.


Meteorologists earlier said Cyclone 'Biparjoy' had been impacting the intensity of the monsoon and that its onset over Kerala would be "mild"

In a statement on Thursday, the IMD said, "The southwest monsoon has set in over Kerala today, June 8."

"The monsoon has advanced into remaining parts of south Arabian Sea and some parts of central Arabian Sea, entire Lakshadweep area, most parts of Kerala, most parts of south Tamil Nadu, remaining parts of Comorin area, Gulf of Mannar and some more parts of southwest, central and northeast Bay of Bengal today," it added.

The southwest monsoon normally sets in over Kerala on June 1 with a standard deviation of about seven days. In mid-May, the IMD said the monsoon might arrive in Kerala by June 4.

Skymet had predicted the monsoon onset



over Kerala on June 7, with an error margin of three days. Over the last 150 years, the date of the monsoon onset over Kerala has varied widely, the earliest being May 11 in 1918 and the most delayed being June 18 in 1972, according to IMD data.

The southwest monsoon arrived in the southern state on May 29 last year, June 3 in 2021, June 1 in 2020, June 8 in 2019 and

May 29 in 2018.

Research shows a delay in the monsoon onset over Kerala (MOK) does not necessarily mean a delay in the monsoon onset over northwest India

However, a delay in the MOK is generally associated with a delay in onset at least over the southern states and Mumbai.

Scientists say a delayed MOK also does

not impact the total rainfall over the country during the season. India is expected to get normal rainfall during the southwest monsoon season despite the evolving El Nino conditions, the IMD had earlier said.

Northwest India is expected to see normal to below-normal rainfall. East and northeast, central, and south peninsula are expected to receive normal rainfall at 94-106 per cent of the long-period average.

Rainfall less than 90 per cent of the longperiod average is considered 'deficient', between 90 per cent and 95 per cent is 'below normal', between 105 per cent and 110 per cent is 'above normal' and more than 100 per cent is 'excess' precipitation.

Normal rainfall is critical for India's agricultural landscape, with 52 per cent of the net cultivated area relying on it. It is also crucial for replenishing reservoirs critical for drinking water, apart from power generation across the country.

Rain-fed agriculture accounts for about 40 per cent of the country's total food production, making it a crucial contributor to India's food security and economic stability.

Traders not facing any problem in exchanging, depositing ₹ 2,000 notes: Minister

INDORE, June 8 (PTI): Union minister Som Prakash on Thursday claimed businesspersons and traders were not facing any problem in depositing or exchanging ₹ 2,000 notes which were withdrawn from circulation by the Reserve Bank of India (RBI) last

He said enough time has been given to people to deposit or exchange the high-value currency, which was introduced in November 2016.

"I have spoken to a number of traders and industrialists over the decision to withdraw the ₹ 2,000 notes. Anyone can go to a bank and get them exchanged. None of them have a problem," the minister of state for commerce and industry told reporters here while responding to a question.

On May 19, the RBI announced the withdrawal of ₹ 2,000 notes and set September 30 as the deadline for exchanging and depositing them with banks.

On May 26, the Confederation of All India Traders (CAIT) said the RBI must put in place a standard operating procedure (SOP) for banks for deposit and exchange of the withdrawn bills.

CAIT president BC Bhartia had told reporters here, "Every bank has its own way to exchange or deposit ₹ 2,000 bills, which is causing hardship to housewives and traders. The RBI must have a common SOP for

Accused kept chopped body parts of his live-in partner in 3 buckets: Neighbours



MUMBAI, June 8 (PTI): The man accused of brutally killing his 36-year-old woman live-in partner in Mira Road locality of Maharashtra's Thane district, kept her chopped body parts in three buckets in their flat and also tried to hide the stench by spraying room freshener, his neighbours said on Thursday.

Police have arrested the accused man, 56-yearold Manoj Sane, after the chopped body parts of the victim, Saraswati Vaidya, were recovered from their rented flat located on the seventh floor of a building in the Mira Road area, where they had been living for the past three years. A court remanded Sane in police custody till June 16, of-

Talking to reporters, Somesh Srivastav, his next-door neighbour, said a foul smell kept emanating from Sane's flat for the past couple of

Srivastav said himself decided to speak to Sane about the stink as the latter did not usually open

"On Wednesday, I planned to speak to him about the unbearable odour coming from his flat and knocked on his door. There was no response from inside initially, but he opened the door after some time. Before that, he sprayed room freshener in the house to suppress the stench. I heard the sound of spray," he said.

But as soon as he opened the door, he started

gent work and he will meet him after returning home around 10.30 pm, he said. At that time, Srivastav's mother noticed that

stepping out saying he has to go out for some ur-

Sane's woman partner was not there to see him off as she used to do whenever he stepped out, he

After sensing that something was amiss, Srivastav informed the housing society's officebearers, who in turn called the builder and the broker of the flat, he said.

After being alerted, a police team also reached the flat. The police broke open the door and entered the flat, Srivastav said, adding he also went inside the house.

The police found a wood cutter in the hall and a piece of plastic in the bedroom. They were shocked to see three buckets full of blood and chopped body parts kept in the kitchen, he said, adding that bones were also lying there.

Police also found parts of the victim's thighs, which were not completely chopped yet, and also the hair braid lying on the ground, he said.

After that, the police decided to nab Sane and waited for his return, he said.

Srivastav said although Sane had told him that he would return home by 10.30 pm, he came back around 8.30 pm. After spotting the police on the 7th floor, he tried to leave the place, but the flat's broker identified him and he was immediately

"The way the accused had chopped the victim's body parts, he would have disposed of these pieces over the next two days," he said.

Another neighbour Vivek Srivastav said that he came to know about the murder after returning home from the office in the evening.

He said although the couple had been staying in the seventh floor flat for the last couple of years, they did not mix with anyone and did not speak with anybody, he said adding they also did not take part in in any functions in the society.

India test-fires new generation ballistic

In December, India successfully test-fired Agni-V missile that can strike targets at ranges up to 5,000 km. Agni-V can bring almost the entire Asia including the northernmost part of China as well as some regions in Europe under its striking range.

The Agni 1 to 4 missiles have ranges from 700 km to 3,500 km and they have already been deployed. In April, India successfully carried out the maiden flight trial of an endo-atmospheric interceptor missile from a ship off the coast of Odisha in the Bay of Bengal as part of its ambitious ballistic missile defence pro-

The purpose of the trial of the sea-based missile was to engage and neutralize a hostile ballistic missile threat thereby elevating India into an elite club of nations having such a capability. India has been developing capabilities to intercept hostile ballistic missiles both inside and outside the earth's atmospheric limits.

Greenhouse gas emissions found to be at 'all-time high' Warming continues at 'unprecedented rate'

NEW DELHI, June 8 (PTI): Greenhouse gas (GHG) emissions have been found to be "at an all-time high", with human activity resulting in the equivalent of 54 gigatonnes of carbon dioxide being released into the atmosphere on average every year over the last decade. A group of 50 leading scientists have said in

an analysis that human-caused global warming has continued to increase at an "unprecedented rate" since the last major assessment of the climate system published two years ago. One of the researchers said the analysis was a "timely wake-up call" and it comes as climate

experts meet in Bonn, Germany, to prepare the

ground for the major COP28 climate conference in the UAE in December, which will take stock of progress towards keeping global warming to 1.5 degrees Celsius by 2050. The researchers wrote in the analysis that human-induced warming, largely caused by fossil fuel burning, reached an average of 1.14 degrees Celsius for the most recent decade (2013 to 2022) above pre-industrial levels, up from 1.07 degrees Celsius between 2010 and

degrees Celsius per decade, they wrote in the journal Earth System Science Data. In an initiative being led by the University of Leeds, UK, the scientists have developed an open data, open science platform - the Indicators of Global Climate Change. Its website will update information on key climate indicators

2019. It is now increasing at a pace of over 0.2

Arguing that policymakers, climate negotiators and civil society groups need to have access to the latest and robust scientific evidence for



decision-making, the scientists said that these key climate indicators have changed since the publication of the UN's Intergovernmental Panel on Climate Change's (IPCC's) Sixth Assessment Working Group 1 report in 2021, which produced the key data that fed into the subsequent IPCC Sixth Synthesis Report.

While there has been a positive move away from burning coal, it has, in fact, added to global warming by reducing particulate pollution in the air, which has a cooling effect, the analysis noted.

Coordinator of the initiative, Piers Forster, Director of the Priestley Centre for Climate Futures at Leeds, said, "Long-term warming rates are currently at a long-term high, caused by highest-ever levels of greenhouse gas emissions. But there is evidence that the rate of increase in greenhouse gas emissions has slowed.

"We need to be nimble footed in the face of climate change. We need to change policy and approaches in the light of the latest evidence about the state of the climate system. Time is

no longer on our side. Access to up-to-date information is vitally important."

Decline in remaining carbon budget, an estimate of how much carbon that can be released into the atmosphere to give a 50 per cent chance of keeping global temperature rise within 1.5 degrees Celsius, another major finding of the analysis, has been attributed to a combination of continued emissions since 2020 and updated estimates of human-induced warming.

The IPCC calculated in 2020 this budget to be around 500 gigatonnes of carbon dioxide. By the start of 2023, the figure was roughly halved to 250 gigatonnes.

"Even though we are not yet at 1.5 degrees Celsius warming, the carbon budget will likely be exhausted in only a few years as we have a triple whammy of heating from very high CO2 emissions, heating from increases in other GHG emissions and heating from reductions in pol-

"If we don't want to see the 1.5 degrees Celsius goal disappearing in our rearview mirror the world must work much harder and urgently at bringing emissions down," said Forster.

Maisa Rojas Corradi, Minister of the Environment in Chile, IPCC author and a scientist involved in this study, said, "An annual update of key indicators of global change is critical in helping the international community and countries to keep the urgency of addressing the climate crisis at the top of the agenda and for evidence-based decision-making."

He said that Chile had a climate change law aimed at aligning government-wide policies



gods... Everything is so specific... To know that it is being seen and conveyed to so many people, it is overwhelming and it's a show that just sets the standard on projects going for-

"Never Have I Ever" follows Devi (Ramakrishnan), an overachieving Indian-American teenager growing up in Southern California, US, who is mourning the death of her father while navigating life as a highschool student

On her recent visit to India, Moorjani, 34, said she was surprised to see the show resonate with people in different parts of the country

"They told me how they feel

ever felt represented or relatable to a character in an American television show. It's very rare as an actor, especially as a brown actor in this country, to be a part of a show that can be so explosive in so many ways," she added.

With Ranjita Chakravarty's Nirmala 'Pati' (Devi's paternal grandmother), the show also gives a peek into how women don't need to stick to the narratives set by the society, Jagannathan said.

"The fact that Pati is so conservative and disapproving of Kamala's boyfriends but ends up being as horny as Devi, it is hilarious, but also groundbreaking.

"... As South Asian women, our narratives, a lot of times, are dictated... Like, my mother became a widow and her narrative was somehow dictated by society. This show picks up a pen where people usually put the period and starts a whole new chapter for each of our characters of South Asian women," she added.

"Never Have I Ever" also stars Darren Barnet, Jaren Lewison, Ramona Young, and Lee Rodriguez.

Fisher serves as showrunner on the series, which is produced by Universal Television, a division of Universal Studio Group, and executive produced by 3 Arts Entertainment's Howard Klein and David Miner.

Messi picks MLS's Inter Miami in a move that stuns soccer after exit from Paris Saint-Germain



MIAMI, June 8 (AP): Lionel Messi has pulled off his latest stunning feat: He is headed to Major League Soccer and joining Inter Miami. After months — years, even — of speculation, Messi on Wednesday finally revealed his decision to join a Miami franchise that has been led by another global soccer icon, David Beckham, since its inception but has yet to make any real splashes on the field.

That likely will soon change. One of Inter Miami's owners, Jorge Mas, tweeted out a photo of a darkly silhouetted Messi jersey shortly before the Argentinian great revealed his decision in interviews with Spanish news outlets Mundo Deportivo and Sport.

It was widely believed that Messi eventually would choose to play for Al-Hilal in Saudi Arabia, following longtime rival Cristiano Ronaldo to a nation where some clubs now are funded by the state's sovereign wealth fund. Going back to Barcelona, a storied franchise where he spent most of his career, was another possibility.

But in the end, he made the call that surprised many. Messi is joining MLS. He said in the interviews Wednesday that some final details still need to be worked out, but that he has made the call to "continue my path" in Miami.

"After winning the World Cup and not being able to return to Barcelona, it was my turn to go to the league of the United States to live football in another way," Messi said.

He didn't take the money. He didn't choose the memories. He picked Miami instead. Messi's next matches are likely to be exhibitions with Argentina against Australia on June 15 at Beijing and at Indonesia in Jakarta four days later — and then his Inter Miami debut figures to be sometime in July.

"We are pleased that Lionel Messi has stated that he intends to join Inter Miami and Major League Soccer this summer," read a statement from MLS. "Although work remains to finalize a formal agreement, we look forward to welcoming one of the greatest soccer players of all time to our league."

The seven-time Ballon d'Or winner — the trophy given annually to the world's best player — makes his move after two years with Paris Saint-Germain. At 35, Messi has nothing left to prove in the game and filled the only significant unchecked box on his resume back in December by leading Argentina to the World Cup title.

Messi has more than 800 goals in his career for club and country, making him one of the greatest scorers in the sport's history. In more than 17 years of representing Argentina on the international stage, he has scored 102 goals against 38 different national team opponents — 16 of those goals coming on U.S. soil. He scored twice in last year's World Cup final against France, a match that ended

3-3 with Argentina prevailing 4-2

on penalty kicks. He has been to the absolute mountaintop of the game. He is a four-time Champions League winner and his 129 goals in the top club competition are second to Ronaldo's 140. Messi has won 10 La Liga titles and two Ligue 1 championships, seven Copa del Reys and three Club World Cups plus a Copa América and Olympic gold medal for Argentina.

And now he comes to MLS, and a team that is struggling — last place in the Eastern Conference, just a few days removed from the firing of coach Phil Neville (who was hand-picked by Beckham two years ago).

Messi's decision to play in the U.S. might be the biggest boost ever for American soccer on the pro stage. Some of the game's biggest names — Pelé, Franz Beckenbauer, Thierry Henry and Beckham himself — have come to the U.S. toward the end of their ca-

reers, but landing a player still no worse than near the pinnacle of his game and just a few months removed from hoisting a World Cup is simply huge.

This is obviously the biggest signing that they've brought in," said Nashville defender Walker Zimmerman, a U.S. national team regular. "It's kind of reminiscent of Beckham when he came originally. You saw how the league has kind of changed in the 15 years since he arrived, and hopefully 15 years from now we're seeing all the growth from this addition to the league. I think it's a great thing.

"I think it'll be great for the sport in this country, especially ahead of the 2026 World Cup. And I'm excited to play against him.'

It took months of negotiations with MLS, the Miami ownership, Adidas and even Apple getting involved in a creative pitch to bring Messi to Miami's pitch. Apple which is a broadcast partner of MLS — announced Tuesday that it will show a still-untitled four-part documentary series "featuring exclusive behind-the-scenes access to global superstar Lionel Messi. ... In his own words. Messi tells the definitive story of his incredible career with the Argentina national football team, providing an intimate and unprecedented look at his quest for a legacy-defining World Cup victory."

And now, his story will have a Miami chapter. His move comes in a week when the NBA's Miami Heat and NHL's Florida Panthers are both at home in their respective title series — and the Heat, during Game 3 of the NBA Finals on Wednesday night, flashed a graphic on their scoreboard welcoming Messi to Miami.

The Heat trailed by 21 points at the time. A few people cheered

Inter Miami needed six years from inception to playing its first match, and its first four seasons have been less than stellar.

Messi is joining a team that sits last in the Eastern Conference and just fired its coach. It has made the playoffs in two of its first three seasons but has yet to finish a season with a winning record or even a months that Miami remained very much in the Messi sweepstakes. Messi met with Inter Miami coowner Beckham this spring, and that was shared publicly almost to ensure that everyone knew the sides were still talking. Messi and his family also own several pieces of luxury real estate in South Florida, and — almost as if to suggest something big was coming the MLS club told fans the only way they could get tickets for the second half of this season was to purchase a season-ticket package.

He's an enormous draw everywhere on the globe, including Miami. Two days after Argentina won the World Cup, Miami Heat guard Kyle Lowry sat on his team's bench for a game unable to play because of injury. He wore a Messi jersey that night.

Inter Miami still plays home matches in a temporary home in Fort Lauderdale, about 45 minutes north of the site in Miami where the team wants to build a permanent complex.

And even in an area where the population has a serious Latin flaor, and where more people might actually call the sport fútbol than soccer, Inter Miami has struggled to generate the same attention as do the area's primary pro teams basketball's Heat, baseball's Miami Marlins, football's Miami Dolphins and hockey's Panthers.

Messi could change that in an instant. In a flash, he becomes the biggest name in MLS and makes everything Miami does newsworthy. Barcelona released a statement saying Jorge Messi, the player's father, told the club president Joan Laporta of the decision to go to Miami and wished him well.

"President Laporta understood and respected Messi's decision to want to compete in a league with fewer demands, further away from the spotlight and the pressure he has been subject to in recent years," the statement from Barcelona said.

His decision ends what has been a wild saga. Barcelona made Messi a superstar, but the financial issues that forced the team to letting him go two years ago still remain an

India suffer 1-4 loss to Netherlands in FIH Pro League



EINDHOVEN, June 8 (PTI): A profligate India squandered a onegoal lead to go down 1-4 to the hosts Netherlands in the FIH Hockey Pro League here.

Skipper Harmanpreet Singh (11') scored India's lone goal despite the visitors being awarded as many as five penalty corners and a penalty stroke. Riding on backto-back wins in London last weekend, India got off the blocks in Eindhoven establishing an early 1-0 lead in the first quarter.

The equaliser put India on the backfoot, with the hosts enjoying most of the ball possession. It took India a few minutes to regain their rhythm and foray into the circle with a well-worked attack down the right flank but the hosts defended well to keep the scoreline even. Only seconds before the hooter, the Netherlands found an opportunity to take the lead when they won a PC from a strong counterattack. But a goal was averted by India's brave first rusher Amit Rohidas.

Starting the third quarter with a 1-1 stalemate, the match promised to keep the audience glued to their seats. The hosts dominated this quarter with improved ball possession backed by an aggressive attack. "You can't keep a player who doesn't want to be there," Sullivan told British radio station Talksport on Thursday.

Rice has been linked with some of Europe's top teams, including Arsenal and Bayern Munich.

"It's not something we want to happen," Sullivan said. "We offered him 200,000 pounds (\$250,000) a week 18 months ago. He turned it down.'

The 24-year-old Rice has played for West Ham since 2017. He said after Wednesday's final that "it's not a goodbye yet."

"Obviously there's loads of speculation but nothing's happened," Rice said. "I'm a West Ham player, I've got two years left on my contract. I love every minute of

Sullivan said West Ham has yet to receive an offer. "But I think the offers will

start to come today," Sullivan said. "There are three or four clubs who have shown interest, but out of respect to West Ham, while we're still playing, you don't make offers for players."

When Hertha hosts Hamburg in its 75,000capacity Olympiastadion, or Schalke hosts Kaiserslautern in front of 62,000 fans in Gelsenkirchen, the games will draw more attention than many first-division matches.

Trout, Moniak use bats and gloves to power Angels past Cubs, 6-2

ANAHEIM, Calif., June 8 (AP): Mickey Moniak realizes the Los Angeles Angels are loaded with quality outfielders at the moment, so he strived to stay sharp in the cage and with video study during five straight days without playing in a game recently.

"I've got the confidence to be able to know I'll be in the right spot, even without seeing pitching for a few days," Moniak said. "The outfield depth in this organization right now is crazy. ... It's just a testament to the talent we've got. If one man goes down, the next guy is ready to go. It's not like there's a hole in the lineup.'

Moniak came up with the bases loaded in the sixth and delivered a double to right on a hanging splitter from Mark Leiter Jr., one of the Cubs' top leverage relievers. Moniak knew Leiter's tendencies from their time as teammates in the Phillies organization, and he had studied the scouting reports on Chicago's bullpen.

Man City, Inter Milan meet in Champions League final of contrasting club history

chester City will enter the Champions League final on Saturday as a modern soccer and financial heavy-

India will return with best-ever medal haul from Asian Games, says Thakur

NEW DELHI, June 8 (PTI): Sports Minister Anurag Thakur on Thursday predicted that Indian athletes will return with the country's best-ever medal haul from the Asian Games later this year.

India are expected to send one of the largest contingents to the Asian Games this year with athletes competing in non-traditional sports like kurash, jujutsu, and chess.

A total of 600 athletes are expected to represent India across various sports, compared to 570 in the last edition and 541 in 2014.

"The improvement in facilities by the government has resulted in India's best-ever performance at the last Oympics, Paralympics, Deaflympics and Commonwealth Games. We won a record number of medals and we will do similarly in the Asian Games.

"I think India will have the bestever performance in the Asian Games," Thakur told reporters on the occasion of Mission Olympic Cell's (MOC) 100th meeting here.

India returned with a best-ever haul of 69 medals, including 15 gold, 24 silver and 30 bronze from the 2018 Asian Games in Jakarta and Pelambang, Indonesia.

The minister informed that over 350 proposals of TOPS (Target Olympic Podium Scheme) group athletes worth ₹45 crore have also been approved in this Olympic cycle.

"For the preparation for Asian



The government has spent Rs 450 crore in the current Olympic cycle on training and equipment. We have approved proposals of TOPS group athletes worth ₹ 45 crore," Thakur said.

The Olympic Council of Asia (OCA) has set July 15 as the deadline for sending final entries for the postponed Asian Games set to take place in Hangzhou, China from eptember 23 to October 8.
