HT Bureau GUWAHATI, July 13: Chief minister Himanta Biswa Sarma has said that the state government has been taking all measures necessary to give shape to Prime Minister Narendra Modi's vision of ensuring housing for all by 2024.

"In this regard, the Government of Assam has been implementing the provisions of PMAY (Grameen) in letter and spirit, the chief minister said while attending the "griha pravesh" ceremony organised by the Government of Assam's Panchayat & Rural Development Department for as many as three lakh beneficiaries of the Prime Minister Awas Yojana (Grameen) held at the Srimanta Sankardev International Auditorium todav

Addressing the event, Sarma said that with the aim of ensuring

a pucca house equipped with all the basic amenities for all eligible beneficiaries in the rural areas, the Panchayat & Rural Development Department of Assam has been working relentlessly in efficient and time-bound implementation of PMAY (Grameen) scheme.

"Beneficiaries are being provided an amount of ₹1.30 lakh each in three installments through their bank accounts as per the provisions of the scheme," he said.

Stating that a total of 19,10,823 houses have been approved under the scheme beneficiaries for which

were selected on the basis of socioeconomic caste census (SECC) and Awas+, the chief minister said a total of 12,43,584 houses have already been constructed. By February 2024, construction of another 6 lakh houses would be completed, the chief minister said. EC's public hearing on delimitation draft from July 19

GUWAHATI, July 13 (PTI): The Election Commission of India (ECI) will hold a three-day public hearing from July 19 on the suggestions/ complaints related to the draft proposal on the delimitation of Assembly and Parliamentary constituencies of Assam, an official release said here on Thursday.

The ECI had issued a notification on June 20 this year, inviting suggestions and objections to the draft proposal on the delimitation of assembly constituencies by June 11 and till the stipulated date about 500 suggestions/objections were received. These suggestions/objections are under the consideration of the Commission and it has been also decided to hold public sittings in the state to hear the suggestions/objections as received from people and organisations on the draft proposal. The public hearing will be held at the Srimanta Sankardeva Kalakshetra from 1500 hrs on the first day and will cover the districts of Kokrajhar, Chirang, Baksa, Udalguri, Karbi Anglong, West Karbi Anglong, West Karbi Anglong and Dima Hasao.

On July 20, the hearing will begin at 9:30 hours and representatives from the districts of Dhubri, Goalpara. South Salmara, Bongaigaon, Barpeta, Nalbari, Karimganj, Hailakandi and Cachar will be heard till 1200 hours, followed by Kamrup, Kamrup(Metro), Nagaon, Sonitpur, Morigaon and Darrang till 1400 hours.

The Commission will also interact with representatives of national and state-recognised political parties (in alphabetical order) from 1530 hours on the same day. On the final day, the hearing will be from 0930 to 1230 hours with representatives from the district of Dibrugarh, Tinsukia, Dhmaji, Lakhimpur, Sibsagar,



Jorhat, Charaideo, Golaghat and Majuli, the release added. The draft delimitation proposal had retained the number of assembly seats at 126 and the Lok Sabha constituencies at 14 in Assam.

The state also has seven Rajya Sabha seats. According to the draft, the assembly seats reserved for Scheduled Castes would be increased to nine from eight and for Scheduled Tribes to 19 from 16 while for the Lok Sabha constituencies, two have been proposed under the ST category and one for the SC community. The commission had also proposed to alter the geographical boundaries of most of the assembly and the Lok Sabha constituencies. The draft delimi-

Assam govt supports UCC, wants to ban polygamy immediately: Himanta

GUWAHATI, July 13 (PTI): The Assam government has already conveyed to the authorities concerned that it is in support of the Uniform Civil Code (UCC) and wants to ban polygamy in the state immediately, chief minister Himanta Biswa Sarma said on Thursday. The UCC is a matter which will be decided by Parliament, but the state can also take a call on it with the assent of the President, Sarma said at the sidelines of a programme here.

'UCC involves various issues and the Law Commission as well as the Parliamentary Committee is looking into it. The Assam government has already conveyed that it is in its support,' the chief minister said.

Pending the decision on the UCC, 'we want to take one of its segments - polygamy - and ban it immediately. We are planning to introduce a Bill to ban it in the next assembly session in September," he said.

Sarma, also a senior BJP leader, said if the state government is unable to table the Bill for some reason, it

will be done in the January session. "In the meantime, however, if the UCC is implemented, we do not have to take this action as it will be merged with it,' he said. Regarding the Congress' opposition to the UCC, the chief minister wondered if a leader of that party has a daughter, 'will the person marry her off to somebody with two wives'.

'The problem is that Congress leaders do not realise the pain of Muslim women. They take their votes but they do not want to give back anything to them', he said.

The Congress wants the votes of both Muslim men and women but they want to serve only the men, Sarma added. 'Even Nabi (The Prophet) did not support polygamy as he had said that all Muslims should ideally have one wife. These are the essential points of Islam. The Congress should not support polygamy and stand with Muslim women, even if they lose some votes,' he said.

The Congress had opposed the abolition of triple talaq and now the UCC, so in a way the party is 'waging a war against Muslim women', he said. 'When they (Muslim women) emancipate themselves from the influence of the male, (CONTD. ON PAGE-9)

Pact inked to connect ONGC's natural gas fields with North East Gas Grid

GUWAHATI, July 13 (PTI): Indradhanush Gas Limited (IGGL) and Oil and Natural Gas Corporation Limited (ONGC) have signed three hook-up agreements to connect the latter's natural gas fields with the North East Gas Grid (NEGG) for transportation of natural gas

The natural gas will be transported from Jorhat, Silchar and Tripura Assets of ONGC to the consumers, an official release said on Thursday. IGGL is laying a 1,656 km long natural gas pipeline connecting the capital cities and the demand centres of all the eight north eastern states.

NEW DELHI, July 13 (PTI): Gold prices jumped by ₹ 400 to ₹ 60,100 per 10 grams in the national capital on Thursday amid strong global trends, according to HDFC Securities.

The precious metal had closed at ₹ 59,700 per 10 grams in the previous trade. Silver prices also zoomed ₹ 2,300 to ₹ 75,000 per kg.

"Gold prices climbed on Thursday, with spot gold prices in the Delhi markets trading at ₹ 60,100/10 gram up by ₹ 400 from its previous day's close," Saumil Gandhi, senior analyst, commodities, HDFC Securities,

In the global market, both gold and silver were trading higher at USD 1,960 per ounce and USD 24.17 per ounce, respectively.

Comex gold prices extended their gains and traded at a fourweek high following softer-thanexpected US consumer inflation data which raised expectations that the Federal Reserve's rate hike cycle might be coming to an end,

Wipro Q1 net profit rises 12 pc to ₹ 2,870 crore

BENGALURU, July 13 (PTI): IT services company Wipro on Thursday reported a 12 per cent rise in its consolidated net profit to about ₹ 2,870 crore for the June 2023

It had posted a consolidated net profit of ₹ 2,563.6 crore in the year-ago period (Q1FY23). Wipro's income from operations

in the June quarter increased 6 per cent to ₹ 22,831 crore. "We expect revenue from our IT

Services business segment to be in the range of USD 2,722-2,805 million. This translates to sequential guidance of -2 per cent to +1 per ent in constant currency terms," the company said in a statement.

Wipro CEO and Managing Director Thierry Delaporte noted that the company's first quarter results came on a strong backbone of large deal bookings, robust client additions and resilient margins.

"Despite a gradual reduction in clients' discretionary spending, we maintained new business momentum. We earned our clients' trust with strong delivery, innovation and expanded services that strengthen our long-term businesses, and help capture market share," Delaporte said.

On the latest AI strategy, Delaporte said that the launch of Wipro ai360 and the USD 1 billion investment "solidifies Wipro's position as a leading transformation partner that delivers the results and innovation our clients need to futureproof their businesses".

Generative AI deals expected in next two quarters: TCS CEO



MUMBAI, July 13 (PTI): The country's largest IT services company TCS is expecting some generative artificial intelligence- (AI) based deals in the next two quarters, but their sizes will not be big,

its top official said on Thursday. Those deals will not be over USD 1 billion, TCS Chief Executive Officer and Managing Director K Krithivasan told PTI during an interview here.

"Each organisation will spin out a number of deals, but there may not be a single billion dollar kind of deal in generative AI," Krithivasan said, adding that at present, every organisation is tinkering to assess the possibilities of the new technology.

TCS, which on Wednesday announced its intent to train 1 lakh associates on generative AI and working on 50 proofs of concept, is also gearing up for the changes in the landscape, Krithivasan said.

"The major impact (for) organisations will happen only when they embark on an enterprisewide programme. As long as they keep doing some use cases here, some use cases there, some pilots here, even they will not see (the gains)," he said.

Businesses need to be sure about the returns on investments on the deployment of such technologies before they move ahead, Krithivasan said, adding that it is important for an IT company to test and understand such tech-

It can be noted that since the launch of ChatGPT by OpenAI late last year, there has been an increased interest in generative AI in the tech world. In the post-earnings press conference on Wednesday, TCS Chief Operating Officer N Ganapathy Subramaniam had said every client conversation is finding a mention on generative

Krithivasan said on Thursday that training of associates will not extract a significant jump in expenses, as it undertakes training efforts for its employees on a reg-

Meanwhile, on the overall demand environment, he said there is a prevailing softness because of the economic prospects in the US - the major market for the USD 245-billion Indian IT sector and the IT companies will become more optimistic when they see clarity.

"Optimism or the lack of it (for tech companies) comes from the point that we don't have a certainty on the government's position on how they want to handle... their current belief is that they will prefer some sort of slowing down because the economy is very hot, unemployment rates are also very low," he said.

"If the governments are going to be driving a slowdown, that will have an impact on all parts of the economy, including IT spending. That's where our uncertainty or caution comes from," he said.

Krithivasan said once there is clarity that the US Fed interest rate would not be hiked further, or the government clearly indicates that interest rates will not go up any more, that could be a good indicator for the IT industry, as it will encourage clients to start spending.

All total contract values (TCVs) are not getting converted into revenues in the older signed deals because clients are re-evaluating their priorities on what they need to invest in, he said, maintaining that some projects get delayed or scrapped as a result.

He, however, declined to quantify the dip in the TCV-to-revenue conversion rates

On Wednesday, TCS had reported a 17 per cent jump in Q1 net profit but pointed towards sluggishness on revenue growth in FY24 because of the ongoing market challenges that have led to minuscule revenue growth on a

The TCS scrip was trading over 2.5 per cent higher at ₹ 3,346 on the BSE in afternoon trade.

Govt imposes import restrictions on certain gold jewellery, articles

NEW DELHI, July 13 (PTI): The government on Wednesday imposed import restrictions on certain gold jewellery and articles, a move which would help cut import of non-essential items and contain trade deficit. Now an importer would need a permission of licence from the government

for importing these gold products. However, the directorate general of foreign trade (DGFT) said that the restrictions will not be there for imports under the India-UAE free trade agreement.

In a notification, the DGFT said that the import policy of these products has been amended from free to restricted with immediate effect"

Imports of pearls, precious and semi-precious stones dipped by 25.36 per cent to about USD 4 billion during April-May this fiscal. Gold imports too contracted by about 40 per cent to USD 4.7 billion in the same period.

Overall merchandise imports during April-May this fiscal declined 10.24 per cent to USD 107 billion. The merchandise trade deficit for April-May 2023 stood at USD 37.26 billion against USD 40.48 billion during April-

Clarificatory amendment to GST Act on online Rupee gains 10 paise to close at 82.08 Rupee gains 10 paise gaming in monsoon session: Revenue Secretary

The online gaming companies have been paying tax at lower rates

NEW DELHI, July 13 (PTI): Revenue secretary Sanjay Malhotra on Thursday said the central government will bring clarificatory amendments to the GST Act in the monsoon session of Parliament to implement GST Council's decision of imposing 28 per cent tax on online gaming, casino and horse rac-

The monsoon session will begin on July 20 and end on August 11,

"It will be our effort to draft the law and introduce it in Parliament and get it passed in the monsoon session," he told PTI in an interview.

The implementation takes effect only when state legislatures have also passed amendments in state GST laws, he said, adding, that it will take some time.

"This is a clarificatory amendment. It has been our view that online games for stakes depend on outcomes...whether game of skill or



game of chance. The Council has only reiterated and confirmed that view that these games are taxable at 28 per cent on the full face value or the payment which is made to the online gaming platform," he said. So in that sense it is not retrospec-

tive, he added. The online gaming companies, however, have been paying tax at

lower rates on Gross Gaming Revenue (GGR) which works out to be less than 5 per cent which is applicable on food, he said.

The Goods and Services Tax (GST) Council in its meeting on Tuesday decided to impose a 28 per cent tax on the turnover of online gaming companies, horse racing and

The tax rate was decided based on the recommendation of a group of ministers that looked at taxing casinos, horse racing and online gaming. The issue before the GoM (group of ministers) was whether to impose a 28 per cent GST on the face value of bets, or gross gaming revenue, or just on platform fees.

The GST Council decided to im-

pose tax on the entire value. The tax on online gaming companies would be imposed without making any differentiation based on whether the games required skill or were based on chance.

BJP leaders' aggressive approach

ullying political opponents has become a key strategy employed by the top leaders of the Bharatiya Janata Party (BJP). This aggressive approach is aimed at suppressing dissent and maintaining control over the political landscape. Recent tweets from Amit Shah, the Home Minister of India and a prominent BJP leader, have shed light on the party's tactics. Shah's tweets, particularly one regarding the Supreme Court's decision on the appointment of the Enforcement Directorate (ED) director, reveal the party's inclination towards intimidation and a disregard for democratic values. With the political landscape shifting against the Modi government, it remains unclear to what extent the new director will be willing to align with the party's objectives. The aggressive posture of the Supreme Court adds further ambiguity to this equation. The upcoming nine months are crucial for the Modi government. The ED's aggressive pursuit of the opposition in states like Maharashtra and Bihar, which together contribute 88 members to the Lok Sabha, highlights the government's determination to undermine its rivals. Despite the Supreme Court's ruling on the illegality of Mishra's extensions, the Modi government justified its decision to retain him as the director. They claimed his services were required for a review meeting related to the Financial Action Task Force, an international organisation combating money laundering. However, other bureaucrats with foreign affairs expertise could have undertaken this responsibility, making the government's insistence on Mishra suspicious.

In a similar case, the Patna High Court declared the extension of an animal husbandry official's service illegal and convicted a politician for granting the extension. The Modi government's endorsement of illegal acts in Mishra's case raises concerns about their commitment to upholding the rule of law. The ED has faced accusations of selectively targeting individuals based on their political affiliations. The BJP's strategy of bullying political opponents through the misuse of institutions like the ED poses a threat to democracy and the rule of law in India. Shah's tweet and the subsequent reactions reveal the party's determination to maintain control and silence dissent. The Supreme Court's intervention and criticisms of the ED's conduct highlight the need for independent oversight and accountability. As the political landscape evolves, it is crucial to ensure that institutions are not exploited for partisan interests but serve the larger goal of unholding democratic values.

SC's final hearing on abrogation of Article 370 has special significance for 2024

early five years after the abrogation of Article 370 and Article 35 spoken of in the past tense, the Centre is once again hoping to get electoral dividends out of the abrogation. At least that is the feeling one gets. For the majority, the abrogation of Article 370 was a nonevent, an election gimmick and over the next couple of years proof that trusting the Modi regime was a fool's errand.

Now, the Supreme Court is set to hear a batch of petitions on the abrogation of Article 370 and the fear of revoking the abrogation is a disturbing thought for those who took abrogation as medicine. For the vast majority of people from outside the Valley, the Hindutva supporters of the BJP in particular, there is nothing left in Article 370. Whether it stays removed or is returned in whatever form doesn't matter.

The general consensus is the Modi government took the country for a ride on August 5, 2019. Fears of an American base at Saint Martin's Island kicks fresh row in Bangladesh politics

In the mid-60s the radical students of the East Pakistan Chattra (Student) League and also a few leftist elements to arouse dissent against the regime of a military dictator General Ayub Khan of Pakistan said that he has leased Saint Martin's island in the southeast tip of the country to the United States to build a military base to counter India.

After the independence of Bangladesh, the myth loaded with political jargon melted away. A similar story of St. Martin's being given away to America popped up several times since its independence in 1971. A couple of times during the military juntas of a liberation war hero, General Ziaur Rahman (1977-1981) and founder of Bangladesh Nationalist Party (BNP), and General Hussain Muhammad Ershad (1982-1990), founder of Jatiya Party were in power. They were deliberately blamed for facilitating inroads for America to counter the regional influence of India.

Once again, Bangladesh's only coral island, Saint Martin's is in fresh controversy for being given away to the Americans, this time not to counter India, but China's hegemony in the South Asia region.

This time, Prime Minister Sheikh Hasina herself exploded a bomb, when she asked "How did BNP come to power in 2001?" at the press conference at her official residence Ganabhaban on 21 June.

"They came to power by pledging to sell gas [to India]. Now do they want to sell the country [to the United States] or come to power by pledging to sell Saint Martin's island," she told.

Well, she did not mention the name of any country, but it is understood by political analysts, that she pointed her fingers towards two countries. The export of natural gas through a pipeline to energystarved West Bengal, India and the coral island to the American for a military base.

She was upbeat to politically admonish BNP that the 'Kings party' had negotiated with India, which helped the rightist party leader Khaleda Zia to return to power in the 2001 October elections.

She blames BNP negotiated with Wash-

She blames BNP negotiated with Washington DC to give away the 'critically endangered' coral island to America for a military establishment to watch over a huge swatch of the Bay of Bengal, which merge with the Indian Ocean in the far south.

Promptly, BNP secretary general Mirza

Fakhrul Islam alleged that Prime Minister
Sheikh Hasina, as of her political strategy, provided false information about BNP's

The US had no intentions to acquire Saint Martin's Island. "We have never engaged in any conversations about taking over Saint Martin's Island," he remarked.

The spokesperson, putting

did not hesitate to comment that in the "last 15 years, she [Sheikh Hasina] is in power without reflection of the will of the people executive Syeda

away his diplomatic niceties

without reflection of the will of the people of Bangladesh, though."

The issue was first raised in the Jatiya Sangsad (parliament) on 14 June by a left leader, Rashed Khan Menon, president of Bangladesh Workers' Party and an alliance of governing Awami League said the countries that "have the US as a friend, do not need any enemies".

He stressed that the US sought Saint Martin's and Bangladesh's participation in the Quadrilateral Security Dialogue (Quad), a strategic Indo-Pacific alliance, where Australia, India, Japan and the United States are primary members.

Six days later, another radical politician Hasanul Haq Inu, president of Jatiya Samajtantrik Dal (JSD), also an ally of Awami League in his speech in parliament said, "The time has come for us to think about the reason for this over-enthusiasm of the US. Is it democracy or Saint Martin's Island?"

A British team of surveyors in 1900 included Saint Martin's island as part of the British Raj in India and named it after a Christian priest Saint Martin.

The Department of Environment (DoE)

in 1999 declared the 8 Sq. Km island an Ecologically Critical Area (ECA). As per section 19 of the ECA Management Rules 2016, notwithstanding anything contained in any other law, the class of land of any ECA cannot be changed without permission of the DoE. Thus, any construction of establishments on the island is illegal and dangerous for saving the coral reef at Cox's Bazar-Teknaf peninsula.

Despite several official notices and high court orders, the island has more than 230 hotels, resorts, cottages and restaurants, either one-storey or multi-storied.

Green activists and researchers say the island is home to several globally endangered marine turtles and birds, including rare Pacific reef-egret, red crab, dolphin and vulnerable olive Ridley sea turtles, which are also on the verge of disappearance.

The longstanding political debate over the island could be understood from a news report on 18 December 1980. The defunct Dainik Bangla published a report under the heading "None will be allowed to establish a naval base at Saint Mar-

A stern warning was issued in a statement by the Bangladesh Ministry of Foreign Affairs. The statement alleged that several political parties claimed that a country [United States] has been allowed to set up its naval base at Saint Martin's island is completely baseless.

However, political historian and researcher Mohiuddin Ahmad quoted in a reputed Bangla-vernacular newspaper Prothom Alo that he first heard in February 1971 about leasing Bhola's Monpura island out to the USA.

The rumour had spread, soon after Bangabandhu Sheikh Mujibur Rahman held a parley with the US Ambassador to Pakistan, Joseph Simpson Farland, on 28 February 1971 – a month before the genocidal campaign 'Operation Searchlight' launched by Pakistan military, which sparked the liberation war.

The pro-Chinese left Maoist parties and their affiliated youth organizations printed a propaganda leaflet that Monpura Island will be given away to America, in exchange for US support for the independence of Bangladesh.

The disinformation against Sheikh Mujib died when the United States tilted towards Pakistan's military junta during the bloody war of Bangladesh's independence in 1971.

The blame game by political opponents in Bangladesh is a dilemma alleging the ruling elites are going to lease out Monpura or Saint Martin's Island to the US or going to provide benefit to India are ageold political bashing, said writer Ahmad.

Some political observers believe that the imposition of sanctions by the USA against the anti-crime special unit Rapid Action Battalion's (RABs) seven current and former senior officers were accused of violating human rights including extra-judicial killings and enforced disappearances – recent US visa restrictions for officials, the ruling party and opposition, whoever undermines democracy and cause hindrance to a free and fair parliament elections in January 2024, have raised eyebrows among political leaders and government officials.

They did not hesitate to slam the United States' foreign policy and deemed the announcement as interference in the internal affairs of a sovereign country.

Meanwhile, Bangladesh Foreign Minister Dr AK Abdul Momen said this week "We welcome the continuous engagement with the US to wipe off misunderstanding between Dhaka and Washington if there was any." He told reporters when he was asked to comment on the upcoming highlevel official visit from the United States.

Dhaka would welcome if the US delegation led by US Under Secretary for Political Affairs Victoria Nuland and US Assistant Secretary of State for the Bureau of South and Central Asian Affairs Donald Lu scheduled in early July came up with a "bright idea" as Bangladesh is committed to hold free, fair and violence-free elections, said Dr Momen. oldman Sachs is at its old game again - that is, exceedingly long term projections of the comparative growth of economies and trying to foresee the shape of the global economy over,

say, fifty years.

The global investment bank's latest projections show India in an exceedingly happy colour. It will be the second largest economy in the world in 2075 and the size of its GDP should be as big as \$52.5 trillion. The first would be that of China at \$57 trillion. The present day Goliath, United States, should have a GDP of \$51.7 trillion.

The first time Goldman got into this business of projections, it had identified four countries which should become giants of the future. These were Brazil, Russia, India and China. Later on, South Africa had joined the august band, thus BRIC has become BRICS.

That was over a decade back and now it is possibly taking a second look. But going by the present status of the vaunted five, only India and China seem to have borne out the Goldman optimism. India and China are on their way to greatness. The others appear to have somewhat fizzled out. The most spectacular disappointment has been Russia. Despite it having every-

thing on its side to sprint along the growth path, the country had put itself into a vortex of a downward

Pursuing its vanity of an imperial

dream and coveting small little parcels of land when it has almost half the globe in its territory already, Russia has pursued a foolish path towards destruction. Against such reality of a decrepit present, it had everything going for it: its manpower had world beating potentials in innovations and scientific achievements, its resources were immense and far more than any other major economy. Yet, its political leadership had landed it in catastrophe. Next in line is China. Its achievements over the last three and a half decades have been stellar by any yardstick. Never before a country had pulled up its vast poor above destitution as China did with breakneck speed of growth and development.

velopment.

It built up its economy from the ashes of another ill-conceived political campaign - Mao Tse Tung's Cultural Revolution - when the country had suffered one of humanity's worst mass starvation and death. With its liberal policies after the strangulating regimes of earlier years, Deng Tsiao Ping, had changed the country beyond recognition during his tenure.

Now nearly forty years after its

opening up, China is already the second largest economy in the world. Varying estimates put it that close to 800 million people have been lifted out of abject poverty and the rich Chinese are the largest conspicuous consumers in the world. No large global company can ignore the Chinese market for the incomparably large size of de-

Along with radical economic reforms, Deng had introduced even more radical political and institutional reforms. Most important, Deng had sought to ensure an institutional mode of rule, against authoritarian control, which is subject to the whims and fancies of an autocrat. Deng had introduced collective rule at the top, thus seeking to rule out individual idiosyncrasies of an autocrat. Thus, a collective decision-making could avoid the errors of a single autocrat. With this system, Deng had introduced a strict rule of time bound offices at the highest level. Thus, the Chinese president was to have only two terms of five years each, as in say other mature large countries, like United States or in Europe.

The current Chinese leader and president, Xi Jinping, had scrapped both these rules and ordained himself with life long tenure at the top. Xi has surrounded himself with sycophants and yes-men thus no

one dares to point out any mistakes in judgment.

These are curious parallels -

Russia and China. Both the supreme leaders of the two countries have pursued a strikingly similar paths. Both have captured power which they have sought, by hook or crook, for lifelong tenures. Both have undermined all institutional structure to ensure severely autocratic rules. Above all, both are imbued with past history of national glory and imperial dreams. The Russian autocrat is dreaming of Peter the Great and sprawling empires in East Europe.

The Chinese autocrat is referring

The Chinese autocrat is referring to Chinese Imperial glory and always referring to the Chinese rules in expanding concentric circles. According to Xi's views, the current boundaries of China is the first concentric circle of the Chinese historical empires. Then comes the somewhat larger concentric circle. which includes tributary nations, such as, Japan, Korea, entire southeast Asia. Thus, the whole extent of South China Sea, which has served as International seaway for the world, is being claimed as Chinese sovereign territory.

Xi's ambitions do not stop there. For him, China extends into south Asia and large parts of Indian territory belongs to China. XI is already competing with Russia, claiming subservience of Central Asia countries, from Kazakhstan, Turkmenistan, and other former Soviet republics.

In no time, the two "best friends"
- Russia and China, as announced
by them prior to former Ukraine invasion - are likely to cross swords.
Russia had occupied north East
Asian territories adjoining Chinese
borders as large as the size of
Ukraine. Vladivostok is claimed by
China as its own town.

China is on a global crash course. It is picking up territorial fights with all its neighbours - some fourteen of them. It has the world's largest boundary with neighbouring countries - some 24,000 kilometres long and large claims in the world's seas. China is pursuing to see its imprint across the world and coming close to fighting battles.

In 2075, the terminal year of Goldman Sachs' prediction cycle, India would surely be first or second largest and United States might still be vying for the pride of place with India. Going by this year's economic performance, Indian economy is regaining the poise it had before the pandemic struck. We are almost where we would have reached had the pandemic not played devastation. Hopefully, at least on one count the Gold Sachs prediction will not go astray. India will be at the top. (IPA Service)

Decoding the mystery of space launch windows

very journey into the cosmos requires precise calculations and meticulous planning. The celestial dance of the planets and our moon governs not just the tides and seasons, but also the launch schedules of our spaceships. Each space mission begins with the identification of a 'launch window', a specific period ripe for the voyage. As we prepare to explore the mysteries of the moon with India's upcoming lunar mission, Chandrayaan 3, we delve into the intriguing complexities of these essential launch windows.

Launch windows serve as specific time frames during which a spacecraft must embark on its journey to successfully reach the designated destination. These unique moments are derived from numerous determinants, encompassing the spacecraft's trajectory, the positions of the Earth and the destination, as well as mission-specific prerequisites. To bring this into perspective, we'll analyze the forthcoming Chandrayaan 3, the sequel to the lunar mission launched by India in 2019, Chandrayaan 2.

Chandrayaan 3, designed for lunar explo-

ration, required a carefully calculated launch window to facilitate its ambitious journey. Several fundamental factors contributed to the determination of this launch window, including the Moon's position, the trajectory from Earth to the Moon, and the mission's objectives.

* Moon's Position: The Moon's position in its orbit around the Earth is of pivotal importance in determining the launch window. Since the position changes over time, the window for launch is decided when the Moon aligns favourably with the intended trajectory of the spacecraft. For Chandrayaan 3, this had to correspond with the objectives of lunar exploration.

* Earth-Moon Transfer Trajectory: To reach the Moon, a spacecraft must adhere to a distinct trajectory that leverages orbital mechanics. This trajectory and the alignment of the Earth and Moon significantly influence the selection of the launch window. "In the complex process of determining a spacecraft's launch window, we place significant emphasis on delta-v, or the necessary change in velocity, for a successful transition from Earth's orbit to a lunar transfer orbit. The ultimate goal is to select a launch window that

minimizes this delta-v, thereby enhancing the mission's fuel efficiency," shares Srimathy Kesan, CEO of Space Kidz.

* Mission Objectives: The goals of the

* Mission Objectives: The goals of the mission also heavily influence the determination of the launch window. The lack of an orbiter in Chandrayaan 3 necessitates different operational conditions for a successful mission. This changes the factors considered, like lunar surface visibility and landing conditions, for establishing the optimal launch window.

* Launch Vehicle Constraints: "The intricacies of planning a lunar mission go far beyond just plotting a course. One must carefully consider the constraints and capabilities of the chosen launch vehicle - in this case, the Geosynchronous Satellite Launch Vehicle Mark III (GSLV Mk III). Factors such as payload capacity, propulsion capabilities, and overall mission requirements are critical in ensuring a successful transition from Earth to the Moon," explains Kesan.

Once these elements have been thoroughly analyzed and factored into the equation, the optimum launch window can be determined. As with Chandrayaan 2, the Indian Space Research Organisation (ISRO) carefully dis-

sected various parameters and fixed a precise launch window for Chandrayaan 3 in July 2023. This selected launch window boasted several optimal conditions, including the Moon's position and the launch vehicle's capabilities.

Launch windows can often be limited and infrequent, constrained by the dynamics of celestial bodies and mission requirements. Sometimes, opportunities may arise only every few days, weeks, or even months, thereby adding to the complexity of mission planning. Delays or technical issues can result in major setbacks or necessitate waiting for the next available window. In conclusion, finalizing a launch window for a spacecraft like Chandrayaan 3 requires meticulous analysis of an array of factors including the Moon's position, Earth-Moon transfer trajectory, mission objectives, and launch vehicle constraints. The finalized launch window for Chandrayaan 3, set for July 14, 2023, optimizes these parameters, setting the stage for a successful mission. The art and science of determining the launch window is a crucial aspect of space mission planning, one that demands extensive knowledge and expertise to ensure mission success. (IPA Service)

How a Boston student's killing sparked a movement against police shooting among South Asian diaspora

n July 4, as many Americans celebrated the country's Independence Day, the family and friends of Bangladeshi-origin student Arif Sayed Faisal in Boston commemorated six months since the police shooting that took his life. Faisal's killing has catalysed important conversations among Southasians on policing, racism as well as mental health, often a stigmatised issue in many households.

South Asians are directly affected by the policing of poorer neighbourhoods, associations with Islamophobic stereotypes, lack of cultural awareness, language barriers, and perceptions of security threat, including through associations with Blackness. Anti-Blackness among the community, too, remains a cause for concern.

Shot during mental health crisis Faisal was killed on January 4 after the police responded to a 911 call about a man jumping from an apartment window with a knife and inflicting self-harm. The Cambridge police officers who arrived pursued Faisal, initially fired sponge bullets, then lethal shots, claiming failed

The officer who fired the shot that killed Faisal has been sent on paid administrative leave while the others involved remain on duty.

Since Faisal's death, organisations have been protesting regularly under the banner of "Justice for Faisal". He was a student at the University of Massachusetts Boston, and was home for the winter break. The Justice For Faisal coalition on January 29 marched to the "Mystic Mural", a community art project on the environment that Faisal had contributed to as a student at Somerville High School.

"Victims of police killings are not just another statistic," said Suhail Purkar, an organiser with the Party for Socialism and Liberation Boston, and Boston South Asian Coalition. "It is important to remember their humanity.'

The organising in Cambridge for police accountability may signify a new moment of antiorganising, activism coalition-building, bringing together the Southasian diaspora with local activists fighting systemic racism and police brutality. On July 8, the Justice For Faisal activists held a rally at

The groups involved include the Bangladeshi

for Socialism and Liberation, and Muslim Justice League.

Criminalisation of mental health crises

Faisal is not the first person of colour to be shot dead while undergoing a mental health crisis in the US. There is a long history of criminalising people suffering mental-health emergencies. Between 2015 and 2018, almost a quarter of those killed by the police had a known mental illness. A database compiled by The Washington Post shows that there have been over 1,700 cases of mental illness-related police shootings since 2015.

Only a handful of such cases get public attention. In 2016, Hope Coleman, the mother of Terrence Coleman, had called 911 asking support for her son who was having a schizophrenic episode. He was, instead, shot and killed by the Boston police. "Had I not called 911, my baby would be alive," she said. Coleman has been attending the Justice for Faisal rallies where she shares her own story.

In 2020, the Boston police shot and killed Juston Root after wounding him. He had been suffering from a schizoaffective disorder and had been carrying an unloaded plastic BB gun, a replica gun. The 41-year old was lying "defenceless, on the ground, semi-comatose, and bleeding profusely", according to a statement from the lawsuit filed by his family against the city of Boston. "Juston was not brandishing a firearm nor did he have any firearm in his possession," said the lawsuit. Despite calls to action, little has changed. The Mapping Police Violence portal documents that US police shootings kill nearly 1,200 people every year.

Media portrayal Purkar pointed to the "dehumanising difference" with which the media tends to portray Faisal compared to the policemen who killed him. This feeds the misperception of Faisal as an "armed man", prompting some to justify his killing. CBS News Boston ran the headline "Man armed with a machete shot and killed by the police" without mentioning Faisal's mental health crisis or that he was inflicting self-harm. Another media report noted that the police official who shot Faisal had seven years of experi-

South Asians and policing The relationship between South Asians and

policing reflects the racist structure of US policing and internal differences among South Asians in their experiences with policing. Southasians in the US are stratified by caste, class, religion, language, nationality, ethnicity, and documentation status.

The effects of and responses to policing follow similar lines. Some South Asian individuals and communities, who live in areas similar to the public housing block that Faisal lived in, are more policed than others.

Last November, police in Austin, Texas, killed Rajan Moonesinghe, a Sri Lankan American entrepreneur. The police were responding to a report from Moonesinghe of a possible burglary at his home. The police mistook him for the burglar and shot him before he had the chance to lower his gun.

In 2015, the Alabama police acting on a report about a "skinny Black man" apprehended Sureshbhai Patel, a 57-year-old Indian visiting his family, who was walking around the neighbourhood. Unable to understand what the police were saying, Patel did not follow their commands. "My South Asian friend gets regularly stopped at traffic lights because the police assume he is Black," said Purkar.

Police reforms

Support for police reform is growing among South Asian Americans. A 2017 NPR report said that 44% of Bangladeshi Americans, 50% of Pakistani Americans and 49% of Asian Indians did not believe that the police treat all racial and ethnic groups equally. In 2020, among Asian Indians, 51% strongly agreed and 24% somewhat agreed that local governments should reallocate police funds towards welfare programs, according to AAPI Data. AAPI refers to Asian Americans and Pacific Islanders.

"There is still need for more political education," said Sharmin Hossain, a Bangladeshi-American artist and former Political Director at Equality Labs, a US-based Dalit civil-rights organisation. She said that conservative politics uses Southasian Americans and Muslim Americans, including through "anti-immigrant views that are responsible for policing of other Southasians". Hossain noted that a primary way

South Asians experience policing is through immigration, referring to police apprehending as many as 63,927 Indians at US borders in 2022. Today, many among the older generation of Southasians no longer see the police in America as benevolent

Community bridges, 'anti-Blackness'

There is clearly a greater need for consciousness raising among the Southasian diaspora, said Cambridge community organisers. Part of the work is "to reflect upon anti-Blackness in our own communities so that our aunties and uncles are not the ones calling the cops on Black folks and on each other", said one activist who did not want to be identified.

Some of those organising in Cambridge said that the South Asian community needs to understand "being a good immigrant does not protect us from racist police violence". The focus, they said, should be on showing up and joining the Black, Latinx and indigenous folks doing this work for decades.

The Justice for Faisal movement is also a movement seeking justice for Tyre Nichols and Terence Coleman, said the organisers. Unnecessary deaths, like in the case of Faisal and others, are due to continued bad policy choices informed by racist structures. Political will can make all the difference. The organisers also highlighted the need to connect the dots transnationally, as people protesting Faisal's killing in Dhaka have been doing, and to recognise how policing disproportionately affects some communities "back home".

In America, ongoing discussions among the community are highlighting the imperial and military connections of US civilian policing, such as the 1033 program, which transfers Defense Department military equipment to local, state and federal law enforcement.

The community continues to demand the release of names of the police officials involved in Faisal's murder, the release of the unredacted

police report. They have also demanded that the police officials be charged and prosecuted. "The only reason it would matter if the police official is a South Asian/Black person is to reiterate that bad policing is not an issue of application or representation," said Payal, an activist.

leased because of a judge order until an inquest is completed. The Cambridge police prides itself as being one of the best trained forces in interpersonal dynamics. People, thus, are divided on more police training or changing the nature of training, including training not to shoot at centre mass, or the torso. In June, the city council moved to vote down without discussion a proposal to turn the Police Review and Accountability Board into an elected body. The Justice for Faisal community has also asked for structural changes: disarm and demilitarise the police (including dismantling the 1033 programme), funding an alternative emergency response system separate from the police, and reallocate the budget into community safety and support.

Small wins, ways forward

The activism and solidarity of Black and Brown communities in Cambridge has contributed to Cambridge City Manager Yi-An Huang announcing that the police will use body cameras. Proposals on ways forward include the Cambridge Holistic Emergency Alternative Response Team, or HEART, an alternative response system formed after demands to delink police from mental health emergency responses. Elsewhere, non-carceral response teams such as Crisis Assistance Helping Out on the Streets are working with local communities.

These initiatives, centering unarmed but trained civilian crisis response to 911 calls, represent a way forward. However, such initiatives only go half way if they continue to operate as nonprofits and are not built into the publichealth system, said Purkar.

Currently, HEART is a subcontractor with the Department of Public Health, substantially underfunded at less than \$2 million. In contrast, the Cambridge Police's 2023 budget is to increase by 7%, from \$68.7 million to \$73.5 million. Organisers note that under current regulations, situations like Faisal's would be categorised as violent and still go to the police.

"At the very minimum, mental health emergency care has to be completely de-linked from incarceration," said Payal, who works in the healthcare system. What emerges in these debates about effectiveness and better alternatives is a consensus across the South Asian diaspora against racist policing, and an emerging allyship with the fight against systemic racism in Amer-

ence on the force, with no complaints.

any assessments in the past week on the developments in Russia seem to indicate that the Wagner mutiny has weakened President Putin and that the outcome of the rebellion is the shattering of the image of invincibility that President Putin had cultivated in the past two and a half decades. If looked at closely, the rebellion highlighted the increasingly problematic relations between the Wagner group and the Russian Ministry of Defence over the course of action in Ukraine. This chain of events between 23-24 June 2023 has raised multiple questions ranging from what led to the mutiny, reactions from within Russian leadership, and its impact on the Ukraine crisis. This article looks at five key questions that emerged from these developments in Russia.

Decoding Wagner's challenge

First is what led to the tensions between the Wagner Group and the Russian military leadership: The differences between the two have been on the rise for some time over a range of issues, including the rationale of war in Ukraine as well as the lack of support for the Wagner Group soldiers from the military leadership. Twofold events preceded the 'March for Justice' - as Yevgeny Prigozhin, leader of the Wagner Group called it - first, was the abject failure of the Russian military leadership to provide the Wagner group with arms and ammunition which resulted in massive fatalities for the group. This was further compounded by the fact that Prigozhin accused the Russian military of striking Wagner's base in Ukraine. Second was the intended plan to bring the Wagner group under the direct control of the Russian military command. President Putin had backed the Ministry of Defence's order for the mercenary groups present in Ukraine to sign contracts with the ministry before 1 July 2023. This order would subsume these groups within the defence ministry's command structures and was vehemently opposed by the Wagner Group leader. This would have meant undermining Prigozhin's influence within the group. The tensions further escalated on 23 June 2023 when Prigozhin stated that the Defence Ministry was trying to "...deceive the public, deceive the president and tell a story that there was some crazy aggression by Ukraine, that - together with the whole Nato bloc – Ukraine was planning to attack us" - thereby vowing to go "all the way" to topple the military leadership. However, one thing that stands out in this is that Yevgeny Prigozhin never claimed to overthrow President Putin, rather the targets of his outburst were Defence Minister Sergei Shoigu and the Chief of the General Staff, Valery Gerasimov - whom he accused of failing the Wagner Group. Therefore, it appeared to be a breaking point between the Wagner group and the Defence Ministry to protect his interests in the group.

Second, is reading between the lines of President Putin's two addresses to the citizens of Russia on 24 and 26 June 2023. In his two addresses, the Russian President oscillated between vowing to crush the armed mutiny by the Wagner Group to calling the majority of Wagner Group soldiers and commanders as patriots and loyalists. However, one needs to note that President Putin

did not mention Preigozhin's name even once. In his first address, he said that Russia was facing "treason" due to personal ambitions and interests and "all those who have consciously chosen the path of betraval... will inevitably be punished" - calling the rebellion a "fatal mistake". However, the tenor of his second speech is completely different. President Putin goes on to reiterate that on his direct instructions, "steps were taken to avoid spilling blood" and offered the soldiers of Wagner group two choices—first, signing the contract with the Defence Ministry or other law enforcement or security agency or returning home; and second, exile in Belarus. Re-asserting his position, he vowed to keep his promise and added that "everyone is free to decide on their own" what path to choose. The two speeches appeared to be an attempt by President Putin to reassert his power, control the narratives, and highlighted that he had been at the forefront of dealing with the situation which had all the makings of spiralling out

Following from the previous point, the third key question is what deal has been brokered by Belarus. So far what is known of the deal is as follows - Yevgeny Prigozhin ordered his troops to halt their march to Moscow and to return to their base in South Russia and further agreed to move to Belarus. Following this, Dmitry Peskov, Kremlin's spokesperson, announced that the criminal charges against Prigozhin will be dropped as he exits Russia. He further added that considering their service to Russia, no charges will be placed against the Wagner troops who were part of the march. What has not been released are the concessions that have been made to Prigozhin. The focus, for now, seems to have shifted from crushing the mutiny to avoiding the bloodshed - a reference that was present in both President Putin's speech of 26 June 2023 and Prigozhin's statement post the deal. What is interesting is the role played by Belarusian President, Alexander Lukashenko in resolving the situation. During the course of the conflict in Ukraine, Lukashenko has emerged to be the strongest ally for President Putin, even allowing Moscow to station nuclear weapons in Belarus. This recent intervention further adds to the increasing influence of Lukashenko in Russia. While the real intentions of what the Belarusian President hoped to achieve by brokering the deal is difficult to ascertain - it could be repaying the favour for President Putin's support to his presidency during the 2020 protests after he was accused of tampering with the elections, however, it remains to be seen what this latest deal entails for Minsk.

Fourth is what is the fate of the Wagner Group in the aftermath of the mutiny. Wagner Group has been a critical part of President Putin's power projection abroad. They have been operating in various countries in Africa, especially in Mali, Libya, the Central African Republic, and Sudan, and have played a very important role in stabilising the Assad regime in Syria. However, their biggest successes have come in Ukraine, where they have been able to register gains in territories where Russian forces have underperformed. During their offensive in Ukraine, they have taken heavy losses, with the Wagner leader estimating the loss of over 20,000 men in the battle for Bakhmut.

Following the "March for Justice", the future of the Wagner group hangs in a delicate balance. So far, Prigozhi has given no intention of disbanding the group and had sent out the message that President Lukashenko was allowing them to remain operational in Belarus. While, according to reports, the Wagner group was still actively recruiting fighters from various Russian cities, however, the impact of the mutiny on the places it has been operating outside Ukraine remains to be seen. Also worth mentioning is their operations in Africa and West Asia, while Russian Foreign Minister, Sergei Lavrov had said that the Wagner group will not be withdrawn from the countries, very little is known about how these stationed mercenaries have reacted to the developments in Russia or how they are going to impact their larger operations out-

Finally, what will be the impact of Wagner mutiny on the conflict in Ukraine? Before any assessments of the Wagner group withdrawing from the fighting in the frontlines, it needs to be noted that the troops had already started to withdraw from Bakhmut in May 2023 with Russian soldiers replacing their units. So far, there has been no noticeable impact on their actions in Ukraine. rather the intensive missile strikes across various Ukrainian cities point to the fact that the domestic upheaval will have no bearing on their offensive in Ukraine. Therefore, in the short term, there is unlikely to be a change in their approach towards the war. However, in the medium to long term, since the mutiny exposed the security vulnerabilities, as the Wagner group was able to initiate a mutiny and advance towards Moscow with ease, there may be a significant tightening of the security apparatus both domestically and internationally to potentially stem similar actions.

There is still no clear sense of what exactly happened, but what is clear is that the "March for Justice" by the Wagner group presented one of the most critical challenges to President Putin in his two-and-a-half decade of power. The same could be said of the deal that was brokered by Belarusian President, Alexander Lukashenko which led to the de-escalation of the situation and the eventual retreat of the Wagner group. The intense back and forth by Prigozhin - from his rapid advance towards Moscow to his sudden retreat—has resulted in many questioning his intentions behind the entire episode: Was it to challenge President Putin's power? or was it to capture Sergei Shoigu and Valery Gerasimov, against whom he had grievances? or was it just a display of discontent over the impending absorption of Wagner group soldiers within the defence forces? In short, it remains a mystery as to why he did what he did and also why he did not go all the way to Moscow. While he clarified that he never intended to challenge President Putin's power - intended or not - the sequence of events did raise some uncomfortable questions about the President's control. The complete fallout of the Wagner mutiny is still unravelling, however, Prigozhin's issues with Russia's military actions in Ukraine and who is responsible for the underperformance of the Russian Army are going to resonate in the near future within Russian leadership. SC status: Negating intersectionality of religion & caste isn't the way forward

The recent petition filed by Activist Kudanthai Arasan from Tamil Nadu in the Supreme Court and an article on Halalkhor Muslims by Research Scholar Shireen Azam from Oxford has once again sparked off the heated debate on claims to SC status by Dalit Christians and Dalit Muslims (Henceforth, DCs and DMs). Rather than analysing the history of commission reports, petitions, and stances taken by different political parties, already available online, I hope to address four common questions. This is not a comprehensive list but only the fundamental ones that I have come across in the debates. Apart from the Union and State Governments, Hindu Right organisations, the different strands of Dalit/Ambedkarite political community are also engaged with these recurring perspec-

Religion-based demarcations

1. One often repeated argument is that since Christianity and Islam don't sanction caste and untouchability, there cannot be any claims of caste-based disabilities leading to socio-economic backwardness and therefore, no SC status can be granted.

Response: Religions such as Sikhism and Buddhism (including the Navayana strand propounded by Dr Ambedkar) too do not sanction caste and untouchability in their central tenets, yet the Dalits in these religious communities avail the SC status. One can argue they are under the larger Hindu umbrella as per Article 25 which prescribes caste distinctions, but if such is the case then why did Sikhs and Buddhists get SC status in 1956 and

1990 separately? Social scientists in the 1950s and 60s often debated on field view and book view of Indian society and even later, scholars like Gloria Raheia and Chris Fuller who undermined the role of Brahmins in caste order have argued that the expressions of caste in social life are different from what Hindu texts prescribe. In fact, it is a well-established fact that caste order in South India is often studied as a three-fold division of Brahmins, Non-Brahmins, and Dalits unlike the North having a Kshatriya Varna followed by the Brahmins. It is a different matter that today many intermediary non-brahmin castes in South India claim a Kshatriya lineage.

This is not just particular to India, but across the globe, religion takes various expressions and divisions according to the cultural surroundings because it involves human being interpreting and materialising it. And in the case of the advent of Christianity and Islam in India, the most dominant factor of their interactive cultural surround-

ing has been that of caste over centuries. Even if not an exact copy of a particular social expression of Hindu caste order, the caste communities in terms of hierarchy, occupations, and endogamy rules have developed along similar lines. In fact, Muslim rulers brought their own descent-based stratification and complemented the caste order here. Resultantly, today we find converts from communities such as Madigas, Doms, Chuhras at the bottom among Christians and similarly Halalkhors and Lalbegis among Muslims facing similar forms of discrimination like their counterparts among the Hindus. To analyse Hinduism through all its various dynamic social practices but restrict Islam and Christianity merely to doctrine is akin to fixing the latter as static objects.

Who can seek a SC status? 2. The Muslims and Christians who claim to be Dalits should

seek redressal in their religious educational institutions rather than SC status. Response: DCs and DMs who are part of their religious commu-

nities are also citizens of India which entitles them to certain rights from the state, and to ask them to choose one between the two is basically asking them to come back to the Hindu or Buddhist fold to enjoy certain citizenship rights or be deprived of it by continuing to stay as Christians and Muslims. This also implies that religion

and caste are supposed to be two mutually exclusive compartments when it comes to Muslims and Christians. They live in the same society along with members of different castes not just from their religious communities but also others. It is almost impossible that they could escape caste and live only as religious entities, particularly in a society where caste considerations are so detailed and pervade all spheres of life. Most mportantly, minority educational institutions do not have any specific quota for these communities due to their own denial of caste and the burden to figure that cannot be placed on these communities.

Furthermore, SC status is not just about reservation in education, there are other crucial areas such as employment opportunities, welfare schemes, SC/ST sub plans, political representation and protection from atrocities that are beyond the scope of any religious body.

Here, the role of the state becomes extremely important because their material conditions and a significant part of their vulnerability lie in their caste status. Therefore if caste has led to some of these conditions similar to that of their fellow Dalit members from other religions, then that require corresponding provisions and protective measures that are based on SC recognition in the constitution. Covered under reservation

bracket, then why inclusion into SC? 3: They are already getting reservations under the Other Backward Classes (OBC) category in various states, so why demand SC status?

Response: Firstly, in the criterion for OBC classification, caste disabilities arising out of untouchability have not been factored in and consequently the measures and provisions directed towards SC and OBCs differ on many grounds. SC/ST POA is the most important difference and those who are aware of caste atrocities in Karamchedu and Tsundur in Andhra Pradesh in 1985 and 1991, would know that there were many Dalit Christians who were at the receiving end because of their caste identities.

Secondly, be it in terms of habitations or occupations, Dalit Muslims and Christians largely live alongside fellow Hindu Dalits and engage in similar occupations. This is due to their similar caste origin and also the separation by higher caste members from their own religious communities and also those who are caste Hindus.

For example, around Marina Beach in Chennai, among the Catholics most of them are from the fishing communities while among the Pentecostal Christians constitute mostly of Paraivars who either work as daily wage laborers or sanitation workers. The former are not considered untouchables but lower castes, while the latter are treated as untouchables but both of them are supposed to be under the OBC category. In Bihar and UP, Halalkhor and Lalbegi Muslims are engaged in cleaning occupations just like the Valmikis among Hindus and face the same social stigma.

A study conducted by Srinivas Goli, Fahimuddin, Prashant Trivedi and Surender Kumar in 2014-15 among 7000 households in Uttar Pradesh found out that Dalit Muslims experience caste untouchability which includes them having separate burial grounds, no invitations to wedding feats by non-Dalits and their children facing segregation in schools. To place them alongside Yadavs and Kurmis in the OBC category is not only a sociological fallacy but also a denial of caste disabilities arising out of their untouchable caste status.

Lastly, in order to compete alongside other OBC groups, they are not equally placed and often at the state level OBC vacancy is filled by few numerically and politically influential castes and in central institutions, the OBC seats are usually far from being filled and more than 2000 castes above DCs and DMs compete for these limited opportunities. KYIV, July 13 (AP): Ukrainian officials said air defences shot down 20 Iranian-made drones fired by Russia mostly at the Kyiv region early on Thursday, but wreckage fell on four districts of the capital, wounding two people and destroying several homes.

The latest barrage by the Kremlin's forces began shortly after midnight, and explosions shook different parts of the city. Two people were hospitalised with shrapnel wounds, authorities said.

In the capital, rescuers extinguished a fire in a 16-story building, as well as in a non-residential building, the Interior Ministry said. Debris also smashed into the frontage of a 25-story apartment building, it said.

Russian strikes have become a grim part of everyday life in Ukraine over the almost 17 months

Kyiv's recent counteroffensive in southern Ukraine, Lt. Gen. Oleg Tsokov, was reportedly killed by a Ukrainian missile strike

Tsokov died when the Ukrainian military struck the city of Berdyansk on Tuesday with UKsupplied Storm Shadow missiles, according to retired Gen. Andrei Guruley, who commanded the 58th Army in the past and currently serves as a lawmaker.

Russia's Defense Ministry hasn't reported Tsokov's death.



Influencer arrested over TikTok video satirizing wealthy Emiratis in Dubai shows limits on freedoms

DUBAI, July 13 (AP): An online influencer has been arrested in Dubai over a satirical TikTok video in which he portrays a brash Emirati on a spending spree inside a luxury car showroom.

The comedic sketch, in which he tosses stacks of bills at bewildered employees and offers to buy the most expensive car — a \$600,000 Ferrari SF90 — poked fun at the lavish lifestyles on display in the city, known for its gleaming skyscrapers and over-the-top tourism attractions.

Dubai is more socially lenient than much of the Middle East, with a relaxed dress code, bars and clubs serving alcohol — and even a local comedy scene. But vaguely worded laws forbid any speech, including journalism and satire, that is deemed critical of authorities or insulting to the United Arab Emirates, the federation of sheikhdoms that includes Dubai.

The influencer, Hamdan Al Rind, who refers to himself as the "Car Expert" online, is a UAE resident of Asian nationality. He boasts over 2.5 million followers on the popular video-sharing site TikTok. His latest video attracted millions of views and was widely shared before being taken down following his arrest.



In the video, he is wearing a kandura, the long white robe typically worn by Emirati men, sunglasses and a surgical mask. He speaks in English with a heavy Arabic accent, shouting clipped sentences at the dealership's employees while his assistants haul around a stretcher filled with stacks of cash.

The Federal Prosecution for Combating Rumors and Cybercrimes says he is accused of "abusing the internet" by posting "propaganda that stirs up the public opinion and harms the public interest." It said the video "promotes a wrong and offensive mental image of Emirati citizens and

ridicules them," the state-run WAM news agency reported on

Sunday The WAM report described the video but did not identify the influencer or specify his nationality. It's unclear when exactly Al Rind was arrested or what penalties he could face. It's not known whether he has hired an attorney.

Just last month, a UAE resident of Arab nationality was sentenced to five years in prison and a \$136,000 fine for violating hatespeech laws by posting a video ranting against men and domestic workers. Prosecutors had ordered her arrest "in the context of the 'buzz' generated by the posting of

the offending video," WAM re-

A vaguely-worded cybercrime law enacted in January 2022 heavilv restricts expression and assembly, criminalizing virtually any form of political opposition and anything that could harm the reputation of the UAE or its leaders. Fifteen human rights groups have called for the law to be repealed or amended.

Ahmed Mansour, the owner of Luxury Super Car Rentals Dubai, where Al Rind filmed his video, said he thought the man was an Emirati citizen.

"He came in, he wanted to shoot a video, I said 'yes.' If it didn't happen in my showroom, it probably would have happened somewhere else," he told The Associated Press. "Some people thought it was offensive, some people thought it was funny, everyone has their own opinion.

"I thought he understood the law," Mansour added. Al Rind, who operates his own

car dealership in the UAE, has posted satirical videos before including one that went viral in which he portrays a wealthy Emirati purchasing cars for each of his four wives — besides video tutorials on how to fix vehicles

after observing new long-range missile launch SEOUL, July 13 (AP): North Korean leader Kim Jong Un vowed to further bolster his country's nuclear

fighting capabilities as he supervised the second test flight of a new, powerful intercontinental ballistic missile designed to strike the mainland United States, state media reported on Thursday. Kim's statement suggested North Korea would

ramp up weapons testing activities to expand its arsenal in response to recent US steps to enhance its security commitment to ally South Korea. "(Kim) clarified again that there will be no change

and vacillation in the strategic line and policy of (the North Korean) government to steadily accelerate the development of more developed, effective and reliable weapon system," the Korean Central News Agency

Kim said North Korea is compelled to bolster the country's "nuclear war deterrent" because the security environment on the Korean Peninsula "is being seriously threatened by the hostile forces every moment." The Korean Central News Agency reported Kim's

comments a day after the launch of the Hwasong-18, which was first test-fired in April and which Kim has called the most powerful weapon of his nuclear forces. The road-mobile ICBM has built-in solid propellant, which makes it more difficult to detect in advance than liquid-fuelled missiles.

KCNA said the launch was meant to reconfirm the technical credibility and operational reliability of the missile. Kim called the launch "another important stride" in efforts to boost the North's strategic forces,

According to KCNA, the missile was launched at a high angle to avoid neighbouring countries. It flew 74 minutes and a distance of 1.001 kilometres at a maximum altitude of 6,648 kilometres before landing in a targeted area in the open waters off the North's east

The missile's flight time is the longest recorded by



any weapon launched by North Korea. If launched on a standard trajectory, the missile could fly to the mainland US, though some experts say North Korea still has some technologies to master to acquire functioning nuclear-armed missiles.

South Korea, Japan and the United States criticised North Korea over the launch that they said posed a threat to regional and international peace. Adam Hodge, a spokesperson for the US National Security Council, said in a statement that the US will take all necessary steps to ensure the security of the American homeland and South Korean and Japanese allies.

The United Nations Security Council scheduled an open meeting late Friday afternoon to discuss the ICBM launch at the request of the United States, Albania, France, Japan, Malta and the United Kingdom.

Wednesday's launch violated UN Security Council resolutions that ban any North Korean launches using ballistic technologies. But it's unclear if the council can impose new sanctions on North Korea because China and Russia, both veto-wielding permanent members, had blocked the US and others' previous attempts to do so over North Korea's other recent ballistic launches

Another bank in Manipur hill district found looted

IMPHAL, July 13 (NNN): In yet another attempt to loot banks, the Kangpokpi branch of Manipur State Co-operative Bank at IT Road was vandalised by miscreants on Wednesday night, official sources here said on Thursday.

No cash was looted as all the cash in the bank had already been shifted at the initial stage of the violence that erupted on May 3 last, the sources said.

However, the miscreants have taken away six computer sets, one canon printer and CCTV camera hard drives after the vandalism in the bank building, a complaint lodged by the deputy manager of the Manipur State Co-operative Bank stated in the complaint to the Kangpokpi district police.

"Cash vault has also been broken, but no cash has been looted as the branch has already taken out all the cash vault as well as from the ATM in the middle week of May as advised by the head office", the deputy manager reportedly stated in his complaint letter.

He added that the said bank branch remained closed from May 4 till July 7 in view of the prevailing law and order situation in the

banks in violent hill districts were looted by miscreants taking advantage of the closure of the banks following incidents of violence.

Two incidents of looting banks were reported in the violence-hit Churachandpur district since the eruption of the violence more than two months ago.

There was a report of looting the Churachandpur branch of Axis Bank which was closed since May 4. The looting of that bank came to light when the bank branch was reopened on July 10. Sources had said that cash and jewellery items worth over ₹ 2.25 crore were found

The looting incident came to light when the manager of the bank branch went to the bank at 1.30 pm. He found the strong room was broken, reports said.

Further examination found that the looting took place after the miscreants entered the strong room of the bank by breaking the ventilator of the bathroom.

Excise policy case

SC to hear on Friday AAP leader Manish Sisodia's bail pleas



NEW DELHI, July 13 (PTI): The Supreme Court is scheduled to hear on Friday the bail pleas of Aam Aadmi Party (AAP) leader Manish Sisodia in the Delhi excise policy case being probed by the CBI and the money-laundering matter arising out of it.

According to the cause list uploaded on the apex court website, a bench of Justices Sanjiv Khanna and Bela M Trivedi is slated to hear his petitions challenging the separate orders of the Delhi High Court which refused to grant him bail in these cases. On July 10, a bench headed by Chief Justice DY Chandrachud had agreed to hear the pleas of the former Delhi

deputy chief minister on July 14. Senior advocate Abhishek Singhvi, representing Sisodia, had urged the top court to take them up for hearing as the senior AAP leader's wife was seriously ill and hospitalised. Sisodia, who held the excise portfolio among many that he handled as the deputy chief minister, was arrested by the Central Bureau of Investigation (CBI) on February 26 for his alleged role in the "scam". He has been in custody since then. The ED arrested him in a money laundering case stemming from the CBI FIR on March 9 after questioning him in Tihar jail. Sisodia resigned from the Delhi cabinet on February 28.


The high court had denied him bail in the CBI case on May 30, saying having been the deputy chief minister and excise minister, he is a "high-profile" person who has the potential to influence the witnesses. On July 3, the high court had declined him bail in the money laundering case linked to alleged irregularities in the city government's excise policy, holding that the charges against him are very serious in nature".

In its May 30 order, the high court had said since Sisodia was at the "helm of affairs" when the alleged scam took place, he cannot say he had no role to play.

The high court had said with his party still in power in the national capital, Sisodia, who once held 18 portfolios, continues to wield influence, and since the witnesses are mostly public servants, the possibility of their getting influenced cannot be ruled out.

According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue favours were extended to licence holders. The Delhi government implemented the policy on Nov 17, 2021, but scrapped it at the end of September 2022 amid

Yamuna water level in Delhi stabilises, will start receding soon: CWC



NEW DELHI, July 13 (PTI): The water level of the Yamuna river in Delhi has stabilised and will start receding tonight, a senior Central Water Commission official said on Thursday

According to the CWC floodmonitoring portal, the water level at the Old Railway Bridge rose to 208.62 metres at 1 pm and remained stable till 4 pm.

"The water level has stabilised and it will start coming down in the next four hours. It is expected to drop to 208.45 metres by 3 am on Friday," Central Water Commission (CWC) Director Sharad Chandra told PTI. He said the rate of water flow rate at the Hathnikund barrage in Haryana dropped to 80,000 cusecs at 4 pm.

The raging river has inundated several areas, impacted public and private infrastructure, road and rail traffic and caused immense hardships to people living near the river. The water level at the Old Railway Bridge crossed the 208metre mark Wednesday night, with the CWC terming it an "extreme situation". Chief Minister Arvind Kejriwal on Wednesday urged the Centre to intervene and the city police imposed Section 144 of the CrPC in flood-prone areas to prevent unlawful assembly of four or more people and public movement

The Delhi Disaster Management Authority on Thursday directed that all non-essential government offices, schools and colleges in the city be closed till Sunday. Private establishments across the city have been advised to work from home.

There are two major barrages on the Yamuna -- Dakpathar in Dehradun and Hathnikund in Yamunanagar -- upstream of Delhi. There are no dams on the river and, therefore, most of the monsoon rain flow remains unutilised, resulting in floods during the season.

Delhi had recorded a rapid rise in the Yamuna's water level over the past four days. It shot up from 203.14 metres at 11 am on Sunday to 205.4 metres at 5 pm on Monday, breaching the danger mark of 205.33 metres 18 hours earlier than expected. The river exceeded the evacuation mark of 206 metres Monday night, prompting the relocation of people residing in floodprone areas to safer locations and closure of the Old Railwa Bridge for road and rail traffic.

The water level breached the previous record of 207.49 metres by 1 pm on Wednesday and the 208-metre mark by 10 pm. Major floods in Delhi occurred in 1924, 1977, 1978. 1988, 1995, 1998, 2010 and 2013. An analysis of flood data from 1963 to 2010 indicates an increasing trend for floods occurring in September, and a decreasing trend

Bihar BJP leader dies 'following lathi charge' during protest march

PATNA, July 13 (PTI): A BJP leader in Bihar on Thursday died while taking part in a "Vidhan Sabha march" against the state's Nitish Kumar government, evoking allegations from senior party leaders that he was "killed in a brutal lathi charge". The party's Jehanabad district general secretary Vijay Singh was brought in an unconscious state to the Patna Medical College and Hospital where he died, PMCH superintendent Dr I S Thakur said.

Union Minister of State for Home Nityanand Rai, a former state BJP president, told reporters that the death of Vijay Singh during the protest march was a "sacrificial offering"

"Besides, thousands of BJP workers have been injured, some of them seriously, while lending their voice to the state's students and youngsters. The injured include many women and members of Parliament and the state legislature", alleged Rai, who represents the Ujiyarpur Lok Sabha seat.

Officials were tight-lipped about the cause of the death of Singh, who was said to be in his 40s, though the district administration in Patna came out with a brief statement asserting that "no injury marks" were found on his body.

The statement claimed Singh was found "in an unconscious state on the roadside in Chhajju Bagh locality" from where he was taken to PMCH, the state's largest government hospital. "He was admitted to the ICU but died during treatment," the PMCH superintendent said.

The cause of the death could not be ascertained till post-mortem examination is con-

ducted, another PMCH official said.



ers like former deputy chief ministers Sushil Kumar Modi and Renu Devi, were rounded up by the police and taken to a police station after they tried to cross the barricades put up at the Dak Bungalow Crossing in the state capital.

The "Vidhan Sabha march", which was organised in support of agitations against the state government's teacher recruitment policy, commenced from the Gandhi Maidan and was stopped a couple of kilometres away from the assembly premises.

Besides batons, the police used water canons and also took recourse to bursting tear gas shells to disperse the BJP workers who tried to breach the barricades. Maharajganj Lok Sabha MP Janardan Singh Sigriwal, in his 60s, showed a wound on his head to journalists.

BJP president JP Nadda claimed in a tweet that the lathi charge on BJP workers is the result of the failure and indignation of the state government. "The Mahagathbandhan government is attacking democracy to save the citadel of corruption. To save the person who has been charge-sheeted, the chief minister of Bihar has even forgotten his morality," he said.

Without naming Bihar deputy chief minister Tejashwi Yadav, Nadda was referring to the RJD leader against whom the CBI has filed a charge sheet in the land for jobs scam. The RJD which is part of the ruling Mahagathbandhan, however, came out with a statement mocking BJP leaders for "keeping their attention focused on getting photographed". It also alleged that many of the protestors had hurled "chilli powder and pebbles" at the police personnel on duty. The BJP is accusing Tejashwi Yadav of going back on the promise of "10 lakh jobs" made during the 2020 assembly elections.

Besides, the saffron party has been seeking the resignation of the young RJD leader following a fresh CBI charge sheet in the land for jobs scam. Leader of the opposition in the assembly Vijay Kumar Sinha, who had walked out during the Question Hour after a couple of BJP MLAs were evicted by marshals for unruly behaviour, sat on a dharna outside the assembly premises during the post-lunch procession. "I kept pleading with the police that let me allow to take part in the debate on the supplementary budget. But I was let off too late. This government is now taking recourse to sticks and bullets", Sinha alleged.

A former speaker himself, Sinha, who has been accusing the Chair of "acting as an instrument of the government" also announced that he would now lead a "Rai Bhavan march" on Friday to apprise the Governor of the situation.

"The Governor is the custodian of the legislature. We now need to seek his protection. The government in the state is now trying to crush by force our voice which we are duty bound to

THIRUVANANTHAPURAM, July 13 (PTI): Ahead of India's ambitious space programme Chandrayaan-3, former ISRO scientist Nambi Narayanan on Thursday said its successful landing will make India only the fourth nation to achieve this and it would increase the potential for space science development in the country Talking to PTI here, he said this will also help India boost

its share in the global space business. Currently India's share in the 600 billion-dollar industry is an abysmal 2 per cent. The former ISRO scientist said that as India is now invit-

ing private participation in technology development, it would also increase the scope for more startups to enter the area. "It means a lot for many players to start their work. For example, I would imagine that many startups will come, and even the startups that we have will have better funding. Many foreign countries may also land here with their startups or add to an existing startup," Narayanan said.

He said a successful Chandrayan-3 mission would be a big boost for space science and technology as well as the na-



tion's economy. Chandrayan-2 managed to land on the Moon but failed to do a soft landing due to some software and mechanical issues. Now they have worked on every aspect of it for four years and are hopeful to do a soft landing, the former scientist said.

Narayanan said that indigenously developed technology is essential for a country to survive, and added that ISRO

has been known to use minimum amounts for their ambitious space missions. "When compared to other nations, our

spending for such missions is a pittance," he said. Narayanan said we will have to wait till August 23 or 24 to know the success of the mission as the landing would take place on those dates. He also pressed on the need for establishing something like an Asian Space Agency (ASA) along the lines of the European Space Agency (ESA), with or without China, for taking up such bigger space missions. The whole of Asia would be happy to partner with India, which already has established a space science infrastructure, he said.

The 25.30 hour countdown for the launch of Chandrayaan-3 commenced on Thursday at Sriharikota, the Indian Space Research Organisation (ISRO) said. Friday's lunar expedition follows the 2019 Chandrayaan-2 mission where space scientists are aiming for a soft landing on the surface of the moon. A successful mission would see India enter an elite club of nations achieving such a feat, the others being the United States, China and the former Soviet Union.

G20 countries should join hands to meet challenges from 'dynamite to metaverse', 'hawala to crypto currency': Shah

GURUGRAM, July 13 (PTI): Warning the global community about security challenges which have evolved from "dynamite to metaverse" and "hawala to crypto currency", union home minister Amit Shah on Thursday asked G20 member countries to rise above conventional boundaries and share information on real time to check

Speaking at the 'G20 Conference on Crime and Security in the Age of NFTs, AI & Metaverse', he underlined the threats emanating from cyber criminals using darknet, metaverse, deepfakes, ransomware and toolkit-based misinformation campaigns and strategic targeting of critical information and financial systems.

Without taking names, Shah said some anti-social elements and global forces are using technology to cause economic and social harm to citizens and governments. "The G20 has so far focused on digital transformation and data flow from an economic perspective, but now it is important to understand the aspects of crime and security, and find a solution," he said.

Shah said such activities are a national concern as they directly impact national security, law and order, and the economy. If such crimes and criminals have to be stopped, we have to think and act by rising above the conventional geographic boundaries, he noted.

"Although technology is a positive development in bringing human beings, communities, and countries closer, there are also some anti-social elements and global forces that are using tech-



nology to cause economic and social harm to citizens and governments," he added.

The home minister suggested a laws of all countries, developing a

slew of measures to act against cyber criminals operating across borders like bringing uniformity in

response mechanism under different laws of the countries, harmonising bench marks, best practices and regulations, and greater coordination among cyber agencies of all countries.

"An integrated and stable approach to cyber security policies will facilitate interoperability, increase trust in information sharing, and reduce the agency protocol and resources gaps. The need of the hour is to share 'real-time cyber threat intelligence' among member countries with active support from industry and academia to secure the nation's critical infrastructure," he said.

Cooperation in the investigation of cross-border cyber crimes through joint efforts to build a 'peaceful, secure, deterrent and open' information and communiextremely necessary today, the Home Minister said.

Shah said our internet vision should neither be one of excessive freedom threatening the very existence of our nations nor one of the isolationist structures such as digital firewalls. "Many countries have become victims of cyber attacks and this threat is hovering over all the major economies of the world. According to World Bank estimates, cyber attacks could have caused losses of around USD 5.2 trillion to the world during 2019-2023. The use of crypto currency by malicious threat actors further complicates its detection and prevention," he said.

The home minster also suggested that in line with the United Nations Convention on the Crimi-

cation technology environment is nal Use of Information and Communication Technology, speedy preservation, investigation and coordination of evidences is essential. He said Computer Emergency Response Teams (CERTs) must be strengthened to deal with emerging technologies. "There should be a 24X7 cyber securty mechanism in place for an effective 'predictive preventive - protective and recovery' action. Time has come to build 'Transparent and Accountable Al (Artificial Intelliegence) and Emerging Technologies Governance Framework' to ensure responsible use," he said.

Shah said given the rise in cyber crime involving digital currency, there is a need for a "dedicated common channel" among the nations to prevent such financial irregularities.

TMC sweeps Bengal rural polls, consolidates rural hinterland ahead of 2024

Saddened at the loss of lives in sporadic incidents of violence during panchayat elections: Mamata

KOLKATA, July 13 (PTI): The ruling Trinamool Congress on Wednesday steamrolled to a massive victory in West Bengal's violence-scarred rural polls, bagging all zila parishads and leaving its rivals trailing way behind in results declared by the State Election Commission. The TMC won all 20 Zila Parishads in the three-tier panchayat system, winning a straight 880 seats, while its nearest rival BJP won 31 seats out of 928 seats. The Congress-Left front alliance won 15 seats while others won 2 remining seats.

The TMC has won over 35,000 gram panchayat seats, out of the 63,219 gram panchayat seats.

However though the counting was over exact figures were not known as compilation and dissemination process was not complete said officials.

The ruling party's nearest rival BJP has won nearly 10,000 seats. While the Left-Congress alliance won over approximately 6,000 seats. It was TMC's aim discussed in party inner circles that the party win bigtime in the rural polls but without resorting to violence, in a manner which would help it consolidate its rural base ahead of the 2024 parliamentary elections, while assuring its urban voters alarmed by tales of corruption that it remained a strong yet

'bhadralok' (well behaved) party. In the 2019 general elections, the TMC had suddenly seen its Lok Sabha seats come down by 12 to just 22, while BJP gained hugely and managed to win 18 LS seats, the equivalent of 164 assembly segments. This was worrying for the regional party with national



ambitions. The 2021 state assembly elections fought on the slogan of 'Bangaliana' against the "invading forces of the BJP" reversed the trend and TMC was able to restrict the saffron camp to just 77 assembly seats, winning a massive mandate of 215 seats in a house of 294.

TMC concentrated on the districts the BJP had done well in the past - North Bengal's Cooch Behar, Jalpaiguri and Alipurduar, western Bengal's Jhargram, Purulia, East and West Medinipur where BJP leader Suvendu Adhikary calls the shots as well as pockets in southern Bengal.

The result was TMC now con trols most gram panchayats in these districts as well as 20 zila parishads. Two districts - Darjeeling and Kalimpong – do not have zila parishads, but their two tier panchayat system is now controlled by a new Gorkha party-Bharatiya Gorkha Prajatantrik Morcha- which is not at odds with the TMC. This happened despite the BJP increasing its gram pan-

chayat tally from 20 per cent of

contested seats in 2018 to 27-28

per cent this time round.

However, in strategically taking on the BJP, the TMC's battle against the Left-Congress combine though fierce in districts like Murshidabad and Malda, has been muted elsewhere, allowing the duo especially the Left to consolidate and clawback from its 2021 position where it won less than 5 per cent of the popular vote and no assembly seats. In all the UPA allies managed to double their gram pan-

chayat seats compared to 2018. The districts where the BJP thought it was entrenched, that is it was the dominant political party -Cooch Behar, Jalpaiguri, Alipurduar, Jhargram, Bankura, Purulia, much of East and West Midnapore, pockets in Nadia, Hooghly, North and South 24 Parganas – it failed to win the majority of the gram panchayats and consequently it did not win the top tier zilla parishads.

Counting of votes for the threetier panchayat polls which began at 8 am on Tuesday at 339 venues spread across 22 districts is over "though it will take some more time to upload the results on the SEC website," an official said.

However, in this high stakes battle all parties indulged in and were victims of violence unleashed by their supporters for the most part without the sanction of their respective party high command, mainly out of local power play compulsions. Violence which began with announcement of elections resurfaced om counting day. In Bhangore in South 24 Parganas, three persons including two activists of the Indian Secular Front (ISF) were killed and several others injured in a clash which took place outside a counting booth late Tuesday night, police said on Wednesday. A 24-year-old Congress worker died on Wednesday while several others were injured after a clash between TMC and Congress supporters in Rampur village in Malda district, police said.

Similarly, a TMC worker from South 24 Parganas district's Chandpasha village was hacked to death by rivals. West Bengal chief minister Mamata Banerjee on Wednesday came out after several days of recuperation after an injury sustained while campaigning and said she is saddened by the loss of lives during the rural polls.

"I am saddened at the loss of lives in sporadic incidents of violence during panchayat elections.. The polls were held in 71,000 booths, but incidents of violence took place in not more than 60 booths," she said.

The Mudalvarin Mugavari Department (IIPGCMS CM Helpline) is an inclusive, integrated and convenient public grievance redressal platform to file and track one's grievances related to government services, schemes and civil issues. Shilpa Prabhakar Satheesh is the Special Officer of the department.

"As a result, the affected people are not reaping the full benefits of the grievance redressal mechanism. Hence, as far as possible, flex the technology to reply to the petitioners and reach out to them," the chief minister said.

The officials should provide an appropriate facility in the e-service for further appeal and take prompt action to provide a proper solution. "Only when the petitions are respected and resolved, our duties shall be deemed to have been duly performed. The hill state has been battered by recent heavy rains that triggered landslides and flash floods All 256 tourists stranded at Himachal's Chandertal evacuated

SHIMLA, July 13 (PTI): Rescue workers on Thursday evacuated all 256 tourists stranded at Chandertal in Himachal Pradesh's Lahaul and Spiti for five days after snowfall blocked the road leading to the spot, officials said. Authorities claim to have shifted 60,000 tourists in the state to safer areas over the past four days. But 10.000 tourists stuck at different places in Kasol, Kheerganga and adjoining areas are refusing to trek to safety as they do not want to leave their cars behind, the officials said.

The hill state has been battered by recent heavy rains that triggered landslides and flash floods, block-

ing roads and damaging properties. Expert drivers were arranged to drive the tourist vehicles in the snowbound area. Food and medical supplies are provided to the tourists at Losar before taking them to Kaza and the superintendent of police is supervising the rescue operation, Lahaul and Spiti Deputy Commissioner Rahul Kumar told PTI.

The distance between Chnadertal and Losar is about 32 km. Chandertal Lake in Spiti valley is a much sought after tourist destination where visitors stay in camps. The site has been used for shooting of several movies. Terming the evacuation from Chandertal a "challenging task", chief minister Sukhvinder Singh Sukhu, who did an aerial sur-



vey of Losar, Chandertal, Sirru and Manali on Wednesday, had tasked revenue minister Jagat Singh Negi to assist the rescue efforts in Chandertal. Negi hails from the tribal Kinnaur district and is acquainted with the harsh topography.

The evacuation started after the revenue minister reached Chandertal early this morning. More than 250 people, mostly tourists, were stranded in Chandertal, while seven sick people, including two elderly and a girl, were airlifted to Bhunter on Tuesday. Due to a heavy landslide near Dunkhara on Kasol-Bhuntar road, the vehicles could not be moved and the tourists climbed the slide for evacuation, the officials said. Sukhu on Thursday said the police will provide the tourists with a slip (receipt) and they can take their vehicles when roads are clear. The CM visited the flood-hit Thunag sub-division in Mandi and announced to provide ₹ 1 lakh each to the affected families and to provide land for the construction of the house which was swept away. He also directed to channelise the Thunag rivulet so as to avoid flooding.

Some videos of tourists, including foreigners, have gone viral, thanking locals and the state government for their evacuation.

With recovery of three more bodies, the death toll following recent heavy rains in the state has reached 42. The total death toll due to rain-related incidents and road accidents has risen to 91 so far

Meanwhile, 113 persons stranded ahead of Karcham near Sangla and other areas have been evacuated through six sorties, CM Sukhu said in a tweet. "Ninety-five people, including foreigners, were brought to safe places at Sangla, Chitkul and Raksham in Kinnaur district, and those affected by floods in Sangla have been temporarily sheltered in

NEW DELHI, July 13 (PTI): Bollywood star Varun Dhawan says collaborating with filmmaker Nitesh Tiwari on their upcoming project "Bawaal" helped him get back to the basics of his craft that led him to acting in the first place. Dhawan said while trying to "come across a certain way" on screen, actors often forget simple things and "Bawaal" helped him refocus on them. "When you're in a field for a very long time, you often overlook the simple things... Things that got you to the party in the first place. It's just about getting these simple things correct," the actor told PTI in a group interview at an event in Dubai where the team launched the film's trailer.

The filming on "Bawaal" started last year in April and during the course of the shooting, Dhawan said Tiwari made him realise his habit of tilting his head like Amitabh Bachchan. "I remember very well, something would happen to me. I don't know why but subconsciously, when shooting a scene, I would become like this (tilts his head). So Nitesh sir would keep telling me 'Brother aapka gardan jhuk raha hai... aap Bachchan ki tarah kyun...?' I also don't know why and what habit that I've formed, that I'm angling myself while talking or wanting to come across a certain way. That was something I had to work on," he said.

Cinema is a visual medium, and it is important for an actor to connect with the audience. said Dhawan, 36. "So these are things which I

had to work on in terms of my craft... It's like going back and standing in front of a mirror and then trying to say the line straight, again and again." "Bawaal" follows an ordinary but popular high school history teacher Ajay Dixit (Dhawan), fondly called Ajju bhaiya, who enjoys a mini celebrityhood in his hometown. 

"In the team rankings, right now we are closing in on the top 10, but the way we are playing as a unit, we can be a top five nation in table tennis," Sathiyan told PTI in an exclusive in-

"I see a lot of players who can break into the top 50, we have to have more Indians coming into the top 50 and going closer to that Olympic medal. This Paris Olympics will be a great chance to qualify as a team and get closer to that podium," said the world number 85.

Sathiyan, who was a member of the Indian team which won the gold medal in the 2018 and 2022 Commonwealth Games, said mixed doubles will be India's best chance to win a medal next year in the Paris

HI has requested the International Hockey Federation (FIH) for a window to conduct the HIL next year and is awaiting a response from the world body.

Asked, when a fresh beginning was being made, shouldn't Pakistan players be allowed in HIL, Zafar said, "Yes. I think, in sports, there should not be any politics."

Nine Pakistani players were part of the first edition of HIL in 2013 but had to leave the country before the start of the tournament following protests from a few political organisations. But after that, no Pakistan player was included till the tournament was discontin-

Asked if the traditional India-Pakistan hockey Tests should also be revived, he said, "I think so because there is hardly anything (differences among players). This is the political issue.

"How far I am true or not but the fact is that in sports we should not differentiate." said the 67year-old hockey great, who was also a member of the two silver medal-winning sides at the Asian Games in 1978 Bangkok and 1982 Delhi.

"There is no cricketer or human being in this world that has gone through the highs without the lows. When you have the lows, it gives you two choices, either you sulk or talk about it and then complain about it and go along with it and go down. Or you learn from it. So I'm someone who's con-

stantly learnt from my lows. "In fact the best thing that'll happen today after this good day that I've had is that I'll have a good meal, have a good conversation, talk to my family and go to

bed and then forget about it. "When you've had a good day, you know you've had a good day but there are areas you can work on and get better for tomorrow. This constant search for excellence has held me in good stead all the time, but it's also been in-

credibly draining. "It's not a journey that's been and mentally, planned for the

The new pair looked comfortable as there is not much help for the bowlers with Indian skipper hitting his customary 'Nataraja' pull-shot and soothing straight drive. Jaiswal

Shubham Todkar wins 67kg Gold at Commonwealth Championships

GREATER NOIDA, July 13 (PTI): India's Shubham Todkar clinched the 61kg gold but he wasn't the best lifter in the category as compatriot Sidhanta Gogoi, competing in the junior competition, out-performed him on day two of the Commonwealth Championships here on Thursday.

Shubham, who is in the Indian squad for the upcoming World Championships, heaved a total of 259kg (115kg+144kg), while Sidhanta had a best effort of 260kg (112kg+148kg) to be crowned the junior champion.

The senior, junior and youth events are being held simultaneously at the Gautam Buddha University here.

Shubham's tournament started on a bad note as he fluffed his first snatch attempt of 113kg. The lifter from Maharashtra looked a little off colour but successfully heaved the

weight in his second attempt before lifting 115kg. In the clean and jerk section, he succeeded in lifting 139kg and 144kg before faltering his 147kg attempt.

"I am very happy because it is my first international medal. This is my third international event. But I am not satisfied with my performance, it was not what expected it to be," Shubham told PTI after the win.

"My hand slipped during that first snatch attempt and I was not able to clean my third clean and jerk attempt, maybe cutting the weight took away some strength from my thighs," he added.

Sidhanta, on the other hand, was on a roll. The 19-year-old executed five of his six lifts perfectly. The only blip in his impressive performance being the final 152kg clean and jerk lift which he couldn't complete.

He beat compatriot Shankar Lalifted 249kg who

The loudest cheer of the day, however, came from the Samoan camp as 35-year-old Commonwealth Games silver medallist Vaipava Nevo Ioane was crowned

the 67kg champion. Samoan champion weightlifter, with a best effort of 280kg (120kg+160kg), was far ahead of silver medallist Madhavan T of India, who lifted 268kg (125kg+143kg).

Ioane had finished second to Jeremy Lalrinnunga at the Birmingham Commonwealth Games last year. The Youth Olympic champion is currently nursing a back injury and has thus skipped this tourna-

In the women's 59kg event, India's Popy Hazarika changed the shade of her silver from last edition to gold.
