Assam to table Bill to end polygamy: CM

GUWAHATI, Aug 6 (PTI): Hours after an expert committee submitted its report on the state's competence to frame laws to end polygamy, Assam chief minister Himanta Biswa Sarma on Sunday said a legislation on the subject will be introduced within this financial year.

Addressing a press conference here, he said the expert committee, which submitted its report earlier during the day, has unanimously agreed that the state can frame its own laws to end

"The report unanimously said the state government can frame laws on polygamy. The only point they said is that the final assent on the Bill has to be done by the President instead of the Governor, who does the final signature on other state laws," he added.

Asked if Assam will bring in a law to end polygamy, the chief minister replied in the affir-

"The law will definitely come within this financial year," he added.

Earlier in the day, the expert committee formed by the Assam government to examine legislative competence of the state legislature to enact a law to end polygamy submitted its report to the chief minister.

Sarma shared pictures of the committee handing over the report to him and the cover of the document on Twitter.

"Today, the expert committee submitted its report. Assam is now closer to creating a positive ecosystem for women's empowerment irrespective of caste, creed or religion," the chief minis-

Students drown in Dhansiri River

DIPHU, Aug 6: A heart-wrenching incident occurred in Khatkhati, where two college students lost their lives after drowning in the Dhansiri River. The victims were identified as Sumit Kuri (22) and Abranil Basak (19).

According to reports, the tragic incident took place when a group of six youths, including Sumit and Abranil, came to Khatkhati from Balijan to celebrate the birthday of one of their friends. While at the Janak Pukhuri area, they decided to take a swim in the Dhansiri River. However, during the swimming session. Sumit and Abranil faced difficulty and eventually drowned.

30 killed, nearly 100 injured in train accident in Pakistan

KARACHI, Aug 6 (PTI): At least 30 people were killed and nearly 100 others injured on Sunday when several compartments of an express train derailed in Pakistan's southern Sindh province, in the latest rail disaster to hit the country. The Hazara Express train travel-

ling from Karachi to Rawalpindi the Sarhari Railway Station, 275 kilometers from the provincial capital Karachi.

Commissioner Benazirabad division Abbas Baloch said in a statement that at least 30 people died in the accident while passengers are still stranded in a bogie.

Sindh chief minister Sved Murad Ali Shah, who spoke to the media at People's Medical College Hospital in Benazirabad — the district home to Nawabshah, confirmed the death toll, the Dawn newspaper reported.

He added that the injured could be shifted to Karachi if needed and directed the local administration and health officials to expedite relief and rescue efforts. Federal railways minister Saad

Rafiq earlier told the media that the number of casualties could rise as some of the injured were in critical after being hospitalised. He said around 10 bogies had de-

railed and the cause of the accident is being investigated.

Pakistan Railways Sukkur Divisional Commercial Officer (DCO) Mohsin Siyal said 15 bodies were retrieved from the wreckage and the rescue work aided by the Pakistan Army was continuing.

liance Industries Ltd, India's most valuable company, has sought shareholder's approval to give Mukesh Ambani another five-year term as chairman and managing director of the company till 2029 -- a period during which he has opted to draw nil salary.

Ambani, 66, will cross the company law-mandated 70 years age for the chief executive of the company and requires a special resolution by the shareholders for him to be appointed beyond that age bar.

In a special resolution, Reliance sought the nod of shareholders to appoint Ambani as the head of the company till April 2029.

Ambani has been on the board of Reliance since 1977 and was elevated as chairman of the company after the death of his father and group patriarch Dhiburhai Ambani in July 2002.

In the special resolution posted to shareholders, Reliance said its Board of Directors on July 21, 2023 approved "re-appointed Mukesh D. Ambani as Managing Director, for a period of 5 years from the expiry of his present term, i.e. with effect from April 19, 2024." Ambani, it said, had capped his annual remuneration at ₹15 crore from financial year 2008-09 (April 2008 to March 2009) to FY20; and since FY21, he opted to forego his salary, due to COVID-19 pandemic, until the company and all its businesses were fully back to their earnings poten-

Accordingly, he has not been paid any salary and profit-based commission for three years in a row beginning FY21.

At the request of Ambani, "the Board has recommended that no



salary or profit-based commission be paid to him for the proposed term from April 19, 2024 till April 18, 2029," the resolution said.

"He shall, however, be entitled to reimbursement of expenses incurred for travelling, boarding and lodging including for spouse and attendant(s) during business trips and provision of car(s) for use on company's business and communication expenses at residence shall be reimbursed at actuals and not considered as perquisites," the special resolution said. "The company shall arrange to provide security to Ambani and his family members and the expenses borne by the company for the same shall not be considered as perquisites." Reliance said Ambani will attain the age of 70 years on April 19, 2027. "The company has grown multifold under his leadership and it would be in the interest of the company that he continues to lead the company even after he attains the age of 70 years. Accordingly, approval of the members (shareholders) is sought for passing the resolution proposed (to give him another 5-year term) as a Special Resolution." Ambani, it said, satisfies all the conditions set out in company law and has not disqualified from being appointed as director.

"In terms of Article 86(1) of the Articles of Association of the company, Shri Mukesh D. Ambani is not liable to retire by rotation. Regulation 17(1D) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 provides that in such cases, the continuation of the director shall be subject to the approval by the shareholders in a general meeting once in every five years," it said, adding he is being sought to be reappointed till April 18, 2029.

Ambani has for a third year in a row drawn no salary from his flagship firm in the last fiscal as he voluntarily gave up remuneration in light of the pandemic hitting the business and economy.

In its latest annual report, Reliance said Ambani's remuneration for the financial year 2022-23

In June 2020, he voluntarily decided to forego his salary for the year 2020-21, in light of the COVID-19 outbreak in India, which exacted a huge toll on the so-

health of the nation. He continued to forgo his salary in 2021-22 as well and now in 2022-23.

In these three years, Ambani did not avail of any allowances, perquisites, retiral benefits, commission or stock options from Reliance for his role as the Chairman and Managing Director.

Prior to that, the Chairman and Managing Director had his salary capped at ₹ 15 crore since 2008-09 in order to set a personal example of moderation in managerial compensation levels. The ₹ 15-crore salary in 2019-20 was the same as in the previous 11 years.

Ambani has kept salary, perquisites, allowances and commission together at ₹ 15 crore since 2008-09, forgoing over ₹ 24 crore per annum.

Nikhil and Hital Meswani rose to ₹ 25 crore each, including ₹ 17.28 crore commission (unchanged from previous fiscal year).

The remuneration of his cousins

Executive Directors P M S Prasad and Pawan Kumar Kapil saw their remuneration rise.

While Prasad drew ₹ 13.50 crore in 2022-23 including performance linked incentives for 2021-22 which was paid in 2022-23. In 2021-22, he drew ₹ 11.89 crore.

Kapil got ₹ 4.40 crore, up from ₹ 4.22 crore in 2021-22. He completed his 5-year term on May 15, 2023 and has since ceased to be a

Dhoot told Chanda Kochhar's husband she would 'land up sharing room with Indrani': Chargesheet in ICICI Bank loan fraud case

MUMBAI, Aug 6 (PTI): Videocon Group founder Venugopal Dhoot had during an argument over a flat told Deepak Kochhar, the husband of ICICI bank's former CEO and MD Chanda Kochhar, that she would "land up sharing room with Indrani Mukeriea." as per the chargesheet filed by the CBI in an alleged loan irregularities case.

Deepak Kochhar became very angry and asked Dhoot to listen to his advice, otherwise he would "ruin him", according to the chargesheet.

The claim, citing the statement of a witness, is part of the Central Bureau of Investigation's (CBI) chargesheet filed in the case against Chanda Kochhar, Deepak Kochhar and Dhoot. The Kochhars and Dhoot, arrested in December last year, are currently out on bail. Indrani Mukerjea, the prime accused in the case of murder of her daughter Sheena Bora, was lodged in the Byculla jail here for more than six years following arrest in August 2015. She was granted bail by the Supreme Court in May 2022.

The chargesheet in the Kochhar case, running into more than 10,000 pages was filed recently before a special CBI court here.

As per a witness's statement, there was an altercation between Dhoot and Deepak Kochhar about a flat at the CCI Chambers in Churchgate area here.

Dhoot told Deepak Kochhar that he had paid ₹ 5.38 crore to the State Bank of India Home Finance Ltd and released the title of the flat from a dispute, and that it belonged to him, the witness said in the state-

"Shri Deepak Kochhar became infuriated and told V N Dhoot to sell all the shares of Quality Appliance Pvt Ltd at face value of ₹ 11 lakh; this way the flat would be transferred to his (Deepak's) family trust Quality Advisor, otherwise Chanda would declare his loan accounts with ICICI Bank NPA (Non-Performing



Assets)," the statement said.

"Shri V N Dhoot told him (Deepak) that don't transfer the flat in such a way (that) Chanda would be in trouble one day and would land up sharing room with Indrani Mukerjea. Shri Deepak Kochhar became very angry and told Shri V N Dhoot (to) listen to his advice, otherwise he would ruin him," it added.

The probe agency said Chanda Kochhar resided in a flat owned by the Videocon Group in Mumbai.

The flat was subsequently transferred to her family trust (Deepak Kochhar being its managing trustee) at a meagre amount of ₹ 11 lakh in October 2016, while its actual value was ₹ 5.25 crore in 1996. She knew it to be inadequate consideration, as per the chargesheet.

The Kochhars were arrested by the central probe agency in December last year in connection with the case. Later, the Bombay High Court granted interim bail to the couple and came down heavily on the CBI for making the arrest in a "casual and mechanical" manner and without application of mind.

The official said the affected bogies would be lifted off the track in a few hours using heavy machines and added that trains departing from Karachi might face delays. Federal minister for railways and aviation Rafiq said the train, carrying over 1,000 passengers, was travelling at a reasonable speed, which initial investigations showed,

He said an emergency has been imposed in hospitals in Sukkur and Nawabshah. "It was either a mechanical fault or it was developed," he was quoted as saying by the Dawn newspaper. Shaheed Benzirabad Deputy Inspector General of Police (DIG) Muhammad Younis Chandio termed the incident "big accident". However, the official refrained from confirming the number of casualties, the report said.

Foreign minister Bilawal Bhutto Zardari, whose Pakistan Peoples' Party is in power in the province, directed the Sindh government to provide immediate treatment to the passengers injured in the train accident and also called on PPP workers to participate in relief and rescue activities.

Railways accidents occur frequently in Pakistan due to outdated track maintenance systems, signal issues, technical equipment and old engines. Sindh has seen the worst railway accidents with the worst train disaster taking place in 1990 near Sukkur when 307 people were killed. Sunday's accident came just a day after three coaches of Allama Iqbal Express — travelling from Karachi to Sialkot — derailed, but no one suffered injuries. In April this year, seven people were killed when a fire broke out in a bogie of the Karachi Express travelling

from Karachi to Lahore near Tando Masti Khan in the Khairpur district of the southern Sindh province. On June 7, 2021, 32 people were killed and 64 injured after two express trains collided in Sindh's Ghotki.

In February 2020, 19 people were killed when a train collided with a passenger bus near Sindh's Rohri station.

PAY WHAT YOU WANT IIM-Kashipur study finds participative pricing model can make consumers shell out more


NEW DELHI, Aug 6 (PTI): Imagine a scenario where one is asked to set a product's price, paying any amount they wished. This pay-what-you-want pricing model can be a wonderful strategy to make consumers shell out more by offering them control over the pricing, researchers at IIM-Kashipur

have found. The team, led by Indian Institute of Management (IIM), Kashipur, Assistant Professor Preeti Narwal, conducted a study to examine how customers lower their motivation to pay more for products offered under the pay-what-you-want model by morally disengaging from reciprocity concerns.

In the pay-what-you-want "participative" pricing model, sellers provide individuals with the opportunity to be actively involved in the price determination process beyond accepting or rejecting the offer. In return, it is expected that the customers would reciprocate the appropriate behaviour by rewarding the seller with higher prices or at

least regular market rates. The IIM-Kashipur team found that the increasing need for creativity in business processes and proliferation of the Internet has led to the extension of participative pricing to a wide range of products and services across industries such as digital products, hospitality, consulting and entertainment, among

According to Narwal, the findings indicate that customers' moral disengagement via displacement of responsibility towards reciprocity concerns is negatively associated with the willingness to pay more.



However, the model is likelier to be embraced more by customers who seek great, awe-inspiring happiness and a distinctly perceivable

Hence, the offerings should be positioned as superior products that satisfy the ego and the status needs of individuals

"Participative pricing like the pay-what-you-want model has several advantages over regular pricing. Participative pricing leads to higher purchase intentions due to increased perceived control and greater customer engagement. It provides opportunities for price customisation like travel-related booking sites such as Orbitz, priceline.com that target each website visitor with a customised price to match their threshold price," Narwal told PTI.

"Even in the financial services industry, BBVA (Banco Bilbao Vizcaya Argentaria) seeks customer participation in pricing to tailor-made interest rates. The other advantage of participative pricing lies in its low implementation cost due to the Internet. The pricing model also helps in differentiating the product or service, thus increasing the offering's overall attractiveness to the customer," she added.

Narwal said the pay-what-youwant model is one such type of participative pricing that empowers the customers to choose the prices, ranging from zero to any infinite higher amount.

The fundamental essence of the pay-what-you-want model is the complete delegation of price-setting control to buyers, without allowing sellers to withdraw their offer even when they freeride, she pay-what-you-want

(model) allows the highest degree of control over price setting to the customers by enabling them to estimate their prices themselves. In the case of participative pricing models such as auctions, customers feel restricted and have a lower sense of perceived control with declining purchase and payment in-

tentions," she said. "Managers should try to increase an individual's sense of control directly through active engagement in setting the minimum and the maximum threshold prices and new product prices," Narwal added.

1,195 looted arms recovered

"Security forces have been continuously raiding the hill and valley areas to recover the looted arms and ammunition," it said in a statement on Saturday evening. Director-general of police Rajiv Singh said strict action will be taken against the people indulging in looting of arms from security forces.

Five policemen suspended over May 4 Manipur incident; IG rank officer to probe armoury looting

IMPHAL, Aug 6 (PTI): Manipur that the breakdown in law and order police has suspended five police personnel including the station incharge of the area where the incident of two women being stripped and paraded by a mob had taken place on May 4, officials said on

The officials said immediately after the video of the incident surfaced on July 19, Manipur police decided to suspend the station incharge of Nongpok Sekmai police station in Thoubal district and four other police personnel. The action was taken promptly and has not been reversed despite daily protests by some sections of people from the majority community for their reinstatement, they said.

The state police has also ordered a time-bound inquiry under an inspector general of police to probe events leading to the looting of an armoury on August 3 in Bishnupur, they said.

Talking to PTI, the officials in the know of developments said that every effort was being made by the Manipur Police to end the cycle of violence in the state which began on May 3 between the majority Meitei and tribal Kuki community.

They said that the police had

was addressed on an urgent basis.

"Now for example, with the help of other agencies including the Army and Assam Rifles, we have managed to keep the essential supplies in surplus quantity."

'This is the season of farming and we can't wait for complete peace to return. So we have to manage it and that means an additional diversion of police force to the foothills where farming is done for the famous black rice," said one of the officials. Around 300 people have been arrested so far in various cases. There have been many zero FIRs registered during the ethnic clashes and every claim has to be cross-checked, they said.

The officials said that a timebound inquiry has been instituted in connection with the recent looting of arms and around 19,000 bullets from the headquarters of the 2nd India Reserve Battalion (IRB) located at Naranseina in Bishnupur

An officer of the rank of inspector general is heading the inquiry which will be completed within six weeks, the officials said.

A crowd had gathered there on August 3 to march towards Chubeen working relentlessly to ensure rachandpur where the tribals were planning to carry out a mass burial of their people killed in ethnic clashes that broke out in the state on May 3, they said.

Highlighting the "proactive" approach of Manipur police, the officials said that as many as 30 people were arrested after an attack on an inspector general rank officer outside the airport last month.

Nine people including five Meira Paibis (Women torch bearers) were arrested in connection with the brutal killing of a Naga Maring lady on July 15.

"In Manipur, a day without an incident is called an 'absence of violence' and is not perceived as a thing that has become normal. It is a long way to go before things can be normal," an official said.

More than 160 people lost their lives and several hundred were injured since the ethnic clashes broke out in Manipur on May 3, after a 'Tribal Solidarity March' was organised in the hill districts to protest against the Meitei community's demand for Scheduled Tribe (ST) status. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley. Tribals -- Nagas and Kukis -constitute little over 40 per cent and reside in the hill districts.

Sarma said the order has a "clear reference to Rahul Gandhi's 2019 contempt case in the Hon'ble Supreme Court underlining his credibility as a repeat offender' He also pointed out that in Para 12, "the Hon'ble SC makes it clear

KOLKATA, Aug 6 (PTI): Most of the Kuki MLAs irrespective of their party affiliations are unlikely to attend the Manipur assembly session slated to be called from August 21 in view of the continued ethnic violence, according to leaders from the community.

An apex Meitei organisation CO-COMI, which has been spearheading demands for an early session of the assembly to "unanimously" reject demands for separate administrative units for Kukis, however, claimed that it would ensure safety of tribal MLAs if "they really want to come".

"In view of the prevailing law and order situation, it will not be possible on my part to attend the upcoming session," said LM Khaute, BJP MLA for Churachandpur, one of the worst-hit districts by the ongoing race riots, in a telephonic interview to PTI.

For good measure, Khaute added

that the violence and the lack of a resolution to demands made by the Kukis for a separate administration 'will not make it possible for all the Kuki-Zomi-Hmar MLAs to attend

the session. There are 10 Kuki-Zomi MLAs, including seven from the BJP, two from the Kuki People's Alliance and one independent, in the Manipur House which has a strength of 60 members

Tongmang Haokip, president of the Kuki People's Alliance (KPA), also told PTI, "The MLAs will not be safe travelling to Imphal ... one BJP MLA Vungzagin Valte who represents Thanlon was badly assaulted there, he is still under med-

He added that this apprehension could be addressed only "if there is a guarantee from the state government and the Centre and adequate steps are taken for the safety of

Gyanvapi-Vishwanath dispute

n the wake of recent developments surrounding the Gyanvapi mosque and Vishwanath temple in Varanasi, Uttar Pradesh chief minister Yogi Adityanath's statements have added fuel to the already contentious temple-mosque issue. The situation has escalated to a point where the matter is being dealt with through lawfare, involving legal proceedings and archaeological surveys, despite the Places of Worship (Special Provisions) Act of 1991. The recent Allahabad High Court verdict allowing the Archaeological Survey of India (ASI) to survey the Gyanvapi mosque complex further stirs the controversy. The court's decision comes after a series of lawsuits and appeals filed in local courts, aiming to establish the Hindu antecedents of the Gyanvapi complex. This ongoing legal battle has raised questions about the 1991 law, which prohibits the conversion of places of worship that existed on August 15, 1947, into places of worship of a different religion. The Supreme Court, in its landmark Ayodhya dispute judgment in 2019, upheld the 1991 law as a critical element of a secular State. It emphasised that the law prevents history from being used as a tool to oppress the present and future. However, despite this endorsement, the court's silence on intervening in the Gyanvapi mosque complex litigation has left many perplexed. The mosque committee's attempts to seek a stay on the survey through Supreme Court intervention were met with a transfer of their suit to the Varanasi district judge, delaying any definitive resolution. This perceived judicial pusillanimity at the highest level has emboldened Hindutya forces to pursue their interests through lawfare. The lower judiciary's involvement has raised concerns about its impartiality and its potential to facilitate ground-level changes through extra-judicial means.

In this context, it becomes imperative for the Supreme Court to take decisive action and apply the 1991 law, as it wholeheartedly endorsed in the Ayodhya judgment. By doing so, the court can curtail the misuse of lawfare and safeguard the secular fabric of the country. Any attempts to alter the ground realities through extra-judicial means must be thwarted to preserve the nation's harmony and unity. The Gyanvapi mosque and Vishwanath temple dispute is more than a legal battle; it's a test of India's commitment to its secular ideals and pluralistic heritage. The judicial system must ensure that it does not succumb to pressures and maintain its integrity and fairness. At the same time, it is crucial for political leaders to exercise restraint and refrain from making statements that could further polarize communities and aggravate the situation. The need of the hour is for all stakeholders to engage in constructive dialogue and seek amicable solutions that respect the sentiments and beliefs of all parties involved. The Gyanvapi mosque and Vishwanath temple hold deep historical and religious significance for their respective communities. As a nation, it is our responsibility to handle this sensitive matter with utmost care, ensuring that justice is served while upholding the principles of secularism and harmony.

The Supreme Court must assert its commitment to the 1991 law and address the Gyanvapi mosque and Vishwanath temple issue decisively. This would set a precedent for handling similar disputes and demonstrate the court's dedication to maintaining India's pluralistic ethos. We must tread cautiously and ensure that the templemosque issue does not become a tool for further discord but rather a stepping stone towards fostering unity and understanding.

NEP challenges and major action points

n course of the implementation of the National Education Policy (NEP) 2020, major challenges have been categorized under three broad themes - School, Teacher and Child. Subsequently, during the Chief Secretary conference, 35 priority areas have been identified for major actions to be taken care of by the states.

Parent awareness drives will be conducted so that they can contribute to the quality of their child's education. Twining of private and government schools should be done and private schools should adopt a remote school as part of their social obligation. Activities such as teacher exposure visits between private and government schools, hosting of government school students by private school students and joint sports competitions between private & government schools should be explored to increase exposure for both sets of students.

Optimal utilization of resources should be systematically planned by the States/UTs on the concept of "Providing Urban Amenities to Rural Areas" (PURA). There should be greater integration between Schools and Anganwadi centres and students from Anganwadis should be taken to nearby primary schools, where they should be given a platform to perform a song and creating confidence to prepare them for school. Also the school teachers should orient the Anganwadi workers on teaching and

learning for pre-school children. Adoption of Anganwadis by nearby schools should be properly planned. Hackathons should be organized, where students should provide innovative solutions to a variety of real-life problem statements created by different departments. Many of these solutions could be adopted to solve long-standing problems. Micro-improvements should be continuously undertaken. Also activation of Tithi Bhojan concept must be activated as "Sabka Prayaas" to ensure supplementary nutrition for the schoolgoing children.

Parents should confirm the teacher's performance on the large photograph of the concerned teachers displayed in the

recruitment drive, as done in technical colleges, for Teacher Education Institutions should be explored. Regular e-training should be promoted for capacity building of teachers to excel. Retired outstanding teachers should be invited for mentoring a cluster of schools and motivating its teachers. Efforts will be made to do away with single-teacher schools and adequate amenities should also be provided in the school. To make teaching and learning more engaging for TVdriven education, teachers should be encouraged to provide high quality content in various forms like animation, mono-acting, drama, dialogues etc.

To give a boost to access to high-quality content for each grade in the country, setting up of 200 TV channels has been planned. The content of these channels will be sourced by the teachers of the States/UTs. There should be peer-to-peer learning in the classrooms. To improve the learning trajectory of the students, classroom interactions through academic quiz is neces-

SCERTs have a pivotal role to play in the implementation of NEP 2020 and hence all SCERTs in the country would need to be strengthened. All Teacher Education Institutions across the country have to adhere to certain norms and standards of the NCTE and gradually move towards a multidisciplinary environment.

Under National Mentoring Mission (NMM), a unified learning interface in the form of a portal has been established where all the mentors will remain connected. National Professional Standards for Teachers (NPST) will focus on the preparation, practice and performance improvement of all teachers. Performance Grading Index (PGI) for the Districts, released by the Ministry of Education (MoE), assesses the performance of the school education system across 83 indicators and the report would be used by the States to accelerate the work in a particular district which is lagging behind. The introduction of 'universal basic income' in India has to face a lot of problems

been advocating a universal basic income for India, an idea that was mooted even in the official Economic Survey for 2016-17. Of course the practical proposals towards this end have varied, some suggesting a common universal transfer to all persons below a certain income, and others suggesting a graded transfer depending on how badly off an individual happens to be. But the vision is of a society where every citizen has a certain basic minimum level of money income through appropriate government transfers which would give the person command over a bundle of goods that assure a minimum living standard. There are conceptual objec-

tions to this idea, which the Economic Survey had enumerated and dealt with at length. These are objections mainly from the right. The primary objection states that such transfers disincentives effort: if one can get a minincome anyway irrespective of the effort one puts in, then why put in any effort at all to earn an income? This presumes however that we have a society where a person's income is reflective solely of his effort, so that any interference with it (in the form of a universal basic income) can upset the arrangement. But this is absurd because the rich get huge incomes without putting in any effort, while the poor work themselves to death for a mere

In fact it was John Stuart Mill who had observed that, contrary to Adam Smith's theory that workers in the most exhausting and hazardous occupations got better paid in order to compensate them for the arduousness of their jobs, they were actually among the worst paid. A universal basic income in this case amounts not

to providing an income for no work, but to increasing the wagerate per unit of work of the poorest workers (which is quite apart from the fact that if a person gets no work at all then his remaining unemployed is the fault not of him as an individual, but of the social arrangement under which

he lives). The claim that a universal basic income disincentivises effort is exactly analogous to the view that a rise in wages makes people lazy, a right- wing "supply side" proposition that the liberal American economist JK Galbraith had mocked as suggesting that the "rich work better if paid more while the poor work better if

paid less". It is both morally reprehensible and ana-

lytically utterly unfounded. Against this right-wing stance opposing a universal basic income, the mooting of this proposal represents a progressive liberal assertion. But the problem with what is mooted is exactly the problem with the liberal position in general, namely that it wants to make an omelette without breaking eggs. It wishes to operate within the capitalist system, making it more humane for the working people, without upsetting the capitalists too much. Not surprisingly the amount of UBI that is mooted is invariably paltry.

The Economic Survey 2016-17 for instance had calculated that an annual transfer of Rs 7620 per annum for every person at 2016-17 prices, excluding the top 25 per cent, would cost 4.9 per cent of the country's GDP. A sum equivalent of this at 2011-12 prices, if given to the bottom 75 per cent in 2011-12, would have reduced poverty in that year to a mere 0.5 per cent of the population, that is, virtually eliminated

it. The Economic Survey recommends obliquely that this amount can be financed by cutting down the various subsidies that the government gives at present.

There are two obvious problems with this calculation. First, the actual poverty-line for 2011-12, at which what the Planning Commission itself considered the minimum requisite calorie intake would be ingested, was almost 50 per cent higher. Assuming for simplicity that a proportionate increase in the transfer had to be made to achieve the same objective, of eliminating poverty, under the same assumptions, it would have cost not 4.9 but almost 7.5 per cent of the

quired an increase in the amount of transfer by making things more expensive. In short, the figure mentioned in the Economic Survev would have been grossly inadequate. Other suggestions for UBI are of course much less ambitious in their scope.

Even more decisive however is another consideration. Even if we assume that the UBI is introduced through a parliamentary resolution which makes it binding on the government to keep providing the stipulated price-indexed transfer every year and not renege on its commitment (as it is doing at present with regard to the MGNREGS), it would typically make this transfer by cutting down on its spending on education, health, and other such heads.

This would mean that while people would have money from the cash transfer made by the government, they would have no proper government schools to send their children to, and no proper government hospitals to

if they access private schools or private hospitals, then the transfer amounts, price- indexed on the assumption that people access the same bundle of goods and services as in the base year, will be much less in real terms. In other words, the basic objective of providing a UBI in real terms would

have got subverted in the very

process of financing it.

Hence, even if the UBI is taken as a universal right that everyone enjoys, with no scope for reneging on it by the government, the transfers made by the government to achieve the UBI in money terms, will in effect not achieve it in real terms. It follows that it is far better to have legislation ensuring a set of individual rights, such as right to free quality education, a right to free quality healthcare, a right to food, a right to employment, a right to an adequate non-contributory old-age pension and disability benefit, than to institute a portmanteau right to a UBI in money terms. Put differently, a right to UBI in real terms cannot possibly mean anything other than a set of specific constituent individual rights, such as a right to health, a right to

The idea of a universal basic income, though well-meaning and laudable, is thus quite meaningless as it stands. If it is interpreted merely as a set of cash transfers, whether uniform or graded across individuals, then it does not necessarily achieve a real UBI which is the objective behind instituting it. On the other hand, if the idea is to have a UBI in real terms, then the only possible meaning one can give to it is in terms of a set of specific rights, to health, education, and such like, which the government has to take on the responsibility for providing

education, and such other rights.

If India has to build a genuine (IPA Service)

antee these specific rights to every individual; but that entails much larger expenditure than the Economic Survey had suggested.

It has been estimated for instance that instituting the very five universal rights that we mentioned above, viz. the right to food (so that everybody gets what the BPL population has been entitled to get), the right to employment (or if employment cannot be provided then the payment nonetheless of a statutorily fixed wage), the right to free quality healthcare through a National Health Service, the right to free quality education (at least up to the school- leaving level), and the right to a universal, non-contributory old-age pension and disability benefits, would cost, in addition to what is already spent from the budget on these items, an additional 10 per cent of the Gross Domestic Product. To spend this additional amount, the government has to raise extra tax revenue, amounting to about 7 per cent of GDP (the other 3 per cent would come through the tax revenue that would automatically accrue from the increase in GDP caused by the spending of this 7 per cent).

To raise this 7 per cent is by no means difficult, provided the government is willing to tax the rich. In fact just two taxes levied on the top 1 per cent of the population, viz. a wealth tax of 2 per cent and an inheritance tax of 33 1/3 per cent, would be sufficient to garner the requisite resources to introduce a welfare state in the country by guaranteeing these five fundamental economic rights. This however makes the introduction of a welfare state in India a matter virtually beyond the capacity of the bourgeois system, and hence beyond the conception of liberal economists.

Recurring floods of Assam - from a political ecology perspective

The drama of floods unfolds when the river begins to rise in April; by July it is swollen to its full height and the whole country becomes an inland sea", narrated Scottish army surgeon John M'Cosh in 1837 in Topography of Assam. He also wrote how the sites of large villages are known only by their roofs above the stream. Rightly called the people of the floodplains, the riparian Assamese communities are traditionally adapted to the annual flood since time immemorial. This relationship between flood and the people of Assam can be best described with what Radhakamal Mukherjee in his book The Changing Face of Bengal has described about humans adapting to a flood landscape and that they 'live a more or less amphibious life'. Be it the writings of Sankardeva, the social-religious reformer of Assam or the British travellers to this region, all very well portrays how the flood is very natural to Assam

from yore. The numerous tributaries of the Brahmaputra continue to change its course over the centuries due to floods, tectonic factors, fluvial activity, river capture, or siltation and change in course of tributaries. This often makes flood a very natural phenomenon in Assam, but is it going to be a same story from the cradle to the grave? Or has it been in fact the same story in all these years?

There is a popular trivia which is often posed to students in Assam during quiz competitions - how many districts in Assam get flooded? Those who have faced this know that this is a tricky question. Because the number of districts keeps increasing almost every year in Assam, it is difficult to keep track of the exact boundaries or the total number. Therefore a very safe answer is 'all districts', which is also the correct answer and precise one too. And just like an annual festi-

val, like Christmas, Diwali or Bihu, floods occur in Assam, without fail. Affecting millions of people, damaging countless houses, destroying public and private property worth thousands of crore and claiming hundreds of lives annually, floods can be easily described as a bane of Assam. But it is these floods which have also shaped the geography of the long run and fails hugely as a

Assam, as we see it today. And therefore a good question to ask in 2023, the 76th year of Indian independence, is: what are the different flood control mechanisms that have been in use so far? How effective they have been? And how can we imagine Assam, not without floods, but without suffering, for floods might be inevitable in Assam, but suffering needn't be.

Hence, we can argue that the flood issue in Assam is not merely an environmental disaster but a hybrid of human-environment artefact if seen through the lens of a political ecology framework, as rightly proposed by Gilbert F. White in his paper Human Adjustment to Floods: a Geographical Approach to the Flood Problem in the United States in 1945

This article, therefore, aims to examine the recurring issue of flood and resultant damage in Assam through four main theses of political ecology.

1. Political objects and actors- This thesis attempts to exthe socio-political conditions of a system. It is contentious to call the floods of Assam a natural phenomenon any longer since there are several loopholes on the part of the government and its administration. The major gaps are the lack of coordination between the state and centre. Flood control is more of a reactionary response rather than a preparatory one and the timing of the reactionary response itself is delayed, which further worsens the situation. This feedback mostly comprises building an embankment with no steps taken to protect against erosion. Breaches have been reported from Brahmajan and Solengi river embankments in Gohpur in 2013 as per the Assam State Disaster Management Authority (ASDMA) flood report of 2013. This was due to the negligence in essential river protection post building an embankment for Rs 5 crores. More than half of the embankments stay in a dire strait almost the whole year because there is always a huge contractoradministration nexus that makes a seasonal benefit from a flood situation, and hence the 'recur-

ring floods.' 2. Conservation and control-The relevance of this thesis lies in the usually viewed cordial efforts at environmental conservation which has detrimental effects in



stances of mockery as to how control mechanisms and structures like embankments and dams end up causing more floods. The Ranganadi Hydroelectric Plant in the district of Yazali in Arunachal Pradesh by the North East Electrical Power Corporation (NEEPCO) since its functioning in 2001 has been creating big trouble to the districts of Lakhimpur and Dhemaji as the dam water released by NEEPCO just takes three hours to reach North Lakhimpur. This sudden torrential inflow of water swells the water level of the Ranganadi river submerging several villages in the river banks.

A similar situation is also faced by the people of Golaghat in Upper Assam since 2000 due to the functioning of another NEEPCO dam in the Doyang River that flows through Nagaland and Assam. We see how a certain class of environmental victims are created through the act of flood-control measure itself and this pushes a certain section of people to the margins. 3. Degradation and margin-

alisation- Flood spells disaster - but not equally for everyone. Often it is seen that the majority of the low-income individuals who rely chiefly on agriculture are highly very likely to dwell in the most vulnerable and remote locations that are surrounded by nature and hence are disproportionately affected by natural hazards and disasters. Thus, populations chiefly dependent on agriculture, livestock production and fishing, when affected by yearly floods, end up abandoning their lands and homes in search of work by migrating to many South Indian cities in the country. All these have been a cause of growing out-migration in the state leaving behind an older generation and thus limited availability of farmers to sustain good livelihood needs, are highly un-

outputs. Clearly, there is a complex web of the interaction of cultivation and production with links between degradation and marginalization in the flood-prone re-

gion of the Brahmaputra plains. While on the one hand – floods force people to flee from Assam to different cities in the country, fragmenting families, friends and identities, on the other side, there is another marginalised section of people, the char dwellers, coping with the annual floods of Assam. Locally known as Chars, the sandbars are the alluvial deposits resulting from the unique fluvialecological flow of Brahmaputra and high sedimentation rates, which however tend to disappear overnight due to rapid erosion. These chars facilitate the survival of distressed migrants from neighbouring states and the riparian country of Bangladesh.

The Chars, which is a part of the Ganges Brahmaputra delta, the largest delta of the world, covers 5% of the total area of Assam spreading across 14 districts, 55 blocks and around 2300 villages (Government of Assam. 2016) and accounts for almost 10% of the population in Assam which are mostly the migrant Muslims of East Bengal origin (Balram Kumar, Debarshi Das 2019).

4. Environmental Subjects and Identity- Paul Robbins in his book Political Ecology: A critical Introduction writes "People make an identity as they make a living". This is what we encounter among the tribal populations inhabiting the riverbanks in Assam who are inseparably linked to the sacred customs, traditions, homelands and a shared history with the mighty Brahmaputra River and its tributaries. Coping with the flood is natural to them for which these communities who are hugely dependent on the environment for their

likely to migrate long distances, so they always feel a threat within themselves. Social activist, Sanjoy Ghose writes how the people of Majuli, particularly the riverdwelling Mising tribe explains the insecurity of not knowing whether there will be any Majuli

Majuli district in Assam is the largest river island in the world. "Floods we've learned to live with, but the loss of the land which nurtured us has made survival difficult", recounts an inhabitant of Majuli in the book Sanjoy's Assam: Diaries and Writings of Sanjoy Ghose. These are the River People; the name "Mising" comes from mi (man) and asi(water), or "man of the water". They build Kare Okum, a traditional Mising chang ghar (sometimes spelt changkar) which is a wooden house built on bamboo stilts with mud foundations and a bamboo thatch roof.

However, several factors have threatened the identity of these people who have been resiliently living in harmony with the river for centuries. The traditional way of living in a chang ghar is not much welcomed by the younger generations. The people of these tribes who have a timeless bond with nature do not easily out-migrate but are also embracing newer technologies and ways of living, somehow giving up their traditional adaptive methods of living with the flood. This, in the long run, tends to threaten their communal customs and practices which otherwise hold these small societies together.

The recurring flood problem in Assam, when apolitically viewed, seems like a natural disaster that generates heterogeneity in the riverine ecosystem, influencing the distribution, composition and abundance of organisms. But when politically viewed, the flood problem is so much more than just a natural disaster which along with the heterogeneity in the riverine landscape also brings heterogeneity in the lives of people across populations. Floods in Assam are more of a socio-economic production of nature and their annual occurrence depends hugely on the way we administer the relationship between society and the environment. rontotemporal disorders involve damage to parts of the front and side, or temporal area, of the brain, resulting in dementia. Depending on the type, these can lead to changes in language use, behaviour, and other aspects of well-being.

Types of frontotemporal dementia (FTD) include Pick's disease, primary progressive aphasia, and semantic dementia. As well as affecting behaviour and language use, they can impact a person's posture and gait and increase the risk of falling.

FTD is the third most common cause of dementia among people aged 65 years and over, and it is the second most common in those aged under 65 years. It usually appears between the ages of 45 and 65 years. However, it is rare, accounting for fewer than 5% of all dementia

There are two main types of FTD: the behavioural variant and the language variant. However, a person may have symptoms of both.

FTD affects the frontal and temporal lobes of the brain. The frontal lobe is at the front of the brain, and the temporal lobe is at the side. These areas play a role in behaviour, language, and the ability to plan and organize.

Damage to neurons, or brain cells, in these parts of the brain can result in a range of symptoms.

Language variant

The language variant can be either progressive, nonfluent aphasia or semantic aphasia. In progressive, nonfluent aphasia, the person has difficulty producing speech. They may produce jumbled words, have difficulty understanding complex sentences, and be unable to name objects. In the early stages, the person may still be able to calculate, remember things, and think abstractly.

In semantic dementia, the person may have difficulty understanding single words and recognizing familiar faces and objects. Speech may sound fluent but make no sense to a listener. In time, this type can also affect

There are three general stages of FTD: early, middle, and late. The following sections will look at each of these in more detail.

Early stage In the early stage of FTD, a person may not experience any memory difficulties. For this reason, some doctors may overlook the condition or misdiagnose it as a psy-

chiatric one. Middle stage

In the middle stage of FTD, the condition starts to appear more similar to other types of dementia, such as Alzheimer's disease.

People in the middle stage of FTD may start to need more help with simple daily tasks, such as dressing and grooming. Family members and caregivers may also notice that behavioral disturbances happen more often and more consistently.

Late stage In late stage FTD, people often experience difficulties with both language and behaviour, and their memory usually starts to deteriorate. Some people with this stage of the condition need 24-

hour care.

FTD seems to result from degeneration in the brain cells in the frontal and temporal lobes due to damage from proteins collecting in those areas. In most cases, it is unclear why a person develops FTD. However, member with FTD. Head injuries and thyroid disease may also increase the risk.

Symptoms

FTD is a type of dementia that can affect speech, behaviour, and other aspects of a person's well-being. The symptoms are progressive and tend to worsen with time. Microplastics can alter gut microbiome, cause intestinal inflammation: FAO

icroplastics and nanoplastics considerably impact human and animal gut microbiomes as well as the V __environment, noted a report by the Food and Agriculture Organization (FAO).

Though the effects of its exposure to other plastic chemicals in the gut microbiome are still unexplored, instances of alteration in the intestinal structure and the functioning of the gastrointestinal tract have been observed, FAO noted in its report Impact of Microplastics and Nanoplastics on Human Health.

After examining various literature on the topic, researchers found that exposure to plastic has led to intestinal inflammation and gut dysbiosis - changes in the gut microbiome and microbiota. The findings stood true for aquatic species and rodents as well.

The findings of the study are crucial as microplastics and nano plastics are known to affect larger soil microorganisms and penetrate the entire food web.

Evidence suggests that microplastics found in water bottles and food items such as sugar, honey, sea salt, tea and others have eventually deposited in human lung tissue, placenta, stool, blood and meconium.

Microplastics (0.1 to 5 000 μm) and nanoplastics (0.001 to 0.1 μm) are ubiquitous contaminants of emerging interest due to their potential effects on the environment, animals and human health. Their capacity to release plastic additives or adsorb, transport and release environmental contaminants (e.g. heavy metals and organic pollutants) and modify the exposure and toxicity of these contaminants have not been well studied

Further research is required to understand how microplastic exposure or co-exposure with other chemicals affects the host and the gut microbiome.

When plastic spreads in the environment, they undergo ageing, weathering and deterioration. Such changes cause mechanical abrasion, breakage, fragmentation and photooxidation, which involves chemical release or adsorption, the report stated.

Plastics eventually break into different sizes and shapes and undergo changes during interactions with microorganisms and other substances in their surroundings.

Another point to note is how the plastic's surface properties interact with the environment, whether they release chemicals or bind to other particles.

Plastics of hydrophobic nature, for instance, can adsorb hydrophobic chemicals or persistent organic pollutants from the environment (for example, polychlorinated biphenyls, polycyclic aromatic hydrocarbons and dichloro diphenyl trichloroethane), the document noted.

'The interactions between environmental contaminants and microplastics and their transfer from the environment to living organisms are complex and challenging to understand, as many factors (microorganisms, sediments, pH, etc) will influence these processes," it added.

After examining 146 articles, the report's authors observed that most studies depicted limited evaluations of the effect of microplastics on the gastrointestinal tract and gut

The authors considered parameters such as accumulation

of microplastic in the gut, changes in the mucus layer and gut permeability, alterations of the mucosal structure, oxidative stress and immune response. Every study showed some level of alteration in the host to the microplastic exposure. In some instances, alterations of gene markings and biochemical markers were also observed. Physical abrasion of microplastic and its accumulation in

the gut can lead to satiety in the organism and even reduce food consumption. It may eventually lead to weight loss and metabolic changes. A few studies indicated the impact of microplastics on liver function and metabolism. The analysis highlighted that the severity of the impac

was proportional to the concentration and particle shape of microplastics. Microplastics act as stressors and cause inflammatory responses in the host, affecting certain microorganisms and resulting in microbial dysbiosis.

However, despite increasing interest in the topic, many knowledge gaps regarding micro and nano plastic consumption and its effects on gut microbiome and human health remain unfilled.

"There are questions concerning the gut microbiome's sensitivity to chronic exposure to microplastics and low concentrations of chemical residues, and whether microbial disturbances lead to short and long-term effects on human

iabetes, being a global epidemic, has a high prevalence of around 11 percent, affecting 250 million people globally. It is the leading cause of many diseases and metabolic syndromes.

Managing diabetes requires careful attention to various factors like lifestyle, medication, diet, etc. When addressing the diet, one must look for the correct type, time, and amount of foods to be included.

Maintaining regular meal timings plays a pivotal role in the management of type-2 diabetes. Adhering to consistent meal timings helps regulate the timely release of insulin, the main hormone responsible for managing blood glucose levels.

Meal timings & quality: how to keep your sugar levels controlled

Along with the timings, the quantity of the meal also matters. Having small, frequent meals can impact glucose levels positively. Smaller meals lead to a slower release of glucose into the bloodstream which further avoids insulin spikes and improves insulin sensitivity and overall glycemic control.

A 2019 Cell study proposed that insulin and IGF-1 (Insulin-like growth factor) are primary signals of feeding time to our cellular clocks throughout the body. There are many researches indicating a relationship between our circadian rhythm (body's clock) and insulin secretion.

cose across the cell membrane. A 2022 study published in the Nutrition, Metabolism & Cardiovascular Diseases Journal found an association between food portion sizes and insulin resistance and suggested that portion size is an important determinant of insulin resistance and metabolic syndrome.

• Nutritional balance: Eating smaller well rounded meals helps one include a variety of food groups.

This helps promote overall health and provide essential micronutrients as well as macronutrients which would be beneficial for managing diabetes effectively.

By the end of the study, the number of total daily calories the exercisers burned was not significantly different from what the nonexercisers burned. And this was in spite of the fact that trainers verified the exercisers burned an extra 400 to 600 calories per session at their nearly daily exercise sessions. Why didn't those extra exercise calories show up in the total daily

calories burned? The answer to that question may help explain why exercise doesn't always help you keep the weight off: Your metabolism responds to regular exercise by decreasing the number of calories you burn when you're not exercising. That's according to the constrained total energy expenditure hypothesis that spurred the current debate.

NIAMEY (NIGER), Aug 6 (AP): The deadline has arrived Sunday for Niger's military junta to reinstate the country's ousted president, but the West Africa regional bloc that has threatened a military intervention faces prominent appeals to pursue more peaceful means.

Neighbouring Nigeria's Senate on Saturday pushed back against the plan by the regional bloc known as ECOWAS, urging Nigeria's president, the bloc's current chair, to explore options other than the use of force.

ECOWAS can still move ahead, as final decisions are taken by consensus by member states, but the warning on the eve of Sunday's deadline raised questions about the intervention's fate.

Algeria and Chad, non-ECOWAS neighbours with strong militaries in the region, both have said they oppose the use of force or won't intervene militarily, and neighbouring Mali and Burkina Faso - both run by juntas - have said an intervention would be a "declaration of war" against them,

Niger's ousted President Mohamed Bazoum said he is held "hostage" by the mutinous sol-

An ECOWAS delegation was unable to meet with the junta's leader, Gen. Abdourahmane Tchiani, who analysts have asserted led the coup to avoid being fired.

Russia promises retaliation after Ukrainian drones hit Russian tanker

promised retaliation on Saturday after Ukrainian drones hit a Russian tanker in the Black Sea near Crimea late on Friday, the second sea attack involving drones in one

Ukraine struck a major Russian port earlier on Friday.

Moscow strongly condemned what it sees as a Ukrainian "terrorist attack" on a civilian vessel in the Kerch Strait, said Russian Foreign Ministry spokeswoman Maria Zakharova.

"There can be no justification for such barbaric actions, they will not go unanswered and their authors and perpetrators will inevitably be punished," she wrote on the Telegram messaging app.

As Kyiv's naval capabilities grow, the Black Sea is becoming an increasingly important battleground in the war.

Three weeks ago, Moscow withdrew from a key export agreement that allowed Ukraine to ship millions of tons of grain across the Black Sea for sale on world markets. In the wake of that withdrawal, Russia carried out repeated strikes on Ukrainian ports, including Odesa. An official with Ukraine's Security Service confirmed to The Associated Press that the service was behind the attack on the tanker, which was transporting fuel for Russian forces. A sea drone, filled with 450 kilograms (992 pounds) of TNT, was used for the attack, added the official, who spoke on condition of anonymity because he was not authorised to give official statements.

"The Sig tanker ... suffered a hole in the engine room near the waterline on the starboard side,

presumably as a result of a sea drone attack," Russia's Federal Agency for Marine and River Transport wrote on Telegram, adding that there were no casualties among the 11 crew members.

Vladimir Rogov, a Kremlin-installed official in Ukraine's partially-occupied southern Zaporizhzhia region, said several members of the ship's crew were

The attack briefly halted traffic on the Kerch Bridge, as well as ferry transport. Tugboats were deployed to assist the tanker, which is under United States sanctions for helping provide jet fuel to Russian forces fighting in Syria, according to Russia's Tass news agency.

Ukraine's earlier strike on Novorossiysk halted maritime traffic for a few hours and marked the first time a commercial Russian port has been targeted in the nearly

a naval base, shipbuilding yards and an oil terminal, and is key for exports. It lies about 110 kilometres (about 60 miles) east of Crimea.

Shipping expert Jayendu Krishna told The Associated Press that the attacks left Russian shipping activity "largely unaffected". He believes that they may increase the risk of Russian attacks on Ukrainian ports rather than serving as a tool to put pressure on Russia to halt attacks and reinstate the grain deal.

"Every time anything happens to Russia, you see Putin in retaliation mode ... therefore, you may see further attacks on other parts of Ukraine," Krishna said.

"I think it will probably compound the effect and compound the risk in the Black Sea, rather than reducing it," he added. "It is very difficult for me to imagine that Russia will give in, unless and until their banks have smooth operations, and they are able to export their own cargo uninterruptedly.'

A Telegram post on Saturday by Deputy Chair of Russia's Security Council Dmitry Medvedev implied that Russia would increase its attacks against Ukrainian ports in response to Kyiv's attacks on Russian ships in the Black Sea:

"Apparently, the strikes on Odesa, Izmail, and other places were not enough for them," he wrote. MANILA, Aug 6 (AP): The Philippine military on Sunday condemned a Chinese coast guard ship's "excessive and offensive" use of water cannon to block a Filipino supply boat from delivering new troops, food, water and fuel to a Philippine-occupied shoal in the disputed South

China Sea. The tense confrontation on Saturday at the Second Thomas Shoal was the latest flare-up in the long-seething territorial conflicts involving China, the Philippines, Vietnam, Malaysia, Taiwan and Brunei.

The disputes in the South China Sea, one of the world's busiest sea lanes, have long been regarded as an Asian flashpoint and a delicate fault line in the rivalry between the United States and China in the

Philippine navy personnel on board two chartered supply boats were cruising toward Second Thomas, escorted by Philippine coast guard ships, when a Chinese coast guard ship approached and used a powerful water cannon to block the Filipinos from the shoal that China also claims, according to Philippine military and coast guard officials.

The Chinese ship's action was "in wanton disregard of the safety of the people on board" the Philippine navy-chartered boat and violated international law, including the 1982 UN Convention on the such actions are the latest by the PRC in the South China Sea and are a direct threat to "regional peace and stability." Australia expressed its concern, de-

scribing the actions of the Chinese coast guard ship as "dangerous and destabiliz-Japan said it supported the Philippines,

adding that "the harassment and action, which infringe on lawful activities of the sea and endanger navigational safety,' were "totally unacceptable. The Department of Foreign Affairs in

Manila did not immediately issue any reaction but has filed a large number of diplomatic protests over increasingly hostile actions by China in recent years. Chinese government officials did not immediately comment on the incident.

China has long demanded that the Philippines withdraw its small contingent nament earlier this year. of naval forces and tow away the actively commissioned but crumbling BRP Sierra Madre. The navy ship was deliberately marooned on the shoal in 1999 and now serves as a fragile symbol of Manila's territorial claim to the atoll.

Chinese ships had blocked and shadowed navy vessels delivering food and other supplies to the Filipino sailors on the ship in the shoal, which Chinese coast guard ships and a swarm of Chinese fishing boats — suspected to be manned by militias — have surrounded for years.

While the US lays no claims to the South China Sea, it has often lashed out at China's aggressive actions and deployed its warships and fighter jets in patrols and military exercises with regional allies to uphold freedom of navigation and overflight, which it says is in America's national interest. China has warned the US to stop meddling in what it calls a purely Asian dispute and has warned of unspecified repercussions.

Additionally, Beijing has critised a recent agreement by the Philippines and the US, which are longtime treaty allies, allowing American forces access to additional Filipino military camps under a 2014 defense agreement.

"Zuck v Musk fight will be live-streamed on X," Musk wrote in a post Sunday on the platform. "All proceeds will go to charity for veterans."

Musk said earlier Sunday he was training for the fight by lifting weights.

'Don't have time to work out, so I just bring them o work," Musk wrote on X. Whether or not Musk and Zuckerberg actually make it to the ring has yet to be seen - especially as Musk often tweets about action prematurely or without following through. But even if their cage match agreement is all a joke, the banter has gained attention. It all started when Musk, who owns X, responded to a tweet about Meta preparing to release a new Twitter rival called Threads. He took a dig about the world becoming "exclusively under Zuck's thumb with no other options" - but then one Twitter user jokingly warned Musk of Zuckerberg's jiu jitsu training."I'm up for a cage match if he is lol," Musk wrote late Tuesday. Musk's push to stream the video live on X comes as he's pushing to turn the platform into a "digital town square." LAHORE, Aug 6 (PTI): Imran to the president for the dissolution Khan's conviction and his threeyear jail term in a corruption case have cleared a "major hurdle" in holding general elections in Pakistan and will help the ruling PML-N and the powerful military establishment to get the "desired results" in the polls, some analysts and political leaders believe.

Former Pakistan prime minister Khan, 70, was arrested from his home here on Saturday shortly after an Islamabad trial court found him guilty of "corrupt practices" in the Toshakhana corruption case and sentenced him to three years in iail, which automatically disqualified him for five years from holding any public office. The case alleges that the Pakistan Tehreeke-Insaf (PTI) chief "deliberately concealed" details of the gifts he retained from the Toshakhana, a repository where presents handed to government officials from foreign officials are kept, during his time as the prime minister and proceeds from their reported sales.

From political analysts to politicians of the mainstream parties, there has been a discussion in Pakistan in recent weeks that the general elections which are due in October/November will only be held once Khan is sent to jail, making it easier for the military establishment to get the "desired results" (in the polls) and install a set up of its choice in Islamabad.

Political analyst Hasan Askari Rizvi told PTI that after the arrest of Khan, there seems to be no reason left to delay the polls. "Both the ruling PML-N and the

military establishment appear to be on the same page," he said. Prime Minister Shehbaz Sharif last week told leaders of the allied

Hiroshima mayor calls nuclear deterrence 'folly' as city marks 78th anniversary of atomic bombing

TOKYO, Aug 6 (AP): Hiroshima officials criticised growing support for nuclear weapons as a deterrent resulting from uneasiness over Russia's war in Ukraine and tensions in the Koreas, commenting Sunday as the city remembered the atomic bombing of 78 years ago.

The observance came two months after Hiroshima hosted a summit of the Group of 7 major industrial nations, at which G7 leaders visited the city's peace park and a museum dedicated to those who died in the word's first atomic

The leaders issued a joint statement calling for the continued nonuse of nuclear weapons, but they also justified having such arms to "serve defensive purposes, deter aggression and prevent war and

Hiroshima Mayor Kazumi Matsui rejected that position in his peace address at the commemora-

"Leaders around the world must confront the reality that nuclear threats now being voiced by certain policymakers reveal the folly of nuclear deterrence theory," he said. "They must immediately take concrete steps to lead us from the dangerous present toward our ideal world."

Hiroshima Gov. Hidehiko Yuzai questioned the growing calls for reinforced nuclear deterrence around the world, including in Japan, since Russia invaded Ukraine and warned of possible nuclear weapons use, while North Korea advances its missile and nuclear development.

"Believers of proactive nuclear deterrence, who say nuclear weapons are indispensable to maintain peace, are only delaying the progress toward nuclear disar-

mament," Yuzai said. The atomic bomb dropped by



the United States on Hiroshima on Aug. 6, 1945, destroyed the city, killing 140,000 people, and a second bomb dropped three days later on Nagasaki killed an additional 70,000. Japan surrendered on Aug. 15, ending World War II and Japan's nearly half century of aggression in Asia.

Prime Minister Fumio Kishida,

who represents Hiroshima in parliament, has sought to highlight the G7 commitment to nuclear disarmament and a condemnation of Russia's threats to use atomic weapons. But he has been faulted by survivors for refusing to sign the Treaty on the Prohibition of Nuclear Weapon.

Arguing the pact is unworkable

because no nuclear-armed state has signed, Kishida has pledged to serve as a bridge between nuclear and non-nuclear states and work for nuclear disarmament. His critics say it is a hollow promise because Japan relies on the U.S. nuclear umbrella for protection and has been rapidly expanding its military.

Japan, the United States and South Korea are stepping up security cooperation in response to a more assertive China and the growing nuclear and missile threats from North Korea. Washington and Seoul have agreed to strengthen their nuclear deterrence cooperation, and Japan also wants stronger protection by U.S. nuclear

Kishida, who also attended Sunday's ceremony, said the path toward a nuclear-free world has grown tougher because of rising tensions and conflicts. "But the situation makes it even more important for the world to regain the momentum," he said.

People at the ceremony observed a moment of silence with the sound of a peace bell at 8:15 a.m., the time when a U.S. B-29 dropped the bomb on the city. Hundreds of white doves, considered symbols of peace, were released.

Many survivors of the bombings have lasting injuries and illnesses resulting from the explosions and radiation exposure and face discrimination in Japan.

As of March, 113,649 survivors, whose average age is now 85, are certified as eligible for government medical support, according to the Health and Welfare Ministry. But many others, including those who say they were victims of the "black rain" that fell outside the initially designated areas, are still without

"She is yet to respond to our offer of support to return to India. We stand ready to extend to her all assistance," it said.

PM Modi's 'Quit India' reference to target opposition as he launches mega railway station revamp

NEW DELHI, Aug 6 (PTI): Prime Minister Narendra Modi on Sunday accused the opposition of playing "negative politics" and said now the entire country is rooting for corruption, dynasty and appeasement to 'quit India'.

Addressing an event after laying the foundation stone for the redevelopment of 508 railway stations across the country via video conferencing, he alleged a section of the opposition is driven by the principle of neither working nor letting others work.

"Unfortunately in our country, there is a part of the opposition who even today won't do anything themselves and won't allow others to do anything either. They are stuck with this attitude.

"So, concerned about the country's present and the future a modern Parliament building was built, the symbol of democracy which has representation of both the government and the opposition. They even opposed that. We developed Kartavya Path and they opposed that as well," he said.

The PM then went on to refer to the Statue of Unity of Sardar Vallabhbhai Patel which is the biggest statue in the world. He said that while all Indians feel proud of it, few opposition party leaders have gone to there to pay homage. But some parties remember India's first home minister only during polls, he alleged.

"In 70 years, they did not construct a war memorial for martyrs but when we built one they did not even feel ashamed of criticising it publicly," he said.

"Away from the negative politics, we have

taken the task of nation's development as a mission and given it the top priority without caring for vote bank and party politics," he

At present, the Prime Minister said, the central government is also running a campaign to provide jobs to 10 lakh youth through 'Rozgar Mela'.

"This is the picture of a changing India where development is giving way to new opportunities for the youth, and the youth are giving new wings to the development of the country," he added.

Referring to the Quit India Movement anniversary on August 9, the prime minister said it was a historic day that created new energy in India's struggle for Independence. Today the whole country is roaring 'Quit India' for every evil, corruption, dynasty and appeasement, he said.

"Inspired by the Quit India Movement, the entire country is now roaring Quit India for every evil, saying 'corruption, quit India', 'dynasty, quit India', 'appeasement, quit India'," Modi said.

The PM mentioned the upcoming Partition Horror Remembrance Day and acknowledged the contribution of the people who gathered themselves after the shock and are contributing to the development of the country. "This day gives us the responsibility of keeping our unity intact."

The victim was shot on the roof of the office. The investigation of the case was transferred to the Crime Branch which examined the witnesses and analysed the evidence collected, including the viral video on social media of a TV Channel.

Search continues for missing disaster victims in Uttarakhand's Gaurikund

RUDRAPRAYAG (U'KHAND), Aug 6 (PTI): Rescue teams in Uttarakhand toiled for the third consecutive day on Sunday, searching for 20 people who went missing in a landslide triggered by a flash flood in Gaurikund while on their way to Kedarnath.

The landslide occurred around 12 am on the intervening night of Thursday and Friday, washing away three shops located close to a rain-fed waterfall and around 50 metres above the Mandakini river, which was in spate.

Personnel from the National Disaster Response Force, State Disaster Response Force, Yatra Management Force, police and fire brigade searched for the missing people with the help of drones from Dhari Devi to the Kund barrage on Sunday but found no one, District Disaster Management Officer (Rudraprayag) Nandan Singh Rajwar said.

Intermittent rain and falling boulders from hillsides continue to hamper the rescue efforts. The nearly six-kilometre stretch between Sonprayag and Gaurikund is highly vulnerable to landslides.

Three bodies were recovered from the rubble of the shops on Friday but 20 people remain missing. The spot where the shops stood and the Mandakini river is also being scoured, Rajwar said.

At 17, a majority of the victims were from Nepal. Ukhimath Sub-Divisional Magistrate Jitendra Verma said bad weather and the rise in the Mandakini's water level have made the rescue operation

With the continuing bad weather posing a threat of more landslides, owners of makeshift kiosks and shops are vacating the sites voluntarily to move to safe locations, he said. The district administration has begun to identify shops and other structures on either side of the road between Sonprayag and Gaurikund that could be endangered by landslides.

The three bodies recovered on Friday have been identified as those of Devi Bahadur, Tek Bahadur and Prakash Tamta -- all from Nepal.

Among the 20 people still missing are Ashu and Priyanshu Chamola from Tilwara, Ranbir Singh from Basti, Nepal resident Amar Bohra, his wife Anita Bohra, their minor daughters Radhika and Pinky and sons Prithvi, Jatil and Vakil. Vinod, a resident of Khanwa Bharatpur, Mulayam of Nagla Banjara in Saharanpur, Sugaram, Bam Bohra, Chandra Kami, Dharamraj, Neer Bahadur, his wife Sumitra Devi, their daughter Kumari Nisha, and Rohit Bisht from Utsuya Chopra are also missing.

Renowned Telangana folk singer Gaddar no more iconic poet, balladeer and fiery activist. His (Gad-

HYDERABAD/AMARAVATI, Aug 6 (PTI): Renowned Telangana folk singer and balladeer Gaddar, who was popularly known for his revolutionary songs during the 1980s and later during the Telangana statehood agitation, passed away here on Sunday due to ill-health. He was 77. Born as Gummadi Vittal Rao at Toopran in

Medak district in 1949, the renowned folk singer and poet went on to become popular as 'Gaddar'.

Gaddar died at Apollo Spectra Hospital in the city due to lung and urinary problems and advanced age, the hospital said in a statement. He was suffering from severe heart disease and got admitted on July 20. He underwent a bypass surgery on August 3 and recovered from it, the hospital said.

However, he has had a history of lung and urinary problems, which along with advanced age, became aggravated and led to his passing, it said.

His body was taken to L B Stadium in the city to enable people to pay their last respects. The funeral will take place on Monday. Tributes poured in condoling the death of the balladeer.

Telangana Governor Tamilisai Soundararajan, her Haryana counterpart Bandaru Dattatreya, Telangana chief minister K Chandrasekhar Rao, top Congress leaders, including AICC president Mallikariun Kharge, Rahul Gandhi and Priyanka Gandhi Vadra as well as TDP chief N Chandrababu Naidu and several other leaders from Telangana and Andhra

Pradesh expressed grief at Gaddar's demise. Rahul Gandhi tweeted, "Saddened to hear about the demise of Shri Gummadi Vittal Rao, Telangana's dar) love for the people of Telangana drove him to fight tirelessly for the marginalised. May his legacy continue to inspire us all," he said. Gaddar had attended a Congress public meeting addressed by Rahul Gandhi at Khammam in Telangana on July 2. Andhra Pradesh chief minister Y S Jagan Mohan



Reddy called Gaddar a revolutionary man. "He was the voice of the downtrodden and fought for social justice through his inspiring songs," Reddy said in a statement, and conveyed his condolences to the singer's family members.TDP chief N Chandrababu Naidu also posted on Twitter about the passing away of the popular singer, who is equally famous in both the Telugu states and popular for his revolutionary ballads."A prolific chapter in public movement and human rights campaign has come to an end with the passing away of Gaddar. He moved the masses with his voice," tweeted Naidu, and expressed his sympathies to the deceased campaigner's family.

TDP general secretary Nara Lokesh said he is devastated to know that Gaddar's voice has been silenced by death. Remembering his stellar contribution in achieving statehood for Telangana through his songs, Lokesh said Gaddar had emerged as the voice of the movement.

A decade ago, his song 'Podustunna Poddu Meeda Nadustunna Kaalama Pooru Telanganama' had become the anthem of Telangana achievement movement. Union minister and Telangana BJP president G Kishan Reddy said Gaddar, who played a key role in spreading public awareness on various issues, gave an impetus to the Telangana statehood agitation with his songs. Kharge said Gaddar would remain a hope for the aspirations of the weakest sections. Gaddar's poetry, passionate songs and activism espousing the cause of social justice shall always be a source of inspiration for Telangana and its people, the AICC president said.

Priyanka Gandhi Vadra said Gaddar's "unwavering dedication to social causes and the fight for Telangana's statehood was truly inspiring.'

A former naxalite, Gaddar had led an underground life, including in the forests. Subsequently, he had joined the mainstream and voted for the first time in his life in the Telangana Legislative Assembly polls in 2018. Gaddar, who was shot by assailants in the 1990s, had a bullet stuck in his spinal cord till the end.


