### WHO South-East Asia region commits to enhancing moon to take place on Aug 23 efforts to end TB

GANDHINAGAR, Aug 17: The WHO South-East Asia Region, which bears a disproportionate burden of nearly half of the global TB cases and deaths, on Thursday committed to further accelerate efforts to end tuberculosis by 2030 with its member countries adopting the Gandhinagar Declaration.

"Today urgent action is needed more than ever to achieve our goal of a region free of tuberculosis, that has been menacing millions of people with disease and death, poverty, and despair," Dr Poonam Khetrapal Singh, regional director WHO South-East Asia, said in her address to a ministerial meeting on "Sustain, Accelerate, and Innovate to end TB in the South-East Asia Region".

The Gandhinagar Declaration was adopted at the end of the twoday meeting held to follow-up on the progress made to end TB, a flagship priority in the region, and in the run-up to the UN High Level Meeting on TB on September 22 in New

The declaration calls for establishing a high-level multisectoral commission reporting to the highest political level in each country for synergy of efforts among various stakeholders, and to monitor progress towards ending TB and other priority diseases.

"These high-level multisectoral commissions on TB could also help build responsive health systems and advance universal health coverage and health security," the WHO regional director said, adding that during the Covid-19 pandemic, TB infrastructure was rapidly deployed for infection diagnosis and containment. ### Chandrayaan-3 lander separates from

propulsion module

BENGALURU, Aug 17: India's Chandrayaan-3 mission on Thursday achieved a major milestone when its Lander Module carrying the rover inside successfully separated from the Propulsion Module to be on course for an unprecedented soft-landing on the moon's south pole planned on August 23.

The Lander Module comprising the lander Vikram and rover Pragyan is now ready to be lowered to an orbit that takes it closer to the moon's surface. The soft landing on the lunar south pole is scheduled at 5.47 pm next Wednesday. "Thanks for the ride, mate! said the Lander Module (LM). LM is successfully separated from the Propulsion Module (PM). LM is set to descend to a slightly lower orbit upon a deboosting planned for tomorrow around 1600 Hrs IST," the Indian Space Research Organisation(ISRO) said in a post on X (formerly Twitter). The estimated ₹ 600 crore Chandrayaan-3 mission was launched on July 14, a far more complicated 41-day

voyage to reach the lunar south pole. After Thursday's separation, the lander is expected



to undergo a "deboost" (the process of slowing down) to place it in an orbit, where the Perilune (the orbit's closest point to the Moon) is 30 km and Apolune (farthest point from the Moon) is 100 km, from where the soft landing on the south polar region of the Moon will be attempted, an ISRO official said. The Propulsion Module will continue its journey in the current orbit for months/years, the ISRO said.

"Now really the match starts. These are the final overs we are talking about," Chandrayaan-I project director M Annadurai told PTI. (CONTD. ON PAGE-9)

### **Dengue outbreak:** 45% positivity rate in Diphu

DIPHU, Aug 17: The Dengue outbreak in the Diphu Municipal Board area shows no signs of abating, with the positivity rate remaining alarmingly high at 45% as of Wednesday. Tragically, the death toll from the outbreak has reached 3.

# to probe paper leaks

ITANAGAR, Aug 17: The Arunachal Pradesh government has constituted a one-man commission to probe into the alleged question paper leaks in various recruitment examinations conducted by the Arunachal Pradesh Public Service Commission (APPSC).

The Commission, led by retired Justice P K Deka will investigate the alleged question paper leaks in various exams conducted by the APPSC from April 2014 to August 2022, an official order said.

The constitution of the commission came in the backdrop of the hue and cry concerning transparency and fairness of the recruitment process due to suspected question paper leaks in various exams conducted in those years.

Chief secretary Dharmendra in the order, stated that the panel was formed aiming at unearthing the truth behind alleged instances of question paper leaks and associated irregularities during the specified period of APPSC examinations.

It will also scrutinize potential lapses on the part of officials, officers, and other stakeholders directly or indirectly involved in the recruitment process.

The Commission is also tasked with suggesting corrective measures to ensure future recruitment procedures, uphold transparency, impartiality, and efficiency. Furthermore, any other relevant issue that emerges during the investigation will be examined, and recommendations formulated accordingly.

The APPSC has been asked to provide all secretarial, logistics and other assistance to the commission, which is expected to compile a comprehensive report detailing its findings and recommendations within three

The question paper leak incident came to light after one Gyamar Padung, a candidate of the APPSC assistant engineer (civil) examination, filed a police complaint on August 29 last year, claiming that he suspected that the examination paper had been leaked. The case was initially investigated by the capital police and later it was transferred to the state police's Special Investigation Cell (SIC) and then the Central Bureau of Investigations (CONTD. ON PAGE-9)


icant crackdown against corruption, the Directorate of Vigilance & Anti-Corruption, Assam, has successfully apprehended individuals involved in bribery cases, leading to the arrest of public servants.

In the first case, a complaint reached the Directorate of Vigilance & Anti-Corruption, accusing Manuj Kumar Saikia, executive engineer of PWD(R&B) Haflong Division, of demanding a bribe of ₹ 55,000 from the complainant for the release of pending bills. The bribe amount was later negotiated to ₹ 25,000. In response to the complaint, a trap was set in the office of the executive engineer, PWD(R&B) Haflong Division. Manuj Kumar Saikia was caught accepting ₹ 10,000 as part of the demanded bribe, resulting in his arrest.

In another such case, a complaint was submitted to the Directorate of Vigilance & Anti-Corruption, Assam, alleging that Debasish Barman, Lot Mandal at the office of the circle officer in Tihu Revenue Circle, Nalbari, demanded a bribe of ₹ 2,00,000 from the complainant for resolving landrelated matters concerning his father's property. The bribe amount was later reduced to ₹ 1,40,000. Refusing to succumb to the demand, the complainant sought legal action against the accused.

In response, a trap was set by the Directorate's team on Thursday, at the office of the circle officer, Tihu. Nayan Barman, a middleman, was caught red-handed at 1:30 PM, accepting ₹ 5,000 as part of the bribe, on behalf of Lot Mandal Debasish Barman. The tainted money was seized, and both Nayan Barman and Debasish Barman were apprehended for their involvement in the bribery scheme. The case has been registered under Section 7(a) of the Prevention of Corruption Act,

The Directorate's actions are aimed at curbing corruption within government agencies and ensuring transparency and fairness in administrative processes.

During the session, the local unit touched a peak of 82.99 and a low of 83.16.

On Monday, the rupee depreciated 26 paise to settle at an alltime low of 83.08 against the US

Forex market was closed on Tuesday and Wednesday on account of Independence Day and Parsi New Year, respectively.

Meanwhile, the dollar index,

which gauges the greenback's strength against a basket of six currencies, rose 0.05 per cent to

Brent crude futures, the global oil benchmark, advanced 0.52 per cent to USD 83.88 per barrel.

"The Indian rupee traded lower in line with the Asian currencies and risk-averse sentiments," said Dilip Parmar, Research Analyst, HDFC Securities.

The greenback enjoyed good momentum reacting to July FOMC minutes that signalled clear openness to more tightening.

"We remain bullish on the pair and a crossing of 83.30 will pave the way for 83.50 and 83.70 while expected to hold the support at 82.70," Parmar added.

On the domestic equity market front, the 30-share BSE Sensex closed 388.40 points or 0.59 per cent lower at 65,151.02 points. The broader NSE Nifty declined 99.75 points or 0.51 per cent to close at 19,365.25 points. Foreign Institutional Investors (FIIs) were net buyers in the capital markets on Wednesday as they purchased shares worth ₹ 722.76 crore, according to exchange data. (PTI)

### Markets snap 2-day winning run; Sensex slumps nearly 390 pts on weak global cues



MUMBAI, Aug 17: Snapping their two-day winning run, equity benchmarks Sensex and Nifty closed in the negative territory on Thursday, tracking losses in index majors Reliance Industries, ITC and HDFC bank amid a weak trend in global

The 30-share BSE Sensex declined 388.40 points or 0.59 per cent to settle at 65,151.02. During the day, it fell by 493.32 points or

0.75 per cent to 65,046.10. The NSE Nifty slipped 99.75 points or 0.51 per cent to end at 19,365.25.

"The mounting influence of weak global cues hindered the domestic market's ability to recoup, resulting in sustained selling pressure. The release of Fed minutes unveiled a divided stance among its members regarding the necessity of additional rate hikes, contrasting the previously anticipated rate pause," said Vinod Nair, Head of Research

at Geojit Financial Services. ITC was the biggest loser from the Sensex pack, sliding 2.04 per cent, followed by Power Grid, Reliance Industries, Larsen & Toubro, Nestle, Kotak Mahindra Bank, Bajaj Finance and JSW Steel.

On the other hand, Titan, State Bank of India, Bajaj Finserv, Axis Bank, Tata Steel, Sun Pharma, Tech Mahindra and Bharti Airtel were the gainers. In the broader market, the BSE smallcap gauge climbed 0.19 per cent, and midcap gained 0.06 per cent.

"As per a study by Goldman Sachs, overseas investors holding in midcaps in India has increased by 175 basis points to 16 per cent of their market capitalisation this year, compared with a drop of 250 basis

points over the last five years,' Deepak Jasani, Head of Retail Research, HDFC Securities, said.

In the global markets, both gold and silver were trading lower at USD 1,895.5 per ounce and USD 22.65 per ounce, respectively.



# Darjeeling tea industry is a 'patient in ICU': ITEA chairman

KOLKATA, Aug 17: Chairman of Indian Tea Exporters Association (ITEA) Anshuman Kanoria on Thursday said that the Darjeeling tea industry is a "patient in ICU" and virtually on its death bed. For the Darjeeling tea industry to survive, some government support is needed in the form of subsidy which will help stave off the threat posed by tea from Nepal, he said.

Speaking at a session organised by the Bengal Chamber of Commerce and Industry (BCCI) here, Kanoria said, "Darjeeling tea is an emotion for us. It flows in our blood. Today, the Darjeeling tea industry is a patient in ICU, virtually in its death

The closure of the gardens due to political agitation in 2017, followed by lockdowns had caused huge financial loss to the industry as a whole,



He said, "A lot of foreign buyers had been turned away and this gave an opportunity to our neighbour (Sri Lanka) to capture some of the some of the export market"

Kanoria said the challenge of Nepal has become

serious as it is infiltrating the Indian Market. "With the Darjeeling crop down to 6.5 million kilograms per annum, the production in Nepal has gone up to six million kilograms. We have a serious competitor now," he noted.

The Darjeeling crop has fallen due to low productivity partially caused by climate change, he said, adding the Nepal tea industry comprising mostly small factories is run unlike that in India which is governed by the Plantations Labour Act.

"Darjeeling has become a high-cost operation with 60 per cent of the cost emanating from wages to labourers. Most of the Darjeeling gardens are losing to the tune of ₹ 200 per kilogram with each garden losing a few crores," he said.

Kanoria said that some support from the government is needed for the Darjeeling tea industry

### Police verification of SIM dealers mandatory: Ashwini Vaishnaw Bulk connections discontinued to curb frauds

NEW DELHI, Aug 17: The government has made police verification of SIM card dealers mandatory and discontinued the provision of bulk connections to curb fraudulent activities, Union

minister Ashwini Vaishnaw said on Thursday. The minister said that the government has disconnected 52 lakh mobile connections. While 67,000 dealers have been blacklisted, 300 FIRs have been filed against SIM card dealers since May 2023. The minister said WhatsApp on its own blocked around 66,000 accounts that were involved in fraudulent activities. "Now we have made police verification of SIM dealers mandatory to curb frauds. Penalty of ₹ 10 lakh will be imposed on dealers found violating norms," Vaishnaw said.

He said that there are 10 lakh SIM dealers and they will be given sufficient time for police verification.

The minister said that the Department of Telecommunications has also discontinued the provision of bulk connections and instead a new concept of business connection will be introduced. "Besides, KYC of businesses, KYC of person taking handover of SIM will also be done," Vaishnaw said. (PTI)

### Tragic demise of Demow resident in tanker fire prompts calls for swift justice

**DEMOW**, Aug 17: In a somber incident that occurred near Demow, Hobibul Ali (25), a resident of 2 No Masoi Gaon, lost his life after being engulfed in flames in a tanker associated with an illicit oil theft operation on July 26. Sustaining severe burns that affected 80 percent of his body, Hobibul Ali was rushed to a hospital in Guwahati on July 27. Despite medical efforts, he tragically succumbed to his injuries on August 3.

Mohammad Yasin Ali, the grieving father of Hobibul Ali, lodged an FIR at Sivasagar police station on August 6, providing an account of the events leading to his son's untimely demise. However, the responsible parties behind the incident remain unidentified, raising concerns about the pace of the investigation.

On Thursday morning, a joint press conference was held at the Demow Inspection Bungalow (IB), organised by Asomiya Yuva Mancha, ATASU, ATTSA, and AASAA. These community organisations came together to address the urgent need for apprehending the culprits involved in the tragic

Jadab Gogoi, president of Asomiya Yuva

Mancha (AYM), Central Committee, shed light on Hobibul Ali's background, revealing that he worked at a welding garage near Desang Bridge. Allegations were made against Mintu Ali, the garage owner, claiming that Hobibul Ali was coerced into performing tasks beyond his capacity. Gogoi expressed concern over the perceived lack of action by the police in response to the incident.

Sumeet Kumar Handique, joint secretary of ATASU, Sivasagar district, highlighted the family's decision to file an FIR at Sivasagar police station. However, the ongoing investigation process appears sluggish, prompting the community to demand justice for the grieving family.

Lalit Tanti, president of AASAA, Demow Regional Committee, stressed the urgency of apprehending the culprits responsible for the tragedy. Meanwhile, Mohammad Yasin Ali, Hobibul Ali's father, appealed for a thorough investigation to uncover the truth and deliver justice for his family.

In a unified call for action, the leaders of AYM, ATASU, ATTSA, and AASAA issued an ultimatum: demanding the culprits' arrest within 48 hours or warning of the initiation of democratic protest measures.

### **Unity must for INDIA**

s INDIA stands at a pivotal crossroads, the nation's political landscape has become a canvas of uncertainty and opportu-**A**nity. Home minister Amit Shah's proclamation that Prime Minister Narendra Modi is poised for a triumphant third term underscores the need for a cohesive opposition strategy. The onus lies on INDIA to prevent Modi's aspirations from becoming reality. This requires the Congress party to refine its leadership approach, with Rahul Gandhi steering the ship towards a united opposition front, rather than aspiring to be a lone 'tapaswi', which could be his undoing. At 53, Rahul Gandhi must engage in candid discussions with opposition leaders, rallying them around the principles of coalition politics. Drawing from the lessons of the UPA experience, he should guide them toward a collective goal. The Aam Aadmi Party (AAP), while valuable to the opposition mosaic, must align with the broader agenda. Arvind Kejriwal's role, though pivotal, cannot stall the emergence of a formidable alternative to Modi's rule. In this pursuit, no opposition leader, regardless of stature, should eclipse the greater alliance that is 'India'. The AAP's decision to eschew the Mumbai meeting of the alliance underscores the need for a unified stand. ### Indian govt steps into mould of British who considered themselves as aliens

Shah's legislative package in relation to the means, or any other means, stirs hailed by his ruling party as pathbreaking, has more symbolism than real reform and even includes a good measure of decep-

Of course, there are a couple of good things, such as stringent punishment for mob lynching, though without specifically mentioning as such, and crimes against women, but Shah makes the vital mistake of confusing English with British and in assuming that the two are freely interchangeable. His package ends up changing names of existing laws while in the process betraying an Indianised version of the British arrogance on the part of the present day rulers. The propriety of giving Hindi names to the three main criminal laws – the Indian Penal Code, Criminal Procedure Code and the Indian Evidence Act – when the entire judicial process in the country is being conducted in English has already been questioned. There is nothing whatsoever to the change of nomenclature than symbolism.

Tamil Nadu chief minister M K Stalin has raised the red flag over the change, accusing the Modi government of a certain linguistic imperialism and describing Shah's package as representing re-colonisation in the name of decolonisation. He is not much off the track.

The British considered themselves as aliens, for logical reasons too, and perceived people as their enemies as the colonialists were aware that they had usurped their rights. But BJP, despite all its protestations about Indianness. has stepped itself into the shoes of the British and is likewise treating people as their adversaries.

Shah's introduction of the new bills was marked by a dramatic announcement that the British-era law against treason was being repealed completely. But even before the excitement died out, the realisation came that he has incorporated a new provision which is more draconian than the one that was being abrogated.

The existing sedition laws have been replaced by Section 150 which outlines that anyone who

deliberately, knowingly, or through words, spoken or written, Minister Amit signs, visible presentations, elec-Shah's legislative pack- tronic communication, financial armed rebellion, subversive activities, fosters separatist sentiments, or poses a threat to India's sovereignty, unity, and integrity, or engages in such acts will be liable to imprisonment for life or imprisonment of up to seven years,

along with a potential fine. Attempts at secession cannot be tolerated by any means, but the real danger here is that there is no proper definition of secession. In fact, the very word secession is missing in the new provision. This makes it easy for the government to interpret anything as secessionist and use the provision to suppress criticism. The new provision, in fact, brings through the back door what the Supreme Court had struck down more than one year ago.

In a landmark development, the Supreme Court had asked the Central government and States to refrain from registering any cases for the offence of sedition under Section 124A of the Indian Penal Code. A bench of Chief Justice of India NV Ramana and Justices Surya Kant and Hima Kohli directed that proceedings under Section 124A be kept in abeyance till the government's exercise of reviewing Section 124A is complete. The bench also asked governments not to continue investigation or take coercive steps in all pending proceedings under the provision till the government's exercise is complete.

Should such cases be registered, the parties are at liberty to approach court and court has to expeditiously dispose of the same, the bench added. "It would be appropriate to put the provision in abeyance," the order further said. The government's intention behind the new provision is to circumvent the courts in cases relating to what it considers as objectionable conduct or event. This was essentially a law that the British framed to deal with any challenge to the imperialists' authority and by retaining it in the new Sanhita, the government has got into the mould of the British. whose distrust for the people was a cardinal aspect of their rule in India. # Debtor nations seek IMF assistance amidst austerity struggles

midst a global economy experiencing a pronounced deceleration, Leven conservative economists are labeling it as 'secular stagnation'. This downturn is accentuating the critical issue of external debt for numerous Global South nations. As their export revenues dwindle, they find themselves unable to cover both import costs and debt servicing obligations. Consequently, these countries confront a dire situation where essential private financial inflows diminish precisely when they are most needed, coinciding with the anticipation of currency depreciation that further exacerbates the scenario. Consequently, debtor nations are compelled to seek aid from the International Monetary Fund (IMF), which often enforces severe 'austerity' measures disproportionately impacting the working populace. The aftermath can be swift and stark, transforming a nation from 'medium income' status to a dire 'basket case', a reality underscored by instances within our own regional vicinity.

Numerous recommendations have surfaced within this context to assist countries. burdened with debt. These proposals encompass a spectrum from debt restructuring to the issuance of a new cycle of Special Drawing Rights, injecting renewed liquidity into the global economy, as well as amplifying lending from within the Global South itself, facilitated by institutions like the BRICS bank. Undoubtedly valuable, these suggestions fall somewhat short. The ultimate goal should extend beyond merely easing borrowing terms for impoverished nations, aiming instead to substantially curtail, if not entirely eradi-

This necessity emerges due to the fact that at any specific level of global economic output, distributed unevenly among nations, debtor countries exhibit aggregate demand surpassing their own production. However, given that global aggregate demand must inherently match production (as anything produced requires corresponding demand), this results in creditor countries experiencing an aggregate demand that falls below their productive capacity. Consequently, any deficit, indicative of borrowing, inherently corresponds to an equally substantial surplus.

If surplus nations consistently diminish their surplus by consistently boosting their domestic consumption each time a current account surplus emerges within their balance of payments, this proactive approach would inherently eradicate the deficits faced by countries in deficit. This, in turn, would obviate the necessity for borrowing by deficit countries.

This approach would yield an added benefit beyond eradicating the need for borrowing. The global demand would expand beyond its initial state, pre-adjustment, resulting in heightened worldwide employment, output, and consumption. In essence, the world would be enhanced, free from inter-country indebtedness, if every surplus nation consistently and promptly eradicated its current account surpluses. However, the question arises: why does this scenario not materialize? Indeed, during the establishment of the Bretton Woods system in 1944, a proposition was put forth suggesting that surplus nations should be compelled to boost their domestic consumption to nullify their surpluses. However, this proposal

America, which, at the time, maintained a surplus position (later transitioning to a deficit) and held a pivotal role as the capitalist world leader, exerting significant influence over its formation.

The mutually beneficial outcome that arises from compelling surplus nations to eliminate their surpluses can be exemplified using a scenario within the European Union. Here, Greece has consistently operated as a deficit country, whereas Germany has maintained a surplus position. If the German government were to elevate its fiscal deficit by, let's say, one million euros, and subsequently distribute this sum gratuitously among its populace for vacations in Greece, it would result in a corresponding increase in Greece's foreign exchange earnings, enabling the repayment of a portion of its existing debt. (Simultaneously, Germany's current account surplus would diminish by the same amount.) Consequently, Greek indebtedness would decrease while employment opportunities in Greece would rise. Meanwhile, for Germany, the populace would enjoy enhanced well-being through their Greek holidays instead of accumulating claims on Greece. This illustration further underscores the reasons behind the absence of such actions. Firstly, within a capitalist economy, the preference lies in possessing claims on other nations, affording it leverage over them, rather than enhancing the quality of life for its citizens.

Secondly, an elevation in the living standards of the populace, predominantly composed of workers, amplifies their negotiating power, empowering them to demand higher wages. Consequently, due to both these factors, the seemingly advantageous win-win scenarios, which would be logical choices, are rendered unfeasible within a capitalist framework.

The likelihood of establishing an international economic order mandating surplus countries to enact adjustments appears distant. This serves as an argument for the Global South to incrementally disengage from a global structure largely dominated by advanced capitalist nations and instead establish local or sub-global trade agreements. In these arrangements, countries may still possess claims on each other, yet these claims would be settled bilaterally or multilaterally within the arrangement itself, free from the encumbrance of interest. In the past, India embraced such an approach with the Soviet Union, wherein bilateral trade was conducted exclusively in rupees and roubles, with a fixed exchange rate between them, excluding the use of dollars or other major currencies.

These arrangements are experiencing resurgence in popularity. Brazil, for instance, has recently forged such an arrangement with China, while India has established a similar agreement with the United Arab Emirates. The mounting instances of advanced capitalist nations, spearheaded by the US, unilaterally imposing sanctions on numerous countries without United Nations Security Council approval are expected to drive the proliferation of such arrangements in the near future. While these arrangements may not address the historical external debt burden of the Global South, they hold potential for curbing future debt challenges. # An unholy omen is looming over Bangladesh

n a warm August night 75 years ago, the sun set on the British Raj. In the mottled dawn that followed came into existence two, then three, countries. It wasn't just the country and provinces that were divided – to use Annada Shankar Ray's words, Partition entailed allotting everything from tea gardens, coal mines, colleges, police stations, office rooms to chairs, tables, wall clocks to peons, policemen, and professors into two countries. And it was accompanied by one of the largest population movements in human his-

In a seminal 2008 article by Prashant Bharadwaj and his colleagues, The Big March: Migratory Flows after the Partition of India, it is estimated that nearly 3 million Hindus emigrated out of then East Pakistan, while three quarters of a million Muslims moved there from India. The relatively small number of people emigrating eastwards, juxtaposed against the relatively large number of people fleeing, possibly explains why the public memory of partition differs so starkly on the two sides of the Radcliffe Line in the eastern subcontinent. In Indian Bengal, partition is everpresent in the literature as well as in the visual media, in classic novels and movies, evoking a lost world and the plight of a people cut off from their rural roots, and their struggles among the teeming multitudes of Calcutta. But what about the lives of those who

stayed behind? Nirad C. Chaudhuri and Jatin Sarker were both born in Hindu families in the Mymensingh district of eastern Bengal, now Bangladesh, Chaudhuri, about four decades older than Sarkar, wrote his autobiography before India held its first election, and ceased to be unknown. Sarker also wrote his life story. Unlike Chaudhuri, Sarker's was in Bangla, published in Bangladesh, never translated in English, and not widely available. He remains unknown. Which is a pity, because Sarker is a far, far better guide than Chaudhuri when it comes to the land of their birth. When Sarker's hometown Mymensingh became part of East Pakistan – the rural slum of Jinnah's moth-nibbled two-winged land of the pure – his family didn't move to India. They were not atypical. Many Hindu families remained in East Pakistan. Perhaps it was the presence of Mahatma Gandhi or the fantastical be-

after the Battle of Plassey - to reunite Mother Bengal. Whatever the reason, there were no trains full of dead bodies to and from Calcutta in that dreadful August. Instead, there were emigrations in dribs and drabs, with major outflows during the communal violence of 1946, 1950, and 1964. Sarker describes the lives of middle class bhadralok (gentlemen) Hindus of mofussil East Pakistan in Pakistan-er Janma Mrittu Darshan ('Witnessing the Life and Death of Pakistan'). While he stopped being an Indian on 14 August 1947, he didn't become a Pakistani. That country became an Islamic Republic. Hindus were not equal citizens there. They were dhimmis, under the 'sacred protection' of the majority. Sarker could never be a Pakistani, but his Bengali Muslim neighbours did not quite feel at home in Pakistan either. In 1971, when East Pakistan died and Bangladesh was born, Sarker thought he would become an equal citizen of a free country.

And on paper, he is. Bangladesh never became an Islamic Republic, although Hussein Muhammad Ershad, military ruler in the 1980s, inserted Islam as the state religion in the Constitution, and his ally andcurrent prime minister, Sheikh Hasina refused to take it out despite other wholesale changes to the document. There is no formal discrimination with respect to religion. Hindus are not formally denied a job, a bank loan, or admission to an educational institution (except madrassas of course). On paper, Sarker has no reason to write Bangladeshey Pakistan-er bhut darshan ('Witnessing Pakistan's Ghost in Bangladesh'), a hypothetical sequel where he might have talked about things that one did not wish for in the Republic

Bangladesh. Things like communal violence targeting Hindus for example.

By communal violence, one does not mean a Gujrat 2002 – nothing like that has ever happened in Bangladesh. And one also needs to acknowledge that the mutual apathy and distrust, if not overt antagonism, between the eastern subcontinents's two large religious commu-(and multiple ethnic communities) is much more complex than the tales of eternal harmony. As Annada Shankar Ray noted, the two communities had co-existed in the region for generations and centuries without really intermingling. Of course, that complex interplay of historical legacy lief that Subhas Chandra Bose would affects the Hindu-Muslim interpersonal



better off to deny this. For example, in a fascinating experiment, Pushkar Maitra and colleagues show that it is the minority status, not religious identity itself, that drives people's behaviour. That is, a Muslim in West Bengal trusts a fellow Muslim more than a Hindu, but a Bangladeshi Muslim is indifferent between the communities.

The historical legacy of the divergent paths taken by the two communities in the 18th and 19th century continue to have economic consequences even in today's Bangladesh. Salma Ahmed found that even in the decade to 2009, Hindu male workers earnt more than their Muslim colleagues because they were better educated on average, but they faced discrimination and earnt less than might have been expected from their qualification.

There is, of course, no law supporting discrimination against Hindus. There is, however, a law that makes the community particularly vulnerable — the Enemy Property Act 1965 and its Bangladeshi successors.

The Act allows the state to seize properties of those who leave the country. In practice, this has been used over the decades to grab Hindu properties. Typically, local big-wigs grab some prime land, and then use death or emigration of one of the family members as an excuse to enlist the entire property. If emigration is not voluntary, coercion or intimidation is commonplace.

What were the political affiliations of the offenders? According to Barakat who is well-connected with the Awami League, allegedly contributing to the party's electoral platform in the 2000s and rewarded with cushy jobs by the current government – over 44% of the land grabbers were connected with the Awami League, more than the combined total of the Bangladesh Nationalreturn in 1957 - a century after the interactions on a daily basis -no one is ist Party (BNP), Jatiya Party and

Jamaat-e-Islami linked offenders. And this study came out in 2000, well before the current 15 years of Awami League

And thus we come to the dysfunctional polity that curses the life of Bangladeshi Hindus. All the historical legacies notwithstanding, the single biggest threat to the wellbeing of Bangladeshi Hindus in 2023 is an authoritarian and increasingly dysfunctional political landscape where most members of the community are treated as the expendable untermensch (racially or socially inferior) by the powers-thatbe. Even though there has been no incident comparable to the Gujarat riots in Bangladesh, there has been violence. In December 1992, when the centuries-old Babri mosque in Ayodhya was razed to ground, temples were desecrated across Bangladesh. Khaleda Zia, then prime minister, ordered the state machinery to move in quickly to stem the violence.

Zia must have remembered the experience very well. The Gujarat rampage happened during her second stint in power. Her government ensured that there were no reprisals against the Hindu community in Bangladesh. She was also acutely aware of the communal violence that marred her return to power in 2001.

Of the 300 seats in Bangladesh's parliament, Hindus were a non-trivial minority in about 70. In a tight election, their votes could make a huge difference. Not allowing them to vote was one way of reducing their influence. That is precisely what happened in 2001. In that election, Awami League received 40% of the votes against the BNP's 41%. Hindu voters in some districts became the victim of targeted communal violence after the election.

Bangladesh's stressed and stretched electoral democracy failed to safeguard

The story, of course, does not end there. Two decades later, images and stories of the victims of 2001 resurfaced in a toxic cocktail of misinformation and propaganda against Mamata Banerjee in the 2021 West Bengal election. Majoritarian democracy is not sufficient to safeguard citizens' rights, this much is self-evident when one looks across the Radcliffe Line.

Of course, discarding democracy is guaranteed to extinguish citizens' rights, this much is also self-evident when one just thinks of Bangladesh of the past decade.

In Bangladesh under a supposedly secular, inclusive government of Hasina Wajed, however, there has been repeated communal violence, with active connivance if not instigation of her partymen.Never in the history of Bangladesh, the Hindu community saw coordinated attacks on temples during Durga Puja, until 2021 that is, after a copy of the Quran was found in a temple. A video of the incident spread like wildfire and soon, angry mobs started attacking temples across the country. Within four days, eight people died including three Hindus.

During the coordinated attack, in Chandpur, Ariyan Sajjad, a member of the Awami League's student wing and son of local Awami League leader Shahida Begum, called the local Muslims to launch an attack on temples and pandals of Hindus in protest of the "desecration of Quran". In Bandarban, Awami League leader Zahirul Islam addressed the mob before they started attacking the temple. This was not an isolated incident. As a former officer of the Indian Police Service, Vibhuti Rai, remarked about communal violence in India, no such event can last for more than 24 hours without the consent of the state – a sentiment that is applicable on an even shorter time-frame in Bangladesh, given the more comressed distances involved. Ain O Salish Kendra, a Bangladeshi human rights organisation, has documented 3,679 incidents of attacks on Hindus from 2013 to 2021, which included 1,559 incidents of housebreaking and arson, 1,678 incidents of vandalism and arson in idols, worship halls, and temples and the death of 11 Hindus in these attacks. The individuals involved in these attacks are loyal to Awami League, Bangladeshi media outlets revealed. Of course, none of the cases involving the attacks on minority communities have been properly investigated. This

Bangladesh has been under a de facto one-party, if not one-person, rule for nearly a decade now. Hasina Wajed's authoritarian regime may or may not come to an end soon - elections are due in a few months and discontent is risingbut then again, she rigged the last two and may as well rig another one.

There is every reason to fear that the increasingly beleaguered dictator may turn to the age-old tactic of communal violence. In November 1990, L.K. Advani led a vatra across India to demand the razing of the Babri mosque. In Dhaka, goons associated with his party vandalised the Dhakeshwari Temple in the capital, to give President Ershad an excuse to impose curfew and act like a statesman. Ershad's gambit failed, and his government fell the next month after a popular uprising. Might Hasina update the playbook for the 21st century, deploying social media and disinformation on the one hand, and a far more draconian state machinery of repression on the other, all against the backdrop of a Hindutva government seeking a third term in India a few months later?

One does not need to be a paranoid conspiracy monger to be apprehensive about the unholy omen as we approach the autumn - the traditional festive season of the Bengali Hindus.

Nearly 76 years after partition, Gayeshwar Chandra Roy, a member of the BNP standing committee, recently bemoaned, "It is a sad fact that the people of Bangladesh's minority community have no say anywhere; neither in administration, nor in judiciary. In one word, Bangladesh does not care. Due to insecurity, there is a gradual exodus of Hindus from Bangladesh."

Almost 77 years ago, the Bengal delta was red with communal bloodletting that couldn't have been stopped by the British Raj in its last days, until a frail old man came with a message of peace. There is, of course, no Mahatma in Bangladesh. But nor is one needed. It would suffice for the state machinery to do what it did in 1992 or 2002.

The reality, however, is that in the past decade, the Bangladeshi state has become very good at stamping out dissent. But given the rot, it has become very bad at statehood and the type of resolute action that would have thwarted these attacks. Until and unless there is an honest acknowledgment that the state is broken and needs to be rebuilt, with a free and fair election as the first step of that process, Bangladesh will remain haunted by the spectre of

# **India-China tensions** on the global stage

China has entered one of its worst phases. While acknowledging that China is an important neighbouring country, Indian policymakers have been underscoring the importance of mutual respect and adherence to agreements to maintain a positive and constructive relationship. New Delhi has been categorical in emphasising that the present downturn in bilateral relations was created by China and not by India, placing the responsibility of bringing the ties back on track squarely on

While India continues to underline the importance of peace on the Line of Actual Control (LAC) as a prerequisite for normalcy in the broader relationship, pressing China to take forward disengagement in remaining friction areas, China continues to go back to the old rule book, suggesting that "specific issues" shouldn't "define the overall relationship." For Beijing, it is important that India and China continue to work together on global and bilateral economic concerns, even as the border issue is dealt with by officials on both sides.

This old paradigm has been the guiding principle in shaping the trajectory of Sino-Indian relationship over the past few decades. However, today there are few takers for this in India as New Delhi sharpens its policy response vis-à-vis China. In the past, there was a sense that India and China, despite serious bilateral divergences, had significant convergences at the global level that could be explored to build a partnership benefiting the two

However, today the divergences between India and China on global platforms are becoming equally evident. Recently, External Affairs Minister S Jaishankar told the Parliamentary Consultative Committee for External Affairs that China is the only country among five permanent members of United Nations Security Council (UNSC) that is opposing India's entry into the powerful body. It was always clear that China won't allow India into the UNSC, but for India to articulate it openly makes it evident that New Delhi has no faith in the UNSC reforming anytime soon. As a result, India is signaling that it will work with other platforms to pursue its global interests and contribute to the global order.

The Sino-Indian contestation is also intensifying across various platforms. At last month's virtual summit of the Shanghai Cooperation Organisation (SCO) that India hosted, Prime Minister Narendra Modi not only took on Pakistan directly but also the duplicitous attitude of nations

countries use cross-border terrorism as an ince the Galwan clashes of 2020, instrument of their policies and provide ndia's bilateral relationship with shelter to terrorists. SCO should not hesitate to criticise such nations. There should be no place for double standards on such serious matters." With his comments, Mr Modi was making clear that sanctimonious statements from SCO on terrorism have no meaning if Pakistan is not made to feel the heat of regional states. He was underlining New Delhi's concerns about the effectiveness of the SCO on a matter as important as this

> Modi also addressed issues related to territorial sovereignty and connectivity, underlining that strong and better connectivity "not only enhances mutual trade but also fosters mutual trust". He, however, cautioned that "in these efforts, it is essential to uphold the basic principles of the SCO charter, particularly respecting the sovereignty and regional integrity of the member states." In line with its longstanding and consistent approach on China's Belt and Road Initiative (BRI), India refused to sign the paragraph supporting BRI in the New Delhi declaration and stayed out of a joint statement on SCO Economic Development Strategy 2030.

> The future of BRICS (Brazil, Russia, India, China and South Africa) is also under stress as Chinese attempt to expand the platform is being resisted by India and Brazil. Beijing is focused on a quick expansion with the aim of giving the platform a distinctly anti-Western orientation, which New Delhi and Brasilia seem to have no interest in. While the five members expressed an interest in the expansion of the grouping last year, India is keen that the principles defining the process of expansion are articulated clearly. # India under Modi gave Pakistan more chances to redeem itself than it deserves

ernment's record and performance during his Lok Sabha speech on the No-Confidence motion moved by the Opposition parties. In the course of his address, he attacked the Congress party for believing foreigners instead of relying on the capabilities of India.

In this context, Modi also accused the Congress of going to the extent of accepting Pakistan's denials about its involvement in terrorism. He said that India carried out surgical and air strikes against terrorism but the Congress did not have faith in India's Armed Forces but put its faith in the claims of the enemy.

India's approach to Pakistan's terror excesses

Ultimately, the Parliament is a political forum and necessarily reflects the political approaches of the government and the opposition parties on all issues under this supreme legislative body's consideration. This is even more so during a debate on noconfidence in the government. It, therefore, follows that Modi's comments on India's approaches to Pakistan were more from a political standpoint rather than strategic and diplomatic positions.

Nevertheless, his remarks provide an opportunity to consider how successive governments, including that of Modi, have dealt with Pakistan, including its sponsorship of terrorism against India.

Pakistan has resorted to proxy armed aggression since 1947 when it sent raiders into the then princely state of Jammu and Kashmir. That led to J&K's accession to India which is final and irrevocable. Later, in 1965, it again sought to send proxies to J&K but India not only crushed them but opened a front outside the state leading to the 1965 war. Pakistan's aim of wresting the state from India failed.

This continuing round of proxy, terrorist aggression through Islamic groups under its control began in 990 and has continued since then. Its intensity though has been calibrated by Pakistan. All governments since then have had to find ways and means of dealing with Pakistan and Pakistani-sponsored terrorism.

How have different governments tackled the Pak issue

These have been Congress-led governments, those of the ThirdFront, the NDA government headed and then, once again the beginning of Pathankot. This did not change Pakled by Modi.

The approach of all governments, till the end of 2015, was two-fold. The first was to combat Pakistani terrorism through hardening Indian defences against infiltration and seeking to effectively combat terrorists on Indian territory largely in J&K but elsewhere in India too. The second was to engage Pakistan in dialogue so that it realised that its quest for gaining J&K through violence and terror was futile but also to show it the advantages which will accrue to it if it agrees to putting in place a framework of cooperative ties with

relented and the National Security Advisors and the Foreign Secretaries of India and Pakistan met in Bangkok in early December 2015. A few days later then External Affairs Minister Sushma Swaraj visited Islamabad for an Afghanistan-related meeting. She agreed with Pakistan to begin a Comprehensive Bilateral Dialogue process once again. Modi put the seal of approval on these developments as an act of statesmanship when he dropped in to meet Nawaz Sharif on his way back from Kabul to Delhi on Christmas Day in 2015. However, as in the past, so now, the Pakistan Army did not want this to go forward.

Within ten days of the Modi visit, the Pathankot airbase was attacked. Yet Modi persisted with the peace initiative and allowed a team which included an ISI officer to visit India for investigations and also go to India's retaliation post Pulwama

In July 2016, the K Burhan Wani was killed by the security forces and Pakistan unleashed a propaganda war against India. In September, the Uri military base was attacked by terrorists from Pakistan. It is at this time that Modi's approach changed and he ordered a surgical strike against Pakistani terrorist launch pads.

This was a significant change in policy and has to be appreciated. Yet it would seem that despite the surgical strike, there was thought being given by Modi to continue with contacts with the Pakistan leadership.

In his book 'In Pursuit of Peace' the late Satinder Kumar Lambah who was the Indian part of the back channel between India and Pakistan during the Prime Minister Manmohan Singh period notes, "On 20 April 2017, a senior official of the PMO came to see me at my house. He said that the Prime Minister wanted me to go to Pakistan to meet Prime Minister Nawaz Sharif" (page 314) Eventually, Lambah did not go but a "leading Indian businessman' went, according to press reports.

It was the Pulwama terrorist attack of February 2019 which changed Modi's position finally.

He ordered the Balakot air strikes. This was an indication to Pakistan and the world that India would take military action against unacceptable Pakistani terrorist attacks. Along with the air strike. India enunciated a doctrine of pre-emption which needs to be reiterated from time to time but is

The constitutional changes in J&K in August 2019 caused Pakistan to go irrational. It broke off ties and the rupture in the relationship has continued. Even then, perhaps as claimed by some Gulf countries diplomats, India and Pakistan entered into a ceasefire in February 2021 along the LOC and the International Border in the UT of J&K with the facilitation of some Gulf country leaders. That has largely held.

Even as Modi's initial instinct was to pursue the policies of his predecessors, the record shows that Modi has changed the dynamics of the India-Pakistan relationship in the context of terrorism. Its test may come if Asim Munir the new Pakistani Army Chief decides as some of his predecessors have done—to act irrationally. (Courtesy: The Quint)



# Hawaii governor vows to block land grabs as fire-ravaged Maui rebuilds

governor vowed to protect local landowners from being "victimized" by opportunistic buyers when Maui rebuilds from a deadly wildfire that incinerated a historic island community, as schools began reopening.

Gov. Josh Green said on Wednesday that he had instructed the state attorney general to work toward a moratorium on land transactions in Lahaina. He acknowledged the move will likely face legal challenges.

"My intention from start to finish is to make sure that no one is victimized from a land grab," Green said at a news conference. "People are right now traumatized. Please do not approach them with an offer to buy their land. Do not approach their families saying they'll be much better off if they make a deal. Because we're not going to allow it.

Also Wednesday, the number of dead reached 111, and Maui police said nine victims had been identified, and the families of five had been notified. A mobile morgue unit with additional coroners arrived on Tuesday to help process and identify remains.

Since flames consumed much of Lahaina about a week ago, locals have feared that a rebuilt town could be even more oriented toward wealthy visitors, Lahaina native Richy Palalay said Saturday at a shelter for evacuees.

### Pakistan's caretaker PM Kakar assures US of 'free and fair election process'

ISLAMABAD, Aug 17: Pakistan's caretaker Prime Minister Anwaarul-Haq Kakar has assured the US of "a free and fair election process" in the country, days after the littleknown politician from Balochistan province assumed office.

Pakistan is likely to have general elections in the coming months with the National Assembly's term ending on August 12.

Taking to X, formerly Twitter, on late Wednesday, Kakar said, "The interim government will be assiduously working to facilitate a free and fair election process in Pakistan according to the Constitution."

His tweet came in response to a congratulatory tweet by US Secretary of State Antony Blinken after Kakar, a first-time Senator, was appointed as Pakistan's caretaker Prime Minister on August 12.

Congratulating Kakar for becoming Pakistan's interim prime minister, Blinken tweeted, "As Pakistan prepares for free and fair elections, in accordance with its constitution and the rights to freedom of speech and assembly, we will continue to advance our shared commitment to economic prosperity.'

Kakar in his response also said Pakistan places importance on its partnership with the US and deeply values the shared commitment to economic prosperity, democracy and stability in the region.

Blinken has recently been quite active in commenting on the developments in Pakistan.

Previously also he issued a statement after cash-strapped Pakistan managed to secure a standby agreement with the International Mone-

tary Fund (IMF). "We stand by the Pakistani peo-



ple during these hard times and welcome the International Monetary Fund's approval of a program to support Pakistan. We urge Pakistan to continue working with @IMFNews toward macroeconomic reforms and sustainable economic recovery," Blinken tweeted after the Washington-based global lender agreed to give a USD 3 billion bailout to Pakistan on June 29.

Earlier this week, the US said it would work with the interim administration led by Kakar and his team as they prepare to hold elections in Pakistan.

'We are aware that the Pakistan National Assembly and government have been dissolved and note the announcement of Senator Anwarul-Haq Kakar, and he has been named the caretaker prime minister, and we look forward to working with the interim prime minister and his team as they prepare to hold elections," State Department's principal deputy spokesperson Vedant Patel said.

"We, of course, will continue to partner with Pakistan on areas of mutual interest, including our interest on Pakistan's economic stability. prosperity, and security, and the conduct of free and fair elections and the respect for democracy and the rule of law," Patel said on Tues-

Former prime minister Imran Khan, who is currently serving a three-year jail term in a corruption case, has been alleging the US of hatching a conspiracy to topple his government.

Khan was ousted from power in April last year after losing a noconfidence vote in his leadership. He alleged that the US targeted him because of his independent foreign policy decisions on Russia, China and Afghanistan. The US has repeatedly dismissed his

### Plea negotiations could mean no 9/11 defendants face the death penalty, the US tells families



WASHINGTON, Aug 17: The suspected architect of the Sept. 11, 2001, attacks and his fellow defendants may never face the death penalty under plea agreements now under consideration to bring an end to their more than decade long prosecution, the Pentagon and FBI have advised fami-

The notice, made in a letter that was sent to several of the families and obtained by The Associated Press, comes 1 1/2 years after military prosecutors and defense lawyers began exploring a negotiated resolution to the case. The prosecution of Khalid Sheikh Mohammed and four others held at the U.S. detention center in Guantanamo Bay, Cuba, has been troubled by repeated delays and legal disputes, especially over the legal ramifications of the interrogation under torture that the men initially underwent while in CIA custody. No trial date has been set.

'The Office of the Chief Prosecutor has been negotiating and is considering entering into pre-trial agreements," or PTAs, the letter said. It told the families that while no plea agreement "has been finalized, and may never be finalized, it is possible that a PTA in this case would remove the possibility of the death penalty."

The letter, dated Aug. 1, was received by at least some of the family members only this week. It asks them to respond by Monday to the FBI's victim services division with any comments or questions about the possibility of such a plea agreement. The FBI had no comment Wednesday on the letter. On Sept. 11, 2001, conspirators from the al-Qaida militant group seized control of jets to use them as passenger-filled missiles, hitting New York's World Trade Center and the Pentagon near Washington. A fourth plane was headed for Washington but crashed in Pennsylvania after crew members and passengers tried to storm the cockpit.

It was Mohammed who presented the very idea of such an attack on the United States to al-Qaida leader Osama bin Laden, and who received authorization from bin Laden to craft what became the 9/11 attacks, the United States' 9/11 Commission concluded. The four other defendants are alleged to have supported the hijackers in various ways.

The attacks led to the U.S. "war on terror," which included U.S. invasions and prolonged wars in Afghanistan, where al-Qaida was based, and in Iraq, which had no connection with the attacks.

Jim Riches, who lost his firefighter son Jimmy in 9/11, went to Guantanamo for pretrial hearings in 2009. He remains deeply frustrated that the case remains unresolved 14 years later. (AP)

### Death toll rises to 27 as Dominican firefighters find more bodies

SANTO DOMINGO, Aug 17: The death toll from this week's powerful explosion in the Dominican Republic rose to 27 on Wednesday as firefighters continued efforts to extinguish the persistent fire set off by the blast, the national emergency director said.

Juan Manuel Méndez, director of the Centre of Emergency Operations, also said there were no longer any people believed missing. Earlier, authorities cited 10 missing but said that would change as forensic officials identified bodies found by search teams. Firefighters still have not been able to fully put out the fires in a building where the explosion occurred Monday at a bakery in the city of San Cristobal, which lies just west of the capital of Santo Domingo. Anguished friends and family

have been pacing outside hospitals and morgues in anger and frustration, saying no one has been providing them information.

Meanwhile, authorities are probing what might have caused the explosion, vowing to crack down on any business that might not have been following regulations.

Ito Bisonó, minister of industry and commerce, told reporters that officials already have determined there were no tanks of any type in the area, adding that he is waiting on authorities to investigate what happened. "It was of great magnitude," he said of the explosion.

Bisonó spoke inside a cathedral in San Cristobal that held a service Wednesday for those who died, with mourners dressed largely in white filling the building to standing room only. (AP)

### China's Xi calls for patience as Communist Party tries to reverse economic slump

BEIJING, Aug 17 (AP): Chinese leader Xi Jinping has called for patience in a speech released as the ruling Communist Party tries to reverse a deepening economic slump and said Western countries are "increasingly in trouble" because of their materialism and "spiritual poverty."

Xi's speech was published by Qiushi, the party's top theoretical journal, hours after data on Tuesday showed consumer and factory activity weakened further in July despite official promises to support struggling entrepreneurs. The government skipped giving an update on a politically sensitive spike in unemployment among young people.

Xi, the country's most powerful leader in decades, called for China to "build a socialist ideology with strong cohesion" and to focus on long-term goals of improving education, health care and food supplies for China's 1.4 billion people instead of only pursuing short-term material wealth.

Since taking power in 2012, Xi has called for restoring the ruling party's role as an economic and social leader and has tightened control over business and society since taking power in 2012.

Some changes come at a rising cost as successful Chinese companies are pressured to divert money into political initiatives including processor chip development. The party tightened control over tech industries by launching data security and anti-monopoly crackdowns that wiped out billions of dollars of their stock market value.

We must maintain historic patience and insist on making steady, step-by-step progress," Xi said in the speech. Qiushi said it was delivered in February in the southwestern city of Chongqing. It is common for Qiushi journal to publish speeches months after they are delivered.

## First major jihadi attack since coup kills 17

NIAMEY (NIGER), Aug 17: Insurgents killed 17 soldiers and wounded nearly 24 in the first major attack in half a year against the army in Niger, where Western powers fear a coup by the elite presidential guard last month is weakening a rare ally against jihadi violence in West Africa's Sahel region. Niger was one of the last democratic countries in the region south of the Sahara and France and the US have about 2,500 military personnel there who were training Niger's forces. France also conducted joint operations with its former colony, but since the coup Paris and Washington have suspended military operations, giving the jihadis more breathing room. A military detachment was attacked Tuesday afternoon as it moved between the villages of Boni and Torodi in the Tillaberi region, the Ministry of Defence said on state television Tuesday. The wounded were evacuated to the capital, Niamey.

It was the first major attack against Niger's army in six months, a worrying sign of possible escalation, said Wassim Nasr, a journalist and senior research fellow at the Soufan Centre, a think tank.

"What we are witnessing today is both jihadi warring factions, the Islamic State group and (al-Qaida affiliate Jama'at Nusrat al-Islam wal-Muslimin), marking their territory because of the security void caused by the coup. This definitely should be seen in the context of the ongoing war between the two groups," he said.

Neighbouring countries are threatening military action against the coup, whose supporters said Wednesday that they would register volunteers to fight and help with other needs so the junta has a list in case it needs to call on people. One organiser, Amsarou Bako, claimed that the iunta is not involved in finding volunteers to defend the coup, although it is aware of the initiative. It's not clear how real the possibility of regional conflict is. Many Bazoum supporters have been silenced or gone into hiding, and rallies to support the president are quickly shut down by police. Several ministers and politicians from deposed President Mohamed Bazoum's regime have been detained since the coup, with humanrights groups unable to access to access them.

The West African regional bloc, ECOWAS, says it has activated a standby force" to restore order in Niger. Bako, one of the founders, told The Associated Press on Tuesday that a recruitment drive will launch Saturday in Niamey as well as in cities where invasion forces might enter, such as near the borders with Nigeria and Benin, two countries that have said they would participate in an intervention. ### Five Indian youths named among 2023 International Young Eco-Hero award winners

WASHINGTON, Aug 17: Five youths from India have been named among 17 teen environmental activists from across the globe to receive the 2023 International Young Eco-Hero Award who have taken initiatives to tackle the world's most pressing environmental challenges.

The young eco-warriors who were recognised for their efforts by the US-based non-profit organisation, "Action For Nature", are Eiha Dixit from Meerut, Manya Harsha from Bengaluru, Nirvaan Somany and Mannat Kaur from New Delhi and Karnav Rastogi from Mumbai.

The International Young Eco-Hero Awards programme recognises and encourages children and teens from ages 8 to 16 who have taken action towards solving the most critical environmental issues. The awardees are eco-conscious

youth who took the crucial steps to solve tough environmental problems. Winners of the International Young Eco-Hero Award are selected by a panel of independent judges, including experts in environmental science, biology, and education. For the past 20 years, "Action For Nature" has recognised 339 Eco-Heroes from 27 countries and 32 US states, a media release on Tuesday said.

All of this year's young climate champions are proving one thing loud and clear: the next generation

of leaders has arrived, and they're unleashing their power on a global scale to tackle the climate crisis head-on," said Beryl Kay, president of Action for Nature.

"The incredible accomplishments of this year's winners are more than just isolated projects they're changing lives and transforming communities for the better," he said. Dixit, who won first place in this year's competition has been growing saplings to protect the environment since she was 4.

Through the Green Eiha Smile Foundation, she and a group of volunteers have planted over 20,000 saplings, creating mini forests, parks, and green belts in her Indian city, providing shade and cleaner air. Dixit also established a plant bank at her home, using plants donated by people who can no longer care for them.

These plants are used to obtain cuttings and seeds, and other people may take these plants free of charge. "Age doesn't matter," said Dixit. "If the work is done with dedication and sincerity, then the biggest goal can be achieved," she said. Manya Harsha who won second place in the 8-12 year-old category has embarked on a mission to raise awareness about environmental issues and climate action.

Through her books, blog, and YouTube channel, "The Little Environmentalist", she aims to in-



spire youth to take action and become environmentally conscious. Manya engages in various activities such as walkathons, planting saplings, distributing seed balls, and organizing clean-up drives to make a positive impact on the environment. With over 5,000 sustainable bags distributed, 3,500 saplings planted, and 3,000 seed bombs thrown, she continues to work tirelessly to create a better future for the coming generations and to protect the earth for all.

"Don't wait for a superhero to lead the march," said Manya Harsha. "Be one! Today's children are tomorrow's future," said Manya.

Nirvaan Somany, who took second place in the 13-16 year-old category is the founder of "Project Jeans" to tackle the environmental

impact of the fashion industry, specifically the waste caused by discarded denim, while also addressing the needs of the underprivileged. He repurposes used jeans into washable and insulating sleeping bags for the homeless, reducing landfill waste and providing better protection from harsh weather conditions.

With 6,000 pairs of jeans collected and 800 sleeping bags distributed to date, Nirvaan's initiative has made a positive impact on both the environment and the lives of those in need.

"Mindless consumerism without consideration of the environmental impact is a huge problem with long-lasting ramifications," said Nirvaan. "Most people only think of financial cost when making purchasing decisions, and ignore the additional hidden costs, often at the expense of the earth's resources," he said.

Mannat Kaur won third place in the 13-16 year-old category. Her project aims to address water scarcity and carbon emissions associated with freshwater supply

and wastewater treatment. She has designed a system to collect, filter, and reuse greywater from households for non-potable purposes, thus conserving precious drinking water. The impact of her invention goes beyond individual households, and could potentially save thousands of litres of fresh water daily and reduce operational and infrastructure costs for the city's sewage treatment.

"India is facing an acute water crisis. We must reduce, recycle, and reuse potable water however we can," said Mannat. Karnav Rastogi, 13, who received an honourable mention in this year's competition is committed to raising awareness about and taking action to reduce plastic waste and combat climate change. He wrote two books, "Kartik, Daddy & Plastic: A Journey About Beating Plastic Pollution" and "Kartik, Mixie & Monster: A Journey About Ocean Pollution," to educate young people about the impact of plastic pollution and climate change, providing solutions to tackle these issues. "The report submitted was examined and it was found to be very generic in nature basically mentioning mostly the reactive approaches adopted in the matter than proactive measures taken to curb the menace of ragging. The commission is not satisfied with the report," a source told PTI.

Superiors ordered an inquiry against Chaudhary over the harassment and action was taken against him as per disci-



During his posting in Gujarat, Chaudhary assaulted a colleague on one occasion. In another incident, he withdrew money using a co-worker's ATM card, the official said.

The decision to sack him was taken based on the train killing incident, he

Chaudhary (34) is accused of gunning

down his senior officer, Tikaram Meena, and three passengers when the Jaipur-Mumbai Central Superfast Express was near Palghar station on the outskirts of Mumbai in the early hours of July 31.

The three passengers, Abdul Kadar Mohamed Hussain Bhanpurawala, Sayyad Saifuddin and Asgar Abbas Shaikh, were travelling in different bogies of the train. Chaudhary was later arrested by the Government Railway Police (GRP). The motive behind the chilling crime is still not clear.

Chaudhary first shot dead RPF Assistant Sub-Inspector Meena and a passenger in B5 coach with his automatic service weapon. He then gunned down another passenger in the pantry car of the train and one more traveller in S6

coach, according to GRP.

### Have engaged best lawyers in SC to challenge Article 370 revocation: Omar Abdullah other government will come, it will bring it


# Delhi HC questions DU's decision of admission to 5-yr law courses through CLAT, not CUET

NEW DELHI, Aug 17: The Delhi High Court on Thursday questioned the Delhi University's decision to admit students to the five-year integrated law course solely on the basis of the Common Law Admission Test (CLAT-UG), 2023.

The high court said when other central universities were taking admissions for the course on the basis of the Common University Entrance Test (CUET) UG 2023 introduced by the Ministry of Education (MoE), Delhi University was

"Under the National Education Policy, once the decision is taken by the Government of India, Ministry of Education that admissions are to be done in central universities only on the basis of CUET, then you are not special. Very sorry," a bench of Chief Justice Satish Chandra Sharma and Justice Sanjeev Narula said. The high court was hearing a petition challenging the decision of DU to grant admissions to the five-year integrated law course solely on the basis of CLAT-

The bench granted time to the counsel for DU to seek further instructions in the matter and file its counter affidavit in response to the petition before the next date of hearing on August 25.



affidavit is filed before the next date of hearing, the matter will be heard on the question of grant of interim relief," the bench said.

It also granted time to the counsel for Centre to file its reply to the plea and seek instructions in the matter.

During the hearing, the counsel for DU submitted that the varsity has started the five-year integrated law course this year only and if a stay is granted on the operation of the August 4 notification, the whole academic year will be wasted. He said no admission is being taking place as of now and only the notification has been issued and sought time to file a reply to the petition.

The DU's counsel stated that "the university will not issue any advertisement inviting applications for the five-year law course based on CLAT till the next NEW DELHI, Aug 17: After Skyroot

done through the CUET-UG, 2023. It said CUET-UG 2023 was introduced by the MoE for admission to all undergraduate programmes in central universities for the academic session 2023-24. Petitioner Prince Singh, a law student at Campus Law Centre in Delhi University, claimed that the university, while issuing the impugned notification, has imposed "wholly unreasonable and arbitrary condition" that the admission to fiveyear integrated law course shall be solely based upon merit in the CLAT- UG 2023 result, which is violative of the right to equality under Article 14 and right to education under Article 21 of the Constitu-

The plea said the condition lacks any intelligible differentia and has no rational nexus with the object of admission to the five-year integrated law course at the Faculty of Law. (PTI)

"Agnikul plans to complete its first flight in the coming few

# State govt should not be selective in remission, opportunity to reform be given to every prisoner: SC

NEW DELHI, Aug 17: State governments should not be selective in granting remission to convicts and the opportunity to reform and reintegrate with society should be given to every prisoner, the Supreme Court Thursday told the Gujarat government which defended its decision of premature release of all 11 convicts in the Bilkis Bano gang-rape case during the 2002 riots. The top court's observation came in response to the submission by Additional Solicitor General S V Raju, appearing for the Gujarat government, that law says a chance must be given to even the hardened criminals to reform themselves.

The law officer submitted the crime committed by the 11 convicts was "heinous" but does not fall in the rarest of rare category. "Therefore, they deserve the chance of reformation. Person may have committed the offence...Something may have gone wrong in a particular moment. Later, he can always realise the consequences.

"This can largely be determined from their conduct in jail, when released on parole, or furlough. All these show they have realised what they had done is wrong. Law is not that everyone should be punished perpetually. Chance should be given for reformation," Raju said.

Responding to the submission, a bench of Justices BV Nagarathna and Ujjal Bhuyan wanted to know how far the law is being applied to other inmates in jail.

"Why are our jails overcrowded? Why is the the policy of re-

mission being applied selectively? "Opportunity to reform and reintegrate must be given to every prisoner not only to few prisoners. But how far is remission policy being implemented where the convicts have completed 14 years? Is it being applied in all cases?" the bench

The ASG replied that all states will have to answer this question and that the remission policy varies from state to state. Commenting on the remission policy of states, the bench said

the question is whether the policy of premature release is being implemented uniformly in all cases in respect of all those who have completed 14 years and are eligible for it.

"On the other hand, we have cases like Rudul Shah. Even though there was an acquittal, he continued to remain in prison. Extreme cases, both this side and that side," the bench said.

Rudul Shah was arrested for his wife's murder in 1953 and was in jail for many years, in spite of his acquittal by a sessions court in June 3, 1968. He was finally released in 1982. The ASG submitted the opinion given by the CBI on remis-

sion of the sentence of the 11 convicts shows there was no ap-

The CBI had said the offence committed was "heinous, grave and serious" and hence the convicts "cannot be released pre-



maturely and no leniency may be given" to them.

Raju said,"They just narrate facts. Except for stating the offence was heinous, nothing is mentioned. Officer sitting in Mumbai has no knowledge of ground reality. Opinion of local police superintendent more useful than that of CBI officer in

"CBI's opinion has no application of mind. They have repeated the facts and said it's a heinous crime. What is the purpose of remission? Does committing a heinous crime debar you from getting its (remission's) benefit?" Raju said.

Moitra has also filed a PIL against the remission.

Bilkis Bano was 21 years old and five months pregnant when she was gang-raped while fleeing the horror of the communal riots that broke out after the Godhra train-burning incident. Her three-year-old daughter was among the seven family members killed in the riots. (PTI)

Historic soft landing on

Chandrayaan-3 is a follow-on mission to Chandrayaan-2 and its objectives are to demonstrate safe and soft landing on the lunar surface, roving on the moon, and to conduct in-situ scientific experiments. Chandrayaan-2 had failed in its lunar phase when its lander 'Vikram' crashed into the surface of the moon following anomalies in the braking system in the lander while attempting a soft landing on September 7, 2019. Chandrayaan's maiden

The lander has the capability to soft land at a specified lunar site and deploy the rover that will carry out in-situ chemical analysis of the moon's surface during the course of its mobility. The lander and the rover have scientific payloads to carry out experiments on the lunar surface. If the Chandrayaan-3 mission succeeds in landing a robotic lunar rover in ISRO's second attempt in four years, India will become the fourth country to master the technology of soft-landing on the moon's surface after the US, China and the former Soviet Union.

The race to the uncharted south pole of the Moon is also hotting up with Russia's Luna-25 also gearing up for lunar landings next week. The proximity, possible overlap, of their landing dates -- August 21-23 for Luna-25 and August 23-24 for Chandrayaan-3 -- has heightened excitement in the scientific community worldwide. Polar regions of the moon are a very different terrain due to the environment and the difficulties they present and therefore have remained unexplored. All the previous spacecraft to have reached the moon landed in the equatorial region, a few degrees latitude north or south of the lunar equator. The moon's south pole region is also being explored because there could be a possibility of presence of water in permanently shadowed areas around it.

"It(separation) is a great moment and this will imply how the lander is performing and the lander will be verified and tested and brought closer and closer to the moon. Then it will be given the required commands such that it takes over on the cue on August 23 to go all the way to the targeted place and have a safe and secure landing," Annadurai said. He said this is the beginning and all further milestones have to be seen very carefully.

"We have crossed major milestones from the launch vehicle and after that the propulsion system (separation)...now really the match starts. These are the final overs we are talking about. I think it is a great moment. The whole world is waiting to see what Vikram will do and what Pragyan will come out and do... I am also enthusiastically waiting." ISRO chairman S Somanath had recently said the most critical part of the landing is the process of bringing the velocity of the lander from 30 km height to the final landing, and that the ability to transfer the spacecraft from horizontal to vertical direction is the "trick we have to play" here.

The velocity at the starting of the landing process is almost 1.68 km per second, but this speed is horizontal to the surface of the moon. The Chandrayaan-3 here is tilted almost 90 degrees, it has to become vertical. So, this whole process of turning from horizontal to vertical is a very interesting calculation mathematically. We have done a lot of simulations. It is here where we had the problem last time (Chandrayaan-2)," Somanath explained.

The significance about Chandrayaan-3 mission, unlike its unsuccessful predecessor, is that the PM has a payload -- SHAPE -- Spectro- polarimetry of HAbitable Planet Earth which is to study earth from lunar orbit.

The ISRO said the SHAPE is an experimental payload to study the spectro-polarimetric signatures of the Earth in the near-infrared wavelength range. Apart from the SHAPE payload, the PM's main function is to carry the LM from launch vehicle injection orbit till lander separation. (PTI) Dengue outbreak: 45% positivity

### Delhi's plan to mitigate heat impact: No schools in afternoon, curb on non-essential water use

NEW DELHI, Aug 17: Delhi will alter school timings, suspend nonessential water use, provide uninterrupted power supply to health facilities and survey vulnerable locations daily to mitigate the impact of extreme heat on susceptible populations in peak summers, according to the city's new heat action plan.

The Delhi Disaster Management Authority (DDMA), which prepared the plan and submitted it to the Centre last month, also plans a pilot project to paint roofs in identified areas with white colour to help keep the indoors cooler.

The nodal officer, who will be responsible for the implementation of the heat action plan (HAP), is still to be appointed, a DDMA official told PTI.

Delhi is one of the hottest cities in India and ranks among the most susceptible to heat waves due to its large population and a significant concentration of lower-income groups. Heat waves are becoming more intense and frequent due to

### Antim Panghal one win away from 2<sup>nd</sup> World C'ship title, 2 more Indians in title contention

AMMAN (JORDAN), Aug 17: Unprecedented success followed India at the junior wrestling World Championships on Thursday with three grapplers, including fast-rising Antim Panghal, storming into the gold medal bouts while Harshita will fight for bronze.

Defending champion Panghal, who hit the headlines for challenging Vinesh Phogat for the Asian Games trials but lost her petition, put up a dominating show to win her three bouts with consummate ease. For the first time, four Indian woman wrestlers have reached the gold medal bouts at the World Championships as Savita (62kg) and Antim Kundu (65kg) also stayed unbeaten on Thursday.

Priya had reached the 76kg final on Wednesday and will fight for gold later in the evening while Harshita will fight for bronze in 72kg after losing her semifinal.

Panghal lost just two points en route the final, annihilating her first round opponent from Poland Nikola Monika Wisniewska in mere 68 seconds and followed that up with technical superiority win over China's Xuejing Liang.

In the semifinals, the wrestler from Hisar district of Haryana outplayed Russia's Polina Lukina, again winning by technical superiority, not losing a single point.

If Panghal can win on Friday, she will become first woman wrestler to win two world titles.

Another Antim was putting the mat on fire in 65kg competition. She was Antim Kundu from Titoli village in Rohtak District as she too put up a dominating show to secure a place in the gold medal

Using her tremendous power, she overpowered Russia's Ekaterina Koshkina in the semifinal, winning 7-5. Before that, the wrestler coached by Kuldeep Kadian, beat Romania's Maria Magdalena Pantiru 7-2 and pinned Poland's Alicja Nowosad.

In the 62kg category, U17 World Champion Savita produced inspiring stuff, winning all three bouts 'by fall', including one against formidable Japanese Suzu Sasaki. She had began with easy win over Serbia's Dunja Lukic.

In the semifinal she pinned French rival Iris Mathilde Thiebaux. Harshita also reached the 72kg semifinals but got pinned by Turkey's Bukrenaz Sert and

# Very easy to criticise team for T20I series loss but there were several positives: Ashwin

CHENNAI, Aug 17: The criticism of India's loss to the West Indies in the T20I series has not gone down well with veteran cricketer Ravichandran Ashwin who feels there were several positives as well despite the defeat.

India lost the closely-contested T20I series 2-3 after winning the Test and ODI series, but losing to a side that failed to qualify for the Super 12s during the 2022 T20 World Cup, has critics targeting Hardik Pandya's side.

"Obviously, after losing the series, many of them are criticising (the team) and (are) upset. It's understandable. But we can see this loss from two perspectives. Many players did well for India," said Ashwin on his YouTube channel.

Ashwin felt it's not easy for any youngster to go and perform on foreign soil straightaway.

"It is very easy to criticise the team on social media since they lost to a side that did not qualify for the last T20 World Cup (Super 12) and the 50-over World Cup (in India this year). In all countries, there will be some innate secrets (home advantage).

"Local players will know these little things more than the visiting team's players, especially when the visitors are youngsters. When I visited West Indies, England and Australia for the first time, I had to learn various little things," said

"So many youngsters would have



learned so many things when they toured the West Indies for the first time. They will become better as cricketers. They will definitely get better from here," he added.

Ashwin was all praise for young batter Tilak Varma, who emerged the highest run-getter in the T20Is, and opener Yashasvi Jaiswal.

"The emergence of Tilak Varma as a

batter (is positive). In the final T20I, he

chipped in with the ball, too. Suryakumar Yadav continued (his) brilliance in T20 cricket...his fearless batting.

"The opening combination of Shubman Gill and Yashasvi won us the fourth T20I. Jaiswal did not play well in his first T20I (third T20I of the series). (But later) his approach made us wonder if he is going

to be the future of T20I batting," said Ash-

"He went for the shots from the very first over. It was a breathtaking batting performance in the second game. We have so many youngsters in the pipeline."

Jaiswal scored just one in his debut T20I but in his second game (fourth of the series), he scored an unbeaten 84 and shared a 165-run stand with Shubman

Ashwin also complimented India opener Prithvi Shaw, who slammed a superb 244 as Northamptonshire defeated Somerset in the One Day Cup in England

Shaw backed it up with another impressive unbeaten hundred against Durham before a knee injury ruled him out for the rest of the season.

Ashwin hailed him as an "outstandingly

"I saw the boundary snippets from his knock. It really looked good, and that was an exceptional knock. We all know Prithvi Shaw's extraordinary bat swing, and he is an outstandingly talented player."

"Both (Cheteshwar) Pujara and Shaw have done really well. Pujara is going through an amazing run of form. This is giving valuable game time for both," he

"Really happy for Prithvi Shaw because he has seen plenty of ups and downs in his short career so far. So, for someone like him, away from home in England, seeing new players will be a bit of fresh air for

"He will have plenty of learning about his life, work ethic, cricket and what not (in England), because he will be in a position to teach a few youngsters in England as well. Even that can transform your cricket." (PTI)
