

HTBRIEF One held with heroin

BOKAJAN: In a significant operation, the police in Karbi Anglong successfully intercepted and recovered heroin from a fishmonger who was traveling on a bicycle from Dimapur. The incident took place at Lahorijan, a location situated on the Assam-Nagaland border under the jurisdiction of Khatkhati police station in Karbi Anglong. The police conducted the inspection after becoming suspicious of the fishmonger's route, as the particular route has a reputation for its involvement in drug smuggling. Upon examination of the fish containers being transported, the police discovered plastic soap cases containing powdery substances, suspected to be heroin, with a total weight of 12.90 grams. Md Sulman Ali (30), a resident of Meleka Dhing under Juria police station in Nagaon district, was arrested in connection with the case. He was identified as the fishmonger involved in the smuggling attempt. A case has been registered, and the investigation is currently ongoing. This incident marks a notable instance of a fishmonger being apprehended for engaging in contraband smuggling, shedding light on the need for vigilance and enforcement in tackling illegal activities in the region.

# Touch down near south polar region of Moon at 6:04 pm today Moon mission: Chandrayaan-3 gets ready to script history

BENGALURU, Aug 22: ISRO's ambitious third Moon mission Chandrayaan-3's Lander Module (LM) is all set to land on the lunar surface on Wednesday evening, as India eyes to become the first country to reach the uncharted south pole of Earth's only natural satellite.

The LM comprising the lander (Vikram) and the rover (Pragyan), is scheduled to make a touch down near the south polar region of the Moon at 6:04 pm on Wednesday. If the Chandrayaan-3 mission succeeds in making a touchdown on moon and in landing a robotic lunar rover in ISRO's second attempt in four years, India will become the fourth country to master the technology of soft-landing on the lunar surface after the US, China and the erstwhile Soviet Union.

Chandrayaan-3 is a follow-on mission to Chandrayaan-2 and its objectives are to demonstrate safe and soft-landing on the lunar surface, roving on the Moon, and to



conduct in-situ scientific experiments. Chandravaan-2 had failed in its

lunar phase when its lander 'Vikram' crashed into the surface of the Moon following anomalies in the braking system in the lander while attempting a touch down on September 7, 2019. Chandrayaan's maiden mission was in 2008.

The ₹ 600 crore Chandrayaan-3 mission was launched on July 14 onboard Launch Vehicle Mark-III (LVM-3) rocket, for a 41-day voy-

age to reach near the lunar south pole

> The soft-landing is being attempted days after Russia's Luna-25 spacecraft crashed into the Moon after spinning out of control. After the second and final deboosting operation on August 20, the LM is placed in a 25 km x 134 km orbit around the Moon. The module would undergo in-

ternal checks and await the sunrise at the designated landing site, ISRO has said, adding that the

powered descent -- to achieve softlanding on the Moon's surface -- is expected to be initiated at around 5:45 pm on Wednesday.

A day before the scheduled touch-down, ISRO on Tuesday confirmed that the Chandrayaan-3 mission is on schedule.

The space agency said the Mission Operations Complex (MOX), located at the ISRO Telemetry, Tracking and Command Network (ISTRAC) here, is buzzing with energy and excitement.

"The mission is on schedule. Systems are undergoing regular checks. Smooth sailing is continuing," ISRO said in an update this afternoon, adding that the live telecast of the landing operations at MOX/ISTRAC begins at 5:20 pm on Wednesday.

ISRO's Space Applications Centre Director Nilesh Desai said, "If any health parameter (of the lander module) is found abnormal on August 23, then we will delay the landing by four days to August 27." (CONTD. ON PAGE-9)

#### KA records 129 fresh dengue cases <u>HT Bureau</u> DIPHU, Aug 22: The number of

confirmed cases of Dengue in Karbi Anglong has shown no decrease, with a total of 129 new positive cases reported on Tuesday, according to recent data.

Despite efforts to combat vectorborne diseases, the figures for Dengue and JE remain consistent. This situation is in contrast to the overall trend of declining cases of vector-borne diseases like JE, malaria, and dengue compared to the previous year, as indicated by available data.

Last year during the same pe-riod, the Case Fatality Rate (CFR) for these diseases stood at 20.9%. However, this year, from January 1, 2022, to August 22, 2023, the CFR has significantly decreased to 5.5%. The reported cases of malaria have totaled 281, whereas dengue cases have risen to 3,651 as of August 22.

It's important to note that regions like Karbi Anglong and West Karbi Anglong, which have historically been susceptible to malaria infections, have experienced a substantial reduction in cases. Notably, there have been zero reported cases of malaria in these areas up to August 22. However, the decline in dengue cases hasn't been as pro-

**GUWAHATI, Aug 22:** AIUDF chief and Lok Sabha MP Badruddin Ajmal on Tuesday said that the Assam government should spread awareness against marrying more than once rather than imposing a legal ban on polygamy.

He emphasised that polygamy is not 'compulsory' in Islam and questioned what the state government has done for the welfare of Muslim women.

The Assam government has initiated a process for enacting a legislation to ban polygamy and had issued a notification on Monday seeking public opinion on the proposed law.

## Pijush assesses erosion threat on Biswanath-Panpur embankment



**HT Correspondent BISWANATH CHARIALI, Aug** 22: Pijush Hazarika, the minister of water resources, information, and public relations, conducted a comprehensive inspection of the historic Biswanath-Panpur embankment in the southern part of Sootea on Tuesday. The embankment, which spans from Biswanath Ghat in Biswanath to Panpur in the southern part of Jamugurihat, has recently been facing erosion threats caused by the mighty Brahmaputra River.

Minister Hazarika visited Kumalia, where erosion caused by the Brahmaputra River has posed a significant risk to the embankment and the adjoining areas. He carefully assessed the ongoing construction work on the embankment and took stock of the progress. Notably, a breach had occurred in the Kumalia and Solmari areas of the embankment, leading to concern among local residents due to the

continuous erosion and rising water levels of the river.

In response to the erosion threat, minister Hazarika promptly directed the chief engineer and additional chief engineer of the Water Resources Department to inspect the ongoing construction efforts. The duo has been stationed in Biswanath to oversee the construction works and implement preventive measures. Sootea MLA Padma Hazarika accompanied the minister during his visit.

To counteract the erosion, 10,000 geo-bags have been installed along the embankment to protect the vast area. Minister Hazarika addressed the media gathering and assured that the affected portion of the embankment would be widened and repaired in a timely manner. Assam flood scene: Over 43,340 affected in Dhemaji

GUWAHATI, Aug 22: The flood situation in Assam has taken a turn for the worse due to ongoing spells of rain across the entire state. According to an official bulletin from the Assam State Disaster Management Authority (ASDMA), the number of individuals affected across three districts has risen to

43,884 as of Tuesday. Among the districts facing the brunt of the flooding, Dhemaji remains the most severely impacted, with over 43,341 people affected by the rising waters. To address the

crisis, the administration has established nine relief camps and relief distribution centers in the affected areas. Currently, 97 villages are submerged, and approximately 1,673 hectares of crop areas have sustained damage throughout the state.

The floodwaters have also caused significant erosion in various districts including Biswanath, Bongaigaon, Dibrugarh, Lakhimpur, and Tinsukia. In Lakhimpur, key infrastructure such as embankments, roads, and bridges have been (CONTD. ON PAGE-9)




At a media briefing, Goyal announced that additional procurement of 2 lakh tonnes of onion for the buffer stock will be done at ₹ 2,410 per quintal, which he said is an "historical rate" and much higher than the average ₹ 1,800-1,900 per quintal the farmers normally get from exports. "Some political opponents have

been trying to present a wrong picture (about export curbs). I would urge all farmers in onion producing states not to worry and indulge in any panic selling. NCCF and NAFED have been directed to procure onion from farmers," Goyal said

On August 19, the central government imposed a 40 per cent export duty on onion to restrict outward shipments and boost the local availability amid apprehension about the kharif output and signs of firming of retail prices. It also decided to increase the size of the buffer stock of onion to 5 lakh tonnes for 2023-24 from the earlier 3 lakh tonnes which has already been procured.

The decision on export duty led to protests by farmers and traders in various parts of Maharasthra, especially in Nashik district. The National Cooperative Con-

## Price pressure in food items to be transitory: Fin min Elevated inflation warrant greater vigil



NEW DELHI, Aug 22: The finance ministry on Tuesday said price pressure on food items is expected to be transitory, with tomato prices seeing a decline, but the government and RBI need to step up vigil to deal with elevated inflationary pressure. Enhanced provision for capital expenditure by the government in the current fiscal is now leading to crowding in of private investment, and domestic consumption and investment demand would continue to drive growth going forward, said the ministry's Monthly Economic Review for July.

The consumer price index based retail inflation spiked to a 15month high of 7.44 per cent in July 2023, with specific food commodities mainly driving the increase. Core inflation, however, stayed at a 39-month low of 4.9 per cent.

"The government has already

ing months," the ministry said. Going forward, while domestic consumption and investment demand are expected to continue driving growth, global and regional uncertainties and domestic disruptions may keep inflationary pressures elevated for the coming months, warranting greater vigilance by the government and the RBI, it added.

Russia's decision to terminate the Black Sea Grain deal, along with dry conditions in major wheat-growing areas, caused the price spike in cereals. While domestic factors like white fly disease and uneven monsoon distribution exerted pressure on vegetable prices in India, it added.

During July, cereals, pulses and vegetables exhibited double-digit inflation compared to the corresponding period last year. Disruption in domestic production also aggravated the inflationary pressures. Interruption in the supply chain of tomatoes due to white fly disease in Kolar district, Karnataka and the swift arrival of monsoon in northern India caused a surge in tomato prices. Tur dal price also inflated due to deficient production in kharif season 2022-23, the ministry

till August 18, 2023 has been deficient by about 6 per cent compared to long period average. As on August 18, 2023, farmers have sown 102.3 million hectares, which is similar to the corresponding period last year's level and 1.1 per cent higher than the average of the last five years.

The monthly report from the finance ministry's Department of Economic Affairs further said that the agricultural sector is picking up momentum with significant advancement in monsoon and kharif sowing. The procurement of wheat and rice has been progressing well, increasing the buffer stock levels of

food grains to ensure food security in the country. With regard to investment, the report said the government's continued emphasis on capital expenditure is expected to drive growth in the coming years. The Union government in FY24 budget increased the capital outlay by 33.3 per cent, raising the share of capital expenditure in total expenditure from 12.3 per cent in 2017-18 to

22.4 per cent in 2023-24 (BE). ## Rupee rises 19 paise to close at 82.94 against US dollar

NEW DELHI, Aug 22: The rupee recovered from its all-time low levels and settled for the day higher by 19 paise at 82.94 (provisional) against the US dollar on Tuesday, as the American currency retreated from its elevated levels.

Forex traders said the rupee appreciated tracking a weak tone in the US dollar. However, selling pressure by foreign investors amid risk aversion in global markets dented sentiments

At the interbank foreign exchange market, the local unit opened at 83.07 against the US dollar and moved in a range of 82.93 to 83.09 in the day trade.

The rupee finally settled 19 paise higher at 82.94 (provisional) against the previous close.

On Monday, the rupee depreciated by 3 paise and settled for the day at an all-time low of 83.13 against the US dollar.

The Indian rupee appreciated on the weak US dollar and positive domestic markets. The decline in crude oil prices also supported the rupee, while selling pressure by foreign investors capped sharp gains, said Anuj Choudhary - Research Analyst at Sharekhan by BNP Paribas.

## Sensex, Nifty close flat amid profit taking in financials, IT shares

MUMBAI, Aug 22: Benchmark stock indices Sensex and Nifty closed flat after a volatile trade on Tuesday as investors booked profits amid concerns over potential rate hikes in the US and persistent foreign fund outflows.

The BSE barometer eked out gains of 3.94 points or 0.01 per cent to settle at 65,220.03. During the day, it climbed 146.82 points or 0.22 per cent to a high of 65,362.91.

The NSE Nifty inched up 2.85 points or 0.01 per cent to settle at 19,396.45.

"Despite the support of positive international markets, Indian equities struggled to maintain their upward momentum due to lingering apprehensions over ongoing global uncertainties," Vinod Nair, Head of Research at Geojit Financial Services said.

Sectors closely tied to the Western economy, such as IT and pharma, faced challenges, while domesticoriented sectors, alongside mid and small-caps, exhibited resilience and gained traction.

"The influence of higher bond yields and concerns about potential rate hikes in the US is prompting FIIs to withdraw funds from the domestic market, contributing to the market's volatility," Nair said.

From the Sensex pack, ITC, Mahindra & Mahindra, Wipro, Larsen & Toubro, Axis Bank, Tata Steel, Maruti and Bharti Airtel were the major gainers.

Jio Financial Services, Bajaj Finserv, State Bank of India, ICICI Bank, Tata Consultancy Services, HDFC Bank, Tech Mahindra and UltraTech Cement were among the laggards.

Shares of Jio Financial Services, the demerged financial services unit of Reliance Industries, listed on the bourses on Monday.

With the company's listing, BSE Sensex and NSE Nifty added Jio Financial Services to their pack. This has been done to ensure price stability and limit volatility in shares of Reliance Industries as part of



During July 2023, NFR has undertaken several initiatives to expand the handling capacity of stations and facilitate smoother transportation of goods.

As part of these initiatives, multiple stations have been designated for both inward and outward goods traffic, contributing to the ease of transporting a diverse range of commodities. The Dhamalgaon station under Tinsukia division is now operational for the handling of all goods traffic, including sand, ballast, coal, and crane consignments, with the exception of certain categories like POL (petroleum, oil, and lubricants), livestock, and explosives. This change came into effect from July 12, 2023. Similarly, the Lakwa station, also under Tinsukia division, has been assigned the task of handling inward iron and pipes consignments for a period of three months, starting from July 14, 2023. Previously, this station was operational for both inward and outward goods traffic, including coal and crane consignments, as of January 3, 2023. Enhancing the customer interface and expanding the network of operational terminals leads to increased loading and unloading of freight trains. As a result, the revenue of the North East Frontier Railway is expected to witness substantial growth in the upcoming years. ## Assamese musician joins London's Royal College of Music; SBI supports his education

GUWAHATI, Aug 22: "Nobody can choose music as a profession, it chooses vou," this is how child prodigy Gyaan Bhuvan on Tuesday described his journey into the elite Royal College of Music (RCM) in London

Hailing from a cultural family of Guwahati, the 19-year-old boy is one of the rare students from the Indian music tradition getting a chance to study at the one of the world's great conservatoires.

Having a gifted baritone voice, this western classical singer is in the second year of the Bachelors of Music and plans to join the Masters programme thereafter.

The country's largest lender State Bank of India on Tuesday announced to extend an education loan to Bhuyan for his studies at the RCM, opened in 1883 by the then Prince of Wales (later Edward VII).

"RCM is a highly selective institution. It

Bhuyan joined the RCM after completing his class 12 from a private school in Guwahati. He is one of the rare Indian talents, and first after several years, getting a coveted spot at the prestigious institute.

Talking about his journey in the field of music and eventually into the RCM, Bhuyan quoted Russian-American cellist Gregor Piatigorsky's words, "Nobody can choose music as a profession, it chooses you."

#### **Moon landing: Countdown begins**

ussia's first moon landing attempt since the 1970s failed on Sunday (August 20, 2023) as the Luna-25 lander crashed into the lunar surface after losing contact with Earth controls, said Russia's space agency, Roscosmos. Launched on August 11, Luna-25 was in a race with India to become the world's first mission to land in the lunar south pole region. But India now has the opportunity to place the first probe near the lunar south pole with its Chandrayaan-3 mission, launched on July 14 last. Chandrayaan-3, ISRO's highly ambitious mission, is in its final phase. The Indian spacecraft aims to achieve a gentle touchdown on the Moon's surface after a similar attempt by Chandrayaan-2 on September 7, 2019. It has chosen a lengthier-but more fuel-conserving-route to the Moon and its landing is scheduled for Wednesday. A successful Chandrayaan-3 mission would position India as the fourth nation to achieve the feat of softly landing a robotic lunar rover on the Moon's surface, following the US, China and the erstwhile Soviet Union. The mission, launched as a follow-up to Chandrayaan-2, aims to showcase the full process of safe landing and rover movement on the lunar surface.

On August 17, the Indian spacecraft had effectively detached the Lander Module, housing the Vikram lander and Pragyan rover, from the Propulsion Module. It successfully ad-justed its orbit to 113 km x 157 km on August 18, through effective deboosting after launch on July 14. India is poised to set a new record with a soft landing on the Moon's southern polar region. So far, soft landings have been accomplished exclusively in the Moon's equatorial zone by the US, China and Russia. Lunar missions have historically focused on the equator due to its favourable topography and operational circumstances. The southern polar area of the Moon poses distinct challenges owing to its markedly different terrain. India has chosen to explore the Moon's southern pole due to its larger expanse in comparison with the northern pole. The presence of water is a potential consideration in the perpetually shaded zones around this region.

The lunar South Pole experiences unique conditions, where the Sun remains close to the horizon, leading to temperatures surpassing 54°C during periods of sunlight. Despite the illumination, certain craters contain permanently shadowed areas that have remained devoid of sunlight for billions of years, causing temperatures to plummet to as low as -203°C. Despite employing sophisticated sensors, discerning the lunar south pole's terrain and appearance will be challenging for a descending vehicle due to the interplay of landscape and lighting conditions. The extreme and contrasting conditions found on the lunar south pole present difficulties for humans. Yet, they also hold the promise of containing valuable insights into the early solar system. Many government space initiatives and private organisations across the world are intrigued by this area of the Moon, as they believe it may contain water ice that could prove invaluable for future astronauts. From Chandravaan-3 to the Luna-25 mission and NASA's Artemis II. lunar exploration has consistently captivated space scientists for centuries. What drives the strong interest of major powers on the Moon?

It was the army who had encouraged Khan to mount massive street protests against Sharif's regime. But accustomed to attaining quick success by bat or ball in the cricket field and thereafter in politics, the former skipper of Pakistani cricket team


The upcoming BRICS Summit, set to convene in Johannesburg, South Africa, is being perceived as a positive indicator following the recent developments between India and China. Despite the ongoing standoff along the Line of Actual Control (LAC) in eastern Ladakh, China is exhibiting eagerness to reestablish regular bilateral relations with India. However, India remains steadfast in its position, asserting that the resolution of border issues is a fundamental prerequisite for normalized relations. External Affairs Minister S Jaishankar has reiterated this stance multiple times; underscoring that rectifying the border situation is a critical precursor to fostering normalcy.

Amid the latest round of discussions, China appears to be intensifying its efforts to decouple border deliberations from the broader bilateral relationship. Though there has been no official announcement from Beijing, a piece published in China's state-

statement. This article conveys the perspective that China and India are realizing the border issue does not define their entire relationship and that the border dispute should not impede the development of their ties. This perspective, potentially aimed at garnering global support for China's stance, might be further echoed by the Chinese foreign ministry in the lead-up to the BRICS Summit. China seems to be signaling that the responsibility for restoring normalcy in relations lies with India.

The prevailing reality places the responsibility squarely on China's shoulders. The absence of concrete progress in the recent dialogue stems from Beijing's hesitance to mend the situation along the border. India must assert this message in a unequivocal manner. It's encouraging that officials are disregarding the article as a vehicle for China's selfserving perspectives. There are signs that India is prepared to counter such an agenda from China if it becomes official. New Delhi should persistently reiterate to China that any notion of a "normal relationship" remains out of reach until normalcy is reinstated along the LAC. In forthcoming discussions, China must take the step of publicly declaring the restoration of the status quo ante as of April 2020.

This has been India's consistent stance, and it will continue to adhere to it in the future. The conflict at the border in 2020 led to a freeze in bilateral relations. While China characterizes the border tensions as a historical matter, it has advocated for segregating border discussions from the broader bilateral dialogue. However, India has firmly rejected this approach, asserting that the resolution of all LAC-related issues is a prerequisite for restoring normalcy in relations. China's eagerness to reestablish normal ties must be understood in the context of its economic strategy, aiming to access Indian markets and reinstate comprehensive trade to bolster its own economy. ## Jihadi outfits continue to pose grave danger to US, western nations

There is a growing perception that these are the last davs of the Islamic State and the United States and its allies war on terror has almost ended in Syria. But still, in one corner of Syria, Jihadists enjoy a safe haven and are even thriving. Hayat Tahrir al-Sham (HTS), formerly known as al-Nusra Front, once an al-Qaeda branch in Syria has totally consolidated its hold on Idlib province and literally operates as the de-facto state in the tiny statelet it created. HTS subscribes to the Salafist school of thought, which is the same as al-Qaeda's. The group imposed strict Islamic rule in areas it controls and is accused of grave human rights abuses including torture, forced disappearance, rape and other sexual

violence, and killing in detention. Also, Hayat Tahrir al-Sham hosts many foreign fighters including Arabs, Turks, Chechens, Uzbeks, and from China's Xinjiang province. Moreover, the group's attitude toward heterodox minorities like the Druze, Christians, and Alawites never changed. It will be right to say that HTS in Idlib province acts as a facilitator and provides an ecosystem for the jihadist forces to operate and regroup. But unfortunately, the policymakers in the West remain solely focused on defeating ISIS and have ignored HTS and its acolytes. Hayat Tahrir al-Sham in the

past tried to showcase through various mergers with other groups that it has ended its affiliation with al-Qaeda but definitely, these mergers did not indicate an ideological split with

-

al-Oaeda. But it was indeed part of a strategy to increase the group's appeal within Syria. On the ground in Syria, various smaller outfits proclaiming loyalty to al-Qaeda, including some HTS defectors. They came together and formed a group called Hurras al-Din (HD) also known as al-Qaeda in Syria. It was officially announced in late February 2018, although it existed sometime before that. It's the official branch of al-Qaeda in Syria and operates primarily in Idlib province. It will be erroneous to presume that Hurras al-Din somehow exists in isolation from HTS.

Given HTS' dominance of the Idlib Hurras al-Din cannot exist in isolation, nor can it undertake operations without HTS' knowledge. In fact, Hurras al-Din previously had multiple meetings with HTS. These meetings were in regard to a dispute over weapons in HTS custody that Hurras al-Din claims belong to it, and HTS suggestions to form a larger military council. Currently, Hurras al-Din still maintains a constant line of communication with HTS.

Previously in some credible media reports, there have been claims that certain frontline points manned by members of Hurras al-Din are supervised by HTS which is allegedly responsible for providing them with the logistics. Another major concern

is that at present, there are thousands of fighters who after being defeated on other fronts by Syrian government forces were allowed to move to Idlib. These fighters include those associated with al-Oaeda and the Islamic State while a significant number of them are prone to be radical Islamists. These fighters based in Idlib are seen as a very attractive source of recruitment by Jihadist outfits

The controversial HTS leader Abu Mohammed al-Jolani is listed as a specially designated global terrorist by the United States. And a reward of \$10 million for information leading to his arrest is still in place. Most of the leaders of ISIS also find refuge in Idlib. And it is evident from the fact that many of its senior and mid-level leaders were killed in the special operations of either the US or Turkey in Idlib including its founder leader Abu Bakr al-Baghdadi in October 2019.

Tahrir al-Sham claims to be cracking down on both al-Qaeda and Islamic State cells in its territory. But this claim seems to be a hollow one in fact it seems remnants of ISIS are now regrouping

in Idlib. As per the US Commission on International Religious Freedom report released in November 2022. HTS remains a potent source of Salafi-Jihadism that restricts the religious freedom of non-conforming Sunni Muslims and threatens the property, safety, and existence of religious minority groups such as Alawites, hristians, and Druze.

Idlib under Hayat Tahrir al-Sham remains a ticking time bomb that arguably poses a greater long-term threat to the region and Syria's stability. Now after one phase of the war on global jihad is over, another phase should start with the sole focus to finish off HTS. The West's own ability to tackle and contain Jihadist elements in northwest Syria is rather limited. This is because the West is excluded from the de-escalation framework in the region agreed between Turkey and Russia and is thus barred, among others, from using the airspace to launch precision strikes against the group

If the United States and its allies have to coordinate with Turkey and Russia in this regard it should be done without any hesitation. Because Tahrir al-Sham and its jihadi extremist network still pose one of the greatest long-term challenges for the US and other Western countries which are trying to eradicate extremists from Syria. Amid the confusion of Syria's kaleidoscopic and multi-sided conflict, one thing remains certain that Hayat Tahrir al-Sham must be isolated, marginalized, and defeated before a stable peace can emerge in Syria. # Abortion for survivors of sexual assault: What are the Delhi HC guidelines?

n 9 August, the Delhi High Court added two important guidelines for officers, doctors, and other authorities in cases of medical termination of pregnancy of sexual assault survivors. The court said:

The medical termination of the pregnancy is to be carried out with "utmost caution" by the medical professional involved.

The investigating officer must ensure that the survivor is taken to the hospital within 24 hours of receiving an order for the medical termination of the pregnancy and ensure that the foetus is preserved (whenever such an order is issued).

The HC issued these guidelines after a 14-year-old survivor of sexual assault and her mother moved court this year, seeking termination of the pregnancy of the minor. She was over 24 weeks pregnant in January.

However, in August, during the bail hearing of the accused in the case, the court found that despite an order, the termination of the pregnancy of the survivor was not done medically, leading to a loss of crucial evidence.

What are the guidelines when survivors of sexual assault choose to terminate their pregnancy? The Quint explains.

MTP (Amendment) Act, 2021: What Are the Provisions for Survivors of Sexual Assault?

The Medical Termination of Pregnancy (Amendment) Act, 2021 prescribes the rules and regulations for those seeking abortion. Under the Act, a woman is given the provision to ter- **They Say**?



minate her pregnancy up to 24 weeks of gestation, with their due consent or that of her guardian in case she is a

Among other reasons under Section 3 of the Act, there is a provision for the termination of pregnancy by a registered medical practitioner for survivors of sexual assault.

"Wherever the timeline is exceeded which is beyond 24 weeks and there is a minor or adult survivor of sexual assault, they will have to approach the high court seeking permission for the termination," Aishwarya Sinha, a senior social worker at iProbono, told The Ouint.

The Act is now to be read with the guidelines issued by the court.

the consent of both the survivor as well as the guardian.

Once the consent has been attained, the survivor must be presented before the medical board on the same day, the court has said.

Time Cap: The court has expressed this by directing the authorities that if an order is being sought for termination - especially in the case of the minor the report has to be presented before the authority concerned to fast-track the process and not lose out on time. Post this order, the survivor has to be taken to the hospital concerned within 24 hours. This applies irrespective of the gestation period.

Constitution of Medical Boards: The HC has asserted the need for the establishment of medical boards in government hospitals in all districts.

Currently, there are only four hospitals in Delhi where the medical board has been constituted in accordance with the MTP Act - namely, AIIMS, Dr Ram Manohar Lohia Hospital, Safdarjung Hospital, and Lok Nayak Jai Prakash Narayan Hospital.

The court has given the responsibility of the same to the state government/Union Territory.

Preservation of Foetus: It is the responsibility of the doctor in-charge to ensure the preservation of the foetus and to ensure that the patient is not re-

leased in a hurry. "After the termination is done the investigating officers have to collect the fetus, and then send the sample to the forensics laboratories to be matched with the DNA of the alleged accused person. It is a part of the medical evi-

case of minors, it is important to take dence and strengthens the case," explained Aishwarya.

'The DNA sample is only handed over to the investigating officer (IO)," added Shivangi Goenka, Lead Social Worker, Survivor Support Team, Counsel to Secure Justice.

Detailed Records by Doctors: The responsibility of the discharge sheet and post-procedure care have been given to the doctor in-charge. They must ensure it contains all the details. In case the survivor has been discharged without termination of pregnancy, the reason for the same has to be mentioned.

Medico-Legal Case Report: Along with this, the Delhi High Court has directed the doctors to ensure that with the original discharge sheet, a typed copy of the same has to be provided to the investigating officer within a week. MTPAct and Child Welfare Com-

mittee: How are minors being addressed? While the MTP Act has provisions for minors, there is also a Child Welfare Committee (CWC), constituted under the Juvenile Justice Act 2015, which helps minors with such procedures.

"It has become a customary practice in Delhi that the CWC writes an order requesting the IO to take care of the documentation as required, and also direct the hospitals, to take up the case; and make sure the procedures are done," says Shivangi.

The CWC only writes orders for MTP in cases where the gestation period is within the prescribed norms. "When the child is pregnant because

of abuse, the CWC issues guidelines to

the concerned hospital to facilitate the procedure at the earliest. This has been helpful so far. With the order, the children get treatment on priority, especially in government hospitals which are typically busy," shares Aishwarya.

The court recommends that while dealing with cases with minors, the doctors must reflect the highest standards of medical ethics, professionalism, and compassion and prioritise the well-being of the survivor.

It has also stressed the importance of post-procedure care and follow-ups in the case of minors to ensure that they are recovering emotionally and physicallv

MTP act & guidelines: are they enough?

Having worked with over 250 minors closely, who have been survivors of sexual assault, Aishwarya says she has found the provisions to be effective

"These guidelines, in my experience (with regard to Delhi), are effective and they have been followed. The practices are in place. And with CWC and bodies like these, there is a better system in place, because a child survivor of sexual assault can get help."

"Even after the termination procedure, the children continue to receive support from the CWC, or even the courts. There is a provision of interim compensation for children under the POCSO Act," says Aishwarya.

"We have seen in the cases where children get pregnant because of abuse, the courts are very prompt in granting the compensation which is required for the medical treatment," she further added. (Courtesy: The Quint)

strual cycle, and other changes may follow. Periods may continue for several years before menopause begins.

This time is known as perimenopause. Some people call it premenopause, but perimenopause is the standard term within the medical community. Some females do not experience perimenopause, instead moving straight into menopause. Undergoing chemotherapy, having surgery to remove the ovaries, and other factors can all cause hormone levels to fall rapidly or suddenly.

#### Premenopause vs. perimenopause

People sometimes use the terms premenopause and perimenopause interchangeably, but premenopause is not a scientifically accepted term.

The term "pre" means "before," while the term "peri" means "around." However, healthcare professionals use the word perimenopause to refer to the time before menopause. They do not use premenopause.

The two stages of menopause are perimenopause and postmenopause. Menopause is the point at which a female moves from one stage to the next.

In most cases, each stage is a gradual change that usually takes place over several years.

#### Perimenopause and beyond

It is not possible to pinpoint when perimenopause starts. For most females, it will be sometime around their mid-to-late 40s.

It usually lasts for around 4 years, but it can last for 2-8 years, according to the Office on Women's Health. During this time, the ovaries start reducing the amount of estrogen they produce.

The menstrual cycle will become variable and eventually stop completely. When no periods have occurred for 12 months, a healthcare professional will confirm menopause. In the United States, the average age at menopause is 52 years. However, the age range for this can vary widely. A female may know that they are starting perimenopause if their menstrual cycle varies by 7 days or more but they still have at least one period in 3 months.

#### During perimenopause, a female may

#### start to experience:

- a longer or shorter menstrual cycle
- · missing periods
- heavier or lighter periods
- hot flashes and night sweats
- sleep problems

• mood changes, including depression and anxiety

· vaginal dryness, leading to painful intercourse

#### Menopause

Menopause occurs when there have been no periods for 12 months. It is a moment of transition rather than a stage. At this point, the ovaries no longer release eggs, and estrogen production in the ovaries has fallen significantly.

The transition from perimenopause to postmenopause happens when a female stops ovulating.

However, experts point out that there is no clearly identifiable moment when this happens. They can only say that it occurs at some point during that transition.

#### Early postmenopause

When menstruation has not occurred for 12 months, early postmenopause begins. The following changes may occur

#### during this time:

- hot flashes and night sweats
- difficulty sleeping
- a reduced sex drive
- problems with thinking and memory
- vaginal dryness, leading to pain during
- headaches
- · mood changes
- an irregular heartbeat, or palpitations
- pain and stiffness in the joints
- · reduced muscle mass
- more frequent urinary tract infections If hormone levels change abruptly,
- menopause can start suddenly. This can happen naturally or as a result of surgery or another treatment.

#### Postmenopause

After around 3-6 years, most females enter late postmenopause, though this can vary widely. Vasomotor symptoms, such as hot flashes, can continue for several years. The symptoms of menopause usually resolve over time, but some changes may be long-lasting.

Lower estrogen and progesterone production can increase the risk of:

• osteoporosis, or weakening of the bones

- heart disease
- · weight gain
- · loss of muscle mass
- vaginal dryness
- a reduction in the size of the vagina
- and urinary tract, or urinogenital atrophy
- Falling estrogen and progesterone levels can trigger some of these changes, but aging may also play a role.
- Treating perimenopause symptoms
- At-home, over-the-counter (OTC), and medical treatments can help manage the physical and mental impact of menopause.
- Help for hot flashes

Hot flashes result when hormonal factors affect the circulatory system. These

According to one 2018 review, taking combined oral birth control pills may also help reduce the risk of:

- irregular periods
- heavy bleeding during menstruation
- · vasomotor symptoms, such as hot flashes

• ovarian, endometrial, and colorectal cancers

However, there is some evidence to suggest that these may slightly increase the risk of breast cancer, blood clots, and heart attack.

Females can ask a healthcare professional about suitable options.

#### **Medical treatments**

Hormone therapies can help some females manage hot flashes and other symptoms. These may contain estrogen, progestin, or a combination of these hormones. Some options combine estrogen with other drugs.

Hormone treatment is available in the form of pills, patches, vaginal rings, sprays, and more. A healthcare professional will look at the female's medical history and their symptoms to help them decide if hormone treatment is suitable for them. They will offer the lowest possible dose because hormone treatment can have adverse effects.

For example, it may increase the risk of blood clots, liver problems, and some types of cancer. Minor adverse effects include headaches, painful breasts, and fluid retention.

#### Postmenopause management

In most cases, the discomfort of menopause will resolve in time. However, some challenges may remain.

#### Some tips for staying healthy during postmenopause include:

getting regular exercise

- avoiding or quitting smoking
- consuming a nutritious and varied diet

 attending regular health checkups For specific problems, such as vaginal dryness, OTC treatments may help. If not, a healthcare professional may prescribe or recommend an alternative. Healthcare professionals can also advise on supplements, dietary measures, and lifestyle choices to help manage these risks as a female moves beyond menopause.

Perimenopause refers to the time before menopause, when hormone changes start to occur but menstruation is also still occurring. When perimenopause ends, menopause occurs and postmenopause follows. ## Trump says he will surrender Thursday on Georgia charges tied to efforts to overturn 2020 election

WASHINGTON, Aug 22: Former President Donald Trump says he will surrender to authorities in Georgia on Thursday to face charges in the case accusing him of illegally scheming to overturn his 2020 election loss in the state.

"Can you believe it? I'll be going to Atlanta, Georgia, on Thursday to be ARRESTED," Trump wrote on his social media network Monday night, hours after his bond was set at \$200,000. It will be Trump's fourth

arrest since April, when he became the first former president in U.S. history to face indictment. Since then, Trump, who remains the leading candidate for the Republican presidential nomination, has had what has seemed like an endless procession of bookings and ar-

raignments in jurisdictions across the country. His appearances in New York, Florida and Washington, D.C. have drawn enormous media attention, with news helicopters tracking his every move.

Trump's announcement came hours after his attorneys met with prosecutors in Atlanta to discuss the details of his release on bond. The former president is barred from intimidating co-defendants, witnesses or victims in the case — including on social media - according to the bond agreement signed by Fulton County District Attorney Fani Willis, Trump's defense attorneys and the judge. It explicitly includes "posts on social media or reposts of posts"

### Windows are shattered in a Moscow suburb as Russia says it thwarts latest Ukraine drone attack

MOSCOW, Aug 22: Russian air defence systems thwarted four nighttime Ukrainian drone attacks, Russia's Ministry of Defence said on Tuesday, with the falling wreckage of one drone shattering an apartment building's windows and damaging vehicles in Moscow's western suburbs.

There were no reports of injuries in the latest drone attacks that Russia blamed on Kyiv, as the war approaches its 18-month milestone.

Though the drone attacks on Russian soil have occurred almost daily in recent weeks, they have caused little damage. Even so, they have unnerved some Russians and are in line with Ukraine President Volodymyr Zelenskyy's pledge to take the war into the heart of Russia.

Flights at several Moscow airports were temporarily suspended on Tuesday as a security precaution amid the attacks, authorities said. I wo other drones were jammed and crashed in the western Bryansk region bordering Ukraine, the defence ministry said.

Trump has repeatedly used social media to attack people involved in the criminal cases against him as he campaigns to reclaim the White House in 2024. He has been railing against Willis since before he was indicted, and singled out Georgia Gov. Brian Kemp — a Republican who rebuffed his efforts to overturn the election - by name in a social media post Monday morning.

The agreement also prohibits the

former president from making any "direct or indirect threat of any nature" against witnesses or co-defendants, and from communicating in any way about the facts of the case with them, except through attorneys. The order sets Trump's bond for

the Racketeer Influenced and Corrupt Organizations — or RICO — charge at \$80,000, and adds \$10,000 for each of the 12 other counts he is facing. Bond is the amount defendants must pay as a form of collateral to ensure they show up for required court appearances.

Willis set a deadline of noon Friday for Trump and his 18 co-defendants to turn themselves in to be booked. The prosecutor has proposed that arraignments for the defendants follow during the week of Sept. 5. She has said she wants to try the defendants collectively and bring the case to trial in March of next year, which would put it in the heat of the presidential nominating season. (AP)

## Putin stays away over arrest warrant as leaders of emerging economies meet in South Africa

JOHANNESBURG, Aug 22: Russian President Vladimir Putin will be notably absent when Chinese President Xi Jinping and other leaders from the BRICS group of emerging economies start a three-day summit in South Africa on Tuesday.

The bloc, consisting of Brazil, Russia, India, China and South Africa, is holding its first in-person meeting since before the

COVID-19 pandemic, but Putin will participate via video call after his travel to South Africa was complicated by an International Criminal Court arrest warrant issued for him in March over the abduction of children from Ukraine. Xi, Brazilian President Luiz Inácio Lula da Silva, Indian Prime Minister Narendra Modi and South African President Cyril Ramaphosa will attend in person as the bloc -- home to 40% of the world's population and responsible for more than 30% of global economic output -- mulls a possible expansion.

That will top the agenda at Wednesday's main summit meeting in Johannesburg's financial district of Sandton. More than 20 nations have applied to join the bloc, according to South African officials, including Saudi Arabia, Iran and the United Arab Emirates. The five BRICS countries will have to agree on the criteria for new members before any countries are admitted, but a bigger BRICS is seen as a policy favoured by China and Russia amid their dete-

riorating relations with the West. The BRICS group was formed in 2009 by Brazil, Russia, India and China. South Africa was added in 2010. (AP)

In what could be perceived as a special treatment, officials said Thaksin has not yet received the severe crew cut associated with Thai prisoners.

"The rule for haircuts is they have to be crew-cuts. But if it's not too long, it doesn't need to be trimmed in a hurry. In prison, hair needs to be cut according to the rules but his hair won't be like other typical inmates: we have to also consider his age," said Ayuth Sintoppant, director-general of the Department of Corrections.

It isn't clear yet how long Thaksin will actually serve of his prison sentence. Officials have said he, like other inmates, can apply for a royal pardon from day

His daughter Paetongtarn Shinawatra, a key figure in Pheu Thai, posted family photos with Thaksin in the middle on Facebook with a message thanking people who went to the airport to welcome her father, saying "me and my family are very grateful."

## Pak Prez Alvi sacked secretary amid controversy to clear his name: Report

#### ISLAMABAD, Aug 22: Pakistan President

Arif Alvi's decision to sack his secretary after a controversy erupted about the signing of two key bills was made to clear his name. media reports said on Tuesday, as the dismissed official claimed innocence and sought an inquiry

President Alvi sacked his secretary Waqar Ahmed on Monday, a day after he said he did not personally sign the Official Secrets (Amendment) Bill, 2023, and the Pakistan Army (Amendment) Bill, 2023 and had instructed his staff to return them unsigned within the stipulated time to make them ineffective. The President's Secretariat said in a statement that Alvi asked for the replacement of Secretary Ahmed, whose services were "no more required". Ahmed's removal is being seen as a punishment for his alleged imp dence, but there was no direct reference to his involvement in the matter, the Dawn newspaper reported. Meanwhile, Ahmed called his removal from the post "not based on justice" and, in a letter, asked Alvi to reconsider his decision to remove the secretary from his post. Ahmed also urged the president to initiate an investigation into the matter through the Federal Investigation Agency (FIA) or any other agency to uncover any misconduct, The Express Tribune newspaper reported.

## Fukushima nuclear plant will start releasing treated radioactive water to sea as early as Thursday

TOKYO, Aug 22: Japan will start releasing treated and diluted radioactive wastewater from the Fukushima Daiichi nuclear plant into the Pacific Ocean as early as Thursday — a controversial step that the government says is essential for the decades of work needed to shut down the facility that had reactor meltdowns 12 years ago.

Prime Minister Fumio Kishida gave the final go-ahead on Tuesday at a meeting of Cabinet ministers involved in the plan and instructed the operator, Tokyo Electric Power Company Holdings, to be ready to start the coastal release on Thurslay if weather and sea conditions



cooling water. The water, now amounted to 1.34 million tons, is collected, filtered and stored in about 1,000 tanks, which fill much of the plant's grounds and will reach their capacity in early 2024. The release of the treated wastewater has faced strong opposition from Japanese fishing organisations, which worry about further damage to the reputation of their seafood as they struggle to recover from the nuclear disaster. Groups in South Korea and China have also raised concerns, turning it into a political and diplomatic issue.

than international standards TEPCO plans to release 7,800 tons of treated water in the 17-day first round of the release, Matsumoto said. TEPCO plans to release 31,200 tons of the treated water by the end of March 2024, which would empty only 10 tanks at the site. The pace will pick up later.

The seawater and marine life will be tested and the results will be disclosed on government and TEPCO websites.

The International Atomic Energy Agency in a final report in July concluded that the release, if conducted as designed, will cause negligible impact on the enviro and human health. After taking into possible bioconcentration of lowdose radionuclides that still remain in the water, the environmental and health impact is still negligible, TEPCO officials said. Scientists generally support the IAEA view, but some say long-term impact of the low-dose radioactivity that remains in the water needs attention. Kishida's government has stepped up outreach efforts to explain the plan to neighbouring countries, especially South Korea, to keep the issue from interfering with their relationship. Kishida said the effort has made progress and the international society is largely responding calmly to the plan. Still. Hong Kong said it would suspend exports from Fukushima and nine other prefectures if Japan went ahead with the plan, while China has stepped up radiation testing on Japanese fisheries products, delaving customs clearance.(AP)

"The President is fully aware of the facts surrounding both bills," he said. Under Article 75 of the Constitution, the president has to approve a bill within ten days, and under the same provision, he can send back a bill to the Parliament for reconsideration within the same amount of days. (PTI)

### Dubai International Airport sees 41.6 million passengers in first half of year, more than in 2019

DUBAI, Aug 22: Dubai International Airport, the world's busiest for international travel, announced on Tuesday it served 41.6 million passengers in the first half of this year — exceeding figures for the same period in 2019 as travellers return to the air after the lockdowns of the coronavirus pandemic.

The airport, home to the long-haul carrier Emirates in skyscraper-studded Dubai, long has served as a barometer for the aviation industry worldwide. The new figures at the airport known as DXB reflect figures offered by the International Air Transport Association that traffic worldwide is at 94 per cent of pre-COVID levels.

"Dubai International Airport has once again recorded for the ninth year running that it is the world's busiest international airport with a very, very strong first half," Paul Griffiths, the CEO of Dubai Airports, told The Associated Press.

"The most important part of that is that we've reached 100 per cent of our pre-pandemic numbers, the same numbers as recorded in the first half of 2019."

The 41.6 million passengers is up some 50 per cent from the 27.9 million recorded the same time last year, as airlines now have more planes and routes running again. Passenger traffic this year largely has been driven by the airport's standard travel destinations -India, Saudi Arabia, the United Kingdom and Pakistan. Russia has also been a major market as Dubai remains one of the few places still open to Russians amid Moscow's war on Ukraine.

Dubai was among the first cities to reopen to tourists in the pandemic. That helped boost the city-state's tourism industry, as attractions like the Burj Khalifa, the world's tallest building, and the sail-shaped Burj Al-Arab luxury hotel draw both visitors and transit passengers out of airport lounges.

Dubai surpassed its pre-pandemic, half-year tourist figures this year with 8.55 million international visitors. Dubai hotels saw an average occupancy of 78 per cent during that period - ranking among some of the world's top destinations.

"What happened pre-pandemic is we saw 60 per cent transit and 40 per cent point to point, but that's actually reversed," Griffiths said. "What we're now seeing is 60 per cent of that traffic number is point to point and 40 per cent is transit. So that's a very notable statistic and underpins the appeal of Dubai as a very, very strong tourist destination.

Hartsfield-Jackson Atlanta International Airport remains the planet's busiest passenger airport overall.

Emirates also saw its most profitable year ever in 2022, earning USD 2.9 billion as passengers returned to its long-haul Boeing 777s and its double-decker Airbus A380s. The return of the A380 has seen the average number of passengers per flight jump at DXB to 214, Griffiths said. (AP)

WASHINGTON, Aug 22: Overriding the Biden administration's appeal, a US court has ordered a stay on the extradition of Pakistani-origin Canadian businessman Tahawwur Rana, to India where he is facing a trial for his involvement in the 2008 Mumbai terror attacks. Rana, 62, has appealed before

the Ninth Circuit Court against the order by a US District Court in the Central District of California that denied the writ of habeas corpus.

District Judge Dale S. Fischer of the US District Court in Central California in his latest order said that Rana's "ex parte application" seeking a stay on his extradition is granted.

"The extradition of Rana to India is stayed pending the conclusion of his appeal before the United States Court of Appeals for the Ninth Circuit," Judge Fischer said in the order issued on August 18. In doing so the judge overrode the government's recommendations that there should be no stay on Rana's extradition. Rana faces charges for his role in the Mumbai attacks and is known to be associated with Pakistani-American terrorist David Coleman Headley, one of the main conspirators of the 26/11 Mumbai attacks.

While the Court does not find that Rana "has made a strong showing that he is likely to succeed on the merits" – otherwise the Court would have ruled in his favour in the first instance – he has

certainly raised serious legal questions going to the merits, the judge wrote."The proper meaning of "offence" in Article 6(1) of the extradition treaty is not clear and different jurists could come to different conclusions. Rana's position is certainly colourable and could very well be found to be correct on appeal," the judge noted.

'The final two factors "merge when the Government is the opposing party." There is value in compliance with India's extradition request, but Rana's extradition proceedings have been going on for more than three years, which suggests that the process has not been rushed so far. Otherwise, the public interest, if anything, favours Rana," the judge wrote.

"The public has a strong interest in the proper interpretation of extradition treaties, particularly in the interpretation of provisions that provide important individual protections like the one at issue here.

Further, there is a strong public interest in definitive, binding interpretations of treaties. District courts cannot provide those rulings; courts of appeals can," the judge wrote, throwing the legal battle to the Ninth Circuit Court now

The US Court of Appeals for the Ninth Circuit has asked Rana to submit his argument before October 10 and the US Government has been asked to submit its response by November 8. Judge Fischer

wrote that Rana has shown that he is likely to suffer significant irreparable harm absent a stay. He will be extradited to India for

a trial on serious crimes with no hope for a review of his arguments or hope for his return to the United States. The government admits this, but then argues that because "this claimed irreparable harm applies categorically to any fugitive who seeks a stay of extradition

pending appeal," it does not count,

**NEW DELHI, Aug 22:** Noting that many Manipur residents may ures to the victims, the first and have lost their identity documents in the ethnic strife, a Supreme Court-appointed panel has urged the top court to pass a slew of directions to the state government and others including the UIDAI to ensure Aadhaar cards are made available to those displaced and the victims' compensation scheme is broadened.

The all-women committee headed by Justice Gita Mittal that also comprises Justices (retd) Shalini P Joshi and Asha Menon, submitted three reports to the apex court on personal documents of the displaced persons, Manipur Victim Compensation Scheme, 2019 and appointment of domain experts to facilitate its functioning.

The panel has been constituted to oversee relief and rehabilitation of those hit by ethnic violence in the border state. The panel of former women judges was constituted days after the apex court had termed as "deeply disturbing" the video of women being paraded naked in the state.

Three separate reports, which were shared with the counsel concerned on Tuesday in pursuance of the apex court's directions, were filed before a bench headed by Chief Justice D Y Chandrachud.

The Justice Mittal panel said among the several gaps, which could impact reaching the benefits ures to the victims, the first and foremost would be "non-availability of documents for identification which would include Aadhaar I-card/ration cards. voter cards/BPL cards etc.

It said enquiries have revealed that out of all the above documents, the process of obtaining a copy of the Aadhaar Card may be the simplest as the Unique Identification Authority of India (UIDAI) has all the necessary information available in digital format

The panel has sought directions to the deputy director general, UIDAI, regional office, Guwahati as well as the secretary, department of home affairs, Manipur to jointly take all steps to ensure availability of Aadhaar card to the displaced persons whose records are available with Aadhaar authorities.

"Direct the secretary, department of finance to issue appropriate instructions to all Banks in the effected parts of Manipur to make available the details of the bank accounts held by the displaced persons to them. If necessary, the Banks should depute responsible staff members to visit the relief camps and interact with the displaced persons, ensuring continuity of banking service to them," it

## **Manipur Guv finally** summons Assembly session on August 29

IMPHAL, Aug 22: Manipur Governor Anusuiya Uikey finally summoned session of Manipur Legislative Assembly on August 29 barely a day after the state cabinet once again recommended summoning the session. A notification of the Manipur Assembly Legislative Assembly secretariat issued today said that the Governor summoned the session quoting the order of the Governor.

"In exercise of the powers conferred by Clause (1) of Article 174 of the Constitution of India, I, Anusuiya Uikey, Governor of Manipur, hereby summon the 4th session of the twelfth Manipur Legislative Assembly to meet at 11 am on Tuesday, the 29th August, 2023 in the Assembly Hall, Imphal," the order of the Governor said

Earlier, the state Cabinet in its meeting on Monday (August 21), once again, had recommended to the Governor to summon the monsoon session of the state assembly on August 29, an official said. The state cabinet had to re-recommend the Governor as she failed to summon the session even as the state cabinet, in its one of the meetings held on August 4, recommended summoning the session on August 21 with the best reasons known to the government only

The summoning of the Assembly session came amid the allegations from the Congress that there was a constitutional crisis in the state when the Governor failed to convene the session despite a recommendation by the state cabinet and time for summoning the normal session had already lapsed. Citing rules under procedure and conduct of business of the state As-

sembly, Manipur Pradesh Con-



dent K Meghachandra had said that for convening the normal session which is mandatory to convene once in six months, the members are to be notified at least 15 days ahead of the scheduled session.


He had also observed that as the last session of the state Assembly concluded on March 2, as per norm, the Governor has to notify the summoning of the session on or before August 16. However, it was not done.

## Nagaland min calls for collective efforts to address pressing issues in Mon

DIMAPUR, Aug 22: Nagaland health and family welfare minister P Paiwang Konyak called for extraordinary efforts, collaborative manpower and collective action to address and resolve the pressing issues of escalating cases of dengue, scrub typhus, conjunctivitis and broader concerns of the fight against drug abuse, maintenance of law and order and road infrastructure in Mon district bordering Myanmar

Konyak called an urgent coordination meeting with the district administration, health department, Assam Rifles and civil society organisations at Mon deputy commissioner's office on Monday to address these issues.

In his address, Konyak highlighted the alarming rise in cases of scrub typhus and dengue in Mon. He pointed out that scrub typhus is curable at its initial stages, but dengue has no specific medicine and its treatment is based solely on symptoms such as severe vomiting and headache.

Konyak stressed the importance of sanitation programmes, including mass social initiatives and regular waste collection, to combat dengue. He called upon the district administration to communicate directives through NGOs and church bodies

Apart from dengue and scrub typhus, conjunctivitis has become a contagious disease of concern, particularly affecting Tizit and Mon area in the district.

It was decided, with the consent of those present, to grant a one-week holiday to schools to contain the spread of conjunctivitis in the district.



Konyak sought assistance from Assam Rifles. Red Cross and NGOs in providing volunteers to support nurses and doctors in managing the situation

On the war against drugs, he reminded of the pledge taken by citizens on August 15. He inquired about the steps needed to fulfill that pledge.

Konyak noted that these drugs are not locally manufactured but imported, making it crucial to thoroughly inspect and curb their infiltration at border areas. He urged the NGOs, district administrations in this regard.

He also proposed a rehabilitation programme for government servants addicted to drugs, allowing them three to four months to recover.

He underlined the importance of scrutinising all borders, constructing rehabilitation centres and conducting blood tests of inmates to prevent the spread of diseases like AIDS and HIV. Addressing concerns related to law and order, Konyak called for strict actions against the disruption of law and order. To enhance security, he proposed the installation of CCTV cameras in all border and sensitive areas to improve surveillance.

On road infrastructure, he called for coordinated efforts between the departments responsible for national highways and town roads under the state roads and buildings department. He directed these departments to expedite road repairs in the district.

## the Indo-Naga Framework Agreement: NSCN-IM

Kuki-Zo demands may face risk direct collision with

DIMAPUR, AUG 22: The NSCN-IM bulletin, Nagalim Voice, in its latest edition released on Tuesday, asserted that the "grandiose dream for Zalengam faces the risk of coming into direct collision with the Indo-Naga Framework Agreement" signed between the Government of India and National Socialist Council of Nagalim (NSCN-IM). The NSCN-IM bulletin also said that "Nagas are not oppose to Separate Administration for Kuki-Zo community but it should not touch even an inch of Naga territory for creating separate administrative zone for them".

The latest edition of Nagalim Voice made available to Newmai News Network today by the Ministry of Information and Publicity (MIP) of NSCN-IM said the never ending Meitei-Kuki ethnic turmoil in Manipur is going the way driving the Kuki-Zo community to an unprecedented geopolitical identity crisis in the midst of the vast scale of devastation, charges and countercharges of committing crime against humanity, unparalleled in this 21st century in Northeast". The NSCN-IM mouthpiece added, "Amidst the acrimonious upheaval, the Kuki-Zo are desperately trying to re-construct their social-political and psychological standing from the cobwebs of ethnic violence". It further added, "It was under this sticky situation that Zalengam agenda, that was conceived years ago, surfaced and exploded with catastrophic effects"

In the present context of Meitei-Kuki ethnic conflict, identity means who the Kuki-Zo are as members of socio-political groups in Manipur and how others perceive and label them and how the Kuki-Zo people have been preparing for Zalengam (Kuki- Zo nation) for years through falsehood and concoction of history, the Nagalim Voice also said. "How this is going to be easier said than done as the grandiose dream for Zalengam face the risk of coming into direct collision with the Indo-Naga Framework Agreement" signed between the Government of India and National Socialist Council of Nagalim(NSCN-IM), it stated.

According to the Nagalim Voice, to further their case, the Kuki-Zo leaders went for desperate campaign to establish their ethnic identity. Faced with terror and trepidation in the hands of Meiteis and state police forces, the Kuki-Zo intellectuals hurriedly organised themselves under the nomenclature of World Kuki-Zo Intellectual Council (WKZIC) to present their ethnic root and socio-political status on the strength of their concocted history before the Prime Minister of Israel Netanyahu claiming themselves as descendant of Joseph (one of the lost tribes of Israel). Similar memorandum also submitted to the UN. The two memorandums pleaded for help in establishing Kuki state (Zalengam), the NSCN-IM bulletin also stated.

Aggravating as it is, the Zalengam plan that was leaked out to the media stated that Zalengam-Kukiland has to be propagated by means of concocting the history to brainwash the Kuki-Zo people and others into believing the Zalengam/Kukiland/Zogam ideas, the NSCN-IM bulletin also said. "For this purpose, fund has to be generated by indulging in drug trading and promoting poppy cultivation. To justify their claim, they have to go for demographic engineering for total area domination and concoct the Anglo-Kuki War, to lend some kind of weight and legitimacy towards creating the Zalengam. But to the many with clear historical knowledge Anglo- Kuki War was found to be nothing less than a misnomer, a claim that finds no historical support/evidence," the NSCN-IM mouthpiece added.

In what can be termed as turning blind eyes to "political correctness", when the situation is going through vulnerable stage, NSCN's name was brought forth by WKZIC as "cessationist militant group" linked with "Ethnic Cleansing", "Kuki genocide", it also said. This offensive (provocative) style of using NSCN's name rendered WKZIC's salvo against NSCN unpalatable as these words are quite toxic and WKZIC made veiled reference to NSCN without having the courage to see through the prism of historical context, the Nagalim Voice further stated. The recorded historical fact, however said it was the Kuki group KNA (Kuki National Army) that placed themselves at the disposal of the government of India as mercenary forces to finish off the Naga political movement within five years, it also stated. "This indelible record will stand as a testimony to prove who the Kuki- zo are against the Nagas, despite their fabricated defence of their ancestry and historical narratives," the NSCN-IM bulletin further added.

By using "cessationist militant group NSCN", the World Kuki-Zo Intellectual Council (WKZIC) proved themselves ignorant of the historical truth of Naga history and political rights as a people and as a nation, it also said. "That Nagalim was never an integral part of India either by conquest or consent is a matter of historical record, acknowledged by the Government of India when it officially granted recognition to the unique history of the Nagas in the Indo-Naga Joint Communique, Amsterdam (Netherlands) July 11, 2002 and followed by signing the historic Framework Agreement on August 3, 2015, giving recognition to the sovereign identity of the Nagas on the basis of the unique history of the Nagas," the NSCN-IM bulletin pointed out. The bulletin then said that to claim Zalengam or Kuki state on the basis of concocted history is dangerous in today's context. To use "Ancestral lands" without historical indigenous support are sensitive words and cannot be used for "ancestral glorification" as it involves geopolitical risk, the NSCN-IM bulletin also said. "Poisonous concoction" of history will never find universal acceptance, however impressive it is presented. Such "repulsive concoction" and "bewildering historical claim" will not stand the test of historical scrutiny, the NSCN-IM bulletin added.

# Vice prez Dhankhar says parliamentary disruptions matter of concern

JAIPUR, Aug 22: Commenting on parliamentary proceedings today, Vice President Jagdeep Dhankhar on Tuesday said the Constituent Assembly faced no disruptions "even for a single day" though it debated more complex issues. Speaking during a programme at Sainik School in Rajasthan's Chittorgarh, he noted that parliamentary disruptions in the present times is a mater of concern.

"As the chairman of Rajya Sabha, I express my pain. The Constituent Assembly that gave us the Constitution held several meetings for around three years. The issues before it were divisive and complex as compared to the matters in the present, but all those were solved by deliberations," Dhankhar said.

'There were no disturbances in the Constituent Assembly even for a single day or moment. In that context, if I see today's condition,



it is a matter of concern and contemplation," he rued.

The vice president also hailed the Indian judicial system and said no one should be allowed to act as a loose cannon and secure justice by taking to streets

"The tendency to take to streets to secure justice without availing justice as prescribed by law will lead to anarchy. Our judicial system is very ro-

bust. In recent days, important judgments have been delivered with impartiality. There is no reason that our faith in institutions should shake

We cannot give the right to anybody to run down the credibility of institutions," he said.

He said India is rising and by the turn of this decade, it will become the third largest economy of the world. Dhankhar, who did his schooling from Sainik School, Chittorgarh, urged the students to always keep national interest above anything else.

"It is not an option. This is the only way. We cannot compromise our national interest. We should always be a proud In-

dian." he said. He also asked them not to have

fear of failure and that they should be disciplined

Recalling his school days, he said studying in Sainik School was like a "rebirth" and that he owed whatever he has achieved in life to the school and its teachers. (PTI)

## Congress will conduct caste census in MP after winning assembly polls: Kharge

SAGAR, Aug 22: The Congress will conduct a caste census in Madhya Pradesh after winning the assembly polls in the state, said party president Mallikarjun Kharge on Tuesday, accusing the regime at the Centre of wishing to change the Constitution.

He was addressing a public rally in Sagar in MP's Bundelkhand region.

Assembly polls are expected to be held in the BJPruled state at the end of the year.

"Some people are trying to change the Constitution. This is not possible because 140 crore people of the country are in support of the protection of the Constitution," Kharge said remembering Dr BR Ambedkar, who was born in MP's Mhow.

Kharge criticised the ruling BJP for "remembering" Sant Ravidas, a revered figure for Scheduled Castes, during elections

Prime Minister Narendra Modi recently laid the foundation of a ₹ 100 crore memorial-cum-temple of Sant Ravidas in Sagar district.

As per the 2011 Čensus, the population of Dalits in MP was 1.13 crore.

"Modi ji is in power for the last nine years while Chouhan (chief minister Shivraj Singh Chouhan) is ruling the state for the last 18 years. They remembered Ravidas only at the time of the polls," Kharge said. Citing a newspaper report, Kharge claimed that the BJP demolished a temple of Sant Ravidas in Delhi. He announced that the Congress will set up a university in the name of Sant Ravidas in Sagar district if voted to power in Madhya Pradesh.

Kharge also said that Congress will conduct a caste-



based census in MP after returning to power. Referring to the crisis in Manipur, Kharge accused PM Modi of not doing "anything" to control violence in the northeastern state.

He also alleged that the BJP government has not implemented the Bundelkhand package approved on the recommendation of the senior Congress leader Rahul Gandhi

Bundelkhand, in north-east MP, has six assembly seats reserved for SCs, and the BJP had won five of them in the 2018 state polls, namely Bina, Naryoli, Jatara, Chandala and Hatta, while the Congress managed to get Gunnor.

Bundelkhand comprises Sagar, Chattarpur, Tikamgarh, Nimari, Damoh and Panna districts, with 26 assembly seats, of which 15 were won by the BJP in the last state polls, while the Congress got nine and one each was won by Samajwadi Party and Bahujan Samaj Party. (PTI)

## Residents of Raj'n should focus on making it Country's leading state by 2030: Gehlot JAIPUR, Aug 22: Lauding Ra- A total of 1.4 lakh kilome

jasthan's progress in all sectors, including health and education, chief minister Ashok Gehlot on Tuesday said every resident should focus on making it the country's leading state by 2030.

Speaking at a programme to "Rajasthan-Mission launch 2030" at the Birla auditorium here, the chief minister said the 'Mission 2030' should be on everyone's agenda.

Gehlot said under this initiative, views will be sought from people across all sections, subject experts, students, businesses, traders, intellectuals and employees till September 15 to prepare the "Vision 2030" document for Rajasthan by the end of the month.

"The idea of 'Mission 2030' came because we have come to such a situation today where we have progressed a lot. We are to exploit several minerals available here. Crude oil is being explored and a refinery is being set up in Barmer. We are ahead in sectors of education and health," he said.

Gehlot added that Rajasthan was fast surpassing Gujarat in road construction and an excellent network of roads and highways is being laid in the state.

A total of 1.4 lakh kilometres of roads has been laid in the last

five years, he added. "This mission is for all residents of Rajasthan, be it students, authors or opposition parties. This is not a personal agenda, it should be everyone's agenda," he said

Around 50 years ago, Gehlot said, famines and water crises were frequent but now, things have changed and the state has progressed.

"What do we not have here in Rajasthan? IIT, IIM and IIIT are there. Medical colleges are being set up in every district. We are ahead in education and medical services," he said.

The chief minister said, "It is the duty of everyone to dream and that is why we have launched this to dream of Rajasthan's future.

He also targeted the Centre on the occasion for not giving a national project status to the Eastern Rajasthan Canal Project (ERCP). If the Centre is obstinate, then "I am also determined to complete the ERCP project in the state", Gehlot added. He urged people from all

## 27 cases of non-compliance by govt depts to punish corrupt, maximum by railways: CVC



NEW DELHI, Aug 22: Government departments have differed from the Central Vigilance Commission's advice to punish corrupt officials in 27 cases, a maximum of seven such instances by the Ministry of Railways alone, according to an official report.

There were three cases of non-compliance of the CVC's advice to act against the corrupt officials by theCC (India) Ltd and two each by the State Bank of India, Coal Ministry and Nuclear Power Corporation of India Ltd, it said.

One each such case was by the Delhi Jal Board, Delhi Transco Ltd, Delhi State Industrial and Infrastructure Development Corporation (DSIIDC), Ministry of Textiles, Bird Group of Companies, Bharat Coking Coal Ltd, Small Industries Development Bank of India (SIDBI) and Industrial Development Bank of India among others, said the CVC's annual report for

2022.

There was one each case of non-adherence of the probity watchdog's advice by New India Assurance Company Ltd, V O Chidambaram Port Authority and Bharat Sanchar Nigam Ltd,

The Central Vigilance Commission (CVC), in the exercise of its functions and powers under Section 8(1) (g) of the CVC Act, 2003, tenders advice to the central government, corporations, government companies, societies and local authorities owned or controlled by the central government.

The advice is tendered by the Commission based on a reasoned appreciation of all the facts, documents and records relating to a particular case, which are brought to its notice by the organisation concerned, the report said.

"Non-acceptance of the Commission's advice vitiates the vigilance process and weakens the impartiality of the vigilance administration. However, there are cases of deviation from the prescribed procedure or non-acceptance of the Commission's advice," it said.

The CVC has observed that during the year 2022, there were some significant deviations from the Commission's advice, said the report made public recently.

Mentioning details, it said the then Senior Divisional Engineer (Sr. DEN) failed to investigate into complaints received from Additional Divisional Railway Manager (ADRM) and also failed to exercise due diligence in scrutiny of credential documents of a firm, resulting in

award of contract to a firm on fake/forged credential papers.

The Commission had advised the imposition of a major penalty. However, the railway board imposed only a minor penalty.

'Imposition of only minor penalty by the disciplinary authority i.e. railway board, is a deviation from Commission's advice," the report said.

The acceptance of the CVC's reasoned advice in an overwhelming majority of cases by the disciplinary authorities is an indication of the objectivity and fairness of the Commission's advice, it said.

"However, in some cases of officers covered under the Commission's jurisdiction, either the prescribed consultation mechanism with the Commission was not adhered to, or the authorities concerned did not accept the Commission's advice," the report said.

Further, there have been instances where the advice tendered by the Commission has been substantially diluted without approaching it for reconsideration of its advice, as per extant procedure, it added.

The report, citing another instance, also said that irregularities were noticed in the issuance of a letter of credit (LC) to a private limited company by the State Bank of India officials.

"The estimated loss to the bank was ₹ 22.04 crore. After the imposition of major penalty on all the 5 officers, the appellate committee modified the penalty to a minor penalty of censure," the report said. (PTI)

#### Centre to incorporate rules to check vulgar content on social media, OTT platforms

NEW DELHI, Aug 22: The Centre has assured the Delhi High Court that its policy governing social media platforms and intermediaries will incorporate necessary rules and regulations to ensure the space occupied by them is free from vulgar language and profani-

The ministry of electronics & information Technology (MeitY), in an affidavit showing compliance of the high court's earlier directions, said it has taken note of the concerns expressed by the high court in its earlier orders

The high court had earlier said framing rules and guidelines to regulate the content on social media and OTT platforms need urgent attention.

It had underlined the need for taking seriously the use of vulgar language in public domain and on social media platforms which are open to children of tender age.

"It is stated that it is a policy decision and having taken note of the concerns of this court expressed through its directions, the concerned ministry (MeitY), while undertaking its regular exercise of policy making, will incorporate rules/regulations to regulate the social media platforms, intermedi-

## Punjab CM launches 'mera bill' app to reward GST payment on invoice

CHANDIGARH, Aug 22: Punjab chief minister Bhagwant Mann launched a 'mera bill' app under the 'bill liao inaam pao' (bring a bill, get reward) scheme.

The scheme is aimed at enhancing the compliance under the goods and services tax (GST) and thereby the revenue, according to an official release.

The scheme is targeted at motivating consumers to get bills from dealers for their purchases made within the state and thereby forcing the dealers to issue the hills for their sales

Mann said the consumers will be encouraged to upload bills of their purchases on the 'mera bill' app to be-

come eligible to participate in a lucky draw, which shall be held at 7th of each month.

There will be a maximum 10 prizes per taxation district (29 taxation districts in the state), taking the tally to 290 rewards each month.

The reward will be equivalent to five times the taxable value of goods or services declared in the bill with maximum capping of ₹ 10,000 for each reward.

Govt's policy neither beneficial to farmers

MUMBAI, Aug 22: The Shiv Sena (UBT) on Tuesday slammed the Centre over its decision to impose 40 per cent export duty on onions and claimed the government's policy is neither beneficial to farmers nor consumers.

An editorial in the Sena (UBT) mouthpiece 'Saamana' further claimed the Modi government gives assurances of doubling the income of farmers, but works in a way that they do not even get the expected income.

On August 19, the central government imposed 40 per cent export duty on onions to restrict outward shipments and boost local availability, amid apprehension about the kharif output and signs of firming of retail prices.

The decision led to protests by farmers and traders in various parts of Maharashtra, especially in Nashik district.

"The policy of the government is neither beneficial to farmers nor consumers," the editorial in Saamana said

Whenever there is a chance for farmers to earn a little more money, the government either resorts to export duty or ban on exports, the Marathi daily claimed.

This decision to impose 40 per cent duty was announced all of a sudden, and thousands of tonnes of onion are stuck at the country's ports. If it rots, then it can neither be exported nor sold within the country, the Sena (UBT) said. Consumer affairs minister Piyush Goyal on Wednesday alleged that some "political opponents" are creating a "wrong picture" about the export duty slapped on onion, and urged farmers not to worry as the Centre has restarted procurement at ₹ 2,410 per quintal for its buffer stock (PTI).

The high court's March 6 verdict had come while upholding an order of the additional chief metropolitan magistrate (ACMM) asking the Delhi Police to register an FIR against TVF, the show's director Simarpreet Singh, and actor Apoorva Arora under the Information Technology Act.

It had clarified that the direction to register FIR does not include a direction to arrest any of the accused or petitioner.

The court had said the challenge faced by India, as by many other countries, for enacting appropriate law, guidelines and rules to regulate the content on social media and OTT platforms needs urgent attention.

After watching a few episodes of the series, the court had found excessive use of 'swear words', profane language' and 'vulgar expletives'

The judge had said she had to watch the episodes with the aid of earphones in the chamber, as the profanity of language was such that it could not have been heard without shocking or alarming the people around. (PTI)

"Two-way communication between the two is established," the post said – and quickly lapped up over 3.4 million views on X (formerly Twitter).

Almost a week before that on August 17 when the lander module successfully separated from its propulsion module, ISRO posted on X: "Thanks for the ride, mate! ' of the Moon, rockets and satellites if not a waving hand or a globe – making a connect The post with a hand waving emoji hit with the people.

While the reach of ISRO's social media messages rode on the enthusiasm and the general buzz around India's ambitious and most anticipated Moon mission, a post on Tuesday showed that the mood within the scientific community at ISRO mirrored that of the public.

With just hours left for Vikram and

Pragyan's landing on the lunar south pole, scheduled for 6.04 pm on Wednesday, the social media handles of ISRO posted saying that the Mission Operation Complex (MOX) is buzzing with energy and excitement. The post also said that the module was continuing to sail smoothly.

Chandrayaan-3 is a follow-on mission of Chandrayaan-2, which failed in its lunar phase when its lander Vikram crashed into the surface of the Moon following anomalies in the module's braking system while attempting a touchdown on September 7, 2019.

In the previous mission too, ISRO's social media handles had attempted to use lighthearted messaging with a hashtag called #CY2Chronicles. One of the initial posts in the Chandrayaan-2 chronicles series was a comic strip depicting the separation of the propulsion module from the lander module. The post on September 6, 2019 on X (then known as Twitter), Chandrayaan-2's lander module is depicted as saying to the propulsion module -- "It was quite the journey indeed! I will see you around -- in the next orbit."

# I am political heir of Ram Vilas Paswan, Chirag will only inherit property: Pashupati Paras

"...Asked me to carry forward his legacy and fulfil his unfinished dreams"

NEW DELHI, Aug 22: Union minister Pashupati Kumar Paras on Tuesday asserted that he is the political "heir" of former Lok Janshakti Party chief and his late brother Ram Vilas Paswan, while Chirag Paswan will inherit only his father's financial assets by law.

Ram Vilas Paswan, a veteran Dalit leader and a political heavyweight from Bihar, passed away in October 2020 after prolonged illness. His Lok Janshakti Party (LJP) split into two factions following differences between his son Chirag Paswan and younger brother Paras.

Talking to reporters on the sidelines of an event here, Paras also asserted that he will contest the 2024 Lok Sabha polls from the Hajipur seat in Bihar, claiming that Ram Vilas Paswan had asked him to fight from the constituency even in 2019.

He had asked "me to carry forward his legacy and fulfil his unfinished dreams", said Paras, who heads the Rashtriya Lok Janshakti Party (RLJP) and represents Ha-



jipur in Lok Sabha, Staking claim to his brother's legacy, Paras said, "According to law, Chirag Paswan is the successor of Ram Vilas Paswan's property. But I am the (political) heir of my late elder brother as was Lord Ram's brother Lakshman in the

Ramayana. "He (Ram Vilas Paswan) had asked me to contest from his Hajipur Lok Sabha seat after he was elected to Rajya Sabha, saying he

trusted me more than anyone in the family. I was not willing to contest from the seat, but he made me join

the frav from his constituency." he claimed. Paras' assertion comes at a time when his nephew, Chirag Paswan, who heads the LJP (Ram Vilas), has keen on contesting from Haiipur in the 2024 general elections. Both the LJP (Ram Vilas) and the RLJP are part of the BJP-led

National Democratic Alliance.

Asked if there is any possibility of reconciliation between him and Paswan, Chirag Paras said,"Never".

Referred to some past incidents, the RLJP chief said he and his family members will "never forgive Chirag" for the way he treated them when Ram Vilas Paswan was hospitalised and after his death.

The BJP has brought Chirag into the NDA fold to prevent division of votes. I told them (BJP) that I have no problem with him coming to the NDA," Paras said. There is no relation between political affairs and personal affairs, he added.

"When Chirag came to attend the NDA meeting (last month), he touched the prime minister's feet and received his blessings. He then came to me and touched my feet as well, and I also blessed him from the core of my heart. But, an hour later, he staked claim over the Hajipur seat, saying he will contest from there," Paras said.

He said he will never forgive him for that. (PTI)

### Touch down near south polar

ISRO on Tuesday also released images of the Moon as captured by the Lander Position Detection Camera (LPDC) of the Chandrayaan-3 mission on August 19, and by Lander Imager Camera 4 on August 20.

LPDC images assist the LM in determining its position (latitude and longitude) by matching them against an onboard moon reference map, according to the Bengaluru-headquartered national space agency.

The critical process of soft-landing has been dubbed by many including ISRO officials as "17 minutes of terror", with the entire process being autonomous when the lander has to fire its engines at the right times and altitudes, use the right amount of fuel, and scan of the lunar surface for any obstacles or hills or craters before finally touching down.

After checking all the parameters and deciding to land, ISRO will upload all the required commands from its Indian Deep Space Network (IDSN) at Byalalu near here, to the LM, a couple of hours before the scheduled time touchdown.

According to ISRO officials, for landing, at around 30 km altitude, the lander enters the powered braking phase, and begins to use its four thruster engines by "retro firing" them to reach the surface of the moon, by gradually reducing the speed. This is to ensure the lander doesn't crash, as the Moon's gravity will also be in

Noting that on reaching an altitude of around 6.8 km, only two engines will be used, shutting down the other two, aimed at giving the reverse thrust to the lander as it descends further, they said, then, on reaching an altitude of about 150-100 metres, the lander using its sensors and cameras, would scan the surface to check whether there are any obstacles and then start descending to make a soft-landing.

ISRO chairman S Somanath had recently said the most critical part of the landing will be the process of reducing the velocity of the lander from 30 km height to the final landing, and the ability to reorient the spacecraft from horizontal to vertical direction. "This is the trick we have to play here," he said.

"The velocity at the starting of the landing process is almost 1.68 km per second, but (at) this speed (the lander) is horizontal to the surface of the Moon. The Chandrayaan-3 here is tilted almost 90 degrees, it has to become vertical. So, this whole process of turning from horizontal to vertical is a very interesting calculation mathematically. We have done a lot of simulations. It is here where we had the problem last time (Chandrayaan-2)," Somanath explained.

After the soft-landing, the rover will descend from the lander's belly, onto the Moon's surface, using one of its side panels, which will act as a ramp.

The lander and rover will have a mission life of one lunar day (about 14 earth days) to study the surroundings there. However, ISRO officials do not rule out the possibility of them coming to life for another lunar day.

The lander will have the capability to soft-land at a specified lunar site and deploy the rover which will carry out in-situ chemical analysis of the lunar surface during the course of its mobility. The lander and the rover have scientific payloads to carry out experiments on the lunar surface.

"After powered descent on to the landing site, there will be deployment of ramp and rover coming out. After this all the experiments will take place one after the other -- all of which have to be completed in just one day on the moon, which is 14 days," Somnath had said.

Noting that as long as the sun shines all the systems will have its power, he said, "the moment the sun sets, everything will be in pitch darkness, temperature will go as down as low as minus 180 degree celsius; so it is not possible for the systems to survive, and if it survives further, then we should be happy that once again it has come to life and we will be able to work on the system once again, and we hope like that to happen.

Polar regions of the moon are a very different terrain due to the environment and the difficulties they present and therefore have remained unexplored. All the previous spacecraft to have reached the Moon landed in the equatorial region, a few degrees latitude north or south of the lunar equator

The Moon's south pole region is also being explored because there could be a possibility of presence of water in permanently shadowed areas around it.

The LM has payloads including RAMBHA-LP which is to measure the near surface plasma ions and electrons density and its changes, ChaSTE Chandra's Surface Thermo Physical Experiment -- to carry out the measurements of thermal properties of lunar surface near polar region -- and ILSA (Instrument for Lunar Seismic Activity) to measure seismicity around the landing site and delineating the structure of the lunar crust and mantle.

The rover, after the soft-landing, would ramp down of the lander module and study the surface of the moon through its payloads APXS - Alpha Particle X-Ray Spectrometer - to derive the chemical composition and infer mineralogical composition to further enhance understanding of the lunar surface.

The rover also has another payload Laser Induced Breakdown Spectroscope (LIBS) to determine the elemental composition of lunar soil and rocks around the lunar landing site.

Ahead of its scheduled landing on the moon, Chandrayaan-3's LM has established a two-way communication with Chandrayaan-2's orbiter which continues to orbit around the Moon. LEH, Aug 22: Congress leader Rahul Gandhi on Tuesday reached Lamayuru, known for its ancient monastery and incredible landscape, riding a motorcycle from Leh town, a party leader said.

Gandhi, who is currently on a tour of the Union Territory of Ladakh, covered a distance of about 130 km to reach Lamayuru where he will stay overnight before moving to Zanskar, a tehsil of Kargil district, on Wednesday. He will be in Kargil town on Thursday.

The 53-year-old leader returned to Leh from Nubra valley on the motorcycle on Monday and was given a warm welcome by people in the main market in the evening, Congress spokesperson and leader of opposition in Ladakh Autonomous Hill Development Council (LAHDC), Leh, Tsering Namgyal told PTI.

Gandhi reached Ladakh on August 17 and is scheduled to visit Kargil in the next couple of days during his over week-long tour of the region, his first after the region was granted UT status after being carved out from Jammu and Kashmir in August 2019.

"Bharat Jodo is deeply rooted in every Indian's heart and mind. The resonating chant of 'Bharat Mata Ki Jai' echoing through the streets of Leh serves as a strong example of this unity. No power can suppress this voice, brimming with affection and camaraderie," Gandhi wrote on his social media account.

## Direct Delhi Police to allow meeting with minor rape survivor, DSW chief Maliwal in letter to Shah

NEW DELHI, Aug 22: DCW chief Swati Maliwal on Tuesday requested union home minister Amit Shah to direct the Delhi Police to allow her meeting with the minor girl allegedly raped by a senior Delhi government official. In a letter to Shah, she also urged the home minister to order an inquiry into the delay in arresting the accused and to shift the girl to AIIMS for better treatment.

Premoday Khakha -- a deputy director in the city government's women and child development department -- allegedly raped the girl several times between November 2020 and January 2021, according to the Delhi Police. His wife allegedly gave the girl medicine to terminate her pregnancy.

Khakha and his wife Seema Rani were arrested on Monday.

Maliwal, the Delhi Commission for Women (DCW) chairperson, said that while the police and the hospital authorities prevented her from meeting the girl and her mother, they allowed the National Commission for Protection of Child Rights chairperson to interact with the mother.

"It is extremely unfortunate that even though I waited for over 24 hours outside the hospital and even slept there, the Delhi Police and



the hospital authorities disallowed my meeting with the survivor or her family. Despite my repeated requests, I was not allowed to meet with the survivor or her family, which is an illegal act, both by the Delhi Police and the private hospi-

tal (sic)," the letter read. Maliwal on Monday began a dharna at the hospital, claiming she was not allowed to meet with the girl. She alleged that the police and the hospital authorities "misused their power" to stall the commission's functioning.

She urged Shah to direct the Delhi Police to allow her meeting with "the girl or her mother so that the commission can assist them" and that an inquiry be ordered to

ascertain why the Delhi Police delayed the accused's arrest. Maliwal also demanded that the

DEHRADUN, Aug 22: Chief minister Pushkar Singh Dhami on Tuesday said a disaster-like situation prevails in Uttarakhand due to excessive rains and put the losses suffered by the state so far at over ₹ 1,000 crore.

"Heavy rains this monsoon have destroyed crops, washed away roads, bridges, houses and cowsheds and also claimed the lives of several people and cattle. A disaster-like situation prevails in the state," he said. "Properties worth more than ₹1,000 crore have been lost and the monsoon is still active," Dhami told reporters after reviewing the rain situation in the state after his return from Delhi.

He said a scheme will soon be introduced by the state government to rehabilitate the affected people and take care of children who have lost their parents in rain-related disasters in Uttarakhand. A team from the Centre has already made a preliminary survey and will make a detailed assessment of the losses caused by the disaster. Dhami said.

Over 20 heads of state from Africa and the Middle East have also been invited to attend. A number of them have applied to become members of BRICS, which is one of the matters on the agenda for the Summit.

Modi said in the statement that he looked forward to interacting with a number of guest countries that have been invited to participate in this event.

"I also look forward to holding bilateral meetings with some of the Leaders present in Johannesburg," he said.

Russian President Vladimir Putin is expected to attend the BRICS summit virtually due to him facing possible arrest in terms of an International Criminal Court (ICC) warrant if he lands in South Africa.

From South Africa, the prime minister will travel to Greece on August 25 at the invitation of his Greece counterpart Kyriakos Mitsotakis. It will be his first visit to this ancient land. "I have the honour to be the first Indian Prime Minister to visit Greece after 40 years," he said.

Contacts between our two civilizations stretch back over two millennia and, in modern times, our ties have been strengthened by shared values of democracy, rule of law and pluralism, he said.



"I never thought I would operate a computer, but I did and I am still learning. Now, all we have to do is, 'Click a button, start, click a button, stop'. Earlier we had to load the film, there was a lot of physical work that went behind it," Fakih told PTI in an interview here. Following the transition to digital film projection, movies are now shown in cinema halls via a server or a DVD. Regal Cinema is among the many theatres that have installed a digital system alongside the old analogue equipment. (PTI)



## CHAHAL GETS A 'GOOGLY' AGAIN: LEG-SPINNER SET PLAYING 3 ICC EVENTS IN

NEW DELHI, Aug 22: It's another ICC event on the horizon and leg-spinner Yuzvendra Chahal has once again fallen out of favour with the Indian team selectors.

Chahal was a big name missing from the Asia Cup squad announced on Monday but India skipper Rohit Sharma has left the door slightly ajar for the 33-yearold for the subsequent ODI World Cup at home in October-Novem-

The wily operator, who was once India's go to bowler in the middle overs, finds himself in familiar territory as another World Cup beckons.

Chahal was controversially excluded from the 2021 T20 World

Cup before returning for the 2022 edition in Australia, where he did not get a game as finger spinners were preferred in the playing eleven. Kuldeep Yadav, one half of the celebrated 'Kul-Cha' duo has left the other half behind in the pecking order. Kuldeep is the sole wrist-spinner in the 17-member squad for Asia Cup with the thinktank going for the better batter in Axar Patel alongside Ravindra Jadeia

India seem to be banking heavily on the fast bowlers to do the job in the World Cup but in the spin department, can Kuldeep, Axar and Jadeja provide the much needed wickets in the middle overs? Will not picking Chahal

hurt India at the Asia Cup, like it did in T20 format when Varun Chakaravarthy, on basis of one season of IPL, was picked ahead of him in what turned out to be a forgettable campaign for the mystery spinner as well as the team. If the chosen combination does-

n't work in the continental event, India will be forced to rethink their options ahead of the 50-over showpiece event at home. Besides not having a right-arm wrist-spin option, there is no off-break bowler in the squad either.

"We thought about an off-spinner as well, Ashwin and Washy (Washington Sundar), but right now you see Chahal had to miss out because we could only pick 17

However, Chahal's non-selection in the Asia Cup squad was not entirely a surprise as he sat on the sidelines in the ODI series in the West Indies. He got the breakthroughs in the following T20s in the Caribbean but the selectors were not convinced enough.

His unlikely comeback will mainly depend on the performance of the chosen trio in the Asia Cup beginning August 31. But with selectors set to announce the provisional World Cup squad by September 5, is there enough time to change their minds? Perhaps, No. (PTI)

# 3<sup>rd</sup> T20I: Chance to test bench strength as India aim clean sweep against Ireland

DUBLIN, Aug 22: Jasprit Bumrah will have to balance between adding miles to his legs and checking his team's benchstrength as India aim to complete a comfortable clean-sweep against Ireland in the three-match T20 series here on Wednesday. The Indian skipper for the series has looked comfortable in the eight overs across two matches but will need to take an informed call if he intends to play a third consecutive game on the bounce in five days even though it is a T20 affair.

The more Bumrah and Prasidh Krishna bowl, the fitter they will get, better the rhythm will be and greater the pace in their deliveries -- ingredients that are a must to cook a perfect recipe to trouble Pakistan in the upcoming Asia Cup and the marquee World Cup.

However, the skipper along with standin head coach Sitanshu Kotak will also have to keep in mind that there is an Asian Games to be played and some of the reserve bench players might just be undercooked. The inconsequential third game gives this think-tank a chance to check out players like Avesh Khan, Jitesh Sharma, Shahbaz Ahmed, who haven't yet got a game in the series.

In fact, Avesh, who was also with the team during the West Indies T20 series has been benched for seven straight matches and if he is again kept on the sidelines, he will go into Asian Games without any game time, which might be detrimental for both him and the team.

It is unlikely that there will be any change in the batting order unless the team management decides to rest Sanju Samson and try out Jitesh before Asian Games. However Samson, who is a senior in shortest format. The likes of Rinku,


