<u>HT Bureau</u> SHILLONG, Aug 8: Meghalaya chief minister Conrad K Sangma, alongside Speaker of the Meghalaya Legislative Assembly Thomas Sangma and State Cabinet min isters, called on Prime

Narendra Minister Modi in New Delhi on Tuesday.

The delegation submitted a memorandum to the Minister Prime seeking his intervention in various issues including border dispute with Assam.

"The Prime Minister heard our concerns, and assured us to look into it. We thank him for giving us this opportunity," the chief minister said, while highlighting the issues that were discussed.

On the Assam-Meghalaya area of differences, chief minister

Sangma sought the support of the Prime Minister for the ongoing resolution of the remaining six out of twelve disputed areas between Assam and Meghalaya.

He told the Prime Minister on the reconstitution of three Regional Committees to assess the current status of the remaining six disputed areas. The committees were tasked with verifying village claims, establishing geographical locations, and preparing

asset registers in collaboration with both state governments. Notably, six areas were successfully resolved in March 2022, with an agreement signed in the presence of Union Home Minister Amit Shah. A joint survey by both states is (CONTD. ON PAGE-9)

### Come as 'guest' to see changed Assam, Himanta to ULFA-I chief

GUWAHATI, Aug 8 (PTI): Chief minister Himanta Biswa Sarma on Tuesday invited United Liberation Front of Asom (ULFA-I) chief Paresh Barua to visit the state as a "guest" and witness the changed situation over the decades.

Talking to reporters on the sidelines of a programme here, Sarma said the invitation to Barua is not for taking part in any talks, but to witness the developed and peaceful Assamese society today.

"Paresh Barua himself is a knowledgeable person. It does not mean that he will come because I have invited him. He will act according to his own wisdom and logic.

"However, I feel that if he stays in Assam for just seven days, he will realize that the old Assam has changed a lot ... " he said.

Sarma said that once Barua had a feeling that outsiders occupied everything in Assam, but now a large number of Assamese youths stay in Karnataka and Andhra Pradesh as the situation has changed.

### 3.75 lakh hectares allotted for palm cultivation in Assam

HT Bureau GUWAHATI, Aug 8: Prime Minister Narendra Modi has stressed on the need to produce palm oil locally in the country, revealed Assam chief minister Himanta Biswa Sarma on Tuesday.

He said this while launching the plantation drive of palm trees at Dibru Saikhowa in Dhola in the Tinsukia district. The plantation drive has been organised by the state agriculture department in collaboration with the Tinsukia district administration and Patanjali Foods Limited as part of the National Mission on Edible Oils.

The Union government has launched an oil palm planting campaign from July 25 to August 5 this year to increase the area under oil palm cultivation in the country. Under this mission a total of 3.75 lakhs

hectares of land will be brought under palm cultivation across the state.

Speaking on the issue, Himanta Biswa Sarma said, "The government has been mulling over starting local production of palm oil for some time now. PM Modi has stressed on the need to produce palm oil in



the country, which will enhance the economic condition of farmers along with boosting production of oil.

India at present imports palm oil from Indonesia and Malaysia at an estimated cost of ₹ 1.5 lakh crore.

"People in Goalpara and Dhubri districts have begun cultivation of palm oil about eight to nine years ago. Small time tea cultivators can also adopt palm oil cultivation to enhance (CONTD. ON PAGE-9)

NEW DELHI, Aug 8 (PTI): There is no question of a Brexitlike referendum on abrogation of Article 370 in Jammu and Kashmir, the Supreme Court said on Tuesday, as it grappled with the question as to whether its repeal was constitutionally legal.

India, it said, is a constitutional democracy where the will of its people can be ascertained only through established institutions. Brexit was the name given to the United Kingdom's departure from the European Union. Britain's exit from the EU was actuated by a rise in nationalistic fervour, daunting immigration issues, and a distressed economy.

The remark by the five-judge bench headed by Chief Justice DY Chandrachud came following the submission by senior advocate

### We challenge you to furnish details of Union ministers' visit to Manipur in last 97 days: Cong slams Rijiju



NEW DELHI, Aug 8 (PTI): The Congress on Tuesday hit out at Union Minister Kiren Rijiju over his remark that the prime minister has directed ministers to visit the Northeast every 15 days, challenging him to furnish details of the visits of Union ministers to Manipur in the last 97 days.

Intervening in the debate on the no-confidence motion against the government, Rijiju said, "When our government was formed, in the first cabinet meeting, (Prime Min-

ister Narendra) Modi ji made a group and said that every 15 days, five cabinet ministers and seven ministers of state must tour the Northeast. It is still going on, all the ministers sitting here have toured the northeast."

"PM Modi has also given directives to officials to visit the Northeast and meet people. There is no meaning of ruling from Delhi, one can reach the people through service. You never thought about this. The prime minister has won the confidence of the people," Rijiju said.

KOLKATA, Aug 8 (PTI): A study by ZSI (Zoological Survey of India) has revealed that there are as many as 78 bird species which are found only in India.

There is a rich diversity of 10,906 bird species in the world, and of them, India is home to 1,353, Zoological Survey of India scientist Amitava Majumder said. These 1,353 bird species account for 12.4 percent of the global avian diversity, he said.

According to the International Union for Conservation of Nature (IUCN) categorisation, 25 of the 78 bird species, which are found only in India, are classified as 'threatened', the scientist said.

"Seventy-eight bird species are found only in the country's geographical region. On the occasion of the 75th Independence year, we



have focussed on 75 such species in the book, '75 Endemic Birds of India'," Majumder told PTI.

These selected winged species exhibit "remarkable distribution patterns" across various regions of

the country, he said. Twenty-eight bird species are restricted to the Western Ghats, 25 to

Eleven species are categorised as 'near threatened'

Majumder said three bird species - the Manipur Bush Quail (Perdicula manipurensis), listed as 'endangered' by IUCN, the Himalayan Quail (Ophrysia superciliosa), categorised as 'critically endangered', and the Jerdon's Courser (Rhinoptilus bitorquatus), classified as 'critically endangered', - have not been included in the ZSI publication.

According to records, the Manipur Bush Quail was last sighted in 1907, while the Himalayan Quail and the Jerdon's Courser were last seen in 1876 and 2009 respectively, he said.

# Guj HC quashes NIA court order which sentenced businessman to life imprisonment for leaving hijack threat note on flight

AHMEDABAD, Aug 8 (PTI): The Gujarat High Court on Tuesday quashed and set aside a 2019 order of a NIA court sentencing a businessman to life imprisonment for leaving a hijack threat note on a Mumbai-Delhi flight in 2017, saying the trial court sentenced him for the offence of hijacking "on the premise of evidence which is tainted with doubt '

Businessman Birju Salla was the first person to be booked under the stringent Anti-Hijacking Act, 2016. The NIA had filed a chargesheet against him under sections 3(1), 3(2)(a) and 4(b) of the Anti-Hijacking Act, 2016. A division bench of HC Justices AS Supehia and MR Mengdey said the appellant (Salla) is acquitted from the offences under sections 3(1) and 3(2)(a) of the Act. As a sequel the sentence under section 4(b) of the Act is set aside, it added. The HC also directed that ₹ 5 crore fine which Salla was ordered to pay be refunded in case it is already paid

special National Investigation The Agency (NIA) court in Ahmedabad on June 11, 2019 sentenced Salla to life imprisonment under the Anti-Hijacking Act, 2016, and imposed a fine of ₹ 5 crore for leaving a hijack threat note on a Mumbai-Delhi flight in October 2017.

Salla had become the first person to be booked under the stringent Anti-Hijacking Act, 2016, which replaced a vintage law of 1982. He was also the first person to be put under the "national no fly list".

While quashing and setting aside the NIA court order against Salla, the HC said it does not subscribe to "the view expressed by the trial court convicting and sentencing the appellant for the offence of hijacking on the premise of evidence which is tainted with doubt." It also directed that ₹ 5 crore fine which Salla was ordered to pay be refunded in case it is already paid, and his properties seized and ordered to be confiscated by the investigation officer under provisions of section 19 of the Act be released.

The high court also directed crew members of the affected flight to refund the amount of compensation in case the same



was paid as per directions of the trial court. The trial court had said ₹ 5 crore fine submitted by the convict shall be distributed among the crew members and passengers on board the affected plane.

"In the alternative, the state is directed to pay the amount which is paid to the crew members, and it will be open for the state to recover such amount from the crew members," the HC bench said in its order. Salla was accused of creating a hijack scare by

planting a threat note written in English and Urdu in the tissue paper box of the aircraft's toilet on October 30, 2017.

The NIA had said Salla prepared a "threat note" in both English and Urdu language and placed it "intentionally" in the tissue paper box of the toilet near the business class of the Mumbai-Delhi Jet Airways flight on October 30, 2017, thereby jeopardising the safety of passengers and crew on board. He was arrested after the plane made an emergency landing at the Ahmedabad airport after a female flight attendant found the note in the washroom which read, "there are hijackers on board and explosives on the plane"

As per the prosecution, Salla confessed to the crime and told investigators he had done it in the hope that it would force Jet Airways to close its Delhi operation and his girlfriend, who worked in the airline's office in the national capital, would come back to Mumbai. The note asked the plane to be flown to Pakistan-occupied Kashmir (PoK). The note ended with the words "Allah is Great"

US inflation data later this week Markets fall as investors turn cautious ahead of RBI monetary policy review



MUMBAI, Aug 8 (PTI): Benchmark equity indices fell on Tuesday as investors turned cautious ahead of the key events -- RBI's monetary policy and the US inflation data -- due to be announced later this week. Continuous foreign fund outflows and weak trend in Asian and European markets also played spoilsport for the domestic markets.

The 30-share BSE Sensex fell 106.98 points or 0.16 per cent to settle at 65,846.50. During the day, it declined 200.85 points or 0.30 per cent to 65,752.63. The NSE Nifty slipped 26.45 points or 0.13 per cent to end at 19,570.85. Amid expectations of another status quo on the key interest rates, RBI Governor Shaktikanta Das-headed high-powered rate-setting panel MPC on Tuesday began its three-day meeting to firm up the next bi-monthly policy.

The decision of the Monetary Policy Committee (MPC) would be announced on Thursday, August 10, by Governor Das. "On the global front, investors are adopting a cautious approach even amidst declining bond yields as they await the release of crucial economic data. The significant drop in Chinese exports has also contributed to concerns within the global market. "FIIs remain in a selling mode in the domestic market, yet active buying from DIIs is mitigating downside risks. Among sectors, PSU banks and pharma stocks inched up, while mid and small-cap stocks have continued to outperform the benchmark, showcasing their resilience, said Vinod Nair, Head of Research at Geojit Financial Services.

From the Sensex pack, Power Grid, Mahindra & Mahindra, JSW Steel, HCL Technologies, Sun Pharma, Nestle, IndusInd Bank, Reliance Industries, Bharti Airtel and ITC were the major laggards.

Tech Mahindra, Wipro, Bajaj Finance, State Bank of India, Bajaj Finserv, Axis Bank, Titan and ICICI Bank were among the major gainers.

"Caution prevailed in the market ahead of the RBI's monetary policy announcement, while weak European and Asian cues saw the local benchmarks linger in negative territory for the majority of the trading session. Listless trading could be seen till the MPC meeting outcome and global cues will continue to dictate trends in the local market," said Shrikant Chouhan, Head of Research (Retail), Kotak Securities Ltd.

In the broader market, the BSE smallcap gauge climbed 0.25 per cent and midcap index gained 0.15 per cent. Among the indices, metal declined by 0.94 per cent, telecommunication fell by 0.92 per cent, utilities declined 0.60 per cent, commodities dipped 0.54 per cent, power (0.39 per cent) and energy (0.32 per cent). Financial Services, healthcare, industrials, bankex, capital goods and consumer durables were the gainers. In Asian markets, Seoul, Shanghai and Hong Kong settled lower while Tokyo ended in the green. European markets were quoting in the negative territory. The US markets ended in the positive territory on Monday. Global oil benchmark Brent crude fell 1.38 per cent to USD 84.16 a barrel. Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 1,892.77 crore on Monday, according to exchange data.

### RBI's rate-setting panel starts 3-day deliberations on monetary policy

MUMBAI, Aug 8 (PTI): Amid expectations of another status quo on the key interest rates, RBI Governor Shaktikanta Das headed high-powered rate-setting panel MPC on Tuesday began its three-day meeting to firm up the next bimonthly policy.

The decision of the six-member Monetary Policy Committee (MPC) would be announced on Thursday, August 10, by Governor Das.

Experts are of the view that the central bank may continue with the pause on the reportate as concerns on the inflation front and keeping the borrowing cost stable to maintain the economic growth momentum persist.

The borrowing cost, which started rising in May last year, has stabilised with the RBI keeping the reportate unchanged at 6.5 per cent since February when it was raised from 6.25 per cent. Later, in the two bi-monthly policy reviews in April and June, the benchmark rate was retained. BofA Securities in a report said it expects the RBI MPC to deliver a hawkish hold on August 10 while retaining the stance as withdrawal of accommodation.

"We don't see the recent tomato price spike to push the MPC to hike rates right away, we have seen such episodes in the past," it said.

Dhruv Agarwala, Group CEO of Housing.com, said market analysts expect the central bank to opt for maintaining the current status quo on both interest rates and policy stance. The RBI is closely monitoring inflation figures, particularly in light of the recent significant surge in prices of essential food items, including vegetables, he said.



"Given the ongoing global economic uncertainties and persistent geopolitical risks, it is likely that the RBI will continue to exercise a cautious approach and keep interest rates unchanged, leading to a rate pause in its upcoming policy decision," Agarwala added.

The government has tasked the central bank to ensure retail inflation remains at 4 per cent with a margin of 2 per cent on either side. The central bank factors in the CPI to arrive at its bi-monthly monetary policy decision.

Puneet Kaura, Managing Director & CEO of Samtel Avionics, an MSME which majorly manufactures products for defense and railways opined that it is going to be a tough call with regard to the interest rate for the Reserve Bank as both the Federal Bank and European Central Bank have raised their benchmark interest rates. "It is expected that the RBI will continue with a pause for the third time in a row as inflation is likely to be benign in the wake of a good monsoon. The MSME sector which faces problems in getting institutional credit at competidown," he said. India's retail inflation based on Consumer Price Index (CPI) rose to a three-month high of 4.81 per cent in June, mainly on account of hardening prices of food. The inflation, however, remains within the RBI's comfort level of below 6 per cent. The inflation data for July will be released on August 14.

According to Deepak Agrawal, CIO-Fixed Income, Kotak Mahindra Asset Management Company, the second quarter inflation is likely to be a little over 6 per cent as against the RBI forecast of 5.2 per cent. This is due to a sharp spike in vegetable prices, particularly tomatoes

However, he does not expect any spill-overs from food inflation to core inflation, as the rise in prices are expected to be temporary. "This should be source of comfort for the RBI and we expect RBI to keep rates unchanged and continue with "withdrawal of accommodation" monetary policy stance," he said.

"Status quo is given in the MPC meeting this week, but the odds of interest rate hike or cut is equally poised going ahead. Global economic and inflationary environment are still not up to the mark because of renewed strengthening of crude oil prices and surge in global food prices on extreme weather conditions," Umesh Kumar Mehta, CIO of Samco Mutual Fund, said.

Kaushik Mehta, Founder & CEO of Ruloans Distribution Pvt Ltd said that the RBI's steadfast strategy of maintaining stable interest rates is likely to be the driving force for growth in retail loans, encompassing both personal and home loans.

### Gold falls ₹ 80 to ₹ 60,120/10 gm; silver plunges ₹ 800

NEW DELHI, Aug 8 (PTI): Gold edged lower by ₹ 80 to ₹ 60,120 per 10 grams in the national capital on Tuesday amid a decline in the precious metal in global markets, according to HDFC Securities.

The yellow metal had closed at ₹ 60,200 per 10 grams in the previous trade. Silver also plunged ₹ 800 to ₹ 74,000 per kg.

Gold declined for the second consecutive day on Tuesday, with spot gold prices in the Delhi markets trading at ₹ 60,120/10 gram down by ₹ 80 per 10 gram, Saumil Gandhi, Senior Analyst - Commodities at HDFC Securities, said. In the overseas markets, both gold and silver were trading lower at USD 1,932 per ounce and USD 23.09 per ounce, respectively.

The Federal Reserve's potential to continue tightening monetary policy helps the dollar gain some momentum, which is seen as a major factor weighing on the price of gold. In futures trade, the October contract of gold declined by  $\mathbf{R}$ 50 to ₹59,370 per 10 grams in afternoon deals on MCX. Silver futures also declined by ₹ 225 to ₹ 71,043 per kg on MCX.

The first half of the year witnessed a record surge in central bank acquisitions of gold, supported by robust investment markets and resilient demand for jewelry. During the second quarter, gold demand (excluding OTC) experienced a marginal 2% year-on-year dip to 921 tons. However, the overall demand (inclusive of OTC) displayed a 7% year-on-year increase, signaling a robust global gold market. In the realm of gold investment, bar and coin demand saw a notable 6% year-on-year growth, reaching 277 tons in the second quarter and a cumulative 582 tons in the first half. This expansion was driven by key markets such as the US and Turkey. While gold ETFs experienced modest outflows of 21 tons in the second quarter, this was significantly lower than the 47 tons in the same period of 2022, resulting in net outflows of 50 tons in the first half of the year. Furthermore, total gold supply observed a substantial 7% year-on-year increase to 1,255 tons in the second quarter. Mine production is estimated to have achieved a record high of 1,781 tons in the first half. Louise Street, Senior Markets Analyst at the World Gold Council, emphasized, "Record central bank demand has been a defining factor in the gold market over the past year. ### **Unpaid wages plague JDA employees**

JAGIROAD, Aug 8: A distressing situation persists as the employees of the Jagiroad Development Authority (JDA) have been denied their rightful monthly salaries for the past 48 months. The government of Assam established the Jagiroad Development Authority (JDA) in 1989 under the provisions of the Assam Town and Country Planning Act 1959 (as amended) to oversee the execution of master plans and zoning regulations. The government's initiative extended beyond the JDA, with the formation of an additional 24 development authorities across various towns in Assam, all aimed at master plan implementation and zoning regulation enforcement.

Each Authority consists of a chairman from the ruling party, a member secretary cum town planner from the relevant district's Town and Country Planning Office, along with several members including the local MLA, deputy commissioner, and department heads. These development authorities are primarily tasked with granting No Objection Certificates (NOCs) for building construction and land sale deed registration. While they also have the potential to undertake development schemes and generate revenue, a dearth of adequate funds and land has hindered most authorities from undertaking such initiatives.

Consequently, the authorities heavily rely on the fees collected from NOC issuance, which falls sig-







### **Crisis unfolds in Niger**

T n a stunning turn of events, a splinter faction of the Niger military orchestrated a coup on July 26, overthrowing President Mo-Lhamed Bazoum and leaving the nation's political landscape in turmoil. As Colonel Amadou Abdramane assumed control and declared the end of the preceding regime due to security concerns and governance issues, the international community's response has been swift and unequivocal. The African Union and the Economic Community of West African States (ECOWAS) promptly condemned the overthrow attempt, emphasizing the importance of respecting Niger's constitution and democratic processes. European leaders, the United Nations, and even Ethiopia's government joined the chorus in condemning any use of force to seize power. The United States expressed deep concern and called for President Bazoum's release from captivity, underlining the gravity of the situation. The coup marks the seventh in Africa's Sahel region since 2020, raising alarms about the region's stability. Mali and Burkina Faso, both under military rule, have stated their intentions to respond with full-scale invasions should ECOWAS or external military forces attempt to reinstate Bazoum. Niger's strategic significance in the Sahel cannot be overstated. With a history of instability in Chad, Mali, and Burkina Faso, the West viewed Niger as a crucial partner in countering rising jihadist movements and pro-Russian sentiments. However, the country's fragility, evident from its economic woes and dire human development indicators, complicates these efforts.

Russia's foreign minister called for the restoration of constitutional order, while Yevgeny Prigozhin, of the Wagner Group, denied any involvement in the coup but spoke of liberation from Western influences. As global powers tread cautiously, Niger's 27 million inhabitants, many living in extreme poverty, face an uncertain future. The upheaval also shines a spotlight on the West African franc (CFA) currency, a remnant of colonialism that constrains the region's economic autonomy. Despite providing some stability, the CFA franc limits intra-regional trade and independent industrial policies, perpetuating economic inequality. This, along with Niger's role in the global uranium trade, underscores the complexity of international interests intersecting with local turmoil. In light of the geopolitical struggle, the West's attempts to ensure security in the Sahel have led to mixed results. France's involvement, marked by assisting governments in the face of jihadist threats, often falters in remote regions. This power vacuum paves the way for coups and the emergence of Russian-backed forces.

The dilemma of intervention looms large, as any move by Western allies could spark a proxy war with Russia-backed factions, amplifying the refugee crisis and further destabilizing the region. In this ever-evolving crisis, regional stability, democratic principles, and humanitarian concerns must be balanced with geopolitical interests. The fate of Niger rests at the crossroads of global powers, with the potential to reshape the region's future. As world leaders grapple with the course of action, one thing remains certain: the people of Niger, burdened by poverty and youth, deserve a path towards stability and prosperity. The events unfolding in Niger not only challenge the status quo but also present an opportunity for the international community to rise above political interests and prioritize the well-being of a nation and its people. As we watch this crisis unfold, the eves of the world remain fixed on the choices made by global leaders, decisions that will undoubtedly shape the Sahel's destiny for years to come.

Then how will we attract foreign students, even if we do, won't it be unfair to Indian students? What India's higher education will achieve from 'Study in India', which is already struggling with lack of resources and lack of better teachers, is a big question. Making education and medicine a business through handing them over to private hands, both have become too expensive; access to them for the common man has become complicated.Expressing concern over this. Dr. Mohan Bhagwat, Sarsanghchalak of Rashtriya Swayamsevak Sangh said that education and health are the basic needs of every person, but both are becoming expensive and rare. The reason for this is the lack of availability and profes-

sionalism according to the rising population of India.

When we are not able to give proper education to the people of the country, then how can it be justified to open doors to the foreign countries, and spend huge resources of the government on them? In a country where the underprivileged group is already going through an ordeal to educate its future generation, the insensitivity and greediness of private schools and hospitals have raised voices of social discontent and rebellion. In such circumstances, there is a question mark on the government's intention to provide advanced education to foreign students.

Former President Dr. A.P.J. Abdul Kalam has dreamed of making India a developed nation by 2020. Addressing the nation on the eve of the 57th anniversary of India's independence on 14th August 2004, he emphasized on education in his speech saving that 'India is in the process of becoming a developed nation in the next 16 years and it is not possible without education'. In fact, education is the most important element for prosperity and development. Everyone's access to educational facilities is very important. Still, education is not easily available for villages and poor families. India should spend 6-7 percent of its GDP on education. Governments are spending on education, but how much the poor and deprived sections get its benefits is a matter of speculation. Politicians, educationists, officials and ministers who give long speeches on education are familiar with the wretched conditions

of the country. Who does not see these children selling peanuts in buses, begging at railway stations, roasting corn at crossroads, filling water in Bisleri bottles in factories, selling vegetables on roadside or selling chaat. Why do they have to do this? How many people try to know this? The story behind the rickshaw- pullers, auto rickshaws and buses drivers is

also similar. Even if the policy-makers had considered the family situation of their personal driver, servant or maid, they would have easily understood a lot about such situations. It is also seen at some places that children who are young enough to play with toys are found selling toys in fairs and markets. They have nothing to do with books at all. Then how can they see the golden dreams of development? In these conditions, the government's investment in how will a new India - a strong India - take shape? Are far-reaching schemes like 'Study in India' not a rude slap on the face of these deprived children? IITs, NITs and universities like IISERs, IIMs, Central Universities, JNU, BHU may have slightly lower fees, but the process to reach here is very complex and competitive. Children reach there through struggling and studying easily. But now the exercise of increasing the fees is also going at a fast pace. Education is becoming expensive due to all government efforts and schemes, so the lower and working class of the country are forced to think how to arrange for the education of their children. In private colleges, so much money is spent that even the middle class' standing is deterred, then what to

say about the lower class? The real aim of the government is to hand over higher education to the corporate houses, to establish foreign universities and colleges in India, so that higher education can become a profit-making industry, instead of adding the expenditure of the government. When India became independent after two hundred years of slavery, we had many challenges and dreams before us. To face those challenges and to fulfill dreams, the constitution was made the main base. Rhetoric was placed on giving special emphasis on education, the basic right of the people, and it was believed that until education does not reach the people of the country, the concept of allround development of the country is impossible. But unfortunately, there has been a steady decline in the field of education.



Khan's fans and followers and even those not quite enamoured by his feats in white flannels and in a politician's garb are left clueless about the verdict. He has been charged with and convicted of a charge which turns out to be a practice institutionalised by his predecessors.

Khan's deed for which he is no longer a free man pales into insignificance when one recalls former President Asif Ali Zardari who apart from retaining all 182 gifts he received, drove off with a BMW and a Lexus. He cannot be accused of taking these objects of desire gratis having paid a fraction of the value, according to details made public early this year. Expensive watches and a bullet proof vehicle are among the gifts which former Prime Minister Nawaz Sharif kept back.

More than six dozen gifts including a car were among the gifts which General Pervez Musharraf and his family walked away. Commonalities arise in the modus operandi followed by these worthy predecessors of Khan in retaining the gifts received in their official capacity. The values of the goodies were under declared and they did not find any place in the state treasury. Khan has every right to feel indignant for walking down a much travelled path. Clearly he has been singled out.

Yet there is not much Khan can do about it given the disarray his party Pakistan Tehreek-e-Insaaf is now in. Hope of a backlash lies in tatters even though the populace is burdened with burgeoning inflation as also food and petroleum products shortage.

If the army brass, a stumbling block before restoration of democracy in Pakistan, is enjoying a quiet chuckle at Khan's expense, there is a message for the populace. If Khan finds himself in the dumps for rubbing the army establishment the wrong way, he stood up to the men in uniform unlike his predecessors who got away scot free for a deed for which he has been convicted. ### Many Nepalese Gorkhas joining foreign mercenary groups including China

ecent reports about the number of Nepalese Gorkhas joining mercenary groups like Wagner army of Russia may be exaggerated, but Indian government is still concerned about China making a fresh attempt to recruit them as soldiers.

For some time, news of Nepalese Gorkhas being recruited by various agencies, reported at some length in international social media backed by videos, has led to a generally negative diplomatic fallout in south Asia and bevond. India stands squarely blamed because of its decision to introduce the new Agnipath recruitment scheme for future aspirant entrants to the Indian army. For decades, Gorkha applicants of both Nepali and Indian origin have been highly welcome within Indian army ranks, because of their fierce fighting spirit, sense of lovalty and discipline. On average over 1200 Gorkha youths from both countries joined the army, until last year. For the record, there are currently seven Gorkha regiments comprising (more or less) 40,000 heads in the Indian army, while the number of resident pensioners in Nepal is over 120,000.

However, some provisions of the Agnipath scheme were strongly rejected by Nepal Government, as it halted the recruitment of Nepalese citizens for joining the Indian army - ending a 200 year old bilateral arrangement!

GOI's new proposals ensure secured jobs for only 25% of initially selected youths, at the end of a 4 year arms and other training period also, there will be no mandatory pension or other social security benefits for retiring soldiers, completing their service tenure!

These conditions along with other game- changing alterations come as part of what have been described as part of an ambitious new GOI scheme to build a stronger, more modern army for the future. It needs stressing that there have been angry youth demonstrations in Bihar and other

parts of India against the Agnipath provisions, quite apart from the resentment reported from Nepal!

In part, the state of its economy as well as the unforeseen economic impact of the continuing Ukraine war might also have forced Nepal's break with India, which does not exactly improve the existing frosty relationship between the two countries. The assured recruitment to the Indian army was undoubtedly an economic opportunity especially for Gorkha youths to work out their future for themselves as well as their families, near home. The current extent of unemployment among job seekers is a high 12%, with only limited domestic opportunities available.

Given this backdrop, prospects of a monthly pay packet of around \$2500 US offered by Wagner recruiters according to reports, together with the offer of Russian citizenship on completion of one year's service as a solider, are obviously attractive for physically fit but jobless youth in Nepal---or anywhere else in South Asia! The reports further suggest that there is no language bar --- Afghans and other mercenaries have also served in Wagner without knowing Russian!In fact, the offer of citizenship in an advanced country like Russia for a Gorkha soldier and family is another major incentive, besides being a sure confirmation that the full weight of a major power like Russia works in favour of Wagner. Despite being seen as a 'Transnational criminal organisation 'by US Government authorities, the Wagner group until recently led by Yevgeni Prigozhin, had effectively intervened in military conflicts in Libya, Syria, Mozambique and more recently. in Crimea. US-EU aided armies and regimes had been fully or partially checkmated in the areas, as the controversial West-sponsored regime change operations failed spectacularly in Syria and parts of Africa as well.

Observers feel that the US-led opposition to the activities of the Wagner group-- not to mention the larger long term Western design to cut down Russia to size politically/economically/militarily-- has prompted the cautious response of Nepali diplomats and authorities regarding Gorkhas becoming part of armed East-against-West hostilities. Kathmandu is determined to maintain its non aligned, neutral stance in the East vs West confrontation. Recent Press inquiries have elicited the Nepalese response that a few individual Gorkhas, some of retirees, might have joined Wagner on their own initiative. They did not inform or seek permission from Nepalese authorities. Their number might be 12 or more, according to one report. As such, it was officially difficult for Nepal to intervene in the present situation. This comes in the wake of fresh reports of a renewed Chinese interest in recruiting Nepalese Gorkhas for the Peoples Liberation Army (PLA). There are suggestions that Nepali recruits could prove highly effective in standing up to Indian troops guarding the disputed Himalayan borders and adjacent regions. The Chinese border troops, it is common knowledge, had faced strong resistance from Indian border guards during the recent skirmishes at Galwan and other areas.

Observers recall that in 1962, Indian troops killed by the Chinese during the border conflict had included many Gorkhas. Beijing authorities reportedly invited them to join the Chinese and fight for them, but the Gorkhas refused.Evidence that the Chinese were now taking a fresh look at the situation became available in 2020, as Beijing authorities ordered a survey to ascertain why the Gorkhas had generally sided with India on most occasions, despite occasional Indo-Nepalese tensions.

Significantly, the Chinese have renewed such efforts now, as tensions and controversies plague Indo-Nepal relations during the tenure of the second NDA government led by the Bharatiya Janata Party (BJP). Stronger Sino-Nepalese ties will also strengthen China's presence and influence in the strategic Himalayan region where the US has become more diplomatically active. (IPA Service)

### Why Muslim women are divided on the question of a Uniform Civil Code Taking care of your feet during Monsoon

n June 27, Prime Minister Narendra Modi made his first public pitch for a uniform civil code while addressing party workers in Bhopal. "Tell me how a house can function smoothly if there is one law for one family member and another law for another member," he said. More significantly, he alleged that opposition parties were "instigating" Muslims into opposing a uniform civil code in the name of personal law while ignoring their welfare. Modi's comments were a reflection of the Bharatiya Janata Party and its allied groups' long-held desire to abolish personal laws and approve a common code for all Indians, irrespective of religion, ethnicity or gender.

Currently, different religious and tribal communities have their own laws that govern their personal affairs, including marriage, divorce, adoption, and inheritance. In its campaign for a uniform civil code, the BJP has mainly targeted Muslim personal law, arguing that it discriminates against women as it allows Muslim men to have more than one wife, get a greater share in inherited property, initiate divorce, and deny alimony.

In Assam, for example, chief minister Himanta Biswa Sarma has said his government will bring a bill to outlaw polygamy "within this financial year". In Uttarakhand, the expert committee for a Uniform Civil Code, according to The Indian Express, is ready to submit its report and draft of the law.

The newspaper also reported that the Law Commission, which has invited suggestions from the public on such a code, is working on a draft where "personal laws that clash with the constitutional mandate of gender equality" will be examined and addressed - such as laws that allow polygamy or prohibit equal rights for women in inheritance of property. Under Islamic law, a Muslim woman is entitled only to half of her brother's share of inherited property. As the rhetoric around uniform civil code appears to highlight the need for gender justice in Muslim personal law, Scroll spoke to several Muslim women on their views.

While many supported the call for reform of personal laws, they questioned the Modi government's intentions behind. "It is an outright majoritarian demand," said Shayma S, a PhD scholar at Jawaharlal Nehru University whose work is on Muslim engagements with law and judiciary, adding the ongoing campaign was "not based on any goodwill or genuine care for Muslim women"



Khan, a Mumbai-based Sabah women's rights activist and co-founder of Parcham, said the debate on uniform civil code is politically motivated. "I feel this demonisation of Muslim personal law is to reap electoral dividends." Shayma S said the debate over a uniform civil code is an example of Muslims being forced to explain and apologise for their religious practices. "The media too is re-circulating this focus and creating an image of a community that needs to be disciplined, controlled and reshaped," she said.

#### The question of polygamy

The uniform civil code is not a solution to the discrimination faced by women, said many activists. "This country is too diverse to have a single code," Khan said, adding that personal laws are not completely either good or bad. She, however, supported the reform of Muslim personal laws to make them gender-just and align them with the spirit of equality in the Constitution. "We should be thinking about how to address inequalities within each personal law so that we have genderjust laws and everyone is equal before law as the constitution guarantees," Khan said, adding, however, that any reform should be the result of dialogue.

According to Khan, the provision of polygamy in Muslim personal law should be revoked because of how such an arrangement traps women in unequal relationships. The Muslim personal law in India allows a Muslim man to have more than one wife. "Sometimes it is the second wife who is treated unfairly and sometimes it is the first wife who faces discrimination," she said.

Polygamy, however, is not practised only among Muslims in India. According to the National Family Health Survey-5 carried out in 2019-21, about 1.9% Muslim women said their husbands had more than one wife - compared to 1.3% of Hindu women and 1.6% of women of other communities. Among caste groups, polygynous marriage, where a man has

(2.4%). In Assam, an expert committee formed to examine the state legislature's legislative competence to bring a law against polygamy acknowledged that "the practice of polygamy is not entirely unheard of among" the tribals. It has recommended that the Assembly "should deliberate upon this aspect at the appropriate level" and the "appropriate time" while bringing in a law.

Sania Mariam, a PhD scholar who heads a collective of young Indian Muslim women, however, said that instead of banning polygamy, the practice should be regulated. "The response from within the Islamic tradition would be that while you are getting married, you can clearly state in your papers that the husband will not engage in a second marriage or there would be an automatic divorce in case of a second marriage," she said. For a lot of women, polygamy was acceptable practice as long as the consent of everyone involved is sought, she said. Dr Asma Zohra, the former head of the now-defunct women's wing of the All India Muslim Personal Law Board, argued that banning polygamy would deny the second wife and her children legal status. "If they care about women, then where is their care for the second wife? Is she not a woman?" Zehra asked, adding that she opposes any calls for change in the personal laws.

#### An older demand

But organisations representing Muslim women such as the Bharatiya Muslim Mahila Andolan or BMMA have also advocated a ban on polygamy in the past. Discrimination cannot be justified in the name of personal law and customs, said Zakia Soman, the founder of BMMA.

"We continue to be governed by the 1937 Shariat Application Act, which allows polgamy and is silent on crucial personal issues like the legal age of marriage, guardianship, and mother-child custody,' she said. "As a result, there is legal discrimination against Muslim women in matters related to marriage and family.' Soman said that the ideal solution to the

issue was codifying personal law, but she added that the clergy was resisting such demands, which pushes women like her to look for relief in secular law and the uniform civil code. She claimed that a lot of affirmative rights granted by the Quran and Islam have not translated into legal rights in personal law.

For instance, in Islamic law, a bride has the right to Mehr, where a groom is obliged to pay a dower to her in the form of money or possessions. But that is dimultiple wives, was found to be highest luted in reality, said Soman. "Rather than among Scheduled Tribe communities pay a substantive mehr to the bride they

are made to say 'mehr maaf' or are paid Rs 786 as mehr. The absence of any law or guidelines to uphold Quranic injunctions leads to a systematic violation of rights of women," she said.

Scope for reform Legal experts also raise questions over the government's plans to enact UCC in

the name of reform, equality, and unity. "Reform is a complicated and nuanced process. It is not as black and white as the majoritarian government makes it out to be where it confuses homogeneity with reform," said Shahrukh Alam, a Supreme Court lawyer. "On the one hand, they want to do away with the differences, but on the other hand, they discourage interfaith and inter-caste marriage." Alam said any exercise towards reform should ensure the active participation of Muslim women. "You can't be doing things on their behalf without the presence of Muslim women in the debate," she said. On July 5, the All India Muslim Personal Law Board made written submissions before the Law Commission, opposing the proposal to enact the Uniform Civil Code. The board defended personal laws, saying that under the constitution, "different communities have been made entitled to different rights. Different religions have been given different accommodations.

Muslim women, however, expressed resentment towards community leaders and organisations over their alleged resistance to reforms in the personal laws. "The self-appointed Muslim organisations out to 'preserve' Muslim personal law are actually doing more harm to it by not initiating reforms. The organisations and the government seem to benefit from playing their politics on Muslim women for their own causes," rued Mariam.

She suggested that stakeholders should work to bring in Shariah-compliant reforms for women, as there is a massive diversity of opinions in Islamic jurisprudence. Soman said that the laws in Muslim countries like Morocco and Tunisia can be emulated to make personal laws more gender-just. Khan, too, argued that the Islamic laws need to evolve with time. A thousand four hundred years ago, when Islam began, she said, "it was a religion of social transformation with a futuristic outlook and gave so many rights to women including property rights in a deeply patriarchal society where a girl child was buried alive." Muslims should hold on to those principles to ensure that women get equal rights, including an equal share in the property, Soman and Khan said. (Courtesy: Scroll.in)

#### What is a healthful diet?

The Dietary Guidelines for Americans 2015-2020 recommend that people eat healthful, nutritious foods that are not calorie dense, such as vegetables and whole fruits. Healthful eating patterns tend to include nutrient dense forms of:

• a variety of vegetables in different colours

· legumes, such as beans and peas

• fruits (mostly whole fruits) • protein foods, such as lean meats and poultry, fish and seafood, soy products, and nuts and seeds

•grains (at least half of which are whole grains)

· unsweetened dairy products, such as milk, yogurt, and cheese

• healthful fats, such as olive oil, olives, avocados, and oily fish

The same guidelines also recommend that people limit or avoid certain foods, as follows:

• Limit calories from added sugars to 10% of total daily calories. Processed foods, sweet treats, and sugary drinks all contain added sugars.

• Limit saturated fats to less than 10% of total daily calories. Foods high in saturated fats include butter, cheese, and meat that is not lean.

• Avoid trans fats. Processed foods such as desserts, frozen pizzas, and coffee creamer can contain trans fats.

• Limit sodium to fewer than 2,300 milligrams (mg) daily (for adults).

• Limit alcohol to no more than one drink daily for women and no more than two drinks daily for men.

#### The DASH diet

According to several studies, the Dietary Approaches to Stop Hypertension (DASH) diet can lower blood pressure and may help people lose weight. Rates of high blood pressure, or hypertension, can increase in

women after menopause. One 2017 study indicates that women aged 70 years and over maintain better cognitive function when they adhere to a long-term DASH diet. A 2017 Cochrane review suggests that the DASH diet may also reduce cesarean section incidence in women with gestational diabetes.

Women aged 19-50 years who are moderately active need 2,000-2,200 calories per day. According to the National Heart, Lung, and Blood Institute, based on a 2,000-calorie per day diet, the DASH diet has the following goals for daily and weekly servings of food groups

• 6-8 daily servings of grains • One serving is one slice of bread or half a cup of cooked rice.

The same benefits could also apply to men. A 2020 study of Iranian women suggests that the participants had a 50% lower risk of breast cancer when they adhered to the MIND diet. Migraine is more common in men than women, and one 2020 study suggests that participants following the MIND diet had less frequent, less severe, and

shorter migraine headaches. The MIND diet emphasizes natural, plant-based foods, much like the DASH and Mediterranean diets. It specifi-

cally encourages people to increase their berry and green leafy vegetable intake. The diet also limits animal-

### India's internet shutdowns hurt women more, Manipur assaults show

hen videos of two women being paraded naked and assaulted in Manipur went viral last week on social media, the remote northeastern state had been cut off from internet access for nearly three months.

The attack took place on May 4, but the videos of the women being dragged and groped by armed men before what onlookers say was a gang rape, surfaced last week. Authorities said they are investigating the incident and have ar-

Officials imposed a statewide internet shutdown on May 3, saying it was needed to curb rumours and disinformation, and quell violent ethnic clashes that have killed at least 125 people and displaced tens of thousands. But the internet ban in the state – among the longest in India to date - has made it difficult to alert authorities and journalists to rights violations, many of them directed at women, activists say.

"If there was no internet shutdown, those videos would have surfaced over two months ago and the horror could have been addressed speedily, and other similar offences could have been curbed," said Patricia Mukhim, an activist and editor of the Shillong Times daily headquartered in Meghalaya."The internet shutdown is a violation of human rights - it curtails people's freedom, and it shuts out news of violent incidents and allows perpetrators to carry on undeterred," she told Context. The shutdowns also have an "adverse impact on women's ability to feel safe and restrict their freedom of movement," said Jayshree Bajoria, an associate director at Human Rights Watch in Asia.

"It took a horrific video of violence against women in Manipur to emerge on social media for the authorities to take action. This shows how necessary the internet is for the flow of information, and reporting and documenting abuses," she said.

After the Manipur high court directed the state government to restore the internet in a "limited fashion", authorities on Tuesday said they had "conditionally" lifted the ban on broadband services. Social media websites, WiFi hotspots, virtual private networks (VPNs) and mobile internet - used by a majority of people – still remain blocked in Manipur.India had the most number of shutdowns in the world for the fifth successive year in 2022, according to Access Now, a digital rights group. The shutdowns – including during protests, elections and examinations - were often imposed for indefinite periods and without the publication of shutdown orders, in violation of a 2020 judgment by the nation's top court.

"Authorities have cited violence as part of the rationale for shutting down the internet. However, there is no evidence to show internet shutdowns reduce violence - quite the opposite,' Access Now said in a report in May. The clashes in Manipur, which borders Myanmar, began when members of the Kuki and Naga tribal groups launched a protest on May 3 against the possible sharing of their benefits with the ethnic majority Meiteis in the state. The federal government rushed thousands of paramilitary and army troops to the state of 3.2 million people, but the state has remained tense since, with killings and other incidents of sporadic violence. The restive northeast region is among the least developed in the country, with patchy internet access and facing frequent shutdowns, according to data compiled by the Software Freedom Law Center, a digital rights group.

As more services are digitised under the Digital India programme, internet shutdowns disproportionately hurt rural communities and other vulnerable groups such as those who depend on social welfare benefits, a recent report by Human Rights Watch and the Internet Freedom Foundation (IFF) showed. Toll on women

In addition to shutdowns, Indian authorities also frequently block websites and issue takedown orders to social media platforms. The government issued nearly 7,000 takedown orders of social media posts and accounts last year compared to 6,000 in 2021, according to Access Now.

Most shutdowns involve blocking the internet on mobile phones, which is how most of the population, particularly in rural areas, access the internet. This severely impacts access to education and livelihoods, particularly for rural women, the report by Human Rights Watch and IFF showed.

In Rajasthan, which has had the most internet shutdowns after Kashmir, the majority of workers in the government's rural employment guarantee programme are women. As attendance checks and wage payments for workers have been digitised, frequent internet shutdowns in the state mean that many women don't get to work, or that they don't get paid, said Bajoria.

"Most of the women come from socially and economically marginalised households ... shutdowns that cut off internet access make their situation worse," she said.

In Manipur, the shutdown means that women cannot communicate as easily with their families via WhatsApp, check the news, make and receive payments on the phone, or even recharge their mobile SIMs, said Ninglun Hangal, who works with development non-profits.

Unable to work from home because of the internet ban, Hangal travelled 13 hours to relocate to neighbouring Assam state. But for women forced to stay back, conditions are tough, she said. "There are more rumours and misinformation circulating, and there's no way to check or clarify what is true" she said.

"Women feel isolated and scared for their safety, and it's taking a terrible toll. More cases of assault and abuse are bound to come to light when the internet is restored." (Courtesy: The Wire)

# Russian missiles kill 7 in Ukrainian city and Kyiv accuses Moscow of targeting rescue workers

KYIV, Aug 8 (AP): The death toll from two Russian missile strikes that hit apartment blocks and other buildings in an eastern Ukrainian city climbed to seven, with 81 people injured, authorities said on Tuesday, as officials accused the Kremlin's forces of targeting rescue workers.

Two Russian missiles slammed into the downtown area of Pokrovsk, in the eastern Donetsk region that is partially occupied by Russia, on Monday evening, officials said.

The dead were five civilians. one rescuer and one soldier. Donetsk Gov. Pavlo Kyrylenko said. The wounded were 39 civilians, including two children; 31 police officers; seven emergency workers; and four soldiers.

ISLAMABAD, Aug 8 (PTI): Pakistan's former Prime Minister Imran Khan has been kept in a small bug-infested cell with an open washroom in the high-security Attock jail after his conviction and arrest in a corruption case.

Khan's attorney Naeem Haider Panjotha said that the 70-year-old Pakistan Tehreek-e-Insaf (PTI) Chairman has been provided C-class facilities in the jail in Punjab province

He said the jail cell where the former captain of the country's world cup winning cricket team is being held was infested with flies and bugs.

He is in a small room "which has an open washroom", Panjotha said after meeting Khan in prison on Monday.

"The PTI chairman says he is ready to spend his whole life in jail," the lawyer was quoted as saying by Geo News.

Panjotha said Khan told him that police did not show him an arrest warrant and tried to break the door of his wife's room when they were at his home in Lahore

He met Khan for one hour and 45 minutes in the presence of a jail official to get his signatures on legal paper for launching appeals against the former premier's conviction. The lawyer told the media that Khan informed him that he has been kept in a dark room with an open toilet, frequented by flies during the day and ants at night

"I have been kept in a dark room with no television or newspaper available. Nobody is allowed to meet me as if I am a terrorist," Panjotha quoted Khan as saving.

Khan was arrested from his home in Lahore on Saturday shortly after an Islamabad trial court found him guilty of "corrupt practices" in the Toshakhana corruption case and sentenced him to three years in jail.



He was shifted to Attock jail in the city of Attock in Punjab province, despite the court order directing authorities that he be sent to Adiala prison in Rawalpindi

The court ruling on Saturday came as a blow to Khan and has put his political future in jeopardy.

The verdict came as Pakistan is heading for general elections later this year, with the current National Assembly set to complete its term on August 12.

The cricketer-turned-politician has been accused of illegally selling state gifts for profit worth USD 497,500. Khan has denied wrongdoings, saying he legally bought the gifts from Toshakhana, a government-owned treasure house.

This is the second time in three months that Khan has been arrested.

Earlier, he was arrested on May 9 in Islamabad from the high court's premises in the Al-Qadir Trust corruption case, sparking violent protests by his supporters. Khan faces more than 140 cases across the country and charges like terrorism, violence, blasphemy, corruption and murder.

> SEOUL, Aug 8 (AP): Buses began moving tens of thousands of Scouts to inland venues ahead of a tropical storm Tuesday, bringing an effective end to a World Scout Jamboree that had already struggled with heat, hygiene and land use controversies. Known for its insatiable desire to host international events, the South Korean government scrambled to keep the 12-day gathering of Scouts from land. around the world going as thousands of British and American Scouts departed over the weekend because of

some attendees to be hospitalized. It wasn't until Monday afternoon that officials announced the decision to abandon the coastal campsite in the southwestern town of Buan, after forecasters raised alarms that Tropical Storm Khanun was heading toward

an extreme heat wave that caused

the Korean Peninsula. South Korean officials say the Jamboree will continue in the form of cultural events and activities, including a K-Pop concert in Seoul Friday. Critics have argued the decision to host the Jamboree at a site known as Saemangeum was part of an effort to justify further investment in a controversial swath of reclaimed

Concerns had been raised beforehand about having such large numbers of young people in a vast, treeless area lacking protection from heat. Hundreds of participants were treated for heat-related ailments after the Jamboree began, as South Korea grappled with one of its hottest summers in years.

The government insisted the event was safe enough to continue and

channeled resources to keep the event going, adding medical staff, air-conditioned buses, military shade structures, and hundreds of workers to maintain bathrooms and showers, which some Scouts had complained were filthy or unkempt.

Saemangeum is the result of a 19year project to build a 33-kilometer (21 mile) seawall, which South Korea describes as the world's longest.

Since the wall was finished in 2010, the land remained a largely barren site as local officials pursued plans for highways, ports and an international airport. Once seen as a major development project for a region lacking an industrial base, it's now increasingly viewed as an ecological disaster that wiped out coastal wetlands and hurt fisheries produc-

The Israeli military said its forces entered the Askar refugee camp in the northern West Bank city of Nablus early Tuesday and demolished the apartment of 49-year-old Abdul Fattah Kharushah, an alleged member of the Hamas militant group who was suspected of shooting and killing two Israeli brothers in the town of Hawara earlier this year. The highway shooting on Feb. 26 that killed the two men - brothers from the Jewish settlement of Har Bracha — had followed a deadly Israeli military raid in Nablus and unleashed the worst outburst of settler violence in decades. Israeli settlers went on a violent rampage in the town of Hawara after the shooting, burning dozens of Palestinian cars and shops and leaving one man dead. Kharushah was later killed during an Israeli military raid on the Jenin refugee camp in March.

Young Palestinians burned tires and hurled stones and explosive devices at Israeli forces who stormed into the Askar refugee camp to demolish Kharushah's home, on the third floor of an apartment building, on Tuesday.

### European scientists make it official: July was the hottest month on record by far Powerful storm kills 2 people and leaves 1.1 million without power in eastern US

July's global average temperature of 16.95 degrees Celsius was a 3<sup>rd</sup> of a degree Celsius higher than the previous record set in 2019

COPENHAGEN, Aug 8 (AP): Now that July's sizzling numbers are all in, the European climate monitoring organisation made it official: July 2023 was Earth's hottest month on record by a wide margin.

July's global average temperature of 16.95 degrees Celsius (62.51 degrees Fahrenheit) was a third of a degree Celsius (six tenths of a degree Fahrenheit) higher than the previous record set in 2019, Copernicus Climate Change Service, a division of the European Union's space programme, announced on Tuesday.

Normally global temperature records are broken by hundredths or a tenth of a degree, so this margin is unusual.

"These records have dire consequences for both people and the planet exposed to ever more frequent and intense extreme events," said Copernicus deputy director Samantha Burgess. There have been deadly heat waves in the Southwestern United States and Mexico, Europe and Asia. Scien-



tific quick studies put the blame on humancaused climate change from the burning of coal, oil and natural gas.

Days in July have been hotter than previously recorded from July 2 onwards. It's been so extra warm that Copernicus and the World Meteorological Organisation made the unusual early announcement that it was likely the hottest month days before it ended. Tuesday's calculations made it official.

The month was 1.5 degrees Celsius (2.7 degrees Fahrenheit) warmer than pre-industrial times. In 2015, the nations of the world agreed to try to prevent long-term warming — not individual months or even years, but decades — that is 1.5 degrees warmer than pre-industrial times.

Last month was so hot, it was .7 degrees Celsius (1.3 degrees Fahrenheit) hotter than the average July from 1991 to 2020, Copernicus said. The worlds oceans were half a degree Celsius (0.9 degrees Fahrenheit) warmer than the previous 30 years and the North Atlantic was 1.05 degrees Celsius (1.9 degrees Fahrenheit) hotter than average. Antarctica set record lows for sea ice, 15% below average for this time of year.

Copernicus' records go back to 1940. That temperature would be hotter than any month the US National Oceanic and Atmospheric Administration has recorded and their records go back to 1850. But scientists say it's actually the hottest in a far

longer time period.

"It's a stunning record and makes it quite clearly the warmest month on Earth in ten thousand years," said Stefan Rahmstorf, a climate scientist at the Potsdam Institute for Climate Research in Germany. He wasn't part of the Copernicus team.

Rahmstorf cited studies that use tree rings and other proxies that show present times are the warmest since the beginning of the Holocene Epoch, about 10,000 years ago. And before the Holocene started there was an ice age, so it would be logical to even say this is the warmest record for 120,000 years, he said.

"We should not care about July because it's a record, but because it won't be a record for long," said Imperial College of London climate scientist Friederike Otto. "It's an indicator of how much we have changed the climate. We are living in a very different world, one that our societies are not adapted to live in very well."

### Manipur police files FIR against Assam Rifles for 'obstructing search ops' State BJP unit requests PM to replace paramilitary force Security tightened ahead

IMPHAL, Aug 8 (PTI): Manipur Police has registered an FIR accusing the Assam Rifles of blocking their vehicle after an altercation between the two groups last week, while the state unit of the BJP requested Prime Minister Narendra Modi to replace Assam Rifles "by any other paramilitary force permanently" from the state.

Security sources, however, described the FIR as a "travesty of justice" and said the Assam Rifles was undertaking a task given by the command headquarters of ensuring sanctity of the buffer zones between Kuki and Meitiei areas.

The FIR, a copy of which is with the PTI, was filed on August 5 when police alleged that the Assam Rifles blocked police vehicles on the Kwakta Gothol road in Bishnupur district.

The FIR claimed Assam Rifles stopped its personnel from proceeding when "the state police was on its way to Pholjang Road along Kwakta as follow up action to conduct search operations in an arms act case in search of Kuki militants.

The police claimed that its personnel were stopped by 9 Assam Rifles which parked their 'Casper'

vehicle blocking the road. Defence sources reacted stating "Assam Rifles was undertaking a task given by the command headquarters of ensuring sanctity of the buffer zones between Kuki and Meitiei areas.

In the evening, the Manipur unit of BJP requested Prime Minister Narendra Modi to replace Assam Rifles "by any other paramilitary force permanently" from the state in the interest of the public and also sought his intervention to bring an amicable solution to the ongoing ethnic unrest at the earliest.

In a memorandum to Modi, the party's Manipur unit said, "The role of Assam Rifles in regard to the ethnic unrest and in maintaining peace and tranquility in the state has been under considerable criticism and public outrage."

"Since Day 1 of the violence on May 3, Assam Rifles has failed to maintain neutrality so as to restore peace in the state," the party said, adding, "The public anger and protest over Assam Rifles for playing the role of partisanship in this highly delicate and sensitive ethnic unrest continues to be witnessed unabated...the Assam Rifles has been charged by the public for their



biased role in tackling the situation." The memorandum signed by its president A Sharda Devi and vice-president Chidananda recalled the recent incident when Assam Rifles allegedly blocked a team of the state police who were in pursuit of militants who had killed three civilians. The memorandum comes days after Manipur Police filed an FIR against 9 AR for "disobeying law by public servant with intent to cause injury to any person, obstructing public servant in charge of public function."

In another development, Assam Rifles personnel, based at Moirang Lamkhai checkpoint in Manipur's Bishnupur, where fresh violence erupted last week, have been withdrawn and substituted by the CRPF and the state police, a notification said

The notification, issued by Additional Director General of Police (Law and Order) L Kailun on Monday, said "the checkpoint at Moirang Lamkhai on the Bishnupur to Kangvai Road shall be manned by the civil police and 128

Bn CRPF in place of 9 AR with immediate effect and until further orders". Assam Rifles has been contacted, and a response from the paramilitary force is awaited.

IMPHAL, Aug 8 (PTI): Drugs worth more than ₹ 1,610 crore have been seized by the Assam Rifles between July 2022 and July this year in Manipur, according to data provided by the paramilitary force. In the financial years 2021-22 and 2020-21, it seized drugs worth ₹ 850 crore and ₹ 1,200 crore, respectively.

However, official sources said the Assam Rifles -- a border guarding force -- primary mandate or task is not drug law enforcement.

'That is the responsibility of the NCB (Narcotics Control Bureau) and the state police. However, the routes, conduits, and funding for terrorism, weapons, and drugs are common at times. # K'taka CM orders CID probe into bribery charge against Agriculture Minister

BENGALURU, Aug 8 (PTI): Karnataka chief minister Siddaramaiah on Tuesday said he has directed the CID to investigate the alleged complaint letter sent to Governor Thaawarchand Gehlot by assistant agriculture directors of Mandya district accusing agriculminister N Chaluture varayaswamy of demanding Rs six lakh to Rs eight lakh as bribe.

Seven assistant agriculture directors allegedly wrote a letter to Gehlot recently complaining that the minister was exerting pressure on the officers and employees of the agriculture department through the joint director of agriculture to pay the bribe

They even threatened to commit suicide with their families if such a "tradition" of demanding bribe is not controlled

Accordingly, the Governor sent the letter to Chief Secretary Vandita Sharma to look into the complaint and initiate appropriate action.

While Siddaramaiah called it a fake letter and blamed the BJP and their 'brother', an apparent reference to the JD(S) leader and former chief minister H D Kumaraswamy, for "creating it", he told reporters on Tuesday that he has ordered a probe.

"With regard to the purported letter written by the agriculture officers against the agriculture min-



ister, it has been decided to conduct a CID (Crime Investigation Department) inquiry. The chief minister decided to hand over the matter to the CID after discussing with home minister Dr G Parameshwara," the CM's office said in

a statement. Earlier, in the day, the chief minister told reporters that he had ordered a police inquiry.

"I have told the police to inquire into it. Chaluvarayaswamy has called it fake because the joint director of agriculture has also issued a statement that it is fake and complained to the police. I have told the police to investigate and find out the truth," Siddaramaiah said on the sidelines of an event.

After the Governor's letter became public, Siddaramaiah posted on Twitter, "It has come out that the letter in circulation in public domain is fake. The Joint Agriculture Director has already clarified that no officers in the district have written such a letter." Stating that he will get the mat-

ter investigated, he wondered whether the BJP was behind it. "BJP leaders, are you the creator of such a fake letter spreading slander against the government or your brother?" he tweeted further.

Meanwhile. Kumaraswamy hit out at the chief minister for "supporting" the minister in a series of tweets. "The shameless chief minister who justifies the disgraceful acts of the ministers, has descended upon the state. The 'Siddha Kale' (expert art) of justifying the extortion by the minister is disgusting and nauseating," the JD(S) second-in-command said.

He sought to know if the letter was fake, will the Governor's office "falsely" write to investigate

"Has the Governor responded to the false letter? Should the preachers of 'Rajadharma' suspect the sanctity of 'Raj Bhavan'? This is no compliment to the self-proclaimed pseudo-constitutional expert," Kumaraswamy said.

NEW DELHI, Aug 8 (PTI): Parliament on Tuesday passed a bill that seeks to provide the commander-in-chief and officer-incommand of inter-services organisations disciplinary and administrative powers over personnel from other forces serving in such establishments.

The bill was cleared in Rajya Sabha with a voice vote. Lok Sabha had given its nod to the legislation on August 4. Speaking in the Upper House, Defence Minister Rainath Singh said India is fully prepared to face any type of warfare and the country's defence spending can be increased to 5-6 per cent of GDP if needed.

In his reply to a discussion on The Interservices Organisations (Command, Control and Discipline) Bill, 2023, Singh said the legislation has been brought to keep in tune with the changing nature of modern warfare and ensure better coordination among the three services. "It (warfare) is not conventional now, it has become technology and networkcentric... It is therefore important considering the new challenges, which we and our forces are facing, there is a need for better coordination. This bill has been brought for that purpose only," the defence minister said. Singh further said, "After the passage of this Bill, our inter-services organisations will be able to work in a better way." Replying to a query, he said the country's maritime interests are fully protected and there is no reason for worry.

"Also, we are fully prepared for any type of warfare," he said. This preparedness will continue going forward, Singh asserted. On low defence spending and vacancies in the armed forces, he reiterated all efforts have been made to ensure there are no shortcomings in any form in protecting the country. He said financial resources will not be allowed to be a constraint and, if need be, the defence budget can be increased to even 5-6 per cent of GDP.

MUMBAI, Aug 8 (PTI): The drivers of the private bus operators hired by BEST announced on Tuesday afternoon their decision to call off their strike claiming that Maharashtra Chief Minister Eknath Shinde has assured them of fulfilling their salary hike and other demands.

The move by the contractual staffers will provide relief to lakhs of bus commuters as the agitation had entered the seventh day on Tuesday morning with 551 of the 1,600 buses wet-leased by the Brihanmumbai Electric Supply and Transport Undertaking (BEST) remaining off roads.

A representative of the contractual employees told mediapersons at Azad Maidan that their delegation met CM Shinde after midnight on Monday. Shinde assured that the demands of the agitating employees would be fulfilled, the representative said.

The delegation was led by Pradnya Khajurkar, wife of contractual worker Raghunath Khajurkar, an employee of Daga group, one of the private operators.

"Our primary demands about salary hike, bonus, leaves and free bus rides have been accepted. Hence the strike has been called off," said Vikas Kharmale, cordinator of a group of employees of private bus operators.

The employees, including drivers, of the private bus operators had been agitating over demands, including salary hikes and pay parity with BEST employees.

The BEST undertaking, which provides public bus services in Mumbai and neighbouring areas, has hired more than 1,600 buses from seven contractors on a wet lease model, under which the vehicle ownership, maintenance, fuel and driver costs are the responsibility of the private operator.

The public transport body ferries more than 30 lakh com-

BEST undertaking. "Therefore we announced to call off our agitation. We appeal to all the employees to re-join duty at their respective depots," he said. Kharmale said that the chief minister also assured them that he would personally hold a meeting with the labour commissioner and come out with a solution on Tuesday itself.

According to employees of private bus operators, on the directives of Shinde, former Thane mayor Naresh Mhaske first listened to their demands and then called them for the meeting with the CM on Monday night.

BEST sources said the public transport body was working on alternative arrangements to avoid the inconvenience to commuters had the employees of the private bus operators remained firm on strike despite the state government's intervention

A BEST official, who did not wish to be named, said the civic-run public transport body had sought an additional fleet of buses and some spare drivers from state-run transporter MSRTC to operate buses in the city if the protesting drivers didn't resume work. He further said that acting on BEST's demand and the state government's directive, the Maharashtra State Road Transport Corporation (MSRTC) provided more than 200 buses on Tuesday morning as against their demand of over 300 buses.

Notably, Mumbai guardian minister Mangal Prabhat Lodha on Monday said the affected BEST bus services will be restored in the next 24 to 48 hours.

Commuters have been facing a tough time due to the strike. As the number of buses plying on roads has reduced, the service frequency has been affected, resulting in the buses which are operating being overcrowded.

The association between PM2.5 air pollution and increase in antibiotic resistance has strengthened over time, with enhances in PM2.5

levels leading to larger increases in antibiotic resistance in more recent years, the analysis found using data for 116 countries from 2000 to 2018. Sources of PM2.5 include industrial processes, road transport, and domestic coal and wood burning.

Previous research indicates 90 per cent of the world's population, or 7.3 billion people, are directly exposed to unsafe average annual PM2.5 levels, with 80 per cent of

the leading factors driving antibiotic resistance, accounting for 11 per cent of changes in average antibiotic resistance levels globally, this study found.

Further, every 1 per cent rise in air pollution was linked with an increase in antibiotic resistance of between 0.5 and 1.9 per cent, depending on the pathogen, or the disease-causing microbe, the study covering nine bacterial pathogens and 43 types of antibiotics found. By 2050, levels of antibiotic resistance worldwide could increase by 17 per cent under no changes to current air pollution policies, the authors' modelling suggested. India is expected to experience a 2.5 per cent increase in antibiotic resistance resulting from a 10 per cent increase in yearly PM2.5 levels. In other scenarios, such as increased health spending, controlling air pollution, improving drinking water and reducing antibiotic usage, the level of antibiotic resistance could be greatly reduced, the study said.

For example, limiting PM2.5 to 5 micrograms per cubic metres in the atmosphere (recommended by the World Health Organization) could decrease global antibiotic resistance by 17 per cent by 2050. It could further reduce premature deaths linked to antibiotic resistance by 23 per cent and save USD 640 billion annually, the study said.

"Antibiotic resistance and air pollution are each in their own right among the greatest threats to global health. Until now, we didn't have a clear picture of the possible links between the two, but this work suggests the benefits of controlling air pollution could be twofold: not only will it reduce the harmful effects of poor air quality, it could also play a major role in combatting the rise and spread of antibiotic-resistant bacteria," said lead author Hong Chen, Zhejiang

Future research should investigate underlying mechanisms of how air pollutants impact antibiotic resistance, the study said.

# Kerala assembly adopts resolution against Centre's move to implement UCC

**THIRUVANANTHAPURAM, Aug 8 (PTI):** The Kerala assembly on Tuesday unanimously adopted a resolution urging the BJP-led central government to refrain from implementing the Uniform Civil Code (UCC) in the country.

Earlier in February, the Mizoram assembly had unanimously adopted an official resolution opposing any move to implement the UCC in the country.

On Tuesday, Kerala chief minister Pinarayi Vijayan moved a resolution in the House against the UCC by terming it as a "unilateral and hasty" action on the part of the Centre. Vijayan contended that the UCC as visualised by the Sangh Parivar was not according to the Constitution, rather it was based upon the Hindu legal text 'Manusmriti'.

"That has been made clear by Sangh Parivar long back. They are not trying to implement something that is there in the Constitution. There is no need to misunderstand it like that," he said.

Vijayan contended that the ruling BJP government at the Centre only criminalised the divorce laws under the Muslim personal law, but has not done anything to ensure safety and security of women or take steps for the welfare of the marginalised.

After the resolution was moved

by the chief minister, several ar amendments and modifications were were suggested by the Congressled opposition UDF that welcomed the Left government's te move.

move. sti After taking into account the modifications suggested, the Chief Minister read out the finalised resolution in which he said that the state assembly was concu cerned and dismayed with the Centre's move to impose UCC as it was a unilateral and hasty decision that would take away the sec-

ular character of the country. Vijayan said the Constitution refers to having a general civil law only as a directive principle and it is not mandatory.

He said that when the freedom of religion is guaranteed under Article 25 of the Constitution and includes the right to follow and practice religious personal rules,

any legislation prohibiting that would be a violation of the constitutional right.

The Chief Minister further contended that Article 44 of the Constitution merely states that the State shall endeavor to establish a common civil code.

He said that any such move has to be preceded by debates and discussions to create a consensus among the people and not doing so was concerning. He said that the Kerala assem-

bly too shares this concern and believes that imposition of UCC is a "non-secular move" to attack the unity of the people and the nation as a whole. Vijayan said that even in the

om Constituent Assembly debates, Arinwith regard to the UCC and B R Ambedkar's position at that time was that the Parliament can try to bring a general civil law, but he did not insist that it should be compulsory. "He only indicated a possibility," the Chief Minister contended.

The CPI(M)-led government's decision to move the resolution came amid an ongoing campaign against the UCC by both the ruling Left and the opposition UDF in the state, as well as various religious organisations in the state. Both the fronts had organised

seminars separately in Kozhikode recently against the UCC, in which the representatives of various religious outfits took part. The Law Commission of India

had last month received submissions from the public regarding suggestions on implementing the UCC in the country.

In a recent statement, the Chief Minister alleged that the "electoral agenda" of the BJP was behind raking up the issue of the UCC and urged the Centre to withdraw from the move to impose it.

Vijayan, who is also a senior leader of the CPI(M), has said the Centre's move can only be seen as a plan to implement the "majority communal agenda of 'one nation, one culture' by wiping out the cultural diversity of the country".

"The Central government and the Law Commission should withdraw from the move to impose the Uniform Civil Code," he has said.

### Time right for India to create global norms, benchmarks: Sanjeev Sanyal

**KOLKATA, Aug 8 (PTI):** India should be confident enough to deconstruct the rest of the world on its own terms as a rising economic power, creating global norms and benchmarks in various fields, Sanjeev Sanyal, Member of the Economic Advisory Council to the Prime Minister, said.

Sanyal said India should no longer be bound by benchmarks that are decided by third parties, and in which the country has no role in framing. The noted economist was speaking at the launch of the Sovereign Risk Assessment Framework by CareEdge Ratings here on Monday evening.

"For the very first time, an Indian rating agency will assign sovereign ratings to the rest of the world... This is an important thing for us as a rising economic power to get used to doing. All this while, we allowed other people to deconstruct us; it's time we get confident enough to deconstruct the rest of the world on our

terms," Sanyal said.

He said the country also needs to come up with global norms in various other fields like medical benchmarks and Environmental, Social & Governance (ESG) standards.

"Our political leadership is visible...but we need to begin to create more institutional systems... like our own ESG norms, sovereign ratings, global benchmarks for technology and regulations," Sanyal told PTI. CareEdge Ratings MD and CEO Mehul Pandya said sovereign risk assessments in the post pandemic world have gained added importance, and require a holistic approach.

"Continued rise in government debt, changing composition of global GDP, sustained low global GDP growth and expectation of higher interest rates for longer periods on the back of stubborn inflation are fundamentally altering the credit profiles of sovereigns,"

#### Pandya said.

The agency will likely begin releasing sovereign ratings of individual countries by the end of 2023, after due statutory approvals.

"You can critique the methodology, and the world can look at it and tell us where we can improve... And over time, it will hopefully get adopted by the global community; in a sense we will have an important say in the way the world sees itself," Sanyal said.

The EAC-PM member also took umbrage over the way in which countries like India are ranked in other global indices and benchmarks.

"There are other kinds of ratings, too, where these are completely off kilter... for example you will see India, the world's largest democracy, is placed 102 or 106 or some such absurd ranking in the 'democracy index'. Similar is the case with the 'freedom of speech index' or the 'happiness index'," Sanyal added.

their earnings," said Sarma. The chief minister also said that the government procures rice from farmers at a minimum support price that helps them in earning profits. The process of procuring mustard from farmers has also begun. This will produce a significant amount of oil. Oil dates yield five times more than Mustard. The chief minister said that up to ₹ 3 lakh can be earned from one hectare of land.

The state government plants to promote this cultivation by dividing 18 districts into six zones. He concurred with Sibal's view that Brexit was a political decision but said, "Within

"Every time the prime minister gets up on the floor of the House, he pushes the Congress through the shredder," he said. "The conflagration in Manipur is the result of nearly 50-60 years of strife in; the fact of the matter is the entire issue boiled earlier in the 1980s too," the MP said.

Misra said the home minister had called an all-party meeting on Manipur where he gave an exceptionally detailed analysis of the situation there.

"I believe the central government missed a trick there. The central government asking for the matter to be remanded back to the High Court was a huge error. The central government should have been happy to let the matter rest in the Supreme Court because the public has faith in its judgement," he said.

Misra also urged all parties to each party to give constructive suggestions rather than blaming the central government on Manipur.

Sibal said the repeal was a political decision taken unilaterally by the executive and it cannot be called a decision that was in consonance with the Constitution.

Sibal, who argued through the day, said whether Article 370 was a temporary or permanent provision does not matter now. He said the ultimate question is whether the Union of India can terminate that relationship which was constitutionally recognised under Article 370.

"It is irrelevant. Temporary or permanent does not matter. The manner it was done is a fraud upon the Constitution. It is a politically motivated act. Executive orders are political acts not constitutional acts. Permanent or temporary at the moment is not the issue.

"The reason why I am saying this is because maybe there is a constitutional way of doing it. Though, I am not addressing that (issue) nor have they (Centre) resorted to constitutional methodology. If they resort to it, it will be tested in the court of law," Sibal said.

Sibal has been insisting that Parliament could not have assumed the role of the constituent assembly to repeal Article 370.

He questioned the Centre's decision of dividing the erstwhile state of Jammu and Kashmir into two Union Territories and said the Constitution did not allow it.

"You cannot divide Madhya Pradesh or Bihar into two union territories. This is a representative form of democracy. In this case, where are the voices of people of Jammu and Kashmir? Where is the voice of representative democracy? Five years have passed...have you had any form of representative democracy? This way the whole of India can be converted into Union Territories," he said.

Sibal said though the Constitution is a political document, one cannot manoeuvre or manipulate it as courts are not silent.

"That's not how you interpret a Constitution. It is a political document but you cannot misuse it politically. What is a Constitution? It's a set of values. Values on the basis of which people will represent themselves and their voice will be heard. If you do such executive acts and silence the voices of people, what is left of democracy?

"All I can say is that this is the historic moment, historic not for the present but for the future of India. And I hope this court is not silent," Sibal said while concluding his arguments.

The hearing remained inconclusive and will continue on Wednesday when senior advocate Gopal Subramanian will advance his arguments for the petitioners.

Several petitions challenging abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh- were referred to a Constitution bench in 2019.

The Congress accused Prime Minister Modi of taking a "vow of silence" on issues such as the ethnic violence in Manipur and Chinese incursions, and said opposition parties were forced to bring a no-confidence motion against the government to make him speak up.

# You keep moving and doing what's best: Sushmita Sen on health and career

MUMBAI, Aug 8 (PTI): It may not be easy but the life of an artist is a privileged one, says Bollywood star Sushmita Sen, who credits her job for keeping her motivated whenever she feels down and out.

Sen, who underwent an angioplasty following a massive heart attack in March, said acting is a stronger medicine than all the pills prescribed by the doctors.

"Health is good, because they (doctors) give you that many pills. The work aspect keeps me healthiest. When I'm working, the mind doesn't have the time to think about sad stories or tragedies. You keep moving and doing what's best.

"To be an actor or creative person is not an easy life, but it is a life that most of us are privileged to have. So, every time you are dog tired to the bone, tell yourself 'How many people get this? You are so lucky, shut up and do it'," the 47 year-old-actor

told PTI in an interview here. Sen is back on screen with the JioCinema series "Taali", described as a biographical drama about the story of transgender activist Gauri Sawant, who was born as Ganesh. The show is her second digital outing after her acclaimed web debut "Aarya" on Disney+ Hotstar.

The former Miss Universe, known for films such as "Biwi No 1", "Filhaal", "Maine Pyaar Kyun Kiya" and "Main Hoon Na", said the streaming platforms gave her an opportunity to "grow" as an actor. "I'm a big fan of OTT. I'm one of the

first mainstream actresses to take on OTT at a time when it was not a done thing. I'm glad I did because it allowed me an opportunity to grow and come back to an art form that I love.

"Earlier, it used to be the greatest tragedy, when an actor or actress reached this age,



their careers were long finished, but this is when they know how to bring it to real life. This is the time to be an actor," she said.

Directed by National Award winner Ravi Jadhav of "Natarang" fame, "Taali" is also the first time for Sen playing a real-life character. Portraying a real person on screen can be daunting and the actor said her strategy was to keep it simple.

"One of the key things that we decided when we started 'Taali' was that you cannot try to ape Gauri Sawant, she is strong. We will have to not mimic her, (because) then we will get it wrong... That's how strong that persona is. So, what do we do? "We take the essence of this woman, and all of what she is hiding and she is projecting. What she is hiding is far more powerful because you don't see that on YouTube or Google. You see that when you meet her. That's what I brought to 'Taali', with her

permission," she added.

The upcoming six-episode series needs to be watched as a human story, the actor said.

"Taali' is about reminding ourselves that watch this as a human story, you will be mesmerised with how this could have been your or my story. You don't have to be born into a world like this.

"It's a desire that drives you, the desire is so powerful that you are willing to sacrifice not just an organ but sometimes your life in the process of trying to give it up. They (trans community) need to be recognised as human beings, who feel like us, who hurt like us, who go through mental depression like us, whose lives matter just like us," she said.

To look the part, Sen said she relied on prosthetics and did a thorough homework to get the mannerisms and voice modulation right.



NEW DELHI, Aug 8 (PTI): The Indian men's hockey team has been clubbed alongside archrivals Pakistan and will play the big-ticket match on September 30 in the Asian Games, while the women's side has South Korea and Malaysia among others in its pool. Placed in Group A, besides Pakistan, the Indian men have Asian Games champion Japan, Bangladesh, Singapore and Uzbekistan against whom they will begin their campaign on September 24, while the women' side, who are also in Pool A, will be up against Hong Kong and Singapore besides South Korea and Malaysia.

The Indian women will start their campaign against Singapore on September 27.

"We are placed along with some strong teams in our pool, including Japan, who won the Gold medal at the 2018 Asian Games in Jakarta. But we will treat all teams at par and will not be taking any competition lightly," Harmanpreet Singh, who is currently leading the team at the ongoing Asian Champions

Trophy said in a release. We are already getting a chance to compete with some of these nations at the Asian Champions Trophy and we will look forward to using this experience to our advantage in the future.

'Our coaches have always instilled in us that we need to be prepared for all our rivals. We will study all our opponents for the Hangzhou Asian Games, rewatch all videos to learn about their strengths and weaknesses and prepare our plans accord-

"It was Inzamam who once he came onto the cricket technical committee said Arthur was capable of delivering and would be with the team for most part of the Asia Cup and then wholly for the World Cup and tour to Australia so the PCB should back him."

The insider said Ashraf had a long discussion with Arthur on the advice of Inzamam and matters have now been settled and there would be no change in the team management.

However, there is one area where Inzamam might again face inquisitions over the selection of his nephew Imam ul Haq.

When Inzamam was chief selector the first time, Imam won his Pakistan cap and the former captain had to face a lot of queries on whether his nephew deserved to be picked ahead of other deserving players.

### Extra Pacer's Slot: Unadkat-Shardul set for tie-breaker to get World Cup berth

NEW DELHI, Aug 8 (PTI): The national selection committee will have its task cut out as it would have to choose between Shardul Thakur and Jaydev Unadkat for the extra fast bowler's slot in the 15-member India squad for the World Cup, starting October 5.

As per ICC rule, every team has to submit its initial squad of 15 by September 5 but the final submission can be done by September 27, and a country is allowed to make as many changes as possible between the initial and final submission.

Interestingly, the Australia series ends on September 27, the day of the final submission.

Therefore, one shouldn't be surprised if India carry around 16 to 18 members for both the Asia Cup and Australia home series before zeroing in on the final squad.

So Unadkat and Shardul will certainly get their share of chances during the Asia Cup in Sri Lanka and the three-match home series against Australia (both in September), serving as a pre-cursor to the World Cup. India's World Cup campaign against Australia starts in Chennai on October 8, which is exactly two months from this date, and the squad composition looks far from settled at the moment.

While the availability of injured batters KL Rahul and Shreyas Iyer would certainly make India one of the serious title contenders, it is the bowling combination on low and slow decks which will decide the team's run during the marquee event.

There are two bones of contention -- the extra seamer's slot and the third spinner's spot in the fifteen. But, in the case of speed merchants, it wouldn't be as straightforward as one envisages.

Jasprit Bumrah is coming back from a lower-back stress fracture but even at 80



percent fitness, Bumrah will be playing the World Cup and so will Mohammed Shami and Mohammed Siraj.

With Hardik Pandya also filling up the fourth fast bowler's slot and is expected to bowl at least six to eight overs per game if not 10, the reserve pacer's slot becomes important. In terms of performance and quality, Shardul is way ahead and has again proved his mettle in the Caribbean with eight wickets in three ODIs but Unadkat's advantage is being a left-arm seamer in this set-up.

With Arshdeep Singh, a left-armer with better skill-sets, shunted to the Asian Games T20 squad, Unadkat is very much in the scheme of things as he adds variation despite his lack of pace. Also since the team management has

carried Unadkat for so long, it is imperative that he is considered for the big occasion Another option is Bengal pacer Mukesh

Kumar, who has impressed one and all with his work ethic but even he has been picked for the Asian Games in Hangzhou, which ends on October 7, provided India qualify for the gold medal match.

The third spinner's slot could be a more straightforward choice with Axar Patel miles ahead of Yuzvendra Chahal at the moment, although his skill-set is quite similar to Ravindra Jadeja, who is expected to start in all of India's games.

But Axar's better batting abilities and the team management's distinct lack of interest to try Chahal during the West Indies ODIs is an indicator.

The Indian team management is desperate to get a fully fit KL Rahul during the upcoming Asia Cup in Sri Lanka but the senior Karnataka man, just like his pace bowling colleague Bumrah, will need to do 50-over match simulation ahead of the continental showpiece.

Closer to the World Cup, people in the know of things believe that if all specialist bowlers are fit and available, then it will be a straight tie-breaker between Mumbai's seam bowling all-rounder Shardul

and Saurashtra's left-arm medium pacer Unadkat.

Having completed its round of experimentations during the three-match series against the West Indies, the think-tank won't cast its net any further and if sources are to be believed, they have zeroed in on the core 18-19 members for the World Cup, out of which 15 will be chosen for the tournament proper.

"The selectors and the team management wants to give both Rahul and Shreyas full chance of recovery. Rahul is certainly way ahead in terms of recovery and getting closer to full match fitness.

"But he needs to do match simulation where he is able to keep wickets for 50 overs," a BCCI source told PTI on the condition of anonymity.

"The Instagram videos show that he is doing well but 50 overs of keeping and at least 30 overs of batting in the heat will prove how his operated thigh is holding up in humid conditions.

"If he is able to do well over next nine possible games (six if India play the Asia Cup final plus three against Australia), it will be the best news for the Indian team," he added.

It is expected that India's Asia Cup squad will be selected end of this week or by the middle of next week (latest by August 16-17).

### Semifinals berth sealed, India edge out South Korea 3-2



CHENNAI, Aug 8 (PTI): Their semifinals spot guaranteed, India prevailed over defending champions South Korea 3-2 in their fourth round-robin fixture of the Asian Champions Trophy here on Monday, maintaining their unbeaten run in the continental hockey tournament.

Even before the action got underway at the Mayor Radhakrishnan Hockey Stadium, India had sealed their place in the semi-finals, following Japan's loss to Malaysia earlier in the day.

Both teams began the match on a fast-paced note, playing mainly possession-based hockey.

In the sixth minute, the deadlock was broken by the hosts, as Nilakanta Sharma tapped the ball in after Sukhjeet Singh dribbled the ball past a couple of defenders.

Unfazed by the goal, Korea came up with a couple of chances of their own but the Indian defence was up to the task.

However, the Koreans did not take much time to equalise as Sunghyun Kim hammered it in after Manjae Jung's low pass, in the 12th minute.

In the second quarter, it was all about India as they came up with as many as four chances and scored their second goal in the 23rd minute through a penalty corner.

The PC was successfully converted by Harmanpreet Singh, who hit the ball low to the right of the goalkeeper before beating him. The Indians followed that up with more attacks, including a PC, but to no avail, as they maintained their slim 1-0 lead at half-time. After the restart, Korea squandered a PC earned through video referral, even as Amit Rohidas was green-carded.

However, India came up with an attacking move and it resulted in a field goal by Mandeep Singh, as Shamsher Singh's assist allowed the former to collect it comfortably and fire it in.

Korea received another PC but skipper Jonghyun Jang's shot went wide. It was followed by three chances for India, with Karthi Selvam and Mandeep Singh coming close, as the game moved into the fourth quarter.

Just two minutes into the final quarter, India earned a PC, which ultimately resulted in a penalty stroke. But, Harmanpreet's attempt to go low towards the keeper's right saw his effort being denied.


A minute later, a video referral allowed Korea to gain a PC, which resulted in it earning three more straight PCs. However, Jang failed to convert either of them.

India continued with their attacking intent, with a double save coming from the Korean goalie in the 50th minute off Mandeep and Sukhjeet's shots.

It was followed by another series of PCs for Korea, while they also opted for a review for a possible PC, only to lose it. Finally, in the 58th minute, Jihun Yang found the back of the net through a field goal, keeping the Indians on their toes.

Even as the Koreans looked for the equaliser, the Indian defence managed to hold on to the one-goal lead.

India will next be up against archrival Pakistan on Wednesday, while Korea, who remain in the top-four race, face Malaysia.
