

Assam to conduct special summary revision of electoral rolls

GUWAHATI, Aug 31: The Election Commission of India (ECI) has directed the Assam election department to carry out a special summary revision of electoral rolls in accordance with constituencies post delimitation, chief electoral officer (CEO) Anurag Goel said on Thursday.

Before revision of the electoral rolls, intensive prerevision activities by electoral registration officer (ERO) and 100 per cent physical verification through field machinery are required to be undertaken, Goel said.

New polling stations have to be created while the old ones will have to be mapped in accordance with the new constituencies and voters list will have to be also prepared accordingly, the CEO said.


The entire process will be done with the help of a software and so on the directives of the ECI, both online and offline submissions of forms for correction and inclusion of names have been stopped till November 30, he said. The draft publication of voters list will begin from December 1 and it is only then that these forms will be accepted with the process continuing till the last day of filing of nomination papers for elections, Goel said. The decision on all the forms received will be taken by January 15 and the final voters list will be published on January 31.

The continuous updating of the list will continue till



the last date of filing of nomination for the elections as announced by the ECI.

Meanwhile, the first level checking of voting machines for next year's Lok Sabha polls will begin from Friday and continue till September 29. Goel said a meeting with all national and (CONTD. ON PAGE-9)

## Arunachal MLA urges PM to discuss 'standard map' issue with China during G20 Summit

ITANAGAR, Aug 31: Senior Congress MLA of Arunachal Pradesh Ninong Ering has requested Prime Minister Narendra Modi to raise the issue of China showing Arunachal Pradesh and Aksai Chin as part of its territory in its map, with Chinese President Xi Jinping in the upcoming G20 Summit in New Delhi in September.

Èring who represents the Pasighat West constituency in the Arunachal Pradesh assembly claimed that China had made its claim on territories earlier too.

'This unforeseen, unfortunate yet deliberate incident on the part of China has invoked deep resentment among the people of Arunachal Pradesh. It is in common knowledge that China has earlier too tried to assert its claim over the state by renaming 11 locations in April 2023, 15 locations in

2021 and 6 places in 2017," Ering said in a letter to Modi. China on Monday officially re-

leased the 2023 edition of its "standard map" that claimed Arunachal Pradesh and Aksai Chin as belonging to that country.

.Being an elected representative of Arunachal Pradesh's Pasighat West seat, I appeal to you to discuss this matter of China unilaterally making changes in its map with Chinese President Xi Jinping in the upcoming G20 Summit," Ering said in the letter.

However, it is not yet clear whether Jinping will take part in the summit to be held from September 8 to 10. India on August 29 lodged a strong protest with China over its so-called "standard map" laving claim over Arunachal Pradesh and the Aksai Chin, and asserted (CONTD. ON PAGE-9)

## Himanta flags off mobile forensic vans

HT Bureau GUWAHATI, Aug 31: Chief minister Himanta Biswa Sarma on Thursday flagged off the first batch of mobile forensic vans for the directorate of forensic science. These vans have been introduced to augment the investigative capabilities of the law enforcement agencies in the state.

Sarma flagged off the first batch of seven mobile forensic vans during a ceremony held at the Assam Secretariat Complex in Dispur.

Speaking at the event, Himanta Biswa Sarma said, "I am confident the mobile forensic vans will contribute immensely towards Assam Police's forensic evidence collection capabilities, which in turn would lead to significant increase in conviction rates in days to come. It is often seen that under-trials accused of serious criminal offences go scot free owing to lack of adequate evidence, which is required for conviction.'

"The forensic vans are equipped with state-of-the-art equipments and tools, which will help the law enforcement agencies to reach crime scenes at the earliest and would enable the investigators to collect and securely preserve crucial evidences and ensure that the same are not contaminated," said Sarma.

The state government will allocate sufficient numbers of resource persons and forensic for each of these vans. More such mobile forensic vehicles will be made avail-



#### able to the law enforcement in future.

Speaking on the importance of forensic evidence in convictions under the criminal justice system, Sarma said a robust forensic science regime has to exist to deal with crimes ranging from murder to drug trafficking. ## Video of 'Pragyan' rover rotating released by ISRO Moon mission confirms presence of sulphur in lunar region

BENGALURU, Aug 31: Another instrument onboard the Chandrayaan-3 mission's rover 'Pragyan' has confirmed the presence of sulphur in the lunar region by deploying a different technique, The Indian Space Research Organization (ISRO) said on Thursday.

The Alpha Particle X-ray Spectroscope (APXS) has detected sulphur as well as other minor elements on the moon, the Bengaluru-headquartered national space agency said in a social media post.

"This finding by Ch-3 compels scientists to develop fresh explanations for the source of Sulphur (S) in the area: intrinsic?, volcanic?, meteoritic?,....?" read the post.

ISRO also released a video of the rover rotating in search of a safe route. The rotation was captured by a lander imager camera.

## Two succumb to injuries as fresh firing reported from Manipur



IMPHAL, Aug 31: Two persons succumbed to splinter injuries in Manipur over the past 12 hours even as heavy gunbattle between two groups was reported from Khoirentak foothills in Bishnupur district and Chingphei and Khousabung areas in Churachandpur district on Thursday morning, officials said. According to officials, the fresh round of firing

comes after a few hours of lull since Wednesday evening. A person who sustained bomb splinter injuries on his head in Wednesday's violence died on the way to Guwahati via Mizoram, officials added.

Another injured person, who also sustained splinter injuries, died around 9am on Thursday in Churachandpur district hospital where he was undergoing treatment, officials said.

According to officials, out of the five persons who sustained splinter injuries at Chingphei area on Wednesday evening, three were taken to Churachand-pur district hospital. While one was hit by splinters on his head, the others sustained injuries on their shoulders, legs and back, officials said.

On Tuesday, two men were killed and six injured in separate incidents of violence near Narainsena village in Bishnupur. While one of the victims was killed by a bullet wound, the other died when a countrymade gun he was using misfired and hit him on his face, sources said.

Meanwhile, the Indigenous Tribal Leaders' Forum (ITLF) called for an emergency shutdown in Churachandpur with immediate effect, with the toll in the ongoing violence climbing to four.

Essential services, including water and medical supply, are exempted from the purview of the shutdown, a statement by the ITLF said.

Search operations were conducted by security forces in the fringe and vulnerable areas of Kangpokpi, Thoubal, Churachandpur and Imphal-West districts and recovered 5 arms, (CONTD. ON PAGE-9)

# Hindenburg 2.0: Adani family secretly invested in own shares, alleges OCCRP

**NEW DELHI, Aug 31:** Billion-aire Gautam Adani's group was on Thursday hit by fresh allegations of associates of the promoter family using Mauritius-based 'opaque' investment funds to secretly invest hundreds of millions of dollars to fuel the spectacular rise in group stocks during 2013 to 2018, a charge the conglomerate denied vehemently.


The Organised Crime and Cor-Reporting Project ruption (OCCRP) said documents obtained by it revealed details of a complex offshore operation in two Mauritius-based funds managed by the partners of the promoter family to support prices of shares of group companies from 2013 to 2018 - a period during which the ports-to-energy conglomerate saw meteoric rise to become India's largest and most powerful businesses. OCCRP said two close associates of Vinod Adani -- the elder brother of group founder, and chairman Gautam Adani -- are sole beneficiaries of Mauritius-based companies through which the money appeared to flow.

Nasser Ali Shaban Ahli from the United Arab Emirates and Chang Chung-Ling from Taiwan spent years trading hundreds of millions of dollars worth of Adani group stock through two Mauritius-based funds that were overseen by a Dubai-based company run by a known employee of Vinod Adani.

Market regulator SEBI had been handed evidence in early 2014 of alleged suspicious stock market activity by the Adani Group, OCCRP said citing a letter.

U K Sinha, who headed the Securities and Exchange Board of India (SEBI) in 2014, is now a director and chairperson of Adaniowned news broadcaster NDTV.

The fresh broadside, which comes months after US short-selling firm Hindenburg Research published an explosive report in



January that accused Adani Group of running the "largest con in corporate history", sent all 10 listed Adani stocks down.

Shares of flagship Adani Enterprises Ltd closed 3.72 per cent lower after dipping as much as 5.2 per cent. Other group stocks closed 2-3.5 per cent lower.

Hindenburg had alleged corporate fraud and stock price manipulation at the conglomerate and raised questions on Vinod Adani's role. The Group had denied Hindenburg allegations, which wiped close to USD 150 billion in the market value of the group at its lowest point and cost Gautam Adani his prime spot on the world rich list, and had stated that Vinod Adani has "no role in the day to day affairs" of the company.

On the OCCRP allegations, the Group on Thursday termed them as "recycled allegations" and called them "yet another concerted bid by (George) Soros-funded interests supported by a section of the foreign media to revive the meritless Hindenburg report".

On the allegation of about USD 1 billion of over-invoicing scam money being routed to the two Mauritius funds, it said, "These claims are based on closed cases from a decade ago when the Directorate of Revenue Intelligence

(DRI) probed allegations of overinvoicing, transfer of funds abroad, related party transactions and in-

vestments through FPIs." An independent adjudicating authority and an appellate tribunal had both confirmed that there was no over-valuation and that the transactions were in accordance with applicable law, it said, adding the matter attained finality in March 2023 when the Supreme Court of India ruled in the group's favour. "Clearly, since there was no over-valuation, there is no relevance or foundation for these allegations on transfer of funds," it said. Opposition parties, which stalled proceedings in Parliament for nearly one full session when the Hindenburg allegations first came out, were quick to latch on to the OCCRP to attack the government and Adani group. Congress general secretary Jairam Ramesh questioned the role of SEBI in investigating the role of shell companies linked to the Adani Group.

"Despite the Modi government's best efforts, the truth will not stay suppressed forever. However, the full story about the flow of Benami funds into the Adani Group, how foreign citizens came to play a role

in critical national infrastructure and how PM (Narendra) Modi 'violated rules, regulations and norms

to enrich his close friends' can only be revealed by a JPC," he said. CPI(M) charged that the links of the Gujarat-based business conglomerate with Modi have ensured

no action against it. The documents show that, through the Mauritius funds, they 'spent years buying and selling Adani stock through offshore structures that obscured their involvement - and made considerable profits in the process," the OCCRP said. "They also show that the management company in charge of their investment paid a Vinod Adani company to advise them in their investments.<sup>3</sup>

The trove of documents lays out a complex web of companies that date back to 2010, when Chang Chung-Ling and Nasser Ali Shaban Ahli, who have both been directors of Adani-linked companies, began setting up offshore shell companies in Mauritius, the British Virgin Islands and the United Arab Emirates. Four offshore companies established by them sent hundreds of millions of dollars into a large investment fund in Bermuda called Global Opportunities Fund (GOF), with those monies invested in the Indian stock market from 2013 onwards.

Another layer of opacity was introduced as the money from the duo's offshore companies flowed from GOF into two funds to which GOF subscribed: Emerging India Focus Funds (EIFF) and EM Resurgent Fund (EMRF).

These funds then appear to have spent years acquiring shares in four Adani-listed companies --Adani Enterprises, Adani Ports and Special Economic Zone, Adani Power and Adani Transmission.

The foreign portfolio investors named in the OCCRP report "are already part of the investigation by the Securities and Exchange Board of India (SEBI)", Adani Group said. "As per the Expert Commit-

tee appointed by the Hon'ble Supreme Court, there is no evidence of any breach of the Minimum Public Shareholding (MPS) requirements or manipulation of stock prices."

"These attempts are aimed at, inter alia, generating profits by driving down our stock prices and these short sellers are under investigation by various authorities. As the Supreme Court and SEBI are overseeing these matters, it is vital to respect the ongoing regulatory process," it said. "We have complete faith in the due process of law and remain confident of the quality of our disclosures and corporate governance standards. In light of these facts, the timing of these news reports is suspicious, mischievous and malicious - and we reject these reports in their entirety." PTI had on August 24 reported that the Soros-funded organisation, which calls itself an investigative reporting platform formed by 24 non-profit investigative centres, spread across Europe, Africa, Asia and Latin America, is planning the publication of fresh allegations against a top Indian corporate.

Separately, 360 ONE Asset Management (Mauritius) Ltd said it is the investment manager for Emerging India Focus Fund and EM Resurgent Fund.

Both funds "are fully compliant broad-based funds registered with Financial Services Commission. Mauritius," it said in an exchange filing. "In neither of these two funds, the Adani group or any of the individuals mentioned in the (OCCRP) article, are investors. These funds as on date have zero investments in any of the shares of the Adani Group." It went on to state that in the past among many other portfolio investments; the funds have had investments in shares of Adani Group companies; all of which were sold in 2018. (PTI)

## Sensex falls 256 points due to selling in banking, FMCG shares on F&O expiry



MUMBAI, Aug 31: Benchmark Sensex closed lower by around 256 points in a volatile trade on Thursday, snapping its three-day gaining streak due to selling in banking, FMCG and oil and gas shares amid weak Asian cues. The BSE barometer fell by 255.84 points or 0.39 per cent to close at 64,831.41 points with 22 of its constituents ending in the red.

The index opened higher and later touched a high of 65,178.33 in early trade. It, however, failed to hold onto the gains and plunged 553 points from the day's high to touch a low of 64,723.63 amid selling on the expiry of derivatives contracts for August month.

The broader Nifty of NSE also lost 93.65 points or 0.48 per cent to settle at 19,253.80 with 35 of its stocks ending in the red. "Markets traded volatile on the monthly expiry day and lost nearly half a per cent," Ajit Mishra, SVP, Technical Research, Religare Broking Ltd, said.

"A slew of weak economic indicators from the US, including a softened GDP figure, have heightened the likelihood of a pause in the Fed's rate tightening, resulting in a downward trajectory of bond yields," said Vinod Nair, Head of Research at Geojit Financial Services.

However, this development had a limited impact on domestic sentiment on the day of expiry, with the market experiencing declines ahead of the release of India's GDP data, scheduled later in the day, Nair said.

Asian Paints dropped the most by 1.33 per cent. IndusInd bank fell 1.2 per cent, Axis Bank by 1.19 per cent, SBI by 1.12 per cent, Bajaj Finance by 1.07 per cent, Nestle by 1.04 per cent, and TCS by 0.97 per cent. Hindustan Unilever, Reliance Industries, Power Grid and Kotak Bank also retreated. Maruti Suzuki was the lead gainer, rising by 2.22 per cent. Titan advanced 1.09 per cent, UltraTech Cement by 1.02 per cent, and Tata Steel by 0.78 per cent. Jio Financial Services, Tech Mahindra, Wipro

ICICI Bank and Jio Financia Services also closed higher. In the broader market, the BSE Midcap index edged lower 0.02 per cent while the Smallcap index bucked the weak trend to close 0.79 per cent higher. BSE Oil & Gas dropped by 1.34 per cent, BSE Utilities by 1.28 per cent, Services by 1 per cent, FMCG by 0.71 per cent, and Energy by 0.84 per cent. On the other hand, Consumer Durables (0.89 per cent), Industrials (0.63 per cent) and Realty (0.68 per cent) advanced.

Meanwhile, nine of ten Adani group stocks ended lower on Thursday after a report from investigative reporting platform OCCRP alleged hundreds of millions of dollars were invested in publicly traded group stocks through Mauritius-based 'opaque' investment funds managed by partners of promoter family of billionaire Gautam Adani. The deficit stood at 20.5 per cent of the Budget Estimates (BE) in the corresponding period of the financial year 2022-23.

## Rupee falls 16 paise to settle at 82.79 against US dollar

MUMBAI, Aug 31: The rupee depreciated by 16 paise to settle at 82.79 (provisional) against the US dollar on Thursday, tracking a firm American currency and rising crude oil prices.

Forex traders said that negative sentiment in the equity market and outflow of foreign funds also weighed on the domestic unit. Investors were also awaiting the domestic GDP data which is scheduled to be announced later in the day. At the interbank foreign exchange, the domestic unit opened at 82.65 and moved between the peak of 82.58 and the lowest level of 82.76 during intraday trade.

The Indian currency finally settled at 82.79 (provisional) against the dollar, registering a fall of 16 paise compared to the previous close. On Wednesday, the rupee closed at 82.63 against the dollar. The latest US data indicated that the pace of growth was less than expected, raising hopes for the easing of interest rates by the Federal Reserve.

"We expect the rupee to trade with a slight negative bias on expectations that the US dollar may bounce back amid disappointing European data. Rising crude oil prices and FII outflows may also weigh on the rupee. Month-end dollar demand from importers may also put downside pressure on the domestic unit. However, improved global risk appetite amid expectations of a Chinese stimulus may support riskier assets.

KOLKATA, Aug 31: Tea production in the country increased marginally by 6.2 per cent at 165.01 million kilogramme during July 2023 as compared to 155.29 million kilogramme in previous similar period.

As per the latest Tea Board data, North India tea production during July this year stood at 143.05 million kilogramme, as against 135.77 million kilogramme in the corresponding previous period. Production in South India in July 2023 was also marginally higher at 21.95 million kilogramme as against 19.52 million kilogramme in the previous similar period. The percentage of production by small tea growers (STGs) as a proportion of overall volumes increased to 50.9 per cent in July 2023. Thus was 50.2 per cent in the previous similar month of 2022.

In North India, both Assam and West Bengal registered higher production volumes during July 2023. The premium Darjeeling variety crop was lower at one million kilogramme during July 2023, as against 1.04 million kilogramme in the previous similar period, according to the data. (PTI)

The name of companies who submitted their applications late evening could not be immediately ascertained.

PLI for IT hardware covers laptops, tablets, all-in-one PCs, servers and ultra-small form factor devices. India is wooing global IT and electronics players with policy sweeteners and incentive schemes, making a push to position itself as a global powerhouse for hi-tech manufacturing.

"India is emerging as a trusted supply chain partner and value added partner... companies are happy to come to India for manufacturing and design work," the Minister said at a media briefing. Electronics manufacturing in



India has witnessed consistent growth with 17 per cent Compounded Annual Growth Rate in the last eight years. This year it surpassed a major benchmark in production - USD 105 billion (about ₹ 9 lakh crore).

This indicates that their existence in India predates the arrivals of the Dravidians, Arvans, and any other settlers in the nation. Anthropologist Verrier Elwin expressed this sentiment even more strongly in his words: "These individuals truly embody India's indigenous essence, rendering all others foreign in their presence. With moral rights and claims spanning millennia, these ancient people rightfully deserve utmost respect. Being the first inhabitants, they should hold the foremost place in our considerations.

The other two groupings, which are considerably more recent, encompass the Caucasoid tribes such as the Banjaras, Gujjars, Meenas, and other North Indian tribes, as well as the Sino-Tibetan or Mongoloid tribal communities, primarily concentrated in the northeastern regions, who have migrated relatively recently. These two extensive tribal categories have experienced comparatively better outcomes in the post-Independence era. It is evident that not all Scheduled Tribes are Adivasis. The government recognizes approximately 573 communities as Scheduled Tribes, granting them access to special privileges and reserved positions in legislatures, government roles, universities, and schools. However, the majority of these advantages have been extended to non-Adi-

vasi tribal groups. The Adivasis of India, much like indigenous populations worldwide, have suffered the devastating consequences of later groups purporting to be more "civilized." Regrettably, they have emerged as the most marginalized and oppressed segment of the population. a parallel effort, the UPA government developed the Scheduled Tribes (Recognition of Forest Rights) Bill in 2005, but implementation was halted due to pressure exerted by self-proclaimed wildlife advocates and the wildlife tourism industry.

The time since Independence and the unfulfilled commitments of the Constitution has seen considerable change. However, there remains a chance to reclaim some of the original pledges. As outlined by the Constitution, all regions with a tribal majority should be consolidated into administrative units, overseen by institutions democratically elected by the people. This collective entity might be termed the Adivasi Maha-panchavat. empowered to operate as a predominantly self-governing body. State legislations should be subject to approval by the Maha-panchayat, en-

suring its satisfaction. In lieu of governance centered in state capitals, responsibilities regarding education, healthcare, irrigation, roadways, and land records should be entrusted to local administrative structures. Additionally, local elected officials should hold the police accountable, curtailing any tendency to function outside the bounds of the

People's Republic of China mutually agree to cut military spending, shifting the money to combatting global warming.

Sanders made his proposal in an Op-ed in The Guardian on August 21. But when he proposed a 10% cut—at least \$90 billion—on July 27 during Senate debate on the annual U.S. military money bill, he lost by an 88-11 margin.

The only response in that brief debate came from Senate Armed Services Committee Chairman Jack Reed, D-R.I. "The senator's amendment excludes defence health programs, military personnel accounts, and assistance to Ukraine, but that means the actual cuts on every other function will be much greater than 10%," said Reed.

The Senate rebuke didn't stop Sanders, a longtime foe of bloated military spending and champion of environmental causes. He repeatedly points out the U.S. outspends every other nation on its military, that the Defence Department can't pass an audit, and that the Pentagon is a cash cow for military contractors, whose weapons eat up approximately half of the military money.

In that brief Senate debate, Sanders cited unmet domestic priorities and Pentagon waste as well as combatting global warming as reasons for the cut. In the Guardian op-ed, he stuck to fighting that threat, but put it in context of "a radical rethinking" of global relationships, especially between the two powers. "The U.S. and China must unite to

fight the climate crisis, not each other," Sanders wrote. It's "absolutely necessary for the survival of the planet." But "the cooperation required to address this existential threat is being undermined by hawks...who are moving us toward a disastrous cold war."

That's a criticism of Democratic U.S. President Joe Biden, who, like Sanders, grew up in the Cold War era, but when the USSR was the main target. Both men were born in 1941. Biden has kept that Cold War era mindset, but with China now substituted as a sometime antagonist. both militarily and on trade. Sanders did not propose a specific cut in each power's military spending, but if the Chinese matched his 10% proposal, their reduction would be around \$30

should be "part of a radical rethinking of geopolitics to reflect the reality that international cooperation is not only in the best interests of all countries. but is absolutely necessary for the survival of the planet," said Sanders, a longtime campaigner, starting in college decades ago, against U.S. wars abroad.

"Here's the reality. The last eight years have been the eight hottest on record. This year is on track to be the hottest year in recorded history, and this past July was the hottest month on record. Across the United States. July broke more than 3.200 daily temperature records and dozens of American cities broke or tied their previous daily temperature records three or more times.

"Phoenix experienced 31 days in a row at or above 110F, 13 days longer than the previous record. El Paso, Miami, Austin and many other places also suffered under record-breaking stretches of extreme heat. South of Miami, [Atlantic] waters reached 101F. You're supposed to find temperatures like that in a hot tub, not the ocean.

"But it's not just the U.S. that is dealing with record-breaking heatwaves and enormous climate-caused devastation. China experienced record-high temperatures last month, including the country's all-time temperature record of 126F, and recent flooding has killed about 100 people, destroyed nearly 200,000 homes, displaced some 1.5 million people and caused more than \$13 billion in dam-

"Into the future, scientists tell us that great cities like Shanghai and New York will be underwater if we do not act effectively against the climate crisis." Global warming is truly global, the senator noted. "In Iran, the heat index hit 158F, testing the limits of human survival. Cuba, the Dominican Republic, and El Salvador all saw temperature records fall. It's winter right now in South America, but that hasn't stopped temperatures from exceeding 100F."

All this evidence of global warming cries out for spending money to combat it, first and foremost, he said. The U.S., under Biden, has started with \$300 billion in last year's Inflation Reduction Act, but must do more, Sanders added. China spent almost double that last year—\$546 billiongoal is cutting a deal to reduce arms spending and use the freed-up funds to combat the "existential threat" to the world.

"Organizing most of our national effort around a zero-sum global confrontation with China...will alienate allies and partners," Sanders warned. "Most importantly, it could doom our planet by making climate cooperation impossible between the world's two largest greenhouse emitters. We need to move in a bold new direction."

The senator then offered what he called "a 'radical' idea." Instead of spending enormous amounts of money planning for a war against each other, the U.S. and China should agree to "mutually cut their military budgets and use the savings to move aggressively to improve energy efficiency, move toward sustainable energy, and end our reliance on fossil fuels. They should also provide increased support for developing countries who are suffering from the climate crisis through no fault of their own.'

Sanders forecast reaching such an agreement would face opposition from "establishment politicians" and special interests in the U.S.

"My response is this: Go talk to the people in Vermont who lost their homes because of unprecedented flooding and the families in Hawaii who lost loved ones in the recent fires. Go talk to the more than one million people in China who have been displaced by catastrophic floods. Go talk to the people in southern Africa who are starving because of the terrible drought and floods they are experiencing or farmers around the world who can no longer grow their crops because of water shortages.

"Perhaps most importantly, go talk to the hundreds of millions of young people in every country on earth who are losing hope, wondering whether they should even have children of their own, given the enormous challenges the climate crisis poses for a normal life.

He then recalled the words of the late Nelson Mandela, who famously remarked, "It always seems impossible until it's done." Sanders then concluded by taking up the challenge: "If we are to save the planet, now is the time for bold action. Let's do it." (IPA Service)

## China's submarine activities in the Bay of Bengal: Considerations for India

n the last few years, China has been instrumental in developing Lthe underwater naval capacities of a number of the littoral countries outlining the Bay of Bengal. Most recently, it helped construct the BNS Sheikh Hasina-Bangladesh's first submarine base, worth US\$1.2 billion, at Pekua in the Cox's Bazaar district of Chittagong, which was inaugurated in March 2023. It is built with the capacity to dock six submarines and eight warships simultaneously, as a part of Bangladesh's 'Forces Goal 2030', to expand and modernise the country's defences. At present, it will station Dhaka's two submarines, BNS Navajatra and BNS Joyjatra, also acquired from Beijing, six years ago in 2017. In 2021, China delivered a Type 035 or Ming class diesel-electric attack submarine, formerly used by the People's Liberation Army Navy (PLAN), to Myanmar.

Thailand had also agreed to purchase three submarines from Beijing in 2017, for the price of two, along with an extended quality guarantee, communications, combat systems and training programmes for the Thai personnel. However, the order was reduced to one submarine, as the Thai government faced criticisms from the Opposition and its populace for its exorbitant defence expenditure in the face of the pandemic's detrimental impact on the Thai economy. The growing unease in Thai society, about an overt reliance on China culminating in its growing strategic influence, especially after witnessing the Hambantota case in Sri Lanka, may have also led to the reduced deal.

Currently, the single order is also in jeopardy as a German company appointed to provide a propulsion system necessary for the submarine has stated its inability, owing to Germany's limited defence export to China, following the European Union (EU) embargo. Subsequently, the Thai Opposition has proposed that scrapping the deal would be in the country's best interests. Indeed, these submarine deals with Bay littorals, have sparked much contemplation about Beijing's intentions in these waters, especially as India is also trying to develop the submarine capacities of its Eastern Naval Command to better secure the Bay, which it considers to be one of its 'primary areas of interest'.

China's interest in the Bay

Sino-Indian competition has been one of the defining features of the Bay of Bengal's strategic resurgence in recent years, as India tries to retain its prominence as a resident power, in the face of China's deepening footprint in the region. In a future riddled with energy uncertainty, the lure of the Bay is undeniable for Beijing, as not only is the maritime space home to a vast repository of hydrocarbons, but it is also traversed by important sea lanes of communication, that are used to ferry critical energy imports from the Middle East to the countries of East Asia.

Most important among these, is the East-West shipping route, which passes along eight nautical miles below India's Andaman and Nicobar Islands in the Bay, before entering the chokepoint of the Strait of Malacca, connecting Europe and Africa with Asia. The Bay's proximity to the Strait of Malacca is one of the cardinal reasons for China's interest in this maritime space as it suffers from the "Malacca Dilemma". This refers to Beijing's apprehensions about any blockages in this narrow chokepoint, which would hinder the passage of almost 80 percent of its imports, thereby negatively affecting the country. Consequently, China wants to maintain a strong presence in the Bay to ensure that its energy supply remains uninterrupted and thereby its growth unfettered. Accordingly, it is keen to strengthen ties with the Bay littoral countries, a manifestation of which is the submarine deals.

Beijing?

Indeed, as rapidly growing economies, most countries belonging to this region, are intent on expanding their defence capacities and are therefore attracted to purchase Chinese naval crafts as these are competitively priced. The acquisition of the submarines has allowed the Bangladesh Navy in particular to become a 'threedimensional force', by adding the under-sea leg, to the pre-existing surface-level operations and naval aviation wing.

Dhaka's agenda is to not only become self-reliant in protecting its sovereignty as well as its sizeable maritime resources but also to play a leading role in furthering regional security. In a way, this will complement India's efforts to maintain security and stability in the Bay of Bengal, as it undertakes coordinated patrols with Bangladesh and the latter also participates in India's multilateral naval exercise- MILAN, that is held in this maritime space. However, there is also a cause of concern for India, as the possible operation of Bangladesh's submarines by Chinese sailors, brings them near India's Exclusive Economic Zones (EEZs) in the Bay, thereby providing Beijing with an opportunity to gather more information to aid Chinese submarine operations in the re-

It is important to note here that, China's request to dock submarines in Sri Lanka, was declined in 2017 by the island nation as it prepared to welcome the Indian Prime Minister Narendra Modi on his official visit. The refusal came as a sign of Sri Lanka's solidarity with India, especially as in 2014, Colombo's decision to harbour a Chinese submarine had sparked fierce opposition from India given its apprehension of China's growing activity, in its area of interest. However, a rise in the docking of submarine tender ships in Sri Lankan ports, suggests the presence of PLAN submarines in Sri Lanka's near-seas, particularly for the collection of hydrological and bathymetric data and the training of submarine crews. Since 2019, PLAN survey ships such as the Xiang Yang Hong 03 have surveyed the deep waters of the Bay of Bengal for better submarine operations.

In a recent development, it has also been reported by the Indian media that China is allegedly building monitoring and surveillance facilities at Myanmar's Coco Islands in Bay, from where it can track India's missile launches off the Balasore test range in Odisha, as well as the movements of India's first nuclear submarine stationed at the Rambili naval base, 50 km south of Visakhapatnam on the country's eastern seaboard. The Coco

Islands, are also located close to India's Andaman and Nicobar Islands where the Army, Navy and Airforce integrated, serve as the country's Far Eastern Tri-command. However, the Myanmar junta government has denied claims of Chinese involvement in the Coco Islands and dismissed India's apprehensions.

#### A cautionary for India

China's proactive presence in South Asia has undoubtedly complicated the situation for India, especially since its underwater naval capacities are yet to be optimally developed. Observers maintain that the deficit between the Indian and the Chinese navies is exceptionally stark in the undersea domain, as there continue to be asymmetries in the budget and warship-building capacities of the two countries. Despite the induction of five Scorpene (Kalvari) class submarines, the Indian Navy continues to be eight boats short of the 24 that were scheduled for induction by 2030, as per the Navy's 2012-27 Maritime Capability Perspective Plan. The older Kilo and HDW/Shishumar class boats are also still pending their decommissioning

Beyond military capacity building, the need for underwater domain awareness is also more than ever before, for India to be truly cognizant of Chinese activities in the Bay. In 2019, India Today reported, that a Chinese maritime research and survey ship had been spotted carrying out research activities, in India's EEZ near the Andaman and Nicobar Islands without its consent.

Seemingly, the vessel could have been used "to monitor all underwater and surface vessels of the Indian Navy stationed in the region." This marks a violation, not only of India's legislation (Act No. 80/1976) "that requires foreign marine scientific vessels to seek licence before undertaking activities," but also of the 1982 United Nations Convention on the Laws of the Sea (UNCLOS), which makes it necessary for countries to abide by the laws of the coastal state to which the EEZ belongs (Part V, Article 58). The UNCLOS also prohibits foreign marine scientific research and hydrographic survey ships undertaking transit passage through straits that are used for international navigation between one part of an EEZ to another, from carrying out any research or survey without the prior authorisation of the necessary coastal state (Section 2, Article 40), This was consistent with the Indian Navy's statement at that time; "if you have to do anything in our EEZ, you have to notify us and take permission." In its defence, China maintained that it was only taking innocent passage through the Indian EEZ, which the UNCLOS permits.

While Beijing claims that its surveys serve global scientific research, the purpose may well be to gauge the operational conditions for its submarine activity or detect anti-submarine warcraft. The need of the hour for India is therefore three-fold; first, to expedite the development of its underwater naval capacities: second, to enhance defence cooperation with other Bay littorals, to ascertain that their resources and territories are not used for purposes that are detrimental to India's security; and lastly, to devise measures to improve its underwater domain awareness, such as developing the surveillance capacities in the Andaman Nicobar Islands, overlooking the Strait of Malacca. This will help identify Chinese submarines passing through it into the Bay of Bengal, as the vessels will have to surface for safe navigation due to the shallow depth of the chokepoint. It is promising to note that the Indian Ministry of Defence has already designed a military acquisition initiative. Project 75-I, for the planned procurement of diesel-electric submarines for the Indian Navy, and is also drawing up "a plan for the indigenous construction of nuclear attack submarines." These endeavours need to be realised and implemented with alacrity. (Courtesy: ORF)

Importantly, the acceleration has grave ramifications for India's border defence and national security.

New Delhi has reasons to worry as the motive behind President Xi Jinping's government expediting the boundary talks with Bhutan is to compel it to formally and officially hand over Doklam to China as quickly as possible.

Remember Doklam?

#### China's coercive diplomacy with Bhutan

The plateau at the tri-junction of India, Bhutan, and China witnessed a dangerous standoff in 2017 after Indian troops clashed with Chinese troops and stopped them from constructing a road on Bhutan's soil as it posed a threat to India's defence.

Six years ago, soldiers of the two nuclear-armed nations withdrew from Doklam after a stalemate lasting over two tension-filled months as South Asia held its breath.

Now, China wants Doklam on a platter by browbeating Bhutan — one of the world's smallest countries nestling in the Himalayas — into parting with it through coercive diplomacy.

China's boundary talks with Bhutan, in geopolitical terms, are aimed at India and India alone. Beijing is piling pressure on Thimphu, but its objective is to harass and intimidate India which is undoubtedly a cause for concern.

It's another matter that Prime Minister Narendra Modi's government not only has its ear to the ground but is mentally prepared to do everything and more to ensure that Bhutan doesn't buckle under tremendous pressure and signs away Doklam to get Beijing off its back. The strategic importance of Doklam, which has been a part of Bhutan until now, for both China and India can't be over-emphasised. If China wrests control of Doklam, the People's Liberation Army (PLA) can easily overrun the "Siliguri Corridor", a thin strip of Indian territory linking the mainland to the northeastern region.

#### The strategic importance of Doklam

Doklam borders the "Siliguri Corridor", also known as the "chicken's neck" because it is as narrow as 22 km, underlining its vulnerability in the event of a limited invasion. That's why the takeover of Doklam is such a priority and a mouth-watering proposition for Beijing. Conversely, New Delhi simply can't let China gain such a crucial military advantage over India under any circumstances.

If the northeast is cut off from the rest of India, the PLA can swoop down and annex Arunachal Pradesh which China illegally claims as an extension of south Tibet. Even the latest standard map released by Beijing this week shows Arunachal Pradesh within China.

Fundamentally, India would be at the receiving end every which way if Bhutan agrees to give Doklam to China.

For years, China has been preparing the grounds

Today, China's urgency to bag Doklam is manifested in the increased frequency of China-Bhutan Expert Group Meetings (which handle border talks) in 2023. The 13th EGM was held from 21-24 August in Beijing.

The 12th EGM took place in May in Thimphu only four months after the 11th EGM was held in Kunming in China's Yunnan province in January. In contrast to three successive engagements so far this year, the 10th EGM was held way back in April 2021, laying bare China's tearing hurry in 2023 after a long lull of 20 months in boundary negotiations.

That China is bent upon forcing the pace of talks is also borne out by the establishment of a Joint Technical Team which held its first meeting on the margins of the 13th EGM and has been officially described as an "important outcome". Moreover, an announcement was made to hold the 14th EGM as soon as possible to "keep up the positive momentum."

For India-China: Ladakh, G20, and now Doklam Significantly, China wants to grab Doklam by bullying Bhutan even as there is no resolution of the China-India conflict triggered in April-May 2020 by the PLA's territorial aggression in Ladakh. External Affairs Minister S Jaishankar keeps describing the situation at the China-India frontier as "abnormal". The dispute is so complicated that the two sides don't agree even on how long the border is. India insists that the border is 3488 km long while China says it is only 2000 km.

And after last week's Xi-Modi meeting in Johannesburg, Beijing promptly declared it was held on Modi's request to show India in poor light as a supplicant.

Additionally, there is no confirmation yet of X's in-person participation in the G-20 Leaders' Summit India is hosting early next month. Contrast this with US President Je Biden's announcement that he would be in New Delhi from 7 to 10 September for the grand G-20 event.

But the suspense over Xi is giving India no respite.As far as China's obsessive overdrive to take control of Doklam is concerned, India should use the carrot-and-stick policy to keep Bhutan on a tight leash so that it holds its own and doesn't capitulate.

And, if necessary, India should not hesitate to get its partners in the Indo-Pacific grouping Quad — US, Australia, and Japan — to call out Beijing for bullying Bhutan and express solidarity with Thimphu and New Delhi. (*Courtesy: The Quint*)

head of the third meet of the Indian National Developmental Inclusive Alliance – INDIA – at Mumbai on August 31 and September 1, Bihar chief minister Nitish Kumar has said that the caste survey in Bihar has been completed. "Its data is being compiled. It will be

published soon," Nitish said.

His remarks coincided with the Narendra Modi government filing two successive affidavits in the Supreme Court with regard to its stand about the caste survey in Bihar. The Union government, in paragraph five of its first affidavit on Monday, August 28, said; "Only the Centre can conduct a census or any action akin to census".

Hours later, it purged this remark in another affidavit, saying that the paragraph had "inadvertently crept in" and, as such it had no objection against the caste survey in Bihar.

The Union government's action has sparked a massive row with INDIA leaders – mainly those of the Rashtriya Janata Dal and Janata Dal (United) – hitting out at Prime Minister Modi and the Bharatiya Janata Party. The opposition leaders accused the government of continuously conspiring against the interests of Dalits and backward classes of the country.

"The Rashtriya Swayamsevak Sangh-BJP represents the forces that have perpetrated atrocities on the poor for centuries and are still doing it. The poor people have understood Modi's machinations now. They are determined to drive Modi out of power in 2024", the RJD supremo Lalu Prasad Yadav told this writer ahead of leaving for Mumbai.

<sup>7</sup> The Prime Minister's Office (PMO) is playing every trick in its bag to impede the caste survey in Bihar. I appeal to him to correct his anti-poor mindset", the RJD's national spokesman Manoj Jha said.

Bihar deputy CM Tejashwi Yadav said, "The BJP's conspiracy has been exposed. It's utterly scared now".

#### **BJP's worries**

Apart from Hindutva and its continuous hate campaign against minorities, what has benefitted the BJP at the elections most, particularly 2014 onwards, is the shift of the major chunk of the backward classes and Dalits votes to it in the Hindi heartland comprising Uttar Pradesh, Madhya Pradesh, Rajasthan and Bihar.

The implementation of the Mandal Commission report in the 1990s led the regional parties – Samajwadi Party in Uttar Pradesh and Janata Dal in Bihar – to have complete sway over the Other Backward Classes or OBC voters who broadly constituted about 60% of the votes in these regions.

However, these regional parties in Bihar and UP suffered multiple splits and the BJP eventually got many of these splinter groups in its fold. The Hindutva party's work was relatively easy in Madhya Pradesh and Rajasthan because these states did not have strong regional parties and the BJP was locked in direct contest with the Congress, which did not play OBC politics. In addition to that, the RSS cadres worked meticulously at the ground level to incorporate the non-Yadav OBCs and non-Jatav Dalits in Uttar Pradesh in the Hindutva fold. In Bihar, RSS's comparative lack of success notwithstanding, the BJP was indirectly benefited by the extremely backward classes (EBCs) and Dalits voting for the JD(U), with which it was in an alliance.

The statistics gathered by a CSDS survey suggests that only 17 % of OBCs had voted for BJP in 1996 Lok Sabha elections. The figures largely remained the same in the 2004 and 2009 elections. However, the BJP got 43% of the OBC votes in the 2014 elections. The Hindutva party's OBCs vote share further swelled with 48% of them voting for it in 2019 polls.

In fact, perhaps recognising the importance of OBCs votes for his party, the PM announced the Vishwakarma Yojna in his Independence Day address, his last ahead of the 2024 polls. The scheme involves giving financial and technological help to ironsmiths, wood workers, goldsmiths and others engaged in leather and aluminiumrelated occupations in rural India. **Caste survey** 

In such a backdrop, the caste survey acts as a tool for Nitish Kumar to take on the BJP's clout among OBCs and bring them

the grand alliance in August 2022 paved the way for the caste survey in the state with the RJD and his deputy Tejashwi supporting it. The survey is also putting pressure on the Union government to carry out caste census at the national level. It has also led to Nitish cementing his proximity with the Samajwadi Party under Akhilesh Yadav. Yadav has suffered heavily on account of losing his non-Yadav OBC votes to the BJP in his state.

The RSS-BJP is known to have caste Hindus – Brahmins and Banias (business communities) – at the core of its socio-political base. The RSS invariably has had Chitpavans – a sub-caste of the Brahmins – heading it ever since its formation in 1925. The upper crust of the BJP too is layered with caste Hindus.

"The BJP's work for the backwards and marginalised sections is only peripheral and cosmetic in nature. The Samajwadi Party is highly appreciative of the caste survey in Bihar and has continuously been demanding the Union government conduct a caste census at the national level too," the senior Samajwadi Party leader and professor at Lucknow University, Sudhir Panwar, said.

The BJP, ostensibly, had supported Nitish when he had moved the resolution for the caste survey in the Bihar legislature. The party also supported the alliance parties' representatives in their meeting with the PM to demand a caste census early last year. But the party got jittery when the Nitish government set in motion the process. Outwardly, BJP leaders kept speaking in favour of the caste survey but the saffron cadres led a covert operation to ensure it did not happen.

The Hindu Sena, Akhilesh Kumar and others were among seven groups and individuals – all directly or indirectly associated with the RSS – who challenged the caste survey in the Patna high court on the ground that it would "imperil the unity and integrity" of India. The Patna HC initially put an interim stay on the survey but later allowed it.

These RSS cadres and sympathisers then challenged the HC's order in the Supreme Court. The PMO was, apparently, exposed when the Solicitor General of India Tushar Mehta questioned the caste survey in Bihar on August 21 and said that the government would file an affidavit to that effect in the SC.

The government did file the affidavit but dithered on it. Clearly, the BJP is in a state of confusion on a sensitive issue that might dominate the discourse of 2024 elections. (*Courtesy: The Wire*)

## Ousting of Gabon's unpopular leader was a 'smokescreen' for soldiers to seize power, analysts say

DAKAR (SENEGAL), Aug 31: Gabonese awoke Thursday to a new military leader after mutinous soldiers ousted a president whose family had ruled the oil-rich Central African nation for more than five decades.

The new leader is Gen. Brice Clotaire Oligui Nguema, head of the elite republican guard unit, soldiers announced on state TV Wednesday hours after President Ali Bongo Ondimba was declared winner of last week's presidential election, which Gabonese and observers say was marred with irregularities and a lack of transparency.

The soldiers accused Bongo of irresponsible governance that risked leading the country into chaos and have put him under house arrest and detained several

people in his cabinet, they said. While there were legitimate grievances about the vote and Bongo's rule, his ousting is just a pretext to claim power for themselves, Gabon experts say.

"The timing of the coup, following the announcement of the implausible electoral results, and the speed with which the junta is moving suggests this was planned in advance," said Joseph Siegle, director of research at the Africa Centre for Strategic Studies.

"While there are many legitimate grievances about the vote and Bongo's rule, that has little to do with the coup attempt in Gabon. Raising those grievances is just a smokescreen," he said.

Gabon's coup is the eighth military takeover in Central and West Africa in



three years and comes roughly a month after Niger's democratically elected president was ousted. Unlike Niger and neighbouring Burk-

ina Faso and Mali, which have each had two coups apiece since 2020 and are being overrun by extremist violence, Gabon was seen as relatively stable. However, Bongo's family has been accused of endemic corruption and not letting the country's oil wealth trickle down to the population of some 2 million people. Bongo 64, has served two terms since coming to power in 2009 after the death of his father, who ruled the country for 41 years, and there has been widespread discontent with his reign.

Another group of mutinous soldiers attempted a coup in 2019 but was quickly overpowered. The former French colony is a member of OPEC, but its oil wealth and nearly 40 per cent of Gabonese aged 15 to 24 were out of work in 2020, according to the World Bank. Its oil export revenue was USD 6 billion in 2022, ac-

cording to the US Energy Information Administration

Gabon's coup and the overturning of a dynastic leader, such as Bongo, appeared to have struck a nerve across the continent that coups in more remote, volatile West Africa previously hadn't.

Hours after soldiers in Gabon announced the new leader, president of neighbouring Cameroon, Paul Biya, who's been in power for 40 years, shuffled his military leadership, and Rwandan President Paul Kagame "accepted the resignation" of a dozen generals and more than 80 other senior military officers. Even Djibouti's Ismail Omar Guelleh, in power in the tiny former French colony in the Horn of Africa since 1999, condemned the coup in Gabon and

denounced the recent trend of military takeovers.

Still, on Wednesday, White House National Security Council spokesman John Kirby said it was too early to call the attempted coup in Gabon a trend.

"It's just too soon to do a table slap here and say, yep, we've got a trend here going' or yep, we've got a domino effect," he said. Since Bongo was toppled, the streets of Gabon's capital, Libreville, have been jubilant with people celebrating alongside the army.

"Today we can only be happy," said John Nze, a resident. "The country's past situation handicapped everyone. There were no jobs. If the Gabonese are happy, it's because they were hurting under the Bongos". (AP)

## At least 70 people killed in fire in multi-storey building in Johannesburg

JOHANNESBURG, Aug 31: A least 70 people were killed and 43 others injured after a massive fire broke out on Thursday in a multistorey building occupied by migrants in the central business district here in South Africa's biggest city, emergency services said.Authorities said it was unclear what sparked the blaze at the fivestorey building in the city centre.

City of Johannesburg emergency services spokesperson Robert Mulaudzi said firefighters were alerted to the fire in a building on the corner of Delvers and Alberts streets at about 1:30 a.m.

Dozens of emergency and rescue workers are still on the scene as bodies continue to be brought out. "We managed to evacuate the people who were inside the building as soon as we arrived while we were conducting firefighting operations," Mulaudzi said, adding that most of those treated for injuries had suffered smoke inhalation or minor injuries. Mulaudzi said arrangements were being made to accommodate those who had been

left homeless by the incident. The fire gutted the building. A total of 70 bodies were recovered and 43

were injured in the fire, Mulaudzi said. A video posted by Mulaudzi on X, formerly known as Twitter, showed fire trucks and ambulances outside the building with burnt-out windows. A toddler was among the floors," deceased. Of the injured, some suffered smoke inhalation with others sustaining minor injuries. Mulaudzi said the fire had been

contained and that they were busy with "damping down" as well as search and recovery operations. He said the death toll may in-

crease because there was an informal settlement inside the building which may have resulted in people being trapped while trying to flee. "Every floor has an informal settlement, and those that were trying to evacuate were trapped because of the structures between the the News24 website

quoted Mulaudzi as saying. "We have informed people who are at the scene looking for their relatives that chances of finding them alive are very slim." The building is one of many in the once bustling district of Johannesburg that has been hijacked by criminal elements who

then let them out to desperate migrants, both legal and illegal, who need accommodation. Often, this is despite there being no electricity, water, or sanitation services as the municipality discontinues these in abandoned buildings in an attempt to make them safer.

"There are dozens of shacks inside this building and there must be a few hundred people living in small shacks into which the five floors have been divided," said a resident from Tanzania, who lives next to the building and refused to be identified as he said he was still struggling to get refugee status.

He said most of the residents in several buildings in the area were illegal migrants from African states who came to the economic heart of South Africa in search of jobs, but most had to struggle to make ends meet as these were very scarce. He said there were also South Africans from rural areas who did that and who were also exploited by unscrupulous criminal syndicates who have hijacked the buildings.

"Most of us are force candles for light and cook on small paraffin stoves and some even use boulas (open fires made in old steel drums), which are very dangerous in closed buildings. I'm not sure how this fire started, but last night was cold and it could have been something like that," he said. He added that there were some families with small children living

in the building. "I don't see much hope for anyone else coming alive out of that building now. We just see firemen bringing out bodies one by one. It's very sad!", said another woman, who also lives in a shack nearby, again refusing to be identified.

Hundreds of economic migrants live in makeshift homes on empty land and even some streets or converted small sections of buildings in the suburbs surrounding the centre of Johannesburg. Those injured in the blaze were taken to hospital.

## Palestinian driver rams truck into pedestrians at West Bank checkpoint, wounding 3

TEL AVIV, Aug 31: A Palestinian driver slammed his truck into pedestrians at a busy checkpoint in the occupied West Bank on Thursday, wounding three people in the latest bloodshed in a relentless cycle of violence to roil the region.

The violence came a day after Israeli police shot and killed a 14year-old Palestinian boy who stabbed a man in a Jerusalem light-rail station and after Palestinian militants detonated a bomb near a convoy of Israeli troops escorting Jewish worshippers to a holy site in the West Bank, wounding four Israeli troops.

The unrest is part of more than a vearlong wave of violence that has surged to levels unseen in the West Bank in some two decades. Israeli paramedics said they were treating three people, one critically, in the aftermath of Thursday's attack.

According to Israel's Defense Ministry, the driver sped away and

was stopped by security guards at a separate checkpoint nearby. His condition was not immediately clear. Israeli PM orders ministries to get his OK before secret talks, as drama over Libya meeting persists

Video circulating on social media showed a white truck surrounded by security guards at the second checkpoint as gunshots rang out.

The checkpoint where the truck rammed the pedestrians occurred is on a major highway leading from central Israel through the West Bank and into Jerusalem and is next to the Israeli city of Modiin. The checkpoint is typically packed with commuters and security guards or soldiers.

Palestinian assaults against Israelis have spiked alongside Israel's intensification of arrest raids in the West Bank since the spring. Some 30 people have been killed in Palestinian attacks against Israelis since the start of 2023. (AP)

He said the status of Islam and Malay privileges are enshrined in the constitution and will not change. At the same time, he said his unity government will also defend the rights of all minorities and

## **Civil bodies in Manipur** should talk in one voice: **CM Biren Singh**



**IMPHAL**, Aug 31: Manipur chief minister N Biren Singh on Thursday lamented that there are too many civil society organisations in the state and they speak in different voices, making it difficult to find a solution to the ethnic problem rocking Manipur for nearly four months.

He urged those bodies to present a concrete proposal to solve the crisis in one voice, so it can be conveyed to the centre by the state government

"There are too many organisations. We are at a very crucial stage now. Both the central and the state governments are confused about whom to talk to. We will go with the public (opinion) and never work against the interests of the people," Singh said at a programme. A number of civil society organisations are communitybased. Meities and Kukis, the two warring communities, have their own such bodies.

Kukis are represented by organisations such as the Indigenous Tribal Leaders Forum (ITLF), Committee On Tribal Unity (COTU), Kuki Inpi and the Zomi Council. On the other hand, civil bodies like the Coordinating Committee on Manipur Integrity (CO-COMI), United Committee Manipur (UCM) and the All Manipur United Clubs Organisation (ÂMUCO) represent Meiteis.

"People and civil society organisations should come together and

## Polls in J-K can be held 'anytime from now', Centre tells SC but sets no time-frame for restoration of statehood

**NEW DELHI, Aug 31:** Elections in Jammu and Kashmir can be held "anytime from now" as the work on updation of voters list is almost over, the Centre told the Supreme Court on Thursday but remained non-committal about setting a time-frame for restoration of statehood to the union territory (UT).

Solicitor General Tushar Mehta, appearing for the Centre, told a five-judge constitution bench headed by Chief Justice DY Chandrachud that the UT status of Jammu and Kashmir is a "temporary thing" and it is for the Election Commission of India and the union territory's election commission to decide when the elections for panchayats, municipal bodies and the legislative assembly will be held.

'The central government is ready to hold elections anytime from now... It is for the Election Commission of India and the Election Commission of the UT to take the call on which election will take place first and how. The updating process of the voters' list is almost complete and will be over in a month," he told the bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant.

The solicitor general said as far as restoration of statehood to the union territory of J-K is concerned, union home minister Amit Shah has already made statements in Parliament that it will be done in due course

"The UT is a temporary thing in J-K. We are dealing with an extremely extraordinary situation. The exact time frame for restora-



tion of complete statehood in J-K cannot be given at the moment. It might take some time. Various steps are being taken to restore the status of the state in Jammu and

Kashmir," Mehta said at the outset. The central government made the submissions in response to the apex court's August 29 observations on restoration of electoral completed. democracy in Jammu and Kash-

Mehta, on the 13th day of hearing on a batch of petitions challenging the abrogation of Article 370 which accorded special status to the erstwhile state of Jammu and Kashmir, said, "Peace does not merely come by policing." He told the court about the vari-

'They are saying there were zero 'hartals'. Five thousand people were put under house arrest. How will there be any 'hartal', when you don't allow them to even go to hospital. The proceedings of this court are televised and these figures may aid in creating an opinion," he said.

The bench told Sibal what the solicitor general has said was pursuant to the court's query as to what steps were taken by the Union of India to restore electoral democracy. (PTI)

## Govt calls 'special session' of Parl between Sept 18-22, keeps agenda under wraps

NEW DELHI, Aug 31: The government on Thursday announced a "special session" of Parliament for five days between September 18 and 22 but kept the agenda for it under wraps, triggering speculation. "Special Session of Parliament (13th Session of 17th Lok Sabha and 261st Session of Rajya Sabha) is being called from 18th to 22nd September having five sittings. Amid Amrit Kaal, looking forward to having fruitful discussions and debate in Parliament," Parliamentary Affairs Minister

Pralhad Joshi said on X. It will be the first such special session under the nine years of the Prime Minister Narendra Modi-led government which had convened a special joint sitting of Lok Sabha and Rajya Sabha to mark the midnight GST roll-out on June 30, 2017. However, it will be a full-

fledged session of five days this time with both Houses meeting separately as they usually do during sessions. Generally, three parliamentary sessions are held in a year- Budget, Monsoon and Winter sessions. Sources said the "special session" could see parliamentary operations being shifted to the new Parliament building which was inaugurated by Prime Minister Narendra Modi on May 28.

With the government not spelling out its agenda, speculation swirled that the government may push some showpiece bills in the run-up to some key state assembly polls followed by the all-important ok Sabha election.

Sources, including in the ruling BJP, spoke of the possibility of bills on simultaneous general, state and local polls, something Modi has assiduously pushed, and reservation for women in directly elected legislatures like Lok Sabha and assemblies. Both are constitutional amendment bills and will require passage with the support of two-third members in both Houses.

The recent historic success of the Chandravaan-3 mission and India's goals for 'Amrit Kaal' may be part of the wider discussions during the special session, which will come a week after the G20 summit meeting scheduled for September 9-10. Congress leader Jairam Ramesh alleged that the announcement of the special session just three weeks after the end of the Monsoon session was aimed at managing "the news cycle" and countering the news about the ongoing meeting of INDIA parties in Mumbai and the latest revelations on Adani. ## Nuh violence: Cong MLA fails to appear before SIT

NUH (HAR), Aug 31: Congress MLA Mamman Khan on Thursday did not appear before the Haryana Police Special Investigation Team (SIT) probing the July 31 Nuh violence case, officials said.

A medical certificate was sent on Khan's behalf stating that he was suffering from viral fever, according to sources.

In a notice issued recently to Khan, the police had asked the Ferozepur Jhirka MLA to reach Nagina police station at 11 am on Thursday to join the investigation into the Nuh violence that had claimed six lives.

SIT head and Deputy Superintendent of Police, Ferozepur Jhirka, Satish Vats said Khan did not join the probe and also could not be contacted.

"We will serve him a notice again and call him to join the investigation," Vats said.

Sources said a medical certificate was sent on Khan's behalf stating that he was suffering from viral fever. Khan could not be reached for comment as his mobile phone was switched off. Communal clashes had erupted in Nuh and its adjoining areas after a Vishva Hindu Parishad (VHP) procession was attacked by a mob on July 31, killing six people, including two home guards and a cleric. Harvana Home Minister Anil Vij had said on Tuesday that before the July 31 incident, Khan was spotted "on July 28, 29 and 30" in areas where the violence took place. (PTI)

## Union fisheries minister outlines comprehensive plan to boost mariculture sector in India

THIRUVANANTHAPURAM, Aug 31: Union fisheries minister Parshottam Rupala on Thursday outlined a comprehensive plan, which includes expanding cage fish farming operations and scaling up pearl oyster production, to boost the mariculture sector of the country.


The union minister, who is visiting Kerala before beginning the 8th phase of the Sagar Parikrama Yatra from Kanyakumari, said that the immediate focus would be on expanding cage fish farming to offshore waters using bigger and better cages.

Rupala, who was accompanied by Minister of State for Fisheries, Animal Husbandry and Dairying Dr L Murugan and Minister of State for External Affairs V Muraleedharan, outlined his ministry's plans during his visit to the Vizhinjam Regional Centre of the ICAR-Central Marine Fisheries Research Institute (CMFRI). He said that bigger and better cages of 30 diameter or above would be used for offshore cage fish farming as they can accommodate lakhs of juvenile fish.

Currently, cage farming is undertaken in nearshore waters using the 6-diameter cages, he noted.

The minister further said that CMFRI should spearhead research and development efforts in creating these advanced cages.

'This is expected to significantly boost mariculture production in the country," the minister is quoted as having said according to a release issued by CMFRI. Mariculture is the cultivation, management, and harvesting of marine organisms in their natural environ-



The minister also urged the CMFRI to expand seed production novation in this area.

Delhi HC allows stem cell therapy for children suffering from autism

NEW DELHI, Aug 31: The Delhi High Court on Thursday allowed two children suffering from autism spectrum disorder (ASD) to undergo stem cell therapy for treatment of their condition.

The family members of the two children had approached the high court earlier this year with a petition after their treatment was stopped by their doctors on account of a recommendation by the Ethics and Medical Registration Board (EMRB) of National Medical Commission (NMC), which said the use of stem cell therapy shall amount to professional misconduct.

A bench headed by Chief Justice Satish Chandra Sharma said there was no law banning the use of stem cell therapy for ASD and even the NMC is yet to take a final decision on the recommendation.

"No fruitful purpose would be served by stopping the treatment that is going on at present and therefore the petitioners are permitted to continue the treatment," the bench, also comprising Justice Sanjeev Narula, said.

Listing the matter for further hearing on October 3, the court also asked the NMC to take a final decision on the recommendation.

"This is an interim order. We don't want treatment to stop right now," the court said. It, however, clarified the treatment shall be at the risk of the petitioners.

Two expert doctors from AIIMS, who were present during the proceedings to assist the court, told the bench that stem cell therapy is allowed as a mode of treatment only for blood cancer and its use for treating ASD was currently at an experimental stage. (PTI)







Institutional League tentatively fixed for January 2024 start, top two teams to get Federation Cup berth

NEW DELHI, Aug 31: The toptwo finishers in the proposed Institutional League, which is likely to start in January next year, will get direct entry in the domestic premier knock-out tournament, the Federation Cup in 2024, the All India Football Federation (AIFF) said on Thursday. The bid document (Request for Proposal) for the Institutional League, which has attracted interest from some of the country's most well-known institutional teams, is set to be released in early September, while the eligible sides are expected to be announced by mid-October.

After a pre-bid meeting with 25 Institutional League teams here on Thursday, the AIFF has set a base participation fee for the Institutional League at Rs 10 lakh annually. The applicants will qualify

The bids will be subject to a two-step evaluation process --Technical Evaluation (to assess the preparedness of the applicant to participate in the competition) and Legacy Evaluation (to determine historical contribution of the applicant to Indian football).

Technical credits will be used to determine the applicant's seeding for the competition, while Legacy credits will be used to determine the concession that will be awarded to the applicant on the base participation fee.

## 7-time French champion Lyon is in crisis amid a fight between owner Textor and former boss Aulas

LYON, Aug 31: There was a time when Lyon ruled French soccer. Back when the likes of Karim Benzema, Brazil midfielder Juninho and France winger Florent Malouda were helping the club win seven consecutive league titles at the start of the century.

Well, that was a long time ago. And, it doesn't look like such a dynasty can be revived soon, with the club now plunged in a sporting crisis amid a legal dispute between its current owner, American businessman John Textor, and his predecessor.

It was worth listening to Lyon midfielder Corentin Tolisso when he left the field last weekend after another worrying display from his team, a 0-0 draw at Nice that left Lyon second from last with only one point from three matches. "Today, we're the Olympique Lyonnais of 2023-We're not the 2024.

Olympique Lyonnais of 2002-2003," Tolisso summed up.

"We're not going to take ourselves for others. We're not like our predecessors ... And today, the Olympique Lyonnais of 2023-24 is happy to take a point at Nice."

Nobody will blame Tolisso, a product of the club's renowned academy who returned to Lyon last year to help it back to its glory days, for speaking the truth.

But, it's unlikely his words of wisdom will have pleased Textor, who proclaimed his ambition to target the dominance of Paris Saint-Germain when he became the club's main shareholder last year. Saying that things didn't work out as the new boss had hoped would be an understate-

ment. After finishing last season in seventh place and 23 points behind PSG, Lyon got off to its worst start to a season since

1966 with two consecutive market have been limited losses that included a 4-1 home defeat. Still winless, coach Laurent Blanc is now under pressure ahead of Sunday's game against PSG, and Textor has made clear he wants improvement.

But, Blanc has limited means to get things back on track, with several key players injured and only a few arrivals from the transfer window, including forwards Mama Balde and Ernest Nuamah, as well as former Arsenal midfielder Ainsley Maitland-Niles. Blanc has been complaining

about the frugal offseason purchases, but there is nothing much Textor could have been doing after a decision by French soccer's financial watchdog to monitor the club's transfer activities this season.

Because of the restrictions imposed by the DNCG, Lyon was allowed to bring in new players, but its moves in the under "a framework for wage costs and transfer indemnities' that hampered its recruiting.

The DNCG ruled that Lyon did not provide sufficient financial guarantees despite Textor's financial arguments.

"We lost an opportunity to be aggressive this summer, to go after targeted players that Lyon doesn't usually go after," Textor was quoted as saying in an interview with several media outlets.

"We weren't able to make that leap forward. It's a terrible feeling to be going into this mercato' with one hand tied behind our backs. We have the investment scale to position ourselves on players valued at 30 to 50 million euros, but we can't spend that money."

Textor, who also has stakes in Premier League team Crystal Palace, Belgian club RWD Molenbeek and Brazilian team Botafogo, was appointed chief

-

executive officer of OL Group in May with Lyon's iconic Jean-Michel Aulas stepping down as president.

The relationship between the pair has quickly deteriorated and reached its nadir this week when Lyon's commercial tribunal ordered to freeze 14.5 million euros (USD15.7 million) of the club's funds corresponding to part of the money owed to Aulas in relation to the purchase of his shares.

Lyon said in a statement it "deeply regrets that its former chairman, who is also a shareholder and director of the company, and as such fully aware of the extremely damaging nature of his actions, has initiated a violent and illegitimate attack on Olympique Lyonnais.

In that turbulent context, preparations for Sunday's big game against the new dominant force of French soccer are far from ideal. (AP)

PALLEKELE, Aug 31: Ishan Kishan is set to play the wicketkeeper-batter role in the absence of K L Rahul but question remains over the left-hander's batting slot going into the Asia Cup opener against Pakistan on September 2.

The temptation will be to hand Kishan the opening position with Rahul not available for the first two games of the continental event. He had opened the innings in India's last ODI series against the West Indies along with Shubman Gill, and made a good impression.

Kishan made 184 runs in that series from three matches, averaging 61.33 and his scores read - 52, 55 and 77.

But it was a rather straightforward move as Rohit Sharma was given a rest during the ODIs against the West Indies.

Now that Rohit has returned to the side and will occupy one opening slot, the Indian think-tank will have to put in a thought as to where to accommodate Kishan.

Opening is also Kishan's most successful slot in the batting order as he had made double hundred there against Bangladesh last year.

Former Indian coach Ravi Shastri too had favoured Kishan opening saying his uninhibited striking will give India an early upper hand over their opponents.



If he opens, then Gill will have to come down to No. 3 and Virat Kohli will have to take the No 4 slot. It also means that the re-

turning Shreyas Iyer will have to move down to No.5. If it happens that way then Hardik Pandya

will be coming in at No.6 and there will be no place for Suryakumar Yadav in the side. Despite his modest record, India were dabbling with the option of Suryakumar in the ODIs because of his prowess at the backend of the innings.

If India indeed want to accommodate Suryakumar in the 11 then they might just have to put a temporary hold on Shreyas' comeback.

The other option India can explore to give Kishan a place at No. 3 – Rohit and Gill as openers – with Kohli at No. 4 and Shreyas at No. 5.

The 25-year-old from Jharkhand can also be fitted in the middle-order as he has a reasonable record at No. 4, scoring two fifties in four innings.

They can mull the southpaw at number five too as it gives a certain stability at the top but the only peril is that Kishan has not batted in that position in his 17-match ODI career. Sanju Samson is here as the travel-ling reserve keeping in mind the injury of Rahul, and he is not a part of the 17-member India squad.

India will not be able to use his services as a wicketkeeper batsman because one of the players, Rahul in this case, has to be ruled out of the Asia Cup for Samson to come into the equation. (PTI)

Viacom 18 bags India's home series broadcast rights for nearly ₹ 6000 crore with 67.76 crore per match deal



NEW DELHI, Aug 31: Viacom 18 on Thursday created a near monopoly in Indian cricket broadcasting sphere by bagging both TV and digital rights of the national team's home series for the next five years with a cumulative bid of approximately ₹ 6000 crore, beating Star India and Sony in a three-way bat-

The BCCI had invited separate e-bids for both linear (TV) and digital for best price discovery.

"Viacom 18 paid ₹ 3101 crore (approximately) for digital and ₹ 2862 crore for linear (TV). As has been the trend, digital has fetched more

"With IPL digital rights being bought by Viacom for ₹ 26,000 crore plus, they now have almost all the high profile cricket properties save IPL linear (TV) and ICC events," a broadcasting industry source, tracking developments closely, told PTI on conditions of anonymity.

The rights will come into effect with India's three-match home series against Australia beginning September 22 and end on March 31. 2028.

"Congratulations @viacom18 for winning the @BCCI Media Rights for both linear and digital

for the next 5 years. India Cricket will continue to grow in both spaces as after @IPL and @wplt20, we extend the partnership @BCCI Media Rights as well," BCCI secretary Jay Shah said on 'X', formerly twitter.

India will be playing 88 international games across three formats including 25 Tests, 27 ODIs and 36 T20Is with per match value of the deal standing around ₹ 67.76 crore. This is nearly ₹ 7.76 crore more than last cycle's ₹ 60 crore per match value.

However BCCI is getting ₹ 175 crore less than ₹ 6138 crore it received during last cycle which had more games, specifically 102.

If one looks at the prevailing market sentiments, it is not a bad price to fetch as the per match valuation has increased. One needs to factor in that only marquee Test matches and series versus England and Australia will fetch a decent advertisement revenue. For matches against other nations, it is only the T20 which is the cash COW.

India will play Australia in 21 games and will be pitted against England in 18 matches across three formats during the next five years. (PTI)

His Malinga-like action has also earned Pathirana sobriquets like Podi (Little) Malinga in Sri Lanka and Baby Malinga among Chennai Super Kings (CSK) fans.

Pathirana had a breakout season for IPL champions CSK. He snared 19 wickets from 12 matches and was Mahendra Singh Dhoni's go-to bowler in crunch situations.

While Dhoni is grooming the 20-yearold as CSK's designated death overs specialist, the Sri Lankan cricket establishment should handle him with utmost care, feels Fassy.

"Seeing his action, a lot of people think that he has modelled it after seeing Malinga. Pathirana also trained under Malinga. But he came to me with this action from day one, and we just worked on it a bit, considering it can put a lot of stress on his young body," Fassy told PTI.

Despite a rising profile, Pathirana still seeks the guidance of Fassy, who runs a cricket training centre in the Trinity College here.

Fassy was impressed with Pathirana's genuine ability to generate pace when he first joined his camp five years back.

"He (Pathirana) was naturally quick. He did not have to put in a lot of effort to get pace unlike some other boys. On top of it,



he was very accurate too as you might have seen while he was bowling in the IPL. He has a fast and accurate yorker that can trouble even the best. His arm speed is just outstanding," he said.

Fassy cautioned against burdening the young man with expectations. "He has talent and he will go a long way

if supported properly. But he is just beginning, so don't compare him with legends like Malinga or (Chaminda) Vaas."

"Let him be his own and allow him to work on his skills and make a mark. He is important for Lanka as we have two World Cups in two years (50-over in 2023, T20 WC in 2024)," he noted.

Eric Simons, the former India bowling coach, who now works with CSK in a similar role, too was an impressed man.

"I have worked with Pathirana over two seasons (2022, 2023) in the IPL. He has shown tremendous improvement. He is a quick learner. Yes, at times he can be a bit erratic," the South African told PTI.

But what impressed him more is his temperament, considering that he is barely out of his teens.

"But for someone who has started top level cricket a couple of years back, he has shown a good temperament to handle a tough task like bowling at death in T20s. I feel he is going to be a big part of Sri Lanka and CSK for a long time," Simons said.

With the ODI World Cup approaching fast, Sri Lanka are racing against time to make their first-choice bowling unit battle ready, as three pacers are nursing injuries. Dushmantha Chameera, Lahiru Kumara

and Dilshan Madhushanka are out of the Asia Cup 2023, and the trio is battling to get in for the quadrennial big show.

Hence, Sri Lanka is hoping that a 20year-old prodigy will be ready for a bigger role sooner than later.

"His strength is his unorthodoxy. He has shown that in the IPL, and he has good pace as well. We can gradually hand him more responsibility, and he has a good attitude as well. We are looking at him as a long-term option, and hopefully, he can be someone like (Lasith) Malinga for us," said Sri Lankan captain Dasun Shanaka.

Former India skipper Dhoni had an advise for Sri Lanka cricket establishment during the 2023 IPL.

"I feel he should not play red-ball cricket, not even get close to it, he can play only ICC tournaments. He is young and he would be a great asset for Sri Lankan cricket," Dhoni had said. (PTI)

I don't have any ego, I can bowl with new ball

### or at death: Shami

PALLEKELE, Aug 31: Mohammed Shami won't mind if he is asked to bowl with a worn-out Kookaburra instead of a shiny white in the ODIs, saying he does not have an ego and would purely go by the team's requirements.

With Jasprit Bumrah back in the mix for the Asia Cup, it will be interesting to see who will be the Gujarat slinger's new ball partner in the match against Pakistan on Saturday

In Bumrah's absence, Shami and Mohammed Siraj shared the new ball in the ODI series against Australia in March this year.

"I don't have any hesitancy to bowl with the new ball or the old ball. I don't have an ego like that. All three of us (Bumrah, Shami & Siraj) are bowling very well, so it depends on the management on who will play," Shami told Star Sports ahead of Asia Cup.

"Depends on whether I have the new ball or whether the team requires me at any stage during the match, I'm always on," said India's best exponent of swing bowling in current times.

For someone, who has 162 wickets from 90 games with an economy rate of 5.60, Shami doesn't get too fussy about the format and colour of the ball. (PTI)
