#### Over 82,000 hectares of state's land encroached: Assam minister

**GUWAHATI**, **Sept 13:** More than 82,000 hectares of Assam territory has been encroached by four of its neighbouring states, state border protection and development minister, Atul Bora said in the Assembly on Wednesday.

He also said that the boundary disputes are being resolved through talks and legal measures with the neighbouring states. Replying to a question by Con-

gress MLA Kamalakhya Dey Purkayastha, Bora said 59,490.210 hectares of Assam land has been encroached by Nagaland. Arunachal Pradesh has en-

croached 16,144.00117 hectares Mizoram 3,441.8601 hectares and Nagaland 3,675.7800 hectares.

Regarding the resolution of disputes, Bora said talks are going on with Mizoram at different levels, while the matter relating to Nagaland is before the Supreme Court. In another reply to Congress' De-

## C-295 aircraft to replace ageing Avro--748 fleet

## IAF Chief receives first C-295 aircraft at Seville

SEVILLE (SPAIN), Sept 13: Chief of Air Staff, Air Chief Marshal VR Chaudhari on Wednesday received the first of the 56 C295 transport aircraft two years after India sealed a deal of ₹21,935-crore with Airbus Defence and Space to procure the jets to replace its ageing Avro--748 fleet

Air Chief Marshal Chaudhari, receiving the aircraft at the aerospace major's production facility in the southern Spanish city of Seville, described it as a "momentous day" for the Indian Air Force (IAF) and India as 40 C-295 out of the total fleet will be manufactured in Vadodara.

"It is a momentous day for us, for the Indian Air Force in particular, and a nation as a whole to receive the first aircraft which marks the beginning of a new era, wherein we



will be manufacturing 40 of these aircraft in India," he said.

Under the deal, Airbus will deliver the first 16 aircraft in 'flyaway' condition from its final assembly line in Seville by 2025

and the subsequent 40 aircraft will be manufactured and assembled by Tata Advanced Systems (TASL) in ship between the two companies.

India as part of an industrial partner-"It gives a tremendous boost to

the capability of moving our forces to the frontline when required," Air Chief Marshal Chaudhari said.

The Chief of Air Staff also took a sortie on the new aircraft. The C295, in transport configura-

tion and with an indigenous electronic warfare suite, will leave Airbus' production site in Seville for Delhi on September 15. It will be piloted by a joint IAF-Airbus crew. "While the first aircraft was

rolled out from Spain, the 17th aircraft will be assembled at the final assembly line in Baroda in 2026. It will mark a historic moment as the first time a military transport aircraft will be fully manufactured in India," Air Chief Marshal Chaudhari told PTI. NEW DELHI, Sept 13: In a strongly-worded message, Commerce and Industry Minister Piyush Goyal on Tuesday suggested the auto industry not to import components unnecessarily if the exporting country is not giving equal access to Indian players.

He however said that companies can import quality products if those are not available or manufactured domestically.

"Where things are being unnecessarily imported without India getting an equal opportunity in those countries I would be tempted....," he said here at the annual convention of the Society of Indian Automobile Manufacturers. He did not elaborate on these re-

Goyal also said that the government may have to look at the practices of some of the players in the sector who get dictated by their parent companies on sourcing and pricing of imports of components.

He added that there are certain companies who by choice prefer to import and there are certain firms who may not by themselves be importing and on record showing a greater degree of indigenisation.

"But the moment, we go down one or two levels into their supply chain, we find them still dependent on imports. Often being dictated by their parent company from to send the metal to India. where these component suppliers Goyal was referring to some would source, the pricing at which companies importing automotive

it will be sourced. "I do not know how legal that is. But I personally think there is a question mark on transfer pricing in that, there is a question mark on fairplay... ## Sensex rises for 9<sup>th</sup> straight session, Nifty closes at record high as banking, metal shares gain

MUMBAI, Sept 13: Benchmark Sensex rose for a ninth straight session while Nifty closed above the record 20,000 mark for the first time on Wednesday as positive macroeconomic data triggered buying in banking, energy and telecom shares.

The 30-share BSE Sensex bounced back from early lows to trade near its all-time high levels at 67,565.41 in day trading. The barometer settled at 67,466.99, up 245.86 points or 0.37 per cent. As many as 20 Sensex shares closed in the green while 10 declined.

The broader Nifty closed above the 20,000 mark for the first time, rallying 76.80 points or 0.38 per cent to 20,070, its all-time closing high. Of 50 Nifty shares, 31 closed higher and 19 declined. Among the Sensex firms, Bharti Airtel rose the most by 2.72 per cent. Titan, IndusInd Bank, Axis Bank, State Bank of India, Power Grid, NTPC and Tata Motors were among the among the major gainers.

Mahindra & Mahindra, Larsen & Toubro, Nestle, JSW Steel, Infosys and Tata Consultancy Services, Tech Mahindra and Maruti were the major laggards.

"The domestic indices resumed an upward trajectory despite weak global cues. The cooling of domestic CPI inflation to 6.83% in Au-



bustness of the Indian economy, said Vinod Nair, Head of Research at Geojit Financial Services.

#### Federal Bank to open 100 branches this fiscal



MUMBAI, Sept 13: Federal Bank, the largest private sector lender in Kerala, on Tuesday said it will open 100 more branches this fiscal as part of its increasing focus on lending to small businesses.

The Kochi-based lender had opened 75 branches last fiscal, its executive director Malini Warrier told reporters here on the sidelines of the three-day global SME financing summit organised by the developmental lender Sidbi.

She said one-third of its total loan book of ₹ 1,86,593 crore as of June 2023, which rose close to 21 per cent on-year, was SME loans, and so are the retail and wholesale

"The idea of focusing on SMEs is that we should be growing in sectors of the economy which is growing faster or which has more credit needs. And the fast growing industry segment in terms of credit is SMEs.

"Therefore our decision to open more SME-focused branches this fiscal as well," Warrier said.

According to her, most of these branches will come up in Tamil Nadu where it already has 200 branches besides Karnataka, Andhra Pradesh and Telangana, the states which have the largest concentration of small businesses.

During the past five years, the bank has almost doubled its branch presence to 1,100 from 600, she

MUMBAI, Sept 13: The Reserve Bank on Wednesday directed banks and financial institutions to release all original movable or immovable property documents and remove charges registered with any registry within 30 days after full repayment of a loan

Failing to comply with the direction, Regulated Entities (REs) would compensate the borrower at the rate of ₹ 5,000 for each day of delay, RBI said in a notification.

RBI noted that REs follow divergent practices in release of such movable or immovable property documents leading to customer grievances and disputes.

As part of Fair Practices Code and to make things uniform, RBI asked "REs to release all the original movable/immovable property documents and remove charges registered with any registry within a period of 30 days after full repayment/settlement of the loan

In case of delay in doing so, it said, the RE would communicate to the borrower reasons for such delay.

The borrower shall be given the option of collecting the original movable/immovable property documents either from the banking outlet/branch where



the loan account was serviced or any other office of the RE where the documents are available, as per her/his preference, it said.

The timeline and place of return of original movable/immovable property documents will be mentioned in the loan sanction letters issued on or after the effective date, it said.

In order to address the contingent event of demise

REs shall have a well laid out procedure for return of original movable/immovable property documents to

Such procedure would be displayed on the website of REs along with other similar policies and procedures for customer information, it said.

With regard to loss/damage to original movable/immovable property documents, the notification said, REs would assist the borrower in obtaining duplicate/certified copies of such documents and would bear the associated costs, in addition to paying

"However, in such cases, an additional time of 30 days will be available to REs to complete this procedure and the delayed period penalty will be calculated thereafter (i.e., after a total period of 60 days)," it said. The compensation provided under these directions would be without prejudice to the rights of a borrower to get any other compensation as per any applicable law, it said.

These directions would be applicable to all cases where release of original movable/immovable property documents falls due on or after December 1,

Rupee falls 2 paise to close



**NEW DELHI, Sept 13:** The rupee depreciated by 2 paise to close at 82.97 (provisional) against the US dollar on Wednesday, weighed down by a surge in crude oil prices and strong American currency overseas.

However, a positive trend in domestic markets and upbeat macroeconomic data from India cushioned the downside for the local unit, forex traders said.

At the interbank foreign exchange market, the local unit opened at 82.92 against the US dollar and moved in a range of 82.89 and 82.99.

The rupee finally settled at 82.97 (provisional) against the US dollar, down 2 paise from its previous close. On Tuesday, the rupee closed at 82.95 against the US

"The Indian rupee depreciated on Wednesday on strong Dollar and surge in global crude oil prices. However, positive domestic markets and upbeat macroeconomic data from India cushioned the downside," said Anuj Choudhary - Research Analyst at Sharekhan by

The dollar gained on expectations that the US Fed may hike interest rates one more time this year.

NEW DELHI, Sept 13: The government will not make six airbags mandatory for cars, Union Road Transport and Highways Minister Nitin Gadkari said on Wednesday. "We don't want to make six airbags rule for cars mandatory," Gadkari said at the ACMA annual session here. Last year on September 29, the government deferred the implementation of the proposal to make six airbags mandatory in passenger cars by one year to October 1, 2023.

The government had earlier planned to make six airbags mandatory in eight-seater vehicles for enhanced safety of occupants

from October 1, 2022. "Considering the global supply chain constraints being faced by the auto industry and its impact on the macroeconomic scenario, it has been decided to implement the proposal mandating a minimum of



6 Airbags in Passenger Cars (M-1 Category) w.e.f 01st October 2023," Gadkari had said in a tweet.

The minister had further asserted that the safety of all passengers travelling in motor vehicles irrespective of their cost and variants is the foremost priority. An airbag is a vehicle occupant-restraint system which interferes between the occupant and the vehicle's body during a collision, thereby preventing serious injuries. (PTI)

**NEW DELHI, Sept 13:** The government is exploring legal options against electric two-wheeler companies for not complying with the FAME II scheme norms, according to a senior government official. The Centre has sought ₹ 469 crore from seven electric two-wheeler makers for claiming incentives while not complying with the Faster Adoption and Manufacturing of Electric Vehicles (FAME II) scheme norms.

The government is seeking a refund of incentives from Hero Electric, Okinawa Autotech, Ampere EV, Revolt Motors, Benling India, Amo Mobility, and Lohia Auto. As per the official, notices have

been sent to the companies, and so far, only Revolt Motors has offered to refund the amount. "We have sent them notices. So far, only Revolt has offered to pay...others have not responded," the official said. He noted that the deadline is al-

most over, and next week, the government will be making some decisions. "We are examining legal options," he said when asked about action being considered by the government.

An investigation by the heavy industries ministry has revealed that these companies have availed fiscal incentives under the scheme by violating the norms.

As per the rules of the scheme, incentives were allowed to produce electric vehicles by using made-in-India components, but in the investigation, it was found that these seven firms allegedly used imported components.

The ministry conducted the investigation after receiving anonymous emails alleging that several



EV makers were claiming subsidies without complying with the Phased Manufacturing Plan (PMP) rules to boost domestic manufacturing of these electric vehicles.

the distribution of subsidies last financial year. The seven electric two-wheeler

makers have urged the government to look at the possibility of asking After that, the ministry delayed customers to pay back excess re-

bates availed by them on the purchase of the vehicles.

The companies have suffered a cumulative loss of over ₹ 9,000 crore on account of unpaid dues and loss of market after their subsidies were stopped last year, the Society of Manufacturers of Electric Vehicles (SMEV) has stated.

To promote electric and hybrid vehicles, a ₹ 10,000 crore-programme under the FAME-II scheme was announced in 2019.

It is the expanded version of the FAME scheme, launched on April 1, 2015, with a total outlay of ₹ 895 crore.

In three-wheeler and fourwheeler segments, incentives are applicable mainly to vehicles used for public transport or registered commercial purposes. In the twowheeler segment, the focus is on private vehicles. (PTI)

#### Sedition laws need relook

or far too many years, Section 124A, commonly known as the Sedition law, has loomed over the Indian legal landscape, casting a shadow on freedom of expression. The recent push to challenge its constitutional validity has ignited a glimmer of hope, but it's a contentious journey, one where the government and the Supreme Court find themselves at odds. It's a familiar script - when in opposition, all political parties unite in demanding the complete repeal of Section 124A. However, the narrative drastically shifts when they assume power. The Modi government is no exception. Yet, this time around, the Supreme Court appears steadfast in its commitment to addressing this contentious issue. The apex court's stance is crystal clear: the constitutional validity of Section 124A will be deliberated upon, and there's no room for compromise. A Constitution bench, comprising five justices, will lead this critical examination.

For those unacquainted, Section 124A of the Indian Penal Code (IPC) criminalizes sedition, a provision that has sparked numerous debates on freedom of speech. The government's argument that there's no need for such a hearing, as the IPC is being replaced by the Bharatiya Nyaya Sanhita Bill which is currently under parliamentary review, has fallen on deaf ears in the Supreme Court. The court maintains that as long as Section 124A remains in the statute books, challenges must be addressed accordingly. The proposed new law will apply prospectively and not retrospectively, as clarified by Chief Justice DY Chandrachud. This means that existing cases under Section 124A will remain unaffected. The Constitution bench will also revisit the 1962 judgment, which upheld the validity of Section 124A but did not scrutinize it against Article 14 (equality before law). Today, the popular sentiment leans towards scrapping Section 124A entirely. Warnings abound that prosecutions will continue even with the new law in place. Section 124A's ambiguity in distinguishing between "state" and "government" only adds to its contentious nature. This colonial-era relic should have been discarded with the end of British rule, but it has endured, employed indiscriminately by successive Indian governments to stifle dissent. Section 124A is a weapon that turns any government authoritarian when wielded. Regrettably, every Indian government post-independence has succumbed to this temptation, including the current Modi administration. The law has silenced government critics across the board - journalists, students, academics, and political rivals. The maximum sentence for sedition is 'life,' but the real punishment lies in the protracted legal process itself.

Each new parliamentary session sees calls to abolish the sedition law, yet it lingers on. In 2022, the Supreme Court temporarily restrained its use, hinting that if Parliament failed to act, the court might address its constitutionality. Beyond domestic concerns, international human rights standards require India to reconsider Section 124A's existence. The time for change is long overdue. The Supreme Court must stand firm, resolute in its pursuit of justice. Only a decisive ruling will put an end to this perpetual uncertainty. The British repealed their own sedition law in 2009. India should not wait for a crisis to act. During Modi's tenure, sedition cases have surged by 30 percent, an alarming statistic that raises concerns over the suppression of free speech. It's a bitter irony that even making jokes about the Prime Minister can attract the heavy hand of Section 124A. The situation is both ludicrous and concerning it's time for India to take a decisive step towards upholding the principles of free expression.

## G-20 Summit's success has catapulted India as a reliable leader of Global South

i Jinping's absence from the recent Group of 20 summit may have been a deliberate move to prevent India from taking the spotlight. However, Prime Minister Narendra Modi, along with the United States and Europe, managed to find more effective ways to challenge China's influence on the global stage as the G-20 Summit concluded on September 10 in New Delhi

Other G-20 nations praised India's achievement in reaching a consensus on a joint communique, which was uncertain until a few days before the major annual diplomatic event convened by world leaders. In addition to resolving the challenging matter of Russia's conflict in Ukraine, they also granted full G-20 membership to the African Union and addressed crucial issues such as climate change and debt sustainability, which are of significant concern to emerging markets.

Ukraine expressed dissatisfaction with the ultimate result, as they perceived the compromise on language regarding the war as less robust than what leaders had achieved in Bali, Indonesia, just ten months prior. However, for the United States and its allies, facing criticism for a communique that, in substance, resembled the one from Bali and had limited real-world impact was a minor trade-off. They viewed it as a worthwhile concession to Prime Minister Modi, strengthening India's standing as an ascending power capable of countering China's global influence.

President Joe Biden took the lead, seeing in India his administration's best hope of isolating China and Russia while reinforcing the United States-led world order. This outcome underscores that Washington is progressively becoming more attuned to the concerns of the so-called Global South, with India serving as its primary guide. Milan Vaishnav, who heads the South Asia Program at the Carnegie Endowment for International Peace, mentioned that some analysts see the softened stance on Russia-Ukraine as a Western concession. However, there's an alternate perspective: Western nations were also determined to ensure

an agreement would have been a significant letdown for India, especially Prime Minister Narendra Modi who staked everything on the success of this summit before the 2024 Lok Sabha elections.

If we had to pick a moment that truly showcased the dynamics of the summit, it would be Biden's meeting on Saturday, where he discussed the White House-led initiatives aimed at providing additional funding to developing countries.

In a photo op, President Biden, alongside World Bank President Ajay Banga (the first Indian American in this role), was seen

with Prime Minister Modi, Brazil's Luiz Inacio Lula da Silva, and South

Africa's Cyril Ramaphosa. These leaders are vital members of the BRICS group, excluding China and Russia. This bloc recently expanded, presenting a challenge to the advanced economies of the Group of Seven (G7). Earlier in the day, US Deputy National Security Advisor Jon Finer indirectly criticized China by describing these countries as "the three democratic members of the BRICS." He emphasized that these nations, along with the US, were dedicated to the success of the G-20. Finer added that if China didn't share this commitment, it would be regrettable for all parties involved, but even more so for China.

The United States didn't stop at that point. They also revealed a separate agreement with India, the European Union, Saudi Arabia, Israel, and additional Middle Eastern nations to establish an extensive rail and maritime network in the region. President Biden praised this as a "transformative regional investment" and sealed the deal with a three-way handshake involving Modi and Crown Prince Mohammed bin Salman, whom the US president had previously portrayed as an outcast before the last election.

Such a declaration is undoubtedly more appealing to Middle East stakeholders compared to pressing concerns about human rights, even though the project's specifics, such as the timeline and funding, remain uncertain. While the US denied any inten-

tion to counter China's increasing influence in the Gulf, a French official admitted that it was crafted to offer an alternative to Xi's Belt and Road Initiative, a development they saw as a positive competition.

Xi's decision to skip the G-20 summit, which was the first time since he assumed the presidency in 2013, marked a noticeable change in his behaviour. Last November, he portrayed himself as a statesman striving for good relations with other countries. China's negotiators also risked coming across as overly critical by trying to hinder India's progress, even

raising minor issues like Modi's use of a Sanskrit phrase and the

US's bid to host the G-20 gathering in 2026. The Global Times, a newspaper affiliated with the Communist Party, labelled the US as a mere imitator for its Middle East infrastructure plan.Before the summit began, British Prime Minister Rishi Sunak accused China of obstructing the advancement of a joint statement. During private discussions, Beijing introduced the topic of semiconductor access in the context of climate action, according to sources familiar with the talks. This led National Security Advisor Jake Sullivan, a proponent of US export controls on semiconductor-related technology to China, to criticize the notion of using climate-related matters as leverage for unrelated issues. Premier Li Qiang, acting on behalf of China while Xi was absent, conveyed to leaders that the G-20 should prioritize unity over division and cooperation over confrontation, as reported by the official Xinhua News Agency. This statement came after a commentary from a Chinese think tank associated with the nation's top intelligence agency, which had criticized India for disrupting the cooperative atmosphere at the G-20 by pursuing its own agenda.

However, China eventually gave in on its resistance to the communique, and India received commendation from various quarters for facilitating a compromise. Sources familiar with the discussions revealed that the

breakthrough happened when India, along with Indonesia, Brazil, and South Africa, collectively presented a proposal for the wording concerning the war.

"The fact that this consensus was reached highlights India's established position as a reliable mediator in a world marked by deep divisions over geopolitical matters such as the Ukraine conflict," remarked Swasti Rao to a media, who is an associate fellow at the Europe and Eurasia Center at the Manohar Parrikar Institute for Defense Studies and Analyses. "It's clear that middleranking powers aim to maintain a multipolar global economic order rather than getting caught up in China's efforts to dominate

Although the ultimate wording on Ukraine may have made some US allies uneasy, endorsing the compromise represented a significant chance to strengthen alignment with major democracies in the Global South. These democracies play a crucial role as pivotal nations when it comes to addressing Russia's conflict and other global concerns. G-7 leaders openly commended the result, with Sunak emphasizing that the adopted language was "highly robust" and that "Russia finds itself entirely isolated." For the United States, any ac-

tion that strengthens India and empowers other democracies in the Global South serves as a means to counter the influence of China and Russia, especially concerning the G-20's goal of achieving a "comprehensive, equitable, and enduring peace" in Ukraine. Going back to May during the G-7 summit in Japan, the US and its allies faced challenges in persuading leaders like Modi, Lula, and Indonesia's Joko Widodo to align with their stance on Ukraine, even with President Volodymyr Zelensky making an unexpected appearance. It's worth noting that Zelensky was not invited to address India's G-

A high-ranking European Union representative stated that this agreement essentially rescued the G-20, as it remains the primary global platform for uniting major world powers. Furthermore, the official pointed out that it played a crucial role in narrow-

ing the divide between the G-7 and emerging markets. This means that emerging markets are now partners in holding Russia accountable if it fails to uphold the pursuit of an equitable peace in line with UN principles.

According to other prominent European officials, China made a strategic mistake by abstaining from the summit. This decision ultimately enabled India to solidify its leadership role within the Global South and created a clear opportunity for the United States and Europe to enhance their relationships with emerging markets.

Even Russia, with Foreign Minister Sergei Lavrov attending in place of Vladimir Putin, regarded the agreement as a victory. Moscow expressed satisfaction with the role of BRICS democracies as intermediaries with the G-7, as reported by someone familiar with the situation. This emphasized China's position as an external observer rather than an active participant.

The United States, of course, still faces the possibility of encountering challenges in its efforts to strengthen its appeal to the Global South. Before the G-20 summit, President Biden did not attend a summit hosted by the Association of Southeast Asian Nations (ASEAN) in Indonesia, which seemed like a snub to President Widodo. However, President Biden attempted to mitigate any negative impact during his visit to Delhi, where he briefly met with the Indonesian leader and committed to a future meeting at the White House in November, coinciding with the APEC summit when world leaders gather in the United States.

More importantly, India seized the opportunity to assert its global leadership position. Prime Minister Modi stated that a historic moment had been achieved, and his chief negotiator, Amitabh Kant, referred to India as the representative of the entire Global South

Above all, the summit's outcome has amplified the influence of the Global South," Kant remarked. "It has also showcased India's substantial capability to unite the world and take a leadership role in both developmental and geopolitical matters." (IPA Service)

# International Labour Organisation welcomes G20 support for just transition measures

International Labour Organisation Director-General, Gilbert F. Houngbo, has welcomed the G20 Leaders' support for the UN Global Accelerator on Jobs and Social Protection for Just Transitions.

In their final Declaration the G20 leaders pledged to, "support progress on the implementation" of the UN Global Accelerator, a UN initiative led by the ILO that aims to bring together UN Member States and a wide range of public and private sector partners to help create 400 million decent jobs and extend social protection coverage to the four billion people currently excluded.

The Leaders agreed to create a new Working Group on the Empowerment of Women. They reaffirmed the importance of gender equality and the promotion of, "full, equal, effective and meaningful participation of women in the economy as decision-makers", adding that that such investment "has a multiplier effect in implementing the 2030 Agenda".

2030 Agenda".

"I heartily welcome the G20's endorsement of the Global Accelerator and its potential to deliver change and better working lives for hundreds of millions of people. The creation of the working group on women's empowerment is also an historic step forward," Houngbo said. "The G20 leadership has made progress on some of the most crucial future of work issues facing us if we are to build a sustainable and equitable future. We must build on this momentum, particularly at the UN SDG Summit later this month."

Following two days of discussions the leaders committed themselves to promote sustainable, quality, healthy, safe and gainful employment, address skill gaps, and ensure inclusive, adequate and sustainably financed social protection policies. They endorsed a set of policy priorities for "adequate and sustainable social protection and decent work for gig and platform workers".

The Declaration also included pledges to promote well-managed migration, increase efforts to eliminate child labour and forced labour in global value chains, support youth employment and encourage skills for sustainable and inclusive economic development – including extending

coverage of the ILO/OECD Skills for Jobs Databases to G20 countries.

Speaking at the Summit, Houngho stressed that effective policy responses to climate change needed to deliver on both climate targets and decent employment creation. "If we don't recognize these issues a social backlash could make the transition even harder. It is essential we achieve a just transition.... that greens the economy in ways that are fair, inclusive and leaves no one behind" he said, adding that this would require three things: effective and inclusive social dialogue, new financing strategies for social protection, and the creation of decent employment. "Here, the Global Accelerator on Jobs and Social Protection for Just Transitions... can play a major role," he said.

The G20 Leaders' Summit was held in New Delhi, India on 9-10 September. under the theme "One earth, one family, one future". In 2024 the rotating Presidency of the G20 will pass to Brazil, which will also host the first meeting of the Working Group on the Empowerment of Women. The summit decisions, if implemented, will be of big help to the global south in the area of new employment generation. The developing and the poor countries are suffering from the problem of acute joblessness and that is hampering their economic growth. The G 20 declaration of New Delhi gives some hope that the developed countries will take special measures to ensure larger job generation in the developing and the poor countries.

As regards India which was the host country of the recently concluded G-20 summit, the employment crisis has accentuated due to the large increase in the youth work force. According to the UN report on World Population 2022, in India, in the age group of 9-22 years, the population will rise from 102 million in 202 to 130 million in 2025 and 191 million in 2030. For people between 23 and 40 years, the population will grow from 409 million in 202 to 522 million in 2025 and to 767 million

in 2030.

Presently, the unemployment rate in India is over 8 per cent and the new entrants, especially the youth are having a tough time in getting jobs. Studies show that 599 million people will be in job market in 2030 which is a humungous task. (IPA Service)

## The fast, furious, and brutally short life of an African male lion

The death of a lion in Kenya's picturesque savannas rarely tugs at people's hearts, even in a country where wildlife tourism is a key pillar of the nation's economy. But when one of the most tracked male lions in Kenya's famous Masaai Mara was killed on July 24, 2023 the world took notice. Known as Jesse, he was killed during a fight with a coalition of three male lions from a rival pride, drawing attention to the brutally risky and dangerous lives of male lions.

Lions are organised in family groups known as a pride. Each pride is comprised of several related lionesses. One or more adult male lions will also be present. In the public imagination, male lions are better known by their popularised image as kings of the jungle. Their bravery, strength, and size (only tigers are larger) fits this profile.

But in reality, male lions live a life far more vulnerable. One in two male lions die in the first year of life. From the moment a male lion is born it faces a gauntlet of challenges - from snakebite and hungry hyenas to infanticide at the hands of other male lions.

If a male lion makes it out of their first year of life, and then to independence at around 3, they leave their pride for a period of nomadism. Nomads lead a dangerous existence, skirting the

tions. Out there on their own, few will make it to the age of 10.

At no time, it seems, is the male lion safe. We know from the evidence collected by the Kenya Wildlife Trust, resident guides, and tourists that Jesse administered and received many beatings from other male lions. We also know that Jesse, who lived to the ripe old age of 12, was eventually killed by three younger, stronger lions. Life comes full circle: killers frequently become victims themselves, of younger, brasher lions, or those in larger and thus more powerful coalitions.

We are three researchers with over 50 years of combined experience in big cat ecology, conservation, and the complexities of people and wildlife living

We base our commentary on the extensive information gathered by conservation organisations, independent scientists and tourism guides working in the Maasai Mara. Information on Jesse has been collected mainly through sightings data compiled by these entities over time.

Often the survival of male lions will be dictated by the size and strength of their coalitions, and the make up of the lion landscape at large. This sometimes has bearing for conservation especially when lions stray out of national parks or when male lions are hunted after leaving the safety of a protected area. The trials of a young lion

aren't their father or uncle. A host of studies from the Serengeti in Tanzania to Zimbabwe show that the most sig-

nificant single cause of lion mortality

in the first year of a lion's life is attrib-

uted to other male lions that kill them

during infanticide. This involves incoming males seeking out and killing the cubs of other males or driving young males away, and attempting to take over prides. Killing cubs accelerates the onset of oestrus in pride females and so is likely to increase the reproductive success of incoming males.

Most lions that get pushed out of their pride when very young don't sur-

Cubs that survive to independence – A young male lion's biggest threat is his exposure to other male lions that around 3 years of age — must leave their pride for a period of nomadism.

During this time, they join up with cousins, brothers, and sometimes unrelated males of similar age to form what biologists term 'coalitions'. The power of coalitions increases dramatically with the size of the group. This power can be defined by the number of different prides these coalitions are likely to rule, the number of offspring they will sire, and the number of times they will successfully be able to defend their prides from violent incursions from neighbouring male lions and their

The tradeoff of larger coalitions is a watering down of a male lion's reproductive opportunities.

coalitions

Examples of such powerful coalitions include the six-strong Mapogo, and five-strong Majingilane from South Africa. There is also the Lake

Ouintet coalition from Ngorongoro Crater in Tanzania

Contrastingly, Jesse had only one coalition mate, a lion known as Frank. The two were strong enough to kick out the duo of Dere and Barrikoi from the Offbeat pride in May 2014. After his coalition mate Frank disappeared, Jesse left the Offbeat Pride and led a largely nomadic lifestyle except when he unsuccessfully tried to take over the Rakero pride and even fought with his

own son Jesse 2. Three laws of the wild

Mate, protect, fight. These are the three tenets most male animals live and die by in the animal kingdom and this could not be truer for male lions. When male lions are in the prime of their lives somewhere between 5 and 9 years of age they will attempt to have as many cubs as they can. And they will do their best to protect and guard over as many prides as possible.

But there is a fine line between holding tenure over many different prides, and successfully being able to defend them and their young. When fights do breakout between male lions they are usually over territorial and breeding

At times they are mere squabbles between coalition mates. At other times, the battles are big enough to cause rifts and splits within coalitions. But in most cases fights are between rival coalitions. During these fights lions engage in a suite of bodily and olfactory enand growling, swatting, and biting, and even urination and territorial demarca-

For conservation: look to the lionesses

When it comes to the conservation of the lion species it is important to look to the lionesses. They are the sentinels of a populations health, specifically the number of animals in a group, and more importantly the ratio of lionesses to lions. Healthy populations can expect ratios of roughly 2 females for every male, but when under pressure due to poaching, killings by cattle farmers and a loss of prey these ratios invert towards males

The story of Jesse highlights how, in spite of their status as king of the beasts, lions are vulnerable. While in this instance, the cause of death was another lion, much more commonly, lions die at the hands of humans. This can be through being shot or poisoned to protect livestock, being poached for their body parts or being caught as bycatch in traps and snares set for other animals by bushmeat poachers.

On the plus side, the fascinating pride dynamics and trials and tribulations of individual lions can help capture the public's imagination and foster a love for the species and other wildlife. Although human pressures are high, Kenya retains a large lion population and a suite of iconic wildlife areas. These assets are a great source of pride for many Kenyans, and rightly

## COP28 should shine a spotlight on corporate environmental responsibility

The 28th Conference of Parties (COP28) to the United Nations Framework Convention on Climate Change (UN-FCCC) is all set to feature a "global stocktake", where participating countries will report on their progress in meeting their voluntary emissions reduction commitments and discuss strategies for closing the gaps. The summit also gives an opportunity to focus on corporate environmental responsibility (CER) to help protect our planet.

India's stance at COP28 centres around the importance of adaptation and equity in addressing climate change. Along with other developing countries, it is pushing for a new global climate finance target, acknowledging the growing costs of addressing and adapting to climate change. The Government of India has launched several domestic actions to improve understanding of climate change. It also put forward its long-term low-carbon development strategy to the UNFCCC in November 2022 after analysing the climate impact in India due to the global rise in tem-

However, as most studies so far have relied on mathematical modelling of climate change impacts, these are not empirically verified. Hence, India needs more accuracy about the attribution of climate change directly causing untimely rains, severe droughts and flash floods. As the central government complements the efforts of the state government through technical and financial aid, 34 states and Union territories have prepared State Action Plans on Climate Change (SAPCCs) consistent with the objectives of the National Action Plan on Climate Change (NAPCC).

However, this area is consistently developing and massive trends will continue to develop, but we as a nation need to keep up with the evolving innovations and put in continuous efforts. While the national-level policy frameworks and ambitious targets look and sound phenomenal, what are we doing to achieve the set goals? There have been progressive initiatives by the Centre, but how has the implementation been going?

Companies try to portray themselves as persuasive towards sustainability practices, but we need to look at the actual impact of their initiatives. The social sector is intellectually aloud about all sorts of jargon related to the environment and climate change; however, what is really happening at the grassroot level?We must question how public, private and social sectors can collaborate to foster a conducive environment for sustainability-led solutions and innovative environmental, social and governance practices. Among a broad range of potential solutions to curb the emerging challenges, CER needs to take root in the country because businesses often desist from giving back to the environment after sourcing natural resources.

CER suggests that it is the responsibility of the companies operating within society to contribute towards economic, social and environmental development that creates a positive impact on society at large. It is an important concept and businesses must take into consideration to ensure the sustainability of our planet. Companies have a responsibility to reduce their environmental impact and promote sustainable practices. This includes reducing emissions, conserving resources and minimising waste.

It also involves educating employees about the importance of environmental responsibility and encouraging them to adopt ecofriendly habits. They can help protect our planet for future generations if they start implementing a company-wide recycling programme to reduce waste and promote sustainable practices. The companies should invest in renewable energy sources such as solar or wind power to reduce their reliance on fossil fuels. They need to be innovative and develop a carbon offset programme to balance out their carbon emissions and shouldn't be reluctant to use environmentally friendly materials and products in manufacturing and packaging. Furthermore, companies should encourage their employees to use public transportation, carpool, or bike to work. Companies can also partner with local

environmental organisations to support conservation efforts and volunteer opportunities. There is a need to conduct regular environmental audits to assess a company's impact on the environment. If companies start offering incentives for customers to recycle or return products for reuse, it might lead to positive outcomes in the long run.

While companies are incorporating ecofriendly practices into their supply chain management, they should not be reluctant to support the research and development of new environmentally sustainable technologies.

Humans are the most selfish of the species and the last two centuries since the onset of the Industrial Revolution in the 19th century have taken a massive toll on the environment. We need societies that are liveable, workable and sustainable and we need to find an equilibrium between ecological concerns and developmental needs. The public, private and social sectors need to come together to adopt sustainability initiatives, strengthen ecological communication and build a multi-stakeholder roadmap to address existing gaps, barriers and challenges on our sustainability journey. Companies should measure the impact they have on the environment and how this can be reduced, for example, through carbon footprints. It is believed that each of the sustainability-led initiatives should have a significant social impact.

Each of the efforts empowers communities and societies towards behavioural change communication, which eventually benefits them at large. It is recommended that companies set aside at least 15 per cent of their corporate social responsibility (CSR) funds for environmental causes. A slight amendment to the Companies Act, 2013 to ensure that a set percentage of CSR funds get reserved for CER will be a massive move. Ideally, it is also recommended to define frameworks for capturing several indicators and make this reporting mandatory.

## Little evidence that carbon offsets reduce deforestation, emissions

n early 2023, the Guardian published an article suggesting that more than 90% of rainforest carbon offsets are worthless. These credits are essentially a promise to protect forests and can be bought as a way to "offset" emissions elsewhere. Verra, the largest certifier of these offset credits, said the claims were "absolutely incorrect" but the story still shook confidence in the billion-dollar market. Soon after, Verra's CEO stood

The claims in the Guardian article rested heavily on analysis which had been published as a preprint (before peer review). Now the research has been fully peer-reviewed and is published in the journal Science. It shows unequivocally that many projects which have sold what are known as REDD+ (reducing emissions from deforestation and degradation) credits have failed to reduce deforesta-

REDD+ projects aim to slow deforestation (for example, by supporting farmers to change their practices). They quantify the carbon saved through reducing deforestation relative to what would have happened without the project, and sell these emission reductions as

Such REDD+ credits are widely used to "offset" (that is, cancel out) emissions from companies (who may use them to make claims that their operations are carbon neutral) or by people concerned about their carbon footprint. For example, if you were planning to fly from London to New York you might consider buying REDD+ credits that promise to conserve rainforest in the Congo Basin (with added benefits for forest elephants and bonobos). Offsetting your return flight would appear to cost a very affordable

However, while previous analysis showed that some REDD+ projects have contributed to slowing deforestation and forest degradation, the central finding from the new study is that many projects have slowed deforestation much less than they have claimed and, consequently, have promised greater carbon savings than they have delivered. So that guilt-free flight to New York probably isn't carbon neutral after all.

The finding that many REDD+ carbon credits have not delivered forest conservation is extremely worrying to anyone who cares about the future of tropical forests. We spoke to Sven Wunder, a forest economist and a coauthor of the new study. He told us that: "To tackle climate change, tropical deforestation must be stopped. Forests also matter for other reasons: losing forests will result in loss of species, and will affect regional rainfall patterns. Despite the evidence that REDD+ has not been delivering additional conservation. we cannot afford to give up."

Deforestation could shift elsewhere

Carbon credits also face other challenges, one of the biggest being "leakage" or displacement of deforestation. Leakage may occur because the people who were cutting down the forest simply relocate to a different area. Alternatively, demand for food or timber that was fuelling deforestation in one place may be met by deforestation elsewhere - perhaps on the other side of the world.

Another problem is ensuring that the forests are protected in perpetuity so that reduced deforestation represents permanent removal of carbon from the atmosphere.

Addressing these challenges is vital because selling carbon credits is an important source of finance for forest conservation. It is not too dramatic to say that unreliable REDD+ credits directly threaten forests.

However, this is an active research area and new approaches are increasingly available. Andrew Balmford is a professor of conservation science at the University of Cambridge who is actively developing methods to improve the credibility of forest carbon markets. He says the new study raises some important concerns but that more robust and transparent methods have been developed. Deploying these new methods, he told us, is "an urgent priority".

Change is also needed to how certification operates. At present, there are incentives for verifiers to inflate estimates of the amount of deforestation that would have happened without the project, and therefore the number of credits that can be issued. Sven Wunder explains: "We need to move beyond vested interest towards independent governance employing scientifically informed, cuttingedge methods.'

Reasons to be cautious

Even if these problems can be solved, there are still reasons to be cautious about the role of carbon offsets in combating climate change. First, there is the risk that offsetting actually increases emissions because people or companies might feel more comfortable emitting carbon if they believe they can undo any damage by simply buying carbon credits. For this reason, some argue that offsets must only ever be a last resort, after all non-essential emissions have been cut (the problem being of course: who decides which emissions are essential?).

Second, keeping warming within 2 degrees Celsius will require most deforestation to be stopped and major reductions in fossil fuel emissions. There is a limit to which one can be used to balance out the other.

Finally, there are serious equity concerns with some forest carbon offsets. If forest conservation is achieved by stopping farmers in low-income countries from clearing land for agriculture, REDD+ may exacerbate poverty: your long haul flight would come at the expense of others being able to feed their fami-

We don't know how much it would cost to achieve genuinely additional offsets which avoid leakage and ensure equity but it is likely to be considerably more expensive than forest carbon credits currently sell for. A higher price would reduce the perception that offsetting is an easy option and should encourage more focus on reducing emissions. So, should you buy those cheap forest carbon offsets when taking a flight? Unfortunately, there's currently little evidence that doing so will really make your journey carbon neutral. If you want to contribute to tackling climate change, perhaps the only real option is to not take the flight. (Courtesy: Scroll.in)

## Sustainable agriculture, climate change and nutrition: A complex challenge

ecent years have seen a surge in recognition of the complex and interdependent relationship between food insecurity, climate variability, sustainable agricultural practices, and land utilisation. This interdependent network has far-reaching consequences for the health of the planet and its citizens. Jong Un offered Russian President Vladimir Putin on Wednesday his country's "full and unconditional support" for Russia's "sacred fight" to defend its security interests, in an apparent reference to the war in Ukraine, and said Pyongyang will always stand with Moscow on the "anti-imperialist" front.

Kim also called North Korea's relations with Russia "the first priority."

The leaders met at a remote Siberian rocket launch facility for a summit that underscores how their interests are aligning in the face of their countries' separate, intensifying confrontations with the United States.

Putin in his opening remarks welcomed Kim to Russia and said he was glad to see him. Putin listed economic cooperation, humanitarian issues and the "situation in the region" among the agenda items for their talks. The two men began their meeting at the Vostochny Cosmodrome, Russia's most important domestic satellite launch centre, with a tour of a Soyuz-2 space rocket launch facility, at which Kim peppered a Russian space official with questions about the rockets. Kim and Putin then met together with their delegations and later one-on-one, according to Kremlin spokesperson Dmitry Peskov.

Following the tour, the two leaders headed a meeting of their delegations, and then spoke one-on-one.

The meeting came hours after North Korea fired two ballistic missiles toward the sea, extending a highly provocative run in North Korean weapons testing since the start of 2022, as Kim used the distraction caused by Putin's war on Ukraine to accelerate his weapons develop-

South Korea's Joint Chiefs of Staff didn't immediately say how far the North Korean missiles flew. Japan's Coast Guard, citing Tokyo's Defence Ministry, said the missiles have likely already landed but still urged vessels to watch for falling objects.

Putin welcomed Kim's limousine, brought from Pyongyang in the North Korean leader's



launch facility with a handshake that lasted around 40 seconds. Putin said he was "very glad to see" Kim. Kim's translator thanked Putin for the warm welcome, "despite being busy."

The decision to meet at Cosmodrome suggests that Kim is seeking Russian technical assistance for his efforts to develop military reconnaissance satellites, which he has described as crucial in enhancing the threat of his nuclear-capable missiles. In recent months, North Korea has repeatedly failed to put its first military spy satellite into orbit.

Official photos showed that Kim was accompanied by Pak Thae Song, chairman of North Korea's space science and technology committee, and navy Adm. Kim Myong Sik, who are linked with North Korean efforts to acquire spy satellites and nuclear-capable ballistic missile submarines, according to South Korea's Unification Ministry.

Asked whether Russia will help North Korea build satellites, Putin was quoted by Russian state media as saying "that's why we have come here. The DPRK leader shows keen interest in rocket technology. They're trying to develop space, too," using the abbreviation for North Korea's formal name, the Democratic People's Republic of Korea. Asked about military cooperation, Putin said "we will talk about all issues without a rush. There is time."

For Putin, the meeting with Kim is an oppor-

month-old war has drained. North Korea may have tens of millions of aging artillery shells and rockets based on Soviet designs that could give a huge boost to the Russian army in Ukraine, analysts say.

Kim also brought Jo Chun Ryong, a ruling party official in charge of munitions policies who joined him on recent tours of factories producing artillery shells and missile, according to South Korea.

Kim said his decision to visit Russia four years after his previous visit showed how Pyongyang is "prioritising the strategic importance" of its relations with Moscow, North Korea's official news agency said Wednesday.

Kim is expected to seek economic aid as well as military technology. Deputy Foreign Minister Andrei Rudenko said Russia may discuss humanitarian aid with the North Korean delegation, according to Russian news agencies.

An arms deal would violate international sanctions that Russia supported in the past.

Lim Soo-suk, South Korea's Foreign Ministry spokesperson, said Seoul was maintaining communication with Moscow while closely monitoring Kim's visit.

"No U.N. member state should violate Security Council sanctions against North Korea by engaging in an illegal trade of arms, and must certainly not engage in military cooperation with North Korea that undermines the peace and stability of the international community,' Lim said at a briefing.

The United States has accused North Korea of providing Russia with arms, including selling artillery shells to the Russian mercenary group Wagner. Both Russian and North Korean officials denied such claims.

Speculation about military cooperation grew after Russian Defence Minister Sergei Shoigu visited North Korea in July. Kim subsequently toured his weapons factories, which experts said had the dual goal of encouraging the modernisation of North Korean weaponry and examining artillery and other supplies that could be exported to Russia. #### Rescuers recover over 2,000 bodies after floods devastate eastern Libya

**Derna, Sept 13:** Rescuers have found more than 2,000 bodies as of Wednesday in the wreckage of a Libyan city where floodwaters broke dams and washed away neighbourhoods. Officials fear the death toll could exceed 5,000 in the nation made vulnerable by years of turmoil and neglect.

Mediterranean storm Daniel caused deadly flooding in many eastern towns, but the worst-hit was Derna. As the storm pounded the coast on Sunday night, Derna residents said they heard loud explosions when the dams outside the city collapsed. Floodwaters washed down Wadi Derna, a river running from the mountains through the city and into the sea.

Rescue teams were working day and night to recover many other bodies scattered in the streets and under the rubble in the city. Some bodies were retrieved from the sea. The startling devastation pointed to the storm's intensity, but also Libya's vulnerability. The country is divided by rival governments, one in the east, the other in the west, and the result has been neglect of infrastructure in many areas. The floods damaged or destroyed many access roads to Derna, hampering the arrival of international rescue teams and humanitarian assistance to tens of thousands of people whose homes were destroyed or damaged.

Libya's neighbours, Egypt, Algeria and Tunisia, as well as Turkiye and the United Arab Emirates, have sent rescue teams and humanitarian

## Ukrainian pilots could be flying F-16s in 3 months: Air National Guard head



NATIONAL HARBOR, MD. **Sept 13:** The U.S. could have the first Ukrainian pilots trained on F-16 fighter jets before the end of the year, though it will be longer than that before they are flying combat missions, the director of the U.S. Air National Guard said on Tuesday.

The Ukrainian pilots are expected to arrive at Morris Air National Guard Base in Tucson, Arizona, by October. Those aviators are being evaluated for English language skills right now, and depending on their proficiency and previous fighter jet experience, they could complete the U.S. training within three months. Lt. Gen. Michael Loh, director of the U.S. Air National Guard, said at the annual Air Force Association convention in National Harbor, Maryland."As soon as they're given a go-ahead, they'll be coming over and they'll start their training immediately," Loh said.

To meet the quick training timeframe, Tucson will likely shift some of its other international pilot training commitments to move Ukraine to the front of the line, he said.

"It's a national priority," Loh said. However, after completing the U.S. training, the Ukrainians would need to return to Europe for additional NATO training. NATO allies are also training Ukrainians on how to maintain the aircraft, and that will also need to be completed before the jets would be flying combat missions. Loh did not have an estimate

training would take.Gen. David Allvin, the nominee to become the next chief of the Air Force, told senators at his confirmation hearing Tuesday that, on average, the F-16 training will take six to nine months.

Ukraine's leaders have asked for fighter jets from the West since the earliest days of the war. For the first year and a half, the U.S. and other allied partners focused on providing other weapons systems, citing the jets' cost, concerns about further provoking Russia, the number of deadly air defense systems Russia had covering Ukrainian airspace and the difficulty in maintaining the jets.

Since then the war has become a gruesome, slow-moving fight with ground tactics and trench warfare reminiscent of World War I, and for that, the F-16's ability to suppress enemy air defenses and conduct lowaltitude attacks could help Ukraine, Loh said. In addition, unlike some other systems pledged to Ukraine, the F-16 is still in production, and because it is widely used by a number of international partners, there are plenty of spare parts.

"I definitely think it can be a game changer," Loh said.Sen. Richard Blumenthal, D-Conn., asked Allvin if the training could be accelerated. noting that the Ukrainian forces learned how to operate other systems, such as the Stryker and Bradley fighting vehicles, faster than

## Pak court extends judicial remand of Imran Khan in cipher case till Sep 26

**ISLAMABAD, Sept 13:** A special court in Pakistan on Wednesday extended judicial remand of jailed former Prime Minister Imran Khan in the cipher case till September 26. The special court – newly formed to hear cases related to the Official Secrets Act, 1923

- Judge Abul Hasnat Zulqarnain conducted the hearing of the cipher case inside the Attock Jail where the former prime minister is currently lodged. Former Foreign Minister Shah Mahmood Qureshi was also produced in court on Wednesday following the completion of his 14-day judicial remand.

The 70-year-old chairman of the Pakistan Tehreeke-Insaf (PTI) party has been kept in jail since August 5 after his conviction in the Toshakhana corruption case. His sentence was suspended by the Islamabad High Court (IHC) on August 29, but he continues to late Tuesday and rescuers struggled to remain in Attock prison in the cipher case. His remand has been extended till September 13 by a special court in the case. The cricketer-turned-politician is charged with the violation of the Official Secrets Act in connection with the leakage of a confidential diplomatic cable from Pakistan's embassy in Washington. The special court hearing the case extended Khan's remand till September 26.

"Judicial remand of Chairman PTI Imran Khan extended till September 26," Khan's PTI party said in a brief message on WhatsApp. The court also extended Qureshi's judicial remand till September 26.

Earlier, the law ministry issued a notification on Tuesday, expressing no objections to conducting the trial in jail, saying that special court judge Abul re-

quested that proceedings be held in Attock jail "due to security reasons". The hearing comes at the end of a 14-day judicial remand which was ordered by the court on the last hearing conducted in the same jail. The ministry in its notification cited unspecified security issues for allowing hearing in the jail premises. However, Khan's spokesman Zulfiqar Bukhari rejected the plea and demanded a trial in a normal

"Hearing continues citing security concerns, a preposterous excuse saturated with malice when there can be video link appearance if not in person," he said in a statement. Bukhari also said that the authorities had not waited for the outcome of the case heard by the Islamabad High Court (IHC) against Khan's trial in jail. The IHC on Tuesday reserved its order on a petition against the conduct of Khan's trial in prison, rather than Islamabad.

Chief Justice Aamer Farooq concluded proceedings by saying that he would pass an "appropriate order". Cipher Case Hearing is to proceed at Attock Prison premises on Wednesday despite a petition filed & awaiting a reserved decision by the Islamabad High Court which is yet to be announced. The hearing continues citing security concerns, a preposterous excuse saturated with malice when there can be a video link appearance if not in person.

The cipher case was filed last month against Khan on the allegations of violating secret laws of the country in the matter of a cable sent by the Pakistan embassy in Washington in March last year. (PTI)

## Japan's Kishida shuffles Cabinet and party posts to solidify power

TOKYO, Sept 13: Japanese Prime Minister Fumio Kishida is shuffling his Cabinet and key party posts on Wednesday in an apparent move to strengthen his position before a key party leadership vote next year, while appointing more women to showcase his effort for women's advancement in his conservative party.

It's the second Cabinet shuffle since Kishida took office in October 2021 when he promised fairer distribution of economic growth, measures to tackle Japan's declining population and a stronger nanal defense Russia's Ukraine, rising energy prices and Japan's soaring defense costs have created challenges in his tenure, keeping his support ratings at low levels.

Kishida's three-year term as Liberal Democratic Party president expires in September 2024, when he would seek a second term. His faction is only the fourth largest in the LDP, so he must stay on good terms with the others to maintain his position.

He distributed Cabinet posts to reflect the balance of power, and nearly half of the positions are shared between the two largest factions associated with late leader Shinzo Abe and former leader Taro

Kishida appointed five women in his 19-member cabinet, part of his attempt to buoy sagging support ratings for his male-dominated Cabinet. He previously had two, and five matches Abe's 2014 Cabinet and one in 2001 under then-Prime Minister Junichiro Koizumi, and women still hold

## Thrust of UN reform has to be to 'democratise' **Security Council: UNGA President**

**UNITED NATIONS, Sept 13:** UN General Assembly President Dennis Francis has said it is "incongruous" that only five countries can exercise certain powers within the UN Security Council, underlining that the thrust of reform has to be to "democratise" the powerful UN organ, making it more fit for purpose in the 21st century. "Ît's not untrue that the architec-

ture of the Security Council was designed a very long time ago, decades ago when geographically and geopolitically the world was a very different place," Francis, President of the 78th session of the UN General Assembly, told PTI in an exclusive interview here.

Francis said many countries did not exist at the time when the UN Security Council was formed more than seven decades ago, particularly developing countries in the Global South and "countries like my own Trinidad and Tobago. We would at that time have been represented by the British.

"But the world has changed. Democratisation has spread across the globe. There are many more sovereigns at the table and the United Nations itself has realised that there is a need to rethink and re-engineer the Security Council," Francis, a veteran diplomat from Trinidad and Tobago who was elected President of the General Assembly in June, said.While the UNSC reform process is ongoing, Francis said "it is incongruous that only five countries can exercise certain powers



within the Council", referring to the five permanent members -China, France, Russia, the UK and the US - who have veto powers.

While 10 countries are elected for two-year terms to become members of the 15-nation Council on a rotating basis, only the permanent five have veto power.

"This is bothersome for many people, for many delegations. The thrust of the reform therefore has to be to democratise the Security Council to make it more fit for purpose in the 21st century, given that we are in a different geopolitical structure, one that most probably involves a multipolar world and where important decisions need to be taken in a more timely fashion. particularly on things like issues of human rights and humanitarian

India, the world's most populous country, has been at the forefront of years-long efforts to reform the Security Council, saying it rightly deserves a seat as a permanent

member at the UN high table, which in its current form does not represent geo-political realities of the 21st century. Earlier this month, India's Permanent Representative to the UN Ambassador Ruchira Kamboj said that an expansion of the Council in both permanent and non-permanent categories of mem-

bership is absolutely essential. "This is the only way to bring the Council's composition and decision-making dynamics in line with contemporary geo-political realities," Kamboj had said.

"What we...need is a Security Council that better reflects the geographical and developmental diversity of the United Nations today. A Security Council where voices of developing countries and unrepresented regions, including Africa, Latin America and the vast majority of Asia and Pacific, find their due place at this horse-shoe table," she had said.

India has asserted that the international community can no longer

hide behind the smokescreen of the Inter-Governmental Negotiations (IGN) in the General Assembly and continue to pay lip service by continuing to deliver statements in a process which has no time frame, no text and no defined goal to achieve. "If countries are truly interested

in making the Council more accountable and more credible, we call on them to come out openly and support a clear pathway to achieve this reform in a time-bound manner, through the only established process in the UN, which is by engaging in negotiations based on text and not through speaking at each other, or past each other, as we have done for the last three decades," Kamboj has said.

Francis noted that there is a degree of "hope" currently in the sense that while the UN Charter assigns primary responsibility for peace and security to the Security Council, the General Assembly also exercises certain residual powers over peace and security. He referred to the General Assembly resolution adopted two years ago requiring that any permanent member of the Council that uses the veto explain to the Assembly why it was

necessary to use the veto. "This is an important innovation that had not existed before and it is designed to enhance the level of transparency and accountability of the Security Council. But the work of reform of the Council is continuing," he said. (PTI)

#### A cruise ship with 206 people onboard has run aground in Greenland

COPENHAGEN, Sept 13: A Bahamas-flagged Norwegian cruise ship with 206 passengers and crew has run aground in northwestern Greenland, authorities said on Tuesday, adding that no one on board was in danger and no damage has been reported.

"Our units are far away, and the weather can be very unfavourable," said Cmdr. Brian Jensen of the Joint Arctic Command.

The closest Danish navy ship was about 1,200 nautical miles (more than 2,000 kilometers or 1,380 miles) away, he said, adding it was heading to the site and could be expected at the grounded ship as soon as Friday. Jensen said in a statement there is no immediate danger to human life or the environment, but that officials "take this incident very seriously".

The 104.4-metre (343-foot) long and 18-metre (60 foot) wide Ocean Explorer ran aground on Monday in Alpefjord in the Northeast Greenland National Park. It's the world's largest and most northerly national park and is known for icebergs and the musk oxen that roam the coast.

The ship belongs to Ulstein Group in Ulsteinvik, southern Norway.

Authorities have been in contact with another cruise ship in the area and it had been asked to remain nearby to assist should the situation develop. The other cruise ship was not identified.



The grounded cruise ship might also get free on its own when the tide is high. Greenland television KNR reported. "Regardless, the most important thing for us is that everyone gets to safety," Jensen said. Later Tuesday the Joint Arctic Command said on its Facebook page that the ship was still stuck despite

"There are still no reports that human life or the environment is in acute danger," Joint Arctic Command said. The primary mission of the Joint Arctic Command is to ensure Danish sovereignty by monitoring the area around the Faeroe Islands and Greenland, two semi-independent territories that are part of the Danish realm. Speaking on the occasion, Jamir said fish is an extremely perishable food commodity unless frozen and stored in deep freezers for which the department came with the idea to provide motorcycles with ice boxes to unemployed youths to encourage

sustainable fish business. He said the motorcycles with ice boxes can be used to supply fish in the interior areas where four wheelers cannot ply.

## Nagaland Assembly refers new Municipal Bill to select committee

land Assembly recently decided to refer the Nagaland Municipal Bill 2023 to the Select Committee for further consideration.

The decision to this effect was taken on the second day of the monsoon session of the Assembly after the members deliberated on the Urban Local Bodies (ULBs) election which has not been held in the northeastern state for almost two decades.

The first and last election to Urban Local Bodies in Nagaland was held in 2004.

During its March session, the Assembly had repealed the Nagaland Municipal Act 2001 and decided to bring about a new law incorporating the views of the tribal bodies and civil societies on 33 per cent women reservation and also tax on land and properties.

The government had announced conduct of the elections to ULBs several times but staunch objection from the tribal bodies and civil society organisations against the 33 per cent women reservation and tax on land & properties had held back the polls.

In 2017, when the state government led by T R Zeliang tried to hold the elections, there was violence. Two persons were killed and government properties and offices were damaged. It also led to the fall of the Zeliang ministry. The Neiphiu Rio-led all-party government in March this year also announced conduct of an election with 33 per cent women reservation as directed by the Supreme Court.

However, following stiff resist-



celled the elections and also repealed the Act of 2001.

In the September 1 consultative meeting with the tribal bodies and civil society organisations convened by the state government, it was decided that ULB elections will be held with women quota and that the government will table the new Act in the monsoon session of the Assembly

On Tuesday, at least nine members led by minister for parliamentary affairs K G Kenye participated in the discussion and they were of the view that while women's quota is welcome, the final Bill should be referred to the select committee and also placed before the public for a consensus.

First-time women legislators minister Salhoutuonuo Kruse and MLA Hekani Jakhalu - also participated in the discussion.

## by gunmen, bombs hurled

IMPHAL, Sept 13: Conflict-torn Manipur witnessed a fresh incident of violence as unidentified gunmen, suspected to be cadres of banned terror groups, attacked people and hurled bombs at a village in Imphal West district, bordering Kangpokpi where three persons were killed a day before, officials said on Wednesday.

No one was injured in the incident in Koutruk village where armed men hurled at least ten bombs late Tuesday night, they said.

The bomb attack triggered panic among the villagers, an official said, adding that Indian Reserve Battalion personnel deployed at the area fired

The fresh violence comes after unidentified armed men, suspected to be members of the outlawed terror groups, killed three persons from the tribal community on Tuesday morning near Kharam Vaiphei village in Kangpokpi district. Tension is still running high in several parts of the district as there is apprehension of fresh attacks in the wake of the killing of three persons, the officials said.

Koutruk is one of the worst violence-hit areas in Imphal valley and has witnessed several exchanges of fire between the two warring groups since clashes broke out on May 3.

Earlier this week, a 14-year-old girl was hit by a bullet that pierced through the wall of her residence at Koutruk.

More than 180 people have been killed and several hundred injured since ethnic violence broke out in Manipur early in May, when a 'Tribal Solidarity March' was organised in the hill districts to protest against the majority Meitei community's demand for Scheduled Tribe status. (PTI)

#### Failing to implement NEP 2020 will impact NEHU affiliated colleges: Conrad

His statement came a day after the teachers of 22 colleges under the banner of the Meghalaya Col-Teachers' (MCTA) decided not to withdraw their ongoing non-cooperation movement (NCM) as a mark of protest against the NEHU VC's refusal to withdraw the July 12-notification, which asks all affiliated colleges to implement NEP from the current academic year.

The CM however refused to further comment on the matter citing that he doesn't have the details with him at the moment.

Stating that the State is going ahead with the NEP implementation, Sangma said, "There is no going back on that.

He also urged individuals and colleges to come forward and discuss the issues they have with the State government.

"We can discuss the problems that you have. Maybe the problems that you are seeing are actually not even there so maybe some clarity or some discussion is required. There are some misunderstandings but we will clarify those," he

#### Nagaland Assembly passes bills to revise taxes on motor vehicles and goods

KOHIMA, Sept 13: The Nagaland Assembly on Tuesday passed two bills that seek to revise taxes on motor vehicles and goods transported in them.

Another bill was for amending an Act to include various new subjects to be taught in the North East Christian University. The Bills were introduced on September 11, the first day of the monsoon session. Chief minister Neiphiu Rio, who also holds the transport department, said the motor vehicles tax for transport vehicles was last revised in 1999 and for private ve-

hicles, the same was done in 2009. The tax rate prevalent in Nagaland is low as compared to other states in the country, Rio stated adding that the hiring charges for transport vehicles have significantly increased and the road conditions too have improved over the years. Taking into account the rise



in price and to improve the financial health of the state, he said the government proposes for revision of the Motor Vehicles Tax by amending the Act. The Nagaland Motor Vehicles Taxation (Amendment) Bill, 2023 and The Nagaland Passengers & Goods Taxation (Amendment) Bill were passed by voice vote on Tuesday. The North East Christian University (Second Amendment) Bill 2023 was passed to include new subjects such as nursing, and medical sciences and research. (PTI)

#### SHILLONG, Sept 13: As teachers continue to protest the imple-Education Policy 2020 in colleges across the state, Meghalaya Chief Minister Conrad K Sangma on Wednesday underlined that decisions of all stakeholders in education should revolve around the interests of students and not other-

Talking about NEP 2020, he spoke at length on the need for colleges to offer a broader range of courses, which necessitates additional resources and infrastructure and financial implications of about ₹ 400-500 crore.

His statement came in the wake of teachers from 22 of 75 colleges affiliated to the North Eastern Hill University protesting against the implementation of the four-year degree courses as envisaged under NEP 2020 for lack of infrastructure

and proper training. "Decisions should be taken by keeping the students' interest and future in mind. The management committee, teachers, officials and political leaders, we all should focus on this and not the pressure and dharnas here and there. These are secondary," the chief minister said, addressing the closing ceremony of the 100-year celebration of Laban Bengali Boys Higher Secondary School here.

He warned that political interference in anything that revolves around education could have an adverse impact on the future of students. According to the chief minister,

"Politics in education is bad. Politicians may want to take decisions for politics. Sometimes, teachers may decide what is good for them and the managing committees may decide due to political

"While all of these are important, in the last 50 years, we forgot that the centre of all of this is the student," he added. On NEP 2020, the chief minister

said there will be a new syllabus, there will be requirements and that it is a process that goes on and requires huge investments.



"There are challenges. The needs are quite large, we are looking at an investment of ₹ 300-400 crore to be able to move forward," he added. Talking about the complex nature of Meghalaya's education sector, he said the state has over 55,000 teachers and close to

15,000 schools and educational institutes.

As compared to Manipur or Nagaland with similar population structure, the chief minister said these states have around 3000-5000 schools and 18,000 teachers.

"The number of schools is huge.

Because of the spread and the numbers, things are not manageable at the level that we want to be," he said, adding that the state government is on the verge of normalisation of certain institutions

that would benefit the students. The chief minister congratulated the school on the historic milestone of 100 years and said it is the vision of the founding members and the commitment and the dedication of the past and present teachers and members of the managing committee that has brought the school to its present glory.

"I can say confidently that the education sector is one of the top priorities of the government and the government has adopted student-centric policies to better education facilities," he said.

The chief minister emphasized student-centric decision-making and said the education cess collected by the state government, which was lying unused until recently, has been diverted towards improving infrastructure in all government schools. (PTI)



NEW DELHI, Sept 13: The New Delhi Declaration adopted at the G20 Summit emphasised the "strengthening" of the fight against illicit trafficking of cultural property at the national, regional or international levels to enable its "return and restitution" to their countries and communities of origin.

Protection and restitution of cultural property is one of the four pillars of culture articulated under India's presidency of the influential grouping. The G20 Summit was held at the newly-built

Bharat Mandapam at Pragati Maidan from September It was attended by US President Joe Biden, UK

Prime Minister Rishi Sunak and French President Emmanuel Macron, among other world leaders. The declaration, the adoption of which was announced by Prime Minister Narendra Modi, came out at the start of the second session of the G20 Leaders'

Summit on September 9. The declaration also highlights the "crucial role of tourism and culture" as a means for sustainable socioeconomic development and economic prosperity, and takes note of the Goa Roadmap for Tourism as one of the vehicles for achieving the Sustainable Develop-

ment Goals (SDGs). "We call for the full recognition and protection of culture with its intrinsic value as a transformative driver and an enabler for the achievement of the SDGs and advance the inclusion of culture as a standalone goal in future discussions on a possible post-2030 development agenda," reads the text of the declaration, under the sub-head 'Culture as a Transformative Driver of SDGs'.

The Preamble of the New Delhi Leaders' Declaration begins by asserting that "We are One Earth, One Family, and we share One Future".

As Leaders of G20, the premier global forum for international economic cooperation, "we resolve to act in concrete ways through partnerships", and "we commit to accelerate strong, sustainable, balanced and inclusive growth", it says.

In the sub-head 'Culture as a Transformative Driver of SDGs', the declaration also speaks about the illicit trafficking of cultural property and their restitution to their countries and communities of origin as relevant.

"We reiterate our commitment to strengthen our fight against illicit trafficking of cultural property at national, regional or international levels to enable its return and restitution to their countries and communities of origin as relevant, and call for sustained dialogue and action in that endeavour, with a view to strengthening cultural diplomacy and intercultural exchanges, consistent with national law and relevant UNESCO Conventions," it reads.

Prior to the summit, over 200 G20 events at nearly 60 locations across India were held, including four meetings of the G20 Culture Working Group and a G20 Culture Ministerial Meeting, and four meetings of the G20 Tourism Working Group and a G20 Tourism Ministerial Meeting.

The fourth and last Culture Working Group meeting was held in Varanasi from August 23-25, followed by the Culture Ministerial Meeting on August 26 in

At the end of the G20 Culture Ministerial Meeting, an Outcome Document and Chair's Summary -'Kashi Culture Pathway' -- was issued.

The 'Kashi Culture Pathway' reiterated the deepest concern for the "continued looting and illicit trafficking of cultural property - including through the rise of the online market and other digital and social platforms, which may require specific regulation – as well as for organised crime committed globally against cultural heritage and cultural institutions"

The outcome document further underlined that "destruction and illicit trafficking of cultural property are serious crimes and can be linked to money laundering, corruption, tax evasion and terrorist financing,

notably in conflict or post-conflict situations, and reiterating our commitment to strengthen the fight against illicit trafficking of cultural property".

G20 Culture Ministerial Meeting's Outcome Document and Chair's Summary -- 'Kashi Culture Pathway; and G20 tourism ministers' Meeting Outcome Document and Chairs' Summary, are among the documents which have been annexed to the G20 leaders' declaration.

In the Varanasi ministerial meeting, deliberations were held on the four pillars of culture articulated under India's presidency of the G20.

These pillars are the protection and restitution of cultural property, harnessing living heritage for a sustainable future, promotion of cultural and creative industries and creative economy, and leveraging digital technologies for the protection and promotion of cul-

The G20 leaders in the New Delhi declaration also resolved to "encourage the international community to protect the living cultural heritage, including the intellectual property, notably with regard to the impact of the over-commercialisation and misappropriation of such living heritage on the sustainability and on the livelihoods of practitioners and community bearers as well as Indigenous Peoples". # Army colonel and major, Dy SP killed in gunfight with terrorists

Two Army personnel and one J&K Police personnel injured'

SRINAGAR, Sept 13: An Army commanding officer, a Major and a Deputy Superintendent of Jammu and Kashmir Police were killed in a gunfight with terrorists in the higher reaches of Kokorenag area in the south of the valley, officials said here on Wednesday.

Colonel Manpreet Singh, Commanding Officer of 19 Rashtriya Rifles, Major Ashish Dhonack, and Deputy Superintendent Humayun Bhat were critically injured in the gunfight with terrorists that ensued in the Garol area of Anantnag district in the morning hours of Wednesday.

The officers succumbed to their injuries during the treatment, they said. Bhat, father of a two-monthold daughter and son of retired Inspector General of Jammu and Kashmir Police Ghulam Hasan Bhat, died due to heavy blood loss, they added.

**NEW DELHI, Sept 13:** Veteran BJP leader B S Yediyurappa on Wednesday said discussions are still underway on the party joining hands with JD(S) in Karnataka for the 2024 Lok Sabha polls and the central leaders will take a final call.

The statement is a marked dilution of his earlier assertion that both parties have already finalised their alliance for the elections next year and the BJP central leadership has agreed to give the regional party four seats.

Speaking to reporters on Wednesday, Yedivurappa said Prime Minister Narendra Modi, union home minister Amit Shah and the party's central leadership will decide on the alliance.

"We do not know what's in the mind of Modiji and Amit Shahji... The discussions are still underway," he said.

The decision on seat-sharing is left to the central leaders, he said adding that he neither has any say in this matter nor will offer any suggestion.

The top court said there is an urgent need for a Standard Operating Procedure (SOP) about how journalists should be briefed as there has been an upsurge in reporting on criminal offences in print, electronic and social media since the last guidelines on the subject were issued by the Ministry of Home Affairs (MHA) in 2010.

A bench headed by Chief Justice D Y Chandrachud said a delicate balance has to be maintained between the media's fundamental right to free speech and expression, the right of the accused to fair investigation, and the privacy of the victim. The top court also

## IIT Mandi, France's INRIA develop AI-Based algorithms for structural assessment of bridges

Institute of Technology (IIT), Mandi and National Institute for Research in Digital Science and Technology (INRIA) in France have developed advanced Artificial Intelligence (AI) and signal processing techniques to accurately predict structural health of bridges and other struc-

These AI-based algorithms have broad applications, not limited to bridges alone, and can be extended to structures such as ropeways, buildings, aerospace structures, transmission towers, and various infrastructure elements requiring periodic health assessments and protection measures, the researchers claimed.

According to officials, there are over 13,500 bridges across India.

"These structures undergo natural ageing due to environmental factors like temperature fluctuations, and water and air exposure, compounded by heavy road traffic. Traditionally, assessing bridge conditions has relied on visual inspections, a method considered inadequate by experts.

"It falls short in detecting all structural issues and is subjective and time-consuming, involving manual analysis of numerous photographs," said Subhamoy Sen, Associate Professor, School of Civil and Environmental Engineering, IIT Mandi.

The findings of the research have recently been published in the journals Mechanical Systems and Signal Processing and Neural Computing and Applications

Recent advances in instrumentation, data analy-



sis and AI tools like deep learning hold great promise for structural health monitoring (SHM) of bridges and other structures.

These technologies make it easier to detect, measure, understand, and even predict the evolution of defects over time. This, in turn, enables more effective planning for renovation or repair work, ultimately reducing maintenance costs and extending the lifespan and availability of bridges.

The research team at IIT Mandi claims to have developed such a Deep Learning-based SHM approach. Their AI algorithms can identify and isolate structural damages by analysing recorded ambient dynamic responses, all without the need for human intervention.

"We have employed data-driven methods like Machine Learning, AI, and Bayesian statistical inference to estimate a bridge's health and prethe potential to reduce risks to infrastructure under operational and adverse loading condi-"Temperature fluctuations can greatly affect a

bridge's dynamic traits, especially prestressed

concrete, and cable-stayed bridges. It is therefore important to consider these temperature effects in both real-time and AI-based SHM. "IIT Mandi's algorithm was rigorously validated on a real bridge in a cold region with extreme annual and daily temperature swings," he

Sen explained that to assess the algorithm's damage detection capabilities, the IIT Mandi researchers initially tested it on an undamaged

Subsequently, they intentionally induced damage in the computer model to evaluate the algorithm's accuracy in pinpointing the damage's location. This testing confirmed the algorithm's

efficacy in identifying structural damage. In another related study, the researchers used advanced filtering techniques to estimate the condition of different structural components without the need for direct measurement of their

"This technique enables the separate assessment of each component's health, which can in turn help in evaluating overall structural integrity. The method was validated using computer simulations of a beam exposed to various forces and demonstrated robust performance in handling challenges like background noise and damage severity," he said. #### Libya floods claim over

Only two roads from the south remain usable, and they involve a long, winding route through the mountains. Aid teams with some supplies managed to get in that way, but local emergency workers otherwise, were relying on whatever equipment they already had on hand. Collapsed bridges split the city centre, further hampering movements. Ossama Ali, a spokesman for the Ambulance and Emergency Centre in eastern Libya, said at least 5,100 deaths were recorded in Derna, along with around 100 others elsewhere in eastern Libya. More than 7,000 people were injured in the city, most receiving treatment in field hospitals that authorities and aid agencies set up, he told The Associated Press by phone on Wednesday. The number of deaths is likely to increase since search and rescue teams are still collecting bodies from the streets, buildings and the sea, he said. At least 30,000 people in Derna were displaced by the flooding, the UN migration agency said. The damage is so extensive that the city is almost inaccessible for humanitarian aid workers, the International Organization for Migration said.

The startling devastation pointed to the storm's intensity, but also Libya's vulnerability. The country is divided by rival governments, one in the east, the other in the west, and the result has been neglect of infrastructure in many areas. "This is a disaster in every sense of the word," a wailing survivor who lost 11 members of his family told a local television station as a group of rescuers tried to calm him. The television station did not identify the survivor. Ahmed Abdalla, a survivor who joined the search and rescue effort, said they were putting bodies in the yard of a local hospital before taking them for burial in mass graves at the city's sole intact cemetery. "The situation is indescribable. Entire families have perished in this disaster. Some were washed away to the sea," Abdalla said by phone from Derna. Bulldozers worked over the past two days to fix and clear roads to allow the delivery of humanitarian aid and heavy equipment urgently needed for the search and rescue operations. Derna is 250 kilometres east of Benghazi, where international aid started to arrive on Tuesday. (PTI)

The final aircraft is expected to be delivered to the IAF by August 2031.

"It was only two years ago that we signed this contract with India, the largest order in the history of the C295," said Jean-Brice Dumont, Airbus' Head of Military Air Systems. "Today, we are enhancing the capabilities of the Indian Air Force and modernizing its transport fleet by delivering the first aircraft on schedule. This is the beginning of an exciting and long-term journey with the Indian Air Force," he said.

The production of components of these aircraft has already started in the Main Constituent Assembly (MCA) facility in Hyderabad, southern India. These parts will be shipped to the Final Assembly Line (FAL) in Vadodara which is expected to be operational by November 2024. (PTI)



"We felt like a big family going into the tournament, and the captain never let anything ruin that atmosphere. His captaincy played a big part in us winning the maiden

World Cup," said Chandana. Chandana, who is now a full-time coach, remembered Ranatunga as a shrewd tactician, whose strategic acumen were way ahead of the time.

"It was after his thought that we used Sanath (Jayasuriya) and Kalu (Romesh

Kaluwitharana) as openers. It was a masterstroke as other teams were not ready for that kind of batting in Power Plays," said

pendent on their openers - Fakhar Zaman and Imam-ul-Haq - and captain Babar Azam for big runs.

They need some runs from the likes of Mohammad Rizwan and Salman Agha, and urgently too. Iftikhar Ahmed showed his bighitting prowess with a blistering hundred against Nepal, but he needs to do that more consistently against better oppositions.

NEW DELHI, Sept 13: Saina Nehwal is aware that qualifying for the Paris Olympics will be "tough" for her but the injury-ravaged Indian shuttler has no plans to quit badminton and would do everything under the sun to resurrect her career.

Laid low by a spate of injuries, including a recurring knee issue, and other health problems, the 33year-old from Hyderabad has found it tough to stay fit to consistently turn up at the BWF World Tour events.

Her ranking has plummeted to number 55 in the world.

"I get inflammation in my knee whenever I train for an hour or two. I am not able to bend my knee so a second session of training is not possible. The doctors have given me a couple of injection. Of course the Olympics is near and it is tough (to qualify)," Saina told reporters.

"But I am trying my level best to comeback. The physios are helping me but if the inflammation doesn't reduce, it will take little more time to recover. I also don't want to play half-heartedly and results will also not come.

"If you are trying to compete against An Seyoung, or Tai Tzu Ying or Akane (Yamaguchi), it won't happen with just one hour of training. The level has improved so much. So when you are playing



a high level game," Saina, who was named the 'Race Ambassador' for Harvest Gold Global Race on September 24 in Gurugram, said.

The former world number 1 last played at the Singapore Open in June this year. It was her sixth tournament of

the season. She managed just one quarterfinal finish in 14 events in 2022, while a semifinal finish at Orleans Masters was her best performance in 8 events in 2021. 'If you are thinking about the

## Demise of Pranobjit Chaliha, aka 'Romuda', casts shadow over Sivasagar

SIVASAGAR, Sept 13: Sivasagar has been enveloped in sorrow as it mourns the passing of Pranobjit Chaliha, affectionately known as 'Romuda'. He was a towering figure in the realm of Assamese nationalism and a respected veteran in the world of sports. Romuda breathed his last at AMCH, Dibruhagh, around 2:30 pm on Wednesday at the age of 73, succumbing to a prolonged battle with bronchial

Pranobjit Chaliha played a pivotal role in the Assam Movement and was incarcerated over a hundred times for his involvement in anti-government protests and his impassioned speeches. Despite his commanding presence in the political landscape, Chaliha never aspired to hold a ministerial position in the AGP ministry under Prafulla Mahanta's leadership. He remained an unwavering advocate for the common people and vociferously criticised corrupt politicians and others for betraying the nation.

During his tenure as the general secretary of AASU, Sivasagar unit from 1972 to 1974, Chaliha was incarcerated a record 127 times. He made headlines for his fiery protests against the government during Prime Minister Indira Gandhi's public address in Sivasagar in 1979. Additionally, Chaliha served as the general



secretary of the Sivasagar Sports Association from 1996 until last year.

Pranobjit Chaliha leaves behind his wife Raka Chaliha, son Shringkhal Chaliha, and daughter Karbi. His legacy as a passionate advocate for Assamese nationalism and uncompromising champion of the common people will be remembered and revered by many.

## English translation of Golap Khound's 'Girmit' debuts at New Art Players
