Govt making sincere attempts to draft laws

in simple manner, Indian languages: Modi



NEW DELHI, Sept 23: Prime Minister Narendra Modi on Saturday said his government is making sincere attempts to draft laws in a simple manner and in Indian languages to the maximum extent.

Inaugurating the International Lawyers' Conference here, he also flagged concerns about cyber terrorism and money laundering besides the use of artificial intelligence for destructive purposes.

Modi said these dangers do not recognise borders and jurisdiction and called for collaborative efforts among legal frameworks of different countries to deal with them.

"When danger is global, then the manner

to deal with it should also be global," he said. The Prime Minister cited the example of cooperation between air traffic control systems of all countries to ensure air travel and said preparing a global framework to deal with these dangers is not about one govern-

ment or country Chief Justice of India D Y Chandrachud, Union law minister Arjun Ram Meghwal, Lord Chancellor and secretary of state for Justice of the United Kingdom Alex Chalk KC, Attorney General for India R Venkataramani, Solicitor General Tushar Mehta, Bar Council of India chairman and senior advocate Manan Kumar Mishra and others, including several judges of the apex court, were present at the event. Commenting on the legal system, he said the language used to write laws and in the judicial process plays a big role in ensuring justice.

"We in the Indian government are thinking that law should be produced in two ways. One draft will be in the language you are used to," he said to the audience drawn from the legal field. "The second draft will be in a language which the country's common man can understand. (CONTD. ON PAGE-9)

Heroin seized

GUWAHATI: In an operation launched by the Special Task Force (STF) of Assam based on a source input regarding a potential drug consignment, six drug peddlers were apprehended in Guwahati. The operation resulted in the seizure of 46 grams of heroin concealed in 33 vials. "The team of STF got hold of six drug peddlers along with 46 grams of heroin concealed in 33 vials," Assam Police spokesperson Pranabjyoti Goswami said. One of them hails from Meghalaya and others are from various places of Assam, Goswami added. "The recovered heroin and the six apprehended drugs peddlers were handed over to the Basistha Police Station for initiating necessary legal actions by registering a case," he further said. Another senior official said that the value of the seized drug would be nearly ₹37 lakh as per Narcotics Control Bureau standards.

NIA arrests suspected terrorist

NEW DELHI: The NIA has arrested a suspected terrorist for his alleged links with Myanmarbased rebel groups and conspiring to wage war against India by exploiting the current ethnic unrest in Manipur, an official said. Moirangthem Anand Singh was arrested from Manipur and brought to New Delhi for questioning, a spokesperson of the NIA said. Singh was one of the five persons arrested by Manipur Police for possessing weapons looted from police armoury. The arrest had led to agitation by the majority community, who were claiming them to be village defence activists. A local court had granted bail to all the five on Friday. However, Singh was immediately placed under arrest and whisked away to an undisclosed location before being brought to the national capital. The official said Singh was arrested in a case related to a "transnational conspiracy" by Myanmar-based leadership of terror groups to wage war against the govt of India by exploiting the current ethnic unrest in Manipur.

CM's wife files ₹ 10-crore defamation suit against Gaurav

GUWAHATI, Sept 23: Riniki Bhuyan Sarma, the wife of chief minister Himanta Biswa Sarma, has filed a ₹ 10-crore defamation suit against Congress MP Gaurav Gogoi for "false" allegations of irregularities in a food processing project.

Senior advocate Devajit Saikia, her counsel, told PTI that the case has been filed at the Court of Civil Judge (Senior Division) of Kamrup Metropolitan on Friday and it will be moved on September 26.

"My client has claimed a defamation of ₹ 10 crore against Gaurav Gogoi for various tweets on X. We have made it very clear that we never made any application to receive subsidy," he added.

Saikia further claimed that the process to seek subsidy has not been initiated at all and for which, a show cause notice was slapped on his client's firm on May 26 this year, followed by an email from the Ministry of Food Processing.

"The approval for the project was given on November 22, 2022. In the last email, we were told that our claim would lapse if we didn't submit our proposal. We are not responding to anything to seek subsidy," he added.

Whatever Gogoi stated on social media about Sarma and her entity 'Pride East Entertainments', that information was not based on facts. claimed the senior advocate.

"He (Gogoi) did not do his homework. Getting approval for a project does not mean that a subsidy has been received. We will fight the case tooth and nail," he asserted.

GUWAHATI, Sept 23: In a significant step towards fulfilling election promises made during the 2021 State Assembly elections, chief minister Himanta Biswa Sarma attended the ceremonial distribution of relief under "Category - III" of the Assam Microfinance Incentive & Relief Scheme (AMFIRS) 2021. This event took place at the Janata Bhawan Complex in Dispur on Sat-

Under Category - III of AMFIRS 2021, borrowers whose accounts had become non-performing assets (NPAs) as of March 31, 2021, and have an outstanding principal amount of up to ₹ 25,000 are eligible for benefits. The state government is allocating ₹ 291 crore as

compensation to microfinance institutions. This move is expected to benefit approximately 2.2 lakh borrowers across the state. In return, the microfinance institutions will issue "no due certificates" to these borrowers, making them credit-worthy again within the formal financial

Speaking at the event, chief minister Himanta Biswa Sarma expressed his happiness that around 2.2 lakh female microfinance and bank loan borrowers would regain their creditworthiness through the Category - III relief. He highlighted the unique nature of the Assam Microfinance Incentive & Relief Scheme, which aims to provide relief to eligible borrowers who had taken small loans from microfinance institutions and the formal banking system but were unable to repay the borrowed amount in full due to certain circumstances.

Chief minister Sarma expressed gratitude to the microfinance institutions for waiving approximately ₹ 300 crore in interest income to facilitate the successful implementation of Category - III relief measures. He appealed to beneficiaries to ensure timely and full repayment of any future loans, emphasising that providing beneficiaries with "no due certificates" would aid in universal financial inclusion. 2.5% of Assam **Police personnel** fail BMI test: DGP

HT Bureau GUWAHATI, Sept 23: Approximately 2.5% of Assam Police's 70,161 personnel have failed the Body Mass Index (BMI) test, according to DGP Gyanendra Pratap Singh. These personnel will undergo medical care over the next three months to improve their fitness. The BMI test initiative for Assam Police personnel began on August 16, with a total of 70,161 tests conducted. Out of these, 1,748 personnel were found to be obese, with BMI readings exceeding 30.

In response to this, the Chief Minister's office approved a plan to provide these individuals with thorough medical examinations at Government Medical Colleges. They will receive medical and nutritional support and be retested after three months. The goal is to help them improve their BMI and overall health. DGP Gyanendra Pratap Singh expressed hope that these personnel would become fit in the coming days and years

As previously stated, those who do not reduce their weight by the end of the three-month period will be offered a voluntary retirement option, except for those with genuine medical reasons like thyroid issues, according to the DGP.

Announcing the news of social media, the DGP said, "Reference BMI tests, the first phase of the exercise is over. Total no of BMI tests done for @assampolice personnel: 70161. No of Obese (30+BMI) Police Personnel: 1748 (2.47%).

As approved by Hon @CMOfficeAssam these personnel would now be thoroughly tested at Government Medical Colleges for any underlying medical condition and provided medical and nutritional support and tested again after three months. Hope to see a fitter Assam Police in days and years to come. Grateful to Hon CM Sir @himantabiswa Sir and @mygovassam for continued support in our quest to improve fitness of @assampolice." Canada shared evidence of 'credible allegations' on Nijjar's killing with India 'many weeks ago': Trudeau

TORONTO, Sept 23: Canadian Prime Minister Justin Trudeau has said that Canada shared with India "many weeks ago" evidence that it may have been behind the killing of Khalistan separatist Hardeep Singh Nijjar on Canadian soil and wants New Delhi to commit constructively with Ottawa to establish the facts in the "very serious matter."

Trudeau, however, did not elaborate on the evidence that he says has been shared with India.

"Canada has shared the credible allegations that I talked about on Monday with India. We did that many weeks ago...We hope that they engage with us so that we can get to the bottom of this very serious matter. That's important," he said in a press conference with the visiting Ukrainian President Volodymyr Zelenskyy. "And what we are asking is for India to commit constructively with Canada to establish the facts on this situation. We're there to work with them. And we have been for weeks now," Trudeau said in response

When asked about Canada sharing any information in the case with India, the Ministry of External Affairs (MEA) in New Delhi said: "No specific information has been shared by Canada on this case, either then or before or after. We have, you know, as we have said, or I think we have made very clear, we are willing to look at any specific information."

"We have conveyed this to the Canadian side and made it clear to them that we are willing to look at any specific information that is provided to us. But so far we have not received any such specific information," MEA spokesperson Arindam Bagchi said in New Delhi. Tensions flared between India and Canada early this week following Trudeau's explosive allegations of the "potential" involvement of Indian agents in the killing of Khalistani extremist Nijjar on his country's soil on June 18 in British Columbia.

India had designated Nijjar as a terrorist in 2020. India angrily rejected the allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case. Trudeau said Canada is working with its partners over the matter.

US Ambassador to Canada David Cohen also confirmed that "shared intelligence among Five Eyes partners" had informed Trudeau of the possible involvement of Indian agents in the killing of Nijjar.

This is the first admission by any US government official about the sharing of intelligence by Five Eyes partners with Canada even when there were multiple unofficial and non-official reports about the same, CTV News channel reported. 'Five Eyes' network is an intelligence alliance consisting of the United States, United Kingdom, (CONTD. ON PAGE-9)

"The Director apologised to us with folded hands and he is like our father. We trust him and respect his



assurances, so we are calling off the agitation," a student Rishi Kant said.

The director has "assured us that the Dean Academics will be removed within two days", Kant

He (Director) also assured the students that the agitation period would not be counted in the academic calendar and none of them

would be marked absent, Kant said. Baidya had met the students for the first time on Friday afternoon but the students said that they would call off the strike only if they received written assurance from the authorities. Later in the night they, however, agreed to call off the agitation as the entire discussion was video recorded.

"The Director told us that they want to start anew, leaving behind all the issues of the past. They could have prevented violence by talking to the students on time. We don't want to pressurise, change has to come from both sides," Kant said.

"The authorities can close the institute for an indefinite period if we continue with the agitation and we don't want that," he said.

Home Ministry has taken steps to fence 60 km of the international border in Manipur," he said.

The CM claimed that the present situation was a result of unplanned policies of the previous governments and not an immediate aftermath of any recent decision.

TRAI recommends measures to boost telecom infra in North Eastern states

issued recommendations for bolstering telecom infrastructure in North East, suggesting parleys with the state governments to harmonise their respective 'right of way' policies with related Central rules, as well as favouring provision of electricity to telecom sites on priority at utility tariffs.

The Telecom Regulatory Authority of India (TRAI) noted that while a number of initiatives have been taken by the government to improve telecom connectivity in the northeastern states, there is still a lack of high-speed mobile-based internet and fixed broadband connectivity, mainly due to the inadequate transmission bandwidth (optical fibre, Microwave and satellite)

"The Northeast states continue to grapple with a significant digital divide due to various reasons such as inhospitable terrain conditions, poor availability of power supply, transmission media related limitations, poor return of investment prospects for TSPs, and Right of Way (RoW) related issues," the sector regulator said in a release.

While speaking with PTI on the sidelines of the groundbreaking ceremony of Micron's semiconductor plant, Vaishnaw said that the global semiconductor company is noticing the progress made by India in the segment and Prime Minister Narendra Modi's capability to execute large and complex policy decisions.

"This has developed India as a major trusted geography in which global industry players want to come. We can see in the coming few months at least two more large semiconductor proposals taking shape," Vaishnaw said.

He said that there are some specific areas where India can take the lead and the focus of the semiconductor projects will be in areas that can help the country export technology to other parts of the world.

The minister said that the Micron plant, for which construction has started, will start producing the first chip from December 2024 onwards. Memory chip maker Micron in June announced setting up a semiconductor assembly and test plant in Gujarat entailing a total investment of USD 2.75 billion (around ₹ 22,540 crore).

825 million in setting up the plant in two phases and the rest of the investment will come from the Centre and the state government.

The company has roped in Tata Projects for phased construction of the new assembly and test facility in Sanand.

Phase 1 will include 500,000 square feet of planned cleanroom space, and will start to become operational in late 2024.

The minister said semiconductor demand is expected to grow to Rs 5 lakh crore in coming years from about Rs 2 lakh crore.

"India is already a very large design hub. With manufacturing coming to India, the entire process and value chain will come to our country and Bharat will become a major semiconductor hub in coming years," Vaishnaw said. Micron Senior Vice President Gursharan Singh at the event said that the company has boarded the first set of 34 employees for the plant.

Five suppliers of Micron including SIMTEC are evaluating possibilities to set up their plant in India, according to government officials.

Minister of State for Electronics and IT Rajeev Chandrasekhar said that the Micron facility in Gujarat marks the beginning of an exciting journey in India's semiconductor ecosystem, in making India a semiconductor nation.

"Micron's state-of-the-art modern facility will serve as a beacon for all investors, manufacturers, and participants in the global semiconductor ecosystem, encouraging them to partner with India," Chan-

In 2022, the government's deposits in commercial banks amounted to over ₹ 2 trillion, and due to its sovereign borrowings in the absence of use of this idle cash, an amount of ₹ 424 billion was paid in interest, the World Bank

For the medium term, it proposed reducing federal development and current expenditures on provincial nature projects, reducing spending on loss-making entities, and improving the quality of development spending to save about ₹ 1.4 trillion. The cumulative impact of these short- to mediumterm savings is 2.7 per cent of the

Pakistan is heavily subsidising the agriculture sector, leading to low productivity, the global lender said, adding that the government can reduce ₹ 328 billion in spending by winding up ministries that fall in the provincial domain.

It said that another ₹ 70 billion can be saved by devolving the Higher Education Commission to the provinces, and ₹ 217 billion savings can be ensured through cost sharing of BISP (Benazir Income Support Programme) with the provinces.

This comes as inflation soared to 27.4 per cent in August after the cash-strapped country received USD 1.2 billion from the Washington-based International Monetary Fund in July, a part of the USD 3 billion bailout programme for nine months to support the government's efforts to stabilise the country's ailing economy.

Pakistan's economy has been in a free-fall mode for the last many years, bringing untold pressure on the poor masses in the form of unchecked inflation. (PTI)



Captivity as both metaphor and material reality: Catherine Ingrassia's domestic captivity and the British subject

It seems like a narrative from a distant past, but we are very much the heirs of the 18th century," said Catherine Ingrassia, Professor of English at Virginia Commonwealth University, during her interview with VCU News on her recently published book, "Domestic Captivity and the Eighteenth-Century Subject, 1660-1750," from Virginia Press. I had the pleasure of meeting her at VCU, where I joined as Affiliate Faculty in English. As the Chair of the English Department, she plays a central role in the humanities at VCU. Her book delves into seventeenth- and eighteenth-century Britain, exploring how captivity became both a metaphor and a reality during this time. By examining this perspective on British life, she calls for a re-evaluation of how literary texts, which contain connections to the slave trade or other forms of captivity, are understood. Catherine Ingrassia began her career

at VCU in 1992 as an Assistant Professor of English and steadily progressed to become an Associate Professor in 1998 and a full professor in 2005. In 2019, she was appointed as the Chair of the Department of English, bringing nearly 30 years of experience to this role. Her extensive experience includes serving as the Associate Dean for Academic Affairs and Executive Associate Dean for Research and Graduate Affairs in the CHS Dean's Office from 2005 to 2011. Her leadership and multi-pronged approach have enhanced the visibility, accessibility, and personality of the institution. She has strategically used social media, focused on intentional branding, and improved student development experiences. Within the College, she has been instrumental in creating the interdisciplinary PhD in Media, Art, and Text (MATX) and the Humanities Research Center. Her contributions have been recognized with the CHS Distinguished Service Award.


Beyond VCU, Catherine Ingrassia

has held various leadership positions including serving as the Founding President of the International Eliza Haywood Society and chairing the Modern Language Association's Executive Committee for Restoration and Early Eighteenth-Century English Literature. She has also served as an editor and advisor for prestigious journals in her field, such as PMLA, Eighteenth-Century Studies, and Eighteenth-Century Novel. Her teaching career has been equally impressive, earning her the Innovative Course Design Competition Award from the American Society for Eighteenth-Century Studies. Her courses, such as "The Persistence of Pride and Prejudice" and "Cultures of Captivity in the Long Eighteenth Century," have captivated a wide audience.

Catherine Ingrassia's first book, "Authorship, Commerce, and Gender in Early Eighteenth-Century England: A Culture of Paper Credit," published by Cambridge University Press, set the stage for her promising career, which continues to expand. Her research profile includes notable publications such as "Teaching Beyond the Heteronormative: Fantomina and Queering Eliza Haywood," "Adaptation and the 'invisible world' of Jane Austen," and "Gendered Dialogues in Satire." Her exemplary research, with numerous well-placed articles and essays in prominent journals and essay collections, serves as an inspiration to her

Additionally, her work as an editor for influential essay collections, including "British Women Poets of the Long Eighteenth Century," "Companion to the Eighteenth-Century Novel and Culture," and "Cambridge Companion to Women's Writing in Britain, 1660-1789," further solidifies her reputation as one of the most respected scholars in her subfield. Her latest book, "Domestic Captiv-


ity and the British Subject, 1660-1750," continues Catherine Ingrassia's commitment to research, historical contextual scrutiny, and feminist



methodologies. It explores how captivity shaped identity, actions, and human relationships for white British subjects, as depicted in fictional texts by British authors of that period. Through an analysis of the popular press, unpublished personal correspondence, and archival documents, she provides a rich cultural description that contextualizes these literary texts within the material world of captivity.

The book highlights the interconnectedness between "domestic captivand England's systematic enslavement of kidnapped Africans, which early fictional narratives either suppressed or ignored. Catherine Ingrassia's insightful analysis prompts a reevaluation of literary texts, shedding light on their connection to the slave trade or other forms of captivity.

According to Dr Ingrassia, captivity, much like British involvement in the trade of enslaved people, was so prevalent and normalized during the period that it became unremarkable in literary texts. However, she urges readers to recognize the discrepancy between the notion of "liberty" central to British national identity and its limited application in the lives of British subjects. She emphasizes that the experience of being a captive subject was not con-



graphic distance; it also influenced other aspects of life in Britain. The book also uncovers the particularly oppressive conditions faced by women held captive within colonial and domestic spaces. Dr Ingrassia believes that even today, the inequities and power imbalances along the lines of race and gender are still prevalent, both in Britain and other parts of the world. Through her work. Catherine Ingras-

sia hopes to encourage readers to reconsider the true meaning of "liberty" in British society and to recognize how captivity shaped the lives of marginalized individuals, including children, impressed sailors, indigent labourers indentured servants, and married women. She highlights that Britain's financial system, reliant on the labour of enslaved people, permeated various aspects of life, even if those individuals lived geographically distant from Britain. The publication of her book catalyzes critical reflection and a call to acknowledge and understand the historical and ongoing impacts of captivity and systemic inequalities. Ukraine targets key Crimean city a day after striking the Russian navy headquarters

Saturday morning launched another missile attack on Sevastopol in occupied Crimea, a Russian-installed official said; a day after an attack on the headquarters of Russia's Black Sea Fleet left a serviceman missing and the main building smouldering.

Sevastopol was put on air raid alert for about an hour after debris from intercepted missiles fell near a Gov. Mikhail Razvozhayev wrote on the messaging app Telegram. Ferry traffic in the area was also halted and later resumed.

Loud blasts were also heard near Vilne in northern Crimea, followed by rising clouds of smoke, according to a pro-Ukrainian Telegram news channel that reports on developments on the peninsula. Crimea, illegally annexed by Russia in 2014, has been a frequent target for Ukrainian forces

full-scale invasion of the neighbouring country almost 19 months ago.

Ukraine's intelligence chief, Kyrylo Budanov, told Voice of America on Saturday that at least nine people were killed and 16 injured as a result of Kyiv's attack on the Black Sea Fleet on Friday.

He claimed that Alexander Romanchuk, a Russian general commanding forces along the key southeastern front line, was "in a very serious condition" following the attack. Budanov's claim could

not be independently verified, and he did not comwhether Western-made missiles were used in Friday's strike.

The Russian Defense Ministry initially said that Friday's strike killed one service member at the Black Sea Fleet headquarters, but later issued a statement that he was missing.

Ukraine's military also



offered more details about Friday's attack on Sevastopol. It said the air force conducted 12 strikes on the Black Sea Fleet headquarters, targeting areas where personnel, military equipment and weapons were concentrated. It said two anti-aircraft missile systems and four Russian artillery units were hit.

Crimea has served as the hub supporting

Ukraine. Sevastopol, the main base of Russia's Black Sea Fleet since the 19th century, has had a particular importance for navy operations since the start of the invasion of Ukraine.

Pak's PM says manipulation of coming elections by military is 'absolutely absurd'

UNITED NATIONS, Sept 23: ary, delaying the vote which was to Pakistan's interim prime minister said he expects parliamentary elections to take place in the new year, dismissing the possibility that the country's powerful military would manipulate the results to ensure that jailed former premier Imran Khan's party doesn't win.

In an interview with The Associated Press on Friday, Anwaar-ul-Haq Kakar said it's the Election Commission that is going to conduct the vote, not the military, and Khan appointed the commission's chief at the time, so "why would he turn in any sense of the word against him?"

Pakistan has been in deepening political turmoil since April 2022 when Khan was removed from office following a no-confidence vote in Parliament. He was arrested in early August on corruption charges and sentenced to three years in prison, later suspended though he still remains in jail.

The country is also facing one of the worst economic crises in its history and recovering from last summer's devastating floods that killed at least 1,700 people and destroyed millions of homes and farmland.

The commission announced on Thursday the elections would take place during the last week in Janube held in November under the constitution.

Kakar resigned as a senator last month after outgoing Prime Minister Shehbaz Sharif and opposition leader Raza Riaz chose him as caretaker prime minister to oversee the elections and run the day-to-day affairs until a new government is elected.

Kakar said that when the commission sets an exact election date his government "will provide all the assistance, financial, security or other related requirements."

Asked whether he would recommend judges overturn Khan's conviction so he could run in the elections, the prime minister said he wouldn't interfere with decisions by the judiciary.

He stressed that the judiciary should not be used "as a tool for any

Pak court to hear jailed ex-PM Imran Khan's A court in China sentences a famed Uyghur scholar to life in prison, foundation says post-arrest bail plea in Cipher case

ISLAMABAD, Sept 23: The Islamabad High Court on Saturday fixed September 25 as the date for hearing jailed former prime minister Imran Khan's post-arrest bail in a case related to the alleged disclosure of state secrets.

Khan, 70, filed a petition in the Islamabad High Court (IHC) against the rejection of his post-arrest bail by a special court that is proceeding against him and former foreign minister Shah Mahmood Qureshi in the case. The special court on September 13 extended the judicial remand of Khan and two-time foreign minister Qureshi till September 26 in the cipher (secret diplomatic cable) leakage case. Both Khan and Oureshi have been accused of violating the secret laws of the country regarding a document sent by the Pakistan embassy in March last year that has gone missing.

According to a cause list issued by the IHC registrar for the coming week, IHC Chief Justice Aamer Farooq will hear the Pakistan Tehreeke-Insaf party chief's bail petition on Monday (September 25), The News reported. Earlier this week, the court issued a notice to the Federal Investigation Agency (FIA), seeking arguments in the case. The special court established under the Official Se-

crets Act — had rejected the post-arrest bail pleas of Khan and his party's Vice Chairman Qureshi in the case. Last month, the FIA booked the PTI chief and his party's vice chairman under the Official Secrets Act

for allegedly misplacing and misusing the classified document for vested political interests. Subsequently, both leaders were arrested in connection with the investigation into the case and a special court was established under the Official Secrets Act to try the accused. Khan has been kept in the Attock Jail since Aug 5 after his conviction in the Toshakhana corruption case. His sentence was suspended by the Islamabad High Court (IHC) on August 29, but he continues to remain in Attock prison in the cipher case. (PTI)

Rahile Dawut to life in prison is a cruel tragedy, a great loss for the Uyghur people, and for all who treasure academic freedom," John Kamm, executive director of the Dui Hua Foundation, said in a statement. Dawut was a professor at Xin-

jiang University and founder of the school's Ethnic Minorities Folklore Research Center. She disappeared in late 2017 amid a brutal government crackdown aimed at the Uyghurs, a Turkic, predom-

For years, her exact status was unknown, as Chinese authorities didn't disclose her whereabouts or the nature of the charges against her. That changed this month when the Dui Hua Foundation saw a Chinese government document disclosing that Dawut was sentenced to life in prison.

Chinese Ministry of Foreign Affairs spokesperson Mao Ning said she had "no information" on Dawut's case at a regular press briefing Friday, but added that China would "handle cases in ac-

Dawut was internationally renowned for her work studying sacred Islamic sites and Uyghur cultural practices in Xinjiang and across Central Asia, authoring many articles and books and lecturing as a visiting scholar abroad, including at Cambridge and the University of Pennsylvania.

She is one of over 400 prominent academics, writers, performers and artists detained in Xinjiang, advocacy groups say. Critics say the government has targeted intellectuals as a way to dilute, or even erase, Uyghur culture, language and identity.

"Most prominent Uyghur intellectuals have been arrested. They've been indiscriminate," said Joshua Freeman, an Academia Sinica researcher who used to work as a translator for Dawut. "I don't think it is anything about her work that got her in trouble. I think what got her in trouble was that she was born a Uyghur."

News of her life sentence shocked Freeman and other academics in Uyghur studies, as Dawut didn't engage in activities opposing the Chinese government. Dawut was a member of the Chinese Communist Party and received grants and awards from the Chinese Ministry of Culture before her arrest.

Dawut's daughter, Akeda Pulati, said she was stunned by the news and called on the Chinese authorities to release her mother.

"I know the Chinese government is torturing and persecuting the Uvghurs. But I didn't expect them to be that cruel, to give my innocent mother a life sentence, Pulati said. "Their cruelty is beyond my imagination.'

Pulati called Dawut "the hardest working person I've ever met,' saying that since she was a child. she had been inspired by her mother's dedication to her career.

"She's a very simple person all she wants in her life is just to find enjoyment in her work and her career and do something good for society, for the people around her," Pulati said.

Mukaddas Mijit, a Uyghur ethnomusicologist based in Brussels, said Dawut had been an important advisor to her and many other scholars early in their careers. Dawut was a critical bridge between global academia and Uyghur culture, Mijit said, mentoring a generation of prominent Uyghur scholars across the world.

"She was a guardian of Uyghur identity, and that's something the Chinese government is after,"

"They want to erase everything. and they want Uyghurs to forget how beautiful and colorful a culture they had." (AP)

IMPHAL, Sept 23: Manipur chief minister N Biren Singh on Saturday said that his government has urged the Union Home Ministry to cancel the free movement regime along the India-Myanmar border and complete its fencing.

The free movement regime allows people residing close to both sides of the India-Myanmar border to venture 16 km deep into each other's territory without any document. Addressing reporters here, he said the government will continue to deal with the influx of "illegal immigrants" and stressed the need for complete fencing of the India-Myanmar border.

'The Union Home Ministry has taken steps to fence 60 km of the international border in Manipur," he said. The CM claimed that the present situation was a result of unplanned policies of the previous governments, and not an immediate aftermath of any recent decision.

"Our government has requested the Union home Ministry to cancel the free movement regime. Also, security forces have not properly guarded the border. Instead of being deployed at zero point, they were found guarding the border 14-15 km inside Indian territory," he

Nagaland announces PMMVY for pregnant women, lactating mothers

HT Correspondent DIMAPUR, Sept 23: The Nagaland

State Social Welfare Board has announced the implementation of the Pradhan Mantri Matru Vandana Yojana (PMMVY) to provide financial assistance to pregnant women and lactating mothers, with a particular focus on empowering girl children. Under the scheme, the pregnant women and lactating mothers will receive a monetary benefit of Rs 5,000 for their first live birth and Rs 6,000 for the second child, provided the second child is a girl.

The benefits will be disbursed through Direct Benefit Transfer (DBT) and can be availed up to nine months after childbirth.

Special enrollment for mothers of the second child born (girl child) on or after April 1, 2022, will be available till September 30, 2023.

The primary objective of PMMVY includes providing partial financial support to pregnant and lactating mothers to enhance their health and nutrition during pregnancy and postdelivery, along with compensation for wage loss, if any.

It also aims to promote positive behavioral change towards girl children by offering additional cash incentives for the second child if it is a girl. The scheme is applicable for the first two live births, provided the second child is a girl. Beneficiaries can register for the PMMVY before 270 days from childbirth.

The board said the beneficiaries can apply at the nearest Anganwadi centre, district programme officer and child development project officer and district hub for empowerment of women attached to the deputy com-

NEW DELHI, Sept 23: The Congress on Saturday attacked Prime Minister Narendra Modi over the architecture of the new Parliament building alleging that it has killed democracy and conversations, a charge the BJP slammed as an insult to the aspirations of 140 crore Indians.Congress general secretary Jairam Ramesh alleged that the new Parliament building should be called a "Modi Multiplex or Modi Marriot".

"Perhaps a better use for the new Parliament building will be found after regime change in 2024," Ramesh claimed in a post on X.

"The new Parliament building launched with so much hype actually realises the PM's objectives very well. It should be called the Modi Multiplex or Modi Marriot. After four days, what I saw was the death of confabulations and conversations both inside the two Houses and in the lobbies. If architecture can kill democracy, the PM has already succeeded even without rewriting the Constitution,"

Hitting back, BJP president J P Nadda said, "Even by the lowest standards of the Congress Party, this is a pathetic mindset. This is nothing but an insult to the aspirations of 140 crore Indians."

"In any case, this isn't the first time Congress is anti-Parliament. They tried in 1975 and it failed miserably," Nadda also said on X.

Joining the BJP's counterattack, Union minister Giriraj Singh said "dynastic dens" all over India need



to be assessed and rationalised. "For starters, the 1, Safdarjung Road complex be immediately transferred back to the Government of India considering all Prime Ministers have their space at the PM Museum now," he said.

The address houses Indira Gandhi Memorial Museum, which was the then prime minister's residence where she was gunned down. It was converted into a museum.Ramesh also alleged that binoculars are needed to see each other since the halls in the new Parliament building are simply not cozy or compact.

The old Parliament building not only had a certain aura but it facilitated conversations. It was easy to walk between Houses, the Central Hall, and the corridors. This new one weakens the bonding needed to make the running of Parliament a success," he claimed.

The Congress leader said quick coordination between the two Houses is now exceedingly cum-

"In the old building, if you were lost, you would find your way back again since it was circular. In the new building, if you lose your way, you are lost in a maze. The old building gave you a sense of space and openness while the new one is almost claustrophobic.

"The sheer joy of simply hanging out in Parliament has disappeared. I used to look forward to going to the old building. The new complex is painful and agonising. I am sure many of my colleagues across party lines feel the same," he said. Ramesh claimed that he has also heard from the staff in the Secretariat that the design of the new building has not considered the various functionalities required to help them do their work. (PTI)

Probe unsavoury conduct of Danish Ali too: BJP MP to Speaker

NEW DELHI, Sept 23: BJP MP Nishikant Dubey said on Saturday the Lok Sabha Speaker should also probe the "unsavoury" conduct and remarks of Danish Ali, who was recently at the receiving end of ruling party member Ramesh Bidhuri's derogatory words in the House.

In a letter to speaker Om Birla, Dubey accused Ali of offering a running commentary during Bidhuri's speech in Lok Sabha on Thursday and making unsavoury remarks aimed at instigating him to lose his composure. Dubey alleged that Ali also made a "highly objectionable and blasphemous" remark against Prime Minister Narendra Modi. He used "neech" barb, the BJP leader claimed, saying it was more than enough for "any patriotic public representative to lose his calm and fall into his trap by uttering

Dubey was, however, categorical in condemning Bidhuri's comments. saying no decent society can justify them and they cannot be condemned

"But the Lok Sabha Speaker should also probe the unsavoury remarks and conduct of Danish Ali. Under Lok Sabha rules, obstructing another MP during the time allotted to him, speaking while sitting and giving a running commentary also call for punishment," he posted on X. In his letter, Dubey said TMC and DMK members also made comments about faith of another community. What he has writ-

ten is a verifiable fact, he claimed. If Bidhuri has committed an inappropriate act, then other members, including Ali, have also contributed in spreading enmity amongst communi-

NEW DELHI, Sept 23: If one imagines Ram Rajya', it should have good and

free education and healthcare for all, chief minister Arvind Kejriwal said on Saturday and announced a major expansion plan for health infrastructure in the city. Addressing a gathering at an event here, he also said that everybody should have access to good education and healthcare and the AAP-led Delhi government is trying to work in that direc-

He inaugurated a new OPD building of the Delhi government-run Aruna Asaf Ali Hospital on Saturday and also interacted with the patients there.

Healthcare and education are the focus areas of the Delhi government and expansion is going on in a major way, he said, adding that there are currently around 10,000 beds at all city government-run hospitals put together.

Eleven new hospitals are being built and the infrastructure of old facilities is being upgraded, he said, adding 16,000 new beds will be added.

Referring to the upcoming Dussehra and Diwali festivals, the Delhi chief minister said, "We worship Lord Ram."

"Ram Rajya is being spoken of. I cannot say that we can reach near 'Ram Rajya'. But if we imagine 'Ram Rajya'. it should have good and free education and good and free healthcare for all," Ke-

Good education and healthcare should be there for all, whether rich or poor, and "our government is trying to work in that direction", he added.

Delhi Health Minister Saurabh Bharadwaj, local MLA Parlad Singh Sawhney and senior officials of the health department were also present on the occasion.

Kejriwal, in his address, also that said



building of new hospitals and augmenting of infrastructure and facilities at existing hospitals will align Delhi's health system with international standards and the WHO's parameters.

The Delhi government has spent approximately ₹ 22.8 crore to construct the three-storey new OPD block at Aruna Asaf Ali Hospital, apart from the ground

The block houses 25 consultation rooms, two elevators, and two staircases. It took nearly a year to complete this construction, the chief minister's office (CMO) later said in a statement.

The old block lacked required space and other facilities. The new block is spacious, centrally air-conditioned with availability of rooms for specialists, he said. Previously, around 800-1,000 patients were coming to the hospital daily, now this number could increase 2-3 times after the opening of the new OPD block, the chief minister said.

"On one hand, we tried to improve the condition and quality of government hospitals, built many mohalla clinics and polyclinics...on the other side, we have managed to provide healthcare facilities for free. All medicines, tests, treatment, and operations are free in government hospitals," he added.

Earlier, these facilities were free for

the sake of being free as medicines were often out of stock and many machines used to be defunct, but now it's not the case, Kejriwal said.

"We may not reach the ideal of 'Ram Rajya,' but our government is striving in that direction," he was quoted as saying in the statement.

The construction of this new OPD block is one step closer to the target, he added

Located along Rajpur Road, Aruna Asaf Ali Hospital is a 100-bed multispecialty hospital providing round-the-clock services, and 45 major surgeries and 38 emergency surgeries are conducted at it per month, it said.

The CMO in the statement shared data about the upcoming 11 hospitals. The 11 hospitals being built will have

10,000 beds. These include hospitals at Siraspur (1,164 beds), Jwalapuri (691 beds), Madipur (691 beds), Hastsal (691 beds), Shalimar Bagh (1,430 beds), Sultanpuri (525 beds), Chacha Nehru Bal Chikitsalaya Annexe (610 beds), GTB Hospital Annexe (1,912 beds), Sarita Vihar (336 beds), Guru Gobind Singh Hospital Annexe (1,565 beds) and Kirari (485 beds),

the statement said. Under brownfield projects, 10 hospi-

tals being taken up, adding 6,505 beds. These projects include a new block at Lok Nayak Hospital (1,570 beds) and augmentation of beds at Satyawadi Raja Harish Chandra Hospital, Narela (773 beds); Baba Saheb Ambedkar Hospital, Rohini (1063 beds); among other hospitals, besides a casualty block at Lok Nayak Hospital (with 384 beds), the statement said.

Currently, 537 Aam Aadmi Mohalla Clinics are functional, out of which five are Mahila Mohalla Clinics, it added. (PTI)

If we imagine 'Ram Rajya', it should have good NIA confiscates Canada-based SFJ terrorist and free education, healthcare for all: Kejriwal Pannu's properties in Amritsar, Chandigarh



NEW DELHI/CHANDIGARH, Sept 23: Tightening its noose around Canada-based "designated individual terrorist" Gurpatwant Singh Pannu, the NIA confiscated a house and land of the self-styled general counsel of the outlawed Sikhs for Justice (SFJ) outfit in Puniab's Amritsar and the Union Territory of Chandigarh on Saturday, an official said.

The action, which comes as a big boost to the country's crackdown on the terror and secessionist network being operated from various countries, including Canada, followed confiscation orders passed by the Special NIA Court, SAS Nagar, Mohali (Punjab), a spokesperson of the National Investigation Agency (NIA) said.

The official said the properties confiscated include a 46-kanal (5.7 acres) agricultural land at Khankot village in Amritsar and a one-fourth share of a house in Chandigarh's sector 15/C area. These properties were earlier attached following orders passed by the government in two different cases, the spokesperson said, adding that they have now been confiscated on the court's orders under the relevant section of the Unlawful Activities (Prevention) Act (UAPA) in a case registered on April 5, 2020.

This is the first time that properties of an absconding accused of the NIA have been confiscated under section 33(5) of the the Indian Penal Code at the Sultanwind police station in Amritsar city and later, transferred to the NIA. A total of 10 accused, including Pannu, have so far been chargesheeted in the case.

Pannu has been on the NIA's radar since 2019, when the anti-terror federal agency registered its first case against the terrorist, who has been playing a major role in promoting and commissioning terror acts and activities, and spreading fear and terror in Punjab and elsewhere in the country through his threats and intimidation tactics. Nonbailable warrants of arrest were issued against Pannu by the Special NIA Court on February 3, 2021 and he was declared a "Proclaimed Offender" (PO) on November 29 last year.

"Investigations have revealed that Pannu's organisation, Sikhs for Justice, was misusing cyberspace to radicalise gullible youth and instigate them to undertake terrorist crimes and activities," the NIA spokesperson said.

The official said the investigations have further revealed that Pannu was the main handler and controller of the SFJ, which was declared an "Unlawful Association" by the Centre on July 10, 2019.

"Pannu, who was declared a 'designated individual terrorist' on July 1, 2020, has been actively exhorting Punjab-based gangsters and youth over the social media to fight for the cause of the independent state of Khalistan, challenging the sovereignty, integrity and security of the country," the spokesperson said. In recent days, the official said Pannu has been in the news for issuing blatant threats to senior Indian diplomats and government functionaries in public forums.

The NIA action came amid an escalating diplomatic row between India and Canada over the issue of the killing of Khalistani extremist Hardeep Singh Nijjar by unidentified UAPA. The case was originally registered on assailants in British Columbia in June. (PTI)

Union minister rebuts CPI(M)'s charges against ED in cooperative bank scam

THIRUVANANTHAPURAM, Sept 23: Union minister V Muraleedharan on Saturday rejected ruling CPI (M)'s claim that the investigation into the multi-crore Karuvannur bank scam was a deliberate move by the Centre targetting the Cooperative sector of Kerala.

Around ₹ 150 crore, invested by common people in the Karuvannur Cooperative Bank, were looted by some fraudsters but the Chief Minister, his cabinet colleagues and CPI (M) state secretary were justifying it, he alleged. Addressing media persons here, the BJP leader also sought to know if senior CPI (M) leader and MLA A C Moideen had done nothing wrong, then why was he not ready appear before the Enforcement Directorate despite repeated summons. Why even the former minister was afraid to answer the questions of the central investigating agency? he asked. Muraleedharan warned that those who looted the life savings of the poor would not be spared. He questioned the allegations raised by the CPI (M) that a witness in the case was assaulted and threatened by the ED officials so that he

would name senior party leaders in the case. On September 11, CPI(M) leader Moideen, was interrogated for over nine hours by the ED in connection with its probe into the ₹ 150 crore Karuvannur Cooperative bank scam which triggered a political row in Kerala recently. The case relates to the alleged fraud in the CPI(M)-con-

trolled Karuvannur Cooperative Bank. The ED has been questioning those involved in the case since it conducted raids at their premises last month. The ED had earlier issued freeze orders against bank and fixed deposits worth ₹ 28 lakh of Moideen, the former Kerala minister for Cooperation and Industries and his wife, apart from the seizure of 36 properties valued at ₹ 15 crore --"proceeds of crime" in this case. After the Kerala Police registered the FIR in July 2021, the registrar in their audit found "diversions" of more than ₹ 100 crore. (PTI)

Large number of vacancies in juvenile institutions having debilitating effect: SC judge S Ravindra Bhat NEW DELHI, Sept 23: Supreme Court judge S Ravindra Bhat on Saturday expressed concern over every institution in the juvenile justice system working "below" its strength, saying such a large

number of vacancies have a debilitating effect which could turn these bodies into "paper tigers" on matters of child protection. The apex court judge, who heads the Supreme Court Committee

on Juvenile Justice and Child Welfare, placed the issue "at the centre stage" during the inaugural session of its two-day national consultation and cautioned against "breakdown of the system" if the institutions become non-functional due to shortage of staff and officials. The national consultation is being organised by the Committee on September 23 and 24 on best practices followed in states and to further strengthen the justice system for children in conflict with law. The inaugural event was attended by Union Minister for Women and Child Development Smriti Irani, Supreme Court judge B V Nagarathna and other dignitaries including Cynthia McCaffrey, Representative of UNICEF India.

"Every institution - whether juvenile justice boards or child welfare committees or other such institutions - are running below their strength in the sense that most of them have a large number of va-

"These vacancies are actually very debilitating and they paralyse the system. Without the full strength of the child welfare committee or the appropriate available quorum, the committees is unable to function," said Justice Bhat in his keynote speech.

"Unless we establish and come out with a common protocol which makes it binding upon all the states, these institutions will become just paper tigers. They will be meaningless if you have to provide for the protection of children," the apex court judge stated. Justice Bhat said that the approach and initiative should be that a child delinquent can and should be reformed and therefore reformation must be the primary driver of all decisions taken for them. The judge added that measures like "group counselling" and

"community services" should be adopted within the judicial frame-

work for juveniles, stating that institutions are the last resort that

must be as far as possible. He also said that due focus should be put



on providing education to children in such institutions.

"Analysis revealed that in terms of the judgement passed on children in conflict with law, being dealt with a 'fine' emerged as the most prevalent followed by 'sent home after advice or admoni-

"We need to encourage group counselling and community services as relevant within the judicial framework and in our judgements. In all cases, children released on probation are likely to be placed back with the family. While the child is in the institution even if the short-term efforts must be undertaken to facilitate education, counselling, sports and life skills education," he stated.

Justice Bhat called for a "multi-stakeholder approach" to achieve the objectives set out under the Juvenile Justice Act and to realise the best interest of the child.

He also pressed for the identification of barriers to "equitable and timely justice for children" and to establish closer coordination among different stakeholders, improving the capabilities of stakeholders as well as implementing child-friendly procedures and adopting the "prevention approach".

"Due to their dependent status, children are most vulnerable when they come in contact with the justice system, either as children in conflict with the law or as a need of care and protection.

"A child who has come into conflict with the law is a child who has been in or continues to be in difficult circumstances. It is, therefore, imperative for us to prioritise a prevention approach," Justice

"In transiting from being stakeholder to shareholders in the care and protection of all children, especially the most vulnerable, prevention of child offending must receive the utmost attention," he added. In his address, Justice Bhat also shared his concern with respect to a young person living in a care institution seizing to be a "child" at the age of 18 and said information about the assistance

available to them must be widely disseminated. "The world is uncertain for them (after turning 18), especially from the point of view of a child who has been in a care institution, who has seen no parent or parents. When he or she comes out, he's

in the void," the judge said. "I'm told that some financial assistance is given. I think it is our duty to ensure that whatever resources are available information about these are disseminated to them in the widest possible manner," he stated. The judge also underscored the important role of an "empowered family and community" as a "safety net" for children

from abuse, neglect, exploitation, violence and harmful practices. "We must as individuals, citizens and duty bearers, leverage knowledge, technology and social resources to identify vulnerabilities and mitigate them in our joint endeavour to prevent children

from coming into conflict with law," Justice Bhat said. The Supreme Court has been conducting national stakeholder consultations annually, bringing partners from the Ministry of Women and Child Development and other relevant government sectors, the national and state commissions for the protection of children's rights and others. The aim is to bring momentum, attention, oversight and direction to priority areas related to the protection of children in the country, an official release has said. (PTI)

When our govt comes in 2024, first we will amend women's reservation bill: Cong chief Kharge

JAIPUR, Sept 23: Congress president Mallikarjun Kharge on Saturday said his party would amend the women's reservation bill if it comes to power at the Centre in 2024. There are no major legal complications in implementing the bill right now but the Narendra Modi government putting it off for 10 years, he said.

While supporting the bill in Parliament, the Congress demanded that it be implemented with immediate effect and a quota for women from Other Backward Classes (OBC) be included in it.

"When our government comes in 2024, the first thing we will do is make amendments to the bill," Kharge said, addressing a party rally in Jaipur in poll-bound Ra-

The Constitution (128th Amendment) Bill, which seeks to reserve a third of seats in the Lok Sabha and state assemblies for women, was passed by Parliament earlier this week. It was the first bill to be taken up and passed in the new Parliament building. In his address, Kharge alleged that the then president Ram Nath Kovind was not invited for the foundation laying of the new Parliament building because he is "untouchable".

"If the foundation laying was done by an untouchable, then naturally it would have to be washed with Gangajal (water from the Ganges)," he said, referring to the former president's caste.

Kharge said President Droupadi Murmu was not invited for the inauguration of the new Parliament building while many others, including actors, were invited.

"This is an insult to the president," he said.



"...Lok Sabha is summoned by the president and not by the prime minister. But there is no place for (the president) and then they say that they respect women a lot," he The Congress leader also questioned the Narendra Modi government's intention behind bringing the women's reservation bill, saying the BJP does not want to give reservation to women even though it does not say so.

Kharge said Sarojini Naidu was the first woman president of the Congress and asked, "In 100 years, has any woman become president of BJP or RSS?"

He said the BJP thought of the women's reservation bill just ahead of elections as several opposition parties have formed the INDIA bloc.

"When Rahul Gandhi, Sonia Gandhi and I together came up with the idea of INDIA, the women's bill came to their mind," he said. Kharge said the special session of Parliament was called for five days because Prime Minwhere there will be no discrimination and women will have equal rights as men.' Did (RSS leader M S) Golwalkar say this? Have the people of Jana Singh or BJP said so?" he asked.

"If there is any party that respects women, it is Congress. The first woman governor was Sarojini Naidu, Vijaya Lakshmi Pandit was in the United Nations, Meira Kumar was the Speaker of the Lok Sabha, the first woman prime minister was Indira Gandhi, the first woman president was Pratibha Patil," he said.

"What respect the BJP gives to its women leaders, you have seen that in Rajasthan and Madhya Pradesh," he said, without elaborating. He also took a swipe at the prime minister over the ethnic violence in Manipur.

Kharge also asked people to protect the Constitution and democracy and warned that if this is not done, then people will become

"If you don't want to become a slave, then vote for Congress. If you don't want to become a slave. then protect the Constitution and democracy," he said.

He said the Prime Minister and BJP leaders always ask what the Congress did in 70 years. "How many times will you ask the same thing, it's been 10 years. I have an account of what we did, it is a long list," he said.

Kharge also alleged Prime Minister Modi pitches four candidates against the Congress - one each of BJP, Enforcement Directorate (ED), Income Tax Department and the Central Bureau of Investigation

He should consider the law his own." Modi said there had been a practice of drafting laws in a complex manner. One of the aspects of justice delivery on which there is very little discussion is the language and the simplicity of law, the Prime Minister noted. He said the government is trying to make laws simple and understandable to the common man but the system has been born and brought up in the same framework and he was trying to pull it out of that. Modi said that he has a lot to do and a lot of time for it. "So I will keep doing it," he said. "We have made the first beginning in the Data Protection law," the Prime Minister said, referring to attempts to draft laws in simple language. He also welcomed the Supreme Court's decision to provide the operative part of a judgment to the litigant in his language. Dubbing the Indian Penal Code and the Evidence Act as colonial-era laws, the government had recently introduced the Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Bill to replace the IPC, Evidence Act and the Code of Criminal Procedure. The Hindi renaming had evoked criticism from various quarters, including parties from Tamil Nadu. Lauding the legal fraternity, he said the judiciary and the Bar have long been protectors of India's justice system and noted that they played a pivotal role in India's Independence. The likes of Mahatma Gandhi, B R Ambedkar, Jawaharlal Nehru and Sardar Vallabhbhai Patel were lawyers, the Prime Minister said.

The conference, he said, is happening at a time when India has witnessed several historic moments. Referring to the passage of the women's reservation bill in Parliament, he said this will give new direction and energy to women-led development. He also spoke of the G20 Summit and the successful Chandrayaan mission.

With India working hard to achieve the goal of becoming a developed country by 2047, it requires the base of a strong and impartial justice system, he said. Impartial justice has a big role in the growing faith of the world in India, Modi added. "We have been consulting throughout very closely with our Canadian colleagues - and not just consulting, coordinating with them - on this issue. From our perspective, it is critical that the Canadian investigation proceed, and it would be important that India work with the Canadians on this investigation. We want to see accountability, and it's important that the investigation run its course and lead to that result," Blinken said. India also said it has very "specific evidence" about criminal activities by individuals based on Canadian soil and it has been shared with the Canadian authorities on a regular basis but has not been acted upon. (PTI)

recognised national parties, parties having governments in states, those having their representatives in Parliament and other recognised state parties "for seeking suggestions or viewpoints on the issue of simultaneous elections in

In addition, the committee will also invite the Law Commission for its suggestions and viewpoints on the issue of simultaneous elections, according to a statement issued by the law ministry. The government notification had said the panel will make recommendations "at the earliest", but not specified a time-frame for the submission of the report. Prime Minister Narendra Modi has been pitching for "one nation, one election", asserting that it will save a lot of money and resources. In Parliament, the government has batted for holding simultaneous elections to the Lok Sabha and state assemblies, saying it would result in a huge saving to the public exchequer. It had also listed out the "imperatives", such as amending the Constitution and bringing all political parties on board, before carrying out the gigantic exercise. The committee will examine and recommend specific amendments to the Constitution, the Representation of the People Act and any other laws and rules that would require amendments for the purpose of holding simultaneous elections. It has also been tasked to suggest a framework for synchronisation of elections and "specifically suggest the phases and time-frame within which simultaneous elections may be held if they cannot be held in one go...." It will also examine and recommend if the amendments to the Constitution would require to be ratified by the states. Certain amendments to the Constitution require a ratification by at least 50 per cent of the state assemblies. The committee will also analyse and recommend possible solutions to scenarios such as a hung house, the adoption of a no-confidence motion or defection or any such event in case of simultaneous elections. The panel has also been asked to recommend "necessary safeguards for ensuring the continuity of the cycle of simultaneous elections and recommend necessary amendments to the Constitution so that the cycle of simultaneous elections is not disturbed". The issue of logistics is also on the agenda of the panel as the massive exercise would require an additional number of electronic voting machines (EVMs), paper-trail machines and polling and security personnel. It will also examine and recommend the modalities of the use of a single electoral roll and electoral identity cards for identification of voters in elections to the Lok Sabha, state legislative assemblies, municipalities and panchayats. A parliamentary committee had recently said a common electoral roll will help reduce expenses and prevent manpower being deployed for a work on which another agency is already working.

While the Election Commission (EC) is mandated to hold the parliamentary and Assembly polls, the state election commissions (SECs) hold the local body elections. The EC and the SECs are separate bodies under the Constitution with a fixed mandate. The original proposal was for simultaneous elections to all three tiers of democracy -- Lok Sabha (543 MPs), Vidhan Sabha (4,120 MLAs) and panchayats and municipalities (30 lakh members). The notification had pointed out that the elections to the Lok Sabha and legislative assemblies were mostly held simultaneously from 1951-52 to 1967, after which the cycle got broken and now, elections are held almost every year and within a year too at different times, which result in a massive expenditure by the government and the other stakeholders. It also leads to a diversion of security forces and other officers engaged in elections from their primary duties for significantly prolonged periods. Frequent polls, it said, disrupt developmental work on account of a prolonged application of the Model Code of Conduct. (PTI)

In fact, I was the only person to take oath in either of the houses on the last day of working in the old Parliament building. On Tuesday, the very next day, we moved to the new building," Sharma told PTI in an interview.

"I was congratulated by the house chairman (Vice President Jagdeep Dhankar) for the distinction of being the last parliamentarian in the old building," he said.

However, the BJP leader said what made the day more historic for him was the introduction of the bill for reserving one-third of the seats in Lok Sabha and state assemblies for

Sabha unanimously voted in its favour on Thursday. It will now require the approval of a majority of state assemblies.

The 128th Constitution amendment bill, referred to as the Nari Shakti Vandan Adhiniyam, will be implemented after a delimitation exercise to redraw parliamentary and assembly constituencies based on the census which the government has said will be commissioned next year.

Sharma claimed the new bill "did not come overnight or suddenly" but were extension of Modi's policies and initiatives since 2014 that were foempowerment and welfare of the poor.

He cited examples of initiatives like Jan Dhan bank accounts, Ujjwala Yojna for LPG supply, Saubhagya Scheme for power connections, subsidies given for building homes and toilets, law against triple talaq as game-changing policies.

"The women's reservation bill has been brought now. Whether LPG, or toilets, or giving homes registered in the name of family's women, or law against instant divorce. All such initiatives were largely focused on women," he said. "Ever since Modi became

Sabha this week, the Rajya ago, welfare of poor and women empowerment have remained the cornerstones of his initiatives and schemes. There is no caste or class distinction government policies.' Sharma said

Agnihotri. 'The Kerala Story", helmed by

"I want my community of filmmakers to treat such stories sensitively and not use it as propaganda," he added. Asked whether the objective of


filmmaking has changed over the years in Hindi cinema, the 58year-old writer-director said it is bound to as society is also changing.

Indian boxers aim to better medal count and grab Olympic berths

coveted Olympic berths will serve as extra motivation to the India boxers when they step in the ring in the Asian Games here from Sunday, eager to better the two medals secured in the previous edition.

India have fielded a strong contingent led by two-time world champion Nikhat Zareen and Olympic bronze medallist Lovlina Borgohain. In the men's section, the trio of world championship medallists -- the experienced Shiva Thapa, Deepak Bhoria and Nishant Dev -- will look to add an Asian Games medal to their kitty and secure their passage to Paris. The Asian Games are the first Olympic qualifying event for boxers from the continent. There are a total of 34 quotas up for grabs across the 13 weight classes.

In the women's events, the semifinalists in the 50kg, 54kg, 57kg, and 60kg while the finalists in the 66kg and 75kg will qualify for the Paris Games. The gold and silver medallists in each of the seven weight divisions in the men's event will receive quotas. The women's events have doubled

Pakistan awaits India visa for **World Cup travel**

INDORE, Sept 23: Players and team officials of Pakistan's World Cup-bound contingent are yet to get visas for their scheduled travel to India on September 27, two days before their opening warmup fixture.

The Pakistan squad was supposed to reach Hyderabad via Dubai where a two-day team bonding exercise was planned before travelling to India on September 27. The Babar Azam-led side is scheduled to play its first warmup game against New Zealand on September 29.

PCB sources told PTI that the team bonding trip to Dubai has been cancelled as players await their visas from the Indian High Commission in Islamabad.

You shouldn't feel low if you are not in playing XI: Shami

MOHALI, Sept 23: "When I was put too much workload in back-toplaying regularly, there must have back games, and its going well and been someone, who had to sit out and I wasn't guilty. So you can't feel low if you are sitting out because the team is winning," a pragmatic Mohammed Shami said when asked about the sporadic chances he has been getting in 50-over cricket of late. The Indian team management has indicated that when it plays full strength during the upcoming World Cup, Jasprit Bumrah and Mohammed Siraj will be the two frontline pacers. But after his match-winning figures of 5 for 51, Shami said that rotation isn't a bad thing when you play so many

"This is the team's plan and it is important to stick with it. You can't be always in the playing XI because a lot depends on the team combination," Shami said.

"If you are playing, well and good and if you are not in the playing XI, then you should be supportive of those, who are playing. I think there is no point feeling low and I am ready to play the role the team gives me," Shami said as he steered clear of anything that could be remotely controversial. He was also asked if he approves of this rotation policy where he has to sit out.

"What you are trying to know is beyond my comprehension but obviously when you build a team, (the) coach has a role to rotate players and, based on the situation, it is decided," Shami said with a wry smile. He made it clear that rotation before a big event like the World Cup is a good thing.

'You have seen we have (had) got results due to rotation and I believe before the World Cup, you shouldn't we are getting good results."

Shami had taken a break after the World Test Championship final and he didn't travel to the West Indies for the two Tests and three ODIs.

"It was important to take that break because I had played back-toback games continuously for 7-8 months. At the back of my head, I felt I needed a break for a series.

"I discussed with coach (Rahul Dravid) and captain (Rohit Sharma) and took a break (from the West Indies series). But my break never seemed like a break for me because I have an elaborate training set-up at home (Sahaspur in UP's Amroha) and I end up training more at home than when I am with the Indian team," he stated.

He was asked if he did anything special to dismiss Steve Smith, but his answer was in the negative.

"Just tried to do my basics right and hit the top of off-stump and wait for the batters to make a mistake."

The conditions were humid and Shami was used in small spells. Could it be a template going into the World Cup?

"It depends on the situation. How a partnership (is) going and how well you are bowling at that time. Sometimes, you end up bowling a six-over spell as well while sometimes you bowl only three overs."

He admitted that heat does a play role. "The heat does play a part and we are also human beings. It takes a toll on our bodies and on stamina. But when you have played international cricket for so long, it will not affect your fitness but it depends how much effort we are putting in," he concluded. (PTI)

From air travel for horses to renting boats, Indian athletes eye glory at Asian Games the dressage team. The individual The horses bound for Asian can sometimes be in another coun-

MUMBAI, Sept 23: From transporting the horses by air to renting canoes and kayaks or even carrying them as luggage, Indian athletes for equestrian, canoe and kayaks disciplines have made their way to the Asian Games hoping to bring laurels to the country.

While Fouaad Mirza ended the country's drought of medals in equestrian in the last Asian Games in Indonesia by winning the silver in individual jumping, India is waiting for its next medal in canoeing and kayaking since the 1994 Hiroshima Games. India has only one medal in canoeing from the pair of Siji Kumar Sadanandan and Johnny Rommel who won the bronze, six editions and 24 years ago in Japan.

Games in Hangzhou, China, for equestrian have undergone oneweek mandatory quarantine from September 12-19 in Aachen, Germany, from where they were taken to the venues. "The transportation of the horses for any event is done by air, which also includes elaborate quarantine procedures that need to be followed," said Shyam Mehta, president of the Amateur Riders' Club in Mumbai, which has hosted several events organised by the Equestrian Federation of India (EFI). "Keeping the horses fit and healthy is a huge task especially keeping in mind the quarantine guidelines and the travel time," Mehta said. "The quarantine zones

try, for example with the Asian Games which is in China, the quarantine centres are abroad — where vou travel first, stay in quarantine and then travel to China." he said.

"These quarantine centres are equipped with riding areas and paddocks to keep the horses fit and healthy throughout their time there, post which, they travel to the event location and practice to get acclimated with the conditions there before performing," Mehta added.

On the query of the other equipment required by the riders during events, Mehta said, "The equipment required depends on the discipline, whether it is dressage, showjumping or eventing." "Each discipline re-

quires different saddles, bridles and bits which are the main equipment. Furthermore, in dressage, they use accessories to dress up their horses and braid their hair. In the end it depends on the discipline when it comes to equipment," he added.

"For riders, the gear and equipment stays more or less the same. The only difference (here) being (that the) Eventers will wear body protectors in addition and Dressage riders will dress up to look good, Mehta explained.

Apurva Dabhade, Vikas Kumar and Ashish Limaye comprise the Indian equestrian team for eventing and Anush Agrawalla, Hriday Chheda, Divyakriti Singh and Sudipti Hajela are the members of

Nagra, Yash Nensee and Tejas Dhingra. India has won a total of 12 medals — three gold, three silver and six bronze medals - in equestrian, which has been a part of the Asian Games calendar since 1982 Delhi Games. Canoe was included in the Asian Games in 1990 and has been a part of the itinerary ever since. In a canoe, the paddler uses a single-bladed paddle whereas a double-bladed paddle is used in a kayak. Hangzhou Asian Games opens with futuristic ceremony



HANGZHOU, Sept 23: Blending elements of artificial intelligence and environmentally friendly technology, the Hangzhou Asian Games began here on Saturday with a one-of-a-kind opening ceremony, headlined by a spectacular futuristic light show.

The dazzling programme, held amid a diplomatic row over the denial of entry to three Indian athletes from Arunachal Pradesh, was a melange of technology, cultural history of China, and the spirit

of the continent's unity.

In keeping with the main theme of 'Tides Surging in Asia', the ceremony was about the intermingling of China, Asia and the world in the new era, as well as the unity, love and friendship of the Asian people.

The water element through the surging tide of Qiantang river -- which flows through Hangzhou -- was the underlying theme of the grand evening which lasted nearly two hours.

The ceremony sought to portray a distinctly Chinese and an uniquely Asian flair, capturing the country's cultural heritage and romantic imagery through the blending of its thousands of years old civilization and modern technology, through stunning visuals.

It portrayed the efforts of China's path to modernisation in a presentation that combined Eastern aesthetics and a viewpoint that connects with a global audi-

The technological might of China was written all over with the lighting of the cauldron -- the Games' Flame -- being done in a unique way.

Digital technology was utilised as torchbearers in the virtual and physical worlds jointly lighted the cauldron. Chinese President Xi Jinping declared

the Games open as more than 12,000 athletes from 45 countries gear up to fight for top honours till October 8. The Olympic Council of Asia's

(OCA) acting president Randhir Singh, International Olympic Committee (IOC) head Thomas Bach, heads of several countries, officials of National Olympic Committees and host of other dignitary were present on the occasion.

The Games are being held belatedly due to a surge in Covid cases in China

In keeping with the concept of 'Green Asian Games' or carbon-neutral Games, the opening ceremony used digital fireworks instead of real ones. It, nevertheless, created a thrilling atmosphere.

The nearly-packed 80,000 capacity

'Big Lotus' stadium was decked up ele-

gantly for the occasion and welcomed

the athletes from the participating coun-

tries, including India, with loud cheers. After three wushu players from Arunachal Pradesh were denied visa by the Chinese government, India had cancelled the visit of its sports minister Anurag Thakur. Indian Olympic Association President PT Usha was not present as she is currently in Paraguay as part of a Parliamentary delegation, though other

officials attended the ceremony. Loud cheers greeted the nearly 100 Indian athletes and officials as they marched into the stadium, led by flagbearers Harmanpreet Singh and Lovlina Borgohain. The Indian contingent walked out for the athletes' parade in eighth position.

From the tennis team, only Ramkumar Ramanathan participated in the parade since the other players have matches on

The male athletes were clad in bandhgala jacket and khaki kurta while their female counterparts donned high-necked blouse and khaki-textured saree made from recycled fabrics.

To begin with, the theme 'Water in Autumn Glow' depicted water as the heart and soul of Hangzhou, where water comes in many forms -- West Lake, Qiantang Tidal Bores, the thousand-yearold Beijing-Hangzhou Grand Canal, and the water conservation system of the Archeological Ruin of Liangzhu City.

In a bid to use culture as a medium of blending the power of technology and the beauty of art inspired by traditional Chinese culture, the opening ceremony combined the flavour of Hangzhou, Zhejiang province imagery and elements unique to the country.

Through innovative modern technologies, the ceremony also showcased the attractiveness, appeal and unique nature of Eastern aesthetics, as well as the profound impact culture has, the power of science, and the encompassing reach of

After around an hour-long protocol part of the ceremony, a cultural programme of 30 minutes enthralled the crowd. That was followed by the lighting of the Cauldron and playing of the official song.

By hosting the continent's biggest multi-sporting event, China has heralded its opening from the pandemic with a giant competition, the largest ever in its

No doubt, the Olympics is the pinnacle multi-sporting event in the world but more athletes compete in the Asian Games, with more than 12,000 taking part in Hangzhou.

About 11,000 participated in the Tokyo Olympics two years ago and about 10,500 will do so in the next year's

The 2018 Asian Games had seen a little over 11,000 athletes taking part,

which will be surpassed in Hangzhou. Besides Hangzhou, the 19th edition of the continental showpiece will be held in five other cities -- Huzhou, Ningbo, Shaoxing, Jinhua and Wenzhou.

Forty-five nations and territories in Asia will compete for 481 gold medals from 40 sports and 61 disciplines, including Esports which is making its debut in the Games. Competitions in football, volleyball, cricket, rowing, sailing and modern pentathlon began before Saturday's opening ceremony. (PTI)
