

## CM inaugurates Catamaran vessels, tug boats New vessels to revolutionize water transport in state

HT Bureau GUWAHATI, Sept 28: Chief Minister Himanta Biswa Sarma on Thursday inaugurated a fleet of 10 Catamaran vessels, three Tug Boats, and a search and rescue vessel at Lachit Ghat in the city with the aim to improve water transport in the state

The new fleet of 10 Catamaran vessels is set to bring in a transform the state' water transport system. These vessels are highly efficient and are a safe and sustainable mode of water transportation. Their low-impact design makes them environmentally friendly and economically viable, contributing to Assam's eco-conscious transportation infrastructure.

The vessels have been launched under a joint initiative of the Inland Water Commission and Assam Tourism Commission

Speaking on the occasion, Himanta Biswa Sarma said, "We have handed over the catamaran ships to the state tourism department. While one ship will be used for tourists in Guwahati, the others will be used for tourists at Silghat, Kaliabor to Biswanath Ghat via Kaziranga to witness the aesthetic beauty.'

"We have also taken up a new project to start a cruise service for Guwahati. It is a joint collaboration between ATDCL and Sagarmala," said Sarma.

The catamarans have a capacity of 100 passengers and six small four-wheelers each. The



ships will be used in Guwahati division, 3 in Jorhat division and 2 in Dhubri division at a cost of ₹ 38.43 crore. The remaining two ships will be used for tourists from Guwahati and the other for tourists from Shilghat in Kaliabar via Bishwanathghat to enjoy the beauty of Kaziranga. The three tug boats, constructed at a cost

of ₹ 15.75 crore, will be able to provide emergency response in case of any accident. In addition, search and rescue boats dedicated to the service of the public will patrol the inland waterways. The boat addition, constructed at a cost of ₹ 1.79 crore, is expected to boost public confidence in water (CONTD. ON PAGE-9)

#### **Gauhati High Court dismisses PIL against KAAC**

works. This decision comes after the submission of compelling evidence showcasing the successful completion of projects undertaken by KAAC. A departmental inquiry, accompanied by thorough verification, including photographic evidence, was conducted to assess the veracity of the works carried out by KAAC.

While hearing the case Justice Susmita Phukan Khaund opined that B. Baruah, the counsel representing the petitioners submitted that after going through the affidavits filed by the respondents and the photographs attached thereto, the petitioners are satisfied that most of the roads in question have been constructed.

Last night, the protesters clashed with security personnel in Uripok, Yaiskul, Sagolband and Tera areas, prompting the forces to fire several rounds of tear gas shells to control the situation, officials said.

The protesters blocked roads with burning tyres, boulders and iron pipes to prevent the security forces from entering residential areas, they said. A mob also vandalized the deputy commissioner (DC) office and torched two fourwheelers. (CONTD. ON PAGE-9)

#### **3 arrested for necrophilia**

KARIMGANJ, Sept 28: Three people, including a railway employee, were arrested on Thursday for allegedly strangling a teenage girl to death and then engaging in sexual acts with the body in Assam's Karimganj district. According to police sources, the minor's body was found beside the Karimganj town bypass on September 9, the same day she was murdered.

A post-mortem examination confirmed necrophilia and a case under the Protection of Children from Sexual Offences (POCSO) Act was registered, Karimganj superintendent of police, Partha Pratim Das said.

During the course of the investigation, police found a phone number in the girl's personal diary, through which the three accused were traced and nabbed from their homes in Karimganj town, the SP said.

"It was found that a newly recruited railway employee had a love affair with the girl and was pressurizing her to have a physical relationship with him, but she repeatedly rejected his sexual advances. "On September 9, on finding the girl alone at her home, her lover along with two of his friends, tried to rape her. When she resisted, (CONTD. ON PAGE-9)

### **DFO arrested for demanding** WHO South-East Asia Region calls for bribe in Dhubri

GUWAHATI, Sept 28: A team of the directorate of vigilance and anti-corruption on Thursday arrested divisional forest officer (DFO) of Dhubri division, Binod Kumar Payeng for demanding a bribe from a person.

According to sources, Payeng allegedly demanded ₹ 50,000 as a one-time bribe from the person to allow unhindered movement of vehicles from his Sand Mahal, within his jurisdiction.

Unwilling to pay the bribe, the person approached the directorate of vigilance and anti-corruption with his complaint. The Dhubri DFO had even directed the complainant to meet his subordinate officers to fix a monthly system of payment of bribe. Accordingly, he met the subordinate officers in the office of the DFO, who further demanded a bribe of ₹ 4 lakhs. However, later they reduced the amount ₹ 2 lakhs.

Based on the complaint, the anti-vigilance team laid a trap was on Thursday in the office of the DFO. Ziaul Islam and Sahabaz Sultan alias Bittu, both grade-1 forest officials were also caught red handed immediately after they accepted ₹ 15,000 and ₹ 5,000 respectively, as part of the demanded bribe, in conspiracy



with the DFO. The bribe money has also been recovered from their possession and seized in presence of independent witnesses.

The anti-vigilance team soon arrested them. In this connection, a case has been registered in the ACB Police Station under section 120 (B) of the Indian Penal Code and section 7(a) of Prevention of Corruption Act, 1988.

World Heart Day, World Heart Organization (WHO) South-East Asia Region urged its member states to join the global call to raise awareness about heart health and accelerate actions to prevent, detect and manage cardiovascular diseases.

The region is home to a quarter of the world's population, said WHO regional director for South-East Asia, Poonam Khetrapal Singh.

It is experiencing a very high burden of non-communicable diseases, she said and added that cardiovascular diseases are responsible for 3.9 million or 30 per cent of all deaths annually.

"Alarmingly, almost half (48 per cent) of these cardiovascular disease-related deaths occurred prematurely, affecting individuals aged 30-70 years and imposing significant socioeconomic burdens on families, communities and countries," Singh said.

The main causes to the burden of cardiovascular diseases include modifiable

NEW DELHI, Sept 28: On the eve of lifestyle factors such as tobacco use, alcohol consumption, unhealthy diets, especially high salt intake and lack of physical activity. Raised blood pressure and glucose levels are the key drivers and these can be detected, diagnosed and managed adequately in primary care, she added.

One in four adults in the region has raised blood pressure while one in 10 has diabetes. However, fewer than 15 per cent are on effective treatment coverage. Additionally, high lipid levels in the blood and the suboptimal management of acute cardiovascular events worsen cardiovascular disease mortality, the health expert pointed out.

In response to this public health importance, non-communicable diseases have been identified as a regional flagship priority since 2014. In 2022, the region adopted the 'Implementation Roadmap for Accelerating the Prevention and Control of NCDs in South-East Asia 2022-2030'. India's target of reaching 75 million people with hypertension and (CONTD. ON PAGE-9)

They have identified as Nur Uddin (43), a resident of Lahkarghat village in Nagaon district and Azhar Uddin (24), a resident of Bhokotgaon in Nagaon district.

#### Meghalaya bags award for AFSPA no solution to environmental commitment Manipur crisis: Irom Sharmila

KOLKATA, Sept 28: A day after the Armed Forces (Special Powers) Act (AFSPA) was extended in most parts of Manipur, rights activist Irom Sharmila said the "oppressive law" was not a solution to the conflict in the state. Sharmila, hailed as the 'Iron Lady of Ma-

nipur', told PTI in a telephonic interview on Thursday that the BJP-led government at the Centre should respect diversity instead of working for uniformity

through proposals like the Uniform Civil Code. AFSPA was extended by another six months in Manipur on Wednesday, barring 19 police station areas in the Imphal

valley and an area that shares its boundary with neighbouring Assam. "The extension of AFSPA is not a solution to the problems or ethnic violence in the state. The Centre and the Manipur government have to respect the diversity of the region," she said. "The values, principles, and practices of different ethnic groups must be respected. India is known for its diversity. However, the central government and the BJP are more interested in creating uniformity through proposals like the Uniform Civil Code," she added. Sharmila questioned why PM Narendra Modi couldn't visit Manipur since

the violence broke out in May.

"PM Modi is the leader of the country. If he had visited the state and spoken to the people, the problems would have been resolved by now. The solution to this violence lies in compassion, love and humane touch. However, it seems the BJP is not keen on resolving the issue and wants this problem to linger," she claimed. Criticizing Chief

Minister N Biren Singh, she alleged, "Wrong policies of the state government have pushed Manipur towards this unprecedented crisis." Stating the youths of the state have suffered the most in the (CONTD. ON PAGE-9)

## 8 fabric testing centres in state to ensure purity of Assam silk Weavers, customers in for unique Assam silk experience

JORHAT, Sept 28: Silk weavers, entrepreneurs and the public can now put their fears regarding pirated silk products to rest. The soon to come up fabric testing laboratories in the state will be effective in ensuing that only authentic Assam silk products reach the public. The Central Silk Board (CSB) under the Union ministry of textiles will set up eight fabric (finished product) testing centres in the state to ensure the purity of the silk and the fabric in a bid to tackle pirated silk products in the market. Director of Muga Eri Silkworm Seed Organization (MESSO), CSB Kartik Neog, while speaking at the inaugural ceremony of the Silk Mark Expo 2023 at Hotel Nikita on Thursday stated that of the eight



proposed laboratories four have been sanctioned. The Silk Mark Expo, 2023 that

began on Thursday will continue till October 2. It has been organized by the Silk Mark Organization of India (SMOI).

The expo in which 30 authorized users and government departments are participating, was inaugurated by the Assam Agricultural University (AAU) vice-chancellor, Bidyut Chandan Deka. Neog said that while two centres

were coming up in Guwahati, one will be set up at Bongshar near Sualkuchi in Kamrup district and another at Jorhat district. Neog said that altogether 20 such laboratories would be set up in the northeastern region with eight in Assam under a plan of the CSB.

"In addition to the proposed fabric testing laboratories, one raw material testing laboratory will also come up in the state. The establishing of such laboratories in the region was aimed at detection of pirated silk products in the market and preventing the customers from being duped along with maintaining the goodwill of silk yarns of Assam, which have a unique place in the market," said Neog. ## Govt working on policy to make national highways pothole free by year-end: Gadkari

NEW DELHI, Sept 28: The gov ernment is working on a policy to ensure that there are no potholes on national highways by year-end and construction of roads on Built-Operate-Transfer (BOT) mode is being preferred as such projects are maintained in a better manner, Union minister Nitin Gadkari said on Thursday.

With an aim to make the national highways free of potholes by the end of December this year, the Road Transport and Highways Ministry is firming up performance-based maintenance and shortterm maintenance contracts.

Generally, road construction is done through three modes -- BOT, Engineering, Procurement and Construction (EPC), and Hybrid Annuity Model (HAM).

"The roads which are constructed under the EPC mode require maintenance quite early whereas under the BOT mode,

roads are better constructed as the contractor knows that he will have to bear the cost of maintenance for the next 15-20 years.

"That is why we have decided for construction of roads under the BOT mode in a big way," the Road

Transport and Highways Minister said at a media briefing on various initiatives of his ministry. Noting that rains can cause dam-

age to highways resulting in potholes, Gadkari said the ministry is doing a safety audit of national

highways. A policy is being made to ensure the national highways are free of potholes and young engineers will be roped in to make the project a success, he said.

Road Transport and Highways Secretary Anurag Jain said the ministry has done the mapping of the entire national highways length of 1,46,000 kilometres and is firming up performance-based maintenance and short-term maintenance contracts to remove potholes by December this year.

In BOT projects, private investors take the risk of financing, building and operating highway projects over a concession period of 20-30 years. The developers then recover the investments through user charges or tolls.

In EPC projects, the government pays the developer for constructing the highway while the toll revenues accrue to the government.

## Sensex, Nifty plunge nearly 1 pc on weak global cues; RIL, Infosys weigh

MUMBAI, Sept 28: Equity benchmark indices Sensex and Nifty fell by nearly 1 per cent on Thursday due to unabated foreign capital outflows amid a largely negative trend in global markets. Besides, heavy selling pressure in index major Reliance Industries, Infosys and ITC also dented market sentiments, traders said.

The 30-share BSE Sensex fell 610.37 points or 0.92 per cent to settle at 65,508.32. During the day, it plunged 695.3 points or 1.05 per cent to 65,423.39. The Nifty declined 192.90 points or 0.98 per cent to end at 19,523.55. "The selling was broad-based, as investors are on alert given the rise of oil prices. If crude continues to stay above the USD 90 level, it will be a threat to inflation and boil the operational margins. Currently, the combination of higher interest rates and US bond yields are influencing FIIs to stay in the selling mode," said Vinod Nair, Head of Research at Geojit Financial Services.

Tech Mahindra was the biggest loser in the Sensex pack, slipping 4.59 per cent, followed by Asian Paints, Wipro, Kotak Mahindra Bank, Bajaj Finserv, Infosys, ITC, Mahindra & Mahindra, Hindustan Unilever, IndusInd Bank, Reliance Industries and JSW Steel.

In contrast, Larsen & Toubro, Bharti Airtel, Power Grid and Axis Bank were among the gainers.

In the broader market, the BSE midcap gauge declined 1.19 per cent and smallcap index fell 0.34 per cent. "The prevailing weakness in heavyweights across sectors combined with feeble global cues is weighing on the sentiment," Ajit Mishra, SVP - Technical Research, Religare Broking Ltd, said.

Among the indices, IT declined 1.84 per cent, FMCG fell 1.74 per cent, teck (1.49 per cent), consumer durables (1.29 per cent), auto (1.24 per cent), commodities (1.21 per cent), consumer discretionary (1.15 per cent), metal (1.05 per cent), realty (0.98 per cent) and services (0.89 per cent).

Telecommunication and capital goods were the gainers. "World stocks were on track for their longest losing streak in two years on Thursday as the sight of oil prices heading for USD 100 a barrel compounded



concerns about persistently high global interest rates while persistent fears of higher US interest rates and concerns over China's beleaguered property market also dented sentiments," said Deepak Jasani, Head of Retail Research, HDFC Securities.

In Asian markets, Shanghai ended in the green while Tokyo and Hong Kong settled lower. Trading was closed in South Korea for a holiday

European markets were trading in the negative territory. The US markets ended on a mixed note on Wednesday.

Global oil benchmark Brent crude dipped 0.38 per cent to USD 96.18 a barrel. Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 354.35 crore on Wednesday, according to exchange data.

"The selling was broad-based, as investors are on alert given the rise of oil prices. If crude continues to stay above the USD 90 level, it will be a threat to inflation and boil the operational margins. Currently, the combination of higher interest rates and US bond yields are influencing FIIs to stay in the selling mode," said Vinod Nair, Head of Research at Geojit Financial Services.

PATNA, Sept 28: With an aim to enhance the economic and financial sustainability of micro, small and medium enterprises (MSME), the Small Industries Development Bank of India (SIDBI) is in the process of launching an app-based 'invoice financing' loans platform 'GST Sahay', an official said.

This was announced by SIDBI, Chief General Manager (CGM), Rahul Priyadarshi at a customer outreach programme here on Wednesday

"The MSMEs are vital for the economic growth and development of India. They (MSMEs) create jobs and contribute enormously to the socio-economic development of the country. Although several measures for the MSMEs have been taken in the past few years by the government, the crunch in working capital credit is one of the major issues for them. Now, SIDBI is in the process of launching an app-based 'invoice financing' loans platform for them," he said.

'The new invoice platform-GST Sahay will reduce the problem of delayed payments and consequential cash flows mismatches for the MSMEs. The GST Sahay will be an invoice-financing marketplace where MSMEs can use their unpaid invoices to get quick working capital loans", said Priyadarshi.

While speaking about industrial growth in Bihar. the CGM said, "There is no doubt that the industrial growth is taking place in the state, but SIDBI wants to take this region at a greater height. There is a lot of scope for agro-processing, medical and agri tourism in the state. We are always focused on such businesses and SIDBI wants this region to prosper further".

SIDBI wants to enhance its loan assistance further in the state, he said, adding the loan book of SIDBI's Patna region has grown at 35 per cent (from March 2023 till the date)



"The jump of 35 per cent in lending (of the Patna region), which is at Rs 232 crore now, is quite satisfactory. We want to increase it further. Now the accelerator of growth is on in this region", he said.

Transparency and trust is the principle on which SIDBI does its businesses, he said. Anubha Prasad, Regional Head of SIDBI Patna, speaking at the event said, "SIDBI is dedicated to fostering strong relationships with its valued customers. ### Massive write-offs and low recovery ails the banking sector: Amit Mitra

KOLKATA, Sept 28: Principal chief advisor to West Bengal chief minister Amit Mitra said on Thursday that massive write-offs in the last nine years and low recovery is presently ailing the banking sector of the country. Speaking at a CII banking session here, Mitra said that in the last nine years from 2014-2023, ₹ 14.56 lakh crore has been written off from the books of the banks.

During 2021-22, the written-off amount was ₹ 1.75 lakh crore, and subsequently ₹ 2.09 lakh crore in the succeeding fiscal.

Mitra, also the former finance minister of the West Bengal government. said that union minister of state for finance Bhagwat Karad had informed Parliament that out of the total written-off amount of ₹ 14.56 lakh crore, ₹7.40 lakh crore are for large industry and services segments.

He said, however, the recovery had been low to the tune of ₹ 2.04 lakh crore out of ₹ 14.56 lakh crore, which means more than Rs 12 lakh crore is yet to be recovered.

According to him, the amount of write-offs in the preceding last nine years (2005-2014) was R₹ 2.20 lakh crore. "Even if this write-off amount of ₹ 2.20 lakh crore is indexed to inflation, the increase in subsequent write-offs is very large", he said. Regarding wilful defaulters, he said that the top 50 in this list owes ₹ 87,295 crore to scheduled banks as on March 31, 2023.

Describing wilful defaulters as those people not willing to pay despite having the capacity to pay, Mitra said it is needed to find out why these defaults and write-offs were happening.

"Are the bankers at fault or the present method of assessment? For whose fault is this happening", he asked.

Referring to West Bengal, he said that the total credit deployed in the state in 2022-23 was ₹ 4.68 lakh crore. Only for the MSME sector, the total credit deployed was ₹ 1.28 lakh crore during 2022-23. Mitra said 37 jobs are created for every ₹ one crore invested in the MSME sector.

The MSME sector has a massive impact on GDP growth through the multiplier effect. ₹ 1.28 lakh crore will translate into ₹ 4 lakh crore additional GDP for West Bengal. In the first five months of the current financial year, the MSME sector has received credit worth ₹ 87,029 crore," he added. (PTI)

### **SBI to encourage** corporates to implement emission reduction tech



KOLKATA, Sept 28: State Bank of India, the country's largest lender will encourage corporates to implement emission reduction technologies and get better terms for availing finance, an official of the bank said on Thursday.

Ashwini Kumar Tewari, the managing director (risk, compliance and stressed assets resolution group), SBI, said that the bank will see how it can help corporates in this regard but at the moment does not ask them of their plans for net zero.

At present SBI gives 25 basis points concession on interest rates for electric vehicles At a later stage, corporates with a better ESG (environment, social and corporate governance) score will get better terms for getting finance from it, he said. "We don't ask for net zero plan from the companies now. Ultimately, we will go to it. We will start conversation with the corporates and that process will start," he said at the sidelines of the banking conclave organised by CII here.

Food Safety and Standards Authority of India (FSSAI) is closely working with state food authorities to monitor and enforce regulations in this regard.

FSSAI Chief Executive Officer CEO) G Kamala Vardhana Rao has "strongly urged consumers and food vendors across the country to immediately stop using newspapers for packing, serving and storing food items.

He expressed concern over the use of newspapers for wrapping or packaging food and also pointed out significant health risks associated with this practice.

"The ink used in newspapers contains various bioactive materials with known negative health ef-

to use newspapers for food packaging

fects, which can contaminate food and lead to health issues when ingested," FSSAI cautioned on Wednesday.

Additionally, printing inks may contain chemicals, including lead and heavy metals, that can leach into the food, posing serious health risks over time, the regulator said. "Moreover, newspapers are often subjected to various environmental conditions during distribu-

tion, making them susceptible to contamination by bacteria, viruses or other pathogens that may transfer to the food, potentially causing foodborne illnesses," FSSAI said. FSSAI has notified the Food Safety and Standards (Packaging) Regulations, 2018 which strictly

prohibits the use of newspapers or similar materials for storing and wrapping food.

pers should neither be used to wrap, cover or serve food nor be used to absorb excess oil from fried food.

Emphasising the paramount importance of food safety, Rao urged all food vendors to adopt responsible packaging practices that prioritise the wellbeing of their customers.

He further highlighted that by discouraging the use of newspapers as food packaging materials and promoting safe alternatives, FSSAI reaffirms its commitment to ensuring the safety of the nation's food supply.

FSSAI urged consumers, food vendors and stakeholders across the nation to immediately discontinue the use of newspapers as food packaging material and recommended the adoption of safe and approved food packaging materials as well as food-grade containers, to ensure the safety and

#### **Bihar's complex** caste politics

Tnarguably, Bihar stands as India's most economically challenged state. The primary contributor to Bihar's quagmire of extreme L poverty and underdevelopment rests squarely on the upper castes of the state, who historically treated it as their fiefdom. The formation of Bihar in 1912 was a significant step towards establishing a distinct Bihari identity. Sadly, this new statehood was swiftly hijacked by the landed elite to further their narrow class interests. By 1930, the formation of Triveni Sangh, a political party uniting the intermediate castes of Yadavs, Koiris, and Kurmis, marked a pivotal moment in Bihar's caste politics. This coalition aimed to voice the political solidarity of "middle peasant castes" and secure a place for lower castes in democratic politics. Prominent leaders like Yadunandan Prasad Mehta, Shivpujan Singh, and Jagdev Singh Yadav championed the cause as the official mouthpiece of Triveni Sangh. However, Triveni Sangh's momentum waned as most of its leaders aligned with the Congress, which also had substantial upper-caste representation. The movement lacked a clear direction, despite gaining significant traction, and eventually dissipated. The 1960s witnessed the resurgence of backward caste politics, with Ram Manohar Lohia leading the charge. Yet, this was a fractured movement, more concerned with recognising sub-caste identities than unity. Bihar experienced a significant caste war during this division. Following the Mandal and Kamandal clashes, OBC politics resurfaced in Bihar. Ram Bilas Paswan and Lalu Yadav emerged as prominent figures in the Mandal movement. However, their efforts primarily focused on electoral gains, especially among Yadavs and Muslims, rather than broader emancipation or the state's development. Despite its location in the Gangetic trough, Bihar missed opportunities for industrial development. Paswan and Lalu did not address this issue, and efforts by some Congress leaders to establish educational institutions were marred by caste and class conflicts.

The OBC community, especially the lower sections of Yadavs, remained largely excluded from government schemes. Paswan and Lalu's rise served as inspiration but did not translate into tangible gains or empowerment, even for Dalits. Koiris and Kurmis managed to secure some government support due to their entrepreneurial spirit. It was during Nitish Kumar's rule that these three castes. Koiris, Kurmis, and Yadavs, formed a potential power bloc. Nitish emerged as an unassailable leader among backward castes and Mahadalits. He also led the mahadalits and extreme backward castes, albeit with internal feuds. Nitish's leadership extended to Jitan Ram Manjhi, Upendra Kushwaha, and Mukesh Sahani, but their differences led to their separation from Nitish's alliance. Amit Shah's efforts to bring them into the NDA fold to counter Nitish's influential caste coalition within the opposition alliance had limited success Modi's reluctance to expand reservations hindered the BJP's prospects, as Sahani's demand for upliftment of the fisherfolk community could open a Pandora's box. This alienated EBCs and Mahadalits from the BJP. In contrast, the Jharkhand government, led by the mahagathbandhan, increased reservation in state jobs, benefiting SC, ST, backward classes, OBC, and economically weaker sections. This move strengthened the government's position and heightened the aspirations of marginalized communities. The proposed job reservation policy further seeks to address these concerns, but it faces political hurdles.

Undoubtedly, India grapples with issues like wealth concentration, staggering wealth inequality, rampant unemployment, and systemic discrimination against lower castes, OBCs, and tribals. Bihar's complex caste politics and reservation dynamics remain central to addressing these challenges.

## **RSS to play key role in strategising BJP** policy for 2024 Lok Sabha polls

Not the Prime Minister Narendra Modi, instead the RSS chief Mogan Bhagwat would leadplay the key role from behind to lead the saffron brigade to the 2024 Lok Sabha electoral battle. This is a major departure from the old practice when RSS led by his predecessors used to provide electoral wherewithal to the BJP and deploy the cadres and pracharaks for the victory of its political outfits, Jan Sangh or

BJP. The socio political and economic situation under which Bhagwat operates is not the same under which his predecessors used to work. Not only the nature and content of the political discourse has undergone a major change, but the philosophical and political thrust and the face and functioning of the key players have also been completely transformed. With these changes the political-economic priorities of the electorates, the people of

India have also altered. While in the last century, veteran RSS ideologue Govindacharya had labelled Atal Behari Vajpayee as the Mukhauta (mask) of the RSS, in the same manner Modi is the Mukhauta of the present day RSS. The change of the shape and size of the mask underlines the basic structural and philosophical change of the RSS. In real sense while Modi is ruling the country, it is Bhagwat and his

unique spectacle on September 26 when on the 12th day of the strike by the United Auto Workers (UAW), the United States of America president Joe Biden visited the picketing workers in Michigan for extending support. In 2023, the labour unions in a number of US industries have carried out protest movements against the managements successfully by getting the US labour department support in most cases. The nearly five month old writers strike in Hollywood is ready for a settlement in favour of the strikers. The Hollywood actors strike is still continuing but hopes are there for an early settlement. # **C295 for India-Third time's the charm?**

o less storied than the hundreds of fighters produced by Indians handson Indian soil since the 1940s, are the humble transports. The Indian Air Force's Aircraft Manufacturing Depot (AMD) at Kanpur began producing the Avro 748 turboprop as a replacement for the WWII-era Dakota in 1961. In 1964, AMD was transferred to a newly reorganised PSU formed by the merger of Aeronautics India and Hindustan Aircraft, forming Hindustan Aeronautics Limited (HAL). HAL would continue production, eventually building nearly 90 of the type for the IAF as well as Indian Airlines.

By the 1980s, the Indian government was shopping around for a short-haul airliner to enable regional connectivity, and the IAF was looking to replace its Devons and Otters in the passenger/utility role. The Dornier 228 was selected for this combined requirement, and the programme expanded to include the Coast Guard and Navy. The first German-built Do 228 was delivered in 1984, and the first HAL-built example was handed over to government-owned Vayudoot in 1986

The contract, like the Avro before it, ensured that the Dornier

228 would be a near-completely indigenous aircraft. Crucially, however, unlike the Avro agreement, HAL had nearly unrestricted marketing and export rights for the Do 228. Unfortunately, no arm of the government ever took advantage of this flexibility, and even though HAL produced over 150 of the type in different variants, only a small handful were ever operated outside India.

Finally, in September 2021, the Indian government signed a contract with Airbus for 56 C295MW (MW for the wingletequipped military transport variant) transport aircraft, under the so-called 'Avro replacement programme'. The first of these formally entered service with the IAF on 25 September, and after Airbus delivers the next 15 from Spain, 40 more will be produced in partnership with Tata at a facility in Vadodara, Gujarat.

That it has taken over 60 years to begin replacing an aircraft design dating back to the 1950s is now entirely par for the course and does not merit further examination or excoriation. However, the C295 procurement offers other opportunities to learn from the Avro and Dornier programmes.

First, the Dornier programme did address one major shortcoming of the Avro, and this should

be repeated with the C295adapting it for more roles. While the Avro was essentially an airliner, some attempts were made to modify it for military transport, with an enlarged door to allow the loading of cargo, including vehicles, as well as paradropping troops and materiel. However, the design of the aircraft was inherently unsuitable for these tasks, and it is typically used for passenger transport and light cargo to this day.

A single aircraft was modified for airborne radar development, but a fatal crash in 1999 ended the project. The Dornier, on the other hand, benefited from starting life as a civilian aircraft that was always intended to be modified for military customers. India was an enthusiastic adopter of the maritime variant, with various specialised configurations being used extensively by the Indian Navy and Coast Guard. The C295 offers similar flexi-

This finally brings us to where the rubber meets the road (or runway, in this case). The biggest letdown of Indian aerospace in the past 70-odd years has been its inability to move bevond its captive customer. Defence PSUs produce almost exclusively for the Defence Ministry, which owns themnot just an unholy exercise in self-gratification, but also a selfdefeating enterprise that relies solely on stunted capital spending from a defence budget overburdened by revenue expenses.

Defence exports. though markedly improved in recent years, are still far short of the government's own targets. The Dornier case is instructive, where competitor aircraft have sold globally in the hundreds, if not thousands, while HAL-built Do 228s have struggled to find a market outside a tiny handful of exports to regional militaries.

The C295 already has the advantage of widespread acceptance around the world and the credibility of a global aerospace OEM, Airbus, behind it. A wider range of variants with the backing of the Indian Armed Forces will only enhance the platform's appeal. Strong domestic adoption of the aircraft will underpin its export potential, but the Ministry of External Affairs and its missions around the world will also need to take up marketing and promotion activities much more robustly than they ever have to date.

The multi-national nature of the programme will mean working with geopolitical partners to ensure the Indian assembly lines are humming at capacity for decades. If the C295 is to succeed, for the OEM, for the Indian production partner, and for India's aerospace ambitions, the government must throw more weight behind it, both at home and abroad. We see the same glee when Muslims are lynched or tied to trees and compelled to chant Jai Shree Ram (Hindutva slogan) on the faces of bystanders who take pictures of humiliation and violence on their phones. We saw the same excitement and clapping when a mob of men stripped two women and made them march naked in Manipur, while they openly molested them.

Something very ugly has been set off in our society. And this is a society that brandishes the platitude 'the world is one family' as its unique contribution to world history. Let us make no mistake, silence or laughter at nauseating comments and violent acts, is acquiescence. One day future generations will ask why our generation was silent when this was happening in our country, the way the young in today's Germany ask their grandparents how they could be part of the 'final solution' masterminded by Hitler. They ask these questions despite the rise of a rightwing neo-Nazi movement in the country.

The ability of New Delhi to get a declaration passed in a highly uncertain, multi-polar global power dynamics while getting China and Russia on board - strengthened India's case as a strategically important actor that can ally with the West and members in the East too.

Why the West is Vital for India

For the West, India is vital for its plan in Asia, to counter China and give access to investment/trade frontiers for a debt. recession-affected Europe, and so countries like the US and those in the EU were more accommodative to let India get a win on the deliverables it sought out to achieve as part of the summit.

Now, a toughened stance against Canada - and the disproportionate blowing up of the Khalistan issue domestically - may simply appear to be part of a domestic electoral strategy for Modi to score 'high' in an election year where the search for a 'foreign enemy' helps develop a cohesive national (security) narrative for the BJP. Remember how it was Pakistan that was vilified, post-Pulwama (sans evidence), in the run-up to the 2019 Lok Sabha election.

But Canada is not Pakistan. We are talking here about a G7 member country that is a close ally to the US and is part of the industrially advanced world which is also a significant destination for India's skilled (e)migration pattern, from young students to mid-career professionals which allows higher remittances into India, even though India's own export/import-trade exposure to Canada is less than 1 percent of its overall export share. The Khalistan issue too isn't that big a concern in defining the domestic politics of India or of/in Punjab's Sikh

for-tat aggressive posture against Canada which shouldn't endanger its relations with the West, and vice-versa.

#### **3 Important Lessons**

From the West's perspective, in context to the current bilateral tension between Canada and India, some things are becoming clear even if the truth remains shrouded in the fog of allegations and counter-allegations.

First, the US, the UK and Canada's other key allies are reluctant to burn bridges with India, which they see as a vital partner in balancing the rise of China.

Second, it would equally be naïve to expect that this time around, the US and its friends will pick India over Canada. The very architecture and credibility of the US-led alliance system hinges on members standing by each other on questions of national security, whatever may happen. Canada's Five Eyes partners aren't just passively sticking by Ottawa: they are actively sharing intelligence that helps Trudeau strengthen his case against India.

This brings us to the third and most important lesson from the past week. For all the public bonhomie that Western leaders demonstrate when meeting Indian counterparts or speaking of ties with New Delhi, they're only too happy to snoop on their friends.

Also, if India doesn't handle this moment more deftly through instruments of quiet, back-channel diplomacy with Canada and its security collaborators (the 'Five Eyes'), it risks of being increasingly viewed in the West as an 'undependable friend'.

New Delhi will then find it tougher to get the West's support on some of the other key issues, such as its balancing game with Russia and Ukraine, facing China and its security risk in its own neighbourhood in South Asia, finding partners for capital mobility and technology-transfers that are key to India's economic growth engine (where the US is a key partner), and finally, being able to stick to the implementation of its own promises driven by different multilateral and plurilateral platforms (including the G20).

## North Korean leader urges greater nuclear weapons production in response to a 'new Cold War'

SEOUL, Sept 28: North Korean leader Kim Jong Un called for an exponential increase in production of nuclear weapons and for his country to play a larger role in a coalition of nations confronting the United States in a "new Cold War," state media said on Thursday.

The Korean Central News Agency said Kim made the comments during a two-day session of the country's rubber-stamp parliament which amended the constitution to include his policy of expanding the country's nuclear weapons programme.

The Supreme People's Assembly's session on Tuesday and Wednesday came after Kim travelled to Russia's Far East this month to meet with Russian President Vladimir Putin and visit military and technology sites.

The trip sparked West-

ern concerns about a po sible arms alliance in which North Korea would supply Putin with badly needed munitions to fuel his war on Ukraine in exchange for economic aid and advanced Russian technologies to enhance North Korea's nuclear and missile systems.

As North Korea slowly ends its pandemic lockdown, Kim has been acboosting his tivelv partnerships with Moscow and Beijing as he attempts to break out of diplomatic North. isolation and join a united front against Washington. ## Trudeau apologises after Nazi unit war veteran honoured in Canadian Parliament

OTTAWA, Sept 28: Prime Minister Justin Trudeau has apologised for the Canadian Parliament's recognition of a man who fought for a Nazi unit during World War II, an incident that drew global condemnation and was termed by the Opposition as the "biggest single diplomatic embarrassment" in the country's history.

Trudeau, already under pressure for jeopardising Canada's relations with India over the killing of a Khalistani separatist in Canada, said the Canadian government has reached out to Ukrainian President Volodymyr Zelenskyy, who was present during the event last Friday, in the wake of the incident.

Russia has painted his enemies in Ukraine as "neo-Nazis" after the incident although Zelenskyy is Jewish and lost relatives in the Holocaust. Speaker Anthony Rota, who has assumed responsibility for inviting Yaroslav Hunka, 98, resigned on Tuesday. The incident has drawn global condemnation.

Hunka, who fought with a Nazi unit in World War Two, got a standing ovation and was praised as a Ukrainian and Canadian "hero". He served in the 14th Waffen-SS Grenadier Division, a voluntary unit made up mostly of ethnic Ukrainians under Nazi command. Division members are accused of killing Polish and Jewish civilians, although the unit has not been found guilty of any war crimes by a tribunal.

#### EAM Jaishankar to meet Blinken amid India-Canada diplomatic row

WASHINGTON, Sept 28: External Affairs Minister S Jaishankar is scheduled to meet US Secretary of State Antony Blinken here on Thursday, amid the diplomatic rumpus between India and Canada stirred over the killing of a Khalistani separatist.

Although officials from both sides are tightlipped about the agenda of the meeting, the latest diplomatic crisis between two of America's friends, its traditional ally Canada and India, is expected to come up prominently during the talks.

"I don't want to preview the conversations he (Blinken) will have in that meeting (with Jaishankar), but as we've made clear, we've raised this; we have engaged with our Indian counterparts on this and encouraged them to cooperate with the Canadian investigation, and we continue to encourage them to cooperate," State Department Spokesperson Matthew Miller told reporters. He was responding to questions about the meeting between Jaishankar and Blinken at the Foggy Bottom headquarters of the State Department here on Thursday afternoon (which is about mid-night local India time).

The two leaders are expected to pose for pictures ahead of the meeting and are not expected to take any questions from the media. While the meeting between the two ton diplomats was scheduled much before the Canadian crisis broke out, the US has been urging India to cooperate in the Canadian investigation into the killing of Sikh separatist Hardeep Singh Nijjar in British Columbia early this year. Canadian Prime Minister Justin Trudeau has alleged that the Indian government was behind the killing of Nijjar, 45, outside a gurdwara in Surrey in British Columbia on June 18. India had designated Nijjar as a terrorist in 2020. India has rejected the allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official. India has also asked Canada to crack down on terrorists and anti-India elements operating from its soil and suspended visa services for Canadians. Miller said that the issue did not come up for discussion in New York during the Quad ministerial that involved foreign ministers of the US, India, Japan and Australia. "It was a meeting of a number of countries and it did not come up in that meeting. But we have engaged with our Indian counterparts on this issue and urged them to fully cooperate with the Canadian investigation," the State Department spokesperson said. (PTI)

YEREVAN (ARMENIA), Sept **28:** The separatist government of Nagorno-Karabakh announced on Thursday that it will dissolve itself and the unrecognized republic will cease to exist by the end of the vear, and Armenian officials said more than half of the population has already fled.

That is after Azerbaijan carried out a lightning offensive to reclaim full control over its breakaway region and demanded that Armenian troops in Nagorno-Karabakh lay down their weapons and the separatist government dissolve itself.

A decree to that effect was signed by the region's separatist President Samvel Shakhramanyan. The document cited an agreement reached last week to end the fighting under which Azerbaijan will allow the "free, voluntary and unhindered movement" of Nagorno-Karabakh residents and disarm troops in Armenia in exchange.

Nagorno-Karabakh is a region of Azerbaijan that came under the control of ethnic Armenian forces, backed by the Armenian military, in separatist fighting that ended in

the region along with surrounding territory that Armenian forces had claimed during the earlier conflict. Following the latest offensive and a cease-fire agreement brokered by Russian peacekeepers. Azerbaijan and Nagorno-Karabakh separatist authorities have begun talks on "reintegrating" the region back into Azerbaijan. Azerbaijani authorities have pledged to respect the rights of ethnic Armenians in the region and restore supplies after a 10-month blockade. Many local residents, however, fear reprisals and have decided to leave for Armenia.By Thursday morning, more than half of Nagorno-Karabakh's population - over 65,000 people had fled to Armenia, according to Armenian officials. The massive exodus began on Sunday evening, and the only road linking Nagorno-Karabakh to Armenia quickly filled up with cars that created an hourslong traffic jam.

On Monday night, a fuel reservoir exploded at a gas station where people seeking to leave were lining up for gas that due to the blockade had been in short supply. At least

### US secures the release of the soldier who crossed into North Korea 2 months ago

WASHINGTON, Sept 28: The U.S. has secured the release of a U.S. soldier who sprinted across a heavily fortified border into North Korea more than two months ago, and he is on his way back to America, officials announced on Wednesday, U.S. ally Sweden and rival China helped with the transfer.

Left unanswered were questions of why North Korea — which has tense relations with Washington over the North's nuclear program, support for Russia's war in Ukraine and other issues — had agreed to turn him over and why the soldier had fled in the first place. North Korea had abruptly announced earlier Wednesday that it would expel Pvt. Travis King though some had expected the North to drag out his detention in hopes of squeezing concessions from Wash-

### Israel's High Court hears challenge to law that makes it harder to remove Netanyahu from office

JERUSALEM, Sept 28: Israel's Supreme Court on Thursday was hearing a challenge to a law that makes it harder to remove a sitting prime minister, which critics say is designed to protect Prime Minister Benjamin Netanyahu who has been working to reshape the justice system while he is on trial for alleged corruption.

The hearing is part of several pivotal court challenges against a proposed package of legislation and government steps meant to alter the country's justice system. It comes as Israel has been plunged into months of turmoil over the plan and deepens a rift between Netanyahu's government and the judiciary, which it wants to weaken despite unprecedented opposition. The hearing is the second by the High Court on the law but was being heard Thursday by an expanded 11-judge panel, underscoring the importance of the deliberations.

Netanyahu's governing coalition - Israel's most religious and nationalist ever - passed the "incapacitation law" in March which allows a prime minister to be deemed unfit to rule only for medical or mental reasons. It also gives only the prime minister or his government the power to determine a leader's unfitness. US allows Israeli citizens to travel to US visafree as Israel joins a select group of countries

The previous law was vague about both the cir-

cumstances surrounding a prime minister being deemed unfit as well as who had the authority to declare it, leaving open the possibility that the attorney general could take the step against Netanyahu over claims that he violated a conflict of interest agreement.

Critics say the law protects Netanyahu from being deemed unfit for office because of his ongoing corruption trial and claims of a conflict of interest over his involvement in the legal overhaul. They also say the law is tailor-made for Netanyahu and encourages corruption.

Based on those criticisms, Thursday's hearing is focusing on whether the law should come into effect after the next national elections and not immediately so that it isn't interpreted as a personalized law. A ruling is expected by January.

Dozens of protesters opposed to the overhaul gathered outside Netanyahu's private residence in Jerusalem ahead of the hearing, while Netanyahu's allies defended the law.

Simcha Rothman, a main driver of the overhaul, told Israeli Army Radio that the court's decision to hear the case over the fate of a sitting prime minister was harmful to Israeli democracy and challenging the law was akin to throwing out the results of a legitimate election. (AP)

**COPENHAGEN (DENMARK),** Sept 28: The Right Livelihood Award — known as the 'Alternative Nobel' - was awarded on Thursday to environment activists from Kenya and Cambodia, a human right de-

fender from Ghana and a humanitarian group that rescues migrants in the Mediterranean Sea. The 2023 laureates "stand up to

save lives, preserve nature and safeguard the dignity and livelihoods of communities around the world," the award foundation said, adding that they "fight for people's right to health, safety, a clean environment and democracy.

This year's prize went to Phyllis Omido from Kenya and the groups Mother Nature Cambodia and SOS Mediterranee. They will share a cash prize but for security reasons its size cannot be disclosed, the award foun-



dation said. The 2023 honorary award was given to Eunice Brookman-Amissah from Ghana.

"They care for their land and each human life connected to it: be it indigenous communities or people risking their lives to get to safety,' Ole von Uexkull, the head of the Stockholm-based Right Livelihood foundation, said in a statement

The Cambodian advocacy group was cited for its "fearless and engaging activism to preserve Cambodia's natural environment in the context of a highly restricted democratic space," while the non-profit charity that operates in international waters north of Libya was credited with carrying out "life-saving humanitarian search and rescue operations in the Mediterranean Sea.<sup>3</sup>

Kenyan grassroots environmental activist Omido received the award "for her groundbreaking struggle to secure land and environmental rights for local communities while advancing the field of environmental law," it said.

The foundation said Brookman-Amissah was honoured "for pioneering discussions on women's reproductive rights in Africa, paving the way for liberalized abortion laws and improved safe abortion access." This year there were 170 nominees from 68 countries, the foundation said. It said the laureates will be recognized at an award presentation in Stockholm on November 29.

Created in 1980, the annual Right Livelihood Award honours efforts that the prize founder, Swedish-German philanthropist Jakob von Uexkull, felt were being ignored by the Nobel Prizes. To date, 190 laureates from 74 countries have received the award. Ole von Uexkull is a nephew of the prize founder.

Previous winners include Ukrainian human rights defender Oleksandra Matviichuk, Congolese surgeon Denis Mukwege and Swedish climate activist Greta Thunberg. Matviichuk and Mukwege received the Nobel Peace Prize in 2022 and 2018, respectively. (AP)

## Militants seen moving around openly and instigating mobs in Imphal

### A serious concern for security forces

NEW DELHI/IMPHAL, Sept 28: The worst fears for security agencies seem to have come true as militants have been seen moving around openly and instigating mobs in Imphal valley which have been on a rampaging spree after pictures of two missing teenagers surfaced on social media.

According to officials, during attacks carried out on a police party Wednesday evening, armed men dressed in black uniform were seen giving directions to the agitated youths to attack the police and many vehicles were then torched.

The security agencies have been warned that militants belonging to United National Liberation Front (UNLF), People's Liberation Army (PLA) and other banned groups had become part of the mobs and carrying out sneak attacks on security forces as well as giving directions to the agitators.

Recently, the presence of insurgents was found within a mob that carried out an attack on security forces injuring a Lt Col of army near Pallel in Tengnoupal.

As reported by PTI on September 11, central security agencies had warned about the possibility of militants mingling with crowds during any protest to stoke tensions in restive Manipur.

The burning down of a police vehicle saw the presence of armed militants directing the crowd. Besides this, miscreants in the crowd used iron pieces which were fired towards security personnel with the help of automated slingshots.

#### **Manipur: Govt doctor** suspended for social media post

IMPHAL, Sept 28: A government doctor was suspended in Manipur for allegedly making an "inappropriate comment" on social media, a notification said. He was a medical officer posted at the Tamenglong district, it said. The doctor was suspended with immediate effect for "posting/ sharing inappropriate comment on social media which is conduct unbecoming of a government servant", it added.

He shall not leave the headquarters at Imphal without obtaining prior permission from the government, the notification issued on Wednesday said. The nature of the post was, however, not clarified in

Over a dozen police personnel including an officer of the rank of additional superintendent of police have been injured in these clashes that erupted in Imphal valley after surfacing of pictures of missing teenagers, who are suspected to have been killed during the ethnic clashes.

The officials reiterated that the current unrest has seen resurgence of near dormant banned groups like UNLF, PLA, Kanglei Yawol Kanba Lup (KYKL), Kangleipak Communist Party (KCP) and People's Revolutionary Party of Kangleipak (PREPAK) in the state.

They said at present, UNLF has (MTPC) at Pangei in East Imphal, Manipur Rifles, both located at Khabeisoi in Imphal city. According to them, out of the

stolen weapons, 2,900 fell in the lethal category whereas others comprised teargas and mini flare guns.

Repeated calls by politicians have yielded no results as none of the looted weapons have been deposited back except for those returned in the last week of July. There has been no forward

movement on disposal of dead bodies and opening of supply routes from Imphal to hill areas. More than 180 people have been

killed and several hundred injured since ethnic violence broke out in Manipur on May 3, when a 'Tribal Solidarity March' was organised in the hill districts to protest against the majority Meitei community's demand for Scheduled Tribe status. A fresh bout of violence, this time led by students, broke out in the state capital on Tuesday after photos of the bodies of two vouths who went missing in July went viral on social media.

Violent protests continued till the early hours of Thursday with a mob vandalising the deputy commissioner's office in Imphal West and torching two four-wheelers, officials said.

On Wednesday night, the protesters clashed with security personnel in Uripok, Yaiskul, Sagolband and Tera areas, prompting the forces to fire several rounds of tear gas shells to control the situation, they said. (PTI)

### **Manipur: Committee formed** to probe 'excessive use' of force on protesters by police

IMPHAL, Sept 28: The Manipur government on Thursday constituted a committee to verify complaints of alleged use of excessive force on protesters, mainly students, by security forces here over the last two days, an official order said.

The order issued by the DGP said, "There have been various reports/allegations of use of excess force by the security forces to maintain law and order over the last few days in Imphal area."

The committee will be headed by IGP (Administration) K Jayanta, the order said, adding that it will "submit the report at the earliest."

Violent protests rocked Manipur's capital for two days on Tuesday and Wednesday as thousands of students protested the kidnapping and killing of two youths, pictures of whose bodies had gone viral. On Tuesday night, a clash occurred between RAF personnel and locals over the murder of the duo, prompting the law enforcers to lob tear gas shells and fire rubber bullets at the agitators and baton-charge them, leaving 45 of the protesters, mostly students, injured.

On Wednesday, around 20 protesters were injured in similar clashes with security forces.

Meanwhile, the Coordinating Committee on Manipur Integrity (COCOMI) has condemned the "brutal act of RAF and security forces" against student protesters on Wednesday and termed it as a "violation of human rights." (PTI)





Plea to govt to locate remains of their kids

IMPHAL, Sept 28: Parents of both the murdered youths, viral pictures of whose bodies caused widespread protests in Imphal valley for two days, on Thursday pleaded with authorities to locate the remains of their children so that the last rites of the boy and the girl can be conducted "with the dignity they deserve.

They hoped that with sleuths from the CBI joining the investigation into the kidnapping and death of the duo who went missing in July this year, the mystery of where their bodies lie will be solved.

The 18-year-old girl's father, Hijam Kulajit, in an interview to PTI said, "We just want to see our children one last time and conduct their last rites with the dignity they deserve. Nothing can substitute the loss. According to Meitei custom, at least a small portion of the clothes they wore is needed to perform the last rites and give them a farewell.

"Whenever I see her photo, it makes me completely restless and I can't find peace in my heart. Her mother has lost her senses and become bed-ridden while embracing a photo of our

## Amit Shah, Nadda hold discussions with BJP's **Rajasthan leadership on upcoming assembly polls**

'Discussions on election strategy were held in the meeting last night'

JAIPUR, Sept 28: Union home minister Amit Shah and BJP president J P Nadda wound up their Rajasthan visit Thursday morning after meetings with the party's state leadership that went late into the night, discussing strategy for the upcoming assembly elections. The meetings began at a hotel late on Wednesday evening and continued till 2 am, party sources said.

Shah and Nadda arrived in Jaipur on a special plane on Wednesday evening and headed to the hotel near the airport for the core committee meeting. Party sources said that Shah and Nadda first held a meeting with former

with senior leaders in which the party's election strategy was discussed. Feedback on the four 'Parivartan Yatras' that the BJP held recently was also discussed.



The latest all-India PLFS data, including rural areas, is much worse - in 2021-22, just 21 per cent of workers have formal jobs, which is still lower than the pre-pandemic period of 23 per cent. Instead, self-employment and casual employment have risen. "These numbers show that the un-

Ramesh said in such a scenario a situation has arisen when in January this year, 8,000 candidates applied for 92 clerk positions at Gujarat University, including those with M.Sc and M.Tech degrees. In June 2023, 10.5 lakh people applied for 4,600 clerk posts in Maharashtra, including MBAs, engineers and PhD holders, Ramesh cited data from the Emhe said.

With economic distress reducing jobs in the private sector, highly educated youths are being forced to compete for a minuscule number of government posts, he noted.

To make matters worse, even the massive 10.5 per cent from 2019-20 public sector has been shrinking under the Modi government, he According to a report from Azim claimed. As of August 2022, he said, 9.8 lakh Union government posts Premji University, the Congress leader said, 42 per cent of graduates were vacant; CMIE data shows that

government jobs declined 20 per cent between 2015-16 and 2022-23; India now has one of the lowest numbers of public employees per 1000 population, lower than the US, Brazil, and even China.

"Rather than dealing with the em-ployment crisis, the Modi government is busy hiding and distorting data and focusing on gimmicks. With the EPFO data, rather than rely on the stable annual estimates, they are touting unreliable monthly data, intentionally ignoring the fact that the monthly data is revised continuously by over 50 per cent at times and has major discrepancies," Ramesh said. "To further cover up its failures in

providing government employment. the prime minister personally holds Rozgar Melas making a complete mockery of routine government workings. Despite massive gaps in the public sector, of close to 10 lakh vacancies, the Modi government makes a big show of 50,000 job letters for posts that were already sanctioned, and claims that it is generating employment

"Further, RTI data from The Telegraph shows that while all job letters at Rozgar Melas are being presented as 'new recruits', a sizeable number are actually just promotions," he alleged. Most disheartening of all is a statistic from the National Sample Survey Office (NSSO) April 2023 report, he said.

A full 33 per cent of India's youth neither has a job nor is taking educational or training courses, and this number rises to over 50 per cent for women, he said, alleging that "the Modi government has crushed the hopes and dreams of India's youth to the point that they do not have jobs and have given up on the future and to the point that they refuse to invest in education or training".

"The tragic consequence of this is that the youth suicide rate (age below 30) has been growing sharply since 2016 and has reached 4.9 per lakh population in 2021, the highest in 25 years.

"Instead of dealing with the crisis of demographic dividend turning into a demographic disaster, we should not be surprised if the Modi government's next move is to manipulate the National Crime Records Bureau (NCRB) data due for 2022 to hide the alarming suicide rate amongst the youth," Ramesh

CHANDIGARH, Sept 28: Congress MLA Sukhpal Singh Khaira was arrested by the Punjab Police in connection with a 2015 drugs case on Thursday morning, official sources said.

A team led by Superintendent of Police Manjeet Singh raided the Chandigarh residence of Khaira around 6 am. The MLA's son went live on Facebook showing that a team of Punjab Police has reached their residence to apprehend Khaira. In the video, Khaira could be seen arguing with the police team and asking them to show him the arrest warrant.

The Bholath legislator could also be seen asking for the identity cards of the police officers who were part of the raiding team.

He was told by the police official that he was being arrested in the Narcotic Drugs and Psychotropic Substances (NDPS) Act case. When Khaira asked the team where he was being taken, a police official told him that he was being taken to Jalalabad in Fazilka. According to official sources, a special investigation team (SIT) led by Deputy Inspector General of Police Swapan Sharma was formed in April 2023 and Khaira was arrested based on its investigation into the 2015 case.

Slamming the Bhagwant Mann government, the Congress MLA, who has been critical of the AAP government on various issues, claimed that he was being apprehended in a "false" case and that "jungle raj" was prevailing in the state. Meanwhile, the Punjab Congress hit out at the AAP government, accusing it of indulging in political vendetta. The Congress state unit chief Amrinder Singh Raja Warring and Leader of Opposition Partap Singh Bajwa strongly condemned the arrest of Khaira.

The ruling Aam Aadmi Party, however, rejected the allegation and asserted that the action against the Bholath MLA was taken as per law. Warring visited the residence of Khaira after his arrest and met his son Mehtab Khaira and other family members. He said they stand by the Bholath MLA.

The drugs case was registered in March 2015 at Jalalabad in Fazilka. Nine people, including Gurdev Singh who was allegedly a close aide of Khaira, were booked in the case and later convicted under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

Police had recovered two kg of heroin, 24 gold biscuits, one country-made pistol, a .315-bore pistol and two Pakistani SIM cards from them. Khaira's name cropped up later during the police probe. (*PTI*)

Sunil Bharti Mittal will be the vice president (co-chair) and Shravin Bharti Mittal, who spearheaded the OneWeb investment, taking it out of Chapter 11, will be Bharti's lead as a director on the Board of Eutelsat.

Director on the Board of OneWeb, now a 100 per cent subsidiary of Eutelsat, it said. OneWeb will be a subsidiary operating commercially as Eutelsat OneWeb with its centre of operations remaining in London. ## **Iconic agricultural scientist M S Swaminathan passes away**

CHENNAI, Sept 28: M S Swaminathan, renowned agricultural scientist and the driving force behind the nation's 'Green Revolution, passed away here on Thursday.

He was 98 and is survived by three daughters including Dr Soumya Swaminathan, the former chief scientist of the World Health Organisation

The celebrated agriculture icon, who was being treated for age-related illness for quite some time passed away today at 11.15 AM at his residence here.

Condolences poured in with Prime Minister Narendra Modi hailing Swaminathan saying his groundbreaking work transformed lives of millions, ensured India's food security

Indian Agricultural Research Institute Director A K Singh said an era of agricultural research, education and extension marked by disruptive innovations has come to an end with the death of Swaminathan

Tamil Nadu Governor R N Ravi, chief minister M K Stalin, leaders of farmers' bodies including P R Pandian condoled Swaminathan's death. The Congress party described him as the key scientific architect of the Green Revolution and hailed his contribution to the agriculture sector.

Modi said on X: "Deeply saddened by the demise of Dr MS Swaminathan Ji. At a very critical period in our nation's history, his



groundbreaking work in agriculture transformed the lives of millions and ensured food security for our nation.

has left an indelible mark on countless scientists and innovators. "I will always cherish my con-

Former Prime Minister H D Deve Gowda expressed grief over the demise of Swaminathan and said he was greatly benefited from

his advice on many occasions. Swaminathan who founded the MS Swaminathan Research Foundation here has been described by the United Nations Environment Programme as "the Father of Eco-

ruptive innovation. If God appears to poor and hungry in form of bread as said by Mahatma Gandhi, that God is Dr. Swaminathan who should be worshipped by every cit-

He has received 84 honorary doctorate degrees from universities around the world. He is a Fellow of many of the leading scientific academies including the Royal Society of London and the U S National Academy of Sciences.

'Dummy schools' adversely affecting **Delhi students: HC** 

NEW DELHI, Sept 28: Unchecked growth of 'dummy schools' is adversely affecting students who genuinely fulfil the 'local education' criterion and allows ineligible candidates to secure seats under the Delhi state quota, the Delhi High Court has said. The high court issued notice and sought the response of the Delhi government, Central Board of Secondary Education. Directorate General of Health Services, Delhi University (DU) and Guru Gobind Singh Indraprastha University (GGSIPU) on a petition against proliferation of dummy schools. It listed the matter for further hearing on November 29. The high court was hearing a public interest litigation (PIL) challenging the eligibility criterion applied by both DU and GGSIPU for allotting MBBS or Bachelor of Dental Surgery (BDS) seats under the DSQ. The PIL filed by Rajeev plaimed the ide 'dummy schools' is to provide a "virtual platform to students to show that they have migrated to Delhi after passing class 10th exam with the sole purpose of somehow availing the benefit of Delhi state quota seats, which otherwise ought to be allocated amongst the bonafide residents of NCT of Delhi". Delhi govt standing counsel Santosh Kumar Tripathi submitted there was no concept of 'dummy schools' in Delhi. As per the criterion, only candidates who have completed their class 11 and 12 education from a recognised school located in Delhi are considered for grant of seats under the DSQ, the plea said. More than 180 people have been killed and several hundred injured since ethnic violence broke out in Manipur on May 3, when a 'Tribal Solidarity March' was organised in the hill districts to protest against the majority Meitei community's demand for Scheduled Tribe status. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal valley, while tribals, including Nagas and Kukis, constitute 40 per cent and reside mostly in the hill districts. Countries need to demonstrate impact through utilizing digital solutions for better coverage and control rates, she further said. "These actions are critical not only for public health but also for achieving Sustainable Development Goal (SDG) targets related to non-communicable diseases and universal health coverage. With only seven vears left until the 2030 SDG target deadline, on this World Heart Day, it's a call for all of us to take action and empower ourselves to address cardiovascular disease risk factors and improve disease outcomes, she said. ## Nanomaterials, vegan leather among technological innovations on display at CSIR exhibition

NEW DELHI, Sept 28: An air purifier that can be retrofitted to ACs, vegan leather, nanomaterials with wide-ranging applications and automated drones that do not need operators were displayed at a CSIR exhibition held here to showcase its achievements in the past decade.

The exhibition was held as part of the Council of Scientific and Industrial Research's (CSIR) Foundation Day celebrations at Pragati Maidan on September 26 and 27.

It featured works of scientists from various CSIR institutes, including the Institute Of Genomics And Integrative Biology (IGIB), National Aerospace Laboratories (NAL), National Physical Laboratory (NPL), Structural Engineering Research Centre, and the Central Drug Research Institute (CDRI).

Mansi Gupta, the founder of Calm The Chaos, an ayurveda-based cosmetics company, said that such exhibitions help lend visibility to the product as well as the institutes providing technical and research support to start-ups.

'Through similar exhibitions, CSIR has helped me showcase my product across India, including in Bengaluru, Mumbai, Goa and Ahmedabad," she said, adding that the Indian Institute Of Integrative Medicine (IIIM), Jammu, a CSIR institute, is providing research support to her start-up. "I have tied up with the government to test my ayurvedic products because testing in private labs is very expensive," she told PTI. IIIM is also helping her find seed funding. Ravi Kaushik, the founder and CEO of Airth, a start-up producing air purifiers that can be retrofitted to ACs, is regularly engaged with CSIR labs -- the Indian Institute of Toxicology Research, Central Drug Research Insti-



tute and the National Physical Laboratory -- to test his initial product, a standalone air purifier unit. Kaushik eventually pivoted to air purifiers that can be retrofitted to air conditioners.

"The relations built with them during re-

search and development helped them understand that I am working in the domain of providing solutions for air pollution," he told PTI. Kaushik's start-up Airth is currently incubated with the Indian Institute of Toxicology Research which is helping him with product testing for a nominal charge.

N Usha Kiran was pursuing PhD in material sciences at another CSIR lab -- the Institute of Minerals and Materials Technology (IMMT) when he founded and registered his company ReseaprolabsPvt. Ltd in 2022. The start-up creates advanced nanomaterials composed of titanium, silicon and carbon which are termed mxene and maxphases. He has invented the flash sintering technique, drastically cutting down the time required to generate these materials.

These materials, having applications in energy and biomedical sectors and competing with graphene in terms of its electrical conduc-

tivity, can profoundly enhance the performance of Lithium-ion batteries, Usha Kiran said.

His start-up venture was recently incubated with the Innovative Technology Enabling Centre (InTEC), an incubation centre run by IMMT.

"India is full of inventions, inventors and innovations. However, there is a big gap in translating our research into practical outcomes," said T. Pavan Kumar, a senior scientist at IMMT, who is also involved in running InTEC. "Usha Kiran's initiative is the 14th start-up

venture, which incubated with us just 10 days back. He gets infrastructural, technical and intellectual support from us at a nominal charge. We also helped him file a patent by fast-tracking the paperwork processing," Kumar said.

He said the incubation centre is also involved in sensitising the community, including other agencies and institutes, about intellectual property rights and their awareness. "This way, we also enhance our visibility and try to attract start-ups who wish to incubate with us."

At the National Physical Laboratory (NAL), another CSIR lab, its wind tunnels are being used by private aerospace firms such as AgniKul Cosmos Private Limited.

"They need testing to validate their (aircraft) design. We do the testing and they bear the expenses charged as per CSIR guidelines," said Venu Ganapuram, the principal scientist at NAL, where ISRO's Chandrayaan-3 underwent 3,000 wind tunnel tests. Even as CSIR labs and incubation centres seek to ease the burden of start-ups by providing testing and mentoring support, funding for testing and then for making the product market-ready is, however, still hard to come by, start-up founders said.(PTI)

"India is a democratic country. For how long should we carry forward this colonial law? In the name of fighting insurgency, crores of rupees are wasted, which could have been utilized for the overall development of the Northeast. The internet is suspended for months, and basic rights are taken away. Can you impose AFSPA if there is a law and order problem in Mumbai or Delhi?" she questioned. Sharmila had started her hunger strike against AFSPA after ten civilians were allegedly killed by security forces at a bus stop in Malom near Imphal in 2000. She waged her peaceful resistance for 16 years before ending it in 2016. The 51-year-old rights activist got married in 2017, and the mother of twin girls is now settled in Bengaluru. (PTI)


## **Dunki' is all funny and emotional: Shah Rukh Khan**

"'Animal' is a cinematic wildfire that's sure to take you on a wild ride




through a realm where thrill and passion collide," the makers said in a press release. In a previous interview with PTI, Ranbir Kapoor had called Animal a "new territory" for him.

According to the lyricist, most of the songs are set to high tempo music where the human mind gets only a fraction of seconds to register the word. 

## I find adapting a book easier, says filmmaker Sriram Raghavan

MUMBAI, Sept 28: Filmmaker Sriram Raghavan believes bringing alive a book on the big screen is a far easier process than coming up with an original story which takes time. In his career, the acclaimed director has tackled two book adaptations -- 2007's "Johnny Gaddaar", which was based on French novel "Les mystifiés", and "Badlapur", adapted from Italian novel "Death's Dark Abyss".

At the Jio MAMI Mumbai Film Festival's panel discussion, titled 'Adaptations - the Stories We Choose to Tell', Raghavan said he reads a lot of books which helps him during the writing process.

"When I try to write my own stories they take time, sometimes they get stuck at some point and you are not able to move ahead. So, I find adapting a book a far easier thing because the basic material, the kernel or the premise is strong enough

that it attracts me. Then the rest is my work, at least I know I'm not inventing things. So, I read as much as I can," the filmmaker told reporters here.

Raghavan revealed that his next feature film, "Merry Christmas" starring Katrina Kaif and Vijay Sethupathi, is based on a novel. The director, however, didn't name the book.

"This is (based on) a novel. I recan't reveal the name, but it is there in the film's credit. We have taken the rights. What I liked about it is there in it (film)," he said about the movie which will come out in theatres on December 15.

The 60-year-old director believes reit is important to ensure that the the core substance of the story is not holost when turning a book into a semovie. "The film also has to work with people who have read the metatory so you try and see what you I

can do without disturbing the essence of the book. Me and a couple of friends check what is being published, some are old books. So, I do a lot of research trying to find stories," he added.

Raghavan further said that he was keen to adapt Vikas Swarup's novel "Q&A" and Hussain Zaidi's "Mafia Queens of Mumbai" for the big screen. Both the books were made into feature films – Danny Boyle's Oscar-winning film "Slumdog Millionaire" and Sanjay Leela Bhansali's period drama "Gangubai Kathiawadi", starring Alia Bhatt.

"I wanted to do 'Mafia Queens' but it was done. Then Vikas Swaroop's book, 'Q&A', when I read the book I loved, and went to meet him, and he said, 'The rights are sold'. So, it is not that I don't like Indian stories, it's just that I have not found an Indian book to adapt. I'm sure it will happen." Film producer Siddharth Roy Kapur said there is a dedicated team at his production banner Roy Kapur Films that identifies books which have the potential to be turned into films or shows.

"What our team does is we have a whole lot of books coming, so you have someone to identify whether something should be adapted (to screen) or not. A book can be daunting because it can be longer read so a lot of things fall through the cracks, a lot of very interesting material falls through the cracks."Zaidi, one of the most prolific crime writers, is best known for his books such as "Black Friday", "Dongri to Dubai: Six Decades of the Mumbai Mafia", "My Name is Abu Salem" and "Byculla to Bangkok", among others. Many of his books have been turned into movies and shows. (PTI)

## Aiming for rich haul of medals, Chopra-led India set to begin athletics campaign

HANGZHOU, Sept 28: Olympic champion javelin thrower Neeraj Chopra will be the cynosure of all eyes as India begins its athletics campaign in the Asian Games here on Friday, targeting to surpass last edition's 20 medals.

Chopra will lead a 65-strong team, with the Athletics Federation of India (AFI) hoping to win at least 25 medals. Three athletes from the original 68, the largest in the Indian contingent, were left out due to injuries. As usual, athletics is likely to account for the the lion's share of India's total medal count. In the 2018 Asian Games, athletics had contributed 20 medals (8 gold, 9 silver, 3 bronze) out of India's

total of 70. "The target is minimum 25 medals. Anything more is a bonus," an AFI official said. It may, however, be difficult to match the eight gold the

country had won in the 2018 Asian Games. Chopra, shot putter Tajinderpal Singh Toor, 3000m steeplechaser Avinash Sable, the men's and women's 4x400m relay teams are strong gold medal contenders. Toor and the men's 4x400m relay team are Asian

record holders. The 25-year-old Chopra, who recently became world champion in addition to his Olympic gold, is the best bet for a gold in jury prone in the last few years. athletics. He is defending his The burly Punjab athlete rewrote his own Asian record by gold he won in 2018.

Pakistan's World Championships silver medallist Arshad Nadeem, who claimed a bronze in the 2018 Asian Games, will

be his main rival here. With a personal best throw of 84.77m while finishing a creditable fifth in his maiden World Championships last month, 28year-old Kishore Jena is also a medal contender in men's javelin. He has the third-best throw among Asians this season. The 28-year-old Toor is the favourite to defend the gold medal he won in 2018. He is the lone Indian Asian record holder in individual events. Toor's only concern is that he has been in-

hurling the iron ball to a distance of 21.77m while winning gold in the National Inter-State Championships in June.

Sable can be considered a sure-shot medal contender. The 2022 Commonwealth Games silver medallist holds the national record of 8 minutes 11.20 seconds. His season's best time is 8:11.63, placing him in second position among Asians behind Miura Ryuji (Season's Best: 8:09.91) of Japan.

In men's long jump, Murali Sreeshankar will be aiming to redeem himself after his disappointing show at the World Championships. His personal and season's best of 8.41m puts him in the fourth spot in the world and second among

Jeswin Aldrin.

Chinese Taipei's Asian champion Lin Yu-Tang (SB: 8.40m) and China's Wang Jianan (8.34m) will be his main rivals, besides Aldrin.

Aldrin was the world season leader before the World Championships with his national record jump of 8.41m early in the season. But he was inconsistent throughout the season with fitness issues also dogging him, due to which he pulled out of the Asian Championships. He is still the season leader among Asians and third in the world. With the Asian record time of 2 minutes 59.05 seconds in the qualification round of the World Championships in

Asians behind compatriot August, India is a gold medal contender in the men's 4x400m relay. The Indian quartet's time is also the eighth best in the world this season. The country finished second behind Sri Lanka in the Asian Championships in July with a time of 3:01.80. Gold winner in the 2018 Asian Games, India is again title contender in mixed 4x400m relay after winning the event in the Asian Championships in July with a time of 3

"I will retire all at once, but I will stop playing each format one by one. I will announce my retirement after the 2025 Champions Trophy.'

Shakib will be leading Bangladesh during the World Cup, having also captained the side during the Asia Cup earlier this month in Pakistan and Sri Lanka. It was his second stint as the

unit's leader. Under him, the Tigers did make it to the Super 4 of the Asia Cup, but failed to make it to

the final. In the meantime, Shakib has confirmed that his outing in the upcoming World Cup will be his last as the skipper and will be quitting captaincy as a whole.

"Given the current reality, I am captain only till the World Cup. Not a day more."

## **CHINA SURPASSED 150 MEDALS ON DAY 5 OF THE TWO-WEEK EVENT HOST CHINA CONTINUE** Bronze in individual **ASIAN GAMES DOMINANCE**

HANGZHOU, Sept 28: China blew past the 150-medal mark Thursday on Day 5 of the Asian Games, more than double the number of second-place South Korea as the home nation continued its decades-long domination of the event.

The hosts were bolstered by multiple golds in a home sport on Thursday, as Chinese athletes won the men's 70-, 60- and 56-kilogram finals in Wushu martial arts, as well as the women's 60- and 52kilogram finals.

He Feng, who took gold in the 70-kilogram final by beating former Asian Games gold medalist Mohsen Mohammadseifi of Iran, was trailing in the first round and credited his coaches for helping him adjust.

"It is mainly the result of the tactics and training by the coach, then the most important thing is mentality, which determines success or failure," he said. "I always tell myself not to give up, persistence is victory." Host nations traditionally get a homefield "medal bump," and He said the crowd also helped keep him going.

"Seeing so many people cheering for me, I think I can't give up, no matter how tired I am," He said. China won almost 300 medals -132 gold - five years ago at

the Asian Games in Indonesia, Olympics.

Astride Etro, Agarwalla scored 73.030 to finish third and claimed his second medal of the Asian Games. India has won 13 medals in the Asian Games equestrian event since 1951, including the dressage team gold here on Tuesday. But, the country had never won an individual medal in dressage in the past. Bin Mahamad Fathil Mohd Qabil Ambak of Malaysia won the gold with a total score of 75.780, while Jacqueline Wing Ying Siu of Hong Kong bagged the silver scoring 73.450.

The other Indian in fray, Hriday Vipul Chheda, who topped the qualifying on Wednesday, was eliminated after blood was spotted on the left foreleg of his horse Chemxpro Emerald and did not feature in the medal competition.

There was a small scratch on the left foreleg of Vipul's horse and so little bit of fresh blood could be seen. So under the rules,

he was eliminated. It was very u fortunate, we were also hopeful of him (a medal)," team manager and doctor Mohd Adil Yakub told PTI. On Tuesday, Agarwalla had teamed up with Chheda, Divyakriti Singh and Sudipti Hajela to win the dressage team gold after 41 years. "I knew that it would be good. I had a good partnership with my horse. In the morning when I woke up, I texted my mother that it will be good and we will get something today. My horse was amazing," Agarwalla said after winning the historic bronze. "It has been a long journey, a very difficult one. A lot of time, I thought maybe I am not good enough. But holding this medal today, it's all worth it. I am very happy how it all went."

He said he spent some nervous moments when he finished his competition and the last rider just after him was on the field.
