**GUWAHATI**, **Sept 12:** Opposition parties staged a walkout from the Assam Assembly on Tuesday, demanding the constitution of a House committee to inquire into the allegations of illegal sale of food items meant for the public distribution system.

Almost immediately afterwards, Speaker Biswajit Daimary adjourned proceedings for 15 minutes as treasury members took to their feet, demanding an apology from Congress MLA Kamalakhya Dey Purkayastha for raising a slogan denouncing the Assam govern-

Meanwhile, Chief Minister Himanta Biswa Sarma on Tuesday asserted that no scam has taken place in government recruitment in his tenure, and that he is prepared to order a probe if anyone can cite a single instance of such irregularity.

Replying to a motion moved in the state assembly by the AIUDF, Sarma said about 87,000 jobs have been provided in the last two years, and if the opposition can point to a single undeserving candidate, he will initiate an inquiry.

"Earlier, scams used to be about people buying jobs with cash. This time, it is about people paying money, but not getting the jobs," he said, referring to instances where aspirants had reportedly paid bribes, but failed to get jobs.

# Fresh violence claims three lives in Manipur

**IMPHAL, Sept 12:** At least three people were gunned down by unidentified men in Manipur's Kangpokpi district on Tuesday morning, an official said.

He said the ambush took place between Ireng and Karam Vaiphei villages in Kanggui area.

"The incident took place in the morning when unidentified men gunned down three civilians in an area between Ireng and Karam Vaiphei," the official said.

Committee on Tribal Unity (COTU), a Kangpokpi-based civil society organization, condemned the attack

"If the Union government is serious about its appeal for restoration of normalcy, it must immediately declare all the valley districts as disturbed areas and impose Armed Forces (Special Powers) Act, 1958," COTU said in a statement

The incident comes close on the heels of the violence that broke out at Pallel in Tengnoupal district in which four persons were killed and over 50 injured on September 8.

More than 160 people have been killed and several hundred injured since ethnic violence broke out in Manipur on May 3, when a 'Tribal Solidarity March' was organized in the hill districts to protest against the majority Meitei community's demand for Scheduled Tribe status. # World can emulate India's law on plant protection: President

NEW DELHI, Sept 12: President Droupadi Murmu on Tuesday said India's law on the protection of plant varieties and farmers' rights can be emulated for the entire world, as it gains importance amid the challenges of climate change.

Addressing the first-ever global symposium on farmers' rights at the Pusa complex in the national capital, the President said India took the lead in bringing the Protection of Plant Varieties and Farmers Rights Act (PPVFR) way back in 2001, which is aligned to the International Treaty on Plant Genetic Resources for Food and Agriculture to protect farmers.

The four-day symposium from September 12-15, being held for the first time since the adoption of the International Treaty on Plant Genetic Resources for Food and Agriculture in 2001, is expected to



have a participation of around 500 delegates including farmers from India and abroad.

Under the PPVFR Act, India provides a range of rights to farmers that include use, reuse, save, share and sell the unbranded seeds of a registered variety. Besides,

farmers can register their own varieties which get protection, she

The President said, "Such an Act can serve as an excellent model worthy of emulation for the entire

This also gains importance amid

challenges posed by climate change and also to fulfill the Sustainable Development Goals of the United Nations, she added. Stating that the challenges of cli-

mate change have put an onus on the conservation of traditional farmers' varieties, Murmu said the varieties including millets are not only endowed with inherent tolerance to various stresses on the ecosystem but also hold nutritional profiles that could be key in providing a solution to the food and health requirements of a large pop-

The declaration of the year 2023 as the Year of Millets by the United Nations is a step in this direction, she said.

NEW DELHI, Sept 12: Road Transport and Highways Minister Nitin Gadkari on Tuesday spoke of the need to levy an additional 10 per cent tax on diesel-run vehicles to help cut emissions, but later clarified that there was no proposal under government consideration to impose such

Speaking at the annual convention of automobile manufacturers body SIAM, Gadkari said rising pollution level is a serious health concern and there is a case for increasing taxes to dissuade sale of diesel vehicles.

"I am requesting the finance minister to impose an additional 10 per cent GST on diesel engines/vehicles. This is the only way to phase out diesel vehicles," he said, indicating a meeting was scheduled with the finance minister for handing over a letter he had drafted on the issue.

But soon after, he took to X, formerly known as Twitter, to clarify the govern-

"It is essential to clarify that there is no such proposal currently under active con-

sideration by the government," he said in a post on X, referring to media reports quoting him as suggesting an additional 10 per cent GST on diesel vehicles.

He emphasised that there was a need to embrace cleaner fuels to cut emissions.

"In line with our commitments to achieve Carbon Net Zero by 2070 and to reduce air pollution levels caused by hazardous fuels like diesel, as well as the rapid growth in automobile sales, it is imperative to actively embrace cleaner and greener alternative fuels. These fuels should be import substitutes, cost-effective, indigenous, and pollution-free," he said on X.

At the Society of Indian Automobile Manufacturers (SIAM) convention, he had warned that the government would increase taxes so much that it would become difficult to sell diesel vehicles. Most of the commercial vehicles in the

country currently run on diesel. In the passenger vehicle segment, various carmakers including Maruti Suzuki India and Honda have already stopped

manufacturing diesel cars. Gadkari said the contribution of diesel cars has already come down drastically in the country and the manufacturers need to stop selling them in the market.

The minister also highlighted that India

is utilising a major portion of fossil fuels in the transport sector which is posing a big economic as well as pollution chal-

He suggested alternatives such as biofuels, ethanol and green hydrogen in addition to electric vehicles.

At the SIAM annual convention, the minister said the country is making good roads across the country, which is leading to the growth of the automobile industry.

"The auto industry is growing at 15-18 per cent and it is also leading to enhanced usage of fossil fuels. If this goes on like this, you (companies) will be happy, but pollution will make the people of this country sad. So quickly leave petrol, diesel. Please focus on alternatives, this is my request to you," Gadkari said.

He further said, "I will request the finance minister for 10 per cent pollution tax as additional GST on all such engines utilising diesel, from generator sets to vehicle engines."

Seeking cooperation from the auto industry, Gadkari said, "I think you will not

force me to push this proposal... this is the appropriate time, it is not rocket science, this is already everywhere in the world... so I will request you all to take suo moto initiative and cooperate with us in moving away from diesel/petrol, this is my humble request."

Terming diesel as a hazardous fuel, he noted that the country has to import the fuel to meet the demand.

"Say goodbye to diesel... Please stop making them, otherwise, we will just increase the tax so much that it would become difficult to sell diesel cars" Gadkari said. He said he would propose additional GST on diesel-powered generators as

NEW DELHI, Sept 12: India and the US have agreed to set up a joint monitoring mechanism to enable domestic exports of at least 3.36 lakh tonnes of certain steel and aluminium products in a year to America without paying extra du-

ties, an official said on Tuesday. Indian exports of these products were attracting additional duties in the US as Washington, in 2018, imposed a 25 per cent import duty on steel products and 10 per cent on certain aluminium products on grounds of national security.

In retaliation, India in June 2019 imposed additional customs duties on 28 American products.

The US is allowing these imports from India without paying the extra 25 per cent and 10 per cent duties in return for New Delhi's decision to remove retaliatory duties on eight American products like apple and walnut.

Additional Secretary of the commerce ministry Peeyush Kumar said that officials will meet twice a year to review the arrangements.

"We will have a biennial meeting...We have requested steel and mines ministries to designate an officer from their side who will be talking to stakeholders and exporters that applications are being properly processed," Kumar told reporters here.

If Indian exporters would face any bottleneck or problem, it would be conveyed to the commerce ministry and will be taken up with the US during the meetanism (JMM), he added.

Kumar said that only the additional duty has been removed and the basic duty of 50 per cent will continue besides the minimum import on apples.

Import of apples from the US decreased sharply from USD 145 million (127,908 tonnes) in 2018-19 to only USD 5.27 million (4,486 tonnes) in 2022-23.

"At the same time, the automobile in-



# Nagaland Assembly passes resolution for exemption from UCC

KOHIMA, Sept 12: The Nagaland Assembly on Tuesday unanimously adopted a resolution strongly urging that the state be completely exempted from the purview of the proposed Uniform Civil Code

The 14th house of Nagaland legislative Assembly unanimously resolves for exemption from the proposed enactment of UCC in its application to the state of Nagaland, chief minister Neiphiu Rio said moving the government resolution on the second day of the monsoon session of the

"The Nagaland government and Naga people are of the view that the UCC will pose a threat to customary laws, social practices and the religious practices of the Naga people, which will be in danger of encroachment in the event of imposition of UCC," he said.

The apparent objective of the UCC is to have a single law on personal matters like marriage and divorce, custody and guardianship, adoption and maintenance, succession and inheritance, he said.

The Nagaland government through a cabinet decision submitted its views on the subject to the Commission on July 4 conveying its opposition on the grounds of the "unique history" of Nagaland since the pre-Independent British era, the assurance of non-interference policy starting since pre-Independence times and continued by the Centre in the social and religious practices and customary laws of the people and the constitutional guarantees given under Article 371A, Rio said.

He also recalled that in the consultative meeting with various stakeholders on the subject of UCC organised by the state government on September 1, the representatives of the various tribal organisations and civil societies have expressed their strong resentment and objection to the idea of having UCC.

The Government of India (GoI) ap-



pointed the 22nd Law Commission of India on February 21, 2020 and extended its term up to August 31, 2024. It issued a public notice on June 14, 2023 inviting views and ideas from all stakeholders on the subject matter of having a UCC throughout India, he said.

Article 371A of the Constitution mainly states that no act of Parliament will apply to the state of Nagaland in a matter relating to religious or social practices of Nagas, Naga customary law and procedure administration of civil or criminal justice involving decisions according to Naga customary law and ownership and transfer of land and its resources will apply to the state unless its Assembly decides so by a resolution, he said.

The legislators on Monday deliberated on the consequences of implementing UCC in the state and the Nagaland Speaker Sharingain Longkumer had granted leave to the government to bring a resolution on Tuesday.

Longkumer put the resolution to vote and it was adopted unanimously by voice vote without any amendment.

Earlier on Monday, Nuklutoshi, partic-

ipating in the discussion regarding the Uniform Civil Code (UCC), expressed concerns about its potential impact. He contended that the UCC could be seen as a violation of the 16-Point Agreement that led to the creation of the state. Additionally, he asserted that the UCC might infringe upon Article 371(A). Nuklutoshi emphasized the importance of the role of people's representatives in advocating for the interests and concerns of the public. He stressed that as representatives, they should vigorously defend the voices and

rights of the people they serve.

Achumbemo Kikon said that the UCC governs matters including marriage and divorce, succession and inheritance, adoption including other personal laws, though it is not enforceable in the court of laws. Therefore, UCC should not come to our land for whosoever reasons, he stated. Dr. Neisato Mero, said the idea of uniform civil code is one nation one vote. It is also a threat to our social, religion, customary laws, and direct indulgence to our personal laws besides contradicting Article 371 (A), he added. Jwenga Seb, said UCC would have negative implications on our personal laws and traditions though its protection is clearly incorporated in the constitution of India. Therefore, UCC be exempted for the state of Nagaland by passing a resolution in the NLA.

Advisor, Labour, Employment Skill Development and Excise, Moatoshi Longkumer, who participated in the debate, said that the state government should oppose the introduction of UCC as it not only overshadows the tenet of regulation but it also threatens the pluralistic society. As such, he suggested that a resolution be passed to oppose the introduction of UCC by the NLA. Advisor, KT Sukhalu and MLA. Er. n hindsight, the New Delhi summit of G20 countries Lunder India's presidency, from September 8 to 10, could be seen as a one-size-fit-all type of clothing, which wrapped around deep differences of rival geopolitical blocs, primarily led by the United States on the one hand, and China-Russia on the other. India is increasingly situating itself as a bridge country that's a conciliatory link nation between choppy waters of international relations, and it has indeed managed to give the otherwise moribund G20 grouping a decent facelift under its presidency.

Under the leadership of Prime Minister Narendra Modi, with his penchant for extravagant event management, the rotational G20 presidency had been turned into a vehicle for the ruling party's nonstop propaganda, an excuse to project him as the "Vishwaguru". The G20 logo carrying the lotus symbol, synonymous with his party, the BJP, as well as Narendra Modi's face on massive hoardings and billboards dotting every street in Delhi and other Indian cities were already preparing the average Indian for a blitzkrieg of G20 advertising. Eventually, central Delhi was barricaded and forced into a quasi-lockdown, its homeless evicted, slums demolished, strays locked up and the poor forced behind absurd green screens, to sanitise the area for its

Nevertheless, the G20 summit became notable for both the presences as well as conspicuous absences. US president Joe Biden, clearly the most anticipated guest, flew in and rubbed shoulders with Modi and other world leaders in several choreographed and photographed events, such as the one at Rajghat paying homage to Mahatma Gandhi. # Paryushan Parv: A spiritual Srimanta Sankaradeva: Reviving Vedic devotion through Vivartanavāda

rimanta Sankaradeva, a towering figure in the history of religious philosophers, established a profound legacy through his philosophy, Eka Sharana Nâma Dharma. His teachings laid the foundation for a new religious philosophy that emphasized the elevation of the individual soul (Jîva) from a state of duality to a non-dual identity with Brahma, the supreme truth. This philosophy is characterized by several key inciples that distinguish it from other philosophical paths. Unity of Brahma and Ishwara:

One of the central tenets of Srimanta Sankaradeva's philosophy is the unity of Brahma (the supreme reality) and Ishwara

His philosophy maintained that the creation, though temporary, is real, and its purpose is to facilitate the divine play of God. Devotion and overcoming Mâyâ:

Srimanta Sankaradeva emphasized the role of devotion in overcoming Mâyâ (illusion). He advocated devotion to God

as a means to transcend the influences of Mâyâ. By holding Lord Hari's name in the heart and chanting it consistently, one could rise above the illusions of the material world.

**Holistic approach to life:** 

Srimanta Sankaradeva's philosophy embraced an integral view of life, accommodating beliefs at various stages of spiritual evolution. He recognized the journey of the individual soul from gross to subtle, from duality to non-duality. His philosophy provided room for all levels of devotees to find resonance and progress.

Vedic influence on Srimanta Sankaradeva's philosophy: Srimanta Sankaradeva's philosophy drew extensively from the Vedas. He glorified the Vedas and emphasized following

their path. His philosophy resonated with the Purusha-sukta of Rigveda, which extols the omnipresence of the supreme Purusha (Brahma) in all entities. This echoes Srimanta Sankaradeva's view of the unity of Brahma and Ishwara.

of Âgama-based practices overshadowed Vedic teachings. 

# The stories of women who migrate alongside their husbands to work as 'helpers'

n southern Rajasthan, male migration has traditionally been a com-Lmon phenomenon among the Adivasi community due to destruction of natural habitats and limited work opportunities. Environmental degradation coupled with financial constraints have pushed many men to look for work elsewhere. However, a new trend has emerged. Newly married women from Udaipur's Gogunda Block migrate with their husbands to Gujarat and Maharashtra and work in the kitchens of hotels and hostels

We previously had a limited understanding of women's migration, focussing mainly on the trend of families from Banswara district moving to Gujarat and Madhya Pradesh, primarily for construction work. Our prior knowledge of the working conditions for women and adolescent girls portrayed a grim picture, marked by physical exhaustion, persistent malnutrition (even during pregnancy), and the constant specter of sexual harassment.

However, our conversations with women from various villages in Gogunda revealed a complex nature of migration, shaped by intricate societal structures. Some of these women we spoke with were visiting to help families for the Kharif crop season, or have returned to their homes permanently, because they dared to speak up for themselves.

No entitlement, lack of options

These women shared their diverse experiences and varied impacts of migration on their lives and families. Tara, a mother of three young daughters, Ganga, Monika and Geeta, works in a hotel in Rajkot with her husband. For the last four years, she has been cooking in the hotel's kitchen. She has left behind two of her daughters with her relatives in Gogunda.

'They only allow one child to stay with us and since Geeta is the youngest,

she travels with us. We have enrolled the other two in a school there [in Gogunda], but they are not consistent because nobody keeps an eye on them," says Tara. Her expression showed how she has been left with an agonising choice - leaving behind her two children, and the wage she seeks to earn to take care of them.

However, Tara's main concern lies with her husband's drinking habits. When they are at the workplace, everything seems fine. Tara feels content and her husband remains sober, as alcohol is strictly prohibited within the campus. However, as soon as they return to their home in Gogunda, her husband starts drinking again. This leads to frequent arguments and even physical abuse, leaving Tara deeply troubled.

"I live like you there," she pointed out to our attires. "I just apply sindoor and nothing else is compulsory. I can wear a suit, or even a saree," she says, as if shedding the heavy burden of wearing a traditional lehenga choli offers her respite. Tara isn't the only woman who doesn't want to come back to her village after working in a big city like Rajkot or Ahmedabad. Women workers are torn between the worlds they inhabit; they stand between the societal expectations of leaving work for family and the different life cities offer.

The gap between these two worlds is quite evident. Sonu, 23, a mother of two, came back to her husband's village Dadiya, during the COVID-19 pandemic and never went back.

She first went to Ahmedabad when she was 10 years old, with her uncle who worked at the airport. "It was not my first time living away from home. I went with my uncle and lived there for two years. I wanted to see the aeroplanes and thought I could study anytime but this is my only chance to go out and see them taking off," her eyes sparkle as she recalls those days.

Even after getting married at the age of 12, she found the courage to speak up about her previous experiences. "I



am not afraid ma'am. During one of our jobs, my husband and I were made to stay along with other men because there were not a lot of women working in those spaces back then. I raised my concern and asked my husband, who is quite understanding, to get work somewhere else," she says.

"We just had one task to do there - I used to clean the kitchen and in turn, I was getting good food and the privilege of working in a place with a functional fan," she adds. Sonu came back to Rajasthan when her sons grew up and needed to enroll in school.

She came back to Rajasthan when her sons grew up and needed to enroll in school. Her migration, which once gave her an opportunity, now seems like a distant memory. There are Gujarati-medium schools mostly, and the Hindi-medium ones are expensive. Because of the inaccessible education system, she is compelled to stay behind. As private ownership grows and public education declines in the state, inequalities between disadvantaged and privileged groups have become more apparent. The lack of access due to language barriers keeps the cycle of marginalisation going.

An identity crisis Another concern emerged during our conversations - that despite their vital contributions, women failed to recognise themselves as workers.

Women working alongside their husbands raises intriguing questions about the evolving migration patterns. To truly understand this shift and the motivation behind women's inclusion, it is imperative to delve into the complicated ways in which both men and women perceive women's roles in this process. When asked about her decision to accompany her husband to Ahmedabad, Ganeshi Bai's response was rooted in the belief that she was needed

"Everyone said he is already working, and you will work in the kitchen only at home. So, why not help your husband with his work," she says. Her response also shaped her perception of her role as a wife and a worker.

Many women find themselves cast into the role of a 'helper'. However, this seemingly innocuous term conceals a significant imbalance. It also reveals a subtle yet significant form of labour exploitation since it diminishes the magnitude of their work, demoting them to a position devoid of the rights that a recognised worker would command. This linguistic choice effectively deprives these women of the entitlements that should rightfully accompany their labour.

In Obra, a quite remote village in the block, where opportunities are limited,

ingly popular, attracting numerous young couples who are hired by the subcontractors and contractors to cities like Rajkot and Ahmedabad.

Hansa, 22, a mother of one, confidently shares her story. She and her husband primarily earn from catering services, where they are paid Rs 500 per day. However, if they secure a monthly job at a hotel, they are paid Rs 15,000 combined.

"I said I also want to go with him because I heard other women from many villages go and help their husbands in the kitchen. I studied till 9th grade. I can keep an account of our salary," she says. As we visited Hansa's home in Obra, we were greeted by a modest kuccha house, barely spacious enough to accommodate her family of six adults along with a dozen farm animals. Such living conditions were common among families in the village.

"We came back to the village for my first delivery, which was seven months ago. My husband will go back [to the city] when he gets some work. Then I will also go after two to three months to work [in the city]," she adds.

Although the uncertain nature of these contracts may expose them to an unreliable employment environment. Hansa and other women from her village do not seem to care about the lack of stability because of the abundant opportunities this migration offers.

However, an awareness about the complexities surrounding labour migration, the need for a consistent income. and the importance of labour rights are crucial for Hansa and her peers as they aim for a more secure and empowered future. These stories, however, raise an important question. Why are women now being included in these migration ventures when historically they had been kept out? The answer to this question lies in the concept of enlisting women as 'helpers', which strategically eliminates the need to hire two separate individuals for kitchen-related tasks.

Contractors keenly seize upon this ploy: by encouraging male workers to bring their wives along, they can avoid the expense of hiring two men because then they can pay two individuals, a husband and a wife, a combined wage that is often lower than what two male workers would individually command.

The contractors' cost-saving strategy, however, becomes unfavourable to women as it does not allow them to explore their identity as an independent worker. This approach also highlights how gender, migration, and economics intersect, showing the ongoing struggle for women to be treated fairly and paid

Kailashi, 21, shared her experience as a migrant labourer. "I was not paid for the work, only my husband did, and at night, all the kitchen staff used to sleep together in the kitchen," she says.

When she came back from Maharashtra due to the COVID-19 pandemic, Kailashi found her in-laws' home overcrowded, with six people crammed into a single room.

When she demanded her husband to provide her and their son a separate living space, he abandoned her and sent her back to her maternal home. In the process, her husband also took her son away, she says.

"I never wanted to get married, and now I don't know what I will do with the rest of my life," she says, while working on her father's farm.

Kailashi's story reveals how women are treated when they seek empowerment. It also highlights the dire need for a systemic change that upholds women's rights, recognises their worth, and safeguards their aspirations within the broader theme of migration and society. Furthermore, these stories also call for the need for a more comprehensive approach to address the multifaceted issues women face, including access to education for children and the intricacies of marital dynamics in the context of migration. # Best skincare routine for dry skin

ealing with dry, dehydrated skin? Don't despair. There's a skincare routine for that!

Dry skin can be uncomfortable and is usually marked by scaling, itching, cracking, and even bleeding. While dry skin commonly affects the hands, arms, and legs, it can affect any part of the body.

When the skin is dry, it develops tiny cracks in the outer layer, interfering with its ability to maintain hydration properly.

Dry skin, also called xerosis is caused by ageing, genetics, heredity factors, sun damages, environmental factors, lack of hydration and moisture etc .There are many other reasons also why skin becomes dry but if left untreated, dry skin can crack and become infected. Dry skins are vulnerable to early wrinkles with rough, reddish patches. Daily and appropriate care is essential.

The type of skincare products you use can also be a factor if they contain harsh chemicals or drying ingredients that disturb the skin's surface.

The secret of a good skin lies in the right kind of care. In dry skins, the oilproducing glands are less active. Seasonal changes also influence the skin. The hot summer season causes moisture depletion. A dry skin lacks both oil and mois-

Moisture is most important to dry skin. It helps to keep the skin soft, smooth and supple, all hallmark of younger skin. In fact, habitual lack of moisture can lead to visible ageing signs on the skin, like lines, wrinkles, loss of elasticity and firmness. When skin is properly moisturized, it is able to naturally exfoliate built-up dead skin which allows younger skin to reveal itself and help a well-formulated moisturizer absorb better.

Normal hydration also allows skin to preserve and sustain the natural substances it relies on to keep it healthy-looking and visibly protected from negative environmental influences. There are various natural ingredients which provide moisturising to skin.

Coconut oil contains saturated fatty acids that have emollient properties which significantly improve skin hydration and increase the number of lipids on the outer parts of the skin making it smooth and

Oatmeal bath has immense qualities .Oatmeal extracts contain anti-inflammatory and anti-oxidant properties which can treat dry skin. It can be used by adding powdered oatmeal to a bath or using creams that contain oatmeal to hyderate

Aloe vera has been part of traditional Indian healing system. Aloe vera gel provides relief from dry skin. A person with dry skin on their hands or feet can apply aloe vera gel and cover the affected area with a sock or glove preferably before going to bed and leave the gel on all night.

Honey has moisturizing ,healing, antiinflammatory properties which can be directly applied on skin to moisturise the skin and can also be used with other herbal products for achieving glowing and radiant skin.

Moisturizers are available in both liquid and cream forms. During the dry season,

for normal to dry skin, it is better to use a moisturising cream, applying it after cleansing and toning. It should also be applied under make-up. A liquid moisturizer can be used at night, after cleansing and nourishing the skin, if the skin is dry. Atmospheric conditions, exposure to the sun, air conditioning and heating, soaps and chlorinated water, make-up cosmetics and air pollution can all lead to moisture loss. This is more so during the hot dry

Therefore, the daily care routine should be adjusted according to the requirements of the skin. For dry skin avoid chemical laden harsh soaps, hot showers, drying cleansers, products with harsh or skin-aghot or cold water and abrasive scrubs, loofahs, or stiff-bristled cleansing brushes that cause micro-tears in skin's surface. Always wear light cotton and khadi comfortable clothing that doesn't feel scratchy on the skin.

Avoid spending too much time in the sun. Tanning and dryness can be a lethal combination. Make sure you regularly moisturize your palms and fingertips because they are constantly exposed to harsh products. Cleanse the face twice a day with a cleansing cream or gel, containing aloe vera, which helps to check moisture loss also rehydrates the skin.

Apply the cleanser, with a light massage and wipe it off with moist cotton wool. Tone the skin, with rose water or a rosebased skin tonic. You can make a homemade cleanser for dry skin - to a tablespoon of cold milk add 2 drops of any vegetable oil (olive, or til or sunflower oil). Dip cotton wool in it and wipe the skin. Make this for 2 or 3 days, but keep it in the refrigerator.

Protect the skin from moisture loss due to sun-exposure. Apply a sunscreen, before going out in the sun. Most sunscreens have built-in moisturizers. A liquid moisturizer should also be used under makeup. Keep the skin well moisturised.

Nourishment is imperative for dry skin, as it not only lubricates the skin, but helps it to hold moisture better. It also softens the skin. After cleansing at night, apply nourishing cream on face and massage it with upward and outward movements, for 3 to 4 minutes. Wipe off excess cream with moist cotton wool before bedtime.

The skin around the eyes is thin and delicate. It acquires lines and wrinkles easily. Apply an under-eye cream wipe it off after 15 minutes, with moist cotton wool. Or, daily apply pure almond oil sparingly and massage lightly, using only the ring finger, for one minute under each eye. Massage in one direction only.

The skin on the lips is also thin and lacks oil producing glands. It becomes dry and chaps easily. After cleansing, apply almond oil or almond cream on the lips daily and leave it on all night. Sun-protective lip balms are also useful.

For skin on the body, arms and legs, apply warm sesame seed oil before bath, massaging it into the skin. Use a mild glycerine soap. Immediately after your bath, apply a body lotion while the skin is still damp. This helps to seal in moisture. (The author is international fame beauty expert and is called herbal queen of

# G20: India's women-led development focus is a good attack on the 'wicked' gender gap

hen India listed "women-led development" as one of six main priorities of its G20 presidency, along with inclusive growth, progress on Sustainable Development Goals, green development, technological transformation and reforming multilateral institutions, it was considered a tacit acknowledgement of the fact that gender equality remains one of the most pressing policy challenges in

India's gender gap – it was ranked 127 out of 146 countries in this year's Global Gender Gap Report and faces the perennial issue of "missing women" from the workforce - is a wicked problem, a term that policymakers ascribe to problems that are impossible to solve in a way that is simple or final, like climate change which is a wicked problem. Under its presidency, India took an approach to mainstream gender into G20 discussions.

India has promoted women-led development as a distinct concept. Under women-led development, women are not just beneficiaries of development; instead, they set the agenda for development and are key to achieving the 2030 Goals, as leaders and equal participants. The concept, as such, taps into a long-established approach in development theory, which calls for the inclusion of women in development planning and decision-making.

Gender and G20

Gender, which was a neglected subject, has slowly gained traction in the G20. There is enough evidence to support that women are force multipliers – when women have access to resources, they invest in the education and health of families and communities, more than men. There is a multiplier effect on economies moting leadership and decision-making roles

too: India, for instance, can boost its GDP by 27 for women at the grassroots, including in politpercent by raising women's workforce participation. At the 2014 summit in Australia, G20 leaders made the "25×25" pledge to reduce the gender gap in labour market participation by 25 percent by 2025. In 2015 in Turkey, the W20 was launched as an official engagement group, a network designed to strengthen women's economic empowerment in the G20 process.

G20 EMPOWER (Alliance for the Empowerment and Progression of Women's Economic Representation) was launched in Japan in 2019, as an alliance between businesses and governments to promote women's leadership and empowerment in the private sector. Gender commitments in the G20 have mainly emphasised increasing female labour force participation and improving workplace conditions and earnings for women. From 2015 onwards the forum has promoted women's entrepreneurship, enhancing digital skills and education in STEM to increase female participation in these sectors.

More recently, the G20 has recognised that the COVID-19 pandemic and the climate crisis have impacted women and girls disproportionately in every part of the world and committed to work on narrowing the resultant inequalities.

Indian vision of women-led development The themes under India's vision for womenled development are wide-ranging, but they can be summarised through the statement that came out of the G20 Ministerial Conference on Women Empowerment, which took place in August and encapsulates discussions that took place during this year.

These include increasing investment in and access to education and skilling, including in STEM for women; promoting women entrepreneurs and women-owned and led MSMEs; proical systems and governance; recognising and promoting women's roles in climate change, food security and nutrition. India's emphasis on women's role in building climate resilience is cognisant of how the climate crisis is not gender-neutral and women and girls experience the greatest impacts of climate change.

**Outcomes of India's Presidency** 

It is a little early to sum up the outcomes, though there have been a few. G20 Empower under the Indian presidency launched a Digital Inclusion Platform for women, TechEquity, an aggregator for learning and skilling that brings together technical training and core skill development along with content on digital and financial education. India has also committed to launching an online platform for mentoring and capacity-building of women in G20 countries with a focus on women in MSMEs and grassroots leaders. The portal will be hosted by NITI Aayog's platform for women's empowerment.

W20 India has pushed for developing National Gender Strategies that are funded and tracked through gender-disaggregated data for G20 countries. That the G20 should create mechanisms to collect and analyse gender-disaggregated data to bridge the gender divide has been demanded under previous presidencies. W20 India has also recommended creating an annual review mechanism to track the implementation and impact of the commitments made to women and girls.

G20 processes are extensive and are dependent on continuity from one presidency to another, just like India promoted women-owned and led MSMEs, an agenda that was taken up last year under the Indonesian presidency. It will be up to Brazil to carry forward some of India's work on these themes (Courtesy: ORF)

## Surgery risks are disproportionately high for women in Africa: New study

mproving surgical care for women in low- and middle-income countries is a global health priority. It's also critical for sustainable development because of the critical role women play in macroeconomic growth, community wellbeing, and as part of the healthcare workforce.

When the inequities and disparities in obstetric outcomes between world regions came to the attention of governments and multinational organisations, maternal health initiatives were started in regions with the highest maternal mortality rates, including sub-Saharan Africa. This has contributed to an almost 40 per cent reduction in maternal deaths in sub-Saharan Africa in the last two decades.

But the outcomes of other kinds of surgery for women in Africa have remained under-examined. Women need equitable surgical care throughout their lives - not just during childbirth.

In our recent study we compared the outcomes of non-obstetric surgery for women in African countries with the outcomes for women in countries outside

We wanted to bring attention to the outcomes and establish whether there

was a large disparity between the groups. At the surface the outcomes seemed similar: 2.9 per cent of the African patients and 2.3 per cent of the international group experienced severe complications after surgery. But when we adjusted for risk profile, African women were twice as likely to experience severe complications (including death) after surgery compared with the international incidence.

Our study reveals an important and addressable health equity issue and makes a case for expanding funding and resources for women's health and global surgery. The findings point to the urgent need to improve healthcare and surgical care for women in Africa.

Comparing surgery outcomes

The study was an analysis of data from two large, similar studies: The African Surgical Outcomes Study (ASOS and the International Surgical Outcomes Study (ISOS. There were 1.671 women in the African cohort and 18,449 in the international cohort (from low-, middle- and high-income countries elsewhere in the world).

We focused on the outcomes of operations such as orthopaedic and bowel surgery. We excluded obstetric and gynaecological surgeries such as caesarean sections and hysterectomies.

At first glance, the rates of severe com-

plications appeared to be similar: 2.9 per cent of women in the African cohort developed a severe complication and 2.3 per cent of women in the international cohort did.

But the African cohort was almost a decade younger. The African women also had significantly fewer comorbidities such as diabetes and hypertension. And they typically underwent more minor and fewer major surgeries. One would therefore expect their outcomes to be significantly better. This means the African outcomes were disproportionately worse. Our analysis then adjusted for these differences in health status and type of

surgical procedure. The analysis confirmed that, if the risk profiles were equal, women in the African cohort would have twice the odds of dying or having a severe complication after surgery.

This indicates that health system factors, such as staffing and infrastructure, are severely affecting women's surgical care and health in Africa. This not only affects the patients, but has ripple effects for their families, communities and the macroeconomic development of their countries.

Almost half – 48 per cent – of the women who developed severe complications in the African cohort died while in hospital (versus 18 per cent in the international cohort). This is a particular cause

The percentage of severe complications that result in death is known as the "failure-to-rescue" rate. It's largely determined and prevented by the early detection of potentially serious postoperative complications in hospital - and fast and effective clinical action in response.

Where there are staff shortages, high patient loads and limited funding, doctors and nurses are stretched. Many hospitals in these settings don't have the resources and warning systems to pick up these complications and act early enough. This is currently a major issue in African health systems.

**Future steps** 

Women at all life stages and from all backgrounds deserve access to safe and comprehensive surgical care. Our study highlights the need for further research and investment into women's surgical care in African countries.

Africa is not a monolith. There are vast differences between and within African countries' health systems. Therefore there's a need for country-specific and condition-specific research into women's surgical care and ways to improve these outcomes on the African continent. (Courtesy: Down To Earth)



#### Israeli Supreme Court hears first challenge to Netanyahu's contentious judicial overhaul



JERUSALEM, Sept 12: Israel's Supreme Court on Tuesday opened the first case to look at the legality of Prime Minister Benjamin Netanyahu's contentious judicial overhaul — deepening a showdown with the far-right government that has bitterly divided the nation and put the country on the brink of a constitutional crisis.

In a sign of the case's significance, all 15 of Israel's Supreme Court justices are hearing appeals to the law together for the first time in Israel's history. A regular panel is made up of three justices, though they sometimes sit on expanded panels. The proceedings were also being live-streamed.

The law, which the Israeli parliament passed in July, cancels the court's ability to strike down government decisions it deems to be "unreasonable." It is the first piece of the wider plan by Netanyahu's government to weaken the Supreme Court and give more

power to the governing coalition. The protesters have come largely from the country's secular middle class. Leading high-tech business figures have threatened to relocate. Perhaps most dramatic, thousands of military reservists have broken with the government and declared their refusal to report for duty over the plan.

Netanyahu's supporters tend to be poorer, more religious and live in West Bank settlements or outlying rural areas. Many of his supporters are working-class Mizrahi Jews, with roots in Middle Eastern countries, and have expressed hostility toward what they say is an elitist class of Ashkenazi, or Euro-

# North Korea's Kim is in Russia ahead of a meeting with Putin as their nations draw closer

SEOUL, Sept 12: North Korea's Kim Jong Un arrived in Russia on Tuesday for a meeting with President Vladimir Putin where they are expected to offer each other increased support in their escalating standoffs with the West.

Kim is expected to seek Russian economic aid and military technology in exchange for munitions to be used in Russia's war in Ukraine.

North Korea's official Korean Central News Agency said Kim boarded his personal train bound for Russia on Sunday afternoon, accompanied by members of the ruling party, government and mili-

After decades of complicated, hot-and-cold relations, Russia and North Korea have drawn closer since Moscow's invasion of Ukraine in 2022. The bond has been driven by Putin's need for war supplies and Kim's efforts to boost his partnerships with traditional allies Moscow and Beijing as he tries to break out of diplomatic iso-

South Korea's military assessed the train crossed into Russia early Tuesday, Jeon Ha Gyu, spokesperson of South Korea's Defence Ministry, said without elaborating on how the military obtained the information.

Experts say North Korea would struggle to acquire such capabilities without external help, although it's not clear if Russia would share

Kim Jong Un may also seek badly needed energy and food supplies, analysts say. Deputy foreign minister Andrei Rudenko said Russia may discuss humanitarian aid with the North Korean delegation, according to Russian news agen-

Kim's delegation also likely includes his foreign minister, Choe Sun Hui, and his top two military officials, Korean People's Army Marshals Ri Pyong Chol and Pak Jong Chon.

Putin arrived in the eastern city of Vladivostok on Monday to attend an international forum that runs through Wednesday. Putin's first meeting with Kim was held in 2019 in the city, which is about 425 miles (680 kilometres) north of Pyongyang. Peskov said Putin and Kim will meet after the Vladivostok forum, but the reports didn't specify when or where. He added

that the meeting would include a lunch in Kim's honour.

At the forum on Tuesday, Putin spoke about economic development in Russia's Far East, and did not mention Kim in his first hour at the forum's plenary session. Earlier, he told forum moderators that Russia was developing weapons based on "new physical principles" but did not give details

Data from FlightRadar24.com, which tracks flights worldwide, showed an Air Korvo Antonov An-148 took off from Pyongyang on Tuesday and flew for about an hour to reach Vladivostok. North Korea's national airline has only just resumed flying internationally after being grounded during the COVID-19 pandemic. There had been speculation that North Korea could use a plane to fly in support

According to US officials, Putin could focus on securing more supplies of North Korean artillery and other ammunition to refill declining reserves as he seeks to rebuff a Ukrainian counteroffensive and show that he's capable of grinding out a long war of attrition. That could potentially put more pressure on the US and its partners to pursue negotiations as concerns over a protracted conflict grow despite their huge shipments of advanced weaponry to Ukraine in the past 17 months. ## US praises India for G20 summit, hails 'India-Middle East Europe Economic Corridor'

**WASHINGTON, Sept 12:** The US lauded India for hosting the G20 summit, calling it a big "success" and hailing the landmark 'India-Middle East-Europe Economic Corridor' which will usher in a new era of connectivity from Europe to Asia and will stimulate economic growth across the two continents.

The G20 Leaders' two-day summit held under India's presidency, wrapped up on Sunday. On Saturday, the ambitious India-Middle East-Europe Economic Corridor (IMEC) was jointly announced by the leaders of the US, India, Saudi Arabia, the United Arab Emirates, France, Germany, Italy and the European Union on the sidelines of the summit in New Delhi.

The new economic corridor is seen as an alternative to China's controversial Belt and Road Initiative (BRI).

During a regular press briefing on Monday, the US State Department spokesperson Matthew Miller told reporters," It was a landmark India-Middle East-Europe Economic Corridor (IMEC) that we believe will usher in a new era of connectivity from Europe to Asia that will stimulate economic growth, economic development across the two continents, as well as cooperation on energy and digital connectivity.'

"The memorandum of understanding is among the United States, India, Saudi Arabia, the UAE, EU, and other G20 partners to explore a shipping and rail transportation corridor that will enable the flow of commerce, energy, and data from India, the Middle East, and Eu-

rope," he said in response to a question. Miller said that the recently concluded G20 Summit in New Delhi was a big success."We absolutely believe that it was a success," he said

"First, with respect to the statement, the G20 is a big organisation. Russia is a member of the G20; China is a member of the G20. There are members that have a diverse range of views. We believe the fact that the organisation was able to issue a statement that calls for respecting territorial integrity and sovereignty and saying that those principles should not be violated is an extremely important statement because that is exactly what is at the heart of Russia's invasion of Ukraine," he said.

"It is those very questions. So we thought that was an incredibly important statement for them to make. You also saw important announcements made at the G20 about new economic arrangements between Saudi Arabia and India that the United States was a part of," Miller said.

"With respect to (Chinese) President Xi Jinping not attending – I'm not going to speak to whether President Xi should have attended or should not have attended. I will say we found it incredibly productive for President Biden and Secretary Blinken to be there, engaging directly with their counterparts," he said.

"There is no substitute for that, and we found it incredibly productive for the interests of the United States to be able to have those conversations and advance them. As the White House made public over the weekend, in addition to the sessions, the President had a number of pull-asides with leaders of other countries where we were actively advancing the foreign policy priorities of the United States, including engaging on the war in Ukraine," Miller said.

India managed to hammer out an unexpected consensus among the G20 countries on the contentious Ukraine conflict through a series of hectic negotiations with emerging economies such as Brazil, South Africa and Indonesia playing a leading role in reaching the agreement on the declaration on the first day of the summit.

The G20 member countries represent around 85 per cent of the global GDP, over 75 per cent of the global trade, and about two-thirds of the world popula-

The grouping comprises Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the UK, the US and the European Union. On Saturday, the African Union was admitted as G20's permanent

## Pak court reserves verdict on Imran Khan's plea challenging cipher case trial inside jail



ISLAMABAD, Sept 12: A Pakistani court on Tuesday reserved judgement on a petition filed by jailed former Prime Minister Imran Khan challenging the hearing of the cipher case inside the Attock prison in

The 70-year-old chairman of the Pakistan Tehreeke-Insaf (PTI) party has been kept in jail since August 5 after his conviction in the Toshakhana corruption case. His sentence was suspended by the Islamabad High Court (IHC) on August 29, but he continues to remain in Attock prison in the cipher case. His remand has been extended till September 13 by a special court in the case.

The cricketer-turned-politician is charged with the violation of the Official Secrets Act in connection with the leakage of a confidential diplomatic cable from Pakistan's embassy in Washington.

During the hearing at the Islamabad High Court, Imran's counsel Sher Afzal Marwat alleged that there was malice behind the change of venue for the cipher case hearing, The Express Tribune newspaper reported.

"The purpose of this change of venue notification is to keep the PTI chairman in jail. We have not even been notified why the notification was issued," he said. Underlining that any trial of a civilian registered under the Official Secret Acts takes place in a special court, as per the law, Marwat argued the rule should be

applicable in Khan's case as well. He further questioned under which law and authority was the law ministry able to transfer the hearing of the case to Attock Jail.

"How can the trial be transferred from Islamabad to Punjab? Transferring a trial to another province can legally be done only by the Supreme Court, not by the chief commissioner or home secretary," Marwat argued, adding that if the trial venue was to be changed, a petition should have been filed with the trial judge.

In his argument, Additional Attorney General Mansoor Igbal Dogal said the notification related to the jail trial was for one time only and that the exception made the PTI chief's petition ineffective.

evasion though she faces 2 more legal cases MANILA, Sept 12: Nobel Peace Prize winner Maria Ressa was acquitted of a final tax evasion charge on Tuesday though she still faces two remaining legal cases she believes

the former Philippine President Rodrigo Duterte used to muzzle her critical reporting. Ressa and her online news organisation Rappler had faced five tax evasion charges but a court acquitted her of four of the charges in January. A different court heard the fifth charge and acquitted her Tuesday.

"Facts wins, truth wins, justice wins," she told reporters outside the courthouse.

Ressa and Russian journalist Dmitry Muratov were awarded the 2021 Nobel for their efforts to safeguard freedom of expression by fighting for the survival of their news organisations and defying government efforts to shut them.

She had said the charges against her were politically motivated as Rappler was critical



of Duterte's brutal crackdown on illegal drugs that left thousands of mostly petty drug suspects dead. The International Criminal Court is investigating the crackdown as a

possible crime against humanity. Rappler also criticised Duterte's handling of the coronavirus pandemic including prolonged lockdowns that deepened poverty, caused one of the country's worst recessions and sparked allegations of corruption in government medical purchases.

Ressa also said there appeared to be a "lifting of fear" under the Philippines' new leader - Ferdinand Marcos Jr, who is the namesake son of the dictator overthrown in the armybacked "people power" uprising in 1986.

Ressa is still appealing to the Supreme Court against an online libel conviction, while Rappler is challenging a closure order issued by the Securities and Exchange Commission.

"You've got to have faith," Ressa said. "The acquittal now strengthens our resolve to continue with the justice system, to submit ourselves to the court despite the political harassment, despite the attacks on press freedom. It shows that the court system works and we hope to see the remaining charges dismissed." (AP)

#### Malaysia's Appeals Court upholds Najib's acquittal in one of his 1MDB trial

PUTRAJAYA, Sept 12: Malaysia's Court of Appeal on Tuesday upheld the acquittal of former Prime Minister Najib Razak of audit tampering in relation to the multibillion dollar looting of the 1Malaysia Development Berhad state fund, though he remains in prison for other graft charges.

The court struck out the appeal after prosecutors failed to meet deadlines in filing documents to support their bid, Najib's lawyer Mohamed Shafee Abdullah told a news conference. Najib, 70, was acquitted in March after the High Court ruled prosecutors failed to show that he abused his position to order amendments to a 1MDB audit report in 2016 to coverup wrongdoings before it was presented in Parlia-

"The acquittal is upheld without any further process," Shafee said, adding that prosecutors are unlikely to appeal to the top court.

The audit tampering is one of Najib's several corruption trials. He is currently serving a 12-year jail term after losing his final appeal last year in his first of several corruption trials linked to the 1MDB scandal.

The 1MDB fund was set up months after Najib became prime minister in 2009. Investigators allege more than \$4.5 billion was stolen from the fund and laundered by Najib's associates through lawvers of bank accounts in the United States and other countries to finance Hollywood films and extravagant purchases that included hotels, a luxury yacht, art and jewelry.

More than \$700 million landed in Najib's bank accounts. Najib and his wife, Rosmah Mansor, were hit with multiple graft charges after the saga led to his ruling coalition's shocking defeat in 2018 general elections. Rosmah was sentenced in 2022 to 10 years in prison and a record fine of 970 million ringgit (\$217 million) for corruption over a solar energy project and is out on bail pending an appeal.

#### 7 died in storms in southern China

BEIJING, Sept 12: Rainstorms battering southern China have killed at least seven people and allowed dozens of crocodiles to escape from a farm. Nearby residents were advised to stay at home after more than 70 crocodiles escaped in Maoming, a city near the coast in western Guangdong province, according to Chinese media reports.

An emergency official was quoted as saying that 69 adult crocodiles and six juveniles had escaped. Some have been captured, but the operation was difficult because of the depth of a lake they are in, the media reports said.

No injuries have been reported. Further west, seven people died and three are missing after multiple landslides in the city of Yulin in the Guangxi region, the official Xinhua News Agency reported late Monday. Heavy rain on Sunday and Monday triggered the landslides.

GUWAHATI, Sept 12: In response to a tip-off, law enforcement authorities launched a significant operation targeting a narcotics trafficking operation involving a Thar vehicle with the registration number AS 01 FM 7800. The vehicle was suspected of transporting illegal drugs from Churachandpur in Manipur to various Lower Assam districts. The operation took place at Saraighat on the Kamrup side, where the vehicle was intercepted. During this operation, three individuals from Manipur, who were believed to be involved in drug peddling, were

apprehended. # SC refers pleas challenging validity of sedition law to bench of at least five judges

NEW DELHI, Sept 12: The Supreme Court on Tuesday referred to a Constitution bench of at least five judges a batch of pleas challenging the constitutional validity of the IPC provision on sedition, a month after the Centre introduced in Parliament bills to replace the colonial-era penal statutes IPC, CrPC and the Evidence Act, proposing among other things the repeal of the sedition

A bench headed by Chief Justice D Y Chandrachud declined the Centre's request to defer the issue of reference to a larger bench as Parliament is in the process of reenacting the provisions of the

Indian Penal Code (IPC) and the Bill has now been placed before a standing committee.

'We are not inclined to accept the request for deferring the consideraof constitutional chal-

lenge in these batch of matters for more than one reason," said the bench, also comprising Justices J B Pardiwala and Manoj Misra. The bench observed that section 124A (sedition) of the IPC continues to remain on the statute book, and even if the new Bill becomes a law, there is a presumption that any new law in the penal statute will have prospective and not retrospective effect.

"Consequently, the validity of the prosecution which would be launched so long as section 124A continues to remain in the statute, will have to be assessed on that basis," it said.

The court noted the constitutional validity of section 124A of the IPC was tested by the apex court on the basis of a challenge that it was ultra vires Article 19(1)(a) of the Constitution in the 1962 judgement of Kedar Nath Singh versus State of Bihar.

Article 19(1)(a) relates to the right to freedom of speech and expression. The 1962 judgement had upheld the constitutionality of Section 124A and held it was in harmony with Article 19(1)(a).

The bench observed it needs to be noted that when the five-judge constitution bench had ruled on the validity of Section 124A in 1962, the challenge to it on the ground that it violated Article 19(1)(a) of the Constitution was tested only

It said at that time there was no challenge on the ground that section 124A of the IPC violated Article 14 (equality before law) of the Constitution.

The bench noted the submission of the counsel representing the petitioners that it would be necessary to re-evaluate the validity of Section 124A of the IPC as the provision has only been tested with respect to Article 19(1)(a) of the Constitution.

The top court said the appropriate course of action for a threejudge bench would be to direct that the papers be placed before the CJI so the pleas could be heard by a

> bench of at least five judges since the 1962 decision was by a constitution bench. "We accordingly

direct the registry to place the papers before the CJI so that appropriate decision can be taken on the administrative side for the constitution of a

bench of a strength of at least five judges," the court said. The apex court had on May 1

deferred the hearing on these pleas after the Centre said it was at an advanced stage of consultation on re-examining the penal provision. On August 11, in a landmark

move to overhaul colonial-era criminal laws, the Centre had introduced in the Lok Sabha three bills to replace the IPC, CrPC and the Indian Evidence Act, proposing among other things the repeal of sedition law and introducing a new provision with a wider definition of the offence.

The top court had on May 11 last year put on hold the penal law on sedition till an "appropriate" government forum re-examined it and directed the Centre and states to not register any fresh FIR invoking the provision. Besides the lodging of FIRs, ongoing probes, pending trials and all proceedings under the sedition law across the country will also be in abeyance, the top court had said. The law on sedition, which provides for a maximum jail term of life under section 124A of the IPC for creating "disaffection towards the government", was brought into the penal code in 1890, a full 57 years before Independence and almost 30 years after the IPC came into

KOCHI, Sept 12: Watching pornographic photographs or videos in one's private time without showing it to others is not an offence under the law as it is a matter of personal choice, the Kerala High Court has held.

The high court said that declaring such an act as an offence would amount to intrusion of a person's privacy and interference with his personal choice.

The ruling by Justice P V Kunhikrishnan came while quashing a case of obscenity under Section 292 of the Indian Penal Code against a 33-year-old man who was back in 2016 caught by police while watching porn videos on his mobile phone on the roadside near the Aluva palace here.

The order and ruling came on the accused person's plea to quash the FIR and the court proceedings against him in connection with

The court said pornography was in practice for centuries and the new digital age has made it more accessible, even to children.

"The question to be decided in this case is whether a person watching a porn video in his private time without exhibiting it to others amounts to an offence? A court of law cannot declare that the same amounts to an offence for the simple reason that it is his private choice and interference with the same amounts to an intrusion of his privacy," it said.

The court also noted that there was no allegation that the petitioner (accused) publicly exhibited the video.

"I am of the considered opinion that watching an obscene photo by



not an offence under Section 292 (obscenity) of IPC. Similarly, watching an obscene video by a person from a mobile phone in his privacy is also not an offence under Section 292 IPC.

"If the accused is trying to ciralate or distribute or publicly exhibit any obscene video or photos, then the offence under Section 292 IPC is attracted," Justice Kunhikrishnan said.

Therefore, no offence under Section 292 of the IPC is made out against the accused, the court said and quashed all the proceedings in the magisterial court in connection with the case.

At the same time, Justice Kunhikrishnan also cautioned parents against giving mobile phones with internet access to children to make them happy.

"The parents should be aware of the danger behind it. Let the children watch informative news and videos from the mobile phones of their parents in their presence.

"Parents should never hand over

mobile phones to minor children to make them happy and thereafter complete their daily routine works in their house allowing unsupervised use of mobile phones by children," the judge said.

Justice Kunhikrishnan said that if minor children end up watching porn videos, which are now accessible in all mobile phones, "there will be far reaching consequences"

"Let the children play cricket or football or other games they like during their leisure time. That is necessary for a healthy young generation who are to become the beacons of hope of our nation in the future.

"Instead of purchasing food from restaurants through 'swiggy' and 'zomato', let the children taste the delicious food made by their mother and let the children play at playgrounds and come back home to the mesmerising smell of their mother's food. I leave it there to the wisdom of the parents of minor children of this society," the judge

# Invest more in R&D for India to keep pace with evolving world: Rajnath to domestic defence firms

JAMMU, Sept 12: Defence minister Rajnath Singh on Tuesday called upon domestic defence companies to invest more in research and development for India to keep pace with the evolving world. Addressing the North-Tech Symposium, jointly organised by the army's Northern Command, the Society of Indian Defence Manufacturers (SIDM) and IIT-Jammu, Singh described the country's defence manufacturing sector as "imaginative, innovative, dynamic and progressive".

"Though research and development (R&D) is a risky venture as it requires out-of-the-box thinking and sometimes does not give desired results, it still remains one of the basic elements for the development of any country," he said. Hence, capital investment in R&D becomes a necessity, the minister added

The defence minister said India is passing through a transitional phase. "There is nothing wrong in acquiring a technology through imitation or transfer, but we cannot become a developed nation on these grounds alone. We need to file our own patents, for which a lot of investment in R&D is needed," he said

He said capital investment in R&D may reduce today's profits, but it will prove to be beneficial to the industry and the country in the long term.

Highlighting the steps taken by Narendra Modi government to support the domestic industry, he said the synergy between the government and domestic companies has resulted in record defence production of ₹ 1 lakh crore and

exports of ₹ 16,000 crore in the financial year 2023-24.

Singh expressed confidence that defence exports will soon touch the ₹ 20,000-crore mark. He extended the Ministry of Defence's continued support to the industry for holistic development of the nation, in line with the 'Aatmanirbhar Bharat' initiative.

The defence minister urged industry partners to focus on creating a culture that encourages R&D, based on skilled human resources, and suggested linking the work of institutions such as IITs, IIMs and IISc with the defence sector to create an R&D ecosystem. "Efforts should be made to connect with the

Indian R&D sector, engineers and scientists who work in top universities, companies, space agencies and scientific research organisations abroad and wish to be a part of India's growth story," he said. The defence minister also recommended hir-

ing of managers, legal experts and financial experts from within the country and abroad to create a culture conducive for R&D. "We cannot run our workforce in the 21st century on the basis of HR policies of the 19th

century. Today, the quality of work is more im-

portant than the number of hours worked. Focus should be on intellect and innovation," he said. The defence minister said that "a work culture needs to be developed where there is a concept of senior and junior, and not superior and inferior". He also noted that there is a need to involve women in R&D with "more effective-

He also exhorted the SIDM to create an independent body, comprising scientists and experts from the industry, which will work with transparency and evaluate the products made by companies.

"The buyer or the government will definitely try to check the quality of the products from their end, but there is a need to develop a system for internal evaluation as well. This quality check system will increase your credibility globally with time," he said.

He also suggested that the SIDM should create an internal vigilance mechanism to counter the potential cases of corruption and favouritism. "If any company affiliated with you is indulging in any wrongdoing or passing wrong information, then you should bring it before the government. Such actions will further increase people's trust in the institutions," Singh said. The North Tech symposium is an event conducted annually and this year, it was organised at IIT-Jammu.

The event witnessed an participation of around 200 industry partners and provided an opportunity for knowledge diffusion among various stakeholders to create awareness of contemporary technologies and hardware solutions available with manufacturers under 'Aatmanirbhar Bharat'

Singh witnessed a plethora of indigenous weapons and equipment. He lauded the efforts of all stakeholders in their joint efforts to push the domestic defence industry. (PTI)

Mehta, Chairman, Deendayal Port Authority; Vladimir Panov, Rosatom Special Representative for the Arctic Development, Dmitry Prokhorenko, Director for Foreign Network Development, Russian Export Center JSC also attended the session. Both the parties also discussed about modern infrastructure in ports and ways and means to ensure cargo volume for the shipping industry.

The Deputy Chairman of Chennai Port Authority, S Viswanathan delivered a presentation on the "Capabilities of Indian ports and prospects for operationalisation of Chennai-Vladivostok corridor." Elena Kazarina, Commercial Director of the Port, Vladivostok Commercial Sea Port also delivered a presentation on "Development of FESCO's Deep Sea routes and further directions of transport and logistics relations between Russia and India." A Memorandum of Intent on Development of Maritime Communications between the two ports of Vladivostok and Chennai was exchanged in the presence of Modi and Russian President Vladamir Putin during Eastern Economic Forum in Vladivostok in September 2019. Subsequently, an independent study found that coking coal as the most suitable commodity for trade between the two countries using EMC.

In due course, more commodities like oil, LNG, fertilizers will be added to the list of commodities transported via EMC. The Eastern Maritime Corridor is estimated to reduce the time required to transport cargo between Indian and Russian ports of Far-East Region by up to 16 days, i.e., 24 days in comparison to over 40 days currently taken to transport goods from India to Far East Russia via Europe.

Present trade route between Mumbai in India and St Petersburg in Russia covers a distance of 8,675 nautical miles which takes approximately 35 to 40 days. A large container ship which travels at the normal cruising speed of 20-25 knots (37-46 km/hour), will be able to cover this distance in approximately 10 to 12 days. This corridor holds immense potential to unlock new opportunities for trade and cooperation.




LOS ANGELES, Sept 12: Hollywood icon Marilyn Monroe's LA residence, the only property she owned in her life, has been saved from demolition after a backlash from residents in the neighbour-

Marilyn bought the palatial pad in the city's Brentwood area in 1962 after her divorce from Arthur Miller but was found dead in the property just months later, following an apparent drug overdose at the age of 36.

The property was to be demolished by its current owner, who bought the 2,900-square-foot hacienda for USD 8.35 million. The residents of the neighbourhood became aware of the planned demolition after the owner filed for permits, according to CNN.

After a backlash from the residents, the Los Angeles officials intervened to block the demolition.

'Unfortunately, the Department of Building and Safety issued a demolition permit before my team and I could fully intervene and get this issue resolved," LA city councilwoman Traci Park said in a



news conference last week.

Park said she received hundreds of calls urging her to

save the Spanish colonial-style house. On Friday, the city council unanimously approved Park's emergency motion to begin the process to desig-

nate the house a historic building. Demolition is on hold until the city's Office of Historic Resources conducts a study and analysis of the

home, according to Park. The 2,624-square-foot home sits on an estate which boasts a swimming pool and citrus grove. It has four bedrooms and three bathrooms. (PTI)

# This innings was classic example of playing second fiddle to KL: Kohli after 47th ODI ton



COLOMBO, Sept 12: Virat him on strike and playing Kohli said that his 47th ODI hundred as a classic example of playing second fiddle after not getting off to a good start in India's record 228-run win against Pakistan in an Asia Cup Super Four game here on Monday.

Kohli's lightening quick running between the wickets was mainly down to this exemplary fitness but he called those singles and doubles "easy runs" after racking up an unbeaten 122 off just 94 It was a typical Kohli hun-

dred in which he accumulated the runs via 38 singles and 15 twos before changing gears towards the end of the innings. "I always prepared my

game in a way I can help the team. Today was a classic example of you don't get off to a good start... KL started better, I was trying to bring second fiddle," said Kohli when asked about his in-

"And yes, then after that I stepped up where I could. I take a lot of pride in fitness. Pushing for doubles are easy runs, compared to a big shot. It has paid off before, hope to continue in the same way," he added.

Talking about the partnership with Rahul, Kohli said: "Both KL and myself are both conventional players. And when you have him batting the way he was and me playing, its tough to break these partnerships because we don't play fancy shots.

"We didn't think about the partnership too much, the idea was to 'keep batting.' It is one of the memorable partnerships we've had and for Indian cricket as well. He hit form for us straightaway, good for us (going into the

World Cup)."

Due to rain, India will end up playing three days in a row as they take on Sri Lanka here on Tuesday. They romped to a 228 run win over Pakistan on the reserve day after only 24.1 overs were possible on Sunday.

Kohli was understandably tired after an epic knock but come Tuesday, he will be

"It's the first time I have done anything (play back-to-back ODIs) like this in 15 years of cricket. Luckily, we are Test players, so we know how to come back the next day and play. Recovery is crucial. It was humid out there today. I will be 35 in November, so I need to take care of my recovery.

"A big shout-out to the groundstaff from my side," he added when asked about taking the field in less than 24 hours. (PTI)


