# Delhi suspends visa issuance to Canadians

Killing of Khalistani separatist: India-Canada row escalates

NEW DELHI, Sept 21: India on Thursday announced temporarily suspending issuance of visas to Canadian citizens in view of "security threats" faced by its high commission and consulates in Canada, amid an escalating diplomatic row over Ottawa's allegations relating to the killing of a Khalistani separatist on Canadian soil.

Union external affairs ministry spokesperson Arindam Bagchi said the decision will include Canadian visa applicants in third countries even as he asserted Canada must act against the pro-Khalistani elements operating from its territory.

India is temporarily unable to process visa applications from Canada because of the "security threats" faced by our high commission and consulates in Canada, Bagchi said at a media briefing.

"You are aware of the security threats being faced by our high commission and consulates in Canada. It has disrupted their normal functioning. Accordingly, our high commission and consulates are temporarily unable to process visa applications," he said. Bagchi said the situation will be reviewed regularly. He said all categories of visas have been suspended.

They also said the major emitting nations' reluctance to act on climate crisis is disrespectful and fatal and must be called out.

United Nations Secretary-General António Guterres' Climate Ambition Summit on Wednesday highlighted two key aspects -- the conspicuous absence of leaders from major emitter nations and a unanimous call by attend-

ing leaders to phase out fossil fuels. Notable omissions included leaders from the

# India to clock GDP growth of 6.5 pc in FY24 despite high crude oil prices: NITI Aayog member Arvind Virmani ICICI bank slumps 2.81 pc

NEW DELHI, Sept 21: The Indian economy will grow at around 6.5 per cent in the current fiscal, notwithstanding high crude oil prices and increased uncertainty due climate changes, NITI Aayog member Arvind Virmani said on Thursday. Virmani also asserted that the gross household savings ratio in India has consistently gone up. In an interview with PTI, he said: "My growth projection (of India's GDP growth) is 6.5 per cent plus minus 0.5 per cent... because my experience is that the fluctuations in global GDP more or less has balanced out for us, assuming normal changes." On some US-based economists' claim that India is overstating economic growth, Virmani said he has noticed that certain former officials don't have any idea how GDP is constructed as they have come from academic background.

Last week, the Finance Ministry also dismissed the criticism of inflated GDP, saying it has followed the consistent practice of using the income side estimates to compute economic growth, and stressed many international agencies have revised upwards their forecast after seeing the first quarter data.

#### New generation Tata NEXON MG Motor India exploring options for a second plant in country

KOLKATA, Sept 21: Chinese car maker MG Motor India is exploring the possibility of setting up a second plant in the country, a company official said. Currently, the company has a manufacturing plant at Halol in Gujarat where the production capacity is 1.2 lakh units per annum. We are exploring the option of putting up a second plant in India. It

generally takes two to three years for a new plant to come into stream", Gaurav Gupta, deputy managing director of MG Motor India said on Wednesday evening. The company has not identified so far the location of the possible second plant.

Starting operations in India four years back in 2019, the company is presently having five models and selling around 5,000 units per month. Out of the five models, two are electric vehicles (EV), he said Gupta said the company plans to introduce a new model every year in

India, either on the EV or ICE (internal combustion engine) platforms. He said at present, 25 per cent to 30 per cent of the company's sales are coming from the EVs. "Our target is to increase this percentage to 35 per cent by 2025", Gupta added. He also said the company is also evaluating the option of a setting up a battery assembly plant near the existing facility in Gujarat. Gupta said the passenger car industry is growing at a pace of nine to ten per cent per year. "During January to August in 2023, the company's sales grew at more than 20 per cent. We hope to maintain

this pace during the current calendar year", he said. Presently, MG Motor India is sourcing batteries for its EVs from China. For improving the EV ecosystem, the company has partnered with Jio-BP to set up charging stations in the country.

The company has invested ₹ 4,000 crore so far in India. MG Motor India is also exporting cars to Nepal and other SAARC countries, he said, adding the company is evaluating other export destinations as well. (PTI) modities (0.75 per cent). Teck







#### Women's Reservation Bill

The much-anticipated passage of the Women's Reservation Bill, after an agonizing 27-year wait, hasn't sparked the jubilation it rightly deserves. Over these years, successive governments have made concerted efforts to bury it in obscurity. It is only the Left parties and segments of the women's movement, notably AIDWA, that have tenaciously fought to keep its flame alive. The disheartening truth is that while the bill has finally been passed, its implementation is being needlessly postponed until after the next general election, citing dubious grounds. The draft bill stipulates that the reservation of parliamentary and state assembly seats for women will occur only after the next census, which is set to begin in 2026, along with the delimitation of seats. Neither the census operation nor the delimitation exercise is a prerequisite for implementing women's reservation. This reservation could be executed immediately after the bill's passage, with seat adjustments made later if necessary. Yet, specious arguments are being wielded to deny women their right to elected representation for more years. The BJP has consistently included the bill's passage in its election manifestos and promised to enact it before both the 2014 and 2019 general elections. They have held a majority in the Lok Sabha after both elections and pushed through controversial legislation. However, they failed to fulfill this electoral pledge during their nine years in power. Now, towards the end of their second consecutive term, they introduce the bill, seemingly hoping to secure women's votes without challenging the patriarchal status quo. This strategy is unlikely to succeed. Women across the nation feel

deceived rather than elated. The bitter realization is that several elections will pass without a substantial increase in women's representation in parliament and state assemblies. It's shameful that in 75 years of our independence, in a nation the BJP heralds as 'the cradle of democracy,' the proportion of seats held by women in the Lok Sabha has only risen from 5% to 15%. Most countries surpass us in this regard, even though Indian women vote in large numbers, and their participation grows with each election. The government's recent message is that this will not change soon, even though it could have by the 2024 general election. Adding insult to injury, the government appends a patronizing section titled 'Statement of Objects and Reasons' to the bill. In it, they claim to have empowered women through various initiatives, citing financial independence, access to education, and health services. They assert that true empowerment requires greater participation in decision-making. This section ends by stating that the bill aims to achieve these objectives.

However, this section is objectionable on several fronts. Initiatives like the Ujjawala Yojana have proven to be cruel jokes on millions of impoverished women who can't access free cylinders due to technicalities and can't afford the now-expensive ones. Similarly, claims of widespread toilet construction belie the grim reality of poor women's enduring unsanitary conditions. Mentioning these deeply disappointing schemes serves as a fitting conclusion for a bill promising women's reservation in positions of power, which will remain frustratingly out of reach for a considerable time. This delay undermines women's political representation, perpetuating a long-standing disparity. The government must act swiftly to fulfill its promise and empower women in decision-making roles. Urgent action is imperative. Closing this representation gap is essential for true democracy and gender equality in India.

## Challenges in Indo-Canada relations: Examining Khalistan extremism and Trudeau's legacy

dian airline by pro-Khalistan separatist terrorists remains a haunting and unresolved chapter in Canadian security history. Despite the passage of many decades, it is disheartening that crucial lessons have not been fully learned from this dreadful attack. Shockingly, only one individual was eventually charged with manslaughter in connection to this horrendous event, and it took nearly two decades for the investigation and prosecution to conclude, as reported by the Canadian national broadcaster, CBC, in July 2022. The prolonged nature of the investigation and the slow progress within the Canadian judicial system have undoubtedly left the Indian government and its citizens, particularly those deeply affected by this act of terrorism, with feelings of dissatisfaction and mistrust. This protracted legal process and the eventual verdict have, for some, served as an ominous precursor to further troubling developments.

Indeed, recent times have witnessed a resurgence of violent and menacing activities perpetrated by elements within the Khalistan separatist movement, taking root in Canada, the neighbor of the United States. Headlines have been replete with evidence of the gravity of this resurgent issue, as exemplified by a report from Wion news titled "How Canada has become headquarters for Khalistani terrorists." Given Canada's historical track record in handling such matters, it is not unreasonable for New Delhi to harbor concerns that Ottawa may lack the necessary commitment or capability to effectively address individuals and groups posing a threat to India's territorial integrity. Especially concerning are those who espouse violence as a means to achieve their destructive objectives, prompting apprehensions about the robustness of Canada's response to this emerging chal-

From this perspective, it comes as no surprise that pro-Khalistan separatists in Canada have felt emboldened to engage in reprehensible actions, such as creating disturbing images glorifying the assassination of a former Indian Prime Minister. Shockingly, they even went so far as to publicly display a grotesque depiction of the brutal assassination of Indira Gandhi, who also served as the head of the Congress Party, an opposition party to the current government led by Narendra Modi's BJP. These recent incidents, among others, have rightfully elicited strong protests from the Indian government and Foreign Minister S. Jaishankar, a member of the BJP party. In a broader sense,

these attacks and threats against India and its citizens on Canadian soil can be viewed as an as-

sault not only on all Indians but also on ethnic Indians worldwide, highlighting the global ramifications of such actions.

Moreover, India has conveyed to Ottawa the imperative of comprehending the necessity for safeguarding its diplomats stationed in Canada, who have been subjected to a range of threats from various Khalistan activists. Adding to the diplomatic concerns, Voice of America reported that India vehemently refuted Canadian Prime Minister Justin Trudeau's allegations of Indian government involvement in the assassination of a Canadian Sikh leader. India dismissed these allegations as "absurd and politically motivated" and, in the midst of escalating tensions between the two nations, took the measure of expelling a Canadian diplomat.

However, one cannot escape the conclusion that years of inaction and ineffectiveness by Otin dealing with the unchecked activities of Khalistan extremists have injected a toxic element into Indo-Canada rela-



tions on all too many occasions. While the overall relationship between these two significant Commonwealth nations has generally been positive, it has been marred by un-

relations hostage. It is imperative that this long-standing friendship between these two major countries is not allowed to fray any further, and a decisive resolution is urgently needed. The primary responsibility for resolving this issue lies with the Canadian authorities, who must take stronger measures to address this problem and prevent it from further straining the bilateral ties between the

The persistent problem of Ottawa's perceived ineffectiveness or lack of interest in addressing the alarming violence and hatred emanating from the pro-Khalistan separatist movement can be attributed, in part, to an overzealous interpretation of Canadian multiculturalism. It seems that the government, entangled in the complexities of minority politics, may be reluctant to confront groups advocating violence. This hesitance may stem from a fear of being labeled as excessively politically correct, a concern exacerbated by the extreme woke politics espoused by certain leftist factions, which may hold undue influence both within and outside the government of Justin Trudeau. A more diplomatic explanation of this leniency towards such groups can be found in the statement made by External Affairs Minister S. Jaishankar, as reported by the Indian Express: "Canada's response to the Khalistani issue appears to be constrained by its 'vote bank compulsion.' India will have to respond if these activities threaten its national security and integrity.

To be more explicit, Justin Trudeau's minority government, which relies on a delicate balance of support, may harbor concerns about alienating a significant and politically active segment of the Canadian community. This segment represents a voting bloc that Trudeau's party has been actively competing for, primarily against the socialist NDP opposition party led by Jagmeet Singh. It's worth noting that Singh had previously attended pro-Khalistan separatist rallies and refrained from condemning the terrorist separatists responsible for the planted bomb that downed the Canadian plane in 2018, as reported by CBC. However, it should be mentioned that Singh has more recently expressed remorse for his past defense of the pro-Khalistani separatist movement leader who was charged in connection with the airline bombing.

ship, would benefit from reframing its perspective. Rather than predominantly positioning itself as a guardian and advocate for various segments of minority groups engaged in overseas conflicts tied to their ancestral roots, a more prudent approach would be to prioritize enlightened selfinterest. This approach doesn't entail indifference to the plight of those suffering and facing abuse abroad but emphasizes a balanced stance that serves the best interests of Canadians while remaining responsive to genuine cases of suffering and oppression elsewhere.

Nevertheless, despite the occasional tensions, New Delhi appears to aspire to enhance its relations with Ottawa, even when these relations have hit rock bottom at times, particularly in the context of the Khalistan issue. Fundamentally, it seems that Prime Minister Justin Trudeau holds a genuine affinity for India and its culture. He seems to be committed to avoiding a legacy marked by opposition to the legitimate concerns of the broader Indian community regarding violence, whether or not voter considerations come into play. #### Significance of Putin-Kim summit for rest Attack on Hinduism- Who gains of the world and global power balance from this intolerance?

n September 13, North Korean leader Chairman Kim Jong-un embarked on his first foreign visit, following the global public health crisis. His arrival was marked by disembarkation from his bullet-proof train at the Vostochny Cosmodrome spaceport, located in the Amur Oblast in the Russian Far East. Kim met Russian leader Vladimir Putin at the launch vehicle assembly building and toured the spaceport facilities before engaging in an hours-long meeting in Kim's Limousine, transported from Pyongyang.

Putin spoke of the Soviet Union's wartime support for North Korea and also covered economic cooperation, humanitarian concerns, and regional dynamics. Kim, reciprocally, pledged "full and unconditional support" for Moscow, making an apparent reference to the ongoing conflict in Ukraine. Kim's itinerary across Russia included visits to aviation factories in Komsomolsk-on-Amur a marine biology laboratory in Vladivostok, and the Russian Pacific Fleet. No doubt, the summit is seen as a sign of the "strategic importance" of bilateral relationships that have an anti-US, anti-Western alignment, thereby strengthening their alliances.

The visit came at a time when the backdrop of a diplomatic standstill in North Korea's relations with the US and South Korea, followed an unsuccessful summit between Chairman Kim and President Donald Trump in Hanoi, Vietnam, in February 2019. Consequently, Kim's meeting with Putin was a strategic manoeuvre to reemerge North Korea on the world stage through successful diplomacy. Moscow and Pyongyang have historical relations, when Stalin supported Kim's grandfather at the start of the Korean War in 1950. North Korea was one of the five countries that opposed the UN resolution in early March 2022, condemning the Russian invasion, and was also one of the first three countries to recognize the independence of the two Russian-occupied states – Donetsk People's Republic and Luhansk People's Republic in Eastern Ukraine.

North Korea possibly has tens of millions of artillery shells and rockets based on Soviet designs that could potentially give a considerable boost to the Russian army. In exchange, Kim seeks badly needed energy, food, and advanced weapon technology, including those related to Intercontinental ballistic missiles, nuclear-capable ballistic missiles, and a military reconnaissance satellite. This exchange can complicate President Biden's security consideration within the European and Asian theatre.

During Kim's visit, he praised "comrade Putin" and depicted Russia's actions in Ukraine as a "sacred fight to protect its sovereignty and security". He also added that the two countries would always be together in the fight against imperialism. The meeting at the Cosmodrome is symbolic, especially as Pyongvang failed twice recently in its bid to put a military spy satellite into orbit. The weaponry of Soviet vintage, akin to those used in the Ukraine conflict, emerged as the most salient items North Korea can provide to Moscow.

According to a senior research fellow from the Royal United Services Institute in Britain, Russia has exhausted up to 11 million shells in Ukraine last year and is set to fire 7 million more this year. Russia's defence industries have been ramping up shell production this year, but it has not been able to keep up with demand stemming from the war. North Korea is believed to possess a substantial reserve of Soviet-designed artillery shells and rockets. which are used against Ukraine. Kim was also accompanied by Jo Chun Ryong, a ruling party official overseeing



The most appealing ammunition to Russia is the BM-21 Grad, a 122 mm multiple rocket launcher system that is similar to the ones it uses. Russia is also interested in the Soviet-made 152 mm M- 1955 (D-20) towed gunhowitzers and 122 mm (D-30) howitzers used by North Korea. North Korea is also one of the few countries with ample stocks of Soviet-era tanks similar to those deployed by Russia in Ukraine, such as the T-54 and T-62, and it could supply spare parts. Former US National Security Advisor John Bolton told CNN "From North Korea's point of view, this gets them back into really significant contact with Russia for the first time since the collapse of

Russia also has an economic interest in North Korea, especially in the fields of energy, transportation, and trade. Moscow hopes to expand its trade with North Korea, which has been severely restricted by the United Nations Security Council sanc-

## Canada's endorsement of terrorism will come back to haunt it

elations between India and Canada have been and Canada nate strained ever since Justin Trudeau became Prime Minister. But it is, perhaps, Trudeau's most dubious achievement to have deteriorated relations with India to a point where Canada is now being seen by most Indians as a new Pakistan. If the India-Canada bilateral readouts after the brief meeting on the sidelines of the G20 Summit in New Delhi reflected a relationship that's destined to head the Pakistan way, then the diplomatic war that has been declared by Trudeau and joined by India has ended all pretence of normal ties and reduced Canada to the status of a new Pakistan.

Both India and Canada have a lot that binds them togetherdemocracy, diaspora (excluding the pernicious parts of it), defence and strategic ties, and, of course, a mutually beneficial economic relationship.

Matters should have never reached such a pass. Both India and Canada have a lot that binds them together—democracy, diaspora (excluding the pernicious parts of it), defence and strategic ties, and, of course, a mutually beneficial economic relationship. And yet, the relations have been allowed to be held hostage by a small but well-organised fringe among the Canadian Sikh community.

At the least, it's immature: at most, it's Ottawa going all out to support the world's No. 1 problem—terrorism.

destabilise India and carry out political assassinations and gangland killings, fund subversive elements, and support narcotics and human trafficking networks inside India. This is unacceptable. These were things Pakistan was notorious for. Canada followed. And now it has become Ottawa's state policy to support terrorists, working on its soil, against India.

Trudeau explains it, in a flippant manner, as protecting freedom of speech and freedom of conscience. For their part, Islamabad defends its support for terrorists under the label of right to self-determination. Nice sounding words and concepts, except that they are both being utterly disingenuous. The people whose freedom of speech and conscience and right to self-determination they are defending are, in fact, the worst violators of these same rights when it comes to those who disagree with them.

Just as the Pakistanis are quick to speak with a forked tongue and assure the world that they will crack down on terrorism, so too is the Trudeau regime in Canada. While in Delhi for the G20 Summit, Trudeau claimed that "we are always there to prevent violence and to push back against hatred". But, so far, there

ties against Khalistanis who have openly been targeting Indian diplomats, have been running a campaign to "Kill India" (isn't that hate speech?), have vandalised the Indian consulates and High Commission, and have defiled Hindu temples. Further, Khalistani gangs have intimidated and threatened non-Khalistan Canadians (Sikhs and Hindus). All this while Canadian authorities have preferred to look away.

#### Parallels with Pakistan and its disingenuous ways

This is so much like what happens in Pakistan. Is Pakistani diplomats openly having deliberations with Khalistanis normal diplomatic activity in the eyes of Canadian authorities? If so. Canada must be reminded of the nexus between Khalistani Canadians and Pakistanis that wreaked havoc in Punjab in the 1980s and 1990s. Normally, if the Khalistanis were blowing off steam and hot air, India would have ignored them with the contempt they deserve. But the track record of the Khalistanis-involvement in the bombing of the AI182, bomb blasts in Tokyo's Narita airport, the funding of subversives and political agitation in India, and freely flowing in a never-ending river of hate speech against India—means been happening in Canada.

The stage for the current spat (predicted by a Canadian politician) was probably set during the meeting between Prime Ministers Modi and Trudeau on the sidelines of the G20 summit in Delhi. In a 10 September 2023 bilateral meeting with Prime Minister Modi, Trudeau was steadfast in his resolve to support terrorists on Canadian soil. In fact, the two readouts could have been talking about two different events.

Modi raised concerns about the anti-India activities of "extremist elements in Canada" who are "promoting secessionism and inciting violence against Indian diplomats, damaging diplomatic premises, and threatening the Indian community in Canada and their places of worship. The nexus of such forces with organised crime, drug syndicates and human trafficking should be a concern for Canada as well. It is essential for the two countries to cooperate in dealing with such threats." Mutual respect and trust, he said, is essential for the India-Canada relationship to progress.

Trudeau's version of the same conversation was so benign that it was almost like the two had not met at all. To him, the meeting was about inclusive eco-

able development; the welcoming of the African Union as a member of G20; and the importance of respecting the rule of law, democratic principles, and national sovereignty.

Trudeau defended his stance as one that is meant to protect freedom of speech. "Obviously, Canada will always defend freedom of expression, freedom of peaceful protest. That is something extremely important to us," he said, while justifying Khalistani terrorists operating from Canadian soil. "At the same time, we are always there to prevent violence to push back against hatred. I think on the issue of community, it is important to remember that the actions of the few do not represent the entire community or Canada." Nobody is arguing that every

Sikh is a terrorist. But the shield called "few" that Trudeau raised merely hyphenates him further and equates his actions with those of the Pakistani army. There is nothing he or his government has done to fix the problem. "It a matter of concern that freedom of expression and speech is once again being misused by anti-India elements based in Canada and elsewhere," India's Official Spokesperson Arindam Bagchi had said on 6 July 2023. "...the issue is not about freedom of expression, but its misuse for advocating violence, for propagating separatism and for legitimizing terrorism."

Like the attacks on the Indian High Commission in London, those in Canada, Bagchi said, will be judged by "what happens on the ground. In the name of freedom of expression, we should not be giving space to those who advocate violence or, as I said, propagate separatism or legitimise terrorism." In the United States, for instance, the

> Until now, sovereign support to terrorism seemed to be a monopoly of Pakistan and its most high-profile export to the world. Now, unfortunately, Canada is catching up. A wealthy G7 nation, with a per capita income of US\$55,000, appears to be following the terror-support and terror-export playbook of its Pakistani counterparts. Terror factories in both nations are led by religious fanatics, whose actions tar their entire communities, when most just want to get by. And both are protected by sovereign leaders and institutions—the army and the governments in Islamabad, and the Trudeau government in Ottawa. But as Pakistan is realising—and Canada will soon—terrorists need to create terror and it is only a matter of time before they turn against their patrons.

The Ottawa-Islamabad terrorhyphenation is complete.

As far as India goes, there are five things it must do. First, it must initiate FATF (Financial Action Task Force) proceedings against Canadian terror financing routes. Second, it must tighten the vigil on OCI (Overseas Citizen of India) status granted to Indian Canadians; this is a privilege, not an entitlement. Third, it must issue travel advisories to citizens of India wanting to travel to Canada and restrict who enters India from Canada. Fourth, at some stage, a diplomatic downgrade might need to be considered. ## Old Parliament House: Indian What the demand for an OBC Democracy's tryst with destiny

t was supposed to be simple. Edwin Lufriends and colleagues for as long as either man could remember, but it seemed as though their new brief in India was going to be the straw that broke the back of that bond. They had been given the opportunity to design the Raj's new imperial capital in

Part of that design would include 'Government House' (Rashtrapati Bhavan) and the 'two principal blocks of the Government of India Secretariats and attached buildings (North and South Block).' Neither of them could have predicted the impact of India's

constitutional reform on their friendship. The passage of the Government of India Act (1919) provided for a bicameral legislature for India. This would mean the construction of a new building, which would incorporate three chambers: the Council of States, the Chamber of Princes, and the Assembly.

Baker wanted a triangular building. Lutyens wanted a circular one.

The story of their angry fallout over the shape of what would become Parliament House is a legendary one, comfortably part of the lore of Raisina Hill today.

In its day, the arguments over its design even shook the House of Commons in London, with Edwin Montagu (then Secretary of State for India) having to hastily assure outraged members of Parliament that there was no need to worry that members going into the newly built Council Chamber would suddenly encounter "servants of the Viceroy on the stairs.'

Witness to Endless Debates and Paper-

But furious wrangling over its construction aside. Parliament House has witnessed India's history for much more than the 75 years of our independence. Reams can and have been written about its architectural splendour, but its legacy

In retrospect, in the days when the capital shifted from Calcutta to Delhi, under King tyens and Herbert Baker had been George V, one might simply dismiss Parliafrom an old capital to a new one. But it has always been more than just old wine in a new bottle.

> If anything, Parliament House has been the stage on which the steps toward not just the transfer of power, but constitutional and political reform took place.

It has borne witness to not just endless debates on sovereignty, federalism, nationalism and independence, but to the paperwork that necessarily accompanies those


From 1927 to 1947, it was the seat of the Imperial Legislative Council. Its edifice has been shaken by protests, such as the bombs thrown by Bhagat Singh and Batukeshwar Dutt in 1929. That was the first time that the

revolution entered the halls of Parliament. Red leaflets, courtesy of the Hindustan Socialist Republican Army (HSRA), rained down on the aghast members of the Central Legislative Assembly, emblazoned with the message: 'It takes a loud voice to make the

On the eve of India's independence in 1947, as the clock edged towards midnight. Jawaharlal Nehru stood before the Constituent Assembly, in the packed Central Hall, to make his famous speech about India's tryst with destiny. "A moment comes, which comes but rarely in history," Nehru told the nation, "when we step out from the old to new, when an age ends, and when the soul of a nation, long suppressed, finds utterance...

Parliament House was the backdrop for the poignant moment when India stood, finally free of the shackles of colonialism. Over the next few decades, it would be the stage for other significant milestones.

It has, for instance, borne witness to spir-



holds the echoes of humour, anger, indignation and sorrow of India's leaders through the decades. It is here that the Constitution – that rulebook of the modern state – was ment House as representing a transition drafted and signed into existence. Over the years, Parliament's halls had to adjust to make room for the growing pains of a new

> The Chamber of Princes, for instance, was made available to the Federal Court of India (which preceded the Supreme Court) for use as a courtroom when the chamber

was not in session. After independence, the chamber was used by the Supreme Court of India – which sat in Parliament from 1950 to 1958. After the first general elections in 1951-52, the chamber was remodelled, and its floor area increased to provide accommodation for 450 new members of Parliament.

The True Legacy of the Old Parliament As the strength of the Lok Sabha grew, so too did the requirement for space, often forcing some hapless MPs to sit behind the pillars in the hall. It was here, in Parliament, that India's leaders debated the Constitution. war and foreign policy, the reorganisation of the states, the choice of a national language, communal riots and famine, border disputes and social justice, the Emergency, the censorship of the press and terrorism.

These, then, were the foundation stones of modern politics and geopolitics. All of these were laid within the walls of the circular building that Edwin Lutyens had so triumphantly designed, the same one that hurt Herbert Baker's aesthetic sensibilities.

Today, the building has been renamed Samvidhan Sabha (Constitution House). Reports suggest that it will function as a 'Museum of Democracy.'

But in truth, Parliament House can never be relegated to being a relic of the past. Its legacy, as I wrote in the beginning, is hard to quantify. That is not simply because of the sheer scale and scope of the history to which it has played host, but because the values which birthed this country are difficult to commodify.

In his last speech from the old building on Tuesday, before he led members of Parliament into the new building, Prime Minister Narendra Modi acknowledged as much, stating that "the glory of this house (the old Parliament building) should never decline."

In 1947, Jawaharlal Nehru told the country, "And so, we have to labour and to work, and work hard, to give reality to our dreams. Those dreams are for India, but they are also for the world."

In 2023, Parliament House stands as a permanent reminder: that power must be cautioned, questioned and debated. After all, its walls have housed the voices of the people, of the citizens of this country for 96 years. For those reasons, the true legacy of the old Parliament House will always be democracy's tryst with destiny. (Courtesy: The Quint)

# sub-quota means for the BJP and for the Opposition

The introduction of the women's reservation bill in parliament on Tuesday has brought to the fore long-standing contestations over demands for a sub-quota for women belonging to the Other Backward Classes. These demands for an Other Backward Classes sub-quota within the women's reservation, partly why previous attempts at passing the legislation failed, have been mainly pushed by OBC-led, Mandal-era political parties from the Hindi belt. The proposed law not providing for such a sub-quota creates a tricky situation for the ruling Bharatiya Janata Party, which has benefitted greatly from the Other Backward Class votes in the region.

What does the new bill say about the OBC sub-quota?

A constitutional amendment bill to provide for a total one-third of seats in the Lok Sabha and state legislative assemblies to be reserved for women was introduced in Parliament on Tuesday by the Narendra Modi government. Over the past 27 years, various versions of the bill aimed at promoting greater participation of women as legislators at the state and national level have failed to pass in Parliament.

This proposed reservation, for a 15year period, will take effect following the next delimitation exercise to redraw boundaries of constituencies. The next delimitation will be carried out following the first census after 2026 is published. Seats earmarked for women will rotate after each subsequent delimitation, the bill says. It also provides for

one-third of the seats already reserved for Scheduled Castes and Scheduled Tribes to be reserved for women. However, it excludes a sub-quota for women from the Other Backward Classes.

What is the Opposition's stance on

While supporting the bill in principle, some Opposition parties have demanded carving out a quota specifically for women belonging to the Other Backward Classes within the seats being reserved for women. Unlike the auota for Scheduled Castes and Scheduled Tribes, the Constitution currently does not provide for reservation specifically for the Other Backward Classes in the Lok Sabha and state assemblies.

This demand is not new and was part of the reason why previous attempts to pass the legislation failed. The United Progressive Alliance government's 2010 bill was blocked in the Lok Sabha by Other Backward Classes-led parties such as the Samajwadi Party and the Rashtriya Janata Dal over their demands for the sub-quota for Other Backward Classes as well as Muslims. Besides social justice for women from

Other Backward Classes, these demands also stemmed from the view the women's quota will get appropriated by upper caste women. Hearing these grievances, at least two parliamentary committees, in 1996 and 2009, had recommended that the government should consider a quota for women from the Other Backward Classes within the women's quota.

The two parties, along with the Janata Dal (United) and the Bahujan Samaj Party, have reiterated these de-

mands now. "Women's reservation should be a balance of gender justice and social justice," Samajwadi Party leader Akhilesh Yadav said on social media on Tuesday.

"In this, reservation for backward, Dalit, minority, tribal ... women should be clear in definite percentage form.' Congress, which brought the previous women's reservation bill in 2010 that also did not provide an OBC sub-quota, has now backed these demands. "We're happy regarding the passing of the bill, but we're also concerned," Congress leader Sonia Gandhi said in Lok Sabha on Wednesday. "[Congress] demands that the bill be implemented with immediate effect, but caste census should also be done and arrangement for reservation of SC, ST and OBC women should be made?

What do these demands mean for the Opposition politically?

These demands by some of the Opposition parties are now in line with their calls for a caste census and usage of the social justice narrative to corner the BJP in the 2024 general election. To this end, the Samajwadi Party has sought to project the BJP as being against Other Backward Classes. "We know that this government is anti-OBC and that's why there's no point in agitating for a quota for the OBC," The Hindu quoted Rajya Sabha member Javed Ali Khan of the Samajwadi Party as saying. "We're hopeful when a pro-OBC government is elected, we can suitably amend the [women's reserva-

tion] bill.' What does this mean for BJP's pol-

These sub-quota demands have put the BJP, which had supported the 2010 bill too, in a delicate situation this time. It is Other Backward Classes-led parties mainly from the Hindi belt that have been making these demands. The BJP is now a dominant political force in this region, having managed to stitch a broader social coalition of voters that include sections of the Other Backward Classes, especially in Uttar Pradesh. The region contributes a large number

of Lok Sabha seats. Consequently, voices within the BJP have raised concerns. DUBAI, Sept 21: Iran's parliament has approved a bill to impose heavier penalties on women who refuse to wear the mandatory Islamic headscarf in public and those

who support them. The move came just days after the anniversary of the death of Mahsa Amini, a 22-year-old woman who had been detained by the morality police for violating the country's dress code. Her death in custody ignited months of protests in which many called for the overthrow of Iran's theocracy.

The bill also extends punishments to business owners who serve women not wearing the mandatory headscarf, known as hijab, and activists who organise against it. Violators could face up to 10 years in prison if the offence occurs in an organised way.

The bill, which was approved by 152 lawmakers in Iran's 290-seat parliament on Wednesday, requires ratification by the Guardian Council, a clerical body that serves as constitutional watchdog. It would take effect for a preliminary period of three years. The demonstrations sparked by Amini's death on Sep-

tember 16, 2022, faded early this year following a heavy crackdown on dissent in which more than 500 protesters were killed and over 22,000 detained.

But many women continued to flaunt the rules on wearing hijab, prompting a new campaign to enforce them over the summer. Iran's clerical rulers view the hijab law as a key pillar of the Islamic Republic and blamed the protests on Western nations, without providing ev-

The protesters said they were motivated by anger over the dress code as well as what they see as the corruption and poor governance of the country's ruling clerics.

In a separate incident on Wednesday, a gunman shot a cleric to death in the northern Iranian town of Sejas. Police detained the assailant, and authorities said the motive was a personal dispute, according to the semiofficial Fars and Tasnim news agencies.

Several clerics were attacked at the height of the protests. An armed guard at a bank shot and killed a senior Shiite cleric in

### UK PM Rishi Sunak defends shift in climate policy as 'realistic' approach

LONDON, Sept 21: British Prime Minister Rishi Sunak on Thursday defended his shift in climate action policy as a "pragmatic and realistic approach" towards delivering the country's Net Zero target, amid criticism over proposed delays in certain measures. A day after his speech set out a pushback of petrol and diesel car ban and other cost-intensive measures to reduce the country's carbon emissions, Sunak fought back suggestions that he was filtering down the UK's climate commitments.

Amid criticism from within his own party and also from Opposition and industry, he stressed that his updated approach was designed to protect "hard-pressed British families" from "unacceptable costs". "We're very confident – being in government, with all the information at our disposal - that we are on track to hit all our targets," Sunak told the

"We're absolutely not slowing down efforts to combat climate change. I'm very proud of our country's leadership. We've decarbonised faster than any other major economy in the G7 – not a fact you hear reported that often," he said. "For those who disagree with me – and there are plenty of people as we can see over the last day or two, lots of people who disagree with me – the question is for them, they should explain to the country why they think it's right that ordinary families up and down the country should have to fork out GBP 5,000, GBP 10,000, GBP 15,000 to make the transition earlier than is necessary," he added.

As a year approaches since the 43-year-old Conservative Party leader took the top job at 10 Downing Street following political turmoil, his latest intervention is widely seen as a voter pitch for the next general election – expected in a year's time. It comes just before the annual party conference season kicks off early next month when all the major parties will set out their stalls for an upcoming election campaign.

"The first year I've had this job, I've brought stability and competence into government, our country, and our economy, which was necessary and important. But what I want to do now is, in a series of decisions, change the direction of our country," Sunak told the BBC. "And I believe that, if we want to do that, we have to change the way we do politics. You can't chase the short-term headline. You've got to do the things that are right in the long term. That's not going to be easy. I know I'll get criticism and flak for it, as you've seen over the last day or two. But I'm not going to be deterred from doing what I think is right for the long-term future of our children," he insisted. Meanwhile, the criticism he referred to has continued to flow from the Opposition benches, with Labour branding Sunak "rattled, chaotic and out of his depth" on the

Within Sunak's own ranks, Britain's Indian-origin Tory MP and president of the COP26 Summit in Glasgow in November 2021 warned against the "chopping and changing" of climate policies. "Concerned about the fracturing of UK political consensus on climate action. Chopping and changing policies create uncertainty for businesses and the public. Ultimately this makes it more difficult to attract investment and pushes up costs for consumers," tweeted Sir Alok Sharma, knighted in King Charles III's New Year Honours list "for his contribution to combatting climate change through his leadership at COP26".

"The UK has led the world on Net Zero, climate action and tackling climate change at COP26. Our international partners have concerns about the stance taken today. Leading on a green growth agenda is good

## Russia strikes cities from east to west Ukraine, starting fires and killing at least 2

**KYIV, Sept 21:** Russian missiles pounded cities across Ukraine on early Thursday morning, according to Ukrainian authorities, starting fires, killing at least two people and trapping others under rubble

The early morning missile attack was Russia's largest in over a month, and came a day after reports of sabotage at a Russian military airfield in Chkalovsk near

It also coincided with the United Nations General Assembly summit in New York, where Ukrainian President Volodymyr Zelensky delivered a speech and presented a Ukrainian "peace formula," and came on the International Day of Peace.

The same day, Poland said it would stop transferring its own weapons to Ukraine as it works to modernise its own military.

Polish Prime Minister Mateusz Morawiecki said the decision was not related to a temporary ban on Ukrainian grain imports, nor would it affect weapons transfers

A dispute about whether Ukrainian grain should be allowed to enter the domestic markets of Poland and other European Union countries has pushed the tight relationship between Kyiv and Warsaw to its lowest point since Russia invaded Ukraine last year.

"We are no longer transferring any weapons to Ukraine because now we will arm ourselves with the most modern weapons," he said in an interview on the private TV broadcaster Polsat News late Wednesday.

Morawiecki stressed that Poland would defend its economic interests but added that the dispute over grain imports would not hurt Ukraine's security. He said a NATO and US hub in the Polish city of Rzeszow used for transporting weapons into Ukraine would not be affected.

"We are not going to risk the security of Ukraine," he said. Poland has transferred large amounts of its older weapons to Ukraine and has been upgrading its own inven-

## Zelenskyy returns to Washington to face growing dissent among Republicans to US spending for Ukraine

WASHINGTON, Sept 21: Ukrainian Volodymyr Zelenskyy returns to Washington on Thursday for a whirlwind one-day visit, this time to face the Republicans now questioning the flow of American dollars that for 19 months has kept his troops in the fight against Russian

Zelenskyy will meet with President Joe Biden at the White House, speak with U.S. military leaders at the Pentagon and stop at Capitol Hill to talk privately with Republican and Democratic leaders of the House and Senate as the world is watching Western support for Kyiv.

It is Zelenskyy's second visit to Washington since Russia invaded Ukraine in February 2022 and comes as Biden's request to Congress for an additional \$24 billion for Ukraine's military and humanitarian needs is hanging in the balance. National Security Council spokesman John Kirby called the Ukrainian president "our best messenger" in persuading U.S. law-



makers to keep vital U.S. money and weapons coming.

"It's really important for members of Congress to be able to hear directly from the president about what he's facing in this counteroffensive," Kirby told reporters on Wednesday, "and how he's achieving his goals, and what he needs to continue to achieve those goals.'

Biden has called on world leaders to stand strong with Ukraine, even as he faces domestic political divisions at

A hard-right flank of Republicans, led by former President Donald Trump, Biden's chief rival in the 2024 race for the White House, is increasingly opposed to sending more money overseas.

As the White House worked to shore up support for Ukraine before Zelenskyy's visit, Secretary of State Antony Blinken and top intelligence officials briefed senior lawmakers behind closed doors Wednesday to argue the case. But some Senate Republicans walked out of the briefing no more convinced than before about the necessity of spending more on Ukraine. 'It's not close to the end," Sen. Josh Hawley, a Missouri Republican, said, "What we're basically told is, 'Buckle up and get out your checkbook.

Since the start of the war,

supported approving four rounds of aid to Ukraine, totaling about \$113 billion, viewing defense of the country and its democracy as an imperative, especially when it comes to containing Russian President Vladimir Putin.

Some of that money went toward replenishing U.S. military equipment sent to the frontlines. Democratic Sen. Mark Kelly of Arizona, who traveled to Kyiv this week, said cutting off U.S. aid during the Ukrainians' counterofwould

"catastrophic" to their efforts. "That would clearly be the opening that Putin is looking for," Kelly said Wednesday. "They cannot be successful without our support."

The political environment has shifted markedly since Zelenskyy addressed Congress last December on his first trip out of Ukraine since the war began. He was met with rapturous applause for his country's bravery and surprisingly strong showing in the war.

#### Under pressure over border, Biden administration to protect hundreds of thousands of Venezuelans



WASHINGTON, Sept 21: The Biden administration said that it was granting temporary legal status to hundreds of thousands of Venezuelans who are already in the country — quickly making them eligible to work - as it grapples with growing numbers of people fleeing the South American country and elsewhere to arrive at the US border with Mexico.

The move — along with promises to accelerate work permits for many migrants — may appease Democratic leaders who have pressured the White House to do more to aid asylum-seekers, while also providing grist for Republicans who say the president has been too lax on immigration.

The Homeland Security Department plans to grant Temporary Protected Status to an estimated 4,72,000 Venezuelans who arrived in the country as of July 31, 2023, making it easier for them to get authorisation to work in the US. That's been a key demand of Democratic mayors and governors who are struggling to care for an increased number of migrants in their care.

That's in addition to about 2,42,700 Venezuelans who already qualified for temporary status before Wednesday's announcement. Homeland Security Secretary Alejandro Mayorkas granted the expansion and an 18-month extension for those who already have temporary status due to "Venezuela's increased instability and lack of safety due to the enduring humanitarian, security, political, and environmental conditions", the department said in a statement.

The administration said that it would accelerate work authorisations for people who have arrived in the country since January through a mobile app for appointments at land crossings with Mexico, called CBP One, or through parole granted to Cubans, Haitians, Nicaraguans and Venezuelans who have financial sponsors and arrive at an airport. It will aim to give them work permits within 30 days, compared to about 90 days currently.

The promise of accelerated work permits does not apply to people who cross the border illegally and seek asylum, who, by law, must wait for six months to receive work permits. Mayors and governors have been clamouring for President Joe Biden to figure out a way for the administration to get newly arrived migrants to

be able to work legally, so they can support themselves. Democratic officials in New York, Massachusetts, Chicago and elsewhere have complained about the strain that newly arrived migrants are putting on their resources, especially in New York where the government is required to provide housing for anyone who

## Nepal PM Prachanda to meet Prez Xi during 8-day visit to China from tomorrow

KATHMANDU, Sept 21: Nepal Prime Minister Pushpa Kamal Dahal "Prachanda" will be on an 8-day visit to China from September 23 for talks with the Chinese leadership, including President Xi Jinping, on ways to further bolster bilateral ties between the two neighbours

Prachanda will also attend the opening ceremony of the 19th Asian Games in the eastern Chinese city of Hangzhou, Nepal's Foreign Ministry said. Prachanda, who along with the country's Foreign Minister Narayan Prakash Saud is currently in the US to attend the 78th session of the United Nations General Assembly, will directly fly to China on

September 23rd for the official visit. Prime Minister Prachanda is paying an official visit to China from September 23 to 30 at the invitation of Li Qiang, Premier of the State Council of the People's Republic of China," said the state-

Prachanda's delegation to China will also include several Nepal government cabinet ministers, including Foreign Minister Saud, Minister for Water Supply Mahindra Raya Yadav, Minister for Physical Infrastructure and Transport Prakash Jwala among others and the National Security Advisor Shanker Das

"During his visit to China, Prime Minister Prachanda is scheduled to meet with Xi Jinping in Hangzhou. He will hold a bilateral meeting with his counterpart Premier Li Qiang, and also meet with Zhao Leji, Chairman of the Standing Committee of the National People's Congress in Beijing," said the statement.

ISLAMABAD, Sept 21: Pakistan's election commission on Thursday announced that the general elections in the country will take place in the last week of January 2024, amid mounting pressure from political parties that pressed for timely elections in the cash-strapped country.

In a statement, the electoral body said that it reviewed work on delimiting constituencies and the initial list for the delimitation of constituencies would be published on September 27. It said parties would be able to file objections after that the ECP would address all objections and

After hearing objections and suggestions regarding the list, the final list would be issued on November 30, which would be followed by the election schedule, it

It said that by the end of delimitation, it would announce a 54-day election program and "polls will be held in the last week of January 2024." The National Assembly was dissolved on August 9 and



constitutionally, the elections should be held within 90 days but the process was delayed by the ECP due to the delimitation exercise which became mandatory in the wake of the new census held this year.

The previous government just days before the end of its term endorsed the results of the census which obligated the ECP to set up a new electoral district on the basis of the latest population. The move led to fears that the polls meant to be held within 90 days may be delayed till next year as the delimitation process would take about four months to complete.

The decision to shorten the timeframe of the delimitation comes amid mounting pressure on the ECP from several political parties that pressed for timely elections. The Constitution also provides that the ECP should complete the delimitation process within 120 days. Currently, a caretaker government is running the country and it will continue until the new prime

minister is elected through the elections. Caretaker Prime Minister Anwaar-ul-Haq Kakar has said the interim government is committed to upholding the democratic process in Pakistan by holding general elections and it will not make any excuse to delay it.

In a letter to the ECP chief earlier this month, President Arif Alvi, who was a founding member of jailed former prime minister Imran Khan's Pakistan Tehreeke-Insaf party, unilaterally proposed November 6 as the day for the polls, but the top election body avoided comment on his suggestion. (PTI)

PARIS, Sept 21: King Charles III praised France and the United Kingdom's "indispensable relationship" and its capacity to meet the world's challenges, including the war in Ukraine and climate change, in an address on Thursday to French lawmakers.

On the second day of his state visit to France, Charles also met with sports groups in the northern suburbs of Paris and was scheduled to pay a visit to fire-damaged Notre-Dame cathedral. The king received a warm

welcome from French lawmakers from both the upper and lower houses of parliament gathered at the Senate, who stood and applauded him at length. The partnership between the two nations "remains absolutely vital as

together we confront the challenges of this world," he said. "The United Kingdom will be one of France's closest allies and best friends.' "Our determination and

our alliance are more important than ever" in response to Russia's invasion of Ukraine. he added. "Together, we are unwavering in our determination that Ukraine will triumph and that our cherished freedom will prevail." Charles offered to adapt

the Franco-British "Entente Cordiale," a 1904 series of agreements that settled former disputes and significantly improved relations, into an "entente for sustainability to respond more effectively to the global climate and biodiversity emergency.'

"There's no challenge we

can't meet, as we have so often done in the past," he said. Charles and Oueen Camilla then headed to Saint-Denis, north of Paris, to meet community sports groups and stars as France currently hosts the Rugby

World Cup.

Saint-Denis, a multicultural, working-class suburb, will serve as a major venue in next year's Olympics. It is also home to the basilica that houses the tombs of French kings. Charles and Camilla's trip started with a ceremony at Arc de Triomphe in Paris and a state dinner at the Palace of Versailles on Wednesday.

On Thursday afternoon, Charles will visit the Paris flower market named after his late mother, Queen Elizabeth II and rejoin Macron in front of Notre-Dame Cathedral to see the ongoing renovation work aimed at reopening the monument by the end of next year, after it was devastated by a fire in

"I look forward to visiting that magnificent cathedral .. to see how centuries-old crafts have been revived and passed onto apprentices who are helping to restore Notre-Dame to its former glory," he said in Versailles.

Charles and Macron will also attend a reception for British and French business leaders about financing climate-related and biodiversity projects.

The king will end his trip on Friday with a stop in Bordeaux, the southwestern city that is home to a large British community. (AP)

Talking about corruption, he reiterated his warning, especially to government employees, to refrain from any form of corruption or face action. He regretted that despite repeated warnings and government's best intentions, the incident of paper leakage occurred in one of the recruitment examinations held by the Arunachal Pradesh Public Service Commission (APPSC), in recent

"That is why we need to apply our mind. Only after seeing the UCC Bill, we will take a stand as a government," he added.

## Mobs try to storm police stations over arrest of 5 youths, curfew reimposed

**IMPHAL, Sept 21:** More than 10 people were injured when Manipur security forces fired tear gas shells on protesters for trying to storm police stations and court arrest demanding the unconditional release of the five arrested youths on

As a precautionary measure, the state government cancelled curfew relaxations in the twin districts of Imphal from 5pm, officials said. Responding to a call by six local clubs and Meira Paibis demanding the release of the five village volunteers, hundreds of protesters holding placards and shouting slogans tried to enter the Porompat police station in Imphal East and Singjamei police station and Kwakeithel police outpost in Imphal West district.

However, police and RAF personnel deployed at strategic positions fired several rounds of tear gas shells to disperse the crowd.

A protester, identified as Th Bimola at Porompat said, "We were left with no option but to court arrest as the government failed to release the five village volunteers. If such village volunteers are arrested, who will protect the Meitei villages in the periphery of the hills and the valley Kuki Zo militants."

Similar attempts to enter Mayang Imphal police station in Imphal West district and Andro police station in Imphal East district All Langthabal Kendra United

Clubs Coordinating Committee president Yumnam Hitler said. "The decision to launch the 'voluntary mass arrest' agitation was taken after the government took no steps to release the five arrested youths.

On September 16, Manipur Police had arrested five persons for carrying sophisticated weapons and donning camouflage uniforms. In a statement, police said the five had been produced before the judicial magistrate and remanded to police custody

In the evening, the state government cancelled curfew relaxation in the twin districts of Imphal in the wake of the violence.

# Canada-based gangster Sukhdul Singh killed in Winnipeg

CHANDIGARH/NEW DELHI, Sept 21: Gangster Sukhdul Singh alias Sukha Duneke, one of Punjab's most wanted criminals, was killed in the Canadian city of Winnipeg by unidentified people, sources said on Thursday.

"It is believed to be the result of inter-gang rivalry," a source said.

The killing of the Canada-based gangster, who had at least 18 cases against him including those for murder, attempt to murder and robbery, took place on Wednesday night Canada time, the sources said.

The development comes at a time when India and Canada are embroiled in a diplomatic row over the killing of Khalistani separatist leader Hardeep Singh Nijjar in British Columbia in June. Canadian Prime Minister Justin Trudeau has alleged the "potential" involvement of Indian agents in the killing of Nijjar.

Hailing from Duneke Kalan village in Punjab's Moga district, the gangster fled to Canada in December 2017, official sources said.

An active member of the Davinder Bambiha gang, Duneke was



closely associated with Canadabased gangster-turned-terrorist Arsh Dalla, gangster Lucky Patial, Malaysia-based gangster Jackpal Singh alias Lali and other criminals.

The dreaded gangster was managing the activities of the gang from foreign soil and was also involved in running an extortion racket, targeted

aging the network of his foreignbased associates, the sources said. In the last few months, the number of extortion calls made by Duneke had increased considerably in Punjab and neighbouring areas,

In January, two of Duneke's associates -- Kulwinder Singh alias Kinda and Paramjeet Singh Pamma -- were arrested by the counter-intelligence wing (Bathinda) and three pistols and cartridges seized from their possession.

The two men were part of the extortion racket run by Duneke.

After his father died in 1990, Duneke got a peon's job at the Moga deputy commissioner's office on compassionate ground. During the eight years he continued with the job, he became addicted to drugs, the sources said. A lookout circular was issued against Duneke in 2022.

His name had also figured in connection with the killing of international kabaddi player Sandeep Nangal Ambian in March last year. He was accused of arranging the shooters for the killing

Duneke's name also cropped up following the killing of two rival gang members -- Manpreet Singh and Vicky Singh -- by the shooters of the Bambiha gang in January

#### Cutting across party lines, Rajya Sabha MPs support women's reservation bill

NEW DELHI, Sept 21: Cutting across party lines, Rajya Sabha members on Thursday supported the bill to provide 33 per cent reservation for women in the Lower House of Parliament and state assemblies, even as some opposition members termed it an election gimmick.

During the debate in the Upper House on the 128th Constitution Amendment Bill that seeks to reserve a third of seats in the Lok Sabha and state assemblies for women, members also highlighted the need to accelerate the

process instead of waiting for a fresh census and delimitation exercise.

Taking part in the discussion, Elamaram Kareem of CPI(M), while supporting the bill, said the BJP had promised to bring the women's reservation bill in 2014 and in 2019 as well but did not take any action. He held the ruling party responsible for women's reservation losing nine years.

This is an election gimmick by the BJP after losing elections in Karnataka and Himachal Pradesh, besides facing defeat in the civic polls in Delhi polls, he

Citing violence against women in strife-torn Manipur and allegations of sexual harassment by women wrestlers, Kareem alleged the government cared little for

Ram Nath Thakur of the JD(U) questioned the timing of bringing the 'Nari Shakti Vandan Adhiniyam'.

Bharat Rashtra Samithi (BRS) MP K Keshava Rao stressed the need to accelerate the process for women's reservation and said the 2011 Census could be taken as the benchmark. He urged immediate appointment of the delimitation commission. MDMK's Vaiko also echoed similar

Saroj Pandey of the BJP said it was unfortunate that questions have been raised on the timing and the intent of bringing the bill. As the country celebrates 'Amrit Kaal', this was the ideal moment for such a legislation, she said.

Asom Gana Parishad MP Birendra Prasad Baishya noted that the women's reservation bill has come at a "proper time" after failed attempts in the past.

JD(S) leader H D Devegowda also supported the bill and recollected steps taken by him for women's reservation while he was the chief minister of Karnataka and also the prime minister.

Manoj Jha of the RJD said demanded that the women's reservation bill be referred to a select committee to consider extending similar benefits to Other Backward Classes.

V Vijayasai Reddy (YSRCP) also supported the bill and said the reservation for women must also be extended to Rajya Sabha and state legislative councils

KC Venugopal of the Congress sought immediate implementation of the legislation. He also sought reservation for the OBC women under the bill.

Venugopal claimed the Narendra Modi government did not make any effort to bring the bill in the last nine years and it is due to the political calculations that the government has brought the legislation now. "Life-transforming legislations should come from the heart and not from the head," he said in the Upper House

Rajani Ashokrao Patil of the Congress and Mausam Noor of the TMC also supported the bill.

Sulata Deo of the BJD, Subhas Chandra Bose Pilli of the YSRCP, Ravichandra Vaddiraju of the BRS and K Ravindra Kumar of the TDP also participated in the discussion. (PTI)

## Karnataka CM, Dy CM meet Jal Shakti minister, say unable to release Cauvery water to TN

NEW DELHI, Sept 21: Karnataka chief minister Siddaramaiah and deputy chief minister D K Shivakumar on Thursday called on union jal shakti minister Gajendra Singh Shekhawat here and informed him of the state's inability to comply with the CWMA's order of releasing 5,000 cusecs of water per day till September 28 to Tamil Nadu, citing a drought-like situation. The meeting came in the backdrop of protests by farmers bodies against the release of Cauvery river water to Tamil

However, the Supreme Court on Thursday refused to interfere with orders of the Cauvery Water Management Authority (CWMA) and Cauvery Water Regulation Committee directing the Karnataka government to release 5,000 cusecs of water to Tamil Nadu.

During the meeting, the deputy CM also sought Prime Minister Narendra Modi's intervention to re-



meeting of four states -- Karnataka, Tamil Nadu, Kerala and Puducherry. BJP MPs, including union ministers Shobha Karanlaje, Bhagawanth Khuba and A Narayanswamy as well as state Congress ministers, were present in the meeting.

"All MPs have supported and the Jal Shakti Minister has assured justice will be given to the state. He has

the facts and they (Centre) are also waiting for the Supreme Court decision," Shivakumar told reporters after the meeting. During the meeting, the minister informed that farmers and various organisations are protesting against the release of water to the neighbouring state.

The state has lost the kharif crop and it will be a difficult situation for the rabi crops as well, he said. Shivakumar further said that the state government was able to comply with earlier orders issued by the CWMA. The latest one issued on September 18 is not possible to comply. However, the state government is releasing about 4,000 cusecs of water per day to the neighbouring state, he

"Though Tamil Nadu is aware of the distressing situation, I think they have used the opportunity to have more crops. But we don't want to intervene on that issue. We feel that Karnataka is facing a lot of problems," he added. Shivakumar informed the central minister that the state in August faced a rainfall shortage for the first time in 123 years. (PTI)

## Bombay HC grants activist Raut bail in Elgar Parishad-Maoist links case


MUMBAI, Sept 21: The Bombay High Court on Thursday granted bail to 33-year-old activist Mahesh Raut, an accused in the Elgar Parishad-Maoist links case, noting the evidence relied upon by the National Investigation Agency (NIA) against him was hearsay and not corroborated.

At the most, Raut can be said to be a member of the CPI (Maoist) but no covert or overt terrorist act has been attributed to him and NIA has placed no evidence to show that he was involved in recruiting persons to the banned outfit, said a division bench of Justices A S Gadkari and Sharmila

After the bench pronounced its order, special public prosecutor Sandesh Patil, appearing for the NIA, sought it to be stayed for two weeks. The bench staved the operation of its order for one

Raut was arrested in June 2018 and is presently in judicial custody at the Taloja prison, on the outskirts of Mumbai.

"In the present case, the incriminating material does not in any manner prima-facie leads to draw an inference that the appellant (Raut) has committed or indulged in a 'terrorist act' as contemplated under section 15 of the UAPA (Unlawful Activities Prevention Act)," the court said in its judg-



The bench added that at the most it can be said that Raut was a member of CPI (Maoist) and that this would attract only provisions of Sections 13 and 38 of the UAPA.

It added that the maximum sentences under these sections are seven years and ten years. "According to us, there is no material on record

to indicate that there are reasonable grounds for believing that the accusations against the appellant under Sections 16, 17, 18, 20 and 39 of the UAPA are prima facie true," the court said. These sections pertain to recruitment, punish-

ment for terrorist activities, conspiracy to commit terrorist activity, punishment for being a member of a terrorist group and committing an offence to support a terrorist group. The court said Raut was in pre-trial incarcera-

tion for more than five years and there are no criminal antecedents, so a case to grant bail has

The bench directed Raut to furnish a surety of ₹ 1 lakh as bail and permitted him to furnish cash bail for a period of eight weeks.

Raut shall not leave Mumbai and must seek prior permission from the special NIA court if he desires to travel outside the city, the HC said, directing the activist not to tamper with evidence.

The bench in its order noted that the allegations against Raut are that he is a member of a banned organisation, he was actively involved in recruiting persons in the organisation and was handling and transferring funds to co-accused.

Raut had moved HC in 2022 seeking bail and challenging the order passed by the special NIA court refusing him bail. (PTI)

## **Boeing comes out with 'Aatmanirbhar Bharat'** approach for P-8I aircraft; eyes additional orders

**NEW DELHI, Sept 21:** US aerospace major Boeing on Thursday outlined its plan for enhancing engineering, manufacturing, and sustainment capabilities of the P-8I long-range maritime surveillance and anti-submarine warfare aircraft in India, eyeing an additional order of six planes.

At present, the Indian Navy has 12 P-8I aircraft. The company said it had already generated a substantial economic impact, amounting to USD 1.7 billion to support the current P-8I aircraft fleet in service with the Indian Navy.

Boeing said it envisions that increasing the P-8I fleet to 18 aircraft will increase investments, approximately USD 1.5 billion, while creating further indigenisation opportunities within India's aerospace and defence sector

"Boeing's commitment to advancing the Aatmanirbhar Bharat vision drives our dedication to the P-8I fleet," said Salil Gupte, president of Boeing India. "As we respond to the Indian Navy's need for more P-

8I aircraft, we are actively looking to enhance engineering, manufacturing, and sustainment capabilities in India. for India, and the world, benefiting both Indian and global customers," he said at a media briefing.

Since its induction in 2013, the P-8I aircraft, based on the 737 next generation platform, has become an integral part of the Indian Navy's fleet and has surpassed 40,000 flight hours with high mission readiness rates.

Boeing played a pivotal role in establishing the Ashok Roy Training Simulator Complex at INS Rajali, and the Kochi training complex, inaugurated in April this year, officials of the company said.

They said this ground-based training reduces on-aircraft training time, boosting mission proficiency and aircraft availability for the Indian Navy.

## Nari Shakti Vandan Adhiniyam gift to ISRO women scientists

NEW DELHI, Sept 21: Defence minister Rajnath Singh on Thursday said the 'Nari Shakti Vandan Adhiniyam', which will provide 33 per cent reservation for women in Lok Sabha and state assemblies, is a gift by a grateful nation to the women scientists of space agency ISRO.

Initiating a discussion in the Lok Sabha on the success of Chandrayaan-3 mission and other achievements of the nation in the space sector, Singh said that of the 424 foreign satellites launched by India so far, 389 have been launched in the last nine years of the government led by Prime Minister Narendra

He said that with the successful launch of foreign satellites, India's space sector is rapidly gaining a prominent place in the world.

"This special session of Parliament is dedicated to the 'Nari Shakti Vandan Adhiniyam'. In such a situation, I consider the bill as a gift presented by a grateful nation to the women scientists of ISRO, and along with them the entire female scientific community of India," he said amid thumping of desks by

He said the House and the nation salute, appreciate and express gratitude to the women scientists of ISRO and every Indian daughter

The defence minister emphasised that while science is crucial for the development of a nation and humanity at large, culture holds equal importance. He voiced the government's resolve to provide equal importance to both aspects.

"Science is value neutral. It can give us knowledge of nuclear power, but it is our culture which tells us whether we use that power in the form of energy for our own development or in the form of a weapon to destroy others." he said

He said it doesn't matter how much progress science makes, it will remain incomplete without culture and values.

"As Martin Luther King said: 'Science gives man knowledge, which is power. Religion gives man wisdom, which is control'. Those who say that we should get rid of our culture and adopt science, they must understand that culture and science complement each other," he said.

Singh said the sources of this success were hidden in the country's past, when there was harmony between science and faith.

He said that due to the foreign invaders, there was a halt in the progress, but now once again it is roaring



with more strength than before and are ready to touch

the sun, moon and stars. The defence minister stressed the importance of cultural security, describing it as equally important to border, space, cyber, economic, social, food, en-

ergy and environmental security. He said cultural security is necessary to maintain the identity of a nation and the government, while giving importance to Indian cultural heritage, is as serious about cultural security as it is about security

"No nation has made economic, social, political

and scientific progress without cultural renaissance,' he said, adding that to take the nation forward, it is imperative to learn from India's own culture. Singh said India's faith and culture is of inclusive

nature and its cultural nationalism teaches everyone the concept of brotherhood of all humanity.

mentary panel has observed that overcrowding in jails and delayed justice have become a pressing concern, leading to a series of consequences for both the prisoners and the criminal justice system as a whole

The Parliamentary Standing Committee on Home Affairs, headed by BJP MP Brijlal, also recommended that special attention should be given to pregnant women on the line of a judgement of the Supreme Court where it was observed that a jail must have adequate facilities for prenatal and post-natal care for female prisoners as well as their children.

"The committees, notes that the issue of overcrowding and delayed justice has become a pressing concern, leading to a series of consequences for both the prisoners

and the criminal justice system as a whole. The committee recommends that prisoners from overcrowded jails may be transferred to other jails with vacant cells in the same state or other states by signing MoUs to that effect. This kind of an arrangement can be mutual in nature between the states signing the MoU," it observed.

The panel recommended that the babies born in prison be allowed to stay with their mothers until the

#### Rajasthan min booked for grabbing granite mine, cheating

JAIPUR, Sept 21: The Rajasthan Police has booked the state's Revenue minister Ramlal Jat following accusations that he took illegal possession of a granite mine in Bhilwara district, threatening the man who claims to be rightful

The case was registered against the minister and four others earlier this week on the orders of the high court, after the local police allegedly did not act on the complaint filed with them. A day after case was filed, Kareda station house officer Om Prakash was removed from his post.

The matter is now being probed by the state CID, Asind Deputy Superintendent of Police Yogesh Sharma said.

Jat, who represents the Mandal assembly constituency in Bhilwara, faces charges under Indian Penal Code sections 406 (criminal breach of trust), 420 (cheating), 384 (extortion), 379 (theft) and 120-B (criminal conspiracy). The minister was not available for comment.

According to the FIR, complainant Parmeshwar Joshi got the site in Raghunathpura village on lease from the state's mining department in 2012. He was the director and a shareholder in the firm Aravali Granite Private Ltd along with partners Sundar Goyal and Chandrakant Shukla.

Joshi's partners had to pay ₹ 10 crore to him under the deal, according to the FIR.

They handed over ₹ 5 crore of their shareholding to Joshi and transferred the remaining share of worth ₹ 5 crore to Jat. The minister transferred the lease to his relatives and refused to pay up this amount

to Joshi. "The minister said he would not pay more than ₹ 2 crore and that too from the earnings from the mine," Joshi said in his com-



age of 12 in order to provide a nurturing environment during their early years while ensuring their well-being and development.

According to guidelines, emphasis should be given towards proper care of children relating to food, shelter, medical care, education, and physical growth, it further said. Apart from this, sports and entertainment facilities are also to be provided to these children.

The committee said transgender prisoners are to be provided the same standards of healthcare available to other inmates and should have access to necessary healthcare services without discrimination on the grounds of their gender

It observed that the overcrowding in Indian prisons has long plagued the country's criminal justice system. Despite various steps to reduce the number of inmates from jails, the total inmates in India stands at 5.54 lakh against the total prison capacity of 4.25

The national average occupancy rate in prisons across India is 130.2 per cent and the states of Uttar Pradesh, Bihar, Madhya Pradesh, Maharashtra, Punjab and Haryana together make up for more than 50 per cent of the total prisoner population in the country.

In four of these six states, the oc-

cupancy rate in prisons is more than the national average. Further, the state of Uttarakhand has reported the highest occupancy rate of 185 per cent. Delhi with the highest crime rate in the country of 1479.9 has an occupancy rate of 182 per cent.

The committee observed that the problem of overcrowding in the Indian prisons is mostly because of a very large number of undertrial prisoners. Of all the prisoners in the country, more than 50 per cent being undertrials.

According to the Prison Statistics India 2021 Report prepared by the NCRB, there are 22,918 women inmates. Out of total women prisoners, 1,650 women inmates are with 1,867 children.

The panel observed that women prisoners are more vulnerable than male prisoners. Many of them are incarcerated in common prisons because there are fewer female prisons in India.

Female prisoners are susceptible to various problems like gender discrimination, living in overcrowded jails in unhygienic conditions, custodial rape etc., The fewer number of women jails and low representation of women in prison staff further undermine their conditions and intensify their difficulties, it observed. ## Cauvery dispute: SC refuses to interfere with order asking K'taka to release 5,000 cusecs water to TN every day

NEW DELHI, Sept 21: The Supreme Court on Thursday refused to interfere with the order of the Cauvery Water Management Authority (CWMA) and the CWRC directing the Karnataka government to release 5,000 cusecs of water per day to Tamil Nadu for 15 days.

The Cauvery Water Regulation Committee (CWRC) in its September 12 order, which was upheld by CWMA, directed Karnataka to release 5,000 cusecs (cubic foot per second) of water every day for the next 15 days to Tamil Nadu.

A bench of Justices BR Gavai, PS Narasimha and Prashant Kumar Mishra said it was not inclined to entertain Tamil Nadu's plea challenging the CWMA decision on the ground that it was facing a drought-like situation due to rain deficit.

The bench noted that bodies like CWMA and CWRC, which have experts from the India Meteorological Department (IMD), and those on agriculture and water resource management, have considered all relevant aspects like drought, deficit rainfall, water level in the river and only then passed the

"We are therefore of the considered view that the factors which have been taken into consideration by both the authorities cannot be said to be irrelevant or extraneous. In that view, we are not inclined to interfere with the orders," the bench said.

It noted the two authorities are meeting every 15 days to take stock of the distress faced by both

Senior advocate Mukul Rohatgi, appearing for Tamil Nadu, submitted that the two authorities, despite having acknowledged there was deficient rainfall since August and the state was eligible for of 7,200 cusecs of water, reduced the volume to 5,000 cusecs a day.



"I am a low riparian state...water flows from Karnataka to Tamil Nadu from where it goes to Puducherry. There is a shortfall of rainfall which has been taken into consideration by the authorities. In a regular year. I would have been eligible for three times more but I am not seeking that. I am seeking what is rightfully mine," Rohatgi

He added Tamil Nadu has five lakh acres of standing crop and is facing a drinking water problem for which more water is needed.

"If the drought-like condition was taken into account and the authority calculated it to be 7,200 cusecs per day, then there was no occasion to further bring it down to 5,000 cusecs per day," he submit-

Senior advocate Shyam Divan, appearing for Karnataka, said the upper riparian state was also facing drought-like conditions, and the release of 5,000 cusecs of water ordered by the authorities is against the "interest of the state".

He insisted it should be further reduced to 3,000 cusecs per day.

He said Karnataka uses Cauvery water for drinking as well as irrigation purposes while Tamil Nadu utilises it only for irrigation. "We are facing a drinking water

crisis, especially in urban areas including in Bengaluru," he said.

The bench then asked what the Centre has to say on the dispute over water sharing.

Additional Solicitor General Aishwarya Bhati, who represented the Centre, said contrary to the claims made by the two states drought is not the only criteria which has been taken into account by CWMA before making the de-

"They have taken into account IMD data, rainfall, water level in reservoirs and other relevant data after which they have arrived at the figure of 5,000 cusecs," Bhati said, adding the CWMA order has not been defied and water is being released to Tamil Nadu

The bench then told Rohatgi the court is not inclined to entertain Tamil Nadu's petition.

On August 25, the top court had refused to pass any order on the Tamil Nadu government's plea seeking release of 24,000 cusecs of Cauvery water daily by Karnataka for irrigating the standing crops.

The apex court had sought a report from the CWMA on the amount of water released by Kar-

Rainfall has been 25 per cent lower and water inflow into Karnataka's four reservoirs 42.5 per cent lesser, an affidavit filed by the upper riparian said, adding the stipulated release shall not be applicable this year.

The Karnataka government said in the affidavit the southwest monsoon has largely failed so far during the current water year. A "distress condition" has arisen in the Cauvery basin in Karnataka, it

"Karnataka, therefore, is not obliged to and it cannot be compelled to ensure water as per the stipulated relief is prescribed for the normal year," the affidavit

A bench headed by Chief Justice of India DY Chandrachud had earlier said a fresh bench will be set up to hear the decades-old dispute between Tamil Nadu and Karnataka over sharing of the Cauvery river water. (PTI)

### Search operations continue

Movement of 182 vehicles along the National Highway-37 and 19 along the NH-2 with essential items has been ensured, the police said. "For decades, fossil fuels have been a taboo word, rarely mentioned at climate summits despite being the root cause of the chaos. Thankfully, we are now saying the 'f-word'. Sadly, because politicians refused to acknowledge the fossil-fuel elephant in the room, it has defecated on the floor, and we need to clean it up fast. That is why we need a fossil fuel phase-out date at COP28 this December," he said.

Mads Christensen, the executive director of Greenpeace International, criticized leaders from major polluting countries for disregarding the UN secretary-general's challenge to present substantive contributions to the Climate Ambition Summit

Christensen likened their reluctance to act on climate to a wealthy CEO trying to evade paying a train fare, saying, "In this time of catastrophic planetary crisis, this climate inaction by these leaders is not just disrespectful, it's fatal, cheap and must be called out.'

Alex Scott, climate diplomacy and geopolitics lead at E3G, an independent climate change think-tank, said the summit set high expectations for the COP28 Presidency in the UAE and "the laggards left behind". Adelle Thomas, a climate expert at the University of The Bahamas, called for clearer signals from financial

actors on innovative measures to address the mounting costs of loss and damage disproportionately borne by She expressed disappointment with the lack of concrete proposals during the summit on how to achieve this.

"Today's session acknowledged the growing impacts of climate change and the need to support the most vulnerable, but lacked concrete proposals on how this can be done," Thomas said. "The rich countries that have historically driven the climate crisis and are continuing to expand fossil fuels were given an opportunity by United Nations Secretary General António Guterres to demonstrate their com-

mitment to the 1.5°C global warming limit. "Instead, we saw cowardice and a staggering failure of climate leadership. The US, Canada, Australia, the UK, and Norway, responsible for a majority of planned oil and gas extraction, either arrived empty-handed or

failed to attend altogether," said Romain IOUALALEN, the Global Policy Manager of Oil Change Interna-He said, "This is a slap in the face of the more than 6,00,000 people who marched on all seven continents last weekend. A slap in the face of science; a slap in the face of the people displaced and dying from escalating

climate catastrophes." As wealthy nations shirk their responsibilities, real leadership comes from people and countries least responsibilities. sible for and most affected by the climate crisis. World leaders must finally find the courage to agree to the end of the fossil fuel era at COP28 in Dubai, before it's too late, IOUALALEN added.

Guterres' "no-nonsense summit", ahead of COP28 in Dubai, came at a time when the world is reeling from the devastating impacts of climate change and probably the hottest year on record.

"Humanity has opened the gates to hell," Guterres said during his opening remarks, warning that the world is heading for a 2.8-degree-Celsius warming in a business-as-usual scenario. Sultan Al Jaber, the president of COP28, closed the summit, saying the "phase-down of fossil fuels is inevitable; it is in fact essential". (PTI)

Rashtriya Vigyan Puraskar will be one of the highest recognitions in science, technology and innovation, to be given across four categories -- Vigyan Ratna, Vigyan Shri, Vigyan Yuva-Shanti Swarup Bhatnagar and Vigyan Team.

Scientists will be selected across 13 domains by a committee headed by principal scientific advisor to the government.

"People of Indian Origin staying abroad with exceptional contributions benefiting the Indian communities or society shall also be eligible for the awards," it said.

The Vigyan Ratna award will recognise lifetime achievements and contributions in any field of science and technology while the Vigyan Shri will acknowledge distinguished contribu-



tions. All the awards will carry a citation and a medal.

The Shanti Swarup Bhatnagar awards, given by the Council of Scientific and Industrial Research since 1958 across seven domains, will now be given across 13 categories to young scientists up to the age of 45 for exceptional contributions in any field of science and tech-

nology. The Vigyan Team award will be given to a team comprising three or more scientists/researchers/innovators who have made an exceptional contribution working in a team in any

field of science and technology. Rashtriya Vigyan Puraskar will be one of the highest recognitions in science, technology and innovation in Scientists/technologists/inno-

vators working in government, private sector organisations or any individual working outside any organisation, who have made distinguished contributions in terms of pathbreaking research or innovation or discovery in any field of science, technology or technology-led innovation shall be eligible, the statement said.

The awards will be given across disciplines such as physics, chemistry, biological sciences, mathematics & computer science, earth science, medicine, engineering sciences, agricultural science, environmental science, technology & innovation, atomic energy, space science and technology, and others.

The nominations will be invited from January 14 to February 28 every year.

The awards will be announced on National Technology Day on May 11 and conferred on National Space Day on August 23. (PTI)

#### World's largest Cedar tree found in J&K's Doda: Officials

BHADERWAH, Sept 21: A Cedar tree, having 54 feet trunk and 35 feet breast diameter, was found in Chanti Bala in the Bhalessa forest range in Jammu and Kashmir Doda district, which forest officials claim is the world's largest and perhaps the oldest Cedar tree.

The officials want the location of the Cedar tree to be declared as a heritage site, while the Panchayat Raj Institution (PRI) members demanded that the location be brought under a tourism map.

Believed to be centuries old, the mammoth tree located on the eastern hill of Gandoh tehsil's Chanti-Bala Panchayat, 124 km from Doda town, has a religious significance for Nag devotees and has been worshipped for centuries by the community.

Surrounded by a thick coniferous forest, the visibly different tree because of its gigantic size, was located by the field staff, divisional forest officer, Bhaderwah Chander Shekhar told PTI at the scene. "The Deodar, also known as cedar, has a

trunk diameter of 54 feet and 35 feet breast size, which is the scientific way of measuring the size of a tree. As per our research and the data we have collected, this is the largest tree of this species (Cedrus Deodara) in the world and seems to be the oldest one as well," he said. Shekhar said the department would refer this to the Forest Survey of India to calculate its exact age. (PTI)

NEW DELHI, Sept 21: As someone who has worked with both Shah Rukh Khan and Vijay, two of the biggest superstars in Indian cinema, filmmaker Atlee says he found the actors to be "ideologically and professionally" similar in many

Atlee is currently basking in the success of "Jawan" that marks his debut in Hindi cinema and his first collaboration with Shah Rukh. He has worked with Vijay in Tamil hits such as "Theri", "Mersal" and

The director, who turned 37 on Thursday, said both the actors wear their stardom lightly and approach every project like it's their first.

"I think both are ideologically and professionally very similar because I've worked with both of them. They're very dedicated. They take filmmaking seriously and they don't get tired... They will give their hundred percent.

"So, I had similar synergies from both. I've been with Shah Rukh sir for four years and I've been with Vijay sir for the same four years. I can see both are really dedicated and hardworking. They never take success, fame or name into their system. They work like a newcomer," Atlee told PTI in an interview.

Recalling his experience of working with Shah Rukh on "Jawan", the filmmaker said the actor surrenders to the vision of the director even after being the business for so many years.

"Shah Rukh sir, having these many audiences, these many footfalls and giving a blockbuster like 'Pathaan', even then when he comes to our set, he comes like a new-

"He's like, 'So, what should I do?' That is why they are there (at the top). That is the learning we should take from them. I think all film technicians, actors or whoever is part of cinema should really be like them. We should feel fresh, we should feel 'This is our first day'," he added.

Bangladesh did breach the defence, Dheeraj Singh saved comfortably. The Blue Tigers' lynchpin for the first half was Bryce Miranda, the winger tirelessly running at defenders and constantly making Bangladeshi players secondguess their options.

In the 40th minute, his corner landed perfectly for Chinglenblocked. Despite having possession, India had not registered a single shot on target when injury time struck in the first half.

The ITF had agreed to shift the tie to a neutral venue in 2019 but it will be very tough for AITA to convince the world governing body if the national federation pushes for a neutral venue.

Pakistan's veteran player Aqeel Khan told PTI that they are hoping for the Indian team to travel to their nation.

"I hope they come and give us a chance to host," Aqeel, 43, said. Pakistan last week beat Indonesia 4-0 at home in the World Group II tie, played on grass courts in Islamabad with Aqeel winning a singles and the doubles said. (PTI)

PTF President Salim Saifullah Khan said they will host India on grass court.

If they have their day, it can be a gold this time. Hopefully, I will find a company this time. "I've a huge feeling that Indian men recurve archers will do better in individual events this time. More than the team we have a better chance in individual and teams like Korea, Japan, China, Malaysia and Indonesia are going to be strong medal contenders.

"A Games experience is totally different than a championship event -- most of the times you lose track and get lost in the crowd," Rai explained why India have fared poorly at the Asian Games.

He added, "The grandeur of the event, the location, the village, atmosphere altogether puts different kind of pressure. It slowly starts affecting your form, unless you are used to it.'

Set for his third successive Asian Games, two-time Olympian Das has a wealth of experience, while Rai's Army "junior" Dhiraj is in the midst of a breakout season.

In his first full competitive season as a senior, the 22-year-old Dhiraj has won one silver, three bronze medals including one in individual section at the World Cup that earned him a World Cup Final berth. He impressed in his maiden World Cup Final where he shocked two-time Olympic gold medallist Kim Woo-jin of Korea, before ending a creditable fourth. (PTI)

# Iyer to prove his fitness, Surya his worth during WC dress rehearsal

MOHALI, Sept 21: Shreyas Iyer's dodgy match-fitness will be put to ultimate test while Suryakumar Yadav's desperation to alter a dismal ODI record adds a fascinating sub-text to India's three-game series against Australia, which also serves as final dress rehearsal before the World Cup, beginning next month.

With pillars of Indian batting – skipper Rohit Sharma and the brilliant Virat Kohli -- resting for the first two games along with lead spinner Kuldeep Yadav and premier all-rounder Hardik Pandya, it will be head coach Rahul Dravid's final chance to assess his bench strength.

The two Mumbai batters – both very different players from each other -- are fighting their own little battles to be a part of the most important tournament of their lives.

The 28-year-old Iyer hasn't played much cricket in last six months due to stress fracture surgery. A stiff back just before an Asia Cup match against Pakistan raised questions about his fitness.

As chairman of selectors Ajit Agarkar has said that Iyer is good to go in the three games but whether his body is holding for 100 overs during the three games over next five days, will be observed keenly. As much as Ishan Kishan has done his bit, India will need Iyer, the proverbial slayer of spin bowling in the middle overs during the World Cup.

For Surya, literally 'SKY' has been the limit in T20Is but before anything else, he perhaps need an uncluttered mind about what kind of role is he looking at in ODI cricket.

In today's day and age, 27 ODIs are a lot and less than 25 average is neither a true reflection of his talent nor his capabilities.

Surya won't be a starter in playing XI during tyhe World Cup but for his own good, he would want the team management to be assured that they didn't make a wrong choice. Tilak Varma is hot on his heels and at 33, he won't practically get a shot at another 50-over World Cup.

'Ash' is name of the game
The small quadriceps tear that left-arm spinner Axar Patel suffered has opened an unlikely door for 37-year-old Ravichandran Ashwin to play his third and what could likely be his last 50 over World Cup in case the former doesn't

Even two weeks back, Ashwin was not even in Indian team management's radar and now the crafty veteran and his younger state-mate Washington Sundar are locked in a battle for an outside chance to make it to the squad.

recover in time.

If one goes by the buzz, Ashwin even if he doesn't do well in the upcoming games, is way ahead of Washington in terms of probable chance of a look-in. Ashwin's battle against David Warner and Steve Smith could be a fan's



delight.

The absence of Kuldeep Yadav and Hardik Pandya will give both Ashwin and Washington, a chance to showcase what they have to offer to the team. But, there is every possibility that even if Ashwin does brilliantly, the team management will go with Axar if he recovers on time and plays the third ODI.

Usually, a small tear takes two weeks to heal and for a spinner, it is not a serious injury unlike for fast bowlers, where it takes more time before they can go full steam. Hence India will remain hopeful about getting Axar fit before the tournament proper starts.

Team Combination
With no Rohit at the top of the order, Ishan
Kishan is likely to open with Shubman Gill
while Kohli's place is taken by Iyer, who needs

India's Asian Games-bound skipper Ruturaj Gaikwad is in the squad more as a cover and could be released after the second game as he would link up with T20 team flying to Hangzhou on September 28.

India haven't rested any of its fast bowlers but Jasprit Bumrah and Mohammed Siraj may play two of the three games as three 50-over games have been slotted in five days and it also includes travel. Workload management of two pacers will be paramount.

# The Asian Games: larger than the Olympics and with an array of regional and global sports

**HANGZHOU** (CHINA), Sept 21: The Asian Games are an attention grabber.

For starters, they involve more participants than the Summer Olympics. Organizers say more than 12,000 will be entered when the opening ceremony takes place Saturday in the eastern Chinese city of Hangzhou. This is more than the 10,500 expected for next year's Paris Olympics

The giant numbers are partly due to the staggering array of events with many regional specialties, sports, and games you won't find in the Olympics. And there's also cricket, which appears headed to the Olympics as soon as 2028 in Los Angeles, and certainly for 2032 in Brisbane, Australia.

And there's squash, which has tried several times for Olympic recognition.

The regional fare includes dragon boat racing, sepaktakraw — sometimes called "kick volleyball — wushu, a Chinese martial art, and kabaddi, a popular contact sport on the Indian subcontinent. There is also the non-Olympic martial

To this, add a long list of what organizers call "mind sports" from bridge to chess to xiangqi (Chinese chess) to esports.

art of ju-jitsu, and kurash, a form of wrestling popular in central Asia.

Of course, there are the old standbys seen in every Olympics like track and field, swimming, or volleyball — and the usual grandiose opening and closing ceremonies. Nine sports will offer qualification spots for the Olympics — archery, artistic swimming, boxing, breaking, hockey, modern pentathlon, sailing, tennis, and water polo.

However, most of the 481 events offer a chance for smaller delegations to win medals, which is often impossible at the Olympics.

China won almost 300 overall medals at the last Asian Games in Indonesia in 2018. At the bottom of the table, Syria and Nepal won a lone medal each. Bhutan and Bangladesh were among nine delegations that didn't win any.

China will dominate the medal table as it has for the last 40 years, followed by Japan and South Korea — Asia's other powers. The vast region stretches from Lebanon on the Mediterranean, through central Asia and the Indian subcontinent, to North Korea with organizers saying 45 nations or territories are entered.

Organizers have said 191 participants from North Korea will be on hand. North Korea closed it border early in 2020 after the COVID-19 pandemic and skipped the Tokyo Olympics, which were delayed a year until 2021. The Asian Games were also pushed back a



year from 2022 because of the pandemic.

According to South Korea's Unification Ministry, the last time North Korean athletes appeared in an international sports competition was January 2020, when North Korea competed in the Asian Football Confederation's under-23 soccer championship.

If you like political intrigue, there may be plenty of it.

The self-governing island of Taiwan will be on hand in China, which claims the democracy as a breakaway province that it has vowed to reclaim it. Known as the Republic of China, the island is officially listed as Chinese Taipei in the Olympics and Asian Games and marches under a white flag adorned with the Olympics rings. Its red, blue and white flag is in not allowed. Taiwan, with only 23.5 million, is a relative sports power in the region and finished seventh in the overall medal standings in Indonesia.

The games also begin amid an open power struggle between International Olympic Committee President Thomas Bach and Kuwait's Sheikh Ahmad Al-Fahad Al-Sabah, a long-time IOC member who is often described as the "kingmaker" who helped Bach win the IOC presidency in Buenos Aires in 2013.

The Switzerland-based IOC openly intervened in July to invalidate the pres-

idential election of the Olympic Council

of Asia. It has also suspended Sheikh

Ahmad from the IOC.

The election was ostensibly won by
Kuwait's Sheikh Talal Fahad Al-Ahmad

Al-Sabah, the younger brother of Sheikh Ahmad. The elder sheikh is the former 30-year president of the OCA, an organization that was created by his father.


The IOC says it will continue to recognize Randhir Singh of India as interim president of the OCA until new elections are held. Bach will attend the opening ceremony in Hangzhou and is sure to have talks with Singh.

The biggest event of the games might be a possible India vs. Pakistan gold-medal game in men's cricket on Oct. 7, which would be one of the most-watched global sports events all year. It comes just as cricket's world cup is also underway.

China will again dominate diving, and several of China's top swimmers — fresh from the world championships two months ago in Fukuoka, Japan — will shine. The field in gymnastics is weakened since the world championships in Antwerp, Belgium, clash with the Asian Games.

The biggest winner at the Asian Games might be South Korea esports star Lee Sang-hyeok, who is also known as "Faker." If he wins gold he will be granted an exemption from military service.

Tottenham Hotspur soccer forward Son Heung-min also bypassed a 21-month military stint because of a government exemption when South Korea won the gold medal in soccer at the 2018 games in Indonesia — although Son still had to do three months of basic training. (AP)
