Mukroh clash: Rumi Phukan panel submits report

GUWAHATI, Sept 22: An enquiry commission formed by the Assam government to probe into a clash that claimed six lives at the Assam-Meghalaya border, has submitted its report.

The one-man commission headed by Justice (retd) Rumi Kumari Phukan submitted the report on Wednesday to the additional chief secretary of the home and political department of Assam government, sources said.

The contents and recommendations of the report on the clash, which took place on November 22 last year at the disputed Mukroh village in West Karbi Anglong district, have not been made public as yet. "The period to complete the enquiry was extended twice as



sought for till September 22 this year. The Commission examined a large number of witnesses and documents produced by the forests as well as police departments and different organizations," a press state-

Six people, including a forest guard and five villagers from Meghalaya, were killed in violence at the disputed location in the early hours of November 22 last year

after a truck allegedly laden with illegally felled timber was intercepted by Assam forest personnel. The clash took place between a joint team of Assam police-forest protection force and villagers of Mukroh in West Jaintia Hills district of Meghalaya.

The disputed area on the Assam side falls in Makoilum village near Kheroni forest range. The entire conflict area falls within a disputed border location between Assam and Meghalaya, which claimed that the killing took place in their respective territories.

On November 24 last year the Assam government had announced that it constituted the enquiry commission headed by Justice (Retd) Phukan (CONTD. ON PAGE-9)

India slams China for pre-meditated target on Arunachali sportspersons

NEW DELHI, Sept 22: India has lodged strong protests with China over its denial of accreditation for the Hangzhou Asian Games to some of the Indian sportspersons from Arunachal Pradesh, and asserted that New Delhi reserves the right to take "suitable measures" to safeguard its interests

Union external affairs ministry spokesperson Arindam Bagchi on Friday said as a mark of India's protest against China's discriminatory behaviour, Union youth affairs and sports minister Anurag Singh Thakur has cancelled his scheduled visit to China for the Games.

Describing the Chinese action as targeting of the sportspersons in a "pre-meditated" manner, Bagchi said the move violates both the spirit of the Asian Games and the rules governing their conduct as they "explicitly prohibits discrimination" against competitors from member states. He said a "strong protest" has



been lodged against China's "deliberate and selective obstruction" of some of India's sportspersons.

"The government of India has learnt that the Chinese authorities have, in a targeted and pre-meditated manner, discriminated against some of the Indian sportspersons from the state of Arunachal Pradesh by denying them accreditation and entry to the 19th Asian Games in Hangzhou, China," Bagchi said.

India has asserted that it reserves the right to take "suitable measures" to safeguard its interests.

"In line with our long-standing and consistent position, India firmly rejects differential treatment of Indian citizens on the basis of domicile or (CONTD. ON PAGE-9)

SHILLONG, Sept 22: TMC leader and former Chief Minister Mukul Sangma was served a legal notice on Friday after he "wrongly" labelled Henry Lalremsanga, the chairman of 2B's Group of Companies, as a drug

Henry's counsel K Kharmawphlang issued a legal notice to Sangma asking him to tender an unconditional apology within seven days for incorrectly labelling Lalremsanga as a 'drug kingpin'.

The notice was in response to the statements made by Mukul on September 19 and 20.

The legal notice demanded the former Chief Minister to tender an unconditional apology and retraction of the false and malicious statements within 7 days of the receipt of this notice.

It also demanded for an immediate halt to making or publishing any more false and defamatory remarks against Lalremsanga and a payment of ₹20 crore within 7 days of the receipt of this notice as compensation for injury to Lalremsanga's reputation.

"Failure to comply with the demands within the stipulated time will compel Lalremsanga to pursue both criminal and civil legal actions, holding the perpetrators accountable for their defamatory statements," the notice said. Due to the lockdown, he was at his home in Arunachal Pradesh and failed to attend the online classes due to lack of internet connectivity, resulting in the backlog, they claimed.

He had appealed to the authorities to conduct a special examination so that he could clear the backlogs, but Roy allegedly insulted him. Following this incident, he locked himself in his room and later his body was found hanging, they said.

Before the meeting, in a notice, registrar KL Baishnab appealed to the students to call off the agitation and resume classes, and also warned that, otherwise, the authority will be constrained to close the college for an indefinite period (CONTD. ON PAGE-9)

Therapeutic plant smilax turbans rediscovered in Kurung Kumey

ITANAGAR, Sept 22: The pristine forests of Arunachal Pradesh's Kurung Kumey district are now home to smilax turbansa, a long-lost plant species akin to a well known an Ayurvedic therapeu-

Botanists have recently rediscovered the smilax turbans in the forests in Kurung Kumey, 500 km away from where it was last collected 95 years ago.

The plant, an endemic species of Arunachal Pradesh, is a wild counterpart of Chopchini, also known as smilux china, a well known Ayurvedic therapeutic plant, according to a report in the website of the department of science and technology.

It was last collected in 1928 by F Kingdon-Ward and the researchers presented detailed description, illustrations, microscopic images, distribution, phenology, field and comparisons with



closely related species after the rediscovery to facilitate its identification and eventual conservation

The feat came during recent exploratory endeavours aimed at locating the wild relative of Chopchini (smilux

J P Morgan to add G-Secs to its emerging markets index from next year



NEW DELHI, Sept 22: Global financial firm J P Morgan has said that it plans to include Indian government bonds (IGBs) or government securities (G-Secs) into its benchmark Emerging Market index from next year, a move that will bring down borrowing cost for the government.

The inclusion of the IGBs will be staggered over a 10-month period from June 28, 2024 to March 31, 2025, indicating one per cent increment on its index weight.

"India's weight is expected to reach the maximum weight threshold of 10 per cent in the GBI-EM Global Diversified, and approximately 8.7 per cent in the GBI-EM Global index," J P Morgan said in a statement on Friday.

This would help attract higher foreign flows, as many overseas funds are mandated to track global indices. It will also help bring in large passive investments from overseas, as a result of which more domestic capital would be available for industry, as crowding out would be reduced. Commenting on the issue, Economic Affairs Secretary Ajay Seth said, "it is a welcome development showing confidence in the Indian Economy.'

Chief Economic Advisor V Anantha Nageswaran said "we welcome this development. JP Morgan has made this decision on their own. It attests to the confidence that financial market participants and financial markets, in general, have on India's potential and growth prospects and its macroeconomic and fiscal policies.

Just as long-term equity investors have been amply rewarded by investing in Indian markets, so will long-term investors in Indian government bonds be, Nageswaran

In her Budget speech for 2020-

21, Finance Minister Nirmala Sitharaman had said, "Certain specified categories of government securities would be opened fully for non-resident investors, apart from being available to domestic

The specified securities, which will be listed on the indices, will not have a lock-in requirement.

This was long pending and there were certain issues including with regard to taxation, which the government has ironed out in the last many months.

Some of the experts openly expressed views that the gains from inclusion of IGBs to global indices are greater than the risks.

According to Axis Mutual Fund, passive trackers of the above indices hover at around USD 250 billion and the staggered approach implies an inflow of USD 1.5 - 2billion per month in the 23 identi-

"This flow is likely to boost India's profile on the world stage and further strengthen local fundamentals. We believe the RBI could conduct sterilization operations during this inclusion period buffeting Forex reserves and the currency," it said.

"This JP Morgan index is USD 240 billion and India will be 10 per cent of it, which means USD 24 billion. This will reset the base rate for India and the yield should come down sharply. India's cost of borrowing will come down," said AUM Capital National Head-Wealth Mukesh Kochar. Since Covid, the fiscal deficit in India has remained elevated due to higher borrowing, Kochar said, adding this event will ease borrowing pressure as a large part of the borrowing will be observed by this route and banks' Treasury will be flushed with mark-to-market gains. (PTI)

Tea trade unions seek 20 pc bonus; planters ask them to reconsider demand

KOLKATA, Sept 22: Trade unions sought a 20 per cent bonus for tea garden workers in Dooars and Terai of West Bengal, while planters' bodies asked them to reconsider their demand because of financially stressed estates in the region, officials said.

A meeting between the constituent bodies of the West Bengal Consultative Committee of Plantation Associations (CCPA) and operating trade unions of tea gardens was held here on Thursday to decide on the rate of bonus for 3.5 lakh tea workers of Dooars and Terai for the 2022-23 financial

"The meeting was held in a cordial atmosphere where both sides presented their views. While the unions have demanded payment of bonus at 20 per cent, the CCPA has made a plea to them to reconsider their position in recognition of the present financially stressed condition of the tea industry," the plantation associations' committee said in a statement.

Asked about the meeting, Joint Forum of Trade Unions convenor Zia-ul-Alam said that CCPA expressed their difficulties in progressing on negotiations during

"They started from 8.33 per cent and made an offer of 8.50 per cent as the base rate across the group," Alam claimed.

Planters' bodies could not be reached for their comment.

"They asked unions for a substantial reduction from 20 per cent," said the official of the umbrella organisation of trade unions working in the tea sector.

From the very beginning of the negotiations, participating representatives of unions unitedly stood for a 20 per cent base rate with flexible considerations for the financially stressed gardens, Alam

He claimed most of the gardens in the Dooars and Terai region had "offered a 20 per cent bonus to their workers for FY22 (2021-22), and some of the estates could not pay that much because of their deteriorating financial conditions".

The meeting for bonus negotiations was adjourned, the CCPA said. It added that the next round of the meeting is scheduled to take place in the first week of October. A separate meeting for the annual bonus of workers of Darjeeling tea gardens was held recently. (PTI)

Sterlite Power acquires Beawar Transmission to develop power project in Rajasthan

NEW DELHI, Sept 22: Sterlite Power on Friday said it has acquired Beawar Transmission Ltd for developing an electricity transmission project in Rajasthan. Beawar Transmission is a Special Purpose Vehicle (SPV) of REC Power Development and Consultancy

The SPV was awarded to Sterlite Power through tariff-based competitive bidding in August, a company statement said.

"Sterlite Power announces the acquisition of Beawar Transmission Ltd from REC Power Development and Consultancy Ltd, a wholly owned subsidiary of REC Ltd," it said.

The company did not share the financial details of the acquisition.

Through the Beawar Transmission Ltd, the company will build the Green Energy Corridor project on Build, Own, Operate, Transfer (BOOT) basis, for a period of 35 years, as per the statement.

IMPHAL, Sept 22: A special court in Manipur on Friday granted bail to the five village defence volunteers who were arrested by police for possessing weapons amid an agitation for their release, offi-

They were released on bail after furnishing a PR bond of ₹ 50,000 with certain conditions, they said.

In its order, the court said the five accused "shall co-operate with the investigation", make themselves available before the investigating authorities and "not influence prosecution witnesses."

The court also directed the youths "not to leave the state of Manipur without its prior permis-

Rejecting the remand prayer of Manipur police for judicial custody, the court said, "all the accommitted any prejudicial activities against the state till the time of the arrest."

Defying curfew restrictions, hundreds of women sat in front of the Cheirap court premises in Imphal West district, where the hearing was held demanding the release of the five youths.

The state had witnessed widespread clashes between security forces and protesters on Thursday after demonstrators attempted to storm police stations as part of "court arrest agitation" over government's failure to release the five

The five were arrested by Manipur Police on September 16 for possession of weapons and donning camouflage uniforms. They were later produced before the judicial magistrate in Imphal East which remanded them to police cused persons have not yet custody till Friday. (PTI)

Situation in two Imphal districts tense but normal

IMPHAL, Sept 22: The situation on Friday in the twin districts of Imphal East and West where curfew was imposed a day before, remained tense but normal.

Curfew was imposed on Thursday after protesters stormed police stations demanding the release of five youths who had earlier been arrested for carrying sophisticated weapons and wearing camouflage uniforms similar to army fatigues.

More than 30 people, mostly women, received minor injuries after they attempted to storm police stations at Porompat and Heingang in Imphal East district and Singjamei and Kwakeithel in Imphal West district prompting secuforces including RAF personnel to fire several rounds of tear gas shells.

The Imphal East and Imphal West district authorities have, however, exempted officials of the municipality, electricity, health, PHED, media persons and flight passengers going to the airport from the purview of the curfew.

Meghalaya spent over ₹ 22 crore to 124 consultants: CM

SHILLONG, Sept 22: Meghalaya government has spent over ₹ 22.56 crore for 124 consultants appointed for different departments, chief minister Conrad K Sangma said on Friday. He was replying to a query raised by TMC MLA Miani D Shira in the Assembly

Sangma said 59 consultants have been appointed specifically for externally aided projects (EAPs).

He said the consultants are technical experts, who are brought into the system on a task basis. They are engaged mainly for the centrally sponsored schemes (CSS) and EAPs. In both the categories, the consultants are mandated by the guidelines, he added. He said there are certain cases where the consultants are also empanelled and they can be used by different departments. Citing the Unity Mall project as an example, the chief minister said ₹ 130 crore was sanctioned for Meghalaya.

"We are among the three states in the country that have been able to do it within 6 months. This is because we were able to get expert advice,' he said adding, "The government of India and EAPs have mandated the services of the consultants which are very highly technical."

The state government has asked Airtel to give a written explanation of its lapses by Friday. The state government also sought to know "who are responsible officers for such act" and "explanation as to why appropriate legal action should not be taken against Airtel for violation of government orders." 

Khalistan movement: Unrest in Canada

anada has found itself in the midst of escalating tensions surrounding the Khalistan movement, which seeks an independent Sikh state in Punjab. Recent events have thrust this issue into the spotlight, particularly allegations of India's involvement in the assassination of prominent Sikh separatist Hardeep Singh Nijjar in British Columbia, a Canadian province on the west coast. In a speech to Canada's Parliament on Monday, Prime Minister Justin Trudeau acknowledged "credible claims" suggesting Indian agents' involvement in Nijjar's June killing. Nijjar, the chief of the 'Khalistan Tiger Force,' had been a vocal advocate for the Khalistan movement within Canada's Sikh community. India vehemently denied these accusations, further deepening the rift. The current accusations are the culmination of decades of developments that have drawn Canada into the Khalistan conflict. These tensions escalated recently when Gurpatwant Singh Pannun, the leader of the banned outfit Sikhs for Justice (SFJ), issued threats against Hindus in Canada and Indian diplomatic missions in Ottawa, Toronto, and Vancouver. Pannun's aggressive rhetoric included declarations of "Death to India" and plans for a Khalistan state referendum in Canada on October 29, 2023. Pannun, who referred to Nijjar as his 'brother,' has also alleged the involvement of the Indian High Commissioner to Canada, Sanjay Verma, in Nijjar's killing. Sikhs for Justice has repeatedly called for the expulsion of the high commissioner and some diplomats, even issuing "death threat" posters against them.

To understand Canada's involvement in the Khalistan issue, it's crucial to delve into history. During the 1900s, the first wave of Sikh migrants, primarily men, moved to Canada to work as laborers in British Columbia and in Ontario's manufacturing sector. The India-Pakistan Partition in 1947 played a significant role in encouraging Sikhs from Punjab to leave their homeland. Canada's appeal stemmed from its "shared values and principles," including a focus on "humanity" and "equality." Canada now hosts the largest Sikh community outside India, with approximately 770,000 Sikhs identifying as such in the 2021 census. Despite Canada's smaller overall population, Sikhs make up 2.1% of the population, compared to 1.7% in India. Neilesh Bose, an associate professor at the University of Victoria, highlights that Sikhs constitute a significant segment of the South Asian community in Canada, amplifying their influence on Canadian perceptions of South Asia.

In today's Canada, Sikhs hold notable positions in society and politics. Jagmeet Singh, leader of the New Democratic Party, is Sikh and has been vocal about Sikh issues in India. Trudeau appointed four Sikh individuals to his Cabinet in 2015, surpassing India's count at the time. It's important to emphasize that not all Sikhs in Canada support the separatist movement, and not all Khalistan advocates endorse extremist methods. Senior Sikh leaders must intervene to ensure that relations between Canadian Hindus and Sikhs remain harmonious and in the interests of the Indian people as a whole. The complex landscape of Canada's involvement in the Khalistan issue calls for a delicate balance of diplomacy and understanding.

The India-Canada saga: A bilateral drama takes center stage on the global arena

he assertion made by Canadian Prime Minister Justin Trudeau, implicating Indian intelligence in the killing of Hardeep Singh Nijjar, a designated terrorist in India, on Canadian soil, has triggered a severe strain in bilateral relations. Trudeau characterized the alleged act as an "unacceptable violation of our sovereignty" and responded by expelling an Indian diplomat. In retaliation, India expelled a Canadian diplomat and dismissed the charges as "absurd." The stage is now set for a potential worsening of relations, with the risk of further escalation looming.

The persistence of the Khalistan movement within the Sikh diaspora has long posed challenges to India's relations with Western countries. However, the situation took a sharp turn following the 2020-21 farmers' protests, resulting in a series of surreal events. These events ranged from the sudden arrival and subsequent arrest of Sikh radical Amritpal Singh Sandhu in Punjab in April, to violent protests at Indian diplomatic missions in various Western capitals. These incidents were followed by a sequence of almost simultaneous killings of Khalistan militants in Pakistan and Canada, along with the mysterious death of another individual in the United Kingdom (UK).

Canada has attributed one of these killings to India. The covert nature of these backstage operations makes them difficult to trace and assess for obvious reasons. However, Canada's decision to elevate this issue to the diplomatic forefront, similar to how London responded when the Russian dissident Sergei Skripal was poisoned, raises significant questions.

Firstly, the question arises: why did this happen? While it may be tempting to attribute it solely to Trudeau's efforts to appease the Canadian Sikh "vote-bank," such an explanation is logical but ultimately insufficient. There are deeper and more complex structural factors at play here, with far-reaching implications in the long term. Secondly, what lies ahead? The ongoing investigation and the possibility of a public inquiry suggest that a protracted and challenging road lies ahead for all parties involved.

dented instance of covert assassination by Indian intelligence on Western soil. The manner in which it was carried out, with the

target being shot by unidentified assailants, suggests minimal effort was made to conceal the operation's origins. In this context, India's message to Canada is crystal clear: if you do not take action against Khalistan militants or downplay our security concerns, we will take matters into our own hands. Undoubtedly, this development has elicited jubilation among many in India.

However, Ottawa's countermessage carries significant weight. It's important to note that Ottawa's primary audience is not New Delhi, but its Five-Eyes allies, which include Australia, New Zealand, the UK, and the US. By taking this stance, Canada is not just aiming to discourage India from employing similar tactics in the future; it is also signaling to its allies that there are boundaries to the West's alignment with India. It would be erroneous to assume that India will not face consequences, especially considering the somewhat muted responses from other Western countries, many of which are investing in India as part of their strategy to counterbalance China. Canada's decision to make these allegations public has emIndia skeptics within the corridors of Western power. Furthermore, India's response to Canada's allegations is exacerbating these concerns rather than

mitigating them.
Pointing out Canada's potential hypocrisy, in light of the West's extensive history of interven-

tions, support for authoritarian regimes, and its robust global covert operations network, is undeniably accurate but may prove futile. Under the leadership of Trudeau, Ottawa has chosen to leverage this incident to highlight the stark contrast in value systems between a conservative India and Western liberals grappling with their own challenges.

This inherent political mismatch, often downplayed for strategic reasons, is greasing the wheels of this collision. It elucidates why the Western nations do not share India's perspective on this matter, viewing New Delhi's concerns as an exercise in exaggerating threats. While it's uncertain whether Washington DC or London will actively support Ottawa in keeping India at arm's length, the political ramifications of Ottawa's front-and-center actions will resonate far and wide. The heightened Western sensitivity surrounding foreign interference in their domestic politics poses the risk of India being lumped together with China and Russia, potentially constraining New Delhi's strategic maneuvering space in the future. Even if conservative parties gain prominence in the West, which may be seen by some in India as a solution to this impasse, it might not completely mitigate the accruing reputational and diplomatic damage.

This leads us to the second question: what comes next? With his position now entrenched, Trudeau has little recourse but to substantiate his allegations with concrete evidence. Given the meticulous approach taken by Ottawa so far, the likelihood of Canada producing compelling evidence cannot be discounted. However, the nature of this evidence, its presentation, and its intended audience all remain uncertain. In an ideal scenario, the United States could act as a discreet mediator, facilitating a behind-the-scenes agreement, crafting dignified exit strategies for both parties, and helping to diminish the prominence of the Khalistan issue. This would not only apply to Canada but also to the UK, Australia, and New Zealand.

However, if this doesn't materialize, Ottawa has two potential courses of action. It could opt for the release of evidence through a formal public inquiry, a move that could constrain even those conservative Canadian politicians advocating for stronger ties with India. Alternatively, Ottawa might employ a "media drip" strategy, similar to what Ankara did concerning Riyadh when unveiling the bungled Saudi operation involving the assassination of Jamal Khashoggi, a critic of the regime, in Istanbul, Turkey strategically leaked fragments of evidence to the media, effectively tarnishing the global image of the crown prince irreversibly. If Canada chooses the second option, the potential reputational toll on New Delhi could be exceedingly high. It has the potential to shatter the perception that India is akin to the new Israel, not due to any inability to carry out untraceable covert operations (as it certainly can), but because its alignment with the West has inherent limitations, even at its highest point. It's important to recognize that under such circumstances, India is likely to remain resolute, with its media countering negative international coverage, and Opposition parties rallying in support of the national interest. Havana declaration of G77+ China summit is a charter of global South in this decade

Just four days after the holding of the G 20 summit in New Delhi on September 9 and 10 this year, the G77+ China held its historic summit in Havana on September 15 and 16 and came out with its Havana Declaration which was an unequivocal charter of action for the Global South for working on a new International Economic Order. The summit was the largest event of the countries of the Global South within the United Nations.

Prime Minister Narendra Modi hosted the G20 summit and the Government of India as also the ruling party BJP went the whole hog by claiming that the Summit was a tremendous success. Indian PM worked hard for bringing consensus on the Delhi Declaration and it goes to his credit that finally, an unanimous statement was possible. Another positive thing was the admission of the African Union as the new member of the G-20. Next year at the summit in Brazil, it will be G 21. But whatever gains India

made at the Delhi summit, especially the inclusion of the AU as the new member lost its impact by the time the Havana summit of G-77+ China attended by more than one hundred countries ended on September 16. India was not represented neither by the Prime Minister nor the External Affairs Minister S Jaishankar. A senior official of the EAM represented India at the high profile summit which was attended mostly by the head of the states PM was supposed to be busy preparing for the Special session of Parliament, but what about the Foreign Minister? He could have attended the summit and still could have comfortably been present at the Special session which began on September18.

The net result was that the impression gained ground among the African and the Latin American countries that India which pioneered the non aligned movement and gave direction to G77 in earlier, has lost interest in the future of this grouping and is now focusing more on improving relations with the western nations like USA,UK, and others. Indian PM or EAM could have met with the new generation of head of states who have taken over in some of the Latin



American countries promising a bright future for their people. Colombian president Gustavo Pero was there while the Brazilian president Lula da Silva took a leading part in the deliberations.

The Havana declaration says "We stress the urgent need for a comprehensive reform of the international financial architecture and a more inclusive and coordinated approach to global financial governance, with greater emphasis on cooperation between countries, notably by increasing the representation of developing countries in global decision-making and policymaking bodies that will contribute to increasing the capacities of developing countries to access and develop scitechnology ence,

innovation". The text also criticizes digital monopolies and other unfair practices that hinder the technological development of the developing countries.

The Declaration also attacks "sanctions" and "coercive economic actions" against developing countries. "We emphasize that such actions not only undermine the principles enshrined in the United Nations Charter and international law, but also seriously impede the advancement of science, technology and innovation and the full realization of economic and social development, particularly in developing countries."

Cuban President Miguel Díaz-Canel stressed at the opening of the summit that one of the aims of the event was to seek common positions so that the countries of the Global South could take their demands to other international forums. On the same day, UN Secretary-General António Guterres pointed out that "global systems and structures have failed" the countries of the Global South.

President Lula on September 16 criticized the sanctions imposed by the United States adaptation to climate change in 10 years, and 7% would be enough to cover the cost of universal vaccination against the pandemic," he estimated.

In the opening speech of UN Secretary General Guterres, he started by saying that the countries of the Global South are "caught in a web of global crises". "Poverty is increasing and hunger is growing. Prices are rising, debt is exorbitant and climate disasters are becoming more frequent," said Guterres. "Global systems and structures have failed them," adding that "the conclusion is clear: the world is failing developing countries."

The UN Secretary-General noted that in recent decades, the G77 countries and China "have lifted hundreds of millions of people out of poverty and have come together in the United Nations in search of global solutions and solidarity."

"To change this, we need action at the national level to ensure good governance, mobilize resources, and prioritize sustainable development. And we need action at the global level that respects national ownership, with the aim of building an international system that defends human rights and looks after the common interest," he said. In this sense, Guterres recognized that "many current global institutions reflect a bygone era." He highlighted the need to update the UN Security Council, the International Monetary Fund

(IMF) and the World Bank. The G77+ China summit has assumed special importance in view of the move by the Let leaning Latin American governments to collaborate effectively for bringing synergy in the utilization of their natural resources. Mexico and Brazil are the leading countries pioneering this move and now Columbia, Honduras and Chile have joined the move with full efforts. These Latin American nations are looking to replace their existing developers from the western

countries.

India has got the appropriate technology to assist the developmental programme of these LA nations. That way, India lost a good opportunity for economic interaction. It is imperative that the Indian policy makers give due attention to the building better relationship with the G77 nations. (IPA Service)

Nijjar murder has similarities with assassination of Saudi journo Khashoggi

he pace at which the India-Canada diplomatic row is deteriorating, manifesting in tit for tat diplomatic expulsions, suggests that Khalistan activist Hardeep Singh Nijjar's killing may be an action replay of the murder of Washington Post journalist Jamal Khashoggi, a Saudi-born critic of the Saudi royal family, particularly crown prince Mohammed bin Salman, which soured US-Saudi relations even more than the alleged involvement of Saudi elements in the dastardly 11/9 terrorist attack against America.

Khashoggi was last seen entering the Saudi consulate in Istanbul in October 2018 reportedly for obtaining documents relating to his proposed marriage to fiancée Hatice Cengiz, who lived in Turkey. But the leading Saudi journalist never emerged out of the consulate. The US Central Intelligence Agency arrived at the conclusion that Khashoggi was murdered at the instance of crown prince Mohammed bin Salman, but the Trump administration sat over the report as 'classified'. Two years later, however, the report was declassified, when its contents became public. But the final report, when published, omitted bin Salman's name.

When president Joe Biden assumed office, he refused to deal with the Saudi Crown Prince for as long as 18 months, although that latter had become the de facto ruler of Saudi Arabia and took complete charge of Saudi affairs, giving them a positive and rather progressive turn, including a dose of religious reforms in the otherwise most conservative Saudi traditions and culture. Mohammed bin Salman even emerged as the liberator of Saudi women, who now enjoy unthinkable rights and privileges in the traditional Saudi society

It was only in the wake of US plan to counter Russia's Putin in the aftermath of the Ukraine war that Biden changed his approach towards the crown prince. Ahead of Biden's so-called 'pilgrimage' to Saudi Arabia, the US decided to grant immunity to the crown prince, which made the president's engagements with Mohammed bin Salman possible. Although the decision took care of the immediate diplomatic concerns, there is still suspicion about the crown prince's role in the ace journalist's assassination. A court in the US, where Khashoggi's fiancée filed a petition, is yet to declare its verdict in the case.

The Indian government had for long designated Hardeep Singh Nijjar as a terrorist, but the Khalistani activist had been carrying on relentlessly in Canada. New Delhi had even announced a cash reward on his head. The man was shot dead outside a gurdwara in a Vancouver suburb on June 18. The killing led to protests outside the Indian consulate in Vancouver, with protesters alleging the involvement of foreign hands. The Canadian authorities had come to the conclusion that the killing may have been the result of rivalries between separatist groupings in the country.

But thanks to developments in Canadian politics, which saw Prime Minister Justin Trudeau's ratings plummet, the murder has assumed additional political importance. Making up nearly 2 percent of the total population, Sikhs are a prominent vote bank in Canadian politics and Trudeau's party has been nurturing the community for its electoral value. This soft approach has encouraged Canada's Khalistani elements to step up their operations, which also extend to other countries such as the UK and Australia.

The Indian government has accused of Khalistanis of randomly picking up Hindu temples in Canada to vandalise and disfigure them with pro-Khalistan graffiti. Similarly, in March this year, the Indian High Commission in Ottawa was attacked by the separatist elements, in incidents similar to those that have taken place in London and other places, where the Indian flag had been pulled down on a number of occasions. New Delhi has been urging Canada and other government to take action against such offences, but has been unhappy with the response from the authorities.

It turns out that when Trudeau came to Delhi for the G20 summit, he had tried to drum up support for the stand that the Khalistani separatist's murder amounted to a violation of his country's sovereignty, but the campaign did not elicit any positive response. which forced him to soft pedal. But he did raise the matter with Prime Minister Modi, who apparently made light work of it. When back home, however, Trudeau escalated the issue by hinting at a role for India in Nijjar's murder and declaring that any involvement of a foreign government was not unacceptable, which drew strong rebuttal from the Indian side, triggering a diplomatic row, the ending of which is not clear yet. From the way developments are overtaking each other, it appears that things are headed for a lot more deterioration. (IPA Service)

Canada says no place for aggression, hate, intimidation in country amid online threats to Hindus

TORONTO, Sept 22: The Canadian government has said the circulation of an online video in which Hindu Canadians are told to leave the country is offensive and hateful, asserting that acts of aggression, hate, intimidation or incitement of fear have no place in Canada.

The video was circulated amid escalating tensions between India and Canada following Prime Minister Justin Trudeau's explosive allegations of the "potential" involvement of Indian agents in the killing of Khalistani extremist Hardeep Singh Nijjar on his country's soil on June 18 in British Columbia. India had designated Nijjar as a terrorist in 2020.

India has angrily rejected Turdeau's allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case.

Public Safety Canada, the department responsible for matters of public safety, emergency management, national security, and emergency preparedness, said the circulation of the video is offensive and hateful and is an affront to all Canadians and



"There is no place in Canada for hate," it said on Thursday night in a post on X.

"Acts of aggression, hate, intimidation or incitement of fear have no place in this country and only serve to divide us. We urge all Canadians to respect one another and follow the rule of law. Canadians deserve to feel safe in their communities.

Indo-Canadian lawmaker Chandra Arya from Prime Minister Trudeau's party has earlier expressed dismay at the "glorification of terrorism" and hate crime targeting Hindus in this country in the name of "free-

dom of expression" in Canada.

"A few days back Khalistan movement leader in Canada and the president of Sikhs for Justice which organises the socalled referendum Gurpatwant Singh Pannun attacked Hindu Canadians asking us to leave Canada and go back to India," Arya, a member of the Liberal Party of Canada, said.

"I have heard from many Hindu-Canadians who are fearful after this targeted attack. I urge Hindu-Canadians to stay

any incident of Hinduphobia to your local law enforcement agencies," the Indo-Canadian MP posted on X.

The Khalistan movement leader is trying to provoke Hindu Canadians to react and divide the Hindu and Sikh communities in Canada, Arya said.

Canada's public safety minister Dominic LeBlanc said all Canadians deserve to feel safe in their communities.

"All Canadians deserve to feel safe in their communities. The circulation of an online hate video targeting Hindu Canadians runs contrary to the values we hold dear as Canadians. There is no place for acts of aggression, hate, intimidation or incitement of fear," he posted on his official X account.

Emergency preparedness minister Harjit Sajjan in a post on X said: "To Hindu Canadians and Indians from all backgrounds: Anyone who says you do not deserve to be safe & welcomed in your home does not embody the values of freedom and kindness we hold dear as Canadians. Do not let others delegitimise or question your place and love for Canada.

Ukraine launched a missile strike on Russia's Black Sea Fleet headquarters

KYIV, Sept 22: Ukraine carried out a fiery missile strike on Friday on the main headquarters of Russia's Black Sea Fleet, a Russian official said. Videos and photos showed large plumes of smoke over the building in Sevastopol in annexed Crimea.

The Russian-installed governor of Sevastopol, Mikhail Razvozhayev, said there was no information about casualties. He said firefighters were battling a blaze, and more emergency forces were being brought in, an indication that the fire could be massive. A stream of ambulances were arriving at the fleet's headquarters and shrapnel was scattered hundreds of metres (yards) around, the Tass news agency reported. Razvozhayev initially warned Sevastopol residents that another attack was possible and urged them not to leave buildings or go to the city centre.

He later said there was no longer any air strike danger but reiterated calls not to go to the central part of the city, saying roads were closed and and unspecified "special efforts" were underway. Ukrainian officials, who have claimed responsibility for a series of other recent attacks on Crimea, didn't immediately announce Kyiv launched the strike.

Sevastopol residents said they heard explosions in the skies and saw smoke, Russian news outlets reported. Images circulated in Ukrainian Telegram channels showed clouds of smoke over the seafront. The Associated Press could not immediately verify the

The attack comes a day after Russian missiles and artillery pounded cities across Ukraine, killing at least five people as President Volodymyr Zelenskyy met with President Joe Biden and congressional leaders in Washington with an additional USD 24 billion aid package being considered. (AP)

"Our regular dialogue has proved that our countries are really, truly allies and strategic friends. And we greatly appreciate the vital assistance provided by the United States to Ukraine to combat Russian terror," Zelenskyy said.

Reiterating his pledge to defend Ukraine's sovereignty, Biden said during the bilateral meeting later

> that the US will continue to support Ukraine's diplomatic effort to deliver a just and lasting peace that protects its sovereignty and territorial tegrity.

"Russia alone stands in the way of peace. It could

end today. Instead, Russia is seeking more weapons from Iran and North Korea. It would violate multiple UN Security Council resolutions that Moscow itself voted to put in place," he said.

Biden announced the next tranche of US security assistance worth USD 325 million to Ukraine, including more artillery, ammunition, and anti-tank weapons. "And next week, the first US Abrams tanks will be delivered to Ukraine," he said. The two leaders also reached a new agreement to strengthen Ukraine's defence capabilities, under which Washington will help Kyiv improve its air defence during the winter season to help protect its people. (PTI)

N Korea's Kim sets forth steps to boost Russia ties as US and Seoul warn about weapons deals

SEOUL, Sept 22: North Korean leader Kim Jong Un ordered unspecified steps to further develop relations with Russia after his recent visit to the country as his foreign rivals warn that any cooperation on military weapons would be dangerous and bring consequences

Experts speculated North Korea and Russia likely discussed banned arms transfer deals and other cooperation measures during Kim's six-day trip last week. They say the two countries are serious about sharply boosting their ties while they are engaged in separate confrontations with the

During a Politburo meeting on Wednesday, Kim arranged for work to be done on further developing bilateral ties at "a new high level at the practical stage" to consolidate "the success" of his Russia trip, the official Korean Central News Agency said Friday.

two countries, KCNA said. While travelling in Russia's Far East, Kim met with President Vladimir Putin and visited key Russian military and technology sites. Yoon said that South Korea, together with its allies, "will not sit idly by" over a possible Pyongyang-Moscow weapons deal that he said would pose a threat to not only Ukraine but also South Korea.

Many experts say North Korea would seek Russian help to complete the development of hightech weapons systems such as spy satellites, nuclear-powered submarines and powerful long-range missiles. They say Kim wants to modernise his weapons arsenals to wrest greater concessions from

Syria and China announce strategic partnership as Asian Games diplomacy kicks off

BEIJING, Sept 22: China and Syria announced the formation of a strategic partnership on Friday as Chinese leader Xi Jinping kicked off a series of diplomatic meetings ahead of the upcoming Asian Games. Xi met Syrian President Bashar Assad in the southern Chinese city of Hangzhou, which is hosting the

15-day sports competition. "In the face of the unstable and uncertain international situation, China is willing to work with Syria to firmly support each other ... and jointly safeguard international fairness and justice," Xi said in a video clip posted online by state broadcaster CCTV. Assad's visit parallels in some ways that of Russian President Vladimir Putin last year for the opening ceremony of the Beijing Winter Olympics.

Both leaders are virtual pariahs in the West but welcomed by China as it tries to expand its global influence and promote an alternative to the US-led international order.

The Syrian leader will attend the Asian Games opening ceremony on Saturday night along with the king of Cambodia, the crown prince of Kuwait and the prime ministers of Nepal, East Timor and South Korea China's Foreign Ministry has said

Xi also met Kuwaiti Crown Prince Sheikh Meshal Al Ahmed Al Jaber Al Sabah on Friday and said he would work with him to take bilateral relations to a new level, CCTV reported.

Both meetings took place at the West Lake state guest house. West Lake is a scenic tourist destination that has inspired Chinese painters over the centuries. Cambodian King Norodom Si-

hamoni arrived on Friday at the airport in Hangzhou. CCTV video posted online showed him walking down the stairs from his plane to the tarmac for a red carpet welcome that included the Asian Games mascots.Assad, who is making a rare trip abroad, is looking for ways to emerge from the international isolation brought on by a brutal war at home that shows

no sign of ending after 12 years. He was expected to discuss economic assistance from China, which could play a major role in Syria's future reconstruction. At least 80 corruption cases to be revived in Islamabad's Accountability Court after landmark SC verdict

ISLAMABAD, Sept 22: At least 80 highprofile corruption cases, including those against former prime ministers Nawaz Sharif and Shehbaz Sharif and ex-president Asif Ali Zardari, would be revived following a recent landmark ruling by the Supreme Court, according to a media report on Friday.

These are among the hundreds of cases closed as a result of amendments made to the anti-corruption laws by the previous government led by the Pakistan Muslim League-Nawaz (PML-N) led by Nawaz Sharif. The hearing for these cases would begin soon, officials sources said.

An apex court bench, headed by former Chief Justice of Pakistan Umar Ata Bandial, had on September 15 declared the amendments to the anti-graft laws void and directed the National Accountability Bureau (NAB) to revive within seven days the closed cases against public office holders.

The apex court had announced its reserved decision on jailed former prime minister Imran Khan's plea filed last year, challenging the amendments made to the accountability laws by the then government led by Shehbaz

NAB prosecution has submitted the record of 80 cases to the accountability court in Islamabad, the Dawn newspaper reported. Several others have been returned to the accountability courts of Rawalpindi and

According to official sources, about 2,000 cases, which were earlier closed, are being reopened against officials and businessmen after the intervention by the apex court.

The 80 cases transmitted to the local accountability court included the Park Lane case against Pakistan Peoples Party (PPP) leader Zardari, Universal Services Funds, in which former prime minister Syed Yousaf Raza Gilani and others are suspects; the Rental Power Projects case against former premier Raja Pervaiz Ashraf, and the case of Benazir Income Support Programme's former chairperson Farzana Raja.

The cases against former prime minister Shaukat Aziz and fake accounts cases against Zardari and Omni Group's directors also stand revived. (PTI)

Azerbaijan sends food, other aid to Nagorno-Karabakh after ending an offensive against Armenians

YEREVAN, Sept 22: Azerbaijan said it mined to guarantee Nagorno-Karabakh was delivering food and other humanitarian aid to Nagorno-Karabakh on Friday, two days after the region's ethnic Armenian separatist government called a cease-fire in a short but intense fight with Azerbaijani forces.

Nagorno-Karabakh's 120,000 people have suffered severe shortages of food and medicine since late last year when a blockade began of the road connecting the region to Armenia. Improving the supply of food and other basic needs will be a key issue in building stability in the region, which is within Azerbaijan but had been under the control of ethnic Armenian forces since 1994.

Azerbaijan on Tuesday launched in-

tense fire on Armenian positions in what it called an "anti-terrorist operation," demanding that the Armenians lay down their arms and the separatist government disband. A day later, Nagorno-Karabakl

authorities agreed to the military demands, but talks on how the region will be reintegrated into Azerbaijan have not reached final agreement.

Armenian Prime Minister Nikol Pashinyan on Friday said at a government meeting that there was no immediate need for the region's ethnic Armenians to leave their homes, but said Armenia is prepared to receive as many as 40,000 evacuees if needed.

Azerbaijan's emergencies ministry said two 20-ton trucks with food and hygiene products as well as two trucks with bread were dispatched to Nagorno-Karabakh on Friday, travelling on the road from Aghdam, which lies east of the region. Supplies for Nagorno-Karabakh previously had come from Armenia, to the west.

Jeyhun Bayramov, Azerbaijan's foreign minister, said at the United Nations on Thursday that his country is deter-

residents "all rights and freedoms" in line with the country's constitution and international human rights obligations, including safeguards for ethnic minorities. Talks with Nagorno-Karabakh in the Azerbaijani city of Yevlakh will continue, he said. Nagorno-Karabakh came under the control of ethnic Armenian forces backed by the Armenian military in separatist fighting that ended in 1994. More than 10,000 people fled their

homes to escape the offensive, he said. Electricity and phone service were knocked out, leaving people unable to contact each other, and "Azerbaijani troops control main roads in Nagorno-Karabakh, which makes it impossible to visit and get information on the ground," he said. (AP)

Rahul demands immediate implementation of women's reservation bill

NEW DELHI, Sept 22: Congress leader Rahul Gandhi on Friday demanded immediate implementation of the women's reservation bill and expressed "100 per cent regret" that the proposed legislation during the UPA government did not include reservation for OBCs. He also demanded that the government should conduct a caste census and make public its findings along with that of the previous caste census conducted during the United Progressive Alliance (UPA)

Noting that the government's intention behind bringing the bill was political, he said it will not be implemented in the next 10 years as it has been linked to the population census and delimitation exer-

The bill was meant for diverting attention from the growing call for a caste census, he said.

"The truth is that this bill will be implemented in 10 years from now, if it is implemented at all," he claimed at a press conference at the party headquarters, a day after Parliament approved the legislation to reserve a third of seats in the Lok Sabha and state assemblies for

Gandhi said that while he favoured the bill, he sought more reservation for women from backward classes and other sections as per their population ratios.

Asked if he regretted that the erstwhile UPA government did not give OBC quota in its women's reservation bill that was passed by Rajya Sabha in 2010, Gandhi said, "There is 100 per cent regret. We should have done that back then and we will get this done now."

The women's reservation bill is a good thing, but two "footnotes" of census and delimitation have been attached to it which will take many years to give this reservation to women, he said.

The Congress said delimitation and census were "poor excuses" for the postponement of the bill's implementation and alleged that the entire exercise was to create an election issue, without actually implementing it.

The opposition party also dubbed the bill a "teasing illusion". Gandhi said, "The BJP came up with the idea of a special session. We appreciated that idea. With a lot of fanfare and pomp we moved from the old building to the new building. The prime minister in a very dramatic gesture carried the

Constitution of India from the old

building to the new building and

"Women's reservation is a central step in the empowerment of women in India and it is a critical step. But, when we read the penrint we found something very

delimitation and that this will be done after Census. What it means is that this bill will be implemented a decade from now," he said.

"So this is a diversionary tactic," he said, asserting that the government is trying divert attention from the issue of caste census.

The Congress leader said he was shocked to find that only three secretary-level officers in the Government of India are from Other Backward Classes (OBCs) and only five per cent of the budget is allocated for them. The budgetary allocation for OBCs, Dalits and tribals put together is just six per cent, he said. "This is a shocking

The central question now is how many OBCs are there in India and how many are from other communities in India, he said and pitched for a caste census.

"If we want to distribute power to the people of India, we want to know this number; otherwise we are working without data.... All this data is available as the census has already been done. Why is the prime minister not releasing this data," he asked.

"What is this delay in this census. The caste census should be done now and the last caste census data should be released at once," Gandhi said

On the BJP's assertion of the party having a significant number of MPs and MLAs from OBCs, Gandhi said, "You can ask any MP or MLA on how much they participate in law-making, how much they participate in how the money in India is spent, they will tell you there is no participation.'

"And as the prime minister keeps saying he an OBC leader, I want him to explain why only three OBC (officers) are there in the Government of India and why the OBC community which is the backbone of this country is responsible for only five per cent of the budget," he noted.

Gandhi said the BJP was not been able to respond to this question and when he mentioned it, "I saw in their face the panic. Because this is the truth and this is what they are trying to distract India from - the fact that the large mass of Indian people do not have

Asked whether they will provide OBC reservation among women, he said one has to do this step by

Gandhi asserted that the independence movement was a beginning when it was the first step towards distribution of power. "The data from the caste census is another way of transferring power to the people of the country. We have to transfer power to women, tribals, OBCs, Dalits and caste census is its foundation."

Protests spread over Cauvery issue in Karnataka; home minister says police well prepared

BENGALURU, Sept 22: As protests continued in various parts of Karnataka on Friday over the release of Cauvery water from Karnataka to Tamil Nadu and a call for a bandh has gone out, police have tightened security across

The protests, which erupted after the Supreme Court refused to interfere with orders of the Cauvery Water Management Authority (CWMA) and the Cauvery Water Regulation Committee (CWRC) directing the state to release 5,000 cusecs of water to neighbouring Tamil Nadu, have intensified.

Farmer organisations and pro-Kannada outfits staged protests in the Cauvery river basin districts of Mysuru, Mandya, Chamarajanagara, Ramanagara, Bengaluru and other parts of the state expressing their anger and urging the state government not to release water to the neigh-

Karnataka has been maintaining that it is not in a position to release water, after taking into account its own need for drinking water and irrigation for standing crops in the Cauvery basin areas, as there has been water scarcity due to deficit monsoon rains. Protests have also spread to districts like Chitradurga, Ballari, Davangere, Koppal and Vijayapura.

Farmers under the aegis of the Raitha Hitarakshana Samiti continued to protest near the statue of Sir M Visvesvaraya in Mandya. They were today joined by Nirmalanandanatha Swamiji, the head of Adichunchanagiri Math, a Dayananda held meetings with his subordinates (court) proceedings and our lawyers have not

Jaishankar embarks on 9-day US visit

NEW DELHI, Sept 22: External Affairs minister S Jaishankar on Friday began a nine-day visit to the US, primarily to attend the annual session of the UN General Assembly (UNGA) in New York and to host a special event on Global South. Following the completion of the 78th UNGA related engagements, Jaishankar will visit Washington DC from September 27 to 30 for bilateral meetings with his American interlocutors.

"During his visit to New York from September 22 to 26, the External Affairs minister (EAM) will be leading the Indian delegation for the high level week at the 78th session of the United Nations General Assembly," the Ministry of External Affairs (MEA) said.

"In keeping with India's support for Global South, the EAM will be hosting a special event 'India-UN for Global South: Delivering for Development'," it said in a statement. Jaishankar would also attend various plurilateral and bilateral meetings in

"The EAM will also be meeting with the UN Secretary General Antonio Guterres and Dennis Francis, President of the 78th Session of the UN General Assembly," the MEA

Stalin sanctions ₹ 10 lakh to bring TN child by air ambulance from Turkey

Admitted to Istanbul Medicana Hospitals, she is being treated in intensive care. Manoj, having spent all the money he had for medical care, sought Stalin's help to bring the child to Tamil Nadu for further treatment.

India-Canada row: Cong calls for 'intensive diplomatic engagement' to resolve crisis NEW DELHI, Sept 22: Amid the India-Canada diplomatic row, the Congress on Friday reiterated that the fight against terrorism has to be uncompromising and called for "intensive diplomatic engagement" to resolve the "serious crisis" while ensuring security of Indians in that country. Congress general secretary Jairam Ramesh also asserted that the security of thousands of Indian students and professionals studying and working in Canada must be protected at all

"The Congress reiterates that our fight against terrorism has to be uncompromising especially when terrorism threatens India's sovereignty, unity and integrity. The Congress hopes that intensive diplomatic engagement between the two countries will help resolve the current serious crisis between India and Canada," he told reporters

In a blunt and clear message, India on Thursday asked Canada to come down hard on terrorists and anti-India elements operating from its soil and suspended visa services for Canadians, as escalating tensions between the two nations over the killing of a Khalistani separatist in June pushed their ties to an all-time low. Tensions flared between India and Canada early this week following Canadian Prime Minister Justin Trudeau's explosive allegations of a "potential" involvement of Indian agents in the killing of Nijjar on his country's soil on June 18 in British Columbia. India had designated Nijjar as a terrorist in 2020. India angrily rejected the allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case. Speaking about the row, Ramesh said

NEW DELHI, Sept 22: Panel discussions with environmentalists, film screenings, presentations by eminent artists, puppet shows and exhibitions are among the many activities planned for the fourth edition of the 'Nadi Utsav' which started here on Friday on the banks of the Yamuna

The three-day event will host discussions on a number of topics, including rivers in ancient texts, cultural heritage along the rivers and rivers in folk and cultural traditions.

Organised by National Mission on Cultural Mapping (NMCM) of the Indira Gandhi National Centre for the Arts (IGNCA) and the Janapada Sampada Division, the initiative was conceived to create awareness and sensitise people about their ecology and environment.

As many as 18 films, out of which six have been produced by the IGNCA, will be screened during the event. Traditional puppeteer and contempo-



rary theatre artist Puran Bhat will perform a puppet show, 'The Yamuna Gatha', on the occasion, informed the

"Nadi Utsav' is an attempt to document riverine culture, its tradition, rituals and water wisdom. In the race of modernity, we have forgotten to thank our rivers and this is an opportunity to do so now. This event is an initiative to remember the connection with rivers. A book fair will also be organized during the three-day event, in which various publishing houses will bring their books related to rivers and environment," said Abhay Mishra, assistant director of NMCM at IGNCA, in a statement.

A total of three types of exhibitions, including 'Sanjhi' exhibition, based on 16 ghats of the country; a photography exhibition related to river civilisation; and an exhibition of paintings made on rivers by school children of Delhi reflecting what they think about rivers is also among the attractions of the event.

The three-day event will also see cultural programs, including singing by folk singer Chandan Tiwari from Bihar and Bharatanatyam performance by Shweta Devendra and her team from Bhopal.

IGNCA, which comes under the purview of the Ministry of Culture, has been organising 'Nadi Utsav' for the last few years.

It commenced in 2018, with its inaugural event on the banks of the Godavari River in Nashik. The second edition took place on the banks of the Krishna River in Vijayawada, and the third on the banks of the Ganga River in Munger. (PTI)

Ex-cop Waze wanted to create terror in the mind of Ambanis, says NIA court MUMBAI, Sept 22: Former policeman Sachin

Waze wanted to create terror in the mind of the Ambani family, a special court here observed in its order denying bail to him in the Antilia bomb scare case and the killing of businessman Mansukh Hiran. The court held that though the gelatin sticks

planted near Antilia, the Ambani residence, were not connected to a detonator, it was sufficient to create terror in the minds of people. Special NIA judge A M Patil denied bail to Waze

on September 16 and the detailed order was made available on Friday. Citing statements of witnesses, the court said the

applicant and the co-accused in the case had tried to spread terror in the mind of the Ambani family and had eliminated Hiran after conspiring with each

"It was a well-planned murder. Every precaution was taken to escape the clutches of law. It is not a simple allegation under a section of the Indian Penal Code. In such a situation if the applicant is released on bail, there is every possibility of him tampering with the witnesses," the court observed.

"It is amply clear that though the gelatin sticks were not connected to the detonator, it was sufficient to create terror in the minds of people. Here in this case, the attempt of the applicant was to create terror in the mind of a particular section of people and that

is the Ambani family," the order stated. As seen from the prosecution story, Waze con-

spired to "regain clout", it said.

The court said that when the incident took place in February 2021, the accused was attached to the Crime Intelligence Unit (CIU) and was entrusted with duties as a police officer.

However, upon perusal of the statements of witnesses, it is seen that bringing the SUV from Hiran, parking it near Antilia along with a note and gelatin sticks and the murder were not part of Waze's duties, it said. In his plea, Waze is silent about how these activities were part of his duty, but he wants to take advantage of the point of obtaining the prior sanction for the prosecution of a government servant, the court observed.

On Waze's contention of internal rivalry in the police department, the court said his bail plea is silent "as to with whom he had rivalry in the police department and how he has been implicated in the

false case". On the grounds of the delay in the trial, the court said that the chargesheet and electronic evidence

were huge and there were 10 accused in the case. According to the NIA, Waze, then an assistant police inspector with the Mumbai crime branch, parked an SUV with explosives outside Antilia as part of a conspiracy. (PTI)

A bench of Justices Aniruddha Bose and Bela M Trivedi issued notices on the petition filed by Chennai-based lawyer B Jagannath who said the apex court has passed several directions, including for registration of FIR, in similar cases. Senior advocate Dama Seshadri Naidu, appearing for the petitioner, alleged Udhayanidhi asked school students to say Sanatan Dharma was not good while other religions were.

"I would understand if an individual rants against a particular community or faith of a group of people. But it causes concern when the State unleashes its machinery,' the lawyer said.

Udhayanidhi, also a well-known film actor, is the son of Tamil Nadu chief minister and ruling DMK chief M K Stalin.

When the bench asked him why did he not approach the Madras High Court with the petition, Naidu said, "This court has taken note of similar matters where individuals make such a statement against another's faith but in this case it is a minister making the statement. Here it is State which



is telling the school students that so and so religion is wrong.

Naidu claimed circulars have been issued asking students to speak against a particular faith. He said the question is can a constitutional authority make such speeches.

"These are impermissible. A batch of petitions has already been admitted and I should not be asked to go to the high court now. The court has issued interim directions earlier when it came to individuals. Here, I am concerned with the State. I was com-

ister, and when we went to register FIR, no one registered it," the lawyer said. Responding to a query by the bench, the senior lawyer said he is seeking a restraining order against Udhayanidhi Stalin to prevent him from making any such statement in the future and registration of an FIR. He said the petitioner also wanted students to be kept out of the controversy.

"Although we are issuing notice, you are turning the Supreme Court into a police station by approaching it for registration of FIR. You should have gone to the high

court," the bench told the lawver.

The petitioner has also urged the court to declare as unconstitutional the participation of the state ministers in the event titled 'Sanatana Dharma Eradication' conference in Chennai on September 2, 2023. He has sought a direction from the court to the higher education department of the Tamil Nadu government to ban holding of events against 'Hindu Dharma' at all secondary The petition said it would have been a

welcome step if the conference was called to eradicate casteism and other ills plaguing a religion. It deplored that no FIR has been filed against Udhayanidhi Stalin, Sekar Babu or the organisers of the event despite the uproar caused by the remarks of the youth welfare and sports development minister which shows "bias, favouritism and discrimination". LS, RS worked more than scheduled time during special session



NEW DELHI, Sept 22: Both Lok Sabha and Rajya Sabha worked more than their scheduled time during the special session of Parliament. It was also the only session in the 17th Lok Sabha when the lower house did not lose any time due to adjournments, according to data compiled by a think tank.

The special session which concluded on Thursday, a day ahead of schedule, saw the historic women's reservation bill being passed by both houses - the only bill to be passed in this session. Discussions on 75 years of Parliament and the success of Chandrayaan 3 were

According to the data compiled by PRS Legislative Research, Lok Sabha sat for over 31 hours, around eight hours more than the scheduled time of 22 hours 45 minutes. This makes the working time of Lok Sabha around 137 per cent of its scheduled time. Rajya Sabha functioned for 27 hours 44 minutes, against a scheduled time of 21 hours 45 minutes, working for 128 per cent of its planned time.

Lok Sabha Speaker Om Birla had announced at the end of the session that the productivity of the lower House was 132 per cent for this session, which was revised later to 160 per cent.

No time was lost to adjournments in this session in Lok Sabha. Rajya Sabha lost around one and half hour

Farmers protest across Punjab to demand compensation for losses

AMRITSAR/HOSHIARPUR, Sept 22: Farmers in Punjab held dharnas in many places on Friday to demand adequate compensation for losses suffered during the recent floods.

Farmers gathered in Amritsar in response to a call from the Samyukt Kisan Morcha and organised a protest in front of the deputy commissioner's office to press for fair compensation.

Balkar Singh Dudhala, the Samyukt Kisan Morcha spokesperson, said in a statement that different outfits gathered under its banner to demand that the Punjab and the central governments provide compensation of ₹ 1.68 lakh per acre for the crops damaged during the floods. The farmers also demanded compensation to level the soil that rose due to floodwater entering the fields. They want another ₹ 1 lakh compensation for each animal killed during the floods, he said.

The floods in July and August caused massive damage to crops and property, the farmers said. Before dispersing from the protest sites, the farmers submitted memorandums on their charter of demands to the respective deputy commissioners.

Several farmers' organisations in Hoshiarpur held a dharna for over three hours in front of the district administrative complex to demand compensation from both the state and the Union governments.

They were led by Harbans Singh Sangha, the general secretary of the Kisan Committee Doaba Punjab. All the speakers who addressed the gathering expressed dissatisfaction with the central and the state governments for "turning a deaf ear" to the farmers' demands. They also warned of intensifying the protest if their demands are not met. In Ludhiana, hundreds of farmers gathered at the call of the Samyukt Kisan Morcha and sat on a dharna in front of the deputy commissioner's office.

They demanded a special package to compensate for the huge losses caused by the floods.

The protesters were addressed by Avtar Singh Mahalon of the Bharti Kisan Union (Lakhowal), Raghubir Singh Benipal of the Jamhoori Insaf Morcha and Baldev Singh Latala of Kul Hind Kissan Sabha, among others. (PTI)

Asked if Canada is thinking about retaliating by pausing visa processing for Indian visitors, Freeland said the government is focused on bringing the killers to justice. "This is not about geopolitics. This is about Canada and the safety of Canadians in Canada. This is about the rule of law," she said.

Prime Minister Trudeau Thursday said Canada is not looking to "provoke or cause problems" with India as he urged New Delhi to take the matter "extremely seriously" and work with Ottawa to "uncover the truth".

"We call upon the government of India to take seriously this matter and to work with us to shed full transparency and ensure accountability and justice in this matter," Trudeau said while responding to questions on the diplomatic row between India and

"We are a country of the rule of law. We are going to continue to do the work necessary to keep Canadians safe and to uphold our values and the international rulesbased order. That's our focus right now," added Trudeau, who is here to attend the 78th session of the United Nations General Assembly in New York. When asked whether his government would take any retaliatory measures following India's suspension of visa services for Canadians, Trudeau said that his government was not looking to provoke or cause problems.

The Canadian government has not released its evidence and has suggested it could emerge during an eventual legal process, the CBC report said.

The US on Thursday said it supports Canada's efforts to investigate allegations of India's involvement in the killing of Nijjar, observing that no country can get any "special exemption" for such kind of activities. The US government has not confirmed or denied that it was the Five Eyes ally providing some of the signals intelligence.

However national security advisor Jake Sullivan told reporters at a White House news conference that the United States has been in frequent contact with Canada on

"I'm not going to get into the substance of private diplomatic conversations, but we are in constant contact with our Canadian counterparts. We are consulting with them closely. We support the efforts that they are undertaking in this investigation and we have also been in touch with the Indian government as well," he said.

"We have deep concerns about the allegations and we would like to see this investigation carried forward and the perpetrators held to account. That is what the US has stood for from the moment this emerged in public and we will continue to stand for that until this fully plays its way out," he said.

Refusing to respond to questions on the evidence of Canadian allegations, Sullivan said he is not going to speak to either intelligence or law enforcement matters from

"I will let that process play out. We are in, as I said before, continuous communication and consultation with the Canadian government and we will remain so as we go forward," he said (PTI)

forest staff facilities developed under the project and interacted with officials concerned on protected area management, including grassland management and invasive

weed management, were held. It was followed by the inauguration of a Banashristi Store by the country director, AFD at the Assam State Zoo cum Botanical Park in Guwahati. Banashristi stores sell products produced by the forest-fringe communities, including unique handicrafts and handloom products. The team also visited a plantation site at Amsoi in the Nagaon Division. Under Phase II, plantations would be raised on about 12,500 hectares in priority sites across Assam. Of the total, more than 75% area has already been covered.

The key focus areas of the project are to build the capacity of the forest department staff for improved wildlife management and fringe communities in alternate livelihood opportunities to enhance their income. The AFD team also interacted with local communities at the Ouguri Ecodevelopment Committee near the Pobitora Wildlife Sanctuary. where they also visited ongoing training sessions on food processing and weaving. 
There are approximately 262 distinct species of the plant across the globe with 39 of

After its initial identification, the plant seemingly vanished from the scientific records

and remained hidden from the world for long 95 years. Choudhary said, "Rediscovering smilax turbans after almost a century is a remarkable achievement for the scientific community. This extraordinary plant which was neglected and underexplored has long been considered a holy grail of botanical rediscoveries and our successful efforts are a testament to the significance of preserving biodiversity and conducting thorough explorations in remote regions.

The rediscovery of smilax turbans serves as a reminder of the mysteries that still lie hidden in the world's most remote and bio-diverse regions and the importance of preserving these unique ecosystems, he added. (PTI)

HANGZHOU, Sept 22: Led by Olympic champion Neeraj Chopra, India will seek to showcase its ascendency as a sporting power at the Asian Games, which opens formally on Saturday after an unprecedented one-year delay due to the COVID-19 pandemic.

India will hope to surpass the 70 medals (16 gold, 23 silver and 31 bronze) won in 2018 in Indonesia with largest contingent of 655 athletes competing in 39 sports in Hangzhou to show the world the rapid strides the country has made in sports since the historic performance in Tokyo Olympics in 2021.

For a country that aspires to host the Olympics in near future, an eighth-place finish in 2018 Asian Games is far from satisfactory, and it will seek to rise higher in the medal tally in Hangzhou, which will host the world's biggest multi-sport event after the COVID-19 pandemic.

India have not finished in the top-5 in medal tally standings since the 1986 edition in Seoul. The catchline is 'Iss baar, sau paar' (this time crossing 100

Though 100 medals may not be possible, India is expected to surpass the last edition's count with athletics once again set to contribute the lion's share. Last time, track and field athletes had won 20 medals and this time at least 25



For the first time in the Asian Games history, India will be having five Olympic medallists in their ranks led by javelin superstar Chopra, who will be defending his title, raising hopes of the

country grabbing more gold

medals than the 16 won in 2018. The other Olympic medallists are weightlifter Mirabai Chanu, shuttler PV Sindhu, wrestler Bajrang Punia and boxer Lovlina Borgohain. Still, it is difficult to predict the gold medal count for India. Sindhu has been struggling for some time, Chanu has had fitness issues recently while Bajrang started training only a few months ago after taking part in the

Borgohain and Chopra have, though, become world champions recently. Borgohain will also shoulder the responsibility of being the Indian contingent flagbearer during the opening ceremony on Saturday along with the men's hockey team captain Harmanpreet Singh. The eight-gold show in athletics in 2018 will be hard to repeat but hockey (men and women), kabaddi (men and women), chess and archery can swell India's yellow metal tally.

Going by current form, India can win gold in both men's and women's hockey competitions. India can also win a gold each in men's and women's kabaddi and in Jakarta. The men's team had won a bronze and the women's settled for a silver last time.

Shooters had given nine medals in 2018, including two gold, but they may not be abe to surpass the tally this time. In boxing, the likes of Nikhat Zareen and Borgohain are favourites to win a medal but it is difficult to predict the colour. The same is the case with the wrestlers who had won three medals, including two gold, in 2018. By hosting the world's biggest multi-sporting event, China is heralding its opening from the pandemic, a giant competition which will be the biggest ever in its history. (PTI)

OCA takes up issue with Chinese authorities after Indian wushu players from Arunachal denied accreditation

HANGZHOU, Sept 22: The Olympic Council of Asia's (OCA) acting president Randhir Singh on Friday said it is actively pursuing with the Chinese authorities the issue of denial of accreditation to three Asian Games-bound Indian athletes from Arunachal Pradesh.

The three female wushu players from Arunachal Pradesh -- Nyeman Wangsu, Onilu Tega and Mepung Lamgu -- have been denied accreditation, which also works as visa, for the Asian Games that officially gets underway here on Saturday.

The three players were scheduled to fly out of India on Friday night with eight other members of the wushu contingent but were forced to stay back without proper clearance as their accreditation could not be downloaded.

"Unfortunately, these athletes didn't accept this visa. I don't think this is OCA problem because China has an agreement to let all the athletes who have certified eligibility to come to compete in China. This is clear. The visa has already been granted," Jizhong added.

The Indian government has also lodged a strong protest with China over the issue, saying that New Delhi reserves the right to take "suitable measures" to safeguard its interests.
