India-Canada issue discussed, both sides came out 'better informed': Jaishanka

WASHINGTON, Sept 29: External Affairs Minister S Jaishankar on Friday said that the Canadian allegations with regard to the death of a Khalistani separatist was discussed during his meeting with the Secretary of State Tony Blinken a day earlier and noted that the two delegations came

out "better informed" after the meeting. "Yes, I did," Jaishankar said in response to a question during his appearance at the prestigious Hudson Institute think-tank when asked if the issue of Canadian allegations came up during his meeting with Blinken at the Foggy Bottom headquarters of the State Department.

The US side shared its assessments on this whole situation and he explained to the

Americans a summary of India's concerns "I think hopefully we both came out better informed," Jaishankar said.

Tensions flared between India and Canada following Trudeau's explosive allegations of the "potential" involvement of Indian agents in the killing of Khalistani extremist Hardeep Singh Nijjar on his country's soil on June 18 in British Columbia. India had designated Nijjar as a terror-

India angrily rejected the allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case.

The Canadian Prime Minister, he said,



made some allegations initially privately and then publicly. "Our response to him both in private and public was that his al-

legation was not consistent with our policy. And if he had, his government had anything relevant specifics, we would look into," he said. "We were open to looking at it now. That's where that conversation is at this point of time," Jaishankar said.

He said that for India, Canada has become a country where organised crime from India mixed with trafficking in people, mixed with secessionism and violence which is a very toxic combination of issues that people who have found operating space. He acknowledged that there has been a lot between India and Canada on this issue preceding the remarks of the Canadian prime minister.

In the last few years, the issue of Khal-

istan has come back very much into play, because of what "we consider to be a very permissive Canadian attitude towards terrorists, extremists, people who openly advocate violence and they have been given operating space in Canada because of the compulsions of Canadian politics." "I don't think most Americans, perhaps Canada, looks very different, it sort of depends, from where the interests where the shoe pinches. For us, it has certainly been a country where organised crime from India, mixed with trafficking in people mixed with cessationism, violence, terrorism. The Law Commission has advised the government not to tinker with the existing age of consent under the POCSO Act and suggested introducing guided judicial discretion in the matter of sentencing in cases involving tacit approval of children in the 16-18 age bracket.

The commission, in its report submitted to the Union law ministry, said the amendments are necessary as such cases do not merit to be dealt with the same severity as the cases that were ideally imagined to fall under the POCSO Act.

Over the years, the POCSO Act, which seeks to protect children from sexual assault, sexual harassment,



and pornography, has often come in shall not be less than 20 years, but conflict with the role of consent in determining the nature of relation-

ships between adolescents. The act defines a child as a person aged below 18.

According to Section 6 of the POCSO Act, "Whoever commits aggravated penetrative sexual assault shall be punished with rigorous imprisonment for a term which

which may extend to imprisonment for life, which shall mean imprisonment for the remainder of the natural life of that person and shall also

GUWAHATI, Sept 29: Assam Governor Gulab Chand Kataria on Friday reviewed the various initiatives of the state food, public distribution and consumer affairs department at the Raj Bhavan.

State food, public distribution and consumer affairs minister Ranjeet Kr Dass provided the Governor with an overview of the department's activities in the state. He also outlined the department's initiatives aimed at benefiting both the department and the people of the

Additional chief secretary of the department, Biswaranjan Samal gave a comprehensive presentation on the department's core responsibilities. He placed particular emphasis on various aspects, including the implementation of the National Food Security Act (NFSA), 2013 and One Nation One Ration Card programme and distribution of subsidized wheat, salt, and cooking oil, highlighting ample stock of essential commodities. He also said that the department is ensuring constant price monitoring and regulation, consumer protection, awareness initiatives, and the maintenance of uniform and accurate weights and measures standards.

Since May 1, 2022, over 2.5 lakh ration cards, encompassing approximately 52 lakh duplicate/ineligible ben-

eficiaries, have been identified and removed from the NFSA database. Moreover, the Aadhaar seeding rate for ration cards has risen from 30.54 per cent in November 2021 to an impressive 99.49 per cent, while Aadhaar seeding against beneficiaries has increased from 11.70 per cent to 97.80 per cent. The state has also successfully deployed electronic point of sale (ePoS) devices at 34,285 Fair Price Shops throughout the state. These shops have been integrated into the One Nation One Ration Card (ONORC) platform since June 2022 as part of the NFSA, said officials present on the occasion.

Governor Kataria inquired about the department's role in addressing price surges in the market and sought details on the measures taken to stabilize prices during the festive season. Further, he emphasized the need for establishing a mandi system in the state, particularly to support farmers in obtaining fair prices for their produce.

The Governor underscored the importance of diversifying agricultural production beyond paddy cultivation. He advocated the need for encouraging farmers to engage in pulse and other allied farming practices to ensure the state's self-sufficiency in agricultural produc-

India in talks with more jurisdictions to make material impact on cross-border payments: RBI DG

Bank Deputy Governor T Rabi Sankar on Friday said the high cost of remittances for countries despite the available technology was "unconscionable", and India is in talks with more jurisdictions to make a material impact on cross-border payments.

Sankar, during a virtual address at the BCC&I Indo-Pacific Economic Conclave, said according to World Bank research, global crossborder remittance in 2022 was estimated to be USD 830 billion, and India was the top recipient.

"As per the World Bank's remittance prices worldwide database, the global average cost of a retail size of remittance (retail size -USD 200) was 6.2 per cent in the fourth quarter of 2022. For some countries, this cost can be as high

"Such a high cost in today's context, when data connectivity is so cheap, is simply unconscionable. I believe that given the available technology, the present situation is not sustainable," he said.

The top RBI official said India has been making efforts to tackle the challenge of the high cost of remittances, and the newly intro-

Tata Steel inks pact with IOCL to further reduce carbon footprint

JAMSHEDPUR, Sept 29: Tata Steel on Thursday said it has signed an agreement with Indian Oil Corporation Limited and its business associate to further reduce carbon footprint at its Ferro Alloys

The agreement encompasses LPG supply, installation of LPG facilities, and the operation and maintenance of the same at the company's Ferro Alloys Plants in Gopalpur of Ganjam and Athagarh of Cuttack districts in Odisha, the steel major said in a statement.

Charge Pankaj Satija said, "The India said on Thursday. agreement, which is a part of our Anuj Choudhary, Rese sustainability initiatives, will help us in reducing the carbon footprint at our plants. We will continue our commitment towards decarbonisation and endeavour for a greener

(CBDC) offers a potential solution in this context. "If we come up with a technologically viable solution to link the CBDC systems across countries, it can dramatically bring down cost of cross-border payments by completely bypassing the legacy correspondent banking system," Sankar said.

He, however, said this will require international cooperation and agreement on multiple legal and technological protocols, "something which should be quite doable in today's hyper-connected global economy", especially when the welfare gains are substantial.

"We are in talks with some other jurisdictions to make a material impact on the high cost of remittances," said Sankar.

In February this year, India and Singapore had enabled the UPI-PayNow linkage to enable users in either country to make convenient, safe, instant and cost-effective cross-border transfers using their respective mobile apps.

"We have followed up on this in July by signing an MoU with the Central Bank of the UAE (for) cooperation regarding interlinking on mutual payments and messaging



systems, among other things," Sankar added.

The RBI deputy governor also talked about the risks that private digital currencies pose for countries like India and other emerging economies. Such currencies impede the ability of emerging market countries to manage their external sector or maintain policy independence, he said.

"Within the set of private virtual currency, the inherent flaws, vulnerabilities and risks posed by stablecoins outweigh their purported

benefits. In fact, all the perceived benefits of stablecoins can perhaps be more easily and responsibly achieved by linking CBDCs or fast payment systems of differential jurisdictions," Sankar said

Meanwhile, speaking at a special session on 'India Leads - Towards 3rd Largest Economy', Ajay Seth, Secretary, Department of Economic Affairs, called for more private investment in the infrastructure sector, and a "creative redevelopment" of cities.

vate capital. At the moment, just about 5 per cent of investment in infrastructure is coming from private capital. And, that is not sustainable in the sense that capacities of the governments are limited, and thereby, we have to create opportunities for the private sector to

Sensex rises 320 pts, Nifty closes above 19,600 on buying in metal, energy shares

MUMBAI, Sept 29: Benchmark Sensex rose by 320 points while Nifty closed above the 19,600 mark on Friday after value-buying in metal, financial and energy stocks aided by positive trends in the US and European markets. The 30-share BSE Sensex climbed 320.09 points or 0.49 per cent to settle at 65,828.41. During the day, it jumped 643.33 points or 0.98 per cent to 66,151.65. The Nifty advanced 114.75 points or 0.59 per cent to end at 19.638.30.

Among the Sensex firms, NTPC climbed over 3 per cent emerging as the biggest gainer. Tata Motors, Sun Pharma, Tata Steel, State Bank of India, UltraTech Cement, JSW Steel, Bajaj Finance, Reliance, ICICI Bank and IndusInd Bank were the other major gainers.

Power Grid, HCL Technologies, Tech Mahindra, Tata Consultancy Services, Infosys and Titan were among the laggard.

"Markets made a recovery attempt after Thursday's fall and managed to close half a per cent higher. The tone was positive for most of the session however dip in the final hour trimmed the gains," Ajit Mishra, SVP - Technical Research, Religare Broking Ltd, said.

Vinod Nair, Head of Research at Geojit Financial Services said that while stocks witnessed a rebound on Friday, the market is facing stiff resistance at higher levels due to insipid liquidity and a lack of triggers to overcome the bears. In the broader market, the BSE midcap gauge climbed 1.31 per cent and smallcap index advanced 0.57 per cent.

Among BSE sectoral indices, metal jumped 2.71 per cent, healthcare rallied 2.22 per cent, oil & gas (1.30 per cent), commodities (1.25 per cent), energy (1.16 per cent) and power (1.02 per cent). IT and teck were the laggards. On the weekly front, the BSE benchmark fell 180.74 points or 0.27 per cent, and the Nifty declined 35.95 points or 0.18 per cent.

In Asian markets, Tokyo ended lower. Markets were closed in Hong Kong, Shanghai, Taiwan and Seoul. European markets were trading in positive territory. The US markets ended in the green on Thursday.

Rupee rises 14 paise to 83.05 against US dollar MUMBAI, Sept 29: The rupee

Analysts said the rupee also strengthened due to a significant decline in India's current account deficit (CAD). However, rising interest rates and US bond yields prompted foreign investors to stay in selling mode. Berger Paints expects margin stability amid rising crude prices

KOLKATA, Sept 29: Berger Paints India Ltd, the country's second-largest paint manufacturer, does not foresee any significant impact on its profit margins despite the recent surge in crude oil prices, according to a senior company official.

Production of paint heavily depends on crude-based derivatives which are used as raw materials.

Berger said the current pain is mostly covered with its previous price increases and is not considering any further hikes in the festive

season to push sales. However, if crude oil prices continue to remain elevated for a longer duration, the company anticipates a potential dip in profits compared to the first quarter levels.

"If the prices remain at this level, which we expect, we see no immediate or significant impact going forward, except that profitability may

be lower than in Quarter 1," Berger Paints Managing Director & CEO Abhijit Roy told PTI.

Brent crude, a benchmark for India, has at one point of time surged to nearly USD 98 per barrel from USD. 75 in July. It is currently trading around USD 93.3 per barrel. Roy pointed out that there is sufficient finished stock in the system to sustain operations until Novemuntil the third quarter.

Roy expressed concern that if crude oil continues

to hover above USD 100 for an extended period, it could start to exert pressure on the company's finan-

Despite these challenges, the paints maker is banking on a robust third quarter (September to December) due to the extended gap between the monsoon season

and the delayed festive season. Berger Paints witnessed double-digit volume growth in the first quarter ending June and is aiming at retaining this growth mo-

China Evergrande, the world's most heavily indebted real estate developer, said in a notice to the Hong Kong Stock Exchange that its shares would remain suspended until further notice after they plunged nearly 20 per cent on Wednesday and were suspended

from trading as of Thursday. Evergrande is at the centre of a property market crisis that is dragging on China's economic growth.

Stocks are still on track for their worst month of the year as Wall Street grapples with a new normal where interest rates may stay high for a while. The Federal Reserve has pulled its main interest rate to the highest level since 2001 in hopes of extinguishing high inflation, and it indicated last week it may cut rates by less next year than earlier expected.

It's a sharp departure from prior years for investors who counted on the Fed to cut rates quickly and sharply whenever things looked dicey. Lower rates can goose financial markets, while high rates slow the economy by design and hurt prices for stocks and other investments.

The threat of higher rates for longer has pushed Treasury yields up sharply in the bond market. The yield on the 10-year Treasury climbed above 4.67 per cent in the morning, near its highest level since 2007. It later fell back to 4.57 per cent, down from 4.61 per cent late Wednesday. The two-year Treasury yield, which moves more on expectations for Fed action, slipped to 5.06 per cent from 5.14 per cent.

Many other challenges are also looming over the economy and Wall Street besides the threat of higher interest rates for longer. Most immediate is the threat of another U.S. government shutdown as soon as this weekend, though financial markets have held up rather well during past shutdowns.

Yields squiggled following the latest batch of reports on the economy.

One said fewer workers applied for unemployment benefits last week than economists expected. It's the latest signal of a solid job market, one that has helped prevent a recession but may also be feeding upward pressure into inflation.

A separate report said the U.S. economy grew at a 2.1 per cent annual rate during the summer, following some revisions to earlier estimates. That was below economists' expectations, but economic growth looks like it's remained solid through the third quarter at least. The question is how the trend goes in the final three months of the year.

Altogether, the reports didn't give anything to change investors' minds about the Fed staying tough on interest rates, something that Wall Street calls a hawkish stance on policy. (PTI)

India calls for Global Stocktake to address gaps in climate funding

NEW DELHI, Sept 29: The firstever Global Stocktake should "accentuate" the gaps in funding between the scale of the requirement in developing nations and the available public and additional funding. India has said.

The Global Stocktake is a twoyear review by the United Nations to evaluate progress toward the Paris Agreement goals. Started at COP26 in Glasgow, this process will conclude at COP28 in Dubai.

In a submission to the United Nations Framework Convention on Climate Change (UNFCCC) outlining its expectations for the Global Stocktake, India emphasised that it should identify obstacles to the support provided by developed countries in terms of finance, technology deployment and transfer, and capacity building for the developing nations.

India called for an assessment under the Global Stocktake process to examine the gaps in the efforts of the developed countries to control and mitigate their emissions, considering the differenti-



ated responsibilities outlined in the Paris Agreement.

The country pointed out that the Intergovernmental Panel on Climate Change (IPCC) had previously highlighted "significant gaps in pre-2020 action".

The IPCC had indicated that the developed countries must reduce their greenhouse gas emissions by at least 25-40 per cent below 1990 levels by 2020 and revisit their 2020 targets no later than 2014.

India also underscored that Annex I countries -- a group of na-

tions that are part of the Annex I to the UNFCCC and considered to be more economically developed and industrialised -- had only reduced emissions by 5 per cent between 2008-2012.

Annex I countries are generally expected to take the lead in combating climate change and reducing greenhouse gas emissions.

According to the UNFCCC Secretariat's assessment, despite committing to cut greenhouse gas emissions by at least 18 per cent relative to 1990 levels between 2013 and 2020, the actual achievement is only 13 per cent. India argued that these commitments from the developed world fell significantly short of what is needed, based on scientific recommendations. It called for the Global Stocktake outcome to provide details of support from the developed countries concerning technology development and transfer. It aims to assess how much technology transfer has already occurred and identify the gaps remaining. A similar process should be applied to capacity building support.

Regarding global finance goals, India suggested that the Global Stocktake should assess the overall impact of financial support provided to the developing countries and identify any gaps in such support. India stressed that the Global Stocktake should not solely focus on assessing the gaps in mitigation support but also include a review of the gaps in the support provided for adaptation to ensure parity between adaptation and mitigation efforts. tion and TRD (Track Renewal and Maintenance) block operations. A series of train services, including the Katihar-Siliguri Intercity Express, Siliguri-Balurghat Intercity Express, Radhikapur-Siliguri DEMU Special, and Malda Court-Siliguri DEMU Special, among others, have been cancelled for journeys commencing on specific dates in October.

The Khalistan Question

s India braces itself for the 18th Lok Sabha elections scheduled for early 2024, one question looms large: will Khalistan emerge as a central campaign issue for Prime Minister Narendra Modi and the Bharatiya Janata Party (BJP)? To understand this, let's reflect on Modi's remarkable electoral journey. In 2019, he secured a resounding victory in the 17th Lok Sabha elections, surpassing even his 2014 triumph. This success was attributed in part to the heightened attention generated by the tragic incident where 40 CRPF personnel lost their lives en route from Jammu to Srinagar. Modi's perceived retaliatory airstrike on Balakot in northwest Pakistan further solidified his image as a resolute leader. The Khalistan issue reared its head after the recent G20 summit, where Canadian Prime Minister Justin Trudeau raised concerns about the assassination of Hardeep Singh Nijjar, the President of the Surrey Gurdwara in British Columbia. Nijjar was also identified by the National Investigation Agency (NIA) as the leader of the Khalistan Tiger Force (KTF) and was reportedly killed by unidentified assailants believed to be Indian agents. This incident reignited discussions surrounding Khalistan, which had previously been dormant.

In response, Prime Minister Modi took swift action, downgrading diplomatic activities involving Canada. This move sent shockwaves, particularly among the Punjabi community, especially Sikhs with close family ties in Canada. Canada is home to the world's secondlargest Sikh population, and Sikhs hold significant positions in Canadian politics and government. This community maintains strong connections with their homeland, often traveling back and forth, further facilitated by direct flights between Amritsar and Toronto... When Shiromani Akali Dal (SAD) president Sukhbir Singh Badal expressed these concerns to Union Home Minister Amit Shah, it caused unease among Punjabis, particularly Sikhs. It's important to note that the BJP doesn't wield significant political influence in Punjab. When the party has secured parliamentary constituencies in the state, it has typically relied on alliances or popular figures like Hema Malini and Sunny Deol. However, their success in Punjab depends on substantial Sikh support, making overemphasizing the Khalistan issue a risky move. But history shows that Modi can leverage national security issues effectively, as seen in the Pulwama-Balakot events during the 2019 Lok Sabha elections. Khalistan could become a potent issue for the ruling party, potentially placing the INDIA bloc at a disadvantage. The Congress party has already voiced support for the government's stance. Once Modi takes a strong position on the Khalistan threat, the Opposition may struggle to maintain a firm position on national security, as seen during the Kargil conflict and

Adding to the tension is the recent killing of Sukhdool Singh Gill, a Khalistani terrorist according to the NIA. He met a fate similar to Nijjar, shot dead in Winnipeg, Canada, by unidentified assailants. Both victims were politically active, advocating for Sikh issues, and both fell to unknown attackers. The question now is whether these events will escalate tensions or prompt the Canadian government to seek de-escalation. In the coming months, the Khalistan issue will continue to evolve, with political consequences in both India and Canada. As we watch these developments, it's crucial for all stakeholders to approach this sensitive matter with diplomacy and caution, keeping the welfare of their citizens and the spirit of international cooperation at the forefront of their actions.

India's South East Asia Policy

Earlier this month, the diplomatic bustle at the national level was focussed on G20 Summit. However, in addition to that the prime minister also focussed on India's Look East policy and participated at ASEAN and East Asia Summit in Indonesia. focussing on ways to counter China's regional dominance

The G20 New Delhi Summit in early September was in fact a global brand and image making exercise for the Government of India. An exercise in which the Prime Minister Modi, G20 Sherpa Amitabh Kant and Minister of External Affairs S Jaishankar were equally involved and committed and achieved the task with a finesse. The cherry on top was the adoption of the New Delhi Declaration, which was adopted unanimously at the summit.

However, Prime Minister Modi as a leader of the Global South and keeping in mind India's strategic and regional priorities, in spite of his heavy commitment to the G20 Summit, undertook a whirlwind tour of the Indonesian capital Jakarta, in order to attend the ASEAN and East Asia Summit.

This shows the priorities of the GoI at both the regional and global level. On one hand India was hosting the prestigious G20 Summit but on the other hand it didn't overlooked its regional priorities and strategy.

Let's take a look at the reasons for PM Modi to fly to Jakarta to participate at these two events. In fact, India is evolving into a strategic actor in Southeast Asia.

It has promoted ties – diplomatic, trade, defence and people to people, with almost all countries in the region from Vietnam, to Philippines to Indonesia, Malaysia, Cambodia, Laos, Brunei, Thailand, Singapore, Japan and S. Korea.

Over the years, India has

signed an arms deal with Vietnam, stood with Philippines over China on sovereignty disputes in the South China Sea, and has increased defence cooperation with Indonesia.

The manner it has managed the balance-of-power politics in the regionis a classic model of diplomacy. Basically, China's aggressive posture in and around the South China Sea is driving India and its partners in the region together. Though these bilateral and multilateral relationships have not transformed into anyformal alliances, but the trend is clear. India's regional forays will increasingly complement the United States' Indo-Pacific strategy to counter

China in the coming years. India initiated its Look East

By: Asad Mirza policy in 1991, which was transformed into an Act East policy in 2014, when India initiated a proactive engagement policy in the region to prevent it from falling a prey to the Chinese domination. Under Prime Minister Modi, India in recent years has steadily strengthened key partnerships across Southeast Asia, particularly with countries along the maritime rim of the Indo-Pacific.

These moves are clearly designed to cooperate with Southeast Asian partners, who besides supporting the international rules-based international order insist on regional norms of behaviour in the face of rising Chinese assertiveness in the region.



enjoy a "comprehensive strategic partnership" after Modi visited Vietnam in 2016. In contrast, the United States is only a "comprehensive partner" for Vietnam, two levels below India's status. Washington has struggled to raise the partnership and President Biden's recent visit to Vietnam was part of this endeavour.

The Philippines, an old and U.S.'s treaty ally, has also expanded security partnership with India. Late last month, Philippine Foreign Secretary Enrique Manalo visited New Delhi and met with his Indian counterpart, S. Jaishankar. For

India has also remained committed to evolve a security partnership with Indonesia. Indo-Indonesian defence relations got a boost in 2018, when Modi visited Jakarta and elevated relations to a comprehensive strategic partnership. The two nations also initiated a new naval exercise, Samudra Shakti, which incorporated a warfighting component. In addition the two countries are exploring potential air force cooperation as well. Indonesia may also follow in the footsteps of the Philippines by purchasing BrahMos missiles. India is also cooperating with

Malaysia, on the basis of an enhanced strategic partnership signed in 2015. Although Kuala Lumpur's decision earlier this year to cancel a deal to purchase Indian-made Tejas fighter aircraft may have dampened the partnership somewhat, the intent clearly remains to strengthen ties in line with upholding the mutual goal of maintaining the rules-based international order in the region especially internationally recognised maritime borders and

which Beijing accepts. Brunei is another emerging partner for India along the South China Sea. In 2021, the two nations renewed their defence agreement for five years, and they regularly engage in joint exercises, port visits by navy and coast guard ships, and official defence exchanges.

freedom of navigation, neither of

India's strategic partnerships with Singapore and Thailandare also close and longstanding. Singapore regularly engages in bilatexercises, high-level dialogues, visits, and professional training with India. Modi visited Singapore twice in 2018, and on the first trip, he signed 35 memoranda of understanding agreements on a range of security and economic issues.

In 2022, India and Thailand renewed their partnership and pledged to elevate defence engagements further, to include cybersecurity. Perhaps of greater

importance is the economic side of their relationship. In a nod to New Delhi's original Look East policy, Bangkok implemented its own Look West policy in 1997, in part to tap into the enormous Indian market. Moreover, Thailand and India are partnering with Myanmar to construct the India-Myanmar-Thailand Trilateral Highway that will significantly upgrade transport links between Southeast Asia and South Asia. Once the highway is completed, Modi and his government also want to add connections to Cambodia, Laos, and Vietnam - another clear rival to China's BRI. India further has good relations

with both Cambodia and Laos. In May, Cambodian King Norodom Sihamoni visited India, and the two sides reaffirmed "the strong civilisational bond" between the two nations. Phnom Penh and New Delhi cooperate on a range of socioeconomic projects, demining, water conservation, and heritage protection. India's engagement with Laos is less robust, but nevertheless, New Delhi and Vientiane are likely discussing ways to boost economic ties. This is all the more remarkable as both Phnom Penh and Vientiane are widely considered to be firmly in China's Overall, India's proactive Act

East policy is also a net positive for the U.S.'s Indo-Pacific strategy aimed at countering China. To provide a further impetus to New Delhi to do even more, the U.S. should also help India in its infrastructure and developmental projects, as well as trade deals, which could help lessen Beijing's economic dominance of Southeast Asia. However, New Delhi's policy of practical outreach to Southeast Asia - even if it were sustained only at current levels - would help further undermine Beijing. India's inflation battle: The perennial fiscal challenge

The official inflation rate for India in August stood at 6.83%, marking a decrease from the previous month's 7.44%. However, it remains above the 6% maximum threshold set as the red line by the Reserve Bank of India (RBI). Since the shift to inflation targeting in 2016, the acceptable range for the consumer price index (CPI) has been between 2% and 6%. Notably, this marks the seventh instance in the past year where the monthly inflation rate has exceeded 6%. This persistent trend may raise concerns within the RBI's Monetary Policy Committee (MPC). While there is a need to tighten the money supply further in order to combat inflation, the MPC has chosen to maintain the current interest rate, banking on the hope that inflation will naturally decrease. The RBI Governor has also hinted that high inflation is expected to persist for some time.

India's consumer price index is comprised of approximately 450 distinct items within the consumption basket, with variations tailored for rural and urban consumers. Notably, nearly 49% of the index's weight is attributed to food and related items. Consequently, when food inflation surges, it invariably drives up overall inflation rates. Presently, food inflation, carrying almost half of the weightage, stands at 10%, largely due to the escalating prices of vegeta-

even cereals. India has adopted a strategy involving the prohibition of exports

bles, oilseeds, pulses, milk, and

or imposing substantial export taxes on a range of agricultural commodities, such as wheat, rice, sugar, and onions. These measures have a direct impact on the income of farmers who had anticipated substantial profits from overseas sales. For instance, in 2022, India

successfully exported 7.4 million tonnes of parboiled rice, but it currently enforces a significant 20% export duty on this product. Given that India accounts for a substantial 40% share of global rice exports, these restrictions have contributed to a heightened scarcity of rice on the world market.

The export restrictions imposed by India have had a notable impact on importing nations such as China, the Philippines, Bangladesh, Indonesia, and Nigeria. In the Philippines, the surge in rice prices has even raised the possibility of a minister's resignation. However, the question arises: has the export ban or tax effectively curbed rice inflation within India? The answer appears to be in the negative, primarily because the export tax is primarily applied to broken rice, which is largely destined for ethanol production.

Utilizing food resources for the production of vehicle fuel remains a contentious policy, particularly during a period of elevated global food inflation. The Food and Agriculture Organisation's (FAO) all rice price index, for example, escalated by 9.8% in August, reaching a 15-year peak. Such inflationary pressures are likely to permeate India as well. While the ethanol policy is primarily driven by the aim to conserve valuable foreign exchange spent on crude oil imports, the domestic consequences of rising food prices necessitate a thoughtful reconsideration of using food crops for fuel production.

Beyond the challenges posed by food inflation, the outlook for crude oil prices is also signaling sustained high costs. Factors such as supply reductions from Russia and Saudi Arabia have already pushed oil prices past the \$85 mark, and they are expected to remain elevated. This development has adverse implications for India's imports, potentially leading to a further decline in the Indian rupee's value from 83 to 85 against the dollar. To counter the escalating oil import bill, the nation's reliance may pivot toward bolstering exports in the soft-

ware and IT services sector. However, this endeavor is not without its hurdles, given the noticeable slowdown in the software industry. Nonetheless, the medium to long-term prospects for India's software services sector remain robust, as underscored by NASSCOM, the industry's governing body.

Beyond the concerns surrounding food inflation, soaring oil prices, and the depreciating rupee-dollar exchange rate, a substantial driver of the current inflationary trend in India is the size of the fiscal deficit. The nation is grappling with a pronounced deficit, coupled with a mounting national debt, and efforts to rein it in appear to yield limited results. It's worth noting that during the pandemic, the fiscal deficit naturally expanded as the government implemented emergency relief measures, including provisions for free food, subsidized loans, and increased liquidity. However, certain decisions have raised eyebrows, such as the ongoing free food grain program, which has been in operation for over 48 months and has cumulatively cost the exchequer 4.5 lakh crore. Additionally, the recent cabinet announcement of a ₹1.7 trillion revival package for the debt-ridden telecom company Bharat Sanchar Nigam Limited has garnered attention.

a parliamentary inquiry, public sector banks in India have effectively written off nearly 15 trillion rupees in bad loans. This

Over the course of the last seven years, in response to

action bears fiscal consequences, as it necessitates the infusion of equity capital into these banks by the central government. The writeoffs may have played a role in contributing to a lower bad-loan ratio and the overall enhancement of the banking sector's health. However, it is undeniable that the government's fiscal expenditures have become increasingly

exerting inflationary pressures on the economy. India's fiscal predicament is more critical than officially acknowledged. When assessing the debt service ratio, which quantifies the portion of the government's revenue allocated solely for servicing its escalating debt burden, India significantly exceeds the global median. The persistently high deficit contributes to elevated interest rates, putting critical sectors such as housing, real estate, and industrial projects at a disadvantage.

India made significant efforts to curb its propensity for deficit spending by enacting legislation in the form of the Fiscal Responsibility law in 2003. This law set a legal limit, capping the fiscal deficit at 3% of the GDP. However, the harsh reality remains that India has consistently exceeded this limit every year, rendering the Fiscal Responsibility and Budget Management (FRBM) law ineffective. Even a review of the law conducted just before the pandemic is unlikely to offer a substantial remedy, as both debt and deficit levels far exceed what is considered healthy for the economy.

In the tumultuous and competitive landscape of a democratic society, there is a persistent demand for increased spending from vocal interest groups and vested stakeholders. Additionally, there is a growing inclination to provide free benefits and incentives. Moreover, the recently introduced industrial policy, offering initiatives like Production Linked Incentives and import protection, further compounds the fiscal implications. These measures, whether beneficial or detrimental, not only jeopardize the sustainability of India's debt and fiscal posture but also contribute to mounting inflationary pressures. The deep-rooted and substantial fiscal influence, a perpetual burden on India, cannot be simply rectified by tightening monetary policies, even as these policies exhibit restraint. Congress needs to start talks with SP on seat sharing immediately

ongress is in dominant position in the three election bound states of the Hindi belt – Rajasthan, Madhya Pradesh, and Chhattisgarh. Hence, the party may decide not to initiate seat sharing talks with Samajwadi Party (SP), which has only marginal presence in Madhya Pradesh, while very little presence in Rajasthan, and insignificant presence in Chhattisgarh. However, it would be a grave political mistake impacting political prospect of the Congress in the long run, especially during Lok Sabha election 2024 in Uttar Pradesh, where SP has dominant position.

What the Congress and SP need at present is sending a clear message to the anti-BJP electorate that they are united, which ultimately would boost the morale of rank and file of both the parties along with the entire INDIA alliance partners and the secular electorate across the country who are aiming at defeating PM Modi and BJP in 2024. Any message of disunity may make the secular voters dishearten and hopeless on the one hand, and boost the morale of PM Narendra Modi and RSS-BJP clan on the other.

The reports presently emanating from Uttar Pradesh suggest that both the Pradesh Congress and SP leaders are engaged in flexing their muscles on how many seats they should contest in the Lok Sabha election. Given this backdrop, immediate initiation of talks may halt the war-of-words between the leaders from both sides, which may help the both the parties to ease roadblock in seat sharing talks in

It is worth mentioning here that both the Congress and SP eaderships seem to have harden their stance on seat sharing n Uttar Pradesh. Even SP president Akhilesh Yadav has given enough hints of hard bargaining by saying "SP is not demanding seats but giving them (Congress).

SP is presently adamant on contesting maximum number of seats among 80 Lok Sabha seats while conceding to give only a few seats to Congress. Sources said that SP is not ready to give more than 5-6 seats to Congress, since it has to also accommodate Rashtriya Lok Dal (RLD), Bhim Army, and Apna Dal (K).

Congress wants to contest on about two dozen seats, which the SP is not willing to concede. SP wants to give Congress as per its performance in 2019 Lok Sabha elections when it won only one seat, while Congress wants seat sharing on the basis of 2009 election results when it won 21

Given such a roadblock in Uttar Pradesh, the initiation of seat sharing talks with SP for the three poll bound states will be important, where SP would not be much demanding.

SP has marginal presence in only Madhya Pradesh, where the party had won 1 seat in the Vidhan Sabha election 2018, while the Congress had won 114 seats out of total 230. BJP could win only 109 seats. Congress vote share was 40.89 per cent as against 41.02 per cent of the BJP. SP's vote share was 1.3 per cent. For Congress it would be better to improve its vote share in the state given the latest moves of the BJP which has fielded several party stalwarts to retain its power in the state. Other state parties with presence in Madhya Pradesh include AAP. It is therefore important for the Congress to initiate seat sharing talks with both, to benefit from the alliance in other states.

In Rajasthan also Congress is in dominant position. Out of 200 seats it had won 100 seats in 2018, and the 6 of BSP MLAs have merged with it later. SP has no seat in the state, but RLD has 1 seat. CPI(M) has also 2 seats. SP has little support base and in 2018 its vote share was 0.18 per cent. RLD's vote share was 0.33 per cent and AAP's 0.38 per cent. Sign languages as Career

re should be aware that according to the World Federation of the Deaf, there are more than 70 million deaf people worldwide. More than 80% of them live in developing countries. Collectively, they use more than 300 different sign languages. As per the 2011 Census, the total population of deaf persons in India numbered about 50 lakh. The needs of the deaf community have long been ignored and the problems have been documented by various organizations working for the deaf. Obsolete training methodology and teaching systems need urgent attention which brings opportunity to choose sign languages as a career

Sign Language is a system of communication that involves hand gestures and signs to communicate with deaf people. Each country has its own Sign Language system, like American Sign Language or Indian Sign Language. These are fully fledged natural languages, structurally distinct from the spoken languages. There is also an international sign language, which is used by deaf people in international meetings and informally when travelling and socializing.

The Convention on the Rights of Persons with Disabilities recognizes and promotes the use of sign languages. The United Nations General Assembly has proclaimed 23 September as the International Day of Sign Languages in order to raise awareness of the importance of sign language in the full realization of the human rights of people who are deaf. The day is a unique opportunity to support and protect the linguistic identity and cultural diversity of all deaf people and other sign language users.

One may choose sign languages as their career choice in life .There are Sign Language courses dedicated to teaching basic to advanced, online and offline. There are certifications, PG diploma and other courses in the field of Sign Language. This course is a requirement for those who wish to take up work as interpreters of Sign Language. In the near future there shall be a requirement for many Sign Language Interpreters who will be interpreting at different community or public places such as hospitals, railway stations, etc.

Course fees vary from institute to institutes and diplomas are from 4 months to 6 months.

There are online courses apart from offline courses. Some popular online courses are Learn and Master Sign Language, Educating Deal Children: Becoming an Empowered Teacher, Introduction to Catalan Sign Language: Speaking with Your Hands and Hearing with Your Eyes, Professional Certificate in American Sign Language Science, Indian Sign Language and Sign Quiz, etc.

ISLRTC: In the 2000s, the Indian deaf community advocated for an institute focused on ISL teaching and research. The 11th Five Year Plan (2007-2012) acknowledged that the needs of people with hearing disabilities had been relatively neglected and envisaged the development of a sign language research and training center, to promote and develop sign language and training of teachers and interpreters. The Finance Minister announced the setting up of Indian Sign Language Research and Training Center (ISLRTC) in the Union Budget speech of 2010-11. As a result, in 2011, the Ministry of Social Justice and Empowerment approved the establishment of the ISLRTC as an autonomous center of the Indira Gandhi National Open University (IGNOU), Delhi. The foundation stone



of the center was laid at IGNOU campus on 4th October, 2011. In 2013, the center at IGNOU was closed. After a long struggle by the deaf community, the Ministry approved the establishment of ISLRTC in New Delhi on 28th September, 2015.

There is a need for ISL interpreters which is an urgent requirement at institutes and places

where communication between deaf and hearing people takes place but India has less trained people which means it brings opportunity for the trained people to become ISL interpreters. 56 people killed in two suicide blasts in Pakistan

KARACHI, Sept 29: A powerful suicide blast ripped through a mosque in Pakistan's restive Balochistan province on Friday. killing at least 52 people and injuring over 50 others gathered to celebrate Prophet Muhammad's birthday, authorities said.

Hours later, another blast at a mosque in Khyber Pakhtunkhwa's Hangu city killed at least three people and injured five others.

The blast in Balochistan occurred near Madina Mosque on Al Falah Road in the Mastung district. No group has claimed responsibility for the attack.

Mastung's Deputy Superintendent of Police (DSP) Nawaz Gashkori, who was on duty for the rally, was among the deceased.

The explosion took place when people were gathering to mark Eid Miladun Nabi, the birth anniversary of Prophet Muhammad.

City Station House Officer (SHO) Mohammad Javed Lehri said the explosion was a "suicide

Balochistan interim Information Minister Jan Achakzai said rescue teams have been dispatched to Mastung. He added the critically injured persons are being transferred to Quetta and that an emergency has been imposed in all the

Stating that "terrorists have no faith or religion", Bugti asserted that all resources were being put to use during the rescue operation. He added that no effort would be spared in treating the injured and that terrorist elements did not deserve any concession.

Meanwhile, Pakistan Muslim League-Nawaz (PML-N) President and former premier Shehbaz Sharif said that carrying out such a despicable act on an occasion marking the birth of the Holy Prophet is detestable now and in the hereafter.

He condemned the attack and offered condolences to the families of the deceased and injured. Soon after the explosion in

Balochistan, the Punjab police also said that its officers were performing security duties for Friday prayers at mosques across the province.

Meanwhile, the Karachi police said that Additional Inspector General Khadim Husain Rind has directed the police to remain "completely on high alert" in view of the Mastung blast.

He directed the policemen to tighten security arrangements regarding Eid-i-Miladun Nabi processions and Friday prayers across the city, as well as to monitor any unusual activities.

This is the second major blast that has terrorised Mastung over the last 15 days, Geo News re-

Earlier this month, at least 11 people were injured in a blast in the same district. Mastung has remained a target of terror attacks for the past several years with a major attack in July 2018 being one of the deadliest in the district's history during which at least 128 peo-

Extremist attack kills at least 12 soldiers in Niger



NIAMEY (Niger), Sept 29: An attack by Islamic extremists in western Niger killed at least a dozen soldiers and wounded seven others, the West African nation's military junta said. The soldiers were on a mission in the Tillaberi region town of Kandadji when hundreds of jihadis on motorcycles attacked them Thursday, Gen. Salifou Mody, Niger's defence minister, said in a statement.

The wounded were evacuated to military hospitals, the statement said. The junta claimed that military personnel killed a hundred extremists and destroyed their motorcycles and weapons. The Associated Press was not able to independently ver-

Niger has battled a jihadi insurgency linked to Al-Qaeda and the Islamic State group for years. Attacks have increased since mutinous soldiers toppled the country's democratically elected president, Mohamed Bazoum, in July. During the month after the junta seized power, violence primarily linked to the extremists soared by more than 40 per cent, according to the Armed Conflict Location and Event Data Project. Jihadi attacks targeting civilians quadrupled in August compared with the month before, and attacks against security forces spiked in the Tillaberi region, killing at least 40 soldiers, the project reported.

Niger was seen as one of the last democratic countries in Africa's Sahel region that Western nations could partner with to beat back the jihadi insurgency in the vast expanse below the Sahara Desert.

The United States, France and other European countries poured hundreds of millions of dollars into shoring up the Nigerien military.

Amid a swell of anti-France sentiment in its former colony., French President Emmanuel Macron announced the withdrawal by the end of the year of his country's 1,500 troops stationed in Niger.

France's ambassador to Niger, Sylvain Itte, left the country this week after a months'-long standoff with the junta, which had ordered him out. The loss of support from France and potentially from the United States will make it hard for the junta to stave off the jihadis,

EAM Jaishankar, US Secretary Blinken discuss global developments amid India-Canada diplomatic row

WASHINGTON, Sept 29: India and the US have emphasised the continued importance of bilateral cooperation in areas like defence, space and clean energy as External Affairs Minister S Jaishankar met Secretary of State Antony Blinken and exchanged notes on global developments, amid a simmering diplomatic row between India and Canada over the killing of a Khalistani separatist.

However, the two sides remained tight-lipped about the direct or indirect implications of the diplomatic row between India and Canada over the killing of Sikh separatist Hardeep Singh Nijjar in British Columbia early this year.

YEREVAN (ARMENIA), Sept 29: More than 10% of Nagorno-Karabakh's original population has fled to Armenia as the region's separatist government said it will dissolve itself and the unrecognised republic inside Azerbaijan will cease to exist by year's end after

a three-decade bid for independence. By Friday morning 84,770 people had left Nagorno-Karabakh, according to Armenian officials, continuing a mass exodus from the region of ethnic Armenians that began Sunday. The region's population was around 120,000 before the exodus began.

The moves came after Azerbaijan carried out a lightning offensive last week to reclaim full control over the breakaway region and demanded that Armenian troops in Nagorno-Karabakh disarm and the separatist government disband.

A decree signed by the region's separatist President Samvel Shakhramanyan cited a Sept 20 agreement to end the fighting under which Azerbaijan will allow the "free, voluntary and unhindered movement" of Nagorno-Karabakh residents to Armenia. Some of those who fled the regional capital of Stepanakert said they had no hope for the future.

"I left Stepanakert having a slight hope that maybe something will change and I will come back soon, and these hopes are ruined after reading about the dissolution of our government," 21-year-old student Ani

Abagnyan told The Associated Press on Thursday During the three decades of conflict in the region. Azerbaijan and separatists inside Nagorno-Karabakh, alongside allies in Armenia, have accused the other of targeted attacks, massacres and other atrocities, leaving people on both sides deeply suspicious and fearful. While Azerbaijan has pledged to respect the rights of ethnic Armenians in the region, most are now fleeing as they do not believe the Azerbaijani authorities will treat them fairly and humanely or guarantee them their language, religion and culture.

After six years of separatist fighting ended in 1994 following the collapse of the Soviet Union, Nagorno-Karabakh came under the control of ethnic Armenian forces, backed by Armenia. Then, during a six-week war in 2020, Azerbaijan took back parts of the region in the south Caucasus Mountains along with surrounding territory that Armenian forces had claimed earlier. Nagorno-Karabakh was internationally recognized as part of Azerbaijan's sovereign territory.

Armenia alleged the closure denied basic food and fuel supplies to Nagorno-Karabakh. Azerbaijan rejected the accusation, arguing that the region could receive supplies through the Azerbaijani city of Aghdam - a solution long resisted by Nagorno-Karabakh authorities, who called it a strategy for Azerbaijan to gain control of the region. Inflation drops sharply in Europe; it offers a glimmer of hope, but higher oil prices loom

FRANKFURT, Sept 29: Inflation that has been plaguing Europeans declined sharply in September, strengthening hopes that consumers will eventually get relief from costlier groceries, vacations and haircuts — and that the European Central Bank won't have to further restrict the economy by raising interest rates from alreadyrecord highs.

The annual rate was 4.3% this month, a drop from 5.2% in August. But recently higher oil prices are casting a shadow over prospects for beating inflation back down to the central bank's target of 2%. Core inflation, which excludes volatile fuel and food prices, fell more than analysts expected — to 4.5% from 5.3%, according to data released Friday by the European Union's statistics agency, Eurostat. The ECB closely watches this figure to assess how inflation is coming down.

The fall in core inflation "reinforces our view that the ECB has finished raising interest rates," said



Jack Allen-Reynolds, deputy chief eurozone economist at Capital Economics. He predicted that the overall inflation rate would tumble to 3.5% by the end of the year.

Energy prices dropped 4.7% in September, while food price inflation remained uncomfortably high at 8.8%. Readings across the major economies that use the euro currency were a mixed bag. Germany's annual inflation fell to 4.3% in September from 6.4% a month earlier, while

Spain's increased to 3.2% from 2.4%. Economists warn, however, that the large drop in Germany, the 20-country eurozone's largest economy, was exaggerated by a statistical quirk — the end of a subsidised transportation ticket and a fuel subsidy in September 2022 that had

raised consumer prices that month.

The latest inflation figures follow what may have been the final interest rate increase by the ECB in its swift series of hikes. It brought

its benchmark deposit rate to a record high of 4% this month, up from minus 0.5% in July 2022.

ECB President Christine Lagarde said that if interest rate levels are maintained for a "sufficiently long duration", that would make a substantial contribution to returning inflation to 2%, a goal the bank does not expect to reach until 2025. High prices have been holding back the European economy because people's paychecks don't go as far as they used to in covering their bills, forcing them to cut back on other spending. Economic growth has stagnated to just above zero in the first six months of the year, with some indicators pointing to a downturn in the current Julyto-September quarter.

This burst of inflation was set off as the global economy rebounded from the COVID-19 pandemic, leading to shortages of parts and raw materials. It got worse when Russian invaded Ukraine, sending energy prices soaring as Moscow cut off most

Supply chain bottlenecks and energy prices have eased, but inflation has worked its way through the economy. Prices are higher for services such as haircuts and hotel stays, and workers have demanded pay raises to make up for their lost purchasing power. The ECB has been trying to get a handle on inflation by raising interest rates, which make it more expensive to borrow for big purchases such as houses or new factory equipment to expand a business. That reduces demand for goods and, in turn, inflation. But higher rates also can weigh on economic growth, leaving the central bank facing a balancing act over how far to go.

Many economists think the ECB has finished raising rates unless something drastic happens to keep inflation from falling further. That could be a further increase in oil prices, which have risen recently after major producers Saudi Arabia and Russia extended production cuts. (AP)

Seattle police officer who joked after Indian student's death taken off patrol duty

SEATTLE, Sept 29: A Seattle Police officer, who joked about the horrific death of a 23-year-old Indian student earlier this year, has been pulled off patrol duty, weeks after the South Asian community here demanded action against him. Jaahnavi Kandula was killed by an over-speeding police car while

crossing a street in January. The department Thursday confirmed by email that Officer Daniel Auderer "has been administratively reassigned to a non-operational position," said a report in The Seattle Times.

Auderer was a member of the SPD's traffic squad and vice president of the Seattle Police Officers Guild. The police department had released footage from a body-cam earlier this month in which Auderer can be seen laughing about the deadly crash and dismissed any implication that another officer, Kevin Dave, might be at fault or that a criminal investigation was necessary, the report said.

Dave was responding to a report of an overdose and driving at 74 mph about 119 kmph) in a 25-mph zone when he struck Kandula, who was thrown more than 100 feet. The video footage showed Auderer, who was involved in the investigation, calling Kandula a "regular person" and suggesting that the department "write a check". "USD 11,000. She was 26 anyway," he said, misstating Kandula's age.

Students in Bangladesh demand justice for the two slain students in Manipur

PM to visit Telangana tomorrow, will inaugurate devp projects worth over ₹ 13,500 crore

ter Narendra Modi will visit Telangana on Sunday during which he will lay the foundation stone and dedicate to the nation multiple developmental projects worth more than ₹ 13,500 crore, his office said. At 2:15 PM on Sunday, the prime minister will reach Mahabubnagar district, where he will dedicate to the nation and lay the foundation stone of multiple developmental projects worth more than ₹ 13,500 crore, in important sectors such as road, rail, petroleum and natural gas and higher education. During the programme, the prime minister will also flag off a train service through video conferencing, a statement issued by the Prime Minister's Office (PMO) said.

In a step that will provide impetus to the prime minister's vision of development of modern road infrastructure across the country, foundation stone and dedication to nation of multiple road projects will be done during the programme, it said.

Prime Minister Modi will lay the foundation stone of key road projects that are part of Nagpur-Vijayawada Economic Corridor, including the 108 km long four-lane access controlled greenfield highway from Warangal to



Khammam section of NH-163G and 90 km-long four lane access controlled greenfield highway from Khammam to Vijayawada section of NH-163G. These road projects will be developed at a total cost of about ₹ 6,400 crore, the statement said. The projects will reduce travel distance between Warangal and Khammam by about 14 km; and between Khammam and Vijayawada by about 27 km, it said.

Prime Minister Modi will also dedicate to nation a road project -- four laning of 59 km long Suryapet to Khammam section of NH-365BB.

Built at a cost of about ₹ 2,460 crore, the project is a part of Hyderabad -Visakhapatnam Corridor and is developed under Bharatmala Pariyojana. It will also provide better connectivity to Khammam district and coastal regions of Andhra Pradesh, the statement said.

The Prime Minister will also dedicate 37 km of Jaklair-Krishna New Railway Line. Built at a cost of more than ₹ 500 crore, the new rail line sectrict of Narayanpet for the first time onto the Railway map. INDIA bloc will take care to ensure no disputes among partners ahead of state polls: Pawar



PUNE, Sept 29: The INDIA bloc will take precautions to ensure that there are no disputes among its alliance partners in states like Rajasthan and Madhya Pradesh where elections are due in a few months, NCP chief Sharad Pawar said on Friday.

He was speaking to reporters at Baramati in Maharashtra's Pune district. Pawar also spoke about issues like Maratha reservation and export duty on onions.

More than two dozen opposition parties have formed the Indian National Developmental Inclusive Alliance (INDIA) to take on the BJP in next year's general elections.

Replying to a question about apparent friction in West Bengal as the Congress has staked claim to some seats,

the veteran politician said there are no elections there in the immediate future. "When elections near, the possibility of differences (among INDIA bloc partners) cannot be ruled out. However, we will sort the issues by sending neutral leaders from the alliance," he

Pawar stressed that elections are due in a few months in four to five states and that is more important for them.

"INDIA bloc will see how all the alliance partners come on one page in states like Rajasthan and Madhya Pradesh. After returning to Mumbai, I will hold discussions with Congress and other party leaders and we will take precautions to ensure that there are no disputes among the alliance partners (in these states)," he said.

Will Rahul speak on issue of women safety in Rajasthan, ask Gehlot to resign: BJP

NEW DELHI. Sept 29: The BJP on Friday sharpened its attack on the Congress on the issue of women's safety in pollbound Rajasthan and demanded that former its party president Rahul Gandhi ask chief minister Ashok Gehlot to tender his resignation. Addressing a press conference at the party headquarters here, BJP national spokesperson Shehzad Poonawalla asked Gandhi to break his silence and raise questions on the functioning of his party's government under Gehlot.

This came after a partially-charred body of a woman was found on the side of a road in a village in Jaipur earlier in the morning and the police suspected it to be a case of murder.

"This is not just one incident... Rajasthan under chief minister Ashok Gehlot is leading the country in crime against women," Poonwalla claimed and cited several other cases of murder, rape and other crimes registered in the state in recent past. He further claimed that law and order in Rajasthan has been "completely destroyed" in the 4.5 years of Congress rule in the state.

"Priyanka Gandhi gave a slogan 'ladki hoon, lad sakti' (girls can fight) but

'ladki hoon to kya Rajasthan mein bach sakti hoon' (If girls are safe in Rajasthan)," he added. While Prime Minister Narendera Modi has ensured that women enjoy their constitutional right, women's right to safety is not being ensured in Raiasthan, he charged.

"Congress leaders talk about women safety and empowerment, make big claims about them. Often their leaders and spokesperson indulge in vulture politics raising the issue of women safety in other states," Poonawalla said.

"Will Rahul Gandhi, Priyanka Gandhi Vadra visit Rajasthan, take up the issue in the state with the chief minister and ask for his resignation," he wondered. The BJP spokesperson referred to some recent cases of crime against women in Rajasthan and said "neither Rahul Gandhi. nor Priyanka Vadra ever come out with a statement condemning these incidents". None of the INDIA alliance partners have also come out with any statement on these incidents in Rajasthan, he charged.

"Why is this selective outrage?" Poonawalla asked Gandhi and the opposition parties' INDIA bloc in a veiled reference to their stand on violence against women

Law Commission working on formula so that 2029 onwards LS, assembly polls can be held together

NEW DELHI, Sept 29: The Law Commission is working on a formula to synchronise all assembly polls by extending or reducing the tenure so that all state elections can be held along with the Lok Sabha polls 2029 onwards, sources said on

As the government has already set up a high-level panel to explore simultaneous polls for Lok Sabha, state assemblies and local bodies, the Law Commission may also be asked to include the third tier of elections along with its current mandate for national and statelevel polls.

The sources also said the law panel is devising a mechanism to ensure a common electoral roll for Lok Sabha, assemblies and local bodies to reduce cost and use of manpower for undertaking an almost identical exercise which is carried out now by the Election Commission and various state

on simultaneous polls is not ready as some issues are yet to be settled, the sources pointed out.

For synchronising various assembly polls to ensure both state and Lok Sabha elections are held together from 2029 onwards, the Commission under Justice Ritu Rai Awasthi may suggest reducing or enhancing the tenure of legislative assemblies.

A mechanism is being devised to ensure that once Lok Sabha and assembly polls are synchronised, voters go to the polling booth only once to cast their ballot for both the

They said since assembly and parliamentary polls are held in phases, the Commission is working out modalities to see that voters do not go to polling stations more than once to cast their ballot for the

As of now the mandate of the Commission is to suggest ways to hold assembly and Lok Sabha polls together. But the high-level committee under former president Ram Nath Kovind has been tasked with recommending how Lok Sabha, assembly and local body polls (panchayat, municipalities, zila parishad) can be held together.

Keeping in mind the terms of reference of the Kovind panel, the ambit of the Law Commission can also be increased to include holding local body polls along with national and state polls, the sources

One suggestion the law panel can make is to hold the three-tier polls in two phases in one year. In the first phase, Lok Sabha and assembly polls can be held and in the

second phase, local body polls can be organised.

This, the sources said, is a practical approach keeping in mind the varied climatic conditions in the

In August 2018, the previous Law Commission had endorsed the Modi government's proposal to hold simultaneous polls to Lok Sabha and state assemblies, saying it will prevent the country from being in constant election mode, but it had sought further public discourse on the issue before arriving at a final decision.

The panel in its draft report had also said the exercise cannot be held in the present constitutional framework, and suggested changes required to carry out the two sets of polls together.

In April 2018, the law ministry had asked the Law Commission to examine the issue of holding si-

Delhi's launches action plan to check winter pollution; focus on dust, vehicular, industrial emissions

NEW DELHI, Sept 29: The Delhi government on Friday launched a 15-point action plan to mitigate air pollution in the national capital during the winter, with a strong emphasis on addressing dust pollution, vehicular emissions and the open burning of garbage.

Chief minister Arvind Kejriwal announced at a press conference that separate and specific action plans have been designed for each of the 13 air pollution hotspots of Delhi based on real-time air quality data collected from 40 monitoring stations in the national capital.

The winter action plan primarily focuses on preventing crop residue burning, dust pollution, vehicular and industrial emissions, open burning of garbage, regulating firecrackers, tree planting, ensuring effective implementation of the Graded Response Action Plan (GRAP), managing e-waste and fostering collaboration with neighbouring states, Kejriwal said. Thirteen teams have been formed to implement these action plans at the identified air pollution

"To combat crop residue burning, the Delhi government successfully implemented a free bio-decomposer technique in the past three years, which has yielded positive results. Last year, we treated 4,400

acres of farmland with the bio-decomposer method. This year, we will use it on 5,000 acres of both Basmati and non-Basmati rice fields, all free of cost," Kejriwal said. The chief minister also announced an anti-dust campaign from October 9. It includes measures such as the installation of dust control equipment at all sites exceeding 500 square metres, with real-time monitoring available through a web portal.

Kejriwal shared that 591 teams have been set up to ensure strict compliance with dust control norms, with 530 water sprinklers and 258 mobile anti-smog guns deployed to combat dust pollution. To tackle vehicular pollution, 385 teams have been formed to check Pollution Under Control (PUC) certificates and enforce the ban on 10-year-old diesel and 15vear-old petrol vehicles.

The city government has identified 90 congested roads where teams will be deployed to manage traffic and inform commuters of alternative routes.

The government will also deploy 611 teams to prevent the open burning of waste. An additional 66 teams will ensure that industrial units do not use unauthorised or non-compliant fuels.

Starting from October 3, a "Green War Room" will be operational 24x7 to monitor environmental



indicators. A nine-member expert team has been assigned to analyse reports and plan future actions based on the gathered data.

Kejriwal encouraged people to download and use the Green Delhi mobile application, which has played a crucial role in facilitating communication between the public and the authorities on environmental violations.

"Over the past three years, the app received 70,470 complaints, with a 90 per cent resolution rate," he said. Similar to previous years, Delhi will continue to regulate the production, storage and the sale of fireworks within the city, including for online deliv-

eries. The residents are urged to celebrate Diwali with minimal firecrackers, Kejriwal emphasised.

This year, Delhi has set a target to plant 52 lakh trees and plants under the tree planting campaign. In the first phase, about 75 per cent, or 39.48 lakh trees and plants, have already been planted. The second phase of will commence on October 15. Additionally, the New Delhi Municipal Council aims to plant 50 lakh trees, he added. The chief minister announced that e-waste generated in Delhi will be collected and processed in 20 identified zones. After proper disposal, all electronic waste in Delhi will be scientifically processed. The Delhi government will also organise a "Run Against Pollution" to raise environmental awareness among the people and campaigns to check vehicular pollution and the burning of firecrackers. The BJP, however, blasted the Kejriwal government over the action plan, calling it a "copy-

Virendra Sachdeva, chief of the party's Delhi unit, said, "Arvind Kejriwal's winter action plan is just a show. Kejriwal did not do anything about pollution control. The winter action plan presented today is a copy-paste of the plan they presented last year.'

Speaking at a press conference, he said before the

AAP assumed power in Punjab, it held the northern state responsible for the pollution in Delhi

"But now, Kejriwal is mum on Punjab," he added. However, when asked about the stubble burning situation in Punjab, Kejriwal said, "Last year, (after) our government was formed, we got six to seven months. But government data shows that last year there was 30 per cent less stubble burning as compared to the previous year."

This year, several steps are being taken, including the diversification of crops under which farmers have been asked to grow crops other than paddy, he said. "This will lead to saving of water as well as less

stubble (generation)," the AAP chief added. Kejriwal said the farmers in Punjab are being encouraged to grow short-term varieties of rice, which will lead to less stubble generation and ensure more

time to dispose those. "We are getting good response. There are many companies that have come forward to adopt districts. They will take the stubble of the entire district and convert it into manure or electricity. Many other steps are being taken. It is difficult to cite the exact data on how much stubble burning will happen but I think it will be reduced," he said. (PTI)

Farmers' stir in Punjab: Train movement hit, some farmers block Chandigarh-Ambala NH

CHANDIGARH/HOSHIARPUR, Sept 29: Farmers squatted on railway tracks and blocked the Chandigarh-Ambala-Delhi national highway in Punjab on Friday, demanding compensation for crop damage in the recent floods, a legal guarantee on MSP and a sweeping debt waiver.

Farmers taking part in the three-day 'rail roko' squatted on the Amritsar-Delhi railway track in Devidas Pura while, in Hoshiarpur, members of the Azad Kisan Committee, Doaba, sat on a dharna at the local railway sta-

Railway officials said while some trains were cancelled, routes of several trains have been diverted. Some trains are being short terminated due to the agitation.

The stir is underway at 17 places in Punjab, including in Moga, Hoshiarpur, Gurdaspur, Jalandhar, Tarn Taran, Sangrur, Patiala, Ferozepur, Bathinda and Amritsar.

A group of farmers owing allegiance to Bharti Kisan Union (Sidhupur) squatted on the Chandigarh-Ambala-Delhi national highway near Lalru in Punjab. The farmers also parked their tractors alongside the highway.

A Punjab Police official said both sides of the highway have been blocked and traffic diverted through alternative routes.

Harpal Singh Sangha, state chief of the Azad Kisan Committee, Doaba, said the agitation



If the demands are not met by that time, the next course of action will be decided, he said. The stir has left many rail passengers stranded in Punjab and Haryana.

"The matter is between the Centre and the farmers. Why should passengers face harassment. Since yesterday (Thursday), we have been waiting at the railway station but there is no surety when our train will arrive," said an elderly passenger waiting to travel to Patna at the Ludhiana railway station.

Late on Thursday, hundreds of railway passengers travelling to various destinations, including Delhi, Bihar and Uttar Pradesh, were stranded at the Ambala Cantonment station in Haryana as rail movement was hit in Punjab.

A large number of passengers, many of them pilgrims, were also stranded at Jammu and Katra railway stations of Jammu and Kashmir on Friday as seven trains were cancelled and 13 diverted due to the agitation.

The agitation has directly affected the Ambala and the Firozpur railway divisions, a railway official said.

Several farmer groups, including the Kisan Mazdoor Sangharsh Committee; Bharti Kisan Union (Krantikari); Bharti Kisan Union (Ekta Azaad): Azaad Kisan Committee, Doaba: Bharti Kisan Union (Behramke); Bharti Kisan Union (Shaheed Bhagat Singh) and the Bharti Kisan Union (Chottu Ram), are participating

Court directs DRI to revise raid guidelines after detainee dies by suicide

NEW DELHI, Sept 29: A Delhi metropolitan court, while taking cognisance of various offences against four Directorate of Revenue Intelligence (DRI) officers, including abduction and abetment of suicide, has directed the agency to revise the guidelines to be followed by its officers during a raid.

Chief metropolitan magistrate Shivani Chauhan was hearing a case where a suspect was allegedly driven to end his life by suicide due to illegal detention, and physical and mental abuse by four DRI officers. According to the case details, the central agency conducted a raid at the office, shop and residence of victim Gaurav Gupta on April 24, 2018. The raid continued till the next morning, and after the victim and his father were taken to DRI office, Gupta ended his life by jumping out of a window.

An FIR was initially registered for the offence of murder. After investigation, however, a cancellation report was filed, and the Investigating Officer (IO) concluded that it was a case of suicide. The court, in an order passed on September 25, said it was "prima facie" a case of suicide but it had to seen whether the victim took his life of his own volition or something happened at the DRI office which drove him to take the extreme

It said the victim's father categorically stated that during the raid at his residence, a DRI officer pointed a revolver at the victim, and four members of the raiding team slapped and misbehaved with them. At the DRI office, he could hear his son being beaten in the adjoining room, the court noted.

It said the victim and his father were detained without following the due procedure. "There is nothing on record to show that the raiding party had the authority to detain these two persons without formal arrest and interrogate them at their office at that time. "The victim was not given a chance to speak with his family members or advocates after the conclusion of the raid. The victim was not given adequate opportunity to rest... Rather he was straightaway and illegally taken to the office of DRI, beaten and abused during further interrogation which deteriorated the mental condition of the victim to such an extent that he was driven to commit suicide," the court said.

It said there was sufficient material on record to take cognisance of offences against the four officers-Parminder, Nishant, Mukesh and Ravinder- under IPC sections 323 (voluntarily causing hurt), 341 (wrongful restraint) 166 (public servant disobeying law with intent to cause injury to a person) 352 (punishment for assault or criminal force otherwise than on grave provocation), 362 (abduction), 348 (wrongful confinement to extort confession), 306 (abetment of suicide), 330 (voluntarily causing hurt to extort confession) and 34 (common in-

there is tacit approval, though not consent in law, on part of the child aged between 16 and 18 years. The proposed changes aim to provide greater discretion to special courts in cases where the child involved in the offence is aged 16 or above and has had an intimate relationship with the accused. The commission has highlighted various factors that should be considered when determining the sentence in such cases.

Under the recommended amendments, special courts would be allowed to impose a lesser sentence than the minimum prescribed under sub-section (1) of the POCSO Act. The decision would be based on a thorough evaluation of the facts and circumstances surrounding each case. Special courts would consider various factors when determining the sentence, including whether there was tacit approval from the child, though not consent in law, for the acts leading to the offence.

They would also assess the age difference between the accused and the child, ensuring it is not more than three years. Moreover, the court would evaluate the accused's criminal history, conduct after the offence, and confirm the absence of undue influence, fraud, misrepresentation, coercion, force, violence, or deceit perpetrated on the

child, according to the law panel recommendation. Additionally, the court would verify that the accused was not in a dominating position to intimidate the child, parents, relatives, or witnesses, and that there is no evidence of child trafficking or manipulation of the child's

Importantly, the court would ensure that the child was not used by the accused for pornographic purposes or

any illegal or immoral activity, the commission said. (PTI) Noted Tiwa writer to speak

NEW DELHI, Sept 29: President Droupadi Murmu has given her assent to the women's reservation bill which seeks to provide 33 per cent reservation to women in the Lok Sabha and state assemblies.

According to a law ministry notification issued on Friday, the president gave her assent on Thursday. Now, it will be officially known as the Constitution (106th Amendment) Act.

According to its provision, "It shall come into force on such date as the central government may, by notification in the Official Gazette, appoint.'

During a special session of Parliament earlier this month, Prime Minister Narendra Modi had described the law as "Nari Shakti Vandan Adhiniyam".

The Constitution amendment bill was passed by the Lok Sabha with near unanimity and the Rajya Sabha with unanimity.

The law will take some time before being implemented as the next census and the subsequent delimitation exercise - redrawing of Lok Sabha and assembly constituencies - will ascertain the particular seats

being earmarked for women. The quota for women in the Lok Sabha and assemblies will continue for 15 years and Parliament

can later extend the benefit period. While there is quota within quota for Scheduled Caste (SC) and Scheduled Tribe (ST) women, the opposition had demanded that the benefit be extended to Other Backward Classes. (PTI)

calls for 'suitable punishment' to BJP MP NEW DELHI, Sept 29: Amid a row over Ramesh Bidhuri's deroga-

tory remarks in the Lok Sabha against him, BSP MP Danish Ali on Friday urged Prime Minister Narendra Modi to make a public statecondemning Bidhuri's behaviour and ensure "suitable punishment" to the BJP MP.

In a letter to the prime minister, Ali also demanded that he be provided enhanced security in view of an "escalation of threats" against him. The recent incident during the special session of Parliament was not just an attack on him as an individual but an attack on the "very essence of democracy", Ali said.

Expressing grave concern as a Member of Parliament over the "recent shameful events" that occurred on the floor of the House, the BSP leader called on the prime minister, as the Leader of the House, to take note

"As you must be aware, the situation has significantly worsened since September 21, 2023, and it has cast a shadow over the parliamentary decorum and democratic functioning of our esteemed House of which I am privileged to be a member," Ali said in his letter which he released to the

"In your capacity as the Leader of the House and the Prime Minister of our great nation, I trust that you would find it deeply concerning that MP Ramesh Bidhuri resorted to using unparliamentary and abusive lan-

guage," Ali said. Noting that the Modi was not present in the House, Ali claimed that Bidhuri used "inappropriate language" when referring to the prime minister during his address.

"I raised an objection to the use of such language in relation to the Prime Minister, even if it was in a quotation. It is evident from the House proceedings that none of the members from the ruling party objected to my stance against the use of unparliamentary

language directed at you," Ali said. "However, when I rose and pointed out to Bidhuri's use of unparliamentary language towards you, he got rattled and reacted strongly, possibly realising his mistake. He began making highly offensive attacks against me on the floor of the House to divert the attention of the House," the BSP

Ali then pointed out some of the objectionable and derogatory words Bidhuri had used against him, saying that the BJP MP displayed a complete disregard for the high decorum of the House and claimed that he verbally threatened him.

"While the incident in question received condemnation from most House members, including some from the BJP, there has been a continuous effort to damage my reputation and perpetuate false claims since September 21. Despite the events on the floor of the House being evident to everyone, certain members have chosen to spread falsehoods about my behaviour," he said. They have "attributed statements to me that were never spoken by me" during any parliamentary session, he said.

Ali said that members like BJP MP Nishikant Dubey have even gone as far as to disseminate "absolute falsehoods" against him by asserting that he made certain remarks which provoked Bidhuri when it is clear that those remarks were made by the BJP lawmaker himself during his address.

"The threat issued by Mr Bidhuri and the subsequent spread of inaccurate information about my conduct have raised substantial apprehensions regarding my personal safety and se-

curity," he said. "In addition to Bidhuri's threat of confronting me outside Parliament, in a manner more akin to a street altercation than a parliamentary setting, certain unknown individuals are persistently sending me threatening and menacing messages," Ali said in his letter to the prime minister. Ali said he believes that as the Leader of the House in Lok Sabha, it is the PM's responsibility to ensure free speech and well-being of all Members of Parliament, irrespective of political affilia-

tions. In his letter, Ali made a series of demands of the prime minister, including that he make a public statement from his office condemning such behaviour and reaffirming the commitment towards maintaining highest standards of parliamentary proceedings.

"I urge you to remind all Members of Parliament of the importance of upholding the highest standards of decorum and conduct within the House as the whole world looks upon us as a torchbearer of parliamentary democracy. Such indecent incidents should have no place in our democ-

Rich nations exploiting Paris Agreement clause to deny essential fossil fuel development in developing countries: India

NEW DELHI, Sept 29: It is unfair that some developed countries are using an article in the Paris Agreement to restrict fossil fuel development in developing nations while they continue to invest in fossil fuels themselves, India has said.

In a submission to the United Nations Framework Convention on Climate Change (UNFCCC) outlining its expectations from the Global Stocktake, India said developed countries are viewing Article 2.1(c) of the Paris Agreement in isolation and ignoring all other provisions on climate finance in an attempt to move away from their commitments to provide money to developing

Global Stocktake is a two-year UN review to evaluate collective global progress towards achieving the goals of the Paris Agreement. This process will conclude at the end of COP28 in

Article 2.1(c) reads: "Making finance flows consistent with a pathway towards low greenhouse gas emissions and climate-resilient development." It talks about making sure money for climate action supports clean and resilient development.

India said some developed countries are focusing too much on this and not providing enough money for other important climate goals. "This is unacceptable, as it seriously undermines the obligation and efforts to mobilise climate finance by developed countries to developing countries," India said.

It would mean no more support for fossil fuels, a push for netzero emissions, and a focus on private sector financing, among other things, India said while stressing that climate finance should meet the actual needs of developing countries.

"Paris Agreement aligned finance flows', as being read under

Article 2.1 (c), is not the same as the commitment and obligation of developed countries to provide climate finance under the UNFCCC and under Article 9 of its Paris Agreement. "The singling out of 'messages on

finance flows' does not address concerns of public finance and provision of support by developed countries to developing countries to achieve the pathway towards low GHG emissions and climate-resilient development," it

India emphasised that some developed countries are using Article 2.1(c) to stop supporting fossil fuel development in developing countries and force them to reduce emissions quickly.

"Implementation of Article 2.1(c) is being used to deny essential fossil fuel development for developing countries, even though these have serious consequences for their economies and their population. On the other hand, developed countries are continuing their profligate investment in fossil fuel infrastructure and production," India's submission to the UNFCCC read.

While some developed countries are increasingly focusing on Article 2.1(c), they are ignoring all other provisions of the Paris Agreement on climate finance. The use of Article 2.1(c) to restrict official development assistance (ODA) for essential fossil fuel development and force a high rate of mitigation on developing countries needs to be discussed in detail, the country

Indrajit Bose, Global Policy Lead at Climate Action Network-International, told PTI. "India has hit the nail on the head. Article 2.1(c) is often used to divert attention from the much-needed core public finance provision responsibilities of developed countries, which India is right in calling out.

He said 'making finance flows consistent' must translate to urgently scaling up additional finance for climate action in a form that does not undermine the ability of recipient countries to address climate impacts as part of a broader focus on low-carbon and climate-resilient development.

"Besides, progress on Article 2.1(c) cannot be pursued as a standalone goal but is required alongside and complementary to significant progress on Article 9.1, which mandates developed countries to provide financing to developing countries," Bose said. (PTI)

Actor Vishal alleges corruption in CBFC's Mumbai office, I&B orders inquiry

NEW DELHI, Sept 29: The Ministry of Information and Broadcasting on Friday ordered an immediate inquiry into Tamil actor Vishal's allegations that he had to pay Rs 6.5 lakh to the CBFC's Mumbai office for the screening and certification of the Hindi version of his film "Mark Antony".

Vishal levelled the allegations of corruption against the Mumbai office of CBFC in a post on microblogging site X on Thursday. In a post on Friday, the ministry said the government had zero tolerance for corruption.

"The issue of corruption in CBFC brought forth by actor @VishalkOfficial is extremely unfortunate. The government has zero tolerance for corruption and strictest action will be taken against anyone found involved.

"A senior officer from the Ministry of Information & Broadcasting has been deputed to Mumbai to conduct an inquiry today itself," the I&B ministry tweeted on Friday.

The ministry also urged people to cooperate and share information about "any other instance of harassment by CBFC". Official sources said Information and Broadcasting Minister Anurag Thakur has directed maximising use of technology to ensure transparency in slotting and implementation of faceless systems wherever possible.

Vishal's sci-fi film "Mark Antony", directed by Adhik Ravichandran, was released in Hindi on Thursday. The movie also features S J Suryah, Ritu Varma, Sunil, Selvaraghavan and Abhinaya. In his post on X, Vishal made an appeal to Prime Minister Narendra Modi and Maharashtra Chief Minister Eknath Shinde to investigate the "scam" that transpired at the CBFC's Mumbai office. "Due to some technical issues, we applied for the Hindi censor certificate online at the last minute. But we were taken aback by what happened at the CBFC office in Mumbai.

"On Monday, when my person visited the office, there was an option given to us -- to pay Rs. 6.5 lakh for the certification the same day. We were left with no other option. We were asked to pay Rs 3 lakhs first, just for the screening. The rest Rs 3.5 lakh were for the certifi-

cate," the actor had claimed.

Vishal also claimed that a woman official told their team that it was a common practice at the CBFC where filmmakers would pay money for receiving censor clearance.

"Those who want the certificate in 15 days, they have to pay Rs 4 lakh. We had no other option, so we paid the money in two instalments and I got the certificate. Today, my film was released in north India. But this is very sadden-

"If this is the case in government offices, I really request higher authorities to look into this matter," the actor claimed. In a statement, Indian Film and Television Directors' Assocation (IFTDA) expressed concern over the allegations made against CBFC officials and demanded a CBI enquiry.

"If any official is found guilty serious action should be taken against the perpetrator of this crime of extortion... This is a dangerous trend which will be the reason for bringing bad name to CBFC," IFTDA president Ashoke Pandit wrote in a letter to Thakur. (PTI)

HANGZHOU, Sept 29: India thrashed lowly Nepal 3-0 in the quarterfinals to secure a historic medal after 37 years in the men's team badminton event at the Asian Games here on Friday.

Taking the court first, Lakshya Sen defeated Prince Dahal 21-5 21-8 before Kidambi Srikanth beat Sunil Joshi 21-4 21-13 in the second match.

The Indian men, who are assured of at least a bronze, will now face the winner of the match between Indonesia and Korea in semifinal for a spot in the gold medal clash.

HANGZHOU, Sept 29: Initially, when we came to know about Palak Gulia would shoot only to break the ennui while studying. But then, pastime gave way to habit and habit to an obsession to excel at the sport, leading to medals at Asian Games.

Hailing from Jhajjar district in Haryana, the 17-year-old Palak took up the sport seriously only after the COVID-19 pandemic.

"I was studying in St Xavier School in Gurgaon when I got to know about the sport of shooting. After that we used to have a onehour session from 6:30 to 7:30 in the morning. I started shooting randomly for another one and half years," Palak said after clinching her individual gold here on Friday.

"I continued doing that just for fun till 2019. After the COVID-19 pandemic was over, I started taking shooting seriously.

Her businessman father, Joginder Gulia, initiated her to the sport but only to give her some break from studies. "We have no shooting background in the family, I am the first one. I was more into study and academics. Before taking up shooting, I used to do other sports like athletics and swimming. Even after starting shooting I used to do other sports as well.

"I used to do shooting in my free time, in the break time after studies, my father said if I can do something good in the break that will be helpful for me. That is shooting. We have a shooting range in the school, so we started morning sessions.'

Now that she is into serious shooting, Palak follows routine drills before competitions and during camps. "Since our sport is a psychological sport, two days before the match we prepare an entire routine, we follow that routine till the match. Sleep is very important in our sport, we need eight hours of sleep. It plays a vital role.

"Another thing is do not rush, take it slow. Even if you are walking, do not rush, take it slow because you need to keep your heart beat calm. You need to be calm whatever you do. We have breathing sessions two or three times a week. Mental health is very important in shooting.

Palak also shed light on the 'war room' simulation training to prepare for the finals, introduced by Indian shooting high performance director Pierre Beauchamp.

"We have a war room where we do simulation for finals. We play music (like in actual competition) and we think of ourselves playing in the finals. "In that, we measure our pulse rate, breathing pattern which helps to analyse if we are hyper or we are relaxed, which stage should we always be in during the finals. We have had a lot of sessions like that." (PTI)

clarified his stance "Chairman PCB's Management stated that the fantastic reception of the Pakistan men's cricket team in India for the World Cup proves how much love the people of both countries have for each other's players," the PCB said in a statement. Sensing that his "enemy nation" comments could have deeper implications, Ashraf was quick to distance himself from his earlier

"This love was evident by the reception arranged at the Hyderabad airport. Zaka Ashraf personally congratulated the Indians over arranging a reception of this kind. He mentioned that whenever India and Pakistan step onto the cricket field, they emerge as traditional rivals but not as enemies," it stated.

The two teams play each other in ICC events and Asia Cup due to the tense relations with the two countries. The players however get

Ashraf is expected to attend the blockbuster India-Pakistan clash in Ahmedabad on October 14.

Indian shooters sizzle, record best-ever medals haul at Asian Games

HANGZHOU, Sept 29: The young Indian the Indians, the young duo challenged each other shooting brigade sizzled at the Asian Games, steam-rolling the rivals to win two gold and three silver on Friday and record their best-ever medal haul in the continental showpiece.

The grand success of the shooters over the last six days has seen them amass 18 medals so far, including six gold and seven silver, surpassing the 14 they had won during the 2006 Doha Asian Games in an era dominated by the likes of the legendary Jaspal Rana.

Palak Gulia and Esha Singh made it a one-two in individual 10m air pistol, while the trio of Esha. Palak and Divva won the country a team silver in the event, before the triumvirate of Aishwary Pratap Singh Tomar, Swapnil Kusale and Akhil Sheoran added another team gold in 50m rifle 3

The baby-faced 22-year-old Aishwary added another individual silver in rifle 3 positions, fighting an early elimination before finishing second best to a Chinese marksman, who set an Asian Games record. Two teenage dreamy-eyed shooters, Palak Gulia and Esha Singh, set ablaze the shooting range by powering to a gold-silver finish in 10m air pistol event.

"There's no rivalry with anybody. My biggest competitor has always been me. I'm always fight-

ing with myself," Palak said later. Palak had a score of 9.1 in her first shot in the finals but recovered remarkably well.

"My first shot was 9.1, a totally outer shot. I was a bit nervous after that, thinking obviously like what I hit. But I then said it's not over, it's the

first shot, you have 23 more shots to go. "So, it's not over until you win. It's all right, it's just one shot and because of this you cannot let you impact the rest of the shots," said the 17-yearold from Jhajjar district in Haryana.

"For an athlete, your quality is how you come back from your bad shots or how well you can come back. So I was only focusing on the process. like no matter what happened, I still had so much to do." Esha said she would give her performance nine out of 10 points.

"It was good, the initial start was very nice. I was able to maintain my focus for as long as possible. There were certain times where it was not working out, but I'm glad that at the end, it did.

"I had a bit of nerves, and I couldn't trigger Swapnil (591) and Sheoran (587), overcoming the

In fact, Swapnil had a 199/200 in prone, while Aishwary had an identical score in kneeling position. The finals though was a bit of an anti-climax, with both Swapnil and Aishwary missing the gold medal. Aishwary signed off with a silver after China's Du Linshu created an Asian Games record score of 460.6 to deny the 22-year-old Indian the top podium spot.

Aishwary had a final score of 459.7, while home team marksman Tain Jiaming took the third place behind the Indian with a score of 448.3.

The biggest setback, though, was for marksman Swapnil, who was gunning for a sure-shot gold after leading for a major part of the finals, but a rank poor shot of 7.6 saw the 28-year-old take a mighty tumble from No.1 position to fifth in the standing position.

That virtually eliminated him from medal contention. Though he shot 10.5 and 10.1 in his last two shots, Swapnil could only manage a fourthplace finish. (PTI)

Palak, Esha gold-silver feat makes it a historic day for India at Asian Games

HANGZHOU, Sept 29: Two teenaged dreamy-eyed shooters, Palak Gulia and Esha Singh, set ablaze the shooting range by powering to a gold-silver finish in 10m air pistol event for India at the Asian Games here on Friday.

In one of the most trailblazing efforts seen by Indian shooters, the duo challenged each other for the top podium finish until 17-year-old Palak clinched the gold medal and Esha the silver to swell the country's tally in the sport to 17 -- six of them gold. Pakistan's Talat Kishmala settled for a bronze after giving a tough fight to Esha.

Indian women's team signs off with Bronze

HANGHZHOU, Sept 29: The Indian women's squash team signed off with a bronze medal after going down fighting to Hong Kong in the semifinals at the Asian Games here on Friday.

The trio of veteran Joshna Chinappa, Anahat Singh and Tanvi Khanna went down 1-2 to Hong Kong.

Joshna was the only Indian who won her match as she defeated world number 24 Tze Lok Ho 3-2 (7-11, 11-7, 9-11, 11-6, 11-8) to level the tie after Tanvi went down meekly (3-0) to Sin Yuk Chan in the opener.

"Sometimes it's just about hanging in there and fighting through. There were moments where that's exactly what I did. I didn't think too much about having a plan or a strategy. I knew today no matter what happens I had to keep fighting through," Joshna said.

Playing against high-ranked and experienced opponent in Lee Ka Yi, the 15-year-old Anahat then tried her best but was undone by her inexperience. The teenager saved eight match points as she went from 10-2 to 10-10 in the third game but eventually lost the final (0-3) 8-11, 7-11, 10-12 and the tie. India had finished with a silver in the previous edition. They had lost to Hong Kong in the final at the 2018 Jakarta Games.

"It was 1-1 (in matches) and my match was a really important match, and if we had won that we would have gone to the finals. I feel like it could have gone better and I could have won it. They were really pushing me and hoping I would win the match and we would get a better medal,

Joshna, who was a part of the silver winning side in 2018, was left a little disappointed that they couldn't get over the finish line"

"We came in and we gave our best I'm just happy to have that fighting spirit on court. That's who I am as a player. "I was really happy I could play at a big stage for my country. Playing for India always brings out the best in me. I'm just glad I could do it today." (PTI)
