



One billion hungry stomachs to 2 billion skilled hands: PM hails India's progress

NEW DELHI, Sept 3: A week before he hosts annual meeting of developing and developed world leaders at the G20 summit, Prime Minister Narendra Modi has asserted that the 'Sabka Saath Sabka Vikas' model can be the guiding principle for the welfare of a world shifting from a "GDP-centric approach" to a "human-centric one". "Irrespective of the size of the GDP, every voice matters," Modi told PTI in an exclusive interview late last week at his Lok Kalyan Marg residence.

US President Joe Biden, Japanese Prime Minister Fumio Kishida, British Prime Minister Rishi Sunak, Saudi Arabia's King Mohammed bin Salman and other leaders will gather at the newly-constructed Bharat Mandapam confer-

countries.

"Many positive impacts are coming out of India's G20 Presidency. Some of them are very close to my heart," Modi said in the 80-minute interview, focused on G20 and related issues, with three senior staff of PTI including Editorin-Chief Vijay Joshi.

G20 accounts for 85 per cent of the global GDP, 75 per cent of international trade and 65 per cent of the world population. India took over the G-20's presidency from Indonesia last November, and will hand it over to Brazil in December. Modi said that while it is true G20 is an influential grouping in terms of its combined ence hall on September 9-10 for the pre-eminent economic might, "a GDP-centric view of the

world is now changing to a human-centric one", and just as a new world order was seen after World War 2, a new world order is taking shape post-Covid

"The shift to a human-centric approach has begun globally and we are playing the role of a catalyst. India's G20 Presidency has also sowed the seeds of confidence in the countries of the so-called Third World," he said. "The Sabka Saath Sabka Vikas model that has shown the way in India can also be a guiding principle for the welfare of the world."

While the interview was meant to be focused on G20, Modi also spoke about India's economic progress, its growing stature on the world stage, cyber-security, debt trap, bio-fuel policy, UN re-

forms, climate change and his vision of what India will be like in 2047.

"For a long time, India was perceived as a nation of over one billion hungry stomachs. But now, India is being seen as a nation of over one billion aspirational minds, more than two billion skilled hands, and hundreds of millions of young people," Modi said.

"The period till 2047 is a huge opportunity. Indians who are living in this era have a great chance to lay a foundation for growth that will be remembered for the next 1,000 years!" he added. "By 2047, I am sure that our country will be among the developed countries. Our poor people will comprehensively win the battle against poverty. Health, (CONTD. ON PAGE-9)

No substitute to merit for govt jobs: CM

514 new recruits receive appointment letters • Advertisement for another 22,000 vacancies to be released shortly

GUWAHATI, Sept 3: Taking another step towards fulfilment of the promise to provide as many as 1 lakh permanent jobs under the payroll of the state government to unemployed youths of the state, chief minister Himanta Biswa Sarma on Sunday attended the ceremonial distribution of appointment letters to a total of 514 candidates of the last Assam Direct Recruitment Examination (ADRE) to fill up vacancies in Class-III and Class-IV posts.

These 514 candidates had appeared in the last Assam Direct Recruitment Examination and had secured marks equivalent to the cut-off marks in their respective categories but didn't qualify for recruitment earlier owing to the rule that states that in case of two candidates securing equal marks, the one with higher age would get primacy over the other.

Speaking at the event held at the Srimanta Sankardev International Auditorium, the chief minister said that the decision to offer 1 lakhplus jobs to unemployed youths of the state was ratified by the state



cabinet in its very first meeting after the current government assumed power in 2021 but owing to the second and third waves of the Covid-19 pandemic, the entire process got delayed.

By the second anniversary celebration of the current dispensation in the state, around 86,000 job seekers received appointment letters, he stated.

Referring to the transparent process of recruitment to government services under the current regime in the state, Sarma exuded confidence the 514 newly recruited government servants would render services with all honesty which in turn would bring a perceptible change in the work culture in the government departments.

The other four policemen were apprehended on Saturday, the official said. All the seven arrested persons are currently in police remand, the official said.

The arrests were made in connection with a CID case registered on Thursday initially against seven police personnel of Bajali, including a deputy superintendent of police and two sub-inspectors.

Director general of police GP Singh had on Friday written on X, formerly Twitter, that the "case was registered after receiving a complaint of demand for money by some personnel of Bajali district" in the first week of August

Though the directorate of vigilance and anti-corruption unit could not succeed in laying a trap, the case was filed after it was found that "the complaint was true prima facie", he said.

GUWAHATI, Sept 3: A doctor in Assam has allegedly been threatened by her familv for converting to Hinduism, forcing her to go into hiding, while her brother has claimed that she has been kidnapped.

Even as the family sought police help in tracing her, a video by the doctor has emerged in which she claimed to be safe and voluntarily staying away for her safety.

As the matter was brought to the notice of chief minister Himanta Biswa Sarma on Sunday, he directed the DGP to probe the issue.

"Take action as per Law after a proper enquiry @gpsinghips," Sarma wrote on X, sharing a post with the doctor's video.

In the video, the doctor claimed that she had irked her family by converting to Hinduism and they had threatened to kill her, leading her to go into hiding.

She also claimed that her family wanted to marry her off to an elderly maulvi as they believe it will lead her to 'jannat' (heaven) in the afterlife.

The video was shot at an airport, the doctor said, adding that she is completely safe though she didn't disclose her location

The doctor's brother, Wakil Khan, had earlier sought police help in tracing her.

In a post on X to the director general of police GP Singh, Khan maintained that his elder sister had gone missing from August 17 from Hapjan primary health centre in Tinsukia, where she was posted.

Responding to the post, Singh wrote, "She has posted a video online indicating that she faces death threat from her family Please be advised that any such threat is unlawful and would attract penal action." Khan, replying to Singh, said they have received a demand for Rs nine lakh and dismissed the video as 'totally baseless'. He maintained that his sister could be in

'some distress condition' and requested the DGP to locate her.

Singh later said that the matter is being investigated. (PTI)

Huge stash of cannabis seized

GUWAHATI, Sept 3: The state's Karimganj Police made a significant discovery on Sunday, intercepting a tanker entering the state from a neighboring region at the Churaibari checkpoint. Acting on credible information, the police uncovered an extensive stash of 1,420 kilograms of cannabis concealed within the vehicle's tank in the Karimganj district. In connection with this case, one individual has been apprehended.



First earth-bound manoeuvre of Aditya L1 performed successfully: ISRO

BENGALURU, Sept 3: ISRO on Sunday said it has successfully performed the first earth-bound manoeuvre of the country's maiden solar mission, Aditya L1, from IS-TRAC here.

The space agency also said the satellite is healthy and operating nominally. The next manoeuvre is scheduled for September 5, 2023, around 03:00 Hrs IST.

"Aditya-L1 Mission: The satellite is healthy and operating nominally. The first Earth-bound maneuvre (EBN#1) is performed successfully from ISTRAC, Bengaluru. The new orbit attained is 245km x 22459 km. The next maneuvre (EBN#2) is scheduled for



September 5, 2023, around 03:00 Hrs. IST," ISRO said in an update Pradesh. The mission aims to study on 'X', formerly Twitter. the outer atmosphere of the sun by Aditya L1 was launched on Satplacing India's first solar observa-

tory at the Sun-Earth L1 point. L1 stands for Lagrange point 1, where the spacecraft would be stationed. The satellite started generating power after the solar panels were deployed. According to ISRO, Aditya-L1

will stay approximately 1.5 million km away from Earth, directed towards the Sun, which is about one per cent of the earth-sun distance. It will neither land on the Sun nor approach the Sun any closer.

SEBI to curb finfluencers to help

investors get accurate, unbiased info

GDP share of 6 new members being added to BRICS to be just 11%: Report

NEW DELHI, Sept 3: GDP share of the six new members, being added to the five-member BRICS grouping of emerging economies from January, will be just 11 per cent, with Saudi Arabia's contribution the highest at 4 per cent, an analysis shows.

The proposed addition of Argentina, Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates to the five-member BRICS, or Brazil, Russia, India, China and South Africa, will also see the grouping's share in the global GDP rising to 30 per cent from 26 per cent now and that of the population to 46 per cent, according to an analysis by the SBI Research.

The expansion decision, effective January 1, 2024, was announced at the recent BRICS summit held in Johannesburg.

Currently China contributes 70 per cent of the BRICS' GDP, which will decline to 62 per cent, while India chips in with 13 per cent now that will inch down to 12 per cent. Russia contributes 8 per cent, Brazil is at 7 per cent and South Africa contributes a paltry 2 per cent, giving combined 26 per cent of global economic output.

Russia's share will fall 7 per cent, while that of South Africa will halve to 1 per cent but Brazil's share will remain unchanged after the expansion, the report said sans offering a reason for the exception of Brazil.

Among these six economies, with ₹ 6,81,259 crore in bilateral



trade in FY23 the UAE is the largest trading partner for India, followed by Saudi at ₹ 4,23,834 crore, Egypt at ₹ 48,792 crore, Argentina at ₹ 39,100 crore, Iran at ₹ 18,680 crore and Ethiopa at ₹ 5,154 crore, said Soumya Kanti Ghosh, chief economic adviser at State Bank of India.

Among the new members, Saudi Arabia will be the biggest economy chipping in with 4 per cent GDP contribution, followed by Argentina, the UAE and Egypt with 2 per cent each, and Iran adding 1 per cent incremental to the GDP with Ethiopia's addition making practically no impact to the grouping's economy.

The Saudi economy was about USD 1.1 trillion in 2022 (already a G20 member), Argentina's at USD 632 billion, the UAE's at USD 507 billion, Egypt at USD 477 billion, Iranian economy stood at USD 388

127 billion, according to the available data. These six economies will add 11 per cent to the current GDP of the BRICS, Ghosh said in the report, which is 4 per cent of the global GDP in 2022 terms and will help boost the BRICS+6's share to $3\overline{0}$

billion and that of Ethiopia at USD

per cent, he added. Even after the new addition, China (USD 18.1 trillion in 2022) and India (USD 3.75 trillion) will continue to contribute 74 per cent of the overall GDP of the grouping, down from 83 per cent of the USD 26.2 trillion economy pre-expansion.

Russian economy was USD 2.2 trillion in 2022, while Brazil's was USD 1.8 trillion and South Africa's

was at USD 468 billion. BRICS+6 and G20 (Group of 20 largest economies) have their share in the global population at 3.7 bil-

lion and 5.1 billion, while that of GDP share is USD 29.2 trillion and USD 70.4 trillion, and forex reserves at USD 5.5 trillion and USD 9.4 trillion, respectively now.

Currently, the five-member grouping is home to 40 per cent of the world's population, which controls 26 per cent of the global GDP, But with the six new members (BRICS+6), their GDP share will jump to 30 per cent and share of population will go up to 46 per

However, the biggest impact will be on the share of global oil production that will increase to 40 per cent from the current 18 per cent, while their oil intake share will jump from 27 per cent to 36 per cent, according to the note.

Similarly, their share in global merchandise trade will rise from 20 per cent to 25 per cent, and that of global services trade will increase to 15 per cent from 12 per cent, the note said, adding that their share in the global forex reserves will increase by 600 basis points to 45 per cent.

On the massive increase in the share of oil trade -- Saudi has the second largest oil reserves after Russia -- the oil math will be the potential game changer for payment system and price discovery, says the report.

The acronym BRICS was originally coined in 2001 by Goldman Sachs economists led by Jim O'Neill. Later in December 2010, South Africa was added as the fifth member. (PTI)

NEW DELHI, Sept 3: The rise of financial influencers or finfluencers, who charge as high as ₹ 7.5 lakh for a post on social media, introduced a new way for people to access and interpret financial information, and now they will soon come under the regulatory purview as SEBI proposed measures to curb their mushrooming numbers.

The proposed move by Sebi not only ensures that investors receive accurate and unbiased information but also helps in preserving authenticity and reducing fraud, Anand Rathi Wealth Deputy CEO Feroz Azeez told PTI. Under the proposal, finfluencers need to be registered with Sebi and adhere to specific guidelines. Also, it has been proposed to ban unregistered finfluencers from partnering with mutual funds and stockbrokers for promotional activities.

While many finfluencers provide valuable insights, there has been a growing concern over the potential risks associated with unregulated finfluencers who might offer biased or misleading advice. They usually work on a commission-based model.

"Finfluencers charge as little as ₹ 10,000 to as much as ₹ 7.5 lakh for an individual post, excluding tax. Influencer marketing agencies quote as much as ₹ 20 lakh for a campaign, plus taxes, to entice their followers," Azeez said.

In addition, many of them make money from referral fees or profit sharing for promoting the product, channel, platform, or services or get compensation directly from social media and other platforms.

To address the risk associated with finfluencers, Sebi floated a consultation paper late last month proposing to restrict the association of registered intermediaries or regulated entities with unregistered influencers. In an era where financial advice is increasingly disseminated through social media, the line between credible advice and misleading information can become blurred.

By requiring finfluencers to register with Sebi and adhere to specific guidelines, the regulator is setting a standard for accountability and expertise in the sector, Sonam Srivastava, Founder and Fund Manager at Wright Research, PMS, said. "The regulatory move to address the role of finan-



cial influencers, or finfluencers in the financial sector is undoubtedly significant in enhancing investor protection and promoting transparency in the industry," Anand Rathi Wealth's Azeez said.

Also, the capital markets regulator has proposed measures on disrupting the revenue model for unregistered finfluencers and ensuring that they adhere to proper disclosure and disclaimer practices. This will help create a more accountable and reliable environment for investors seeking financial guidance, he said.

Finfluencers have significantly impacted their followers' financial decisions in the last few years and thus Sebi's proposed regulatory framework can make them accountable and responsible for the advice they provide, Tejas Khoday, Co-founder and CEO of FYERS, said.

Further, finfluencers registered with Sebi or stock exchanges or AMFI are expected to display their appropriate registration number, contact details, and investor grievance redressal helpline, and make appropriate disclosure and disclaimer on any posts.

Khoday said that the new regulations could help prevent conflict of interest and recommendation bias, which usually overlooks their followers' risk profiles. However, it is also essential to balance regulation and innovation.

"The proposed rules should harness the power of digital media to increase the overall financial awareness of the population fairly and transparently without compromising the far-reaching social media penetration so far," he added. (PTI)

Debt crisis matter of great concern for world: PM Modi ahead of G20 Summit

NEW DELHI, Sept 3: Stressing the need for financial discipline, Prime Minister Narendra Modi has reiterated that "irresponsible" financial policies and populist measures may give political results in the short term but will extract a "great social and economic price" in the long term.

Modi made these remarks in an interview to PTI late last week while answering a question about the global debt crisis -- which, he noted, is "a matter of great concern for the world, especially (for) developing countries". In remarks that came ahead of the G20 summit here, The prime minister said countries that are going through debt crisis or have gone through it, have begun to give greater importance to financial discipline.

Modi said he has urged state governments to be conscious about financial discipline. "Whether it is in the National Conference of Chief Secretaries or any such platform, I have said that irresponsible financial policies and populism may give political results in the short term but will extract a great social and economic price in the long term," Modi said, as he cautioned against politics based on populist measures.

"Those who suffer the consequences the most are often the poorest and the most vulnerable." Modi also spoke about how the political stability seen in India in the last nine years has led to several reforms in economy. education, banking and financial sectors, saying growth was its "natural by-product", as he outlined his vision for the country for the next two decades. With his government approaching the end of its second term, the prime minister said before 2014, the country saw many governments that were unstable and therefore, unable to get much done. "But in the last few years, the people have given a decisive mandate, which has led to a stable government, predictable policies and clarity in the overall direction," Modi said. "By 2047, I am sure that our country will be among the developed countries. Our economy will be even more inclusive and innovative. Our poor people will comprehensively win the battle against poverty. Health, education and social sector outcomes will be among the best in the world. Corruption, casteism and communalism will have no place in our national life." Modi also noted that the rapid and sustained progress made by India has evoked interest across the world. Many countries have been watching our growth story very closely and are convinced that this progress is not an accident but is happening as a result of a clear, action-oriented roadmap of 'Reform, Perform, Transform', he said. For a long time in world history, India was one of the top economies of the world but later, due to the impact of colonisation of various kinds, our global footprint was reduced, he added. "But now, India is again on the rise. The speed with which we jumped five spots, from the 10th largest economy to the fifth largest in less than a decade has conveyed the fact that India means business!" he added. Emphasising that the period till 2047 is a "huge opportunity", he said Indians living in this era have a great chance to lay a foundation for growth that will be remembered for the next 1,000 years! Modi also asserted that the quality of life of Indians would be on par with the best countries of the world and "most importantly, we will achieve all of this while caring for both nature and culture". IKEA enters 2nd phase of growth in Biz can claim ITC on goods procured for distribution to India, to expand retail operations

NEW DELHI, Sept 3: Swedish furniture maker Ikea is looking for omnichannel expansion with diverse retail formats besides kicking off online operations in Delhi-NCR by the end of 2024 as it enters the second phase of

growth in the Indian market. According to company India CEO Susanne Pulverer, Ikea is now planning to expand its operations by adding more stores to its network and considering new locations such as Pune and Chennai and increasing local sourcing making products more affordable here. Ikea, which has completed five years of retail operations after opening its first store in Hyderabad on August 9, 2018, plans to increase its employee count to 10,000 from 3,000 in the coming

years. Besides, the company which sources from India for its global retail operation, is expanding its scope and looking into a big category with wood-based products here. "Our next growth phase in India looks very promising and full of opportunities. IKEA is committed to India and here for the long term. We are looking at an omnichannel expansion in India with diverse retail formats to come closer to the many people in India," Pulverer told PTI. She further said:" We have already booked an investment of ₹ 10,500 crores in building five stores in India, apart from announcing investments in two large shopping centres in Gurugram and Noida with integrated IKEA stores." Punjab & Sind Bank plans to raise ₹ 250 cr via QIP in third quarter

NEW DELHI, Sept 3: Stateowned Punjab & Sind Bank plans to raise ₹ 250 crore through share sale to institutional investors in the third quarter of the current fiscal.

"The bank has got approvals for capital raising of ₹ 250 crore via Qualified Institutional Placement (QIP) in the next quarter," Punjab & Sind Bank managing director Swarup Kumar Saha told PTI.

It will help achieve the twin objective of capital raising and dilution of the government's holding in the bank, he said. Government of India holds a 98.25 per cent stake in the bank which was listed on the stock exchanges in 2010.

He said that the government's nod is also in place for the capital raising. The bank had written to the Centre seeking its approval for capital raising in May this year.

As part of a strategy to increase touch points and brand visibility, Saha said the bank is aiming for 2,000 branches and as many ATMs in the country in the next three years. The addition of branches would help mobilise low-cost deposits and also increase penetration of loan products, he said. (PTI)

NEW DELHI, Sept 3: Leading stock exchange BSE has revised the circuit limit of Jio Financial Services, the demerged non-banking financial services unit of Mukesh Ambani-led Reliance group, to 20 per cent from the existing 5 per cent.

The new limits will be effective from Monday, September 4, according to a notification issued by BSE.

The move would ensure stock prices do not fluctuate beyond a prescribed level during a session.

Further, market experts believe that the stock will be out of the tradeto-trade segment next week.

Apart from Jio Financial, the price band for nine companies, including RailTel and India Pesticides, has been revised to 10 per cent.

A circuit filter mechanism is used by BSE to keep in check excessive volatility in a scrip. It is the maximum fluctuation that is allowed in a stock in a day.

Additionally, the stock of Jio Financial was removed from all the BSE Indices, including the benchmark Sensex, on September 1.

Shares of Jio Financial got listed on the stock exchanges on August 21 due to its spin-off from parent Reliance Industries.

Earlier, the stock was slated to be removed from the indices on August 24. Later it was postponed to August 29. However, the exclusion was delayed by exchanges as it continued to be locked in the lower circuit.

In the past three trading sessions, the stock has gained, touching upper circuits and avoiding lower circuits. This indicated its imminent removal from the indices.

During the Annual General Meeting (AGM) last month, Reliance Industries Chairman Mukesh Ambani announced that Jio Financial will enter the insurance segment to offer life, general, and health insurance products

Tata Steel in advanced talks to secure funds for UK plant: Reports

LONDON, Sept 3: Tata Steel is in advanced talks with the UK government to agree around GBP 500 million in state-backed funding to secure the future of its Port Talbot plant in South Wales, according to UK media reports this weekend.

The Indian steel major has been in long-drawn discussions related to the critical green transition of the UK's largest steelworks, involving thousands of jobs in the country's steel industry.

According to a Sky News' report on Saturday, both sides are now close to agreeing a deal that would commit millions to the future of the Port Talbot steelworks.

"Tata Steel is continuing to discuss with the UK government a framework for continuity and decarbonisation of steel making in the UK amidst very challenging underlying business conditions given that several of its heavy end assets are approaching end of life, a Tata Steel spokesperson told PTI, when asked about the development. "Given the financially constrained position of our UK



business, any significant change is only possible with government investment and support, as also seen in other steel making countries in Europe where governments are actively supporting companies in decarbonisation initiatives, the spokesperson said.

According to UK media reports, the draft plans close to being finalised include the UK government committing around GBP 500 million of funding and the Tata

Magsaysay award winning oncologist's mission to provide affordable cancer care to poor


SILCHAR, Sept 3: It was 23 years ago that this year's Magsaysay award winning oncologist Dr R Ravi Kannan left a lucrative career in Chennai to move to the Cachar Cancer Care Hospital and Research Centre (CCHRC) here with a mission to deliver affordable and accessible cancer care to the poor. Located at Meherpur on the outskirts of Assam's Silchar town in Barak Valley, the hospital was set up as a nonprofit on a plot provided by the state government in 1996.

With cancer cases high in the Valley, primarily due to lifestyle issues, and the nearest cancer hospital 350 km away in Guwahati, citizens of Cachar district felt that there was an imperative need to set up the hospital. "To deliver inclusive cancer care, we must have in place a package that is accessible, affordable, respectful and hassle-free," the 59year-old awardee said.

He had received a call from the then director, Dr Chinmoy Choudhury, in December 2006 who invited the oncologist, then working at the Adyar Cancer Institute in Chennai, to join and head the CCHRC. "It was then that I and my wife Seetha arrived in Silchar to explore the possibility and when we saw the prevailing cancer care scenario here. I knew this was my calling.' Kannan said on his journey of providing cancer care here from 2007.

It was his wife who took the final decision as she felt that they were needed here more. She continues to volunteer along with a team of over 450 colleagues who are committed to make people aware of cancer, adopt preventive measures and seek early detection. "How a society takes care of its sick is an

important parameter to judge how civilised the society is. Since the initial days of the hospital, the focus was on pro-active poor



branding with low cost services, treatment subsidy, no separate dual pricing for poor and rich patients, providing boarding and lodging along with active counselling for patients and caregivers," he said. Around 80 per cent of the patients are daily wage earners, tea garden and agricultural workers with 59 per cent of them having an income of ₹ 10.000 or less.

The cost of treatment since the very beginning was very nominal and this was followed by subsidising the treatment but what became a challenge was that after the initial visit, patients did not return for follow-up treatment," he said. "Cancer treatis a long-drawn process. ment Chemotherapy is for six months, radiation for two months, followed by surgery and by

the time the treatment is over, a year is gone," he pointed out.

Again, by the time the side-effects and fatigue wears off, another six months is gone and as the bread-winner keeps coming back to the hospital, the family starves and after a while they stop coming as they feel that the "individual will have to die so that the others can live.

A policy decision was, therefore, taken to provide food and ad hoc employment to attendants of the patients on the hospital campus to offset their daily wages. "We conducted an audit following this decision and found that 55 per cent of the patients are completing the prescribed treatment but for me this was a poor track record as 45 per cent are not returning for follow-up," Kan-

nan said. It was then decided to provide free home visits and "we now see 900 patients annually at their homes which has improved the compliance rate of treatment to 80 per cent," the oncologist said.

The hospital now has a footfall of over 4,000 new patients and over 25,000 follow up visits of patients annually. It was also decided that CCHRC will introduce satellite hospitals to improve accessibility of affordable cancer care in remote locations and save travel costs for patients, Kannan said.

"Along the way, we also realised that we will have to work with the community, particularly for early detection and palliative care," he said.

Radiation, surgical and medical oncology has to be institution-based but even more important is prevention, early detection, palliative care, providing support and rehabilitation of patients, Kannan said.

"We entered into a programme with the Indian Council of Medical Research and the state government to train ASHA workers for creating awareness and early detection. They are doing a remarkable job," he said. The North East Alliance Against Cancer was also formed to link all stakeholders of the community to a common platform "to empower them to do better and involve them to take care of their own," Kannan said.

On winning the award, the oncologist had said the award is not about him but for all who have contributed to cancer care in the community and that he was just one of the many faces involved in this effort. "Offering inclusive health care or inclusive education are activities that are as patriotic as those of our soldiers standing at the border of our nation defending and protecting us," the Magsaysay award winner said. Rampage erupts in Nagaon town as frequent loadshedding sparks public outrage

GUWAHATI, Sept 3: The Assam govt announced its decision on Sunday to acquire the Ginger hotel and its associated land for the development of Silsako Beel as a reservoir, according to an official order.

"In exercise of the powers conferred on me under section 3(1) of the Assam Land Requisition and Acquisition) Act, 1954 (A XV of 1964) under Notification No. RLA81/93/5-A dated Dispur, the 15 of July 1993, 1, Pallav Gopal Jha, IAS. Deputy Commissioner & Collector, Kamrup Metropolitan District, Guwahati, do hereby requisition under Section 361) of the Assam Land (Requisition and Acquisition) Act, 1964, the land described in the Schedule below along with building standing over the land with effect from the date of this order, for the purpose of development of Sisako Beel as a reservoir and facilitate the mitigation of Urban

flooding in pursuance of Department of Housing & Urban Affairs," the order read. The govt had initiated an eviction drive in the Chachal area of Guwahati on May 13, 2022. Another eviction drive took place, clearing 100 meters from both sides of the Silsako Canal on Feb 27 and 28, 2023, and again on March 2 and 3, 2023, affecting 150 bighas and around 500 families. Locals have raised concerns that the administration is conducting these drives without prior notice or proper rehabilitation and resettlement measures. According to the state govt, the area was occupied by illegal settlements, contributing to flooding in Guwahati city. They also claimed that the area fell under the Water Bodies Act 2008.

However, locals argue that in 2008, the previous government (Congress) passed a water body preservation act without properly demarcating the affected areas, leading to the current situation.

NAGAON, Sept 3: Dr Parikshit Gogoi, a distinguished faculty member at Nowgong College (Autonomous), has received the prestigious Fulbright-Nehru Academic & Professional Excellence Research Fellowship for the year 2023-24. As an assistant professor of Chemistry, Dr Gogoi will commence his research work under this fellowship starting from September 15, 2023.

He will collaborate with Dr Jaemin Kim from the Prairie Research Institute at the University of Illinois at Urbana-Champaign, Illinois, USA. Dr Kim is recognised as an outstanding material scientist with a research focus on catalytic materials, particularly in sustainable energy technologies.

Dr Gogoi has previously been honoured with several awards, including the INSA Summer Research Fellowship for Teachers in 2014 from

the Indian National Academy of Science, Bangalore, the Raman Fellowship in 2016 for Post-Doctoral Research at the Georgia Institute of Technology, Atlanta, USA, awarded by the University Grants Commission. He also received the Dulal Ch Goswami Memorial Research Award in 2021 from Nowgong College (Autonomous)

During his Fulbright-Nehru Research Fellowship, Dr Gogoi's research will centre on the catalytic conversion of biomass and lignin biooils into aromatics and fuel range hydrocarbons using polyoxometalate catalysts.

His primary goal is to develop catalyst systems capable of achieving biomass conversions at lower temperatures and moderate hydrogen pressure. This innovative approach promises to offer new insights into the effective utilisation of lignin within a biorefinery, benefiting its overall economic sustainability.

'Shock and awe' over simultaneous poll move

he recent flurry of activity within the Narendra Modi government has raised eyebrows and stirred the political pot. With the unexpected convening of an out-of-turn parliamentary session and the formation of a panel led by former President Ramnath Kovind to explore the feasibility of implementing a onenation policy, one can't help but wonder if this is more about "shock and awe" politics than a genuine intent to introduce such a contentious proposal. These bold moves are widely perceived as a prelude to positioning for the 2024 Lok Sabha elections, yet their practicality remains questionable. The timing, strategically synchronised with the Mumbai session of the INDIA bloc of opposition parties, is undoubtedly designed to disrupt the steady progress of opposition unity - a development that has been causing unease for Prime Minister Modi and his ruling party. The term "shock and awe" may have originated in the military realm but seems aptly applicable here. It was famously used by former US defense secretary Ronald Rumsfeld during the American invasion of Afghanistan, a move that triggered a series of events reshaping contemporary world history, albeit not for the better. The consequences were dire, destabilizing nations and creating fertile ground for terrorism. Whether the Modi government's "awe and shock" strategy will lead to similar consequences remains to be seen, but the intent is clear: sow confusion and chaos to disrupt opposition unity. In response, the Mumbai session has had to adjust its agenda, prioritizing seat-sharing negotiations ahead of less critical matters, such as selecting a national convenor and a common PM candidate. Thus far, the shock-and-awe tactics seem to be working.

However, the odds are stacked against swift adoption of a one-nation, one-election policy. The limited timeframe, coupled with the extensive deliberations and legislative processes required, make significant progress in the special session nearly impossible, except for generating noise. The ruling party could choose not to wait for the current Lok Sabha's full term to expire, but achieving simultaneous elections, even in several states, would entail extending or abbreviating some state assembly tenures - a process requiring constitutional amendments ratified by at least half the states. This appears impractical. Still, it's plausible that elections might be synchronised in a group of states to coincide with the parliamentary elections, although nationwide simultaneous elections seem far from reality. Elections are scheduled for five state assemblies this year, while seven more will see their tenures end next year, concurrent with the Lok Sabha. Some of these states, such as Maharashtra, Haryana, and Arunachal Pradesh, are governed by the BJP, while Odisha and Andhra Pradesh have parties open to cooperation with the BJP. The Law Commission had previously proposed aligning all states with elections in the same year. Yet, the political landscape has evolved since the era of simultaneous elections up to 1967, marked by Cong dominance both at the Centre and in the states. Today, powerful regional parties with divergent interests often clash with the ruling party at the Centre, creating instability and thwarting consensus. The shift towards regional politics has shattered any hope of uniform state assembly tenures. One positive aspect of these discussions is the proposal to link traditional no-confidence motions with resolutions expressing confidence in a new govt, mitigating the risk of premature dissolution. While legislators typically resist shortened tenures due to their financial implications, the prospect of a new govt assuming office without dissolving the incumbent one could foster stability, particularly at the state level.

lphabet Inc.'s digi-tal giant Google A has established itself as the largest digital advertising platform in India and accumulated around ₹ 25,000 crores in ad revenue in 2022. However, the underlying phenomena behind such success lies within the monopolisation of advertisement technology (adtech) by Google. The tech giant is under attack in various jurisdic-

tions, such as the European Union (EU), UK and US, for holding a dominant position in the advertising

sector. There have been instances of questioning Google's practices in India as well. However, no report has been filed against the actions of the company yet. Monopolisation of adtech poses an immense threat to the viability of the current

digital advertising mechanism. Indian media houses and publishers are losing rev-

enue due to Google's monopoly. The present competition regime in India, along with the Digital Competition Act, seem inadequate to address the issue. Publishers and advertisers across the world primarily utilise three main adtech services to facilitate their ads: publisher ad servers (to manage ad spaces), ad buying tools (to buy ads), and ad exchanges

(wherein the supply and demand converge). Google acquired prominent service providers in these categories, namely; DoubleClick (2008), AdX (2008), and AdMeld (2011) and other nascent competitors, to position itself as a tech giant which could "control and manipulate" selling and buying of digital ads. This merger led to the creation of Google's "AdTech stack", own which includes publisher ad server as Google Ad Manager, ad exchange as

AdX, and two buying services: DV360 and Google

Concretisation of such power was pursued through various contentious tactics such as prioritisation of Google's own transactions through ad-exchange, and pressurising news outlets in adopting alternative webpage format. Consequently, Google now controls the digital tools which are utilised by every prominent publisher to sell and buy ads on their websites, and the advertising exchange technology to connect buy-

ers and sellers. Post these acquisitions, Google continued to grow into the adtech monopoly that it is today. Google generated US \$54.5 billion in ad revenue from July through September 2022 alone, an increase of 2.5 percent from the same quarter of 2021.

The casualties of such a dominant position are the newspapers, media houses and local businesses that also depend on digital advertisements. The precarious relationship between Google and these other businesses is evident, as Google quintupled its earnings in the past decade, the annual advertising revenue of US newspapers collectively decreased from US \$49.4 billion in 2005 to US \$9.6 billion in 2020.

The continual decrease in ad revenue of newspapers and small businesses is due to the lack of options and coercion into choosing Google's ad services, which allows Google to take nearly 35 percent of the earnings from digital advertisers. This leads to excessive revenue cuts, excruciating layoffs in the industry, and readers having to face paywalls due to businesses facing diminishing yields. Major publishers have stated that it is very difficult or nearly impossible to buy or sell advertising without utilising Google's ad services.

Moreover, the advertisers and ad agencies in India have so far abstained from

being affected by Google's monopolisation. Google's monopolisation has led to an anti-competitive environment within the advertising sphere, as the nascent adtech competitors are subverted, preventing improvisation of marketing

in creative ways. Further, the holding of such a dominant position by Google also leads to a collection of unnecessary personal data of users in the use of microtargeted advertising tactics. In summation, Google's anti-competitive behaviour has led to acquisition of competitors, forced adoption of Google's tools, distortion in auction competition, and auction manipulation. Ironically, Google's own AI-powered chatbot, 'Bard', in one of its responses, stated that Google has a "monopoly on the digital advertising market", which has allowed the company to engage "in anti-competitive

behaviour" The adverse effects of the present adtech monopoly upon the news media and small businesses are enormous. Three studies have shown that nearly 50 percent of spendings in digital media go to intermediaries such as Google, rather than the publishers displaying the advertise-

Furthermore, India is ill-equipped to address such technological issues in future as the current competition regime as well as proposed Digital Competition Act fail to recognise and effectively address this issue.

India can implement some necessary changes into its regime by incorporating provisions from the US' new anti-trust legislation, which directs companies to sell "portions of their operations" if their digital ad transactions surpass US \$20 billion. Furthermore, India can incorporate measures for companies to disclose their source of revenue if the ad transactions surpass a certain threshold.

> Companies which simultaneously act as sellers, buyers and regulators, must be divided into small structures to prevent monopolies that stifle innovation and transparency. Lastly, the new changes must include limitations on the user data being collected for advertising.

Google's monopolistic tactics have been lucrative in the past decade but at the expense of publishers' and news media's unequal share in ad revenue. Various countries have recognised the threat of such anti-competitive measures and taken action against the tech giant with an aim to divest the monopoly in the sector. Furthermore, India's recognition of the dominant position of Google in the recent Android case, calls for CCI to take action against the giant in respect of the ad tech monopoly.

Lastly, the Indian competition regime requires amendments to address such niche technological issues and ensure healthy competition in the market. (IPA Service)

India's UNSC quest: Diplomatic drive for permanent seat before G20

Investors shun East, Northeast despite contrary claims by govts

uring an event at Delhi University on Thursday, August 31st, India's External Affairs Minister, S. Jaishankar, emphasized the crucial importance of India being granted permanent membership in the United Nations Security Council (UNSC). He likened the current situation to the five permanent members, who hold veto power, as passengers in the front row of a bus unwilling to relinquish their seats.

Jaishankar's statement comes just ahead of the G20 Summit scheduled for September 9-10 in New Delhi, underscoring India's proactive efforts to secure a permanent seat in the UN body. This move is strategically timed to make a compelling case for India's inclusion in the UNSC as a permanent member during the upcoming G20 Summit, which will gather representatives from member and guest nations in New Delhi

Given the context, it is evident that Prime Minister Narendra Modi intends to leverage the forthcoming bilateral discussions with numerous global leaders on the sidelines of the G20 Summit. These meetings will serve as a platform for India to advocate strongly for its permanent membership in the UNSC. By addressing the UNSC issue, Jaishankar's remarks have indicated India's readiness to redirect the G20 bloc's attention towards United Nations reforms.

India's assertive diplomatic efforts have notably influenced the BRICS group, comprised of Brazil, Russia, India, China, and South Africa, to emphasize the necessity for a reevaluation of UNSC memberships, signaling a broader push for UN reform.

India's stance on its potential inclusion in the UN Security Council has received a significant boost, and the Indian government is understandably pleased with this development. The 15th BRICS summit, recently held in Johannesburg, South Africa, concluded with a final declaration that expressed support for increased representation of developing nations in the UN Security Council. The statement specifically endorsed the aspirations of Brazil, India, and South Africa to assume a more prominent role in the UNSC.

The joint statement emphasized the need for a comprehensive reform of the United Nations, including its Security Council, with the aim of making it more democratic, representative, effective, and efficient. The

BRICS nations underscored the importance of addressing global challenges and supporting the legitimate aspirations of emergng and developing countries from regions like Africa, Asia, and Latin America. For India's mission to secure permanent membership in the UNSC, this declaration from BRICS served as a significant vote of confidence.

India's confidence in its pursuit of UNSC permanent membership was evident in the words of External Affairs Minister Jaishankar himself. He noted that BRICS had. for the first time, acknowledged the need for a change in UNSC memberships. Jaishankar's statement hinted at China as a key obstacle hindering India's aspirations in this regard. Just a month prior, during his visit to France, Prime Minister Narendra Modi had strongly advocated for India's rightful place in the UNSC. He questioned the legitimacy of the UNSC as a primary global organ when large continents like Africa and Latin America remained underrepresented.

Modi highlighted the irony of the world body claiming to speak for the globe while India, the most populous country and a vibrant democracy, was not a permanent member. With Jaishankar's renewed call for India's inclusion as a permanent UNSC member, it is clear that during the upcoming G20 Summit, Prime Minister Modi will seize every opportunity to reaffirm India's claim to a permanent seat on the global stage

What bodes well for India is the strong support it has garnered from four out of the five permanent members of the 15-nation UN Security Council. The United States, the United Kingdom, France, and Russia have all endorsed India's bid for a permanent seat in the UN body. Notably, the lone holdout against India's aspirations has been China, which has not backed India's quest for permanent membership. India seeks to expand its support base beyond the BRICS nations, especially among newly included members, and rally the global community to exert pressure on Beijing to reconsider its stance.

In a positive turn of events, United Nations Secretary-General Antonio Guterres also voiced his support for reforming the UNSC while addressing the BRICS summit. wo East and Northeast Indian states - Assam and West Bengal - have largely failed to secure significant investments from domestic or foreign private sector in recent years. Assam is ruled by the Bharatiya Janata Party (BJP) while in neighbouring Bengal, the Trinamool Congress (TMC) was reelected to power for the third term in 2021.

Their obvious political differences apart, Assam Chief Minister Himanta Biswa Sarma shares with his Bengal counterpart Mamata Baneriee a remarkable gift of making stunning public claims of administrative achievements and success that are not always factually correct. For all Sarma's talk of transforming Assam into a dynamic economy in the Northeast region through unprecedented levels of infrastructural investments, courtesy the BJP-led NDA Government, the state has failed to secure even 1% of recent investments in India!

As for Mamata Banerjee's similar claims about unorthodox job creation as a 'major administrative achievement of the Bengal TMC Government,' Kolkata-based media channels reported that last week alone, from Mizoram to Delhi, at least 30 people - all jobless youths from Bengal - had been killed in industrial 'accidents'! Almost to the last man, the victims hailed mostly from Murshidabad, Malda and Nadia districts. The exact number of migrant workers from Bengal working in other states, beginning from a trickle in the 80s and swelling to a mighty torrent by the 2020s, has never been officially registered. The reason for not keeping an official record was political: Left or non-Left, no ruling dispensation wished to advertise its failure in reducing domestic unemployment.

As for the districts themselves, Murshidabad (a former capital of undivided Bengal during the Mughal rule) and Malda are Muslim-majority areas, with significantly poor indices of human resource development in recent times. The decline of Murshidabad



from the capital of a once flourishing region to Bengal's present-day crime capital, not to mention its present tag as India's poorest district, has been very pathetic indeed. The transition also attests to the abysmal failure of Bengal's political/cultural establishment in the post-Independence period to provide any leadership in crisis management.

A current estimate provides an indication of the extent of the present economic crisis plaguing especially rural Bengal: the Left-affiliated Centre of Indian trade Unions (CITU) has launched a detailed study of the problem of domestic joblessness. Its most crucial finding so far: between 4 million and 5 million jobless youths, mostly from rural Bengal, are currently working in the road building or real estate sector projects in other States.

Most are barely literate, unskilled and school dropouts, but the exodus also includes hundreds of graduates. From power projects in Kochi to Jammu to working for the Railways in the remotest areas of the NE, their chief objective is to earn ₹ 400 to ₹ 750 daily, so that they can send some money back to dependent relatives at home!

It needs stressing that the going daily wage rate for workers in Bengal has remained stagnant in the ₹ 250/350 range for over a decade, according to TU circles. At present most workers are engaged in real estate-related work. Further, mafiatype of labour leaders, mostly enjoying TMC support, collect a daily cut of ₹ 30/40 from each worker!

"This never happens in Odisha or Kerala", says Sudeep Mandal (25), who has worked in both States and is currently visiting his home at Dankuni, Hooghly.

Both Chief Minister Banerjee and her Chief Adviser former Finance Minister Dr Amit Mitra proudly claim that during the TMC's 12-year long tenure, there has occurred no industrial strike in Bengal.

"It would be nearer the truth to say that there is hardly any industry left here - the reduction in the number of industrial workers by several lakhs during the past decade in Bengal is a fact confirmed by numerous surveys conducted by the labour department itself. NGOs and researchers", says an INTUC leader. Dr. Mitra's recent claims made in

Mumbai about Bengal's immense potential as Eastern India's emerging economic powerhouse, has evoked little interest though considerable local merriment in West Ben-

'People in Bengal have been hearing of lakhs of new jobs in these projects for over a decade, from the Chief Minister herself. Very little has changed at the ground level. There has been no land acquisition for years, and hardly any organised upskilling of young unemployed vouths. At this rate, the state Government will make such claims for another 30 years if things continue like this,' said Sanatan Nandi, a jobless youth of Howrah.

For Assam, according to recent Reserve Bank of India figures, official efforts to attract major investments in the 2020s have failed miserably. Just as West Bengal's much vaunted but mostly ineffective annual jamborees, inviting industrialists to work in the state, had flopped, Assam's ambitious 'Advantage Assam' programme and similar moves have also come a cropper.

From 2016 onwards, apart from leading Indian industrialists, many foreign delegates and dignitaries had been invited to consider setting up projects in the NE region -- to little apparent effect. All over India, according to RBI and other stats, altogether ₹ 1.41.000 crore had been invested in 401 projects in 2021-22.Assam-based media further reported that in 2022-23, the figures respectively rose to ₹ 2,66,000 crore for 547 projects.

Uttar Pradesh bagged the highest share of these investments, at 16% of the total, in 2022-23. It was followed by other well-performing states like Karnataka, Odisha and Maharashtra. As for Assam, it secured only 0.7% of the total!

Opposition parties in Bengal and Assam cite different and contrasting reasons for the relative failure of both Sarma and Mamata Banerjee to secure the confidence of top industrialists in India. Poor governance might have been the main cause.

In post-Singur Bengal as well as Assam (to a lesser extent), the volatile law and order situation and recurrence of violence affecting different communities have been common in recent times. Both Chief Ministers have been more adept in pandering to narrow vote bank interests than attending to their economic priorities. Widespread corruption has been a common feature of governance in both states. No wonder such trends have not exactly encouraged investors, foreign or homegrown, to repose confidence in their words or announcements. (IPA Service)

13 early signs of Parkinson's disease

arkinson's disease is a nervous system disorder that affects around 1 percent of people aged 65 years and older. Symptoms usually develop slowly over several years. They may be subtle at first, so early signs are easy to miss.

If someone notices symptoms of Parkinson's disease, they should consider contacting their doctor for more information. Early treatment can improve the condition's long-term outcome. In this article, we cover 13 early signs of Parkinson's disease

1. Tremors

Many healthcare professionals consider tremors to be a key characteristic sign of Parkinson's disease. Tremors involve a persistent twitching or shaking of the hands, legs, or chin.

Tremors associated with Parkinson's disease are called "rest tremors." This means that the tremors stop when a person uses the affected body part. Tremors are very subtle when they first appear. At this stage, the person experiencing the tremors is usually the only one who notices them. Tremors will gradually worsen as the disease progresses. Tremors typically appear on one side of the body and then spread to other parts of the body later on

2. Difficulty walking

Subtle changes in a person's walking pattern could be an early sign of Parkinson's disease.

Someone who has Parkinson's disease might walk slowly or drag their feet as they walk. Many refer to this as a "shuffling gait.

The person might walk at an irregular pace, suddenly walking faster or slower or changing the length of their stride.

3. Cramped or small handwriting

Micrographia is a disorder that involves abnormally small or cramped handwriting.

Doctors associate micrographia with medical conditions that affect the nervous system, or neurodegenerative disorders, such as Parkinson's disease. 4. Loss of smell

Hyposmia occurs when someone loses their ability to smell. This is also called olfactory dysfunction. A loss of smell is a relatively common symptom, affecting 70-90 percent of people with Parkinson's disease.

Loss of smell is one of the most noticeable symptoms of Parkinson's disease that is not related to movement. It can appear several years before the disease affects a person's movement. People who have hyposmia as

a symptom of Parkinson's disease might experience:

- a dulled sense of smell • difficulty detecting odors
- difficulty identifying odors • difficulty telling the differ-

ence between odors

Doctors use smell identification tests to diagnose hyposmia, but the accuracy of these tests



Having hyposmia does not always mean that someone has Parkinson's disease. A person's sense of smell can change for

many reasons, such as age, smoking, or exposure to harsh chemicals. Hyposmia is also a symptom of other medical conditions, including Alzheimer's disease and Huntington's disease. 5. Sleep problems Parkinson's disease can se-

verely affect a person's ability to sleep. People who have Parkinson's disease may experience a wide range of sleep-related symptoms, including: insomnia

• excessive daytime fatigue narcolepsy

 sleep apnea nightmares

• uncontrolled or sporadic movements while asleep

6. Poor balance Parkinson's disease specifi-

cally targets nerve cells called basal ganglia, which reside deep within the brain. Basal ganglia nerves control balance and flexi-

bility, so any damage to these nerves can impair a person's balance

Doctors use a test called the pull test to assess a person's balance. The pull test involves a healthcare professional gently pulling a person's shoulders backward until they lose their balance and recording how long it takes them to regain it.

Healthy individuals recover after one or two steps, while people with Parkinson's disease may take a higher number of smaller steps to fully balance themselves. 7. Bradykinesia

Bradykinesia is a term that means slowness or absence of movement.

Bradykinesia causes a variety of symptoms, such as stiffness of the limbs and slow movements. A person who has bradykinesia might walk slower or have difficult starting a movement.

Some people who have this symptom might misinterpret it as muscle weakness. However, this symptom does not affect muscle

8. Facial masking

Facial expressions involve many subtle, complex muscle movements. People with Parkinson's disease often have a reduced ability to make facial expressions. This is called facial masking

Facial masking is related to bradykinesia. The facial muscles move more slowly or rigidly than usual. People who have facial masking may appear blank or emotionless, though their ability to feel emotions is not impaired. Facial masking can also cause someone to blink their eyes slower.

A person with facial masking might have difficulty communicating with others because changes in their facial expressions are less noticeable than usual.

9. Vocal changes

Changes in the volume and quality of a person's voice is another early sign of Parkinson's disease. Vocal changes may involve speaking in a softer tone, or starting to speak at a usual volume and then the voice becomes softer or fades away.

In other cases, a person might lose the usual variation in the volume and tone of their voice, so that the voice appears monotonous

their weight is evenly distributed over their feet. However, people who have Parkinson's disease may start bending forward, making them appear hunched or stooped over.

11. Constipation

Constipation is a common problem that can have a wide range of causes. Constipation is one of the most common nonmotor symptoms associated with Parkinson's disease. Nearly 25 percent of people with the condition experience constipation before they develop motor symptoms.

research ushered in the era of conditionspecific psychopharmacology.

Psychiatry can proudly claim its status as an evidence-based discipline. Practitioners refer to research-based guidelines to determine the best medications to help stabilise a bipolar disorder. Options now include lithium, three anti-epileptic drugs, multiple antipsychotic drugs and antidepressants. While most guidelines rate lithium highly for both bipolar types, we personally favour lithium as the first choice medication only for bipolar I, and the anti-seizure drug lamotrigine for bipolar II. But evidence isn't everything

In 2017, our research group examined 11 guidelines published by professional organisations. All were "evidence-based", but we found minimal agreement between them, thus raising questions about their validity. New guidelines have been published since then but the trend for minimal agreement continues. Assessing a psychiatric evidence base is difficult. For medical trials, the treatment being tested is compared against a treatment in common use, and/or against a placebo. Results from multiple trials are aggregated to compare their overall impact. But the way study participants are selected to participate in trials presents a problem. Recruitment is generally limited to those with milder conditions, those without co-existing disorders, or those taking limited medications Participants might also sign up to obtain medication at no cost, which may affect their motivation and reporting. Finally, the observations made by managing doctors commonly differ from those made by the patients about the benefits and side effect impact of the drugs given.

or skills become consolidated in the brain during sleep, whether at night or while napping.Napping can also reduce stress. One study found that naps of approximately 20 minutes improved the overall mood of participants. However, longer naps lasting more than 30 minutes are not typically associated with improved mood and increased feelings of well-being.

Short naps may also be associated with a reduced risk of cardiovascular diseases. If we are awake more than we should be, we tend to have a buildup of the "fight or flight" chemicals in our bodies. Studies show that more consistent sleep will help lower these chemicals, resulting in a normalization of blood pressure and heart rates. Napping appears to help this process for some people.

Tapping during the day is an ancient custom that is practiced worldwide. While some people view napping as a luxurious indulgence, others see it as a way to maintain alertness and well-being. But napping can come with drawbacks as well as benefits.

As an orofacial pain specialist, I have extensive education in sleep medicine and how sleep impacts wellness, due mostly to the relationship between sleep and painful conditions such as headaches and facial pain. My training involved all aspects of sleep, especially sleep breathing disorders, insomnia and sleep-related movement disorders. As such, I'm aware of the complex nature of napping, and why a short nap that is, a nap during the daytime that lasts from 20 to 30 minutes - may be beneficial in myriad ways.

An abundance of health benefits

another drug is better. What are your next steps? Do you seek evidence? And if so, what type of evidence would you consider?

Around 2 per cent of the adult population have a bipolar disorder. It can create high levels of suffering, carry suicide risks, and persist for decades. Management options vary, and if you search for information online, it's easy to become overwhelmed by the many different views and interpretations of "the evidence" obtained from clinical trials. Some medications can be extremely helpful for stabilising mood, but they can often have side effects. Certain medications may be more beneficial for certain types of bipolar disorder, but how do you know which "type" you or a loved one has?

Clinical specialists, including psychiatrists, often rely on guidelines authored by professional organisations to evaluate the evidence for treatments. However, there is minimal agreement between many of the current guidelines. A new approach is needed that places emphasis on "realworld" effectiveness and respects the observations of people with bipolar disorder.

Two types of bipolar disorder

As far back as Hippocrates, bipolar disorder has been known to the medical comcalled Originally munity. "manic-depressive psychosis", it is now known as bipolar I disorder. In the mid-1990s, bipolar II disorder was defined. Although this second "sibling" has always existed, it was previously viewed as more of a personality style, and frequently given the label of "cyclothymia".

Both bipolar I and bipolar II are marked by pronounced mood swings. During "highs", individuals feel energised and "wired". They talk more, spend more, and require less sleep but don't feel tired. They might experience a heightened sex drive; feel more creative, or so "bulletproof" they take more risks. Anxiety seems to melt away.

During "lows", depression rolls in like a fog. Sufferers may lie in bed for days, lacking any energy. They can't derive any pleasure in life. Cheerless and battling impaired cognitive capacity, they can be at greater risk of suicide. The key distinguishing feature between the two bipolar conditions is the presence of psychotic features (delusions and/or hallucinations) in those with bipolar I.

Current treatments

Medication is the main way bipolar disorders are managed. Melbourne psychiatrist John Cade discovered the effectiveness of lithium as a treatment for manic depression in 1949. This landmark

Accounting for side effects

In addition to evaluating the effectiveness of any drug, we need to assess the side-effects. For instance, lithium can be the right medication for some with a bipolar disorder and, as noted, it is the most frequently recommended medication across clinical guidelines. However, it has multiple side effects.

Our 2021 efficacy study compared lithium and lamotrigine in a small sample of patients with bipolar II. For the 28 patients who completed the study, the benefits were similar for the two medications. But 50 per cent of the completers receiving lithium experienced distinctive cognitive impairment — side effects that affected their thinking and reasoning. This is of particular concern because bipolar disorders are known to be over-represented in creative people and high achievers. We suspect, from clinical observation, that lithium is not the best option for bipolar II, and the first author has long observed it is more cognitively "toxic" for those individuals with a bipolar II condition.

Many of the antipsychotic drugs nominated in guidelines also have major side effects, including weight gain and diabetes. People who are stable while taking these medications without major side effects should not be alarmed. But these risks support a push for more tailored treatments based on real-life costs and benefits, informed by people's experiences. (Courtesy: Down To Earth)

Research shows that there are many benefits to napping. Short naps can boost mental functioning and memory, as well as improve alertness, attention and reaction time. Short naps are also linked to increased productivity and creativity. Because napping seems to improve creative thinking, some companies have attempted to harness this by introducing napping rooms into the workplace.

What's more, it appears the brain uses nap time to process information gathered throughout the day, which appears to enhance problem-solving abilities. One small study revealed that people who took short naps were less frustrated and impulsive, which resulted in better focus and efficiency when performing work-related tasks.

Napping may even lead to an improved ability to learn new motor skills, such as a golf swing or the playing of a musical in-

have been shown to be beneficial for both nighttime sleep and napping. Other nonspecific relaxation techniques, like listening to relaxing music, appear to also be beneficial for falling asleep. Interestingly, many people overestimate their time awake when trying to sleep and underestimate the time they actually spent sleeping. Napping can have drawbacks

One condition associated with napping longer than 30 minutes is sleep inertia – the grogginess and disorientation that people sometime experience after waking from a longer nap. Usually, the longer the nap, the more sleep inertia there is to overcome. This can impair cognitive function from several minutes up to half an hour. In many cases, these effects can be minimised by consuming caffeine directly after the nan. But it is important to note that caffeine is not a substitute for sleep. Caffeine acts

Long or late afternoon naps can also interfere with nighttime sleep, either by leading to difficulties falling asleep or staying asleep during the night. This disruption of the regular sleep-wake cycle can result in overall sleep deprivation, which can have numerous negative health effects. What's more, for those age 60 and up, longer naps beyond 30 minutes – may increase the risk for cardiovascular problems. Researchers found that older adults taking naps for more than one hour per day have a higher incidence of increased blood pressure, high blood sugar, excess body fat around the waist, and abnormal cholesterol or triglyceride levels, sometimes known as metabolic syndrome.

The reason for this phenomenon is mostly unknown. Older individuals tend to nap more frequently than younger adults partly due to more disturbed sleep during

disruptions. Nap in the early afternoon, as that aligns with a decrease in energy levels after lunch and with the body's natural circadian din, which is an increase in sleepiness similar to what occurs at dusk.

Avoid late afternoon naps, finish naps at least four to six hours before bedtime, and create the right environment by napping in a quiet, comfortable and dimly lit space. If you're struggling with daytime sleepiness, it's best to address the root cause rather than relying solely on napping. Reducing caffeine consumption, maintaining a regular sleep schedule and getting adequate nighttime sleep are essential steps to reduce daytime sleepiness.

Ultimately, napping should complement a healthy sleep routine, not serve as a substitute for sufficient nighttime rest. A balanced approach to napping can contribute to a more energised, focused and resilient life. (Courtesy: Scroll.in)

Pak's special court postpones hearing of postarrest bail applications by Imran Khan, Qureshi

ISLAMABAD, Sept 3: A special Pakistani court has postponed the hearing of post-arrest bail applications of former Prime Minister Imran Khan and his close aide Shah Mahmood Oureshi in a case related to the alleged disclosure of state secrets till the Islamabad High Court decides a plea challenging the court's jurisdiction.

The purported cipher (secret diplomatic cable) contained an account of a meeting between US State Department officials, including Assistant Secretary of State for the Bureau of South and Central Asian Affairs Donald Lu, and Pakistani envoy Asad Majeed Khan last year.

Of late, Khan has come under increased scrutiny following the publication of a purported copy of the secret cable by the US media outlet The Intercept, with many in the previous government led by Shehbaz Sharif pointing fingers at the PTI chief for being the source of the leak.

Qureshi, 67-year-old former foreign minister and Pakistan

Meanwhile, the Lahore High poned the hearing of post-arrest Court (LHC) will address petitions on Monday filed by 70-year-old Pakistan Tehreek-e-Insaf's (PTI) Khan against the rejection of his pre-arrest bail applications in seven different cases.

Khan, who served as the country's prime minister until April last year, currently faces around 180 cases. These cases primarily stem from incidents that occurred following the sacking of the Lahore corps commander's house on May 9. In these petitions, presented by Barrister Salman Safdar, Khan has also named the Attock jail superintendent as a respondent.

He argues that his bail applications were dismissed due to his non-appearance in court after being convicted in the Toshakhana case on August 5. The cricketerturned-politician seeks a fair consideration of his bail applications on their merits.

During an in-camera hearing, Judge Abual Hasnat Muhammad Zulqarnain of the Islamabad ATC-1, who was recently appointed as a judge of a special court handling cases under the Official Secrets

Act, 1923, was informed by the prosecution that Khan had challenged both the special court's jurisdiction and his jail trial in the IHC.

The court advised PTI lawyers to await the IHC's decision and consider bail matters thereafter. It further recommended withdrawing the bail applications and re-filing them after the IHC's ruling. A hearing on both defendants' bail requests is scheduled for Monday.

Additionally, an ATC in Lahore has directed authorities to include Khan's sisters, Aleema Khan and Uzma Khan, in an investigation into four different cases filed against them following incidents on May 9.

Aleema and Uzma appeared in the ATC of Judge Abher Gul after their interim bail expired. They had been requesting inclusion in the investigation for three months, and the judge ordered the investigating officers to do so promptly, expressing a desire to conclude the case and receive the investigation report. (PTI)

Netanyahu demands Eritrean migrants to be deported immediately



TEL AVIV, Sept 3: Israeli Prime Minister Benjamin Netanyahu said on Sunday he wants Eritrean migrants involved in a violent clash in Tel Aviv to be deported immediately and has ordered a plan to remove all of the country's African migrants.

The remarks came a day after bloody protests by rival groups of Eritreans in south Tel Aviv left dozens of people injured. Eritreans, supporters and oppo-

nents of Eritrea's government, faced off with construction lumber, pieces of metal and rocks, smashing shop windows and police cars. Israeli police in riot gear shot tear gas, stun grenades and live rounds while officers on horseback tried to control the protesters. The violence on Saturday re-

turned to the fore the issue of migrants, which has long divided Israel.

Its resurgence comes as Israel is torn over Netanyahu's judicial overhaul plan, and supporters cite the migrant issue as a reason why the courts should be reined in, saying they have stood in the way of pushing the migrants out.

"We want harsh measures against the rioters, including the immediate deportation of those who took part," Netanyahu said in a special ministerial meeting called to deal with the aftermath of the violence.

He requested that the ministers present him with plans "for the removal of all the other illegal infiltrators," and noted in his remarks that the Supreme Court struck down some measures meant to co-

erce the migrants to leave. About 25,000 African migrants live in Israel, mainly from Sudan and Eritrea, who say they fled conflict or repression. Israel recognizes very few as asylum seekers, seeing them overwhelmingly as economic migrants, and says it has no legal obligation to keep them.

The country has tried a variety of tactics to force them out, including sending some to a remote prison, holding part of their wages until after they agree to leave the country or offering cash payments to those who agree to move to another country, somewhere in Africa

Critics accuse the government of trying to coerce the migrants into leaving. Under international law, Israel cannot forcibly send migrants back to a country where their life or liberty may be at risk. Netanyahu said Sunday he didn't think deporting supporters of the Eritrean government would be a problem.

Migrants' supporters say Israel, a country founded upon the ashes of the Holocaust and built up by Jewish refugees, should welcome those seeking asylum. Opponents claim migrants have brought crime to the low-income southern Tel Aviv neighbourhoods where they have settled.

The clashes came as Eritrean government supporters marked the 30th anniversary of the current ruler's rise to power, an event held near the Eritrean embassy in south Tel Aviv. Eritrea has one of the world's worst human rights records and migrants in Israel and elsewhere say they fear death if they were to return

Critics see Netanyahu's judicial overhaul plan as a power grab meant to weaken the courts and limit judicial oversight on government decisions and legislation. Supporters say it is meant to restore power to elected legislators and rein in what they say is an interventionist and liberal-leaning justice system. (AP)

Pakistan's interim Taiwan suspends work, transport and classes **PM Kakar terms** as Typhoon Haikui slams into the island May 9 violence 'attempted coup'



ISLAMABAD, Sept 3: Pakistan's caretaker Prime Minister Anwaarul-Haq Kakar has termed the May 9 violence by supporters of former premier Imran Khan "an attempted coup and civil war" that targetted Army chief Gen Asim Munir and his team, a media report said on Sunday. Kakar, however, denied that revenge was a motive behind taking legal action against the perpetrators of the violence.

Dozens of military installations and government buildings, including the army headquarters in Rawalpindi, were attacked during the May 9 violence following the arrest of 70-year-old Khan by paramilitary Rangers.

"The vandalism and arson on May 9 were witnessed by the whole world and international newspapers reported the tragedy. This kind of manipulation is not acceptable in any form of govern-ment," Kakar said in an interview of Florida before he set out on a walking suffering," said Frank Davis, adding he ule Saturday included stops in Keaton former Republican New Jersey Gov.

BEIJING, Sept 3: Taiwan suspended flights, rail transport and ferry services along with classes and outdoor events and urged workers to stay home on Sunday as Typhoon Haikui churned across the southern part of the island. The typhoon made landfall in Taitung county on the Pacific-facing east coast around 3 pm

(0700 GMT) Sunday, bringing sustained winds of 155 kph (96 mph) and gusts of 190 kph (120 mph). The winds and driving rains forced in unse-

cured doors, uprooted trees — at least one of which crushed a parked minivan - and caused flooding in some low-lying areas. There had been no mass evacuations, although dozens sheltered in school gymnasiums and public meeting halls.

There appeared to be little serious damage, and some shops remained open, partly to dispose of locally grown fruits and vegetables that would otherwise go to waste.

Haikui's arrival came as Typhoon Saola continued to weaken while swirling along the Chinese coast, where 900,000 people and 80,000 fishing vessels had been moved to safety.

Most of Hong Kong and parts of the coastal mainland had suspended business, transport and classes. Damage appeared to be minimal, however, and restrictions had largely been lifted by



Sunday. On Saturday night, the Hong Kong Observatory had canceled all warnings.

Among events cancelled in Taiwan were a hot air balloon festival in the central Taichung region, several outdoor concerts, art events and a baseball game. National parks and treacherous roads in the island's mountainous center were also closed.

Haikui was expected to continue toward China after crossing over Taiwan, and authorities in the Chinese city of Shantou in Guangdong province were advising residents to take precautions

workers in a number of Chinese cities stayed at home and students saw the start of their school year postponed from Friday to Monday. Trading on Hong Kong's stock market was suspended Friday and hundreds of people were stranded at the airport after about 460 flights were canceled in the key regional business and travel hub.

The cross-border bridge connecting Hong Kong, the gambling hub of Macao and manufacturing center of Zhuhai was closed at one point, with Macao leader Ho Iat Seng ordering a halt to casino operations.

In recent months, China has experienced some of its heaviest rains and deadliest flooding in years. Dozens of people have been killed, including in outlying mountainous parts of the capital, Beijing.

Despite the twin storms, China's military continued to conduct operations meant to intimidate Taiwan, a self-ruled democracy that Beijing seeks to bring under Chinese sovereignty by force if necessary.

Taiwan's Defense Ministry said it was monitoring the movements of Chinese military aircraft and navy ships near the island. However, it said there were no indications any had crossed the median line in the Taiwan Strait or entered Taiwan's air defense identification zone as they frequently do. (AP)

Pope joins shamans and evangelicals to highlight Mongolia's faith diversity

ULAANBAATAR, Sept 3: With China's crackdown on religious minorities as a backdrop, Pope Francis joined Mongolian shamans, Buddhist monks and a Russian Orthodox priest Sunday to highlight the role that religions can play in forging world peace, as he presided over an interfaith meeting highlighting Mongolia's tradition of religious tolerance. Francis listened intently as a dozen faith leaders — Jewish, Muslim, Bahai, Hindu, Shinto and evangelical Christian among them - described their beliefs and their relationship with heaven. Several said the traditional Mongolian ger, or round-shaped yurt, was a potent symbol of harmony with the divine — a warm place of family unity, open to the heavens, where strangers are welcome. The interfaith event, held at a theater in the capital, Ulaanbaatar, came midway through Francis' four-day visit to Mongolia, the first by a pope. He is in Mongolia to minister to one of the world's smallest and newest Catholic communities and highlight Mongolia's tradition of tolerance in a region where the Holy See's relations with neighbouring China and Russia are often strained. According to statistics by the Catholic nonprofit group Aid to the Church in Need, Mongolia is 53% Buddhist, 39% atheist, 3% Muslim, 3% Shaman and 2% Christian. Later Sunday, Francis was to preside over a Mass in the capital's sports stadium that the Vatican had said would also be attended by pilgrims from China. One small group of Chinese faithful from Xinjiang attended his meeting at the city's cathedral Saturday. (AP)

Ukrainian prosecutors also announced Sunday that they had opened a war crimes investigation into the death of a police officer killed by Russian shelling on the town of Seredyna-Buda on Saturdav afternoon.

Two other police officers and one civilian were wounded during the attack, which hit Ukraine's north-eastern Sumy region. (AP)

Plans for permanent memorial to UK's Queen **Elizabeth II to be unveiled in 2026**

LONDON, Sept 3: The plans for a permanent memorial to the late Queen Elizabeth II will be unveiled by an independent body chaired by her former Private Secretary in 2026, the year that would have marked the monarch's 100th birthday, the UK government announced in London on Sunday. Queen Elizabeth II died aged 96

at Balmoral Castle in Scotland on September 8 last year before being laid to rest at St George's Chapel in Windsor Castle in a State Funeral on September 19.

As the one-year anniversary of her passing approaches this month, the Cabinet Office unveiled plans for a "fitting tribute" to be finalised by a new Queen Elizabeth Memorial Committee to be chaired by Lord Robin Janvrin

The committee will be responsi-

ble for considering and recommending proposals for a memorial to Queen Elizabeth II, jointly supported by the UK government and the Royal Household.

It will develop proposals for both a permanent memorial and a national legacy programme that will allow everyone in the UK to commemorate Queen Elizabeth's life of service, the Cabinet Office said

"It is an honour to be asked to chair the Queen Elizabeth Memorial Committee. It will be a unique challenge to try to capture for future generations Her Late Majesty's extraordinary contribution to our national life throughout her very long reign," said Lord Janvrin.

Campaigning for bypolls in Tripura ends

AGARTALA, Sept 3: Campaigning for the September 5 bypolls in Dhanpur and Boxanagar assembly seats in Tripura's Sepahijala district ended on Sunday.

In both the constituencies, BJP organised mega rallies, road shows, motorbike rallies and door-to-door campaigns to reach out to voters. Chief minister Manik Saha led

the party's campaign from the front while ministers, MLAs and leaders joined the campaign trail in the last couple of days.

CPI(M) politburo member Manik Sarkar and party's state secretary Jitendra Chaudhury along with leaders campaigned for its candidates, but Tipra Motha, the main opposition, and Congress stayed away from campaigning making the electoral battle an oneon-one contest

BJP's Tafajjal Hussain, who unsuccessfully contested the Assembly election in February, will take on CPI(M)'s Mizan Hussain in minority-dominated Boxanagar constituency, still considered the Left party's stronghold.

Despite efforts by the BJP, the CPI(M) had managed to retain the seat by a margin of 4,849 votes. Of the total 43,087 voters, electors from the minority community count for around 55 per cent, which is seen as a major vote bank for the CPI(M).

Dhanpur, once a strong bastion of the communists, is heading for direct fight between BJP's Bindu Debnath and CPI(M)'s Kaushik Debnath. According to political analysts, two independent candidates who are in the battle are unlikely to make any impact.

In the 2023 Assembly elections, the BJP won by a margin of 3,500 votes and the Tipra Motha nominee had polled over 8,000 votes, which ensured the saffron party's victory after 25 five years. Mizan is the son of Boxanagar CPI(M) MLA Samsol Haque who passed away in July causing a vacancy. The bypoll in Dhanpur was necessitated after Union minister Pratima Bhoumik resigned from the assembly days after her election.

"The campaign for the bypolls in two Assembly constituencies came to an end on Sunday without any trouble. All steps have been taken to ensure free, fair and peaceful bypolls on September 5", Sepahijala district magistrate told PTI.

Out of the total 110 booths, around 34 have been categorised as vulnerable where paramilitary forces will be deployed, he said, adding around 2,500 CRPF and Tripura State Rifles (TSR) jawans have been deployed for the polls. (PTI)

IMPHAL, Sept 3: The Manipur government has shifted the last of 10 Kuki families comprising 24 members from Imphal's New Lambulane area where they had been living for decades and did not move elsewhere even after the ethnic violence broke out in Manipur four months ago.

These families were taken to the Kuki-dominated Kangpokpi district on the northern side of Imphal Valley early on Saturday, as they had become "vulnerable targets", an official said.

The last of 10 Kuki families were provided "safe passage" to Motbung, in Kangpokpi district, some 25 km from Imphal, he said. But Kuki families alleged that they were forcibly evicted from their residences in the New Lambulane area to Motbung.

S Prim Vaiphei, one of the volunteers guarding the Kuki locality in the heart of Imphal, said that a "team of uniformed armed personnel claiming to be acting under directions from the home department

came to New Lambulane, Imphal in the intervening night of September 1 and 2 and forcibly evicted the last remaining residents of the Kuki locality in Imphal from their homes" Around 300 tribal families, who

"Twenty-four of us were not given time to even pack our belongings and we were herded into vehicles with only the clothes we were wearing," Vaiphei said in a statement.

Expressing strong displeasure over the "forcible eviction", Kuki Inpi Manipur, the apex body of the Kuki tribes, in two statements, said, they stood "aghast at the das-

tardly attack against the last of the Kuki Zo volunteers (numbering about 24 men) who have been guarding the houses and properties of the Kukis at New Lambulane. The volunteers were later escorted by security personnel".

The Kuki body reiterated its demand for a separate administration.

"There is now total separation of the Meiteis and Kukis..it is imperative that the central govt should constitutionally recognise this separation at the earliest," it said.

Tripura ex-CM criticises 'one nation, one election' panel



AGARTALA, Sept 3: Former Tripura chief minister and CPI(M) leader Manik Sarkar has slammed the Centre for the formation of a panel to explore the feasibility of 'one nation, one election' and calling a special Parliament session this month, stating that the BJP is "scared" of the opposition bloc INDIA. Sarkar, the CPI(M) politburo member, claimed that the "Centre is reportedly planning to bring a new bill in the Lok Sabha to implement 'one nation, one election' idea".

"The Narendra Modi government has convened a special session of Parliament without unfolding the agenda just a few days after the conclusion of the Monsoon session. "In a democracy, the government

can convene such a special session but what is the motive? The Centre is reportedly planning to bring a new bill to implement the 'one nation, one election' idea," he said on Saturday during an election rally at Manaipathar under the Dhanpur Assembly constituency in Sepahijala district.

Bypolls to Dhanpur and Boxanagar Assembly seats in Sepahijala district will be held on September 5.

Sarkar also claimed that the BJP is "apprehensive" about the electoral outcome in the upcoming assembly polls in five states and the 2024 Lok Sabha elections.

'They are scared of the opposition alliance INDIA. It will be tough for the BJP to return to Delhi if the saffron party faces defeat in the upcoming assembly elections in five states. That's the reason, it contemplates to push one nation one idea before the next general elections," the CPI(M) leader said.

The Centre has constituted the committee headed by former president Ram Nath Kovind to explore the possibility of 'one nation, one election'

The move comes after the government called a special session of Parliament between September 18 and 22, the agenda for which is under wraps.

In Tripura, the BJP's vote share has reduced from 51 per cent in 2018 to 39 per cent in the 2023 Assembly elections and its seat count has also slipped from 46 to 33 during the period, Sarkar added. (PTI)


Arunachal small traders seek resumption of operation in Indo-Myanmar border haat

NAMPONG, Sept 3: The Covid-19 pandemic came as a bolt from the blue for Khingwom Mossang and many of her peers as their source of income from trading activities at Pangsau Pass in Changlang district of Arunachal Pradesh, along the India-Myanmar border, came to a grinding halt in 2020.

Not only Mossang but over 100 small traders have been facing difficulties after the border trade with Myanmar stopped with the outbreak of the pandemic.

Two years on, they are still running from pillar to post to sustain their families and pleading with the government for early resumption of border trade, which began in 2000.

For 46-year-old Mossang, the sudden halt in trading activities at phase of life. We are finding difficul-

in border trade after 2000, and trading was their only source of income. They earned an average of ₹ 1-1.5

lakh per month. "We could not even recover our money as we supplied commodities to the traders of Myanmar on credit,' Mossang, who used to sell vegetables, grocery items and utensils, said, while appealing to the government to initiate measures to re-open border trade.

Tenya Mossang (47), another trader from Nampong, has a similar story to tell.

"The economic conditions of many families, who were dependent on the border trade, became worse. They are now facing difficulties to survive," Tenya, who owns a small shop in Nampong town, said.

"Earlier, I earned an average of ₹

40,000 monthly by selling cosmetic products and food items through border trade. But now I am hardly able to earn ₹ 5,000 a month, which is not enough to fulfil the needs of my family," she added.

Wichak Morang (36) from Theremkan Village near Nampong is now working as a daily wage earner after the border trade activities stopped.

"We are now in a very bad condition with no income source. Whatever I earn from daily work is not sufficient. I hope the government will soon reopen the border trade keeping in view the interest of small traders like us," said Morang, who earlier managed an earning of ₹ 20,000 per month by selling bakery products and vegetables. (PTI)

The counting of votes will take place on September 8

KOLKATA, Sept 3: The INDIA opposition bloc faces a crucial test in the upcoming bypoll in Dhupguri assembly segment as its important constituents, TMC and Congress-CPI(M) alliance, fight it out against each other to wrest the rural seat in North Bengal from the BJP.

The bypoll on September 5 is also a litmus test for all three political outfits, with the BJP hoping to check its erosion in its vote share and retain the seat, the TMC aiming to wrest the tribal-dominated assembly segment and the CPI(M)-Congress alliance hoping to regain its traditional seat.

The bypoll was necessitated following the death of its sitting BJP MLA Bishu Pada Ray earlier this year.

Dotted by tea gardens, the seat in Jalpaiguri district is an agricultural settlement with a considerable population of Rajbanshis and Matua communities, who voted for the saffron camp in the 2021 assembly polls. The constituency also has around 15 per cent minority population

CPI(M) state secretary Mohammed Salim and Congress president Adhir Rajan Chowdhury held a massive rally in Dhupguri, hitting out at both the TMC and the BJP, as their central leadership was holding brainstorming session with the TMC and other anti-BJP parties at the third INDIA opposition meet to discuss the strategy to defeat the saffron camp in 2024 Lok Sabha elections.

Although the CPI(M), Congress and TMC have dubbed it as local elections, with no bearings on opposition unity efforts, the BJP has gone hammer and tongs pointing at the frictions in the INDIA camp.



"It is a local election and has nothing to do with the INDIA opposition bloc. At the local level, we are fighting our own battle," state Congress president Adhir Ranjan Chowdhury said

Frequent polls, it said, disrupt developmental work on account of prolonged application of the Model Code of Conduct. "Now, therefore, in view of the above and that in the national interest it is desirable to have simultaneous elections in the country, the Government of India hereby constitutes a high-level committee to examine the issue of simultaneous elections and make recommendations for holding simultaneous elections in the country," the resolution said. 'Darwaze pe dastak', food vigil by mess workers: Kota police's new attempt at checking student suicides

KOTA (RAJN), Sept 3: Rocked by a spate of student suicides, the coaching hub of Kota is roping in wardens, mess workers and tiffin service providers to look for any signs of depression or stress among the students staying in hostels and PG accommodations

While the wardens are being encouraged to participate actively in the 'Darwaze pe dastak' (knock on door) campaign, the city police has urged the mess workers and tiffin providers to report if a student is repetitively absent from the mess and skipping meals or anyone's tiffin is found unconsumed.

'We have launched a campaign called 'Darwaze pe dastak' where we are encouraging wardens to make it a routine to knock on each students' door at around 11 pm, ask them if they are okay, notice their activities, and keep a vigil just to ensure that there are no signs of stress, depression or abnormal activity

"After coaching, the students spend maximum time in hostels, and hence wardens should be the first one to notice the signs," Chandrasheel Thakur, ASP. Kota told PTL

Over 2.5 lakh students move to Kota annually to prepare for competitive exams such as the Joint Entrance Exam (JEE) for engineering and the National Eligibility-cum-Entrance Test (NEET) for admission to medical colleges.

The year 2023 saw the highest number of student suicides -- 22 so far -- with two ending their lives in a gap of a few hours on August 27. Last year, the figure was 15.

Packed schedule, cut-throat competition, constant pressure to do better, burden of parents' expectations and homesickness are the common struggles of the students here.

Psychologists have been warning that there are always signs that go undetected before any child takes the extreme step.

"The idea is to detect these early signs. If any student is repetitively missing classes or skipping meals, there has to be something. We want to identify these children, get them counselled before they get pushed to the brim. We have launched a dedicated number on which wardens, mess workers and tiffin providers can give us this information," he

Naveen Mittal, president, Kota Hostel Association said there are 3,500 hostels and 25,000 paying guest (PG) accommodations in Kota. Garima Singh, warden, Amratingali Girls Residency said she knocks on the doors of children regularly.

"The idea is not to disturb them, but to keep a check if they are fine. If someone is sleeping for unusual hours, I discuss with them if they are just tired or unwell. I check their mess logbooks too. If someone has not eaten meals in the mess, I ask if he or she did not like the food or is it because of some stress," she said.

The district administration recently directed the coaching institutes to stop conducting routine tests for students preparing for NEET and other competitive exams for the next two months in the wake of the latest suicides.

Gagendra Soni, warden of a boys hostel said, "Some boys opt for tiffin service rather than mess food. We notice sometimes that the tiffin is lying outside the room. We take it very seriously now and try to strike a conversation." (PTI)

MUMBAI, Sept 3: In the wake of violence in Maharashtra's Jalna district over the Maratha quota demand, chief minister Eknath Shinde on Sunday said his government was committed to providing reservation to this community in education and government jobs. Talking to reporters after attending a state function in Buldhana district, around 450 km from here, he also said that there was no misunderstanding between him and two deputy chief ministers in the state and that all of them were working as a good team. "My government is committed to giving reservation to

the Maratha community in the state. We will not sit quiet until the community get its due reservation," Shinde said. "Till the Maratha community gets reservation, the gov-

ernment schemes that are already in place will continue and deserving people from the Maratha community will benefit from it," he added. Reservation in jobs and education provided by the state government to the Maratha community was quashed by the Supreme Court in May 2021, citing the 50 per cent ceiling on total reservations among other grounds.

An agitation seeking reservation for the Marathas turned violent at Antarwali Sarathi village in Jalna on Friday, leading to several people, including dozens of police personnel, getting injured. Police resorted to lathi-charge and lobbed tear gas shells to disperse a violent mob that allegedly re-



fused to let authorities shift a man on a hunger strike as part of the quota stir to the hospital. Police registered a case against more than 360 people in connection with the violence, officials said.

When asked why deputy chief minister Ajit Pawar, who along with eight other Nationalist Congress Party (NCP) MLAs joined his government two months ago, was not present at the event, CM Shinde said, "Ajit Pawar informed me that he is unwell. He is down with fever, while Deputy CM Devendra Fadnavis is in Ladakh to attend a military event." (PTI)

Congress to hold yatras at district level to mark Stray dogs picked up in illegal, cruel first anniversary of Bharat Jodo Yatra: Sources fashion in the wake of G20 Summit: PFA

NEW DELHI, Sept 3: The Congress is set to hold yatras at the district level to commemorate the Kanyakumari-to-Kashmir Bharat Jodo Yatra, which was launched on September 7 last year, sources said on Sunday.

The party is planning to mark in a big way the beginning of the cross-country march that saw Rahul Gandhi, along with several party leaders, traverse over 4,000 kilometres and interact with a cross-section of society.

The sources said yatras will be held at the district level to mark the one-year anniversary of the beginning of the Bharat Jodo Yatra on September 7 last year.

They said the modalities of how long the yatras will be and other details are being worked out.

Gandhi launched the yatra on September 7, 2022, in Kanyakumari. It ended on January 30 this year as Gandhi capped his ambitious 145-day journey in Srinagar. "I have not done this (yatra) for myself or for the Congress but for the people of the country. Our aim is to stand against the ideology that wants to destroy the foundation of this country," Gandhi had said at the Sher-e-Kashmir Cricket Stadium in Srinagar at a rally marking the grand finale of the cross-country march. During the course of the yatra, Gandhi addressed 12 public meetings, over 100 corner meetings and 13 press conferences. He had over 275 planned walking interactions and more than 100 sitting interactions. Many experts had said a big takeaway from the yatra for the Congress had been Gandhi's image transformation -- from a reluctant and part-time politician to one who is mature and taken seriously by opponents.

Jairam Ramesh, the Congress

general secretary, considered the brain behind the yatra along with party colleague Digvijaya Singh, had said back then that the transformation of Gandhi's image was not the cause of the yatra but a consequence of it.

Asserting that the Congress made huge gains from the yatra, Ramesh had said the party succeeded in conveying the messages of the march -- the threats to the republic from economic inequalities, social polarisation and political dictatorship. With over 4,000 kilometres under his belt, Gandhi had managed to catch the attention of his supporters as well as detractors and the march saw participation from a cross-section of society, including film and TV celebrities such as Kamal Haasan, Pooja Bhatt, Riya Sen, Sushant Singh, Swara Bhasker, Rashami Desai, Akanksha Puri and Amol Palekar. (PTI)

NEW DELHI, Sept 3: The Municipal Corporation of Delhi has started picking up stray dogs, mostly sterilised in "illegal" manner and without any written orders, in the wake of the G20 Summit scheduled on September 8-10, People For Animals claimed in a statement on Sunday.

The People For Animals (PFA) was reached out by air travellers at Terminal 2 who spotted "screaming and yelping" dogs being "dragged by neck" using wires by "what looked like class 4 untrained workers" before being bundled into vehicles, the statement said.

Another stray dog feeder also approached the PFA saying that a lactating mother with tiny pups was picked up from Pragati Maidan and "no one knows if all the pups have been taken or some carelessly left behind"

The animal rights group said after the hasty withdrawal of its "ill-thought out order dated August 3" to remove stray dogs across 47 locations in the city, the Municipal Corporation of Delhi (MCD) has chosen to avoid sharing any plans or orders, and simply gone ahead to pick up dogs randomly

The statement said on September 1, catching

teams swooped down on two locations -- Pragati Maidan where the long suffering dogs had been picked just over a month ago, and the Airport terminal-2 area

"Having got wind of their intentions, the animal welfare community had actually offered its help towards the safe collection and keeping of dogs by involving local feeders in the exercise. Spurning the offer, MCD went ahead to blatantly and illegally pick up mostly sterilised dogs," it said.

PFA said the airport area from where dogs have never been previously picked was targeted by three teams

"Some 60 harmless, sterilised and mostly very old dogs were caught and incarcerated at illequipped centres that have neither fans nor adequate staff nor even food. Only dry kibble was provided at one centre which street dogs do not eat," the group said.

Ambika Shukla, trustee of PFA, said there is no need to remove friendly, gentle and sterilised dogs and if you are going to do it, do it properly.

"The animal welfare community actually reached out to MCD to help towards collecting the dogs kindly and safely. Had local caretakers been involved in the process as we suggested, there would have been no cruelty, chasing or missing dogs," she said. Shukla said like other fields where experts are roped in, animal welfare people must be involved in issues dealing with stray animals.

"Rough, untrained Class 4 staff cannot be expected to handle dogs humanely. Why not take those who can? Every holding unit needs to be open to feeders and caretakers towards the best care for the dogs during their stay," she said. (PTI)

Delhi Metro to sell 'Tourist Smart Cards' through dedicated counters from today



NEW DELHI, Sept 3: Anticipating increased passenger footfall for the G20 Summit, the Delhi Metro will sell 'Tourist Smart Cards' through dedicated counters at 36 stations from September 4-13, officials said.

These cards will be available in two categories -- one-day and three-day validity -- offering "unlimited rides" in the metro network.

The Tourist Smart Cards are available on regular days too but, in view of the G20 Summit, dedicated counters have been opened to sell these cards for a period of 10 days from Monday, a senior official said.

The G20 Leaders' Summit is slated to take

place in New Delhi from September 9-10. The dedicated counters have been provided to "facilitate G20 delegates and international visitors who might be interested in exploring the prominent tourist places of the capital city as they arrive in Delhi, owing to the upcoming G20 Summit," the official said.

The one-day card will be available for ₹ 200 while the three-day card will cost ₹ 500. This amount also includes a refundable security deposit of ₹ 50, the Delhi Metro Rail Corporation (DMRC) said.

The 36 stations where these cards will be sold through dedicated counters include Kashmere

Gate, Chandni Chowk, Chawri Bazar, New Delhi, Rajiv Chowk, Patel Chowk, Central Secretariat, Udyog Bhawan, Lok Kalyan Marg, Supreme Court, ITO, Hauz Khas, Nehru Place, Kalkaji Mandir, Akshardham and Terminal 1 IGI Airport. Besides unlimited rides, these cards are of great benefit to tourists as they can seamlessly travel in the entire network from the first train to the last service available for the day, the officials said.

'There are no penalties or surcharge levied on the use of Tourist Smart Cards on account of instances like entry or exit mismatch, overstay in system, overstepping etc," the DMRC said.

Delhi Metro, India's largest metro network, ranked among one of the largest metro systems in the world is well connected to almost all the prominent tourist destinations in the city such as Red Fort, Jama Masjid, Akshardham Temple, Kalkaji Temple, Qutub Minar, to name a few.

Tourists can seamlessly reach these tourist places by travelling on various corridors of the Delhi Metro by using these cards. Tourists can also download the 'Delhi Metro Rail' app for more details on the network to plan their journeys. The app also includes a dedicated section on the home page under 'Tour Guide' where they can find the list of all stations and tourist places nearby, the officials said.

Tourist Smart Cards are also available at all metro stations (except Airport Express Line) across the network. Anyone wanting to explore the city can avail of these cards from the stations at any time during the day, they said. (PTI)

MBSG CLINCHED THE TITLE FOR FIRS Mohun Bagan beat East Bengal **1-0 to win Durand Cup title**

KOLKATA, Sept 3: A mo-ment of sheer brilliance from Dimitri Petratos proved decisive as 10-man Mohun Bagan Super Giant beat arch-rivals East Bengal 1-0 in a fiercely contested final to clinch Durand Cup title for the first time after 23 years here on Sunday.

Mohun Bagan were one-man down after Anirudh Thapa was sent off in the 62nd minute, but they still scored the decisive goal through a brilliant solo effort from Petratos in the 71st minute

In a swift counter-attacking move, the Australian player skilfully weaved past the East Bengal defence, before unleashing a powerful strike from 25 yards out. East Bengal goalkeeper Prabhsukhan Singh Gill was left a mute spectator.

This was Mohun Bagan's 17th Durand Cup title. They last won the title in 2000 when they beat Mahindra United via a golden goal.

As the clock ticked away, East Bengal coach Carles Cuadrat made three changes, bringing in Nishu Kumar, VP Suhair and Edwin Vanspaul in the last 10 minutes in a bid to restore parity.

His Mohun Bagan counterpart Juan Ferrando pressed eight players into his defence with Anwar Ali rock solid in the middle.

In a heated exchange, East Bengal's assistant coach Dimas Delgado got into a war of words with Ferrando, and after a scuffle, the former received a red card in the second-half extra



time In the 86th minute, Edwin Vanspaul attempted a shot on target from outside the box, but Anwar Ali was quick to react, making a timely block to deny East Bengal any chance of an equaliser.

Mohun Bagan thus avenged their 2004 Durand Cup final defeat to East Bengal when they had lost 1-2.

HARARE, Sept 3: Former Zimbabwe captain Heath Streak died on Sunday at the age of 49, his family confirmed on social media.

Streak, who played 65 Tests and 189 ODIs for Zimbabwe from 1993-2005, was battling liver cancer for a long time.

"In the early hours of this morning, Sunday the 3rd of September 2023, the greatest love of my life and the father of my beautiful children, was carried to be with the Angels from his home where he wished to spend his last days surrounded by his family and closest loved ones," wrote Streak's wife Nadine on Facebook. "He was covered in love and peace and did not walk off the Park alone. Our souls are joined for eternity Streaky. Till I hold you again," Nadine added.

A few days ago, former Zimbabwe fast bowler Henry

Olonga announced the demise of Streak on social media, only to denv it hours later after a message from his captain, but by then condolence messages by several former cricketers had surfaced.

"RIP Streaky," Olonga wrote on X, formerly Twitter, on Sun-

In Test cricket, Streak claimed 216 wickets and scored one century and 11 half-centuries for Zimbabwe. In 189 ODIs, he bagged 239 wickets and made 2.943 runs with 13 fifties. He is the highest wicket-taker for Zimbabwe by a long margin in both Tests and ODIs.

In 68 ODIs as captain, he led Zimbabwe to win in 18 and lost 47 while three finished without any result. In 21 Tests, Streak captained Zimbabwe to wins in four while they lost 11 and drew six. (PTI)


