Employees will have to seek permission from govt for 2<sup>nd</sup> marriage if spouse is alive: Official notification

# Govt goes tough on staff indulging in bigamy

HT Bureau GUWAHATI, Oct 26: The state government employees will have to think twice before opting for a second marriage with the government warning of punitive action against any employee indulging in

The state government has barred its employees from marrying another person if the spouse is alive.

The office memorandum (OM) by the personnel department, which did not mention about the divorce criterion, instructed employees to take the government's permission before marrying another person if the spouse is alive.

"No government servant who has a wife living shall contract another marriage without first obtain-



ing the permission of the government, notwithstanding that such subsequent marriage is permissible under the personal law for the time being applicable to him," it added.

servant shall marry any person who has a husband living without first obtaining the permission of the government, said the OM, which came into force with imme-

The notification was issued by personnel additional chief secretary Niraj Verma on October 20. It said the guidelines have been issued as per the provisions of Rule 26 of The Assam Civil Services (Conduct) Rules 1965.

"In the context of the above provisions, the disciplinary authority may initiate immediate departmental proceedings...for imposition of major penalty, including compulsory retirement," the order stated.

It termed such a practice as a gross misconduct on the part of a government servant having 'large bearings' on society.

The OM further asked authorities to also take necessary legal steps whenever such cases are de-

# Israeli troops launch ground raid into Gaza

RAFAH, Oct 26: Israeli troops and tanks launched a ground raid into northern Gaza that lasted throughout Wednesday night into Thursday, the military said, striking several militant targets in order to "prepare the battlefield" before a widely expected ground invasion after more than two weeks of devastating airstrikes.

The hours-long raid came after the UN warned that's it's on the verge of running out of fuel in the Gaza Strip, forcing it to sharply curtail relief efforts in the territory, which has also been under a complete siege since Hamas' bloody rampage across southern Israel ignited the war earlier this month.

The rising death tolls in Gaza are unprecedented in the decades-long Israeli-Palestinian conflict.

Even greater loss of life could come if Israel launches an expected ground offensive aimed at crushing Hamas which has ruled Gaza since



2007 and survived four previous wars with Israel.

The health ministry in Hamasruled Gaza said on Wednesday that more than 750 people were killed over the past 24 hours, higher than the 704 killed the previous day.

The Associated Press couldn't independently verify the death toll, and the ministry doesn't distinguish between civilians and combatants. By comparison, 2,251 Palestinians, mostly civilians, were killed in the entire six-week-long war in 2014, according to UN figures. On Wednesday, the wife, son, daughter and grandson of Wael Dahdouh, a veteran Al-Jazeera correspondent in Gaza, were killed in an Israeli strike. The (CONTD. ON PAGE-9)

# ULFA (pro-talk) seeks reservation in 94 assembly seats for indigenous people

JORHAT/GOLAGHAT, Oct 26: The pro-talk faction of the United Liberation Front of Asom (ULFA) has demanded reservation in 94 assembly constituencies for the indigenous people of the state, an office bearer of the organization said on Thursday

ULFA (pro-talk) general secretary Anup Chetia said they have sent their suggestions to the Centre on the draft peace agreement and are waiting for a response from the Union government.

"We want reservation in 94 seats of Assam legislative assembly for the indigenous people of the state. This is more important after the delimitation exercise," he said.

In August, the Election Commission published its final delimitation report by retaining the number of assembly seats in Assam at 126 and the Lok Sabha constituencies at 14. The state has seven Rajya Sabha seats. It revised the nomenclature of one parliamentary and 19 assembly



Talking about the decades-old issues related to ULFA, Chetia expressed his faith in the present government to solve them amicably.

### 8 Indians awarded death sentence in Qatar; India deeply shocked

NEW DELHI, Oct 26: Eight former Indian Navy personnel were on Thursday handed death penalty in Oatar by a local court, a verdict that India described as "deeply" shocking.

The Indian nationals, all employees of Al Dahra company, were taken into custody in August last year in an alleged case of espionage. The charges against the Indian nationals were not made public by Qatari authorities.

In its reaction, the Union ministry of external affairs (MEA) said it is attaching "high importance" to this case and is exploring all legal options.

"We have initial information that the Court of First Instance of Qatar has today passed a judgement in the case involving eight Indian employees of Al Dahra company," it said.

## 30 lakh EVMs, over year long preparations for simultaneous LS, assembly polls

NEW DELHI, Oct 26: The Election Commission to store the electronic voting machines will require around 30 lakh electronic voting machines (EVMs) and a preparation time of nearly one-and-half years for the smooth conduct of simultaneous elections to the Lok Sabha and state assemblies, sources

An EVM comprises one control unit, at least one ballot unit and one voter verifiable paper audit trail (VVPAT) unit.

According to the sources, the commission will reguire nearly 30 lakh control units, about 43 lakh ballot units and about 32 lakh VVPATs for the simultaneous polls, taking into consideration the reserve units kept for replacement in case of any malfunction or damage. Sources said there is a shortfall of nearly 35 lakh voting units -- control units, ballot units and VVPAT units -- for the simultaneous conduct of Lok Sabha and as-

As deliberations on the conduct of simultaneous polls gathered steam, the Election Commission had informed the Law Commission a few months ago that it would also require adequate warehousing facilities

The Law Commission, which is working on a report

on holding simultaneous elections to Lok Sabha and state assemblies, had organized an interaction with the EC on its requirements and challenges for holding synchronized polls.

Sources aware of the interaction said much would depend on the number of polling stations set up when such an exercise takes place. When Lok Sabha and assembly elections are held simultaneously in some states, voters cast their votes in two separate EVMs. In the last Lok Sabha elections, there were 12.50 lakh polling stations.

The commission now requires around 15 lakh control units, 15 lakh VVPAT units and 18 lakh ballot units for 12.50 lakh polling stations.

An EVM has shelf life of 15 years. While there was no official estimate available on how much these voting units cost, at the previous procurement rates also the total cost for one crore units will be in excess of ₹ 15,000 crore, including over ₹ 6,500 crore for VVPAT units. (CONTD. ON PAGE-9)

#### EC issues notice to **Assam CM Sarma for** 'Akbar' remarks

NEW DELHI, Oct 26: The Election Commission on Thursday issued a show-cause notice to Assam chief minister and BJP leader Himanta Biswa Sarma for his remarks targeting Chhattisgarh minister Mohammad Akbar during the assembly poll campaign last week.

The commission has asked Sarma to respond to the notice by 5 pm on October 30. The EC action came a day after

the Congress filed a complaint with it against Sarma. In a speech in Kawardha in Chhattisgarh on October 18, Sarma had taken a controversial dig at Akbar saying that "the land of Mata Kaushalya will get defiled if Akbar isn't sent off." "If one Akbar comes to some place, he calls 100 Akbars. So, send him off as soon as possible, otherwise the land of Mata Kaushalya will get defiled," he said.

The developed nations are projected to collectively emit around 3.7 giga tones extra carbon dioxide in 2030 against the reduction goals outlined in their nationally determined contributions (NDCs) under the Paris Agreement, according to a new analysis released on Thursday.

This represents a 38 per cent emission overshoot, with the US, the European Union, and Russia responsible for 83 per cent of this.

Emission overshoot refers to a situation where the greenhouse gas emissions released into the atmosphere exceed the targets or limits set to mitigate climate change.

# Toyota initiates process to enhance manufacturing capacity in India

**TOKYO, Oct 26:** Japanese auto major Toyota Motor Corporation has initiated the process to enhance manufacturing capacity in India with two plants running at full capacity in the country, a senior company official said on Thursday.

Speaking to media on the sidelines of the Japan Mobility Show here. Toyota Motor Corporation Board Member and Executive Vice President Yoichi Miyazaki confirmed the development and said the company is reaching full plant capacity utilisation in India.

"We have started a discussion (on the matter)," he said when asked if the company is looking to make fresh investment on capacity enhancement in the country.

He said the demand for automobiles, especially higher segment cars, has surged in India post Covid. "After Covid, the market recovery is very strong (in India) in comparison to other countries so we believe demand itself is very strong in India," the company executive said.

Bengaluru-based Toyota Kirloskar Motor, a joint venture between Toyota Motor Company and



Kirloskar Group, operates two plants with a total production capacity of 3.42 lakh units per annum. With enhanced demand leading to long waiting periods on certain products, the automaker is now looking to set up a third plant in India.

Miyazaki said it is a good sign for the automaker that the car market in India has started to witness a gradual increase in acceptance of bigger cars.

When asked if the Indian car

market moving from small cars to higher segments makes the market more attractive for Toyota, he said, "With the strength of higher segments going up in the Indian market, it tells us it is now Toyota's

TKM has seen a robust increase in demand for its models this year. During April-September period, its sales grew 35 per cent to 1,23,939 units from 91,843 units in

## Govt rolls out mandatory quality norms for helmets for police force, water dispensers

ernment has issued mandatory quality norms for helmets for police force, bottled water dispensers, and door fittings to curb the import of sub-standard goods and boost domestic manufacturing of these goods. Three separate notifications - Helmets for Police Force, Civil Defence and Personal Protection (Quality Control) Order, 2023, Bottled Water Dispensers (Quality Control) Order, 2023, and Door Fittings (Quality Control) Order, 2023 -- were issued in this regard by the Department for Promotion of Industry and Internal Trade (DPIIT) on October 23. Under these orders, items cannot be produced, sold, traded, imported and stocked unless they bear the Bureau of Indian Standards (BIS) mark. These orders will come into force with effect from six months from the date of publication of the

notifications, the DPIIT said. In order to safeguard the domestic small/micro industries, ensure smooth implementation of the QCO and ease of doing business, relaxations have been granted to small/micro industries as regards to timeliness, additional nine months have been given to small industries and an additional 12 months to micro industries, the de-



partment said. DPIIT in consultation with BIS and stakeholders has been identifying key products for notifying QCO. This has led to the initiation of development of more than 60 new QCOs covering 318 product standards.

Violation of the provision of the BIS Act can attract imprisonment of up to two years or a fine of at least ₹ 2 lakh for the first offence.

# travel portals to discuss consumer grievances on Nov 8 NEW DELHI, Oct 26: Amid rising complaints from

air travellers, the Centre has called a meeting on November 8 with senior officials of all airlines and travel portals to discuss grievances related to 'refund not given after ticket cancellation' and showing every seat as 'paid' despite free web check-in, among others. Consumer Affairs Secretary Rohit Kumar Singh, in a media briefing, said about 10,000 complaints related to the airline sector has been received through the government's National Consumer Helpline in the last one year.

About half of the complaints are related to "ticket cancelled but no refund received from airlines" Some of the major grievances also include airlines showing every seat as paid despite free mandatory web check-in, he said.

"These complaints are just a tip of the iceberg. We have called a meeting on November 8 to discuss these consumer grievances with all airlines, travel portals and consumer organisations," Singh said.

While booking a ticket either through airline websites or travel portals, he said, the department has noticed that many of the consumers are not happy with the interface and they think they are "misled and cheated".

"Airlines say 'free web check-in' but 'seats are paid'. Once a traveller has paid the fare and the airines has issued a confirmed ticket then all the services have to be fair and to the advantage of the consumers. You cannot take consumer to a ride," he said. The ministry has nothing to do with the business model of airlines or travel companies, but "we are saying that when a consumer has a confirmed ticket then he should not put to further inconvenience in form of these things (paid seat) which are making life difficult for air travellers". ### Artificial Intelligence company from Silicon Valley enters Bihar

WASHINGTON, Oct 26: A Silicon Valleybased Artificial Intelligence company has opened an office in Bihar, making it the first

IT company from the US to enter the state. Tiger Analytics, headquartered in Santa Clara, has opened its first office in Patna this month. "We are hoping that the initial step that we are taking, can lead to a lot of progress down the road," Mahesh Kumar, founder and CEO of Tiger Analytics, told PTI in a recent interview. The company currently has some 4,000 employees in India, but they are mostly in Chennai, Bangalore and Hyderabad.

Kumar, who is himself from Bihar, said during the COVID crisis a large number of its employees went back home to Bihar and started working remotely.

"We have close to a hundred people between Bihar and Jharkhand right now. They're working remotely and they were happy there, they didn't want to come back," he said.

"So, we realised that they're very good talented people, young people, they want to stay close to home but there are no opportunities in Bihar for them to work. Even when we set up this office (in Patna), a lot of social media responses came. People are looking forward to Tiger (Analytics) growing there (in Bihar) so they can go back and work from there," Kumar said. Kumar, who interacts with other successful entrepreneurs from Bihar in Silicon Valley regularly, said their goal is to encourage more like-minded people to come together and use it as an initial seed to grow a bigger ecosystem in Bihar. Tiger Analytics is primarily a consulting company in the field of artificial intelligence and machine learning.

'We hope that taking this lead into account, many more companies will come to Bihar in the same way," Sandeep Poundrik, Additional Chief Secretary, Department of Industries, Bihar told PTI. A delegation of senior Bihar officials travelled to Silicon Valley this summer for meetings with Bihar-origin successful tech

"We are trying to get IT companies to start their operations in Bihar. .... It's not a very easy task, especially because right now there are not many IT companies in Bihar," said Poundrik who is also CEO of the Bihar Foundation, a state government-supported body for its diaspora community. Thousands of engi-

neering students from Bihar currently seek opportunities outside the state due to the limited presence of IT companies within Bihar, he said. Responding to a question. Poundrik acknowledged that it's a little more challenging to attract investment in Bihar in the IT sector.

"Number one.... I would say their percep tion of Bihar is not very positive, especially outside India. Because they have never heard of Patna or Bihar. So if any IT company wants to start their unit, they only think about Chennai, Bangalore or Hyderabad. They never think about Bihar," he said.

"Second, I think the market is not local as far as IT is concerned. We have created the infrastructure. So in addition to whatever infra structure the government has created for startups and IT companies, there's a lot of private infrastructure which has come up in Patna. About 12 IT towers are being developed in Patna in various stages of construction in the Patliputra industrial area," he said.

#### Sensex tumbles 900 points amid broad-based selloff; slips below 64K

MUMBAI, Oct 26: Sliding for the sixth straight session, equity benchmark Sensex on Thursday about 900 points to crash below the 64,000 level due to an across-theboard selloff amid heightened tension in the Middle East.

Besides sluggish trends in global markets, deep losses in auto, financial and energy stocks as well as fresh selling by foreign investors added to the gloom, analysts said.

The 30-share BSE Sensex slumped 900.91 points or 1.41 per cent to settle below the 64,000 mark at 63,148.15. During the day, it plummeted 956.08 points or 1.49 per cent to 63,092.98.

The Nifty dived 264.90 points or 1.39 per cent to 18,857.25. Since October 17, the BSE benchmark has tumbled 3,279.94 points or 4.93 per cent, while the Nifty fell 954.25 points or 4.81 per cent.

Mahindra & Mahindra was the biggest loser in the Sensex pack, falling 4.06 per cent, followed by Bajaj Finserv, Asian Paints, Nestle, Bajaj Finserv, JSW Steel, Titan, HDFC Bank, Tech Mahindra, Tata

Motors and Larsen & Toubro. In contrast, Axis Bank, ITC, HCL Technologies, NTPC and IndusInd Bank were the gainers.

In Asian markets, Seoul, Tokyo and Hong Kong settled lower, while Shanghai ended in the green.

European markets were trading with significant losses. The US markets ended in negative territory on Wednesday. Global oil benchmark Brent crude declined 0.65 per cent to USD 89.54 a barrel.

tor," Pololikashvil said. "The introduction of tourism into high schools reflects the heightened relevance of our sector as a pillar of economic and social development. The support of Ministries of Tourism will be essential for making it happen. At the same time, it is equally crucial we engage with key stakeholders within the high school ecosystem to ensure the success of this transformative initiative," he added.

The toolkit includes modules not only for Ministries of Education but also for parents, school directors, and teachers, who will require robust support and empowerment in this endeavour.

Kunal Vasudeva, co-founder and managing director of the Indian School of Hospitality (ISH), formally launched the toolkit at the event that concluded here on Sat-

Packed curricula, insufficient career learning, complex regulatory environment, lack of government support, insufficient funding, lack of qualified faculty, negative perception about tourism, insufficient commitment, and lack of advocacy, are among the roadblocks listed by experts in the introduction of tourism as a subject in

Among the recommendations made in the toolkit are – focus on advancing in the general education track of national school systems; optimising the visibility and adoption of tourism in international systems; introducing a skills-based education that encourages completion of studies at university; engaging and empowering key stakeholders in high schools; addressing the tourism gap and shaping the beliefs and perceptions around tourism. 
mark on the community's handloom traditions, producing beautiful and artistic de-

s the Mizoram Assembly elections approach, the BJP finds itself embroiled in a challenging political battle, largely due to its perceived failure in controlling the ethnic riots in neighbouring Manipur. The ramifications of these events have shaken the state's political landscape, especially its relationship with the Mizo National Front (MNF), a significant political ally. The BJP's expansion into the Northeast has seen varying degrees of success, with Assam and Tripura being exceptions due to a Christian minority. However, in Mizoram, the party's alliance with the MNF has been more complex. Reservations have always existed among the more orthodox Christian voters in the Northeast regarding the BJP's philosophy and policies. The fear of an aggressive 'Hindutva' mindset within the party, perceived majoritarianism, and favouritism for Hindu ideals and values have deepened concerns. These concerns materialized during violent clashes in Manipur between the indigenous Meitei community and Christian tribals like the Kukis and Zos. The mishandling of the situation further fuelled Christian sentiment. Manipur witnessed significant casualties, with over 180 people killed and property worth at least ₹ 200 crore destroyed. This turmoil spilled over into Mizoram, with over 40,000 refugees from Manipur and Myanmar living in special relief camps

In this challenging scenario, the MNF has chosen not to align itself closely with the BJP, especially after the Manipur events. Chief Minister Zoramthanga has declined to participate in a joint campaign with the BJP and will not share a platform with Prime Minister Narendra Modi during his upcoming visit, citing Mizoram's Christian majority status. Furthermore, disagreements over the financial assistance provided to the state by the central government for the relief camps have strained the centre-state relationship. The MNF expressed its inability to close down the camps abruptly, leading to more civilians seeking refuge in Mizoram from Myanmar's civil war. The Congress party is now poised to exploit the BJP's difficulties and campaign independently, hoping to make gains in the absence of MNF's support. Rahul Gandhi, a prominent opposition campaigner, has already visited Mizoram, criticizing the BJP for not addressing the Manipur crisis promptly. Congress has released a list of 39 candidates, promising ₹ 2000 pensions for senior citizens and special schemes for aspiring entrepreneurs, as well as subsidized LPG cylinders at ₹ 750. This strategy aligns with the growing trend among major parties to offer populist sops for the economically weaker sections during election campaigns.

However, offering freebies may not guarantee long-term success. The ruling Congress in Karnataka, for example, faced challenges in fulfilling its pre-election promises. Resource constraints compelled the state to restrict eligibility for certain benefits, leading to public dissatisfaction and opposition attacks. In the upcoming Mizoram Assembly elections, the BJP will contest 23 seats, while the MNF and the main opposition party, Zoram Peoples Movement (ZPM), will contest all 40. The electorate comprises 856,868 voters, including 438,925 women. With 174 candidates in the fray, including 23 from the BJP and 4 from the Aam Aadmi Party (AAP), the results are eagerly anticipated and set to be announced on December 3. The complex political landscape in Mizoram highlights the challenges faced by the BJP, the ambitions of the Congress, and the evolving strategies of political parties in the region as they navigate the delicate balance between populist promises and effective governance.

# Maldives: Shifting dynamics and challenges in Indo-Maldivian relations

he recent elections in the Maldives marked a significant shift in Indo-Maldivian relations, culminating in the victory of Dr. Mohamed Muizzu. He is known for his pro-China stance and, regrettably, his unfavorable stance towards India. This outcome serves as a poignant reminder of the transformation in the diplomatic landscape since India's decisive Operation Cactus on November 3, 1988.

Three and a half decades ago, India's surgical intervention not only safeguarded democracy in the Maldives but also thwarted the coup attempt led by Abdullah Luthufi. He had enlisted a group of Sri Lankan Tamil mercenaries in an endeavor to overthrow Abdul Gayoom.

In 1988, amid Cold War tensions and internal discord, the operation carried out on the personal initiative of the late Prime Min-Rajiv received significant international praise. Leaders like Ronald Reagan and Margaret Thatcher, from the Western world, particularly lauded India's proactive stance in preventing the subversion of democracy.

However, in Dr. Muizzu's case, current reports in the public domain suggest that this relationship appears to be more complex, with indications of a leaning towards anti-India sentiments, at least for the time being.

strated a heightened to project power in the Inawareness of India's apprehensions regarding the expanding influence of China in the Indian Ocean.

In retaliation, the Opposition coalition, comprising the People's National Congress (the party affiliated with Dr. Muizzu) and the Progressive Party of Maldives, initiated a campaign known as "India Out." This policy sought to eliminate the Indian military presence in the Maldives, which, in actuality, comprises only 75 Indian military personnel stationed in the country to support the operation of Dornier aircraft and two helicopters gifted by the Indian government.

The intrinsic majoritarianism embedded in the current ruling establishment in Delhi contributed to the growing anti-Indian sentiment in the Maldives.

Maldives, being highly conservative society with Islam as its state religion, experienced instances of pro-Hindu and anti-Muslim rhetoric emanating from India. The Maldivian Opposition coalition, currently in office, strategically employed these occurrences to polarize society and cultivate its voter base on

an anti-Indian platform. Maldives holds strategic importance for India as it oversees critical Sea Lanes of Commerce (SLOCs) connecting Asia with Europe. Therefore, it acts as a crucial buffer to preempt the spread of Chinese influence from the South China Sea to the Northern Indian Ocean and beyond. With Chinese control over the Gwadar and Hambantota ports, a pro-China Maldives could potentially enhance their access, if not their ability, paknewslive@gmail.com)

dian Ocean. These developments have clear implications for India's sphere of influence, akin to its Monroe Doctrine.

Regrettably, Mohamed Muizzu is making things challenging, not only for India but also, by implication, for himself, with his persistent anti-India rhetoric. From the very start of his tenure, he reiterated his campaign promises of removing Indian troops and further declared his intention to pardon the former President Abdulla Yameen, known for his anti-India stance. Consequently, Yameen was released from prison and placed under house arrest.

Furthermore, Muizzu's unwavering commitment to Salafism, a radical school of Islam, contrasts with the relatively liberal Deobandi Islam and the permissive Sufi Islam that define the Muslim ethos of the subcontinent.

The rising resonance of radicalism and extremist ideologies among the youth in Maldives is a growing concern. Some reports indicate that Maldives contributes the highest number of cadre per capita to the ranks of Al-Qaeda and ISIS. As a result. India-Maldives relations are expected to face challenging times, with an anticipated increased Chinese presence in its strategic backyard and a greater proliferation of radicalism in its neighborhood. # Worst humanitarian disaster is happening India's Olympic dream: A testament in Gaza strip as Israel gets free hand



fter eighteen days of the surprise attack by Hamas on Isthe return onslaught against Gaza strip continues. The Hamas attack resulted in the killing of 1400 Israelis and abducting of more than 200 others, leading the Israeli govt. to declare war on the Palestinians in Gaza and even in West Bank to end all the terror attacks on Israel. Actually those have been going for decades. Benjamin Netanyahu vows to wipe out Hamas from the face of the earth, but it is the same man who told his Likud colleagues in March 2019 - "Anyone who wants to thwart the establishment of Palestinian state has to support bolstering Hamas and transferring money to Hamas. This is a part of our strategy - to isolate the Palestinians in Gaza from the Palestinians in the West Bank.' Israeli leaders have promised to

eliminate Hamas - but possibly cannot end Hamas existence; even if it succeed to eliminate Hamas infrastructure in Gaza, in the process killing thousands of civilians, including children and uprooting a whole population from their land. -'Hamas is not simply a militant organization limited in Gaza Strip - it is more an ideology. Israel, how strong it may be with the backing of USA and other western powers, cannot achieve its goal in a short period. Israel is going to start a ground assault shortly, which will incur significant Israeli casualties and Palestinian collateral deaths of many more as well - which would result in pressure in both internally and from outside world, where concern about civilian deaths, including many children are already leading inflamed tensions regionally and internationally.

Though US president Joe Biden had gone to Israel day after the Hamas attack, breaking any precedent before and unilaterally supported Israel strongly, ignoring caution from many of Democratic congressmen, he recently toned down his unconditional supporting voice due to internal and external pressures. Biden has granted \$ 10 billion to Israel's aid and sent them the most modern war planes and

There is a possibility that the war might escalate to other regions. The US had deployed two naval strike groups to eastern Mediterranean, led by USS Eisenhower and USS Gerald Ford aircraft carriers. It has also deployed several squadrons of F 15, F 16 and A 10 warplanes to its bases in the Middle East. This show of force is expressly an attempt to deter other players, especially Iran and Hezbollah from getting involved in the conflict. But now there's a report that China has sent six war ships to the Middle East.

As Israel is pounding Gaza ceaselessly with its war planes, the humanitarian crisis is surging; all the International laws are being violated, war crimes are being committed - concern about it are also rising. In America, Senator Bernie Sanders and former president Barack Obama both strongly expressed annoyance in Biden's unilateral support of Israel and Israel's brutal attack on Palestinian civilians in the name of crushing Hamas. Both expressed concern for the humanitarian crises and asked for immediate ceasefire, saying history will not forgive us for this. Student bodies in college and universities are divided in their support, but as the war escalates, many are expressing their concerns about

the humanitarian crisis that aroused from the conflict and vied for immediate ceasefire.

Till October 23, more than 5790 Palestinians were killed, 40% of that are children. There is a serious shortage of essentials in Gaza Stripfood, fuel, drinking water, shelter, medicines and other commodities. Hospitals are being bombed. About more than 190,000 Palestinians have fled north Gaza after the Israeli warning. Many of them took shelter in UNRWA schools run by UNICEF and many of them are children. Even some of these schools are bombed, 'The Save the Children Charity' reported that one child in Gaza was being killed every 15 minutes. On Saturday, 'the Euro-Med Human Rights Monitor' was estimating a daily death roll of 200 children are infants. At least 4000 have been injured. "Gaza's children are suffering record psychological trauma and terror" Euro-Med says. Many are homeless and short of food and safe drinking water, or have been forced to flee south under fire, compounding their trauma. 'Human Rights Watch' said - 'Israeli bombardments and blockade of Gaza mean that countless wounded and sick children ,among many other civilians, will die for want of medical care'.

Though Biden now has taken initiative to send convoy of relief through Egypt, it is very much inadequate, about 7% of the total minimum requirements to reach Gaza so far to avoid a total humanitarian distals in northern Gaza due to lack of security. It called for "an immediate humanitarian ceasefire so that health supplies and fuel can be delivered safely throughout the Gaza Strip". The number of aid trucks being allowed in Gaza is "wholely inadequate", - says United Kingdom's Tory minister Andrew Midul.

"The US speaks a good deal about principles; political analysts point out that president Biden has embedded a hierarchy of human life in official American policy. He expressed outrage at the massacre of the Jews by Hamas, as he should have; but he struggles to be equally clear valuing Gazan lives, especially of children.

Not for the first time, the international community stands accused of complicity in a war crime, of a collective crime against humanity; it is watching it at Gaza, mostly and it is failing miserably to stop it. Killing and targeting civilians, especially children is illegal under 1949 Geneva International convention.

In a joint statement on Sunday, the US, UK, France, Germany, Italy and Canada while supporting Israel's right to defend, called for "adherence International humanitarian laws, including the protection of the civilians". But they know full well that in Gaza, the exact opposite is happening. Big powers like China and Russia who could have really done something effective to stop the savage bloodbath in Gaza are not active at all. Chinese President has even commented that Israel has the right for self defence. Chinese foreign minister is visiting Washington on Oc-26 discussions. Palestinians are left alone to fend for themselves.

The continuing Israeli-Hamas war has once again shown the duplicity and the revanchist attitude of the NATO nations as also the cavalier stance of China and Russia. It seems that the Gaza strip Palestinians are fated to face the worst humanitarian disaster in recent history as Israeli Prime Minister Benjamin Netanyahu has got free hand in implementing his resolve to free Gaza from the Palestinians taking advantage of the October 7 Hamas attack. # Caracals on the brink of extinction, could become second cat species to be wiped out from India

7 ith an estimated 50 individuals across the country, concentrated in the western parts of India, the caracal (Caracal caracal schmitzi), a small wild cat noted for its long-tufted ears and a reddish-tan or sandy-brown coat, is critically endangered and perhaps on the brink of extinction in India. Wildlife experts and scientists fear that after the Asiatic cheetah, that was declared extinct in 1952, the caracal will be the second cat species to be wiped out from the country.

As per estimates in a 2015 study, some 28 caracal individuals are found in the Ranthambhore Tiger Reserve in Rajasthan and scientists estimate around 20 in Kutch in Gujarat. These are reported to be the only two populations of the cat that remain in India

According to the International Union for Conservation of Nature, or IUCN, Cat Specialist Group the feline, with distinctive black markings on its face and white circles around the eyes and mouth, is native to Africa, the Middle East, Central Asia and arid areas of Pakistan and northwestern India.

While the species is listed under "least concern" under the IUCN Red List globally, it has been listed as "near threatened" by the Conservation Assessment and Management Plan and IUCN Red List assessment in India. The species is included in the Schedule-I category of the Indian Wildlife (Protection) Act, 1972, offering it the highest possible protection.

"Historically, the caracal was found all across Central India and the Indo-Gangetic plains. But there has been no sighting of the animal in these regions for the last 40 years," says YV Jhala, former dean of the Wildlife Institute of India. "We

trap (caracal) in Kuno National Park since 2006 but it all was in

In 2022, the Wildlife Institute of India along with the Indian Space Research Organisation, Madhya Pradesh Forest Department and Leo Foundation of The Netherlands conducted a study in nine states - Chhattisgarh, Delhi, Gujarat, Jharkhand, Haryana, Madhya Pradesh, Maharashtra, Rajasthan and Uttar Pradesh – on the presence of

The study indicated that areas in Kutch (Gujarat), Aravalli mountains (Rajasthan), Malwa plateau (Rajasthan and Madhya Pradesh) and Bundelkhand region (Madhya Pradesh) were potentially suitable habitats for caracals.

It further identified the Ranthambore-Kuno Landscape, which falls in Rajasthan and Madhya Pradesh, as a highly potential caracal habitat area and a suitable site for the conservation of the feline. The Madhya Pradesh Biodiversity Board is also undertaking a study on caracals in this landscape.

Uncertainty about population decline

Though the caracals have not been spotted from the Central India range for over four decades, scientists and wildlife experts are yet to determine a reason for the decline in the population. Jhala says that while habitat loss is a common factor for all wildlife, other species of cats are doing relatively well, but the same cannot be said for

"Protected areas like Gandhisagar National Park and Nauradehi Wildlife Sanctuary all had caracals and the prey base here is high. So, there is no question of threat to habitat or lack of prev but it is still not understood as to why the population is falling so heavily even in



these protected areas," Jhala

Subharanjan Sen, Assistant Principal Chief Conservator of Forests (Wildlife), Madhya Pradesh, echoing Jhala says, "No one knows why the cats are not being spotted anymore. It might be due to a disease but we aren't sure.'

Jhala has the same speculations. However, he adds that while a general disease would have affected other species of lesser cats too, if there is a disease that is leading to the vanishing of the caracals, it has to be species-specific. "These are speculations but we need to look into it to determine the root cause before we can start thinking about conservation strategies," he says.

Initially, large-scale hunting and illegal trade were the two main causes for the decline but Sen says that poaching and seizure of the cat have not been reported for many decades. He added that while the cat had not been spotted for a long time in Madhya Pradesh, they might have been looking at the wrong places all this while.

"The forest department is mostly focused on dense forests but the caracal is found in open forests and scrublands. It is a species of wasteland, which generally falls under the revenue department's jurisdiction, so we

**Challenges in conservation** In 2021, the National Board for Wildlife and the Ministry of Environment, Forest and Climate Change announced a Species Recovery Plan for the conservation and population revival of 22 species in India, including the caracal.

As per the project plan, Ranthambhore is working on the conservation of the species with a focus on strengthening government management of wild cats and habitats by enhancing private sector partnerships, regional collaboration and knowledge transfer and learning supported by gender mainstreaming and monitoring and

The plan talks about developing conservation master plans, monitoring protocols for wild cats, Standard Operating Proceand strengthening wildlife-related law enforce-

be the potential habitat for the species.

"We will set up camera traps in parts of Rajasthan and Kuno National Park to study the population and will then devise strategies for conservation. First and foremost, it is important to know the number of individuals present in the area," says Singh.

Former Principal Chief Conservator of Forests of Madhya Pradesh, JS Chouhan also feels that the survey of potential habitats is necessary before designing conservation strategies. "If the researchers find that there is even a small population in the landscape that they are planning to undertake the study in, I am sure the MP Forest Department will be more than willing to dedicate more than one sanctuary in the region to protect the species. But since it has not been spotted in MP for many decades, on some level, I feel that it is more like a distant dream," Chouhan

The Rajasthan Forest Department is also planning to start a breeding programme for caracals but with a lot of challenges and technicalities involved, the project is in its initial phase. However, the conservation process will only begin once the major threats leading to the decline are identified.

However, Jhala feels that while a breeding programme might help stabilise the population, it will cause a decline in wild species.

"Once the threats are identified then we can design strategies to address them. But even in a breeding centre, we need to have a good founder population before we begin with the programme. If there are less than 50 individuals remaining, it is hard to start breeding them," adds Jhala, highlighting some major roadblocks in establishing a caracal breeding centre. (Cour-

Some major steps are the need of the hour for India. Firstly, immediate curbs on ammonia release in farms are essential: this must be followed by a full ban on refuse burning. Apart from this rural brick kilns must be persuaded to shift to cleaner kiln-firing technologies. Urgent efforts also need to be made to convert coal-based power plants to clean energy, as this by itself will make a huge difference. To make this a reality, India must make a push for creating the correct financial architecture through investment funds with a dedicated green focus that can play an instrumental role in catalysing the growth of green industries and simultaneously addressing the twin problems of air pollution and climate change. These funds would combine a returnsdriven strategy with the sustainability imperative and accelerate investment in green industries. Measures such as these can help India fight air pollution and prevent a calamitous future where common antibiotic efficacy is not held to ransom by polluted air. (Cour-

# Four factors driving 2023's extreme heat and climate disasters

etween the record-breaking global heat and extreme downpours, it's hard to ignore that something unusual is going on with the weather in 2023.

People have been quick to blame limate change – and they're right: human-caused global warming plays the biggest role. The weekslong heat wave that started in June 2023 in Texas, the US Southwest and Mexico would have been virtually impossible ithout it, one study found.

However, the extremes this year are sharper than anthropogenic global warming alone would be expected to cause. September temperatures were far above any previous September, and around 3.1 degrees Fahrenheit (1.75° C) above the preindustrial average, according to the European Union's earth observation pro-

July was Earth's hottest month on record, also by a large margin, with average global temperatures more than half a degree Fahrenheit (a third of a degree Celsius) above the previous record, set just a few years earlier

Human activities have been increasing temperatures at an average of about 0.2 F (0.1° C) per decade. But this year, three additional natural factors are also helping drive up global temperatures and fuel disasters: El Niño, solar fluctuations and a massive underwater volcanic erup-

Unfortunately, these factors are ombining in a way that is exacerbating global warming. Still worse, we can expect unusually high temperatures to continue, which means even more extreme weather in the near fu-

How El Niño is involved

El Niño is a climate phenomenon that occurs every few years when surface water in the tropical Pacific reverses direction and heats up. That warms the atmosphere above, which influences temperatures and weather patterns around the globe.

Essentially, the atmosphere borows heat out of the Pacific, and lobal temperatures increase slightly. This happened in 2016, the time of the last strong El Niño. Global temperatures increased by about 0.25 F (0.14 C) on average, making 2016 the varmest year on record. A weak El Niño also occurred in 2019-2020, contributing to 2020 becoming the world's second-warmest year.

El Niño's opposite, La Niña, involves cooler-than-usual Pacific currents flowing westward, absorbing heat out of the atmosphere, which cools the globe. The world just came out of three straight years of La Niña, meaning we're experiencing an even greater temperature swing.

Based on increasing Pacific sea surface temperatures in mid-2023, climate modelling now suggests a 90% chance that Earth is headed toward its first strong El Niño since

Combined with the steady humaninduced warming, Earth may soon again be breaking its annual temperature records. June 2023 was the hottest in modern record. July saw global records for the hottest days and large number of regional records, including an incomprehensible heat index of 152 F (67 C) in Iran.

The Sun may seem to shine at a onstant rate, but it is a seething, churning ball of plasma whose radiating energy changes over many differ-

The Sun is slowly heating up and n half a billion years will boil away Earth's oceans. On human time scales, however, the Sun's energy output varies only slightly, about 1 part in 1,000, over a repeating 11-year cycle. The peaks of this cycle are too small for us to notice at a daily level, but they affect Earth's climate sys-

Earth's temperature increase during a solar maximum, compared with average solar output, is only about 0.09 F (0.05 C), roughly a third of a large El Niño. The opposite happens during a solar minimum. However, unlike the variable and unpredictable El Niño changes, the 11-year solar cycle is comparatively regular, consistent and predictable.

The last solar cycle hit its minimum in 2020, reducing the effect of the modest 2020 El Niño. The current solar cycle has already surpassed the peak of the relatively weak previous cycle (which was in 2014) and will peak in 2025, with the Sun's energy output increasing until then.

A massive volcanic eruption

Volcanic eruptions can also significantly affect global climates. They usually do this by lowering global temperatures when erupted sulfate aerosols shield and block a portion of incoming sunlight – but not always.

In an unusual twist, the largest volcanic eruption of the 21st century so far, the 2022 eruption of Tonga's Hunga Tonga-Hunga Ha'apai, is having a warming and not cooling effect.

The eruption released an unusually small amount of cooling sulfate aerosols but an enormous amount of water vapour. The molten magma exploded underwater, vaporizing a huge volume of ocean water that erupted like a geyser high into the atmos-

Water vapour is a powerful greenhouse gas, and the eruption may end up warming Earth's surface by about 0.06 F (0.035 C), according to one es-

Unlike the cooling sulfate aerosols, which are actually tiny droplets of sulfuric acid that fall out of the atmosphere within one to two years, water vapour is a gas that can stay in the atmosphere for many years. The warming impact of the Tonga volcano is expected to last for at least five years. Underlying it all: Global warm-

All of this comes on top of anthropogenic, or human-caused, global warming.

Humans have raised global average temperatures by about 2 F (1.1° C) since 1900 by releasing large volumes of greenhouse gases, particularly carbon dioxide, into the atmosphere. The amount of carbon dioxide in the atmosphere is up 50%, primarily from the combustion of fossil fuels in vehicles and power plants. The warming from greenhouse gases is actually greater than 2 F (1.1° C), but it has been masked by other human factors that have a cooling effect, such as air pollution.

If human impacts were the only factors, each successive year would set a new record as the hottest year ever, but that doesn't happen. The year 2016 was the warmest in part because temperatures were boosted by the last large El Niño.

What does this mean for the fu-

The next couple of years could be very rough.

If a strong El Niño develops over the coming months as forecasters expect, combined with the solar maximum and the effects of the Hunga Tonga-Hunga Ha'apai eruption, Earth's temperatures will likely continue to soar.

As temperatures continue to increase, weather events get more extreme. The excess heat can mean more heat waves, forest fires, flash floods and other extreme events, climate models show.

In January 2023, scientists wrote that Earth's temperature had a greater than 50% chance of reaching 2.7 F (1.5° C) above preindustrial era temperatures by the year 2028, at least temporarily, increasing the risk of triggering climate tipping points with even greater human impacts. Because of the unfortunate timing of several parts of the climate system, it seems the odds are not in our favour. (Cour-

Newer and more perilous problems are arising due to unabated pollution levels. A recent study published in the health journal "Lancet" has established a connection between bacterial antibiotic resistance and air pollution, particularly PM 2.5. The study suggests that PM 2.5 contains elements of antibiotic resistance, and inhaling this pollutant can lead to an increase in the spread of antibiotic resistance. The authors of the study aimed to estimate the global premature death toll caused by resistance to antibiotics due to PM 2.5 pollution.

PM 2.5 refers to particulate matter with a diameter of 2.5 micrometres or smaller. These particles, consisting of solid and liquid elements, are of varying sizes, with some, like dust and soot, visible to the naked eye and others, such as PM 2.5, only observable under electron microscopes. Inhaling these pollutants can pose serious health risks, especially to the respiratory system. # Pakistan court restores appeals of Nawaz Sharif against his conviction in two graft cases



ISLAMABAD, Oct 26: A top court here on Thursday restored appeals of Pakistan Muslim League-Nawaz supremo Nawaz Sharif against his conviction in two high-profile corruption cases, in a major relief to the former prime minister who wants to clear his name to contest the general elections expected in January.

Sharif, accompanied by his younger brother and PML-N president Shehbaz Sharif, appeared before the Islamabad High Court (IHC) for the second time since his return to Pakistan from London on October 21 after a self-exile of about four years.

A two-member division bench comprising IHC Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb announced the verdict, which was reserved earlier

The bench issued the verdict while hearing the 73-year-old pleas seeking protective bail in the Al-Aziza steel mill and Avenfield corruption cases and for restoring his appeals against his conviction.

"Congratulations to all of Pakistan on the restoration of justice. his party said in a post on X, celebrating the restoration of appeals. A large number of his supporters gathered outside the court building and raised slogans in his favour.

Sharif was earlier granted a protective bail until October 24 when he appeared before the court to surrender and also filed pleas for revival of his appeals in both cases.

The court after the initial hearing had issued notice to the National Accountability Bureau (NAB) and adjourned the hearing until today.

During the hearing, the NAB prosecutor informed the court that the anti-corruption watchdog was not interested in the arrest of Sharif, while his counsel pressed

also refused to oppose the plea by Sharif's lawyers.

The court after the conclusion of the arguments reserved judgment which it announced later

On Tuesday, the caretaker government of Pakistan's Punjab province had suspended Sharif's seven-year sentence in the Al-Azizia corruption case.

Sharif was convicted in the Al-Azizia Steel Mills corruption case and sentenced to seven years in jail in December 2018. Delivering the verdict, the judge had said at the time that there was concrete evidence against him in the Al-Azizia case and that he was unable to give the trail of the money used to set up the Al-Azizia steel mills in Saudi Arabia by his family in 2001 and later on the Hill Metal Establishment also in the Gulf King-

He was also convicted in July 2018 by an accountability court in the Avenfield properties case and was arrested and put in jail but set free after being given bail while his appeals against acquittal in the case were pending.

His daughter Maryam Nawaz was also sentenced to seven years in jail in the Avenfield case but was acquitted in September 2022 along with her husband Muhammad Saf-

He has always denied allegations of any wrongdoing and termed his conviction orchestrated by the powerful establishment in collusion with the judiciary.

The IHC declared him a proclaimed offender in both cases in December 2020.

Sharif, who was disqualified in 2017 and later in 2018 convicted in both cases of corruption, wants to clear his name to lead his party in the general elections, which are expected in January 2024. However, no specific date has been announced by the Election Commission of Pakistan (ECP).

The Pakistan People's Party has alleged that the ECP would give the poll date once Sharif gets a clean chit from the courts in all the cases he is facing. Both the PPP and jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf party have called Sharif the 'new ladla' (favourite) of the military establishment.

Khans' party said Sharif returned to the country after four years of exile because of the blessing of the military establishment which has given him assurance to make him the next prime minister.

Sharif is the only Pakistani politician who became the prime minister of the coup-prone country for a record three times. (PTI)

#### Canada welcomes India's decision to resume some visa services

TORONTO, Oct 26: Canada has welcomed India's decision to resume some visa services in the country from Thursday, saying the move was a "good sign" after "an anxious time" for many Canadians, amid a diplomatic row over the killing of a Sikh separatist.

India's high commission Canada said on Wednesday that the country's officials will resume processing some types of visa applications for Canadians applying from across the country as well as abroad.

The decision came a month after New Delhi suspended the services in Canada and for Canadian citizens worldwide as tensions flared between the two nations last month following Prime Minister Justin Trudeau's allegations of the "potential" involvement of Indian agents in the killing of Khalistani extremist Hardeep Singh Nijjar on June 18 in British Columbia.

India had designated Nijjar as a terrorist in 2020. India has rejected Trudeau's allegations as "absurd" and "motivated".

On Wednesday afternoon, Immigration Minister Marc Miller called India's move "a good sign" after "an anxious time" for his many Canadi-

"Our feeling is that a suspension should never have happened in the first place," he was quoted as saying by CTV News.

He said the "really concerning diplomatic situation with India has created a lot of fear in a lot of communities.'

Emergency Preparedness Minister Harjit Sajjan, who is also a Sikh, said the resumption of visa processing is good news, but wouldn't speculate on what message New Delhi is trying to send.

"It's good to see that they have resumed that. It would have been nice (if) they didn't take it in the first place," Sajjan told reporters. (PTI)

### At least 16 dead in Maine mass killing and police hunt for the shooter as residents take shelter

LEWISTON (US), Oct 26: A man shot and killed at least 16 people at a restaurant and a bowling alley in Lewiston, Maine, on Wednesday and then fled into the night, sparking a massive search by hundreds of officers while frightened residents stayed locked in their homes.

A police bulletin identified Robert Card, 40, as a person of interest in the attack that sent panicked bowlers scrambling behind pins when shots rang out around 7 pm. Card was described as a firearms instructor believed to be in the Army Reserve and assigned to a training facility in Saco, The document, circulated to law

enforcement officials, said Card had been committed to a mental health facility for two weeks in the summer of 2023. It did not provide details about his treatment or condition but said Card had reported "hearing voices and threats to shoot up" the military base. A telephone number listed for Card in public records was not in service.

Lewiston Police said in an earlier Facebook post that they were dealing with an active shooter incident at Schemengees Bar and Grille and at Sparetime Recreation, a bowling alley about 4 miles (6.4 kilometers)

One bowler, who identified himself only as Brandon, said he heard about 10 shots, thinking the first was a balloon popping.

"I had my back turned to the door. And as soon as I turned and saw it was not a balloon - he was holding a weapon - I just booked it," he told The Associated Press.

Brandon said he scrambled down the length of the alley, sliding into the pin area and climbing up to hide in

the machinery. He was among a busload of survivors who were driven to a middle school in the neighboring city of Auburn to be reunited with family and friends.

"I was putting on my bowling shoes when when it started. I've been barefoot for five hours," he said.

Melinda Small, the owner of Legends Sports Bar and Grill, said her staff immediately locked their doors and moved all 25 customers and employees away from the doors after a customer reported hearing about the shooting at the bowling alley less than a quarter-mile away. Soon, the police flooded the roadway and a police officer eventually escorted everyone out of the building.

"I am honestly in a state of shock. I am blessed that my team responded quickly and everyone is safe," Small said. "But the same time, my heart is broken for this area and for what everyone is dealing with. I just feel

After the shooting, police, many armed with rifles, took up positions while the city descended into eerie quiet - punctuated by occasional sirens - as people hunkered down at

The Androscoggin County Sheriff's Office released two photos of the suspect on its Facebook page that showed the shooter walking into an establishment with a weapon raised to his shoulder.

Two law enforcement officials told The AP that at least 16 people were killed and the toll was expected to rise. However, Michael Sauschuck, commissioner of the Maine Department of Public Safety, declined to provide a specific estimate at a news conference, calling it a "fluid situa-

# Biden condemns retaliatory attacks by Israeli settlers against Palestinians in the West Bank

WASHINGTON, Oct 26: President Joe Biden on Wednesday spoke out against retaliatory attacks by Israeli settlers against Palestinians in the West Bank in the aftermath of the October 7 Hamas attacks on Israel. He also said he was redoubling his commitment to working on a two-state solution to end the decades-long

Israel-Palestinian conflict. Biden said the attacks by "extremist settlers" amounted to "pouring gasoline" on the already burning fires in the Middle East since the Hamas attack.

"It has to stop. They have to be held accountable. It has to stop now." Biden said at the start of a news conference with Australian Prime Minister Anthony Albanese, who was being honored with a state visit to Washington.

Settler violence against Palestinians has intensified since the Hamas attack, and Palestinians have been killed by settlers, according to Palestinian authorities. Rights groups say settlers have torched cars and attacked several small Bedouin communities, forcing them to evacuate to other areas. The West Bank Protection Consortium, a coalition of nongovernmental organizations and donor countries, including the European Union, says hundreds of Palestinians have been forcibly displaced in the West Bank due to settler violence since October 7. That's in addition to over 1,100 displaced since 2022.

Deadly violence has been surging in the West Bank as the Israeli military pursues Palestinian militants in the aftermath of the Hamas attack from Gaza.



The violence threatens to open another front in the two-week-old war, and puts pressure on the internationally recognized Palestinian Authority, which administers parts of the West Bank and is deeply unpopular among Palestinians, in large part because it cooperates with Israel on security matters.

Biden again condemned the brutality of the Hamas attack that killed 1.400 Israelis and said he was convinced that Hamas was driven in part by a desire to undo U.S.-led efforts to normalize Israeli relations with some of its Arab neighbors, including Saudi Arabia.

The president also said that after the Israel-Hamas conflict comes to an end, Israelis, Palestinians and their partners must work toward a two-state solution.

"Israelis and Palestinians equally deserve to live side by side in safety, dignity and peace," Biden said, adding, "When this crisis is over, there has to be a vision of what comes next. And in our view, it has to be a two-state solution."Biden emphasized that point during a Wednesday afternoon call with Prime Minister Benjamin Netanyahu, telling the

Israeli leader it will be important to focus "on what comes after this crisis" including "a pathway for a permanent peace between Israelis and Palestinians," according to a White House statement.

The leaders also discussed ongoing efforts to locate and free the more than 200 hostages that Hamas and other militant groups captured, the flow of humanitarian aid into Gaza, and ensuring safe passage for foreign nationals looking to leave the strip.

The Hamas-run Health Ministry says more than 6,500 Palestinians in Gaza have been killed in retaliatory strikes. Biden said he had doubts about the accuracy of the Hamas death count, but stressed that it was critical for Israel to move carefully in its response to minimize civilian deaths.

"I'm sure innocents have been killed, and it's the price of waging a war," Biden said. "Israel should be incredibly careful to be sure that they're focusing on going after the folks that are propagating this war." Biden said.

Biden also said he has not directly sought assurances from Netanyahu that Israel will hold off on an expected ground invasion into Gaza before hostages can be released.

"What I have indicated to him is that if that's possible, to get these folks out safely, that's what he should do. It's their decision," Biden said at news conference at the White House. "But I did not demand it. I pointed out to him, if it's real, it should be done." About 10 Americans remain unaccounted for amid the Israel-Hamas war, according to the White House. (AP)

#### Russia, China veto US-led draft resolution in UNSC on Gaza, rival text by Moscow also fails



**UNITED NATIONS, Oct 26:** Russia and China vetoed a USled draft resolution in the UN Security Council that would have called for humanitarian pauses in fighting to allow aid access to Gaza while a rival text by Moscow on the Israel-Hamas conflict failed to garner enough votes in its favour.

The 15-nation UN Security Council voted on two rival draft resolutions tabled by Washington and Moscow on the ongoing Israel-Hamas conflict. The first resolution by the US affirmed the right of member states to defend themselves against threats to peace and security posed by acts of terrorism. It called for all measures - specifically humanitarian pauses - to allow for full, rapid, safe, and unhindered access into Gaza, territory ruled by Hamas militants. The Council's permanent members Russia and China vetoed the US

led resolution. The UAE also voted against the draft, which received ten votes in favour (Albania, France, Ecuador, Gabon, Ghana, Japan, Malta, Switzerland, UK, US) and two abstentions by Brazil and Mozambique.

Before the vote on the resolution, US Ambassador to the UN Linda Thomas-Greenfield said Washington has worked to forge consensus around a resolution that is strong and balanced.

"We solicited input. We listened. We engaged with all Council members to incorporate edits, including language on humanitarian pauses and the protection of civilians fleeing conflict, and language on the importance of deconfliction mechanisms to protect UN facilities and personnel."

After the vote, she expressed disappointment that Russia and China vetoed the resolution and called on the Council members not to encourage Moscow's "cynical and irresponsible behaviour" by voting for its text, which she said was offered up at the very last minute with zero consultations and which contains a number of problematic sections.

The Council then voted on Moscow's resolution that called for a humanitarian ceasefire, unhindered aid into Gaza and the immediate cancellation by Israeli forces of the evacuation order for civilians to head into southern Gaza. The resolution failed to get adopted as it did not get sufficient votes in its favour. Only four countries - China, Gabon, Russia, and the UAE - voted in favour of the resolution while the UK and US vetoed it and nine nations - Albania, Brazil, Ecuador, France, Ghana, Japan, Malta, Mozambique, Switzerland abstained. This was the fourth time in over a week that the powerful UN Security Council, responsible for the maintenance of international peace and security, failed to adopt a resolution and take unified action in the ongoing conflict that broke out after Hamas attacked Israel on October 7. (AP)

DIMAPUR, Oct 26: With the beginning of the arrival of Amur Falcons in Nagaland, the state forest department on Thursday appealed to all the concerned and responsible citizens to protect and preserve the migratory birds by refraining from hunting them and ensuring their safe stay and passage through the

It pointed out that the Amur Falcon is granted legal protection under the Wildlife (Protection) Act 1972. According to this Act, the Amur Falcon (Falco Amurensis) is classified as a protected species, the department said. It reminded that hunting these birds or possessing their meat is a serious criminal offense punishable by imprisonment for up to three years under the provisions of the Act.

The migratory Amur Falcon, also known as Molulem in the local dialect, has begun its arrival in Naga-

land this month. These majestic birds embark on an incredible longdistance journey, traversing up to 22,000 kilometers in a single year, all the way from eastern Asia to South Africa and back during early autumn. Nagaland serves as a crucial stopover for these remarkable creatures, where they congregate in enormous flocks, sometimes numbering up to one lakh, to rest and refuel for a duration of three to four weeks. Their presence holds immense ecological importance, as they naturally regulate pest populations and participate in vital polli-

nation activities. The department said the dedicated efforts of both the state government and the public have significantly contributed to providing a secure passage for these avian travelers over the years. As a result, Nagaland has proudly earned the well-deserved title of the "Amur Falcon Capital of the World".

IMPHAL, Oct 26: Manipur Education Minister Thounaojam Basantakumar Singh on Thursday said out of 15,915 students staying in 347 relief camps, 15,641 have been "linked/re-admitted" to nearby schools.

Thounaojam told reporters that when violence erupted in the state on May 3, schools were shut for summer vacation, which was later extended owing to the deteriorating law and order situation. "Classes from 1 to 8 reopened from July 5 while higher classes resumed from August 10," he said.

The minister said as on October 23, attendance in schools was 77 per cent.

"In all, 26 schools — 18 in Churachandpur and three each in Imphal East and Jiribam districts — are yet to be reopened as they were being used as relief camps or for accommodating personnel of Central Armed Police Forces."

On steps being taken for welfare of displaced students, Thounaojam said, "The students have been admitted in nearby schools free of cost. Nodal officers have been appointed from the school education department to ensure free admissions and provide textbooks, notebooks, sta-

tionery items and uniforms.' Identity cards have been issued to displaced students and both the Board of Secondary Education of Manipur and Council of Higher Secondary Education Manipur are coordinating in retrieving documents and certificates that were

The agency had searched the group and its promoters for three days in August at locations in

Delhi. Rattan Kant Sharma's alleged under the scanner of the ED and the agency is expected to question and record his statement under the Foreign Exchange Management Act (FEMA). He has been a business partner of Vaibhav Gehlot in a car rental

company in the past. Unaccounted cash of ₹ 1.2 crore was seized by the ED after these searches. Soon after the action against its leaders in Rajasthan, Congress president Mallikarjun Kharge alleged that agencies such as the ED, Central Bureau of Investigation (CBI) and the Income Tax Department become the real 'panna pramukh (party workers)' of the BJP as soon as elections come.

#### Kerala govt opposes NCERT's proposal to rename 'India' as 'Bharat' in school textbooks

KOLLAM (KER), Oct 26: The Left government in Kerala on Thursday strongly opposed the NCERT panel's suggestion to replace "India" with "Bharat" in school textbooks.

The CPI(M)-led dispensation alleged that this was a form of "parochial politics" with a hidden agenda, something the southern state could not accept under any circumstances.

A high-level committee for social sciences, appointed by the National Council of Educational Research and Training (NCERT) to revise the school curriculum, has recommended the replacement of "India" with "Bharat" in textbooks for all classes nationwide. Addressing a press conference, state education minister V Sivankutty stated that the state would reject the panel's recommendation to change the country's name.

He asserted that there was a deliberate effort to "saffronise" the entire curriculum, denying the new generation the opportunity to learn the authentic history of the country. Sivankutty alleged that this national-level curriculum revision was incompatible with democratic values.

"Every citizen has the right to use India or Bharat as mentioned in the Constitution," he

#### Asking to use only "Bharat" in the textbook was with a "hidden agenda and parochial politics," and Kerala cannot accept it, he said while explaining the government's stand. In a federal country, the opinion of states should also have been sought before taking significant decisions, but it is not hap-

pening in India now, the minister alleged. He recalled that Kerala had responded "academically" when a similar attempt to "distort history" took place at the national level during a previous curriculum revision.

Citing figures, he said out of the 33 crore children of school-going age, only 25 crore actually attend educational institutions. The remaining are not in school for various reasons.

As a progressive society, Kerala bears the responsibility to expose attempts to evade such critical issues, Sivanakutty said.

The minister further said that since education is a subject on the concurrent list of the Constitution, the state has the right to take its own decision in that area. If the NCERT intends to give children, through its textbooks, content that is 'unconstitutional, unscientific, and a distortion of real history, Kerala would defend it by raising academic de-

## ED raids residences of TMC minister Jyotipriyo Mallick, others over 'ration scam'

KOLKATA, Oct 26: Enforcement Directorate (ED) officials began an early Thursday morning search at the residences of West Bengal minister Jyotipriyo Mallick in connection with an ongoing probe into the alleged multi-crore ration distribu-

The ED sleuths raided two flats belonging to Mallick, the state's forest minister, at Kolkata's Salt Lake area, supported by a team of central forces, an officer said.

The ruling Trinamool Congress termed the raids as "nothing but political vendetta" amid festivities in the state.

Search operations were also underway at eight other flats including the residences of Mallick's former personal assistant, while he was the food minister, he said.

"There are eight officers conducting the exercise at Mallick's residences. We are also conducting searches at his former personal assistant's residence in Dum Dum, and at a few other places," the ED officer told PTI

The central probe agency had arrested one person who allegedly has close links to the TMC as well as Mallick, he said.

Mallick is being questioned about his connection with the ar-



rested person, the officer said, adding, the minister's bank accounts are also being scrutinised.

TMC leader and state minister Shashi Panja criticised the raids at Mallick's residences, asserting that "this is an attack on the culture of Bengal at the time of 'Bijoya Dasami'. Israel also said it had also carried out around 250 airstrikes across Gaza in the last 24 hours, targeting tunnel shafts, rocket launchers and other militant infrastructure

The Gaza health ministry says more than 6,500 Palestinians have been killed in the war. That figure includes the disputed toll from an explosion at a hospital last week. The fighting has killed more than 1,400 people in Israel, mostly civilians slain during the initial Hamas attack, according to the Israeli government. Hamas also holds at least 224 hostages in Gaza. The warning by the UN agency for Palestinian refugees, UNRWA, over depleting fuel supplies raised alarm that the humanitarian crisis could quickly worsen. Gaza's population has also been running out of food, water and medicine.

About 1.4 million of Gaza's 2.3 million residents have fled their homes, with nearly half of them crowded into UN shelters. Hundreds of thousands remain in northern Gaza, despite Israel ordering them to evacuate to the south, saying those who remain might be considered "accomplices" of Hamas. In recent days, Israel has let more than 60 trucks with aid enter from Egypt, which aid workers say is insufficient and only a tiny fraction of what was being brought in before the war. Israel is still barring deliveries of fuel — needed to power generators — saying it believes that Hamas will take it. An official with the International Committee of the Red Cross said that it hopes to bring in eight trucks filled with vital medical supplies.

"This is a small amount of what is required, a drop in the ocean," said William Schomburg, head of the sub-delegation in Gaza. "We are trying to establish a pipeline." (AP)

The cost can go even higher if local body polls are also held together with Lok Sabha and assembly polls. The high-level committee on "one nation, one election" headed by former president Ram Nath Kovind is examining holding simultaneous elections to the Lok Sabha, state assemblies, municipalities and panchayats, keeping in view the existing framework under the Constitution and other statutory provisions.

According to sources, the poll watchdog in its interaction with the Law Commission also listed out challenges such as need for more warehousing facilities for EVMs. Referring to the nearly one-and-half years of preparatory time, they said two public sector undertakings -- ECIL and BEL -- who manufacture EVMs would also need to be informed well in advance.

They said the semiconductor industry should also be stable to cater to the enhanced demand. The EC would also need time for 'first-level check' (FLC) of EVMs before polls. The EC has already commenced FLCs for the 2024 Lok Sabha elections in a phased manner across India. During FLCs, EVMs, including VVPATs, machines are checked for mechanical flaws by engineers of Bharat Electronics Ltd. (BEL) and Electronics Corporation of India Ltd. (ECIL). Faulty machines are returned to the manufacturers for repair or replacement. A mock poll is also held to check the two machines in the presence of representatives of political parties. (PTI)

"I mentioned about the lessons we drew from the ongoing Russia-Ukraine conflict. And if I can delve on one of the key lessons -- I think land will continue to be a key domain of warfare, especially in cases where

"I think the victory marker will have to be in the land domain. The salience of land domain, I think, is going to be extremely important in our case," he said. Talking about India's rising global profile, Gen Pande said India will continue to play a key role in the Indo-Pacific region.

With the enhanced stature, we will have additional responsibilities and with this we will have certain challenges to encounter," he said. The chief of army staff said "In all of this, we need to remain proactive rather than responding or reacting. We should be able to shape our strategies." He said there will be responsibilities, opportunities and challenges for India in the Indo-pacific. "I think the nation is on the rise, be it the economic growth, technological progress or the influence that the nation wields in the world arena," Gen Pande said. He described the last one year period for the army as "challenging yet satisfying".

"As far as the operational situation is concerned, on the borders, I would say it is stable and we have dealt with internal security challenges in a manner that is expected of us," he said.

The chief of army staff also noted that the ongoing reform process in the army is being implemented as planned. "About a year back, we spelt out our transformation roadmap. In that we defined five distinct foundations as pillars of transformation," he said.

"These were restructuring and right-sizing of the force, modernization and technology infusion, refining and improving our systems and processes to improve combat and functional efficiencies, jointness and human resources management," he said. He said the progress of the reform process has been good. The army chief also listed technology infusion into his force as a key focus area.

In his remarks, Gen Pande also spoke about how national security is emerging as a crucial aspect in the geopolitical competition.

"What we are seeing is the centrality of national interest in this global flux...The salience of national security is growing in the entire international system," he said. Highlighting the changing character of war, Gen Pande said "by this I am alluding to what we are witnessing in the context of Russia-Ukraine conflict." "You have new domains -- be it cyber, be it space, be it information warfare, battle of narratives and the rest. All these indicate that we need to be better prepared and future ready to be able to meet future security challenges," he said. "Looking at the future security challenges, I think we need to transform and that is what we are doing," he added. (PTI)

This failure has implications for the limited global carbon budget available now, especially for developing countries like India." He said that to fulfill their responsibility as historical emitters and financially capable economies, developed countries must do more than meet the global average in emission reduction. The projections also reveal that developed countries rely on drastically ramping up emission reductions after 2030. Even if all developed countries were to reach net zero by 2050, they would require more than four times the average annual reductions they achieved from 1990 to 2020.

CEEW estimates that even in a net-zero-by-2050 scenario, developed countries would collectively emit over 40-50 per cent of the remaining global carbon budget left for the 1.5 degrees Celsius warming target, even though they are home to less than a fifth of the world's population.

Sumit Prasad, programme lead, CEEW, said, "The climate journey of developed countries – historical and proposed – does not show deep enough emission reductions to reflect climate leadership. This means that the burden to mitigate global warming shifts to developing countries, which is problematic in a context where financial support to developing countries to achieve this transition has not been forthcoming, as promised." In their submissions to the United Nations Framework Convention on Climate Change (UNFCCC) regarding their expectations from the global stocktake, a two-year review of the collective global action to achieve the Paris Agreement's goals, many developing countries emphasised that significant gaps exist in developed countries' pre-2020 ambition and implementation, and that their 2030 and 2050 mitigation ambitions are inadequate.

Initiated in Glasgow in 2021, the first-ever global stocktake will conclude at the annual climate talks (COP28) in Dubai in December and set the stage for the next few years of global action to cut down the greenhouse gas emissions causing climate change.

According to the UNFCCC, the recognition that developed countries' 2030 mitigation ambitions are inadequate may also find its way into the outcome of the global stocktake. (PTI)

# 'Climate change, biodiversity loss one indivisible crisis'


NEW DELHI, Oct 26: More than 200 health journals globally have come together to simultaneously publish an editorial calling on world leaders and health professionals to recognise that "climate change and biodiversity loss are one indivisible crisis". They must thus be tackled together to pre-

serve health and avoid catastrophe, said the editors-in-chief of leading journals, including The Lancet, The British Medical Journal (BMJ), the Journal of the American Medical Association (JAMA) and the National Medical Journal of Urging the World Health Organization

(WHO) to declare this indivisible crisis as a global health emergency, the authors say that it is a "dangerous mistake" to respond to the climate crisis and the nature crisis as if they were separate challenges.

'The climate crisis and loss of biodiversity both damage human health, and they are interlinked. It makes no sense for climate and nature scientists and politicians to consider the health and nature crises in separate silos," said Kamran Abbasi, Editor in Chief of The BMJ in a separate statement.

Rising temperatures, extreme weather events, air pollution, and the spread of infectious diseases are some of the major health threats exacerbated by climate change and thus, human health is damaged directly by both the climate crisis and the nature crisis, they said, stressing that the poorest and most vulnerable communi-



ties often bear the highest burden of this dam-

For example, the authors said, pollution threatens access to clean water, fundamental to human health, by damaging water quality and

causing a rise in water-borne diseases.

They also cited the example of ocean acidification which has reduced the quality and quantity of seafood that billions of people rely on for food and their livelihoods. On biodiversity loss, the authors write that it

undermines good nutrition and constrains the

discovery of new medicines derived from na-

Further, they write that emergence of new diseases and pandemics have heightened, owing to land use changes that have forced a closer contact between thousands of species, thereby

increasing the exchange of pathogens. While the biodiversity conference (COP) of December 2022 agreed on the conservation and

management of at least 30 per cent of the world's land, coastal areas, and oceans by 2030, the authors noted that the climate and nature scientists providing the evidence for COPs are largely separate.

Many of these commitments have not been met, they said in the editorial. "This has allowed ecosystems to be pushed

further to the brink, greatly increasing the risk of breakdowns in the functioning of nature," the authors warn. "Even if we could keep global warming below an increase of 1.5 degrees Celsius over pre-industrial levels, we could still cause cata-

strophic harm to health by destroying nature,'

they said. This risk, combined with the severe impacts on health already occurring, means the WHO should declare the indivisible climate and nature crisis as a global health emergency, before or at the World Health Assembly in May 2024,

"Health professionals are highly trusted by the public, and they have a central role to play in articulating this important message and advocating for politicians to recognise and take urgent action to address the global health emergency. Over 200 health journals are today sending an unequivocal message," said Ab-



# Objectivity must as we are responsible to history: Benegal on being neutral in political films

MUMBAI, Oct 26: Veteran filmmaker Shyam Benegal says it is important for a director to be objective while making films about politically relevant events and personalities.

Benegal, considered a pioneer of the Indian parallel cinema movement with classics such as "Ankur", "Nishant", "Manthan", "Bhumika", "Junoon" and "Mandi" to his credit, said it is always easy to take sides but a storyteller has a responsibility towards history and must present it

as objectively as possible.

"It is easy to take sides. You cannot look at it objectively, not everybody can, even I cannot, but the fact is that we have to see to it that we are as objective as possible because you are responsible to history, not to anybody else," Benegal told PTI in a group interview. He was asked about movies like Vivek Agnihotri's "The Kashmir

Files" and Sudipto Sen's "The Kerala Story", and how important it is for filmmakers to stay neutral when they make films about politically relevant events. "It depends on how close you are to the (subject), whether you can be objective enough or not. Now 'The Kashmir Files' is a very earnest film but he is too close to the subject because he is (referring to actor Anupam Kher) a Kashmiri himself, he is too close. He cannot have the objectivity that is necessary," Benegal

Starring Kher and Pallavi Joshi, The Kashmir Files" depicted the exodus of Kashmiri Pandits from Kashmir valley in the 1990s. It opened to polarised reactions in March 2022 but became one of the most commercially successful Hindi films of the year. Benegal, 88, is currently promoting his latest film "Mujib - The

Making of a Nation"

The biographical drama narrates the life story of Sheikh Mujibur Rahman, the first president of Bangladesh and later its prime minister who was assassinated with most of his family in 1975.

Benegal said it is difficult to make a film on a politician's life. He added that it was essential for him to tap into the humane side of Rahman and bring out unknown facets of his life.

"It is not easy to make because you end up doing many conventional things. It is very difficult to say anything from another point of view because so many points of view have already been covered by so many people -- historians and newspaper reporters ---because they are people in the news and hence there's a lot written about them.

"So, in that jungle of information

you have to find your way and find that one thing that suddenly reveals the man. It's like peeling an onion. Like, we have our prime minister, how many of us know him, I don't know but we think we know him because there's a public image about him. But how many of us know him as a person? This happens with pub-

"Mujib – The Making of a Nation" is a collaboration between India's National Film Development Corporation (NFDC) and the Bangladesh Film Development Corporation (BFDC).

#### India creates history in Asian Para Games, takes tally to record 80 medals with 2 days left

HANGZHOU, Oct 26: Indian para athletes on Thursday created history by winning the highest number of medals in the Asian Para Games, taking country's tally to 80, including 18 gold medals.

India have now gone past the earlier best of 72 achieved in the 2018 edition in Indonesia. India's medal tally read 18 gold, 23 silver and 39 bonze, and the count will keep on increasing till the end of the fourth day of competitions. With two more days left in the Games, the country is on course to achieving its target of 100 medals in this Hangzhou edition.

India had won 72 medals (15 gold, 24 silver, 33 bronze) in the last edition in Jakarta which was the best before this Hangzhou Games
