# 'Unrest to continue if 4000 looted arms not seized'

GUWAHATI, Nov 21: Terming the ethnic clashes in Manipur as a "political problem", Eastern Army Commander Lt Gen Rana Pratap Kalita on Tuesday said incidents of violence will continue unless around 4,000 weapons, which were looted from security forces, are recovered from common people.

The Eastern Command General Officer Commanding-in-Chief also said India is giving shelter to anyone from Myanmar seeking refuge, including common villagers, army or police, in Mizoram and Manipur, but not armed cadres of militant groups of drug traffickers.

"Our efforts have been to contain the violence and motivate both sides of the conflict to come for a peaceful resolution of the political problem. Because ultimately, there has to be a political resolution to the problem," Kalita told reporters at an interaction organised by the Gauhati Press Club

As far as the ground situation was concerned, the Indian Army's aim initially was to carry out

# Coordination between NE police forces will help tackle common problems: CM

GUWAHATI, Nov 21: Chief minister Himanta Biswa Sarma on Tuesday stressed on the need for close coordination between police forces of the northeastern region as the different states share common problems such as drug trafficking and militancy.

He also asserted on the need for increased use of technology in policing to effectively prevent crime and bring criminals to book.

Speaking at the passing out parade at the North East Police Academy (NEPA) at Umiam in Meghalaya, Sarma said police forces of the northeastern states should work together since the problems are also the same.

He cited drug trafficking through Myanmar as a common menace, while also claiming that militant groups of different states "stay outside and work together and adopt



crease understanding and adopt uniform policy to fight them," he said.

He urged the newly inducted policemen to maintain the spirit of camaraderie that has developed between them during training, emphasising that closer coordination at the field level will help in tackling crime more effectively than waiting for official communication between

the higher-ups. "We have to fight drug trafficking and other crimes and ensure that our senior citizens, women, children and other vulnerable sections are safe," the CM added. #### Change in geo-politics on, only army can't win war: Lt Gen R P Kalita

GUWAHATI, Nov 21: Stating that a "change" is taking place in the geo-political sphere, Eastern Army Commander Lt Gen Rana Pratap Kalita on Tuesday said only the armed forces cannot win any future war without the involvement of the civil society. As a 'Guest of Gauhati Press Club', Kalita said the "change" has impacted the Indian Army, which is undergoing a huge transformation currently on five different verticals of the force.

"Russia-Ukraine war is going on, Israel-Hamas conflict is also on. There is also a lot of instability in our neighbourhood. So, the whole geo-politics is changing. There is a change which is taking place. And it impacts not only our country but our armed forces as well," he added.

As there are "changes" all around, a technological development is taking place and it is making an impact on the art of warfare, said the General Officer Commanding-in-Chief of Eastern Army Command.

"So, the war fighting methodology is also changing. That is the reason why 2023 has been identified as the year of transformation by the Indian Army. These are based on five main pillars," he told reporters here. The five verticals are force restructuring and optimisation, modernisation and technology infusion, processes and functions, human resource management, and (CONTD. ON PAGE-9)

The minister was chairing a review meeting here of ongoing projects of his ministries in the northeastern region. Of the 25 inland waterways projects in the region, 15 programmes worth ₹ 850 crore were granted for Assam,

He directed the officials to complete the seven floating jetties at Jogighopa, Pandu, Biswanath, Nimati, Bindhakata, Uriamghat and Sadiya in Assam.



In addition, permanent jetties at Bogibeel in Dibrugarh, and renovation of a jetty at Badarpur in Karimganj would also be completed while one permanent jetty being constructed at Sonamura in Tripura was also likely to be completed within the timeframe, he said. The minister also reviewed the

He also directed officials of the Inland Waterways Authority of India (IWAI) to regularly dredge 88 identified shallow passages on the Brahmaputra river to ensure smooth passage of ships.

# Mamata announces slew of new policies, sub-sea cable landing station, industrial corridors

ister Mamata Banerjee on Tuesday announced a slew of new policies including plans to double the state's exports, modernise its logistics and promote renewable energy manufacturing, while inaugurating the seventh Bengal Global Business Summit here.

Banerjee also announced a policy to promote bio-fuels and a new sub-sea cable landing station at the sea-resort of Digha to help improve internet connectivity in the eastern region.

The chief minister also said the state's economy was growing at 8.41 per cent and its GDP would touch USD 212 billion this fiscal. West Bengal was ranked sixth in terms of GDP among Indian states in a recent report by Forbes India. She also told a star-studded gathering of business leaders including petro-chemicals to retail tycoon Mukesh Ambani, energy baron Sanjeev Goenka and Wipro's Rishad Premji, that four new industrial corridors would be set up including Dankuni-Kalyani, Tajpur port-Raghunathpur, Dankuni-Jhargram and Durgapur to Cooch Behar in north Bengal.

Dankuni, eastern India's largest logistics hub, already boasts of 9 km of conveyor belts to carry goods to and from storage silos, added her former finance minister and principal chief advisor Amit Mitra.

The Bengal Global Business Summit, an annual affair, is being attended by several hundred companies from 35 countries, including UK, US, Australia, Korea, Japan, Germany and France. Lashing out at the BJP-ruled Union government, she said, "I am sorry to say that the state is not getting any financial support from the Centre. We are not getting our share



of GST and wages under MGNREGA scheme have been stopped."

"But I am in favour of peace and happiness. Some people ask me which 'ism' do I follow. I tell them that I am neither in favour of Rightism

nor Leftism. I believe in humanism," she said. Highlighting the fact that the state was home to some 90 lakh MSME units employing 1.3 crore people, Banerjee pointed out that it also housed a large leather manufacturing complex which was being expanded to be the Asian continent's biggest, besides boasting of one of the largest IT hubs in the country. Banerjee said that the state's Durga Puja festival economy grossed over ₹ 80,000 crore this year. She also announced former India cricket skipper-turnedbusinessman Sourav Ganguly would be a brand ambassador for the state.

Reliance Industries chairman and MD Mukesh Ambani, while speaking on the occasion, announced an additional ₹ 20,000 crore investment for West Bengal over the next three

years. Ambani said the fresh investment will be in the areas of digital life solutions, retail and bio-energy. "We plan to invest an additional ₹ 20,000 crore in West Bengal in the next three years for enhancing digital life solutions, augmenting Reliance Retail footprint and on bioenergy," he said. The Reliance Industries has invested close to ₹ 45,000 crore in the last few years in the state, Ambani said. "Reliance will leave no stone unturned to accelerate Bengal's growth," he asserted.

The Reliance Foundation will also take up the task of renovating and restoring the iconic Kalighat Temple in Kolkata to regain its "original glory", Ambani added. Wipro Chairman Rishad Premji added, "West Bengal provides the right policy environment for expansion of IT industries." RPG's Sanjeev Goenka told the gathering that his firm has invested ₹ 25,000 crore in the state over the last few years as "decision making has been quick and efficient" and that the era of "go slows, strikes and unrest are of the past... the CM wants business"

The chief minister also claimed that her state was a model of tranquillity and good governance, though she also accused the opposition of running a campaign to smear the state's image. Banerjee said that in the last six editions of BGBS, proposals amounting to USD 190 billion have been received, and of those, projects worth USD 121 billion have already been launched or are at various stages of implementation. She also touched upon various social welfare schemes of her government including Kanyashree, free ration for the poor, and Lakshmi Bhandar direct cash benefit for women, among others. (PTI)

# Stock markets recover from 2-day decline on firm global cues, easing rate hike worries

MUMBAI, Nov 21: Benchmark stock indices Sensex and Nifty rebounded on Tuesday after two days of decline following buying in select metal and banking shares and a bullish trend in the US markets on easing

The 30-share BSE Sensex climbed 275.62 points or 0.42 per cent to settle at 65,930.77 as its 18 components advanced while 12 declined. During the day, it jumped 427.21 points or 0.65 per cent to 66,082.36.

The broader Nifty went up by 89.40 points or 0.45 per cent to 19,783.40. As many as 30 NSE shares gained while 20 closed in the red.

JSW Steel was the lead gainer among Sensex shares, rising by 1.76 per cent. Tata Steel rose by 1.45 per cent, and Titan by 1.44 per cent.

Oil major Reliance Industries advanced 1.24 per cent, helping the indices snap two days of losses.

Among banking shares, HDFC Bank, ICICI Bank and Axis Bank gained. Sun Pharma, Bharti Airtel, Tata Motors and Bajaj Finserve also advanced.

NTPC, Tech Mahindra, Maruti, State Bank of India and Larsen & Toubro were among the laggards. Vinod Nair, Head of Research at Geojit Financial

Services said, "Today, the market exhibited positive momentum, with attention centred on the minutes of the latest Fed meeting. The declining inflation and the recent cooling job data in the US provide foundation for a dovish comment from the Fed.'

The drop in bond yields and the dollar index suggests mounting speculation regarding the potential peak in the interest rate cycle.

'This will attract funds to emerging markets. The gain in the broad market was led by consumer durables and realty, thanks to a strong rebound in festive demand," Nair added.

The US dollar index eased by 0.10 per cent to 103.33 ahead of the release of the Fed minutes later

In the broader market, the BSE smallcap gauge climbed 0.20 per cent and midcap index gained 0.14 per cent. Among the indices, consumer durables jumped 1.34 per cent, commodities climbed 0.77 per cent, healthcare (0.59 per cent) and financial services (0.37 per cent).

FMCG, industrials, IT, telecommunication and oil & gas were the laggards.

A total of 2,018 stocks advanced while 1,701 declined and 134 remained unchanged on the BSE.

In Asian markets, Seoul settled with gains while Tokyo, Shanghai and Hong Kong ended lower.

European markets were trading on a mixed note. The US markets ended in positive territory on Monday as bond yields eased as well the dollar weakened. Global oil benchmark Brent crude declined 0.61 per cent to USD 81.82 a barrel.

Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 645.72 crore on Monday, according to exchange data.

The BSE benchmark declined 139.58 points or 0.21 per cent to settle at 65,655.15 on Monday. The Nifty slipped 37.80 points or 0.19 per cent to 19,694. (PTI)

#### **ASEAN** wants India to join RCEP for greater market access: Secretary-General Kao

JAKARTA, Nov 21: ASEAN Secretary-General Dr Kao Kim Hourn has said that the 10-member bloc of the Southeast Asian countries wants India to join the landmark Regional Comprehensive Economic Partnership (RCEP) for greater market access as he asserted that all partners stand to gain from the inclusive, open and rulebased trade pact.

Dr Kao also said that India and ASEAN have been working together across different sectors from space to investment, to tourism, to the defence sector and counter-terrorism, among others and advocated expanding such cooperation in new sectors.

Talking to a select group of Indian journalists here on Monday evening, Dr Kao said joining the Regional Comprehensive Economic Partnership (RCEP) would benefit India as the agreement would provide greater market access. He added that all partners will gain from the inclusive, open and rule-based trade pact.

The RCEP is a free trade area (FTA) consisting of 10 ASEAN members (Brunei, Cambodia, Indonesia. Malaysia. Myanmar. Singapore, Thailand, the Philippines, Laos and Vietnam) and five of the bloc's dialogue partners -- China,



Japan, South Korea, Australia and

The landmark agreement was signed in November 2020. Together, these RCEP participating countries account for about 30 per cent of the global GDP and 30 per cent of the world population.

India had pulled out of the RCEP as, according to officials, joining it would have resulted in fairly negative consequences for the country's economy.

"Looking ahead, of course, we hope to continue to expand the existing areas of cooperation and also to deepen our cooperation," he said, suggesting collaboration in the biotech sector, public health facility, renewable energy sector, people-to-people exchange, con-

nectivity and in many other areas partnership between ASEAN and India. At the moment, we have cific." (AP)

#### Argentina's president-elect wants public companies in private hands, with media 1st to go

BUENOS AIRES (ARGENTINA), Nov 21: Argentina's right-wing president-elect gave the first indications on Monday of how he plans to start shaking up South America's second-largest economy: with a slew of privatisations.

Populist Javier Milei, a libertarian economist and self-described "anarcho-capitalist", won a presidential runoff election on Sunday with 55.7 per cent of the vote. He said on Monday that he would move quickly to privatise the country's state-owned media outlets and look to do the same with other public companies.

"Everything that can be in the hands of the private sector will be in the hands of the private sector," Milei told Bueno Aires station Radio Mitre.

Experts immediately questioned how far Milei would get in fulfilling that vision without the support of Argentina's National Congress, where his party holds a relatively small share of seats. However, some analysts said his resounding election victory could give him leverage.

"The decisiveness of the victory — a doubt until yesterday — allows him to signal to all parties who is in control of the transition and the formation of the Cabinet," said Mariano Machado, principal analyst for the Americas at Verisk Maplecroft, a global risk intel-

In his radio comments, Milei described the public media outlets he wants to make private as amounting to "a covert ministry of propaganda".

He complained during the presidential race that the coverage of his campaign in state-run outlets was highly negative.

Milei also signalled that he intends to act on some of his most controversial ideas from his campaign for slashing the size of the state and reining in Argentina's triple-digit inflation. They include reducing the number of government ministries by half, to eight. He said he still wanted to close the Central Bank of

Argentina, calling it "a moral decision", but appeared to put his plans for replacing the local currency, the peso, with the US dollar on the back burner. "In conceptual terms, the central axis is to close the

Central Bank, and subsequently, the currency (will be) whichever one Argentines choose freely," he said, characterising a potential change in the national currency as "a second-order issue"

Milei predicted it would take him up to half of his presidential term — "between 18 and 24 months" to decrease inflation, which polls showed was the biggest concern for Argentine voters as consumer prices have increased 140 per cent over the past year.

"Working to reduce the size of the government and eliminate taxes," Diana Mondino, a lawmaker from Milei's Liberty Advances party who is widely seen as likely to be Milei's pick for foreign minister, wrote on social media. She posted a photo showing the newly elected president meeting with several key allies.

State-controlled energy firm YPF, the country's largest integrated energy company, is another entity the president-elect thinks should be privatised but only once its finances are shored up so it can be "sold in a very, very, very beneficial way for Argentines".

Milei claimed the company's balance sheet deteriorated after a majority stake was nationalised during the government of former President Cristina Fernandez de Kirchner, who is now the outgoing vice presi-

Monday was a public holiday in Argentina so financial markets weren't open, but the stocks of Argentine companies that trade in New York soared. YPF saw its share price increase 40 per cent after Milei talked of its privatisation. (AP)

At the interbank foreign exchange, the rupee opened at 83.33 and finally settled at 83.34 against the greenback, registering a gain of 4 paise from its previous close.

During the day, the rupee witnessed range-bound trade reaching an intra-day high of 83.32 and hitting a low of 83.37 against the American currency. (PTI)

#### Gold climbs ₹380; silver advances ₹100

NEW DELHI, Nov 21: Gold prices climbed ₹380 to ₹62,150 per 10 grams in the national capital on Tuesday amid strong global cues, according to HDFC Securities. In the previous trade, the precious metal settled at ₹ 61,770 per 10 grams. Silver also edged up by ₹ 100 to ₹ 76,400 per kilogram. In the global markets, both gold and silver were trading higher at USD 1,992 per ounce and USD 23.66 per ounce, respectively. Gold prices surged to a fresh swing high as the dollar and Treasury yields fell in the wake of expectations that Federal Reserve was done with raising interest rates, Saumil Gandhi, senior analyst of commodities at HDFC Securities, said. Traders will focus on minutes of the Federal Open Market Committee (FOMC) meeting which is going to be released later in the day for cues on monetary policy rate outlook, Gandhi said. (PTI)

Stocks broadly drifted higher throughout

the day before they took a turn upward in the afternoon when yields fell in the bond market following an auction of Treasurys. Easing Treasury yields have driven a strong rally for stocks in recent weeks.

This week is relatively light on reports that could sway the hopes on Wall Street that

Other than that, the release of the minutes from the Fed's latest policy meeting on Tuesday and preliminary reports on US business activity on Friday are among the highlights.

That could make Nvidia's upcoming profit report on Tuesday the week's highestprofile event. Analysts expect it to say its earnings per share more than quintupled from a year earlier and that its revenue

soared to nearly USD 16.2 billion from less than USD 6 billion. Nvidia, which rose 2.3 per cent on Monday, carries huge sway on the S and P 500 and other indexes because it's the fifth-most valuable US stock. Much of that rise has been because of excitement around AI, and Nvidia's report could offer clues on how much all the talk about AI is translating into actual sales.

Best Buy, Deere, HP and Lowe's also will give their latest quarterly updates this week. The yield on the 10-year Treasury, which is the centrepiece of the bond market, dipped to 4.40 per cent from 4.44 per cent late Friday. The two-year yield, which moves more on expectations for Fed action, slipped to 4.89 per cent from 4.90 per cent late Friday.

In energy trading, benchmark US crude fell 30 cents to USD 77.53 per barrel in electronic trading on the New York Mercantile Exchange. It added USD 1.79 on Monday. Brent crude, the international standard, shed 28 cents to USD 82.04 per barrel.

In currency trading, the US dollar inched down to 147.51 Japanese yen from 148.37 yen. The euro cost USD 1.0961, up from

# 'Kabhi Khushi Kabhie Gham': UK Oppn Leader Keir Starmer on FTA with India

Leader Keir Starmer has described the ups and downs of the government's negotiations towards a free trade agreement (FTA) with India as 'Kabhi Khushi Kabhie Gham' and committed the Labour Party to pursuing an "always happy" bilateral rela-

During his speech at a Diwali celebration in the Houses of Parliament complex in London organised by the British Indian think tank 1928 Institute last week, Starmer referenced the Bollywood box-office hit which translates as sometimes happy, sometimes sad. India and the UK are currently in the 14th round of FTA negotiations to enhance the GBP 36-billion bilateral trading partnership, with several expected completion points having passed.

'We will be rebuilding Britain's reputation on the international stage and that means a new strategic partnership with India," said Starmer.

"The Tories are working on a free trade

agreement, I think. It's all a bit stop-andstart. In fact, you could almost call the negotiations 'Khabi Kushi Khabhie Gham'. But Labour wants more than that – we want a deeper understanding. You can call it an always happy relationship. A relationship based on our shared values of democracy, aspiration and respect," he said.

The FTA talks began in January last vear with Diwali 2022 set as the initial deadline by then prime minister Boris Johnson. Under the Prime Minister Rishi Sunak-led Tory government, no new timelines have been set but both sides are keen to get things signed off before a general election year in India and the UK in 2024.


Meanwhile, the Opposition Labour Party, which is leading the opinion polls over the governing Conservatives ahead of the expected polls, is keen to reach out to Britain's estimated 1.9 million strong Indian diaspora electorate.

"To British Indians, I want to express my admiration and respect for everything you do for our country. Without your efforts, this country would be diminished in so many ways," said Starmer, who was joined by senior members of his shadow cabinet at the event last Wednesday. His shadow foreign secretary, David

Lammy, shared reflections from his wideranging discussions with External Affairs Minister S. Jaishankar, who was in the UK on a five-day visit last week.

"We talked, of course, about the free trade agreement. We talked about development aid and partnership across South Asia and also, Africa... about tech and digital. and the huge contribution science and tech can make in an age of AI (artificial intelligence)," he said.

In addition to leaders representing the Hindu faith, a cross-section of parliamentarians and activists joined the community cohesion-themed Diwali event which included messages of goodwill and solidarity by prominent members of the Jewish, Islamic and Christian faiths.



"In these times, the message of light over darkness, of good over evil and knowledge over ignorance is so impor-

tant," said Anneliese Dodds, chair of the Labour Party and shadow women and equalities secretary. (PTI)



#### **December 3: All** awaiting keenly

s the assembly elections in Madhya Pradesh and Chhattisgarh loom on December 3, political tension escalates, with both the Bharatiya Janata Party (BJP) and Congress closely monitoring the record turnout, led notably by women voters. The BJP asserts that Prime Minister Narendra Modi's charisma remains an electoral asset, while the Congress anticipates significant wins, potentially shaking the BJP's stronghold in Madhya Pradesh and Chhattisgarh. Crucially, December 3 marks a pivotal moment for the Indian National Developmental Inclusive Alliance (INDIA). Depending on the results. INDIA will chart its course for alliance talks ahead of the upcoming Lok Sabha polls. The success of the Opposition's attempt at unity hinges on this, especially considering the setback when the Congress chose to contest independently in Chhattisgarh and Madhya Pradesh. In Madhya Pradesh, the Congress posed a formidable challenge to the ruling BJP, prompting a reliance on Modi's image. Simultaneously, the Samajwadi Party's seat-sharing plea was rejected, leading to exchanges of words between party leaders.

The INDIA bloc, after an optimistic start, faces uncertainties, with Rajasthan also awaiting its turn to influence the political narrative. The prevailing anticipation leans towards Congress victories in all three states, solidifying its position as a formidable force and affirming the INDIA bloc's reliance on Congress leadership. December 3 serves as the litmus test for the INDIA bloc's relevance, determining whether it will emerge as the defining alliance for the 2024 general elections. Conversely, BJP victories could unravel the INDI-Alliance, dealing a blow to its constituents. The vulnerability of the INDI-Alliance is attributed to the Congress's actions. The original concept aimed at presenting a united front against the BJP, but the Congress's reluctance to share seats in key states disrupted this unity. A Congress triumph in Rajasthan would further underscore its self-sufficiency within the alliance, emphasizing that the INDIA bloc cannot thrive without Congress leading from the front. The harsh reality is that, among the INDI-Alliance parties, only the Congress holds the potential to defeat the BJP. The BJP's reliance on women voters, particularly those benefiting from the Prime Minister's welfare schemes, adds an intriguing dimension. The extension of the free ration scheme for five more years was a strategic move, aimed at securing support from women who prioritize food security over other considerations.

December 3 will also unveil the electorate's stance on the INDIA bloc's demand for a 'Caste Census'. Congress victories would validate the need for such a census, reinforcing Rahul Gandhi's vocal advocacy. Conversely, BJP wins may indicate a weariness with caste dynamics influencing elections. The call for a 'Caste Census' aligns with the Opposition's push for equitable participation of Other Backward Castes in governance. Congress victories would signify that the era of 'Mandal' politics is far from over, posing a formidable challenge to the BJP's 'Kamandal' narrative. Rahul Gandhi's departure from traditional Congress thinking on the 'Caste Census' may resonate with the electorate, reflecting in the December 3 results and affirming the Congress as the linchpin of the INDI-Alliance. In its current form, the Congress strives to reclaim its former glory amid a growing discontent with Modi's rule. The timing appears opportune, with a surge in the Congress's winnability rating, marking a significant shift after a decade of political dynamics. December 3 emerges as the D-Day when numerous political arguments will find resolution, shaping the trajectory of Indian politics in the coming years.

# Far Right outsider Javier Milei wins presidential elections in Argentina

n a big setback to the Left in Latin American region, Far Right out-Lsider Javier Milei defeated the Left coalition's Peronist economy minister Sergio Massa in a close contest in the Presidential elections held on Sunday November 19. Milei got around 55 per cent of the votes polled as against the Peronist minister and sealed his election as the new President of the second largest country in the Latin American continent.

The victory of the Far Right candidate in the Argentina presidential elections is a reversal of the process of pink tides in the Latin American countries in the presidential elections of the last two years. After the election of the leftwing Morena party candidate Obrador as the President of Mexico in 2018, in most of the presidential elections in the region, the left wing candidates won. These countries so far include Bolivia, Peru, Chile, Guatemala, Honduras, Columbia and most importantly Brazil. Only on October 15 this year, the leftwing candidate got defeated in Ecuador in the presidential elections. After that, the right victory took place in Argentina. The term of the President is for four years. The victory of the Far Right Milei has both political and economic implications for the immediate future of the economy of the region. Milei, who is called the Donald Trump of Argentina, has a completely different political and economic perspective about the future of the Argentine economy and its links with the other countries of the region. He fought on a completely different platform as against the pro public sector programme of the Peronist government.

His campaign promise to dollarize Argentina, if enacted, is expected to thrust the country into a new developmental path. No country of Argentina's size has previously turned over the reins of its own monetary policy to Washington and the multinational corporations. With his coming, the collaboration planned between Mexico, Brazil and Argentina-the three largest economies of the continent for having synergy in economic activities, will also get a jolt. Brazil and Mexico are bent on diluting the role of the US companies in the development of their respective economies, but the President elect wants full involvement of the US in the economic rehabilitation of Argentina which is facing an inflation rate of around 140 per cent this

Milei, a social conservative with ties to the American right, opposes abortion rights and has called climate change a "lie of socialism." He has promised to slash government spending by closing Argentina's ministries of culture, education, and diversity, and by eliminating public subsidies. Milei's programme of cutting the role of the state in development of Argentina has been welcomed by his mentor Donald Trump. Who tweeted on his platform Truth 'I am proud of

you. Make Argentina great again.' Outside of his controversial plan for dollarization, Milei's political program includes slashing regulations on gun control and transferring authority over the penitentiary system from civilians to the military; both measures part of a tough-oncrime approach. He proposes using public funds to support families who choose to educate their children privately and even privatizing the health sector, which in Argentina has always been in public hands. This specific plan for dismantling the government subsidized health system was one of the key points in the campaign by the Left candidate Massa.

The Left coalition has accepted the verdict gracefully and preparing for the next round of battle. The Peronists and its Left allies have ruled Argentina for many terms and have solid base among the underprivileged. The coalition leaders are waiting for the takeover of the new President and the result of the implementation of his promised programmes. Political analysts are of the view that in a vast country like Argentina it is not possible to give relief to the underprivileged by cutting the role of the state. Already, the country's population is polarized. The impact of Milei's unconventional programmes will decide which way the wind will blow during 2024. The Left in other countries of Latin America are watching with keen interest the coming developments in the crisis ridden economy of Argentina. (IPA Service)

# Opposition in Bangladesh failing to unseat Sheikh Hasina

any keen political observers believe that the principal opposition Bangladesh Nationalist Party (BNP) has come to a dead end on the road. Their strategy has been violent to demand that Prime Minister Sheikh Hasina should step down and an interim government to hold a free, fair and inclusive national elec-

BNP has announced to boycott the upcoming national election in January 2024. The party and its alliance have called for a countrywide general strike (hartal) and blockade (oborod).

The blockade was announced in protest of breaking up the BNP's 28 October rally allegedly by police in conjunction with the 'golden boys' of the governing Awami League.Political historian Mohiuddin Ahmad said the opposition always envisages winning the election. If they access that they will not win, or even win a reasonable number of seats in the parliament. then they threaten to boycott the elections. Demanding Hasina to quit power and form an interim government to oversee the elections is not happening. The rewritten constitutional provisions have deleted the sections for holding elections under a caretaker government, said Ahmad.

Winter in Bangladesh comes as a blessing when flowers bloom across the gardens and parks in the country. The village women prepare traditional pita (traditional cake made from fresh rice harvest). Some schools are done with their final exam. While others plan vacations during the

The vibrant tourist industry is now challenged with negative business. This awkward situation has been caused by opposition actions and the governing party along with its alliance joining the election fest. In fear of political actions, the customers cancelled their vacation plans.

Ahmad said it is understood what the BNP wants. But the party leaders before they were arrested and sent to prison had not spelled out what they wanted to do after they won the election

They have not promised that they will abrogate all draconian laws which hinder democracy. They did not say they would ensure accountability and transparency and zero-tolerance for corruption and human They did not say that the judiciary would become independent with no political influence and not harass and intimidate opposition, critics, and dissidents. The opposition party has not spoken a word about freedom of expression, freedom of speech, freedom of assembly and freedom of the press.Arson, agitation and protest rallies will not change the policy of the government. After boycotting the election they have nowhere to go but sink in a black hole. There are reasons BNP is aggressive, arrogant and refuses to dialogue with the government parties. Thus arrogance of the BNP has led the party to the end of the

Nonetheless, BNP for long is leaderless or rudderless and floating without any compass. The present party leaders are

powerless and do not have the guts to manage the party autonomously. It's no longer news that BNP is managed by a remote controller - sitting in London by a self-exiled leader. The party chairperson Khaleda Zia is serving jail terms and is restricted in her house. She is barred from politics and unable to contest any elections. The ailing leader with medical complications often shuttles between her home and the hospi-

The party's de facto leader Tarique Rahman (56) is Senior Vice-Chairman of BNP. A spoiled brat of the military dictator General Ziaur Rahman (1977-1981) and former Prime Minister Khaleda Zia. The 93-year-old former President Prof Badruddoza Chowdhury once blamed Tarique arestablished a political bitrarily "powerhouse outside the Prime Minister's Office" when her mother Khaleda was the Prime Minister (2001-2006)

Tarique never attended any BNP's central committee or high command's meetings, but he dictated his decisions. Several ministers and secretaries of various ministries sought his decision and approval of government projects from the popularly known place in upscale Banani, the 'Hawa Bhaban', the office of the delinquent.

His schoolmates said he was a flop in the class exam. A below-average student in BAF Shaheen School and College in Dhaka was a timid person and not vocal. He was kicked out of the school for failing an annual exam. Later he was a dropout from studies. The high school certificate and college degree were obtained fraudulently. Khaleda Zia never expressed embarrassment that her son established a parallel government. She never stopped him from messing with government ad-

Instead, she indulged his son to run an unauthorised powerhouse and also rein the party. Corruption during Khaleda Zia's regime was not spatial but horizontal - the 'prince' did it all.Discontentment among the senior party leaders and ministers began to surface, which the Prime Minister tried to pacify. He hated the senior BNP

leaders including those DEGREE OF THOUGHT Ministers who were inducted into the newly born By: Saleem Samad party by his assassinated father Ziaur Rahman. He advocates that the country should be gov-

> erned by new generation (XGen) politicians and not left with the 'old haggards'. In the October 2001 election, understanding that the BNP may not be elected to power, he cleverly forged an alliance with the Islamist party Jamaat-e-Islami, which surprised many BNP leaders.

In fact, several senior BNP leaders and ministers were 1971 liberation war veterans and also those from the leftists and communists who joined the nationalist party during the tenure of Zia were uncomfortable with the presence of JeI. The Islamist party opposed the independence of Bangladesh and collaborated with marauding Pakistan troops. The youths of JeI were recruited to form the death squad, Al Badr.

The death squad, a secret outfit abducted hundreds of intellectuals, tortured them in secret locations and later killed them, which was the saddest episode of the liberation war history.

The Pakistan military committed genocide of 3 million, targeting the Hindus, but Muslims who belonged to the Awami League and people sympathetic to independent Bangladesh were also slaughtered and buried in hundreds of mass graves all over the country.

The occupation forces deliberately used rape as a weapon of war to create a new generation of "saccha (genuine) Pakistanis". The crackdown created 10 million war refugees of Hindus and Muslims alike.

The war refugees were forced to take shelter in neighbouring states of India. The war has also caused internal displacement of 25 million in search of safe refuge.

The refugees were sheltered in India until Bangladesh was liberated in December 1971. Millions of refugees trekked home to their homesteads only to find their villages were parched, houses looted and torched by local militia. The JeI leader of the eastern province of Pakistan, Ghulam Azam, fled to Pakistan in 1971 living behind his compatriots and Islamic militia to fight alongside the Islamic army.

Later Jel party was banned. Imbued in the 1974 constitution and declared that any party with a religious objective will not be registered as a political party.

Civil society challenged the self-styled professor Ghulam Azam as the Ameer of Jamaat-e-Islami Bangladesh in 1991, arguing that he was a citizen of Pakistan and should be deported. He, however, held the position until 2000. Azam hated the independence of Bangladesh and believed the territory (Bangladesh) would be under the hegemony of India. Azam was convicted of crimes against humanity in July 2013.

In a development on November 19, the apex court upheld the scrapping of Jamaate-Islami's registration as a political party, barring the party from contesting any polls. The Appellate Division of Supreme Court upholds a verdict from the High Court that prevents the party from running for elected office, writes the private news portal bd-

This means that JeI is left with no scope to contest the upcoming elections scheduled in early January. It could not be ascertained whether JeI has any alternative plan to participate in the national election. A senior journalist who is familiar with the JeI policy said that the party leaders of Majlis-e-Shura, the highest policy-making body of the JeI will meet soon, to discuss the future of the party and relay the decision to the members

With Jei put out of circulation, the wings of the BNP have been clipped from forming an electoral alliance or having a strong ally in the anti-government movement. (The author is an award-winning independent journalist based in Bangladesh. could be reached

fter 7th October, following Hamas's unprecedented surprise attack on Israel, much of the international community rushed to voice its concern about the escalation in tensions, but few took a moment to condemn Israel's aggression against the Palestinians. However, as Israel continues to bomb Gaza and attack Palestinians in the occupied West Bank, several governments have started to turn critical of Israel's actions - some more directly than others. Surprisingly, even the number of nations, condemning Israel's brutal military oppression in Gaza, doesn't exceed a two-digit

In contrast there are some nations like South Africa, which have vociferously condemned the Israeli brutalities in Gaza on unarmed Palestinian children, youth and aged. On 17th November, the prosecutor of the International Criminal Court (ICC) said he had received a joint request from five countries to investigate the situation in the Palestinian territories.

Prosecutor Karim Khan said the referral had come from South Africa, Bangladesh, Bolivia, Comoros and Djibouti. South Africa said the request was made "to ensure that the ICC pays urgent attention to the grave situation in Palestine."Though, Israel is not a member of the court and does not recognise its jurisdiction, the ICC can investigate nationals of nonmember states in certain circumstances, including when crimes are alleged to have been committed in the territories of member states. The Palestinian territories have been listed among the ICC's members since 2015.

Perhaps the emotional connect between S Africa and Palestine exists because of the two prominent leaders of the non-aligned movement i.e. Nelson Mandela and Yasser Arafat, from these two countries respectively, and recalling the experience of anartheid themselves, the S African leaders could better understand the plight of the Palestinians and raise their voice in their support. The South African government has made its position clear expressing support for the Palestinians amid the ongoing attacks by Israel in the Gaza Strip, though also condemning resistance group Hamas for attacking and kidnapping Israeli civilians.

"We, who enjoy the freedom from Apartheid, can never, ever be the ones who agree to an apartheid form of oppression. This cannot be tolerated. This brutality should not be accepted." Foreign Minister Naledi Pandor said in parliament on 14th November while deliverIsraeli-Palestinian Conflict.

"These actions remind us of our experiences as Black South Africans living under Apartheid. This is one of the key reasons South Africans, like people in cities all over the world, have taken to the streets to express their anger and concern at what is taking place in Gaza and the West Bank." she said. Taking a proactive action last week, South Africa withdrew all its diplomats from Tel Aviv for consultation over Israel's assault in Gaza. The S African government also instructed the Foreign Ministry to take the necessary diplomatic measures to deal with the conduct of the Israel ambassador to South Africa, Eliav Belotserkovsky, whose conduct, they said is becoming very untenable. Belotserkovsky is accused of disparaging comments against people raising their voices against attacks on Palestinians.

South Africa is among a handful of African countries maintaining diplomatic ties with both Israel and Palestine. Yet, it has strongly advocated for Palestinian freedom and has called for a two-state so-

at the University of South Africa, commenting on the S African government's response told Anadolu news agency that S Africa and Palestine have had historic relations for decades and that it is important for them to support the Palestinian cause for freedom.

"Palestine was with South Africa during the struggle against apartheid, while Britain and America never supported us but they were ever supporting Israel. This context is important," he told Anadolu. Teffo also said South Africa has been consistent in supporting Palestine over the years.

Dirk Kotze, another professor of politics at the same university, told Anadolu that South Africa's ruling African National Congress (ANC) has had historical links with the Palestine Liberation Organisation (PLO) since the time of late antiapartheid hero and first Black South African President Nelson Mandela, Siyabulela Mandela, the great-grandson of Nelson Mandela in an interview said that despite South Africa being liberated from the senseless violence and oppression, he (Nelson) was able to recognise the fact that our freedom is not complete until the people of

Siyabulela, an independent con-

sultant on human rights, peace and conflict resolution, and spoke with Global National's Farah Nasser while in Toronto where he was interviewed on stage at the Journalists for Human Rights annual gala. Mandela said that his greatgrandfather, the first Black presi-

dent of South Africa, was considered idealistic for thinking that there was a solution to apartheid in his country and people would consider it a miracle if it happened - and then it did.

Meanwhile last week, President Cyril Ramaphosa joined a growing chorus of international voices against what many has termed "the genocidal operation" of the IDF in Gaza.

The SA Parliament also last week debated whether to cut diplomatic ties with the Jewish state. Leading parties in parliament, notably the ruling ANC and the third largest party, Economic Freedom Fighters (EFF), favour cutting diplomatic ties with Israel.

In recent years, human rights organisations and legal experts have increasingly described Israel's policies toward Palestinians as apartheid, adding to a longstand-

ing debate about whether this is an accurate way to categorise the country's practices. Human rights groups have ar-

gued that the Israeli government's policies on land access, restrictions on movement, and limitations on the right to vote meet the ICC's standard and that it has institutionalised racism against Palestinians in order to ensure Israeli Jews remain the dominant group across Israel and the occupied Palestinian territories (OPT), which includes the West Bank and Gaza. Israel and its allies, including the U.S. and the European Commission, have rejected this assessment

Overall, it makes one wonder what is holding back the so-called Islamic states from taking any firm step against the Israeli aggression, like S Africa? Their own selfish interests and their lust for power, as most of them are monarchies and in no way are obligated to uphold the wish of their people, which recent demonstrations in some Arab states have shown. It would not be wrong to surmise that the current conflict has shown the leopard's true spots. (The author is a Delhibased senior political and international affairs commentator)

# Mahua Moitra's plight is testament to the kismet of women politicians in India

t a time when parliament finally passed a law reserving one-third of total seats for women in the House of the People and Legislative Assembly of every state, the targeting of MP Mahua Moitra under the guise of unsubstantiated charges is a reminder of how 'gender' and the 'performance of femininity' shape the life of women leaders across the political sphere.

Let's observe the statistics first. The Rajya Sabha has only 31 women among 239 total members and in the Lok Sabha, only 82 of the 539 members are women. When it comes to the Government of India, only 10 women find representation in Prime Minister Narendra Modi's 79-member council of ministers. out of which only two hold cabinet rank. The picture at the state level is bleaker, with the national average of women in state assemblies being around 9%. India's rank on the World Economic Forum's Global Gender Gap Index 2023 is 127 out of 146, with the country trailing beneighbours Bangladesh, Nepal and Sri

In the 2019 general election, out of the 435 candidates that the Bharatiya Janata Party fielded, 12.6% were women. Women constituted 12.9% of the total candidates fielded by the Indian National Congress. On the other hand, some regional parties' selection of women candidates was quite commendable. Of the total number of candidates fielded by West Bengal's All-India Trinamool Congress,

viewed as 'gender neutral' public institutions and political parties in India are exclusively 'for, by and of' men. Rather, 'masculinity' is the defining feature of Indian politics. On its own, the Women's Reservation Act, 2023 cannot enable greater political participation of women and their equal representation in parliament and politics.

In a 2021 book titled Women, Power, and Political Representation: Canadian and Comparative Perspectives, the authors have acknowledged that the introduction of gender quotas has improved women's participation in Canadian politics. However, Canadian women still face many informal and formal barriers not just when they seek to gain access to political power but also once they have gained that power. They have cautioned that, "women need not just be present in politics, but rather should have access to key positions of power where they can act as gatekeepers, agenda setters, and political insiders". The Moitra matter reinforces the same les-

Indian politics has constructed a sexual imagery of women leaders that primarily focuses on their character, physical appearance, dress, demeanour and family. They are closely watched and their performance minutely scrutinised. While their success is understated and mostly shoved under the carpet, their failure is wholly attributed to their gender.

Indian news reporting on women MPs like Moitra is pervaded by gendered perceptions of ambition, visibility, competitiveness, suitability and capability. Her association with a

Evidently, what are typically leading businessman and fight ter, where she was not allowed to with an ex-lover over Henry, their pet dog, have become more newsworthy than her attendance and performance in parliament. Conversely, her participation in parliamentary debates, the type of questions she has raised, and the veracity of her criticisms of the kleptocratic tendencies of the ruling dispensation have been largely ignored.

None of those pillorying Moitra have bothered to analyse how many of questions she has raised in Parliament have a direct link with her businessman friend, Darshan Hiranandani, whose office staff helped her upload those questions. When it is common practice for MPs to share their login details and even one-time-passwords (OTPs) with personal assistants, office staff, policy clerks, interns and others – the authors and almost all LAMP fellows who have worked with MPs from different political parties will easily vouch for this fact - why is Mahua Moitra being singled out?

The Lok Sabha Ethics Com-

mittee, which was established in 2015 to oversee the moral and ethical conduct of members and examine cases of misconduct referred to it, has been operating without a proper written 'Code of Conduct for Members of Lok Sabha' and a mandatory 'Declaration of Members' Business Interests'. It is highly probable that in the absence of these two important documents, the committee can cherry-pick cases involving MPs from opposition parties while going easy with ruling party members. Further, the committee can also conduct hearings without following a fair, just and impartial procedure – as was seen in the Moitra mat-

cross-examine those who had levelled grave charges against her. This violates the norms of natural justice in a constitutional democracy.

It has not escaped anyone's notice that the committee has been super swift to investigate Moitra's alleged association with Hiranandani. On the other hand, its response has been extremely tardy with respect to the conduct of BJP MP Ramesh Bidhuri who made communal and sexist comments against several MPs including Danish Ali, a member of the Ethics Committee.

In order to avert sexual objec-

tification, increase their acceptability within politics and be 'likeable' among the masses, women leaders have taken to supposedly asexual, respectable and dignified titles like 'Didi' Mamata Banerjee (elder sister), 'Behenji' Mayawati (sister), 'Amma' Jayalalitha (mother). Even Moitra has chanted 'Jai Ma Durga' and invoked the powerful Hindu goddess on X (formerly Twitter) to fight off the attacks on herself from the BJP. We cannot forget that as a woman politician, she has to work overtime to not let the scandal blight her political career.

Unfortunately, there exists zero female sorority in Indian politics. Women politicians do not get the requisite support from peers in their own political party, nor are formal institutional mechanisms available to check misogyny and bullying. When the Ethics Committee quizzed MP Moitra about her private life, none of the women members of the committee responded. Women leaders find it extremely difficult to support their ilk across party lines because they

der identity and political differences. Explaining the reality of female misogyny, feminist writer Chimamanda Adichie has commented, "[A]nd there are many women in the world who do not like other women." This is writ large in Indian politics.

Ireland's landmark 2009 report on 'Women's Participation in Politics' has found that factors such as 'less confidence', 'gendered culture' and 'gender bias in political parties' in candidate's selection procedures' adversely affect women politicians. Particularly in India, because the Parliament, state assemblies and political parties are mainly led and run by men, the culture of behaviour and the informally accepted norms of language, views and expressions render the political sphere unsuitable for women.

Moitra walked out of the Ethics Committee's meeting as a mark of protest and lashed out against the committee's unfair procedure, manner of investigation and content of the questions. While people were left aghast at her audacity, the ruling dispensation has called her remarks 'explosive'. Kimberle Crenshaw's words can be used to describe the Indian society for which "saving honour from shame is a priority. Unfortunately, this priority tends to be more readily interpreted as obliging women not to scream rather than obliging men not to

## Shraddha Walkar murder: Stop isolating women in interfaith relationships her day-to-day work, she counsels

The last time Shraddha Walkar's father Vikas Walkar spoke to her was in mid-2021, over the phone. This was almost a year before she was murdered, allegedly by her live-in partner Aaftab Amin Poonawala in May 2022 in Delhi's Chhatarpur. The murder came to light several months later in November 2022.

Speaking to The Quint, Vikas said, "I didn't approve of the relationship because his religion is different from ours." Shraddha Walkar was practically cut

off from her family, who claim to have no idea that she was in an abusive relationship. Her friends, on the other hand, knew about Aaftab's alleged assaults until all communication stopped in mid-May this year.

Details about how Shraddha's body was allegedly chopped into 35 pieces and disposed of across Delhi emerged on 14 November, two days after the accused – 28-year-old Aaftab – was arrested by the Delhi Police. In its 6,600-page-long charge sheet in relation to case, accessed by The Quint earlier in February, the Delhi Police wrote:

...Tortured and tormented Shraddha decided to break up with the accused several times but she could not because she had no support system and she was largely banking on the accused, or rather, she was at no return point."

How did no one try to reach Shraddha since May?

"This is very common for women in interfaith and inter-caste marriages. They are cut off, practically disowned by their families, making it more difficult for them to not only speak about their abuse but also seek help." - Kavita Krishnan, Feminist Activist & Author, told The

Feminist activists say that while abuse is the responsibility of the abuser, one must not forget how silence and isolation enable the person, leading to brutal incidents like the Shraddha Walkar case.

"In this case, the father had not spoken to her for over a year. There are families - irrespective of their educational and financial background – who do not talk to their daughters for years because they got married or is in a relationship they do not approve of. Where do women go in such a situation, when there is a complete lack of support system?" - Shabnam Hashmi, Social Activist and Human

Rights Campaigner Internalised guilt & 'I told you so' It is harder for women in interfaith and inter-caste relationships to seek help against domestic abuse, because in most cases, the family 'verbally disowns'

"Even if they do not disown and merely disapprove of her relationship, she will still hesitate to complain about her partner for fear it will confirm their

prejudices," Kavita Krishnan elaborated Then, there is the internalised guilt. "Survivors of abuse – in marriages and relationships that do not conform to the so-called societal norms – hesitate to even talk about it or consider their op-

tions because they chose their partner despite all odds. They want their family and friends to be there for them, not say 'I told you so,'" Krishnan told The Quint. Shraddha's 59-year-old father, too, had a similar response.

"I told her not to live with him. Yeh galat hai. I told her to not take this relationship forward.... Nahi toh biraadari se baahar nikal jao. She didn't listen to me."

A Delhi Commission for Women counsellor, who works on the ground in north Delhi, noted that isolation is ex-

women in distress, including those in interfaith and inter-caste relationships

"From what I have seen, men who are abusive want their partners to be isolated, because they know that no one will notice signs of emotional and physical abuse. For example, in Shraddha's case, Aaftab would have known that no one would try to reach out to Shraddha immediately - neither her family nor her friends because she was cut off from them. She actually took a very hard decision to stay, because she had no other choice. It makes abusers emboldened,

This is true, asserted Hashmi.

"The first thing that an abuser wants is to cut off the woman's relationship with her mother. When men know that their partner is being watched, that she might tell her parents who will stand up for her, or that she might reach out to helplines, they are more cautious. This is why the first thing any abuser wants to do is to cut off his partner's communication lines. It is the first red flag.

Self-doubt about their decisionmaking

Madhubala, a feminist activist, who was working with Jagori NGO, explained that apart from the internalised guilt, women in such marriages also develop self-doubt over their decisionmaking.

"I don't want to mince my words but our society is casteist, communal, and anti-women. It does not like it when women go beyond the role defined for them. And, when women do not conform to it, like by choosing their partner, families make two things clear – You do not belong to us, you are on your own," Madhubala said, adding that, when the relationship turns abusive, the survivors start questioning themselves and not their partner."

"I have seen multiple cases where the families say - 'Dekĥa tumne yeh decision li. Hum the tumhare saath, ab kaun hai? Do you really think you can stand on your own?' But women just want to hear that their families are with them and that they can come back to their parents or friends' homes in such a situation. I cannot stress enough how emotionally taxing it is for women to come out with their stories." - Madhubala to The Quint

Hashmi added, "There is a very small fraction of families in India that tell women that it is their right to live with

'Demand better': What can be done?

Feminist activists say that we, as a society, must demand better - put the interest of women and survivors ahead of the political issue of communalising interfaith relationships.

"Not just domestic abuse, women who are in 'love marriages' or 'relationships' hesitate to even say that their partner is alcoholic or their marriage ingly becoming toxic. If parents and communities make it clear to women and stand with them, it will make a difference," Krishnan said.

"Whether it is the state government or the central government, put pressure on the elected representatives for sustained, non-judgmental and respectful justice."

"As someone who works with survivors of domestic violence, there are not enough shelter homes in the country. When we are working on the rehabilitation of one survivor, activists do not have the resources to work on another. There are times when we take survivors to our homes and offices because they have nowhere else to go. The system has completely let down women, and is not doing much to fix it." - Shabnam Hashmi to The Quint

"The issue is not men from one community being abusive towards women from another community. Making this the focus simply surpasses the actual cause," added Krishnan. (Courtesy: The

# Can transgender women have a period?

ransgender women do not experience typical menstrual periods. However, people may experience physical and emotional symptoms similar to premenstrual syndrome and premenstrual dysphoric disorder.

Transgender women may undergo gender-affirming treatment, such as hormone therapy. As a side effect of hormone therapy, they may experience symptoms similar to those of premenstrual syndrome (PMS) women or premenstrual dysphoric disorder (PMDD).

While some symptoms of PMS and PMDD are physical, others are emotional or psycho-

In this article, we discuss whether trans women can experience symptoms similar to those of PMS. We also look at the symptoms that can result from hormone therapy and provide tips on how to track them.

The United Kingdom's National Health Service (NHS) states that a period is the part of the menstrual cycle in which blood, comprising uterine lining, leaves the body. People who do not have ovaries and a uterus do not experience periods.

However, PMS and PMDD are terms that refer to the physical and emotional symptoms that people may experience before their period begins. These conditions occur due to fluctuations in hormones.

The symptoms of PMDD are similar to those of PMS but are

more severe. Transgender women can transition in a variety of ways. One way that a person may transition is through the use of gender-affirming hormone therapy.

Transgender women who undergo hormone therapy may take oral, transdermal, or injectable versions of estrogen. They may also use anti-androgens, such as progesterone.

The anti-androgen that healthcare professionals most commonly prescribe spironolactone, although they may also prescribe progesterone.

Hormone therapy for transgender women aims to help alleviate gender dysphoria in

several ways, including: changing how the body distributes fat

· promoting breast growth · reducing male pattern hair growth

Estrogen can affect the body in various ways, and transgender women may experience several side effects while taking supplemental estrogen. Progesterone can also cause side effects.

It is important to advocate for inclusivity as an ally. Working with and listening to those who are transgender can help people come up with suggestions to make schools, workplaces, and other areas more inclusive.

Be open to education Allies do not know everything there is to know about people who are transgender. They should always be open to learning more from transgender peowho will have more knowledge than them of certain

An ally should never assume that they know more about trans health and trans life than a person who is transgender. Summary

Transgender women may experience physical, emotional, and psychological symptoms similar to those of PMS if they use hormone therapy. Hormone therapy can have multiple side effects, such as breast tenderness and rapid changes in mood.

People can track their symptoms in a variety of ways. Doing this may help them recognize when certain symptoms are unusual for them.

DEIR AL-BALAH (GAZA STRIP), Nov 21: Israeli troops battled Palestinian militants in an urban refugee camp and outside the gates of a nearby hospital on Tuesday as the army expanded operations across northern Gaza, where residents have been without electricity, water or access to humanitarian aid for weeks.

The front line of the war, now in its seventh week, has shifted to the Jabaliya camp, a dense warren of concrete buildings near Gaza City that houses refugees from the 1948 war surrounding Israel's creation and their descendants

Israel has been bombarding the area for weeks, and the military said Hamas fighters have regrouped there and in other eastern districts after being pushed out of much of Gaza

Fighting has also intensified outside the Indonesian Hospital on the outskirts of Jabaliya, where a strike killed 12 people on Monday. Health officials said on Tuesday that hundreds of patients and displaced people are trapped inside with dwindling supplies after some 200 were evacuated the day before.

The war sparked by Hamas surprise October 7 attack into Israel has exacted a heavy toll on Palestinian civilians, particularly those who remain in the north after Israel repeatedly called on people to flee south.

It's unclear how many people remain in the north, but the UN agency for Palestinian refugees estimates that some 160,000

people are still in its shelters there, even though it is no longer able to provide services. Some 1.7 million Palestinians, about three fourths of Gaza's population, have fled their homes.

Hundreds of thousands of displaced people have packed into UN-run schools and other facilities across southern Gaza. As the shelters have overflowed, people have been forced to sleep on the streets outside, with little shelter from winter rains that have hit the region in recent

Across Gaza, there are shortages of food, water and fuel for generators to power basic infrastructure. There has been a territory-wide blackout since Israel cut off fuel imports at the start of

Israel continues to strike what it says are militant targets across Gaza, including in the southern evacuation zone, often killing women and children, and officials have said it may soon expand its operations in the south.

A similar standoff has played out in recent days at Shifa Hospital, Gaza's largest, where over 250 patients and medical workers are stranded after the evacuation of 31 premature babies.

Israel has provided some evidence in recent days of a militant presence at Shifa, where its troops have been operating since last week. But it has yet to substantiate its claims that Hamas had a major command centre beneath the facility, allegations denied by Hamas and hospital

Michael Ryan, a senior World Health Organisation official, said Monday that care for complex medical cases - including most cancer and kidney dialysis patients – is no longer available in Gaza and that remaining hospitals would likely be overwhelmed by some 5,500 births expected in the next month.

The hospital situation – the primary health care system situation – in Gaza is catastrophic," he said. In the north, "it is the worst you can imagine."

More than 12.700 Palestinians have been killed in Gaza, according to the Palestinian Health Ministry in the West Bank. Officials there say another 4,000 are missing. Their counts do not differentiate between civilians and combatants. Israel says it has killed thousands of mili-

The Palestinian Health Ministry bases its count on information gathered by its counterpart sualty figures for more than 10 days because of the breakdown in services and communications in the north.

About 1,200 people have been killed on the Israeli side, mainly civilians during the October 7 attack, in which Hamas dragged some 240 captives back into Gaza. The military says 68 Israeli soldiers have been killed in Gaza ground operations.

The military said forces are "preparing the battlefield" in the area of Jabaliya. It said they struck three tunnel shafts where fighters were hiding and destroyed rocket launchers. Footage released by the military shows Israeli soldiers patrolling on foot as gunfire echoes around

Residents said there had been heavy fighting as Israeli forces tried to advance under the cover of airstrikes. "The (Israeli) occupation is trying to besiege the camp," said Hamza Abu Mansour, a university student. "They are facing stiff resistance."

It was not possible to independently confirm details of the fighting.

Military footage from other areas in the north in recent days has shown widespread destruction, with nearly every building appearing to be damaged or destroved.

Israel, the United States and Qatar, which mediates with Hamas, have been negotiating for weeks over a hostage release that would be paired with a temporary cease-fire and the entry of more humanitarian aid. (AP)

TOKYO, Nov 21: North Korea told Japan on Tuesday that it will launch a satellite in the coming days in violation of UN resolutions, its apparent third attempt to fire a military spy satellite that drew immediate rebukes from its neighbours.

North Korea is eager to operate spy satellites to deal with what it calls escalating US-led military threats. But its two previous attempts to place a spy satellite into orbit earlier this year ended in failure due to technical issues.

Japan's coast guard said North Korea notified Tokyo of its plan to launch a satellite sometime between Wednesday and November 30. The notice identified three maritime zones where debris from the rocket carrying the satellite may fall. Two are in the waters between the Korean Peninsula and China and the third in the Philippine Sea, Japanese coast guard spokesperson Kazuo Ogawa said.

Ogawa said the areas are the same as the ones North Korea identified for its failed satellite launches in May and August, implying the third attempt would have a similar flight path. North Korea has given Japan the launch information because Japan's coast guard coordinates and distributes maritime safety information in East Asia

The North's notification came a day after rival South Korea warned it to cancel its launch or face consequences. South Korea's military suggested Seoul would suspend a 2018 inter-Korean agreement to reduce tensions and resume front-line aerial surveillance and live-firing drills in response to a North Korean satellite

UN Security Council resolutions ban any satellite launches by North Korea because they are seen as a cover for testing its missile technology. North Korea says it needs a space-based surveillance system to better monitor its rivals, but South Korea says the North's launches are also designed to enhance its long-range missile

Since last year, North Korea has carried out about 100 missile tests as part of its



efforts to modernise its arsenal of nuclearcapable weapons targeting the United States and its allies. Many foreign experts say the North still has the few remaining technological hurdles to overcome to possess functioning nuclear-tipped missiles.

Japanese Prime Minister Fumio Kishida asked officials to coordinate with other countries to ask North Korea to cancel its launch. He said Japanese destroyers carrying Aegis-class radars and PAC-3 missile defence systems on Okinawa have been activated to stand by in case of an unexpected development.

"Even if the purpose is to launch a satellite, if ballistic missile technology is used, it is a violation of the United Nations Security Council resolutions, and this is a matter that greatly affects the safety of the people," Kishida said.

During trilateral phone talks, senior officials from Japan, South Korea and the US affirmed their cooperation to "strongly request North Korea to cancel" its launch plan, according to Japan's Foreign Ministry. South Korea's Foreign Ministry separately urged North Korea to withdraw the launch plan immediately, saving that Seoul will sternly deal with "an illegal provocation by North Korea" in close coordination with Washington

After the second launch failure, North Korea had vowed a third attempt would take place in October, but failed to follow through. South Korean officials said the delay was likely because North Korea is receiving Russian technology assistance.

# Polish police arrest woman with Islamic extremist sympathies who planted explosive device in Warsaw

WARSAW, Nov 21: Polish authorities say that they have arrested and pressed charges against a 38-year-old Polish woman with Islamic extremist sympathies who planted an explosive device on a street in central Warsaw earlier this month. There were no

Police said in a statement published on Monday that the woman placed the device in Warsaw on the night of Nov. 10-11 and then took a train back to her home in western Poland.

Nobody was hurt, but the device had the potential to hurt many people, police said. 'The makeshift explosive device filled with gas containers and nails could have caused a serious threat to the health and

lives of many people," the statement said.



It added that she was charged with "causing danger and bringing danger to the life and health of many people, as well as prepara-

tion for causing such danger." Police used CCTV footage to track her movements. After planting the device in Warsaw, she headed to the central train station in the capital and then traveled to the western Polish city of Wroclaw, and was arrested at her home in the nearby town of Strzelin.

Police described the suspect as a Polish woman interested in Middle Eastern affairs, but wouldn't give any more details about her. They released a video showing police fingerprinting and handcuffing her, and also showed some of the objects they said they found in her home. Among them was an image of Osama bin Laden.

"Police officers secured items and gadgets related to the Islamic State, as well as items that could have been used to construct another explosive device," police

The G20 virtual summit will take forward key outcomes and action points firmed up at the annual conclave of the grouping in September under India's presidency, the Ministry of External Affairs (MEA) in New Delhi said in a statement.

The summit will also delve into the impact of the Russia-Ukraine war and the Israel-Hamas conflict. It is also expected to push for the effective implementation of various decisions taken at the bloc's annual summit in New Delhi over two months back, the statement said. Li will attend the meeting at the invitation of the Indian government, China's Foreign Ministry Spokesperson Mao Ning told a media briefing, state-run Xinhua news agency re-

Leaders of all G20 Members, including the Chair of the African Union, as well as nine Guest countries, and Heads of 11 International Organisations, have been invited to attend the virtual summit. India hosted the G20 Summit in New Delhi on September 9-10.

India holds the G20 Presidency until November 30, 2023. The G20 Troika during the Brazilian G20 Presidency in 2024 will comprise India, Brazil, and South Africa. (PTI)

ISLAMABAD, Nov 21: A two-member panel of Islamabad High Court on Tuesday reserved the judgement on an intra-court appeal by Pakistan's former premier Imran Khan against his jail trial in the cipher case.

A single-judge bench of the same court had earlier turned down the Pakistan Tehreek-e-Insaf (PTI) chairman's appeal against his trial in the Adiala Jail in Rawalpindi. The 71-yearold former premier has been kept in the Adiala Jail since September 26 when he was shifted there from the District Jail in Attock.

The IHC panel of justices Miangul Hassan Aurangzeb and Saman Rafat Imtiaz heard the intra-court appeal and reserved the judgment after completing the hearing process.

The panel is expected to announce its judgment at 5:30 pm on Tuesday. The cipher case is about the allegations that Khan and his foreign minister Shah Mahmood Qureshi March last year violated the secret laws of the country while handling a communication sent by Pakistan's embassy in Washington.

The duo was indicted on October 23 and their formal trial has already begun with the recording of statements by witnesses.

The Islamabad High Court (IHC) had upheld the indictment when challenged by the cricketer-turned-politician. However, the IHC had stayed the trial until adjudication on the intra-court appeal. (PTI)

## **Argentina's president-elect** wants public companies in private hands, with media first to go

BUENOS AIRES, Nov 21: Argentina's right-wing president-elect gave the first indications on Monday of how he plans to start shaking up South America's second-largest economy: with a slew of privatisations.

Populist Javier Milei, a libertarian economist and self-described "anarchocapitalist", won a presidential runoff election on Sunday with 55.7 per cent of the vote.

He said on Monday that he would move quickly to privatise the country's state-owned media outlets and look to do the same with other public companies.

"Everything that can be in the hands of the private sector will be in the hands of the private sector," Milei told Bueno Aires station Radio Mitre.

Experts immediately questioned how far Milei would get in fulfilling that vision without the support of Argentina's National Congress, where his party holds a relatively small share of seats. However.

analysts said his resounding election victory could give him leverage.

"The decisiveness of the victory — a doubt until yesterday — allows him to signal to all parties who is in control of the transition and the formation of the Cabinet," said Mariano Machado, principal analyst for the Americas at Verisk Maplecroft, a global risk intelligence firm. In his radio comments. Milei described the public media outlets he wants to make private as amounting to "a covert ministry of propaganda".

He complained during the presidential race that the coverage of his campaign in state-run outlets was highly negative.

Milei also signalled that he intends to act on some of his most controversial ideas from his campaign for slashing the size of the state and reining in Argentina's triple-digit inflation. They include reducing the number of government ministries by half, to eight.

He said he still wanted to close the Central Bank of Argentina, calling it "a moral decision", but appeared to put his plans for replacing the local currency, the peso, with the US dollar on the back

"In conceptual terms, the central axis is to close the Central Bank, and subsequently, the currency (will be) whichever one Argentines choose freely," he said, characterising a potential change in the national currency as "a second-order

Milei predicted it would take him up to half of his presidential term — "between 18 and 24 months" — to decrease

inflation, which polls showed was the biggest concern for Argentine voters as consumer prices have increased 140 per cent over the past year.

# Taylor Swift's Rio tour marred by deaths, muggings and a dangerous heat wave

deaths of two people, muggings and a dangerous heat wave left legions of Taylor Swift's Brazilian fans angry and disappointed in the threeday Rio de Janeiro leg of the pop superstar's Eras Tour, which concludes on Monday night.

Gabriel Mongenot Santana Milhomem Santos, 25, a fan who had travelled from the country's centerwest region to see Swift, was stabbed to death on a Copacabana beach about 3 a.m. on Monday, Rio's police said in a statement.

It was the second death of a Swift fan in four days. On Friday, 23-year-old Ana Clara Benevides Machado fell ill during the singer's first show in the city, and died later that evening at a hospital. Fans also reported fainting from

extreme heat, being mugged or getting caught up in a police raid. Rio's Municipal Health Department said Benevides, who, accord-

ing to a friend, passed out during Swift's second song, "Cruel Summer," experienced cardiorespiratory arrest, but the exact cause of her death is not vet known. Rio's Forensic Medical Institute

examined the body on Saturday and said additional laboratory tests had to be conducted, the online news site G1 reported.In a statement posted on Instagram, Swift said Benevides' death left her with a "shattered heart." Before the show on Friday, fans

lined up for hours outside the Nilton Santos Olympic Stadium where temperatures soared to 41 degrees Celsius (105 Fahrenheit), with a heat index of nearly 59 C (138 F). Inside the stadium, concertgoers complained of unbearable heat and some said they had difficulty getting access to water.

"I didn't imagine that my dream could turn into a nightmare," said fan Kléssia Menezes, who told R7



hundreds of other people on one of the ramps to a VIP area Saturday as security officers blocked the entrance.Once security let them through, she said, people started running and she fell on a hot metallic floor that burned her leg and

"They took me to the doctor ... and I saw that I wasn't the only person to have fallen in this chaos," she said. "Many people fell and burned themselves.

Ultimately, that night's show was postponed, after tens of thousands of fans had spent hours lining up in the heat. Swift announced on Instagram that it was necessary "due to the extreme temperatures in Rio."

A fan who identified herself as Julia Alvarenga said she was upset that Swift didn't decide to cancel earlier."My friend, can you see how much I'm sweating, how all the pores in my body are dilated from the sweat?" Alvarenga asked, visibly angry, in a video posted on X,

formerly known as Twitter. She then pointed to her waist, highlighting the extreme measures she had taken to attend a concert for which she knew she would stand in line for hours. "I'm wearing a diaper, a geriatric diaper," she says, urging the artist to appear. "Come on stage, I want to see you!"

The postponement was followed by chaos outside the stadium. Under a light rain, a mass of concertgoers left the area, which is close to one of Rio's working-class neighborhoods, known as favelas.

Videos shared on social media showed groups of pickpockets robbing fans of their belongings, scenes not so unusual to Rio residents, but far from the postcards many tourists have seen of the "cidade maravilhosa." Many took refuge inside a Burger King, ducking for cover under tables and behind the counter in the kitchen area.

# Men trapped in tunnel come on camera, rescue effort in Uttarakhand enters $10^{\text{th}}$ day

**Nov 21:** The first visuals of the 41 workers trapped inside Silkyara tunnel emerged Monday, raising hopes of families anxiously awaiting their evacuation as a multipronged rescue effort entered its 10th day.

The visuals were captured using an endoscopic camera sent in through a six-inch pipeline, which was pushed Monday through the rubble of the collapsed portion of tunnel on Uttarakhand's Char Dham route.

In a video released by the rescue agencies, the workers wearing yellow and white helmets, are seen receiving food items sent to them through the pipeline and talking to each other.

Officials watching them on a screen are heard giving instructions, asking them to clean the lens and show themselves on camera. They are heard asking them to come near the mouth of the pipeline and use the walkie-talkies, apparently sent down earlier.



Relatives have talked earlier to the trapped workers through the four-inch compressor tube that already existed. Food items like dry fruit were also being sent through

But the new wider 'lifeline', which pierced through 53 metres of rubble, has come as a boost to the morale of the rescue workers. Communication is much better and larger quantities of food can now

"I talked to him this morning," Sunita Hembrum, whose brotherin-law Pradeep Kisku is among the trapped labourers, told PTI. She has come to Silkyara from Banka

"Oranges have been supplied to them through the new food pipe. Efforts are also underway to send khichdi to them. He was fine," she said. "Earlier we had to shout to

his voice was clear," she said.

According to officials, food items like dalia, khichdi, sliced apples and bananas can be sent in through the new pipeline. Also, mobile phones and chargers could

also be sent to the workers. Prime Minister Narendra Modi spoke to Uttarakhand Chief Minister Pushkar Singh Dhami on Tuesday, the second day in a row, to enquire about the progress of the

On social media, Dhami said he informed the PM about communicating with the workers using the endoscopic camera. "The prime minister said it is our top priority to rescue all the workers safely," the CM posted.

The tunnel collapsed following a landslide early on November 12, leaving 41 workers trapped behind a huge mound of debris.

On Friday afternoon, efforts to drill through the debris with a huge auger machine received a setback when it encountered a boulder.

tion, which involves inserting sections of a steel pipe as the machine drills through, rescue agencies have begun work on a bunch of alternative plans.

These include drilling more than 80 metres vertically from above the tunnel to reach the two-kilometre built-up stretch where the workers are now confined.

Drilling from the other, Balkotend, of the tunnel is another alternative on which the rescue agencies are working. Drilling parallel tunnels is also being consid-

Some of the heavy machinery for these new approaches has reached the disaster site.

A road has also been constructed to haul up a 75-tonne machine up the hill to begin vertical drilling.

In Delhi, the government issued an advisory to private television channels, asking them to be sensitive in their coverage of the rescue operations. (PTI)

## Maharashtra BJP announces date for MTHL inauguration

MUMBAI, Nov 21: The BJP's Maharashtra unit has claimed that the Mumbai Trans Harbour Link (MTHL), touted as India's longest sea bridge, will be thrown open for public use on December 25, but the government agency implementing the project said although it is 97 per cent complete, the remaining work is not likely to get over by

The MTHL is a six-lane 21.8 km road bridge between Sewri (Mumbai) and Chirle (Navi Mumbai). The project, being implemented by the Mumbai Metropolitan Region Development Authority (MMRDA), will link south Mumbai with Navi Mumbai township. Once completed, it would be the longest sea bridge in India and would cater to 70,000 vehicles daily, officials said.

On Monday, the Maharashtra unit of the Bharatiya Janata Party (BJP) said on X that the "Atal Bihari Vajpayee Sea Link" will be inaugurated on December 25 this year, on the birth anniversary of the late prime minister after whom it is to be

However, when contacted, an MMRDA source said, "The construction work of the sea link is nearly 97 per cent complete. But the work of electrification, erection of poles on the bridge, toll booths and integration of the entire system is yet to be done."

"Some of the work orders for erecting polls and others were issued in June this year. The project cannot be completed by December this year," the source said. Prime Minister Narendra Modi had laid the foundation stone for the project a few years back. The work was partially affected during the Covid-19 pandemic.

Although the ruling BJP has announced the date of the MTHL inauguration, the Maharashtra government has not made any announcement about its inauguration yet.

In May this year, chief minister Eknath Shinde and deputy CM Devendra Fadnavis visited the MTHL and drove a vehicle on the bridge, also known as the Sewri-Nhava Sheva Trans Har-

#### BJP urges EC to act against Congress for 'misleading' ads, resorting to 'corrupt' practices

**NEW DELHI, Nov 21:** The BJP on Tuesday accused the Congress of putting out advertisements in the form a news or opinion piece about a wave in its support in the Rajasthan assembly polls and demanded action from the Election Commission against the state's rul-

A BJP delegation, which included Union minister Mansukh Mandaviva and former minister Ravi Shankar Prasad, moved the EC with complaints against the Congress as they also charged the party with resorting to "corrupt" practices by asking people to give missed calls on a mobile number to get benefits of its guarantees if it retains the power in the state.

"A registered number was generated for the caller, creating an impression that only the caller would benefit by voting for a particular candidate or party, specifically the Congress party," the party delegation, which also included its IT department head Amit Malviya and another leader Om Pathak,

The Congress inserted this ad-

Ashok Gehlot also posted on X about it, their complaint said.

Mandaviya told reporters that this creates a narrative that only those who register themselves will get the benefits and others will not, and added it aims to mislead vot-

Prasad highlighted the BJP's another complaint which noted that the Congress issued Hindi advertisements in a couple of leading dailies about its "lahar" (wave).

The manner in which it was put out made it a deliberate attempt to make an impression in the minds of voters that it is a news/opinion published after a survey.

"It is a violation of the Model Code of Conduct and also the Press Council of India's guidelines on advertisement," he told re-

"The said advertisement is false, frivolous and wholly unverified, contrary to the actual facts and statistics available on record," the BJP's memorandum to the EC said and demanded stringent action, including FIR, against the Congress. It also sought action against the

The EC should direct the Congress to issue a public apology and put out in the same space a clarification to the effect that there is no wave in the party's support, it said.

"We also requested the EC to issue guidelines to ensure that such an incident is not repeated in future polls," Prasad said.

Hitting out at the Congress for its missed call advertisement, the BJP's memorandum said, "That giving a missed call and in return the caller is assigned with a registration number, which amounts to like distributing of coupons to the voters, that is an extreme corrupt

The Congress has violated the provisions of the Indian Penal Code and electoral laws besides the Model Code of Conduct, the

Seeking an FIR, the BJP urged the EC to immediately stop Ashok Gehlot and his party from publishing or disseminating "misleading" advertisements. The commission should issue an advisory to voters about such malpractice and exhort them to not fall prey to it, the party

# Stalin lauds late Jayalalithaa for designating CM as TN music varsity's chancellor

ter M K Stalin on Tuesday praised former chief minister late J Jayalalithaa for naming the CM of the day as chancellor of the state-run music and fine arts university.

Addressing the second convocation of The Tamil Nadu Dr J Jayalalithaa Music and Fine Arts University here, Stalin said it is the one and only university in the country set up for music and that is its unique feature

Only in this state-run varsity in Tamil Nadu is the chief minister the chancellor -- a special feature that distinguishes it from other institutions, he pointed out.

Fully funded by the state government, the Tamil Nadu Music and Fine Arts University was established in 2013 when Jayalalithaa was the chief minister. She was also the varsity's first chancellor. Later, the university was named after Jayalithaa in 2019, three years after her death, by the AIADMK regime at the time.

Stalin, stating that he is not "talking politics" but only "spelling out a fact", said an institution can grow only if the CM functions as chancellor -- seemingly expressing opposition to the Governor's position as chancellor of universities.

If the post of chancellor is held by "others", the very purpose of achieving growth would be defeated, the chief minister opined, adding that



former chief minister Jayalalithaa considered this and decided that the CM of the day shall be the music varsity's chancellor -- and implemented it accordingly.

"We can wholeheartedly appreciate her (Jayalalithaa) for this. Considering the present situation, I too heartily laud her," he said.

At the convocation ceremony, the university conferred honorary doctorates on iconic playback singer P Susheela and noted music historian B M Sundaram. Pointing to the awarding of the doctorates,

Stalin said he could take such decisions reflecting the wishes of the people, as he is the varsity's chancellor. That is why we say that the chief minister

should be the chancellor of all (state-administered) universities. For this purpose, we have passed bills in the assembly," the chief minister

said, and added that related matters are before the Supreme Court.

The Tamil Nadu government had recently approached the Supreme Court over files and bills, "kept pending" by Governor R N Ravi.

Stalin said that education must be brought under the state list from the present concurrent list, as allocated in the Constitution, reiterating his stand on the issue. Only then, states can achieve the goal of education and higher education for all, he said.

"I am not saying this only for the sake of Tamil Nadu; but this is for all the states in India," he said, adding that hindrance-free access to education for all is the ideal of the Dravidian model of governance.

Stalin announced that the state grant for the music varsity would be increased to ₹ 3 crore from the next fiscal and an allocation of ₹ 1 crore for purposes including a research centre would be provided.

On 18 November, 2023, the Tamil Nadu assembly re-enacted bills returned by Governor Ravi and sent them again to Raj Bhavan.

The ruling DMK is batting for designating the chief minister as the chancellor of state government-run universities. The governor is at present the chancellor of state varsities, barring the music university. (PTI)

# Climate change hits women's health harder

in its alliance with the UDF.

NEW DELHI, Nov 21: Manju Devi suffered in pain for two months last year as she worked on a farm near Delhi, unable to break away from duties that sometimes had her standing for hours in the waistdeep water of a rice paddy, lifting heavy loads in intense heat and spraying pesticides and insecticides.

When that pain finally became too much to bear, she was rushed to a hospital. The doctors' verdict: Devi had suffered a prolapsed uterus and would need a hysterectomy. She hadn't said a word to her family about her discomfort because of societal taboo over discussing a "women's illness," and with two grown children and three grandchildren looking to the 56year-old widow to help put food on the table, Devi had relied on painkillers to stay in the fields.

"I endured excruciating pain for months, scared to speak about it publicly. It shouldn't take a surgical procedure to make us realise the cost of increasing heat," she said, surrounded by women who told of undergoing a similar ordeal.

As the annual UN-led climate summit known as COP is set to convene later this month in Dubai, activists are urging policymakers to respond to climate change's disproportionate impact on women and

girls, especially where poverty makes them more vulnerable

Their recommendations include securing land rights for women, promoting women's cooperatives, and encouraging women to lead in developing climate policy. They also suggest that countries especially developing countries like India - commit more money in their budgets

to ensure gender equity in climate poli-

A Group of 20 leaders who met in New Delhi in September also recognised the problem, calling for accelerating climate action with gender equality at its core by increasing women's participation and leadership in mitigation and adaptation. Devi is a farm worker in Syaraul, a village of about 7,000 a couple of hours southeast of Delhi in Uttar Pradesh, one of India's

biggest and most populous states. Several other middle-aged and older women from the village described similar injuries leading to hysterectomies.

The link between phenomena like uterine prolapse and climate change is indirect but significant, said Seema Bhaskaran, who tracks gender issues for the nonprofit Transform Rural India.

"Women in rural, climate-affected communities often bear the brunt of physically demanding agricultural work, made more strenuous by climate change-related challenges like erratic weather and increased labour needs," Bhaskaran said.

"While climate change doesn't directly cause uterine prolapse, it magnifies the underlying health challenges and conditions that make women more susceptible to such health issues."

About 150 km away in Nanu village, 62-year-old farm worker Savita Singh blames climate change for a chemical infection that cost her a finger in August 2022. When her husband moved to Delhi to work as a plumber, she was left alone to tend the couple's fields.

As rice and wheat yields fell due to shifting climate patterns and a surge in pest attacks, Singh's husband, who retained decision-making power, decided to increase the use of pesticides and insecticides. It was up to Singh, who had opposed the increases, to apply the chemicals.

"With the rise in pest attacks in farms, we have started using more than three times pesticides and fertilisers in our farms and without any safety gear my hand got burned by the chemicals and one of my fingers had to be amputated," she said. (PTI)

# Relations with CM 'very cordial'; conflicts can be resolved: Bengal Guv

KOLKATA, Nov 21: West Bengal Governor Dr CV Ananda Bose said he shares a "very cordial" relationship with chief minister Mamata Banerjee and hasn't faced any difficulties while working in the state. Bose, who completed a year as the governor on Tuesday, said his priority is the well-being of the people of the state.

"I see the governor-CM relationship in two levels. As individuals, our relation is very cordial which is based on mutual respect and understanding. As far as the relationship between the governor and the CM is concerned, the perception may be different because the elected chief minister and the nominated governor need not necessarily think alike on every issue," Bose told PTI in an interview at the Rai Bhavan here.

"My role as the governor is upheld in the Constitution. I work for the well-being of the people. When we apply the yardstick of constitutional propriety, certain actions of the government, not only this government, may be found to be wanting. There the governor has to step in. That may lead to apparent conflicts. But conflicts can be resolved because our constitutional democracy has the inner strength to reconcile conflicts," Bose added.

"I haven't faced any difficulties in working as the governor here. I have been a civil servant. I have



worked with various political parties. I go by what is right, what is proper, what is ethical, what is good. I have my own standards and those are not my subjective standards, but objective because they are based on the Constitution, the law of the land," he added.

On ruling Trinamool Congress' allegations that he is running a parallel administration from Raj Bhavan and interfering in the state's affairs, Bose said, "In a democracy, anyone can express their views freely, frankly and fearlessly. The governor's views need not necessarily be of the government. Such dichotomy is natural to democracy. I go ahead which I think is right, legal, and constitutional. That's my approach.

"In a democracy, criticism should be there. Somebody should be there to hold a mirror before you. I do not think that criticism should be shunned. Criticism is good and it should be welcomed. That's the beauty of democracy, I

welcome it." On allegations that the state's failure to contain the law and order prompted the governor to open the "anti-corruption cell" at Raj Bhavan, Bose referred to hundreds of petitions alleging corruption on various issues pouring in at his of-

"There is no question whether the state government has failed or succeeded. There are certain aberrations in society and corruption is one of such. Action has to be taken namic process," he added.

On his priorities as a governor in the years ahead, Bose said he would keep on working for the people of Bengal

"My priority is the people of Bengal. Whatever I can do for them, I will do. I will also offer constructive cooperation with the state government and uphold the principles of federalism. My next priority will be to translate into action PM Narendra Modi's vision of 'Atmanirbhar Bharat' also includes Atmanirbhar Bengal," he added.

On the state assembly passing the West Bengal University Laws (Amendment) Bill 2023 under which the chief minister shall, by the virtue of his/her office, be considered the chancellor of all stateaided universities, replacing the governor, Bose said the matter is sub-judice at the Supreme Court and would follow what the apex court decides.

"This issue is before the Supreme Court. Not particularly in respect of Bengal, but also in respect of some other states, the issue is the same. Whatever the Supreme Court decides, I will follow in letter and spirit. When and if I am the chancellor, I will exercise the powers of the chancellor without fear and favour. I will be a chancellor who does not leave things to chance," he said. (PTI)

NEW DELHI, Nov 21: The Enforcement Directorate (ED) on Tuesday said it has attached immovable assets and equity shares worth about ₹ 752 crore as part of its ongoing money laundering investigation against the Congresspromoted National Herald newspaper and companies linked

The provisional attachment order came as the elections in five states of Chhattisgarh, Madhya Pradesh, Rajasthan, Telangana and Mizoram are in progress and the counting of votes is scheduled to

be held on December 3. The Congress called the agency

action as "petty vendetta tactics" and dubbed the ED a "coalition partner" of the BJP which, it claimed, is staring at a certain defeat in the assembly polls.

The federal probe agency alleged in a statement that in this case the shareholders and donors of the Congress were "cheated" by the office-bearers of AJL and the party. A provisional attachment order has been issued by the federal probe agency under the Prevention of Money Laundering Act

(PMLA) against Associated Journals Ltd. (AJL) and Young Indian (YI). The National Herald is published by AJL and owned by Young Indian Private Limited. Congress leaders Sonia Gandhi and Rahul Gandhi are majority shareholders of Young Indian with 38 per cent shares held by each one of them.

In the statement, the ED said it has issued an order to provisionally attach properties worth ₹ 751.9 crore in the money laundering case being investigated under the PMLA. (PTI)

#### India donates USD 2.5

Earlier on November 19, India had delivered 32 tonnes of "humanitarian assistance to the people of Palestine" via the El-Arish Airport in Egypt. Since 2018, India has given USD 27.5 million to UNRWA.

During an Extraordinary Virtual Ministerial Pledging Conference for UNRWA held on June 23, 2020, India announced that it would contribute USD 10 million to UNRWA over the next two years.

Prior to the war in Gaza, UNRWA was already facing an increased demand for services resulting from a growth in the number of registered Palestine refugees, the extent of their vulnerability, and their deepening poverty. The agency is mandated to provide assistance and protection to some 5.6 million Palestine refugees registered with it across its five fields of operation.

Its mission is to help Palestine refugees in Jordan, Lebanon, Syria, West Bank, including East Jerusalem and the Gaza Strip achieve their full human development potential, pending a just and lasting solution to their plight. UNRWA services encompass education, health care, relief and social services, camp infrastructure and

improvement, protection, and microfinance among Palestinian refugees. During the first-ever Indian Prime Minister's visit to Palestine in February 2018, India increased its annual financial contribution fourfold to the UNRWA core budget, from USD 1.25 million to USD 5 million.

India has also made a strong appeal to other traditional donors of UNRWA to consider enhancing their contributions as well as to non-donor member states to consider contributing to the agency in solidarity with the

Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley. Tribals --Nagas and Kukis -- constitute little over 40 per cent and reside in the hill districts.

On the refugee crisis from Myanmar, Lt Gen Kalita said, "Any instability in our neighbourhood is not in our interest. It definitely impacts us as we share the common border. The problem of the Indo-Myanmar border gets accentuated because of the difficult geography and terrain conditions, and lack of development.' He further said as the border is porous and people are from the same ethnicity on both sides of the border, a lot

of free movements take place, and it becomes difficult for the forces managing the borders to identify who are the people from India and who are from Myanmar. "We are giving shelter to anybody who is seeking refuge, whether it is a common villager or Myanmar Army

or Myanmar Police. There is a due process that is followed. Whenever they want to come in, the weapons are obviously separated. "Thereafter there is a proper identification, which is carried out so that the undesirable elements are segregated.

We get in touch with the MEA and (Myanmar) Embassy. Generally, all these Myanmar Army personnel will be taken to Moreh (in Manipur) and then handed over to the (Myanmar) force," Kalita said. He further explained the direction is very clear to the forces on the border that the common villagers seeking

refuge to escape the conflict in Myanmar are not stopped and whenever they are ready, they are sent back. "While doing that, the directions are very clear that no armed cadres will be allowed to come. Any armed cadres trying to come are addressed in an appropriate manner. There is a definite check on people with drugs and arms,

and anybody caught is handed over to the police following the due procedure," Kalita said. Currently, the Assam Rifles is managing the Indo-Myanmar border in Manipur and Mizoram and they have border outposts in both the states along the international border, he added. More than 31,000 people from Myanmar have been living in Mizoram. These foreigners, mostly from Chin

state, fled following a military coup in Myanmar in February 2021. Many also took shelter in neighbouring Ma-In the last few weeks, dozens of Myanmar soldiers stationed near the international border with India fled to Mizoram following intense gunfights with militia group People's Defence Force (PDF). They were later escorted

back to their country through Moreh in Manipur. (PTI)

#### 4 persons killed, 11 injured in bus accident on highway in Gujarat

GODHRA, Nov 21: Four persons were killed and 11 others injured when their private luxury bus rammed into a stationary bus on a highway near Godhra town in Gujarat's Panchmahal district on Tuesday, an official said.

The deceased included two children, he said.

The accident took place on Dahod-Godhra highway at around 3.30 am when an Indore-bound bus was undergoing repairs on a roadside after the vehicle stopped due to a technical issue, Godhra Sub-Divisional Magistrate Pravinsinh Jaytavat said.

"The driver of another luxury bus coming from Dahod couldn't spot the stationary bus ahead and rammed his vehicle into the parked bus from behind. Four passengers two women and two children - were killed in the accident," he said.

Eleven other passengers received injuries. While nine of them were undergoing treatment at a civil hospital in Godhra, two other seriously injured persons were referred to Vadodara for medical assistance, the official said. (PTI)

The accused has been identified as Malak Singh alias Malik, a resident of Kurukshetra in Haryana, they said. He painted the graffiti in Delhi and other parts

of the country at the behest of Gurpatwant Singh Pannu, the chief of banned organisation Sikhs for Justice, police said. On September 27, 2023, multiple pro-Khalistan graffiti mentioning "Delhi banega Khalistan

SFJ" and "Khalistan Zindabad SFJ" were found

sprayed under and over Yudhister Setu, Kashmere Gate, a senior police officer said. Later, a video also appeared over the internet where Pannun claimed that Khalistani Sikhs from Canada have reached Delhi to target the Parliament House to avenge the assassination of

Delhi, the officer said. "During investigation, a person wearing a turban was spotted near the spots. The suspect boarded a Punjab-bound bus and de-boarded it at Pipli, Kurukshetra. Later, the alleged person was identified as Malak Singh.

He took photos and videos of the slogans and sent to Pannun, which were later uploaded by the SJF chief on various social media platforms. He also destroyed digital evidence by erasing the data of the mobile phone used for making photos and videos of the said graffiti, police said.

negative effects on the person's These effects can include deterioration in mental health, poorer performance at school or work, social isolation and relationship problems, and neglect of personal health or hygiene, the researchers

Disordered screen use shares characteristics with behavioural addictions like problem gambling, and some people may even develop symptoms of severe dependency like those associated with addictions to alcohol and il-



licit substances.

The researchers from Macquarie University in Australia identified 43 studies that assessed the neuropsychological effects of disordered screen use, ultimately including 34 in their analysis.

Twenty of the 34 included studies were on online and offline gaming, 12 were on internet use, and one each on social media and smartphone use, the researchers

The bias towards gaming and internet use were due to these platforms having been around longer, while smartphones and so-

cial media are relative newcomers to the screen-use landscape.

The research mostly looked at young males, and tested a total of 58 different neuropsychological measures, with most examining attention and executive function-

"This is the first time anyone has reviewed all the available evidence together," said study lead author, Mic Moshel from Macquarie University.

"The studies used different tests, which makes it more difficult to compare apples with apples, but there was clear evidence cognitive performance in people with disordered screen use, Moshel said. While there is an effect, the

that children and adolescents are

the most vulnerable to disordered screen use, and developing brains are highly sensitive to cognitive impairment. While cognitive impairment resulting from some other causes can be remediated, if left untreated, it can compound over

time, the researchers said.

Moshel says mild traumatic brain injury provides a good analogy, as it can lead to reduced cognitive performance that affects their ability to learn. "If it is not remediated

quickly and effectively, then you have what is called the widening of the gap, where you see an increasing distance develop between these children and their peers academically," the researcher added. (PTI)



# Barcelona and Madrid among teams hit by 'FIFA virus' as players get injured on international duty

MADRID, Nov 21: The latest international break is proving costly for several European clubs, including Spanish powerhouses Barcelona and Real Madrid.

Both teams will be depleted by the injury absences of important players affected by the "FIFA virus" while on duty with their national

Not long after Madrid confirmed injuries to Brazil forward Vinícius Júnior and France midfielder Eduardo Camavinga, Barcelona saw midfielder Gavi arrive from his stint with Spain in European Championship qualifying on crutches because of a serious injury that will likely see him miss the rest of the season. Gavi, who was in tears when he limped off the field in the 26th minute of Spain's 3-1 win over Georgia on Sunday, will need surgery in the coming days to repair a complete tear of the anterior cruciate ligament in his right knee.

Premier League champion Manchester City apparently avoided a scare — Erling Haaland's ankle iniury sustained in a friendly between Norway and the Faeroe Islands on Thursday doesn't seem to be too serious. Paris Saint-Germain wasn't so lucky with Warren Zaïre-Emery, a

17-year-old midfielder who hurt his right ankle when he became France's youngest scorer on his international debut in a record 14-0 rout of Gibraltar in European qualifying on Saturday.

Manchester United also may be in trouble after goalkeeper André Onana couldn't finish Cameroon's World Cup qualifier on Friday, while Inter Milan saw defender Alessandro Bastoni pick up an iniury while on duty with Italy.

Media in Spain and other countries refer to injuries sustained on international duty as the "FIFA virus." And the injury to Gavi is another example. "A very high price," read a front-page headline by the Marca sports daily on Monday, along with a photo of Spain forward Ferran Torres holding Gavi's jersey after he scored one of the team's goals in the second half. Some in Spanish media were quick to blame Spain coach Luis de la Fuente for not taking Gavi out of the game moments earlier when he received a knock to the same knee. The match meant little for Spain because it had already secured its spot at Euro 2024. Local reports said Barcelona was considering making a formal complaint to

the Spanish soccer federation.

was one of the "toughest" moments of his coaching career but noted that it had nothing to do with the knock he received earlier.

This can happen at any time. It was an accident," De la Fuente said. "It's a very difficult moment. It's difficult for him, his club, his teammates, for me and for the federation. We are devastated."

# Wenger commits himself to 'digging out' football talent in India

BHUBANESWAR, Nov 21: Legendary coach Arsene Wenger on Tuesday committed himself to "digging out talent" in India and place the country on world football map, as he inaugurated the FIFA-AIFF academy here.

Former Arsenal coach Wenger, currently serving as FIFA's chief of global football development, did not give any time frame when India would start producing "great players" but made it known that without proper grassroots development, the country will remain as it

"Our project is to identify talent in India, to put the best talent together, give them a good coaching programme, give them a good education and a good level of competition and make them great players," Wenger said.

"Our huge effort is to dig out talent and make them as good as they can be," he said after witnessing the signing of MoU between the All India Football Federation (AIFF) and the Odisha government. Fifty under-14 players -- including 15 from Odisha -- will be selected by the FIFA coaches in the first batch and they will get training at the academy for two years.

Odisha government will take care of the boarding, lodging, accommodation and education of the players, and FIFA will provide the



coaches. FIFA has already recommended Spain's Sergi Amezcua Fontrodona -- who was previously involved with developing football in China as project director -- to be the academy head coach for two years and an Indian will assist him for a few months. A foreign assistant coach will be appointed in four-five months.

"With such a huge population, the potential in India is huge, for you to be on top of the world. That is what we want to achieve together. How long will it take, I don't know," Wenger said.

"But one thing is for sure, if we don't educate we will be where we are at the moment. With the quality of education, you get great players. Our target is to develop top level players here and get India on the map among the best countries in the world," said the celebrated coach. He emphasised the necessity of catching players young if the country wants to reach the top level. "No country has more right over another country to be on the top of world. It's just down to educating your children (in football).

"India is a country which has invested a lot in education. It is a job you have to learn like any other job. And unfortunately, it starts at a very young age, you cannot start playing football at 15 years of age,

you have to start at 5 or 6 years of age." Wenger made a round of inspection of the academy, which is up for running with top-class facilities. It was initially planned as an


# Mbappe has reached 300 career goals faster than Messi or Ronaldo

PARIS, Nov 21: Kylian Mbappé has scored 300 career goals faster than Cristiano Ronaldo and Lionel Messi. Former France great Thierry Henry has nothing but admiration and Jean-Pierre Papin — the 1991 Ballon d'Or winner — believes the best is yet to come.

Mbappé achieved the feat over the weekend in a 14-0 rout of Gibraltar at the age of 24 years and 333 days. Both Messi and Cristiano Ronaldo, the game's two biggest stars in the 21st century, were older when

they reached the milestone.
"What this kid is doing is really out of this world," said Henry, who is now in charge of leading the new generation of France's players as coach of the Under-21 team. "It's just unbelievable.

Mbappé was often compared to Henry earlier in his career. Both attended France's Clairefontaine academy before playing as left wingers at Monaco, where each won the French



league titles as a teenager. Mbappé then replicated another of Henry's accomplishments

when he won the 2018 World Cup in his first major tournament with France. Henry won the 1998 tournament.

"The U19 World Cup has been shifted to South Africa from Sri Lanka due to SLC's suspension. In fact, participating nations were apprised some days back after SLC got suspended. South Africa hosted the U19 WC in 2020. The decision got approval at ICC Board meeting in Ahmedabad," an ICC Board member told PTI.

"Sri Lanka's bilateral and domestic cricket will not be affected by this .:

It was, in fact, Sri Lanka Cricket (SLC) that had reached out to the ICC and notified about the government interference in the running of the sport in the country after being knocked out in the league stage of the just-concluded World Cup following a forgettable outing.

The SLC and the country's sports ministry have been at loggerheads for some time now. The government had accused SLC officials of being involved in corruption and mismanage-

In a statement issued after its Board meeting, the ICC said, "After hearing representation



from SLC, the ICC Board decided that Sri Lanka can continue to compete internationally both in bilateral cricket and ICC events after being suspended recently for breaching its obligations as a Member in particular the requirement to manage its affairs autonomously and without government interference."

However, funding to SLC will be controlled by the ICC and the ICC Board.

SLC president Shammi Silva had recently warned that the country could lose the hosting rights of the U-19 World Cup, scheduled to be held from January 13 to February 4, if the government's interference continued.

said. "While SLC focuses on resolving the suspension issue, it appears that the minister of sports is pursuing a different agenda through media manipulation without pursuing legal avenues to address the allegations.'

"This raises concerns about its intention to influence public opinion and other stakeholders to achieve its objective of taking control of SLC through the misuse of his powers.

"SLC calls for a fair and unbiased examination of the facts and remains focused on its mission to uphold the integrity of cricket in Sri Lanka and is confident that the truth will prevail in due course." (PTI)

# Cricketers who have experienced male puberty, can't compete in women's cricket despite gender reassignment: ICC



AHMEDABAD, Nov 21: In a major policy decision, the ICC on Tuesday barred cricketers, who have been through any form of male puberty, from competing in international women's game regardless of whether or not they have undergone surgery or gender reassignment treatment.

The ICC said it was taking the decision to protect the integrity of international women's game and the safety of players. In a statement, the ICC said, "The ICC Board approved new gender eligibility regulations for the international game following a nine-month consultation process with the sport's stakeholders.

"The new policy is based on the following principles (in order of priority), protection of the integrity of the women's game, safety, fairness and inclusion, and this means any Male to Female participants who have been through any form of male puberty will not be eligible to participate in the international women's game regardless of any surgery or gender reassignment treatment they may have undertaken."

Gender reassignment and treatment have been a hotly-debated topic in world athletics for

The ICC, while firming up rules for gender eligibility for international women's cricket, left the issue at the domestic

level in the hands of the member boards.

"The review, which was led by the ICC Medical Advisory Committee chaired by Dr Peter Harcourt, relates solely to gender eligibility for international women's cricket, whilst gender eligibility at domestic level is a matter for each individual Member Board, which may be impacted by local legislation. The regulations will be reviewed within two years," said the ICC.

ICC Chief Executive Geoff Allardice said the world governing body had arrived at the decision following "extensive consultations".

"The changes to the gender eligibility regulations resulted from an extensive consultation process and is founded in science and aligned with the core principles developed during the

"Inclusivity is incredibly important to us as a sport, but our priority was to protect the integrity of the international women's game and the safety of players," said Allardice.

Meanwhile, the Chief Executives' Committee (CEC) endorsed a plan to accelerate the development of women match officials, which includes equal match-day pay for ICC umpires across men's and women's cricket, and ensuring there is one neutral umpire in every ICC Women's Championship series from January next year. ### ICC introduces stop clock in men's ODI and Fancied players advance to pre-quarterfinals in ITF Women's World Tennis Tour T20Is, five-run penalty on third offence

AHMEDABAD, Nov 21: Bowling teams in men's ODI and T20Is will be the next over for the third time in an innings, the sport's governing body ICC said on Tuesday

"The CEC agreed to introduce a stop clock on a trial basis in men's ODI and T20I cricket from December 2023 to April 2024. The clock will be used to regulate the amount of time taken be-

"If the bowling team is not ready to bowl the next over within 60 seconds of imposed a five-run penalty if the bowler the previous over being completed, a 5exceeds the 60 second limit of bowling run penalty will be imposed the third time it happens in an innings," said the ICC in a statement. "Changes to the pitch and outfield monitoring regulations were also approved, including a simplification of the criteria against which a pitch is assessed and increasing the threshold for when a venue could have its international status removed from five demerit points to six demerit points over a five-year period," the ICC added. (PTI)

# It was most attended ODI World Cup ever but jury still out on 50-over format's relevance

NEW DELHI, Nov 21: World Cup winning skipper Pat Cummins, by his own admission, has fallen in love with 50-over cricket all over again but the jury remains out on the future of the ODI format, whose relevance in modern-day cricket is being debated for some time

India is the heartbeat of world cricket and nearpacked stadiums for majority of World Cup games over the course of 45-day long event was expected at the spiritual home of the game. It was not a surprise that India has delivered the most attended ODI World

More than a record 1.25 million people thronged the stadiums but the same buzz and fanfare will most likely be missing when there is a bilateral series happening anywhere in the world including India.

The players and the purists love Test cricket while T20 is the format that enjoys unmatched popularity and is being used as a tool to spread the game globally. The attention spans are shorter than ever in the dig-

eight hours for an ODI game. The ICC event in India has shown that the format has plenty of takers if it is a world event but the bilateral ODIs don't inspire the same confidence going

ital age and not all have the time and zeal to spend

That begs the question: Should ODIs only be played in a World Cup year? If not, then should the format be tweaked on the advice of legends like Wasim Akram

and Sachin Tendulkar. The format is not high on priority for most teams with India featuring only in six ODIs next year and Pakistan don't have any match scheduled till November 2024 even though they host the Champions Trophy

During the World Cup, Akram opined that the format should be reduced to a 40 overs a side while Tendulkar wants to break the ODIs to four innings of 25 overs each to break the "monotony"



"I have a problem with ODI cricket right now. Very rarely do you see nowadays in One-day cricket something interesting happen in those (middle) 30 overs. Just go to 40 overs, you'll have more action during that

"I don't know if it's going to happen, but I think 40 overs would be more interesting, especially for bilateral series. Nowadays the audience, we do know their (attention) span is lesser than the nineties, because of T20 format and because of social media. We have to adapt," Akram told Fox Sports.

His menacing bowling partner Waqar Younis also expressed his views on the subject in the middle of the World Cup he was commentating on.

"ODI cricket is too friendly for batters. Suggestion @ICC 2 new balls to start, take away 1 ball after 30 overs, continue with the other. At the end that ball will only be 35 overs old. We'll see some reverse at the end. Save the art of #ReverseSwing," he posted on social

However, the comments of Cummins after the World Cup triumph on Sunday night were a good advert for the ODI format. Unlike the slam bang T20 format, ODI cricket is played in gears and does challenge the cricketers more.

It is a challenge Cummins and his team enjoyed in a global event but the same can't be said about a bilateral contest.

"I must say, maybe because we won, I did fall in love with ODI again this World Cup. I think the scenario where every game really matters, it does mean a bit different to just a bilateral," he acknowledged.

"I mean, the World Cup's got such rich history, I'm sure it's going to be around for a long time. Yeah, there's so many wonderful games, so many wonderful stories within this last couple of months. So, I think there's definitely a place."

The view and constraints of the average fan must also be taken into consideration by the ICC which might be forced to make changes to the ODI format in the near future.

Two Indian fans, who travelled the length and breadth of the country following the team in the World Cup, had a time to remember but they too want immediate changes to how the 50-over game is played.

"In the current scenario, it should be two innings of 20 overs each packed into six hours. Toss and conditions get nullified to a certain extent. Eight hours is way too long and needs to change," said Gurgaonbased Inderpreet Khurana referring to the World Cup final where the evening dew made batting easier for Australia.

He was in attendance for both the marquee games in Ahmedabad, the India-Pakistan showdown and World Cup final.

Atirav Kapur, who travelled to Chennai, Kolkata, Ahmedabad, Dharamsala and Lucknow for the India games in the league stage, is a fan of ODI cricket but doesn't see it surviving in its current version.

"Given that the biggest ever ICC rights deal has been signed recently and a big chunk of that is the 2027 ODI WC, I think ODIs will be 'forced' to survive. Though, on the whole, it's bound to slowly wind up -I don't think audiences can sustain watching a game for 7+ hours anymore - it's too long for a single day.

"Bilateral ODI cricket is meaningless at the moment," he reckoned. (PTI)
