

New Delhi confident of positive outcome Appeal against death order on 8 Indians in Qatar initiated

NEW DELHI, Nov 16: India on Thursday said the appeal process against the death sentence handed down to eight former Indian Navy personnel by a Qatari court is under process and it was hopeful of a positive outcome from it.

External Affairs Ministry spokesperson Arindam Bagchi said India is engaged with the Qatari authorities on the matter and that the government will continue to extend all legal and consular assistance to the Indian nationals.

The eight Indians were on October 26 given death sentences by Qatar's Court of First Instance. India described the ruling as "deeply" shocking and vowed to explore all legal options in the case.

Days later, an appeal was filed against the death sentence.

The case is currently in a legal process there. As we mentioned, an appeal has been filed in Qatar's



Court of Appeal. We are also engaged with the Qatari authorities on the matter and we will continue to extend all legal and consular assistance (to them)," Bagchi said.

"I would again urge everyone not to engage in speculation considering the sensitive nature of the

case," he said. The judgement in the entire process has been made confidential

by the Qatari side. "The appeal process is underway and we would hope for a positive outcome," Bagchi said, replying to a question on the matter

at his weekly media briefing. He also described as "factually incorrect" some reports that suggested the appeal in the case has been adjudicated.

The Indian nationals, who worked with private company Al Dahra, were arrested in August last year reportedly in an alleged case of espionage.

Neither the Qatari authorities nor New Delhi made the charges against the Indian nationals public. In its reaction to the ruling by the Qatari court, the Ministry of External Affairs (MEA) last month said that it is attaching "high importance" to this case and is exploring all legal options.

The charges were filed against the eight Indian navy veterans on March 25 and they were tried under Qatari law.

All of the former Navy officers had "unblemished stints" of up to 20 years in the Indian Navy and had held important positions including that of instructors in the force, former military officials had said. (CONTD. ON PAGE-9)



LONDON, Nov 16: External Affairs Minister S Jaishankar has said that India is not ruling out an investigation into Canada's allegations about the involvement of the Indian government's agents in the killing of a Khalistani separatist in that country but wants it to provide evidence to back its claims.

Jaishankar made the comments on Wednesday in response to questions during a conversation with veteran journalist Lionel Barber titled 'How a Billion People See the World' here.

"If you have a reason to make such an allegation. please share the evidence with us. We are not ruling out an investigation and looking at anything which they may

have to offer. They haven't done so," Jaishankar, who was here on a five-day official visit to the UK, said while responding to a question.

The ties between India and Canada came under severe strain following Canadian Prime Minister Justin Trudeau's allegations in September of a "potential" involvement of Indian agents in the killing of Khalistani separatist Hardeep Singh Nijjar on June 18 in British Columbia. India had designated Nijjar as a terrorist in 2020. India has rejected Trudeau's allegations as "absurd" and "motivated"

Jaishankar also said Canadian politics has given space to violent and extreme political opinions which advocate separatism from India, including through violent means.

"These people have been accommodated in Canadian politics. They are given the freedom to articulate their views," he said.

Jaishankar said that freedom of speech and freedom of expression comes with a certain responsibility and the misuse of those freedoms and the toleration of that misuse for political purposes would be very wrong, referring to the pro-Khalistani activities in Canada.

Jaishankar said that he was in touch with his Canadian counterpart Melanie Joly on the issue.

He recalled the attacks on the High Commission of India in Canada, or smoke bomb attacks on the High Commission and (CONTD. ON PAGE-9)

India committed to unimpeded lawful commerce

NEW DELHI, Nov 16: India is committed to freedom of navigation, overflight and unimpeded lawful commerce in international waters in accordance with global norms, defence minister Rajnath Singh said on Thursday against the backdrop of China's increasing military muscle flexing in South China Sea.

In an address at a meeting of 10-nation ASEAN and some of its dialogue partners in Jakarta, Singh also underlined the importance of dialogue and diplomacy to ensure enduring peace and stability in the world.

The defence minister reaffirmed India's message to the world at large, that "this is not an era of war". and spoke about the imperative to give up the "us versus" them" mindset. Singh said India is commitment to freedom of navigation, overflight and unimpeded lawful commerce in the international waters in accordance with international laws, including United Nations Convention on the Law of the Sea (UNCLOS) 1982.

There have been growing global concerns over China's sweeping claims of sovereignty over all of the South China Sea, a huge source of hydrocarbons. Several countries in the region including Vietnam,

the Philippines and Brunei, have counterclaims. In his remarks at the meeting of ASEAN Defence

Ministers' Meeting Plus (ADMM-Plus), the defence minister described terrorism as a serious threat to international peace and security and called for concerted efforts to deal with it.



The ADMM-Plus is a platform comprising 10-nation ASEAN (Association of Southeast Asian Nations) and its eight dialogue partners -- India, China, Australia, Japan, New Zealand, Republic of Korea, Russia and the United States.

Indonesia is hosting the meeting as the current chair of ADMM-Plus. The defence minister called for regional security initiatives that are consultative and development-oriented to reflect the larger consensus among various stakeholders.

He committed towards nurturing practical, forwardlooking and result-oriented cooperation with ADMM-Plus for enhancing maritime security in the region, the defence ministry said here. (CONTD. ON PAGE-9)

It is worth mentioning that this initiative, launched by the Assam government in 2019, focuses on reintegrating individuals with militant backgrounds into mainstream society.



MUMBAI, Nov 16: A Reserve Bank Bulletin on Thursday said retail inflation has moderated due to monetary policy action and supply side interventions, but "we are not out of the woods yet and have miles to go".

An article on the state of the economy in the November Bulletin also noted that the global economy is showing signs of slowing down in the ongoing quarter as manufacturing languishes while services sector activity appears to have reached the end of its postpandemic expansion.

Going forward, it said tightening financial conditions is a significant risk to the global outlook.

"In India, the momentum of the change in GDP is sequentially expected to be higher in Q3, 2023-24, with festival demand remaining ebullient," the article authored by a team lead by RBI Deputy Governor Michael Debabrata Patra said.

The authors said investment demand appears to be resilient with

The article further said India's external sector has remained viable, with a modest Current Account Deficit (CAD) financed by resilient capital flows, one of the least volatile currencies in the world and a healthy level of foreign exchange reserves.

The momentum of growth has picked up, taking GDP well above pre-pandemic levels to becoming the fifth largest economy in the world at market exchange rates, it added. "Steadfast policy initiatives are showing results, with the financial sector exhibiting soundness and supporting the credit needs of a resurgent economy," it said.

The 37th edition of the State of the Economy article marks the third year of its revival after a long hiatus of 25 years. (PTI)

Sensex and Nifty closed higher for a second straight day on Thursday following gains in IT, tech and consumer durable shares amid a mixed trend in global equities. Softer-than-expected US inflation data and easing bond yields have also brought optimism in equity markets.

The 30-share BSE Sensex climbed 306.55 points or 0.47 per cent to settle at 65,982.48. During the day, it jumped 682.44 points or 1 per cent to 66,358.37.

The Nifty gained 89.75 points or 0.46 per cent to 19,765.20.

'The Indian market continued its positive resurgence, tracking global gains. Softer-than-expected US inflation data and easing bond yields have bought optimism that spending will emerge like in technology.

"Taking the cues further, IT stocks showed a significant jump in the broader market. The market is sensing that export-based sectors like IT and pharma could be future winners. While cut in inflation will also benefit domestic placed staples and consumer sector,' said Vinod Nair, Head of Research, Geojit Financial Services.

Among the Sensex firms, Tata Consultancy Services, HCL Technologies, Tech Mahindra, Infosys, Bajaj Finance, NTPC, Mahindra & Mahindra and Bajaj Finserv were among the major gainers.

Axis Bank, Power Grid, ITC and ICICI Bank were the major laggards. In the broader market, the BSE midcap gauge jumped 0.52 per cent and smallcap index climbed 0.52 per cent.

Among the indices, IT jumped 2.59 per cent, teck rallied 2.13 per cent, healthcare (0.98 per cent), realty (0.98 per cent), oil & gas (0.84 per cent), telecommunication (0.68 per cent) and consumer discretionary (0.64 per cent).

FMCG, bankex and metal were the laggards.



In Asian markets, Seoul settled in the green, while Tokyo, Shanghai and Hong Kong ended lower. European markets were trading on a mixed note.

The US markets ended with gains on Wednesday. Global oil benchmark Brent crude declined 0.54 per cent to USD 80.74 a barrel. Foreign Institutional Investors (FIIs) turned buyers on Wednesday as they bought equities worth ₹ 550.19 crore, according to exchange data. "Although key indices pared gains towards the closing hour, markets continued their upward bias due to an upsurge in IT and realty stocks. Moderating inflation in the US could be signalling that the Federal Reserve may be done with rate hikes, which is good for global markets.

"Further, domestic economic numbers like exports have shown signs of recovery, which has further boosted the market sentiment and has triggered renewed buying interest in recent sessions," Prashanth Tapse, Research Analyst-Sr VP Research, Mehta Equities Ltd, said.

The BSE benchmark jumped 742.06 points or 1.14 per cent to settle at 65,675.93 on Wednesday. The Nifty climbed 231.90 points or 1.19 per cent to 19,675.45. (PTI)

MUMBAI, Nov 16: The rupee declined by 14 paise to settle at 83.23 (provisional) against the US dollar on Thursday due to foreign fund outflows and a firm greenback in the overseas markets.

Losses in crude oil prices, however, helped the rupee restrict the fall, forex dealers said.

At the interbank foreign exchange market, the rupee opened lower at 83.18 against the US currency. The local unit remained under pressure in the day trade moving in a range of 83.17 to 83.25.

The rupee settled at 83.23 (provisional) against the US dollar, showing a loss of 14 paise over the last close.

The rupee appreciated 24 paise to close at 83.09 against the US dollar on Wednesday as the American currency retreated from its elevated levels after the US inflation came lower than expected.

Windfall profit tax on crude oil, diesel exports cut NEW DELHI, Nov 16: The government on Thursday cut the windfall profit tax on crude oil produced in the country and on exports of diesel in line with softening international oil prices.

The tax, levied in the form of Special Additional Excise Duty or SAED, on domestically produced crude oil has been reduced to ₹ 6,300 per tonne from ₹9,800 per tonne, according to an official notification. SAED on the export of diesel was reduced to ₹ 1 per litre from ₹ 2 per litre. The levy on the export of jet fuel or ATF and petrol will continue to be zero.

The new tax rates came into effect from Thursday. At the last revision effective from November 1, the government had increased the tax on crude oil to ₹ 9,800 per tonne from ₹ 9,050 per tonne. Simultaneously, the levy on the export of diesel was halved to ₹ 2 and that on jet fuel was brought to nil from $\gtrless 1$ per litre. International oil prices have softened since the last revision, necessitating the reduction. The basket

India first imposed windfall profit taxes on July 1 last year, joining a growing number of nations that tax supernormal profits of energy companies. At that time, export duties of ₹ 6 per litre (USD) 12 per barrel) each were levied on petrol and ATF and ₹ 13 a litre (USD 26 a barrel) on diesel. A ₹ 23,250 per tonne (USD 40 per barrel) windfall profit tax on crude oil produced by companies such as Oil and Natural Gas Corporation (ONGC) was also levied.

The tax rates are reviewed every fortnight based on average oil prices in the previous two weeks.

A windfall tax is levied on domestic crude oil if rates of the global benchmark rise above USD 75 per barrel. Export of diesel, ATF and petrol attract the levy if product cracks (or margins) rise above USD 20 per barrel. (PTI)

During the period from November 10-13, the bank had observed, due to technical issue in IMPS, certain transaction(s) initiated by holders of other banks have resulted in credit to the account holders in our bank without actual receipt of money from these banks.(PTI)

loans for banks, NBFCs

MUMBAI, Nov 16: The Reserve Bank on Thursday tightened norms for unsecured personal loans for banks and non-banking financial companies.

The revised norms wherein risk weights have been increased by 25 percentage points will not be applicable on certain consumer loans, including housing, education, and vehicle loans.

Besides, the norms will not be applicable on loans secured by gold and gold jewellery. These loans will continue to attract 100 per cent risk weight.

Higher risk weight implies that banks have to keep aside more money as buffer when it comes to unsecured personal loans. In simple words, a higher risk weight restricts banks' lending

capacity. Recently, RBI Governor Shaktikanta Das had flagged the high growth in certain components of consumer credit and advised banks and Non-Banking Financial Companies (NBFCs) to strengthen their internal surveillance mechanisms, address the build-up of risks and institute suitable safeguards, in their own in-

terest. The high growth seen in consumer credit and increasing dependency of NBFCs on bank borrowings were also highlighted by the governor during the interactions with MD/CEOs of major banks and large NBFCs in July and August, respectively.

"On a review, it has been decided to increase the risk weights in respect of consumer credit exposure of commercial banks (outstanding as well as new), including personal loans, but excluding housing loans, education loans, vehicle loans and loans secured by gold and gold jewellery, by 25 percentage points to 125 per cent," the RBI said in a circular.

The central bank has also increased the risk weights on credit receivables by 25 percentage points to 150 per cent and 125 per cent for banks and NBFCs, respectively. (PTI)

after Roy's death: Sebi chief

MUMBAI, Nov 16: Sebi chairperson Madhabi Puri Buch on Thursday said the Sahara matter will continue for the capital markets regulator even after the death of the group's founder Subrata Roy. Roy died in Mumbai on Tuesday after a prolonged illness at the age of 75. Speaking to reporters on the sidelines of a Ficci event, Buch said for Sebi, the Sahara matter was about an entity's conduct and added that it will continue regardless of whether an individual is there or not. When asked why the refunds have been too less. Buch said the monies were returned through a Supreme Court-appointed committee basis the evidence of the claims made by investors. It has been reported that refunds of only ₹ 138 crore have been made to investors even though Sahara

group was asked to deposit over ₹ 24,000 crore with Sebi for further refund to investors. Sahara group has faced many allegations, including that of running a Ponzi scheme. Troubles for Roy started in November 2010 with Sebi

asking two entities of Sahara group not to mobilise funds from equity markets or from issuance of any security to the public while restraining Roy

from approaching the public for raising money. Roy was arrested in 2014 on the orders of the Supreme Court after he failed to appear before it in a contempt case arising out of non-refund of more than ₹ 20,000 crore to investors by the two companies. He was later granted bail but troubles continued for his various businesses.

The two Sahara group companies --Sahara India Real Estate Corporation (SIRECA) and Sahara Housing Investment Corporation -- raised funds in 2007-08 through a debenture instrument, OFCD. In June 2011, the capital markets regulator asked the two entities to refund money collected from investors through Optionally Fully Convertible Debentures (OFCD) along with the return.

After a long process of appeals and cross-appeals, the Supreme Court, in 2012 ordered refund of deposits of its investors along with 15 per cent interest. Sahara was eventually asked to deposit an estimated ₹ 24,000 crore with Sebi for further refund to investors, though the group always maintained it amounted to "double payment" as it had already refunded more than 95 per cent of investors directly. In a report titled 'Global Banks Country-By-Country Outlook 2024', S&P said the banking sector's weak loans will decline to 3-3.5 per cent of gross advances by March 31, 2025, on the back of structural improvement, including healthy corporate balance sheets, tighter underwriting standards and improved risk-management practices.

Interest rates in India are unlikely to rise materially, and this should limit the risk for the banking industry, it added. "Unsecured personal loans have

grown rapidly and could contribute to incremental NPLs. We believe underwriting standards for retail loans generally remain healthy and overall level of delinquencies remains within acceptable limits for this product category," S&P Primary Credit Analyst Deepali Seth

Chhabria said. The report said that global uncertainties will have a lesser impact on the Indian economy

Slower global growth and external demand will weigh on economic activity and could fuel further inflation. However, given that India is domestically oriented,



the agency expects the economic to continue. India's economic growth to be less affected, it added. growth prospects should remain "Economic growth momentum strong over the medium term, with

GDP expanding 6-7.1 per cent annually in fiscal years 2024-2026," S&P said. India's real GDP rose 7.8 per cent year-on-year in the June quarter, up from 6.1 per cent in the March quarter.

The Reserve Bank of India has forecast a 6.5 per cent economic growth for the 2023-24 and 2024-25 fiscal years. The report further said that the State Bank of India and the leading private-sector banks have largely addressed their asset-quality challenges.

Many public-sector banks still carry relatively high volumes of weak assets, which will result in higher credit losses and hit profitability; their performance lags that of the industry. (PTI)





MP polls: battle royale on cards

s the fervour of the election campaign in Madhya Pradesh simmers down, the political landscape indicates a neckand-neck contest between the Bharatiya Janata Party (BJP) and the Congress. The BJP's resurgence, seemingly bolstered by the Prime Minister's whirlwind tour, has brought a renewed sense of competition. With the polls scheduled for November 17, both parties are leaving no stone unturned in their bid for victory. The BJP's formidable campaign, marked by the Prime Minister's three public meetings daily over the past week, has refrained from revealing a chief ministerial face. Through daily advertisements featuring prominent figures like Prahlad Patel, Kailash Vijayvargiya, V. D. Sharma, Narendra Singh Tomar, Shivraj Singh Chouhan, and Jyotiraditya Scindia, the party deliberately maintains an air of suspense regarding its leadership choice. While Chief Minister Shivraj Singh Chouhan expresses confidence in a BJP triumph, the Congress has adopted a different approach. PCC chief Kamal Nath has been projected as the Congress's chief ministerial candidate, supported by Rahul Gandhi's assertion that the party aims to secure 150 seats out of the 230 in the assembly. The battleground, this time, is the booth level, with both parties intensifying their efforts at the grassroots.

In a strategic move well before the last assembly polls in 2018, Kamal Nath acknowledged the Congress's organizational shortcomings compared to the BJP's well-established cadre. Nath focused on rebuilding the cadre formation, expanding from district and block levels to introduce mandal levels. Within six months, organizational units increased from 600 to 3,000, blocks from 500 to 800, and 2,400 mandals were established to rival the BJP's organizational strength. The Congress claims parity with the BJP in terms of booth workers, albeit in larger numbers. Under Nath's leadership, the party boasts two 'booth level agents' authorized to report "BJP excesses" directly to collectors. The organizational structure has witnessed substantial growth, expanding from 3,000 to 15,000 units in this election. In contrast, the BJP touts a formidable force with 41 lakh registered workers in 65,430 booths. Despite Congress's efforts, the BJP asserts a colossal workforce of over 1 crore in the state. The presence of senior central ministers in the state, praising Shivraj Singh Chouhan's leadership and claiming extraordinary progress, raises questions about the necessity of deploying the Prime Minister for such assertions.

Observers express surprise at the influx of central ministers addressing public meetings in small towns, implying an unprecedented focus on Madhya Pradesh. However, the opposition questions the sincerity of progress claims, citing the substantial advertising expenditure. The capital, Delhi, seems to have shifted to Madhya Pradesh, with the Prime Minister, defense minister, home minister, and a dozen ministers making the state their temporary home. A noteworthy aspect of this election's propaganda is the undignified language employed by leaders across party lines, including the Prime Minister. Such rhetoric, ranging from derogatory descriptions to name-calling, raises concerns about the level of political discourse in the electoral arena. As Madhya Pradesh braces for the upcoming polls, the clash of strategies between the BJP and Congress reveals a nuanced battle at the organizational and grassroots levels. The outcome remains uncertain, but what is clear is that both parties are sparing no effort to secure victory in this crucial electoral battleground.

India's democracy: Press freedom, media dilemmas, and the path forward

If both the past and the external world exist only in the mind, and if the mind itself is con-- what then?" - 1984, trollable George Orwell The state of both press and democracy is critical today, despite Prime Minister Narendra Modi's 2017 declaration on World Press Freedom Day via Twitter, which has become a common platform for significant policy announcements. He stated, World Press Freedom Day is a day to reiterate our unwavering support towards a free & vibrant press, which is vital in a democracy.

As per the most recent update from the international media watchdog, Reporters Without Borders, India's position in the 2023 World Press Freedom Index has slipped to 161 out of 180 nations. The report also highlights that, on average, each year witnesses the tragic loss of three to four journalists due to their professional pursuits. In a comprehensive study titled "Mapping patterns of violence against journalists in India," conducted by The Polis Project's Watch the

State, a concerning total of 256 incidents of violence against journalists was documented between May 2019 and August 2021. In the realm of democracy, India's standing has witnessed

significant shifts. According to the 2021 report by the Swedenbased V-Dem Institute, India was designated as an "electoral autocracy," signifying a decline in democratic norms. This classification underscores that while the country continues to hold regular elections, the quality of its democratic institutions and procedures

has eroded, resulting in the concentration of power and restricted political liberties. In a similar vein, the Economist Intelligence Unit's Democracy Index for 2020 saw India's ranking drop by two positions to the 53rd spot, labeling it a "flawed democracy." The year 2022 witnessed Access Now's report dubbing India as the foremost perpetrator of internet shutdowns. With a staggering count of at least 84 instances, India secured the ignominious title of having the highest number of internet shutdowns globally for the fifth consecutive year. Notably, Ma-

nipur's governrecently imposed an 83 day internet shut-

down in an attempt to quell violence and disinformation. Regrettably, this strategy not only exacerbated the challenges faced by the general populace but also concealed instances of violence and misinformation from the broader national view.

On July 27, the "Indian Media: Trends and Patterns" report was unveiled by Lokniti and CSDS. With the swift evolution of media consumption patterns in the digital era, the report advocates for a proactive approach in addressing the emerging obstacles. The necessity for soul-searching and reform within the media sector becomes progressively more conspicuous.

As indicated by the report, an astounding 80% of journalists express the belief that the media demonstrates a bias in favor of the Narendra Modi-led government, while 61% sense that the media showcases unfair treatment towards the Opposition. Furthermore, the report underscores that 73% of journalists perceive media establishments to incline toward a specific political party. Within this category, a substantial majority (82%) pointed to the Bharatiya Janata Party as the recipient of such inclinations, with merely 3% indicating any partial-

ingly, 89% of freelance journalists and 81% of those affiliated with news organizations shared the consensus that the media presents the Modi government in a favorable light.

These unsettling revelations draw striking parallels with the seminal contribution of Noam Chomsky and Edward S Herman, as presented in their groundbreaking work "Manufacturing Consent: The Political Economy of the Mass Media," initially published in 1988. Within this influential tome, the authors conduct a meticulous dissection of the mass media within the United States of America, illuminating its role as a vehicle for propagandistic endeavors that mold public perspectives while aligning with the interests of the influential. Chomsky and Herman introduce the concept of a "propaganda model," positing that the media functions as a mechanism for steering public perception rather than offering impartial information. Their argument revolves around the sway of corporate interests, propelling the media to cater to prevailing political and economic powerhouses. Notably, this viewpoint resonates significantly within the context of the landscape.Numerous Indian media outlets, including Dainik Bhaskar, Bharat Samachar, The Quint, The Wire, The Caravan, Newsclick, and Greater Kashmir, have encountered scrutiny from investigative agencies. The Lokniti-CSDS report corroborates these observations: 72% of journalists indicated a perception that news channels currently experience limitations in conduct- *dipaknewslive@gmail.com*)

ing their responsibilities, while 71% of independent journalists hold the view that newspapers nowadays encounter constraints in fulfilling their roles effectively. Moreover, 16% of journalists disclosed instances where individuals within their organizations were compelled to resign due to their political inclinations, and over half of the respondents expressed apprehensions about the prospect of job loss based on their political affiliations. These collective actions cast a pall over transparency, the freedom of expression, and the overall democratic vitality within the nation.

Amidst these troubling times, our nation is wrestling with communal strife, the stealthy infiltration of false information. a worrisome upswing in misinformation in the digital era, capricious alterations to educational content and curriculum adjustments, along with an unsettling rise in attacks on women. Concurrently, mainstream media appears to have hit a nadir as well, with journalists navigating either official scrutiny for their routine tasks or prioritizing sensationalism over matters of authentic import. In light of these formidable hurdles, one can't help but question: what vestiges of our democracy endure?The government bears the obligation to furnish explanations and assume accountafor the bility prevailing circumstances. Modi-Shah try to woo back Yediyurappa; while Sidda, DKS factions bicker

ecent developments in Karnataka BJP send out the message that Amit Shah, despite his so-Called 'Chanakya' fame, has lost grip on party affairs and also is running short of ideas. Only a week back, the BJP leadership appointed B Y Vijayendra, a first-time MLA, the younger son of the former Karnataka chief minister B S Yediyurappa, as the president of the state unit. This is being perceived as a circuitous move to hand over the command of the party once again to the old Lingayat leader, B S Yediyurappa, who was sidelined by Modi and Shahin May this year, right in the middle of the state election, in their bid to move the party away from the shadow of the Lingayat strongman.

That decision by Modi and Shah proved to be suicidal, as the Lingavats shifted their lovalty to the Con-

used to behave as a "super CM" when his father was the chief minister. They even allege that his style of functioning was a major factor for the disconnect of the lower rung cadres and leaders with the state leaders. This was a major reason for fall of the party in Karnataka. Lingayats are viewed as having anti-Hindutva orientation. It is said that Lingayatism was founded to disrupt Hinduism's Brahminical order. Centuries later, the community's social elite and new middle class has embraced the neoliberal and communal policies beloved of the Sangh Parivar. To endorse their views, they mention the statements of former BJP chief minister Basavaraj Bommai, that 'hijab and halal are not election issues' and also of senior Yediyurappa who had observed that he will not approve any socially polarising issue.

Saudi oil cut extension fails to boost prices despite continuing Gaza conflict By: K Raveendran

Saudi decision to extend its voluntary oil production cut to the end of the year has passed off as a non-event, with the Thoil markets shrugging off the decision as of little consequence to the current demand-supply situation in the global market. The kingdom said on Sunday it will continue its additional voluntary output cuts to the end of the year as part of an Opec+ policy of acting to stabilise and balance the markets.

Oil was trading at around \$85 a barrel last week, despite weeks of conflict in Gaza that have raised fears of a regional war. The prices had hit a high of \$98 in September, raising the scare of another crisis for the oil importing countries. But the delicate demand situation in the wake of the prospects of sluggish growth in the global economy, prices began to cool off and the cuts by major producers, including Russia, have failed to hold prices at the desired level. eign Assets Control (OFAC) announced sanctions against the Myanmar bank of Foreign Trade and the Myanmar Investment and Commercial Bank. These banks have funds amounting to over \$ 1.70 million deposited at the Sonali bank in Bangladesh. Fresh restrictions against the Myanmar banks followed the earlier round of US sanctions issued in the wake of the February 2021 army coup.

According to sources, US authorities kept Bangladesh 'informed' about the new orders, emphasizing a specific instruction to freeze existing funds.

Sonali Bank in Bangladesh then proceeded to freeze Myanmar's accounts,, falling in line with the OFAC directive. It also informed other commercial banks to avoid transaction with the two concerned banks, as urged by US authorities. Observers said Dhaka-based authorities had little choice in the matter, their country hardly being in a position to invite more problems vis-à-vis the US just before the general elections or risk facing fresh sanctions itself.

According to one report, Myanmar exported food items including rice, beans, onions and other stuff worth \$4.5 million between April and August this year. Bangladesh is seeking to buy additional stocks of rice from other countries including India and the cut announced by Myanmar authorities could have a negative impact.

The country imports sizable

However, Myanmar authorities, somewhat upset, arranged to meet Dhaka officials in Dhaka. BD officials then explained the situation at length.

Meanwhile, Bangladesh authorities on their part reiterated their requests to Myanmar to facilitate the return to Myanmar to the extent possible of the lakhs of stranded Rohingya Muslims as early as possible. Bangladesh had looked after them for years, but in the process it had suffered enormously in terms of economy, general governance, environmental losses and other socialeconomic problems.

Junta spokesmen, who officially present a more reasonable approach towards the Rohingya issue by not opposing the demand for repatriation, reaffirmed their intent to speed things up, while pointing to existing difficulties.

Dhaka-based media reports indicated that given the glacially slow pace of the Rohingva repatriation process and official negotiations involved with it, Myanmar's assurances hardly helped in lifting Bangladeshi hopes for any early improvement in the present situation. (IPA Service)

gress and ensured its victory in at least 30 constituencies. Though the BJP national leaders claim that taking lessons from assembly defeat, they have handed over the command to Yedivurappa, it has already had a damaging impact on the state unit. The state unit of the party has a large number of prominent Lingayat faces. They feel aggrieved at this move of Shah and Modi and openly say that they feel humiliated.

They have a valid argument. They respected B S Yediyurappa, as he was a senior leader and had revived the party in the state. But respect for him should not have been construed by Modi and Shah as confirmation for the senior Lingayats listening to the diktats of Vijayendra, who is a greenhorn. They resorted to this move as Lingavat vote weighs heavy on party after the May 2023 loss and ahead of 2024 national polls. These leaders also say that while the Lingayats indeed have high regard for the senior Yediyurappa, they too deserve respect from the party leadership. BJP nurses the hope that the installation of Vijayendra would bring back Lingayats to the party fold and help it replicate its 2019 Lok Sabha performance, when it had won 25 of the 28 seats in Karnataka.

Naturally, the BJP facing "dynasty politics" criticism, following the appointment of Vijayendra as state unit president. The senior Lingayat leaders hold the view that the national leadership are running short of ideas as how to expand the base of the party in the state and have probably abandoned the strategy to evolve a cadre-based leadership system, which it had tried to do by forcing out Yediyurappa mid-term as CM in 2021.In a message to the strongmen from dominant castes like Yediyurappa that they could no longer dictate terms to the party leadership, and citing its stand against dynastic politics, the BJP had in 2018 also denied a poll ticket to Vijayendra and denied him a ministerial post between 2021 and 2023.

Sources maintain that after the electoral Waterloo of May, the national leadership had decided to rope in the Vokkaliga community. But it did not succeed. They also pointed out that the idea was dropped after the JD(S) of H D Deve Gowda decided to have an alliance with the BJP as the Vokkaliga has been the main support base for Deve Gowda. "With the JD(S) coming into the NDA, the appointment of a Vokkaliga leader as the BJP chief was not viable. Obviously, the party was forced to have someone from the Lingayat community as the public face. Now after installing Vijayendra as the state chief, the leadership is looking for some prominent OBC leader to appoint as the legislative leader," said a senior leader.

Yet another factor that has significantly come into play is the attitude of the Sangh Parivar. The RSS cadres of Karnataka never held senior Yediyurappa in high esteem. They feel that he might have been the face of the Lingayat community in the state, but he never tried to take all the castes and communities along with him. He never had a smooth and cordial relation with the state unit of RSS. Obviously, those loyal to RSS could not be expected to extend their support to Vijayendra. Some RSS leaders recall how Vijayendra

striving to implement the ideological line of Rahul Gandhi, too are involved in a bitter power struggle. Karnataka CM Siddaramaiah has accused the BJP of attempting to destabilize the Congress government in the state through "Operation Kamala". But there are few takers for his accusation. He had come out with this allegation following a complaint by Congress MLA Ravikumar Gowda that a BJP team had approached Congress legislators with offers of Rs 50 crore for each and a ministerial berth to switch to the saffron party.

Deputy CM DK Shivakumar also observed: "A big conspiracy is being hatched, but it will not bear fruit. He said that BJP was actively working to destabilise the state government. He had claimed Congress legislators had informed him and the CM about who was in touch with them and the offers being made.

In fact, the scare of poaching is not acute. It is the infighting between two warring factions led by Siddaramaiah and Shivakumar that has been major source of worry for the Congressmen in the state. The supporters of Shivakumar are pressuring the party leadership to install Shivakumar as the chief minister. His supporters have even been holding dinners and get together to work out the strategy. On his part, Siddharamaiah has also been holding meetings of his supporters.

Recently, Siddaramaiah participated at a dinner party hosted by state home minister G Parameshwara, where Shivakumar was absent. Yet another dinner was organised coinciding with the earlier one where Mandya MLA Ravikumar Gowda claimed Shivakumar would become the CM after two-and-a-half years. Party insiders suggested the dinner aimed to pacify PWD minister Satish Jarkiholi, who has expressed dissatisfaction with Shivakumar's increasing involvement in Belagavi politics. Those who joined the Congress quitting BJP in the wake of the May assembly election have been key players in the game of infighting. Jarkiholi, in fact, had planned to travel to Dubai with around 20 likeminded legislators to send a message to party leaders, although a previous trip to Mysuru was cancelled after the intervention of the Congress high command.

The infighting has adversely affected the functioning of the government. Most of the pre-election promises made by Rahul and Priyanka are yet to see the day light as the ministers being senior leaders are busy garnering support for their respective leaders. Infighting has also held up party rejig ahead of Lok Sabha polls The Congress party in Karnataka is facing delays in restructuring the Karnataka Pradesh Congress Committee (KPCC) due to factionalism.

Following the advice of Rahul Gandhi, the decision was made to induct new young faces in the state committee. But it is not happening as both the leaders Siddaramaiah and Shivkumar are not willing for this exercise. The move to infuse 'fresh blood' in the party ahead of the Lok Sabha elections and to reduce the workload on ministers is yet to materialise. Though AICC general secretary Randeep Singh Surjewala, incharge of Karnataka and other central leaders will be holding meetings with the leaders to find a solution, the nature of animosity prevailing in the party sends a clear message that a major show down in near future between the two factions is imminent. The cartel has reasons to feel worried as the market rally that pushed benchmark prices towards triple digits in September reversed sharply in October, despite continued tight crude supplies and an intensifying conflict in the Middle East. In early November, ICE Brent futures plunged to a four-month low around \$80 per barrel.

The abrupt sell-off came as market concerns shifted from supply risks to the global economy and oil demand. In addition, front month paper market trade has moved to the first quarter of next year when markets appear more or less in surplus, adding to the downward pressure on prices.

Fears that the war between Israel and Hamas would escalate into a wider regional conflict, disrupting oil supply flows, have yet to materialise. Barring large unforeseen outages, world oil supply is firmly on an upward trajectory.

Saudi Arabia, which has taken upon itself the burden of balancing the market by assuming the role of swing producer so as not to allow prices to sag, is facing a dilemma as the voluntary cuts have started affecting the kingdom's finances. Lower supply at lower prices is highly problematic for its economy, leading to fears of a massive drop in GDP estimates compared to the previous year.

Saudi Arabia and Russia have indicated the possibility of cuts extending to the next year. The cuts look set to keep the oil market in a significant deficit through year-end, with the OPEC+ alliance pumping below the demand. According to International Energy Agency (IEA), global observed crude oil inventories fell by a massive 140 million barrels over the third quarter to a fresh low, as refineries boosted activity ahead of seasonal maintenance. With demand growth set to slow, the market could shift into surplus at the start of 2024, IEA said. For now, with demand still exceeding available supplies heading into the Northern Hemisphere winter, market balances will remain vulnerable to heightened economic and geopolitical risks – and further volatility ahead, it added.

Russian oil exports eased by 70,000 barrels per day in October, to 7.5 million barrels as higher crude oil shipments failed to offset a decline in product flows. Estimated export revenues fell by \$25 million to \$18.34 billion as lower international oil prices more than offset a narrowing discount for Russian grades. Russian crude and product prices were above the G7 price cap.

IEA has slightly revised up its 2023 growth forecast to 2.4 million barrels per day, as US deliveries proved more resilient than indicated by preliminary data and Chinese oil demand in September set another all-time high above 17 million barrels per day, fuelled by a booming petrochemical sector. Those gains have come to the detriment of petrochemical producers elsewhere, most notably in Europe and advanced economies in Asia and Oceania.

Indeed, the two regions saw third quarter oil demand slump. This year's surge will take the world oil demand to 102 million barrels per day before growth eases as the last phase of the pandemic economic rebound dissipates and as advancing energy efficiency gains, expanding electric vehicle fleets and structural factors reassert themselves. Despite growth that is almost two-thirds lower than this year's increase, global oil demand is set to rise to a record annual nigh of 102.9 million barrels per day in 2024.

Refinery margins collapsed in October from the near-record levels achieved during the third quarter of this year. Weaker gasoline cracks drove much of the decline, but still-elevated middle distillate cracks ensured margins remain above the five-year average. Global crude runs are expected to rise by 1.9 million barrels per day this year and 1 million barrels in 2024, to average 82.6 million barrels and 83.6 million barrels respectively. (IPA Service)

The incomparable James Baldwin pronounced with profound simplicity that "one writes out of one thing only - one's own experience," and from that experience tries to wrench out "the last drop, sweet or bitter it can give." How true of the writer's craft, even that of a lowly hack! This composition is, after a fashion, the upshot of an association of ideas, events and people relating to the experience of corruption. In the end, it is a story of a nemesis confronting hubris!

A recent essay on the monstrous corruption under the present regime provoked remonstrations from some critics who chastised me for describing the India Against Corruption (IAC) movement steered by Arvind Kejriwal as 'messianic' and a force for good, for ramming through the groundbreaking Lokpal Act in 2013. I was admonished for bestowing a halo on what was a sanctimonious and disingenuous middle-class uprising against political corruption that, in tandem with the infamous Comptroller and Auditor General of India (CAG) Vinod Rai and his trumped-up national loss of Rs 1.76 lakh crores to the Exchequer apropos of the 2G spectrum allotment, cleared the way for the alleged but now absolved conductor of Guiarat 2002.

In my critics' view, it was ultimately not about fighting corruption but a deep-rooted RSS-backed plot to wrest control of the polity. One should have but didn't smell the rat when Kejriwal roped in Hindutva icons Ramdev and Sri Sri Ravishankar to the IAC fold. Much later, Prashant Bhushan, one of IAC's leading lights, conceded that his outfit was "propped up by the

and Bharatiya Janata Party (BJP)".

Ironically, almost all my critics were at one time passionate devotees of Kejriwal and gang. Who wasn't? The entire country was initially suckered into believing the third-rate cops-and-robbers narrative spun by these self-righteous do-gooders.

A decade ago, Kejriwal and his cabal - with Anna Hazare as bewildered talisman - were perceived as starry-eyed idealists on a mission to awaken people to the rot in the system. Despite a host of seasoned professionals and intellectuals in the IAC, it was chief minister Arvind Kejriwal, the upstart who usurped the leadership mantle through sheer ingenious guile. To give the devil credit, he was undoubtedly the moving force in the crusade against corruption.

What was unknown at that time was his absolute craving for power. And his unbridled ambition was far from quenched by bringing the venal UPA government to its knees and forcing through the Lokpal Act. Having got a taste of power, albeit without accountability, he lusted for more. Kejriwal realised that the anti-corruption movement had run its course and he needed to migrate to where the real power was to remain relevant in the public sphere.


In late 2012, Kejriwal broke away from Anna Hazare who had, in any case, expended his usefulness as titular head of the anti-corruption campaign. But the rumoured trigger for the parting of ways was the issue of converting the IAC movement into a political entity. Even as the old man faded into insignificance, Kejriwal formed the Aam Aadmi Party (AAP), determined to exploit the mass public support and goodwill generated by the



IAC movement. His instincts were spot on as the new kids on the block emerged ahead of the Congress and BJP with 28 of the 70 Assembly seats in the 2013 Delhi election.

In the 2015 Delhi assembly elections, this fledgling party won a resounding victory, claiming 67 of the 70 seats, decimating the two major political parties. AAP struck a chord among all sections of the masses with its message of a moral political order based on the sovereignty of the people and devolution of powers to the grassroots.

It denounced caste and communitybased politics and upheld the dignity of the individual and her right to essential goods including free water and subsidised electricity. It purveyed an ideological neutrality that sought to absorb the best in capitalism and socialism. A party comprising academics, lawyers, technocrats, bureaucrats, actors, holy men, et al spoke an audacious democratic idiom that held out hope of a brave new form of governance free of corruption and based on the well-being and collective will of the people.



There are striking similarities between Kejriwal and the Vishwaguru. Although the bush shirted and mufflered aam aadmi (common man) is sartorially very different from the dandy accoutred in Maybach shades and flashy kurtas, they share much in common. They are machiavellian realists possessed of an all-consuming lust for power, who refuse to be distracted by considerations of right and wrong. They traffic in falsehoods and are so addicted to lying that exaggeration is their nearest link to the truth. They shamelessly parade religion in the public square for personal benefit, heedless of the damage it does to the secular fabric. They take credit when

things are going well but are deft at dire adversity. Long ago, Dante said deflecting blame when anything bombs. The universe is only about them!

Very early in the piece, Kejriwal decided to hitch his lot to self-serving power politics. Autocratic to the core, he went about neutralising anyone who was seen as a competitor or pricked his conscience. Much like the Vishwaguru who, without ado, consigned BJP's veteran leaders L.K. Advani and M.M. Joshi to the margdarshak back burner, Kejriwal's first significant move was to banish Prashant Bhushan and Yogendra Yadav who represented the conscience of AAP and incessantly reminded him of the moral code that was the raison d'etre of the party. In another cynical move, he nominated two nonentities a businessman and a CA belonging to his caste - to the Rajya Sabha, ignoring luminaries who had slaved for the party, provoking allegations that he had traded the seats.

Perhaps the clearest pointer to Kejriwal's metamorphosis into an amoral, power-hungry politician has been his stance on the Lokpal as head of the Delhi government. The Jan Lokpal Bill passed in 2015 by the Delhi assembly has still not been ratified into law - the casualty in an unending saga of obfuscation and bitter recrimination between the AAP and the Lieutenant Governor, neither keen on an independent ombudsman. Another indicator of his transformation into a hardened, reprobate leader was his abortive attempt to wrest control of the Anti-Corruption Bureau of the state in direct contravention of the IAC's sacred credo that anti-corruption units should be independent of the political executive.

that the hottest places in hell are reserved for those who are non-aligned in times of grave crisis. The riots in North-East Delhi in 2020 called Kejriwal out for the diabolically amoral politician that he is. The mayhem over four nightmarish days was an awful exhibition of human depravity, perhaps the worst since the Sikh pogrom in 1984. At this critical time, the chief minister went missing, using the fig leaf that law and order was not his domain. A man who has sought the limelight in every situation, played the artful dodger when his people needed him most for the treacherous reason that any intervention would antagonise the majority community; so he let people die.


English revolutionary Thomas Paine had people like Kejriwal in mind when he observed that the cunning of the fox is as murderous as the violence of the wolf.

How governments and global aid agencies use TB as a political tool

ot long ago, as India concluded its G-20 events, among its statements was an oft-repeated commitment to end tuberculosis in India by 2025. This coincided with reports of anti-TB drugs being out of stock in India. This dichotomy underlines the many truths about TB in India.

This week, the global TB community will come together again for the Union Conference in Paris to discuss solutions to end the disease. The usual suspects will attend, more of the same issues will be discussed and some token gestures will be made by the foreign agencies to include global advocates and voices

In truth, as such meetings unfold, rarely is any transformative work done on TB diagnosis, treatment or including communities in the discussions. In-



Bhutan's eight-day visit to India from November 3-10 is most likely aimed at mollifying India on the eve of a possible border deal with China. Recall that the King had visited New Delhi earlier this year in April as well. During the visit to New Delhi, the King met with Prime Minister Modi and senior officials of the government.

The government terms relations with Bhutan an "exemplary bilateral partnership" and the Joint Statement following the visit listed a range of areas in which the two cooperate. But the timing of the visit suggests that it is related to the fast-moving border talks between China and Bhutan. At the official level, though, there have been no indications that his subject has come up for discussions

Going by the Joint Statements issued after the King's visits, there was nothing remarkable. The visits were about furthering the already close India-Bhutan relations and their focus was on the multiple areas of cooperation between the two sides, primarily on hydropower and connectivity. However, two visits by the heads of state in one year is somewhat unusual even if the country is Bhutan, and is most likely linked to the Bhutan-China border talks

The key point of departure has been the "3-Step Roadmap", a Memorandum of Understanding (MoU), signed by China and Bhutan in October 2021 during the 10th round of their Expert Group Meeting (EGM) in Kunming, China, which envisaged a three-stage process. This involves, first, the delimitation of the border on maps through talks between the two sides, followed by joint surveys which would finally lead to an actual demarcation of the 477 km border between them. India's response at the time had been that it had noted the signing of the MoU and that like Bhutan, "India has similarly been holding boundary negotiations with China.'

Last month, China and Bhutan held their 25th round of border talks in Beijing. The previous 24th round had been held eight years earlier in 2016. The Bhutanese delegation was led by Lyonpo Tandi Dorji, the Foreign Minister of Bhutan and the Chinese one by Sun Weidong, Vice Foreign Minister of China. Sun is a former Chinese ambassador to India. Maj Gen (retd) V Namgyel, the Bhutanese ambassador to India and the Bhutan foreign secretary Pema Choden were part of the Bhutanese delegation

Beginning in January this year, there has been a quick sequence of Expert Group Meetings, that culminated in the 25th round of their border talks. The 11th round of Expert Group Meeting was held in Kunming in January 2023. In May, the two sides held their 12th round of their Expert Group Meeting in Thimphu, Bhutan, and said that they had made progress in discussing the "3-Step Roadmap" towards settling their border issue. In August, they held the 13th Expert Group Meeting in Beijing, followed by the 25th round of talks last month in Beijing.

During the 25th round of talks, the two sides signed a Cooperation Agreement detailing the functioning of the Joint Technical Team on the delimitation and demarcation of the Bhutan-China boundary that had been agreed to after the 13th Expert Group Meeting.

Dorji also met his Chinese counterpart Wang Yi and both sides indicated that they wanted a quick border set-

tiations and the establishment of diplomatic relations between China and Bhutan" would serve the fundamental interests of both countries. As of now, Bhutan does not have ties with any of the permanent members of the UN Security Council.

In an interview with The Hindu last month, the current Prime Minister of Bhutan, Lotay Tshering, whose term ends this month, had said that he expected progress to be made and confirmed that China and Bhutan were "inching" towards completing their 3-Step Roadmap and that the two sides had "managed two to three meetings and we feel we are nearing the completion of the threestep roadmap" and that the talks also included a possible tradeoff between Chinese claims in Doklam and the ones in northern Bhutan.

The main areas in dispute between China and Bhutan are 269 sq kms on the western border along the Chumbi Valley and two northern areas of Jakarlung and Pasamlung valleys measuring 495 sq kms. Since 2020, the Chinese have also raised an additional claim in eastern Bhutan. There are two important tri-junction points involving India, China, and Bhutan. The one in the west involves Doklam, and the one in the east is the eastern terminus of the McMahon Line which delineates the Sino-Indian border in the region. Doklam was also the site of an India-China standoff in 2017. This is the area where the India-China-Bhutan borders meet but India considers Doklam to be Bhutanese territory and is concerned that it could be ceded to China in the border settlement and enable them to overlook the sensitive Siliguri Corridor that links mainland India to the Northeastern region.

In April, the Foreign Secretary V M Kwatra had briefed the media on the visit. In response to direct questions as to whether there had been any discussions on the China-Bhutan border negotiations, especially Doklam, Kwatra noted that India and Bhutan remain in close touch and maintain "close coordination" relating to our national and security interests. As to the Doklam issue, he referred to the Ministry's earlier statements which "explicitly bring out our position on the determination of the trijunction boundary points.'

He was referring to the Ministry of External Affairs (MEA) statement at the onset of the 2017 Doklam crisis which had laid out the Indian view of how the crisis had unfolded. Further, it had revealed that in 2012, India and China "had reached an agreement that the tri-junction boundary points between India, China and third countries will be finalised in consultation with the concerned countries." Adding that any attempt "to unilaterally determine trijunction violates this understanding.³

In an interview with a Belgian newspaper in March, Tshering had more or less upheld the Indian position when he noted that "Doklam is a junction point between India, China and Bhutan. It is not up to Bhutan alone to fix the problem. There are three of us... We can discuss this as soon as the other two parties are ready.'

The border settlement, if and when it comes, will mark a major change in Bhutan's geopolitical perspective. But as for the present, the Bhutanese seem determined to press ahead. Their problem is the lack of capacity to police its borders and the deliberate Chinese pressure to press their claims. (Courtesy: ORF)

stead, such global conferences have become forums for neocolonial ambitions to play out and political posturing by international institutions and their domestic partner governments. In short, a meeting to maintain the power asymmetry in TB.

While talking innovation and rights, these global institutions and advocates quickly fall in line with domestic governments. A case in point being India, where even though reports of drug stockouts pile up, the government's efforts on TB continue to be applauded internationally

TB has enormous political currency as it affects numerous poor countries. In India, the poorest and most vulnerable are affected by TB. So it is appropriate for foreign-funded institutions, universities and academics and also domestic leaders to be seen as engaged in the moral battle to fight TB. It has an emotive value for millions of those affected and earns their support, creating an illusion of cooperation. It also resonates globally as the killer disease that devastates the poor everywhere.

It is the ideal story to tell the media, to make survivors repeat their stories and make it seem like change is imminent. After all, how can one not like leaders and organisations that promise to end TB in India and elsewhere?

Despite the political attention, however, the progress has been small. This is not an idea, systems or administrative problem. Instead, it is a power issue where TB is being used as a tool of neocolonisation with truth being the biggest casualty. Here, programmes are being set impossible targets, with international agencies and governments partnering to make it seem like action is being taken. Political considerations, not expertise, drive disease programmes.

Those affected still do not seem to have much-needed drugs and reliable tests, yet slogans talk of eliminating the disease. It's no surprise that curable TB kills an Indian every minute. Globally, communities are rallied to support and validate these efforts but they have little or no say in their design or implementation efforts.

For every issue that communities have raised over the past decade, domestic governments, with support from international partners, have converted it into clever campaigns about their work, parading community participation. It is evident that the commitment

to eliminate TB is unrealistic but it is a lie reiterated in meetings and policy documents. Yet, few know exactly how to do so.

Instead, at its core, the global and national strategy is focused on creating a positive media narrative that ignores and distracts from the realities of TBaffected communities. It is a way to implement ideas developed elsewhere, which can often be counterproductive. For instance in India, concrete action would mean revisiting how TB is diagnosed and treated and communities dealt with. This will require significant investment, reskilling and the reimaging of the entire system.

What, then, is the reality of TB? India's TB efforts, for instance, are underfunded, understaffed and also not trusted by the 50% of the country's TB affected who seek care in the private sector.

The first challenge often is TB diagnosis. Most Indians, even today, miss TB symptoms. India's healthcare providers routinely fail to order a TB test. TB is so stigmatised that many do not want to be tested fearing loss of job, family and community. In truth, even today, accurate and affordable diagnostics are highly delayed for most Indians. What no global partner ever asks is how India will eliminate TB if it does not diagnose it in time.

TB treatment remains equally challenging. As the current stockouts illustrate, public sector treatment can be unreliable and provides poor quality of care. The private sector, by comparison, gives the illusion of prompt diagnosis and treatment even though it is expensive and often inaccurate. Strategies that include neither communities nor the private sector abound, with foreign academics and institutions forcing definitions of what quality of care looks like. This represents cookie-cutter formulas that are presented to national governments and often adapted. Few ask the difficult questions - or even bother to ask the end user.

There have never been better options for treating TB. Numerous new shorter, more effective regimens promise reduced side effects and decreased suffering for TB patients. This, however, has been turned into a war field by pharmaceutical companies with support from international agencies to get governments to adopt them. They are needed

because TB treatment is exhausting and with numerous side effects. But how are they to be made affordable?

From mental health and stigma to neuropathy and long-term disability, the TB-affected struggle with side effects that most would barely tolerate. While talking of elimination, governments rarely announce plans to implement these new regimens. International agencies remain strategically silent on this as well. If India's commitment is real, there should be no struggle with stockouts or long toxic treatment.

Another case in point is the relationship between undernutrition and TB. How do hungry people eat toxic medicines? In India, the government's Nikshay Poshan Yojana gives a Rs 500 to those affected by TB. Despite requests, this amount has never been raised. What is troubling is that the state is now outsourcing these nutritional needs through the TB Mitra Scheme, describing it as a people's movement. This leaves the TB-affected helpless and reliant on the goodwill of fellow citizens.

What the government should be doing is providing food security to India's vast population as a preventive measure. Yet, international agencies cheer on official programmes as progress when it is an abdication and dilution of the state's ethical and legal responsibility.

While the political value of TB is clear, its route to elimination is not. Conversations need to be led by the global south but instead; these countries are merely offered a seat at the table. Even today in India, TB survivors are used as underpaid labour, with support from international agencies, to fight and end TB. The irony of this is not lost on them.

A final case is the growing use of community voices that are co-opted to make these efforts look good. Now and then, like at the TB conference, survivors are paraded to share their stories. When this is done, the governments and international agencies pat each other on the back for an inclusive media campaign well done.

While thousands die every day from this curable disease, governments and international agencies seem busy using it as a far-reaching political tool to maintain the status quo. (Courtesy: Scroll.in)

US and China agree to resume military communications during Biden-Xi summit

WOODSIDE, Nov 16: US President Joe Biden and his Chinese counterpart Xi Jinping have agreed to resume high-level military-to-military communication and counter-narcotics cooperation as they met for four hours in a bid to establish a working relationship amidst Beijing's aggressive actions in the Indo-Pacific region.

The two leaders also affirmed the need to address the risks of advanced artificial intelligence (AI) systems and improve AI safety through US-China government talks during their meeting on the sidelines of the Asia-Pacific Economic Cooperation summit in San Francisco.

Biden said since their last meeting in Bali, on the sidelines of the G20, the key members of the two governments have had important discussions on issues that matter to both the nations and to the world.

"But as always, there's no substitute for face-to-face discussions. I've always found our discussions straightforward and frank, and I've always appreci ated them," Biden said. Observing that he has known Xi for a long time, Biden said they haven't always agreed, which was not surprising to anyone.

"But our meetings have always been candid, straightforward, and useful. I've never doubted what you've told me in terms of your candid nature in what you speak. I value our conversation because I think it's paramount that you and I understand each other clearly, leader to leader with no misconceptions or miscommunication," said the US president.

Both the countries should lead by example, step up coordination and cooperation on international and regional issues, and provide more public goods for the world, he said.

The two sides should keep their initiatives open to each other, or coordinate and connect them for synergy, Xi said. (PTI)

Biden says he still believes Xi Jinping is a dictator

WOODSIDE (CALIFORNIA), Nov 16: US President Joe Biden has once again called his Chinese counterpart Xi Jinping a "dictator", just hours after they met for the first time in more than a year and held candid and productive discussions to revive bilateral ties.

The two leaders met on the sidelines of the Asia-Pacific Economic Cooperation summit in San Francisco.

"Well, look, he is (a dictator)," Biden told reporters in response to a question when reminded about the similar remarks he had made about Xi early this year.

"I mean, he's a dictator in the sense that he is a guy who runs a country that is a communist country that's based on a form of government totally different than ours," Biden, 80, said.

"Anyway, we made progress," he said about the four-hour-long meeting, the first in-person summit since they met on the sidelines of the G20 Summit in Bali. Indonesia in November 2022.

Biden previously compared Xi, 70, to dictators during a June political fundraiser in California as he discussed Xi's reaction to US fighter jets shooting down a Chinese spy balloon over American airspace in February.

The latest remarks could spark a possible backlash from China. The last time Biden called Xi a dictator, at a June fundraiser in Northern California, Chinese officials called the remarks absurd and a provocation. Biden's comment could also threaten to derail the positive energy coming out of the meeting, which Biden described earlier in the news conference as "some of the most constructive and productive discussions we've had." (PTI)

3 police constables taken hostage by armed men: Balochistan

KARACHI, Nov 16: Heavilyarmed men have taken three police constables hostage after they attacked a security checkpoint in Pakistan's restive Balochistan province, officials have said. The incident took place on Wednesday at the police checkpoint in Turbat. The armed men, besides taking three constables hostage, also took away their official submachine guns and ammunition. There were around 6-8 heavily

armed men who attacked the checkpost, officials said.

However, no one has claimed responsibility for the attack. Meanwhile, in the capital city of Quetta, security forces arrested a man who forcibly entered the cantonment area late on Wednesday evening without stopping at the entry checkpoint and proving his identity, officials said.

They said the suspect, identified as Essa Khan, drove a Suzuki van into the Quetta cantonment area without stopping for identification at the security post at one of the entry points.

After he drove through the main gate, security was put on high alert, and he was later arrested inside the cantonment area with the vehicle.

Bordering Afghanistan and Iran, Balochistan is Pakistan's largest province and has frequently been hit by terror groups, including the Tehrik-e Taliban Pakistan (TTP) and the Islamic State group. (PTI)

KHAN YOUNIS, Nov 16: Israeli forces dropped leaflets warning Palestinians to flee parts of southern Gaza, residents said on Thursday, signaling a possible expansion of operations to areas where hundreds of thousands of people who heeded earlier evacuation orders are crowded into U.N.-run shelters and family homes.

Meanwhile, soldiers continued searching Shifa Hospital in the north, in a raid that began early Wednesday but has yet to uncover evidence of the central Hamas command center that Israel has said is concealed beneath the complex. Hamas and staff at the hospital, Gaza's largest, deny the allegations.

Broadening the offensive to the south — where Israel already carries out daily air raids — threatens to worsen an already severe humanitarian crisis in the besieged territory. Over 1.5 million people have been internally displaced in Gaza, with most having fled to the south, where food, water and electricity are increasingly scarce.

The war, now in its sixth week, was triggered by a wide-ranging Hamas attack into southern Israel on Oct. 7 in which the militants killed over 1,200 people, mostly civilians, and captured some 240 men, women and children. Israel responded with a weekslong air campaign and a ground invasion of northern Gaza, vowing to remove Hamas from power and crush its military capabilities.

More than 11,200 Palestinians have been killed, two-thirds of them women and minors, according to Palestinian health authorities. Another 2,700 have been reported missing, with most believed to be buried under the rubble. The official count does not differentiate between civilian and militant

deaths. Israeli troops on Wednesday stormed into Gaza's largest hospital, searching for traces of Hamas inside and beneath the facility, where newborns and hundreds of other patients have suffered for days without electricity and other basic necessities.

The military released video from inside Shifa showed three duffel bags it said it found hidden around an MRI lab, each containing an assault rifle, grenades and Hamas uniforms, as well as a closet that contained a number of assault rifles without ammunition clips. The Associated Press could not independently verify the Israeli claims that the weapons were found inside the hospital.

Hamas and Gaza health officials deny militants operate in Shifa — a hospital that employs some 1,500 people and has more than 500 beds. The Palestinians and rights groups accuse Israel of recklessly endangering civilians.

Munir al-Boursh, a senior official with Gaza's Health Ministry inside the hospital, said that for hours, the troops ransacked the basement and other buildings, including those housing the emergency and surgery departments, and searched the grounds for tunnels. Troops questioned and face-screened patients, staff and people sheltering in the facility, he said, adding that he did not know if any were detained.

no reports of any fighting within the hospital after Israeli troops entered.

The military said it was carrying out a "precise and targeted operation" in a specific area of the hospital, and that its soldiers were accompanied by medical teams bringing in incubators and other supplies.

At one point, tens of thousands of Palestinians fleeing Israeli bombardment were sheltering at Shifa, but most left in recent days as the fighting drew closer. The fate of premature babies at the hospital has drawn particular concern.

The Health Ministry said 40 patients, including three babies, have died since Shifa's emergency generator ran out of fuel Saturday. There was no immediate word on the condition of another 36 babies, who the ministry said earlier were at risk of dving because there is no power for incubators.

The leaflets, dropped in areas east of the southern town of Khan Younis, warned civilians to evacuate the area and saying anyone in the vicinity of militants or their positions "is putting his life in danger." Similar leaflets were dropped over northern Gaza for weeks ahead of the ground invasion.

Two local reporters who live east of Khan Younis confirmed seeing the leaflets. Others shared images of the leaflets on social media.

26 killed in Chinese coal company office fire

BEIJING, Nov 16: At least 26 people were killed and more than 60 injured after a fire tore through a building of a coal mine company in north China's Shanxi province on Thursday, state media reported.

The fire started at the second floor of the five-story building located in Lishi District of Lyuliang City at around 6.50 am (local time).

Twenty-six people were killed in the fire and more than 60 people have been sent to a local hospital for treatment, state-run Xinhua news agency reported.

The fire has been brought under control and rescue efforts are underway, the Global Times newspaper reported.

The building belongs to a private coal mine company.

Industrial accidents are common in China due to lax safety standards and poor enforcement. (PTI)

Troops were searching the underground levels of the hospital on Thursday and detained technicians responsible for running its equipment, the Health Ministry in Hamas-run Gaza said in a statement. After encircling Shifa for days, Israel faced pres-

sure to prove its claim that Hamas was using the

"Patients, women and children are terrified," he told the AP by phone Wednesday.

The military said its troops killed four militants outside the hospital at the start of the operation, but through days of fighting there were no reports of militants firing from inside Shifa. There were also

On Thursday, the military said it had blown up a residence belonging to Ismail Haniyeh, a senior Hamas leader based abroad. It was unclear if anyone was inside the building.

The bridge was inaugurated by state minister for roads and bridges Samdup Lepcha in the presence of officials of the Indian Army, BRO and civil administration. (PTI)


Police station inaugurated at Sevochung town

Rajasthan polls: BJP pledges LPG subsidy, completion of Eastern Canal Project

'Mahila thana' will be set up in every district and 'mahila desk' in every police station besides an anti-romeo squad in every city

JAIPUR, Nov 16: The BJP on Thursday released its manifesto for the Rajasthan assembly polls, promising to provide LPG cylinder for ₹ 450 each to Ujjawala scheme beneficiaries, 2.5 lakh government jobs in five years and increasing the financial assistance to farmers under the PM-Kisan scheme.

Releasing the 'sankalp patra' here, party chief J P Nadda also said that if the BJP forms the government in the state, a Special Investigation Team will be formed to probe paper leaks and other alleged scams in the Congress government.

The manifesto said an arrangement to procure wheat at ₹ 2,700 per quintal, including bonus above MSP, will be made and financial assistance under PM Kisan Samman Nidhi will be increased to ₹ 12,000 per year.

Under the Pradhan Mantri Kisan Samman Nidhi (PM-Kisan), which aims to support farmers in meeting their agricultural and other incidental needs, a financial assistance of ₹ 6,000 per year is at present transferred to bank accounts of farmers in three equal installment.

The manifesto also promises completion of the Eastern Rajasthan Canal Project (ERCP) in a time bound manner in collaboration with the Centre.

The Congress has been demanding national project status to the ERCP which was envisaged by the former BJP government to address irrigation and drinking water problems in a 13 eastern Rajasthan districts.

Nadda said a compensation policy for farmers whose land was auctioned will be brought and noted that land of 19,400 farmers was auc-

Pledging a slew of schemes for girls and women, he said a 'mahila thana' will be set up in every district and 'mahila desk' in every police station besides an anti-romeo squad in every city.

He also announced a savings bond of $\gtrless 2$ lakh on birth of girl child under Lado Protsahan Yojna, skill training to nearly six lakh rural women under Lakhpati Didi scheme, scooty to meritorious girls on clearing class 12 exam, free education from KG to PG to girls of poor families, three Mahila Police Battalions and increase in financial assistance under the PM Matru Vandan scheme from ₹ 5,000 to ₹8.000

For the youth, the party announced 2.5 lakh government jobs in five years, annual assistance of ₹ 12,000 for students of poor families to purchase school bags, books and uniform and setting up of Rajasthan Institute of Technology and Rajasthan Institute of Medical Sciences in every division.

In the health sector, the party pledged an investment of ₹ 40,000 crore through the Bhamashah Health Infrastructure Mission and appointment of 15,000 doctors and 20,000 paramedical staff.

Besides a white paper on corruption cases of the Congress government and strict action, the party promised round-the-clock electricity supply in domestic sector, expansion of Jaipur Metro, transparent transfer policy, free ration to poor families under PM Garib Kalyan Yojna for five years, increase in old age pension and pension of ₹ 1500 per month for the disabled.

The party said in the manifesto that it is committed to make Rajasthan a 350 billion



dollar economy

In the manifesto, the party also promised to set up the Rajasthan Economic Revival Task Force for the revival of the state economy.

'We will make Jaipur, Udaipur, Kota, Ajmer, Bharatpur, Jodhpur and Bikaner smart cities in collaboration with the central government," the manifesto said.

A special police cell for investigating sleeper cells of anti-national forces and antigangster task force to stop gang wars was also among the promises made

BJP's election in-charge for Rajasthan and union minister Pralhad Joshi, BJP in charge for Rajasthan Arun Singh, state president CP Joshi, former chief minister Vasundhara Raje and other leaders were present during the release of the manifesto.

Defence min Rajnath holds conversation with US counterpart Austin in Jakarta

NEW DELHI, Nov 16: Defence minister Rajnath Singh held a brief conversation with his American counterpart, Lloyd Austin, in Jakarta on Thursday, focusing on the India-US strategic ties and ways to strengthen the common efforts towards a more secure world.

In the interaction that took place on the sidelines of the ASEAN Defence Ministers' Meeting Plus (ADMM-Plus), Singh and Austin discussed how India and the United States could contribute together to ASEAN centrality in the Indo-Pacific region, officials said. Ten-nation regional grouping ASEAN (Association of Southeast Asian Nations) is a major stakeholder in the Indo-Pacific.

The ADMM-Plus is a platform comprising the 10-nation ASEAN and its eight dialogue partners --India, China, Australia, Japan, New Zealand, Republic of Korea, Russia and the US.

Indonesia is hosting the meeting as the current chair of the ADMM-Plus.

The Singh-Austin conversation came less than a week after the two ministers held wide-ranging talks in New Delhi that centred around an ambitious agenda to deepen the India-US bilateral strategic ties in the face of China's increasing mil-

itary assertiveness Indian officials said both leaders used the opportunity in Jakarta to quickly review the "tremendous

rogress" achieved in the India-US defence partnership in recent



They discussed how the two countries could contribute together to ASEAN centrality in the Indo-Pacific and to advance "peace, prosperity and security"

Singh and Austin also discussed ways to expand the India-US partnership to address emerging challenges and further strengthen the common efforts towards a more secure world, the officials said.

The two leaders met in New Delhi on November 10 and resolved to advance the defence technology cooperation with joint research in emerging areas.

US secretary of state Antony Blinken and defence secretary Austin travelled to India last week to attend the fifth edition of the '2+2" ministerial dialogue with their Indian counterparts.

UTTARKASHI, Nov 16: A heavyduty drilling machine flown in by the IAF from Delhi began boring through the rubble of a collapsed tunnel on the Char Dham route in Uttarakhand Thursday, in a fresh attempt to create an escape passage for 40 workers trapped inside for four days

Workers outside the Silkyara tunnel performed a puja before the America-made auger machine began work

Union Minister of State for Road Transport and Highways V K Singh had arrived at the site to take stock of the rescue operation when the drilling by the new machine began.

The Indian Air Force (IAF) had flown in the equipment in parts on their C-130 Hercules transport planes to an airstrip 30 kilometres away, after previous efforts to insert steel pipes into the rubble with the help of a smaller auger machine

"I have been told that the new drilling machine has already penetrated 5-7 metres through the debris. We hope it would soon reach the trapped workers, drilling at the rate of 5-10 metres every hour," chief minister Pushkar Dhami told reporters in Dehradun.

Officials had earlier said that a 30-40 metre stretch of the underconstruction had collapsed on Sunday. The collapsed section is 270 metres from the mouth of the tunnel from the Silkyara side.

The workers are stranded on the other side of debris. They are safe, and being provided with oxygen, electricity, medicines, food items and water through pipes, Navayuga Engineering Company's spokesperson G L Nath said. The company is building the tunnel on behalf of the National Highways and Infrastructure Development Corporation Limited (NHIDCL).

800-mm and 900-mm diameter will be inserted -- one after the other -into the drilled passage. Once this happens, the workers trapped inside can crawl out to safety

A six-bed makeshift health facility has been set up and 10 ambulances with expert doctors stationed outside the tunnel to provide immediate medical care to the trapped workers after their evacuation, officials said

The state government is providing all support to the technical experts supervising the rescue operations on the spot, Dhami said and added that they are in touch with international special-He said Prime Minister Naren-

dra Modi is constantly monitoring the situation.

The Uttarakhand government has decided to review all underconstruction tunnels in the state,

"We need such tunnels and many of them are being built in the state. We will review wherever they are being constructed," he said.

The auger machine was flown in after the first drilling machine turned out to be too slow and technical issues developed, the officials said. Also, falling debris inside the tunnel damaged the first equipment and injured two rescue workers on Tuesday.

The 25-ton new auger machine has a capacity to drill 4-5 metres per hour. NHIDCL director Anshu Manish Khalkho said earlier. After being brought to the site, the machine was installed through the night and made operational on Thursday.

The portion of the tunnel, part of the ambitious Char Dham allweather road project, collapsed due to a landslide on Sunday.

K'taka CM's son embroiled in controversy after viral video; JD(S) & BJP target Siddaramaiah

BENGALURU, Nov 16: Karnataka chief minister Siddaramaiah's son Yathindra Siddaramaiah found himself embroiled in a controversy on Thursday after a video, where he was seen issuing certain instructions on the phone, went viral on social media.

Hurling corruption charges against him, former chief minister and JD(S) leader H D Kumaraswamy hit out at the chief minister Siddaramaiah, alleging that the conversation was related to the "transfer (of government servants) business".

Chief minister Siddaramaiah, his deputy D K Shivakumar and others from the ruling party said the phone conversations were regarding development of four to five schools using the Corporate Social Responsibility (CSR) funds.

Siddaramaiah even said that he would retire from politics if even one instance is presented with proof that he had made money by transferring officials.

In the video, Yathindra, a former Congress MLA, is heard saying, "Hello Appa (Father), Vivekananda! To where? No I didn't give that. Give it (phone) to Mahadeva. I had given only five." Then he speaks to Mahadeva, saying, "Ma-

hadeva, why are you giving something ...? Who has given that? Nothing but whatever 4-5 I have given, that alone should be done." According to Kumaraswamy, Yathindra spoke to

R Mahadeva, a sub-registrar at Ganganagar in Bengaluru, who has been appointed as the CM's Officer on Special Duty.

Demanding an investigation into the whole episode, the JD(S) state president sought to know which list Yathindra was speaking about and who was Vivekananda in the conversation.

Directing his questions at Siddaramaiah, Kumaraswamy asked, "Why did you call him (son Yathindra) and which list is that?"

Taking a dig at the CM, Kumaraswamy said, "What is his (CM's) role? Is it his job to call his son and ask him what to do?"

The BJP too came down heavily on the Chief Minister and his son Yathindra.

"This shadow CM (Yathindra) is more powerful than CM! The ex-MLA Yathindra gave an order to Chief Minister Siddaramaiah that he should do only what 'I have given him' and not more than that,"

the BJP posted on social media platform X. Chief minister Siddaramaiah is only occupying a nominal position and all power and administration belongs to his son Yathindra, the BJP alleged, remarking that the post of chief minister is "vacant in the state"

Speaking to reporters, Siddaramaiah clarified that the conversation was related to the school buildings being constructed with CSR funds. He claimed that social welfare minister H C Mahadevappa had given the list.

Talking about the video, the chief minister said he would retire from politics if it was shown that he had made money through transfers in his political career.

Shivakumar, also the Karnataka Congress chief, too said the conversation was related to school development with CSR funds.

Yathindra being the member of the Karnataka Development Programme and chairman of the Ashraya Samiti was talking about utilisation of CSR funds to provide benches and other furniture in the schools he had chosen, he said. (*PTI*)

ED issues fresh summons to American millionaire Singham in NewsClick money laundering case

NEW DELHI, Nov 16: The Enforcement Directorate has issued fresh summons to American millionaire Neville Roy Singham for questioning in connection with a money laundering investigation linked to online news portal NewsClick, official sources said Thursday.

The businessman, who is accused of spreading Chinese propaganda in India, is stated to be currently based in Shanghai, China. The ED has issued fresh summons to Singham under the provisions of the

Prevention of Money Laundering Act (PMLA). This is a fresh notice issued to him after the agency got issued Letters Rogatory (LR) from a local court seeking to record his statement, the sources said.

The summons have been sent to Singham on his email id and through the Chinese government channels, after the ED routed them through the Ministry of External Affairs (MEA). This is understood to be second summons issued to Singham by the ED after one was issued last year after the investigation was launched in 2021.

Singham's name hit the headlines again few months back in a New York Times article.

The Delhi Police, following this news piece and some "evidence" shared by ED, had also filed a FIR against him and the founders of NewsClick after this news report came

In a statement issued to The Hindu newspaper in October, Singham had said that the language used in the FIR filed by the Special Cell of Delhi Police "strongly suggests" that the claims were "influenced by misinformation from an article published by The New York Times."

"The NYT intentionally chose not to publish all the factual rebuttals that I provided to them on July 22, 2023, prior to their publication date," Singham had charged.

He also rejected the allegation of fraudulent infusion of funds through a "complex web of several entities" as mentioned in the FIR and in the NYT article.

The New York Times report claimed that NewsClick was part of a global network that received funding from Singham, who allegedly works closely with the Chinese government media machine.

The Enforcement Directorate had first raided the premises of NewsClick in Saidulajab area of the national capital in September, 2021 on charges of money laundering.

The agency has recorded the statements of more than 25 people in this case, including that of NewsClick founder and Editor-in-chief Prabir Purkayastha

It last year attached a flat in south Delhi's Saket worth 4.52 crore, which is linked to Purkayastha apart from fixed deposits worth ₹ 41 lakh as part of this investigation. (PTI)

NCB team picks up 4 students from Koraput in ganja trafficking case

KORAPUT, Nov 16: A Narcotics Control Bureau (NCB) team detained a panchavat samiti member and four college students from Jeypore in Odisha's Koraput district for their alleged involvement in ganja trafficking, police said. A team from the NCB regional office in Bengaluru conducted a raid on a rented residence in the Parabeda area of Jeypore, where the students were residing. The operation took place on Tuesday night.

The NCB had recently apprehended some ganja traffickers in Karnataka. During interrogation, the arrested traffickers in Karnataka disclosed their links with the students in Odisha, identifying them as their suppliers. Superintendent of Police, Koraput, Avinash Sonkar said that the NCB team did not inform them about the raid.

"Currently, we are in contact with them to obtain further details of the case," the SP said. (PTI)

NEW DELHI, Nov 16: Over 25 crore households across India have the potential to deploy 637 GW of solar energy capacity on rooftops, according to a new independent report by the Council on Energy, Environment and Water (CEEW) released on Thursday.

The CEEW report said that deploying just one-third of this total solar technical potential could support the entire electricity demand of India's residential sector (about 310 TWh).

However, the technical potential reduces to one-fifth (118 GW) after factoring in the current electricity consumption of households.

"Most residential consumers fall into low-consumption slabs and solar may not be economically feasible for them without financial support even though it is technically possible.

"The potential reduces further to 11 GW when no capital subsidy is considered, the payback period for rooftop solar is restricted to five years and we factor in consumers' willingness to buy rooftop solar," the report said. Currently, India has installed 11 GW of rooftop solar capacity, of which

only 2.7 GW is in the residential sector.

The CEEW report did a bottom-up analysis across 21 Indian states that cover 97 per cent of the country's population.

It found that 60 per cent of the residential rooftop potential was concentrated in just seven states - Uttar Pradesh, Maharashtra, West Bengal, Odisha, Rajasthan, Andhra Pradesh, and Tamil Nadu.

India's rooftop solar potential is spread geographically across states in contrast to other renewable technologies like utility-scale solar and wind projects, and could be critical to the energy transition ambitions of states.



Rooftop solar potential could be critical to energy

transition in India, should be incentivised: Study

Moreover, rural areas show higher technical potential based on residential rooftop area (363 GW) compared to urban areas across states (274 GW). Arunabha Ghosh, the CEO of CEEW, said that India's solar energy revolution – going from 2,000 MW of solar power capacity in 2010 to 72,018 MW now - must reach households too to achieve its full potential. "CEEW's study shows the mammoth capacity of solar systems that both rural and urban households can deploy to guarantee not only a transition to clean energy but also fulfil a basic need - access to power.

"But to get there, residents must get the right price and attractive incentives

and enjoy a convenient experience, which can then spur the markets to create the right products and capacities for homes," he said.

The CEEW report also found that residential awareness of rooftop solar systems was less than 50 per cent at the national level in FY 2020.

Awareness in most states was clustered between 30 and 50 per cent. When it came to willingness to install rooftop solar systems, residential consumers in Gujarat showed the highest willingness at 13 per cent, compared to the national average of 5 per cent.

However, residents across states perceive rooftop solar systems to be costly investments, impacting their willingness to pay.

According to another CEEW study released on Thursday, solarising residential households also offers huge economic benefits to power distribution companies (discoms).

The study on solarising rural households in Bihar and Meghalaya highlights lifetime economic gains to the tune of ₹ 2,700 crore per 100 MW of olar capacity to discoms

The benefits will be due to reduced cross-subsidy burden, improved transmission and distribution losses, and lower average cost to serve consumers.

The CEEW study recommended introducing targeted capital subsidies for consumers, particularly for rooftop solar system sizes of 0-3 kW, and recognising systems below 1 kW in policies and regulations.

Further, for consumers, states should create a one-stop platform for rooftop solar to provide basic, reliable, and compelling information about rooftop solar. At the national level, there is a need to roll out awareness campaigns to generate demand. (PTI)

Delhi govt sends Bamnoli land acquisition report to CBI, ED; seeks probe

NEW DELHI, Nov 16: The Delhi government has sent to the CBI and the ED a report of Vigilance Minister Atishi alleging "prima facie complicity" of Chief Secretary Naresh Kumar in the Bamnoli land acquisition matter, requesting a probe, government sources said on Thursday. Kumar has denied any wrongdoing and alleged that "mudslinging" was being done by people with vested interests" against whom vigilance action was taken for corruption.

On Wednesday, the 670-page report of Vigilance Minister Atishi was submitted to Lieutenant Governor V K Saxena by Chief Minister Arvind Kejriwal's office. It has demanded Kumar's suspension and claimed that the scale of "undue benefits" in the matter was more than Rs 897 crore.

"The report was referred to the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED) after the chief minister gave his go ahead," a source said. Compensation for 19-acre land in southwest Delhi's Bamnoli village for the NHAI's Dwarka Expressway project was allegedly raised from ₹ 41 crore to ₹ 353 crore but the report claimed that the "scale of undue benefits" in the deal was more than ₹ 897 crore. The vigilance minister's report was an outcome of an inquiry into a complaint that alleged that the chief secretary's son was employed by a person, who was a relative of beneficiary landowners in Bamnoli. The sources said Atishi wrote to the directors of CBI and ED that it was understood that certain aspects related to the matter, including the action of the then southwest Delhi District Magistrate Hemant Kumar in enhancing the land compensation "exorbitantly", were already referred by the Delhi LG to the CBI. However, according to the report, the then district magistrate "may just have executed the unlawful directions of his superiors" and, therefore, the chief secretary's role too should be investigated, the minister pointed to the CBI and the ED in her letters.

The government sources said the vigilance minister mentioned in her letter to the CBI director that after the preliminary investigation, it appeared that in view of the scale of the alleged corruption and "prima facie" establishment of the "abuse of authority" by the high-ranking officials, this case should come under the purview of the Prevention of Corruption Act 1988.

Reacting to the latest development, sources in the chief secretary's office said the CBI inquiry was already ordered by the Government of India in October on his recommendations as chief vigilance officer of Delhi government.

"There is nothing new in it and it seems they (AAP government) want to take credit for the same. It is a well known fact that whenever any instance of money laundering is observed by CBI, it refers the same to the Enforcement Directorate also," said a source in the CS office. The sources in the CS office also alleged that every attempt was being made for his (Kumar's) removal since his reports paved way for exposures of "several scams" like those related to excise policy, power sector and construction of chief minister's residence. Last week, Prime Minister Trudeau underlined that a "fight" with India was not something Canada wanted to be having right now but reiterated his allegations and said Ottawa wants to "work constructively" with New Delhi on this "very serious matter". Foreign secretary Vinay Kwatra said India has conveyed to the US side its serious concerns over increasing activities of pro-Khalistani elements in Canada. "Insofar as Canada is concerned, we have been having very consistent conversations with all our friends and partners. Our position on this matter has been enunciated and explained in full detail on multiple occasions," Kwatra said in New Delhi recently. Days after Trudeau's allegations in September, India temporarily suspended the issuance of visas to Canadian citizens and asked Ottawa to downsize its diplomatic presence in the country to ensure parity.

India resumed some visa services in Canada last month, more than a month after they were suspended. On China, Jaishankar said that the 2020 deadly clash in the Galwan Valley has vitiated the relationship between the two countries. He said China did not adhere to the agreements of 1993 and 1996 not to amass troops at the Line of Actual Control as he asserted that such acts of not following pacts have consequences in terms of credibility.

"It is important that agreements are kept. And then that doesn't happen that has consequences in terms of credibility and cost," he said. On updates on resolving the border issue with China, Jaishankar said: "Since September 2020, we have solved a number of these situations, but there are some which are still under discussion. So this is still under discussion." On another question, he said India helped in managing global inflation through a strategic approach to oil purchases amid the Russia-Ukraine war. While the West imposed sanctions and restrictions on Russia's oil exports since its war on Ukraine, India's refiners have been snapping up discounted Russian oil. "So we've actually softened the oil markets and the gas markets through our purchase policies. We have, as a consequence, actually managed global inflation. I'm waiting for the thank you," Jaishankar said.

The minister underlined India's strategic approach to oil purchases as a crucial factor in preventing a potential surge in global oil prices, thereby safeguarding the country's position in the international market against European competition. "When it comes to the purchase...I think the global oil prices would have gone higher because we would have gone into the same market to the same suppliers that Europe would have done and as we discovered Europe would have outpriced us," Jaishanakar said.

We saw that in the LNG markets where actually many supplies which were traditionally coming into Asia were diverted to Europe and in fact at least India was a big enough country to command some respect in the markets but there were much smaller countries who didn't even get responses to their tender in Paris because the LNG suppliers were no longer interested in dealing with them," he said. Speaking on America's power in the context of the changing world. Jaishankar said that America today is "reinventing itself" and becoming more open which is shaping the Indo-Pacific and creating multilateral bodies like the Quad. "I would say a divided America or a divided country would obviously be a less effective player on the international scene...America is the premier power of our times...I would say America has been actually, in the last few years, quite effective abroad in a variety of ways...I would say America today is a power which is reinventing itself. I don't think it's a power which is declining," he said. On India's relations with Taiwan amid tensions with China, Jaishankar said, "We have substantial technology and economic and commercial relations with Taiwan and certainly Taiwan has a reputation when it comes to electronics and of course, more recently with semiconductors. So, there has been an upswing in the levels of cooperation." On another question, Jaishankar said that the tolerance in India has not gone down but Indians today are "more authentic" and less hypocritical about their beliefs, traditions and culture. "For us, secularism does not mean being non-religious, but equal respect to all faiths. But what happened...we got into vote bank politics, a minoritarian pandering, that created backlash. In the name of equality of all religions, the biggest religion had to be self-deprecatory, and play itself down," he said. "I'll say we are more Indian, we are more authentic," he said. (PTI)

Delhi's air quality severe, vehicular emissions largest contributor

category on Thursday as unfavourable meteorological conditions hindered the dispersion of pollutants.

Recent findings from a joint project by the Delhi government and IIT-Kanpur found that vehicular emissions accounted for about 38 per cent of the capital's air pollution on Wednesday. This reduced to 25 per cent on Thursday.

Secondary inorganic aerosols -- particles such as sulfate and nitrate that are formed in the atmosphere due to the interaction of gases and particulate pollutants from sources like power plants, refineries, and vehicles -- is the second major contributor to Delhi's foul air, accounting for 30 to 35 per cent of the air pollution in the city over the last few days.

Calm winds and low temperatures are allowing accumulation of pollutants and relief is unlikely over the next few days, an official at the India Meteorological Department (IMD) said.

An improvement in the wind speed November 21 onwards might bring air pollution levels down, he said.

Delhi's 24-hour average Air Quality Index, recorded at 4 pm every day, stood at 419 on Thursday. It was 401 on Wednesday, 397 on Tuesday, 358 on Monday and 218 on Sunday, 220 on Saturday and 279 on Friday. Neighbouring Ghaziabad (376), Gurugram (363), Greater Noida (340), Noida (355) and Faridabad (424) also recorded very poor to severe air quality. An AQI between zero and 50 is considered good, 51 and 100 satisfactory, 101 and 200 moderate, 201 and 300 poor, 301 and 400 very poor, 401 and 450 severe and above 450 severe plus.

Delhi's air quality dropped over the last few days despite the state government implementing stringent measures, including a ban on construction work and the entry of diesel-guzzling trucks into the city, to control pollution. According to IQAir, a Swiss company that specialises in air quality monitoring, Delhi was the most polluted city in the world on Thursday, followed by Baghdad and Lahore.

NEW DELHI, Nov 16: Delhi's air quality worsened within the severe showed stubble-burning accounted for 7.5 per cent of the air pollution in the capital on Thursday. It is likely to come down to 3.5 per cent on Friday and 3 per cent on Saturday.

An official of the Commission for Air Quality Management (CAQM) had earlier said stringent measures, including a ban on construction work and the entry of polluting trucks in the national capital, under the final stage of the central government's air pollution control plan called the Graded Response Action Plan (GRAP) will continue until further orders. The Delhi government on Thursday set up a six-member special task force to ensure strict implementation of measures outlined in the GRAP in the capital. Delhi's special secretary (environment) will head the STF whose members include senior officials from the departments of transport, traffic, revenue, Municipal Corporation of Delhi (MCD) and Public Works Department (PWD).

The STF will coordinate with all the departments involved in the enforcement of pollution control measures and submit a report to the government daily. Environment Minister Gopal Rai told reporters.

Earlier this week, Rai had said the city government may implement the odd-even car rationing scheme if the AQI crosses the 450 mark.

The government last week postponed the implementation of the scheme, which permits cars to operate on alternate days based on the odd or even last digit of their registration numbers, after a notable improvement in the city's air quality due to rain on Friday.

Doctors say breathing in the polluted air of Delhi is equivalent to the harmful effects of smoking approximately 10 cigarettes a day.

Prolonged exposure to high levels of pollution can cause or exacerbate respiratory problems such as asthma, bronchitis and chronic obstructive pulmonary disease (COPD) and dramatically raise the risk of cardiovascular disease, they said.

Unfavourable meteorological conditions, combined with vehicular emissions, paddy-straw burning, firecrackers and other local pollution sources, contribute to hazardous air quality levels in Delhi-NCR during winters. (PTI)

BENGALURU, Nov 16: Indo-Canadian pop singer Raghav Mathur, known for hits like 'Angel Eyes' and 'Desperado', says best is yet to come for the Indian-influenced soundscape in global pop music.

pop music. Mathur, who has just released 'Chingari', his second single this year, featuring Mumbai-based rapper Divine, has been one of the pioneers to introduce Indian-influenced hooks and samples from old Bollywood songs, redefining the sound of global pop music.

"I think we're entering a brand new dawn of what being Indian in the arts means. The Western record labels are threatened by the impact of the numbers and the way our culture can take a record to the top of the charts around the world. I think the best is yet to come for us," Mathur told PTI in a

Zoom interview. In 'Chingari', Mathur has also sampled a couple of lines from Kishore Kumar's song, 'Aadmi Jo Kehta Hai' from the 1974 film 'Majboor', starring Amitabh Bachchan.

"Divine is the most instrumental artist in the subcontinent in terms of legitimising hip-hop as a sound that is the future of pop music. It's such a privilege to work with him," says Mathur.

In the beginning of his career, Mathur says it was not easy to incorporate Indian sound into pop music. His first single, 'So Confused', released in dian roots. But it gained a foothold for him in the pop music world by reaching number 6 in the UK Singles Charts.

"On the back of that, I was able to put out some of my more Indian-centric work, starting with 'Can't Get Enough', which samples 'Kabhi Aar, Kabhi Paar' from 'Aar Paar'. A few more singles and an album kind of changed my trajectory," says Mathur.

NEW DELHI, Nov 16: Everybody loves to hate "a good bad guy", says "The Hunger Games: The Ballad of Songbirds & Snakes" star Tom Blyth, who is happy to have portrayed the younger version of villainous Coriolanus Snow, a role made popular by Hollywood veteran Donald Sutherland in the original movie franchise. Blyth, 28, said he was a teenager when he saw the Jennifer Lawrence-led "Hunger Games" films and Sutherland's performance as the tyrannical leader of the dystopian country of Panem stayed with him.

"I was a big fan of the original films

when I was a teenager, and I'm probably a bit embarrassed to admit that Donald Sutherland's character was my favourite in the franchise. He was so naughty that you're not supposed to admit that. But I think it was because his performance was so deliciously evil," Blyth told PTI in a virtual interview.

The story of "The Ballad of Songbirds & Snakes" is set decades before the events of the first "Hunger Games" movie, based on author Suzanne Collins book series of the same title that explored the world of a dystopian country and the simmering conflict between the Capitol

The actor, known for starring in British shows and movies such as "Benediction" and "Billy the Kid", has played Snow as a charmer. The new film's story is adapted from Collins' 2020 novel. "I think everyone loves to hate a good bad guy, right? If a bad guy is played well enough, then you really love to hate them. And he (Snow) is one of those and makes these choices that nobody else could have made. "So, getting to come back and play him 64 years before, lift the lid on why he has become so bad... As an actor, that's just the most exciting thing because you get to see him as a full-fledged human being who has all this depth and all these layers," Blyth said. The Francis Lawrence-directed film follows Snow as the last hope of a failing lineage that has fallen from grace in a post-war Capitol. Snow reluctantly accepts the assignment to mentor Lucy Gray Baird (Rachel Zegler), a Tribute from the impoverished District 12, in the 10th Hunger Games. But after Lucy's charm captivates the audience of Panem, Snow sees an opportunity to shift both their fates. (PTI)

Miller's fighting century propels South Africa to 212 against Australia

KOLKATA, Nov 16: David Miller absorbed extreme pressure with phenomenal ease on way to a rearguard 101, allowing South Africa to post a fighting 212 against Australia in the second World Cup semi-final here on Thursday.

Under gloomy and windy conditions, South Africa showed familiar signs of choking when their top-four Quinton De Kock (3), Temba Bavuma (0), Rassie van der Dussen (6) and Aiden Markram (10) departed cheaply to have them reeling at 24/4 in 12 overs.

Mitchell Starc (10-1-34-3) and Josh Hazlewood (8-3-12-2) were breathing fire making full use of the conditions, but after a 40-minute rain delay, it was the Miller show.

Miller's 116 ball-effort was his sixth ODI century and the first one for Proteas in a World Cup knockout game. The southpaw took a blow on his finger from a Josh Hazlewood snorter, but he remained steady and unleashed his 'Killermode' smashing eight fours and five sixes. On a turning wicket, Miller had little trouble and was brutal especially against Adam Zampa who leaked 55 runs from his seven overs. He reached the three-figure mark

by hitting Pat Cummins over square leg for a 94-metre six. His 95-run partnership with Heinrich Klaasen (47 off 48) gave South Africa the much-needed respite be-

fore part-time off-spinner Travis Head turned it on taking two wickets in two balls to dent South Africa's recovery. After Klaasen, Gerald Co-



Miller as they put together quick fifty-plus partnership for the seventh wicket. But it had a nightmarish end as Coetzee fell on the pull to Cummins flicking off the glove through to Josh Inglis. Replays showed the ball only hit his elbow, but he didn't take the review.

MUMBAI, Nov 16: New Zealand captain Kane Williamson doffed his cap to pacer Mohammed Shami and the India team after his side was outplayed in the World Cup semifinal here, saying that the bowling stalwart was one of the best in the world and Rohit Sharma's side the "best team".

India crushed New Zealand by 70 runs to book their place in the final to be played on Sunday, with their opponents in the summit clash to be decided after the Australia-South Africa showdown in Kolkata on Thursday.

New Zealand could only manage 327 in 48.5 overs chasing 398, with Shami producing a magical seven-wicket spell for his unprecedented third five-wicket haul in World Cup matches

Shami also took his tally to 23 wickets despite missing four matches at the start of the tournament to become the leading wicket-taker in the World Cup.

"He has been incredible. He has only played probably half the games and he might be close to top wicket-taker (position) and coming on first change, behind two outstanding new-ball bowlers," Williamson told the media after the loss. "He is, without a doubt, one of the top operators in the world and the way he moves the ball and he keeps bringing the stumps into play. It has been quite phenomenal, really, the amount of wickets he has got in such a small amount of games in this tournament. "That Indian team in all departments are firing without a doubt and I am sure they will be looking forward to their next opportunity in a few days' time," the

Kiwi skipper added. Terming India as the 'best team in the world', Willliamson said it is "tough" on the opposition to see all match," he said. (PTI)


