# 17,861 people granted citizenship, SC told Apex court reserves order on 17 petitions challenging validity of Section 6A of CA • Collection of data of illegal migrants impossible: Centre

NEW DELHI, Dec 12: The Supreme Court Tuesday reserved its order on petitions challenging the constitutional validity of Section 6A of the Citizenship Act (CA) related to grant of Indian citizenship to illegal immigrants in

A five-judge constitution bench headed by Chief Justice DY Chandrachud heard the submissions of attorney General R Venkataramani, solicitor general Tushar Mehta, senior advocates Shyam Divan, Kapil Sibal and others for four days before reserving the judgement.

The bench, also comprising Justices Surya Kant, M M Sundresh, J B Pardiwala and Manoj Misra, reserved order on 17 petitions questioning the constitutional validity of Section 6A, which was inserted into the Citizenship Act as a special



provision to deal with the citizenship of people covered under the Assam Accord

It says those who came to Assam on or after January 1, 1966 but before March 25, 1971 from specified territories, including Bangladesh, in accordance with the Citizenship Act amended in 1985, and since then are residents of the northeastern state, must register themselves

dian citizenship. As a result, the provision fixes

March 25, 1971 as the cut-off date for granting citizenship to migrants, particularly those from Bangladesh, residing in Assam.

Meanwhile, the Centre informed the apex court that it is not possible to collect data of illegal migrants living in various parts of the country as entry of foreign nationals is clandestine and surreptitious. In its affidavit filed in the top court which is examining the constitutional validity of section 6A of the Citizenship Act relating to illegal immigrants in Assam, the Centre said 17,861 people have been granted citizenship under the provision.

Answering the court's query posed on December 7, the Centre said 32,381 people have been detected as foreigners under the or-

ders of foreigners tribunal with reference to the period of 1966-1971.

Replying to the court's query about the estimated inflow of illegal immigrants into India, including but not confined to Assam after March 25, 1971, the Centre said illegal immigrants enter the country without valid travel documents in a clandestine and surreptitious manner. "The detection, detention and deportation of such illegally staying foreign nationals are a complex ongoing process. Since entry of such foreign nationals into the country is clandestine and surreptitious, it is not possible to collect accurate data of such illegal immigrants living in various parts of the country," the Centre said. The government said in the past five-years from 2017 to 2022, 14,346 foreigners were de-

**HT Bureau** GUWAHATI, Dec 12: Several organizations on Tuesday collectively pledged to rekindle a movement to oppose the Citizenship (Amendment) Act (CAA) if the government attempted the enforcement of the same.

The pledge was taken during memorial gatherings which were held across the state, including in Guwahati, orchestrated by political parties, student groups, and civil society organizations.

During the memorial gatherings, homage was offered to the five individuals who lost their lives in an anti-CAA protest in Assam four years ago. The state had witnessed widespread violent protests after the Citizenship (Amendment) Act or CAA was passed in Parliament in December 2019.

The All Assam Students' Union (AASU), which had been at the forefront of the anti-CAA movement, organised a memorial at Hatigaon Higher Secondary School field here.

Local residents also joined them in paying tributes to the five slain persons, including local teenager Sam Stafford, killed during the protests four years ago in different parts of the state. Similar memorial prayers were organised by the AASU across the state.

The memorial prayers were held

on December 12, 2019. AASU said it will continue stir against the CAA, and its partner organisations have also been staging protests against the Act in other

northeastern states as well. Independent legislator Akhil Gogoi, one of the prominent leaders of the anti-CAA agitation who was jailed for a prolonged period for his role as a Krishak Mukti Sangram Samiti (KMSS) leader in 2019, said the agitators were ready to take to the streets again if the government

tried to implement the Act. "KMSS has resolved once again today that we will resume our agitation if the government attempts to implement CAA. We will start taking the matter to the public once again and take to the streets again, if needed," he asserted.

Gogoi, who now heads Raijor Dal, a political party formed after the anti-CAA movement, paid tributes at a programme organised by KMSS. He also maintained that the anti-CAA agitation will go down the annals of history as one of the biggest movements and will serve as an inspiration for posterity.

Assam Jatiya Parishad (AJP), another political outfit born postanti CAA movement, also organised a memorial meeting at Panitola in Tinsukia district.

Party president Lurinjyoti Gogoi, who was the AASU general secretary in 2019, said the sacrifices made (CONTD. ON PAGE-9)

**NEW DELHI, Dec 12:** Finance minister Nirmala Sitahraman on Tuesday in the Lok Sabha said the economy is moving in the right direction, and India has become the fastest-growing major economy in

Replying to a debate on supplementary demands for grants, finance minister Sitharaman said fiscal prudence is the top priority of the government without compromising on social welfare.

The House later approved the supplementary demands for grants. allowing the government to spend an additional over ₹ 1.29 lakh crore, of which ₹ 58,378 crore would be the cash outgo in the current fiscal. The remaining ₹ 70,968 crore will be matched by the savings and receipts.

"Our economy is moving in the right direction...Macroeconomic omy. Q2 growth of 7.6 per cent is the highest in the world," she said.

Responding to issues raised by the Opposition members on BSNL, the minister further said the government has earmarked ₹ 11,850 crore capital infusion in the stateowned telecom firm.

GUWAHATI, Dec 12: Chief minister Himanta Biswa Sarma on Tuesday stated that maternal mortalities have dropped by more than 33 per cent, and child deaths decreased by nearly 15 per cent following the initiation of measures against child marriage in the state this year.

He vowed to eradicate child marriage by 2026 and informed that more than 5,000 people already arrested in multiple cases.

"Child marriage is a social evil, which also manifests undesirable health outcomes such as high infant and maternal mortality rates. Our crackdown has yielded encouraging results in women & child health sphere. By 2026, Assam will end this abhorrent practice," Sarma wrote micro-blogging site X. Highlighting the challenges, Sarma emphasized that Assam's infant mortality rate (IMR) and maternal mortality rates (MMR) surpass the national average, particularly in specific districts. He attributed the primary cause to

The chief minister said that in 2020, under-5 mortality in the state was 40 per cent, exceeding the national average of 32 per cent. As per sarma, the government's response involved

### Only 7 pc doctors aware of recent advances in anti-smoking strategies: Study

NEW DELHI, Dec 12: Only 7 per cent of doctors showed awareness about the recent advances in antismoking strategies, posing a significant challenge to the nation's efforts in combating tobacco addiction, a study conducted by the Indian Medical Academy for Preventive Health (IMAPH) said.

The study, based on a survey conducted among 200 doctors with a minimum of three years of experience, brought to light some eyeopening statistics.

Cardiovascular disease emerged as the most common reason for patient visits at 12 per cent, underscoring the urgent need for anti-smoking interventions.

Dr Chandrakant S Pandav, former head of the Department of



Community Medicine at the AIIMS-New Delhi, expressed concern stating, "The survey sheds light on the key role doctors play in motivating smokers to quit, emphasising the need for increased

awareness and training in implementing advanced anti-smoking strategies. The findings of the survey are a wake-up call. We need to bridge the awareness gap among doctors to effectively combat to-

Dr M Wali, senior consultant, Medicine at Sir Ganga Ram Hospital also underlined the importance of healthcare providers being well-informed about the latest smoke cessation approaches.

He said, "Effectiveness remains a critical factor in recommending cultural and region-specific methods to combat smoking, advocating the need for science-backed policy-making to arm doctors with safer options against tobacco addiction. Therefore, doctors must stay abreast of the latest developments to offer the best guidance. It's crucial for effective tobacco control which is successfully practised abroad." ## Job creation single most important pressure point: Rajan

### 'Nation needs to create jobs at every level going along the path of development'

NEW DELHI, Dec 12: Indian economy, dubbed the fastest growing major economy in the world, is faced with the single most important pressure point of job creation, says former RBI Governor Raghuram G Ranjan as he makes a strong case for improvement of human capital through skill development.

Talking about the book 'Breaking the mould: Reimagining India's economic future', written jointly by him and Rohit Lamba, assistant professor of economics at Pennsylvania State University, Rajan said one of the greatest strength of India is its human capital of 1.4 billion and the question is "how do you make it

The nation needs to create jobs at every level going along the path of development, said Rajan, presently Katherine Dusak Miller Distinguished Service Professor of Finance at Chicago Booth, USA.

"Jobs is the single most important pressure point... If we had many more private sector jobs showing up, would there be so much pressure on reservations? Perhaps there'll be less so to some extent," he said, regretting that states are trying to reserve jobs for their residents, which is a worrisome trend.

...that's a reflection of the fact that we're not providing jobs. And I would say that it is the primary concern. We are a united country. You can't reserve jobs in your state for people from the state. It has to be available for everybody. We've benefited so much from each other's migration," Rajan said in an interview to PTI.

Making a case for improvement of human capital, he



if we move some of them to vocational training", lots of jobs can be created in the next six months to a year and the nation will not have to wait for 10 years to generate employment.

Citing an example, he said, "one place where we are severely understaffed is local government, partly because they don't do very much. You need to improve the functions that they have to do."

Rajan further said, "If we improve the human capital, the biggest problem of today, the jobs that we need, will

come automatically...if you also improve the quality of the workforce, companies will come to India. We constantly hear from entrepreneurs (that they) can't find good workers.

He said that by skilling the average level of jobs can be transformed into good jobs. "So it's really about how we do this by taking the long view. The longer view doesn't mean results only in the long term. It means results all along the way. It means that when we end there, we will come to 2047 with a population that can be upper middle income," he added.

Rajan also underlined the need for governance reforms with focus on decentralisation and improving democratic institutions.

We need to have governance reform which means building on our democracy and focusing on decentralization...One example of good decentralization is the daily administration which has to focus on providing social services to the poor and the middle class, such as education, mobile app clinics etc," he

India, he added, "needs stronger democracy, not a weaker democracy besides strengthening distribution and becoming more inclusive, taking all our people with us...We need to create the opportunities for people, entrepreneurs".

According to the book, "our current growth is largely jobless, which means we need more growth to create necessary employment or else the demographic dividend will evaporate in front of our eyes... Another possibility is that our growth and GDP have been overestimated since 2013, when we changed the method of estimating the GDP.

India, the book concludes, "is at a cross road. We must embark on the Indian way, which builds on our strengths rather than our weaknesses. Our strengths include our spirit of inquiry and debate... Those not only make life in India more empowering and fulfilling for every citizen, they will also help us build the economy of the future.

Besides other things, the authors pointed out issues concerning data collection. For instance, they said India has not collected consumption data in the last six years, since the last report from 2017 was suppressed, perhaps because leaked versions suggested an increase in poverty and the latest census data is from 2011. The

new decadal round has simply been shelved. "The infrequently collected data on employment is noisy, often not square with the lived reality of the citizenry," they said.

The authors argued that they are not against manufacturing, they are against pouring enormous subsidies into attracting the lowest end of the manufacturing supply chain, assuming that will attract the rest.

They observed that India, for a variety of reasons, missed the manufacturing bus when China took it. "The China path of starting with low skilled assembly and moving up there will not work well for us because China and others are already there and have competed down the profits," they opined. From January to November of the current year, a total of 1139 coaches underwent POH at the two workshops of NF Railway, namely New Bongaigaon and Dibrugarh. The POH process involves thorough inspections and maintenance, addressing issues such as breakage of springs, loose types on the wheels, and other mechanical equipment failures that could lead to untoward incidents.

### Review advocates increased patrolling coverage in Raimona National Park

GUWAHATI, Dec 12: The recent

annual review of Data Driven Patrolling in Raimona National Park (RNP) in the state suggested increased patrolling coverage and the identification of sensitive areas to set up new anti-poaching camps. Data Driven Patrolling was introduced in Raimona National Park, the youngest national park in Assam, in October 2022 at the central range of the national park.

The annual review meeting discussed the progress and outputs of the Data Driven Patrolling initiative. The additional principal chief conservator of Forest and the council head of the Department of Bodoland Territorial Council (BTC) Forest, Suman Mohapatra, praised the work done so far and stated the need to identify sensitive areas for building new anti-poaching camps. He also called for increased patrolling coverage, especially in the eastern and west-

ern ranges. Concerns were raised regarding the increasing threat of timber and firewood collection in the park. The use of temporal graphs to plan better patrolling strategies to mitigate these threats was suggested. Additionally, the condition of for-



est roads, accessibility, and logistical issues were discussed.

The meeting appreciated Aaranyak, an organisation supporting conservation efforts, and encouraged collaboration. The participants included the DFO of Kachugaon Division, Bhanu Sinha, secretary general & CEO of Aaranyak, Dr Bibhab Kumar Talukdar, director of Tiger Programme Panthera, Dr Abhishek Harihar, senior scientist of Aaranyak, Dr Firoz Ahmed, and staff members from RNP and Aaranyak.

Dr Bibhab Kumar Talukdar pledged Aaranyak's support in legal and advocacy efforts, including organising workshops and training for the forest officials of Raimona National Park in the scientific investigation of wildlife

The Data Driven Patrolling initiative aims to strengthen the security of the wildlife habitat. Frontline staff of RNP have been trained and mentored in patrol data collection and management over the years with assistance from Aaranyak. The patrol data have been periodically analyzed to improve patrolling efforts and threat detection inside the park. The review meeting highlighted

the importance of recording threat data for effective planning and minimising threats in the park. Aaranyak has been supporting the Forest department of BTC in improving patrolling since 2016, starting in Bhuyanpara and Bansbari Ranges of Manas National Park. The best practices of this model were later transferred to the newly-established Raimona National Park.

#### **Historic verdict on Article 370**

In a landmark verdict on December 11, the Supreme Court upheld the abrogation of Article 370, marking a significant development with far-reaching implications. While political parties in Jammu and Kashmir now face the task of reassessing their strategies in light of the judgment, the aftermath is likely to trigger a series of political actions and reactions. Mehbooba Mufti asserted that the ruling was not just a defeat for Kashmiris but a setback to the cultural ethos of Kashmir, known as Kashmiriyat. The legal intricacies surrounding the judgment are noteworthy; the apex court deleted sub-section (B) of Section 370 without explicitly stating the cessation of Section 370 itself. The presumption is that Section 370 has become obsolete with the removal of sub-section (B). The court emphasized that Jammu and Kashmir had no internal sovereignty, having fully surrendered to the Union of India through the Instrument of Accession in 1947. However, questions arise about the government's selective application of Article 370, leaving defense, external affairs, and monetary transactions under its purview, while devolving other matters to the local administration.

Despite the government's claims that the abrogation aimed to curb insurgency and terrorism, recent data from the Ministry of Home Affairs revealed 761 terrorist incidents in Jammu and Kashmir between 2018 and 2022, resulting in 174 civilian deaths. This challenges the government's assertion that terrorism has been eradicated. Notably, a judge on the constitution bench suggested the establishment of a "truth and reconciliation commission" to investigate human rights violations in Jammu and Kashmir since the 1980s. The call for healing wounds underscores the complex social and political landscape. While the court directed the restoration of Jammu and Kashmir's statehood, providing a ray of hope, it also mandated elections by September 30, 2024. The reinstatement of local governance allows the people of Kashmir to address concerns such as the provision allowing outsiders to purchase land, a key factor that prompted the abrogation. Despite the court's approval of the abrogation, questions linger about the government's intentions and the temporary nature of the measures taken. The decision to bifurcate the state into Union Territories, particularly Ladakh, raised eyebrows, with the court declining to decide on the validity of this move.

The court's reluctance to address the mutilation of Jammu and Kashmir disappointed some, including Congress, which expressed disagreement with the judgment on Article 370. Congress member Abhishek Manu Singhvi questioned the central government's prolonged control over the state by remote and raised concerns about the contradictory stance on Ladakh. In the backdrop of the ruling, the court's acknowledgment that Parliament's use of Article 367 to amend Article 370 was "constitutionally invalid" raises questions about the overall legitimacy of the abrogation. The lack of a compelling explanation from the Modi government regarding the bifurcation further fuels skepticism. Despite the legal intricacies and political nuances, the court's directive for the restoration of Jammu and Kashmir's statehood signifies a pivotal moment. As the region moves toward electing its assembly, the people of Kashmir will have an opportunity to shape their future and address longstanding concerns, including the protection of land rights. The Supreme Court's verdict on Article 370 introduces a new chapter for Jammu and Kashmir, presenting both challenges and opportunities. The intricacies of the judgment and its implications will undoubtedly continue to shape the region's political landscape in the coming years.

### Abrogation to reconciliation: The changing landscape of Kashmir

The historic Supreme Court verdict on December 11, 2023, affirming the validity of the abrogation of Article national liberal and Wahhabi 370, marks the definitive closure ecosystem spreading misinforof a troubling chapter in India's mation against him. Modi rehistory. This chapter, casting doubt on India's territorial integrity and affecting security, not only discriminated by law but also deprived the people of J&K of the complete benefits of Indian citizenship as per the Constitution. Article 370, a source of the security and socio-political challenges in Kashmir, served as a tool for local leaders to fuel separatism, enabling external powers like Pakistan to exploit existing fault lines. According to the Supreme Court, J&K lost its sovereignty upon accession to India, and Article 370 was only a temporary provision. This unanimous verdict from the fivejudge bench firmly resolves all questions regarding the status of J&K as an integral part of India. In the grand scheme of events,

the seamless execution of a task untouched for over seven decades became a reality in 2019, with the Supreme Court's final dismissal of all petitions challenging the abrogation four and a half years later. Since 2019, Kashmir has witnessed a transformation - stone-pelting has faded, infrastructural development has flourished, and tourism has thrived. Despite lingering Pakistan-sponsored terrorism, security forces assert that those resorting to violence in the Valley have a limited shelf life. Today, the Tricolour proudly flies over Lal Chowk as Independence Day is celebrated, marking a stark contrast to its turbulent past. Movie halls are reemerging, symbolizing a significant shift in a region where cinemas were once destroyed under the pretext of religious objections. Contrary to warnings from leaders like Faroog Abdullah, who predicted turmoil post-Article 370 abrogations, Kashmir remained calm after 2019. The echoes of violent unrest in 2016 and 2010 led by figures like Burhan Wani and the Hurrivat now seem like distant, unpleasant memories.

The scenario in Kashmir isn't entirely normal, but it marks a significant step towards integrating the valley with the rest of India. This underscores the im-

plified by Prime Minister Narendra Modi's resolve to address the supposedly insurmountable Kashmir issue. Despite the intermained undeterred in steering the problem towards resolution. Post the 2019 abrogation, international voices opposing the govgrew louder, constructing a narrative of maioritarian India oppressing minorities. However, the Supreme Court's verdict on the 2019 action refuted such claims, placing Article 370 in an irreversible state. It is anticipated that demands for "azaadi" (freedom) for Kashmir within India will diminish. Even when former J&K Chief Minister Omar Abdullah asserts his party's respect for the Supreme Court verdict but expresses intent to bring back Article 370, it appears as posturing, diverging from the mainstream politician's role of ensuring prosperity for J&K. The lack of unrest in Kashmir in recent years indicates a desire for progress. The Supreme Court's verdict, met with silence in the Valley, sends a clear message to Kashmiri politicians: refrain from pandering to separatist sentiments and focus on fostering a normal life, free from strife and violence. for the people.

The call for reconciliation and healing, as emphasized by the Supreme Court, is timely. However, any proposed Truth and Reconciliation Commission must ensure justice not only for those based in the valley who may have suffered from state and nonstate excesses but also for the lakhs of people abruptly driven out of the valley. The crucial question arises: Does reconciliation extend to enabling these individuals or their descendants to return to Kashmir and rebuild their lives in a secure environment? This remains a challenging inquiry with no immediate answer, as various adversarial interests seek to maintain Kashmir as a hotbed of terror and extremism. Recent targeted attacks on Kashmiri Pandits underscore the ongoing efforts to instill fear in their hearts, making the path ahead difficult. Nonetheless, it signifies a noteworthy beginning. # The Siang Dialogue 1.0: North East pivotal to India's prosperity and security

The inaugural session of The Siang Dialogue 1.0 titled "The Namsai Note" kicked-off the conference on 8th December. It was aimed to stimulate discussions towards the strategic importance of attending to India's neighbourhood besides providing an opportunity for an in-depth discussion on India's northeast region.

Éring-MLA, Ninong Arunachal Pradesh Assembly, in his address stated how the northeast region is of great importance for India strategically and geopolitically.

Dr Sriparna Pathak, Associate Professor at OP Jindal Global University, elaborated on the details of the topic in great depth and its impact on the northeast. She talked about how China is weaponising water.

Dr Sriparna further added that the mindless construction of dams by China in ecologically sensitive regions like Occupied Tibet and on the Majia Zangbu river, will badly impact natural habitats and its impact can be seen in the form of floods in Arunachal Pradesh, Assam and the entire northeast region.

Dr Rajiv Nayan, Senior Research Associate at Manohar Parrikar Institute for Defence Studies & Analyses elaborated on how the geographical location of Northeast India makes it very special. He further said that the Government has transformed its "Look East Policy" into the "Act East Policy". In the last 10 years, the northeastern region of the country has witnessed significant transformation on the infrastructure front

under the current leadership. Dr Shrabana Barua, Research

Red Lantern Analytica, a Delhi based think-tank organised their annual event "The Siang Dialogue 1.0" in virtual mode from 8th-10th December 2023. Over three days, the speakers articulated their views that China must not preach things that it itself doesn't practice like bringing peace and creating friendly ecosystems. Speakers further explored the origins of the people of Tibet, the historical significance of the relationships between the people of Tawang and Tibet

Fellow at the Indian Council of World Affairs, focused more on connectivity issue in the northeast region and how it is transforming strategic aspects in the

region. Dr Shrabana stressed that we need to address the China factor in the northeast region. She highlighted the example of China reviving the Burma Road, which can lead to an increase in smuggling and opium trade once completed.

Bangladesh-Bhutan-The India-Nepal (BBIN) initiative is doing good work in integrating the region with neighbouring countries, she said, and suggested that the Indian Government should utilise water resources in the northeastern region to its greatest potential by strengthening inland water connectivity.

Namrata Hasija, Research Fellow at the Centre for China Analysis & Strategy, moderated the session. In her remarks Hasija said, "North East Region of India is set to play a crucial role in India's grandiose plan of development. China's Belt and Road Initiative is being countered proactively & China's evil plans are upfront now."

In the second session titled 'Lohit's Longitude' held on 9th December discussion centred on understanding India's northeast as a gateway to the "Act East policy" of the government.

Sujeet Kumar-MP-RS in his video message said, "Northeast region of India holds immense political and geopolitical importance. India's 'Act East Policy' cannot be successful unless we

Bansal mentioned that India's Act East Policy is based on the 4 C's -Culture, Commerce, Connectivity, and Capacity Building. > Translation Dr. Ayanjit Sen, senior journalist and Associate Professor at Bennett University said that Arunachal Pradesh has always been and will always remain an integral part of India no matter what may come. Commenting on China he said Arunachal Pradesh holds significant importance for India and it is not "South Tibet" (as claimed by China). He criticised China's sinister tactics of including

official maps, he concluded by saying, Arunachal Pradesh from the map but not from Geography."

Lekshay Tenzin Spokesperson of the Central Tibetan Administration expressed his concern about the ecological damage being done by China in Tibet. Dr. Soumya Awasthi, author and consultant with the Indian Ministry of Defence in the context of China's actions in Tibet said, "Chinese have a very aggressive and expansionist agenda but Tibet is a very important part of India's history. She further added that the Tibet issue continues to be unresolved due to China's expansionist agenda. It has still not honoured the 1954 agreement of granting autonomy to the Tibetan people to run their own government.

Tsewang Dorji, Researcher at Tibet Policy Institute, in his presentation elaborated on the geopolitical significance of Tawang in India-China relations and China's Great Game in the Himalayan region. He said that the geopolitical importance of Tibet is very critical to understand China's expansionist agenda in the Himalayan region.

### Human rights and labour advocacy need to be intensified to protect workforce

ecember 10, 2023 is the 75th anniversary of the Universal Declaration of Human Rights and ILO Convention 87, yet we are far from achieving human dignity, freedom, and social justice for all, especially for the entire workforce. Intensified efforts to promote and protect the human and labour rights is thus imperative at this juncture when the employers and governments across the world are in favour of scuttling large number of labour rights including the "right to strike" while real wages are on the decline, quality of jobs deteriorating, and unemof COVID-19 in 2020.

Only a month ago on November 10-11, a special two day session outside the ILO Governing Body meeting was held on request of 14 Employer members, who wanted to limit the scope of the Freedom of Association and Protection of the Right to Organize Convention of 1948, ie Convention 87. Such a meeting was a rare event held outside the ILO Governing Body meetings, only the fourth one in the history of ILO's existence since 1919. The three others were held in September 1932, October 1935, and May 1970.

The two-day special session was held just after conclusion of 349th Session (October 30 – November 9), in which the ILO Governing Body members could not even defend the Convention 87, due to split of votes, and had to decide to refer the dispute to the International Court of Justice

The 14 employer members of the ILO governing body had requested for urgent inclusion of the issue on the agenda of the 112th Session of International Labour Conference (ILC) and proposed ILC adopt protocol to ILO Convention 87. If adopted, it would authoritatively determine the scope and limits of the right to strike, is, more broadly, industrial action. As per the request of the employer members, the dispute is to be brought in the 112th Session of the ILC to be held in June

However, the Governing Body has decided to consider appropriate follow-up action only after receiving the advisory opinion of ICJ. It should be noted that just before this decision, the Governing Body had endorsed the proposed ILO integrated strategy for the promotion and implementation of the right to collective bargaining and requested the DG ILO to take into account its guidance in implementing the strategy and submit a progress report at its 352nd Session in November 2024.

It is therefore significant that ILO Director-General Gilbert F. Houngbo has now called for intensified efforts to promote and protect these rights and collectively strive for a future grounded in human dignity, freedom, and social justice. He has said that these human rights were hard-won, and they remain essential for peace and social justice. We all have a duty to protect and support them - especially in times of conflict and insecurity, he said in a statement adding, "at the ILO we pledge to redouble our efforts to promote these rights, and so support a future based on human dignity, freedom and social justice for all.

How far his call will be effective is uncertain, since the ILO Governing Body itself is not running smoothly. There are 56 titular members and 66 deputy members in it. Titular members included 28 governments, 14 employers, and 14 workers while deputy members included 28 governments, 19 employers and 19 workers. Ten of the titular government seats are permanently held by states, and other government members are elected by the ILC every three years. However, it is unfortunate that not election has been held since June 2014.

It is worth recalling that the Universal Declaration of Human Rights was adopted in 1948 in the aftermath of World War II. That same year the ILO's members adopted Convention 87, protecting freedom of association and the right to organize, safeguarding the rights of workers and employers to choose how, and by whom, they are represented. For many years until 2012, the ILO Committee of Experts on the Application of Conventions and Recommendations, consisting of independent experts responsible for monitoring the application of the ratified Conventions by member states, has taken the view that the right to strike is a corollary to the right to freedom of association, and that, as such it is reorganized and protected by the Convention 87.

In 2012, Employers' group have started questioning the interpretation of the Experts, bringing a major institutional crisis with the ILC Committee on the Application of Standards being prevented for the first time from exercising its supervisory functions. The issue of collective bargaining came before the tripartite screening roup in May 2022 that decided to place the strategy for promotion and implementation of the right to collective bargaining on the agenda of the ILO Governing Body in its meeting in March 2023.

Since trade unionism across the world is in great crisis, ILO's call for protecting and promoting Convention 87, is important. The 75th anniversary of the Convention 87 should be an occasion to make a fresh resolve for workers and trade unions to protect themselves from exploitation and assert for their rights, especially the right to organize, right to collective bargaining for proper wages and social security coverage, and right to strike. ILC and ILO has major responsibility to protect the Convention 87 to protect workers' rights. (IPA Service)

### Hectic work is on in ISRO to send first Indian astronaut to moon by 2040

n October this year, Prime Minister Narendra Modi led a significant meeting to evaluate the advancement of India's Gaganyaan Mission and to define the future of the nation's space exploration efforts. Expanding on the achievements of such previous space missions as Chandrayan-3 and Aditya L-1, the Prime Minister has set ambitious targets for India, which include establishing an Indian Space Station, called the Bharatiya Antariksha Station, by 2035 and sending the first Indian astronaut to the Moon by 2040.

To ensure that humans are adequately prepared for extended space missions, including lengthy ourneys to Mars which can take up to seven months, scientists are actively studying the impact of space on human well-being. This research encompasses investigations into the effects of the space environment on various aspects of health, including sexual health. Recent research funded by

cles can include cosmic rays, which are typically high-energy protons, electrons and atomic nuclei. including impairing vascular tissues and potentially resulting in conditions like erectile dysfunction, along with the microgravity conditions experienced in space, can negatively impact vascular tissues. This impairment of vascular tissues can result in erectile dysfunction. What is concerning is that the research indicates that. even after astronauts return to Earth and undergo an extended recovery period, these issues with sexual function can persist.

As manned missions to space are scheduled for the near future. the research emphasizes the importance of monitoring astronauts' sexual health upon their return to Earth. Justin D La overall life satisfaction, still lacks and the ageing process. Favor, a co-author of the study from Florida State University, states that these findings highlight the need for close observation in this area. Earth's magnetosphere shields us from cosmic radiation, but astronauts on the ISS rely on artificial shielding. Despite this,

We are susceptible to oxidative stress in such conditions as chronic inflammation, exposure to environmental pollutants, smoking, excessive alcohol consumption, poor diet, certain medical conditions, such as diabetes and cancer, and neurodegenerative diseases, such as Alzheimer's

Oxidative stress is linked to a higher chance of erectile dysfunction due to how the body responds to damage in blood vessels. Exposure to cosmic rays, causing oxidative stress, is thought to impact the artery supplying blood to erectile tissue. Microgravity also has a similar, though less pronounced, negative effect on erectile function. The body fights oxidative stress by producing antioxidants naturally The team's study suggests that using certain antioxidants as a treatment could enhance the function of tissues exposed to cosmic

"Despite the adverse effects of galactic cosmic radiation staying for a long time, we have learnt through our research that, by specifically targeting the redox and nitric oxide pathways in tissues, we could, possibly, treat erectile dysfunction," the research team stated. Redox is a term formed from 'reduction' and 'oxidation', involving chemical reactions with electron transfer in the body. Targeting these reactions is possible through interventions, such as employing specific

During the first trimester of pregnancy, a woman's body goes through several drastic changes in a short space of time. The body experiences a large influx of hormones, along with an increase in the amount of blood. Rapid weight gain may also occur. Together, these changes may make certain types of headache, such as tension headaches, more likely. Some other pregnancy symptoms may also influence these headaches or make them worse. Common issues that could cause or worsen a headache include:

- nausea and vomiting high stress levels
- poor nutrition low blood suga
- dehydration
- lack of sleep changes in vision
- light sensitivity, which may trigger migraine • a sedentary lifestyle
- Additionally, a pregnant woman may have some trigger foods that cause irritation

headaches. These trigger foods may vary among individuals, but some common culprits include dairy prod-

ucts and chocolate. Second and trimesters

In the second and third trimesters, a woman may be less likely to experience headaches due to hormonal changes, as the body has usually adjusted to these changes by this stage of pregnancy.

However, some women continue to experience tension headaches from hormonal changes throughout their pregnancy. In the later stages of pregnancy, symptoms such as headaches are more likely to be due to: excess weight

- high blood pressure
- muscle strain poor posture
- insufficient sleep
- poor diet

Hypertension during pregnancy

Hypertension, or high blood pressure, is a common experience for many pregnant women. Some will experience a condition called preeclampsia, which occurs when someone who usually has normal blood pressure levels suddenly develops high blood pressure after 20 weeks of pregnancy.

The Centers for Disease Control and Prevention (CDC) estimate that 1 in 25 pregnant women in the United States will develop preeclampsia. Preeclampsia increases the risk of many medical emergencies, including seizures and stroke. The condition may also reduce the oxygen flow to the fetus.A common symptom of preeclampsia is a headache that will not go away. Some other symptoms include:

- changes in vision, such as blurred vision or seeing
- nausea or vomiting
- sudden weight gain • pain in the upper stomach
- · difficulty breathing • swelling in the face or hands

These symptoms do not occur in every case of preeclampsia, which is one of the reasons why it is important to check in regularly such as yoga, swimming, or with a doctor throughout tai chi

**Tension headaches** 

Tension headaches are the most common type of headache during pregnancy. In fact, a 2017 review in the Journal of Headache and Pain notes that 26% of all headaches that occur during are tension pregnancy headaches.

Tension headaches cause mild-to-moderate pain in the head. Many people describe the pain as feeling as though they have a tight band around their head.

Migraine headaches

Migraine headaches may also occur during pregnancy. According to estimates, migraine headaches without aura occur in up to 10% of pregnant women

A migraine headache often begins as a dull ache that grows into a piercing, throbbing pain, which may or may not radiate. A person may also be very sensitive to light, noise, and some smells. Migraine episodes might also cause other symptoms, such as dizziness or nausea.

**Cluster headaches** 

Cluster headaches are rarer than other types, occurring in an estimated 0.3% of all pregnancies. Cluster headaches cause a severe "stabbing" pain, typically on one side of the head and around the eye. A person may also notice some other symptoms, such as nasal congestion, watery eyes, or swelling in the area.

**Treatments** In many cases, home remedies can help soothe a primary headache during pregnancy. Some home remedies that may be effective include:

- · applying a cold or warm compress to the area for 10 minutes at a time
- taking a warm bath to release muscle tension
- stretching
- doing mild exercises,
- better posture • taking frequent breaks
- away from screens
- · drinking plenty of water throughout the day
- getting plenty of rest · getting a gentle head massage • resting in a dark area

What to avoid

During pregnancy, it is essential to avoid over-thenonsteroidal anti-inflammatory (NSAIDs), such as ibuprofen (Advil) or aspirin.

A review in the Annals of Epidemiology notes that women who take NSAIDs while pregnant are more likely to give birth to babies with congenital abnormalities. Some women take acetaminophen (Tylenol) while pregnant, although there is a concern that this may also affect the baby.

A recent study in the journal JAMA Psychiatry found that children born to women who take acetaminophen during pregnancy are more likely to be autistic or have attention deficit hyperactivity disorder. However, there is a need for more research into this connection before health experts can make any broad claims. Many people still view acetaminophen as the safest drug choice for women during pregnancy.

When to see a doctor Although headaches during pregnancy are common, it may sometimes be neces-

sary to see a doctor.

Anyone experiencing seheadaches that do not respond to home remedies should schedule an appointment with their doctor. Similarly, anyone experiencing other troubling symptoms such as dizziness or changes in vision - should seek diagnosis and treatment. ## NCRB report: How Kolkata has emerged as the safest city, especially for women

The National Crime Records Bureau recently released its annual report on crime in India for the year 2022 and Kolkata has emerged as the safest city in India for the third consecutive year. The city recorded the least number of cognizable offenses per lakh population among all the metropolises in

According to the NCRB's annual report for the year 2022, Kolkata reported 86.5 cases of cognizable offenses per lakh population, a remarkable feat that places it ahead of Pune (280.7 cases) and Hyderabad (299.2). The ruling All India Trinamool Congress hailed this as an achievement for West Bengal chief minister Mamata Banerjee.

"We rejoice as Kolkata achieves this milestone once again! For the third consecutive time, according to NCRB data, the City of Joy proudly stands as the safest city in India. Under the able guidance of Smt @MamataOfficial and the constant vigilance of @KolkataPolice, crime rates have significantly plummeted. Beyond its richness in culture, food, music and art. Kolkata also nurtures a sense of security seldom found elsewhere." - Trinamool Congress posted on X.

However, the BJP, which is the main Opposition in the state said that the data is misleading.

Leader of Opposition, Suvendu Adhikari, claimed that the state govmitted to the NCRB.

In response, the Trinamool Congress accused Adhikari of questioning the credibility of the BJP-led central government's reports.

Which city is safest? Delving deeper into the NCRB report reveals a disturbing national trend - a significant rise in crimes against women. The nationwide data indicates a 4 percent increase in crimes against women in 2022 compared to the previous year.

categories of crimes against women, notably rape, where the city reported 1,204 cases, constituting nearly a third of the 3,635 cases reported in metropolitan cities. Jaipur followed with 497 cases, and Mumbai with

Delhi, perennially grappling with this issue, recorded a staggering 14,158 cases, with about 186.9 crimes reported for every 1,00,000 women, maintaining its unenviable position as the most unsafe metropolitan city for women.

istered in the national capital under the Indian Penal Code in 2022 against 2,89,045 in 2021, as per the annual crime report of the NCRB.

The grim statistics further highlight that Delhi logged nearly 3 lakh criminal cases in 2022, marking a 3.3 percent increase from the preceding year. The city recorded three rape cases daily, underscoring the urgent need for focused interventions.

Furthermore, the capital recorded the highest number of dowry deaths, accounting for 129 out of the total 381 cases nationwide. Delhi was followed by Lucknow and Kanpur, each reporting 43 cases, and Jaipur with 33 cases.

Delhi was also on top on cases of assault against women and kidnapping. The incidence of crime rates against women has witnessed a 4% increase compared to previous years. In 2021, there were 428,278 recorded cases, which has risen to 445,256 cases in 2022. Another alarming trend are the crimes against children. A total of 1,62,449 cases were registered during 2022.

Crimes against children witnessed an 8.7 percent surge in 2022, with Maharashtra leading. Metropolitan cities like Delhi and Mumbai have highest records of crime against children under POCSO Act.

# Getting married this Winter? Here are some hair & skincare tips for you

s the winter is knocking on the door, it is time to Astart preparing for the wedding nuptials. It's a day that would forever etch in your heart, a string of moments that you would hold dear for the rest of your life! Yes, the wedding day the magical 24 hours that nudges your soul with love, pomp, and care towards a dream living!

Who doesn't want to look gorgeous at a party or a wedding? When it comes to a winter wedding, we generally assume that winter weddings are fuss free. No humidity so no frizzy hair, no sweaty makeup, no makeup meltdown during wedding functions. But the season brings along problems like flaky skin, cakey makeup, chapped lips, limp hair and pedicure running out too soon during marriage celebrations. Dry and patchy skin can be a nightmare when it comes to makeup application as everything

you apply flakes off or creases. Looking beautiful on the wedding day is not merely a matter of make-up and dress. It needs weeks of care. If a skin care programme is followed a few weeks before the wedding, it can really help. The skin type and the season should also be taken into consideration. For instance, in winter, even oily skins may feel dry, while dry skins need more miniaturisation and nourishment with creams and oils

For your daily facial care routine, cleanse your skin twice a day. It's not just the skin on your face that's prone to dryness in the

winter-your hands are often left vulnerable to the same environmental elements as your complexion. Same goes for the rest of your body! Night time cleansing is more

important, in order to remove pollutants and make up before bedtime. So, cleanse the skin daily at night and apply a layer of moisturizer before you sleep. You can also apply an all-night mask for your skin. For normal to dry skin, use a cleansing cream or gel. Or, take half a cup of cold milk and add five drops of any vegetable oil (til, olive or sunflower oil). Put this in a bottle and shake well. Cleanse the skin with it, using cotton wool.

Keep left-over mixture in the fridge. If the skin is oily, use a cleansing lotion or face wash for oily skins. Oily skins also need deep pore cleansing. Mix rice powder with curd and apply on the face once or twice a week. Rub gently with small circular movements and wash off with water. Ready-to-use scrubs are also easily available. In winter, an oily skin may be prone to blackheads. You can have "clean-up" at a beauty parlour and have blackheads extracted. One of the easiest ways to prevent dry hands is by adding a hand cream to your skin care routine.

An oily skin may also feel dry in winter, but when cream is applied, it can lead to pimples. So, mix one teaspoon pure glycerine with 100 ml rose water and keep in a bottle in the fridge. Use a little of this lotion to relieve dryness. It will soften the skin, without making it oily.



on the face and wash off with plain water after 20 minutes. For all skin types, tone the skin

daily with chilled rose water, using cotton wool pads. Wipe and stroke the skin with them. Then, pat briskly with the rosewatersoaked cotton wool pads. This adds a glow to the skin.

The daily nourishing of normal to dry skin can be done at night, with a nourishing cream. After cleansing, apply the cream and massage on the face with a few drops of water, with outward and slightly upward movements, for 2 minutes. Wipe off with moist cotton wool. For the face, mix a mask at home and use it two or three times a week. For normal to dry skin, mix two teaspoons wheat bran (choker) with one teaspoon each of almond meal (badaam), curd, honey and rose water.

For oily or combination skin,

mix three teaspoons oats with curd, honey and egg white or rose water. Mix everything together into a paste and apply on the face, avoiding the lips and area around the eyes. Wash it off after 20 minutes. After applying face mask, soak two cotton wool pads in rose water and use them as eye pads. Lie down and relax. This is extremely relaxing and refreshing and a great restorer of both body and mind. Rose water actually has a relaxing effect, helps to remove fatigue and brighten the

The skin around the eyes is thin and delicate. It acquires lines and wrinkles easily. Apply an undereye cream wipe it off after 15 minutes, with moist cotton wool. Or, daily apply pure almond oil sparingly and massage lightly, using only the ring finger, for one minute under each eye. Massage in one direction only.

The skin on the lips is also thin and lacks oil producing glands. It

becomes dry and chaps easily. Even if you are using the moistest lipstick you cannot apply it on your lips without a coat of lip balm or petroleum jelly. For plump looking lips give them a base coat of lip balm. After cleansing, apply almond oil or almond cream on the lips daily and leave it on all night. Sun-protective lip balms are also useful.

Protect the skin from moisture loss during the day. Apply SPF rich sunscreen, before going out in the sun. Ultra violet rays are weaker in winter and you don't get tanned easily. But, it tends to cause wrinkles, premature ageing, dryness, and damage the skin. Most sunscreens have builtin moisturizers. Moisturizers are available in cream and liquid form. For extreme dryness, use a cream. A liquid moisturizer should also be used under makeup. Keep the skin well mois-

During winter, opt for water-resistant sunscreens free from fragrance and parabens. This practice will make you glow on your wedding day and even before after.

In winter, the skin of the body also needs nourishing with oils. In the olden days, "ubtan" was made at home for skin care. First the body was massaged with "til" oil. Then homemade "ubtan" was applied. This usually consisted of wheat bran (choker), gram flour (besan), yogurt (dahi) or cream of milk (malai) and a pinch of turmeric (haldi). All these were mixed together and applied on the face and body, before bathing. The "ubtan" was washed off after half an hour, while bathing. It helped to clear the skin of dead cells, leaving it smooth and bright, with a translucent quality.

Another ideal way for glowing skin on the body is to tie ingredients in a clean cloth, wet slightly and then rub the cloth bag on the skin while bathing. Mix powdered milk, ground almonds (badaam), rice powder and rose petals. The ingredients work on your skin, gently cleansing it and leaving it soft, smooth and vibrant. It also leave the body naturally perfumed and refreshed, feeling as smooth as silk.

In winter, the hair also needs to be nourished with oils. Heat pure coconut oil and apply on the hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. After shampoo, apply a creamy conditioner, leave on for 2 minutes and wash off with plain water. Or, you can apply a leave-on conditioner or hair serum for shine and protection. Oil them every week and get a hair spa atleast once a month prior to your wedding. Add a little olive oil to whichever oil you apply to give it a little

touch of moisture. You can also give your hair a quick conditioning treatment before shampoo. Mix one teaspoon each of vinegar and almond oil with one egg. Beat them together well. Massage the mixture into the scalp. Leave on the mixture for half an hour and then wash your hair. If you do not wish to use egg, add more almond oil.

You must keep yourself hydrated by drinking 8-10 glass of water daily which will help flush out toxins, improves skin tone, healthy and glowing skin. You can add fruit juice, coconut water, watermelon, green tea and lassis in your daily routine. Make sure these do not contain too much sugar or sodium. Eating the right kinds of food will help your skin glow even in the winter months. Have a small box of dry fruits when you are travelling. Try to include regional and seasonal fruits, vegetables in your diet on a daily basis.

Snacking on naturally hydrating food will keep your body hydrated. Opt for a diet that is rich in Omega 3 essential fatty acids.All brides go through some kind of stress. Do not stress. It can ruin all your winter skincare efforts. To deal with this kind of mental stress, it is essential to learn to relax. It has been proved that physical exercise actually helps the body to cope with stress. A few weeks before the wedding, start taking a little exercise, like going for a walk.

In fact, walking is good for both body and mind. Yoga and meditation are also helpful, in terms of calming the mind and inducing relaxation. You must ensure Eight hours sleep daily to rejuvenate your skin. If you sleep late and aren't getting enough rest, take mini naps between the days. # A missile strikes Norwegian-flagged tanker off Yemen in an apparent expansion of rebel attacks

Yemen's Houthi rebels slammed into a Norwegian-flagged tanker in the Red Sea off the coast of Yemen near a key maritime chokepoint, the rebels and authorities said on Tues-

The assault on the oil and chemical tanker Strinda expands a campaign by the Iranian-backed rebels targeting ships close to the Bab el-Mandeb Strait into apparently now striking those that have no clear ties to Israel. That potentially imperils cargo and energy shipments coming through the Suez Canal and further widens the international impact of the Israel-Hamas war now raging in the Gaza Strip.

Houthi military spokesperson Brig. Gen. Yahya Saree issued a video statement saying the rebels only fired on the vessel when it "rejected all warning calls."

The U.S. military's Central Command issued a statement Tuesday saying an anti-ship cruise missile "launched from a Houthi-controlled area of Yemen" hit the Strinda.

There were no U.S. ships in the vicinity at the time of the attack, but the USS Mason responded ... and is

is an Arleigh Burke-class destroyer that has been involved in several of the recent incidents off Yemen.

The private intelligence firms Ambrey and Dryad Global had earlier confirmed the attack happened near the crucial Bab el-Mandeb Strait separating East Africa from the Arabian Peninsula.

Geir Belsnes, the CEO of the Strinda's operator, J. Ludwig Mowinckels Rederi, also confirmed the attack took place.

"All crew members are unhurt and safe," Belsnes said. "The vessel is now proceeding to a safe port."

The Strinda was coming from Malaysia and was bound for the Suez Canal and then on to Italy with a cargo of palm oil, Belsnes said. Saree alleged without offering any evidence that the ship was bound for Israel. The British military's United Kingdom Maritime Trade Operations, which provides warnings to sailors in the Middle East, earlier reported a fire aboard an unidentified vessel off Mokha, Yemen, with all the crew aboard being safe. The coordinates of that fire correspond to the last known location of the Strinda based off satellite tracking

In 2016, the U.S. launched Tomahawk cruise missiles that destroyed three coastal radar sites in Houthi-controlled territory to retaliate for missiles being fired at U.S. Navy ships at the time. (AP)

### Suicide bomber attacks police station in northwest Pak, killing 6 officers and wounding 25

#### Pakistan SC resumes hearing of long-pending case against Zulfikar Bhutto's death sentence

ISLAMABAD, Dec 12: Pakistan's Supreme Court on Tuesday resumed hearing a long-pending presidential reference seeking to revisit the 1979 controversial death penalty given to former Prime Minister Zulfikar Ali Bhutto. A nine-member larger bench of the apex court, headed by chief justice Qazi Faez Isa, took up the case for hearing.

Bhutto was hanged to death in 1979 after he was convicted for abetment in a murder case. The execution was carried after a seven-member Supreme Court upheld the conviction, which many believed was done under coercion exercised by then military dictator Gen Ziaul Haq who had toppled Bhutto's government in 1977.

WASHINGTON, Dec 12: President Ukrainian Volodymyr Zelenskyy will arrive on Capitol Hill to a darker mood than when he swooped in last winter for a hero's welcome, as the Russian invasion is grinding into a third year and US funding hangs in balance.

Zelenskyv's visit on Tuesday comes as President Joe Biden's request for an additional USD 110 billion US aid package for Ukraine, Israel and other national security needs is at serious risk of collapse in

Republicans are insisting on trict US-Mexico border security changes that Democrats decry as draconian in exchange for the overseas aid.

"It is maddening," said Sen. Chris Coons, D-Del., a close ally of Biden, of the stalemate. "A very bad message to the world, to the Ukrainian people." The White House said the time was right for Zelenskyy's trip to Washington as Biden pushes lawmakers to approve the aid package before the year-end holidays. But the mood turned grim at the Capi-

tol on the eve of his arrival. Zelenskyy will meet privately with senators and new House Speaker Mike Johnson, then talk with Biden at the White House as the once robust bipartisan support for Ukraine was slipping further out of reach.

Ahead of Zelenskyy's highstakes meetings, the White House late Monday pointed to newly declassified intelligence that shows Ukraine has inother Western allies. (AP) flicted heavy losses on Russia

in recent fighting along the Avdiivka-Novopavlivka axis — including 13,000 casualties and over 220 combat vehicle losses. The Ukrainian holdout in the country's partly-occupied east has been the centre of some of the fiercest fighting in recent weeks. US intelligence officials

have determined that the Russians think if they can achieve a military deadlock through the winter it will drain Western support for Ukraine and ultimately give Russia the advantage, despite the fact that Russians have sustained heavy losses and have been slowed by persistent shortages of trained personnel, munitions, and equipment.

"Russia is determined to press forward with its offensive despite its losses. It is more critical now than ever that we maintain our support for Ukraine so they can continue to hold the line and regain their territory," said White House National Security Council spokesperson Adrienne Watson. She added that Russian President Vladimir Putin "is clearly watching what happens in Congress — and we need Congress to act this month to support Ukraine in its time of need.'

Republicans in Congress, fuelled by Johnson's far-right flank in the House, have taken on an increasingly isolationist stance in US foreign policy, demanding changes to American border and immigration policies in exchange for any funds to battle Putin's war in Ukraine. (AP)

### Hong Kong leader praises election turnout as voter numbers hit record low

HONG KONG, Dec 12: Hong Kong leader John Lee on Tuesday praised the 27.5 per cent voter turnout in the city's weekend election, a record low since the territory returned to Chi-

Sunday's district council election was the first held under new rules introduced under Beijing's direction that effectively shut out all pro-democracy candidates.

"The turnout of 1.2 million voters has indicated that they supported the election, they supported the principles," Lee said at a news conference.

"It is important that we focus our attention on the outcome of the election, and the outcome will mean a constructive district council. rather than what used to be a destructive one,' he said. Sunday's turnout was significantly less than the record 71.2 per cent of Hong Kong's 4.3 million registered voters who participated in the last election, held at the height of anti-government protests in 2019, which the pro-democracy camp won by a landslide.

Lee said there was resistance to Sunday's election from prospective candidates who were rejected under the new rules for being not qualified or lacking the principles of "patriots" administering Hong Kong.

"There are still some people who somehow are still immersed in the wrong idea of trying to make the district council a political platform for their own political means, achieving their own gains rather than the district's gain, he said. The district councils, which primarily handle municipal matters such as organising construction projects and public facilities, were Hong Kong's last major political bodies mostly chosen by the public.

But under the new electoral rules introduced under a Beijing order that only "patriots" should administer the city, candidates must secure endorsements from at least nine members of government-appointed committees that are mostly packed with Beijing loyalists, making it virtually impossible for any pro-democracy candidates to run.

An amendment passed in July also slashed the proportion of directly elected seats from about 90 per cent to about 20 per cent.

"The de facto boycott indicates low public acceptance of the new electoral arrangement and its democratic representativeness," Dominic Chiu, senior analyst at research firm Eurasia Group, wrote in a note.

Chiu said the low turnout represents a silent protest against the shrinking of civil liberties in the city following Beijing's imposition of a tough national security law that makes it dif-

### A court sets aside the South African president's recognition of the Zulu king

JOHANNESBURG, Dec 12: A South African court has overturned President Cyril Ramaphosa's decision to recognise Misuzulu kaZwelithini as the king of the country's 15 million-strong Zulu nation in what may spark a lengthy battle for the throne.

Ramaphosa has now been ordered to launch an investigation into objections by some members of the Zulu royal house that the correct processes were not followed in selecting kaZwelithini as the rightful heir to the throne. KaZwelithini was chosen as the new king last year after the death of his father, King Goodwill Zwelithini. He was recognised by Ramaphosa as the new king and handed a recog-

nition certificate, but some of his siblings have challenged the process

and insisted that he is not the rightful heir to the throne and that due processes were not followed in choosing him. In judgment delivered by Judge Norman Davis in the Pretoria High Court on Monday, Ramaphosa was criticised for not launching an investigation after he became aware that there was a dispute in the royal house

regarding the selection of the heir to the throne. According to South African law, which recognises and affords some rights and responsibilities to traditional leadership, Ramaphosa was supposed to launch an investigation as soon as he was aware of objections against the recognition of the new king.

"It is declared that the recognition by the first respondent of the second respondent as Isilo of the Zulu nation was unlawful and invalid and the recognition decision is hereby set aside," reads the judgment.

The judge noted that his ruling was not meant to determine whether the king was the rightful heir, but whether the correct processes had been followed. (AP)

### Common people not law enforcers, can't grill others on suspicion: Manipur CM

**IMPHAL, Dec 12:** Manipur chief minister N Biren Singh on Tuesday said that common people should not take the role of law enforcers and excessively question those whom they deem suspicious in the restive northeast-

Asking them not to see enemies everywhere, the chief minister said one should not harass and assault people unreason-

There were allegations from various quarters that volunteers guarding different areas interrogate people whom they think are suspicious and even assault them.

The chief minister also announced a scheme under which a certain category of women will receive ₹ 500 per month from the government.

'It's understandable for the people to be suspicious due to the prevailing situation and it's okay to ask some basic questions. However, acts that amount to humiliation cannot be tolerated," Singh said while speaking at a function here.

A common person cannot don the hat of a law enforcer and question others excessively or assault them, he said.

"Let us know our friends and enemies. Don't see enemies everywhere. Don't harass and assault people unreasonably... Not everyone is the enemy. It's only those outsiders who are armed with sophisticated weapons," the chief minister said.

Singh also expressed disappointment with a recent incident in which two women from Laimanai area in Thoubal district were allegedly assaulted by some people at a place in Bishnupur district.

"Why were the two women assaulted without reason? The matter was known quickly and was amicably settled. It could have blown out of proportion," he said. Singh also appealed to the people not to

take laws into their own hands. "Whenever there is seizure of drugs or apprehension of robbery, please do not take laws into your hands as it will create tension. Rather, hand them (the accused)

over to the police," the chief minister

'PM Narendra Modi ji, BJP president JP Nadda, home minister Amit Shah, chief ministers of other states, Union ministers, senior BJP leaders from other states, eminent personalities, and intellectuals will attend the ceremony," Sao said.

# First-time BJP MLA Bhajan Lal Sharma to be new Rajasthan CM

**JAIPUR, Dec 12:** The BJP on Tuesday picked first-time MLA Bhajan Lal Sharma as Rajasthan's new chief minister, ending days of speculation that followed its victory in the assembly polls.

The surprise choice was announced after BJP MLAs met here and elected the 56-year-old legislator from Sanganer as the leader of its legislature party. He is at present a Rajasthan BJP general secretary. Diya Kumari and Prem Chand Bairwa will be the deputy chief ministers and Vasudev Devnani the speaker of the state assembly, said senior BJP leader Rajnath Singh, who led a team of three party central observers to oversee the meeting. Following the meeting at the BJP office here, chief minister-designate Sharma met Rajasthan Governor Kalraj Mishra and staked claim to form the next government in the state.

The BJP won 115 seats in the November 25 assembly elections, while the Congress got 69 seats. Polling was held on 199 of the 200 seats in the state.

BJP state president CP Joshi presented a letter to the governor, informing that Sharma has been elected as the leader of the BJP legislature party in the state, according to a Raj Bhawan statement.

Kumari is a member of the erstwhile Jaipur royal family and a Rajput, while Bairwa a Dalit leader and Sharma a Brahmin. Vasudev Devnani is from the Sindhi community. At the meeting, the CMdesignate's name was proposed by former chief minister Vasundhara Raje, who was herself considered to be in the running for the top post. Sharma is the third in the series of little known MLAs who have been elevated by the BJP to the chief minister's post after the recently held assembly elections,



The others are Vishnu Deo Sai. who has been picked as the CMdesignate for Chhattisgarh, and Mohan Yadav, who has been picked for the post in Madhya Pradesh. Elections were held between November 7 and November 30 in Rajasthan, Madhya Pradesh, Chhattisgarh, Telangana and Mizoram. The Congress won in Telangana and the Zoram People's Movement in Mizoram. Rashtriya Sangh-backed Swayamsevak Sharma won the Sanganer constituency with a margin of 48,081 votes. Sharma, who belongs to Bharatpur district, holds a master's degree in political science. Prior to the legislature party meeting, a group photo was taken and Sharma

seen standing in the last row. Before Sharma, Raje was the preferred choice of the BJP for the post for 20 years. She was chief minister twice -- from 2003 to 2008 and from 2013 to 2018. The Congress was in power in the state in the intervening years with Ashok Gehlot at the helm.

In what was seen as a show of strength following the November 25 polls, several MLAs had met Raje over a number of days leading to the legislature party meeting.

Singh after the meeting told reporters that Raje had proposed leader of the legislature party. This was unanimously accepted, the defence minister said

He said Devnani, Kirodi Lal Meena, Madan Dilawar and Jawahar Bedham were the first to accept the proposal. Following this, Singh said, he declared the name of the leader of the BJP legislature party - Bhajan Lal Sharma.

"I am assured that in the leadership of Bhajan Lal Sharma, Raiasthan will move on the path of development. All have congratulated Sharma," he said.

Along with this, Singh also declared that Kumari and Bairwa will be the deputy chief ministers and Devnani the assembly speaker. Kumari is a two-time MLA and onetime MP and this time she won from Vidhyadhar Nagar with a margin of 71,368 votes. The 51-year-old BJP leader became an MLA for the first time in 2013 from Sawai Madhopur. In 2019, she was elected as MP from Rajsamand.

Bairwa, who was declared deputy chief minister along with Kumari, is a Dalit face in the BJP. The 54-year-old won the Dudu constituency in the November 25

### Kerala Guv accuses CM hatching conspiracy after attack by SFI activists

NEW DELHI, Dec 12: Kerala Governor Arif Mohammed Khan on Tuesday claimed that his car was "attacked" by the Students Federation of India (SFI) activists at the behest of chief minister Pinarayi Vijayan as he has called for a report on the financial health of the state government.

The chief minister is saying the government is not bound to reply to every query of the Governor. Let him not reply. I will wait for 10 days. And then, if the state is in crisis, it is my duty to make my recommendations to the central government," Khan told reporters at Kerala Bhavan, a day after the incident in Thiruvananthapuram. He said the state chief secretary in an affidavit to the high court has stated that the Kerala government is not in a position to disburse the pension of employees.

The state chief secretary also stated in the affidavit that the Kerala government is not in a position to honour the financial guarantees that it has given, he said, adding "Which means financial emergency in the state And I have asked for a report". Khan claimed that the state government is "so piqued" by him after he has called for a report on Kerala's financial health following the chief secretary's affidavit to the high court.

CPI(M)-affiliated SFI activists allegedly hit the Kerala Governor's car while he was on his way to the Thiruvananthapuram International Airport to leave for Delhi. "It is the chief minister who has hatched this conspiracy (to attack him). Three days ago, he made a public statement. He said the governor is provoking the students. But he did not give the instance as to how I am actually provoking them," Khan said

"This is not the first time... In Kannur, they had tried to assault me physically. The one who was preventing police from taking action against those creating disturbance has been rewarded by the chief minister by appointing him his secretary," he charged.

After meeting Khan at Kerala Bhavan, Union minister V Muralidharan and former president of the BJP's state unit slammed the Left Democratic Front (LDF) government over Monday's incident and said it depicted the dangerous situation and the level of law and order situation in Kerala.

"He was attacked thrice during his travel from the Rai Bhavan to the airport.... The Kerala chief minister and communist party (CPI-M) and the communist party secretary have been issuing threats to the governor for the last few weeks," Muralidharan alleged. "It's because the governor has been upholding the law and the Constitution and is also taking a firm stand against the corruption of the state government and nepotism. (PTI)

### Govt to move amendment to bring CEC, ECs on par with SC judges

NEW DELHI, Dec 12: The government has decided to retain the status of the Chief Election Commissioner (CEC) and other election commissioners on par with judges of the Supreme Court following protests by opposition parties and former chief election commissioners. At present, the CECs and ECs enjoy the status of a Supreme Court judge.

The CEC and other Election Commissioners (Appointment, Conditions of Service and Term of Office) Bill, 2023 introduced in the Rajya Sabha in August this year had proposed to bring the status of the CEC and other ECs on par with the Cabinet Secretary.

The opposition parties and some former CECs had opposed the move, saying it will go against the independence of the institution.

Now the government has decided to move amendments to the Bill pending in the Rajya Sabha.

One of the amendments which Union law minister Arjun Ram Meghwal will move states that "The CEC and other commissioners shall be paid a salary which is equal to the salary of a judge of the Supreme Court.'

According to another amendment. a search committee headed by the Union law minister comprising two other members not below the rank of secretary to the government of India, shall prepare a panel of five persons

The official amendment also seeks to insert a new clause in the bill to protect CEC and ECs from court cases while discharging their official duties. It states that notwithstanding anything contained in any other law for the time being in force, no court shall entertain or continue any civil or criminal proceedings against any and other person who is or was a Chief Election Commissioner or an Election Commissioner.

The new clause comes against the backdrop of the Telangana High Court placing under suspension a special sessions judge in

for the selection committee. In the connection with a "direction" given by him to police for register. ing an FIR against Chief Election Commissioner Rajiv Kumar and several others, saying the judge acted in "undue haste"

Another proposed amendment made it clear that the chief election commissioner shall not be removed from his office except in like manner and on the like grounds as a judge of the Supreme Court. It also states that the other Election Commissioner shall not be removed from office except on the recommendation of the Chief Election Commissioner.

These two clarifications are in line with constitutional provisions mentioned in Article 324 dealing with the Election Commission, a former poll panel functionary pointed out. The bill is listed for consideration and passage in the Rajya Sabha

### SC defers hearing on CBI plea against accused in loan fraud case

NEW DELHI, Dec 12: The Supreme Court on Tuesday deferred until January 3 next year the hearing on the Central Bureau of Investigations' (CBI) plea challenging the Bombay High Court order granting bail to former ICICI Bank CEO and MD Chanda Kochhar and her husband Deepak Kochhar in a loan fraud case. A bench comprising Justices Bela M Trivedi and Satish Chandra Sharma took note of the submissions of senior advocate Amit Desai, appearing for the Kochhars, that he would like to appear physically before it to aroue the case

Desai, who was appearing virtually from Mumbai, said there were some connectivity issues, and sought an adjournment.

Additional Solicitor General S V Raju, who represented the CBI, opposed Desai's plea for adjournment, saying the hearing be held on Wednesday and not adjourned for a long period. The bench then fixed it for hearing on January 3 next year. The bench had on October 16 sought a response from the Kochhars on the CBI's petition challenging the interim bail granted to them in the case by the Bombay High Court.

ASG Raju had said the high court proceeded on a wrong presumption that the offence is punishable with a maximum sentence of seven years imprisonment without considering section 409 of the breach of trust by public servant), which entails a sentence from 10 years to life imprisonment. The bench had asked Raju as to how section 409 (criminal breach of trust by a public servant) of the IPC came into play when it was a private bank. The law officer had replied that the bank may be private but the matter involves public money.

Later, the top court had pulled up the probe agency for not objecting to repeated extension of the two-week interim bail granted to Chanda Kochhar and her husband. The Bombay High Court had on

A day after bail was granted, Chanda Kochhar walked out of the Byculla women's prison in Mumbai, while her husband was released from the Arthur Road jail.

The high court had held that the arrest of the Kochhars was in violation of Section 41A of the Code of Criminal Procedure (CrPC). which mandates sending notice for appearance before the police officer concerned. The couple was arrested by the CBI on December 23. 2022 in connection with the Videocon-ICICI Bank loan case. Apart from the Kochhars, the CBI also arrested Videocon group founder

**NEW DELHI, Dec 12:** The Union ministry of home affairs on Tuesday approved the release of ₹ 338 crore to Gujarat and ₹ 633 crore to Himachal Pradesh as financial assistance for damages caused by natural calamities. The Union home minister's office said in a post on X that Gujarat was severely affected by Cyclone Biparjoy and, under the guidance of Prime Minister, the Centre and the state made advanced preparations before it, achieving a zero-casualty rate during the natural calamity. In the aftermath of the extremely severe cyclone, the Union ministry of home affairs (MHA) immediately deputed the inter-ministerial central team to assess the damages, without waiting for a memorandum from the state govt. "The MHA has approved the financial assistance of ₹ 338.24 crore to Gujarat today," the Home Minister's Office said. The Centre had earlier released the first installment of its share, amounting to ₹ 584 crore, to the State Disaster Response Force. The home minister's office said in another post that the ministry also approved an additional financial assistance of ₹ 633.73 crore from the National Disaster Response Fund for Himachal Pradesh. ### Infant stuck in Odisha bore well, rescue operations on

BHUBANESWAR/ SAM-BALPUR (ODISHA, Dec 12: An

infant was found stuck in an abandoned bore-well in Odisha's Sambalpur district on Tuesday. prompting the state government to launch a rescue operation, officials

The bore well at Laripali village in Rengali area is 15-20 feet deep and oxygen is being supplied into it. The baby, apparently newly born, has no claimant, police said.

The state's special relief commissioner sent fire services personnel from Rengali and one team of Odisha Disaster Rapid Action Force Jharsuguda to the spot to conduct the rescue operation.

An NDRF team from Mundali in Cuttack is also on its way to the bore-well site, said Gyanranjan Dash, the managing director of Odisha Disaster Management Authority.

Local people came to know about the presence of the child inside the bore well after hearing cries, police said.

The abandoned bore-well is located in a forest close to the village. The police said it was not known how the infant got into the well. Locals suspect that the infant might have been dumped there by

Sambalpur additional district magistrate Pradeep Sahoo said, "Rescue operation has started and oxygen is supplied into the bore well. The ODRAF team has dug a

parallel pit." He expressed hope that the child would be rescued soon.

In another incident, a five-yearold boy fell into a borewell at a village in Alirajpur district of Madhya Pradesh on Tuesday, and efforts were on to rescue the child. police said.

The incident occurred around 4.30 pm in Khandala Davri village, about 20 km from the district headquarters, Alirajpur superintendent of police Rajesh Vyas told PTI.

The boy was stuck at a depth of around 20 feet and a rescue operation was underway to save him, he

A parallel pit was dug with the help of machines, but the rescue would take time because of the rocky terrain, the official said.

All the necessary precautions would be taken for the child's safety, he added. (PTI)

### PM Modi calls for global framework for ethical use of AI

NEW DELHI, Dec 12: Prime Minister Narendra Modi on Tuesday flagged the threat falling of artificial intelligence (AI) tools in the hands of terrorists pose to the world as he called for a global framework for the ethical use of AI.

Speaking at the Global Partnership on Artificial Intelligence Summit, he said AI can become the biggest tool for development in the 21st century, but it also equally be a force in destroying the 21st century.

"Besides the challenge of deepfakes, cyber security, and data theft, AI tools falling in the hands of terrorists pose a big threat. Global security will face a big threat if AI-laced weapons were to reach terrorist organisations. We have to deliberate on this issue and reach a concrete plan to stop the misuse of AI," he said.

The Prime Minister said India had during its G20 presidency proposed creating a responsible, humancentric governance framework for AI.

"Just like we have agreements and protocols for various international issues, we have to create a global framework for the ethical use of AI. This will include a protocol for testing and deployment of high-risk and frontier AI tools," he said. India is committed to the responsible and ethical use of artificial intelligence,

Modi said AI has the potential to revolutionize India's tech landscape and the government will soon be launching an AI mission.

AI has the potential to transform sectors including healthcare and it can play a big role in sustainable development, he said. But "we have to tread very cau-

The direction of AI will be dependent on human values and democratic values, he said. Trust on AI will rise if ethical, economic and social concerns are addressed. Privacy concerns will get addressed if data is secured, he said.

"We have to complete the global framework within a set timeframe," he said adding this was essential for the security and progress of the world and humanity. The Prime Minister said AI has to be made all-inclusive as only then it will yield more inclusive results.

AI, he said, is not just new technology but a worldwide movement. (PTI)

Jankar, Sachin Ahir, Anil Parab and others. He also said courier companies have been appealed to scrutinise parcels, and surprise checks equipped with modern technology were being conducted at courier offices to curb the drug trade.

Ahir raised the issue of a case pertaining to drug racketeer Lalit Patil and removal of Sanjiv Thakur from the post of dean of

Pune-based Sassoon Hospital. Fadnavis assured that proper action would

be taken following a thorough inquiry. Patil emerged as the kingpin of a drug racket that was recently busted by the Sakinaka police in Mumbai in a two-month-long operation, which included the seizure of mephedrone worth about Rs 300 crore and a raid at a drug manufacturing unit in Nashik.

The case took a new turn after Patil, who was in Pune's Yerawada prison over his role in another drug case but was admitted to government-run Sassoon Hospital in that city, escaped on October 2 while being taken for X-ray imaging. He was arrested in Karnataka two weeks later.

Fadnavis also said the government has initiated action against 172 Nigerians involved in drug-related offenses. A detention centre has been established for Nigerian nationals engaged in such offences, he said. (PTI)

# Mumbai cops form SIT to probe death of



MUMBAI, Dec 12: Mumbai Police on Tuesday formed a special investigation team (SIT) to probe the death of Disha Salian, the ex-manager of late actor Sushant Singh Rajput, an official said.

He said Malvani police station senior inspector Chimaji Adhav will investigate the case and the investigation will be supervised by deputy commissioner of police, Ajay

Salian (28) was found dead on June 8, 2020, days before Rajput (34) was found hanging in his flat in suburban Bandra in Mumbai. According to police, Salian allegedly committed suicide by jumping from a high-rise building in Malad.

Her father Satish Salian had written to police stating that he didn't suspect any foul play in his daughter's death. He had also expressed "complete satisfaction" with the probe by Mumbai Police.

"If anything official comes out, then that day we will reveal the information we have about them. If they level false allegations against us, then we will bring out the true information against them," the Sena (UBT) leader said without naming anyone

Shiv Sena (UBT) leader Ambadas Danve told reporters that the announcement for SIT was made last year as well and that Salian's death had been investigated on earlier occasions also.

"I demand that an SIT probe also be initiated into Judge Loya's death. If you want to probe Disha Salian's death, you can do it....Politics is being done," Danve told reporters in the Vidhan Bhavan premises in Nagpur where the winter session of the state legislature is currently under-

### 17,861 people granted

Giving some figures, the Centre said 100 foreigners tribunal are presently working in Assam and as on October 31, 2023, more than 3.34 lakh cases have been disposed of and still 97,714 are pending as on October 31. It said the number of cases pending before the Gauhati High Court, arising from the orders of the Foreigners Tribunal are 8,461 as on December 1, 2023.

The government gave details about the working of the Assam Police, fencing of borders, border patrols and other mechanisms adopted to dissuade infiltration. On December 7, the top court directed the Centre to provide data on the number of Bangladeshi immigrants granted Indian citizenship in Assam between January 1, 1966 and March 25, 1971.

A five-judge constitution bench headed by Chief Justice D Y Chandrachud, which is hearing a batch of pleas on validity of section 6A of the Citizenship Act had asked the state government to provide the data to the Centre It had also asked the Centre to inform it about the steps taken to deal with illegal immigration into India, par-

ticularly the North Eastern states. Section 6A of the Citizenship Act relates to illegal immigrants in Assam. (PTI)

The CAA seeks to provide Indian citizenship to Hindus, Jains, Christians, Sikhs, Buddhists and Parsis entering India on or before December 31, 2014 from Bangladesh, Pakistan and Afghanistan after five years of residence

It was passed by both Houses of Parliament and given the Presidential assent in December 2019, though the rules are yet to be notified.

Assam witnessed widespread anti-CAA agitation led by students and other organisations in early 2019 before the Lok Sabha polls, but it subsided after the 2016 format of the Bill lapsed in June 2019 when the term of then Lok Sabha ended as it could not be tabled and passed in Rajya Sabha.

When the Bill of the present CAA was passed in both Houses of Parliament in December 2019, the state witnessed one of the most violent protests for several days as agitators engaged in pitch battles with police and administration in almost every major city or town, leading to the death of five persons. This led to a crackdown by the state government, including arrests of leaders of the agitation, snapping of internet connectivity and imposition of curfew. (With inputs from PTI)

### ISRO to put first astronaut on Moon by 2040 Maiden manned mission 'Gaganyaan' to send astronauts into Low Earth Orbit

THIRUVANANTHAPURAM, Dec 12: After the historic success of its Chandrayaan-3 lunar mission, the Indian Space Research Organization (ISRO) is going full throttle with its plans to send Indian astronauts for the first time to the Moon by 2040, ISRO chairman S Somanath said. The Bengaluru-based space agency is currently working on the country's maiden manned mission, 'Gaganyaan', which aims to send astronauts into Low Earth Orbit and bring them back safely to earth.

Four pilots from the Indian Air Force who were selected for the mission are undergoing training at the Astronaut Training Facility in Bengaluru, the top scientist said.

In an exclusive article for Manorama Yearbook 2024, the secretary of department of space said, "Looking ahead, ISRO aims to take the next step in space exploration with the Gaganyaan programme, planning to launch a crew of 2 to 3 Indian astronauts into Low Earth Orbit (LEO) for up to three days before safely returning them to a predefined site in Indian wa-

The inaugural manned mission involves developing critical technologies, including a human-rated (capable of safely transporting humans) launch vehicle (HLVM3), an orbital module comprising a crew module (CM) and service module (SM) and life support systems.

Two identical un-crewed missions (G1 & G2) besides Integrated Air Drop Test, Pad Abort Test, and Test Vehicle flights will precede the manned mission.

CM is a habitable space with an Earth-like environment in space for the crew and is de-



signed for safe re-entry. Safety measures also include a Crew Escape System (CES) for emergencies, a statement issued by Malayala

Manorama said The first development flight of Test Vehicle (TV-D1) was launched on October 21, 2023, and it successfully demonstrated in-flight abort of the Crew Escape System, followed by crew module separation and its safe recovery from

the Bay of Bengal by the Indian Navy. "The success of this test flight was crucial for subsequent unmanned missions and the ultimate human space mission, expected to be launched in 2025," said Somanath, who is also chairman of the Space Commission.

Aditya L1, which is India's maiden solar exploratory mission, is also an important mission of the ISRO, he noted. It will study the sun from the unique vantage

point of Lagrange Point 1, showcasing the

country's prowess in both lunar and solar re-

search. Launched on September 2, Aditya L1 is poised for a five-year mission. The spacecraft is on its intended path towards

Sun-Earth Lagrange Point 1(L1), approximately 1.5 million km from Earth, where it will be inserted into a Halo orbit in January 2024, he explained On the success of the Chandrayaan-3 mis-

LONDON, Dec 12: Newly flush surprise, though. with Saudi cash, Newcastle has chosen to tread a strategic and methodical path in its bid to reach the summit of European game under the richest owners in soccer. The club is encountering some teething problems by playing the slow game.

Qualifying for the Champions League last season arguably came ahead of schedule for Newcastle and manager Eddie Howe, and they're struggling to juggle the demands of playing in Europe's top competition while also keeping up with their rivals in the Premier League.

With a relatively shallow squad hit by a spate of injuries and running on empty amid a packed fixture schedule, the team has dropped to seventh in the league following back-to-back losses last week and, on Wednesday, faces the very real prospect of being eliminated from

Champions League before the knockout stage.

Newcastle hosts AC Milan with both teams on f i v e points two behind second place Paris Saint-Germain and five adrift of already-qualified Borussia Dortmund

Newcastle needs a win at St. James' Park and for PSG to draw or lose against Dortmund in Germany to seal a top-two finish and advance to the last 16.

Lose and Newcastle would be out of Europe completely, not even dropping into the Europa League playoffs courtesy of a third-place finish in the group.

It's a huge night, then, for the northeast team and its Saudi ownership — the Public Investment Fund — following the 300million-pound (then \$409 million) purchase of the club in 2021 that invited accusations of sportswashing amid scrutiny of the kingdom's human rights record. Failing in the Champions League, the biggest show in club soccer, would be an early blow to its new-found status as a major disruptor for the established elite.

# Mandhana bats for Women's WTC but England's Beaumont says long way to go

NAVI MUMBAI, Dec 12: India vice-captain Smriti Mandhana on Tuesday welcomed the idea of organising a World Test Championship in women's Test cricket, but England veteran Tammy Beaumont said it would be unfair to have such a competition when only three countries are playing regularly.

There is a huge disparity among women's teams in terms of playing Test cricket as only England, Australia and India have played in the longest format regularly even though there is a long gap.

"I would love to be a part of the World Test Championship but that is for the boards and the ICC to decide," Mandhana told the media ahead of India's training session here on Tuesday. "Having watched a lot of men's Test

cricket and championships that would be really exciting to be a part of something of that sort. But as I said, that would be their (administrators') decision," she added. India and England will face-off in a oneoff Test starting here on Thursday at the DY

"That will have to be a very big investment from the ICC, I do not think they are probably willing to put into," she said.

Beaumont advocated the countries to have more matches during a bilateral tour and get other nations like Pakistan, Sri Lanka and New Zealand playing more women's Test

"They are still trying to develop the T20 game across the globe, the way you have seen Thailand and other countries come into T20 cricket. I think that should stay as a focus, however, I would love to see more nations do maybe like a multi-format series like we do in the Ashes," she said.

"So say, India come over and we do Test match, ODI and T20Is and (get an) overall winner from that. We do that from South Africa and New Zealand and all those teams and build from there.'

"One day, I would love to see a World Test Championship but at the moment I do not think it would be fair when you have India, Australia and England have played a lot of Tests in the last four years but other teams like Pakistan, Sri Lanka and New Zealand have not played any Test cricket in the last 15 years," Beaumont added.

"The imbalance is still there, we need to build it from ground up a little bit longer and definitely have many Tests," said the England opening batter. (PTI)

"We had conversations about where my best cricket is likely to be played moving forward and naturally in Test cricket, it looks likely to be at home.

Beaumont said even though on field England's mindset does not look similar to the men's Bazball approach, they share similar values in terms of trying to move the game all the time.

The mindset is very similar, in terms of, we want to move the game forward at all times and be putting bowlers and batters under pressure. Having that wicket"Potentially won't have quite as funky

fields as Ben Stokes in the Ashes when he was at silly point to a seamer but at the same time we want to try and inspire the next generation of female cricketers not just in England but across the world,' added the opening batter.

Beaumont said despite the lack of playing red-ball cricket, she expects hosts India to have more knowledge of the conditions. "We tend to focus on ourselves, we are

feeling happy and how we want to play our red-ball cricket and what our method is and what our ethos are around it," she said.

"Having regular Test matches have helped us get to this point but again India have probably played more in the last 2-3 years than they have done in the last 10 years.'

"I am sure they have got their learnings and probably have little more knowledge of the surface here at the DY Patil, having played here in the WPL and other times,' Beaumont added.

Beaumont struck 208 in the Women's Ashes Test in June, a knock that the batter says unlocked new aspects of her game.

"Took a lot of learning from that. It unlocked something in terms how I want to play red-ball cricket and actually play a ong innings across a couple of days," she

"In particular, how we want to play Test cricket. My dad reminds me every time that you start on nought, so, I am not going to be thinking I am on 208 but it gave me a lot of confidence knowing I can do it and I have to try and find a way to get somewhere close to that," Beaumont added. (PTI)
