Suspected ULFA cadre, 3 youths hurt in police firing in Assam

24: A suspected ULFA(I) cadre and three youths purportedly en route to join the banned outfit were injured in two separate incidents when they allegedly attempted to escape from custody, Assam Police said on Sunday.

While the militant, reportedly involved in a suspected grenade blast in Sivasagar, was injured on Sunday morning near Geleky, the other three were hurt in firing in Tinsukia district on Saturday night, they

Sivasagar Police in a statement said that the person 'was found directly involved' in the December nine grenade blast incident near CRPF Camp in the Joysagar area of the district

The police had earlier refrained from confirming that the blast had taken place, though four suspects were arrested in this regard last week and the injured suspect was not among them.

The accused had "went to ULFA during the end of 2019 and after

GUWAHATI/ TINSUKIA, Dec spending about a month in the ULFA camp based in Myanmar he came back to Assam", the statement said.

On his return journey, he was arrested by Assam Rifles and imprisoned at Khonsa Jail in Arunachal Pradesh for about four months.

Retired SSP shot dead by terrorists in J&K

SRINAGAR, Dec 24: A 72-year-old retired police officer and local "muezzin", Mohammad Shafi Mir, was shot dead by terrorists on Sunday morning while he was giving a call for "azaan" from a mosque in north Kashmir's Baramulla district, leaving the community

According to Mir's cousin Mohammad Mustafa, who was present at home during the incident, the call for pre-dawn prayers was being given through a loudspeaker when it abruptly stopped

Mir's last words were "reham" (mercy), Mustafa recalled. The "azaan" had stopped at the phrase "Ashhadu Anna Mohammadu Rasool-Allah" (İ bear witness that Mohammad is the messenger of Allah).

Police officials stated that Mir, who retired as a senior superintendent of police (SSP) in 2012, was shot inside the mosque located in the Gantmulla locality of "Terrorists fired upon Shri Mohd Shafi, a retired po-

lice officer, at Gantmulla, Sheeri Baramulla, while praying 'azaan' in the mosque and succumbed to injuries," the Kashmir Zone Police said. Police are also looking into the possibility of per-

sonal animosity as the deceased was shot with a .12 bore gun, the officials said.

Mir's family members described him as a dedicated ndividual who had taken up the role of the local "muezzin" and faithfully carried out his duties at the mosque. After the incident, a large number of people gathered at Mir's house and at the mosque complex to pay their respects. He is survived by his wife, two sons, and a daughter. Mustafa, speaking to reporters, shared his account of the incident, stating, "He (Mir) was my cousin. He used to call for prayers every day. This morning, while I was reading the Quran, as usual, he started the 'azaan', so I closed the Quran."

He added, "my cousin recited 'Ashhadu Anna Mohammadu Rasool-Allah', and then the 'azaan' stopped. I only heard a shout of 'reham' (mercy). It was in a heavy voice." (PTI)

India logs 656 new Covid cases NEW DELHI, Dec 24: India saw a single-day rise of

656 Covid infections while the active cases have increased to 3,742, according to Union health ministry data updated on Sunday.

The death toll was recorded at 5,33,333 with one new death reported from Kerala in a span of 24 hours, the data updated at 8 am showed. The country's Covid case tally is 4.50 crore (4,50,08,620).

The number of people who have recuperated from the disease has increased to 4,44,71,545, and the national recovery rate stands at 98.81 per cent, according to the health ministry's website. The case fatality rate stands at 1.19 per cent.

According to the ministry's website, 220.67 crore doses of Covid vaccines have been administered in the country so far. (PTI)

'The act of searching online to evaluate news increases belief in highly popular misinformation'

Poor quality results for online searches made people believe possible misinformation: Study

NEW DELHI, Dec 24: A study has found that people who performed online searches to verify the truthfulness of a piece of possible misinformation actually ended up believing it due to "poor quality results" from search engines.

The findings, according to researchers, flag the need for online search engines to address the challenge posed by the appearance of non-credible information at the top of search results.

The study conducted by a research team from the University of Central Florida, New York University and Stanford University, US,



aimed at understanding the impact of search results produced when people used search engines to evaluate the

veracity of news. The findings, published in the journal Nature, highlighted the need for media literacy programs to

empirically tested interventions and search engines to invest in solutions to the challenges identified by this

"Our study shows that the act of searching online to evaluate news increases belief in highly popular misinformation -- and by notable amounts," said study author Zeve Sanderson, founding executive director of New York University's Center for Social Media and Politics (CSMaP). The researchers evaluated



Main-board IPOs weather global headwinds, collect ₹ 52,000-cr in 2023

NEW DELHI, Dec 24: The capital generated through mainboard IPOs dipped slightly to just over ₹ 52,000 crore in 2023 amid global volatility driven by rising interest rates and geopolitical risks, while the number of issues rose. Experts maintain a strong bullish outlook on the IPO market for 2024. Excluding LIC's blockbuster maiden public issue of ₹ 20,557 crore in 2022, initial public offering (IPO) collection actually increased by 36 per cent this year. Notably, mid and small-cap

companies were in flavor this year, given the considerable tailwind in the markets. The market environment for IPOs has been extremely robust in 2023, though the start of the year was tepid due to global headwinds. "A key reason for the strong interest in IPOs has been an increased focus on profitability and reasonable pricing of deals, at least relative to prevailing higher valuation multiples in listed peers. Another strong pillar of the Indian market ecosystem is the robust yet efficient regulatory framework,' said Mahavir Lunawat, Managing Director, Pantomath Capital Advisors. V Prashant Rao, Director & Head - ECM, Investment Banking, Anand Rathi Advisors, believes that the momentum of 2023 will roll over to 2024 and that could be a golden period for Indian primary

"We hold a strong bullish outlook on the IPO market in 2024. This optimism is buoyed by robust domestic and foreign investments, driven by superior growth prospects of the Indian markets. The inflows are expected to gain uncertainties related to the elec-

India's economic growth to boost demand of corporates: Fitch Ratings



KOLKATA, Dec 24: Leading credit rating firm Fitch Ratings expects that India's resilient economic growth will boost demand of the corporates. In its latest research report on 'India Corporates: Sector Trends 2024', Fitch said that this is a sequel to the robust performance of the corporates in 2023 and will offset weakness from slowing growth in the key overseas markets. Rising demand and easing input cost pressure should boost margins of the corporates in the next financial year, Fitch said. Fitch said that with strong domestic demand growth, it is expected that India will be among the world's fastest-growing countries, with resilient GDP growth of 6.5 per cent during the fiscal 2024-25. This is despite a challenging global backdrop and the cumulative impact of the recent monetary tightening, it said. Sectors like cement, electricity and petroleum products are expected to witness a strong demand with high-frequency data in 2023 sustained well above pre-COVID pandemic levels. Fitch said that India's improving infrastructure will also boost steel demand. Slowing down in the US and the Eurozone is likely to moderate growth of the IT services. Fitch said rising domestic auto sales volume should drive revenues of the auto suppliers, while travel and tourism conditions also improved in 2023. (PTI)

Around 24 companies, which have already received clearance from the markets regulator Sebi but are yet to launch their IPOs, are looking to raise over ₹ 26,000 crore. Add to this, 32 more companies have filed their draft papers with Sebi and are awaiting clearances to mobilise more than ₹ 35,000 crore, according to data provided by Prime Database.

Going by the industry data, as many as 58 maiden public issues have been floated this year to raise ₹ 52,637 crore, including ₹ 3,200crore IPO of Nexus Select Trust REIT. The fund mobilization in 2023 was lower than 40 companies raising ₹ 59,302 crore last year. This was largely due to the ₹ 20,557crore LIC issue, which constituted as much as 35 per cent of the total amount raised during 2022. Before that, 63 companies had mobilized ₹ 1.2 lakh crore through the initial share sales in 2021, which was the best IPO year in two decades. This fundraising was driven by excessive liquidity and increased retail investor participation, which spurred a persistent euphoria in the primary market. In the past three years, more than 150 mainboard IPOs have come for listing.

"Despite high global volatility due to rising interest rates and geopolitical risks, 2023 was a very good year for Indian IPO markets," JM Financial's Agarwal said. Of the total 58 issues, 38 were floated during September and

The big size issues were missing in 2023 with an average ticket size of ₹865 crore. The same was the case last year too. Except for LIC and Delhivery, the majority of the IPOs were in the sub-₹ 1,500 crore IPO category.

Mankind Pharma IPO (₹ 4,326 crore) was the largest issue of 2023, followed by Tata Technologies (₹ 3,042 crore), JSW Infrastructure (₹ 2,800 crore), RK Label (₹ 1,964 crore), and Cello World (₹ 1.900). The smallest IPO in the period was Plaza Wires, which raised

No takers for rupee payment for oil imports: Oil ministry in Parliament

NEW DELHI, Dec 24: India's push for rupee to be used to pay for import of crude oil has not found any takers as suppliers have expressed concern on repatriation of funds and high transactional costs, the oil ministry told a parliamentary standing committee.

The default payment currency for all contracts for import of crude oil is US dollar as per the international trade practice. However, in a bid to internationalise the Indian currency, the Reserve Bank of India on July 11, 2022 allowed importers to pay with rupees and exporters be paid in rupee.

While there has been some success with non-oil trade with a select few countries, rupee continues to be shunned by oil exporters.

"During FY 2022-23, no crude oil imports by oil PSUs was settled in Indian rupee. Crude oil suppliers (including UAE's ADNOC) continue to express their concern on the repatriation of funds in the preferred currency and also highlighted high transactional costs associated with conversion of funds along with exchange fluctuation risks," the oil ministry told the parliamentary department related standing committee.

The ministry, whose subimissions are part of the committee's report which was tabled in Parliament last week, said Indian Oil Corporation (IOC) has informed that it incurred high transaction costs as crude oil suppliers pass on the additional transactional costs to IOC." The RBI, it said, had last year permitted opening of rupee vostro accounts in the partner trading country. Under this mechanism, Indian importers undertaking imports through this mechanism shall make payment in Indian



the special Vostro account of the correspondent bank of the partner country, against the invoices for the supply of goods or services from the overseas seller /supplier.

"Payments for crude oil can be made in Indian rupee, subject to the suppliers' complying with regulatory guidelines in this regard," the ministry said. "Currently, Reliance Industries Ltd and oil PSUs do not have an agreement with any crude oil supplier to make purchases in Indian currency for supply of crude oil." India is the world's third largest energy consumer. With its domestic production meeting less than 15 per cent of its needs, the country imports the remaining crude oil, which is converted to fuels such as petrol and diesel at refineries.

In the 2022-23 (April 2022 to March 2023) fiscal, India spent \$157.5 billion on import of 232.7 million tonnes of crude oil. Iraq, Saudi Arabia, Russia, and UAE were its biggest suppliers. Of this, 141.2 million tonnes came from the Middle East, accounting for 58 per cent of all supplies.

In the current fiscal, India imported 152.6 million tonnes of crude oil between April and No-

"India's consumption would be about 5.5-5.6 million barrels per day. Out of that, we import about 4.6 million barrels per day, which is about 10 per cent of the overall oil trade in the world," the ministry told the committee

On price volatility, the ministry said PSU oil firms are impacted by the volatility in prices of crude oil but only to the extent of fuel and

"The prices of crude oil and refined petroleum products generally move in tandem with each other. Thus, it's the volatility in product cracks (price difference between that of product prices and benchmark crude oil), which impacts the refiners the most." "To hedge against this volatility, oil companies has been hedging the various product cracks as and when the opportunity is presented in the forward market. All the hedge positions are undertaken through OTC (Over the Counter) market with registered international counterparties and details of the hedge is reported to authorised dealer bank on quarterly basis. Further, oil companies are also hedging their forex risk in line with their risk management policies," it added. (PTI)

FPIs pour ₹ 57,300-cr in equities in Dec on account of political stability

NEW DELHI, Dec 24: Foreign portfolio investors (FPIs) have injected over ₹ 57,300 crore into the Indian equity markets this month so far owing to political stability, robust economic growth, and a steady decline in the US bond yields.

With this, total investment by FPIs surpassed ₹ 1.62 trillion this year. Going forward, the New Year is expected to witness declines in US interest rates, and FPIs are likely to increase their purchases in 2024, V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services,

According to the data, FPIs made a net investment of ₹ 57,313 crore in Indian equities in this month (till December 22). This was the highest monthly inflow by them in a year.

This came following a net investment of ₹9,000 crore in October. Before this overseas investors withdrew 39,300 crore in August and September, data with the depositories showed.

The robust inflow from FPIs into the Indian stock markets can be attributed to various factors. Primary among these are political stability and positive sentiments prevailing in the Indian markets, Himanshu Srivastava, Associate Director- Manager Research, Morningstar Investment Research India, said.

Also, the country's stable and robust economy, coupled with impressive corporate earnings and a string of Initial Public Offerings (IPOs), has attracted foreign investors to explore investment opportunities in

Vijayakumar said that the steady decline in U.S. bond yields has caused this sudden change in the strategy of FPIs.

"India's market engine is revving: Strong GDP growth exceeding estimates, coupled with a burgeoning manufacturing sector, paints a vibrant picture for investors, "Mayank Mehraa, smallcase manager and principal partner at Craving Alpha, said.

Globally, the US Fed has signalled three potential rate cuts next year, indicating the end of the rate hike cycle, which bodes well for emerging markets like India. Bhuvan Rustagi, COO and Co-Founder, of Per Annum & Lendbox,

said that easing Fed tightening, declining US treasury yields, and soften-Additionally, there were India-specific factors that prompted FPIs to

invest such as robust economic growth, political stability, improved corporate earnings, and attractive valuations. With regards to bonds, the debt market attracted ₹ 15.545 crore during the period under review. This came after receiving an inflow of ₹ 14,860

crore in November and ₹ 6,381 crore in October, data showed. In terms of sector, FPIs were big buyers in financial services and also

showed interest in sectors like autos, capital goods, and telecom. (PTI)

FMCG flavours: Better volumes and rural demand revival uptick in 2024

NEW DELHI, Dec 24: From an uptick in rural demand to higher volumes and favourable commodity prices, the country's FMCG industry is pinning hopes on diverse catalysts for a double-digit volume-led growth in the new year after a challenging 2023.

Weaker-than-expected festive demand, rainfall deficit that hampered rural growth, unseasonal rains that dampened sale of beverages and higher commodity prices all together cooked a difficult-todigest market recipe this year even though "green shoots" of recovery are becoming more visible.

The sector, which has a high growth potential especially in an emerging market like India, is anticipating 2024 to be a "better year" with favourable input prices benefitting the Home and Personal Care (HPC) as well as certain food business segments.

"We expect the demand situation to improve as we enter the next financial year. We expect FMCG players to increase the pace of innovation and premiumisation and also focus on significant investment behind expanding the quality of rural distribution," Marico MD and CEO Saugata Gupta said.

The FMCG players are also expecting expansion of their profit margins with softening of commodity inflation that would result in increased spending on branding, return of promotional schemes for consumers and increased dividend payout to their shareholders, according to analysts.

Most FMCG companies extend the benefits of moderation in key commodity prices to consumers by



undertaking price cuts or by increasing grammages. They are expecting a faster growth in the premium and large pack sizes, thanks to a stronger urban market and modern trade channels.

Besides, analysts expect a double-digit growth for the sector with higher volumes with market share gains and increase in rural penetration with the come back of popular price packs, which gained prominence when inflation was ruling at

"A combination of weak demand sentiment especially in rural areas due to inflation and increased aggression of smaller players and alternative avenues of spending have led to softer growth of the FMCG sector this year.

Having said that, the economy is on a sound footing, inflation is largely under control and the overall outlook is on an improvement trajectory," Gupta said. He also said that price cuts by large, organised players in the sector will make them more competitive.

Small regional FMCG players have reemerged in the market after the cooling of inflation, giving tough competition to big players, impacting their market share in their pocket of influence in seg-

ments such as soaps, tea, detergent and biscuits Dabur India CEO Mohit Malho-

tra said there has been a marked improvement in consumer sentiments in 2023 with the softening of inflation

"While green shoots of recovery are visible, rural demand is still trailing urban markets. That said, we are hopeful that rural markets will post a strong recovery in the new year. We are already seeing the gap between rural and urban growth continuously shrinking,' he said, adding that going forward, Dabur is looking at both urban and rural markets to drive growth.

Leading consultancy EY India National Leader - Consumer Products & Retail - Angshuman Bhattacharva said that for the FMCG sector, urban growth will continue. "The FMCG industry is expected to grow at over 10 per cent,

and in urban-centric segments above 12 per cent," he said. All said, the rural market contributes around 37 to 38 per cent to

the overall FMCG sales and a bulk of that comes from the food seg-According to the latest report from data analytics firm

NielsenIQ, the rural market, which has been facing a consumption slowdown for the last several quarters, is showing signs of recovery while the urban market is maintaining a "stable rate of growth".

For Tata Consumer Products Ltd (TCPL), 2023 was an "actionpacked year", in which the Tata group FMCG arm had a number of new product launches across categories, expanding its total address-

M-cap of 3 of most valued firms jump ₹70,312 crore

NEW DELHI, Dec 24: The combined market valuation of three of the 10 most valued firms jumped ₹ 70,312.7 crore last week, with Reliance Industries emerging as the biggest winner, amid volatile market conditions.

From the top 10 pack, Reliance Industries, HDFC Bank and Hindustan Unilever were the gainers, while Tata Consultancy Services (TCS), ICICI Bank, Infosys, State Bank of India, ITC, Bharti Airtel and Life Insurance Corporation of India (LIC) faced erosion to the tune of ₹ 68,783.2 crore.

Last week, the BSE benchmark declined 376.79 points or 0.52 per cent after a record-breaking rally. The market valuation of Re-

liance Industries jumped ₹47,021.59 crore 17.35.194.85 crore. Hindustan Unilever added ₹ 12,241.37 crore, taking its valuation to ₹ 6,05,043.25 crore. HDFC Bank's valuation climbed ₹ 11,049.74 crore to ₹ 12,68,143.20 crore.

However, the market capitalisation (mcap) of ICICI Bank plummeted ₹ 30,235.29 crore to ₹ 6,97,095.53 crore.

The valuation of TCS eroded by 12,715.21 crore to 13,99,696.92 crore and that of State Bank of India declined by ₹ 10,486.42 crore to ₹ 5,68,185.42

The mcap of Infosys fell by ₹ 7,159.5 crore to ₹ 6,48,298.04 crore and that of ITC diminished by ₹ 3,991.36 crore to ₹ 5,67,645.03 crore.

Automakers gear for moderate sales after 2023, ready for more EV launches

NEW DELHI, Dec 24: After posting record-breaking volumes in 2023, Indian automobile industry is driving into the new year aware of a lurking moderation in sales growth but ready to embrace green technologies, led by electric

vehicles. Passenger vehicle sales are expected to cross 40 lakh units this year and prices are set to rise from January. Veteran industry leader and Maruti Suzuki India Chairman RC Bhargava said the sales are expected to moderate a bit next year compared to 2023.

He noted that the revival of the small car segment is necessary for the faster growth of the industry.

The share of entry-level cars in the passenger vehicle sales which stood at around 14 per cent in 2018-19 has reduced to around 4 per cent in the April-October pe-

riod this year. "As far as Maruti Suzuki is concerned, I believe that we will have higher growth than the industry," Bhargava told PTI. While being positive on the growth of Electric Vehicle (EV) sales next year, he noted that the focus should be towards all the green technologies which help in meeting the carbon neutrality goals.

Society of Indian Automobile Manufacturers (SIAM) Director General Rajesh Menon said the sales outlook remained positive for the industry going into next year.

"The overall outlook for the Indian automobile industry in 2024 looks good which can be attributed to the all-round economic growth of the country, which is also enabled with the conducive policy environment of the government," he said. On EVs gaining a foothold next year, he said the industry is likely to see continued increase in the share of EVs in all the vehicle

segments. "Though this phase of the FAME Scheme is scheduled to conclude in March 2024, we as an industry are optimistic that Government of India will introduce another version of FAME Scheme beyond March 2024," Menon said. Continuation of the FAME

Scheme after March 2024 will not

only help the consumers but would

also enable the industry to further scale up and provide a wide range of products to the consumers, he added.

Federation of Automobile Dealers Associations President Manish Raj Singhania said the automobile sector is poised for steady growth next year with an expected low single-digit growth in passenger vehicles and high single-digit growth in two wheelers.

The outlook for green technologies and electrification in the automotive sector remains promising, Singhania said when asked about the outlook for the EV segment.

Automotive Component Manufacturers Association of India Director General Vinnie Mehta said the auto components sector is set to experience a continued transition towards electric vehicles, with increased emphasis on safety, prompted by the introduction of Bharat NCAP.

"This shift has resulted in increased integration of Advanced Driver Assistance Systems (ADAS) and enhanced safety offerings by Original Equipment Manufacturers



(OEMs)," he added. SUVs, which have been the flavour of the season, are expected to gain further momentum next year.

"This year SUV share is expected at around 49 per cent for the industry and 60 per cent for Hyundai. In 2024, we can expect the industry's SUV share to cross 50 per cent and company's to go up beyond 60 per cent," Hyundai Motor India COO Tarun Garg said.

Tata Motors Passenger Vehicles

Managing Director Shailesh Chan-

dra said the company will continue to launch new products across Internal Combustion Engine (ICE) and EVs.

"We will integrate the new Sanand factory into our industrial footprint and unlock capacity. We plan to further drive deeper penetration of emission-friendly technologies by strengthening our portfolio of EVs and Compressed Natural Gas (CNG) cars," he said and added that charging infrastructure growth remains the residual

Tata Motors has initiated an open collaboration with key charging players to accelerate the growth of chargers to provide a better experience to the EV buyers,

barrier for mass adoption of EVs.

Homegrown rival Mahindra & Mahindra is also looking to charge up its electrification programme further as there is an increasing customer pull, conducive policy environment and expanding charg-

ing infrastructure. 'We will witness an inflection point when the Born electric products start coming to the Indian market in a significant manner. M&M will bring its Born Electric portfolio starting 2025," Mahindra & Mahindra Auto & Farm Sectors (Executive Director & CEO) Ra-

jesh Jejurikar said. Overall, the auto maker expects the industry to remain dynamic on account of positive macroeco-

nomic outlook, he added. In the luxury segment, Mercedes-Benz India expects an in-

crease in the EV penetration. "However, the tipping point is still a few years away. Customers require convincing of the ownership benefits and hassle free experience of a Battery Electric Vehicle (BEV) over Internal Combustion Engine (ICE) vehicles," Mercedes-Benz India MD & CEO Santosh Iver said. He noted that in tune with the in-

dustry growth, the company expects this year to be its best year ever amid supply-chain related disruptions.

Another luxury carmaker Audi is also upbeat about electrification of its portfolio in India.

"As a brand, we remain committed to enhancing the electric vehicle infrastructure in the country and continue to invest in expanding our charging network," Audi India Head Balbir Singh Dhillon

As for the 2024 outlook, he said, "the year 2023 marked a strong performance in the luxury car segment, propelled by consistent demand. Looking ahead, we remain confident about the growth prospects of the luxury car segment in 2024. (PTI)

Concern over criminal law overhaul

▼n a significant move, Prime Minister Narendra Modi's government has recently replaced three colonial-era criminal laws with new ones, Levoking a sense of nationalism, as per Union Home Minister Amit Shah. The revamped laws include the Bhartiya Nyaya (Second) Sanhita (BNS), Bhartiya Nagarik Suraksha (Second) Sanhita (BNSS), and Bhartiya Sakshya (Second) Bill (BSB), which replace the Indian Penal Code (IPC), 1860, the Code of Criminal Procedure Act, 1973, and the Indian Evidence Act, 1872, respectively. Shah, defending the legislative changes in the Lok Sabha, asserted that the colonial laws were designed to serve British interests, while the new laws aim to deliver justice rather than merely punish. He emphasized the shift towards an indigenous approach, highlighting the bills' alignment with the spirit of the Indian Constitution. However, concerns have been raised about the government's authoritarian streak, particularly in the context of its ambitious agenda to overhaul established structures. Critics argue that the intent and spirit of the laws need closer examination, questioning whether these changes are a substantial improvement or merely a rewording of existing legislation.

The ideological underpinning of the colonial laws, rooted in the English common law principle of justice, focused on not punishing the innocent and upholding the presumption of innocence until proven guilty. Some critics argue that the government's move may reflect a lack of awareness of this historical context and a narrow-minded vision of nationalism. One contentious point is the handling of sedition in the new laws. Shah claimed that the crime of sedition, historically used against freedom fighters such as Balgangadhar Tilak, Gandhi, and Vallabhbhai Patel, has been removed. However, a closer look reveals that a new provision has been introduced to punish those who speak against the country, potentially stifling freedom of speech. The nuanced distinction between criticizing the government's policies and speaking against the nation itself raises concerns about the potential misuse of such provisions. The article underscores the importance of self-criticism in a democratic society and expresses apprehension about laws that discourage dissent. It argues that a country that refuses to engage in self-critical reflection is at risk of stagnation and backwardness. The author points to the need for a balance between maintaining law and order and ensuring that laws are administered justly.

The efficacy of these new laws, the article suggests, hinges on the law enforcement machinery's application and the judiciary's interpretation. The potential for abuse exists if the police force harbors casteist and communal prejudices or if judges are influenced by political considerations rather than impartially upholding justice. The editorial raises concerns about the government's apparent authoritarian attitude and questions the motivations behind the legislative changes. It warns against a narrowminded vision of nationalism and emphasizes the importance of a selfcritical spirit for the growth and progress of any democratic nation. Ultimately, the success of these new laws will be determined by how they are implemented and interpreted in practice. The recent replacement of colonial-era criminal laws by the Modi government, ostensibly to promote nationalism and justice, raises concerns about potential authoritarian overreach. Critics argue that the laws may curtail freedom of speech, and the ideological shift appears to lack an understanding of the historical context. The editorial emphasizes the need for a self-critical spirit in democracy and underscores that the laws' success will depend on fair en-



Atal Bihari Vajpayee - The poet, patriot and politician

The greatness of values that democracy upholds comes through a variety of inclusive processes and procedures. ▼PI(M)'s West Bengal unit secretary Md. Salim's assertion that the CPM will not campaign for INDIA bloc candidates in the 2024 general elections in West Bengal has landed state Congress leaders in more than a spot of bother for good reason.

Could long COVID 'brain fog' be an acquired form of ADHD?

n May, I was invited to take part in a survey by the National Academies of Sciences, Engineering, and Medicine to better delineate how long COVID is described and diagnosed as part of The National Research Action Plan on Long Covid. The survey had several questions around definitions and criteria to include, such as "brain fog" often experienced by those with long Covid. My intuition piqued, and I began to wonder about the similarities between these neurological symptoms and those experienced by people with attention-deficit/hyperactivity disorder, or ADHD. As a medical journalist with clinical and epidemiological experience, I found the possible connection and its implications impossible to

We know that three years of potential exposure to SARS-CoV-2, in combination with the shift in social patterns (including work-from-home and social isolation), has impacted several aspects of neurocognition, as detailed in a recent report from the Substance Abuse and Mental Health Services Administration. A 2021 systematic review found persistent neuropsychiatric symptoms in Covid-19 survivors, and a 2021 paper in the journal JAMA Network Open found that executive functioning, processing speed, memory, and recall were impacted in patients hospitalised with Covid-19. Long Covid may indeed be linked to developing chronic neurocognitive issues, and even dementia may be accelerated.

The virus might impact the frontal lobe, the area that governs executive function — which involves how we make decisions and plan, use our working memory, and control impulses. In October, a paper in Cell reported that long Covid brain fog could be traced to serotonin depletion driven by immune system proteins called viral-associated interferons.

Similarly, the symptoms of attention-deficit/hyperactivity disorder, or ADHD, are believed to be rooted structurally in the frontal lobe and possibly from a naturally low level of



the neurotransmitter dopamine, with contributions from norepinephrine, serotonin, and GABA. This helps explain why people with ADHD, who experience inattention, hyperactivity, and impulsivity, among other symptoms, may seek higher levels of stimulation: to activate the release of dopamine. However, a deficit in serotonin can also trigger ADHD. The same neurotransmitter, when depleted, may be responsible for brain fog in long Covid.

ADHD is a form of neurodiversity a concept coined in the 1990s by sociologist Judy Singer, who herself has autism, that refers to differences in brain structure and function that lead to cognitive processing not typical of most individuals. It can present significant challenges involving emotion, empathy, inattention, and impulsivity. Today, up to 20% of the global population may classify themselves as neurodiverse, with up to 6.7% of adults having ADHD.

A neurodiverse brain has largely been viewed as a disability, the sort that may show up in workplace assessments for accommodations or job applications. One key criterion for the diagnosis of ADHD, however, is presence before age 12, according to the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders, or DSM-5. So what happens when the brain changes much later in life due to some kind of physical or psychological trauma? And what if that trauma is collective, as it was during the height of the Covid-19 pandemic? If a significant portion of the population has undergone changes in their brains due to a virus, how do

The researchers called it post Covid-19 ADHD-like syndrome, or PCAS, and even though the cause (Covid) was different, the symptoms and apparent response to treatment were similar enough to ADHD to warrant further examination.

Could the recently discovered serotonin depletion mechanism behind brain fog, as well as the virus targeting the frontal lobe, trigger PCAS or ADHD in those who never previously had concerns with focus, attention, and working memory? Could brain fog and acquired ADHD effectively be the same condition?

We know that more people in the U.S. have been diagnosed with ADHD than ever before: Diagnoses have spiked since 2020, even if it's unclear if these are new symptoms or simply symptoms unmasked by the pandemic. The US Centers for Disease Control and Prevention has reported that the number of adults and adolescents seeking a stimulant prescription increased from 3.8 to 4.1% between

Estimates in 2022 show that somewhere between 82 and 94% of people in the U.S. have had Covid-19 at least once. A 2022 meta-analysis found that between 22 and 32% of people who have had Covid-19 reported lingering problems with attention, memory, and brain fog. Similarly, a 2021 review noted that 22% of people experience cognitive impairment three or more months after infection.

The most recent US Census data paints a dire picture of the burden of brain fog. As such, research should be focused on if it is indeed reversible, perhaps with a short course of stimulant medications. Studies should also better tease out the causal factors from association. As I've written about before, the DSM-5 is severely limited by an arbitrary classification of symptoms. The Brazilian researchers have begun planning randomised controlled trials to help facilitate replicability and tailoring treatment for PCAS and acquired ADHD. It may also open the doors for non-traditional approaches to healing the brain, such as psychedelics. The National Academies continues to revise its definition of long Covid to consider neuropsychiatric symptoms, and the CDC shared with me in an email that they aim to submit the agency's findings on ADHD prevalence next year.

The idea of neurodivergence was conceived some 25 years ago to describe a minority. If, after the pandemic, a growing number of people find themselves with a newly neurodivergent brain via a form of acquired ADHD, perhaps that can also lead to improved workplace and personal support. Even if said neurodivergence ends up being reversible with medication, recognition of the disorder would bring much-needed understanding to neurodivergent individuals. (Cour-

oxidative stress and cell damage

• experiencing immune system prob-

· experiencing changes in lipid profiles

• having a higher risk of respiratory and other infections

· having a higher risk of cardiovascular disease, heart attack, and stroke All of these risks can worsen the symptoms and complications of diabetes. People who have diabetes are more susceptible to infections, and in-

fections can quickly become serious. In addition, both smoking and diabetes can lead to poor circulation. They also increase the risk of foot ulceration, oral health problems, respiratory infections, and other infections that

can have severe and possibly life-

threatening consequences. Research from 2008 suggests that smoking heavily may raise the risk of glucose intolerance and the accumulation of abdominal fat, both of which are risk factors for diabetes.

A 2016 study concluded that there may not be a direct link between smoking and insulin resistance. The researchers suggested that other factors may play a role, and they called for fur-

Nevertheless, both smoking and diabetes can worsen a person's health. Quitting or avoiding smoking is better for everyone, whether they have diabetes or not.

Additional risks

Lowering the risk

There is no safe way to smoke, particularly with diabetes. The best way to lower the risk from smoking is to quit or cut down dramatically.

The following strategies may lower the risks associated with smoking and diabetes:

Lead an active lifestyle: Exercise may lower the risk of lung cancer in people who smoke. It also supports glucose metabolism and can reduce the chance of obesity, which is another risk factor for diabetes

Eat healthfully: Eating a diet rich in fresh fruits, vegetables, and whole grains and low in fat, salts, sugar, and other processed or simple carbohydrates can lower the risk of cardiovascular disease. Fiber is especially important for people with diabetes, as it helps lower blood sugar.

Follow the treatment plan: People with hard-to-control diabetes are more likely to experience complications. Smoking compounds these risks. Taking appropriate medications and following a doctor's instructions can reduce these risks.

Cut back or quit smoking: There is no safe number of cigarettes to smoke, and all smoking and exposure to smoke is a health hazard. However, people who smoke heavily are more likely to experience extensive health problems.

A doctor can help a person start a plan to quit smoking. People with diabetes who smoke should consult a doctor before making any significant lifestyle changes.

Quitting smoking

For people who smoke and have diabetes, doctors recommend quitting smoking or dramatically cutting down.

Smoking is an addictive behaviour. Quitting is difficult, but doing so can significantly reduce the risk of shortand long-term complications that relate to smoking, diabetes, and the two com-

Before quitting, people who smoke and have diabetes should ask their doctor about the best course of action. A healthcare professional may have advice for overcoming the following chal-

Risk of overeating: People who smoke and have diabetes may need to adjust their diets. Smoking suppresses the appetite, and quitting can trigger the urge to overeat. This can lead to weight gain, another risk factor for diabetes and its complications

Blood sugar levels: A 2015 study found that people with diabetes who quit smoking might struggle to manage their blood sugar levels for the first 3 years after quitting.

9 tips for quitting

Some strategies that can help people quit smoking include:

1. Try to quit in one go

Some people plan to quit smoking gradually, but this can prolong the stress of quitting, because each reduction may trigger new withdrawal symptoms.

2. Don't give up

Many people attempt to quit several times before they are successful. Each attempt helps people learn what works for them. An unsuccessful attempt is not a failure, just one step on the way to quitting successfully.

3. Recognize the addiction

People who experience withdrawal may worry that the cravings and discomfort will never go away. Some people may feel that they have lost their only source of pleasure. However, these negative feelings stem from the addiction, which can distort a person's way of thinking

4. Finding a new, more healthful

Smoking is a behavioral and chemical addiction. Breaking the association between smoking and certain activities can be helpful. For example, if a person always starts their day with a cigarette, they could instead start with a short walk around the block

5. Ask about nicotine replacement therapy (NRT)

NRT does not work for all people

should consult a doctor before trying it. 6. Counseling Counseling and psychotherapy can

help people understand why they smoke and why they think smoking helps them cope. They also provide support for the emotional challenges of

7. Medication

Quit assistance medication can help some people who want to break the habit, such as varenicline (Chantix). These drugs can reduce cravings, and some also help with the emotional side effects of quitting. People who smoke should talk to a doctor about whether these drugs are safe to use alongside their diabetes medications.

8. Vaping

The long-term health impacts of using electronic cigarettes are unclear, and doctors advise that people who do not smoke do not start using them.

Evidence suggests, however, that "vaping" may be less harmful than smoking tobacco directly, and some doctors recommend it as a way to reduce the risks of smoking for those who find it hard to quit. 9. Convince others to join you

If another household member

smokes, talk to them about quitting together. This way, people can encourage each other.

If the other person continues to smoke, the one who is quitting still faces exposure to smoke. Secondhand smoke can make it harder to stay tobacco-free, and it will continue to pose a health risk.

People who do not smoke but share accommodation with people who do should talk to them about quitting, for the health of both people in the house-

147 BGB platoons deployed across Bangladesh as BNP calls 12-hr blockade Hasina's Awami League is likely to gain an upper hand and likely to form the government for the fourth consecutive term

DHAKA, Dec 24: A total of 147 platoons of Border Guard Bangladesh were deployed across the country on Sunday to maintain law and order ahead of the January 7 elections as a 12-hour road, rail and waterways blockade called by the opposition BNP and its allies demanding the resignation of Sheikh Hasina-led government is underway.

Bangladesh Nationalist Party (BNP) and its mostly far-right allies allege that no election under the incumbent dispensation would be fair and demand the restoration of a non-party interim government for election oversight by amending the country's Constitution.

The blockade began at 6 am and will end at 6 pm, the Dhaka Tribune newspaper reported.

Of the 147 platoons deployed across the country, 16 teams are patrolling in Dhaka and adjoining districts, Shariful Islam, public relations officer at Border Guard Bangladesh (BGB), was quoted as saying by the newspaper.

This is the 12th such blockade called by the opposition parties since October 31, and the first since the announcement of BNP's non-cooperation movement against the government on December 20 during which the party urged people not to pay taxes and utility bills as part of



In the national capital, the BNP and its affiliate parties held separate protest rallies in support of the ongoing blockade and non-cooperation movement.

Chanting anti-government slogans, the protesters demanded elections under a non-partisan caretaker government and the release of all detained opposition leaders and activists, including BNP's ailing chairperson and former prime minister Khaleda Zia.

Zia, 79, who was convicted and jailed

on two graft charges with a 17-year jail term, is now in a hospital with multiple

Besides BNP, the other parties which participated in the protest rallies include Swechchhasebak Dal, Jubo Dal and Chhatra Dal

Some 10-12 BNP supporters protesting on the Dhaka-Aricha highway were also arrested.

The BNP is boycotting the election after its demand for an interim nonparty neutral government to organise the

voting was rejected by the government. The party had boycotted the 2014 election but took part in 2018 polls.

With the BNP boycotting the election, and no other credible opposition party against it, Hasina's Awami League is likely to gain an upper hand and likely to form the government for the fourth consecutive term.

Since October 29, the BNP has been holding intermittent nationwide strikes and transport blockades to press for their demand for elections under a neutral government, which the ruling party reected saying the poll would be held in line with the existing Constitution.

The US and other major Western countries called for dialogue between the ruling Awami League and particularly with the BNP to ensure an inclusive and credible election, which, however, saw no headway due to reluctance from both sides.

According to a media tally, 11 people died and 376 vehicles were torched in the past two months in political violence. Police arrested thousands of opposition activists and figures, including de-facto BNP leader and party secretary general Mirza Fakhrul Islam Alamgir, over charges

Pak elections: Candidates rush to file nomination papers as deadline looms

ISLAMABAD, Dec 24: Candidates aspiring to contest the February 8 general elections in Pakistan are rushing to submit their nomination papers, as the deadline to file their candidature is set to expire on Sunday. The nomination process started on December 20 and was initially set to be completed on Friday but the Election Commission of Pakistan (ECP) extended it for two days on the demand of various political parties.

The National Assembly's 266 general and 70 reserved seats and over 600 seats of four provincial assemblies are up for grabs.

Several political leaders including PML-N's Tariq Fazal Chaudhary, former Islamabad mayor Pir Adil Gillani, Sheikh Ansar Aziz, federal capital's ex-deputy mayors Zeeshan Naqvi and Chaudhry Riffat Javed among others submitted their nomination papers on Sunday.

Already many leading politicians, including incarcerated former premier Imran Khan, former three-time premier Nawaz Sharif, former president Asif Ali Zardari, former prime ministers Yusuf Raza Gilani, Raja Pervaiz Ashraf and Shehbaz Sharif and many other influential leaders have filed their documents.

Khan has so far filed papers from two constituencies in Lahore and his ancestral town of Mianwali. But his chances of getting a green signal to contest the election are slim due to his conviction in the Toshakhana corruption case for illegally

In a setback, the Islamabad High Court

(IHC) during the week rejected his plea for suspending his conviction in the case.

Major parties in the election are the Pakistan Muslim League-Nawaz (PML-N), Pakistan Peoples Party (PPP), Muttahida Qaumi Movement-Pakistan (MQM-P), Jamiat Ulema-e-Islam-Fazl (JUI-F), Pakistan Tehreek-e-Insaf (PTI), Jamaat-e-Islami (JI) and others local parties are in the field. However, the fate of Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party is yet not clear as the Election Commission of Pakistan (ECP) rejected its intra-party elections and refused to let it use the bat as the party symbol

The party has announced that it will challenge it in the Supreme Court. Without a unifying symbol, it would be difficult for its candidates to contest.

Once the deadline for filing nomination papers ends, the ECP is set to conduct their scrutiny from Monday through December 30, as per the commission's updated schedule. Appeals against the acceptance or rejection of nomination papers can be submitted until January 3, with decisions expected by January 10.

The ECP is set to release the updated list of candidates on January 11, and candidates can withdraw their papers till January 12. The allocation of electoral symbols will take place on January 13.

The foreign observers can submit applications to monitor the elections from December 31 to January 20, according to the

Indian-flagged oil tanker hit by Houthi attack drone in Řed Sea: US military

NEW YORK, Dec 24: An Indian-flagged crude oil tanker is among two vessels that came under drone attacks by Yemen's Houthi rebels in the Southern Red Sea, the US Central Command has said.

The US Central Command said in a statement that on December 23, two Houthi anti-ship ballistic missiles were fired into international shipping lanes in the Southern Red Sea from Houthi-controlled areas

No ships reported being impacted by the ballistic missiles.

Between 3 and 8 pm (Sanaa time), the USS LA-BOON (DDG 58) was patrolling in the Southern Red Sea as part of Operation Prosperity Guardian (OPG) and shot down four unmanned aerial drones originating from Houthi-controlled areas in Yemen that were inbound to the USS LABOON. There were no injuries or damage in this incident.

At approximately 8 pm (Sanaa time), US Naval Forces Central Command received reports from two ships in the Southern Red Sea that they were under

The M/V BLAAMANEN, a Norwegian-flagged, owned, and operated chemical/oil tanker, reported a near miss of a Houthi one-way attack drone with no injuries or damage reported.

A second vessel, the M/V SAIBABA, a Gabonowned, Indian-flagged crude oil tanker, reported that it was hit by a one-way attack drone with no injuries

The USS LABOON (DDG 58) responded to the distress calls from these attacks.

The US Central Command said these attacks represent the 14th and 15th attacks on commercial shipping by Houthi militants since October 17.

Iran-backed Houthi rebels stepped up attacks on ships in the Red Sea amid the Israel-Hamas conflict.

Pak SC returns appeal against conviction of former PM Imran Khan



ISLAMABAD, Dec 24: Pakistan's Supreme Court office has returned an appeal seeking to set aside the three-year conviction of former prime minister Imran Khan in the Toshakhana corruption case, according to a media report on Sunday

The registrar's office on Saturday returned the appeal moved by 71-year-old Khan through his counsel Latif Khosa under Article 185 of the Constitution, challenging December 11, 2023, Islamabad High Court (IHC) decision of rejecting a similar plea for lacking requirements, including the absence of actual controversies or chronology of the past litigation. The petition was filed with a plea to overturn the August 5 conviction of Khan by an additional sessions judge of the IHC for illegally selling state gifts, Dawn News reported.

The Toshakhana case is based on the allegations that the the former premier violated the Toshakhana or state repository rules.

All gifts given by foreign leaders to Pakistani top leaders on their trips are kept in the Toshakhana.

The registrar's office, however, returned the appeal with observations that the same was suffering from several deficiencies, like the concise statement. In addition to the existing requirements, the petition should contain actual controversy or chronology of the litigation as well as the findings recorded by the forums below.

Moreover, the petition should contain questions

requiring consideration and decision by the Supreme Court, relevant facts, events and documents in the case showing a breach of legal rights/entitlement to relief.

Likewise, the concise statement in the petition should be signed by an advocate of the Supreme Court. Besides, the petitioner has not informed the respondents by issuing notices to them about the filing of the petition.

Consequently, the court office returned the petition to the petitioner lawyers in original for removal of the deficiencies within a fortnight by January 6, 2024. The petition argued that the petitioner had moved an application for the suspension of the three-year sentence with the main appeal which came up for hearing before the IHC on Au-

During the arguments, a request was made to the high court to suspend the operation of the sentence. The sentence was challenged by the petitioner, the petition claimed, since it suffered from juris-

On August 8, the Election Commission of Pakistan (ECP) issued a notification to disqualify the appellant under Article 62(1)(f) of the Constitution, without even giving the petition an opportunity of being heard. Under the recent amendments to the Elections Act 2017, the period of disqualification under Article 62(1)(f) of the Constitution has been reduced to five years from the earlier life term.

The petition pleaded that the ECP notification was never communicated to the petitioner who at that time was behind bars. The petition argued that attempts were being made to take away the symbol of the Pakistan Tehreek-e-Insaf (PTI) as well and throw it out of the election arena, according to Dawn. The cricketer-turned-politician was convicted on August 5 and arrested but the Islamabad High Court granted him bail. However, he has not been released due to his arrest in some other cases. (PTI)

Strong earthquake in northwest China that killed at least 148 causes economic losses worth millions



BEIJING, Dec 24: The strong earthquake that hit northwest China this week, killing at least 148 people, caused economic losses estimated to be worth tens of millions in the agricultural and fisheries industries, state media said Satur-

Officials in Gansu conducted preliminary assessments that showed the province's agricultural and fisheries industries have lost 532 million yuan (about USD 74.6 million), state broadcaster CCTV reported.

Authorities were considering the best use of the relief fund, set up days before, for the agricultural sector to resume production as soon as possible, the report said.

The magnitude 6.2 quake struck in a mountainous region Monday night between Gansu and Qinghai provinces and about 1,300 kilometers (800 miles) southwest of Beijing, the Chinese capital. CCTV said 117 people were killed in Gansu and 31 others died in neighboring Qinghai, while three people remained missing. Nearly 1,000 were injured and more than 14,000 homes were destroyed.

During a visit Saturday to several villages in Gansu and a county in Qinghai, Chinese Premier Li Qiang urged authorities to improve living conditions for the survivors of the quake by every available method, the official Xinhua News Agency reported.

Li said the top priority of relief efforts was to make sure people stay warm and safe in winter, the report added.

CGTN, the Chinese state broadcaster's international arm, said the first batch of 500 temporary housing units had been built for residents in Meipo, a village in Gansu, on Friday night.

Many had spent the night in shelters set up in the area as temperatures plunged well below freezing. Funerals were held, some following the Muslim traditions of much of the population in the affected area.

Most of China's earthquakes strike in the western part of the country, including Gansu, Qinghai, Sichuan and Yunnan provinces, as well as the Xinjiang region and Tibet. The latest quake was the deadliest one in the country in nine years. (AP)

Chinese Premier visits quake-affected areas; ensures safety of distressed people

BEIJING, Dec 24: Chinese Premier Li Qing has asked the rescue and relief teams to make sure that people in the quake-hit areas live through the winter safely as he visited the affected villages in northwest China.

Li visited several villages in Jishishan County of Gansu province as well as Minhe County in the neighbouring Qinghai province on Saturday.

The region was struck by a 6.2magnitude earthquake at midnight Monday, leaving 148 people dead and 781 injured besides toppling many buildings.

During the visit, Li talked with

people affected by the disaster and learned about the work related to resettlement, relief supplies, and the construction of temporary dwellings. He said the top priority of current relief workers was to ensure the affected people stay warm and

news agency reported. Li urged relief workers to race against time to send relief supplies and daily necessities to the victims in the settlements and build temporary houses as fast as possible for

those living in tents. If needed, buildings in the quakehit areas should be checked and reinforced so that residents can move back and essential facilities such as schools and hospitals can be re-

opened, Li said. Reconstruction should be planned in a coordinated manner to help local people improve their living conditions to prevent them from falling into poverty due to the disaster, he said. He instructed authorities to provide the best possible medical treatment for those injured in the quake. (AP)

Iran Summons Russian envoy over statement on Persian Gulf disputed islands

DUBAI, Dec 24: Iran summoned Russia's charge d'affaires after Moscow and Arab countries released a joint statement earlier this week challenging Iran's claim to disputed islands in the Persian Gulf, state media reported on Sunday.

Iran's official IRNA news agency said the Russian envoy was summoned on Saturday and handed a note to deliver to Moscow in which Tehran protested the statement the 6th Arab-Russian Cooperation Forum issued in Morocco that called for a peaceful solution to resolve the conflict between Iran and the United Arab Emirates over the islands. Earlier on Saturday, Iran's foreign minister Hossein Amirabdollahian told his Russian counterpart over the phone that "respecting countries" sovereignty and integrity is among basic principles in the ties between nations", IRNA said in a separate report

This marked the second time this year that Iran has called for a Russian envoy in protest over comments on the disputed islands. Tehran summoned the Russian ambassador in July over a similar statement

The diplomatic spat is a rare occurrence between the two countries that have deepened their ties since Moscow invaded Ukraine, with Iran supplying Russia with killer drones that have been used to devastating effect there. Both countries have also been strong backers of President Bashar Assad in Syria's civil war. In 2022, Iran summoned China's envoy over a

similar joint statement with Arab nations.

Iran took control of the three islands of Abu Musa, the Greater Tunb and the Lesser Tunb after British forces withdrew in 1971. It considers them an "inseparable" part of its territory. The UAE also claims the three islands and has long pressed for a negotiated solution.

The three islands dominate the approach to the strategic Strait of Hormuz, a key waterway through which about one-fifth of the world's oil supply passes.

Iran says the islands have been part of Persian states from antiquity up until they were occupied by the British in the early 20th century. It also says an agreement reached with Sharjah, one of the UAE's seven emirates, gives it the right to administer Abu Musa and station troops there. (AP)

US lawmakers strongly condemn vandalism of Hindu temple in California

NEW YORK, Dec 24: Several US lawmakers, including three prominent Indian-American Congressmen, have strongly condemned the vandalism of a Hindu temple in California and asserted that those responsible for the act must be held accountable. The Shri Swaminarayan Mandir Hindu Temple in Newark, California was vandalised with anti-India graffiti and the police are investigating the matter as a possible hate crime.

Congressman Ro Khanna, who represents California's 17th Congressional District located in Silicon Valley, said in a post on X that he strongly condemns the "defacing" of the Swaminarayan temple in Newark, California which is in his district. "Freedom to worship is at the heart of American democracy. Those who committed this act of vandalism must be held accountable," Khanna said. He said he is heartened that the community is coming together to stand up against hate and remove the graffiti. "This community action is answering wickedness with goodness," he said. Congressman Raja Krishnamoorthi termed the defacing of the Swaminarayan temple as "despicable" and said he strongly condemns it. (AP)

On Christmas Eve, Bethlehem resembles a ghost town; celebrations are halted due to Israel-Hamas war

BETHLEHEM (WEST BANK), Dec 24: The normally bustling biblical birthplace of Jesus resembled a ghost town on Sunday, as Christmas Eve celebrations in Bethlehem were called off due to the Israel-Hamas

The festive lights and Christmas tree that normally decorate Manger Square were missing, as were the throngs of foreign tourists and jubilant youth marching bands that gather in the West Bank town each year to mark the holiday. Dozens of Palestinian security forces patrolled the empty square.

"This year, without the Christmas tree and without lights, there's just darkness," said Brother John Vinh, a Franciscan monk from Vietnam who has lived in Jerusalem for six

He said he always comes to Bethlehem to mark Christmas, but this year was especially sobering, as he gazed at a nativity scene in Manger Square with a baby Jesus wrapped

in a white shroud, reminiscent of the thousands of children killed in the fighting in Gaza. Barbed wire surrounded the scene, the grey rubble reflecting none of the joyous lights and bursts of colour that normally fill the square during the Christmas The cancellation of Christmas

festivities is a severe blow to the town's economy. Tourism accounts for an estimated 70% of Bethlehem's income — almost all of that during the Christmas season.

With many major airlines cancelling flights to Israel, few foreigners are visiting. Local officials say over 70 hotels in Bethlehem have been forced to close, leaving thousands of people unemployed.

Gift shops were slow to open on Christmas Eve, although a few did once the rain had stopped pouring down. There were few visitors, however.

"We can't justify putting out a tree and celebrating as normal,



when some people (in Gaza) don't even have houses to go to," said Ala'a Salameh, one of the owners of Afteem Restaurant, a family-owned falafel restaurant just steps from the

square. Salameh said Christmas Eve is usually the busiest day of the year. "Normally, you can't find a single chair to sit, we're full from morning till midnight," said Salameh. This year, just one table was taken, by journalists taking a break from the

Under a banner that read "Bethlehem's Christmas bells ring for a cease-fire in Gaza," a few teenagers offered small inflatable Santas, but no one was buying. Instead of their traditional musical march through the streets of Bethlehem, young scouts stood silently with flags. A group of local students unfurled a massive Palestinian flag as they

"Our message every year on Christmas is one of peace and love. but this year it's a message of sadness, grief and anger in front of the international community with what is happening and going on in the Gaza Strip," Bethlehem's mayor, Hana Haniyeh, said in an address to the crowd.

Over 20,000 Palestinians have been killed and more than 50,000 wounded during Israel's air and ground offensive against Gaza's Hamas rulers, according to health officials there, while some 85% of the territory's 2.3 million residents

have been displaced. The war was triggered by Hamas' deadly assault Oct 7 on southern Israel in which militants killed about 1,200 people, most of them civilians, and took more than 240 hostages. The Gaza war has been accompanied by a surge in violence, with some 300 Palestinians killed by Israeli fire.

The fighting has affected life across the West Bank. Since Oct 7, access to Bethlehem and other Palestinian towns in the Israeli-occupied territory has been difficult, with long lines of motorists waiting to pass military checkpoints. The restrictions have also prevented tens of thousands of Palestinians from exiting the territory to work in Is-

Amir Michael Giacaman opened his store, "Il Bambino," which sells olive wood carvings and other souvenirs, for the first time since Oct 7. There have been no tourists, and few local residents have money to spare because those who worked in Israel have been stuck at home.

"When people have extra money, they go buy food," said his wife, Safa Giacaman. "This year, we're telling the Christmas story. We're celebrating Jesus, not the tree, not Santa Claus," she said, as their daughter Makaella ran around the deserted store. (AP)

MST buses initiate operations braving roadblocks in Kuki areas

GUWAHATI, Dec 24: Tight security arrangements made by the State government for resumption of Manipur State Transport's bus service on Imphal-Senapati-Mao and Imphal-Churachandpur routes could not yield the desired result as the buses have to turn around before reaching their des-

MST's Imphal-Senapati bus departed Imphal (North AOC) together with private passenger buses plying on Imphal-Dimapur-Guwahati route at around 10.30 am.

The MST's Imphal-Churachandpur bus was flagged off from near Malom oil depot.

There were just four/five non-Meitei passengers on board the MST's Imphal-Senapati bus but there was not a single passenger on the Imphal-Churachandpur bus.

On receiving information about Kuki volunteers blocking the highways at several points, the Imphal-Senapati bus took a U-turn from Gamgiphai near Kang-latongbi and the Imphal-Churachandpur bus turned back towards Imphal from Phougakchao Ikhai.

Nonetheless, the other private passenger buses went past Kangpokpi to their respective destinations like Senapati, Mao, Kohima, Dimapur and Guwahati

MST's Imphal-Senapati bus was escorted by a police team led by Lamphel police station SDPO N Ingocha till Kanglatongbi Shantipur while the Imphal-Chura-chandpur bus was escorted by another police team led by Bishnupur SP K Meghachandra. The State government's home department

arrangements Kangpoki/Senapati district police and Central paramilitary forces to escort the Imphal-Senpati bus from Kanglatongbi Shantipur till Senapati and Mao. As there is no Kuki village between Senapati and Mao, the security arrangement was relaxed in this section of the highway but tight security measures were put in place from

Imphal to Kangpokpi. Notwithstanding the tight security measures, not a single Meitei passenger was on board the MST's Imphal-Senapati bus as well as the private passenger buses heading to Dimapur and Guwahati

Meiteis have been staying away from Imphal-Mao highway since the violent conflict erupted on May 3. 2023. Two Meitei teenagers who mistakenly crossed Kanglatongbi bridge toward Gamgiphai on November 5 could not be traced till date. The bus passengers who travelled from Imphal toward Senapati today with security escorts were Nagas, Nepalese, Meitei Pangals

and non-Manipuris. After the passenger bus service was suspended for a long time following the violent conflict which erupted on May 3, some private transporters resumed Imphal-Dimapur-Guwahati bus service with

blocking the highway at Kangvai. After passenger transport service was suspended on Imphal-Senapati-Dimapur highway for a long time, a limited number of buses and wingers resumed transportation of passengers on the highway in November.

All the passengers travelling on these limited number of buses and wingers are Nagas, Meitei Pangals and non-Manipuris. Moreover, these limited number of passengers vehicles which have been put into service are owned by either Nagas or Meitei Pangals or non-Manipuris. The drivers of these vehicles are also either Nagas or Meitei Pangals or non-Ma-

Kukis have not been allowing vehicles owned by Meiteis to operate on the highway. Armed Kukis have been checking the documents of all vehicles plying on the highway at three/four points apart from verifying the Aadhaar cards and other identification documents of the passengers.

All Manipur Inter-State Bus and Allied Transport Association, Imphal president Hanjabam Tarunkumar said that private passenger buses resumed operation on Imphal-Senapati-Dimapur highway since November

But no Meitei has travelled on the highway since the passenger services resumed, he said.

All the passengers travelling on the highway are being checked and verified by armed Kukis and Kuki volunteers at Motbung, Saparmeina, Kalapahar and Kangpokpi. The armed Kukis have also been openly engaging in extortion from the vehicles plying on the highway, he said.

He remarked that the Government's initiative to resume passenger bus services on Imphal-Dimapur highway by deploying additional security forces is a positive step. Tarunkumar urged the Government to ensure that the vehicles and passengers moving on the highway are not subjected to any undue harassment.

With all the buses and other passenger vehicles owned by Meiteis not allowed to ply on the highways, specially Imphal-Dimapur highway, their source of livelihood has been severely jeopardised. There inter-State buses. Now, most of the inter-State buses are owned by non-

Earlier, there were around 25 ticket counters of inter-State bus service at North AOC but 18 of them have been shut down, Tarunkumar said. Notably, the ITLF and CoTU demanded the State Government to withdraw its order of resuming passenger bus services on Imphal-Senapati and Imphal-Churchandpur routes. The Kuki bodies also warned that the Government should be held responsible for any untoward incident if the Government went ahead with its order. (PTI)

China's denial of visa to Wushu players rock Arunachal in 2023

service of 256 government employees for producing forged documents, China's decision to deny visa to wushu players from Arunachal Pradesh for the Asian Games and protests against the state public service commission exam paper leak took centre stage in the frontier state in the year 2023.

The abduction of village officials and construction workers by militants, killing of a former MLA and anomalies over the recruitment of junior engineers found a place in the headlines in the northeastern state during the

India strongly protested China's decision to deny visa to three women athletes from Arunachal Pradesh for the Asian Games with Union sports minister Anurag Thakur cancelling his visit to Hangzhou where the event took place.

Women players Nyeman Wangsu, Onilu Tega and Mepung Lamgu were denied accreditation, which also worked as visa for the games held in September-October this year.

Arunachal Pradesh chief minister Pema Khandu dubbed the denial of visa to the athletes from the state as "unfortunate".

"Beijing has acted against the established diplomatic norms and has shown utter disregard for the spirit of sports. People of Arunachal Pradesh, an integral part of Bharat, firmly stand by our players and vehemently oppose China's abominable decision," Khandu had written on X, formerly

The Pema Khandu government in the state terminated the services of 256 employees for producing "forged and fabricated" documents to authorities concerned without maintaining formalities of the Education de-



State education commissioner Amjad Tak had issued separate orders terminating these employees from services in various districts after an inquiry committee, constituted to analyse the alleged irregularities, found that their appointment letters had "never been issued from the directorate of elementary education"

Irregularities in the appointments of 66 junior engineers also surfaced in the state during the year.

The northeastern state was also in the news earlier this month after former MLA Yumsem Matey was shot dead by unknown gunmen near the Indo-Myanmar border in the Lazu circle of Tirap district.

Amid protests by the opposition Congress over the law and order situation in the state, the BJP government decided to transfer the murder case to the National Investigation Agency (NIA).

The Pan Arunachal Joint Steering Committee intensified its protests against the Arunachal Pradesh Public Service Commission's question paper leak.

Normal life in the state capital was affected in February as the committee called for a 48-hour 'public' bandh to press for the fulfilment of the 13-point charter of demands. The government had suspended internet services in the Itanagar capital region for three days after the protestors broke barricades, while police personnel batoncharged them and fired tear gas shells to disperse the mob.

The assistant engineer (civil) exam was conducted by the Arunachal Pradesh Public Service Commission (APPSC) in 2022.

The controversy over the question paper leak took an ugly turn when APPSC undersecretary and assistant controller of examinations Tumi Gangkak allegedly died by suicide, and Gyamar Padang, the whistleblower of the scam, breathed his last in May.

The border state also remained in head lines when the Changlang district adminisstaffers" in the education department as they were drawing salaries without any presence.

During the year, the kidnapping of persons by various factions of the outlawed NSCN for ransom emerged as a major challenge to the state administration.

Militants of Ang Mai faction of the NSCN-K abducted a village chief and a gaon bura (village headman) from Longding district in November and demanded a "house tax" of over ₹ 50,000 from them.

In another case, a junior engineer and a supervisor of a construction company were kidnapped last month by three armed militants of the outfit from a camp near the Tisa river in the district. However, both were released on November 28.

It was suspected that the motive behind the kidnapping was extortion, but it could not be confirmed whether any ransom was paid for their release.

During the year, the state also witnessed an extension of the Armed Forces Special Powers Act (AFSPA) for another six months in Tirap, Changlang and Longding districts. Additionally, areas falling within the jurisdiction of Namsai, Mahadevpur, and Chowkham police stations in Namsai district were designated as 'disturbed areas' under Section 3 of AFSPA, 1958.



The TDP following its alliance with actor Pawan Kalyan's Jana Sena Party is hopeful of a strong show against the YSR Congress but the state's ruling party has been electorally dominant in the last five years, riding on a slew of welfare schemes it has imple-

TDP sources claimed that Reddy's governance model and leadership style bear a lot of resemblance with those of BRS leader K Chandrashekar Rao. whose party lost power to the Congress in Telangana after its 10-year rule as charges of crony corruption and highhandedness stuck a chord with voters.

The TDP has repeatedly accused the YSR Congress of using strong-arm methods, including the case, to weaken it. Its leaders believe that an alliance with the BJP can prove to be an X factor as the national party is seen favourite to retain power at the Centre.

The BJP may not add much in terms of vote share but it brings in a positive national narrative which can be helpful. TDP sources said, claiming that such an alliance will also help it taken on the state government's might.

Though home minister Amit Shah had reportedly met Naidu in June and his son Nara Lokesh following his arrest but the BJP has been keen to ensure that it is not seen as taking any side and has maintained that it had taken no decision on an alliance in the

PATNA, Dec 24: Bihar deputy chief minister Tejashwi Yadav on Sunday condemned DMK MP Dayanidhi Maran's alleged remark that people from the Hindi heartland were cleaning toilets and doing other menial jobs in Tamil

Yadav said like his RJD, the DMK headed by Tamil Nadu chief minister MK Štalin was a party that believed in social justice and it was unbecoming of a leader of such a party to have made such a

"Had the DMK MP highlighted caste iniquities, had he pointed out that only people from some social groups took up such hazardous jobs, it would have made sense",


said the RJD leader. "But to speak disparagingly of the entire populace of Bihar and UP is reprehensible. We condemn it. We believe that people should be respectful towards those coming from other parts of the country", asserted Yadav.

"We look upon DMK as a party which shares our ideal of social justice. Its leaders should avoid saving things that run counter to the ideal", said Yaday, who is known to share personal equations

"Shouting normalcy or propagating tourist arrivals as peace will not finish terrorism which is still alive. They were claiming that terrorism has finished with the abrogation of Article 370 (in 2019) but four years down the line, terrorism is still there and will not finish till we try to understand its root cause," Abdullah said.

He was reacting to the killing of retired police officer Mohd Shafi who was shot dead by terrorists inside a mosque while de-



livering 'azan' (call for prayer) at his Gantmulla village in north Kashmir's Baramulla district.

"I regret the killing (of the officer). Those who are claiming normalcy are silent... they tried to heal the wounds in a superficial manner rather than addressing the root cause. The commoners should understand that we are losing our soldiers, officers and com-

moners," Abdullah said. The National Conference president said he fails to understand how the perpetrators of violence are going to benefit by killing innocent persons.

"The central government had to find ways in the right perspective to end bloodshed in Jammu and Kashmir. We are part of India, we were part of India and we will remain part of India and if we have to end terrorism, we have to look for ways rather than claiming normalcy or talking about tourism which is fragile under the shadow of terrorism," he

The use of military or police is not going to finish terrorism, he said. "We have to go deeper and address the root cause to finish it

Asked about growing terror activities in the twin border districts of Poonch and Rajouri, Abdullah said this contradicts the government's claims that everything is

'honkv-dorv' "Where are those shouting normalcy? Nothing is going to be achieved by propaganda as people are dying here. They have to find a solution and Farooq Abdullah does not have a book with a ready-made solu-

Asked whether he wants India and Pakistan to talk to address the problem, Abdullah said the central government has to decide on the subject.

In a separate interaction with mediapersons, Abdullah expressed concern over the alleged custodial death of three civilians in the aftermath of the killing of five soldiers in an a mbush in Surankote area of Poonch and said the war against terrorism cannot be won without the support of the people.

"Terrorists attacked and martyred our brave soldiers and later three locals were tortured to death. This is tragic as we are fighting against terrorism and not against our own people. If we annoy our people, we will never win this war," he said.

Abdullah said his party has already sought a judicial inquiry into the killing of the three civilians and "I would like to add that home minister (Amit Shah) should visit the area and assure the people that those involved will be handed down an exemplary punishment. The killing of the civilians is a sad incident and a human rights violation." (PTI)

Indigenously-built guided missile destroyer INS Imphal to be commissioned tomorrow

The naming of the ship after the capital city of Manipur underlines the importance of the Northeastern region

NEW DELHI, Dec 24: INS Imphal, the indigenously-built stealth guided missile destroyer equipped with BrahMos surface-to-surface missiles, will be commissioned into the Indian Navy on Tuesday in a boost to its maritime capability amid China's increasing forays into the Indian Ocean region.

It is the first warship to have been named after a city from the Northeastern region, the approval for which was accorded by the President in April 2019.

The warship will be commissioned at a ceremony in the naval dockyard in Mumbai in the presence of Defence Minister Rajnath Singh, officials said.

The naming of the ship after the capital city of Manipur underlines the importance of the Northeastern region for national security and prosperity, they said.

A guided missile destroyer with a displacement of 7,400 tonnes and overall length of 164 meters, Imphal is a potent and versatile platform equipped with state-of-the-art weapons and sensors, including surface-to-air missiles, anti-ship missiles and torpedoes.

Powered by Combined Gas and Gas (COGAG) propulsion, the ship is capable of achieving speeds in excess of 30 knots (56 km/hour).

The ship boasts of a high indigenous content of approximately 75 per cent that includes BrahMos surface-to-surface missiles, medium range surface-to-air missiles, anti-submarine indigenous



rocket launchers and 76mm super rapid gun mount.

INS Imphal was delivered to the Indian Navy on October 20 after completion of a rigorous and comprehensive trial programme both in the harbour and at sea.

Subsequently, the ship successfully test-fired the extended-range supersonic BrahMos missile last month, a first for any indigenous warship before commissioning.

Following this milestone, the ship's crest was unveiled by Defence Minister Singh in New Delhi in the presence of the chief minister of Manipur.

"The ship Imphal will have the unique distinction of being the largest and the most advanced destroyer to be ever named after a city from the Northeast. This is a befitting tribute to Manipur's sacrifices and contributions in India's freedom struggle -- be it the Anglo-Manipur War of 1891; or Netaji Subash Chandra Bose's hoisting of the INA flag for the first time on April 14, 1944 at Moirang," it said.

Delhi Metro completes 21 years of operations

NEW DELHI, Dec 24: Delhi Metro, which began operations with a small 8.4-km line in December 2002, on Sunday completed 21 years of journey dotted with several milestones.

On this very day in 2002, the then Prime Minister Atal Bihari Vajpayee had inaugurated the first stretch of the Delhi Metro from Shahdara to Tis Hazari on the Red Line. Passengers services began a day later on Christman

"From an inaugural network length of just 8.4 kilometres with six stations in 2002, the Delhi Metro stands tall today with a network of 393 km and 288 stations. More than six million passenger journeys are being performed every single day on the Delhi Metro making it one of the largest mass transit systems in the entire world," it said.

In the last 21 years, more than 380 km of additional lines have been laid in the NCR, which is a "staggering feat" and probably, the biggest infrastructure marvel created in the country, the DMRC said.

juries on their legs," Deka said. The SP said the three youths are currently undergoing treatment at the AMCH in Dibrugarh. Asked about any details on the meeting the youths reportedly attended in Dhola, Deka said further information can be known once the trio is interrogated after recovery. (PTI)

Further, from one of the five studies that assessed the impact of quality of search results on believing or disbelieving misinformation, the researchers found that online users exposed to "low-quality" search results were more likely to believe the falsehoods.

"This points to the danger that 'data voids' - areas of the information ecosystem that are dominated by low quality, or even outright false, news and information - may be playing a consequential role in the online search process, leading to low return of credible information or, more alarming, the appearance of non-credible information at the top of search results," said lead author Kevin Aslett, an assistant professor at the University of Central Florida. Both the SOG jawans are out of danger, he

said, adding that one jawan, who got an injury in his eye, is being shifted to AIIMS Bhubaneswar after preliminary treatment at Balikud hospital.

Another jawan got injuries on his hand and


he has been shifted to Kandhamal district headquarters hospital, Phulbani after first aid, the SP said.

As Covid-19 cases rise, WHO asks countries to strengthen surveillance

"The Covid-19 virus continues to evolve, change, and circulate in all countries globally. While current evidence suggests the additional public health risk posed by JN.1 is low, we must continue to track the evolution of these viruses to tailor our response.

"For this, countries must strengthen surveillance and sequencing, and ensure sharing of data," said Dr Poonam Khetrapal Singh, regional director, WHO South-East

WHO has classified JN.1 as a variant of interest following its rapid global spread. In recent weeks, JN.1 was reported in multiple countries, and its prevalence has been rapidly increasing globally.

Considering the limited available evidence, the additional public health risk posed by JN.1 is currently evaluated as low at the global level. Singh said.

It is anticipated that this variant may cause an increase in Covid-19 cases amid surge



of infections of other viral and bacterial infections, especially in countries entering

In May, following sustained decline in the trajectory of Covid-19 cases,

the winter season.

"As people travel and gather for festivities during the holiday season, spending a lot of time together indoors where poor ventilation facilitates transmission of viruses that cause respiratory diseases, they must take protective measures and seek timely clinical care when unwell,"

said Dr Khetrapal Singh.

The regional director also emphasised on the importance of vaccination against Covid-19 and influenza, especially for people at high

"All WHO-approved Covid-19 vaccines continue to protect against severe diseases and deaths from all variants including JN.1," she

In May, following sustained decline in the trajectory of Covid-19 cases, hospitalisations and deaths, and high levels of population immunity to SARS-CoV2, WHO declared that COVID-19 no longer constituted a public health emergency of international concern.

While considerable progress has been made in establishing and strengthening a global system to detect and rapidly assess risks posed by SARS-CoV2, testing and reporting of Covid-19 cases has decreased.

With Covid-19 continuing to circulate at high levels globally, countries must strengthen surveillance, sequencing, and reporting to effectively manage respiratory diseases and to protect people's health, the regional di-

rector said. (PTI)

Laura Lynch, a co-founder of the Dixie Chicks, dies at 65

LOS ANGELES, Dec 24:

Laura Lynch, a founding member of the country music group the Dixie Chicks, died in a car crash on Friday, according to the authorities. She was 65. The death and Lynch's identity were confirmed by Nikol Endres, a justice of the peace in the area.

Lynch, of Fort Worth, was driving east on Route 62 near Cornudas, Texas, about 70 miles east of El Paso, when a pickup truck that had been heading west crossed into her lane and struck her pickup truck head on, the Texas Department of Public Safety said. She was pronounced dead at the scene. After being raised on her grandfather's ranch in Texas, Lynch, a bassist, founded the Dixie Chicks, now known as the Chicks, in Dallas in 1988 with Robin Lynn Macy, and sisters Emily

The original lineup only had two albums together: the debut "Thank Heavens for Dale Evans" in 1990 and "Little Ol' Cowgirl" in 1992.

Strayer and Martie Maguire.

In an interview with National Public Radio that aired in 1992, Lynch referred to the band's music as "cowgirl music." "Our brand of cowgirl music is a mixture of old-time country music, bluegrass music, acoustic," she said. "We all sing three-part and four-part harmony. We throw in some instrumentals, some country swing. That's our

brand of cowgirl music. Macy left the band in 1992. The next year, the remaining trio released "Shouldn't A Told You That," and began to experience moderate success. In 1993, the band played at an inaugural ball for President Bill Clinton. (AGENCIES)



NDIA RECORD MAID EST WIN OVER AUSTR

MUMBAI, Dec 24: It was a befitting end to India Women's first 'home season' of Test cricket in 28 years as they recorded a historic maiden victory over a venerable Australia in the one-off Test here

On the final day, India produced their best both with the ball and bat to thwart a spirited Australian resurgence, first sparking a collapse in the visitors' ranks to snaffle the remaining five wickets for 28 and then knocking off a meagre target of 75 without much ado to script an eight-wicket win.

Smriti Mandhana (38 not out) and Jemimah Rodrigues (12 not out) embraced each other in a warm hug when the objective of beating a world-dominating side was accomplished, bringing back memories of India's shushed reaction in 2008 in Australia when MS Dhoni's side beat the hosts and made a statement by not indulging in any passionate celebrations. Playing more than one Test at home for the first time since 1995, there was hardly a moment

when the team put a foot wrong. India Women's stuck to the promise of playing 'positive cricket', weathered all mini storms along the way and largely dictated terms against fancied opponents in Australia and England.

in Team India's clinical perform ance in the two home Tests played on different surfaces here at the Wankhede Stadium and at the DY Patil Stadium against England, considering they were playing at home for the first time in almost a decade. While India scripted the biggest win for any team by margin of runs against England, their first-ever triumph over Australia in 11 Tests now has ensured more entries in the column of 'matches won' compared to 'matches lost'.

In 40 Tests, India now have seven wins and six defeats, while 27 have been drawn.

India's dominating show warrants the attention of the game's custodians to ruminate over more 'home' Tests in future since such games have only been few and far between. If the win over England last week saw the emergence of new Test stars in Jemimah Rodrigues, Shubha Satheesh and Renuka Singh Thakur, the one against Australia witnessed the 20-year-old Richa Ghosh arriving at the scene with 52 on debut.

On the fourth day morning, Indian spinners ruled the roost as the trio of Sneh Rana (5-2-9-2), Rajeshwari Gayakwad (1.4-1-0-2) and Deepti Sharma (3-2-5-0) teamed up to wreck havoc on the Australian resistance.

Australia, looking to build on



their slender lead of 46 runs, collapsed spectacularly to lose five wickets in the first 45 minutes of the day and concede the game to India. Pooja Vastrakar began the damage by trapping Ashleigh Gardner for seven in front of the wickets, and Rana tiled the game in India's favour when she struck twice to remove Annabel Sutherland (27) and Alana King (0).

Rajeshwari Gayakwad, who was unlucky to have not got any success on the third day when she got a breakthrough nearly thrice, cleaned up Kim Garth (4) for her first wicket in the innings.

Gayakwad then bamboozled Jess Jonassen (9) with a delivery that turned into the left-hander sharply and crashed into middle

Australian batter nearly toppling over on her front foot.

Australia were bundled out for 261 in their second innings, having scored a moderate 219 in their first essay after electing to bat.

India were supreme with the bat again as they made 406 in the first essay to also record their highest total ever against Aus-

LIVERPOOL, Dec 24: Arsenal stayed on top of the English Premier League after holding on to draw Liverpool 1-1 at Anfield on

Arsenal led through Gabriel's fourth-minute header but Mohamed Salah evened the score in the 29th. Salah's 151st Premier League goal moved him to 10th on the all-time list. Liverpool pressed hardest in the second half and hit the woodwork twice.

Mikel Arteta's team will go into Christmas a point ahead of Liverpool. Defending champion Manchester City is likely happiest with the result after seeing two of its title rivals drop points

City, which fell to fifth while it was away winning the Club World Cup in Saudi Arabia this week, is six points behind Arsenal with a game in hand.

Another title challenger, Aston Villa, also dropped points with a

surprise 1-1 draw against Sheffield United on Friday. Villa was third on goal difference.

Liverpool has drawn back-toback games in the league against

Manchester United and Arsenal. Jurgen Klopp's team had the better chances to win on Saturday; Trent Alexander-Arnold hit the bar in the second half with only Arsenal goalkeeper David Raya to beat. Substitute Harvey Elliott also hit the post with a deflected shot from outside the box.

It was at Anfield that Arsenal's title challenge began to falter last season, when Arteta's team squandered an early 2-0 lead to draw 2-

The London side was ahead first again after a flying start that appeared to catch Liverpool cold. Gabriel Jesus had already seen

Harmanpreet's spell on third day was turning point: Sneh Rana

MUMBAI, Dec 24: Skipper Harmanpreet Kaur's spell on the third evening was the turning point in the one-off women's Test between India and Australia which the hosts won by eight wickets, said allrounder Sneh Rana here on

Kaur brought herself on after Australia's resurgent batting display kept India on the field for a large part of the third day and dismissed Tahlia McGrath (73) and Alyssa Healy (32), after they had reduced the first-innings deficit of 187 runs and taken a slender lead of 46 runs.

India came out firing on all cylinders to bowl Australia out for 261 after they resumed play at 233/5 on the fourth day and easily chased the target of 75 runs. "We were not thinking much and wanted to stay in the present. Harmanpreet's two wickets were the turning point," Rana told the media after India's maiden win over Australia in Tests when asked about the turning point in the match. Rana seconded India captain Kaur in acknowledging that head coach Amol Muzumdar had a key role to play in their strong performances. "As Harmanpreet said, he had an important role in the team. He has been a very experienced player and all his inputs have been good," Rana

"We have tried to follow that and the result can be seen in the last two Tests. We are very thankful that he has come on as a coach. In the future too we hope to continue doing well

under him," she added. On the fourth and final day spinners Rana, Rajeshwari Gayakwad and Deepti Sharma tamed the Australian batters with a superlative bowling show that saw the visitors lose five wickets for 28 runs.

Rana said the fact that they all compliment each other with on-field discussions worked in their favour.

"We try to talk a lot among ourselves when we are in (the field) and remain calm," she said. "Each of us back our respective strengths and we discuss about what is working in terms of which kind of delivery is behaving how and what you have to bowl to a batter."

"We try to keep it simple and not overcomplicate it and whatever we speak about on the field compliments us. We have had partnerships in both batting and bowling and the result is in front of us," Rana added. Rana said given the lack of Test assignments for the Indian team it was imperative to keep things simple.

'The preparations were simple, we had no need of experimenting a lot because red-ball and I have always prepared to bowl in my channels. I back my strengths and in these two matches I tried to do the same," she said.

Sports Ministry suspends newly-elected WFI for not following rules

NEW DELHI, Dec 24: The Sports Ministry on Sunday suspended the Wrestling Federation of India (WFI) till further orders after the newly-elected body made a "hasty announcement" of organising the U-15 and U-20 nationals "without following due procedure and not giving sufficient notice to wrestlers" for preparations.

The ministry also said the new body was working under the "complete control of former (WFI) office-bearers", which was not in conformity with the National Sports Code.

The WFI elections were held on December 21 with former president Brij Bhushan Sharan Singh's loyalist, Sanjay Singh, and his panel winning the polls by big margins.

'The new body has not followed the WFI constitution. The Federation stands suspended till further orders. WFI will not be taking care of day to day activities of wrestling. They need to follow the due process and the rules," a sports ministry official told PTI.

Top wrestler Bajrang Punia, who along with Vinesh Phogat and Sakshi Malik, had led the agitation against Brij Bhushan had returned his Padma Shri award to the government on Friday in protest over Sanjay Singh, who is a Brij Bhushan lo12/24/2023 1:02:44 PMyalist, becoming WFI President.

This was a day after Sakshi Malik quit wrestling for the same reason.

"Sanjay Kumar Singh, newly-elected



president of WFI announced on December 21, the day he was elected as president, that U-15 and U-20 nationals for Wrestling will take place in Nandini Nagar, Gonda (UP) before the end of this year.

"This announcement is hasty, without giving sufficient notice to wrestlers who are to take part in the said nationals and without following the provisions of the constitution of WFI," said the source.

"As per clause 3 (e) of preamble of constitution of WFI, object of the WFI, among others, is to arrange holding of Senior, Junior and Sub Junior National Championships as per UWW Rules at places selected by the Executive Committee," said the source.

The source added that the new body

had started functioning in the same premises (Brij Bhushan's official bunglow) from where the previous office-bearers operated wherein allegedly sexual harassment of the players have been alleged.

"Newly-elected body appears to be in complete control of former office-bearers in complete disregard to the Sports Code. "The business of the Federation is

being run from the premises controlled by former office-bearers. Which is also alleged premises wherein sexual harassment of the players have been alleged and present (ly) the court is hearing the mat-

"The decisions made by the newlyelected executive body of the Wrestling Federation of India (WFI) demonstrate a blatant disregard for the established legal and procedural norms, violating both the WFI's constitutional provisions and the National Sports Development Code," the source said.

Several top wrestlers, including Olympic medallists Bajrang Punia and Sakshi Malik and World Championship medallist Vinesh Phogat have levelled allegations of sexual harassment against Brij Bhushan and the case is being heard in the Delhi High Court.

The source added that all these actions by the new body are contrary to the established norms of fair and transparent gov-

"The actions smack of complete arbitrariness on part of the President, which is against the settled principles of good governance and devoid of transparency and due process. Adherence to governance norms is vital for ensuring fair play, transparency and accountability. There are crucial to built trust among athletes, stakeholders, and the public," said the source. The source added that the decision to hold the national championships should have been done in a procedural manner by informing the executive committee, which

"Such decisions (holding of the nationals) are to be taken by Executive Committee, before which agendas are required to be placed for consideration. As per Article XI of the WFI constitution under the Heading 'Notices and Quorum for Meetings', minimum notice period for EC meeting is 15 clear days and quorum is of

"Even for Emergency EC meeting, minimum notice period is 7 clear days with quorum requirement of 1/3rd of representatives.

"Further, in terms of the Article X (d) of Constitution of WFI, it is Secretary General of WFI, who has been made responsible for carrying out the general business of the Federation, keeping the minutes of the meetings, maintaining all the records of the Federation, calling the meetings of the General Council and the Executive Committee.

"It seems Secretary General has not been involved in the said meeting of EC, which was held without any notice or quorum," the source added.

Newly-elected WFI secretary-general, Prem Chand Lochab, had written to Sanjay Singh a day after the elections that a 'few states have objected to rescheduling and relocating of age group and junior Nationals".

"In this regard, no regular meeting of the Executive Committee of WFI as per its Constitution has been conducted after the elections for newly elected Executive Council held on 21-12-2023.

"In view of the above, it is felt that the grievances of state federations are genuine and may be considered and the U20 and U15 National Wrestling Championships 2023 scheduled at Nandini Nagar, Gonda from December 28-30 may be postponed," Lochab, the former Railway Sports Control Board secretary had writ-

I have taken retirement from wrestling, says ex-WFI chief Brij Bhushan

NEW DELHI, Dec 24: Former Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh on Sunday said he has "taken retirement" from the sport and the newly-elected body will now take charge as he has many more responsibilities to look into, including next year's Lok Sabha elec-

Brij Bhushan's comments came soon after his meeting with BJP chief JP Nadda following WFI's suspension by the Sports Ministry till further orders.

In suspending the newly elected WFI, the government cited its "hasty announcement" of organising the U-15 and U-20 nationals "without following due procedure and not giving sufficient notice to wrestlers" for

The ministry also said the new body was working under "complete control of former (WFI) office-bearers" -- an indirect refer-

ence to Brij Bhushan -- which was not in conformity with the National Sports Code.

The WFI elections were held on December 21 with Brij Bhushan's loyalist, Sanjay Singh, and his panel winning the polls by big

"I served wrestling for 12 years, good or bad only time will tell. I have taken retirement from wrestling. I am breaking my relationship with the sport. Now whatever decision has to be taken, whether to liaise with he government or handling the legal processes, those decisions will be taken by the elected members now. The Lok Sabha elections are round the corner and I have to move ahead," he said.

Brij Bhushan clarified that the decision to hold the U15 and U20 Nationals was taken in haste because he did not want the young players to lose one precious year of their ca-

"In haste, the old committee had to take the decision to organise the U15 and U20 Nationals because on December 31 the competition cycle (of year 2023) was ending and if those tournaments happen after that, one full year of the wrestlers would have gone waste," said Brij Bhushan.

"That's why all the state associations collectively decided that a sporting atmosphere needs to be brought back as soon as possi-

The decision to host the U15 and U20 Nationals in Nandini Nagar in Gonda has also drawn criticism from wrestlers including Olympic medallist Sakshi Malik, who have claimed young women were wary of going

Brij Bhushan said the Nationals were allotted to Nandini Nagar because all state associations declined to host them because of paucity of time to make arrangements at such a short notice.

"The championship was allotted to Nandini Nagar because every state association said they cannot organise it in just 4-5 days. The decision to hold the U15 and U20 Nationals was taken by consensus of all 25 state associations so that children don't lose one year. All 25 state associations gave their consent in writing to hold them in Nandini

"I will request the government and the sports ministry to please organise the tournaments under their supervision if they want in Delhi or whichever place they want so that children don't lose a year," he added. Brij Bhushan is a sitting BJP MP from Kaiserganj in Uttar Pradesh.

On meeting BJP chief JP Nadda on an eventful day, the former WFI chief said there was no discussion with regard to the suspension of the newly-formed body. (PTI)
