RANGIA, Dec 25: A suspected the first grenade blast, was peace ULFA (Independent) linkman was injured in a police firing while allegedly attempting to escape from custody in Assam's Kamrup (Rural) district on Monday, an officer said.

The police had raided the house of Pranjal Das alias Bhelu in Baihata Chariali area on Sunday night and recovered a flag of the outfit, following which he was taken into custody, Kamrup (Rural) superintendent of police Hitesh Roy said.

Das tried to escape from police custody in New Market area and the police opened fire in which he was injured on Monday. He was admitted to the Gauhati Medical College and Hospital for treat-

The SP said that Das was a close associate of another ULFA(I) linkman, Ashim Adhikary, arrested in Guwahati last week for allegedly recruiting cadres to the outfit.

He was allegedly involved in hoisting the outfit's flag at Baihata Chariali recently, the SP

Meanwhile, director general of police G P Singh warned that initiation of violence by a banned organisation was unacceptable. He said 'Our initial plan, after and conflict resolution through discussion'

'However, our peace initiative was taken as a weakness and further violence was committed. We still believe that peace and conflict resolution is the best way ahead but, initiation of violence from a banned organisation is unacceptable', Singh posted on 'X'.

### **Departure of grounded Romanian** plane with Indian passengers delayed

PARIS, Dec 25: The departure of a Romanian aircraft carrying nearly 300 passengers, mostly Indians, to Mumbai was delayed on Monday as some of them did not want to return to their country of origin, media reports said on Monday, three days after being grounded by the French authorities at an airport near Paris over suspected "human trafficking."

The situation was, for a time, confusing, according to Me Liliana Bakayoko, lawyer for the Romanian airline Legend Airlines.

Speaking to BFMTV, she said that some passengers did not want to return to their country of origin and that they had refused to board the plane initially this Monday

"Some of the passengers would be unhappy with this return because they wanted to continue their journey to Nicaragua as planned," the French news broadcast television and radio network reported.

According to the 'Le Monde' newspaper, the local prefecture, or official in charge, "confirmed" that the plane would indeed take off "but not before noon" local time. Two passengers are not autho-

rised to leave, and may face charges, the newspaper said. The Nicaragua-bound charter flight that took off from Dubai in

the United Arab Emirates (UAE) carrying 303 passengers was grounded at the Vatry airport, 150 km east of Paris, on Thursday over suspected "human trafficking". On Sunday, the French authori-

ties allowed the A340 aircraft, operated by Romanian company Legend Airlines, to resume its jour-



### Delhi HC refuses to direct TRAI to furnish info on tapping mobile phones

**NEW DELHI, Dec 25:** The Delhi High Court has set aside an order upholding the Central Information Commission's (CIC) direction to telecom regulator TRAI to collect and furnish information under Right to Information (RTI) Act proceedings about the alleged tapping of a mobile user's phone.

A bench headed by Justice Vibhu Bakhru allowed an appeal filed by the Telecom Regulatory Authority of India (TRAI) against a single-judge bench order and said an act of surveillance is carried out under the government's directions and in the interest of the country's sovereignty and integrity, the security of the State, friendly relations with foreign states or public order, or for preventing incitement to the commission of an offence, and is exempted under the RTI Act.

"Any orders passed by the government concerned in relation to interception or tapping or tracking of a phone is passed when the authorised officer is satisfied that it is necessary or expedient to do so in the interest of the sovereignty and integrity of India, the security of the State, friendly relations with foreign states or public order, or for

preventing incitement to the commission of an offence," the bench, also comprising Justice Amit Mahajan, said in a recent order.

"In a given case, the disclosure of any such information, therefore, may impede the process of investigation and may be construed to prejudicially affect the sovereignty and integrity of India, the security, the strategic, scientific and economic interest of the State, relations with foreign states or lead to incitement of an offence, and would therefore be exempted from disclosure under the terms of section 8 of the RTI Act," the court concluded.

It further said phone tapping does not fall under the affairs of telecom service providers and the information sought also does not relate to the functions of the TRAI under the law.

"Any contrary view would give the authority (TRAI) unbridled power to call for information and interfere with the functions of telecom service providers, and also would not be in consonance with the objects sought to be achieved by the TRAI Act," the court said. It said the (CONTD. ON PAGE-9)

### Adani Green Energy inks pact with SECI for supply of 1,799 MW solar power



NEW DELHI, Dec 25: Adani Green Energy (AGEL) on December 25 said it has signed a power purchase agreement (PPA) with the Solar Energy Corporation of India (SECI) to supply 1,799 MW of solar power. With the signing of this balance PPA, AGEL has completed the power offtake tie-up for the entire 8,000 MW manufacturing-linked solar tender awarded to it by the SECI in June 2020, a company statement said.

According to the statement, AGEL has announced the execution of a PPA with the SECI to supply 1,799 MW of solar power. "We are glad to conclude the largest green PPA and enable a sustainable energy landscape. Aligned to India's target of 500 GW non-fossil fuel capacity by 2030, Adani Green is determined to deliver in excess of 45 GW renewable energy, a five-fold increase from our current operating portfolio," Amit Singh, CEO, AGEL, said in the

AGEL has progressed on the commitments of the SECI manufacturing-linked solar PV tender, including setting up 2 GW of PV cell and module manufacturing facilities. AGEL has already commissioned a solar PV cell and module manufacturing plant with a capacity of 2 GW per annum through its associate company Mundra Solar Energy Ltd (MSEL), it stated.

### Here's what happens to the billions that go unspent each year

SAN FRANSISCO, Dec 25: Gift cards make great stocking stuffers — just as long as you don't stuff them in a drawer and forget about them after the hol-

Americans are expected to spend nearly \$30 billion on gift cards this holiday season, according to the National Retail Federation. Restaurant gift cards are the most popular, making up one-third of those sales.

Most of those gift cards will be redeemed. Paytronix, which tracks restaurant gift card sales, says round 70% of gift cards are used within six months.

But many cards — tens of billions of dollars' worth - wind up forgotten or otherwise unused. That's when the life of a gift card gets more complicated, with expiration dates or inactivity fees that can vary

LOVED, BUT LOST

After clothing, gift cards will be the most popular present this holiday season. Nearly half of Americans plan to give them, according to the National Retail

But many will remain unspent. GIFT CARDS or recipients hang on to them for a special occasion. In a July survey, the consumer finance company Bankrate found that 47% of U.S. adults had at least one unspent gift card or voucher with an average value of \$187. That's a total of \$23 billion.

THE GIFT OF TIME

Under a federal law that went into effect in 2010, a gift card can't expire for five years from the time it was purchased or from the last time someone added money to it. Some state laws require an even longer period. In New York, for instance, any gift card purhased after Dec. 10, 2022, can't expire for nine years.

Differing state laws are one reason many stores have stopped using expiration dates altogether, says Ted Rossman, a senior industry analyst at Bankrate. **USE IT OR LOSE IT** 

While it may take gift cards years to expire, experts say it's still wise to spend them quickly. Some cards especially generic cash cards from Visa or Master-Card — will start accruing inactivity fees if they're not used for a year, which eats away at their value. Inflation also makes cards less valuable over time. And if a retail store closes or goes bankrupt, a gift card

Perhaps consider clearing out your stash on National Use Your Gift Card Day, a five-year-old holiday created by a public relations executive and now backed by multiple retailers. The next one is Jan. 20,

If you have a gift card you don't want, one option is to sell it on a site like CardCash or Raise. Rossman says resale sites won't give you face value for your cards, but they will typically give 70 to 80 cents per

THE MONEY TRAIL

What happens to the money when a gift card goes unused? It depends on the state where the retailer is incorporated.

When you buy a gift card, a retailer can use that money right away. But it also becomes a liability; the retailer has to plan for the possibility that the gift card will be redeemed.

Every year, big companies calculate "breakage," which is the amount of gift card liability they believe won't be re-

averages. For some companies, like Seattle-based Starbucks, breakage is a huge profit-driver. Starbucks reported \$212 million in revenue from breakage in 2022.

But in at least 19 states — including Delaware, where many big companies are incorporated — retailers must work with state unclaimed property programs to return money from unspent gift cards to consumers. Money that isn't recovered by individual consumers is spent on public service initiatives; in the states' view, it shouldn't go to companies because they

haven't provided a service to earn it. CLAIM IT

All 50 states and the District of Columbia have unclaimed property programs. Combined, they return around \$3 billion to consumers annually, says Misha Werschkul, the executive director of the Washington State Budget and Policy Center.

Werschkul says it can be tricky to find the holders of unspent gift cards, but the growing number of digital cards that name the recipient helps. State unclaimed property offices jointly run the website MissingMoney.com, where consumers can search by name for any unclaimed property they're owed, including cash from gift cards. (AP)

### Year of social media soul-searching

### Twitter dies, X and Threads are born and AI gets personal

NEW YORK, Dec 25: We lost Twitter and got X. We tried out Bluesky and Mastodon (well, some of us did). We fretted about AI bots and teen mental health. We cocooned in private chats and scrolled endlessly as we did in years past. For social media users, 2023 was a year of beginnings and endings, with some soul-searching in between.

Here's a look back some of the biggest stories in social media in 2023 what to watch for next year:

#### **GOODBYE TWITTER**

A little more than a year ago, Elon Musk walked into Twitter 's San Francisco headquarters, fired its CEO and other top executives and began transforming the social media platform into what's now known as X.

Musk revealed the X logo in July. It quickly replaced Twitter's name and its whimsical blue bird icon, online and on the company's San Francisco headquar-

"And soon we shall bid adieu to the twitter brand and, gradually, all the birds," Musk posted on the site.

Because of its public nature and because it attracted public figures, journalists and other high-profile users, Twitter always had an outsized influence on popular culture — but that influence seems to be waning.

"It had a lot of problems even before Musk took it over, but it was beloved brand with a clear role in the social media landscape," said Jasmine Enberg, a social media analyst at Insider Intelligence. 'There are still moments of Twitter magic on the platform, like when journalists took the platform to post real-time updates about the OpenAI drama, and the smaller communities on the platform remain important to many users. But the Twitter of the past 17 years is largely gone, and X's reason for existence is

Since Musk's takeover, X has been bombarded by allegations of misinformation and racism, endured significant advertising losses and suffered declines in usage. It didn't help when Musk went on an expletive-ridden rant in an on-stage interview about companies that had halted spending on X. Musk asserted that advertisers that pulled out were engaging in "blackmail" and, using a profanity, essentially told them to get lost.

Continuing the trend of welcoming back users who had been banned by the



former Twitter for hate speech or spreading misinformation, in December, Musk restored the X account of conspiracy theorist Alex Jones, pointing to an unscientific poll he posted to his followers that came out in favor of the Infowars host who repeatedly called the 2012 Sandy Hook school shooting a hoax.

LGBTQ and other organizations supporting marginalized groups, meanwhile, have been raising alarms about X becoming less safe. In April, for instance, it quietly removed a policy against the "targeted misgendering or deadnaming of transgender individuals. In June, the advocacy group GLAAD called it "the most dangerous platform for LGBTQ people.3

GLSEN, an LGBTQ education group, announced in December that it was leaving X, joining other groups such as the suicide prevention nonprofit Trevor Proj-

ect, saying that Musk's changes "have birthed a new platform that enables its users to harass and target the LGBTQ+ community without restriction or disci-

#### HELLO X. AND THREADS. AND **BLUESKY**

Musk's ambitions for X include transforming the platform into an "everything app" - like China's WeChat, for instance. The problem? It's not clear if U.S. and Western audiences are keen on the idea. And Musk himself has been pretty vague on the specifics.

While X contends with an identity crisis, some users began looking for a replacement. Mastodon was one contender, along with Bluesky, which actually grew out of Twitter — a pet project of former CEO Jack Dorsey, who still sits on its board of directors.

When tens of thousands of people, many of them fed-up Twitter users, began signing up for the (still) invite-only Bluesky in the spring, the app had less than 10 people working on it, said CEO Jay Graber recently.

This meant "scrambling to keep everything working, keeping people online, scrambling to add features that we had on the roadmap," she said. For weeks, the work was simply "scaling" — ensuring that the systems could handle the influx.

"We had one person on the app for a while, which was very funny, and there were memes about Paul versus all of Twitter's engineers," she recalled. "I don't think we hired a second app developer until after the crazy growth spurt.'

MENTAL HEALTH WORRIES Social media's impact on children's mental health hurtled toward a reckoning this year, with the U.S. Surgeon General warning in May that there is not enough evidence to show that social media is safe for children and teens — and calling on tech companies, parents and caregivers to take "immediate action to protect kids

"We're asking parents to manage a technology that's rapidly evolving that fundamentally changes how their kids think about themselves, how they build friendships, how they experience the world — and technology, by the way, that prior generations never had to manage,' Dr. Vivek Murthy told The Associated Press. "And we're putting all of that on the shoulders of parents, which is just simply not fair." (AP)

The level crossing gate ST-27 was a busy gate with a train vehicle unit (TVU) of 669,754, leading to frequent closures and traffic



disruptions The Northeast Frontier Railway constructed the ROB (No. 85A) at

a total cost of ₹85.96 crores to ensure the safety of both rail and road users. The total length of the bow string arch steel girder of 74 meters length, with a height of 12.85 meters and a weight of 730 MT. The ROB includes a newly constructed three-lane road of 11 meters width connecting NH 24 & NH 715A with viaducts on both sides. Additionally, two staircases on either side of the Bow String Girder have been provided for pedestrians to cross the railway

#### **Houthi Strikes Disrupt Global Shipping**

In recent developments in the Red Sea, Yemen's Houthi rebels continue their targeted assaults on ships, impacting global shipping Land escalating geopolitical tensions. The United States leads a coalition of 10 nations in efforts to prevent further attacks, emphasizing the shared interest in avoiding a potentially uncontrollable escalation. The Houthi rebels claim their strikes on ships, particularly those linked to Israel, aim to pressure Israel into ending the Gaza conflict. These attacks, supported within Yemen, also serve the Houthi recruitment drive for new fighters. The situation is exacerbated by the toll of over 20,000 Palestinian lives lost in Gaza since October 7 due to Israeli bombings and artillery shelling. The Houthi capture of the cargo ship 'Galaxy Leader' on November 19, linked to Israel, has turned into a tourist attraction for Yemenis. Furthermore, their targeting of ships in the Bab el-Mandeb Strait, a crucial passage to the Red Sea and Suez Canal, has led to disruptions in global shipping. Approximately 30 percent of global container ship traffic relies on this route. Sanam Vakil of Chatham House notes the strategic importance of the Houthi presence in northern Yemen, creating a geopolitical bottleneck. While Houthi attacks haven't caused injuries or deaths, their impact on global shipping is significant. Over 12 shipping firms, including major players like Mediterranean Shipping Company and CMA CGM, have suspended operations in the Red Sea. This disruption affects about 12 percent of the world's seaborne oil and eight percent of liquefied natural gas, with companies opting for longer routes around the southern tip of Africa, increasing costs by at least 15 percent.

In response, the United States has imposed sanctions on 13 individuals accused of financing the Houthi rebels. A maritime coalition involving the United Kingdom, France, Italy, Canada, the Netherlands, Norway, Spain, Seychelles, and Bahrain aims to deter the Houthi actions. However, Yemen's internationally recognized government, based in Aden, faces a delicate situation, unwilling to be perceived as supporting Israel. Iran, a supporter of the Houthi rebels, treads carefully not to escalate the Gaza conflict regionally. However, Eleonora Ardemagni of the Italian Institute for International Political Studies doubts Iran's extensive influence over the Houthis. The Houthi rebels pursue an independent agenda, capitalizing on internal challenges before October 7 to gain widespread support by backing Gaza. The Houthi state media reports over 1,000 protests, boycotts, and recruitment efforts since the Gaza conflict began. Despite war-weariness in Yemen, supporting Hamas has helped the Houthi recruit new fighters, deployed not only in Gaza but also against the Yemeni government stronghold of Marib. The Red Sea attacks may be a diplomatic tactic aimed at Saudi Arabia. Talks between the Houthi and Saudi Arabia for a ceasefire follow a UN-mediated truce in 2022, with tensions and disruptions to oil trade pressuring Saudi Arabia to return to the nego-

Despite the involvement of the United States and its allies, the Houthi belligerence persists. Houthi spokesperson Mohamed Abdulsalam attributes the Red Sea "operations" to supporting Gaza. The US, cautious not to escalate the crisis, refrains from retaliatory action against the Houthi, highlighting the delicate balance in the region as both parties avoid crossing a dangerous threshold. The Red Sea tensions escalate as Houthi rebels target ships linked to Israel, disrupting global shipping. Despite international efforts, the impact persists, challenging diplomatic resolutions.

### Save the Maharashtra tiger, 41 killed in 10 months alone

aharashtra boasts a seemingly healthy tiger population, but the numbers hide a troubling reality: a significant number of these magnificent creatures are dying, with a third of the deaths attributed to unnatural causes. Since 2018, Maharashtra has lost 151 tigers. Poaching and electrocution were responsible for 42 tiger deaths. Drowning incidents and rail/road accidents killed another 16. Tiger habitats should be kept free of road/rail intrusions.

As of October 2023, Maharashtra recorded 41 tiger deaths, including from accidents and poisoning. In 2022, the toll was 29, with 18 dying from natural causes, four to accidents, four to electrocution, and three to poaching. The 2022 'Tiger Census' revealed Maharashtra had an estimated 444 tigers in its six tiger reserves: Tadoba Andhari. Pench, Navegaon Nagzira, Bor, Melghat, and Sahyadri. Poaching remains the most serious threat to tigers. And poacher gangs have become increasingly brazen. Only enhanced surveillance and protection in buffer areas, besides translocation corridors to safeguard dispersing tigers during their territorial expansion, will help fight poachers.

Some tigers inadvertently become victims of electrified fences which farmers erect to protect their crops from herbivores. The story is that farmers often steal power to electrify farm fences. They do this electrification themselves or by untested hands, shoddy unsafe work, indeed, for which tigers pay the price with their precious lives.

Electrocuting tigers is also the favoured method of poachers, who also use live traps to ensnare tigers. Tigers keep falling victim to electrocution and illegal hunting posing a significant threat to wildlife conservation efforts. In 2011, the Wildlife Trust of India (WTI) introduced anti-snare walks (ASWs) to detect and remove snares in and around wildlife protected areas.

At a recent orientation training conducted by WTI for the forest and electricity department officials, SM Dathrak, the Range Forest Officer of North Deori, stressed the importance of ASWs. There's the recent incident of the deaths of three leopards – a mother and two cubs – from electrocution, which prompted residents to be more careful when erecting electrified fencing. In the Vidharba region of Central India, which is a critical corridor for tiger movement but faces high anthropogenic pressure, tigers and other wildlife are at risk due to encounters with humans. In the past decade, the region has seen tiger and leopard deaths from snares and traps, along with electrocution from live wires. The WTI conducted orientation workshops across eight Territorial Divisions of the Nagzira-Navegaon Tiger Reserve (NNTR) ranges. These workshops involved forest officials and collaboration with Maharashtra State Electricity Distribution Company Limited (MSEDCL) officials to reduce electrocution and snaring in the landscape. The focus extended beyond core areas to buffer zones where tigers fre-

Practical sessions included forest officials walking along electric lines and forest-agriculture boundaries to identify snaring incidents and record ASW tracks and data using an Anti-Snare Walk mobile application. Presentations covered wildlife crime in India, the Wildlife (Protection) Act, and documentation of evidence during encounters. Efforts like these demonstrate a commitment to safeguarding tigers and other wildlife in Maharashtra, where conservationists, government agencies, and local communities work together to protect these majestic creatures and their habitats.

As per media reports, Sudhir Mungantiwar, Maharashtra's Minister for Forests, emphasizes the importance of launching public awareness programs to inform locals about tiger presence. In the Tadoba Andhari Γiger Reserve, the forest department employs AI-based e-surveillance to capture thermal images of tigers and alert local villagers. Mungantiwar underscores the priority of reducing tiger electrocution to zero. A senior forest department official acknowledges that tiger deaths in Maharashtra are linked to population growth. He asserts that unnatural deaths are a consequence of saturation in tiger landscapes and expanding urbanization, leading to increased man-animal conflicts. Many of Maharashtra's tigers reside in landscapes with human settlements, mining activities, and other human interventions. (IPA Service)

The vacuity of the free trade argument

country with relatively unrestricted trade will face two problems: the first is a balance of payments problem because its exports are insufficient relative to its imports. And the second, the creation of unemployment, and more generally of domestic resources remaining idle, because domestic goods cannot compete with imports. These two are not identical problems. There can be unemployment even when there is no import surplus.

During the colonial era domestic "deindustrialisation" caused massive unemployment of artisans and craftsmen even though the Indian economy did not have an import surplus. In what follows I shall concentrate only on the employment question.

The fact that unrestricted trade creates domestic unemployment is quite obvious. Yet there is a general impression that free trade is a good thing, and an utterly spurious argument is advanced to create this impression. This argument states that countries should specialise in the production of those goods where they have a "comparative advantage"; if each country does this, then world output would be larger than otherwise, so that all countries can profit. This free trade argument based on "comparative advantage" is a complete fiddle. It assumes that in each country there is always full employment of all resources, including labour-force, irrespective of whether it is engaging in trade or not. It follows that if all resources, including its labour-force, are fully employed before and after trade, then all that trade involves is a mere redirection of resources from one kind of use to another; it cannot by assumption cause the unemployment of any resource including a country's labour-force.

Once we reject this assumption however, as we must since it has ory, the potentially deleterious implications of free trade for a

country become clear. There is a very simple way of seeing this. Suppose the total production capacity of the world economy is 100 units; if total demand in the world economy is 80 units, then 20 units of world output would remain unrealised, and hence, under capitalist conditions, unproduced. The resources that remain unemployed as a result will be distributed among the countries in a certain manner.

A question may be raised here. Keynes, afraid of the workers being disillusioned with capitalism because of the unemployment it generates and hence moving towards socialism, had suggested State

The very simple and obvious answer to this question is that for this to happen there has to be a world State with a world government, which there isn't under capitalism. And in countries resources unutilised because the world demand is not large enough, if their particular states attempted to raise demand in those economies to create larger unemployment, then under free trade conditions this extra demand might "leak out" resulting in additional imports and hence an unsustainable trade deficit. If these countries did not have free trade and could protect their economies, then their governments could expand domestic aggregate demand and hence employment. But their hands get tied because of free



The fact that under a free trade regime a country's government cannot intervene to raise aggregate demand and hence employment, but has to accept meekly the fall-out of the consequences

of whatever the level of world demand happens to be, means that employment. whether in a

particular country or at the world level, might well be lower with free trade than if countries could resort to protection. This totally negates the fundamental argument for free trade. This argument, it may be recalled, hinged on the fact that each country, specialising in producing only those goods where its comparative advantage lay, would increase world output which would be potentially beneficial for all countries; but this argument collapses once we recognise that post-freetrade world output might be lower than pre-free-trade world output if the level of world aggregate demand in the former situation shrinks compared to the

What, it may be asked, does the post-free-trade world aggregate demand depend upon? The primary determinant of world aggregate demand is the demand generated within the leading capitalist country, in the present con-

text the United States, which enjoys a degree of autonomy in generating demand even when this demand "leaks out" to other countries. This is because it does not have to worry about a trade deficit as its currency is generally considered to be "as good as gold" and it can simply print money to finance its external deficits which the rest of the world would be willing to hold.

It is for this reason that consumption plus investment plus government expenditure in the United States becomes the primary determinant of world aggregate demand. Government expenditure of the US in particular is important here because it has a certain autonomy: it can be turned on like a tap. In this sense the US State, despite being a nation-state, can potentially act, and even actually acts up to a point, as a surrogate world-state in conditions of contemporary capital-

There is however a contradiction here which is now beginning to make itself felt. While the US State can act as a surrogate world state, it is not a world state; it remains, everything said and done, a nation-state after all. If the US State increases domestic aggregate demand which "leaks out", then, even though the US may not have any problems in financing its external deficit, it gets indebted while financing its debted while generating employment, most of which is located abroad. An enlarging through larger government expenditure of US aggregate demand therefore, while it may not raise any technical problems for the US in the sense of being unsustainable, militates against its narrowly national point of view, which its State cannot ignore as it is after all a nation-state. Its nation-state role in short comes in the way of its surrogate world-state role. This contradiction is now reaching an acute form.

During the pandemic the US ran large fiscal deficits to finance the provision of relief to their populations. Even after the pandemic was over, the US was keen to continue with relatively larger fiscal deficits for reviving domestic aggregate demand, but was somewhat thwarted by the recent upsurge of inflation. But once this upsurge abates, there is likely to be a stimulus to domestic demand in the US by State expenditure, but this would be accompanied by protectionism to prevent any "leaking out" of demand to other countries. In fact, the US for some time has been moving towards protectionism, most clearly directed against China, but also vis-à-vis other third world countries

Some have called this move towards protectionism in the US "de-globalisation" but that is not correct. While there is this tendency to introduce protectionism, no restrictions are being placed by the US on the movement of finance capital; indeed, on the contrary, any third world country imposing capital controls faces victimisation by the US. Such contradictions, however, do not bother the US. After all, it is a country that is going protectionist even while preaching the virtues of free trade to the rest of the

### Maldivian politics unveiled: Subtle forces that could favor India

olitical complexities are unfurling in the Maldives, revealing intricate narratives beyond the anticipated dichotomy. The much-discussed national elections were often framed as a contest between the 'pro-India' Maldivian Democratic Party and the 'pro-China' People's National Congress. However, a deeper exploration unravels a more nuanced reality. During the tenure of former President Ibrahim Mohamed Solih (2018-2023), the Maldivian Democratic Party fostered a diplomatic thaw, notably restoring amicable relations with Delhi following the preceding administration's anti-Indian stance under Abdulla Yameen.

In a surprising turn of events, the People's National Congress, led by Mohamed Muizzu, ran a virtual 'India Out' campaign during this election season. Ultimately, their strategic approach resonated with the electorate, leading to their victory in the polls.In keeping with his electoral commitment, Mohamed Muizzu formally requested the Indian Government to withdraw its personnel. Notably, he assured a stance that is unequivocally 'pro-Maldives,' steering clear of being labeled as either 'anti-India' or 'pro-China.' The context of Muizzu's presidential candidacy adds another layer, as he entered the race due to the legal exclusion of Abdulla

Yameen over corruption and money laundering charges. This context has amplified expectations of a potential shift in Male's diplomatic allegiance from Delhi to Beijing, seemingly on behalf of Yameen's interests. The unfolding narrative has aligned with expectations, prompting Delhi to adopt a cautious stance and observe President Mohamed Muizzu's actions to gauge the true extent of his perceived reservations toward India. The lingering question revolves around whether Muizzu, previously characterized as a politically charged, accusatory opposition leader during the campaign, will diverge from this image and chart a distinctive course or align closely with his supposed mentor Yameen's inclinations.

The prospect of Muizzu tempering his political rhetoric in favor of practical considerations, potentially mitigating the noise against Delhi, remains uncertain in these early stages. As is customary in politics, the complexities and subtle currents beneath the surface are likely more intricate than they appear. Importantly, Muizzu's autonomy from Abdulla Yameen beyond a certain point could significantly shape the unfolding political dy-

namics Following the settling dust of the recent elections, two unrelated topics have dominated discussions in the Maldives. Firstly, there's a pervasive sense of uncertainty surrounding Mohamed Muizzu's political trajectory, keeping the public discourse engaged in speculation. Secondly, the sudden surge in onion prices, a staple in Maldivian cuisine, has captured attention.

With India restricting onion exports to address its domestic inflation concerns. Male is grappling with the repercussions, witnessing a spike in prices from Maldivian Rupee 200-300 per sack to 900-1000. Attempts to explore alternative supplies from Pakistan and China have highlighted the challenges, as the quality and pricing don't match up. Despite fulfilling his campaign promise by releasing Yameen from incarceration, Muizzu opted not to delay celebratory events to accommodate Yameen's presence and participation. This nuanced behavior speaks volumes about the evolving dynamics between the two, indicating a shift in the dynamics of their relationship post-elec-Rumblings within political cir-

cles suggest that President Mohamed Muizzu is becoming increasingly aloof to unsolicited advice and interference from Abdulla Yameen. Muizzu appears determined to carve out his own distinctive style, policies, and preferences as a rightfully elected President, rather than serving as a mere conduit for someone else's agenda. The leadup to Yameen's promised release was marked by tense interactions, with Muizzu urging Yameen's supporters to refrain from street protests and entrust him with the handling of Yameen's release. ### Global shipping industry hostage to Red Sea-Suez crisis

The shipping industry is keeping its fingers crossed till the Gaza-Houthi triggered crisis in Red Sea-Suez Canal areas lasts. The duration of the current situation is what matters. A temporary disturbance – a perceived bump in the road – and the industry may cope. But, if it lasts, with container vessels forced to divert around the Cape of Good Hope, and the inaccessibility of critical ports will add to the strain.

The Red Sea, especially with the Suez Canal, is like a superhighway for shipping containers, connecting different parts of the world, particularly Europe, Asia and Africa. However, ongoing disruptions will escalate operational costs, adding significant strain, while concurrently exerting downward pressure on profits. It marks a disheartening beginning to the strategic planning for the year 2024.

The Red Sea trade route is strategically significant due to its role in connecting the Mediterranean Sea to the Indian Ocean, providing a shortcut for ships travelling between Europe and the countries in Asia and Africa. The 193-km long

canal accounts for 12 percent of global trade, including 30 percent of all container movement. A huge amount of Europe's energy supply, palm oil and grain come through the Suez Canal Waterway which also gets impacted by these attacks and subsequently by the disruptions there-

A lingering question is when naval forces, particularly from Egypt, Great Britain, France, and the US, will take control of security in the Red Sea.

It is significant that the crisis is at a time when shares of shipping lines have jumped in anticipation of a post-Covid disruption revival. It will all depend on how navies take this up. Egypt has a significant commercial interest in the functioning of the Suez Canal as it is one of the main revenue drivers and if the diversion happens then it will have a significant impact there.

According to Container Xchange, the platform for the logistics industry, a consistent pricing trend has been observed in the surge of freight rates, with increases of 20 to 30 percent on major East-West corridors in the spot prices. Up to 77 million TEU of capacity, accounting for 5 to

6 percent of the market's total capacity, is

Missile attacks by Houthi militants in the Red Sea have prompted leading shipping entities like CMA CGM, Hapag-Lloyd, Maersk, and Mediterranean Shipping Co. to temporarily halt transits through the Suez Canal. Additionally, the Panama Canal has been effectively closed to multipurpose shipping until at least May, leading carriers to explore alternative routes via the Cape of Good Hope and the Strait of Magellan.

According to the platform, the market anticipates that especially in Europe which is on the receiving end of import containers from the Middle East, India, Southeast Asia and China, that container scarcity will lead to an increase in container prices and the market. Ports at the receiving end of those import containers like the port of Rotterdam and Hamburg, are recording a significant increase in container prices over the last two weeks, since the situation in Red Sea started to

Some of the main ports in Germany like Rotterdam, Hamburg, Bremen are posting significant week on week price increases

and of course the interpretation is that the situation in the Red Sea has contributed to this increase.

The situation in the Red Sea has been escalating quite significantly over the last two weeks where Houthi rebels have started to attack the commercial vessels by the big ocean liners. Subsequently the container liners are essentially instructing their vessels to avoid transiting through the Suez Canal and around the Cape of Good Hope adding quite a significant delay and time to their East to West trade

An additional 40 percent longer route, causing heavy upward pressure in the operating costs is expected to persist as the shipping time extends anywhere between one to four weeks due to the longer route.

Israel has been particularly affected due to the shipping crisis. About 30 percent of Israeli imports come through the Red Sea on container vessels that are booked two to three months in advance for consumer or other products, meaning that if the voyage will now be extended, products with a shelf life of two to three months will not be worthwhile importing from the Far East. # Making disability a joke is neither comedy nor art

sat through roughly two and a half hours of crisis while watching the recent Bollywood movie Aankh Micholi. Recently. Goa State Commissioner for Persons with Disabilities ordered two district administrations to stop the movie from screening. The office of the Chief Commissioner of Persons with Disabilities also issued notice to the makers of the movie and Central Bureau of Film Certification seeking a response from them, as the movie violated Sections 3 (non-discrimination) and 92 (punishment for offences of atrocities) of the Rights of Person with Disabilities Act, 2016 (RPwD Act).

In brief, the story is based on a family of six. Barring two members, all of them live with some form of disability. The story is premised on the theme of the marriage of the lead character (Mrunal Thakur), who is living with a visual disability, rendering her unable to see at night. The underlying premise is that the disability is a disease that has to be hidden from outsiders (including the one you will be marrying).

#### Undoing the understanding of disability

The disability movement across generations has struggled to eradicate the engrained idea of the medical model of disability, wherein your disability is identified in the medical condition. The American civil rights move-

ment percolated into the disability rights movement. Thus, the social model of disability was followed, wherein societal barriers are identified as the source of disability and not the individual. This understanding was implemented through legislative mandate under the Rights of Persons with Disabilities Act, 2016, which used the phrase "person with disability" rather than a disabled person - placing individuals at the forefront. It also defines a person with disability in a more social sense: "a person with long-term physical, mental. intellectual or sensory impairment which, in interaction with barriers, hinders his full and effective participation in society equally with others".

The makers of this movie and others in the Indian cinema world have systematically misconstrued this fundamental differentiation. In the movie, characters often view the inherent disability as a person's characteristic and a painful extra. Disability is termed a beemari (disease).

No legal excuse

The apparent argument from the makers of the movie is the freedom of expression and creative liberty. This overarching freedom is also limited by reasonable limitation under Article 19(2), specifically decency and morality. The makers have rendered the creation an ideal piece of ableism devoid of decency. The Supreme Court has proactively decided not to confine the



contours of decency to just acts of a sexual nature but has widened the horizons to include acts that would invite a collective shock, disgust or revolt.

For instance, in Dr. Ramesh Yeshwant Prabhoo vs Shri Prabhakar Kashinath Kunte, while explaining indecency, the Supreme Court said, "...Indecency is not confined to sexual indecency; indeed it is difficult to find any limit short of saying that it includes anything which an ordinary decent man or woman would find to be shocking, disgusting and revolting..."

The makers in the work employ the ableist framework in every corner of the screenplay, garbed as humour. This fundamentally invites disgust from a large sect of society whose lives are depicted as devoid of any dignity. The Supreme Court in Vikash Kumar vs UPSC, while explaining the dignity of persons with disabilities, said that it is "intrinsic to individual dignity. is recognising the worth of every person as an equal member of

the society, respect for the dignity of others and fostering conditions in which every individual can evolve according to his capabilities".

Section 5B of the Cinematograph Act, 1952 deals with the 'Principles of guidance in certifying films'. Subsection (1) of section 5B allows the film certification authorities to not certify a film for public exhibition if it is against "decency and morality". This can serve as an instrument to direct makers to comply with basic tenets of dignity wherein creativity subordinates every other aspect.

The RPwD Act was imple-

mented to ensure equality and dignity for persons with disabilities. Resultantly, section 3 of the RPwD Act talks about equality and non-discrimination. It is operationalised in different sectors through various sections of the RPwD Act, wherein government and private bodies are obligated to ensure this mandate. Thus, the Cinematograph Act must be aligned with these principles.

Creating stereotype through

The phenomenon is not new and is documented in a seminal piece by Joyojeet Pal. He underlines four trends in Indian films: first, disability as punitive; second, disability as dependence; third, disability as disequilibrium and fourth, disability as maladjustment. For the first trend, an all-time classic Sholay (1975) fits the mould; the antagonist thinks chopping off a character's arms is worse than death. Disability as a divine punishment has also been a central theme for makers, which is visible in movies like Dhanwaan (1981).

The second aspect, and probably the most prominent one, is of disability as dependence. The sympathetic attitude towards persons with disabilities is often transformed into the object of pity and a metaphor depicting helplessness. This is catalysed by cinematic depiction. Pal, in his paper, underscores a series of films that have regularly employed this trend, mainly as a subject of violence because of this dependence, like in Hum Aapko Aapse Pyaar Hai (2006) or an all-time classic like Mother India (1957), wherein the disability is looked at with ridicule as it is presumed to default dependence.

The third and fourth aspects are closely related to finding disability as something extra that burdens an individual's ability to live a "normal" life in a society. This is evidenced in the screen-

sole objective is to either correct her/his disability or that of someone else. This is vividly visible in Shatrughan Sinha's movie Aa Gale Lag Jaa (1974), where he endeavours to cure a poliostruck boy by employing the most extreme form of mental violence. Thus, as Pal mentions in his paper, there is a dearth of cinema wherein the protagonist stays disabled throughout the

film. Recent creations like Mar-

garita with a Straw (2014) or

Guzaarish (2010) serve as an ex-

ception on this front.

The social maladjustment aspect of disability further attributes the trait of evilness. This is not unique to Indian films, as the recent addition to James Bond's franchise showed Rame Malek as having a disability to underline his evil characters further. However, the most common usage of this aspect in in comedy, which is exactly what makers of Aankh Micholi intended to do. A few examples include Hum Hai Kamaal ke (1993) or Tom Dick and Harry (2006).

However, the makers of Aankh Micholi indulge in establishing the undertone that persons with disabilities are not necessarily equal, especially when they have to fit into the institution of marriage. The underlying messaging of the film—that to fit in the most fundamental unit of our society, people with disabilities must hide their disability—cannot be overlooked

Respect the new reality

Hindi cinema has seen a transition to accommodate disability more meaningfully and is sticking to a new understanding of the concept. This understanding is depicted in films like Black (2005) and My Name is Khan (2010). The makers don't necessarily have to overwrite disability in their screenplay for any of the four trends mentioned above.

If Bollywood wants to make a comedy using disability as the central theme, they might wish to experiment with an extreme option: casting a person with a disability. In the movies Peanut Butter Falcon (2019) or Give me Liberty (2019), an actor with Down Syndrome and locomotor disability shows that comedic timing is not the exclusive domain of able-bodied individuals but rather a skill to be acquired with effort. It might not have to look far for inspiration either. Gulzar's 1972 classic Koshish had its poster and introduction credits in sign language, as the lead actors were living with some form of disability.

The character depicted that they can live independently if society doesn't interfere. This conceptual understanding was far ahead in both cinematic and political discourse. The decline of Indian cinema from Koshish to Aankh Micholi on the issue of disability depiction shows the intellectual bankruptcy of today's makers. ### Social media is broken for news; Here's what I'm doing about it

pps like Instagram were once about seeing how your friends were doing, seeing who ate what, where and with whom and more unnecessarily details alike. But over the years, they became a source of details that are necessary. They became your news source, for reports like this: The Israel-Hamas war is all set to escalate. US President Joe Biden reportedly gave \$8 billion to assist Israel. To counter this massive funding, BBC reported that Ukraine was smuggling weapons to Hamas.

What you just read in italicized text are two instances of disinformation pointed out by The Guardian, with a wee bit of my own trickery (linking them both as cause and effect). The news about US President Joe Biden's \$8 billion funding is from an edited document posted on X (formerly Twitter). And nope, BBC did not report the weapon-smuggling thing; it was from a fake video masquerading to be from BBC. (Now that you know it, please do me a favour and don't share that bit out of context . Thanks!)

Both were unrelated and made up news events, but have one thing in common: Both were posted on social media. Out of 8,000 people that Ipsos surveyed from 16 countries with an election next year: 56% rely on social media as their main source of news, more than TV (44%) or news sites (29%). And 85% of people (from the same survey) said they were worried about disinformation's impact on

What do the stats mean?

For starters, they mean more people are relying on a news source that isn't as reliable as a newspaper, or even a TV news channel (whose job you'll see stand-up comedians do better; to understand why, read this YKA article by Jaimine), but is easy to use and gets you the news you'll want (with interest-based targeting). This also means platforms that are designed & used for entertainment now have become main distribution outlets for both trusted news sources and spreaders of disinformation. For example, how do you "like" an post on wars and rising emissions?

With its rising popularity, here's a thing for you to detect: Are social media platforms ideal to be the digital town square of our lives? And what does it mean for journalism?

Problem 1/3: Surveillance Capitalism

(it's as bad as it sounds)
As the primary source of revenue, be it

As the primary source of revenue, be it the video-centric YouTube or the text-based Twitter/X, you'll find ads at the heart of most social media apps you know. If you're hearing about Pixelfed – a decentralized alternative to Instagram – here for the first time, that's because it doesn't rely on ads and doesn't have the billions to compete with mainstay apps. On their own, ads aren't harmful. But social media apps run targeted-ads. For starters, companies track your habits and interests to target you with ads based on them. Say, if you like posts on skin-care, you'll be seeing ads promoting lotions, serum and alike. Where's the harm, you ask?

Targeted-ads also are at the core of a concept called surveillance capitalism, a system where your data is the product for sale, and is obtained via surveilling what you do on and off a platform. The more targeted-ads you see, the more likely you're to purchase something and that equals more money for the social media apps. Along with this data collection comes the risk of data breaches, and constant sharing of data with law enforcement agencies.

enforcement agencies.

As per Shoshana Zuboff, professor emerita at Harvard Business School and the person who coined the term, it's not just about monitoring your habits, but also "actuating" i.e., influencing them. This means social media apps condition our actions with app design that silently nudges us towards doing something that helps their bottom line (even



at the cost of our time and mental health), like Instagram's infinite-scrolling feeds and YouTube's auto-playing videos. Viewing it as a risk to democracy, and your freedom of thought & action in a Q&A with The Harvard Gazette in 2019, she goes on to say:

Long-story short: Ethical business models matter and social media hasn't got one. Should you want to deep-dive into the privacy concerns of surveillance capitalism, you can read this YKA article by yours truly (because yes, it's a whole new Pandora's Box of woes and needs a separate article).

Problem 2/3: The rigged pay-to-play model

If you have ever played a game in the last decade, you may have come across in-app purchases for skins, upgrades and in-game currency. In short, you pay for things that make you win more against those who don't. Social media did a Ctrl+C on this idea, with added real-world implications.

Ever since Facebook and Instagram have gone mainstream, news sources have found themselves relying on them for distribution. And the social media giants have taken note. If you're a small business or a regular poster, you know organic reach has gotten tougher over the years; less than 10% of your own followers will see and like your posts.

Instagram, Facebook and X have already launched their own paid-verification programs, where you pay \$12-15 (to Meta in the EU) or \$8 a month (to X) a month for a tick-mark next to your username and boosted reach. If you run a media company, be ready to shell out a cool \$1,000 per month on X. This not only skews the distribution game – and by extension, the overall conversation on a subject – towards those who can afford to pay for more engagement, i.e., big media houses and companies, but it also violates the 'End-to-End principle'. As the EFF notes, it means:

Hence, instead of seeing posts from friends and handles you follow i.e., the reason you sign up on any social media app, you now see posts that Instagram (like most social media apps) thinks you may like. This control over what you see, listen and understand means social media, once a great "traffic funnel" for news outlets, has also now turned into an uneven pay-to-play field, biased against issues faced by the minority (like religion and caste based discrimination) and those covering them. Lowering the barrier to the verified check-mark also means disinformation gets to go wild, due to the (hot) air of credibility the mark brings, along with increased reach. X already proved it with the ongoing Israel-Hamas war.

Problem 3/3: They are 'psychoactive

That's how Dr. Greenfield, psychologist and founder of the Center for Internet and Technology Addiction in West Hartford, Conn., terms social media apps, while speaking to New York Times.

The best thing about newspapers is, you can pick them up when you want to, and leave them when you don't; you have full control over when you read, what you read and for how much time. And the news that you read aren't targeted at you, based on your interests.

Things are different with a social media app like say, Instagram or YouTube. By design, they imitate slot machines where you're lured in with the promise of a reward every time you open the app or pull to refresh, but you don't know what it is and when you'll get it. Who liked your post this time? Which video will play next? Did Taylor Swift tease her next album? You never know. This makes social media a great way for entertainment when you're feeling tired, but also a terrible way to get your news from (esp. when you're tired). Consuming news should be a voluntary choice and not an impulse-driven one.

Should I consider deleting my social media account?

For most, social media serves some purpose which can be memes, texting people or building networks. If you rely on it for something essential like getting customers for your small business or bringing attention to an issue that traditional news won't cover (like dilution of India's environmental policies), I feel social media's still the way to go. As rigged as the platforms have become, they remain crucial ways to connect with people.

Deleting your account, while rewarding, is

an extreme step to take only if you're willing and able. What you should consider is, an alternative news medium like a newspaper or this little zine I'm working on <insert black moon emoji> as your primary way of being in the know about what's happening. Because as much as a 60-second reel from some influencer would like to explain you the war on Gaza's people, it will inevitably miss out on decades' of crucial context and you deserve to know it before forming opinions.

What's your solution here?

With their core business reliant on surveillance capitalism, companies like Meta and Google have near-zero incentive to work towards user-centric design, one that respects your choices. It's the reason why they're so terrible for your privacy, are so compulsive and as Shoshana terms their model, "an assault on human autonomy."

But what if you could take the youthful design & conciseness of social media, the reliability of a newspaper for critical issues and mix them into one idea? Newspapers are better than social media w.r.t factual accuracy and accountability, but they tend to stick to mainstream issues that assure them readership. If you're learning now that a mega infra project threatens nearly a million (~10 lakh) trees to be cut in Nicobar Islands, and risks displacing indigenous Shompen, Onge & Nicobarese tribes, you now have proof.

This is where Detected, the weekly zine I mentioned earlier, strives to achieve ft. a business model that resists and isn't based on surveilling you wherever you go (which also enables us to cater to your needs, not advertisers'). # Puchka, golgappa, panipuri – is there one original among many doppelgangers?

few weeks ago, I was at a bookshop and asked the proprietor if they had any books on phuchka. "I think you mean panipuri?" he queried, his eyes narrowing. Not wishing to engage in the long and arduous debate that would be necessary to prove him wrong, I smiled politely and nodded. Mollified, he told me how much he enjoyed eating panipuri and then directed me to a magisterial book on Indian cuisine.

A quick browse through the index of the book revealed no references to phuchka. There was, however, a single citation for panipuri – it read "see golgappa". I returned the book to the shelf and decided not to inform the proprietor how the book had relegated his beloved panipuri to the status of a mere synonym. As someone who loved books, he did not deserve to have his heart broken by them.

When I moved from Kolkata to Mumbai in 2010, there were many ways in which this new city felt alien, not least of which was the shift in street-food lexicon. Gone were the days of egg roll, fish fry, and mutton chop being commonplace roadside grub. Instead, the bustling lanes of Mumbai offered vada pay, bhajia pay, misal pay, and if you craved variety, pay bhaji. There was no food item, it seemed, which could escape the pay's embrace.

In the midst of all this bread, the discovery of panipuri had kindled hope. Here was a snack that finally seemed familiar, a snack that resembled its portly cousin from the East and could, perhaps, quell both hunger and home-sickness. I had popped that first panipuri into my mouth, expecting the explosion of flavours that phuchka produced: the tang of lime, the heat of chilli, the lip-smacking piquancy of the water.

Imagine then my consternation, when I realised what looks like phuchka and feels like phuchka does not always taste like phuchka. It was my encounter with its deceitful doppelganger that made me curious about the provenance of phuchka and its many versions so popular across the country. What is their story and which of them can lay claim to being the original?

According to internet folklore, it was Draupadi of the Mahabharata who created this divine dish. During their days of exile, so the legend goes, the Pandavas had to make do with meagre resources and Kunti, their mother, wanted to test her daughter-in-law's frugality. So, she asked Draupadi to conjure a meal out of leftover potato sabzi and a little wheat dough. Knowing that the dough was insufficient to make chapatis for all five brothers, Draupadi graced them, and the world, with her innovative invention: a small, crunchy shell (the deep-fried puri) filled with the sabzi.

This myth has seeped so far into the public consciousness that it even inspired a phuchka-themed Durga Puja pandal in Kolkata. Yet, it is difficult to swallow this story whole – particularly, since Draupadi, Kunti, and the Pandavas would have never set eyes on a potato. The tuber arrived on Indian shores only in the 17th century, courtesy of European traders.

In his book Digesting India: A Travel Writer's Subcontinental Adventures with the Tummy, the humourist Zac O' Yeah refers to an alternate origin story of the panipuri. In medieval times, the Yamuna was believed to be the cause, and carrier, of diseases. It was the royal physician at the imperial court in Delhi, he writes, who came up with the idea of a diet "rich in certain spices" to combat the virulent waters of the river. This disinfectant mix of spices and condiments supposedly birthed the "classic chaat masala" we know and love today.

While attributing medicinal motive to chaat

and phuchka does make this theory more attractive, these tales are likely apocryphal. In fact, if one were to go by the words of renowned academic and food historian, Pushpesh Pant, seeking to locate the place and time of chaat's conception is itself a flawed enterprise. In an interview discussing the history of Indian cuisine, Pant brushed away a question on the antecedents of panipuri as a misguided and fruitless inquiry. Perhaps he is right. Perhaps it is futile to attempt to isolate a single point of origin for such mercurial fare, every element of which is inconstant.

Depending on the state, city or even neighbourhood you find yourself in, you may encounter variances in the type of puri, filling, and water (both flavour and temperature) being used by the local sellers. Manoj Chaurasia, who hails from Varanasi, has been selling chaat in Mumbai for over 22 years. He takes pride in making his own chaat masala – an intricate mix of spices, which is a staunchly guarded secret – and offers rare insight into the subtle regional differences that make street-food so distinctive.

The sweetened water popular with his panipuri-craving customers in Mumbai is made, he tells me, by soaking khajur, or dates. Whereas, in Benares, it is the tartness of imli, or tamarind, that defines the meetha pani, or sweet water, added to the golgappa. Interestingly, the idiosyncratic golgappa water also finds mention in the works of the pioneering food historian KT Achaya, who tantalisingly described it as "cold, fiery pepper-mustard liquid concoction".

Then there is, of course, the matter of the filling – the raison d'etre of the dish.

I had learnt the difference that filling can make when I had taken my first bite of a panipuri. Instead of a fiery ball of mashed potatoes – studded with chickpeas and chopped green chillies, and seasoned with salt, spices, and lime juice – what rested on my tongue was the velvety ragda, a mildly spiced curry of boiled white peas. (In retrospect, it could have been worse. It could have been a filling of moong sprouts). Speaking to me while serving his customers at a street corner in Bandra, Chaurasia confirmed that most of his patrons prefer the ragda. Potatoes, if used, are generally sliced and not mashed, with the spice mix sprinkled on top. It is the way people like it here, he shrugs.

Kurush Dalal, the eminent archaeologist and culinary anthropologist, echoes this last sentiment. In a conversation with me about the origins, history and varieties of panipuri, he describes the puri quite eloquently – and precisely – as "a vessel". As the puri gradually evolved from the kachori, he explains, it was the imagination of the maker, and the appetite of the eater, which dictated the filling it could contain.

Be it potatoes, ragda, or even bhel (a South Gujarat speciality, I am surprised to learn from Dalal), what you can put in a puri depended on what you can sell. The customer, after all, is king and it was the unique tastes of customers across the breadth of this country, that shaped the assorted forms of this delicacy.

As with much else in history, phuchka, too, refuses to be shackled by the notions of purity and cannot be pinned down to a single, original source. Indeed, its many avatars, and the devotion they arouse in their respective fiedoms, mirror the diversity of our nation.

There is a part of me that says I should appreciate this vibrancy; that I should celebrate the cultural milieu that allows so many varieties of this cherished snack to exist; that I should eschew juvenile chauvinism, and learn to treat all the different versions without bias or prejudice. Perhaps one day, I will listen to that part of me. But for now, I would kill to get a decent plate of phuchka in Mumbai. (Courtesy: Scroll.in)

### Pope Francis blasts the weapons industry as he makes a Christmas appeal for peace in the world



ROME, Dec 25: Pope Francis on Monday blasted the weapons industry and its "instruments of death" that fuel wars as he made a Christmas Day appeal for peace in the world and in particular between Israel and the Palestinians.

Speaking from the loggia of St. Peter's Basilica to the throngs of people below, Francis said he grieved the "abominable attack" of Hamas against southern Israel on October 7 and called for the release of hostages. And he begged for an end to Israel's military campaign in Gaza and the "appalling harvest of innocent civilians" as he called for humanitarian aid to reach

those in need. Francis devoted his Christmas Day blessing to a call for peace in the world, noting that the biblical story of the birth of Christ in Bethlehem sent a message of peace. But he said that Bethlehem "is

a place of sorrow and silence" this year.

Francis' annual "Urbi et Orbi" ("To the City and the World") speech typically offers a lament of all the misery facing the world, and this year's edition was no different. From Armenia and Azerbaijan to Syria and Yemen, Ukraine to South Sudan and Congo and the Korean peninsula. Francis appealed for humanitarian initiatives, dialogue and death.

He called for governments and people of goodwill in the Americas in particular to address the "troubling phenomenon" of migration and its "unscrupulous traffickers" who take advantage of innocents just looking for a

He took particular aim at the weapons industry, which he said was fuelling the conflicts around the globe with scarcely anyone paying attention.

'It should be talked about and written about, so as to bring to light the interests and the profits that move the puppet

and security to prevail over violence strings of war," he said. "And how can we even speak of peace, when arms production, sales and trade are on the rise?"

Francis has frequently blasted the weapons industry as "merchants of death" and has said that wars today, in Ukraine, in particular, are being used to try out new weapons or use up old

He called for peace between Israel and Palestinians, and for the conflict to be resolved "through sincere and persevering dialogue between the parties, sustained by strong political will and the support of the international commu-

### At least 68 killed in central Gaza in airstrike, adding to weekend's bloodshed

PDEIR AL-BALAH, Dec 25: At least 68 people were killed by an Israeli strike in central Gaza, health officials said on Sunday, while the number of Israeli soldiers killed in combat over the weekend rose to 15.

Associated Press journalists at a nearby hospital watched frantic Palestinians carry the dead, including a baby, and wounded following the strike on the Maghazi refugee camp east of Deir al-Balah. One bloodied young girl looked stunned while her body was checked for broken bones.

The 68 fatalities include at least 12 women and seven children, according to early hospital figures.

"We were all targeted," said Ahmad Turokmani, who lost several family members including his daughter and grandson. "There is no safe place in Gaza anyway."

Earlier, the Health Ministry in Gaza gave the death toll as 70. The Israeli military had no immediate comment. As Christmas Eve fell, smoke rose over the besieged territory, while in the West Bank Bethlehem was hushed, its holiday bouring Egypt, tentative efforts continued on a deal for another exchange of hostages for Palestinians held by Israel.

The war has devastated parts of Gaza, killed roughly 20,400 Palestinians and displaced almost all of the territory's 2.3 million people.

The mounting death toll among Israeli troops - 154 since the ground offensive began - could erode public support for the war, which was sparked when Hamasled militants stormed communities in southern Israel on October 7, killing 1,200 and taking 240

Israelis still largely stand behind the country's stated goals of crushing Hamas' governing and military capabilities and releasing the remaining 129 captives. That's despite rising international pressure against Israel's offensive, and the soaring death toll and unprecedented suffering among Palestinians. "The war exacts a very heavy price from us, but we have no choice but to continue fighting," Israeli Prime Minister Benjamin



Netanyahu said.

In a nationally televised speech, Israeli President Isaac Herzog appealed for the country to remain united. "This moment is a test. We will not break nor blink," he said.

There has been widespread anger against his government, which many criticize for failing to protect civilians on October 7 and promoting policies that allowed Hamas to gain strength over the years. Netanyahu has avoided accepting responsibility for the military and policy failures.

"Over time, the public will find it hard to ignore the heavy price paid, as well as the suspicion that the aims that were loudly heralded are still far from being attained,

and that Hamas is showing no signs of capitulating in the near future," wrote Amos Harel, military affairs commentator for the Haaretz newspaper.

The Israeli military said it had completed the dismantling of Hamas' underground headquarters in northern Gaza, part of an operation to take down the vast tunnel network and kill off top commanders that Israeli leaders have said could take months.

Efforts toward negotiations continued. The head of the Palestinian Islamic Jihad, Ziyad al-Nakhalah, arrived in Egypt for talks. The militant group, which also took part in the October 7 attack, said it was

hostages only after fighting ends. Hamas' top leader Ismail Haniyeh travelled to Cairo for talks days earlier. Israel's offensive has been one of the most devastating military campaigns in recent history. More than two-thirds of the 20,000 Palestinians killed have been women and children, according to the Health Ministry in Gaza, which does not differentiate between civilians and combatants.

On Friday, Israeli airstrikes on two homes in Gaza killed 90 Palestinians, including dozens from an extended family, according to rescuers and hospital officials. One of the homes, located in Gaza City, became one of the deadliest airstrikes in the war after 76 people from the al-Mughrabi family were killed, said Mahmoud Bassal, a spokesman for Gaza's Civil Defense department

The Palestinian Red Crescent said a 13-year-old boy was shot and killed in an Israeli drone attack while inside al-Amal Hospital in Khan Younis, a part of Gaza where Israel's military believes Hamas leaders are hiding. (AP)

### Beijing sees most hours of sub-freezing temperatures in December since 1951

BEIJING, Dec 25: Beijing recorded the most hours of subfreezing temperatures in December in more than seven decades as a cold wave has enveloped northern and central swathes of China, bringing snowstorms and recordbreaking temperatures.

A weather observatory in the Chinese capital as of Sunday had recorded more than 300 hours of sub-freezing temperatures since Dec. 11 – the most since records began, in 1951, according to the official newspaper Beijing Daily.

The city saw nine consecutive days with temperatures below minus 10 degrees Celsius (14 degrees Fahrenheit), the paper added Parts of northern and central

China have shivered under frigid cold snaps this month, with authorities closing schools and highways several times due to snowstorms

Temperatures at 78 weather stations across the country hit record lows for the month of December, while average temperatures this month in northern and some central parts of China hit record lows set in 1961, according to the National Meteorological Centre.

Thousands join migrant caravan

in Mexico ahead of secretary of

State Blinken's visit to the capital

TAPACHULA, Dec 25: A sprawling caravan of migrants from Central America, Venezuela, Cuba and other countries trekked through Mexico on Sunday, heading toward the U.S. border.

The procession came just days before Secretary of State Antony Blinken arrives in Mexico City to hammer out new agreements to control the surge of migrants seeking entry into the United States.

caravan, estimated at around 6,000 people, many of them families with young children, is the largest in more than a year, a clear indication that joint efforts by the Biden administration and President Andrés Manuel López Obrador's government to deter migration are falling short.

The Christmas Eve caravan departed from the city of Tapachula, near the country's southern border with Guatemala. Security forces looked on in what appeared to be a repeat of past tactics when authorities waited for the marchers to tire out and then offered them a form of temporary legal status that is used by many to continue their journey northward.

"We've been waiting here for three or four months without an answer," said Cristian Rivera, traveling alone, having left his wife and child in his native Honduras. "Hopefully with this march there will be a change and we can get the permission we need to head north.

López Obrador in May agreed to take in migrants from countries such as Venezuela, Nicaragua and Cuba turned away by the U.S. for not following rules that provided new legal pathways to asylum and other forms of migration.

But that deal, aimed at curbing a post-pandemic jump in migration, appears to be insufficient as the number of migrants once again surges, disrupting bilateral trade and stoking anti-migrant sentiment among conservative voters in the U.S.

This month, as many as 10,000 migrants were arrested per day at the U.S. southwest border. Meanwhile, U.S. Customs and Border Protection had to suspend crossborder rail traffic in the Texas cities of Eagle Pass and El Paso as migrants were riding atop freight

Arrests for illegal crossing topped 2 million in each of the U.S. government's last two fiscal years, reflecting technological changes that have made it easier for migrants to leave home to escape poverty, natural disasters, political repression and organized crime

On Friday, López Obrador said he was willing to work again with the U.S. to address concerns about migration. But he also urged the Biden administration to ease sanctions on leftist governments in Cuba and Venezuela — where about 20% of 617,865 migrants encountered nationwide in October and November hail from and send more aid to developing countries in Latin America and beyond.

"That is what we are going to discuss, it is not just contention,' López Obrador said at a press briefing Friday following a phone conversation the day before with President Joe Biden to pave the way for the high level U.S. dele-

The U.S. delegation, which will meet the Mexican president on Wednesday, will also include Homeland Security Secretary Alejandro Mayorkas and White Liz Sherwood-Randall.

Mexico's ability to assist the U.S. may be limited, however. In December, the government halted a program to repatriate and transfer migrants inside Mexico due to a lack of funds.

So far this year, Mexico has detected more than 680,000 migrants living illegally in the country, while the number of foreigners seeking asylum in the country has reached a record 137,000. Sunday's caravan was the largest since June 2022, when a similarly sized group departed as Biden hosted leaders in Los Angeles for the Summit of the Americas.

Another march departed Mexico in October, coinciding with a summit organized by López Obrador to discuss the migration crisis with regional leaders. A month later, 3,000 migrants blocked for more than 30 hours the main border crossing with Guatemala. (AP)

### Death toll goes up to 149 in China's earthquake

BEIJING, Dec 25: The death toll from the 6.2magnitude earthquake that jolted northwest China earlier this week has risen to 149 with two people still missing. The quake, the worst in nine years in the region, struck midnight on December 18 at a depth of 10 kilometres.

The Quake hit Jishishan County, Gansu Province, and Minhe County in the neighbouring Qinghai Province last Saturday causing heavy death and destruction. The death toll in Qinghai Province has risen to 32 while two people are still missing, the Qinghai Emergency Management Department said on Monday. Search for the two missing people was continuing, the department said. The death toll in Gansu Province stood at 117 and 781 people in injured. About 200 people were injured in the Qinghai quake.

Chinese Premier, Li Qing visited the quakehit areas on Saturday and asked the rescue and relief teams to make sure that people live through the winter safely.

So far, about 500 individuals have been discharged from the hospital after receiving treatment, while 282 people remain under treatment. Among them, 17 are in critical condition and 69 are severely injured, according to official media reports, China's National Forestry and Grassland Administration (NFGA) has allocated disasterrelief materials to Gansu and Qinghai which included 1,335 pieces of cold prevention materials and communication equipment, state-run Xinhua

Primary and secondary schools in Jishishan County, northwest China's Gansu Province resumed classes on Monday, state-run CGTN TV reported. The quake was China's deadliest since an earthquake killed 617 people in Yunnan province in 2014. (PTI)

### Police in Serbia fire tear gas at election protesters threatening to storm capital's city hall

BELGRADE, Dec 25: Riot police in Serbia fired tear gas to prevent hundreds of opposition supporters from entering the capital's city council building on Sunday in protest of what election observers said were widespread vote irregularities during a general election last weekend. Serbia's populist President Aleksandar Vucic said it was an attempt to overthrow the government orchestrated from abroad. He said more than 35 people were arrested and more detentions would follow. "This was an attempted violent takeover of the state institutions of the Republic of Serbia," Vucic told the progovernment Pink TV. The country's populist authorities have denied rigging the vote and described the election to fill parliament and local offices as fair. Vucic said Sunday that claims of irregularities in the vote were blatant "lies" promoted by the political opposition.

Vucic suggested the unrest was instigated from abroad but provided no evidence to support the claim. Addressing the nation on state media as the protest took place outside Belgrade city hall, he called the demonstrators "thugs" who would not succeed in destabilizing the state

and said, "This is not a revolution." "They will not succeed," Vucic said. "We are doing our best with our calm and mild reaction not to hurt demonstrators" who came to the event to protest peacefully. Shielded riot police first barricaded themselves inside the city government building, firing tear gas and pepper spray as hundreds of opposition protesters broke windows at the entrance. Later, the police pushed the crowd from the downtown area and made several arrests. The protesters shouted "Open the door" and "Thieves," as they pelted the building with eggs and stones. Some chanted "Vucic is Putin," comparing the Serbian presi-



dent with Russia's leader. Nebojsa Zelenovic, one of the leaders of the opposition Serbia Against Violence alliance, said police officers swarmed all of downtown Belgrade, including the roofs of buildings. The area is home to the national parliament and the presidential headquarters along with the city government.

There were no immediate reports of injuries. Results from the Dec. 17 election showed a victory for Vucic's Serbian Progressive Party in both the parliamentary and Belgrade city ballots. Serbia Against Violence, the party's main opponent, said it was robbed of a win, especially in Belgrade.

"We will continue with our fight," Zelenovic said. An observation mission made up of representatives of international rights watchdogs reported multiple irregularities, included cases of bought votes and the stuffing of ballot boxes.

The observers also noted unjust conditions for opposition candidates due to media bias, an abuse of public resources and the president's dominance during the campaign.

"Police are everywhere, also on the roofs. It is obvious that they do not want to recognize (the) election results. We will continue with our fight," Nebojsa Zelenovic, one of the leaders of the alliance, said. (AP)

### Egypt floats ambitious plan to end Israel-Hamas war as death toll in an Israeli strike rises to 106

Egyptian officials discussed the outline of the proposal with Ismail Haniyeh, the Qatar-based political leader of Hamas, who visited Cairo last week

CAIRO, Dec 25: Egypt has put forward an ambitious, initial proposal to end the Israel-Hamas war with a cease-fire, a phased hostage release and the creation of a Palestinian government of experts who would administer the Gaza Strip and occupied West Bank, a senior Egyptian official and a European diplomat said on Monday.

The proposal, worked out with the Gulf nation of Qatar, has been presented to Israel, Hamas, the United States and European governments but still appeared preliminary. It falls short of Israel's professed goal of outright crushing Hamas and would appear not to meet Israel's insistence on keeping military control over Gaza for an extended period after the war.

Israel's War Cabinet, including Prime Minister Benjamin Netanyahu, will meet later Monday discuss the hostage situation, among other topics, an Israeli official said, but would not say if they would discuss the Egyptian proposal. The official spoke on condition of anonymity because they were not authorised to talk to the media.

Word of the proposal comes as Israeli airstrikes heavily pounded central and southern Gaza, crushing buildings on fam-

In the Maghazi refugee camp, rescue workers pulled dozens more bodies from the wreckage hours after a strike levelled a three-story building and shattered others

At least 106 people were killed, according to hospital records seen by The Associated Press, making it one of the deadliest strikes of Israel's air campaign.

The war has devastated large parts of Gaza, killed more than 20,400 Palestinians and displaced almost all of the territory's 2.3 million people.

The mounting death toll among Israeli troops — 17 since Friday and 156 since the ground offensive began — could erode public support for the war, which was sparked when Hamas-led militants

October 7, killing 1,200 and taking 240

Israelis still largely stand behind the country's stated goals of crushing Hamas' governing and military capabilities and releasing the remaining 129 captives. That's despite rising international pressure against Israel's offensive, and the soaring death toll and unprecedented suffering among Palestinians

EGYPTIAN PROPOSAL

The Egyptian proposal was an ambitious bid not only to end the war but also to lay out a plan for the day after.

It calls for an initial cease-fire of up to two weeks during which Palestinian militants would free 40 to 50 hostages, among them women, the sick and the elderly, in return for the release of 120-150 Palestinians from Israeli prisons, the Egyptian official said. He spoke on condition of anonymity to discuss the ongoing talks.

At the same time, negotiations would continue on extending the cease-fire and the release of more hostages and bodies held by Palestinian militants, he said.

Egypt and Qatar would also work with all Palestinian factions, including Hamas, to agree on the establishment of a government of experts, he said. The government would rule Gaza and the West Bank for a transitional period as Palestinian factions settle their disputes and agree on a roadmap to hold presidential and parliamentary elections, he added.

In the meantime, Israel and Hamas would continue to negotiate a comprehensive "all-for-all" deal he said

This would include the release of all remaining hostages in return for all Palestinian prisoners in Israel, as well as the Israeli military's withdrawal from Gaza and the Palestinian militants' halting of rocket attacks into Israel. Close to 8,000 Palestinians are held by Israel on security-related charges or convictions, according to Pales-

Israel's offensive has been one of the most devastating military campaigns in recent history. More than two-thirds of the more than 20,400 Palestinians killed have been women and children, according to the Health Ministry in Gaza, which does not differentiate between civilians and combatants among the dead.

After Sunday night's strike in the Maghazi camp, first responders and residents searched through the ruble, many with their bare hands or simple tools. The dead continued to flow into Al-Aqsa Martyrs Hospital in nearby Deir al-Balah, where men prayed over several dozen bodies laid out on the ground. Sobbing relatives peeled open body bags to get a last look or kiss the face of a loved one. One man wept as he hugged a body wrapped in bloody plastic sheeting, the size of a small child.

Another man knelt over the body of a relative, screaming, "I swear to God, he was a man. I swear to God, he was better than the whole of Hamas.'

The devastation of the war over the past weeks has brought sporadic eruptions of anger against Hamas, something that would have previously been unthinkable during the group's 16-year rule over Gaza.

Apart from the Maghazi deaths, the bodies of another 80 people killed in strikes across central Gaza were also received at the hospital from late Sunday to early Monday, hospital records showed.

Since Friday, 17 Israeli soldiers have been killed in combat, most in southern and central Gaza - an indication of the heavy fighting in and around the southern city of Khan Younis. "The war exacts a very heavy price from

us, but we have no choice but to continue fighting," Netanyahu said Sunday. There has been widespread anger

against his government, which many criticize for failing to protect civilians on October 7 and promoting policies that allowed Hamas to gain strength over the years. Netanyahu has avoided accepting responsibility for the military and policy failures.

"Over time, the public will find it hard to ignore the heavy price paid, as well as the suspicion that the aims that were loudly heralded are still far from being attained, and that Hamas is showing no signs of capitulating in the near future," wrote Amos Harel, military affairs commentator for the Haaretz newspaper.

In northern Gaza, Palestinians reported heavy Israeli bombardment and gunfire in the urban refugee camp of Jabaliya, an area Israel had claimed to control. The Israeli military said it had completed the dismantling of Hamas' underground headquarters in northern Gaza.

Israel faces international criticism for the civilian death toll, but it blames Hamas, citing the militants' use of crowded residential areas and tunnels. Israel says it has killed thousands of Hamas militants, without presenting evidence.

Israel also faces allegations of mistreating Palestinian men and teenage boys detained in homes, shelters, hospitals and elsewhere during the offensive. The military says it had detained hundreds of Palestinians, including more than 700 who were transferred to Israel for further interrogation about suspected ties to militants. It has denied abuse allegations and said those without links to militants are quickly re-

Speaking from a hospital bed in Rafah after his release, Khamis al-Burdainy of Gaza City said Israeli forces detained him after tanks and bulldozers partly destroyed his home. He said men were handcuffed and blindfolded.

### PMML, a party backed by Hafiz Saeed, fields candidates in Pak

LAHORE, Dec 25: A new political front organisation of the 26/11 terror attacks mastermind Hafiz Saeed has fielded candidates for most of the national and provincial assembly constituencies across Pakistan for the February 8 general elections.

Saeed, the founder of Lashkar-e-Taiba (LeT), has been in jail since 2019 after being convicted for several years in multiple terror finance cases along with some other leaders of the banned Jamaat-ud-Dawa (JuD). The Pakistan Markazi Muslim League (PMML) party - set up by Saeed - says it is a political party. The electoral symbol for the PMML is 'chair'.

In a video message, PMML President Khalid Masood Sindhu said that his party is contesting on most of the national and provincial assembly seats. "We want to come to power not for corruption but to serve the people and make Pakistan an Islamic welfare state," he said. Sindhu is a candidate for NA-130 Lahore, from which Pakistan Muslim League-Nawaz supremo and former prime minister Nawaz Sharif is also contesting.

Saeed's son Talha Saeed is contesting from Lahore's NA-127.

When contacted, Sindhu denied his party's link with Saeed's outfit. "The PMML has no backing of Hafiz Saeed," he claimed on Monday. In 2018, the Milli Muslim League (MML) was the political face of JuD. It had fielded candidates on most seats, especially in Punjab province but failed to win a single seat.

For the 2024 polls, the PMML has been formed because of a ban on the MML.

The US has placed a USD 10 million bounty on Saeed, a UNdesignated terrorist. (AP)

#### Russian shelling kills 4 as Ukraine prepares to observe Christmas

KYIV, Ukraine, Dec 25: Russian shelling in southern Ukraine's Kherson region killed four people Sunday, including an 87-year-old man and his 81-year-old wife who died after a strike on their apartment building. The barrage injured nine other people, including a 15-year-old, sparked fires in homes and at a private medical facility, and set a local gas pipeline alight, the head of the regional military administration, Oleksandr Prokudin, said. "There are no holidays for the enemy," Andrii Yermak, the head of the Ukrainian president's office, wrote on social media commenting on the Kherson attack. "They do not exist for us as long as the enemy kills our people and remains on our land." The shelling across Kherson reached the center of the region's capital city of the same name. The assault took place as Ukraine prepared to officially celebrate Christmas for the first time on Dec. 25, having previously marked the date on Jan 7. Some Orthodox Ukrainians observed Christmas on Dec. 25 last year in response to Russia's February 2022 invasion of Ukraine. The Russian Orthodox Church observes the birth of Jesus on Jan 7. The cathedral in the Monastery of the Caves, a UNESCO World Heritage Site in Kyiv, held its Christmas celebration on Jan 7 of this year, but the service was held in the Ukrainian language for the first time in the 31 years of Ukraine's independence

#### Ukraine says it shot down Russian fighter jets and drones as the country officially marks Christmas

KYIV, Dec 25: Ukraine's air force on Monday reported that it shot down two Russian fighter jets during the night along with two cruise missiles and 28 Shahed-type drones.

The report said the attacks were aimed at southern and central regions of Ukraine, but that no casualties were immediately known. It said that 31 drones were launched in all, but details of what the three that weren't intercepted may have struck weren't given.

A summary from the Ukrainian presidential office said that one civilian was killed and at least four wounded in Russian attacks over the previous 24 The death occurred in the Chornobaivka in the Kherson region, which is partly under Russian control and experiences daily fighting.

Ukraine observed Christmas on Monday, the first time the country has officially marked the holiday on December 25 rather than the January 7 date followed by some Orthodox countries, including Russia. President Volodymyr Zelenskyy signed legislation

in July to move the public holiday's date. Ukraine is predominantly Orthodox Christian, but the faith is divided between two churches, one of which had long affiliation with the Russian Orthodox Church.

The Orthodox Church of Ukraine, which didn't recognise the authority of the Russian church and had been regarded as schismatic, was granted full recognition in 2018 by the Ecumenical Patriarch of Constantinople, Orthodoxy's top authority.

The Ukrainian Orthodox Church, which was a branch of the Russian church, announced in 2022 after the start of the Russia-Ukraine war that it was breaking ties with Moscow and considered itself autonomous. However, its parishes continue to follow the same liturgical calendar as the Russian church and will observe Christmas on January 7. (AP)

### Imran's party to challenge 'flawed' ECP verdict on intra-party polls, electoral symbol in high court

ISLAMABAD, Dec 25: The Pakistan Tehreek-e-Insaf (PTI) party on Monday said that it will challenge the election commission's decision to declare its intraparty polls as unconstitutional and revoke the iconic 'cricket bat' symbol in the Peshawar High Court.

A five-member panel of the Election Commission of Pakistan (ECP) on Friday rejected the organisational elections of Khan's party and its plea to have a cricket bat as the electoral symbol for the general elec-

PTI lawyer and central information secretary Mohammad Muazzam Butt on Monday said the party had decided to approach the Peshawar High Court and file a writ petition on December 26, Dawn newspaper reported.

claimed the ECP's verdict was a "legally flawed" decision. He added the commission had failed to serve justice in its order. The electoral watchdog declared void for the second

time in less than a month the PTI's internal elections in which Barrister Gohar Ali Khan was elected as the party's new chairman. With this decision, Gohar Khan, a close aide of

Khan, 71, lost his position as chairman of PTI, days after his appointment. Khan, a former iconic international cricketer, is syn-

onymous with the cricket bat. He is lodged in Adiala Jail at Rawalpindi facing multiple cases. The ECP declared the party ineligible to obtain an

election symbol to contest the upcoming general elections on February 8 next year. "It is held that PTI has not complied with our direc-

tions rendered therein order dated November 23 and failed to hold intra-party election following PTI prevailing Constitution, 2019 and Election Act, 2017, and Election Rules, 2017," the poll body had said in its 11-

The PTI had termed the decision part of the "fa-



mous London Plan" and a "disgusting and shameful attempt to stop the party from [participating in the]

general elections and maintained that it would appeal the decision at every forum.

It asserted that its candidates would contest the polls with the 'bat' symbol, come what may, Butt on Monday claimed that petitions against the

PTI's internal elections were filed in the ECP based on "malicious intent" and "on orders of some people". "We are not being provided a level playing field and attempts are being made to keep us away from polls,"

the secretary added. Meanwhile, experts have criticised both the poll watchdog as well as the former ruling party for what they called their contradictory behaviour.

Pakistan Institute of Legislative Development and Transparency (Pildat) head Ahmed Bilal Mehboob said Khan's party should have been more careful about its intra-party polls.

"At the same time we have seen the election commission has been soft over many other things," he added. Khan, the PTI founder, had decided to stay away from party elections as it would have invited a legal challenge by his opponents because the ECP disqualified him in the Toshakhana corruption case. ### China to provide consular protection to Vivo employees held in India

BEIJING, Dec 25: China on Monday said it will provide consular protection and assistance to the arrested employees working for China's smartphone maker Vivo in India and expressed its firm backing to the Chinese businesses in protecting their lawful rights and interests.

No incidents were reported as some students played volleyball and soccer on a sunny day. Police "are ready and capable of countering any acts of violence with determination." Ivkovic said.

The country's Serbian Progressive Party has denied rigging the vote and described the elections as fair despite criticism from international monitors and local election observers. President Aleksandar Vucic described Sunday's protests as an attempt to overthrow the government with help from abroad, without specifying what he meant. Serbia's Prime Minister Ana Brnabic thanked Russia late Sunday for tipping off Serbia in advance of violent protests against the election results.

Vucic has "irrefutable evidence" that the West is encouraging the opposition protests, Russian Ambassador Aleksandr Botsan-Kharchenko told Russian media after meeting with Vucic on Monday. In a post on Instagram on Monday, Vucic also referred to "mentors from abroad" of his political opponents leading the protests but offered no other details. Po-



lice officers and state property were "brutally" attacked by those who want to demolish democracy and the election will of Serbia's citizens, Vucic said.

Serbia is formally seeking membership in the European Union, but the Balkan nation has maintained close ties with Moscow and has refused to join Western sanctions imposed on Russia over the full-scale invasion of Ukraine.

Vucic's party claimed victory in both the parliamentary and Belgrade city ballots elections. Serbia Against Violence, the governing party's main contender,

said that it was robbed of a win, especially in Belgrade.

They also noted unjust conditions for opposition candidates because of media bias, abuse of public resources by the ruling party, and Vucic dominating the ruling party's campaign and media time allocated for candidates despite not taking part in the elections himself. ### In year of milestones, SC upholds Art 370, demonetisation

**NEW DELHI, Dec 25:** In a year of milestones, the Supreme Court delivered a melange of seminal verdicts in 2023 including for judgeship of the apex court were approved with alacrity. those that upheld the Centre's decisions to scrap Article 370, which bestowed special status on Jammu and Kashmir, demonetisation of Rs 1,000 and Rs 500 currency notes, and refused to accord legal recognition to same-sex marriages.

Under Chief Justice of India D Y Chandrachud, the top court created a record by disposing of an unprecedented 52,191 cases between January 1 and December 15, 2023. It had disposed of nearly 40,000 cases the previous year.

Though the Modi government received an emphatic endorsement from the Supreme Court for its decisions nullifying Article 370 and binning Rs 1000 and Rs 500 notes, it was at the receiving end of apex court order that held the Delhi government had legislative and executive control over services in the national capital except for public order, police and land.

A five-judge bench of the Supreme Court (SC) unanimously ruled that the appointment of the Chief Election Commissioner and Election Commissioners shall be made by the President on the advice of a committee consisting of the prime minister, the leader of the opposition in the Lok Sabha and the Chief Justice of India. However, these led to the framing of a new law on the appointment of CEC and ECs and amendments to the Government of National Capital Territory of Delhi (GNCTD) Act by the Centre. Now the CJI will not be part of the committee for selecting members of the poll panel as was envisaged in the March 2 judgement of the Supreme Court. Through the new GNCTD Act the Centre also wrested control over services from the Delhi government.

The top court is now again seized of the Delhi government's fresh plea against the amended GNCTD Act.

Notwithstanding the continuing tug of war between the Supreme Court and the Centre over appointment and transfer of judges in constitutional courts on the recommendation of the collegium, the apex court worked with full strength of 34 judges

for judgeship of the apex court were approved with alacrity. The decades-old hope of the queer community for legal validation of their marriages and consequential rights like adoption, enrolment as parents in schools, opening of bank accounts and succession got dashed as a five-judge constitution bench came out with a fractured verdict leaving major issues to the discretion of Parliament.

The Centre also drew flak from the Supreme Court for granting repeated extensions to Sanjay Kumar Mishra as the Enforcement Directorate (ED) chief and held it "illegal".

The Centre won the legal battle over scrapping of Article 370, with a five-judge constitution bench unanimously upholding its decision to abrogate its provisions. The apex court, however, ordered restoration of statehood for the present-day Union Territory of Jammu and Kashmir "at the earliest" and holding the state assembly elections by September 30, 2024.

In a setback to the central government, its curative plea seeking an additional Rs 7,844 crore from the Union Carbide Corporation's successor firms to extend higher compensation to the victims of the 1984 Bhopal gas tragedy that left over 3,000 people dead and caused massive environmental damage was

In one of the cases involving the Adani Group, the apex court reserved its verdict on a PIL on the Adani-Hindenburg row on allegations of stock price manipulation.

The discretionary powers of state governors and legislative assembly speakers in granting assent to bills and deciding disqualification petitions against MLAs, especially in oppositionruled Maharashtra, Tamil Nadu, Punjab, Kerala and Telangana, came under scrutiny by the apex court.

On the police strife between the rival Shiv Sena factions in Maharashtra, the court ruled it cannot reinstate the MVA government headed by Uddhav Thackeray since the Shiv Sena leader chose to resign without taking a floor test in the wake of

a rebellion in his party, paving the way for continuation of Eknath Shinde as the chief minister.

Later in the year, it extended the deadline for Maharashtra assembly Speaker Rahul Narwekar to decide cross-petitions by rival Sena factions seeking disqualification of each other's MLAs from December 31 to January 10, 2024.

The apex court talked tough over the governors of Punjab and Tamil Nadu delaying assent to bills passed by the state legislatures, cautioning the Raj Bhawan occupant in Chandigarh against "playing with fire" and observing his counterpart in Chennai, accused of "sitting over" 12 bills, was a "matter of

The apex court, while taking note of hate speeches at political rallies and religious programmes, said it was looking to put in place a machinery to deal with these.

The year saw marathon hearing of important cases, including on reconsideration of the Supreme Court's 1998 judgement which said lawmakers enjoy immunity from prosecution for taking bribe to make a speech or cast a vote, besides on pleas challenging the remission granted to 11 convicts in the Bilkis Bano gang-rape case and murder of seven of her family members during the 2002 Gujarat riots.

Judgements in these cases are expected in 2024. The apex court will also deliver its verdict on petitions challenging electoral bonds scheme for political funding next year.

Matters related to air pollution during winter in Delhi-National Capital Region also kept the apex court busy. It made hard-hitting remarks and passed directives for curbing the menace. In a first initiative of its kind, the Supreme Court launched a handbook containing a glossary of 'gender unjust terms' and suggested alternative words and phrases which may be used in

According to the handbook, words like eve-teasing, prostitute, and housewife will be out of the legal jargon and be replaced with terms like street sexual harassment, sex worker and

In a bid to make itself litigant friendly, the Supreme Court undertook measures including launch of portal 'SuSwagatam' to enable lawyers and litigants to register themselves online and get e-passes to enter courtrooms. It also onboarded the National Judicial Data Grid, a repository of data on pendency and disposal of cases.

The SC also stepped in to assuage the concerns of those hit by ethnic violence in Manipur and passed a raft of directives, including for setting up a panel of three former women high court judges to ensure that people are protected, rehabilitated and compensated.

Batting for media freedom, it said criticism of government policies cannot be termed "anti-establishment" and quashed the Centre's telecast ban on Malayalam news channel, 'MediaOne'.

On pleas questioning the seizure of electronic devices like mobile phones and laptops of individuals, especially media professionals, by investigating agencies, it asked the Centre to come out with guidelines.

Dealing with cases of anti-terror law, the Unlawful Activities (Prevention) Act, the apex court delivered important verdicts including the one which held that mere membership of a banned organisation was an offence liable to be punished with imprisonment under the provisions of this law.

In another verdict, it held that mere holding of certain literature through which violent acts may be propagated would not attract the provisions of UAPA.

The apex court also dealt with several matters related to animals, including the death of eight cheetahs, translocated from Africa, in the Kuno National Park in Madhya Pradesh.

### Kharge says 'answer may not lie in a discussion', MPs' suspension was premeditated

#### **DHANKHAR-KHARGE LETTER WAR**

NEW DELHI, Dec 25: It was the mass suspension of MPs that was "premeditated" and "weaponised" by the ruling party to sabotage Parliamentary practices, Congress chief Mallikarjun Kharge alleged on Saturday, hitting back at Rajya Sabha Chairman Jagdeep Dhankhar.

Kharge was replying to a second letter on the disruption of parliamentary proceedings and the suspension of MPs by Vice President Dhankhar, who had alleged that the disorder by the

Opposition in the House was deliberate and part of a strategy. In his letter on Saturday, Dhankar had also said, "We need to move ahead", and invited the Leader of Opposition in Rajya Sabha for an interaction on December 25 "or a time of your convenience" at his official residence.

The Congress president, in his reply, said that he agrees with the Chairman that they need to move ahead but stressed that the "answer may not lie in a discussion in the Chairman's chambers, if the government is not keen on running the

The Congress chief said he is currently out of Delhi and it would be his "privilege and duty" to meet the Chairman as

Replying to the points raised by Dhankhar, Kharge alleged that the suspensions were "executed without any application of mind" and said that as the custodian of the House, he should protect the people's right to hold its government accountable in Parliament

The opposition leader alleged that the ruling party has "weaponised the suspension of MPs as a convenient tool to undermine democracy, sabotage Parliamentary practices and throttle the Constitution"

Kharge said the Chairman's letter "unfortunately justifies the autocratic and arrogant attitude of the Government towards

"If anything privilege motions have also been weaponis to muzzle the voice of the Opposition. This is a deliberate design of the ruling dispensation to undermine Parliament itself. By suspending MPs, the government is effectively silencing the voice of the voters of 146 MPs altogether," Kharge said.



"You have also mentioned that disorder was deliberate and strategised and predetermined.

"I would like to submit that if anything, it is the mass suspension of the Opposition MPs from both Houses of Parliament that seems to be predetermined and premeditated by the Government and I am most sorry to say, executed without any application of mind, as can be seen by the suspension of an INDIA party MP who was not even present in the Parliament,' he said

While Dhankhar, in his letter, had said that his attempts to meet the Leader of Opposition were turned down, Kharge said he had sought a statement from the Union Home Minister Amit Shah on the security breach on December 14, before the suspensions started.

"I recognise it is well within your powers as Chairman to decide on these notices. However, it was regrettable that the Chair condoned the attitude of the Hon'ble Home Minister and the Government who did not wish to make a statement on the

ister made his first public statement before a TV channel when Parliament was in session and the Chair did not find that sacrileging the temple of democracy," Kharge alleged. The senior Congress leader urged him to examine his con-

cerns "objectively and with neutrality as the Chairman of the

He said a Union minister allegedly informed an opposition parliamentarian that most opposition MPs "will be suspended before the home minister is present in the Rajya Sabha". "We would have expected the Chairman to have inquired if

such a threat was indeed issued. Such comments grossly undermine the Chair who we believe is the final authority on conducting the House including suspension of members," Kharge

Kharge said as the custodian of the House, the Chairman should protect the people's right to hold its government accountable in Parliament

"The Chairman should also kindly note that the government has escaped accountability on all crucial issues like serious border incursions by China, or continued unrest in Manipur or the recent intrusion in the Lok Sabha by visitors who had been facilitated entry by a BJP MP," he said.

"It would be distressing when history judges the presiding officers harshly for Bills passed without debate and not seeking accountability from the government. "It is disappointing that the Hon'ble Chairman feels effect-

ing suspensions facilitated legislative business by passing bills without discussion," he said. Kharge had on Friday told Dhankhar that the suspension of

MPs on such a large scale was detrimental to the core principles of India's parliamentary democracy. In his letter to Dhankhar, the Congress chief had said he was

pained and agonised at the suspension of so many MPs and felt frustrated and disheartened The Congress president was responding to an earlier letter by Dhankhar in which he had said rendering the House dysfunctional by making a demand to the Chair that cannot be ac-

ceded was unfortunate and against public interest. The Raiya Sabha was adjourned sine die on Thursday, a day ahead of the scheduled end of Parliament's Winter session.

#### Poonch: Army initiates Court of Inquiry as police lodges murder case over killing of 3 civilians

**JAMMU, Dec 25:** The Army has initiated a Court of Inquiry as police lodged a murder case against unknown persons over the death of three civilians picked up for questioning by the force after three soldiers died in a terrorist attack in Poonch recently, official sources said on Monday

In a related development, a brigadier-level officer was shifted and action is being taken against three officers of 48 Rashtriya Rifles as the Army has taken a serious note of the incident which sparked allegations of custodial torture and widespread outrage.

The soldiers lost their lives when their vehicles were ambushed by terrorists at Dhatyar Morh between Dhera Ki Gali and Buffliaz in the Surankote area of Poonch on December 21. Three civilians, aged between 27 and 42, were allegedly picked up by the Army for questioning following the attack and they were found dead on December 22. Video clips purportedly showing their torture were shared widely on social media

In a post on X on December 23, the Additional Directorate General of Public Information (ADGPI) of the Indian Army said, "Search operations by the security forces are continuing in the area of operations after the incident of 21 Dec 23. Reports have been received regarding three civilian deaths in the area. The is of special nature ... special report matter is under investigation. Indian Army stands committed to extending full support and cooperation in said quoting the FIR. (PTI)

#### 3 killed in bustruck collision in UP's Bahraich

BAHRAICH (UP), Dec 25: Three people, including two passengers of a bus, died and 20 others were injured when it collided head on with a rice-laden truck on Monday morning, police said. According to the police, prima facie the accident took place due to dense fog.

Police sources said that truck driver Pappu (50), a resident of Deoria, died on the spot. Bus driver Mahboob (35), a resident of Shravasti, and bus passenger Ram Raj (38), a resident of Gonda, also died on the spot.

They added that 20 passengers of the ill-fated bus were also injured. Circle Officer (City) Rajiv Sisodia said, "Most of the people travelling in the bus are said to be labourers from UP working in Gujarat. Prima facie it seems that due to excessive fog in the morning, the drivers could not see each other. The Bahraich-Balrampur road on which the accident took place is a two-lane road without a divider.

"Had there been dividers, perhaps the accident would not have happened. The driver's sides of both the vehicles collided head on, due to which both the drivers died on the spot," he said. The third deceased. bus passenger Ramraj (24), was a resident of the Gonda district, the CO said.

Bahraich District Magistrate (DM) Monica Rani and Superintendent of Police (SP) Prashant Verma reached the incident site and the district hospital and took stock of relief, rescue and treatment given to the injured. The SP told reporters that the truck was coming from Shravasti to Bahraich and the bus was going from Rajkot in Gujarat to Balrampur. Both the vehicles collided head on near the Dharaswan village on Bahraich-Shravasti road in Kotwali Dehat police station area. (PTI)

The ministers of state with independent charge are Krishna Gaur, Dharmendra Bhav Lodhi, Dilip Jaiswal, Gautam Tetwal, Lakhan Patel and Naravan Singh Pawar.

The other MLAs who took oath as minister of state are Narendra Shivaji Patel, Pratima Bagri, Dilip Ahirwar, and Radha Singh, the official said.

Five women legislators - Sampa-

tia, Uikey, Nirmala Bhuria, Krishna Gaur, Pratima Bagri and Radha Singh - are among those included in the ministry led by CM Yaday.

The total strength of the cabinet has now gone up to 31, including CM Yadav and two deputy chief ministers Rajendra Shukla and Jagdish Devda.

The maximum strength of the council of ministers in Madhya Pradesh, which has 230 MLAs, can be 35, including the CM.

In the state assembly elections held last month, the BJP won 163 seats and the Congress 66.

Yadav took oath as chief minister on December 13 along with Shukla and Devda who were sworn in as deputy CMs. (PTI)

### Pending paddy bonus of ₹ 3.7k cr transferred to 12 lakh farmers in Chhattisgarh

RAIPUR, Dec 25: Chhattisgarh chief minister Vishnu Deo Sai on Monday digitally transferred pending bonus of ₹ 3,716 crore to more than 12 lakh farmers who had sold their paddy in 2014-15 and 2015-16 in cooperative societies under minimum support price. Addressing the function meant to disburse bonus, Sai said his government will fulfil every "Modi guarantee" (ruling Bharatiya Janata Party's pre-poll promise) in the next five years. The event was held in Bendri village of Raipur district to mark Good Governance Day, observed nationwide on the birth anniversary of former prime minister Atal Bihari Vajpayee.

The bonus of ₹ 300 per quintal was not disbursed to paddy farmers by then Raman Singh-led BJP government for Kharif marketing seasons 2014-15 and 2015-16. The previous Congress government under Bhupesh Baghel had promised to disburse this bonus but failed to do so citing some reasons. In its manifesto for the 2023 Assembly polls, which were held on November 7 and 17, the BJP had promised to pay this bonus on December 25 if it came to power in Chhattisgarh.

"We had promised farmers that as soon as the BJP comes to power in the state, we will give the outstanding bonus of two years to them. I am very happy today we have transferred ₹ 3716 crore into the bank accounts of more than 12 lakh farmers". the CM said. The confidence of the farmers of Chhattisgarh on the BJP government and Prime Minister Narendra Modi has increased, Sai asserted. The CM further said his government has decided to provide 18 lakh houses to the poor under Pradhan Mantri Awas Yojna.

"We have made a provision in the recent supplementary budget to give ₹ 1000 per month to married women under Mahtari Vandan Yojna," he said. The promises of annual assistance of Rs 10,000 to landless labourers, recruitment to one lakh government vacant posts in a transparent manner, free treatment upto ₹ 10 lakh under Ayushman Card, procurement of paddy at ₹ 3100 per quintal and tendu leaf collection at ₹s 5500 per standard sack will also be fulfilled, he added. ### Semiconductor policy to help realise Gujarat's commitment towards self-reliance: CM Patel

AHMEDABAD, Dec 25: The 'Gujarat Semiconductor Policy' will help realise the state's commitment for a self-reliant India and Gujarat, Chief Minister Bhupendra Patel has said.

The policy is setting the stage for a future in the world of technology and manufacturing, and helping Gujarat transform itself into a semiconductor powerhouse, he said. According to the state government, chip maker Micron Technology's decision to set up a USD 2.75-billion plant at Sanand near Ahmedabad indicates that Gujarat's dedicated semiconductor policy is bearing fruit and attracting global players.

Under the policy, the state government will set up 'Dholera Semicon City' near Ahmedabad where eligible projects will be given subsidies for setting up manufacturing units, it said ahead of the Vibrant Gujarat Global Summit (VGGS) to

be held in Gandhinagar next month. The summit is a forum for business networking, knowledge sharing and strategic partnerships for inclusive growth and sustainable development.

In June this year, the Gujarat government signed a Memorandum of Understanding (MoU) with the Micron Technology for setting up a semiconductor assembly and test facility at Sanand.

Speaking at a startup event recently on semiconductor policy investment, Union Minister of State for Skill Development and Entrepreneurship Rajeev Chandrasekhar said, "(Prime Minister) Narendra Modi ji in January 2023 enacted a

policy. We have these big units and plants like Micron coming up in Gujarat.

"There are over 30 design startups that have come up. We are going to set up a new Indian semiconductor centre for research," he said.

The policy has been designed in line with the Centre's 'India Semiconductor Mission' to attract and facilitate new projects in the sector, the government said in

a release. To encourage investments, a 75 per cent subsidy is offered on the purchase of first 200 acres required for setting up manufacturing units, with additional land provided at 50 per cent subsidy, the state

government said. Eligible projects under this policy enjoy a power tariff subsidy of Rs 2 per unit for a decade and good quality water at a rate of Rs 12 per cubic metre for the first five years, with additional incentives for projects with significant foreign direct investment or those relocating from overseas locations, it said. #### Delhi HC refuses to direct TRAI to

TRAI was established for the purpose of regulating telecom services to protect the interest of the service providers and consumers in the telecom sector, and to promote and ensure an orderly growth of the sector. The court noted that "information" under the RTI Act includes any information relating to any private body, which can be accessed by a public authority under any other law for the time being in force.

The high court had, in August 2021, stayed the single-judge order, saying irreparable damage will be caused

if the same was not done. Lawyer Kabir Shankar Bose had filed an RTI application seeking information and details on whether his phone was being tapped and by which agency.

The telecom regulator had said directions to intercept a phone number are issued only by government officials of certain ranks and such information cannot be collated by it and furnished to a consumer or subscriber as it would "prejudicially affect the sovereignty and integrity of the nation". Bose had moved the CIC after his telecom service provider, Vodafone, declined his request for information

on whether his phone was being tapped. The company had claimed that it did not come under the ambit of the RTI Act. Bose had then moved the

TRAI, which said it did not have the information he had asked for. The CIC, in its September 12, 2018 order, asked the TRAI to obtain the information from the telecom com-

pany and provide it to Bose.

The TRAI challenged it in the high court and the single judge, on November 20, 2018, upheld the CIC's decision, saying the TRAI has the powers to call for any information or conduct an investigation where it considers

The single-judge order also said the TRAI does have the obligation to get the information from the private body and furnish it to the subscriber. (PTI)

**NEW DELHI, Dec 25:** A Special Court has convicted a former Indian Air Force Squadron Leader for allegedly moving funds for a former Congress MP for a land deal and amassing disproportionate assets worth ₹ 40.36 lakh, officials said Monday.

Squadron Leader Polu Sreedhar, facing several health issues, was not given any respite by the court, which convicted him for amassing assets that could not satisfactorily be accounted for, they said.

The special court will start hearing arguments on the quantum of the sentence from January 2 next year, they said.

In its FIR, the CBI had alleged that from January 1, 2007, to December 31, 2010, deposits worth ₹ 11.9 crore were made in his three accounts in Axis Bank.

MP Balashowry which were received in the three bank accounts of accused Polu Sreedhar and later on withdrawn, but is concerned with the excess amount of ₹ 40,36,560 only as shown in Statement 'B'," the Judge has

The Judge observed that according to the charge sheet the lands were purchased by Bal-"from his own money" and Saxena "simply opened the accounts" of Sreed-

no evidence found that Mr. Balashowry or Mr Manish Saxena abetted the offence" of alleged criminal misconduct under Section 13 (2) of the PC Act committed by the former Air Force officer.

"(A) Public servant is bound to disclose his assets and income as per service rules to his employer and cannot be allowed to convert black money of someone else into white through his own account.

"Presumption can be raised in view of the above facts and circumstances that the money lying in his account was either the part of ill-gotten money of ex MP Balaswory or was wrongfully earned specially when he is unable to account for the same by leading any evidence that it was earned through share or property dealing as well as the fact that he did not disclose about it to his employer and the income tax

authorities," the court noted. The court said that mere fact that the probe agency has not investigated the source from where this money came in the bank account of the accused itself does not discharge the onus lying upon the accused under the Prevention of Corruption Act.

"Mere fact that accused is not keeping good health and undergoing dialysis twice a week or is suffering some other medical problems itself is not a ground to acquit him," it said.



### Rohit's men gear up to end 31-year wait for series win in South Africa

CENTURION, Dec 25: He endured the heartbreak of a lifetime 36 evenings back but Rohit Sharma will give his all to erase the memories of a World Cup final defeat as he trains his eyes on ending India's 31-year wait for a Test series win on South African soil.

The two-match Test rubber, starting here on the Boxing Day, will be India's ninth away series in the Rainbow Nation since 1992, and captain Rohit will have an onerous task of traversing a difficult terrain in order to conquer what has always been dubbed the team's 'final

However, for the action to start at Supersport Park, the heavy rains predicted on the first two days need to subside. The Centurion track offers variable bounce and is one of the fastest in the region. And that makes up for a compelling contest between bat and ball in relatively cooler and windy conditions in an open ground where it can jag around a bit.

In the last 50 over World Cup, skipper Rohit, at best would have emulated Kapil Dev and Mahendra Singh Dhoni, but if he and his men manage to pull off a coup in this country, he would stand first among the equals.

Mohammed Azharuddin (1992) failed, so did Sachin Tendulkar (1996) and Sourav Ganguly (2001). Rahul Dravid (2006-07), Dhoni (2010-11 and 2013-14) won Test matches, and so did Virat Kohli (2018-19 and 2021-22) but none of them could win the elusive series in South Africa.

So Rohit will have a job at hand and a win might just be the muchneeded soothing balm required to heal the World Cup wounds even though the scars will remain.

"We encourage the players to play (in a manner) they feel most comfortable. In the end they are judged by the results they produce. They know that," Dravid said. But that freedom comes with a

"We want to encourage them in the way they play but also keeping the conditions in mind and certain, sort of tactical thing they have to adopt when they play in South

"The nature of ball, how it behaves over 80 overs, shots that they play early and later on. I think it's

about finding balance between having cricket smarts to read the game and understand the situation, and of course allowing to express your-

"Hopefully, they make smart decisions," the coach had said on Christmas eve.

But all said and done, India's performance will depend on three factors: how well the skipper executes his hook and pull shots, for how much time Virat Kohli decides to leave balls outside the off-stump, and how well the team covers up Mohmmed Shami's absence.

The skiddy Mukesh Kumar looked better at the nets but the extra bounce available makes a case for Prasidh Krishna.

Bavuma, the retiring Dean Elgar, the stylish Aiden Markram, the exciting Tony de Zorzi, and the dogged Keegan Petersen constitute a good batting unit that can make Indian bowlers toil hard.

KL Rahul donning the big gloves is another aspect of this game. The team management handing over keeping responsibilities to Rahul can be viewed from two different

The positive one would be the faith in his ability as a glovesman in 50-over cricket and hoping that he can do it for 90 overs in a day.

The not-so-positive aspect will be the sheer desperation not to lose that extra batter in Iyer and also not looking at the bigger picture that Rahul could find it extremely difficult to stand up to Ravichandran Ashwin and Ravindra Jadeja in a month's time against England at home, provided Ishan Kishan isn't back from his mental health break.

It will be another away Test match which Ashwin might have to miss because of conditions and combinations.

At Supersport Park, it normally takes three and half to four days to achieve results and if the toss happens on the second day, after a washout on opening day, batting first will surely be a very difficult proposition.



KARACHI. Dec 25: Pakistan Cricket Board has appointed former allrounder, Yasir Arafat as the high performance coach of the national team for next month's fivematch T20 series against New Zealand.

Yasir will reach Lahore from London and will leave with the Pakistan white-ball players for New Zealand where five matches are scheduled from January 12.

The Pakistani selectors have already announced a 17-member squad for the T20 series in New Zealand which is seen as a preparation for the ICC World Cup in West Indies and USA next year.

Yasir, who had applied for the post of bowling coach earlier this year when the PCB had approached Mickey Arthur to take over as head coach, is a qualified coach and has worked in New Zealand and England.

A source said that Yasir will replace Simon Helmut, who is the high performance coach of the Pakistan team for the ongoing Test series in Australia.

"Yasir's appointment came about on the recommendation of the national team's director Muhammad Hafeez who is calling the shots in Australia even above captain, Shah Masood," the source said.

Yasir, who appeared in three Tests and some white ball games for Pakistan, was a member of the squad that won the ICC World T20 in England in 2009.

This will be the fifth appointment of a coach with the Pakistan team since Hafeez was named Director of the team.

Hafeez has seen the appointments of Umar Gul and Saeed Aimal as the team's fast and spin bowling coaches and then the short term appointments of Adam Hollioake and Simon Helmut as batting coach and high performance coach of the team in Australia for the three-Test series.

RIO DE JANEIRO, Dec 25: FIFA warned Brazil on Sunday it could suspend its national teams and clubs from international competitions if an intervention by its soccer body leads to the election of a new president

FIFA said in a letter to a Brazilian soccer executive that the country's soccer body CBF could face suspension if it does not heed its call to wait and instead holds a swift election to replace Ednaldo Rodrigues as president regardless. The document was obtained by The Associated Press.

A Rio de Janeiro court removed Rodrigues and all his appointees at CBF from office on Dec. 7 due to irregularities in his election last year. Brazil's two highest courts upheld that ruling last week.

Soccer's governing body FIFA historically rejects government and third-party interference in its member associations, which ultimately could leave five-time World Cup winners Brazil out of major competitions until the crisis is solved.

The Rio court ruling also named José Perdiz, the head of Brazil's top sports court, as an intervener to organize new elections for the presidency within 30 working days. FIFA said in previous letters to CBF it considers the intervention to be undue.

Sunday's letter was signed by FIFA's Kenny Jean-Marie, its chief members' association officer, and CONMEBOL's deputy secretary-general, Monserrat Jiménez Garcia. FIFA and South American soccer body CONMEBOL also said in the letter they will



form a commission to discuss the matter in Brazil on Jan. 8.

"FIFA and CONMEBOL would like to strongly emphasize that, until such mission takes place, no decision affecting CBF, including any elections or call for elections, shall be taken. Should this not be respected, FIFA will have no other option but to submit the matter to its relevant decision-making body for consideration and decision, which might also include a suspension," the letter said. "For the sake of good order, we would also like to underline that should CBF be eventually suspended by the relevant FIFA body, it would lose all of its membership rights with immediate effect and until the suspension is lifted by FIFA. This would also mean that CBF representative and clubs teams would no longer be entitled to take part in any international competition while it is suspended," it added.

The document also says that any irregular

interference in its member associations "can lead to sanctions as provided for in the FIFA Statutes, including a suspension, and this even if the third-party influence was/is not the fault of the member association con-

Perdiz said in a statement he sees FIFA's letter "as a positive sign." He also added he will "call for the elections within the established deadline, with the transparency and integrity that are demanded."

Spokespersons for Rodrigues did not respond a request for comment from the AP.

Rodrigues first took the job as interim president in 2021 after predecessor Rogério Caboclo was suspended. Local media reported he is currently in negotiations with other Brazilian soccer executives to either bid again for the presidency in new elections or to support another candidate.

Rodrigues' term in office runs through 2026. He is yet another CBF president to face legal problems in recent years, though he is not involved in corruption cases like predecessors Ricardo Teixeira, José Maria Marin and Marco Polo del Nero.

Caboclo was suspended from the presidency in September 2021 in connection with a sexual harassment case at the CBF, which opened the path for vice presidents to elect Rodrigues as the first Black president of the soccer body. The ruling against the 69-yearold Rodrigues could hurt Brazil's bid to host the Women's World Cup in 2027 and his quest to hire Real Madrid coach Carlo Ancelotti to

They began the second half with similar urgency, Gomes hitting a shot that nicked off Lesley Ugochukwu and grazed the post before defender Toti got forward from the back and drew an outstanding point-blank save from Chelsea's stand-in goalkeeper Djordje Petrovic.

It was a warning the visitors did not heed and the goal moments later was an almost carbon copy of Toti's chance. (AP)

# Ratcliffe wants struggling Man United back at the top of English and European soccer

billionaire Jim Ratcliffe has finally got his hands on Manchester United after securing a stake of up to 25% in the Premier League club. Ratcliffe's interest in sports — and soccer in particular — is longstanding. The 71-year-old owner of petrochemicals giant has been a United fan since childhood, and supporters will like his stated am-

"We all want to see Manchester United back where we belong, at the very top of English, European and world football," Ratcliffe said Sunday after a deal, subject to Premier League approval, was confollowing firmed lengthy negotiations with the Glazer family, United's American owners.

The announcement comes after moves elsewhere in European soccer that could have seen Ratcliffe take control of one of United's main Premier League rivals as recently as last year

Ratcliffe, one of the richest people in Britain, had initially looked to buy the Glazers' controlling stake of around 69%, but eventually agreed to become a minority shareholder.

He had to see off competition from Oatari banker Sheikh Jassim bin Hamad Al Thani, who withdrew in October from the bidding process after failing to agree a deal for a complete takeover.

Ratcliffe made a surprise late bid for Premier League club Chelsea in 2022, despite not being involved in a months-long bidding process.



A consortium led by Todd Boehly and Clearlake Capital had already seen off competition from the likes of Chicago Cubs to enter exclusive talks to buy out former Chelsea owner Roman Abramovich when Ratcliffe made his move.

Despite his long-standing support of United being well-publicized. Ratcliffe was adamant his interest was serious.

"We are British and have great intentions for Chelsea," he said at the time. Ultimately his bid came too late to disrupt Boehly and Clearlake's takeover.

Later that year, Ratcliffe let it be known that was interested in buying United as rumors of a Glazer sale surfaced.

He then altered that stance.

Americans' stake. While Ratcliffe is tasked with helping to make United competitive again in the Premier League a competition it once utterly dominated — his Nice side is impressing in the south of France.

Ratcliffe completed the takeover of Nice four years ago. After some inconsistent seasons. Nice, under its philosophy-studying Italian coach Francesco Farioli, is challenging defending champion Paris Saint-Germain.

Nice is second in the French league, five points behind leader PSG after 17 rounds.

So Nice can realistically target second place and an automatic spot in next season's Champions League.

But that could be problematic. UEFA rules in place for more than 20 years do not allow two clubs where the same owner has "decisive influence" on how they are run to both enter European competitions if they could cross paths at any point in the season.

If both teams qualify for the Champions League, priority goes to the team which finishes higher in its domestic league. On current form, that is Nice.

Ratcliffe's first entry into soccer club ownership was Lausanne-Sport in 2017. INEOS already was a sponsor of its local club in Switzerland where it had moved parts of the business in 2010.

INEOS management's stated ambitions for the top-tier Swiss club were to qualify for European competitions and work with youth academies in Africa. Its first player signing was soccer great Zinedine Zidane's son, Enzo.

Lausanne is currently 10th in what is now a 12-team league.

Ratcliffe has also successfully ventured into the world of cycling. Back in 2019, the mighty Team Sky became Team INEOS (and later INEOS Grenadiers) after a

### Pochettino unfazed by Chelsea disciplinary record

"Palmer is playing for us his first season as a regular. It's normal. The players care, they want to win, they are frustrated," Pochettino said. "It's not discipline. We need to have more the capacity to read the situation of the game."

Chelsea has already seen suspensions for Reece James, Malo Gusto and Conor Gallagher after being sent off earlier in the season, while summer signing Nicolas Jackson is only two bookings. short of 10 for the campaign and a further two-match ban, having also been suspended in Septem-

Pochettino also pointed toward injuries as a contributing factor in his team's overall struggles, with at least eight players unfit for the meeting with Palace at Stamford Bridge. Chelsea is 10th in the league, five places higher than Palace (AP)

tic note earlier this year. Having won the first round in dominant fashion, Jaismine seemingly had a brain fade moment after she was given a warning, with referee eventually forced to stop the 60kg quarter-"I was given a warning, counting for the first time. So, I was not able to handle it.

My mind just went blank. It is important to know how to come back from such a situation which I didn't," Jaismine told PTI after winning her quarterfinal bout at the National Championships here on Monday.

A win would have not only fetched her a medal but also a Paris Olympics quota. "After that Asian Games bout, coaches

told me to work on the mental aspect. I am working with a psychologist. He has told me to work on visualisation and do meditation," she added. The 22-year-old cruised to the National

Championships semifinal in the 60kg category, which is one of the two women's weight classes where India is yet to seal a quota. A top-three finish at the Nationals



will ensure a return to the national camp for Jaismine, where she has been a regular for the past two years.

Jaismine has come a long way since competing in her debut World Champi-

onships in 2022. From someone who used to only counterattack, she has learnt to be the aggressor.

"There has been progress, I am learning a lot of things, I try and work on my weak-

nesses. My game is getting better with time. Par ek dum se nahi aa raha, time lag raha hai (I am not able to win medals, it's taking time)," rued Jaismine

"Mera quarterfinal mei reh jata hai (I

added, having lost in the last-eight stage both in the World Championships and the Asian Games.

Last year, Jaismine had become the first female boxer to be inducted into the Indian Army. At the Services camp, she trains and spars with male boxers to increase the power of her punches.

"I am working on my mistakes from before. I prefer back-peddling but my Services coaches tell me to not just rely on that and go ahead and attack.

"I train with the boys during the Services camp. It improves my game and strength. There are only three girls in the camp, so coaches pay a lot of attention to what we should do and should not do."

Under Boxing Federation of India's (BFI) new selection process, Jaimsine had always topped the charts in the 60kg weight division. "Dimitry (Dmitruk) sir and Bernard (Dunne) sir also tell me to connect punches and go ahead and attack and build pressure. At the same time, be ready for counter attack," she adds.

The top-three boxers in 60kg will move to the national camp where they will undergo an assessment, based on which a pugilist will be selected for the next Olympic qualifier, which is slated to take place in Busto Arzizio, Italy from February 29 to March 12. (PTI)
