'Availability of weapons a big challenge' Arabinda confident of resolving Myanmar instability, weapons with Manipur groups key issues in restoring peace: Lt Gen Kalita

KOLKATA, Dec 27: Eastern army commander Lt General RP Kalita on Wednesday said the availability of a large number of firearms with the warring groups in Manipur and instability in Myanmar leading to influx of people from the neighbouring country are the key challenges in restoring peace in the strife-torn Northeastern state.

Kalita said till the time firearms are available with members of the warring Kuki and Meitei communities, the situation can flare up any time.

"The availability of weapons with both the communities, whether stolen from Manipur police armoury or obtained from Myanmar, continues to pose a challenge," general officer commanding-in-chief, Eastern Army Command, Lt General RP Kalita, who is set to retire on December 31, said during a media interaction

Besides Rajkhowa, other senior members of the delegation comprises the outfit's foreign secretary Sasadhar Choudhury, finance secretary Chitrabon Hazarika, cultural secretary Pranati Deka, deputy commander-in-chief Raju Barua, among others.

Himanta orders probe into suicide of youth allegedly linked to Jorhat grenade blast

HT Bureau GUWAHATI, Dec 27: Chief Minister Himanta Biswa Sarma has ordered a high-level inquiry into the suspected suicide of 24-year-old Dipankar Gogoi from Titabor town in Jorhat district.

Gogoi, who was picked up by the police for questioning in connection with the grenade explosion near an army camp in Jorhat on December 14, was found hanging from a tree on Tuesday

The deceased's family alleges that Dipankar took the extreme step due to the police torture he reportedly endured during recent interrogations

'The Government of Assam will institute an additional chief secretary-level inquiry into the death of Mr Dipankar Gogoi, son of Mr Khagen Gogoi, from GariKuri Brinasayak Gaon, Titabar on 26/12/23. The inquiry will be concluded within 30 days," the chief

minister wrote on micro-blogging site X.

Meanwhile, Jorhat superintendent of police ML Meena has denied any mistreatment during Gogoi's police questioning at Titabar police station, emphasising that Gogoi, while not directly connected to the blast, had indirect links.

Meena revealed that Gogoi was implicated in arms smuggling, having recently acquired a pistol from Sanjiv Baruah, involved in a shooting incident at Lichubari a month ago.

Several organisations protested at Titabar police station, decrying alleged police torture and harassment of youths connected to ULFA-related grenade blasts in upper Assam.

HT Bureau GUWAHATI, Dec 27: In a significant step towards fulfilling its promise of job creation, Assam education minister Ranoj Pegu has announced the recruitment of 14,223 school teachers statewide. In a series of posts on microblogging site X, on Wednesday, Pegu said the Directorate of Secondary Education has released the advertisement for 1,424 postgraduate and 7,249 graduate

teachers. "Directorate of Secondary Education has released an advertisement for recruitment of 1424 Post Graduate Teachers and 7249 (1) Graduate Teachers (Arts), (2) Graduate Teacher In the 10 years of his govern-(Science), (3) Graduate Teachers (Hindi) and (4) Graduate Teacher (Sanskrit) of the different Provincialised Secondary Schools," Pegu wrote on X.

Simultaneously, the Directorate

of Elementary Education has advertised 3,800 Assistant Teachers for Lower Primary (LP) Schools and 1,750 positions for Assistant Teachers, Science Teachers, and Hindi Teachers in Upper Primary (UP) Schools.

Reacting on the same, Assam chief minister Himanta Biswa Sarma expressed confidence, and said, "Today, our government has released vacancies for over 10,000 posts in the education department. We will not only deliver but exceed our promise of creating more than 1 lakh government jobs in the most transparent manner in Assam's history."

It is worth mentioning that this move follows the BJP's commitment during the 2021 assembly polls to provide one lakh government jobs annually in Assam, however, the party later clarified that the target was for the entire five-vear tenure.


Union minister asks public to enroll for welfare schemes

NEW DELHI, Dec 27: Asserting that many patients are deprived of liver, kidney or other transplant due to non-availability of organs, President Droupadi Murmu on Wednesday said there was a need to organise more and more awareness campaigns on a larger scale to encourage people about organ donation.

Addressing the ninth convocation of the Institute of Liver and Biliary Sciences (ILBS) here, the President suggested that more attention should be paid to preventive healthcare.

"It can be said that liver is the security guard of our body. Health problems related to liver are serious in our country and the huge number of diseases caused by them is a cause for worry," Murmu said.

Suspecting 'possible terror attack', Israel issues travel warning for India

JERUSALEM, Dec 27: The Israeli National Security Council has issued a travel advisory for its citizens in India, suspecting that an explosion near the Israeli embassy in New Delhi on Tuesday was "a possible terror attack"

No one was injured in the blast that occurred near the Israel embassy in the Chanakyapuri diplomatic enclave in New Delhi on Tuesday evening.

When contacted, Israeli embassy spokesperson Guy Nir said, "We can confirm that around 5:48 pm, there was a blast in close proximity to the embassy. Delhi Police and the security team are still investigating the situation."

The recommendations of the Israeli National Security Council (NSC) on Tuesday, which come amid concerns of a "recurrence of events", apply especially to New Delhi

Israeli nationals have been warned to try to avoid going to crowded places (malls and markets) and places identified as serving Westerners/Jews and Israelis.

They have also been urged to be on heightened alert in public places

India-Russia relations reflect geopolitical realities and strategic convergence: Jaishankar



MOSCOW, Dec 27: India-Russia relations reflect geopolitical realities, strategic convergence and mutual benefit, external affairs minister S Jaishankar said Wednesday as he held a wide-ranging and "useful" meeting with his Russian counterpart Sergey Lavrov here during which they discussed the international situation and contemporary issues.

Jaishankar, who is on a five-day visit to Russia, and Lavrov also exchanged views on the Indo-Pacific region, the Ukraine conflict, the Gaza situation, Afghanistan and Central Asia, BRICS, Shanghai Cooperation Organisation, G20 and the UN.

"A wide-ranging and useful meeting with FM Sergey Lavrov of Russia. As strategic partners, discussed the international situation and contemporary issues," Jaishankar said in a post on X.

He noted the progress in bilateral economic cooperation, energy trade, connectivity efforts, militarytechnical cooperation and people-to-people exchanges. "Signed Protocol on Consultations for the period 2024-28. India-Russia relations reflect geopolitical realities, strategic convergence and mutual benefit," he said. Sensex scales 72k peak for first time; Nifty hits all-time high



MUMBAI, Dec 27: Sensex and Nifty soared to fresh closing record highs on Wednesday, with the 30share benchmark index crossing the historic 72,000 mark, boosted by optimism over the country's macroeconomic fundamentals and firm global market trends.

Reflecting broader investor bullishness, the 50-share index surged to a record high of 21,654.75 on intense buying in metal, commodity, auto and banking sectors.

Rising for the fourth straight session, the BSE gauge jumped 701.63 points or 0.98 per cent to settle at its all-time closing high of 72,038.43. During the day, it zoomed 783.05 points or 1.09 per cent to reach its intra-day lifetime high of 72,119.85.

The Nifty climbed 213.40 points or 1 per cent to settle at a record high of 21,654.75. During the day, it rallied 234.4 points or 1.09 per cent to reach its all-time intra-day peak of 21,675.75.

"The upbeat domestic market continued reaching a new record high and easily recovered the last week's losses. This upward trend was predominantly supported by the Santa Claus rally in anticipation of early rate cuts by the US Fed and cooling global inflation," said Vinod Nair, head of research at Geojit Financial Services.

UltraTech Cement was the biggest gainer on the Sensex chart, rising 4.23 per cent, followed by JSW Steel, Tata Motors, Bharti Airtel, State Bank of India, Larsen & Toubro, Infosys and Bajaj Finserv were the major gainers.

On the other hand, NTPC and Tech Mahindra were the laggards. In the broader market, the BSE midcap gauge climbed 0.41 per cent, and smallcap index advanced 0.20 per cent.

Among the indices, metal

jumped 1.33 per cent, auto climbed 1.33 per cent, commodities (1.19 per cent), teck (0.96 per cent), IT (0.68 per cent), consumer durables (0.67 per cent) and capital goods (0.67 per cent).

Utilities, power and services were the laggards.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled with gains.

European markets were mostly trading in positive territory. The US markets ended in the green on Tuesday.

"After a brief midweek panic last week, bulls are back with a bang, albeit with some caution. India VIX has touched a new high in a multi-month time frame, indicating the possibility of some volatility as we approach the monthly expiry.

"FII's have been buyers in the last couple of sessions in Index options while they continue to stay long in the index futures segment. Banks have been a bit late to this party but now seem ready to break out from the current range. PSU Banks are the strongest while private banks are expected to play catch up," Rahul Sharma Director, Head- Technical & Derivative Research, JM Financial Services, said

Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 95.20 crore on Tuesday, according to exchange data.

TotalEnergies, holds about 19.75 per cent stake in AGEL TotalEnergies invests USD 300 million in joint venture with Adani Green Energy

NEW DELHI. Dec 27: French energy giant TotalEnergies has invested USD 300 million (about ₹ 2.500 crore) in a renewable energy joint venture with Adani Green Energy Ltd as it continues to repose faith in the conglomerate run by billionaire Gautam Adani. The Adani group firm and the French giant will own 50:50 stake in the company which in turn will house a 1,050 MW project portfo-

lio. "TotalEnergies has acquired a 50 per cent stake in Adani Renewable Energy Nine Ltd (ARE9L) for an amount of USD 300 million,' Adani Green Energy Ltd (AGEL) said in a stock exchange filing. ARE9L is a subsidiary of

AGEL The 1,050 MW project portfolio includes 300 megawatts (MW) of operational capacity, 500 MW of under-construction solar projects and 250 MW of under-development projects.

TotalEnergies, which holds about 19.75 per cent stake in AGEL, had previously invested in Adani Green Energy Twenty

Three Ltd, another subsidiary of AGEL.

"As per the valuation report dated November 27, 2023 obtained from Mazars Advisory LLP, an independent valuer, the aggregate valuation of the project portfolio companies is equivalent to USD 489 million," AGEL said in a notice to shareholders seeking approval for the TotalEnergies deal

"As part of the transaction, TotalEnergies will acquire a 50 per cent stake in ARE9L, which will house this Project portfolio companies, for an amount of USD 300 million which are terms more beneficial to the company (AGEL)." Upon the under-construction

and under-development projects achieving commercial operations, TotalEnergies will also invest an additional amount to be determined based on actual project cost subject to certain parameters around the project cost and timelines.

"Such further funding by Total-Energies will be over and above the initial investment of USD 300



million and will be subject to suitable approvals as may be required," it added.

The French firm infused an amount of Rs 4,013 crore into AGE23L by subscribing to compulsorily convertible debentures issued by AGE23L, which have been used to redeem the existing non-convertible debentures held by TotalEnergies.

'The (Wednesday's) transaction also reinforces the strategic alliance between the company tween AGEL and TotalEnergies in September 2023.

The JV houses the 1,050 MW portfolio comprising a mix of already operational (300 MW), under-construction (500 MW) and under-development assets (250 MW) with a blend of both solar and wind power projects in India. "With this transaction, TotalEn-

ergies has reinforced its strategic alliance with AGEL and support in enabling AGEL's target of 45 GW capacity by 2030," it said.

AGEL develops, owns, and operates utility-scale grid-connected solar, wind, and hybrid renewable power plants and has an operating renewable portfolio of 8.4 gigawatts (GŴ).

On December 26, AGEL announced that its board has approved the promoter's plan to infuse Rs 9,350 crore into the company by investing in warrants of the company. This, together with a debt worth USD 1.4 billion raised earlier this month, takes the total funds raised by the company to USD 3 billion. (PTI)

Progress of Banking in India 2022-23' released by the RBI, the Indian banking system and NBFCs remain sound and resilient, backed by high capital ratios, strengthening asset quality and robust earnings growth. The consolidated balance sheet of sched-

uled commercial banks (SCBs) in 2022-23 expanded by 12.2 per cent, driven by credit to retail and services sectors. Deposit growth also picked up, although it trailed credit growth, it said.

prices rose ₹ 100 to ₹ 63.850 per 10 grams in the national capital on Wednesday amid a bullish trend in the global markets, according to HDFC Securities.

In the previous close, the precious metal had closed at ₹ 63,750 per 10 grams.

However, silver plunged ₹ 350 to ₹ 79,100 per kilogram, while it had finished at ₹ 79,450 per kg in the previous trade.

Saumil Gandhi, senior analyst of commodities at HDFC Securities, said gold prices edged higher on Wednesday, in the Delhi markets trading at ₹ 63,850/10 grams, up by ₹ 100 following a bullish trend in the overseas markets.

In the futures trade on the MCX, the February contract of gold jumped ₹ 334 to ₹ 63,359 per 10 grams. Also, the March contract of silver bounced ₹ 109 to ₹ 75,135 per kilogram on the bourse.

In the international markets, gold was trading higher at USD 2,067 per ounce, while silver was down at USD 24.15 per ounce.

"Gold prices continue to inch higher, as soft inflation data fupets on early into rate cuts in 2024 and weighed on the dollar index and US treasury vields," Navneet Damani, senior vice-president of commodity research at Motilal Oswal Financial Services, said. (PTI)

Missouri is one of a dozen states where sports wagering remains illegal more than five years after the U.S. Supreme Court cleared the way for states to adopt it.

"It just seems silly that everyone else can do it and we can't," said Koenig, who has launched a social media campaign called "Let MO Play" to rally support for legal sports betting in his home state.

Other states have reaped a total of over \$4 billion of taxes from more than \$280 billion wagered on sports since 2018. Vermont will become the latest to accept sports bets, starting Jan. 11, But the odds for expansion to additional states appear iffy in 2024 because of political resistance and the sometimes competing financial interests of existing gambling operators.

"The handful of states yet to legalize are last for a reason: They all have multiple obstacles," said Becca Giden, policy director at Eilers & Krejcik Gaming, a Californiabased consulting firm.

After a "whirlwind" of expansion, the playing field for further sports betting has narrowed to a group of states where various stakeholders all "want to kind of maximize what they get out of the legalization framework," said Chris Cylke, senior vice president of government relations at the American Gaming Association, which represents the industry. "So that can create some friction.

The states where sports betting remains illegal are Alabama, Alaska, California, Georgia, Hawaii, Idaho, Minnesota, Missouri, Oklahoma, South Carolina, Texas and Utah

California and Texas, the nation's two most populous states, would be the biggest prizes for sports bettors. But neither appear particularly likely to adopt it in 2024.

Voters in California last year overwhelmingly defeated two rival sports betting initiatives following a record \$463 million raised by supporters and opponents. The advertising barrage was fueled by divisions among online gaming companies, tribal casinos and horse tracks. Those tensions have continued, with Native American tribes objecting to a new sports betting initiative that is seeking signatures to appear on the 2024 ballot.

The proposed sale of the Dallas Mavericks basketball team to a politically active family that runs the Las Vegas Sands casino company has raised speculation of a bigger push for legal sports betting in Texas. But the state Legislature is not in regular session in 2024, and Texas has no means of placing citizen initiatives on the ballot.

Neighboring Oklahoma already has

scores of casinos run by tribes. Republican Gov. Kevin Stitt announced a plan in November to allow in-person sports betting at tribal casinos and online sports wagering through platforms licensed by the state. But his plan doesn't appear to have support from tribes, with whom Stitt has been feuding.

Minnesota is perhaps the next likeliest state to authorize sports betting, but that probably would require a bipartisan vote in the Senate, where Democrats hold a slim one-seat advantage over Republicans. Lawmakers this past year struggled to resolve differences between tribal casinos, which want exclusive rights over online and in-person sports betting, and horse racing tracks, which also want a greater share of the gambling market. But they will try again.

"From the perspective of the tribes, the moment is now, and they'd like to see it done this year," said Democratic state Sen. Matt Klein, a sponsor of sports betting legislation. Efforts to legalize sports betting in Mis-

souri have repeatedly stalled in the state Senate, where Republican Sen. Denny Hoskins insists it must be paired with the regulation of legally questionable slot-machine-style video games that have popped up in convenience stores and truck stops. Casinos oppose that.

Online sports wagering companies, casinos, professional sports teams and video gaming terminal interests have combined to hire about 80 lobbvists in Missouri.

The St. Louis Cardinals also are leading a coalition of the state's professional sports teams proposing an initiative petition to put sports betting on the November ballot. But Senate President Pro Tem Caleb Rowden doubts the prospects of both the initiative petition and legislation, bemoaning that Missouri may "lose out on probably some fairly significant economic activity.

Data suggests Missourians are interested in sports betting. From mid-June to mid-December, the technology firm GeoComply Solutions processed over 13.5 million location checks from 280,000 devices lofrom importers and banks.



While recognizing the importance of social media in contemporary political communication, Shah's avoidance of explicit mention of rallies and street corner meetings hints at a concern - the absence of charismatic crowd-pullers among the state leadership. This move reflects Shah's acknowledgment that the state unit lacks figures capable of drawing large crowds, a vital component of successful political campaigns. The call for door-to-door campaigning, however, raises skepticism. Past attempts at such approaches have backfired, as illustrated by Rahul Sinha's encounter with the late Soumitra Chattopadhyay. The lack of research on the state BJP's part was apparent, and the incident underscored the importance of understanding local sentiments and affiliations before engaging in such efforts. Amit Shah, known for his pragmatic approach, is fully aware of the organizational weaknesses within the West Bengal unit. His push for increased social media usage is not just about modern communication; it serves to divert attention from the dearth of top party leaders actively participating in the upcoming 2024 elections. With Prime Minister Narendra Modi and Shah likely to be engaged in a nationwide campaign, their absence from state-centric activities might impact the BJP's electoral prospects in West Bengal.

The composition of the core poll panel, with the induction of former state chief Dilip Ghosh, adds a significant dimension. Ghosh, a leader with a proven track record, played a pivotal role in BJP's success in the 2014 Assembly polls and the 2019 Lok Sabha elections. His inclusion signals a recognition of his organizational acumen, emphasizing the importance of experienced leaders in navigating the complex political landscape of West Bengal. Notably, the return of Ghosh and another former state chief, Rahul Sinha, to the limelight is a clear indication of a new organizational equation within the party. The exclusion of four Ministers of State and the message conveyed to the 14 MPs from the state indicate a restructuring aimed at addressing the weaknesses in the state unit. While Shah's diagnosis of the state unit's weaknesses is evident, the real test lies in the 2024 Lok Sabha poll results. The party's grassroots organization in West Bengal is facing challenges, and the effectiveness of Shah's prescription will only be fully gauged in the electoral outcome. Amit Shah's recalibration of BJP's strategy in West Bengal reflects a pragmatic response to organizational challenges.

The emphasis on social media, the inclusion of experienced leaders in the core poll panel, and the restructuring of the state leadership highlight a concerted effort to address weaknesses. As the political landscape evolves, only time will reveal the impact of these strategic adjustments on the BJP's fortunes in the upcoming elections. Amit Shah's recent Kolkata visit reveals a strategic shift for the BJP in West Bengal, prioritizing social media and door-to-door campaigns amid organizational challenges.



ernment had sent a wrong message to Army too. Ever since the BJP government came to power, some of the Army men have become assertive against the common people.

The Modi government is out to finish off parliamentary institutions. On December 25, Congress party President Mallikarjun Kharge accused Rajya Sabha Chairman Jagdeep Dhankhar of being the "agent of autocracy". He alleged that the BJP has weaponised suspension of MPs as a convenient tool to undermine democracy. Kharge said Dhankar was toeing the government's line and argued that normal functioning of Parliament was not possible without adherence to constitutional principles and parliamentary practices. The manner in which the Speaker of the Lok Sabha and the Chairman of the Rajya Sabha suspended 146 members of parliament makes it explicit that the presiding officers had resorted to this measure only at the instruction of the government. However, the Opposition parties, including the Congress, were anguished at the role of the presiding officers, particularly of Dhankar who allowed himself to be used in the partisan political warfare. Some members recall how he had used the Governor's administrative set-up, while he was Governor of Bengal, to embarrass Chief Minister Mamata Banerjee and had not let her perform her duties and responsibilities. The manner in which Dhankar wants to project the mimicry issue as a personal insult also underlines the efforts of the RSS and BJP to communalise parliamentary procedures for electoral benefit. Dhankhar's reference to his caste and the farming community in the context of the mimicry incident has convinced most Opposition leaders that he is bent on engaging in a kind of politicking that is not in tune with the high constitutional office he holds. The alacrity shown by Narendra Modi in picking up the thread and equating it with the Jat pride lays bare the design. There is no denying that Dhankhar has provided the BJP with enough political ammunition to polarise the Jats and create the communal impression that INDIA and Rahul Gandhi were indulging in a game of vilification. This was a shrewd move of the BJP which is using Dhankar's caste to woo back Jats who had distanced themselves from the BJP in the wake of the farmers agitation. Modi or Dhankar could not succeed in their mission to polariseJats because Olympic medal winner Sakshi Malik, a Jat, announced her retirement from wrestling in protest against BJP MP Brij Bhushan Sharan Singh's continuing dominance of the wrestling federation.

The image of the crying Jat woman washed out Dhankar's design. Bajrang Punia, again a Jat, wrestler of international repute, returned his Padma Shri over the Brij Bhushan controversy, bringing the issue of sexual exploitation of athletes to the forefront of the national discourse.

In the rearview mirror, I glimpsed the silhouette of Noklak, a place that had cracked open my heart and revealed the universality of human struggle. The journey had not just been a solo expedition; it had been a communion with the collective soul of a community left on the fringes. The roads may have been

from Topa Peer, a village in Kashmir, for questioning and the bodies of three of them, bearing injury marks, were found near an encounter site. The remaining 12 persons have been admitted to different hospitals in critical conditions.

Political parties staged protests and demanded an impartial probe into the mysterious deaths. The bodies were found near the site of an ambush of Army vehicles in Poonch district, which left five soldiers dead. "I saw a video that shows Armymen thrashing people and spraving red chilli powder on their wounds. It is heart-wrenching, however, I do not know about its authenticity,' PDP Chief Mehbooba Mufti said.

Senior CPI(M) leader Mohammad Yusuf Tarigami demanded a prompt and impartial inquiry while condemning the militant attack on the soldiers. The death of three civilians has acquired such an embarrassing form that it forced the Chief of Army Staff General Manoj-Pande to flv into Jammu and Kashmir and exhort commanders to conduct operations in a "most professional manner" and remain "resolute and steadfast against all challenges".

Sending a strong message that it has taken a serious note of the death of the three civilians which has sparked allegations of custodial torture and widespread outrage, the Army has initiated a Court of Inquiry. Brigadier Padam Acharya of 13 Sector Rashtriya Rifles and three other officers had been "attached" pending internal investigations, implying they had been divested of the leadership of their brigade. This was done, to placate the local population and ensure proper investigations.

. Of late, the Army taking action against the civilians had become a common feature. The counter-insurgency unit of the Army was in the news for wrong reasons in October also when one of its major-rank officers opened fire on his colleagues and exploded grenades inside the Neeli post camp near Thanamandi, leaving five personnel including three officers injured. On September 2 2022, Amnesty International alleged that the Indian government had drastically intensified the repression of rights in Jammu & Kashmir in the three years since the change in status of the region. Aakar Patel, chair of the board of Amnesty International India, alleged that "civil society and media in Jammu and Kashmir have been subjected to a not succeed in his designs because of Kharge who wrote to Dhankar: "I would like to clarify on the points that you have raised and request that you examine my concerns objectively and with neutrality as the Chairman of the Rajya Sabha. Your letter unfortunately justifies the autocratic and arrogant attitude of the government towards Parliament. The letter most shockingly justifies the denigration of parliamentary practices and subversion of democracy.

Hinting at the Chairman's failure to enforce parliamentary norms and traditions, Kharge wrote: "I recognise it is well within your powers as Chairman to decide on these notices (submitted by the Opposition demanding the home minister's statement). However, it was regrettable that the Chair condoned the attitude of the home minister and the government who did not wish to make a statement on the floor of the House. It was even more regrettable that the home minister made his first public statement before a TV channel when Parliament was in session and the Chair did not find that 'sacrileging the temple of democracy

Kharge further said: "You have also mentioned that disorder was deliberate and strategised and predetermined. I would like to submit that if anything, it is the mass suspension of the Opposition MPs from both Houses of Parliament that seems to be predetermined and premediated by the Government and I am most sorry to say, executed without any application of mind, as can be seen by the suspension of an INDIA party MP who was not even present in the Parliament.'

Modi and his lieutenant Amit Shah, who have acquired expertise in coercing and resorting to torture for ruling the country, had in fact chalked out the plan to suspend the MPs long back. They knew that without this they would not succeed in having the house pass the three draconian criminal law bills. It is worth recalling that a Union minister had informed an Opposition MP that most Opposition MPs would be suspended even before the Home Minister came to the Rajya Sabha. Recycling: Need, aims & advantages

ecycling is the process of collecting and convertwhich would otherwise be discarded as waste into useful and beneficial new products, be it to serve the original purpose or to serve another purpose. Recycling is a dynamic process that converts a used product into a new product and therefore gives it a new life cycle.

Reducing, recycling, and reusing waste play a significant role in fostering a sustainable future for all living organisms. Issues such as global warming, environmental pollution, acid rain, ozone layer depletion, and climate change must be addressed at the earliest.

Recycling waste might just be the first step towards creating a more beautiful and a healthier planet for all living creatures to survive in.

How are products recycled and reused? The recycling loop is a process that primarily involves three distinct steps. The first step involves collecting the waste materials from the dropoff centre. The second step i volves segregating, sorting out, and processing the waste materials, and then selling them off. The third step is the most crucial step which involves converting the waste materials into new and useful products which take on a new life as consumer goods. Then, these consumer goods are sold in the market for purchase. A few typical materials which can be recycled are ferrous met-

als like iron and steel, aluminium cans, glass, wood, paper and cardboard, newspapers and magazines, motor oil, tyres, and cellulose and plastics.

However, black plastic cannot be recycled because it is nonbiodegradable, and clutters drains and chokes living organisms. Black plastic is generally not sorted for recycling because much of it cannot be retrieved. It is too dominant of a colourant and much of it does not mix well with other plastic.

The recyclability of a product depends on its ability to retain or acquire the features that it possessed in its original form so that it is useful as a consumer good, to those who purchase it.



Countries and economies also need to figure out to what extent recycling waste items is feasible for them, both environmentally and fiscally or financially.

Why is recycling relevant and important? "If you're not recycling, you're throwing away a lot more than your trash", says the Environmental Defense Fund (which has its headquarters in the USA).

In the era of urbanisation and industrialisation, all countries. both developed and developing, produce waste on gigantic scales. The need of the hour is to not only chemically treat the waste but also judiciously reduce and reuse it. Every year, American countries reportedly dump their hazardous wastes on the coasts of African and Asian countries. This is not only morally incorrect but also deadly because it leads to the spread of harmful diseases.

The purpose of recycling is to minimise the production of waste, and resultantly, conserve energy. Recycling is a key component of the modern waste reduction process. Since reusing and reducing waste heavily relies on recycling waste, recycling has emerged as a matter of paramount importance in the process of waste reduction. Re-


The Sahara Desert used to Norwegian philosopher had the solution be a green Savannah and new research explains why

lgeria's Tassili N'Ajjer plateau is Africa's largest Anational park. Among its vast sandstone formations is perhaps the world's largest art museum. Over 15,000 etchings and paintings are exhibited there, some as much as 11,000 years old according to scientific dating techniques, representing a unique ethnological and climatological record of the region.

Curiously, however, these images do not depict the arid, barren landscape that is present in the Tassili N'Ajjer today. Instead, they portray a vibrant savannah inhabited by elephants, giraffes, rhinos and hippos. This rock art is an important record of the past environmental conditions that prevailed in the Sahara, the world's largest hot desert.

These images depict a period approximately 6,000-11,000 years ago called the Green Sahara or North African Humid Period. There is widespread climatological evidence that during this period the Sahara supported wooded annah ecosys is and numer-

This greening of the Sahara didn't happen once. Using marine and lake sediments, scientists have identified over 230 of these greenings occurring about every 21,000 years over the past eight million years. These greening events provided vegetated corridors which influenced species' distribution and evolution, including the out-of-Africa migrations of ancient humans.

These dramatic greenings would have required a large-scale reorganisation of the atmospheric system to bring rains to this hyperarid region. But most climate models haven't been able to simulate how dramatic these events were. As a team of climate modellers and anthropologists, we have overcome this obstacle. We developed a climate model that more accurately simulates atmospheric circulation over the Sahara and the impacts of vegetation on rainfall.

We identified why North Africa greened approximately every 21,000 years over the past eight million years. It was caused by changes in the Earth's orbital precession – the slight wobbling of the planet while rotating. This moves the Northern Hemisphere closer to the sun during the summer months.

This caused warmer summers in the Northern Hemisphere, and warmer air is able to hold more moisture. This intensified the strength of the West African Monsoon system and shifted the African rainbelt northwards. This increased Saharan rainfall, resulting in the spread of savannah and wooded grassland across the desert from the tropics to the Mediterranean, providing a vast habitat for plants and animals.

Our results demonstrate the sensitivity of the Sahara Desert to changes in past climate. They explain how this sensitivity affects rainfall across North Africa. This is important for understanding the implications of present-day climate change (driven by human activities). Warmer temperatures in the future may also enhance mon-

On 100,000-year cycles, the shape of Earth's orbit (or eccentricity) shifts between circular and oval, and on 41,000-year cycles the tilt of Earth's axis varies (termed obliquity).

Eccentricity and obliquity cycles are responsible for driving the ice ages of the past 2.4 million years. The third Milankovitch

cycle is precession. This concerns Earth's wobble on its axis, which varies on a 21,000-year timescale. The similarity between the precession cycle and the timing of the humid periods indicates that precession is their dominant driver. Precession influences seasonal contrasts, increasing them in one hemisphere and reducing them in another. During warmer Northern Hemisphere summers, a consequent increase in North African summer rainfall would have initiated a humid phase, resulting in the spread of vegetation across the region.

Eccentricity and the ice sheets In our study, we also identified that the humid periods did not occur during the ice ages, when large glacial ice sheets covered much of the Polar Regions. This is because these vast ice sheets cooled the atmosphere. The cooling countered the influence of precession and suppressed the expansion of the African monsoon system.

The ice ages are driven by the eccentricity cycle, which determines how circular Earth's orbit is around the sun. So our findings show that eccentricity indirectly influences the magnitude of the humid periods via its influence on the ice sheets. This highlights, for the first time, a major connection between these distant high-latitude and tropical regions.

The Sahara acts as a gate. It controls the dispersal of species between north and sub-Saharan

during the glacial periods of the last 800,000 years.

Our ability to model the African humid periods helps us understand the alternation of humid and arid phases. This had major consequences for the dispersal and evolution of species, including humans, within and out of Africa.

Furthermore, it provides a tool for understanding future greening in response to climate change and its environmental impact.

'Deep ecology' and the equal right to exist

In this task, the work of Norwegian environmental philosopher Arne Næss (1912-2009) might be of help. Næss is known as the father of "deep ecology", an ethical theory that contends that all life has intrinsic value. Næss argued that all beings, whether human or nonhuman, have an equal right to exist and flourish, a principle he called "biospherical egalitarianism".

As this applies to wolves, Næss was clear: wolves have

¬ertilizer is one of the important inputs required to increase agricultural production and farmers' income in India. India ranks second in the world and first among South Asian Association for Regional Cooperation (SAARC) countries in terms of total fertilizer consumption. Changes in government policies related to fertilizer distribution and use have significantly affected nutrient use ratios. Excessive use or misuse or unbalanced use of fertilizer nutrients is causing environmental degradation and climate change.

The compounded harmful effects of unbalanced fertilizer use are not only increasing soil and atmospheric pollution but also affecting water bodies (eutrophication) and posing a threat to biodiversity and human health. Excessive use of fertilizers leads to environmental pollution as their residual and unused amounts will become pollutants for air, water, and soil. It also initiates the process of eutrophication in water bodies, thereby reducing soil quality by killing soil microflora, etc.

India needs to establish a well-defined comprehensive system that enforces stringent policies on balanced fertilizer use, besides facilitating integrated nutrient management and cultivation of efficient crop genotypes with locally available organic manure/crop residues. To make any amendment in the fertilizer subsidy program successful and longterm, the Central Government should also involve all concerned parties such as farmers, state governments, and fertilizer companies in the reform process.

RAFAH, Dec 27: Israeli forces on Tuesday expanded their ground offensive into urban refugee camps in central Gaza after bombarding the crowded Palestinian communities and ordering residents to evacuate

Gaza's main telecom provider announced another "complete interruption" of services in the besieged territory. The military's announcement of the new battle zone threatens further destruction in a war that Israel says will last for "many months" as it vows to crush the ruling Hamas militant group after its October 7 attack. Israeli forces have been engaged in heavy urban fighting in northern Gaza and the southern city of Khan Younis, driving Palestinians into eversmaller areas in search of refuge.The US said Israel's minister for strategic affairs, Ron Dermer, was meeting with Secretary of State Antony Blinken and national security adviser Jake Sullivan.

Despite US calls for Israel to curb civilian casualties and international pressure for a cease-fire. Israeli Prime Minister Benjamin Netanyahu said the military was deepening the fighting

Israel's offensive is one of the most devastating military campaigns in recent history. More than 20,900 Palestinians, two-thirds women and children, have been killed, according to the Health Ministry in Gaza, whose count doesn't differentiate between civilians and combatants. The agency said 240 people were killed

over the past 24 hours. The UN human rights office said the continued bombardment of middle Gaza had claimed more than 100 Palestinian lives since Christmas Eve. The office noted that Israel had ordered some resi-

dents to move there. Israel said it would no longer grant automatic visas to UN employees and accused the world body of being "complicit partners" in Hamas' tactics. Government spokesman Eylon Levy said Israel would consider visa requests case by case. That could further limit

aid efforts in Gaza. Residents of central Gaza described shelling and airstrikes shaking the Nuseirat, Maghazi and Bureij camps. The built-up towns hold Palestinians driven from their homes in what is now Israel during the 1948 war, along with their descendants.

North Korea's Kim boasts of achievements as he opens key year-end political meeting

SEOUL, Dec 27: North Korean leader Kim Jong Un praised what he called achievements and victories that strengthened national power and boosted the country's prestige this year, as he opened a key political meeting to set new policy goals for 2024, state media reported on Wednesday.

Experts said that during this week's yearend plenary meeting of the ruling Workers' Party, North Korea would likely hype its progress in arms development because the country lacks economic achievements amid persistent international sanctions and pandemic-related economic hardships.

In his opening-day speech at the meeting that began on Tuesday, Kim defined 2023 "as a year of great turn and great change both in name and reality, in which (North Korea) left a great trace in the glorious course of development in the efforts to improve the national power and enhance the prestige of the country," according to the official Korean Central News Agency.

KCNA said North Korea achieved a rapid advancement in its defence capabilities this year thanks to the launch of its first military spy satellite in November and the introduction of other sophisticated weapons.

KCNA said North Korea also reported a rare good harvest this year as the country finished building new irrigation facilities ahead of schedule and met major agricultural state objectives. It said that modern streets, new houses and other buildings were built in Pyongyang and elsewhere across the country.

The Workers' Party meeting, expected to last several days, will review state projects from this year and establish new objectives for next year. In recent years, North Korea has published the results of its meeting, including Kim's closing speech, in state media on January 1, allowing him to skip his New Year's Day address.

The meeting comes after North Korea launched its most advanced intercontinental ballistic missile, the solid-fuelled Hwasong-18, which is designed to strike the mainland US, into the sea last week. North Korea said the Hwasong-18 launch, the third of its kind this year, was meant to warn the US and South Korea over their confrontational



moves against North Korea.

On November 21, North Korea put its first military spy satellite into orbit, though outside experts question whether it can send militarily useful high-resolution imagery.

The launches of the Hwasong-18 missile and the spy satellite were part of an ongoing run of weapons tests by North Korea since last year. Kim has maintained he was forced to expand his nuclear arsenal to cope with increasing hostilities from the US and its allies toward the North, but foreign experts say he eventually hopes to use an enlarged arsenal to win greater outside concessions when diplomacy resumes.

Last Thursday, South Korean Defence Minister Shin Wonsik told lawmakers that North Korea appeared to be speeding up its weapons testing activities to highlight its achievements in defence sectors because it lacked major progress in the economy and public livelihoods.

In recent years, North Korea's fragile economy was severely battered by pandemic-related curbs, U.S.-led sanctions and the North's own mismanagement. But monitoring groups say there are no signs of a humanitarian crisis or social chaos that could threaten Kim's absolute rule at home.

In August, South Korea's National Intelligence Service told lawmakers that North Korea's economy shrank each year from 2020 to 2022 and that its gross domestic product last year was 12 per cent less than in 2016. (AP)

Former Pakistani premier Nawaz Sharif will seek a fourth term in office, his party says

LAHORE, Dec 27: Former Pakistani Prime Minister Nawaz Sharif will seek a fourth term in office, his party said on Wednesday, noting he would be its consensus candidate in the upcoming parliamentary elections and the office of the prime minister.

Sharif, who has served as prime minister three times, returned to Pakistan in October after four years of self-exile in London to avoid serving prison sentences on corruption charges. However, his conviction and sentences were overturned on appeal after his return, making him eligible to run for a seat in the parliament, which will elect the new prime minister after the Feb. 8 vote.

"There is no doubt about it. Nawaz Sharif is our candidate for the office of the prime minister," said Rana Sanaullah Khan, a senior leader in Sharif's party.

Sharif stepped down as prime minister in 2017 over the corruption charges. In July 2018, he was sentenced to 10 years in prison over purchases of luxury apartments in London. In December that year, he was sentenced to a further seven years for failing to disclose how his family set up steel mills in 1999.

Sharif's main rival, Imran Khan, is currently serving a prison term, but he too has an nounced plans to contest the elections. Khan was ousted in a no-confidence vote in April 2022, but he remains a leading figure and his Pakistan Tehreek-e-Insaf party has a large following Also Wednesday, police arrested one of Khan's deputies, Shah Mahmood Qureshi, in Rawalpindi under a law that allows authorities to detain anyone to maintain law and order in the country. A video showed police pushing Qureshi toward an armored vehicle as he shouted that he was being arrested unjustly. The arrest came days after the Supreme Court granted bail to Qureshi and Khan in a case related to the leaking of official government secrets. But because Khan is in prison for a graft case, he will not be released.

But the meeting was adjourned after legislators from Erdogan's ruling party submitted a motion for a postponement on grounds that some issues needed more clarification and that negotiations with Sweden hadn't "matured" enough.

On Tuesday, the committee resumed its deliberations and a large majority of legislators in the committee voted in favor of Sweden's application to join.

PTI's Shah Mehmood Qureshi arrested

LAHORE, Dec 27: Pakistan Tehreeke-Insaf party's Vice Chairman Shah Mahmood Qureshi, who was last week granted bail in the cipher case by the Supreme Court, was re-arrested outside the Adiala jail on Wednesday.

Footage aired on television and shared by PTI on social media showed the 67-year-old former foreign minister, who was loudly protesting the "illegality" of the police's actions, being shoved into an armoured police vehicle by an official wearing the Punjab police uniform, Dawn News reported.

In a post on X, the party said Qureshi was again arrested from outside the Adiala jail after being released on bail in the cipher case. The party said that the order issued on Tuesday by the Rawalpindi Deputy Commissioner Rawalpindi Hasan Waqar Cheema for Qureshi's 15-day detention had been withdrawn. Police have not yet commented on the issue.

While being forcibly whisked away by police personnel, the PTI leader kept saying he was being arrested illegally.

Qureshi added that the police were making a mockery of the Supreme Court's orders and cruelty and injustice were at its peak. (PTI)

"What we're looking at right now is a very, very perplexing crime scene," the chief said. "Detectives right now are looking at this as a possible murder

Pakistan goes for crucial elections in New Year as ties with India remain frozen

ISLAMABAD. Dec 27: Pakistan-India bilateral relations remained frozen for the fourth year over the vexed Kashmir issue but analysts hope the strained ties could be repaired if Nawaz Sharif becomes the prime minister for a record fourth time in the general elections in February in the absence of his main challenger Imran Khan who is in jail in multiple cases.

The main highlight of the outgoing year was a visit to India by then-foreign minister Bilawal Bhutto Zardari in May to attend the Shanghai Cooperation Organisation ministerial moot in Goa.

The usual pre-visit hype centred on the question of any meeting between Bilawal and his Indian counterpart S Jaishankar. But both sides did not show any desire for such a meeting. Instead, the two leaders in their official speeches at the ministerial huddle, targeted each other's countries through innuendoes and pointed jargon.

Bilawal's choice of words, especially urging the participants not to let terrorism hinder political relations, irked many in India. Jaishankar in his address to the SCO meeting underscored the importance of stopping the issue of cross-border terrorism.

Thus, Bilawal's trip, which was the first by a Pakistani foreign minister to India in almost 12 years, failed to repair the strained ties which remained frozen over the Kashmir issue. Pakistan down-



graded its diplomatic relations with India by expelling its envoy in Islamabad and stopped trade ties following New Delhi's decision to revoke the special status of Jammu and Kashmir in August 2019 after abrogating Article 370 of the Constitution. In December, Pakistan's current caretaker government and Pakistani political leaders also reacted sharply to India's Supreme Court upholding the Indian government's decision to abrogate Article 370 of the Constitution.

As the year 2023 fades into history, it leaves a feeble ray of hope that changes may come in the India-Pakistan equation due to the changing regional situation and domestic compulsions.

Pakistan has lately found itself in an enviable position due to the floundering of its gamble in Afghanistan. The Taliban takeover has badly backfired, as the rulers in Kabul have refused to break ties with the Tehreek-e-Taliban Pak-

istan militants, who are responsible for the endless bloodbath in the country, forcing Islamabad to recalibrate its stance and options. The immediate result has been the issuance of marching orders for hundreds and thousands of Afghans living illegally. So far, more than 400,000 have been expelled. The orders have not been reversed despite protests and threats by the Taliban regime in neighbouring Afghanistan.

Second, elections are slated to take place on February 8 next year, and former three-time premier Nawaz Sharif, who returned from the UK after a four-year selfexile, is likely to make a record fourth-time ascendancy to power. As a prelude to his rise to power, 73-year-old Sharif has been acquitted in all corruption cases and enjoys the protocols of a prime minister-designate.According to analysts, Sharif is considered an ardent advocate of having good ties with all neighbours, especially India. He made his intention clear while addressing his party leaders in Lahore on December 7, when he said that repairing diplomatic ties with neighbouring nations, including India,

Afghanistan, and Iran, was on the agenda of his Pakistan Muslim League-Nawaz (PML-N) party. "How can you achieve global status when your neighbours are upset with you?" he asked.

Sharif, who had opposed the Kargil war of 1999 and was later

ousted by then-military chief Pervez Musharraf because he was against this "misadventure," said that he was right to oppose it.

"Time has proved us right as far as the Kargil episode is concerned," he said, which may have been well received by his audience in India. Sharif talking about his successes during his previous tenures also included improvement in the ties with India and sought endorsement of his policy towards India by posing a question:

During whose tenures did two Indian prime ministers visit Pakistan? First Atal Bihari Vajpavee and later Narendra Modi." After his Lahore address, the leading Dawn newspaper quoted a political observer saying Sharif has a record of improving ties with India.

"Improving ties with India has always remained a point of conflict between Nawaz and the establishment in the past. Whenever Nawaz Sharif came to power, he tried to shake hands with India against the wishes of the powers that be," the paper quoted the expert without identifying him.

He enjoys good relations with Prime Minister Narendra Modi who, like him, is in a race to gain power for another term in the next year's elections. Their presence on the two countries' national scenes may help ease bilateral tension.

Cabinet approves widening of Khowai-Harina road in Tripura

Centre earmarks ₹2,486.78 *crore for road project, JICA to provide loan assistance*

NEW DELHI, Dec 27: The Union cabinet on Wednesday gave its approval for widening of the 135-km stretch of Khowai-Harina road in Tripura, according to an official statement.

The project involves an investment of ₹ 2,486.78 crore which includes a loan component of ₹ 1,511.70 crore (JPY 23,129 million), the statement said.

The loan assistance will be given from the Japan International Cooperation Agency (JICA) under Official Development Assistance (ODA) scheme, it added.

The project is envisaged to facilitate better road connectivity between various parts of Tripura and to provide alternative access to Assam and Meghalaya from Tripura apart from existing national highway-8.

"The Cabinet Committee on Economic Affairs, chaired by Prime Minister Narendra Modi, has given its approval for improve-





The statement noted that development of the project stretch of NH-208 would not only improve interstate connectivity between Assam and Tripura via the national highway, but also reduce the transit time and provide safer connectivity for the travellers.

The project stretch also passes very close to the Bangladesh border and it would improve connectivity to Bangladesh through Kailashahar, Kamalpur and Khowai border check post, it said. The statement said land border trade would also potentially grow with the improvement in road network in the region through development of the project road.

The construction period for the project will be two years, which includes the maintenance of these national highways stretches for five years in the case of flexible pavement and 10 years in the case of rigid pavement after completion of construction. (PTI)

BJP national spokesperson Nalin Kohli also hit out at the Congress and said the opposition party cannot fool Indians by coining some slogans. Its leader Rahul Gandhi has been seen in the company of people who advocate "tukde-tukde" (division) of India.

The Congress leader goes abroad seeking foreign interference in the country's democracy, Kohli alleged.

"Real nyay" is what Modi has been doing since 2014 by ensuring that development reaches every corner of the country and everyone, he said and cited measures for electrification of every village, free ration for the poor, building of subsidised homes and provision of Mudra loans to make his point.

"All this is happening because PM Modi cares for people. Mere sloganeering does not change anything. What changes is your intent and commitment to implement good policies which Modi is doing," he said. (PTI)

NEW DELHI, Dec 27: A faction of Muslim League Jammu Kashmir, led by separatist leader Masarat Alam Bhat, was on Wednesday declared a banned organisation by the government under the stringent anti-terror law.

The ban comes as a response to the outfit's involvement in anti-national and secessionist activities in Jammu and Kashmir, with the intent to create a reign of terror in the country, the Union Home Ministry said.

Union home minister Amit Shah, while announcing the ban under the Unlawful Activities (Prevention) Act, emphasised that the Modi government's message is clear that those who act against the unity, sovereignty, and integrity of the nation will face the full wrath of the law and will not be spared.

"The Muslim League Jammu Kashmir (Masarat Alam faction) is declared as an 'Unlawful Association' under UAPA. This organisation and its members are involved in anti-national and secessionist activities in J&K, supporting terrorist activities, and inciting people to establish Islamic rule in J&K," Shah said in a post on 'X'.

Masarat Alam Bhat is known for his anti-India and pro-Pakistan propaganda. Bhat became the chairman of the hardline

Israel Embassy blast: Two youths caught on CCTV, security beefed up in Delhi

NEW DELHI, Dec 27: Delhi Police has intensified its probe into a low-intensity blast that occurred near the Israel Embassy here and sources said two youths were caught on camera walking on the road close to the spot shortly before the explosion.

The National Security Guard (NSG) along with forensic experts visited the spot Wednesday morning and collected samples of leaves and grass that they suspected might contain chemicals used in the explosion, police sources said. A team of NSG's dog squad also inspected the spot with two canines, they said.

The team of forensic experts has marked the places with the signage of "A" "B" and "C" from the spot where the low-intensity blast took place on Tuesday.

The experts have used magnetic gadgets to detect the intensity of the blast, said sources.

The officials of Delhi Police Special Cell and local police inspected the spot and a group of paramilitary personnel were deployed there.

"2023 breach: GOVT SILENT. 146 MPs suspended for demanding discussion & statement from Home Minister. Parliament turned into a deep, dark chamber," he said. O'Brien added that in 2001, just three

2001 Parliament attack, two people jumped into the chamber of the Lower House of Parliament from the public gallery during the Zero Hour, released yellow gas from canisters they had been hiding in their shoes, and shouted slogans before they were overpowered by MPs.

Following the incident, opposition MPs demanded a discussion on the breach, and a statement from Home Minister Amit Shah

As many as 100 opposition MPs in Lok Sabha, and 46 in Rajya Sabha, were suspended during the session for indiscipline as they raised their demand vociferously, leading to frequent adjournments

O'Brien, who was the first Rajya Sabha MP to be suspended, also had a breach of privilege motion moved against him for staying in the House after being suspended. The matter has been referred to the Privileges committee of the House.

As per Parliament records, after the December 2001 attack on Parliament, a debate was held in both the Houses, and then home minister LK Advani had replied to the debate, while prime minister Atal Bihari Vajpayee made interventions in both Houses. (PTI)

DHARWAD (K'TAKA), Dec 27: Karnataka minister Priyank Kharge on Wednesday appealed to the disgruntled BJP MLA Basanagouda Patil Yatnal to make the documents public related to the alleged ₹ 40,000 crore scam in Covid-19 management during the previous BJP government in the state.

The minister said Yatnal should at least hand over the details to the Justice John Michael Cunha Commission of Inquiry to probe into the coronavirus related irregularities. "Yatnal has said that if he is expelled from the BJP then he will release all the documents (related to Covid mismanagement). Or at least share them with Justice John Michael Cunha Committee Commission of Inquiry," Kharge, who holds IT/BT and Rural Development and Panchayat Raj portfolios, told reporters.

"If you (Yatnal) are not interested in handing it over to the commission then share it with the media because it is a Rs 40,000 crore scam. There is no humanity if they (previous BJP government) made money from corpses," Kharge said reacting to BJP MLA's statement.

BJP MLA Yatnal to expose Covid irregularities

Yatnal on Tuesday warned that he would expose the alleged irregularities of ₹ 40,000 crore that happened during the BJP government in Karnataka led by B S Yediyurappa at the height of the Covid-19 pandemic if he was expelled from the party. The MLA said, "They (the BJP government in Karnataka) have done everything (huge corruption during Covid). Let them serve me a notice and try to expel me from the party, I will expose them."

Stating that these allegations were not by the Congress but a BJP MLA and a former union minister, Kharge asked the BJP state president B Y Vijayendra and opposition leader in the Karnataka Assembly R Ashoka to clarify the charges.

To a question why the Central level leaders were silent on the irregularities in Covid management, Kharge claimed they too would have got their share.

The minister added that the title of '40 per cent commission' given to the previous BJP government was not from the Con-

gress but from their own (BJP) party leaders and Karnataka State Contractors' Association. "Did we ask them to make money out of corpses? Even though we were alleging that there was large scale corruption in the procurement of medical equipment, the then Speaker said the investigation should not continue further and it is illegal. "Have you ever heard that the Speaker wrote to the public accounts committee? It

is quite visible that everyone's involvement is there - Central as well as the state government," Kharge said.

Asked when the inquiry report was expected, the minister said the commission has not vet submitted the report because it is still inquiring into it since it pertains to a massive ₹ 40,000 crore irregularity.

Karnataka Rakshana Vedike (NG) activists damage signboards for not using Kannada

BENGALURU, Dec 27: The Karnataka Rakshana Vedike (Narayana Gowda faction) on Wednesday targeted business establishments in Bengaluru and damaged their signboards and name plates which did not use Kannada.

The activists took out rallies in various parts of the city, especially in the business hubs such as MG Road, Brigade Road, Lavelle Road, UB City, Chamarajapet, Chickpet, Kempe Gowda Road, Gandhi Nagar, St Marks Road, Cunningham Road, Residency Road and Sadahalli Gate near Devanahalli. The activists claimed that the business establishments were "undermining the official language of Karnataka, which is Kannada.'

Many malls, shops, commercial buildings, companies and factories, especially multinational companies, faced the ire of KRV activists, who damaged and defaced signboards and name plates which were not in Kannada.

Later, the agitating members including the KRV convener T A Narayana Gowda, were taken under preventive custody by police. Addressing reporters, Gowda said the name plates and signboards in Karnataka should be in Kannada.

Citing BBMP rules, he said, "60 per cent of the signboards and name plates should be in Kannada. We are not against your business but if you are doing business in Karnataka then you have to respect our lan-



guage. If you ignore Kannada or put Kannada letters in small, we will not let you operate here.

The KRV leader warned the government that it will face the music in the upcoming Lok Sabha elections if it did not take their love for Kannada seriously.

The Ballari road leading to the airport and other places was chock-a-block with activists, which led to vehicles moving at a snail's pace. The police too found themselves helpless before the agitating crowd, which had gone berserk.

Meanwhile, state Home Minister G Parameshwara told media in Kalaburagi that the pro-Kannada activists have been warning against the non-usage of Kannada language in the signboards, advertisements and name plates. He said the government respects Kannada very much because all its activities take place in the state's official language. (PTI)

Ammonia gas leaks from subsea pipeline of TN fertiliser plant, several people hospitalised

CHENNAI, Dec 27: An ammonia gas leak from a subsea pipeline linked to a private fertiliser manufacturing unit in north Chennai has caused illness among local residents, with about 25 people hospitalised.

Officials on Wednesday reported symptoms such as shortness of breath and nausea among the affected people, who are currently undergoing treatment. Following the leak, at about 11.45 pm on December 26, an odour that caused severe discomfort to people spread through air in north Chennai areas. A number of persons fainted after experiencing 'burning sensation' in their throat and chest. Many people who were asleep woke up in panic and scurried out of their homes and alerted neighbours and all of them soon reached the main roads unsure of what to do.

For the people of north Chennai, it was double whammy, as they were affected by the recent oil spill and now the ammonia gas leak. About 25 people including children, who were residents of areas close to the fertiliser manufacturing facility were hospitalised. Most of them experienced unease, shortness of breath, nausea, and faintness. According to representatives of fish-

ermen villages, Chinna Kuppam, Periya Kuppam, Netaji Nagar, Burma Nagar in north Chennai were among the affected neighbourhoods.

People had a tough time finding vehicles midnight and used whatever vehicles were available like autorickshaws and motorcycles to reach hospitals.

An elderly woman fainted after bouts of vomiting and she was rushed to a hospital in an autorickshaw. Buses and ambulances were also deployed by authorities to immediately bring affected people to hospitals many kilometers away from the location of the fertiliser unit. Some fishermen and local people who happened to be on the beachfront at midnight noticed unusual sound and water gushing out from select spots above the subsea pipeline.

Health Minister Ma Subramanian visited the Government Stanley Medical College Hospital here and spoke to people admitted from gas-hit areas and interacted with hospital authorities.

Coromandel International Limited, a Murugappa group company said in a statement: "As part of routine operation, we noticed abnormality on 26/12/2023 at 23.30 hrs in the ammonia unloading subsea pipeline near shoreside, outside the plant premises. Our Standard Operating Procedure activated immediately, and we have isolated ammonia system facility and brought the situation to normalcy in the shortest time.'

During the process, the company said, "few members in the local community expressed discomfort and were given medical attention immediately. All are safe and normalcy is restored. We have informed relevant authorities about the incident. Coromandel has always adhered to the highest safety standards and emergency response system. After the company officials 'addressed' the issue, police personnel pacified people who gathered on roads and requested them to go back to their homes as 'there is no problem'. Agitated residents, however, gathered in front of the fertiliser manufacturing company's premises this morning and raised slogans and demanded the unit's immediate closure. (PTI)



Mann attacks Centre for not including Punjab's tableau for Republic Day parade

CHANDIGARH, Dec 27: Punjab chief minister Bhagwant Mann on Wednesday hit out at the BJP-led central government over non-inclusion of the state's tableau for the Republic Day parade, alleging the Centre has discriminated against the state.

He said that like the last year, this year too, Punjab's tableau for the Republic Day parade on January 26 will not be included.

"The Centre has discriminated against Punjab," alleged Mann, adding that both Punjab and Delhi are not on the list whose tableaux have been selected.

Mann was addressing a press conference in Chandigarh after visiting Fatehgarh Sahib

Mann said they received a letter from the Centre on Wednesday, which shows that Punjab's tableau has not been included.

When asked about the reason for the rejection, Mann said they have only been informed about the list of states whose tableaux have been selected.

"Every year on the occasion of Republic Day, through their tableaux various states showcase their culture and traditions," he said. He said that this year the Centre had written a letter

to the state "asking our willingness regarding the state's tableau. On August 4, 2023, we wrote a letter of willingness and also mentioned that not just in January 2024, but for 2025 and 2026 also, we expressed our willingness that our tableau be included"

We proposed three tableaux from Punjab for shortlisting and even gave them designs for this, and our officers also held meetings in this regard with the Centre.

"Punjab Kurbaniya ate Shahadatan Da Itihaas, the second tableau proposed was the Nari Shakti -- Mai Bhago, the first lady warrior of Sikhism and the third was Punjab da Ameer Virsa te Odi Peshkari," he said.

Among the selected states include Uttarakhand, Uttar Pradesh, Telangana, Tamil Nadu, Rajasthan, Odisha, Manipur, Maharashtra, Madhya Pradesh, Haryana, Goa, Meghalaya, Ladakh, Karnataka, Jharkhand, Gujarat, Chhattisgarh, Assam, Arunachal Pradesh and Andhra Pradesh, said Mann. (PTI)

In October, Chetia had said they had sent their suggestions regarding the draft proposals to the Centre. The ULFA was formed at Rang Ghar in Sivasagar in 1979 and was banned in 1990 when it started an armed conflict against the state.

The outfit split into two factions in 2011 when the pro-talk faction led by Rajkhowa decided to return to the state from abroad and participate in peace talks while the other group ULFA (Independent), led by its commander Paresh Barua, was opposed to negotiations unless the 'sovereignty' clause was included.

The pro-talk ULFA had submitted a 12-point charter of demands on which the talks should be held and these include constitutional and political arrangements and reforms, protection of the identity and material resources of the local indigenous population of Assam, financial and economic arrangements, status report on missing ULFA leaders and cadres, amnesty, reintegration and rehabilitation of ULFA members and affected people, settlement of all royalties on mines/minerals including oil on a retrospective compensatory basis and rights of independent use for a sustainable economic development in future.

The demand of the pro-talk faction also encompassed the right to engage in specific relationships with foreign countries for promotion of mutual trade, commerce and cultural relationship, restoration, protection, preservation and spread of indigenous culture of Assam.

Study highlights urban environmental aspects key to child development

NEW DELHI, Dec 27: Air and noise pollution, overcrowding and limited green space are some of the key areas of environmental exposure in early life that can impact development, new research has found. The study, led by University of Technology Sydney, Australia, and analysing 235 research articles from across 41 countries, has highlighted such key aspects of environmental exposure in childhood influencing growth.

The first 2000 days of life (0-5 years) are recognised as a critical period impacting physical, cognitive, social and emotional health outcomes in later life.

Other exposure factors crucial to child development include atmosphere, chemical and metal exposure, neighbourhood-built features, community support, and residential living environment, the researchers said in their study published in the journal Public Health Research and Practice.

The findings help understand the health risks of urban living, which can further inform the design and planning of urban environments to improve these outcomes, as it is expected that by 2030, more than



60 per cent of the world's population will live in urban areas, the team said.

Further, the fast-paced nature of city life often leaves parents and carers feeling disconnected and overwhelmed, lacking the vital support networks crucial for healthy infant development. Thus, the families face challenges such as social isolation and limited community support, the researchers said.

"Programs providing parenting classes, playgroups, and community centres can foster connections and support networks crucial for navigating the challenges of parenting," said McIntyre.

She also emphasised the need for further research, policy advocacy, and community involvement to address the challenges of raising children in urban settings. (PTI)

After the incident, security was further beefed up around the embassy and other Israeli establishments, according to officials. Earlier this month, the NSC warned Israelis to reconsider all their travel abroad and called on those who do need to travel overseas to avoid outward displays of their Jewish and Israeli identities amid rising antisemitism around the world amidst the ongoing war between Israel and Hamas militant group in Gaza. In the past, too, the Israeli embassy and its staff have come under attack in New Delhi.

There was an explosion outside the Israeli embassy in 2021 in which cars were damaged, but no casualties were reported. In February 2012, the wife of an Israeli security staff at the embassy was injured in an attack on her car in New Delhi.

Security has been high around the Israel embassy in New Delhi since the war between Israel and Hamas began earlier this year, security officials said. (PTI)

India-Russia relations reflect geopolitical

relationship from which both India and Russia have benefitted enormously," Jaishankar said while responding to a question during a joint media appearance along with Lavrov after talks.

"My presence here today and the fact that all the developments that I have pointed out including our growing trade investments, our military-technical cooperation, our connectivity projects all of this will give you a good sense of the importance and value that we attach to the relationship," he added.

In his opening remarks at the meeting, Jaishankar said that Prime Minister Narendra Modi and President Vladimir Putin have been in frequent contact. "Our relations have been very strong, very steady. And I think we have lived up to a special and privileged strategic partnership. This year we have already met six times, and this is our 7th meeting," he said. During today's meeting, the two sides focussed on bilateral cooperation in different spheres, adjusting it to changing circumstances and demands.

Jaishankar said the two sides have seen different expressions of their cooperation this year. "I will also mention our presence at the St. Petersburg International Economic Forum at the Far Eastern Economic Forum in Vladivostok at the meetings. And on the bilateral economic cooperation the India, Russia intergovernmental commission, which I had co-chaired with Deputy Prime Minister Denis Manturov," he said.

"We are very glad to see continued progress and we expect a strong Russian participation at the Vibrant Gujarat meeting in January," he added. On his part, Lavrov said the relations between India and Russia are very ong and very good and it's good to see that they're moving on consistently in the present moment.

On Tuesday, Jaishankar held a "comprehensive and productive" meeting with Deputy Prime Minister Manturov on the bilateral economic cooperation during which they witnessed the signing of some "very important" agreements related to the construction of the future power-generating units of the Kudankulam nuclear power plant in Tamil Nadu. The ties between India and Russia remained strong notwithstanding Moscow's invasion of Ukraine. India has not yet condemned the Russian invasion of Ukraine and it has been maintaining that the crisis must be resolved through diplomacy and dialogue. India's import of Russian crude oil has gone up significantly despite increasing disquiet over it in many Western countries.

"The time-tested India-Russia partnership has remained stable and resilient and continues to be characterised by the spirit of the Special and Privileged Strategic Partnership," the Ministry of External Affairs said in a press release ahead of Jaishankar's visit. (PTI)

The 50-year-old director said he never imagined that he would get to narrate the script to the actor. "I went with a prayer in my heart

He looked at me at the interval point (by then I was looking like I was at the Sahara desert and water could keep me alive) kindly offered me water and said 'I'm on!!!'

"I was perplexed and said but 'you are in the second half, you haven't heard it?' He said 'I love your father and my sister will kill me if I don't do this movie' and that's how Salman Khan was in KKHH'," Johar said. Oscar-winning 'Parasite' actor Lee Sun-kyun found dead at 48

SINGAPORE, Dec 27: South Korean actor Lee Sun Gyun, known for his roles in the Academy Award-winning film Parasite, has tragically passed away, according to South Korean authorities. The actor was involved in a drug case and had been under investigation since October. On December 27, police responded to an emergency call reporting an unconscious person in a parked car at Waryong Park. The caller, who identified herself as Lee Sun Gyun's wife, mentioned that he had left home after leaving a note indicating suicidal intentions.

The 48-year-old actor, renowned for his work in films like Sleep, Coffee Prince, and A Hard Day, had faced public scrutiny due to the drug case and had withdrawn from several upcoming projects. Earlier in the morning, police confirmed the individual's identity as Lee Sun Gyun, and evidence such as burning charcoal briquettes in his car pointed to suicide. The actor had been investigated by the police three times for alleged drug use.

Authorities reported that Lee Sun Gyun left behind either a suicide note or a 'will' for his wife. The police received a call at night from his wife, stating that her husband had left the house after writing a note that resembled a will. Despite facing uncertainties in the drug case, a detailed analysis by the National Institute of Forensic Science confirmed the absence of drugs in his system following a reagent test. Lee Sun Gyun had sought a lie detector test on the 26th in an effort to clear his name. Several other industry A-listers, including BIGBANG's G-Dragon, had also faced drug allegations but were cleared after tests.(AGENCIES)

CENTURION, Dec 27: KL Rahul scored one of his most satisfying hundreds in extremely difficult batting conditions to take India to an above-par first innings score of 245 against South Africa on the second day of the opening Test here Wednesday.

At lunch, South Africa were 49 for one as Rahul followed his hundred with a regulation catch to dismiss Aiden Markram (5), who was forced to nick one off Mohammed Siraj (1/19) that nipped away a shade after pitching.

Siraj used the overcast conditions to good effect as he continuously troubled Dean Elgar (30 batting) and Tony de Zorzi (12 batting) beating their bats on a number of occasions

Starting the day unbeaten on 70, Rahul made 101 off just 137 balls and this innings could well be considered on par with some of the best knocks played by Indians in SENA countries if the degree of difficulty is taken into account.

No Test batter from any other country has been able to score two Test hundreds at the Supersport Park and Rahul now holds that inique record.

Labuschagne scored a patient 63 as Australia was bowled out for 318 at lunch on the second day of the second cricket test against Pakistan on Wednesday.

On a Melbourne Cricket Ground pitch that continues to offer sideways movement for the seam bowlers, Australia lost seven wickets for 131 in an entertaining session that lasted for over 2 1-2 hours due to rain delays on the opening day Tuesday.

Invited to bat first in overcast conditions, Australia reached 187-3 at stumps Tuesday. David Warner, who was dropped at slip on two, scored 38 in a 90-run opening stand with Usman Khawaja (42).

Steve Smith added 26 in a 46-run partnership with Labuschagne for the third wicket as Australia battled through a tough afternoon on a rain-interrupted first day of play when only 66 of the scheduled 90 overs were bowled.

Travis Head (17) fell in the fifth over Wednesday, caught at second slip off the bowling of Shaheen Shah Afridi (2-85). Aamir Jamal (3-64) removed Labuschagne in a key strike, caught at slip at 250-5 after a 46-run stand with Marsh

MUMBAI, Dec 27: Flying high after two consecutive Test wins, India Women will now shift focus to white-ball cricket as they take on seven-time world champions Australia in a three-match ODI series, looking to resurrect their dismal record in the format, here on Thursday.

India have been in top form winning their last three contests - two Tests and one T20I — after losing the first two T20Is to England and concede the three-match series in this long home season.

After crushing England by a record 347 runs in the one-off Test, India carried the momentum to defeat Australia by eight wickets last week here at the Wankhede Stadium, which will also be the venue for the three-match ODI series.

Given their current form, India will eye more success in the fixtures lined up but the Harmanpreet Kaur-led side would know that it has a huge task cut out against Australia who have historically dominated them in 50-overs cricket.

India have only 10 wins and 40 losses to show from 50 ODIs against Australia overall, while at home, their record has been simply terrible.

With only four wins in 21 ODIs and 17 defeats at home, India have not beaten Sadhu getting their maiden ODI call-ups. However, India will be without Devika Vaidya who was dropped despite taking six wickets in three matches in Bangladesh. India have played only three ODIs this vear — a three-match away series in Bangladesh – which ended in a 1-1 draw with the third game culminating in a tie in controversial circumstances, leading to skipper Kaur being banned for the next two matches. While Jemimah Rodrigues has been

India's top run-maker in three ODIs this year with 129 runs, for Australia it is their left-hand opener Beth Mooney who has amassed 387 runs with one century and two fifties in 11 matches.

Phoebe Lichfield and Ellyse Perry have also been among runs for the visitors, who will be keen to put the lessons learnt about the conditions during the one-off Test to good use as new skipper Alyssa Healy looks to win another series with an eye on the 2024 T20 World Cup in Bangladesh.

The visitors will bank on Ashleigh Gardner — 21 wickets in 11 ODIs this year —
