## BSF plans marine battalion, drone squadron to secure Sundarbans

**KOLKATA/NEW DELHI, Dec 17:** A marine battalion comprising more than 1,100 personnel, a squadron of about 40 drones and all-terrain vehicles (ATVs) are part of a plan devised by the BSF to secure the strategic Sunderbans mangrove region along the India-Bangladesh border against smuggling and infiltration.

The blueprint of the plan has been prepared by the Eastern Command of the border force based in Kolkata and a final approval and financial sanction from the Union Home Ministry in Delhi is awaited, official sources told PTI. The Sunderbans, the world's largest mangrove forest cover region is an archipelago of over 100 islands and a complex network of streams, rivers, tidal creeks and channels spread over an area of 9,630 sq km in India. The rest falls in Bangladesh.

It lies on the delta of the Ganga,



Brahmaputra and Meghna rivers in the Bay of Bengal.



# FPIs flood Indian equity markets, infuse ₹ 1.5 lakh crore in 2023 despite global uncertainty

NEW DELHI, Dec 17: In a dazzling resurgence, foreign investors have graced the Indian equity markets with an influx of nearly ₹ 1.5 lakh crore in 2023, fuelled by optimism over the country's resilient economic fundamentals amid shadows of a gloomy global scenario. Experts believe that the positive trend may continue in 2024.

This follows Indian equities witnessing the worst-ever net outflow of ₹ 1.21 lakh crore by FPIs in 2022 on aggressive rate hikes by the central banks globally after net inflows for three consecutive

Going forward, as the general elections approach next year, political stability and economic growth will become focal points for foreign investors. Besides, global cues on the inflation and interest rate scenario would dictate the flow of foreign money into Indian equities, said Himanshu Srivastava, Associate Director – Manager Research at Morningstar Investment Research India.

India, with its promising position for economic growth, is expected to continue attracting foreign investment flows, he added. As of now, the foreign portfolio investors (FPIs) have made a net investment of around ₹ 1.5 lakh crore in the Indian equity markets and around ₹ 60,000 crore in the debt market. Collectively, they pumped over ₹ 2 lakh crore into the capital market, according to data available from the deposito-

FPIs made a net infusion of ₹ 25,752 crore in equities in 2021, ₹ 1.7 lakh crore in 2020, which was the best year, and ₹ 1.01 lakh crore in 2019.

In the year 2022, the flows from foreign investors were largely driven by factors like inflation and interest rate scenarios in developed markets, such as the US and UK, currency movement, the trajectory of crude oil prices, geopolitical scenario and the health of the domestic economy, among others, Srivastava said.

Heightened FPI investment was triggered by the nation's resilient economic fundamentals, forward-looking policy reforms, optimistic corporate earnings outlook, global liquidity trends, and a growing recognition of India's enduring long-term growth potential, said Bharat Dhawan, Managing Partner, Mazars in India. Mazars is an international audit, tax and advisory firm.

"India is one of the top investment destinations of FPIs. There is a near consensus now in the global investing community that India has the best prospects among the emerging economies for sustained growth for many years to come," said VK Vijayakumar, Chief Intially strengthen the rupee, thereby,

bolstering the economy.

In terms of sectors, FPIs preferred financial, IT, pharma, and energy sectors owing to the country's strength in technology and healthcare, and commitment to sustainable development contributed to the appeal for foreign investors.

FPIs started the year on a negative note, and a departure of "hot money" was seen in the first two months when they pulled out over ₹ 34.000 crore.

But, FPIs shifted gears and turned buyers in March and incessantly purchased equities till August on the resilience of the Indian economy amid an uncertain global macro backdrop. During these six months, they pumped in ₹ 1.74 lakh crore.

However, FPIs departed from equities in September, and the negative trend continued in the succeeding month, owing to economic uncertainties in the US and Eurozone regions as well as growing concerns about global economic growth.

Additionally, higher crude prices, sticky inflation numbers, and the expectation that the interest rate may continue to remain at elevated levels longer than expected prompted foreign investors to adopt a wait-and-watch ap-

In November, FPIs again turned buyers with a net investment of ₹ 9,000 crore, and the positive momentum has continued this month on the outcome of recent elections across three significant states.

Internationally, signals from the US Federal Reserve about three prospective rate cuts in the upcoming year marked a departure from the prevailing high-interest rate regime also prompted FPIs to invest. (PTI)

# Ideas and opinions of critics should be attacked but not their motives: Rajan NEW DELHI, Dec 17: Former rent fiscal to infrastructure spend-

NEW DELHI, Dec 17: Former RBI governor Raghuram Rajan, who has often been trolled for his frank views, says ideas and opinions of critics should be attacked but not their motives, as for India's progress listening was more important than preaching like a know-all vishwa guru.

In an interview with PTI, Rajan defended joining Congress leader Rahul Gandhi's 'Bharat Jodo Yatra' saying he very strongly believed in the ideas of national integration and of love, not hate and thought the 135-day foot march was an attempt to make that point.

Rejecting as "just ridiculous" the charge by government backers that he was responsible for some of the mess in the economy that Prime Minister Narendra Modi inherited, he said he had brought down inflation from double digits and had cleaned up the bad debt which the government is taking credit for now.

He also stuck to his comment -'India will be lucky if it achieves 5
per cent growth in 2023-24 fiscal
year', saying the country was indeed lucky to achieve a 6.5 per
cent expansion and he was "very
happy" with a faster growth rate.

Rajan, presently Katherine Dusak Miller Distinguished Service Professor of Finance at Chicago Booth, USA, was in India to talk about his new book 'Breaking the mould: Reimagining India's economic future', written jointly by him and Rohit Lamba, assistant professor of economics at Pennsylvania State University.

Rajan said: "You don't just designate an opponent by questioning their motives. Attack their ideas. Don't question their motives. Don't

say so and so is anti-national."

According to Rajan, having debates on India's progress is much more important than just sitting and saying 'I know everything, main vishwa guru hun'

He further said he very strongly believes in the ideas of -- national integration, inclusion, decency in public life, love not hate.

"I thought that Bharat Jodo Yatra was an attempt to make that point. So I thought it was important to support that idea of India, the idea of India that my parents grew up with," he said.

Rajan emphasised that disadvantaged communities, women will have to be much more included in the process of growth and development of India.

Responding to a question on his last year's comment in which he had said India will be lucky if it achieves 5 per cent economic growth in 2023, Rajan said, "I was absolutely right. We were lucky ... the world grew much more strongly." To buttress his argument, he said the USA beat its economic growth estimate by three percentage points, adding, "We are now (growing) at may be six and a half (per cent). That is a percentage and a half point more."

Rajan said that he is very happy to see Indian economy growing at faster rate and wants it to accelerate to 8 per cent.

While noting that all economic forecasts have a band of error, he said it is ultimately expectations of what will happen and things work out one way or the other way.

Rajan attributed the sharp uptick in GDP in the first half of the cur-

rent fiscal to infrastructure spending and good performance by large economies of the world, but added that India has to do a lot of catching up and the USD 5 trillion economy goal for 2025 is nearly impossible

impossible.

Rajan further said that even as India's growth rate is strong, private investment and private con-

sumption have not picked up.

He noted that over the last four years, from the pre-pandemic days till today, the Indian economy has grown about 4 per cent a year.

"That is way below our growth potential (economic growth rate) of 6 per cent.

"So you said inflation is contained. One of the reasons inflation is contained is we haven't even grown at our potential rate," Rajan said. Noting that for democracy to work, the government needs to share the data with the people, he said, "You can not simply pull numbers out of a hat and say...we will be a USD 5 trillion economy by 2025."

According to Rajan, it is virtually impossible for India to become a USD 5 trillion economy by 2025 unless a "miracle" happens.

"Because we are now maybe USD 3.5 trillion economy, to be a USD 5 trillion economy, you have to grow at 12 to 15 per real growth rate over the next two years," he explained.

Rajan wondered whether the government has any plan for increasing India's economic growth from the current 6 per cent-plus to 12-15 per cent.

"So you need some sensible discussion in public...you have to take economists into your conference," he suggested

Replying to a question on his earlier prediction that India is 'dangerously close' to the Hindu rate of growth, Rajan said he was right to worry that India's economic growth had slowed down. (PTI)

### Reliance biggest wealth creator, Adani Ent top all-round creator: Study

**NEW DELHI, Dec 17:** Reliance Industries Ltd was the biggest wealth creator during the five-year period from 2018 to 2023 while Adani Enterprises Ltd was the top all-round wealth creator, according to a study by Motilal Oswal Financial Services.

The study, based on stock market performance of companies, said for the fifth time in succession, Reliance emerged as the largest wealth creator, adding ₹ 9,63,800 crore wealth over 2018-23.

It was followed by Tata Consultancy Services (₹ 6,77,400 crore wealth addition), ICICI Bank (₹ 4,15,500 crore), Infosys (₹ 3,61,800 crore) and Bharti Airtel (₹ 2,80,800 crore).

"A low-profile company, Lloyds Metals, has emerged the fastest

wealth creator with 2018-23 price CAGR of 79 per cent," it said. Adani Enterprises Ltd, the flagship incubator firm of the Adani Group, is a close second with a CAGR of 78 per cent.

It said ₹ 10 lakh invested in 2018 in the top 10 fastest wealth creators would be worth ₹ 1 crore in 2023, a return CAGR of 59 per cent.

Motilal said Capri Global is the most consistent wealth creator, out-

performing the BSE Sensex in all the last five years with the highest price CAGR of 50 per cent.

Defining 'all-round wealth creators' as one which is the biggest, fastest and consistent stock market performer, the study said Adani Enterprises

has emerged as the best all-round wealth creator. It is the 9th biggest wealth creator, second fastest and fifth most consistent.

It is followed by Varun Beverages, Adani Power, Tube Investments and ICICI Bank. Reliance is ranked at No.10 on this list.

"During 2018-23, the top 100 wealth creators of India Inc created wealth of ₹70.5 lakh crore, lower than (₹92.2 lakh crore in) the previous 5-year period 2017-22. Pace of wealth creation at 21 per cent CAGR is also lower than (28 per cent) in the previous 5-year period, but well higher than the BSE Sensex return of 12 per cent," the study said. Reliance emerging as the largest wealth creator for the fifth time in succession has taken the company's overall No.1 tally to 10 in the last 17 five-year study periods. TCS and Infosys continuously remain among the top 5 wealth creators. "HDFC Bank does not feature in the top 10 list of

wealth creators for the first time in several years," the report said.

The technology sector has emerged as the largest wealth creating sector for the second year in a row, ahead of consumer and retail and financials. Technology has also gained a significant share of wealth creation - 20 per cent versus 9 per cent five years ago. Like last year, the new kid on the block is chemicals/fertilizers with 3 per cent share. The biggest losers are rate sensitive financials and auto. "Two key factors have driven PSU wealth creation, turnaround by two banks (SBI and Bank of Maharashtra) and growth in the defense sector (Bharat Dynamics, Bharat Electronics and Hindustan Aeronautics)," it added. **NEW DELHI, Dec 17:** In a bid to achieve 'Insurance For All by 2047', LIC will play a significant role and to meet that objective it is planning to launch a product especially designed for rural areas.

"The focus would be how to cover maximum rural masses who actually need insurance. In coming days, rural share will also go up to our total business kitty," LIC Chairman Siddhartha Mohanty told PTI.

He said to achieve the objective of 'Insurance For All by 2047', LIC will play a very significant role and in that direction the insurer has already started working. "I must thank the regulator. The regulator IRDAI has already proposed 'Bima Vistar', a composite product. The product will consist of life, health and property insurance," he said.

To sell those products Bima Vahak would be engaged, he said, adding, it will be a women-centric distribution channel model.

Prime Minister Narendra Modi has given a clarion call to make India a developed nation by 2047, when the country achieves 100 years of independence from British rule. As of now, India is the fifth largest economy in the world but insurance penetration is low compared to the global average.

In June this year, Insurance Regulatory and Development Authority of India (IRDAI) came out with draft guidelines for 'Bima Vahaks', which seeks to establish a dedicated distribution channel at the level of Gram Panchayats.

The guidelines proposed Corporate Bima Vahaks and Individual Bima Vahaks for the distribution chan-

nel. Corporate Bima Vahak would be legal persons registered in accordance with the respective laws and engaged by an insurer.

Corporate Bima Vahak would be legal persons registered in accordance with the respective laws and engaged by an insurer. Individual Bima Vahak could be any individual appointed by an insurer or appointed by a Corporate Bima Vahak.

Meanwhile, LIC has initiated a total digital transformation project DIVE (Digital Innovation and Value Enhancement) and appointed a consultant to steer the project. "Our objective is to get best-in-class digital initiatives for all our stakeholders, customers, intermediaries, marketing people and everybody through the project DIVE," he said.

In the first phase, the customer acquisition part is going to be transformed, he said.

Customer acquisition is done through three modesagent, bancassurance and direct sale. LIC gets most of its new customers through its agents.

Subsequently, other areas would see the transformation, he said, adding, that services like claims settlement, loans and other services will be made available at the click of a button.

"Customers need not come to the office. Sitting at home on his mobile he can access our required services...We are focusing on fintech as well and will harness its potential in expanding business," he said.

LIC is also exploring options of having its own fintech arm that can be developed as a business model, he added. (PTI)

# Number of GST return filers up 65% to 11.3 mn in 5 years: Finance ministry

**NEW DELHI, Dec 17:** The number of GST return filers rose about 65 per cent to 11.3 million in 5 years till April 2023 as compliance by tax-payers improved, the finance ministry said on Sunday.

Also, the number of active taxpayers registered under GST increased from 10.6 million as of April 2018, to 14 million.

As per data shared by the ministry, 90 per cent of eligible taxpayers are filing GSTR-3B returns by the end of the filing month in current fiscal year, up from 68 per cent in 2017-18, the first year of GST rollout.

"Simplification in Rules and Procedure in GST has resulted in increase in return filing percentage by eligible taxpayers," the ministry said in a post on X. A nationwide Goods and Services Tax (GST) was rolled out on July 1, 2017. It subsumed over a dozen local taxes like excise, service tax and VAT. The number of GSTR-3B filers increased from 7.24 million in April 2018, to 11.3 million as of April 2023.

GSTR-3B is the monthly return form for filing outward supplies details and tax payment. "With effective policy and systemic changes in GST, the compliance level in GST return filing has improved over the years," the ministry said in another post on X.

Increase in return filing across the years indicates improvement in compliance level, the ministry added. Monthly collection from GST came in at ₹ 1.68 trillion in November. It is for the sixth time that gross GST collection has crossed ₹1.60 lakh crore mark in current fiscal.

The Goods and Services Tax collection has been showing an upward trend on an annual basis since its rollout on July 1, 2017, and the average gross monthly mop-up in the current fiscal so far is ₹ 1.66 trillion, Finance Minister Nirmala Sitharaman had said in the Lok Sabha earlier this month. (PTI)

## Tata Steel aims to complete Kalinganagar project expansion, begin ops by Dec 2024: Rajiv Kumar

KALINGANAGAR (ODISHA), Dec 17: Tata Steel aims to complete expansion of its Kalinganagar project by December next year, a company official said. The company had commenced the second phase of expansion of its Kalinganagar project in Odisha in Nov 2018 to reach the production capacity of 8 million tonnes per annum, from 3 MTPA, with an investment of ₹ 23,500 crore."We are aiming to complete the project and make it operational by December end next year," Rajiv Kumar, vice-president, Operation, Tata Steel Kalinganagar (TSK), told

PTI in an interaction. The project includes raw material capacity expansion, upstream and mid-stream facilities, infrastructure and downstream facilities including a cold rolling mill complex, he said, adding that the new blast furnace being installed is India's largest with 5,870 cubic metres (cum) of inner volume. The phase 2 expansion will increase the production of flat steel at the plant to meet the growing requirements of automotive, general engineering, oil & gas, lifting & excavation and other value-added segments in the country, Kumar said. On the status

of the expansion project, the vice-president said around 80 per cent work stands completed as on date and the remaining 20 per cent is progressing well. Along with its 8 MT of annual production capacity at Kalinganagar, the total output capacity of Tata Steel's India operations will reach 26.6 MTPA. The company has an output capacity of 12 MTPA at its plant in Jamshedpur (including 1 MTPA acquired from Usha Martin), 5.6 MTPA at Tata Steel Meramandali (erstwhile Tata Steel BSL) in Dhenkanal, and 1 MTPA of NINL at Kalinganagar. # Growth rate at 6 per cent, India will remain lower middle economy by 2047, says Raghuram Rajan

HYDERABAD, Dec 17: Former Reserve Bank Governor Raghuram Rajan said India will still remain a lower middle country if the potential growth rate remains at 6 per cent annually without any rise in population by 2047 (Amrit Kaal) and will be reaching the end of the demographic dividend by then.

Speaking at a programme organised by Manthan here on Saturday, the economist said if the country does not grow faster, it will grow older (demographically) before it gets richer, which means there is the burden of an aging population to deal with also at that point.

Rajan said the GDP growth in India for the past two quarters was in the region of 7.5 per cent and if one looks at the labor force participation, it is very low and when it comes to female participation, "it is the lowest in the G20".

"India's growth potential is today about 6 per cent a year, GDP growth. If you do the math, at 6 per cent a year, you double every 12



years and therefore in 24 years, we'll be four times our per capita income. Today, the per capita income in India, as you know, is just a little below \$2,500 per person. Multiply by four, we get \$10,000 per person...So if you do the math, at our current rate of growth, you know, strong as it is highest in the G20, we don't get rich but we stay lower middle income till 2047," he

said. The former RBI chief said some southern states are growing with regards to population at below reproduction rate, in other words, the fertility rate has fallen below reproduction rate thus slowing the growth.

"In other words, we will start the process of aging at some point around that time, which leads to the alarming question if we don't

grow faster, we will grow old before we grow rich, which means we all have all the burdens of an aging population to deal with also at that point," he opined. According to him, the current

pace of growth is not enough to employ all those who are entering the labour force and insufficient to make the country get richer, before it gets older.

Describing that Prime Minister

Describing that Prime Minister Narendra Modi's vision of 100 years of Independence by 2017 as "Amritsar Kaal", he said it is going to be an ear of plenty.

Rajan said some of the developed nations moved from manufacturing to services as part of moving up the value chain after

they became richer.

Those countries are largely services economies with 70 per cent of the workforce in rich countries, typically in the service industry and 20 per cent in manufacturing, five per cent each in construction

and agriculture, he noted. (PTI)

## Britain is 'dangerously close to recession', TUC warns as GDP falls

ritain is "dangerously close to recession," the TUC warned the Sunak Government as news that the economy shrank in October dealt a blow to one of the Prime Minister's five priorities. Gross domestic product (GDP) is estimated to have fallen by 0.3 per cent during the month, down from a 0.2 per cent growth in September, the Office for National Statistics (ONS) said.

It came as all three of the main sectors that the ONS tracks fell into negative territory for the first time since July. Economists had expected GDP to contract by just 0.1 per cent. The worsethan-expected reading comes as the Bank of England is to set a new interest rate on Thursday.

PM Rishi Sunak's priorities for the year were to halve inflation, grow the economy, reduce debt, cut NHS waiting times and stop small boat crossings. But the fall in GDP shows that the overall picture for 2023 is set to be one of stagnation. On his promise on inflation, and with figures falling to 4.6 per cent in October, Sunak said that he has "delivered" on his "top priority" for the year and asked the public to judge his government on "re-

Economists have suggested the fall was largely due to lower energy costs and rising interest rates rather than government action. And BoE governor Andrew Bailey previously voiced caution, saying it was "much too early to declare victory" against inflation and that it remained "too high" at more than double the bank's target rate of 2 per

TUC general secretary Paul Nowak said that the "red warning lights should be flashing," adding: "These grim figures show the UK is dangerously close to recession. "Unemployment is rising, vacancies are falling and living standards have plummeted. "Rishi Sunak - and his cabinet of millionaires - may be cushioned from flatlining growth. "But this Conservative economic failure is hitting jobs and living standards across Britain." Nowak warned that Britain is "stuck in a rut and the Tories have no plan for getting us out of it.'

Unite general secretary Sharon Graham said: "It's no surprise that growth continues to stagnate after two years of interest rate hikes and an autumn statement promising more spending cuts. 'When politicians tell workers that they have to wait for growth before they can have a pay rise, we know that's just an excuse for another lost decade of falling living standards. "The growth that matters to people isn't GDP figures but putting cash in their pockets. "We won't see sustainable growth until we see sustainable rises in wages."

Shadow chancellor Rachel Reeves said Sunak has ended the year having failed to deliver on his promise to grow the economy. The Labour MP said: "Economic growth is going backwards leaving working people worse off. "After 13 years the Conservatives have failed on the economy and after the chaos of the past few weeks Rishi Sunak is clearly too weak to deliver for Britain.

Chancellor of the Exchequer Jeremy Hunt said: "It is inevitable GDP will be subdued whilst interest rates are doing their job to bring down inflation. "But the big reductions in business taxation announced in the autumn statement mean the economy is now well placed to start growing again." (ÎPA Serv-

## **Unanswered questions: Supreme Court's** verdict on Article 370 in Jammu and Kashmir

Narendra Modi govshortly after its triumph in the May 2019 Lok Sabha elections, to introduce a bill in Parliament in August 2019 aimed at abolishing Article 370 of the Constitution was a clear instance of political maneuvering. This decision transpired at a juncture when Jammu and Kashmir had no elected government, having transitioned from Governor's Rule in December 2018, which was initially valid for six months, to President's Rule in June 2019. The Bharatiya Janata

Party, with a longstanding desire to revoke Article 370 dating back to its Jan Sangh days in the 1950s under Syama Prasad Mookerjee, successfully realized a crucial aspect of its political agenda. Legitimate politics, regardless of one's disagreement with the rightwing party's ideology, played out. Despite holding a parliamentary majority, the party refrained from openly campaigning on its agenda to remove Article 370. The strategic political maneuvers, characterized by a certain degree of stealth, could be argued as a legitimate and calculated

The legal challenge to the abrogation of Article 370, the elimination of Jammu and Kashmir's statehood, and its division into two Union territories

(UTs) - Jammu and Kashmir, and Ladakh - surfaced in the Supreme Court in However, the Supreme Court opted to address the issue only at this juncture, paralleling its approach in the Ayodhya's Babri Masjid-Ram Janmabhoomi case in Novem-2019 and the demonetization matter of November 16, 2016, which it deliberated on in 2022.

The political resonance of the Article 370 abrogation and the bifurcation of the state into two Union Territories had subsided, with no anticipation that the Supreme Court would nullify the Article 370 revocation or the dissolution of Jammu and Kashmir's statehood.

Chief Justice D.Y. Chandrachud, accompanied by Justices B.R. Gavai and Surya Kant, affirmed the abrogation in a 352-page judgment, albeit in an indirect manner. The judges found it convenient to lean on the stipulated provision declaring it a temporary measure, while dismissing the feeble argument presented by senior lawyer Kapil Sibal and others. They contended that once Kashmir's Constituent Assembly concluded in 1956. there existed no avenue to amend Article 370.

The remaining two members of the five-member bench, Justices Sanjay Kishan Kaul and Saniiv Khanna, issued concurring

The judges' contention that the Constitution of Jammu and Kashmir and Article 370 suggested residual sovereignty is indeed intriguing. The notion becomes peculiar when considering that once Jammu and Kashmir became part of the Dominion of India in 1947 and India attained republic status in 1950, the concept of separate sovereignty for Jammu and Kashmir ceased to be applicable. However, from a standpoint of democratic morality, it would have been preferable for a significant decision, such as the abrogation of Article 370, to occur when there was an elected Legislative Assembly and government in Jammu and Kashmir.

The second major issue revolved around whether the Centre possesses the authority to abolish a state or divide it into two Union territories. The new Union Territory status hasn't appeased even Hindu-majority Jammu. The only assertion the Modi government can put forth is that the alteration in the status of Jammu and Kashmir was driven by national security concerns. National security is undeniably a delicate matter, often serving as a rationale for significant changes. Nevertheless, the ultimate safeguard lies in the trust of the people of the former state. ## Unemployed youths intruding Parliament is a desperate cry for help

This is the second time in two decades that the security of Parliament has been breached. Nevertheless, the two incidents are distinctly different from each other in nature and probably in intention. The first was planned by terrorists "to wipe out the entire political leadership of India," to quote the then home minister L K Advani. In that attack at least eleven persons had lost their lives.

But today's attack does not appear to be inspired by any terrorist idea or intention. The two intruders, including one woman, Neelam, who were arrested outside the Parliament house were shouting: "Bharat Mata Ki Jai", "Inquilab Zindabad", "Jai Bhim", "Tanashahi Nahi Chalegi" (we would not tolerate dictatorship). It is a known fact that the word tanashahi is being used by opponents of Narendra Modi for him.

Neelam, the only woman, who was protesting outside the Parliament, claimed to be a student. She said she was unemployed. Her family members told the media that she was angry because she had no job, though she was highly qualified. They said she had also taken part in the 2020-2021 farmer protests. Neelam outright denied that she was affiliated to any party or organisation. This is nothing unusual. There are number of educated youths who are angry with the administration, but are not with any organisation. They belong to the angry young men/women genre, a role which the superstar Amitabh Bachchan assayed in

countless films. Nevertheless, the intrusion of two youths and using smoke bomb inside Parliament is undoubtedly the most audacious and alarming act of protest, justified or otherwise. Just after the incident, the police claimed that it was a meticulously and wellcoordinated incident carried out by six people, all of whom were in contact with each other over Instagram and other social media platforms, where they hatched the plan. However, after some hours, a

police officer said: "A preliminary probe has revealed that Sagar Sharma, D. Manoranjan, Neelam Devi and Amol Shinde knew each other. They had become friends on social media and hatched the plan." But Neelam and Amol claimed they had no links with Manoranjan and Sagar, the officer said. Though police is trying to discover an'anti-national' angle to the incident, it cannot absolve itself of the responsibility of utter failure. The police owe an explanation to the country as to how could the two persons entered the Parliament House, despite the building having an extremely tight security.

certained how the BJP's Mysore MP Pratap Simha issue could pass for the two persons without verifying their antecedents.

Usually an MP or MLA issues passes only to the persons who are known to them. Incidentally, the BJP MPs and MLAs are most judicious in this matter. The most important revelation of the police "They had the same ideology and hence decided to give a message to the government. The security agencies are trying to ascertain if they were instructed by anyone or any organisation. During interrogation, Amol said they were upset with issues like the farmers' protest, Manipur crisis, unemployment, that's why they committed this act".

In the backdrop of this revelation, the role of the BJP MP comes under the scanner, given that Mahua Moitra has been expelled from the Lok Sabha for merely sharing her login id to the businessman Hiranandani, citing national security threat. Obviously, the BJP MP Pratap Simha must have been aware of their protesters' ideology and the organisation to which they belonged. The police also did not elaborate the content of the message, which it claims, the intruders wanted to give to the government.

Though the police is trying to look through the narrow prism of a broader conspiracy angle, they

have failed to clarify why they did not take security warnings seriously. The day was close to the anniversary of the terror attack on Parliament on December 16, 2001; obviously it called for highest order of security alert.

Moreover, America-based Khalistani terrorist Gurnatwant Singh Pannu had already warned of an attack on Parliament on this day. In this backdrop, the role of police comes under scrutiny. It is unthinkable how they managed to carry smoke sticks and break into the Lok Sabha, despite security checks and scanners inside the building. There is one more lacuna. Initially, the police said that five of them stayed at residence Vikram's Gurgaon/Gurugram before coming to the Parliament. Later it said that they had stayed at the Gurgaon residence of Lalit Jha.

Even police officers confess that the motive behind their action is still unclear. Of course, it is certain that they were disillusioned with the prevailing situation in the country. Two youths even claimed themselves as "deshbhakts (patriots)". A section of the Godi media tried to compare the incident with 93-yearold incident of the iconic youth revolutionary Bhagat Singh and his friends throwing bomb in the British colonial parliament to make them listen to the voice of

Leader of the Opposition in the

Rajya Sabha, Mallikarjun Kharge rightly said that "security breach that took place in Parliament today is a very serious matter. We demand that the home minister should come to both the Houses and give a statement on this."

The most important part of the entire story had been the Speaker of Lok Sabha, Om Birla seeking to play down the security breach, saying the youths had released "sadharan and sansani failaniwali dhuan" (normal smoke, meant to create panic), and told the MPs that there was nothing to worry. Usually, the political class becomes too aggressive in such cases. But Birla, on the contrary, was trying to play down. An insight into the whole episode would make it explicit that it was an attempts of the intruders to draw the attention of the people of the country towards the autocratic functioning of Modi and having little or no concern for the people, especially the unem-

ployed youths. Manoranjan's father Devaraj Gowda from Mysore said his son was an engineer who graduated in 2014. In absence of any job, he used to assist his father in farm. He said: "My son is an ardent follower of Swami Vivekananda. No one has perhaps read as many history books on Vivekananda as my son. He used to travel to different places for any celebration related to Vivekananda."

The intrusion of Parliament by

unemployed youths exposes the claim of Modi that India does not face the problem of unemployment. Exactly a month back, the Congress had accused Modi of leaving a legacy of record unemployment as India's jobless rate reaches a two-year high. It is a fact that growing "economic crisis" continues to spiral out of control. Congress president Mallikarjun Kharge took a swipe saying that amidst recession and inflation, the Modi government has organised such an "unemployment fair" which is forcing crores of youth to wander from

The condition of rural India is bad. The fact is government's Periodic Labour Force Survey (PLFS) data itself says that the unemployment rate among graduate youth is 13.4%. Kharge said: "Now your false advertisements and new tricks to divert attention will no longer work. Be it the elections of five states or the upcoming Lok Sabha elections, the youth of India will definitely take revenge from those who have wronged them.

Only the unemployed youth of the country will sound the bugle of the countdown of the BJP rule's end. CMIE data shows that unemployment rate in India is now at above 10%, the highest in over 2 years - when it already was the highest ever in five decades. Rural unemployment is 10.8%." (IPA Service)

## COP28 may have avoided a showdown, but conflict points remain largely unresolved

t is no surprise that COP28 Dubai has proceeded the way it has. As member countries grappled with how to formalise and approach towards the most sensitive issue of fossil fuels, the climate summit had to be extended to try and work out a consensus. According to latest reports emerging the vibrant city, the COP28 presidency has released a proposed text for the final declaration, which would call upon nations to move away from fossil fuels as part of the global fight against

This marks the success of some of the most vocal states that insisted on stronger language to indicate the resolve to end the fossil era, a goal that was being vehemently opposed by oil and coal producing countries, particularly Saudi Arabia and the UAE. The conflict was inherent in the very presidency of the summit, with the CEO of the Abu Dhabi National Oil Company (ADNOC) sitting on that chair.

A remark by summit president Sultan Al Jaber there is 'no science' indicating that a phase-out of fossil fuels is needed to restrict global heating to 1.5C had caused eyebrows to be raised. He went to the extent of claiming that a phase-out of fossil fuels would not be sustainable. In fact, there were exchanges between him and delegates at a women-oriented event on the sidelines of the main summit, where he said there was no point in pointing

OPEC members have been promoting the idea of targeting emissions rather than fossil fuels, through technologies to capture and

store emissions. But the problem is that car- kept global coal consumption buoyant. Even bon capture is exorbitantly expensive so that the focus shifts to financial resources. This would mean replacement of phase out with phase down in the declaration's language. But the vast majority of countries preferred a

India reportedly raised the issues relating to phasing out of coal, which it said won't be possible any time in the immediate future. New Delhi wanted differential goals to be set for phasing out, with developing countries requiring more time and financial resources to oursue climate change goals as there is a conflict between such goals and the aspirations of the people of developing countries, which add to the carbon footprint.

Globally coal has dominated the power sector for the past 30 years, and according to Rystad Energy 2024 will mark the start of the fuel's decline as solar and wind generation grow in popularity. New electricity supply from renewables is expected to outstrip power demand growth, leading to coal's displacement starting next year and compounding in the coming years. As a result, coal-fired generation will fall marginally to 10,332 terawatt hours (TWh) in 2024, down 41 TWh from 2023. This is a relative drop in the ocean, but it's a sign of things to come as renewables continue their growth trajectory.

Investments in coal capacity and overall usage have fallen in Europe and North America in recent years due to a combination of strict emissions policies and abundant availability of affordable natural gas supplies. Yet, enduring growth in Asia, primarily China, has

so, coal will be gradually displaced by the rapid development of low-carbon power sources, ushering in a cleaner, leaner system even as investments in new capacity in Asia continue over the next few years.

Thanks to abundant coal reserves and the need to add energy supply quickly to support economic growth, Asia is responsible for more than three-quarters of the world's coal power generation. Coal generation capacity continues to grow in the region, but the pace of new projects is slowing amid environmental concerns. Countries around the world that are highly dependent on coal, like China, Germany and the US, are developing renewable capacity fast enough and at favorable economics to displace coal easily.

Europe and North America are systematically replacing coal generation with cleaner sources like natural gas and renewables, reducing coal power capacity by more than 200 GW since 1990. Europe's decline is mainly driven by strict emissions policies, while North America has primarily replaced coal generation with gas power as abundant regional production has slashed prices.

Asia has added more than 40 GW of new coal capacity in each of the last five years and is expected to add 52 GW next year. In other words, Asia will add more coal capacity in 2024 than the total installed capacity in Argentina. Most of this new capacity is in China, followed by India and Indonesia. The additions are expected to continue until 2027, albeit slower, after which coal power plants will begin to decline. (IPA Service)

## **How much** protein do you need to build muscle?

rotein is found in every cell and tissue in the body. While it has many vital roles in the body, protein is crucial for muscle growth because it helps repair and maintain muscle tissue.

The current recommended dietary allowance (RDA) to prevent deficiency in minimally active adults is 0.8 grams (g) of protein per kilogram (kg) of body weight. However, newer research suggests individuals trying to build muscle need more than this.

Consuming less protein than the body needs has been linked to decreased muscle mass. In contrast, increased protein intakes above the RDA may help increase strength and lean body mass when paired with resistance exercise.

Why is protein important for building muscle?

Protein is made up of amino acids that act as building blocks for cells and tissues in the body. There are 20 amino acids that combine to form proteins.

While some can be synthesized by the human body, others cannot. The nine amino acids that the body cannot make are called essential amino acids.

These must be obtained through diet. When a person eats protein, it is digested and broken down into amino acids, which are involved in many processes in the body, including tissue growth and repair, immune function, and energy production.

Like other body tissues, muscle proteins are continuously broken down and rebuilt. In order to build muscle, a person must consume more protein than what is broken down. This is often referred to as a net positive nitrogen bal-

ance, as protein is high in nitrogen. If a person is not consuming adequate amounts of protein, their body tends to break down muscle to provide the body with the amino acids needed to support body functions and preserve more important tissues. Over time, this can lead to decreased muscle mass and strength.

Lastly, the body uses amino acids for muscle protein synthesis (MPS), the primary driver of muscle repair, recovery, and growth after strenuous exer-

How much protein do you need?

According to the 2020-2025 Dietary Guidelines for Americans, most healthy adults over 19 years old should get between 10-35% of their daily calories from protein. One gram of protein provides 4 calories.

This means that a person who eats 2,000 calories per day would need to consume between 50 and 175 grams of protein per day. The current RDA of 0.8 g per kg of

body weight for protein is based on the amount required to maintain nitrogen balance and prevent muscle loss. However, extending these recommendations to active individuals who are looking to build muscle may not be appropriate.

When it comes to building muscle mass, the ideal amount of daily protein a person should consume varies depending on several factors, including age, gender, activity level, health, and other variables.

However, several studies have given us a good idea of how to calculate the amount of protein adults need for muscle gain based on body weight.

What do studies say?

While most studies agree that higher protein intakes are associated with improvements in lean body mass and strength when combined with resistance training, the optimal amount of protein required to build muscle remains controversial.Here is what the latest research says.

One 2020 meta-analysis published in the journal Nutrition Reviews found that protein intakes ranging from 0.5 to 3.5 g per kg of body weight can support increases in lean body mass. In particular, researchers noted that gradually increasing protein take, even by as little as 0.1 grams per kilogram of body weight per day, can help maintain or increase muscle mass.

The rate of increase in lean body mass from higher protein intakes rapidly decreased after 1.3 g per kg of body weight was exceeded. Strength training suppressed this decline. This suggests that increased protein intake paired with strength training is best for gaining lean

body mass. Another 2022 meta-analysis published in the journal Sports Medicine concluded that higher protein intakes of around 1.5 g per kg of body weight daily paired with resistance training are required for optimal effects on muscle

strength. Researchers noted that the benefits of increased protein intake on strength and muscle mass appear to plateau at 1.5 to 1.6 g per kg of body weight per day.

Lastly, one 2022 systematic review and meta-analysis published in the Journal of Cachexia, Sarcopenia, and Muscle concluded that a protein intake of 1.6 g per kg of body weight per day or higher results in small increases in lean body mass in young, resistance-trained individuals. The results on older individuals were marginal.

Notably, 80% of studies examined in this review reported participants consuming a minimum of 1.2 g of protein per kg of body weight per day, which is still higher than the current RDA. This may be a potential contributor to the decreased effects of protein intervention in combination with resistance training in older adults.

While it is difficult to give exact figures due to varying study results, the optimum amount of protein for musclebuilding appears to be between 1.2 and 1.6 g per kg of body weight.

This means a 180-pound (81.8 kg) male, for example, would need to consume between 98 and 131 g of protein daily, combined with resistance training, to support muscle growth.

What are the best protein sources? A person can meet their daily protein needs by eating animal and plant-based protein sources.

Animal-based protein sources in-

• lean meats (beef, pork, or lamb)

- poultry eggs
- fish and seafood
- dairy products • whey protein powders.
- Plant-based protein sources include: · beans
- peas nuts
- lentils
- seeds · soy products
- plant-based protein powders.

Some nutritionists consider animal protein sources to be better than plantbased protein sources when it comes to building muscle mass. This is because they contain all the essential amino acids the body needs in sufficient amounts. They are also easy to digest.

Some plant-based proteins are less bioavailable and harder to digest. They also have varying amino acid profiles. However, individuals who opt for plantbased diets can easily supplement by eating more overall protein, and opting for a variety of foods.

To obtain all the necessary amino acids in a plant-based diet, individuals can pair ingredients such as rice and beans, hummus and pita bread, or peanut butter on whole wheat bread.

One notable exception is soy, which is highly bioavailable, has a good profile of amino acids, and is easy to di-

How much protein is too much?

Doctors generally agree that healthy adults can safely tolerate a long-term protein intake of up to 2 g per kg of body weight per day without any side effects. However, some groups of people, such as healthy, well-trained athletes, may tolerate up to 3.5 g per kg of body weight. Most research suggests that eating more than 2 g of protein per kg of body weight per day can cause

## Adenoidectomy: What to know and when to have it done

denoidectomy is a surgical procedure used to remove adenoid glands when they become swollen or enlarged due to infections or allergies. Enlarged and inflamed adenoids are known as adenoiditis; this makes breathing difficult and causes respiratory infections.

Adenoid glands are situated behind the nose at the roof. It is a mass of lymphoid tissue (which appears as a small lump of tissue) behind the nasal passage. Adenoids serve an important purpose in young children, as they act as a part of the immune system and protect the child's body from bacteria and viruses.

Removing adenoid glands can help the patient to breathe easily and sleep more comfortably. Adenoids automatically shrink around the age of 10-11 teenage years.

When is Adenoidectomy surgery needed?

A patient needs adenoidectomy surgery when their adenoids gland becomes enlarged, which can partially or completely block the airway. Patients with enlarged adenoids can have breathing problems, infections, and other complications which may



By: George M Savva urveys on lifestyle and longevity consistently find that people who do more exer-Cise live longer. So it is surprising to see a report from the Finnish Twins Cohort Study that there is little direct effect of "leisure time physical activity" on lifespan. What makes this study

different from others – and is it right? Human behaviour and biology are complex and interact with wider society and the environment. How much exercise a person gets could be linked to their genetics, diet, disabilities, education, wealth, or just whether they have enough leisure time and a safe green space. Each of these factors

could also be linked to lifespan in different ways. You can probably think of a dozen other things that might be associated both with a person's health and the amount of exercise that they do. The direction of the causation will not always be clear. Although it is certainly true that people who exercise more will, on average, live longer, it is far more difficult to know how much is caused by the exercise itself, versus these other

How can we hope to isolate this single causal effect from the complexity of people's lives? Studies of twins can help us here. Twins have similar or identical genetics and early life expe-

riences, so we can more directly test how differences in their later-life behaviour affect lifespan. This is precisely the approach taken by researchers at the University of Jyväskylä in Finland. They used exercise questionnaires given to 11,000 pairs of adult same-sex twins in 1975, 1981 and 1990, and linked this to death records

up to the year 2020. Least and most active groups

They found that, as expected, the most active had a 24% lower rate of death compared with the least active. This effect is smaller than suggested by previous studies, and most of the excess risk was confined to the least active 10% of the study

participants. They also looked at biological age, measured by the degree of DNA damage (methylation) and, surprisingly, found that both the most and the least active groups appeared biologically older

Pairing twins deals with genetics and early life differences, but what about other aspects of health behaviour?

When smoking, alcohol consumption and body mass index, or BMI, were taken into account in the analysis, the link between exercise and longevity was much reduced, with only a 9% difference in death rate between the least active group and others – and no difference between the highly and moderately active. In other words, for a hypothetical twin pair with very different activity levels but the same smoking history, alcohol use and BMI, there would be very little difference in life expectancy.

But what does it mean to change exercise levels while all other aspects of health remain con-

stant? For example, if the effect of exercise on death was mediated by weight loss, then this analysis would not reveal that link. And if exercise increases but weight does not change, then

There was also some evidence that the effect of exercise was stronger in the first 20 years after the assessment compared to the subsequent decade. So it is possible that exercise needs to be maintained to keep its longevity benefits into

This would agree with evidence from clinical trials that show more immediate benefits of exercise interventions on health in people with ex-

isting conditions. Smaller role than previously thought So what can we safely conclude from these new findings – which have won a national sports

medicine prize in Finland, but are yet to be peerreviewed? Clearly, people who exercise more live longer on average. Genetics, social factors, existing health and other aspects of lifestyle explain some of the association. We should not rule out a direct link between exercise and longevity, but this study suggests that it may have a smaller role

than previously thought. Nevertheless, experimental evidence shows that exercise can prevent illness and disability, improve mood and overall quality of life, which many would regard as more meaningful outcomes than lifespan alone.



On the basis of the complaint, a case was registered under IPC section 342 (wrongful confinement) and 323 (voluntarily causing hurt) along with the Juvenile Justice Act's section 75 that deals with cruelty to children, he added.

nipur government has decided to revise excise duty and VAT in a bid to boost the state's revenue gener-

This decision was taken in a meeting of the Manipur cabinet, chaired by chief minister N Biren

This revision of excise duty and VAT is expected to generate a revenue of around ₹ 600 crore annually for Manipur. The cabinet revised the excise

duty and VAT (Value-added Tax) under which the excise duty slab on 12 bottles will be around ₹ 600 to ₹ 6000 according to the prices of the Indian Made Foreign Liquor (IMFL). The VAT levied on the public

will be increased to 35 percent from 20 percent but on military and other exempted categories, the levy will be increased from 12 per-



cent to 20 percent. 30 percent of the revenue collected from sales of beverages plus 30 percent of VAT revenue will be used in public health and welfare

It may be mentioned here that the Manipur government recently had lifted the ban on liquor sale and consumption in the state.

Furthermore, the Manipur cabinet also gave its nod for establishing a Manipur State Beverages Corporation Limited (MSBCL). Sources close to the chief minis-

tional Highways. However, this will not be applied in areas under Municipality.

## Loktak Hydroelectric Power Project Tripura: VIP to invite greetings, appeals for peace lifespan extension receives objections

IMPHAL, Dec 17: Extension of lifespan of Loktak Hydroelectric Power Project for another 25 years, a proposal of the National Hydroelectric Power Corporation Limited's (NHPC), received strong objections from the stakeholders concerning the Loktak Lake.

The Loktak Hydroelectric Power Project had a lifespan of 35 years which had completed in 2018 but was then extended for another five years and now NHPC seeking further extension for another

The NHPC has recently sought approval from the Union ministry of environment, forest and climate change on leasing the fresh life to the project for another 25 years.

The proposal received a strong objection from various quarters and a people's convention on the topic "Impact of Loktak Hydro Electric project in Manipur" held on December 10 had resolved to oppose the extension of lifespan of the project and related activities of the National Hydroelectric Power Corporation's on Loktak Lake for another 25 years.

While adopting the resolution, the convention alleged that NHPC Ltd has exceeded its intended lifespan and since then people have raised concerns about its adverse environmental impact on the ecosystem and livelihoods of thousands of individuals in Manipur valley.

All Loktak Lake Areas Fishers Union, Manipur (ALLAFUM), a body of fishermen of Loktak Lake, strongly condemned the arbitrary move of the NHPC while joining the chorus objecting to the extension of the lifespan of the project.

It alleged that the people of the state have suffered extensively because of the hydro project and the lives of the lake dependent communities cannot be further exploited by the project for another two decades and more.

"The Loktak fishing community is suffering acutely from declining fish population in the lake and this is directly impacted by Ithai Barrage of the Loktak hydro project," it also said.

It added that Loktak is suffering from siltation, pollution and eutrophication, and the native vegetation of food and fodder value is fast disappearing from the lake.

'Loktak is suffering massive biodiversity loss because of the hydro project," the ALLAFUM stated while calling upon the Manipur government to redress the grievances of the affected people before any move to extend the lifespan of the project is considered.

However, the visit of Dalai Lama to the Himalayan state in December after over a decade brought some solace to the people scarred by the devastation, as over 30,000 people listened to his sermons on Buddhist philosophy at Gangtok's Paljor Stadium.

Sikkim hosted a G20 meeting in August, during which the state showcased its rich culture and traditions to the world. Investors showed interest in pumping in Rs 1.000 crore in the Himalayan state.

The year started with nine-yearold Sikkimese girl Jetshen Dohna Lama bringing cheers to the people of the state by winning a prestigious reality singing contest on national television, as thousands lined up on both sides of the road to welcome her upon her return home after the

The state got a new governor in Lakshman Prasad Acharya, who was sworn in on February 16, replacing Ganga Prasad.

February also saw protests over a Supreme Court verdict referring to Sikkimese Nepalis as "foreigners of Nepali origin". Civil society organisations, political parties and all sections of the society came together to demand the deletion of the word "foreigner" from the verdict, which was later done ceasing all the



protests.

The state also witnessed violent protests after the body of Padam Gurung, a student leader of Namchi Government College, was found in a drain in June. Opposition political parties and various other organisations staged protest rallies demand-

ing a CBI inquiry into the incident. Prohibitory orders under Section 144 of CrPC were imposed in Namchi town in south Sikkim in August

after protestors turned violent during a rally demanding justice for Gurung. Police baton-charged the agitators and fired tear gas shells at

them to bring the situation under

The state government constituted a one-man inquiry committee comprising a retired high court chief iustice, who in the first week of November submitted his report in which it was stated that Gurung's death was "accidental".

Meanwhile, heinous crimes against women shook the peaceful Himalavan state.

A nine-year-old girl was kidnapped, raped and murdered by a taxi driver in Pangthang area near Gangtok town when she was returning from school in April.

Another 22-year-old woman was gang-raped by a taxi driver and two of his accomplices in Ranipool area near the state capital when she was returning home after attending a graduation party.

The accused persons in both cases were nabbed, with demands being raised from various quarters for capital punishment for the rapemurder accused

The state also witnessed incidents of political violence as the opposition Sikkim Democratic Front (SDF) alleged its members were beaten up and pelted with stones when they went for political meet-The SDF submitted various

memorandums to the governor and the Centre demanding the imposition of President's Rule in the state over the "situation of political violence and vendetta politics". SDF members also staged sym-

bolic protests in various parts of the state wearing helmets to highlight the stone-pelting incidents. Footballer-turned-politician

Bhaichung Bhutia merged his Hamro Sikkim Party with prime opposition SDF and officially joined the party on November 23.

A new political party, Citizens Action Party, was launched, projecting itself as the third front in the state's politics dominated by the ruling Sikkim Krantikari Morcha (SKM) and opposition SDF. (PTI)

ALA), Dec 17: Kerala chief minister Pinarayi Vijayan on Sunday accused Governor Arif Mohammed Khan of deliberately 'attempting to destroy' the peace in the southern state by making provocative state-

The hard-hitting accusation by the CM came during a press conference held here as part of the Nava Kerala Sadas, an outreach programme of the state government. Responding to reporters' queries about the Governor calling the protesting SFI activists as "criminals", Vijayan said Khan has "reached a situation where he is saying whatever comes to mind".

"He (Khan) is forgetting that he is the Governor of Kerala," the CM

Vijayan said that he had earlier also pointed out that Khan was "deliberately attempting to destroy the peace in the state through his actions" and the same has been

proven by the Governor's subse-

"He (Khan) has tried to create the maximum possible provocation on every issue," he added.

The CM also criticised Khan for referring to the protesting activists of the CPI(M)'s student wing -- the Students Federation of India -- as "criminals" and "goondas".

"How can he use such rude words against the protesters?" he asked. Khan, a day ago, reiterated that the volunteers of the ruling CPI(M)'s students' wing were "criminals" to whom he was not accountable to explain any of his de-

(PTI) Parl panel recommends having provisions in AMASR Act to fix accountability of govt officials

**NEW DELHI, Dec 17:** A parliamentary panel has recommended to the Centre that in the upcoming amendment of the AMASR Act, "strong provisions" may be incorporated for fixing accountability of government officials to ensure necessary steps are taken timely for tackling encroachment of centrally protected monuments.

The department-related Parliamentary Standing Committee on Transport, Tourism and Culture, in its report, has also strongly recommended that provisions to "empower the local bodies for the protection of historical monuments" and to make them accountable may be incorporated in the amendment of the AMASR Act that is being worked upon by the Culture Ministry.

'Three Hundred Sixty Third Report on the Action Taken by the Government on the recommendations/ observations of the Committee contained in its Three Hundred Twenty-Fourth Report' on 'Issues relating to Untraceable Monuments and Protection of Monuments in India', was presented in both Houses last week.

The sites under the Archaeological Survey of India (ASI) are maintained under the ambit of the AMSAR (Ancient Monuments and Archaeological Sites and Remains) Act.

At present, over 3,690 monuments are under the

"The Committee takes note of the existing framework and recommends that in the upcoming amendment of the AMASR Act being worked upon by the Ministry, strong provisions may be incorporated for fixing accountability of concerned



government officials to ensure that necessary steps are taken timely for tackling encroachment of Centrally Protected Monuments," the report says.

The officials concerned should be "liable to be prosecuted in case of gross negligence of their duties" with regard to tackling encroachment of

The Committee further recommends that the Culture Ministry may examine the powers given to District Forest Officers (DFOs) under The Wildlife (Protection) Act, 1972 and "consider granting similar powers to ASI officials" in order to effectively curb the issue of encroachment of centrally protected monuments, it added.

The ministry in its response has told the panel that "amendment in the AMASR Act, 1958 is under consideration".

The panel has further observed that it is "concerned to note that out of the 3,693 Centrally Protected Monuments, security guards are posted at only 248 CPMs/sites/museums i.e. less than about 6.7 per cent of the total number of CPMs".

"The Committee notes with dismay that out of the total requirement of 7,000 personnel for the protection of monuments, the Government could provide only 2,578 security personnel at 248 locations due to budgetary constraints," the report says. The parliamentary panel observes that "budgetary constraints should not be an excuse for not providing security guards to protect our rich cultural heritage", adding it is the "bounden duty of the Government of the day to protect our cultural heritage sites".

The Committee, therefore, recommends that a budget may be provided by the government to appoint 7,000 personnel for the protection of the monuments or as per the study conducted by IIT,

"In view of this worrying state of affairs, the Committee is of the strong view that the budgetary allocation available with the Ministry/ASI for safeguarding our centrally protected monuments needs a serious relook," it has said.

The Committee recommends that the Culture Ministry, the ASI may conduct an "urgent thorough assessment" of the security requirements and budgetary allocation required for the same and a "strong case may be made to the Ministry of Finance" requesting allocation of additional funds for this purpose so as to ensure a basic state of protection for all Centrally Protected Monuments across the country to preserve them for generations to come, the panel said in its report.
