# State records decline in teenage pregnancies

GUWAHATI, Dec 19: Chief Minister Himanta Biswa Sarma on Tuesday claimed that the state has witnessed decline in teenage pregnancies which have come down drastically to 40,012 this year from the previous year's 1,05942.

Taking to the micro-blogging site X, Sarma said that the government's relentless pursuit against child marriage and teenage pregnancy is yielding positive results.

"Our relentless pursuit against child marriage and teenage pregnancy is yielding positive results. Registered teenage pregnancies in the State has come down drastically from 1,05,942 in 2022-23 to 40,012 in 2023-24. We won't rest until we bring this figure to zero," Sarma wrote on micro-blogging

The chief minister also pre-



sented data indicating a significant reduction in teen pregnancies across districts

As per the data, Dhubri and South Salmara, with the highest cases at 14,769 last year, decreased to 5,482 this year. Similarly, such cases in Nagaon and Hojai declined from 12,107 to 4,578, and Barpeta and Bajali decreased from 11,449 to 4,000.

It is worth mentioning that recently, Sarma had declared to eradicate this social issue by 2026,

secretaries as child marriage prevention officers. Sarma also claimed a notable reduction of over 33 per cent in maternal deaths and nearly 15 per cent in child deaths since the launch of the crackdown.

"Child marriage is a social evil which also manifests undesirable health outcomes such as high infant and maternal mortality rates. Our crackdown has yielded encouraging results in the women & child health sphere. By 2026 Assam will end this abhorrent practice," Sarma had said.

Further, highlighting the challenges, Sarma emphasised that Assam's infant mortality rate (IMR) and maternal mortality rates (MMR) had surpassed the national average, particularly in specific districts. He attributed the primary cause to (CONTD. ON PAGE-9)

#### BJP, Congress announce candidates for NC Hills Autonomous Council election

GUWAHATI, Dec 19: The Bharatiya Janata Party (BJP) and the Indian National Congress (INC) on Tuesday announced the names of all their 28 candidates for the forthcoming Members of Autonomous Council (MAC) election to the 13 NC Hills Autonomous Council, scheduled for January 8, 2024.

According to an official statement, the selection was done by the committee formed by the BJP. The declaration was made formally in the office of the BJP Assam Pradesh on Tuesday.

In this election, a few new candidates were included. such as Mohet Hojai, Niranjan Hojai, Rupali Langthasa, S T Jem Hrangkhol, and Namrang Jeme.

"Apart from this, several new faces were seen in constituencies like Mahur, Langting, Dautuhaja, Maibang (E), and Maibang (W). In the prestigious Haflong constituency, where the BJP has never won an election so far, the saffron party has chosen the present president of BJP Dima Hasao," the statement added.

On the other hand, Congress also released a list of its party candidates for the said election.

Recently, during a press conference, the election commissioner, Alok Kumar, said that due to the unavailability of electronic voting machines (EVMs), the elec-



tion will employ traditional ballot papers. He further informed that the deadline for filing nominations in all 28 constituencies is December 21, with

application scrutiny slated for the following day. The total voters count in Dima Hasao district's constituencies is 1,41,124, with 70,485 men and 70,639 women, he said.

"Withdrawal of candidature can be done until December 22, and the final list of candidates will be published on the same day. Polling hours are set from 8 am to 4 pm on January 8, (CONTD. ON PAGE-9)

#### Leopard attack GUWAHATI: Three persons,

### Oppn will remain in opposition with less strength in 2024 LS polls: Modi

NEW DELHI, Dec 19: Prime Minister Narendra Modi on Tuesday accused the opposition parties of providing "muted and indirect" support to the security breach incident in Parliament and asserted that they will remain in opposition with further reduced numbers in the 2024 Lok Sabha elections because of their conduct.

Addressing what he said was the last BJP parliamentary party meeting this year, Modi pretty much laid out the theme for the ruling alliance's campaign for the 2024 Lok Sabha election as he took a swipe at the INDIA bloc over its meeting on Tuesday.

Slamming opposition parties for disrupting Parliament proceedings, Modi said they were giving a "political spin" to the incident in frustration over their losses in the recent



assembly polls. Their goal is to throw out his government but the government's goal is to ensure a bright future for India," he added.

"Some People are uniting in their intent to remove the BJP from power while we are patriots working for the betterment of India. They are utilising their strength to remove

ing our strength for the betterment of India," parliamentary affairs minister Pralhad Joshi said, quoting the Prime Minister.

Modi asserted that the opposition's conduct in Parliament will ensure their numbers go further down in the 2024 Lok Sabha polls while the BJP boosts its tally. Pointing to some empty rows in the auditorium where all BJP MPs had collected, he said these will be filled up after the 2024 polls.

Referring to the December 13 incident of two persons jumping into the Lok Sabha chamber from the visitors' gallery and opening smoke cans, he said anyone who believes in democracy will not accept such an act. #### Section 144 imposed in Manipur

CHURACHANDPUR, Dec 19: The Manipur government has imposed prohibitory orders under Section 144 of the CrPC for two months in Churachandpur district following fresh violence, according to an official order.

Various parts of the northeastern state have been rocked by ethnic strife since May this year. Incidents of sporadic violence were reported from several places in Churachanddistrict, especially in Thingkangphai village, on Monday.

"There are still chances of breach of peace due to the confrontation between the two groups of people... and the situation is still tense," the district magistrate said in an order. The prohibitory orders prohibiting gathering of five or more people and carrying arms were imposed on Monday and it would be in force till February 18, 2024. (CONTD. ON PAGE-9)

### Three ULFA(I) linkmen arrested in Guwahati

GUWAHATI, Dec 19: Close on the heels of recent blasts in three major towns of Assam, three suspected ULFA (Independent) linkmen have been arrested from a house in Guwahati, police said on Tuesday.

Acting on a tip-off, a police team raided a house in Pandu area of the city late on Monday night and nabbed a person, identified as Ashim Adhikari, who was allegedly involved in the recruitment of cadres for the banned outfit. Following his interrogation, the police apprehended two others from the same area and seized a pistol and some cartridges from their possession.

Security has been tightened across the state following recent blasts near security establishments in Tinsukia, Sivasagar and Jorhat.

The ULFA(I) had claimed responsibility for the blasts stating it was carried out in response to the "arrogance" of state director general of police G P Singh who is trying to

The DGP had in response to the ULFA(I)'s allegations said they 'always refer to me and if they have a cause with me, they can always target me. I live in Kahilipara and my office (DGP headquarters) is in Ulubari, (both in Guwahati). They can come and target me. Why are they harassing the common people by lobbing a

grenade here and there'. Singh had in another statement earlier said that the police was "committed to wipe out the remnants of terrorism that impedes the growth of the state. And for that, if we have to sacrifice our life, we shall not hesitate, nor shall we waver from our determination to use full the might of law against those who stand in the path of our state's growth, progress and development". ## PM Modi speaks to Netanyahu, calls for early restoration of peace

**NEW DELHI, Dec 19:** Prime Minister Narendra Modi on Tuesday held a "productive" conversation with his Israeli counterpart Benjamin Netanyahu on the Israel-Hamas conflict including "shared concerns" over the safety of maritime traffic in the region.

In the phone talks, Modi emphasised on an early and peaceful resolution of the conflict, in-

cluding the release of all hostages,

well as continued humanitarian assistance to the affected people. The prime minister's office (PMO) said Modi received a phone call from the Israeli prime minister. "Had a productive exchange of views with PM @netanyahu on the ongoing Israel-Hamas conflict, including shared concerns on the safety of maritime traffic," Modi posted on 'X'.

"Highlighted India's consistent stand in favour of early restoration of peace & stability in the region with continued humanitarian assistance for the affected," he said. There have been concerns over the safety of maritime traffic in the region. A missile reportedly fired by Yemen's Houthi militants hit a commercial tanker in the Red Sea off the coast of Yemen last week triggering concerns. In a statement, the PMO said Netanyahu briefed Modi on the recent developments in the ongoing Israel-Hamas conflict. "The two leaders shared concerns regarding the safety of maritime traffic," it said.

"The prime minister reiterated the need for continued humanitarian aid for the affected population and emphasised an early and peaceful res-

olution of the conflict, including through "dialogue and diplomacy" as ISTAE - Hamas conflict the release of all hostages, through

dialogue and diplomacy," it added. The PMO said the two leaders agreed to remain in touch. Israel has been continuing its military offensive in Gaza as part of its retaliation to the unprecedented attack on Israeli cities by Hamas on October 7. Hamas killed around 1,200 people in Israel and kidnapped more than 220 others some of whom were released during a brief ceasefire. Around 17,000 people have been killed in Gaza in the Israeli offensive, according to the Hamasrun authorities in Gaza. India has been calling for deescalation of the situation and creating conditions for an early resumption of direct peace negotiations towards a two-state solution to the Palestine issue. India strongly condemned the terror attack by Hamas. (PTI)

## Breathing during sleep may be influencing how our brains form memories: Study

NEW DELHI, Dec 19: Our breathing during sleep may be influencing how memories in our brains are being consolidated, a new study has found. While it is known that sleeprelated brain rhythms are linked with reactivation of memory contents during sleep, researchers from Germany and the UK found that these rhythms, such as oscillations and

spindles, are linked to breathing. "Our results show that our breathing and the emergence of characteristic slow oscillation and spindle patterns are linked," said Thomas Schreiner, Department of Psychology, Ludwig-Maximilians-Universität München, Germany, and the corresponding author of the study published in the journal Nature Communications. Sleep spindles refer to short bursts of increased brain activity during sleep.

"Although other studies had already established a connection be-



tween breathing and cognition during wake, our work makes clear that respiration is also important for memory processing during sleep," said Schreiner.

For the study, the researchers included 20 study participants and over the course of two sessions showed them 120 images, all of them associated with certain words. The participants then slept for

around two hours in the laboratory. The brain activity over the entire duration of learning and sleeping was recorded, along with their breathing. Upon waking up, the inassociations they had learned.

The researchers found that along with reactivation of content learnt prior to sleep, the "precision of these sleep-related brain rhythms increases from childhood to adolescence and then declines again during aging.

Further, because respiration frequency also changed with age, the researchers analysed the recorded data on breathing and were able to establish a connection between the sleep-related brain activity and

As older people often struggle with sleep disorders, respiratory disorders, and declining memory function, the team said they plan to investigate if they were linked and if interventions such as CPAP masks, that help breathe unobstructed, made sense from a cognitive perspective. (PTI)

## RBI tightens norms to check evergreening of loans by lenders through AIFs

MUMBAI, Dec 19: In a move to curb "evergreening" of loans, the Reserve Bank on Tuesday barred banks and NBFCs from investing in any scheme of Alternative Investment Funds (AIFs) having investment in companies that have taken loan from the lenders concerned in the past 12 months

Banks and NBFCs, which are Regulated Entities (RE) under the Reserve Bank of India (RBI), make investments in units of AIFs as part of their regular investment operations.

Venture capital funds, angle funds, infrastructure funds, private equity

funds and hedge funds, among others, are AIFs.

In a circular PRI said "cortain transactions of PFs involving AIFs that

In a circular, RBI said, "certain transactions of REs involving AIFs that

raise regulatory

come to our notice".

These transactions entail substitution of direct loan exposure of REs to borrowers, with indirect exposure through investments in units

of AIFs, it said.



RBI said that in order to address concerns relating to possible evergreening through this route", REs cannot make investments in any scheme of AIFs which has downstream investments either directly or indirectly in a debtor company of the lender.

Further, it has directed lenders that such investments would be required to be liquidated within 30 days.

In case, REs are not able to liquidate their investments within the prescribed time limit, they should make 100 per cent provision on such investments, it added.

The debtor company of the RE means any entity to which the lender currently has or previously had a loan or investment exposure anytime during the preceding 12 months. (PTI)

## RBI tightens norms to check Telecom Bill 2023 progressive, forward-looking, brings predictability: Industry captains

Legislation ensures predictability and availability of spectrum covering aspects such as refarming, harmonisation and trading/leasing/sharing

**NEW DELHI, Dec 19:** The industry on Tuesday said the new telecom Bill introduced in the Lok Sabha is progressive and forward-looking, and marks groundbreaking reforms by streamlining India's licensing landscape.

Leading voices of telecom industry, including Bharti Airtel MD and CEO Gopal Vittal, and Vodafone Idea CEO Akshaya Moondra, lauded various provisions of the Bill, especially those related to security provisions, right of way, and simplification of licensing among others.

"I would like to warmly compliment the government for introducing a progressive and forward-looking Telecommunications Bill in Parliament. The Bill suggests groundbreaking reforms by streamlining India's licensing landscape," Vittal said.

He said the Bill aims to simplify the current "convoluted system" that includes various types of licensing (license, registration, permission), into a "more cohesive and efficient" authorisation-based regime.

"The seminal spectrum reforms initiated in 2021 eliminated SUC for future spectrum assignments and provided the option of moratorium of past spectrum dues and annual spectrum roadmap. These reforms have now gained further momentum under the proposed Telecommunications Bill 2023," he

The proposed legislation ensures predictability and availability of spectrum covering aspects such as refarming, harmonisation and trading/leasing/sharing. This, he said, will lead to the creation of a robust digital infrastructure and increased pen-

etration of services, benefitting all Indians.

The captains of the telecom industry also appreciated the reforms related to Right of



Way (RoW).

Business

"The proposed reform on RoW is yet another seminal move that is set to accelerate the rollout of telecom infrastructure, including 5G in the country. The move will provide the necessary enforceability of central RoW rules at the local level," Vittal said.

The provisions related to public and private property, common ducts further instill confidence in the industry for faster rollout, he added

According to him, another pivotal reform involves the restructuring of penalties, as the government simplifies the penalty framework regime under the proposed Bill.

This will be achieved through a tiered sys-

This will be achieved through a tiered system of graded penalties proportionate to the breach.

"The introduction of a voluntary undertaking and an appeal process within the government aims to mitigate litigations thereby promoting more efficient resolution of disputes," he said.

Vittal said the government has rightfully retained oversight of telecom networks from a sovereign security perspective, a requirement integral to India's telecom licences over the last two decades.

Vodafone Idea CEO Akshaya Moondra described the Telecommunications Bill, 2023, as a watershed moment in the telecom reform process and said it reaffirms the the government's commitment to provide Indian telecom with a future-fit framework that helps achieve the growth aspirations of new India.

"The Bill carries several forward-looking provisions that will help deliver the benefits of digital connectivity to all our citizens. We warmly welcome the rationalisation of penalties and the legal enforceability of right of way provisions, a long-standing request of the industry," he said.

Security of telecom networks is paramount, and the Bill recognises telecom as

critical infrastructure and prescribes punitive consequences for those who damage it, he

"By highlighting the duties of users, the Bill puts equal responsibility on consumers to meet the requirements of national secu-

rity," he said.

The government on Monday introduced a new telecom Bill in the Lok Sabha, which seeks to allow the authorities to temporarily take control of telecom services in the interest of national security, provide for a non-auction route for allocation of satellite spectrum and drop OTT in the definition of services.

The Telecommunications Bill, 2023, proposes that the Centre will take temporary possession of telecom networks in case of any public emergency or in the interest of public safety.

The Bill proposes to stop transmission and intercept messages in case of public emergency, in the interest of the public, to prevent incitement for committing offence.

"On the occurrence of any public emergency, including disaster management, or in the interest of public safety, the central government or a state government or any officer specially authorised in this behalf by the central government or a state government, if satisfied that it is necessary or expedient so to do, by notification — take temporary possession of any telecommunication service or telecommunication network from an authorised entity," the Bill said.

The Bill was introduced in the lower House by communications minister Ashwini Vaishnaw amid a din over the Opposition demanding a statement by home minister Amit Shah on the Parliament security breach issue. (PTI)



#### Rupee falls 9 paise to close at 83.19 against US dollar



MUMBAI, Dec 19: The rupee declined by 9 paise to settle at 83.19 (provisional) against the US dollar on Tuesday due to dollar buying by importers amid lingering worries over oil supplies through the Red Sea route.

Forex traders said that positive sentiment in the stock market, a weak greenback against major currencies overseas and steady crude oil prices restricted losses in the local currency.

At the interbank foreign exchange market, the local unit opened flat at 83.10 against the greenback and traded between the peak of 83.09 and the lowest level of 83.22. It finally settled at 83.19, registering a loss of 9 paise over its

previous close.

Traders said dollar buying by importers following a recent spike in the rupee amid increased FII inflows kept the unit under pressure. On Monday, the domestic currency settled 7 paise lower at 83.10 against the dollar, a day after witnessing a jump of 27 paise on Friday. The rupee breached the 82 level twice this week to touch a

high of 82.90.

Traders are also concerned over oil supplies amid attacks by rebel group Houthis on ships. While Maersk on Tuesday announced that it may reroute some of its vessels around Africa's Cape of Good Hope, the US and a host of other nations are creating a new force to protect ships transiting the Red Sea that have come under attack by drones and ballistic missiles fired from Houthi-controlled areas of

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.04 per cent lower at 102.13 on Tuesday.

# Google to pay \$700M in antitrust settlement reached with states

#### Like apple does in its iphone app store, google collects commissions ranging from 15% to 30% on in-app purchases

SAN FRANSISCO, Dec 19: Google has agreed to pay \$700 million and make several other concessions to settle allegations that it had been stifling competition against its Android app store — the same issue that went to trial in a another case that could result in even bigger changes.

Although Google struck the deal with state attorneys general in September, the settlement's terms weren't revealed until late Monday in documents filed in San Francisco federal court. The disclosure came a week after a federal court jury rebuked Google for deploying anticompetitive tactics in its Play Store for Android apps.

The settlement with the states includes \$630 million to compensate U.S. consumers funneled into a payment processing system that state attorneys general alleged drove up the prices for digital transactions within apps downloaded from the Play Store. That store caters to the Android software that powers most of the world's smartphones.

Like Apple does in its iPhone app store,

Google collects commissions ranging from 15% to 30% on in-app purchases — fees that state attorneys general contended drove prices higher than they would have been had there been an open market for payment processing. Those commissions generated billions of dollars in profit annually for Google, according to evidence presented in the recent trial focused on its Play Store. Consumers eligible for a piece of the \$630 million compensation fund are supposed to be automatically notified about various options for how they can receive their cut of the money.

Another \$70 million of the pre-trial settlement will cover the penalties and other costs that Google is being forced to pay to the states.

Google also agreed to make other changes designed to make it even easier for consumers to download and install Android apps from other outlets besides its Play Store for the next five years. It will refrain from issuing as many security warnings, or "scare screens," when alternative choices are being used.



The makers of Android apps will also gain more flexibility to offer alternative payment choices to consumers instead of having transactions automatically processed through the Play Store and its commission system. Apps will also be able to promote lower prices available to consumers who choose an alternate to the Play Store's payment processing.

Washington DC Attorney General Brian Schwalb hailed the settlement as a victory for the tens of millions of people in the U.S. that rely on Android phones to help manage their lives. "For far too long, Google's anticompetitive practices in the

distribution of apps deprived Android users of choices and forced them to pay artificially elevated prices," Schwalb said.

Wilson White, Google's vice president of government affairs and public policy, framed the deal as a positive for the company, despite the money and concessions it entails. The settlement "builds on Android's choice and flexibility, maintains strong security protections, and retains Google's ability to compete with other (software) makers, and invest in the Android ecosystem for users and developers," White wrote in a blog post.

Although the state attorneys general hailed the settlement as a huge win for consumers, it didn't go far enough for Epic Games, which spearheaded the attack on Google's app store practices with an antitrust lawsuit filed in August 2020.

Epic, the maker of the popular Fortnite video game, rebuffed the settlement in September and instead chose to take its case to trial, even though it had already lost on most of its key claims in a similar trial targeting Apple and its iPhone app store in

2021. The Apple trial, though, was decided by a federal judge instead of the jury that vindicated Epic with a unanimous verdict that Google had built anticompetitive barriers around the Play Store. Google has vowed to appeal the verdict.

But the trial's outcome nevertheless

raises the specter of Google potentially being ordered to pay even more money as punishment for its past practices and making even more dramatic changes to its lucrative Android app ecosystem. Those changes will be determined next

Those changes will be determined next year by U.S. District Judge James Donato, who presided over the Epic Games trial. Donato also still must approve Google's Play Store settlement with the states.

Google faces an even bigger legal threat in another antitrust case targeting its dominant search engine that serves as the centerpiece of a digital ad empire that generates more than \$200 billion in sales annually. Closing arguments in a trial pitting Google against the Justice Department are scheduled for early May before a federal judge in Washington D.C. (AP)

# 47 aspirants for Cong LS tickets in state

"Barpeta MP Abdul Khaleque got his application form collected on Monday, though the other two MPs - Pradyut Bordoloi from Nagaon and Gaurav Gogoi from Kaliabor – are yet to take their papers," the source said.

He, however, said the deadline for receiving



applications could be extended.

"As a Parliament session is going on, our leaders are busy. The time for accepting the applications is likely to be extended," he said.

The process for accepting the filled-up forms began on December 11, and each applicant is

required to deposit a fee of Rs one lakh, according to a circular issued by the Assam Pradesh Congress Committee (APCC) earlier this

With the Congress being a part of a 15-member opposition forum in the state, aiming at contesting the 2024 Lok Sabha elections together, it will have to refrain from fielding candidates from certain constituencies, the party said.

#### **Suspension of MPs** threat to democracy

n an unprecedented move, the Narendra Modi-led BJP government has suspended a total of 92 opposition MPs, with an additional 50 from the Lok Sabha, sparking concerns about the functioning of a democratic parliament. The suspension, the highest in 34 years, has led to accusations that the government aims for an Opposition-free Parliament. The suspended MPs, a mix of diverse non-BJP representatives, gathered on the Parliament front, showcasing their hidden talents and openly celebrating their suspension with mimicries of Rajya Sabha Chairman Jagdish Dhankar. This unusual spectacle unfolded as the INDIA bloc, comprising various opposition parties, intended to convey their unity and future plans to the electorate during a meeting at the Ashoka Hotel in the Capital. The Congress strongly criticized the Modi government for "bulldozing key bills" without any dissent, portraying a government seemingly indifferent to parliamentary decorum. The mass suspensions, 78 in a single day, marked a historic high for both the Rajya Sabha and the Lok Sabha.

A total of 33 Lok Sabha MPs and 34 Rajya Sabha MPs now face suspension for the remainder of the Winter Session. The cases of three Lok Sabha MPs and 11 Rajya Sabha MPs were referred to the Privileges Committee of Parliament. The situation raises questions about the Modi government's intentions, with critics suggesting a shift towards authoritarianism. The term "undeclared emergency" is being evoked, emphasizing the unprecedented scale and impact of the suspensions. A recent breach in Parliament security further fueled concerns, exposing vulnerabilities in the New Parliament's armor. Denying these weaknesses could be perilous for the government, as safeguarding the sanctity of Parliament requires more than a mere show of strength. Some citizens report hearing strange noises in their ears, humorously speculated to be the suspended MPs cursing the government. The broader concern is that such curses may affect the entire nation. A sense of foreboding has lingered since May 2014, and there is talk of a dark curse on India, solidifying over a decade.

As the Winter Session progresses, the absence of a significant opposition presence signals a challenging period ahead. The recurring ruckus in Parliament becomes a lullaby for BJP leaders, who seemingly sleep soundly amid the chaos. The BJP appears undisturbed by the tumultuous atmosphere, treating it as the 'Sound of Music' that accompanies Prime Minister Narendra Modi and his MPs to bed each night when Parliament is in session. Since the December 13 Parliament security breach, chaos has dominated both Houses. However, the Modi government seems more concerned with countering the electoral threat posed by the INDIA bloc than addressing security concerns. The recent victories in Madhya Pradesh, Chhattisgarh, and Rajasthan have not guaranteed BJP success in the 2024 Lok Sabha elections, adding to the government's nervousness, especially considering the Congress's victory in Telangana. The BJP's struggles in southern states intensify as the party is seemingly informed that the south of the Vindhyas is out of bounds, presenting a considerable challenge. The Opposition's potential boycott of Parliament could escalate if MPs collectively resign, leaving Prime Minister Narendra Modi grappling with the consequences. In this tumultuous political landscape, the BJP government's focus on political threats rather than addressing parliamentary issues raises significant concerns about the state of Indian democracy. The Winter Session remains unpredictable, with the Opposition's response becoming a crucial factor in determining the future trajectory of the nation's political landscape.

#### **Reforming the Election Commission: A critical** analysis of the 2023 bill

The inception of The Chief Election Commissioner and Election Commissioners (Appointment, Conditions of Service, and Term of Office) Bill 2023 marks a crucial step in addressing a gap overlooked by the Constitution-makers concerning the procedural aspects of appointments within the Election Commission of India

The inception of the bill was prompted by a directive from a Constitution Bench of the Supreme Court. This directive. disapproving of the arbitrary manner in which appointments to the Election Commission were previously made, established a mechanism for the process.

However, this mechanism, consisting of the Prime Minister, the Leader of the Opposition, and the Chief Justice of India, curgovernment's unchecked authority to appoint individuals to the panel. The judicial decree, nonetheless, emphasized that its prescription would be of a limited duration until Parliament enacted legislation on the matter.

The new bill, ratified by the Rajya Sabha on Tuesday, essentially restores to the current government the authority to determine the composition of the panel. It outlines a committee, consisting of the Prime Minister. the Leader of the Opposition, or the leader of the largest party in the Lok Sabha, and a minister designated by the Prime Minister, responsible for selecting the Chief Election Commissioner and the other Election Commissioners. The provision eliminates the presence of a judiciary representative in the panel, thereby reverting the choice of the panel back to the executive.

Upon examination, we observe no significant deviation from the period when the President appointed individuals based on the recommendations of the Union council of ministers, led by the Prime Minister.

salary and perks of the Chief Hapag-Lloyd indicate that large Commissioner (CEC) and the Election Commissioners (ECs), will now align with those of a Supreme Court judge, in contrast to the initial proposal equating them to the Cabinet secretary. Notably, the search committee tasked with shortlisting names for the EC will be led by a Cabinet minister, a departure from the initial arrangement with the Cabinet secretary at the helm. Additionally, the bill aims to shield commissioners from legal challenges during their tenure. These alterations are commendable as they are poised to enthe independence, hance autonomy, and prestige of the commission.

The major institutions of our democracy, including the constitutional courts, the Election Commission, and the Comptroller and Auditor-General, have, despite occasional displays of weaknesses, consistently upheld the independence expected of them. The paramount prerequisite for the flourishing of democracy is unquestionably free and fair elections, a responsibility primarily entrusted to the Election Commission.

The integrity of a democratic institution hinges not solely on the determination of those in charge but on institutional mechanisms designed to ensure both independence and fairness. It is the character of the institution itself, rather than the individuals within it, that should dictate its quality. The Election Commission of India, for the most part, has met people's expectations, drawing strength from democracy and reciprocally empower-

Although occasional allegations suggest the EC may align with the government in power, they have predominantly upheld the people's will in the electoral process. One can only anticipate that the government, wielding its newfound authority, will use it to bolster the Election Commission's character, further fortifying our representative democracy and parliamentary system. ## Narendra Modi-The quintessential unifier

The Supreme Court's verdict on the abrogation of Article 370 would give a momentous moral boost to the ruling Bharatiya Janata Party (BJP) led by Narendra Modi. Modi's efficient leadership and pragmatic nationalistic approach seem to gain enormous support from across the country. The judiciary had unequivocally stood in tune with what the government executed in 2019. Jammu and Kashmir since then was ripped off its prerogatives and outcries for reinstating its special status were heard from selective corners. But the government's excellent initiatives in the direction of giving the area a fillip in development were deeply convincing and self explanatory. There have been concerted efforts to translate the already chaotic and deteriorating atmosphere in the most beautiful landscape in India into a meaningful possibility of tranquility and peace and the result of it began to show up with the world community noticing it. The pomp and discipline with which the national celebrations are celebrated in Jammu and Kashmir these days gives us the gist of transformation that the present union territories have come across

Jammu and Kashmir's journey as a terrain of terror to a destination that people would prefer to land as a tourist was an affirmative ascent in its recent history. This was possible with the effective involvement of the Indian army that went out on a hunting expedition tracking the terror hideouts and brilliantly eliminating them. People's support for a positive change could catapult the momentum of its makeover further. But the Supreme Court's upholding the abrogation would exacerbate the dilemma of people and parties that stood for diand disenchantment seems to help the government to expose their double standard and hypocrisy and corruption.

Whatever, the court came up

with its pronouncement at a time when the ruling party and its leadership are in high spirits after winning elections in three crucial states and the national elections almost at a hand-stretch distance.

Critical decisions and drastic transformative changes have been becoming talking points since 2014. The general election that year witnessed the rise of a true nationalist and statesman. The Modi factor came as a sweeping generational change and the impact of its gaining hold on the national arena was unprecedented. Having decimated decades of

Congress rule, his rise to the top job was not only an aspirational moment for a huge number of voters who voted for his party but with that began a fresh and defining chapter of nationalism in India with a majoritarian thrust capturing the imagination of a new version of vote bank politics. This had been subdued and pushed hard to insignificance ever since the country jumped into freedom and its Nehruvian Socialism holding its reigns for decades. And the Modi rise had given India a meaningful mandate, the largest one that any political party managed to win from outside the Congress bandwagon. For the Congress, the landslide victory of Rajiv Gandhi in 1984 was the last humongous people's verdict. The national election after the assassination of Indira Gandhi was principally an exercise of sympathy that the nation remorsefully executed. People voted on the loss that the untimely death of their leader caused but the vacuum was not effectively filled by her son though he enjoyed a landslide victory. The party was later reduced almost to a nominal player that won meager seats and its dominance came clattering down with the saffron storm in 2014.

India's enormous exercise of casting the franchise is an example of democracy celebrating its principles with greater assertion of values. Modi's victory in 2014

was criticized as a calamity for India and a blot on its democratic values. This was mainly due to his being cornered with indescribable malignity by a section of the media in India and abroad. A deliberate accusation further castigated him to be the monster ruler who had intentionally given permission for the butchery of Muslims in his home state Gu-

jarat during the Godhra post riots. It was al most predicted and conceded

that Modi by no means would ascend to the top of world's largest democracy. I still remember my conversation with an eccentric traveler from California to India's northeast in 2014. A T-shirt designer, as he introduced him to me during my travels to this area, was on a cvcling expedition to one of the most strategically important locations in the state of Arunachal Pradesh along the India-China border. He was firmly convinced of the reasons that he thought would defeat Modi. For him there was not even a microscopic chance for Modi to win the popular mandate. The hate-mongering was deafeningly resolute and potty mouthed sociopaths continued to dehumanize him until the judiciary gave him a clean chit. But Modi's party won 282 of the 543 seats in parliament, reducing its principal opposition the Congress to a mere 44 seats, practically trimming its right to lead

Probably, Modi's experiment to bank on the majority sentiments towards the remodeling of a state took an unusual turn. India's clueless colonial masters had decided to divide the country between its Muslim population and the gargantuan Hindu population which the former was terribly intolerant to. But an anglicized Jawaharlal Nehru re-

had chiseled a secular nation out of an amputated landscape which accommodated Hindus and other Indic religions and a section of the undecided Muslims that refused to migrate to an Islamic Pakistan. The Modi rise in India's electoral spectrum was principally accentuating a fundamental sentiment, a discontent that continued to consume the essential readiness of its electorate to democratically take a revenge on the animalization of a polytheistic religious framework called Hinduism. Aggressively subduing the essential cultural vigor of generations of a subverted Hindu majority, the successive ruling class that followed the Nehruvian secularism had ruthlessly distorted the values that it preserved for centuries. There has always been a tribe of insinuators successively working to distort, dismantle and disgustingly strangulate its existence in the name of secularism, liberal-

That was the moment when Modi came to the national stage, essentially gaining accolades for the Hindu unity that the post Godhra riots had blessed him with. His performance as a futuristic Chief Minister with development as his mission had further made him electorally unassailable in the Sangh Parivar cohort. Modi's success has multifaceted implications. He facilitated the country with greater quality of development but he did not forget to cement its civilizational existence with universal values that the landscape once projected and propagated. This combination of nationalistic spiritual values with the latest count of scientific temperament was a perfect combination. The values enshrined in India's spiritual texts have found global acceptance with the government officially launching them for international platforms. In his yet another surprising move, Modi had launched the party's most prominent saffron clad Yogi as the Chief Minister of Uttar Pradesh. Probably, that was one of the trump cards that Modi's political brilliance exerted with futuristic calculations.

Yogi, being voted to power for the second term, has transformed the state into an investment destination and its social ambiance of febrile callousness and corruption seem to have almost been rooted out. Modi has not only managed to culturally unite the scattered sentiments of a huge section of the country's population, but he could also help it survive irrespective of dividing factors such as castes and outcries for a head-counting in the name of castes sprung from across the opposition camp. The recent election results could further enhance his image as an ultimate unifier of nationalistic sentiments rising above the pulpit of caste arithmetic. ## Yemen's Houthi rebels attack on ships poses threat to trade through red sea

Temen's Houthi rebels have carried out hijackings, missile strikes, and drone attacks on ships, leading Danish shipping and logistics company AP Moller-Maersk and German shipping and container transportation firm Hapag-Lloyd to temporarily suspend shipments via the Red Sea.

The announcements made on Friday by AP Moller-Maersk and companies are now recognizing the security risks in the Red Sea region. However, there could be potential effects on global oil markets and the cost of energy for consumers. The extent of the disruption will depend on how major international actors respond to the impending crisis, according to experts. According to a statement from Maersk, their decision to pause shipments through the Red Sea is based on their worries about the increasingly dangerous security situation in the southern Red Sea and Gulf of Aden. The recent attacks by missiles and drones on commercial ships pose a major risk to the safety and security of the crew members onboard, the

statement mentioned. Maersk and Hapag-Lloyd jointly control around 25% of the global shipping fleet. The increased instability in the Red Sea can be attributed to the conflict between Israel and Gaza, which started on October 7. Over the past 10 weeks, during which Israel has been conducting airstrikes on Gaza, the Houthi rebels have launched attacks on at least eight ships in the Bab el-

rates Eritrea and Djibouti from the Arabian Peninsula. With a width of just 29km (18 miles) at its narrowest point, the Bab el-Mandeb strait plays a crucial role in international trade. Approximately 10% of the world's seaborne crude oil passes through this strait, making any disruptions a global concern.

The Houthis have been attacking ships that have some ownership connection to Israelis or that transport goods to Israel through the Red Sea. In November, they claimed to have seized the Galaxy Leader cargo ship, which they believed to be Israeliowned. However, Israel stated that the ship was actually owned by a British company and operated by a Japanese team, with no Israelis on board. The ship was originally bound for India.

The rebels, who have held significant territory in Yemen since 2014. have vowed to persist with these attacks until there is a comprehensive truce in Gaza. Their objective is to increase the consequences for the US and other nations that provide assistance to Israel in different capacities.

These acts of aggression also indicate that the Houthis are a formidable presence in Yemen and a significant member of the alliance known as the "axis of resistance." This alliance includes Hamas in Gaza, Hezbollah in Lebanon, the Syrian government, as well as several groups in Syria and Iraq that are supported by Iran. The Houthis are demonstrating their growing boldness and determination in this group. There is limited evidence to in-

dicate that the Houthi attacks will

raises concerns about the impact on the oil market. According to Colby Connelly, a senior analyst at Energy Intelligence, an energy information company based in Washington, the attacks have had a noticeable but not significant impact on the oil market. With the continuation of these attacks, the markets have increasingly paid attention. As a result, the prices of crude oil have risen towards the end of the week, reaching levels higher than those observed in the previous days. This is mainly due to the fact that these attacks show no signs of stopping unless a more forceful effort is made to put an end to them, as explained by Colby Connelly, As tensions escalate, it is uncertain how this crisis in the Red Sea will unfold. According to Paul Sullivan, a non-resident senior fellow at the Atlantic Council's Global Energy Center, if the Bab el-Mandeb Strait is limited in terms of oil traffic due to regional tensions, there is a high possibility that the price of oil to certain locations will increase. This is primarily because of the added premiums on insurance and the products themselves, as a result of the crisis and potential con-

Considering the current situation, it is uncertain, but not likely. that such a scenario will occur. However, in a region of escalating tensions, unexpected outcomes are possible. If the situation deteriorates to the extent that various cargoes need to be redirected around Africa, it could result in significant changes to cargo contracts, including those involving oil and liquefied natural gas (LNG). As a consequence, prices would face upward pressure. Although the recent decline in oil prices may provide some relief, it is not expected to last long, as stated by Sullivan

One of the complexities of this situation is the unpredictable nature of Houthi missile and drone attacks. These attacks do not adhere to a clear pattern, making it challenging to anticipate their next move. As Colby Connelly stated, the Houthis' actions are increasingly making it difficult to predict their future actions. If the Houthis were to attempt

to blockade the Bab el-Mandeb Strait, it would have significant ramifications. Colby Connelly explained that the consequences would involve increased shipping insurance risks, expenses related to alternative routes, and the potential for disruptions in supply chains, among other factors. However, he also expressed doubt regarding the Houthis' capability to carry out such an ac-Furthermore, emphasized that any attempt to do so would inevitably provoke a

The disruptive actions of the Houthis in the Red Sea have the potential to draw increased scrutiny and pressure from various factors such as China, India, Gulf Cooperation Council states, Iran, and Western powers. China opposes any disruption to global trade, including in strategic routes such as the Bab el-Mandeb Strait and the Suez Canal. due to the negative impacts it would have on its economy. As a result, there is a possibility that

reduce their aggressive actions in the Red Sea. Amin Mohseni, a senior economics lecturer at American University, shared this perspective with the media

It is worth mentioning that sev-

eral countries, including the US, UK, China, Germany, Spain, Italy, France, Saudi Arabia, and Japan, already have military bases in Djibouti, which serve to constrain the Houthis' aggressive actions in the Red Sea over the long term. Additionally, there is interest from both Russia and India in establishing their own military bases in the region, further reinforcing the efforts to limit the influence of the Houthis.Sullivan believes that certain global players may increase their presence in the region to safeguard uninterrupted shipping from Yemeni actors. He suggests that China and possibly India could deploy more assets to protect their oil interests, and NATO could strengthen task forces to ensure the freedom and security of navigation. Sullivan also expects the US to become more involved as tensions escalate in the region. Despite the ongoing conflict between Israel and Gaza, with a high number of Palestinian casualties exceeding 18.700, the Houthis are likely to remain committed to influencing the situation as much as they can. The ongoing violence in Gaza is expected to result in a sustained high level of risk in the Red Sea region. As a result, both the shipping industry and the global community should be prepared for new economic challenges to

## South Africa's ruling party faces split before national elections in 2024

ormer South African president Jacob African National Congress (ANC) and vowed to vote for a new political formation in next year's general election. Mr Zuma, who led the ANC from 2007 to 2017, said on Saturday that he was backing the newly formed Umkhonto we Sizwe party, which is named after the ANC military wing that was disbanded after the liberation struggle ended in victory.

The former president called on other South Africans to vote for the new formation, claiming that it would be "a betrayal to vote for the ANC" of President Cyril Ramaphosa. Even former president Thabo Mbeki said in an interview on Saturday that his "answer was still outstanding' when asked if he would encourage people to vote ANC in next year's general elec-

Recent polls have suggested that the

ANC could win less than 50 per cent of the national vote for the first time and may need to form a coalition government to remain in power. Zuma described the ANC and Ramaphosa as a "proxy for white monopoly capital" and claimed that his decision was part of a bid to rescue the ANC.

"I have decided that I cannot and will not campaign for the ANC of Ramaphosa in 2024. My conscience will not allow me to lie to the people of South Africa and to pretend that the ANC of Ramaphosa is the ANC of Luthuli, Tambo and Mandela," said Mr Zuma, referring to previous ANC leaders Albert Luthuli, Oliver Tambo and Nelson Mandela. But former ANC MP Andrew Feinstein told the Morning Star he did not expect Zuma's endorsement of the Umkhonto we Sizwe party to have much impact."Amidst the failings of the ANC to govern in a competent, accountable and non-corrupt manner, dozens of small parties have sprung up," he said."The key issue is whether they will deprive the ANC of a majority for the first time in the country's democratic history."

"The biggest challenge will be to get people to the polls as disaffection with not just the ANC but politics generally takes hold," Feinstein added. Zuma was ousted as president in 2018 and replaced by Mr Ramaphosa amid wide-ranging allegations of corruption in government and stateowned companies during his time in office, which began in 2009.

The ANC indicated this week that it would take legal action over the use of the name Umkhonto we Sizwe because it belonged to the existing party. Zuma, who served as leader of the ruling ANC and the country for nearly a decade, said he had been asked by some ANC leaders if he would campaign for the party in next year's elections. "I have decided that I cannot and will not campaign for the ANC of (current South African President) Ramaphosa in 2024," he said. He said his conscience will not allow him to pretend that Ramaphosa's ANC is the ANC of late founding father Nelson Mandela or the late Oliver Tambo or Albert John Luthuli, who once led the party.

"The ANC is being led by some leaders who are behaving in a manner that does not reflect the true character of the organization that liberated South Africans from apartheid," he said. "When I was president of the ANC, dissenting voices were never sided (sidelined) as in the present, even the 'Zuma must fall' brigade were free to express themselves." He claimed dissenting voices are being suppressed under Ramaphosa. Zuma claimed the ANC under Ramaphosa is a proxy of white monopoly capital, alleging that the party has been infiltrated by its enemies. Now, he said, South Africans must save the ANC revolution from its enemies. "It would be betraval to campaign for the ANC of Ramaphosa. It is not the ANC that I joined and went to jail for," he said, referring to the apartheid era. (IPA Service)

## India's remarkable progress to cut maternal deaths has hit a climate change hurdle – water shortages

onu Bohra's first pregnancy coincided with one of the longest dry spells she had seen in her home village of Sal, high in the Himalayas in Uttarakhand. By the time she went into labour, it had not rained for almost six months and the taps had run dry for days.

When her waters broke, an ambulance came to take her to the nearest medical centre, in Chauramehta. But they refused to admit her, saying they had run out of water. The ambulance driver decided to take her to the next centre, 55 kilometres away in Pati – a drive of several hours on the poor roads. But when they arrived, they discovered the same problem. They set off for the next health centre, but it was too late. The baby was coming. In the end, Bohra gave birth by the roadside, helped by the ambulance driver.

As she watched her healthy twoyear-old son playing and shricking with joy outside their home, Bohra recalled the excruciating pain she endured giving birth to him. She knows it could all have ended very differently.

"I was terrified," she recalled. "Other pregnant women have died. Everyone knows that these [maternal] deaths are high in this area. When the first hospital said no, I was worried that I might end up dying as well, like the others I've heard about. I started praying. My biggest concern was that the child inside me should remain alive

For nearly two decades, India has been working to transform its record on maternal health. It has expanded maternity units in rural areas, provided free ambulances to ensure women can get to them safely, and set up a vast network of community health workers known ASHA, or Accredited Social Health Activists, to provide advice, organise antenatal check-ups and coordinate transportation to hospital when women go into labour.

The proportion of women delivering their babies in hospitals or clinics rather than at home has more than doubled, from just over 40% in 2005-'06 to nearly 90% in 2019-'21. India's maternal mortality rate has dropped from 400 deaths per 100,000 births in 2007-'09 to 97 per 100,000 in 2018-'20, meeting a government target to bring it below 100 by 2020.

It is one of the country's biggest public health victories of recent decades and has won international praise. Yet as Bohra's experience shows, the strategy of encouraging institutional deliveries has hit an unexpected hurdle – climate change.

India has 18% of the world's population and just 4% of its water resources, according to the World Bank. It is the world's largest user of groundwater, exceeding the United States and China combined, according to a United Nations report published in October that warned India's north-western region, including states Punjab and Haryana, would experience critically low groundwater availability by 2025.

As a changing climate has brought more erratic rainfall patterns that are less easy to predict than they were, water shortages have made it impossible for hospitals in drought-hit parts of the country to operate year-round. Even in major cities, some are having to delay planned surgeries during the driest times of the year – the hot months ahead of the monsoon rains, when water reserves run low. Unlike a

In mountainous areas like Uttarakhand where Bohra lives, the problem is particularly acute because the terrain makes it challenging to build and maintain infrastructure like water pipes or truck in water by tankers, according to Parmanand Punetha, chief engineer at the Uttarakhand water department.

The main hospital in Uttarakhand's Champawat district, in which Bohra's village is located, has struggled for years with water shortages. The main aquifer that its piped water supply comes from dried up at the height of the summer, when it has to rely on supplies coming in by truck. The hospital needs 25,000 litres of water a day, but the trucks only deliver about 10,000 a day, if they get there at all – sometimes they are blocked by landslides.

A new pipeline was installed this year that draws water from a different aquifer. But with extraction outpacing the rate at which these underground sources naturally replenish, that will not last forever. "More springs are running dry with every passing year," said Punetha.

On a hot day during this year's dry season, a long queue of pregnant women were waiting to be seen. Rukmani Devi, 33 and six months pregnant, said she usually found the washrooms at the hospital were closed. "I really worry about giving birth here," she said. "There's nowhere even to wash yourself after giving birth."

The hospital's Chief Medical Officer Dr KK Agarwal said he was aware of other cases like Bohra's, but could not put a figure to just how many they are. 'We have been raising this issue [water supply] with the authorities for years now," he said. "Any project that needs government approval has to go through a long chain of paperwork for approvals...It takes time.

With no data showing how often water-related maternity ward closures occur, it is difficult to know how many women have been impacted. But there is anecdotal evidence that it is happening elsewhere in India as overexploitation of groundwater has led the water table to drop, making it harder to

source water during the summer. Dr Rakesh Kumar heads a small government health centre in Bihar that relies on water deliveries by tanker during the dry season, but receives far less than it needs to operate at full capacity. The centre has been forced to turn women away fearing infection if hygiene standards cannot be maintained.

"We perform a minimum of 200 deliveries a month here," he said. "But during peak summers, the centre receives only one water tanker a day. Most days we have to ask patient's attendants to bring water from the nearby hand pump, or are forced to send them away for delivery if we cannot manage to get water.'

In neighbouring Jharkhand, one health worker said her local primary healthcare centre had suffered consis-

tent water shortages in recent years "The submersible pump at the health centre stopped working a few years ago as the ground water dried up," she said. "The washrooms are never open. Women here now prefer to deliver babies at home. We have to spend a lot of time and energy convincing them to go to the nearest hospital for delivery.'

Dr Margaret Montgomery, the World Health Organization's lead on water, sanitation and hygiene in healthcare facilities, said closed washrooms would put women off going to health facilities. "If toilets do not work, women do not want to go to a facility; this is a real disincentive," she said. "India has made huge gains in reversing MMR but climate change and missed indicators into national health system monitoring and unsystematic review into budgeting will compound health risks for mothers and newborns."

Globally, 16.6 million women give birth in hospitals and clinics every year without adequate water, according to WaterAid. The international charity's advocacy advisor for health Annie Msosa said that more than 11% of all maternal deaths and 26% of neonatal deaths can be attributed to unclean births. "Every two seconds, a woman gives birth in a facility without adequate water," she said. "Yet, there does not appear to be specific data regarding maternal health, even though the World Health Organization resolved in 2008 to do more research on the impact of climate change on health."

Even where hospitals have adequate supplies, water shortages are impacting pregnant women's ability to access care. Hospitals in drought-affected parts of Kenya have recorded a drop in deliveries as local nomadic or semi-nomadic communities have deviated from their traditional migration patterns in search of pasture for their livestock, taking them further away and making it harder to get to hospitals on

Dr Antony Apalia, who heads the government's health work in the worst-hit county of Turkana in northwestern Kenya, said that during the worst of the drought this year, only around one in four births there were attended by a registered nurse – well below the 70% recorded in October

To address the problem, authorities in arid and semi-arid areas of the country have deployed mobile health facilities using vans or even camels. They are also using chips placed in the bracelets that young women traditionally wear to track the location of new and expectant mothers and try to ensure they can access pre- and antenatal

In India, reducing maternal mortality remains a key policy goal, as does the impact of water shortages. But the connection between the two has received little attention, experts say. A 2019 report on water management by the Niti Aayog public policy think-tank noted that at least 200,000 Indians die every year from the lack of sanitation that results from water shortages, yet its main policy focus was agriculture. Maternal healthcare was not mentioned.

"We keep hearing news reports of how a pregnant woman miscarried while carrying water home or was refused admission due to shortage of water," said Anant Bhan, a global health researcher in bioethics and health policy. "Yet, there is no comprehensive analysis." If current trends continue, India will not meet the global target of bringing maternal mortality below 70 per 100,000 live births by 2030, warned Montgomery of the World Health Organization.

"The problem of maternal and newborn mortality caused due to inadequate water can be solved. It's just a matter of political will and leadership,' she said. "But if we go by the current trends, the world will fall short in ending preventable maternal mortality by more than one million lives." (Courtesy: Scroll.in)

## Websites using AI to 'undress' women receive unprecedented traction, study finds

**7** ebsites that used artificial intelligence (AI) to undress people, especially women, received more than 24 million unique visits in September alone, a study conducted by a social media analytics firm named Graphika found.

The findings highlight the rampant misuse of AI and an urgent need for laws to regulate them.

It analysed around 34 websites that use AI tools to manipulate existing images and videos of people to make them appear nude without their consent. The firm called the services offered by these websites "non-consensual intimate imagery"

These NCII providers misuse the popularity of different social media platforms to market their "services" and divert traffic to their websites. The study found that the volume of referral link spam has increased by more than 2,000 percent on platforms, such as X (formerly Twitter) and Reddit since the beginning of this year.

How do these models operate? These websites function on a freemium model. This means that

users are allowed to generate a few free images but once that expires, they required to purchase additional "credits" to access premium tools or to further generate such images. The manipulation of existing images raises privacy concerns for everybody, especially women, who can be targeted using the help of such websites.

It further said, "Users are required to purchase additional "credits" or "tokens" to access features such as higher resolution exports, 'age" and "body trait" customization, and inpainting - a feature where the AI model will replace a highlighted part of the image with requested content, such as removing clothing.

Earlier this year, we saw deepfakes of Bollywood actors Rashmika Mandanna and Kajol going viral on social media platforms. While these clips prompted responses from different public figures, it also highlighted the threats that AI tools possess when misused by bad actors.

Why are these websites emerg-

The study highlighted that the growth in accessibility of opensource artificial intelligence image

diffusion models has allowed several websites to easily provide such realistic NCII at a large scale. You may ask how? It is because of the availability of such tools have significantly brought down the time and cost of generating such images.

"Without such providers, their customers would need to host. maintain, and run their own custom image diffusion models - a timeconsuming and sometimes expensive process," the study said.

What next?

Recently, Prime Minister Narendra Modi had expressed his concern over the threats posed by AI tools and deepfakes while addressing a gathering.

## Dry skin during winters is bad for diabetics

Tinter is here. North winds, cold temperatures, sleet, and snow

With a drop in temperature, most people with diabetes experience higher blood sugar levels in winter. This occurs because the body tends to release more glucose to keep itself warm in winter, but this ends up being more harmful than helpful for those having diabetes.

The intake of comfort foods (rich in carbohydrates and sugar), a tradition of eating seasonal sweets specially made with jaggery, and a sedentary lifestyle with limited physical activity increases blood sugar levels during winter as the body is unable to process glu-

As many as 1/4 of people with diabetes will have a skin disorder caused or affected by diabetes at some time in winter. This is what some refer to as 'winter itch'. When sugar is high, the body loses fluid, causing your skin to become dry. This occurs because the body is turning the water into urine to remove the excess sugar from the blood.

During the winter dry air, lowered humidity outdoors, heaters in the home, hot water and more irritating fabrics such as wool can all be contributing factors to dry and itchy skin. Diabetes also affects the ability to heal those cracks and fight off any infection.

People with diabetes need to maintain proper winter skin care to avoid cracking, bleeding, and other possible skin complications

1. Moisturize: In the winter months and on the feet and hands, a moisturizing cream or ointment is preferable. The thicker the moisturizer, the less evaporation of water from the skin occurs. Skin moisturizers, which rehydrate the epidermis and seal in moisture, are the first step in combating dry skin. Regular moisturizing fights dry

Before you get dressed for the day, start with a daytime moisturizer. Any time you wash your face, hands, or body, you strip your skin of its natural oils. Since these oils help to lock in moisture, it's vital to replace them. That's why it's important to use a moisturizer any time you wash your skin, especially in winter. Creams and ointments generally work better than



and more protective. Creams and ointments are more likely to contain petroleum jelly, mineral oil, glycerine, and shea butter, which help keep moisture in the body.

Rub the moisturizer into the skin so that it doesn't leave your skin feeling sticky or pool between the fingers or toes. Keep a small bottle of moisturizer with you in case you need to reapply while away from home. Moisturize before bed, too. Consider using a special nighttime moisturizer because they often have ingredients that promote healing while they moisturize.

Lips become easily chapped in winter so protect them with lip balm that also contains sunscreen. Dry, cracked lips may increase your risk of cold sores. Keep in mind, that the snow can reflect 80% of the sun's ultraviolet

3. Hydration and Nutrition: Proper hydration is essential for diabetic patients to keep the skin moisturised and prevent dryness during winter. Remember to drink at least 8 glasses of water a day.

and supple on the long run. You can even drink fresh juices and green tea. Stay clear of carbonated beverages. If you work in office enviroment or work from home then it is the more important to drink sufficient water, soups and iuices: as the indoor heaters suck the humidity out of the air which can cause fluctuation in body temperature. Stay hydrated in the cold weather, even if you are not as thirsty. Consuming water helps keep your skin moist on the inside.

Drink plenty of fluids like lime water (without sugar), buttermilk, but not soft drinks and coconut water. Eat healthy foods like whole grains, less saturated fat and lots of fruits and vegetables. Consume fruits and vegetables high in antioxidants, like berries and leafy greens, to protect the skin from oxidative damage. ## Pentagon announces new international mission to counter attacks on commercial vessels in Red Sea

U.S. and a host of other nations are creating a new force to protect ships transiting the Red Sea that have come under attack by drones and ballistic missiles fired from Houthicontrolled areas of Yemen, Defense Secretary Lloyd Austin announced on Tuesday in Bahrain. The seriousness of the attacks, several of which have damaged the vessels, has led multiple shipping companies to order their ships to hold in place and not enter the Bab el-Mandeb Strait until the security situation can be ad-

dressed The U.S. military's Central Command reported two more of the attacks on commercial vessels on Monday. A strike by attack drone and ballistic missile hit a tanker off Yemen, at roughly the same time a cargo ship reported an explosive detonating in the water near them, the military said.

"This is an international challenge that demands collective action," Defense Secretary Lloyd Austin said in statement released just after midnight in Bahrain. "Therefore today I am announcing the establishment of Operation Prosperity Guardian, an

mercial vessels in the southern Red Sea, an area roughly the size of Washington D.C. to Boston, at any given time, a senior military official told reporters traveling in Bahrain with Austin. Under the new mission, the military ships that have increased their presence in the region will not necessarily escort a specific vessel, but position the military ships to be able to provide umbrella protection to as many as possible at a given time, the official said on the condition of anonymity to provide additional details that had not been made public on how the new mission will work.

In the last four weeks, Houthi militants have attacked or seized commercial ships 12 times, and still hold 25 members of the MV Galaxy Leader hostage in Yemen, Austin said in remarks on Tuesday in a ministerial meeting on the new maritime mission. The U.S. is still actively seeking member countries to join the mission, and increase the number of navies present and participating. The United Kingdom, Bahrain, Canada, France, Italy, Netherlands, Norway, Seychelles and Spain



have joined, Austin said. Some of those countries will conduct joint patrols while others provide intelligence support in the southern Red Sea and the Gulf of Aden.

One notably absent participant is China, which has warships in the region, but those ships have not responded to previous calls for assistance by commercial vessels, even though some of the ships attacked have had ties to Hong Kong, the military official said. Several other countries have also agreed to be involved in the operation but prefer not to be publicly named, a defense official said on the condition of anonymity to discuss additional details of the new mission that have not been publicly announced.

The mission will be coordinated by the already existing Combined Task Force 153, which was set up in April 2022 to improve maritime security in the Red Sea, Bab el-Mandeb and the Gulf of Aden. While the task force has primarily provided a headquarters structure to date, the goal of the new mission is to generate ships and other assets to carry out the protection. There

In a letter to council members obtained Monday by The Associated Press, U.S. Ambassador Linda Thomas-Greenfield said Houthi attacks

legally transiting the international waterways continue to threaten "navigational rights and freedoms, international maritime security, and international commerce.

The 15 council members discussed the Houthi threat behind closed doors on Monday but took no immediate action. Two U.S. warships the USS Carney and the USS Mason, Navy destroyers have been moving through the Bab el-Mandeb Strait daily to help deter and respond to attacks from the Houthis.

The move to set up the expanded operation came after three commercial vessels were struck by missiles fired by Iranian-back Houthis in Yemen on Dec. 3. Those attacks were part of an escalating campaign of violence that also included armed and other drones launched in the direction of U.S. warships

To date the US has not struck back at the Iranianback Houthis operating in Yemen or targeted any of the militants' weapons or other sites. On Monday Austin did not answer a question as to why the Pentagon had not conducted a counterstrike.

## Midnight earthquake kills 118 people, injures over 500 in northwest China

BEIJING/JISHISHAN, Dec 19: At least Jishishan. So far 32 aftershocks were 118 people were killed and over 500 others injured when a powerful 6.2-magnitude earthquake struck a remote mountainous region in northwest China just before midnight, the local earthquake relief headquarters said on Tuesday. According to the China Earthquake Networks Centre, the shallow quake jolted Gansu and Qinghai provinces at 11:59 p.m. on Monday, with a focal depth of 10 kilometres.

The epicentre of the earthquake Liugou township is about 8 kilometres from the county seat of Jishishan Bao'an, Dongxiang, Sala autonomous county in Linxia Hui au-

tonomous prefecture in Gansu. Experts say shallow quakes cause heavy damage to infrastructure.

Qinghai province is adjacent to the Tibet Himalayan region which is prone to frequent earthquakes due to shifting of continental plates. A second quake struck the neighbouring Xinjiang Uygur Autonomous Region hours later on Tuesday.

The Atux City of Kizilsu Kirgiz Autonomous Prefecture in northwest China's Xinjiang Uygur Autonomous Region, was struck by the earthquake at 9:46 a.m. loacal time on Tuesday, the CENC said. The epicentre, with a depth of 10 km, was monitored at 40.02 degrees north latitude and 77.86 degrees east longitude, the CENC said.

Gansu and Qinghai also experienced aftershocks. While 105 people were killed in Gansu, 13 others died in Qinghai due to the quake, according to official media reports. So far 579 people have been reported injured in the quake-hit areas, officials said.

The quake has damaged 6,381 houses in

recorded, with the largest registering a magnitude of 4.0, said Han Shujun, a spokesperson for the provincial emergency management

department, at the press conference. The quake has destroyed some rural roads, leading to power outages and telecommunication failures. The maintenance crew has been working overnight to repair the damaged infrastructure. Several villages suffered power failures and disruption of water.

The Ministry of Transport, which monitors the operation of roads, said on Tuesday morning that a bridge across the Yellow River had cracked because of the

the disaster area. The railway authority has suspended passenger and cargo trains passing through the quake zone and ordered a safety check of railway tracks. Hu Changsheng, the ruling Communist Party chief of Gansu, and Ren Zhenhe, the governor of Gansu, have rushed to the disaster-hit area to command rescue and relief efforts. Chinese President Xi Jinping and Premier Li Qiang have ordered all-out rescue efforts to minimise casualties after the earthquake. Xi asked local authorities to rescue and treat the injured people promptly, and closely monitor the earthquake situation and weather changes to prevent secondary disasters. (PTI)

"You are complicit in the bombing of Gaza... Your silence is violence. Your silence is abhorrent, and we will not let

you sleep!" one protester shouted. "There will be a price to pay," the protester added before becoming largely in-

Thanedar has expressed his strong support for Israel on his campaign website, including vowing to "defend Israel's

right to exist and to thrive." "In this time of great international uncertainty, it is now more important than ever before to reaffirm as a people, and as a nation, our unequivocal support for the state of Israel, the lone Democracy in the Middle East and one of our closest, and strongest, allies across the globe," the Democratic Party lawmaker from Michigan wrote.

## 4 killed as train torched by unidentified persons in Bangladesh amid political unrest

DHAKA, Dec 19: Unidentified persons set on fire a passenger train here in the Bangladeshi capital on Tuesday killing at least four people, including a woman and her minor son, amidst the political unrest over the January 7 elections.

The attack coincided with the nationwide stoppage called by the main opposition Bangladesh Nationalist Party (BNP) on Tuesday as part of its ongoing campaign to boycott the polls and launch a formal protest against the Election Commission's polls schedule.

The arson attack on the train was the fifth in the past month but the deadliest so far in terms of casualties.

The miscreants set on fire three compartments of the Dhaka-bound inter-district Mohanganj Express early morning shortly after the train left the Airport Railway Station at the entry point of the capital, police and witnesses said. "The passengers saw the fire after the train left the Airport station, it was stopped at the next stop at Tejgaon station," Tejgaon police station officer-in-charge Mohammad Mohsin said.

At least four persons, including a woman and her child, have died after the train was set on fire amid a hartal called by the BNP.

Mohsin said another minor boy was missing while his mother awaited in front of the gutted compartment as fire service rescuers were searching inside. Railway officials said the locomotive master halted the train at Tejgaon where the

But he asked the nearly 110 million voters to freely exercise their rights franchise in an "enthusiastic atmosphere, discarding all worries, tensions and un-

BNP had boycotted the 2014 election but took part in 2018 polls, which party leaders later said was a mistake alleging that the voting was marred with widespread rigging and intimida-

According to media reports, over 10,000 opposition leaders and activists, including BNP Secretary General Mirza Fakhrul Islam Alamgir have been arrested in a nationwide crackdown while BNP claimed the figure to be as high as 20,000.

A Dhaka court on Monday denied a bail request from Alamgir, meaning he could not guide his party ahead of the election next

#### West accuses Iran of illegally testing missiles, transferring drones to Russia, enriching uranium

UNITED NATIONS, Dec 19: The Western powers in the 2015 nuclear agreement with Iran accused Tehran on Monday of developing and testing ballistic missiles, transferring hundreds of drones to Russia, and enriching uranium to an unprecedented 60 per cent level for a country without a nuclear weapons programme — all in violation of a UN resolution endorsing the deal.

Iran and its ally, Russia, dismissed the charges by Britain, France and Germany, strongly supported by the United States, which pulled out of the agreement known as the Joint Comprehensive Plan of Action in 2018.

The six-party agreement was aimed at ensuring that Iran could not develop atomic weapons. Under the accord, Tehran agreed to limit enrichment of uranium to levels necessary for the peaceful use of nuclear power in exchange for the lifting of economic sanctions.

The sharp exchanges came at the Security Council's semi-annual meeting on the implementation of its resolution endorsing the 2015 nuclear deal.

Both Iran's UN Ambassador Amir Iravani and Russia's UN Ambassador Vassily Nebenzia blamed the United States' withdrawal from the JCPOA. Western sanctions and an "anti-Iran" stance for the current standoff.

Iravani said Iran is allowed to enrich uranium for peaceful purposes under the Nuclear Nonproliferation Treaty, and Nebenzia rejected alleged evidence that it was using Iranian drones in Ukraine.

Then-President Donald Trump said when unilaterally pulling out of the accord in 2018 that he would negotiate a stronger deal, but that didn't happen. Iran began breaking the terms a year later and its 60 per cent enrichment is near weapons-grade levels, according to the International Atomic Energy Agency, the UN nuclear watchdog.

Formal talks to try to find a roadmap to restart the JCPOA collapsed in August 2022.

At Monday's council meeting, UN political chief Rosemary DiCarlo stressed that UN Secretary-General Antonio Guterres still considers the JCPOA "the best available option to ensure that the Iranian nuclear programme remains exclusively peaceful".

She urged Iran to reverse course, as did the three European countries who issued a joint statement quoting the IAEA as saying Iran's stockpiles of enriched uranium now stand at 22 times the JCPOA limit.

"There is no credible civilian justification for the state of Iran's nuclear programme," the UK, France and Germany said. "The current trajectory only brings Iran closer to weapons-related capabilities.

The Europeans and US Minister Counselor John Kelley stressed that they would use all means to prevent Iran from developing nuclear weapons. (AP)

#### Iceland volcano erupts weeks after At least 13 dead, 178 injured after a massive thousands were evacuated from a town on Reykjanes Peninsula

Leif-Eric STOCKHOLM, Dec 19: A vol-Easley, a profescanic eruption started on Monday night on Iceland's Reykjanes Peninsula, turning the sky orange and prompting the country's civil defence to be on high alert.

The eruption appears to have occurred about four kilometers (2.4 miles) from the town of Grindavik, the Icelandic Meteorological Office said. Grainy webcam video showed the moment of the eruption as a flash of light illuminating the sky at 22:17 local time. As the eruption spread, magma, or semi-molten rock, could be seen spewing along the ridge of a

'The magma flow seems to be at least a hundred cubic metres per second, maybe more. So this would be considered a big eruption in this area at least," Vidir Reynisson, head of Iceland's Civil Protection and Emergency Management told the Icelandic public broadcaster, RUV.

In November, police evacuated the town or Grindavik after strong seismic activity in the area damaged homes and raised fears of an imminent eruption.

Iceland sits above a volcanic hot spot in the North Atlantic and averages an eruption every four to five years. The most disruptive in recent times was the 2010 eruption of the Eyjafjallajokull volcano, which spewed huge clouds of ash into the atmosphere and grounded flights across Europe for days because of fears ash could damage airplane engines. Scientists say a new eruption would likely produce lava but not an

A coast guard helicopter will attempt to confirm the exact location and size — of the eruption, and will also measure gas emissions.

Grindavik, a fishing town of 3,400, sits on the Reykjanes Peninsula, about 50 kilometers (31 miles) southwest of the capital, Reykjavik and not far from Keflavik Airport, Iceland's main facility for interna-

CONAKRY (GUINEA), Dec 19: An explosion and inferno at Guinea's main fuel depot in the capital of Conakry left at least 13 people dead and 178 injured, authorities said on Monday, as the West African country was

assisted by other nations in

managing the disaster. The massive explosion sparked the fire at the Guinean Petroleum Company depot after midnight Sunday, Guinea's presidency said. It caused significant damage in the heart of the Kaloum administrative district, home to most government

At least 89 of the 178 people injured have been treated and are back home, the government said in a statement. It also updated the casualty toll that Guinea's Civil Protection Service had earlier said was provisional. Among the 13 killed were foreigners, it added.

Authorities said an investigation has started to reveal what

caused the explosion at the depot that supplies most of the fuel in Guinea. The depot had been in the process of being relocated to a remote site in a bid to avoid such a disaster.

There are now fears of a major supply disruption as the country relies on imported refined petroleum products.

Officials were "identifying vital fuel-related needs to prevent possible disruptions in supplies from the capital to other parts of the country", the government said in the state-

A worker at the depot was quoted by the Conakry-based Guinee Matin news website as saying the explosion occurred while a ship was offloading. "I lost several of my friends in this fire. Some like me are guards, others are technicians. ... All offices are destroyed as well as all equipment," said the worker identified as Ahmed Conde.

Security Minister Bachir Di-

allo said on state television the fire had been contained and some countries including Senegal and Mali were sending medical and safety teams.

The fire razed several offices and buildings. Many residents fled their homes as thick smoke spread.

"I was sleeping when I heard a whistle, then a deafening explosion," said resident Mounatou Balde.

Authorities shut down schools and public places in the capital. Access to the district was shut except for essential services. The presidency asked people to stay at home.

Col. Mamadi Doumbouya, who was sworn in as interim president following a coup in 2021, said the state is taking full care of those injured.

"I call on the people of Guinea to show solidarity and prayer for the nation in these moments of hard trial," Doumbouya added. (AP)

# AAI may take over Lengpui airport: Official

HT Bureau GUWAHATI, Dec 19: The Airport

Authority of India (AAI) may receive control of the state's sole airport, located in Lengpui close to Aizawl, from the newly formed Mizoram government led by chief minister Lalduhoma, an official said.

The official further claimed that the state government would take action to turn over the Lengpui airport to the AAI following a meeting of the council of ministers on December 14. According to him, the meeting also resolved that the Union Ministry of Health and Family Welfare will receive control of the sole Zoram Medical College (ZMC) from the government.

The state government owns and maintains ZMC and the Lengpui airport. ZMC is situated near Falkawn, roughly 16 kilometres from the state capital, while Lengpui is situated roughly 29 kilometres west of Aizawl.

The Lengpui airport's VIP-only dropping zone was recently abolished by the state government and made public, thanks to the initiative of home minister K. Sapdanga.

Lalduhoma had previously declared that in order to get the state government through its severe financial problems, the incoming administration pursue

According to officials, the new government feels that Mizoram, being a small state with limited revenue streams, cannot afford to retain the airport due to its high maintenance costs. The resource mobilisation department, which had been set up by the previous Mizo National Front (MNF) government, was similarly abolished by the state government. # INDIA bloc meeting: Mamata and Kejriwal propose Kharge as PM face

Leaders to brainstorm on joint campaign ahead of LS polls

NEW DELHI, Dec 19: West Bengal chief minister and TMC chief Mamata Banerjee and Delhi chief minister Arvind Kejriwal on Tuesday proposed Congress president Mallikarjun Kharge's name as the prime ministerial candidate of opposition bloc INDIA during a meeting in the national capital.

However, veteran Congress leader Kharge said it is important to win first and everything else can be decided later.

Significantly, while MDMK leader Vaiko said Kharge's name was proposed by Banerjee and Kejriwal, other leaders, on the condition of anonymity, maintained that there was no final decision on the issue during the

After his name was proposed as a candidate to become the country's first Dalit Prime Minister at a meeting attended by 28 opposition leaders here, Kharge said, "I work for the downtrodden. Let's win first, then we will see. I don't seek anything.

"First we have to win and get a majority, then MPs will decide democratically,' Kharge when asked if he could be the PM candidate for the opposition alliance.

Banerjee after her arrival in the national capital on Monday, had told reporters that any decision on the Prime Ministerial face of the alliance will be taken after the election.

"When so many political parties are together, it is a democracy, with different states, different views and different opinions, but ultimately INDIA is a platform where we are fighting together," said Banerjee.



"The BJP doesn't have any allies. The NDA is gone. We are not like that. It will be better, after the elections, we have to see the results, and then announce the PM candidate. All parties will decide that," she had said.

"You can decide how a party can do better for the people and motherland. You have to give priority to the people of India. What is going on right now is autocracy, which is not desired by anyone," she said.

Meanwhile, the top leaders also discussed the way forward, including seat-sharing, for taking on the BJP in the 2024 Lok Sabha

The issue of suspension of 141 opposition

MPs in both Houses of Parliament came up at the meeting with leaders cutting across party lines condemning the action against the members. Harping on putting up a united front, the Congress alleged that democracy is being "mercilessly murdered" and MPs who raise people's issues are suspended from the

"In such an adverse situation, our unity is our strength," the party posted on X after the meeting began.

The opposition leaders are deliberating on a blueprint for a joint campaign, seat-sharing arrangement and redrawing their strategy after the Congress suffered a setback in the jasthan, Madhya Pradesh and Chhattisgarh. Evolving a "core positive agenda" will also be among the main challenges before the

"We will give a befitting reply to the dictatorship of Modi government. Will not be afraid, will not stop, will fight and win. Jai Hind," the Congress posted.

This is the fourth meeting of the INDIA bloc leaders, with the first one held in Patna, followed by meetings in Bengaluru and

Sources said there is a likelihood that seatsharing talks may begin immediately and would end by this month itself, amid demands by some leaders to finish them soonest. The leaders would also brainstorm on evolving their joint campaign strategy and presenting a positive agenda to emerge as an alternative to the BJP.

According to a senior Congress leader, the constituents of the opposition alliance intend to move forward with the theme "Main Nahin, Hum (We, Not Me)" at the

## Lok Sabha passes Bill to give immediate effect to customs, excise duty proposals

NEW DELHI, Dec 19: The Lok Sabha on Tuesday passed a bill that seeks to give immediate effect to the changes in customs and excise duties announced in the budget.

The House after a brief discussion on the 'Provisional Collection of Taxes Bill, 2023' passed the bill by voice vote. Jayant Sinha (BJP) and B V Satyavathi (YSRCP) participated in the brief discussion on the bill which is aimed at curbing speculative activities following changes in customs and excise duties in the budget.

Moving the bill for passage, Union finance minister Nirmala Sitharaman said, the Provisional Collection of Taxes Bill, 2023 seeks to obtain the authority from Parliament to provisionally levy and collect the newly imposed or increased duties of customs and excise for 75 days. This bill proposes to replace the erstwhile Provisional Collection of Taxes Act, 1931 with a minor change that is technical in nature.

The provisions of the bill empower collection provisionally, during the period between the introduction and enactment of the bill the increased customs or central excise duty where such duty rate is increased beyond the statutory rate approved by Parliament or where such duty is newly imposed, she said. While the changes in rates of

income and corporate taxes, incorporated in the Budget announced on February 1, are effective from April 1 or a notified date, most of the changes in customs and excise duty rates become effective from mid-

The bill provides for the "immediate effect for a limited period" of provisions in bills relating to the imposition or increase of duties of customs or excise. Sitharaman said the bill incorporates the existing provisions of the 1931 Bill.

"By invoking this particular Act, we are able to temporarily ensure, till the time the Finance Bill gets passed, no speculative activities are happening," she had said while introducing the bill in Lok Sabha last

#### Karnataka CM meets PM, seeks ₹ 18,000 crore drought relief from Centre

BENGALURU, Dec 19: Karnataka chief minister Siddaramaiah on Tuesday met Prime Minister Narendra Modi in New Delhi and requested early release of a drought relief of ₹ 18,177.44 crore from the Centre, and said the farmers of the state are in deep distress.

The Congress government in the state has been critical of the Modi government alleging delay in releasing drought relief to the state, despite its repeated requests, and even after the central team of officials visiting and conducting inspections in various affected

The Karnataka government has declared 223 out of 236 taluks as drought-hit.

"It is learnt that the sub-committee of the National Executive Committee, chaired by the Union agriculture secretary, met on November 13 and considered Karnataka's memorandums and the report of the interministerial central team (IMCT). The sub-committee, it is also learnt, has submitted its report to the ministry of home, which is expected to place the same before the high-level committee chaired by the Union home minister," Siddaramaiah said in a memorandum to the

"It is nearly three months since we submitted our first memorandum and two months since the IMCT made its field visits. The farmers of Karnataka are in deep distress. Since crops have failed, it is necessary that we pay the input subsidy to the farmers soon so as to alleviate their hardship and suffering," he said.

Siddaramaiah was accompanied by Karnataka revenue minister Krishna Byre Gowda during the meet-

Listing out memorandums submitted to the central government seeking relief and the Government of India deputing the IMCT, which visited the state during October 4-9, the CM said in his memorandum to PM said, "....total claim of Karnataka to ₹ 18,177.44 crore." The ₹ 18,177.44 crore drought relief sought from National Disaster Response Fund (NDRF) include ₹ 4,663.12 crore input subsidy, ₹ 12,577.86 crore gratuitous relief, ₹ 566.78 crore for drinking water purposes, ₹ 363.68 crore for animal husbandry inter-

Further noting that under MGNREGA, for the taluks where drought has been declared, the number of days of employment should be increased from 100 days per job card to 150 days, Siddaramaiah said a request for this has been made and the matter is pending in ministry of rural development for a long time. "Kindly expedite a decision on this very important

According to the state government, around 48.19 lakh hectares of agriculture and horticulture crops have suffered crop losses ranging from 33 to 100 per cent, with the majority of area reporting loss of more

The chief minister noted that small and marginal farmers are most affected, as about 83 per cent of the land area under cultivation is covered by small and marginal farm holdings.

The land area under cultivation falling under small and marginal farm holdings (SMF) is very important to determine the input subsidy payable to the state, he said. Karnataka has a robust digital database of farmers under the system called FRUITS (Farmer Registration & Unified Beneficiary Identification System). This system is Aadhaar enabled and therefore is very reliable.

Requesting the Centre to the consider the area under SMF holdings as per the Aadhaar enabled FRUITS digital database, the CM said, the trends since 1970-71 show that, due to constant sub-division and fragmentation of holdings, the number of SMF holdings and therefore the area under such land holdings, has

The 2015-16 agriculture census shows that in Karnataka 43.94 per cent of land area belongs to SMF holdings. However, as per the FRUITS database of Karnataka, 83 per cent of land is covered by holdings which are small and marginal.

"It is therefore to request the Prime Minister to direct the High-Level Committee under the Union home minister to consider the number of and area under SMF holdings as per the FRUITS database of Karnataka," he said.

The average size of operational holding in Karnataka has decreased from 3.2 Ha in 1970-71 to 1.35 Ha in 2015-16, Siddaramaiah further said. "The average size would have further decreased in the last 8 years since 2015-16. Therefore, relying on 2015-16 data (agriculture census) would cause great injustice

## Ruckus in Jharkhand assembly, 3 BJP MLAs suspended

RANCHI, Dec 19: The Jharkhand assembly on Tuesday witnessed uproarious scenes as three BJP legislators were suspended for the remainder of the winter session and marshalled out of the House for "creating disturbances" in the proceedings.

The other BJP legislators staged a walkout in protest against the Speaker's action.

As the proceedings resumed at 12.30 pm after the House was adjourned following uproar by both opposition and treasury benches, BJP chief whip Biranchi Narayan and legislator Bhanu Pratap Sahi trooped into the well in support of their demands.

Speaker Rabindra Nath Mahto said the legislators were creating disturbance in the house proceed-

"I suspend Biranchi Narayan and Bhanu Pratap Sahi from the ongoing session," Mahto said. Another legislator JP Patel was also suspended.

Following his directions, marshalls took the legislators out of the House. Leader of Opposition Amar Bauri termed the Speaker's action as dictatorship.

"We were raising the issue concerning the state's youth. But, the government doesn't have any reply. BJP protested the suspension of legislators. We are staging a walkout," Bauri said.

Earlier protests by legislators led to a washout of the question hour in the Assembly

The BJP-led opposition as well as ruling party legislators created an uproarious scene in the Assembly over their demands.

The House assembled around 11 am for the day's business. BJP



raised the demand for clearing the employment policy of the state and a debate on the issue in the House. Raising slogans against the government, the BJP legislators trooped into the well.

Legislators of the ruling coalition also reached there and demanded a resolution condemning the suspension of 92 members from Lok Sabha and Rajya Sabha by the speaker. Reacting to this, the leader of Opposition, Amar Bauri said that when they raised the issue of cashhaul linked to Congress MP Dhiraj Sahu, it was said that the matter was not related to the State assem-

"How the ruling party members can demand a resolution in this House condemning suspension of the MPs, while it was done by speakers in Lok Sabha and Rajya Sabha. I think their proposal should be rejected," Bauri said.

Bauri said that over 18,000 workers of Panchavat secretariat

Singh (71) filed his nomination for the speaker's post on Sunday and said his new responsibility will be to take everyone together in the Chhattisgarh Vidhan Sabha.

The Congress, which ruled Chhattisgarh for last five years, suffered a shock defeat in the assembly polls held last month at the hands of the BJP which bagged 54 out of 90 seats, restricting the grand old party to 35 seats. As the assembly session commenced on Tuesday, pro-tem speaker Ramvichar Netam administered the oath to BJP and Congress legislators and one MLA from the GGP as members of the legisla-

#### Around 40 % of global carbon dioxide emissions stem from coal NEW DELHI, Dec 19: India did not accede to the pressure from developed countries on the issue of fossil fuels at the UN climate conference in the United Arab

Emirates (UAE), Union environment minister Bhupender Yaday said on Tuesday. Responding to questions at a press conference here, he also said India is committed to meeting the energy needs of its people and will also have to rely on coal power until it achieves developed country

Yaday said the country cannot meet the energy needs of its people by just "importing oil and gas".

"While we are increasing our renewable capacity, we will also have to rely on coal power until we achieve the objective of a developed India," he said.

India relies on coal for about 70 per cent of its power generation and aims to add 17 gigawatts of coal-based power generation capacity in the next 16 months. Responding to a question from PTI,

Yadav said India "strongly resisted" the rich nations' call for limitations on new and unabated coal power generation. "We said you cannot dictate or tie up any country." Around 40 per cent of global carbon dioxide emissions stem from coal, with oil

COP28 outcome revealed a "softening" of the language on developed countries taking the lead in moving away from fossil fuels, he said.

He said India accounts for 17 per cent of the global population but its contribution to global carbon emissions is just four per cent. "Poverty eradication is a priority for

many nations. So, we did not give in to the pressure from developed countries (to stop using fossil fuels)," Yadav said.

The minister said developed nations, which have taken up a large part of the carbon budget for 1.5 degrees Celsius (since the start of the industrial revolution) and spent it on their own development, are required to provide finance and technological support to developing countries to help them combat climate change.

"We have different starting points. Countries that developed first, taking up a large part of the carbon budget in the process, should also take the lead in combating climate change.

"But they are pressuring developing nations to end the use of fossil fuels. We did not accept it (at COP28). We said efforts to (limit temperature rise to) 1.5 degrees Celsius should be seen in light of national circumstances and should adhere to (the principles of) equity and common but differentiated responsibilities and respective

These principles acknowledge that countries' efforts to combat climate change should be considered in light of their contributions to total emissions. They also stress that wealthier nations should bear primary responsibilities due to their substantial historical emissions.

Countries reached a historic deal on a 'transition away from fossil fuels' at COP28 in Dubai last week while emerging economies like India and China strongly resisted the targeting of coal.

The deal called for tripling global renewable energy capacity and doubling energy efficiency rates by 2030 which, according to the International Energy Agency, is critical to avoid breaching the 1.5 degrees Celsius threshold.

Yadav said India reduced its GDP emission intensity by 33 per cent between 2005

and 2019, achieving the target 11 years in advance. The country reached its non-fossil fuel targets nine years ahead of schedule.

The emission intensity of the economy refers to the total amount of greenhouse gases emitted for every unit increase in gross domestic product.

At COP28, the minister said, India also asked rich nations to vacate carbon space by achieving negative carbon emissions (removing more carbon dioxide from the atmosphere than emitted), not merely reaching net zero by 2050.

According to the Global Carbon Project, a group of international scientists, India's per capita carbon dioxide emissions rose by around five per cent in 2022 to reach two tonnes but these were still less than half of the global average.

The United States topped the per capita emissions chart with every individual in the country emitting 14.9 tonnes of CO2, followed by Russia (11.4), Japan (8.5), China (8), and the European Union (6.2). The

global average stood at 4.7 tonnes The US is also the biggest CO2 emitter

since the industrial revolution. Over the entire period 1850 2022, the US' cumulative emissions amounted to 115 gigatonnes of carbon dioxide (GtC) (24 per cent of the world's total), the EU's to 80 GtC (17 per cent) and China's to 70 GtC (15 per cent). India has emitted 15 GtC since 1850 which is just 3 per cent of the world's total. (PTI)

**NEW DELHI / CHENNAI, Dec** 19: The southern districts of Tirunelveli and Thoothukudi were among the severely affected by unprecedented rains as they received their annual rainfall on a single day leading to massive inundation, Tamil Nadu chief minister M K Stalin said on Tuesday.

As the state was coping with the relief and rehabilitation of the four districts including Chennai where Cyclone Michaung wreaked havoc on December 4, heavy rains battered the southern districts of Tirunelveli, Thoothukudi, Tenkasi and Kanyakumari, on December 17 and 18. Relief and rehabilitation in these districts would be taken up in the same vigour in which the state government had launched the activities in Chennai and suburbs, Stalin said and added that he personally Thoothukudi on Wednesday to oversee the relief and rehabilitation activities.

"The rainfall received in Tirunelveli and Thoothukudi was

#### 6 held for cyber crimes, supplying SIM cards to fraudsters

DWARKA (GUJARAT), Dec 19: Police in Gujarat's Devbhumi Dwarka district has arrested six persons for alleged involvement in various cyber crimes including sextortion and sale of SIM cards to online fraud-

As many as 600 illegally activated SIM cards from Gujarat were supplied to fraudsters through a Rajasthan-based man, said Raghav Jain, assistant superintendent of police, Devbhumi Dwarka.

The arrested men were identified as Hasan Shaikh (25), Altaf Shaikh (25) and Aarif Mirza (25), all three Vadodara-based SIM card retailers; Gopal Gurjar (50), Dalwirsingh Beniwal (30) and Azru Mohammad Mev,

all residents of Rajasthan. While investigating cyber fraud cases registered in the district, police found that the mobile SIM cards used by the fraudsters were registered in the names of Vadodara residents but later operated from Rajasthan, ASP Jain told reporters. The three accused held from Vadodara were friends and working as SIM card retailers for the last one year, he said.

"Some time ago, the trio came into contact with one Dhansingh Gurjar who offered to buy pre-activated SIM cards for them for ₹ 350 apiece. To activate a dummy SIM card, the trio used to take a (genuine) customer's biometric fingerprint twice, one to activate the original SIM card and another to activate a dummy card without the customer's knowledge," Jain said. In all, the trio allegedly supplied nearly 600 SIM cards to Dhansingh Gurjar and his father Gopal Gurjar, resident of Ghoghar village in Rajasthan's Deeg district. While Dhansingh is on the run, Devbhumi Dwarka police raided his house and nabbed Gopal who confessed to have sold SIM cards to various fraudsters, said the official.

Police also nabbed Beniwal from Karauli district of Rajasthan for allegedly duping a Khambhalia-based businessman by posting a Facebook advertisement, said Jain, adding that Beniwal holds an MTech degree.

Complete relief work could be carried out only if the central government provided the funds fully, he said. He would take up this issue and also submit a detailed report on the extend of damages in the southern districts to Prime Minister Narendra Modi during his meeting tonight and seek additional central assistance. #### ED arrests woman, seizes luxury cars after raids against 'bitcoin ponzi'

NEW DELHI, Dec 19: The Enforcement Directorate (ED) on Tuesday said it has arrested a woman and seized three luxury cars and some jewellery after recent raids against the promoters of a 'bitcoin ponzi scheme' where as much as ₹ 6,600 crore worth of public deposits were collected.

Simpy Bhardwaj alias Simpy Gaur was taken into custody on December 17 and after she was produced before a special Prevention of Money Laundering Act (PMLA) in Mumbai the next day, the court sent her to ED custody till December 26, the agency said in a statement.

The investigation is against a company called Variable Pte Ltd and others and was known as 'Gain Bitcoin Ponzi scheme', it

The money laundering case stems from multiple FIRs registered by the Maharashtra and Delhi Police against the company and its promoters like Simpy Bhardwaj, Amit Bhardwaj, Ajay Bhardwaj, Bhardwaj, Mahender Bhardwaj and a number of MLM (multi-level marketing) agents.



plaints, the ED said, that they had collected about ₹ 6,600 crore in the form of Bitcoin from the public in the name of investment.

Probe found, the ED said, that Simpy Bhardwaj along with her husband Ajay Bhardwaj and MLM agents played an "active role" in luring innocent investors by "promising huge returns on the investment and cheated the public by way of committing fraud.

The "proceeds of crime" generated out of this scam were transferred to various overseas chasing properties abroad and Simpy Bhardwaj was actively involved in generating, concealing and layering of the proceeds of crime, the ED alleged.

During the raids, three cars including a Mercedes and a Audi, some "incriminating" documents and jewellery worth of ₹ 18.91 lakh was seized even as assets worth ₹ 69 crore have been attached in the case till now. The main accused Ajay Bhardwaj and Mahender Bhardwaj are absconding, the ED said. (PTI)

### HC orders speed trial in 32-yr-old Gyanvapi case

on Tuesday dismissed pleas challenging the maintainability of a 1991 suit seeking the "restoration" of a temple where the Gyanvapi mosque now exists in Varanasi, while observing that the "religious character" of a disputed place can only be decided by the

The high court dismissed five connected petitions filed over the years by the mosque management committee and the Uttar Pradesh Central Sunni Waqf

It held that the suit filed before the district court is not barred by the Places of Worship (Special Provisions) Act, 1991 that mandated that the "religious character" of a place cannot be changed from what existed on 15 August, 1947.

In an important observation, Justice Rohit Ranjan Agarwal said the Act did not define the term "religious character" and this can only be determined through evidence in court presented by the opposing parties.

"Either the Gyanvapi compound has a Hindu religious character or a Muslim religious character. It can't have dual character at the same time," Justice Rohit Ranjan Agarwal said.

He ordered that the trial in the case which is of "vital national importance" should be concluded as soon as possible, preferably within six months.

"In the national interest, it is required that the suit must proceed expeditiously and be decided with utmost urgency with the cooperation of both the contesting parties without resorting to any dilatory tactics," he said, cautioning against any "unnecessary adjournment" in the lower court.

The order on the Gyanvapi mosque-Kashi Vihswanath temple issue follows other significant court rulings on temple-mosque disputes in Uttar Pradesh over the past months.

The Supreme Court earlier gave its go-ahead for a survey of the Gyanvapi mosque premises by the Archaeological Survey of India and the high court al-

lowed a survey of the Shahi Idgah mosque that adjoins the Krishna Janmasthan temple in Mathura.

Hindu litigants say the two mosques were built after the demolition, or partial demolition, of temples and the surveys would through up evidence proving this.

The high court took note of the ASI survey conducted at the Gyanvapi masjid, following directions by the trial court which is hearing the petition of a group of women seeking regular access to Hindu deities depicted on the mosque's rear wall.

If required, the lower court may direct ASI for a further survey, the judge added.

"The dispute raised in the suit is of vital national importance. It is not a suit between the two individual parties. It affects two major communities of the country," he said while calling for a speedy trial.

The case was filed by petitioners seeking the right to worship in the Gyanvapi mosque adjoining the Kashi Vishwanath temple. Muslim litigants had challenged the maintainability of the suit, citing the 1991

But the court said, "The Act does not define "religious character", and only "conversion" and "place of worship" have been defined under the Act.'

"What will be the religious character of the disputed place can only be arrived by the competent court after the evidences are led by the parties to the suit," it said.

"Either the Gyanvapi Compound has a Hindu religious character or a Muslim religious character. It can't have dual character at the same time. The religious character has to be ascertained by the Court considering pleadings of the parties, and evidences led in support of pleadings," it said.

The Places of Worship Act had exempted only the Ram Janmabhoomi-Babri Masjid dispute from its purview.

After a landmark Supreme Court verdict four years back, the first phase of the construction of the Ram temple in Ayodhya is nearly over. The consecration ceremony will take place next month. (PTI)

## Community radio brings out voice of people in Bengal's remote villages

Radio jockeys visit people of remote village to air programmes on issues affecting them **SILIGURI** (WB), Dec 19: In a nondescript and vice principal of Salesian College.

village among tea gardens in the northern part of West Bengal, an elderly retired army soldier narrates the stories of bravery during fights. In another such hamlet, a woman sings songs which are relatable to those living in all nearby in those remote villages and the issues like transport, water, sanitation, health, education villages.

As their voices are aired on a community radio, listeners hear with rapt attention as they consider those expressions to be their own.

"Recently we visited Dupkin village where we came across a widowed woman who told us how listening to our community radio station helped her overcome depression," radio jockey (RJ) Samir told PTL

Samir and other RJs who work for Radio Salesian 90.8 FM, a community radio station, visit remote hill villages 6,500 feet above sea level in Darjeeling district to meet local Nepalispeaking people and make programmes on is-

sues affecting them. In a community radio, local people produce and broadcast their own programmes and participate in operating the station.

"From the first week of November this year, our RJs have started moving out to villages every Saturday. We have an ambitious plan to reach out to 40 remote villages," said Father CM Paul, founder-director of Radio Salesian

These villages are often not easily accessible by vehicles, compelling the RJs to cover a portion of the journey on foot, Fr Paul told PTI. He said the RJs bring out what is happening

and unemployment faced by the villagers. "After talking to the villagers, our RJs try to help them with their issues and also tell them about government schemes which are likely to

mitigate their problems," Fr Paul said. The RJs also try to create awareness among the villagers about having names in the voters' list and the importance of voting.

Radio Salesian operates from 8 am to 8 pm daily. As mandated by regulations, 50 per cent or more of the programmes are made in collaboration with the community. "We have programmes for all categories of

people - children, youths, women, elderly people, farmers, entrepreneurs, success stories," Fr

The RJs have become celebrities and their

visit to a village turns out to be a festival. "We visit villages to give a voice to them. They treat us like celebrities and organise feasts for us. Retired Gurkha soldiers of the Indian Army tell us how they fought and other

stories of bravery of fellow soldiers," Samir

The RJs also encourage the villagers with their talent in singing and sports. The prerecorded programmes of village visits are aired from 7 am to 8 am. The programmes of the radio station are in Nepali and sometimes in English.

Live shows are interactive and popular with the audience as they call on mobile, even from neighbouring districts of Nepal from where they make WhatsApp calls or send voice mails, Fr Paul said.

Radio Salesian is the first college-based community radio of Darjeeling Hills, as well as of North Bengal, Fr Paul claimed. He said the FM radio station which started

operations in 2016 serves not only stakeholders of the college community (Faculty, students and their guardians) but also the local tea garden population spread out in the far-flung tea gardens and hill stations of Darjeeling, Mirik and Kurseong.

"We work with government departments of health and family welfare, women and children. UNICEF as well as NGOs for various campaigns related to health, literacy, sanitation and so on", said the founder director of the radio station. (PTI)



# YOU CAN'T PLAN TO MAKE A PAN-INDIA MOVIE: 'SALAAR' DIRECTOR PRASHANTH NEEL

MUMBAI, Dec 19: Filmmaker Prashanth Neel says movies like his "KGF" franchise that organically travel across the country do well, a phenomenon he hopes is repeated with his latest directorial "Salaar: Part 1 -Ceasefire"

Neel and Yash, the lead star of "KGF" series, rose to national prominence after the success of "KGF: Chapter 1", the 2018 Kannada period action film. Its 2022 follow-up, "KGF: Chapter 2" also starred Bollywood actors Raveena Tandon and Sanjay Dutt in key roles.

The director, who made his debut with 2014's "Ugramm", said he never plans his films as pan-India projects.

"I've written a story and I've executed it. I don't know if it ('Salaar') is going to be a pan-India movie or not. But if it becomes a pan-India movie, then that's an absolute bonus for all of us. Like, 'KGF' happened very organi-

"Movies that happen organically always do well.

India movie, you can't plan and say that I'm going to bring these actors from this industry to make it a pan-India movie. It doesn't work like that," Neel told PTI in an interview here.

"Salaar" revolves around two friends Deva and Vardha, played by Prabhas and Prithviraj Sukumaran, who end up becoming arch rivals. It will be released on Friday. The 43-year-old director

said the journey of the film started over 15 years ago. "It was an idea that was in my head. But it needed a very big budget. So, I made

my first film 'Ugramm', then I made 'KGF'. I was occupied with 'KGF' for almost eight years. During COVID-19, I narrated this subject ('Salaar') to Prabhas sir and he agreed to do it," he recalled.

The USP of "Salaar" is an emotion between two friends and how this emotion translates to violence forms the core of the story, Neel said.

"We make a movie to tell a story and we want the right characters, right actors to portray every role. There's a commercial aspect with a star and we get bigger budgets to do what we want. But the criteria is the same that this is the character, it is not the hero who is playing the hero because if we think like that then we have lost the battle,"

he added. With "Salaar", Neel said his aim was for Prabhas ("Baahubali") to shed his superstar persona.

"There was never a pressure to make 'Salaar'. The idea is to make sure that the actor looks like a character. You don't want to show Prabhas as Prabhas, you want to show him as a character and I tried our best to do something like that," he said.

While the director acknowledged that Prabhas has had a difficult run at the box office with his recent releases "Adipurush" and "Radhe



Shyam", he said a star can always bounce back after a hit film.

"Prabhas is a big star. After 'Baahubali', he became the biggest star. People are not going to forget something like that. Stars have always been stars; they can have one flop or 20 flops, they just need to give one hit. Recently, Shah

Rukh Khan showed us that a star is always a star, there's no denying that," Neel added.

A box office showdown is expected between "Salaar" and Rajkumar Hirani's "Dunki". The latter, starring Shah Rukh Khan, will hit the screens a day before "Salaar" on Thursday.

About the release, Neel said he doesn't meddle in the business aspect of a movie. "I don't get involved in the logistics of what happens after the movie is ready. My brief is I've to make a movie on a given budget and I've to give it to them at a time that they want to release," he said. (PTI)



## Starc leaves captain Cummins behind to become most expensive buy in IPL history



DUBAI, Dec 19 (PTI) Mitchell Starc surpassed his Australian bowling partner Pat Cummins to become the most expensive buy in IPL history with an eye popping bid of ₹ 24.75 crore as pacers attracted big moolah at the auction here on Tuesday.

Not long after Cummins fetched an unprecedented pay packet of 20.50 crore from Sunrisers Hyderabad, Starc raised the bar when Kolkata Knight Riders made a multi million dollar bid for the left-arm pacer who last played in the IPL in 2015.

Such are the unpredictable ways of IPL that the one third of the formidable Australian pace trio, Josh Hazlewood, went unsold in the first round of auction from a base price of ₹ 2 crore.

Gujarat Titans and KKR were involved in a long and exhilarating bidding battle for Starc before the latter lapped him up for a record deal.

Starc, 33, has usually prioritised international duty over IPL but decided to enter the auction with one eye on the T20 World Cup that follows the IPL.

He has only played only two seasons (₹ 11.75 crore to Punjab Kings), Alzarri of the IPL, taking 34 wickets in 27

games at an average of 20.38. In contrast, Cummins has been a regular at the IPL but skipped the 2023 edition to focus on the Ashes and the ODI World Cup.

An intense bidding war followed for Cummins with Mumbai Indians, Royal Challengers Bangalore, Chennai Super Kings, and Sunrisers Hyderabad raising their paddles frenetically to secure the services of the fast bowling all-rounder.

# Shadab likely to be ruled out of New Zealand T20 series

KARACHI, Dec 19: Senior Pakistan allrounder Shadab Khan is unlikely to make the cut for the upcoming T20I series in New Zealand in January as he is yet to fully recover from his ankle injury.

Test captain, Shan Masood is expected to be named in the T20 squad that plays in New Zealand from January 12 with fast bowler Haris Rauf also in line to make it despite refusing to play the Tests in Australia. Rauf is instead playing in the Big Bash in Australia.

The PCB source also informed that the selectors are against any kind of experi-

mentation with T20 World Cup being played in six months' time.

"The consensus is to start building the World Cup squad from now with no real surprises in store. But some players of the recent World Cup will be dropped," he


41-year-old Shoaib Malik had expressed his desire to play T20 cricket for Pakistan but Wahab and Co. feel that it will be a step in backward direction.

DUBAI, Dec 19: The supremely gifted Rishabh Pant says he will need a few more months to get back to playing competitive cricket as he appreciated the love and support he received during his long rehabilitation period.

Pant had met with a horrifying car accident last year and missed the entire 2023 after undergoing a knee surgery.

"(I am feeling) much better (than) what I was doing a few months ago. So like, (I am) still on recovery towards 100 per cent (fitness). But hopefully in a few months time, I'll be able to do it," an optimistic Pant said in a video posted by the Delhi Capitals on its instagram page.

The Delhi Capitals skipper, who will be present at the mini auction alongside Team Director Sourav Ganguly and head coach Ricky Ponting here on Tuesday, had a close shave after his car hit a divider on National Highway towards Roorkee and caught fire in a terrifying accident in December last year.

The 26-year-old suffered multiple injuries and is currently under going rehab at the National Cricket Academy in Ben-



galuru. However, he is expected to be back to action during the IPL which starts on March 22. What touched Pant was the love and concern shown by the fans. which he felt he realised for the first time.

"I think it's been really amazing because whenever we keep on playing cricket, we feel no one loves us because there is always pressure in so many things. But actually yes, it's a hard time.

"But I got to know at least people love us. They respect us and the kind of appreciation and the kind of concern I would

say people have shown over a period of time because of my injury," Pant said.

"I think it was heartfelt, like crazy for me because it means a lot as an individual." Pant said the love and affection shown by people has helped him make a quicker recovery.

"When you are going through a very rough time or something like that happens to you. It's not only physical, it's like mentally also and if your supporters and the people support you or show you love, it means a lot and it's it really helps in re-

In the absence of Pant, Australia opener David Warner led DC last season with the team finishing second from last.

"Thank you for always being supportive all the time. Yes, I know sometimes we have given you a hard time as fans.

"But see, we try to do our best all the time and, hopefully, next year in time to come, we will show the kind of respect or love you have shown over a period of time, hopefully we can reciprocate it over a period of time, and just keep supporting us," Pant said. (PTI)

"Unless you take 20 wickets how can you expect to win against a tough opposition like Australia in their own backyard." While Morgan asserted that bowlers will be in demand during the auction to be held in Dubai, a few batsmen such as England's Harry Brook, Australia's Travis Head and Rachin Ravindra of New Zealand will evince some interest from the bidders.

"When you look at the teams, I suppose they are coming into auction when their top-order is pretty much full. So, in that regard, I don't see many batters going for huge amounts of money.

"Brook is going to be in there and will be sought after. I think Head is going to create a strong buzz, given the last year and a half to two years he has had in all formats of the game.


