

Qatar appellate court commutes death sentence 'Without ULFA (I) participation talks meaningless' of 8 Navy veterans: MEA

NEW DELHI, Dec 28: In a huge Dubai. After the meeting on Derelief to eight Indian Navy veterans on death row, an appellate court in Oatar has commuted their sentence. "We have noted the verdict today of the Court of Appeal of Qatar in the Dahra Global case, in which the sentences have been reduced," the External Affairs Ministry said in a statement on Thursday.

The ministry didn't specify what the "reduced" punishment was and said a detailed judgment was awaited. "Due to the confidential and sensitive nature of proceedings of this case, it would not be appropriate to make any further comment at this juncture," the ministry said and added that it was in close touch with the legal team as well as the family members to decide on the next steps.

The appellate court verdict is also seen as a big diplomatic win for India as it comes weeks after Prime Minister Narendra Modi's meeting with Emir of Qatar Sheikh Tamim bin Hamad Al-Thani on the sidelines of the COP28 Summit in cember 1, Modi said they discussed the well-being of the Indian

community in Qatar. The Indian nationals, who were working with Doha-based Al Dahra Global Technologies, were taken into custody in August 2022 in an alleged espionage case. While the charges against them were not made public by Qatari authorities, they were sentenced to death by Qatar's Court of First Instance in October this year.

The private firm provided training and other services to Qatar's armed forces and security agencies. India had moved the Court of Appeal in Qatar against the death sentence last month.

"Our Ambassador to Qatar and other officials were present in the Court of Appeal today, along with the family members. We have stood by them since the beginning of the matter and we will continue to extend all consular and legal assistance. We will also continue to take up the matter with the Qatari authorities," (CONTD. ON PAGE-9)

India sees single-day rise of 702 Covid cases NEW DELHI, Dec 28: India saw

a single day rise of 702 cases of Covid-19, with the number of active cases of the infection rising to 4.097, the health ministry said on Thursday.

Six new fatalities -- two from Maharashtra and one each from Karanataka, Kerala, West Bengal, and Delhi -- were reported in a span of 24 hours, according to the ministry's data updated at 8 am.

The country had recorded 752 new cases on December 22.

The number of daily cases had dropped to double-digits by December 5, but the cases have again gone up after emergence of a new variant and cold weather conditions.

The daily numbers were in lakhs at the peak of the pandemic, which began in early 2020 and has seen more than 4.5 crore people getting infected and over 5.3 lakh deaths in about four years since then across the country.

The number of people who recuperated from the infection stands at over 4.4 crore with a national recovery rate of 98.81 per cent, according to the ministry's website. According to the website, 220.67 crore doses of Covid vaccines have so far been administered in the country.



Human error behind Nepal's Yeti Airlines crash that killed all 72 people: Report



KATHMANDU, Dec 28: The crash of a Yeti Airlines' aircraft in January this year that killed all 72 people on board, including five Indians, in Nepal's resort city of Pokhara was caused by human error, according to an inquiry report submitted to the government on Thursday

Yeti Airlines' 9N-ANC ATR-72 aircraft crashed on the bank of the

Seti River between the old airport and the new airport minutes before landing on January 15.

A five-member Investigation Commission formed after the crash said in its report that the aircraft crash on January 15, 2023, was due to human error, Nepal's official news agency RSS reported.

The five Indians - Abhisekh Kushwaha (25), Bishal Sharma

(22), Anil Kumar Rajbhar (27), Sonu Jaiswal (35) and Sanjaya Jaiswal (26) - were among 72 peo-ple on board when the plane crashed The Commission formed under

the coordination of former Secretary Nagendra Prasad Ghimire submitted the report to the Minister for Culture, Tourism and Civil Aviation, Sudan Kirati. It took eight months and three days for the Commission to carry out the investigation and prepare the report. The government had formed the

Share of engineering exports in India's total merchandise exports was recorded at 23.17 per cent in November 2023

KOLKATA, Dec 28: Exports of engineering goods during the period April to November of the current financial year have dipped 1.81 per cent at USD 69.46 billion as against USD 70.74 billion in the similar previous period, Engineering Exports Promotion Council (EEPC) of India said.

Engineering goods exports to West Asia and North Africa (WANA), North East Asia, and CIS countries recorded positive year-on-year growth in the first eight months (April-November) of the current financial year 2023-24, while shipments to key regions like North America, EU, ASEAN and South Asia witnessed decline during this period.

Excluding iron and steel, engineering exports recorded a marginal 0.79 per cent y-o-y growth during April-November 2023-24, EEPC said in a statement on Thursday.

Rupee rebounds 17 paise to 83.17 against US dollar

MUMBAI, Dec 28: The rupee rebounded after two straight days of fall to settle 17 paise higher at 83.17 (provisional) against the US dollar on Thursday, amid a weak American currency overseas and a rally in domestic equity markets.

The inflow of foreign funds and a downward trend in crude oil prices also supported the Indian currency, forex traders said.

At the interbank foreign exchange, the domestic currency opened at 83.33 and traded in a range of 83.16-83.34 against the greenback. The local unit finally settled at 83.17 (provisional), registering a gain of 17 paise over its previous close. The rupee had lost 18 paise in the previous two sessions. On Wednesday, the domestic currency settled 15 paise lower at 83.34 against the dollar, a day after closing at a loss of 3 paise.

Anuj Choudhary, Research Analyst at Sharekhan by BNP Paribas, said the rupee appreciated on the weak US dollar and a surge in domestic markets.

Choudhary said the rupee is likely to trade with a slight positive bias on fresh foreign inflows and an extended decline in the US dollar. Also, "traders may take cues from weekly unemployment claims data from the US. USD-INR spot price is expected to trade in a range of ₹ 82.90 to ₹ 83.50".

The US dollar declined on rising expectations of rate cuts by the US Federal Reserve. The dollar index, which gauges the greenback's strength against a basket of six currencies, was trading lower by 0.28 per cent at 100.37 on Thursday.

Meanwhile, global oil price benchmark Brent crude declined 0.64 per cent to USD 79.14 per barrel. In the domestic equity market, the 30-share BSE Sensex jumped 371.95 points or 0.52 per cent to settle at an all-time high of 72,410.38 points. The broader NSE Nifty soared 123.95 points or 0.57 per cent to 21,778.70 points. (PTI)

WASHINGTON, Dec 28: Social media companies collectively made over \$11 billion in U.S. advertising revenue from minors last year, according to a study from the Harvard TH Chan School of Public Health published on Wednesday. The researchers say the findings show a need for government regulation of social media since the companies that stand to make money from children who use their platforms have failed to meaningfully self-regulate. They note such regulations, as well as greater transparency from tech companies, could help alleviate harms to youth mental health and curtail potentially harmful advertising practices that target children and adolescents.

To come up with the revenue figure, the researchers estimated the number of users under 18 on Facebook, Instagram, Snapchat, TikTok, X (formerly Twitter) and YouTube in 2022 based on population data from the U.S. Census and survey data from Common Sense Media and buoyant note," said Siddhartha Pew Research. They then used data from research firm eMarketer, now called Insider Intelligence, and Qustodio, a parental control app, to estimate each platform's U.S. ad revenue in 2022 and the time children spent per day on

each platform. After that, the researchers said they built a simulation model using the data to estimate how much ad revenue the platforms earned from minors in the U.S.

Researchers and lawmakers have long focused on the negative effects stemming from social media platforms, whose personally-tailored algorithms can drive children towards excessive use. This year, lawmakers in states like New York and Utah introduced or passed legislation that would curb social media use among kids, citing harms to youth mental health and other concerns.

Meta, which owns Instagram and Facebook, is also being sued by dozens of states for allegedly contributing to the mental health crisis.

"Although social media platforms may claim that they can self-regulate their practices to reduce the harms to young people, they have yet to do so, and our study suggests they have overwhelming financial incentives to con tinue to delay taking meaningful steps to protect children,' said Bryn Austin, a professor in the Department of Social and Behavioral Sciences at Harvard and a senior author on the study. US companies are picky about investing in China

WASHINGTON, Dec 28: There's been no shortage of tough news for China's economy as some of the world's biggest brands consider or take action to shift manufacturing to friendlier shores at a time of unease about security controls, protectionism and wobbly relations between Beijing and Washington.

Count Adidas, Apple and Samsung among those looking elsewhere.

But as a tumultuous 2023 for the Chinese economy comes to a close, there has been at least one bright spot for Beijing when it comes to foreign investment: American fast-food chains have decided a market of 1.4 billion people is simply too delicious to pass up.

KFC China's parent company opened its 10,000th restaurant in China last month and aims to have stores within reach of half of China's population by 2026. McDonald's is planning to open 3,500 new stores in China over the next four years. And Starbucks invested \$220 million in a manufacturing and distribution facility in eastern China, its biggest project outside the U.S.

This is surely not what Chinese President Xi Jinping had in mind as he made the case to American CEOs about the upside of China's "super-large market" last month while he was in San Francisco for a summit of world leaders. The investments in fast food and other consumer goods, while Washington is curbing exports of computer chips and other advanced technology, don't fit into China's own blueprint for modernizing its economy.

"As you try to interpret the signals from Mc-Donald's and Starbucks" and other chains, says Phil Levy, chief economist at the supply chain management firm Flexport, "note what the industries are: These are not high-tech burgers.'

And while some U.S. companies are increasing investments in the world's second-largest economy, overall foreign investment began falling this year. In the July-September quarter. net foreign direct investment in China sank to a deficit of \$11.8 billion, the first quarterly deficit since Beijing began publishing the data in 1998.

As tensions simmer between China and its Western trading partners, many multinational companies are shifting investments to other places, such as Southeast Asia or India, or repa-



triating their earnings. That has sapped China of a key engine when its economy has yet to fully recover from the disruptions of the pandemic and a property industry crisis that has

been a drag on growth. Beijing puts some of the blame on U.S. government policies.

Commerce Ministry spokesperson Shu Jueting said recently, "The U.S. side has repeatedly politicized economic, trade and technology issues and overstretched the concept of security, abused export control measures, and restricted trade and investment in China by its own enterprises, which is forcing enterprises to give up opportunities in the Chinese market and opportunities for win-win cooperation."

A survey released in September by the U.S.-China Business Council, which represents American companies in China, suggested that the uncertainty has taken a toll: 43% of its members said China's business environment had deteriorated in the past year, and 83% said they were less optimistic about China than they had been three years ago. Twenty-one percent said they were investing fewer resources in China, versus just 10% who were investing more.

Surveys of European and Japanese companies have shown similar results.

While China's market is gigantic, it's ailing. Unemployment among young Chinese rose to over 20% by June, the last time the government released that data. Housing prices are falling and the stock market is down nearly 15% since the summer. That's left many Chinese feeling nervous about spending.

Still, bullishness for China as other industries try to de-risk and detangle from Beijing may be a profit-increasing strategy for the fastfood industry.

"We believe there is no better time to simplify our structure, given the tremendous opportunity to capture increased demand and further benefit from our fastest-growing market's long-term potential," McDonald's CEO Chris Kempczinski said as the Chicago-based company announced in November it was increasing its minority 20% ownership of its McDonald's licensed stores in China, Macau and Hong Kong to 48%

Burgers and lattes don't raise the sorts of friction that more high-tech industries have in the complicated U.S.-China relationship. Those strains have persisted under the presidency of Joe Biden, who took office vowing to do more to counter China's expanding military clout and its menacing of neighbors, to improve the country's treatment of Uyghur and other ethnic minorities, and to crack down on intellectual property theft.

Relations hit a low point in February when Biden ordered a Chinese spy balloon that traversed the continental United States to be shot down. Beijing, which claims self-governed Taiwan as its own territory, also protested a stopover in the U.S. by the island's president, Tsai Ing-wen, earlier this year. China answered fresh U.S. controls on exports of advanced computer chips and the technology to make them with limits of its own on exports of vital commodities like graphite, gallium and germanium, all metals used in making semiconductors, solar panels, missiles and radar.

The relationship appears to be stabilizing somewhat as 2023 winds down, highlighted by last month's Biden and Xi meeting outside San Francisco. But since then, Biden's top advisers have said there are no plans to shift the strategy of tightening regulations and blocking U.S.-based high-tech investments in China, citing the need to safeguard national security.

Both former President Donald Trump, the 2024 GOP presidential front-runner, and Biden have worried about depending on China, a potential adversary, for supplies of critical materials used in many high-tech products. Both have sought to reduce America's reliance on Chinese factories and have encouraged compa-

nies to shift away from China to other countries so-called "friend-shoring."

Still, Biden administration officials have said they don't want to see a total decoupling of the world's two biggest economies.

"De-risking, yes. Decoupling, no," Nicholas Burns, the U.S. ambassador to China, said at a recent event in Washington. "We want to continue a major trade and investment relationship with China, just not ... in the realm that might help them leapfrog over us sometime in the next 10 years in military technology."

Rosemary Coates, executive director of the nonprofit Reshoring Institute, noted that decisions to expand or retrench are relatively easy for a company like McDonald's or its fast-food rivals.

Franchises "can be opened or closed," Coates said. "It's not like you're investing in an auto plant or some kind of machine shop.

China's vast market is vital for many foreign companies: At their annual investors day gathering this month, McDonald's executives noted that 70 million of the 150 million customers active in its customer loyalty program are in China

KFC China says growth in its new outlets has averaged more than 22% over the last five years. The chain Popeyes Louisiana Kitchen relaunched its brand in China in August with a flagship restaurant in Shanghai and plans to open 1,700 stores over the next 10 years.

But for all the promise of China's huge market, U.S. businesses have other reasons to think twice about expanding in China.

In July, the U.S. recommended Americans reconsider traveling to China because of arbitrary law enforcement and exit bans and the risk of wrongful detentions. Commerce Secretary Gina Raimondo has warned Chinese leaders that U.S. businesses might stop investing in their country if they do not address complaints about worsening conditions due to raids on firms, unexplained fines and unpredictable official behavior.

While insisting that China is keen to have foreign investment, Beijing has given no indication it might change trade, market access and other policies that irk Washington and its other trading partners. (AP)

India-UAE oil transactions

Tndia and the UAE recently completed their first transaction in rupees for crude oil from the Emirates. A major shift in how global trade is conducted, typically done in dollars, this step is a significant boost to the growing trade between India and the UAE, which is likely to surpass the \$100 billion target within a few years. Businesses and traders from both countries welcomed this move as an important part of their cooperation. It opens the door for better economic partnership and simplifies international financial dealings. After the Comprehensive Economic Partnership Agreement (CEPA) was signed in 2022, trade between the UAE and India increased to \$85 billion. The UAE became India's third-biggest trading partner and the secondbiggest export market in the fiscal year 2022-23. In turn, India ranked as the UAE's second-largest trading partner. For India, which is the third-largest energy consumer in the world, using its own currency for payment is a significant step in its strategy to reduce reliance on the widely-used dollar and to increase the global use of the Indian rupee. This aligns with the BRICS, of which India is a member, strategy to shift away from the US dollar as the dominant global reserve currency.

Experts in currency matters explain that trading using the rupee removes the necessity of converting into another currency for import or export payments, and aids in preserving foreign exchange reserves. Making the Indian rupee more widely used internationally could lower India's borrowing costs and help establish the rupee as a recognized payment medium for global trade transactions. As the rupee gains popularity in international trade transactions, it might eventually reach the status of a strong currency, similar to the US dollar. The initiative to use the rupee for payments is in line with the Reserve Bank of India's (RBI) decision on July 11, 2022, which permits importers to make payments in rupees and allows exporters to receive payments in the local currency. Since then, India has taken measures to enhance the role of the rupee in international payments, authorizing over a dozen banks to conduct trade settlements in rupees with 18 different countries.

India has been actively persuading other major oil exporters, including Saudi Arabia and Russia, to accept the Indian rupee for their trade transactions. During Prime Minister Narendra Modi's trip to the UAE in July, the Central Bank of the UAE and the Reserve Bank of India signed two agreements. The first agreement aimed to create a structure for using local currencies in international transactions, while the second focused on connecting their payment systems. After the deal with the UAE on rupee settlements, the Indian Oil Corporation paid for one million barrels of crude oil from Abu Dhabi National Oil Company using Indian rupees. Some of India's oil imports from Russia have also been paid for in rupees. India's Commerce and Industry Minister Piyush Goyal said that India has been working with the UAE to increase bilateral trade to a \$100 billion target.

Following approximately eight hours of questioning by the Central Bureau of Investigation (CBI) regarding alleged irregularities in the now-discarded Delhi excise policy, Sisodia faced a significant turn of events. The sequence leading to Sisodia's arrest by the CBI commenced in July 2022, triggered by a report from Delhi Chief Secretary Naresh Kumar to Lt Governor Vinai Kumar Saxena. The report accused Sisodia of granting undue advantages to liquor vend licensees in exchange for alleged "kickbacks" and "commissions," purportedly utilized by the Aam Aadmi Party (AAP) during the February Punjab Assembly elections earlier that year. The arrest marked a critical moment in a narrative rife with political implications and legal intricacies. March unfolded with the polit-

ical landscape in the Northeast taking center stage, marked by crucial elections and a significant development in the Lok Sabha. The BJP secured a resounding victory in the Tripura Assembly elections, reclaiming power in Meghalaya and Nagaland as a junior coalition partner.

On the political front, the Congress found relief as senior leader Rahul Gandhi returned to Parliament following the Supreme Court's stay on his 2019 criminal defamation case related to his remarks on the 'Modi' surname. The restoration of Rahul's membership by the Lok Sabha Secretariat, about four months after its revocation, brought a notable development in the political landscape.

September marked the pinnacle of India's year-long presidency of the G20 with the highly anticipated summit held in New Delhi. Leaders from the world's most influential nations gathered in the capital, culminating in the adoption of a G20 Leaders' Declaration. Against the backdrop of a global geopolitical shift, exacerbated by the Russia-Ukraine war and the ongoing impact of the Covid-19 pandemic, India assumed leadership during a critical period. The economic reverberations of these twin events disproportionately affected developing and underdeveloped countries, hindering their efforts toward post-pandemic recovery. Despite nearly five months passing since the initiation of clashes during a tribal solidarity

march in Manipur, the state remained ensnared in tension. Ethnic conflict between the Meitei and Kuki communities' fuelled undating four districts, including Mangan, Gangtok, Pakyong, and Namchi on October 4.

Meanwhile, the Supreme Court, in a unanimous decision, refrained from recognizing same-sex marriages, emphasizing that such a determination falls within the purview of the legislature. Any judicial interference in this matter, the court asserted, would constitute an encroachment on the legislative domain. Additionally, the month witnessed a tragic series of explosions during a Sunday prayer convention hosted by the Christian denomination Jehovah's Witnesses near Kochi in Kerala. The blasts claimed the lives of at least 7 individuals and left over 30 others injured, casting a somber shadow over the month.

November saw the resurgence of election fervour as Madhya Pradesh, Rajasthan, Chhattisgarh, Telangana, and Mizoram headed to the polls, setting the stage for the upcoming 2024 Lok Sabha elections. Despite a formidable campaign, India experienced collective heartbreak as it narrowly missed securing victory in the ODI World Cup after an impressive 40-night streak of invincibility, stumbling on the 41st night to a subdued defeat.

The month's highlight, however, centered around a monumental rescue mission to extract 41 workers trapped in the aftermath of a tunnel collapse in Uttarakhand. Spanning over 400 hours, the operation tested resolve, grit, and perseverance on both sides of the 57 meters of debris. Overcoming setbacks, the final lap saw 14 "rat-hole miners" break through the last 12 meters, reaching the trapped individuals and eliciting a nationwide sigh of relief.

December unfolded with the announcement of new governments in Madhya Pradesh, Rajasthan, Chhattisgarh, Telangana, and Mizoram following the Assembly polls on December 3 and 4. The BJP-led National Democratic Alliance secured a resounding victory in Madhya Pradesh, overturning Congress governments in Raasthan and Chhattisgarh, solidifying its authority in 17 states and Union Territories. Despite a consolation win for the Congress in Telangana, where it secured 64 seats and a 39.4% vote share, the party's robust performance reinforces its presence in the South.

osy political scientist, political analyst and political observers have been scratching their heads to understand, where is the opposition in the upcoming national election scheduled to be held on January 7, 2024

Which party will sit on the opposition bench in the magnificent iconic Jatiya Sangsad (parliament) building?

It should not sound strange that in an election, a party that gets a majority in an election forms a government, while the runners-up (second majority) takes a seat on the opposition bench in the parliament. That's a norm in political science.

A day before, the European Union (EU) was equally curious to know where the opposition is.

The EU asked the governing Awami League general secretary, Obaidul Quader, to know who would be the opposition party in the 12th national parliament.

Quader, also Road Transport and Bridges Minister said 'The results of the polls will tell who will be the opposition.' Indeed, a simple answer to a complex question.

In Bangladesh, the governing party Awami League has ensured that the principal opposition Bangladesh Nationalist Party (BNP) is eliminated and thousands of the key leaders, members and supporters are behind bars.

The trumped-up cases are mostly terrorism, vandalism and destruction of government properties.

The Awami League has sacrificed six constituencies for its alliance partners and 26 for the Jatiya Party in the national election, said the ruling party's Office Secretary Biplob Barua that their party leaders have withdrawn their candidacies from these 32 seats. Thus the party will contest for 263 constituencies.

On the other hand, the Jatiya

Party Secretary General Mujibul Haque Chunnu announced that the party will contest for 287 constituencies, out of 300.

With the Jatiya Party joining, the pre-election camp gets bigger, writes Jahidul Islam in the Business Standard.

If the Awami League shares seats with the Jatiya Party the latter will become a "loyal opposition" that will be subservient to the governing party and would hardly oppose not debate any bill that goes against the freedom and rights of the people.

The 'loyal opposition' will need not walk out from the session nor debate in the parliament, other than asking for political favour for the party and their members only.

Meanwhile, upbeat Awami League lawmaker Prof Mohammad A. Arafat and Chairman of Suchinta Foundation who is active on Twitter (X) writes: 30 former parliamentarians, including five advisors to the (opposition) BNP Chairperson and 15 members of the BNP Central Committee, are participating in the election.

Apart from the central leaders, 87 leaders of the BNP, including the president, vice president, general secretary of the district, and upazila (sub-district) level, are contesting the election.

Arafat, who is an active cyber warrior against the opposition (BNP) and critic of the Awami League regime troll army, seems to justify the absence of BNP and others in the poll and remarked that "They look set to mount a tough challenge in many seats. In addition, the Jatiya Party and its 14-party partners will also face stiff competition in many seats. Trinamool BNP and BNM (Bangladesh Nationalist Movement) have also fielded strong candidates in many seats. (The author is an award-winning independent journalist based in Bangladesh. Cash still fundamental part of the Indian daily life

n 2016, India suddenly stopped using two types of banknotes, which made Lup 86% of all the money in use. This was done to fight corruption and hidden wealth.

Known as Demonetisation, this action led to chaos at banks and ATMs. Critics argued it harmed those with low incomes and disrupted India's large cash-based economy. Prime Minister Narendra Modi stood by the decision, stating it reduced hidden wealth, improved tax adherence, and enhanced transparency.

Seven years after the ban, cash is still widely used in India, raising questions about the effectiveness of the move. The Reserve Bank of India reports that in 2020-21, the amount of cash in use grew by 16.6%, which is higher than the 12.7% average growth rate of the previous ten years. The cash-to-GDP ratio, a measure of cash usage, reached over 14% in 2020-21 before dropping slightly to 13% in

2021-22. Meanwhile, digital payments are also increasing, helped by more people using smartphones and debit cards, and the government's digital distribution of welfare benefits.

The rise in digital payments in India is mainly due to the Unified Payments Interface (UPI). This system allows quick and easy transfers between bank accounts using financial apps. In the last year, the value of UPI transactions exceeded one trillion dollars, which is about a third of India's total economy. India saw an impressive 89 million transactions, making up 46% of all digital payments worldwide, as reported by ACI Worldwide and Global Data in 2023

The fact that both cash and digital payments are growing at the same time is often called a "currency demand" paradox. The Reserve Bank of India's latest annual report explains that this is surprising because cash and digital payments are usually seen as alternatives to each other, so their simultaneous increase doesn't

seem to make sense. People are using ATMs less and the speed at which money is being passed around in the economy has decreased.

Despite this, many in India still see cash as an important way to save for emergencies and as a way to keep value. As of March 31, the larger currency notes (500 and 2,000 rupees) made up over 87% of all banknotes in use, as per the Reserve Bank of India. Interestingly, the central bank stopped using the 2,000-rupee note, the highest value note, which was introduced after the 2016 currency ban.

Before the pandemic, a study showed that people liked using cash for small buys and digital methods for bigger ones. A recent survey by LocalCircles, a community social media platform, revealed that many people prefer cash for things like buying groceries, eating out, takeaways, paying for help, personal services, and home repairs

According to a paper by the Reserve Bank of India, the greater preference for cash could be due to lower interest rates on bank savings, the extensive informal and rural sectors, and more direct cash benefits given during the pandemic.

Politics and real estate also play a role in the ongoing use of cash. Undeclared money is still a significant source of funding for political parties during elections. For instance, income tax authorities recently discovered about 3.5 billion rupees (around \$42 million) at locations connected to an opposition MP. In 2018, Prime Minister Modi's administration introduced electoral bonds, which are limited-time, interest-free bonds of set values, with the aim of reducing illegal cash and increasing transparency in political funding. However, critics argue that these bonds have actually reduced transparency due to their secretive nature.

Most of the undeclared wealth is still found in the real estate sector. A survey by LocalCircles in November reported that 76% of people who purchased property in India over the past seven years used cash for the transaction, with 15% paying more than half of the total amount in cash. Only 24% stated they didn't use cash, compared to 30% two years earlier. The importance of cash in real estate deals is linked to property developers depending on the backing and favour of politicians, as discovered in a study by the Financial Experts

India isn't alone in seeing both digital and physical cash grow together. The European Central Bank, in a 2021 report, mentioned a "paradox of banknotes". They observed that although the usage of banknotes for shopping appears to be declining, the demand for euro notes has been rising continuously. Despite expectations of a decrease due to more digital payments, the actual demand for cash hasn't fallen, with the number of euro notes increasing since 2007. Sweden stands out as an exception, being the world's leading cashless society.

In India, cash is still a fundamental part of daily life for many. Seena, an auto-rickshaw driver in Bangalore, notes, "Most of my customers still pay in cash. Cash will never disappear." (*ÎPA Service*)

Are we headed for an open autocracy?

e are in a time of momentous transition. Recent events suggest that as a nation we could be headed for life-altering turbulence. Separately, each episode is of high impact, and together they have the potential to accelerate a process in the direction of an open autocracy that could betoken, for all practical purposes, a one-party state apparatus - bidding adieu to the constitution we have nurtured for 75 years – if circumstances remain supportive.

Predictably enough, in the short run, the most critical of these would be the return of Prime Minister Narendra Modi to office in the next Lok Sabha election, five months away. Whether as a propaganda trick or not, Modi has recently declared that a third straight win for him was a foregone conclusion.

Looking at the country's political map, it is a no-brainer that an effective coming together of the significant sections of the opposition in the major states will block Modi's further advance, and that may result in his relegation to the background. He appears to have way too many adversaries within the saffron universe who could turn vengeful if power slips from his grasp

The top shots in Lucknow, and not a few in Nagpur, the city of the RSS headquarters, or in Delhi, Bhopal and Jaipur, to say nothing of the second or third string players in elsewhere, who now pretend to be obsequious or dutiful, are likely to lose little time in getting even for real or perceived slights.

On the other hand, A failure on the part of the INDIA alliance parties to recognise the

magnitude of the historical moment they are navigating is poised to leave each of them isolated. Unity is, therefore, an existential imperative. Are they aware of this reality?

If anything, the recent assembly polls in the northern states, which the BJP won decisively, showed that the local Congress satraps were blissfully unaware of the great political significance of these particular elections and carried on as though it was business as usual. So was the Congress leadership, else it would have rapped the three erring chieftains on their knuckles for their tunnel vision when there was still time.

Rahul Gandhi was candid enough to bring up the subject in the December 21 meeting of the Congress Working Committee but, with the Congress, there is no knowing that the party won't fluff its lines again when it deals with partners and allies to prepare for the parliament election. After being displaced from its

high perch 30-odd years ago when the party was indeed a gargantuan enterprise - it has not quite figured out how to operate the philosophy of working in tandem with entities some of whom may well have a chip on their shoulder, being state parties that have made space for themselves by edging out the Congress over time. Working in genuine partnership with the Congress is a lesson that the state parties of the INDIA alliance also need to learn – and in quick time. There is not much time left.

Comparisons of the present situation with the Janata experiment do not hold water. The entity that regional parties of the day (including the BJP's precursor, Jana Sangh, was also just that at the time) were called upon to ally with was not the



Congress but a disgruntled Congress rump.

Modi played a high-stakes game in the recent elections in Rajasthan, Madhya Pradesh and Chhattisgarh. He would have been acutely conscious that in the event of a serious setback in this battle, the wolves within the BJP would be out, baying for his blood. They would question his ability – or even credentials – to lead the party in the forthcoming Lok Sabha election. These polls were close to being a point of reckoning, if not a make or break moment, for the prime minister, although this was not apparent. Inherent in them was the potential to bring the 10-year Modi rule to a turning point, whether history marked a turn or

It is not clear the prime minister's Congress opponents figured any of this. They did not discern the sensitivity of the moment. They went about as though this was just another poll battle. They didn't understand that a positive result would give Modi the leap and momentum in advance of the key election in 2024 and help him set the field for the main battle ahead.

Though Modi was taking his chances, he was not playing blind when he forced the BJP's key state leaders – the architects of its past wins in Rajasthan, Madhya Pradesh and Chhattisgarh – out of the reckoning, appealing to the electorate to cast their vote in his name. He was aware that the wind of communalism was in his sails. Two important considerations would have weighed as inordinately powerful factors - Ayodhya and Kashmir.

After a long four-year wait, the Supreme Court decided to take up the Kashmir case - the challenge to the Union government jettisoning the constitutional autonomy of J&K. The arguments being reported in the press gave ample indication which way things were going. To many it seemed that the timing of an event of such magnitude may not be unrelated to the electoral timetable. The judgment came on December 11, 2023, after the recent assembly election results were announced, but forms a prelude to the parliament election due early next year.

Arguably the most crucial

event in setting the narrative of the new nationalism espoused by Modi and his party was the November 2019 Ayodhya judgment of the Supreme Court, which called the destruction of the Babri Masjid a "criminal act" but also, defying logic and common sense, handed over possession of the site on which t had stood to the so-called Hindu parties, meaning a clutch of Hindutva outfits. Since then, activities associ-

ated with the construction of the new temple to Lord Rama have been flooding the newspapers and social media. They have also found a regular mention in the BJP's speeches during the assembly elections. The inauguration of the temple scheduled for January 22, 2024, is the primary news in the Modi calendar, and is dutifully reflected in the mainstream media. This background became the

setting for the win in Rajasthan, Madhya Pradesh and Chhattisgarh, which has unbound the Prometheus of Hindutva, who is portrayed as a heroic figure – greater than anything that has happened to the Hindu suprema-

To add more grist to the mill, the temple disputes of Varanasi and Mathura appear to be continually stoked in the direction desired by the new nationalists by various levels of our judicial system, not excluding the Supreme Court.

Senior BJP leaders now routinely refer to Modi as the 'best' prime minister India has ever had, clearly surpassing Vajpayee and not to mention the great leaders of the freedom movement, such as Nehru, who is just about recognized as a former prime minister - and sought to be made less than significant. The already-established Modi cult owes not a little to its forceful promotion by Modi himself. who seeks to portray himself as larger than life and all-conquering. The G20 meet in Delhi this year was an illustration.

It is in the reign of this cult figure that a senior functionary of the Ayodhya temple administration has declared the upcoming inaugural of the temple on January 22 as an event of history on par with the independence of India from British rule in 1947. The new chief minister of Madhya Pradesh has said that the prime meridian, the internationally recognised zero degree longitude line, will now be made to pass through Ujjain in his state. which is the seat of the Lord Shiva as Mahakaal (the Great Time). The currently recognised marker is Greenwich near London, and the international time zones are calculated in relation to Greenwich to arrive at Greenwich Mean Time (GMT).

Modi is the "strong leader", the Hindutva forces hanker for, veritably the current avatar of the "Chakravarti samrat" of ancient India, a mighty, conquering ruler who cannot be accountable to his subjects, and cist ideology since its inception. who is beyond questioning or

reproach Then it is no surprise that the prime minister declared to a newspaper in an interview, ignoring the parliament which was in session, that the December 13 incident, which saw the breach of the security system in the new parliament building and the entry in utterly dumbfounding circumstances of some youths, shouting slogans and letting off smoke-filled canisters, into the Lok Sabha chamber, was "serious", but "there shall be no debate.'

What followed was predictable enough as the presiding officers of the Lok Sabha and the Rajya Sabha, in a space of three days suspended nearly 150 opposition MPs because they made a ruckus and showed protest placards when their demand for a statement by the Union home minister was ignored by the Chair.

For all practical purposes, the prime minister's statement about not encountering a debate became a diktat for those who run the chambers of parliament. It is plain that while Prometheus may have now broken free, thanks to multi-sided institutional capitulation, the institutions of modern India are themselves now in chains, waiting upon the will of the master. After this, if the next engagement is in the bag for the ruler, we may only anticipate a turn of enormous magnitude in our constitutional and political history.

This is the inverted reality the INDIA opposition alliance can overlook at its own peril as it goes about in its inscrutable meandering fashion to chart out an electoral battle plan. Grand upsets are a part of history, including our own not so distant electoral past. But it is not chance that brings it about. (Courtesy: The Wire)

Year-ender: How India battled extreme weather events in 2023's climatic turmoil

The World Meteorological Organization (WMO) revealed that 2023 was the warmest year globally, breaking all previous records. The WMO's provisional 2023 State of the Global Climate report, released before COP28, emphasised the urgent need for action to curb global warming and its devastating impacts.

This warming trend is mirrored in India, where the India Meteorological Department (IMD) reported the

its highest rainfall in four decades. Meteorologists and climate scientists attribute the escalating frequency of extreme weather events to rising global warming levels.

The Ministry of Earth Sciences, Government of India, underscores that monsoonal rainfall will intensify and affect larger areas due to increased atmospheric moisture content. The IPCC Report 2023 warns of a 20 per cent surge in extreme rainfall events in the Indian subcontinent, leading to incessant and erratic rain-

predicting the storm's trajectory across the Jakhau Port area, resulting in winds up to 125 km/h. The cyclone led to casualties, injuries, and widespread destruction of vegetation, infrastructure, and transport links. Rising sea surface temperatures in the Arabian Sea, attributed to climate change, were identified as a contributing factor to the cyclone's inten-

Another significant cyclone, Hamoon, struck the Bay of Bengal from October 23 to 25. With a maximum wind speed of 148 km/h, it affected the Eastern and Northeastern regions. Additionally, Cyclone Mocha, a Category 5 storm in the Bay of Bengal from May 11 to 14, did not make direct landfall in India but impacted Myanmar. These cyclones collectively resulted in a toll on human lives, causing casualties and injuries, while also inflicting substantial damage to infrastructure. The cyclones, exacerbated by climate change-induced factors, highlighted the vulnerability of coastal areas and underscored the need for effective disaster preparedness and mitigation measures in the face of increasingly frequent and intense tropical storms. 2023's unusual weather patterns

The Hamas' shrewd use of graphic videos and imagery from its initial spectacular violence in southern Israel and then the death and destruction caused by Israel Defense Forces' campaign in the Gaza Strip has generated a discernible pro-Hamas sentiment across many countries. This has acted as a stimulus for pan-Islamic terrorist groups like al-Qaeda (AQ) and the Islamic State (IS), as well as other regional terrorist organisations. In South Asia, too, terrorist organisations and their sympathisers are using developments in West Asia to spur radicalisation and rally vulnerable, impressionable youth to fill their ranks. **Global scenario**

Counter-terrorism experts around the world have noted that the Israel-Hamas conflict may cause a resurgence of the terrorist threat. The nature and scale of Israel's retaliatory strikes in the Gaza Strip have expectedly generated anger and condemnation across the Muslim world. Terrorist organisations like AQ have exploited these sentiments to assert their relevance. Days into the Hamas attack on Israel, AO's franchisees in North and West Africa commended the attacks and called for more violence against the Jews. Likewise, AQ's Somali affiliate, al-Shabaab, praised the Hamas fighters and termed it the "battle of the entire Muslim Ummah.

In Europe, there has already been a spillover of the West Asian developments. According to a report by the Center for Science and Environment, a significant shift has been observed in the winter, traditionally India's second-west period, with January and February experiencing above-average temperatures for the third consecutive year.

February 2023 was notably the warmest on record since 1901, accompanied by an alarming decline in rainfall, particularly in Central India. and a 76 per cent deficit in the Northwest region. Experts attribute these anomalies to changes in Western Disturbances (WDs), cyclonic storms originating in the Mediterranean, influenced by climate change.

Heatwaves persisted into June, impacting 12 states/UTs (union territories) and attributed to human-caused climate change by Climate Central. Between June and August, 11 states/UTs experienced higher temperatures, made at least three times more likely by the climate crisis. The India Meteorological Department linked this trend to greenhouse gas emissions from fossil fuels, projecting a further increase in frequency and duration by 2060. The pre-monsoon season in March witnessed extreme storm activities, leading to the highest rainfall in Central India and the Southern Peninsula since 1901. April saw unprecedented hailstorms on 27 out of 30 days, with heatwaves occurring seven days in at least nine states. A study by the World Weather Attribution (WWA) attributed these heatwaves in April to climate change, predicting their increased frequency.

Monsoon meltdown and climateinduced extremes

In 2023, India confronted a surge in extreme weather events, signalling a new normal heightened by climate change. The year commenced with unprecedented temperatures in February, breaking a record of the past 123 years. The impact of climate change became evident in April and June, marked by a humid heatwave in East and Central India that was made 30 times more likely. Cyclone Biparjoy in the Arabian Sea lingered for 13 days, setting a record as the longestduration cyclone since 1977.

Incessant rainfall wreaked havoc in North-West India, prompting flash floods and landslides in Himachal Pradesh, while Delhi grappled with

fall, intensifying floods, and more frequent cyclonic events.

India has witnessed a rise in average temperatures, decreased monsoon precipitation, increased extreme events, and a rise in sea levels since the mid-20th century. Analysts emphasise the continuous moisture feed from the Bay of Bengal and the Arabian Sea contributing to extreme weather events.

Himalayan vulnerability unveiled

In the tumultuous landscape of the Himalayas, 2023 has unfurled a harrowing sequence of events, with the latest being a Glacial Lake Outburst Flood (GLOF) wreaking havoc in Sikkim. From the submersion of Joshimath to the extensive losses witnessed in Uttarakhand and Himachal Pradesh during the monsoon, the region grapples with unprecedented rainfall, landslides, and accelerated glacial melt, signalling the unmistakable impacts of climate change.

The intricate interplay of geological, hydrological, and meteorological hazards, coupled with an elevated seismic risk, paints a dire picture for the Himalavas. The existing framework reveals shortcomings in handling high-risk projects, often neglecting the impacts of climate change and lacking sophisticated methodologies.

The Himalayan region, home to numerous operational and upcoming hydroelectric projects, calls for a twofold approach: ensuring mega projects align with environmental preservation and fortifying against multiple threats through comprehensive risk assessments. The evolving climate crisis necessitates a proactive stance, incorporating all risks during project design and establishing independent bodies for impartial risk assessments in the Himalayas.

Cyclonic turmoil

In 2023, India faced the impact of several cyclones, contributing to a year marked by extreme weather events. Among the notable ones, Cyclone Biparjoy, the first severe cyclone of the year, made landfall in Western India near the Pakistan border on June 15. Initially classified as a very severe cyclonic storm, it was later downgraded to severe, causing substantial damage to Gujarat's Saurashtra and Kutch coasts.

The India Meteorological Department (IMD) issued an orange alert,

Climate scientists and experts highlight multiple factors contributing to the unusual weather patterns in 2023. These include the alignment of weather systems, an atmospheric phenomenon amplifying global temperatures, more enormous wildfires releasing more carbon, warming in the North Atlantic Ocean, exceptional warming in the Arabian Sea since January, and unusual upper-level circulation patterns.

The tragedy in Sikkim, where lives and infrastructure succumbed to the forces of a GLOF, brings to light the critical oversight in constructing hydropower projects, failing to account for these complex dynamics.

The escalating frequency and intensity of extreme weather events, intensified by global warming, cast a looming threat over the region. As the narrative of the Sikkim tragedy unfolds, it underscores the imperative need for a comprehensive re-evaluation of Environmental Impact Assessment (EIA) and Environment Clearance (EC) procedures.

Recognising the urgent need for action, India must intensify efforts to mitigate greenhouse gas emissions, transition to renewable energy, enhance energy efficiency, and adopt sustainable practices. Strengthening early warning systems and building resilience to extreme weather events are crucial for safeguarding communities.India's experience underscores the global imperative to address climate change collectively, focusing on reducing emissions and fostering adaptation measures to secure a sustainable future. NKorea's Kim vows to bolster war readiness to repel 'unprecedented' US-led confrontations

SEOUL, Dec 28: North Korean leader Kim Jong Un called for bolstered war readiness to repel what he said were unprecedented US-led confrontational moves in comments during a key political meeting tasked with setting state objectives for 2024, state media reported on Thursday.

Kim's comments indicated once again that North Korea will likely continue weapons tests to modernize its nuclear arsenal for the time being. But observers say Kim likely hopes to eventually use his boosted arsenal as leverage in diplomacy with Washington, possibly after the US presidential election in November next year. During Wednesday's second-day session of the ruling party's plenary meeting, Kim set forth unspecified tasks for the military and the munitions industry to "further accelerate the war preparations" in the face of "(anti-North Korea) confrontation moves by the US and its vassal forces unprecedented in history," the official Korean Central News Agency said.

It said Kim also clarified the party's stance on expanding North Korea's strategic cooperation with anti-imperialist countries amid the world's rapidly changing geopolitical situation. KCNA said Kim spoke about the direction of the North's dealings with South Korea as well but didn't elaborate.

The Workers' Party meeting is expected to last several days, and state media are expected to publicise details of its discussions after it ends, likely on December 31. Experts say North Korea is expected to come up with pledges and steps to strengthen its nuclear attack capability and expand cooperation with Russia and China, which are also locked in separate confrontations



with the US

Topics to be dealt with at the meeting could include North Korea's push to operate more spy satellites following its launch of its first military reconnaissance satellite on November 21. After the November launch, North Korea said it will submit to the plenary meeting a plan to launch more satellites to improve its spaced-based surveillance capabilities on its rivals.

Since last year, North Korea has performed a barrage of missile tests in breach of UN bans, including last week's launch of the solid-fueled Hwasong-18 intercontinental ballistic missile - its most advanced weapon designed to attack the mainland US The North has argued it has sovereign, legitimate rights to conduct such tests to deal with the expansion of US-South Korean military exercises that it views as invasion rehearsals. Kim has refused to return to diplomacy with the US since his high-stakes diplomacy with then-President Donald Trump fell apart in 2019. 

A Russian drone and artillery attack kills 6 in Ukraine and knocks out power in a major city

KYIV, Dec 28: Russia fired almost 50 Shahed drones at targets in Ukraine and shelled a train station where more than 100 civilians were gathered to catch a train to Kyiv, Ukrainian officials said on Wednesday. The barrages killed at least five people and knocked out power in most of the southern city of Kherson.

The aerial barrage came a day after Ukrainian warplanes damaged a Russian ship moored in the Black Sea off Crimea as both sides' soldiers struggle to make much progress along the front line of the 22-month war.

Overnight, the Kremlin's forces launched an artillery and drone bombardment of the Kherson region just as some 140 civilians were waiting for a train at the region's capital city of the same name, according to Ukrainian Interior Minister Ihor Klymenko. The shelling killed one policeman and injured two other police officers, as well as two civilians.More than 100 people who were waiting for the train at the time of the attack arrived in Kyiv on Wednesday morning, national rail operator Ukrzaliznytsia said.

The attack on the Kherson region and its capital hit residential areas and a mall winter cold, regional Gov. Oleksandr Prokudin said.

It was not immediately possible to estimate when power might be restored, he said. Targeting energy infrastructure was also a Russian tactic last winter, when it tried to break Ukrainians' spirit by denying them heating and running water. In Odesa, another major city in southern Ukraine, the drone assault killed two people and wounded three, including a

accident, at least six members of an Indian family, including two children, were killed when their minivan collided head-on with a pickup truck in the US state of Texas, officials

Seven people of the same family from Amalapuram town in Andhra Pradesh were in the minivan, and only one of them, 43-year-old Lokesh Potabathula, survived with critical injuries.

Authorities identified those who died as Potabathula's wife, 36-yearold Naveena Potabathula; the couple's children, 9-year-old Nishidha Potabathula and 10-year-old Krithik Potabathula; and Naveena Potabathula's parents, 60-year-old Sitamahalakshmi Ponnada and

64-year-old Nageswararao Ponnada. The DPS identified the driver of the minivan, 28-year-old Rushil Barri of Irving, as one of the deceased victims. The elderly were visiting their daughter Naveena and

Argentina's unions take to the streets to protest president's cutbacks, deregulation and austerity

union members and activists took to the streets of Argentina's capital on Wednesday to protest a decree from President Javier Milei that imposes sweeping deregulation and austerity measures meant to revive the country's struggling economy. Unions had asked a court for a prior injunction to block measures lifting some labour protections, but a judge rejected the appeal, noting the decree had not yet entered into effect. It does so on Friday.

Argentine labour activists question whether Milei, a self-described anarcho-capitalist who has long railed against the country's "political caste," can impose the measures by way of an emergency decree bypassing the legislature where his party has few seats.

"We do not question the president's legitimacy ... but we want a president who respects the division of powers, who understands that workers have the need to defend themselves individually and within the framework of justice when there is unconstitutionality," said Gerardo Martínez, general secretary of Argentina's construction workers' union. The protest went off peacefully, except for a confrontation between a small group of protesters and police. Journalists were caught up in the scuffle as police broke up the group of protesters, and some were beaten by police. 'The country is not for sale!" some protesters chanted, apparently referring to proposals that would allow the privatization of state-run industries. BRUSSELS, Dec 28: Jacques Delors, a Paris bank messenger's son who became the visionary and builder of a more unified Europe in his momentous decade as chief executive of the European Union, has died in Paris, the Delors Institute think tank told The Associated Press on Wednesday. He was 98.

"The whole of Europe mourns the death of one of its greatest architects," the institute said in a statement. "The best results of European integration cannot be dissociated from the vision, the courage, the conviction, the perseverance and the relentless work which characterized Jacques Delors' work during his 10 years at the head of the European Commission." Paying tribute, the office of French President Emmanuel Macron said: "This grandson of farmers and the son of a bank employee, whose rise was entirely due to his talent, never allowed the lofty heights to corrupt his human righteousness."

Delors "became the builder of the EU as we know it today," German Chancellor Olaf Scholz wrote on X,

Polish president tangles with new government in battle over control of state media

For many, the owlish but harddriving Socialist and Catholic was simply "Mr. Europe." The EU, which stretches these days from Finland to Portugal and is home to some 450 million people, was dubbed "the house that Jacques built" by a popular biography.

Under his 1985-1995 tenure at the head of the EU's bureaucracy in Brussels, member countries agreed to tear down barriers that prevented the free movement of capital, goods, services and people. Delors was also key in drawing up the blueprint for economic and monetary union, which led to the creation of the European Central Bank and the euro currency

The latter, considered by many to be Delors' masterpiece, is now official tender for 20 of the 27 EU nations. But in the years leading up to his death, some of Delors' handiwork came under threat. A narrowly averted crisis over Greece shook the eurozone, while the EU's borders came under pressure from hundreds

of thousands of refugees and other migrants, revealing fault lines within the bloc. In 2016, the U.K. voted to leave the EU in a repudiation of the "ever-closer union" the former EU Commission president toiled to forge.

Further expansion eastward of the EU into territory once controlled by Moscow had been halted by ferocious Kremlin opposition. And the economies of many of the bloc's member nations appeared to be stuck in idle, with persistent low growth rates and millions of people unable to find work.

In remarks that may ring as true today as when he left office. Delors in 1995 cautioned fellow Europeans that "we have a future filled with danger." He insisted their countries, which spent centuries at one another's throats in devastating and bloody wars, must continue to strive for "agreements at political, social and economic levels.

For many, the moody Frenchman with big ideas yet painstaking attention to detail was the most influential figure in constructing a more united Europe since the postwar founders of the Common Market decided to bind their nations together to prevent another war.

Wim Kok, a former Dutch prime minister, admiringly called Delors the man "who for 10 years determined the face of Europe like no other." "I am satisfied like an artisan from whom someone ordered a table and chairs, who did everything he could to craft a fine work, and who today sees it in front of him.' Delors told a newspaper reporter in 1998, three years after leaving Brussels. (AP)

SHILLONG, Dec 28: Electoral activities dominated the early part of 2023 in Meghalaya, where the National People's Party formed government with support of the BJP, as the year also remained witness to an MLA's defiant fast over a reservation policy, interstate border issues and ethnic strife.

Led by its charismatic young leader Conrad K Sangma, the NPP bagged 26 seats in the 60-member House, seven more than what the party had managed in the 2018 assembly polls.

The NPP got another shot in the arm in May, when the People's Democratic Front (PDF), along with two MLAs, merged with it, increasing the ruling party's tally to 28.

Despite Prime Minister Narendra Modi and top central ministers campaigning for the BJP, the saffron party could only retain the two seats it had won in 2018.

The Opposition Congress and the TMC secured five seats each, while the newly floated Voice of the People Party (VPP) won four.

Within months of formation of the new government, VPP chief Ardent Basaiawmoit began a fast that lasted for over 200 hours, demanding the Conrad K Sangmaled Meghalaya Democratic Alliance government constitute an expert committee to review a 51-year-old reservation policy.

The state government announced the constitution of such a panel to review the 1972 policy, which awarded 40 per cent

In September, clashes broke out at Lapangap village and the situation remained tense for weeks, as people of two ethnicities attacked each other with catapults, bows and arrows.

At one point, the Assam Police resorted to firing teargas shells to disperse unruly crowds, which engaged in violence by burning down huts, police had said.

The relocation of residents of the Punjabi Lane area here also made news in Meghalaya during the year, as the state government proposed to shift 342 families from the disputed area to land owned by the Shillong Municipal Board.

People from Punjab, who were brought to Shillong around 200 years ago by the British, live in the area.

After initial reluctance, the residents agreed to the proposed relocation but with certain demands, including the government providing them plots and bearing the cost of constructing their houses

The genesis of the relocation can be traced to a clash that erupted in the area, after a person was assaulted in May 2018. Thereafter, the Shillong Municipal Board began an exercise to determine the legal residents of the area. (PTI)

Meghalaya govt to hire chopper for VIP movement: CM

SHILLONG, Dec 28: Meghalaya chief minister Conrad K Sangma on Thursday said his government plans to hire a twin-engine chopper exclusively for the movements of VIPs.

The VIP chopper service is valid initially for three months.

"It is necessary sometimes. It saves a lot of time. Movements need to be done by senior leaders. Keeping fiscal constraints (the state is facing), we are not procuring a chopper but will be hiring on an hourly usage basis," the chief minister said in a statement.

He said, "We are giving out a tender for a short-term lease and we pay on an hourly basis. That is the most efficient way and will not incur much financial burden"

The chief minister's statement came in the wake of reports that the state government plans to procure a chopper

for VIP movements. He said the state government has come up with a tender to hire chopper

services and not for procuring a chopper because that in itself is very expensive.

He also said that the normal sorties for the Shillong-Tura-Guwahati route used by visitors get disturbed when VVIP takes the choppers.

The Transport department had on December 22 floated an advertisement requesting a proposal for wet lease of one twin-engine helicopter with a seating capacity of 4-5 passengers.

The last date for submission for the proposal is January 2, 2024, while the tender will be opened on January 16 following which the winning bidder will have to make the chopper available within 5 days for the government's usage. (PTI)

Tripura BJP MLA Surajit Datta dies after prolonged illness

AGARTALA, Dec 28: Tripura BJP MLA Surajit Datta passed away at a Kolkata hospital on Wednesday night after a prolonged illness, according to officials.

Dutta (70) is survived by wife and daughter. The Ramnagar MLA, who had been suffering from multiple diseases, was admitted to an Agartala hospital on Tuesday due to breathlessness. He was then transferred to Kolkata for better treatment, but died during the process.

Tripura Chief Minister Manik Saha expressed his sorrow in a Facebook post, saying, "I am saddened and pained by the death of senior politician and sitting BJP MLA Surajit Dutta during treatment in a hospital outside the state.

Saha added, "His death is an irreplaceable loss for the state. May his soul rest in eternal peace. My deepest sympathies go out to the grieving family. Om Shanti.'

Tamil actor, DMDK founder leader Vijayakanth dies Vijayakanth was to offer alternative to DMK, AIADMK


CHENNAI, Dec 28: DMDK founder-leader and popular yesteryear Tamil actor Vijayakanth, who sowed the seeds of hope among his supporters on the possibility of a real alternative to the Dravidian majors, the DMK and AIADMK, died here on Thursday following illness.

Praised as 'Karuppu MGR' (black MGR) by his fans for his generosity, Vijayakanth had been ill and kept a low profile for the past 4-5 years and his wife Premalatha formally took over the reins of the DMDK on December 14 and she was declared the general secretary at a party meet here.

Vijayakanth aged 71 was popular as 'Captain' after he performed the role of an IFS officer in the 1991 blockbuster Tamil movie 'Captain Prabhakaran.' He is survived by his wife and two sons. Vijayakanth was born Vijayaraj to KN Alagarsamy and Andal Alagarsamy in the temple town of Madurai. Prime Minister Narendra Modi and chief minister M K Stalin were among a string of leaders to condole the death.

The acclaimed actor, even before he gave the hope of a new messiah after his political entry in 2005, had a huge fan following, which he organised well into a structural unit and that stood him in good stead when he took the political plunge.

Respected as a philanthropist erable influence, was seen as a



and hailed by the Tamil film world and fans alike for over two decades (since the early 1980s) as 'the macho actor' and real life saviour, that impressive on and off-screen charisma appeared to translate well electorally too, considering the DMDK's performance, which bet on eradicating poverty and corruption. Vijayakanth's spirited fight against graft in movie 'Ramana' immediately struck a chord with the electorate during his initial years in politics. Within a year of its formation the Vijayakanth-led party garnered about 8.40 per cent votes in the 2006 assembly election, though only Vijayakanth managed to win. His maiden win from Virudhachalam in northern Tamil Nadu, where the Pattali Makkal Katchi wielded consid-

positive sign of his mass appeal. His run-in with the PMK, which opposed the entry of actors into politics helped him strengthen his political standing. In the 2009 Lok Sabha polls, the actor- turned-politician's party had a little over 10 per cent vote share. Though Vijayakanth had often repeated that his 'alliance is only with the people,' the party allied with the AIADMK in the 2011 Assembly elections.

The Jayalalithaa-led bloc won the polls and the DMDK founder went on to become the Leader of the Opposition (2011-16) by winning from the Rishivandiyam constituency in northern TN. In 2011, the DMDK won 29 As-

sembly segments after contesting 41 seats (nearly eight per cent vote share) and emerged as the second

largest party. Though an ally, he questioned the powers-that-be and his verbal duel with Javalalithaa in the Assembly took the state by storm and he appeared all set to break the hegemony of the Dravidian parties, that have held sway for over half a century in Tamil Nadu's politics. After the AIADMK-DMDK al-

liance soured, the DMDK joined the BJP-led alliance for the 2014 general election, in which, the PMK and Vaiko-led MDMK were also constituents.

In the alliance, though Vijayakanth's party got the lion's share of 14 out of 39 LS seats in Tamil Nadu, it failed to win even a single seat and the party's vote share plummeted to 5.1 per cent. In the 2016 Assembly polls, the

DMDK was the major party in the Makkal Nala Kootani (People's Welfare Front), a four-party front in which the Left parties, MDMK and the VCK were partners.

The alliance parties faced a rout and the Chief Ministerial candidate of the front, Vijayakanth lost his deposit in Ulundurpet.

The DMDK could only garner about 2.4 per cent vote share in 2016 and in the 2019 LS polls drew a blank after contesting in four Parliamentary constituencies as part of the AIADMK-BJP alliance and it also lost the EC recognition of a state party. The gradual slide continued between 2011 and

2016 when functionaries and MLAs had either quit the party or were expelled over several issues. From 2016 onwards, Vijayakanth's health gradually deteriorated and in view of his poor health he could not devote time for party affairs. Considering factors such as absence of robust secondrung leaders, the party's decline appeared irreversible.

Under Premalatha's stewardship, the DMDK faced the 2021 Assembly election as a partner of the TTV Dhinakaran-led Amma Makkal Munnetra Kazhagam and it faced a rout again. Vijayakanth named one of his two sons as Prabhakaran and championed the rights of Tamils in Sri Lanka. His wedding with Premalatha and several family functions had been presided over by late DMK patriarch M Karunanidhi. MIOT International hospital said in a press release: "Captain Vijayakanth was on ventilatory support following his admission for pneumonia. Despite the best efforts of the medical staff he passed away in the morning on 28th December 2023."

While the party statement had said that Vijayakanth had tested positive for coronavirus and was under ventilator, the hospital bulletin said he battled pneumonia. Hospital sources said the party issued that statement even before the results for the second round of samples were available. (PTI)



ED probes land transactions

NEW DELHI, Dec 28: Purchase of three plots of land in Harvana in 2005-06 by Congress leader Sonia Gandhi's son-in-law Robert Vadra from a real estate agent is being probed along with a land deal made by his wife Priyanka Gandhi Vadra, the Enforcement Directorate (ED) claimed in a recently filed money laundering case charge sheet.

The federal agency filed the charge sheet (prosecution complaint) in November before a Delhi court against UAE-based NRI businessman C C Thampi, who is allegedly linked to Robert Vadra, and Sumit Chadha, a relative of alleged middleman Sanjay Bhandari. Though Robert Vadra and Priyanka Gandhi, a Congress general secretary, have not been named as accused in the charge sheet, this is the first time that Gandhi has been named in a charge

sheet filed before a court. A special Prevention of Monev Laundering Act (PMLA) court in Delhi took cognisance of this charge sheet on December 22 and listed the matter for next hearing on January 29, 2024.

Bhandari fled to the UK in 2016 and the British government approved his extradition to India in January this year acting on a legal request made by the ED and the Central Bureau of Investigation (CBI).

The two federal agencies are probing charges of money laundering and tax evasion against the alleged middleman for holding alleged undisclosed assets abroad. The ED stated in the charge sheet that it came across the land purchase and sale transactions of the Vadras after it registered a Foreign Exchange Management Act (FEMA) case against 67-year-old Thampi in 2015. A 'long and thick relationship' existed between Robert Vadra and Thampi, the

agency said. Robert Vadra has been questioned by the agency in this case in the past and he had denied any wrongdoing.

"It is imperative to mention that Robert Vadra also purchased three pieces of land measuring 334 kanals (40.08 acres) in Amirpur from H L Pahwa from 2005-2006 and sold the same land to H L Pahwa in December 2010," it said in the charge sheet.

"Further, Privanka Gandhi Vadra, wife of Robert Vadra, also purchased agricultural land measuring 40 kanal (05 acres) in village Amirpur, district Faridabad, Haryana, from H L Pahwa in April 2006 and sold the same land to H L Pahwa in February 2010," the ED stated.

It said "Pahwa was receiving cash out of the books for the purpose of acquisition of land". "It was also noticed that Robert Vadra did not pay the entire consideration to Pahwa. The investigation in this regard is still ongoing," the ED said. Thampi was arrested in this case in January 2020 and the ED in a recent press statement alleged that he was a 'close associate' of Robert Vadra. Thampi is at present out on bail.

The ED also stated in the charge sheet that Thampi, in a statement recorded before the agency in January 2020, said he purchased a Land Cruiser car from Robert Vadra 'more than 10 years ago' for which he made payments to the businessman through cheques from his NRE accounts in India.

It also said Thampi has not submitted any documents or details to explain a bank transaction of ₹ 10 lakh with Robert Vadra in 2007.

"Thus, from the above, it is quite evident that Robert Vadra has a close association with C C Thampi," it said.

In June 2019, Thampi told the ED that he knew Robert Vadra for more than 10 years and the businessman was "initially introduced" to him by Madhavan, PA to Sonia Gandhi

Delhi HC refuses Neelam Azad urgent hearing on police remand

NEW DELHI, Dec 28: The Delhi High Court on Thursday refused urgent listing of a plea by Neelam Azad, a woman arrested in the December 13 Parliament security breach case, who alleged that her police remand was illegal as she was not allowed to consult a legal practitioner of her choice to defend her during the trial court proceedings.

The matter was mentioned for urgent hearing by her lawyer before a vacation bench of Justices Neena Bansal Krishna and Shalinder Kaur, which said there was no urgency in the matter.

"In any case it will be taken up on 3rd (January). There is no urgency," the bench said.

Azad's lawyer said she has challenged her remand order and on January 5, her police custody was getting over. Turning down the request, the court responded there was still "enough time" for the hearing to take place before the remand came to an end. In her petition seeking a writ of habeas corpus directing her production be-

filed through lawyer Suresh Kumar, has alleged. "The remand order dated 21.12.2023 is illegal and violative of Article 22(1) of the Constitution of India which mandates the accused person to be defended by a legal practitioner of his choice whereas in the present case the petitioner's advocate wasn't permitted to take instructions and defend the petitioner prior to the disposal of the remand application," the plea added. The petition also said Azad was

produced before the trial court on December 14 "after a period of 29 hours from the time of arrest."

Article 22(2) of the Constitution says that every person who is arrested and detained in custody shall be produced before the nearest magistrate within a period of 24 hours of arrest excluding the time necessary for the journey from the place of arrest to the court of the magistrate and no such person shall be detained in custody beyond the said period without the authority of a magistrate. Milestones of social justice ministry in 2023

NEW DELHI, Dec 28: From the submission of the Rohini commission report constituted to examine the sub-categorisation of OBCs to 714 districts declaring themselves manual scavenging-free, this year the Union social justice and empowerment ministry touched several milestones.

All districts have been requested, either to declare themselves free from manual scavenging or upload the data of insanitary toilets and manual scavengers associated with it on "Swachhta Abhiyan" mobile app.

As of November, 714 districts out of 766 districts in the country have declared themselves as manual scavenging-free. Amid the caste census debate, this year the Rohini Commission, constituted to examine the sub-categorisation of Other Backward Classes (OBCs), submitted its report to President Droupadi Murmu in July. However, its submission has not been made public and is presently under scrutiny.

The findings of the Rohini Commission are set to play a crucial role in the debate over the caste census. Unique Disability ID (UDID), launched in 2021, saw the issuance of 1 crore cards this year.

In 2023, all 35 international airports and 55 out of 69 domestic airports provided accessibility features for differently-abled like ramps, accessible toilets, help desks and lifts with Braille and auditory information systems. Further, all international/customs airports are reported to have been provided with aerobridges. As many as 709 railway stations have been made 'fully accessible', and 4,068 railway stations have been made 'partially accessible', according to official data. Seven states/UTs have informed that 2,839 state government buildings have been selected to be made accessible. In the Central government, CPWD reported completion of retrofitting all 1,100 central government buildings targeted under the 'Accessible India Campaign'.

The Chief Commissioner for Persons with Disabilities delivered two landmark judgments, mandating government offices to relocate if inaccessible and addressing insensitivity towards disabilities at airports.

In another move, action was taken against MTNL for neglecting disability status updates, requiring officers to undergo sensitisation at a disability services trust. The Chief Commissioner called for action on accessibility at the Jawaharlal Nehru University campus, invoking relevant disability acts.

Additionally, a ban on the sale of hearing aids by ecommerce platforms was ordered to protect individuals with hearing impairments.

The disability affairs department announced a 1 per cent interest rate rebate to 'divyangjan' borrowers under the National Scheduled Castes Finance and Development Corporation loan for timely repayment.

"This initiative aims to alleviate the financial burden on divyang individuals seeking financial assistance, while also promoting responsible repayment practices." (PTI)

MUMBAI, Dec 28: For five consecutive policy reviews in 2023, the Reserve Bank of India (RBI) chose to hold rates, citing inflation threat. And when the prices did cool off a bit, it reminded all about the target to get the headline consumer price inflation at 4 per cent and the risks from food inflation.

Heading into the New Year, all eyes are on when RBI will cut the rates, especially after one of the Monetary Policy Committee (MPC) members stressed on the need for such an action in the face of the US Federal Reserve's guidance for easing rates. Also, some analysts point to the Consumer Price Inflation (CPI) falling below the 4 per cent mark in mid-2024 and then, there will be prospects of a rate cut.

RBI Governor Shaktikanta Das,

who is into the last year of his second three-year term at the helm of the central bank, has been steadfast in highlighting the need to get the inflation down to 4 per cent on a durable basis. CPI cooled off to a four-month low of 4.87 per cent in October but rose to 5.55 per cent in November. After announcing the December monetary policy review, Das said that "loosening in rates is not on the table at all" till the inflation demon is chained at or is under 4 per cent for a durable time. In December, he said the future is "very fickle", where any shock

can hit the economy. The policy stance has continued to be "withdrawal of accommodation" through the year and will be relooked only when inflation reaches the target zone for a

"durable time", Das had said.



Episodic rise in inflation like the one fuelled by sky-high tomato and onions prices in the latter half of the year has made the central bank's warnings on potential troubles from food inflation feel more real. The Monetary Policy Com-

Apart from the entrenched entities, the challenge from new age entities indulging in lending activities continued in 2023. Such activities are expected to grow bigger as newer attempts continue at disrupting the game, according to experts.

The central bank's policies over the years have come in for a lot of praise as the government propped the digital payments architecture through the year, and also made it into a key theme during the G20 presidency.

In the New Year, the RBI will also focus on promoting the Central Bank Digital Currency (CBDC) so that it reaches a critical mass in terms of volume. (PTI)

Startup story set for better script in New Year after unicorns, funds fall

NEW DELHI, Dec 28: Funding winter and corporate governance woes separated the men from the boys in the country's startup space in 2023 that saw funds into the segment tapering to just around USD 8 billion.

All said, investors are hopeful of strong growth of the maturing startup ecosystem in the New Year. Edtech and health tech segments that grew exponentially during the pandemic plunged into an abyss of financial uncertainties, with sev-

eral firms shuttering their business, and valuation of prominent players like BYJU'S and PharmEasy plummeting 85-90 per cent. Indian startups are estimated to

have laid off over 15,000 employees in 2023. Startups with sustainable business models as well as the well-capitalised ones are expected to weather the current turmoil. And the horizon in 2024 is expected to be "exciting" as well as "challenging". Venture capital firm Lightspeed, which has invested in firms like BYJU'S, Magicpin and OYO, said a high cycle or a low cycle of two years does not really impact the outcome of companies that get built over a period of 8-10 years.

"As such, we think of the current phase as a part of the growing up of our ecosystem. Yes, there will be consolidation, valuation correction and even some mortality of companies but all in all, the end result will still be progress," Lightspeed's Partner Rahul Taneja said.

Reflecting a challenging environment for the startup ecosystem, which has churned out numerous unicorns, the total funding tumbled this year compared to a staggering USD 35 billion it attracted two years ago.

Also, corporate governance issues came to the fore at various promising unicorns making the investors' community jittery. BharatPe, GoMechanic, 4B and BYJU'S all had to grapple with multiple red flags in terms of corporate governance ways as well as funding

157 cases of Covid sub-variant JN.1 detected

NEW DELHI, Dec 28: A total of 157 cases of Covid-19 sub-variant JN.1 have been detected in the country, with Kerala reporting the highest number of 78, followed by Gujarat at 34, according to the IN-SACOG's data updated on Thursday. Several states have been reporting an uptick in the number of Covid cases over the last few weeks and nine states and Union territories have so far detected the presence of the JN.1 sub-variant of the virus. These states areKerala (78), Gujarat (34), Goa (18), Karnataka (eight), Maharashtra (seven), Rajasthan (five), Tamil Nadu (four), Telangana (two) and Delhi (one), according to the Indian SARS-CoV-2 Genomics Consortium (INSACOG). The INSACOG's data showed 141 Covid cases recorded in the country in December had the presence of JN.1, while 16 such cases were detected in November. The World Health Organisation (WHO) has classified JN.1 as a separate "variant of interest" given its rapidly-increasing spread, but said it poses a "low" global public health risk. The JN.1 sub-variant of the coronavirus was previously classified as a variant of interest (VOI) as part of the BA.2.86 sub-lineages, the parent lineage that is classified as a VOI, the world body said. (PTI)

aging Partner Apoorva Sharma said all lenders in general have been extremely cautious and the primary focus has been to ensure healthy asset quality.

"The average ticket size is already in the range of say ₹ 20 crore now, which in 2021 was close to ₹ 45-50 crore. If you look at venture capital investments, it was about USD 35 billion in 2021, about USD 25 billion in 2022 and in 2023, it will be roughly about USD 8 billion. It is declining every year," she said. Further, Sharma said several unicorns have not

gone for public valuation and those which are raising funds are doing so either by way of flat valuation or promising discounts in the next round of fund raise.

According to venture capitalist firm Fundamentum Partnership, the number of unicorns dropped to 72 as of November this year from 110 in 2022. "As of November 2023, India had 72 unicorns in comparison to 110 unicorns last year," Fundamentum Partnership's Principal Prateek Jain said.

Consulting firm HexGn's CEO Jaspreet Sethi estimates that health and medtech segments saw an 8 per cent valuation decline while in the case of e-tail, market places and portals, the fall is 9 per cent. The fintech sector saw a marginal decline of 2 per cent in 2023, he

added. IvyCap Ventures' Founder and Managing Partner Vikram Gupta said that approximately 30 unicorns saw changes in their status between 2021-2023. "When we look at specific sec-

tors, the multiples in the consumer/ D2C sectors might have dropped from 5-7 times in 2021 (price to revenue) to around 2-3 times in 2022. Now, they may be showing an increase of 2-4 times.

"Similarly, in SaaS, these multiples may have dropped from 10-30 times in 2021 to 3-5 times in 2022, and may currently be coming to 5-7 times in 2023," Gupta said.

On the other hand, startups with sustainable business models and those innovating around artificial intelligence, Software-as-a-Service

(SaaS), deep tech, fintech, electric vehicles and casual gaming, are anticipated to progress well. Softbank Group, which has invested USD 15 billion in India in

the last few years, sees emergence of global technology companies out of India and maturity in the funding ecosystem with many venture capital players getting IPO (Initial Public Offering) exits.

"Our India portfolio has done quite well in terms of exits as well as operating performance of companies. Even in 2023, we saw companies like Lenskart, Firstery, Meesho and Ola Electric raise cap-

Four killed, Six injured in road crashes due to fog in UP

LUCKNOW/UNNAO/MUZAFFARNAGAR, Dec dense fog with visibility dropping to 50 metres in the 28: At least four people were killed and six injured in separate road crashes in Uttar Pradesh due to reduced visibility caused by dense fog, police said on Thursday. Chief minister Yogi Adityanath had to cancel his trip to Ayodhya on Thursday due to poor visibility because of dense fog, press secretary in the CM's office Mrityunjay Kumar said.

Adityanath had to fly to the temple town ahead of Prime Minister Narendra Modi's visit on December 30 to inaugurate a new airport and a new railway building. Sources said he might travel to Ayodhya by road either this evening or Friday morning

According to the state meteorological department officials, dense fog was reported from across Uttar Pradesh in the early hours of Thursday, with visibility plunging down to less than 40 metres in some areas. The weather department officials have forecast state for the next two days during the morning hours. In Unnao, two men were killed when their motorcycle collided with a stationary truck here in Uttar Pradesh, police said on Thursday, suspecting that the accident took place due to dense fog.

"Govind Pathak (31) and Vivekanand (21) were travelling on a motorcycle and it collided with a truck on Wednesday night," Sehramau Station House Officer (SHO) Kamal Dubey said.

"It appears that the duo failed to spot the truck due to dense fog. While Pathak was killed on the spot, Vivekanand succumbed to injuries at a hospital a few hours later," he said.

Early Thursday, police constable Dinesh Yadav, who was driving a police jeep, was injured when his vehicle collided with a truck in an area under the Purva Police Station. (PTI)

the ministry statement said. The court verdict was welcomed by political parties, former diplomats and security experts, among others. "The Indian National Congress shares its immediate relief along with the entire nation that the Court of Appeals in Qatar has decided not to go ahead with the death penalty... While fuller details are awaited we express the hope that even the jail sentence that has replaced the death penalty will be set aside and the officers will be set free," Congress' Jairam Ramesh said on X. BJP general secretary Tarun Chugh said the relief for the former Navy personnel was a "victory of the diplomatic efforts" under the leadership of Prime Minister Modi.

"This news has made it clear that the entire world recognises the strength of India's foreign policy under the leadership of Prime Minister Modi," Chugh said. Former diplomat Anil Trigunayat also welcomed the verdict and hoped that the veterans would be exonerated of the charges. "It is good that the court has reduced their sentences. I sincerely hope that they will not only be exonerated but also be returned home at the earliest," Trigunayat said. Former Navy spokesperson D K Sharma, said,"This great news, but this is the first step, at least the capital punishment has been reduced. The final aim is to bring them home. That is what we are hoping and praying for." "Every provision will be made use of. Our relations with that country are such that we can see which provision can be invoked and how our people can be brought back," Sharma said in response to a question on an agreement on sentenced persons between India and Qatar.

Sharma said he was confident that the government and every authority involved in the matter would take legal recourse to get the veterans back home. "It is too premature to talk about straight from capital punishment to release. It is probably a sequential thing that may happen and probably take more time," Sharma said. In 2015, India and Qatar signed an agreement that allows persons sentenced to jail terms to complete their punishment in their own country.

According to the agreement, a sentenced person may be transferred if the death penalty has not been imposed on the sentenced person; the judgment is final; no criminal proceedings are pending against the sentenced person in the transferring state in which his presence is required. The agreement also applies to persons facing life imprisonment.

The accord is expected to be signed in the presence of Union home minister Amit Shah and chief minister Himanta Biswa Sarma. The ULFA was formed in 1979 at the historic Rang Ghar, the Ahom era ampitheatre, in Sivasagar and was banned in 1990 when it started an armed conflict against the state.

The outfit split into two factions in 2011 when the pro-talks faction led by Rajkhowa decided to return to the state from abroad and participate in peace talks while the other group, ULFA (Independent), led by its commander Paresh Barua, was opposed to negotiations unless the 'sovereignty' clause was included.

The chief minister on assuming office in 2021 had sent out an olive branch to the ULFA(I) for talks with the latter announcing a ceasefire of operations but recently it carried out three blasts in Tinsukia, Sivasagar and Jorhat which they claimed was in response to the 'arrogant' attitude of director general of police GP Singh. actor Sharmila Tagore has revealed that she was battling with cancer when filmmaker Karan Johar approached her to play a key role in his movie "Rocky Aur Rani Kii Prem Kahaani".

The cinema icon and her son, actor Saif Ali Khan, appeared in the latest episode of Johar's celebrity chat show "Koffee with Karan".

In the episode, which dropped on Disney+ Hotstar on Thursday. Johar said he wanted Tagore to play the role of Alia Bhatt's grandmother in the movie, which was released in August.

"I had offered Sharmila ji the part played by Shabana (Azmi) ji in 'Rocky Aur Rani Kii Prem Kahaani'. She was my very first choice. Due to health reasons at that time, she couldn't say yes. but it is a regret I have," the filmmaker said.

Tagore, 79, said she didn't want to take a risk during the pandemic as she was not vaccinated.

"This is at the height of Covid.

Covid at that time. They didn't know about the vaccine, we were not vaccinated. You know, (it was) after my cancer. So, they didn't want me to take that risk," she said.

Tagore, however, did not reveal the details of her battle with can-

The veteran, known for her roles in Satyajit Ray's "The World of Apu", "Devi" and Hindi movie such as "Kashmir Ki Kali", "Aradhana", "Amar Prem" and "Chupke Chupke", said not doing Johar's movie is a regret and she hopes to collaborate with the filmmaker in future.

"It will be a regret, and it is something I hope that we can make up for and work together,' Tagore said.

Earlier this year, Tagore made a return to acting with family drama "Gulmohar", co-starring Manoj Bajpayee. The film, directed by Rahul V Chittella, was released on streaming service Disney+ Hotstar. (PTI)

LOS ANGELES, Dec 28: Tom Cruise has a new fan in "Ted Lasso" star Hannah Waddingham, who says the Hollywood superstar is one of the most "inspiring human beings" she met in her life. The British actor recently worked with Cruise on the latest chapter of his "Mission: Impossible" series.

Appearing on the Christmas episode of UK channel ITV's "James Martin's Saturday Morning", Waddingham said she spent five days with Cruise filming the action tentpole on the USS George HW Bush fighter carrier.

Waddingham joined the cast for the eighth installment, which was originally designed as the second part to "Mission: Impossible - Dead Reckoning Part One", in March this year. The details of her character have been kept under wraps.

"Mission: Impossible 8" is scheduled to be released in US theatres on May 23, 2025.

2023: When Hindi movies made a spectacular theatrical comeback after a year of misfires

NEW DELHI, Dec 28: The year that was marked the triumphant return of the alpha male to the big screen and ageing star Shah Rukh Khan fronting Bollywood's march back to the box office after "Pathaan", "Jawan" and "Dunki" with Sunny Deol and Karan Johar walking alongside, reviving their careers and the fortunes of the Hindi film industry

The year, the first after the pandemic, began with "Pathaan" and finishes with "Dunki", the two very different Shah Rukh films bookending the success of Sunny Deol starrer "Gadar 2", Johar's "Rocky Aur Rani Kii Prem Kahani" and the hugely controversial "Animal" that brought back Bobby Deol into the limelight

But 2023 was not just about macho heroes fighting their way to victory in high octane, high tech thrillers edged with

VFX and testosterone. Bollywood's return to its theatrical glory days was also about sequels and agenda-driven films.

Last year, around this time, Hindi cinema was struggling to make a mark in theatres, while films from the South captured the hearts of audiences across India, the pinnacle being "RRR" song "Naatu Naatu" winning at the Oscars. Major Bollywood titles that failed to work at the ticket window in 2022 included "Samrat Prithviraj", "Raksha Bandhan", "Shamshera" and "Laal Singh Chaddha".

The revival kickstarted with Shah Rukh's spy act in the January release "Pathaan" that brought him back to movies after a gap of four years. The Siddharth Anand-directed film became one of the biggest hits of the year with its earnings of Rs 1,000 crore worldwide, leading to many think-pieces and discussions for its palatable patriotism in a hero who was found in a theatre and named 'Pathaan' by a group of Afghan women he saves during a mission. Shah Rukh followed it up with another hit in September's "Jawan", which once again saw the actor live up to the hype surrounding his return. Directed by Atlee, the film went on to mint more money than "Pathaan" by earning over Rs 1.100 crore.

He seems to have hit a hat-trick with "Dunki", which has done reasonably well at the box office despite mixed reviews. Though its earnings don't match up to the earlier two films, the Rajkumar Hirani-directorial has grossed over Rs 250 crore globally since its December 21 release

"Gadar 2" was the surprise package of the year. It made over Rs 500 crore and marked one of the most spectacular

returns to forms for Sunny in his 40th year in films.

In fact, the year belonged to the Deol family. It saw papa Dharmendra playing a hardcore romantic in "Rocky Aur Rani Kii Prem Kahani" and younger brother Bobby walk away with praise for his brief but impactful role in "Animal".

Besides, Sunny's son Rajveer also made his acting debut with "Dono", which did not do the numbers but got its lead actor noticed.

With the film, Johar, whose last fullfledged feature was 2016's "Ae Dil Hai Mushkil", reminded his fans why he continues to be a filmmaker who knows how to tug at the heartstrings through his larger-than-life cinema. The family entertainer, starring Ran-

veer Singh and Alia Bhatt, is Johar's most realised film, delivering both laughs and lessons on equality and re-

spect in relationships while overturning stereotypes that have long been Hindi movie tropes. He has acknowledged in interviews that he tried to correct past mistakes in his own cinema through the film about a rich Punjabi brat and a Bengali journalist. While there was a "Rocky Aur Rani..." giving viewers a progressive vision, the year ended with Sandeep Reddy Vanga's "Animal", starring Ranbir Kapoor, in one of the most divisive films of 2023.

Just like Vanga's "Kabir Singh", "Animal" too courted controversy over its projection of masculinity, violence and its promotion of the toxic, overtly macho hero. The film, however, is one of the biggest Hindi blockbusters of the year by earning over Rs 800 crore. Before "Animal", Ranbir had a solid hit in "Tu Jhoothi Main Makkaar", which also raised eyebrows for its depiction of gender dynamics. There were smaller, quieter successes too.

Three years after "Shikara", Vidhu Vinod Chopra returned to the big screen as a director with "12th Fail", a lowbudget film whose box office success (over Rs 60 crore) surprised many. With testosterone seemingly at an all-time high, cinegoers didn't quite warm up to female-led stories, except for Rani Mukerji's "Mrs Chatterjee Vs Norway". Kangana Ranaut-starrer "Tejas", Vidya Balan-starrer "Neeyat", "Akelli" featuring Nushrratt Bharuccha, Shilpa Shetty's "Sukhee" and "Dhak Dhak", starring Ratna Pathak Shah and Dia Mirza, didn't work.

It was also a year of sequels with "Gadar 2", "OMG 2", "Tiger 3", "Dream Girl 2" and "Fukrey 3" releasing and proving the worth of franchise cinema. (PTI)

Man City rallies for 3-1 win at Everton to get Premier League campaign back on track

LIVERPOOL, England, Dec **28:** Manchester City had to come from behind to beat Everton 3-1 on Wednesday and climb back into the Premier League's top four.

Just back from winning its first Club World Cup title in Saudi Arabia, City went behind to Jack Harrison's first-half goal but recovered after the break thanks to a well-taken strike by Phil Foden and a penalty by Julian Alvarez.

Bernardo Silva added the third when he pounced on a poor clearance by Jordan Pickford to curl home into an empty net in the 86th

It was only City's second win in seven league matches but lifted the defending champions above Tottenham into fourth place, five points behind leader Liverpool with a game in hand.

Second-place Arsenal can move six points clear of City by beating West Ham on Thursday.

City was without Erling Haaland again because of a foot injury and Pep Guardiola's side had a sluggish start as Everton took the lead in the 29th minute.

City midfielder Rodri was pressured into an uncharacteristic loss of possession on the edge of his own area, and Dwight McNeil teed up Harrison to sidefoot home from close range.

The former City winger almost scored a spectacular second with Ederson at full stretch to tip over

son Chelsea has not found any kind of consistency under Pochettino, who was forced to name the club's youngest-ever starting lineup for a Premier League game following a slew of injuries and suspensions.

The hosts started well, though as they largely dominated the first half and took the lead through Mykhailo Mudryk in the 13th minute. But they missed several chances to double their advantage before Michael Olise equalized just before the break.

Pochettino's team continued to control possession in the second

half but Nicolas Jackson missed their best chance to restore the lead in the 74th when the struggling striker lifted the ball wide after he was played clear

Man United set to enter a new **Ratcliffe era with spotlight on January** transfers and Ten Hag's future

MANCHESTER, ENGLAND, Dec 28: Fans of Manchester United know 2024 will be anything but boring as the club tries once again to end a period of on-field decline that has lasted 10 years for the record 20-time English league champions.

British billionaire Jim Ratcliffe agreed Sunday — Christmas Eve — to buy a minority stake in United. The owner of petrochemicals giant INEOS, and a number of sports teams, will also take charge of United's soccer operations.

The announcement of the deal, worth around \$1.6 billion, came more than a year after American owners the Glazers put United up for sale in November 2022. The deal requires Premier League approval.

Here's a look at the people involved and issues likely to be raised by the deal, including the future of United manager Erik ten Hag.

JIM RATCLIFFE

The 71-year-old Ratcliffe is one of the richest people in Britain and a boyhood United fan from Greater Manchester.

He already owns French club Nice and cycling team INEOS Grenadiers. He is a one-third shareholder of the Mercedes-AMG Petronas Formula One team and competes in the America's Cup with sailing team INEOS Britannia.

"We all want to see Manchester United back where we belong, at the very top of English, European and world football," Ratcliffe said.

TEN HAG

The Dutch manager has endured a troubled season, with his team losing 13 games in all competitions and being eliminated from the Champions League at the earliest possible stage.

He has faced reports of locker room un-

rest and speculation about his job, but there has been no suggestion from United that his position is under threat and he said this month that he believes he has the backing of the club's hierarchy.

Still, his relief was evident as United came back from 2-0 down against Aston Villa to win 3-2 in the Premier League on Tuesday.

Afterward, Ten Hag was positive about the arrival of Ratcliffe

SOCCER OPERATIONS

Ratcliffe will take charge of United's failing soccer department. How that will work in practice is one of the biggest questions.

After more than 20 years of success under former manager Alex Ferguson, United hasn't won the title since he retired in 2013. Ten Hag is the fifth permanent manager United has had in repeated attempts to turn its fortunes around.

INEOS's director of sport Dave Brailsford — who was at the Villa game — and CEO Jean-Claude Blanc will join the board of the soccer club.

Brailsford was credited for his role in the success of British cycling in recent years. Blanc has held prominent posi-

tions at Juventus and Paris Saint-Ger-

main.

As the deal is expected to take up to 10 weeks to go through, Ratcliffe will not be in place in time for the January transfer window. He will, however, be consulted on any major soccer decisions such as transfers and the future of Ten Hag.

Members of Ratcliffe's team have already visited United's training ground and discussed operations. It is likely they will have already been consulted on plans for January and possible signings.

It is not yet known how football director John Murtough's position will be affected by Ratcliffe's investment, but the club's recruitment operations will be part of the INEOS owner's remit under the new structure

DIVIDENDS

It has been agreed that no dividends will be taken for a period of three years, with investment in the team and infrastructure said to be the immediate priority.

Old Trafford is in need of modernization, while Ten Hag's squad still looks well short of rivals like Manchester City, Arsenal and Liverpool after suffering early elimination from the Champions League. FULL SALE

There is no obligation for the Glazers to sell any further shares to Ratcliffe. But Ratcliffe does have right of first refusal if any further shares are sold within a year of the deal being completed.

If the Glazers choose to sell the entire club to a third party after 18 months of the deal being completed, Ratcliffe would be forced to sell his shares subject to them being priced at a minimum of \$33 per share. (AP)

Elgar, Jansen take SA to 408; India struggle at 62 for 3 at tea



CENTURION. Dec 28: Rohit Sharma and Yashasvi Jaiswal got a couple of unplayable deliveries, while Shubman Gill played an irresponsible shot as India, staring at an innings defeat, stuttered to 62 for 3 at tea on the third day of the opening Test against South Africa here on Thursday.

South Africa, riding on Dean Elgar's superbly-crafted 185 and Marco Jansen's career-best 84, posted a healthy first-innings score of 408.

Trailing by 163 runs, India's lack of preparedness was evident as the top order could neither handle movement nor bounce as they still need 101 runs to avoid an embarrassing innings defeat.

Virat Kohli (18 batting) and Shreyas Iyer

(6 batting) are surviving dangerously with the deliveries flying all around. The sun is beating down, odd balls are keeping low and survival isn't an option against a quality Proteas attack.

Kagiso Rabada, just like he had got Virat Kohli in the first innings, bowled one in the off-middle corridor to Rohit Sharma (0). The skipper closed the face of his bat after the ball had moved away, only to see the off-stump pegged back.

Rohit had anticipated an inswing but it deviated away. Yashasvi Jaiswal (5) hasn't played on a

track offering such steep bounce. Nandre Burger got one to rear up from length and Jaiswal's technique of swaying away from the delivery didn't help matters, with the ball kissing the gloves and landing into the keeper's hands

Shubman Gill (26) knew that attack was the best form of defence. But when Jansen fired one into the blockhole from wide of the crease, Gill played all over when the situation demanded a bit more discretion.

Kohli hit some nice boundaries but it will be a miracle for India to change the course of the match.

Earlier veteran Elgar missed out on a well-deserved maiden double hundred but inflicted enough damage on India in company of young Jansen to potentially bat the visitors out of the opening Test.

Elgar, whose previous highest Test score

is 199, was inching towards his maiden double hundred before a faint tickle to a legside bouncer from Shardul Thakur brought an end to his innings.

But that didn't deter the lanky Jansen, not exactly known for his batting prowess, from negotiating a deflated Indian attack that looked out of sorts and bereft of ideas.

The Elgar-Jansen pair added 111 runs for the sixth wicket.

The Indian bowlers were even more disappointing on the third morning with Shardul Thakur (1/101 in 19 overs) and Prasidh Krishna (1/93 in 20 overs) spraying all over the place, only to be mercilessly punished by the former Proteas skipper Elgar and the lanky left-arm seamer Jansen. The pair drove, pulled, cut at will and nei-

ther the old ball nor the semi-new ball could bring about any change in fortune for the visiting team bowlers.

Jasprit Bumrah (4/69 in 26.4 overs) and Mohammed Siraj (2/91 in 24 overs) once again were unlucky as they repeatedly beat the bat of Elgar and Jansen but didn't have the rub of the green going their way.

Prasidh and Thakur were not only belowpar but also missed both line and length.

Prasidh was inducted into the squad to hit the deck and generate extra pace off the surface, but he missed the trick by consistently bowling length balls. Even someone like Gerald Coetzee dispatched him into the stands.

On a track that demanded bowlers to bend their backs, Thakur literally floated the deliveries, which were hit all around the park. When he started using the shortball tactic, Jansen hooked him for good as he didn't have enough pace to hurry the batter.

The only bowler who came out with his reputation intact was Ravichandran Ashwin, who for most part, came from an angular run-up but ended with figures of 1/41 in 18 overs.

But, even his effort wasn't enough as the Prasidh-Shardul duo, having already conceded nearly 200 runs (194 in 39 overs) cumulatively in less than 40 overs, have severely dented their team's chance of redemption. (PTI)

KUALA LUMPUR, Dec 28: Indian Super League side Odisha FC has been pitted against a yet to be determined ASEAN Zone champions in the Inter Zone semifinal of the ongoing AFC Cup during a draw ceremony here on Thursday.

Odisha FC had emerged victorious in the AFC Cup South Zone, having beaten Bashundhara Kings of Bangladesh in their final Group D encounter earlier this month.

Four teams -- Central Coast Mariners FC (Australia), Phnom Penh Crown FC (Cambodia), Macarthur FC (Australia) and Sabah FC (Malaysia) -- are vying for the ASEAN Zone champions honour.

The ASEAN Zone final will take place on February 22 and the winner will face Odisha FC in the Inter Zone semi-final, which will be a double-leg affair.

The opening leg will take place on March 6 or 7 at the home of the ASEAN Zone champions, followed by the return leg at the Kalinga Stadium in Bhubaneswar on March 13 or 14.

The winner of the Inter Zone semi-final will take on either FC Abdysh-Ata Kant (Kyrgyz Republic) or Futuro FC (Chinese Taipei), the other two semifinalists.

Govt didn't follow 'proper procedure' while suspending WFI, will challenge in court: Sanjay

NEW DELHI, Dec 28: Newly-elected talk to the government and if it (govern-WFI president Sanjay Singh on Thursday said that the sports ministry did not follow "proper procedure" while suspending the wrestling national body and will challenge the government's decision in a court. The sports ministry on Sunday sus-

pended the WFI, three days after its elections were held, for flouting its own constitution while taking certain decisions, including the announcement of U-15 and U-20 National Championships.

Sanjay, however, said that his "autonomous" and "democratically elected" body could not have been suspended by the government without hearing the WFI's side of the story.

"We have won the elections (of WFI) democratically. The returning officer was the retired chief justice of J&K High Court, there were observers from the IOA and UWW (United World Wrestling). There were 22 state units (three absent out of 25 state associations) taking part in the elections, 47 votes were polled out of which I got 40," Sanjay told PTI.

"After all these, if you say we are suspended, we are not going to accept it. A democratically-elected body was not given a chance to explain its position which is against the principle of natural justice which everybody is entitled to under the Constitution of India."

Asked what is the way forward for his body, he said, "WFI is an autonomous body and the government has not followed proper procedure. We are going to

ment) does not take back the suspension, we are taking legal opinion and going to court.

He said since the WFI is contesting the suspension, he does not accept the threemember ad-hoc committee formed by the Indian Olympic Association (IOA) on Wednesday to run the day-to-day affairs of the national sports body.

He said the visit by Congress leader Rahul Gandhi in an akhada in Haryana to meet Olympic medallist Bajrang Punia made it clear that the trio, who led the fivemonth-long protest accusing former WFI chief Brij Bhushan Sharan Singh of sexually harassing women grapplers, were playing politics.

"It is clear that they (Bajrang, Vinesh Phogat and Sakshi Malik) are being backed by the Congress, tool-kit gang and left parties. These three are playing on the lap of these political parties," said Sanjay, a close aide of Brij Bhushan.

"Please tell me any fourth wrestler who is opposing the WFI other than these three. These three don't want the junior wrestlers to progress, they want to take away the rights of junior wrestlers.

"Bajrang had gone (to the Hangzhou Asian Games) without taking part in the trials and he came back with 10-0 loss. They are not in wrestling, they are in politics. Please come forward if you are concerned about wrestling, the road is clear for you, but if you want to do politics, please do it in the open."



Sanjay also took a dig at Bajrang for leaving his Padma Shri on the road after he decided to return it to the government. "It may be a personal matter, but the country's emotions are associated in Khel Ratna, it's not for a single person, but be-

longs to the whole society. Padma Shri is not something which should be put on a road.'

After the election of Sanjay as WFI chief, Sakshi quit the sport while Bajrang decided to return his Padma Shri. Vinesh followed suit by returning her Khel Ratna and Arjuna Award.

Sanjay also claimed that he had written a letter to the United World Wrestling requesting lifting of the ban imposed on WFI, and he is hopeful of a favourable de-

cision from the international parent body. 'We have written to the UWW requesting to lift the ban imposed on the WFI, as the elections were held democratically. Office holidays are going on (in Europe) so may take some days."

He also claimed that the newly-elected office bearers did not violate any constitutional provision of the WFI while announcing dates and venue of the U-15 and U-20 National Championships in Gonda -- Brij Bhushan's Lok Sabha constituency -- after the December 21 elections.

"There was full quorum when we took the decision to hold the U-15 and U-20 Nationals. There was an AGM on the day of the elections, we went to a hotel (in Delhi) and took the decision.

"If the Nationals were not held this year, the future of the young wrestlers would have been spoilt, which it has happened now. They will become overage. Everybody agreed to the venue also.'

Asked why the newly-elected WFI secretary general Prem Chand Lochab was not involved in the decision making, he said, "We told the secretary general to go there (at the hotel) along with us but he did not come. I don't know what is his intention.

"We followed the WFI Constitution to the full. If we did something (wrong), the government should have asked for an answer from us instead of restraining us from our work. WFI is an autonomous body and we were elected in a democratic way under our (WFI) constitution." (PTI)
