Bill aimed at regulating legal profession tabled in Lok Sabha

NEW DELHI, Dec 4: A bill which aims to regulate the legal profession by a single act and seeks to target 'touts' was tabled in the Lok Sabha on Monday with Union law minister Arjun Ram Meghwal saying there should be no role of touts in the country's courts

"The legal profession is a noble profession. The law commission was given a mandate to bring judicial reforms as per new circumstances. There should be no role of touts in the court premises in the country. Hence, it was felt that in the amendment there should be provisions related to touts," Meghwal

Initiating the debate, Karti Chidambaram of the Congress said, injustice anywhere is a threat to justice and touts thrive because of the complexity in dealing with our legal system.

"Because of the asymmetry in our society in terms of education, access to people in authority and wealth, sometimes people do not know how to navigate the legal system. This is what is being exploited and some people step in as touts. Touts thrive because of the complexity in dealing with our legal system," the Sivaganga MP said.

"We largely welcome the amendment...however, I urge the government to focus on the big fish rather than targeting the touts in the small courts," he added. The Rajya Sabha had passed the

Advocates (Amendment) Bill, 2023, during the monsoon session.

The bill provides that every high court and district judge can frame and publish lists of touts (those who procure clients for legal practitioners in return for any payment).

According to the provisions, people named in the list of touts will be excluded from entering the court premises. Any violation of this provision will entail punishment with imprisonment of up to three months and a fine. (PTI)

NEW DELHI. Dec 4: A total of 28.522 FIRs of murder were registered in 2022 with an average of 78 killings every day or more than three every hour across India. This has gone down from 29,272 in 2021 and 29,193 in 2020, according to the latest National Crime Records Bureau (NCRB) data.

'Disputes' with 9,962 cases was the motive in highest number of murder cases in 2022 followed by 'personal vendetta or enmity' in 3,761 cases and 'gain' in 1,884 cases, said the data in the annual crime report of the NCRB, which functions under the Union ministry of home affairs.

The rate of murder per lakh population across the country stood at 2.1, while the charge sheeting in such cases was 81.5, according to the NCRB.

Uttar Pradesh saw the highest number of such FIRs at 3,491 in 2022 followed by Bihar (2,930), Maharashtra (2,295), Madhya Pradesh (1,978) and Rajasthan (1,834), with the top five states together accounting for 43.92 per cent of murder cases in the country, the data showed.

The top five states with the least number of murder cases in 2022 were Sikkim (9), Nagaland (21), Mizo-

ram (31), Goa (44), and Manipur (47), according to the NCRB, which is tasked with collection and analysis of crime data.

Among Union Territories, Delhi, the national capital, registered 509 cases of murder in 2022 followed by Jammu and Kashmir (99), Puducherry (30), Chandigarh (18), Dadra and Nagar Haveli and Daman and Diu (16), Andaman and Nicobar Islands (7), Ladakh (5) and Lakshadweep (Zero).

Across India in 2022, the murder rate was highest in Jharkhand (4), followed by Arunachal Pradesh (3.6), Chhattisgarh and Haryana (both 3.4), Assam and Odisha (both 3).

Uttar Pradesh (1.5), Bihar (2.3), Maharashtra (1.8), Madhya Pradesh (2.3) and Rajasthan (2.3) fared better in terms of crime per lakh population.

Of total murder victims, 8,125 were female and nine third-gender persons, with men constituting about 70 per cent of victims, according to the NCRB. In a note of caution about the annual report, the NCRB said the primary (CONTD. ON PAGE-9)

Rupee falls 3 paise to close at 83.36 against US dollar

MUMBAI, Dec 4: The rupee pared its initial gains and settled lower by 3 paise at 83.36 (provisional) against the US dollar on Monday amid a recovery in the greenback in overseas markets.

Forex traders said the rupee gained earlier in the day as domestic equity indices surged to record highs after the ruling BJP scored a spectacular win in three Hindi heartland states. Moreover, sustained foreign fund inflows also supported the local currency.

At the interbank foreign exchange market, the local unit opened at 83.28 and touched a low of 83.37 against the greenback. It finally settled at 83.36 (provisional) against the dollar, down by 3 paise from its previous close.

On Friday, the rupee settled at 83.33 against the American currency. "The Indian rupee eked out opening gains and headed lower following the weaker Chinese currency. The market ignored the positive political news and lower crude oil prices as traders worried about the central bank's two-way interventions," said Dilip Parmar, Research Analyst, HDFC Securities. Looking at the price actions, the rupee is facing resilience in crossing the 83.10 to 83.50 range,

"However, the seasonality patterns and expectations of year-end dollar inflows may support the rupee in limiting losses in case of back," Parmar said. According to traders markets now await for RBI Monetary policy on December 8. and non-farm payroll data from the US on the same day in the evening for further cues.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.06 per cent higher at 103.32. Brent crude futures, the global oil benchmark, fell 0.51 per cent to USD 78.48 per barrel. On the domestic equity market front, Sensex surged 1,383.93 points, or 2.25 per cent, to settle at 68,865.12 points. The Nifty advanced 418.90 points, or 2.07 per cent, to 20,686.80 points.

Foreign institutional investors were net buyers in the capital market on Friday as they purchased shares worth ₹ 1,589.61 crore, according to exchange data. Meanwhile, India's foreign exchange reserves increased USD 2.538 billion to USD 597.935 billion for the week ended November 24, the Reserve Bank said on Friday. In the previous reporting week, the overall reserves had jumped USD 5.077 billion to USD 595.397 billion. (PTI)

Avg monthly GST mop-up at ₹ 1.66 trn so far this fiscal: FM Sitharaman

NEW DELHI, Dec 4: The GST collection has been showing an upward trend on an annual basis since its rollout on July 1, 2017, and the average gross monthly mop-up in the current fiscal so far is ₹ 1.66 lakh crore, Finance Minister Nirmala Sitharaman said on Monday. In a written reply to a question in the Lok Sabha, she said the GST collection crossed ₹ 1.50 lakh crore mark in every month of the current fiscal and had touched a record high of ₹ 1.87 lakh crore in April 2023. "GST collection has been showing an upward trend on yearon-year basis since the implementation of GST w.e.f. 1st July, 2017... The average gross monthly GST collection in FY 2023-24 now stands at ₹ 1.66 lakh crore and is 11 per cent more than that in the same period in the previous financial year," Sitharaman said.

The average monthly Goods and Services Tax (GST) collection in 2022-23 was over ₹ 1.50 lakh crore, higher than ₹ 1.23 lakh crore in 2021-22. In 2020-21, the average monthly mop-up was ₹ 94,734 crore. In reply to a separate question, Minister of State for Finance Pankaj Chaudhary said the monthly average gross GST collection for 2021-22 and 2022-23 have shown 30 per cent and 22 per cent year-on-year

growth respectively.

"GST is paid on self-assessment basis and tax administration at Central and State level is empowered to take action against cases where GST is not paid and short paid. Detection of such cases and recovery of taxes not paid or short paid is a continuous process," Chaudhary said.

He said the government, on the recommendation of the GST Council, has been bringing several reforms in GST and these measures would improve the GST compliance and increase the GST collection.

These include structural changes like calibration of GST rates for correcting inverted duty structure and pruning of exemptions; measures for improving tax compliance such as mandating e-way bill, ITC matching, mandating e-invoice, deployment of artificial intelligence and machine-based analytics, aadhaar authentication for registration, calibrated action on non-filers, stop filers.

Also, system-based analytical tools and systemgenerated red flag reports are being shared with central as well as state tax authorities to take action against tax evaders. (PTI)

Stock markets surge over 2 pc to hit lifetime highs after state poll results

MUMBAI, Dec 4: Benchmark stock indices Sensex and Nifty soared more than 2 per cent to settle at record high levels on Monday, marking the fifth straight day of gains as the BJP's victory in assembly polls in three states boosted investor sentiment.

The 30-share BSE Sensex jumped 1,383.93 points, or 2.05 per cent, to close at a lifetime high of 68,865.12. The index touched an intra-day record peak of 68,918.22. The barometer logged its biggest single-day jump since May 20, 2022.

The total market capitalisation of BSE-listed companies surged by ₹ 5.81 lakh crore to ₹ 343.48 lakh

The broader Nifty also climbed 418.90 points, or 2.07 per cent, to hit its all-time closing high of 20,686.80. On the 50-stock benchmark Nifty, 44 closed with gains.

Analysts said BJP's clear majority in Madhya Pradesh, Rajasthan and Chhattisgarh state polls strengthened the positive sentiment built up last week following robust macroeconomic numbers and unabated foreign fund inflows.

Besides, crude oil prices hovering below USD 80 per barrel fuelled investors sentiment, they

Among the Sensex firms, ICICI Bank and SBI led the index with the maximum gains of 4.68 per cent and 3.99 per cent, respectively. Other major gainers were Larsen & Toubro, Kotak Mahindra Bank and HDFC Bank.

On the other hand, Wipro and Tata Motors defied the trend and traded in negative.

'The benchmark index hits its all-time high following the landslide victory of BJP in elections in three states. It spurred a rally with an anticipation that the country will witness a stable government post the general elections next year," Vinod Nair, Head of Research at Geojit Financial Services, said.

"All the sectors have broadly participated in the rally with an op-



timism that the FIIs will continue its value buying, indicating positive commentary on the global inflation data and stable domestic marcoeconomics," Nair said.

Rupak De, Senior Technical analyst at LKP Securities, said the Nifty "kicked off with a gap up, propelled by BJP's exceptional performance" in three state elec-

"Technically, the Nifty had already surged past the critical resistance level of 19850. Since then, there has been a significant shift in Put positions towards higher strike prices, foreseeing a robust upward rally in the near future. The overall sentiment appears highly bullish, until Nifty fall below 20400. On the higher end, the index might move towards 21,000," De said.

Ajit Mishra, SVP - Technical Research, Religare Broking Ltd said all sectors participated in the move wherein banking majors contributed the maximum to the

"The buoyancy in the banking pack is leading from the front now while others are playing a supportive role and we feel the same trend could continue in the coming days. Besides, cues are favorable from the global front too, further adding to traders' comfort," Mishra said.

Corporate bond market likely to double by 2030: Crisil

KOLKATA, Dec 4: The Indian corporate bond market is poised for rapid growth despite clocking a compound annual growth rate (CAGR) of nine per cent over the past five years.

Crisil Ratings expects the outstanding size of the market to more than double from around ₹ 43 lakh crore as of last fiscal to ₹ 100-120 lakh crore by fiscal year 2030, a statement said on Monday. "The growth will be driven by a con-

fluence of factors. Large capital expenditure (capex) in the infrastructure and corporate sectors, growing attractiveness of the infrastructure sector for bond investors, and strong retail credit growth are expected to boost bond supply, while the rising financialisation of household savings should drive demand. Regulatory interventions are also helpful," Crisil senior director, Somasekhar Ve-

Capex in the infrastructure and corporate sectors is anticipated to be propelled by decade-high capacity utilisation, healthy corporate balance sheets, and a favourable economic outlook, he said.

Crisil envisions a capex of around ₹ 110 lakh crore in these sectors between fiscals 2023 and 2027, approximately Ratings

1.7 times higher than that of the past five fiscals. The rating major expects this pace of capex to continue beyond fiscal . The corporate bond market is projected to finance about a sixth of the anticipated capex. Infrastructure assets are emerging as strong contenders for investment owing to their improving credit risk profile, promising recovery prospects, and long-term nature. Currently, infrastructure accounts for only about 15 per cent of the annual corporate bond issuance by volume, the note said.

However, structural improvements facilitated by a raft of policy measures are expected to make infrastructure bond issuances more attractive to patient-capital

investors, particularly insurers and pension funds, who constitute the key investor segment in the bond market.

Crisil estimates assets in the managed investment segment to double to around ₹ 315 lakh crore by fiscal 2027, and the trend is expected to continue well past fiscal 2027. These investments will be in both equity and debt and a good portion of it may flow to the corporate bond market. The agency stated that retail credit growth is expected to maintain its momentum, fueled by private consumption growth and the formalisation of lastmile credit flow. The bond market, being a crucial funding source for larger NBFCs and accounting for a third of the funding mix, will play a pivotal role in financing retail credit flow.

Managed investments are expected to continue to outpace bank deposits in terms of growth. Factors such as increased digitisation, rising investor sophistication in retirement planning, higher awareness and utilisation of insurance, investment objectives aimed at surpassing inflation, and a burgeoning middle-income population are contributing to the growth of managed invest-

Oil palm is sustainable and can aid small farm holders in NE: Solidaridad

GUWAHATI, Dec 4: Consuming around 13% of the total global oil palm production, India is the world's largest importer and 2nd largest consumer of Oil Palm amounting USD 10.17 bn in 2021-22 to the country's exchequer.

The Mega Oil Palm Plantation Drive earlier this month across the country was aimed to create awareness and increase area under Oil Palm cultivation so as to decrease the import expenditure in the coming years.

"Without touching any forest cover, around 9 lakh ha of potential area is available and suitable in the Northeast for oil palm plantation," said Dr Suresh Motwani, Veg Oil programme head – India, Solidari-

dad Network. "With a possibility of converting areas under Jhum cultivation or barren lands into oil palm plantations, it can aid reduce environmental impact while securing the livelihoods of indigenous communities, he further added. Solidaridad Network is involved in running sustainable oil palm programmes worldwide. With special initiatives surrounding small farm holders, the organisation has also played a critical role in developing India's own standards for sustainable palm oil – IPOS. IPOS would provide sustainability framework for effective implementation of aambitious Oil Palm Mission of Government of India namely National Mission on Edible Oil-Oil palm (NMEO-OP) to pro-

mote oil palm cultivation for making the country Atmanirbhar in edible oils.

Highlighting the benefits for small farm holders, a peculiar situation in the region, he said that 0.26 ha of land has a potential to produce 1T Palm Oil as compared to 2 ha of land needed to produce same amount of Soybean Oil. Hence with the plantations requiring significantly less land compared to other oilseed crops, having a remarkable capacity to yield up to 8 times more oil and also enabling intercropping it has a potential to translate into economic prosperity for smallholders. Furthermore, as per the studies conducted by The Indian Council of Agricultural Research (ICAR) – Indian Institute

of Oil Palm Research (IIOPR), oil palm plantations require less water compared to crops like rice, banana and sugarcane for its optimum production. Being an evergreen tree with spreading branches, it has a potential to protect soil erosion due to heavy rainfall and helps in conserving moisture due to evaporation. "Contrary to misconceptions, modern oil palm cultivation practices are not synonymous with monoculture. As many less water intensive intercrops like pepper, ginger, cocoa etc can be grown under partial shade condition in the existing plantations, it not only enhances the environmental resilience of the cultivation but also generates additional revenue streams for farmers," said Dr. Motwani.

Students enact play to promote coexistence with elephants in HEC-affected villages

GUWAHATI, Dec 4: Leveraging drama as a powerful medium for mass communication, the premier biodiversity conservation organisation in the region, Aaranyak, has used theatrical performances to encourage cooperation from villagers in facilitating coexistence with wild elephants in areas affected by human-elephant conflict (HEC).

Aaranyak's team enacted a play involving school students with the aim of educating villagers about the importance of coexistence with wild elephants. The play revolves around a conversation between a grandfather and his grandson, where the grandfather narrates how their village once lived in harmony with elephants. He describes how large herds of elephants coexisted peacefully

with villagers in the adjacent forest. However, he mourns the sudden developmental changes in the village that have negatively impacted both the lives of elephants and villagers. The portrayal of the village's history moves the young boy, instilling hope that people will one day make paths for the elephants to return to the jungles that were once their delightful abode.

To enact the play, Aaranyak's team conducted a four-day training for 25 students from the 9th standard of Paneri Higher Secondary School in Udalguri district, Assam. The first performance took place on November 28 in the school auditorium in the presence of students and teachers, many of whom come from high humanelephant conflict areas in the district. The play was scripted

conceptualized Aaranvak's senior conservation biologist Dr. Alolika Sinha and penned down by researcher Anushka Saikia. Other team members who played active roles in the successful event included Rabiya Daimary, Abhijit Saikia, Reshma Narzary, Mondeep Basumatari, Pradip Barman, and Bikash Tossa.

This theatrical initiative aims to sensitize locals about the increasing conflict with wild elephants, highlight the key reasons behind the conflict, and emphasize the need for coexistence with these gentle giants, which are crucial for biodiversity conservation. The drama is expected to be enacted in two more HEC conflict zones in Udalguri district to further raise awareness among the local communities.





BJP receives booster for 2024

The recent state poll results, particularly the resounding victories in the 'Hindi Heartland,' have propelled Prime Minister Narendra Modi and the BJP into a commanding position for the upcoming General Elections in 2024. Modi wasted no time in asserting the dominance of the BJP and emphasizing the impact of their welfare schemes. The Prime Minister, attributing the BJP's success to the "double-engine ki Sarkars," highlighted corruption as a key issue resonating with the electorate. Notably, the Congress's strategy of focusing on ousting Modi failed, with Rahul Gandhi's "Panauti" jibe seemingly ineffective. Modi's references to a "hat-trick" and the potential guarantee of another in 2024 underscored the BJP's confidence. The victories in Madhya Pradesh, Rajasthan, and Chhattisgarh provided an opportunity for Modi to counter Rahul Gandhi's narrative, labeling him as the "bad omen." While the Congress secured a victory in Telangana, the overall results served as a wake-up call for the opposition. Congress President Mallikarjun Kharge's call for an emergency INDI-Alliance meeting reflects the urgency felt within the party. However, the meeting may face challenges given the setbacks and the BJP's swift

Looking ahead, the BJP is expected to intensify its focus on the Hindu card, particularly after Rahul Gandhi affirmed the Congress's adherence to its ideology, including the Muslim card. Modi's emphasis on aggressive Hindu appeasement, notably with the grand opening of the Ayodhya Ram Mandir on January 24, aligns with the party's strategy for 2024. The BJP's success in Uttar Pradesh, Madhya Pradesh, and Chhattisgarh was attributed to the effective implementation of welfare schemes. Chief Ministers Shivraj Chouhan and Yogi Adityanath capitalized on initiatives like the "ladli behna" scheme and a medley of 'labarthi schemes.' Modi issued a warning to the opposition, urging them to refrain from ridiculing the BJP's welfare schemes. The dismissal of the Opposition's "Caste Census" demand and countering Rahul Gandhi's "jitni abaadi, utni hisedaari" OBC card will likely be key points for the BJP. With Modi presenting the BJP's narrative around "four castes" – "mahila, kisan, yuva, and garib" – as a foil to Rahul's "Caste Census," the Prime Minister has solidified his position as a definite winner for a third term. The transformation from a frontrunner to a winner is evident, while Rahul Gandhi faces a shift to an "also-ran" status.

As of now, there seems to be little standing in the way of Prime Minister Narendra Modi securing a third term, a scenario unimaginable just three months ago. The BJP's unexpected victories in Chhattisgarh, Rajasthan, and Madhya Pradesh have positioned Modi as a formidable force. Going forward, Modi is likely to employ strategic words to provoke Rahul Gandhi into 'Panauti' moments, serving as a guarantee that the BJP will fight the 2024 General Elections on Modi's name and face. In the aftermath of the state poll triumphs, the BJP's momentum remains formidable, prompting speculation about whether the party peaked too early. The victories in Madhya Pradesh, Rajasthan, and Chhattisgarh have energized the BJP rank and file, but the party must navigate the challenge of maintaining this momentum leading up to 2024. Meanwhile, the Congress, facing setbacks, must urgently reassess its strategy and rhetoric to mount a credible challenge. As the political landscape evolves, the BJP's emphasis on welfare schemes, Hindu appeasement, and Modi's leadership stands as a potent formula, leaving the opposition with a daunting task of regaining lost ground.

Examining the Constitutional validity of Section 6A in Assam's Citizenship Act



The Supreme Court announced on Monday (06th November 2023), that it will hear pleas challenging the constitutional validity of Section 6A of the Citizenship Act, which was inserted through an amendment in 1985 as part of the Assam Accord. The hearing, originally scheduled for Tuesday (07th November 2023), was deferred after the Solicitor General of India and senior counsels representing the petitioners' side requested an adjournment due to the last working week before Diwali. In response, the apex court fixed the matter for hearing on December 5, to be presided over by a five-judge Constitution bench consisting of Chief Justice DY Chandrachud and Justices AS Bopanna, MM Sundresh, JB Pardiwala, and Manoj

Background:

In 1985, the Rajiv Gandhi government signed an accord with Assam student leaders, addressing the prolonged agitation against illegal Bangladeshi immigrants in the state. This accord led to the amendment of Section 6 of the Citizenship Act. The amended Section 6A serves as a significant provision within the Assam Accord, establishing a unique cut-off date for the detection and deletion of "foreigners." Currently, the constitutional validity of Section 6A is under scrutiny, with a plea challenging the 1971 cut-off date and advocating for the use of the 1951 cut-off date in-

The Assam Accord's Clause 5 designates January 1, 1966, as the base cut-off date for identifying and removing "foreigners." However, the accord also allows for the regularization of individuals who arrived in Assam after that date but prior to March 24, 1971. Consequently, March 24, 1971, has become the cutoff date for entry into the state, thus categorizing those who came after that date as "illegal immigrants."

Assam's unique cut-off date: It is important to note that Assam is the only state in India that has such a specific cut-off date for citizenship. This uniqueness is attributed to the historical context and regional concerns regarding immigration from neighbouring Bangladesh. While the intention of the accord was to resolve the issue of illegal immigration and safeguard the rights of indigenous Assamese people, the constitutional validity of Section 6A has come

under question. **Challenging Section 6A:**

The current challenge to Section 6A questions the appropriateness of the 1971 cut-off date and suggests reverting to the 1951 cut-off date instead. The plea argues that a revised cut-off date would ensure a more comprehensive and accurate inclusion in the National Register of Citizens (NRC).

Evaluation of arguments:

Those in favour of the 1971 cut-off date contend that it aligns with the basic principle of the Assam Accord and takes into account the years of prolonged agitation against illegal immigrants. Supporters assert that reverting to the 1951 cut-off date would undermine the purpose and ethos of the accord, as it fails to account for the substantial influx of ilimmigrants during the intervening years.

On the other hand, those challenging Section 6A argue that the 1971 cut-off date is arbitrary and outdated. They suggest that a broader scope, including the 1951 cut-off date, would serve as a more accurate representation of the native population, as it predates the significant influx of immigrants from across the border.

The constitutional validity of Sec-

tion 6A in Assam's Citizenship Act is of utmost significance. The ongoing evaluation by the bench will determine whether the 1971 cut-off date remains valid or if the 1951 cut-off date ought to be reinstated. The decision will have far-reaching implications, shaping the future direction of Assam's immigration policies and the inclusion of individuals in the National Register of Citizens. As the nation awaits the verdict, it is crucial to balance the concerns of regional security, indigenous rights, and the principles of equality and inclusive citizenship. (The author can be reached

BJP's success in the Hindi belt through local factors

notable shifts, with the BJP secur-L ing convincing victories in the northern states of Rajasthan, Madhya Pradesh, and Chhattisgarh, while the Congress celebrates a significant win in Telangana, marking its first triumph since the state's inception a decade ago. The interpretation of these results varies: first, as a reaffirmation of the BJP's influence in the Hindi heartland; second, as a clear expression of anti-incumbency in the four states, despite the BJP's ascension following Jyotiraditya Scindia's defection in Madhya Pradesh; and third, as a looming disaster for the Congress, with implications for its standing in the INDIA formation leading up to the 2024 Lok Sabha elections. Among these perspectives, the second, highlighting anti-incumbency emerges as the most plausible interpretation.

The BJP finds itself in a peculiar position atop the victory stand, with internal challenges brewing in Rajasthan and Madhya Pradesh. Despite these party fissures, the triumph seems to temporarily conceal these issues. However, for Prime Minister Narendra Modi and Union Home Minister Amit Shah, this victory poses a trial, given the leadership challenges prevalent in the aforementioned states. Asserting that these electoral wins endorse Modi as the party and national leader becomes a tough proposition, as the stark reality unveils the absence of the Modi factor in all four states. The Assembly election outcomes are predominantly influenced by intricate local factors that defy easy enumeration or categorization.

The BJP's inclination to rejuvenate Modi's image using these results represents a valid political strategy. Over the past nine years, the luster of the Modi

image has worn thin, and despite the party and the leader clinging to the charisma of the leader concept, they are well aware of its diminishing impact. The enigma persists regarding the party's victory, and as long as they continue to triumph, there seems to be little urgency in delving into the intricacies of the situation.

These Assembly elections present an intriguing aspect wherein, despite the prominence of headline numbers indicating

seats won and lost, the underlying narrative shifts when examining the vote share. Contrary to the impression of complete obliteration suggested by

the majorities, the Opposition's resilience in these states emerges as a positive sign. In Madhya Pradesh, the BJP commands nearly 50 percent of the vote (48.50 percent precisely), contrasting with the Congress' 40.37 percent.

However, the margin of difference in vote share appears narrower than expected, given the BJP's double the number of seats compared to the Congress - 150plus to 71-plus. Likewise, in Rajasthan, though the victory margin is less pronounced than in Madhya Pradesh (with the BJP securing 110-plus seats to the Congress' 65-plus), the vote share difference is relatively modest: 42 percent-plus for the BJP and 39 percent-plus for the Congress. In Chhattisgarh, where the BJP leads with over half the seats in a 90-member House, and the Congress hovers at 35plus, the vote share gap is closer, with the BJP at 45.84 percent and the Congress at 41.82 percent. The evident disparity between seat numbers and vote share highlights a notable discrepancy that we must

nant parties in each state, with the role of the local leader vet to be fully unraveled. In Rajasthan and Chhattisgarh, the Congress established clear leadership with Ashok Gehlot and Bhupesh Baghel, respectively. However, in Madhya Pradesh, the absence of clarity persisted, as Shivraj Singh Chouhan and Kamal Nath held nominal leadership roles in their respective parties within the state. Notably, the

BJP entered the polls in Rajasthan and Chhattisgarh without a prominent local leader taking the forefront. Simultaneously, it

became evident that the

party's victory in these states was not solely attributed to Prime Minister Modi. This dynamic reveals that people vote in ways that disrupt even the most well-conceived plans of parties and their leaders. The enigmatic nature of the people's choices persists, defying attempts by politicians and pundits to pinpoint the reasons behind victories and losses. In many ways, this unpredictability is beneficial for democracy, as the electorate's unplanned and collective exercise of the vote consistently keeps everyone guessing, and perhaps, even on tenterhooks.

It is only natural that, buoyed by victories in three states, the BJP will transition into campaign mode with heightened enthusiasm and confidence. Leaders of the party, including Prime Minister Modi and Home Minister Amit Shah, have consistently displayed a penchant for boastfulness, whether in victory or defeat.

The recent triumphs in the three states are likely to amplify their sense of confidence. Meanwhile, the Congress is confronted with the challenging task of

strategizing how to reclaim its foothold in North India - a pivotal factor in the upcoming 2024 Lok Sabha elections. However, a closer look at the vote share reveals that the Congress is regaining substantial ground, offering a glimmer of hope and dispelling the need for despair. The party remains a formidable force in regions where the electoral battle is waged between the BJP and the Congress.

The BJP may desire to proclaim loudly that the victories constitute an endorsement of its Hindu-first program, attributing the success to the influence of the Ram Mandir in Ayodhya on public sentiments. However, the actual reasons behind these triumphs are more ordinary, albeit intricate. In the typical political playbook, details often take a backseat to the overarching importance of victory.

Once the triumph is secured, it becomes a canvas on which any narrative can be painted. With the BJP emerging victorious in the three Hindi-speaking states, it now has the liberty to ascribe the success to the Ram Mandir factor, even if it might not have played as significant a role as sug-

The outcomes of these Assembly elections should not be regarded as a direct indicator of the 2024 Lok Sabha elections. Even if the BJP emerges victorious seemingly likely based on current assessments - it would not necessarily attribute its success to the wins in these Assembly elections. Both the Congress and INDIA, the Opposition conglomerate, must approach the 2024 contest as an entirely new and distinct round, with the results of these Assembly elections serving as a separate chapter in the political narrative. Despite hiccups, Chinese President Xi Jinping's **OBOR** project making good progress

ndia's unreserved opposition to China's One Belt One Road (OBOR) initiative launched across four continents Lover ten years ago by President Xi Jinping with great fanfare was given vent to from time to time by powers that be, including prime minister Narendra Modi. More recently, India's external affairs ministry spokesperson Arindam Bagchi found an occasion to tear to shreds the decade ago minted Chinese policy to win over the global south by promising and also funding all kinds of infrastructure projects from roads to sea and river ports to new city development.

The provocation for Bagchi to do so in the strongest possible words till date was Maldives' then president elect (president since) Mohamed Muizzu praising the role of Beijing's flagship global infrastructure programme in the development of aid receiving countries. Incidentally, China too bears a grudge against India for not only being not a participant in OBOR but also being its one of the most strident critics all

The neighbour India, which is the world's fifth largest economy and clocking the highest rate of growth among all the countries, not an OBOR participant takes a whole lot of shine off the initiative. Beijing may not agree, but New Delhi's derision of the grandiosity of Chinese ambition is quite enervating for it. No wonder then, as Bagchi confirmed, unlike on past occasions, Beijing did not send an invitation to India to join the third Belt and Road forum that was held on 17th and 18th October. New Delhi is aware that verbal assault alone from time to time will not be enough to counter China's attempt to ingratiate itself with the global south.

But India needs the backing of developed countries, particularly the US to offer the global south something that will match the Chinese OBOR, which, however, has undergone radical transformation to become less and less ambitious Ahead of the recent G-20 summit in Delhi. India was engaged in rounds of discussions with the US to bring it on board concerning this country's ambitious plan to build a corridor to run through India, West Asia and Europe. Such a corridor requiring unprecedented investments in development of road, rail and ports will be an effective way of economic integration of countries in the three continents.

While presenting the colossal corridor plan, Modi said: "In its development journey, India has accorded the highest priority to this area." At the same time, he used the occasion where so many world leaders, including the Chinese Prime Minister Li Qiang were present to present OBOR as a way of casting the net of China's "debt trap diplomacy wide in a bid to establish its hegemony over especially resource rich or strategically important middle and lower income countries." The truth is China has already spent a trillion dollars to expand its influence in Asia, Africa and Latin America through its belt and road infrastructure programme. At the same time tens of billions dollars of loans have gone sour and many development projects have stalled.

Most of the countries that received loans from China to give shape to infrastructure projects have defaulted in servicing debts. Poor project implementation combined with slowing global economy, high interest rates and high inflation queered the pitch for them. Simultaneously, the slowing of the Chinese economy and Covid-19 battering continue to engage Beijing attention to exercise caution on project selection leading to virtual overhauling of the original OBOR narrative. In fact, as Beijing is pressuring countries to honour the debt servicing and repayment conditions, many African countries facing economic turmoil want China to revise loan terms

Nearly a decade ago China launched a mission to be loved and admired by the global south riding on OBOR initiative. But the enthusiasm with which the initiative was embraced in the beginning has started fading. Xi keeps on claiming that the initiative is on the right side of history and conforms to the centuries old spirit of the Silk Road. But the world did not fail to notice that only 21 heads of state and government were present at the third Belt and Road forum. The presence was much thinner than what was seen in the earlier two forums. Remember Italy is the only G-7 nation to have endorsed Xi's signature foreign policy initiative. This happened following Xi's significant investment of political capital to bring Rome into China's orbit.

Italy endorsing OBOR by signing a memorandum of understanding with Beijing could not have been to the liking of Washington and many European nations. (The MOU signed by Italy provides that an official decision as to whether to renew or cancel it must be taken by the end of 2023.) Italy's Prime Minister Giorgia Meloni has said on a number of occasions since coming to power that her country wants to exit OBOR. In fact, at the recent G-20 summit Meloni raised the OBOR quitting issue with the Chinese Premier at a bilateral meeting. It was heard in diplomatic grapevine that Li urged Meloni for a 'silent renewal' of MOU. But in no case she should go for an exit ahead of the OBOR third forum. Meloni heading a conservative coalition is working to evolve a China policy that is in alignment with that of the US and European

That there is no enthusiasm about Xi's attempt to bring the global south firmly under China's influence through OBOR in the EU became embarrassingly clear for Beijing that only the Hungarian prime minister Viktor Orban from the 27 member EU member countries attended the 3rd forum. This could not have been otherwise considering Orban's friendly disposition to Kremlin. Italy has seen how famously President Emmanuel Macron of France is doing business with China without having anything to do with Xi's flagship programme. Then why endorse OBOR to court the US displeasure, seems to be the reason driving Melon not to remain part of global infra development initiative of China. A good development for India.

But the challenge for New Delhi has since the launch of OBOR was to present a infrastructure development programme similar or near similar to Xi's ambition. The Chinese President has never missed an opportunity to underline the Silk Road spirit of traders carrying goods on the camel back or by boat and doing business and promoting economies of trade partners peacefully unlike the hegemonic designs of Western colonial powers. This has, however, not stopped New Delhi to see in OBOR designs of 'debt trap diplomacy.'

What no doubt has emboldened India to propose a corridor encompassing India, West Asia and Europe is Biden commitment: "Together with our partners, we are working to mobilise trillions (dollar) of investments needed to close infra gaps around the world." Besides economic and practising democracy considerations, there is also convergence of US and India interest in neutralizing Chinese belligerence in the Indo-Pacific region. All this has prompted Biden to support India's corridor programme. (IPA Service)

Counterintuitive Palestine politics: Hamas may be treading a path paved by PLO earlier

panish philosopher George Santayana didn't have Palestine in mind when he coined the phrase, 'history repeats itself. 'Yet, Santayana's maxim may apply to Hamas when comparing the group's political evolution to the 16vear-torturous road traversed by the Palestine Liberation Organization (PLO) from classification by Israel and its Western allies as a terrorist organization to establishing the Palestine Authority on Israeli-occupied Palestinian land.

To be sure, there is no guarantee that Hamas, despite its brutal October 7 attack on Israel and wanton slaughter of 1,200, mostly civilian Israelis, will emulate the PLO in eventually recognising Israel and abandoning the armed struggle. Moreover, Hamas' current notion of realpolitik falls far short of anything that would qualify it as an acceptable and credible party to the negotiation of a resolution of the Israeli-Palestin-

ian conflict. Even so, the parallels between the PLO and Hamas' political evolution are noteworthy. The PLO embarked on its road to recognition of Israel and abandonment of the armed struggle in 1974 with a first ever direct appeal to Israelis published as an advertisement in Yediot Ahranot, a leading Israeli newspaper, by Democratic Front for the Liberation of Palestine (DFLP) leader Nayef Hawatmeh

The PLO refused to address Is-

raelis directly prior to publication because that would acknowledge the Jewish state. The DFLP's pioneering advocacy of Palestinian engagement with Israel and recognition of the Jewish state as part of the PLO's endorsement of a two-state resolution of the Israeli-Palestinian conflict did not stop the group's primarily Gazabased paramilitary wing, the National Resistance Brigades, from participating in Hamas' October 7 attack. The Brigades said it had lost three fighters in combat with the Israeli military. It said it had engaged Israeli forces in the towns of Kfar Aza, Be'eri, and Kissufim. The October 7 attack claimed the lives of at least 130 Israeli civilians or ten per cent Be'eri's residents, including women, children, and infants. The publication of Hawatmeh's

appeal was negotiated by American activist and journalist Paul Jacobs as part of an initiative that would have its armed struggle. included talks hosted by Tunisian President Habib Bourguiba between the PLO and two prominent Israeli politicians, Arie Eliav, a member of parliament and former secretary general of the then governing Labour Party, and Yitzhak Ben-Aharon, the head of Histadrut, Israel's national trade union, that was closely aligned with Labour. The plan was scuttled months after the advertisement when DFLP operatives attacked a girls' school in Maalot. They took 115 people hostage and killed 31, including 25 schoolgirls. ily criticised for its outreach to Israelis. The attack overshadowed the significance of the PLO's first formal steps towards accepting a two-state

solution a month after the incident. The PLO's parliament, the Palestine National Council, meeting in Cairo, adopted a 10-point programme that called for "the establishment of the people's independent combatant national authority over every part of Palestinian territory that is liberated." The Council endorsed three years later the Palestinians' right to "establish their own independent national state over their national soil." For the first time, the PLO stressed "the importance of connecting and coordinating with the Jewish progressive and democratic forces inside and outside the occupied homeland."It took the PLO another decade to unambiguously recognise Israel and declare an end to

Similarly, Hamas adopted an updated charter in 2017 that differed significantly from its 1988 fundamental document but was as ambiguous and ambivalent as the PLO pronouncements in the 1970s. Hamas' original 1988 charter called for the killing of Jews based on a saying attributed to the Prophet Muhammad. Hamas dropped the call to kill Jews in its new charter. The 1988 charter also insisted on a Palestinian state in all of historic Palestine that would replace the State of Israel.

Significantly, Hamas adopted its first charter months before PLO leader Yasser Arafat recognised Israel. The revised charter still calls for Israel to be replaced by a Palestinian state in all of historic Palestine but allows for the creation of a Palestinian state alongside Israel as an interim step provided it does not involve recognition of the Jewish state. Instead, the charter advocates a longterm ceasefire that would de facto acknowledge Israel's existence.

Complicating Hamas' potential to follow the PLO's path is the group's rejection of an Israeli and US negotiating framework that demands recognition of Israel and abandonment of the armed struggle as a prerequisite rather than an outcome of negotiations that was adopted by Arafat. Hamas concluded from the failure of the PLO's approach and the 1993 Oslo accords to produce an independent Palestinian state alongside Israel that Palestinian concessions

upfront were counterproductive. The brutality of Hamas' October 7 attack ensures that any role for Hamas or a potential successor in future negotiations will have to adopt the Israeli-US framework. This reduces the likelihood that Hamas or its successor may follow in the PLO's footsteps. Even so, the jury is out on whether Hamas, or a possible successor, will retain spoiler capability.

Irrespective of whether Hamas adopts the PLO model, Palestinian moderation has proven to be a torturous process. It often adheres to the principle of two steps forward, one step backwards. To be sure, Hamas' decision to randomly kill or kidnap anyone, Jewish or non-Jewish, during the October 7 attack rather than only target Israeli military personnel and facilities is a huge step backwards that has reeked unimaginable Palestinian suffering, which is not to absolve Israel of responsibility for its conduct of the Gaza war.

The jury is out on who Palestinians will hold responsible for the Gaza carnage, Israel and/or Hamas. Even so, it is becoming increasingly clear that Israel is unlikely to wipe Hamas off the face of the earth. Even if Hamas is destroyed, its hardline philosophy will survive, probably embodied in a successor. More than 30 years after Arafat recognised Israel and abandoned the armed struggle and three decades after the conclusion of the Oslo accords it is evident that Palestinian moderation is a fragile process that needs nurturing. Israel's emphasis on the stick rather than the carrot coupled with the Palestine Authority and Hamas' failure to provide good governance and effective leadership created the environment for a nascent armed resistance on the West Bank, the October 7 Hamas attack, and the DFLP's participation in the assault. To be clear, nothing justifies the random killing of innocent civilians. Even so, more killings and greater repression of Palestinians is not a solution.

A pathway towards a solution lies in fewer Israeli sticks and more Israeli carrots. It lies in empowering Palestinians rather than undermining them. It resides in encouraging Palestinian moderation rather than stymieing it. (IPA Service)

In the age of artificial intelligence, a 1973 **Supreme Court ruling threatens privacy rights**

n an October evening in 1964, wo doctors and several policemen sat around a landline in a Mumbai suburb, intently listening to a conversation between two doctors and an officer of the coroner's court, which is responsible for the conduct of post-mortems for police investigations. Supervised by the police, the doctors were negotiating the mechanics of a pay-off to the coroner court officer to tweak a postmortem report and escape liability for medical negli-

Recording the conversation through a large magnetic tape recorder attached to the doctors' phone was Assistant Commissioner Sawant. His hope was that the recording would help secure the conviction of the coroner court officer for corrup-

Little did Sawant know that his recording of a phone call would set a judicial precedent that would come to haunt India's post-colonial criminal jurisprudence, incentivising an unbridled invasion of the privacy of Indians for decades to come.

Sawant's phone conversation recording was challenged in the Supreme Court in the 1973 case of RM Malkani vs State of Maharashtra as illegal phone tapping and consequently liable to be excluded from evidence. The defence argued that in attaching the tape recorder to a phone without proper authorisation, the police had violated the Telegraph Act, which prohibits tampering with telecom infrastructure for intercepting communications.

As was the case in jurisdictions like the United States at the time - the only prominent democracy in 1973 where illegally obtained evidence is inadmissible – the accused sought to exclude the illegally recorded phone conversation from being used against them in court. It may seem odd to suggest that the court should refuse to consider relevant evidence simply because it had been obtained illegally. The person committing the illegality could be separately punished, but once the evidence was available, courts should be able to review it.

However, the exclusion is critical to a fair trial. In any criminal trial, an accused is at a significant disadvantage compared to the State, and likely in the physical custody of the police. Creating a perverse incentive for the State to commit crimes to extract evidence in such cases increases the probability of using illegal and despicable means, such as confessions coerced through torture.

But in the case of RM Malkani's case, Justice AN Ray went against conventional judicial wisdom, and, re-



lying on an 1861 British ruling, held "it matters not how you get it; if you steal it even, it would be admissible in evidence". What Ray did not acknowledge was the contrary position in the United States and that even the British had since modified their position, only permitting a narrow set of circumstances where illegally obtained evidence could be used against an accused.

In the US, for instance, the Fourth Amendment to the American Constitution precludes admission of evidence obtained from an unauthorised search or seizure.

But Ray's ruling has since made its mark in several cases - consider the numerous allegations of police misconduct in high-profile cases ranging from the arrest and death sentencing of Afzal Guru in the 2010 Parliament terror attack to the more recent cases involving Opposition politicians and Central agencies, like the Enforcement Directorate.

In December last year, for instance, the Jammu and Kashmir High Court upheld the rationale of the RM Malkani ruling while adjudicating on the preventive detention orders issued during the abrogation of the former state's special status under Article 370 of the Constitution in August 2019.

What is more concerning now is how this ruling will play out as new surveillance technologies are de-

Smartphones, to start with, are password protected but there have been frequent incidents of police demanding passcodes and access to phones, including during routine stops on the street - like the Hyderabad police in September.

While the legal position on this matter is not settled, there is a strong argument that the practice of law enforcement seeking passwords or biometric information - face ID or fingerprints – to access smartphone data of the accused violates the right against self-incrimination and the right to privacy. This practice has continued unabated: when the police and officials of central agencies raided the homes of NewsClick journalists on October 3, they also seized devices. including the phones, of some em-

This is because even if the privacy

protections precluding access to a person's smartphone and personal computers were enforced by a court or guaranteed by legislation, the ruling in the RM Malkani case would permit the use of any evidence gathered from such an unlawful search and seizure. An accused in such a case will not be protected from any adverse material found on their phone from being used against them. The prospect of the police officer being charged with a separate offence subsequently does not effectively deter such actions since enforcement in these kinds of cases has been fairly limited.

Crucially, emerging artificial intelligence-based surveillance technologies risk worsening the existing situation. Chief among these is realtime biometric tracking. Developments in artificial intelligence can leverage the current infrastructure of face-detection cameras enabling realtime identification tracking of thousands of individuals simultaneously.

Such infrastructure is coming up fast in major cities across the world. While today, the technology can be used to identify individuals but the process is time-consuming and requires sifting through large volumes of data. In most cases therefore, identification and tracking of only specific individuals can be undertaken and real-time tracking is difficult to accomplish. Though not ideal from a privacy standpoint, this constraint places natural guardrails against misuse, such as the need to enrol relatively large number of people in the analytics process and the time taken for completing the analysis.

Real-time biometric identification systems will enable round-the-clock tracking of thousands of individuals simultaneously. Such technologies will invariably be deployed to track and gag dissidents, journalists and Opposition politicians. With a precise map of someone's life, it will not be hard to selectively use circumstantial information and people's imperfect lifestyles to malign reputations.

The deployment of such systems will be sold to the public as a panacea for national security with "safeguards" designed against abuse. If the past is any guide, such safeguards will be broadly worded to allow for wide ranging discretion to the State or law enforcement. Even where these safeguards work, the incentives to abuse the system for advantage will remain. A law enforcement agency could always choose to breach the limited safeguards since the resulting information will still be available for use against an accused or suspect, thanks in large part to the RM Malkani case.

The legal theory that permits illegally obtained evidence to be admissible in a case may not itself be responsible for most emerging challenges to privacy. However, as advances in surveillance technologies make them more pervasive, the precedent set by RM Malkani further skews the balance in favour of the State and against the individual. It fosters a fundamentally undemocratic and paternalistic ideology that requires people to be transparent to the State.

Tragically enough, Ray could have still convicted the corrupt officer without permitting the admissibility of illegally obtained evidence - the police recorded the call at the doctors' end with their consent and it could be argued that such a recording did not constitute an interception in violation of the Telegraph Act. Ray did note this fact but nonetheless went on to hold that all illegally obtained evidence remains admissible. Such a blunt force approach to individual rights is typical of Indian jurisprudence. Often disgusted by the crime at hand, citizens tend to cede ever greater authority to law enforcement without regard for its future consequences or necessity consider, for instance, the expansive authority of the Enforcement Directorate and the vast powers of the draconian Unlawful Activities Prevention

We are increasingly creating a lopsided two-track privacy framework that enforces rigorous protections in private contracts, but forces the individual to be subordinate and transparent to the interests of the State. vegan or plant-based diet excludes all animal products, including meat, dairy, and eggs. The benefits can include reducing the risk of chronic diseases and supporting weight loss.

Increasing numbers of people are moving toward vegan diets due to health, animal welfare, or environmental concerns. A 2018 Gallup poll reports that about 3% of people in the United States are fully vegan and notes that sales of plant-based foods are rising.

Vegan diets tend to be rich in nutrients and low in saturated fats. Research suggests that the diet can improve heart health, protect against cancer, and lower the risk of type 2 diabetes.

However, people eating only plant-based foods need to be more aware of how to obtain certain nutrients, including iron, calcium, and vitamin B-12, that usually come from an omnivorous diet.

What is a vegan diet?

A vegan diet involves eating only foods comprising plants. Those who follow this diet avoid all animal products, including meat, dairy, and eggs. Some people also avoid eating honey. For some, being vegan is a dietary choice, while for others, it is a lifestyle choice.

People who choose to live a vegan lifestyle may also avoid clothes, soaps, and other products that use or contain parts of animals, such as leather and animal fur.

Research into the effects of diet on the risk of specific cancers has produced mixed results. However, the International Agency for Research on Cancer report that red meat is "probably carcinogenic," noting that research has linked it primarily to colorectal cancer but also to prostate cancer and pancreatic

The agency also report that processed meat is carcinogenic and may cause colorectal cancer. Eliminating red and processed meats from the diet removes these possible risks.

Weight loss People on a vegan diet tend to have a lower body mass index (BMI) than those following other diets.

The researchers behind a 2015 study reported that vegan diets were more effective for weight loss than omnivorous, semi-vegetarian, and pesco-vegetarian diets, as well as being better for providing macronutrients. Many animal foods are high

in fat and calories, so replacing these with low calorie plantbased foods can help people manage their weight. It is important to note, though,

that eating lots of processed or high fat plant-based foods which some people refer to as a junk food vegan diet — can lead to unhealthful weight gain. Lower risk of type 2 dia-

view, following a plant-based diet can reduce the risk of type 2 diabetes. The research linked this effect with eating healthful plant-based foods, including fruits, vegetables, whole grains, nuts, and legumes.

A vegan diet removes some sources of nutrients from the diet, so people need to plan their meals carefully to avoid nutritional deficiencies.

People may wish to talk to a doctor or dietitian ahead of adopting a vegan diet, especially if they have existing health conditions.

Key nutrients that may be low in a vegan diet include:

• Vitamin B-12: Vitamin B-12 is mainly present in animal products. It protects the nerves and red blood cells. Plant-based sources of this vitamin include fortified cereals and plant milks, nutritional yeast, and yeast spreads. Read more about vegan sources of vitamin B-12.

• Iron: Iron is important for blood health. Beans and dark leafy greens are good sources. Find out more about iron-rich vegan foods.

• Calcium: Calcium is crucial for bone health. Eating tofu, tahini, and leafy greens will help keep calcium levels up. Learn about calcium-rich plant-based

• Vitamin D: Vitamin D protects against cancer and some chronic health conditions, and it helps strengthen the bones and teeth. Regularly eating vitamin D-fortified foods and spending time in the sun can boost vitamin D levels.

China says a US Navy ship 'illegally intruded' into

A Chinese naval force was mobilized to track the USS Gabrielle Giffords during the operation, according to a statement from the People's Liberation Army Southern Theater. The U.S. Navy did not re-

Chinese and Philippine naval and coast guard ships have confronted each other repeatedly around the Second Thomas Shoal in recent months as China tries to prevent the Philippines from resupplying and repairing a rusting warship that it intentionally ran aground in 1999 to serve as a military outpost.

Philippines has sought America's help, agreeing to an expansion of the U.S. military presence in the country earlier this year and launching joint sea and air patrols with the United States late last month.

climbers are still missing PADANG, Dec 4: The bodies of 11 climbers were recovered on Monday a day after a furious eruption of the Mount Marapi volcano as Indonesian rescuers searched for 12 apparently still missing. Marapi has stayed at the third highest of four alert levels since 2011, a level indicating above normal volcanic activity and prohibiting climbers or villagers within 3 kilometres of the peak, said Hendra Gunawan, the head of the Centre for Vol-

canology and Geological Disaster "This means that there should be no climbing to the peak," Gunawan said, adding that climbers were only allowed

below the danger zone, "but sometimes many of them broke the rules to fulfil their satisfac-

11 bodies recovered after volcanic

eruption in Indonesia, and 12

About 75 climbers had started their way up the nearly 2,900-metre mountain on Saturday and became stranded. Eight of those rescued Sunday were rushed to hospitals with burns and one also had a broken limb, said Hari Agustian, an official at the local Search and Rescue Agency in Padang, the West Sumatra provincial capital.

All of the climbers had registered at two command posts or online through West Sumatra's conservation agency before they climbed, Agustian said. It was possible others took illegal roads or local residents were active in the area, but it couldn't be confirmed, he said.

Marapi spewed thick columns of ash as high as 3,000 metres in Sunday's eruption and hot ash clouds spread several miles (kilometres). Nearby villages and towns were blanketed by tons of volcanic debris. Volcanic dust and rain smeared the faces and hair of evacuated climbers, according to video on social media.

Falling ash blanketed several villages and blocked sunlight, and authorities distributed masks and urged residents to wear eyeglasses to protect them from volcanic ash. About 1,400 people live on Marapi's slopes in Rubai and Gobah Cumantiang, the nearest villages about 5 to 6 kilometres from the peak.

Gunawan said that Sunday's eruption was not preceded by a significant increase in volcanic earthquakes. Deep volcanic earthquakes were only recorded three times between November 16 and on Sunday, while the deformation equipment or tiltmeter on the peak showed a horizontal pattern on the radial axis and a slight inflation on the tangential axis.

"This shows that the eruption process is taking place quickly and the centre of pressure is very shallow, around the peak," he said.

Marapi has been observed regularly erupting since 2004 with a gap of 2 to 4 years, Gu-

"Marapi eruptions are always sudden and difficult to detect using equipment because the source is near the surface," Gunawan said, "This eruption was not caused by the movement of magma.'

West Sumatra's Search and Rescue Agency head Abdul Malik said rescuers found 11 bodies of climbers as they searched for those who still missing and rescued three others Monday

"The evacuation process of the bodies and survivors are still ongoing," he said, adding that rescuers are still searching for 12 climbers reportedly still missing.

Marapi has been active since a January eruption that caused no casualties. It is among more than 120 active volcanoes in Indonesia, which is prone to seismic upheaval due to its location on the Pacific "Ring of Fire," an arc of volcanoes and fault lines encircling the Pa-

Indian-origin ex-MP Dave Sharma sworn in as Australia's Senator

MELBOURNE, Dec 4: Dave Sharma, who became the first Indian-origin lawmaker in Australia's Parliament in 2019, was sworn in as a Senator on Monday after his victory in the New South Wales Liberal Senate race.

Sharma, who represented the Sydney seat of Wentworth until his defeat at the 2022 election, beat former New South Wales (NSW) minister Andrew Constance, a frontrunner backed by Opposition Leader Peter Dutton.

The 47-year-old leader will replace ex-foreign minister Marise Payne, who has retired from the Senate, the Canberra Times reported.

"An honour to escort our newest Senator, Dave Sharma, for his swearing-in today. Congratulations Senator Sharma," Senator Maria Kovacic wrote on X.

Sussan Ley, Deputy Leader of the Liberal Party, said Sharma is a "welcome addition" to the federal Liberal team.

"He has strong experience in Parliament and senior diplomatic postings. Dave's keen foreign policy intellect will be particularly welcome given we are in the most dangerous set of geopolitical circumstances since WWII," Ley wrote on X.

In a vote by the New South Wales Liberal

Party members, Sharma defeated Constance 251-206 in the final ballot.

Sharma, who served as Australia's ambassador to Israel from 2013 to 2017, was backed by the moderates within the party.

Senator Sharma will reportedly set up his office in Sydney's west as the Liberals look to claw back support and win predominantly Labor-held seats. He lost his seat of Wentworth in Sydney's

east at the federal election last year to teal independent Allegra Spender. But he secured preselection over former

NSW state treasurer Andrew Constance and former ACT senator Zed Seselja, who also lost his seat to an independent at the last elec-

Opposition Leader Peter Dutton said his entry into the Senate came at a crucial time during international politics and his foreign policy experience would be a great asset.

Sharma's swearing-in comes just weeks before his 48th birthday.

In 2019, Sharma scripted history by becoming the first Indian-origin lawmaker in Australia's Parliament after winning a seat in a Sydney suburb in the federal election. (PTI)

Ukrainian diplomats negotiate both climate change and Russia's war on their nation at COP28 in Dubai DUBAI, Dec 4: While Ukrainian diplomats take part in negotiations

at the United Nations COP28 climate talks, Russia's war on the country lurks just in the background — even as the United Arab Emirates has seen its business ties to Moscow surge despite Western sanctions.

As Ukraine announced a 450 million euro (\$489 million) expansion Monday of a wind farm in its Mykolaiv region, officials highlighted how its turbines would be spread far enough apart to survive any Russian missile attack. They decried continued attacks by Moscow on its energy infrastructure as snow storms grip the country. And an American diplomat forcefully denounced Russian President Vladimir Putin at an event that's seen demonstrators stopped from naming Israel in their protests over its pounding airstrikes and ground offensive in the Gaza Strip against Hamas.

"The war in Ukraine — Putin's invasion — represents a fundamental challenge to the international system that the United States and our allies and partners are trying to build," U.S. Assistant Secretary of State for Energy Resources Geoffrey R. Pyatt told The Associated Press. "Putin is dragging us back to the law of the jungle. He has to be

The Russian embassies in Abu Dhabi, the UAE's capital, and Washington did not immediately respond to a request for comment.

The war looms large over Ukraine's pavilion at the COP28 summit A brick roof from the war-torn Kherson region serves as a physical reminder of the collapse of the Kakhovka Dam and the rush of water from the country's largest reservoir that washed away villages and cities in June. The dam's destruction led to deadly flooding, endangered crops in the world's breadbasket, threatened drinking water supplies for thousands and unleashed an environmental catastrophe.

Ukraine puts blame for the collapse on Russia, which had the means, motive and opportunity to bring down the dam. Russia has blamed Ukraine for the dam's collapse through a variety of allegations, though even Putin acknowledged it provided his retreating troops cover and disrupted Ukraine's counteroffensive this summer.

Monday's event at the pavilion saw private Ukrainian energy producer DTEK sign a memorandum of understanding with the Danish firm Vestas to expand its wind farm project in Mykolaiv. Its first phase was built for 200 million euros (\$217 million) amid the war, with crews spending about a third of their time in bomb shelters during the project, said Maxim Timchenko, the CEO of DTEK.

"They work in (body) armor and they see missiles flying above

The new 450 million euros in funding comes from banks with government guarantees and war-risk insurance, Timchenko said, praising Denmark for its role in securing the project's financing.

The energy grid expansion comes as Russia still occupies Europe's largest atomic power plant in Ukraine, the Zaporizhzhia nuclear power plant, and fighting still endangers others. At risk as the cold sets in this winter is power, too.

Russia last winter destroyed about half of Ukraine's electricity infrastructure, including generating plants and power lines. Ukraine says it has repaired that damage during the summer, but the largest-ever wave of Russian attacks using Iranian-supplied drones last month has renewed fears that its grid again will come under attack. "Putin has made energy one of his weapons," said Pyatt, a former

U.S. ambassador to Ukraine. "He's done that with his drone and missile attacks on civilian energy infrastructure. He's done that by turning off the gas pipelines in order to try to weaken Europe's resolve to support the Ukrainians. "So we have recognized from day one that for Vladimir Putin, en-

ergy is just about as much a part of his war strategy as are his tanks and his missiles." (AP)

Former Pak PM Imran Khan, ex-foreign min Qureshi to be indicted in cipher case again on Dec 12 secret diplomatic cable -

ISLAMABAD, Dec 4: A special court here ruled on Monday that jailed former Pakistan prime minister Imran Khan and ex-foreign minister Shah Mahmood Qureshi would be indicted again on December 12 in the cipher case for allegedly leaking a diplomatic cable.

The in-prison hearing of Khan, 71, and Qureshi, 67, began from the start on Saturday after a ruling by the Islamabad High Court last month declared the jail trial illegal on procedural grounds and also nullified its proceedings.

Special Court Judge Abual Hasnat Zulqarnain issued the directive while hearing the case at the Adiala jail premises in Rawalpindi, where both the Pakistan Tehreek-e-Insaf (PTI) party leaders are currently jailed, the Dawn newspaper reported.

PTI party chief Khan has been incarcerated at the high-security Adiala jail since September 26. Qureshi was also arrested in the cipher (secret diplomatic cable) case and is imprisoned in the same prison

The hearing of the cipher case was again shifted to jail after the order by the trial judge, followed by its approval by the Cabinet and notifications issued by the Ministry of Law and Justice as required under

On Monday, Judge Zulgernain adjourned the hearing till December 12 and said charges would be framed against the PTI leaders of the same day, the report said.

Family members and lawyers of the incarcerated leaders attended the hearing along with special prosecutor Zulfikar Abbas Naqvi and Rizwan Abbasi, according to the report.

Six members of the media were allowed to attend the proceedings, it

4.45 lakh FIRs on 'crime against women' in 2022 in India, highest on average in Delhi: NCRB

NEW DELHI, Dec 4: A total of 4,45,256 cases of crime against women were registered across India in 2022, almost 51 FIRs every hour, up from 4,28,278 in 2021 and 3,71,503 in 2020, according to the latest NCRB data.

The rate of crime against women per lakh population stood at 66.4 while the charge sheeting in such cases was logged at 75.8, showed the data in the annual crime report of the National Crime Records Bureau (NCRB), which functions under the Union Ministry of Home Af-

majority of crimes The against women under the Indian Penal Code were of cruelty by husband or his relatives (31.4) per cent) followed by kidnapping and abduction of women (19.2 per cent), assault on women with intent to outrage her modesty (18.7 per cent), and rape (7.1 per cent), the NCRB

With 14,247 cases in 2022, Delhi registered the highest rate of crime against women in the country at 144.4 -- way above the country's average rate of

Such cases in Delhi stood at 14,277 in 2021 and 10,093 in 2020, the official data showed.

In absolute numbers, Uttar Pradesh (65,743) registered the maximum FIRs in cases of crime against women in 2022 followed by Maharashtra (45,331), Rajasthan (45,058), West Bengal (34,738) and Mad-

hya Pradesh (32,765), it showed. These five states together contributed to 2,23,635 (or 50.2 per cent) of the total cases lodged in India last year, according to the NCRB, which is tasked with the collection and analysis of crime

In 2021 and 2020, Uttar Pradesh registered 56,083 and 49,385 cases in this category followed by Rajasthan (40,738 34,535), Maharashtra (39,526 and 31,954), West Bengal (35,884 and 36,439) and Madhya Pradesh (30,673 and 25,640), it showed.

A total of 12 states and Union Territories recorded crime rates higher than the national average

Delhi topped the list at 144.4 followed by Haryana (118.7), Telangana (117), Rajasthan (115.1), Odisha (103), Andhra Pradesh (96.2), Andaman and Nicobar Islands (93.7), Kerala (82), Assam (81), Madhya Pradesh (78.8), Uttarakhand (77), Maharashtra (75.1) and West Bengal (71.8). The rate of crime in Uttar Pradesh -- which alone contributed nearly 15 per cent of the

cases in India -- stood at 58.6,

according to the NCRB. In a note of caution about the annual report, the NCRB said the primary presumption that the upward swing in police data indicates an increase in crime and thus a reflection of the ineffectiveness of the police is falla-

"Rise in crime' and 'increase in registration of crime by police' are clearly two different things, a fact which requires better understanding. Thus an oftrepeated expectation from certain quarters that an effective police administration will be able to keep the crime figures low is misplaced," it stated.

"Increase in crime numbers in a state police data may in fact be on account of certain citizencentric police initiatives, like launching of e-FIR facility or women helpdesks," it said.

"The increase or decrease in crime numbers, however, does call for a professional investigation of underlying factors pertaining to the local communities to suitably address the pertinent issues," it added. (PTI)

RS panel holds Raghav Chadha guilty of presenting misleading facts

NEW DELHI, Dec 4: AAP MP Raghav Chadha was on Monday held guilty of presenting misleading facts to the media by the Privileges Committee of Rajya Sabha and was allowed to attend the House proceedings after his suspension was ended through a motion

Chadha was also held guilty by the RS Committee of adding names of members in the proposed select panel without their consent.

A motion to end his suspension was moved in the house by BJP member GVL Narasimha Rao. which was adopted by a voice vote, that said his suspension so far is "sufficient punishment" for him. Ahead of the motion, Rajya Sabha chairman Jagdeep Dhankhar said, "the committee after deep and thoughtful consideration finds Raghav Chadha finds guilty of both the charges.'

"Charge 1: that he intentionally and deliberately presented misleading facts to the media, misinterpreted proceedings of the Council resulting in affront to the authority of the Chairman, Raiva Sabha and engaged in outrageous defiance of the resolutions of the House and directives of consent in blatant transgression of rule 72 of Rules of Procedure and Conduct of Business in the Council of States (Rajya Sabha)," the chairman also announced.

Dhankhar said, "As regards the sentence, 'the Committee finds the suspension suffered by him since 11th August, 2023 from the House thus far as sufficient sentence that will meet the ends of

"The Committee stands committed to upholding the sanctity of parliamentary proceedings and safeguarding the integrity of the institution. The Committee expresses hope that Shri Raghav Chadha, Member will reflect and introspect. "The Committee expects Shri Raghav Chadha

to uphold the expected standards of conduct and decorum befitting a Member of Parliament," the Chairman said. Earlier, Elamaram Kareem, a member of the panel, presented the report of the Privileges Committee of the Rajya Sabha in the House. Later, GVL Narasimha Rao, who is also a member of the RS privileges panel, moved the motion under Proviso to Rule 256 (2) of the Rules of Procedure for Conduct of Business in the

"That this house resolves that Shri Raghav

ileges, and the suspension suffered by him so far be taken as sufficient punishment and the house may consider discontinuance of suspension of Shri Raghav Chadha, member, from the service of the Council from this day," the motion read as it was put to vote by the Chairman and was adopted by a voice vote.

After the motion was adopted, Dhankhar announced that Chadha can now attend the House

"Shri Raghav Chadha may attend the Session," the Chairman said after the adoption of the motion. Chadha was suspended from the Upper House on August 11, during the Monsoon session of Parliament. He had earlier moved the Supreme Court against his suspension and thanked the apex court for its intervention.

After he was allowed back in the House, Chadha thanked the Supreme Court and Rajya

"I am happy that my suspension was ended. I am thankful to the Supreme Court and Rajya Sabha chairman for this. During the 115 days, I got a lot of love and blessings from people. I got strength from you guys. I am thankful to you from the bottom of my heart," the AAP MP said in a video message later. (PTI)

Delhi HC seeks Centre's stand on PIL against deepfakes, artificial intelligence

NEW DELHI, Dec 4: The Delhi High Court on Monday sought the Centre's response on a public interest litigation against the unregulated use of artificial intelligence and deepfakes. Deepfakes are videos or images that are created using Artificial Intelligence (AI)-powered deep learning software that show people saying and doing things that they didn't say or do. A bench headed by Acting Chief Justice Manmohan observed that technology cannot be "reined in" and the issue raised by the petitioner required deliberations which only the government could undertake.

'There is no easy solution. It requires a lot of deliberation. It is a very complicated technology," the bench, also comprising Justice Mini Pushkarna, said. Maintaining that the matter required balancing several factors as there were certain positive uses of the technology, the court added, "It is something that only the government with all its resources

The central government counsel said it was public knowledge that the government was looking into the issue and sought time to seek instructions. Regulations are in place and the ministry has already said it is a se-

The petitioner, represented by advocate Manohar Lal, said while technological development was happening by leaps and bounds, the law was moving at a snail's speed. Law by its nature lags behind, the court said as it listed the case for further hearing on January 8.

Petitioner Chaitanya Rohilla, a lawyer, sought directions to the Centre to identify and block websites providing access to deepfakes and regulate artificial intelligence to protect the fundamental rights of citizens. (PTI)

IN-SPACe unveils seed fund for start-ups in urban development, disaster management

"The seed fund scheme is a part of efforts to provide a special thrust to enhance the space activity capabilities of the nation with the active participation of the start-ups," Pawan Goenka, Chairman, IN-SPACe said.

He said the scheme was designed to support Indian space start-ups that aim to develop innovative space products and services to improve the quality of life for people and communities in India and around the

The last date of application for the scheme is December 20.

As part of the scheme, selected start-ups will receive seed funding for transforming an original idea into a prototype using space technology, ISRO facility support including Earth Observation (EO) data for validation of the concept, mentorship support, and access to data algorithm as transfer of technology from the Department of Space. At the outset, the counsel representing the ED contended that a petition filed by Chandrasekhar with similar prayers is already pending in the high court. Responding to him, Chandrasekhar's counsel said his earlier plea challenged the framing

However, according to the settled principle of law with respect to the PMLA, a person cannot be convicted of money laundering if they have been acquitted in the criminal case, that is, the predicate offence, or the case has been quashed.

The petition said the trial arising out of the scheduled or predicate offence is at a halt due to the stay granted by the Delhi High Court and the Supreme Court, and that there is every possibility that the same may be quashed and set aside resulting in the whole process getting terminated.

The plea alleged the investigation and the trial proceedings in the ED case are being conducted in total violation of the settled principles of law, are highly arbitrary and

"On bare perusal of the prosecution complaint filed by the respondent (ED), it can be clearly seen that the petitioner is not even involved in the generation of money laundering and, in fact, it is TTV Dhinakaran and his associates who were actually involved in the process of money laundering....," it alleged.

The money laundering probe against Chandrasekhar has arisen from a 2017 Delhi police case which alleged he took money from former AIADMK leader TTV Dhinakaran to bribe Election Commission officials to secure the party's 'two leaves' symbol for the VK Sasikala faction in a byelection to the R K Nagar assembly seat in Tamil Nadu. In 2019, the high court had stayed the trial against Dhinakaran and Chandrasekhar in the bribery case.

The trial court had framed charges against Chandrasekhar in the money laundering case probed by the ED in October last year after he was arrested earlier that year while he was in jail in connection with another case. Chandrasekhar is also facing proceedings for allegedly cheating and extorting money from some prominent people, including individuals like former Fortis

Delhi HC seeks Centre's stand on PIL against use of public servants, Army for political propaganda

Exercise seems to be showing that government has conferred all kinds of benefits to people

NEW DELHI, Dec 4: The Delhi High Court on Monday sought the Centre's stand on a PIL against the alleged use of public servants and defence personnel to spread "political propaganda" by showcasing the achievements of the government in the last nine years.

A bench headed by Acting Chief Justice Manmohan observed though there should not be any objection to a government popularising its welfare schemes but asked the central government counsel to take instructions on publicising the work done in the last nine years.

"You can say recent. Why nine years?.. Make it recent issues or developments," the bench, also comprising Justice Mini Pushkara,

Petitioners EAS Sarma and Jagdeep S Chhokar, represented by lawyer Prashant Bhushan, said several selfie points were being installed with directions to soldiers to promote the work done by the ministry of defence, and public servants were being deployed as special officers in "Viksit Bharat Sankalp Yatra" to "canvass" for the ruling party in the upcoming elec-

Bhushan argued that the communications issued by controller general of defence accounts on October 9 and the department of personnel and training on October 17 about publicising the government's development activities amounted to "corrupt practice" under the Representation of the People Act



which prohibits the use of public servants for the benefit of the rul-

ing party in elections. The election of former Prime Minister Indira Gandhi was set aside for using government offi-

"This is political propaganda of the government highlighting only achievement of the last nine years.. It says nothing about the scheme. The court also asked the counsel for the Election Commission to seek instructions on the issue. Additional Solicitor General Chetan Sharma opposed the petition and said the petitioners were wrongly assuming that the government was a political party.

"Government of India and party are different things. This is pure government, and for government, it is permissible. We will take in-

structions on nine years," he said. The petition said the government's action of deploying public servants to showcase the achievements for a political purpose disturbs free and fair elections and the level playing field, which are essential parts of democracy.

"Centre's brazen move, referred to above, has wider implications. Firstly, considering that the campaign to showcase the NDA government's achievements, for the time being, will extend up to 25.01.2024, it will amount to deploying civil servants and public resources to influence the voters even during the 2024 Parliament elections," the petition said.

"Secondly, the Centre's move has set an unhealthy precedent to encourage the political leadership in each State going for elections to do likewise, deploying their government machinery and resources in electioneering, a situation that would certainly lead to anarchy and wholesale, irreversible erosion of democratic values," it further

Meanwhile, reacting to the poll outcome, the outgoing chief minister Zoramthanga on Monday said anti-incumbency was the main factor for his party's debacle in the state assembly polls.

He submitted his resignation to Governor Hari Babu Kambhampati in the evening after the MNF suffered a

heavy defeat to the Zoram People's Movement (ZPM). Speaking to reporters after submitting his resignation, Zoramthanga said that the 'anti-incumbency and Covid-

19 onslaught are the main factors' for his party's defeat in the state assembly polls. People were also not satisfied with the performance of the MNF government due to inconvenience caused by the Covid-19 pandemic, he said, adding that the outbreak of coronavirus infection had impacted the state economy adversely and impeded the government.

"Because of the anti-incumbency factor and people's dissatisfaction with our performance due to the Covid-19 onslaught, I lost my government," Zoramthanga said. The MNF chief said his party accepted the poll verdict. Asked whether MNF will be part of the BJP-led NDA, Zoramthanga said he has no intention of leaving the alliance but the final decision will be taken by the party.

"Remaining in NDA depends on the decision of our party. I am the founding member of NDA. Personally I have no intention of leaving the alliance," he said.

MNF is part of the BJP-led North East-Democratic Alliance (NEDA) and an ally of NDA at the Centre. However, the party has no alliance with the BJP in Mizoram. The present Mizoram assembly term will end

tivities in Assam between 2014 and 2023, he added. The minister said that after 2014, projects worth ₹ 44,000 crore have been taken up by oil manufacturing companies (OMCs) in Assam. Out of which, Numaligarh Refinery Expansion Project is about ₹ 18,968 crore, the North East Gas Grid is ₹ 9,265 crore, and the Paradip Numaligarh Crude Pipeline (PNCPL) is ₹ 9,058 crore, he said. These projects have already been sanctioned and work is underway, he said. In Assam, OMCs have set up ethanol plants with a total production capacity of 1,150 kilo litres per day at an outlay of ₹ 1,370 crore. Numaligarh Refinery Ltd (NRL) is setting up a commercial 2G ethanol plant to be commissioned by 2024 at a cost of ₹ 4,200 crore, he added. Replying to another supplementary on crude oil prices, the minister said petrol prices in the last two years have come down by 11 per cent and diesel in smaller amounts owing to reduction in central excise twice. 2 IAF pilots killed as Pilatus trainer aircraft crashes in Hyderabad

NEW DELHI, Dec 4: Two pilots of the Indian Air Force (IAF) were killed on Monday as a Pilatus PC-7 Mk II aircraft crashed near Hyderabad, the first such accident involving the Swiss-origin trainer jet.

The IAF has ordered a Court of Inquiry to ascertain the cause of the accident.

"A Pilatus PC 7 Mk II aircraft met with an accident today morning during a routine training sortie from Air Force Academy, Hyderabad," the IAF said in a statement.

"It is with deep regret that the IAF confirms both pilots onboard the aircraft sustained fatal injuries. No damage to any civil life or property has been reported," it added. Defence Minister Rajnath Singh condoled

"Anguished by this accident near Hyderabad. It is deeply saddening that two pilots have lost their lives. In this tragic hour, my thoughts are with the bereaved families," he

the deaths of the two pilots.

The Pilatus PC-7 Mk II is a trainer aircraft designed and manufactured in Switzerland by Pilatus Aircraft.

The aircraft is capable of undertaking all basic training, including aerobatics, instrument, tactical and night flying. In May 2012, India sealed a deal to procure

75 Pilatus PC-7 MkII aircraft for the İAF. The IAF pilots undergo basic training on Pilatus PC-7 Mk II planes and Kiran Mk-1/1A jets. The IAF is now procuring an in-

digenously-developed trainer aircraft. In March, the defence ministry sealed a deal with Hindustan Aeronautics Limited (HAL) to procure 70 HTT-40 basic trainer aircraft at a cost of more than Rs 6,800 crore

The HTT-40 contains approximately 56 per cent indigenous content, which will progressively go beyond 60 per cent through indigenisation of major components and





Ravi Bishnoi emerges as India's third spin option ahead of T20 WC

BENGALURU, Dec 4: When Ravi Bishnoi was named in India's against South Africa, it, perhaps, was the clearest indication about his place in the think tank's longterm plans with the next year's T20 World Cup in mind.

With only six T20Is remaining for India ahead of the showpiece, it can be assumed that the 23-yearold leg-spinner has moved ahead of veteran Yuzvendra Chahal in the pecking order, for now at least. Chahal is not a part of India's T20I side to face the Proteas.

Chahal is 33 and Bishnoi is 23, but the latter getting as much or more game time in T20Is is not just about a natural generational transition.

Chahal has played nine T20Is this year, grabbing as many wickets whereas Bishnoi appeared in 11 matches and picked up 18 wickets. The difference is there for everyone to see.

In the just-concluded series against Australia, Bishnoi was India's go-to bowler and he rewarded the faith reposed on him by emerging as the 'Player of the Series, taking nine wickets from five matches.

It was not just about the wickets but the whole attitude shown by him to bowl under any condition or situation was praiseworthy.

In fact, Bishnoi had an eminently forgettable first match at Visakhapatnam, leaking 54 runs in four overs and his fielding too was in a shambles marred by a dropped

eight thereafter. Out of the 20 overs he bowled against the Aussies, seven were in the Power Play segment (1-6 overs). In this phase, he took five wickets at a fine economy rate of 6.45, besides bowling 20 dot balls.

Australian skipper Matthew Wade admitted that facing Bishnoi even on some of the battingfriendly tracks here was not an

"Their spinners bowled well. They got us tied down and we couldn't really break away in that middle period. So, that was probably the biggest difference in the game. ECB tells Archer to skip 2024 IPL to manage workload ahead of T20 World Cup

LONDON, Dec 4: England and Wales Cricket Board (ECB) has instructed Jofra Archer to skip next vear's Indian Premier League (IPL) in order to manage the injury-prone pacer's workload in the run up to the 2024 T20 World Cup, according to a report.

Archer, who was bought by Mumbai Indians ahead of the 2022 IPL for a whopping INR 8 crore, was released by the franchise last week. His name doesn't figure in the list of players who have registered for the IPL auction, set to be held on December 19 in Dubai.

Archer, who has been plagued by multiple injuries, suffered a recurrence of his elbow stress

during the IPL in May. The 28year-old Barbados born cricketer hasn't played any professional cricket since then and also missed the ODI World Cup. "... the ECB believes that it will be easier to manage Archer's comeback if he is in the UK in April and May under its supervision than if he is in India on the books of an IPL team looking to get their money's worth from him," 'ES-PNCricinfo' reported.

As per the report, he has signed a new two-year contract with the ECB and ahead of the T20 World Cup in the West Indies and the United States from June 4 next year, the board has "opted to take as much control fracture while playing for MI over Archer as possible." (PTI)
