Sec 6A of Citizenship Act

SC: Govt must be given latitude to make adjustments necessary to save nation

NEW DELHI, Dec 6: Observing that several northeastern states are affected by insurgency and violence, the Supreme Court Wednesday said the government must be given "latitude and leeway" to make adjustments necessary to save the nation.

Referring to section 6A of the Citizenship Act applicable exclusively to Assam, a five-judge constitution bench headed by Chief Justice DY Chandrachud said governments have to make compromises for the overall well-being of the nation. "We must also give the government that lati-

tude. Even today there are parts of North East, we may not name them, but there are states affected by insurgency, affected by violence. We have to give the government that leeway to make adjustments necessary to save the nation," Chandrachud said.

He made the observation after senior advocate Shyam Divan, appearing for the petitioners, submitted that section 6A operates in a "blanket manner" and rewards illegal immigrants who continue to stay in Assam in violation of the citizenship law.

"Assam and other immediate neighbouring border states form a homogeneous single class. Singling out Assam is im-

permissible," Divan said. The bench, also comprising Justices Surva Kant, M M Sundresh, J B Pardiwala and Manoj Misra, is hearing 17 petitions to examine the con-

stitutional validity of section 6A of the Citizenship Act relating to illegal immigrants in Assam

Section 6A was inserted in the Citizenship Act as a special provision to deal with the citizenship of people covered under the Assam Accord. (CONTD. ON PAGE-9)

CM pats police for drop in crime rate

'Developmental activities and providing jobs to youths paid dividends'

GUWAHATI, Dec 6: Chief minister Himanta Biswa Sarma Wednesday said "strong and uncompromising policing" has been the key to decline in incidents of crime, asserting that the state will become a "paradise" within three years if law and order is maintained in a similar

Sarma's comments came after the latest report of the National Crime Records Bureau (NCRB) showed that the total number of cognisable offences in Assam fell by 48.26 per cent to nearly 69,000 cases in 2022 as against the previous year.

He also said the crime rate has seen a decline in the state in 2023 as well.

"Strong and uncompromising policing is the reason for this decline in crime rate; there is no alternative to strong policing. If we can maintain this robust policing for three years, Assam will be a paradise," Sarma said.

The chief minister said this is the first time Assam has witnessed a fall in overall crimes since 1979, and the gov-



ernment hopes to continue this trend in the coming years.

"Assam was at ninth position in 2021 in India in terms of the number of crimes taking place. As per NCRB data, we are now at 20th position and this is real good news," he said. Sarma said

jobs to youths have also helped reduce the crime graph of the state.

He, however, said registration of cases related to drugs and child marriage will rise, as the state has been carrying out continuous operations against

"By 2026, we will wipe out child

marriage from Assam. After the next assembly session, we will also end polygamy," the CM said without elab-

Asked about the low conviction rate in Assam, he said one of the main reasons is filing of marital discord cases under IPC 498(A), which is eventually withdrawn by many complainants after settlement. "In Assam, the highest number of cases are filed under this section and these continue for years. By the time the case goes to court, the wife and husband settle their differences," Sarma

The conviction rate in 2022 stood at 13.56 per cent as against 6.13 per cent in the previous year.

"We have been taking several measures, including creation of the Directorate of Prosecution and regular prosecution service cadre. We expect a huge improvement very soon," he said. At present, around 32,000 cases are pending in police stations without filing of chargesheets, he said. (CONTD. ON PAGE-9)

Replying to a debate in the Lok Sabha on the Jammu and Kashmir Reservation (Amendment) Bill and the Jammu and Kashmir Reorganisation (Amendment) Bill, Shah said if Nehru had taken the right steps, a large chunk of territory would not have been ceded and Pakistan-occupied Kashmir would have been part

during the time of Nehru, Kashmir had to suffer. With responsibility, I want to say that the two big blunders that happened during the tenure of Jawaharlal Nehru, happened due to his decisions, because of which Kashmir had to suffer for years," Shah said.

"Kashmir had to suffer due to Nehruvian blunders. One was that when our Army was winning and as soon as Punjab area was reached. ceasefire was declared and Pakistan-occupied Kashmir was born. 

Digital India Act unlikely to be passed before LS polls

NEW DELHI, Dec 6: The central government may not be able to put in place the Digital India Act, which aims to replace the over 23 years old IT Act 2000, before the next general election, as there is not much time left for extensive consultation, Union minister of state for electronics and IT Rajeev Chandrasekhar said on Wednesday.

While speaking at the Global Technology Summit 2023, the Union minister, however, said that the rules for Digital Personal Data Protection Act will be out later this month for consultation and are expected to be notified by the end of December or early January next year. Chandrasekhar said, the existing IT Act doesn't even have the word internet and there is a consensus that it can be safely superseded and replaced.

"The successor act to that is something called the Digital India Act, which is a work in progress. We have the draft ready and a lot of work has gone into it.

"I suspect that before the next elections, we will not be able to legislate it because one of the things that the Prime Minister insists on is that we need every digital legislation to be extensively consulted. Therefore, I don't think we have enough time to get that done,' Chandrasekhar said. The proposed Digital India Act has a lot of focus on the online segment.

The proposed Digital India Act will focus on making the internet open with rules to check on dominance of certain players, focus on online safety and user harm with provisions like age-gating by regulating addictive technology, discretionary moderation of fake news by social media, define and regulate emerging technologies etc.

The DIA also proposed stringent regulation for privacy invasive devices such as spy camera glasses, wearable tech by adding know your customer rules for retail sales backed by appropriate criminal law

Over 100 websites blocked for facilitating organised illegal investments

NEW DELHI, Dec 6: The Centre has blocked over 100 websites involved in facilitating organised illegal investments related to economic crimes and task-based parttime job frauds.

According to an official statement, these websites were being operated by overseas actors and targets were mostly retired employees, women and unemployed youth looking for part time jobs.

The Indian Cybercrime Coordination Centre (I4C), a wing of the Union home ministry, through its vertical National Cybercrime Threat Analytics Unit had last week identified and recommended that these websites

be blocked. Following this, the Union ministry of electronics and information technology, invoking its power under the Information Technology Act, 2000, has blocked these websites, the statement said.

These websites, which facilitated task-based organised illegal investment related to economic crimes, were learnt to be operated by overseas actors and were using digital advertisement, chat messengers and mule and rented accounts.

The proceeds from the large scale economic frauds were seen to be laundered out of India using card network, crypto currency, overseas ATM withdrawals and international Fintech companies, the statement said. The



I4C is an initiative of the home ministry to deal with cyber crimes in the country in a coordinated and comprehensive manner.

Citizens have been advised to promptly report phone numbers and social media handles used by such fraudsters to the National Cybercrime Reporting Portal (NCRP), the statement said. It said several complaints have been received through 1930 helpline and the NCRP and these offences were posing significant threat

to the citizens and also involved data security concerns. These frauds, typically, involve a number of steps that include targeted digital advertisements launched on platforms like Google and Meta using key words like "Ghar baithe job" (CONTD. ON PAGE-9)

RBI's MPC meet begins amid expectations of status quo on interest rate

high-powered rate setting panel on Wednesday began its 3-day brainstorming on the next set of bimonthly monetary policy amid expectation of continued pause on the short-term key lending rate as GDP growth is gaining momentum, and inflation manageable.

RBI left the benchmark policy rate (repo) unchanged in its past four bi-monthly monetary policies. It had last increased the repo rate in February to 6.5 per cent, thus ending the interest rate hike cycle which began in May 2022 in the aftermath of Russia-Ukraine war and subsequent disruptions in the global supply chain resulting in high inflation in the country.

On expectations from the MPC, Aditi Nayar, Chief Economist at ICRA said with the GDP data for the second quarter of 2023-24 appreciably higher than the MPC's last forecast, and continuing concerns on various aspects of food inflation, "we expect the MPC to pause in its December 2023 review, amidst a fairly hawkish tone of the policy document".

According to Deutsche Bank Research, RBI will likely increase 2023-24 GDP forecast to 6.8 per cent year-on-year, from 6.5 per cent earlier, while holding the CPI forecast unchanged at 5.4 per cent.

"RBI will likely keep repo rate and stance unchanged, persist with would unveil the decision of the tight liquidity and ensure that short-term rates remain around 6.85-6.90 per cent, resulting in an 'effective rate hike'," it said.

India retained the tag of the world's fastest-growing major economy, with its GDP expanding by a faster-than-expected rate of 7.6 per cent in the September quarter on booster shots from government spending and manufacturing.

Director of Medical Technology Association of India (MTaI) Sanjay Bhutani, said the central bank's recent MPC meetings have kept the policy rate unchanged, aligning with market expectations.

"We anticipate a similar outcome for this upcoming meeting. However, with inflation on a downward trend, an easing of interest rates could be on the cards, potentially occurring as early as



February-March 2024," he said, and added this would be a positive development for all sectors, particularly capital and research-intensive

industries like the medical technology sector. The government has mandated the central government to ensure that the retail inflation based stays at 4 per cent, with a margin of 2 per cent on either side.

Retail inflation eased to a fourmonth low of 4.87 per cent in October, mainly due to cooling prices of food items. The Reserve Bank's MPC, in its October meeting, projected CPI inflation at 5.4 per cent for 2023-24, a moderation from 6.7 per cent in 2022-23. Markets scale fresh lifetime highs; Nifty nears 21k-level



MUMBAI, Dec 6: Equity benchmarks Sensex and Nifty rallied for the seventh straight session to hit fresh lifetime highs on Wednesday, driven by gains in index majors Reliance Industries, ITC and L&T amid persistent foreign fund inflows.

Besides, receding crude oil prices in international markets also boosted sentiment, traders said.

The 30-share BSE Sensex surged 357.59 points, or 0.52 per cent, to settle at a new record of 69,653.73.

The barometer rose to 69,744.62 during intra-day. The broader index Nifty also climbed 82.60 points, or 0.40 per cent, to hit its fresh peak of 20,937.70.

"Post-state elections, market optimism thrives, confirming policy continuity and meeting investor expectations. A robust FII reversal is fuelled by receding inflation and dropping yields in US and Indian markets. The allure of Indian market gains post-China credit rating downgrade and decline in oil prices was followed by ease in geopolitical tensions," said Vinod Nair, Head of Research at Geojit Financial Services.

As many as 20 shares of the BSE benchmark index closed the session with gains, while 30 stocks in the Nifty ended in positive territory.

Among major Sensex movers, Wipro closed with the maximum gain of 3.85 per cent, followed by ITC -- 2.51 per cent higher. L&T and TCS gained 2.31 per cent and 2.13 per cent, respectively. Tata Motors, Nestle India, Infosys and Bajaj Finance were other gainers. On the other hand, NTPC, Axis Bank, UltraTech Cement and ICICI Bank ended the session with a loss of up to 1.58 per cent.

In the broader market, the BSE largecap index rose 0.61 per cent, the midcap gauge gained 0.19 per cent, and smallcap advanced by 0.18 per cent. "A strong rein anticipation of robust summer demand, fuels the momentum in the power sector," Nair said.

However, he cautioned that short-term profit booking may occur due to domestic premium valuation concerns. "Further, lingering El Nino risks, a drop in reservoir levels, and reduced sowing may hold RBI to profoundly upgrade H2 FY24 growth and reduce future inflation estimates.'

Among sectoral indices, utilities surged 3 per cent, followed by power (2.41 per cent). While oil & gas jumped 1.96 per cent, the IT index went up 1.48 per cent, capital goods advanced by 1.25 per cent, and teck rose by 1.18 per cent.

In contrast, healthcare declined by 0.64 per cent, telecommunications slipped 0.58 per cent and bankex

Analysts said the sustained equity buying by foreign institutional investors was attributed to declining US bond yields, while the domestic players were betting big on favourable macroeconomic data and expectations of longer political stability in the country.

Besides, investors are also expecting the Reserve Bank to maintain the status quo on the interest rate in its bi-monthly monetary policy decision to be announced on Friday, they added.

On Wednesday, global oil benchmark Brent crude was trading 0.31 per cent lower to USD 76.96 a barrel.

"The bearish formation around the crucial resistance of 21,000 (Nifty) amplifies the bearish sentiment. Rupee rises 5 paise to close at 83.32 against US dollar

MUMBAI, Dec 6: The rupee appreciated 5 paise to close at 83.32 (provisional) against the US dollar on Wednesday, helped by a bullish trend in domestic equities and sustained foreign fund inflows.

Forex traders said elevated American currency in the overseas markets and dollar buying by the Reserve Bank of India (RBI) capped sharp gains for the local unit. The rupee consolidated in a narrow range as investors remained on the sidelines ahead of the RBI's monetary policy decision later this week. At the interbank foreign exchange market, the local purposeful growth has made it unit opened at 83.35 against the

The runee intra-day low of 83.37 and a high of 83.29 against the greenback and finally settled at 83.32 (provisional) against the dollar, higher by 5 paise from its previous close. even as domestic benchmark indices touched new lifetime peaks. On Tuesday, the rupee settled at 83.37 against the dollar.

"We expect the rupee to trade with a slight negative bias on positive tone in the US Dollar and fresh foreign inflows. A weak tone in crude oil prices and positive domestic markets may also support

"However, the RBI intervention may cap the sharp upside. Traders may take cues from US ADP Trade balance and non-farm employment change data. Investors may remain cautious ahead of RBI's monetary policy decision on Friday," said Anuj Choudhary Research Analyst, Sharekhan by BNP Paribas.

The Reserve Bank is likely to maintain the status quo on the short-term interest rate in its monetary policy review. RBI Governor Shaktikanta Das-headed Monetary Policy Committee (MPC) is scheduled to begin its three-day deliberations on December 6. Das will unveil the decision of the six-member MPC on December 8.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.07 per cent lower at 103.97. (PTI)

State journalist joins ULFA-I, sparks concerns

DIBRUGARH, Dec 6: In a concerning development, a journalist from Assam, identified as Bidyut Mahanta from Naharkatia in Dibrugarh, has reportedly joined the proscribed United Liberation Front of Asom-Independent (ULFA-I). Mahanta shared a detailed post in Assamese on Facebook, expressing his decision to join the banned militant outfit.

The news of Mahanta's association with ULFA-I has raised alarms in the region, adding to the growing trend of local youth joining militant outfits. The motive behind Mahanta's decision to join ULFA-I remains unknown at this time. His announcement on social media has triggered widespread concern and discussions.

This incident follows a similar case on November 4, when Manash Borgohain from Golaghat district publicly declared his allegiance to ULFA-I through a video on social media. The trend of youths, especially from upper Assam, showing an inclination to join militant outfits has become a matter of concern for authorities.

Reports suggest that ULFA-I has initiated a recruitment process, tar-



geting educated youths. The region has witnessed instances of youth joining such outfits, with some choosing to return home later. Bidyut Mahanta, previously recognised for his work as a journalist and having won awards, has not provided details regarding his decision to join ULFA-I.

The situation highlights the challenges authorities face in preventing radicalisation and addressing the root causes that lead individuals, including educated youths, to join insurgent groups.

Cong: Future tense

n the aftermath of the recent state elections, the discourse around a perceived North-South political divide in India has gained traction. The influence of social media, notably Musk's 'X' (formerly Dorsey's 'Twitter'), has played a role in exacerbating tensions, with online comments reflecting regional stereotypes. However, it is crucial for Congress to focus on corrective measures rather than perpetuating divisive narratives ahead of the 2024 elections. The election results in five states saw the Congress securing more popular votes than the BJP, reminiscent of the 2016 US election dynamics between Hillary Clinton and Donald Trump. While Udayanidhi Stalin and Balaji Senthil contributed significantly to the DMK's success, the Congress must not overlook the potential harm caused by taking their support for granted. Some leaders within the INDI-Alliance suggest that the BJP's victories were confined to what they refer to as "Gaumutra states." It's essential to recognize that Ayurveda acknowledges the medicinal properties of 'gaumutra,' and 'gaumata' holds cultural significance across India. Speculation also arises about the Congress benefiting from a surge in Muslim votes, akin to what occurred in Karnataka. There is a concern that DMK politicians might be underestimating the Congress, as seen in statements by Udayanidhi Stalin and Priyank Kharge. While Rahul Gandhi's move to secure a Lok Sabha seat in the south has been compared to his grandmother Indira Gandhi, who similarly ventured south, it is essential to avoid making assumptions based on regional stereotypes.

The historical context of the north-south divide goes beyond recent events, with Maharashtra considering itself as much a part of the north as Uttar Pradesh. Dismissing entire states as 'gaumutra states' oversimplifies the complex dynamics that determine electoral outcomes. Balaji Senthil's remarks have become a contentious issue for Rahul Gandhi, who may need to address the controversy with a strategic approach. MK Stalin, Chief Minister of Tamil Nadu and DMK supremo, faces questions about the recent changes in perception regarding his candidacy for Prime Minister. The landscape has shifted since the time of his father, MK Karunanidhi, with the INDI-Alliance grappling with the challenge of projecting a unifying "PM's face." The north-south divide has become more pronounced, exacerbated by recent statements targeting the north. The DMK and similar parties now wield influence over the narrative of Hindutva, a departure from the traditional dominance of the Sangh Parivar. It is crucial for these parties to understand the evolving dynamics of Hindu sentiments in the north since 2014. The weakening of the Congress and the rise of the BJP have contributed to the evolving political landscape. The DMK's apparent lack of awareness regarding the extent of "Hindutvaisation" in the north raises concerns about their ability to connect with voters beyond their regional base. The Prime Minister is ultimately elected by a diverse range of states, and the INDI-Alliance must acknowledge this reality to secure success in the 2024 General



Congress has performed much better Israel and Hamas have different objectives in state polls compared to 2019

he outcome of the five Assembly India. For non-BJP forces to succeed in **■** proved almost all opinion polls and ground reports wrong. Even the few exit polls that predicted a thumping BJP victory in Madhya Pradesh gave the Congress a comfortable majority in neighbouring Chhattisgarh. The clean BJP sweep of Rajasthan, Madhya Pradesh and Chhattisgarh has therefore come as a major surprise after the BJP's recent losses in Himachal Pradesh and Karnataka and given the signs of a popular yearning for change in Madhya Pradesh after eighteen years of BJP rule and no such visible anti-incumbency against the Congress governments of Chhattisgarh and Rajasthan.

For the Congress, which was perceived to be on the ascendant after its Himachal and Karnataka victories, the only win has come in Telangana. The Telangana developments of course mark a significant change for this newly created state and also in the larger context of political balance in south India, but the Telangana victory of the Congress cannot but be overshadowed by the party's loss in the three big states in central and western India.

Before looking at the factors that led to this surprising outcome, let us take a closer look at the changes in vote share in Chhattisgarh, Madhya Pradesh and Rajasthan. It will appear that in terms of vote share, the Congress has not suffered any major decline - its vote share has decreased by 0.6% in Madhya Pradesh (41 to 40.4), 0.9% in Chhattisgarh (43.1 to 42.2) and even registered a very marginal increase of 0.2% in Rajasthan (39.3 to 39.5). What dramatically changed the outcome is a major increase in the BJP's vote share - by 7.45% in Madhya Pradesh (41.1 to 48.55), 13.27% in Chhattisgarh (33 to 46.27) and 2.9% in Rajasthan (38.8 to 41.7). On the face of it, the increase in the BJP's vote share has therefore happened not so much at the cost of the Congress as other non-BJP parties, but we clearly need to look beyond the figures at the actual social and electoral shifts on the ground.

Having suffered defeats in Himachal and Karnataka, the BJP was of course desperate to retain Madhya Pradesh and wrest Rajasthan and Chhattisgarh from the Congress. The elections witnessed brazen use of the ED all through the election period; double standards adopted by the EC in dealing with alleged violations of the model code of conduct and reported administrative manipulations at different levels and stages

cannot really be expected in today's of India's real producers. turn into a veritable people's movement full of energy, mass participation and meticulous booth-level mobilisation. The victorious Congress election campaigns in Karnataka and Telangana exhibited considerable mass dynamism and energy, but the campaigns in Madhya Pradesh, Chhattisgarh and even Rajasthan, the best fought among the three, lacked this dynamism and energy.

In Karnataka, the Congress had won by exposing the corruption and all-round failure of the incumbent BJP government led by Bommai. But learning from Karnataka, the BJP in Madhya Pradesh tried to defuse the anti-incumbency factor by fielding several ministers and MPs as MLA candidates even as CM Shivraj Singh Chouhan ran a hectic personalised campaign focusing on the flagship schemes of his government. To counter the appeal of the promises made by the Congress, the BJP made similar offers and termed them 'Modi's Guarantee'. The fusion of the Modi cult and the model of targeted direct transfer-based 'welfare economics' aimed at converting 'beneficiaries' into bonded voters seems to have once again worked as a complement to communal polarisation and aggressive Hindutva. The BJP had successfully applied this formula earlier this year in UP elections and now once again in Madhya Pradesh, Chhattisgarh and Rajasthan.

In the wake of its impressive Karnataka victory, the Congress centrally focused on two issues - the Adani-Modi nexus and caste census. For the Congress, which has never been a known votary of caste census and expanded reservation, the focus on OBC representation and caste census is a welcome new direction, but how far has the message percolated to the entire organisation and become an integral part of its political articulation? While the central leaders of Congress raised this issue, in Madhya Pradesh Kamal Nath was busy seeking the blessings of Hindu Rashtra champion Bageshwar Baba (Dhirendra Shastri). Similarly the issue of Adani-Modi nexus does not just represent institutionalized corruption, it represents the most brazen face of corporate aggression. The farmers' movement successfully challenged this arrogant corporate power and any effective political campaign against the Modi-Adani nexus will have to forge organic ties with the growing unity of farmers and workers for a reorientation of India's economic policy

Another major weakness of the Conthe complete absence of any will or plan to harness the potential of the INDIA alliance. On the contrary, we saw a totally unwarranted war of words between the Congress and Samaiwadi Party in Madhya Pradesh. In Telangana, the Congress has effectively channelised the accumulated anti-incumbency against the BRS government into a significant victory for the Congress, but we must remember that the BJP too has succeeded in doubling its vote share from 7% to 13.9% and the seat tally from the lone seat in the outgoing Assembly to eight seats. Any serious attempt at seat adjustment with the Left, SP, the newly formed Bhartiva Adivasi Party and at harnessing the INDIA potential in the campaign could have made significant differences in all states and even further improved the Congress tally in Telangana.

There has often been a North-South divide in India's electoral outcomes; most notably we had witnessed a sharp contrast in the post-Emergency 1977 election when the Congress was wiped out from North India even as it did fairly well in the southern states. The doors being shut on the BJP in the south certainly marks a major blow to the BJP's ambitions to dominate India for decades, but the decisive defeat of the party in 2024 will have to be shaped north of the Vindhyas. In Mizoram, the ZPM has swept the polls dislodging the NDA-affiliated MNF from power, but here too the BJP has increased its tally from 1 to 2 while the Congress tally has gone down from 5 to 1.

The concluding round of 2023 elections has certainly been a big moralebooster for the BJP, and the Modi regime has already started talking of scoring a 'hat trick' in 2024. This is nothing but psychological warfare. The fact is if the Assembly results in the four states of Madhya Pradesh, Chhattisgarh, Rajasthan and Telangana are seen in Lok Sabha terms, the Congress actually improves its tally from its 2019 strength of 6 to 28 and BJP tally actually goes down from 65 to 46. The Assembly elections have certainly not settled the outcome of 2024 in the BJP's favour and if we draw proper lessons it is still perfectly possible to dislodge the BJP from power in 2024. The onus is of course on INDIA to get its act together without any further delay and launch an energetic mass campaign on the burning issues of the day to galvanise the people towards a decisive victory in 2024. T srael has conflicting goals of neutraliz-▲ napped during the October 7 storming of its territory in a surprise - and vicious - attack after they broke through the heavily guarded perimeter fence, landing by sea and using paragliders, killing about 1,200 people and taking 240 hostage. In order to achieve both objectives, Israel opted to halt its military operation against Hamas in exchange for the release of some of those hostages. The truce is off now as Israel has started pounding Gaza localities saying Hamas did not honour the conditions.

There is a significant threat to Israel's 1 right to defend itself that needs to be considered. It is referred to as the 'terrorist veto'. And, as time goes by, Israel's chances of overcoming this threat is becoming increasingly slim, despite the resumption of hostilities on Friday. The term, 'terrorist veto', refers to the tactic employed by Hamas groups to hinder, or prevent, a country's ability to defend itself by exploiting international pressure and humanitarian concerns.

Many believe that the underlying purpose of these hostage negotiations as far as Hamas is concerned is to divert international attention and evoke strong emotions in order to indefinitely halt hostilities, restrict Israel's military actions and regroup to lick their wounds of war. Regardless of the label given to this pause - truce, ceasefire, or whatever term may apply - the strategic consequences undeniably favour Hamas By using innocent people as bargaining tools and using fellow Gazans for shielding themselves, Hamas seeks to prevent Israel from eliminating the terrorist threat it poses.

If Hamas manages to maintain a limited presence in Gaza and rebuild it to its pre-October 7 state, it can be considered a success for the group. However, this outcome essentially acts as a veto by them regardless of whether those in favour of the military pause try to downplay its significance. This result is labelled as a 'veto' since it enables terrorists to dictate terms and hinder progress towards a resolution.

"Regardless of whether those in favour of the military pause try to downplay its significance" implies that the military pause contradicts the goals of its supporters. This is evident in Hamas's success in surviving and rebuilding Gaza, which goes against the intended outcome of neutralizing the terrorist threat posed by Hamas through the temporary halt in military operations.

If the Hamas veto prevails, other groups like Hezbollah and the mullahs in Tehran (the main adversaries here) can shield themselves from the consequences of their terrorist acts. What is even worse is that this



veto could be adopted by nations with aggressive tendencies, leaving victims unable to defend their sovereignty and territorial integrity. Taiwan can be considered a potential victim in this new scenario.

about what to achieve during truce

US President Joe Biden and others claim they are not attempting to hinder further military action, but their policies are having precisely that impact. According to CNN on Wednesday last week, Biden's approach is based on three pillars: release of hostages, increase in aid to Gaza and planning for post-war scenarios. Notably, there is no mention of eliminating Hamas. Meanwhile, some Democratic senators are pushing for conditions on aid to Israel, aiming to limit its military operations - a stance Biden has supported.

The heads of major UN agencies have termed an "outrage" the cutting off of essential supplies to 2.2 million Palestinians and, time and again, called for a permanent ceasefire on humanitarian grounds. Following the October 7 attack, Israel had closed its border crossings with Gaza, blocking off food, water and medicine supplies from the territory. All fuel deliveries to the territory were cut off until late-November, arguing it could be stolen by Hamas and used for military purposes.

Regardless of the arguments supporting the extension of the initial or subsequent pauses, Israel could face three potential negative outcomes if it stops, or restricts its military campaign.

First, despite strong statements from many Israelis, both in and out of the government, the country's determination is waning. Right after October 7, Jerusalem may have been open to hearing US military advisers warn that pacifying resistance in Mosul and Fallujah - cities in Iraq that experienced significant resistance and conflict, particularly during the Iraq War - took between nine months and a year.

This would serve as a comparison or benchmark for the potential challenges that Israel may have faced in achieving its objectives. Initially, Israelis may have been ready for a prolonged struggle, but it seems unlikely after this initial pause. A decline in Israeli resolve makes it unlikely that Hamas will be completely eliminated.

Those supporting a ceasefire argue that, when Israel convinced a million Gazans to relocate south before their initial campaign, it set the stage for higher 'civilian' casualties in subsequent operations. While Hamas and Iran were responsible for placing Gazans in danger initially, unfair blame from the international community is likely to weigh on Israelis, weakening their determination.

Second, because Hamas, Iran and their allies stand to benefit more militarily from the pause than Israel, the human toll on the Israeli military will increase. This, in turn, may lead to growing domestic opposition against Prime Minister Benjamin Netanyahu's objectives. Quantifying the exact number of Israel Defense Forces casualties resulting from the pause might be challenging, but it could surpass the count of re-

leased hostages. And third, if there are more pauses or restrictions, it gives Hamas's allies around the world more time to pressure their governments to oppose Israel. As a result, many governments may push Israel to accept much less than what Netanyahu has stated as his goals. After the conflict, the White House is suggesting that the Palestinian Authority take control of Gaza. However, this overlooks the poor track record of the authority in the West Bank, where it has been ineffective, corrupt and secretly supportive of terrorism. Some sources even claim that Hamas is now more popular in the West Bank than in Gaza.

If Palestinian Authority control is extended. Israel could face the same threat that intensified on October 7. Israel Defence Force (IDF) views that every prolongation of the truce gives leeway to Hamas to consolidate in Gaza strip which Israel is not ready to allow. This contrast in the objective of the two contending groups is the main reason why the truce could not be prolonged. For bringing about any lasting solution, the present status on the objectives has to be changed. (IPA Service)

n 400 BC, Greek physician Hippocrates is said to have provided a list of things that should be considered during a proper medical evaluation. The list included the properties of local ground. Modern science recognises the distinct influence of soils on human health, but few studies have examined the connection outside Africa. In August 2023, researchers from the US and Australia published a study in the journal Scientific Reports, which for the first time conducts a large-scale evaluation of the relationship between the availability of micronutrients in the soil and nutritional status of people in India. Their findings hold clues for the country to not only improve soil health but also to address the long-standing challenge of malnutrition among children and

The researchers conducted a large-scale evaluation in which they analysed over 27 million soil tests, drawn from a nationwide government programme on soil health called Soil Health Card, and the health data of 0.3 million children and 1 million women from the National Family Health Survey (NFHS). The study focuses on two key minerals—zinc, which plays a role in the growth of cells, building proteins and supporting a healthy immune system, and iron, which is used by the body to make haemoglobin that carries oxygen from the lungs to all parts of the body.

The researchers found that districts where soil zinc availability was low had significantly higher rates of stunting (when a child has low height for their age) and underweight conditions (low weight per age). The zincstunting relationship was the strongest even in wealthier households. The researchers also found clear association between soil iron availability and anaemia.

At places where the availability of soil nutrients were satisfactory, they found a positive correlation with the height and haemoglobin levels of children and women. A one-standard deviation increase in soil zinc (equivalent to 24.3 per cent increase in the proportion of zinc tests) is associated with a reduction in stunting by 10.8 per 1,000 children and with a reduction in underweight conditions by 11.7 per 1,000 children, notes the study

Similarly, a one-standard decrease in women's heights. And. a one-standard deviation increase in iron (equivalent to a 26.8 per cent increase in the proportion of iron tests) is associ-

ated with 0.038 gram per decilitre (g/dl) increase in haemoglo-bin for children and 0.037 g/dl increase in haemoglobin for women, the report states.

The findings hold significance for India for two reasons. One, India is home to one-third of the 2 billion global population suffering from micronutrient deficiency. Though NFHS data shows a decline in child stunting between 2015-16 and 2019-21, the rate is still significantly high at 35 per cent among children under five years of age. In 161 districts, more than 40 per cent children under five years of age suffer from stunting.

Scientific Reports, August 21, 2023Two, micronutrient deficiency in Indian soils has increased at a rapid scale in recent decades. "Initially, the country's soil was more deficient in nitrogen and phosphorous. It then developed potassium-deficiency, followed by sulphur-deficiency in the 1990s and 2000s. Now our soils are greatly deficient in zinc and other micronutrients," says Arvind Shukla, who led the All India Co-ordinated Research Project on Micro- and Secondary Nutrients and Pollutant Elements in Soils and Plants (AICRP-MSPE) under the Indian Council of Agricultural Research from 2011 to 2022.


The project was launched in 1967 to analyse micronutrient deficiency in soil across the country. An analysis of 0.2 million soil samples from 28 states by scientists associated with AICRP-MSPE shows that 36.5 per cent of the country's soil is deficient in zinc and 12.8 per cent is deficient in iron.

Other micronutrients like boron is deficient in 23.4 per cent of soils, copper in 4.20 per cent and manganese in 7.10 per cent of soils. Since 2014, the project has shifted focus to analysing the link between soil health and human health.

"Factors like women's nutrition and household wealth hold more importance when we look at child or adolescent stunting, and rightly so. But there is a need to simultaneously work on establishing a clear understanding of how soil health affects human health," Leah Bevis, associate professor at the Departof Agricultural, Environmental and Developmental Economics, Ohio State University, US, tells Down To Earth. Bevis is also co-author of the Scientific Reports study.

Biodiversity International Center for Tropical Agriculture, US, conducted a study in Nepal's Terai region, and found that a 1 ppm (parts per million) increase in soil zinc availability seems to increase child height by 7.5-25 per cent of a standard deviation, and decreases child stunting by 2-7.5 per cent.

In 2014, the AICRP-MSPE scientists also conducted a laboratory experiment in which they fed rats with zinc-biofortified wheat (cultivated using foliar application of zinc) produced on zinc-deficient soil. They found that rats fed low-zinc wheat had low zinc in their blood serum as compared to the rats fed highzinc wheat. In 2016, AICRP-MSPE along with doctors from the All India Institute of Medical Sciences (AIIMS), Bhopal, carried out a study in Samnapur, a tribal village in Madhya Pradesh's Mandla district.

Some 15 families with teenagers were selected for biometric observations. For three years, the researchers surveyed the families for dietary recall, animal food intake, access to the food and fodder through external sources and use of inputs, especially zinc fertilisers, in their agricultural fields. Their blood samples were collected and analysed. "Analysis of zinc content in soil, grain, straw-feed, animal and human blood serum established a strong correlation and interdependence among the soil-plant- animal-human continuum," says Shukla.

A research, published in the journal Applied Geochemistry in March 2000, also analysed the impact of selenium concentrations in soil on human health. It studied the distribution of selenium in samples of soil, grain and human hair collected from the Keshan disease belt of Hebei Province, China, and found that villages with highest incidence of Keshan disease had the lowest selenium concentration in

Economic, effective

Though limited, study results indicate that it is possible to address malnutrition and micronutrient deficiency among people by improving soil health. This can also be an economic and effective way of addressing malnutrition in the country.

Consider this. In August 2022, the Union government approved rice in all government food schemes and entitlements under the National Food Security Act 2013. Since then, iron-fortified rice is being supplied as a pilot programme in 15 states.

However, food and agriculture experts have time and again highlighted concerns regarding the indiscriminate distribution of fortified rice to even those suffering from thalassemia and sickle cell disease.

Food Safety and Standards Authority of India's statutory regulations have warned patients with thalassemia and sickle cell anaemia against consuming iron-fortified food or using it only under strict medical supervision. Such concerns can be avoided by improving soil micronutrient availability.

The Scientific Reports study from August 2023 states that foliar and soil application of minerals like zinc, iron, boron and sulphur to wheat and rice has also been shown to increase crop yields. In India, application of zinc to crops on zinc-deficient soils increases yields of rice, wheat, maize, and oats by over 75 per cent more than application of only nitrogen, phosphorus, and potassium fertiliser. Zinc-enriched fertilisers can enhance soil zinc for three to four years after application, which means that it could be an effective long-term intervention, reless quiring short-term maintenance than other solu-

The study, however, calls for more studies to consider the costs of such an intervention and the human nutrition impacts of agronomic fortification. Shukla savs doctors often prescribe zinc tablets or multi-vitamins or minerals for different health issues. One should compare spending on such multi-vitamins with the expenses involved in making the soil healthy. Both Shukla and Bevis call

for government initiated experimental research on a large scale in which zinc-enriched fertilisers or foliar application of zinc are promoted during sowing and then zinc levels in the blood are compared with a control group. "Research done by us and other scientists is the first step and an effective entry point for the government ernments to conduct their own experiments and develop policies," says Bevis. (Courtesy:

Empowering forests: A blueprint for sustainable restoration & climate resilience

estoration of forest landscapes is becoming more widely acknowledged as an essential method of storing carbon in the atmosphere, protecting biodiversity, and fostering co-benefits for indigenous people regarding

A recent research appeared in the scientific journal Nature Climate Change entitled Community Forest Governance and Synergies among Carbon, Biodiversity and Livelihoods, exmined 314 forest commons in 15 tropical African, Asian, and Latin American countries and provided insight into the complex interactions that exist between carbon sequestration, species diversity of trees, and forest livelihoods.

The results indicate that formal community management associations and their local engagement in rule-making and empowered local forest governance are reliable predictors of favourable outcomes in various contexts.

The findings of this research have special relevance for India, a nation with a wide variety of ecosystems and a sizeable rural populace that depends on forests for subsistence. A global focus on nature-based solutions has resulted from the urgency of addressing climate change and biodiversity

Rural tropical landscapes are frequently the focus of these solutions because of their rich biodiversity and potential for sequestering carbon. But these landscapes also support a significant human presence; some 1.8 billion people live in places important for achieving global biodiversity goals. Harmonising forest goals: A holistic perspective

The research emphasises how important it is to comprehend the interconnected systems of rural livelihoods, biodiversity protection, and carbon sequestration. It asks for a comprehensive strategy that considers the advantages and disadvantages of each of these goals to guide successful interventions for multifunctional tropical forests. Examining the connections between contributions to regional livelihoods, biomass as a stand-in for carbon storage, and species richness of trees highlights the significance of this viewpoint.

Three important variables significantly predict forest outcomes: formal inclusion, involvement, and tree plantations.

Formal inclusion and local engagement in regulation are essential components of forest governance to ensure the effectiveness of restoration efforts. On the other hand, the research raises concerns about the prevalent focus on planting trees as the main strategy for restoring forests, pointing out the possible negative effects of this method on society and

Sustainable forest governance: A path for India's fu-

In India, where a significant proportion of the populace depends on forest resources for fundamental livelihood advantages, the results emphasise the necessity of transcending oversimplified notions of mutually beneficial outcomes. According to the research, having effective governance is essential to getting many benefits from forests. Establishing formal community forest management organisations and local participation in rule-making as indicators of empowered local governance is emerging as a critical success factor for attaining positive effects for carbon, biodiversity, and rural livelihoods concurrently. The research's conclusions are consistent with the inter-

national demand that indigenous peoples and local communities be given equal rights and be included in efforts to mitigate climate change and restore the environment. It highlights how crucial it is to have formalised local forest institutions, with local management authority legally recognised and significant local influence over decision-making. The research questions accepted ideas about stakeholder participation and promoted stronger, more capable local institutions with the long-term capacity to catalyse socio-ecological ad-As India struggles with climate change and biodiversity

loss, a key element of forest policy interventions should be promoting empowered local governance. In human-dominated settings, where it is impossible to ignore the requirements of rural inhabitants, it is critical to acknowledge the multifunctional nature of forests. Forest commons, when well managed by rural and indigenous people can substan-

tially contribute to various environmental and human objectives. As a result, the research offers insightful information about the structure of Indian forest policy, highlighting the significance of governance conditions for attaining sustainable results. India can concurrently address climate change, biodiversity protection, and the welfare of rural communities while maximising the benefits of its forest restoration operations by prioritising the official acknowledgement of local management authority and fostering meaningful local en-

Local governance for sustainable forest restoration and climate resilience

The research highlights four main policy proposals that can be deciphered for India's forest management as outlined

1. Formalized Local Governance for Holistic Forest Management: The research emphasises how important formal community forest management groups are in predicting successful outcomes in forest restoration and how important local participation in rulemaking is. The official state recognition of local management authority should be India's top priority to implement this strategy. Implementing well-defined legal frameworks that enable indigenous groups to oversee and decide on managing forest resources will guarantee a more efficient and long-lasting restoration strategy. This entails establishing open channels for national technical assistance, guaranteeing local autonomy, and putting clear guidelines for choosing and dismissing local officials in place. By formalising local governance, India may promote socio-ecological benefits such as carbon sequestration, biodiversity conservation, and rural livelihoods.

2. Rethinking the Emphasis on Tree Planting: The research questions the widespread belief that planting trees is the primary strategy for restoring forests worldwide. This necessitates a careful strategy for India, considering the environmental and social hazards connected to extensive tree plantations. Planting trees may help reduce carbon emissions, but the policy should prioritise local forest users' needs and response behaviours. This entails concentrating on the social and environmental effects rather than just meeting quantifiable goals for the number of trees planted. India should carefully consider the context-specific effects of tree plantations to ensure they complement the area's biological circumstances and support sustainable and subsistence forests instead of having a detrimental effect on carbon sequestration and conservation forests.

3. Building Durable and Empowered Local Institutions: The research emphasises the necessity for strong and independent local institutions and pushes for going beyond project-based participatory forums and organised stakeholder meetings. India ought to allocate resources towards institutional reforms that facilitate efficient management of local resources, considering the distinct socio-ecological dynamics of various areas. This entails identifying and formalising different local forest organisations to guarantee that communities have a meaningful say in managing forests. India should prioritise the creation of favourable conditions through empowered local institutions to achieve just climate action and other forest restoration goals. In the long run, this will advance several benefits for humans and the environment. 4. Climate-Resilient Policies: A Pillar of Sustainable

Transformation: The research emphasises how important it is to implement climate-resilient methods and recognise the critical role of forests in reducing climate change. Through smoothly incorporating climate considerations into restoration programs, India can fortify its landscapes against the harmful consequences of climate change. This proactive strategy fosters resilience in nearby communities while guaranteeing ecosystems' sustainability. Adopting climate-resilient policies is a crucial first step to sustainable transformation in India. It provides a comprehensive and well-thought-out solution to the interrelated problems of declining biodiversity, rural livelihoods, and the growing dangers of climate change. Why safe roads are good for the environment

The impact of road safety goes far beyond its direct effect on preserving life and limb. In addition to ensuring an easier, comfortable and more secure commute, safer roads also have a tremendous positive impact on the envi-In 2021, India reported 4,03,116 crashes, each

of which may have affected the environment to different degrees and in various ways. Most vehicles contain toxic metals such as lead, mercury, cadmium or hexavalent chromium, which are highly detrimental for the environment. One of the first things witnessed at any road

crash site is fuel and fluid leaks that emit harmful chemicals leading to air, water and soil pollution. The massive number of road crashes registered in India, year after year, have a significant negative effect on the environment. Severe road crashes also lead to automobile

wreckages that become a part of the unusable end-of-life vehicles, giving rise to scrappage. India is estimated to have about 22.5 million endof-life vehicles by 2025. Despite being one of the largest car and light commercial vehicle markets in the world, India's National Automobile Scrappage Policy, launched in August 2021, is still in its nascent stages.

With the absence of widespread, systematic facilities dedicated to proper recycling, abandoned road crash vehicles and old end-of-life automobiles left to rot by the wayside are a common sight across cities.

Some of them end up at landfills or informal recycling facilities where rudimentary hand tools are used to unscientifically dismantle them, leading to the leakage of hazardous constituents such as oils, coolants, glass wool and more. Vehicle landfills turn into automobile graveyards, a wasteful and sub-optimal use of land that also causes prolonged water and soil pollution stretching over decades.

Road safety and environmental sustainability are intertwined. Being cognisant of the latter while working on the former is the need of the hour, along with action geared towards long-term environmental preservation and sustenance.

One of the biggest causes of road crashes is speeding. In 2020 alone, speeding was responsible for 91,239 road crash fatalities, comprising 69.3% of all such deaths registered. Speeding has consistently been responsible for over 60% of all

road crash fatalities in India during the past five

Simulation exercises conducted in Europe have demonstrated that cutting motorway speed limits even by 10 km/hour can deliver 12%-18% fuel savings for current passenger cars, along with a significant reduction in pollutant emissions, particularly NOx and particulate matter (PM) output from diesel vehicles.

A similar study conducted in Amsterdam showed that where the speed limit was lowered from 100 kmph to 80 kmph, particulate matter reduced by up to 15% significantly improving air quality. Studies also show that 96.5 kmph of highway speed limits are 25% more efficient than 120 kmph, in which case wind resistance leads to more fuel consumption.

Consequently, several governments globally have reduced speed limits to prevent crashes and lower air pollution. For instance, the Wales government brought in 80 kmph speed limits at five locations to reduce outdoor pollution and improve public health. In India, the "Zero-Fatality Corridor" solution for road safety by the SaveLIFE Foundation, of which this author is a part of, focuses on reducing speeding through engineering and enforcement technologies.

Vegetation on or very close to the road stretches often falls prey to road widening initiatives. On the Mumbai-Pune Expressway and the Old Mumbai-Pune Highway, or National Highway 48, the Zero-Fatality Corridor programme has helped bring down road crash fatalities by 52% and 61%,

The recommendations have been environmentfriendly and include guarding natural hard structures like trees using crash barriers to prevent direct collisions, and installing retro reflective signage on the trees to make them more visible. The Union government, too, is now building green corridors to go over forests and animal paths instead of through them. Scaling the same will have a profound impact on preserving the environment while ensuring better road connectiv-

Roads and the environment are shared, democratic spaces that are also our joint responsibility. Safer roads and a sustainable environment can be ensured only through the joint efforts of road managing agencies, enforcement officials as well as the public. Each effort in this direction, no matter how small, can save lives through safer roads and a better environment. (Courtesy: Scroll.in)

New Zealand's quest to save its rotund, flightless parrots

ākāpō are avid walkers, wandering on strong legs for miles at a time and hiking up mountains to find mates. They're keen climbers too, clambering up New Zealand's 65-foot-high rimu trees on large claws to forage for red berries on the tips of the conifer's branches

But there's one thing that the world's heaviest parrot species can't do: fly. With their bulky frames — males weigh up to nine pounds — and waddling gait, they have little chance of outrunning predators like stoats and feral cats. When threatened, the nocturnal parrots freeze, relying on their moss-green feathers to act as camouflage.

New Zealand was once a land of flightless birds like the extinct moa — no terrestrial mammalian predators in sight. That changed in the 13th century, when Māori voyagers brought rats and dogs, and again in the 19th century, when European settlers brought more rats, cats and mustelids like weasels. stoats and ferrets. These predators have played a major role in putting at risk some 300 native species on New Zealand's two main islands and smaller offshore islands, taking an especially heavy toll on flightless birds like kākāpō.

Now listed as critically endangered, the kākāpō teetered on the edge of extinction in the mid-1900s due to hunting, predators and land clearance. From the 1970s, conservation efforts focused on managing the remaining kākāpō on the country's offshore islands, where predators are systematically eradicated. Due to those ongoing efforts, which include breeding programs, veterinary treatment and supplementary food, parrot numbers have grown from fewer than 60 in 1995 to more than 200 today.

That success, plus lack of space in offshore islands, led New Zealand's Department of Conservation and Ngāi Tahu, the Māori tribe whose people serve as traditional guardians of the kākāpō, to find a new habitat for the parrots. Starting in July 2023. relocations began to the 8,400-acre Sanctuary Mountain Maungatautari, a predator-



free haven enclosed by one of the world's longest pest-proof fences.

So far, 10 male parrots have moved to the reserve — the first time the species is living back on the mainland in almost half a century. Researchers are tracking their locations and conducting regular health checkups to assess whether the birds can thrive there.

If male parrots start hiking to the ridgetops, serenading female kākāpō with deep "booms" and high-pitched "chings," they might be in shape to breed, says conservation biologist Andrew Digby, science advisor for kākāpō at the Department of Conservation. "We might start looking at bringing females in.'

Kākāpō have much lower fertility than other parrots. Since the 1980s, fewer than half their eggs have hatched, which is thought to be partly due to inbreeding. Left to their own devices, they breed only when rimi trees bear masses of fruit, every two to four years, with females laying one to four

Recently, researchers have started to explore how genomic data can contribute to kākāpō survival. Such studies can help wildlife managers boost genetic diversity and resilience in threatened species, says evolutionary biologist Cynthia Steiner of the San Diego Zoo Wildlife Alliance.

In one important study published in 2023, researchers analysed whole-genome sequence data for 169 parrots — nearly all of

those living when the research began in 2018. That work yielded crucial insights, including genetic variations affecting aspects of kākāpō chick development, like height and growth rate. This could help scientists predict how quickly baby birds will grow, and initiate veterinary interventions should the growth rates deviate, says Joseph Guhlin, a genomicist with Genomics Aotearoa at the University of Otago in Dunedin, New Zealand

Scientists also found that some kākāpō have genetic resistance to aspergillosis, a fungal respiratory disease. In 2019, an outbreak affected 21 birds and killed nine. If another outbreak occurs, vulnerable parrots could be isolated and treated ahead of time, Guhlin says.

As of October 2023, all parrots in the sanctuary were doing well, although the first four arrivals lost a bit of weight. Thanks to GPS trackers attached to each bird, "we can see that they've been bouncing around all over the place," Digby says. But the survival of kākāpō beyond fenced-in sanctuaries depends on the success of Predator Free 2050, an ambitious initiative to eradicate some of the introduced predators most harmful to New Zealand's native wildlife by 2050.

"Eradications are a high-cost, high-risk, high-reward strategy," says ecologist Stephen Hartley of Te Herenga Waka-Victoria University of Wellington. Hartley thinks it may be possible to get rid of possums, because they breed slowly and are easy to detect, but that rats and mustelids will be nearly impossible to eliminate without introducing some form of genetic or biological control, such as gene editing or introducing a parasite to prevent them from

reproducing If all goes as planned, people across New Zealand may one day be able to see and hear the parrots from their own backyards. For now, they can traipse through the forest sanctuary the parrots now call home. "Transferring them to Maungatautari is a good first step," Digby says. "It brings kākāpō back to where people are." Under Putin, the uber-wealthy Russians known as 'oligarchs' are still rich but far less powerful

TALLINN, Dec 6: When Vladimir Putin came to power in 2000, the outside world viewed those Russians known as "oligarchs" as men who whose vast wealth, ruthlessly amassed, made them almost shadow rulers. A "government of the few," in the word's etymology.

The term has persisted well into Putin's rule, broadening in popular usage to refer to almost any Russian with a substantial fortune.

How much political power any of Russia's uber-rich now wield,

however, is doubtful. A few hours after Putin sent troops into Ukraine in February 2022, a televised meeting he held in the Kremlin with top industrialists and entrepreneurs showed how the dynamics had changed: Putin

but to invade. Despite the harsh consequences to their wealth that the tycoons could expect from the war, they had to accept it; the power was his, not theirs.

After the collapse of the Soviet

Union, astute businessmen who

had already begun building operations as government controls loosened under Mikhail Gorbachev's "perestroika" reform policies took advantage of the privatizing of state industries to quickly establish vast holdings.Fast-talking mathematician Boris Berezovsky epitomized the breed, becoming the largest dealer for Russia's largest automaker and managing to buy the vehicles at a loss to the manufacturer. He took over the management of the Sibneft oil company,



gained control of Russia's biggest TV channel, then known as ORT. Somewhat less-colorful than Berezovsky but still prominent figures from the era included media mogul Vladimir Gusinsky, whose NTV channel made him highly influential, and oil tycoons Mikhail Khodorkovsky and Roman

Upon taking office, Putin was well aware of the widespread resentment ordinary Russians felt for the ultra-wealthy who thrived while millions struggled through the economic changes. In the summer of 2000, Putin met in the Kremlin with about two dozen of the men regarded as the top oligarchs. The meeting was closed,

but reports later said he made them a sternly clear deal: Stay out of politics and your wealth won't be

"The guarantee ... was that all the riches amassed before his presidency could be kept by their owners, and this has never changed." Carnegie Endowment for International Peace analyst Alexandra Prokopenko wrote in a commentary this year. "Loyalty is what Putin values above all else."

By then, Berezovsky had already begun criticizing Putin. Within months, he left Russia for the United Kingdom and was granted asylum in 2003. Ten years later, he was found dead in his home; a disputed post-mortem examination said he appeared to have hanged himself. Gusinsky, whose media

holdings were critical of Putin and even satirized him, was hauled into jail amid an investigation of misappropriated funds; within weeks, he agreed to sell his holdings to an arm of Russia's state natural gas monopoly, and he left the country.

Khodorkovsky, regarded as Russia's richest man at the time, lasted longer, establishing the Open Society reformist group and showing increased political ambitions. But he was arrested in 2003 when Special Forces stormed onto his private plane and spent a decade in prison on convictions of tax evasion and embezzlement before Putin pardoned him and he left Russia.

Putin tolerated the 2012 presidential run against him by Mikhail Prokhorov, who made a fortune in metals, but the bid was widely seen

as a Kremlin-supported red herring aimed at creating the impression of genuine political pluralism in Russia. Despite the blows to their assets as a result of the Ukraine war, most of Russia's ultra-wealthy have stayed quiet about the conflict or offered only mild, token criticism.

Banking and brewing entrepreneur Oleg Tinkov was a rare exception, denouncing the war and calling its supporters "morons." He left the country in late 2022 and later renounced his citizenship.

Mikhail Fridman, a co-founder of Russia's largest private bank, called the war a tragedy and for the "bloodshed" to end. He holds Israeli citizenship and had lived in Britain, but reportedly returned to Moscow after fighting between Is-

At least 85 civilians killed by a Nigerian army drone attack, in Heavy fighting across Gaza halts most aid delivery, the latest such deadly mistake



ABUJA, Dec 6: At least 85 civilians were killed when an army drone attack erroneously targeted a religious gathering in northwest Nigeria, officials confirmed on Tuesday, as the president ordered an investigation into the latest in a series of such deadly mistakes in Nigeria's conflict zones.

The strike took place Sunday night in Kaduna state's Tudun Biri village while residents observed the Muslim holiday marking the birthday of the Prophet Muhammad, government officials said. The military believed it was "targeting terrorists and bandits," officials said.

At least 66 people also were injured in the attack, the National Emergency Management Agency said in a statement. Eighty-five bodies, including of children, women and the elderly, have been buried so far, as a search continues for any additional victims, the

Nigeria's army chief, Lt. Gen. Taoreed Lagbaja, apologized for the drone strike during a visit to the village Tuesday and said it had been carried out "based on the observation of some tactics usually employed by bandits.

"Unfortunately, the reports we got revealed it was innocent civilians that the drone conducted a strike on," Lagbaja said.

Since 2017, some 400 civilians have been killed by airstrikes that the military said were targeting armed groups in the deadly security crisis in the country's north, according to the Lagos-based SBM Intelligence security firm.

'The incidence of miscalculated airstrikes is assuming a worrisome dimension in the country," said Atiku Abubakar, Nigeria's former vice-president and the main opposition presidential candidate in this year's election.

Nigerian President Bola Tinubu ordered "a thorough and fullfledged investigation into the inci-However,

are often shrouded in secrecy.

Nigeria's military often conducts air raids as it fights the extremist violence and rebel attacks that have destabilized Nigeria's north for more than a decade, often leaving civilian casualties in its wake, including in January when dozens were killed in Nasarawa state and in December 2022 when dozens also died in Zamfara state.

Maj. Gen. Edward Buba, a spokesman for Nigeria's Defense Headquarters, said in a statement Tuesday that terror suspects often "deliberately embed themselves within civilian population centers," though he wasn't speaking specifically about Sunday's holiday gathering.

Analysts have in the past raised concerns about the lack of collaboration among Nigerian security agencies as well as the absence of due diligence in some of their special operations in conflict zones.

One major concern has been the proliferation of drones within Nigerian security agencies such that "there is no guiding principle one when these can be used," according to Kabir Adamu, the founder of Beacon Consulting, a security firm based in Nigeria's capital, Abuja.

"The military sees itself as a little bit over and above civilian accountability as it were," Adamu

In the incident in Nasarawa in January, when 39 people were killed, the Nigerian air force "provided little information and no justice" over the incident, Human Rights Watch said.

Such incidents are enabled by a lack of punishment for erring officers or agencies, according to Isa Sanusi, Amnesty International's director in Nigeria.

"The Nigerian military is taking lightly the lack of consequences ... and the civilians they are supposed to protect are the ones paying the price of their incompetence and lack of due diligence," Sanusi told The Associated Press. (AP)

The aid group Doctors Without Borders said fuel and medical supplies have reached "critically low levels" at the Al-Aqsa Martyrs Hospital in the central town of Deir al-Balah, north of Khan Younis. Up to 200 wounded people have been brought in every day since Dec. 1, when a weeklong truce expired, it

"Without electricity, ventilators would cease to function, blood donations would have to stop, the sterilization of surgical instruments would be impossible," said Marie-Aure Perreaut Revial, the aid group's emergency coordinator in Gaza. She said the hospital is also running desperately low on broken bones together. Gaza has been without electricity since early October, and Israel has severely limited fuel imports, forcing several hospitals to shut down because they cannot operate emergency generators.

The war has killed more than 16,200 people in Gaza — 70% of them women and children — and wounded more than 42,000, according to the territory's Health Ministry, which released new figures late Tuesday. The ministry does not differentiate between civilian and combatant deaths, but its overall tally tracks with a figure released by the Israeli military this week. The ministry says hundreds more have been killed since the ceasefire ended Friday, and many still are trapped under rubble. The military accuses Hamas of using civilians as human shields when the militants operate in residential areas. But Israel has not given detailed accounts of individual strikes, some of which have leveled entire city blocks.

Military Chief of Staff Herzi Halevi said militants keep weapons in homes and other buildings so fighters in civilian clothes can use them to fire on troops.

"Striking them requires significant use of fire, both to target the enemy but also to, of course, protect our forces," he said Tuesday. Israel says it must remove Hamas from power to prevent a repeat of the Oct. 7 attack, 1,200 people, mostly civilians, and took captive some 240 men, women and children after bursting through Israel's vaunted defenses. More than 100 hostages were released during last week's cease-fire, along with 240 Palestinians imprisoned by Israel.

Family members of hostages held a tense meeting with Netanyahu and the war cabinet Tuesday in which some of them shouted at cabinet members, accusing them of having no plan to bring back the rest.

Five of the released hostages shared details of their experience during the meeting. One spoke of Hamas fighters "touching" female hostages, and another said militants shaved off a male hostage's body hair to humiliate him, according to a group representing the families. A doctor who treated some of the 110 released hostages told The Associated Press separately that at least 10 women and men were sexually assaulted or abused, without providing further details, adding to widespread allegations of rape and other atrocities committed during Hamas' Oct. 7 attack.

Toshakhana corruption case: Pak court rejects Imran Khan's plea to withdraw Arabia and UAE, host of COP28 climate talks appeal against disqualification

ISLAMABAD, Dec 6: A Pakistani high court on Wednesday rejected jailed former Prime Minister Imran Khan's plea seeking the withdrawal of his appeal against his disqualification in the Toshakhana

corruption case Khan, 71, has been in jail since August 5, when he was arrested after a conviction in the Toshakhana case. He was disqualified by the Election Commission of Pakistan (ECP) in the case for failing to disclose the proceeds from the sale of gifts he got from the Toshakhana (state repository).

The Pakistan Tehreek-e-Insaf (PIT) party leader approached the Islamabad High Court Chief (IHC) against the electoral body's decision, contending that he had purchased the assets legally; hence, there was no reason for him not to mention the gifts in his assets statement. However, on January 18, the PTI filed a fresh plea in the IHC to withdraw the petition, saying the cricketer-turned-politician wanted the Lahore High Court (LHC) to hear the matter. A separate petition had been filed in the LHC against

Khan's disqualification. IHC Chief Justice Aamer Farooq on Wednesday announced the verdict which was reserved on September 13, rejecting Khan's request to withdraw his petition against disqualification in the case. According to The News International newspaper, the court will announce its reserved judgment later on Wednesday.

On Tuesday, the ECP reserved its verdict on a petition seeking to remove the former premier as the head of the PTI party due to his conviction in the Toshakhana corruption case. In November last year, the ECP found Khan guilty of not submitting accurate details of the gifts he got from the Toshakhana and disqualified him from public office. Later, he was convicted in the same case.

Khan is currently jailed at the high-security Adiala prison in Rawalpindi since September 26 in the cipher case for allegedly leaking state secrets and violating the

DUBAI, Dec 6: Russian President Vladimir Putin on Wednesday will visit both Saudi Arabia and the United Arab Emirates as Dubai hosts the United Nations' COP28 climate talks — despite facing an arrest warrant from the International Criminal Court over the war in Ukraine.

Neither Saudi Arabia nor the UAE has signed the ICC founding treaty, meaning they don't face any obligation to detain Putin over the warrant accusing him of being personally responsible for the abductions of children from Ukraine during his war on the country.

However, the visit comes as armed UN police patrol a portion of Dubai's Expo City now considered international territory for the talks, again highlighting the Emi-

rates' expansive business ties to Russia that have exploded in the time since grinding Western sanctions have targeted Moscow.

Russian Prez Vladimir Putin to visit Saudi

A readout on Putin's trip from the state-run Tass news agency published early Wednesday offered no suggestion Putin might come to the COP28 site, instead quoting Russian presidential aide Ŷury Ushakov saying he'd land and have a "meeting at the palace" and one-on-one talks with Emirati leader Sheikh Mohammed bin Zayed Al Nahyan.

The visit comes after COP28 saw a parade of Western leaders including US Vice President Kamala Harris, French President Emmanuel Macron, British Prime Minister Rishi Sunak and others backing Ukraine speak at the summit. So did Belarusian President Aleksandr Lukashenko, long a

Taliban's abusive education policies harm boys as well as girls in Afghanistan, rights group says

ISLAMABAD, Dec 6: The Taliban's "abusive" educational policies are harming boys as well as girls in Afghanistan, according to a Human Rights Watch report published on Wednesday.

The Taliban have been globally condemned for banning girls and women from secondary school and university, but the rights group says there has been less attention to the deep harm inflicted on boys' educa-The departure of qualified teach-

ers including women, regressive curriculum changes and the increase in corporal punishment have led to greater fear of going to school and falling attendance.

Because the Taliban have dismissed all female teachers from boys' schools, many boys are taught by unqualified people or sit in classrooms with no teachers at all.

Boys and parents told the rights group about a spike in the use of corporal punishment, including officials beating boys before the whole school for haircut or clothing infractions or for having a mobile phone. The group interviewed 22 boys along with five parents in Kabul, Balkh, Herat, Bamiyan and other communities in eight provinces

The Taliban have eliminated subjects like art, sports, English and civic education.

"The Taliban are causing irreversible damage to the Afghan education system for boys as well as girls," said Sahar Fetrat, who wrote the report. "By harming the whole school system in the country, they risk creating a lost generation deprived of a quality education."

Students told Human Rights Watch that there are hours during the school day when there are no lessons because there is a lack of replacement teachers. So they said they do nothing.

Taliban government spokesmen were not available for comment on the report. The Taliban are prioritizing Islamic knowledge over basic literacy and numeracy with their shift toward madrassas, or religious schools.

The Taliban have barred women from most areas of public life and work and stopped girls from going to school beyond the sixth grade as part of harsh measures they imposed after taking power in 2021. According to the U.N. children's

agency, more than 1 million girls are affected by the ban, though it estimates 5 million were out of school before the Taliban takeover due to a lack of facilities and other reasons.

The ban remains the Taliban's biggest obstacle to gaining recognition as the legitimate rulers of Afghanistan. But they have defied the backlash and gone further, excluding women and girls from higher education, public spaces like parks and most jobs.

The new report suggests that concerned governments and U.N. agencies should urge the Taliban to end their discriminatory ban on girls' and women's education and to stop violating boys' rights to safe and quality education. That includes by rehiring all women teachers, reforming the curriculum in line with international human rights standards and ending corporal punish-

"The Taliban's impact on the education system is harming children today and will haunt Afghanistan's future," Fetrat said. "An immediate and effective international response is desperately needed to address Afghanistan's education crisis.'

November was nearly a third of a degree Celsius (0.57 degrees Fahrenheit) hotter than the previous hottest November, the European Space Agency's Copernicus Climate Change Service announced early Wednesday. November was 1.75 degrees Celsius (3.15 degrees Fahrenheit) warmer than pre-industrial times, tying October and behind September, for the hottest above average for any month, the scientists said.

"The last half year has truly been shocking," said Copernicus Deputy Director Samantha Burgess. "Scientists are running out of adjectives to describe this.'

November averaged 14.22 degrees Celsius (57.6 degrees Fahrenheit), which is 0.85 degrees Celsius (1.5 degrees

Scientists say November is 6th straight month

pre-industrial times. The northern autumn is also the hottest fall the world has had on record, Copernicus calculated. Copernicus records go back to 1940. United States government calculated records go back to 1850. Scientists using proxies such as ice cores, tree rings and corals have said this is the warmest decade Earth has seen in about 125,000 years, dating back before human civilization. And the last several months have been the hottest of the last decade.

Scientists say there are two driving forces behind the six straight record hottest months in a row. One is human-caused climate change from the burning of coal, oil and gas. That's like an escalator. But the natural El Nino-La Nina cycle is like jumping up or down on that escalator. The world is in a potent El

Nino, which is a temporary warming of parts of the central Pacific that changes weather worldwide, and that adds to global temperatures already spiked by climate change. It's only going to get warmer as

long as the world keeps pouring greenhouse gases into the atmosphere, Burgess said. And she said that means "catastrophic floods, fires, heat waves, droughts will continue.

"2023 is very likely to be a cool year in the future unless we do something about our dependence on fossil fuels," Burgess said.

Mizoram registers third lowest murder cases in country: NCRB data

AIZAWL, Dec 6: Mizoram registered the third lowest murder cases in the country last year, according to National Crime Records Bureau (NCRB) data.

The northeastern state recorded 31 murder cases in 2022, after Sikkim (9) and Nagaland (21).

The murder rate in the state was 2.5, while the chargesheet filing rate stood at 95.7, the NCBR data said. There were 14 blind murders or murders with no motive known and six murders due to dispute.

The state reported 28 murder cases in 2020 and 24 in 2021.

A total of 28,522 FIRs of murder were registered in 2022 across the country, the NCRB data said.

Uttar Pradesh saw the highest number of such FIRs at 3,491 followed by Bihar (2,930) and Maharashtra (2,295). (PTI)



He highlighted Meghalaya's geographical proximity to the notorious Golden Triangle, a region known for the production and trafficking of opium and heroin, making the state particularly vulnerable.

While addressing the gathering, state social welfare minister Paul Lyngdoh stated that the government had been actively pursuing the DREAM Mission together with the social welfare department and other line departments. NEW DELHI, Dec 6: More than 1.500 cases were registered under IPC section 153A that penalises promoting enmity between different groups, including offences of hate speech, across India in 2022, a 31.25 per cent increase from 2021 but a 15.57 per cent decline from 2020, according to the NCRB.

Last year, the maximum of these 1,523 cases were lodged in Uttar Pradesh (217) followed by Rajasthan (191), Maharashtra (178), Tamil Nadu (146), Telangana (119), Andhra Pradesh (109), and Madhya Pradesh (108), the data showed.

The National Crime Records Bureau (NCRB), which functions under the Union Ministry of Home Affairs, is tasked with collection and analysis of crime data from all states and union territories, the figures of which are published annually in its report.

In 2022, nine states registered over 100 cases under IPC sections 153A, while in 2021 there were just two states - Andhra Pradesh and Uttar Pradesh - with such offences in three-digits. Both Andhra



Pradesh and Uttar Pradesh had re- cases in 2020, official figures ported 108 IPC 153A offences in 2021, according to the data.

In 2020, there were seven states with ovear 100 such cases each -Andhra Pradesh, Assam, Karnataka, Rajasthan, Tamil Nadu, Telangana and Uttar Pradesh. The maximum 303 cases were reported in Tamil Nadu in 2020, the NCRB data from corresponding year showed.

In 2022, the number of such offences nearly-tripled to 108 in Madhya Pradesh from 38 in 2021. The state had recorded 73 such

showed. In some states the figures increased to more than double in 2022 from 2021, like Uttar Pradesh (217 and 108), Maharashtra (178 and 75), Rajasthan (191 and 83),

Gujarat (40 and 11). Assam, which had reported 147 offences under IPC 153A in 2020, registered 75 cases in 2021 and last year the figure came down to 44, according to the NCRB report.

National capital Delhi recorded 26 cases in 2022, 17 in 2021 and 36 in 2020. Jammu and Kashmir

showed 16 such offences in 2022, 28 in 2021 and 22 in 2020, the official data revealed.

In a note of caution about the annual report, the NCRB said the primary presumption that the upward swing in police data indicates an increase in crime and thus a reflection of the ineffectiveness of the police is fallacious.

"'Rise in crime' and 'increase in registration of crime by police' are clearly two different things, a fact which requires better understanding. Thus an oft-repeated expectation from certain quarters that an effective police administration will be able to keep the crime figures low is misplaced," it stated.

Increase in crime numbers in a state police data may in fact be on account of certain citizen-centric police initiatives, like launching of e-FIR facility or women helpdesks," it said.

"The increase or decrease in crime numbers, however, does call for a professional investigation of underlying factors pertaining to the local communities to suitably address the pertinent issues," it

DMK MP expresses regret for north-south divide remark

NEW DELHI, Dec 6: DMK MP D N V Senthil Kumar on Wednesday apologised in the Lok Sabha for his controversial 'north-south divide' remark which had sparked a back-

Kumar had on Tuesday used a pejorative to describe Hindi heartland states while attacking the ruling BJP. His comments led to ruckus and adjournment in the House, and were expunged by Speaker Om Birla later. MPs from the ruling BJP on Wednesday also created a ruckus over the issue, and the House witnessed a brief adjournment during the Question Hour over the issue.

At 12 noon, when the House reassembled for the Zero Hour, Union Minister Arjun Ram Meghwal raised the issue, and asked if DMK leader TR Baalu, and Congress leader Rahul Gandhi agree with the

Demanding an apology, he said, 'Is TR Baalu standing with him? Is Rahul Gandhi standing with him? Voters have made BJP victorious in three states, and this is what they say. This is the thinking of dividing India in north and south. We will not allow it," he said.

Baalu, who raised the issue of floods caused by Cyclone Michaung in Tamil Nadu and demanded that the Centre declare it as a national calamity, said the remarks made by Kumar were not correct.

"Statement made by Senthil

Kumar was not correct. MK Stalin has warned the particular member," Baalu said

Soon after, Kumar expressed regret over the comment.

Kumar said the remarks were made "inadvertently" and if they have hurt the sentiments of people, he withdraws them. The DMK MP had earlier tendered an apology for his comments on Tuesday.

"Commenting on the results of the five recent state assembly elections. I have used a word in a inappropriate way. Not using that term with any intent, I apologise for sending the wrong meaning across," he said in a post on X.

While participating in a discussion on J&K Reorganisation (Amendment) Bill in the House on Tuesday, Kumar had said the BJP can win elections only in the Hindi heartland states and not in south

BJP leaders termed Kumar's remarks as "hate speech" and said the voters will "wipe out" the India bloc from southern India as well in the next elections.

"Very unfortunate choice of words. Unparliamentary. Senthil Kumar must forthwith apologize and withdraw his comments," Congress Lok Sabha member Karti Chidambaram had said on X.

'Very unfortunate to witness an Indian MP making derogatory state-

SanatanaDharma culture revered by over one billion Indians. Many, including myself, consider ourselves Sanatanis," former Union minister

Milind Deora had said on X. "DMK must realise that its reckless remarks only weaken INDIA Alliance's efforts in challenging BJP in the Hindi heartland. India is one, and there is no place for a northsouth divide," Deora had said.

Kumar's comments come in the backdrop of some referring to the recent assembly election results as reflective of the 'north-south divide' after the BJP trounced the Congress in Rajasthan, Madhya Pradesh and Chhattisgarh, and the Congress won in Telangana.

"This is another example of hate speech. This reflects the frustration of INDIA constituents. Gomutra and Gomata are revered not only in northern states but also in the South. If they keep insulting Indian culture and traditions then leave aside north India, the INDIA bloc will also be wiped out from southern India,' BJP Rajya Sabha member G V L Narasimha Rao told PTI.

Senior BJP leader Sanjay Jaiswal said the BJP will even form the government in Tamil Nadu in the next five years by defeating the DMK.

"Senthil Kumar is scared because he knows that the BJP will win big in Tamil Nadu. Defeating the DMK is the only goal of the BJP in Tamil Nadu," he had said. (PTI)

Bill passed by Lok Sabha



NEW DELHI, Dec 6: The Lok Sabha on Wednesday passed the Jammu and Kashmir Reorganisation (Amendment) Bill, which seeks to nominate two members from the Kashmiri migrant community and one representing the displaced persons from Pakistan-occupied Kashmir (PoK) to the legisla-

The House also passed the Jammu and Kashmir Reservation (Amendment) Bill, which seeks to change the nomenclature of a section of people who are eligible for quota in appointment and admission.

The bills were passed after more than six hours of debate spanning over two days and a spirited reply by Union Home Minister Amit Shah. The home minister said the two bills related to Jammu and Kashmir

brought by the government will give justice to those deprived of their rights for the last 70 years and asserted that reservation to the displaced people will give them a voice in the legislature. He said that Jammu and Kashmir has suffered due to two blunders com-

mitted by the country's first prime minister Jawaharlal Nehru - first announcing ceasefire and then taking the Kashmir issue to the United Nations. "Had Jawaharlal Nehru taken right steps, PoK would have been part of

India now. It was a historic blunder," he said. The home minister said a plan to have zero terror incident in Jammu and Kashmir has been in force for the last three years and it will be successful

JK Reservation (Amendment) Parts of city suffer from inundation, relief work expedited

CHENNAI, Dec 6: Residents grappled with stagnant water and power disruption in parts of the city and its suburbs on Wednesday, two days after Cyclone 'Michaung' wreaked havoc in the metropolis and neighbouring districts, even as civic agency personnel were involved in relief and rehabilitation efforts. The government said power was kept suspended in some areas as a "preventive measure" as the cables were under water, while asserting all efforts were being taken to restore normalcy.

Another day's holiday was declared for schools and colleges in Chennai on December 7.

The cyclone-triggered heavy rainfall had led to inundation in localities including Velachery and Tambaram. On Wednesday too, people were seen leaving their homes in the areas surrounded with water to safer zones, carrying their children and wading through the stagnant water. They called for help, including pressing more boats to ferry people to higher ground. Chief minister M K Stalin visited some of the affected areas and distributed food and essential commodities to people put up at a relief centre in the city. He inspected activities undertaken by the city civic body to drain water.

He also wrote to the Centre seeking an interim flood relief of ₹ 5,060 crore to tide over the situation. Many users on social media site 'X' shared videos of residential localities still being surrounded by stagnant water, claiming many residents were stuck inside. The hashtag #Velachery was trending on the microblogging site. A user lamented that her relatives were stuck in their home for the last three days without power, drinking water and milk.

There were complaints of delay in supply of milk in many affected parts including Velachery and Tambaram and residents alleged it was being sold for extra price. Power supply had not resumed in ban services on the Chennai Egmore-Chengalpet parts of the city including Kilpauk and Kat- and Chennai Beach-Arakkonam routes with fre-



tupakkam. The state government said relief activities were on in full swing and that people in many of the affected areas were being rescued through inflatable boats even during the midnight.

Senior officials of the Greater Chennai Corporation were overseeing the rescue and relief activities, the civic agency said.

The Greater Chennai Police also announced helpline numbers for citizens to contact them for rescue and relief activities.

An update from the city police on Wednesday said six rain-related deaths were reported while many persons in need were rescued by police personnel in different parts of the city. Among the rescued were aged persons and a number of pregnant women, and a woman and her newborn, an official

Further, 11 subways in the metro remained closed for vehicular movement due to water-logging. There were no disruptions in operations at the airport while the Southern Railway announced cancelling a number of services and diversion of many others.

However, it announced resumption of the subur-

quency of 30 and 45 minutes, respectively. Services on the Tiruvottiyur-Sullurpeta line will be operated in a hourly frequency, it said in an update.

State Chief Secretary Shiv Das Meena told reporters that water was draining in many parts of the city. Where water has cleared, cleaning of roads was being done, while supply of drinking water was also being ensured.

A number of personnel, including those from NDRF and SDRF were involved in relief and rehabilitation activities, he told reporters here.

"Food packets, bread and milk are being supplied in waterlogged areas while boats have been deputed to severely affected areas in Perumbakkam and Varadarajapuram, with senior officials monitoring the efforts," he said. Over 200 boats have been pressed into service in different areas. On power supply yet to be restored in some areas, the official said it was done as a "preventive step" to avert any untoward incident as the government wants nobody

"We are ready to provide power but there should be no loss of life, nobody should be affected, there should be no accident. Wherever the power cables are under water, as a preventive stop, there is delay in (resuming)power supply," he said

Only 95 of the 1,812 feeders in the city are yet to be switched on. The situation will be better as water recedes, the top official added.

Later, addressing a press conference, he said around 41,400 persons have been accommodated in 372 relief centres in different districts and that they were being provided with food. In the 4 worst districts of Chennai, Tiruvallur, Kancheepuram and Chengalpet, there were a little over 800 locations with inundation and about 19,000 persons have been evacuated from there and moved to relief

BJP makes false promises before elections: Mamata

KOLKATA, Dec 6: West Bengal Chief Minister Mamata Banerjee Wednesday lashed out at BJP calling it the "biggest pickpocket" in the country and for bluffing voters before elections

Talking to reporters at the Netaji Subhas Chandra Bose International Airport here before leaving for north Bengal, she said central agencies repeatedly visit the state to get "political food" for the saffron party.

"They (BJP) are the biggest pickpockets in the country and people have suffered the most due to this. Their promises to transfer ₹ 15 lakh to each person's account, then demonetisation, and then the sudden stop to free ration during the pandemic. They bluff people making false promises before the elections," Banerjee said.

"We (TMC) are unlike them," she asserted

Referring to Uttar Pradesh getting funds even after the deletion of a large number of fake job cards, Banerjee wondered why the Centre was not disbursing dues for 100 days' work scheme to West Bengal.

On Giriraj Singh's advice to her to meet Narendra Modi to get the dues of West Bengal, the chief minister said that she has already met the prime minister thrice and has sought time for another appointment. (PTI)

BJP MPs, including Union ministers, elected to assemblies quit Parl; likely to join state govt

NEW DELHI, Dec 6: Union ministers Narendra Singh Tomar and Prahlad Singh Patel resigned from Lok Sabha on Wednesday as the BJP decided that all of its 12 MPs recently elected to state assemblies will quit Parliament, amid strong indications that they may join the new governments in Madhya Pardesh, Chhattisgarh and Rajasthan. The move has given rise to the view that the party leadership may bring in new faces at the helm in all the three states. Senior leaders, however, declined to comment on such a development.

BJP president J P Nadda accompanied 10 of them as they tendered their resignations from Parliament. Two others, Union minister Renuka Singh and Mahant Balaknath, will also be quitting, party leaders said. Other MPs who quit are Rakesh Singh, Udya Pratap Singh and Riti Pathak from Madhya Pradesh; Kirodi Lal Meena, Diya Kumari and Rajyavardhan Singh Rathore from Rajasthan and Gomati Sai and Arun Sao from Chhattisgarh.

All except Meena are Lok Sabha members. Meena is a Rajya Sabha member. Patel said they took Prime Minister Narendra Singh's blessings before tender-

ing their resignations.

All three Union ministers will also be quitting the Modi government as a procedural formality. Tomar is a Cabinet minister handling the crucial agriculture portfolio, and their departure have sparked a fresh buzz within the party on whether Modi will induct new members in his council of ministers ahead of the 2024 Lok and Patel, who comes from politically significant Other Backward Classes, are seen as possible chief ministerial choices in Madhya Pradesh along with the incumbent Scheduled Tribes, are seen as serious Shivraj Singh Chouhan, who has been at contenders due to their social backthe helm in Madhya Pradesh since 2005 except for five months when Kamal Nath headed a Congress government after the 2018 assembly polls.

Democratic nations must look at the 'internal forces': Tibetan leader on China

NEW DELHI, Dec 6: Tibetan people are "dying a slow death" in the face of China's repression and the democratic nations must stand up to the Chinese belligerence, the president of Tibet's government-in-exile Penpa Tsering has said.

Tsering said democratic nations around the world must look at the "internal forces" such as the Tibetans, Uyghur leaders and pro-democratic activists in Hong Kong to put pressure on Beijing to reverse its aggressive approach and bring "positive changes" within that coun-

He said there has not been much understanding in the world about the extent of China's strategic objectives and plans and that there is a need to create awareness on what Beijing's machinations are.

In an address at an awareness event on Panchen Lama, the Sikvong or political leader of the exiled Central Tibetan Administration accused China of destroying the historical basis of Tibet's existence.

I have been telling the world that "we are dying a slow death, we are being stricken by being squeezed out of our breath by the dragon", he said last night.

After a failed anti-Chinese uprising in 1959, the 14th Dalai Lama fled Tibet and came to India where he set up the government-in-exile. The Chinese government officials and the Dalai Lama or his representatives have not met in formal negotiations since 2010.

Beijing has in the past accused the Dalai Lama of indulging in "separatist" activities and trying to split Tibet and considers him as a divisive figure.

However, the Tibetan spiritual leader has insisted that he is not seeking independence but "genuine autonomy for all Tibetans living in

Lok Sabha speaker Om Birla said the remarks made were not an insult to anyone and were only made to put things in context. In his remarks, Shah also alleged that the Kashmir matter was taken to the UN in a hurry. "If at all it had to be taken to the UN, it should have been sent under Article 51 rather than Article 35 of the UN Charter," he said, asserting that he of course believes that the issue should not have been taken to the UN in the first place. Shah also quoted Nehru as saying later that the ceasefire was a 'mistake'. Shah

added that it was not Nehru's mistake but a blunder. "So much land of this country was lost, it was a historic blunder," the home minister added. Talking about the abrogation of Article 370, Shah said it had nothing to do with going back on promise as it was a temporary article and had to go. "You did not have the courage, PM Narendra Modi showed courage and did away with it," he said, referring to the opposition benches.

Shah pointed out that the two bills on Jammu and Kashmir seek to nominate two Kashmiri migrant community members, including a woman, to the assembly. One seat in the Jammu and Kashmir assembly will be set aside for people displaced from Pakistan-occupied Kashmir, the home minister said. More than 45,000 people have lost their lives due to terrorism in Jammu and Kashmir so far, he said. Shah said the government's focus was on ending the terror ecosystem in Jammu and Kashmir. He said a plan to have zero terror incident in Jammu and Kashmir is in force for three years and it will be successful by 2026.

"I believe Modi government will return to power in 2024 and by 2026, I hope there will be no terror incident in Jammu and Kashmir," he said. Shah said the two bills will give justice to those deprived of their rights for the last 70 years and asserted that reservation to the displaced people will give them a voice in the legislature. He said that had terrorism been tackled at the beginning without considering vote-bank politics, Kashmiri pandits would not have had to leave Kashmir Valley.

He said one of the bills seeks to give representation in the assembly to those who had to leave Kashmir due to terrorism. Shah also lashed out at the Congress for talking about backward classes, saying that if any party has harmed backward classes and come in the way of their growth, it is the Congress.

The income threshold will also affect people more if they live outside of London and the south east [England], in areas of the country where earnings are lower.' An analysis she co-authored with fellow researcher Dr Ben Brindle reflects that it is unclear why the proposed

thresholds for family migration and skilled work migration are the same. "The income threshold will affect some groups more than others. For example, whereas around 60 per cent of men earn less than the new income requirement, this rises to more than 75 per cent for women," they note. The Opposition Labour's shadow home secretary, Yvette Cooper, has also raised the prospect of many rushed weddings between now and spring 2024 by those desperate to circumvent the new rules.

"What we're asking for is the Migration Advisory Committee (MAC) to look at this. It looks as though the committee hasn't actually been asked to look at this for over 10 years," Cooper told the BBC. "So, they should be asked to look at this very swiftly, and to look at what the best way to approach this is, because at the moment this seems to have come out of thin air with no plan at all and because there's a possibility that actually what this will lead to is a big increase in rushed marriages and so on in the next few months because of the changes," she said. Meanwhile, the British Association of Physicians of Indian Origin (BAPIO) - the UK's largest representative

body for nearly 80,000 doctors and 55,000 nurses of Indian origin - has written to the Home Secretary on Wednesday demanding clarity on exactly how the new clampdown on overseas care workers will operate.

The letter reads: "It was very concerning and distressing to our members to read about the plans to prevent overseas care workers from bringing their dependents to the UK. "Stopping their spouses and children from accompanying them to the UK will have a significant detrimental impact on their mental and physical wellbeing resulting in a lower quality of care for patients and a reluctance for these skilled workers to either continue working or start new positions in the UK.'

Under the new immigration crackdown, overseas care workers will be banned from bringing family members and skilled professionals must meet an annual salary threshold of GBP 38,700, up from the current GBP 26,200. Indian industry and student groups have warned the Prime Minister Rishi Sunak led government of "unintended consequences" of the new measures aimed at curbing migration figures, which would lead to skilled Indians choosing alternate economies. (PTI)

(Do jobs sitting at home), "Ghar baithe kamai kaise karen" (How to earn by sitting at home) etc. in multiple languages from overseas advertisers. Upon clicking the advertisement, an agent using WhatsApp or Telegram starts conversation with the potential victim, who convinces him or her to perform some tasks like video likes and subscribe, maps rating, etc. Upon completion of task, the victim is given some commission, initially and is asked to invest more to get more returns against given task.

After gaining confidence, when victim deposits larger sum, deposits are frozen and thus the victim is duped. As precautionary measure, it is advised to exercise due diligence before investing in any such very high commission paying online schemes sponsored over internet. If an unknown person contacts anyone over WhatsApp or Telegram, refrain from performing financial transactions without verification, the statement said. Verify the name of receiver mentioned in UPI App. If receiver is any random person, it may be a mule account and scheme may be fraudulent. Similarly, check the source from where initial commission is received, it said. Citizens should refrain from doing transactions with unknown accounts, as these could be involved in money laundering and even terror financing and lead to blocking of accounts by police and other legal action, the statement said. (PTI)

SC: Govt must be

It says those who came to Assam on or after January 1, 1966 but before March 25, 1971 from specified territories, including Bangladesh, in accordance with the Citizenship Act amended in 1985, and since then are residents of the northeastern state, must register themselves under section 18 for acquiring Indian citizenship. As a result, the provision fixes March 25, 1971 as the cut-off date for granting citizenship to Bangladeshi migrants in Assam. Seeking declaration of the provision as invalid, Divan had on Tuesday sought a direction to the Centre to frame a policy in consultation with States/UTs for settlement and rehabilitation of all people of Indian origin who came to Assam after January 6, 1951 proportionally across the country. Responding to his submission, the bench asked if Parliament could let the "strife" continue in Assam on the ground that the law will discriminate among states. "Can Parliament say that we are doing this to bring about peace in a striferidden State? Or should we continue that strife merely because we will be discriminating between states? ... The situation of Assam in 1985, there was so much violence. Any solution they would have found is bound to be an inexact solution," the bench said. At the outset, Divan said illegal migrants in Assam who are required to be processed under Section 3 of the Foreigners Act are rewarded with citizenship.

'The very existence of section 6A operates even today as a beacon to persons to migrate illegally into Assam and then gain the system in the manner they want and make claim to citizenship. "My submission is that Assam and other immediate neighbouring border states form a homogeneous single class. Singling out Assam is impermissible. The next point is that a violent or any type of political agitation resulting in a political settlement is not a sufficient basis for classification," he said. Divan said allowing huge illegal immigrant regularisation with potentially future generations also making a claim without any time frame undermines economic, social, and political aspirations, which are facets of Article 21, of the people of Assam. Opposing section 6A, senior advocate KN Choudhury, representing one of the petitioners, claimed that out of the state's 126 assembly constituencies, indeginious people can win elections only in 57. "That is the state of affairs. Can we ever conceive a situation where the Government of India wants to protect immigrants at the cost of indeginious people?

This is a legislation brought by a regime who had a brute force of 400 plus MPs. It is a parliamentary joke to have this legislation. Instead of protecting indigenous people, people living in the state, they're protecting illegal immigrants for the sake of politics," Choudhury said. The hearing remained inconclusive and will resume on Thursday. The top court had on Tuesday sought data on the beneficiaries of section 6A of the Citizenship Act in Assam, saying there was no material before it which could indicate that the effect of granting Indian citizenship to Bangladeshi immigrants between 1966 and 1971 was so great that it impacted the demographic and cultural identity of the border state. While acknowledging the problem of cross-border infiltration in Assam, the constitution bench had referred to the humanitarian aspect of the 1971 Indo-Pakistan war for liberation of Bangladesh which also led to influx of immigrants.

Solicitor general Tushar Mehta had referred to data produced by an MP in the Rajya Sabha earlier and said 5.45 lakh illegal immigrants had come to Assam between 1966 and 1971. From 1951 to 1966, the figure was 15 lakhs, he added. As many as 17 petitions, including the one filed by NGO Assam Public Works in 2009, are pending in the apex court. Under the Assam Accord signed by the All Assam Students Union, Assam government and the Government of India on August 15, 1985, to detect and deport foreigners, Section 6A was inserted into the Citizenship Act to grant citizenship to people who have migrated to the state.

A two-judge bench had referred the matter to the Constitution bench in 2014. (PTI)



When Sinclair was subbed out in the second half, Schmidt took her place on the field after an emotional embrace.

With Sinclair, Canada won the gold medal at the Tokyo Olympics. She won bronze medals at both the 2012 and 2016 Games.

Sinclair is also among just five players to appear in six Women's World Cups, and one of just three players to score in five. But a World Cup trophy eluded her.

She was asked what advice she would give young players looking at a career in soccer.

"All the players on the national team, we were once that young kid that had aspirations and dreams of playing professionally, and representing Canada at World Cups and Olympics," Sinclair said. "There's no secret. It's a lot of work but man it's the best job in the world. Just go for it. Anything's possible.'

Sinclair plans to play one more season for her club team, the Portland Thorns in the National Women's Soccer League.

Bayern Munich to sign Bryan Zaragoza from Granada at the end of the season

Arsenal move 5 points clear in Premier League after last-gasp win

LUTON, ENGLAND, Dec 6: As soon as the ball hit the back of the net, Arsenal goalkeeper David Raya sprinted the length of the field to celebrate the lastgasp winner with his jubilant

No player will have been more relieved than Raya to see Declan Rice's glancing header creep into the corner and seal a chaotic 4-3 victory over Luton in the Premier League on Tuesday. While Rice is proving value for money after his clubrecord signing in July, Raya another offseason recruit — remains an issue for Arsenal manager Mikel Arteta as the team bids to win the league title after last season's near miss.

Arsenal moved five points clear with its fourth straight victory in the league, overcoming errors from Raya that led to two



goals for Luton by netting in the seventh minute of stoppage time through Rice at Kenilworth Road. "The spirit of the team how we fought, showed our quality in the right moments and never gave up," Arteta said. the 49th minute when the Span-

Botafogo squander a 13-point lead to lose national league title Injured Newcastle

SAO PAULO, Dec 6: There's an old saying in Brazilian soccer: some things only happen to Botafogo. The reference to the club's historic lack of luck has never rung more true than this year.

The club of World Cup winning greats like Mané Garrincha, Jairzinho and Mário Zagallo squandered a 13-point lead in the Brazilian league and now Palmeiras is very likely to defend its title on Wednesday. It's the first time a team has lost such a big advantage in the South

American nation's top flight. The last round will take place without any hopes for Botafogo fans at Internacional but to finish in fourth position, which would be enough to secure a direct spot at the next Copa Libertadores. The Rio de Janeiro club is currently fifth. Botafogo was on the top of the

standings for 31 of 38 rounds, giving long-suffering supporters confidence their club would lift its first national title since 1995.

But now Palmeiras is in a position where it doesn't necessarily have to win its last game to secure another title. Even with a loss at Cruzeiro, Palmeiras can clinch the league as long as Atletico Mineiro doesn't erase a differential of eight goals. Flamengo has a slim title chance, but that depends on an even more unlikely combination of results involving other teams.

Botafogo's title hopes vanished for the season after a 0-0 draw with Cruzeiro on Sunday, a match that ended with some supporters hurling insults at players and burning team shirts at the Nilton Santos Stadium. Only a few seasons ago the fans

would have been excited just to fin-

ish near the top. But after American businessman John Textor bought the club's soccer division last year, expectations rose dramatically. "We needed to be a little bit more humble. We needed to read every match. read the moment of the club," veteran striker Diego Costa, who arrived in the middle of the season, told journalists on Sunday. "We needed to leave our ego outside so we could achieve better results. I hope this is a good teaching for all those who are here. Soccer makes you pay." It was against Wednesday' rival, Internacional, that Botafogo achieved its 13-point advantage on Aug. 12. By then, some fans had tattooed the Brasileirao trophy on their bodies, laughed at rivals losing points to relegation contenders and started debating what round the team would be crowned. (AP)



Arsenal's slew of late winners highlights resilience and boosts belief in Premier League title bid

LUTON, ENGLAND, Dec 6: They say little should be read into the Community Shield, the traditional curtain-raiser to the English soccer season.

Maybe this year is an exception. Back in early August, Arsenal scored an equalizer through Leandro Trossard in the 101st minute in regulation time and went on to beat Manchester City in a penalty shootout at Wembley Stadium.

Aside from winning a piece of silverware, it was hailed by Arsenal's players as a statement victory — despite the uncompetitive nature of the fixture.

"The mental block is gone," goalkeeper Aaron Ramsdale said that day, a reference to his team stumbling late in last season's Premier League title race and finishing behind City.

Well, maybe they are right. And that's not just because Arsenal woke up Wednesday to a five-point lead in the Premier League. It's because of how the

Scoring late goals — a trait demonstrating resilience and character — has become the norm for Arsenal. Dare it be said, it's a sign of a champion team.

Just in the first 15 league games of this season, Arsenal has scored in the 96th and 101st minutes to beat Manchester United 3-1; in the 86th minute to beat Man City 1-0: in the 84th minute to draw 2-2 at Chelsea; in the 89th minute to beat Brentford 1-0; and, on Tuesday, in the seventh minute of stoppage time to win 4-3 at Luton.

That's nine points gained with goals scored from the 84th minute or later. Maybe that late rally in the Community Shield was a portent for how this season will go.

"We don't want a draw, we want to win," Arsenal manager Mikel Arteta said. "That drive, that energy, that risk and emotion that we put in the pitch, you can sense it." The seeds of these comeback wins were sewn last

season when Arteta's teams produced a number of late recoveries in games to snatch crucial points in the title race.

The most memorable was Reiss Nelson's winning goal against Bournemouth that sent Arsenal fans wild at Emirates Stadium. That was in the 97th minute and gave Arsenal a five-point lead in the league, just like Declan Rice did with his winner against Luton. Arsenal again looks to be the team most likely to stop City winning the Premier League.

Last season, its title bid imploded in the final two months, weighed down by injuries to key players - William Saliba, in particular — and a naivety in dealing with holding off a fast-finishing juggernaut like City.

Could this season be different? Arsenal has a few things going in its favor. Rice, a club-record signing for \$138 million in July, is an upgrade in central midfield and has already contributed crucial goals against United and Luton. There's better strength in depth across the squad, in terms of numbers and experience.

Arteta's approach also appears to be different this season, going for more control than chaos - before the Luton game, anyway to help the team better last the distance in a grueling campaign that also includes playing in the Champions League. In this respect, Arteta seems to be using the playbook of City manager Pep

Guardiola from last season. "Playing every three days and vou have to win every game and every game, the demands are there," Arteta said. "It's the way they go about it, how much they want it." After the pain of the end of last season, Arsenal's players might want it even more.

There are questions marks about the wisdom of Arteta's decision to bring in goalkeeper David Raya and promote him above Ramsdale, last year's firstchoice keeper. Raya was at fault for two goals against Luton and has looked shaky in other games, notably in the draw at Chelsea.

Whether Kai Havertz, another summer signing, is an upgrade on the departed Granit Xhaka is also up for debate. Playing Havertz as a central attacking midfielder might be making Arsenal more brittle, though he has come through with crucial goals against Brentford and Luton over the past two weeks.

"He's getting better and better," Arteta said of Havertz.

Arsenal's season may vet be derailed by injuries or going deep in the Champions League which the team has already qualified for the round of 16 — or another typically relentless finish to the campaign from City.

Yet it appears that, on a psychological level, the Gunners are in a good place to have another go at winning a first league title since

"We have not made any inquiries or any decisions about our recruitment leading into January," Howe said.

"This is a chance for the goalkeepers we have at the football club to consolidate their positions, and that will be the same for every other position at the club." (AP)

Too much cricket is affecting development of all-rounders: Kallis

NEW DELHI, Dec 6: Jacques Kallis, one of the last multi-skilled legends, says quality all-rounders have become a scarcity in modern-day cricket, especially in Test cricket, because of "too much cricket across for-

While Sir Garfield Sobers (8032 runs and 235 wickets) is considered 'greatest of 'em all' across generations, Kallis (25,000-plus runs and nearly 600 wickets in three formats) is inarguably one of the legendary allrounders the modern era has seen.

In the 1980s, there were four great allrounders in Imran Khan, Richard Hadlee, Ian Botham and Kapil Dev while the new millennium saw emergence of Kallis and Andrew Flintoff.

But with advent of T20 cricket and mushrooming leagues across the globe with new rules have actually discouraged development of multi-skilled cricketers.

"It is a tough question to answer, allrounders don't come around every day. There aren't many throughout the history. Lot of things, amount of cricket that is played certainly plays a role," Kallis told PTI during an exclusive interview.

The former Proteas captain is in India to play the Legends League Cricket.

While he didn't name Indian Premier League but the former KKR coach isn't a great fan of 'Impact Player' rule where a team can change one player during its batting or bowling innings as per need.

"A few T20 competitions have substitutes (IPL) and I am not a big fan of that as it takes away the all-rounder out of your team. The teams that do not have good all-rounders are now playing with 12 men. I am not a huge

"There are lot of little things that add up on to why there aren't too many all-rounders at the moment, as it is surprising as they add so much value to the game. But it's a whole lot of little things coming together," Kallis

The Indian team would be embarking on a tough away tour of South Africa, the only major Test playing nation where it hasn't



won a single Test series in 31 years. The focus will be on the two Test matches, which is a part of World Test Championship (WTC) cycle even as ODIs and T20s are

part of the full tour. The stars from both sides (Virat Kohli, Rohit Sharma, Jasprit Bumrah, Kagiso Rabada) will only be playing the traditional

format during the series. "This is a good Indian team but South Africa is tough to beat in South Africa. Centurion will probably suit South Africa and Newlands will probably suit India. It will be a good series and it will come down to one

or two sessions that one team might play better than the other. It would be a closelyfought contest," said Kallis.

The Indian team's average age is in mid-30s. Skipper Rohit is 36 and main batter Virat Kohli is 35. Ravichandran Ashwin and Ravindra Jadeja are 37 and 35 respectively while Mohammed Shami 33.

There would be a transition sooner or later in another couple of years and Kallis feels that if talented youngsters are groomed by keeping them with senior team, the handing of baton becomes easier.

"Older players obviously have got the

knowledge and you would combine that with younger players. That's the job of coaches and selectors to make sure so that even if younger players might not be playing, they are in that environment where they can learn from the older players," said Kallis, who scored 45 Test hundreds in his illustrious 18-year career in which he played

It is imperative that youngsters are travelling to unfamiliar territories and soaking in all knowledge available watching those who have been there and done that.

"(They should) travel to these parts of the world that they are probably not used to and learn from sitting on the side, try to pick up as much knowledge as possible and play those warm-up games where big players are resting for. Picking up knowledge helps a lot and transition when a few players are retiring, it becomes little bit easier," he elabo-

Having started his career in mid-90s just when players like Kepler Wessels, Peter Kirsten, Andrew Hudson had all retired or were on verge of retirement, Kallis felt that back in the day, Proteas had a good system of changeover in place.

"Certainly, when I started, South Africa were very good at transitioning younger players into good international players and that obviously needs to be done when senior players retire.'

A part of the South African side that had to bear the label of "chokers" for not winning big-ticket events. Kallis understands the pain of the current Indian team that has now lost nine semi-finals or finals at marquee ICC competitions.

"You need a little bit of luck in these tournaments to go your way. You could end up being at the wrong end of the toss or bad end of the conditions, you need little bit of luck as players certainly don't go out there to

"From that point of view, you can get beaten by a better team on the day and you have got to put your hand up and accept it. Try to learn from those things," he said.(*PTI*)

ICC Rankings: Ravi Bishnoi becomes world's No 1 T20I bowler



DUBAI, Dec 6: Young Indian legspinner Ravi Bishnoi on Wednesday rose to the top spot in the ICC T20I bowling chart on the back of his recent player of the series-winning performance against Aus-

The 23-year-old was India's goto bowler in the just-concluded series against Australia, taking nine wickets from five games.

Bishnoi, who is on 699 rating points, has jumped five places to displace Afghanistan spinner Rashid Khan (692) from the top

Sri Lankan spinner Wanindu Hasaranga and England's Adil Rashid, who both have 679 points, are in joint third.

Sri Lanka's Maheesh Theekshana (677) completes the top five. Bishnoi is the only Indian bowler in the top 10 in the shortest format even as Axar Patel climbed

nine spots to be 18th. Meanwhile, the swashbuckling Suryakumar Yadav, who captained India during their 4-1 T20I series win against Australia, held on to the top spot among batters, while opener Ruturaj Gaikwad dropped a place to be seventh.

Hardik Pandya retained the third spot in the all-rounders' list, despite missing the series against Australia due to injury. (PTI)

LOS ANGELES, Dec 6: LeBron James scored 15 of his 31 points in the fourth quarter, and the Los Angeles Lakers secured the last semifinal spot in the inaugural NBA In-Season Tournament with a 106-103 victory over the Phoenix Suns on Tuesday night.

Anthony Davis had 27 points and 15 rebounds and Austin Reaves scored 20 for the topseeded Lakers, who will face New Orleans on Thursday in Las Vegas. Milwaukee plays Indiana in the East semifinal.

Rahim becomes first Bangla batter to be dismissed obstructing field; first in Test after 22 years

MIRPUR (BANGLADESH), Dec 6: Bangladesh wicketkeeper-batter Mushfiqur Rahim on Wednesday became only the 11th player in Test cricket history, and first in 22 years, to be given out for "obstructing the field" on the opening day of the second match against New Zealand here.

Rahim, who became the first Bangladesh batter to be dismissed in this way, blocked a climbing delivery from New Zealand pacer Kyle Jamieson in the fourth ball of the 41st over, and then tried to keep the ball away with his right hand even though it was far from the off-

The Kiwis quickly appealed and the on-field umpires referred the matter to the TV umpire Ahsan Raza who gave Rahim out. He made 35.

Bangladesh, who lead the series 1-0, were bundled out for 172 in their first innings but later reduced NZ to 55 for 5 at close

The last player to be given out in Test cricket in a similar fashion was former England captain Michael Vaughan in the Bengaluru match against India in 2001. Vaughan had made 64

According to Law 37.1.2, "The striker is out obstructing the field if, except in the circumstances of 37.2, in the act of receiving a ball delivered by the bowler, he/she wilfully strikes the ball with a hand not holding the bat.

'This will apply whether it is the first strike or a second or subsequent strike. The act of receiving the ball shall extend both to playing at the ball and to striking the ball more than once in defence of his/her wicket."

Earlier, such dismissals were classified as "handled the ball" but a change in the laws in 2017 brought them under "obstructing the field" category. (PTI)
