#### Biren Singh asked the people not to take the law into their hands

# Those engaged in violence will be responsible if AFSPA is re-imposed: Manipur CM

**IMPHAL, Jan 2:** Manipur chief minister N Biren Singh Tuesday said that he is "highly upset" with the ongoing violence in Manipur and elements who engage in it will be held responsible for any stringent government action, including the reimposition of AFSPA

"Whatever is going on in the society now is too much. The government will find it really hard to tolerate if anyone or any group keeps on taking the law into their own hands. The central government will not keep on looking. If AFSPA is again re-imposed, they will be held responsible," he said after visiting those injured in a firing incident at Lilong Chingjao area in Manipur's Thoubal district.

"Elements who continuously engage in violence should be held accountable if the government takes any stringent action, including re-imposition of the unwanted AFSPA ... I am highly upset (sic). The government cannot watch all these forever," he said.

AFSPA was extended for six months in the hill areas of the north eastern state since October last year and 19 police station areas Imphal valley area and an area that shares its boundary with neighbouring Assam were kept outside its purview despite the violent ethnic conflict that broke out in May.

The chief minister asked the people not to take the law into their hands and to inform the authorities concerned if they find anything suspicious so that the necessary legal actions are taken. He also asked them to identify the "enemies of Manipur" and face them unitedly rather than engage in internal clashes.

Singh visited the injured at Raj Medicity, a private hospital here. Four persons received bullet wounds in the firing and two of them who were injured critically firing are being treated in the ICU of the hospital.



## **Government plans to end Free Movement Regime with Myanmar to curb influx**

NEW DELHI, Jan 2: The Free Movement Regime (FMR), which allows people residing close to the India-Myanmar border to venture 16 km into each other's territory without visa, will be ended soon, a senior government functionary said on Tuesday.

The 1,643-km-long India-Myanmar border, which passes through Mizoram, Manipur, Nagaland and Arunachal Pradesh, currently has FMR. It was implemented in 2018 as part of India's Act East policy.

Under the FMR, every member of the hill tribes, who is either a citizen of India or a citizen of Myanmar and who is resident of any area within 16 km on either side of border can cross over on production of a border pass with one year validity and can stay up to two weeks per visit.

"We are going to end the FMR along the Indo-Myanmar border soon. We are going to put fencing along the entire border. The fencing will be completed in next four-and-a-half years. Anyone coming through will have to...get a visa," the functionary said.

The idea is to not only to stop the misuse of FMR, which is used by insurgent groups to carry out attacks on Indian side and flee towards Myanmar, but also put a halt to influx of illegal immigrants, and paralyse drugs and gold smuggling networks Tendering for an advanced smart fencing system for 300 km of the India-Myanmar border is already in

pipeline and the work will be started very soon. It may be mentioned that Manipur chief minister N Biren Singh had urged the Centre in September 2023 to end the FMR. The state government has argued that insurgents use the free movement regime to further their activities.

Manipur shares around 390 km of porous border with Myanmar and only about 10 km has been fenced so far. In July last year, the state government shared data that around 700 illegal immigrants entered the state.

Besides, Mizoram has seen an influx of anti-Junta rebels in thousands since the military coup in Myanmar on February 1, 2021. According to government estimates, several thousand refugees are living in different parts of Mizoram since the coup.

Mizoram shares a 510-km-long porous border with Myanmar.

The Manipur chief minister had also said that several persons from Myanmar tried to enter into his state but returned on seeing the (CONTD. ON PAGE-9)



NEW DELHI, Jan 2: Amid a political row over dropping the Chief Justice of India (CJI) from a panel empowered to choose the chief election commissioner and election commissioners, an advocate has moved the Supreme Court, seeking quashing of the new law that accords the central government sweeping powers to make appointments to the poll body.

The plea filed by advocate Gopal Singh has sought the apex court's direction to implement an 'independent and transparent system of selection, constituting a neutral and independent selection committee for appointment of the chief election commissioner and election commissioners (CEC and ECs)". While dropping the CJI from the selection committee, the new law said "Chief Election Commissioner and other election commissioners shall be appointed by the President on the recommendation of a Selection Committee consisting of—(a) the Prime Minister—Chairperson; (b) the leader of opposition in the House of the

People-Member; (c) a Union cabinet minister to be nominated by the Prime Minister-Member." The opposition has accused the Modi government of having defied the Supreme Court by dropping the CJI from the selection panel. In its March 2023 order, the Supreme Court had said the prime

Singh, in his Public Interest Litigation (PIL), has sought an order from the apex court to injunct the implementation of the gazette notification of December 28, 2023 relating to the chief election commissioner and the other election commissioners (Appointment, Condition of Service and Term of Office) Act, 2023.

## 312 Covid sub-variant JN.1 cases detected

in country

NEW DELHI, Jan 2: A total of 312 cases of COVID-19 sub-variant JN.1 have been detected in the country so far, with about 47 per cent of them recorded in Kerala, according to the INSACOG's data updated on Tuesday.

Ten states and Union territories have so far detected the presence of the JN.1 sub-variant of the virus.

These states are Kerala (147), Goa (51), Gujarat (34), Maharashtra (26), Tamil Nadu (22), Delhi (16), Karnataka (eight), Rajasthan (five), Telangana (two) and Odisha (one), according to the Indian SARS-CoV-2 Genomics Consortium (INSACOG).

The INSACOG's data showed 279 Covid cases recorded in the country in December had the presence of JN.1, while 33 such cases were detected in November.

The World Health Organisation (WHO) has classified JN.1 as a separate "variant of interest" given its rapidly-increasing spread, but said it (CONTD. ON PAGE-9)

**NEW DELHI, Jan 2:** The BRICS bloc of top emerging economies, including India, Russia and China, has announced induction of five full members into it in an attempt to expand its strategic heft against the backdrop of Western dominance in world affairs.

As Moscow assumed the presidency of BRICS, Russian President Vladimir Putin on Monday said the grouping has become a 10-nation body now with Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates joining it as new members, adding work on modalities to induct new categories of partner nations would start now.

In August, the top BRICS leaders at the grouping's summit in Johannesburg approved a proposal to



admit six countries, including Ardent Javier Milei last week angentina, into the bloc with effect nounced withdrawing his country from January 1. from becoming a member of the However, Argentina's new Presi-BRICS (Brazil-Russia-India-China-

South Africa). "Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates joined BRICS as new full members which is a strong indication of the growing authority of the association and its role in international affairs," Putin said in an address.

The Russian President said BRICS is attracting an ever increasing number of supporters and likeminded countries that share its underlying principles such as sovereign equality, openness, consensus, aspiration to form a multi-polar international order and a fair global financial and trading system.

The grouping took shape in September 2006 and it originally comprised Brazil, Russia, India and China (BRIC). It was renamed as BRICS after South Africa was ac-

cepted as a full member in September 2010. With Brazil, Russia, India, China and South Africa as its members. BRICS represents a quarter of the global economy and it has been a major engine of global economic growth over the years.

In his remarks, the Russian President said about 30 more countries are prepared to join the multi-dimensional agenda of the BRICS.

"Of course, we will consider the degree to which many other countries, about 30 of them, are prepared to join the BRICS multi-dimensional agenda in one form or another," Putin said.

"To this end, we will start working on the modalities of a new category of BRICS partner country," he said. (CONTD. ON PAGE-9)

### Tea production falls by 6.18pc India-Bangladesh trade down in pre-election season to 127.12 mkgs in Nov 2023 Impact is particularly acute in West Bengal's border town of Bangaon near the Petrapol border

KOLKATA, Jan 2: Tea production in the country has dipped by 6.18 per cent to 127.12 million kilograms in November 2023.

According to Tea Board data, the production in the year-ago month was 135.49 million kgs.

In North India, primarily comprising Assam and West Bengal, the production volume was at 106.23 million kgs (mkgs), down from 114.18

mkgs in the same period previous year. The production figures in November 2023 in South India stood lower at 20.89 mkgs from 21.31 mkgs in the same month of 2022. Maintaining the

growers was higher than the organised gardens in the month under review.

Small growers produced 67.50 mkgs in November 2023, Tea Board data said

Tea Board had issued notifications regarding plucking restrictions during the winter months in order to preserve the quality of bushes.

For tea estates in Darjeeling and gardens located at higher elevations, the last date for plucking of green leaves was December 11, 2023. The same for North Bengal's Dooars and Terai regions was December 23. (PTI)

KOLKATA, Jan 2: The India-Bangladesh bilateral trade, already strained by economic headwinds during the year, has dampened in some land ports due to the upcoming general elections in the neighbour-

ing country, exporters said on Tuesday. Bangladesh is set to hold its 12th general election on January 7 and the pre-election atmosphere has cast a shadow on the crossborder trade.

Indian exports to Bangladesh between April and October 2023 declined by 13.32 per cent, while imports saw a marginally smaller 2.3 per cent dip, according to data from the department of commerce.

Trade activity has been affected for some time now due to Bangladesh's forex shortages and liquidity crunch. The election-related slowdown is expected to be temporary, but stricter rules like the 110 per cent margin on letters of credit compared to the earlier 10 per cent have been a major concern for traders," a commodity exporter told PTI on condition of anonymity.

Stakeholders point to the general slowdown in trade activity during elections as a natural phenomenon due to factors like tighter border controls, heightened risk aversion among businesses, and the potential for disruptions like protests and short-



age of labourers who go back to their hometowns for voting.

The impact is particularly acute in West Bengal's border town of Bangaon near the Petrapol border, where local markets heavily rely on Bangladeshi tourists, they said.

"Export activity, especially of construction materials like stone chips, has slowed down due to the elections," said Prasonjit Ghosh of Malda's Malhadipur Exporters' Association

Fly ash exports via the Indo-Bangladesh protocol route through Kolkata port have also witnessed a 15-25 per cent drop during the peak construction season, highlighting the broader impact on construction material

trade. "There's been a temporary slowdown due to the election mode, but we expect trade to bounce back to normal after the polls," said Sajedur Rahman of the Benapole C&F Agents Association.

Although Petrapole cargo truck movement data shows no major trade disruptions, the number of trucks moving between December 21 and 31 had been quite erratic due to holidays. However, passenger movement, particularly inbound traffic, had reduced significantly.

## About 2,000 petrol pumps run dry as truckers strike against new penal code



NEW DELHI, Jan 2: About 2,000 petrol pumps, mostly in western and northern India, have run out of fuel stocks as the strike by some truckers' associations entered the second day on Tuesday.

While state-owned oil firms had topped up tanks at most petrol pumps across the country in anticipation of the truckers' strike, some petrol pumps in Rajasthan, Madhya Pradesh, Maharashtra and Punjab ran out of stock due to heavy rush, industry officials said

Long queues were witnessed at several pumps in these states as panic set in on stocks running out. Situation in southern India is bet-

ter with no major supply disruption barring a few pumps in Hyderabad, they said. Essential supplies of vegetables.

The industry officials said most petrol pumps have stocks to last 2-3 days and should not see any problems if the strike was to last for the stated three days. However, there will be trouble if the strike is extended or a pan-India protest is called, they added.

There are about 1 lakh trucks that ferry petrol and diesel as well as LPG from oil company depots to petrol pumps and gas distribution agencies.

The strike has impacted the movement of trucks in some western and northern states, they said, adding some LPG truck movement too has been impacted.

However, there is no complaints on LPG shortage just yet as most users have double connections (two LPG cylinders) and reserve stock even if one cylinder gets exhausted. If the strike were to get extended, roads. LPG supplies too may get hit, they



"The market extended yesterday's last hour's sell-off, taking negative cues from Asian peers due to weak Chinese manufacturing data and mounting tensions in the Red Sea, which has the potential to disrupt global trade and crude supplies," Vinod Nair, head of research at Geojit Financial Services said.

"Ahead of the impending results season, investors are adopting a profit booking strategy. Auto stocks declined on below-expected volume numbers, while pharma stocks were the standout due to catch-up in the US economy," Nair added.

In the broader market, the BSE midcap gauge declined 0.08 per cent and smallcap index dipped 0.03 per cent.

The dollar index, which gauges the greenback's strength against a basket of six currencies, was 0.11 per cent up at 101.44 on Tuesday. Brent crude futures, the global oil benchmark, was trading higher by 2.13 per cent to USD 78.68 per barrel. Brazil's economy improves during President Lula's first year back

RIO DE JANEIRO, Jan 2: Brazilian President Luiz Inácio Lula da Silva likes to boast he had a good first year after returning to the job. The economy is improving, Congress passed a long-overdue tax reform bill, rioters who wanted to oust him are now in jail, and his predecessor and foe Jair Bolsonaro is barred from running for office until 2030.

Still, the 78-year-old leader has struggled to boost his support among citizens and lawmakers. Some major setbacks, including a series of votes by Congress to

override his vetoes, signaled that Lula's POLITICAL DIV future could be less

productive in a Brazil almost evenly split between his supporters and Bolsonaro's.

"Brazil's political polarization is such that it crystallized the opinions of Lula and Bolsonaro voters beyond the economy," said political consultant Thomas Traumann, the author of a recent best-selling book on Brazil's political divisions. "These groups are separated by very different world views, the values that form the identity of each group are more important than food prices or interest rates.'

Lula took office on Jan. 1, 2023, after a narrow victory over Bolsonaro in October 2022. At the beginning of his four-year term, only one fourth of Brazil's Congress sided with him. Business and opposition leaders feared Lula had gone too far to the left.

A riot led by Bolsonaro supporters destroved government buildings in the capital of Brasilia on Jan. 8 and more turmoil looked certain. Former Finance Minister Paulo Guedes, among other conservatives, forecast Lula's policies would make Brazil's economy soon turn as sour as those in crisis-ridden Argentina and Venezuela.

"Six months to become Argentina. One year and a half to become Venezuela,"

Guedes said in an interview. Fast forward to December.

Brazil's economy is set to grow 3% this year instead of the 0.6% expected by market economists. Inflation looks controlled at about 4.7% on a yearly basis, slightly above projections but far from the double digits of recent years. The unemployment rate fell to 7.5% in November, one percentage point below the day Bolsonaro left office.

The Sao Paulo stock exchange hit record levels in December, rising above

134,000 points for IDE REMAINS the first time in its

history. Brazil's real currency is also rising against the U.S. dollar. All that brought back the optimistic, keen-to-travel-abroad Lula who had been missing during almost a decade of personal gloom.

"We needed to get our house fixed (in 2023), put things into place," Lula said in a meeting at the presidential palace on Dec. 12. "And now I say get ready. Next year, the Brazilian economy will not let anvone down.

Yet some polls have shown unchanged support for the president, at between 38% and 40% since January 2023. The numbers didn't pick up even after the announcement of a higher minimum wage in 2024, the buildup of Bolsonaro's legal woes or Brazil's return as a player in foreign affairs under Lula.

About a third of Brazilians consider Lula's presidency about average and another third deeply dislike the way he governs Latin America's powerhouse economy, which rose once again to the top 10 biggest in the world after years of sink-

Lula's supporters are at home, but Bolsonaro's are still taking to the streets.

Though not as numerous as in the recent past, the few thousand protesters asking



Congress to impeach Lula on corruption allegations have shown the resilience of the far-right leader's political base.

Bolsonaro was barred in June 2023 from running for office again until 2030 after Brazil's electoral court ruled that he abused his power and cast unfounded doubts on the country's electronic voting system

Engineer Eduardo Carlos Santos, 73, believes Brazil's economy recovered due to the work of Bolsonaro. A devout evangelical, as with many in the former president's base, he says there is a cultural war against conservatives and that leftists should have no place in government.

"Like it or not, Bolsonaro left a better economy and Lula is just reaping the fruits of that," said Santos, who blames the economic difficulties during the previous presidency on the COVID-19 pandemic and health restrictions. "Lula is a former inmate, sentenced for corruption. He had

## **Re-checking of BMI of 'obese' Assam Police personnel begins**

GUWAHATI, Jan 2: In a bid to ensure a professional outfit, the reexamination of body mass index (BMI) of "obese" Assam Police personnel began on Tuesday, a top official said.

Police personnel, who will fail to meet the required standard will undergo an 'assessment' of the factors due to which they could not make it, as the exercise is aimed at improving "fitness of the force and not punishing anyone", another official said

The review of BMI of 1,884 police personnel started at Jorhat, Silchar and Guwahati, director general of police GP Singh said.

The state police had conducted the body mass index (BMI) check of all personnel in August last year with the director general of police (DGP) undergoing the screening test first.

"As a follow up to BMI testing Former Janambhumi

The DGP had earlier said that all those who would not be able to reduce their weight by the end of the stipulated period would be offered a voluntary retirement option, except for those who have genuine medical reasons like thyroidism.

Chief minister Himanta Biswa Sarma had previously advocated removing the 'dead wood' from the police force - habitual drinkers, those with extreme obesity and with charges of corruption - to turn the force into a responsive and action-oriented one. (PTI)

#### Safety shocker for women!

n a shocking incident at Banaras Hindu University (BHU), a 22-year-old student was allegedly raped by three BJP youth leaders on November 1, raising serious concerns about women's safety under the Modi-Yogi administration. The incident occurred inside the campus, a supposed stronghold of Hindutva values, in Varanasi, the Lok Sabha constituency of Prime Minister Narendra Modi. The victim reported that the accused, riding a motorcycle, waylaid her and a friend, forcing the friend away before assaulting her. Disturbingly, they also filmed the assault. Despite the complaint, the police failed to file an FIR on the same day, creating a delay that has fueled accusations of political influence. The accused, Kunal Pandey, Abhishek Chauhan, and Saksham Patel, identified by the police, were allowed to leave Varanasi within five days, tasked with electioneering for assembly polls in Madhya Pradesh. The involvement of these BJP youth leaders, with roles such as IT cell convenor and working committee member, highlights the alleged political protection they enjoyed. Their subsequent arrest took two months, and they were placed on judicial remand rather than police remand, raising questions about the handling of the case. The police did not seek a PC (police custody) to delve deeper into their activities or potential habitual offenses.

The incident sparked public outrage in Varanasi, leading to protests and demands for justice. The victim's courage stands in contrast to the reported reluctance of other students to file complaints due to fear of the accused's political connections. Disturbing images circulating on social media show the accused posing with top BJP leaders, including Narendra Modi, UP Chief Minister Yogi Adityanath, and BJP president J.P. Nadda. Denials of association with the BJP by state leaders further add to the controversy. Vidya Sagar Rai, BJP's Varanasi city unit in-charge, disclaimed any connection, while opposition leaders accused the police of letting the accused go free to protect the BJP's electoral interests. University academics are now seeking answers from UP CM Yogi Adityanath, questioning whether the accused's houses will face legal action and if justice will be served for the victim. Despite Yogi's claims of creating a crime-free state, Uttar Pradesh continues to witness high rates of crimes against women. This incident underscores the broader issue of rising crimes against women in India under Modi's rule. National Crime Records Bureau (NCRB) data for 2021 reveals a concerning increase in crimes against women, with over 4,00,000 reported cases, including 32,033 rape cases-a 26.35% rise over six years. The BJP's slogan 'Beti Bachao-Beti Padhao' is being questioned as incidents like the BHU rape case unfold.

The involvement of accused BJP youth leaders in an RSS event and their connection with ABVP raises concerns about the political influence affecting the campus environment. The RSS has faced criticism for creating a lawless situation in BHU, including instances of insulting professors and forcing a Muslim Sanskrit scholar to stop teaching. As the nation grapples with the aftermath of this shocking incident, it brings to light the urgent need for addressing the safety concerns of women and holding perpetrators accountable, irrespective of their political affiliations. The BHU rape case exposes alarming safety issues for women under the Modi-Yogi administration. Delayed arrests of BJP youth leaders and their alleged political protection raise serious concerns about justice and accountability.

# **Growth challenges for India's** defence manufacturing sector

# new legal codes

t should ideally be a moment of celebration for every Indian citizen as the three British-era laws that governed criminal justice administration in India - the Indian Penal Code (IPC), 1860; the Code of Criminal Procedure, 1973 (originally enacted in 1898); and the Indian Evidence Act, 1872 - are now giving way to three new laws the Bharatiya Nyaya Sanhita (BNS), 2023: the Bharativa Nagarik Suraksha Sanhita (BNSS), 2023; and Bharatiya Sakshya (BS), 2023, respectively. However, those deeply invested in the preservation of democracy in the country seem to lack the enthusiasm exhibited by Union home minister Amit Shah, who presented the bill in the Lok Sabha. This sentiment persists despite the assurances given in his response before the House adopted the three bills on December 20, 2023.

The impact of these three laws is poised to resonate through the lives of Indians for generations to come. Every police officer and legal professional in the country will be transitioning to the new codes, handling charges encrypted within them to serve the people. However, the pace of this transformation was notably swift - presented on August 11 of this year, the revised versions of the bills were passed within a mere four months.

Despite requests from members of the Opposition in the parliamentary standing committee on home affairs, which is tasked with subjecting the bills to thorough scrutiny over an extended period, their appeals were disregarded. Subsequently, the home minister announced the withdrawal of the bills presented in August, introducing new ones with changes suggested by domain experts and legal professionals. In a matter of days, the Lok Sabha embraced these bills.

The fundamental flaw in the home minister's approach lies in his undervaluation of Parliament's significance as the nation's paramount law-making institution. It is within the walls of Parliament that laws are crafted and dismantled, and the people elect representatives to ensure their perspectives are considered in this legislative process. While recognizing that law-making indeed requires the input of domain experts, the essence of democracy lies in having representatives with a grassroots-level understanding of life. These elected officials comprehend the intricacies of implementing laws on the ground far better than experts, and it is their insights that render a law truly people-friendly. A mere couple of days of discussion on the just over a thousand sections in the three bills though many were replaced - is undeniably insufficient by any standard, particularly considering the inclusion of critical subjects such as terrorism and the

laws. In a disconcerting turn of events, crucial laws were slyly pushed through via a voice vote in a House where a significant chunk of Opposition members found themselves ousted for merely raising valid concerns. This power move by the government underscores its unwavering dominance in the Lower House, demonstrating a blatant disregard for the Opposition's voice. Chief Justice of India, D.Y. Chandrachud, eloquently highlighted the essence of democracy, emphasizing that while the majority may prevail, the minority retains the right to express its perspective. Contrary to this principle, the government seems singularly focused on imposing its will, leaving little room for the democratic discourse it should uphold. The Indian defence manufacturing sector has advanced significantly, L largely due to the government's 'Make in India' policy and emphasis on self-sufficiency. But difficulties that can hinder development in 2024 need to be addressed. So like all significant nations, India has an Army, Navy and Air Force and these wings need among other essentials, ground vehicles, naval vessels, C4ISR, fixed-wing aircraft, rotary-wing aircraft, weapons and ammunition, protection and training and unmanned systems.

The Indian defence market is growing. It is expected to increase at 4 percent annually. India's rivalry with China needs constant modernization of military equipment, cutting imports and market growth. Geopolitical tensions - as well as terror threat perceptions - have pushed India to expand its perimeter, security, naval and aviation capabilities. The country's defence budget has steadily expanded.

Military budget for 2024 could be \$84 billion - a whopping 13 percent rise from 2023. This increase will support market expansion over the projection period. Also, with the 'Make in India' initiative, India seeks self-sufficiency in defence and allied areas, thereby opening up new prospects for market players.

The increased emphasis on modernizing aircraft capabilities will stimulate segment growth-including HAL Tejas LCA Mk-1A, Dornier 228, HAL Dhruv ALH/Rudra and HAL Light Combat Helicopter deliveries. India's initiatives in manufacturing and operational self-sufficiency generate considerable opportunities for regional suppliers. India will keep spending on AMCA, LCA Mk-2, 3-tonclass Indian Multi-Role Helicopter and AWACS.

The Indian Air Force will buy 114 Medium Multi-Role Combat Aircraft (MMRCA) worth approximately \$18-\$20 billion. The IAF wants to keep expanding its air defence capabilities and invest in key capabilities by obtaining local and foreign-produced systems - such as Akash SAM, S-400 and MRSAM IAI. Such programmes will support segment growth

The Ministry of Defence had an exceptional year in 2023, experiencing a sharp rise in defence exports - an unparalleled



\$1.95 billion, nearly \$365 million more than in the previous year. Simultaneously, defence production surpassed the milestone of \$12.2 billion for the first time.

The Indian government has set a target of \$25 billion in defence production by 2025, with \$5 billion coming from exports. Through Defence Public Sector Undertakings (DPSUs) and ammunition production factories, the Department of

Defence Production (DDP) has created vast manufacturing capabilities for producing various pieces of defence equipment including heavy transport vehicles, weapons and ammunition, tanks, armoured vehicles, helicopters, fighter planes, military ships and submarines.

The IAF promotes 'Make in India' via targeted, sustainable, established indigenization programmes. The current focus is on reducing reliance on imported defence technology. Light Combat Aircraft, Akash missiles and Advanced Light Helicopters (ALH) have all been introduced recently. It actively supports and closely coordinates with the Defence Ministry on LCH, RPA, medium-power radars, lowlevel tracking radars and other systems, its actions in line with that of the Defence Research and Development Organisation (DRDO).

The Strategic Partner Model also aligns with 'Make in India. Shipyards have also followed the 'Make in India' model. The Indigenous Aircraft Carrier (IAC)-1 is India's largest and most sophisticated military ship, built by Cochin Shipyard Limited. Submarines, destroyers, frigates, replenishment oilers, research vessels, diving support vessels and

tugs are being built in India. Such advances will lead to increased indigenous development of various defence technologies.

The Indian defence market is moderately consolidated, with several prominent firms having market shares including Hindustan Aeronautics Limited (HAL), Bharat Electronics Limited (BEL), DRDO, Rostec and Airbus SE. The 'Make in India' policy has fostered the formation of partnerships between foreign and indigenous enterprises. This has enhanced the capacities of Indian companies. Recent partnerships have benefited HAL, Safran, Elbit Systems Ltd, Tata Motors, Bharat Forge, General Dynamics, Russian companies, L&T, Boeing and Mahindra.

India is also working to improve its domestic manufacturing capabilities to broaden the variety of local defence equipment it can make, and reduce reliance on foreign procurement. Some state-owned enterprises are developing indigenous technologies to boost local players' market share.

But there are issues galore! Imports, for example. India still relies largely on imports for vital defence technologies and components, notably high-end systems, such as fighter planes, submarines and missiles. Because of this reliance. India is subject to supply chain disruptions and geopolitical pressures.

Then there are infrastructure bottlenecks. The Indian defence manufacturing ecosystem is underdeveloped regarding infrastructure, such as testing facilities. production lines and trained labour. This might result in delays, inefficiencies and increased expenses.

Financial constraints: While defence spending is increasing, it remains restrained compared to that of other big

powers. This reduces resources available for R&D, upgrading and procuring new technology. There are also bureaucratic obstacles which complicate and delay procurement, discourage private participation and hinder development and deployment of new technology. It is critical for speedier expansion to streamline the procurement process and reduce red-tape.

Attracting Private Capital: To close the technology gap and encourage innovation, the Indian defence sector needs to attract more private investment. Private players can be enticed by creating a suitable climate with clear policies, incentives and long-term contracts.

Skilled Labour Shortage: The Indian defence industry faces a skills deficit, notably in such fields as aeronautical engineering, cyber security and robotics. Investing in education and training programmes is critical for closing this gap.

MSMEs Integration: Micro, small and medium-size companies (MSMEs) can be important in supplying components and subsystems to bigger military manufacturers. However, properly integrating MSMEs into the supply chain necessitates improved access to money, technology and market opportunities.

Geopolitical Uncertainty: The current global geopolitical environment, including the war in Ukraine and tensions with China, can disrupt supply chains and raise the cost of defence equipment. India must establish alternative sources for vital technology and minerals to offset these risks. Threats to Cyber Security: Cyber attacks on the defence sector are becoming more common, with the potential to disrupt operations and compromise sensitive data. Strong cyber security measures are crucial to safeguarding key infrastructure and information.

Cost-Quality Balance: While cost-effectiveness is critical, sacrificing quality can have major implications for national security. Finding the correct mix between price and performance is a major problem for India's defence industry.

Addressing these difficulties requires a collaborative effort by government, industry and academia. India can build a robust and self-sufficient military manufacturing ecosystem that can satisfy the country's strategic demands in the coming years by investing in infrastructure, technology and people resources. # Women entrepreneurs in India: Defying the male gaze: Shyam What is holding them back?

The Indian economy has grown steadily over the last decade, and there has been a parallel surge in the number of startups and new businesses in the country. A majority of these have been founded by men. While many Indian women have ambitions towards entrepreneurship, it is often more difficult for them to succeed. In fact, India has been found to be in a group of countries where women business owners (as well as women leaders and professionals) struggle with less favourable conditions, pronounced cultural biases, and a lack of business resources such as finances, capital, training, and development.

A society in which women cannot realise their full potential loses out on the significant potential for innovation, economic growth, and job creation. For instance, a recent study showed that in India, measures to close the gender gap could lead to a 6.8-percent gain in GDP. Another study estimated that advancing women's equality in India could boost its GDP by \$0.7 trillion in 2025 or 16 percent as compared to the 'business as usual' scenario. Moreover, entrepreneurship remains critical to harness the economic potential of women and thus, achieve the sustainable development goals (SDGs) by 2030.

This issue brief seeks to provide a comprehensive overview of the situation of women entrepreneurs in India. To this end, it gathers information on the share of businesses that are started by Indian women, and in which sectors and states they are active. It explores the underlying reasons that make it difficult for Indian women to succeed, and offers recommendations for pushing women's entrepreneurial empowerment.

The brief builds on a review of the latest literature on the subject and supplements theory with insights culled by this author during interviews with female founders and managers of startup support organisations. The interview data was obtained as part of a broader study on the Indian startup ecosystem, in which 14 of the 39 interview partners were women, who were asked additional questions and invited to share their perspectives on the subject.

#### Women entrepreneurs in India: A glance at the figures

On an individual level, some women have strong entrepreneurial ambitions. Interestingly, several of the interview partners mentioned that they got inspired by male role models such as Bill Gates or Steve Jobs, or that they were introduced to the "startup world" by their male friends who are entrepreneurs. On an institutional level, the government has launched several schemes to augment the entrepreneurial motivations of women and there is more noticeable political will to empower them.

However, looking beyond high individual and political aspirations and investigating the statistics of how many women actually own businesses shows a rather sobering balance. Literature on the subject often cites data from the Sixth Economic Census, which was conducted between January 2013 and April 2014. Out of 58.5 million businesses counted by that census, 8.05 million were owned by women, which corresponds to a rate of 13.76 percent of women among the total number of entrepreneurs in India. The World Bank Enterprise Survey, meanwhile, found that in 2014, the percentage of firms with female participation in ownership was 10.7 percent. While more recent data is not available, interview partners, as well as recent media reports, highlighted a steady rise in the number of startups founded by women. The low rates of women entrepreneurship are reflected in a dismal score in the Index of Women Entrepreneurs, where India is ranked 52nd out of the 57 surveyed countries. The fact that few women own companies is part of a larger phenomenon of weak engagement of women in business. This further relates to a low female labour force participation rate as well as women having fewer opportunities to become business leaders, professionals and technical workers. Indeed, despite high economic growth rates as well as an increase in the proportion of working-age women in the population, the participation in the work force has decreased from 35 percent in 2005 to just 26 percent in 2018. According to a World Bank Enterprise Survey, the percentage of women in leadership positions in 2014 was as low as nine percent. It is hardly a surprise, therefore, that the World Economic Forum's Gender Gap Report finds India's gender gap to be particularly prevalent in the indicator group "economic participation and opportunity," where the country is ranked 142nd out of 149 countries. India's overall rank, which takes into account three further indicator groups, is 108th. Unequal education is an issue holding women back, and it is not a coincidence that states with relatively higher literacy rates also have more women entrepreneurs. The top five states with the highest percentage of women entrepreneurs are Tamil Nadu, Kerala, Andhra Pradesh, West Bengal, and Maharashtra. To be sure, India is a highly diverse country, and so are the forms of entrepreneurship women engage in. The availability of microfinance has ameliorated women's empowerment and entrepreneurship and 98 percent of businesses owned by women are microenterprises, where approximately 90 percent of them operate in the informal sector. Interview partners observed that women entrepreneurs are often active in social areas and sectors such as health, clean energy and zero waste, education, women's hygiene, fashion, cosmetics, food and nutrition, garments and textiles, and services (such as

#### management and human resources). Causes of low female entrepreneurship rates

Regardless of gender, starting a business is a difficult prospect. Key challenges for startups in India include generating funding, limited understanding of customers, penetrating the market, hiring qualified employees, and the complex regulatory environment. For women entrepreneurs, however, there are additional barriers which are part of a broader and more pronounced gender gap in the male-dominated Indian society.

#### Unconscious gender bias

Some female founders who were interviewed by this author, who were at early stages of their careers, said that they had not experienced discrimination based on gender. While they struggled with various entrepreneurial challenges, they do not think it had to do with their gender. They saw themselves as hardworking and had faith that the best ideas will prevail, and the brightest and most passionate entrepreneurs succeed. Conversely, senior women entrepreneurs with much more experience were rather disillusioned and described being a woman founder as difficult. While it is possible that the vounger entrepreneurs had not (yet) experienced unequal treatment based on their gender, the discrepancy of perceptions could also indicate a lack of awareness of subtle bias, which is often worse than blatant discrimination. Unconscious gender bias is defined as "unintentional and automatic mental associations based on gender, stemming from traditions, norms, values, culture and/or experience," and has been found to be a key factor impeding the progress of women entrepreneurs. Automatic associations enable quick assessment of an individual and often feed into decision-making that is unfavourable towards women. Individuals, regardless of gender, hold unconscious biases

#### Confidence in business skills

Frequently-repeated stereotypes enforce the notion that "business is not a woman's world," and the belief that men are more competent when it comes to financial matters. As such attitudes reflect in communication, women entrepreneurs are often treated with less respect and they sense doubt when interacting with business partners. For instance, one interview partner (19.03.2019, Mumbai), who co-founded a startup with her husband, shared how people often talked to her as part of a 'founding' couple, "he is earning, you are helping." Countering such negative feedback makes it more challenging for women to develop a business mindset. Therefore, unsurprisingly, women often have lower confidence in their own business skills. In fact, highly successful women often struggle with self-doubt and underestimate their abilities and performance, while the opposite has been observed for men. Moreover, it has been found that practically everywhere in the world, men tend to think that they are much smarter than women, yet arrogance and overconfidence are inversely related to leadership tal-

#### Access to finance

times as much time than men on housework, household care, and other unpaid activities. As juggling between both home and company can be challenging, family support is considered a core success factor for Indian female entrepreneurs. The women who were interviewed, explained that their families "had a modern outlook" or they "understood her passion" and often mentioned, "I was lucky" – thereby implicitly suggesting that such supportive families are not the norm. One interviewee (19.03.2019, Mumbai) greatly appreciated the supportive role of her husband and quoted a prominent statement by Facebook's Chief Operating Officer Sheryl Sandberg - that the most important career choice that women make is who they choose to marry.

#### Child care

While some perceive entrepreneurial careers as difficult to reconcile with duties at home, they might, as one interview partner said (22.03.2019, Bangalore), be a good opportunity for women, allowing them to work with more flexible hours and space. However, when women entrepreneurs become mothers, they often encounter further difficulties holding them back. On the one hand, they are not entitled to maternity benefits. On the other, when women start working again, they need help and some women entrepreneurs live with or close to the grandparents, who can look after the kids. However, those who are less fortunate, struggle with a lack of options for childcare. Some women consider hiring nannies, but again, negative perceptions come into play, and interview partners pointed out that these mothers are seen as "selfish" and are made to feel guilty by their peers. Safety in work and public spaces

Finally, safety at the workspace as well as during commutes between the office and home is an issue in India. Delhi, in particular which is considered one of India's four global startup cities - continues to be notoriously poor in ensuring women's safety and has high rates of sexual crimes. Interview partners highlighted that women need to leave the office early, since public spaces are perceived as unsafe after a certain time in the evening. Moreover, the perception of danger reinforces social norms, which restrict women's mobility and thereby, their economic participation and freedom. Conclusion

Harnessing the full potential of women entrepreneurs can promote innovation, economic growth, and job creation. This brief has described the current situation in India and identified causes that explain the low female entrepreneurship rate in the country. Overcoming these barriers is a matter of grit and passion of individual women themselves, as well as tackling structural factors in the external environment, which they alone have limited control over. Accordingly, this article arrives at five sets of recommendations, which will help women seize entrepreneurial opportunities and increase their chances of success.

First, the low women entrepreneurship rates are part of a broader gender gap in economic participation and opportunity. Thus, it is crucial to provide equal access to edu-

hyam Benegal, who celebrated his 89th birthday this month, is one of the most outstanding filmmakers in Indian Cinema. He has never claimed to be a "feminist" filmmaker but his films clearly show his regard, respect, and concern for women across caste, class, status, education. They defy Laura Mulvey's theory of the "male gaze" framed in 1975 in which she says that women in films are objects of titillation that sensualises their bodies without probing into their minds. She stated that as the director

was male and so were his technicians, with the audience majorly male, the women in their films were reduced to 'objects' and not 'subjects' of the films they featured

Benegal did not subscribe to this theory. Even when he made films centered on sex workers, he saw that they were strong 'subjects' and not 'objects'

Benegal's films dabbled with women in socially sensitive contexts

Benegal's first feature film Ankur (1974) introduced the powerful FTII gold medalist Shabana Azmi. She is the wife of a deafmute farmer who is a Dalit wagelabourer played by Sadhu Meher, in the village zamindar (Anant Nag)'s home where his wife works as a housemaid.

The young zamindar manipulates an affair with the maid though he is a married man. Through these incidents, the film defines a sharp critique of casteism, sexual exploitation, silent abuse of the zamindar's wife played by Priya Tendulkar, and physical torture of the deaf-mute labourer.

• Bhoomika (The Role, 1977) was based on the autobiography titled 'Sangtye Aika' (Listen to this) penned by a famous Marathispeaking actress of her time, Hansa Wadkar. For Bhoomika, Benegal

pletely on her terms after a stormy and exploitative girlhood in which she was victimised and exploited by her own mother and her lover, financially and sexually.

It explores the invisible and little-known areas of female subjectivity. Although biographical in intent, Bhoomika's structural complexity seems to suggest that the journey of self-exploration undertaken by Usha (named Urvashi for her screen persona) portrayed by Patil when she was very fresh in films, is circular, full of snares, forever incomplete

Portrayal of complex and conflicting themes with ease was his forte

• Mandi (Marketplace, 1983) is one of the very few films that revolve around an old brothel the existence of which stands threatened because of land-grabbers, including local politicians, and landlords who wished to grab the land on which the brothel stands without offering them any alternative space.

The brothel, located along the fringes of Hyderabad city, is headed by a madam portrayed by Shabana Azmi. Benegal has used burlesque as the mode to explore the dynamics of a whorehouse. He tempers the film with an air of black comedy, allowing for some crude voyeurism in keeping with the social environment in which the women live.

Mandi makes a delightful case of depicting the conflicting and complex aspects of prostitution.

• Sooraj Ka Satvan Ghoda (The Seventh Horse of the Sun, 1992): Based on Dharamvir Bharati's noted Hindi novel of the same name, this film is not only a classic example of the transcription/interpretation of literature on celluloid, but also, one of the few celluloid experiments with the lost art of storytelling. Characters of one story telescope and move freely in and out of the other two, growing with time, and subtly hinting at the

and tortured and exploited young gypsy girl Sakti (Neena Gupta), but failing to come to a definite closure in any of the relationships. Suggested adultery enriches the

tapestry and texture of Sooraj Ka Saatvan Ghoda. Of the three women who enter Manek Mulla's life, one is adulterous purely by suggestion, even before she becomes a widow. Jamuna, forced to marry an old widower, suddenly finds herself pregnant.

But can one rightfully call it adultery? The question is left hanging in mid-air, leaving you to find the right answer which would depend on your perspective on morals underlined by patriarchy.

• Zubeidaa (2001) is said to be Benegal's costliest film before Netaji - comprising four female characters that offers an insight into Benegal's mastery in understanding and handling the woman psyche from every angle transcending barriers of communal identity, age, background, status, and education.

Apart from Zubeidaa (Karishma there Kapoor), is Fayyazi(Surekhha Sikri) her mother, who is not very educated and is Muslim. She is submissive and never raises her voice against her domineering and abusive husband Suleiman (Amrish Puri) even when he openly flaunts his keep, Rose Davenport (Lilette Dubey) in public. But Fayyazi takes a critical decision when Zubeidaa decides to marry her Hindu prince of Jodhpur, Hukam Singh(Manoj Bajpeyee) though he is already married to Mandira (Rekha) and has kids. But she does not permit Zubeidaa to take little Riyaz with her.

When Riyaaz comes to meet Rose, she is a ghost of her former self, without work or identity because, post Independence, the Anglo Indian was gradually falling out of favour with the newly formed Indian Government. Mandira (Rekha), the original queen of Hukam Singh, is officially acknowledged by the Royal family, by the Royal family and by the subjects of Fatehpur.

She speaks impeccable English but is always bejewelled and costumed royally like any Indian princess of her time. Her name is abbreviated to the British-sounding Mandy, probably motivated by the sycophantic allegiance Indian royalty bore towards the British.

But she had affection for the much younger Zubeidaa and was pleasantly surprised by her free

While entrepreneurship is an inherently risky undertaking, women are often easily assumed to be less willing to take risks. For instance, one of Indian's most successful women entrepreneurs, Kiran Mazumdar-Shaw, observed a great deal of skepticism towards women entrepreneurs and she was considered 'high-risk' by potential funders whose investment she courted for her biotechnology company, Biocon. Again, stereotypes appear to manifest in behaviour as fewer women actively approach investors and are more reluctant to divest stakes, as observed by one interview partner (22.03.2019, Bangalore). However, if women do approach investors, they are perceived differently than men, and investors have been found to prefer pitches presented by men as compared to those by women, despite identical content. Further difficulties with procuring funding occur due to the fact that Indian women rarely own property, which can be used as collateral for loans. Moreover, about 79 percent of womenowned ventures are self-financed, but families are often hesitant to support their daughters' entrepreneurial ventures finan-

#### Networks and relationships

cially.

Masculine corporate cultures are one of the most-cited barriers to women's leadership. Even a male interviewee (28.03.2019, Bangalore) described that the Indian startup ecosystem is characterised by a "bro culture" of "alpha males", where empathy is lacking and talking about emotional challenges is perceived as a weakness. For example, an article revealed a cutthroat culture in Îndia's most famous startup — Flipkart and that rumors about sexual harassment led to the resignation of co-founder Binny Bansal. Women tend to feel alienated in this culture and this explains why, as one interview partner pointed out (22.03.2019, Bangalore), women entrepreneurs do not feel comfortable in prominent industry networks. Not being part of such networks further impedes progress of women entrepreneurs because — as the broader study identified — in the Indian context relationships strongly matter. Women entrepreneurs miss important opportunities to mingle and connect with people in the market and thus, struggle even more than male entrepreneurs with getting access into the market.

#### Family support

The other side of the "business is a man's domain" coin is that predominant social norms expect women to first and foremost look after their home. In fact, many Indian women often do assume greater responsibility at home and spend, on average, five cation and encourage women to use their acquired skills by joining the workforce. Policies aimed at including more women in senior and leadership positions are needed and will help women gain experience and knowledge, which in turn will enable them to start their own businesses.

Second, awareness for unconscious biases and how they disadvantage women entrepreneurs needs to be raised. However, as changes in mindsets take time, women entrepreneurs need to deal with negative atti-— as one interview partner tudes (29.03.2019, Bangalore) expressed — by being conscious about the bias themselves. while finding ways to minimise it. Moreover, new role models have come up and shown that it is possible to "crack through conformity." Sharing their success stories in social and traditional media provides inspiration and proof that business can be a woman's world, too, and therefore strengthen the confidence of younger female entrepreneurs.

Third, women entrepreneurs in India need better access to finance and networks. Organisations such as NITI Aayog's Women Entrepreneurship Platform, Catalyst for Women Entrepreneurship, and the accelerator for women in tech initiated by Zone Startups India, provide dedicated support for women entrepreneurs. They connect them with relevant people in their industry and foster networking among the women entrepreneurs themselves, so they can learn from each other's experiences. Moreover, they assist in fundraising by teaching how to pitch and connecting them with potential investors. Studies indicate that policies aimed at reducing collateral constraints can improve equal access to finance. In the interviews, the requirement for a seed fund for women entrepreneurs was articulated.

Fourth, more inclusive, non-discriminatory, and safe work environments are needed to help retain qualified women, especially in the tech sector. Measures to improve the safety of public spaces are necessary, so women can commute between their homes and offices without the mental load of having to always worry about their security.

Fifth, women entrepreneurs need more support from their families and social circles to pursue their entrepreneurial ambitions. Household and care duties should not be understood as women's sole responsibility. Furthermore, granting maternity benefits to women entrepreneurs, improving childcare, and cultivating social acceptance would help them combine their entrepreneurial pursuits and family responsibilities.(Courtesy: ORF)

# Powerful earthquakes leave at least 48 dead; destroy buildings along Japan's western coast

1,000 soldiers to the disaster

powerful earthquakes hit western Japan, leaving at least 48 people dead and damaging thousands of buildings, vehicles and boats, with officials warning people in some areas on Tuesday to stay away from their homes because of a risk of more strong quakes.

Aftershocks continued to shake Ishikawa prefecture and nearby areas a day after a magnitude 7.6 temblor slammed the area on Monday afternoon. Forty-eight people were confirmed dead in Ishikawa, offi-

cials said. Sixteen others were seri-

ously injured, while damage to homes was so great that it could not immediately be assessed, they said

Japanese media reports said tens of thousands of homes were destroyed. Government spokesperson Yoshimasa Hayashi said 17 people were seriously injured and gave a slightly lower death tally, while saying he was aware of the prefecture's tally.

#### Militants kill 6 barbers from Punjab in Pak's Khyber Pakhtunkhwa province

PESHAWAR, Jan 2: Unidentified militants shot and killed six barbers from Pakistan's Punjab province after abducting them from the restive northwest region, police said.

The incident took place in the Mir Ali area of the North Waziristan district of the Khyber Pakhtunkhwa province bordering Afghanistan, ARY News reported on Tuesday.

The victims, who were from the Punjab province, ran barber shops in the local bazaar, police said, adding that they were abducted a day earlier and their bodies were recovered on Tues-

However, no one immediately claimed responsibility for the killings. Police have launched a search to arrest the culprits who shot and killed the six barbers.

The latest incident from North Waziristan came after five labourers were killed in the same province by unidentified militants while they were in their tents.

The gruesome act took place at a time when the province wrestled with a worsening law and order situation due to the rising terrorism at a time when the much-awaited countrywide elections were just over a month away.

The increase in terrorist acts – including attacks on military and police as well as targeted killings - is on the rise in Khyber Pakhtunkhwa, especially the former tribal belt.

SEOUL, Jan 2: South Korea's toughspeaking liberal opposition leader, Lee Jae-myung, was stabbed in the neck by an unidentified knife-wielding man during a visit on Tuesday to the southeastern city of Busan, police said. Lee, 59, the head of the main oppo-

sition Democratic Party, was airlifted to a Seoul hospital for surgery after receiving emergency treatment in Busan. Police and emergency officials earlier said he was conscious after the attack and wasn't in critical condition, but his exact status was unknown.

The attack happened as Lee walked through a crowd of journalists and others after a tour of the proposed site of a new airport in Busan. The attacker approached Lee, saying he wanted to get his autograph, and then stabbed him in the left side of his neck with a knife, senior Busan police officer Sohn Jae-han said in a televised briefing. Sohn said Democratic Party officials near Lee quickly subdued the attacker before police officers detained him. He said 41 police officers had been deployed to the area for crowd

control and traffic management. TV footage showed Lee, his eyes closed, lying on the ground as a person pressed a handkerchief to his neck to stop the bleeding. A witness, Jin Jeong-hwa, told YTN television that Lee had bled a lot. Videos circulated on social media showed the suspect, wearing a paper crown reading "I'm Lee Jae-myung," being chased and tackled by several people, apparently including plainclothes police officers. Sohn said the suspect, aged about 67, told investigators that he bought the 18-centimetre knife online. He said police are investigating the motive for

the attack Lee's Democratic Party called the incident "a terrorist attack on Lee and a serious threat to democracy." It called on police to make a through, swift investigation.

At Pusan National University Hospital in Busan, where Lee received emergency treatment, party spokesperson Kwon Chil-seung said Lee's jugular vein was believed to have been damaged and there was concern over the large amount of bleeding. Hospital officials would not comment on Lee's condition.

President Yoon Suk Yeol expressed deep concern about Lee's health and ordered authorities to investigate the attack, saying such violence would not be tolerated, according to Yoon's office.

Lee lost the 2022 presidential election to Yoon by 0.7 percentage point, the narrowest margin ever recorded in a South Korean presidential election. Since his election defeat, Lee has



been a harsh critic of Yoon's major policies. Last year. Lee held a 24-day hunger strike to protest what he called Yoon's failure to oppose Japan's release of treated radioactive wastewater from its crippled Fukushima nuclear power, his handling of the country's post-pandemic economy and his hardine policies on North Korea.

Lee faces an array of corruption allegations, including that he provided unlawful favors to a private investor who reaped huge profits from a dubious housing project in the city of Seongnam, where Lee was mayor for a decade until 2018. Lee has denied legal wrongdoing and accused Yoon's government of pursuing a political vendetta.

#### Hong Kong activist publisher Jimmy Lai pleads not guilty

HONG KONG, Jan 2: Prominent activist and publisher Jimmy Lai on Tuesday pleaded not guilty to three charges of sedition and collusion with foreign countries in a landmark national security trial in Hong Kong.

Lai, a media tycoon who founded the nowdefunct Apple Daily newspaper, faces one count of conspiring to print seditious publications to incite hatred against the Chinese and Hong Kong governments, as well as two counts of collusion with foreign countries to call for sanctions and other hostile actions against China and Hong Kong.

Flanked by three prison officers, Lai formally pleaded not guilty to the charges read to him, shortly after the court rejected a lastditch attempt by his counsel to throw out a sedition charge against him. The court began hearing opening statements from the prosecution on Tuesday.

Dressed in a navy blazer and a white shirt, Lai smiled and waved at his family members as he entered the courtroom ahead of the start of the court session. Lai, 76, was arrested during the city's crackdown on dissidents following huge pro-democracy protests in 2019. He faces possible life imprisonment if convicted under a sweeping national security law imposed by Beijing. The trial is expected to last about 80 days without a jury.

JERUSALEM, Jan 2: Israel's Supreme Court struck down a key component of Prime Minister Benjamin Netanyahu's contentious judicial overhaul on Monday, delivering a landmark decision that could reopen the fissures in Israeli society that preceded the country's ongoing war against Hamas

The planned overhaul sparked months of mass protests, threatened to trigger a constitutional crisis between the judicial and legislative branches of government, and rattled the cohesion of Israel's powerful military. Those divisions were largely put aside after Hamas militants carried out a bloody cross-border attack in southern Israel on Oct. 7, triggering a war that has raged in Gaza for nearly three months. But Monday's court decision could reignite those tensions even while the country remains at war.

Justice Minister Yariv Levin, a Netanyahu ally and the architect of the overhaul, lambasted the court's decision, saying it demonstrated "the opposite of the spirit of unity required these days for the success of our soldiers on the front." Israeli parliament takes first major

step in Netanyahu's contentious overhaul, deepening divisions

The ruling "will not discourage us," Levin said without indicating whether the government would try to revive his plan in the short term. "As the campaigns are continuing on different fronts, we will continue to act with restraint and responsibility," he said.

In Monday's decision, the court narrowly voted to overturn a law passed in July that prevents judges from striking down government decisions they deem "unreasonable." Opponents had argued that Netanyahu's efforts to remove the

#### standard of reasonability opens the door to corruption and improper appointments of unqualified cronies to important positions. The law was the first in a planned overhaul of the Israeli justice system. The overhaul was put on hold after

Hamas militants carried out their Oct. 7 attack, killing some 1,200 people and kidnapping 240 others. Israel immediately declared war, and is pressing forward with an offensive that Palestinian health officials say has killed nearly 22,000 people in Gaza.

In an 8-7 decision, the Supreme Court justices struck down the law because of the "severe and unprecedented harm to the core character of the State of Israel as a democratic country." The justices also ruled 12-3 that they had the authority to overturn so-called "Basic Laws," major pieces of legislation that serve as a sort of constitution for Israel.

It was a significant blow to Netanvahu and his hard-line allies, who claimed the national legislature, not the high court, should have the final word over the legality of legislation and other key decisions. The justices said the Knesset, or parliament, does not have "omnipotent" power. Netanyahu's government could decide to ignore Monday's ruling, setting the stage for a constitutional showdown over which branch of government has ultimate authority.

The court issued its decision because its outgoing president, Esther Hayut, is retiring, and Monday was her last day on the job.

Netanyahu and his allies announced their sweeping plan to reshape the judiciary shortly after taking office a year ago. It calls for curbing the power of the judges, including by limiting the Supreme Court's ability to review parliamentary decisions and changing the way judges are appointed. Supporters said the changes aim to strengthen democracy by circumscribing the authority of unelected judges and turning over more powers to elected officials. But opponents see the overhaul as a power grab by Netanyahu, who is on trial for corruption charges, and an assault on a key watchdog. (AP)

## Pakistan likely to get USD 700 million from IMF as next tranche of bailout this month: Report

ISLAMABAD, Jan 2: Cashstrapped Pakistan is expected to get USD 700 million as the next tranche of the bailout from the IMF as the Executive Board of the global lender meets on January 11, according to a media report on Tuesday

The board of the Washingtonbased International Monetary Fund is set to deliberate and potentially grant final approval for the disbursement of the next USD 700 million tranche for Pakistan under the existing USD 3 billion Stand-By Arrangement (SBA), the Dawn newspaper reported.

According to the IMF Executive Board calendar, upcoming meetings are scheduled for January 8, 10 and 11, with Pakistan's case slated for discussion on the last day.

The current IMF programme, amounting to USD 3 billion, is expected to conclude in the second week of April, with approximately USD 1.8 billion remaining undis-



needed financial support. The outcome of the upcoming meeting will shape the trajectory of the ongoing economic cooperation between Pakistan and the IMF. "Discussions between the IMF

staff and the authorities on policies to strengthen macroeconomic stability in the coming year continue, and important progress has been

made over the FY23 budget," the bursed. The initial tranche of IMF said in another statement. The IMF also updated economic projections and data for Pakistan, depicting a challenging outlook for the country in 2024. According to the IMF's latest figures, the projected real GDP for the year is anticipated to experience a contraction of 0.5 per cent, indicating potential economic headwinds. Simultaneously, the projection for the Consumer Price Index in 2024 shows a significant increase.

This suggests a substantial rise in

stability. Despite a surprise jump of USD 853 million in the reserves of the State Bank in the week ending on December 22, 2023, Pakistan is keen to receive the second tranche which shows Islamabad has fulfilled the IMF's demands for economic recovery.

The Ministry of Finance has recently announced that the July-December revenue collection target of Rs 4.425 trillion, given by the IMF, has successfully been surpassed by Rs 43 billion. After securing the second tranche of USD 700 million this month, Pakistan is more likely to receive the remaining amount in March under the USD 3 billion SBA. However, Caretaker Finance

Minister Shamshad Akhtar had already informed the nation that the country needs to enter a new agreement with the IMF to revive the economy.

There is no hope that Pakistan could say goodbye to the lending

agency. Despite tough conditions, Pakistan is still facing very high inflation which clocked in at 29.7 per cent for December from 29.2 per cent in the preceding month.

The latest data reveals that Pakistan has engaged in 24 arrangements with the IMF since becoming a member on July 11, 1950. This underscores the country's historical reliance on IMF support to address economic challenges, according to Dawn.

Pakistan has been facing balance-of-payments-related challenges, driven by a burgeoning trade deficit, every few years due to which the country has had 23 arrangements with the IMF over the past few decades.

The current programme with the lender was agreed to in 2019 when the country faced another balanceof-payments crisis. Since then, the IMF has disbursed about \$4 billion to Pakistan, with a balance of \$2.6 billion remaining. (PTI)

# 4 shot down in Thoubal, CM promises action Victims shot down by PLA cadres over drug money

**IMPHAL, Jan 2:** The situation in the minority-dominated Lilong Chingjao area in Manipur's Thoubal district, where four villagers were gunned down by cadres of the banned People's Liberation Army, remained calm on Tuesday as additional security forces were deployed there, officials said.

The toll in the incident increased to four after one more person succumbed to injuries, while two other critically injured persons were undergoing treatment at the ICU of an Imphal-based hospital, they said.

The deceased, whose bodies were brought to Jawaharlal Nehru Institute of Medical Sciences in Imphal for post-mortem examination, were identified as Md Daulat (30), M Sirajuddin (50), Md Azad Khan (40) and Md Hussain (22), the officials said

10 others were injured in the incident and are currently undergoing treatment at another hospital in Imphal. Four of them received gunshot wounds and two of them are currently admitted in the intensive care unit of the hospital.

The incident was seen as the fallout of a dispute over money

trade, the officials said. Giving details of the incident, the officials said that some cadres of the banned People's Liberation Army (PLA) arrived at the house of one person, who has several narcotics cases pending against him. Within minutes, around 1,000 people gathered outside the residence of the suspected narcotic dealer at Lilong Chingjao village, 15 km from the Thoubal district headquarters and chased away the PLA cadres.

On the run, the PLA cadres opened indiscriminate fire on the locals, killing four and injuring some others.

The Revolutionary People's Front (RPF), the political wing of the People's Liberation Army (PLA), issued a statement claiming

that the gunmen belonged to the outfit and they were holding an internal inquiry into the incident. Both the organisations are banned under the stringent Unlawful Activities (Prevention) Act. After the incident, police held an inter-faith meeting in the presence of civil society leaders and Lilong MLA Abdul Nasir to ease tension

Residents of Lilong Chingjao submitted a memorandum to the chief minister with a list of demands. They demanded that the investigation into the incident be handed over to the National Investigation Agency (NIA) and ex-gratia payment of ₹ 20 lakh each to the families of the deceased and ₹ 2 lakh to the injured.

Meanwhile, with curfew being imposed in five districts of Impha Valley in view of the "prevailing law and order situation", a few vehicles were seen plying roads as most commercial establishments remained closed. After the attack. enraged locals set fire to four vehicles in which the attackers had arrived. Senior Superintendent of Police of Thoubal Rakesh Balwal was among the first to reach the spot after the incident.



AGARTALA, Jan 2: A total of 744 people, including 112 Rohingyas, were arrested by the Border Security Force (BSF) while they were trying to illegally enter India from Bangladesh through the Indo-Bangla international border in Tripura, an official said on Tuesday.

This number was the highest in the last three years, with the BSF Tripura Frontier nabbing 369 infiltrators in 2022 and 208 in 2021, he said.

"In 2023, the BSF arrested a total of 744 infiltrators and of them, 112 are Rohingyas, 337 are Bangladeshis and 295 are Indians. This was the highest number of arrests of infiltrators in the frontier state in the last three years," he said.

He said BSF personnel have also seized contraband items such as banned cough syrup, cannabis, Yaba tablets and brown sugar worth a total of Rs 41.82 crore.

Besides, 4 kg of gold was also seized, the officer said.

Over the years, the BSF Tripura Frontier has performed multifarious responsibilities in fighting insurgency, maintaining the border's sanctity and preventing all kinds of trans-border crimes while working under adverse climatic conditions in remote and inhospitable terrain, he added.

**CBI files two charge sheets** against 5 in missing students' case

NEW DELHI, Jan 2: The CBI has filed two separate charge sheets against five accused in connection with the case of two missing Manipuri students who were feared killed during ethnic violence in the state, officials said Tuesday.

Photos purportedly showing their bodies surfaced on September 25, 2023, leading to violent protests, mainly by students. The CBI, however, is yet to find the bodies. The agency filed the charge sheets in the interconnected cases before a designated special court in Kamrup, giving a sequence of events before they went missing.

The agency said on July 6, 2023, the boy went to the tuition class of the girl and, after picking her up on his bike, proceeded to-

## Jairam Ramesh writes to CEC, seeks time for INDIA bloc team to put forward view on VVPATS

NEW DELHI, Jan 2: Senior Congress leader Jairam Ramesh has written to Chief Election Commissioner Rajiv Kumar, requesting that a team of INDIA bloc leaders are provided an opportunity to meet him and his colleagues to put forward their point of view on VVPATS. In his letter to Kumar, Ramesh said that on December 20, 2023 INDIA parties' leaders had requested for an appointment with the ECI to "discuss and provide suggestions on the use of VVPATs" based on a resolution passed at meeting of leaders of the bloc held the previous day. "We have been trying to meet

with the ECI to hand over a copy of this resolution and have a discussion but have not been successful so far in doing so," he said. "I once again make a request for

an opportunity for a 3-4 member team of INDIA party leaders to meet with you and your colleagues and take a few minutes to put forward our point of view on VVPATS," Ramesh said

In his letter dated December 30. 2023, the Congress general secretary also pointed out that on August 9, 2023 a memorandum had been submitted to the ECI on EVM- related concerns of INDIA parties. This was supported with several requests on August 9, 10, 16, 18 and 23 last year for a meeting of an INDIA parties' delegation with the ECI, he said. "On August 23, 2023 ECI issued

a clarification to our counsel on the memorandum. This clarification was generic in nature and (i) directed us to refer to the standard FAOs on EVMs available on ECI website; (ii) explained the legal backing for EVMs through Section 61A of the Representation of Peoples' Act, 1951; (iii) summarised judgments of High Courts and the Supreme Court on issue of EVMs; (iv) provided a chart of assembly and parliamentary election results since 2004 to show that the political party winning the maximum number of seats changed several times." Ramesh said. However, there was no meeting or hearing provided to INDIA parties' delegation despite repeated requests, he said. On October 2, 2023 a follow-up representation was sent by us through counsel, Ramesh pointed out. The representation raised specific concerns which remained unaddressed in the ECI's clarification of August 23, 2023, he said and added that no response was received on the same.

Ramesh's letter comes days after the opposition INDIA bloc asserted that there are many doubts about the integrity of the functioning of electronic voting machines and sug-gested that VVPAT slips be handed over to voters and its 100 per cent counting done later.

Leaders of several opposition parties had deliberated on the issue of EVMs, especially after the recent victories of the BJP in the state assembly elections, and felt that the entire opposition coalition should raise the matter unitedly before the people. According to the Election Commission, mandatory verification of printed voter-verified paper audit trail (VVPAT) slips of five randomly selected polling stations of each assembly constituency or each assembly segment is done in case of election to the House of the People before declaring results. (*PTI*)

Privileges panel to meet on Jan 12 on issue of suspension of opposition members

During the Winter Session of Parliament, 100 Lok Sabha members from the opposition ranks were suspended from the Lower House for unruly behaviour after they brought placards and raised slogans demanding a statement from Home Minister Amit Shah on the issue of breach of Parliament security.

While 97 members were suspended for the remainder of the Winter Session, the issue of Singh, Khaleque and Vijayakumar, who had reached the presiding offi-

## Army probing civilian deaths in Poonch, those found guilty will definitely be punished: Official

conducting an internal probe into the death of three civilians in Poonch district of Jammu and Kashmir and those found guilty will "definitely be punished," a senior government functionary said on Tuesday.

Three civilians, aged between 27 and 42, were found dead on December 22 after they were allegedly picked up by the Army for questioning in connection with a terrorist ambush a day before that left four soldiers dead in Poonch district

The deaths sparked public outrage, prompting the authorities to announce compensation for their families.

"The Army is conducting its own investigation. If anyone is found to be guilty, they will definitely be punished. But such an investigation is not to be disclosed publicly. Let the Army do its work. There is no need to prejudge anything or make any comment on the

NEW DELHI, Jan 2: The Army is that it would conduct the investigation and hence everyone should have faith in it.

> On December 27, Defence Minister Rajnath Singh said he had full faith in the Indian Army that it will wipe out terrorism from Jammu and Kashmir, even as he urged the troops to not make such "mistakes" that may hurt the citizens of the country.

It is the responsibility of the troops to win the hearts of the people while performing their duty towards the security of the nation, Singh had said.

### Criminal always a criminal until acquitted by court: CM Siddaramaiah on arrest of kar sevaks of '92

VIJAYAPURA, Jan 2: With the recent arrest of two BJP activists who had taken part in the Ayodhya agitation back in 1992 snowballing into a controversy, Karnataka Chief Minister Siddaramaiah on Tuesday said a criminal is always a criminal unless acquitted by a court of

Hitting out at Union Minister of Coal and Mines Pralhad Joshi for his jibe at the government, Siddaramaiah said Joshi does not know the law and is talking politically and not legally.

"A criminal is always a criminal unless acquitted by the court. Does crime vanish with time? Does Pralhad Joshi know the law? Crime does not fade away with time. It remains as it is," Siddaramaiah told reporters.

He was reacting to a question on the recent arrest of two 'kar sevaks' who were allegedly involved in the commotion that ensued post Babri mosque demolition in 1992 in Hubballi. The BJP criticised the Congress government

"for pursuing the politics of vendetta" against kar sevaks after 31 years of the incident. It warned the government that it will stage a vehement agitation if the kar sevaks are not released.

"Is Pralhad Joshi a legal expert or legal luminary? Is he a court? Can Pralhad Joshi's statement be accepted as a quote from the Vedas? He is talking politically and not legally. Government abides by the law," the chief minister said.

He explained that the state Home Minister G Parameshwara had ordered police officials to pursue and dispose of old cases. So the police rounded up people involved in old cases. Police have only obeyed the home minister's direction, he added.

To a question on Joshi's allegation that the government has stooped low by arresting the accused in a 31-year-old case, Siddaramaiah attributed Joshi's remarks to his "low-level men- event. (PTI)

## Odisha's Chilika Lake to remain closed for visitors till tomorrow for bird count

BERHAMPUR (ODISHA), Jan 2: Asia's largest brackish water lagoon Chilika will remain closed for visitors on January 3 and 4 for the annual bird census, officials said.

The mid-winter survey of birds in the lake will be carried out by the Chilika Wildlife Division on January 4, while training will imparted to enumerators on January 3, they said.

"We have decided to stop the entry of visitors to the lake for these two days to conduct an undisturbed bird census," Divisional Forest Officer Amlan Nayak of Chilika Wildlife Division said. He said boat associations have also been requested not to ferry visitors during this period and these bodies have assured the forest department of full cooperation for the smooth conduct of the census. Thousands of winged guests, mostly from Russia and central Asian countries, visit Chilika Lake every winter to escape the biting cold in their homelands and in search of food. They start their homeward journey before the onset of summer.

He said over 100 people, including ornithologists, wildlife activists and researchers of different organisations, including the Bombay Natural History Society (BNHS), World Wildlife Fund (WWF) and Wildlife Trust of India (WTI), will participate in the bird census. "We will form 21 teams, with five persons in each team headed by an expert, for the bird count. Each team will be provided with instruments such as binoculars," he said.

He said not a single poaching case has been registered in the division this year due to the strict patrolling at the lake. In last winter's survey, as many as 11,31,929 birds of 184 different species were counted at the 1,100 sq km blue lagoon. These included 10,93,049 feathered guests of 105 various species, and 38,859 of 79 species of resident birds, sources said. (PTI)

## CBI closes 2019 IPL betting cases over lack of evidence

NEW DELHI, Jan 2: The CBI has closed two cases related to alleged fixing of Indian Premier League matches in 2019 "based on inputs" from Pakistan due to lack of evidence, officials said on Tuesday.

The agency had filed two FIRs in May 2022 against seven people after receiving information that "a network of individuals involved in cricket betting are influencing the outcome of Indian Premier League (IPL) matches based on inputs received from Pakistan".

The CBI (Central Bureau of Investigation) named Dileep Kumar, based in Delhi's Rohini, and Gurram Vasu and Gurram Satish -based in Hyderabad -- as accused in its first FIR. Sajjan Singh, Prabhu Lal Meena, Ram Avtar and Amit Kumar Sharma, all from Rajasthan, were named as accused in the second FIR.

After nearly two years of probe, the CBI could not find enough evidence to proceed with the prosecution against them.

The agency filed a closure report in a special court on December 23, in which it has given detailed description of the allegations and its probe in the matter, besides citing reasons for recommending the closure of the case, officials said.

It will now be up to the court to decide whether to accept the report filed by the agency or order it to continue further investigations, they said.

The agency had booked these people on allegations that they were running the racket for more than 10-13 years with suspicious cash transactions being made from their accounts, the officials said.

The CBI had alleged that these individuals were in touch with Pakistani individuals through a Pakistani mobile number. (PTI)

# SC issues notice to Centre on PIL for framing of rehabilitation policy for differently-abled person

NEW DELHI, Jan 2: The Supreme Court on Tuesday sought a response from the Centre and others on a PIL seeking framing of guidelines for rehabilitation and social reintegration of mentally and physically challenged people who have no one to take care after they turn 18 years of age.

A bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra took note of the plea filed by KSR Menon, a former journalist, seeking framing of a policy or guidelines to provide aftercare facilities to such people.

The PIL, filed through law firm 'KMNP LAW AOR', referred to a provision of the Juvenile Justice (Care and Protection of Children) Act which deals with the "child in need of care and protection".

Lawyer Abir Phukan, appearing for Menon, a former news agency journalist, said the plea has been

filed for rehabilitation of children who are "mentally ill or mentally or physically challenged or suffering from terminal or incurable disease, having no one to support or look after or having parents or guardians unfit to take care".

The top court issued notices to the Ministry of Women and Child Development and the Chief Commissioner, Persons with Disability Department of the Ministry of Social Justice and Empowerment, and sought their responses within four weeks.

"The Petitioner has preferred the present writ petition, inter alia, in public interest seeking issuance of a writ of Mandamus ... direction or guidelines for the rehabilitation and social reintegration of children of Child Care Institutions (CCIs)/Juvenile Homes who are mentally ill or mentally or physically challenged or suffer from terminal or incurable disease

one to support them or take care of them upon them turning 18 years," the plea said. The petition also sought a direction for maintaining a database of all children who are in need of care and protection.

'The demands are foreseen on the grounds of Right to live a life with dignity under the Constitution and to provide rehabilitation and social re-integration with financial support," it said.

"Declare that 'Child in need of care and protection' (CNCP) recognised under Section 2(14)(iv) of the Juvenile Justice (Care and Protection of Children) Act, 2015 have a fundamental right under Article 21 of the Constitution to aftercare beyond the age of 21 years and till the time they are rehabilitated and integrated in society," it said.

The plea, which referred to various studies, said according to the 2011 census, the differently-abled

population in India stood at 26.8 million.

"In percentage terms, this stands at 2.21 %. There has been a marginal increase in the differentlyabled population in India, with the figure rising from 21.9 million in 2001 to 26.8 million in 10 years. There are 14.9 million men with disabilities as compared to 11.8 million women in the country.

There appears to be only one aftercare home in Bangalore which caters to children with special needs," it said.

It said these differently-abled people also have the fundamental right to live a life with dignity under Article 21 of the Constitution

"The child in need of care and protection as defined under the JJ Act. 2015 is a citizen of India and by virtue thereof, he/she is entitled to live a life of dignity," it said. (PTI)

# **Kerala Minister retracts controversial** remarks on bishops amid Church criticism

**KOCHI, Jan 2:** Facing criticism from various church groups for his remarks against bishops who attended the Prime Minister's Christmas programme, Kerala Cultural Affairs Minister Saji Cheriyan on Tuesday said he is withdrawing the controversial parts of his speech related to "cake and wine" that had offended them.

Cheriyan, a senior leader of the CPI(M) in Kerala, however, maintained his stance on the alleged silence of bishops regarding "violence targeting Christians" in Manipur and other parts of the country during Modi's Christmas programme.

He addressed the media, acknowledging the criticism from the Catholic Church and other Christian groups, particularly regarding his comments against priests present at the Prime Minister's Christmas event at his official residence in New Delhi on December 25.

"If there is any difficulty and pain in the remarks about cake and wine, those parts are withdrawn," Cheriyan said in response to attacks against him.

He said that the priests had raised concerns about his speech during the inauguration of a CPI(M) local committee office in Alappuzha district on Sunday evening. Cheriyan acknowledged that the mention of wine and cake in his speech may have caused dis-



#### CAA rules to be notified 'much

The TMC, led by Mamata Banerjee, has been opposing the CAA. The promise of implementing the controversial CAA was a major poll plank of the BJP in the last Lok Sabha and Assembly polls in West Bengal. The saffron party's leaders consider it a plausible factor that led to the rise of the BJP in the state.

According to the manual of parliamentary procedures, the rules for any legislation should have been framed within six months of presidential assent or seek extension from the Committees on Subordinate Legislation in Lok Sabha and Rajya Sabha.

Since 2020, the home ministry has been taking extension in regular interval from the parliamentary committees for framing the rules. More than a hundred people lost their lives during the protests or police action after Parliament passed the law. Meanwhile, in last two years, more than 30 district magistrates and home secretaries of nine states have been given powers to grant Indian citizenship to Hindus, Sikhs, Buddhists, Jains, Parsis and Christians coming from Afghanistan, Bangladesh and Pakistan under the Citizenship Act of 1955.

According to the annual report of the Ministry of Home Affairs for 2021-22, from April 1, 2021 to December 31, 2021, a total of 1,414 foreigners belonging to these non-Muslim minority communities from Pakistan. Bangladesh and Afghanistan were given Indian citizenship by registration or naturalization under the Citizenship Act, 1955.

The nine states where Indian citizenship by registration or naturalization is given under the Citizenship Act of 1955 to non-Muslim minorities from Pakistan, Bangladesh and Afghanistan are Gujarat, Rajasthan, Chhattisgarh, Haryana, Punjab, Madhya Pradesh, Uttar Pradesh, Delhi and Maharashtra.

Authorities of none of the districts of Assam and West Bengal, where the issue is politically very sensitive, have been given the powers so far. (PTI)

## Yet to take final decision on Ram Lallla idol: Temple trust

AYODHYA, Jan 2: The Ram temple trust is yet to take a final decision on which of the three Ram Lalla idols being sculpted over the past months will be installed at the temple here, those associated with the trust said on Tuesday. On Monday, BJP leader and former Karnataka chief minister B S Yediyurappa had congratulated Arun Yogiraj, a sculptor from the state, saying that the idol carved by him has been chosen to be enshrined at the new temple Ayodhya. But the Ram Janmabhoomi Teerth Kshetra Trust, which is building the temple, has not made its decision known.

The decision will be taken by the trust in consultation with Shankaracharya Vijayendra Saraswati and other seers, trust functionaries said. "Whatever is the decision of the trust, it will be made public at an appropriate time,' Prakash Gupta, office in-charge of the trust told PTI.

The chosen idol will be installed in the sanctum sanctorum and consecrated at a ceremony attended by Prime Minister Narendra Modi on January 22. The first phase of the temple's construction is now over.

Since 1949, devotees have offered prayers at a makeshift shrine housing an idol of Ram Lalla. This shrine too was shifted for the temple's construction, which began after a historic Supreme Court verdict in 2019 that

TIRUCHIRAPPALLI (TN), Jan 2: Tamil Nadu chief minister M K Stalin on Tuesday appealed to Prime Minister Narendra Modi to declare the rains that caused massive destruction in Tamil Nadu a natural calamity and immediately provide NDRF funds to facilitate relief and restoration work.

He exuded the hope that the Prime Minister would consider the plea he reiterated as the demand of the people affected by the rains.

"You are aware of the havoc caused by the rains in Chennai and the southern districts last month. Infrastructure was extensively damaged and people's livelihood was affected due to the floods," Stalin, who is also the president of the DMK, said raising the issue before Prime Minister Narendra Modi here.

The Prime Minister dedicated to the nation and laid the foundation stone for multiple development projects worth over Rs 20,000 crore here in the presence of the chief minister and Governor R N Ravi.

"The calamity is very severe. Don't think that I am repeatedly making this demand," Stalin said, adding that it was up to him to convey the will of the people

He said only the state governments, being close to the people, have the onus of providing them education, medical, and other necessary assistance. Putting forth a request and thereby asserting state rights is only "the demand of the people and not a political rhetoric", Stalin said while passionately making his submission.

"I am sure the Prime Minister will deliver on this," the chief minister added. While Chennai and its suburbs in the north were severely affected by Cyclone Michaung in early December, four southern districts bore the brunt of the unprecedented torrential rains on December 17 and 18, bringing life to a standstill.

Turning to other issues, the CM requested Modi to take steps to introduce direct air flights between Chennai and Penang and Chennai and Tokyo, on a priority basis, given Tamil Nadu's cultural and trade relations with Malaysia and Japan.

in ICU if they or kin refuse: Govt guidelines **NEW DELHI, Jan 2:** Hospitals cannot admit critically ill patients in the intensive care unit in case of refusal by them and their relatives, the Union Health Ministry has said in its recent guidelines

on ICU admissions. The guidelines compiled by 24 experts further recommended that when no further treatment is possible or available in a disease or in terminally ill patients if the continuation of therapy is not going make an impact on the outcome, especially survival, then keeping in ICU is futile care.

Further, anyone with a living will or advanced directive against ICU care should not be admitted to ICU.

Hospitals cannot admit critically ill patients

Besides, low priority criteria in case of pandemic or disaster situation, where there is resource limitation, should be taken into account for keeping a patient in the ICU.

Criteria for admitting a patient to ICU should be based on organ failure and need for organ support or in anticipation of deterioration in the medical condition, the guidelines stated.

Altered level of consciousness of recent onset, hemodynamic instability, need for respiratory support, patients with acute illness requiring intensive monitoring and/or organ support or any medical condition or disease with anticipation of deterioration have been listed as criteria for ICU admission.

Patients who have experienced any major intraoperative complication like cardiovascular or respiratory instability or have undergone major surgery also feature among the criteria. (*PTI*)

"In general, Russia will continue to promote all aspects of the BRICS partnership in three key areas: politics and security, economy and finance, and cultural and humanitarian contacts," he said.

"Naturally, we will focus on enhancing foreign policy coordination among the member countries and on jointly seeking effective responses to the challenges and threats to international and regional security and stability," he said. Putin said the priorities under the Russian presidency of the grouping will include promoting cooperation in science, high technology, healthcare, environmental protection, culture and sports.

"In total, over 200 events of different levels and types will be held in many Russian cities as part of the chairmanship," he said.

"We encourage representatives of all countries interested in cooperating with our organisation to take part in them. The BRICS Summit in Kazan in October will be the culmination of our chairmanship," he added.

Putin said the Russian presidency of BRICS will focus on contributing to the practical implementation of the strategy for BRICS economic partnership 2025 and the action plan for the grouping's innovation cooperation 2021-2024 for ensuring energy and food security. (PTI)

## Prime Minister Modi visits Lakshadweep, highlights decade of development in Islands

AGATTI (LAKSHADWEEP), Jan 2: Prime Minister Narendra Modi said on Tuesday that numerous developmental projects have been completed in Lakshadweep over the past 10 years of his government, and the Centre is committed to the progress of the islands.

The Prime Minister addressed a public function immediately after his arrival at Agatti Airport. During his address, Modi noted the immense possibilities that Lakshadweep offers and alleged that the islands faced neglect for many years after independence.

"The union territory is full of many possibilities, but for a long time after independence, the infrastructure of Lakshadweep was not given much attention," he said.

He mentioned weak port infrastructure, despite shipping being the lifeline of the islands. This applies to education, health, and even petrol and diesel as well, he said.

"Even though shipping is the lifeline of the archipelago, the port infrastructure is weak. Whether it's health, education, or even petrol and diesel, we had to face a lot of problems. All these challenges are being addressed by our government," Modi said.

He said that the government has now taken up the task of developing the Lakshadweep Islands in earnest.

Expressing optimism about the newly introduced ice plant at Agatti, the Prime Minister emphasised that it would pave the way for enhanced seafood processing possibilities on the island.

The Prime Minister said that many development projects were completed in Agatti in the past 10 vears and mentioned the creation of modern facilities, especially for fishermen. He also touched upon the fact that Agatti now has an airport as well as an ice plant.



Thanks to this, Modi said, new possibilities are being created for the seafood export and seafood processing sectors.

He mentioned the initiation of the export of tuna fish from Lakshadweep, which has also paved the way for increasing the income of the fishermen in the union territory.

Referring to new development projects, the prime minister mentioned the inauguration of a solar plant and an aviation fuel depot to meet the electricity and other energy needs of Lakshadweep. He also spoke about providing tapped water connections to all houses on Agatti Island and reiterated the government's efforts to ensure houses. toilets, electricity, and cooking gas for the poor. "The Government of India is working with full commitment for the development of the entire Lakshadweep, including Agatti," Modi added. During this visit to Lakshadweep, the Prime Minister will inaugurate and dedicate to the nation development projects worth more than Rs 1,150 crore

In what would become a transformational initiative, the prime minister had resolved to overcome

the challenge of slow internet speed on Lakshadweep Island with the Kochi-Lakshadweep Islands Submarine Optical Fiber Connection (KLI -SOFC) project, which he had announced in his Independence Day speech in August 2020 at Red Fort.

The project has now been completed and will be inaugurated by the PM, an official statement said. This will lead to an increase in internet speed of more than 100 times (from 1.7 Gbps to 200 Gbps) in the islands.

For the first time, Lakshadweep will be connected through submarine optical fibre cable, it said. The statement said the dedicated submarine OFC will ensure a paradigm shift in communication infrastructure in the Lakshadweep islands, enabling faster and more reliable internet services, telemedicine, e-governance, educational initiatives, digital banking, digital currency usage, digital literacy, etc.

The PM will also inaugurate the Low Temperature Thermal Desalination (LTTD) plant at Kadmat.

This will produce 1.5 lakh litres of clean drinking water every day.

Modi will also dedicate to the nation the Functional Household Tap Connections (FHTC) in all households on the Agatti and Minicoy islands. Other projects include the solar power plant at Kavaratti, which is the first-ever battery-backed solar power project in Lakshadweep; the laying of the foundation stone for the renovation of the primary health care facility in Kalpeni; and the construction of five model Anganwadi centres (nand ghars) in the five islands of Androth, Chetlat, Kadmat, Agatti, and Minicoy, the statement added.

The Prime Minister is scheduled to stay overnight on the islands. (PTI)

LOS ANGELES, Jan 2: Mexican actor Ana Ofelia Murguia, who voiced the role of Mama Coco in Disney's two-time Oscar-winning animated feature film Coco has died. She was 90. Murguia passed away on December 31, 2023.

The news of her demise was shared on Monday by Mexico's National Institute of Fine Arts and Literature. "With deep sadness we regret the sensitive death of the first actress Ana Ofelia Murguia, who was part of the stable cast of the @CNTeatromx del #INBAL and whose artistic career was vital for the performing arts of Mexico. We send condolences and warm hugs to her family and friends," the institute wrote on X.

Born in Mexico in 1933, Murguia's career spanned over 40 years in movies and television during Mexican cinema's golden age. She received the Golden Ariel lifetime achievement award, the highest honour given by the Mexican Academy of Cinematographic Arts and Science, in 2011. She also won best supporting actress at the Ariel awards in 1979, 1986 and 1996.

Murguia's acting credits include The Queen of the Night (1994) and Nobody Will Speak of Us When We're Dead (1995). Coco followed the story of an aspiring musician Miguel (Anthony Gonzalez) who has to face his family's prejudices against music.

On the Day of the Dead, he ventures into the Land of the Dead and encounters his ancestor, a legendary singer. At the climax, Murguia's Coco sings the film's Oscar-winning song Remember Me with Miguel in the memory of her father. Coco also won an Academy Award for best animated film in 2018. (PTI)

# Sriram Raghavan on Merry Christmas-**Pinocchio connection: It's a story of deception**

NEW DELHI, Jan 2: Sriram Raghavan says his upcoming thriller "Merry Christmas", starring Katrina Kaif and Vijay Sethupathi, is set in the early '80s and shares a thematic connection with the story of "Pinocchio".

Raghavan, regarded as the master of the thriller genre in India, returns to direction with the film after 2016's hit "Andhadhun" and hopes the audiences engage with the story that unfolds within a span of one night. It will hit the screens on January 12.

The trailer of "Merry Christmas" shows the two central characters walking past a theatre showing the children's classic "Pinocchio", about the titular wooden puppet whose nose grows longer when he lies.

"We have not specified the time but it is set in the early '80s. 'Pinocchio' has many movie versions so we decided to design our own version of the 'Pinocchio' poster. We haven't shown the movie on screen, you will only hear the soundtrack. So, thematically it's very much like

our film because it is about deception. When Pinocchio tells lies, his nose gets longer," Raghavan told PTI in an interview.

The filmmaker said it was challenging to cut the trailer of the Hindi film as he wanted to create intrigue about the plot of the movie, which he shot simultaneously in Tamil. "The Hindi trailer was more fun because it's got these quick cuts. The whole aim was to not give away the story and make viewers think of their own stories so that when they come to the cinema hall, they're surprised. Occasionally, one of them will be right too," he said.

The Hindi trailer of "Merry Christmas" seems like a time capsule, taking viewers back to the era of weighing machines, landline phones and single-screen theatres.

Raghavan, 60, said he decided to include these elements as they are all gone now.

"These are iconic things of that era and it has all gone now. I remember I would go to the railway station just to check my weight and get

that little card, which had a picture and something written on it. I used to collect those. This is why we chose it for our film."

The idea to set the film within the span of a night was also by design, said the director, known for cult classics like "Ek Hasina Thi", "Johnny Gaddar", "Badlapur" and his biggest hit, "Andhadhun". Raghavan said one of his earliest memories is watching Yash Chopra's 1969 thriller "Ittefaq", starring Rajesh Khanna and Nanda, which was also set in the course of a night. "I think one-night stories are a genre in themselves because there can be all kinds of stories. I remember seeing Yash Chopra's 'Ittefaq' and I was completely blown away by that movie and performances. Even 'Die Hard' (the 1988 Hollywood hit featuring Bruce Willis) was a one night and a Christmas story.

"I like the sub-genre of one-night stories because it's tough to hold the attention of the audience. It's exciting to think how you are going to compress time and space, and make the story work," he added.

"Merry Christmas", according to the filmmaker, is an intimate story of two mysterious strangers. "You meet them on this particular day. What they were doing before, how much of what they are saying is true or false, it is all left to you to make assumptions as a viewer. These two strangers are meeting each other and the viewer is meeting each of them, and we have to figure out, 'Okay, what's happening here?' It just makes you curious," he teased.

Just like his films, chance played an important role in the unique casting of Kaif and Sethupathi. Kaif had once spoken to Raghavan about doing a film that is "out of her comfort zone" and that conversation stayed with him.

"It is unlike the films she has done so far which largely, and I'm saying largely, project her as a very glamorous person. She once met me two years back and said she would love to do something in this sort of a zone. Luckily, I found this story," he recalled.

The director said he was looking for an "oddball" pairing, but most of the suggestions that came up for the leading man seemed a bit too familiar. "By chance, I met Vijay Sethupathi in Melbourne, where he was getting an award for 'Super Deluxe' and Tabu was getting an award for 'Andhadhun'. In the flight, it was fortuitous that I happened to see '96', starring Sethupathi, and then I landed and met the actor.

"I told him, 'I just saw your movie' and in my mind I kept thinking, 'What if this is the guy?' He's a Tamilian who speaks Hindi as he has lived in Dubai for three years. The language is not really alien to him," he said.

Raghavan said he kept thinking about Sethupathi and finally spoke to his team. Later, they also came onboard with the idea.

"This casting is so oddball that I hope it will create curiosity. You can't write chemistry on paper. Chemistry has to be performed and enacted. It has to come through. What they have managed is difficult to achieve." (PTI)

#### Crystal Dunn signs with NWSL champion Phoebe Litchfield's 119 fires Australia Women's to highest ODI total of 338/7 against India NJ/NY Gotham FC through 2026 season

MUMBAI, Jan 2: Phoebe Litchfield continued her rich vein of form with a magnificent century as Australia Women flayed India to post their highest ever total of 338 for seven in the third and final ODI here on Tuesday.

Litchfield cracked as many as 16 fours and a six to make 119 off 125 balls and put on a record 189-run stand for the first wicket with Australia captain Alyssa Healy, who also cashed in on the opportunity with an 85-ball 82 (4x4s, 3x6s).

Australia, who already have the series in the bank, were relentless with the bat from the word go and despite Shreyanka Patil's 3/57, the visitors made merry on a placid wicket that proved to be a batting haven.

Litchfield and Healy's 189-run stand is now the highest for any wicket among all the visiting sides in India in the 50-overs format, bettering South Africans Lizelle Lee and Laura Wolvaardt's 169-run partnership for the first wicket in 2021.

Having possibly missed out



on making tons in each of the first two ODIs with scores of 78 and 63, Litchfield showcased her rich arsenal of strokes all

around the park to flatten India. Litchfield, however, was also lucky when Deepti Sharma could not hold onto a tough div-

ing catch to her left, off Amaniot Kaur (10-0-70-2) in the 19th over, when the batter was on 62. If it was any consolation,

eepti had Lichfield caught by Harmanpreet Kaur in the 40th over and with that the right-arm spinner became only the fourth Indian to have taken 100 wickets in one-day cricket.

Patil was the most successful Indian bowlers with 3 for 57 in her 10-over spell, with her twin strikes in the 36th over providing some respite on a tough day out in the field for her teammates. Patil trapped Beth Mooney (3) and Tahlia McGrath (0) leg-before on consecutive deliveries to peg Australia back, albeit momentarily, as the visitors' aggressive approach again brought them back on top.

Ashleigh Gardner's 27-ball 30 with four fours, Annabel Sutherland's 21-ball 23 (2x4s, 1x6s) and late fireworks yet again from Alana King — 26 not out off 14 balls, three sixes, one four — helped Australia better their own record.

King took 19 runs off Vastrakar's final over as Australia bettered their own record for highest-ever total against India in ODIs. Australia had made

332/7 in March 2018 at Vadodara.

Apart from a slew of misfields and dropped catches, Indian team was also guilty of conceding 28 extras, which gave further push to the visitor's massive total

Early on, Healy was lucky when she got an inside edge which fell short of wicketkeeper Richa Ghosh off Vastrakar in the ninth over.

# *Liverpool possible destinations for* PSG star Mbappe

PARIS, Jan 2: As the New Year begins, so does the countdown on Kylian Mbappé's future.

It promises to be a nervous start to 2024 for Paris Saint-Germain and its fans with speculation set to intensify about their prolific striker, one of only two players in soccer history to score a hat trick in a World Cup final.

Mbappé began this season in a transfer standoff with his club after not taking up the option of a 12month extension into 2025. It means that, starting Jan. 1, he can openly talk to other clubs or even sign a pre-contract agreement with long-time suitor Real Madrid or Premier League leader Liverpool. Mbappé can do so because his

contract runs out in June, when he can leave the defending French champion for free, having joined from Monaco --- initially on loan in 2017 — for 180 million euros (now \$199 million).

The France star is PSG's alltime leading scorer with 233 goals despite only recently turning 25, and has already netted some 46 goals for Les Bleus.

But it has been frustrating at times for Mbappé at PSG, which failed to reach the quarterfinals of the Champions League in the last two seasons and has scraped through to the last 16 in second place this season.

Despite having scored 21 goals in 22 games in all competitions so far this season, Mbappé failed to make his mark when PSG lost 4-1 at Newcastle and 2-1 at AC Milan. His frustration has been seen in some of PSG's league games over the past three seasons, when bad defending and a lack of teamwork has led to soft goals being conceded.

Mbappé has said he wants to win the Ballon d'Or — soccer's most prestigious individual prize

and the Champions League But whether he can win either with PSG remains to be seen and, at age 25, the time could be right for him to leave PSG as he enters his peak years.

Here's a look at where Mbappé might go:

#### **ŘEĂL MADRID**

Will it be third time lucky for the Spanish powerhouse with a record 14 European Cup titles?

PSG rejected an offer of 180 million euros for Mbappé in 2021 and Madrid missed out a year later when Mbappé — amid frenzied speculation that Madrid would finally get him to join - signed a new deal with PSG in May 2022.

Mbappé held aloft the PSG jersey that day with 2025 on the back. But he was reportedly annoyed because the actual deal only took him to 2024 and, while good PR for the club, it was also seen as somewhat presumptuous to expect he would sign the extension given his world renown.

Mbappé has spoken about his affection for Madrid but, if he does not join this time, then the move may never happen. Coach Carlo Ancelotti has re-shaped the attack since Karim Benzema left and it is functioning well.

#### LIVERPOOL

Mbappé's English is near-fluent and he's at ease conducting interviews after Champions League games with British broadcasters.

It would make his transition to the Premier League even easier, for his speed, strength on the ball, dribbling and lethal finishing are all attributes that would serve him well.

have his contract ripped up. There was a bit of a fight to keep him because he was so important to the team. (There was) the confidence, being his captain, that (at) the start of his career that like all of us, we are young, (he) needed to learn lessons along the way." "Davey's game has really been learnt at the highest level, playing for Australia, which is not easy to do. So I think he de-

serves a lot of credit." Warner's aggressive brand of cricket did not convince many at the start of his career when he made the cut to Australia firstclass cricket from T20s. But Clarke said he proved the doubter's wrong.

"He's had a stellar career, opening the batting (is) such a hard position," Clarke said. "There were a lot of doubts

"And he's been able to manage that role as an opening batsman but keep his intent, which is eas-

ier said than done.' Speaking further about Warner, Clarke drew a parallel with former Australia openers Matthew Hayden and Michael Slater.

"An Australian batsman that set the tone when it came to opening batting was Matthew Hayden -- I used to love watching Haydos and Michael Slater walk out and bat and play that aggressive role -- and think Davey continued in that manner.'

"If the ball was full and there to drive early in his innings he'd take it on, if it was short he takes on that pull or hook shot, he wanted to score runs. That's the name of the game but it's easier said than done, trying to do that

against a brand new ball in Test cricket. Deserves a lot of praise," Clarke added.

He said it's perfect timing for Warner to retire from the Test format at his home town Sydney.

'Guess I thought it would have been the ideal time to walk away from international cricket in general but (he) wants to keep playing T20 cricket," Clarke said.

CAPE TOWN, Jan 2: The Ajit Agarkarled selection committee will have some sleepless nights before selecting the squad for T20s against Afghanistan with veterans Rohit Sharma and Virat Kohli keen to play the World Cup in June.

Both Rohit and Kohli have not played in the shortest format for India since the T20 World Cup semifinal against England in November 2022.

The two national selectors, Shiv Sunder Das and Salil Ankola are both here and will be joined by their chairman Agarkar during the course of the second Test at Newlands.

It is expected that Agarkar and Co will speak to head coach Rahul Dravid along with Test and ODI skipper Rohit, star batter Kohli before announcing the squad against Afghanistan. Around 30 T20 specialists, including India and IPL stars, will be monitored ahead of the ICC event in Caribbean and United States.

It remains to be seen whether Agarkar and his colleagues select both Rohit and Kohli for the short series starting January 11 in



Mohali or directly check their form and fitness during IPL. The two contemporary legends have apparently made it clear that they would very much like to be part of T20

World Cup. With England Tests starting in Hyderabad from January 25, it is unlikely that even if Rohit and Virat are selected, they would play beyond a couple of matches.

# Several grapplers seek UWW intervention in resolving wrestling crisis in India People from all walks of life get together to bid adieu to Sandeep Chattoo

**NEW DELHI, Jan 2:** Several international medal-winning wrestlers from different states have approached the world governing body UWW, requesting its intervention for restoration of the suspended WFI and accused Bajrang Punia, Vinesh Phogat and Sakshi Malik of orchestrating a "fake agitation". The three wrestlers had led a protest against former WFI chief Brij Bhushan Sharan Singh, alleging that he has sexually exploited women wrestlers and sought his arrest. The matter is being heard by a Delhi court and Brij Bhushan is out on bail.

The National camps have not been held for a long time due to the on-going tussle between the elite wrestlers and the BJP MP. An ad-hoc panel ran the sport till recently but was brought back to handle day-to-day affairs of the sports body after the newly-elected body was suspended by the Sports Ministry.

"I would like to inform you that due to fake agitation of three wrestlers, the wrestling in India has been destroyed. I am a woman wrestler but I did not face any sexual demand from the previous president," wrote an Asian Games and CWG medal-winning wrestler.

"I thought after the election of WFI, this controversy will be over but these three wrestlers are trying to damage wrestling in India. Being a woman wrestler, I personally contacted many women wrestlers but no one corroborated the version of these wrestlers.

"My humble request to UWW is to interfere in the matter and a permanent Federation may please be established in India otherwise wrestling will be destroyed," the Arjuna awardee added.

It may be mentioned that United World Wrestling (UWW) had suspended the WFI on August 24 for not holding elections on time and Indian wrestlers had to compete as neutral athletes at the World Championships last year.

A junior wrestler from Maharashtra, in her letter to UWW President Nenad Lalovic, wrote how their careers have been stalled in the absence of junior national championships.

"Since two years, there is no sub junior and junior competition, the wrestlers are not getting the chance to show their talent as there are only three senior players (creating controversy) and on top of that due to politics, a big crisis has come ..... Please give justice to Indian wrestlers by activating Wrestling Federation of India," the wrestler wrote.

The newly elected body WFI had announced immediately after the polls that U15 and U20 Nationals will be held in the last week of December in Gonda, UP but due to WFI suspension, the competitions could not be held. Interestingly, the minor who filed a sexual harassment complaint against Brij Bhushan before withdrawing it, also wrote to the UWW admitting that her father filed a fake complaint against the former WFI boss.

JAMMU, Jan 2: Hundreds of people from all walks of life including sports personalities bid adieu to Sandeep Chattoo, a prominent businessman and the owner of Real Kashmir Football Club (RKFC), as he was cremated here on Tuesday. Chattoo, 57, died in Gurugram on Sunday after suffering a heart attack. He is survived by his mother, wife, and two children.

His body was flown from Delhi to his native place Jammu where people paid their last respects to Chattoo, who is widely acknowledged for his pivotal role in reinvigorating football in the insurgency-affected Kashmir valley. The last rites were performed by his son Samarth in the presence of many mourners who had turned up to pay their last respect to the departed soul. Chattoo's death has left the football community in shock and grief, particularly in Jammu and Kashmir, where he made significant contributions to the sport. As a hotelier, Chattoo founded RKFC in 2016 with the aim of providing a platform for local players to showcase their talent.

Under his leadership, the club achieved great success, including winning the second division I-League in 2018 and securing victory in the 123rd edition of the IFA Shield in December 2020.

Chattoo's unwavering commitment to promoting local talent resulted in many individuals from Jammu and Kashmir participating in India's premier football leagues. His passion for football and dedication to uplift the young athletes will always be remembered.

Sportspersons, political parties, and football associations have expressed their condolences and paid tributes to Chattoo's legacy.

Former chief minister and Lok Sabha MP Farooq Abdullah and National Conference party's vice president Omar Abdullah described him as "an invaluable jewel" who worked tirelessly for the youth of Jammu and Kashmir. "Chattoo's death is a huge loss, especially for the people of Kashmir where he did a tremendous job in the sports arena and creating jobs. His only urge was to do something for the locals and he proved it by his dedication and commitment," Apni Party vice president and former minister Usman Majid Wani told PTI.

## Cape of 'Good Hope': Indian bowlers face tall task as Rohit seeks redemption

CAPE TOWN, Jan 2: Rohit Sharma, the leader, will need to channelise the champion tactician that resides in him as India look to restore parity against South Africa and remain consequential in the World Championship points table when the second Test starts here on Wednesday.

India are sixth in the nine-team table with 14 points (38.89 PCT) and a defeat will dent their standing further, Ravindra Jadeia, India's "Most Valuable Player" across formats, will come back to add the requisite middle-order batting balance and steady overs with the old Kookaburra but it will be the skipper's choice of third and fourth speed merchants that will define the embattled team's response.

As harsh as it might sound, no one knows more than Rohit that Prasidh Krishna is pretty undercooked to counter the vagaries of Test cricket and Shardul Thakur's bits and pieces talent will not win him much on most days.

But with three top-order batters, Yashasvi Jaiswal, Shubman Gill and Shreyas Iyer compounding the team's worries with their ineptitude while dealing with the bouncer barrage, Shardul's presence gives the side an assumption of batting depth on paper.

Save KL Rahul in the first innings and Virat Kohli in the second essay, none of the Indian batters could cope with the extra bounce and lateral movement at Centurion.

With one loss and one draw in three Tests in the new World Test Championship cycle, India would be desperate for a win, which will be easier said than done at the picturesque cricket stadium where the visitors have lost four of their previous six games

The last six weeks of 2023 haven't exactly been kind to Rohit, who is still trying to pick up the pieces after India's World Cup final defeat.

That final and Rohit have become a tragic love story, and what has added humiliation to the mix is the two and half day defeat at Centurion in the run up to the New Year. The skipper stood as exposed tactically as his batters and bowlers were found to be inept technically in an innings and 32 run defeat.

There would be no better way to start 2024



than a win at the Newlands ground with the breathtaking Table Mountain adding to the scenic backdrop.

But South Africa have had an upper hand against India at this venue and Dean Elgar, who would captain South Africa in his last Test appearance wouldn't want that Rohit becomes the second skipper after Mahendra Singh Dhoni to at least draw a Test series in the Rainbow Nation. The toss will be crucial at Newlands which is recording temperatures of 33 to 34 degrees and despite decent grass covering, the pitch will be a batting paradise with little help for spinners from either side.

It will therefore not be prudent to retain Ravichandran Ashwin given that Jadeja is fit and available for selection.

However, Rohit's biggest decision as skipper would be whether to rely on his specialist batters and replace Shardul and Prasidh with Mukesh Kumar and Avesh Khan.

There's no guarantee that the two rookies, with a combined experience of one Test (played by Mukesh), will pull any rabbit out of the hat. But with their solid experience of first-class cricket, their presence might just give the skipper a stronger shot at a win.

Mukesh has bowled extended spells and is certainly more effective compared to Shardul while Avesh could be the proverbial hit-thedeck bowler, who can put the red cherry on hard lengths and extract steep bounce.

But on a track, which gets better for batting with the passage of time, Dean Elgar, Aiden

Markram, Tony de Zorzi, Keegan Petersen, David Bedingham are a formidable force.

To counter them, the new ball overs will be vital. Jasprit Bumrah would pray that there is a suitable cloud cover known as "Table Cloth" over the mountains and he is not as unlucky as he was at Centurion where he beat the bat 26 times in his first spell without much success.

If the bowlers need to step up, Rohit, the skipper would also need to tell "Rohit the batter" to buck up. He might be a compulsive hooker and puller of the short ball, but in his heart, Rohit knows that only one career Test hundred in SENA countries in a decade is not a fair reflection of his abilities.

The peerless Kagiso Rabada has made him his bunny and the Indian captain needs to outthink the legend in the making.

Lungi Ngidi, who also asks probing questions, won't make life any easier for the Indian skipper and his colleagues.

There would also be the young Nandre Burger to expose the Indian batting line-up's historically fragile technique against left-armers. He would be bowling in and around the ribcage, occasionally slipping a fuller one across the line. Virat Kohli looked in imperious form during both innings of the last Test, getting a beauty from Rabada in the first essay and running out of partners en route his 76 in the second innings.

However, there are plenty of questions for a circumspect Indian team and sooner it gets the answers, the better it will be for its captain. Squads:
