Missing minors

JORHAT: In a heartening development, two minor girls who had been reported missing from Nagaon district were found on Monday at Maleng Balisapori under Bhogdoi police outpost in Jorhat. The girls, along with a minor boy from Charigaon, were rescued following a tip-off from the village's Gaon Burah. According to R. Bagliari, in-charge of the Bhogdoi police outpost, the Gaon Burah informed them about the presence of the two girls and the boy in a house in the village. Acting swiftly on the information, the police proceeded to the location and successfully rescued the minors. "The boy was reportedly in a relationship with the elder sister of one of the minor girls and would frequently visit her in Nagaon. On one such visit, the younger sister and her friend accompanied him to Jorhat, ostensibly to pursue their studies," stated the Bhogdoi police in-charge. The police informed the parents of both girls, who are en route to Jorhat to reunite with their daughters. The Bhogdoi police assured that necessary actions would be taken in coordination with the families to ensure the well-being and safety of the minors. This incident underscores the importance of community vigilance and prompt police response in safeguarding vulnerable individuals, especially minors, from

GUWAHATI, Feb 19: Assam Police has summoned Congress MLA Jakir Hussain Sikdar and another party leader for questioning in connection with a clash that took place when Rahul Gandhi-led 'Bharat Jodo Nyay Yatra' entered Guwahati last month, officials said on Monday.

The Criminal Investigation Department (CID) of Assam Police has issued the summons to Sikdar and Guwahati City Congress general secretary Ramen Kumar Sarma and asked them to appear before it at 11:30 am on February 23.

"The case is still under investigation. We have issued notices to two persons under Section 41A of CrPC. We are looking into the role of other people in the case," a senior Assam Police official told PTI on condition of anonymity.

Along with Gandhi, other senior Congress leaders such as KC Venugopal, Jitendra Singh, Jairam Ramesh, Srinivas BV, Kanhaiyya Kumar, Gaurav Gogoi, Bhupen Kumar Borah, Debabrata Saikia and others have also been named in



workers in presence of Gandhi and other leaders broke police barricades, which were put up after chief minister Himanta Biswa Sarma threatened to file an FIR if the Yatra attempted to enter the main Guwahati city.

The party workers clashed with police, who used mild lathicharge to control the situation, but failed to protect the barricades. Several police personnel and party workers were injured in the scuffle.

After dismantling the barrier, the Congress workers, however, did not proceed further with Gandhi stating that

they "can break barricades, but will not break law" and moved through its permitted route along the NH-27 in Guwahati.

This episode prompted the chief minister to term the action as "naxalite" style and instructed police to register a case. Guwahati Police lodged a suo motu FIR against Gandhi and other leaders for "wanton acts of violence"

Sarma even announced that the "instigators", including Gandhi, will be arrested after Lok Sabha polls as he does not want to "politicise" the issue before the general elections. The chief minister, who also

holds the charge of the home department, later announced that a Special Investigation Team (SIT) will be formed to probe the case and accordingly,

was handed over to the CID. The case was initially filed at Basistha Police Station under 10 different sections, including nonbailable ones, such as 120B (criminal conspiracy), 143 (unlawful assembly), 147 (rioting), 188 (disobedience of order), 283 (causing danger, obstruction or injury) and 353 (criminal force to deter public servant from discharging duty) of the IPC. Section 3 of the Prevention of Damage to Public Property Act, 1984 for alleged mischief causing damage to public property has also been slapped in the FIR. Similarly, another FIR was registered against the 'Bharat Jodo Nyay Yatra' and its organisers such as KB Byju, Assam Congress chief Bhupen Kumar Borah and others for allegedly deviating from its permitted route inside Jorhat town, leading to a "chaotic situation" in the area. Ops on to rescue abducted Assam miners

TINSUKIA, Feb 19: Efforts are on to trace three miners from Assam, who have allegedly been abducted by militants in Arunachal Pradesh, police said here on Monday. At least three miners were allegedly kidnapped by suspected militants from Febru Basti in Changlang district of Arunachal Pradesh on Sunday, Tinsukia police said. "Operations by police forces and Assam Rifles are underway. Details will be shared later," a senior officer said. Those who have been kidnapped are identified as Gyan Thapa, Lekhan Bora and Chandan Narzari but the exact number of abducted persons is not vet known, Tinsukia Superintendent of Police Abhijit Gaurav said. It is not clear whether they were engaged in illegal mining activities or not. According to reports received from Arunachal, workers at a coal mine in Febru Basti area of Changlang district were abducted by suspected ULFA (I) and NSCN militants. (PTI)

ment think tank NITI Aayog has pitched for tax reforms, mandatory saving plan, and housing plan for elderly in India, as the population of senior citizens is projected to reach 19.5 per cent of the country's population by 2050.

In a report titled 'Senior Care Reforms in India - Reimagining the Senior Care Paradigm', NITI Aayog said a national portal for senior care must be developed for senior citizens to provide easy access of services to them.

"Since the social security framework in India is limited, most seniors depend on the income generated from their savings. Variable interest rates result in the erosion of their income, sometimes even below sustenance levels.

"Therefore, a regulatory mechanism is required to set a viable base rate for the interest accrued on senior citizen deposits," the report said.

The report emphasised that giving a further concession to older women will contribute to their financial well-being.

closed higher for the fifth consecutive day on Monday with the benchmark Sensex rising 281 points and Nifty scaling its fresh lifetime high driven by gains in financial and FMCG shares.

The 30-share BSE Sensex rose by 281.52 points or 0.39 per cent to close at 72,708.16. As many as 17 Sensex shares advanced while 13 closed in the red. After a firm start, the index hit a high of 72.881.93 in day trade.

The broader Nifty closed at its all-time high of 22,122.25 points, up by 81.55 points or 0.37 per cent from the last close.

The 50-issue barometer also scaled its intra-day record high of 22,186.65 helped by gains in pharma, banking and oil shares. As many as 27 Nifty shares posted gains while 23 declined.

"The overall sentiment appears to position Nifty for a potential upward movement towards 22,500-22,600 in the short term. The immediate crucial support is situated at 22,000," said Rupak De, Senior Technical Analyst, LKP Se-

Mcap of BSE-listed firms hits new peak at ₹ 3.91 lakh cr

MUMBAI, Feb 19: Investors became richer by ₹ 2.20 lakh crore on Monday and the market capitalisation of BSE-listed firms reached an all-time high of ₹ 3.91 lakh crore as buoyant sentiment sustained the stock market rally for the fifth straight session.

The 30-share BSE Sensex benchmark climbed 281.52 points or 0.39 per cent to close at 72,708.16, while NSE Nifty ended at its all-time high of 22,122.25 points, up 81.55 points or 0.37 per cent from the pre-

The market capitalisation (mcap) of BSE-listed companies went up ₹ 2,19,581.56 crore to reach its all-time high of ₹ 3,91,69,087.01 crore.

"BSE market cap touching a record high of around USD 4.7 trillion reflects the strength of the ongoing bull run and the momentum in the market.

"The fact that the crucial Buffet Ratio (market cap to GDP) is signalling very high valuation at above 120 per cent is a matter of concern. But this is unlikely to halt the bull run in the near-term since flows into the market from domestic individual investors and DIIs continue to be strong," V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said.

CBDT sets ₹ 1 lakh threshold per assessee for withdrawal of old tax demands

NEW DELHI, Feb 19: The income tax department has prescribed a ceiling of ₹ 1 lakh per assessee for withdrawal of small tax demands till Assessment Year 2015-16, in accordance with a scheme announced in Budget.

The Central Board of Direct Taxes (CBDT) has issued an order giving effect to the 2024-25 budget announcement by Union finance minister Nirmala Sitharaman. The budget had announced that tax demands for AY 2010-11 of up to ₹ 25,000 and for AY 2011-12 to 2015-16 of up to ₹ 10,000 will be withdrawn. Tax demands totalling about ₹ 3,500 crore will be withdrawn following the an-

nothing we say in any rules, noth-

ing we say in any law will ever transgress into or interfere with the fundamental rights of any of our citizens. As a matter of fact we support it," he said. The government is fully commit-

ted to ensuring that internet is safe and trusted, the minister said.

He said some people take the view that free speech is an absolute right and it has to be protected which may be true for the US but the Indian constitution has reasonable restrictions on it. "There are restrictions to it that

you cannot say anything that is il-

legal, unlawful or against national

security. There is a fundamental

right to free speech. "Fundamental right to free

speech does not mean you have a fundamental right to lie, or provoke or create public order disturbances because you are inciting violence," the minister said. There is a group of people who constantly allege censorship by government, he said, adding that the government is fully focussed on protecting the fundamental rights of citizens.

"There are some bad guys and there are some good guys in this battle for free speech. If there is any good guy in this, it is us, the government of India. Under Prime Minister Narendra Modi it is very

clear... We are trustees to protect the fundamental right of every one of our citizens," the minister said.

He said allegations on govern-

ment transgressing privacy or cur-

tailing free speech are mostly politically driven. "When they have a doubt, and they can sit and discuss... they quickly get convinced that we are absolutely on the right track," the minister said.

In response to controversy around the PIB Fact Check unit, that flags misinformation or false information pertaining to the government, Chandrasekhar said the fact check unit is not any form of censorship but rather a tool to help platforms that are dealing with disputed government information.

"When the fact check unit says this is right or this is wrong, all platforms have to do is label it. Now there is nothing in that, that is censorship. But some people have characterised that, specifically editors guild, etc, who are looking for a cause to hang their hat on," Chandrasekhar said. Editors' Guild of India has challenged the amendments to IT Rules 2021 in June.

The guild has alleged that "amendments to the IT Rules will have deeply adverse implications for press freedom in the country".

The minister said the government wants to have a lesser role to be arbiter of disputes between consumers and the platforms.

"We had a situation in 2021, with every dispute between a consumer and a social media platform getting referred to us. We want platforms to be accountable under law, to the consumers' grievances.

"We want consumers to have the process of going to an independent regulator or to the court to have their dispute with the platform sorted not to the government," the minister said. (PTI)



Adamant Houthis, crisis in Yemen

Temen's Houthi rebels have demonstrated unwavering support for the Palestinians in Gaza. Unlike many Arab leaders who express insincere sympathy, the Houthi rebels, despite being from one of the world's poorest countries, have taken action by launching ballistic missiles at Israel and targeting ships passing through the Bab al-Mandab strait, a crucial pathway for global trade.

The religious leader of the Houthi rebels, Abdel-Malik al-Houthi, has made a commitment to persist with the attacks until Israel ceases its bombings in Gaza and allows unimpeded humanitarian assistance. The Houthis are delighted by the support they receive from overseas. In New York, protesters express their enthusiasm, chanting, "Yemen, Yemen, we are proud of you! Prevent another ship from proceeding!"

The neglect of the Houthi insurgents towards the welfare of their own citizens in Yemen is frequently overlooked. After ten years of fighting, the United Nations has identified the humanitarian situation in Yemen as among the worst in the world. Over half of Yemen's 33 million inhabitants, translating to several million people, urgently require help to live. A large number of these people are in the north-west area, which is governed by the Houthis.

Within the areas under their control, the Houthi rebels hinder the flow of humanitarian aid. They obstruct the process of delivering assistance, making it difficult for aid to reach those in need. They demand control over the distribution of aid and impose restrictions on international aid workers. Additionally, they impose taxes, sell aid, and charge customs fees at checkpoints. In essence, they treat the aid program, which is worth billions of dollars, as a means to generate revenue. A former UN official accurately describes the situation by stating that, similar to Gaza, the risk of famine in Yemen is a result of deliberate actions taken by the Houthis. They exploit aid as a weapon to further their own interests and exert control.

Over the past ten years, Yemen's economy has heavily relied on foreign aid for survival. Following the Houthi rebels' seizure of the capital, Sana'a, in 2014 and the subsequent war with Saudi Arabia, various United Nations agencies have provided substantial financial assistance to prevent famine in the country. However, the Houthis, who follow a Shia offshoot of Islam, typically view foreign aid workers with suspicion, often treating them as if they are Western

Following military strikes by the United States and the United Kingdom on Yemeni military targets in response to Houthi attacks on shipping in the Red Sea, the Houthi rebels have issued orders for American and British citizens to evacuate the country. For now, most of those affected, including Julien Harneis, the newly appointed humanitarian co-ordinator for Yemen from the United Nations, have sought refuge in Aden. Aden serves as Yemen's largest city in the southern region and is regarded as the administrative center for the internationally recognized government. Speculation is spreading that the Houthis may take measures to close down any United Nations or aid agency that declines to withdraw its American and British staff from Yemen

gust presence? The manner and the excuses Kejriwal used to escape the Enforcement Directorate dragnet are the mark of genius – six in a row summonses. And it's his video image that presented itself before the Rouse Avenue Court. Directorate (ED) could do. Whatever happened to the court's "legally bound" ultimatum is not known, but the court has now posted the case to be heard on March 16. Even the court got hogtied when it came to the Delhi Chief Minister's shenanigans.

March 16 spells a month to spend as he pleases in relative freedom and there's a lot the AAP can do in 30 days. Kejriwal's presence over-ground is important to the ongoing farmers' agitation. Does Kejriwal care? Anybody who knows Kejriwal knows that the street-smart AAP convener is least bothered about what people think of his shenanigans.

Kejriwal's trust vote was another exercise to give the ED's sixth summons the skip. The sixth summons had asked Kejriwal to appear before the ED on February 19. The five earlier summons were rejected with the excuse that the summonses were "illegal" and the Enforcement Directorate's sole aim was to arrest him and put him in a cell next to that of erstwhile Delhi Deputy Chief Minister Manish Sisodia.

Kejriwal's impending arrest is so long expected that people have stopped thinking of it. Every time the Enforcement Directorate issues summons, there's intense speculation and then resignation. Manish Sisodia, Sanjay Singh and Satyendra Jain, three AAP leaders are behind bars, but this man eludes anticipation. two parliamentary seats were formally made public, ven before the results for the the message was moving around the British political and social circles that Conservatives are set for losing Wellingborough and Kingswood, supposed to be their safe seats. A deeper look into the reasons would make it clear that the outcome could not be construed as defeat for Tories or a win for Labour. Instead, it is a manifestation of no-trust in the policies and style of functioning of the UK Prime Minister Rishi Sunak.

Though the top Tory leadership is maintaining a passive silence on their next move and continuance of Sunak in office till the final general election is held, what is absolutely clear is that he has lost the support of the decision-makers and Conservative financers.

Sunak trying to identify with the rightist ideas and policies of the USA has severely damaged his reputation and image. Notably, a section of UK media likes to describe him "British-Indian". What does it imply? There is a lurking impression that he is too close to the rightist Indian leader Narendra Modi. Of course, the Conservative party has strong political lineage in the rightist ideology and philosophy, but its leadership isn't as orthodox in their approach and functioning as Modi.

Sunak has suffered two heavy blows to his leadership ahead of a general election later this year as the opposition Labour Party grabbed two wins. Labour's Dan Egan won the House of Commons seat of Kingswood, south-west England, and the party's Gen Kitchen won Wellingborough, in the East Midlands region of Eng-

Another emerging trend saw the far-right Reform UK - the re-organised anti-immigration Brexit Party – coming third, ahead of the Liberal Democrats and Green Ground for Tory defeat from

Kingswood was laid out by Sunak himself. Tory leader Chris Skidmore had resigned as an MP in protest over Sunak's green policies. True enough, it was shaping up well. Last year in July, Sunak

had signalled the government could delay or even abandon green policies that impose a direct cost on consumers, as he comes under pressure from the Conservative right to create a dividing line with Labour in the next election. He had also said the drive to reach the UK's net zero targets should not "unnecessarily give people more hassle and more costs in their lives", as he rethinks his green agenda after last week's Uxbridge and South Ruislip by-election. In Wellingborough, the voter followed Tory MP Peter Bone being recalled by his constituency over claims of bullying and sexually inappropriate behaviour, which he

Labour leader Sir Keir Starmer claimed: "The Tories have failed, Rishi's recession proves that. Labour is back in the service of working people." He may sound correct. But the Tory leadership is not willing to oblige Starmer. Undeniably, the twin defeats have come as a major blow for the Tories as they prepare for a general election, which Sunak, 43, has indicated will be held in the second half of the year.

The major reason for the defeat of Tory candidates is being cited by seasoned pollsters and Tory leaders is, averseness of the Tory members to vote for the party which is presently is being perceived as under the control of Sunak. Conservative MP and former minister in Boris Johnson's Cabinet, Sir Jacob Rees-Mogg holds the Kingswood result was "not as bad as I'd expected", as Tory voters appeared to have stayed at home. Though he was not too harsh on Sunak, he obviously deflected the reason for voters staying at home.

Sir John Curtice, Professor of Politics at Strathclyde University pointed out: "The party will be concerned not only by having lost these seats, but also by the scale and manner of its defeats. Its share of the vote fell by a whopping 37.6 points in Wellingborough, the biggest drop the party has ever suffered in a byelection it was defend-

Rishi Sunak is facing questions

from inside his party on the loss of two seats. Some senior members those who guide the functioning of the party nurse the view that Tory must have some other leader to lead the party at general election. They are not sure that Sunak could counter the challenge of Labour leader Starmer. His pledge to reduce irregular migration by stopping small boats crossing into England from France is being undermined as a key government deportation policy is repeatedly held up because of accusations it breaches international law. In the

past Tory used to beat the Labour on these issues. But now they are on defensive mode.

A big chunk of Conservatives believe that the party leadership is increasingly out-of-touch and wrecking its own electoral prospects. They think Sunak - the richest person to ever hold the office of Prime Minister – is not an appropriate leader at a time when so many people in the UK are struggling financially. Sunak's pledge for reforms have not materialise don the ground.

the demand for Sunak's resignation might have cropped up in the wake of the twin defeats, but it is the absence of the replacement that is delaying the move. Who exactly would replace Sunak is not clear. Boris Johnson no longer sits in parliament, so it would be very hard to bring him back in time for the next election. He is also not as universally popular as his own diehard loyalists claim.

It is also alleged that he is not a team leader. He has not taken pains to keep the party together. This is another reason that Sunak has been consistently losing support at the ground level. Sunak committed major mistake by openly supporting Israel's aggression against Hamas. It is felt he should have treaded cautiously. His action gave the impression that he was supporting Zionism, which cannot be the policy of a British political party seeking power in Britain. Political experts feel that the situation in Israel, particularly with regard to the rights of Palestinians, is far too complex for such a bold position to be adopted, especially when so many people are convinced that some form of twostate solution is the only eventual answer to the problems faced in

that area. For Labour leader, Keir Starmer defeat of Tory has come as the message "the country is crying out for change". He described his party's performance in the elections as "fantastic." In a statement, he said it showed that "people are ready to put their trust in a Labour government." Labour exploited the internal dissent in the Conservative rank and also shrinking economy and discontent over a crisis gripping the country's health system.

Nevertheless, the possibility of Sunak being purged is the hot topic for discussion in the political and domestic circles. If the party can drive out the last two Conservative leaders, Liz Truss and Boris Johnson, it can also take steps against Sunak. The internal division resulting from the fear of losing the general election is likely to further drag down the Conservative vote. (IPA Service)

Electoral funding quagmire: No real progress possible with peripheral changes

The Narendra Modi government's electoral bond scheme has been thrown out of the window by the Supreme Court. That is certainly good riddance to an obnoxious and highly abused scheme. But in the aftermath of the Supreme Court's decisive ruling, a stark reality emerges – the convoluted landscape of political financing in India that requires a thorough overhaul.

Justice Sanjiv Khanna in his separate judgment has suggested a revisit the electoral trust system with new guidelines as an alternative. But on closer scrutiny, that would appear to be another futile exercise. The electoral trust scheme, already found wanting in many respects before the Modi government's treacherous electoral bonds entered the scene and held forth, has been tried, tested and found inadequate. The suggested antidote thus fails to address the chronic issues that continue to plague India's electoral funding. This prompts a compelling question: Is it not time to usher in a new era of state-funded elections that prioritizes transparency and levels the playing field for all contenders?

At the heart of the matter lies the persistent lack of transparency that shrouds the origins of political funds within the electoral trust system. This opacity has not escaped attention and has led to calls for the disclosure of the identities of contributors to electoral trusts becomes imperative in an age where citizens demand accountability and integrity in the exercise of their democratic right.

In fact, the electoral trust system's Achilles' heel is its lack of obligation to disclose the names of contributors. This glaring omission not only robs citizens of the power to make informed choices but also raises the spectre of potential conflicts of interest. Transparency International India, a stalwart in the battle against corruption, emphasizes that disclosure is the linchpin in fortifying democratic principles and preventing the erosion of public trust.

While electoral trusts were designed to streamline political funding, they constitute only a fraction of the financial behemoth that sustains political parties. Private donations, corporate sponsorships. and undisclosed contributions remain significant funding streams, perpetuating an uneven playing field that tilts the scene in favour of the financially endowed. Dr. Jagdeep Chhokar, a co-founder of Association of Democratic Reforms, has unearthed the impact of financial muscle on political outcomes, unveiling a stark reality where wealth, not merit, often dictates electoral success.

Compounding the conundrum is the sheer number of political parties in India, presenting a formidable challenge for electoral trusts to ensure fair resource distribution. Dr. Trilochan Sastry, another luminary in the ADR camp, underscores the necessity for systemic reforms in the face of a multitude of political entities with diverse funding dynamics.

Money's pernicious influence extends beyond the logistics of campaigns to the very heart of candidate selection. Financial prowess has been found to bestows substantial advantage upon well-funded candidates. This stark reality perpetuates a cycle of inequality within the political arena, where innovative ideas and merit often take a back seat to monetary might.

Studies have revealed the direct and indirect influence of money on electoral politics. The ability of a company to influence the electoral process through political contributions is much higher when compared to that of an individual.

A company has a much graver influence on the political process, both in terms of the quantum of money contributed to political parties and the purpose of making such contributions. Contributions made by individuals have a degree of support or affiliation to a political association. However, contributions made by companies are purely business transactions, made with the intent of securing benefits in return. We have been seeing this in action dramatically in recent times

In the light of the inadequacies in both the electoral bond and electoral trust schemes, the clarion call for a paradigm shift in statefunded elections becomes resonant. A robust state funding mechanism, fortified with stringent disclosure requirements, contribution limits, and vigilant oversight, emerges as the antidote to the malaise afflicting India's electoral financing system.

A bold and comprehensive reform agenda is what is needed, one that not only addresses the past shortcomings but also paves the way for a future where political funding is a beacon of transparency and fairness. The time has come for a new narrative in Indian electoral politics – one that places the power back in the hands of the people and rejuvenates the spirit of a robust and resilient democracy. hat is love? Could those feelings you label as love be something else? What about infatuation? Obsession? A passing fancy? Being smitten? Enthrallment? Beguilement? Lust? A crush? A squish? Platonic admiration? Why do people categorize some attachments as romantic love but not others?

Suppose Holly meets someone on vacation. They quickly become romantically and sexually intimate and seem deeply compatible. Holly is from the United Kingdom, where the term "holiday romance" is commonly used and part of her vocabulary. Because she knows this term, she can apply its social scaffolding to this relationship. She understands that the rapid emotional intimacy and apparent compatibility she experienced likely sprang from fleeting circumstances that aren't meant to

Someone from the United States, however, where this term is rarely used, might more easily interpret this rapid intimacy as a sign of deep, significant lifelong compatibility.

Judging that you are in love can be powerful. It can affect your feelings, relationships and even your sexuality. But how do people judge whether they are in love?

This, I argue, depends on your linguistic community. That is, how the people around you talk about romance, relationships and attrac-

I am a philosopher who studies categorisation schemas - how, when and why people label things such as emotions, sexuality and health. I examine the effects of those labels on how people understand themselves and on their mantic bond but see each other well-being, and how alternative only intermittently, living far apart taxonomies and labels can make the rest of the time without much people understand and shape the contact. Dictionary of polyamory

Words create possibilities, and the recent surge of interest in polyamory, or having more than one romantic relationship at a time, has introduced substantial amounts of new vocabulary.

An "anchor partner" is a central figure in your romantic life. A "nesting partner" is a partner you live with. And a "satellite partner" has emotional and physical distance from your home. Vocabularies sculpted by traditional monogamous relationships might not distinguish between these types of attachments because they see non-cohabitating partnerships only as temporary transition phases that end by breaking up or become serious by moving in.

By rejecting the mainstream social scaffolding about relationships, polyamory creates the need for more terms to describe innovative relationship structures. And those words in turn create more possibilities for how polyamorous people interpret and structure their attachments.

"New relationship energy" is the buzzing excitement of a new relationship. "Established relationship energy" is the comfort of a stable, long-term relationship. These emotions are especially salient within polyamorous relationships, where the excitement of a new relationship can arise alongside the comfort of preexisting relationships.

But monogamous relationships also benefit from these linguistic innovations. Monogamous relationships might also involve new relationship energy, established relationship energy, and nesting, anchor and satellite partnerships, even if they aren't labeled as such. Such self-understandings affect the values, emotions, commitments and beliefs people use to forge relationships.

Conceptual tourism

Conceptual schemas, or the words and concepts we have for understanding ourselves and the world around us, have permissive flexibility: People can disagree about what words like "love," "crush" and "bi-curious" mean. Disagreement doesn't mean that someone is wrong. Rather, flexibility allows us to explore different ways to understand the world and ourselves. We can be concep-

Nell can adopt a broad or narrow definition of the word "crush," depending on whether her feelings meet how she defines a "crush." Altering what she means by a "crush" would change whether she labels herself as having a crush. This, in turn, could affect whether Nell sees herself as queer or straight.

If she knows other terms to describe her feelings, Nell might interpret them as "alterous attraction," which is the desire for emotional intimacy in a way that is neither platonic nor romantic. She might seek a "queerplatonic relationship," which resembles a conventional romantic relationship but without sex or conventional romance. Or, if her feelings are intense, Nell might self-ascribe "limerence," which is obsessive infatuation.

Self-ascribing labels affects what people notice about themselves, how they interpret their feelings and what they appreciate about their attachments. What she pays attention to fuels particular emotions and can bolster certain attitudes, like profound gratitude, that might distinguish love from crushes.

For example, if Nell interprets herself as having a crush, she may become more attuned to the excitement she feels around her classmate, which can fuel those emotions in a feedback loop. If she labels her feelings as platonic admiration, she might instead interpret herself as being nervous about impressing her new class-

Nell can experimentally adopt different labels - alterous attraction, queer, crush, limerence, straight and more – to see which fit best. Some labels might better match her emotions. And those labels might also change her emotions and become self-fulfilling prophecies.

Conceptual tourism can be a valuable cognitive skill. It requires the mental dexterity to inhabit rival conceptual schemas and try on new interpretative terms. Doing so can increase your selfunderstanding, cultivate self-determination and even help steer

Culture unavoidably provides a lexicon of attachment that shapes how you relate to other people. A culture that is more deliberate about the words it uses for different kinds of attraction can help people bond in new and more open-minded ways.

It's also a great motivator for education: Learning new words

Who is most likely to develop coronary artery disease?

oronary artery disease is the leading cause of death in the United States. Therapies such as statins, which target high cholesterol levels, can reduce the risk of mortality due to coronary artery disease.

These effects of statins are mediated, in part, by improving blood vessel health. However, there is a lack of therapies for coronary artery disease that directly target the endothelial cells that form the inner lining of blood vessels and influence blood flow.

Identifying genetic risk factors associated with endothelial cell function could help develop therapeutics that target blood vessels. Research has shown that spe-

cific genetic variants are associated with an increased risk of coronary artery disease. These genetic variants regulate the expression of several genes that work together in a small number of major biological pathways.

However, methodological limitations have impeded the identification of major pathways associated with coronary artery disease variants

Understudied gene plays key role in coronary artery disease

A new study using a combination of high-throughput molecular biology techniques and computational methods has identified major biological pathways and novel genes involved in endothelial cell function that could contribute to the risk of coronary artery disease.

The paper reporting the study findings appears in Nature. Study author Dr. Jesse Engre-

itz, assistant professor at Stanford University, CA, explained the findings to Medical News

"We found that genetic risk factors for coronary artery disease converge onto a particular pathway in endothelial cells. One of the known roles of this pathway is to tune endothelial cell responses to blood flow, and includes genes that could prove to be good targets for therapies that directly target blood ves-

"We also found a new understudied gene, TLNRD1, that plays a key role in this pathway in humans and zebrafish but has previously eluded notice. The list of genes we identified might also prove helpful in identifying individuals who are genetically predisposed to having poor vascular health and, therefore, may respond better to existing medications," added Dr. Engreitz.

How researchers pinpointed genetic risk factors for heart

Advances in genome sequencing technologies have facilitated the discovery of genetic variants associated with several diseases. These genome-wide association studies involve examining genomes from a large number of individuals to identify genetic variants associated with a particular disease.

Several of these genetic variants associated with a disease likely regulate a small number of biological pathways, with each pathway consisting of several genes that work together.

Although genetic variants have been identified for several diseases, linking genetic variants to a few converging biological pathways has been challenging.

A majority of these genetic variants identified by genomewide association studies do not code for proteins. Instead, these noncoding variants regulate the expression of multiple genes nearby that are involved in biological pathways associated with

However, identifying the spe-



cific genes regulated by each variant and playing a role in disease-associated pathways remains challenging.

Moreover, multiple cells contribute to the development and progression of a disease. Different biological pathways operate in each cell type and contribute to the disease. The specific biological pathways in a particular cell type impacted by disease-associated variants have not been fully characterized.

In other words, how genetic variants identified using genomewide association studies affect biological function is not well understood. In the present study, the researchers investigated the biological pathways associated with genetic variants that are involved in coronary artery dis-

Dr Engreitz said: "Human genetics has been immensely successful over the last decades in identifying variants that influence risk for disease - there are now 100,000s of associations between genetic loci and particular human diseases and traits. This vast trove of insights could reveal genes that mediate disease and guide therapeutic develop-

"But, it has proven extremely difficult to find the genes, cell types, and pathways underlying each of these associations. Sometimes, it can take a decade to solve this "variant-to-function" problem for even one association," he added 254 genes linked to coronary

artery disease More than 300 genetic variants have been identified for coronary artery disease using genomewide association studies. These coronary artery disease-associated variants are known to impact cells associated with blood vessels and hepatocytes in the

In the present study, the authors specifically examined the variants impacting the function of endothelial cells that are present in the walls of blood vessels.

The researchers used laboratory cultures of genetically modified endothelial cells obtained from the human aorta, the blood vessel that carries oxygenated blood to the rest of the body.

The genome of these endothelial cells was sequenced, and then a computational model was used to map genes whose expression was influenced by the coronary artery disease-associated variant. With the help of data on coro-

nary artery disease-associated variants identified by previous studies, the researchers identified nearly 2,000 genes close to these variants.

Among these genes, the expression of 254 genes was regulated by the coronary artery

The researchers then identified the programs or pathways associated with coronary artery disease. They used CRISPR interference (CRISPRi) to individually inhibit the expression of each gene identified in the vicinity of the coronary artery diseaseassociated variants.

Subsequently, the researchers examined the changes in the gene expression profile of the endothelial aorta cells upon the inhibition of individual candidate

Using computational methods, genes that showed similar patterns of changes in expression profile were categorized as coregulated genes. These coregulated genes were

classified as a biological program or pathway. The analysis generated 50 such programs, several of which were involved in processes that were not specific to endothelial cells or coronary arterv disease.

Gene involved in blood flow regulation may be key

The researchers then examined programs in which the 254 genes regulated by coronary artery disease-associated variants were overrepresented. They identified five such programs, which encompassed 41 coronary artery disease-associated genes and 43 variants.

While these programs included genes that have been implicated in coronary artery disease, a majority of genes in these pathways have not yet been identified as risk factors for this condition.

In addition, all five programs were regulated by genes associated with the pathway associated with cerebral cavernous malformations (CCM), a condition involving the formation of tiny, abnormal clusters of blood vessels in the brain.

Specifically, the analysis revealed that the CCM2 gene and other genes in the CCM pathway were involved in the regulation of all five coronary artery disease pathways

Previous studies have shown that the CCM pathway modulates the function of endothelial cells in blood vessels and regulates blood flow.

However, CCM2 and other CCM pathway genes have not been shown to be involved in coronary artery disease. The present study found that inhibiting the expression of CCM pathways modulated the expression of genes that have been shown to be involved in coronary artery disease. These findings indicate the involvement of genes in the CCM pathway in coronary artery

disease. The researchers further examined the role of one of the novel CCM pathway genes, TLNRD1. They focused on TLNRD1 because the gene is one of the strongest regulators of the five coronary artery disease pathways. The role of TLNRD1 in endothelial cell function has not

been characterized so far. The researchers found that TLNRD1 interacts with CCM2 and, consequently, examined whether TLNRD1 performed a function similar to CCM2. The disruption of TLNRD1 in cells cultured in the laboratory altered the barrier function of endothelial cells. Such an impaired barrier function of endothelial cells has been implicated in cardiovascular diseases.

In addition, the disruption of the TLNRD1 expression in zebrafish also adversely impacted heart and blood vessel development in a zebrafish model.

Dr. Engrietz said: "In this study, we developed a new methodology to extract lessons from human genetic data. Here, we took a new approach leveraging CRISPR tools, which we use to simultaneously break every candidate gene in different endothelial cells in a dish and measure what happens to these cells. From there, we use computational models to learn which sets of genes are working together in pathways.'

"With this comprehensive and systematic data, we are able to much better interpret genetic associations and here identify likely causal genes for 40 out of [approximately] 300 loci for coronary artery disease in a single pass. We think this tool will be a powerful approach for studying many other heritable diseases in the future," added Dr.

Dr. Cheng-Han Chen, boardcertified interventional cardiologist and medical director of the Structural Heart Program at MemorialCare Saddleback Medical Center in Laguna Hills, CA, not involved in this study, commented that:

"This research has the potential to open an entirely new field of research, as it might be able to identify the molecular connections more efficiently between gene variants and clinical disease. But, even if the opposition were united, he questioned whether "given the instruments of coercion, repression and intimidation available to the Russian state, what difference, at least in the short term, would that

Putin is eyeing at least another six years in the Kremlin, which means he could effectively rule Russia for almost three decades.

Russia's remaining opposition leaders and activists, largely outside the country, are now grappling with the question of how to mount an effective challenge to the Kremlin. That would mean breaking through state propaganda to reach Russians inside the country and offer them an alternative to the Kremlin's vision of the future.

It is a difficult task, one which even Navalny struggled with after he returned to Moscow in February 2021 to face certain arrest after recuperating in Germany from a nerve agent poisoning he blamed on the Kremlin. (AP)

Israel's Netanyahu slams Brazilian president's comparison of Gaza war to the Holocaust



TEL AVIV, ISRAEL, Feb 19: Israel on Sunday condemned Brazil's president for comparing the war in Gaza to the Holocaust, accusing him of being antisemitic and trivializing the Nazi genocide of European Jews during World War II.

The outcry further strained relations between the countries, which have deteriorated since President Luiz Inacio Lula da Silva returned to office last year. Lula has portrayed himself as a leader of the "Global South," a loosely defined group of devel-

Speaking to reporters at the African Union summit in Ethiopia, Lula said that "what is happening in the Gaza Strip and to the Palestinian people hasn't been seen in any other moment in history. Actually, it did when Hitler decided to kill the Jews."

Such comments strike a raw nerve in Israel, a country established as a haven for Jews in the wake of the Holocaust. Israel rejects any comparisons of its conduct in the war in Gaza to the Holocaust. Trump rails against New York fraud ruling as he faces fines that could exceed half-a-billion dollars Israeli Prime Minister Benjamin Netanyahu said Lula's comments "trivialized the Holocaust" and

"crossed a red line." He also accused Lula of being a "virulent anti-Semite." Foreign Minister Israel Katz wrote on X, formerly Twitter, that he had summoned Brazil's ambassador in Israel for a reprimand. Katz called Lula's comments "shameful and serious."

Lula's comments came after leaders at the AU summit on Saturday condemned Israel's offensive in Gaza and called for its immediate end.

The war was triggered by an Oct. 7 attack by Hamas militants, who stormed into southern Israel and killed about 1,200 people, mostly civilians, and took around 250 hostage. Militants still hold around 130 hostages, a fourth of them believed to be dead. Most of the others were released during

The war has killed at least 28,985 Palestinians, mostly women and children, according to the Health Ministry in Hamas-ruled Gaza, which does not distinguish between civilians and combatants. Around 80% of Gaza's population have been driven from their homes, and a quarter face starvation. The heavy death toll and widespread damage have led to mounting criticism of Israel and growing calls for a cease-fire. Lula has previously said Israel is carrying out a genocide in Gaza and has supported South Africa's case accusing Israel of genocide at the U.N.'s International Court of Justice. His comment Sunday was the first time he directly compared Israel's actions to the Holocaust.

In January, during a meeting with the Palestinian ambassador, Lula condemned Hamas' attack on Oct. 7, but said there was no justification for the indiscriminate killing of civilians and pushed for a

TOKYO, Feb 19: Japanese Prime Minister Fumio Kishida on Monday pledged his country's long-term engagement in Ukraine's reconstruction, calling it a future investment, as Japan stressed its commitment to supporting the war-torn country ahead of the two-year anniversary of Russia's invasion.

In his keynote speech at a conference Japan co-organized with the Ukrainian government and business organizations, Kishida said Japanese public and private cooperation will be a long-term partnership based on inclusivity, humanitarianism as well as technology and knowledge. More than 50 cooperation deals were signed by Japanese and Ukrainian government agencies and compa-

Kishida stressed the importance of investment across industries for the future of that country's development and ensuring that the support caters to Ukraine's needs.

Support for Ukraine's reconstruction is about "investing in the future," Kishida said. "The war in Ukraine is still going on at this very moment and the situation is not easy. The promotion of economic reconstruction, however, is not only an investment for the future of Ukraine but also investing in Japan and the whole globe.

Japan's government has chosen seven target areas - including removal of mines and debris; improvement of humanitarian and living conditions; farming; biochemical manufacturing; digital and information industry; infrastructure in power and transportation sectors; and anti-corruption measures. Japan, in cooperation with other Group of Seven members, hopes to link the Tokyo conference to a separate Ukraine reconstruction conference to be held in Germany in June.

SEOUL, Feb 19: Trainee doctors in South Korea began resigning en masse on Monday in protest of a government medical policy, causing reported delays in surgeries and other treatments at hospitals, though no major disruption

Doctors' groups and the government have been squabbling over a government plan to increase the number of medical school admissions by 2,000, starting from next year. Health authorities say it's urgent to have more doctors considering South Korea's fast-aging population. They say the number of doctors in the country

relative to the size of the population is among the lowest in the developed

world. But doctors' groups say the government must use available resources to raise medical fees and resolve other problems first. Some doctors say the government plan could eventually result in doctors locked in competition. performing unnecessary medical treatments and posing a burden to the public health insurance plan. On Monday, trainee doctors at the country's five major hospitals began submitting letters of resignation before formally walking off their jobs the

The Health Ministry said it was trying to find how many of the total trainee doctors at the five hospitals — estimated at about 2,700 in local media — submitted their resignations. South Korea has about 140,000 professional doctors.

The Korea Medical Association, which represents doctors, said it plans to hold rallies in support of the trainee doctors but hasn't determined whether to join their walkouts. (AP)

No Haokip Reserved in Thanging hill, Manipur government

IMPHAL, Feb 19: Manipur forest, environment and climate change department on Monday refuted Thangjing hill ownership claim

made by the Ukha-Loikhai village. On February 16, chief of the Ukha-Loikhai village, Thenkhomang Haokip claimed the village as the owner of the Thangjing hill in Churachandpur district while terming it as 'Haokip Reserved'. He also referred to

Thangjing as 'Thangting' "There are no records of the Haokip Reserved notified under any resolution/Act/rules as per records maintained by the state government contrary to the claim made by the selfproclaimed chief", the forest, environment and climate change said, in an order issued on Monday while discrediting the claim.

The order asserted that the claim is fabricated and holds no legal standing.

The order stated that the present day Thangjing hill range, which falls within the Churachandpur-Khoupum Protected Forests, was notified on September 17, 1966 under

section 29 of the Indian Forest Act, 1927. The present day Ukha-Loikhai settlement falls within the boundary of this protected forest and the order for setting apart Ukha-Loikhai from the Churachandpur-Khoupum protected forest was cancelled by an office memorandum of the state forest department issued in November 2022. Fresh inquiry in this regard has already been initiated by the state government, the government order

Contrary to the village chief's claim, there are no records of the 'Haokip Reserved' under any Resolution/Act/Rules, as per the state government's maintained records, it added.

The order emphasized that Thangjing (Thang Ching) holds historical importance, leading the government to declare it a protected site under section 4 of the Manipur Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1976, through Gazette No. 376.

The order signed by special secretary (forest, environment and climate change department) RK Amarjit Singh stated alleged that the claim is a deliberate attempt to mislead the general public while labeling it as non-existent with a mala-fide intention. 

SC refuses to entertain PIL seeking probe into Sandeshkhali violence

One of the judges of the high court has also taken cognisance of the alleged incidents

NEW DELHI, Feb 19: The Supreme Court on Monday refused to entertain a PIL seeking a court-monitored CBI or SIT probe into the violence in West Bengal's Sandeshkhali village, saying the incidents cannot be compared to the savagery in Manipur.

A bench of Justices B V Nagarathna and Augustine George Masih said the Calcutta High Court is already seized of the mat-

"The local high court will be the best to assess the situation. Let there be no dual forums," the bench said while granting liberty to the PIL petitioner to approach the high court.

As the hearing began, petitioner-lawyer Alakh Alok Srivastava said disturbing incidents have come to light where a number of women have claimed they have been raped.

The top court said one of the judges of the high court has also taken cognisance of the alleged incidents. It can consider transferring the case to the CBI, the bench

The petitioner said the situation in the state is so bad that even the CBI has to approach the apex court to seek trial of post-poll violence cases outside West Bengal. "We understand your eagerness

and sympathy for the victims but monitoring of an investigation by this court is completely different.'

the bench said. Senior advocate Jaideep Gupta, appearing for the West Bengal government, submitted the high court has taken cognisance of the alleged incidents and some arrests have also been made.

When Srivastava referred to the top court having formed a committee of three former women high court judges to oversee the investigation, relief and remedial measures in Manipur, where also women were sexually assaulted, the bench said,"Don't compare Manipur with this. Don't make different cases comparable.'

As the bench was disinclined to

entertain the matter. Srivastava withdrew the PIL. The matter was dismissed as withdrawn. "The petitioner who has ap-

peared in person, after arguing the matter for some time, sought permission to withdraw this petition filed under Article 32, with liberty to seek reliefs before the Calcutta High Court. Consequently, this writ petition is dismissed as withdrawn while granting liberty to the petitioner to seek appropriate relief before the Calcutta High Court," the bench said in its order.

The plea filed by Srivastava in his personal capacity, sought compensation for the victims of the Sandeshkhali violence and action against officials of the West Bengal Police for alleged dereliction

The plea also sought transfer of the probe and subsequent trial outside West Bengal, besides an inquiry by a three-judge committee as done in Manipur.

Sandeshkhali, a village in North 24 Parganas district of West Bengal, has been witnessing violent protests over allegations of sexual abuse of women by a local TMC leader and his supporters.

Several women have accused local Trinamool Congress strongman Shajahan Sheikh and his supporters of land grab and sexual

Sheikh is absconding ever since a mob, allegedly linked to him, attacked Enforcement Directorate officials who had gone to search his premises in connection with a

corruption case. Earlier in the day, the apex court stayed the notices issued by the privileges committee of the Lok Sabha to the West Bengal chief secretary, DGP and others over a complaint of "misconduct" filed against them by BJP MP Sukanta Majumdar.

Majumdar was hospitalised last week following a clash between BJP workers and police after being stopped from going to violence-hit Sandeshkhali. (PTI)

SC stays proceedings against Karnataka CM Siddaramaiah, others

NEW DELHI, Feb 19: The Supreme Court on Monday stayed criminal proceedings against Karnataka Chief Minister Siddaramaiah and others in connection with a protest march held in the state in 2022.

Issuing notice to the Karnataka government, a bench of Justices Hrishikesh Roy and P K Mishra also stayed the proceedings against Congress general secretary and Karnataka in-charge Randeep Singh Surjewala, state ministers M B Patil and Ramalinga

The top court also stayed the Karnataka High Court order, which had imposed a fine of ₹ 10,000 on them and directed them to appear before a special

"Issue notice. Returnable in six weeks. In the meantime, further proceedings against the petitioners are staved," the bench said.

At the outset, senior advocate Abhishek Singhvi, appearing for Siddaramaiah, submitted that it was a "political" protest and the criminal case was a violation of the right to protest under Article 19(1)(a) of the Constitution.

The senior lawyer said in a democracy right of freedom of speech and protest is paramount and is guaranteed under the Constitution and the only re-

striction envisaged is when public order is impacted. Singhvi submitted that a political protest conducted peacefully without any criminal intent cannot be muzzled by using penal provisions.

At this juncture, the bench observed that if the submission is accepted, then every public protest on the road, disrupting normal life, should be allowed on the grounds of Article 19(1)(a) of the Constitution.

Your argument is that if a politician does it, it has to be quashed, but if there are other group of people doing demonstration, then they cannot do it. Only politicians have the right under Article 19(1)(a). How can it be quashed just because it is done by a politi-

"Did you seek permission for the demonstration? You cannot assemble in thousands and say that you are protected" Justice Mishra said.

Senior Advocate Kapil Sibal, also appearing for Siddaramaiah, submitted that the case was about a "law and order allegation" and not a "public order allegation"

"Law and order" cannot be the basis of restriction of my fundamental right to protest. Otherwise every protest would be hazardous and every public protest will be illegal," Sibal said.

Siddaramaiah had moved the apex court against a Karnataka High Court order that has dismissed his plea to quash an FIR lodged against him and others

The Congress leader has challenged the February 6 order of the high court that has imposed a fine on him as well as Surjewala, Patil and Reddy, and directed him to appear before a special court on March

The case was registered against the Congress leaders after they took out a march to lay siege to the then chief minister Basavaraj Bommai's residence in Bengaluru, demanding the resignation of K S Eshwarappa, who was then the rural development and panchayat raj minister in the southern state.

The agitation was staged after a contractor, Santosh Patil, died by suicide accusing Eshwarappa of demanding 40 per cent commission on a public work in his village.

According to police, the case pertained to blocking roads and causing trouble to commuters.

Holding that none of the "quintessential" ingredients of the offences alleged was made out, Siddaramaiah has said in his plea that the proceedings are an abuse of the process of law and would lead to undue harassment.

"The incident complained lasted for almost an hour and no violent action or use of criminal force has been alleged against any of the members of the procession, it is thus submitted that the prosecution cannot be allowed to continue on such frivolous incidents where no allegation of criminality has been attributed to any of the members of the assembly,"

In his plea before the top court, Siddaramaiah has said there is no allegation that the protest led to any violence or use of criminal force to pose an imminent threat to the public at large or to anyone, including the minister. (PTI)

Lt Gen Upendra Dwivedi assumes charge as vice chief of Army Staff

NEW DELHI, Feb 19: Lieutenant General Upendra Dwivedi, who has vast operational experience along the frontiers with China and Pakistan, on Monday assumed charge as Vice Chief of the Army Staff, succeeding Lieutenant General MV Suchindra Kumar.

Lt Gen Dwivedi is the front-runner to become the Army Chief when incumbent General Manoj Pande retires on May 31.

Prior to taking over as Vice Chief of the Army Staff, Lt Gen Dwivedi was serving as the General Officer Commanding-in-Chief of Northern Command from 2022-2024 in an "extremely challenging operational environment", the Army said in a statement.

An alumnus of Sainik School, Rewa, Lt Gen Dwivedi was commissioned into 18 Jammu and Kashmir Rifles in 1984, a unit he later commanded.

"The General officer has had a unique distinction of balanced exposure of both Northern and Western Theatres," the Army said. In his illustrious career spanning 39 years, he has held command appointments in challenging operational environments, spanning the length and breadth of the country.

He commanded his unit in Kashmir Valley as well as in Rajasthan.

Lt Gen Dwivedi was the Sector Commander and the Inspector General of Assam Rifles in an intense counter terrorism environment in the north east.

He commanded the Rising Star Corps with an operational role along the western borders.Lt Gen Dwivedi commanded the prestigious Northern Army in an extremely challenging operational environment along both the northern and western borders, the Army said in a statement. As Northern Army commander, he provided strategic guidance and operational oversight for planning and execution of sustained operations along the northern and western borders, besides orchestrating the dynamic counter-terror-

ism operations in Jammu and Kashmir. During this period, the General officer was actively engaged in the ongoing negotiations with China in resolving the vexed border issue, the Army said.

He was also involved in modernisation and equipping of the largest Army command of the Indian Army, where he steered the induction of indigenous equipment as part of Atmanirbhar Bharat (self-reliant India).

The Army said that he synergised with people of Jammu, Kashmir and Ladakh for "convergent nation-building outcomes" and infrastructure development.

Besides the challenging command assignments, Lt Gen Dwivedi has tenanted important staff appointments in headquarters Armoured Brigade, Mountain Division, Strike Corps and Integrated HQ (Army). Asked if the severity of the air pollution problem in India is underestimated due to a lack of sensors and air quality monitoring institutions, Peltier said, "I don't think we know with enough precision where the pollution is worse. There probably are not enough air pollution monitors spread out across India, especially those around major city areas that give us the confidence that we are 100 per cent sure that our model is right." "But I think we have a pretty good understanding that air pollution is really quite bad across India. It'd be nice to have more

According to independent think-tank Greenpeace India, more than 99 per cent of the country's population breathes air that exceeds the WHO standards on PM2.5. It said 62 per cent of pregnant women and 56 per cent of the country's population live in the most polluted areas. A report by the Energy Policy Institute at the University of Chicago last August said fine particulate air pollution (PM2.5) shortens average life expectancy by 5.3 years in India on an average and by up to 11 years in Delhi.

Asked if air pollution is a meteorological problem, particularly for Delhi, or a governance issue, Peltier said meteorology is not the problem but it can aggravate air pollution in specific areas.

We cannot control meteorology but we can control emission sources. Identifying and regulating these sources are crucial for improving air quality in India, even under challenging meteorological conditions," he

The US scientist also said though it is challenging to convey, there is a clear relationship between high air pollution levels and higher mortality. Peltier said, "Epidemiologically, we know the link between air pollution exposure and mortality, particularly from cardiovascular disease, lung cancer, stroke, and COPD (chronic obstructive pulmonary disease)." "While it's challenging to convey this connection to individuals, the scientific community agrees on the clear relationship between increased air pollution and higher mortality rates," he added. (PTI)

Myanmar poachers' boat hits rock as they were inebriated

PORT BLAIR, Feb 19: A police investigation into the death of six Myanmarese poachers, whose bodies were found in remote Narcondam island in Andaman and Nicobar Islands, revealed that 10 people from the neighbouring country had entered Indian waters illegally to collect marine wealth on February 12, a senior officer said.

Of the 10 Myanmarese nationals, six died of

identified as Aung Kyaw Myint, he said. The bodies were found lying a few metres from the shore in a forest on the small Narcon-

dam island on Saturday. Located in the easternmost part of India, Narcondam in North and Middle Andaman district is only 126 km from Myanmar's Coco Island.

Police sources said, these Myanmarese nationals were employed by one Kyaw Zar Win, a resident of Labutta (a town in the Avevarwady Region of south-west Myanmar), who had provided advance payments to them and organised essential supplies such as fresh water and fuel for their voyage, expected to last 15-20 days.

The dinghy, under the command of Myo Lwin Oo (boat captain), departed from Labutta in Ayeyarwady, Myanmar, on February 2 (evening), to collect marine wealth in the Andaman and Nicobar Islands. They carried 200 kg of rice, 1,000 litres of high-speed diesel and

other essential items. "On February 5 morning they reached the



open sea in Myanmar. Later they continued their journey and after two days they reached Little Coco Island on February 7 and halted there till February 11. On February 11 they started their journey and reached Narcondam Island at about 10 pm on February 12", the senior police officer

During interrogation, Aung Kyaw Myint revealed that while they were at Little Coco Island they got 4-6 bottles (suspected to be spirit) from the seashore of Little Coco Island. Throughout the entire journey, the other members (except Aung Kyaw Myint) consumed liquor.

"Following the consumption, the master Myo Lwin Oo and eight other members started behaving abnormally. As the master and other associates were under the influence of alcohol and due to darkness their dinghy hit a rock at Narcondam Island. They took their belongings including mobile phones, some rations items and liquor with them. On the next morning on February 13, they left the shore area and reached the

upper land area of the island," a senior police source said.

"Aung Kyaw Myint disclosed that as the health condition of Bo Bo Lwin worsened, he and Lwin decided to surrender on February 14. Myint and Lwin left the group and surrendered before the police outpost at Narcondam Island. They were brought to Port Blair where Bo Bo Lwin was admitted to G B Pant Hospital and is undergoing medical treatment. The ration they were carrying is believed to be damaged after their dinghy met with an accident," a police officer said.

"The poachers had entered the Indian waters with the intent to collect marine wealth in Andaman waters. They lack the necessary travel documents or fishing permissions from the competent authorities to engage in fishing within Indian territorial waters. Their clandestine entry into the Andaman and Nicobar Islands to collect marine resources is considered illegal by the joint interrogation team", a senior CID officer said.

Winslet became an overnight star with "Titanic" in 1997 but the actor still cannot shake off the scrutiny that she faced in her twenties.

In an interview with Net-A-Porter, the 48-year-old actor recalled the constant media attention that came with the success of the James Cameron-directed film which featured her alongside Leonardo DiCaprio. "I would have said to journalists, I would have responded, I would have said. 'Don't you dare treat me like this. LONDON, Feb 19: Former ond slip had sparked a collapse England captains Nasser Hussain and Michael Vaughan have criticised the team's 'Bazball' approach in the ongoing Test series against India, saying the visitors need to apply themselves based on match situation instead of being guided by a one-dimensional philosophy of aggression.

India registered their biggestever Test win, annihilating England by 434 run in the third Test in Rajkot on Sunday. Chasing 557 to win, the tourists were bundled out for 122. The home side leads 2-1 in the five-match series with games left in Ranchi and Dharamsala.

"This was the worst defeat under (Ben) Stokes and Brendon McCullum, and one that exposed their method. They cannot take the aggressive at every opportunity, they have to pick their moments," Vaughan wrote in his column for "Telegraph.co.uk'.

Hussain echoed the sentiment. "Bazball is about being attacking but it is also about soaking up pressure," Hussain

said on 'Sky Sports'. In contrast, India's Yashsavi Jaiswal, who has two double hundreds in the series so far, Shubman Gill (91) and debutant Sarfaraz Khan played mature knocks in Rajkot, taking time to settle in before going for their

"They need to look at the way Jaiswal and Shubman Gill played on day three. They soaked up the pressure for 30 or 40 balls, and then they started to get boundaries.

'That is what Test batting is about. India have scored 875 runs in 228.5 overs. No one can tell me it's been boring watching India bat here," Vaughan said.

Things have gone downhill for England since winning the series-opener in Hyderabad. The visiting team's batters have displayed poor judgement, giving away the advantage to the hosts. "...surely a defeat this heavy has to be a wake-up call for Ben Stokes and his players.

"England make out that everything is positive but they need to be having conversations about how to bat better," Vaughan said.

Out-of-form batter Joe Root has been in the eve of the storm for his dismissal in the third Test. His reverse-scoop off turning it around in the next two Jasprit Bumrah straight to sec-

"Get Bumrah into his second or third spell, take it deep and then play the shot later in the day," Hussain wrote.

Root had played a similar shot with much success during the Ashes last year.

"When he played it to the first ball at Edgbaston, I didn't mind it at all because it was all about how many runs England were going to score that day to set up game," Cook said on 'Sky Cricket'.

"It sent a real message to everyone in the changing room that England's best player is going to take on Australia. Root will be sitting in his room tonight going, 'I think I got that one wrong'.

At the end of day three of the second Test, pacer James Anderson had asserted that England will chase down 332 runs in 60-70 overs only for them to lose by 106 runs. Ben Duckett was as bullish last week, declaring that "the more the better" when talking about targets.

"They have to be careful that people around don't think they are smug, or above their station...they are in a bubble. All that matters is their dressing room, and fun. There is a bit more to Test cricket than that.

"This England team are hell bent on doing things their way, and 'saving Test cricket'...But ultimately they have to be better than that now. They didn't win in New Zealand, they didn't win the Ashes, and if they carry on like this, they are going to lose in India.'

Five domestic stalwarts bring curtains to illustrious Ranji careers



End of an Era

NEW DELHI, Feb 19: The ongoing Ranji Trophy season marks the end of an era in domestic cricket with five heavyweights bidding adieu to the game, leaving a huge void to fill.

Bengal legend Manoj Tiwary, Jharkhand duo of big-hitting Saurabh Tiwary and express pacer Varun Aaron, Mumbai stalwart Dhawal Kulkarni and Vidrabha's Ranji Trophy-winning captain Faiz Fazal have decided to bring curtains to their illustrious domestic careers. The reasons for their retirement are varied, ranging from not having anything to play for (IPL contract or national call-up), to embarking on new adventures or focussing on politics.

For Aaron, Manoj and Faiz life came a full circle as they said goodbye at the same venue they

But needless to say, domestic cricket will be poorer without the quintet turning out.

One of the doyens of domestic cricket, Bengal's Manoj Tiwary said goodbye to his "beloved 22 yards" after leading his state to a comprehensive win over Bihar on Monday. Tiwary served his state for over 19 years, the 38-year-old had taken Bengal to the finals of the Ranji Trophy last season.

An aggressive batter, he has over 10,000 first class run in his kitty. As a captain, he always led from the front, helping Bengal be-

come a force to reckon with. The absence of the supremely experienced duo Aaron and swashbuckling Saurabh Tiwary will be a big void Jharkhand will have to fill. Tiwary, a left handed middle order batter, made his first-class debut while he was still a teenager in the 2006-07 Ranji Trophy season. Over the last 17 years, the Jharkhand captain became a proplaying 115 first-class matches amassing 8030 runs in 189 innings at an average of 47.51 including 22 hundreds and 34 fifties.

"I think, if you are unable to make in the national team or IPL. it is best time to leave space for talented youngsters," Tiwary said while announcing his retirement last week. One of the country's fastest bowlers, Aaron has been unable to realise his potential due to persistent injuries that included a series of stress fractures in the back and the legs.

But the pacer, who grabbed everyone's attention with the 153kmph delivery in the 2010-11 Vijay Hazare Trophy final, still managed to snare 173 first class wickets in the 66 games he played at an average of 33.27.

GUWAHATI, Feb 19: Chief Minister Himanta Biswa Sarma on Monday said sports foster unity among people and provide an opportunity for players to interact and understand their counterparts from different regions.

Highlighting the initiatives by his government to boost sports, he pitched for hosting another edition of the National Games in the state.

Declaring the Khelo India University Games (KIUG) 2023 open, Sarma said, "In a rich and diverse country like ours, sports with its inherent transforming potential is strengthening unity among people and giving impetus to 'Ek Bharat, Sreshta Bharat'.

He maintained that continuous interaction, travel for competition, matches and training are giving the players an opportunity to visit and understand different regions.

"This is immensely contributing to national integration. I am sure this edition of KIUG will further develop brotherhood and friendship and bring the players closer to the natural beauty and rich biodiversity of Northeast region," Sarma added.

Mentioning of several national and international tournaments hosted by Assam in the previous years, the CM urged that the state should be given another opportunity to host the National Games in 2025 or 2026, having already organised it once in 2007.

He also dwelt on the investments being made in sports infrastructure in the state, in line with the prime minister's vision.

Besides large sports complexes in and around Guwahati, such infrastructure are coming up at all district headquarters and all 126 legislative assembly constituencies in the state, Sarma added.

began their domestic journeys. Olympics and world medallists among 500 cyclists to take part in Asian Track C'ships from Feb 21

NEW DELHI, Feb 19: Around 500 participants, including 42 Indians and a few Olympics and world championships medallists, will vie for top honours in the Asian Track Cycling Championships, which will be held here from February 21 to 26.

India will be hosting the continental championships for the second time in two years and sixth overall after 1989, 2005, 2013, 2017 and 2022.

New Delhi was the venue of the championships on four occasions while Ludhiana hosted the continental event in 2005.

Pakistani cyclists will miss the championships as they are "facing difficulties in getting travel documents because of the delay in government formation after the general elections in their country.'

"Pakistani cyclists were to take part in the championships and our ministry of external affairs have given clearance to them. But they have informed us that they are not coming as their ministry formation is yet to be done," Asian Cycling Confederation secretary general Onkar Singh said at a press conference.

'They (Pakistani cyclists) said they can't do the visa process now," said Onkar, a former secretary general of Cycling Federation of India (CFI).

This edition of the championships holds added significance as it serves as the final continental track event before the Paris Olympics. The points collected by the riders from the championships will be counted for the Olympic qualification process No Indian, however, is within a striking distance of

making it to the Paris Olympics. "The performance of our cyclists have improved a lot in recent times and they need top class competitions. It is a prestigious continental championships and we are proud of hosting it," said CFI Secretary General Maninder Pal Singh.

"We are confident that the event will provide an exciting platform for the athletes to compete at the highest level and inspire the next generation of cyclists.

We are going in the right direction and our target is for our cyclists to qualify for the 2028 Olympics." The championships will be staged at the state-ofthe-art Cycling Velodrome at the Indira Gandhi Indoor

Cyclists from 18 counties will compete across various categories, including elite men and women, junior men and women, and para events. Asia's leading nations such China, Japan, Korea, Malaysia, Kazakhstan and Iran will be among top medal contenders.

"At least four or five Olympics or World Championships medallists will be in the fray in this championships," Onkar said.

The Indian team, led by the formidable sprint team comprising former junior world number one Ronaldo Singh along with David Beckham, Rojit Singh and Esow Alben, will fancy podium finish. (PTI)

VIZIANAGARAM (AP), Feb 19: Andhra Pradesh will join 41-time champions Mumbai in the quarterfinals of the Ranji Trophy after escaping with a draw against Kerala on the fourth day of their final group match, here Monday.

Andhra finished with 26 points from seven games, while Mumbai topped the Group with 37 points from as many matches. Despite conceding three points to Kerala on the basis of first innings lead, the draw was enough for Andhra to make the knockout stage.

But Andhra, who conceded a massive 242-run first innings lead, had to survive some anxious moments to earn the draw as Basil Thampi (3/36) and Nedumankuzhy Basil (3/43) produced a fiery spell to reduce their opponents to 185 for 9 in 91.5 overs. But Shoaib Md Khan (11 not out) and last man Satyanarayana Raju negotiated the last few overs to secure the draw for Andhra.

Besides Thampi and Basil, Vaisakh Chandran (2/36) also scalped two wickets for Kerala.

Newly retired Tiwary calls for Delhi end season on high with dramatic win over Odisha

greater emphasises on Ranji Trophy KOLKATA, Feb 19: A day after his retirement from cricket, Bengal star Manoj Tiwary raised concerns over the IPL-centric approach of young cricketers and strongly advocated for greater emphasis on Ranji Trophy. The 38-year-old Tiwary, who served Bengal for about two decades and represented India in 12 ODIs and three T20Is, had recently posted on X that Ranji Trophy should be "scrapped" but did not elaborate on the subject as he was an active BCCI cricketer. He was fined 20 per

cent of his match fee for that remark. He also had a Facebook live in the midst of the match where he said he would come out in the open after taking retirement. "I can observe that young players have adopted an IPL-centric mindset," Tiwary said, referring to central contracted players opting out of playing domestic cricket. "Those who don't play IPL often go to Dubai or other places whenever they find some free time. However, this trend is diminishing the significance of the prestigious Ranji Trophy.

'Now, expressing any opinion might lead to a ban. I have already been penalised with a 20 percent reduction in my match fee for just one post.' Ishan Kishan's reluctance to play first-class cricket and focus only on

the IPL forced the BCCI to make a minimum number of Ranji Trophy games mandatory for players in order to be eligible for the cash-rich league's lucrative auction pool. "In hindsight, I feel that the directive issued by the BCCI might not have been given had I not posted it on X. Perhaps my post prompted the BCCI secretary to put the players under pressure now. "The seriousness they have shown by taking this step in the crucial stage of the Ranji Trophy indicates their concern that many players, especially high-profile ones who have succeeded in the IPL with limited first-class cricket, are not giving enough importance to the Ranji

Trophy," Tiwary said. "I could have spoken up earlier, but it seems that the BCCI is no longer governed by sportspersons; it's now run by politicians. I am associated

with a political party, but I am also a sportsperson. "I don't want to engage in a fight; I simply want the Ranji Trophy to be prioritised, as it is slowly losing its importance."

'Essence of IPL has lost' Tiwary further went on to criticise the the approach of young cricketers. "The new-age cricketers adopt a 'Bazball' approach, swinging the bat aggressively from the first ball. Personally, I dislike this approach because

it focuses solely on winning or losing. "However, there is a scope to save a match, especially when facing a potential loss. They are aiming to secure an IPL contract or improve their strike rate to attract attention. "I won't blame the players; it's a situation that has emerged. The essence of IPL seems to have been lost. "IPL is a massive platform for all of us, but I also request the BCCI president and secretary to increase the significance of the Ranji Trophy. (PTI)

With two confident half centuries in his debut Test in Rajkot, Sarfaraz has shown that he is here to stay in the Indian team. The 26-year-old got his Test cap after years of toiling in the domestic circuit and also honing his skills at his father's 'Macho Cricket

The hard work and systematic planning of the past few years, especially during the two COVID-19 lockdowns, paid off against the likes of Tom Hartley, Joe Root and Rehan Ahmed in Rajkot. "It has taken playing 500 deliveries per

across Oval, Cross and Azad Maidans in Mumbai," said a coach who has seen the Mumbaikar's growth from close quarters. "...during (COVID) lockdown, he undertook a car journey covering 1600km. From

"During lockdown, Naushad called me as we are both from Azamgarh and we played club cricket in Mumbai when I was employed with the Indian Navy. So, when he wanted his son to get practice, I felt it's my duty," Kapil Pandey told PTI.

"During lockdown, Sarfaraz played Kuldeep a lot at our Kanpur Academy. They did lot of net sessions together. I would

Another coach who has seen Naushad train his sons -- Sarfaraz and India U-19 star Musheer -- spoke about the gruelling training regimen that the two players endured even on non-match days.

"From a young age, he has been playing hundreds of balls. So when Mumbai didn't have a match, Naushad prepared an astro turf wicket at home where Sarfaraz practised against pacers. But the moment he has to play spin, they go to the Maidans and do open field training," he said.

"Even for red-ball training, Naushad would give Sarfaraz simulation training. Suppose Mumbai play Tamil Nadu in Chennai, the bowlers would be asked to create roughs with spikes and then he would be asked to play on a track that resembles a day four pitch with wide cracks," he explained.

The combined effort seems to have got the desired results as was evident from the commanding manner in which Sarfaraz tackled the visiting spinners in Rajkot. (PTI)
