ballot voting history GUWAHATI, Feb 23: For the first time in its history, the Assam Assembly on Friday witnessed voting with ballot paper while deciding the fate of a private member's resolution brought in by Independ-

ent MLA Akhil Gogoi. The resolution on the irrigation system was rejected by just nine votes.

Out of 77 MLAs in the BJP-led alliance, the government garnered 39 votes. On the other hand, 30 votes were polled in favour of the resolution from 47 opposition MLAs, including five Congress members with allegiance to the government.

Earlier, the resolution was put to voice vote and speaker Biswajit Daimary said the resolution was rejected.

Gogoi and other opposition members, including leader of the opposition Debabrata Saikia, however, claimed that the ruling party did not have the numbers during the voice vote and demanded proper voting.

Daimary then adjourned the House for 10 minutes, saying that



voting would take place and the Assembly Secretariat would require time to prepare for the polling on the resolution.

**ASDCYF** criticises Congress leader's remarks on eviction process <u>HT Bureau</u> DIPHU, Feb 23: The Autonomous

State Demand Committee Youth Front (ASDCYF) and Karbi Students Association (KSA-Jemson) have vehemently criticized Congress leader Debabrata Saikia for his purported remarks regarding the eviction procedures on the Professional Grazing Reserve (PGR) and Village Grazing Reserve (VGR).

Expressing their discontent, AS-DCYF staged a protest in front of their office, symbolically burning an effigy of Saikia, who also holds the position of the leader of the opposition.

# Sensex edges lower by 15 points, Nifty retreats from record highs to settle flat

MUMBAI, Feb 23: Benchmark stock indices Sensex and Nifty edged lower in a volatile trade on Friday, reversing early gains due to selling in IT and select banking shares. The 30-share BSE Sensex slipped 15.44 points or 0.02 per cent to close at 73,142.80 points with 17 of its constituents closing in the red and 13 in the green. The index opened higher but later slipped into losses due to profit-taking by investors. The barometer oscillated between a high of 73,413.93 and a low of 73,022 during the day. The broader Nifty of NSE closed lower by 4.75 points or 0.02 per cent at 22,212.70 points as gains in FMCG, pharma and financial shares were offset by losses in IT and private bank shares. The 50-share barometer scaled a record high of 22.297.50 in intra-day trade.

"Nifty opened higher but failed to sustain the morning momentum, leading to a closing at the day's low due to profit booking," Rupak De, Senior Technical Analyst,

LKP Securities, said. Among Sensex shares,

HCLTech. Asian Paints. Maruti, JSW Steel, TCS, SBI, ITC and Bharti Airtel were the major losers.

On the other hand, Bajaj Finserv, Mahindra & Mahindra, Titan, L&T and

Wipro were the major gainers.

'The domestic market paused momentarily today after reaching another record high earlier in the day, driven by positive signals from global markets," Vinod Nair, Head of Research, Geojit Financial Services, said. The capital goods and industrial sectors showed strength, supported by

advancements in manufacturing and services. BSE Midcap advanced 0.25 per cent while Smallcap rose by 0.53 per cent. Among sectoral indices, BSE Oil & Gas dropped by 0.81 per cent, BSE Metal by 0.33 per cent, BSE Energy by 0.36 per cent and Bankex 0.29 per cent. On the other hand, BSE Industrials spurted by 1.22 per cent, Telecommunications by 1.52 per cent, Capital Goods by 1.18 per

cent. and Consumer Durables 0.76 per cent. Reliance Industries rose by around 1 per cent to hit a 52-week high intra-day. Its arm Reliance Jio Financial Services soared by more than 14.5 per cent to hit a year's high level, taking its market valuation to more than ₹ 2 lakh crore. Global markets were mostly higher following sharp overnight gains in US markets driven mainly by stunning December quarter results by technology company Nvidia.

The Shanghai Composite index added 0.6 per cent while Hong Kong's Hang Seng was unchanged. Tokyo's markets were closed for a holiday. Germany's DAX, the CAC 40 in Paris and FTSE 100 in London rose up to 0.1 per cent. In the domestic market, Foreign Portfolio Investors (FPIs) were net sellers on Thursday as they offloaded securities worth ₹ 1,410.05 crore. (PTI)

# Byju's EGM gets underway; investors file suit before NCIT

NEW DELHI, Feb 23: An Extraordinary General Meeting (EGM) of Byju's shareholders got underway on Friday to vote on a resolution brought by some investors to oust founder CEO Byju Raveendran and his family over alleged "mismanagement and fail-

Raveendran and his family stayed away from the EGM, calling it "procedurally in-

Ahead of the EGM, a group of four investors of Byju's on Thursday evening filed an oppression and mismanagement suit against the management of the company in the Bengaluru bench of the NCLT, seeking declaring of founders, including CEO Byju Raveendran, as unfit to run the company, appointment of a new board, declaring the justconcluded rights issue as void and a forensic audit of accounts

Sources with direct knowledge of the matter said the EGM was to start at 0930 hours on Friday morning but was delayed for almost an hour as some 200 people, some of them are Byju's employees, sought to join the virtual meet.

Only after due verification were the investors led in, they said, adding that some 40 people representing the investors were alowed in and would vote on the resolution moved by some investors.

However, the outcome of the vote at the EGM will not be applicable until March 13, when the Karnataka High Court will next hear Raveendran's plea challenging the move by certain investors.

The High Court on Wednesday refused to stay the EGM, called by shareholders collectively holding more than 32 per cent stake in Byju's. Raveendran and family own 26.3 per

cent in the company. The EGM notice calls for the ouster of the

operates Byju's, composed of Raveendran, his wife and co-founder Divya Gokulnath, and his brother Riju Raveendran. Byiu Raveendran on his part wrote to shareholders for the second time in a week

saying the EGM was "procedurally invalid, contractually in contravention" articles of association and shareholder agreement, "legally on the wrong side of the Companies Act. 2013, and fundamentally designed and timed to create a media circus around it"

Sources said he wrote that the investors seeking his ouster, have assumed the roles of judge, jury, and executioner.

He quoted the Wednesday order by Justice Anant Ramanath Hegde of the Karnataka High Court and said: "The decision, if any, taken by the shareholders of Byju's in the EGM scheduled on February 23 shall not be given effect till the next date of hearing.'

He went on to add that he was confident of getting a favourable final verdict. Calling the EGM invalid, he said neither he nor any other board member (the others being his wife and brother) would attend the meeting.

Under the articles of association and shareholders agreement, the attendance of at least one of the founders was necessary to form the quorum for a valid EGM, he claimed, adding that if there is no quorum within half an hour of the scheduled time, the EGM cannot com-

mence. Investors, who are seeking the ouster of Raveendran and family from the Byju's board at an EGM of shareholders for alleged "mismanagement and failures" at what was once India's hottest tech startup, have also sought a forensic audit of the company in the plea filed before the National Company Law Tribunal (NCLT) on Thursday evening, according to a court filing.

As per the filing, the investors have sought declaring the present management as unfit to run the company and appointing a new CEO and a new board

The plea also wants a forensic audit and a direction to the management to share information with the investors.

Sources said the plea seeks a declaration of the just-concluded USD 200 million rights offer as void and sought a direction that the company should not take any corporate actions that will prejudice the rights of the investors

The petition has been signed by four investors -- Prosus, GA, Sofina, and Peak XV -- along with support from other shareholders, including Tiger and Owl Ventures. The plea has been filed to prevent value erosion for all shareholders as well as preserve worth for other stakeholders -- employees and customers.

Concerns raised in the suit included financial mismanagement by the founders leading to losing control of Aakash, Byju's Alpha (TLB loan) default, and prolonged corporate governance issues, including non-hiring of CFO and independent director.

Other concerns are about "oppressive nature" of the rights offer, alleged regulatory non-compliances, "oppressive, opacity and wilful defaults" in sharing information with stakeholders, and unauthorised corporate actions regarding acquisition of Singaporean edtech company Northwest Education Pte.

The plea has also mentioned about intercorporate loans on undisclosed terms and multiple insolvency petitions filed by BCCI, TLB lenders, and Surfer Technologies Pvt Ltd.

The edtech firm in the last one year suffered other setbacks, including its auditor resigning, lenders beginning bankruptcy proceedings against a holding company and a US lawsuit disputing the terms and repayment of a loan.

Byju's was valued at USD 22 billion in 2022 and it is now valued at USD 200 million in a rights issue.

To mollify investors, Raveendran earlier this week wrote to them saying he is taking more steps to ensure transparency on how the funds will be utilised and committed to restructuring the board.

Detailing the reasons for seeking the ouster, the notice listed alleged financial mismanagement, erosion of value due to management's failure to enforce the company's legal rights, and concealment of material information.

The investors who have called for the EGM vote include South Africa's Prosus (9.10 per cent holding in Byju's), Peak XV Partners (formerly Sequoia Capital) (7 per cent), General Atlantic (6 per cent), Sofina (5.70 per cent), The Chan Zuckerberg Initiative (2.40 per cent), Owl Ventures (1.30 per cent), and Sand Capital. It is the first instance of shareholders banding together to seek a change of guard in the company. (PTI)

### Govt tweaks rules for speedy installation of electricity connection NAME CORRECTION

People can now access new electricity connection in 3 days in metropolitan areas, 7 days in municipal areas, 15 days in rural areas

NEW DELHI, Feb 23: Now getting new electricity connections will be as fast as three days in metropolitan areas, seven days in municipal areas and 15 days in rural areas, according to the latest amendments in the existing norms.

The government has approved amendments to the Electricity (Rights of Consumers) Rules, 2020, the power ministry said in a statement on Friday.

The amendments also simplified the process of rooftop solar installations and empower consumers living in multistoried flats to chose connection type and ensure separate billing for common areas and back-up generators in residential societies, thus enhancing transparency, the ministry said

The revised rule provides for checking meters installed by distribution companies in case of consumer complaints to verify electricity consumption.

According to the statement, the time period for obtaining a new electricity connection under the rules has been reduced from

seven days to three days in metropolitan areas, from fifteen days to seven days in other municipal areas, and from thirty days to fifteen days in rural areas.

However, in rural areas with hilly terrain, the time period for new connections or for modifications in existing connections will remain 30 days, it stated.

The amendments has also made installing rooftop solar systems easier and faster.

The statement also said that the revised rules will facilitate faster installation and enhance the ease of setting up rooftop solar PV systems at the premises of "prosumers" (referring to consumers who would also produce electricity through rooftop solar system).

An exemption has been provided for the requirement of technical feasibility study for systems up to a capacity of 10 kW, it stated

For systems of capacity higher than 10 kW, the timeline for completing the feasibility study has been reduced from 20 days to 15 days



Further, in case the study is not completed within the stipulated time, the approval will be deemed to have been given.

Additionally, it has now been mandated that the distribution system strengthening necessary for rooftop solar PV systems up to 5 kW capacity will be done by the distribution company at its own cost

Also, the timeline for the distribution licensee to commission

rooftop solar PV systems has been reduced from 30 days to 15 days.

Consumers can now obtain separate electricity connections for charging their electric vehicles (EVs)

This aligns with the country's goal of reducing carbon emissions and reaching net zero by 2070, it stated.

It stated that provisions have been introduced to enhance con-

sumer choice and promote greater transparency in metering and billing

Owners residing in co-operative group housing societies, multi-storied buildings, residential colonies, etc., will now have the option to choose from the distribution licensee either individual connections for everyone or a single-point connection for the whole premises.

The exercise of the option will be based on a transparent ballot to be conducted by the distribution company

A parity has also been brought in the tariff charged to consumers who get electricity supplied through the common single-point connection and to those who avail of individual connections.

Metering, billing, and collection will be done separately for individual electricity consumption sourced from the distribution licensee; individual consumption of backup power supplied by the residential association, and electricity consumption for common areas of such residential associations, which is sourced from the

distribution licensee. In cases where consumers raise complaints about meter reading not aligning with their actual electricity consumption, the distribu-

tion licensee is now required to install an additional meter within five days from the date of receipt of the complaint, it stated This additional meter will be

used to verify the consumption for a minimum period of three months, thus reassuring consumers and ensuring accuracy in billing

Union Power Minister R K Singh said in the statement that the interest of consumers is paramount for the government. It is for this purpose that the

government issued the Electricity (Rights of Consumers) Rules, 2020 on 31st December, 2020, thus setting standards for services provided by electricity distribution companies all over India.

These rules cover aspects such as billing, complaints, compensation and timelines for new connections. They also offer support for renewable energy generation by 'prosumers'. (PTI)



## Fight for farmers' rights

he recent resurgence of demands for a law guaranteeing Minimum Support Prices (MSPs) for crops reflects the ongoing struggle of farmers against corporate encroachment in Indian agriculture. Central to these demands is the need to address the distress faced by farmers and ensure their livelihood security. While some economists argue against the feasibility of implementing guaranteed MSPs, it's crucial to delve deeper into the economic implications and the broader context of agricultural policies. Critics, including economists like Dr. Ashok Gulati and Dr. Ramesh Chand, raise concerns about the financial burden on the government, suggesting that procuring all crops at MSPs would strain the budget. However, empirical data reveals a more nuanced picture. The total value of major crops entering the market constitutes a fraction of the overall agricultural produce, and government intervention need not entail purchasing every grain. With a legal guarantee in place, even a modest procurement can set a price benchmark, stabilizing markets and compelling private traders to adhere to MSPs. Contrary to exaggerated claims of bankruptcy, the additional expenditure for ensuring MSPs is manageable. By reallocating resources, such as revising corporate and wealth taxes and adjusting public sector bank liquidity ratios, the government can effectively meet the financial requirements without jeopardizing other crucial sectors.

Moreover, portraying MSPs as a "reserve price" is misleading. The proposed law aims to regulate prices in the market, not mandate government procurement of every grain. Historical precedents, such as interventions by the RBI in other sectors, underscore the feasibility of market stabilization measures. Critics also overlook the economic ripple effects of MSPs on rural communities. Unlike corporate investments, which often prioritize speculative gains, income generated from crop sales immediately circulates within local economies, driving demand and fostering sustainable growth. Furthermore, guaranteed prices incentivize diversification in crop cultivation, promoting ecological resilience and reducing dependence on monoculture. This aligns with recommendations from the Swaminathan Commission for comprehensive socio-economic reforms to enhance rural livelihoods and ensure food security. However, addressing farmers' grievances extends beyond MSPs. The broader issue of corporate encroachment in agriculture, exemplified by the contentious farm laws of 2020, underscores the need for comprehensive policy reforms. Proposed contract-based purchasing schemes, devoid of MSP considerations, risk repeating past injustices faced by farmers and serve corporate interests rather than safeguarding farmers' rights.

While demands for guaranteed MSPs represent a critical step towards alleviating farmer distress, the ultimate goal must be to challenge corporate dominance and advocate for public ownership of agricultural resources. This necessitates sustained collective action by farmers and workers to resist exploitation and advance towards a more equitable and sustainable agricultural system. The renewed calls for guaranteed MSPs highlight the urgency of addressing farmer grievances and ensuring agricultural sustainability. By implementing comprehensive policy reforms and resisting corporate encroachment, India can safeguard farmers' rights and realize the vision of inclusive and equitable rural development.

temporaries. One such luminary is Bir Chilarai, officially known as Shukladhwaja, a pivotal figure in the 16th-century Kamrupa-Kamata kingdom. Born on a auspicious fullmoon day in the month of Magh (January-February) in 1510 A.D. Chilarai was the third son of King Biswa Singha and Queen Padmavati, and brother to the reigning monarch, Naranarayan.

Chilarai, often referred to by alternative names such as Sangram Singha, Samar Singha, Chota Raja, and 'Param Rashik Guru Raja Shukladhwaja,' was renowned for his valor and humanity. His early years were marked by exposure to Brahmanical teachings under the guidance of 'Brahmananda Swami,' a disciple of 'Vishnu Puri Sanyasi.'

Upon the demise of King Biswa Singha in 1533, Malladev assumed the throne as 'Naranarayana,' while Chilarai undertook the crucial role of Naranaravana's Commander-in-Chief. The strategic organization and modernization of the Koch military machine became Chilarai's forte. His visionary approach toward soldier welfare included the allocation of freehold land based on ranks, ensuring the maintenance of soldiers' families wouldn't demotivate them during war.

The military prowess of the Koch dynasty, under Chilarai's leadership, extended to a formidable force of 52,25,000 during the reigns of Biswa Singha and Naranarayan. Chilarai not only fortified the military but also constructed well-designed forts, embankments, and ramparts for protection. His tactical brilliance, including the use of poisoned pools, guerrilla warfare, and the prioritization of Elephantry forces, earned admiration even from contemporaries like Ralph Fitch.

In 1547, before the conflict with the Ahoms, Gohain Kamal Ali, the youngest brother of Naranarayana and Chilarai, engineered a groundbreaking six-hundred-kilometer road connecting Coochbehar with North Lakhimpur. This engineering marvel, parts of which are considered the 52 No. National Highway today, exemplified the Koch dynasty's prowess.

The diplomatic and military sagacity of Chilarai became evident

beyond Ahom, including Kachar, Manipur, Jayantia, and Tripura. Each victory was marked by strategic planning, alliances, and tributes.

Chilarai's engagement with Hidimba, the kingdom of Kacharis, showcased his unique approach to warfare, employing guerrilla tactics and securing allegiance without conventional frontal warfare. The conquests continued with Manipur, Javantia, and Tripura, each marked by diplomatic overtures, tribute agreements, and strategic construction

Chilarai's patronage extended beyond the battlefield. A distinguished scholar. he translated Poet Javadeva's Gita Govinda, earning respect among the era's greatest scholars. The cultural renaissance under Chilarai included Varanasi-educated scholars like Purusottam Bhattachaivva and Pitambar Siddhantavagisa, who contributed significantly to Sanskrit learning and Hinduism in the Koch dominion.

One notable episode involves Chilarai's support for Sankaradeva, a Vaisnava reformer. Despite initial reports of dissent from the old priestly class, Chilarai not only facilitated Sankaradeva's escape from potential arrest but also contributed to the spread of neo-Vaisnavism in the Koch Kingdom.

Chilarai's legacy extends beyond military conquests; he played a pivotal role in shaping the cultural and religious landscape of the Koch Kingdom. His instrumental support for scholars, protection of cultural icons, and patronage of the neo-Vaisnava movement mark him as a multifaceted leader whose contributions deserve recognition.

In contemporary times, the legacy of Bir Chilarai lives on through Bir Chilarai Divas, an annual celebration recognizing his birthday. The Bir Chilarai Award, the highest honor for bravery, serves as a testament to his indelible impact on the history and heritage of the region. As we reflect on the overlooked chapters of history, Bir Chilarai emerges as a towering figure, leaving an enduring legacy of military acumen, cultural revival, and unwavering leadership. Ravidas's parents were said to be in close proximity of Ramananda Swami and held him on high esteem. Influence of Ramananda Swami on the family manifested in child Ravidas most of all, who began to ineven the greatest contemporary Hindus as Kafirs. sages began to surrender himself

before Ravidas in the polemics. The tales of Ravidasa's spirituality soon spread all around. and reached to the ears of the king of Kashi as well, and he invited him to his palace.

# Supreme Court scrapping electoral bonds scheme is a boon for democracy

The Supreme Court has taken a step to restrain the limitless corporate funding to allow free and fair elections. It was the issue of Electoral Bonds that had a secret system and brought to light the grim fact that corporate houses had a stronger influence over political process than a common citizen who votes. It was not only 'arbitrary', but also 'unconstitutional'. Also these bonds remained anonymous which was in violation of the citizen's right. Voters need to know if there has been any reciprocal agreement among the receiving political parties and the donors.

The SC step also scraps amendments to I-T Act, Companies Act, allowing anonymous, limitless non-disclosed company contributions, as all these are in violation of Fundamental Rights.

All these factors lead to one fact that Electoral Bonds function as political funding, which is not only illegal but also unconstitutional. And yet such funding continued. Till 2022-23, for the BJP, it was the highest at ₹ 6,566 crores. The cap on corporate funding is back. The contribution can go up to ₹ 20,000 only and no more. The Bench also asserted that Electoral Bond scheme is not exclusively to reign in the black money, and

when it is from companies, the contributions are simply business transactions. On the other hand, individual contributions are usually to boost the financial strength of the particular political party. It also turns into a pressure which is violation of democracy, since it may influence the policy making itself. The Bench also described the Electoral Bonds as means to permit unlimited corporate contributions that is an authorization to unlimited unrestricted influence over the political process.

For our democratic set up visualized by our Constitution, the apex court has taken the step to scrap a six-year-old election funding system amounting to unveiling an unholy and "unconstitutional" secret system that allowed individuals and companies to donate money to political parties anonymously and without any limits.

The largest beneficiary of the system of donations by Electoral Bonds, introduced in 2017, the ruling Bharatiya Janata Party, led by Prime Minister Narendra Modi, has come to realise the failure of the entire initiative that had benefitted them since 2018. Electoral Bonds have been challenged

since their inception by the opposition on grounds that it was systematically kept as a secret from public view and thus vi-

olated their right to know about the source of it. Under the system, a person or company can buy bonds from the state-run State Bank of India and donate them to a political party.


Individuals can donate any amount of cash. Companies had been restricted based on their revenue and profits, but the bond system removed those limits. The Supreme Court brought reinstated corporate donation limits, saying that treating companies and individuals alike for this was "manifestly arbitrary".

"The ability of a company to influence the electoral process through political contributions is much higher when compared to that of an individual ... contributions made by companies are purely business transactions made with the intent of securing benefits in return," the court wrote.

The court directed SBI to not issue any more such bonds, to furnish identity details of those who bought them, and to provide information about bonds redeemed by each political party. Despite the Supreme Court making no bones about the electoral bonds being unconstitutional, Modi's government had defended the policy earlier, rationalizing their supportive stand saying it helps in rooting out the "black money" in political funding, allowing donors a confidential channel to contribute to any party's funds. Under the system, a person or company can buy bonds from the staterun State Bank of India and donate them to a political party. Undeclared individuals and companies bought 165.18 billion rupees (1.99 billion dollars) of such bonds up to November 2023, according to the Association for Democratic Reforms, a non-government civil society group working on election funding in India. The group was a petitioner challenging the system. A five-judge bench headed by Chief Justice D.Y. Chandrachud said: "Political contributions give a seat at the table to the contributor... this access also translates into influence over policy making."Because of the close nexus between money and politics it is possible that financial contributions would lead to quid pro quo arrangements", the court said.

Finally the verdict came from five judge bench unanimously annulling the scheme, saying it violates Constitutional Rights to freedom of speech and expression and Right to information. It has been since demanded long by the progressive, democratic sections of the populace that elections must be manned by state funding and expenses never should go beyond that. It should be binding for all political parties. (IPA Service)

# Private US company makes history by landing first commercial spacecraft on Moon

WASHINGTON, Feb 23: A private American company has scripted history by landing the first commercial spacecraft on the Moon as well as the first US vehicle on the Earth's only natural satellite in more than 50 years, joining earlier feats by India, Russia, the US and China.

Built by Intuitive Machines, the lander named Odysseus - touched down on the Moon at around 6:23 p.m. ET on Thursday, making it the first American spacecraft on the Moon since the Apollo 17 mission in 1972.

"Today, for the first time in half a century, America has returned to the Moon.' Bill Nelson, National Aeronautics and Space Administration (NASA) Administrator said after Intuitive Machines, a Houston-based company, landed its Odysseus robot near the lunar south pole.

The lander carries a bounty of NASA scientific instruments, "and bearing the dream of a new adventure in science, innovation and American leadership in space, well, all of that aced the landing of the lifetime," Nelson said.

"What we can confirm, without a doubt, is our equipment is on the surface of the Moon, and we are transmitting," Flight Director and Chief Technology Officer Tim Crain announced amidst cheers among his colleagues and others across the country as there were some tense moments before the landing on the Moon



As the spacecraft made its final descent, ported mission controllers lost contact with it, as was expected to occur, NBC News re-

ported. "After troubleshooting communications, flight controllers have confirmed Odysseus is upright and starting to send data. Right now, we are working to downlink the first images from the lunar surface," Intuitive Machines said, announcing the historic feat.

"I know this was a nail-biter, but we are on the surface, and we are transmitting. Welcome to the Moon," Intuitive Machines Chief Executive Officer Stephen Altemus said during the livestream.

The lander will have seven days before darkness descends on the landing site, preventing the spacecraft's solar panels from gathering energy from sunlight and bringing freezing temperatures, ABC News re-

programme contracts to build private lunar landers that the federal space agency, among others, would use to send instruments into space, the report said.

"Congratulations to everyone involved in this great and daring quest at Intuitive Machines, SpaceX and right here at NASA. What a triumph. Odysseus is taking the Moon. This feat is a giant leap forward for all of humanity," Nelson said.

Intuitive Machines CEO Steve Altemus said that the company's employees' names are engraved into the footer to stamp their names permanently on the lunar surface.

"I had everyone's name etched on the bottom of the landing gear so that their names will be indelibly printed on the moon when we touch down softly," he told ABC News.

NASA said the lander brings NASA science to the Moon's surface. "These instruments will prepare us for future human exploration of the Moon under #Artemis," it said. The Wall Street Journal said the lander is carrying NASA research devices under a USD 118 million contract, which is part of its CLPS, as well as commercial cargo, including a sculpture project from artist Jeff Koons.

"The company and its customers are expected to have about a week to run devices before lunar night sets over the site where Odysseus landed, rendering it inoperable," the daily reported. (PTI)

# Putin takes a flight in nuclear-capable bomber in a tough message to the West ahead of election

MOSCOW, Feb 23: Russia's Pres- of the first such revamped bombers ident Vladimir Putin on Thursday took a co-pilot's seat in a nuclearcapable strategic bomber on a flight that appeared aimed at bolstering his image ahead of next month's election he's all but certain to win.

Putin's 30-minute flight in a Tu-160M supersonic strategic bomber also seemed intended to send a reminder of Russia's nuclear might amid soaring tensions with the West over the fighting in Ukraine.

Putin, 71, who is running as an independent candidate, relies on a tight control over Russia's political system that he has established during 24 years in power.

Friday's death of imprisoned Russian opposition leader Alexei Navalny sent a chilling reminder of the Kremlin's ruthless crackdown on dissent and dealt a heavy blow to the beleaguered Russian opposition. On Thursday, Putin, clad in a flight suit, boarded the warplane at a snow-covered airfield of an aircraft-making plant in the Volga River city of Kazan that has built the heavy bombers since the Soviet times.

The plant has received state orders to produce a modernized version of the Tu-160 bomber that first flew in the 1980s and was codenamed Blackjack by NATO.

flight, Putin praised the new aircraft as "excellent," noting that it has big improvements compared to the initial version.

Thursday's flight marked at least the third time he got in a cockpit of a warplane.

In 2000, he took a co-pilot's seat in a Su-27 fighter to fly to Chechnya during separatist fighting there and in 2005 he co-piloted a Tu-160 during military drills.

As part of the Kremlin efforts to project an image of an action-loving and physically strong leader, Putin also took a co-pilot's seat in an amphibious plane, flew a paraglider and drove a racing car and heavy trucks.

He also drove a heavy truck to a meeting in Kazan on Thursday, one of a series of campaign trips ahead of the March 15-17 presidential election

With prominent critics who could challenge him either jailed or living abroad and most independent media banned, Putin's reelection is all but assured. UK and EU agree to cooperate post-Brexit relations thaw further

LONDON, Feb 23: Britain and its former partners in the European Union have struck a deal to cooperate more on tackling illegal migration, in the latest sign of a thawing in relations between the two sides following Brexit.

The British government said in a statement Friday that UK border agencies and Frontex, the European Union's border and coast guard agency, will be able to access each other's intelligence to secure borders and tackle organised immigration crime

There will also be joint training, deployments of staff from one side to the other, and collaboration on research and development on new technologies.

The agreement, which will be signed later in London, doesn't include any bilateral returns agreement, which means neither side will be obliged to take any asylum-seekers under burden-sharing arrangements agreed on between the EU's 27 member states.

WASHINGTON, Feb 23: The Treasury Department plans to impose more than 500 new sanctions on Russia and its war machine on Friday as the US vows to keep up its financial pressure on Moscow with the war entering its third gruelling year.

The sanctions represent the largest single tranche of penalties since Russia's invasion of Ukraine on February 24, 2022. They come on the heels of a series of new arrests and indictments announced by the Justice Department on Thursday that target Russian businessmen, including the head of Russia's second-largest bank, and their middlemen in five separate federal cases.

The Biden administration is seeking to demonstrate its unwavering support for Ukraine, even though Republican lawmakers allied with former President Donald Trump are blocking vital additiona IUS military aid.

The White House had promised major sanctions in response to the death last week of Russian President Vladimir Putin's most prominent critic, opposition leader Alexei Navalny, in an Arctic penal colony. Biden said Thursday after meeting with Navalny's wife and daughter that the sanctions would be "against

Thousands of sanctions have already been imposed on Russian officials, businessmen, banks, companies and entire industries since the start of the war.

He, along with the two others, is also accused of trying to evade sanctions by concealing his ownership of a home in Aspen, Colorado. The indictment says Wolfson and Bond a statement. (AP)

## Hamas leader leaves Egypt after cease-fire talks with officials there

BEIRUT, Feb 23: Hamas says its political leader, Ismail Haniyeh, has left Egypt after holding talks with Egyptian officials about a possible cease-fire in the Gaza Strip and an exchange of hostages held by the militants for Palestinians imprisoned in Israel.

The statement released early on Friday by Hamas did not say whether Haniyeh's talks with Egyptian intelligence chief Abbas Kamel about ways of ending the war, a hostage deal and the flow of aid to Gaza were successful or led to a breakthrough. The talks in Cairo came ahead of a high-level meeting expected over the weekend in Paris, where international mediators will present a new proposal.

The United States, Egypt and Qatar have been struggling for weeks to find a formula that could halt Israel's devastating offensive in Gaza, but now face an unofficial deadline as the Muslim holy month of Ramadan approaches.

Israel seeks a phased deal, including a temporary pause in fighting in exchange for the release of some of the roughly 100 hostages still held by militants since the brutal October 7 Hamas attack on southern Israel. Israel has vowed to keep fighting until Hamas is crushed.

Hamas initially demanded to end the war, now in its fifth month, before hostages can be released. Hamas has said that it would release the Israeli hostages in return for the all Palestinian prisoners in Israeli jails.

Israel rejected that demand, and mediators have been working on a new deal.

During Hamas' October 7 attack on southern Israel, militants killed about 1,200 people and took some 250 hostages. Roughly half of the hostages were released during a weeklong cease-fire in November. About 100 hostages remain in captivity, in addition to the bodies of 30 others who were killed

# Taliban holds public execution for 2 men, who are killed by gunfire in a stadium as thousands watch

ruling Taliban carried out a double public execution on Thursday at a stadium in the country's southeast, where relatives of the victims of stabbing deaths fired guns at two convicted men while thousands of people watched

The Taliban's Supreme Court ruled that the two men were responsible for the stabbing deaths of two victims in separate attacks, according to a court statement. It identified the two as Syed Jamal from central Wardak province and Gul Khan from Ghazni — though it was unclear who carried out the stabbings, the two convicted men or others.

The statement also said that three lower courts and the Taliban's leader. Hibatullah supreme Akhundzada, had ordered the executions in retribution for their purported crimes. On Thursday, people crowded outside the stadium in the Ali Lala area of the city of Ghazni,

GHAZNI, Feb 23: Afghanistan's clambering to get in. Religious scholars pleaded with relatives of the victims to forgive the convicts, but they refused. Abu Abu Khalid Sarhadi, a spokesman for Ghazni police, said that relatives of the victims executed the two men. He did not say what type of guns they used.

The executions started shortly before 1 p.m. There were 15 bullets fired, eight at one of the men and seven at the other. Supreme Court spokesman Abdul Rahim Rashid said the men were shot from behind. Ambulances then took their bodies away. The killings were the third and fourth public executions since the Taliban seized power in 2021 amid the chaotic withdrawal of U.S. and NATO forces from Afghanistan.

The United Nations has strongly criticized the Taliban for carrying out public executions, lashings and stonings since seizing power, and called on the country's rulers to halt such practices. (AP)

# Heavy snowfall in higher areas of Arunachal, 70 tourists rescued

GUWAHATI, Feb 23: Around 70 people, including tourists and locals, have been rescued from Sela Pass following heavy snowfall in the higher reaches of Tawang district of Arunachal Pradesh, a defence spokesperson said here on Friday.

The Border Roads Organisation (BRO) went beyond its mandate of keeping the roads open for traffic and carried out the operation to evacuate approximately 70 tourists and locals stranded at the Sela Pass, he said

The incident took place when some vehicles got stranded at the Pass on the night of February 22/23 and the BRO mobilised its men and equipment to rescue them.

The team braved out the chilling cold with temperatures going below -10 degree celsius to save precious lives throughout the night and were able to move them to safety by Friday morning, the spokesperson said.

BRO's Project Vartak has deployed men and personnel round-the-clock at not only Sela Pass, but other important roads in the region as well to keep it accessible for traffic at all times, the spokesperson said. (PTI)

# Manipur HC decision to revoke inclusion of Meiteis in ST list evokes contrasting reactions

IMPHAL/CHURACHANDPUR, Feb 23: The Manipur High Court's decision to delete a paragraph from its March 2023 order, which urged the state to consider including the Meitei community in the scheduled tribe list, has evoked contrasting reactions from the two warring communities in the northeastern state.

While Meitei organisations said it will continue the movement for ST status for the community claiming it is not just a matter of the judiciary, a Kuki bodies welcomed the verdict asserting that it is the right decision. Keithelakpam Bhogen, the general

secretary of the Scheduled Tribe De-Committee mand Manipur (STDCM), expressed determination to continue the movement for ST status for the Meitei community despite the court's decision.

He said the issue is not solely a judicial matter and vowed to persist in their efforts, including engaging with legislators

World Meitei Council president Heigrujam Nabashyam downplayed the significance of the directive, stating that their demand for ST status would persist, unaffected by the court's decision.

The March 27, 2023 directive, believed to be a catalyst for ethnic unrest that claimed over 200 lives, was rescinded by a single judge bench of Justice Golmei Gaiphulshillu during a review petition hearing on February 21. The contentious paragraph from last year's verdict, instructing the state to expedite consideration of Meitei community inclusion, was deemed for deletion.

On the other hand, the Zomi Council Steering Committee convener welcomed the high court's decision, considering it the right course of ac-

ITLF media spokesperson Ginza Vualzong criticised the Meitei community's demand for ST status, characterising it as absurd and driven by ulterior motives such as land acquisition of tribals.

Vualzong argued that the Meiteis, being an advanced group with their language recognised in the Constitution, should not seek ST status.

Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley, while tribals, who include Nagas and Kukis, constitute 40 per cent and reside mainly in the hill districts. (PTI)

government is developing the escape trail of the Tibetan spiritual leader the Dalai Lama, from where he entered India, into a spiritual and religious tourism circuit.

Little-known Lumla in western Arunachal Pradesh's Tawang district would soon be on the national tourism map. The young Dalai Lama had passed through even stayed, in this area during his escape from Lhasa to India in 1959. The project is being executed by the state public works department.

"We are developing the escape trail of His Holiness into a religious and spiritual tourism circuit which is going on. As many as five monoliths will be constructed in each place where the Dalai Lama spent the night during his journey to India from Tibet," Tsering Lhamu the Lumla MLA told PTI.In 1959, when the Chinese crackdown on Tibet seemed inevitable and the Tibet uprising had reached the palace of His Holiness the 14th Dalai Lama at Lhasa, he along with family members and a few aides escaped to India. The escape trail was through the business route Tibet (Tsona) to Khen-Dze-mani under the Zemithang circle in Tawang district.

On March 31, 1959, the Dalai Lama and a group of eight people along with another group of eighty people were received officially at Khen-Dze-Mani by the political officer of Tawang, the 5 Assam Rifles and the people of Zemithang

Gorsam Chorten, a little far from Lhasa Dwar, is one of the largest stupas of Buddhism, located 90 km from Tawang. It was founded by a Monpa monk Lama Pradhar in the 12th century and is the largest Buddhist stupa in the region. Monpa is a major tribe of Arunachal Pradesh.

People say after he entered Zemithang, the Dalai Lama stayed in the Gorsam Chorten for a day. Zemithang is now being developed as a vibrant village in Tawang district under the Centre's vibrant village programme.

Lhamu informed that two gompas at Thonglek and Lumla areas were completed as part of the project and one museum is also coming up at Lumla which will display various artefacts related to the Dalai Lama.

District tourism officer of Tawang, Tsering Dickey said that early last year a team from the department accompanied by the then tourism secretary Sadhna Deori visited the trail site from where the Dalai Lama entered India to explore the feasibility of developing it into a tourist circuit

of the Union tourism ministry for the development of Bhalukpong-Bomdila-Tawang tourism circuit.

Swadesh Darshan scheme is one of the flagship schemes of the ministry for the development of thematic circuits in the country in a planned and prioritised manner. Under the scheme, the government is focussing on the development of quality infrastructure with the objective of providing better experience and facilities to visitors on one hand and on other hand fostering economic growth.

# **INDIA bloc members incite** people in name of caste: PM Modi

VARANASI, Feb 23: Prime Minister Narendra Modi on Friday launched a scathing attack on INDIA bloc, saying members of the opposition alliance believe in instigating people in the name of caste and making them fight.

He also said the opposition leaders cannot "tolerate" Dalits and tribal people occupying high posts. He cited the presidential election which was contested by Droupadi Murmu.

Varanasi is Modi's parliamentary constituency. The prime minister also remarked that Ravidas ji has been calling him repeatedly to his birthplace of the ancient temple town.

Speaking at a function here to commemorate the 647th birth anniversary of Sant Ravidas, Modi said, "In every era, the sermons of the saints show us the path and also alert us. In our country, whenever anybody indulges in discrimination in the name of caste, it damages humanity.

"If someone instigates (others) in the name of caste, it also damages humanity. Hence, brothers and sisters, today every Dalit and backward of the country has to



keep in mind that 'INDI gathbandhan', which believes in instigating and making people fight in the name of caste, opposes the schemes meant for the welfare of the Dalits and 'vanchit' (deprived)," he said.

The prime minister further said the truth is that these people indulge in politics of vested interest of the family in the name of wel-

fare of castes. "You must be remembering that when construction of toilets was started, they ridiculed it. They also

mocked the Jan Dhan accounts and also opposed Digital India. "Not only this, these 'parivar vaadi' (dynastic) parties have another identity - they do not want any Dalit or tribal person outside their families to move ahead. They cannot tolerate Dalits and tribal persons occupying high posts,"

Modi said. "You must be knowing that when Droupadi Murmu, the first woman tribal president, was contesting elections, then who all opposed her and which parties came

Haryana announces interest waiver on crop loans in budget amid farmer protests



CHANDIGARH, Feb 23: Haryana chief minister Manohar

Lal Khattar on Friday announced waiver of interest and penalty on certain crop loans and did not hike taxes as he presented a ₹ 1.89 lakh crore budget for 2024-25 financial While announcing the budget

proposals at a time when farmers have intensified their protests at Punjab-Haryana borders, Khattar asserted that his government has taken many steps for the welfare of the farmers and that Minimum Support Price (MSP) is being given for 14 crops.

The government has also decided to double the financial compensation to ₹ 1 crore for families of soldiers who die in the line of

"For 2024-25, I propose a budget of ₹ 1,89,876.61 crore which is 11.37 per cent more than ₹ 1,70,490.84 crore (revised estimates) of 2023-24," Khattar said while presenting the budget in the Haryana Assembly.

In a major announcement, Khattar, who also holds the finance portfolio, said that interest and penalty will be waived on crop loans taken by farmers form Primary Agriculture Credit Societies (PACS).

"I announce to waive interest and penalty on the crop loan in case crop loan was availed till September 30, 2023 and the principal amount is paid by May 31, 2024, provided the farmer is registered with MFMB (Meri Fasal Mera Byora)." he said

He said that such loans should have been taken by farmers registered on MFMB portal and thereafter, the farmers will be eligible for crop loan from PACS during Kharif season. As the chief minister made the announcement, Leader of Opposition Bhupinder Singh Hooda asked him, "you talk of farmers, then why you slap NSA (National Security Act) on farmers. Farmers are protesting on Haryana's borders"

In response, Khattar said that "as much farmers are dear to you, they are to us also".

"I am the son of a farmer, I

This comes a day after Ambala police issued a statement saying that it was implementing the process of detaining office bearers of the protesting farmer outfits under section 2(3) of the National Security Act, 1980, to maintain law and order and prevent criminal activities.

While presenting the budget in the state assembly, Khattar also announced an increase in the financial compensation from ₹ 50 lakh to Rs 1 crore for families of soldiers who die in line of duty.

He also announced that his government would provide 1,000 km of free travel in Haryana Roadways to nearly 22.89 lakh families having an annual income of ₹ 1 lakh, benefitting 84 lakh people. It will incur an estimated expenditure of ₹ 600 crore, he said.

A₹10 crore startup fund will be set for encouraging drone manufacturing in Haryana, said Khattar. The government will also train women to operate drones for agricultural purposes and these women will be called 'drone didis', he said.

"The state will also make provisions to provide drones, which may be given on rent for agricultural purposes. For details, a notification will be issued later," the chief minister said. He also announced that freedom fighters' monthly allowance will be raised from ₹ 25,000 to ₹ 40,000.

Khattar also proposed setting up of 400 new sports nurseries in the state. Besides, two high performance centres for boxing and wrestling will come up in Panipat, Sonepat in 2024-25, he added

# Shubhkaran's cremation won't happen till Punjab govt registers FIR: Farmer leaders

CHANDIGARH, Feb 23: Farmer leaders participating in the 'Delhi Chalo' agitation on Friday said the cremation of Shubhkaran Singh, who died amid clashes between Haryana Police and Punjab farmers, will not take place till the Punjab government registers a case against those responsible it.

The development came hours after Punjab Chief Minister Bhagwant Mann announced a compensation of Rs 1 crore and a government job for Shubhkaran's sister.

Subhkaran Singh, 21, a native of Bathinda, died on Wednesday at Khanauri border point on the Punjab-Haryana border amid clashes between Haryana Police and Punjab farmers. The incident took place when the farmers rushed to the barricades, several layers of which had been erected by Haryana authorities to prevent farmers from proceeding with their march, and clashed with police.

According to the medical superintendent of Patialabased Rajindra Hospital, Subhkaran had an injury to his head. The post-mortem was delayed as the farmers pressed for acceptance of their demands.

Speaking to reporters in Patiala, farmer leader Sarwan Singh Pandher said the Punjab chief minister had asserted that stringent action would be taken against those responsible for Shubhkaran's death. But now the officials are saying that it was not possible, the Kisan Mazdoor Morcha leader said

"We have told the (Shubhkaran) family that it may take two days or 10 days. For us money is not important. We are demanding that an FIR be lodged and then cremation

# **Transgender community seeks bigger share** of LS tickets; recognition of 'Trans Shakti'

NEW DELHI, Feb 23: Members of the transgender community are demanding a bigger share of tickets for the upcoming Lok Sabha polls and the recognition of 'Trans Shakti' in hopes of getting their voices heard.

Belonging to one of the country's most marginalised communities, a majority of transgender people are hesitant to join politics. However, politicians like Meera Parida, Bobbi Kinnar and Chandramukhi Muvvala among others are bucking the trend to fight for the rights of the community.

The community members said the narrative of 'Nari Shakti' (women empowerment) must be transcended so that 'Trans Shakti' can also get due recognition and representation and hoped that more political parties will give tickets to transgender candidates for the general elections.

Parida, Vice President of Biju Mahila Janata Dal, who was born as Mayadhar Parida, lamented how despite 75 years since Independence, the trans community members are shunned during the day and exploited at night. "I am ready to contest Vidhan Sabha

or Lok Sabha polls if the party decides to entrust me with the responsibility," Parida, who left home at the age of 12 after facing years of ridicule from her family members, said. She recalled how her early years were marked by a profound sense of difference, a feeling that set her apart Assembly constituency, said. from her peers. Parida said she refused to stay silent and was determined to

challenge the status quo. So, she immersed herself in social work and eventually found her voice in politics.

Aam Aadmi Party leader Kinnar, the first transgender councillor of the Municipal Corporation of Delhi, emphasised the urgent need for representation and inclusion of transgender people in the country's politics.

"A few years ago, people used to think that transgender individuals couldn't do anything; however, this is not true. Whatever men and women can do, we can do it too," she told PTI. Kinnar said politicians of the country like to wear their struggles as badges of honour, but they pale in comparison to the harrowing experiences faced by several transgender individuals. Corrobarating Kinnar's views, Muvvala, who contested as an independent candidate in the 2018 Telangana Assembly elections said there was an urgent need for the enhanced inclusion of the community in the country's politics.

"The trans community needs to talk more about the problems that we face. We know what our sufferings are like. I am a beggar on the street, a sex worker, I have been thrown out by my family, I am being extorted, molested and raped by my classmates... a lot of

transwomen, it will be better because financially we are not fit and we don't have any support," she added.

She said the current situation is such that most of the bigger parties do not even think about choosing a transgender candidate and it is only the smaller parties that consider them

Punjab CM Mann on Friday announced compensation and a job for Shubhkaran's sister.

"The family of Shubhkaran Singh, who got martyred during the farmer's movement at Khanauri border, will be given financial assistance of Rs 1 crore by the Punjab government and a government job to his younger sister. Due legal action will be taken against culprits," he said in a post on 'X' in Punjabi.

Farmers leaders were also demanding "martyr" status for Shubhkaran Singh.

Mann on Wednesday said he was saddened by the death of the young farmer and asserted that stringent action would be taken against those responsible for it. "After post-mortem, a case will be registered. Those officials responsible for his death will have to face stringent action," he had said.

The Samyukta Kisan Morcha, which spearheaded the 2020-21 farmers' stir, has announced that farmers would observe a 'black day' on Friday to mourn the death and will burn effigies of Union Home Minister Amit Shah, Haryana Chief Minister Manohar Lal Khattar, and state home minister Anil Vii.

# Payload aboard Aditya-L1 mission detects solar wind impact of Coronal Mass Ejections

BENGALURU, Feb 23: Advanced sensors of a payload on board India's maiden solar mission Aditya-L1 have successfully detected the impact of coronal mass ejections (CMEs), according to ISRO.

The payload -- Plasma Analyser Package for Aditya (PAPA) -- is an energy and mass analyser designed for in-situ measurements of solar wind electrons and ions in the low energy range, the space agency noted.

It has two sensors: the Solar Wind Electron Energy Probe (SWEEP, measuring electrons in the energy range of 10 eV to 3 keV) and the Solar Wind Ion Composition Analyser (SWICAR, measuring ions in the energy range of 10 eV to 25 keV and mass range of 1-60 amu).

The sensors are also equipped to measure the direction of arrival of solar wind particles.

Aditya-L1 spacecraft carried seven payloads to study the Sun -four to observe the light from the Sun and the remaining three to measure insitu parameters of the plasma and magnetic fields.

Aditya-L1 was placed in a halo orbit around the Lagrangian Point 1 (L1), which is 1.5 million km from the Earth in the direction of the Sun. It revolves around the Sun with the same relative position and hence can see the Sun continuously, ISRO officials said. (PTI)

# NHRC team in Sandeshkhali to hold on-spot inquiry

KOLKATA, Feb 23: A six-member NHRC team on Wednesday went to the restive Sandeshkhali in West Bengal and spoke to villagers to ascertain facts over allegations of sexual atrocities on women there.

Several villagers at Sandeshkhali in North 24 Parganas district have accused Trinamool Congress leader Shajahan Sheikh and his supporters of landgrab and sexual assault.

The team of the National Human Rights Commission, India went around some localities in Sandeshkhali and noted statements of the villagers after speaking to them.

The NHRC had earlier said in a statement that the team would be led by a member of the commission and assisted by officers of the rights panel.

The team reached Sandeshkhali via Dhamakhali ferry ghat in the morning, after crossing the Kalagachi river by boat.

The commission has taken suo motu cognisance of print and electronic media reports that in Sandeshkhali, innocent and impoverished women have been harassed and sexually assaulted.

The NHRC said it has issued notices to the chief secretary and the director general of police of West Bengal seeking reports within four weeks with regard to violence that took place, as reported in the media, in Sandeshkhali. (PTI)

# India and Oman agree to cooperate in field of archives

NEW DELHI, Feb 23: India and Oman have "agreed to cooperate" in the field of archives during a visit by a delegation of the National Archives of India to the Gulf country on February 21-22, the Culture Ministry said on Friday.

In a statement, the ministry said a draft on cooperation was "discussed and agreed upon". It said the members of the Indian delegation, led by NAI Director General Arun Singhal, was shown around various sections and divisions of the National Records and Archives Authority (NRAA) of Oman

The purpose of the visit was to explore the areas of bilateral cooperation in the archival field, it said.

In bilateral discussions with NRAA chairman Hamad Mohammed Al-Dhawyani, Singhal dwelt upon the historical ties between India and Oman and informed him about the existence of a large number of records pertaining to Oman in the NAI as well as in other repositories of India, NAI officials said.

As a gesture of goodwill, Singhal handed over "a list of 70 select documents pertaining to Oman" that are available in the NAI in Delhi. These documents cover a period from 1793 to 1953 and deal with a wide range of subjects, they said.

# Bullet train project slowed down under Thackeray govt, we'll try to make up for it: Vaishnaw

MUMBAI, Feb 23: The country's first bullet train project would have seen much progress by now had the then Uddhav Thackeray government in Maharashtra expedited permissions, said railway minister Ashwini Vaishnaw on Friday, asserting that the high-speed line will usher in economic growth.

Speaking to media persons while inspecting the work on the project here, Vaishnaw announced that the Surat-Bilimora section on the 508-km-long corridor between Mumbai and Ahmedabad could be operational by July-August 2026. The other sections will be opened one after the other thereafter, he said.

The bullet train corridor will have 'limited stop' and 'all stop' services. While the limited-stop trains will cover the distance between Mumbai and Ahmedabad in just two hours, the other service will take about 2 hours 45 minutes, the minister said.

A total of 12 stations have been planned for the project, which is being implemented by the National High Speed Rail Corporation Limited (NHSRCL).

"Had the (then) Uddhav Thackeray government given all the permissions faster, this project might have progressed much ahead by now," Vaishnav said.

He said as soon as the Eknath Shinde-Devendra Fadnavis (Shiv Sena-BJP) government came to power in the state, permissions were given in 10 days.

The Maha Vikas Aghadi government under Thackeray fell in 2022 after Shinde split the Shiv Sena with his rebellion. Shinde then aligned with the BJP to form the government and became the chief minister, with Fadnavis taking the deputy CM's post.

The railway minister said that the 284-km-long bullet train corridor viaduct is ready in Gujarat, where work has progressed speedily. It is now happening at the same speed in Maharashtra as well, he said.

The Thackeray government, unfortunately, delayed the project much but they will try to "make up for it now", he said. High-speed rail projects should be seen from an economical

standpoint and not as transport initiatives. With high-speed connectivity, areas like Mumbai, Thane,

Vapi, Surat, Vadodara, Anand and Ahmedabad will turn into a

single economic zone and it will give them a "big economic boost", the railway minister asserted.

To speed up tunnel construction, Vaishnaw said, innovations have been made and work was started from four points at a time. Of the four points two are shafts, one ADIT (additionally driven intermediate tunnel) and one final point at BKC (Bandra-Kurla Complex) station.

He said that there are complexities and difficulties tied to the corridor as trains will run at 320 kmph on it. "But our biggest aim in this project is to understand this complete technology,' he said.

The bullet train corridor has a 21-km-long tunnel, including a 7-km undersea stretch, he said, calling the work challenging.

The deepest point of the tunnel is 56 metres and it will also be very wide with a width of 40 feet. Inside the tunnel too, the trains will run at the speed of 300-320 kmph, Vaishnaw said.

"We have many cities having a population of over 1 crore. To give them low-cost and less time (consuming) transport systems, our country needs to achieve 'mahrath' (expertise) in such technology," he said.

According to NHSRCL, the 21-km shaft, which will have India's first undersea tunnel, is coming up between BKC in Mumbai and Shilphata in neighbouring Thane district. It will be a single tube tunnel having Up and Down tracks.

Work on the tunnel is underway at BKC, Vikhroli and Ghansoli. NHSRCL said they are facing multiple challenges at these shaft construction sites, which have high population density and several utilities like pipelines, electrical installation and infrastructure projects, including the Metro and highways.

"Three Tunnel Boring Machines will be used to make about 16 km of the tunnel portion and the remaining 5 km will be through New Austrian Tunnelling Method (NATM)," NHSRCL said.

The cost of the project is pegged at  $\overline{\mathbf{x}}$  1.08 lakh crore and as per its shareholding pattern, the Government of India is to pay ₹ 10,000 crore to the NHSRCL, while the two states involved, Gujarat and Maharashtra, are to pay ₹ 5,000 crore each.

The rest is to be funded by Japan through a loan carrying 0.1 per cent interest. (*PTI*)

Sarma also said the Assam government is committed to protect the land rights of all sections of the people across the state.

"Government shall provide land pattas to all deserving beneficiaries by 2026 to ensure no genuine citizen entitled to enjoy land rights is deprived of legal rights over his or her landholdings," he added.

He said all the difficulties the people had to endure during Mission Basundhara 2.0 shall be addressed and resolved in Mission Basundhara 3.0 and that the government shall start in this direction right after the Lok Sabha elections.

'Mission Basundhara 3.0 will be made simpler to allow indigenous landless people to gain land rights. Along with individual land rights, government is taking adequate steps to allot land pattas to socio-cultural institutions," he avowed.

Commenting on the advantages of the digital land pattas, the Sarma stated pattas in digital format shall help the patta owners gain access to their pattas through the dig locker medium in the event of misplacing them.

He said ever since the present government took over the state administration, it has been working relentlessly to bring about socio-economic- academic empowerment narrative.

Schemes such as Orunodoi, waiver of microfinance loans, ration cards, health insurance, transparency in government jobs, to name a few, are the testament to the government's commitment to transforming Assam into a state developed on all parameters, he said. The chief minister further said that the government has been taking steps to see that all the Orunodoi beneficiaries are entitled to Pradhan Mantri Suraksha Bima Yojana, Pradhan Mantri Ayushman Bharat and Mukhya Mantri Ayushman Asom, to name a few. Tea Tribes Welfare Minister Sanjoy Kishan, member of parliament Pradan Barua, Member of Legislative Assembly (MLA) Bolin Chetia also spoke on the occasion.

MLA Suren Phukan, chief executive of Deuri Autonomous Council Bhairav Deuri and host of other dignitaries were also present on the occasion. At a function held at the playground of Rupai High School in Doom Dooma, Sarma said despite the country achieving Independence more than seven decades back, a great number of indigenous population of the state lacked patta certificates of the land under their possession. The current government in the state had launched Mission Basundhara with the aim of mitigating the land documentation woes of such indigenous families, the chief minister added.

He also added that in the upcoming Mission Basundhara 3.0, land pattas shall be provided to religious institutions, educational institutions, anginawadi kendras, etc.

During his speech, the Sarma spoke about the various initiatives the current regime in the state has been taking for the socioeconomic uplift of the members of the tea tribe communities in the state.

"Steps such as increase in wages of tea garden labourers, reservations for youths from tea tribe communities in recruitment to government services, among others, are manifestations of the current government's commitments towards the welfare of the members of the tea tribe communities," he said.

# There is skewed negative perception of Bollywood due to social media: Emraan Hashmi

MUMBAI, Feb 23: Bollywood may have become a victim of negative perception due to some devious sharks but there are good people in the industry as well, says actor Emraan Hashmi. Hashmi is all set to play the role of a producer and a studio head in the upcoming Dinsey+Hotstar series, "Showtime", which, the actor said, does not stick to a cookie-cutter template about the industry.

The story is the fulcrum of these characters and then seeing this crazy world of Bollywood or the film industry. But the outside perception could be tainted for a few people. It has skewed negative perceptions about the industry because of the trends that have come out of social media in the last few years, Hashmi told PTI in an

interview

According to Hashmi, known for movies such as "Footpath", "Murder", "Once Upon a Time in... Mumbai", "The Dirty Picture" and "Shanghai", like any other industry, Bollywood has "good and bad aspects"

'It's like any industry where a few bad apples might make the industry seem like it's bad, but you have these kinds of devious sharks in the industry, and you also have good people, but everyone is struggling with their problems in life, Hashmi added.

The show will let the audiences in on what goes behind the multi-million-dollar industry, the nepotism debate, and the power struggles at the top, he said.

"We are not trying to show the

world what we are not. It's not a cookie cutter thing that we are just trying to show a particular facet of the industry, he said.

The 44-year-old actor, who has been in the film business for more than two decades, said when he started out, he also had the perception that the industry would be "very cutthroat and unfair". "When I started, I was all of 20, so I just had this perception. At that time, there was no social media so there was not much in the public domain. There were a few magazines in which interviews of stars would be published so while growing up, there was no such perception about the industry. Whatever I've learned about the industry was along the way. Hashmi, nephew of filmmaker Ma-

India women eye victory against Hong Kong in Turkish Cup



ALANYA (TURKEY), Feb 23: Having played determined football to get the better of Estonia in their opening match, India would be looking forward to another successful outing when they face Hong Kong in the Turkish Women's Cup here on Saturday. The 4-3 victory against Estonia

was the first-ever for a senior Indian women's national team against an European side, and it would have raised the morale of the Chaoba Devi-coached side in the four-team round-robin tournament. This will be India's fifth encounter against Hong Kong, ranked 79th in the FIFA rankings, and India would be buoyed by the fact that they have won all four previous games, netting 11 goals, while the opponents have managed just two.

In their most recent clash, a friendly in 2019, India won by a solitary goal courtesy Pyari Xaxa, who also found the net in India's victory against Estonia in the ongoing tournament.

India currently lead the table with three points and a goal difference of plus one, while Hong Kong are at the bottom having yet to open their account and a goal difference of -1 after losing 0-1 to Kosovo

Coach Chaoba Devi said Hong Kong had made a marked improvement since they last played in 2019 and her team would not underestimate the opponents.

'We played against Hong Kong a while ago, but they have shown significant improvement since then. We watched their recent match against Kosovo, where they put up a good fight despite losing by only one goal," said Chaoba Devi on the eve of the match. "So, we can't underestimate them. We if our finishing was better. Today, we will do some finishing drills in our training to prepare for the Hong Kong match and ensure the girls are ready to perform well. It's our time to win this tournament," added Chaoba Devi.

Midfielder Anju Tamang said the win against Estonia was the result of cohesiveness in the side.

"After the Olympic Qualifiers Round 2, we are together and playing as a team. Winning against Estonia was an ample testimony of our cohesiveness. We need to keep ourselves motivated and play as a team, whatever happens. We will not take Hong Kong as an easy team and try to push our limits and win tomorrow also." Chaoba Devi added that the fine blend of young and experienced players was behind India's early success in the tournament.

# Rohtas to Ranchi via Kolkata: Akash Deep's sensational journey from adversity to triumph

RANCHI, Feb 23: Laduma Devi was busy overseeing the construction of their family house in Baddi village of Bihar's Rohtas district when she received a call from Akash Deep on Thursday. "Ma, I'm making my Test debut for India tomorrow, you have to come"

Hours later, after a gruelling 300km road journey, she was at Ranchi's JSCA stadium, watching with pride and tears in her eyes as head coach Rahul Dravid handed the coveted cap to the pacer, who made an immediate impression with three top-order England wickets in the ongoing fourth Test.

The shy but stoic woman was soaking it all in with Akash Deep's two nieces and his cousin Baibhaw Kumar providing her support in the emotionally overwhelming moment. She and the family had been through hell and back but

Akash Deep was finally making it School, never wanted him to beall count.

"His father always wished for him to become a government officer, but cricket was his true passion, and I was his partner in crime. I would secretly send him to play cricket and help him pursue his dream," the proud mother told PTI as she watched her son make a sensational debut.

"During that time, if someone heard that your son was playing cricket, they would say 'yeh toh awara mawwali hi banega (he is spoilt and will become a rogue). But we had the faith in him and didn't let him give up despite losing my malik (husband) and beta (son) in six months," she said, pain still apparent in her shaky voice as she grappled with a surge of emotions. Akash Deep's father Ramji Singh, a physical education

teacher in a Government High

come a cricketer. He was paralysed after retirement and was bed-ridden for five years before breathing his last in February 2015.

In the October of the same year, Akash Deep's elder brother Dhiraj died on his way to a hospital in Varanasi following brief illness, leaving behind two daughters and wife. "If his father and brother

were alive today, they would be brimming with joy. This is the life's most memorable day and only few are lucky to see it. I'm the proudest mom on this earth," Laduma Devi said, tears rolling down her eves

"Sab bolte hain, padhoge likhoge banoge nawab; kheloge, kudoge banoge kharab. Yeh toh ulta ho gaya. (They say those who study become kings, and those who play end up spoilt. But it's the opposite in our case)." The 27-year-old was as self-assured as a seasoned pro as he blew away the English top order in the first hour's play to leave the visitors reeling at 112/5 at lunch.

There were no nerves to be seen, and why would there be, Akash Deep had known and handled bigger challenges than England's 'Bazball' much earlier in life. With the family reliant on his father's monthly pension, he had

thought of giving up his passion for cricket and focus on finding a stable income.

The youngest among six siblings with three elder sisters, Akash Deep briefly dabbled in sand selling business by renting dumpers near Sone river at the Bihar-Jharkhand border after Dhiraj's death. He would also play tennis ball cricket at that time and needed a helping hand to keep his

cricketing dream alive.

His cousin Baibhaw, whose father works at Durgapur Steel Plant allowing him access to coaching in leather ball cricket, proved to be just the man.

"I always felt he was god-gifted and I took him to Durgapur where we got his passport made and he went on to play a tournament in Dubai," Baibhaw recalled.

The the duo landed in Kolkata in search of better opportunities and stayed in a rented flat in Kestopur

But life didn't become easy with the shift as Akash Deep was rejected by three clubs -- United CC, YMCA and the famous Kalighat.

# How old-fashioned Joe Root shunned 'Bazball' to save the day for England

**RANCHI, Feb 23:** Joe Root did not bring out the sweep shot until he faced his 115th ball on a clement Friday at Ranchi and unleashed only a solitary reverse sweep while constructing a slowburning hundred to save the day for England.

Root's unbeaten 106 off 226 balls. which was made at a strike rate of 46.90, was, perhaps, the most anti-Bazball innings that might have been played in the Brendon McCullum era.

But then Root needed to rediscover that dogged Yorkie inside him - for himself and the team.

He entered the fourth Test against India on the back of 29, 2, 5, 16, 18, 7 in his last Test innings and that 18 in the first innings at Rajkot might have hurt him deeply.

England were at a dominant 224 for two, well in sight of India's first innings total of 445. But Root decided to reverse lap Jasprit Bumrah for Yashasvi Jaiswal to pull off a smart catch at slip.

His dismissal sparked an England collapse as the tourists were bundled out for 319, and India converted that lead into a record victory and a 2-1 series lead. It sparked the discussion about the

careless side of Bazball, and Root's 50plus average during the McCullum reign was not good enough to slow down the wagging fingers at him.

The 33-year-old needed an innings of substance for that, and he had to return to his original batting ways. Ian Chappell, a cricketing master-brain, offered a similar thought.

"Root had a bloody fine record playing normally, and he was a quick scorer playing normally. I don't see why he's trying to change things drastically, and I've never believed you should play premeditated shots," Chappell told World Wide Sports.

Later, Mohammed Siraj too hit his pads with an in-swinger as Root almost paid for his delayed front foot movement but for a feather of an inside edge. He was 82 then.

When Root was on 97, Akash Deep's reverse swinging in-dipper came in and slammed into his pads, but umpire Rod Tucker deemed that the ball was doing too much.

**RANCHI, Feb 23:** India unearthed a fresh pace talent in debutant Akash Deep but veteran Joe Root single-handedly kept England afloat with a tenacious hundred that shunned 'Bazball' for a more conservative approach as the visitors hobbled to 302 for 7 on the opening day of the fourth Test here on Friday.

At stumps, the 33-year-old Root was unbeaten on 106 and had used up 226 deliveries during his classical Test knock. Giving him company at the other end was Ollie Robinson (26) as England staged a decent recovery from the early jolts given by Akash Deep.

The 27-year-old Bengal pacer, who hails from Bihar, picked up three wickets in his 17 overs, marking yet another confident debut for the home side in the ongoing series.

He made life miserable for England's top-order with the new ball, grabbing the top-three in 10 balls as the visitors lost half of their side in the first session.

But Root decided to drop anchor after that, reverting to his natural style of playing the waiting game. The move got him and England the desired results as he struck his first century in 15 innings.

With the sun playing hide and seek during the fag end of the day, the Yorkshire man hit the three-figure mark for the 31st time in his Test career, striking a classy cover-drive off Akash Deep.

It took him 219 balls to get there and the former skipper did not show much emotion, fully aware that his job was not yet done. A record 10



of his 31 Test centuries are against India and the latest one came at just the right juncture.

England are reeling from back-to-back losses in Visakhapatnam and Rajkot to trail the fivematch series 1-2.

He hit nine fours in his innings and was a picture of determination, noticeably avoiding the sweep shot due to the variable bounce of the pitch

The absence of rested pace spearhead Jasprit Bumrah, who had dismissed Root thrice in this series, also gave the Englishman some breathing space. He was happy to play the spinners on the back-foot and slice the field.

His biggest ally in England's splendid recovery was wicketkeeper-batter Ben Foakes (47 off 126 balls). The visiting side went through the second session without losing a wicket for the first time in the series

The duo took their time and frustrated India by adding 86 runs in the post-lunch session when the wicket flattened out.

Post tea, Mohammed Siraj (2/60) gave the much-needed breakthrough dismissing Foakes three runs short of his half-century, caught by Ravindra Jadeja at short mid-wicket. The dismissal ended a 113-run sixth wicket partnership. Siraj also dismissed Tom Hartley (13 off 26 balls) with a brilliant delivery that exhibited late movement off the pitch, crashing into the off stump.

Hartley had earlier narrowly avoided a catch by the second slip following an edge that didn't carry. Instead, it went past Yashasvi Jaiswal and reached the boundary rope.

He departed after scoring 13, which included a powerful six off Ravichandran Ashwin over long-on. Ashwin got the scalp of Jonny Bairstow, who made a quick-fire 38 off 35 balls.

Earlier, India's good run with debutants continued as pacer Akash Deep, the fourth newcomer for the hosts in this series, showed promise for this level.

Bowling one of the finest maiden spells in a Test debut -- 7-0-24-3 -- Akash Deep dismissed Ben Duckett (11), Ollie Pope (0) and Zak Crawley (42) in 10 deliveries while bowling from the dressing room end.

The pacer, who came through the ranks playing domestic cricket in Bengal, hit the deck hard in a sensational display during the first hour's play after Ben Stokes opted to bat. (PTI)
