Elephant calf

**TEZPUR:** An elephant calf was found dead in Sonitpur district of Assam, forest officials said on Sunday. A herd of 10 wild elephants along with the calf entered Bihaguri Kalitagaon in West Sonitpur Forest Division of Tezpur on Saturday night, a Forest Department official told PTI. "The Forest Department pushed back the herd, but the calf was unable to move due to injury and it was left behind by the group. The local people provided food to the calf during the night", assistant conservator of Forest (Sonitpur) Gautam Mahanta said. The age of the elephant calf was estimated to be around three years and it fell down on the field, he added.

# Senior Cong leader Rana Goswami quits party post

**GUWAHATI/JORHAT, Feb 25:** Rana Goswami, the working president of APCC and a former twotime MLA from Jorhat, tendered his resignation as the organisational in-charge of Upper Assam and four districts in northern Assam on Sunday. Sources close to Goswami re-

vealed that he sent a resignation letter to APCC president Bhupen Borah, citing "various political reasons" for his unfortunate decision.

"I beg to state that unfortunately I am tendering my resignation as the organisational in-charge of Upper Assam including the districts Dhemaji, Lakhimpur, Sonitpur and Biswanath due to various political reasons," Goswami said in his letter to Assam Congress president Bhupen Kumar Borah.

The letter also included his resignation from the role of organisational in-charge for Upper Assam and the northern Assam districts of Dhemaji, North Lakhimpur, Sonit-



The resignation letter was copied to AICC general secretary and Assam in-charge, Jitendra

Insiders familiar with the party's internal affairs in Assam indicated that Goswami's dissatisfaction stemmed from not being consulted on certain issues within the party.

It is worth mentioning that there was a speculation claiming that Goswami might defect from the

Congress, especially after he left the Congress leader's Bharat Jodo Nyay Yatra midway in Assam. However, Goswami refuted these rumours, citing poor health as the reason for his departure from the Yatra. The decision comes after Goswami held a meeting with his followers on Saturday night at his hometown Jorhat following rumours that the former MLA was

Repeated calls made Goswami remained unanswered. Borah told PTI that Goswami has been in the party for over 30 years and "there is no question of him leaving Congress"

"There was already a process going on to shuffle the role of the working presidents as one out of the three has decided to support the government. I don't think there is any other meaning to this resignation letter," he added.

On February 14, two Congress MLAs — Kamalakhya Dey Purkayastha, who was the working president, and Basanta Das, who was a minister in the Tarun Gogoi government - announced to "support the government" without leaving the grand old party.

Both the MLAs joined the group of two other Congress MLAs -Sashi Kanta Das and former minister Siddeque Ahmed —, who too had "joined the government" but are a part of the opposition party's legislators. (With inputs from PTI)

# Assam to stop hiring teachers in colleges with low student enrolment

GUWAHATI, Feb 25: The Assam government is planning to stop teachers' recruitment in colleges and merge those or certain departments of such institutions, where student enrolment is less, education minister Ranoj Pegu said.

The government is mulling the step of merging the institutions of higher education in line with the existing policy of amalgamation of schools where student enrolment is scanty, he said.

In a post on X, Pegu said the Higher Education Department conducted a meeting with the principals and the governing body presidents of 79 colleges having less than 500 enrolments on Saturday evening

...discussed possible roadmap to enhance enrolment... Enhancing gross enrolment ratio (GER) in higher education is a priority of the government," he said.

Accordingly, the minister has directed the higher education department to draft a policy for the merger of colleges or departments having lower numbers of students,



similar to the one by the school education department. The government is "aiming at merging colleges or departments having low enrolment and to stop recruiting teachers against vacancies in dept (department) with low enrolment". The Assam government has closed down thousands of schools in the last few years through the amalgamation process.

The education department through the amalgamation process merges one school with another for various reasons such as less number of students, poor infrastructure, lower pupil-teacher ratio and higher operational cost. (PTI)

## No Mann ki Baat broadcast for 3 months in view of polls: PM Modi



NEW DELHI, Feb 25: Prime Minister Narendra Modi said on Sunday that his monthly 'Mann Ki Baat' broadcast will not be aired for the next three months in line with political ethics in view of the upcoming Lok Sabha polls.

In the 110th episode of the programme, he asked first-time voters to poll in record numbers in the elections and said their maiden vote should be cast for the country. With the general elections expected in April-May, he said there is a possibility that the Model Code of Conduct (MCC) will be enforced in March like it was done in 2019, a reference to the expected announcement

The MCC guidelines of the Election Commission asks governments to not use official events or publicfunded platforms for something that may be seen to give the ruling party publicity or political advantage.

The prime minister said it is a big success of the programme that it has been kept away even from the shadow of the government during its 110 episodes and asserted that the broadcast has been dedicated to the country's collective strength and achievements.

"It is a programme of the people, for the people and by the people," Modi said.

"However, following political ethics the 'Mann ki Baat' will not be broadcast for the next three months during this period of the Lok Sabha elections," he said. "When we meet the next time, it will be the 111th

episode of the 'Mann Ki Baat'," Modi added, noting the auspiciousness associated with the number. What can be better than this, he said.

The prime minister has frequently expressed confidence of retaining power in the elections.

The programme was deferred before the 2019 general elections as well. Modi also appealed to first-time voters to cast their votes in record numbers, asserting that the 18th Lok Sabha will be a symbol of their aspirations. Citizens are eligible to vote after turning 18. The youth should not (CONTD. ON PAGE-9)

## Focus on front liners, systematic expansion key to Kaziranga model of conservation: Director

the front liners coupled with the systematic expansion of Kaziranga National Park and Tiger Reserve in Assam has led to the emergence of a 'Kaziranga model' of conservation which has been considered a global flag bearer in forest management, its director said.

The reserve forest, which is celebrating its 50th year as a national park, witnessed that the model of conservation has helped secure the largest population of one-horned rhinoceros and wild buffalo, the highest density of tigers, Asian elephants and eastern swamp deer in the landscape, Kaziranga National Park and Tiger Reserve director Sonali Ghosh told PTI in an inter-

"In terms of biodiversity and securing their habitat, the Kaziranga or the wilderness model has been a success as it has invested in the frontline workers who protect the



30 people per square km as compared to five per sq km in the leading parks of Africa," she said.

It has the highest density of 200 anti-poaching camps with 1,500 forest personnel in the 500-square km park, Ghosh pointed out. "The trust in the forest front linmanning the anti-poaching camps all through the year, has been the key to Kaziranga's conservation success," she said.

The second factor that has ensured the success of the conservation practice is the gradual expansion of the park landscape

current 1,300 sq km, which includes the northern bank of the Brahmaputra river and the addition of Burachapori and Laokhowa last year, the KNPTR director said.

The park is home to nearly 3,000 rhinos, 2,500 wild buffalo, 1,089 Asian elephants, 1,129 swamp deers and 121 tigers, besides having a species diversity of 39 mammals, 553 birds, 64 reptiles and 41 amphibians.

The strategy of expanding the area of the reserve forest for wildlife has helped the animals flourish and the long-term conservation process, she said

"We have had ten additions to the greater Kaziranga landscape in five districts of the state, including a significant portion of the Brahmaputra river with a very unique aquatic habitat, including the Gangetic dolphins and the Indian gharial among others," she said. (CONTD. ON PAGE-9)

## Tipra Motha leaders to begin fast-unto-death stir from Feb 28

# IOC, GAIL, ONGC fined for third straight quarter for failure to appoint directors

NEW DELHI, Feb 25: Stateowned oil and gas giants including IndianOil, ONGC and GAIL (India) have been slapped fines for the third straight quarter for failing to meet listing norm requirements of having the requisite number of directors on their board.

Stock exchanges have fined oil refining and fuel marketing giant Indian Oil Corporation (IOC), explorers Oil and Natural Gas Corporation (ONGC) and Oil India Ltd (OIL), gas utility GAIL, and refiners Hindustan Petroleum Corporation Ltd (HPCL) and Mangalore Refinery and Petrochemicals Ltd (MRPL) a cumulative Rs 32.5 lakh, stock exchange filings showed.

In separate filings, the companies detailed the fines imposed by the BSE and NSE for either not having the requisite number of independent directors or the mandated women director in the third quarter ended December 31, 2023, but were quick to point out that appointment of directors was done by the government and they had no

The companies had faced fines for the same reason in the previous two quarters as well.

The six PSUs in separate filings said they have been slapped with a fine of ₹ 5,42,800 each for the third quarter. While ONGC and its subsidiaries HPCL and MRPL, GAIL and OIL faced fines for not having the required number of independent directors on their board, IOC for not having a woman inde-



pendent director on its board. Listing norms require companies to have independent directors in the same proportion as execu-

tive or functional directors. They are also required to have at least one woman director on the board. For the second quarter, IOC, ONGC, OIL, GAIL, Bharat Petroleum Corporation Ltd, HPCL and Engineers India Ltd had faced a fine of ₹ 5.42 lakh.

For the latest fine, IOC in the regulatory filing said that "being a government company, the power to appoint directors (including independent directors) vests with the Ministry of Petroleum and Natural Gas, Government of India, and hence the non-appointment of women independent director on the Board during the quarter ended December 31, 2023 was not due to any negligence/fault by the com-

Accordingly, IOC said it should

not be held liable to pay the fines and the same should be waived-

"IOC regularly takes up with ministry for appointment of requisite number of independent direc-(including woman independent director) to ensure compliance with corporate governance norms enunciated under SEBI (LODR) as well as the Companies Act," it said, adding, it had

its waiver request was granted. GAIL in the filing said "appointments are outside the purview/control of the GAIL's management."

"The non-compliance with regard to the composition of the Board was not within the control of the company and the company has been regularly pursuing with the Government of India (GoI) for appointment of requisite numbers of independent directors to meet

the compliance requirements," ONGC said.

The appointment of directors on its subsidiaries HPCL and MRPL too are done by the government.

"The company is following up with the government from time to time for appointing the required number of directors on its board and GOI is seized of the matter," HPCL said.

MRPL said it has been continuously following up with the ministry for appointment of requisite number of independent directors on the Board and "the same has been under active consideration' of the ministry.

Stating that the non-compliance was beyond the control of the company, OIL said it has requested the ministry for appointment of independent directors on the Board of the company to comply with Regulation 17(1) of the SEBI (LODR) Regulations, 2015.

The companies had cited similar reasons and remedial action when they had faced fines for non-compliance in the previous two quar-

IOC, ONGC, OIL, GAIL, BPCL, HPCL and Engineers India Ltd were slapped with a uniform ₹ 5,42,800 fine for the second quarter as well. ## **Exports venturing into uncharted** territories of Africa, Asia, Europe: Govt

is facing geo-political uncertainties, India's exports of goods like automobiles and gold jewellery have ventured into uncharted territories of Central Asia, Africa and Latin America, according to an analysis by the commerce ministry.

The analysis has shown that India has penetrated into what are termed as "absolutely new markets" in regions such as Africa, Central Asia, Latin America and North America during April-December 2023.

The "absolutely new markets" refer to areas where India did see any export during April-December 2022, but healthy growth of certain principal commodities like motor vehicles, two- and three-wheelers, petroleum products, sugar, gold and other precious jewellery were recorded in April-December 2023.

Exports of these commodities to the absolutely new markets during April-December 2023 stood at USD 234 million as against nil shipments during the same period of 2022.

It added that these commodities captured a greater number of markets in the Central Asia, Africa, and European regions.

"A comprehensive examination of country-wise exports underscores a notable diversification of markets for India's merchandise exports, characterised by the exploration of new export destinations, in spite of strong global headwinds with subdued performance globally," an official said.

The official added that after evaluating the market diversification of the country's merchandise exports across major sectors at the principal commodity level, comparing the periods from April-December 2022-23 to April-December 2023-24, significant advancements in market diversification emerged in the current fiscal. These diversified markets are termed as "absolutely new", "new", and "promising". "Together, exports to these markets capture 5 per cent of India's total exports of 42 principal commodities to the world. These commodities span across 16 important sectors of India's export basket," the official added.

In the new markets, where India's exports share of goods like ceramics and allied products, aluminium, products of aluminium, two- and three-wheelers, products of iron and steel, electric machinery and equipments was meagre or nil has jumped to USD



2.17 billion during April-December 2023.

These items have captured a greater number of markets in the America, Central Asian, and African re-

The analysis showed that the export of two- and three-wheelers has been headed to 31 new markets/countries with a total exported value of USD 110 million in the April-December 2023 period.

Similarly, in the "promising markets" such as North and South American, European, and African regions, where the share of the country's outbound shipments of these commodities was less than 1 per cent, has now increased to USD USD 8.6 billion during the first nine months period of this fiscal.

"Despite challenging global conditions, India has demonstrated notable export growth, maintaining its position in established markets while proactively exploring new ones," the official said.

This strategy not only reduces dependency on specific markets but also enhances India's competitiveness and contributes to economic development, the official added.

India's exports rose to a three-month high of 3.12 per cent to USD 36.92 billion in January despite global uncertainties, including the Red Sea crisis, while the trade deficit narrowed to a nine-month low of USD 17.49 billion.

Cumulatively, exports during the April-January period of this fiscal dipped 4.89 per cent to USD 353.92 billion. Imports contracted 6.71 per cent to USD 561.12 billion, leaving a trade deficit of USD 207.2 billion in the 10-month period of this fiscal as against USD 229.37 billion in April-January 2022-23. The Vietnam-based EV maker had signed a memorandum of understanding with the Government of Tamil Nadu for the plant, during the maiden edition of the Global Investors Meet by the DMK government in January. The foundation stone laying ceremony would be an apt example of the industry-friendly climate prevailing in Tamil Nadu and showcases the government's commitment for faster clearance of approvals as the event is conducted within 50 days of signing the MoU, an official said on Sunday

In the initial phase, VinFast Auto Ltd would invest ₹ 4,000 crore that would generate 3,500 jobs in the Tuticorin region. The plant would have a capacity to produce 1.50 lakh vehicles once it comes into operation. #### Monthly household consumer spending more than doubled in last decade

NEW DELHI, Feb 25: The per capita monthly household expenditure more than doubled in 2022-23 as compared to 2011-12, according to the latest study of National Sample Survey Office (NSSO).

NSSO, under Ministry of Statistics and Programme Implementation, conducted Household Consumption Expenditure Survey (HCES) during August 2022 to July 2023, an official statement said on Saturday.

The survey aims at generating estimates of household Monthly Per Capita Consumption Expenditure (MPCE) and its distribution separately for the rural and urban sectors of the country, for states and Union Territories, and for different socio-economic groups.

As per the survey, the average MPCE at current prices (without imputation) more than doubled to ₹ 6,459 in urban areas in 2022-23 from ₹ 2,630 in 2011-

Similarly in rural areas, it jumped to ₹ 3,773 from ₹ 1,430 at current prices.

2011-12 prices (without imputation) also increased to ₹ 3,510 in 2022-23 from ₹ 2,630 in 2011-12 in urban areas. Similarly, it rose to ₹ 2,008 from

₹1,430 in rural areas at 2011-12 prices. It showed that the average MPCE also



increased (with imputation) to ₹ 6,521 in 2022-23 from ₹ 2,630 in 2011-12 at current prices in urban areas.

Similarly, it rose to ₹ 3,860 from ₹ 1,430 in rural areas. The average MPCE at 2011-12 prices (with imputation) increased to ₹ 3,544 in

2022-23 from ₹ 2,630 in 2011-12 in urban areas It increased to ₹2,054 from ₹1,430 in

The estimates of MPCE are based on the data collected from 2,61,746 households (1,55,014 in rural areas and 1,06,732 in urban areas) in the central sample spread over all states and Union

In HCES:2022-23, the usual practice of imputation of the value figures for consumption out of home-grown/homeproduced stock and gifts, loans, free collection and goods received in exchange of goods and services etc. has been continued; and accordingly, estimates of MPCE have been generated.

Besides, a provision for collection of information on the quantity of consumption for a number of items, received and consumed by the households free of cost through various social welfare programmes has been made in HCES:2022-Consequently, the value figures for

food items: rice, wheat/atta, jowar, bajra, maize, ragi, barley, small millets, pulses, gram, salt, sugar, edible oil and nonfood items: laptop/PC, tablet, mobile handset, bicycle, motorcycle/Scooty, clothing (school uniform), footwear (school shoe etc.) received free of cost by the households through these programmes, have been imputed using an

Accordingly, another set of estimates of MPCE considering imputed values of these items and of consumption out of home produce, free collection, gifts, loans etc. has also been compiled for HCES: 2022-23. (PTI)

## Markets to focus on global trends; may face volatility, say analysts

NEW DELHI, Feb 25: With no major domestic market-moving event scheduled this week, stock market investors would largely focus on global trends and foreign fund movement, and may face volatility amid monthly derivatives expiry, analysts said.

"We expect volatility to remain high due to the scheduled expiry of February month derivatives contracts. Besides, participants should keep a close watch on the performance of the global indices, espe-cially the US for cues," Ajit Mishra, SVP - Technical Research at Religare Broking Ltd, said.

Last week, BSE Sensex rose 716.16 points or 1 per cent to close at 73,142.8 points and inched closer to its record high level of

"Markets remained volatile in the passing week but managed to end with a gain of nearly a per cent. After the initial rise, mixed global cues combined with profit taking in select heavyweights capped the momentum.

'Consequently, the benchmark indices. Nifty and Sensex, continued to oscillate in a narrow range till the end and finally settled at 22,212.70 and 73,142.80 respectively," Mishra said.

After the marginal dip, the US benchmark index, the Dow Jones Industrial Average (DJIA) has resumed the untrend and also crossed a new milestone of 39,000. With a strong base of around 38,400, we expect the prevailing tone to continue in the index and that could also help our markets to maintain the positive bias, Mishra

Investors are also expected to take guidance from the minutes of the February Monetary Policy Committee (MPC) meeting released by the central bank last week. The rate-setting panel has



hinted a cautious approach towards monetary easing amid uncertainties around inflation outlook

"On the economy front, almost all MPC members continued to express a cautious approach to monetary easing, given the uncertainties surrounding the inflation outlook," Shrikant Chouhan, Head Equity Research at Kotak Securities, said.

In the latest bi-monthly policy review held earlier this month, the Reserve Bank of India's six-member panel decided to leave the key policy rate unchanged at 6.5 per cent for the sixth time in a row.

Analysts pointed out that factors like crude oil prices, rupee movement, quarterly GDP data to be released in India as well as in the US, and monthly global manufacturing PMI data in the coming week will also influence the market sentiment.

With O3 FY24 results season behind us, the market focus will be on the macro developments both domestic and international, Chouhan said.

Besides, six IPOs worth more than ₹ 3,300 crore will be hitting the stock markets next week, including Platinum Industries and Exicom Tele-Systems public issues which will open for subscription on February 27 and IPO of Bharat Highways Infrastructure Investment Trust on February 28. (PTI)

## infuse ₹ 18,500 crore in debt market in Feb

NEW DELHI, Feb 25: Foreign portfolio investors (FPIs) continued their bullish stance on the country's debt markets with a net infusion of over ₹ 18,500 crore so far this month, driven by upcoming inclusion of Indian government bonds in the JP Morgan Index. This came following a net investment of over ₹ 19,836 crore in January, making it the highest monthly inflow in more than six years. This was the highest inflow since June 2017, when they infused ₹ 25,685 crore.

"With introduction of India in global bond indices this year, Indian debt inflows should get steady flows going ahead. Also, further frontloading before actual inclusion in June this year is also expected. This is also in line with long-term aim to deepen our underdeveloped debt-markets," Kislay Upadhyay, smallcase Manager & Founder Fidelfolio, said.

On the other hand, foreign investors pulled out ₹ 424 crore from equities during the period under review. Before this, they withdrew a massive ₹ 25,743 crore in January, data with the depositories showed.

According to the data, FPIs made a net investment of ₹ 18,589 crore in the debt markets this month (till February 23). With this, the total investment by FPIs reached over ₹ 38,426 crore in 2024. They have been injecting money in the debt markets for the past few months.

FPIs infused ₹ 18.302 crore in the debt market in December. ₹ 14.860 crore in November, and Rs 6,381 crore in October. The upcoming inclusion in JP Morgan EMBIGD in June 2024 is a major driver for the huge inflow in the debt market, Bhuvan Rustagi, Co-Founder and COO, Per Annum and Lendbox, said. Additionally, attractive yield, stable macroeconomic indicators and rel-

atively stable rupee too attracted FPIs towards the debt market. JP Morgan Chase & Co. in September last year announced that it will add Indian government bonds to its benchmark emerging market index from June 2024. This landmark inclusion is anticipated to benefit India by attracting around \$ 20-40 billion in the subsequent 18 to 24 months. This inflow is expected to make Indian bonds more accessible to foreign investors and potentially strengthen the rupee, thereby bolstering the economy. On equities front, FPIs pulled out ₹ 424 crore so far this month, sharply

down from ₹25,744 crore in January. The resilience of the market is preventing FPIs from selling aggressively despite attractive bond yields in the US, V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said. Making similar statement, Bharat Dhawan, Managing Partner at

Mazars in India, said the Indian market continues to captivate international interest, signifying not only the resilience of the economy but also the trust global investors place in its growth trajectory. In terms of sectors, FPI sell-off was significant in the banking sector,

as it saw lower-than-expected results in terms of net interest margins due to competition in deposit mobilization, smallcase's Upadhyay said. Overall, the total FPI flows for 2023 stood at ₹ 1.71 trillion in equities and ₹ 68,663 crore in the debt markets. Together, they infused ₹ 2.4 tril-

lion into the capital market. (PTI)

#### Foreign portfolio investors PV industry growth likely to moderate to less than 5% in FY25: Tata Motors

**NEW DELHI, Feb 25:** The growth of the domestic passenger vehicle industry is likely to moderate to less than 5 per cent in the next fiscal, according to Tata Motors Passenger Vehicles Managing Director Shailesh Chandra.

The company, however, expects electric vehicle sales to keep growing despite the slow pace of charging infrastructure development in the country.

"We had seen a very strong growth in FY23 of 25 per cent, which is likely to moderate in FY24 to about 8 per cent. Therefore, we are seeing with this high base effect, and FY25 will be slightly challenging with less than 5 per cent growth rate," Chandra said in an analyst call.

He further said, "As far as EVs are concerned, I

think the biggest challenge here is the pace at which the charging infra is growing. It is lagging behind the pace at which the EV adoption is happening." Citing other challenges, Chandra noted that while commodity prices have been stable in the past quarter or so, there is a risk that prices of certain items may go up

going forward. "So we are keeping a very close track of that," he added.

Chandra noted that in 2023 while the overall passenger vehicle industry grew 8 per cent year-on-year, while the EV sales grew by 95 to 100 per cent.

"And I think this trend is likely to continue. So companies with stronger portfolios in CNG and EVs will grow," Chandra said. (PTI)

## Mahindra Holidays to invest ₹ 4,500 cr to double room capacity to 10,000

NEW DELHI, Feb 25: Mahindra Holidays & Resorts India Ltd (MHRIL) plans to invest up to ₹ 4,500 crore in the next three to four years to double its room capacity to 10,000, according to company Managing Director and CEO, Kavinder Singh.

The company is actively pursuing partnerships with state governments besides setting up new resorts, brownfield expansion and acquisitions to achieve the target to increase room count from 5,000 to 10,000 by FY30.

"We have all the strategies on the table to get from 5,000 to 10,000 rooms. We are well on our way there," Singh told PTI.

At the moment, about ₹ 835 crore of investment is underway for five greenfield, brownfield, and acquisition projects, comprising about 690 keys.

"We are very confident this investment will get scaled to at least ₹ 2,000 crore in the next year and very quickly we will scale it up to



₹ 4,000-4,500 crore in three to four vears time because you need to deliver 5,000 keys by 2030," he said. On the strategy for expansion, Singh said apart from greenfield, brownfield and acquisitions, the company is also emphasising on public-private partnership (PPP).

"We have already tied up with the Uttarakhand government and identified two pieces of land to do

also have signed an MoU with the Tamil Nadu government for about ₹ 800 crore investment," he said. Further, Singh said,"We are also

at this moment of time engaged with the Odisha government and we have been allotted two pieces of land that will help us to invest at ₹ 500 crore if not more in Odisha." Besides, the company is still look-

ing at another piece of land in the Puri area, he added.

"So, PPP as a route to scale up is another weapon beyond greenfield and brownfield (expansions). The fourth weapon is acquisitions. We (are constantly) looking at resort properties, which are available and can meet our requirement, which can be refurbished to our standards is also going on," he

In January this year, the company had announced that it would invest ₹ 800 crore in Tamil Nadu to build three greenfield resorts over the next five to six years. It would be the second-largest investment by MHRIL, following the ₹ 1,000 crore investment in Ut-

tarakhand last year. MHRIL has 102 resorts across India and abroad as on June 30, 2023. Its subsidiary, Holiday Club Resorts Oy (HCR), Finland, has 33 Timeshare Properties, including nine spa resorts across Finland, Sweden, and Spain. (PTI)

The scheme, aimed at preventing erosion over a total of 7 km along the city through NABARD Infrastructure Development Assistance (NIDA), was launched at Mohanaghat, Dibrugarh.

Two spurs worth ₹ 24 crore and ₹ 27 crore will be constructed. along with geo bags worth ₹ 16 crore and ₹ 9 crore.

Addressing reporters, Dibrugarh MLA Prasanta Phukan stated, "We are aware of the erosion problem in the Mohanaghat area for the last couple of years. Today, work has begun to prevent erosion near the 8 number spur. Once the work is completed, the threat from erosion will be significantly reduced.

"IIT-Guwahati has provided us with advice, and based on their recommendations, we have taken measures to prevent erosion. Three categories of geobags and porcupines will be



used to prevent massive erosion. IIT-Guwahati conducted the survey and suggested the method, which we are implementing,'

Phukan added. Erosion has been affecting Dibrugarh town due to changes in the Brahmaputra's course upstream. Previously, the river current hit Dibrugarh's Rohmoria area, but now it directly affects the town area, causing erosion.

In 2020, six houses were washed away in the Mohanaghat area due to massive erosion.

Additionally, another project is underway parallelly to prevent erosion through the Asian Development Bank.

The significant earthquake of August 15, 1950, measuring 8.7 on the Richter scale, altered the Brahmaputra's course and raised the riverbed level in Dibrugarh by several meters. Consequently, the eral feet higher than the ground level of Dibrugarh town. Often, the Brahmaputra flows much higher than the ground level.

#### **Assam advances Uniform Civil Code**

The chief minister of Assam, Himanta Biswa Sarma, has taken a significant step by repealing the outdated Assam Muslim Marriage and Divorce Registration Act of 1935. This move is aimed at combating the prevalent issue of child marriages within the Assamese Muslim community. Sarma, known for his assertive demeanor, views this as a crucial stride towards implementing a long-awaited Uniform Civil Code (UCC), aligning with the principle of one nation, one law, enshrined in the directive principles

The decision to repeal the act was made during a meeting of the Assam Cabinet, presided over by Chief Minister Sarma himself, indicating the government's strong stance on the matter. Consequently, all Muslim marriages and divorces in Assam will now be governed by the Special Marriages Act of 1954. Sarma's determination to erase traces of the "Sharia" from the legal framework underscores his commitment to this cause, although his demeanor often elicits mixed reactions from the people of Assam. The chief minister's actions have garnered unwavering support from his Cabinet, with ministers like Jayanta Mallabarua endorsing the move as essential for realizing the BJP's vision of a Uniform Civil Code. The state government believes that this repeal will pave the way for the actualization of the UCC, aligning with the party's electoral promises. The repeal of the Assam Muslim Marriage & Divorce Registration Act also entails the displacement of 94 Muslim registrars who were previously employed under the legislation. However, the government has announced a one-time compensation of ₹ 2 lakh each for these individuals to aid in their transition. With this repeal, Assam joins Uttarakhand as one of the few states where elements of the Uniform Civil Code are already in practice. Despite initial resistance, Muslims in the state have largely complied with the laws of the land, recognizing the consequences of non-compliance. The Uniform Civil Code remains a significant electoral agenda for the Bharatiya Janata Party (BJP), alongside other contentious issues like the abrogation of Article 370. chief ministers like Sarma and Pushkar Singh Dhami of Uttarakhand face pressure to deliver on these promises to bolster Prime Minister Narendra Modi's electoral ambitions.

However, as opposition forces, including regional and national parties, voice their dissent, it's evident that the road to UCC implementation is fraught with challenges. The recent uproar over the repeal of the Assam Muslim Marriage Act underscores the deeply entrenched religious sentiments and political dynamics at play.

## BJP's nightmare begins with his Russian counterpart Congress-SP alliance in Uttar Pradesh

ongress-Samajwadi Party alliance in Uttar Pradesh is the beginning of BJP's nightmare before the Sabha elections in April/May this year. The hope hitherto generated after the January 22 Ram Temple inauguration in Ayodhya, and a prospect of falling off allies of INDIA bloc as leaves from a tree, of BJP and PM Narendra Modi's returning to power for their third term has somewhat dimmed in a fast-changing political scenario on the eve of 2024 polls.

Only a few days ago during the reply to the motion of thanks to Presidential address in Lok Sabha, Prime Minister Narendra Modi had said that BJP will be winning 370 seats and NDA 405, which later rounded to 400+. Even during the BJP's National Council Meet in Delhi, he had said, "Aavega to Modi hi" (Indeed, Modi would return). However, Congress-SP alliance in Uttar Pradesh has altered the political situation in the state in such a way that would offer many sleepless nights to PM Narendra Modi, not only in Uttar Pradesh, but also in other Hindi heartland states such as Chhattisgarh, Madhya Pradesh, and Rajasthan.

What exactly Congress-SP alliance has changed? Before finding an answer to this question, one needs to note the ongoing farmers' agitation that has made even the farmers of Western Uttar Pradesh restive, and most of them are not going with the Rashtriya Lok Dal (RLD) to support BJP or NDA. They are on the agitation path against the BJP government at the Centre led by PM Narendra Modi against the denial of legal guarantee for MSP. The situation just gone against the BJP despite the fact that Narendra Modi played Bharat Ratna Politics, awarded Bharat Ratna to Chaudhary Charan Singh, which made his grandson Jayant Chaudhary desert INDIA alliance and join hands with the BJP. Desertion of RLD paved the way for Congress-SP alliance and now SP will contest on 62 seats, Congress on 17, and Azad Samaj Party (ASP) of emerging Dalit leader Chandra Shekhar Azad on 1

The three major political

groups are now arrayed in electoral battlefield in Uttar Pradesh are: NDA led by BJP; INDIA bloc led by SP; and the BSP. BJP had won 62 seats in Lok Sabha election 2019, BSP 10,

SP 5 and Congress 1. NDA ally Apna Del (S) had won 2 seats. BSP and SP had contested the election together as Mahagathbandhan allies. BSP contesting this time alone will adversely impact BSP's electoral prospect, and the party has already lost its vote share from 19.26 per cent in 2019 Lok Sabha elections to 12.88 per cent in Vidhan Sabha election 2022.

Mayawati's support base has considerably declined, and is likely to decline further. With rise of Chandra Shekhar Azad as a Dalit leader and his alliance with INDIA block would attract Dalit votes, which will damage BJP's prospect at a time when farmers and large chunk of OBC's are already supporting

BJP's vote share in Uttar Pradesh in 2019 Lok Sabha election was 49.56 per cent, and there were 20 Lok Sabha seats where BJP's winning margin was less than 50 per cent. Congress-SP-ASP alliance and further decline of BSP's support base would make way for even closer contest with BJP on these 20 seats. There were already 16 seats with the opposition, and the loss of BSP would be gain of INDIA bloc, since Dalits of Uttar Pradesh have always been against the BJP. Thus, BJP will have to face tough battle in 36

By 2022, as the Vidhan Sabha results in Uttar Pradesh revealed, BJP's votes share has declined to 41.29 per cent from 49.56 per cent in 2019. Moreover, BJP could win only 255 seats out of 403. BJP could win 104 seats with a small margin of less than 20,000 votes. Congress-SP alliance will therefore enforce a too tough battle for BJP in these 104 Vidhan Sabha constituencies. SP+ had won 125 seats, and Congress 2, and BSP only 1 seat in 2022 Vidhan Sabha election. Hence the total number of Vidhan Sabha constituencies where BJP will have to fight a tough battle would be

This Vidhan Sabha Constituency wise electoral prospect of the BJP would adversely affect the final outcome in the Lok Sabha constituencies, since on an average 5 Vidhan Sabha Constituencies make a Lok Sabha Constituency.

By going through the 2019 Lok Sabha election results and the latest Congress-SP alliance, one can clearly see 36 Lok Sabha constituencies where INDIA block would make BJP vulnerable. However, if we consider the 2022 Vidhan Sabha election result, INDIA block would offer a tough electoral battle in at least 46 Lok Sabha seats.

As against fall of BJP's vote share by 8.27 per cent during 2019-2022, SP's vote share rose by 10.24 per cent to 32.06 per cent. Therefore, to retain its 62 seats BJP needs a swing in its favour by 8.27 per cent. Ram Temple inauguration in Avodhya, and staking claims by CM Yogi Adityanath on Gyanvapi Mosque in Kashi, and Idgah Mosque in Mathura, and asking Muslims to hand them over to Hindus temples Kashivishvanath and Krishnaianmabhumi, had initially expected to fetch electoral dividend to BJP, but Congress-SP alliance has greatly damaged its possibility. Large number of farmers, OBCs, and Dalits are turning in favour of INDIA alliance.

Since SP has its own pocket of influence is Chhattisgarh, Madhya Pradesh and Rajasthan, the alliance would boost INDIA block prospects under the leadership of Congress. Including UP, these four Hindi heartland states have 145 seats out of which BJP had won 123 seats in 2019.LokSabha elections. BJP would find it difficult to retain its seats in these states, which would also apply to its ally Apna Dal (S) in Uttar Pradesh which won 2 seats. Its ally in Rajasthan, Rashtriya Loktantrik Party had won 1 seat in 2019, which has already deserted BJP. Congress-SP alliance has put BJP in a difficult position, since PM Modi and his followers had pinned their hopes chiefly on INDIA block falling apart, especially after TMC in West Bengal and AAP in Punjab had announced to contest alone.

It is yet uncertain how much loss the BJP can make up by pushing Hindutva communal politics further, which the two new developments coming to the front – farmers protest and Congress-SP alliance - have pushed back to its rear. (IPA

## Coalition govt of Pakistan will have testing time over tackling economy

ore things change, the more they remain the same. Not much surprise surfaced when this old adage came true once more after the announcement of February 8 election results in Pakistan and formation of its government even as the political outfit which emerged victorious in maximum constituencies readies itself to sit in the Opposition benches.

In so many words, it is a chronicle of a coalition foretold when Pakistan People's Party and Pakistan Muslim League-Nawaz closed ranks to reach the magic figure of 134 seats in the National Assembly. One wonders if one would tread the path to prolixity to add that such a coalition has the blessings of the Establishment read the army headed by General Asim Munir. It boils down to the fact that Army had put its best foot forward to "manage" the elections. The new government was formed by the identical players who made up the Pakistan Democratic Alliance government post ouster of Imran Khan.

Incidentally, candidates of Khan's Pakistan Tehrik-e-Insaf contesting as independents won 93 seats. The PML-N won 75 seats while the PPP trailed behind it with 54 constituencies in its kitty; coming far behind Muttahida Qaumi Movement Pakistan secured 17 seats.

Khan being in the prison cannot be the leader of the Opposition, it would be Shehbaz Sharif of PML-N the prime minister of the PDA government who would be sworn in the oaths of office the second time. There is a clear division of the spoils of a rigged poll victory. Asif Zardari, the PPP chief will be the President while the Senate chairmanship will also go to PPP together with the governorships of Punjab and Khyber Paktunkhwa.

The post of Speaker of the National Assembly will be part of PML-N's spoils. Not joining the government, the PPP will be voting on the no-confidence motions with the ruling party and the spending Bills

The "coveted role" of the elder statesman to the alliance will be played by former Prime Minister, Nawaz Sharif. One wonders, whether Shehbaz Sharif will be comfortable in his crown of thorns given the fragile nature of the alliance and the fallout of the unpopular and harsh decisions he will have to take once he assumes office.

On becoming the Prime Minister, Sharif cannot shirk from unpopular economic decision as growth has slowed down in Pakistan. Since 2011, external debt has almost doubled and there has been a six-fold increase in its domestic debts.

Pakistan is en route to default in payments thereby taking it into deeper economic crisis. Hard choices, serious reforms and another IMF bailout are some of the beacons at the end of the tunnel.

The PPP already against pro -market reforms will side step sans much definess as it is not part of the coalition government. Small wonder, it is Shehbaz Sharif and his Cabinet colleagues who will be the targets of the ire of the populace post the economic belt-tighten-

Insurgency in Balochistan and its western border of Afghanistan pose serious security challenges to Pakistan. What about India whom its powers that be often finds it convenient to dub the sources of its

Before reading the thoughts of the new dispensation across the border and the power behind the throne, the army, India can view the new government with cautious optimism. Nawaz Sharif has always displayed a willingness to engage with India.

There was considerable personal warmth between Sharif and Prime Minister Narendra Modi during the latter's swearing in 2014. It was cemented by PM Modi's surprise visit to Lahore next year. Barring a few incidents, the ceasefire agreement along the Line of Control in Kashmir dating to 2021 holds. It is possible to open channels on some issues though Pakistan took a view it could have dispensed with in the wake of abrogation of Article 370.

One does not expect an overnight dropping of guard. But security gains of the past can be strengthened through limited bilateral engagements. Of course, a spanner in the works can be thrown in by the army and Imran Khan-led PTI. The latter entity remains an elephant in the room for the coalition government.

They have already raised the issue of a "stolen mandate". As soon as the NA convenes, the PTI Opposition will train its guns and fire broadsides at the alliance keeping alive the new government's crisis of legitimacy. (IPA Service)

utism, or autism spectrum disorder (ASD), is **\**a developmental condition that can affect social interaction, communication, and behaviour.

Conversely, Alzheimer's disease is a progressive neurodegenerative disorder primarily associated with memory loss and cognitive decline.

While these conditions differ significantly in their characteristics and onset, recent research suggests autistic adults have an increased risk of developing Alzheimer's disease and other types of dementia.

This article explores the link between autism Alzheimer's disease, examining their symptoms, diagnosis, and available support for these conditions.

#### Is there a link between autism and Alzheimer's dis-

In a 2021 study of public health records, researchers found that autistic middle-aged adults appear to be more likely to receive a diagnosis of Alzheimer's disease or other dementias than non-autistic people.

Furthermore, it appears memory declines faster in

autistic middle-aged adults. Autistic middle-aged adults also have a higher likelihood of a specific gene called APOE4. This gene increases the risk of developing Alzheimer's disease in later life and can lead to early shrinkage of the hippocampus, the brain's main

While these findings suggest a relationship between autism and Alzheimer's disease, research is ongoing. The exact mechanisms and causal factors underlying this connection require further investigation.

As the disease progresses, memory problems become more pronounced, affecting recent occurrences and those in the distant past. People may not recognize close family members. They may forget names, appointments, or where they place everyday objects.

A person with Alzheimer's disease may also: • find certain tasks difficult,

such as those they used to handle easily, including managing finances, cooking, or following familiar processes

• have trouble finding the right words, following or joining conversations, or repeating

themselves in conversation • become confused about the current date or their location, even in familiar surroundings

 find basic activities difficult, such as bathing, dressing, and grooming

• experience mood changes, irritability, and changes in personalitv

• have communication difficulties, such as difficulty understanding spoken or written language

Eventually, people with Alzheimer's disease may lose the ability to walk, sit, and swallow. They will need caregivers to manage all aspects of care, including feeding, bathing, and toileting.

#### Early diagnosis of both

Early diagnosis of autism and Alzheimer's disease is crucial, as it allows for timely intervention and support.

By identifying signs of autism at a young age, healthcare professionals can initiate any needed interventions and support. For instance, speech, occupational, and behavioural therapy can help address specific challenges and enhance communication and social

Likewise, there is no guaranway to teed Alzheimer's disease. That said, certain lifestyle strategies may help reduce its risk or delay its onset. These include:

## Minimally invasive cancer surgeries changing the face of cancer treatment

astrointestinal cancers impact the GI tract and the digestive system including Esophagus, stomach, small and large intestines, liver, gallbladder, pancreas, etc. These cancers can originate from any organ in the abdomen as ulcers or masses and can metastasize to the other parts in no time if go unno-

While timely diagnosis increases the chances of better treatment and prolonged survival of the patient, delayed treatment impacts the outcome of the treatment and may also have adverse consequences on the quality of life. The rise in cases also show the low level of awareness due to which early detection isn't possi-

From the past few years, the incidences of gastrointestinal and HPB cancer cases have been rising at an exponential rate in our country, particularly due to the lack of awareness associated with the subject. Early diagnosis and prompt treatment have significant importance in preventing mortality from such diseases.

On the other hand, the rapidly growing advancements in the field of science and technology, newer treatment options like minimally invasive GI surgeries, Laparoscopic surgeries and Robotic surgeries have completely changed the face of cancer treatment at a greater scale. Minimal invasive GI surgeries have become a great addition to the field as they provide an innovative approach in the treatment of cancer while ensuring minimal blood loss, quicker recovery and shorter

Recent data shows that developing countries are facing a sharp increase in cancer incidence. But

at the same time, there have been numerous advancements in cancer care. However, the majority of our population is not able to avail of the benefits of these developments due to a sheer lack of knowledge and myths associated with the subject.

One of the biggest reasons for the rise in such cases is lack of awareness among the general public about the early signs and symptoms which leads to delayed diagnosis and treatment causing poor prognosis. Poor lifestyle choices including unhealthy dietary intake with dependence on junk food, along with binge alcoholism and erratic sleep patterns are some of the major known causes of the exponential rise in such cases. Early and prompt treatment can help prevent the

rise in GI diseases. As of the Globocan India 2020 report, gastrointestinal (GI) cancers continue to pose a significant health burden in the country. The data reveals varying incidences and mortality rates across different types of GI cancers. Colorectal cancer, a common GI malignancy, showed notable incidence, with a substantial number of new cases reported. Similarly, stomach cancer demonstrated a significant presence in the popu-

The mortality rates associated with GI cancers underline the severity of these conditions, emphasizing the need for effective prevention, early detection, and treatment strategies. The Globocan India 2020 findings underscore the importance of ongoing efforts to address the challenges posed by GI cancers and to implement comprehensive public health measures to reduce the incidence and mortality rates associated with these diseases.

With the advancement of tech-

nologies, minimal access to cancer surgeries has also become commonplace. Experts can adequately resect difficult tumors including colon cancers, stomach cancer, including liver metastases which suggest a late-stage disease, with minimal incisions or even laparoscopically, in certain

1. Endoscopy:

• Colonoscopy: This procedure involves inserting a flexible tube with a camera (colonoscope) into the rectum to examine the entire colon. It is effective in detecting colorectal cancers and

•Esophagogastroduodenoscopy (EGD or Upper Endoscopy): This involves the insertion of a scope through the mouth to examine the esophagus, stomach, and the beginning of the small intestine. It is commonly used for detecting esophageal, stomach, and duodenal cancers.

2. Endoscopic Ultrasound EUS combines en-

doscopy with ultrasound imaging, providing detailed images of the digestive tract and surrounding structures. EUS is particularly useful for assessing the extent of GI cancers, staging tumors, and guiding biopsies.

3. Computed Tomography (CT) Scan:

CT scans are used to obtain detailed cross-sectional images of the abdomen and pelvis. They are valuable for detecting tumors, evaluating lymph nodes, and determining the extent of cancer spread.

• MRI can provide detailed images of soft tissues, making it useful for evaluating the liver, pancreas, and other abdominal organs. It is often employed for staging and planning treatment. 5. Biopsy and Pathological

microscope to confirm the presence of cancer and determine its type and grade.

6. Tumor Markers:

· Blood tests measuring specific biomarkers associated with certain GI cancers may aid in diagnosis and monitoring treatment response. Examples include CEA (carcinoembryonic antigen) for colorectal cancer.

7. PET-CT Scan:

 Positron emission tomography combined with computed tomography can be used to detect abnormal metabolic activity, helping to identify areas of possible cancer spread.

Minimally invasive surgeries have numerous advantages for patients in comparison to traditional surgeries including minimal scars, faster recovery, reduced pain, shorter duration of hospital stays, and lesser postsurgery complications. The preference for Robotic Surgery has increased after the pandemic since it reduces hospital stay and post-surgical complications.

People still need to be aware that with recent advancements in oncology, cancer is completely treatable. And early diagnosis can, not significantly increase the chances of survival, but also provide a better quality of life. ## Chronic Kidney Diseases - Diagnosis & Treatment

The burden of chronic kidney diseases in India cannot be assessed accurately. The approximate prevalence of CKD is 800 per million population (pmp), and the incidence of end stage renal disease is around 150-200 pmp. Most common cause of kidney disease is diabetes and high blood pressure. Both the diseases are related to our genetics and lifestyle, hence the emphasis is to keep our diabetes and blood pressure under control with medicines, exercise and a blend of healthy food. Blood pressure not only needs to be judiciously controlled, but weather its secondary to kidney disease also needs to be ruled out. Young people developing high bp especially needs to be screened for underlying kidney diseases often people feel depressed once diagnosed with chronic kidney disease (CKD), hence the whole idea of doctors is now to focus on a holistic approach when dealing with CKD. This involves dietary change, avoiding pain killers, quit smoking and to promptly refer to a nephrologists, once diagnosed with diabetes, high BP or any form of CKD. Certain kidney diseases are controllable/ treatable hence the need to promptly diagnose the disease and treat it.

Preventive strategies play a very pivotal role in

dealing with CKD. Regular health checkups form an integral role in screening of CKD during early phase, which i think should be inculcated in schools, colleges at entry level and while joining a new job or organization. Since treating a CKD patient is more expensive these screening strategies will definitely reduce the financial burden on the patient and on the society as whole. Another most neglected area in our country is lack of physical activity/regular exercise. Regular exercise not only improves physical well being, but also is a stress buster for a lot of patients. All these measures help in creating awareness in coping with the kidney disease and allow the patient to deal with his disease with a positive mindset. Being in regular follow up with one's kidney physician helps the patient to help discuss strategies to not only control his disease but also to formulate a planned way of dealing with his ailment. India being a big country with patients having varied dietary habits, diet plays a very important role when it comes to kidney diseases; hence patients regular diet counselling is very important. Kidney diseases have a variable presentation; hence a tailor-made therapy is important for each kidney patient. Speaking to FIT in November 2022 about young people opting for surgeries, Dr Kedar Tilwe, Consultant Psychiatrist, Fortis Hospital Mulund & Hiranandani Hospital, Vashi, had also said that social pressure, body image issues, and criticism or bullying pushes people more and more towards permanent cosmetic treatments.

polishing: What the new age bride and grooms want

And what's the trend now? Dr Jaishree Noor, Consultant, Dermatology, Cosmetology, and Laser Expert, Marengo Asia Hospitals, Gurugram, tells FIT that the most common cosmetic surgical procedures are started weeks or months before the actual day comes. These include microdermabrasion (which is a sort of body polishing done on the face and the body) and liposuction (removal of excess fat from the body). Other common procedures, says Dr Lall, are botox, fillers, laser hair removal, other laser treatments,

etc. She adds, "A lot of people come to get their acne, pimples, and scars treated. So, most of them would require microneedling. There are others who want to get their skin tightening and lifting procedures done, which we do with radio frequency based devices."

Dr Lall also mentions that there are some procedures that people get done to help with their insecurities perhaps – getting skin boosters for "light reflection and a shine on their face," surgery for a sharper jawline, removing unibrows, hair transplants, chemical peels, hydra facials, etc.

While some of these procedures are minor and surface level, treatments like microneedling, liposuction, and botox can be invasive and major surgeries as well.

an impending ischemic stroke, making it crucial for individuals to recognize the distinction in symptoms and seek prompt medical attention. It is a prevalent issue that many individuals, especially those in older age groups with common risk factors such as hypertension, diabetes, and high cholesterol, frequently mistake the symptoms of stroke for those of a heart attack.

While the public is well-aware about the typical signs of a heart attack, signs and symptoms of stroke often go unnoticed, leading patients to approach cardiologists first. A significant challenge arises when indi-

Every minute in stroke, 2 million cells die and thus even a small delay in seeking treatment can significantly affect patient out-

blood pressure and attribute their condition to hypertension. While elevated blood pressure is common in stroke patients, it is a reactive response and not the root cause. Rather than focusing solely on blood pressure, it is important to target the closed blood vessel responsible for the stroke.

Not all chest pain indicates a heart attack, some

may signal an impending ischemic stroke

It is thus important to recognize stroke symptoms early and seeking treatment at hospitals equipped with stroke centers. Stroke symptoms manifest differently from heart attack symptoms. Stroke patients commonly present with weakness on one side of the body, transient weakness or numbness, sudden difficulty in understanding or speaking, slurring of speech, imbalance, inability to walk, lack of coordination, and even loss of vision in one eye.

sis involves administering clot-dissolving medicine intravenously within four to five hours of a stroke. Mechanical thrombectomy, a method gaining popularity in the last decade, involves neurointerventionists using a stent retriever device to remove clots from blocked brain blood vessels, restoring normal blood flow

It is a known fact that 20% of strokes are attributed to cardiac problems, including arrhythmias, heart valve diseases, and previous heart attacks. Patients with these cardiac issues may consult cardiologists, leading to delayed neurological intervention and potentially impacting treatment outcomes. Such public awareness platforms serve as a crucial step in educating the public on the distinctions between stroke and heart attack

Haley received 39.4 per cent of the votes against Trump's 59.9 percent

CHARLESTON, Feb 25: Indian-American presidential candidate Nikki Haley lost to former president Donald Trump in her home state of South Carolina, despite giving a better-than-expected fight in the Republican presidential primary.

Refusing to give up, the 52-year-old twotime former governor of South Carolina on Saturday vowed to take the fight to the Super Tuesday states on March 5 when Republican primaries are scheduled to be held in 21 States nationwide.

With nearly 90 per cent of the votes counted, Haley received 39.4 per cent of the votes against Trump's 59.9 per cent, a gap of 20 per cent.

All the polls had earlier indicated that the former UN Ambassador was trailing by 30 per cent against Trump, who further consolidated his path to a third straight GOP nom-

A candidate needs 1,215 delegates to bag the party's nomination. So far, Haley has won 17 delegates and Trump has won 92.

"I said earlier this week that no matter what happens in South Carolina, I would continue to run for president. I'm a woman of my word. I'm not giving up this fight when a majority of Americans disapprove of both Donald Trump and Joe Biden," Haley told her supporters in this historic city, a few blocks away from where she had launched her presidential campaign about a year ago.

"What I saw today was South Carolina's frustration with our country's direction. I've seen that same frustration nationwide. I share it. I feel it to my core. I couldn't be more worried for America. It seems like our country is coming apart. But here's the thing. America will come apart if we make the wrong choices. We need to beat Joe Biden in November," she said amidst cheers from her supporters.

"I don't believe Donald Trump can beat Joe Biden. Nearly every day, Trump drives people away, including with his comments just yesterday. Today, in South Carolina,



we're getting around 40 per cent of the vote. That's about what we got in New Hampshire

"I'm an accountant. I know 40 per cent is not 50 per cent. But I also know 40 per cent is not some tiny group. There are huge numbers of voters in our Republican primaries who are saying they want an alternative," Haley said, making her case for her to continue her battle against Trump.

"South Carolina has spoken. We're the fourth state to do so. In the next ten days, another 21 states and territories will speak. They have the right to a real choice, not a Soviet-style election with only one candidate. And I have a duty to give them that choice. We can't afford four more years of Biden's failures or Trump's lack of focus," Haley said.

A confident Trump celebrated his victory in Columbia, South Carolina.

"There's never been a spirit like this, and I just want to say that. I have never seen the Republican Party so unified," he told his cheering supporters. Notably, he did not mention Haley in his speech nor did he ask her to drop from the race.

Haley in his speech in Charleston congratulated Trump on his South Carolina victory. Trump, who by now has won all four Republican primaries in Iowa, New Hampshire, Nevada and South Carolina, exuded

confidence that he would defeat incumbent

President Biden in November. 'We're going to be up here on November 5, and we're going to look at Joe Biden, and we're gonna look him right in the eye. He's destroying our country and we're gonna say 'Joe, you're fired. Get out. Get out, Joe. You're fired," Trump said amidst loud applause from his audience.

In her speech, Haley criticised both Biden and Trump.

"Does anyone seriously think Joe Biden or Donald Trump will unite our country to solve our problems? One of them calls his fellow Americans fascists. The other calls his fellow Americans vermin. They aren't fighting for our country's future. They're demanding we fight each other. YOU deserve

"So I will keep fighting - for them and for you and for all of America! I'm running for president to save America! And I'm running to remind us what it means to be American. In the America I know and love, we believe

in each other. And we believe in America's

inherent goodness. Now is the time to renew that belief. Now is the time to remember who we are," she said. "I'm grateful that today is not the end of our story. We're headed to Michigan tomor-

row. And we're headed to the Super Tuesday states throughout all of next week," Haley

Following the South Carolina primary, President Biden said that Trump poses a threat to the country.

"Despite the threat that Trump poses, I will say again to the American people: I have never felt more optimistic about what we can do if we come together. Because I know that America believes in standing up for our democracy, fighting for our personal freedoms, and building an economy that gives everyone a fair shot. To Republicans, Democrats, and independents who share our commitment to the core values of our nation, join us. Let's keep moving forward," Biden said. Democratic National Committee Chair Jaime Harrison said that the results of the South Carolina Republican Primary all but confirm that MAGA extremism has taken over the Republican Party — and that Donald Trump will once again be the Republican nominee for president.

"Just like he did in 2020, Donald Trump is running on an extreme, out-of-touch agenda that rolls back the clock on our personal freedoms, undermines our democracy, and rigs the economy in favour of the ultrawealthy — and he has become only more extreme since his resounding loss to Joe Biden last cycle. The American people rejected MAGA extremism in 2018, 2020, 2022, 2023, and will reject it again at the ballot box this November," he said. (PTI)

Israeli media report progress on reaching a temporary truce in Gaza and a hostage-prisoner exchange



TEL AVIV, Feb 25: Mediators are making progress on an agreement for a weeks-long cease-fire between Israel and Hamas and the release of dozens of hostages held in Gaza as well as Palestinians imprisoned by Israel, Israeli media reported Sun-

Israel's War Cabinet met to discuss the proposal late Saturday, but there was no official word on what they had decided. Several Israeli media outlets, citing unnamed officials, said it tacitly approved the deal and that Israel would send a delegation to Qatar for further discussions.

Hamas says it has not yet been involved in the latest proposal developed by the United States, Egypt and Qatar, but the reported outline largely matches its earlier demands for the first phase of a truce. Hamas' top political leader, Ismail Haniyeh, was in Cairo last week.

Israel is meanwhile developing plans for expanding its offensive to the southernmost city of Rafah, on the Gaza-Egypt border, where more than half the territory's population of 2.3 million have sought refuge in squalid tent camps, packed apartments and overflowing shelters. Aid groups have warned of a catastrophe and the US and other allies of Israel have said it must avoid harming civilians.

Israeli Prime Minister Benjamin Netanyahu said he'll convene the Cabinet this week to "approve the operational plans for action in Rafah", including the evacuation of civilians.

A senior official from Egypt, which along with Qatar is a mediator between Israel and the Hamas militant group, said Saturday that the draft cease-fire deal includes the release of up to 40 women and older hostages in return for up to 300 Palestinian prisoners, mostly women, minors and older people.

Israel responded to the attack with a massive air and ground offensive that has driven around 80 per cent of Gaza's population from their homes, putting hundreds of thousands at risk of starvation and the spread of infectious disease. The Health Ministry in Hamas-ruled Gaza says 29,606 Palestinians have been killed since the start of the war, two-thirds of them women and children.

The ministry's death toll doesn't distinguish between civilians and combatants. Israel says its troops have killed more than 10,000 militants, without providing evidence.

The war has devastated the territory's health sector, with less than half of hospitals even partially functioning as scores are killed each day in Israeli bombardment.

At the Emirates Hospital in Rafah, three to four newborns are placed in each of its 20 incubators, which are designed for just one. Dr Amal Ismail said two to three newborns die in a single shift, in part because many of their families live in tents in rainy, cold weather.

"No matter how much we work with them, it is all wasted," she said. "There is no health improvement because of the conditions of living in a

## Sunak warns of 'toxic' culture in UK politics amid threats to MPs

LONDON, Feb 25: British Prime Minister Rishi Sunak has warned against a growing toxic culture in politics amid reports of members of Parliament facing security threats over their voting intentions in the House of Commons related to the Israel-Gaza conflict.

The 43-year-old British Indian leader issued a statement on Saturday to condemn the hijacking of protests on the streets of the country by extremists to glorify terrorism. It came as a report in 'The Sunday Times' newspaper claims that three unnamed female MPs have been sanctioned additional security after concerns

"The explosion in prejudice and antisemitism since the Hamas attacks on the 7 October [2023] are as unacceptable as they are un-British. Simply put antisemitism is racism." said Sunak in his statement.

"Legitimate protests hijacked by extremists to promote and glorify terrorism, elected representatives verbally threatened and physically, violently targeted and antisemitic tropes beamed onto our own Parliament building," he said, with reference to an offensive projection on the



Palace of Westminster recently. "And in Parliament this week a very dangerous signal was sent that this sort of intimidation works. It is toxic for our society and our politics and is an affront to the liberties and values we hold dear here in Britain," he said of the scenes of chaos in the Commons last week over a Gaza ceasefire

While he did not make a reference to it specifically, his intervention came soon after the governing Conservatives suspended party MP Lee Anderson after he claimed during an interview that Pakistani-origin London Mayor Sadiq Khan was under the control of "Is-

The Opposition had demanded action over the remarks, which Labour Leader Keir Starmer branded as a "racist and Islamophobic out-

"This isn't just embarrassing for the Conservative Party, it emboldens the worst forces in our politics," said Starmer. The row follows an article

by former home secretary Suella Braverman over the weekend that claimed Islamists and extremists were taking charge in all walks of life in Britain, attacked as "extreme rhetoric" by the Opposition parties.

Braverman, sacked from the Cabinet by Sunak last year,

#### Pak's poll body gears up to hold **President's election by March 9**

ISLAMABAD, Feb 25: Still struggling to address the rigging allegations after general elections in the country, Pakistan is now gearing up to elect the new president by March 9. The Election Commission of Pakistan (ECP) is set to hold an election for the office of the country's president by March 9, two days before the retirement of half of the senators after completing their six-year term, Dawn reported quoting sources.

'The president will be elected by the present senators after setting up of all the four provincial assemblies," a senior Pakistan Peoples Party (PPP) office-bearer said, adding that the election could take place on March 9 or 10 The six-party alliance, set to form

a coalition government at the Centre under the Pakistan Muslim League-Nawaz (PML-N) Shehbaz Sharif, has already announced Asif Ali Zardari as its consensus candidate for the country's top constitutional office. Zardari previously served as the president from September 2008 to 2013 after the resignation of the military ruler Pervez Musharraf.

Article 41(4) of the Constitution says that "election to the office of president shall be held not earlier than sixty days and not later than thirty days before the expiration of the term of the president in office: Provided that, if the election cannot be held within the period aforesaid

dissolved, it shall be held within thirty days of the general election to the Assembly".

Since the general elections were held on February 8, the presidential election is required to be conducted by March 9, just two days before the retirement of half of the 100member Senate. The sources said the Senate elec-

tions were also due in the first week of March, but because of the delay in the general elections of the National and provincial assemblies, the Senate elections will now be held either in the last week of March or the first week of April which means the upper house will remain dysfunctional and incomplete for some period.

According to a PPP leader, it is because of the upcoming presidential election and to ensure Zardari's win that the party has stopped its two senators, Nisar Khuhro and Jam Mahtab Dahar, from taking the oath as MPAs in the Sindh Assembly. According to the formula applied for the president's election, the vote of a senator is counted as a single vote, whereas in the Sindh Assembly, one vote will be equal to nearly four votes.

In this way, Zardari will get benefit in the presidential elections. Incumbent President Dr Arif Alvi is already on an extended tenure after completing his five-year term on September 9 last year. Article 44(1)

because the National Assembly is of the Constitution says that the president will hold office for a term of five years from the day he assumes charge, but he continues to hold the office until a successor is

> Dr Alvi is the country's fourth democratically elected president to complete the five-year term. The three presidents before Dr Alvi who completed their full terms were Chaudhary Fazal Elahi (fifth president, from 1973 to 1978), Asif Ali Zardari (11th, from 2008 to 2013), and Mamnoon Hussain (12th, from 2013 to 2018).

Therefore, Dr Alvi is the third consecutive president to have a full term and the first one to have an extended term due to an incomplete electoral college, which comprises the National Assembly, Senate and the four provincial assemblies. The term-wise data of senators suggests that the PML-N and the PPP stand to lose a large chunk of their members — 69 per cent and 57 per cent, respectively — as they retire on March 11 after completing their

But after the February 8 polls, both the PML-N and PPP will be able to add to their tally in the Senate. The PTI, however, will be at a definite disadvantage if it fails to conduct the intra-party elections before the Senate polls, and it may have to depend on the SIC to get representation in the upper house of the parliament. ## British Indian doctor's rock band embarks on UK-wide tour

LONDON, Feb 25: A 25-year-old British Indian doctor whose passion for music resulted in a band with some of his fellow medical colleagues has embarked on his first UK-wide tour, with the launch show in London recently proving a sell-

Gulzar (Gulz) Singh Dhanoya started the indie-rock band named Gulz during his university days as a medical student. It was over the COVID pandemic that the singersongwriter plucked up the courage to put out some of his musical creations onto the audio streaming service SoundCloud and soon this one-man bedroom project struck a chord with an ever-expanding fan base. The lead singer and songwriter is now busy rehearsing with his four bandmates for their next live gig in

Birmingham on March 16. "How it usually works is that at the moment I go away and think of an idea for a song and it's very bare bones. Then we go into a studio rehearsal room and all of us together kind of think about our parts and we just keep playing it over and over. It's a great way to kind of balance our creative ideas," Gulz told PTI.

While two of his other bandmates are also National Health Service (NHS) doctors like him, two are professionals in other fields which he feels helps bring some flexibility to striking a balance with late-night hospital shifts. He admits some-



times wondering how they are all able to commit to their music with stressful full-time jobs.

"It's a huge commitment. Obviously, the working day is long and then it's fitting in shows and rehearsals and social media stuff. It's like a second job and one that doesn't realistically pay compared to a 'normal' job. It's very cliche, but it's just because we love it," he said.

Born in Newcastle to a Punjabi father born in India and mother born in Southall, west London, music was a part of Gulz's life from a very young age. From strains of Mohammed Rafi to Stevie Wonder, his musical influences were an eclectic mix - something that chimes with the kind of tunes he is now creating

lyrically and musically. "I began by sort of writing music that sounds like the music I like and have tried to retain that in some ways. I just try to weave certain themes of my life at the time into the stuff that I'm writing, be it relationships and breakups or just having some fun," he said

Currently based in Brighton and completing his second foundation year as a junior doctor in the National Health Service (NHS), Gulz plans to take some time off later this year to focus entirely on music for some time. Asked about the ongoing strikes by NHS junior doctors demanding better pay and working conditions, Dr Dhanoya says the band fully supports their medical colleagues in the industrial action.

"We always hope the next set of strikes will be the last one because junior doctors don't want to have to strike. But sadly there's no other way to be heard by the government. The working conditions and pay right now are really not acceptable. There's so much responsibility that doctors have, with people's lives at stake literally, and the working conditions and pay do not reflect that at all," he said, pointing out that in real terms all his colleagues are fighting for is an extra GBP 5 an hour.

Juggling their work shifts and rehearsals, the band is all set to perform at the Sunflower Lounge in Birmingham and then their tour is slotted for his home crowd in Newcastle followed by Manchester towards the end of next month. Beyond that, Gulz is open to bookings and asked if a tour to India may be in the offing, the doctor-musician sounds very excited at the prospect of playing a gig in the country he has so far only visited with family to spend time with cousins in Pun-

"After August, I'm out of contract, which sounds dramatic but it's actually a really good thing because it means that I've got a lot more flexibility in my time and work. So, I would love to go to India and perform, in case any promoters out there want to reach out," he said.

Meanwhile, the band – dubbed the doctors/rockers – have sold-out shows in the UK to look forward to with tickets selling out fast on their socials. (PTI)

## Violence rocks Imphal, claims one



IMPHAL, Feb 25: Series of violence including bomb blasts and burning and ransacking of offices of civil society organisations rocked Imphal on recently, and also claiming the life of a student in one of the blasts.

One of the blasts that killed a student and injured another one occurred inside the premises of the All Manipur Students' Union (AMSU) located inside the DM University campus in the heart of Imphal last night, around 10 pm.

The deceased has been identified as Oinam Kenegy (24) of Upokpi village in Bishnupur district who was staying at the boys' hostel inside DM University. He studied at DM College of Science.

He succumbed to splinter injuries at a private hospital in Imphal where he was rushed along with the other injured student identified as Salam Michael (24) of Keibul Lamiao of the same district. He is also a student of the

same college. The police rushed to the spot soon after the blast and took stock of the situation. They suspected perpetrators using a remote control device to trigger the blast. Around the same time, miscreants also hurled and exploded a hand grenade at the house of an in-

dividual in Imphal West district.

No sooner had the blast at the premises of the students' body took place, miscreants set on fire the office of the United Committee Manipur (UCM) where the ofof the Coordinating Committee on Manipur Integrity (COCOMI) also housed.

The miscreants also torched the offices of Macha Leima (a women based organisation) in Imphal's Palace Compound and a school runs by the organisation, Manipur Peace and Integrity (MAPI) Council at Wangkhei and Nongpok Leingak Apunba Nupi Lup at Wangkhei Keithel Ashangbi.

The offices of Coalitions Against Drugs and Alcohol (CADA) at Pureiromba Khongnangkhong, United People's Front (UPF) and National Identity Protection Committee (NIPCO) were also vandalized.

People who witnessed some of the incidents alleged that the miscreants armed with sophisticated weapons came on four-wheelers while committing the arsons and

#### Independent fact-finding team stopped by police on way to Sandeshkhali



KOLKATA, Feb 25: Six members of an independent fact-finding committee led by former Chief Justice of Patna High Court L Narasimha Reddy were stopped by police as they were proceeding to troubletorn Sandeshkhali area in West Bengal's North 24 Parganas district to probe alleged incidents of atrocities on women.

Citing Section 144 CrPC was in force in parts of Sandeshkhali and it would not be prudent to allow them access to the area even in groups of four-five, senior police officers stopped their convoy at the Bhojerhat area, which is around 52 km from the riverine area, on Basanti High-

Reddy, accompanied by former IPS officer Raj Pal Singh, former National Commission for Women member Charu Wali Khanna, advocates O P Vyas and Bhavna Bajaj, and senior journalist Sanjeev Nayak, sat on the wayside vowing to proceed to the area as high drama followed.

The six were detained by police and taken in a vehicle and later released, a police officer said.

'This is completely illegal. We have told the police personnel as law-abiding citizens we will not break rules. No curfew has been imposed in Sandeshkhali. So we can go in two groups. At least two of our women members should be allowed to visit the females who had bore the brunt of atrocities of musclemen enjoying political patronage and impunity from police action in all these days till the media unravelled the shocking truth", Reddy said.

Claiming they were given a copy of the section 144 order as they set off for the journey, he said "The administration cannot stop civil society members of the country to interact with victims of human rights violation. What they (administra-

tion) are scared to hide". He recalled the panel members had been stopped from visiting certain pockets of Howrah, signed by clashes between two groups during Ram Navami, halted at Howrah Bridge last year though others from the ruling party were allowed to go.

Another member of the group told reporters they would "peacefully sit on one side of the road", without hindering the movement of vehicles till being allowed to proceed.

Khanna said "What they have done is nothing but murder of democracy. They have illegally detained us." The group comprising former judge, bureaucrats and journalist was slated to visit Sandeshkhali on February 25 to also probe alleged incidents of Trinamool Congress leaders grabbing residents' land to convert into Bheris (fish farm).

They were scheduled to visit Majherpara, Natun para, Patra para and Naskarpara Ras temple under the jurisdic-

tion of Sandeshkhali police station limits. The committee is slated to submit a report to the constitutional authorities.

Asked about the police action against the fact-finding team, Sujit Basu, one of the two West Bengal ministers who visited Sandeshkhali for the second day on Sunday, told reporters, "I don't have any knowledge or information about that".

Meanwhile, ISF leader Ayesha Bibi was arrested from Sandeshkhali on Sunday for her alleged involvement in burning poultry farms of arrested local TMC leader Shibaprasad Hazra, an officer said.

A few days back a fact-finding team of BJP consisting of Union minister Annapurna Devi, Pratima Bhowmik, MP Sunita Duggal, Kavita Patidar, Sangeeta Yadav and Rajya Sabha member and former director general of police of Uttar Pradesh Brij Lal was stopped by police from entering Sandeshkhali.

On Saturday, a TMC delegation consisting of two West Bengal ministers Partha Bhowmik and Sujit Basu visited different parts of the riverine area, interacted with locals and promised their grievances will be addressed expeditiously.

# Absconding for 22 years, SIMI operative Hanif Sheikh arrested by Delhi Police

'Hanif became highly radicalised after coming in contact with SIMI activists'

NEW DELHI, Feb 25: A 47-yearold member of Students' Islamic Movement of India (SIMI) who also allegedly edited a magazine of the banned organisation besides indoctrinating many gullible youths has been arrested by the Delhi Police, officials said on Sunday.

According to the police, Hanif Sheikh was declared a proclaimed offender in 2002 and has been absconding for the last 22 years. He was nabbed on February 22 from Bhusawal in Jalgaon district in Maharashtra where he was a teacher in an Urdu school under a different identity, they said.

Deputy Commissioner of Police (Special Cell) Alok Kumar claimed that Hanif was the most notorious and wanted SIMI terrorist who had played pivotal roles in various activities of the proscribed organisation across the country.

Police said the SIMI magazine that Hanif Sheikh edited had his name printed as Haneef Hudai. This was the only lead available with the police, making it difficult to trace him, they said.

Unlawful Activities (Prevention) Act (UAPA) was registered against him in 2001 at New Friends Colony police station in the national capital. "A local court declared him proclaimed offender in 2002," Kumar said.

"A team from the Special Cell was tasked with collecting data, information and other digital footprints about the absconding SIMI cadre, sympathisers and sleeper cells across states. The team extensively visited and collected information from various parts of the country," he said.

The information collected by the team helped the Delhi police's special cell to zero in on Hanif. Following this, a raiding party was formed which laid a trap, the offi-

"Around 2.50 pm on February 22, a person travelling from Mohmadin Nagar to Khadka Road was identified as Hanif. As members of the team began to corner him, Hanif attempted to escape but was arrested after a scuffle," the DCP said.

He said Hanif became highly radicalised after coming in contact with SIMI activists and after joining the organisation, he started attending its weekly programmes and radicalising youths. Hanif was later appointed as the editor of the Urdu edition of the SIMI's magazine in 2001, the police officer

The DCP added that Hanif was one of the think tank members of Wahadat-e-Islam and played an important role in Maharashtra and other adjoining states.

"He was also involved in collecting money under the guise of donations to support and finance the agenda of SIMI as well as Wahadat-e-Islam.'

After fleeing Delhi in 2001, Hanif moved to Jalgaon and subsequently to Bhusawal in Maharashtra from where he was arrested, police said. (PTI)

They will have modern passenger amenities like roof plaza, beautiful landscaping, inter-modal connectivity, improved modern façade, kids play area, kiosks, food courts, etc. These stations will be redeveloped as environment friendly as well as Divyang friendly. The design of these station buildings will be inspired by local culture, heritage and architecture.

Further, the Prime Minister will inaugurate Gomti Nagar station in Uttar Pradesh which has been redeveloped at a total cost of around ₹ 385 crores. To cater to the increased future passenger footfall, this station has segregated arrival and departure facilities. It integrates both sides of the city. This centrally air-conditioned station has modern passenger amenities like Air Concourse, congestion free circulation, food courts and ample parking space in upper

and lower basement. Prime Minister will also lay the foundation stone, inaugurate and dedicate to the nation 1500 road over bridges and underpasses. These road over bridges and underpasses spread across 24 States and Union Territories, the total cost of these projects is around ₹21,520 crores. These projects will reduce congestion, enhance safety and connectivity, improve capacity, and efficiency

of rail travel. Under the jurisdiction of N. F. Railway, foundation stone for 23 railway stations under Amrit Bharat Station Scheme, 06 road under bridges and 02 road over bridges will be laid by the PM.

## 20 times increase in dog bite incidents in Bihar: Economic Survey

nessed an over 20 times increase in dog bite cases compared to the previous year, according to data released by the state's latest economic

The Bihar Economic Survey (2023-24) released by the state government has identified dog bite as the "most prevalent disease" in the state. According to the report, a total of 2,07,181 people suffered dog bites in the year 2022-23 whereas the total number was just 9,809 in the year 2021-22.

Analysis of the data revealed that on average, 600 people become victims of dog bites in Bihar every day. The second most prevalent disease in the state, as per the report, was malaria. The state witnessed 45,532 cases of malaria in 2022-23, the re-

The report, however, did not mention the number of rabies cases usually transmitted by a bite from an infected animal, including dogs.

According to a World Health Organisation report, "Dogs are the main source of human rabies deaths, contributing up to 99 per cent of all rabies transmissions to humans. The incubation period for rabies is typically 2-3 months but may vary from

factors such as the location of virus entry and the viral load."

As per the report, state capital Patna reported a total of 22,599 incidents of dog bites, highest in Bihar in the year 2022-23, followed by Nalanda (17,074), Gopalganj (15,253), Vaishali (13,110), West Champaran (11,291), East Champaran (9,975),

Madhubani (8,401), Araria (6,710). Nawada district reported 6,234 cases of dog bites followed by Sitamarhi (6,198), Jamui (5,851), Jehanabad (5,683), Bhojpur (5,323), Madhepura (5,169) and Darbhanga (5,023).

The districts that witnessed less than 2,000 reported dog bite incidents in 2022-23 include Kaimur (33), Aurangabad (435), Buxar (686), Muzaffarpur (1,258) and Khagaria (1,916). In January 2023, a stray dog al-

legedly went on a biting spree and attacked more than 80 people in Bihar's Arrah in Bhojpur district.

Commenting on Patna reporting the highest number of dog bite incidents, Animesh Kumar Parashar, Patna Municipal Commissioner (PMC), told PTI, "We are aware of the fact and will soon intensify our drive to check this menace as per the

existing norms. The PMC is also going to engage non-government organisations for the purpose. At the same time, we are also expecting cooperation from the public.

Echoing a similar view, Shekhar Anand, Municipal Commissioner, Nalanda, the district which reported the second highest number of dog bite incidents in Bihar, said, "We have our dedicated and trained team of municipal employees to curb his menace. We have already intensified the drive against the stray dogs in the

Expressing his concern over the stray dog menace in the state, Patnabased medical practitioner, Dr Manoj Kumar, said, "The survey report should have mentioned the number of rabies cases usually transmitted by a bite from an infected animal, including dog. How can dog bite incidents be termed as a disease? Rabies is a disease, it's a dangerous virus that causes brain inflammation. Animals can spread rabies to humans through bites and scratches.'

The incubation period for rabies may vary from one week to one year, he said, adding authorities concerned must take adequate measures to check incidents of dog bites in the

#### Focus on front liners

The people living in the fringe areas of the park have voluntarily accepted that the wild animals are their neighbours and their tolerance has ensured conservation success, Ghosh said. Asked about the threat of poaching in the park, she said the frontline forest guards have brought the situation under control.

Still, there was an incident of rhino poaching in January this year which is a matter of concern, the official said. "As long as there is international trade in body parts of wild animals, particularly the rhino horn, the threat of poaching will remain but a lot of emphasis has been laid on rhino conservation," she said.

Another matter of concern is the human-animal conflict, particularly with the wild buffaloes which have a considerable population of over 2500, and "there is a need for an effective strategy to establish and maintain the coexistence between humans and animals", she said.

The capacity of the reserve forest also needs to be addressed continuously with a growing number of tourists. The Kaziranga park is a "very intensely managed reserve forest and we need to develop and innovate strategies to tackle the increasing pressure," the director said. There is always a challenge to balance conservation and tourism by implementing the strategies, she added.

The maximum concentration of tourists is in the central and western ranges and it is difficult to convey to people that there are equally beautiful areas with diverse wildlife in the eastern, northern and westernmost ranges, the official said. "If we can stagger the tourist footfalls across all the ranges, we can reduce the pressure on just two and bring down the adverse impact. Besides, we are also keen to expand the buffer areas both from the wildlife and tourism point of view," she said.

With the expansion of the park and animals colonising these areas, the need for their protection arises and "we need more watch towers and camps in the extended area", she added. (PTI)

IIT-Madras researchers patent use of Indian spices to treat cancer; clinical trials to begin soon

NEW DELHI, Feb 25: Researchers at Indian Institute of Technology (IIT), Madras, have patented the use of Indian spices to treat cancer and the medicines are likely to be available in the market by 2028, according to officials. The Indian spice-derived

nanomedicines have shown anti-

cancer activity against lung, breast,

colon, cervical, oral and thyroid cell lines but were safe in normal cells, they said. The nanomedicines were also found to be safe in normal cells. The researchers are currently working on addressing the safety and cost issues which are major challenges in the existing cancer medicines. Animal studies have been successfully concluded re-

cently and clinical trials are being

planned with a target of making

the medicines available in the mar-

ket by 2027-28. "While the medical benefits of Indian spice oils have been known through the ages, their bioavailability has limited their application and use. Formulation as a nanoemulsion effectively overcomes this limitation. Stability of the nano-emulsion was a key consideration and it was optimised in our



laboratory," R Nagarajan, a professor at the Department of Chemical Engineering in IIT-Madras, told

"While mechanistic studies to identify the active ingredients and their modes of interaction with cancer cells are important and will continue in our labs, parallelly, we will attempt to translate the positive results in our animal studies to clinical trials in an expedited manner. We are looking at a two to three-year window for bringing the formulations to market," he added.

Animal studies have been carried out on the patented anti-cancer nano-formulations.

Animal validation to adjust the dosage (GLP phase) and efficacy studies (non-GLP phase) have been carried out through funding support from IIT Madras Distinguished Alumnus Awardee and Infosys Co-Founder Gopalakrishnan through Pratiksha Trust.

Nagarajan said there are several advantages of nano-oncology over conventional cancer treatment therapy. "The benefits include no toxic side-effects, reduced cost of treatment, abundance of Indian spice oils and leveraging of nanoscale for optimising effectiveness

and bio-availability," he said. M Joyce Nirmala, Chief Scientific Officer (Cancer Nanomedicine and Drug Design Laboratory), IIT Madras, said the patented Indian spice-based nano-formulations have proven effective in many common types of cancers through in-vitro studies.

"The drug dosage adjustment and efficacy are now under investigation through animal models. This will be followed by clinical trials. This cancer nanomedicine is being developed to reduce the cost and pain of cancer treatment and also to overcome the toxic side effects seen in the existing cancer treatments.'

India is the world's largest spice producer. Hence, large-scale production could be achieved at a low cost with our Indian spice-based cancer nanomedicine.

"Moreover, the formulations are developed for an oral route of administration to ease the treatment process. The spices chosen are edible, hence, biocompatibility is good, reducing toxic side effects.

"Also, plant and spice oils, in general, could influence multiple oncogenic signalling pathways, which have an added advantage in improving the quality of life of cancer patients," Nirmala said. (PTI)





# 'It makes more sense for IOC to give 2036 Olympics to India'



**NEW DELHI, Feb 25:** Sports Minister Anurag Thakur said on Sunday "it makes more sense for the IOC" to give India the hosting rights for the 2036 Olympic Games as the country is growing by leaps and bounds in every sphere including sports. Thakur, while speaking at the News9 Global Summit, said India's recent performance at mega international events, such as the 2020 Tokyo Olympics and the 2022 Hangzhou Asian Games, gives him hope that the country could become a top-10 sporting nation by 2036 and be in the top-5 by 2047. "We had the largest population to see the Olympic sports last time (in 2020 Tokyo) and this time, it makes more sense for the IOC to give 2036 Olympics to none other than Bharat, our India," said Thakur.

Prime Minister Narendra Modi has already expressed the country's desire to host the Olympics in 2036 during the IOC session in Mumbai last year, and when asked if India was ready to hold the mega event and which city could play host, Thakur said, "PM Modi made it very clear during the IOC session that India is very serious to host the 2036 Summer Olympics, and before that we want to host the 2030 Youth Olympics. And, I have a reason to say so. "If you look at India in the last 10 years, we have become the fifth-largest look at sector to sector, India is doing extremely well...economy-wise fifth largest, next five years, we are going to be the third largest.

"By 2036, the Indian economy cricket we didn't have enough

would be much larger, sports infrastructure is also getting better and better with each passing day. We have 1.4 billion population, out of which 65 per cent is below 35. That is 1/6th of the total population of the world lives in India, so what could be a bigger market (for Olympics).

"Then, the target I have set for 2036, India will be among the top-10 medal winning countries, and (by) 2047, among the top-5 to win medals," he said.

Thakur foresees Olympic disciplines too enjoying a huge following and compared it with economy in the world. If you where cricket was before the country won the World Cup for the first time and how massively things have changed now.

"If you look at 1983 (World Cup win), before that even in

World Cup, even the BCCI didn't have enough money to pay them (winning team play-

ers), or to celebrate in a big way. "But when they (BCCI) fought the case against Prasar Bharati and won the case, that is where they won the telecast rights and the game changed. Then money came into cricket. That is how the BCCI have done well with their professional working in the last so many years. "In the last 2-3 decades, we have seen so many cricketers doing well on the international stage. So, in cricket we had a lot of stars to look up to. And, today, in other sports too we have a lot of starts to look up to. I think the time has started when the country's mindset has changed," he added. He said the government's focus on creating sports infrastructure in the last 10 years and pumping in money gave him confidence.

"The sports budget has been increased three times in the last 10 years. We have spent 3,000 crores in creating 300 sports infrastructure. We have a lot of schemes for the benefit of players, so that they can perform better rather than worry about the facilities... how they can train, where to train, who will fund them. That is not their worry today, they all need to train hard and perform.

"That is why India has won 100-plus (107) medals in the Hangzhou Asian Games. At one time, a rickshaw-puller's or a tea seller's son used to worry how he will reach the top level in sports. After Khelo India and Target Olympics Podium Scheme (TOPS), boarding, lodging and training etc is taken care of and elite athletes get Rs six lakh

Having survived through an umpire's call, England skipper Ben Stokes was castled by Kuldeep with the ball staying low.

Bairstow looked in firm control in his 42ball 30 (3x4) but fell in the first ball after tea when Jadeja exploited the cracks on the pitch to turn it away and the batter drove it straight to short cover.

Kuldeep then dismissed Tom Hartley and Ollie Robinson in four balls, before Ashwin raced to his fifth wicket as stumper Dhruv Jurel took a brilliant reflex catch to oust James Anderson.

In the process, Ashwin also became the highest wicket-taker at home for India. He now has 354 wickets from 59 Tests at home, overtaking Anil Kumble's tally of 350 from 63 matches.

But Jurel's innings might just have ended India's search for a wicketkeeper batter in Tests in the absence of recuperating Rishabh

The 23-year-old from Agra was not only terrific with his glovesmanship but exhibited oodles of maturity during that determined fifty as India mounted an incredible fightback, trimming England's first-innings lead to a mere 46 runs.

After reaching his maiden fifty in 96 balls, the Rajasthan Royals' wicketkeeper-batsman shifted gears, taking on English spinners Shoaib Bashir and Tom Hartley.

Jurel hurried for a single off Hartley to bring up his fifty in an entertaining 40-run stand off just 75 balls for the ninth wicket

with Akash Deep (9).
But Hartley denied him a hundred with a

quicker delivery that stayed low. Young England off-spinner Bashir completed his maiden Test five-wicket haul, trapping Akash to finish with figures of 5 for 119 in only his second Test.

# Australia beats New Zealand by 27 runs in rain-shortened 3<sup>rd</sup> T20



AUCKLAND, Feb 25: Australia beat New Zealand by 27 runs under the Duckworth-Lewis system in the heavily rain-affected third T20 international Sunday to complete a 3-0 sweep the series and to harden its favoritism for the World Cup later this year.

## Assam athletes shine in 44th National England spinner Jack Leach to undergo knee surgery

LONDON, Feb 25: Left-arm spinner Jack Leach is set to undergo a knee surgery on Tuesday after being ruled out of the England's ongoing five-Test tour of

Leach, who came into the India series as England's most experienced spinner, took part in only the opening Test at Hyderabad which his side won by 28 runs. The 32-year-old spinner suffered an injury on the field which caused severe swelling, forcing him to leave the tour after missing the second Test and sub-

sequently returning home. "I'm going to have an operation to get the rest of the swelling out because it's not budging," Leach was quoted as saying by the BBC.

The report added that the knee injury trouble is the latest for Leach who suffers from Crohn's disease, having also missed last year's Ashes in England due to a stress fracture in his back. On the tour of New Zealand five years ago in 2019, Leach had also contracted sepsis.

"That, from a legislation point I would really

"From policy makers, there are two things that are important. For performance, there are too many people involved, there are the (sports) associations, government, private parties, managers; there's a whole of ecosystem.

"So, I think that needs to be streamlined. Because on one side is the corporate and marketing side, the entire ecosystem of very different things. But performance is a purely different

port staff and an ecosystem which builds performance. We need to keep that isolated from the rest of it. So, I would really say 'boss get this done for us (athletes)'," he added. "We have grown too fast as a country in sport, we are still pushing forward in big force and that is amazing. It has taken the 23-year-old from Agra around 18 months of tremendous hardwork to develop his game and he has been praised by none other than the great Sunil Gavaskar for his "MSD like game awareness".

Former Mumbai batter Zubin Bharucha, who is also Rajasthan Royals' High Performance Director, spoke about the process that Jurel followed and how he pushed his body to the limits while training at RR High Performance Academy in Talegaon before the start of the Test series against England.

"We have been preparing for the last 18 months taking the version (T20, ODI's or Test matches) out of the equation and the practice and merely focusing on the how and where runs can be scored," Bharucha, who helped Yashasvi Jaiswal in developing his power game for international cricket,

Bharucha, who played alongside Ravi Shastri, Sachin Tendulkar, Sanjay Manjrekar and Vinod Kambli for a very formidable Mumbai side in the early and mid 1990s gave an incredible piece of statistic.

"Just before the (debut) Test match he came to the RR HPC in Talegaon and batted for 140 overs in a day, it took over four hours on different spinning surfaces. It was



few that matched Jaiswal's long sessions," Bharucha revealed. A day in a Test match has 90 overs, which

is 540 balls plus extras, but 140 overs is effectively 840 deliveries in a single day. How was that even possible? Bharucha explained the process.

"All (bowlers and throwdown men) are standing there at the same time. And the sequence is one throws for the flick. Next one for the cut. Next one for the pull. Next one for the straight drive. We do this on multiple surfaces (spinning, grass, bounce, wet cement), with multiple types of balls (rubber, tennis, cricket) and multiple types of bats

"Within this also we have one bunch who do it with the hand and the next bunch who do it with the wanger (throwdown apparatus Roboarm). Behind them are the spinners, and behind them the fast bowlers.

"So, one round in the nets would comprise around 14 people throwing, wanging and bowling, as opposed to the traditional way, where you may have like three spinners and three fast bowlers (for example) bowling one round.

"That's how we got through 140 overs in a day's practice for Dhruv," he said. Bharucha explained the need for young batters to practice "sequencing" where they
