# Farmers take out tractor rallies in Punjab, Haryana, UP to protest against WTO

**CHANDIGARH/LUCKNOW, Feb 26:** Farmers took out tractor rallies at several places in Punjab, an umbrella body of several farm unions that spearheaded the 2020-21 farmers' stir, protesters Haryana and western Uttar Pradesh and burnt effigies, demanding the agriculture sector be taken out of the WTO agreement.

In Uttar Pradesh, the rallies led to disruption in traffic at many places and farmers also burnt effigies representing the World Trade Organisation (WTO), which is holding its 13th ministerial conference, a meeting of its highest decision-making body, in the UAE.

On the call of Samyukta Kisan Morcha (SKM),

parked their tractors along the highways at many places in Punjab and Haryana.

Effigies representing the WTO were also burnt at Khanauri and Shambhu points on Punjab's border with Haryana where thousands of farmers have been camping after their march to Delhi, led by the Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha (KMM), was halted by security forces. Farmer leaders claimed the WTO's objective was to end farm subsidies and

In western Uttar Pradesh, protests by farmers with tractors and by burning effigies representing WTO following a call given by the Bharatiya Kisan Union (BKU), disrupted vehicular traffic, which could resume only in the afternoon.

BKU national spokesperson Rakesh Tikait alleged the Union government was ignoring the genuine demands of farmers and condemned the 'atrocities" against farmers camping on the Punjab-Haryana border points to press the Centre for various demands, including a legal guarantee of minimum support price (MSP) for crops.
In UP's Muzaffarnagar district, a tractor march by farmers on a highway disrupted traffic in many places. They also blocked the left lane of the Delhi-Dehradun national highway.

The protesters parked their tractors at Bhuraheri under the Purkaji police station area, Bhangela under the Khatauli police station area, Mansoorpur intersection and Rampur Tiraha under the Chhapar police station area.

BKU workers and farmers parked their tractors on National Highway 58 in Meerut causing jam on the road. An effigy representing the WTO was also burnt there. During this, BKU district president Anurag Chaudhary had a heated exchange of words with officials.

The BKU workers held a meeting under the chairmanship of Madanpal Yadav during which the office bearers called for marching to Delhi on March 14. In Punjab's Hoshiarpur, farmers parked their tractors at several locations including the Jalandhar-Jammu National Highway. # Assam to bring UCC through 'front door': CM

ister Himanta Biswa Sarma on Monday asserted in the Assembly that his government will bring the Uniform Civil Code through the "front door", while maintaining that the UCC does not deal with traditional practices and rituals.

Replying to a discussion on 'Assam Healing (Prevention of Evil) Practices Bill, 2024', Sarma claimed that the government was only trying to curb practices conducted by individuals with malicious intent.

"The UCC is in Uttarakhand now. The UCC deals with four points – preventing underage marriage, banning polygamy, inheritance laws and registration of live-in relationships. The UCC does not deal with traditional rituals or practices," the CM said.

The Uttarakhand Assembly had on February 7 passed a Bill that seeks to impose uniform rules on marriage, divorce, inheritances and live-in relationships for all communities — except the Scheduled Tribes.

Sarma had said last month that Assam will be the third state after Uttarakhand and Gujarat to introduce a Bill seeking the UCC and it would exempt the tribal communities from the ambit of the law. "We will bring the UCC and we will bring it through the front door,' Sarma asserted, reacting to leader of opposition Debabrata Saikia's

UCC by the 'back door'. The Bill, which was later passed by a voice vote, seeks to eradicate non-scientific healing practices and making 'magical healing' by any person with sinister motive a

Sarma, referring to a ruckus created by opposition parties earlier in the House over the state Cabinet's decision to repeal the Assam Muslim Marriages and Divorces Registration Act, 1935, said he was saddened at the stance taken by them over such a sensitive issue as child marriage.

"Should the Congress, AIUDF support marriages of five-six yearolds? Can't we be unanimous in

boys above 21 years of age? Legislations which promote child marriage should be banned," the CM

The Act of 1935 contained provisions allowing marriage registration even if the bride and groom had not reached the legal ages of 18 and 21, as required by law.

On the opposition's objections to the 'Assam Healing (Prevention of Evil) Practices Bill, 2024', Sarma maintained that a similar law in the form of Centre's 'The Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954' was already in place.

"It was passed when the late Jawaharlal Nehru was the prime minister. We haven't taken Nehru's extremist view and banned everything like talisman, mantra, and kavach," he said. The CM claimed that the state government has refrained from implementing the Central Act as it will get in the way of traditional systems, especially prevalent among tribal communities of the state.

"The simple design of our bill is not to prevent anyone from their traditional practices, but we stop

# CM to be honoured with Assam's economy will be in shambles in 5 yrs if OPS restored: Himanta

GUWAHATI, Feb 26: Chief Minister Himanta Biswa Sarma on Monday said the state's economy will be in "shambles" if the government has to imlement the Old Pension Scheme (OPS) for its em-

Speaking in the assembly, he maintained that employees retiring after 30-35 years of service under the National Pension System (NPS) stand to gain, a notion that the opposition members refused to accept, and staged a walkout.

Replying to a question by independent MLA Akhil Gogoi, Sarma said as per data with the 'FinAssam' portal, there are 4,34,454 pensioners under the state government, excluding those under the Sixth Schedule Areas.

Of these, 2,58,456 are under the NPS and 1,75,998 are under OPS, he said.

The CM also said that 7,006 retired personnel are currently drawing pension under the NPS, which was implemented in the state from 2005.

"Since we implement the central government's pay scale here, we follow their policies with regards to pension. Those who have joined service at a younger age like 25 years, will get a good pension amount under the NPS

"But, the benefit cannot be same for some with, say, three years of service under NPS and someone with 30 years of service," Sarma said.



He said the Assam government has a pension bill

of about ₹ 1,700 crore per month at present. "If we assume that the current salary bill is ₹ 2,800-3,000 crore per month and pension bill is ₹ 1,700 crore, then under OPS, our pension bill will be more than the salary bill in five years. And, then our economy will be in shambles," Sarma said.

He said only a limited number of employees whose retirement is due soon under NPS could face. some financial setback, and the government is aware of it. "The central government has formed a committee to study whether to move forward with NPS or go back to the OPS and other related matters. We have to wait for (CONTD. ON PAGE-2)

## Won't allow child marriage till I am alive, says Himanta

GUWAHATI, Feb 26: Asserting that he will not allow child marriages in the state, Chief Minister of five-six years of age. If you Himanta Biswa Sarma on Monday alleged that opposition Congress and AIUDF were siding with a "draconian" law which purportedly legalised underage marriage.

Members of the Congress and AIUDF, protesting against a Cabinet decision to repeal the Assam Muslim Marriages and Divorces Registration Act, 1935, staged walkouts later.

The AIUDF had sought an adjournment motion to discuss the Cabinet decision, while the Congress maintained the original act could have been amended without repealing it altogether.

While Speaker Biswajit Daimary disallowed the adjournment motion, the chief minister also said that a discussion can be done when the repeal bill is listed in the proceedings.

As Sarma tried to explain why the repeal was needed, the two opposition parties created noisy scenes in the House leading a visibly agitated chief minister to assert that he will go ahead with banning child marriage.

"This old law allowed registration of marriages between children want to speak in favour of this draconian law, I will also say that till I am alive, I will not allow child marriage to happen in Assam," Sarma said, pointing to the opposition benches. "I won't allow you to carry out business with Muslim children," Sarma said, specifically targeting the AIUDF.

As the opposition parties continued to create a ruckus, the chief minister switched to speaking in Hindi, saying that he was doing so that his words can reach a wider section of people.

"I want the Congress, AIUDF to know that till Himanta Biswa Sarma is alive, I will not allow child marriages to take place," the CM said in a raised voice to assert his point.

Protesting against the Cabinet decision, the Congress walked out

of the House for 10 minutes. AIUDF legislators initially raised slogans and stormed into the Well of the House, sitting on the floor for over five minutes. They later walked out as the Speaker continued (CONTD. ON PAGE-2)

# UN member states meeting to plan how to tackle the world's environmental crises

NAIROBI, Feb 26: The world's top decision-making body on the environment is meeting in Kenya's capital on Monday to discuss how countries can work together to tackle environmental crises like climate change, pollution and loss of biodiversity.

The meeting in Nairobi is the sixth session of the United Nations Environment Assembly, and governments, civil society groups, scientists and the private sector are attending. "None of us live on an island.

We live on planet Earth, and we are all connected," Inger Andersen, executive director of the UN Environment Programme, which is leading the process, told The Associated Press ahead of the talks. The only way we can solve some of these problems is by talking to-

At the meeting, member states discuss a raft of draft resolutions



on a range of issues that the assembly adopts upon consensus. If a proposal is adopted, it sets the stage for countries to implement what's been agreed on.

In the last round of talks in 2022, also in Nairobi, governments adopted 14 resolutions, including to create a legally binding instrument to end plastic pollution globally. Andersen described it then as

the most significant environmental multilateral deal since the Paris Agreement to limit global warming. For this year's talks, countries have submitted 20 draft resolutions for discussion, including on how best to restore degraded lands, combat dust storms and reduce the environmental impact of metal and mineral mining

But with countries having differ-

ent priorities, it's often hard to get consensus on the draft resolutions.

However, Andersen said, there's generally "a forward movement" on all draft resolutions for this year's meeting, known as UNEA-6. With this meeting's focus on multilateralism, UNEP wants to build on past agreements it led between governments, such as the Minamata Convention to put controls on mercury and the Montreal Protocol to heal the hole in the ozone layer, Andersen said.

Bjorn Beeler, international coordinator for the International Pollutants Elimination Network, thinks there'll be slow progress on more complex issues such as financing around chemicals and waste.

Beeler also expects strong opposition on a draft resolution that wants to phase out the use of highly hazardous pesticides. The draft resolution, which was submitted by (CONTD. ON PAGE-2)

"NPCI has been advised by the RBI to examine the request of One97 Communication Ltd (OCL) to become a Third-Party Application Provider (TPAP) for UPI channel for continued UPI operation of the Paytm app, as per the norms," it said.



Meanwhile, an advisory committee, set up by One97 Communications after the Reserve Bank's action on its payments bank business, is at a stage of engagement with the company on matters related to the terms of reference for the panel.



# India seeks permanent solution to long-pending food stockpile issue at Abu Dhabi WTO meet

NEW DELHI, Feb 26: India on Monday called on WTO members to find a permanent solution to the long-pending public food stockpile issue, saving it is directly related to achieving the sustainable development goal of zero hunger by

Commerce and Industry Minister Piyush Goyal said that the World Trade Organisation (WTO) should not negotiate rules on nontrade-related subjects like climate change, gender, and labour and rather these should be addressed in respective intergovernmental organizations, "I re-emphasize that the development agenda would remain incomplete without a permasolution on public stockholding (PSH) for food security purposes which is directly related to achieving the Sustainable Development Goal of Zero Hunger by 2030, Goyal said.

This continues to be a longpending issue for the last few decades and despite having a clear mandate agreed by the members in the past, finding a permanent solution on PSH remains an unaccomplished agenda on which we

have to deliver in MC13. Trade ministers of 164 WTOmember countries are gathering in



Abu Dhabi for the 13th ministerial conference (MC13). The highest decision-making body started the four-day meet on February 26 in the UAE.

The PSH programme is a policy tool under which the government procures crops like rice and wheat from farmers at the minimum support price (MSP) and stores and distributes foodgrain to the poor.

Under the global trade norms, a WTO member country's food subsidy bill should not breach the limit of 10 per cent of the value of production based on the reference price of 1986-88.

India has been seeking amend-

ments to the formula for calculating the food subsidy cap.

As an interim measure, the WTO members at the Bali ministerial meeting in December 2013 had agreed to put in place a mechanism popularly called the Peace Clause and committed to negotiating an agreement for a permanent solution. Under the Peace Clause, WTO members agreed to refrain from challenging any breach of the prescribed ceiling by a developing nation at the dispute settlement forum of the WTO. This clause will be there till a permanent solution is found to the food stockpil-

They were also being dumped directly in flood

### **Trouble beckons Mayawati**

The Bahujan Samaj Party (BSP), once a formidable force in Indian politics, finds itself at a critical juncture as the 2024 Lok Sabha elections draw near. The recent exodus of MPs and senior leaders from the party signals a deep-seated turmoil within, posing a significant setback for its leader, Mayawati. The departure of prominent figures from the BSP reflects a growing disillusionment with Mayawati's leadership and the party's direction. While some attribute this trend to the uncertainty of securing BSP tickets in the upcoming elections, others point to broader issues of discontent and a lack of resonance with the party's vision. Mayawati, often regarded as a formidable figure in Indian politics, seems unfazed by the unfolding crisis. Mayawati's dismissal of the MPs' exodus as inconsequential further underscores the disconnect between the party leadership and ground realities. As the political landscape continues to evolve, it is essential for the party to adapt and rejuvenate its leadership if it hopes to remain a relevant player in Indian politics. The coming months will be crucial in determining the BSP's fate, and decisive action is needed to navigate these turbulent waters effectively. t a time when India is gearing up for national elections. Indonesia chose its next president. It merits mention not only because it was the world' largest single-day vote but it was an election which is a beacon of hope in a region plagued by autocrats and juntas.

The defence minister, Prabowo Subianto who exit polls suggest won comfortably, declared victory soon after voting ended though his rivals were yet to concede. His ascent to power is tinged with concerns that ripple through the very fabric of his country's democratic credentials. Subianto is scheduled to take over as the President in October this year.

Accusations of interference in the electoral process, arbitrary cancellation of Opposition rallies and intimidation of critics deepen democratic fissures. Incidentally, such gaps have opened wider in the recent years.

If Subianto's policies are stated to be one of continuation of that of his predecessor Joko Widodo, there is cause for concern. Apart from ambitious plans to relocate the Capital of Jakarta, there is a worrying continuity of crackdown on civil society and press freedom. Such apprehensions are not unfounded given Subianto's past. It includes kidnapping of democracy activists in the 1990s and ordering massacres in East Timor in the 1980s.

More skeletons tumble out of Subianto's closet. It is troubling that he is the only candidate who did not reply to a questionnaire on human rights issues. Subjanto cannot wish away the fact that the human rights issue is crucial to voters as well as the country's democratic health. But then he will be having time and authority

is accelerating its effort to recruit up to 50,000 personnel per year to replenish its armed forces under the reinforced Conscription Law.

Several media outlets have recently reported in independent and pro-resistance Myanmar media on the forcible recruitment of young men in urban areas.

Military junta Chief Min Aung Hlaing activated, for the first time in a decade, a conscription law amid heavy regime casualties and desertions.

Following the nouncement, the regime formed a central committee led by the Defence Minister to conscript over-18s into military service. Those who fail to comply face three to five years in prison.

The committee announced the formation of branches in each state and region to implement the law, led by the chief minister with the deputy regional military commander as the vicechair.

The conscription branches will be established in rural areas and townships. The recruitment process will start in April, regime spokesman Major General Zaw Min Tun said. The spokesman said around 6 million men and 7 million women were eligible for compulsory military service, according to the 2019 census.

He said 5,000 people will be called up each

Junta forcefully recruiting Rohingya to fight rebels with around 50,000 recruited per year. The conscription is not intended for only one, two, three, or four years and will be eligible for service for two

> The junta also activated a Reserve Forces Law, allowing it to send veterans back to the front line. Under the law, all former military personnel must serve in the reserve forces for five years starting from the day they resigned

or retired. Conscription has sparked fear and anger among eligible citizens who have been called on to defend the junta that has brutalised them for three years.

It has also been criticised for legalising the junta's practice of rounding up civilians for use as porters or human shields.

Desertions and defections plague Myanmar troops

The military government's forces have been stretched thin by the recent upsurge in resistance activity. They were already believed to be depleted by casualties, desertions, and defections, though there are no reliable numbers regarding their scale.

The army faces two enemies: the pro-democracy forces formed after the army takeover and bettertrained and equipped ethnic minority armed groups that have been battling for greater autonomy for

Sittwe, the state capital of Rakhine State, has 13 IDP camps for about 100,000 Rohingya people who were displaced by ethnic and religious vio-

At least 400 Rohingya men have already been forcibly recruited from villages and IDP camps after community Rohingya leaders and administrators were pressured to compile lists of at least 50 men for each small IDP village and at least 100 for each IDP camp in three Rakhine townships - Buthidaung, Maungdaw, and Sittwe.

The junta is offering freedom of movement to Rohingya Muslims restricted to IDP camps as part of a bid to entice them into military service amid the nationwide rollout of a conscription law.

Junta forces have told Rohingya men that if they serve in the military, each one will receive a sack of rice, a citizenship identity card, and a monthly salary of 150,000 kyats (US\$ 41), Rohingya residents of Rakhine State and activists stated.

Since taking the census on Monday, junta officers have repeatedly visited the camp, trying to persuade Rohingya residents to serve in the military with an offer of free movement within Kyaukphyu township, said another camp

However, the conscription law only applies to Myanmar citizens, but the citizenship of Rohingya people has been scrapped after a draconian Citizenship Law of 1982 requires individuals to prove that their ancestors lived in Myanmar before 1823 and

hingya Muslims as one of the nation's ethnic groups or list their language as a

national language. Despite the compulsory military training schedule to begin in April, junta troops arrested at least 100 men from four villages in Buthidaung Township on 18 and 19 February, and they were transferred to a nearby military base for basic military training.

Nay San Lwin, cofounder of the Free Rohingya Coalition, describes that two weeks of training would make them vulnerable either to be captured or killed on the battlefront by the battle-hardened Arakan Army (AA) rebels fighting the military junta for more than a decade. Lwin said the junta's military will use the Rohingya foot soldiers as human shields and porters.

Rohingya to defend IDP

villages Junta troops informed Rohingya leaders that the AA had established armed fortified camps near the Rohingya villages and that residents would have to undergo military training to defend their villages.

The junta's troops, who are fighting the AA, know the terrain of Rakhine State better than the AA does and have public sup-

The capital of Rakhine State, Sittwe, is besieged government troops. Civil administration officials and their families have been evacuated to safe places by commercial flights, while other officials have been shifted by Naval vessels.

Rights campaigners fear that drafting Rohingya into military service could stoke ethnic tensions in Rakhine state, while legal experts argue that the drive is unlawful, given that Myanmar has refused to recognize the Rohingya as one of the country's ethnic groups and denied them citizenship for decades.

An estimated 1.2 million ethnic Rohingya refugees have been languishing in squalid camps Cox's Bangladesh, since 2017 after fleeing the genocide committed by Myanmar military forces

Another 630,000 living within Rakhine State are designated stateless by the United Nations, including those who languish in camps for internally displaced persons (IDPs) and are restricted from moving freely within Rakhine state. # Greece finds potential in collaborating with India

he Raisina Dialogue's ninth edition, serving as a key Indian forum for discussions on geopolitical and geoeconomic matters, featured Greek Prime Minister Kyriakos Mitsotakis as the distinguished chief guest during this year's proceedings. The event aligned with his official state visit on February

During his opening address, Prime Minister Narendra Modi noted that, apart from his visit to Greece last year, a substantial 14-year gap had transpired without significant high-level exchanges between the two nations. Diplomatic engagements are naturally influenced by domestic political dynamics and the global environment. The most recent comprehensive bilateral interaction dates back to the 1980s

Following Ronald Reagan's election as the President of the United States in 1980, the Cold War entered a phase marked by heightened tensions between superpowers. Reagan's assertive rhetoric, coupled with increased defense expenditures and the Strategic Defence Initiative, fueled global apprehensions about a potential nuclear catastrophe. Meanwhile, in India, Indira Gandhi and later her son Rajiv held the prime ministership. In Greece, the collapse of the military dictatorship in 1974 paved the way for Andreas Papandreou's return from exile to establish the Panhel-

lenic Socialist Movement. Perceived as radical by Western nations. Papandreou advocated for a "third way," distinct from the perceived Eastern and Western blocs, aligning with the traditional post-Independence Indian foreign policy approach that evolved into the Non-Aligned Movement (NAM). He called for the removal of US bases from Greek soil, NATO withdrawal, and rejection of full European Union Membership. Upon assuming the role of prime minister in 1981 and serving three terms (1981-89 & 1993-96), Papandreou tempered his earlier extreme views to avoid significant disruption to the European alliance sys-

Hence, it came as no surprise when, in May 1984, India and Greece collaborated in a six-nation effort advocating nuclear disarmament to counter what they deemed as "a rush towards global suicide." Andreas Papandreou made three visits to India: first in November 1984 for Mrs. Gandhi's funeral, then in January 1985 for the 6-nation summit on nuclear disarmament, and finally in January 1986 as the chief guest at Republic Day. Additionally, President Zail Singh undertook a visit to Greece in October 1986. However, as global priorities shifted with the conclusion of the Cold War and the dissolution of the Soviet Union in 1991, the relationship between India and Greece gradually receded to the background.

In the 21st century, while the Indian economy experienced robust growth, Greece grappled with a severe economic crisis that reached its zenith in 2015. A Reuters report highlighted that from 2008 to 2013, Greeks witnessed a staggering 40% decline in wealth as unemployment and economic hardships proliferated. Disposable household incomes plummeted below the levels observed in 2003 necessitating three massive bailouts amounting to \$280 billion for Greece. Amidst this turmoil, Prime Minister Matsotakis, leading the New Democracy party, entered the scene in 2016 and eventually assumed the role of prime minister in 2019.

Subsequently, Prime Minister Matsotakis has authored an impressive narrative of economic revitalization for Greece. Steering the nation from a "junk" rating, he successfully elevated Greece to an investment-grade credit rating. The electorate reciprocated with a resounding re-election in 2023, acknowledging his accomplishments.

Matsotakis' keen interest in India is apparent as he expands his focus beyond the European context. During a joint press conference with Prime Minister Narendra Modi, he expressed optimism about the significant potential inherent in the emerging Indo-Greek "strategic partnership." Notably, he advocated for collaboration, particularly in the realm of infrastructure development.

During the recent discussions, Prime Minister Modi highlighted a commitment to doubling trade by 2030, while the Greek leader specifically emphasized India's keen interest in the India-Middle East-Economic Corridor (IMEC). This ambitious project was unveiled with great enthusiasm during the G-20 summit hosted by India in September 2023. However, the attack by Hamas on Israel on October 7 and the subsequent intense Israeli response have temporarily halted further progress on its implementation. Despite the UAE maintaining its commitment to the Abraham Accords and normalizing relations with Israel,

Saudi Arabia has publicly linked any agreement with Israel to a clear path toward establishing a Palestinian state alongside Israel. Considering that the Adani group has already invested \$1.2 billion to acquire control of Haifa port in Israel, it is conceivable that they are ex-

ploring options for a corresponding port in Greece to serve as IMEC's European

Adding complexity to the quest for a Greek port under Indian control is the prior transfer of Greece's primary port, Piraeus, to China amid the Greek financial crisis. The operationalization of IMEC hinges on the normalization of the Gaza crisis and the subsequent attainment of a two-state solution to the longstanding 75year dispute. This journey is anticipated to encounter numerous obstacles before Saudi Arabia can openly acknowledge engaging in infrastructure partnerships with Israel. Despite the challenges, there are indications that the UAE has initiated a practice of permitting trucks to transport goods to Israel overland through Saudi Arabia and Jordan, suggesting a potential shift in regional dynamics.

The resurgence of a closer alliance between India and Greece is indeed a positive development. Similar to the discord between India and Pakistan over divided Kashmir, Greece and Turkey grapple with a comparable dissonance concerning divided Cyprus. Nurturing a robust association with Greece enhances India's influence with Turkey, a nation that Pakistan views as a valuable Islamic ally, occasionally leveraging it to address developments in Jammu and Kashmir.

Furthermore, the diverse landscape of Greece, encompassing both the mainland and islands, presents an enticing tourism destination for India's increasingly affluent and mobile middle class. In honoring Alexander's legacy of bridging the gap between Europe and Asia, the ongoing renewal of this connection remains crucial. (The writer can be reached at dipaknewslive@gmail.com)



nomic activity. Markets work efficiently for ordinary goods like online taxi services and even in case of 'bads' such as tobacco, logical solutions are provided by the market. However, the 'good' in question is education and the agents providing it are the coaching centres. Without getting into the philosophical debate on what is education, we look at this fairly complex good from an economist's perspective and question the efficiency of coaching classes and how much wellbeing they actually produce in the society.

Education in itself, especially at the school level, is declared to be a public good which is non-excludable and non-rival. This means that nobody should be excluded from its consumption and consumption by one should not rival the other's

With private schools occupying 31.5% of the total schools, 46.7% in total enrolments and 49.3% of total teachers in India, the 'public good' nature of education becomes blurred.

of coaching centres have mushroomed all over the country to meet an unprecedented demand. The 75th round of the National Sample Survey (NSS 2017) states that 27.2% of students in rural areas and 38.3% of urban students take private tuitions at the secondary level. The 2022 ASER report states that the proportion of rural Indian students between grades 1 to 8 taking private tuition classes increased from 26.4% in 2018

The genesis of a massive and progressively increasing demand for private coaching is the substandard state of government school education. Nearly 35% of both urban and rural students report this as the reason to opt for private schooling, according to

The share of government schooling at all levels of schooling is higher in rural areas, at 68% at the secondary and higher secondary level; than in urban areas where the same is at 38.8% explaining the increasing demand for private coaching.

A thriving coaching culture in urban and rural areas has emerged in a country that's obsessed with entrance exams. Appearing as 'ancillary units' of private schools, coaching centres have witnessed a phenomenal growth with some becoming unicorns and case studies at Harvard Business School. The rising feeling of irrelevance of schools - since they do not provide the code to crack entrance exams – has made parents and students flock to private coaching centres to fill

So far what sounds like a simple story of effective demand in economics takes a twist because of the original nature of education as a public good that we began with. Public goods create 'externalities' or spillover effects that affect the society positively apart from benefitting the consumers themselves.

Education, justifiably, has

free play and finally increasing mental health issues among teenagers leading to growing suicide numbers are some of these problems.

Rajasthan's Kota, the hub of private coaching, is infamous in reporting 20-25 cases of young students dying by suicide in fear of not fulfilling their parents' aspirations.

Students accounted for 8% of the total deaths by suicide in 2022 according to the National Crime Records Bureau. Of these, most of the students were in higher secondary school. This loss of potential human capital plus loss of productivity among related family members due to acute distress appear intangible although real.

Professor Tilak, an eminent researcher in the field of education talks of three 'fads' in education: Private education is most efficient, Englishmedium education is very important and pre-primary education is essential. Tilak argues that all these 'fads' are mere views of people that lack research evidence.

That private coaching is a sure road to success can be annexed to the 'fads' list.

An IIT-Madras study revealed that 50% of students who got admission into IITs did not go to any coaching. The recent case of a missing teenager in Bangalore, who feared being reprimanded by parents for his poor performance in a coaching centre, created furore in society, prompting the government to introduce more regulation on private coaching.

Certainly government intervention is needed to correct 'market failures'; in our case the failure of achieving welfare objectives intended through education. However, all regulation will be ineffective till the most important stakeholders, the parents, are fully convinced. Between the risk taken by

parents while perceiving education as a capital good and the joy and satisfaction experienced by students who are consuming it, there are externalities, positive and negative. There is a need to recognize and educate that education is a good where the impact is on parents (through fees), incidence in on students (through their schooling experience) and the effects are on the society (that could be positive or negative). Well-informed choices of parents, in clear recognition of their children's interests and abilities will alone bring about the desired outcomes benefitting individually and collectively. # Despite working so hard, why does free time remain elusive?

There have been massive gains in productivity over the past century. So why are people still working

so hard for so long? Output per worker increased by almost 300% between 1950 and 2018 in the US. The standard American workweek, meanwhile, has remained unchanged, at about

This paradox is especially notable in the US, where the average work year is 1,767 hours compared with 1,354 in Germany, a difference largely due to Americans' lack of vacation time.

Some might argue that Americans are just more hardworking. But shouldn't more productive work be rewarded with more time free from work? This is the central theme of my new book, Free Time: The History of an Elusive Ideal.

#### Keynes misses the mark

Many economists see the status quo mostly as a choice: People would simply rather have more money. So they prioritise work over free time. However, in the past, many economists assumed that people's need for more stuff would eventually be met. At that point, they would choose more free time.

In fact, one of the most famous economists of the 20th century, John Maynard Keynes, confidently predicted in 1930 that within a century, the normal workweek would decrease to 15 hours. Yet Americans in their prime working age are still on the job 41.7 hours per week. Why was Keynes wrong?

Obviously, people's needs or wants were not fully met. In the first half of the 20th century, advertising shifted in ways that emphasised emotions over utility, making consumers feel like they needed to buy more stuff; planned obsolescence shortened how long products remained functional or fashionable, spurring more frequent purchases; and new, exciting - but costly goods and services kept consumerism churning.

So workers continued to labour for long hours to earn enough money to spend.

Furthermore, as wages rose, the opportunity cost of time spent away from work also grew. This made more free time less economically appealing. In a consumptionsaturated society, time spent neither producing nor consuming goods increasingly appeared as wasted time. Interest in slower, cheaper activities – reading a book, meeting a friend to catch up over coffee started to seem less important than buying a pickup truck or spending an hour at the casino, pursuits that demand disposable income. Forced labour

It's still important to consider whether there's even any choice to

Almost everyone who works 40 hours a week or more does so because they have to. There are bills to pay, health insurance coverage to maintain and retirement to squirrel away money for. Some jobs are more precarious than others, and many workers even forego earned vacation time for fear of losing promotions.

This hardly makes for a free

But the 40-hour week isn't the result of a personal calculation of costs and benefits. Rather, it's the result of a hard-fought political battle that culminated in the Fair Labor Standards Act of 1938, which established the standard 40hour workweek, along with a minimum wage.

Pressed by a labour movement that was far more powerful than today's, the government implemented a range of progressive economic policies during the 1930s to help the nation emerge from the Great Depression.

Many government officials viewed setting a standard workweek as a way to curtail exploitation and unfair competition among employers, who would otherwise be motivated to push their employees to work for as long as possible.

progressive reduction of hours worked, as Keynes had envisioned.

In fact, it was hardly a radical Labour leaders had initially pro-

posed a 30-hour week, which government officials resoundingly rejected. Even New Deal liberals saw a shortening of working hours as a potential threat to economic growth. So the 40-hour week ended up as the compromise, and the standard hasn't been updated since. For most Americans, this was an

acceptable trade-off. They might be working long hours, but they could afford television sets, cars and homes in the suburbs. Many families could live on the wages of the full-time work of the father, making the 40-hour week seem reasonable, since the mother had time to care for the family and home.

But this consensus has long since been undermined. Since the 1970s, inflation-adjusted wages haven't risen with economic growth. In many households that include married or partnered couples, a single wage earner has been replaced by two earners, both of whom find themselves working at least 40 (Courtesy: Scroll.in)

hours per week.

It's almost as if the 40-hour week has been replaced by an 80-hour week – at least in terms of hours worked per household.

Who has time to raise kids? Who can afford them? It's no wonder the birth rate has declined.

Economic growth, well-being For decades, the amount of work we do has been talked about as "just the way things are" - an inevitability, almost. It doesn't seem possible for society to take a different tack and, like flipping a switch,

To me, this resignation points to a need to reconsider the social contracts of the past. Most Americans will not abandon their work ethic and their insistence that most people work. Fair enough.

Many people prefer working over having vast stores of free time, and that's OK. And there's still immense value in work that doesn't produce a paycheck - caregiving and volunteering, for example.

But reducing the standard workweek, perhaps by transitioning to a four-day week, could ease stress for overworked families.

These changes require political action, not just individuals making the personal choice to arrive at a

> life balance. And yet a national reduction in the standard workweek seems almost impossible. Congress pass legisla-

tion for paid family leave or guaranteed vacation time.

It doesn't help that elected leaders continue to insist that wellbeing be measured mostly by economic growth, and when the US media breathlessly reports quarterly economic growth data, with increases deemed "good" and decreases deemed "bad."

Why shouldn't free time and its benefits be included in the equation? Why aren't figures on the social costs of unlimited growth publicised? Does it even matter that the Dow Jones Industrial Average has doubled in less than a decade when economic security is so fragile and so many people are overstressed?

The idea that stratospheric increases in productivity can allow for more time for life is not simply a romantic or sentimental idea. Keynes viewed it as entirely reasonable. Opportunities like the one that led to the 40-hour workweek in the 1930s rarely appear. But some sort of paradigm shift is urgently needed. Something has to give.

# Medical myths: How much sleep do we need?

lthough we all know sleep is vital to maintain good health, there are still many unanswered questions. And, over the millennia, a variety of myths and halftruths have developed and

This feature is the second and final part of our series that tackles sleep-related myths. Find the first part here.

This time, we focus on myths that surround how much sleep the average person needs. We also discuss naps, the effects of sleeping too little or too long, and sleep in the animal king-

1. Everyone needs 8 hours As with many aspects of human biology, there is no onesize-fits-all approach to sleep. Overall, research suggests that for healthy young adults and adults with normal sleep, 7-9

hours is an appropriate amount. The story gets a little more complicated, though. The amount of sleep we need each

- day varies throughout our lives: newborns need 14–17 hours • infants need 12–15 hours • toddlers need 11–14 hours
- preschoolers need 10-13 hours school-aged children need
- 9-11 hours • teenagers need 8–10 hours
- adults need 7–9 hours • older adults need 7–8 hours

#### You can train your body to need less sleep

There is a widely shared rumor that you can train your body to need fewer than 7–9 hours' sleep. Sadly, this is a

According to experts, it is rare for anyone to need fewer than 6 hours' sleep to function. Although some people might claim to feel fine with limited in some countries. Naturally, sleep, scientists think it is more likely that they are used to the negative effects of reduced

People who sleep for 6 hours or fewer each night become accustomed to the effects of sleep deprivation, but this does not mean that their body needs any less sleep. Cynthia LaJambe, a sleep expert at the Pennsylvania Transportation Institute in Wingate, explains:

"Some people think they are adapting to being awake more, but are actually performing at a lower level. They don't realize it because the functional decline happens so gradually."

"In the end, there is no denying the effects of sleep deprivation. And training the body to sleep less is not a viable op-Cynthia LaJambe.

However, it is worth noting that some rare individuals do seem to function fine with fewer than 6.5 hours' sleep each night. There is evidence that this might be due to a rare genetic mutation, so it is probably not something that someone can train themselves to achieve.

2. Daytime naps are unhealthy

Generally, experts recommend people avoid naps to ensure a better night's sleep. However, if someone has missed out on sleep during previous nights, a tactical nap can help repay some of the accrued

Around 20 minutes is a good nap length. This gives the body ample time to recharge. People who sleep much longer than this could mean they descend into a deep sleep, and once

awake, they feel groggy. Daytime napping is relatively common in the United States. but taking a "siesta" is the norm our bodies tend to dip in energy during the early afternoon, so perhaps napping around that time is more natural than avoid-

ing sleep until nighttime. After all, the vast majority of mammals are polyphasic sleepers, which means they sleep for short periods throughout the

In a large review of the effects of napping, the authors explain afternoon naps in people who are not sleep deprived can lead to "subjective and behavioral improvements" and improvements in "mood and subjective levels of sleepiness and fatigue." They found people who nap experience improved performance in tasks, such as "addition, logical reasoning, reaction time, and sym-

bol recognition. Not all naps are equal, however. There is a great deal of variation, such as the time of day, duration, and frequency of

naps. One author explains: "Epidemiological studies suggest a decrease in the risk of cardiovascular and cognitive dysfunction by the practice of taking short naps several times a week."

The author also acknowledges that much more research is needed to understand how factors associated with napping influence health outcomes. Medical News Today recently examined the relationship between napping and cardiovascular disease in a Special Feature.

It is also important to note if an individual experiences severe tiredness during the day, this might be a sign of a sleep disorder, such as sleep apnea. Scientists will need to con-

myths and mysteries to bed. 3. All animals sleep

Because humans sleep, and our companion animals appear to sleep, many people assume all animals do the same. This is not true. The authors of a paper entitled "Do all animals sleep?" explain:

'Some animals never exhibit a state that meets the behavioral definition of sleep. Others suspend or greatly reduce 'sleep' behavior for many weeks during the postpartum period or during seasonal migrations without any consequent 'sleep debt.

They also explain that some marine animals, reptiles, fish, and insects do not appear to enter REM sleep.

Because sleep is not simply a lack of consciousness, but a rhythmic cycle of distinct neural patterns, it is a challenge to distinguish whether an animal sleeps or takes a rest.

"[F]ewer than 50 of the nearly 60,000 vertebrate species have been tested for all of the criteria that define sleep," the authors explain. "Of those, some do not meet the criteria for sleep at any time of their lives, and others appear able to greatly reduce or go without sleep for long periods of time." 4. More sleep is always bet-

Although many people struggle to get the amount of sleep they need to feel refreshed, some regularly sleep longer than their body needs. One might think this could endow these individuals with super-

powers. However, researchers identify a link between longer sleep durations and poorer health. For instance, one study, which followed 276 adults for 6 years, concluded

"The risk of developing obesity was elevated for short and long duration sleepers, compared to average-duration sleepers, with 27% and 21% in-

creases in risk, respectively.' This finding held even when the scientists controlled the analysis for age, sex, and baseline body mass index. Sleep duration might also impact mortality, according to some researchers.

A meta-analysis, which appears in the journal Sleep, concludes "Both short and long duration of sleep are significant predictors of death in prospective population studies.

5. Sleep deprivation can be lethal

There is no record of anyone dying from sleep deprivation. In theory, it may be possible, but as far as scientists can ascertain, it is improbable.

It is understandable why this myth may have taken root. though. Sleep deprivation, as many people can attest, can feel horrendous. However, the case of Randy Gardner demonstrates that extreme sleep deprivation is not fatal.

In 1965, when Gardner was just 16, he was part of a sleep deprivation experiment. In total, he stayed awake for 11 days and 24 minutes, which equates to 264.4 hours. During this time, he was

monitored closely by fellow students and sleep scientists. As the days rolled on, sleep deprivation symptoms worsened, but he survived. So why has this myth persisted?

The belief that sleep deprivation can kill might have its roots in a study from the 1980s. Rechtschaffen and colleagues found if they deprived rats of sleep with a particular experimental method, they would die after 2-3 weeks.

In their experiments, the researchers placed rats on a disc suspended above water. They continuously measured their brain activity. Whenever the animal fell asleep, the disc would automatically move, and the rat would need to act to avoid falling in the water.

Despite the fatalities in Rechtschaffen's experiments, later research showed this is not the norm. Rats deprived of sleep using different methods do not die. Also, other researchers who used the disc method on pigeons found it was not fatal for these creatures.

Sleep deprivation is not painless for humans, though. Back in 1965. Gardner's parents were worried about their son. They asked Lieutenant Commander John J. Ross from the U.S. Navy Medical Neuropsychiatric Research Unit in San Diego to observe him. He describes a steady deterioration in

For instance, by day 2, Gardner found it more difficult to focus his eyes. By day 4, he struggled to concentrate and became irritable and uncooperative. On day 4, he also reported his first hallucination and delusion of grandeur.

On day 6, Gardner's speech became slower, and by day 7, he was slurring as his memory worsened. Paranoia kicked in during day 10, and on day 11, his facial expression and tone of voice became expressionless. Both his attention and memory span were significantly diminished.

However, he did not die and apparently, did not experience any long-term health issues.

Another reason why the myth that sleep deprivation can be fatal persists might be due to a

condition called fatal familial insomnia. People with this rare genetic disorder become unable to sleep. However, when individuals with this disease die, it is due to the accompanying neurodegeneration rather than lack of sleep.

Although sleep deprivation will probably not kill you directly, it is worth adding a note of caution: being overtired does increase the risk of accidents. According to the National Highway Traffic Safety Administration, "Drowsy driving kills it claimed 795 lives in

Similarly, a review published in 2013 concludes, "[a]pproximately 13% of work injuries could be attributed to sleep problems." So, although sleep deprivation is not deadly in a direct sense, it can have fatal consequences.

Additionally, if we consistently deprive our bodies of sleep for months or years, it increases the risk of developing several conditions, including cardiovascular disease, hypertension, obesity, type 2 diabetes, and some forms of cancer

The takehome

Overall, we should try and aim for 7-9 hours' sleep every night. It sounds simple, but in our neon-lit, bustling, and noisy lives, it is more challenging than we might like. All we can do is keep making an effort to give sleep the space that it

# Netanyahu says a cease-fire deal would only delay 'somewhat' an Israeli military offensive in Rafah

itary offensive in Gaza's southernmost city of Rafah could be "delayed somewhat" if a deal is reached for a weekslong cease-fire between Israel and Hamas, Prime Minister Benjamin Netanyahu said on Sunday, and claimed that total victory in the territory would come within weeks once the offensive

Netanyahu confirmed to CBS that a deal is in the works, with no details. Talks resumed on Sunday in Oatar at the specialist level, Egypt's state-run Al Qahera TV reported, citing an Egyptian official as saying discussions would follow in Cairo with the aim of achieving the cease-fire and release of dozens of hostages held in Gaza as well as Palestinians imprisoned by Israel.

Meanwhile, Israel is nearing the approval of plans to expand its offensive against the Hamas militant group to Rafah on the Gaza-Egypt border, where more than half the besieged territory's population of 2.3 million have sought refuge. Humanitarian groups warn of a catastrophe. Rafah is Gaza's main entry point for aid. The U.S. and other allies say Israel must avoid harming civilians. Netanyahu has said he will convene the Cabinet this week to approve operational plans that

"Once we begin the Rafah operation, the intense phase of the fighting is weeks away from completion. Not months," Ne-

tanyahu told CBS. ' "If we don't have a deal, we'll do it anyway." He said four of the six remaining Hamas battalions are concentrated in Rafah.

U.S. national security adviser Jake Sullivan told NBC that President Joe Biden hadn't been briefed on the Rafah plan. "We believe that this operation should not go forward until or unless we see (a plan to protect civilians)," Sullivan said.

Early on Monday, Netanyahu's office said the army had presented to the War Cabinet its "operational plan" for Rafah as well as plans to evacuate civilians from the battle zones. It gave no further details.

His office also said the War Cabinet had approved a plan to deliver humanitarian aid safely into Gaza. United Nations agencies and aid groups say the hostilities, the Israeli military's refusal to facilitate deliveries and the breakdown of order inside Gaza make it increasingly difficult to get vital aid to much of the coastal enclave. In some chaotic scenes, crowds of desperate Palestinians have surrounded delivery trucks and stolen the supplies include the evacuation of civilians off them. Heavy fighting continued



in parts of northern Gaza, the first target of the offensive, where the destruction is staggering.

"We're trapped, unable to move because of the heavy bombardment," said Gaza City resident Ayman Abu Awad.

He said that starving residents have been forced to eat animal fodder and search for food in demolished buildings. In nearby Jabaliya, market vendor Um Ayad showed off a leafy weed that people pick from the harsh, dry soil and eat.

"We have to feed the children. They keep screaming they want food. We cannot find food. We don't know what to do," she said. Philippe Lazzarini, commissioner general of the U.N. agency for Palestinians, said it has not been able to deliver food to northern Gaza since Jan. 23, adding on X, formerly Twitter, that "our calls to send food aid have been denied." Israel said that 245 trucks of aid entered Gaza on Sunday — less than half the amount that entered daily before the war.

A senior official from Egypt, which along with Qatar is a mediator between Israel and Hamas, has said the draft cease-fire deal includes the release of up to 40 women and older hostages in return for up to 300 Palestinian prisoners, mostly women, minors and older people. The official, speaking on condition of anonymity to discuss the negotiations, said the proposed six-week pause in fighting would include allowing hundreds of trucks to bring desperately needed aid into Gaza every day, including the north. He said both sides agreed to continue negotiations during the pause for further releases and a per-

deadline of the start of the Muslim holy month of Ramadan around March 10, a period that often sees heightened Israeli-Palestinian tensions. Hamas says it has not been involved in the latest proposal developed by the United States, Egypt and Qatar, but the reported outline largely matches its earlier proposal for the first phase of a

Hamas has said it won't release all of the remaining hostages until Israel ends its offensive and withdraws its forces from the territory, and is demanding the release of hundreds of Palestinian prisoners, including senior militants. Netanyahu has rejected those conditions.Israeli Defense Minister Yoav Gallant on Sunday made clear that a cease-fire deal for Gaza wouldn't affect the military's daily low-level clashes with the Lebanese militant group Hezbollah, a Hamas ally.

"We will continue the fire, and we will do so independently from the south," he said while visiting the Northern Command.

Israel declared war after the Oct. 7 Hamas attack on southern Israel in which militants killed about 1,200 people, mostly civilians, and took around 250 hostages. More than 100 hostages were released in a cease-fire deal in November.

Before the war, one or two newborns in incubators there died per month. (AP)

Palestinian PM submits govt's resignation, a move that could open door to reforms



JERUSALEM, Feb 26: Palestinian Minister Mohammed Shtayyeh said on Monday his government is resigning, in a move that could open the door to U.S.-backed reforms in the Palestinian Authority.

President Mahmoud Abbas must still decide whether he accepts Shtayyeh and his government's resignation. But the move signals a willingness by the Western-backed Palestinian leadership to accept shake-up that might usher in reforms seen as necessary to revitalize the Palestinian Authority.

The U.S. wants a reformed Palestinian Authority to govern Gaza once the war is over. But many obstacles remain to making that vision a real-

"The next stage and its challenges require new governmental and political arrangements that take into account the new reality in the Gaza Strip," Shtayyeh said at a Cabinet

#### UN's secy gen warns the world is becoming 'less safe by the day'

GENEVA, Feb 26: UN Secretary-General Antonio Guterres says combatants in places such as Congo, Gaza, Myanmar, Ukraine and Sudan are turning a "blind eye" to international law as he made a plea for greater respect for human rights and peace around the

Speaking as the UN's top human rights body opened its latest session, Guterres warned on Monday that the world is becoming "less safe by the day."

"Our world is changing at warp speed," he told the Human Rights Council. "The multiplication of conflicts is causing unprecedented suffering. But human rights are a constant.'

The UN chief said attacks on human rights take many forms, and reiterated his frequent calls for debt relief for some of the world's poorest countries and greater spending to fight climate change. He defended UNRWA, the agency for Palestinian refugees, as the "backbone" of aid efforts in Gaza at a time when top Israeli authorities have called for its dismantling. The UN human rights chief, Volker Türk, also lashed out at "attempts to undermine the legitimacy and work" of the UN and its affiliates.

"The UN has become a lightning rod for manipulative propaganda and a scapegoat for policy failures," he said. "This is profoundly destructive of the common good, and it callously betrays the many people whose lives rely on it."

The council was kicking off a six-week session on Monday as crises of human rights abound. On many minds will be the death this month of while held in prison in President Vladimir Putin's Russia, a permanent UN Security Council member. (AP)

## Hungary's parliament set to ratify Sweden's NATO accession in final step toward membership

BUDAPEST, Feb 26: Hungary's parliament is to vote on Monday on ratifying Sweden's bid to join NATO, likely bringing an end to more than 18 months of delays that have frustrated the alliance as it seeks to expand in response to Russia's war in Ukraine.

Hungary's government submitted the protocols for approving Sweden's entrance to NATO in 2022, but the matter has stalled in parliament since then over opposition by governing party lawmakers. Unanimous support among all NATO members is required to admit new countries, and Hungary is the only one of the alliance's 31 members that has not given its back-

Prime Minister Viktor Orban, a right-wing nationalist who has forged close ties with Russia, has said that criticism of Hungary's democracy by Swedish politicians had soured relations between the two countries and led to reluctance among lawmakers in his

But the vote on Monday is widely expected to approve Sweden's membership in NATO, removing the final hurdle after it first applied to join the alliance in May 2022.

Ulf Kristersson, Sweden's prime minister, met with Orban on Friday in Hungary's capital, where they appeared to reach a decisive reconciliation. Following their meeting, they announced the conclusion of a defence industry agreement which will include Hungary's purchase of four Swedish-made JAS 39 Gripen jets and the extension of a service contract for its ex-

Orban said the additional fighter jets "will significantly increase our military capabilities and further strengthen our role abroad" and will improve Hun-

gary's ability to participate in joint NATO operations. "To be a member of NATO together with another country means we are ready to die for each other," Orbán said. "A deal on defence and military capacities helps to reconstruct the trust between the two coun-

Monday's vote on Sweden's NATO accession is just one matter on a busy agenda for lawmakers in the Hungarian parliament. A vote is also scheduled on accepting the resignation of President Katalin Novák, who stepped down earlier this month in a scandal over her decision to pardon to a man convicted of covering up a string of child sexual abuses.

After accepting Novák's resignation, lawmakers are expected to confirm Tamas Sulyok, the president of Hungary's Constitutional Court, as the country's new

Some opposition parties have said they will not participate in a vote to confirm a new president. But Sulyok was nominated by Orban's Fidesz party, which has a two-thirds majority in parliament and is expected to easily approve his presidency.

A presidential signature is required for approval of Sweden's NATO bid to take effect, but it was unclear when that final endorsement would take place.

Hungary's allies in NATO and the European Union have put increasing pressure on it in recent months to drop its opposition to Sweden's membership. Last weekend, a bipartisan group of US senators visited Hungary and announced it would submit a joint resodemocratic backsliding and urging Orbán's government to immediately lift its block on Sweden's trans-Atlantic integration. There are about 13,000 medical interns and residents in South Korea, most of them working and training at 100 hospitals. They typically assist senior doctors during surgeries and deal with inpatients. They represent about 30 to 40 per cent of total doctors at some major hospitals.

The Korea Medical Association, which represents about 140,000 doctors in South Korea, has said it supports the striking doctors, but hasn't determined whether to join the trainee doctors' walkouts. Senior doctors have held a series of rallies voicing opposition to the government's plan.

Earlier this month, the government announced universities would worry they would face greater competition and lower income.

#### Farmers converge on the EU's headquarters in a fresh show of force

BRUSSELS, Feb 26: Concrete barriers and barbed wire surrounded the European Union's headquarters on Monday as farmers angry at red tape and competition from cheap imports drove their tractors into Brussels in a fresh show of force as the bloc's agriculture ministers met.

Police carrying riot gear patrolled near barricades set up at the main entry points to the European Council building, where the 27-nation bloc's agriculture ministers were gathering. Scores of tractors adorned with flags and banners were ranked in lines, snarling city traffic.

Some lamented what they see as the slow death of working the land. 'Agriculture. As a child you dream of it, as an adult you die of it," said one.

Farmers dumped a trailer load of tyres a few hundred metres (yards) from the European Council building, and police brought in water cannons before the piles of rubber were set

At the start of the month, a similar demonstration turned violent as farmers torched hay bales and threw eggs and firecrackers at police near a summit of EU leaders.

"We are getting ignored," Marieke Van De Vivere, a farmer from the Ghent region in northern Belgium told The Associated Press.

She invited the ministers "to be reasonable to us, to come with us on a day to work on the field, or with the horses or with the animals, to see that it is not very easy ... because of the rules they put on us".

The protests are the latest in a series of rallies and demonstrations by farmers across Europe

# Feleti Teo is named Tuvalu's new PM after elections that ousted Taiwan supporter

MELBOURNE, Feb 26: Tuvalu's former Attorney General Feleti Teo was named prime minister of the tiny South Pacific nation on Monday after elections a month ago ousted the last government leader.

Teo was the only candidate nominated by his 15 lawmaker colleagues and Governor General Tofiga Vaevalu Falani declared him elected without a vote, government secretary Tufoua Panapa said in a statement. The swearing-in ceremony for Teo and his Cabinet will be held later this week.

It was not immediately clear how the new government will affect China's influence in the country of around 11,500 people halfway between Australia and Hawaii.

Kausea Natano, and three of his

# Your dream is my resolve: PM Modi to youngsters 'Indian Railways is undergoing a transformation and it will benefit those who are studying in schools and colleges'

ister Narendra Modi on Monday said a developed India will be the India of youngsters' dreams and they have the maximum right to decide how the country shapes up in the future.

Addressing a function to lay the foundation of railway projects, the Prime Minister said the third term of his government will start in June, but the scale and speed with which new projects have begun have left every-

Recalling the events he attended in Jammu and Gujarat over the last couple of days, Modi said he dedicated a dozen Indian institutes of technology (IITs) and Indian institutes of management (IIMs) and five All India Institute of Medical Sciences (AIIMS) to the country.

The Indian Railways is undergoing a transformation and it will benefit those who are studying in schools and colleges and those below 35 years of age, he said, adding that he has laid the foundation for the work to revamp more than 550 railway stations across 27 states and 300 districts.

"Youngsters have the maximum say in deciding how Viksit Bharat (developed India) will shape up.... I wish to tell every youngster of the country that your dream is Modi's resolve. Your dream, your hard work and Modi's resolve is the guarantee for Viksit Bharat," the prime minister said, addressing the gathering



spread across 2,000 railway stations

Modi laid the foundation for 554 Amrit Bharat stations, a government initiative to revamp key railway stations across the country, and inaugurated rail overbridges and underbridges

The Prime Minister's outreach to voungsters comes against the backdrop of a surge in the number of first-time voters in the 2024 Lok Sabha polls. Nearly 1.85 crore firsttime voters -- in the age group of 18-19 -- have registered for the polls likely to be held in April-May, as against the 1.5 crore ahead of the 2019 general election.

The total number of voters aged below 30 years is nearly 22 crore. Modi lauded the youngsters who participated in various competitions across the country on the theme of "2047: Viksit Bharat ki Railway". He said every paisa of taxpayers money is being used for the welfare of the commuters.

"There is also a 50-per cent discount given by the government on every railway ticket," the prime min-

"Just as interest is earned on money deposited in banks, similarly, every paisa spent on infrastructure creates new sources of income and employment," he said, adding that the laying of new railway tracks created multiple employment opportunities for labourers to engineers.

"Whatever India does today, it does it at an unprecedented speed and scale. We dream big and work tirelessly to realise those dreams. This resolve is visible in this Viksit Bharat Viksit Railway programme,' the prime minister said, as he

launched more than 2,000 rail infrastructure projects worth about Rs 41.000 crore.

Exuding confidence about the Bharatiya Janata Party (BJP) retaining power in the Lok Sabha polls, Modi said the third term of his government will start from June, but the scale and speech with which it has been working have surprised people.

"People have seen a new India being built in the last 10 years," he said, highlighting the transformation in the railways, including the launch of Vande Bharat trains, an emphasis on cleanliness and electrification of

## Will scrap 'Agnipath', revert to old recruitment system if voted to power: Congress

NEW DELHI, Feb 26: Stepping up its attack on the Union government over the "Agnipath" military recruitment scheme, the Congress alleged on Monday that "gross injustice" was done to youngsters and asserted that it would revert to the old recruitment system if voted to power at the Centre.

The opposition party also demanded that appointment be given to the about two lakh youngsters who had cleared the recruitment process but were not given joining letters as the "Agnipath" scheme was launched in 2022.

Congress chief Mallikarjun Kharge wrote to President Droupadi Murmu on Monday, highlighting the "gross injustice" done to the youngsters seeking regular employment in the armed forces due to the "Agnipath" scheme, and urged her to ensure

The future of nearly two lakh young men and women has become uncertain due to the scrapping of the regular recruitment process in the armed forces, Kharge said in his letter to the president, who is the supreme commander of the armed forces.

"There are many well-known issues with the Agnipath scheme. Former Chief of Army Staff General MM Naravane has written that the Army was 'taken by surprise' by Agnipath and that 'for the Navy and Air Force, it came like a bolt from the blue'," he said in his letter to Murmu.

"Furthermore, the scheme is discriminatory among our jawans by creating parallel cadres of soldiers who are expected to work on similar tasks, but with very different emoluments, benefits prospects. The majority of Agniveers will be released into an un-

certain job market after four years of service, which some have argued could affect social stability," Tagging Kharge's letter, Con-

gress leader Rahul Gandhi said on X: "We are with the military candidates, who are full of patriotism and bravery, in the fight for justice." Congress general secretary Priyanka Gandhi Vadra said with the spirit of patriotism and service in mind, lakhs of youngsters across the country work hard day and "Whether it is cold, hot or rainy, they wake up early in the morning and practise running. "In the long term, this scheme will not benefit anybody except saving some money for the government of India. We in the Congress party feel that we should go back to the old recruitment system," Pilot said.

If some changes are to be introduced to modernise the armed forces, that is very much possible in the current setup, but to completely eradicate the old system is not right, he added.

The Delhi Police has intensified checking at the borders by putting up barricades.

There was heavy traffic at the Chilla border from Delhi towards Noida due to the checking. The traffic was also heavy at the Delhi-Noida Expressway.

Earlier in the morning, Gautam Buddh Nagar Police said intensive checking will be conducted by the Delhi Police as well as the district police by installing barriers at all the border points between the national capital and Noida. Traffic will be diverted in accordance with the situation, it said. The ongoing farmers' protest has also affected the traffic movement at the Singhu and Tikri border points between Delhi and Harvana.

On Saturday, the authorities partially reopened the Singhu and Tikri border points, almost two weeks after they were sealed in view of the farmers' 'Delhi Chalo' march.

One of the commuters wrote on X that the traffic was heavy at Singhu border service road. The vehicles can be seen crawling

near the border. The two border points were sealed on February 13 as the protesting farmers from Punjab began their protest march to press

the BJP-led Centre over their demands, including a minimum support price (MSP) for crops and farm loan waiver.

Thousands of farmers have been camping on the Punjab-Haryana border near Ambala, about 200 kilometres from Delhi, after their march was thwarted by security personnel.

Apart from this, the traffic was also heavy at other places in the national capital.

Due to the construction of flyover between Apsara border and Anand Vihar, the vehicular movement was affected near Anand Vihar flyover on both the carriageways.

The commuters also complained about the traffic jams at Sardar Patel Marg and towards Gurgaon from the national capital.

# Allahabad HC rejects plea challenging Varanasi court order allowing 'puja' in Gyanvapi mosque's cellar

prayers will continue in the southern cellar of the Gyanvapi mosque in Varanasi, the Allahabad High Court said on Monday while dismissing a plea that had challenged the district court's order to this ef-

Justice Rohit Ranjan Agarwal rejected two appeals filed by the mosque management committee challenging the Varanasi district judge's January 17 order that appointed the district magistrate as the receiver of the "Vyas Tehkhana" or southern cellar of the mosque and January 31 order by which he allowed 'puja' to be per-

The high court said worship will continue in the "Vyas Tehkhana" of the mosque adjacent to the Kashi Vishwanath temple.

Mohammad Yasin, joint secretary of Anjuman Intezamia Masajid, the committee that manages the affairs of the Gyanvapi, said that their lawyers are studying the judgement and they might approach the Supreme Court against

Dismissing the appeals, Justice Agarwal said, "After going case and considering the arguments of the parties concerned, the court did not find any ground to interfere in the judgment passed by the district judge on January 17, appointing the Varanasi district magistrate as the receiver of the property, as well as the order dated January 31 by which the district court permitted puja in the tehkhana.

Going through the argument made by the Muslim side that the January 31 order was passed without any application, the high court said, "In the instant case, by order dated January 17 the composite prayer made in application was allowed, but only relief (a) was incorporated appointing receiver. Relief (b) allowing worship was added on January 31, 2024 after it was brought to the notice of the Court and order stood modified/ amended in terms of Sections 151/152 CPC."

"I find that the challenge made to the order dated January 31 on the plea of res judicata is totally unfounded as the relief prayed by the plaintiff was granted on January 17, 2024 but part of it was not



incorporated in the order which subsequently modified/ amended." Justice Agarwal said.

In its 54-page judgment, the court also noted, "Lastly, an attempt has been made to malign the image and impute motive to the order passed by the Court below on January 31, 2024 on the ground that the officer concerned had passed the order on the last work-

Justice Agrawal said that puja at

that place has already been started and is going on thus there is no occasion to stop the same.

The high court judge had reserved his verdict in the matter on February 15 after hearing the counsel for the parties.

The mosque committee had moved the high court on February 2. hours after the Supreme Court refused to hear its plea against the district court order and asked it to approach the high court.

chaeological Survey of India (ASI) on the court's order had suggested that the Gyanvapi mosque was constructed during Mughal emperor Aurangzeb's rule over the remains of a Hindu temple.

The district court ruled on January 31 that a Hindu priest can perform prayers before the idols in the southern cellar of the mosque.

The prayers are now being conducted by a Hindu priest nominated by the Kashi Vishwanath temple trust and the petitioner, who has claimed that his grandfather offered puja in the cellar till December 1993.

The district court had directed the local administration to make arrangements within seven days for prayers in the cellar. This would have involved "proper arrangements" with metal barricades at the complex.

# Rape survivor shot at by rapist, aides in Rajasthan; 3 arrested

survivor was seriously injured when she was shot at and attacked with a sharpedged weapon by a man accused of raping her and his two accomplices in Kotputli-Behror district of Rajasthan.

The woman's brother was also injured in the attack and the two are undergoing treatment at Sawai Man Singh Hospital here. The three accused have been arrested, police said.

On Saturday night, the woman was returning home on a two-wheeler with her brother when Yadav and two others, Mahipal Gujral and Rahul Gujral, attacked them near Pragpura police station. The accused followed the siblings before

attacking them, police said. Yadav shot the woman in the back while the other two accused stabbed her and her brother with a sharp-edged weapon. The woman sustained multiple injuries in the head, legs, hands and

An FIR has been registered in the matter based on a complaint lodged by the woman's family.

According to the FIR, Yadav allegedly raped the woman on January 16 last year and was subsequently arrested and fired from his job.

He recently came out on bail and

started threatening the woman to withdraw the case against him. Yadav attacked her as she did not withdraw the case, the FIR stated. Mahipal and Rahul were arrested on Sunday Yadav got his beard and hair trimmed



## EC ropes in banks, post offices to spread voter awareness ahead of LS polls



NEW DELHI, Feb 26: The Election Commission on Monday roped in banks and post offices to spread voter awareness as part of its efforts to increase voting percentage in the upcoming Lok Sabha polls.

The poll panel has often expressed concern over urban and youth apathy with many registered voters not turning up at the polling stations to cast ballot in the previous elections.

Over 30 crore of the 91 crore electors did not cast their ballot in the previous parliamentary polls.

The Election Commission (EC) on Monday signed a memorandum of understanding (MoU) with two prominent organisations -the Indian Banks' Association (IBA) and the Department of Posts (DoP) -- to amplify its voter outreach and awareness efforts ahead of the Lok Sabha elections.

The initiative, the poll panel said, is in con tinuation of its efforts to enhance electoral awareness in the country.

The EC had recently signed an MoU with the Ministry of Education to formally integrate electoral literacy into the educational curriculum of the schools and colleges.

The latest initiative has been taken based on insights and knowledge gained by Chief Election Commissioner (CEC) Rajiv Kumar from his past roles and experience working in the financial sector, particularly in the Indian banking sector and India Post Payments Banks, the officials pointed out.

As part of the MoU, the IBA and the DoP with its members and affiliated institutions will extend support in promoting voter education through their extensive network on a pro

bono without charge basis, employing various interventions to empower the citizens with knowledge about their electoral rights, processes and steps for registration and vot-

The members and affiliated institutions will now display voter education messages prominently on their websites, directing visitors to learn more about the electoral process.

Voter education content will be disseminated through various promotional channels such as social media and customer outreach platforms of member institutions, ensuring widespread awareness among stakeholders and the public, the EC said.

Voter education messages will also be displayed in the form of posters, flex and hoardings at office premises at major locations. reaching the customers at key touchpoints.

All member institutions under the IBA and the DoP will establish 'voter awareness fora' to engage the employees and customers in discussions and initiatives related to voter educa-

The Department of Posts will affix a special cancellation stamp (bearing voter education messages) on the postal articles.

"Despite successfully managing and conducting elections by the Election Commission over the years in a fair and peaceful way along with a significant increase in participation of the electors, there is also a concern that around 30 crore electors, out of 91 crore, did not cast their votes in general election to Lok Sabha 2019. The voting percentage was 67.4 per cent, which the Commission has taken as a challenge to improve upon," the EC said.

The Indian Banks' Association now has a strong network of 247 members across the country. Public sector banks are in lead with 90,000+ branches and 1.36 lakh ATMs followed by 42,000+ branches of private sector banks with 79.000+ ATMs.

Regional rural banks contribute over 22,400 branches, while small finance and payment banks operate around 7,000 branches and more than 3,000 ATMs.

Foreign banks maintain 840 branches and 1.158 ATMs, and local area banks have 81

NEW DELHI, Feb 26: Researchers at IIT-Madras have developed the first India-specific Artificial Intelligence model to accurately determine the age of a foetus in a pregnant woman.

According to officials, accurate 'Gestational Age' (GA) is necessary for the appropriate care of pregnant women and for determining precise delivery dates. Called 'Garbhini-GA2', this is

the first late-trimester GA estimation model to be developed and validated using Indian population data, they said. Currently, the age of a foetus

(Gestational Age) is determined using a formula developed for the Western population. It are likely to be erroneous when applied in the later part of pregnancy due to variations in the growth of the foetus in the Indian population.

According to officials, the newly developed 'Garbhini-GA2' accurately estimates the age of a foetus for the Indian population, reducing error by almost three times. This GA model can improve the care delivered by obstetricians and neonatologists, thus reducing maternal and infant mortality rates in India.

"GARBH-Ini is a flagship programme of DBT, and the development of these population-specific models for estimating gestational age is a commendable outcome.

The station will be a part of the under-construction 45-km rail line from Sevoke near Siliguri in West Bengal to Rangpo in Sikkim. It will have 14 tunnels and 22 bridges.

The track on the Sevoke-Rangpo section of the Northeast Frontier Railway will have the capacity to handle 25 tonnes and trains can run at a maximum speed of 110 km per hour. There will be three stations between Sevoke and Rangpo -- Riyang, Teesta and Melli, all in West Bengal.

The project was awarded to IRCON International in May 2010 at a cost of ₹ 4,084.69 crore and the original deadline was May 2015. The revised date is now December 2024 with a revised cost of ₹ 12,474.07 crore, according to officials. (PTI)



## IDCA wants deaf cricket's inclusion in Para Asian Games

NEW DELHI, Feb 26: The Indian Deaf Cricket Association (IDCA) on Monday said it is working hard for the sport's inclusion in the Para Asian Games to provide a levelplaying field to the differentlyabled athletes.

IDCA is a founder member of Differently Abled Cricket Council of India (DCCI), which is being supported by BCCI.

We are working, we are already in touch with the Asian countries. We have already visited Hong Kong, which is one of the Asian countries who are ready to host the first Asian match with IDCA. But, right now, we are focussing on the World Cup," IDCA president Sumit Jain said here.

"We have got all the government certifications and some of them are under process which we will be getting very soon.

"Everything is in process right now and we are working very hard to get that into action very soon."

Even though they are being recognised and supported by BCCI, the IDCA doesn't get any monetary assistance from the nation's cricket board, which it hopes it will get in future.

"As of now, the BCCI has recognised us under DCCI and has been providing us kits and all other cricketing equipments. But there is no monetary support. We are hoping to get financial assistance from BCCI through DCCI in future,' said IDCA CEO Roma Balwani.

"We have learnt that in 2025 cricket will be included in Paralympics, so we are hoping that this committee of BCCI will come in the forefront and get all the disability cricket teams to participate."

Balwani also hopes one day a deaf cricketer will represent the Indian mainstream team as besides hearing impairment they have no other problems.

"We are only hoping, we would love at least one of our players if he or she can join the mainstream team. It has been Sumit's vision for over a decade," she said. A 15member Indian deaf cricket team, under Virendra Singh's captaincy, is set to participate in the Deaf International Cricket Council (DICC) T20 Champions Trophy 2024 to be held in Sharjah from March 6 to March 12. RANCHI, Feb 26: India's home supremacy weathered the 'Bazball' storm as Rohit Sharma's men secured a hardfought five-wicket win over England in the fourth and penultimate Test for a 17th consecutive series triumph in their own backyard here on Monday, handing a harsh reality check to the visitors' unidimensional approach.

Overnight 40/0 in a chase of 192 here, India romped home after surviving a few hiccups with the opening duo of skipper Rohit Sharma (55 off 81 balls) and Yashasvi Jaiswal (37 off 44 balls) providing the perfect platform for others to build with their 84-run stand on day four of the match.

There were some jitters after the two departed in close succession followed by Rajat Patidar and Ravindra Jadeja's dismissal but Shubman Gill (52 not out) and Dhruv Jurel (39 not out) guided the side past the finishing line with an unbeaten 72-run partnership.

Left-arm spinner Tom Hartley (1/64) took the prized scalp of Rohit, while Shoaib Bashir was the most successful English bowler, scalping 3/79 in the second innings for a match haul of eight

India lead 3-1 in the series with the last

Indian captain. Rohit came down the track only to be beaten by the flight and spin from Hartley and Ben Foakes did the needful behind the stumps. Though Rohit was way out of the crease, he was adjudged caught behind after getting a faint tickle on the

way to the wicketkeeper. Bashir sent back Jadeja and Sarfaraz off successive deliveries right after the lunch break. The Indian chase began to unravel with those dismissals but Gill and Jurel teamed up to steady the ship.

Against the run of play, Jurel produced a lovely cover drive off Bashir, who went too wide and full, to get the team's first boundary in 31 overs. There was a sigh of relief and the Indian victory did not seem remote anymore.

The target soon came down to less than 50 and Gill too joined in the party smashing Bashir for back-to-back sixes. (PTI)

# Jurel's Army upbringing gives him the fearless attitude: Raina

GREATER NOIDA, Feb 26: India wicketkeeper-batter Dhruv Jurel's Army up-bringing gives him the "fearless attitude" on the field, felt former cricketer Suresh Raina, adding that the young player had put in a lot of hard work to reach this level.

Jurel scored a peerless 90 in the first innings of the ongoing fourth Test against England and then played with determination on difficult day-four pitch in Ranchi, scoring an unbeaten 39, to give India a fivewicket win and an unassailable 3-1 lead in the five-match series.

"I was impressed with his (Jurel's) wicket-keeping, he has worked really hard. He comes from an Army family, so he has that fearless attitude of never wanting to lose anything from anywhere," said Raina about the 23-year-old Uttar Pradesh player who made his India debut in the third Test at Rajkot, scoring 46.

Jurel's knock of 90 in Ranchi also received applause from the legendary Sunil Gavaskar, who called him the next Mahendra Singh Dhoni.

"He's (Jurel) been amazing, I have played a couple of matches with him for



Uttar Pradesh. Special credit to Rohit Sharma, the way he gave chances to first Sarfaraz (Khan) and Dhruv Jurel. It is not easy to come into Test cricket and score back-to-back fifties, especially in a crucial Test match where the wicket was turning, said Raina, who played 18 Tests, on the

sidelines of the Indian Veteran Premier league (IVPL).

Sarfaraz scored back-to-back half centuries on Test debut in the third Test at Ra-

Raina, who was an integral part of Chennai Super Kings not so long back, said that

he wants Virat Kohli and Royal Challengers Bangalore to break the IPL jinx and lift the trophy this season.

"I wish Virat Kohli and RCB lift the trophy. It is long overdue now, CSK won it last season too but this year I hope that the team who has never lifted the trophy should finally add one to their trophy cabinet. Virat has worked really hard and I think he deserves to win this time," said Raina.

The 37-year-old former India cricketer also said that Kohli should be a part of the 2024 T20 World Cup in the West Indies and the USA because the team needs someone in the middle to soak the pressure.

"A blend of youth and experience will be key for India's success in the Americas."

'Youth and experience is really important because I played in the Caribbean in the 2010 edition, to bat on those wickets is not easy. You need someone to control the innings, he (Kohli) is the chase-master and knows how to handle pressure.

"Now we have players like (Yashasvi) Jaiswal, (Shubman) Gill, Surya (Yadav) and Rinku Singh who can back him and play fearless cricket from other end." (PTI)

# India consolidate second position in WTC standing with five-wicket win against England

DUBAI, Feb 26: India consolidated their second spot in the World Test Championship (WTC) standing following their five-wicket win against Ben Stokes' England in the fourth Test at Ranchi on Monday.

The hosts, led by Rohit Sharma, took an unassailable 3-1 lead in the five-Test series.

India's point-percentage jumped from 59.52 to 64.58 following the hard-fought win and they further extended the gap with Australia (55%) and Bangladesh (50%), third third and fourth-placed teams, respectively. England, on the other hand, are languishing at eighth with 19.44%, just a spot ahead of bottom-placed Sri Lanka, who are yet to open their account.

India have so far played eight Tests in the current WTC cycle, winning five, losing two and drawing one match.

England's 'Bazball' approach

doesn't seem to have given them rich dividends with the visitors having won just three matches, while losing five and drawing one so far.

New Zealand are leading the standing with 75 percentage points and have played just four Test so

A total of 12 points are awarded for a win, six for a tie and four for a draw. Teams are ranked according to the percentage of points.

The top-two teams will progress to the final at Lord's in 2025.

India have reached the WTC final both the times since the format was launched. They lost to New Zealand in the inaugural championship final, while bowing to Australia in the second edition.

India have a great chance to further cement their second position if they win the fifth and final Test in Dharamsala, beginning from March
