GUWAHATI: A complaint was received at this Directorate of Vigilance & Anti-Corruption, Assam, alleging that Arafad Alom Bora, lot mandal of Naduar Revenue Circle, Sootea, and District-Biswanath had demanded ₹ 5,000 as bribe from the complainant for name correction and updation in land records. Unwilling to pay the bribe, the complainant approached this Directorate for taking necessary legal action against the above-mentioned public servant. Accordingly, a trap was laid today, on 07/02/2024 by a team from the Directorate of Vigilance and Anti-Corruption, Assam, in the office of the Circle Officer, Naduar Revenue Circle, Sootea, and District- Biswanath. Arafad Alom Bora was caught red handed in the office, in presence of independent witnesses, immediately after he accepted ₹ 2,000 as part of the demanded bribe from the complainant. The tainted bribe money has been recovered from his possession and has been seized accordingly, in presence of independent witnesses. In this connection, a case has been registered in ACB Police Station on 07/02/2024 vide Case No. 14/2024, under Section 7(a) of Prevention of Corruption Act.

83,000 ha of Assam land facing encroachment, House told

GUWAHATI, Feb 7: The Assam assembly on Wednesday witnessed a noisy scene over border disputes with other northeastern states as the opposition alleged that Assam is giving away its land to resolve the issue, even as the House was informed that almost 83,000 hectares of land belonging to Assam are being occupied cur-

rently by four neighbouring states. Raising the issue during the Question Hour, Independent MLA Akhil Gogoi said Assam is abandoning its rights over constitutionally received land to Meghalaya and Arunachal Pradesh as per replies of border protection and development minister Atul Bora.

going on and it is not clear which state will get what portions of the disputed areas.

"We are trying to settle the disputed land parcels," he said. When Gogoi reiterated his allegation that Assam is giving away state land, the minister said, "No one can satisfy Akhil Gogoi. He has been disturbing the assembly since he joined the proceedings.

This led to a noisy scene with opposition and treasury benches engaging in a verbal duel. "Is the Assam government a donor of state land? Who has given you that right?" asked an infuriated Gogoi.

Leader of the Opposition Debabrata Saikia pointed out that as per an independent commission of 1983, there was no jurisdiction for any claim made by Meghalaya over the disputed land. "So, there is no question of giving away Assam land. The government should rethink its policy of giving our land to Meghalava. For other states, the cases may be different," he added. Bora said the two states are moving

ahead by taking feedback from residents of the disputed places and the administrations of both sides. Of the 36 disputed sites between Assam and Meghalaya, 18 have been settled, meaning "Assam gave away its land to the neighbouring state" for a resolution, AIUDF MLA Aminul

'This government will not give any land to Meghalaya. We will not betray the sentiment of Assam," the minister said. Assam and Meghalaya have a longstanding dispute in 12 areas along the 884.9-km-long inter-state border. The two states had, in March 2022, signed an agreement in the presence of Union Home Minister Amit Shah in New Delhi to resolve the issue in six areas. Of the 36.79 sq km of disputed areas taken up for settlement in the first phase at six places, Assam got 18.46 sq km and Meghalaya received 18.33 sq km, Bora said.

Meiteis welcome move

Indo-Myanmar border fence will sever ethnic ties, say Kuki-Zo people

IMPHAL/AIZAWL/ITANA-GAR, Feb 7: The Centre's decision to fence the Indo-Myanmar border has evoked mixed reactions with the Kuki-Zo people claiming that the move will sever ethnic ties and Meitei organisations hailing the step saying it will check movement of unscrupulous elements from across the border.

The reactions came a day after the announcement by Union home minister Amit Shah on X that the Centre had decided to fence the Indo-Myanmar border.

"It has been decided to construct a fence along the entire 1643-kilometre-long Indo-Myanmar border. To facilitate better surveillance, a patrol track along the border will also be paved," Shah had said.

Reacting to the move, the Mizo Zirlai Pawl (MZP), the apex stu-

dents' body of Mizoram, said fencing the border will divide the Zo ethnic people between the two countries and bring an end to the Free Movement Regime (FMR). The FMR allows people living on either side of the border enter up to 16 km of each other's country with-

out needing a visa and stay up to two weeks. The Mizoram government and the Central Young Mizo Association (CYMA), the state's largest civil organisation, also opposed the move to fence the border. Mizoram chief minister Lalduhoma had earlier (CONTD. ON PAGE-9)

Assam govt to merge Class 10, 12 boards into one new body

String of attacks on Indian students in US continues

NEW YORK, Feb 7: In a series of disturbing incidents, an Indian doctoral candidate was found dead at Purdue University in Indiana while another Indian IT student was brutally attacked near his house in Chicago. The back-to-back incidents since Sunday were the sixth in the US in 2024 alone.

According to The Purdue Exponent, a news agency independent of the university, Sameer Kamath, 23, a doctoral candidate in mechanical engineering, was found dead in Warren County on Monday, the mechanical engineering head Eckhard Groll announced on Tuesday.

Kamath's body was found at a nature preserve at Crow's Grove, the agency said, quoting a press release from Justin Brummett, the

Warren County Coroner. After his bachelor's degree in mechanical engineering from the University of Massachusetts Amherst, Kamath had come to Purdue in the summer of 2021, Groll said in his email. He was slated to graduate from the doctoral programme in 2025. In another incident, Indian IT student Syed Mazahir Ali was chased and brutally (CONTD. ON PAGE-9)

Stop creating narrative to divide country into north, south: PM to Cong NEW DELHI, Feb 7: Prime Minister Narendra Modi on Wednesday urged the Congress and its government in Karnataka to stop

creating a narrative to divide the country into north and south saying it jeopardises the country's future. Replying to the debate to the Motion of Thanks in the Rajya Sabha, he lamented that the Kar-

nataka government was building such a narrative through advertisements. Modi was referring to the protest dharna by the Congress led by Karnataka chief minister Siddaramaiah over alleged "injustice" meted out by the Centre on devolution of tax share to the state.

"Today I want to share my pain on a specific matter...The way language is being spoken these days to break the country, these new narratives are being made for political gains. An entire state is speaking this language, nothing can be worse for the country than this...what language have we started saying," he said.

Modi said such narratives were not good for the country and could



jeopardise its future.

He lamented that a vaccine is made in one part of the country and someone says that it can't be given to other parts. "What is this thinking? And it is very painful that such language is emerging from a national party, it is very sad," he noted. "This nation is not just a piece of land for us. It is like the human body, if there is pain somewhere, the hand doesn't say that the thorn is in the foot and it doesn't concern me...if there is pain anywhere in this country, pain should be felt by everyone. "If one body part does not work the entire body is dubbed as handicap, If any part of the country is left without development, then the country cannot become (CONTD. ON PAGE-9)

Oil cos losing close to ₹3 a litre on diesel, profit on petrol down

BETUL (GOA), Feb 7: Stateowned fuel retailers are losing close to ₹ 3 per litre on selling diesel while the profit on petrol has trimmed due to recent firming up in international oil prices, industry officials said detailing reasons for continuing to hold retail prices.

Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL), who control roughly 90 per cent of India's fuel market, 'voluntarily' have not changed petrol, diesel and cooking gas (LPG) prices for almost two years now, resulting in losses when input cost was higher and profits when raw material prices were lower.

International oil prices, against which domestic rates are benchmarked as India is 85 per cent dependent on imports to meet its oil needs, had softened late last year but firmed up again in the second half of January.

They have resisted calls to revert to daily price revision and pass on softening in rates to consumers on grounds that prices continue to be extremely volatile - rising on one day and falling on the other - and that their past losses haven't been fully recouped.

"There are losses on diesel," an industry official said. "It had turned positive but now oil companies are losing close to ₹ 3 per litre." He said the profit margin on petrol has trimmed from low teens to around ₹ 3-4 a litre

Asked about fuel price revision, Oil Minister Hardeep Singh Puri told reporters on the sidelines of the India Energy Week that the



government does not dictate prices and the oil companies take their decision considering all economic aspects. "They say there is still volatility (in the market)," he said.

Asked about the bumper ₹ 69,000 crore profits that the three firms have clocked in the first nine months of the current fiscal, he said the expectation would be to start price revision if the trend continues in the fourth and last quarter of the current fiscal year ending March 31. "They had losses when they voluntarily decided not to raise prices (despite oil prices going up)," he said.

The combined net profit of IOC, BPCL and HPCL in the April-December (first nine months of current fiscal year) was better than their annual earning of ₹ 39,356 crore in pre-oil crisis year, regula-

tory filings by them showed.

The firms had posted a combined net loss of ₹21,201.18 crore during the April-September 2022 despite accounting for ₹22,000 crore announced but not paid LPG

had a margin of ₹ 11 a litre on petrol and ₹ 6 on diesel last month. But now things have changed, another industry official explained.

International oil prices have been turbulent in the last couple of years. It dipped into the negative zone at the start of the pandemic in 2020 and swung wildly in 2022 - climbing to a 14-year high of nearly USD 140 per barrel in March 2022 after Russia invaded Ukraine, before sliding on weaker demand from top importer China and worries of an economic contraction.

But for a nation that is 85 per cent dependent on imports, the spike meant adding to already elevated levels of inflation and derailing the economic recovery from the pandemic.

So the three fuel retailers froze petrol and diesel prices for the longest duration in the last two decades. They stopped daily price revision in early November 2021 when rates across the country hit an all-time high, prompting the government to roll back a part of the excise duty hike it had effected during the pandemic to take advantage of low oil prices.

The freeze continued into 2022 but the war-led spike in international oil prices prompted a ₹ 10 a litre hike in petrol and diesel prices from mid-March 2022 before another round of excise duty cut rolled back all of the ₹ 13 a litre and ₹ 16 a litre increase in taxes on petrol and diesel done during the

Essar unveils blueprint for green economy at India Energy Week

BETUL (**GOA**), **Feb 7:** Diversified conglomerate Essar Group will invest billions of dollars in setting up a green hydrogen plant, the world's first green refinery, and building an LNG and electric ecosystem to decarbonise long-haul heavy trucks as it charts a new phase of growth, a top official said.

Armed with a substantially lighter balance sheet after it repaid $\mathbf{\xi}$ 1,40,000 crore of loans over the last four years, the group now has a strong revenue stream of over $\mathbf{\xi}$ 1 lakh crore from existing businesses.

"Essar is charting its path to a resurgence by investing in ecosystems for sustainable growth in India and beyond," Prashant Ruia, Director at Essar Capital, said at India Energy Week here.

Anchored around three core themes of decarbonisation, decentralisation and digitalisation, Essar is looking to play a pivotal role in shaping a greener future

"As India emerges as the world's fastest-growing and third-largest economy, Essar is dedicated to fulfilling climate commitments and promoting green growth," he said.

Essar will invest USD 3.6 billion to build one of the world's largest low-carbon (blue hydrogen) plants and the world's first green refinery, he said without giving further details.

It is also looking to develop a 1 gigawatt green hydrogen project in Gujarat.

In the realm of green mobility solutions, Essar is focused on building an LNG and electric ecosystem to decarbonise long-haul heavy trucks, contributing to a cleaner transportation sector, he said.

Besides, the group is also producing gas using coal seams from a block in West Bengal, he said.

Its arm, Essar Oil and Gas Exploration and Production Limited (EOGEPL), India's leader in the coal bed methane industry, contributes nearly 65 per cent of the country's total coal bed methane production and aims to increase its contribution to India's total gas production to 5 per cent within the next five years, he said. Ruia did not share the investment details in green

mobility and hydrogen plants.

"With these initiatives, Essar is at the forefront of driving the nation's vision of energy transition and sustainable growth." he said.

Separately, in a post on X, Ruia said: "Excited to be back at the @IndiaEnergyWeek, where impactful dialogues are shaping a sustainable future. Hon'ble PM @parandramodi ii's vicion for India's economic

Essar had over the years invested ₹ 2 lakh crore in sectors ranging from ports to steel plants, oil refining and fuel retailing, power generation, mining, shipping and telecom. It sold its oil refinery at Vadinar in Gujarat and fuel retailing network to Russia's Rosneftled consortium in an over ₹ 86,000 crore deal (USD 13 billion), which was the largest FDI in the sector.

Its steel plant was sold to ArcelorMittal-led group in insolvency proceedings.

Essar currently owns businesses in the core sectors of energy, metals and mining, infrastructure, services and technology. In the energy sector, it has commercial interests in oil, gas and coal bed methane exploration and production in India, Vietnam and Nigeria, oil refining and retailing in the UK and power generation in India and Canada.

The group's aggregate revenues now stand at about USD 15 billion. Its businesses include a 10 million tonnes per annum oil refinery in the UK, 12 trillion cubic feet reserves (including some producing fields) of unconventional hydrocarbons in India, an iron ore mine and pellet project in the US, and a high-grade thermal coal mine with 72 million tonnes of proven reserves in Indonesia, among others.

It is now building the UK's first 1 GW blue hydrogen project and is looking to produce green hydrogen and green ammonia in Salaya in Gujarat. It is also investing in the LNG value chain, including LNG trucking and LNG fuel stations. (PTI)

JAMSHEDPUR, Feb 7: Tata Steel CEO and Managing Director T V Narendran claimed India is the fastest growing economy of the world and the next three decades are important for the country on the development front.

China has emerged rapidly during the last 30-40 years and the next 30 years are important for India, which is the fastest growing economy of the world, Narendran said while addressing the members of Singhbhum Chamber of Commerce and Industry (SCCI) here on Tuesday evening.

"Currently, China is the largest steel-producing country in the world and we are second. In view of the global challenges being faced by the steel sector, we have to move forward keeping in mind the steel prices", the Tata Steel MD said. "Today, India is the world's fastest-growing economy and the infrastructure sector witnessed rapid momentum during last two/three years, which resulted in growing steel supply by the private steel major", he said.

As Tata Steel's Jamshedpur plant is located in a densely populated area, there was no possibility of further expansion of the Jamshedpur plant, Narendran said.

He said Tata Steel's relation with SCCI was strengthening continuously and this would help further industrial growth. Sensex, Nifty close flat in choppy trade ahead of RBI policy decision

MUMBAI, Feb 7: Benchmark stock indices Sensex and Nifty closed flat in a volatile trade on Wednesday as investors stayed on the sidelines ahead of RBI's interest rate decision on Thursday.

India to overtake China as oil demand growth centre in 2027: IEA

BETUL (GOA), Feb 7: India will overtake China as the biggest driver of global oil demand in 2027 as transportation and industry consumption in the world's fastest-growing major economy will drive growth despite a big push for clean energy and electrification, the International Energy Agency said on Wednesday.

The Paris-based agency in a special Indian Oil Market Outlook to 2030 report released at the India Energy Week here, said the country's oil demand will rise from 5.48 million barrels per day in 2023 to 6.64 million bpd in 2030.

China currently is the biggest driver of oil demand and India ranks No.2 in growth.

The numbers given by IEA in the report seem to talk of crude oil processed into fuel for domestic as well as for exports. The domestic consumption as per the oil ministry data is around 5 million barrels per day (Aprd)

"India's oil demand will grow at a rapid pace by 2030 despite accelerated green energy moves," IEA director of energy markets and security Keisuke Sadamori said. "Growth in India will surpass that of China in 2027."

But in absolute terms, demand in India will still lag China's even in 2030. "As oil demand slows in developed countries and China, India becomes the largest source of growth," said Toril Bosoni, head of oil industry and markets division, IEA. India currently is the third largest consumer of oil behind the US and China. It imports 85 per cent of its oil needs and this dependence is likely to rise as domes-

tic production falls.

Diesel, she said, accounts for about 50 per cent of Indian gains and 20 per cent of global demand growth to 2030.

The demand growth is despite the push for electric vehicles which make up for a small fraction of the automobiles on the road currently. The EV push will see greater adoption in two- and three-wheelers while their penetration in the four-wheeler segment would be around

5 per cent.
"More than 500,000 barrels per day of oil demand will be avoided due to increased EV penetration, energy efficiency improvements



and biofuels growth," she said. Of this, around 200,000 bpd would be because of EV penetration.

She said refinery expansions will ensure India meets domestic needs and maintain its position as a key exporter of transportation fuel to Asia and the Atlantic Basin, she said adding Indian energy companies are targeting an additional 1 million barrels per day of refinery capacity. On biofuels, IEA said raising ethanol blending in petrol from current 12 per cent to 20 per cent may be a challenge given feedstock constraints.

Lack of major discoveries will see domestic production fall to 540,000 bpd by 2030, she said adding imports will rise from 4.6 million bpd in 2023 to 5.8 million bpd in 2030

bpd in 2030.

India holds oil stock equivalent to meet 66 days of requirement. This includes 7 days requirement stored in underground strategic reserves and the rest in depots and tanks in refineries and other locations. IEA member nations maintain a stockpile equivalent to 90 days of their demand. India is an associate member of IEA.

"India will become the largest source of global oil demand growth between now and 2030, while growth in developed economies and China initially slows and then subsequently goes into reverse in our outlook," IEA said. "India is on track to post an increase of almost 1.2 million bpd, accounting for more than one-third of the projected 3.2 million bpd global gains, to reach 6.6 million bpd by 2030".

The massive industrial expansion means that diesel is the single largest source of oil demand growth, accounting for almost half of the rise in the nation's demand and more than one-sixth of total global oil demand growth through 2030. Petrol will grow by 0.7 per cent on average, as the electrification of India's vehicle fleet avoids a more substantial rise. LPG rounds out the growth picture, as petrochemical industry investments in production facilities boost

feedstock demand.
As a relatively small oil pro-

ducer, and with limited potential for near-term growth, India's domestic production accounted for just 13 per cent of the country's supply needs. In 2023, domestic oil production averaged around 700,000 bpd. "Despite renewed efforts by the government to attract foreign upstream investment, domestic crude oil production is expected to see continued declines over the medium term," IEA said.

India's spectacular economic growth story, however, brings myriad challenges for its security of energy supplies, IEA said.

ergy supplies, IEA said.

"India was already the world's second-largest crude oil net importer in 2023, having boosted imports by 36 per cent over the past decade to 4.6 million bpd to meet rising refinery intake. Increased refining processing will lift crude oil imports further, to 5.8 million bpd by 2030, with major implications for India's security of supply".

The energy crisis and recent surge in long-haul crude sources, notably from Russia, has also added further impetus to sustaining the country's oil resilience in case of market disruptions, it said. (PTI)

China's 'foray' into **Indian Ocean**

The recent docking of a Chinese scientific vessel, the Xiang Yang Hong 3, in the Maldives has reignited tensions between Beijing, New Delhi, and Malé. While Beijing claims the visit is innocuous, India views it with suspicion, fearing it could be a precursor to Chinese military activities, particularly submarine operations, in the region. However, experts dismiss these concerns, citing the lawful nature of Chinese scientific research in international waters. This incident is not isolated; it's part of a larger strategic competition between China and India in the Indian Ocean, exacerbated by their ongoing border disputes in the Himalayas. Previous instances, like Chinese naval submarines docking in Colombo and research ships visiting Sri Lanka, have raised India's ire. Despite India's objections, the Maldives, historically within India's sphere of influence, appears to be tilting towards China, exemplified by President Mohamed Muizzu's pro-China stance and anti-India rhetoric. The Maldives' shift in allegiance is troubling for India, given the nation's strategic importance in the Indian Ocean. India's concerns about Chinese access to this vital location stem from China's expanding naval capabilities and its ambitions in the region. The Maldives' decision to terminate a hydrographic survey contract with India and reduce Indian military presence further underscores the deteriorating relations between the two countries.

China's warm reception of President Muizzu during his recent visit to Beijing and subsequent infrastructure projects funded by China in the Maldives signal a deepening of ties between the two nations. This sudden change in Malé's stance has raised alarms in Delhi, which aims to counter China's growing influence in its backyard. However, it's not just India that's apprehensive; opposition parties in the Maldives, such as the Maldivian Democratic Party (MDP), are also advocating for a shift in government policy, fearing the repercussions of antagonizing India. The Maldives relies heavily on India for various essentials, including food supply, infrastructure development, and healthcare services, making it economically vulnerable to any fallout in relations. The situation underscores the delicate balance of power in the region and the complexities of geopolitics. As China expands its strategic footprint in the Indian Ocean, India must devise effective strategies to safeguard its interests and counter China's assertiveness. This may involve diplomatic maneuvers, bolstering alliances with regional partners, and enhancing naval capabilities to maintain a balance of power.

Furthermore, India must tread carefully to avoid escalating tensions with China while asserting its influence in the Indian Ocean. Any misstep could have far-reaching consequences for regional stability and India's security interests. The docking of the Chinese vessel in the Maldives is a symptom of the broader strategic competition unfolding in the Indian Ocean. India must navigate this complex landscape with caution, prioritizing its national security interests while engaging in constructive dialogue with regional partners to counter China's growing influence. Houthi pirates bring global trade through Red Sea to a near halt

t is difficult to believe in the 21st century that some small groups of Yemeni Houthi pirates on the Red Sea can bring a \$1-trillion-plus annual global trade using the sea route almost to a halt, forcing ship-owners and shippers divert the trade through a several times longer route via the Cape of Good Hope at the bottom of South Africa. Sea piracies are nothing new. But few have shown such guts as Houthi pirates indiscriminately attacking cargo vessels passing through the trait with arms, ammunition, and anti-ship missiles. They won't even spare US Navy destroyers. Cargoes are looted and captured seamen are often thrown into the sea. The escalating Red Sea crisis poses billions of dollars of risk for India. The world mood remains inexplicably defensive. An estimated 12 percent of the global trade isses through the Red Sea. The pirates seem to have strong back-

ings from Iran, which it denies. The Houthi attacks are believed to be linked with Israeli counter attacks on Palestinian Gaza rebels, which have killed over 24,000 Gazans since Palestinian militants attacked an Israeli cultural entertainment programme killing some 1,200 people. mostly civilians, on October 7, last year. Iranian-backed Houthis have been protesting since November against the continuous hammering on Gaza citizens by

Israel's military force. Now, Houthi pirates from Yemen are increasingly attacking commercial vessels passing through the Red Sea. The attacks have forced shippers to avoid one of the world's most crucial trade routes and use the alternative longer route through the waters of the southern tip of Africa, adding more than 3,500 nautical miles (6,500 km,

approximately) to the journey taking close to half a month of extra sailing time in each trip apart from highly increasing shipping and insurance costs.

DEGREE OF THOUGHT

Since last November, the Houthi pirates have targeted vessels passing through the strait of Bab al-Mandab, a 32-km wide channel that splits north-East Africa from Yemen on the Arabian Peninsula. Although India, as in the case of other affected countries, is yet to react to the latest Houthi pirate attacks except keeping its naval frigates in the sea to ensure safety of the cargoes and seafarers. The incidents will have a major impact on the country's foreign trade during the current financial year and beyond. The worst affected are India's oil imports. India is the world's third largest oil importer. It gets the bulk of its Russian supplies through the Red Sea. Russian supplies made up over 35 percent of the country's crude oil imports, last year, amounting to 1./ million barrels per day. As of now, Russian vessels are not the prime targets of the Houthi pirates. However, the rerouting of vessels via the Cape of Good Hope for safety has led to shortage of merchant ships due to the long travel time.

India is also the world's biggest importer of vegetable oils and much of the import passes through the Red Sea. The supply of sunflower oil has become tight for India. The sunflower oil imports are already said to be down. Buyers are shifting to other vegetable oils available at discount. The freight cost has increased by nearly 35 percent. Similarly, fertilizer shipments are getting delayed. Logistics costs are moving up. Exports from India through the Red Sea too are facing big trouble. The Red Sea route via the Suez Canal accounts for 50 percent of the country's exports and 30 percent of imports.

Among the sectors deeply affected by the Houthi piracy are perishable items such as agricultural commodities, farm products, and marine foods, all carrying lean margins. The crisis has also hurt the export of buffalo meat. Nearly 60 percent of India's buffalo meat exports go through the Red Sea to north African countries and Russia.

A prolonged strife can affect the profitability and working capital cycle of India's export-oriented industries. "The extent of this will vary depending on sectoral nuances. Supply chain issues could also intensify, curbing trade volume and renewing inflationary pressures," rating agency CRISIL has said. In a recent credit alert, the rating agency said Basmati rice exporters, shipping a third of India's produce to these regions, are feeling the pressure. They are selling part of their inventory in the domestic market. Marine foods like shrimp and prawn could see a significant impact as 80 to 90 percent of the production is exported, over half of which flows through the Red Sea. While sectors like textiles and chemicals may not be severely impacted as yet, a sustained disruption of trade channels could crank up working capital needs and dent operating profits for them as well as capital goods players, CRISIL has warned.

Although there is nothing new about sea piracy, Houthi pirates seem to be more politically motivated than grabbing ships just to offload goods to make money. Sea and river pirates have existed since ancient times. They attacked both passenger and cargo carriers on seas or rivers. They threatened the trading routes of ancient Greece, and seized cargoes of grains and olive oil from Roman ships. Pirates were reported to have been highly active for at least seven decades since 1650, known as the 'golden age' of piracy. The cases of piracy were down since the 19th Century, which saw the massive rise of the global naval power. Piracy still exists in some select seas such as South China Seas and

Interestingly, Houthi pirates appear to be selective about their targets. They are choosy about the targeting of vessels by the flags they fly or the origin and destination of cargoes. They don't normally touch Russian, Chinese and West Asian country vessels. So far, Indian ships have also been spared. Clearly, they are more after ships or shipments linked with countries supporting Israeli attacks, directly or indirectly, on Gaza Palestinians.

India is concerned as the Red Sea route accounts for almost 50 percent of exports, a substantial part of which are meant for EU member countries, the UK, and the USA. Almost all of these countries are against Gaza militants and have done little to force Israel to stop pounding on Gaza to massacre innocent civilians, including women and children. The matter is getting increasingly complicated as there is no sign of an Israeli withdrawal of strikes on Gaza. As a result, some of the world's most powerful nations have chosen to avoid the Red Sea rather than taking up a collective agenda to negotiate with the Houthi controlled Yemen, the second largest state on the Arabian Peninsula and a member of the United Nations. Several naval forces, including the Indian Navy, are active in the Red Sea trying to prevent Houthi pirates from grabbing cargo carriers. However, they seem to have little impact on increasingly desperate Houthi attacks on cargo vessels in the Red Sea. A global action against Yemen may probably end the situation. Unfortunately, no country wants to take a lead in the matter. (IPA

Empty-handed budget: Need for comprehensive reforms in health, education, and social sectors

nion Finance Minister Nirmala Sitharaman presented her sixth budget on February 1, where she focused on the government's wide-ranging achievements in the last 10 years. Since it is an election year the budget was not a full one, but a vote on account and did not include major announcements on the revenue or expenditure account. An interim budget, separate from the regular annual budget, is presented in an election year (2024 is an election year for the Lok Sabha).

Similar to the Union Budget, it is debated in the Lok Sabha and remains valid for the entire year (even though it is meant to serve as a transitional arrangement for about 2-4 months). Čommonly known as 'vote-on-account', it authorizes specific expenditures until the new government takes office. Article 116 allows the advance allocation of money from the 'Consolidated Fund of India' to meet immediate expenditure requirements. The government did not make any changes in the income tax slabs in the last budget of its second term. Nor are any changes being made in direct

or indirect taxes. As experts say, one should not expect too much from the election year budget.

However, if the government wanted, it could have given a list of populist cuts and benefits. Despite the fiscal deficit being estimated at 5.1 percent, the government will have to be prepared to bear the brunt of the announcements of free distribution, vaccination, and benefits to farmers, expanding the scope of Avushman Yojana, and providing free electricity. However, by not announcing MSP for farmers, the government seems to be failing to fulfill its guarantee. On the one hand, it argues that twenty-five crore people have been brought out of the poverty line, while on the other hand, it pats itself on the back for giving free rations to eighty crore people.

Overall this is an administrative tradition. In the last ten years, direct tax collections have more than tripled and the number of returns filed has increased by 2.4 times. Two crore more houses will be built in the next five years under PM Awas Yojana (Rural). Although this interim Union Budget is not very expensive. Therefore, only time will tell how much public-private partnership will be promoted to strengthen development ambitions and meet budget commitments. Both higher and school educa-

tion got increased allocation in the budget and schemes like PM School for Rising India (PM SHRI) got almost 50% more allocation than the previous budget. The total allocation for the school education department ₹73,008.10 crore which is more than the previous allocation. Critics argue that a large portion has gone into funding the PM-SHRI project which aims to upgrade existing government schools in the country and not allocate funds to enhance government schools.

A major announcement in the budget relates to health coverage extension for ASHA and Anganwadi workers under the PM-Jan Arogya Yojana. The allocation for the health sector has been increased from ₹89,155 crore to ₹ 90,658.63 crore. Experts in this field argue for the government to focus on non-communicable diseases, increase tax exemptions for preventive health care, and improve and upgrade the quality of subsidized treatments. The budget allocation for most social sector schemes and departments is more or less the same as last

vear. Allocations for school and higher education as well as health and family welfare departments show a somewhat modest increase over last year's BE, around

Although no new announcements of major schemes were made in the Budget, the Finance Minister highlighted that 25 crore people have been brought out of multidimensional poverty (MPI) in the last 10 years. Experts argue that the MPI does not tell us about trends in income poverty, which is a useful indicator of economic well-being. The further claim that "people's average real income has increased by 50%" does not tell us much about how the lives of the poor changed because what matters is the distribu-

tion of national income. Experts also argue that there has been modest growth in average rural worker income which is also reflected in poor growth in private final consumption expenditure. There has been a notable reversal in the structural transformation of employment, marked by an increase in the share of agriculture in total employment. This shows the lack of employment opportunities other than agriculture. The recent increase in

women's labor force participation rate over the past 4–5 years appears to be crisis-driven, as large numbers of women are engaged in unpaid family labor rather than gainful employment.

At the macroeconomic level, the Budget claims that in 2023-24, the central government has managed to ensure that its receipts, other than borrowings, are almost equal to the budget. It has met budgetary expectations concerning tax revenues and is also expected to grow its non-tax revenue receipts by 25% relative to the budget. There is a need to create an enabling environment for businesses to flourish, focus on environment-related issues, and upliftment of the marginalized section of society. Instead of focusing on big schemes, the government needs to focus on comprehensive reforms in the health, education, and social sec-

While these are important schemes for the poor, it does not take away from the fact that health, education, and social security budgets are grossly inadequate, even as these services suffer from poor infrastructure, huge vacancies, and inadequate

With unprecedented snowfall shortage, winter drought grips the Himalayas

iconic snow-capped peaks in the Hindu Kush Himalaya (HKH) region, usually adorned with a winter white blanket, are noticeably bare this year, especially in the western Himalayas. This abnormal winter, marked by minimal or no snowfall, has triggered concerns among farmers whose livelihoods heavily rely on agriculture. The HKH region, which is highly dependent on agriculture, faces severe consequences due to the direct impact of low snowfall.


Traditionally, snow is a vital source of sustenance in mountainous regions, providing insulation for dormant crops, supporting root growth, preventing frost penetration, and safeguarding soil from erosion. The scarcity of snowfall, exacerbated by warmer temperatures this season, is poised to have adverse ecological effects on water and agroforestry in the Himalayan region. Even if there is a substantial snowfall in the upcoming months, it might be insufficient to compensate for the existing deficit. The dwindling snow accumulation raises concerns about reduced 'runoff,' contributing to diminished water flow into rivers and streams crucial for agriculture.

Glaciers are vital in sustaining downstream water resources

Mountain communities in the HKH region already grapple with multiple challenges, including crop failure, livestock loss, fodder shortages, and the threat of disasters, leading to psychological distress. The current dry winter intensifies these challenges, following years of below-average snowpack accumulation, promising to strain water resources further in the coming spring and summer. Notable cases include Nepal's Humla District, where the high-altitude Limi Valley experienced an unusual early snowfall in September, followed by a pronounced lack of precipitation. Similarly, northern Pakistan's Central Hunza, a region typically covered in meters of snow at this time of year, has seen no snowfall in this warmer-than-usual winter.

The underlying cause of this unusual weather pattern is attributed to global heating, a vital component of the climate crisis, influencing La Niña - El Niño conditions and disrupting the critical 'Western Disturbance.' This meteorological phenomenon significantly impacts the hydrological regime of the Hindu Kush Himalaya, affecting water security for the region's in-

The observed rise in global temperatures, with 2023 recording the hottest global temperatures, further accentuates the urgency of addressing climate change. The conse- average snowpack accumulation,

Global warming can affect the ability of forests to suck carbon from atmosphere, shows study

orests are considered the most effective and abundantly available carbon sinks, capable of storing and sequestering millions of tonnes of carbon dioxide from the atmosphere. A new study from India joins emerging research that challenges this notion, showing that carbon uptake by forests is more volatile in a warming world than previously thought.

The goal to reach net-zero emissions by mid-century has popularised the idea of using forests as tools to aid climate mitigation, or carbon removal, in order to reduce global emissions. The Indian government bet on forests when it pledged to create a carbon sink capable of sequestering an additional 2.5-3 billion tonnes of carbon through forest and tree cover by 2030.

However, the study by researchers from the Indian Institute of Technology, Bombay, highlights the impacts of global warming on the forest ecosystem, suggesting that it may be affecting and reducing the carbon uptake potential of forests. Global warming could have reduced the carbon uptake potential in forests by around 6% over the last two decades, the research finds.

The findings send a "strong scientific message" that improvements in greening don't necessarily result in improvements in carbon uptake. "This analysis also has significant implications on the scientific analyses for planning to achieve net zero by 2070, as committed by India," says the paper, published in Nature in Decem-

Scientists are still trying to fully understand the effects of global warming on the ability of forests to sequester carbon. "It's still a very novel area of research, especially in India because we don't have observational data that captures these changes," says Subimal Ghosh, convener, Interdisciplinary Program in Climate Studies at the Indian Institute of Technology, Bombay, and one of the authors of the study.

The fate of forests and how they navigate a warming world is driven by multiple feedback loops with complex relationships between heat, moisture and carbon dioxide. The only way to meaningfully study how effective they are is to improve the robustness of India's greenhouse gas monitoring network, several experts told Mongabay India.

The science of carbon intake Trees are able to absorb carbon dioxide through photosynthesis, a crucial process for plant survival in which it uses carbon dioxide and water in the presence of sunlight to produce glucose and oxygen. Trees also release some carbon dioxide through respiration. Scientists measure this carbon uptake through gross primary productivity and call it net primary productivity when subtracting respiration from the rate of uptake.

Global warming can affect the way plants and forests function in a number of ways. For one, elevated levels of carbon dioxide in the atmosphere can drive photosynthesis, in a process called carbon fertilisation. But on the other hand, higher temperatures brought on by global warming can also reduce the rate of photosynthesis.

The study from IIT Bombay relied predominantly on Moderate Resolution Imaging Spectroradiometer satellite data and found that even though the Leaf Area Index – a measure of canopy cover – in India's forests went up by 6.75% between 2001-2019, its carbon uptake reduced by 6.19%, possibly due to the effects of global warming. "At higher temperatures, it is possible that the rate of photosynthesis is reduced. The other explanation is that, if there are droughtlike conditions, along with atmospheric aridity, plant productivity reduces, because there's less water available," said

The study found that the areas which experienced the greatest warming also saw the steepest declines in carbon uptake over the last two decades. Together, the Western Ghats, northeast India and the East Coast Peninsula are responsible for 32% of gross primary productivity and 34% of net primary productivity. Yet, these regions, which the paper describes as the "most biodiverse and pristine forest regions", saw the most prominent declines in carbon uptake.

According to Ruth DeFries, a professor of ecology and sustainable development at Columbia University, the results do not bode well for net-zero plans that heavily rely on forests to act as carbon sinks. "Uptake of carbon by vegetation is a critical process in the earth system, but it is a fickle and unreliable partner in the fight against climate change," she told Mongabay India over email, adding, "The promising ways forward are to re-

duce greenhouse gas emissions from fossil fuels and other sources which are the primary source of climate change and reduce deforestation and degradation so vegetation can continue to be a carbon sink as much as possible."

India's policies are aggressively geared towards afforestation and it is the second largest contributor to global greening since 2000 after China, although bulk of this greening comes from the cultivation of crops. Programmes such as the National Afforestation Programme and Green India Mission are both designed to enhance forest and tree cover, while afforestation is mandatory for project developers who are diverting forest land for their projects. One of the stated objectives is to scale up carbon sequestration

Many unknowns

Climate change is generally said to limit the carbon uptake potential of forests globally. Governments across the world have thrown their weight behind forests in the fight against climate change in the absence of large-scale carbon removal technologies. A survey of the Long Term Low Emissions Development Strategies from 41 countries found that forest and soil sinks dominated the plans of most countries. Reliance on this "creates risks for both national and global net-zero", ambitions because of instabilities in carbon sequestration and storage by forests, the survey said.

Emerging studies from Europe found that the droughts and heatwaves of 2022 negatively affected carbon uptake, and shrunk the capacity of forest carbon sinks. "Recurrent drought and heat challenges the net-zero goals of governments relying on forestry, and that forest management needs to be adapted to retain the forest carbon sink," the paper says.

Forrest Fleischman, an associate professor of environmental policy at the University of Michigan, said the results of the Indian Institute of Technology, Bombay, study "are plausible", but that in order to be more accurate, it needed more granular data as well as to take into consideration the impact of human activity on forests. "Absent data on how humans are modifying forests in India (data which doesn't really exist) it is difficult to draw out these comparisons properly,"

Another big limitation of the Indian Institute of Technology, Bombay, study is that it did not include the effects of carbon fertilisation on carbon uptake. In other words, it didn't account for the possible effect of increased photosynthesis because of more abundantly available carbon dioxide in the atmosphere. 'There are many uncertainties, and what it boils down to ultimately is that we need more and better observational data to support these projections," said Ghosh.

The study also does not project what carbon uptake will look like in the future, when global warming rises and the effects of climate change grow more pro-

Scientists at the Indian Institute of Tropical Meteorology attempted to do just this, projecting carbon uptake potential in India's forests till the year 2100, using multiple data sets and models. In the study, published in October last year, they find that even in the "most aggressive climate change projection," gross primary productivity rose till the end of the century, with the Eastern Himalayan region absorbing the most.

According to Pramit Kumar Deb Burman, a scientist with Indian Institute of Tropical Meteorology and a co-author of the paper, improved carbon uptake in a climate altered future could be due to three factors – carbon fertilisation, early blooming due to warm temperatures and because shaded leaves at the bottom receive more scattered solar radiation, becoming more productive. "We are trying to do further studies to see which of these is the primary driver in India," he said, adding, "The changes in the Indian monsoon season can also complicate the carbon uptake process, because the health of so many ecosystems depends on the monsoon.'

India lacks a robust network to measure fluxes in greenhouse gas emissions, which could support satellite data and modelled projections with actual, observed trends. Both Deb Burman and Ghosh said more concerted efforts were needed by both the government and the scientific community to improve observed data sets.

"Forests and our biodiversity is the most valuable system to absorb carbon, and we need more data not only to protect it, but so we know how vulnerable they are to climate change and the extent to which we can expect them to sequester and store carbon," said Ghosh. (Courtesy: Scroll.in)

In Jambavan's land: Sloth bears mostly coexist peacefully with humans in Karnataka; but conflict is not non-existent

arnataka, the legendary home of Jambavan, the bear king of the Hindu epic Ramayana, is also home to one of India's largest sloth bear (Melursus ursinus) populations. Bears mostly coexist peacefully with humans in the state. But human-sloth bear conflict is never far away, according to a survey by the state forest department.

The survey was conducted in Karnataka's Western Ghats, spanning 38,540 square kilometres during September 2021. Contrary to expectations, sloth bears exhibited a surprisingly harmonious coexistence with humans. Cultural acceptance in regions with high human densities favoured their presence, challenging the notion of human-wildlife conflict.

Yet, Karnataka has witnessed instances of human-sloth bear confrontations, raising concerns for both communities and wildlife enthusiasts. This is especially important, given the fact that sloth bears occupy a significant 67 per cent of potential habitat in India.

The ursids are not confined to protected areas but also extend into multi-use forests. Within the Western Ghats, nearly 61 per cent (roughly 15,000 sq km) of the forested landscape played host to these elusive creatures, with a preference for drier forests and rough terrains. Worryingly, less than 9,000 sq km of this area is designated as wildlife reserves.

"Though we have not taken up a survey in recent years, I can say that their numbers are not just stable but also showing a marginal and steady increase, and their habitat has also expanded; they are showing up in almost all terrains in Karnataka apart from the conventional scrubby and dry deciduous forest areas," Subhash Malkhed, the principal chief conservator of forests (wildlife) of Karnataka told this re-

A long relationship

For over 400 years, the sloth bear has been a tragic target of human exploitation. The nomadic tribe known as the Kalandars started 'dancing' sloth bears for emperors during the Mughal era. As kingdoms faded away, the 'dancing' bear trade transformed into cheap roadside entertainment, where villagers and



tourists paid to watch bears jump in agony. Mother bears were ruthlessly killed, and their cubs were taken for perpetuating this brutal practice. Through underground trading, as many as 200 cubs annually ended up in the hands of the Kalandars.

In 1996, research indicated more than 1200 'dancing' bears scattered throughout India. Wildlife charity Wildlife SOS embarked on a mission to rescue and rehabilitate these bears, with help from the government and others. Today, Bannerughatta National Park in Karnataka has the most active bear protection programme under the Wildlife SOS initiative.

'Sloth bears have also been demonised in many places. Rural folk say that during the collection of Mahua (A kind of wildflower that blooms only in the night), villagers used to send the elderly out in the night to collect Mahua flowers, knowing well that bears are on the prowl. This way, they disposed of their elderly and their old age problems and also collected compensation from the government. But those were archaic times; things have changed, and human-sloth bear conflicts will continue for different reasons," former principal chief conservator of forests (wildlife) BK Singh, who has travelled to bear habitats including Chhattisgarh and Madhya Pradesh, told this reporter.

Human-sloth bear confrontations in Karnataka often stem from habitat encroachment and agricultural activities, leading to accidental

"Human-sloth bear conflict is happening everywhere in bear country. Bear habitats have been fragmented due to new areas coming under farming and allied activities. This is why human-sloth bear conflicts are common," Malkhed said.

India has four sloth bear sanctuaries that are home to over 620 of these animals. Among them is the Daroji Sloth Bear Sanctuary in Karnataka. Asia's first sloth bear sanctuary is in the Ballari district of the state, spanning 82.72 sq km.

Originally the Bilikallu Reserve Forest, the government declared it as Daroji Sloth Bear Sanctuary in 1994.

Scattered around the sanctuary in the Deccan Plateau are patches of dry deciduous scrub forest and thorn forest, with a preponderance of boulders and rocks featuring cave formations. This unique landscape provides sloth bears shelter in the extremely hot weather of the region.

Sloth bear tourism has also become popular in recent years. But sloth bear tourism spots in the wild have also been cited as a reason for disturbance in the bears' habitat.

One example is the 'Sweet Lick' areas started by the forest department in Daroji to give tourists a glimpse of the bears. Department staff would smear honey around rocks, attracting bears to lick it, making slurping sounds audible from 100 metres away

After licking off the honey, the bears would crawl away, drink water from a nearby watering hole, scratch against nearby trees, and return to their day-to-day activities. This is not anymore in practice, as excessive, unnatural feeding used to affect health, says the forest officials.

The aforementioned survey stated that the key to mitigating human-sloth bear conflicts lies in community engagement and awareness programmes. It advocated for measures like enhancing habitat connectivity, minimising human-wildlife interaction zones, and implementing responsible waste management prac-

"Due to the Forest Department's extraordinary efforts, there is widespread awareness among villagers about the presence of sloth bears in their settlements, and they should be careful to protect themselves from bear attacks,' Malkhed said. (Courtesy: Down To Earth)

Senate deal on border security and Ukraine aid faces defeat as Republicans ready to block bill

Border security and Ukraine aid collapses despite Biden's plea for Congress to 'show some spine'

ate deal on border enforcement measures and Ukraine aid suffered a swift and total collapse on Tuesday as Republicans withdrew support despite President Joe Biden urging Congress to "show some spine" and stand up to Donald

Just minutes after the Democratic president's remarks at the White House, Senate Republican Leader Mitch McConnell emerged from a GOP luncheon at the Capitol and acknowledged that the deal was dead.

"It looks to me and to most of our members that we have no real chance here to make a law," the Kentucky Republican told re-

The split-screen moments in Washington represented a rapid turn of events that showed Mc-Connell's slipping control of his GOP conference, Trump's growing influence, and Biden's ability only to look on as a cornerstone of his foreign policy - halting Russian President Vladimir Putin's advance into Europe - crumbled in

Out of funds, the Pentagon is sending no more arms shipments to Kyiv just as the war - entering its third year - reaches a critical juncture. Ukraine is struggling with ammunition and personnel shortages while Russia is on the offensive, mounting relentless at-

"Every week, every month that passes without new aid to Ukraine means fewer artillery shells, fewer air defense systems, fewer tools for Ukraine to defend itself against this Russian onslaught," Biden said. "Just what Putin wants."

Biden had engaged for months with Senate leaders on a carefully negotiated plan to pair policies intended to curb illegal crossings at the U.S.-Mexico border with \$60 billion in wartime aid for Ukraine. The bill was intended to exhibit American strength around the world and would have also sent tens of billions of dollars more for Israel, other U.S. allies in Asia, the U.S. immigration system and humanitarian aid for civilians in Gaza and Ukraine.

But after Republicans rejected the compromise, the president and Senate leaders are now stranded with no clear way to advance aid for Ukraine through Congress. They have run into a wall of opposition from conservatives - led by Trump - who reject the border proposal as insufficient and criticize Jkraine funding as wasteful.

Biden laid blame for the bill's demise squarely on Trump - his likely Republican opponent in the November presidential election.

"For the last 24 hours he's done nothing, I'm told, but reach out to Republicans in the House and the Senate and threaten them and try



to intimidate them to vote against this proposal," Biden said. "It looks like they're caving. Frankly. they owe it to the American people to show some spine and do what they know to be right."

Democrats in the Capitol vented frustration at their colleagues as it became clear that the deal was

Senate Majority Leader Chuck Schumer cast on Tuesday as a "gloomy day here in the United States Senate" during a floor speech in which he scolded Republicans for backing away from the deal. He still dared them to vote against border security — an issue they have long championed.

"After months of good faith negotiations, after months of giving Republicans many of the things they asked for, Leader McConnell and the Republican conference are ready to kill the national security supplemental package even with border provisions they so fer-

Senators are still floundering for a way to get Ukraine funding through the Republican-controlled House. And after the border compromise collapsed Tuesday, some suggested jettisoning that portion from the package and advancing the aid for U.S. allies on their own.

vently demand," Schumer said.

But that idea also faces resistance in the Republican-controlled House, where House Speaker Mike Johnson is under pressure from hardline conservatives not to bring any Ukraine funding up for

When asked about wartime aid for Ukraine and Israel Tuesday, he told reporters, "We have to deal with these measures and these issues independently and separately." House Republicans on Tuesday night failed to pass a separate \$17.6 billion package of military aid for Israel. Hardline conservatives opposed the bill because the funding would not be

The lack of a national security deal will loom large over Biden's Friday meeting with German Chancellor Olaf Scholz. Biden plans to underscore to Scholz that he remains committed to providing Ukraine the funding it needs to continue to repel the nearly twovear-old Russian invasion.

McConnell said in an earlier floor speech that it was essential to assert American strength in Europe, the Middle East and Asia, yet also blamed Biden for not responding sooner to threats from rival powers. "Either we confront challenges we face with clear strategy and firm resolve or we lose," McConnell said.

But he reacted with frustration when he was later asked by reporters whether he misread his colleague's demands for border policy. "I followed the instructions of my conference, who were insisting that we tackle this in October," he said. "I mean, it's actually our side that wanted to tackle the

After Trump excoriated the compromise, however, the longtime Republican leader has not been able to convince his conference to support the proposal. (AP)

Qatar gets 'positive' response from Hamas on cease-fire plan as group reiterates its broader demands

DOHA, Feb 7: Hamas' response to the latest plan for a cease-fire in Gaza and the release of hostages was "generally positive," key mediator Qatar said on Tuesday, as the militant group reiterated its demand for an end to the war, something Israel has thus far ruled out.

Qatari Prime Minister Sheikh Mohammed bin Abdurrahman Al Thani announced the response during a news conference with U.S. Secretary of State Antony Blinken, who said he would brief Israeli leaders on it Wednesday when he meets with them.

Blinken, who met with Saudi Arabian Crown Prince Mohammed bin Salman the day before, said the Saudis still have a "strong interest" in normalizing relations with Israel but require an end to the war and a "clear, credible, time-bound path to the establishment of a Palestinian state."

Qatar, which has long mediated with Hamas, has been working with the U.S. and Egypt to broker a ceasefire that would involve a halt in fighting for several weeks and the release of the over 100 hostages still held by Hamas after its Oct. 7 cross-border raid that ignited the war.

Hamas said in a statement that it responded in a "positive spirit" to the latest proposal. But the militant group said it still seeks "a comprehensive and complete" cease-fire to end "the aggression against our people." Hamas is also expected to demand the release of a large number of Palestinian prisoners, including high-profile militants, in exchange for the

Israeli Prime Minister Benjamin Netanyahu has ruled out both demands, saying Israel is committed to continuing its offensive until "total victory" over Hamas and to returning all the hostages. He has also dismissed U.S. calls for the creation of a Palestinian state. When asked by reporters, President Joe Biden said Hamas' response "seems to be a little over the top" but that negotiations would go

A U.S. official said Blinken was told the Hamas response was delivered to Qatar just an hour before his meeting with the prime minister. The official spoke on condition of anonymity to discuss the behind-thescenes negotiations. Blinken acknowledged "there's still a lot of work to be

But he said he still believed an agreement on the hostages was possible and that a pathway to more lasting peace and security in the region was 'coming ever more sharply into focus.

"We know the immense benefits that would come for everyone concerned with Israel's further integration into the region, starting with the benefits for Israel," Blinken said. "That's something that Israelis will have to decide for themselves."

"All of this requires difficult, hard decisions, made all the more challenging given the focus on the conflict in Gaza," Blinken said. Netanyahu's office said the Hamas response had been delivered to Israel's Mossad spy agency and was being "thoroughly evaluated." (AP)

Cambodian PM Hun Manet visits Thailand with busy schedule to extend close ties

BANGKOK, Feb 7: Cambodian Prime Minister Hun Manet arrived on Wednesday in Thailand's capital on his first official visit since becoming his country's leader last year, seeking to renew the close ties the two countries have maintained in recent times.

In addition to meeting with his Thai counterpart, Srettha Thavisin, Hun Manet is slated to have a royal audience with King Maha Vajiralongkorn, preside over the signing of several documents on bilateral cooperation and address a

ness forum Hun Manet's scheduled one-day visit "is an important opportunity for both countries to further strengthen the bilateral cooperation, especially in the economic develop-

Thailand-Cambodia busi-

ment of border areas, promotion of two-way trade and investment, closer transportation connectivity, tourism cooperation as well as fostering closer ties tween the peoples of the two kingdom the Thai Foreign Ministry said in a state-

Cambodian government spokesperson Pen Bona said Hun Manet's visit would reaffirm the close relationship for peace, development and cooperation established by his father and predecessor, Hun Sen. Hun Sen stepped down as prime minister last year after 38 years in power, including periods of tensions with Thailand, especially over territorial disputes.

Human rights activists say that the coop-

eration extends to the repression of political dissidents. Several Cambodian opposition figures and other government critics who fled to Thailand to escape arrest under Hun Sen's government were recently detained in Bangkok in an apparent effort to quash possible protests against Hun Manet.

Phil Robertson, deputy Asia director of Human Rights Watch, issued a statement appealing to Thai authorities to release the detained U.N.-recognized Cambodian refugees

"and cease the crackdown on Cambodian rights and democracy activists who have fled to Thailand.' "Hun Manet is proving

to be the same kind of human rights abusing dictator that his father was, and Thailand should not cooperate with his expanding transnational repression efforts,"

Robertson said. Cambodian officials are keen to point out office on Aug. 22 last year and quickly set their relations on a positive course with congratulatory phone calls to each other. Srettha paid an official visit to Cambodia last Sep-

Cambodia and Thailand are neighboring countries with generally warm relations. Thailand's economy dwarfs that of its neighbor, which is one of Asia's poorest nations. Cambodia sends substantial numbers of laborers to Thailand to fill low-paying jobs, especially in the construction sector. (AP)

Syria says Israeli airstrikes over Homs have killed and wounded civilians

DAMASCUS, Feb 7: Israeli airstrikes over the central city of Homs and nearby areas killed and wounded civilians, the Syrian military said on Wednesday,

There was no immediate comment from Israel Syrian state news agency SANA quoted an unidentified military official as saying the strikes late Tuesday damaged both private and public property, without giving additional details. The Israeli jets reportedly struck the Syrian city and the countryside from over the Mediterranean Sea near the Lebanese coastal city of Tripoli.

The strikes come as tensions across the Middle East flare with the Israeli-Hamas war and a drone attack on Jan. 28 that killed three US troops and injured dozens more in northeastern Jordan, near the Syrian border.

The pro-government Sham FM radio station said the areas struck included the affluent al-Malaab neighbourhood and Hamra Street. It said Israel hit farmland in al-Waer, causing fires but no casualties there.

Britain-based pro-opposition war monitor the Syrian Observatory for Humanitarian Rights said at least six civilians were killed, among them a woman and a child, as well as two militants from the Lebanese Hezbollah group. The casualties were all in a building on Hamra Street that was apparently targeted in one of the strikes, it said. Search efforts were ongoing, the Observatory added. It said at least nine explosions were heard in Homs and its outskirts, where Hezbollah is reportedly present.

Israel has carried out hundreds of strikes on targets inside government-controlled parts of war-torn Syria in re-

Israel rarely acknowledges its actions in Syria, but it has said it targets bases of Iran-allied militant groups such as Hezbollah, which has sent thousands of fighters to support Syrian President Bashar Assad's forces. It has also targeted members of Iran's paramilitary Revolutionary Guard in Syria, including a high-ranking general last De-

Prince Harry arrives in London after King Charles III, is diagnosed with cancer

LONDON, Feb 7: King Charles III's cancer was caught early and the monarch will "crack on" with his constitutional duties, Britain's prime minister said on Tuesday, as Prince Harry flew in from California for a rare visit with his father.

Royal officials announced on Monday that the 75-year-old king has been diagnosed with an undisclosed form of cancer and is receiving treatment as an outpatient.

Less than 18 months into the reign that he'd famously waited decades to begin, Charles suspended public engagements but will continue with state business including weekly meetings with Prime Minister Rishi Sunak — and won't be handing over his constitutional roles as head of state.

On Tuesday afternoon, Harry could seen arriving at the king's Clarence House residence in a black SUV after an overnight flight. The two have a troubled relationship, and Harry has seen his father infrequently since the prince quit royal duties in 2020 and moved to Los Angeles with his wife, Meghan, citing what they said was the unbearable intrusions and racist attitudes of the British media. Harry, 39, has since detailed his rocky relationship with his family and his royal inheritance in TV interviews, a documentary and a memoir, "Spare."

About an hour after Harry arrived, Charles and Queen Camilla were driven from their residence to nearby Buckingham Palace in a royal Bentley. The couple waved to tourists and well-wishers gathered outside the palace gates. They then traveled by helicopter to Sandringham, the monarch's rural residence in eastern England.

Buckingham Palace said the king's cancer was found during Charles' recent hospital treatment for an enlarged prostate but is a "separate issue" and not prostate

"Thankfully, this has been



caught early," Sunak told BBC radio, adding: "We'll crack on with everything.' "Many families around the country listening to this will have been touched by the same thing and they know what it means to everyone," Sunak said. "So we'll just be willing him on and hopefully we get through this as quickly as possible." The palace said Charles, who has generally enjoyed good health, "remains wholly positive about his treatment and looks forward to returning to full public duty as soon as possible.'

Charles became king in September 2022 when his mother, Queen Elizabeth II, died at the age of 96 after 70 years on the throne.

News of the king's diagnosis comes as his daughter-in-law Kate, Princess of Wales, recovers from abdominal surgery that saw her nospitalized for about two weeks.

Kate is taking a break from royal duties as she recovers. Her husband, Prince William, who is heir to the throne, also took time off to help look after her and the couple's three children, but is due to preside over a ceremony at Windsor Castle and a charity dinner on Wednesday.

Charles departed from royal tradition with his openness about his prostate condition. For centuries Britain's royal family remained tight-lipped about health matters.

Disclosing information about his cancer diagnosis — albeit in a limited way — is another break with tradition. When U.K. monarchs had real power, news of illness was withheld for fear it might weaken their authority. (AP)

Kurt Campbell is the new US Deputy Secretary of State

WASHINGTON, Feb 7: The US Senate has overwhelmingly confirmed President Joe Biden's top Asia aide Kurt Campbell as the Deputy Secretary of State, described as someone "with deep experience to excel in this position."

Considered a veteran in the US-Asia engagement scenario, Campbell, 67, was confirmed on Tuesday by the US Senate in a clear 92-5 bipartisan vote.

"I congratulate Kurt Campbell on his confirmation to serve as our new Deputy Secretary of State and thank Toria Nuland who has been serving in an acting capacity. The Department and the nation will benefit from his diplomatic expertise and leadership at this critical time," Secretary of State Antony Blinken posted on X on Wednesday. Local media described his nomination as an effort by the Biden administration, carrying the legacy of his predecessors, to turn the US gaze towards China.

Earlier, US Senator Ben Cardin, Chair of the Senate Foreign Relations Committee, delivered remarks on the floor of the Senate in support of Campbell's nomination to be Deputy Secretary of State, according to the Senate Foreign Relations Committee website.

"Mr Campbell's distinguished career provides him with deep experience to excel in this position. It includes service in the Navy, the State Department, the Defense Department, and the private sector," said Chair Cardin.

"Mr. Campbell brings more than two decades of service in various leaderships, including as Assistant Secretary of State for East Asian and Pacific Affairs and Deputy Assistant Secretary of Defense for Asian and Pacific Affairs. He has the expertise to help navigate the Department—and our nation through complex global challenges," he said. (PTI)

BAKU, Feb 7: Azerbaijanis are voting on Wednesday in an election almost certain to give incumbent President Ilhan Aliyev another sevenvear term, following his government's swift reclaiming of a region formerly controlled by ethnic Armenian separatists.

ISLAMABAD, Feb 7: Ahead of the general elections in Pakistan on Thursday, prominent rights bodies have expressed dismay over the failure of major political parties to allocate at least five per cent of their party candidates for women on gen-

The legal requirement is set in Section 206 of the Elections Act 2017. the major statute that deals with all aspects of elections.

The Human Rights Commission of Pakistan (HRCP) in a statement on social media platform X advocated for a minimum requirement of women representation, with parties urged to take affirmative action to ensure that at least one-third of their candidates for general seats are

"In principle, this should be a minimum requirement, with parties taking affirmative action to ensure that at least a third of their candidates for general seats are women," the HRCP, an independent rights



Till now there is no consolidated data from the Election Commission of Pakistan on the total number of women candidates fielded by the political parties in the February 8 polls. The statement underscores the mportance of gender parity in political representation, emphasising that increased women's participation is essential for the development of inclusive and representative gover-

HRCP welcomed the decision of the Islamabad High Court to request an explanation from the Election Commission of Pakistan (ECP) regarding the issue.

The move reflects a step towards

hinder women's meaningful participation in politics. Aurat Foundation in a statement urged the ECP to ensure that all political parties allocate five per cent of tickets to women candidates on general seats in each of the provincial and national assemblies. Sharing serious concern about the delay in the publication of final lists of candidates by political parties, the organisation stated that compliance with Article 206 was a legal obligation for their eligibility for allocation of electoral symbols.

The foundation termed it a legal and constitutional requirement to safeguard the participation of women in electoral and political processes. "If not fulfilled, parties cannot contest elections," it added. Appreciating measures taken by

the ECP to protect women's rights, the Aurat Foundation said it expected that the commission would ensure the allocation of 5 per cent of party tickets to women. (PTI)

on September 26, 1950, signed an agreement, according to which the indigenous hill tribes of both sides living within 40 km of the border were exempted from the requirement of a passport for trade pur-

A MoU was signed in 2012 between India and Myanmar for the establishment of border haats along the international border at Pangsau Pass to facilitate trade. Accordingly, both countries established border haats for trading purposes.

Sixty-two commodities, including, food items, vegetables, utensils, cosmetics, 100 cc motorbikes and cement, were allowed for trade by both the countries which were under tax exemption, trade development officer at Nampong in Changlang district, Tangli Mossang said.

The state administration and the government of Myanmar, through a mutual understanding, had allowed border trade on 10, 20 and 30th of every month at Pangsau Pass and every Friday at Nampong, local MLA Laisam Sima said.

The border trade has been suspended after the outbreak of COVID-19 in 2020 and since then, it has not been resumed, Changlang deputy commissioner Sunny Kumar Singh said.

"It is a project that is going to be worth more than ₹ 2,500 crore if you were to include everything from road connectivity, water supply and the building infrastructure," he said

The CM said that he had recently taken a representation of the designs of the administrative city and he would soon present the same before the state cabinet.

"Once those designs are ap-

proved by the cabinet, we should be able to tender out the works after the DPRs are made by the end of the second quarter of 2024-2025," he said while adding that he is hoping within the present term, the government would be able to shift the secretariat, if not all the tive city.

He said that the idea is to bring governance and overall services to the public under one roof so that people can get all kinds of different services and all the help they require at one location.

Further, the CM informed that the government has also sanctioned ₹ 100 crore for the construction of three roads leading to the new administrative city, the foundation stones of which were laid

"The tenders are already out

and work should start in about a couple of months. We are expecting that within the next financial year, all three roads leading to the new Shillong township are ready so as to facilitate the infrastructural work for the actual secretariat," he also said.

The CM said the government is not trying to do things on a piecemeal basis.

"We have a larger and a bigger plan for the city and we are really working on a long-term, mediumterm and short-term basis to see how we can improve the overall living conditions in the city of Shillong. While we are working on that long-term and larger project which I am sure will lead to a larger development for the decongestion of Shillong city, there are small things we need to do to really improve things," he added. like substance found in waters of Manipur's Iril river

IMPHAL, Feb 7: Authorities of the Manipur government swung into action on Wednesday to investigate an oil-like black substance, which was found floating in the Iril river near Dolaithabi Barrage in Manipur's Imphal East district.

The barrage is situated on the edge of the Imphal East district bordering Kangpokpi district.

After the news went viral on social media platforms, the state public health engineering (PHE) department and Imphal East district police rushed to the spot and examined the substance

Spot examination has confirmed that the substance is soluble. Initially, there were suspicions of oil that spilled on the river.

However, the authorities collected the sample for further laboratory investigation.

The development came a month after the alleged leakage of heavy fuel from a defunct power station flowed into streams on January 10 in Kangpokpi district. The police did not delay in responding and taking up precautionary measures to prevent floating of substance downstream further on Wednesday.

A team of Sagolmang police station of Imphal East district rushed to the scene and took up necessary



steps to close the water gates of the Dolaithabi Barrage to halt any further spread of the unknown substance to the downstream of the river.

Higher authorities of the state government also dispatched a team of experts to conduct a spot investigation into the matter.

Dolaithabi Barrage is constructed in the Iril river that flows through the Imphal valley in Imphal East district. Besides being the main source of water for various water supply plants in the valley areas, the water of the river is used by the local people for domestic and agricultural purposes. (NNN)

23 Bangladeshi smugglers arrested in Tripura, 6,000 kg of sugar seized

AGARTALA, Feb 7: As many as 23 Bangladeshi smugglers have been arrested by the Border Security Force (BSF) from Samarganja in South Tripura district, an official said. The BSF troops also seized over 6,000 kg of sugar and 17 mobile phones from them, he said



"Acting on specific inregarding trans-border smuggling of sugar, troops waited at Samarganj on Tuesday apprehended 23 Bangladeshi smugglers," the BSF official said.

It appears that around 30 Bangladeshi smugglers, divided into small

groups, crossed the international border to receive a consignment of sugar from their counterparts on the Indian side.

"A total of 6,250 kg of sugar, packed in 125 bags, were recovered from them, and 17 mobile phones seized. Of the 23 arrested, 22 are residents of Feni district, while one is from Chittagong in Bangladesh," he said. An FIR was registered, and then the apprehended Bangladeshi smugglers were handed over to the police for further action, he said.

There has been a spurt in the trans-border smuggling of sugar through the Indo-Bangladesh border in Tripura in recent years, the official said. Sixteen smugglers were apprehended, while a total of 5.49 lakh kg of sugar was seized in 2023 at the Indo-Bangladesh border in Tripura, he added. (PTI)

All talk, no action, govt playing game of 'smoke and mirrors': Cong slams interim budget

NEW DELHI, Feb 7: The Congress on Wednesday accused the Centre of playing the game of "smoke-and-mirrors" with its interim budget and asked the Modi government "kiska saath aur kiska vikas" when the poor, women, youth and farmers were among the "worst performing groups" economically.

Initiating the debate on the Interim Budget 2024-25 in Lok Sabha, senior Congress leader Shashi Tharoor said the government was about "all talk and no action" and dubbed the ruling NDA as "no data available" to reveal the real situation of poverty and consumption in the country.

Taking a swipe at finance minister Nirmala Sitharaman's remarks describing GDP as governance, development and performance, Tharoor said that under the current dispensation 'G' "stands for governmental intrusion and tax terrorism, 'D' for demographic betrayal and 'P' for poverty continuing'

"This actual 'GDP' also jettisons the trinity of 'demography, democracy and diversity' that the government claims to be

"The demographic dividend is on the cusp of becoming a demographic disaster with the unemployment crisis, K-shaped growth, and the ever-widening schism between the rich and poor," Tharoor alleged.

In a scathing attack at the government, Tharoor said that in 2014 the people chose to offer a mandate to the current dispensation with the hope that this government would come through on their "bloated rhetoric" of 'Sabka Saath, Sabka Vikas



(Together will all, development for all)', the "illusory promise" of inclusive development for all Indians.

"Fast forward to 10 years later, we find the people of this country have been sadly betrayed by a government whose economic mismanagement in this past decade has left the people of India staring at widespread distress, hardship, low incomes and high unemployment," the Congress leader

Noting that the finance minister talked about four new castes poor, women, youth and farmers, the Congress leader said all four groups are some of the worst performing groups in most categories of social and economic policy performance.

"The unprecedented levels of unem-

NEW DELHI, Feb 7: Top Congress leaders from Karnataka led by Chief Minister Siddaramaiah staged a protest at Jantar Mantar here on Wednesday against the Centre over "injustice" meted out to the state in devolution of taxes.

Deputy chief minister D K Shivakumar, several MPs, ministers and MLAs from the state took part in the protest. The Congress alleges that "injustice" has been meted out to Karnataka in tax devolution and grants-in-aid over the past few years.

The protesters demanded that the Centre set right the losses to the tune of ₹ 1.87 lakh crore allegedly incurred by Karnataka under the 15th Finance Commission. Siddaramaiah said this protest is not against the BJP but the discrimination against Karnataka.

Dismissing the BJP's allegation that the protest was aimed at raking up the North-South divide, the chief minister said the Congress wants the country to be united but there should be no discrimination against the southern states.

"We are raising the issue of discrimination meted out by the government of India to the state of Karnataka and other southern states," Siddaramaiah said while addressing the protesters.

"This is why I had written a letter to all the MPs of the BJP and the JD(S) asking them to participate in this agitation," he said.

The chief minister said the formula used to devolve taxes to the states, especially Karnataka, under the 14th Finance Commission was changed by the 15th Finance Commission and called for reverting to the old formula to stop the loss of revenue for his state.

He said they would also submit a representation to the new Finance Commission for adopting the formula used by the 14th Finance Commission.

Shiyakumar said Karnataka ranks second in Goods and Services Tax (GST) collection and is the biggest contributor to the country's revenue.

"We are asking for our rights, we are asking for our share. The Karnataka government had sought drought relief funds from the Centre but not even a single rupee was given," he said.

"We are the voice of Karnataka. We demand justice," Shivakumar said.

NEW DELHI, Feb 7: Congress leader Priyanka Gandhi Vadra accused the Narendra Modi government on Wednesday of meting out injustice to the country's labourers by "weakening" the MGNREGA, as she flagged the outstanding dues to be paid by the Centre to the states under the scheme. The Congress general secretary shared on X a media report that claimed that payments under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) have not been made to labourers in Madhya Pradesh.

"The labourer should get his wages before his sweat dries'. In 'Amritkaal', this phrase has become a joke for the workers?" Gandhi said in his post on the microblog-

"According to reports, MGNREGA payments worth Rs 16.000 crore to be made to states are pending as of February 1. The labourers are facing the problem of raising children but the government does not care about it," she added. Prime Minister Narendra Modi first described the MGNREGA as a "monument of failure" of the Congress and tried to shut it down, but when he came face to face with the ground reality, he could not stop it but continuously reduced the budget, Gandhi

"This time too, they are trying to garner applause by making a minor increase, whereas the truth is that the amount allocated in the budget is equal to the revised budget of 2023-24. Experts say that only 25 days of employment can be provided in the amount that would be left after paying the dues and other expenses, whereas the MGNREGA scheme guarantees 100 days of employment," she said. The Congress government had brought the MGNREGA so that money comes into the hands of common villagers, the poor and labourers, and their households can be run, Gandhi said.

Uproar in Chhattisgarh Assembly over coal mining in Hasdeo region, Cong MLAs suspended

RAIPUR, Feb 7: Opposition Congress on Wednesday created an uproar in the Chhattisgarh Assembly over tree felling for a coal mine project in the biodiversityrich Hasdeo-Arand area, saying it will affect flora and fauna and tribals in the region and demanding discussion over it. Amid pandemonium, the proceedings had to be adjourned once and the Congress legislators, who trooped into the well of the House after the chair disallowed their demand for discussion, were also suspended. During zero hour, leader of opposition Charan Das Mahant moved an adjournment motion notice, which is meant to draw the attention of the House to a matter of public importance, on the issue.

Mahant said the state Assembly had unanimously passed a private member resolution urging the Centre to cancel all coal blocks in Hasdeo area, in the state's northern region, in July 2022 (during the previous Congress government). The government had then written to the Centre in this regard but no action was taken, he said. Surprisingly, Mahant claimed, ahead of the chief minister Vishnu Deo Sai's oath-taking ceremony in the newly elected BJP government, the principal chief conservator of forest issued an order on December 11 last year to fell 15,307 trees on 91.3 hectares of forest land for a coal mine project in Hasdeo area. If the Assembly had already passed a private member resolution cancelling mines in Hasdeo area, how such an order could be issued by the forest department, he said, demanding a discussion on the ad-

The deforestation and coal mining will have an adverse impact on the biodiversity of Hasdeo. The mining will affect Hasdeo river that flows through the area and Bango dam which helps in irrigation, while it will also trigger human-elephant conflicts, he said.

Senior Congress MLA and former chief minister Bhupesh Baghel called the matter a serious issue and said that the coal mining in Hasdeo area will not only affect flora and fauna but also the tribals living in the region. Baghel and other Congress members also sought discussion on the adjournment motion.

State's parliamentary affairs minister Brijmohan Agrawal urged the chair to reject the demand on the grounds that in the ongoing budget session, the members will get sufficient time to raise issues during budget discussion. However, Congress continued to demand for a discussion, raising slogans.

Assembly Speaker Raman Singh disallowed the discussion on the adjournment motion notice and said the members would get an opportunity to raise the issues during discussion on department-wise demand proposals for the budget. The speaker's decision led to pandemonium in the House. The ruckus prompted the speaker to adjourn the proceedings for five minutes. After the House reassembled, Bhupesh Baghel again raised the issue saying the treasury bench should admit the demand and sought discussion on the mo-

Poonam Pandey not considered govt's cervical cancer awareness campaign ambassador: Health ministry officials

NEW DELHI, Feb 7: Actor Poonam Pandey is not being considered as the brand ambassador of the government's national campaign to spread awareness on cervical cancer, Union health ministry officials said on Wednesday.

The clarification came after sources said Pandey is likely to be the face of the campaign and she and her team are in talks with ministry officials.

Earlier this month, news of Pandey's "death" from the disease dominated the headlines and led to intense debate on social media. It later turned out that the news was fake and was a stunt pulled off by the actor and her team to spread "critical awareness" about cervical cancer.

In a video, posted on her official Instagram page, Pandey on February 3 said, "I feel compelled to share something significant with you all "? I am here, alive."

"Cervical cancer didn't claim me, but tragically, it has claimed the lives of thousands of women who stemmed from a lack of knowledge on how to tackle this disease," the 32-year-old added.

"Unlike some other cancers, cervical cancer is entirely preventa-



ble. The key lies in the HPV vaccine and early detection tests. We have the means to ensure no one loses their life to this disease.

"Let's empower one another with critical awareness and ensure every woman is informed about the steps to take. Together, let's strive to put an end to the devastating impact of the disease and bring #DeathToCervicalCancer,"

Three men held for illegally entering India as they reach Mumbai from Kuwait by fishing boat

MUMBAI, Feb 7: The Mumbai police on Wednesday arrested three men, originally from Tamil Nadu, for entering India illegally using a fishing boat in which they sailed from Kuwait in a bid to escape from that country, an incident that raised concerns over potential maritime lapses.

The boat was spotted off the Mumbai coast during patrolling on Tuesday morning, a police official

In the probe conducted so far, the police found that the trio were fishermen from Tamil Nadu, who had been working in Kuwait since the last two years. Allegedly ill-treated by their agent, the trio set sail on a fishing boat of their master without permission to escape from the Gulf country and entered the Indian territory illegally, he said.

The arrested persons were identified as Infant Vijay Vinod Anthony, Sahaya Antony Anish - both aged 29 and residents of Kanyakumari- and Nidiso Dito (31) from Ramnathpuram in Tamil Nadu, the official said.

A local court here remanded them to police custody till February 10.

The incident has raised concerns over maritime security as 10 Pakistani terrorists had arrived by the sea route before launching a terror strike in the metropolis in November 2008. The 26/11 terror attacks had claimed the lives of 166 individuals and left hundreds of people injured.

"A suspicious boat was spotted by the officials of the Yellow Gate police station around 7.30 am on Tuesday when they were on patrolling duty in the Arabian Sea. The boat, which was of a different make, was found moving near the Sassoon Dock, following which the police patrolling boat went closer and found three persons aboard," the FIR Gate police station. (PTI

The three persons were neither able to speak Marathi nor Hindi. They were speaking broken English, due to which the suspicion surrounding them grew, it said.

The police patrolling team then informed the South Region control room and sought assistance, following which two police boats and another from the Navy arrived at the spot, the FIR said.

The three persons then stopped the boat. The police asked them to go along for an inquiry, but they did not start the boat, following which it was towed to the Gateway of India, the official said.

During the inquiry it came to light that the three of them were fishermen and the fishing boat in which they sailed was owned by their master Abdullah Sharahit in Kuwait, he added. The FIR said they took the fishing boat from

Kuwait without permission, crossed the international borders and entered Indian territory illegally without passports.

The boat with the trio on board was anchored at the Gateway of India on Tuesday. Prima facie, nothing suspicious was found on the boat, he said.

A case was registered against them by the Colaba police here, the official said.

'The police arrested them after filing a case under section 3 (a) with penal section 6 (a) of the Passport (Entry into India) Rules for not following the due procedures required for entering India," he

IMA writes to NMC highlighting concerns about NExT

NEW DELHI, Feb 7: The Indian Medical Association (IMA) has written to the National Medical Commission (NMC) stating that the implementation of the NExT without proper evaluation would jeopardise the affordability and accessibility of medical education and urged it to reconsider certain provisions.

The NMC has sought comments from all the stakeholders on the implementation and preparation of conducting the National Exit Test (NExT) by filling up the feedback form

The stakeholders have also been requested to go-through the NMC National Exit Test Regulations, 2023.

The doctors' body said bringing in the NExT defeats the vision of the prime minister and government of affordable and accessible medical education by seriously hampering the survival of medical institutions in underprivileged communities.

"We cannot afford to train doctors and deny degree to practise," it said. The association further pointed out that currently, uniform standards of medical education across all academic institutions do not exist and testing the entire country with one test would not be feasible.

"Using the same exam to test the basic minimum required for licensing and highest standards required for post-graduate entrance assessment is completely illogical," it said.

The IMA further stressed that the NExT cannot be conducted both as a licentiate exam and a PG entrance exam, as the focus of the licensing exam should be on assessing the minimum standard while that of the PG exam

The suggested format of an MCQ-based test will only decrease the attention and interest of students in classes and clinics and help in the mushrooming of coaching centres that are already threatening the medical education system in the country by patronising only the rich and affordable classes, it pointed out.

Developed as another home for cheetahs, Gandhi Sagar sanctuary in MP ready to welcome felines

MANDSAUR (MP), Feb 7: Madhya Pradesh, which currently hosts 21 cheetahs at the Kuno National Park (KNP), is ready to welcome a new batch of the spotted felines as the second such facility has been developed at the Gandhi Sagar Wildlife Sanctuary in Mandsaur district of the state.

This new home for cheetahs is located around 270 km from the KNP in Sheopur district.

Forest department officials said the Gandhi Sagar Wildlife Sanctuary is ready to welcome cheetahs and all preparations for the introduction of these animals have been

"This new home for cheetahs, which is spread over 64 square kilometres of area, has been developed in Gandhi Sagar Wildlife Sanctuary at a cost of ₹ 17.72 crore," Mandsaur's Divisional Forest Officer (DFO) Sanjay Raikheda

This area is protected with a

wired fence, he said. "The sanctuary is ready to welcome cheetahs and all preparations for their introduction have been



completed," he added.

Raikheda, however, said the decision on the time and other formalities regarding the settlement of cheetahs in this sanctuary will be taken by the National Tiger Conservation Authority (NTCA).

"About 25 employees and officials posted at the Gandhi Sagar Wildlife Sanctuary and the forest department have already received

training required for monitoring and taking care of cheetahs from

the KNP," the official said. A hospital is also being constructed to provide medical services to cheetahs, he said.

A team of veterinarians from the KNP is soon visiting the sanctuary to provide guidance regarding the construction of the hospital, he

Raikheda said prey is available for cheetahs in Gandhi Sagar Wildlife Sanctuary in abundance.

'There are many animals, including chitals (spotted deer), that are available in large numbers in the sanctuary," the DFO said.

A new batch of cheetahs is likely to arrive from South Africa at this sanctuary, he said.

Cheetah, the fastest land animal, was declared extinct in the country in 1952. The relocation of cheetahs from Africa is part of the government's ambitious plan to revive their population in India.

Under the Cheetah Reintroduction Project, eight Namibian cheetahs - five female and three male were released into enclosures at the KNP on September 17 in 2022. In February 2023, another batch of 12 cheetahs were brought to the park from South Africa.

Since March 2023, seven adult cheetahs and three cubs have died in the KNP due to various reasons. The total number of cheetahs at the KNP currently stands at 21 - six males, seven females and eight cubs. (PTI)

said Mizo people can't accept the present Indo-Myanmar border as it was imposed by the British during colonial period without consulting the Mizo people and fencing the border would mean accepting the colonial demarcation. Last month the MZP had written to Prime Minister Narendra Modi urging him that the Centre should reconsider its decision to fence the border.

"It (FMR) enables us to participate in each other's marriages and funerals, pay visit to patients, participate in religious meetings, and engage in local-level sports tournaments. Any decision to terminate the FMR regime will take away these essential aspects and will deprive us of our rights as human beings, much like other communities around the world," the MZP had said.

Coordinating Committee (COCOMI), a joint body of valley-based Meitei civil bodies, welcomed the decision but cautioned that no area of the state should be compromised during the process.

M Dhananjoy, assistant media coordinator of COCOMI told PTI, "Had this (border fencing) been done 30-40 years back, we would not have seen the violence we are seeing today". "Porous borders have undoubtedly led to massive smuggling of drugs threatening the lives of the youths and influx of illegal immigrants have caused enormous demographic changes threatening the indigenous population of Meiteis and state Nagas," Dhananjoy said. Manipur's Churachandpur-based United Zou Organisation, General Headquarters (UZO-GHQ) also opposed the government's plan to fence the border without taking into account the socio-historical implications and the existence of the Zou/Zo people. In a statement, UZO said, "The Zou/Zo are trans-border communities who have long lived in the former Manipur-Chin (now Indo-Myanmar) boundary regions." It asserted that without their knowledge or approval, the British colonial overlords segmented their inhabited regions and gave them to Manipur and Chin Hills, in the late 19th century. In a statement, the Kuki Chiefs' Association, Tengnoupal, expressed dismay over 'blatant' disregard of its sincere appeal against border fencing. "In the face of vehement public opposition, this brazen action signifies a stark betrayal of democratic values, as it silences the collective voice of the people, undermining the very essence of democratic principles," the association said.

Naga bodies in Manipur also said border fencing and cancellation of FMR "is not acceptable" to them. President Ng Lorho of the United Naga Council, the apex Naga body in the state, told PTI, "We are against border fencing. Whatever Union home minister said is not acceptable to the UNC."

Tangkhul Naga Long, a prominent body of Tangkhul Naga tribe in Ukhrul and Kamjong districts of the state that shares border with Myanmar, told PTI, "Our stand is very clear. We do not approve of fencing along the India-Myanmar borders and cannot be accepted".

Arunachal Pradesh chief minister Pema Khandu hailed the decision of the Centre to fence the border, saying the move will check the movement of unscrupulous elements from across the border. "A great move in the right direction to make our borders foolproof. Gratitude to Hon'ble Prime Minister Shri

There were videos posted on social media and in one video posted on X, Ali can be seen with a bloodied nose and face and blood stains on his clothes as he describes his ordeal. Ali, who moved to the US from Hyderabad about six months ago, told ABC7 Eyewitness News that one of the attackers pointed a gun at him.

Video surveillance shows Ali walking to his home at night with a packet in his hand when the three men chase him when he was punched by the men in the eye and hit on the face, ribs and back. The ABC7 report said he was taken to a local hospital where he was treated for several cuts and bruises. Ali is pursuing Masters in information technology from Indiana Wesleyan University.

"America has been my dream country and I came here to fulfil my dreams and pursue my Masters. The incident gave me trauma," he told the channel. The report said that the police do not have any suspect in custody

The Consulate General of India in Chicago said on X that the "Consulate is in touch with Syed Mazahir Ali and his wife in India Syeda Ruquiya Fatima Razvi and assured all possible assistance. The consulate has also contacted the local authorities who are investigating the case." Ali's wife Ruqiya Fatima reached out to external affairs minister S Jaishankar, requesting assistance to travel to the US along with three minor children. Last week, 19-year-old Shreyas Reddy Beniger, a student at the Lindner School of Business in Ohio State was found dead. However, local authorities have ruled out foul play.

Another Indian student, identified as Neel Acharya at Purdue University, Indiana, was confirmed dead days after being reported missing on January 28. The incident comes just days after 25-year-old Indian student Vivek Saini, who had recently earned an MBA degree in the US, was hammered to death by a homeless drug addict in Georgia state's Lithonia city on January 16.

The horrifying incident was caught on camera when assailant Julian Faulkner, a homeless man, mercilessly struck Saini nearly 50 times on the head with a hammer. Akul B Dhawan, an 18-year-old at the University of Illinois Urbana-Champaign, was found dead last month with signs of hypothermia. (PTI)

NZ beat under-strength SA by 281 runs in test cricket series opener



MOUNT MAUNGANUI (NEW **ZEALAND), Feb 7:** New Zealand beat an under-strength South Africa lineup by 281 runs on the fourth day of the first cricket test Wednesday to take an early lead in the two-match series. Captain Tim Southee declared New Zealand's second innings overnight at 179-4, with an overall lead of 528. New Zealand bowled out South Africa in the fourth innings for 247.

ting first and dismissed South Africa for 162 for a 349-run first innings lead. Southee chose not to enforce the follow-on and Kane Williamson completed his second century of the match, the 31st of his career, before the declaration.

"I think it was pretty good on a good (pitch) for the batters to set it up and the bowlers to take 20 wickets," Southee said. "We knew the South Africa side would be a strong one. You look at them in all sports, they compete, they're

Africa's hopes after lunch with a career-best 87 from 96 balls in a partnership of 105 for the fifth wicket with Keegan Petersen (16). The partnership occupied most of the middle session and while Bedingham and Petersen were together New Zealand was faced with the prospect that the test might continue into the fifth day. Bedingham had benefited from New Zealand's short-pitched bowling, hitting 13 fours and a six. But he chased a short ball once too often and fell to Kyle Jamieson not long after the tea interval. Jamieson removed both partners as South Africa slumped from 178-4 to 181-6. Bedingham tried to pull a ball which reached him sooner than he expected and his miscued shot flew to Mitchell Santner at deep midwicket.

Petersen attempted to hook a ball which bounced to chest height, tucked him up and his pull shot was taken by Rachin Ravindra at fine leg.

With such a big lead, New Zealand was able to work on plans to dismiss the key South Africa batters and, while it was expensive, the short-pitch policy eventually yielded the wicket of

Clyde Fortuin's dismissal was indicative of the bad luck South Africa has had throughout the test. He pushed a rank short ball from part-time spinner Glenn a break in play. (AP)

DUBAI, Feb 7: Jasprit Bumrah on Wednesday became the first Indian pacer to top the ICC Test rankings after a stellar performance against England in Visakhapatnam. The 30-year-old's nine-wicket match haul has helped him leapfrog Pat Cummins, Kagiso Rabada and Ravichandran Ashwin, making him only the fourth from his country to attain number one position. Ashwin, Ravindra Jadeja and Bishan Singh Bedi are the other Indians who have been at the top of the charts. Bumrah, who was named Player of the Match after helping India level the five-match series with a 106-run victory, ended Ashwin's 11-month long reign. Ashwin, on 499 Test wickets, is now third in the standings.

Bumrah now has 881 rating points with Ashwin (904) and Jadeja (899) the only India bowlers to have aggregated more rating points. Ashwin and Jadeja also have the unique distinction of being jointly top-ranked in March 2017. The batting rankings see lefthanded opener Yashasvi Jaiswal progress 37 places to 29th after completing a fine double-century in the first innings and Shubman Gill go up 14 places to a career- (PTI)

in the second innings England opener Zak Crawley is another player to gain after the Visakhapatnam Test, moving up eight places to a career-best 22nd

position after scores of 76 and 73. Rookie leg-spinner Rehan Ahmed has moved up 14 places to 70th while Tom Hartley, who became just the second England player with at least 50 runs and five wickets in each of his first two Tests, has advanced in both lists up from 103rd to 95th in the batting rankings and from 63rd to 53rd in the bowling rankings.

The latest rankings have also factored in performances in the one-off Test between Sri Lanka and Afghanistan in Colombo. Leftarm spinner Prabhath Jayasuriya has moved up to three places to a career-best sixth position after his eight-wicket match haul helped the home side win by 10 wickets.

In the ODI rankings, Australia leg-spinner Adam Zampa is up one place to third and fast bowler Sean Abbott's six wickets in the threematch series against the West Indies this past week have lifted him 35 places to joint-33rd position.

Police collecting evidence against Varun Kumar, to approach him to join probe

galuru Police probing rape charges against Indian national team Hockey player Varun Kumar said they are collecting evidence, scanning through Call detail records, messages and voice notes exchanged between him and the alleged victim as part of the ongoing investigation.

The police would soon be approaching the 28-year-old to join the probe, they said.

'We are investigating the case and are collecting the required evidence. We have not approached Kumar yet. He is out of Karnataka, so we will be contacting him soon to join the probe. We have not sent any teams to his place where he is currently undergoing training. If he comes, fine, or we will have to send our team there," a senior police officer told PTI.

"We have already started collecting evidence. We are scanthrough messages exchanged between the victim and Kumar, the voice notes, call detail records. We would also be approaching their mutual friends to record statements," he said. Kumar has been booked under the stringent POCSO act by the Bengaluru Police after a woman accused him of sexually abusing her multiple times when she was a minor. The 22-year-old, in her complaint filed on Monday, said that she came in contact with Kumar in 2018 through Instagram, and the player raped her on multiple occasions promising her of marriage when she was 17.

She said Kumar was training at the Sports Authority of India (SAI) centre in Bengaluru when

she met him. Kumar, who got the Arjuna award in 2021, was recently promoted as a DSP in Punjab Police. "Based on the complaint received from the woman, we have registered a case on Monday against the Hockey player under appropriate section of Protection of Children from Sexual Offences Act and sections 376 (rape) and 420 (cheating and dishonestly inducing delivery of property) of the Indian Penal Code," a senior Bengaluru Police officer said on Tuesday.

Kumar, who was on the Indian standby list for the Tokyo Olympics, is currently training with the national squad in Bhubaneswar for the upcoming FIH Pro League. India are scheduled to face Spain in their opening encounter on February 10. There was speculation that Kumar, part of the 2022 Commonwealth Games silver-medal winning Indian team, is on the run, but Hockey India rubbished the rumour.

Kumar, who hails from Himachal Pradesh, made his debut for India in 2017.
