# ABVP to submit memorandum to President Murmu on Sandeshkhali

KOLKATA, Feb 27: Akhil Bharatiya Vidyarthi Parishad (ABVP) on Wednesday said it will submit a memorandum to President Droupadi Murmu to draw her attention on the Sandeshkhali issue.

At a central working committee meeting in Puducherry, the Parishad passed a resolution condemning the alleged crimes against local women by Trinamool Congress leaders in the restive Sandeshkhali in North 24 Parganas district.

ABVP national secretary Saptarshi Sarkar expressed concerns that Sandeshkhali could become

"the Noakhali of the 21st century," referencing the riots in 1946. He called for public dissent against the West Bengal's government's alleged failure to address the issue. "We express dissent against the state government's failure to contain the situation and call upon the public to raise their voice against the crimes against women in Sandeshkhali," he said.

Yagyavalkya Shukla, national general secretary of ABVP, highlighted plans to engage the youth ahead of the upcoming Lok Sabha elections through a nationwide awareness campaign.

"To ensure that the youth play their role in the upcoming Lok Sabha elections, ABVP will start a nationwide awareness campaign drive to protect democracy," he added.

In response, TMC state spokesperson Kunal Ghosh acknowledged the possibility of atrocities against some local women and assured action against errant party leaders. He accused the opposition of exacerbating the situation for political gain while affirming the party's commitment to supporting the local people and women. Trinamool Con-

Goswami had previously resigned as the party's organisational in-charge of Upper Assam, citing 'various political reasons.'

In a letter addressed to K C Venugopal, the general secretary of the All India Congress Committee, Goswami stated that he was tendering his resignation as the working president of Assam Pradesh Congress Committee and as an active member of the Indian National

### Mizoram Assembly adopts resolution against Centre's decision to fence India-Myanmar border

**AIZAWL, Feb 28:** The Mizoram Assembly on Wednesday adopted a resolution opposing the Centre's decision to fence the India-Myanmar border and scrap the Free Movement Regime (FMR) with the neighbouring country.

The resolution, moved by home minister K Sapdanga, urged the Centre to reconsider its decision.

It urged the Union government to instead take steps to ensure that Zo ethnic people, "who have been divided in different countries, are unified under one administrative unit". While moving the resolution, Sapdanga said the Zo ethnic people, who have inhabited Mizoram and the Chin hills of Myanmar for centuries and once lived together under their own administration, have been geographically divided when the British occupied

He said the British demarcated

the India-Myanmar border and divided the Zo ethnic people's land into two countries.

"The Zo ethnic people can't accept the India-Myanmar border, which has been imposed on them by the British. They have been dreaming of reunification under one administrative unit someday," the home minister said.

He said fencing the India-Myanmar border or scrapping the FMR, which will mandate the approval of the imposed boundary, is unacceptable for the Zo ethnic people.

Although the Mizoram government is yet to receive official intimation about the Centre's plan, it is evident from media reports and statements of Union ministers that the Centre is planning to fence the India-Myanmar border and suspend the existing FMR with Myanmar, he said. 

## **Asian stocks lower after Wall Street** holds steady near record highs

HONG KONG, Feb 28: Asian markets were mostly lower on Wednesday after US stocks held near their record levels in a quiet day of trading. US futures and oil prices fell.

Japan's benchmark Nikkei 225 edged 0.3 per cent lower to 39,173.50.

Shares in Hong Kong and Shanghai sank after the territory's financial chief announced a budget aimed at boosting tourism and the property industry. The Hang Seng in Hong Kong slipped 1.4 per cent to 16,562.96, while the Shanghai Composite sank 1.9 per cent to 2,957.85.

China's largest private property developer, Country Garden, said Wednesday that it is facing a liquidation petition after failing to repay a term loan facility worth .6 billion Hong Kong dollars (USD 204.5 million). The first hearing in the case is scheduled for May 17.

The move comes after China Evergrande, the world's most heavily indebted real estate developer, was ordered to undergo liquidation following a failed effort to restructure USD 300 billion in late January.

Australia's SandP/ASX 200 was little changed at ,660.40 after the Australian Bureau of Statistics said Wednesday the country's inflation rate held at a twoyear low in January, triggering hopes that the Reserve Bank may cut its benchmark interest rate.

South Korea's Kospi gained 1 per cent to 2,652.29, while Thailand's SET was down 0.6 per cent.

On Tuesday, the SandP 500 added 0.2 per cent, to 5,078.18 and was just off its all-time high set last week. The Dow Jones Industrial Average dipped 0.2 per cent, to 38,972.41, and the Nasdaq composite rose 0.4 per cent to 16,035.30.

Macy's climbed 3.4 per cent after reporting better results for the latest quarter than feared. It also announced a sweeping reorganisation as it tries to kickstart growth in revenue.

Norwegian Cruise Line Holdings steamed 19.8 per cent higher for the biggest gain in the SandP 500 after

saying it's seeing healthy demand from customers. AutoZone revved 6.7 per cent higher after reporting a stronger profit than expected. Much of its growth last quarter came from its stores in Mexico and Brazil.

Zoom Video Communications climbed after topping analysts' forecasts for profit last quarter. It also announced a programme to buy back up to USD 1.5 billion of its stock, which would send cash directly to

Those winners helped offset a 1.5 per cent drop for Chevron, one of the main reasons for the Dow Jones Industrial Average's slide. The company warned that its pending takeover of Hess may be under threat.

Cryptocurrency prices have also been running higher. Bitcoin rose above USD 57,000 before edging back below the threshold and is up by roughly a third so far this year already.

New exchange-traded funds that hold bitcoin have made investing in the cryptocurrency easier, while also driving business for Coinbase and others who safeguard those ETFs' bitcoins. Coinbase rose 2.7 per cent Tuesday to bring its gain for the year so far to 14.5 per cent. Earnings reporting season is winding down for the big companies in the SandP 500, and the hope is that a remarkably solid US economy will help profits grow through this year.

A report in Tuesday morning showed orders for long-lasting manufactured goods were weaker last month than economists expected, but they were better than forecast after ignoring airplanes and other transportation items. (AP)

### Mizoram Assembly adopts

had on February 6 announced that the entire India-Myanmar border would be fenced. Two days later, on February 8, he said that the Centre has decided to scrap the India-Myanmar Free Movement Regime (FMR) to maintain the country's internal security and demographic structure of the northeastern states.

Sapdanga alleged that the recent decisions were motivated mainly by the demands of the Manipur government. The idea of fencing the India-Myanmar border and lifting the FMR, as reported in a section of media, stemmed out of some reasons, including national security, smuggling of contraband items, illegal immigration and movement of insurgents, he said. Sapdanga said national security "can't be an excuse" for fencing the India-Myanmar border and lifting the FMR.

"If the Centre is so concerned about national security, it should also fence all the international borders that the country shares with neighbouring countries," he said.

It should also abolish the mechanism India has with Nepal and Bhutan, under which people of these countries can visit each other's territory without a visa, he said. He said that even during the peak period of insurgency in the northeastern states, the FMR with Myanmar was never questioned. He said that fencing the international border and lifting the FMR will severely affect people living along the border on either side

"I urge the Centre to consider the hardships that will be faced by the Zo ethnic people if the India-Myanmar border is fenced and the FMR is scrapped," Sapdanga said. After a prolonged discussion, the assembly unanimously adopted the resolution. Chief Minister Lalduhoma and leader of the opposition, Lalchhandama Ralte of the Mizo National Front (MNF), were present.

Four Indian states -- Mizoram, Manipur, Nagaland and Arunachal Pradesh -- share a 1,643-km-long international border with Myanmar. Mizoram shares a 510-km-long border with Myanmar's Chin state and the Mizos share ethnic ties with the Chin people. Mizoram's civil society organisations and student bodies also strongly opposed the Centre's decision to fence the border and lift the FMR. (PTI)

The US has been demanding accountability in the matter. India is also seeking action against the pro-Khalistan elements involved in the July 2023 attack on the Indian consulate in San Francisco, the sources said.

The National Investigation Agency (NIA) has identified more than 50 pro-Khalistan activists who had attacked the consulate in San Francisco. New Delhi is also pushing for the extradition of 26/11 Mumbai terror attacks accused Tahawwur Hussain Rana, A US court had dismissed Rana's appeal against extradition.

The dialogue concluded with signing of the following document which will further deepen bilateral security cooperation: A Memorandum of Cooperation on law enforcement training between the US Federal Law Enforcement Training Centre and India's Sardar Vallabhbhai Patel National Police Academy. Both sides agreed to hold the next round of the senior officials' Homeland Security Dialogue in Washington D.C. at a mutually convenient date. The last India-US homeland security dialogue was last held in January 2022. (PTI)

ABU DHABI, Feb 28: Trade in services such as movement of skilled professionals accounts for over 20 per cent of the global commerce but the sector is still not getting sufficient attention in the negotiations of the WTO, according to experts and officials.

The experts also said that developed or rich member nations of the World Trade Organisation (WTO) are only interested in pushing their own non-trade agenda and not focusing on issues which really need special focus of the Geneva-based multi-lateral body.

Trade ministers and officials of the 166-member WTO are gathered here to discuss wide ranging issues such as agriculture, and fisheries subsidies.

The 13th ministerial conference (MC13) of the WTO on Wednesday entered the third day. MC is the highest decision making body of the global trade watchdog.

"There are enough issues related to trade are there to discuss in the WTO like sanitary and phytosanitary issues, technical barriers to trade and mutual recognition agreements (MRAs), but the developed nations want to push new issues," an international trade expert, who did not wish to be

named, said. Sharing similar views, an official said that there are no discussions on services trade in terms of how this can be improved. "There are no talks on that. They are not talking about MRAs, about

mobility issues, how the mobility issues will be tackled. They are not discussing the issues which are restrictive for the developing nations," the official said. Another expert said that issues

like the movement of care-givers from emerging nations to rich nations needs attention as countries like India have demographic dividend for another 25 years and the EU has demographic deficit. "But they are not willing to ac-

cept immigration or mobility rules," the official added.

Economic think tank Global Trade Research Initiative (GTRI) said that services trade account for over 20 per cent of the world trade and despite that it is mired in nontransparent domestic regulations that impede the cross-border trade.

"It receives far less attention at WTO meetings resulting in insignificant progress on critical issues of importance to developing countries. The only issue that gets priority treatment is extension of the moratorium on customs duties on electronic transmissions as it is of interest to the USA. EU and other developed countries," GTRI Founder Ajay Srivastava said.

The customs duty moratorium is

a temporary measure to prevent countries from imposing import taxes on digital products like software, music and movies. India, Indonesia. South Africa and many other countries are opposed to the extension which has been renewed every two years since 1998. "However, it is expected that ex-

tension may be agreed for another two years in the spirit of bonhomie and consensus building," Srivastava said. He added that so far there is no progress in the MC13 on a proposal of the G-90 (group of 90 nations which consists of developing countries) for enhancing existing flexibilities and exemptions for developing countries in the General Agreement on Trade in Services (GATS). "This could involve longer transition periods for implementing GATS commitments, greater flexibility in domestic regulations affecting services and technical assistance, and capacity building for developing countries," Srivastava said.

India had earlier floated a proposal on trade facilitation in services (TFS).

India's objective behind this proposal is to initiate discussions on comprehensively addressing the numerous barriers -- both at the border and behind it -- that hinder the full potential of services trade across all modes of supplies. (PTI)

# Concern on alleged conversion of educational to religious institutions: Kutumba Surakshya Parishad

GUWAHATI, Feb 28: Kutumba Surakshya Parishad president Satya Ranjan Borah said that the parishad has raised concern on the alleged conversion of educational institutions into religious institutions and that the 'movement' is not against Jesus Christ and Christianity.

Talking to The Hills Times Borah said that he had appealed to all other stake holders related to this issue so that collective and inclusive solution can be found at the earliest.

"Love for one's own mother doen't imply hate for others," he added.

Earlier, Meghalya chief minister Conrasd Sangma had told the Meghlaya assembly that the state govt would first verify the reports about the 'anti missionary campaign' in Assam before taking up the matter with Assam CM.

"I have seen the statement of the CM of Meghalaya. I welcome and appreciate his concern. If he wants I am ready to talk with him with the facts. We too want the facts to be placed in black and white for the sake of the constitution of India. This movement is not against Jesus Christ and Christianity. We are concerned about the conversion of educational institutions into religious institutions. I think Christian Missionary ruled schools are not notified and recognised religious institutions; rather, these are public schools. So, being a responsible citizen of India they too have fundamental duties to value the secularism of the nation. So, I am pleased by seeing the concern of Meghalaya CM so that we can solve the issue in a proper way. I ap-



pealed all other stake holders related to this issue so that we can find out a collective and inclusive solution early. Further, I would like to request everyone not to divert the issue from its core concerns. We don't want anyone to face difficult consequences," Borah said.

Meanwhile, the parishad has sent a letter to Assam chief secretary for alleged practice of exclusive religious practices by the Christian Missionaries by defaming the "Secular" values of Bharat and by encouraging anti-constitutional activities by ignoring the Fundamental Duties of being the Citizen of India as defined in

the Article 51 (A) of the Constitution. The Parishad in its letter wondered if

the Parishad in its letter Wondered if the dress or costume of the teachers specially the Father-Sisters of Christian Missionaries run institutions was not exclusive religious? If the installation of idol of Jesus Christ and Mother Marry and the sign of Cross in the institutions was not exclusive religious practices? The presences of churches inside the campus of educational institutions ruled by the Christian Missionaries; was not exclusive religious practices?

The letter further stated that by doing so the Christian Missionaries have al-

### **Q-mark over** democratic integrity

The recent Rajya Sabha elections across various states of India have once again highlighted the precarious state of political morality and the erosion of democratic values. The events unfolding in Himachal Pradesh, Uttar Pradesh, and Karnataka serve as stark reminders of the challenges facing the electoral process and the imperative need for political accountability. In Himachal Pradesh, the spectacle of cross-voting, with 15 seats affected, has plunged the Congress into a state of crisis, particularly endangering the stability of the Sukhvinder Singh Sukhu-led government. The brazen defiance of party whips and the alarming ease with which legislators switch allegiances underscore a troubling trend towards opportunism over principled governance. The unprecedented level of cross-voting in Himachal Pradesh, notably resulting in a tied vote eventually decided by lot, reflects a worrying departure from democratic norms. Despite possessing a comfortable majority, the Congress was blindsided by defectors within its own ranks, signalling not only a lapse in party discipline but also a betraval of public trust. The insidious tactics employed, including allegations of horse-trading and coercion, further tarnish the integrity of the electoral process. The reported involvement of central investigating agencies adds another layer of complexity to an already volatile situation, raising questions about the abuse of power for political gain.

The role of the Governor in upholding constitutional norms and ensuring the stability of state governments cannot be understated, particularly in times of

As the nation approaches the Lok Sabha elections, the onus is on every stakeholder to uphold the principles of democracy and ethical governance. Political expediency must not be allowed to trump the will of the electorate, and concerted efforts must be made to restore faith in the democratic process. The events unfolding in Himachal Pradesh and beyond serve as a sobering reminder of the fragility of democracy and the imperative need for collective action to safeguard its integrity. # Formal job generation in India hit hard in last 10 years

he latest EPFO data released last week shows that formal job generation in India has been a casualty since 2018-19 when new EPF subscribers joining the EPF were 13.94 million but had fallen to 13.85 million in the year 2022-23. During this period there were great fluctuations showing that fewer decent jobs were created in informal sector and those created belonged to low category.

If we look at the number of new members who joined and exited the EPF, it could be puzzling. In the year 2018-19 the number of workers exited from membership was 12.29 million since September 2017, while in 2022-23, this number was 13.36 million. This shows very large fluctuation in the formal job market of the country, and thereby the relatively more secure and covered under social security net were not so secure.

According to the Employees' Provident Fund Organisation's Net Payroll Data, the total number of EPF members were 13.85 million in the country while we have over 900 million people in working age population, out of whom only about 400 million are in actual jobs, which are counted as employed, and which included even those who had gotten 1 hours of paid jobs in a week. This presents a very frightening picture of the Indian job market.

In 2022-23, a total of 77570 workers of less than 18 years of age became members of EPF; workers between the age of 18-21 were 3.2 million and between 22-25 were 3.6 million. It is to be noted that every year about 20 million people enter the job market. Obviously, the new job generation in for-

mal sector is very unsatisfactory. Moreover, the members of the EPFO are increasingly dissatisfied on account of theirs not getting enough financial security both in terms of their fund settlement claims, and the family pension they get. In 2022-23, EPFO rejected 34 per cent of the claims made by the subscribers, that is one in every three. It is a very high rate of rejection which has risen sharply from only 13 per cent in 2017-18. In 2018-19, EPFO rejected 18.2% of all final settlement claims made by its subscribers. This rose to 24.1% in 2019-20, 30.8% in 2020-21 and 35.2% in 2021-22.

It is a serious matter because EPFO is the largest state-run retirement fund with around 290 million workers under the scheme of which 68 million are active subscribers. In addition to this EPFO subscribers have issues with their pension fund also. It is only recently, the Union Ministry of Finance has turned down a request to increase the monthly minimum pension under the Employees Pension Scheme (EPS) from ₹ 1000 to ₹ 2000.

The EPS is also handled under EPFO. There are only 7.55 million pensioners as per Annual Report 2022-23, which shows that only a fraction of India's workers are eligible under EPS, 3.64 per cent receiving pensions up to ₹ 1000 per month, while 1.17 million receive ₹ 1001-₹ 1500. Around

₹ 1501 and ₹ 2000 per month and only 26,769 receive more than ₹ 5000 per month. Department related Parliamentary standing committee had also found the pension amount too little.

All theses show that apart from little new formal job generation, those who are in formal job under social security covers, are actually getting too little social security cover. Employment growth has been dismal as is also evident from a recent study by D Tripati Rao of the Indian Institute of Management (IIM), Lucknow, prepared in collaboration with researchers from Birla Institute of Technology and Science, and Union Ministry of Agriculture and Farmers Welfare. It was aptly said in the paper that India's economy is witnessing a stagnating employment growth rate, weakening employment elasticity, slow structural transformation, and brewing structural problems in the country's labour market, such as low female labour force participation and rise in the unemployment

The researchers have found after analysing the NSSO employment and unemployment survey, and Periodic Labour Force Survey of the Union Ministry of Labour and Employment that the economic growth, rather than creating more jobs, has resulted in the net labour displacement. The paper published in the Indian Journal of Labour Economics, asserted that the agricultural sector, though employing most youth, contributed low value-added to the overall economy, resulting in significant employment challenges.

There is significant gender disparity in the labour market and a growing level of unemployment for highly educated youth than the less educated, the study pointed out. "In 2020-21, the total labour force in India stood at an estimated 556.1 million. Out of this total, 292.2 million (54.9%) were self-employed, 121.1 million (22.8%) were in regular employment and an estimated 118.6 million (22.3%) were in casual employment. The number of unemployed people declined from 26.4 million in 2019-20 to 24.3 million in 2020-21 in India, while an additional 119 million people were not added to the notential labour force during the same. The estimates show that self-employment has been the chief driver of the Indian job market.'

Unemployment rises with education level, the report said, adding "the unemployment rate for the illiterate and less educated class (below primary) was 0.57% and 1.13% respectively while, for the highly educated class (graduates and above), it was 14.73% in 2020-21 for the age group '15-29 years'. This pattern follows across the years." It is worth noting that the latest unemployment rate as per CMIE data for February 25, 2024 on 30 day moving average basis is 7.8 per cent, which is 2 per cent higher than the last month. The last decade proved to be the era of joblessness in India, worst in the independent India, and new job generation in both the formal and informal sector remained dismal. (IPA Service)

The overarching vision is to turn the Northeast into a thriving contributor to India's broader aspiration of a developed nation, encapsulated in the vision of Viksit Bharat.

Together, these principles serve as the foundation for a holistic and progressive approach aimed at fostering growth in the Northeast. Evaluation against these standards reveals a distinctly positive and promising conclusion – a new dawn has emerged in the Northeast.

The past decade has witnessed a remarkable improvement in the security landscape, marked by a substantial decline in insurgency incidents and casualties among civilians and pressive 86% drop in civilian deaths.

Notably, over 8,900 extremists have surrendered during this period. The overarching strategy focuses on establishing enduring peace to address persistent challenges effec-

In 2023, pivotal agreements were inked with prominent groups like the United Liberation Front of Assam (ULFA), the United National Liberation Front (UNLF), and the Dimasa Peace Accord. Nagaland and Assam have recorded growth exceeding 2.5 times (refer to the figure). # Lizards and other species are evolving with climate change, but not fast enough

limate change is threatening the survival of plants and animals around the globe as temperatures rise and habitats change.

Some species have been able to meet the challenge with rapid evolutionary adaptation and other changes in behaviour or physiology. Dark-coloured dragonflies are getting paler in order to reduce the amount of heat they absorb from the sun. Mustard plants are flowering earlier to take advantage of earlier snowmelt. Lizards are becoming more cold-tolerant to handle the extreme variability of our new climate.

However, scientific studies show that climate change is occurring much faster than species are changing.

#### What is evolutionary adaptation?

The word "adaptation" is used in many ways by climate scientists, but it has a very specific meaning to biologists: It refers to genetic changes that are passed on from one generation to the next and improve a species' ability to survive in its environment.

These genetic modifications make evolutionary adaptation different from "acclimation" or "acclimatisation," which involve advantages that are not passed on to offspring. For example, when people move to high-altitude cities, they start producing more red blood cells as they acclimate

to the low oxygen. All over the world, plants and animals have adapted to many different warm and dry habitats, prompting scientists to question whether species might also adapt to our rapidly changing climate, too. Thus far, the answer seems

#### to be no for most species. Evolving, fast and slow

A recent study of the populations of 19 bird and mammal species, including owls and deer, shows one potential barrier to

In animals that take several years to reach breeding age, the climate has already shifted by the time their offspring are born. Genes that gave the parents an advantage – like hatching at exactly the right time or growing to the best size – are no longer as beneficial for the offspring.

Populations of these slow-maturing animals are adapting to climate change, but not enough during each generation to thrive in the changing conditions. In fact, the rate of evolution is so mismatched to the rate of global warming that the study's authors estimate that nearly 70% of the local populations they studied are already vulnerable to climate-driven extinction over the coming

Small-bodied animals, such as many fish, insects and plankton, typically mature quickly. Yet, recent research on small fish and a type of fast-maturing plankton called a copepod revealed another hurdle for rapid genetic adaptation to climate change.

Many species possess genes that permit them to live in environments that are 1 to 2 degrees Celsius (about 2 to 4 Fahrenheit) warmer than today, but new genetic mutations must arise to enable survival if climates reach 4 to 5 C (about 7 to 9 F) warmer, as is possible in some regions, particularly if greenhouse gas emissions continue at a high rate.

To test species' resilience, scientists warmed populations of these fast-maturing species over many generations to observe genetic changes. They found that both the copepods and the small fish were able to adapt to the first couple degrees of warming, but populations soon went extinct above that. This was because genetic mutations that increased their ability to live in hotter conditions occurred at a slower rate than the temperatures

Cold-blooded species, such as lizards, frogs and fish, are especially vulnerable to climate change because they have a limited capacity to regulate their own body temperatures. Their ability to evolve in response to climate change is expected to be critical for their survival.

However, rapid adaptation to climate change often comes at a cost: Populations get smaller due to the deaths of individuals that cannot tolerate new, hotter temperatures. Therefore, even if species do evolve to survive with climate change, their smaller populations may still go extinct due to problems such as inbreeding, harmful new mutations or plain old bad luck, such as a disease epidemic.

In a now-classic study, re-

searchers studying lizards in Mexico discovered that the high death rates of just the heat-sensitive individuals - representing only a subset of the entire population – caused 12% of all lizard populations in Mexico to go extinct between 1975 and 2009. Even with some heat-tolerant adult lizards surviving in each population under the warmer conditions, the researchers estimated climate change would kill so many heat-sensitive adults within each population that 54% of all populations would go extinct by 2080.

#### Evolutionary adaptation isn't species' only option

Another way species adjust to rising temperatures is acclimation, sometimes called "phenotypic plasticity." For example, great tits in the UK – small birds that are common in yards and forests – lay their eggs earlier in warmer years so that their nestlings hatch right as the winter weather ends, no matter when that happens.

However, a recent analysis of more than 100 beetle, grasshopper and other insect species all over the world found that acclimation may not help those species enough. The study's authors found that the species they reviewed gained an average of only 0.1 C (about 0.2 F) greater heat tolerance when acclimating to 1 C (about 2 F) warmer air temperatures during their development. Thus, the rate of global warming seems to be outstripping species' abilities to acclimate, too.

Plants and animals could also escape the impacts of global warming by migrating to cooler habitats. A global analysis of more than 12,000 different plants and animal species recently showed that many species are migrating toward the poles fast enough to keep pace with rising temperatures, and many tropical species are moving upslope to

higher elevations as well. Nonetheless, migration has its limits. Research shows that tropical birds that already live high in the mountains could be doomed because there is no room for them to migrate any farther upward. Tropical species, therefore, may be on what the authors call an "escalator to extinction."

High-latitude and high-elevation habitats also present numerous challenges for species to overcome besides temperature. Our own research across 800 species of insects all over the Earth shows that butterflies, bees and other flying insects are especially hindered from migrating to higher elevations because there is not enough oxygen for them to

#### Many species lack obvious climate strategies

Overall, evolutionary adaptation appears to help lessen the impacts of global warming, but the evidence thus far shows that it is insufficient to overcome current rates of climate change. Acclimation and migration provide faster solutions, but research shows that those may not be

enough, either. Of course, not all evolution is driven by warming temperatures. Plant and animal species appear to be also gradually adapting to other kinds of environments, including human-created ones like cities. But the fast pace of global warming makes it one of the major threats that species must

respond to immediately. The evidence indicates that humanity cannot simply assume that plants and animals will be able to save themselves from climate change. To protect these species, humans will have to stop the activities that are fueling climate change. (Courtesy: The

# The future of urban mobility: Shared, connected, and electric

The world is in the midst of a major migration. Every week, more than 1 million people make the transition away from rural life to cities, with projections indicating that by 2050 cities will become home to approximately 7 billion inhabitants. This massive influx of people poses a significant challenge to urban mobility systems. The ability of these systems to adapt will be crucial in determining whether cities can continue to fulfil their role as the engines of economic The past holds important lessons for

the future of urban mobility. In the developed world, where a substantial portion of urbanisation has taken place, mobility has been automobile dominated and focused on personal modes of travel. For instance, the United States (US) has around 900 cars per 1000 population—almost a car per person. This reliance has come at a cost, manifesting in productivity losses caused by congestion and massive carbon emissions and air pollution. Estimates suggest that if the same trends continue, by 2050, urban dwellers could lose on average 106 hours per year stuck in traffic jams. As the next wave of urbanisation unfolds, particularly in developing nations, mobility planning must increasingly focus on a new paradigm that facilitates more efficient and sustainable movement of both people and goods.

Technology will be a major shaper of new urban mobility systems. Driven by a strong global push to decarbonise, the biggest disruption is currently the transition to electric vehicles (EVs). Yet, the contours of this transition vary across geographies. China has been the outright leader in this regard accounting for over 50 percent of all electric vehicles sales. In the developed world,

EV growth has largely been driven by people looking to replace their fossil fuel-powered personal vehicles with new electric variants. In Europe and US, electric cars accounted for 15 and 8 percent of all car sales in 2022.

However, in the emerging world, EV sales have been driven largely by the two-wheeler and three-wheeler segments. These vehicles are largely utilised by people in lower income brackets, many of whom are captive

While in the developed world, the transition to electric vehicles is predominantly driven by affluent consumers with access to diverse transportation options, in the developing world, it's

the lower-ingroups come leading the For charge. them, electric vehicles serve not just as a means of transport but as indispensable tools vital for sustaining their livelihoods.

The rise of digitalisation is also creating a new transition from private to shared urban mobility. While there are various definitions of shared mobility, fundamentally, it refers to a shift towards 'mobility as a service', where digital platforms enable the sharing of vehicles and bicycles by multiple users. This allows better utilisation of the existing vehicle stock, leading to reduced costs, congestions, and emissions.

The growth of shared mobility has been quite remarkable; between 2016 to 2019, e-hailing trips grew from 5.5 trillion to 16.5 trillion. This has also be-

with more than US\$ 100 billion invested in shared mobility companies since 2010.

In the short run, shared mobility will be people-driven. However, in the long run, the advent of autonomous vehicles is likely to add a new paradigm. Cities of the future could well be characterised by shared robo-taxis and roboshuttles with optimised routes that can reduce costs and emissions. Some estimates suggest that autonomous shared mobility services could reach over US \$400 billion by as early as 2030. However, there still remain many risks with autonomous vehicles

City governments are now actively attempting to identify a regulatory

framework that can make autonomous vehicles safe while maintaining convenience. The pace at which enabling regulations evolve will determine growth of autonomous mo-

Therefore, urban mobility in the future will be shaped by the advent of new vehicle technologies combined with increased digitalisation and automation. However, whether these technological trends are successful in shaping effective urban mobility systems will depend upon the ability of city authorities to effectively incorporate these disrupters into the broader city planning process.

In the developed world, existing cities will need to be reimagined to enable a transition from a private-vehicle dominated mobility system powered by

ways of moving people. This will necessitate creating the right regulations to grow shared mobility and for public transport to shift away from private vehicles, while also creating the right economic incentives to enable people to shift towards electric mobility.

Urban mobility in the future will be shaped by the advent of new vehicle technologies combined with increased digitalisation and automation.

However, the biggest opportunity lies in the developing world. In these geographies, the cities that will house the next few billions are yet to be built. This new wave of urbanisation will be characterised not just by mega metropolises but also smaller cities that will emerge as non-urban regions transform. Currently, cities with less than 100,000 inhabitants house a third of the world's urban population. This figure is expected to grow to 40 percent by 2050 making these medium-sized cities the fastest growing urban agglomerations.

These developing cities present a ripe opportunity for innovation, sustainable development, and inclusive growth. They offer a blank canvas for urban planners, architects, and policymakers to create environments that prioritise accessibility and quality of life for residents. However, for these cities to achieve their potential, sustainable mobility must be baked into the core planning process with the ultimate goal of meeting transport demand in a cost-effective way, without creating motorised systems that will need to be redesigned

The century of the cities is also poised to become the age of innovative mobility systems that can enhance both human well-being and environmental sustainability. However, achieving these new urban systems will require human ingenuity and planning to match the rapid pace of technological ad-

# Can behavioural changes improve and encourage waste segregation in India?

ndia faces a colossal waste management problem, which is exacerbated by poor segregation and sorting practices, especially in the country's urban parts.

Globally, the country ranks fourth in the Plastic Mismanaged Index. It generates about 1.51 lakh tonnes of municipal waste daily, yet only 47% of it undergoes proper processing.

Municipal corporations across India insist on garbage segregation that is, sorting waste into wet and dry - but they have had limited success in making this work on the ground.

Understanding behavioural patterns linked with waste segregation, and deploying nudges informed by behavioural science can go a long way in making some change.

Over the years, improper disposal has increased the volume of total waste in landfills across the country, contributing further to higher levels of short-lived climate pollutants such as methane.

The waste sector contributed to 4% of the total greenhouse gas emissions in 2018. Given the environmental and health implications, management should be urgently addressed.

#### Behavioural barriers, facilitators

Effective waste segregation can be difficult due to the confusing terminology of "dry" and 'wet". Items labelled 'wet" can be considered as dry waste and vice versa. This lack of intuitive classification complicates accurate sorting.

For instance, items labelled as "wet", like used paper napkins, might be more suitable for dry waste disposal. Conversely, seemingly dry items, like leftover food, fall under the wet waste

There is also an under-

estimation and a lack of

understanding about the immediate and long-term harmful effects of improper waste disposal. Awareness campaigns are often linked to mitigating climate change and reducing pollution. These goals can be perceived as distant or irrelevant where lower importance is assigned to future out-

Inconsistency among family members in segregating waste further complicates matters. Some family members properly dispose of waste, while others do not. Ingrained habits and status quo bias pose challenges, as it can be difficult to break established patterns and adopt new habits.

The resistance to waste segregation is fuelled by the perception that it is a high-effort activity with an unclear payoff, coupled with the belief that municipal workers and not households themselves are responsible.

The idea that waste segregation demands sibly requiring higher salaries for domestic workers, adds to this resistance. Smaller quantities of waste generated by households can also lead to a dismissive attitude.

The absence of convenient waste segregation facilities, like easily accessible bins and flexible waste collection schedules, intensifies the perdifficulty. ceived Navigating these complexities requires a combination of system-level support and behavioural interventions.

#### Making structural changes

At the macro-level, clear communication from sanitation authorities is vital to ensure that people understand and follow guidelines, emphasising the importance of proper waste disposal and the consequences of non-compliance.

Adequate financial support for cleaning staff at the local level is necessary to maintain an efficient waste management system.

Increasing awareness among sanitation workers about segregation is equally crucial to enhance their communication and ensure adherence to segregation practices. Infrastructure improvements, such as the availability of separate bins and recycling facilities, must also be made to facilitate successful segregation.

Coordination and instructions from resident welfare associations can bring about community efforts, ensuring that everyone is aligned towards the same goal.

Government mandates, penalties for non-compliance and awareness campaigns can play a pivotal role in encouraging public participation by creating a sense responsibility and understanding the collective impact on the environment and climate.

#### Behavioural change interventions Behavioural change at

the level of household and individuals, requires different strategies to overcome existing barriers and facilitators. To begin with, there should be intuitive language with clear and descriptive like "organic terms waste", "kitchen and garwaste", den "compostable" for wet waste and "recyclables" for dry waste. This reduces the cognitive load at the time

of disposal. In awareness campaigns, the emphasis should be on connecting segregation practice to personal and immediate goals - for example, disease reduction, greener neighbourhoods, safety of stray animals, local pride, instant compost for residents - compared to long term or intangible ones, such as climate change and recycling.

campaigns should also highlight the impact of non-segregation on the lives of sanitation workers to instil a sense of accountability

and responsibility. At the community level, recruiting "waste champions" to lead efforts within neighbourhoods can help motivate citizens to contribute to better waste management. They can help oreducational ganise programmes for children, neighbourhood clean-up events, thus fostering shared responsibility.

New social norms could also be brought about by using WhatsApp groups to share simplified information on segregation: thumb rules on what goes in which bins, especially when it comes to difficult items such as paper napkins, dry dals, take away packaging, dry flowers and the like while also creating peer pressure for compliance.

# Water every other day: Bengaluru is drying up and destruction of lakes is the reason

The gardens of Bengaluru, also known as 'garden city', may soon wilt while its citizens wait for water to trickle out of taps. The city is facing the worst domestic water crisis in

Over 30 localities inside the Bruhat Bengaluru Mahanagara Palike (BBMP) will receive water on a rotational basis every alternate day, the residents have been informed. That means, each locality will have to manage without water supply for 24 hours at least. And even on the days a locality does receive water; it won't be for longer than 30-45 minutes. This is particularly concerning as summer has already arrived in the city, and there are at least 75-90 days of peak summer ahead.

While narratives and theories doing the rounds indicate many things, including the alleged highhandedness of the water tanker lobby in the city, scientists point out the phenomenal neglect of the city's water bodies and the total absence of conservation. The city, up until 1961, had 262 lakes.

and the last count taken by the city's environmentalists indicates that there are only 81 left. The rest have been claimed by the real estate business for making housing layouts; the Bengaluru Development Authority and BBMP have been held responsible for levelling over 100 lakes directly and indirectly.

Out of the 81 lakes that are identified as 'as lakes,' only 33 are living just because they are located in zones where land cannot be reclaimed for any activi-

The Dharmambudhi Lake, developed by the rulers of Bengaluru, the Hoysalas, Wodeyars and Kempegowda, for more than 500 years of known history, was the first to go in as early as 1969. It was filled up to hold consumer fairs organised by a political party. Later, it became the Kempegowda interstate bus terminus.

These lakes perished mainly due to real estate development, mining and infrastructure. However, due to the whistleblowers of the city, some of the lakes were saved, including Nagavara, Halasuru and Hebbal, the largest among the 32 lakes classified as 'living lakes'.

The city is now dependent only on the augmented water source at the Krishna Raja Sagara (KRS) reservoir in Srirangapatna, built across River Cauvery, which about 125 kilometres from the city. However, due to a lax southwestern monsoon in 2023, the Cauvery catchment area did not get enough rain and, consequently, the KRS reservoir got only 75 per cent of its usual inflow.

Even as the citizens are holding demonstrations, the tanker water prices have plummeted to Rs 2,000 for a 12,000 litre tanker, which was just Rs 800-1.000 a fortnight ago. "We have a hunch that the government is playing a big game with us. First, the politicians will make deals with the tanker lobbyists and then direct the Bangalore Water Supply and Sewerage Board officials to tune down the water availability to nil for days together so that they approach the tanker business owners. We have spent lakhs of rupees on the water in the last three months ever since our taps ran dry in November," said Hanumanthappa, the resident association leader of Jaimaruthi Nagar extension in Bengaluru South.

Dasarahalli and Rajarajeshwari Nagar zones in North Bengaluru are the worst affected. "Even though all six stages of the Cauvery pipeline corridor pass through our area just across the Bengaluru Mysuru Infrastructure Corridor, still our areas do not get water regularly. In the far end of Rajarajeshwari Nagar, tap water supply stopped in November 2023 and all dug wells and borewells have also gone dry. We are entirely dependent on the tanker water services,' said resident association office bearer Ra-

machandrappa. Bengauru is located at 920 metres above sea level, directing the natural flow of water away from the city and into surrounding valleys. The city receives an average of 920 millimetres of rainfall spread over 60 rainy days annually, nourishing two river basins, the Cauvery and Dakshina Pinakini.

With over 200 lakes and tanks, Bengaluru's landscape faces the challenge of diminishing open wells, urging the need for preservation efforts. Moreover, the proliferation of private borewells, estimated at over 400,000, underscores the critical importance of water management in Bengaluru.

In Bengaluru, the city's lakes rely solely on rainwater and surface runoff from their catchment areas, which are the regions where water collects and flows into the lakes. These lakes are interconnected through a network of stormwater drains called kaluves, which transport excess water from higher to lower-elevation lakes, effectively managing floods and conserving water.

Bengaluru boasts of six lake series, including Yellamallappa Chetty, Varthur, Madavara, Byramangala, Puttenahalli and Hulimavu.

Most lakes in Bengaluru are primarily fed by stormwater through their inlets, but they also receive sewage from leaky pipes and streets. To control water levels, overflow weirs or culverts known as kodis are used, while human-made lakes are equipped with bunds or ridges, to create reservoirs.

Many non-governmental organisations (NGO) working on improving water conservation have opined that community involvement is pivotal in preserving Bangalore's lakes. Examples like Puttenahalli and Kaikondrahalli lakes showcase how urban and traditional communities collaborate with government agencies, forming trusts authorised to maintain these lakes. Organisations like Friends of Lakes Bangalore or One Bengaluru for Lakes facilitate citizen engagement in lake conservation efforts, offering support from awareness campaigns to liaising with authorities. Individuals can contribute to lake restoration efforts by organising events like Kere Habba", featuring activities for children, organic food stalls and environmental NGOs discussing water issues, birdwatching, competitions and lake

Regular community activities such as cleaning, gardening and tree planting are encouraged, each lasting no more than an hour, according to locals. (Courtesy: Down To Earth

**DUBAI, Feb 28:** Iran is holding parliamentary elections this Friday, yet the real question may not be who gets elected but how many people actually turn out to vote. Widespread discontent over the cratering economy, years of mass protests rocking the country, and tensions with the West over Tehran's nuclear programme and Iran's support for Russia in its war on Ukraine have many people quietly saying they won't vote in this

Officials have urged people to cast ballots but tellingly, no information has been released this year from the state-owned polling centre ISPA about expected turnout a constant feature of past elections.

Of 21 Iranians interviewed recently by The Associated Press, only five said they would vote. Thirteen said they won't and three said they were undecided.

"If I protest about some shortcoming, many police and security agents will try to stop me," said Amin, a 21-year-old university student who gave only his first name for fear of reprisals. "But if I die from hunger on the corner of one of the main streets, they will show

Over 15,000 candidates are vying for a seat in the 290-member parliament, formally known as the Islamic Consultative Assembly. Terms runs for four years and five seats are reserved for Iran's reli-

gious minorities. Under the law, the parliament has oversight over the executive branch, votes on treaties and handles other issues. In practice, absolute power in Iran rests with its

Hard-liners have controlled the parliament for the past two decades — with chants of "Death to America" often heard from the

supreme leader, Ayatollah Ali

Under parliament speaker Mohammad Bagher Qalibaf, a former Revolutionary Guard general who supported a violent crackdown on Iranian university students in 1999, the legislature pushed forward a bill in 2020 that greatly curtailed nuclear watchdog, the International Atomic Energy Agency. # Trump defeats Indian-American Nikki Haley in Michigan primary, Biden wins Democratic primary

dent Joe Biden and former president Donald Trump won their respective parties' Michigan's presidential primaries on Tuesday, and the two candidates continue marching toward a likely rematch in the November 2024 race for the White House.

Trump easily defeated his main rival, Indian-American Nikki Haley, winning yet another early contest and additional delegates — bringing him one step closer to being able to formally secure the Republican Party's nomination.

When last reports came in, Haley had received 28.9 per cent of the votes as against Trump's 66.4 per cent. The New York Times projected that 77year-old Trump would sweep the Michigan primary with more than 40 per cent of the votes against 52-year-old Haley.

Biden thanked every Michigander who made their voice heard. "I want to thank every Michigander who made their voice heard today. Exercising the right to vote and participating in our democracy is what makes America great," Biden said in a statement

"Four years ago, it was Michigan's diverse coalition that came together to reject Donald Trump's MAGA extremism and sent me and Kamala to the White House. Because of Michiganders, we've been able to work hand in hand with Governor Whitmer and the incredible Democratic leaders in Michigan's congressional delegation to deliver enormous progress...," he said.

However, a key feature of the Democratic primary in Michigan, which has a significant Muslim cratic voters cast ballots for the "uncommitted" as part of their protest against the 81-year-old president for his handling of the Israel-Palestine war.

"Joe Biden is losing about 20 per cent of the Democratic vote today, and many say it's a sign of his weakness in November. Donald Trump is losing about 35 per cent of the vote. That's a flashing warning sign for Trump in November. Since Trump became president in 2016, he lost Michigan Republicans the state House, state Senate, and Governor's mansion.

What was once a beacon for the conservative cause, the Michigan Republican Party is now fractured and divided," Nikki Haley for President campaign's national spokesperson, Olivia Perez-Cubas, said in a statement after the results came out.

"Let this serve as another warning sign that what has happened in Michigan will continue to play out across the country. So as long as Donald Trump is at the top of the ticket, Republicans will keep losing to the socialist left. Our children deserve better," Perez-Cubas said.

In New Hampshire and South Carolina, Haley got about 40 per cent of the votes. Next Tuesday primaries will be held in 21 States. Given the current trend, Trump is expected to emerge as the presumptive nominee of the Republican party by March 2. This will result in a rematch of the 2020 elections: Biden vs Trump.

However, according to The Washington Post, both Trump and Biden are facing internal chal-



"Trump continues to face a faction of Republicans who refuse to back his candidacy despite his chokehold on the nomination. Biden was confronted with a protest movement urging Democrats to vote "uncommitted" in the primary over his handling of the Israel-Hamas war. Early returns showed that "uncommitted" was poised to easily garner more than 10 per cent of the vote statewide," the Politico reported.

While for Biden, the main political threat has come from progressives and like-minded voters, for Trump, the threats have been both political and

"His unbroken swing of early state victories has given him a commanding position in Republican politics. But he remains embroiled in court cases stemming from his business practices and his time

Earlier in the day, the Haley campaign said that

"She's in Michigan today and heading to Super Tuesday states across the country over the next week. We must get it right this election!" said the campaign

In an interview with CNN, Haley said that she

has concerns about both Biden and Trump. "I have serious concerns about Donald Trump. I have even more concerns about Joe Biden. But I don't think either one should be president, and that's why I'm running. And so I'm going to continue to run as long as Americans say they want a choice, as long as Americans say they want someone to vote for. I'm going to continue to do that," she said.

"And what a blessing it is in America that we can. This is not Russia where you've got a dictator that goes and kills his political opponents. This is America where people can have their voices heard. This is America where you can go and be anything you want to be without anyone getting in the way. This is America that was built on faith, family, and country," Haley told CNN.

"That's what I'm trying to do is get us to remember our purpose, get us to remember who we are as Americans in the first place. Not a divided country, not a divided party, not a country sitting in anger, but one sitting in hope and energy and saying that we're going to do this for our kids. That's what I'm going to keep fighting for. I'm not going to think about what's going to happen 10 days, two months, three months from now," she said in response to a question. (PTI)

## SKorean and US troops will begin major exercises next week in response to NKorean threats



SEOUL, Feb 28: South Korean and US troops will begin their expanded annual military drills next week in response to North Korea's evolving nuclear threats, the two countries said on Wednesday, a move that will likely enrage North Korea because it views its rivals' joint training as an invasion rehearsal.

In recent months, North Korea has inflamed animosities on the Korean Peninsula with fiery rhetoric and continued missile tests.

While it's unlikely for North Korea to launch full-blown attacks against South Korea and the US, observers say the North could still stage limited provocations along the tense border with

On Wednesday, the South Korea and US militaries jointly announced that the allies will conduct the Freedom Shield exercise, a computer-simulated command post training, and a variety of separate field training, from March

Col. Lee, Sung-Jun, a spokesperson for South Korea's Joint Chiefs of Staff, said that the allies' drills are designed to bolster their joint capabilities to prevent North Korea from using its nu-

He said the allies are to carry out 48 field exercises this spring, twice the number conducted last year, and that this year's drills would involve air assault, live-firing and bombing training.

"Our military is ready to punish North Korea immediately, strongly and to the end in the event of its provocation, and we'll further strengthen our firm readiness through the upcoming drills,'

North Korea didn't immediately respond to the drills' announcement. North Korea has reacted to previous major South Korea-US military drills with its own missile tests.

North Korea has sharply intensified its weapons testing activities since 2022 in part of its efforts to expand its nuclear and missile arsenals. This year, the North already conducted six rounds of missile tests — five of them reportedly involving cruise missiles — and other weapons launches.

Experts say North Korea believes a bigger weapons arsenal would allow it to pressure the US and South Korea more effectively to make concessions like sanctions relief when diplomacy resumes. They expect North Korea to ramp up its testing activities and other provocations this year as both the US and South Korea head into major elections.

South Korea and the US have responded to the North's testing spree with expansions of their bilateral military drills and trilateral exercises involving Japan. US and South Korean officials have repeatedly warned that any nuclear attack by North Korea against them would spell the end of the North's government led by Kim Jong

### Rocket fire reported off Yemen in Red Sea in a new suspected attack by Houthi rebels

DUBAI, Feb 28: A rocket exploded late on Tuesday night off the side of a ship traveling through the Red Sea off the coast of Yemen, authorities said, the latest suspected attack to be carried out by Yemen's Houthi

The attack comes as the Houthis continue a series of assaults at sea over Israel's war on Hamas in the Gaza Strip and as the U.S. and its allies launch airstrikes trying to stop them.

The British military's United Kingdom Maritime Trade Operations center, which oversees shipping in the Mideast, reported the attack happened about 110 kilometers (70 miles) off the coast of the Houthi-held port city of Hodeida. The rocket exploded several miles off the bow of the vessel, it said.

"The crew and vessel are reported to be safe and are proceeding to next port of call," the UKMTO said

The private security firm Ambrey reported that the vessel targeted appeared to be a Marshall Islands-flagged, Greek-owned bulk carrier in the area at the time. Another ship, a Panamaflagged, Emirati-owned chemical tanker was nearby as well, Ambrey said.

The Associated Press could not immediately identify the ves-

sels involved. The Houthis typically take several hours to claim their assaults and have not yet done so for the assault late Tuesday

Since November, the rebels have repeatedly targeted ships in the Red Sea and surrounding waters over the Israel-Hamas war. Those vessels have included at least one with cargo for Iran, the Houthis' main benefactor, and an aid ship later bound for Houthicontrolled territory.

Despite over a month of U.S.led airstrikes, Houthi rebels remain capable of launching significant attacks. Last week, they severely damaged a ship in a crucial strait and downed an American drone worth tens of millions of dollars. The Houthis insist their attacks will continue until Israel stops its combat operations in the Gaza Strip, which have enraged the wider Arab world and seen the Houthis gain

international recognition. The Houthis, a Zaydi Shiite group, seized Yemen's capital in 2014 and have battled a Saudiled coalition since 2015. Their Zaydi people ran a 1,000-year kingdom in Yemen up until 1962. (AP)

### Germany and Poland say they're not sending troops to Ukraine as the Kremlin warns of a wider war

BRUSSELS, Feb 28: European military heavyweights Germany and Poland affirmed on Tuesday that they would not be sending troops to Ukraine, after reports that some Western countries may be considering doing so as the war with Russia enters its third year.

The head of NATO also said the U.S.-led military alliance has no plans to send troops to Ukraine, after other central European leaders confirmed that they too would not be providing soldiers.

The Kremlin, meanwhile, warned that a direct conflict between NATO and Russia would be inevitable if the alliance sends combat troops. "In this case, we need to talk not about probability, but about the inevitability (of conflict)," Kremlin spokesman Dmitry Peskov told reporters.

Moscow's warning came a day after French President Emmanuel Macron said that sending in Western ground troops should not be "ruled out" in the future, after hosting a conference of top officials from more than 20 of Ukraine's Western backers. German Chancellor Olaf Scholz appeared to have a different view of what happened in Paris. He said the participants had agreed "that there will be no ground troops, no soldiers on Ukrainian soil who are sent there

Scholz said there was also consensus "that soldiers operating in our countries also are not participating actively in the war

With Macron increasingly looking iso-

lated and opposition politicians in France has said his government is not planning to furiously critical of his suggestion that propose a deployment, but that some counground troops might be considered, the French president's government subsequently sought Tuesday to clarify his com-

French Defense Minister Sébastien Lecornu said there had been discussions but no consensus at the conference about carrying out de-mining and military training operations in Ukraine, away from the front

"It's not sending troops to wage war against Russia," the minister said.

The idea of sending troops has been taboo, particularly as NATO seeks to avoid being dragged into a wider war with nuclear-armed Russia. Nothing prevents NATO members from joining such an undertaking individually or in groups, but the organization itself would only get involved if all 31 members agree.

Secretary-General Stoltenberg told The Associated Press that "NATO allies are providing unprecedented support to Ukraine. We have done that since 2014 and stepped up after the full-scale invasion. But there are no plans for NATO combat troops on the ground in Ukraine."

At a meeting in Prague on Tuesday, Polish Prime Minister Donald Tusk said, "Poland does not plan to send its troops to Ukraine." Prime Minister Petr Fiala of the Czech Republic insisted that his country "certainly doesn't want to send its soldiers." Slovakian Prime Minister Robert Fico

tries were weighing whether to strike bilateral deals to provide troops to help Ukraine fend off the Russian invasion.

Fico did not provide details about which countries or what the troops would do in Ukraine. Macron, too, avoided naming any countries, saying he wanted to maintain "strategic ambiguity" and not tip the West's hand to Russia. NATO as an alliance provides Ukraine

only non-lethal aid and support like medical supplies, uniforms and winter equipment, but some members send weapons and ammunition of their own accord, bilaterally or in groups. A decision to send troops and keep them

deployed long term would require the kind of transport and logistics capabilities that only countries like the U.S., U.K., France, Germany and possibly Italy, Poland or Spain could muster. While ruling out NATO military action,

Stoltenberg told the AP "that this is a war of aggression by Russia against Ukraine, blatantly violating international law. According to international law, Ukraine of course has the right to self-defense, and we have the right to support them in upholding that right."

The conference in Paris was held just after France, Germany and the U.K. each signed 10-year bilateral security agreements with Ukraine as its government works to shore up Western support. (AP)

# A bus accident in southern Mali has left at least 31 people dead

BAMAKO, Feb 28: At least 31 people were killed and 10 others injured when a driver lost control of a passenger bus in southern Mali on Tuesday, the country's government announced.

The bus carrying Malians and nationals from the West African subregion was en route to Burkina Faso when it "overturned," said a statement posted on Mali's Ministry of Transport and Infrastructure's Facebook

"The provisional toll is 31 killed on the spot and 10 injured, some of them seriously," the statement said. The accident around 5 p.m. local time in Koumantou south of Bamako.

Accidents involving public transport buses are a frequent occurrence in Mali. On Feb. 19, at least 15 people died and more than 46 were injured in a traffic accident between a public transport bus and a lorry in central Mali. (AP)

# A small drone flies into a damaged Fukushima reactor for the first time to study its melted fuel

TOKYO, Feb 28: A drone small enough to fit in one's hand flew inside one of the damaged reactors at the wrecked Fukushima Daiichi nuclear power plant on Wednesday in hopes it can examine some of the molten fuel debris in areas where

earlier robots failed to reach. Tokyo Electric Power Company Holdings also began releasing the fourth batch of the plant's treated and diluted radioactive wastewater into the sea on

Wednesday. The government and TEPCO, the plant's operator, say the water is safe and the process is being monitored by the International Atomic Energy Agency, but the discharges have faced strong opposition by fishing groups, as well as a Chinese ban on Japanese seafood.

A magnitude 9.0 quake and tsunami in March 2011 destroyed the plant's power supply and cooling systems, causing three reactors to melt down. The government and TEPCO plan to remove the massive amount of fatally radioactive melted nuclear fuel that remains inside each reactor — a daunting decommissioning process that's already been delayed for years and mired by technical hurdles and a lack of data

To help fill in that data, a fleet of four drones were set to fly one at a time into the hardest-hit No. 1 reactor's primary containment

TEPCO has sent a number of probes — including a crawling robot and an underwater vehicle — inside each of the three reactors, but got hindered by debris,

high radiation and inability to navigate them through the rubble, though they were able to gather some data in recent years. In 2015, the first robot to go

inside the reactor got stuck on a grate. Some helpful information came from the mission, but the crawling robot had to be aban-Wednesday's drone flight

comes after months of preparations and training that began in July at a nearby mockup facility outside of the plant. The drones, each weighing

only 185 grams, are highly maneuverable and the blades hardly stir up dust, making it a popular model for factory safety checks. It's nearly a square of about 18 centimetres on both sides, 5 centimetres thick, and carries a front-loaded high definition



camera to send live video and a higher-quality images to an operating room

In part due to battery life, the drone investigation inside of the reactor is limited to a 5-minute flight each.

TEPCO officials said they plan to use the new data to develop technology for future probes as well as a process to remove the melted fuel from the reactor in the coming years. The data will also be used in the investigation of how exactly the 2011 meltdown occurred.

First, two drones were to inspect the area around the exterior of the main structural support in the vessel, called the pedestal, before deciding if the other two could be sent inside to the area previous probes could not reach.

The pedestal is directly under the reactor's core. Officials hope to film the core's bottom to find out how overheated fuel dripped there in 2011.

About 880 tons of highly radioactive melted nuclear fuel remain inside the three damaged reactors. Critics say the 30- to 40-year cleanup target set by the government and TEPCO for Fukushima Daiichi is overly optimistic. The damage in each reactor is different, and plans need to be formed to accommodate their conditions. TEPCO's goal is to remove a

small amount of melted debris from the least-damaged No. 2 reactor as a test case by the end of March by using a giant robotic arm, but was forced to delay due to difficulty removing a deposit blocking its entry. That monthslong postponement comes in addition to its already nearly two-year delay, underscoring the difficulty and uncertainty of the decommissioning process. (AP)

# Mizoram govt not to increase power tariff in next 5 years



AIZWAL, Feb 28: The Zoram People's Movement (ZPM) government in Mizoram will not increase power tariffs during the next five years, the state assembly was informed on Wednesday.

State power minister F Rodingliana said the government is making efforts to augment power generation in the state.

"During the five years of the present government, there is no plan to change power tariff for onsumers," the minister said.

The ZPM came to power in the state in December last year. The minister said that Mizo-

ram now has 15 small hydroelectric projects that together generate 38.55 MW of power.

He also said that power generation fluctuates depending on the weather.

Mizoram spends ₹ 33-37 crore month for purchasing power from outside as the northeastern state requires 156 MW of power during peak hours.

Three hydel electric projects with a total generation capacity of 294 MW and four solar power plants, which can produce 45 MW of power, are in the pipeline.

**DIMAPUR, Feb 28:** A workshop on the uses and benefits of solarbased storages for the remote areas of Nagaland was organized by the North Eastern Regional Agricultural Marketing Corporation Limited under the DoNER ministry with support from the Nagaland directorate of horticulture in Kohima.

### 219 people killed in Manipur violence: Guv Anusuiya Uikey

IMPHAL, Feb 28: Manipur Governor Anusuiya Uikey on Wednesday said that 219 people have been killed in ethnic violence in the state since May last year.

Addressing the Manipur Assembly during the commencement of the budget session, she said that 198 companies of central armed police forces and 140 army columns have been deployed along with state forces to maintain law and order in the northeastern state.

She condoled the deaths of 219 people in the ethnic strife and said that an ex-gratia amount of Rs 10 lakh each is being disbursed to the next of kin of the deceased after due verification. The mortal remains of the victims have been handed over to their kin and their last rites have been performed, Uikey said.

The Governor exuded confidence that all stakeholders and people in general will contribute towards the restoration of peaceful coexistence and brotherhood among various communities of the state.

"Manipur has always been and will continue to be a multi-cultural state that respects the diverse identities of the state. The government believes in taking all the people along, irrespective of their identity, in its path of development," she

"The state government has been working tirelessly under challenging circumstances to address various complex issues related to the present law and order situation following the violence that started on May 3, 2023," she said. "Within the first few days (of the

violence), evacuation of stranded people on both sides of the conflict was taken up on a war footing. Manipur State Transport Services transported over 4,000 students and stranded civilians to safer places," the governor said.

She said that pre-fabricated

houses have been built for displaced

people living in relief camps and the

government has also formulated a scheme for the construction and repair of permanent houses that were damaged during the violence.

"Basic analysis of damage assess ment has been completed," she said. The Governor said that students staying in relief camps have been linked to nearby schools.

She said that a commission of inquiry chaired by a former chief justice of the high court was constituted by the Centre to investigate the facts that led to the genesis of the present situation.

A peace committee has also been constituted to help establish peace and harmony among various ethnic groups, Uikey said.

"The government is leaving no stone unturned to ensure that justice is delivered to our sisters both in the hills and the valley, who were victims of sexual violence," she said.

Uikey said that the government has handed over 29 cases to the Central Bureau of Investigation (CBI) and one to the National Investigation Agency (NIA) for independent and transparent probe.

She said that a peace agreement has been signed with the militant outfit United National Liberation Front (UNLF), "which is anticipated to usher in a new era of peace", and encouraged other armed groups to participate in the peace process. On the Centre's move to scrap the Free Movement Regime (FMR) with neighbouring Myanmar, she said the decision was taken keeping in mind India's internal security and demographic structure of the northeastern states.

Later, the House condoled the deaths of former Governor P B Acharya, former secretary of Manipur assembly, Ningthoujam Hera Singh, and 10 former members, and observed a two-minute silence as a mark of respect to the departed souls. The budget session of the assembly will continue till March 5. (PTI)

SHIMLA/NEW DELHI, Feb 28: The Congress on Wednesday scrambled to save its government in Himachal Pradesh, amid dramatic developments that included the resignation of high-profile minister Vikramaditya Singh and the suspension of 15 BJP MLAs by the Speaker.



NEW DELHI, Feb 28: The Law Commission is likely to recommend adding a new chapter to the Constitution on 'one nation, one election' and holding the gigantic democratic exercise of simultaneous polls for Lok Sabha, state assemblies and local bodies across the country by mid-2029, sources said on Wednesday.

The Commission, under Justice (retd) Ritu Raj Awasthi, would recommend an amendment to the Constitution to add the "new chapter or part" on simultaneous elections, the sources said.

The panel would also recommend synchronising the terms of legislative assemblies in "three phases" in the next five years so that the first simultaneous polls could be held in May-June 2029 when elections for the 19th Lok

The new chapter in the Constitution would include issues related to "simultaneous election", "sustainability of simultaneous elections" and "common electoral roll" for Lok Sabha, state legislative assemblies, panchayats and municipalities so that the three-tier simultaneous polls could be held together "in one go", they ex-

The new chapter being recommended will have power of nonextant" to override other provisions in the Constitution dealing with terms of assemblies.

The five-year period in which the terms of assemblies will be synchronised will be spread over three phases. The Commission would recommend that the first phase may deal with state assemblies whose period will have to be

In case a government falls due to no confidence or if there is a hung House, the Commission would recommend constitution of a "unity government" with representatives from various political par-

In case the unity government formula does not work, the law panel would recommend holding fresh elections for the remainder of the term of the House.

"Suppose fresh elections are called for and the government still has three years, then polls should be for the remainder of the term -three years -- to ensure sustainability," a source explained.

Besides the Law Commission, a high-level committee under former president Ram Nath Kovind is also working on a report on how simultaneous polls to the Lok Sabha,

state legislative assemblies, municipalities and panchayats can be held by tweaking the Constitution and the existing legal framework.

Along with the upcoming Lok Sabha polls, expected in April-May this year, elections for at least five assemblies are likely to take place, while state polls for Maharashtra, Haryana and Jharkhand are expected later this year.

Bihar and Delhi are scheduled for assembly polls next year, while Assam, West Bengal, Tamil Nadu, Puducherry and Kerala are scheduled for 2026, and Uttar Pradesh, Uttarakhand, Punjab and Manipur

As many as nine states may have assembly polls scheduled for 2028 -- Tripura, Meghalaya, Nagaland, Karnataka, Mizoram, Chhat-Madhya Pradesh,

It is alleged that public servants allowed illegal mining during 2012-16, when Yadav was chief minister, and illegally renewed licences despite a ban by the National Green

It is alleged that the officers allowed theft of minerals, extorted money from lease-holders and drivers. The CBI had filed seven preliminary enquiries in 2016 on the directions of the Allahabad High Court to probe the case of illegal

mining of minor minerals. The agency had alleged that the then chief minister Akhilesh Yadav's office had cleared 13 projects in a single day, officials said.

They had said Yadav, who also held the mining portfolio for some time, had cleared 14 leases, of which 13 were cleared on February 17. 2013, in violation of e-tendering

The Central Bureau of Investigation (CBI) claimed that on February 17, 2013, the leases were granted by the district magistrate of Hamirpur, B Chandrakala, after getting approval from the chief minister's office in violation of its 2012 e-tender policy, which was ratified by the Allahabad High Court on January 29 that year.

The CBI had carried out searches at 14 locations in January 2019 in connection with its FIR against 11 people, including IAS officer B Chandrakala, Samajwadi Party MLC Ramesh Kumar Mishra and Sanjay Dixit (who unsuccessfully contested the 2017 assembly election on a BSP ticket) to probe the alleged illegal mining of minor minerals in Hamirpur district during 2012-16.

Yaday, who was the chief minister of the state between 2012 and 2017, held the mining portfolio during 2012-13 apparently bringing his role under scanner, according to the FIR.

He was succeeded by Gayatri Praiapati, who took charge as mining minister in 2013 and was arrested in 2017 following a complaint of rape by a woman residing in Chi-

# Record 3,300 kg narcotics seized from boat off Gujarat coast; 5 foreigners arrested

Feb 28: Indian agencies Wednesday made their highest-ever drugs bust from the sea as they seized 3,300 kg narcotics, which sailed from an Iranian port, off the Gujarat coast and arrested five foreigners from a dhow.

Home minister Amit Shah called the joint operation by the Navy, Narcotics Control Bureau (NCB) and the Gujarat Police a "historic success" and a testament of his government's "unwavering commitment to making our nation drug-free".

The unregistered fishing boat was intercepted on Tuesday morning at the Arabian Sea from point about 60 nautical miles from the Indian coast and along the International Maritime Boundary Line (IMBL). The Navy deployed its P8I long-range maritime reconnaissance aircraft and marine commandos onboard a warship and helicopters

Almost 3,300 kg of contraband that includes 3,110 kg charas or Hashish, 158.3 kg of crystal Methamphetamine and 24.6 kg of suspected heroin have been recovered from packets that bore the stamp of 'Ras Awad Goods Co, produce of Pakistan', the NCB

The source of the drugs is found to be the Chabahar Port in Iran, the agency said.



NCB director general S N Pradhan told reporters during a press conference in Delhi that the cache could be estimated to be worth anything between ₹ 1,300- ₹ 2,000 crore in the international market.

"This is the biggest offshore narcotics seizure made in the country till date. We have seen that drugs smuggling has increased through the maritime route over the last few years and hence we are jointly working with other government agencies like the Navy, Coast Guard, Customs etc. to intercept such activities."

"The smugglers and drugs operators use the Arabian Sea to exploit the Indian coastline that is

# Bihar Congress seeks disqualification of two defectors from assembly

PATNA, Feb 28: A day after two MLAs of the Congress in Bihar crossed over to the NDA, the party on Wednesday sought their disqualification from the state assem-

Congress president Akhilesh Prasad Singh led a party delegation that met Speaker Nand Kishor Yadav and sought disqualification of Siddharth Saurav and Murari Gautam, both of whom sat beside the ruling coalition members in the assembly on Tuesday.

Talking to reporters later, Singh said, "The BJP is misusing its power to offer inducements, and also issue threats through agencies like CBI and ED. We deplore the poaching of our MLAs, one of whom, Murari Gautam, was till recently a minister."

Notably, the Congress ceased to share power in Bihar last month when chief minister Nitish Kumar. who heads the JD(U), made an abrupt return to the NDA.

The state Congress president said the conduct of the two MLAs, was tantamount to "giving up the membership of their party", which violated the anti-defection law.

"The Speaker has said that he will study our representation and take a decision as per rules," added the state Congress chief, who, however, bristled at suggestions that his party could be hit by more defections in the near future.

'You are speculating on the

basis of the absence of some of our members in the House. You should pay attention to an even larger number of BJP MLAs remaining absent from today's assembly session," Singh shot back.

Earlier, Congress legislative party leader Shakil Ahmed Khan said that both MLAs have also been "stripped of the party's primary membership"

Khan also termed the two MLAs as "gaddar" (traitors), likening them to Mir Jafar, the infamous military commander of Bengal who connived with the British during the Battle of Plassey to become the Nawab.

The two Congress MLAs had switched sides along with Sangita Kumari of the RJD. The trio has kept mum over future course of action and none of them was present inside the House during the prelunch session on Wednesday.

However, their felicitation inside the assembly premises on Tuesday by deputy chief minister Samrat Choudhary, who is also the state BJP president, is being seen as an obvious signal that they would be joining the saffron party.

Meanwhile, RJD MP and national spokesperson Manoj Jha, whose party has lost four of its MLAs to the NDA camp, said, "We will definitely seek disqualification. I wonder how the Speaker is allowing this to happen on the

Notably, three RJD MLAs --Chetan Anand, Neelam Devi and Prahlad Yadav -- were allotted seats beside the ruling coalition members a fortnight ago when they also voted against senior party leader Awadh Bihari Chaudhary who got voted out as the Speaker in a no-confidence motion.

Jha also alleged that there has been a groundswell of support for RJD leader Tejashwi Yadav, who is on a state-wide tour following the loss of the deputy CM's post as a result of Chief Minister Nitish Kumar's abrupt return to the NDA.

He alleged this public support has rattled the BJP which is now taking recourse to the use of money power.

"But they do not realise that the RJD has produced thousands of MLAs since it came into being and cannot be cowed down by such antics," he said.

The ruling NDA at present has 134 MLAs, including the ones accused of defection. The strength of the Mahagathbandhan, which includes RJD, Congress and three Left parties, has dwindled to 108.

The RJD has also lost the status of the single-largest party, with its effective strength falling to 75, three less than that of the BJP even if the detectors are not added to the latter's tally.

The effective strength of the Congress has been reduced to 17.

### 'Zero fatality corridor': Crash deaths down by 58.3% on Mumbai-Pune E-way since 2016, says report



MUMBAI/NEW DELHI, Feb 28: The "zero fatality corridor" initiative has led to a 58.3 per cent reduction in road crash fatalities on the Mumbai-Pune Expressway since 2016 and 32 per cent since 2022, according to a report.

Describing the reduction as "unthe report stated that this marks a "significant stride towards a safer and more secure

"Once infamous for recording 151 deaths in 2016, roughly three deaths every 2 km, compared to the 2016 national average of one death per 2 km, the expressway earned the distinction of being one of the deadliest expressways in the country," it stated.

Since the launch of the "zero fatality corridor" initiative for the Mumbai-Pune Expressway (MPEW) in 2016, there has been a marked decline in road crash deaths, stated the report on the project, a joint effort of the Maharashtra State Road Development Corporation (MSRDC), the Maharashtra Highway Police (HSP), the Maharashtra Motor Vehicle Department and the SaveLIFE Foun-

The initiative, it stated, focused on comprehensive interventions spanning the 5Es of Road Safety – Enactment, Engineering, Enforcement, Emergency Care and Engagement.

The report stated that "as a result of these interventions, the Mumbai-Pune Expressway witnessed a 58.3 per cent decline in road crash deaths from 151 fatalities in 2016 to 63 fatalities (from 56 fatal crashes) up until 31st December,

"Every fatality on the expressway is a matter of grave concern for the MSRDC. We will leave no stone unturned to ensure we achieve zero deaths on this crucial link between Mumbai and Pune. The MSRDC has implemented various safety measures on the Mumbai-Pune Expressway and this has resulted in the elimination of various types of crashes like run-off crashes, object impact crashes, head-on crashes, and poor visibility related crashes," MSRDC Vice Chairman and Managing Director Dr Anil Kumar Gaikwad said.

Effort to achieve zero fatalities on the expressway is ongoing and the MSRDC is fully committed to achieve this ambitious goal, the senior official said.

The report, released by the SaveLIFE Foundation, highlighted that under the initiative, "hundreds of interventions" were undertaken across road engineering, traffic enforcement, trauma care and road-

More than 3,500 engineering issues were treated, traffic enforcement enhancement issues were enhanced, and emergency care and way were strengthened, including increasing the number of ambulances, upgrading ambulances and training personnel in basic trauma life support, according to the re-

Besides these, critical aspects of road safety were addressed and road users engaged through awareness campaigns, it stated.

On the reduction in road crash fatalities on the MPEW, founder and CEO, SaveLIFE Foundation, Piyush Tewari, said, "This is the result of the multi-agency collaborative approach of the programme. The success seen on this expressway has encouraged authorities across India to replicate this effort

"By scientifically understanding the causes of road crash fatalities, over 3.500 road engineering issues were fixed, enforcement was strengthened by police and RTOs, ambulance placement was optimised, and extensive campaigns were undertaken to educate road users commuting on the expressway," he said.

"Most importantly, monthly reviews of the programme were undertaken by the MSRDC, the Maharashtra Highway Police and the Transport Department along with SaveLIFE Foundation to ensure complete alignment and synergy in ensuring that lives can be saved," Tewari said.

He said that the result is a testament to the fact that road crash fatalities can be significantly reduced across Maharashtra as well as the country by taking a concerted and coordinated approach to understanding and resolving road safety

The report stated the creation of a steering mechanism that convened all concerned agencies on a single platform was a "cornerstone of the initiative".

The initiative also saw violations being effectively combated by employing a focused enforcement action plan, speed cameras and vehicle-activated speed signs. Speed traps on the MPEW have issued 13,16,512 challans since their installation in July 2020.

In 2023 alone, 2,17,089 challans were issued, the report stated.

KOLKATA, Feb 28: The Calcutta High Court on Wednesday directed that Trinamool Congress leader Shajahan Sheikh, the main accused in sexual atrocities on women and land grabbing at Sandeshkhali, can be arrested by the CBI, the Enforcement Directorate (ED) or the West Bengal Police. On a prayer by the state's advocate general, the court clarified its order of February 26 in which it had ordered the arrest of Sheikh by the police authority.

A division bench presided by Chief Justice TS Sivagnanam clarified that the court in its February 7 order had only stayed the constitution of a joint special investigation team (SIT) of the CBI and West Bengal Police by a single bench to probe an attack on ED officials.

The division bench directed that it will be "well open to the CBI or the ED also to arrest" the absconding Sheikh, noting that he has been on the run for a substantial period.

ED officials were attacked by a nearly 1,000-member strong mob at Sandeshkhali in West Bengal's North 24 Parganas district on January 5 when they went to search the premises of Sheikh. (PTI)

### Entire stretch of river Ganga in West Bengal unfit for bathing: NGT

NEW DELHI, Feb 28: The entire stretch of the Ganga in West Bengal contains high faecal coliform making the water unfit for bathing, the National Green Tribunal has observed, warning the authorities concerned of imposing a fine unless there was progress in tackling the pollution. The tribunal underlined that 258.67 million litres per day (MLD) of untreated sewage was directly flowing into the river.

The NGT was hearing a matter involving prevention, control and reduction of pollution of the Ganga across each district and state through which the river or its tributaries flow. It was considering a report from West Bengal, submitted in pursuance of its earlier directions.

A bench of NGT Chairperson Justice Prakash Shrivastava noted that reports were filed by the District Magistrates (DM) of North 24 Parganas, Murshidabad, Nadia, Malda, Hooghly, Purba Burdhaman, Howrah Purha Medinipur and South 24 Parganas

"On perusal of these reports, we, in general, find that no adequate facilities for treatment of sewage generated per day have been set up and that even the timeline for achieving the target of 100 per cent treatment of sewage has not been disclosed," the bench, also comprising judicial member Sudhir Agarwal and expert members A Senthil Vel and Afroz Ahmad, said,

In an order passed on February 21, the bench said, it was "surprising" that not even a single Sewage Treatment Plant (STP) was set up in some districts like Purba Medinipur.

# Ajmer Dargah demands Hindu Shakti Dal chief's arrest for 'objectionable' remarks

JAIPUR, Feb 28: Ajmer Dargah 'khadims' on Wednesday demanded strict action against Hindu Shakti Dal leader Simran Gupta for allegedly calling Sufi mystic Moinuddin Chishti a "rapist" and "terrorist". Sarwar Chishty, president of a body of 'khadims' of Ajmer Dargah, wrote a letter to Ajmer SP demanding Gupta's arrest over his objectionable comment.

"It is very unfortunate and disgraceful that the members of fringe organisation 'Hindu Shakti Dal' deliberately, as per a well-planned criminal conspiracy, made a hate-speech filled with offensive remarks and extremely objectionable defamatory statements against Khawaja Gharib Nawaz within the premises of Ajmer Collectorate campus," Sarwar Chishty said.

He said that astonishingly, concerned authorities did not take any preventive steps or any action against Hindu Shakti Dal members. "There is a multi-fold rise in rumour mongering, twisted historical facts, misinformation, abusive, insulting and defamatory comments on Khawaja Gharib Nawaz, and Dargah Ajmer Sharif 'khadims' as well as the Muslim community.

"Shockingly, despite our written complaint along with documentary and electronic evidence, and multiple FIRs, no one has been arrested by police so far for curbing hate speech and maintaining social harmony and peace," he said.

He added that a demonstration will be held if stringent legal action is not taken immediately and the accused persons are not arrested

Circle officer Dargah Gauri Shankar said that two FIRs have been registered in connection with the statement of Simran Gupta made nearly a week ago and the matter is being investigated

Hindu Shakti Dal president Gupta had allegedly said Moinuddin Chishti was a "rapist" and "terrorist" and the 'Jannati Darwaja' of the dargah was built after demolishing an ancient Shiva Temple. Gupta had recently submitted a memorandum to the district administration, demanding a survey of the dargah by the Archeological Survey of India (ASI). (PTI)

# 'Mothers Against Vaping' calls for curb on vapes, e-cigarettes in SE Asia

NEW DELHI, Feb 28: 'Mothers Against Vaping' has urged south east nations to take action on the WHO's call on them to curb use of new-age gateway devices such as e-cigarettes and vapes, particularly among children and youth.

The group is a united front of proactive and concerned mothers who are combating the "escalating vaping crisis" among the youth.

The warning by the World Health Organization against the rise of vaping in the region underscores and reemphasises the urgency to control the viral spread of e-cigarettes and other new-age gateway products, it said.

India has been at the forefront of banning e-cigarettes and other similar new-age gateway devices.

The PECA 2019 legislation has prohibited all aspects of electronic cigarette products, such as production, manufacturing, import, export, transport, sale, distribution, storage, and advertisement of ecigarettes, and renders them illegal in the country

The collective claimed there is little evidence that e-cigarettes lead to smoking cessation and these devices pose significant health risks to children and youth

In December 2023, the WHO said that e-cigarettes have not demonstrated effectiveness in quitting tobacco use, with emerging evidence pointing to adverse population health effects associdevices.

"Scientifically, claiming that E-Cigarettes can eliminate nicotine addiction is not accurate, given that these devices contain nico-

"Furthermore, the use of e-cigarettes poses a risk of delivering higher doses of nicotine and other harmful chemicals, potentially causing more harm to users. Hence there is an urgent need for effective measures to curb their

According to WHO, the South-East Asia Region has a significant prevalence of smokeless tobacco users, accounting for a massive 77 per cent of the global smokeless tobacco user population.

There are around 11 million adolescent users in the age group of 13-15 years, constituting nearly 30 per cent of the global total.

"The surge in the use of e-cigarettes among young people is not surprising, influenced by a variety of factors including peer pressure and aggressive advertising by manufacturers

"Beyond the evident physical harm caused by vaping or e-cigarettes, there is a critical concern about the serious mental health impacts such as mood and anxiety disorders, suicidal thoughts and depressive symptoms," said Dr Bhavna Barmi, Clinical Psychologist, Founder, Happiness Studio.

Mothers Against Vaping also drew attention to a survey conducted by the American Heart Association, presented in February 2023. The findings of the survey revealed a concerning correlation between vaping nicotine and THC (tetrahydrocannabinol), the psychoactive component in marijuana and self-reported symptoms of depression and anxiety.

"The long-term consequences of e-cigarettes remain unknown, but studies have already demonstrated serious lung injuries and adverse health effects associated with their use. Without effective control measures, the widespread prevalence of these new-age devices poses a genuine risk, potentially leaving our future generation with

lasting health impairments. "From causing chemical poisoning in users to jeopardising maternal and foetal health, vaping presents a myriad of physical health risks," said Dr Varuna Pathak, former Professor of Gynaecology and Obstetrics, Gandhi Medical College. (PTI)

# Irate villagers protest against MP Rameswar Teli for alleged neglect of issues

DIBRUGARH, Feb 28: Irate villagers of Jokai Mahabir Tea Estate Rameswar Teli in Dibrugarh. They accused him of failing to address their problems during his 10-year

Jokai Mahabir Tea Estate, located just 21 kilometers from Dibrugarh town, now falls under the newly formed Khowang legislative seat after the delimitation process. Previously, it was under the Moran legislative assembly seat.

The villagers claimed that Rameswar Teli had not visited their village in the past decade. They also expressed disappointment with Moran MLA Chakradhar Gogoi for not addressing their genuine issues.

Around 200 people from Jokai Mahabir Tea Estate participated in the protest against Rameswar Teli, accusing him of neglecting their problems

Montu Mura, one of the irate villagers, alleged, "In the last 10 years of Rameswar Teli's tenure as Dibrugarh MP, we have not seen him in our village. He didn't come to know the problems our villagers



face. Our area has not seen development, unlike most of the roads in tea garden areas, which were properly constructed. But our village has been neglected."

He added, "The road between Jokai Mahabir Tea Estate and Barbaruah has not been built. When the BJP government prioritised road construction, why has our road remained neglected?"

"We elected Rameswar Teli from Dibrugarh constituency as a representative of our people, but he failed to address the problems of the tea garden people. Our burning issues are never discussed in the parliament. As a representative of the people. Rameswar Teli should address the issue, but he failed to do so during his 10 years in power," Mura emphasised. LUTON, ENGLAND, Feb 28: Erling Haaland looks determined to make up for lost time.

The Norway striker scored five goals to power Manchester City into the quarterfinals of the FA Cup in a 6-2 win against Luton on Tuesday. It was his eighth hat trick in a season-and-a-half with City and the second time he has scored five in a single game for the club.

Perhaps more significantly, it was evidence that Haaland is fully back up to speed after recently returning from a foot injury that ruled him out for more than a month between December and January. "My fitness is getting back to its best finally," he said. "I feel good. It's an amazing feeling."

Haaland had scored only three goals in seven appearances since making his comeback on Jan. 31.

By his remarkable standards, that represented a relative drought, but he looked back to his devastating best at Kenilworth Road with a first-half hat trick and two more after the break. Four of those goals came from assists by Kevin De Bruyne, who has also missed large parts of the season through injury.

"It's a pleasure playing with him," Haaland said. "I think we know what we both want from each other, we look at each other and it clicks well."

Mateo Kovacic added a sixth for City, while Jordan Clark struck twice for Luton.

Haaland was denied a possible double hat trick when he was replaced by Julian Alvarez in the 77th minute. It was the second time City manager Pep Guardiola substituted the striker after scoring five goals, having taken him off during the 7-0 rout of RB Leipzig in the Champions League last year.

# Turmoil in hockey: HI head Tirkey, secretary Bhola Nath Singh deny rift in joint statement

India president Dilip Tirkey and secretary general Bhola Nath Singh on Wednesday denied outgoing CEO Elena Norman's assertion of a rift between them, saying that they are "united" and working in the best interest of the sport.

Norman resigned on Tuesday and in an interview to PTI she alleged that there was factionalism in the body. The 49-year-old Australian suggested that Tirkey and Singh were at loggerheads and also complained of a difficult work environment.

In a joint statement, Tirkey and Singh rejected Norman's claims.

"Recently there have been statements by outgoing officials published in the media, claiming that there are divisions within the organisation. This is not correct. We remain united in working together, and as always in the best interest of the sport," the two said.

"Hockey India is an autonomous and professional body dedicated to the development of Indian hockey. Our primary objective as an organisation has been and continues to remain the welfare and progress of the sport of hockey and our ath-
