Boost for BJP ahead of LS elections

DIPHU, March 22: In a significant political development, some prominent leaders from the Congress party, including former MLA Klengdoon Engti from Bokajan constituency, have officially switched allegiance to the Bharatiya Janata Party (BJP).

The defection, which took place at the state BJP Assam Pradesh office in Guwahati, marks a substantial boost for the BJP in the region ahead of the upcoming Parliamentary elections.

According to reports, a total of 45 individuals, comprising former MPs, MLAs, and influential Congress leaders, alongside members from the Aam Aadmi Party (AAP) and other political factions, have joined the BJP.

The event witnessed the presence of key BJP figures including Bhabesh Kalita, the state BJP chief



Tuliram Ronghang, chief executive member of the Karbi Anglong Autonomous Council, and minister Jayanta Malla Baruah

One of the notable figures in this

political shift is Klengdoon Engti, the former Congress MLA from Bokajan and the son of senior Congress leader and former MP Birensing Engti. While Klengdoon

Engti has chosen to align with the BJP, his father remains within the Congress ranks. This move underscores a significant realignment of political affiliations within the

The timing of this defection is crucial as Assam gears up for the upcoming Parliamentary elections.

The BJP's acquisition of seasoned leaders from rival parties could potentially reshape the political landscape in the region. It's worth noting that the Congress has fielded Joyram Engleng, former MLA and former chief executive member of the Karbi Anglong Autonomous Council, as their candidate for the 6 – Diphu (ST) Parliamentary Constituency.

Eleven Congress MLAs led by Sangma joined the TMC in 2022, following which it became the main opposition party in the state overnight. The West Bengalbased party won only five seats in the 2023 assembly elections.

"Our team went and met Dr Mukul, and invited him to come back (to the Congress). I told Mukul, you come back to the Congress or you be in the TMC, we will work together, but rather he himself is trying to persuade Congress workers to join the BJP," Pala, the MP of Shillong, told reporters here on Thursday. "Many of our (Congress)

workers received calls. For example, in Ri Bhoi, they have al-

Pala claimed that Sangma will "definitely" join the BJP after the Lok Sabha elections.

The saffron party had unsuccessfully contested the two seats in Meghalaya and one seat in Manipur in the 2019 Lok Sabha polls.

two seats in Meghalaya. Sources said the political upshot of ethnic clashes in Manipur might have prompted the BJP to support these regional parties in these constituencies with a considerable

Maldives seeks debt relief from India after insisting on withdrawal of military personnel



MALE, March 22: After his anti-India rhetoric, Maldives President Mohamed Muizzu has struck a reconciliatory tone, saying India will continue to remain his country's "closest ally" and urged New Delhi to provide debt relief to the archipelago nation.

The Maldives owed approximately USD 400.9 mil-

lion to India by the end of last year. Ever since he took oath as the president in Novem-

ber last year, the pro-China Maldivian leader has pursued a hardline stand towards India and within hours had demanded that Indian military personnel operating three aviation platforms be repatriated from his country by May 10.

On Thursday, in his first interview with the local media since assuming office, Muizzu said India was instrumental in providing aid to the Maldives and has implemented the "greatest number" of projects. India will continue to remain the Maldives' closest

ally, he said and emphasised that there was no question about it, Maldives news portal Edition.mv said in a report that carried excerpts of Muizzu's interview to its Dhivehi language sister-publication 'Mihaaru.'

Muizzu's comments praising India came after the first batch of Indian military personnel left the island nation this month as planned. By May 10, Muizzu had demanded that all 88 military personnel, manning the three Indian aviation platforms, should leave the country. People watch, history remembers, truth prevails." State Congress president Bhupen Kumar Borah also criticised Kejriwal's arrest and said "INDIA will give a befitting reply".

"A frightened dictator wants to create a dead democracy," he wrote on the micro-blogging site. "While capturing all the institutions including the media, breaking up parties, extorting money from compa-

nies, freezing the account of the main opposition party were not enough for the 'devilish power', now the arrest of the elected chief minister has also become a common thing," Borah wrote.

Assam Jatiya Parishad (AJP) president Lurinjyoti Gogoi termed the ED raid and arrest of the Delhi CM as an attack on democracy. "The ED raid and arrest of Arvind Kejriwal is an attack on democracy and abuse of power. Targeting political opponents undermines the principles of justice and fairness. Rupee falls 35 paise to hit all-time low of 83.48 against US dollar

MUMBAI, March 22: The rupee depreciated 35 paise to settle at an all-time low of 83.48 against the American currency on Friday, tracking a surging greenback against major crosses in the overseas markets and weak Asian peers. Forex traders said foreign fund outflows also weighed on the local unit.

At the interbank foreign exchange market, the local unit opened weak at 83.28 against the greenback, and finally settled at a record low of 83.48 (provisional), registering a fall of 35 paise from the previous close of 83.13.

In intraday trade, the rupee touched a low of 83.52 against the American currency.

The rupee had earlier recorded its lowest closing level of 83.40 on December 13, 2023.

According to Anuj Choudhary, Research Analyst, Sharekhan by BNP Paribas, the US dollar strengthened on weak euro and pound. Euro declined as the Swiss National Bank (SNB) surprised the markets by cutting interest rates by 25 bps to 1.5 per cent, which raised the odds of a rate cut by the European Central Bank (ECB) in June 2024

The pound also fell after the Bank of England kept interest rates unchanged at 5.25 per cent. Two hawkish committee members, who voted for a rate hike in the previous meeting, also voted for a no rate hike. Robust economic data from the US also favoured the US dollar, Choudhary said. (PTI)

The evolution and trustworthiness of electronic voting machines

The electronic voting machine (EVM) has once again taken center stage in public discourse. Since its full implementation in the 2004 Lok Sabha elections, the EVM has been a subject of intense debate among political circles and civil society alike. The arguments surrounding its efficacy remain consistent, though the proponents and opponents frequently switch positions. In the current context, Chief Election Commissioner (CEC) Rajiv Kumar has eloquently come to the defense of the voting machine. He metaphorically rebukes its detractors, stating, "Blaming EVMs for unfulfilled desires is an unjust accusation." This poetic stance by the CEC underscores the ongoing dialogue surrounding the role and reliability of EVMs in democratic processes

The issue at hand revolves around the fundamental concept of trust in technology. Take, for instance, the Electronic Voting Machine (EVM), a cornerstone in the democratic process of electing representatives. For this system to function effectively, it's imperative that all stakeholders—be it political entities, voters, or civil society—place their trust in it. Trust, however, is not solely contingent upon the technology meeting legislative, legal, regulatory, and technological standards, but it extends beyond these parameters. This principle is applicable across various technological advancements.

Consider the evolution of financial transactions: from the traditional paper-based cheque system replacing informal methods like Hundi transfers, to the emergence of electronic money transfers via banks, and presently, the widespread adoption of internet-based digital transactions facilitated by mobile phones. Despite the involvement of numerous unidentified inter-



mediaries in the latter, the fact remains that billions of digital transactions occur daily. While acknowledging the presence of potential vulnerabilities within these systems, it's evident that users exhibit a significant level of trust in their reliability and functionality.

Before the Electronic Voting Machine (EVM) took center stage, the paper ballot system was the primary mode of voting, a practice that evolved over several decades. Initially, in the inaugural General Election of 1951-52, the process involved multiple ballot boxes, each designated for a specific candidate and marked with their party's symbol.

Voters then had to deposit their ballot in the box corresponding to their chosen candidate. Subsequently, a common ballot box was introduced, accompanied by ballot papers featuring symbols and names of contesting candidates. Voters were required to stamp their chosen symbol and deposit the paper into the shared box.

However, despite its widespread adoption, the paper ballot system wasn't immune to controversies regarding its reliability and security. Instances of ballot box theft and booth capturing were reported from various parts of the country, highlighting its susceptibility to fraud. Nonetheless, despite these challenges, the paper ballot system maintained a

reasonable level of trust among all stakeholders for many decades.

From its humble beginnings as a prototype developed by the Hyderabad-based Electronics Corporation of India Limited in 1979 to its nationwide implementation in 2004, the

ing Machine (EVM) underwent a series of refinements amidst intense legal

and political scrutiny.

Much like its predecessor, the paper ballot, the EVM is expected to instill confidence in voters across three crucial aspects: firstly, ensuring that their vote is accurately recorded in a transparent manner; secondly, guaranteeing that their vote is allocated to the intended candidate; and finally, ensuring that the entire process, from assembly and programming to transport, storage, and counting,

Regarding its technological aspect, the Election Commission of India (ECI) has consistently asserted that the Electronic Voting Machine (EVM) is immune to tampering and corruption. At first glance, this assertion appears reasonable. The EVM op-

erates on a simplistic design, devoid of any networking capabilities, wireless interfaces, or operating systems found in more sophisticated voting machines. This inherent simplicity, proponents argue, shields the EVM from external hacking attempts.

During the peak of public skepticism surrounding the integrity of the Electronic Voting Machine (EVM) in 2009, the Election Commission of India (ECI) organized a public challenge, offering around 100 EVMs for examination by political parties and activists. However, the challenge faced objections from ECI officials and EVM manufacturers when some participants resorted to dismantling the machines.

The incident highlighted a lack

The incident highlighted a lack of transparency on the part of both the Election Commission of India (ECI) and EVM manufacturers regarding the inner workings of the machines. However, in response to mounting criticism over this opacity, the ECI took a significant step in 2013 by introducing the Voter-Verified Paper Audit Trail (VVPAT) system. This innovative measure aimed to provide voters with tangible assurance that their votes had been accurately recorded, thus addressing concerns about trans-

parency in the voting process.

While an individual Electronic Voting Machine (EVM) may appear secure against external hacking attempts, its vulnerability lies in the human element involved during the manufacturing process. EVMs are programmed using a source code that operates on the hardware. In theory, this code could be manipulated to function in a desired manner.

PV Indiresan, a former IIT professor who chaired the Election Commission of India's (ECI) technical committee in 2005, disclosed that only a handful of individuals, typically three to four, possess knowledge of the source code. This source code, kept confidential by the EVM manufacturers (often public sector units), is entrusted to individuals whose integrity is paramount. Ultimately, the trustworthiness of the EVM technology hinges not solely on its technical aspects but also on the integrity of those involved in its manufacturing process.

Advocating against reverting to the paper ballot, some suggest that the Election Commission of India (ECI) should proactively work towards reinstating trust among political parties and voters. This endeavor necessitates a comprehensive approach, encompassing every facet of the electoral process, from the manufacturing and programming of machines to the secure storage and accurate counting of votes. Furthermore, additional trustbuilding measures, such as the Voter-Verified Paper Audit Trail (VVPAT), should be implemented where deemed necessary. Central to fostering greater trust is a corresponding level of transparency. It's crucial to recognize that technology, including the Electronic Voting Machine (EVM), is dynamic and adaptable, never set in stone. (The writer can be reached at di-

India's NHRC is acting as an agency of the ruling Narendra Modi government

India, the world's largest democracy, has unfortunately been witnessing a backsliding on human rights. It is in this context that the National Human Rights Commission of India (NHRC) will be undergoing its review for accreditation by a jury of its peers which is the Global Alliance of National Human Rights Institutions (GANHRI) in March 2024.

Accreditation by GANHRI and the status of A or B, which is awarded, is based on the extent to which an NHRI complies with the Paris Principles— which are the agreed minimum standards that NHRIs must meet to be considered credible.

must meet to be considered credible.

One of the standards that the NHRC will have to meet is to show that it is exercising its powers to "draw the attention of the government to situations in any part of the country where human rights are violated and making proposals to it for initiatives to put an end to such situations and, where necessary, expressing an opinion on the positions and reactions of the government".

In India, the constituency which has mounted the strongest defence of human rights is civil society. There have been strong protests against the Citizenship Amendment Act, 2019 (CAA) as well as by farmers against the farm laws. There has also been a consistent campaign for the release of political prisoners including the BK-16, the Delhi anti-CAA protestors as well as the thousands of Adivasis who languish in Indian prisons. The exercise of these fundamental rights to speech, expression and assembly has come at a great cost. Those doing human rights work have faced the brunt of persecution by the State.

Be it Khurram Parvez of the Jammu Kashmir Coalition of Civil Society (JKCCS), Harsh Mander, Henri Tiphagne or Aakar Patel - they have all faced the brunt of State intimidation. Khurram Parvez, who is an internationally known human rights defender is still in jail, imprisoned under the Unlawful Activities (Prevention) Act (UAPA), 1967 for the 'crime' of human rights reporting on Kashmir

mir.

It is outrageous that the NHRC has not released a single statement on the arrest of Khurram Parvez and Irfan Mehraj and the targeting of the JKCCS, which is the premier human rights organisation based in Kashmir. When the very raising of a voice is sought to be stifled by the State, democracy is under threat. It is in times such as this, that it is vital that an institution with a mandate of independence stands up for the principle that the work of human rights defenders, however unpalatable it is to the government, is a vital element of our democratic fabric for the princip fabric fa

ocratic fabric.

The institution which Indian civil society looks to, to stand up for these core democratic principles of speech, expression, association and assembly, is the NHRC. The mandate of the NHRC under the Protection of Human Rights Act, 1993 is the 'better protection of human rights'. By human rights, the statute under Section 2(d) means, "the rights related to life, lib-

erty, equality and dignity of the individual guaranteed by the Constitution or embodied in the international covenants."

The question of defending the right to speech, expression, assembly and association is vital to an institution that claims human rights as its very mandate. If the NHRC has remained silent when its core mandate is being threatened, then it needs to be accountable for its inaction. Leaving aside the question of being a voice in support of those raising human rights concerns, the NHRC also has a mandate to proactively intervene in human rights concerns of the day.

In the past, the NHRC has exercised its power under Section 12(d) of the Act by doing a 'review' of the "safeguards provided by or under the Constitution or any law for the time being in force for the protection of human rights and recommend measures for their effective implementation". The NHRC in the past has been responsive to civil society concerns and come out with recommendations on legislation in which there were legitimate concerns expressed about human rights.

With respect to the Prevention of Terrorism Ordinance (later Act), the NHRC came out with a finding that, "there was no need to enact the new law" and that the concerns around terrorism could be dealt with under existing legislation. However, the current NHRC has shown no concern about the constitutional implications of anti-terror laws. Ever since the coming into power of the Modi government, both the UAPA and the National Investigation Agency (NIA) Act, 2008 have become the go-to laws with respect to targeting dissenters.

An online People's Union for Civil Liberties (PUCL) conference held in January 2021 had victims and activists testifying from twelve states across the country on how the UAPA continues to be invoked to criminalise dissent, be it of speech, association or assembly. However, the misuse of the UAPA and the NIA Act while being raised by civil society groups has not troubled the human rights conscience of the NHRC.

Neither has the current NHRC seen fit to issue any statement or analysis regarding the human rights implications of the three

criminal laws that have been passed to replace the Indian Penal Code, 1860 (IPC), the Code of Criminal Procedure, 1973 (CrPC), and the Indian Evidence Act, 1872. These laws seriously dilute human rights standards which the NHRC should hold dear, be it the prohibition against handcuffing or solitary confinement. However, the analysis and critique of the same have been left to civil society.

The other important function that the NHRC has under Section 12(b) of the Protection of Human Rights Act, relates to "intervening in any proceeding involving any allegation of violation of human rights pending before any court". In the past, the NHRC has intervened forcefully in the Supreme Court on key human rights violations. During the Gujarat riots in 2002, the NHRC was a petitioner before the Supreme Court representing the interests of the human rights violated, in a luminous example of the use of its powers under Section 12(b) of the Protection of Human Rights Act.

However, the NHRC has not said a word in relation to the passing of the CAA by the Union government and its recent notification. The passing of the law triggered one of the most widespread protest movements in contemporary times, with over 140 petitions being filed challenging the CAA. The NHRC could have exercised its powers under Section 12(b) and added the weight of its office to the challenge by filing its own petition before the Supreme Court.

It took a statement by the Office of the High Commissioner of Human Rights (OHCHR), in which it contemplated intervening in the Supreme Court to expose the failure of the NHRC to a global audience.

The Ministry of External Affairs has opposed this proposed intervention, stating that the Act is "an internal matter of India". It further went on to characterise the United Nations body as a "foreign party" and the intervention itself as bereft of "locus standi" as it related to "issues pertaining to India's sovereignty".

This debate between the ministry and the OHCHR provided the NHRC an opportunity to issue a statement welcoming the OHCHR intervention as adding a welcome

dimension of an understanding of international human rights which was in harmony with the definition of human rights in the Protection of Human Rights Act. However, the NHRC remained silent. Shockingly, the NHRC choose not to comment on one of the most egregious violations of human rights in India. The Gujarat government remitted the sentence passed against those accused of rape and murder during the Gujarat riots of 2002 and released 11 convicts who were serving a life sentence.

The case itself involved the brutal gangrape of Bilkis Bano and several other women of her family along with the murder of her family members, including her 3-year-old daughter. This shocking case of remission led to the filing of a petition in the Supreme Court by concerned citizens. The NHRC did not see it fit to either intervene or comment on this violation of women's rights to dignity, bodily integrity and life.

The final decision of the Supreme Court, striking down the remission, is entirely due to the intervention of civil society, with the NHRC remaining a silent bystander. When the government arbitrarily remits the punishment for the most egregious crime of rape and murder and the NHRC remains silent then the question remains as to whether it is performing its statutory and constitutional responsibilities?

From the point of view of Indian civil society, the NHRC has utterly failed to fulfil its mandate. Though it has relatively broad powers, it has failed to exercise them. It has violated its commitment to uphold the Paris Principles by showing a lack of independence in the discharging of its mandate. The NHRC must not be given a free pass to continue to abuse its mandate by its partisan silence. The decision of the Sub-Committee on Accreditation (SCA) on the status of the NHRC should be based on a rigorous scrutiny of the record of the NHRC in fulfilling its mandate.

The material in the public domain inspires no confidence at all that the NHRC deserves an A status. Hopefully, this process of scrutiny will provide a muchneeded wake-up call to the NHRC to exercise its powers under the Act and work to fulfil the Paris Principles. (IPA Service)

President's Media Division of Sri Lanka (PMD) said in a post on X: "President Ranil Wickremesinghe released 234 acres of land which were previously held by the Jaffna Security Forces Headquarters, to farmers for cultivation purposes in 5 Grama Niladhari Divisions in Jaffna.'

These plots of land were released to farmers across five Grama Niladhari Divisions in Jaffna for cultivation purposes, The Morning News website reported.

Under the Urumaya national programme, aimed at distributing two million freehold deeds to the deserving public, Wickremesinghe symbolically presented the deeds, benefiting 408 individuals at a ceremony held in Jaffna's Oddakapulam.

Jaffna holds great significance as it was the region where the Liberation Tigers of Tamil Eelam (LTTE) had run a military campaign for a separate Tamil homeland for nearly 30 years before its collapse in 2009 after the Sri Lankan Army killed its supreme leader V Prabhakaran.

The region has lacked economic development and the Sri Lankan leaders have said they are committed to the development of the Tamil-dominated Northern and Eastern provinces of the island nation. (PTI)

Gaza's Rafah would be a mistake and isn't needed to defeat Hamas CAIRO, March 22: U.S. Secretary of State

Blinken says an Israeli assault on

Antony Blinken said Thursday a major Israeli ground assault on the southern Gaza town of Rafah would be "a mistake" and "unnecessary" to defeating Hamas, underscoring the further souring of relations between the United States and Israel.

Blinken, on his sixth urgent Mideast mission since the war began in October, spoke after huddling with top Arab diplomats in Cairo for discussions on efforts for a cease-fire and Gaza's post-conflict future. He said an "immediate, sustained cease-fire" with the release of Israeli hostages held by Hamas was urgently needed and that gaps were narrowing in indirect negotiations that U.S., Egypt and Qatar have spent weeks mediating. Those negotiations are to continue at a senior level in Oatar on Friday.

Blinken heads to Israel on Friday to meet Prime Minister Benjamin Netanyahu and his War Cabinet. The growing disagreements between Netanyahu and President Joe Biden over the prosecution of the war will likely overshadow those talks — particularly over Netanyahu's determination to launch a ground assault on Rafah, where more than a million Palestinians have sought refuge from devastating Israeli ground and air strikes further

Netanyahu has said that without an invasion of Rafah, Israel can't achieve its goal of destroying Hamas after its deadly Oct. 7 attack and taking of hostages that triggered Israel's bombardment and offensive in Gaza.

"A major military operation in Rafah would be a mistake, something we don't support. And, it's also not necessary to deal with Hamas, which is necessary," Blinken told a news conference in Cairo with Egyptian Foreign Minister Sameh Shoukry. A major offensive would mean more civilian deaths and worsen Gaza's humanitarian crisis. Blinken

said, adding that his talks on Rafah in Israel on Friday and discussions between senior U.S. and Israeli officials next week in Washington will be to share ideas for alternative action.

The U.S. position on a Rafah operation has shifted significantly in recent days. Initially, U.S. officials said they could not support a major incursion into the city unless there was a clear and credible plan for getting civilians out of harm's way. Now, U.S. officials said they have concluded there is no credible way to do that, given the density of the population of more than a million people. They say now that other options, including specifically targeted operations against known Hamas fighters and commanders, are the only way to avoid a civilian catastrophe.

But Netanyahu, on a roughly 45-minute call with GOP senators on Wednesday, pledged to ignore warnings about a Rafah operation. He also took aim at Senate Majority Leader Chuck Schumer's condemnation last week of the civilian death toll in Gaza and his call for new elections in Israel in a speech that Biden later said was "good." Netanyahu stressed that Israel would move ahead in Rafah, according to senators who participated in the meeting. Sen. John Kennedy, a Louisiana Republican, said Netanyahu "made it very clear that he and the people of Israel intend to prosecute the war to the full extent of their power and that he would not be dictated to by Senator Schumer or President Biden."

The UN will vote on a US resolution declaring that an immediate cease-fire in Gaza is imperative

UNITED NATIONS, March 22: The United Nations Security Council is set to vote on a United States-sponsored resolution declaring that "an immediate and sustained cease-fire" in the Israel-Hamas war in Gaza is "imperative" to protect civilians and enable humanitarian aid to be delivered to more than 2 million hungry Palestinians.

U.S. Ambassador Linda Thomas-Greenfield said she was optimistic that the new, tougher draft resolution would be approved on Friday by the 15-member council.

The draft being put to a vote "determines" — which is a council order — "the imperative of an immediate and sustained cease-fire," with no direct link to the release of hostages taken during Hamas' Oct. 7 attack on Israel, which was in the previous draft. But it would unequivocally support diplomatic efforts "to secure such a cease-fire in connection with the release of all remaining hostages."

Russia's deputy U.N. ambassador Dmitry Polyansky said Moscow will not be satisfied "with anything that doesn't call for an immediate cease-fire," saying it's what U.S. Secretary of State Antony Blinken is pressing for and what "everybody" wants. He questioned the wording of the draft, asking, What's an imperative? I have an imperative to give you \$100, but ... it's only an imperative, not

"So, somebody's fooling around, I think, (with the) international community," the Russian envoy said. The Security Council had already adopted two resolutions on the worsening humanitarian situation in Gaza, but none calling for a cease-fire. Russia and China vetoed a U.S.-sponsored resolution in late October calling for pauses in the fight-

ing to deliver aid, protection of civilians, and a halt to arming Hamas. They said it didn't reflect global calls for a cease-fire. The U.S., Israel's closest ally, has vetoed three resolutions demanding a cease-fire, the most recent

The 27-nation EU is holding USD 3 billion deal with UK gets Australia closer to having a fleet of nuclear-powered submarines

SYDNEY, March 22: Australia is set to provide 4.6 billion Australian dollars (USD 3 billion) to British industry to support the construction of nuclear-powered submarines and ensure its new fleet arrives on time, the two countries said on Friday.

The announcement came a day after the two countries signed a defence and security pact to better meet challenges such as China's increased activity in the South China Sea and South Pacific.

UK Defence Minister Grant Shapps said the submarine programme was expensive but necessary. "Nuclear-powered submarines are not cheap, but we live in a much more dangerous world where we are seeing a much more assertive region with China, a much more dangerous world all around with what's happening in the Middle East and Europe,' Shapps told the Australian Broadcasting Corporation.

The bombing on Thursday at a branch of New Kabul Bank in Kandahar city killed three people and wounded 12 others.

All of the victims were people who had gathered there to collect their monthly salaries, said Inamullah Samangani, head of the government's Kandahar Information and Culture Department.

The Islamic State group's affiliate, a major Taliban rival, has conducted attacks on schools, hospitals, mosques and Shiite areas throughout Afghanistan.

The militant group said in a statement posted on its news agency, Aamaq, late on Thursday that the suicide bomber detonated his explosive belt among the Taliban gathered near the bank to receive their salaries.

For this reason, the NDA government should be opposed. I have been constantly opposing the NDA government in the present Rajya Sabha," the MNF leader said. Modi will also hold bilateral talks with his Bhutanese counterpart Tshering Tobgay.

The Prime Minister is scheduled to receive a grand welcome at the Tashichho Dzong, a traditional Buddhist monastery and the seat of the Bhutanese government.

Tshering Tobgay was on a five-day

visit to India last week, his first foreign trip after assuming charge of the top office in January.

Kejriwal 'kingpin' of excise scam, claims ED

ED seeks 10 day custody in the 'Liquor Scam' case

NEW DELHI, March 22: Arvind Kejriwal, the Delhi chief minister once idolised as an anticorruption crusader, was on Friday produced before a court where the Enforcement Directorate dubbed him as a "key conspirator" in the liquor scam case and sought his 10-day custody.

The ED told Special Judge Kaveri Baweja at the Rouse Avenue court that Kejriwal received several crores of rupees as kickbacks from the 'South group' for formulating and implementing the Delhi Excise Policy 2021-22.

He demanded Rs 100 crore from some accused from the 'South group' for contesting elections, Additional Solicitor General (ASG) SV Raju, who is appearing for the federal antimoney laundering agency, told the court.

The law officer said the money trail showed that Rs 45 crore "kickback" used in the Goa assembly elections came from four hawala routes.

Protests erupted in the national capital over Kejriwal's arrest with hundreds of AAP workes and supporters hitting the streets. Raising slogans "Arvind tum sangharsh karo, hum tumhare sath hain" and "tyranny won't last", they converged near the AAP offices.

Many of them, including Atishi and Saurabh Bharadwaj, two key ministers in the Kejriwal cabinet, were detained. They were taken away in police buses after they refused to disperse from ITO intersection, which is close to the AAP and BJP offices, violating section 144

While accusing Kejriwal of being the "kingpin" of the alleged scam, the ED has alleged the party's communication incharge Vijay Nair functioned as his link to the south cartel, which gave the Delhi's ruling party kickbacks of Rs 100 crore in return for favours by way of wholesale and retail liquor licences.

These funds, it claimed, were used for the assembly elections in Goa and significant amounts of money were given to AAP candidates in cash. (PTI)

Kejriwal withdraws plea from SC hours after apex court agreed to hear it

NEW DELHI, March 22: Delhi Chief Minister Arvind Kejriwal on Friday withdrew from the Supreme Court his plea against arrest by the Enforcement Directorate in the excise policy-linked money laundering case, hours after the apex court said the petition would be heard during the

The apex court, which had around 10.45 am said the plea would be heard by a three-judge bench, was informed by Kejriwal's counsel around 12.15 pm that they are withdrawing the petition and would contest the remand proceedings before the trial court. The plea was initially mentioned for urgent hearing before a bench headed by Chief Justice D Y Chandrachud.

Senior advocate Abhishek Singhvi, representing Kejriwal, said he was mentioning a matter of "some significance and urgency".

"If this process goes on, I am very sorry to say, before the first vote is cast, a lot of senior leaders will be behind bars. I am imploring your lordships to take it up ur-

gently either in the middle of the board or the end of the board," Singhvi said.

The CJI said a special threejudge bench is convening in Justice Sanjiv Khanna's court, and Singhvi can mention the matter before that bench.

"The special bench is over, almost," the senior counsel said.

"Then you can go right away to Justice Khanna and it will be taken up," the CJI said, adding, "Just go to that bench because that bench is available."

"You can just mention that the Chief Justice has assigned it to Justice Sanjiv Khanna's court," Justice Chandrachud told Singhvi.

Singhvi then rushed to Justice Khanna's court but the special three-judge bench, also comprising justices MM Sundresh and Bela M Trivedi, which had assembled to hear BRS leader K Kavitha's plea challenging her arrest in the Delhi excise policy scam case and the provisions of the Prevention of Money Laundering Act, was over by that time. (PTI)

ASI begins survey of Bhojshala complex in MP; puja, namaz to continue as per practice, says official

DHAR, March 22: A team of the Archaeological Survey of India (ASI) Friday began a survey of the controversial Bhojshala/Kamal Maula Mosque complex situated in the tribal-dominated Dhar district of Madhya Pradesh.

The ASI team, comprising more than a dozen members, reached the complex in the morning. It was accompanied by senior local police and district administration officials.

The ASI team worked till noon and left the spot for the day, Ashish Goyal, one of the petitioners in the matter who was present with surveyors, told reporters. Both Hindus and Muslims consider the site a place of worship.

Asked whether Muslims would be allowed to offer prayers at the site, Dhar Superintendent of Police (SP) Manoj Kumar Singh said 'puja' on Tuesdays and 'namaz' on Fridays will be held as per practice. The SP said he would discuss the matter with ASI officials and make adequate arrangements for the faith-related activities.

A 15-member team reached the site early in the morning to survey the Bhojshala complex, Goyal said. He said that members of the Hindu Front for Justice, an umbrella organisation representing petitioners like him, were also present during the survey.

"Today they did the ground-level preparations for conducting the survey. As directed by the high court, new technologies like GPS and carbon-dating equipment were used by the team," Goyal said.

However, eyewitnesses said that the members of the Muslim community were not present on the occasion. As per the ongoing practice, Muslim community members offered Friday namaz at the site amid heavy police presence, they said.

Earlier, SP Singh said that the survey had begun the Bhojshala.

"We have provided all the logistical support that the ASI team needed to conduct it. Adequate security measures were taken for the exercise and there is peace in the town," he had told PTI.

A heavy police force has been deployed at the

site, eyewitnesses said.

Meanwhile, a Special Leave Petition (SLP) filed by the Muslim community against the HC order in the Supreme Court on the issue was listed for hearing on April 1, lawyer Shirish Dube, representing Hindu Front for Justice, told reporters. He said the SC refused to hear the matter on Friday as mentioned by their lawyers. The survey will continue as directed by the HC, he added.

The Madhya Pradesh High Court, on March 11, directed ASI to carry out within six weeks a 'scientific survey' of the Bhojshala complex, a medieval-era monument that Hindus believe is a temple of Goddess Vagdevi (Saraswati) and the Muslim community calls Kamal Maula Mosque. As per an ASI order issued on April 7, 2003,

Hindus are allowed to worship inside the Bhojshala complex every Tuesday, while Muslims are allowed to offer namaz at the site on Fridays. Speaking to reporters later, Dhar town's 'Shahar Qazi' Waqar Sadiq said that no authorized member of the Muslim community was present during the survey, though Kamal Moula Mosque's representative Abdul Samad was supposed to be there.

But it seems ASI has not given him any notice and for this the central agency is responsible, Sadiq claimed. Sadiq said ASI reports of 1902 and 1903 are in its records and the first report on the site mentioned that "this is a mosque".

"A petition was again filed in the high court in 1998 by Vimal Kumar Godha on behalf of the Bajrang Dal and other Hindu bodies. Atal Bihari Vajpayee was the prime minister then. A reply was filed that time that it was 'Kamal Moula Mosque' and the existence of Bhojshala was a mystery," he said. This reply is in the records of the high court and ASI cannot go back on its stand on the issue, he said.

About the SC not taking up their matter after being mentioned, he said dates keep moving back and forth and the community will get a hearing. Sadiq said they have documents to show that

sadd said they have documents to show that namaz can be offered at the site five times a day, but they have restrained themselves in the interest of "peace and harmony".

Stressing that there is no dispute with the Hindus, he said, "Only 13-14 persons, who are the self-proclaimed leaders of the community, are creating problems. Now we think that we have to insist on starting namaz five times a day at the site. We will move the high court and the supreme court on this," he said. (*PTI*)

CBSE disaffiliates 20 schools for enrolling dummy students

NEW DELHI, March 22: The Central Board of Secondary Education (CBSE) has disaffiliated 20 schools, five of them in Delhi, for enrolling dummy students and ineligible candidates, its secretary Himanshu Gupta said on Friday.

The board has also downgraded affiliation of three schools.

"Pursuant to the surprise inspection conducted in CBSE schools across the country to check whether the schools are running as per the provisions and norms contained in affiliation and examination bye-laws, it was found that some schools were committing various malpractices of presenting dummy students, ineligible candidates and not maintained records properly," Gupta said.

"After thorough inquiry, it has been decided to disaffiliate 20 schools and downgrade three schools," he added.

Five of the disaffiliated schools are in Delhi, three in Uttar Pradesh, two each in Kerala, Rajasthan, Chhattisgarh and Maharashtra, and one each in Jammu and Kashmir, Dehradun, Assam and Madhya Pradesh. The schools with downgraded affiliation are in Delhi, Punjab and Assam. (*PTI*)

Ponmudy sworn in as Minister by Governor Ravi, a day after SC nudge

CHENNAI, March 22: Senior DMK leader K Ponmudy was on Friday sworn in as Minister by Tamil Nadu Governor RN Ravi, a day after the Supreme Court's nudge.

About three months after he lost his post following his conviction by the Madras High Court on 19 December 2023 in a disproportionate assets case, Ponmudy is now again the Tamil Nadu Minister for Higher Education.

Water storage in country's key reservoirs at just 38%: Official data

NEW DELHI, March 22: Ahead of the summer season, the live storage capacity in India's 150 primary reservoirs stands at just 38 per cent of their total capacity, which is less than the last decade's average for the same period, according to data. Cities like Bengaluru are already grappling with a shortfall of around 500 million litres of water per day (MLD), against a demand of 2,600 MLD. Karnataka, among other states, registered lower storage levels compared to the same period last year, according to the weekly bulletin by the Central Water Commission.

Bengaluru hosts 14,000 borewells with 6,900 of them having dried up. Water bodies have either been encroached upon or have dried up. The city requires 2,600 MLD of water, out of which 1,470 MLD is sourced from the Cauvery River and 650 MLD from borewells, Karnataka CM Siddaramaiah had told reporters.

Several other states, including Himachal

Pradesh, Punjab, Madhya Pradesh, Tripura, Rajasthan, Bihar, Maharashtra, Uttar Pradesh, Gujarat, Chhattisgarh, Andhra Pradesh and Telangana (two combined projects in both states), and Tamil Nadu, also reported lower storage levels compared to last year. The total live storage capacity of these 150 reservoirs is 178.784 BCM, which accounts for about 69.35 per cent of the nation's total live storage capacity estimated at 257.812 billion cubic metres, according to official data.

According to the reservoir storage bulletin

on Thursday, the live storage available in these reservoirs is 67.591 BCM, representing 38 per cent of their total live storage capacity. However, during the corresponding period last year, the live storage available was 80.557 BCM, with an average of 72.396 BCM over the past decade.

Thus, the current live storage in these 150 reservoirs amounts to 84 per cent of the storage during the same period last year and 93

per cent of the average storage over the past decade.

"The overall storage position in the country is lower than the corresponding period last year and also falls short of the average storage over the past ten years for the same period," stated the bulletin.

The Southern region, which includes states like Andhra Pradesh and Telangana (two combined projects in both states), Karnataka, Kerala, and Tamil Nadu, monitors 42 reservoirs with a total live storage capacity of 53.334 BCM.

As of the Reservoir Storage Bulletin dated 21.03.2024, the total live storage available in these reservoirs is 12.287 BCM, which constitutes 23 per cent of their total live storage capacity.

This marks a decrease compared to the storage levels during the corresponding period last year (39 per cent) and the average storage over the past ten years (32 per cent). (PTI)

'BJP to go solo in Lok Sabha and Assembly elections in Odisha'

BHUBANESWAR, March 22: The BJP will go solo in the Lok Sabha and assembly elections in Odisha, state party president Manmohan Samal said on Friday.

Talks on pre-poll alliance were being held between the ruling BJD and the opposition BJP for the past few days.

"Bharatiya Janata Party (BJP) will fight this election alone in all 21 Lok Sabha and 147 Assembly seats to create a developed India and a developed Odisha under the visionary leadership of Hon'ble Prime Minister Shri Narendra Modi to fulfil the hopes, aspirations and aspirations of four and a half crore Odiyas," Samal said in a post on X.

Earlier this week, Union Home Minister Amit Shah had said in Delhi that BJP national president J P Nadda will take a final call on the alliance with the Biju Janata Dal (BJD).

Samal, in his post, also thanked BJD president and Chief Minister Naveen Patnaik for his party's support to the BJP-led NDA government at the Centre on various issues for the last 10 years.

"We feel that the states that have dual engine governments across the country, make extensive development and accelerate welfare work for poor," he said.

The BJP state president also claimed that many of the welfare schemes of the Modi government are not reaching the grassroots level, and the poor people of Odisha failed to the benefits. The BJD and the BJP were in alliance for around 11 years between 1998 and 2009 and fought three Lok Sabha and two Assembly elections together. (PTI)

BJP has faith in dictatorship, not in Constitution, alleges Karnataka CM Siddaramaiah



BENGALURU, March 22: Accusing BJP-led NDA government of freezing Congress' bank accounts fearing defeat in the coming Lok Sabha polls, Karnataka Chief Minister Siddaramaiah on Friday expressed hope that the people of the country will clearly reject the saffron party and "save" India.

BJP has no faith in democracy and Constitution, but has faith in dictatorship, he alleged, as he demanded that free and fair elections

Claiming that the money voluntarily donated by the people was in the Congress accounts, Siddaramaiah expressed outrage about freezing of the entire account for a "small technical reason" and termed it as a "dictatorial attitude".

Speaking to reporters here, he said: "BJP troubling Congress like this so as to stop it from contesting the election is dangerous for democracy. This is condemnable." BJP has the mentality of

BJP there should be inequality, caste system should be strengthened, unemployment should increase, farmers' problems should not be solved.

BJP's intention is that Congress should not fight against these issues, he further said, adding that 'the bank accounts have been frozen so that the Congress party does not have money for elec-

"In the name of CAA, Pulwama, Ayodhya, how many more years will you emotionally mislead Indians? You are not responding to the problems of people, but instigating them emotionally..... The people of India will remove you from power this time," he said.

AICC general secretary incharge of Karnataka Randeep Singh Surjewala alleged that the accounts of Congress -- the principal opposition party in India -- are frozen just ahead of the elections and claimed that "democracy is under attack.'

He accused BJP of using muscle and money power to lure opposition legislators and leaders in various states going against the Constitution or anti-defection law.

"Governors are now used as BJP tools, Election Commission is captured by a sinister law, ED and Income Tax departments are unleashed to conduct raids ahead of elections in various states," Sur-

Allahabad HC declares UP Board of Madarsa Education Act 'unconstitutional'

LUCKNOW, March 22: The Allahabad High Court Friday declared the Uttar Pradesh Board of Madarsa Education Act, 2004, "unconstitutional" and violative of the principle of secularism, and asked the state government to accommodate current students in the formal schooling system.

A division bench comprising Justice Vivek Chaudhary and Justice Subhash Vidyarthi of the Lucknow bench of the court declared the law ultra vires on a writ petition filed by a person named Anshuman Singh Rathore.

In his reaction to the order, UP Madrasa Education Board Chairman Iftikhar Ahmed Javed said the board will study the decision and decide the further course of action.

"Now after 20 years, the Madrasa Education Act has been declared unconstitutional. Obviously there has been some mistake somewhere. Our lawvers could not present their case properly before the court," he said.

Senior All India Muslim Personal Law Board (AIMPLB) member Maulana Khalid Rashid Farangi Mahali said the order should be challenged in the Supreme Court.

The petitioner had challenged the constitutionality of the UP Madarsa Board as well as objected to the management of madarsa by the Minority Welfare Department, rather than the edu-



The petitioner and his counsel submitted that the Madarsa Act violates the principles of secularism, which is the basic structure of the Constitution, fails to provide quality compulsory education up to the age of 14 years/Class-VIII as is mandatorily under Article 21-A; and fails to provide universal and quality school education to all the children studying in madarsas.

"Thus, it violates the Fundamental Rights of the students of the madarsas," they claimed.

Madarsa Board is providing religious education as well as religious instructions to the students, but the State has sufficient power to impart such education under the Constitution of India and is rightly permitting such education.

"Providing religious education and instructions is not barred or illegal. For such religious education a separate Board is necessarily required, which needs to have members of such particu-

There are about 25,000 madrassas in Uttar Pradesh of which 16,500 are recognised by the Uttar Pradesh Madrassa Education Board. Of them, 560 madrassas receive grants from the government. Apart from this,

Javed said that the High Court's

order will have a major impact on government-aided madrassas. If the Madrasa Education Act is repealed, teachers of aided madrasas will become unemployed, he said.

"In 2004, the government itself enacted the Madarsa Education Act. Similarly, Sanskrit Education Council has also been formed in the state. The objective of both the boards was to promote languages like Arabic, Persian and Sanskrit,' he said.

On the question whether this decision of the High Court will be challenged in the Supreme Court, Javed said, "Now it is for the government to decide, because the court has given orders to it."

AIMPLB member Farangi Mahali said this order of Allahabad High Court should be challenged in the Supreme Court.

He said the Muslim community has established madrassas as per its constitutional rights, "just like there are Sanskrit schools".

"Modern education is also being given in madrassas. If the Madrassa Education Act itself is abolished, then teachers of hundreds of madrassas in the state will become unemployed and there will be a question mark on the future of the children studying in them," he said.

SC denies bail to BRS leader K Kavitha in Delhi excise policy case, asks her to approach trial court

NEW DELHI, March 22: In a setback to BRS leader K Kavitha, the Supreme Court on Friday refused to grant her bail in the money laundering case related to the alleged Delhi excise policy scam. The development came a day after Delhi Chief Minister Arvind Kejriwal was arrested by the Enforcement Directorate in the same case.

A bench of Justices Sanjiv Khanna, MM Sundresh and Bela M Trivedi asked Kavitha to approach the trial court, saying it is a practice which this court is following and cannot bypass

'Îssue notice. Counter affidavit shall be filed in six weeks. Rejoinder, if any, in six weeks. It will be open to the petitioner to move the trial court or invoke any other remedy for grant of bail," the bench said, adding all pleas and contentions available to the petitioner are left open. It clarified that the court has not made any

comments on merits of the case. The bench said as far as Kavitha's plea challenging the provisions of the Prevention of Money Laundering Act (PMLA) is concerned, the court is issuing notice to the ED and seeking

"The petition challenging the provisions (of

PMLA) will come up with the pending matters," the bench told senior advocate Kapil Sibal, appearing for Kavitha. At the outset, Sibal told the bench that he has one request to the court that he should not be asked to go to the high court.

"Please see what is happening in our country. People are being arrested on the basis of an approver's statement. I am very upset," he said.

The bench told Sibal, "As a counsel, you should never be upset. Don't be so emotional. Main writ petition can be put up for hearing with other petitions (pending matters) in July. As far as bail is concerned, we are very clear, you have to go to the trial court."

When Sibal referred to the arrest of former Jharkhand chief minister Hemant Soren and other political leaders, the bench asked him not to make political statements. "We have been very clear and uniformly fol-

lowing this practice in this bench. All of us in principle agree we should not, because there is a political person or someone who can directly afford to come to the Supreme Court, bypass all the statutory and constitutional forums," the

Sibal then referred the statement made by the

ED in the court last year in September that she is not an accused. The bench said it is not going into the merit of the case at the moment.

"Mr. Sibal, what you are asking us to do is, according to us, not permissible. You see, what is going to happen if this court is going to entertain Article 32 petitions in all matters where a person can afford to come directly to the Supreme Court. This can't be done," the bench said.

Sibal told the bench that he will approach the trial court for relief. Not pleased by the court's decision, Sibal said, 'If history of this court is visited, this will not be

"Let's see," Justice Khanna told the veteran lawyer tersely.

The bench ordered that if any bail application is filed by Kavitha before the trial court, it should be adjudicated expeditiously.

Kavitha had moved the top court challenging her arrest by the ED in the Delhi excise policy case. A member of the Telangana Legislative Council and daughter of former state chief minister K Chandrashekar Rao, Kavitha was arrested on March 15 and remanded in the ED's custody till March 23. (PTI)

Akhilesh Yadav does not allow anyone from backward classes to be leaders: OP Rabhar

BALLIA (UP), March 22: SBSP chief and Uttar Pradesh's Panchayati Raj Minister Om Prakash Rajbhar on Friday hit out at Samajwadi Party president Akhilesh Yadav, accusing him of "betraying" leaders from the backward classes, Dalits and minorities.

Rajbhar, whose party is part of the ruling National Democratic Alliance, said Yadav's allies are quitting the opposition alliance as he does not want leaders from the backward communities to rise.

"Akhilesh ji does not want to take anyone along. He does not want to allow any person from backward class, Dalit community or minority community to become a leader," the Suheldev Bharativa Samaj Party (SBSP) chief said while speaking to reporters at his party's office in Rasra here.

"Be it Jayant Chaudhary, Om Prakash Rajbhar, Dara Singh Chauhan, Swami Prasad Maurya (all SP leaders or leaders of parties



part of its alliance), everyone is saying the same thing. The SP leaders are betraying the backward class, Dalit community and Muslim class. This is the reason why everyone is leaving him (Akhilesh Yadav)," said Rajbhar.

On Apna Dal (Kameravadi) not being given any Lok Sabha seat in Uttar Pradesh under the INDIA bloc, Raibhar said that if the leaders of Apna Dal (K) want to join the NDA, then they are welcome. Apna Dal (K) has expressed displeasure over not being given a

single seat under the INDIA bloc after Yadav said that "the alliance between Apna Dal (K) and the Samajwadi Party was for the 2022 Assembly polls and not the 2024 elections.

Rajbhar's party had contested the 2022 assembly polls in alliance with the Samajwadi Party and won six seats. Later however, he parted ways with the SP. Rajbhar who had contested the 2017 assembly election in UP with the BJP returned to the NDA fold and was sworn in as a minister recently.

Asked about Delhi Chief Minister Arvind Kejriwal's arrest by the Enforcement Directorate (ED) in the excise policy case, Rajbhar said, "The country's money has been misused. Action is being taken against Kejriwal only after he was found guilty in the investigation," he said.

The ED is an autonomous agency and it is doing its work, he added. (PTI)

Lalu gave poll ticket to daughter after taking her kidney: Bihar BJP chief

BJP president and Deputy Chief Minister Samrat Chaudhary on Friday accused RJD supremo Lalu Prasad of "selling tickets" of Lok Sabha polls to aspirants, alleging that he didn't even spare his daughter and took a kidney from her before making her a candidate

In a strong rebuttal, Prasad's Singapore-based daughter Rohini Acharya, who donated one of her kidneys to his ailing father in late 2022, said that she will reply court of the people.

Making her debut in electoral police, Acharya is contesting the Lok Sabha polls from Bihar's Saran constituency on RJD ticket.

Talking to reporters in Patna, Chaudhary said, "Lalu Prasad is a politician who is an expert in selling tickets. He did not even spare his daughter. First, he took a kidney from her and then gave her a Lok Sabha ticket".

death toll due to the suspected consumption of spurious liquor in Punjab's Sangrur district has risen to 14 as six more people succumbed on Friday, officials said.

Police said they have arrested two more people. With this, a total of six people have been nabbed in connection with the case.

Earlier on Thursday police had recovered ethanol and raw material used for making alcohol.

"Fourteen people have died in this incident so far. We have made two fresh arrests in the case. Investigations are on and culprits

will not be spared,' Deputy Inspector General of Police, Harcharan Singh Bhullar told PTI on Friday.

Police had earlier suggested that the sale of spurious liquor could be part of an attempt to lure voters ahead of the Lok Sabha elections. On Wednesday, five people died

allegedly after consuming spurious liquor and some were hospitalised. The next day, three more people succumbed during treatment at Patiala's Rajindra Hospital.

On late Thursday night, two more people died while four others succumbed his morning, taking the total death in the incident to 14.

Officials said that most of the deaths have taken place in different villages under Dirba block of Sangrur, a few deaths were also reported from Sunam.

Punjab Finance and Excise and Taxation Minister Harpal Singh Cheema, who is under fire from the opposition over the deaths in Gujran village which falls in his Dirba assembly constituency, had on Thursday expressed grief and said whosoever responsible for this incident will not be spared.





ACTING IS ABOUT BEING ABLE TO TRY NEW THINGS: JAKE GYLLENHAAL ON HIS VARIED FILMOGRAPHY

NEW DELHI, March 22: Acting is all about using one's skills to try new things, says Hollywood star Jake Gyllenhaal, who didn't mind sweating it out in the gym to play a former UFC

boxer in his new film "Road House". In a career of over 20 years, the actor has created a rich tapestry of diverse performances with films such as "Brokeback Mountain", "Zodiac", "Source Code", "Prisoners", "Nightcrawler", "Nocturnal Animals", "Enemy", "Spider-Man: Far From Home" and "Ambulance".

The actor said not a lot of thought has gone into building his filmography but his choices constantly evolve with "relationships, people and things".

"I love different genres. I like the idea of being able to use my skills to try new things, try and test them and push them. I think the idea of acting, in particular, is about the fun of being able to change and try a new outfit or a different behaviour," Gyllenhaal told PTI in an interview.

"I try to use the joy of change that is inherent to acting in the choices that I make. And I try to move with things that bring me joy. That's really at the heart of it for me," he added. "Road House" is a remake of late

Hollywood star Patrick Swayze's

1989 movie of the same name. It was released on streaming service Prime Video on Thursday.

In this new take, Gyllenhaal stars as a former UFC (Ultimate Fighting Championship) middleweight fighter who ends up working at a roadhouse, an old-fashioned term for a small bar on the main road in a city or town. The 43-year-old actor underwent a

gruelling workout regime to get in shape for the movie, in which he is pitted against world famous professional mixed martial artist (MMA) and boxer, Connor McGregor.

Gyllenhaal said he likes to push himself physically, something that he has learnt from his father, filmmaker Stephen Gyllenhaal.

"I am a physical person. Since I was a kid, I have loved sports and my dad was always very athletic. He instilled that in me and I found that it's so helpful, particularly as a performer, to be in a place where you can deliver things for the stage.

"Being in shape has always been so helpful to me. And then also mental health. It's so good to be in shape and have that outlet. I've always found it an anchor for me," he added.

With the character he has played or wants to essay on screen, Gyllenhaal said he embraces the "physical, mental and intellectual challenge" as part of the development process.

"And this proved to be fun, to create a character who I could get in great shape and work with fun people who I enjoy working with. I like pushing myself. I think that's interesting. And when a role gives me that opportunity, I love to do that.'

"Road House", directed by Doug Liman of "The Bourne Identity", "Mr & Mrs Smith" and "Edge of Tomorrow" fame, features Gyllenhaal as Dalton, an ex-UFC fighter trying to escape his dark past and his penchant for violence.

Dalton, as per the official plotline, is barely scraping by on the reputation that still precedes him when he is spotted by Frankie, owner of a roadhouse in the Florida Keys. She hires him to be her new bouncer in hopes of stopping a violent gang, working for crime boss Brandt from destroying her beloved bar.

But the stakes get higher with the arrival of ruthless gun-for-hire, Knox. As the brutal brawls and bloodshed escalate, the tropical Keys prove more dangerous than anything Dalton ever faced in the Octagon.

Gyllenhaal had the opportunity to collaborate with the original movie's star Swayze, when they worked on

the 2001 cult classic "Donnie Darko".

"Patrick and I never spoke about 'Road House' in particular, though he knew that I was a huge fan of his. All of his films, like 'Point Break', I've watched maybe hundreds of times, and then 'Dirty Dancing' and 'Ghost' and so on," he said, recalling the actor, who passed away at the age of 57 in 2009 after a battle with pancreatic cancer.

But his version of "Road House" stands alone in a lot of ways, the actor

"It is a reimagining of the idea. It definitely takes some of the ideas from the original. There is a difference between the two. In this one, there is a real sense of humour. There's a different sense of tone and that tone comes from Doug Liman, our director, who is such a funny guy, but also does action so well.

"He also understands the minutiae of performance in those scenes. And so there are similarities in a way, but ultimately it is so wholly a Doug Liman film and that's what makes it different," Gyllenhaal added.

India, Afghanistan play out goalless draw in FIFA WC Qualifiers

March 22: India played out a against draw Afghanistan after both sides failed to turn their opportunities into goals in a Group A fixture of the 2026 FIFA World Cup

It was end-to-end contest in the first half on Thursday night with India coming close to scoring through Manvir Singh on two occasions and the hosts too had their share of chances.

With this result, India climbed to the second spot in Group A with four points from three matches, followed by Kuwait, who are on three points from as many games.

The equation was quite clear for both teams. A win would do either side a world of good.

India have provisionally taken the second spot in Group A, three points ahead of Kuwait, who lost to Qatar 0-3 earlier in the night. Afghanistan, following a draw and to losses are fourth in the group.

A feisty midfield battle ensued in the opening exchanges as lunging tackles were frequently on display at the Damac Stadium. While Afghanistan looked to use their pace and physical built to assert dominance, India were intent on playing a passing

Vikram Partap Singh, who had earned his senior national team debut in January, made the starting XI for the first time, and was a constant thorn in the flesh of the Afghanistan defence.

The forward kept drifting be-

often switching with Manvir, which caused much confusion in the Afghanistan ranks.

With India and Afghanistan resorting to open football, the first half (45+3) saw a wave of attacking moves but the strikers were not able to come alive in the final third, leaving coaches Igor Stimac and Ashley Westwood a bit frustrated as they shouted instructions from the

Despite India's control over the game, Afghanistan kept finding chances, especially on the counter. Mosawer Ahadi was released down the right flank, as he cut in and unleashed a leftfooted curler that India custodian Gurpreet Singh Sandhu grabbed with both hands. Manvir had more than one opportunity to score in the first half itself. A corner from Chhangte, and a cross whipped in by fullback Nikhil Poojary were great chances for the India forward to score, but both went begging, as the first half came to a close.

After Manvir, it was Vikram Pratap's turn in the second half to miss a couple of chances.

While on the first occasion. the ball was just a yard too far, the 22-year-old managed to wriggle past his marker on the second opportunity, only to run into a cul-de-sac, where the angle was too narrow for him to take a crack at the goal.

His last opportunity came just minutes ahead of the hour mark, when he managed to get into the six-yard box unmarked, and connected a header onto a cross by Akash Mishra. But the effort

came to an end. A mistimed tackle earned him a booking, and head coach Stimac took the opportunity to replace him with Brandon Fernandes.

Afghanistan kept resorting to counter-attacks and had arguably their best scoring opportunity in the 62nd minute when Rahmat Akbari's low cross found Omid Popalzay in the Indian box, but Rahul Bheke intervened just in time to deny the Afghanistan midfielder.

Stimac made a final throw of the dice with a quarter of an hour left on the clock, bringing on Liston Colaco, Mahesh Naorem, and Deepak Tangri. Colaco found a lot of joy down the right, frequently sending in crosses, but the Afghanistan defence

Vikram's night, however, soon managed to deal with them. Subhasish Bose, who had earlier replaced Mishra, was added to the list of Indian players who managed to get a free header inside the Afghanistan box, as he nodded a Colaco corner inches wide of the target.

Srikanth, though, secured a place in the quarterfinals by defeating top seed Lee Zii Jia of Malaysia 21-61 21-15, while Rajawat got the better of Lei La Xi of China 21-14 21-13 to clinch a last-eight berth.

George struggled against French shuttler Alex Lanier before prevailing 18-21 22-20 21-18 in gruelling 71-minute contest to book a quarterfinal berth. Srikanth will take on Lee

MELBOURNE, March 22: For the third Formula 1 Grand Prix in a row, controversies off the track are threatening to overshadow the almost pre-

dictable action on it. News this week ahead of the Australian GP that the FIA's Ethics Committee had cleared its president, Mohammed Ben Sulayem, from "interference of any kind" at two F1 events last year was followed quickly by a social media post from Susie Wolff, director of the all-female series F1 Academy and who is married to Mercedes F1 boss Toto Wolff, announcing that she had filed a criminal complaint in the French courts against the sport's governing body for statements made about her in De-

It's all against the backdrop of ongoing furor surrounding Red Bull Racing and its team principal Christian Horner.

Mercedes' star, seven-time world champion Lewis Hamilton, was quick to support Wolff's legal action.

"I think she's so brave, and she stands for such great values," Hamilton said Thursday at Melbourne's Albert Park circuit. 'She's such a leader. And in a world where often people are silenced, for her to be standing up sends such a great message.

The off-track issues continue at Red Bull Racing, where a recently suspended team employee has exercised the right to appeal Red Bull's clearance of alleged misconduct by Horner and filed a formal complaint with the FIA.

The chatter about Red Bull at Albert Park, therefore, hasn't been about its all-conquering RB20 car, which has secured perfect 1-2 results at the seasonopening events in Bahrain and Saudi Arabia, but whether Max Verstappen was preparing to

leave for Mercedes. "I'm happy within the team," the three-time F1 world champion said Thursday, rejecting speculation about a switch. "Of course, it's very important that we try to keep the key players in the team for a longer period of time because that's where the performance is. And at the end of the day, it's a performance business.'

Verstappen is the favorite Sunday to take his third straight win for 2024, his second at the Albert Park track in as many years, and his record-equaling 10th straight that dates to last year's Japanese Grand Prix.

Verstappen was secondfastest in the first of Friday's two practice sessions at Albert Park, finishing .018 seconds behind McLaren driver Lando Norris' time of 1 minute, 18. 564 seconds. Mercedes' George Russell was third-fastest, .033 behind Norris.

The top seven cars were separated by a tenth of a second. Ten minutes were lost during the one-hour session after Alex Albon lost control and slammed into a wall, escaping without injury but damaging his Williams.

Sergio Pérez, who was sixth-fastest in the first practice, is again expected to follow Verstappen home for another 1-2 Red Bull finish, with the Mexican driver in far more stable form than last sea-

Ferrari remains its closest rival to the Red Bulls, with Charles Leclerc, fourth-fastest in the opening practice, hoping to lock out the front row with Verstappen for the sixth straight event and be more competitive in the Melbourne

"We're in a better situation compared to last year," Leclerc said. "However, we are speaking about maybe four tenths (of a second) a lap in the race, which is still significant. I am more optimistic, not looking at the gap, but more looking at the overall situation at the team . . . " Ferrari's performance here could be compromised after Carlos Sainz declared he's ready to return to

the cockpit, but not feeling 100% after surgery for appendicitis ahead of the last race in Saudi Arabia.

The Spanish driver, who is out of contract at the end of the season, with Hamilton set to take his drive from 2025, said there's a chance he could be replaced for the second straight race by Ferrari's standout reserve driver Oliver Bearman, who is in Melbourne racing in F2. "I'm not stupid, and if I don't feel good tomorrow — I will be the first one to raise my hand and say that I need another two weeks until the next race," Sainz said.

McLaren says it's in a contest with Mercedes to be F1's thirdfastest team, meaning Oscar Piastri is more likely than Australian countryman Daniel Ricciardo to finish on the podium on home soil. Ricciardo is racing for mid-grid team RB, known last year as AlphaTauri and the second team owned by Red Bull. (AP)

CHANDIGARH, March Rishabh Pant's resilient return to the cricket field in multiple roles will be the focus when Delhi Capitals take on Punjab Kings in their IPL opener here on Saturday, both teams hoping to erase the disappointment of below-par performances in the last season.

Pant's miraculous escape from a lifethreatening car crash in December 2022 has now become a tale of perseverance after the big-hitting wicketkeeper-batter made a faster than expected recovery to

He has been cleared to play as a keeper-batter and has the additional responsibility of captaining the side, taking back the position from David Warner, who led DC to a ninth-place finish in the 10-team tournament last

"He (Pant) has probably batted more in the last week than he has ever batted leading into most of the IPLs. I think from his point of view, he wants to get a bit of trust back in his body again," said DC coach Ricky Ponting on Thursday ahead of the match to be played at the newly-constructed Maharaja Yadavindra Singh cricket stadium in Mullanpur here.

It has taken 15 months of hard work, courage and determination for Pant to be ready to lead DC again. He is a massive shot in the arm for the team whose best-ever performance in the IPL till

date is a runners-up finish in 2020. It is not yet clear whether Pant will start his keeping duties immediately. In case he doesn't, DC will fall back on either West Indian Shai Hope or South Africa's Tristan Stubbs. DC have a potent fast bowling arsenal, backed up by an explosive batting lineup.

Warner, who recently retired from the Test cricket, will be hoping to make a mark and secure a spot in the T20 World Cup-bound Australian side.

In Prithvi Shaw, Mitchell Marsh, Pant and Stubbs, DC have explosive batting line-up, while their bowling attack will be led by Anrich Nortje in the company of Indian veteran Ishant Sharma, Mukesh Kumar, Kuldeep Yadav and Axar Patel.

CHANDIGARH, March 22: Rishabh Pant is experiencing an entire gamut of emotions from nervousness to excitement as he gears up for his first competitive game in nearly 15 months when he leads Delhi Capitals in their IPL opener against Punjab Kings here on Saturday.

"But I have been playing since childhood, so it doesn't go away that easily. So, the more I practice, the better chance I will give myself as a crick-



eter," he added. Having endured a painful break, Pant

doesn't want to look too far ahead. "I just want to be there in the moment. I don't think much ahead. I take one day at a time, and give my 100%. Every time I take field, I love this game more and more," he added while talking about Delhi Capitals' pre-season camp

in Visakhapatnam. Just like his batting, Pant wants to keep his team's approach as simple as

"Most of the conversations are pretty simple. We just want to go out there, have fun, not complicate things and give our 100% in all the games," he

Head coach Ricky Ponting couldn't be happier that his skipper is back where he belongs.

"We are about to start an IPL, it's re-

ally an exciting time of the year. It becomes more exciting when your captain is back in your team. Last year, we missed him. He is our leader. He is the heartbeat of this franchise and having him back is going to make this team a lot stronger," Ponting said when asked about Pant's return.

Pant termed Pant's comeback as an 'amazing story that cricket loving people of India should be proud of." "When I met him during the IPL last
