PM inaugurates Haryana section of Dwarka Expressway

GURUGRAM (Haryana), March 11: Prime Minister Narendra Modi on Monday inaugurated 19-km long Haryana section of Dwarka Expressway, which will improve traffic flow and ease congestion between Delhi and Gurugram on NH-48 and will also boost economic activities in the National Capital Region.

The total length of Dwarka Expressway is 29 kilometre, out of which 18.9 km falls in Haryana, while the remaining 10.1 km is in Delhi. On March 9, 2019, the then Union ministers, Sushma Swaraj, Arun Jaitley and Nitin Gadkari had laid the foundation stone for Dwarka Expressway.

Addressing a gathering after inaugurating the Haryana section of the expressway, Modi said this will change the travel experience between Delhi and Haryana forever and will shift gear not just in vehicles but also in the lives of the people of the region.

"The inauguration of the Haryana section of Dwarka Expressway and the launch of 112 National Highway projects mark a milestone in the country's infrastructure development

"Dwarka Expressway will boost economic activities in the National Capital Region," he said.

The prime minister mentioned many long-pending projects that were completed by the present government such as Eastern Peripheral Expressway (announced in 2008 completed in 2018), Dwarka Expressway too was stuck



for the last 20 years. "Today, whatever work our government lays the foundation stone for, it works equally hard to complete it on time. And then we do not see whether there are elections or not," he said.

Modi added that projects like laying down of lakhs of kilometres of optic fibers in villages, airports in small cities, rural roads, were completed irrespective of the election time. The prime minister also held a road show here.

"Construction of expressways opens a lot of opportunities for rural India and Dwarka Expressway is itself a big example (of it)," he said. The prime minister said his government has successfully completed big infrastructure projects on time.

"My government has completed big infrastructure projects, including Dwarka Expressway, Eastern

Peripheral Expressway, Delhi-Meerut Expressway on time.

"These projects, along with the expansion of metro lines and the construction of international airports, are aimed at easing traffic congestion and reducing pollution in the region," he asserted.

The prime minister also noted that development of good roads also helps 2-wheeler and 4-wheeler automobile companies.

"Construction of expressways also helps development of industrial corridors which creates more employment opportunities."

The prime minister said the union government is focusing on construction of 9,000 km of high-speed-access controlled highways, out of which construction of 4,000 km has been completed.

He reminisced how, in the past, the area where the expressway is now built was considered unsafe,

with people avoiding it even after sunset.

However, today, it serves as a hub for major corporations, contributing to the rapid development of the National Capital Region (NCR). Dwarka Expressway is India's first elevated 8-lane access control urban expressway, being constructed at an estimated cost of ₹ 9,000 crore, as part of the Centre's ₹ 60,000 crore highway development plan in the NCR to decongest the national capital.

The Haryana section of Dwarka Expressway has been built at a cost of around ₹ 4,100 crore and includes two packages of 10.2-km Delhi-Haryana Border to Basai Rail-over-Bridge (ROB) and 8.7-km Basai ROB to Kherki Daula.

It will also provide direct connectivity to the IGI Airport in Delhi and Gurugram Bypass.

Haryana Chief Minister Manohar Lal Khattar and Minister of Road Transport and Highways Nitin Gadkari were present at the event. Gadkari said Dwarka Expressway is a state-of-art project.

"The government saved 20 per cent in construction cost against estimates in awarding contracts of Dwarka Expressway," Gadkari said. He also said there were projects worth ₹ 65,000 crore in Delhi and its nearby areas for construction of roads, highways and expressways.

Out of these, projects worth ₹35,000 crore have been completed and the rest will be completed by December, he added. (PTI)

Markets break two-day rally on weak global trends

MUMBAI, March 11: Stock market benchmark Sensex declined by 616.75 points on Monday, snapping its two-day gaining streak due to selling in metal and banking shares amid weak trends in the global markets.

Taking a breather after a record-breaking rally, the 30-share BSE Sensex declined by 616.75 points or 0.83 per cent to settle at 73,502.64 due to profit taking. During the day, the barometer tanked 685.48 points to 73,433.91.

The broader Nifty slumped by 160.90 points or 0.72 per cent to close at 22,332.65.

"In the short term, Nifty could experience weakness, possibly leading to a decline toward the range of 22,200-22,250. Looking at the upside, immediate resistance is identified at 22,400 based on closing prices," Rupak De, Senior Technical Analyst at LKP Securities, said.

Among Sensex firms, Power Grid and Tata Steel fell more than 2 per cent. HDFC Bank, State Bank of India, IndusInd Bank, Hindustan Unilever and NTPC

were among the major losers. Nestle, Bajaj Finserv and Bajaj Finance were among the gainers.

"Continued sell-off in global markets due to uncertainty over rate cuts impacted the domestic market sentiment, which is currently at an overbought level. The stronger-than-expected US non-farm payroll data and caution ahead of the release of US inflation data tomorrow kept investors on the edge," said Vinod Nair, Head of Research, Geojit Financial Services. "The broader market continued its underperformance due to valuation concerns, while investors are rebalancing their portfolios to include safe haven assets like gold," he added.

In the broader market, the BSE smallcap gauge declined 2.01 per cent and midcap index dipped 0.24 per cent.

Among sectoral indices, telecommunication plunged by 2.40 per cent, metal by 1.39 per cent, utilities by 1.25 per cent, realty by 1.16 per cent, and energy by 1.15 per cent. Healthcare was the only gainer.

Govt moves, industry efforts set to transform healthcare, insurance penetration among women: experts

KOLKATA, March 11: Concerted efforts by the government and private insurance companies are expected to bring a sea change in healthcare and insurance penetration among women, which is extremely low at present, experts said. The Insurance Regulatory and Development Authority of India (IRDAI) has also been taking several measures to make health insurance products standardised, seeking to enhance coverage among all citizens, including women. In line with IRDAI's ambitious vision of achieving "Insurance for All by 2047," the industry is striving to cater to diverse customer segments, ensuring comprehensive coverage and distribution.

According to P Nanda Gopal, Founder and CEO of the Insurtech platform Upsure, rising medical inflation is compelling the financially savvy to choose health insurance over other necessities. As general literacy and awareness among women increase, they would be more active in financial decision-making, he said.

According to the National Family Health Survey India data, only about 30 per cent of women in India aged 15-49, were covered



under health insurance between 2019-2021. Nanda Gopal stated there are multiple reasons behind the low insurance coverage.

A recent survey undertaken by Future Generali India Insurance Company along with Unomer suggests that only one out of every five women (nearly 21 per cent) bought their health insurance policy independently and only one out of every three women (32 per cent) was aware of the coverage details of their health insurance. "I think the idea (of Insurance for All) is to make sure that your product covers every single cohort which is customized to every eco-

nomie segment, every social segment, said Anup Rau, Managing Director and CEO, Future Generali India Insurance.

"So, we thought that we would start over here. While we have got other innovative products, we thought we would start with the largest unaddressed minority in this country which is women by any metric," he said.

The company has introduced 'Health Powder' - a comprehensive policy to empower women and cater to their varied health needs.

According to the FGII Survey, nearly 75 per cent of women believe that existing health insurance policies fall short of addressing women-specific needs. Close to 94 per cent of the respondents agree that having a comprehensive health insurance plan for women would increase participation in the purchase process.

There is a need for targeted awareness campaigns and education initiatives aimed at informing women about the importance of health insurance and equipping them with the knowledge to make informed financial decisions, said Sapna Desai, Chief Marketing Officer, Manipal Cigna Health Insurance. (PTI)

after the Supreme Court's strictures on the electoral bonds issue. "After seeking nine extensions for the notification of the rules, the timing right before the elections is evidently designed to polarise the elections, especially in West Bengal and Assam," the Congress leader said. Kerala CAM Pinaray Vijayan described CAA as a communally divisive law and asserted that it will not be implemented in the state.

According to the Manual on Parliamentary Work, the rules for any legislation should be framed within six months of presidential assent or the government has to seek an extension from the Committees on Subordinate Legislation in Lok Sabha and Rajya Sabha. Since 2020, the Home Ministry has been taking extensions at regular intervals from the parliamentary committee for framing the rules. No document will be sought from the applicants, an official said. Pakistani Hindu refugees, who have been living a life of uncertainty, welcomed the government's step. Dharamveer Solanki, a leader of Pakistani Hindu refugee families in Delhi, told PTI that around 5000 from the community will receive citizenship now.

"I and my family have been waiting for this for over a decade now. We are extremely happy that we will be finally called Indian citizens. I am glad I decided to return to my homeland in 2013," Solanki said.

Over 100 people lost their lives during the anti-CAA protests or police action. On Monday, security was stepped up in Shaheen Bagh, Jamia and other areas of the national capital as well as in various states where anti-CAA protests were held in the past. On December 27, 2023, Union home minister Amit Shah said that no one can stop the implementation of the CAA as it is the law of the land and accused West Bengal Chief Minister Mamata Banerjee of misleading people on the issue. Addressing a party meeting in Kolkata, Shah said it is the BJP's commitment to implement the CAA.

The TMC, led by Mamata Banerjee, has been opposing the CAA since the beginning. The promise of implementing the controversial CAA was a major poll plank of the BJP in the last Lok Sabha and Assembly polls in West Bengal. The saffron party's leaders consider it a plausible factor that led to the rise of the BJP in Bengal.

In the last two years, over 30 district magistrates and home secretaries in nine states have been given powers to grant citizenship to Hindus, Sikhs, Buddhists, Jains, Parsis and Christians coming from Afghanistan, Bangladesh and Pakistan under the Citizenship Act, 1955.

According to the annual report of the Ministry of Home Affairs for 2021-22, from April 1, 2021, to December 31, 2021, a total of 1,414 foreigners belonging to these non-Muslim minority communities from the three countries were given Indian citizenship by registration or naturalisation under the Citizenship Act, 1955. The nine states where Indian citizenship by registration or naturalisation is given under the Citizenship Act, 1955 to non-Muslim minorities from Pakistan, Bangladesh and Afghanistan are Gujarat, Rajasthan, Chhattisgarh, Haryana, Punjab, Madhya Pradesh, Uttar Pradesh, Delhi and Maharashtra. Authorities of none of the districts of Assam and West Bengal, where the issue is politically very sensitive, have been given the powers so far. (PTI)

CAA copies burnt, 'hartal'

The Nalbari district unit of AASU took out a protest rally and also burnt copies of the Act in front of the local municipal board office. Pointing out that the Sixth Scheduled areas and states with provisions for Inner Line Permit (ILP) in the North East have been exempted from CAA, Bhattacharjya said, "Our question is, something which is bad for some parts of NE, how can it be good for the other parts. In Assam too, in eight districts it will not be enforced." He also claimed that the CAA goes against the Assam Accord, which sets March 25, 1971, as the deadline for identification of illegal migrants in this northeastern state.

The AASU had been at the forefront in protesting against the CAA since the bill proposing the legislation was brought by the central government, and has already filed a petition in the Supreme Court against the Act.

Meanwhile, students have started protesting against the CAA in different parts of the state, including in front of Cotton University in Guwahati. The Assam Jatiya Parishad (AJP), which was formed post the anti-CAA movement in the state in 2019-20, staged protests in different parts of the state. Its members displayed black flags and raised slogans against the government as they took out protest marches in several parts, including Guwahati. The UFOA has called for a statewide 'hartal' on Tuesday, its general secretary and AJP president Lurinjyoti Gogoi told PTI. "We are going forward with our programme of a hartal tomorrow. We will also take up other protests, including gherao of the state secretariat, as announced earlier", he said. Opposition political parties, student bodies and other organisations had announced intensifying protests against the CAA when the rules were notified for its implementation. Chief Minister Himanta Biswa Sarma had asked those opposed to the Act to fight it out at the Supreme Court, maintaining that protests on the streets will bear no fruit as it is already a legislation passed by Parliament. He had also warned that if political parties call for bandhs, they could lose registration as the Gauhati High Court had passed an order earlier prohibiting bandhs. With the CAA rules being issued, the Narendra Modi-led central government will start granting Indian nationality to persecuted non-Muslim migrants from Bangladesh, Pakistan and Afghanistan who came to India till December 31, 2014. These include Hindus, Sikhs, Jains, Buddhists, Parsis and Christians. The CAA was passed in December 2019 but had not come into effect as rules were not notified till now. (PTI)

Oppn parties flay CAA

"There was a misinformation campaign by the opposition that crores of Hindus from Bangladesh would enter Assam after the law was passed by Parliament, but nothing of that sort has happened," Goswami said. AIUDF MLA Ashraf Hussain told PTI that the BJP has implemented the CAA before the Lok Sabha polls as it is 'greedy for Bangladeshi Hindu votes'. "They have done it only to win this election and also to fulfil BJP's Hindutva agenda by polarising the Hindu votes," he said.

The AIUDF protested the decision to implement the CAA as 'we favour Indian citizenship for anyone coming to Assam before March 25, 1971, and it should not be based on any religion or community', Hussain said. Assam Jatiya Parishad general secretary Jagadish Bhuyan told PTI that the people of Assam had protested against the CAA but the BJP ignored their emotions and notified the rules based on the strength of their numbers. "The people of Assam will not forgive the BJP for this law which is against the interest of the Assamese people. This is not acceptable and we will continue to protest against it," he said. Assam also accused union minister Sarbananda Sonowal who hailed from the state and Assam Chief Minister Himanta Biswa Sarma of being 'puppets in the hands of the BJP government at the Centre for their selfish interests. They have committed a crime against the Assamese people'. Aam Aadmi Party (AAP) state president Bhaben Choudhury told PTI that it will be marked as a "black day in Assam's history and the BJP will be remembered as a traitor for imposing the communal and anti-community CAA".

AAP will continue to protest against this law, he said. CPI(M)'s Assam secretary Suprakash Talukdar told PTI that this is a 'politically motivated step by the central government while the matter is already in the court'.

Earlier in Parliament, the Ministry of Home Affairs in a reply to a query had said that the government had no plans to introduce the law till it remains sub-judice, he pointed out. "Notifying the rules now is just immoral and shows that the BJP does not have any respect for the rule of law. This Act is anti-Constitutional and highly communal, which violates the Assam Accord," he said. The CPI(M) will protest against it as a party and as a part of the united opposition also, Talukdar added. With the CAA rules being issued, the Modi government will now start granting Indian nationality to persecuted non-Muslim migrants from Bangladesh, Pakistan and Afghanistan who came to India till December 31, 2014. Over a hundred people lost their lives during the anti-CAA protests or police action. The law could not come into effect as rules had not been notified till now. The protests against the Act in the state were led primarily by the All Assam Students Union (AASU) and the Krishak Mukti Sangram Samiti (KMSS). The protests turned violent with five persons losing their lives to police firing in 2019 and the arrest of KMSS leader Akhil Gogoi along with four others, to be called off only with the onset of the pandemic. It subsequently led to the creation of two new political parties in the state - the Assam Jatiya Parishad (AJP), led by then AASU leader Lurinjyoti Gogoi and the Rajior Dal, headed by Akhil Gogoi. The event will witness the signing of MoUs in the presence of various agencies, with Union minister of state for culture Meenakshi Lekhi and other dignitaries, underscoring the government's dedication to fostering partnerships for the preservation of India's diverse heritage, the statement said. Centre never looks at Arunachal from political point of view: Khandu

ZIRO (ARUNACHAL), March 11: Chief Minister Pema Khandu on Monday said that the BJP-led NDA government at the Centre never looks at Arunachal Pradesh from a political point of view. Speaking at a public meeting here in Lower Subansiri district, Khandu said that the Prime Minister during his visit to Itanagar on March 9 mentioned that the government's outlook towards North Eastern states is never based on the party's strength in Parliament.

"We contribute only two MPs to the Lok Sabha and only one to Rajya Sabha but this number factor has been overlooked by Modi and since day one has been supporting the state in its accelerated development on all fronts", Khandu said. The chief minister called upon the people to look around themselves with an open mind and witness for themselves the development Arunachal has witnessed since 2014 when Narendra Modi for the first time became the prime minister.

"Earlier governments at the Centre always considered the North East unimportant as politically the states here do not contribute much in government formation at Delhi. That's the only reason for the underdevelopment of North-Eastern states. We are lucky that Narendra Modi came to power in 2014 and since then changed the fate of these states", he observed. On behalf of the people of the state, Khandu extended gratitude to the prime minister for announcing developmental projects worth ₹ 55,000 crore for the North East from Itanagar. He informed that of these ₹ 55,000 crore Arunachal Pradesh alone will get a whopping ₹ 41,000 crore worth of projects. Asserting that it's time to express gratitude and say 'thanks' to Modi,

Khandu said the best and only way to do so is by supporting and voting for the BJP candidates in the upcoming Lok Sabha as well as Assembly elections. Earlier in the day, Khandu visited the under-construction site of India's first Integrated Aqua Museum under construction at Tarin here. The project under Pradhan Mantri Matsya Sampada Yojana is expected to revolutionise the state's fisheries sector and boost livelihoods by providing additional income sources to farmers. Khandu also launched an AI-based tele-health facility at GyatiTakka General Hospital here. This pilot project being implemented in Ziro and Tawang will revolutionize healthcare delivery in the region. He also visited the Water Treatment Plant which was virtually dedicated to the people by Prime Minister Modi on March 9.

Citizenship (Amendment) Rules, 2024 enables persons eligible under CAA-2019 to apply for Indian citizenship Govt announces implementation of CAA 4 years after it was passed



NEW DELHI, March 11: The Centre on Monday implemented the contentious Citizenship (Amendment) Act, 2019, a move that comes four years after the contentious law was passed and paves the way for citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan who came to India before December 31, 2014. The rules were notified days ahead of the expected announcement of the Lok Sabha elections. With this, the Modi government will now start granting Indian nationality to persecuted non-Muslim migrants -- Hindus, Sikhs, Jains, Buddhists, Parsis and Christians from the three countries. Union copies minister Amit Shah said Prime Minister Narendra Modi has

delivered another commitment and realised the promise of the makers of the Constitution. "These rules, called the Citizenship (Amendment) Rules, 2024 will enable the persons eligible under CAA-2019 to apply for the grant of Indian citizenship," a Union home ministry spokesperson said. "The applications will be submitted in a completely online mode for which a web portal has been provided," the spokesperson added. The CAA was passed in December 2019 and subsequently got the president's assent but there were protests in several parts of the country against it, with many opposition parties speaking out against the law calling it "discriminatory". The law could not come into effect as rules had not been notified till

now. "These rules will now enable minorities persecuted on religious grounds in Pakistan, Bangladesh and Afghanistan to acquire citizenship in our nation. "With this notification, PM Shri Narendra Modi Ji has delivered on another commitment and realised the promise of the makers of our Constitution to the Hindus, Sikhs, Buddhists, Jains, Parsis and Christians living in those countries," Shah said on X. The Congress and other opposition parties slammed the government's step, alleging it is designed to polarise the coming Lok Sabha elections, especially in West Bengal and Assam. Congress general secretary Jairam Ramesh also alleged that the announcement is yet another attempt to "manage the headlines" (CONTD. ON PAGE-2)

CAA copies burnt, 'hartal' announced in Assam as Centre notifies rules Oppn parties flay CAA rules notification, BJP welcomes move

GUWAHATI, March 11: The All Assam Students' Union (AASU) and 30 indigenous organisations on Monday burnt copies of the contentious Citizenship (Amendment) Act (CAA) in different parts of the state, including Guwahati, Barpeta, Lakhimpur, Nalbari, Dibrugarh and Tezpur. The 16-party United Opposition Forum, Assam, (UOFA) announced a statewide hartal on Tuesday, besides taking up other agitational programmes in a phased manner. "We will continue with our non-violent, peaceful, democratic movement against CAA. Alongside, we will also continue our

legal fight", AASU advisor Samujjal Bhattacharjya told PTI. Bhattacharjya asserted that the indigenous people of Assam and Northeast will never accept CAA. "On Tuesday, copies of the CAA will be burnt by the North East Student Organisation (NESO) in all state capitals of the region. AASU and 30 organisations will also take out torchlight processions in Assam, and launch a satyagraha from the next day," he said. In Dibrugarh, AASU members were engaged in a scuffle with police when the latter tried to stop them from taking out a procession from their office in the Chowkidingi area of the town. (CONTD. GUWAHATI, March 11: Opposition parties in Assam on Monday flayed the BJP government at the Centre for implementing the contentious Citizenship (Amendment) Act, 2019 (CAA), paving the way for granting citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan while the BJP has welcomed it. The All Assam Students' Union (AASU), which had spearheaded a six-year agitation demanding identification and deportation of illegal immigrants in 1979, said it would fight legally against the Centre's move. Congress leader of the opposition in Assam assembly Debabrata Saikia termed the notification of CAA as "unfortunate". "When Prime Minister Narendra Modi and BJP had been saying since 2016 that all illegal foreigners will have to leave Assam, they betrayed the people of the state and brought in the CAA," Saikia told PTI. The people of Assam will make the PM and the BJP answerable for it, he



added. Rajior Dal president and MLA Akhil Gogoi said, "The process to legitimate 15-20 lakh Bangladeshi Hindus illegally living in Assam has begun. There is no other way but to come out on the street and protest against this unconstitutional act." Assam and several other northeastern states had witnessed widespread protests after the BJP-led government at the Centre moved towards amending the citizenship act in 2019. A section of the people of the region were scared that if the CAA is implemented, it would endanger their identity

and livelihood. "This is Delhi's attack on Assam and the entire country. We appeal to all to come out and protest against this law peacefully and democratically," Gogoi told PTI. "Assam's long struggle against illegal immigration has been nullified with just this one act. This act will also open the doors for 1.7 crore Hindus living in Bangladesh to cross over to Assam. There is no other option but to fight against this act with full force. It has to be an all-encompassing protest," he said. Chief advisor of AASU and North East Students' Organisation Samujjal Bhattacharjya told PTI that they will not accept the CAA and will continue to protest against it. "We are already in talks with our advocates and will continue our legal fight against its implementation," he said. Meanwhile, BJP senior spokesperson Rupam Goswami welcomed the notification of the rules of the CAA saying it was much awaited". (CONTD. ON PAGE-2)

ASDC holds talks with KAAC on autonomous state issue

DIPHU, March 11: The Autonomous State Demand Committee (ASDC) and frontal organisations on Monday held talks with the Karbi Anglong Autonomous Council (KAAC) regarding the autonomous state issue. The meeting chaired by Chief Executive Member (CEM) of KAAC, Tuliram Ronghang and attended by ASDC, Karbi Nimso Chingthur Asong (KNCA) - Karbi Women organisation and Karbi Students Association (KSA- Jemson Timung), was held at the conference hall of Old KAAC Secretariat building here on Monday. ASDC president, Chandra Kanta Terang said, "First, we discussed the longstanding demanding of the people of Karbi Anglong for creating an autonomous state under article 244 (A) of the Indian Constitution without separation from Assam. Successive governments have come and gone, but there was no positive response." On CAA Terang said, "We have highlighted in the memorandum submitted earlier to CEM, KAAC, chief minister Himanta Biswa Sarma and Union home minister Amit Shah to exclude the scheduled tribes dominated areas of Karbi Anglong from the purview of the Citizenship Amendment Act (CAA), as it may endanger the local culture and aged old practices. We also mentioned that the Uniform Civil Code (UCC), which was implemented by the Centre in 2016, should not be executed in the sixth scheduled areas. It should be exempted in the hill districts of the state, where scheduled tribes dominate." Terang said that the CEM clarified that the 'give and take' policy is not going to affect the inter-state bound-



ary between Meghalaya and West Karbi Anglong areas. It will not affect the sixth scheduled areas of West Karbi Anglong. Earlier the ASDC had submitted a memorandum to the chief minister and the Union home minister, Amit Shah for the creation of an autonomous state comprising of three hill districts of the state, namely Karbi Anglong, West Karbi Anglong and Dima Hasao. The ASDC also demanded that the CEM take up a resolution in the executive committee and pass it in the KAAC session to convince the state government to discuss it in the state legislative assembly and urge the central government to hold tripartite talks with it. ASDC said the CEM has agreed to their demands and assured the delegation that he would meet the CM within a few days.

AGP fields Phani Bhusan, Zabeed Islam for IS polls

GUWAHATI, March 11: The Asom Gana Parishad (AGP), a partner in the BJP-led government in the state, on Monday announced its candidates for the forthcoming Lok Sabha elections. It named Phani Bhusan Choudhury for the Barpeta constituency and Zabeed Islam for the Dhubri constituency. Out of 14 Lok Sabha seats in the state, BJP is contesting from 11 constituencies, AGP from two and United People's Party, Liberal (UPPL) from one. Security tightened across Assam following notification of CAA rules

GUWAHATI, March 11: Security has been tightened across the state with additional deployment of police personnel following the announcement of the implementation of the contentious Citizenship (Amendment) Act, 2019 (CAA) on Monday. All police stations have been put on an alert and barricades have been set up in major thoroughfares in almost all the towns of the state, including Guwahati, officials said. Patrolling has been intensified in the sensitive areas with opposition parties announcing that they would launch protests against the notification of the rules. The All Assam Students Union has also announced that it would burn copies of the CAA, take out torchlight processions and launch a 'satyagraha' against the notification of the rules. Earlier, Assam Police had cancelled the long leaves of its personnel till the election process was over and also in anticipation of CAA notification. In December 2019, the protests against the Act were led primarily by

the All Assam Students Union (AASU) and the Krishak Mukti Sangram Samiti (KMSS). The protests had turned violent with five persons losing their lives to police firing and the arrest of KMSS leader Akhil Gogoi along with four others, to be called off only with the onset of the pandemic. It subsequently led to the creation of two new political parties in the state-the Assam Jatiya Parishad (AJP), led by then AASU leader Lurinjyoti Gogoi and the Rajior Dal, headed by Akhil Gogoi. The Centre on Monday announced the implementation of the Citizenship (Amendment) Act, 2019 for granting citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan who came to India before December 31, 2014. With the CAA rules being issued, the Modi government will now start granting Indian nationality to persecuted non-Muslim migrants -- Hindus, Sikhs, Jains, Buddhists, Parsis and Christians -- from the three countries. APHLC stages demonstration against illegal encroachment in PGR, VGR lands

DIPHU, March 11: The All Party Hills Leaders Conference (APHLC) held a sit-in-demonstration in front of the Semson Sing Ingti Memorial Park in Diphu on Monday against the delay of the eviction drive in professional grazing reserve (PGR) and village grazing reserve (VGR) land in Kheroni, West Karbi Anglong. APHLC president, JI Kathar had said in a meeting held at Arboretum-cum-Craft Centre, Matipung here on February 20 that the Chief Executive Member (CEM), KAAC, Tuliram

Ronghang had said that the eviction process would begin by February 21. But the eviction drive has not been carried out so far. Kathar said, "The executive member of land and revenue, KAAC, Amarsing Tisso during his visit to Kheroni on February 16 had assured that by March 7 evictions would be carried out to clear encroachers from PGR/VGR land. However, till date EM Tisso has not done anything to initiate the eviction process citing various reasons. The model code of conduct is yet to be enforced and there is still time for

KAAC to carry out the eviction." Kathar mentioned that 21 bighas of land belonging to Sarthe Phangcho has been captured by two persons from Bihar. They have forcefully settled on his land. Phangcho had filed a petition in the Gauhati High Court, which directed the KAAC to evict the encroachers and hand it over to the owner. The verdict was given in 2012. The APHLC has urged the KAAC to take up the eviction drive seriously and blamed the BJP government for misleading the people.

NEW DELHI, March 11: The Archaeological Survey of India (ASI) will unveil its revamped website on Tuesday, with an aim to seek wider engagement of people with the country's rich cultural heritage, officials said on Monday. The ASI will also sign memoranda of understanding (MoUs) with various agencies for the adoption of monuments under the 'Adopt a Heritage 2.0' programme. The revamped website launch event will take place at the National Museum here, with Union minister for culture G Kishan Reddy slated to join the event virtually, according to Union culture ministry officials. "This newly upgraded platform offers diverse functionalities, with each vertical of ASI meticulously navigable, and users can effort-



lessly explore various aspects of India's rich cultural tapestry, from historical sites to educational resources," the ministry said in a statement. The revamped website is tailored to cater to "dynamic needs" of citizens across the country, it said. Students will find the website to be a valuable resource for accessing information, it added. This "comprehensive digital overhaul reflects ASI's commitment to leveraging technology for the benefit of all, ensuring that the nation's cultural treasures are ac-

cessible to a broader audience," the ministry said. In a move aimed at furthering the preservation and promotion of India's cultural heritage, the ASI has envisioned the 'Adopt a Heritage 2.0' programme. With more than 3,600 monuments under its protection across the country, the ASI recognises the importance of collaboration with external partners in ensuring safety and enhancement of visitors' experience at these cultural treasures, the ministry said. The signing of MoUs under this programme will formalise the commitment of these agencies to take up the responsibility of adopting specific monuments, contributing to their maintenance and better showcasing to public, it said. Exodus of Brahmin Leaders from Congress

In a significant political development, the Congress in Madhya Pradesh has been shaken by the departure of several prominent Brahmin leaders, including Suresh Pachauri, a veteran with nearly five decades of association with the party. This exodus, just two months before the Lok Sabha polls, comes as a substantial boost to the BJP in the state. Yadav's assertion, "Wherever Rahul Gandhi goes, Congress gets cleaned out," encapsulates the BJP's narrative of portraying the Congress as a party in disarray under Gandhi's leadership.

Pachauri's disillusionment with the Congress stems from recent decisions by the party leadership, particularly its boycott of the consecration ceremony of Lord Rama's idol in Ayodhya. His resignation from the Congress, after over five decades of service, underscores deep-seated grievances and a perceived departure from the party's foundational principles. In his resignation letter to AICC president Mallikarjun Kharge, Pachauri lamented the party's trajectory, emphasizing the need for the Congress to reconnect with its historical legacy and core values. His decision to join the BJP underlines a belief in the party's leadership, particularly Prime Minister Narendra Modi, Home Minister Amit Shah, and BJP President JP Nadda. State BJP president VD Sharma welcomed Pachauri and his associates into the party fold, emphasizing their trust in the BJP's vision and commitment to national interests. Former Chief Minister Shivraj Singh Chouhan echoed this sentiment, highlighting the departure of seasoned Congress leaders as indicative of the party's internal turmoil and leadership crisis. Pachauri's extensive political career, including his tenure in Rajya Sabha and ministerial positions, adds weight to his defection to the BJP. His decision, along with other Congress defectors, signals a seismic shift in Madhya Pradesh's political landscape, with implications for the upcoming Lok Sabha elections.

The BJP's meticulous planning and swift action in welcoming the new members highlight its organizational prowess and strategic acumen. The sight of key BJP leaders, including Chouhan and Sharma, alongside Pachauri and other former Congress leaders, symbolizes the BJP's confidence and unity in the face of electoral challenges. As the political dynamics continue to evolve in Madhya Pradesh, the exodus of Brahmin leaders from the Congress serves as a cautionary tale for the party leadership. It underscores the urgent need for introspection and course correction to stem further defections and rejuvenate the party's prospects. The BJP's gain of influential Brahmin leaders from the Congress represents a significant coup in the lead-up to the Lok Sabha polls. It underscores the BJP's dominance in Madhya Pradesh's political landscape and poses formidable challenges for the Congress as it grapples with internal dissent and leadership crises.

SBI plea for extension of deadline on electoral bond details is unsustainable

The Supreme Court of India had struck down the electoral bonds scheme as unconstitutional and manifestly arbitrary. That the Modi government would find this verdict unpalatable is not surprising, given the fact that the electoral bonds scheme was devised by it to legitimise political corruption. The govt has moved through the State Bank of India (SBI) to undermine the implementation of the judgment. The Supreme Court had directed that all the details of electoral bonds purchased since April 2019 must be made public, including the date of purchase, the name of the buyer and the denomination of the bond. For this, the State Bank of India, which was the sole agency for the transaction of electoral bonds, was asked to submit all the relevant details of the bonds to the Election Commission of India by March 6 and thereupon the Election Commission was to make public all the details by March 13.

The SBI has approached the Supreme Court on March 4 asking for more time to submit the details of electoral bond transactions. It has asked for an extension of the time till June 30. This would mean that instead of 21 days given to the SBI by the Supreme Court, the bank now wants another 116 more days to complete the work. In effect, the public will be informed about the details of the electoral bonds only after the Lok Sabha elections are over and a new government is formed. The request of the SBI has been met with widespread criticism and ridicule. All banking operations of the SBI are digitalised. According to a RTI reply given by the SBI, ₹ 60,43,005 was spent on IT system's development for the floating of electoral bonds out of a total cost of ₹ 1,50,15,338. If over ₹ 60 lakh was spent for developing an IT system for the electoral bonds scheme, how is it that the SBI now claims that certain records of the electoral bonds have been kept manually and in sealed covers at the Mumbai headquarters of the SBI?

When a bond is purchased at a designated branch of the SBI by any person or entity, that would be recorded digitally. When the bearer bond is deposited at any of the other designated SBI branches, for that too there would be a digital record. As early as in 2019, Nitin Sethi writing in the HuffPost India had shown how a bond issued by the SBI carries a secret alphanumeric code, which can be used to keep track of who bought a bond and to which party it has been donated to. Even if some of the records have been kept manually, there is no reason whatsoever to believe that accounting for 22,217 electoral bonds cannot be done in a space of 21 days. All that the SBI needed to do was to put additional personnel for the job. It is, therefore, crystal clear that the SBI has come out with a lame excuse and spurious reasons which amount to insulting the intelligence of the Supreme Court. The ulterior intent is also evident from the fact that the SBI filed its petition in the court just a day before March 6, so that missing the deadline becomes a fait accompli.

The Modi government and the ruling BJP have every reason to try and scuttle the publication of the details of the electoral bonds so far issued and redeemed. As the court itself pointed out, the scheme was so devised as to facilitate a quid pro quo. Once the break-up of ₹ 6,565 crore worth of bonds received by the BJP is known, then it can be correlated to which company or individual capitalist had donated the bond and what policy or favour was given as a quid pro quo. There is another angle which will be exposed by the publishing of the details of the electoral bonds received by the BJP. A study conducted recently by the Newsland and The News Minute of corporate donations received by the BJP shows that there are at least 30 companies, which donated a total of nearly ₹ 335 crore to the BJP in the five previous financial years, had faced action by central agencies during the same period. Of these, 23 companies had never donated to the BJP between 2014 and the year of the action taken by a central agency like the ED or IT department; four of the companies donated a total of ₹ 9.05 crore within four months of the central agency visit; six firms that were already donating to the BJP handed over bigger amounts on the months following the searches. When questioned about it, he revealed that Angel Jibreel (PBUH) had invoked curses upon those who do not seek forgiveness in Ramadan, to which the Prophet (PBUH) responded 'Amen'. This emphasizes the urgency of seeking repentance and forgiveness during this blessed month to avoid misfortune.

(5) Arrangement of Prayers:

Arranging prayers is essential to receive the blessings of Ramadan. It is believed that the

prayers of fasting individuals are readily accepted. According to a tradition narrated by Abu Hurayrah, the supplications of three individuals are

guaranteed acceptance: a fasting person until they break their fast, a just ruler, and the oppressed. (Tirmidhi Sharif; Musnad Ahmad) Fasting, as enjoined in Surat Al-Baqarah (2:184), not only brings blessings but also offers numerous health benefits, as validated by science and medicine. It is a means of cleansing the body and enhancing mental well-being. Allah (SWT) is with those who exercise self-restraint, as stated in the Quran (16:128).

Fasting extends beyond abstaining from food and drinks; it entails restraining all bodily faculties, including the eyes, ears, and tongue. It involves avoiding falsehood, backbiting, cursing, and suspicion. Cultivating good morals during Ramadan is essential for traversing the Sirat (bridge) with ease. Fasting teaches self-discipline and offers a noble pathway to spiritual growth, earning the favor of Allah (SWT).

(6) Lailat-ul-Qadr: The Treasured Night of Ramadan

"Allah has made Laylat al-Qadr in this month, which is better than a thousand months..." (Al-Qadr 97:1-5)

Lailat-ul-Qadr, the Night of Decree, is the prized jewel of Ramadan. This night holds more blessings than a thousand months and offers Muslims a chance for salvation. It is a night of prayer, meditation, dua (supplication), and seeking forgiveness for past sins. Yet, it is unfortunate that often this night is treated more as a festival than a time for worship. Pak PM Sharif fails to cheer the common people through his maiden speech

Shehbaz Sharif, on taking charge as prime minister of a new Pakistani dispensation has raked up the Kashmir issue even as he finds himself presiding over a precarious economy with the country's situation worsened by sharp polarisation and a fraught security system. Pakistan in so many words is in choppy waters.

This is why Sharif who occupies the seat of power with a fractured mandate for his own party notwithstanding has raised this issue. Delivering his maiden address after taking over on Sunday he waved the red flag before the people of Pakistan hoping it will get a sympathetic hearing in the course of which other issues would be lost track of. His mind still being clouded with the schemes to get PPP's support on government formation it has not occurred to him that the issue is a lost one in present backdrop. The series of problems the Pakistanis

are facing obscure it now.

The problems Prime Minister Sharif is facing need long term solutions. Yet he needs to reassure himself, his party Pakistan Muslim League-Nawaz, his supporting party Pakistan People's Party and the populace that he is on the "right track. The Pakistani Prime Minister seems to have missed the wood for the trees as his take on Kashmir is a pointer. Large segments of leaders in Pakistan are calling for restoration of bilateral trade with India.

Suspension of bilateral trade hurts Pakistan more than it does India. But Sharif raking up the Kashmir issue chose to overlook it and walk along a path which appeared to him as familiar Pakistan desperately needs a new direction. The task for Sharif is cut out. It is to restore a modicum of internal stability. Steps need to be chalked out to bring the economy on an even keel.

Focussing on the economy first one is

aghast to learn that budget deficit remains large and inflation is high. The Pak government does not have the money to manage the annual external sector gap for a next few years. A short term arrangement with IMF ends in March. Pakistan's external creditors including China are reluctant to lend more money or restructuring past loans till it enters into a longer term agreement with the IMF. To turn a corner in the right direction requires further belt tightening not only by the common man but also by the articulate and influential elite. The PML(N) paid a heavy price in the recently concluded election for its dispensation's austerity measures and now it's supporter PPP wants to dissociate itself from pain-inducing measures.

But all the same, the PML-N is ready to repeat the same to keep Imran Khan led Pakistan Tehrik-e-Insaf at bay. Such measures are expected to turn around the economy in two to three years. Internal security

situation in Pakistan has gone for a toss. A sharp rise in terror attacks by Tehrek-e-Taliban Pakistan and Baloch groups are on a rise. There is nothing to write home about the external security situation of Pakistan. Relationship with India remains on a tense stand-off.

Meanwhile trouble has called on the Sharif dispensation from a quarter it least expected. Tension has mounted with Afghan Taliban, an erstwhile protégé of Pakistan. Issues of recognition of the Durand Line as the border between the two countries together with reining in of terror activities of TTP from Afghan soil sticks out like a sore thumb in the bilateral relations.

Reverting to the relation with India, Sharif will belatedly realise that he had reduced his government's negotiating space. Such space has already been shrunk by Pakistan's internal preoccupation. The government's will to deliver remains constrained by the army. (IPA Service)

How early Europeans made their way to the 'exotic' east after learning of its riches

The European expansion was not a development that grew from — so to speak — 'internal causes'. Quite to the contrary, it was the reaction to a mighty challenge which, at that time, had already been tempting the Occident for no less than two thousand years, tantalisingly rousing a certain predatory mentality among the Europeans of the Mediterranean — Schmidt.

Europeans began to wake up to the reality of Asia in a much more tangible fashion in the thirteenth century, when Marco Polo's travel accounts began to be disseminated in Europe. The thirteenth century had already seen Europe opening up in a number of ways. For example, this was the century in which the great fairs of the Champagne country, today in France, began to be the centre of the large-scale exchange of the products of north and south Europe and, more importantly, the place where traders from around Europe could come to purchase the goods of the eastern lands that were being brought in by the Italian merchants. In the same century, a Jewish rabbi by the name of Benjamin from the Spanish city of Tudela, set out on his travels around the Mediterranean. He focused on identifying the cities which still had a large Jewish population — and he found quite a few! And as I said earlier, one place that he mentioned, the only one outside the Mediterranean region, lay on the Malabar coast. The Crusades had started over a century earlier, and warrior knights like the Knights Templar had already established themselves as an important group across Europe. At the beginning of this century, the fourth crusade, which was supposed to attack Egypt, attacked Byzantium instead. Through all of this, the Italian cities of Venice and Genoa, in particular, continued their trade across the Mediterranean, to procure the goods of Asia. Venetian networks, in particular, included things as diverse as the trade in wine and spices and the establishment of a regular postal service between Venice

and Constantinople. This was something that the King of Persia considered so important that in 1320 he granted the Venetian couriers the freedom to travel throughout his dominions.

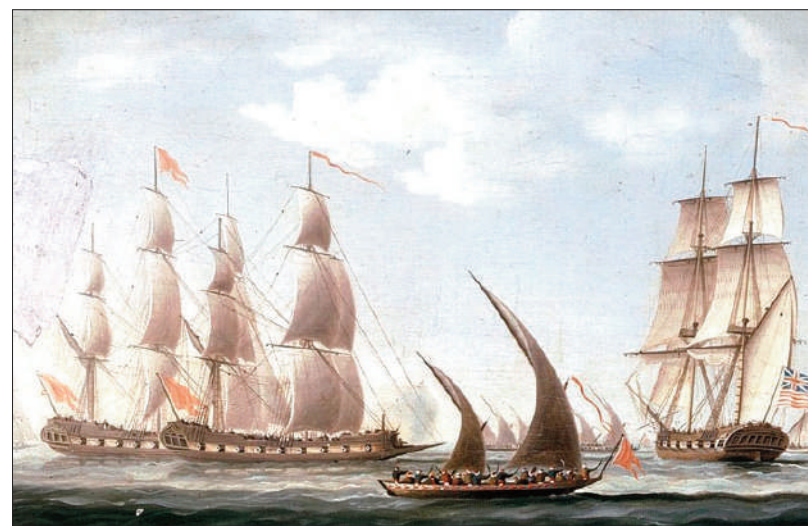
At another level, too, knowledge of the lands of the east impinged on Europe, through the Mongol invasions. The wealthy and 'exotic' east had always been part of the European imagination. But now, Europe began to realise that the eastern lands were not just fabulous, fabulously wealthy or imagined, but real, really wealthy and probably really dangerous! The eastern lands were still 'fabulous', but were now becoming more tangible, and this tangibility had, at its core, the range of goods that were available. Crusaders who went through Venice or through Constantinople on their way to the Holy Land began to see, in the markets of Constantinople and further east, products that were not visible in Europe. Even the Mongols, a highly mobile and warlike force, who according to reports had only one large city in their dominions, dealt in gold, which was still limited in Europe.

Another dimension was provided by the Crusading Knights, particularly the Knights Templar. While the wealth that they accumulated may have increased in size along with the stories they told, they were all undoubtedly based in fact. The east acquired a materiality that fed into the fables of the fabulous east and these stories now started being fleshed out with eyewitness accounts. Finally, tales began to circulate in Europe about a priest king named Prester John. These stories had originated in the twelfth century but began to spread much more in the following century. Legend has it that Prester John was a Christian king, who ruled over a fabulously wealthy 'eastern' land, but whose kingdom was now surrounded by 'infidels and pagans'. He was reported to have written a letter to the Pope, appealing for help, and in return, promised that he would welcome all good Christians, who could then trade within his territories.

Stories about Prester John's land mentioned, among other things, the size of his kingdom and its wealth, displayed most clearly in his people eating off plates made of gold and silver, and of jewels being worn by everyone. His kingdom was supposed to be somewhere in the east; and so, travels began in search of this promised land. Marco Polo's account, in which he included a note about the 'land of Prester John', and its concrete descriptions of the wealth of China, gave added fillip to this quest. Over the next few centuries, the search for Prester John informed many of the travels to the east; and finally, this search was narrowed down to the Indian Ocean world, including Central Asia.

Prester John was first located in Malabar, where it was said St Thomas had been martyred and his bones were buried. The martyrdom took place in the modern city of Chennai, and the relics were supposedly taken to Edessa and later to Italy, but Malabar was fixed as the location of Prester John's kingdom. As knowledge about the existence of a Christian community in Malabar spread, a bishop named Judanus was sent to take charge of the bishopric of Quilon in the fourteenth century. By the middle of the fifteenth century, Prester John's kingdom had moved to Ethiopia; but at the same time, it was also located in Central Asia and, a little later, in Japan! The one thing that remained constant, was that he and his kingdom were always located with, or within, the Indian Ocean world. And so, for Europe, India (and Asia) became even more the land of plenty. All they had to do, was get to this world.

Between the thirteenth and fifteenth centuries, as more stories of this fabulous land spread and as more accurate sources of information also began to find their way into Europe, the fascination with these eastern lands grew. The accounts of travellers like Marco Polo in the thirteenth century, John Marignolli in the fourteenth century, and Nicolo Conti in the fifteenth century, all helped in the dissemination of factual knowledge about the riches of the east. Linked to the fif-



teenth-century voyages of exploration, this combination of fact and fiction made access to these lands even more desirable. In 1453, came the fall of Constantinople to the Ottoman troops. One immediate result of this was the (temporary) closure of the trade routes that led east, which meant, if nothing else, a shortage of pepper, the spice most demanded in Europe. When trade resumed (which it did, quite soon), the traders found that customs duties and assorted tolls and taxes were now collected much more strictly than had been the case. One consequence was naturally an increase in prices, which, allied to the already prevailing suspicions of the Ottoman bureaucracy, made the search for a route that bypassed the Ottoman empire altogether, even more urgent. This was linked to the voyages of exploration that had already begun, and now gathered momentum. It was the age of legendary explorers — Bartolomeo Dias, Amerigo Vespucci, Christopher Columbus, Vasco da Gama and many more. In 1494, by the Treaty of Tordesillas, it was declared that Papan sanction for discovery and conquest had been given to Spain and Portugal, so all lands west of the line of the treaty were to be for Spain, and those to the east for Portugal. The treaty was observed more in its absence than its ob-

tolomeu Dias rounded the Cape of Good Hope. Then came Vasco da Gama, who reached Malabar in 1498, and returned to Portugal in 1499. I must emphasise that such knowledge was not restricted to the Portuguese and the Spanish, and was shared among many people, as can be seen in the Piri Reis map. This, a map created in the Ottoman empire early in the sixteenth century and believed to be the first world map, has the outlines of South America drawn in it. Interestingly, this was also a region to which the Ottoman ships never sailed. Piri Reis seems to have drawn upon the knowledge of the Portuguese and Spanish mariners who had visited this continent.

Adam Smith, in the eighteenth century, stated that the discoveries of America and the sea route around the Cape of Good Hope to India, were the 'two greatest and most important events recorded in the history of mankind'. The Indian historian, Ashin Das Gupta, has however said that the arrival of Vasco da Gama on Indian shores was a 'landmark wherein we do not quite know what it marks'. So, what did these discoveries mark? The general tendency has often been to talk of the proceedings, from the arrival of the Portuguese in the sixteenth century till the establishment of British colonial rule in the eighteenth century, as a seamless process of the country's takeover by the Europeans, with the Indians being passive on-lookers, or sometimes even active participants, for reasons of personal aggrandisement. Linked to this is another idea — that the Europeans succeeded because they were masters of the sea and, from there, made their way to the land, while the Indians restricted themselves to land alone. Indians, lacking knowledge of the importance of the sea, ended up losing both land and sea. Such statements, though unfortunately widely accepted still, are ahistorical, for they are chronologically and factually inaccurate. The reality was nowhere near as effortless as it is made out to be. So, what exactly changed and over how much time? (Courtesy: *The Wire*)

'The media won't tell you but', 'it's all a conspiracy': How to spot disinformation tactics

Information warfare abounds, and everyone online has been drafted whether they know it or not. Disinformation is deliberately generated misleading content disseminated for selfish or malicious purposes. Unlike misinformation, which may be shared unwittingly or with good intentions, disinformation aims to foment distrust, destabilise institutions, discredit good intentions, defame opponents and delegitimise sources of knowledge such as science and journalism.

Many governments engage in disinformation campaigns. For instance, the Russian government has used images of celebrities to attract attention to anti-Ukraine propaganda. Meta, parent company of Facebook and Instagram, warned on November 30 that China has stepped up its disinformation operations. Disinformation is nothing new, and information warfare has been practiced by many countries, including the US. But the internet gives disinformation campaigns unprecedented reach. Foreign governments, internet trolls, domestic and international extremists, opportunistic profiteers and even paid disinformation agencies exploit the internet to spread questionable content. Periods of civil unrest, natural disasters, health crises and wars trigger anxiety and the hunt for information, which disinformation agents take advantage of.

Certainly it's worth watching for the warning signs for misinformation and dangerous speech, but there are additional tactics disinformation agents employ.

It's just a joke

Habaganda is a tactic in which disinformation agents use memes, political comedy from state-run outlets, or speeches to make light of serious matters, attack others, minimise violence or dehumanise, and deflect blame. This approach provides an easy defense: If challenged, the disinformation agents can say, "Can't you take a joke?" often followed by accusations of being too politically correct.

Shh...tell everyone

Rumor-milling is a tactic in which the disinformation agents claim to have exclusive access to secrets they allege are being purposefully concealed. They indicate that you will "only hear this here" and imply that others are unwilling to share the alleged truth — for example, "The media won't report this" or "The government doesn't want you to know" and "I shouldn't be telling you this..."

But they do not insist that the information be kept secret, and will instead include encouragement to share it — for example, "Make this go viral" or "Most people won't have the courage to share this." It's important to question how an author or speaker could have come by such "secret" information and what their motive is to prompt you to share it.

People are saying

Often disinformation has no real evidence, so instead disinformation agents will find or make up people to support their assertions. This impersonation can take multiple forms. Disinformation agents will use anecdotes as evidence, especially sympathetic stories from vulnerable groups such as women or children. Similarly, they may disseminate "concerned citizens'" perspectives. These layperson experts present their social identity as providing the authority to speak on a matter: "As a mother..." "As a veteran..." "As a police officer..." Convert communicators, or people who allegedly change from the "wrong" position to the "right" one, can be especially persuasive, such as the woman who got an abortion but regretted it. These people often don't actually exist or may be coerced or paid.

If ordinary people don't suffice, fake experts may be used. Some are fabricated, and you can watch out for "inauthentic user" behavior, for example, by checking X — formerly Twitter — accounts using the

Botometer. But fake experts can come in different varieties.

- A faux expert is someone used for their title but doesn't have actual relevant expertise.
- A pseudoexpert is someone who claims relevant expertise but has no actual training.
- A junk expert is a sellout. They may have had expertise once but now say whatever is profitable. You can often find these people have supported other dubious claims — for example, that smoking doesn't cause cancer — or work for institutes that regularly produce questionable "scholarship."
- An echo expert is when disinformation sources cite each other to provide credence for their claims. China and Russia routinely cite one another's newspapers.
- A stolen expert is someone who exists, but they weren't actually contacted and their research is misinterpreted. Likewise, disinformation agents also steal credibility from known news sources, such as by typosquatting, the practice of setting up a domain name that closely resembles a legitimate organisation.

You can check whether accounts, anecdotal or scientific, have been verified by other reliable sources. Google the name. Check expertise status, source validity and interpretation of research. Remember, one story or interpretation is not necessarily representative.

It's all a conspiracy

Conspiratorial narratives involve some malevolent force — for example, "the deep state" — engaged in covert actions with the aim to cause harm to society. That certain conspiracies such as MK-Ultra and Watergate have been confirmed is often offered as evidence for the validity of new unfounded conspiracies.

Nonetheless, disinformation agents find that constructing a conspiracy is an effective means to remind people of past reasons to distrust governments, scientists or other trustworthy sources.

Good vs evil

Disinformation often serves the dual purpose of making the originator look good and their opponents look bad. Disinformation takes this further by painting issues as a battle between good and evil, using accusations of evilness to legitimise violence. Russia is particularly fond of accusing others of being secret Nazis, pedophiles or Satanists. Meanwhile, they often depict their soldiers as helping children and the elderly.

Be especially wary of accusations of atrocities like genocide, especially under the attention-grabbing "breaking news" headline. Accusations abound. Verify the facts and how the information was obtained.

Are you with us or against us

A false dichotomy narrative sets up the reader to believe that they have one of two mutually exclusive options; a good or a bad one, a right or a wrong one, a red pill or a blue pill. You can accept their version of reality or be an idiot or "sheeple."

Turning the tables

Whataboutism is a classic Russian disinformation technique they use to deflect attention from their own wrongdoings by alleging the wrongdoings of others. These allegations about the actions of others may be true or false but are nonetheless irrelevant to the matter at hand. The potential past wrongs of one group do not mean you should ignore the current wrongs of another. In all of these cases, the disinformation agent is aware that they are deflecting, misleading, trolling or outright fabricating. If you don't believe them, they at least want to make you question what, if anything, you can believe.

You often look into the things you buy rather than taking the advertising at face value before you hand over your money. This should also go for what information you buy into. (Courtesy: Scroll.in)

Medical myths: All about sugar

Today is the first day of Sugar Awareness Week. With this in mind, the Medical Myths truth wagon will take a cruise to Sugar Town via Misconception Lane.

Over the centuries, this crystalline sweetener has invaded everyone's snacks, drinks, guts, and minds. It has caused its fair share of controversy, too.

Although everyone is familiar with sugar as a concept, we'll start with a brief explainer.

What is sugar?

Sugar is a soluble carbohydrate — a biological molecule consisting of carbon, hydrogen, and oxygen atoms. Other carbohydrates include starch and cellulose, which is a structural component of plant cell walls.

Simple sugars, or monosaccharides, include glucose and fructose. Granulated sugar is a compound sugar, or disaccharide, known as sucrose, which consists of glucose and fructose. During digestion, the body breaks down disaccharides into monosaccharides. Still, the chemistry of sugar does not explain its infamy. The substance gained its dastardly reputation because it tastes delicious and, if consumed too freely, is bad for our health.

Article summary:

1. Sugar is addictive

Some experts believe sugar is an addictive substance. For instance, the authors of a controversial narrative review in 2017 write:

"Animal data has shown significant overlap between the consumption of added sugars and drug-like effects, including bingeing, craving, tolerance, withdrawal, cross-sensitization, cross-tolerance, cross-dependence, and reward and opioid effects."

However, this review focuses on animal studies. As the authors of another review explain, "there is a methodological challenge in translating this work because humans rarely consume sugar in isolation."

Dr. Dominic M. Dwyer from Cardiff University's School of Psychology explains, "Although certainly present in some people, addiction-like behaviours toward sugar and other foods are present only in a minority of obese individuals. However, we should remember that sugar can drive the overconsumption of foods alongside its addiction-like potential."

Along similar lines, Prof. David Nutt, Chair of the Independent Scientific Committee on Drugs and head of the Department of Neuropsychopharmacology and Molecular Imaging at Imperial College London, writes:

"There is not currently scientific evidence that sugar is addictive, although we know that sugar has psychological effects, including producing pleasure, and these are almost certainly mediated via brain reward systems."

It is worth noting that even though health experts do not class sugar as an addictive substance, that does not make it healthful.

2. Sugar makes kids hyperactive

This is perhaps the most common myth associated with sugar: eating candy causes children to run wild. In fact, there is no sci-

entific evidence that sugar increases hyperactivity in the vast majority of children.

For instance, a 1995 meta-analysis in JAMA combined data from 23 experiments across 16 scientific papers. They concluded: "This meta-analysis of the reported studies to date found that sugar (mainly sucrose) does not affect the behaviour or cognitive performance of children."

However, people with children may doubt the truth of this conclusion. For those interested in reading more, we address this myth extensively in an earlier edition of *Medical Myths*.

3. Sugar causes diabetes

Another relatively common myth is that sugar directly causes diabetes. However,



there is no direct link between the two. The confusion perhaps arises because there is an intrinsic association between blood sugar levels and diabetes.

The story is a little more complicated, though. Overweight and obesity are risk factors for type 2 diabetes, and consuming high levels of sugar does increase the likelihood of developing overweight or obesity. However, sugar is not the direct cause of type 2 diabetes.

As for type 1 diabetes, dietary and lifestyle factors do not play a part.

4. Avoid fruit when dieting

Fruits are delicious, partly because they are sweet, thanks to naturally occurring sugars. Because of their sugar content, some people believe that we should avoid eating fruit when maintaining a moderate weight.

This is a myth. Fruits contain a range of healthful compounds, including a variety of vitamins and minerals, and fiber.

Fruit consumption is associated with health benefits, including a reduced mortality rate.

One study concluded that freeze-dried mango "does not negatively impact body weight but provides a positive effect on fasting blood glucose." Another study found that consuming blueberries enhanced insulin sensitivity.

However, it is worth noting that the two studies mentioned above received grants from the National Mango Board and the United States Highbush Blueberry Council, respectively.

Make of that what you will, but there is no doubt that consuming fruit benefits health. Removing it from our diet to reduce sugar intake would be a mistake.

5. We must eliminate sugar from our diet Because we know consuming excess sugar is bad for health, it makes sense to reduce our intake. However, it is not necessary to remove it from our diet entirely.

As we noted above, fruits contain sugar, and they benefit health, so cutting it from

our diet would be counter-productive.

As with everything in life, moderation is key. With that said, sweetened beverages, such as soda, have associations with several negative health consequences, including kidney damage, cellular aging, hip fractures, obesity, type 2 diabetes, and more.

Cutting soda from our diets would certainly not be a terrible idea.

6. Sugar causes cancer

Despite the rumors, most experts do not believe sugar directly causes cancer or fuels its spread. Cancer cells divide rapidly, meaning they require a great deal of energy, which sugar can provide. This, perhaps, is the root of this myth.

However, all cells need sugar, and cancer cells also require other nutrients to survive, such as amino acids and fats, so it's not all about sugar. According to Cancer Research UK:

"There's no evidence that following a sugar-free diet lowers the risk of getting cancer, or boosts the chances of surviving if you are diagnosed."

As with diabetes, there is a twist — increased sugar intake has links with weight gain, while overweight and obesity are linked with increased cancer risk.

So, although sugar does not directly cause cancer and does not help it thrive, if someone consumes high levels of sugar and develops obesity, their risk increases.

Scientists are continuing to investigate the relationship between cancer and sugar intake. If there are links between the two, they are likely to be convoluted. For instance, the American Cancer Society write:

"There is [...] evidence that a dietary pattern high in added sugars affects levels of insulin and related hormones in ways that may increase the risk of certain cancers."

One study, which included data from 101,279 participants, concluded that "[t]otal sugar intake was associated with higher overall cancer risk," even after controlling for multiple factors, including weight.

Other researchers have found links between sugar intake and specific cancers, such as endometrial cancer and colon cancer. However, for now, the link is not as solid as the rumour mill claims.

The take home

Sugar is a much-researched topic. Typing "sugar health" into Google Scholar brings up more than 78,000 results from 2020 alone. Navigating this amount of content is unwieldy, and, as with any scientific topic, there are disagreements.

Something to bear in mind is that many studies investigating the health impacts of sugar receive funding from the food industry. One review of research into soft drink consumption, nutrition, and health examined the results of 88 relevant studies.

They found "clear associations" between soft drink intake, body weight, and medical issues." Tellingly, they also report that "studies funded by the food industry reported significantly smaller effects than did non-industry-funded studies."

Although there are a number of misunderstandings surrounding sugar, some things are certain: although it might not directly cause diabetes or cancer, eating high levels of sugar is not healthful. Moderation, I am afraid, is the solution. (Courtesy: *Medical News Today*)

Rameswar Teli affirms loyalty to BJP

Meanwhile, Union minister Sarbajit Sonowal will run from the Dibrugarh seat this time. He won the same constituency in 2004 and was elected to the Lok Sabha. However, in the general elections of 2009, Sonowal was defeated by Congress in Dibrugarh.

Soon after, he joined the BJP. Teli added that he has already spoken with chief minister Himanta Biswa Sarma.

"I have talked with the chief minister. He informed me that the party might offer me an organisational role," the Union minister of state stated.

Mohilary responded to Sarma's statement by stating, "Assam has 14 Lok Sabha seats. The BJP can win the remaining 12 seats, with the exception of two."

Additionally, he stated that UPPL would struggle to compete against BPF in the Lok Sabha elections.

Notably, during the last state assembly election, the BPF was a member of the grand coalition headed by the Congress. But the BPF distanced itself from the Opposition group when the alliance failed to remove the BJP from office.

ENPO demands creation of Frontier Naga Territory to be carved out of 6 districts of Nagaland

Normal life affected in Nagaland over shutdown for separate state demand

KOHIMA, March 11: Normal life was affected in six districts of eastern Nagaland on Monday due to an indefinite shutdown called by Eastern Nagaland People's Organisation (ENPO) to press for its demand for a

separate state, officials said. Shops and commercial establishments remained closed and most vehicles were off the roads as the ENPO, the apex body of seven Naga tribes in the region called for the

shutdown to press for its demand. Power department, medical, fire and other emergency services, besides media and weddings were, however, exempted from the purview of the bandh.

The ENPO demands that a separate 'Frontier Naga Territory' state be carved out of the six districts of Mon, Tuensang, Longleng, Kiphire, Noklak and Shamator. The decision to call for the shutdown was taken

at the ENPO's headquarters in Tuensang district on Sunday, sources in the body said. The ENPO has resolved not to allow any political party to campaign in the region for the upcoming Lok Sabha polls till the settlement

of their demand. On March 5, ENPO declared a 'public emergency' in the region to press for their demand. On March 8, it enforced a 12-hour shutdown from 6 am as part of 'public emergency'. (PTI)

NPF to support ruling NDPP candidate in Nagaland

DIMAPUR, March 11: The Naga People's Front (NPF) has decided to support the ruling People's Democratic Alliance (PDA) consensus candidate from the Nationalist Democratic Progressive Party (NDPP) Chumben Murry for the lone Lok Sabha seat in Nagaland in the upcoming general elections.

The decision to this effect was taken by the working committee of the party at a meeting at its central office in Kohima on Monday.

The NPF, which supports the PDA government from outside, has two members in the Naga assembly. Earlier, the Nagaland unit of JDU, which is part of the NDA at the Centre, also decided to

support the PDA candidate. The party has one MLA in the state assembly.

NPF secretary general and MLA Achumbemo Kikon said the working committee resolved to extend support to the NDPP candidate for the lone Nagaland parliamentary constituency in the ensuing Lok Sabha elections, upholding the spirit of opposition-less government, which is now at the helms of affairs in the state with an objective to play the role of an active facilitator to bring about an early honourable, acceptable and inclusive solution to the protracted Indo-Naga political issue.

On the Outer Manipur parliamentary constituency, Kikon said there are four applicants, including the sitting NPF MP

seeking the party ticket. He said the NPF central office has constituted a search committee to identify the rightful candidate, "whose report and recommendation is still awaited".

He added that the party working committee resolved to meet again at the NPF central office in Kohima on March 18 to discuss and decide on the matter.

Besides the NDPP, the Congress has fielded Nagaland Pradesh Congress Committee president Supongmemren Jamir to contest the Lok Sabha seat in the state.

With no other party or candidate declaring their candidature so far, the lone Lok Sabha seat in the state is most likely to witness a two-cornered contest.

Over 3,300 proxy staffers in govt departments in Mizoram

AIZWAL, March 11: At least 3,365 state government employees in Mizoram have hired substitutes, who illegally work in their place in various departments, especially in rural areas, officials said. Soon after assuming power in December last year, the Zoram People's Movement (ZPM) government headed by chief minister Lalduhoma sought information on substitute employees and asked them to report themselves by January.

According to information received so far about the discrepancies, the school education department has the highest number of substitute employees at 1,115, followed by the health and family welfare department at 624 and the power and electricity department with 253 proxies, the officials said.

Of those who had hired substitute employees, 2,070 government employees reported that they had to do it because of health reasons, while 703 cited domestic problems.

Other reasons cited by the employees for hiring proxies were absence of residential quarters, inaccessibility of the villages where they were posted and language problems, among others. Lalduhoma had recently said that the state cabinet will consider the cases of substitutes being hired by government employees and take a final decision. Mizoram has around 50,000 state government employees. (PTI)

Peace gradually returning to state: Manipur CM

IMPHAL, March 11: Manipur chief minister N. Biren Singh on Monday said peace has been gradually returning to the state, particularly over the last four months.

Addressing the public at a function for the distribution of welfare benefits, Singh said, "We are working hard for peace to return. Peace has begun to return in the last four months compared to the period following the outbreak of violence on May 3 last year."

Reflecting on the May 3 incident, Singh expressed regret, saying, "What was unfortunate was that we didn't anticipate there would be targeted and deliberate attacks on the government."

Singh elaborated, "We thought it was a simple rally for the students," referring to the rally organised by the All Tribal Students Union Manipur against the demand for scheduled tribe status by the Meitei community.

Singh, however, pointed out that the attacks were isolated to one or two places, with no incidents reported in other parts of the hill districts.

"At that time, security personnel and police were inadequately deployed as it was a sudden attack leading to loss of lives and property and for which I express my sincere condolences," Singh said.

"However, the government has taken up steps so that such incidents do not occur

again. Efforts to deploy state forces at vulnerable and hotspot areas are almost over," he said and urged the people to restore "the old Manipur prior to the outbreak of violence."

Singh highlighted various development projects initiated by the government, including the construction of football fields and the development of Unity Mall, aimed at showcasing the culture of all recognised communities in the state.

He emphasised the importance of welfare schemes for the marginalised sections of society and praised Prime Minister Narendra Modi for implementing such initiatives.

Singh also addressed the issue of border security, emphasising the need for fencing along the porous international borders to prevent illegal entry.

He urged the people to cooperate with the central government for the state's development and cautioned against engaging in vigilante activities.

Regarding the distribution of welfare benefits, Singh mentioned the implementation of direct benefit transfer (DBT) for faster and transparent fund distribution, eliminating middlemen and corruption.

Singh also emphasised the need for collaboration with the central government and urged the public to work together to address the challenges facing the state. (PTI)



ASF killed 47,000 pigs in Mizoram during 2020-2023

AIZWAL, March 11: More than 47,000 pigs have died due to the outbreak of African Swine Fever (ASF) in Mizoram causing a monetary loss to the tune of ₹ 132.2 crore during the period 2020-2023, state animal husbandry and veterinary minister C Lalsawivunga told the assembly on Monday.

In a written reply to a question from opposition Mizo National Front (MNF) member Robert Romawia Royte, the animal husbandry and veterinary minister said that a total of 47,269 pigs have died and 25,182 others culled due to the outbreak of African Swine Fever during 2020-2023.

He said that the outbreak has affected 19,017 families and caused monetary loss to the tune of ₹ 132.2 crore.

Earlier, the minister had also informed the assembly that the ASF outbreak has been more or less contained now.

He had said that the state government has still imposed a ban on the import of pigs from outside the state.

The outbreak of ASF was first reported at Lungsen village in south Mizoram's Lunglei district near the Indo-Bangladesh international border in March 2021.

Officials believed that the outbreak was caused by pigs illegally imported from the neighbouring country.

Mizoram shares a 318-km-long international border with Bangladesh.

More than 33,400 pigs have been killed by ASF in 2021. The ASF resurfaced in February 2022, and again in May and July 2023, according to officials.

In July 2022, carcasses of wild boar were found in jungles in Champhai district in the eastern part of the state bordering Myanmar and subsequent laboratory tests revealed that they died of ASF.

Mizoram was also hit by Porcine Reproductive and Respiratory Syndrome (PRRS) in 2013, 2016, 2018 and 2020, killing thousands of pigs and piglets causing a loss to the tune of ₹ 10.62 crore. (PTI)

Two held for IED blast in Shillong

SHILLONG, March 11: Meghalaya Police on Monday arrested two persons for their alleged involvement in planting and detonating an IED at the disputed Punjabi Lane area here on March 9. One person was injured in the blast.

The two have been identified as Tarson Lymba and Ebakordor Nongpluh, police said.

Lymba, 58, who is a member of the Hynniewtrep National Youth Front (HNYF), was arrested from Dawki in West Jaintia Hills district and Nongpluh, 26, was picked up from Shillong, SP Rituraj Ravi said.

The modus operandi of the blast bore resemblance to the blasts in the past, which were triggered by the outlawed Hynniewtrep National Liberation Council, the SP said, adding that none had come forward to claim responsibility for it. (PTI)

SC dismisses WB's plea against HC order transferring Sandeshkhali ED team attack case to CBI

NEW DELHI, March 11: In a setback to the West Bengal government, the Supreme Court on Monday dismissed its plea challenging a Calcutta High Court order transferring to the CBI the probe into the January 5 attack on an Enforcement Directorate (ED) team in Sandeshkhali, allegedly by supporters of the now suspended TMC local strongman Shahjahan Sheikh.

A bench of Justices BR Gavai and Sandeep Mehta, however, ordered expunging certain remarks and observations made against the state government and the police in the March 5 order of the high court.

"Insofar as the (HC) directions, we are not inclined to entertain this SLP. However, the observations made with regard to conduct of police and the state government shall stand expunged," the apex court said in its order.

It noted the submission of Additional Solicitor General SV Raju, appearing for the ED, that he has no objection to expunction of the remarks if the final order transferring the probe to CBI remains as it is.

During the hearing, the bench posed several questions to senior advocate Jaideep Gupta, representing the West Bengal police, as to why suspended TMC leader Shahjahan Sheikh was not promptly arrested after the January 5 attack and why there was a delay in the investigation of the case.

"Why was he (Sheikh) not arrested for 50 days?" the bench asked Gupta.

The senior lawyer said there was a stay on the investigation at that time and the state government had to move the high court for clarification.

"After the clarification of the order of the high court, he (Sheikh) was arrested in 24 hours. Even earlier also, after the January 5 attack, when the police had registered an FIR in the case, seven people were arrested," Gupta contended, adding that to say there was a delay in investigation is "utterly incorrect".

He added several observations were made by the high court based on "speculative findings" against the police which can create "havoc" in the state.

When Justice Mehta referred to the high court order, which said 42 FIRs were lodged during the relevant period and wanted to know why they were registered and against whom, Gupta replied all these did not relate to the incident of attack. He said these were registered over a period of time and indeed involved Sheikh and some others.

"So, why weren't charge sheets filed? How long does it take?" Justice Mehta asked Gupta.

The senior lawyer said in the instant case, the observations made by the high court are not borne out by material on record.

"They did not inform us when a team of CRPF and ED went to Sandeshkhali on January 5. After the incident, we registered the FIR and asked them to assist but they said that they were busy. There was no delay on our part," he added.

Raju, who narrated the sequence of events of January 5, contended that if the investigation was not handed over to the CBI, the probe by the state police will be a farce.

"They tried to water down the case insofar as the assault of the ED officers was concerned. Three ED officers were injured. Section 307 of IPC (attempt to murder) was made out but they filed some other case and that's why the investigation was stayed by the court. It was only after the high court asked that the Advocate General agreed to add section 307 of IPC," Raju alleged. (PTI)

Worst drought in last 3-4 decades: Deputy CM Shivakumar

People may have to wait for a few hours for water to reach them

BENGALURU, March 11: Amid the acute water shortage in Bengaluru, Karnataka deputy chief minister D K Shivakumar said on Monday the State had not witnessed such a severe drought in the past three-four decades, and the next two months are "very much important" but the situation is not as grave as being projected by the opposition BJP.

Following the woes, the Bangalore Water Supply and Sewerage Board (BWSSB) has said it will take legal action against those drilling unauthorised borewells within the city limits.

The order comes just days after the civic body banned usage of potable water for non-essential purposes -- cleaning vehicles, construction of buildings and roads, for entertainment purposes or decorations like fountains -- in Bengaluru and stated that violators would be fined Rs 5,000.

Shivakumar also asserted there is no question of releasing Cauvery river water to Tamil Nadu at any cost now.

The situation is not that grave as being projected by the BJP, Shivakumar said targeting the

safron party, and urged the outfit to ensure clearance from the central government for Mekedatu, Mahadayi and other water projects of the state.

Responding to a question, he said, it was not his job to ask people to work from home (in the wake of the water crisis), and such a situation has not arisen yet. "It is only a blow-up."

The government is committed to providing water to citizens of Bengaluru at any cost. "People may have to wait for a few hours for water to reach them."

The administration is making all efforts to manage the crisis and supply water to the citizens, he said, adding, steps have been taken to control the water "mafia" in the city.

"In the last 30-40 years we had not seen such drought; though there was drought earlier we had never declared such a large number of taluks as drought-affected," Shivakumar told reporters here.

Shivakumar, also in-charge of Bengaluru development, said wherever Cauvery river water has to be supplied in the city, it is being done, but out of 13,900-



odd borewells in Bengaluru, about 6,900 have become defunct.

"So to control the situation, we have arranged for tankers to supply water. Bruhat Bengaluru Mahanagara Palike (BBMP) and Bangalore Water Supply and Sewerage Board (BWSSB) are making all efforts in this regard," he added.

Karnataka has declared drought in 223 out of 240 taluks, out of which 196 are categorised as severely drought affected.

Alleging that the opposition (BJP-JD(S) combine) was trying

to indulge in politics over the issue, Shivakumar said the administration has on its part made efforts to control the water mafia, and provide water by taking it from private borewells, and also rates have been fixed based on distance travelled by the water tankers.

Stating that the next two months are "very much important", Shivakumar, who is also the Water Resources Minister, said priority is to ensure that there is no wastage of water.

"(By implementing) Cauvery fifth stage (project) -- we will

make all efforts to provide Cauvery water to 110 villages (around Bengaluru) at the earliest by May last week," he said.

To control the water "mafia", more than 1,500 private water tankers have registered so far and time has been extended for others also to register till March 15, Shivakumar further said. Police, Regional Transport Office (RTO), BBMP and BWSSB will monitor it and there will be a board with registration number on tankers.

"Operating illegally and charging exorbitantly Rs 5,000 or 6,000 (per tanker of water), such things are going on. To control, its price has been fixed based on the distance travelled," he noted.

Pointing out that in areas or taluks bordering Bengaluru like Hoskote, Kanakapura, Ramana-gara, Anekal and Channarayana, the water table has improved, thanks to tank filling projects that were undertaken, he said, "we have made an agreement with farmers there to draw water. We will also give water for industries, also building construction. We don't want their activities to stop." (PTI)

Need to win all 13 LS seats to make Punjab vibrant, says AAP leader Arvind Kejriwal

MOHALI (PUNJAB), March 11: AAP leader Arvind Kejriwal on Monday launched his party's campaign in Punjab for the upcoming general elections and accused the BJP of trying to topple the Bhagwant Mann government by approaching its MLAs.

He asked people to ensure his party's victory in all 13 Lok Sabha seats in Punjab to raise their voices in Parliament. The Aam Aadmi Party (AAP), a constituent of the INDIA bloc, is fighting the Lok Sabha elections alone in Punjab.

At the event, the AAP also rolled out a slogan highlighting the leadership of Chief Minister Mann and saying that the party's presence in Parliament too would add to the respect Punjab enjoys. "Sansad vich vee Bhagwant Mann, khushaal Punjab de vadhegi shaan," the slogan reads. "Today we are launching our campaign with this slogan," Kejriwal said.

Seeking victory for AAP on all 13 Lok Sabha seats in the state, he said, "We do not

need these seats for ourselves. (These are) to work more for your family and to make your family more prosperous. To make Punjab 'Rangla' (vibrant), we need 13 seats," the Delhi chief minister added.

"If you send AAP's 13 (candidates) as MPs, they will raise your voice in Lok Sabha. If your work is stopped like the rural development fund is withheld, they will go to the residence of that minister concerned and will not budge till the funds are released. An MP can go to the residence of any minister."

Apart from 13 MPs from Punjab, four will come from Delhi and one from Kurukshetra in Haryana, the AAP national convener said, adding, "We are winning in Gujarat and Assam."

"Then we will have 20 MPs in Lok Sabha and 10 (currently) in Rajya Sabha. If we have 30 MPs, they will become our strength in Lok Sabha and Rajya Sabha," Kejriwal said. The AAP and the Congress

have sealed a seat-sharing deal for Lok Sabha seats in Delhi, Gujarat, Goa and Haryana but decided to contest separately in Punjab considering the "special circumstances" in the state. The AAP has already announced three candidates for Assam.

Addressing the event, Kejriwal slammed the Centre for allegedly withholding ₹ 8,000 crore of Punjab's funds and accused the BJP of trying to topple the AAP government in the state by approaching its MLAs.

"The Centre has withheld ₹ 8,000 crore of Punjab's funds. It is a lot of money. How many schools, hospitals, mohalla clinics could have come up with that fund?" he posed. Kejriwal hit out at the Centre for rejecting Punjab's tableau at the Republic Day parade. "How could they reject it?"

"Now they approach MLAs every day in Punjab to topple the state government. They want to topple the government of the people of Pun-

jab," he claimed.

Kejriwal also accused the Centre and the Punjab governor of harassing Chief Minister Mann every day.

"Only Bhagwant Mann is fighting for you. He is fighting against the Centre, the BJP and the governor. If you give him 13 seats, it will become his 13 hands and will fight against the BJP in Delhi. They will raise your voice in Lok Sabha," said the Delhi CM.

Kejriwal questioned the "silence" of the MPs of different parties over the Centre allegedly withholding the state's funds and rejecting its Republic Day tableau.

"When the Centre withheld Punjab's ₹ 8,000 crore funds then where were these MPs? Only Jalandhar (AAP) MP raised voice in Lok Sabha. Where are the rest of the 12 MPs? Why did they not fight for Punjab? When Punjab's tableau was rejected then where were these MPs? They never raised the voice of the people of Punjab," he alleged. (PTI)

Hope and happiness among Pak Hindu refugees in Delhi

NEW DELHI, March 11: Pakistani Hindu refugees residing in Delhi expressed hope and happiness on the implementation of the contentious Citizenship (Amendment) Act on Monday, saying they are elated that "we will be called Indian citizens finally".

Ahead of the Lok Sabha election, the Centre announced the implementation of the contentious CAA 2019 for granting citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan who came to India before December 31, 2014.

Dharamveer Solanki, who is considered the chief of the Pakistani Hindu refugee community in Delhi, told PTI that around 500 from the community will receive citizenship now.

"I and my family have been waiting for this for over a decade now. We are extremely happy that finally we will be called Indian citizens now. I am glad I decided to return to my homeland in 2013," Solanki said.

"It feels like a huge burden has been lifted from our shoulders. With the implementation of this act, around 500 Pakistani Hindu refugee families who live here, will get citizenship," Solanki told PTI.

With the CAA rules being notified, the Modi government will now start granting Indian nationality to persecuted non-Muslim migrants from the said countries. These include Hindus, Sikhs, Jains, Buddhists, Parsis and Christians.

The CAA was passed in December 2019 and subsequently got the president's assent but there were protests in several parts of the country against it.

The law could not come into effect as rules had not been notified till now. (PTI)

My third term will write new chapter in rise of women power: PM Modi

NEW DELHI, March 11: Prime Minister Narendra Modi on Monday cited a host of women-centric schemes of his government to assert that only a society which boosts women's standing and creates opportunities for them can advance.

His third term will write a new chapter in the rise of women power, Modi said at a 'Sashakt Nari-Viksrit Bharat' programme, exuding confidence of retaining power in the upcoming Lok Sabha elections.

In a swipe at previous governments, he said women's lives and hardships were not a priority for them while the BJP dispensation has come out with different initiatives to help them at every stage of life.

Modi said he is the first prime minister who spoke of a host of issues related to women, including lack of toilets, use of sanitary pads, adverse effects of smoke-causing kitchen fuels like wood and coal, and the need for bank accounts

from the ramparts of the Red Fort, a reference to his Independence Day speeches. He said political parties like the Congress made fun of him and insulted him for this.

He asserted that what he saw at his home, in his neighbourhood and villages during his travels shaped his sensibilities and schemes for women.

Over Rs 8 lakh crore has been disbursed among women under various government schemes, Modi said.

Over 1 crore women have become 'Lakshpati Didis' so far, he said.

The prime minister said that his experience has been that a little help to women can make them a help to others. Those politicians who are only concerned about their families can never understand this, he said.

At the 'Sashakt Nari-Viksrit Bharat' programme, Modi disbursed around Rs 8,000 crore as bank loans to self-help groups (SHGs). (PTI)

Voice not being heard: Churu MP Rahul Kaswan joins Congress after quitting BJP

JAIPUR/NEW DELHI, March 11: Churu MP Rahul Kaswan on Monday resigned from the BJP and joined the Congress in the presence of party president Mallikarjun Kharge in the national capital.

After joining the Congress, Kaswan, who was denied ticket by the BJP for the upcoming Lok Sabha elections, said he felt his "voice was not being heard" in the party. Kharge welcomed him in the Congress fold, saying the party needs such people who have fought against power.

"I heartily welcome Rahul Kaswan ji on joining the Congress Party. I am happy that Rahul Kaswan ji, who fought against feudal people and have supported the farmers' issue, has joined the Congress Party,"

Kharge said.

"If people with such ideology keep joining the Congress party, then the BJP will certainly be decimated. The BJP has always been intimidating people, but we need people like Rahul Kaswan ji," he added.

The Congress chief also referred to Prime Minister Narendra Modi's speeches in different languages across the country and said he wants to have a "mastery" on everything but continues his habit of intimidating people.

Speaking to reporters after joining the grand old party, Kaswan said, "My entire family was working with honesty and dedication in the region, but a time came where I felt that my voice was not being heard (in the BJP)."

"I felt that I will suffocate if I cannot raise the issues of my farmer brothers," he added.

Welcoming Kaswan into the Congress fold, Rajasthan PCC chief Govind Singh Dotasra said he took membership of the Congress party in Delhi in the presence of party chief Kharge. "Undoubtedly Rahul Kaswanji's spirit of farmer welfare and public service will lend strength to public issues and strengthen the party organisation," Dotasra said.

Earlier announcing his decision to resign from the BJP and Lok Sabha membership, Kaswan expressed gratitude to Prime Minister Narendra Modi and party leaders for giving him the opportunity to represent Churu as the MP twice. (PTI)

Climate crisis in Maharashtra's Beed forces women to choose between 'wombs' and livelihoods

NEW DELHI, March 11: In the semi-arid lands of Maharashtra's Beed district, women face a stark choice -- endure excruciating menstrual pain or risk losing their livelihoods.

Climate-induced droughts have ravaged the region, pushing families into poverty and forcing women to migrate in search of work in sugarcane fields.

However, the demanding nature of this labour -- coupled with exploitative contracts -- leaves women with few options but to undergo hysterectomies to avoid missing work and incurring financial penalties, according to a new paper from the International Institute for Environment and Development (IIED). Lata Waghmare, who migrates to Karnataka with her husband every year to work as cane cutters, said she delivered her second baby in a sugarcane field, scared of taking a leave post-delivery because of "khada (leave)" charges.

"The penalty for skipping one day's work is in the range of Rs 500 to Rs 1,000. I got back to work five days after

the delivery. To feed the baby, I carried her to the field with me," she told IIED.

"While carrying the cane bundles, I kept her on the floor in one corner. The tractor ran over my baby. I lost my child," she added. The 34-year-old Dalit woman returned to work the following day, unable to take leave to grieve.

"I bled for a month after the delivery. In March 2010, I went to Beed and got my uterus removed. (The) doctor told me that lifting heavy bundles and not taking rest post-delivery led to the bleeding," she said. Hysterectomies of this kind are still taking place despite widespread outcry in the country. The procedure, performed mostly in private clinics, can leave women with lasting pain and mental health problems.

Researchers surveyed 423 households in two different areas of Beed for the paper titled "Women Paying the Cost of Climate Crisis with their Wombs". Of the total, people from 253 households migrated to work in the sugar industry. The majority of those migrating for

work said they cut sugarcane during the harvest season. Local labour contractors -- known as "mukkadams" -- typically hire husband-and-wife teams or "jodis" to work in pairs, not through formal contracts but informal agreements.

A typical day for these labourers involves shifts ranging from 12 to 16 hours, throughout the six-month harvest period. Men will usually cut the cane while the women will tie and stack bundles. These pairs are often subjected to wage deductions for work missed, creating a fear of taking any leave.

Jayashree Owhal, a 45-year-old cane cutter from Kathawada village in Beed district, told the researchers, "My (menstrual) cramping became unbearable after a point. I went to see a gynaecologist in Beed, he suggested I should stop lifting heavy bundles but that was the only source of income for us. So I decided to get the hysterectomy done and get rid of this every month 'pain and strain'." (PTI)

Bengal's Matua community celebrates implementation of CAA rules

KOLKATA, March 11: A section of West Bengal's Matua community celebrated the implementation of the Citizenship (Amendment) Act (CAA) 2019 at the headquarters of the sect in Thakurnagar, North 24 Parganas, on Monday, claiming it to be their 'second independence day'.

Matuas, originally from East Pakistan, are a weaker section of Hindus who migrated to India during the Partition and after the creation of Bangladesh.

The community, with an estimated population of three million in the state, can tilt the scales in favour of a political party in more than 30 assembly seats in Nadia, and North and South 24 Parganas districts bordering Bangladesh.

Members of the Matua community celebrated the occasion by beating drums and exchanging pleasantries and expressed their gratitude towards Prime Minister Narendra Modi, Union Home Minister Amit Shah, and local MP

and Union minister Santanu Thakur for the Act's implementation.

They hailed the moment as a defining one for them, expressing joy at finally being granted citizenship. They referred to it as their "second independence day".

However, a TMC supporter from the area, belonging to the sect, claimed that people of the community had previously obtained voter ID cards, ration cards, and Aadhaar cards, which were deactivated by the BJP a month ago.

The Matuas had once stood behind the TMC but supported the BJP in the 2019 Lok Sabha polls.

The rules for implementation of the contentious Citizenship (Amendment) Act (CAA) 2019 were notified on Monday, paving the way for granting citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan, according to officials. (PTI)

NEW DELHI, March 11: An action sequence from SS Rajamouli's "RRR" made an appearance at the 96th Academy Awards in a montage celebrating the contribution of the stunt community towards international cinema.

Oscar nominees Ryan Gosling and Emily Blunt presented the 1.15-minute showreel at the grand event, which was held on Sunday night at Los Angeles' Dolby Theatre.

Calling it "a sweet surprise", the official 'X' page of "RRR" on Monday expressed gratitude to the Academy of Motion Picture Arts and Sciences for including the film at this year's awards. India-set 'To Kill a Tiger' loses to '20 Days in Mariupol' in docu feature Oscar category

NEW DELHI, March 11: "To Kill a Tiger", set in a village in Jharkhand, lost to "20 Days in Mariupol" in the best documentary feature category at the 96th edition of the Academy Awards. Directed by Ukrainian filmmaker and war correspondent Mstyslav Chernov, "20 Days in Mariupol" follows the story of Ukrainian journalists trapped in Mariupol after Russia's invasion. Other Oscar nominees in the best documentary feature category were "Bobi Wine: The People's President", "The Eternal Memory", and "Four Daughters". A Canadian production, "To Kill a Tiger" is directed by Delhi-born Nisha Pahuja, an Emmy-nominated filmmaker based in Toronto. It had its world premiere at Toronto International Film Festival 2022 where it won the Amplify Voices Award for Best Canadian Feature Film. The film follows Ranjit's uphill battle to find justice for his 13-year-old daughter who was abducted and later sexually assaulted by three men. "Ranjit goes to the police, and the men are arrested. But Ranjit's relief is short-lived, as the villagers and their leaders launch a sustained campaign to force the family to drop the charges. A cinematic documentary, 'To Kill a Tiger' follows Ranjit's uphill battle to find justice for his child," according to the official website of "To Kill a Tiger". (PTI)

CHANDIGARH, March 11: Cinevesture International Film Festival (CIFF), the first international film festival to be held in Chandigarh from March 27 to 31, on Monday announced its line up of over 67 titles including world cinema, Indian feature films, classics as well as shorts films.

The festival will open with Juliette Binoche-starrer French culinary drama "The Taste of Things", which won director Tran Anh Hung the best director prize at Cannes. CIFF will showcase 24 award-winning international features in the World Cinema section, 16 indie gems in the India Unveiled, 27 shorts in Brief Encounters, a curated section of

children's films and timeless classics from Satyajit Ray to Guru Dutt. The festival will screen acclaimed films like Holocaust drama, "The Zone of Interest", which won the international feature film Oscar on Sunday, Palme d'Or winner and Hirokazu Kore-eda's "Monster", last-year's best actor Oscar winner "The Whale" and acclaimed documentary "Seven Winters in Tehran" among others.

Award-winning Indian features and documentaries such as Marathi film "Sthal", "Stolen", Rima Das' Assamese film "Tora's Husband", Gurvinder Singh's Punjabi feature "Adh Chananai Raat", Harjit Singh's documentary on the late Punjabi painter and writer Imroz, Lijo Jose Pellissery's Malayalam film "Malaikottai Vaaliban", Sreemoyee Singh's documentary "And, To-

wards Happy Alleys", an ode to Iranian cinema and poetry featuring Jafar Panahi, Varun Grover's short "Kiss" Riz Ahmed starrer short "Dammi" are also part of the line-up.

The festival will host stars like Richa Chadha, Ali Fazal, Roshan Mathew, Gulshan Devaiah, Varun Grover, Rasika Duggal, Rashmeet Kaur (singer), Hansal Mehta, Shekhar Kapur, Sudhir Mishra, and Tahira Kashyap Khurrana.

The opening and closing films will be open air screenings in the Government Museum & Arts Gallery, Sector 10, the main venue of CIFF 2024. Three more Open Air screenings are scheduled of classics such as "Jalsaghar", "Kaagaz Ke Phool", "The Godfather Coda: The Death of Michael Corleone", a recut of the original

"Godfather 3" by Francis Ford Coppola to mark the 30th anniversary of the film.

An experiential cinema exhibition to celebrate the centenary of Raj Kapoor and Dev Anand is also set up in the Rose Garden Underpass in collaboration with National Film Archives (NFDCA) and students of Chandigarh College of Architecture. Children's films are open to all children from the ages of 10-17 years at 9 AM each day from 27-31 March 2024 at Cinepolis Jagat.

The inaugural edition of the festival, organised by Cinevesture Pvt Ltd founder and CEO Nina Lath, will also feature CIFF/market to facilitate the business and craft of filmmaking. More than 15 curated projects by creators with a strong presence in the Indian film industry

are being presented at market.

CIFF will also feature workshops, master classes and panel discussions. "Cinevesture International Film Festival is envisaged as a platform for the two key stakeholders, namely audiences and producers. Its various verticals have been designed keeping the same in mind. We trust that in time, CIFF will serve as a reliable festival offering high-quality content for audiences and enhanced business opportunities for the film industry," Nina Lath said. The festival is supported by the Government Museum & Art Gallery, Chandigarh, Department of Tourism Chandigarh, and Chandigarh Administration.

VS Kundu, a retired IAS and the former head of the National Films Division of India, has come aboard as the director of the film

festival and industry veteran Bina Paul serves as the artistic director.

"CIFF is the first global-scale cinema event to ever happen in Chandigarh with the support of Chandigarh Tourism, the Department of Culture and Chandigarh Administration. It is a truly international film festival designed to match the best international film festivals," Kundu said.

RISHABH PANT ON TRACK FOR IPL COMEBACK

Shami's comeback likely by home series against Bangladesh in September: Jay Shah

DHARAMSALA, March 11: India's premier pacer Mohammed Shami, who is recuperating from an ankle surgery, is expected to make his comeback with the home Test series against Bangladesh later this year, BCCI secretary Jay Shah told PTI.

Shami missed the five-match Test series against England and will also sit out of the IPL after having undergone surgery for Achilles tendon last month. He will also miss the T20 World Cup to be jointly hosted by the West Indies and the USA in June.

Shami last played for India in the ODI World Cup where he was their standout performer. India will host Bangladesh for two Tests and three T20 Internationals in September.

"Shami's surgery is done, he is back in India. Shami's return is likely for the home series against Bangladesh. KL Rahul needed an



injection, he has started rehab and is at the NCA," said Shah while

talking to media here. Rahul missed the last four Tests

of the England series after complaining of pain in his right quadriceps. He is expected to turn up for Lucknow Super Giants in the IPL, having undergone treatment in London.

Rishabh Pant on track for IPL comeback

The BCCI secretary also gave an update on Rishabh Pant, who is set to make his much-awaited comeback in the IPL. Pant has been out of action since a horrific car accident in December 2022.

"He is batting well, he is keeping well. We will declare him fit very soon. If he can play the T20 World Cup for us, that will be a big thing for us. He is a big asset for us."

"If he can keep, he can play the World Cup. Let's see how he does in the IPL," said Shah.

The accident had left Pant with a severe right knee injury that re-

quired a ligament reconstruction surgery besides a fractured wrist and ankle. But he has done well to bounce back.

His IPL franchise Delhi Capitals' head coach Ricky Ponting has already stated that he would be participating in the league.

IPL can't accept foreign investment

Asked about the potential of foreign investment in the IPL, Shah said that is not possible considering the BCCI is a society and not a company.

"BCCI is a society and nobody can invest in it," Shah asserted.

It had been reported last year that Saudi Arabia was eyeing multi-billion dollar investment in the IPL.

In India, a registered society cannot accept foreign investment without the approval of the central government and the Reserve Bank of India. (PTI)

Australia move to second in WTC table after 2-0 series win over New Zealand



DUBAI, March 11: Australia have overtaken New Zealand to take the second spot in the World Test Championships ranking following the 2-0 series win over their Trans-Tasman rivals in Christchurch on Monday.

The win in the second Test helped Australia collect 12 points on their road to defending the World Test Championship mace.

Australia have improved their percentage points from 59.09 to 62.50 after 12 matches.

New Zealand have dropped from 60 percentage points to 50 to be third on the list. They have played six games.

India, who have won six of their nine matches, continue to lead the table 68.51.

One guy stood up in key moments: Cummins after thrilling series-win over NZ

Cummins lauded his team for its fearless attitude and particularly praised wicketkeeper Carey for his series-clinching effort, saying the story of the rubber was that one player who stood up when they needed.

A herculean effort from Alex Carey alongside Mitchell Marsh's 80 and Pat Cummins' late heroics helped Australia defeat New Zealand in the second Test and seal the series.

Australia had won the first Test by 172 runs in Wellington last month.

Carey finished on 98 not out

while Cummins (32 not out) struck the winning runs off New Zealand debutant Ben Sears (4/90), whose double-wicket over to collect Mitchell Marsh and Starc, earlier looked to bring the Kiwis back into the match.

In the end, the 61-run partnership between Cummins and Carey sealed the deal for Australia.

"If the scoreboard is not moving, you always feel in the game (from the bowling side), but if they're just chipping away at it seems like it's all happening pretty quickly."

"So that was a goal today - just always be busy out there. Just keep the run rate ticking over, bit by bit getting closer." Cummins was quoted as saying by ICC after the end of the match.

Cummins feels the 92-run first innings lead over New Zealand played a big role in Australia's success in the keenly-contested clash.

"That day one moved really quickly. And then after that the pitch flattened out and it was a bit tougher going for the bowlers. But yeah, the first innings lead was always key."

"I think the story of this series was in key moments one guy stood up, and we didn't necessarily play complete games but you know, someone stood up and made themselves a match-winner. (We) keep finding ways to win. It's a pretty awesome squad," he said.

"Amazing win, bit by bit, the boys were fantastic today." (PTI)

Pistol shooter Rudransh Khandelwal wins silver in Para World Cup



NEW DELHI, March 11: India's Rudransh Khandelwal and Nihal Singh settled for silver and bronze respectively in the mixed 50m pistol (SH1) category as a gold medal eluded the hosts on day three of the Para Shooting World Cup here on Monday.

Rudransh, Nihal and Tokyo Paralympics silver medalist Singhraj also bagged the mixed 50m pistol (SH1) team silver with China claiming the top step on the podium.

Teenaged shooter Rudransh, who had secured a Paris Paralympics berth last year, shot 223.2 in final to finish behind Italy's Davide Franceschetti, who totalled 230.0 for the gold medal.

Nihal had to settle for a bronze medal with 202.8 points.

Earlier in the qualification round, Rudransh shot 530 and Nihal 527 to enter the eight-shooter final placed sixth and seventh.

In the mixed 50m pistol (SH1) team event, the trio of Rudransh (530), Nihal (527) and Singhraj (516) aggregated 1573 for the silver medal with China taking the gold with a combined score 1611. Rifle shooter Mona Agarwal is the only one so far to have won a gold medal for India in the prestigious Para World Cup for India. (PTI)

Lifter Mirabai Chanu to train in Paris ahead of Olympics

NEW DELHI, March 11: Former world champion weightlifter Mirabai Chanu's proposal to train in Paris ahead of the Olympic Games was on Monday cleared by the government.

The Tokyo Olympics silver medalist will acclimatise to the weather and prepare for the quadrennial showpiece during her month-long stint in La Ferte-Milon in Paris, according to a statement by the Sports Ministry's Mission Olympic Cell.

The 29-year-old Chanu, who competes in the 49kg category, will be accompanied by two coaches and a physiotherapist.

The government will bear the cost for air tickets, visa fees, accommodation, food, training, local transport and medical insurance among other expenditures under the Target Olympic Podium Scheme (TOPS).



The Mission Olympic Cell also cleared the proposals of equestrian exponent Anush Agarwalla to compete in eight competitions and buy equipment for his horses.

"TOPS will cover his and his coach's accommodation costs, entry fees, two horse feed costs,

coach fees, and horse grooms costs among other expenditures."

Judoka Asmita Dey and shooter Arjun Singh Cheema's request for financial assistance were also cleared.

"MOC also approved judoka Asmita Dey's proposal for financial

assistance to participate in Grand Prix, Austria and shooter Arjun Singh Cheema's request for financial assistance towards participation in ISAS Dortmund competition," said the statement.

The request for financial assistance by ace Indian tennis player Sumit Nagal for participation in two international competitions along with expenditure for his support staff was also approved by MOC.

"The other proposals approved by MOC during the meeting were financial assistance towards hiring of video analyst for badminton players Chirag Shetty and Satwiksairaj Rankireddy, extension of contract for weightlifter Jeremy Lalrinnunga's physiotherapist and financial assistance towards buying equipment for track athlete Amoj Jacob," the statement added. Satwik and Chirag at forefront as Indians chase glory at All England

BIRMINGHAM, March 11: Hopes will be high on French Open champions Satwiksairaj Rankireddy and Chirag Shetty to end India's 23-year-old title drought at the All England Championships as they lead the country's charge in the tournament, starting here on Tuesday.

Prakash Padukone (1980) and Pullela Gopichand (2001) were the last Indians to claim the title with Saina Nehwal (2015) and Lakshya Sen (2022) being the only ones to come close when they finished runner-ups.

The prestigious tournament holds an iconic status in India but over the years its exclusivity has somewhat dwindled as it is now one of the four Super 1000 event on the international calendar. Satwik and Chirag have already won a Super 1000 title in Indonesia last year and given their stellar run this season, expectations would be at a record high when the two towering shuttlers take the court this week, following their exploits at Paris on Sunday night.

Satwik and Chirag, the Asian Games champions, have bossed over their opponents this season, reaching three finals -- Malaysia Super 1000, and India Super 750 before winning at Paris and will remain India's biggest hopes of a title finish at the Utilita Arena

Birmingham here.

Standing in front of them in the opening round will be the veteran Indonesian pair of Mohammad Ahsan and Hendra Setiawan, the three-time world champions, who has left the Indians with a lot of heartbreaks in the past. The 'Daddies' had defeated Satwik and Chirag the last time they faced in the French Open last year and the Indians will be etching for revenge.

If they cross the opening hurdle, the Indian duo is likely to face the Malaysian pair of Aaron Chia and Soh Wooi Yik, who has proved to be a nemesis for them but the Indians had defeated them thrice in the last three meetings. Double Olympic medallist PV Sindhu will also face an acid test this week with world no. 1 and top seed Korean An Se Young lined up in the second round once the Indian time Germany's Yvonne Li, against whom she has a 2-0 record.

Sindhu has shown that she has recovered well from the left knee injury that left her on the sidelines for four months before her campaign in the French Open last week.

With the legendary Padukone by her side, Sindhu matched Olympic champion Chen Yu Fei before marginally falling short in the quarterfinals in Paris.



The 68-year-old Indian will also be a constant source of inspiration for Lakshya Sen, who received a big boost in his race for Olympic qualification with a semifinal finish at the French Open last week. Sen will be up against Malaysia's Ng Tze Yong with a likely clash with fourth seed Dane Anders Antonsen standing in the second round.

World no. 7 HS Prannoy had made the semifinal of the India Open but bowed out in

the first round last week and will hope to go deep in the draw this week after opening against Chinese Taipei's Su Li Yang.

Kidambi Srikanth, who is racing against time to make the cut for Paris, however, will have to play out of his skin as he faces top seed and world no 1 Viktor Axelsen in the opening round, while young Priyanshu Rajawat will have to fight it out against Indonesia's Chico Aura Dwi Wardoyo. (PTI)

India skipper Rohit Sharma took full advantage of the tentative field placings on day four of the Ranchi Test

Stokes gave India the upper hand, says Ian Chappell

SYDNEY, March 11: Legendary Australian cricketer Ian Chappell has punched holes in England skipper Ben Stokes' aggressive leadership tactics during the just-concluded five-Test series against India, saying some of his decisions were responsible for the visitors' 1-4 series humiliation.

He said that while the need of the hour on the third evening of the fourth Test in Ranchi was to give the ball to pace stalwart Jimmy Anderson to make early breakthroughs, Stokes decided to bowl part-time spinner Joe Root, thus missing a trick.

"On the third evening, Stokes desperately needed to start India's chase with his best two bowlers and try to claim at least one wicket. Incredibly, he gave the ball to a part-timer, Joe Root, and ignored the experienced, probing bowling of Jimmy Anderson. India took full advantage and



scored an invaluable 40 runs off just eight overs," said Chappell in his column for ESPNcricinfo.

India did not lose a wicket in the post-tea session on day three, scoring 40 invaluable runs to put the pressure back on England. India won the Test by five wickets

to take an unassailable 3-1 lead in the series.

"Stokes missed a trick in Ranchi. He then compounded his error by allowing too many easy singles on the final day (day four) by resorting to some cautious field placings. At a time when Stokes

needed to be extremely brave as captain and hope he got lucky, he was abnormally conservative."

"India probably would still have won but at least by going on the attack, Stokes would have given England their best chance of an upset victory."

He said that Stokes could probably take a lesson or two from former Pakistan skipper Javed Miandad, who was a "leadership master" in trying situations.

Chappell added that India skipper Rohit Sharma took full advantage of the tentative field placings on day four of the Ranchi Test with a thoughtful innings, and India's solid opening partnership helped seal victory.

"By allowing easy singles, Stokes gave his opponents the upper hand. He also needed to use the experience and guile of Anderson to try and force the issue on the third evening but instead re-

lied on the part-time spin of Root." Chappell said that Kuldeep Yadav ripped open England batters' vulnerabilities to quality wrist spin, adding that R Ashwin did the job by decimating the lower order.

"In the final Test (in Dharamsala), England again capitulated to spin -- this time it was the wrist version, from the talented Kuldeep Yadav, who broke open England's vulnerable batting order while R Ashwin plundered the bottom half as offspin was again dominant.

"India have been getting stronger in this series, while England are regularly being overwhelmed by spin. They're fortunate it's the final Test. Despite all the feel-good stories and bold predictions, India and Australia are still flexing their muscles as dominant teams," Chappell added. (PTI)

Drama at wrestling trials: Vinesh does not let bouts start in two categories

PATIALA, March 11: Keen to ensure that she remains in reckoning for the Paris Games, star wrestler Vinesh Phogat did not let selection trials start in the women's 50kg and 53kg categories and demanded a written assurance from the authorities that a final trial will be held in the 53kg weight class before the Olympics.

Vinesh, who had accused former WFI President Brij Bhushan Sharan Singh of sexual harassment and led a prolonged protest against the BJP MP, turned up at the SAI centre to compete in the 50kg trials.

The 29-year-old used to compete in 53kg before the protest but has lowered her weight class since Antim Panghal has already earned an Olympic quota in that category.

However, Vinesh did not let the competition start and demanded a written assurance. She also sought permission to compete in both 50kg and 53kg trials on Monday, leading to a bizarre situation.

The officials went into discussions.

The wrestlers who are to compete in the 50kg weight class were complaining to the officials.

"We are waiting since the past 2.5 hours," they said.

This is despite the fact that IOA ad-hoc panel has already announced that a final trial will be held to pick India's representative in 53kg. The best four wrestlers in 53kg will compete in trials near the Games and the winner will be asked to compete with Antim.

The winner of that bout will represent India.

"Vinesh wants an assurance from the government. Probably she fears that if WFI gets back the control, the federation may change the selection policy. But how can the government give assurance on this. The government can't interfere in selection matters," a coach, present at the trials, told PTI.

"Probably she wants to secure her future. If she loses 50kg trials today she wants to ensure that she remains in hunt in 53kg. If she finishes in top-4 today in 53kg, she remains alive for Paris Games qualification," the coach added. (PTI)

Rahane, Musheer put Mumbai in command against Vidarbha

MUMBAI, March 11: Skipper Ajinkya Rahane bucked the trend of poor scores with a timely unbeaten 58 as Mumbai took a 260-run lead against Vidarbha at close on day two of the Ranji Trophy final here on Monday.

While young Musheer Khan reined in his aggression to make a gritty 51 not out, Rahane negotiated the Vidarbha bowling attack with utmost patience and precision to put Mumbai, who are aiming for a record 42nd Ranji title, in pole position. At stumps, the hosts were 141 for 2 in their second innings.

Having been shot out for a meagre 224 in the first innings on the first day, Mumbai came roaring back in the first session to take a 119-run lead as Vidarbha, resuming at 31/3, were dismissed for 105 in the first innings.

Rahane and Musheer came together after Mumbai lost openers Prithvi Shaw (11) and Bhupen Lalwani (18) early in their second dig, with the game delicately placed shortly after innings.

Shaw was cleaned up when Yash Thakur got one to nip back as the ball sneaked between the India player's bat and pads. Lalwani was caught at mid-wicket off Harsh Dubey (1/46).

Old warhorse Rahane and Musheer were clinical as they frustrated the opposition for more than three hours to ensure the game tilted heavily in their favour when stumps were drawn.

Rahane, who has averaged just 12 runs this season, began cautiously but grew in confidence to bring up only his second fifty of the tournament, reaching 58 not out off 109 balls with the

help of four boundaries and a six.

At the other end, Musheer kept committing himself on the front foot, meeting most of the deliveries with a dead bat to consume 134 balls for his unbeaten 51 with three fours.

The two right-handers took their time to build the unbeaten third-wicket stand of 107 runs from 232 balls.

A bit of luck favoured Rahane late in the day when Harsh Dubey pinned the batter in front of the wickets to get an on-field call for a leg-before.

But Rahane quickly took the DRS, which showed the ball had kissed the

inside edge of the bat before hitting the pads.

Musheer followed the team's instruction to a tee by dropping anchor, tiring out the opposition bowlers.

Mumbai's cause was also aided by the fact that Vidarbha's ace spinner Aditya Sarwate was under-bowled owing to an injury.

Earlier, Vidarbha showed no conviction or game plan as they were skittled out for just 105 in their first essay.

Having lost three wickets overnight, including two key batters in Dhruv Shorey and Karun Nair, Vidarbha

began cautiously but failed to stem the slide despite the pitch conducive for batting.

The lack of initiative was evident with Vidarbha neither succeeding in striking enough boundaries nor being able to rotate the strike.

Nightwatchman Aditya Thakare (19 off 69 deliveries) though performed his role admirably, holding one end up while Yash Rathod (27 off 67 balls) looked appealing.

Dhawal Kulkarni added one more wicket to his tally to return figures of 3/15, while Mumbai spinners Shams Mulani (3/32) and Tanush Kotian (4-3-1-7-3) ruled the roost in the first session.

Kulkarni bagged the first scalp of the day when he had opener Atharva Taide caught behind for a 60-ball 23.

Mulani persistently troubled a resolute Thakare until he pinned the batter down leg-before, ending his 69-ball vigil.

Left-arm spinner Mulani ensured a short stay for Dubey (1), getting him caught bat-pad, which was confirmed by the review.

Tanush Kotian had Yash Rathod chopping one onto his wickets. The spinner did not waste time in getting Yash Thakur (16) and Umesh Yadav (2) caught by Tushar Deshpande to wrap up the tail.

Job is far from done for Mumbai against Vidarbha, says Shams Mulani

MUMBAI, March 11: Senior left-arm spinner Shams Mulani feels that Mumbai team cannot afford to be complacent despite having an overall lead of 260 runs after two days in the Ranji Trophy final against Vidarbha.

Mumbai produced an all-round show on the second day at the Wankhede Stadium to take complete command, bowling out Vidarbha for a mere 105 in the first innings to earn a big 119-run lead.

In their second innings, Mumbai were jolted twice early on but skipper Ajinkya Rahane (58 not out) and Musheer Khan (51 not out) led a resolute fightback with an unbeaten 107-run stand for the third wicket to take second innings score to 141/2.

"Three days are left (in the game). We have not thought about anything else other than batting. Yes, we have got a healthy lead but we will look to build on it and see how we can improve and take the game away from them as much as possible," Mulani told the media after stumps.

"Right now, we feel that we need to bat. There's no target in mind because we are just thinking that it's just 141. We are not thinking of the lead as of now. It's just 141 for two and we will bat along — the game is still a long way to go," he added.

Mulani said Rahane's timely unbeaten fifty was worth celebrating like a century for the Mumbai dressing room.

"We celebrated like it was a hundred because we knew how important this small milestone for him is. For the team, for himself, in this situation, it was very important that he stays on the wicket," Mulani said.

The domination for Mumbai was, however, set up by veteran Dhawal Kulkarni, who snaffled two key wickets on first day evening and bowled a measly spell of 11-5-15-3 while adding one more dismissal to his kitty.

Mulani said to see former India medium pacer Kulkarni excelling in his final game of his career was "emotional".

"It was emotional moment for all of us. For him, obviously it was very emotional. But coming the way he did — he didn't play the last four games but it didn't feel like he has not played," Mulani said.

"Him coming in at a crucial stage like the finals and delivering... Coming in is a different thing and delivering in the finals is a different thing. We are very happy for him as a unit," Mulani said.

The left-arm spinner also heaped praise on Musheer for his gritty 51 not out, revealing a



dressing room conversation between the Mumbai players, including his elder brother Sarfaraz Khan, from last year when the 18-year-old made his debut.

"Last year, when Musheer made his debut, Sarfaraz told the dressing room that what others do, this guy can do much better than that," Mulani revealed.

"He knew what (kind of) character Musheer is — the gritty character that he is. He has shown that, coming into the knockouts from the (U-19) World Cup," he added.

Mulani also credited his team for being disciplined enough to bundle out Vidarbha inside one session on the second day.

"Discipline was the major thing, where we picked the wickets because we didn't give too many bad balls in the initial overs. In 14-15 overs (or so), we gave around 20-25 runs. We put the pressure on them by not giving too many runs and bowling in the right channel," he added.

Meanwhile, Vidarbha pacer Yash Thakur admitted his team is behind in the game but expressed confidence of a turnaround given the amount of time left in the contest.

"It is a long game, a five-day game. We have a chance to come back and we believe in that we will come back in this game," Thakur said.

"It is a part of the game that we collapsed. We are behind in the game but you don't know, cricket is a funny game and you can make a comeback anytime," he added.

Talking about Vidarbha's collapse in the morning session — the visitors lost seven wickets for 74 runs — Thakur said his team had a batting plan in place but failed to execute.

"What should I say? We had planned but unfortunately it did not happen our way. They were bowling well and we suddenly collapsed — it was a bad session — I can certainly say that," he added. (PTI)
