# Grand old party receives I-T notices of over ₹ 1,800 crore

BJP accused of indulging in 'tax terrorism', violating I-T regulations

NEW DELHI, March 29: The Congress on Friday said it has received fresh notices from the income-tax department, asking it to pay ₹ 1,823.08 crore, and alleged that the BJP is in "serious violation" of income-tax laws for which authorities should raise a demand of more than ₹ 4,600 crore from the saffron party.

The Congress also accused the ruling BJP of indulging in "tax terrorism" to financially cripple the opposition party ahead of the Lok Sabha polls.

Addressing a press conference at the AICC headquarters here along with Congress general secretary Jairam Ramesh, party treasurer Ajay Maken alleged that the BJP is in serious violation of income-tax laws and said the I-T department should raise a demand of ₹ 4,617.58 crore from the saffron party for such violations.

Maken said political parties have to fill up a proforma of Form 24A, in which two basic and important pieces of information have to be furnished -- the names and addresses of their donors.

"We have analysed all the submissions of the BJP to the Election Commission (EC). The party has faltered every year," Maken claimed.

Ramesh alleged that through the "electoral bonds scam", the Bharatiya Janata Party (BJP) has collected ₹ 8,200 crore and used

GUWAHATI, March 29: Chief Minister Himanta Biswa Sarma on Friday said that Union home minister Amit Shah will campaign for the first phase of Lok Sabha polls in the state on April 6.

The BJP leader will campaign in Lakhimpur parliamentary constituency and in Hojai which falls under Kaziranga seat, Sarma told reporters at the BJP state headquar-

'We have discussed Prime Minister Narendra Modi's campaigning in the state with New Delhi and it is being worked out. We will know the details by tomorrow or day after,' he said.

Sarma will begin his campaign in the state from April one by participating in a cycle rally in Majuli.

'The candidates have already launched their campaign in their respective constituencies with each of them addressing 10 to 12 meetings daily,' Sarma said.

The most important aspect of the campaign this time will be the 'socio-economic survey by the booth committees to ascertain whether any beneficiary has been left out of government schemes

# Vice President calls for neutralising 'anti-national' narrative regarding judiciary

During the discussion that touched on a slew of topics, from AI to Digital Public Infrastructure, the PM said in the case of deepfakes, it is crucial to acknowledge and identify that a particular deepfake content is AI-generated, along with appropriate disclosures about

# Neglect plagues multi-crore water supply project

Amidst the state government's proclamation of development, the multi-crore project by the Irrigation Department in Ledo Maulang, under the 83rd Margherita constituency in Tinsukia district, resembles more of a deserted structure than a symbol of progress. Despite significant investments, including iron pipes, boats, staff quarters, water motors. and various electrical equipment, the site languishes in neglect with-

out adequate security measures. Local residents lament the lack of attention from state government officials, including the Irrigation Department minister and higherranking personnel. Despite the presence of four department employees, their sporadic visits and hefty monthly salaries over the years have failed to address the project's deterioration.

The neglect has had tangible consequences, with agricultural fields suffering due to water scarcity. Despite pleas from locals,

officials have been remiss in their duties, failing to address the urgent need for water access in the area.

# Arvind Kejriwal's arrest poses a big threat to parliamentary democracy in India

The arrest and detention of turning point in the steady erosion of democracy in India. This brazen assault on the democratic system is a first in many respects. It is the first time a sitting chief minister whose party commands more than four-fifth majority in the assembly has been arrested. for the first time the head of a national political party has been put behind bars. And this is the very first time that such an arrest has been affected after the announcement of the Lok Sabha election and the model code of conduct has come into force.

The ruling party is out to finish off the opposition using an array of instruments of the State. The central agencies are being used to target key opposition leaders. Prior to Keiriwal's arrest, the chief minister of Jharkhand Hemant Soren was detained by the ED just after he resigned from the chief ministership. Earlier the deputy chief minister of Delhi, Manish Sisodia was arrested and spent nearly a year in jail. There are scores of further opposition leaders and ministers in all non-BJP state governments who are either in jail or facing investigations by the central agencies. The central agencies have also been illegally used to threaten opposition leaders and legislators to engineer their defection to the

The notorious role of the ED has been exposed after the details of the electoral bond scheme were made public. In the liquor policy case in which Kejriwal has been implicated, the ED had arrested the managing director of a pharmaceutical company, Aurobindo Pharma, Sarath Chandra Reddy, whose company donated ₹ 5 crore through electoral bond to the BJP, five days after his arrest in November 2022. Subsequently, he got bail and turned approver and four months later, ₹ 25 crore was paid to the BJP through bonds. This shows how the cases against Kejriwal and AAP leaders have been manufactured. Apart from coercive action by the ED and the CBI, opposition parties are facing attacks by the Income Tax department on

their finances. The main opposition party, the Congress, has faced penal action and been taxed Arvind Kejriwal, chief to the tune of ₹ 135 crores for the minister of Delhi, by the financial year 2018-19. Its bank IT department recovered this amount. Similar action is being taken against other parties too. For instance, the CPI(M) had its tax exemption withdrawn for the year 2016-17 and ordered to pay a tax of ₹ 15.59 crore for the mere technical lapse of not listing one of the hundreds of bank accounts that the Party has all over the country. The CPI(M) went to the Delhi High Court against this unwarranted action and the matter is sub-judice at the moment.

After having choked off legal funding to the opposition parties through the electoral bond scheme and monopolising corporate donations through electoral trusts, the Modi government is now bent upon strangulating the opposition financially through punitive taxation measurers.

The Kejriwal arrest comes after the systematic onslaught on the powers of the elected government in Delhi. Just like the opposition parties, state governments run by the opposition are under attack through assaults on the federal principle.

It is in this context that the Kejriwal arrest must be seen as part of the existential threat to parliamentary democracy in India. There are no pretensions left, the veil is off. A tyrannical regime has established an electoral autocracy. The Election Commission is under the thumb of the executive and the higher judiciary is refusing to confront a rampaging gov-

There is no other way but for the secular and democratic forces to go to the people and mobilise them against the threat to their democracy and citizens' rights. The mass protests musts not be centered in Delhi alone, where a mass rally by the INDIA bloc is being organised on March 31, but must spread thorough out the country. Kerala had shown the way where mass demonstrations and rallies have been held all across the state. It is essential that popular protests and mass campaigns take place. It is such public mobilisation that will certainly affect the BJP adversely in the elections. (IPA Service)

# A working paper on "Study on violation of rights of private sector employees in State of Nagaland"

stances of infringements upon rights of employees within Nagaland's burgeoning private sector, our attention has been drawn to 234 cases wherein the rights of employees engaged in various occupations such as Hotel staff, Shop staff, Workshop staff, School teachers, Media employees, College teachers, Construction labourers, Daily wage earners and NGO workers/employees have been compromised. In the sphere of employment, the relationship between an employer and an employee is governed by a complex interplay of statutory provisions, corporate policies, and ethical precepts. Central to this discourse is the contentious issue surrounding the deduction of an employee's remuneration for instances of tardiness that is Late coming (Late arrival at workplace) as we found this as one of the common "allegations" against employees in Nagaland. Hence, our discovery made us launch a focal inquiry pertaining to the legal prerogative of an employer to effectuate deductions from an employee's salary owing to late arrival, and if so, the requisite conditions and limitations governing such ac-

It is firmly established in jurisprudence that an employer possesses the legal prerogative to promulgate and enforce rules pertaining to punctuality and attendance within the workplace. Nonetheless, the exercise of this authority must adhere scrupulously to established legal norms and principles of fairness. Consequently, an employer is empowered to deduct an employee's salary for tardiness, provided that such deductions are commensurate with the duration of the lateness and are executed in strict conformity with applicable statutory provisions and judicial precedents.

For instance, in the event that an employee is late by one hour in reporting to work, the employer is within their rights to deduct from the employee's salary an amount commensurate with the duration of said tardiness. Any deduction surpassing the actual period of absence would run afoul of the principles of proportionality and equity. It is imperative to underscore that deductions must be limited to the precise duration of the employee's absenteeism.

A frequently encountered misinterpretation observed in certain organizations involves the deduction of half-day salary in instances where an employee arrives one or more hours late. It is imperative to note that such a policy lacks legal foundation and constitutes a clear infringement upon the principles of justice codified within the law. Employees subjected to these arbitrary deductions possess the right to pursue legal recourse to challenge these unjust practices.

It is incumbent upon companies/business entities to acknowledge that their policies must conform to legal statutes and constitutional principles, rather than being solely guided by subjective moral considerations/moral compass. Instances wherein organizations arbitrarily deduct a full day's salary for minor tardiness, ranging from 5 to 30 minutes to one or more hours, demonstrate a disregard for legal standards. In such circumstances, employees are advised to pursue legal recourse to rectify the financial losses suffered as a result of un-

lawful deductions. Employees who have been unfairly subjected to deductions have legal avenues available for seeking redress. They possess the

Labour Department, an administrative body tasked with overseeing matters pertaining to employment and ensuring adherence to labour legislation. Furthermore, employees retain the option to initiate legal proceedings in civil courts (by initiating recovery suits) to pursue remedies for damages incurred as a consequence of unlawful practices perpetrated by their employ-

Moreover, mental harassment in the form of late wages, no wages, or even equal pay for equal work or illegal deductions in salary can be easily claimed. Redressal in such cases can be granted by the Labour Court if the victim approaches the Labour Court/Industrial Tribunal under the Industrial Dispute Act, 1947 or the Payment of Wages Act, 1936. Importantly, all those workers/employees not governed by the Industrial Disputes Act, 1936 can very well move to the Civil Court jurisdiction.

Nevertheless, despite facing the prospect of salary deductions for tardiness / late arrival at work, it was found in our survey that a considerable number of employees continue to uphold their work obligations diligently. This steadfast commitment to their duties underscores a profound sense of dedication and professionalism that extends beyond mere monetary concerns which in itself becomes a "mitigating factor" in disciplinary proceedings against them. It is important to make our readers aware that In all the Criminal Trials we do not just look at the "Mens-Rea" and "Actus Reus" but also look at the "mitigating factors". Similarly, in issues related to disciplinary cases at workplace consideration of mitigating factors is a legal obligation for the concerned H.R.

continues to fulfill their work duties for the entirety of the workday before departing, it becomes evident that the severity of the consequences imposed is disproportionate to the infraction committed.

The issue of deducting an employee's salary for tardiness necessitates a careful examination of legal principles, ethical considerations, and practical implications. While employers have the authority to enforce rules regarding punctuality, they must do so in a manner that is proportionate, fair, and consistent with legal re-

Employees, on their part, have the right to challenge arbitrary deductions through legal avenues to safeguard their rights and interests in the workplace. Ultimately, fostering a work environment characterized by fairness, respect, and mutual understanding is essential for proproductivity employee well-being.

Moreover, the issue of deducting an employee's salary for tardiness cannot be viewed in isolation; rather, it must be contextualized within the broader framework of employee rights and protections against exploitation within the private sector. Exploitation of private sector employees represents a grave concern, encompassing various forms of misconduct by employers aimed at deriving undue benefits at the expense of their workers' rights and well-being. Legal frameworks worldwide seek to address and prevent such exploitation through a range of provisions and regulations tailored to safeguard employee rights, thereby ensuring fair treatment and just compensation for all workers within the private

One common aspect of legal protections for employees is the establishment of minimum wage rates, which serve to guarantee a baseline level of compensation for labour and prevent exploitation through substandard pay. Employers who pay below the mandated minimum wage or circumvent statutory entitlements exploit their employees' vulnerability for unjust gain. Moreover, laws often limit the number of hours an employee can work per week without receiving overtime pay, aiming to prevent exploitation when employers compel their workers to toil excessively without proper compensation, contravening labor regulations and disregarding employees'

Wage theft, another form of exploitation, occurs when employers illegally withhold or fail to pay salary/wages owed to their employees, taking various forms such as non-payment for work performed unauthorized deductions, or misclassification of workers to evade providing rightful benefits or protections. Additionally, ensuring safe working conditions is a fundamental responsibility of employers governed by occupational health and safety regulations, with exploitation arising when employers flout these regulations, subjecting employees to hazardous environments jeopardizing their physical or mental health.

Discrimination and harassment, prohibited by law, represent forms of exploitation when employers engage in discriminatory practices such as pay disparities, wrongful termination, or fostering a hostile work environment through systemic harassment based on protected characteristics. Moreover, contractual violations constitute exbreach the terms and conditions outlined in employment contracts (or add conditions without taking expressed/written consent from employee or by way of systematic coercion-for e.g. threat of termination), including reneging on promised benefits, unilaterally altering terms without employee consent, or retaliating against whistleblowers exposing illegal/unlawful activities or safety concerns at workplace.

In our research we found that, In Nagaland, as in other regions of India, private sector employees encounter similar challenges related to exploitation, including non-payment or delayed payment of wages, violation of minimum wage standards, overtime violations, lack of social security benefits, unsafe working conditions, discrimination, harassment, contractual breaches, and insufficient legal awareness among employees. To address these issues effectively, robust legal frameworks and enforcement mechanisms are essential.

In Nagaland, employees can seek recourse by reporting grievances to the Nagaland Labour Department, which oversees labour law enforcement and dispute resolution. Furthermore, the active involvement of labour unions, civil society organizations, and public spirited individuals is crucial in advocating for employee rights and providing support to those facing exploitation within the private sector. By upholding and strengthening these legal protections, societies can strive towards fostering fair and equitable workplaces where employees are treated with dignity and respect.

It is high time residents of Nagaland, especially employees in the private sector, should make themselves aware of legal provisions which can safeguard their life and rights. Knowledge of Law is an empowerment so that none can fool an individual and take them for a ride. In a rapidly evolving world where legal intricacies can often determine the course of one's life, understanding one's rights and obligations under the law is paramount. By familiarizing themselves with legal provisions, residents of Nagaland can equip themselves with the tools necessary to navigate various situations and protect their interests.

Whether it pertains to civil matters, matrimonial rights, employment rights, consumer protection or criminal justice, having a basic understanding of the law empowers individuals to assert their rights and seek redressal when necessary. Moreover, an informed citizenry serves as a bulwark against exploitation and injustice, fostering a society founded on principles of fairness and equality before the law. Therefore, it is incumbent upon residents of Nagaland to invest in legal literacy and education, thereby enhancing their ability to assert their rights and contribute to the overall welfare and development of the state. For instance, Section 503 and Section 504 deal with criminal intimidation and intentional insult with intent to provoke breach of peace, respectively. We came across a case where employers (Partnership Firm) have regularly used abusive language against a certain employee which even led the concerned person to develop suicidal tendency (Suicidal tendency is actually very rare in Naga society).

An inherent challenge in penalizing late attendance lies in the failure to differentiate between remuneration (salary) and punitive measures (penalty/fine). Remuneration, constituting payment for services rendered by an emplovee, contrasts with fines, which serve as sanctions for infractions or breaches of regulations. Policies that equate tardiness with salary deductions blur the distinction between remuneration and penalties, thus detracting from the fundamental principle of compensating workers/employees for their labour.

In a hypothetical scenario, let us consider a situation wherein a company establishes a late attendance policy wherein tardiness exceeding the fourth instance results in the forfeiture/deduction of an entire day's compensation. Such a stringent measure fails to adhere to principles of proportionality and fairness. Depriving an employee of their full day's compensation for tardiness (when in-fact employees go on performing all of their tasks throughout the day at work) is excessively severe and lacks justifiable rationale hence deserved to be examined in the eyes of Law.

Moreover, it must be noted that employees who arrive late, within a range of 5 to 15, or at most 20/30 minutes to one hour, are nonetheless capable of fulfilling their contractual obligations and contributing to the organizational objectives with due diligence. Despite occasional instances of punctuality lapses, these employees consistently discharge their assigned duties. This raises the pertinent inquiry: What recompense do these diligent employees receive for their exertions on days when they are

# US President Joe Biden approves \$60mn aid; Governor Wes Moore warns of 'very long road ahead' for recovery

MORE - Maryland Gov. Wes Moore warned on Thursday of a "very long road ahead" to recover from the loss of Baltimore's Francis Scott Key Bridge as the Biden administration approved \$60 million in immediate federal aid after the deadly collapse.

Meanwhile the U.S. Army Corps of Engineers was moving the largest crane on the Eastern Seaboard to help remove the wreckage of the bridge, Moore said, so work to clear the channel and reopen the key shipping route can begin. The machine, which can lift up to 1,000 tons, was expected to arrived on Thursday evening, and U.S. Sen. Chris Van Hollen said a second crane with a 400-ton capacity could arrive Satur-

The state is "deeply grateful" for the federal funds and support, Moore said at an evening news conference. Moore promised Thursday that "the best minds in the world" were working on plans to clear the debris, move the cargo ship that rammed into the bridge from the channel, recover the bodies of the four remaining workers presumed dead and investigate what

"Government is working hand in hand with industry to investigate the area, including the wreck, and remove the ship," said Moore, a Democrat, who said the quick aid is needed to "lay the foundation for a rapid recovery." President Joe Biden has pledged the federal government would pay the full cost of rebuilding the bridge

"This work is not going to take hours. This work is not going to take days. This work is not going to take weeks," Moore said. "We have a very

The huge vessel, nearly as long as the Eiffel Tower is tall, was carrying nearly 4,700 shipping containers, 56 of them with hazardous materials inside. Transportation Secretary Pete Buttigieg, who met Thursday with supply chain officials, has said the Biden administration was focused on reopening the port and rebuilding the bridge, but he did not put a timeline on those efforts.

From 1960 to 2015, there were 35 major bridge collapses worldwide due to ship or barge collisions, according to the World Association for Waterborne Transport Infrastructure.

# Russia launches barrage of 99 drones and missiles on Ukraine's energy system: Officials

KYIV, March Moscow launched a large scale attack on Ukraine's energy infrastructure on Friday, with a mass barrage of 99 drones and missiles hitting regions the country, Ukraine's armed forces



raid warnings across the country continued through the night as the strike targeted 10 separate regions, Ukraine's Interior Minister, Ihor Klymenko, said in a statement on Telegram. The Ukrainian air force reported that 60 Shahed drones and 39 missiles of varying types were seen across the country, of which 58 drones and 26 missiles were ultimately shot down by air defenses.

Ukraine's state-owned grid operator, Ukrenergo, said that the attack deliberately targeted energy infrastructure, including thermal and hydroelectric power plants across central and western regions.

DTEK, Ukraine's largest private electricity operator, also said Friday that three of its thermal power plants had been damaged in the attack. Elsewhere, five people were wounded during the attack in Ukraine's Dnipropetrovsk region, said local governor Serhii Lysak. The injured included a 5-year-old girl. The bombardment in the west of Ukraine caused the Polish Armed Forces to scramble its own aircraft, the country's operational command said on social media.

Putin says he won't start a war with NATO. But Western bases hosting Ukraine F-16s would be targets Last week Warsaw demanded an explanation from Moscow, after one of its missiles strayed briefly into Polish airspace during a major missile attack on Ukraine, prompting the NATO member to activate F-16 fighter jets.Romania's defense ministry also said on Friday that an investigation has been launched after fragments that appear to be from a drone were identified on its territory on Thursday evening in an agricultural area of Braila county, close to the border with Ukraine. It did not provide additional details, although since the start of the fullscale invasion of neighboring Ukraine, NATO member Romania has confirmed drone fragments on its territory on several occasions. #### Mob in Mexico brutally beats suspected kidnapper to death hours before Holy Week procession

TAXCO, March 29: A mob in the Mexican tourist city of Taxco brutally beat a woman to death on Thursday because she was suspected of kidnapping and killing a young girl, rampaging just hours before the city's famous Holy Week pro-

The mob formed after an 8year-old girl disappeared on Wednesday. Her body was found on a road on the outskirts of the city early on Thursday. Security camera footage appeared to show a woman and a man loading a bundle, which may have been the girl's body,

into a taxi. The mob surrounded the woman's house Thursday, threatening to drag her out. Police took the woman into the bed of a police pickup truck, but then stood by — apparently intimidated by the crowd — as members of the mob dragged her out of the truck and down onto the street where they stomped, kicked and pummelled her until she lay, partly stripped and motionless.

Police then picked her up and took her away, leaving the pavement stained with blood. The Guerrero state prosecutors' office later confirmed the woman

died of her injuries. "This is the result of the bad government we have," said a member of the mob, who gave her name as Andrea but refused to give her last name. "This isn't the first time this kind of thing has happened," she said, referring to the murder of the girl, "but this is the first time the people have done something.

The mayor of Taxco, Mario Figueroa, said he shared residents' outrage over the killing. Figueroa said a total of three people beaten by the mob — the woman and two men — had been taken away by police. Video from the scene suggested they had also been beaten, though The Associated Press witnessed only the beating of

The state prosecutors' office said the two men were hospitalized. There was no immediate information on their condition.

In a statement issued soon after the event. Figueroa complained he did not get any help from the state government for his small, outnumbered municipal police force.

"Unfortunately, up to now we have not received any help or answers," Figueroa said.

The Good Friday eve religious procession, which dates back centuries in the old silvermining town, went off as planned Thursday night.

People crowded Taxco's colonial streets to watch hooded men walking while whipping themselves or carrying heavy bundles of thorns across their bare shoulders in penitence to emulate the suffering of Jesus Christ carrying the cross.

Mob attacks in rural Mexico are common. In 2018, two men were torched by an angry crowd in the central state of Puebla, and the next day a man and woman were dragged from their vehicle, beaten and set afire in the neighboring state of Hi-

In late January, Taxco endured a days-long strike by private taxi and van drivers who suffered threats from one of several drug gangs fighting for control of the area. The situation was so bad that police had to give people rides in the back of their patrol vehicles. (AP)

#### Pak Finance Min says meeting with IMF scheduled for April 14-15

**KARACHI, March 29:** Pakistan's Finance Minister Muhammad Aurangzeb on Friday said the government will hold a meeting with the IMF on April 14 and 15 in Washington to discuss the features of the new bailout programme which the cash-strapped country is seeking, according to a media report.

The minister for finance and revenue in the Shehbaz Sharif government, while addressing journalists during his visit to the Pakistan Stock Exchange here, reiterated that the government plans to enter a major programme with the International Monetary Fund which will ensure microeconomic stability, Geo News reported.

Aurangzeb said the features of the new programme would be discussed during the meeting, while detailed talks would be held in Pakistan, the report said.

Prime Minister Shehbaz on March 21 signalled that the new IMF programme was likely to be continued for three years.

Shehbaz, while addressing a session of the Special Investment Facilitation Council's apex committee attended by civil-military leadership, said the new tranche of loan was likely to be received from the IMF in a few days.

"However, we would need another programme," he added.

He also said the country's current account was "better" and the exchange rate was also "stable", the report said.

Aurangzeb said the inflation rate has also decreased and credited the accomplishments to the stand-by arrangement (SBA) agreement during PM Shehbaz's last tenure.

"The caretaker government did better work to restore the economy. The economy will stabilise soon owing to better economic policies," the minister was quoted as saying.

# Haiti now needs up to 5,000 police to help tackle 'catastrophic' gang violence, UN expert says

Haiti now needs between 4,000 and 5,000 international police to help tackle "catastrophic" gang violence which is targeting key individuals and hospitals, schools, banks and other critical institutions, the U.N. rights expert for the conflict-wracked

Caribbean nation said on Thursday. Last July, William O'Neill said Haiti needed between 1,000 and 2,000 international police trained to deal with gangs. Today, he said the situation is so much worse that double that number and more are needed to help the Haitian National Police regain control of security and curb

numan rights abuses. O'Neill spoke at a news conference launching a U.N. Human Rights Office report he helped produce which called for immediate action to tackle the "cataclysmic" situation in Haiti where corruption, impunity and poor governance compounded by increasing gang violence have eroded the rule of law and brought state in-

stitutions "close to collapse." The report, covering the fivemonth period ending in February, said gangs continue to recruit and abuse boys and girls, with some children being killed for trying to escape.

Gangs also continue to use sexual violence "to brutalize, punish and

O'Neill said re-establishing security is key, and getting the international security force on the ground in Haiti is critical and urgent.

Getting the transitional presidential council officially installed and active is also "crucial" and "absolutely vital," O'Neill said, expressing hope this could happen possibly next week. For one thing, Kenya's President William Ruto has said he won't deploy police to lead the multinational security operation until he has a Haitian counterpart, the U.N. expert said. O'Neill said the trust fund to finance the international police operation also desperately needs funds.

Haiti asked for an international force to combat gangs in October 2022. and U.N. Secretary-General Antonio Guterres appealed for a force last July, he said.

"We're still waiting and every day lost means more people die, and more women and girls get raped, and more people flee their homes," O'Neill said. "So the sooner the better." (AP)

# Bus plunges off a bridge in SA, killing 45 people, 8-yr-old survives

MANILA, March 29: A Filipino villager has been nailed to a wooden cross for the 35th time to re-enact Jesus Christ's suffering in a brutal Good Friday tradition he said he would devote to pray for peace in Ukraine, Gaza and the disputed South China Sea.

On Friday, over a hundred people watched on as 10 devotees were nailed to wooden crosses, among them Ruben Enaje, a 63-year-old carpenter and sign painter.

The real-life crucifixions have become an annual religious spectacle that draws tourists in three rural communities in Pampanga

province, north of Manila. The gory ritual resumed last year after a three-year pause due to the coronavirus pandemic. It has turned Enaie into a village celebrity for his role as the "Christ" in the Lenten reenactment of the Way of the

Ahead of the crucifixions, Enaje told The Associated Press by telephone on Thursday night that he has considered ending his annual religious penitence due to his age, but said he could not turn down requests from villagers for him to pray for sick relatives and all other kinds of mal-

adies. The need for prayers has also deepened in an alarming period of wars and conflicts worldwide, he said.

"If these wars spread, more people, especially the young and old, would be affected. These are innocent people who

have totally nothing to do with these wars," Enaje said.

CAPE TOWN, March 29: A bus carrying worshippers on a long-distance trip from Botswana to an Easter weekend church gathering in South Africa plunged off a bridge on a mountain pass on Thursday and burst into flames as it hit the rocky ground below, killing at least

45 people, authorities said. The only survivor was an 8-yearold child who was receiving medical attention for serious injuries.

The Limpopo provincial government said the bus veered off the Mmamatlakala bridge in northern South Africa and plunged 50 meters (164 feet) into a ravine before busting into flames.

Search operations were ongoing. the provincial government said, but many bodies were burned beyond recognition and trapped inside the vehicle, while others had been thrown from the bus.

The crash happened near the

town of Mokopane, which is about 200 kilometers (125 miles) north of the South African capital, Pretoria.

Hours after the crash, smoke

seeped from the mangled, burned wreck underneath the concrete bridge. Authorities said it appeared that the driver lost control and the bus ploughed into the barriers along the side of the bridge and then over the edge. The driver was one of the

dead. South African President Cyril Ramaphosa said the victims appeared to be all from Botswana and had been on their way to the town of Moria in Limpopo for a popular Easter weekend pilgrimage that attracts hundreds of thousands of worshippers from South Africa and neighboring countries who follow the Zion Christian Church.

# Aspirants with Imphal as exam centre can change it, Delhi HC told

**NEW DELHI, March 29:** The Union Public Service Commission (UPSC) has told the Delhi High Court that it will permit candidates from the hill districts of Manipur, who have opted for Imphal as their examination centre to change it and that the state government will facilitate their travel.

The commission said such aspirants can choose any of the centres in Aizawl in Mizoram, Kohima in Nagaland, Shillong in Meghalaya, Dispur and Jorhat in Assam, Kolkata in West Bengal and Delhi by making a request for change of examination centre between April 8 and 19 through an e-mail.

The statement came on a petition by Zomi Students Federation seeking setting up of examination centres in Churachandpur and Kangpokpi in the hill districts of Manipur for Civil Services (Preliminary) Examination, 2024 and Indian Forest Service (Preliminary) Examination, 2024.

The UPSC said that since the Manipur government has expressed its inability to open examination centres in Churachandpur and Kangpokpi, it was not feasible to open and operate examination venues there for the UPSC exam-

"He (UPSC's counsel) assures that the Commission will permit the candidates from the hill districts of Manipur who have opted for Imphal as their ex-

amination centre to change their examination centre during the period 8th April, 2024 to 19th April, 2024 by making a request for change of examination centre at e-mail ID: uscspupsc@nic.in," recorded a bench of Acting Chief Justice Manmohan and Justice Manmeet PS Arora in an order passed

The court, in its order, also noted that the Manipur government has decided to extend financial assistance in the form of reimbursement of fare for conveyance, limited to the maximum of 2nd class sleeper railway fare rates or notified bus fare rate of the State, as well as for fooding and accommodation at the rate of Rs 1,000 per day for three days at the maximum.

In case of any need, the candidates from these districts can contact the Commission's toll-free helpline number 1800118711, added the court.

Closing the proceedings on the petition, the court "accepted" the statements and assurances given by the Commission as well as by the State of Manipur and said they would be held bound by

Manipur plunged into violence in May 2023 over a high court order directing the state government to consider including the non-tribal Meitei community in the list of Scheduled

This order led to rampant ethnic clashes. More than 160 people have been killed and several hundred injured since the ethnic violence first broke out in the state on May 3 when a 'Tribal Solidarity March' was organised in the hill districts to protest against the majority Meitei community's demand for scheduled tribe status. ## Mahagathbandhan announces LS seat-sharing for Bihar; RJD to contest 26, Cong 9

PATNA, March 29: The RJD-led Mahagathbandhan in Bihar on Friday announced its formula for seat-sharing, with Lalu Prasad's party laying claim on nearly twothirds of the state's 40 parliamentary constituencies, virtually steamrolling allies - the Congress and three Left parties.

The RJD will be contesting 26 seats, nine more than it had fought in 2019 when it drew a blank. The Congress has got nine seats, as many as it had contested in the last elections, followed by CPI(ML) Liberation (three) and CPI and CPI(M) (one each).

The belated announcement, coming a day after filing of nomination papers for the first phase of Lok Sabha polls was over, was made at a press conference here addressed by RJD national spokesman and Rajya Sabha MP Manoj Kumar Jha, state Congress president Akhilesh Prasad Singh and state-level leaders of CPI(ML) Liberation, CPI and CPI(M).

Tejashwi Yadav, the Mahagathbandhan's leader in the state legislature, was scheduled to address the press conference but remained conspicuous by his absence.

Jha said names of candidates would be announced soon and claimed: "We have arrived at a unanimous decision, demonstrating a cohesiveness that you may

not find in the NDA. We will defeat them at the hustings".

Notably, the RJD had fielded its candidates for the four seats of Gaya, Aurangabad, Jamui and Nawada, which go to polls in the first phase, much to the annoyance of its allies, particularly the Congress which wanted to give ticket

to former MP Nikhil Kumar. Moreover, CPI and CPI(M) have already announced their candidates for Begusarai and Khagaria

According to the seat-sharing formula, the RJD has also wrested from the Congress Purnia, a seat the latter has been contesting in the past few Lok Sabha polls.

Recently, Lalu Prasad, the RJD president, gave party ticket for the seat to JD(U) turncoat Bima Bharti, stopping short of making a formal announcement.

The Congress had last week inducted Pappu Yadav, a three-term former MP from Purnea, whose wife is also a Rajya Sabha MP of the party. Yadav had been hopeful of getting the ticket from the seat claiming that an assurance to the effect was given to him by Rahul Gandhi and Privanka Gandhi.

There were murmurs that Prasad, whose "blessings" Yadav had sought before he went to Delhi and merged his Jan Adhikar Party with the Congress, was suggesting that the former Purnea MP try his luck from Madhepura, which he had won on an RJD ticket in 2014, or Supaul which his wife had represented more than once.

However, that option, too, seems closed as both seats have been claimed for itself by the RJD and it remains to be seen what is going to be the next move of Yadav who has been dropping hints that he will not flinch from fighting as an Independent from Purnea if the need arose

Among the seats given to the Congress are Kishanganj, Bihar's lone Muslim-majority constituency that the party has been winning for some time, and adjoining Katihar where senior leader Tariq Anwar lost by a thin margin in 2019, having won in 2014 on an

Other seats given to Congress include Patna Sahib, where the BJP has been seemingly invincible, Bhagalpur, where party MLA Ajeet Sharma wanted to field Bollywood actress daughter Neha Sharma, who has refused, and reserved constituency Sasaram, a bastion of late Deputy Prime Minister Jagjivan Ram, whose daughter and former Lok Sabha Speaker Meira Kumar, has won the seat a few times but reportedly excused herself this time on account of old

#### 44 per cent of sitting MPs face criminal charges, 5 per cent are billionaires: ADR



NEW DELHI, March 29: Out of the 514 sitting Lok Sabha MPs analysed, 225 (44 per cent) have declared criminal cases against themselves, according to the selfsworn affidavits analysed by poll rights body Association of Democratic Reforms (ADR).

Out of those analysed, 5 per cent are billionaires, with assets exceeding ₹ 100 crore.

The report by the ADR, which scrutinised affidavits of the sitting MPs, revealed that among the sitting MPs with criminal charges, 29 per cent face serious criminal cases, including allegations of murder, attempt to murder, promoting communal disharmony, kidnapping, and crimes against women.

Out of the sitting MPs with serious criminal cases against them, nine face murder cases. The analysis revealed that five of these MPs belong to the BJP.

Furthermore, 28 sitting MPs have declared cases related to attempt to murder, with a majority—21 MPs—belonging to the BJP. Similarly, 16 sitting MPs face charges related to crimes against women, including three

allegations of rape. The report also sheds light on

Among major parties, the BJP and the Congress have the highest number of billionaire MPs, though the analysis shows significant representation from other parties as well.

Regarding the distribution of criminal cases among states, Uttar Pradesh, Maharashtra, Bihar, Andhra Pradesh, Telangana, and Himachal Pradesh stand out with more than 50 per cent of their MPs facing criminal

Additionally, the analysis unveils disparities in wealth among MPs, with some having assets worth hundreds of crores, while

others have minimal assets. Notably, the top three MPs with the highest declared assets are Nakul Nath (Congress), DK Suresh (Congress), and Kanumuru Raghu Rama Krishna Raju (Independent), with assets

amounting to hundreds of crores. The report also highlights the educational background, age, and gender distribution among the sitting MPs.

A significant majority—73 per cent—of the MPs have graduate or higher educational qualifications, while only 15 per cent of the sitting MPs are women. (PTI)

#### BJP misusing agencies to subvert democracy, belittle Constitution: Kharge

NEW DELHI, March 29: Congress president Mallikarjun Kharge accused the BJP-led Centre on Friday of misusing institutions like the incometax department, ED and CBI to subvert democracy and belittle the Constitution, and asked why is the I-T department being used as a weapon to harass the principal opposition party.

#### More than 79,000 violations reported so far through C-Vigil app, says EC

NEW DELHI, March 29: The Election Commission (EC) on Friday said its C-Vigil mobile application has become an effective tool in the hands of people for flagging poll code violations and since the announcement of the Lok Sabha election, more than 79,000 complaints have been received. More than 99 per cent of the complaints have been resolved and close to 89 per cent of those were resolved within 100 minutes, the poll panel said. More than 58,500 complaints (73 per cent of the total number of complaints) received were against illegal hoardings and banners, the EC said, adding that over 1,400 complaints received pertained to money, gifts and liquor distribution.

Close to 3 per cent of the complaints (2,454) were related to defacement of property. Of the 535 complaints received for display of firearms and intimidation, 529 have been resolved, the poll panel said.

A total of 1,000 complaints were for campaigning beyond the prohibited period, including those related to the use of speakers beyond the per-

# INDIA parties stage protest in Mumbai, call Kejriwal's arrest 'illegal', 'unjustified' Kejriwal arrested as Union govt

MUMBAI, March 29: Opposition INDIA bloc parties staged a protest in Mumbai on Friday against the arrest of Delhi chief minister Arvind Kejriwal in an excise policylinked money laundering case and called the ED action "illegal" and "unjustified". Demonstrators held a 'satyagraha' (a form of non-violent resistance) at south Mumbai's Azad Maidan and called for the Bharatiya Janata Party (BJP)'s resounding defeat in the upcoming Lok Sabha polls. The anti-BJP grouping consisting of more than two dozen parties reiterated commitment to their united struggle against the Modi government's "tyranny". Political workers cutting across party lines braved scorching heat to register their protest against Kejriwal's arrest by the Enforcement Directorate last week. The Kejriwal-led Aam Aadmi Party (AAP) is a constituent of INDIA, which was formed last year to take on the BJP and the Lok Sabha polls.

In attendance at the protest site were Varsha Gaikwad, Mumbai Congress president, Bhai Jagtap Congress MLC, Preeti Sharma-Menon, AAP Mumbai chief, Rakhee Jadhay, Mumbai head of NCP (Sharadchandra Pawar), Vidya Chavan of NCP(SP), Shailendra Kamble of CPI-M, Samya Korde of Peasants and Workers Party of India and a few other leaders of INDIA. Sharma-Menon said previous arrest of former Delhi ministers and AAP politicians Manish Sisodia and Satyendar Jain has disrupted the work they were doing in education and healthcare fields, respectively.

"It is not Manish Sisodia who is in jail, it is education (portfolio held by him as deputy CM) in India that is in jail. It is not Satyendar Jain who is in jail, it is healthcare that is in jail. And it is not Arvind Kejriwal who is in jail, it is India's hope that has been imprisoned," she maintained.

BHOPAL, March 29: Delhi chief minister Arvind Kejriwal was arrested by the ED as the Narendra Modi government wants to weaken the opposition, Madhya Pradesh Congress president Jitu Patwari said on Friday.

Speaking to PTI, he also exuded confidence the Congress will win at least 15 of the 29 Lok Sabha seats in MP, where polling will take place in four phases between April 19 and May 13.

"Kejriwal's arrest is an attempt to weaken the opposition and wipe out the democratic system in the country. While Kejriwal was arrested, they have spared others who joined hands with the BJP. Of the 154 persons against whom there were ED and CBI probes, 121 ioined the BJP and investigation stopped. But propaganda against opposition leaders (on such probes)

continues," he said. He said Prime Minister Narendra Modi has double standards when it comes to this issue (of probes against persons by ED and CBI) and every attempt was being made

to weaken the opposition. "They (government through IT department) have frozen the accounts of the Congress just ahead of polls. It means they want to cripple the opposition financially and arrest leaders to terrorise democracy," he said.

The BJP is forcing local level leaders from other parties to join by threatening no-confidence motion etc. Those who have business interests in sand mining, crushers, transport etc are being harassed so that they join the BJP," Patwari added. Asked if he wanted Congress general secretary Priyanka Gandhi Vadra to contest from Raebareli Lok Sabha seat, which is represented by Sonia Gandhi currently, Patwari said," It is not a question of what I wish. What the party wants is more important and moreover what Priyanka Gandhi wants. The party will take appropriate decisions in the interest of the organization." Patwari said he was confident the Congress would win 15 seats in MP based on the party's performance in the 2023 Assembly

"There were 12-15 seats where we won or were very close to winning. We are in a position to perform better," he asserted.

Asked about MP chief minister Mohan Yadav pointing out that the BJP has given tickets to six women for Lok Sabha polls while the figure for the Congress was just one, Patwari asserted 80 per cent of his party's candidates were below the age of 50 and the representation of SC/ST and OBCs was also very good. #### the financial aspects of these law-Storage capacity in main reservoirs drop to 36 pc, south states show significant shortfall: Data

NEW DELHI, March 29: The live storage capacity in India's 150 primary reservoirs has dropped to 36 per cent of their total capacity while the southern states like Karnataka face a significant shortfall in water storage compared to the previous year and the ten-year average, according to official data.

Cities like Bengaluru have been grappling with water shortage, which can be attributed to rain deficiency in Karnataka during last year's monsoon, a decline in reservoir level. and the loss of lakes due to rapid urbanisation.

The Central Water Commission, in its weekly bulletin, said the total live storage capacity of 150 reservoirs is 178.784 BCM (billion cubic metres) which is about 69.35 per cent of the live storage capacity of 257.812 BCM, which is estimated to have been created in the country.

As per reservoir storage bulletin released on Thursday, live storage available in these reservoirs is 64.606 BCM, which is 36 per cent of total live storage capacity of these reservoirs.

"However, last year the live storage available in these reservoirs for the corresponding period was 76.991 BCM and the average of last 10 years live storage was 66.644 BCM,"

Thus, the live storage available in 150 reservoirs as per the bulletin is 84 per cent of the live storage of the corresponding period of last year and 97 per cent of storage of the average of the last ten years.

Ahead of the summer season, a week-onweek decline has been noted in the reservoir



According to last week's bulletin, the live storage capacity was 38 per cent or 67.591

In the week of March 7-14, the live storage capacity was recorded at 40 per cent or 70.746 BCM and the week prior to that it was 41 per cent or 73.297 BCM.

In the northern region, comprising states like Himachal Pradesh, Punjab, and Rajasthan, the total live storage available in the

monitored reservoirs stands at 32 per cent of their total capacity.

This figure, at 6.290 BCM, is notably lower than the storage levels observed during the corresponding period last year and falls short of the ten-year average. The southern region, including states like

Tamil Nadu and Karnataka, faces a significant shortfall in water storage compared to both the previous year and the ten-year average. With storage levels at a mere 22 per cent of

total capacity in southern states, the situation underscores the pressing need for water conservation measures and sustainable management practices.

Contrastingly, the Eastern region, encom-

voirs is recorded at 47.49 per cent of their capacity, marking an improvement from the previous year and surpassing the ten-year average. The states like Gujarat and Maharashtra, falling under the Western region, are grappling with a decline in water storage compared to the previous year.

Despite this, the current storage levels, at 42 per cent of total capacity, exceed the tenyear average, offering a glimmer of hope amidst the challenges posed by fluctuating water availability.

Similarly, the Central region, comprising states such as Uttar Pradesh and Madhya Pradesh, witnessed a decrease in water storage compared to the previous year. However, the current storage levels, at 44

per cent of total capacity, surpass the ten-year

average, indicating a relatively stable situation despite the year-on-year decline. Several states, including Assam, Jharkhand, and Odisha, among others, have showcased improved water storage levels

compared to the previous year. However, states like Himachal Pradesh, Punjab, and Maharashtra, along with others, continue to grapple with diminished water storage. (PTI)

We continue to encourage peaceful resolution of the conflict through dialogue and diplomacy and remain open to engaging all ways this objective," the MEA spokesperson had said on a query on India's position on the peace conference in Switzerland.

The peace formula proposed by Ukrainian President Volodymyr Zelenskyy in 2022 follows 10 principles aimed at ensuring a just and lasting peace in Ukraine.

Prime Minister Narendra Modi on March 20 had held separate conversations with Russian President Vladimir Putin and Zelenskyy and asserted that dialogue and diplomacy were the way forward for the resolution of the Russia-Ukraine conflict.

Modi had spoken to Putin over telephone to congratulate him for winning a fifth term in office in the recent elections, and followed it up with a phone call to Zelenskyy to convey India's "consistent support" for all efforts for peace and bringing an early end to the ongoing conflict.

During the telephone conversation, the Ukrainian President had thanked India for its support for his country's sovereignty and said that it would be important for Kyiv to see New Delhi attend the inaugural Peace Summit in Switzerland.

**NEW DELHI, March 29:** Union minister Hardeep Singh Puri on Friday compared chief minister Arvind Kejriwal's wife Sunita to former Bihar chief minister Rabri Devi, and said she is perhaps preparing to hold the post of her husband.

"The madam you are naming is perhaps preparing to hold the post like Rabri Devi did in Bihar," the senior BJP leader told reporters here at the inauguration of the Delhi BJP's election office. The Union minister for Housing and Urban Affairs was responding to a question about Sunita Kejriwal who has been briefing media on behalf of her husband, since his arrest by the ED last week. Earlier in the day, Sunita Kejriwal launched a WhatsApp campaign, urging people to support her husband, who is in ED custody in an excise policy-linked money-laundering case. In a digital media briefing, she said her husband has challenged the "most corrupt and dictatorial forces" in the country and asked people to support him through their blessings and prayers.

The Delhi chief minister was arrested by the Enforcement Directorate (ED) on March 21 in the money-laundering case linked to the now-scrapped excise policy for Delhi. A court on Thursday extended his ED custody

When Puri was asked how serious challenge the AAP-Congress alliance in Delhi was for the BJP, he said, "Which alliance? What are you talking about? # Marginalised communities reaching top govt positions due to 'affirmative action': Justice B R Gavai

**NEW DELHI, March 29:** Members of marginalised communities have been able to reach top government positions due to "affirmative action" of the constitution. Supreme Court Judge Bhushan Ramkrishna Gavai has said while citing that his elevation to the apex court was advanced by two years as there was no judge from the Dalit community.

Speaking at a cross-cultural discussion hosted by the New York City Bar Association, Justice Gavai shared that when he was appointed as a judge in the Bombay High Court in 2003, he was a leading lawyer, and that there was no judge from Dalit/Scheduled Caste

community in the High Court. The SC judge said his appointment to the Supreme Court of India in 2019 was made solely on the account of giving representation to the Scheduled Castes in the Supreme Court, as there was no judge in the apex court who came from the SC community for almost

He added that it is only because of the Indian Constitution and its mandate of affirmative action and inclusion, that he would be able to serve in the highest judicial office.

"If not for giving representation to Scheduled Castes, I would have been elevated maybe two years later," said Justice Gavai, who is in line to become the Chief Justice of India in May 2025.

# ground, Justice Gavai shared his Notify guidelines by July 15 to make films accessible to hearing, visually impaired: HC to Centre

NEW DELHI, March 29: The Delhi High Court has asked the Centre to notify by July 15 the guidelines to make films accessible to persons who are hearing and visually impaired. Justice Prathiba M Singh said ac-

cessibility was enforceable as a legal right and even private parties have to take "reasonable accommodation measures" to enable greater accessibility for the hearing and visually impaired persons. The court observed that the Ministry of Information and Broadcasting

has framed the "Draft Guidelines of Accessibility Standards in the Public Exhibition of Feature Films in Cinema Theatres for Persons with Hearing and Visual Impairment", and was in the process of finalising the same. 'The guidelines shall now be finalised by the MIB and shall be notified on or before 15th July, 2024. It is

made clear that the said guidelines

shall make the provision of accessibility features mandatory and provide a reasonable period for compliance by all stakeholders, in an expeditious manner," the court ordered recently. "A hearing or visually impaired person, may get easy physical access

to a film theatre but may not be able

to enjoy the film at all, if measures to make it enjoyable are not taken by the other stakeholders, including producers, theatre managers, OTT platforms, etc," the order said.

The court stated that non-provision of accessibility features would constitute an offence under the Rights of Persons with Disabilities Act and the State has a positive obligation to ensure that all reasonably possible steps are taken to ensure access to them. The central government said it "fully intended" to notify the guidelines as soon as possible and its counsel prayed for time up until August 1 to notify as the responses of all the stakeholders had to be considered in

It informed that the guidelines would be applicable for those feature films that are certified by the Central

Board of Film Certification for public exhibition in

inate one Under Secretary as the designated officer for receipt of any representations on inclusion of accessibility features in films

The court's order came on a petition by four persons suffering from visual and hearing impairments who sought directions to make Shah Rukh Khan-starrer "Pathaan", accessible to

The four petitioners -- a law student, two lawyers and a disability rights activist -- have contended that under the Rights of Persons with Disabilities Act (PWD Act), the government has to take measures to ensure access to content to those suffering from disabilities. While three of them are visually impaired, the fourth one is hearing impaired.

The petitioners were represented by lawyer Rahul Bajaj. (PTI)



"3 Body Problem" begins with a young scientist's decision to contact an alien civilisation during 1960s China, a moment that echoes across space and time. And many years later, a group of scientists come together to tackle humanity's greatest threat.

In the series, Wong essays the role of Da Shi, the London-based detective investigating the mysterious deaths of top scientists all over the world.

One of the highlights of the show is the camaraderie between Wong and costar Liam Cunningham's characters. Cunningham plays the role of Da Shi's boss Thomas Wade, who is also the enigmatic leader of an elite intelligence agency in charge of the planetary defence. In a series that explores darker themes such as existential threats and moral and ethical dilemmas, the two often bring a much needed respite with some of the light-hearted moments in the story.

Wong said he has been a "massive fan" of Cunningham, who has also featured in films such as "Clash of the Titans" and "War Horse".

"I've been a massive fan of this guy. He was my tennis partner, dance partner and ice skating partner. It's a real pleasure once that sort of environment is there. It allows even more to play. I think that's what we did with our scenes," he added. (PTI)



# WFI decides to function at 'no cost to govt' model if suspension not lifted

Wrestling Federation of India (WFI) on Friday decided at its Special General Meeting (SGM) that it will start functioning at 'no cost to the government' model if its request to lift the suspension is not considered by the Sports Ministry.

The WFI had its SGM in Noida after the UWW (the sport's world governing body) lifted its suspension and the IOA also dissolved the ad-hoc panel that was managing the affairs of the body.

The two developments paved the way for the elected office bearers to take back control of the federation, though the government is yet to lift its suspen-

The government had contended that the WFI flouted rules and put it under suspension, three days after it conducted polls to elect Sanjay Singh as president.

All 25 state associations attended the SGM even as secretary general Prem Chand Lochab, who is from the rival camp, skipped the meet.

"It was agreed that we will request the government to lift the suspension. The UWW has lifted the suspension and ad-hoc committee has also been dissolved, so there is no point of continuing with the suspension of the body," a WFI source told

"If the ministry will not consider the request and decide against providing financial assistance, then we have decided unanimously that we will start functioning at no cost to the government," added the source.

If the WFI goes ahead with the plan then it will also have to arrange and conduct the national camps on its own.

Only if a candidate is attempting to get elected to the post he is holding, he will be required to win by a two-third majority," explained

ent them as genuine bodies despite suspension from WFI. They showed SOC recognition to claim that they are genuine affiliated state bodies. We have done away with this," informed the source

All the 25 state bodies were asked to ensure that the Sports Code is followed while conducting the elections and functioning. Age and tenure guidelines will have to be followed by all.

"I want to help the team and I want to help the young players to develop. And if I am part of the process, I'm happy with that. So putting all the things together, this important decision, hopefully, I'm convinced is the right one. I'm happy. I'm still young, so time will tell, but right now I feel like that." Alonso said he reflected on his future during the recent international break before informing Leverkusen. Leverkusen is on course for its first German title, 10 points clear in the Bundesliga

erkusen, which was in the relegation zone when Alonso took charge in October 2022, is still unbeaten in all competitions this season. That record has made Alonso one of the most sought-after coaches in world soccer. He has two more seasons left on his contract at Leverkusen. It's the first head coach job of Alonso's career and he emphasized he believes he's still learning as he goes.

The former Spain midfielder was a player for both Bayern and

Liverpool. Both clubs are seeking new coaches for next season. Bayern is parting company with Thomas Tuchel, in part because it lags so far behind Alonso's Leverkusen, while Jürgen Klopp is stepping down as Liverpool manager after nine years.

Alonso didn't say how much contact, if any, he had with Bayern or Liverpool.

"I think that it wouldn't be correct for me to talk about other clubs when they are in this situa-

tion, for sure. They are clubs that I have a strong link (with), I play there, so I respect them, but it's not correct for me to talk about them right now," he said. "It's more about the conviction that I have that I am in the right place in Bayer Leverkusen and that I want to keep growing with the club, growing with the players, learning from them." Alonso added that he wants to help build Leverkusen into a Champions League contender, with its return to Europe's top competition all but certain for

In Liverpool, Klopp said he understood Alonso's decision, having been in a similar situation. The German had extended his stay at Borussia Dortmund in 2013 despite interest from other clubs.

"I had a similar situation and did pretty much the same, and ever regretted it," Klopp said at a news conference ahead of Liverpool's Premier League match against Brighton on Sunday. "The club is doing an incredible job there. Leverkusen has a good team, probably will keep the team together. It's not in all years like that. So I understand that he wants

MILAN, ITALY, March 29: Tonali has been charged with breaching English soccer's betting rules, the Football Association said on Thursday.

Tonali is already serving a 10month ban issued by the Italian soccer federation for betting on teams he played for, which has ruled him out of action since October.

He could be in more trouble after the FA said he breached its rules on 50 occasions by allegedly placing bets on matches from Aug. 12 to Oct. 12 last

On Oct. 12, Tonali was sent home from Italy's training camp after being notified by police of his involvement in a betting investigation.

The 23-year-old Tonali joined Newcastle from AC Milan last July for a fee reportedly worth up to 60 million pounds (\$76.3 million). But he made only 12 appearances for the Premier League club after being caught up in a wider betting investigation that saw Juventus midfielder Nicolò Fagioli banned for seven months.

Tonali told prosecutors he bet on Milan and Brescia when he played for those clubs. His agent, Giuseppe Riso, acknowledged his client had a gambling problem. Tonali agreed to a plea bargain with the Italian federation that included therapy for a gambling addiction. His ban ends on July 14.

Newcastle said last year it would give Tonali and his family its full support. Tonali is the latest Premier League player to be charged with breaching betting rules. Brentford and England striker Ivan Toney was banned for eight months last year and fined 50,000 pounds

An independent commission said Toney's punishment could have been more severe had he not been diagnosed with a gambling addiction.

NEW DELHI, March 29: Australian star batter Steve Smith has advised Hardik Pandya to simply "block out" the constant jeers and boos the new Mumbai Indians skipper is receiving from spectators at the IPL so far, as they are "all irrelevant".

Hardik, who replaced five-time IPL-winning captain Rohit Sharma as skipper this season, had a dismal start to his captaincy tenure as MI suffered back-toback defeats.

On top of the two losses, the former Gujarat Titans skipper was booed by fans at Ahmedabad and Hyderabad -- the venue of MI's first two matches -- as they were clearly not happy with the way Rohit was removed from

captaincy. "I'd try and just say, to block it out, it's all irrelevant," Smith, who has faced abuse from fans across the world for his role in the 2018 ball-tampering scandal in Cape Town, told ESPN-

cricinfo. "No one outside knows what you are going through. No one (from outside) is in that change room.'

Smith, who was called "cheat' by fans during the 2019 ODI World Cup in England, feels all these abuse will come as a big surprise for Hardik as he is getting it from his Indian fans at

"Personally, for me, it doesn't bother me. I don't care. I don't pay any attention," said Smith, who had to resign as Rajasthan Royals captain in 2018 after the ball-tampering scandal.

"You know it's all white noise, but certainly players do hear things and everyone's entitled to their own emotions and how they respond to those. So is it affecting him (Hardik)? Maybe. It's possible. He probably hasn't experienced that before in, in any walk of life. So it's natural, I suppose, and particularly being in India and a star Indian player, to be in that position where some fans are booing you, it's certainly something he wouldn't have ex-

# **Bopanna-Ebden sail** into men's doubles final of Miami Open



MIAMI, March 29: Indian tennis stalwart Rohan Bopanna and his Australian partner Matthew Ebden sailed into the men's doubles final of the Miami Open with a straight-set win over Marcel Granollers and Horacio Zeballos here.

Bopanna and Ebden, the Australian Open winners, hardly broke a sweat to get the better of Spain's Granollers and Argentina's Zeballos 6-1 6-4 in the semifinals on Thursday night.

Bopanna had slipped to second spot in the doubles rankings after a quarterfinal loss at the Dubai Championships and a round-of-32 exit at the Indian Wells Masters, but the semifinal win here will help the Indian regain the top spot when they are updated on Monday.

Following the Australian Open triumph, the 44-year-old

Bopanna had climbed to the world No.1 spot in the ATP rankings, becoming the oldest player to do so.

In the final, Bopanna and Ebden will take on Ivan Dodig of Croatia and American Austin Krajicek, who beat the German duo of Kevin Krawietz and Tim Putz 6-4 6-7(7) 10-7 in the other semifinal.

For Bopanna, this will be his 14th ATP Masters 1000 final and the first in Miami. Overall. this will be his 63rd ATP Tour level final. He has so far won 25 doubles titles. This will also be the fifth appearance in an ATP Masters 1000 final for the Bopanna and Ebden pairing.

Bopanna also achieved a rare feat as he became the second Indian after Leander Paes to reach the final of all 9 ATP Masters events. (PTI)

#### Andy Murray to miss **Monte Carlo and Munich** tournaments because of ankle injury

LONDON, March 29: Andy Murray still has no timetable to return from an ankle injury as the three-time Grand Slam champion's management team confirmed on Friday that he'll miss upcoming clay-court tournaments in Monte Carlo and Munich.

The 36-year-old Murray tore ligaments in his left ankle on Sunday during a match at the Miami Open and announced the next day that he'd be sidelined "for an extended period.'

"At this stage, it is still not clear how long Andy will be out of action, and he is continuing to review options with his medical team," Friday's statement from his management team read.

"Obviously this is very disappointing news for Andy and he has reiterated his desire to get back or court as soon as possible."

The former world No. 1 rolled his ankle on an approach to the net late in the third set against Tomas Machac. Murray finished the match, losing 5-7, 7-5, 7-6 (5).

The Monte Carlo Masters begins April 7, and the BMW Open in Munich is the following week.

Murray, who has said he's unlikely to play past this summer, has been holding out hope of competing for Britain again in the Paris Olympics. (AP)

# Advani, Causier storm into last 16



PARIS, March 29: France says it has asked 46 countries if they would be willing to supply more than 2,000 police officers to help secure the Paris Olympics this summer, as organizers finalize security planning for the French capital's first Games in a century while on heightened alert against potential attacks.

The Interior Ministry said Friday that the request for foreign security assistance was made in January, seeking nearly 2,185 reinforcements. The officers are sought to help with Games security and "the spectator experience" and to "strengthen international cooperation," the ministry said.

"This is a classic approach of host countries for the organization of major international events," the ministry added.

It noted that France sent 200 of its gendarmes to soccer's World

Cup in Qatar in 2022 and also wel-

comed 160 officers from other European security forces for the Rugby World Cup that France hosted last year.

Separately, the French Defense Ministry has also asked foreign nations for "small numbers" of military personnel who could help with 'very specific" tasks at the Games, including sniffer dog teams, said Col. Pierre Gaudillière, spokesman for the army general staff. Poland's defense minister said

his country will be sending soldiers to the Paris Games. The Polish armed forces delegation will include dog handlers and "its main goal will be to undertake activities related to the detection of explosives and counteracting terrorist phenomena." the minister, Wladyslaw Kosiniak-Kamysz, posted

Security is the biggest challenge for Paris Games organizers in a city that has been repeatedly hit by deadly attacks by Islamic extremists and which is expecting as many as 15 million visitors for the July 26-Aug. 11 Games and Paralympics that follow. Security concerns are notably

high for the opening ceremony, which will involve boats along the Seine River and huge crowds watching from the embankments. France's government increased

its security alert posture to the highest level in the wake of the recent deadly attack at a Russian concert hall and the Islamic State's claim of responsibility.

French Prime Minister Gabriel Attal announced the decision in a post on X, saying authorities were "taking into account the Islamic State's claim of responsibility for the (Moscow) attack and the threats weighing on our country.? (AP)
