Sabha polls, the Election Commission on Friday asked parties and their leaders to refrain from seeking votes on the basis of caste, religion and language, and not insult the devotee-deity relation or make any suggestion of a divine censure.

Temples, mosques, churches, gurdwaras or any other place of worship should not be used for poll propaganda or electioneering, the commission said in its advisory to parties, warning their candidates and star campaigners they will face stern

NEW DELHI, March 1: India is grappling with a profound nutritional shift, as highlighted by the latest Lancet study, with nutritionists attributing this "double whammy" of undernutrition and obesity to a dual challenge: inadequate consumption of quality foods and easy access to cheap, unhealthy alternatives. The Lancet study, published on

Thursday, found that in India, nearly 44 million women and 26 million men were obese in 2022, respectively

The analysis by the NCD Risk Factor Collaboration (NCD-RisC) a global network of scientists - and the World Health Organization (WHO) also found that about 12.5 million children aged between five and 19 were overweight in 2022. "These numbers are up from 2.4

million and 1.1 million in 1990 for women and men, respectively, while for children, the baseline number was about 0.4 million," said study co-author Guha Pradeepa, from Madras Diabetes Research Foundation

(MDRF), Chennai, told PTL Reacting to the study findings, nutritionist Sudha Vasudevan, who was not involved in the study, noted that while good quality foods are nutrient-dense like fruits and vegetables, unhealthy foods are usually processed, containing high-fat, sugar, salt, and refined carbohydrates. "We had not yet won the war against undernutrition-related health problems, but now we are additionally burdened by those coming from overnutrition or obesity, and resembling the developed nations in that sense," Vasudevan, Senior Scientist and Head of the Department of Foods & Nutrition Research, MDRF, told PTI.

The findings suggest trends of an "epidemiological and nutrition transition" of India, Vasudevan said.

"While the developed countries might be economically equipped to deal with obesity and related healthcare burden, India is not and therefore, we are struggling," she said. The Lancet (CONTD. ON PAGE-2)

Sensex, Nifty hit record high levels on impressive GDP data, foreign fund inflows

MUMBAT, March 1: Benchmark equity indices Sensex and Nifty rallied more than one-and-a-half per cent to hit their lifetime highs on Friday helped by impressive GDP data and fresh foreign fund inflows.

The 30-share BSE Sensex jumped 1,245.05 points or 1.72 per cent to reach 73,745.35 -- its alltime closing peak. During the day, it zoomed 1,318.91 points or 1.81 per cent to hit a record intra-day high of 73,819.21.

The Nifty climbed 355.95 points or 1.62 per cent to settle at a new closing high of 22,338.75. During the day, it soared 370.5 points or 1.68 per cent to reach its intra-day record peak of 22,353.30.

A rally in global markets and auto sales numbers added to the positive momentum in the equity markets, analysts said.

Among the Sensex firms, Tata Steel jumped over 6 per cent while JSW Steel climbed more than 4 per cent. Larsen & Toubro, Titan, Maruti, IndusInd Bank, ICICI Bank and Tata Motors were the other major gainers.

HCL Technologies, Infosys and Tech Mahindra were the laggards. India's economy grew by betterthan-expected 8.4 per cent in the final three months of 2023 -- the

fastest pace in one-and-a-half years. The growth rate in October-December was higher than 7.6 per

cent in the previous three years, and it helped take the estimate for



the current fiscal (April 2023 to March 2024) to 7.6 per cent, according to the data released by the National Statistical Office (NSO) on Thursday.

India's manufacturing sector growth climbed to a five-month high in February amid a sharper uptick in factory production and sales, supported by both domestic and external demand, a monthly survey said on Friday.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index (PMI) rose from 56.5 in January to 56.9 in February, pointing to the strongest improvement in the health of the sector since September 2023. "Better-than-expected Q3 FY24

scheme to 27 lakh women, new roads and 16 lakh new houses under PMAY are among the work done by his government since coming to power in May 2021, Sarma added. Earlier in the day, Sarma inaugurated a cancer care unit at Silchar Medical College and Hospital (SMCH) and claimed that the state's cancer care model is being emulated across the country. "We have inaugurated the cancer care unit here today, which is part of the network of 17 hospitals in the state under a joint initiative of the state government and Tata Trusts," he said.

Three categories of cancer care units are being set up in government-run hospitals under the project, of which the one at SMCH is in category 2, which will provide patients with comprehensive care, Sarma said. "The lone category-1 facility, which will be the apex cancer care hospital, is being opened at Guwahati," the chief minister said. The state government's share in the project is ₹ 2,460 crore, while Tata Trusts will provide ₹ 1,180 crore, the government of India ₹ 180 crore and over ₹ 80 crore has been raised through donations. An Assam Cancer Care Foundation has been formed to manage the units, which will be responsible for operating these and if any revenue deficit is there at the end of the year, the state government will fill the gap, the CM said.

Ten such cancer care centres are already operational and over 2.15 lakh patients have received treatment in these, he added. "The entire country is trying to emulate Assam. We are thinking of upgrading this project so that Assam becomes a nodal state when it comes to cancer care," Sarma said. He also affirmed the state government's commitment to the development of the Barak Valley.

"A section of people in Barak Valley indulge in propaganda that the state government does not care about this part. But when you look at projects like this, it shows that not only does the government care, but we also actively support Barak Valley," Sarma said.

Later in the day, the chief minister attended a function at Lakhipur where he opened and laid the foundation for several projects.

Speaking on the occasion, he elaborated the government's various developmental initiatives and assured of sustained progress of Barak Valley. (PTI)

"The aero-engines will be manufactured under transfer of technology license from the Russian original equipment maker. The programme will focus on indigenisation of several high value critical components, which would help increase the indigenous content of future repair and overhaul tasks of RD-33 aero-engines," it said.

The ministry also signed a deal with Larsen and Toubro Ltd for procurement of a batch of close-in weapon system (CIWS).

"The contract for procurement of CIWS has been signed with Larsen & Toubro Limited at a cost of ₹7,668.82 ore," the ministry said, "The CIWS will provide terminal air defence to select locations of the country. The project will boost and encourage active participation of Indian aerospace, defence and associated industries including MSMEs," it said.

Markets record rally makes investors richer by Rs 4.29 lakh cr

NEW DELHI, March 1: Investors became richer by ₹ 4.29 lakh crore on Friday as markets fired on all cylinders with the BSE Sensex rising sharply by 1,245 points or nearly 2 per cent.

The 30-share BSE benchmark jumped 1,245.05 points or 1.72 per cent to settle at a new closing high of 73,745.35. During the day, the benchmark zoomed 1,318.91 points or 1.81 per cent to reach an all-time high of 73,819.21.

The market capitalisation of BSE-listed companies soared by ₹ 4,29,339.75 crore to 3,92,25,029.98 crore (USD 4.78 trillion).

"The strong resilience in India's Q3 GDP growth numbers propelled Sensex & Nifty to fresh record highs amid a rally in index heavyweights such as Reliance Industries, Tata Steel and banking stocks," Prashanth Tapse, Senior VP (Research) at Mehta Equities NEW DELHI, March 1: Finance Minister Nirmala Sitharaman on Friday said Direct Benefit Transfer of ₹ 34 lakh crore has been facilitated by the Public Financial Management System (PFMS) and asked accounts officers to further enhance efficiency and transparency of the system.

WTOs 5th day meet: Talks on to break impasse over agri, fisheries issues

ABU DHABI, March 1: The UAE time on Friday, 1 March," meeting of the highest decisionmaking body of the WTO on Friday entered the fifth day with key members including India, the US, and the EU holding talks to iron out differences on issues such as agriculture, fisheries subsidies, and duty moratorium on e-commerce trade. The 13th Ministerial Conference (MC), which was to end on February 29, extended for a day as developing and developed nations were unable to find common ground on these key issues.

The members are talking to end the impasse and so far things have not moved much, an official said.

"There are nine countries in the green room meeting including Brazil and China. The negotiations have been extended as WTO chief Ngozi Okonjo-Iweala is pushing for outcomes," the official said.

WTO spokesman Ismaila Dieng said that the ministers continue to be engaged in intensive and difficult discussions on a package of agreements for adoption at MC13.

"As a result, in order to give more time for negotiations, the Formal Closing Session of MC13 has now been postponed to 5 pm

Dieng said.

India has clearly stated that finding a permanent solution to the public stockholding of grains for food security purposes should be the top priority before taking up any new issues in the agriculture sector. There are major differences among rich nations also on issues related to market access for agri commodities. There are seven agri matters which include export restrictions. An official said talks are going on among the member nations on all the issues and India is clearly stating that it will not compromise the interests of farmers

and fishermen New Delhi is pressing for a permanent solution to the issue of public stockholding of grains for food security programmes and has asked developed countries engaged in distant water fishing to stop providing any kind of subsidies for 25 years.

India is also pressing for an end to the moratorium on imposing customs duties on e-commerce trade. India and South Africa have blocked a proposal led by China on investment facilitation stating that

the agenda is out of the WTO mandate. India has also asked for the restoration of the appellate body of the WTO's dispute settlement system. The US has been blocking the appointments of judges in the body since 2019, due to which the sys-

tem is not working smoothly. New Delhi is pitching for finding a permanent solution to the issue of Public Stockholding (PSH) for its food security programmes PSH programme is a policy tool

under which the government procures crops like rice and wheat from farmers at a Minimum Sup-

port Price (MSP) and stores and distributes foodgrains to the poor. As part of a permanent solution, India has asked for measures like amendments in the formula to calculate the food subsidy cap. Further, the talks on non-trade issues such as trade inclusiveness, women's participation in trade, industrial policy, and environment, in the draft Abu Dhabi package also remained unresolved so far. However, the ministerial has managed to get at least five outcomes such as new disciplines on domestic regulation for services,

formal joining of Comoros and Timor-Leste as members of the WTO, and least developing countries continuing to get the benefits of LDC even three years after graduation

Besides, India is also pushing for the adoption of open and interoperable payment systems with a view to cut the cost of money transfers or remittances as the dominance of a few large players in the market contributes to these high costs through complex and opaque fee structures.

According to an expert, the challenge of high remittance costs, averaging 6.18 per cent globally, are well above the United Nation's target of 3 per cent. MC is the highest decision-making body of the 166member Geneva-based multilateral body. As many as 22 more nations have shown interest to join the organisation. At the meeting of the Heads of Delegation on 28 February, DG Okonjo-Iweala has called on members to go the extra mile to find convergence on various negotiations at the ministerial gathering and to be mindful that time is running out to conclude meaningful agreements. (PTI)

The contract for procurement of high-power radar systems has also been signed with Larsen and Toubro Limited at a cost of ₹ 5,700 crore. It will replace existing long-range radars of IAF with modern active aperture phased array based HPR with advanced surveillance features. "It will significantly enhance the terrestrial air defence capabilities of IAF with integration of sophisticated sensors capable of detection of small radar cross section targets,' the ministry said.

"It will boost to indigenous radar manufacturing technology as it would be first of its kind radar built by the private sector in India," the ministry said. The signing of the two contracts for procurement of the Brahmos missiles came days after the acquisition was cleared by the Cabinet Committee on Security (CCS). The CCS accorded approval for procurement of over 200 BrahMos supersonic cruise missiles and associated equipment.

It is learnt that it will be a mix of BrahMos missiles having a range of around 290 km and the latest extended range variant of the weapon with a range of around 450 km. BrahMos Aerospace Pvt Ltd, an India-Russian joint venture, produces the supersonic cruise missiles that can be launched from submarines, ships, aircraft, or land platforms. BrahMos missile flies at a speed of 2.8 Mach or almost three times the speed of sound. (PTI)

From undernutrition to obesity

study looked at body mass index (BMI) to understand how obesity and underweight have changed worldwide from 1990 to 2022. It analysed the weights and heights of over 220 million people aged five years or older, from across more than 190 countries. The findings also highlighted a major shift in lifestyle over the past decades, including lack of exercise and healthy food, said Pradeepa.

The study found that the adult obesity rate in India increased from 1.2 per cent in 1990 to 9.8 per cent in 2022 for women, while for men, it rose from 0.5 per cent to 5.4 per cent. Pradeepa attributed the spike in obesity rate to a combination of biological and social factors. "Biological factors involve constant, cyclical hormonal activity with pregnancy-specific weight gain, following which taking care of the child takes precedence.

"On the other hand, social factors compel them to prioritise their children's and family's health over their own. These factors present as barriers to doing exercise for women and taking care of themselves," she explained. The findings revealed the need for innovative interventions in terms of introducing more physical activity and movement in a day, especially for women, said Pradeepa. She referred to Thandav, which is one such intervention, developed by Dr. R. M. Anjana, President of MDRF.

Thandav is a ten-minute routine that combines the physical exercise aspect of high-intensity interval training (HIIT) with enjoyable dance movements. The routine thus makes the act of performing physical exercise more entertaining and recreational, and also more socially acceptable as girls and women can perform this easily at their homes, explained Pradeepa. Anjana along with colleagues at MDRF, have scientifically investigated the impact of Thandav on the physical fitness of Indian girls and women and published papers in journals such as Diabetes Technology and Therapeutics. (PTI)



ormer Supreme Court Judge Kurian Joseph has ignited a contentious discussion within legal and intellectual circles by calling for the Chief Justice of India (CJI) to reconsider the Supreme Court's motto "Yato Dharmastato Jaya" (Where there is Dharma, there is Victory). Brazilian President LuizInacio Lula da Silva, while speaking to reporters in Addis Ababa, where he was attending an African Union summit, has accused Israel of committing "genocide" against Palestinian civilians in the Gaza Strip and compared its actions to Adolf Hitler's campaign to exterminate Jews. "It's not a war of soldiers against soldiers. It's a war between a highly prepared Army and women and children," he remarked. This is a repeat of what Hitler did to the Jews during the 2nd world war, he said. He had previously condemned Hamas's October 7 attack on Israel as a "terrorist" act. So he is not being partisan in his utterance. His views are confirmed by the latest rhetoric by the Israeli officials who are justifying the killings of children in Gaza.

Similar statement has been given by Republican Representative Andy Ogles of Tennessee in the US, who responded to an activist's question about the deaths of Palestinian children in Gaza by asserting that "we should kill 'them all". Double standards of the US administration are obvious. Whereas they talk of humanitarian ceasefire and advise Israel to be cautious in bombing, they are supplying billions of US\$ worth arms to them. The US has vetoed Algerian resolution in the Security Council for ceasefire in Gaza. All these are a pointer to serious situation likely to develop in the Middle East which can have global ramifications.

After four months of unprecedented aggression on Gaza the Israel has not been able to find the Hamas or the hostages. Starting from North of Gaza to the center, South, tunnels, the hospitals, schools, every building they have destroyed and evacuated. Now they are saying that the Hamas is hiding in Rafah. Palestinians are being pushed to the sea as they have nowhere to go. These happenings are reminiscent of the barbaric era of colonialism and apartheid.

It is now crystal clear that the sole aim of Israel is to eliminate the Palestinians and establish a Zionist regime in that region with the explicit support of the US administration. Israel's demand for stoppage of aid to the United Nations Relief and Work Agency (UNRWA) for Palestinian refugees and its accusations that some of its employees were involved in the October 7 attack is totally unjustified as there is no evidence in it. A majority of at least 15 out of 17 judges voted in favour of imposing the socalled provisional measures, including the court's president, Joan Donoghue of the United States. Israel however has not made public the action taken in this regard till date

The UN Secretary General has expressed anguish over Israel's decision to attack Rafah and condemned collective punishment of Palestinians. But despite his several efforts the UN has failed to contain Israel The multilateral institutions are not properly equipped to deal with the current challenges, as has been demonstrated by the Security Council's inability to act on the on-going conflicts. Will the G20 group whose chair is now with Brazil be able to take a position?

There have been many peace keeping forces around the world the under the UNO, but this is missing now. India as a big country could have played tangible role in bringing peace in the region. India's non participation in the presentations at the ICJ has raised several questions. Indian government has been the harbinger of peace and disarmament as a leader of the Non aligned Movement (NAM) and always stood with Palestinian cause. The Delhi Declaration of the Seventh NAM summit from 7th to 11th March, 1983, carried the conclusions and recommendations for total unconditional withdrawal of Israel from all Palestinian and other occupied territories including Jeru1alem: A War crimes tribunal to try Israel for committing crimes against the Palestinian people.

Alas India changed its position on the relationship with Israel and has developed strong defence relations with them and has now supplied Israel with drones made by the Adani group to carry out operations. On the other hand, the regime has asked students to join the University Training Corps (UTC), which acts as a reserve for the military's depleted ranks.

Junta newspapers boast that many generals, including regime boss Hlaing, were former UTC members.

Under the Conscription Law, students can defer service, but the regime wants students to join the UTC to recruit them as reserves in the meantime.

The first UTC was formed in 1922 at Rangoon University under colonial rule. It was modelled on the British Army's University Officers Training Corps, which aims to recruit educated officers and expose civilians who will become future employers to aspects of military life.

There are three days of training a week during the academic year with a camp every October. Junta newspaper The Global New Light of Myanmar said the UTCs are commanded by the Directorate of Militias and Border Guard Forces, providing students with four years of training

University staff and UTC students were quoted by junta newspapers saying the organization teaches basic skills and explains what the military does to protect the country. In the wake of the 2021 coup, the regime revived a colonial-era law that allows authorities to conduct warrantless searches of private homes and requires all residents to register overnight houseguests. Previously, such searches were mainly conducted at night. But junta troops are also searching households in Mandalay during the day.

Myanmar's military is aiming to recruit 5,000 able-bodied fighters every month from April under a conscription order, Myanmar watch groups say, revealing its weakness.

Meanwhile, junta soldiers are extorting money from people whom they detain under the pretext of overnight guest registration. The detainees are released after payment is made. However, pro-junta Telegram channels claim that the young men detained are members of the anti-junta People's Defence Force and that they possess weapons.

Fighters from the People's Defence Forces (PDFs) have a message for compatriots who have not yet directly supported their resistance against the junta but are now at risk of being pulled into the violent chaos that has engulfed the country since the 2021 coup.

This comes as a coalition of ethnic armed groups and pro-democracy rebels across the country has inflicted heavy losses on government forces, in a counteroffensive that poses an unprecedented – and possibly existential – threat to the Tatmadaw, as Myanmar's vicious military is known, reports the South China Morning Post. Reports from Yangon (formerly Rangoon) show queues of hundreds at the Thailand embassy as people seek a legal way out, while hundreds of mainly young men have been detained after sneaking over the border into Thailand to escape the draft – a warning of the potential for a larger exodus ahead.

Thailand, a country that does not have an asylum system for the protection of refugees, is under pressure to consider formalising entry ahead of the expected influx, writes SCMP. Earlier in January, China brokered the Myanmar ceasefire, urging the junta and rebel militia to 'exercise maximum restraint'. 'The two sides agreed to an immediate ceasefire,' the Chinese foreign ministry claimed, while pledging a continued 'constructive role' from Beijing.

The junta and rebel Three Brotherhood Alliance held two days of talks in the Chinese city of Kunming, the ministry spokeswoman reveals.

In another story on Al Jazeera, Myanmar's military regime has admitted it is facing "heavy assaults" by anti-coup forces who began a coordinated offensive at the end of last month, claiming to have taken control of several towns in border areas and dozens of military outposts.

Spokesperson Zaw Min Tun told Al Jazeera that troops were under "heavy assaults from a significant number of armed rebel soldiers" in Shan State in the north, Kayah State in the east, and Rakhine State in the west.

Anti-coup fighters are using "hundreds" of drones to drop bombs on military posts, and some sites have had to be evacuated, he added.

Myanmar was plunged into crisis when the generals seized power from the elected government of civilian leader Aung San Suu Kyi in a coup in February 2021. DUBAI, March 1: Ir began voting on Friday in its first parliamentary elections since the mass 2022 protests over its mandatory hijab laws after the death of Mahsa Amini, with questions looming over just how many people will turn out for the poll. Navalny's family is laying the opposition leader to rest after his death in prison MOSCOW, March 1: Relatives and supporters of Alexei Navalny are bidding farewell to the opposition leader at a funeral on Friday in south

eastern Moscow, following a battle with authorities over the release of his body after his still-unexplained death in an Arctic penal colony. His supporters say several churches in Moscow refused to hold the service before Navalny's team got permission from one in the capital's Maryino district, where he once lived before his 2020 poisoning, treatment in Germany and subsequent arrest on his return to Russia.

The Church of the Icon of the Mother of God Soothe My Sorrows, which agreed to hold the service, did not mention it on its social media page. Authorities lined the road from from a nearby subway station to the church with crowdcontrol barriers, and riot police deployed in big numbers early on Friday.

Burial was to follow in the nearby Borisovskoye Cemetery, where police also showed up in force. Navalny's mother, Lyudmila Navalnaya, spent eight days trying to get authorities to release the body following his Feb. 16 death at Penal Colony No. 3 in the town of Kharp, in the Yamalo-Nenets region about 1,900 kilometers (1,200 miles) northeast of Moscow.

Authorities originally said they couldn't turn over the body because they needed to conduct post-mortem tests. Navalnaya, 69, made a video appeal to President Vladimir Putin to release the body so she could bury her son with dignity.

Once it was released, at least one funeral director said he had been "forbidden" to work with Navalny's supporters, the spokeswoman for Navalny's team, Kira Yarmysh, said on social media. They also were unable to find a hearse for the funeral

"Unknown people are calling up people and threatening them not to take Alexei's body anywhere," Yarmysh said Thursday,

Russian authorities still haven't announced the cause of death for Navalny, 47, who crusaded against official corruption and organized big protests as Putin's fiercest political foe. Many Western leaders blamed the death on the Russian leader, which the Kremlin angrily rejected.

It was not immediately clear who among Navalny's family or allies would attend the funeral, with many of his associates in exile abroad due to fear of prosecution in Russia. Navalny's Foundation for Fighting Corruption and his regional offices were designated as "extremist organizations" by the Russian government in 2021.



The politician's team said the funeral would be streamed live on Navalny's YouTube channel His widow, Yulia Navalnaya, accused Putin and Moscow Mayor Sergei Sobyanin of trying to block a public funeral.

"We don't want any special treatment — just to give people the opportunity to say farewell to Alexei in a normal way," Yulia Navalnaya wrote on X. In a speech to European lawmakern Wednesday in Strasbourg, France, she also expressed fears that police might interfere with the gathering or would "arrest those who have come say goodbye to my husband."

Moscow authorities refused permission for a separate memorial event for Navalny and slain opposition leader Boris Nemtsoy on Friday, citing COVID-19 restrictions, politician Yekaterina Duntsova said Thursday. Nemtsov, a 55-year-old former deputy prime minister, was shot to death as he walked on a bridge adjacent to the Kremlin on the night of Feb. 27, 2015.

Yarmysh also urged Navalny's supporters around the world to lay flowers in his honor Fri-

"Everyone who knew Alexei says what a cheerful, courageous and honest person he was,' Yarmysh said Thursday. "But the greater truth is that even if you never met Alexei, you knew what he was like, too. You shared his investigations, you went to rallies with him, you read his posts from prison. His example showed many people what to do when even when things were scary and difficult."

Ivan Zhdanov, director of Navalny's Anti-Corruption Foundation, said that his funeral had initially been planned for Thursday - the day of Putin's annual state-of-the-nation address - but no venue agreed to hold it then.

In an interview with the independent Russian news site Meduza. Zhdanov said authorities had pressured Navalny's relatives to "have a quiet family funeral." (AP)

ISLAMABAD, March 1: Jailed former Pakistan prime minister Imran Khan's party has announced Barrister Gohar Khan's election for the chairman's post for a second time after the withdrawal of all other candidates from the organisational polls.

Barrister Gohar Khan reelected

as Imran Khan's party chairman

The 71-year-old former-cricketer-turned-politician Khan's Pakistan Tehreek-e-Insaf (PTI) was scheduled to hold fresh organisational polls on March 3 after the result of its earlier intraparty election was annulled by the Election Commission of Pakistan (ECP).Barrister Gohar, 45, was on Thursday elected as the party's chairman unopposed, becoming the only leader to have been elected to the post twice in the party, Geo News reported. The PTI's candidate for the prime minister's slot, Omar Ayub Khan, was also elected unopposed as the party's central general secretary, the party announced late on Thursday.

Dr Yasmin Rashid, Ali Amin Gandapur, and Haleem Adil Sheikh were elected unopposed to the positions of the party's presidents for Punjab, Khyber Pakhtunkhwa, and Sindh, respectively, as no candidate contested against them.

Several party leaders had submitted their nomination papers as panels for the intra-party polls, but a majority of them withdrew only two days before the organisational election, the PTI's Federal Election Commissioner Raoof Hasan told the Dawn newspaper. Hasan said that he had no option but to announce the unopposed winners in the absence of opponents on most seats. The former ruling party will organise an organisational poll in Quetta for the Balochistan president's post.

"The final result of the election will, however, be declared by the Federal Election Commissioner on March 3, 2024, after the election process," read a statement by the party.

The party's top post had been lying vacant after the ECP and the Supreme Court declared its intra-party elections conducted in December last year unlawful.

The PTI held the organisational polls in December on the directions of the ECP. However, its result, which some disgruntled PTI workers challenged, was annulled after a bitter court battle. Subsequently, the party was deprived of its iconic cricket bat symbol by the top electoral body, and Gohar, who became the chairman after those elections, was no longer the party head. Earlier, Barrister Ali Zafar was announced as the party's next chairman nominee. However, he refused to accept the chairmanship, and subsequently, the former ruling party nominated Gohar

Gunfire paralyzes Haiti as powerful gang leader says he will try to detain police chief, ministers

PORT-AU-PRINCE, March 1: Heavy gunfire paralyzed Haiti's capital on Thursday, and at least four police officers were slain, as a powerful gang leader announced that he would try to capture the country's police chief and government ministers.

The move came during the absence of Prime Minister Ariel Henry, who is in Kenya trying to finalize details for the deployment of a foreign armed force to Haiti to help combat gangs.

Gunmen shot at Haiti's main international airport and other targets, including police stations, in a wave of violence that caught many people by surprise. At least four police officers, including two women, were killed in an attack on a station near the community of Canaan, according to a police union. The violence forced the airport, businesses, government agencies and schools to close as parents and young children fled through the streets in panic. At least one airline, Sunrise Airways, suspended all flights. Jimmy Chérizier, known as "Barbecue" and leader of the gang federation G9 Family and Allies, was seen in a recorded video announcing that the aim was to tie up the police chief and government ministers and prevent Henry from returning to Haiti.

"With our guns and with the Haitian people, we will free the country," he said. A spokesman for the prime minister's office could not be immediately reached for comment. The head of Haiti's National Police, Frantz Elbé, and police spokesman Garry Desrosiers did not return messages for comment.

Former Canadian PM Brian Mulroney, who SKorea's Yoon calls for unification, on holiday forged closer ties with US, has died at 84 marking 1919 uprising against colonial Japan

TORONTO, March 1: Former Canadian Prime Minister Brian Mulroney, who forged close ties with two Republican U.S. presidents through a sweeping free trade agreement that was once vilified but now celebrated, died on Thursday. He was 84.

The country's 18th prime minister died peacefully and surrounded by family, daughter Caroline Mulroney said in a post on X. Mulroney's family said last summer he was improving daily after a heart procedure that followed treatment for prostate cancer in early 2023. A family spokesman said Mulroney died at a hospital in Palm Beach, Florida, where he was being treated after a recent fall.

Leader of the Progressive Conservative party from 1983 to 1993, Mulroney served almost a decade as prime minister after he was first elected in 1984 after snagging the largest majority in Canadian history with 211 of 282 seats.

The win would mark Canada's first Conservative majority government in 26 years. His government was re-elected in 1988. Mulroney entered the job with widespread support, but he left with the lowest approval rating in Canadian history. His Progressive Conservative party suffered a devastating defeat just after he left office. But in the years after the loss, prime ministers sought his advice.

"He had the courage to do big



things," Prime Minister Justin Trudeau said. "He shaped our past, but he shapes our present and he will impact our future as well. He was an extraordinary statesman and he will be deeply, deeply missed."

The man known for his charm and Irish blarney — a gift for the gab — was an ardent advocate of stronger U.S.-Canadian relations. He pushed a free trade deal forward in no small part due to his chumminess with U.S. President Ronald Reagan. Few Canadians around during his reign have forgotten the widely broadcast Mulroney-Reagan duet of "When Irish Eyes Are Smiling" at the Shamrock summit in Quebec City in 1985, named after the pair's Irish heritage and the fact that their meeting fell on St. Patrick's Day. The 24-hour meeting opened the door to future free trade talks between the countries. Along with a fan base of fellow conservative Margaret Thatcher, Mulroney can also

H.W. Bush. Mulroney delivered a eulogy for Bush's state funeral. He also eulogized Reagan in 2004. Mulroney, Reagan and Bush became friends when they shared the world stage as leaders of their countries during the last

decade of the Cold War. Mulroney's nine years in power overlapped with Bush's four. It was Mulroney's amiable relationship with his southern counterparts that helped develop the free-trade treaty, a hotly contested pact at the time. The trade deal led to a permanent realign-

ment of the Canadian economy and huge increases in north-south trade. Canada is one of the most trade-dependent countries in the world. More than 75% of Canada's exports go to the U.S.

"He unleashed free enterprise, crushed inflation, restored fiscal sanity and concluded one of the greatest free trade agreements the world has ever seen," Canadian Conservative leader Pierre Poilievre said in a statement. boast of an enduring friendship

"On the world stage, he stood firmly on the side of Western al-

lies against communism and for freedom. He was among the first and most strident to fight against South Africa's apartheid policy and champion the cause of Nelson Mandela.'

However, Mulroney's administration was saddled with scandals and his near decade reign as prime minister came crashing down in 1993 when voters delivered a devastating election defeat to his Progressive Conservative Party, leaving it with just two seats in the 295-member House of Commons. He left shortly before the election result.

The defeat came amid wideunhappiness over spread Canada's then-depressed economy. Canadians blamed Mulroney for a three-year-old recession that left a record number of people out of work or bankrupt. Under his leadership, a much-criticized 7% sales tax was pushed through, as well as the 1988 U.S.-Canada Free Trade Agreement, after more than 100 years of tariff protection. The agreement later included Mexico in 1994, evolving into the North American Free Trade Agreement.

"Prime Minister Mulroney's instrumental role in the creation of the North American Free Trade Agreement laid the foundation for decades of economic cooperation and shared prosperity between the United States and Canada," the U.S. ambassador to Canada, David Cohen, said in a statement. (AP)

SEOUL, March 1: South Korea's president lambasted North Korea on Friday over what he called its repressive rule and vowed to achieve a free, unified Korean Peninsula, weeks after North Korean leader Kim Jong Un rejected the idea of peaceful unification and threatened to occupy the South in the event of war.

South Korean President Yoon Suk Yeol spoke on March 1 Independence Movement Day, a holiday marking a 1919 Korean uprising against Japanese colonial rule.

"Now, we must move toward a free, unified Korean Peninsula." Yoon said in a televised speech. "The North Korean regime relies solely on nuclear weapons and missiles while trapping its 26 million citizens in a quagmire of misery and despair."

"Unification is precisely what is needed to expand the universal values of freedom and human rights," Yoon said. "Our unification efforts must become a source of hope and a beacon of light for the people of North Korea.³

Yoon and Kim's conflicting comments on unification come after Korean animosities have run high for more than two years, with North Korea ramping up missile tests and South Korea expanding military drills with the US in a tit-for-tat cycle.

For most of the 70 years since the end of the 1950-53 Korean War, unification was a prized goal of leaders in both Koreas. which are divided by the world's most heavily fortified



border.

But the prospects for unifying the the rich, democratic South and the nominally socialist, authoritarian and poor North any time soon are extremely dim, observers say.

Despite extensive US-led sanctions and its own economic mismanagement, North Korea has appeared politically stable. Exchange programmes between the Koreas have been dormant since Kim's highstakes nuclear diplomacy with then-President Donald Trump collapsed in 2019. In a speech in January, Kim vowed to rewrite the constitution to remove the long-running state goal of a peaceful Korean unification and cement South Korea as an "invariable principal enemy."

He said the new constitution must specify North Korea would annex and subjugate the South if another war breaks out. The sudden abandonment of unification took observers by surprise.

Many experts say Kim likely aimed to take the initiative in dealings with the South while trying to diminish South Korean cultural influence and bolster his family's rule at home.

During Friday's speech, Yoon called Kim's vow of enmity "truly deplorable." He earlier said Kim's speech showed the "anti-national and anti-historical" nature of the North Korean government.

Yoon's speech didn't touch on the abuses of the Japanese colonial rulers in Korea, which left painful memories and have long been a source of tension between the two countries.

"On a holiday commemorating Korea's resistance against Japanese colonialism a century ago, Yoon touted his administration's improved relations with Tokyo," said Leif-Eric Easley, a professor of international studies at Ewha University in Seoul. "He emphasised that the independence movement will only be complete once the northern and southern halves of the Korean Peninsula are finally unified and free.'

Since taking office in 2022, Yoon has worked to beef up South Korea's military alliance with the US and resolve historical disputes with Japan, aiming to forge a stronger Seoul-Washington-Tokyo partnership against North Korea's nuclear threats.

"Now, Korea and Japan are working together to overcome the painful past," Yoon said. "Sharing the values of freedom, human rights and the rule of law, our two countries have become partners in the pursuit of common interests for global peace and prosperity." (AP)

Nagaland legislators express concerns over 'Assam Healing Bill' Minister Along made a plea to his fellow legislators, urging not to rush into condemning the bill

KOHIMA, March 1: Nagaland lawmakers have expressed concerns over the 'Assam Healing (Prevention of Evil) Practices Bill, 2024.' The legislators deliberated this matter under Rule 50 during the last day of the fourth session of the 14th Nagaland Legislative Assembly in Kohima on Friday.

Deputy chief minister T R Zeliang emphasised the significance of the discussion on the Assam Healing (Prevention of Evil) Practices Bill, 2024. Zeliang asserted the "duty to defend faith and beliefs", citing constitutional provisions safeguarding freedom of religion (Article 25-28). He criticised the Assam Bill, alleging it as undermining secularism and targeting Christian practices.

Zeliang argued that Assam's diversity mirrors India's secular fabric, emphasizing coexistence among religions in the Northeast. He criticised the Bill's restriction on healing practices by Christian missionaries, asserting healing as integral to Christian faith, protected under constitutional rights.

He condemned religious intolerance incidents in Assam, including detentions of American citizens for alleged "Christian preaching" and those demands to remove Christian symbols from schools. Zeliang urged Assam to revoke the Bill, calling it a threat to India's secular principle. Highlighting constitutional guarantees of religious autonomy, Zeliang urged Assam to respect minority rights and repeal the contentious Bill. He proposed conveying the Assembly's opposition to Assam's Legislative Assembly.

ECI notifies scheme for IDP voters of Manipur violence for upcoming Lok Sabha elections

IMPHAL, March 1: Election Commission of India (ECI) has notified "Scheme for Internally Displaced Persons of Manipur to vote at the relief camps", said chief electoral officer (CEO) of Manipur on Friday.

The elections to the Lok Sabha are expected to be held between April and May 2024 to elect 543 members of the house.

As per the ECI, the scheme was notified after due consultation with the Central government and state government considering the displacement of large number of people in the ongoing

A large number of electors registered in several parts of the state of Manipur were displaced from their native places during the conflict that started from May 3, 2023.

Presently they are residing in relief camps in various districts of Manipur. The displaced electors are still enrolled at the places where they were ordinary residents before the conflict started

All such displaced persons who had to leave their native places during the conflict shall continue to be borne on the electoral rolls of the assembly and parliamentary constituencies concerned in the state of Manipur.

As per the past precedent of similar nature, the internally displaced electors shall be provided with the facility to vote at 'Special Polling Stations' to be set up in relief camps as per the scheme.

In order to identify the 'specified voters ', the eligible voters staying in the relief camps or otherwise (staying with relatives/friends) are given the option to elicit the choice of 'special polling station' where they would like to cast their vote under the scheme. If the head of the family or any senior member of the family gives intimation in respect of all the family members, it may not be necessary to collect such information from each elector.

Though the right to vote is an individual right, the gathering of such information from the head of the family would not militate against the individual's right to vote at the time of election as the voter concerned will have to exercise the vote individually after satisfying the polling staff of her/his identity.

This information from the head of the familv/senior member of the families may be obtained in a non-statutory form to be called 'ID Form', the ECI said while notifying the scheme

An individual voter, if without any family members staying with her/him at the relief camp, may submit her/his own ID form, it added

On the basis of intimation given by the specified voters in the 'ID Form', the AROs may cull out lists, constituency-wise, (showing therein the details of assembly segment and part number thereof) of electors who opt for voting in person in the above mentioned special polling station.

Then these electors will be assigned to the different special polling stations as per the preference indicated by them. The maximum number of voters at each special polling station will be 1200.

If at any special polling station, the number of voters exceeds 1200, then more than one booth may be provided at the same special polling station location with equitable distribution of electors for convenience, the scheme stated.

'Special Polling Stations' shall be notified for a cluster of relief camps with a specific 'Special polling Station' earmarked for a group of relief camps.

Eligible electors staying in the relief camps shall be given the option to vote at the 'special polling station' notified for the relief camp where she/he is staying at. (NNN)



Tripura FM tables ₹27,804.67 crore budget in assembly

AGARTALA, March 1: Tripura Finance Minister Pranajit Singha Roy on Friday presented a ₹ 27,804.67-crore budget for the 2024-25 fiscal, and asserted that the government is focused on infrastructure building to generate more job opportunities in the northeastern state. Roy said ₹ 6,633.80 crore has been earmarked for capital expenditure, while ₹ 1721.94 crore was allocated for the agriculture sec-

"During 2022-23, the Gross State Domestic Product (GSDP) grew at around 8.89 per cent against 7.20 per cent growth at the national level. The GSDP growth for 2024-25 is estimated to be 8.47 per cent," the minister said

A total of ₹ 2,000 crore will be spent for road infrastructure in all the 60 assembly constituencies over the next four years, according to the budget.

"The state government will provide Rs 698.68 crore to the Tripura Tribal Areas Autonomous District Council (TTAADC)... Besides, we are setting aside 39.93 per cent of the total development allocation for welfare of indigenous people," he said.

Tripura will set up 85 'pink toilets' at various locations to create hygienic public restrooms for women and children at a cost of Rs 7.51 crore.



Referring to Khanakul, the birthplace of 19th century social reformer Raja Rammohan Roy which was close to the venue of the public meeting, the Prime Minister said that "the spirit of Roy, wherever it is, must be sad and weeping at the state of affairs in Bengal' TMC leaders

"Someone must have been protecting him," Modi declared and asked the gathering whether people would forgive and keep supporting such a political party in the state.

Accusing the TMC government of being corrupt in all spheres, Modi also took a dig at the opposition bloc INDIA for acting like the fabled monkey sculptures of "Gandhi who keep their eyes, ears and mouth shut" in the face of the abuse which left Sandeshkhali simmering with discontent.

The PM questioned why the Left and Congress leaders shied away from asking the tough questions to Chief Minister Mamata Banerjee

"For INDI alliance leaders, supporting the corrupt and appeasement politics is of prime importance rather than standing

by those tortured by the TMC in Sandeshkhali," he said.

Naming the TMC for remaining "neck deep in corruption", Modi mentioned the scams which had recently rocked the state in the domains of primary teachers' recruitment, municipal body recruitment and the public distribution system.

"It is Modi's guarantee to you that those who have looted your money will have to go back to where they came from," he declared.

The Prime Minister also accused the Mamata Banerjee government of stalling several central projects from getting implemented in the state. "The arrogance of the TMC

will break soon. It is confident that it has the support of a particular group, but the Muslim women too will throw them out now," Modi asserted.

The Sandeshkhali region, located on the fringes of the Sunderbans, has been engulfed in turmoil for over a month with allegations against TMC leader Shajahan Sheikh and his cohorts of sexual abuse and land usurpation. (PTI)

SC to hear Gyanvapi committee's plea on maintainability





NEW DELHI, March 1: The Supreme Court on Friday agreed to hear an appeal of the Gyanvapi management committee against an Allahabad High Court order which held that lawsuits for "restoration" of a temple, which was claimed to have stood where the mosque stands in Varanasi, are maintainable.

"We will tag this with the main case," a bench comprising Chief Justice D Y Chandrachud and justices J B Pardiwala and Manoj Misra said.

The petition was filed by the Anjuman Intezamia Masjid, the committee which manages the affairs of the Gyanvapi mosque.

On December 19 last year, the Allahabad High Court had dismissed pleas challenging the maintainability of a 1991 suit seeking "restoration" of a temple at the site

of the ruling NDA inside the Bihar assembly, becoming the fifth legislator to have deserted the party in less than a month.

Bind, who represents Bhabua in Kaimur district, reached the Vidhan Sabha premises in the post-lunch session with Deputy Chief Minister Samrat Choudhary, who is also the state BJP president.

He entered the House with Murari Gautam, a former minister who had turned his back on Congress a couple of days ago, and the two sat together.

The development comes on the final day of the budget session when the House was through with legislative business and taking up private members' bills.

Earlier, RJD MLAs Chetan Anand, Neelam Devi and Prahlad Yadav had switched over to the ruling side, voting against party leader and the then Speaker Awadh Bihari Chaudhary in a no-confidence motion, and supporting the NDA in the trust vote.

Besides, on Wednesday, RJD MLA Sangita Kumari, along with Murari Gautam and Siddharth Saurav of the Congress, were felicitated inside the premises by Samrat Choudhary, whom they followed into the assembly hall, and amid thumping of desks in approval by NDA members, they sat beside the ruling coalition MLAs.

However, the two Congress MLAs' disqualification has been sought by the party which has called them "traitors".

The HC had said the "religious character" of a disputed place can only be decided by the court.

It had dismissed five related petitions on maintainability and against a survey of the mosque premises filed over the years by the mosque management committee and the Uttar Pradesh Sunni Central Waqf Board.

The HC had held that the suit filed before the district court by Hindus is not barred by the Places of Worship (Special Provisions) Act, 1991, which forbids "conversion" of the "religious character" of a place from what existed on August 15, 1947.

The suit was filed seeking the right to worship in the Gyanvapi mosque adjoining the Kashi Vishwanath temple. Muslim litigants had challenged its maintainability, citing the Places of Worship (Special Provisions) Act.

On December 8 last year, the high court had reserved its judgment on all five petitions challenging the maintainability of the suit pending before the Varanasi court.

While upholding the maintainability of lawsuit, the high court had ordered speedy trial in the 32-year-old Gyanvapi dispute case.

It had said the 1991 law on places of worship did not define "religious character" which can only be determined through evidence presented in court by the opposing parties.

Éither the Gyanvapi compound has a Hindu religious character or a Muslim religious character. It can't have dual character at the same time," the HC had said.

"In the national interest, it is required that the suit must proceed expeditiously and be decided with utmost urgency with the cooperation of both the contesting parties without resorting to any dilatory tactics," the high court had said, cautioning against any "unnecessary adjournment" in the lower court.

The Supreme Court earlier gave the go-ahead for a survey of the Gyanvapi mosque premises by the Archaeological Survey of India and the high court allowed a survey of the Shahi Idgah mosque that adjoins the Krishna Janmasthan temple in Mathura.

Hindu litigants say the two mosques were built during the Mughal rule after demolition, or partial demolition, of temples, and the surveys would throw up evidence proving this.

The high court took note of the ASI survey conducted at the Gyanvapi masjid on the directions of the trial court which is hearing the petition of a group of women seeking regular access to Hindu deities depicted on the mosque's rear wall.

If required, the lower court may direct ASI for a further survey, the HC had added.

The high court, on February 26, decided another petition challenging the permission granted to the Hindu side to offer prayers in the southern cellar of the Gyanvapi mosque. It said Hindu prayers will continue in the southern cellar of the mosque and dismissed a plea that challenged the district court's order to this effect.

The high court observed that the Uttar Pradesh government's 1993 action of stopping rituals inside "Vyas Tehkhana" in the southern cellar of the Gyanvapi mosque was "illegal". It said the rituals were stopped by "illegal action of state without there being any order in writing". (PTI)

IIT-Mandi developing quantum computer that will use photons for faster calculations

NEW DELHI, March 1: The Indian Institute of Technology, Mandi, is de-veloping a first-of-its-kind indigenous room-temperature quantum computer that will use photons for faster calculations, according to officials.

Indore, Mumbai and Raipur.

The computer, being developed as part of the National Quantum Mission. will be unique in its ability to analyse data and suggest solutions with 86 per cent accuracy without traditional algorithms, they said.

Quantum computing is a rapidly emerging technology that harnesses the laws of quantum mechanics to solve problems too complex for classical computers.

"We are constructing a room-temperature optical Quantum computer capable of solving feature learning and classification problems instantly.

"With a sophisticated user interface, quantum simulator and quantum processing capabilities in place, our computer will operate as a graphics processor (GPU) instead of CPU,



seamlessly processing inputs such as videos or photographs," said C S Yadav, the chairperson of the Center for Quantum Science and Technologies (CQST) at IIT-Mandi.

It will extract a model to explain inherent dynamics hidden in the input data and deliver output as quantum live feed, he said.

"Composing a quantum algorithm is tedious. Yet our computer will mirror the inquisitive mind of a scientist, swiftly suggesting an approximate theoretical model for unknown big data with an 86 per cent accuracy, all without relying on algorithms," Yadav told PTI.

According to Yadav, there is a lot of

buzz about quantum computing and companies like Google and IBM have made their own quantum computers.

"So let's say that those companies are making a quantum computer which is based on a superconducting Josephson junction qubit. To do that quantum computing you will require a very very low temperature. So, our objective is to make a photon-based quantum computer at room temperature," he said.

Josephson junction is a device that provides the non-linearity needed to turn a superconducting circuit into a qubit.

Yadav explained that the room-temperature optical quantum computer will use light for doing fast calculations. Using quantum bits (qubits), the computer will exist in multiple states simultaneously, allowing incredibly fast processing. The system will be able to update itself and erase its memory using a special gel.

"We are focusing on scaling up the quantum computing system from handling 16 tasks to 1,024 tasks simultaneously. To achieve this, the team is developing three crucial components: a single photon source, a phase-sensitive single-photon avalanche diode and a multipurpose coincidence counter. These components are vital for building quantum computers and will be developed up to a high level of reliability and effectiveness," he said.

According to IIT-Mandi Director Laxmidhar Behera, CQST is making significant strides in quantum computing technology and is poised to revolutionise various sectors.

"Through the National Quantum Mission, we are advancing the field with groundbreaking innovations aimed at enhancing feature learning and classification capabilities across genetics, astrophysics, finance, and weather forecasting. Strategically selecting the three immediate products, we are poised to develop each component vital for building quantum computers," he said. (PTI)

Nine injured in bomb blast in Bengaluru eatery 'It was not a large-scale blast, it was an improvised explosive blast'

BENGALURU, March 1: A bomb blast at a popular eatery in the city on Friday left nine people injured and police have launched a probe from all angles after it emerged that an earlier suspected gas leak was not the cause of the explosion.

Police suspect that a bag at the eatery with a possible improvised explosive device (IED) could have exploded, even as the NIA and the IB have been apprised of the matter. Officials from the local unit of the National Investigation Agency (NIA) later arrived at the spot.

Chief minister Siddaramaiah said investigation is on to ascertain the cause and nature of the explosion at the popular Rameshwaram Cafe in Whitefiled, and added it might have been caused by an "improvised explosive" device.

The incident should not be politicised and everyone should cooperate, Siddaramaiah said, adding strict action would be taken against those involved.

State police chief Alok Mohan described the explosion as a "bomb blast" and said nobody was seriously injured.

"At 1 PM, a bomb blast occurred at the hotel (cafe), nine people are injured, and no one is serious. We are investigating. FSL (forensic) teams have come and are checking. City police Commissioner and other officers are at the spot. We will certainly identify who did it," he said after visiting the spot. Speaking to reporters, he said the injured -- both staff and customers -- are undergoing treatment

Asked whether an IED was used for the blast, he said, "we are checking."

"Let's not say anything now itself. The FSL team has come and they are checking. Once they collect (samples from the spot),

we will examine.

Divya Raghavendra Rao, co-founder & managing director of Rameshwaram Cafe told a Kannada news channel the blast occurred in the area where customers wash their hands. A stand is also kept there, where the waste is collected.

The explosion was caused from a bag placed by someone from outside, she claimed. A CCTV video of the incident showed an explosion, leading to smoke and panic-stricken customers and others fleeing the place. The opposition BJP sought a detailed probe into the matter.

"Deeply troubled to hear about the blast at Rameswaram Cafe in Bangalore (sic). Praying for a swift recovery of all the injured in the incident. State govt should order a detailed enquiry & spare no efforts in apprehending the perpetrators," BJP state president Vijayendra Yediyurappa said in a post on 'X.'

'Callousness' of the government in downplaying such crimes "is pushing the state into this chaos & proving to be a safe haven for antisocial elements.

"Failure of police intelligence is also evident in this incident. We strongly urge the

police to conduct a thorough probe & eradicate these elements from the core without yielding to any political pressures," he demanded

R Ashoka, leader of opposition in the Assembly said, "the bomb blast at Rameshwaram Cafe in Bengaluru is yet another glaring example of the deteriorating law and order situation in Karnataka ever since CM @siddaramaiah led @INCKarnataka Govt came to power in the state.'

While it was initially suspected that a gas leak could have triggered the blast, the Fire department ruled out the possibility and said a bag was found at the spot. Subsequently, police were looking into all angles related to the incident. A bomb disposal squad and forensic teams were at the spot...

CCTV footage is being scanned to check if there was any suspicious movement in and around the cafe.

"At 1.08 pm today, the Fire department received a call about LPG leakage fire in the cafe. When our officers and teams reached the spot, there was no fire or flame. A bag which was lying behind a woman who was sitting with six other customers at the eatery exploded. It is suspected that the explosion could have been caused due to some object in that bag," TN Shivashankar, Director of Karnataka State Fire and Emergency Services department told PTI.

It is not clear whose bag it was. Ruling out about the possibility of any gas cylinder leakage, the officer said, "I along with my team of officers inspected the spot. But there is no sign of any leakage from the gas cylinder. We have checked it. Another LPG gas cylinder inside the kitchen which was used for making tea and coffee also was checked but there is no leakage from it as

well. There is no sign of gas leakage from any cylinders at the spot as per our initial probe." The cafe which is located at Whitefield's Brookfield area, a vibrant neighborhood, a business centre as well as a tech hub. It is usually crowded with employees from nearby offices during the lunch hours. Edison, an eyewitness said, "I was waiting outside the eatery for my turn when suddenly we heard a loud noise ... an explosion. We got scared not knowing what it was. There were around 35-40 people at the eatery. They all started rushing out and there was absolute chaos. They started saying that a cylinder exploded. But we don't know exactly what happened.'

Amruth, who works at a private firm nearby had just placed his order when he suddenly he heard a huge explosion.

In Mysuru, Siddaramaiah said that after 12 PM someone placed a bag and went. All the injured persons are out of danger. "CCTV and other things are being exam-

ined. We have come to know about someone placing a bag. It is said to be an improvised explosive blast. We have to see, the investigations are on. Asked whether it was a terrorist act, the

CM said, it is not known and investigation was on. Police are at the spot and he has asked the home minister also to visit the

"It was not a large-scale blast, it was an improvised explosive blast. Such things have happened earlier too, it should not happen. Let's see what it is. In recent times such blasts had not taken place other than the incident in Mangaluru (Nov'22 pressure cooker blast) during BJP rule. This is the first such incident during our government," he added. NEW DELHI, March 1: The number of candidates contesting the Lok Sabha polls has seen a rise of over four times from 1,874 in 1952 to 8,039 in 2019, according to official data

The average number of candidates per constituency has jumped from 4.67 to 14.8 in the same period, the data showed.

With the Lok Sabha polls nearing, the battleground is set but it is yet to be seen how many candidates are in the frav even as the proportion of candidates contesting has seen a rise since 1952 when the first elections were held.

On an average, there used to be only around three to five contestants per Lok Sabha seat until the sixth Lok Sabha elections in 1977 but in the last elections 14.8 candidates on average contested from per

constituency across the country. According to an analysis by nonprofit organisation PRS Legislative Research, there were 8,039 candidates contesting from 542 Parlia-

mentary constituency seats in the 2019 general assembly elections. A closer look at the last Lok Sabha polls in 2019 show that on an average, among all the states, Telangana had the highest average number of candidates contesting. This is primarily due to 185 contestants from Nizamabad. Excluding Nizamabad, the state's average

> number of contestants would be 16.1. After Telangana, Tamil Nadu had the highest average of independent candidates contesting in last elec-

Number of candidates contesting Lok Sabha polls jumped four-fold between 1952 and 2019 Of the candidates in each con-

stituency in Tamil Nadu, an average of two-thirds contested as independent candidates.

After Nizamabad, the second highest number of candidate representation was seen in Belgaum, Karnataka.

The five constituencies that had the highest candidate representation were from the southern states of Telangana, Karnataka, and Tamil Nadu.

The Bharatiya Janata Party and Congress contested 435 and 420 seats respectively. They were in competition with each other in 373 seats. BSP fielded the third highest number of candidates contesting in the 2019 elections.

The seven national parties together fielded 2.69 candidates per constituency. Among the largest five states, West Bengal had the highest representation of candidates from national parties at 4.6 and had candidates from five national parties contesting in the state.

Recognised state parties together fielded 1.53 candidates per constituency. Bihar (6 state parties) and Tamil Nadu (8 state parties) saw a high representation of candidates from state parties at 1.2 and 1.3 respectively.

BHUBANESWAR, March 1: Youth Congress supporters hurled tomatoes and eggs at Odisha police after they were prevented from marching towards Chief Minister Naveen Patnaik's residence during a protest rally against 'unemployment' and 'corruption here on Friday.

Led by their national president BV Srinivas, hundreds of youth Congress supporters participated in the 'Naveen Hatao, Odisha Bachao' protest rally, party sources said.

DRI confiscates 36 kg of methamphetamine tablets in TN

MADURAI (TAMIL NADU), March 1: Sleuths from the Directorate of Revenue Intelligence (DRI) seized 30 kg of narcotic drugs, identified as methamphetamine, from a male passenger at the railway station here, and another six kg from the Kodungaiyur dump yard, Chennai, in a meticulously planned operation, the central agency said on Friday.

The value of the confiscated drugs was ₹ 180 crore and the man and his wife were detained, it said. Methampheta ine, also known as "ice" or "crystal meth" is a highly addictive psychostimulant drug which exhibits powerful euphoric effects similar to those of cocaine, leading to lifethreatening consequences, the agency said.

Acting on a tip-off that a passenger of the Madurai bound Pothigai Express Train from Chennai on February 29 would be carrying narcotic substances, the DRI Chennai Zone officials laid a trap for the said passenger and when the train arrived at Madurai railway station on Friday morning the team identified the "passenger" and intercepted him with the help of RPF officials.

A search of his baggage yielded 15 packets weighing 30 kg in total containing white coloured crystal substance, which on testing was found to be methamphetamine. The contraband was immediately seized. Upon being interrogated, he disclosed that some more methamphetamine packets were kept at his home in Chennai, a replatform 'X'. (PTI)

lease said. "His home was searched in a swift move and it came to light that his wife threw away the narcotic packets in the dustbin and the garbage was already taken to the Kondungaiyur dumpyard," the release stated. A DRI team rushed to the dumpyard and recovered three packets of methamphetamine weighing six kg.

"The international market value of the total seized narcotics substance is around ₹ 180 crore," the DRI said. Preliminary investigation revealed that the man was carrying it to be transported to Sri Lanka through the coastal route. Both the passenger and his wife have been detained and further investigation is under progress.

The survey also mentioned that at the end of the financial year 2022-23, the total sanctioned bed capacity in Delhi decreased to 57,686 beds at 1,153 government and private medical institutions and hospitals, from 58,960 beds available, as on March 31, 2022.

"Sanctioned bed capacity in Delhi decreased particularly in hospitals run by the Government of India and Municipal Corporation of Delhi. In hospitals, run by the government of India this has decreased from 9,544 in 2021-22 to 9,386 in 2022-23," it added. (PTI)

Child predator Bijay Rajput sentenced to 20 years RI Portfolios allocated to 11 EMs in 13 NC Hills Autonomous Council

HT Correspondent JORHAT, March 1: The Court of Special Judge, Jorhat, has sentenced a man to 20 years of rigorous imprisonment after convicting him of sexually abusing a minor girl. The Additional Jorhat District and Sessions Judge (Jorhat), AJ Borah, acting as Special Judge on Thursday, pronounced the judgment in the case, convicting Bijay Rajput, a resident of a tea garden under Titabar Police Station, under Section 6 (1) of the Protection of Children from Sexual Offences Act (POCSO), 2012, and sentenced him to 20 years rigorous imprisonment. A fine of ₹ 20,000 was also imposed on Rajput,

and in default of payment, the convict will have to undergo another two years of rigorous imprisonment. Altogether, six witnesses were examined during the trial by the court. The Judge also referred the matter to the District Legal Services Authority (DLSA), Jorhat, for the grant of compensation to the victim under the Victim Compensation Scheme for her medical treatment, education, and rehabilitation. As per the FIR lodged by the mother of the victim on August 5, 2022, at the Titabar Police Station, Rajput was accused of sexually assaulting the minor several times, which came to light after injury on her private parts was found by the mother.

NEW DELHI, March 1: "A few players will suffer, but let it be," said legendary former India captain Kapil Dev on Friday as he backed the BCCI's decision to terminate central contracts for lack of commitment to domestic cricket, calling it a much-needed step to protect marquee first-class events like the Ranji Trophy.

Ishan Kishan and Shreyas Iyer were on Wednesday excluded from the BCCI's central contracts after ignoring the board's diktat to play in the Ranji Trophy. The decision evoked mixed reactions with some former players like Kirti Azad and Irfan Pathan backing the out-of-favour duo.

Kapil refrained from taking names but said the BCCI's decision to assert the importance of domestic cricket was long overdue. "Yes, few players will suffer, kuch logon ko taqleef hogi, hone do lekin desh se badhkar koi nahi hai (some people will feel hurt but let it be because nobody is bigger than the country). Well done," he said.

'I congratulate the BCCI for taking the much needed step to protect the status of domestic cricket. I was sad to see domestic cricket being given the skip

1.16 crore approx). "I am really looking forward to play at the Indian Open this year. It has been five years since I had the opportunity to compete in my



national open. Winning the title

in 2015 remains one of my most cherished memories," said Lahiri, a former Asian and European tour champion, via a video message during a press conference

here on Friday. Lahiri, who had clinched the title in 2015, last played in the 2019 editions before the outbreak of the COVID-19 pandemic in 2020, which meant the event could only return in 2023 after three years.

The 36-year-old, who now competes on the LIV Golf Tour, skipped the last edition but he has taken approval from the European Tour to participate in the country's flagship golf tournament this year.

The 57th edition of the Indian Open will be the second of five events comprising the Asian Swing as part of the new-look 2024 Race to Dubai.

Apart from Lahiri, Shiv Kapur, three-time DP World Tour winner Nicolas Colsaerts of Belgium and the new exciting talent Kazumi Kobori of New Zealand will be part of the elite field, the entry of which is still open.

Manu Gandas, who is currently ranked second in the PGTI Order of Merit, and Aman Raj will also be part of the Indian field

"My best result was last year, I have played thrice in this tournament. My last day was not that great, so I would like to put up an improved show this year," said Gandas, who had played in the 2023 DP Tour.

Indian Golf Union (IGU) President Brijinder Singh said they have taken efforts to make it a memorable experience for the spectators this time.

'The Hero Indian Open has been the summit on the Indian golf calendar as Indian Golf Union strives to promote and run one of the most expansive amateur schedules, which has allowed top amateurs to grow into world-class professional golfers," he said.
