India's first automobile in-plant railway siding project of Maruti Suzuki in Gujarat

Project has been developed under the Centre's PM Gati Shakti mission in partnership with the Gujarat government

AHMEDABAD, March 12: Prime Minister Narendra Modi on Tuesday inaugurated India's first automobile in-plant railway siding project of Maruti Suzuki (MSIL) at its plant at Hansalpur in Gujarat's Mehsana district virtually from a function here.

PM Modi, who visited Gujarat on Tuesday, inaugurated and laid the foundation stone of ₹ 85,000 crore railway projects, including the launch of 10 new Vande Bharat trains, from Sabarmati area of Ahmedabad in Gujarat after visiting the Dedicated Freight Corridor's (DFC) Operation Control Centre here. The MSIL's in-plant railway siding project was also inaugurated during the event.

The project has been developed under the Centre's PM Gati Shakti mission in partnership with the Gujarat government, Indian Railways and MSIL at a cost of ₹ 976 crore, MSIL's Executive Officer, Corporate Affairs, Rahul Bharti said.

"It is for the first time in India that an in-plant railway siding for any automobile company has happened. This is the excellence of the Gati Shakti programme," Bharti told media persons here.

The project has been developed by a special purpose vehicle - Bahucharaji Rail Corporation Lim-



ited (BRCL) - set up with Gujarat Railway Infrastructure Development Corporation (GRIDE), Gujarat Industrial Development Corporation (GIDC) and MSIL as partners with 49 per cent, 29 per cent and 26 per cent equities each respectively.

GRIDE is a joint venture between the Gujarat government and the Ministry of railways.

The railway line within the Bahucharaji plant is developed entirely by Maruti Suzuki at a cost of ₹ 105 crore, Bharti said.

The project eliminates an annual 50,000 truck trips for MSIL, with the automobile major planning to increase dispatches of finished cars

by railway from 26 per cent currently to 40 per cent annually at its full capacity, he said.

"The project will save 50,000 truck trips, 35 million litres of fuel used in trucks per annum, and cut down on 1,650 tonnes per annum carbon emission. Logistics can be a good way of reducing our carbon emission, moving us towards carbon neutrality," Bharti said.

"Converting the dispatch from road to rail will benefit everyone as it reduces road congestion. A truck does an average trip of 1,600 km, and one train replaces 40 such trucks. One route of the train thereby helps us effectively eliminate 64,000 km of a truck running

on the road," he said.

The railway siding has a capacity to dispatch 3,00,000 cars per annum with a present parking capacity of 800 cars expandable up to 3,000 cars, he said.

Till February, Maruti Suzuki has dispatched around 18 lakh cars by railways. During the current fiscal till February, 4.09 lakh cars have been dispatched by the railways, he said.

"Our penetration of the railway as a mode of dispatch is the highest among all car manufacturers in the country. We have done more than 21 per cent of dispatches this year, and we want to keep increasing it further, the company's executive officer said.

"We want to keep increasing the share of railways in our finished goods dispatched from the factory to either the dealers in India or to ship for exports. Our exports are also growing, and the company now exports 42 per cent of cars from India. It will increase drastically in the future," he said.

Giving details of the timeline of the project, Bharti said that G-RIDE gave its formal approval in March 2017, after which the company's internal board approved it in January 2019, and construction began in May 2020. (PTI)

Sensex edges higher, Nifty ends almost flat amid volatile trade

MUMBAI, March 12: Equity market benchmark Sensex ended higher on Tuesday due to heavy buying in index heavyweights like HDFC Bank, TCS and Reliance Industries amid mixed cues from Asian markets.

Witnessing a volatile trade, the 30-share BSE Sensex closed 165.32 points or 0.22 per cent higher at 73,667.96. During the day, the barometer surged 501.52 points to 74,004.16.

The broader Nifty, however, ended almost flat at 22,335.70, inching up 3.05 points or 0.01 per cent.

Among Sensex firms, HDFC Bank climbed more than 2 per cent. TCS, Maruti, Infosys, Reliance Industries and Bharti Airtel were among the major gainers.

State Bank of India, JSW Steel, ITC, Tata Motors, UltraTech Cement and Nestle were among the laggards.

"The domestic market witnessed range-bound trading today after the previous day's sharp profit booking. However, mid and small-cap stocks remained pressured, primarily due to apprehensions regarding inflated valuations," Vinod Nair, Head of Research, Geojit Financial Services, said.

"Global sentiment remained mixed as investors awaited key US inflation data, which could offer insights into the Fed's interest rate decisions. Additionally, market participants are anticipating India's inflation figures scheduled for release today, to remain consistent with the previous month, which will be at the middle of RBI's tolerance range," he added.

In the broader market, the BSE smallcap gauge declined 2.11 per cent and midcap index dipped 1.31 per cent.

Among sectoral indices, realty plummeted by 3.53 per cent, industrials by 1.74 per cent, commodities by 1.73 per cent, services by 1.70 per cent, utilities by 1.59 per cent and metal by 1.34 per cent. IT and Teck were the only gainers. (PTI)

Google ties up with ECI to prevent spread of false information

Ads policies already prohibit the use of manipulated media to mislead people, like deepfakes or doctored content

NEW DELHI, March 12: Alphabet Inc-owned Google has joined hands with Election Commission of India (ECI) to prevent spread of false information, promote authorised content and label AI-generated data during the upcoming general elections. Google India in a blog post on Tuesday said its product features are designed to elevate authoritative information on various election-related topics.

"We are collaborating with ECI to enable people to easily discover critical voting information on Google Search - such as how to register and how to vote - in both English and Hindi," Google said.

With more people using artificial intelligence to create content, Google said it is setting up processes to help audiences identify AI-generated content.

"As more advertisers leverage the power and opportunity of AI, we want to make sure we continue to provide people with greater transparency and the information they need to make informed decisions. Our ads policies already prohibit the use of manipulated media to mislead people, like deepfakes or doctored content," it said.

Google has already started displaying labels for content created with YouTube generative AI features, like Dream Screen.

"Soon, YouTube will begin to require creators to disclose when



they've created realistic altered or synthetic content, and will display a label that indicates for people when they're watching this content," it said. The blog post further said the company has begun to roll out restrictions on the types of election-related queries for which Gemini will return responses.

It said that for news and information related to the election, YouTube's recommendation system prominently surfaces content from authoritative sources on the YouTube homepage, in search results, and highlights high-quality content from authoritative news sources. The popular search engine said they have set policies around demonstrably false claims in areas like manipulated content, incitement to violence, hate speech, and harassment, that could undermine democratic processes.

"We rely on a combination of human reviewers and machine learning to identify and remove content that violates our policies. Our AI models are enhancing our abuse-fighting efforts, while a dedicated team of local experts across

all major Indian languages are working 24x7 to provide relevant context," the blog post said.

Google has set strict policies and restrictions around who can run election-related advertising on its platforms. These include identity verification, certification and authorisation by the ECI, and financier disclosures.

"We take our responsibility for providing high-quality information for these types of queries seriously, and are continuously working to improve our protections," the blog post said. Google said it has recently joined the Coalition for Content Provenance and Authenticity (C2PA), and pledged to help prevent deceptive AI-generated imagery, audio or video content from interfering with this year's global elections.

Earlier, Google had introduced the Google News Initiative Training Network and the Fact Check Explorer tool to enable newsrooms and journalists deliver reliable, fact-checked updates to debunk misinformation. Additionally, Google is supporting Shakti, India Election Fact-Checking Collective, which is a consortium of news publishers and fact-checkers in India working together to aid the early detection of online misinformation, including deepfakes, and to create a common repository that news publishers can use to tackle the challenges of misinformation at scale. SBI submits electoral bonds details

made to political parties as part of efforts to bring transparency to political funding. The first sale of electoral bonds took place in March 2018.

Electoral bonds were to be redeemed exclusively by an eligible political party through an authorised bank account, and the SBI is the sole authorised bank for issuing these bonds.

Electoral bonds were encashed by an eligible political party only through a bank account with the authorised bank. Electoral bonds were purchased by Indian citizens or entities incorporated or established in the country.

Registered political parties that had secured not less than 1 per cent of the votes polled in last Lok Sabha or legislative assembly elections were eligible to receive funding through electoral bonds. (PTI)

and democratically," he said. In Sonitpur, the district administration has imposed Section 144 of CrPC and prohibited holding of meetings, demonstrations, processions and sloganeering in public places to prevent any untoward incident.

Security has been tightened across the state with additional deployment of police personnel, including commandos, in sensitive areas, while all police stations in the state have been put on an alert.

Patrolling has been intensified and check-posts have been set up on arterial roads in almost all the cities and towns of the state, where protests were held over the issue in 2019.

All Assam Students' Union and 30 non-political indigenous organisations will also take out torchlight processions in the evening and launch a satyagraha from Wednesday.

An AASU delegation left for New Delhi on Tuesday to pursue the petition against the Act in the Supreme Court and the leaders will return for the procession in the evening, the student organisation's general secretary Sankar Jyoti Baruah said. (PTI)

adding that "now the time has come for application on the portal. The data on the portal will speak now, and it will become clear whether the claims of those opposing the Act stand factually correct or not," Sarma said. People of Assam will know in a month whether lakhs of people or a few thousand are applying for citizenship in the state, he said.

The chief minister said he respects both the protesters and the supporters of the Citizenship Amendment Act but "enough has been said on CAA and now it is time to prove the claims".

"It is time for those who are in politics to prove their claims just like Sita had to undergo 'agni pariksha' to prove her purity," Sarma said. He said it would also be clear who were responsible for the death of five people during the violent protests in 2019.

"Protests should not be held now as the law has already been enacted, but if anybody has any grievance, they should go to courts," he said.

A sizable population of Bengali Hindus was left out due to lack of proper legacy data documents.

The NRC authorities had claimed that these people did not have documents to prove that they had entered the state before March 24, 1971. (PTI)

CAA not meant to snatch anyone's

take it away. "...I want to tell the minorities of this country that no citizen of the country will lose citizenship due to CAA. The CAA is a law that grants citizenship and does not take away anyone's citizenship. I assure you there is no provision in CAA to snatch anyone's citizenship," he said.

Speaking at a BJP social media volunteers meeting, Shah alleged that the Congress party opposed the new citizenship law due to appeasement and vote-bank politics.

"We had said we will bring CAA. The Congress party opposed CAA. Since independence it was a promise of the Congress and makers of our Constitution that citizenship will be granted to those persecuted on religious grounds in Bangladesh, Afghanistan and Pakistan, who come (to India). But, due to appeasement and vote-bank politics, the Congress party opposed the CAA."

He said in order to save their faith and honour, lakhs and crores of people from Pakistan and Bangladesh came to India, but were not granted citizenship.

"They (refugees) felt insulted in their own country when they were not granted citizenship," he said, adding that Prime Minister Narendra Modi honoured Hindu, Buddhist, Jain and Sikh refugees by granting them citizenship through the CAA. The home ministry statement sought to allay fears of a section of Muslims and students regarding the CAA, making it clear "no Indian citizen would be asked to produce any document to prove his citizenship after this Act."

"Indian Muslims need not worry as CAA has not made any provision to impact their citizenship and has nothing to do with the present 18 crore Indian Muslims, who have equal rights like their Hindu counterparts." The ministry also launched a portal for people eligible to apply for Indian citizenship under the CAA, an official spokesperson said in Delhi.

Alleging that the CAA is against the Constitution, Owaisi said he would challenge it in the Supreme Court. A law cannot be made on the basis of religion and there are many Supreme Court judgments on it, the AIMIM leader added.

"... (it is) against the right to equality. You are giving permission (citizenship) to every religion, you are not giving to those whose religion is Islam," he told reporters.

An application was also filed by the Indian Union Muslim League (IUML) in the Supreme Court seeking a direction to the Centre to stay the CAA's implementation till the pendency of petitions challenging its constitutional validity before the apex court.

West Bengal chief minister Mamata Banerjee claimed that the notified rules were "ambiguous, unconstitutional and discriminatory".

Addressing an official programme at Habra in North 24 Parganas district, Banerjee claimed the CAA was merely a precursor to implementing the National Register of Citizens(NRC) across the country and declared that her pledge to resist implementation of NRC in Bengal was the trigger to opposing the CAA.

"I urge the people to think several times before applying for citizenship under the law. That's because the rules provide no clarity on what happens to the status of existing citizens once they make a fresh application. I apprehend that existing citizens would automatically be first designated as illegal immigrants and then left at the mercy of the committee to grant them citizenship afresh."

The CPI(M) opposed the notification of CAA rules and claimed that it violates the secular principle of the Constitution by linking citizenship to religious identity.

In a statement, the Left party alleged that the implementation of the rules was linked to NRC and raised the apprehension that citizens of Muslim origin would be targeted.

Protests against the implementation of the CAA erupted across Assam with effigies of Modi, Shah and copies of the law being burnt.

Assam Chief Minister Himanta Biswa Sarma said he will be the first to resign even if one person, who has not applied for the NRC in the state, gets citizenship.

"I am a son of Assam and if a single person who has not applied for NRC in the state gets citizenship, I will be the first to resign." Protesters in Assam are claiming that lakhs of people will enter the state after the implementation of the CAA.

Protests against the CAA also erupted in various parts of Kerala, as both the LDF and the UDF organised marches towards Central government institutions to condemn the decision. (PTI)

Assam Police 'order' opposition parties to

notices were served by the police to ensure there is no damage to public property and risk to the lives of the people by any agitation in the state.

Meanwhile, no untoward incident has been reported in the state so far, police said.

Security has been tightened with additional deployment of police personnel. All police stations have been put on alert, patrolling has been intensified and check-posts have been set up on major thoroughfares in most towns of the state, including Guwahati which witnessed violent protests over the issue in December 2019, they said. (PTI)

CAA not to be implemented in tribal

India's golden langur population

golden langurs, SACON's Principal Scientist Dr H N Kumara said. "This method is applied for the first time for golden langur, which is considered to be relatively simple, cost-effective, and robust, especially for arboreal, small group-living primates," Kumara said.

The demographic analysis, however, indicates an unstable situation in fragmented habitats. Despite regular infant recruitment, the percentages of juveniles and immature individuals compared to adults were invariably low in all fragmented habitats, Biswas said.

"The low percentage of infants, compared to juveniles and adults, entails that these populations have a higher rate of mortality in the immature stage, which might be due to some human-induced factors such as road accidents, feral dog attacks, electrocution, or exposure to parasites, among others," he added. (PTI)

SBI submits electoral bonds details to Election Commission

NEW DELHI, March 12: State Bank of India (SBI) on Tuesday evening submitted to the Election Commission the details of the parities that had bought now-scrapped electoral bonds and those who got them, as it complied with the Supreme Court order to furnish information. The Supreme Court on Monday ordered SBI to disclose the details of electoral bonds to the Election Commission by close of business hours on March 12. As per the order, the Election Commission will have to publish the details shared by the bank on its official website by 5 pm on March 15.

"In compliance of the Hon'ble Supreme Court's directions to the SBI, contained in its order dated Feb 15 & March 11, 2024 (in the matter of WPC NO.880 of 2017), data on electoral bonds has been supplied by the State Bank of India to the Election Commission of India, today, March 12, 2024," Election Commission said in a post on X.

According to sources, SBI has complied with the orders of the apex court and submitted the details of the electoral bonds to the Election Commission.

The SBI has issued electoral bonds worth ₹ 16,518 crore in 30 tranches since the inception of the scheme in 2018.

The Supreme Court, however, in a landmark verdict on February 15 scrapped the Centre's electoral bonds scheme that allowed anonymous political funding, calling it "unconstitutional" and ordered disclosure by the EC of donors, the amount donated by them and recipients. SBI had sought time till June 30 for disclosure of the details. Its plea, however, was rejected by the apex court, and it asked the bank to submit all details to the Election Commission by the close of working hours on Tuesday.

Former finance secretary S C Garg in a column said SBI's time-wasting tactic is laughable, saying the bank wanted to match the buyer of each electoral bond with its recipient political party, something which the apex court had not asked for. Such bonds had no serial number or any other identifier, he said, adding, the purchase and deposit processes did not allow the SBI to record any identifier of a specific electoral bond for its purchaser or depositor.

The electoral bonds scheme was introduced on January 2, 2018. Electoral bonds have been pitched as an alternative to cash donations (CONTD. ON PAGE-2)

Anti-CAA protests erupt in state; security beefed up

Effigies of PM, Home Minister burnt ●Oppn forum's 'Sarbatmak Hartal' fails evoke response ●Police issues notice to UOFA

GUWAHATI, March 12: Protests against the implementation of the Citizenship Amendment Act (CAA) erupted across the state on Tuesday with effigies of Prime Minister Narendra Modi, Union home minister Amit Shah and copies of the law being burnt.

The Asom Jatiyatadhi Yuba Chatra Parishad (AJYCP) burnt the effigies of the Prime Minister and the home minister in Lakhimpur, while the Congress also torched copies of the law in different parts of the district to protest against the implementation of the CAA.

Congress workers led by leader of the opposition in Assam assembly, Debabrata Saikia staged a protest in front of its state headquarters Rajiv Bhawan in Guwahati and burnt copies of the Act.

The CPI(M) also held a demonstration against the implementation of the Act here and in Kamrup's Rangia town, while students of different colleges organised protests outside their respective institutions in the city.

In Sivasagar district, activists of Rajiv Dal, Krishak Mukti Sangram Samiti and the Chitra Mukti Parishad and MLA Akhil Gogoi protested against the contentious law and raised slogans against the Centre.

Burning of copies of the CAA by the Congress and AJYCP has also been re-



ported from Barpeta and Nalbari respectively.

The 12-hour 'Sarbatmak Hartal', called by the 16-party United Opposition Forum Assam (UOFA), did not evoke much response.

Shops and business establishments remained closed in a few districts such as Sivasagar, Golaghat, Nagaon and Kamrup.

The Assam police has meanwhile, issued notices to opposition parties, asking them to withdraw the hartal over the implementation of the CAA, and warned that "legal action" will be taken against them if they fail to follow the

Himanta allays CAA fear with NRC reference

GUWAHATI, March 12: Assam chief minister Himanta Biswa Sarma on Tuesday said that he will be the first to resign even if one person, who has not applied for the National Register of Citizens (NRC) in the state, gets citizenship.

His comment comes after protests erupted across Assam with opposition parties flaying the BJP government at the Centre for implementing the contentious Citizenship (Amendment) Act, 2019 (CAA) on Monday, paving the way for granting citizenship to undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan.

"I am a son of Assam and if a single person who has not applied for NRC in the state gets citizenship, I will be the first to resign," the chief minister said on the sidelines of a programme at Sivasagar.

The protesters are claiming that lakhs of people will enter the state after the implementation of the CAA.

"If this happens, I will be the first to protest," he said.

The chief minister asserted that those who have come to India after 2014 will not get citizenship, and the number of such applicants will be "negligible".

"People do not want to identify themselves as foreigners. There may be 50,000-60,000 applications from the three districts of Barak Valley, while it will be negligible in districts of Brahmaputra Valley," he said.

There is nothing new about CAA as it was enacted earlier, the chief minister said, (CONTD. ON PAGE-2)

CAA not meant to snatch anyone's citizenship, assures Amit Shah

HYDERABAD/GUWAHATI, March 12: Union home minister Amit Shah on Tuesday assured minorities that the Citizenship (Amendment) Act is not meant to snatch anyone's citizenship, as he accused the Congress and other opposition parties of spreading misconception about the new law which has sparked protests in Kerala and Assam.

As Shah sought to allay apprehensions on the contentious CAA-2019 and declared that no Indian will lose citizenship due to it, Tamil Nadu chief minister and DMK chief M K Stalin said the CAA was divisive and will not be implemented in his state. On Monday, Stalin's counterpart and CPI-M leader Pinarayi Vijayan said the act will not be put into effect in Kerala.

Stoutly defending CAA-2019 in the face of fresh opposition criticism, Shah accused AIMIM president Asaduddin Owaisi, Congress president Mallikarjun Kharge and party leader Rahul Gandhi of lying that minorities will lose citizenship due to the new law and also indulging in vote-bank politics. The CAA was implemented on Monday after the Modi government notified the rules four years after securing Parliament's approval.

The CAA seeks to grant citizenship for undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan who came to India before December 31, 2014.

The Union home ministry also came out with a press statement to say that Indian Muslims need not worry as the CAA will not impact their citizenship and has nothing to do with the community which enjoys equal rights as their Hindu counterparts.

Odisha's ruling Biju Janata Dal (BJD) supported implementation of CAA.

"The BJD welcomes the CAA as it is giving citizenship to the people and not taking away anyone's rights to live in the country," BJD MLA Parsuram Dhada said.

Addressing a BJP booth workers' meeting in Hyderabad, Shah hit out at those spreading misconception about CAA-2019, saying the law grants citizenship and would not (CONTD. ON PAGE-2)



Assam Police 'order' opposition parties to withdraw stir against CAA

GUWAHATI, March 12: The Assam Police have issued notices to opposition parties "ordering" them to "withdraw" the hartal over the implementation of the Citizenship (Amendment) Act or CAA and warned that "legal action" will be taken against them if they fail to follow the diktat, officials said on Tuesday.

The 16-party United Opposition Forum, Assam (UOFA) has called a statewide hartal to protest against the implementation of the CAA.

"It has come to the notice of the undersigned from the Press Note dated 11th March, 2024 released by 'United Opposition Forum' that you and your organization have called for 'Sarbatmak Hartal' in Assam on 12th March, 2024 from 6 am to 6 pm. Whereas, as a result of the 'Sarbatmak Hartal', there is every likelihood of breach of peace



and security leading to disruption of normal life of peace loving citizens in the state," said the identical legal notices, dated March 11, sent to the office-bearers of different parties.

"Further, calling of such 'Sarbatmak Hartal' will lead to highway and railway track blockade, which has been declared as illegal and unconstitutional by various judgements of Hon'ble Supreme Court of India, Hon'ble Kerala High Court as well as Hon'ble Gauhati High Court," it added.

The notices ordered the parties to withdraw the hartal and co-operate in maintaining peace in the state.

"...failing which legal action will be taken against you in your personal capacity. Further, be known that in case there is any damage to public/private property including Railway and National Highway properties or injury to any citizen caused due to 'Sarbatmak Hartal', legal action under appropriate provisions of law... will be initiated against you and the total cost of damage to public and private properties will be recovered from you and your Organization," it said.

CAA not to be implemented in tribal areas of Northeast

NEW DELHI, March 12: Most tribal areas in northeastern states, including those granted special status under the 6th Schedule of the Constitution, have been kept out of the purview of The Citizenship (Amendment) Act, 2019, which came into effect on Monday.

According to the law, it is also not going to be implemented in those northeastern states where Inner Line Permit (ILP) regime is in existence.

The ILP is in force in Arunachal Pradesh, Nagaland, Mizoram and Manipur whereby anyone from other parts of the country seeking to visit these states needs special permission from the state government. The tribal areas, where autonomous (CONTD. ON PAGE-2)

Cong declares candidates for Assam; Gaurav Gogoi to contest from Jorhat



GUWAHATI, March 12: Deputy leader of Congress in Lok Sabha, Gaurav Gogoi has moved out from his constituency and will contest from Jorhat in Assam during the upcoming Lok Sabha elections, the party said on Tuesday.

Another prominent Congress leader, former Assam minister and sitting MP from Nagaon seat, Pradyut Bordoloi has been nominated to contest from the same constituency.

Out of the 14 Lok Sabha seats in the state, the Congress announced candidates for 12 seats. It has offered one seat to alliance partner Assam Jatiya Parishad, while no decision has been taken yet on the remaining constituency.

Gogoi is a Lok Sabha MP from Kallabor, which has been rechristened as Kaziranga after the delimitation exercise last year.

Now, the Congress has named its deputy leader in Lok Sabha to contest from Jorhat and pitted him against incumbent BJP MP and candidate Topon Kumar Gogoi.

On the other hand, incumbent MP Bordoloi's direct fight will be against his erstwhile confidante Suresh Bora, who was in Congress and joined the BJP around two months back.

Bora was the Nagaon district president of Congress and had unsuccessfully contested Assembly polls thrice from Barhampur.

In the high-profile Guwahati constituency, the Congress has named Assam Pradesh Mahila Congress (APMC) president Mira Barthakur Goswami, a first-timer.

She is likely to have a direct contest with BJP's new face Bijuli Kalita Medhi, who is a vice president of Assam BJP and the former president of the party's women wing in the state.

This will be the first election after the Election Commission of India carried out the delimitation exercise only for Assam last year, which was strongly criticised by the opposition parties alleging that it was done to help the ruling BJP only. (CONTD. ON PAGE-2)

Survey conducted in various habitats covering Manas Biosphere Reserve, fragmented forests of north-western Assam

India's golden langur population increases to 7,396, says survey



GUWAHATI, March 12: The population of endangered golden langur in India has increased to 7,396 from a previous estimation of 6,000, according to a recent survey.

The survey was conducted in various habitats of the animal, covering the Manas Biosphere Reserve and all fragmented forests of north-western Assam.

The survey was jointly conducted by the Primate Research Centre NE India (PRCNE), the forest department, the Bodoland Territorial Council, the Salim Ali Centre for Ornithology and Natural History (SACON) and the Conservation Himalayas in two phases.

"The team observed 7,720 golden langurs in 706 unique groups and 31 lone males or floating males," Senior Scientist of Primate Research Centre NE India Dr Jihosuo Biswas said.

"With estimating minimum population size, we found 7,396 golden langurs in 707 groups, inclusive of bisexual and male bands, along with 31 lone males," he said.

The 2008-09 estimation showed that there were 6,000 golden langurs in India, while the current head-count exercise suggested an increase in the population size but the satellite imagery shows shrinkage of forest cover which negatively impacts their habitats, Biswas pointed out.

There are two major sub-populations - the northern extended population, which encompasses the western part of the Manas Biosphere Reserve and the southern fragmented population, which occurs along the southern side of the national highway-27 up to the Brahmaputra river in the south, he said.

The northern population of golden langurs in Manas Biosphere Reserve is estimated to be 5,566 in 534 groups and 23 lone males, while the same in southern fragments is estimated to be 1,830 langurs in 173 groups and 8 lone males, he said.

"The major population of golden langurs in the Manas Biosphere Reserve was found in Ripu reserve forest, and the number was 2,847, followed by Chirang reserve forest with 2,000 animals, and Manas National Park with 719," he said.

Similarly, in the southern fragments, the major populations were found in Chakrashila Wildlife Sanctuary of Kokrajhar district with 838 golden langurs, and Kakoijana reserve forest of Bongaigaon district with 464, Biswas said.

Additionally, the group size was found to be larger with an average of 10.69 per group as compared to 9.24 per group in the previous estimation.

In the first phase, the survey covered the western part of the Manas Biosphere Reserve, including Ripu Reserved Forest, while the second phase focused on fragmented forest habitats of golden langurs in Bongaigaon, Kokrajhar, and Dhubri districts of Assam.

The survey applied the occupancy framework of the block count method to assess the abundance, spatial distribution and densities of (CONTD. ON PAGE-2)

Meghalaya police busts sleeper cell of HNLC, arrest 4

SHILLONG, March 12: Meghalaya police on Tuesday claimed to have busted a sleeper cell of the outlawed Hynniewtrep National Liberation Council (HNLC) by arresting four persons in Ri-Bhoi district.

The police also seized an IED from their possession.

Police suspect that the four persons were involved in planting and detonating an IED at the disputed Punjabi Lane area of the city on March 9 in which one person was injured.

Ri-Bhoi district SP Jagpal Dhanoa Singh told PTI "Meghalaya police was able to foil the bid of proscribed Hynniewtrep National Liberation Council (HNLC) to explode another IED after the arrest of the four persons in Ri-Bhoi district".

The arrest was made on Monday at around 6 pm when a live IED packed with shrapnels and gelatin sticks was found inside a pickup truck driven by Damanbha Ripnar.

Ripnar was detained at the Umsning-Mawhati road and on his voluntary leading, one IED was recovered from his vehicle by the Bomb Detection and Disposal Squad (BDDS), (CONTD. ON PAGE-2)

CAA impact on Bengal politics

Welcome to the era of "image-time," where our existence is immersed in a visual narrative. Images inundate our lives through diverse channels of orality, cultivated perceptions, electronic and print media, and the expansive realm of social media platforms. We not only consume these images but also engage in their recreation and distribution among our peers. The younger generation in India, devoting a significant amount of time to the vast media landscape, becomes avid consumers of these visual narratives, distinguishing them from their older counterparts.

In the realm of images, a dichotomy exists between those with fleeting moments and those with enduring legacies. Images endowed with longevity often undergo a metamorphosis, evolving into symbols through a continuous process of additions, deletions, and modifications. These symbols, born from the amalgamation and remixing of diverse images portraying leaders, social icons, and political figures, possess the remarkable ability to persist even beyond an individual's lifetime. Consider the indelible impressions left by leaders such as Mahatma Gandhi, Nehru, Ram Manohar Lohia, and Indira Gandhi, etched in the collective memories of the populace, particularly the youth, who, despite not directly experiencing these leaders and their eras, carry their images forward. However, the images or symbols of leaders no longer among us are less susceptible to drastic shifts, whether positive or negative. The political actions of leaders actively shape the resources of their image, paving the way for significant transformations. In contrast, a living leader seizes the opportunity to wield considerable influence over their own image through ongoing political endeavors, allowing for sweeping changes in perception.

Exploring the visual inclinations of the youth in the district towns of Uttar Pradesh involved engaging in interviews with middle-class individuals. These young minds, predominantly enrolled in colleges or engaged in preparations for diverse competitive exams, offered us valuable insights. Our interviewees, representing various castes in these district towns, collectively showcased a profound reliance on images and political symbols as beacons of hope during their arduous journey towards employment. The future emerged as a paramount theme in our discussions, resonating as the focal point in the minds of these youths. Beyond personal aspirations and concerns, their contemplations extended to encompass the future trajectory of both society and the nation.



Research indicates that the advent of the neo-liberal economy has induced inertia and uncertainties among the youth. During this phase of stagnation, they lose their bearings for personal growth. Notably, such trends were discernible in the initial stages of the neo-liberal era, primarily evidenced in studies conducted before 2010 in India. However, in the current epoch—what I refer to as the 'second (matured) phase of the neo-liberal era in India'—a noteworthy transformation has unfolded in the mindset of the youth, marking a shift from inertia to aspirations. The fervent desire for success is rapidly taking root in provincial India, spurred by two key factors. Firstly, there is an explosion of information regarding diverse livelihood opportunities, success stories, and entrepreneurial narratives conveyed through various media forms. Secondly, the youth are driven to explore, comprehend, and share inspiring symbols of socio-political icons, delivered either through traditional narratives or the evolving narratives crafted by diverse media channels.

The concept of "kam-dhandha" is emerging as a beacon of hope among them. Many express the sentiment that if traditional employment opportunities

('Naukri') elude them, they are determined to embark on entrepreneurial pursuits like starting their own business or exploring online platforms such as YouTube channels. In this phase, often labeled as a 'time-pass period' by Craig Jeffrey in his book "Time pass: Youth, class, and the politics of waiting in India," I've observed that images play a pivotal role. They not only assist in garnering inspiration but also fortify the 'aspirations bhava,' fostering determination to achieve their goals.

Amidst the diverse imagery shaping the minds of the youth in provincial India, political images stand out as potent cultivators of inspiration and hope.

The manner in which these young individuals engage with images is intriguing. Our observations in the small district towns of provincial India revealed a distinctive pattern in how they consume political icons' images. Drawing from their knowledge, perceptions, and available information, these youths craft specific typologies or condensed narrative capsules for easy recollection and reference. For instance, figures like Gandhi are encapsulated as 'Mahatma' and 'Rashtra pita,' Nehru assumes the roles of the first Prime Minister of India and a nation builder, while Indira Gandhi is envisioned as the

daughter of Nehru and a formidable woman Prime Minister.

During interviews in various district towns of Uttar Pradesh, particularly in the eastern region, a multitude of images pertaining to Narendra Modi, the Prime Minister of India, emerged. Descriptions portrayed him as a robust and decisive leader, committed to eradicating corruption and dedicated to fostering development—a narrative that has persisted over the years.

During recent field explorations in several district towns, a noteworthy trend came to light as diverse positive images of Narendra Modi, the Prime Minister of India, coalesced into a symbolic amalgamation referred to as 'Yug Purusha' in the minds of certain youths. Intrigued by this classification, I delved deeper into the reasoning behind this symbolic encapsulation. While some youths found it challenging to articulate the reasons, others, particularly from upper castes and other backward castes, offered insights. According to them, Modi is perceived as diligently working towards a developed India, shaping the future trajectory of the nation with a visionary outlook. They highlighted his role in the construction of the Ram Janam Bhoomi temple as a testament to his commitment and contributions.

The emergence of the 'Yug Purusha' image intertwined with Narendra Modi's persona along a segment of provincial youth poses a challenge in pinpointing its exact origin. However, our observations indicate a significant shift in Modi's image, particularly among youths in district towns, following the Ram Janam Bhoomi Pran Pratishtha Samaroh. The event marked a pivotal moment, triggering a substantial transformation in the perception and portrayal of Prime Minister Narendra Modi within the provincial youth demographic.

Indeed, these images serve as potent symbols of trust and hope, resonating within the imaginations of those who embrace them. The 'Yug Purusha' emblem, forged through the political and administrative initiatives spearheaded by Prime Minister Narendra Modi over the past decade, transcends mere political connotations. These images carry with them a representation of a leader actively engaged in reshaping the socio-cultural and economic fabric of public life. As the 2024 parliamentary elections approach, it is conceivable that these symbols will wield political influence, leaving an indelible mark on the electoral landscape of Indian democracy and prompting nuanced political analyses. Being baptised in political delinquency and insensitivity Saffrons will project Sandeshkhali nationally to discredit INDIA bloc

When political rivalries convert college campuses into hotspots of crime and criminal behavior, education takes a back seat. There has always been an epidemic of crime spreading exponentially in college campuses across the state of Kerala and I personally could witness many. It was on 17 September 1996, the state witnessed one of the most heart-wrenching campus brutalities carried out by a mainstream political party. In an attempt to silence political rivalry, three young boys from the BJP's students wing ABVP were brutally chased and killed by students from the same college and goons from outside the campus that belonged to the left parties. This heinous incident of abrupt brutality had taken place in the Devaswom Board College in Parumala. When being chased and tortured by a violent mob from the Students Federation of India (SFI), the students' wing of the CPI (M), the three jumped into River Pampa. The idea was to swim across the river and escape. But the barbarous goons began to pelt stones from the riverbed critically injuring the boys in water and they had drowned. The local women who were busy washing clothes tried to rope out the hapless boys with their clothes. But they were chased away by the wanton brutes and all the three died in the river.

Campus politics has always been a parallel track played in tune with the dictums of parties that ruled the state. Most of the students gain merit for representing the ruling party and they are given a free hand by the police when chaotic skirmishes take place. There have been plenty of instances in which lives have been lost and many students have become victims of political insanity. The Kannur district of the state deserves a special reference here as it remained the most acrimonious landscape for the state politics where rivalries between the BJP and CPI (M) destroyed a number of families. Both parties have had consistent efforts to steer their presence in this district which is in the Malabar region. Situation became turbulent when the traditional stronghold of the CPI (M) had shattering faced a systematic ideological invasion from the BJP and the Sangh Parivar. This had absolutely been leading the entire region to break into a huge political turmoil that gained notoriety for decades. Hundreds of party workers got butchered by the violence unleashed by the parties. Many people died and many families perished.

This narration was necessary here to

elaborate the quantum of political acrimony prevailed among parties in the state. But the present scenario turned this traditional enmity and acrimony more inhuman. Campuses are no more centers of learning. Across the state they have now been turning into breeding grounds of goons. With the uninterrupted supply of drugs and being baptized in ruthless political indoctrination, a huge number of students have gone directionless. Kerala's universities have long been witness to violence and spine chilling horror of student politics. With the latest brutality of political indoctrination, the foot soldiers of Students Federation of India (SFI) have managed to kill J S Sidharthan, a 20 year old second-year student of veterinary college, Pookot, Wayanad, under the Kerala University. The punishment executed on the young boy by the brutal gang was beyond comparison and narration. It is reported that he was stripped naked and beaten up with belts and cable wires by his classmates and seniors in front of other students. His close friends were threatened and forced to beat him up when the show of cruelty was performed in broad daylight. The probe found the involvement of almost 31 students. This heartbreaking trial-cum-torture continued for almost three days leading the boy to commit suicide. His body was later found hanging lifeless in the hostel.

Governor Arif Mohammed Khan has suspended the Vice-Chancellor of the university ordering a judicial enquiry. Now, there is a crucial question that began to distressingly prick the conscience of the people of the state. That why was the entire population of students and staff in the hostel silent on the inhuman torture of the boy? Why was the management of the college tight-lipped on violence inside its premises? This insensitivity indicates the depth of fear on this horribly rampant criminality that has been controlling the campus; it also finger-points at the failure of the education system. Evidently, the ruling class has been applying its political power to cripple the system with its notorious interference and the administration in universities and colleges have silently been forced to remain servile to their political masters. There has been a huge wave of violence infiltrating into the campuses with political groups and radicalized religious groups getting consistently active among students.

Should this incident be seen as a usual occurrence of ragging breaking all extremes of brutality or was there a terrible mindset emanating from the vacuum of organizations that the Gov-

ernment of India has recently banned? Could they successfully stretch their ugly claws into colleges and universities by systematically intruding into political parties? What was the real intent of the crime that the goons perpetrated on a hapless boy? Was this criminal justice system executed by the students motivated by the brutal depiction of cruelty being carried out by the Taliban or other outfits working in countries where the atmosphere is warm and fertile for barbarity? Violent means of murders in the state, especially among the youth, should have shaken the society long before, but there seems a lack of urgency and lethargy again and again dominating its value system. Trimming the aspirations of a state that once remained an excellent hub for quality education, its political system has certainly pushed it through the tunnel of hatred and inhuman retribution.

Schools and colleges have lost their lessons of empathy and the value system that we cherished once got deeply dispelled. The state of Kerala has lost its sheen of being one of the most empathetic societies. Often being applauded for its socio-political awareness and excellent performance in various socio-economic indices, Kerala has maintained its status of being a good example for the rest of the country. But its terrible failure and inability to understand the need of maintaining values that would nurture its existence as a society is a reality. Irrespective of it being a society with good living standards, the state has grown into an insensitive terrain for moral values. With bigoted cries for free speech and scientific thinking being heard louder; the campuses in the state have lost the essence of a learning atmosphere well knit with compassion, tolerance and mutual acceptance.

Narendra Modi was absolutely right in saying that the Sandeshkhali "storm" would sweep across Bengal and ensure an end to the Trinamool Congress's "rule of terror". His confidence emanates from the apparition of the RSS polarising the Bengali society attaining a tangible shape.

Ever since Modi came to power, RSS has been using the state machinery and even his office and services to expand its support base in the eastern state, but it did not succeed so far. Probably the people, especially the women of Bengal, must not have forgotten the manner in which Modi jeered at Bengali women's dignity when he jibed 'Didi, O Didi' at Mamata Banerjee. Unfortunately for Modi, in spite of resorting to all kind of gimmicks, RSS and Modi could not expand.

But their tenacity must be appreciated. Finally, they appear to have succeeded in their mission. For Modi and his saffron ecosystem, Sandeshkhali has come as gift of the gab. At the same time, he could make inroad in the TMC support base and succeed in enticing other TMC leaders to cross over. Actually, this has been happening.

Strategically, the RSS and BJP have presented these turncoats as the vanguard of the Hindutva politics. It is worth recalling that initially the BJP had managed to entice a strong non-Bengali TMC leader, Arjun Singh, into its fold. But soon he realised the wicked game of the RSS and BJP and he returned to his old party.

Mamata Banerjee's arrogance and her opting for wrong priorities have been primarily responsible for erosion of her image as well as the adverse situation she is faced with today. She once symbolised the aspiration of the secular forces. They came to believe her. But as was witnessed in the past, instead of strengthening the secular forces, she relied more on muscle power and manipulative politics.

She preferred not to take lessons from the past mistakes of the political system and institution of the state. The allegations simply underline that they have been resorting to such criminal activities for long and certainly have not resorted to such only during the last one month. The women even alleged land grabbing by them. What is noteworthy that only two complains of sexual harassment were registered with the legal authorities which visited the area.

Had it been a regular affair, why the women threw their support behind Shahjahan when ED raided his house? Does it imply that the lean period of a month bolstered the women of region to muster courage and speak the truth. If it is the case, it obviously puts Mamata in dock. It implies that she has left the state to be ruled by her partymen. This has precisely been the allegation of the RSS and Modi.

One thing is absolutely clear that RSS used this one month period to mobilise its women force and inspire them to speak out against Mamata. She had used Nandigram against CPI(M) and BJP, working on the same political line, is contemplating the use of Sandeshkhali against her.

That the saffron ecosystem will make it a state issue is evident from Modi's recent speech: "The women of Bengal and also the entire country are angry with what happened to the mothers and sisters of Sandeshkhali. The anger of Nari Shakti (power of women) will not be confined to

Sandeshkhali." Modi who was unmoved at the mass-scale rape and tortures on women in Manipur is quite shaken at what happened in Sandeshkhali. No heads rolled in the wake of Manipur atrocities of women's there, but according to him, "Anyone will hang his or her head in shame after knowing what happened to the mothers and sisters of Sandeshkhali. Sampurna Bangla te Sandeshkhali-r-jhawar utthe (The storm blowing over Sandeshkhali will sweep across Bengal)".

Modi's repeated stress on the plight of "the mothers and sisters" of Sandeshkhali during a rally in Barasat made it clear that the BJP was banking heavily on the allegations of atrocities to defeat Trinamool in the Lok Sabha polls in Bengal. The saffron design to malign Mamata and her government, just ahead of Lok Sabha election, is perceptible in the fact that his address was broadcast live at 19,000 places across the country. The programme in Barasat marked the conclusion of the BJP Mahila Morcha's three-day-long Shakti Vandan Karyakram to promote women's empowerment.

Modi's concern and sympathy for Sandeshkhali women was oozing like honey: "The women here (in Bengal) have shaped the country's direction, figures like Maa Sarada, Rani Rashmoni, Matangini Hazra... However, on this land, Trinamool has committed a grave sin against women. They have committed heinous crimes against mothers and sisters. I can see that the women of Bengal will put an end to the TMC's mafia raj." He felt ebullience at Supreme Court refusal to accede to TMC request to have the trial of Shahjahan in state. He said, "While the oppressed mothers and sisters are fighting for justice, the Trinamool government is using its power to protect the perpetrators who committed crimes against women. But it received a rap, first from the high court and then from the Supreme Court."

The BJP will use Sandeshkhali for electoral gain was revealed by a senior BJP leader by saying: "Modiji has made it clear that the party would take on Trinamool over its anti-women face in Sandeshkhali. We have already chalked out programmes in Sandeshkhali to keep the issue alive and spread the protest across Bengal."

The Left parties nevertheless ought to not forget that maintaining silence on the devious designs of the saffron ecosystem they were handing over the state on the platter to the rightist and fascist forces. Undeniably, the latest creations straightway fingers at the failures of Mamata and her criminalising the politics, but once RSS comes to control the fulcrum of the state politics and governance, the saffron mercenaries will dictate and ruin the lives of the common people. A 19th-century Indian queen's photographic work has been obscured by history

In the May 1890 edition of the Photographic Society of India's journal, a letter by Radharaman Ghosh, secretary to the Maharaja of Tripura, made a remarkable claim. Titled "The Camera Club of the Palace of Agartala" and likely dictated by the maharaja himself, the letter contained commentary on the photographs that had been dispatched to the journal. It stated that some pictures were taken by Maharaja Bir Chandra Manikya and others by his wife, Maharani Manmohini. Calling attention to this information in his significant 1988 book *Chobi Tola: Bangalir Photography Chorchha*, writer Siddhartha Ghosh says that Manmohini "had printed most of those; the Maharaja had developed others. Each image was marked in a particular way to indicate the photographer". This would make the maharani among the first women from India known to create photographic images.

Who was she? What do we know about her images? And what can we make of them today?

Before delving into these questions, it is helpful to briefly survey the broader landscape within which to locate and read the little known about her. By the end of the 19th century, women had been making lens-based pictures for about 50 years. In India too, by the mid-1800s, several European women had begun to either work at established studios or set up their own urban practice focussing on only women, as professional zenana photographers who could access and photograph their subjects behind purdahs. Ghosh's book furnishes many of these names, such as Mrs E Mayer, Mrs Kenny-Levick and Bibi Wince. But while the work of European and North American women has been identified, both in their homelands as well as in colonies, it has been harder to trace the practices of women belonging to the occupied territories. Manmohini seems to be the first Indian woman credited with taking photographs, but it is her bhadramahila contemporary Sarojini Ghosh who is recognised as the first Indian woman professional photographer. One 1899 article extolled Sarojini Ghosh's Mahila Art Studio and Photographic Store in Calcutta thus: "Bromide enlargements, platinotypes, photographs on silk, etc. are executed in effective style and at moderate rates."

Clearly, by the last decade of the 19th century, the practice of photography was within the reach of elite women who were unencumbered by the veil, as the maharani consort of Tripura seems to have been. Along another axis of social location, Manmohini is among a small group of Indian aristocrats who operated the camera – her husband and probable teacher Maharaja Bir Chandra Bikram Manikya, of course, but also their compeer Sawai Ram Singh II of Jaipur and, many decades later, Rajmata Rajendra Kunverba of Kutch. Among these, Ram Singh's oeuvre of thousands of glass plate negatives is the best preserved. Rajendra Kunverba's archive has been entirely lost. The Manikya couple's work seems to be sparsely available in the public domain, though what has surfaced is arguably glamorous and relatable to contemporary publics – a few years ago, a photograph that the pair took of themselves in an almost anachronistically intimate pose emerged online, widely reported on and dubbed the first Indian selfie.

Taken using what Bir Chandra's great-great-grandson Vivek Dev Burman terms "a long wire shutter control" activated via a pneumatic bulb in the king's hand as the couple sat facing their camera, the Manikyay's self-portrait suggests a close and affectionate partnership. While it is impossible to comment on their marital dynamics, it does appear from the scant accounts available that they collaborated in the studio and dark room, with the young maharani learning the craft and chemistry from her husband. In her essay titled "Matrimonial Alliances between the Royal Houses of Tripura and Manipur in the Days of the Monarchy", historian Memchaton Singha tells us more about the queen and her conjugal family. A Manipuri Meitei princess, Khuman Chanu Manmohini was the third wife of Bir Chandra, marrying him at 13, when he was 50. Notwithstanding his acceptance of premodern norms governing marriage, Bir Chandra is regarded as a modernising ruler, to whom is attributed the founding of the Agartala Municipality in 1871 and the promotion of Western-style education and culture. His pioneering interest in photography – evinced by his ownership of one of the first two cameras in India (the other being Lala Deen Dayal's) – might be considered an example of his bent towards new ideas and technology.

Gendered codes

A member of the Royal Photographic Society till his death and founder of the Camera Club of the Palace of Agartala, Bir Chandra composed portraits of his family

members, courtiers and friends such as the Tagores. Some of his platinum palladium prints were part of a 2019 exhibition titled *The Tripura Project* curated at the Mangalbag Gallery, Ahmedabad – by Tilla, a design studio founded by Aratrik Dev Varman, one of the king's descendants – including another "selfie" with his first wife Bhanumati Devi. While Bhanumati does not seem to have progressed from posing to composing, Bir Chandra's passion for photography did influence his third wife. Ghosh writes, "The Maharaja himself was an expert photographer and a keen enthusiast for the dissemination of photography. It was under his tutelage that Manmohini learned photography and soon excelled in it. She not only took photos but also developed them herself."

Since Manmohini was trained by and probably worked somewhat subordinate to Bir Chandra, the issue of identifying which images might have been hers becomes complicated. It is unclear whether any of the labelled photographs referenced by Radharaman Ghosh seem to have survived. Another of Bir Chandra's direct descendants, MK Pragna Deb Burman, who is the state convenor of INTACH Tripura, is able to unearth from her family archive a single photograph that she thinks was almost certainly taken by the queen – a somewhat candid snapshot of a group of children in what looks like a garden's arbour inside the palace compound. Analysing compositional choices in terms of the gendered visual codes of the time, Deb Burman said, "This photo of the children is quite domestic in contrast to the more formal portraits of them by the king. It seems to me there was an attempt to take a series of photos." She is of the view that the informal intimacy between the royal women and children would have lent itself to more spontaneous photoshoots.

Since no details survive of the queen's practice, it might be best to look at the infrastructure installed by the king to get a sense of the context in which she might have produced this photograph. Drawing on contemporaneous descriptions, Ghosh tells us that the maharaja came to photography through oil painting, developed a laboratory in which he appointed assistants from his court staff, sourced "printing machines of colotype and photogravure for his state press in Agartala" and arranged for full-tone reproductions of photographs – at the time a cutting-edge technology – for a genealogy of the Tripura royal dynasty. In an essay titled "Our Native Princes as Amateur Photographers: Independent Tipperah" in the journal of the Photographic Society of India, the author shares: "Through all the stages of wet and dry collodion plates, he had attained great success considering the challenges with which he had to work. With the introduction of gelatin dry plates, many of these difficulties disappeared, and this enabled His Highness to carry on his photographic work on a most extensive scale."

Elaborating on these advancements at Bir Chandra's court, Pragna Deb Burman said, "Photographic material imported from England was unsuitable for their local climate, so the maharaja and maharani had to develop their own material that would last in that weather." Given the dominance of the king's knowledge, practice and images, substantiated by numerous reports, as well as the absence of pictures that can be definitively attributed to the queen, the exact nature of Manmohini's work is cast into doubt. She may have been the first recorded Indian woman to operate a camera, but does that quite make her a practitioner? Speaking to the photograph of children which Pragna Deb Burman considers a likely candidate for being a Manmohini original, her relative Vivek Dev Burman disagrees, basing his reasoning on the fact that she would have been unlikely to shoot outdoors or take up the cumbersome, physically demanding and technically unpredictable process of producing glass plate stereo negatives such as these. Besides, he argued, "no mother would take a picture of her children dressed so badly." He offers up another photograph with a stronger claim to being Manmohini's – a formal one of her daughters – pointing out that they are old enough for the queen to have become practised at such compositions, with the clothes and jewellery further possible proof of her directing the shoot.

However, in our email exchange, Vivek Dev Burman expresses scepticism about using the term photographer at all to describe her: "I am unsure if she was actually a photographer as we know it. More an assistant and part of the many that collaborated to make pictures. I am sure she did the styling and arranged or chose props for the shoots of her children, initially influenced by British photo magazines and later, as she gained confidence, using indigenous materials and styles. She is likely to have helped with the printing more easily... we must remember

she got married as a teenager and came from a village background." It is on the distinction between mechanical activation of a device and conscious creative decision-making that the matter of Manmohini's claim to a specific vision rests. Vivek Dev Burman conceded, "She probably picked up some knowledge about the practical side of photography. As almost all the pictures are portraits and taken in a studio set up in the palace, there was only some variation in the backgrounds used and props, making it easier to follow instructions on how to shoot. But using those old wooden cameras was anything but easy. She may have even opened and closed the shutter following instructions, depending on the lighting conditions. If that makes her a photographer then I guess she was."

While this may not be the case in this instance, it is hard not to keep in mind the historical erasure of the contributions of women to work produced by the men in their lives. Even accepting that she was an assistant, one might argue that her involvement in the production of these pictures – the art direction and printing process – is of interest as artistic and operational labour that forms an integral part of the image-making process. Manmohini's very presence in the studio and the dark room, assisting her husband alongside his male court staff, affords a chance to rethink historiographies of labour in lens-based practices. (Think of Saraswati Bai Phalke's involvement in her husband DG Phalke's film productions, holding bed linen as light reflectors, mixing film chemicals and punching holes in raw film reels.)

Contextualising this debate within the "non-standardised" systems of practice at the time, photographic historian Ranu Roychoudhuri said, "First, the larger question is, who could assert their singular creative ownership of the image in the 19th century – be called a photographer – when a complex and multipart process like photography is in question?... The darkroom work was not merely 'operational labour' but a crucial part of the 'creative labour' in the 19th century." Reflecting specifically on Manmohini's work, Roychoudhuri is of the opinion that while no evidence remains of the nature of her darkroom experimentations, "she was certainly Bir Chandra's active 'partner in the process.'"

Visual representations

At least as an image of companionate matrimony, this partnership has been documented. Apart from her asterisked work behind the camera, Manmohini's appearance in relative dishabille in the photographs themselves – which she may have actively participated in framing – troubles the paradigm of purdah portraiture prevailing in late colonial India. Compared to, for example, Ram Singh II's series of zenana portraits 20 years prior (entirely mediated – as scholar Laura Weisstein demonstrates – through his sovereign masculinity legitimising the purdah as compatible with colonial modernity), or even the commanding studio picture of Sultan Shah Jahan, Begum of Bhopal, Manmohini's act of self-representation is a break from the patriarchal scope of depicting aristocratic women's bodies on camera. She is a lover as much as a wife, her left hand draped over her husband's shoulder, her right one resting on his belly in a proprietary hold, the arm's suggestive curve drawing the eye to the bulb in the maharaja's left hand, as though part of the same line of activation. This power pose becomes more pronounced when contrasted with Bir Chandra's selfie with his first wife, Bhanumati Devi, whom he envelops in his kingly embrace, his hand encompassing hers in a gesture of possessive control. The casual ease with which Manmohini (already unencumbered by the purdah system as a northeastern Indian woman) makes herself available to her own gaze, via a dispositif that is no mystery to her, and allows her to refute the zenana portrait's tension between invisibility and visibility.

Placing the self-portrait within the wider frame of photographic representations of women during this era, Roychoudhuri considers the circumstances of their availability: "The images of elite women were never meant for public display and were only to be circulated within a niche group in the family. The fact that we now have access to these restricted photographs owes itself to how studies of early photography have developed over the years, especially with the scholarly interest in photographs of women and families."

The labelled photographs of Maharani Manmohini dispatched to the journal of the Photographic Society of India may never be recovered. Whether or not she qualified as what we would call a photographer today might remain contentious also. However, paying attention to what can be known about and seen in her images – as both maker and model – inaugurates new possibilities of thinking about feminist histories of photographic labour and the gaze in South Asia. Home remedies for longer, thicker eyelashes naturally

Eyelashes protect the eyes from light debris. They also act like sensors that warn the eyes of potential danger when objects come close. In fact, more attention is being paid to eye make-up, especially during this Covid crisis. Masks are mandatory, while eyes are visible. This has increased the importance of protecting the beauty of our eyes and eyelashes. Leaving mascara, eyeliner and eye shadow on right through the night can affect the beauty of the lashes. In fact, it can lead to infection of the lashes and eyes.

At night, use a cleansing gel and cotton wool to remove eye make-up gently. For upper lashes, put a cleanser on cotton wool and wrap it around your index finger. Brush through the lashes from underneath. To remove mascara from the lower lashes, use a cotton bud with a little cleanser on it. To remove kajal from the lower lashes use a cotton bud that has a little cleanser on it. Also, clean the corners of the eyes with a cotton bud. Use very gentle movements on the lashes.

Brush your lashes with an eyelash brush, so that they are not entangled. Heavy eye make-up, too much mascara and even eyelash extensions can damage and lead to loss of lashes.

If you have very thin or sparse eyelashes, it may become a problem and you may wonder how to encourage their growth. You can apply very little oil on the eyelashes, using a cotton bud. You may apply almond oil, coconut oil, or



olive oil. Leave it on for 15 to 20 minutes and wipe off very gently with moist cotton wool. Do not go to sleep with oil on the eyelashes, as this can lead to puffy eyes.

Curry leaves are also said to help. Keep curry leaves in hot water and leave it to cool. Then make a paste of the curry leaves and apply to the lashes, again using a cotton bud. Apply very little and wash off with water after 15 minutes.

You can also apply aloe vera gel. You can take the gel from the aloe vera growing in your house. The gel obtained from the plant itself is the leaf pulp and is found in the inner portion of the leaves. First, wash the leaf well and observe total hygiene while extracting the gel. Apply a small amount of aloe vera gel on the eyelashes before bed and wash it off in the morning.

Castor oil: Apply a small amount of castor oil on the eyelashes each night before bed and wash it off in the morning.

Eyelid massage: Gently massage eyelids along the lash line.

Nowadays new eyelash serum is available, to help enhance the growth of

natural eyelashes. It also improves the health and texture of sparse and brittle lashes. In serum form, it is easy to apply and includes a brush applicator. Follow the directions on the label.

Mascara adds glamour and thickness to the eyelashes. But, mascara must be removed at night, along with the rest of your eye make-up. Roll-on mascara is easy to apply. You can apply the mascara both above and below the upper lashes. This gives a thicker look. Apply on the lower lashes too. Wait for a while and apply a second coat. Then brush out the lashes, with a small eyelash brush, otherwise, the lashes will stick together. The idea is to achieve a natural effect. You can apply a little powder on the eyelashes between two coats of mascara, to make them look thicker.

The latest in eye glamour is eyelash extensions. They are attached to natural eyelashes, one by one to make the lashes look thicker. A trained beautician has to attach them. It's up to you to decide how thick you want your lashes to be. The eyelash extensions may last for about 3 weeks to a month and then you will have to get them done again. Basically, the eyelash extensions are synthetic strands that are specially curved to look like natural eyelashes. If you apply mascara on eyelash extensions, use the water-based kind.

Medical myths: Endometriosis facts vs. fiction

Endometriosis is a chronic condition in which tissue similar to that usually lining the inside of the uterus grows outside the womb. This condition can cause pain during periods, sexual intercourse, and urination or bowel movements. It can also be responsible for other symptoms, including nausea, fatigue, and mental health concerns.

Sometimes, depending on the tissue's location, it can cause problems with fertility. Moreover, endometriosis can occur in or around other organs, including the lungs.

Worldwide, approximately 10% of females of reproductive age have endometriosis. Although extremely rare, endometriosis in males can occur. Furthermore, because endometriosis symptoms are so varied, people with the condition often experience a delay in diagnosis.

Risk factors for endometriosis include having a mother, sibling, or daughter with the condition, having periods that began before age 11, or having periods that are heavy or last longer than 7 days. Having a history of short monthly cycles of fewer than 27 days can also increase the risk of endometriosis in some individuals.

Confirming an endometriosis diagnosis often involves laparoscopic surgery, a common surgical procedure done under anesthesia. Once a doctor confirms a diagnosis, treatments include managing the symptoms with hormone therapy or pain relief medication. If the pain associated with endometriosis is severe or if fertility has become affected, surgery is an option. However, there is currently no known cure for the condition. Despite these known facts, many myths surround endometriosis, leaving many people confused about what to believe.

To help separate fact from fiction, we talked with Dr. Barbara Stegmann, clinical lead, Woman's Health at Organon and OB-GYN, and Carly King, N.D., licensed naturopathic doctor at Entrepreneur and The Health Centre Integrative Therapies. We also looked at recent peer-reviewed research to reveal the science-backed truths about endometriosis.

1. Periods are normally very heavy, very painful, or both

Although estimates suggest that more than half of all menstruating females experience some pain during periods, severe pain can sometimes indicate the presence of endometriosis.

Dr. King told Medical News Today: "Periods can be heavy and painful with endometriosis, but it's not always the case. Pain can show up in other areas, such as with bowel pain, urinary pain, ovulation pain, as well as pain in other areas of the body. Pe-

riod bleeds can vary in volume — cycle lengths can also vary, with midcycle bleeding a potential symptom as well."

Dr. Stegmann added:

"Periods are normally very heavy/very painful — this is only a partial myth. Some people do have very heavy, very painful periods, but that is only one end of the spectrum. Some have mild cramps and light periods, and some have pain between periods. So, it is best to speak to [a healthcare professional] if you have concerns."

2. Pregnancy can cure endometriosis

"Pregnancy does not cure endometriosis," Dr. King told MNT. "Some women see improvements in symptoms during pregnancy, although others do not, and still others may see a worsening of symptoms," she added.

Dr. Stegmann also emphasized that "[t]here are no cures for endometriosis." Still, she explained that pregnancy does cause hormone levels to change. This variation in hormones may result in people experiencing different pain levels after having a baby. Research also suggests that pregnancy does not seem to offer benefits for women with endometriosis. In addition, scientists note that although some endometriosis lesions show regression, others remain stable or increase.

3. A hysterectomy can cure endometriosis

According to one study involving 137 female participants with endometriosis who underwent a hysterectomy, 84% of the participants were satisfied with the results after surgery. However, while "[a] hysterectomy can relieve symptoms of endometriosis for many people, [...] the condition can recur after the surgery," Dr. King noted.

"Symptoms can also continue if there are endometrial lesions still present outside of the uterus," she added.

"Endometriosis responds to estrogen, which is made by the ovaries. A hysterectomy typically removes the uterus versus the ovaries and therefore wouldn't cure endometriosis," Dr. Stegmann further explained.

"There are different types of endometriosis, from lesions that are just on the surface to those that invade into the bowel and other organs. That type is called deep infiltrating endometriosis, or DIE. Those lesions will likely not improve even if you have your ovaries removed or your hormones suppressed," she continued.

4. Endometriosis only affects the female reproductive organs

"Endometriosis lesions are most commonly found in the pelvis and lower abdomen," Dr. King told MNT. "However, they can develop anywhere in the body," she noted. Dr. Stegmann explained further:

"Actually, most endometriosis does not affect

the reproductive organs but implants on the inside of your abdomen on a surface called the peritoneum. That is what causes pain. But endometriosis can be found just about anywhere and has been seen in the lining of the lung and even in the brain, where it causes seizures when the woman has a period."

"Fortunately, this does not occur very often, and your [healthcare professional] should be able to help watch for signs or symptoms of implants [located in] other places," she continued.

Still, a 2017 study in mice that investigated the potential for endometrial-derived cells to migrate to other organs of the body suggests that endometriosis in locations distant from the pelvis may be more common than previously recognized.

5. Endometriosis always causes pain

Study data suggest that more than 60% Trusted Source of females with an endometriosis diagnosis report chronic pelvic pain. Moreover, people with endometriosis are 13 times more likely to have abdominal pain than those without the condition. Still, Dr. King notes that despite pain being a common symptom, it is possible to receive a diagnosis of endometriosis even if a person is not experiencing any pain.

Dr. Stegmann added: "Some people with mild forms of endometriosis have excruciating pain, and some people with DIE have little or no pain at all. We think this may be related to whether the implant releases certain pain-causing chemicals, as well as where the implant occurs. In fact, some people never know they have really advanced endometriosis until they have [...] abdominal surgery."

6. Menopause stops endometriosis

Although research is limited, scientists estimate that 2–5% Trusted Source of females have postmenopausal endometriosis.

Dr. King told MNT: "Endometriosis doesn't necessarily end when you're in menopause. In fact, the condition can develop years after your periods stop."

Dr. Stegmann explained, "For the same reason that a hysterectomy doesn't always cure endometriosis, menopause may not cure it either." She suggested that if endometriosis-related pain does not stop after menopause, it is best to consult a healthcare professional about pain management options.

7. Endometriosis equals infertility

Studies suggest that 30–50% of females with endometriosis also experience difficulty becoming pregnant. Still, Dr. King noted that despite statistics linking the condition to fertility challenges, "endometriosis does not automatically mean a diagnosis of infertility," Dr.

Stegmann agreed:

"I have had patients with [severe] endometriosis that become pregnant and those with mild endometriosis that do have issues. The only way to know if you will have problems with getting pregnant is to try. Just make sure you work with your [healthcare professional], since many of the medications used to treat endometriosis prevent pregnancy and will need to be stopped for you to be successful."

8. Abortion causes endometriosis

The myth that abortion causes endometriosis may have surfaced due to abortion-related political debate. However, this is not a fact-based claim. Dr. King told MNT: "While the exact cause of endometriosis is still unknown, there does appear to be a genetic link. There is no evidence that abortion causes endometriosis."

When asked whether having an abortion could cause endometriosis, Dr. Stegmann was clear: "Absolutely not. There is no association between abortion and endometriosis."

9. Birth control pills can cure endometriosis

Although Dr. King noted that birth control pills do not cure endometriosis, "they may help reduce symptoms due to suppression of ovulation and menses," she explained. "Nothing cures endometriosis," Dr. Stegmann reiterated. "But birth control pills do treat endometriosis by leveling out your hormones and preventing you from bleeding. So, they are a good treatment, but not a cure," she explained.

Other medications used to treat endometriosis include pain relievers, such as nonsteroidal anti-inflammatory drugs. Additionally, in 2018, the Food and Drug Administration (FDA) approved a gonadotropin-releasing hormone antagonist, a medication to help treat the pain associated with endometriosis.

10. High estrogen levels cause endometriosis

Debunking this myth, Dr. King said: "High estrogen levels have not been shown to cause endometriosis. However, estrogen-blocking medications can help relieve symptoms." Additionally, research suggests that although high estrogen levels may not cause endometriosis, estrogen and its receptors may play a role in the processes that scientists associate with the condition. Still, a 2022 study notes that preventing or treating endometriosis may also involve therapies that target immune system activity.

He expressed concern that the BJP plans to grant citizenship to over 15 to 20 lakh Hindu Bangladeshis who entered Assam till 2014 and also to invite the remaining 1.7 crore Hindu people currently in Bangladesh from 2014 to 2026. He urged those who love the state and its people not to vote for BJP.

SP Subhrajyoti Bora IPS informed this correspondent that they have been arrested for violating a High Court verdict against any call for 'Sarbatmak Hartal'.

Shrinkhal Chaliha, a popular social activist, pledged to continue the protest and criticised the notion that only BJP activists are considered patriots while others are labeled traitors in India. He called upon people to participate in mass protests against the BJP and CAA from the historic Ranghar premises. Jintu Mech declared their unwavering commitment to opposing CAA. AASU Sivasagar also organised a procession in the evening to protest against the implementation of CAA.

National Conference on Language and Linguistics addresses endangered languages of NE

TEZPUR, March 12: "When a language faces the threat of extinction, it leads to the loss of cultural diversity and human heritage," said Prof C Yashwant Singh, a noted academician of linguistics and formerly dean of Arts, Manipur University, while delivering his keynote address at the National Conference on Language and Linguistics organised by the department of Linguistics and Language Technology (LLT), Tezpur University on Tuesday, marking its second anniversary. Prof Singh further added that languages are not just tools for communication; they are intricate expressions of culture, history, and identity. Attending as the chief guest at the conference focused on the linguistics of the languages of north-east, many of which are from Tibeto-Burman languages, vice-chancellor of Tezpur University Prof Shambhu Nath Singh said that India's north-east region is the most linguistically diverse and culturally vibrant area in the country, with a



confluence of languages from at least four language families, several of which are lesser-known or understudied. "It is our duty not only to study these languages for academic purposes but also to help the speakers in multiple ways by encouraging them to preserve their linguistic, cultural, and ecological heritage," he added. Prof Singh also released a book titled 'Select Papers from National Conference on Linguistics and

Language Technology 2023' launched as part of the event. Delivering the welcome address, Prof Gautam K Borah, head of the department of LLT, said that north-east is known for its linguistic diversity, but many of the 220 languages spoken in the region are currently endangered. In this context, the department has been conducting research on several endangered and previously unresearched languages of North East India. Prof. Borah further stated that given the importance of the department in this region, it shall offer a four-year undergraduate programme in Linguistics and Language Technology from the next academic year. Currently, it is offering a two-year Master's in Linguistics and Language Technology and guides PhD research in the discipline. Senior Prof Madhumita Barbara, who has been closely associated with the erstwhile department of English & Foreign Languages for nearly three decades, expressed her views on the future activities of the department. Prof Farheena Danta, dean of Humanities & Social Sciences, said that research on endangered languages in the department will play an important role in the discussions on the introduction of mother tongue medium under the National Education Policy. Lyngdoh, who was arrested from Mawlynrei on March 2, was again produced before the court on Monday.

This was after completion of his 10 days of police custody.

Police have said that Lyngdoh had served demand notes to extort money for the HNLC leading to widespread scare and fear psychosis among a number of businessmen of Shillong.

"As per inputs he might have succeeded in scaring and threatening individuals to yield to the ille-

gal demands," police had said. During his arrest, one Bangladeshi SIM card was also recovered from him.

Lyngdoh is an active member of the HNLC with a close link to the deputy commander-in-chief of the HNLC. He was also the PSO of A. Hazarika @ Manbhalang Jyrwa, the previous vice-chairman of HNLC, who resigned during the process of peace talks.

In this connection, an FIR has been registered at Rynjap PS for further investigation into the matter, the SP said, even as he added that as per the records of Meghalaya Police, Lyngdoh is involved in many criminal cases and has been evading the due process of law. (NNN)

SHILLONG, March 12: The Hynniewtrep National Youth Front (HNYP) has denied that its disciplinary secretary was involved in the March 9-IED bomb blast at Them Iew Mawlong.

58-year-old Tarson Lyмба was picked up from Dawki in West Jaintia Hills district on the night of March 10, after he was alleged to have been involved in the IED bomb blast incident.

Tarson has helped in the picking up and bringing of the HNLC leaders from certain locations along the international border to Shillong for peace talks with the government. A delegation of the HNYP led by its president Sadon K Blah along with the family members of Tarson met the superintendent of police (SP) of East Khasi Hills district, Rituraj Ravi to seek clarification on his arrest.

"The SP has clearly indicated that the arrest of Tarson was in connection with the recent bomb blast which took place at Mawlonghat," Blah told reporters after the meeting.

"However, as HNYP, we are not convinced that Tarson would be involved in the bomb blast incident. In fact we believe that he is not involved at all," he said. Blah said that Tarson has been with the HNYP for the past 26-27 years and was never involved in any anti-social activities. (NNN)

265.49 kilometres of National Highway 913 to be constructed under project Centre sanctions over ₹ 6,621cr for frontier highway in Arunachal

ITANAGAR, March 12: Union minister Nitin Gadkari on Tuesday said the Centre has sanctioned an allocation of ₹ 6,621.62 crore for construction of the ambitious frontier highway in Arunachal Pradesh.

The allocation has been made for the construction of eight packages on National Highway 913 (Frontier Highway), transitioning to an intermediate lane configuration using the EPC mode, the minister said.

The project spans a total length of 265.49 kilometres.

"Encompassed within this initiative are packages 1, 3 and 5 covering the Huri-Taliha section, two packages addressing the Bile-Migging section, packages 2 and 4 managing the Kharsang-Miao-Gandhigram-Vijaynagar section, and package 1 focusing on the Bomdila-Nafra-Lada section," the transport minister said.

The development of these highway stretches holds promise for enhanced connectivity to border areas, fostering socio-economic growth in the state, he said.

The construction of the frontier highway



is anticipated to curb migration and facilitate reverse migration towards the border areas

of the state, the minister said.

"Additionally, these stretches play a vital

role in establishing essential road infrastructure connecting significant river basins, thereby enabling the development of numerous hydropower projects within the state," Gadkari pointed out.

The greenfield road is designed to link uninhabited and sparsely populated areas of Upper Arunachal, making it conducive to tourism.

Chief minister Pema Khandu welcomed the development project, saying that the state is witnessing a new era of connectivity in border areas.

"Gratitude to Hon Union Minister Shri @nitin_gadkari Ji for fresh allocation of ₹ 6,621.62 crore for construction of eight packages of NH-913, designated as Frontier Highway, spanning length of 265.49 km. This marks a monumental step towards enhanced connectivity," Khandu said in a social media post.

CAA becomes key poll issue in Kerala; LDF and UDF protest, BJP defends

THIRUVANANTHAPURAM, March 12: The notification of CAA rules by the Central government has turned into a key issue in Kerala in the Lok Sabha polls, sparking separate protests by the CPI(M)-led LDF and the Congress-led UDF, while the BJP vehemently defended it, asserting it does not target Muslims.

Protests have erupted in various parts of Kerala against the Centre's notification regarding the Citizenship Amendment Act (CAA), as both the LDF and the UDF organised marches towards Central government institutions to condemn the decision.

A day after Kerala Chief Minister Pinarayi Vijayan denounced the CAA as divisive and assured it would not be implemented in the state, senior BJP leader Prakash Javadekar criticised him, alleging that Vijayan was misleading the public.

"Shri Pinarayi, don't make the people fools. The CAA is not designed to revoke anyone's citizenship but to grant it to refugees persecuted on religious grounds who came to India. This is not discriminatory against Muslims," Javadekar said in a post on "X".

Javadekar, who is also the BJP in-charge of Kerala, said Muslims are not persecuted for their religion in Pakistan, Bangladesh, or Afghanistan.

Shortly after the Centre announced the implementation of the controversial Citizenship (Amendment) Act, 2019, Vijayan had said the government has repeatedly stated that the Act, which treats Muslim minorities as second-class citizens, will not be implemented in Kerala.

"That remains the position. All of Kerala will stand united in opposing this communally divisive law," the chief minister said in a statement here.

Meanwhile, hitting out at the BJP on the issue, the CPI(M)-led LDF on Tuesday alleged that "the RSS agenda to build a Hindu Rashtra is behind the CAA."

"The notification was issued ahead of the elections with the aim of religious polarisation," LDF convenor E.P. Jayarajan alleged.

Seeking to garner support in favour of the Left from the Muslim community in polls in Kerala, Jayarajan claimed that the Congress did not oppose the Citizenship Act in Parliament.

"Congress MPs in Lok Sabha and Rajya Sabha didn't do anything. It was like tacitly supporting communalism," the senior CPI(M) leader told reporters.

He alleged that the intention of the Centre is to break the peaceful atmosphere prevailing in the coun-

try and seize power.

Hitting back at the LDF, the UDF alleged that the Pinarayi Vijayan-led government, which says that the CAA will not be implemented in the state, has no sincerity on the issue.

"In 2019, police in the state registered 835 cases related to protests against the Citizenship Amendment Act (CAA). Despite the chief minister's announcement to withdraw non-aggressive cases, this action has not been carried out. It raises questions about the government's stance."

"The chief minister should clarify why these cases have not been withdrawn," the Leader of Opposition in the Kerala Assembly, V.D. Saheeshaan, said.

Criticising the Centre on the issue, the Congress leader said the same government that filed an affidavit in the Supreme Court that it did not intend to implement the CAA amendment brought the rules into effect just before the elections.

"Determining citizenship on the basis of religion is unacceptable. This action is against Article 5 of the Constitution on how to grant citizenship. The Congress and the UDF will fight as hard as they can to preserve the Constitution," he said.

BJP state president K Surendran alleged that the LDF and UDF are dividing the people under the cover of the CAA.

Speaking to the mediapersons in Kochi, he said that both fronts are trying to deceive the Muslim community in Kerala.

"CAA has become law in our country. No one can do anything. I do not know if you are aware or not, but Pinarayi Vijayan, after CAA came up for discussion in Parliament, has set up a concentration camp in Kollam to detain illegal immigrants from Bangladesh and other infiltrators."

"If there is any lie in what I said, you should go and investigate. Vijayan has established a jail in Kollam. The first concentration camp on Centre's instructions to implement the CAA has been set up in Kerala's Kollam district. The first state to implement the CAA would be Kerala," Surendran alleged.

Meanwhile, the Democratic Youth Federation of India (DYFI), the youth wing of the CPI(M), on Tuesday announced its intention to challenge the union government's decision to implement the CAA, by filing a petition in the Supreme Court.

DYFI's All India President, A.A. Rahim, expressed that the amendment poses a threat to the fundamental principles of the country's Constitution. (PTI)

Development work for us is a mission to build nation, not to win elections: PM Modi

'Railway sector in the country suffered heavily after the country's independence because the past governments prioritised 'political motives' rather than development'

AHMEDABAD, March 12: Prime Minister Narendra Modi on Tuesday said his government undertakes developmental works as a part of its mission to build the nation and not to win elections as perceived by some people.

The PM launched ₹ 1,06,000 crore development projects for the country at an event in Sabarmati area of Gujarat's Ahmedabad city after visiting the Dedicated Freight Corridor's (DFC) Operation Control Centre near the venue, ahead of the upcoming Lok Sabha polls.

These comprise ₹ 85,000 crore railway projects, including the launch of 10 new Vande Bharat trains, and a petrochemicals complex coming up at Dahej in Gujarat's Bharuch district with an investment of ₹ 20,600 crore.

"Some people try to look at our efforts through the electoral lens. Let me tell you that we undertake developmental works as part of a mission to build the nation, not to form a government (by winning elections). We want to ensure that our youth do not suffer what their past generations had suffered. This is Modi's guarantee," the PM said.

Modi said that in the last 10 years, his government spent around six times more amount for the development of Railways than was done earlier. In just two months of 2024, his government inaugurated and laid the foundation of ₹ 11 lakh

crore projects, he added.

The PM said the railway sector in the country suffered heavily after the country's independence because the past governments prioritised "political motives" rather than development.

"Earlier, lawmakers used to clap in Parliament over the railway minister's announcement of giving stoppage to a train or increasing the number of coaches. This was the thinking back then. What would have happened if such an attitude persisted in the 21st century too? That is why the first thing I did was to merge the railway budget with the main Union budget so that the Centre's fund is made available for the development of Railways," he said. Earlier, it was very common for trains to get late. Everything was left on the fate of the passengers, he said.

"Earlier, lawmakers used to clap in Parliament over the railway minister's announcement of giving stoppage to a train or increasing the number of coaches. This was the thinking back then. What would have happened if such an attitude persisted in the 21st century too? That is why the first thing I did was to merge the railway budget with the main Union budget so that the Centre's fund is made available for the development of Railways," he said. Earlier, it was very common for trains to get late. Everything was left on the fate of the passengers, he said.

Till 2014, only 35 per cent of the railway lines were electrified. The common people were suffering due to long queues, agents demanding commission and hours of waiting to get train reservation, the PM said.

"I know this very well because I started my life on railway tracks," he said.

Modi said his government has shown a strong willpower to pull the Railways out of a "hell-like situation" and this sector's development is among their topmost priorities.



The previous governments did not give priority to the doubling of railway tracks, he said.

Referring to the DFC, Modi said that for decades, there was a demand of separate tracks for goods trains. It would have increased the speed of both passenger and goods trains and was also necessary to boost agriculture, trade and export activities, he said.

"But under the Congress regime, this project was either delayed or hit roadblocks. Today, we are inaugurating the freight corridor having a length of 650 km."

At the venue, PM Modi laid the foundation stone of railway workshops, loco sheds, electric traction system upgradation work and dedi-

cated to the nation two new sections of the Dedicated Freight Corridor and Western DFC's Operation Control Centre in Ahmedabad.

He flagged off 10 new Vande Bharat trains between Ahmedabad-Mumbai Central, Secunderabad-Visakhapatnam, Mysuru-Dr MGR Central (Chennai), Patna-Lucknow, New Jalpaiguri-Patna, Puri-Visakhapatnam, Lucknow-Dehradun, Kalaburagi-Sir M Visvesvaraya Terminal Bengaluru, Ranchi-Varanasi and Khajuraho-Delhi (Nizamuddin).

The PM also flagged off the extension of four Vande Bharat trains.

The Ahmedabad-Jamnagar Vande Bharat is being extended till Dwarka, Ajmer-Delhi Sarai Rohilla

Vande Bharat till Chandigarh, Gorakhpur-Lucknow Vande Bharat till Prayagraj and Thiruvananthapuram-Kasargod Vande Bharat till Mangaluru.

He also flagged off and two new passenger trains between Asansol and Hatia & Tirupati and Kollam stations.

The PM dedicated 51 Gati Shakti Multi-Modal Cargo Terminals to the nation. These terminals will promote seamless movement of goods between different modes of transportation, said a PIB release.

Other projects which were launched by the PM included digital controlling of railway stations at 2,646 stations, 35 rail coach restaurants, 1,500 "One Station One Product" stalls to promote local products and generate income for local artisans and businesses and solar-powered stations and buildings at 975 locations.

Modi also laid the foundation stone of the petrochemicals complex of Petronet LNG, including ethane and propane handling facilities of more than ₹ 20,600 crore, at Dahej in Gujarat.

The setting up of the petrochemicals complex in proximity to the existing LNG regasification terminal would result in significant savings in the capex (capital expenditure) and opex (operating expenses) cost of the project, said the release. (PTI)

Haryana CM Khattar, all cabinet minister submit resignation to Guv

CHANDIGARH, March 12: Haryana Chief Minister Manohar Lal Khattar and his cabinet ministers on Tuesday submitted their resignations to Haryana Governor Bandaru Dattatreya, sources said.

The development came amid speculation of cracks emerging in the state's ruling BJP and Jananayak Janata Party (JJP) coalition over seat sharing ahead of the Lok Sabha elections.

The cabinet comprised 14 ministers, including Khattar and three members of the Deputy Chief Minister Dushyant Chautala-led JJP. All have resigned.

A new cabinet is likely to be sworn in at the oath taking ceremony to be held at the governor's residence later in the day, the sources said.

The BJP has called a meeting of its MLAs at Haryana Niwas. However, there was no official word from the party.



Five MLAs of the JJP are learnt to have skipped the meeting called by the party in New Delhi.

Several BJP leaders had earlier maintained that party would fight all 10 Lok Sabha seats in the state.

Union minister Arjun Munda, BJP national general secretary Tarun Chugh, who have been appointed as observers by the party, as well as BJP's Rajya Sabha MP Subhash Barala are in Haryana Niwas.

Panel formed to draft legal framework for adventure sports, amusement parks: Guj govt to HC

AHMEDABAD, March 12: The Gujarat government on Tuesday informed the high court that a high-level committee has been constituted to draft a legal framework, certification and enforcement proceedings for adventure sports and amusement parks in the state.

A 13-member committee has been given three months to come out with the legal framework, certification and enforcement proceedings of various activities, Advocate General Kamal Trivedi told the division bench of Chief Justice Sunita Agarwal and Justice Aniruddha Mayee.

The court was hearing a suo motu PIL on the Harni boat tragedy, in which 12 students and two teachers of New Sunrise School at Waghodia near Vadodara drowned after a boat capsized in Harni Lake on the outskirts of Vadodara city on January 18.

"Tourism activity in the state is

increasing, and people have started utilising boating activities, amusement parks, adventure sports, and ropeways at religious and tourist places," Trivedi told the division bench.

The advocate general informed that the state urban development and urban housing department has decided to constitute a high-level committee to lay a specific policy for legal framework, certification and enforcement of various activities of adventure sports and amusement parks, roadways for religious and tourist places and boating in rivers, lakes, and other boating activities in rivers.

The committee has been given three months to draft a legal framework, certification and enforcement proceedings, he said.

The state government has also framed rules under the Gujarat Inland Vessels Act, mandating registration and certification of boats, he said. (PTI)

FLY91 to start flights to Lakshadweep from April NDA finalises seat-sharing in Andhra Pradesh

MOPA (GOA), March 12: Regional airline FLY91 will start commercial services on March 18 and flights to Lakshadweep in April.

The Goa-based carrier, which will have a fleet of 70-seater ATR 72-600 aircraft, has raised USD 25 million, and plans to connect 50 cities in 5 years, its MD and CEO Manoj Chacko said on Tuesday.

At a briefing at the Mopa airport, Chacko said it will start commercial services from March 18 with flights from Goa to Bengaluru and Hyderabad.

There will also be flights to Sindhudurg from Bengaluru and Hyderabad.

The carrier will start flights to Agatti in Lakshadweep from April.

FLY91 will have a total of six ATR 72-600 planes in six months.

Currently, there are two aircraft in its fleet.

"We aim to connect Bharat," Chacko said and added that initially, it will con-



nect 13 city pairs. In the next five years, FLY91 plans to have around 35 planes, connect 50 cities and 6 bases, Chacko said.

Civil aviation minister Jyotiraditya Scindia on Tuesday virtually inaugurated the symbolic flight of FLY91.

The carrier, operated by Just Udo Aviation Pvt Ltd, seeks to enhance air con-

nectivity across Tier 2 and Tier 3 cities.

Chacko said the airline is well-capitalised and currently has around 200 staff.

For every new aircraft, FLY91 will be adding 25 people and for each new station, the addition will be around 20 staff.

"We have a conservative, restricted growth path," he said.

The airline received its air operator permit from aviation regulator DGCA on March 6.

Chacko said the airline's first base Goa is a huge attraction for pilots.

The airline is promoted by Chacko, a former Kingfisher Airline's senior executive, former Fairfax India head Harsha Raghavan, and others.

It is also the first Indian airline to use Goa's Manohar International Airport as its home base.

In April 2023, the carrier received the non-objection certificate for flying from the civil aviation ministry. (PTI)

AMARAVATI (ANDHRA PRADESH), March 12: Andhra Pradesh NDA partners finalised their seat-sharing formula for the Lok Sabha and state polls following a marathon discussion on Monday, under which the BJP will contest six Lok Sabha and 10 assembly seats while the TDP will fight 17 parliamentary and 144 state seats.

Under the deal, Pawan Kalyan's JanaSena will contest two Lok Sabha and 21 assembly seats, TDP supremo N Chandrababu Naidu announced after the meeting.

Senior BJP leader and Union Jal Shakti Minister Gajendra Singh Shekhawat went into a huddle with TDP supremo Naidu and JanaSena chief Kalyan in Amaravati to finalise seat-sharing for the upcoming Parliamentary and Assembly elections.

"In Amaravati today, the BJP, TDP and JSP (Janasena) forged a formidable seat-sharing formula. With this significant step, the people of Andhra Pradesh now stand on

the threshold of reclaiming our state and paving the way for a brighter future. I humbly call upon my people of Andhra Pradesh to shower their blessings upon this alliance, and grant us a historic mandate to serve them," said Naidu in a post on X.

The state has 25 Lok Sabha and 175 assembly seats.

JanaSena was initially supposed to contest 24 assembly and three Lok Sabha seats, but in the seat-sharing formula it got 21 assembly and two Lok Sabha seats, after the TDP joined the NDA alliance recently.

The 2024 polls will be the first time the three parties are contesting the polls together. Back in 2014, when TDP and BJP fought the polls together, JanaSena was their outside ally.

The TDP and JanaSena have announced the names of 100 candidates already, and Naidu said the respective parties will name other candidates soon.

According to the TDP supremo, the

Monday brainstorming exercise sought to forge a formidable combination of seats for every alliance partner that truly represents the people of Andhra Pradesh and their aspirations.

Meanwhile, TDP sources said that the state's opposition party have invited Prime Minister Narendra Modi to attend an election meeting which could take place between March 17 and 20.

"We have invited Modi for the meeting, mostly he will come for the meeting, date is not yet finalised. We proposed March 17 but a day here and there, mostly Modi will be there. Life expectancy dropped by 1.6 years during pandemic, reversing past progress: Lancet study

NEW DELHI, March 12: Global life expectancy dropped by 1.6 years between 2019 and 2021, a sharp reversal from past improvements, according to a research published in The Lancet journal.

One of the first to fully evaluate demographic trends in the context of the first two years of the Covid-19 (coronavirus) pandemic, the study has published findings, which researchers said, could have implications for health systems, economies and societies around the world.

The findings also included those of an ageing worldwide population.

The study found that life expectancy declined in 84 per cent of countries and territories during this time. This demonstrated the "devastating potential impacts of novel pathogens", the researchers said.

Places such as Mexico City, Peru and Bolivia experienced some of the largest drops, the study found.

The researchers also found a marked increase in adult mortality rates globally during the pandemic in 2020 and 2021, reversing past decreasing trends.

However, child mortality continued to drop amid the COVID-19 pandemic, albeit more slowly than in earlier years, with half a million fewer deaths among children under five years in 2021 compared to 2019, they found.

The researchers said stark differences in child mortality persisted regionally, with one in every four children who died globally living in South Asia and two in every four children who died living in sub-Saharan Africa.

The estimates reported here will enable key stakeholders to better understand and address the

profound changes that have occurred in the global health landscape following the first two years of the Covid-19 pandemic and longer-term trends in the future, they said.

The research, coordinated by the Institute for Health Metrics and Evaluation (IHME), University of Washington (UW), US, presented updated estimates from the Global Burden of Disease Study (GBD) 2021.

GBD 2021, the newly published most recent round of GBD results, is one of the first studies to fully evaluate demographic trends in the context of the first two years of the pandemic.

Measuring mortality, excess mortality from the Covid-19 pandemic, life expectancy and population, the researchers estimated that global death rate jumped among people aged over 15 years -- by 22 per cent in men and 17



per cent in women -- from 2019 to 2021. Roughly 131 million people died globally from all causes in 2020 and 2021 combined, of which the pandemic caused about

16 million, either directly by infecting or indirectly by bringing about social, economic or behavioural changes, they estimated.

The team identified high mortality during the pandemic in places previously less recognised or reported such as Jordan and Nicaragua. The high pandemic-related excess deaths in these countries were not apparent in previous all-age excess mortality estimates, they said.

Conversely, they found Barbados, New Zealand and Antigua and Barbuda to be among those places experiencing some of the lowest excess mortality during the pandemic.

The pandemic did not, however, completely erase historic progress made in enhancing life expectancy at birth, which rose by nearly 23 years between 1950 and 2021, they said.

Assessing population trends,

the researchers found that in 2021, the global population almost touched 7.9 billion, with 56 of 204 countries and territories peaking and subsequently shrinking.

The decline in global population was observed to begin in 2017 following years of stagnation, which accelerated during the pandemic.

Many lower-income countries, however, continued to see rapid population growth, with the largest share coming from Sub-Saharan Africa (39.5 per cent) and South Asia (26.3 per cent), they said.

The researchers said that further, the global population is ageing with the number of people aged 65 years and older now increasing faster than the number of people younger than 15 years in 188 of 204 countries and territories. (PTI)

"The Guwahati Municipal Corporation under the Swachh Bharat Mission (Urban), Guwahati Municipal Corporation has undertaken the construction of public toilets across each ward, utilizing funds from the 15th Finance Commission. In the second phase, 17 public toilets were inaugurated today, totaling an estimated value of ₹ 3,36,94,850. These facilities, equipped with continuous water supply and soon to be maintained by specialized third-party, aim to improve sanitation accessibility in the city," a press release stated.

The virtual inauguration-cum-foundation stone laying ceremony was graced by the Ashok Singhal, minister of housing and urban affairs, Mrigen Sarania, Mayor, GMC, Kavitha Padmanabhan, commissioner and secretary to the government of Assam, DoHUA and M N Dahal, commissioner, GMC amongst others.

"Guwahati Municipal Corporation took a significant stride towards improving civic amenities with the inauguration of



various projects which included Public Toilets, Cremation/Burial Grounds, Community Halls.

management in the city, GMC inaugurated a Material Recovery Facility at Adabari. Coupled with the inauguration, foundation stone was laid for the construction of

a state-of-the-art Refuse Transfer Station-cum-Material Recovery Facility at Six Mile, Purabi Dairy campus and 45 new bus shelters.

Also, responding to the need for adequate cremation/burial grounds, GMC has initiated construction/renovation projects for 29 locations across the city under SOPD fund.

In the second phase, 6 cremation/burial grounds were inaugurated on Tuesday, with amenities such as water supply, rest houses, and cremation platforms incorporated.

The total value of these facilities amounts to ₹ 1,18,92,300. Along with these, 9 community halls were inaugurated, the total value of which is ₹ 1,78,38,450.

To enhance scientific waste management practices, the inauguration of the Material Recovery Facility (MRF) at Adabari signifies a crucial step toward collecting, segregating, and recovering dry waste, notably plastic.

Boasting a total capacity of 5 TPD, expandable to 10 TPD, this facility, constructed with generous support from HDFC Bank and the Centre for Environment Education, promotes the fundamental

principles of Reduce, Reuse, Repurpose, and Recycle.

In furtherance of its commitment to enhance waste management practices within the city, GMC has laid the foundation stone for the Six Mile - Purabi Dairy Refuse Transfer Station cum Material Recovery Facility (RTS-cum-MRF).

This initiative will significantly augment waste management capabilities, offering a total waste handling capacity of 25 TPD and 10TPD MRF. At an estimated cost of ₹ 7.68 Cr, the facility is poised to reduce the carbon footprint, mitigate the risk of garbage spillage during transportation, and elevate recycling efforts.

Additionally, in a proactive move towards fostering an inclusive and efficient bus transport system, GMC has officially announced the construction of 45 Bus Queue Shelters along major roads.

These well-equipped shelters, developed through a Public-Private Partnership (PPP) model with an approximate cost of ₹ 7 lakhs, are poised to elevate the office of the guwahati municipal corporation, overall bus transit experience for citizens.

The total construction cost for this transformative initiative is estimated at ₹ 3.15 crores," the press release further stated.

Assam govt employees demand restoration of old pension scheme

GUWAHATI, March 12: Assam government employees staged a demonstration in front of several offices on Tuesday, demanding restoration of the old pension scheme (OPS).

The two-hour protest was carried out under the banner of the All Assam Government NPS Employees Association (AAGNPSEA), a common platform of government workers demanding restoration of OPS in the state, the group said in a release.

The demonstration was held in front of different offices and educational institutions, with the employees reiterating their demand for scrapping the National Pension System (NPS).

The AAGNPSEA questioned the rationale of including teachers and employees with 20-30 years of service record under the NPS, while MLAs and MPs continue to be under



OPS after few years of being elected. Claiming that employees retiring under NPS

are getting monthly pension of Rs 500-3,000, they said that such "drastic reduction" in income of individual households has an impact on the economy, as it brings down the spending capacity of people.

"From today, arrangements have been made to distribute petitions about NPS to the general public so that everyone can come forward to solve the problem. The target is to distribute about one million petitions..." the release said.

AAGNPSEA president Achyutananda Hazarika had earlier said that most employees who retired under the NPS are getting pension of Rs 500, Rs 600 or Rs 1,000 or a maximum of Rs 3,000 a month.

He had also claimed that Assam has around five lakh government employees, out of which around 3.5 lakh are under the NPS. (PTI)

Mimicry of celebs all in good fun, stand-up puts my different skills to use: Jamie Lever

NEW DELHI, March 12: What do you do when you get an 8 am call from Usha Uthup with the legend screaming 'I love you!' in your ears and asking you to mimic her? That's what happened to stand-up comic and actor Jamie Lever, and Uthup's wish became her command.

Jamie, a social media sensation with her excellent impersonations of Asha Bhosle, Farah Khan, and Kareena Kapoor Khan, says she has been lucky that celebrities have always taken her mimicry in good spirits.

The comedian, who is currently promoting her comedy gig 'The Jamie Lever Show', recounted how Uthup approached her out of the blue.

"Usha Uthup called me at 8 am and I was fast asleep. She said, 'Darling! I love you!' I was like who is screaming in my ears and I said 'Hello?' She said, 'Main hoon! Usha! Usha Uthup! I watch all your videos, please mimic me. Why aren't you mimicking me? And that's how I started mimicking her. What more could I ask?' Jamie, who is the daughter of screen legend Johnny Lever, told PTI in an interview.

"Honestly, I have been so lucky. People have always come forward and complimented me... This is all in good fun. People are enjoying it, so it's worth it," she added.

Besides doing stand-up and acting, Jamie is a trained Indian classical vocalist and a Bharatanatyam dancer who has also learnt jazz and hip-hop at the Terence Lewis Dance Academy.

During the reading of the 2021 film "Bhoot Police", the actor, 36, said her co-star Saif Ali Khan came up to her and said "my wife is a big fan of yours".

It took her a few seconds to register that Saif was talking about Kareena.

"Then, I was like 'Wait, did he just say Kareena Kapoor is a big fan of mine?' I couldn't even fathom that this has happened. He said, 'She watches your videos, she really likes you'. I was shocked. I know she knows my dad and Johnny Lever is Johnny bhair for her. But I'm nowhere close to her circle. The fact that she took my name is big for me," she added.

Choreographer-filmmaker Farah, is equally supportive, she said.

"She is always complimenting and commenting on my videos. She called me one morning and said, 'Jamie, what have you done? My husband is sending your videos to my kids, saying 'Mumma talks like this.' I love her spirit, she's such a sport."

Industry stalwarts Rekha and Javed Akhtar have also praised her, added Jamie. "Rekha ji has called me and asked me to break down my process of making a video. She said, 'Break it down for me darling, how do you do it? You wear a sari, you even do make-up?' She asks me those details.

"Javed Akhtar saab has called me and complimented me especially on my Kareena Ranaut mimicry. He said 'The way you have caught the nuance of how she says 'hai' that's just too good.' Every day,

I'm amazed," she said.

While she has never restricted herself to only one skill, the Mumbai-born actor said there was a phase when she was only doing television. Her small screen credits include: "The Kapil Sharma Show" and "Comedy Circus Ke Mahabali".

"Then, I got bored of it and felt like I'm being repetitive. Sometimes people like to go with the tried and tested. That this works with her so let's do more of it. It was really becoming monotonous for me. I wanted to break from that cycle. I hosted a lot of red carpets at award shows. Then I switched to social media."

Stand-up helps her put all her acquired skills to use on one stage, Jamie said.

"I can use all the different skills I have and bring them all together, stitch it up together in a nice stand-up act. All the skills I have acquired from all the various jobs I've done whether it's playing a different character in a different accent in 'Bhoot Police', impersonating people in my social media videos or playing Farah Khan on 'The Kapil Sharma Show'..."

The actor is not new to the stand-up circuit but the two-hour 'The Jamie Lever Show' is her first solo stint. She has done almost 300 onstage shows worldwide with small clubs and also toured with her father.

"Four years ago, my father predicted that one day I will have my own Jamie Lever show. So he asked me to start preparing for it. It has taken me a lot of time to gather the courage and confi-

dence. Over the years, I have built

the content... It's from my experiences in mimicry or just being his daughter. I realised I have so much to say, so many of my own observations of people around me," she added.

Johnny Lever ki beti!' I don't get a normal reaction... That's been my life. In school, I was made to do plays or jokes because I was Johnny Lever's daughter. I was forced to do all these things..." she quipped. The growing emphasis on the importance of domestic cricket and red-ball games got another shot in the arm with Tendulkar and Rohit attending the third day's play during the Ranji Trophy final between Mumbai and Vidarbha here on Tuesday.

field. Rohit was seen scrolling through his phone while also chatting with Mumbai teammates including Shardul Thakur, but how did the India skipper made his way to the domestic giants' dressing room with a phone while not being a part of the squad remained an intriguing question.

With the backdrop of Shreyas Iyer missing out on a BCCI contract and also losing his spot in the Indian Test side, Rohit witnessed the right-handed batter getting back into his groove but also throwing away his wicket when he was just one hit away from triple-figure mark.

In the morning session on Tuesday, the TV camera kept

panning towards the MCA President Box wherein sat the legendary Tendulkar to witness the action.

Tendulkar was spotted sitting alongside former players Dilip Vengsarkar, Subroto Banerjee, a few officials as well as Chandrakant Pandit, the incumbent coach of Madhya Pradesh and Kolkata Knight Riders.

The Little Master, who had termed Mumbai's batting as 'ordinary' on the opening day when the 41-time champions were shot out for a mere 224, appeared satisfied with the improvement shown in the second innings wherein Musheer Khan (135), Ajinkya Rahane (73) and Iyer flayed the opposition. Ten-



dulkar took to his social media platforms to share his observations. "Mumbai displayed a lot more discipline, patience and commitment in the second innings," he wrote.

"First, a crucial partnership between @ajinkyarahane88 and Musheer Khan put Mumbai in a solid position. Then, Musheer's stand with @ShreyasIyer15 has taken the game further away

from Vidarbha. Had a good time watching the game today with my friends and colleagues," Tendulkar added.

The presence of Rohit and Tendulkar came a day after another Mumbai and India legend, Sunil Gavaskar, showed up. Gavaskar sat with cricket administrator Ratnakar Shetty and former women's cricket team skipper Diana Edulji as well as former captain and chairman of the Mumbai selection committee, Milind Rege.

The opening day marked the presence of enthusiastic crowd turning up in decent numbers to fill up the Vijay Merchant Pavilion, but they also had to deal with the disappointment of

Mumbai batters not making it big in the first essay.

But the disappointment did not last long as Mumbai fought their way back into the final to get into the driver's seat. However, there were some off-field issues that did concern a few. With the IPL 2024 about 10 days away, the Wankhede Stadium is undergoing renovation work which is expected to be completed before the venue hosts its first game on April 1 between Mumbai Indians and Rajasthan Royals. A few fans, though, complained about the lack of a scorecard for fans despite a manually-operated scorecard operational across the field. (PTI)

Just before the break, however, Abdulrahman Ghareeb pulled one back for Al-Nassr, and just after, an own goal from Eisa made it 2-2 on the night.

With 18 minutes of normal time remaining, former Manchester United defender Alex Telles scored for Al-Nassr to



force the game into extra time.

Al-Ain restored its lead through Sultan Al Shamsi, but with 118 minutes on the clock, Ronaldo scored from the spot to level the tie 4-4 on aggregate. In

the shootout, Ronaldo found the net while Marcelo Brozovic, Telles and Otavio all failed.

Al-Ain will face more Saudi Arabian opposition in the last four. Four-time champion Al-

Hilal carries a 2-0 lead against two-time champ Al-Itihad into their quarterfinal second leg on Tuesday.

Indian men slip to 4th, women's team ranked 9th in the latest FIH world rankings

NEW DELHI, March 12: India on Tuesday slipped a spot to the fourth position in the latest FIH men's world rankings with Germany taking the third place following their impressive run at the FIH Hockey Olympic Qualifiers.

India (2761) had directly qualified for the Paris Olympics through an Asian Games gold last year and didn't need to play in the recently-concluded Olympic Qualifiers.

Nishant Dev loses in quarterfinal; Indian boxers draw a blank at Olympic qualifiers

BUSTO ARSIZIO (ITALY), March 12: Nishant Dev missed out on a Paris Olympic quota by a whisker, suffering a heartbreaking loss in the 71kg quarterfinals as all Indian boxers returned empty-handed from the first World Olympic Boxing Qualifier here.

Dev went down 1-4 to USA's Omari Jones, the 2021 World Championship silver medalist, in a closely-contested light middleweight quarterfinal late on Monday. A win in the last eight stage would have fetched the 2023 World Championships bronze medalist an Olympic quota. None of the nine boxers competing here were able to add to India's tally of four quotas in boxing.

After two qualification events -- the

Asian Games and the first World Olympic Boxing Qualifier -- not one Indian male pugilist has been able to book a place for the Olympics.

All four quotas in boxing have come in the women's section with two-time world champion Nikhat Zareen (50kg), Preeti Pawar (54kg), Parveen Hooda (57kg), and Tokyo Olympics bronze medalist Lovlina Borgohain (75kg) securing their passage to Paris.

Indian boxers will get a final chance to book their ticket to Paris during the second World Olympic Boxing Qualifier, scheduled to be held in Bangkok from May 23 to June 3. Between 45 and 51 boxers will qualify from the Bangkok meet.

India had nine boxers competing in the Tokyo Olympics with Borgohain winning the only medal -- a bronze.

On Monday night, Dev was slow off the blocks, as Jones relied on his speed to land several blows in the opening minutes to take command at the start.

Trailing on all five cards after the opening three minutes, the 23-year-old was aggressive from the beginning of the second round.

Both boxers threw punches but Jones' speed gave him a slight edge. With Dev coming at him heavily, the US pugilist relied on his counterattack.

The round was a messy one with lots of clinching, and warnings were handed to both boxers. As the bout progressed,

In the range: How Tughlakabad's 'butt party' helps shooters stay on target

NEW DELHI, March 12: It takes a village to raise a kid or move a mountain or in this case, keep an international shooting range up and running through the year in the heart of Delhi.

When the pistol and rifle shooters make a beeline for the well-lit room inside the Karni Singh Ranges, Manu and Mohit are hard at work to ensure equipment is ready.

They are part of the "butt party", a bunch of youngsters from the Tughlakabad, one of the oldest villages in Delhi located in the shadows of the seven centuries old Tughlakabad fort.

With most of its members in their late teens or early 20s, the 15-strong "butt party" is the "lifeline" of the premier shooting arena in the country.

They all come from the same village and the skill has been passed on to them by their seniors, who also hail from Tughlakabad.

Be it fixing the targets, print-

ing rolls and score-sheets in the 10m, 25m and 50m ranges or loading clay pigeons at the shotgun ranges or operating them, they are the unsung heroes of the highly technical sport.

"About 14-15 boys from our village work here on a contractual basis to keep the ranges up and running during national and international competitions and trials," says Manu, 24, who left school after ninth standard and was brought to the range by a senior to become part of the 'butt party'.

The term 'butt party' comes from the old times when servicemen manually placed and removed targets and patched up bullet holes with square pieces of paper and starch.

Electronic targets may have replaced manual targets but 'butt party' has stuck.

"I don't really know why we are all called 'butt party' but we know our job very well. With all of us coming from the same village, there is camaraderie

among us and also makes us understand each other better," says Mohit, 19, a college student.

"Our team does everything to make all the ranges operational, including filling pistol and rifle cylinder with compressed air, fixing targets, templates, print rolls, collecting score-sheets, loading clay pigeons at the shotgun ranges and operating them," he adds.

The ongoing Para Shooting World Cup is keeping them busy all day long, with an unending stream of shooters waiting for their turn to get the cylinders refilled in their pistols and rifles.

Air pistol and air rifles operate on a mechanism where pressurised air cylinders attached to the barrels eject the lead pellets at the press of the trigger.

The process to fill these cylinders from the reservoir cylinder is in itself a specialised job where a small mistake can have disastrous consequences as was evident recently when a na-

tional-level shooter lost his thumb after his pistol cylinder exploded during refilling.

"In a competition like the Para World Cup where more than 250 shooters are competing, we have to be on our toes to ensure no accident occurs."

"We know exactly how much compressed air needs to be filled in air pistols and air rifles and how to attach the cylinder below the barrel without damaging the delicate lining of the guns," says Manu, who wanted to play professional cricket but could not go beyond the district level.

"This is the only job I know. The increase in the number of national and international competitions and trials has guaranteed us work 365 days a year.

I am doing this job for 6-7 years. We ensure that no shooter fills the cylinders himself. We don't allow them to do it, it can lead to accidents, adds Manu, who is a veteran of 100-plus competitions and trials.

JP Nautiyal, chairperson, para shooting, Paralympic Committee of India says, the 'butt party' is an "integral part" of shooting sport.

"They know exactly how much compressed air needs to be filled, how much the cylinder rims have to be tightened in order to ensure no accidents take place. They are also sensitised to the needs of the para shooters, who have come here for the ongoing World Cup," says Nautiyal.

"Their task is huge as shooters, once they arrive in droves at the range from airports, need to get the pistol and rifle cylinders refilled as they have to empty them before they board the flight. "A compressed cylinder cannot fire more than 80 shots, so a shooter needs at least four refills a day. Multiply it with the 250-odd shooters who are here and one can gauge the quantum of work these people do. Their hands are full all the time free," says Nautiyal. (PTI)

Palmer stars for Chelsea as Newcastle beaten 3-2 in English league thriller

LONDON, March 12: Cole Palmer capped an impressive display with a goal and an assist as Chelsea beat Newcastle 3-2 in a pulsating English Premier League match on Monday.

In front of watching England manager Gareth Southgate, the 21-year-old Palmer pulled the strings in midfield for the London club.

His 11th goal this season made him the sixth Chelsea player to score in five consecutive league matches. Chelsea has not lost a league game at home in the month of March since 2001.

The result cut the four-point gap between Newcastle in 10th and Chelsea in 11th to one point.

Palmer's goal came 12 minutes into the second half. He found space just outside the Newcastle penalty area and fired home a low shot.

Nicolas Jackson gave the home side the lead after six minutes when he diverted a shot

from Palmer past Newcastle goalkeeper Martin Dubravka.

Although it lost in-form winger Anthony Gordon to injury 10 minutes before halftime, Newcastle fought back and eight minutes later got an equalizer when Alexander Isak found the net with a perfectly placed shot from 18 yards out.

Substitute Mykhailo Mudryk made it 3-1 to Chelsea in the 76th just five minutes after replacing Raheem Sterling.

Jacob Murphy got a goal back for the visitor in the 90th but his rasping strike was not enough to stop Chelsea taking all three points and prevent Newcastle from recording its first home-and-away double over the Blues since the 1986-87 season.

Kohli's aggression gives his team required intensity: Anil Kumble



BENGALURU, March 12: Former Indian captain Anil Kumble is marvelled at Virat Kohli's manic consistency and believes that his on-field aggression always adds to required intensity in any T20 team that he plays for.

Kumble marked it as the biggest legacy of Kohli, who is the only player in history of IPL to play 16 seasons for one franchise -- Royal Challengers Bangalore.

"I would say consistency. I saw him in RCB when I was a part of RCB, that's where he started his T20 career, after being a U-19 World Cup winner. From there, the transformation in his fitness, the way he wanted to play his cricket, and the performances he put in white-ball cricket," Kumble told Star Sports.

"In Test cricket, we know his greatness.

In T20s for India, his consistency over a period of time has been immense. The kind of aggression and attitude he brings on to the field help the team gain intensity," said Kumble.

The World Cup winning England captain Eoin Morgan rated Kohli as one of the finest cricketers of the modern era.

"I highly regard him as one of the greatest of the modern era, across all three formats. When you have a player of that calibre in your side, it's crucial that you're constantly asking him to get the best out of himself.

"It brings a huge ceiling, as we've seen in the past. The level of inspiration and intensity that he brings lifts everybody within the group."

Mike Hesson, who has shared dressing

room space with Kohli during his tenure as RCB coach, offered a slightly different view of a calmer Kohli outside the playing field.

"You talked about the side on the field, but he's very calm off the field. When youngsters come into the team or overseas players, he'd spend time getting to know them.

"This was after he was a captain (of RCB) as well. It's not a captain thing. It's a genuine want to share and communicate about things other than cricket," said Hesson. For Robin Uthappa, the combative instincts of Kohli makes playing against him a tough and an even more "annoying" experience.

Uthappa has played alongside Kohli at Royal Challengers Bangalore, and he has

also been in opposition while playing for various other IPL teams such as Chennai Super Kings and Kolkata Knight Riders.

"Playing against Virat isn't daunting as much as it is annoying. As an opposition, he could be grating, in your face. You'd always feel like there's a battle happening with a bowler," Uthappa said. But Uthappa said the ambit of that battle is not just restricted to Kohli the batsman.

"There's an extra battle happening with an extra-cover fielder because he's coming at you all the time. He's throwing the ball and it's whizzing past your head. You feel that pressure all the time," he added.

Royal Challengers Bangalore will start their IPL 2024 campaign on March 25 with an away match against title holders Chennai Super Kings. (PTI)

Pant declared fit as keeper-batter for IPL; set to return as DC captain

NEW DELHI, March 12: The BCCI on Tuesday declared Rishabh Pant fit to play as a wicketkeeper-batter in the upcoming IPL, brightening his prospects of a national comeback in the T20 World Cup after suffering multiple injuries in a harrowing car crash 14 months ago.

Pant, who will once again be back as Delhi Capitals skipper, has undergone extensive rehabilitation and is ready to shoulder the dual responsibility in the event starting March 22, ending weeks of speculation surrounding his exact role in the league.

"After undergoing an extensive 14-month rehab and recovery process, following a life-threatening road mishap on December 30th, 2022, near Roorkee, Uttarakhand, Rishabh Pant has now been declared fit as a wicket-keeper batter for the upcoming IPL 2024," said the BCCI in a statement.

The T20 World Cup is scheduled to be held in the West Indies and the USA in June.

A few weeks back, Pant, in an interaction with Star Sports, had recalled telling his doctor that he would shave off at least six months from his recovery timeline.

"I asked the doctor how long will it take for me to recover. I told him that everybody is speaking different things, but you will give me the most clarity about it. He (Doctor) said it would take 16 to 18 months. I told the doctor from whatever timeline you give me, I will reduce six months from it."

Pant had told the official TV broadcasters of IPL.

The National Cricket Academy had declared him fit a week back after he passed all the fitness tests related to his 'Return To Play' (RTP).

It has been learnt that he batted for long hours and more importantly, kept wickets for extensive periods in match simulations organised by the NCA.

There was speculation that he might play only as an 'Impact Player' or batter but one of India's biggest match-winners in the past six years has managed to get back in shape to go full throttle.

Pant keeping wickets also means that he would have a fair chance of playing the T20 World Cup if he can come up with some impactful innings during the IPL season.

"If he can make the T20 World Cup for us, that will be a big thing for us. He is a big asset for us. If he can keep, he can play the World Cup. Let's see how he does in the IPL," BCCI secretary Jay Shah had recently told PTI in an exclusive interaction.

Pant was present at the Capitals table during the IPL auction last year, and has been working on his fitness at the NCA after recovering from the injuries sustained in the unfortunate incident. The accident had left Pant with a severe right knee injury that required a ligament reconstruction surgery besides a fractured wrist and ankle. But he has done well to bounce back.



"If there was any nerve damage, there was a possibility of amputation. That is when I felt scared," Pant had said in Star Sports series 'Believe: To Death & Back' which documented his recovery.

"I had taken an SUV, but what I was seeing was a sedan," he quipped as he remembered his mangled vehicle.

"There was someone around so I asked if he could help getting the leg back in the position. He helped the knee get back in place.

"It was the first time I had such a feeling in life. At the time of the accident, I was aware of the wounds, but I was lucky as it could have been even more serious," he recollected.

The big-hitter had said the process of recovery was boring at best and frustrating at worst.

"I was focusing on recovery cut off from the world. It helped me in recovering fast, especially when the injury is so serious. For recovery, you have to do the same thing every day. It's boring, it's irritating, it's frustrating, but you have to do it," he elaborated.

The BCCI also confirmed the PTI news report from last month that Mohammed Shami (Gujarat Titans) will not take part in the IPL due to heel surgery.

Shami is not expected back before September this year.

"The fast bowler successfully underwent surgery on February 26th, 2024, for his right heel problem. He is currently being monitored by the BCCI medical team and is ruled out of the upcoming IPL 2024," the BCCI statement read.

Lanky fast bowler Prasad Krishna (Rajasthan Royals), who had an unsuccessful Test debut in South Africa is also being monitored by the BCCI medical team. PTI had reported in January that Prasad will be out for an extensive period.

"The fast bowler underwent surgery on February 23rd, 2024, on his left proximal quadriceps tendon. He is currently being monitored by the BCCI Medical Team and will resume rehab at the NCA soon. He will not be able to take part in the upcoming IPL 2024," the BCCI said. (PTI)

Two-day conference for sports psychologists to be held in Mumbai

MUMBAI, March 12: The Indian Sports Psychologists' Association (INSPA) will organise a two-day conference here to bring together sports psychologists from around the country.

Prolific Yashasvi Jaiswal wins ICC Player of Month Award Dubai, March 12 (PTI) India's newest batting sensation Yashasvi Jaiswal was on Tuesday named the ICC 'Player of the Month' for Feb-

ruary, following his prolific run in the Test series against England, which saw him amass over 700 runs. The 22-year-old southpaw totalled a staggering 712 runs over five matches, the highest aggregate by an Indian batter in a Test series against England.

The Indian opener created several records in February, and equalled the long-standing Test record for most sixes in a Test innings (12) during his Rajkot double ton. He struck two double hundreds and three half-centuries in the just-concluded series against England, which the hosts won 4-1 with Jaiswal playing a handsome role in the triumph.

"I'm really happy to achieve ICC award and I hope I will be getting more in future," Jaiswal said after he was informed about the win.

"It's one of the best and this is my first five-match series. I really enjoyed it, the way I have played and the way it's been and we won the series by 4-1. It's been an incredible experience with all my mates And I really enjoyed it."

Few have made as strong a start to their international career as Jaiswal and the numbers prove that he could already be one of the best Test openers in the world. (PTI)
