Assamese's definition changed, includes those living in Assam for years: Himanta

GUWAHATI, March 2: The definition of Assamese has undergone change over the years, and it must include people who have been residing in Assam for centuries, such as Hindi speakers and the tea tribes, chief minister Himanta Biswa Sarma said on Saturday.

He said that a mass movement is needed to convince the Assamese people that the identity of the community can be preserved through "quality".

Sarma was speaking at a programme in which rehabilitation grants were given to 936 cadres and family members of the ULFA, following provisions of the Peace Accord with the now-disbanded outfit.



"In Assam, there are two sections of people, some support the CAA and I am one of them, and there are many who oppose it," Sarma said, speaking to reporters on the sidelines of a programme here.

"We have to accommodate both points of view. We don't have to criticize somebody for opposing or supporting it," he added. Citing the example of the Illegal Migrants (Determination by Tribunal) (IMDT)

Act, the CM said, "A large section of people

lity of the state, people must go to the court and ventilate their grievances," he said. adding that the SC is a neutral body and will listen to logical reasoning.

Congress biggest enemy of peace, development: Himanta

GUWAHATI, March 2: Chief minister Himanta Biswa Sarma on Saturday hit out at the Congress, labelling the grand old party as the 'biggest enemy of peace and development'. He termed the forthcoming Lok Sabha elections as a 'fight between anarchism and democracy', with Prime Minister Narendra Modi standing for the latter.

Speaking to reporters on the sidelines of a programme here, Sarma said, "These people (Congress) are not only the biggest enemy of development, but also of our civilisation. They are the biggest enemy of peace and development." "At a time when India is witnessing civilisational triumph, if they oppose growth, how can they say they like India? They want anarchism and our Prime Minister wants development. This election is precisely a fight between anarchy and democracy," the CM claimed. He termed the polls a fight between those who want to see India as 'vishwa guru' (world leader) and those who want it to remain an inferior country. "Modi has transformed India completely and the people of the country are with him," he added. Taking a dig at Rahul Gandhi, Sarma said, "He came to Assam and destroyed 90 per cent of Congress, now only 10 per cent is left." (PTI)

The Election Commission of India (ECI) has issued directions in this regard, the statement issued by the state Chief Electoral Officer on Friday said.

The 30-share BSE Sensex jumped 1,245.05 points or 1.72 per cent to reach 73,745.35 -- its alltime closing peak. During the day, it zoomed 1,318.91 points or 1.81 per cent to hit a record intra-day high of 73,819.21.

The Nifty climbed 355.95 points or 1.62 per cent to settle at a new closing high of 22,338.75. During the day, it soared 370.5 points or 1.68 per cent to reach its intra-day record peak of 22,353.30.

A rally in global markets and auto sales numbers added to the positive momentum in the equity markets, analysts said.

Among the Sensex firms, Tata Steel jumped over 6 per cent while JSW Steel climbed more than 4 per cent. Larsen & Toubro, Titan, Maruti, IndusInd Bank, ICICI Bank and Tata Motors were the other major gainers.

NEW DELHI, March 1: Investors became richer by ₹ 4.29 lakh crore on Friday as markets fired on all cylinders with the BSE Sensex rising sharply by 1,245 points or nearly 2 per cent.

The 30-share BSE benchmark jumped 1,245.05 points or 1.72 per cent to settle at a new closing high of 73,745.35. During the day, the benchmark zoomed 1,318.91 points or 1.81 per cent to reach an all-time high of 73,819.21.

The market capitalisation of BSE-listed companies soared by ₹ 4,29,339.75 crore to 3,92,25,029.98 crore (USD 4.78 trillion).

"The strong resilience in India's Q3 GDP growth numbers propelled Sensex & Nifty to fresh record highs amid a rally in index heavyweights such as Reliance Industries, Tata Steel and banking stocks," Prashanth Tapse, Senior VP (Research) at Mehta Equities Ltd, said

NEW DELHI, March 1: Finance Minister Nirmala Sitharaman on Friday said Direct Benefit Transfer of ₹ 34 lakh crore has been facilitated by the Public Financial Management System (PFMS) and asked accounts officers to further enhance efficiency and transparency of the system.

In a written message to the Controller General of Accounts (CGA) and the Indian Civil Accounts Organisation (ICAO) on the occasion of the 48th Civil Accounts Day, Sitharaman said PFMS has been the cornerstone of establishing an efficient fund flow system alongside a robust payment and accounting network. PFMS is the management information system used by officers of the Indian Civil Accounts Service to maintain the accounts of the government.

It is also used to transfer funds to beneficiary accounts of various government schemes via Direct Benefit Transfer (DBT).



"The Direct Benefit Transfer mechanism, facilitated through PFMS, has led to the transfer of Rs 34 lakh crore from the government. This is a testament to the system's effectiveness in eliminating inefficiencies and ensuring that the benefits are delivered directly to the citizens without any leakages," Sitharaman said in her message, read out by Finance Secretary T V Somanathan at the Civil Accounts Day event.

She also highlighted that 1,081 different schemes, including those of state governments, have been

WTOs 5th day meet: Talks on to break impasse over agri, fisheries issues

ABU DHABI, March 1: The UAE time on Friday, 1 March," meeting of the highest decisionmaking body of the WTO on Friday entered the fifth day with key members including India, the US, and the EU holding talks to iron out differences on issues such as agriculture, fisheries subsidies, and duty moratorium on e-commerce trade. The 13th Ministerial Conference (MC), which was to end on February 29, extended for a day as developing and developed nations were unable to find common ground on these key issues.

The members are talking to end the impasse and so far things have not moved much, an official said.

"There are nine countries in the green room meeting including Brazil and China. The negotiations have been extended as WTO chief Ngozi Okonjo-Iweala is pushing for outcomes," the official said.

WTO spokesman Ismaila Dieng said that the ministers continue to be engaged in intensive and difficult discussions on a package of agreements for adoption at MC13.

"As a result, in order to give more time for negotiations, the Formal Closing Session of MC13 has now been postponed to 5 pm Dieng said.

India has clearly stated that finding a permanent solution to the public stockholding of grains for food security purposes should be the top priority before taking up any new issues in the agriculture sector. There are major differences among rich nations also on issues related to market access for agri commodities. There are seven agri matters which include export restrictions. An official said talks are going on among the member nations on all the issues and India is clearly stating that it will not compromise the interests of farmers and fishermen

New Delhi is pressing for a permanent solution to the issue of public stockholding of grains for food security programmes and has asked developed countries engaged in distant water fishing to stop providing any kind of subsidies for 25 years.

India is also pressing for an end to the moratorium on imposing customs duties on e-commerce trade. India and South Africa have blocked a proposal led by China on investment facilitation stating that the agenda is out of the WTO mandate. India has also asked for the restoration of the appellate body of the WTO's dispute settlement system. The US has been blocking the appointments of judges in the body since 2019, due to which the system is not working smoothly.

New Delhi is pitching for finding a permanent solution to the issue of Public Stockholding (PSH) for its food security pro-PSH programme is a policy tool

under which the government procures crops like rice and wheat from farmers at a Minimum Support Price (MSP) and stores and distributes foodgrains to the poor. As part of a permanent solution,

India has asked for measures like amendments in the formula to calculate the food subsidy cap. Further, the talks on non-trade issues such as trade inclusiveness, women's participation in trade, industrial policy, and environment, in the draft Abu Dhabi package also remained unresolved so far.

However, the ministerial has managed to get at least five outcomes such as new disciplines on domestic regulation for services, formal joining of Comoros and Timor-Leste as members of the WTO, and least developing countries continuing to get the benefits of LDC even three years after graduation

Besides, India is also pushing for the adoption of open and interoperable payment systems with a view to cut the cost of money transfers or remittances as the dominance of a few large players in the market contributes to these high costs through complex and opaque fee structures.

According to an expert, the challenge of high remittance costs, averaging 6.18 per cent globally, are well above the United Nation's target of 3 per cent. MC is the highest decision-making body of the 166member Geneva-based multilateral body. As many as 22 more nations have shown interest to join the organisation. At the meeting of the Heads of Delegation on 28 February, DG Okonjo-Iweala has called on members to go the extra mile to find convergence on various negotiations at the ministerial gathering and to be mindful that time is running out to conclude meaningful agreements. The state government's share in the project is ₹ 2,460 crore, while Tata Trusts will provide ₹ 1,180 crore, the government of India ₹ 180 crore and over ₹ 80 crore has been raised through donations. An Assam Cancer Care Foundation has been formed to manage the units, which will be responsible for operating these and if any revenue deficit is there at the end of the year, the state government will fill the gap, the CM said.

Ten such cancer care centres are already operational and over 2.15 lakh patients have received treatment in these, he added. "The entire country is trying to emulate Assam. We are thinking of upgrading this project so that Assam becomes a nodal state when it comes to cancer care," Sarma said. He also affirmed the state government's commitment to the development of the Barak Valley.

"A section of people in Barak Valley indulge in propaganda that the state government does not care about this part. But when you look at projects like this, it shows that not only does the government care, but we also actively support Barak Valley," Sarma said.

Later in the day, the chief minister attended a function at Lakhipur where he opened and laid the foundation for several projects.

The deal for procurement of RD-33 Aero Engines for MiG-29 aircraft was signed with state-run aerospace giant Hindustan Aeronautics Limited (HAL) and the cost of the project would be ₹ 5.249.72 crore.

The ministry said the aero engines will be produced by the Koraput Division of the HAL.

"These aero engines are expected to fulfill the need of Indian Air Force (IAF) to sustain the operational capability of the MiG-29 fleet for the residual service life," it said. "The aero-engines will be manufactured under transfer of technology license from the Russian original equipment maker. The programme will focus on indigenisation of several high value critical components, which would help increase the indigenous content of future repair and overhaul tasks of RD-33 aero-engines," it said.

The ministry also signed a deal with Larsen and Toubro Ltd for procurement of a batch of close-in weapon

"The contract for procurement of CIWS has been signed with Larsen & Toubro Limited at a cost of ₹ 7,668.82 ore," the ministry said. "The CIWS will provide terminal air defence to select locations of the country. The project will boost and encourage active participation of Indian aerospace, defence and associated industries in-

The contract for procurement of high-power radar systems has also been signed with Larsen and Toubro Limited at a cost of ₹ 5,700 crore. It will replace existing long-range radars of lAF with modern active aperture phased array based HPR with advanced surveillance features. "It will significantly enhance the terrestrial air defence capabilities of IAF with integration of sophisticated sensors capable of detection of small radar cross section targets," the ministry said.

"It will boost to indigenous radar manufacturing technology as it would be first of its kind radar built by the private sector in India," the ministry said. The signing of the two contracts for procurement of the Brahmos missiles came days after the acquisition was cleared by the Cabinet Committee on Security (CCS). The CCS accorded approval for procurement of over 200 BrahMos supersonic cruise missiles and associated equipment.

It is learnt that it will be a mix of BrahMos missiles having a range of around 290 km and the latest extended range variant of the weapon with a range of around 450 km. BrahMos Aerospace Pvt Ltd, an India-Russian joint venture, produces the supersonic cruise missiles that can be launched from submarines, ships, aircraft, or land platforms. BrahMos missile flies at a speed of 2.8 Mach or almost three times the speed of sound. (PTI)

From undernutrition to obesity

study looked at body mass index (BMI) to understand how obesity and underweight have changed worldwide from 1990 to 2022. It analysed the weights and heights of over 220 million people aged five years or older, from across more than 190 countries. The findings also highlighted a major shift in lifestyle over the past decades, including lack of exercise and healthy food, said Pradeepa.

The study found that the adult obesity rate in India increased from 1.2 per cent in 1990 to 9.8 per cent in 2022 for women, while for men, it rose from 0.5 per cent to 5.4 per cent. Pradeepa attributed the spike in obesity rate to a combination of biological and social factors. "Biological factors involve constant, cyclical hormonal activity with pregnancy-specific weight gain, following which taking care of the child takes precedence

"On the other hand, social factors compel them to prioritise their children's and family's health over their own. These factors present as barriers to doing exercise for women and taking care of themselves," she explained. The findings revealed the need for innovative interventions in terms of introducing more physical activity and movement in a day, especially for women, said Pradeepa. She referred to Thandav, which is one such intervention, developed

by Dr. R. M. Anjana, President of MDRF. Thandav is a ten-minute routine that combines the physical exercise aspect of high-intensity interval training (HIIT) with enjoyable dance movements. The routine thus makes the act of performing physical exercise more entertaining and recreational, and also more socially acceptable as girls and women can perform this easily at their homes, explained Pradeepa. Anjana along with colleagues at MDRF, have scientifically investigated the impact of Thandav on the physical fitness of Indian girls and women and published papers in journals such as Diabetes Technology and Therapeutics. (PTI)

Farmers to get additional ₹ 5 on every litre of milk Purabi Dairy plant expands processing capacity to 1,50,000 litres per day

GUWAHATI, March 2: Purabi Dairy has expanded the processing capacity of its existing dairy plant from 60,000 liters per day to 1,50,000 liters per day. Purabi Dairy will now be able to produce 10 tons per day of curd, 2 tons per day of paneer, 10 thousand liters per day of lassi and 2 thousand liters per day of flavored milk.

Chief minister Himanta Biswa Sarma unveiled the expanded dairy plant of West Assam Milk Producers' Cooperative Union Ltd popularly known as Purabi Dairy at an inauguration event organised at its premises in Guwahati.

CM was the chief guest of the event that was also graced by Atul Bora, minister of agriculture & AHVD, Nandita Gorlosa, minister of cooperation, Meenesh Shah, chairman, National Dairy Development

The event also saw the attendance of Dr B Kalyan Chakravarthy, principal secretary to the Govt of Assam, Cooperation Dept., Manish Thakur, principal secretary to the Govt of Assam, animal husbandry & veterinary dept, Virendra Mittal, commissioner & secretary to the govt of Assam, agriculture dept. and state project director, ARIAS Society, Narayan Konwar, secretary to the govt of Assam, cooperation dept and registrar of cooperative societies, govt of Assam and Rituraj Bora, secretary to the govt of Assam, cooperation dept besides, key officials and large number of farmer members of dairy cooperative societies were present during the

Sarma unveiling the first batch of Purabi Ice Creams said: "This ice cream tastes great as it is made from milk produced by the dairy farmers of Assam. Today, through this new plant, the capacity of milk processing will increase to 1.5 lakh litre. The increased capacity will help the thousands of dairy farmers in the state who will get better market access through

this initiative. The Assam Government has formed a JV company with NDDB and with today's inauguration, the company has launched its first commercial prod-

"The state government from next year has decided to provide ₹ 5 additional benefit on each litre of milk to the dairy farmers of the state in the organized sector. This will be over and above the already existing rate given by the different dairy cooperatives. Through this, we are providing additional support to the farmers who through various interventions like sexsorted breed, artificial insemination, etc. are already increasing their yield," Chief Minister Sarma announced. Sarma also announced WAMUL's decision to increase the basic milk procurement price by ₹ 1/- per liter i.e. from ₹ 39/- per liter to ₹ 40/- per liter at 4% Fat and 8.5% SNF with effect from 01st March 2024.

Sarma informed that the state government will release funds for development of milk processing units in Jorhat and Dibrugarh. "Along with today's new plant at Purabi Dairy here and the two new units at Jorhat and Dibrugarh, the new JV company will also construct units in Barak Valley, Lakhimpur-Dhemaji and Nagaon. These 6 units will further satisfy the demand of milk and allied products in the state," Dr Sarma said.

Under the management of NDDB since 2008, Purabi Dairy has grown in leaps and bounds. From a meager milk procurement volume of 400 Kg per day currently it has reached volumes of over 60,000 Kg per day covering around 30,000 dairy farmers that are organised into 800 plus dairy cooperative societies across 21 districts in lower, central and upper parts of Assam. The milk procurement network primarily revolves around a transparent milk collection, measurement and payment system through installations of automatic milk



societies. Then suitable milk chilling infrastructure (to the tune of 1.22 lakh liters per day capacity) has been created at remote locations to maintain the quality of raw milk that is brought through road milk tankers to the milk processing plant of

Purabi Dairy located at Guwahati. Addressing the gathering, minister of Agriculture & AHVD, Atul Bora, said that state government has been providing all the needed support to NDDB to scale up the production of milk and help dairy farmers in the state. "Today Assam has crossed 1 lakh litre of milk production. This is a good development for the dairy section in the state. Our chief minister Himanta Biswa Sarma has taken forward a grand plan and today's inauguration is a big step towards this roadmap of Aatmanirbhar Assam. This new plant, setup collection systems at the dairy cooperative at the cost of approx. Rs 49 crore, will fur-

ther boost the dairy sector," Shri Bora said.

The milk processing plant of Purabi Dairy plays a significant role in manufacturing of fresh packed milk and various value added products such as paneer, curd, flavored milk, cream, ghee etc. At present milk and milk equivalent of products worth of around 1.05 lakh liters are being sold in the market. Over the years this processing plant has become the single largest revenue center of WAMUL enabling it to attain sales turnover of over ₹ 200 crore during the financial year ending March 2023. This is the highest revenue turnover reported by WAMUL since its inception. Further, the processing plant has catapulted WAMUL into the bracket of dairies that are consistently selling a daily quantity of over 1,00,000 litres of milk and milk equivalent of products.

In his address, Meenesh Shah, Chairman, National Dairy Development Board& WAMUL said that the new plant will enable processing of 1.5 lakh litres of milk. Earlier we used to process 60,000 litres of milk per day. The new plant will have the capacity to produce 10 MT of curd per day, 10,000 litres of lassi per day, and 2 tonnes of paneer per day. We will be able to meet the additional demand though this new plant. We have also set up an ice cream plant in this new processing plant and 2000 litres of ice-cream, of various flavours, will also be produced," Dr Shah

Previously, value-added milk products constituted 9-12% of the sales turnover for Purabi Dairy; this is now expected to increase to 20-25%. This increase will provide a tremendous impetus in terms of higher returns for the dairy farmers associated with the brand 'Purabi'

Dr Shah further stated that the expanded processing plant facility has been installed with Concentrated Solar thermal System to harness 10 lakh Kcal of energy. In simpler terms, this energy will translate into direct savings to the extent of ₹ 4.0 lakhs per month in fuel cost. The capacity expansion project of Purabi Dairy was implemented by NDDB under the World Bank aided Assam Agribusiness and Rural Transformation Project (APART) at a cost of around ₹ 49 crore

Govt. of Assam and NDDB has been instrumental in bringing dairy development in Assam through cooperatives. They have arranged financing of many dairy development interventions under various central and state funded schemes. The noteworthy among all such schemes is the World Bank aided Assam Agribusiness and Rural Transformation Project (APART) funded by Govt. of Assam to strengthen the formal dairy sector in Assam through the "Purabi Dairy" model.

Board (NDDB) is working to increase productivity so that India can account for one-third of the global milk production by 2030, its chairman Meenesh Shah said.

He said breeding, nutrition and health of animals are the main focus areas for achieving the target.

"Currently, India accounts for 24 per cent or one-fourth of total world milk production. This contributes to 4-5 per cent of our GDP. Our plan is to increase the share globally to 30 per cent or one-third of world milk production by 2030," he

Increasing the productivity of animals is crucial to achieving it, Shah said, pointing out that though India is the largest producer of milk, animal productivity is less than in developed countries.

"The Government of India and NDDB are working together on its mission to increase productivity. Breeding, nutrition and health of animals are the crucial areas in this regard," he added.

"Our milk production has been growing at 6 per cent per annum for the last fivesix years, while the global growth rate is 2 per cent. We have to maintain it," Shah

In Assam, the NDDB has formed a joint venture company with the state government to work for holistic development of the dairy sector, he said

"In the next seven years, the plan is to increase procurement of milk and bring more farmers under the cooperative move-

ment," he said. The installed capacity of West Assam Milk Producers Cooperative Society (WAMUL), which operates the popular brand Purabi, is being also increased with the opening of a new plant, Shah, who is

Conifers harbor an intricate web of tissues, encompassing vital conduits like xylem and phloem, facilitating the seamless transport of water, nutrients, and sugars throughout the entire tree. However, the unforgiving grip of harsh winters poses a threat to the life-sustaining sap, putting the delicate cell walls at risk of severe damage through freezing. In a testament to nature's ingenious design, both deciduous and evergreen trees possess a remarkable defense mechanism. Through osmotic processes, water is strategically shifted out of the living cells into the intercellular spaces, isolating the freezing threat to these non-living zones. Moreover, the sap undergoes a transformative shift, increasing its sugar concentration and adopting the consistency of a thick syrup—an innate antifreeze. This metamorphosis effectively lowers the internal freezing point of each cell, bolstering its resilience against the icy onslaught. In employing these strategic measures. Conifers ensure the safeguarding of their living cells, preventing the peril of ice rupture and securing the tree's survival through the most unforgiving winter climates.

Conifers, especially those belonging to the Pinaceae family,

bark beetles and their associated microorganisms. Their weapon of choice in this battle is a viscous resin that oozes from their bark, a versatile defense acting as both shield and sword in their fight for existence. This resin creates a formidable barrier, impeding the movement of freezing air molecules—a crucial adaptation, particularly beneficial in arid climates or during periods of drought, as it effectively conserves the tree's essential moisture. Beyond its protective role, the resin's adhesive properties ensuare infiltrating insects, while its unique chemical composition acts as a deterrent or, in some cases, an exterminator, ensuring the tree's uninterrupted growth and survival. Nevertheless, the delicate balance maintained by Conifers faces disruption due to climate change and the invasion of new species, presenting these resilient trees with novel challenges in their ongoing battle for

survival. In contrast to the expansive vascular conduits of broadleaf trees, fostering swift growth and rapid leaf turnover, conifers boast a vascular system characterized by slender tracheids. The slim profile of these tracheids restricts the formation of only tiny bubbles, which promptly dissolve back into solution, skillfully preventing the occurrence of freeze-thaw embolisms. These embolisms pose a risk after prolonged, frigid winters, as the vascular system thaws and air bubbles can form. In broadleaf trees, these bubbles may enlarge and struggle to dissolve, resulting in embolisms. However, the narrow tracheids of conifers serve as a safeguard against this, establishing them as marvels of the mountains.

Their higher suicide death rate (SDR) than men is rooted in various factors, such as differences in socially acceptable ways of dealing with stress and conflict for women and men, domestic violence, and the different ways in which poverty affects genders. In general, married women are the biggest victims of suicide deaths among women. This group becomes more vulnerable due to arranged and early marriage, early motherhood, and economic de-

Social Stigma: The social stigma associated with mental health disorders in India is a major barrier to addressing them. Stigma and a general lack of knowledge and understanding of mental health disorders prevent timely intervention. State capacities to address mental health issues are non-existent. There are approximately 5,000 psychiatrists and fewer than 2,000 clinical psychologists in the

Expenditures on mental health constitute a small portion of the total public health expenditure. India's economy is largely dependent on agriculture, and about 60% of the people are directly or indirectly dependent on it. Various reasons like drought, low produce prices, exploitation by middlemen, and inability to repay loans lead Indian farmers to commit suicide. The reason for this high number can be attributed to the lack of ecosocial,

emotional resources. More specifically, academic pressures, workstress. social place pressures, modernization of urban centers, relationship concerns, and the breakdown of support systems. Some researchers have attributed the increase in youth suicide to urbanization and the breakdown of traditional large-family support systems. Conflict of values within families is an important factor in the lives of youth.

As young Indians are becoming more progressive, their traditionalist families



tion, elder care, etc. Depression: WHO says depression and suicide are closely linked and, at its worst, India accounted for 18 percent of the total number of people suffering from depression globally in 2015. remarks, gender discrimination, etc. Caste-based discrimination and resentment from upper-caste students and teachers are common in the high-pressure environment of medical colleges as well as other higher educational

institutions in the country. The Thorat Committee report of 2007 revealed how widespread and diverse caste-based discrimination practices were at AIIMS, the country's premier medical college. Decriminalizing suicide was long overdue and welcome.

The same applies to the order of the Insurance Regulatory and Development Authority of India that insurance companies will have to make a provision in their policies to cover mental illnesses along with physical illnesses.

Concerned over the rising incidents of suicides in Indian colleges, the Human Resource Development Ministry has circulated a manual among the country's higher education institutions, asking authorities to adopt measures to prevent students from taking extreme steps. The manual lists measures such as early identification of suicidal tendencies, a buddy program, and a dou-

ble-blind helpline, where both callers and counselors are unaware of each other's identity. Other experts have suggested taking proactive steps as early as adolescence, including mental health in the school

curriculum. The Mental Health Care Act 2016 will ensure that these people have the right to live a life with dignity and will not be discriminated against or harassed by the authorities. The Supreme Court has also said that Section 309 of the IPC also violates the right to life given under Article 21 of the Constitution of India.

Firstly, stop-gap solutions of setting up expert committees and consultants in schools have not been able to address the Deep-rooted problem. causes must be addressed. The government should conduct a comprehensive study on the reasons behind these suicides.

Second, the curriculum should be designed in a way that emphasizes the importance of mental exercise and meditation. Example: Delhi government's initiative on 'Happiness Curriculum' could be a step in the right direction.

Third, 12 measures were suggested by the Justice Rupanwal Commission regarding higher education. Operationalizing equal opportunities cells with antidiscrimination officers in universities and colleges. Starting from the most "innocuous" practices of ragging "extreme harassment", such discriminatory behavior constitutes violence and is an attack on a person's human rights that prevents them from living their lives with dignity and receiving education. The person should be given psychological support and care.

sistance from NGOs as well as religious missionaries for this purpose.

Strengthening the existing National Mental Health Program and District Mental Health Program as well as focusing training resources and streamlining funding are some other recommendations to fight

depression and suicide. Finally, it is time that we revitalize our educational ecosystem in ways that inculcate new meanings, new ideas of living, and new possibilities that can transform a life of uncertainty into a life worth living. Suicide can be prevented. Young people who are thinking about suicide often give warning signs of their trouble.

Parents, teachers, and friends play an important role in recognizing these signs and getting help. Most importantly, never take these warning signs lightly. The media sometimes give intense publicity to "suicide clusters" – a series of suicides that occur mainly among young people within a short period in a small area.

These have a contagious effect, especially when they are glamorized, imitated, or incited to "mimic suicide". This phenomenon has been observed on several occasions in India, especially after the death of a celebrity, mostly a film star or politician.

The widespread media publicity given to these suicides has led to similar suicides. The methods of combat depicted in films are also not uncommon. This is a particularly serious problem in India where film stars enjoy an iconic status and exert great influence, especially on youth who often look to them as role models.

Laapataa Ladies: Cheerful ode to sisterhood

That are the odds of more than one pair newlyweds crowding a compartment of Belpur-Katariya Express on a wintry January's day?

Quite high, it turns out when auspicious stars as per the unerring Hindu calendar align

'Shubh din shaadi karke Shankar Parvati ban jaate hain,' scoffs a fellow passenger, both amused and inconvenienced, at the sorcery of shubh muhurats.

Set in 2001 in the fictional region of Nirmal Pradesh, the hinterland forms the heart of Kiran Rao's sophomore ef-

bindranath Tagore's novel Noukadubi, the ghoonghat is the source of all confusion in Rao's bridal mix-up as well. That's just about all that it

shares in common with Biplab Goswami's genial story where the ghoongat serves as a clever metaphor for all

that's obstructed from view as well as an obstacle to break out from.

Aboard Katariya Express, Deepak (Sparsh Shrivastava) is escorting his young bride Phool (Nitanshi Goel) back to her marital home in Soorajmukhi.

Huddled in the same corner as them is another newly married couple, again the same generic red dulhan's attire adorned on its nondescript bride Jaya (Pratibha Ranta).

Without meaning to, Deepak takes off with Jaya while poor Phool is left stranded at the railway sta-

What follows isn't a hacky lost and found drama but a sweet tale of sisterhood and spirit.

Often North India's perilous landscape is a hub for horror stories but in Rao's benign gaze, decency still abounds I found it remarkable how

trustworthy her idealistic setup is, where we get to see a rarely ever documented face of humanity that has helped women move around freely despite patriarchy's looming threats. Where Manju Maai

(Chhaya Kadam), the toughtalking tea seller at the railway station, takes wide-eyed Phool under her wing, a selfreliant but guarded Jaya warms up to Deepa's joint family and friends.

The reasons prompting one to conceal her whereabouts and the other not to report the incident to the cops are telling of the social strain afflicting



It paints a whimsical picture of people in the interiors governed by vishwas over vigyan. What is refreshing is how Rao abandons the smug tone underlying satirical messaging to reimagine a society still capable of fixing its follies by finding its strength in subversion

Phool and Jaya.

Rao addresses these disparities lightly in delightfully phrased fears suggesting crisis is more tolerable than cops, 'chota dukh chori, bada dukh thana'.

Indeed, the madcap attitude of a maverick inspector (Ravi Kishen in his element) at the helm of the curious case of the swapped brides is enough reason for alarm. Laapataa Ladies milks it fittingly for mirth and milieu without wavering from its objective of empowerment.

Yet, Phool's initiation into self-efficiency beyond matrimonial expectations and Jaya's agrarian skills put to good use aren't the only forces of feminism at work

The women folk (led by the elegant Geeta Aggarwal) in Deepak's family may not have the vigour of Manju Maai's no-bullshit voice but they are each other's strongest allies nevertheless.

Rao is respectfully embracing of their differences and convictions, which find a charming expression in dialogue writer Sneha Desai's lyrical play of words.

Or politics. Like a character belonging to a town relentlessly rechristened from Indirapur to Atalnagar to Mayaganj, you get the drift, winking at the state of affairs.

Laapataa Ladies is gentle yet firm in calling out the hypocrisies colouring everyday mindsets and prejudices without acquiring the highhandedness of a crusader. As its good-humouredly told story energetically advances towards its predictable but pleasant outcome, Phool and Jaya have found an ardent cheerleader in the audience.

The young girls of Laapataa Ladies are a revelation. If Pratibha's serene, sorted demeanour is tailor made for


Jaya, a teenage Nitanshi tugs at the heartstrings in all her unfeigned credulity. It's not all 'ladeez log' hogging the limelight, Sparsh


Shrivastava's warm screen presence and touching vulnerability is a welcome addition in the space. Expectedly, Chhaya Kadam and Ravi Kishen are

spot-on as the worldly-wise veterans whose respectively hard and corrupt exterior belies their goodness

Unlike Rao's savvy exploration of urban conflicts in her directorial debut Dhobi Ghat, which felt a tad too self-conscious to be fully empathetic, the film-maker is completely at home in the rustic, rooted ambiance of Laapataa Ladies.

Ship earlier attacked by Yemen's Houthi rebels sinks in the Red Sea



DUBAI, March 2: A ship attacked by Yemen's Houthi rebels has sunk in the Red Sea after days of taking on water, officials said Saturday, the first vessel to be fully destroyed as part of their campaign over Israel's war against Hamas in the Gaza Strip.

The sinking of the Rubymar comes as shipping through the crucial waterway for cargo and energy shipments moving from Asia and the Middle East to Europe has been affected by the Houthi attacks.

Already, many ships have turned away from the route. The sinking could see further detours and higher insurance rates put on vessels plying the waterway potentially driving up global in-flation and affecting aid shipments to the region.

The Belize-flagged Rubymar had been drifting northward after being attacked on Feb 18 in the Bab el-Mandeb Strait, a crucial waterway linking the Red Sea and the Gulf of Aden.

Yemen's internationally recognized government, as well as a regional military official, confirmed the ship sank. The official spoke on condition of anonymity as no authorisation was given to speak to journalists about the incident.

The Rubymar's Beirut-based manager could not be immediately reached for comment.

Yemen's exiled government, which has been backed by a Saudi-led coalition since 2015, said the Rubymar sank late Friday

safe port. The Iran-backed Houthis, who had claimed the ship sank almost instantly after the attack, did not immediately acknowledge the ship's sinking.

The US military's Central Command previously warned the vessel's cargo of fertiliser, as well as fuel leaking from the ship, could cause ecological damage to the Red Sea.

Since November, the rebels have repeatedly targeted ships in the Red Sea and surrounding waters over the Israel-Hamas war. Those vessels have included at least one with cargo bound for Iran, the Houthis' main benefactor, and an aid ship later bound for Houthi-controlled territory.

Despite over a month of US-led airstrikes, Houthi rebels remain capable of launching significant attacks. That includes the attack on the Rubymar and the downing of an American drone worth tens of millions of dollars. The Houthis insist their attacks will continue until Israel stops its combat operations in the Gaza Strip, which have enraged the wider Arab world and seen the Houthis gain international recognition.

However, In recent days, there has been a slowdown in attacks. The reason for that remains clear.

In a post on X, formerly Twitter, Zelenskyy said the deal prioritized "the provision of air defense, artillery, sea and long-range capabilities, with a particular emphasis on strengthening Ukraine's air force."

As Sweden joins NATO, it bids farewell to more than two centuries of neutrality

STOCKHOLM, March 3: Sweden's last war ended in 1814, and when the rifles and cannons it aimed at Norway fell silent, the once-warring power would not take up arms

For the next two centuries, Sweden embraced a policy of neutrality, refusing to take sides in wars or join any military alliance. It was a stance that kept peace at home and contributed to the country becoming a prosperous welfare state and humanitarian su-

This remarkably long era of nonalignment is coming to a close as Sweden joins NATO. The ceremonial formalities are expected soon, after 18 months of delays while Turkey and Hungary held up ratification and sought concessions from other members of

"Sweden is now leaving 200 years of neutrality and nonalignment behind us," Swedish Prime Minister Ulf Kristersson said after Hungary's Parliament gave its approval Monday, overcoming the final hurdle. "It is a big step. We must take that seriously. But it is also a very natural step that we are taking."
Sweden, like neighbor Finland, had long

ruled out seeking NATO membership. That changed practically overnight when Russia launched its invasion of Ukraine in February 2022. The attack sparked fears across Europe of Moscow's revived imperial ambitions — alarm that has grown as Russia

"It's the right path for us," said Jacob Frederiksen, a 24-year-old pilot, who like many Swedes has embraced NATO membership amid the breakdown of the post-World War II order that largely kept the peace for decades. "I think in this new era, it's better to be part of an alliance than being independent and neutral."

The invasion "had a shock effect on Swedish political life," said Henrik Ekengren Oscarsson, a political scientist at the University of Goteborg. He analyzed polling data showing that support for NATO membership surged from 35% in 2021 to 64% after the invasion.

"It was the largest and fastest shift in opinion that has so far been measured in Swedish political history," Ekengren Oscarsson wrote.

Still, new anxieties come with being part

of an alliance amid rising tensions between Russia and the West.

Ulrika Eklund, a 55-year-bank employee in Stockholm, said she feels uncertainty about being in NATO and the effect it will have on Sweden. But she understands why the step has been taken with "so much going on in the world and in Europe."

The country's neutrality has its roots in the early 19th century, when Europe was engulfed in the Napoleonic wars.

Though Sweden ended up on the winning side of battles against France's warrior-emperor Napoleon Bonaparte, the loss of territorial possession in Finland to Russia years earlier put an end to any illusions of Sweden continuing in a big-power role.

"After having gained Norway, the policy was aimed at staying outside the quarrels of the big powers and instead developing Sweden as a country. And that we did," said Robert Dalsjö, senior analyst with the Swedish Defence Research Agency. The policy allowed Sweden to grow, Dalsjö said, putting it on the path to a modern state after being "one of the poorest and most backward countries in Europe in the early 19th

As Sweden adjusted to its new status, King Karl XIV John declared the country's neutrality in 1834. In a letter to the courts of Britain and Russia, he urged respect for Sweden's wish to stay out of their conflicts.

Turkey rejects accusations by a human rights group that it committed abuses in Syria

ANKARA, March 2: Turkey has rejected allegations by a human rights group that Turkey bears responsibility for some of the abuses and possible war crimes carried out mostly against Kurdish residents in north-

Human Rights Watch said in a 74-page report released on Thursday that the alleged abuses were committed by Turkish forces and also by Ankara-backed armed factions in areas they control in northern

A senior Turkish Foreign Ministry official denied the accusations on Friday, insisting that the report by the New York-based watchdog "did not reflect the realities on the ground" and ignored Turkey's security concerns.

The official, who spoke on condition of anonymity in line with government protocol, also insisted that Turkey fully respects "international humanitarian law.

Since 2016, Turkey has launched three major operations inside Syria, targeting Syria's main Kurdish militia — the People's Protection Units or YPG, a U.S.- backed faction that Turkey considers to be a terrorist organization and an extension of the outlawed Kurdistan Workers Party, or

The PKK has waged a decades-long insurgency within Turkey. The conflict has killed tens of thousands of people.

The Human Rights Watch report — titled "Everything is by the Power of the Weapon: Abuses and Impunity in Turkish-Occupied Northern Syria" — documents allegations of abductions, arbitrary arrests, unlawful detention, sexual violence and

The human rights group said that it also found that the Turkish army and intelligence agencies were involved in carrying out and overseeing abuses.

The Turkish official asserted that the Syrian opposition now runs and controls areas that were cleared of militants by the Turkish forces.

The opposition had made "significant progress" in improving human rights in those areas and were cooperating with U.N. agencies, the official said. (AP)

Powerful storm in California and Nevada shuts interstate and dumps snow on mountains

RENO, March 2: A powerful blizzard raged overnight into Saturday in the Sierra Nevada as the biggest storm of the season shut down a long stretch of Interstate-80 in California and gusty winds and heavy rain hit lower elevations, leaving tens of thousands of customers with-

Up to 10 feet (3 meters) of snow is expected in some areas. The National Weather Service in Reno said late Friday it expects the heaviest snow to arrive after midnight, continuing with blizzard conditions and blowing snow through Saturday that could reduce visibility to one-quarter mile or less.

"High to extreme avalanche danger" is expected in the backcountry through Sunday evening throughout the central Sierra, including the greater Lake Tahoe area, the weather service said.

California authorities on Friday shut down 100 miles (160 kilometers) of I-80 due to "spin outs, high winds, and low visibility." They had no estimate when



the freeway would reopen from the California-Nevada border just west of Reno to near Emigrant Gap, California.

A tornado touched down Friday afternoon in Madera County and caused some damage to an elementary school, said Andy Bollenbacher, a meteorologist with the National Weather Service Han-

Some of the ski resorts that shut down Friday said they planned to remain closed on Saturday to dig out with an eye on reopening Sunday, but most said they would wait to provide updates Saturday

Earlier in the day, police sources said that four persons have been detained for questioning in connection with yesterday's low-intensity bomb blast at a Bengaluru eatery. They were picked up from Dharwad, Hubballi and eatery. (PTI)

'Several teams are working on different leads obtained so far," he said.

NAGPUR, March 2: Maharashtra BJP chief Chandrashekhar Bawankule on Saturday hit out at Congress president Mallikarjun Kharge and leader Jairam Ramesh for their "mischievous" post on Union minister Nitin Gadkari, saying their move was aimed at creating discontent in the ruling party.

Calling Gadkari an asset for the Bharatiya Janata Party (BJP), he said the Union minister has been working with Prime Minister Narendra Modi for the development of the country. He made the statement a day after

Gadkari sent legal notices to Kharge and Ramesh for allegedly sharing misleading and defamatory news contents about him on X.

Gadkari's lawyer said Kharge and Ramesh deliberately posted a 19second video clip of the minister's interview given to "The Lallantop" web portal, concealing the contextual intent and meaning of his words. The notice said Gadkari's interview was twisted, distorted and presented by uploading the video that is bereft and devoid of the contextual mean-

Addressing a press conference in Nagpur, Bawankule said, "BJP con-



demns the post shared by Congress (leaders) about Union minister Nitin Gadkari. Some people think that posting such videos will create discontent in our party. Some people have done this mischief and we have given legal notice to them...People will not spare such individuals.'

"It (the post) is an absolute lie, Nitin ji is an asset for `dev, dharm, sanskar' and our party. He has an important place in terms of development in the government," he added.

"BJP condemns the cheating done to Nitin ii. He has worked shoulder to shoulder with PM Modi ji for the

development of the poor and the country," Bawankule said.

Replying to a query on Vanchit Bahujan Aghadi (VBA) chief Prakash Ambedkar's statement that winning Nagpur Lok Sabha seat was very easy for his outfit it fights it properly, the state BJP chief said the National Democratic Alliance (NDA) will win this constituency (currently represented by Gadkari) with a huge margin.

SHIMLA, March 2: Rajinder Rana, one of the six Himachal Pradesh Congress MLAs who cross-voted in the Rajya Sabha elections and was later disqualified from the assembly, on Saturday rubbished chief minister Sukhvinder Singh Sukhu's claim that some rebel legislators want to return, asserting that at least nine party legislators were in touch with them.

He also accused Sukhu of misleading people with his statements.

No one wants to return. On the other hand, at least nine more MLAs are in touch with us," Rana told PTI.

On the other hand, Sukhu claimed that "80 per cent of the Congress is together" and the rest were dissatisfied over "trivial issues". Asked about the possibility of cross-voting if Sonia Gandhi had contested the polls instead of Abhishek Manu Singhvi, Rana said, "She has made a lot of contributions to the country and been Congress president. Had she fought from here, that would have been a different matter."

In a stunning upset for the ruling Congress in Himachal Pradesh, the BJP on Tuesday won the state's lone Rajya Sabha seat with its candidate Harsh Mahajan defeating Congress stalwart Singhvi and setting the stage for a no-trust motion in the assembly. The move by Gambhir, a former team India cricketer, came amid buzz in the BJP circles about him being possibly replaced in the East Delhi Lok Sabha constituency in the upcoming general elections. The BJP has yet to announce tickets for the seven Lok Sabha constituencies

Names of several probables, including Delhi BJP chief Virendra Sachdeva, general secretary Harsh Malhotra and state treasurer Vishnu Mittal are making the rounds as contenders for the East Delhi seat. People close to Gambhir said he was prepared to contest from the East Delhi seat this time too. However, the reason behind his sudden decision was not clear yet.

Sources claimed that Gambhir met BJP national general secretary (organisation) B L Santhosh on Thursday and his X post on Saturday might be a fallout of that. Hours before his sudden move, Gambhir

shared on X a picture of the receipt for his donation to the BJP as his contribution to PM Modi's vision of building a 'Viksit Bharat' and urged all to join the drive. Delhi BJP leaders, meanwhile, termed

Gambhir a "reluctant" politician.

"He never really got into the swing of the things related to the party. Most of the time, he missed party programmes, meetings and imporwas still his primary focus," said a senior Delhi BJP leader. The East Delhi MP was involved in a spat with Gandhi Nagar MLA Anil Bajpai over different issues. Moreover, Gambhir's relations with other leaders in his constituency were less than cordial, he claimed.

As an MP, Gambhir pursued with vigour his initiatives of running a community kitchen to provide free meals to the poor, opening libraries and focusing on the removal of the Ghazipur garbage dump.

To his credit, the East Delhi constituency represented by Gambhir gave the best results to the party in the 2020 Assembly polls and the MCD elections in 2022.

In the 2020 Assembly polls, the BJP won eight seats, three of which -- Gandhi Nagar, Vishwas Nagar and Laxmi Nagar -- were under the East Delhi Lok Sabha constituency. The party also won 21 of 36 wards in the Municipal Corporation of Delhi polls. It was the highest among the seven parliamentary constituencies

World Birth Defects Day: WHO calls for awareness on congenital anomalies, releases toolkit

NEW DELHI, March 2: On the eve of the World Birth Defects Day 2024, the World Health Organization (WHO) on Saturday highlighted the need to raise awareness about birth defects and accelerate actions to prevent, detect and manage congenital anomalies which occur during intra-uterine life of infants.

"We are reminded that every journey matters and the journey of health indeed begins before birth," Saima Wazed, WHO Regional Director for South-East Asia said in a statement.

A regional guidance document on screening newborns for three conditions -- hearing impairment, eye abnormalities, and neonatal hyperbilirubinaemia -- is being released on this occasion to facilitate capacity-building of member states, Wazed said.

She pointed out that the contribution of congenital disorders to death is increasing globally among children aged below 5

Between 2000 and 2021, the contribution of birth defects to child mortality increased in our WHO South-East Asia Region from 4 per cent to 11 per cent, and globally from 4.6 percent to 8 per cent, she said.

"Birth defects are sadly now the third most common cause of death among under-5 children in our Region, accounting for 11 per cent of the total. This is equivalent to the deaths of 300 under-5 children every single day," Wazed said.

Birth defects not only have a profound impact on individuals but also place a considerable burden on families, friends, the community and health-care systems.

The WHO regional director said while genetics plays a major role in their aetiology (study of



the causes of a disease), many birth defects are preventable through addressing environmental factors. These include exposure to pollutants, lifestyle choices and socioeconomic conditions that affect pregnant

women and fetuses Since 2014, WHO has supported all our member states to

drive rapid and sustained reductions in maternal, newborn and child mortality, which includes targeted action to prevent, detect, manage and care for birth defects, Wazed said.

An integrated approach has been adopted to implement interventions for the prevention and treatment of birth defects in existing national programmes, she "Guided by the Regional

Strategic Framework, all our member states have national plans for prevention and control of birth defects," she added. Accelerating prevention, man-

agement and care for birth defects is a priority, and we as a region have issued a "call for action" in five key areas, Wazed highlighted.

First, countries need to place birth defects high on their agenda and expand commitment and leadership at both the policy and programme levels, along with commensurate financial allocations, she said

Secondly, the new regional document and videos on universal newborn screening of three conditions -- hearing impairment, eve abnormalities and neonatal hyperbilirubinaemia -- provide

guidance on how simple bedside tests can be integrated within the existing health system, she added.

Third, focus should be laid on improving the coverage and quality of preventive interventions such as rubella immunisation, food fortification and quality pre-

conception and antenatal care. "Fourth, our Member states must work together with community-based networks, platforms and organisations, to recognize the challenges, hard work and perseverance of parents, caregivers and families of children with birth defects, and to empower them to access services and support, including social protection," Wazed stated.

Finally, member states must sustain and expand surveillance of birth defects, with a focus on improving coverage and quality of surveillance with regular data analysis and application.

The results of data analysis must be used for mobilising commitment and resources, along with improving programme implementation, the regional director said.

Aligned with the 76th World Health Assembly resolution WHA76.9 in 2023 on food fortification, our member states need to plan, implement and monitor large-scale food fortification programmes, Wazed said.

"On World Birth Defects Day 2024, WHO reaffirms its commitment to accelerate actions to prevent, detect and manage these conditions -- aligned with the "survive, thrive and transform' agenda of the Global Strategy for Women's, Children's and Adolescents' Health (2016'?2030)," she

added. The World Birth Defects Day, observed on March 3 every year, was launched in 2015. (PTI)

Strong GDP growth, weak monsoon drove up India's energy-related carbon emissions in 2023: IEA



NEW DELHI, March 2: Strong GDP growth and a weak monsoon drove up India's energy-related carbon emissions by around 190 million tonnes in 2023, though the country's per capita emissions remain far below the global average, the International Energy Agency

Global energy-related carbon emissions grew by 1.1 per cent in 2023, increasing 410 million tonnes (Mt) to reach a new record high of 37.4 gigatonnes (Gt) in 2023, the International Energy Agency (IEA) said on Friday.

It said emissions in China grew around 565 Mt in 2023, the largest increase globally and a continuation of its emissions-intensive ecogrowth post-pandemic period. Per capita emissions in China are now 15 per cent higher than in advanced economies.

However, China continued to dominate global clean energy ad-

"In India, strong GDP growth

drove up emissions by around 190 Mt. But a weak monsoon increased demand for electricity and cut hydro production, contributing around one-quarter of the increase in its total emissions in 2023. Per capita emissions in India remain far below the world average," the IEA said

India grappled with warm and dry conditions throughout 2023 and experienced a weak monsoon season, with August being the driest in at least 45 years.

In 2022, energy-related global emissions increased by 490 Mt, representing a 1.3 per cent rise.

According to the Intergovernmental Panel on Climate Change (IPCC), countries together need to cut down emissions of planetwarming greenhouse gases such as carbon dioxide and methane by 43 per cent by 2030 to limit global warming to 1.5 degrees Celsius.

The IEA noted that emissions from coal accounted for more than 65 per cent of the increase in 2023.

pacity increased by around 20 gigawatts (GW) in 2023. Despite this increase, the global generation of hydropower saw a record decline last year. This was primarily driven by severe and prolonged droughts that impacted major hydropower regions, exacerbated by the influence of El Niño -- a periodic warming of waters in the central Pacific Ocean.

Had the availability of the hydropower plant fleet in 2023 remained consistent with 2022 levels, an additional 200 terawatthours (TWh) of electricity would have been generated globally.

This would have avoided the emission of around 170 million Mt CO2 from fossil fuel-based power plants. It would also have meant that electricity sector emissions would have fallen globally in 2023, instead of rising moderately, the IEA said.

It mentioned that between 2019 and 2023, total energy-related emissions increased by around 900 Mt. Without the growing deployment of five key clean energy technologies since 2019 -- solar PV, wind, nuclear, heat pumps and electric cars -- the emissions growth would have been three times larger.

"Thanks to the growing deployment of clean energy, emissions are experiencing a structural slowdown. In the decade to 2023, global emissions grew slightly more than 0.5 per cent per year, the slowest rate since the Great Depression," the IEA said. (PTI)

Security agencies seize consignment meant for Pakistan's nuclear programme

MUMBAI, March 2: Security agencies at Mumbai's Nhava Sheva port intercepted and seized the consignment of a Karachibound ship from China after it was found carrying a dual-use consignment with implications for Pakistan's nuclear and ballistic missile programmes, officials said on Sat-

Customs officials, acting on intelligence, halted the Maltaflagged merchant ship -- CMA CGM Attila -- en route to Karachi on January 23 and, during its inspection, found that the consignment had a Computer Numerical Control (CNC) machine, manufactured by an Italian company, known for its precision and efficiency controlled by a computer

A Defence Research and Development Organisation (DRDO) team examined the consignment and confirmed its potential usage in Pakistan's nuclear initiatives. notably in manufacturing crucial components for missile development, the officials said.

CNC machines fall under the Wassenaar Arrangement, an international arms control regime aimed at curbing the spread of items with dual civilian and military applications, in which India is an active participant. The CNC machine was used by North Korea in its nuclear programme.

Further investigations showed many discrepancies in the shipping

sion tactics to conceal the true recipients. This incident follows past seizures of dual-use military-grade items being transhipped from China to Pakistan, raising concerns over illicit procurement activities.

The ongoing probe aims to as-

certain if the suspected Pakistani entities receiving these items are linked to the Defence Science and Technology Organisation (DESTO), responsible for Pakistan's defence research and devel-

The port officials, with specific intelligence, had alerted the Indian defence authorities who inspected the heavy cargo and reported their suspicions, after which the consignment was seized, the officials said and added that the seizure sible proliferation by Pakistan and

According to documents such as bills of loading and other details of the consignment, the consigner was mentioned as "Shanghai JXE Global Logistics Co Ltd" and the consignee as "Pakistan Wings Pvt Ltd" of Sialkot.

However, further investigation by the security agencies indicated that the consignment, weighing 22,180 kilogrammes, was shipped by Taiyuan Mining Import and Export Co Ltd and meant for Cosmos Engineering in Pakistan, the officials said.

This is not the first instance that Indian port officials have seized such dual-use military-grade items being shipped from China to Pak-

Cosmos Engineering, a Pakistani defence supplier, has been on a watchlist since March 12, 2022. when Indian authorities intercepted a shipment of Italian-made thermoelectric instruments, once again at the Nhava Sheva port.

Despite international conventions, the interception highlights persistent cooperation between Pakistan and China in activities that contravene global agreements, raising alarms about potential proliferation activities.

In February 2020, China was supplying autoclaves to Pakistan under the cover of an "industrial dryer".

The autoclave was seized from a Chinese ship -- Dai Cui Yun -that carried a Hong Kong flag and had left Jiangyin port on the Yangtze river in Jiangsu province of China, bound for Pakistan's Port

The seizure of the autoclave, possibly meant to be used in the missile programme of Pakistan, strengthened apprehensions that Pakistan is unabashedly indulging in illegal trade of missiles and violating the Missile Technology Control Regime (MTCR).

The cooperation between China and Pakistan in acquiring sensitive items and equipment, coupled with China's support in constructing nuclear power plants for Pakistan, has drawn scrutiny from international bodies, challenging established guidelines and control

Over 1K Amrit Bharat trains to be made in

coming years: Vaishnaw NEW DELHI, March 2: India will manufacture at least 1,000

new-generation Amrit Bharat trains in the coming years and the work to make trains that can run at a speed of 250 kmph was on, railway minister Ashwini Vaishnaw said on Saturday.

In an exclusive interview to PTI Videos, Vaishnaw also said the Railways has already started working on the export of Vande Bharat trains and the country should see the first export in the

coming five years. While speaking on the transformational initiatives taken by the Railways in the last 10 years of the Narendra Modi government, he said the world's highest railway bridge -- Chenab bridge -- and the first under-river water tunnel for Kolkata metro are some of the significant technological advancements that happened in the rail

"The railways has a huge social obligation. We carry about 700 crore people every year. Two and a half crore practically every day. The fare structure is such that if the cost of carrying a person is ₹ 100, we charge ₹45. So we give 55 per cent discount to every person who travels by railways on an average," Vaishnaw said.

Talking about affordability, the minister said, "We have designed Amrit Bharat which is a worldclass train. It provides 1,000 km of travel at a price of only ₹454. That is the kind of affordability that has been provided."

'Vande Bharat is highly popular among youths. Practically, every week one Vande Bharat is getting inducted into the fleet. We will be manufacturing at least 400 to 500 of these trains in the coming few years," Vaishnaw added. (PTI)

Farmers from landlocked areas of North Karnataka have turned their attention towards cashew as the market for the nut is increasing immensely.

"I will personally visit many places in Karnataka after assessing the viability of introducing cashew in arid districts of Karnataka. Many elite research organisations with bright minds have put in their efforts in many ways to make cashew plantations widespread in the state. Rat-hole miner rejects another house offered in Delhi's Dilshad Garden

NEW DELHI, March 2: Rat-hole miner Wakeel Hassan, who had lost his house in a demolition drive, has rejected another offer of a house in Dilshad Garden here by the authorities, he told PTI on Saturday.

"On Friday night, four government officers, including an SDM, came and offered me a house in Dilshad Garden but I refused to accept it as they wanted me to shift on a temporary basis," Hassan said.

"It was also not in writing. That house belongs to an NGO," he said.

Hours after the demolition, DDA officials offered Hassan to move to an EWS (economically weaker sections) flat at Narela, which is far from Khajoori Khas in northeast Delhi. Hassan rejected it saying

On being asked why he is rejecting the second offer as Dilshad Garden is located near Khaioori Khas unlike far-flung Narela, he said the cost of his house, which was razed by the DDA (Delhi Development Authority), was more than ₹ 1 crore and if the government wants to compensate, then the cost of the house should be

Hassan, who claimed to have been staying in Khajoori Khas for several years, had lost his house in a demolition drive by DDA on Wednesday. He along with his wife and two children

have been staying on a footpath and demonstrating against the drive

On Saturday, during the rain in Delhi, he

for his support.

While talking to PTI, he said that his belongings and household articles are lying open in the rain. "Today is the third day of my demonstration, which will continue till I get the solution from the government," he said. Hassan further said that he had bought this plot from a private person for ₹33 lakh in 2012-13.

"After buying the plot, I invested about ₹8 lakh to build the rooms and also gave money to the DDA employees. The cost of my house has now gone up to more than Rs 1 crore now," he claimed.

Veer Dev Kaushik, who lives in the same locality of Khajoori Khas near Hassan's razed house, said the locality was regularised by the Delhi government several

years ago, after which he along with many others invested money to buy the plots.

"Hassan had also invested and bought a plot here. But the corrupt DDA officials were still harassing him to get more money and when he failed to do so, his house was razed," Kaushik, a government official in Uttar Pradesh's health department, said.

Hassan was a part of the team of miners that rescued 41 construction workers trapped inside the Silkyara tunnel in Uttarakhand's Uttarkashi district by manually drilling through the debris in November last year.

Hassan told PTI on Thursday that DDA officials had said he would be provided a house, but he refused the offer as it was only a "verbal assurance". (PTI)

'Kerala govt making efforts to protect agriculture sector from corporates'

ALAPPUZHA (KERALA), March 2: The Kerala government is making relentless efforts to protect the agriculture sector and the farmers from the influence of corporates, Chief Minister Pinarayi Vijayan said on Saturday.

Addressing a massive gathering of farmers as part of the Nava Kerala Sadas here, Vijayan said even though the farmers are facing challenges, the Central government was not ready to ensure price stability of agricultural crops.

The state government is making relentless efforts to protect the agriculture sector and farmers of Kerala from the influence of agri-corporates. We are putting an end to the trends of doing away with subsidies for agriculture and raising the prices of fertilizers," Vijayan said.

Attacking the Union government, Vijayan said even laws related to agriculture are being amended in favour of the corporates in the coun-

"Even when agriculture and farmers are facing challenges, the Central government is not ready to ensure price stability of agricultural crops or efficient storage of food grains. The state government is moving forward by increasing the budget allocation for agriculture, providing assistance to farmers by interfering in the market and thus keeping agricorporates away. This is an alternative way," Vijayan said.

He claimed that the state government has intervened to modernise the agriculture sector in the state and to increase the income of the farm-

Vijayan also said that it was imperative to utilise all possible resources for the development of the agriculture sector and pointed out the importance of cooperative movements as the farmers could rely on those institutions for financial assistance. (PTI)

Health a glaring hole in election discourse, say experts

NEW DELHI, March 2: Every year, crores of Indians are pushed to the brink of financial ruin by medical emergencies, but as India gears up for the Lok Sabha polls, health remains conspicuously absent from the election discourse, feel experts.

Not only are most parties seemingly uninterested in prioritising commitments on health in their poll agenda, even the voter on the street appears to be unaware of healthcare rights, the public health experts say.

The result is that election after election, medical infrastructure and services leave a lot to be desired.

"Public health issues have traditionally not been a prominent poll agenda in India due to various factors. The most vocal sections of society 'the educated middle class'? often do not access public health services, instead preferring the private sector. Hence, demands to improve government health services are not raised strongly," Dr Abhay Shukla, national co-convenor of Jan

Swasthya Abhiyan, told PTI. Healthcare has suffered in the absence of adequate allocations in the Union budget under successive governments, the experts said.

India has a heavy disease burden

with a WHO report stating that the country accounts for one-fifth of the total deaths occurring from stroke and ischemic heart disease, especially in younger adults. Also, more than around 57 per

per cent of children (below 5 years) are anaemic, according to the National Family Health Survey 5 data, Sourindra Mohan Ghosh, assistant professor at the Council for Social Development, stated. Not only that, the NFHS data

cent of women (15-49 years) and 67

points to a wide incidence of hypertension and diabetes, while an ICMR report says that India will have 29.8 million cancer patients in 2025.

"The Public Health System on which most poor and lower middle classes depend suffer from insufficient infrastructure and persistent shortfall of public health workforce. Private health care is unaffordable. As a result, out of pocket expenditure continues to be high," Ghosh emphasised.

Budgetary allocation for health consistently remains low and has not achieved 2.5 per cent of GDP as recommended under the National Health Policy 2017 and 15th Finance Commission. Allocation for health




has remained stagnant at around 2 per cent of the Union Budget in the last few years, according to the Centre for Budget Governance and Ac-

countability. If health still remains absent from the election manifestos of political parties it may be "because for most people, lack of employment, low income, absence of social security and rising cost of living assume priority", Dr K B Saxena, former Ûnion health secretary, told PTI.

These affect daily lives "unlike health issues that become critical only when one falls ill and unable to work", he said

Dr Shukla said the situation was expected to change after the experiences of the Covid pandemic, since all sections of society suffered in various ways due to difficulties in accessing lifesaving care, and unaffordable costs of private hospitalisation during peak outbreaks. But the "Covid pandemic has

changed nothing", argued Dr R V Asokan, IMA president. "Neither the government investment in health nor the healthcare



dend as the impact is indirect and delayed". According to Dr Anoop Saraya, former head of department of Gastroenterology at AIIMS, a part of the issue has to do with how the healthcare system underwent a transforma-

tion in India "Healthcare system in India has undergone a transformation from its initial government-funded structure to a privatised and corporatised healthcare system and underfunded public sector wherein 80-85 pc of outpatient and more than 60 per cent of inpatient care is provided by pri-

This transformation has resulted in a system where the most vulnerable segment bears the brunt.

According to Dr Asokan, a major reason health continues to be neglected "is the short memory of the people.

"As far as the parliamentary elec-

tions are concerned the Covid pandemic should have been an election issue. The infrastructural deficiencies and the gaps in human resources were glaring. Yet it is also true that the government managed the supply chains of masks etc. well and rolled out a vaccine programme which was the envy of other countries," he said.

According to Dr Yogesh Jain, a physician and co-founder of Jan Sawasthya Sahayog and Sangwari in Chhattisgarh, people are keen to get the right treatment from the available health system, at any cost only when they fall sick.

"When we are healthy and are not acutely sick, individually or even collectively, we don't seem to feel the need for health care. Thus, demand and struggle for health care in future remains un-articulated," he

While the Modi government is showcasing its flagship Ayushman Bharat health insurance scheme, claiming 6.22 over crores hospital admission worth ₹79,174 crore have been authorized under it till now. some experts feel that such schemes only strengthen the private health sector at the expense of the public health sector. (PTI)

CA chief Hockley denies reports Big Three ignored study to save Test cricket

SYDNEY, March 2: Cricket Australia CEO Nick Hockley on Saturday rebutted reports that India, England and his organisation had not paid attention to a draft presented to the International Cricket Council to save Test cricket.

A report in the Sydney Morning Herald said that the three powerful boards were dismissive of a document compiled by New Zealand Cricket chair Martin Snedden, who proposed an overhaul of the future tours program (FTP) to save the longest version of the game.

"Categorically, I think there was some misreporting around that. Certainly, the discussions I'm in at the moment are very much thinking about how we

can optimise the calendar and Wellington and conveyed to how we can continue to grow cricket around the world." Hockely told SEN Cricket.

The changes proposed in the blueprint document include additional windows for T20 leagues other than the Indian Premier League, alteration in the World Test Championship points system, 40-over ODIs, apprehensions about T20Is and an effort towards pooling of broadcast rights revenue for bilateral series.

Hockley, when asked about the report, denied suggestions that the powerful nations were turning a blind eye to Test cricket, saying he had met Snedden during the New Zealand-Australia first Test in

him that Australia was very much committed to help ICC ensure all the three formats flourish. "We had a great catchup with Martin (Snedden) here yesterday (Friday in Wellington)," Hockley said.

'We're very much involved with that piece of work. I think at Cricket Australia we've got good influence and I think we've got a really important role to play around the ICC in terms of driving strategy.

"I think that Cricket Australia has been behind many of the developments. Whether that's the introduction of the World Test Championship. I'm on the FTP working group with the ICC, and making sure that we're



keeping all three formats healthy and strong, that we're growing the game in all territo-

Pointing out the growth of cricket across the world, Hockley said countries like the United States too had embraced

Indian boxers renew quest for Paris Olympic quotas in Italy

NEW DELHI, March 2: The seasoned Shiva Thapa, Deepak Bhoria and Nishant Dev will be among nine Indian boxers fighting it out for Paris Olympic berths at the 1st World Qualification Tournament, starting in Busto Arsizio, Italy on Sunday.

Seven men and two women from India will be aiming to secure Olympic berths at the qualifiers being conducted by the Paris 2024 Boxing Unit (PBU), an ad-hoc body created by the International Olympic Committee Executive Board.

The tournament has 49 quota places on offer and a boxer will be assured of a Paris ticket after reaching the semifinals.

In the women's 60kg category, however, there will be a box-off between the losing semifinalists to decide the Olympic berths as only three spots are available.

While several boxers have already obtained quota places via their respective continental events, there are many worldclass pugilists including Colombia's Yuberjen Martinez and Tomoya Tsuboi of Japan in the men's 51kg, reigning 57kg world champion Makhmud Sabyrkhan of Kazakshtan and Olympic silver medallist Yoel Finol of Venezuela, who will be keen to seal the deal in Italy this month. wealth Games bronze medallist jeet (92kg)

Pogba has tough fight against 4-year ban judging by doping cases in soccer and for other stars

GENEVA, March 2: The four- or negligent for a positive test, year ban imposed on Paul Pogba — a 2018 World Cup winner with France and once the most expensive player in soccer history — in a doping case that could end his career has shocked soccer.

It was also entirely in line with bans in similar recent cases in soccer, including two cases prosecuted by FIFA from qualifying games for the 2022 World Cup and a UEFA case detailed on Friday by the Court of Arbitration for Sport

Top-ranked athletes in other sports, including Grand Slam tennis champion Simona Halep and Russian figure skater Kamila Valieva, also have their careers on hold while their lawyers challenge four-year

bans in doping cases. Four years has been routine since 2015 when the world antidoping code was updated. Since then, the code also lets bans be reduced or overturned if athletes can show they were not at fault or were contaminated.

"The feedback at that time. including among many athletes, was that a more robust default sanction was needed," the World Anti-Doping Agency said

on Friday in a statement. Pogba will be the latest case going to appeal at CAS, to challenge his ban imposed on Thursday by an Italian sports tribunal for a positive test for DHEA, a steroid precursor.

On Friday, the court in Lausanne, Switzerland, published a detailed ruling in the doping case of an international soccer player that helps show the narrow path to a reduced ban.

A four-year ban was imposed by UEFA on Bulgaria winger Georgi Yomov, who tested positive for an anabolic steroid at a Europa Conference League game in July 2022 when aged

Yomov's argument was to blame his brother, who was said to have crushed steroid pills into smoothies made in a blender they both used at their parents' home. With no proof to back the theory, and other inconsistencies in evidence noted by the CAS judges, the appeal failed.

The three judges were split 2-1 and noted a four-year ban for Yomov "may be said to be harsh," the 33-page court ruling

"That said, the majority of the panel is bound to apply the rules, of which the player was aware, as they are set out," the CAS judges said. "There is no scope to act otherwise."

In a different soccer doping case at CAS, judges were swaved by parts of a player's argument of contamination by an anabolic steroid and cut his UEFA ban to two years.

Dinamo Zagreb player Arijan Ademi tested positive after a Champions League win over Arsenal and was able to persuade judges he had no intent to dope. Ademi could show he checked with team doctors about the supplement he used.

Few details of Pogba's case have been confirmed officially and the Italian tribunal judges could take another month to give him their detailed rea-

"When I am free of legal restrictions the full story will become clear, but I have never knowingly or deliberately taken any supplements that violate anti-doping regulations," the France midfielder wrote on Thursday on his Instagram ac-

Pogba turns 31 on March 15 and his appeal to CAS could take at least several months to be heard and longer to reach a

The timeline of Halep's case has frustrated the former No. 1ranked player, who was at CAS from Feb. 7-9 for an appeal hearing to challenge her ban for a positive test at the 2022 U.S.

The 32-year-old Romanian has blamed a contaminated sup-

Valieva was banned for four years by a CAS panel in January. She tested positive for a banned heart medication that was belatedly revealed at the 2022 Beijing Olympics where she was a 15-year-old star.

A strawberry dessert made by her grandfather said to be taking the medication was offered as an explanation in court — another unproven excuse of contamination by food preparation that did not work at CAS.

'There are too many shortcomings in the evidence," the CAS judges said in the Valieva ruling, which is being challenged at Switzerland's supreme court in Lausanne.

Pogba's case has been dealt with relatively fast so far, but likely still has a long way to go. The Juventus player's agent is standing by him.

"Wise beyond his years," agent Rafaela Pimenta wrote of Pogba on Instagram, "clean to the soul." (AP)

AIFF legal head accuses President Chaubey of corruption

NEW DELHI, March 2: All India Football Federation's (AIFF) Principal legal advisor Nilanjan Bhattacharjee on Saturday made serious "corruption allegations" against president Kalyan Chaubey, who termed them baseless and said he

would take legal action. In a letter written to Prime Minister Narendra Modi, Bhattacharjee said Chaubey worked out "corruption avenues" through non transparent ten-

der process and preferential allotment of tender. Bhattacharjee also alleged that Chaubey made attempts to "siphon off money from the federation's exchequer" and used AIFF fund for personal expenses.

"...through coercion and at his own subservient interest, allotted numerous tenders such as broadcasting of I-League (last season), IWL, Santosh Trophy in favour of one (company; name withheld) which happens to be close to the incumbent president," Bhattacharjee wrote in the letter, which is in possession of PTI.

"Further tenders running into crores were allotted to the same service provider for broadcasting of futsal and other such tournaments," he wrote in the letter, a copy of which was also marked to home minister Amit Shah and sports minister Anurag Thakur. He said even the tender for the ongoing Santosh Trophy was also given to the same entity.

Bhattacharjee claimed that when he suggested safeguards in subsequent tenders, Chaubey attempted to "malign" his image and professional

"Crores of money have been spent by the current president for his personal trips, hotel stays. For his numerous Bangalore trip alone, a conservative estimation of more than Rs 40 lakhs has been spent to fund his business class travel, local conveyance and hotel stays." Phillips' maiden five-wicket total comprised the wickets of Usman Khawaja (28), first-innings centurymaker Cameron Green (34), Travis Head (29), Mitch Marsh for a first-ball duck and Alex Carey (3). Matt Henry took 3-36 as Australia was bowled in less than

Australia still increased its overall lead to 368 after leading by 204 on the first innings. At stumps New Zealand was 111-3 and 257 runs behind.

Rachin Ravindra reached a half century from 77 balls just before stumps and was 56 not out at the close of play and Daryl Mitchell was 12.

Australia struck a major blow when it

last session. Williamson fell to Nathan Lyon, the off-spinner who likely holds the key to the match.

After being run out for 0 in the first innings, Williamson was caught by Steve Smith at leg slip from a ball that bounced more than he expected. Smith moved to first slip and caught Will Young (15) off Head as New Zealand's hopes of winning began to melt away.

Ravindra revived those hopes a little before stumps with his first half century in his first match against Australia. The only previous time he passed 50 in his test career, he made 240

A New Zealand win remained unlikely and of the three possible results still in play an Australia win is most probable. A draw also looms as a possibility as rain is forecast for most of the fourth day.

New Zealand's highest successful fourth-innings run chase in New Zealand is 324 and the current target would represent the 10th-highest successful chase in the history of test cricket. Still, Phillips' incredible contribution in the middle session when four of his five wickets fell helped save some face for New Zealand after it was bowled out for 179 in reply to Australia's 383.

New Zealand captain Tim Southee threw the ball to Phillips as his first spin option of the second innings. New Zealand didn't take a specialist spinner into the match but relied on Ravindra who took 1-24 in the first innings.

Southee then backed Phillips who bowled his 16 overs without a break.

"It's a dream come true absolutely," Phillips said. "Tim (Southee) is an incredible captain and he really gives me the confidence to go out there and stick to my plan and also gives you the chance

dismissed Kane Williamson for 9 in the to be able to miss every now and then. As a spinner you really need that.

"The bowling unit today really stuck to the things we wanted to stick to. Partnership bowling all the way."

Phillips has a reputation in the New Zealand team as a player who can make things happen in all three formats: a hard-hitting middle-order batsman, an athletic fielder and now as a serious bowling option. He had taken only 11 wickets in his five previous tests with a best of 4-53.

When Green became his fifth victim, brilliantly caught by Will Young under the helmet at short leg, Phillips set off on a long, jubilant run around the Basin Reserve, finally ending the Henry's arms.

"I've got a six-year-old daughter and any celebration a six-year-old girl would do, that's probably me," Phillips said. "I've never really thought what to do if I got a five-for but the emotion, the way the crowd went up. It was just an unbelievable moment.

Phillips acknowledged New Zealand's chance of winning the test is slight but happy to able to give his team a chance.

"I understand we've got to combat the situations that are out there," he said. "Obviously there's a bit of turn so it's a matter of how we go about combating (Nathan) Lyon. The way their big fast bowlers bowl as well is going to be a challenge.

"I definitely think we've got the time on our hands to be able to pull this off." Australia resumed Saturday at 13-2 after losing Steve Smith and Marnus Labuschagne late on the second day. Nathan Lyon was once again a useful nightwatchman and he made 41 before he fell in the first session and Khawaja also was out stumped before lunch. (AP)






