Narendra Modi is not a Hindu. Nevertheless, it is also evident that Lalu had not done so," the RJD patriarch had also stated. Prasad Yadav has always opposed Hinduism and is ignorant of Hindu

Notably, Lalu Prasad asked, "What can we do if Narendra Modi does not have a family of his own?" at a Patna gathering of the INDIA Opposition group in response to the Prime Minister's charge that dynastic politics are being used to weaken opposition parties, especially the RJD.

Oppn parties in Assam seek meeting with Modi over CAA

GUWAHATI, March 5: Opposition parties in Assam have sought an appointment with Prime Minister Narendra Modi during his visit to the state later this week to apprise him of the "volatile situation likely to arise" if the Citizenship (Amendment) Act or CAA is implemented.

A letter seeking an appointment with PM Modi was dispatched by state Congress chief Bhupen Borah, who is also the president of the United Opposition Forum of Assam (UOFA) which represents 16 opposition parties.

"There is a strong perception among the people of Assam irrespective of caste, creed and political affiliation that the Citizenship Amendment Act 2019 will put in danger the culture, history, socioeconomic condition, social fabric and identity of Assamese people," said the letter, a copy of which was shared with the press on Tuesday.

"Moreover, the said Act will go to nullify the historic Assam Accord of 1985, which is regarded as the lifeline of Assamese people," it

The UOFA deems it urgent to apprise the PM about the "volatile



in the coming days", the letter said. The opposition parties have sought an appointment with Modi at the earliest, proposing to meet him during his scheduled visit to the state on March 8-9.

The letter mentioned the protests against the CAA in 2019-20, before the outbreak of COVID-19, in the state, during which five persons were killed and several others in-

The UOFA had last week announced that a state-wide bandh will be called the very next day the contentious Act comes into force, followed by 'gherao' of state secretariat Janata Bhawan.

Murmu, saying they would undertake a "democratic mass movement" across the state if the CAA is not repealed.

Other organisations have also announced that they will begin protests demanding the repeal of the Act.

situation as 'tragic', India wants to restore normalcy



SEOUL. March 5: Union external affairs minister S Jaishankar on Tuesday said what happened in Manipur is "truly tragic" while underlining that the entire people of India wish to see normalcy return to the northeastern state.

Jaishankar was addressing the Indian community here this evening as part of the first leg of his four-day visit to South Korea and Japan.

Among the multiple questions about India and the issues related to the Indian diaspora, one of the community members asked him about the situation in Manipur.

"In terms of how did this happen? How did the government let this happen? You know there cannot be anybody who would not regret what is happening there. I mean, what's happened there is truly tragic and it is tragic because of the close intermingling of communities, which leads to this degree of violence, which becomes

very difficult to head off," the minster said. "I think, the entire wishes of the country are very much with Manipur, I mean, people would like to see normalcy returns, they would like to see law and order get back," Jaishankar said, adding, "This is not the India, and certainly not the northeast, which anybody is hoping for."

Manipur has witnessed escalating violence between Meiteis and the Kuki communities since May 3, 2023 with 219 casualties reported after a 'Tribal Solidarity March' in the hill districts protested the Meitei community's demand for Scheduled Tribe (ST)

The Meiteis, constituting around 53 per cent of Manipur's population, reside predominantly in the Imphal Valley. The tribals, including Nagas and Kukis, who comprise 40 per cent, primarily inhabit the hill districts.

Answering the question, Jaishankar said, "This (the situation in Manipur) is something which we take very much to heart" and mentioned how the open border with Myanmar was one of the issues and how India suspended the earlier unique system where people could travel up to 16 km either way without travel documents. "We have unfortunately decided now to suspend that and, actually, in a way, harden the border situation. It unfortunate," he added. (CONTD. ON PAGE-2)



Google agrees to reinstate delisted Indian apps on Play Store after govt intervention

has agreed to reinstate all the delisted apps of Indian companies on its Play Store after a government intervention got the two sides talking to resolve a dispute over service fee payments.

Telecom and Information & Technology Minister Ashwini Vaishnaw, who got Google and the startups to the negotiating table, said the US tech giant has been supporting India's technology development journey.

"Google and the startup community have met with us, (and) we have had very constructive discussions...Google has agreed to list all the apps," he said.

Google had on Friday removed from its Play Store apps from a dozen of developers, including popular ones by Matrimony.com and job search app Naukri, for non compliance with its in-app payment guidelines.

As the government took strong exception to the removal, calling it unacceptable, Google beginning Saturday restored some apps that agreed to comply with its guideline to pay a fee of 11-25 per cent on in-app payments or do financial transactions outside of the app.

Vaishnaw and Minister of State for Information and Technology Rajeev Chandrasekhar held multiple rounds of discussions with Google and the app owners on



they need". The government thereafter called the two sides for a meeting on Monday to resolve the issue.

At the heart of the problem is Google's in-app fee. While Google says the fees help develop and promote the Android and Play Store ecosystem, startups say the tech giant was forcing them to use its payment system and pay a fee, failing which they were being offloaded by Play Store.

Antitrust body Competition Commission of India had previously ordered Google not to mandatorily enforce an earlier system of charging 15-30 per cent.

11-26 per cent on in-app payments. It removed the apps that weren't paying the fee after the Supreme Court did not provide interim relief to companies behind these apps in their battle against the search giant's platform fees.

While removing the apps Google had on Friday stated that some Indian companies had chosen not to pay for the "immense value they receive on Google

Among the worst hit by the removals is Matrimony.com which has seen more than 140 of its apps being dropped from Play Store. Other apps removed included Balaji Telefilms' Altt (formerly ALT-Balaji), audio platform Kuku FM, dating service Quack Quack, and Truly Madly.

Info Edge saw its job search app Naukri and real estate search app 99acres removed but they were back the next day when it moved to Google's consumption model, where any payment made is done outside of the app.

Google had briefly removed popular payments app Paytm from its Play Store in 2020 citing some policy violations. That led to a widespread industry cry and startups joining hands to mount legal challenges against the tech giant. They even joined hands to launch

On Monday, the rupee settled 1 paise lower at 82.90 against the US dollar.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, rose 0.05 per cent to 103.83.

"In Guwahati, 2,745 cases were lodged in a single year. But the police cannot look at those and solve them as the biggest criminal for them is Bhupen Borah.

"Earlier, other Congress leaders were also issued notices for their alleged role in violence in the yatra, but everything went silent after they joined the BJP. However, I am not going to join the BJP," he said in an apparent reference to former Assam Congress working president Rana Goswami, who has recently joined the ruling party. On January 23, Congress workers in the presence of Gandhi and other leaders broke police barricades, which were put up after the CM threatened to file an FIR if the yatra attempted to enter the main Guwahati city.

The party workers clashed with the police, who used mild lathi-charge to control the situation but failed to

protect the barricades. Several police personnel and party workers were injured in the scuffle. After dismantling the barriers, the Congress workers, however, did not proceed further with Gandhi stating that they "can break barricades, but will not break the law" and moved through its permitted route along NH-27 in Guwahati.

Following this episode, the chief minister called the action "Naxalite-style" and instructed the police to register a case. The Guwahati Police lodged a suo motu FIR against Gandhi and other leaders for "wanton acts of violence". Sarma even announced that the "instigators", including Gandhi, would be arrested after the Lok Sabha polls as he did not want to "politicise" the issue before the general elections.

Along with Gandhi, several other senior Congress leaders, including KC Venugopal, Jitendra Singh, Jairam Ramesh, Srinivas BV, Kanhaiyya Kumar, Gaurav Gogoi, Bhupen Kumar Borah and Debabrata Saikia, have also been named in the FIR.

The chief minister, who also holds the home department in the state, later announced that a special investigation team (SIT) will be formed to probe the case and accordingly, it was handed over to the CID.

The case was initially filed at the Basistha Police Station under 10 different sections, including non-bailable ones, such as 120B (criminal conspiracy), 143 (unlawful assembly), 147 (rioting), 188 (disobedience of order), 283 (causing danger, obstruction or injury) and 332 (causing hurt to deter public servant from his duty) of the IPC. Section 3 of the Prevention of Damage to Public Property Act, 1984 for alleged mischief causing damage to public property has also been slapped in the FIR.

Similarly, another FIR was registered against 'Bharat Jodo Nyay Yatra' organisers including KB Byju, Assam Congress Chief Bhupen Kumar Borah and others for allegedly deviating from its permitted route inside Jorhat town, leading to a "chaotic situation" in the area.

The Jorhat Police issued notices to the accused persons and several of them have already been interrogated. Referring to the police cases against him and other Congress leaders in Assam, Gandhi had dared the BJPruled state to file "as many cases as it can", asserting that he would not be intimidated. The yatra, led by the Congress MP, commenced from Manipur on January 14 and will culminate on March 20 in Mumbai

The Assam leg of the march, which started on January 18 and concluded on January 25, traversed 833 km in 17 districts. The yatra plans to cover 6,713 km in 67 days while passing through 110 districts in 15 states. (PTI)

Jaishankar terms Manipur

Before specifically answering the question about Manipur, Jaishankar recounted how the current dispensation at the Centre changed the mere talk about Look East and Act East into practice and implemented a number of projects there. "If you look at how difficult it was to travel, if you see the sort of level of business, the attention given, the resources given, it was actually very disturbing. And that has been one of the changes of the last 10 years," he asserted.

There is obviously everybody today is ... distressed is a very mild word ... for what is happening in Manipur. So, I do feel in many respects, northeast itself can act as a bridge, but it has both a cultural side to it and a physical contiguity side too," he said. Jaishankar then mentioned the developmental works in the region carried out over the last decade and how India-Bangladesh are now witnessing "railways, roadway, trains, waterways" connectivity; goods are going to Bangladesh port, electricity is being supplied etc. "So, it has given that whole area, I would say, a kind of a boost."

Jaishankar then added that India is trying if similarly, connectivity with Bhutan can be enhanced. He also mentioned India's decision last week to three projects for semiconductor manufacturing, of which one is going to be in Assam. "To me, to see a major production, that too high technology production project, coming up in the Northeast ... it is a big statement," Jaishankar added.

Earlier in the day, after reaching Seoul, the external affairs minister called on South Korean Prime Minister Han Duck-soo among other things. He will be co-chairing the 10th India-South Korea Joint Commission Meeting (JCM) with his counterpart Cho Tae-yul on Wednesday. (PTI)

'Positively' considering UNRWA

As a mark of its solidarity with the Palestinian refugees, Kamboj said India enhanced its annual contribution to the agency from USD 1.25 million to USD 5 million in 2018. Since then, India has been regularly making this contribution to the UN agency annually, which goes to support its core programmes and services, including education, healthcare, relief and social services provided to Palestinian refugees.

She, however, noted that the recent allegations against UNRWA are a "matter of serious concern".

"We have noted that the secretary-general has announced a time-bound investigation into all such allegations," Kamboj said. India also noted the constitution of an independent review group led by the former foreign minister of France Catherine Colonna to go into the working of the UNRWA. Kamboj said India looks forward to getting UN secretary-general Antonio Guterres was "horrified" regarding the "extremely serious allegations" which

implicated several UNRWA staff members in the terror attacks of October 7 in Israel.

The secretary-general, in consultation with UNRWA commissioner-general Philippe Lazzarini, appointed an independent review group to assess whether the agency was doing everything within its power to ensure neutrality and to respond to allegations of serious breaches when they are made.

The UN has said it is taking swift action following the allegations and an investigation by the UN's Office of Internal Oversight Services (OIOS) was immediately activated.

Separately, addressing another UNGA meeting, Kamboj said India has been "deeply troubled by the conflict in Gaza that has been raging for nearly five months now." She added that the humanitarian crisis has deepened, and the region and beyond have seen rising instability. "The ongoing conflict between Israel and Hamas has led to large scale loss of civilian lives, especially women and children...this has also resulted in an alarming humanitarian crisis. This is clearly unacceptable," Kamboj told the UN General Assembly meeting on the Use of Veto. The General Assembly held the plenary debate on 'Use of the veto' after the US cast a veto in the UN Security Council last month, leading to the failure of the 15-nation Council to adopt a resolution calling for a humanitarian ceasefire in the Gaza war. Kamboj told the UNGA that India's position on the conflict has been clear and Delhi has strongly condemned the deaths of civilians in the conflict. "It is critical to prevent further escalation of violence and hostilities. It is imperative to avoid the loss of civilian lives in any conflict situation,'

She underlined that it is imperative that humanitarian aid to the people of Gaza be scaled up immediately to avert a further deterioration in the situation. India urged all parties to come together in this endeavour, welcoming efforts of the UN and international community in this regard. India has provided humanitarian aid to the people of Palestine and will continue to do so.

Kamboj said India is cognizant of the fact that the immediate trigger of the conflict was the terror attacks in Israel on October 7, which were "shocking and deserve our unequivocal condemnation.

India has a longstanding and uncompromising position against terrorism in all its forms and manifestations. There can be no justifications for terrorism and hostage-taking. We demand the immediate and unconditional release of all hostages.'

India has repeatedly emphasised that only a two-state solution, achieved through direct and meaningful negotiations between both sides on final status issues, will deliver an enduring peace. "India is committed to supporting a two-state solution where the Palestinian people are able to live freely in

an independent country within secure borders, with due regard to the security needs of Israel," Kamboj said. To arrive at a lasting solution, India urged for immediate de-escalation, eschewing violence, the release of all hostages, avoiding provocative and escalatory actions, and to work towards creating conditions for an early resumption of direct peace negotiations. (PTI)

India's services sector growth eases in February on softer expansions in business activity, sales

NEW DELHI, March 5: The services sector growth in India moderated in February amid softer expansions in business activity, sales and jobs, a monthly survey said on Tuesday.

The seasonally adjusted HSBC India Services Business Activity Index registered 60.6 in February, down from 61.8 in January. In Purchasing Managers' Index (PMI) parl-

ance, a print above 50 means expansion, while a score below 50 denotes contraction. "India's services PMI suggests that the pace of expansion in the services sector eased in Feb-

"Due to a slowdown in growth in new orders and output, services companies' outlook for future business activity, while remaining strongly positive, weakened slightly," Lam added.

Lam further noted that prices charged for services rose at the slowest rate in 24 months as input prices inflation moderated. On the employment front, companies created

jobs on the back of rising workloads, but the easing of capacity pressures and lower confidence towards the outlook dampened employment growth.

Meanwhile, the HSBC India Composite PMI Output Index slipped from a six-month high of 61.2 in January to 60.6, indicating a softer but sharp rate of expansion. Composite PMI indices are weighted aver-

ages of comparable manufacturing and services PMI indices. Growth of private sector sales likewise remained sharp in spite of softening since Janu-

ary, the survey said. Rates of expansion were broadly similar at manufacturers and services firms, though the former registered an acceleration and the latter a slowdown, it added. (PTI)

Death threat to Kutumba Surakshya Parishad president, FIR lodged

GUWAHATI, March 5: The Kutumba Surakshya Parishad lodged an FIR with Geetanagar PS against a miscreant who threatened parishad president Satya Ranjan Borah with dire consequences.

Talking of deployment of NATO forces in Ukraine war is preposterous

he world took a step closer to global war this week with President Emmanuel Macron's public speculation about deploying NATO forces to fight Russia in Ukraine. The French leader made it clear that there was, unsurprisingly, no consensus or agreement on the matter. But even raising the possibility is deeply dangerous and irresponsible.

NATO has been giving Ukraine full backing throughout the conflict, in terms of armaments, economic aid and diplomatic support. Special forces, including British, have been deployed near combat zones.

However, the direct use of Western armed forces would mean NATO was effectively at war with Russia. The catastrophic potential consequences of fighting the power with the most nuclear warheads in the world scarcely need spelling out. That Macron has floated this alarming trial balloon reflects two facts - Ukraine is not winning the war; and the divided West is not yet ready to seriously consider peace talks.

On the battlefield, Ukraine's much-trumpeted counter-offensive last year achieved little. Russia has made limited gains, most recently around Avdiivka, at considerable cost, without obtaining a strategic breakthrough.

a strategic breakthrough.

In the Black Sea, Ukraine has performed better, denying the Russian fleet the expected control of the waves. Neither side appears to have the air superiority necessary for sustained advances.

Nevertheless, the tide overall has turned in Russia's favour. The US arms, without which Ukraine could not long fight, have been held up by Republicans in Washington. NATO sanctions have not had the anticipated impact on Russia's economy, and most of the world persistently refuses to align with Washington over the conflict.

This should be a moment for a ceasefire followed by peace negotiations. Several things stand in the way, however.

On the Russian side, war aims remain unclear. Former president, and present deputy Security Council chair, Dmitri Medvedev said at the weekend that Russia would someday need to march on Kiev again. He asserted that the Zelensky government must be brought down and threw in a claim for Russian control over the port of Odessa for good measure.

It is obvious that having failed to achieve any of these objectives by force, Russia is not going to secure them through negotiation. Nor is there any mood in Kiev at present to make the necessary concessions to end the fighting. The larger obstacle, however, is the determination of Washington and its allies to prolong the war as part of a global strategy to maintain the hegemony of Western imperialism.

The US and Britain are habitually in the bellicose lead. They seek to block ceasefires in Ukraine and Gaza alike, and they are champions of confronting China in the Pacific. Anglo-US policy is endless war.

That France is now upping the rhetoric around Ukraine is additional cause for alarm. Rather than bring the agony to an end by seeking to address Russia's real security concerns, while supporting Ukraine's sovereignty and the rights of its minorities, it seeks to pursue the chimaera of a Russian defeat.

Such a defeat is not only highly improbable; the pursuit of it is reckless in the highest de-

Perhaps Macron hopes that by rattling the sabre of a direct rather than a proxy war Russia might moderate its conduct or ambitions. That seems far less likely than a continuing escalation with the Ukrainian people the principal losers.

The Ukraine crisis may not arouse the same intense feelings as Israel's barbarism in Gaza, but it is in large part the product of the same policies and the same forces driving NATO imperialism. The labour and anti-war movements must give a clear rebuff to Macron's warmongering. (IPA Service)

The manner in which the information technology has outpaced even our wildest dreams is manifest in the fast-paced growth of AI in technically all fields of human existence.

The manner in which AI-generated content that can impersonate anyone with alarming accuracy has also set the alarms bells ringing. This when coupled with how this technological advancement could be misused for unlawful activities I also very scary. One domain which could be affected the most in particular using this technology is the manner in which it could be deployed political parties to influence their

voters or malign their opponents. This technological advancement is known as Deepfakes. While developers could argue that their technology is evolving and mistakes are inevitable, the rapid rise of deepfakes, particularly those used for sexual harassment, fraud, and political manipulation, poses an existential threat to democratic

processes and public discourse.

Deepfakes could be exploited for non-consensual exploitation, financial deception, political disinformation or the dissemination of falsehoods, and they could endanger not only the integrity of individuals but also the very foundations of democratic soci-

Further, they corrode trust, manipulate public sentiment, and have the potential to incite widespread chaos and violence. From 2019 to 2023, the total number of deepfakes surged by 550%, as revealed in the 2023 State of Deep-

fakes report issued by Home Security Heroes, a US-based organ-

With elections slated in more or less half of the world, the potential for deepfakes to sow discord and undermine trust in institutions is more significant than ever. Various efforts are underway to combat this threat. Initiatives like the "Tech Accord to Combat Deceptive Use of AI in 2024 Elections" at the recently held Munich Security Conference (MSC) represent a commendable effort to confront the challenges presented by deepfakes in electoral processes.

By uniting leading tech companies, the accord presents a unified stance against malicious actors, showcasing a shared determination to address the issue. Beyond mere detection and removal, the agreement encompasses educational initiatives, transparency measures, and origin tracing, laying the groundwork for comprehensive and enduring solutions.

However, the accord's focus on the 2024 elections may overlook the on-going evolution of the deepfake threat, potentially necessitating adjustments beyond the specified timeframe.

The efficacy of the accord also hinges on its ability to keep pace with the latest advancements. While the accord establishes guiding principles, it lacks concrete mechanisms for enforcement. Ensuring accountability among participating companies is essential for meaningful progress. Relying on self-regulation from tech companies raises concerns about potential biases in implementation, underscoring

the need for transparent and impartial oversight. The era of the deepfake campaign has already begun. And as generative AI gathers ubiquity and sophistication, the fraying of social cohesion throughout the West in recent years may soon feel quaint by comparison. Rather than stoke outrage, tribalism, and conspiratorial thinking among voters, these new digital tools might soon breed something arguably much worse: apathy.

The concern stems from some of the recent deepfake incidents. The concerns come after a series of recent deepfake incidents involving top Indian film stars and public figures. This prompted the government to work out a "clear, actionable plan" in collaboration with various social media platforms, artificial intelligence companies and industry bodies to tackle the issue.

Reportedly, PM Narendra Modi has said that deepfakes were one of the biggest threats faced by the country, and warned people to be careful with new technology amid a rise in AI-generated videos and pictures.

Meanwhile, Global Risks Report released by World Economic Forum in January 2024, warns thatas polarisation grows and technological risks remain unchecked, 'truth' will come under pressureEmerging as the most severe global risk anticipated over the next two years, foreign and domestic actors alike

will leverage misinformation and disinformation to further widen societal and political divides.

The report further says that as close to three billion people head

The report further says that as close to three billion people head to the electoral polls across several economies – including Bangladesh, India, Indonesia, Mexico, Pakistan, the United Kingdom and the United States – over the next two years, the widespread use of misinformation and disinformation, and tools to disseminate it, may undermine the legitimacy of newly elected governments.

The resulting unrest could range from violent protests and hate crimes to civil confrontation and terrorism. Misinformation and disinformation is a new leader of the top 10 rankings this year. No longer requiring a niche skill set, easy-to-use interfaces to large-scale artificial intelligence (AI) models have already enabled an explosion in falsified information and so-called 'synthetic' content, from sophisticated voice cloning to counterfeit websites.

Moreover, in Western countries in particular, an even deeper governance issue might be playing even now. Basically, AI may also accelerate a decades-long erosion of civic engagement and social capital, particularly in liberal democracies - where citizens tend to be more secular and self-oriented and have smaller family

networks than in other societies, like in the East.

It is predicted that Generative AI will lead to even greater social fissures, by allowing more and more individuals to bypass complex human interactions and exchanges and contests of ideas that form the bedrock of democracy. In this background, the generative AI might echo your thoughts and will tell you what you want to hear, putting a complete end to human interactions, grasp and execution.

This highlights the darker side of the generative AI in future yet to come. The citizen's ideals, inputs and actions might be marred at the local, national and international issues and may force them to completely opt out of the normal civic life, by creating a false picture in their minds, akin to human being controlled by machines, though in the democratic scenario it will be the political leaders not machines, who'll control the electorate through false narratives. Thus, it may portend an end of human intervention at all levels in all fields and manipulative leaders could use the generative AI to create empathy in their favour amongst the wider electorate and thus influence the outcome of electoral battles in a completely corrupt manner. Uttrakhand's Uniform Civil Code is a mere extension of highly controlled lives Indian women lead

The provocation being offered by the recent Uniform Civil Code (UCC) legislation, passed in Uttarakhand on February 7, 2024, on the penal requirement to register live-in heterosexual relationships, needs a matching and appropriately hard-hitting response. As it stands, rightwing conservatives find it easy to dismiss constitutional arguments that permit consenting adults to be in a relationship without interference from the state or caste and community, as middle class, 'woke' and out of touch with the real India or Bharat as they prefer to call it today. To my mind, both positions are problematic.

The criticism that the compulsory registration process, six months into or out of a partnership, infringes the right to privacy and illegitimately criminalises and infantilises adult relations, does not go far enough. Divested of all culpability, the underlying cultural presumptions of the regulation have not come up for public discussion at all.

The live-in relationship in India, let's be very clear, rides on the back of the moral and statistical norm of heterosexual marriage, obligatorily "arranged" even by oneself, with the 'correct' person of the opposite sex. The parental and community surveillance the UCC authorises for the live-in relationship is not very different from that already in place for the Indian arranged marriage.

Penal intrusion into the bedrooms of adult persons 'living in sin' is possible to outsource in a society which polices the bedrooms adults can or cannot enter via marriage. Middle class 'woke' rhetoric has been quick to cancel the anachronism of one but not the other.

The statistical incidence of free spirits entering bohemian relationships with partners they are 'allowed' to marry, remains next to negligible in India.

The regulatory harassment is really that of a separate minority of couples made up of predominantly mixed caste, mixed faith or otherwise 'wrong' partners, cohabiting in a 'cringeworthy' manner. It makes political sense for the state to keep tabs on them, only against the backdrop of majoritarian marriage – a parentally blessed, public, celebratory and endogamous union.

Ironically, for a government which wants to de-colonise India, the emphasis on marriage as the only healthy and normal sexual, cohabiting relationship possible between two adults – a man and a woman – remains an imperial legacy.

Indeed, as my own research has shown, for the post Mutiny Crown government of 1857, the quest for uniformity was itself a punitive strategy by which to civilise, sanitise and subdue a defiant and extremely diverse native society. Enforcing western conjugal adult norms of monogamy was predicated, however, on a colossal error — the confusion of the vast and bewildering variety of pre-pubertal sacramental 'marriages'

extant in India as unions of the same kind as the rulers' own – legal contracts involving long engagements, mutual consent and the necessity for 'love' to morally justify adult sexual cohabitation.

In reality, the Victorian and the Hindu unions were not logically comparable at all. The rituals of marriage which all clean, caste Hindu girls underwent, bore no immediate, intrinsic or inherent connection with heterosexual love or even sexual consummation.

Cross-culturally speaking, they were more in the nature of baptisms. Boys performed the sacred thread ceremony, girls performed the 'marriage' ceremony, to count as full members of a particular caste society.

That is why even the 'diverse' counter-intuitive, matrilineal customs of marriage – whether to an absconding bridegroom, or to a deity or a sword or to a Brahmin guru from a different household – were all pre-pubertal and totally respectable community events. One only needs to have watched ITV's Downton Abbey to understand the colossal difference between the traditional variety of Hindu ceremonies and the uniform English understanding of marriage.

Never ones to balk however, the imperial rulers rushed in where angels fear to tread. The obnoxious Contagious Diseases Act (CDA) of 1868, was unleashed in an attempt to stamp out all but western styled nuclear, male headed family systems. Unions not focused around the heterosexual marital



couple were stigmatised as perpetuators of promiscuity, polygamy, even "hereditary" prostitution.

"Unmarried" women — whether abandoned widows or poorer, vagrant, less privileged single women — were incarcerated in Lock Hospitals as a source of venereal disease for British soldiers in cantonments, unaccompanied by wives under law. The Act however was condemned in Britain itself and finally repealed in 1886 through the efforts of British suffragettes, its draconian business in India left half finished.

A second weapon aimed at standardising the Hindu family systems to meet the western norm, was the Age of Consent Bill (1891), which sought to portray pre-pubertal marriage ceremonies as in fact perpetuating pederasty and criminal rape. But here too, after many long years of protest and Assembly deliberations, now by the upper castes, the government only managed an escalation of the age of consent from the existing 10 to 12 years!

The Bill's civilisational purpose, however, had been served – to demean the Hindus for bes-

tiality towards child wives and women. Stoked into nationalist anger over the Bill, Tilak's Home Rule agitation (1916) and later The Sarada Act of 1928, under a triumphant native leadership now, put an end to the age of consent controversy by removing the justification for "child marriage" – the bar was raised to a clear post-menarche age of 14 for women.

Today, child marriage, in its original pre-pubertal sacramental sense, is illicitly followed by some communities but by and large the samskari obligation that a girl's first menarche must be preceded by a baptismal ceremony of marriage has thankfully lost its sacred force.

Why, then, the continual hiking of the age of consent post the Sarada Act? If we are to go by the authoritarian motivations of the imperial government, fixing biological age limits to the formal or informal practice of heterosexual coupling achieves "uniformity" most efficiently.

Currently, the minimum age of marriage – 18 for women – is threatening to go up to even 21. The idea is to criminalise more and more 'wrong' unions as forms of "child marriage".

The criminal law courts' repeated advisory that the government rethink lowering the age of consent has gone unheard. The persecution in Assam of many young, 'differently' married men, as criminal rapists of technically underage but sexually mature wives, continues.

Charges of rape are largely initiated by parents of the girls, despite their protestations in court that the relationship was consensual and one of love. Now with the Uttarakhand UCC, the surveillance of adult live in relationships, will bring in more and more 'wrong' unions into the ambit of criminal prosecution.

The post-colonial, largely virginal, legal marriage of today bears the marks of good old Indian jugaad. Thankfully, it is not child marriage any more. But equally, is it morally and not merely biologically, 'adult'?

The astonishing statistic that almost the entire female population in the critical age group of 25-29 is married (94.3% according to 2001 census and 91.2% in 2011), points to traditional obligatory, family and community sentiments behind the 'child marriage' of yore having carried over into the modern, adult avatar as well.

The UCC's assumption, under the banner of gender rights, that young women are more likely to face a brutal fate at the hands of their live-in lovers is skewed. Matching the high percentage of the population of women that are married in India, is the other, dismally high percentage of married

women who take their own lives, compared to other cultures, testifying to the pressure to not only marry but to stay married.

National Crime Records Bureau's data on 'accidental deaths and suicides' records that between 2014 and 2020, women who were currently married accounted for a whopping 63•1% (28,085 of 44,498) suicide deaths among women in India.

Marriage in India unfortunately does not ensure a more protected, happier young womanhood. The suffering of women routinely violated, killed and even burnt within the sacred legal confines of marriage cannot be denied a voice and strategically wished away to justify UCC's uncalled for regulation of informal unions.

Under criminal law, the death or harassment of a woman within the first seven years of marriage makes a man automatically vulnerable to charges of domestic violence, even murder and dowry death. The realities of a young bride, living with a husband who is really a stranger, under the control of his own parental household, is there for everyone to see in this legal prescription. In India, almost all women are born, menstruate and marry under the benevolent and benign dictatorship of parents. In such a context, the Uttarakhand UCC's determined attempt to put the screws on free consensual living together, based on love and mutual attraction between an adult man and woman, is not entirely surprising. Wedding season: Hacks to darken your mehndi naturally

It's the season of weddings, and who doesn't like the hands with some beautiful mehndi on them? Mehndi ki raat is one of the most important pre-wedding ceremonies.

Functions like Haldi, Sangeet, and Mehndi are celebrated with great pomp and show. As for weddings, it is celebrated as part and parcel of the wedding, where intricate designs are painted on hands and feet. Henna or mehndi is a part of wedding rituals and is said to bring prosperity to newlyweds. It is believed that the darker the stain, the deeper the bond. That is one reason brides are keener to get a brilliant and dark mehndi stain. It is stated that Mehndi is a fertility symbol and is hence utilized in wedding rituals. Majorly, the mehndi ceremony is a very special function for a bride. From the design of the mehndi to the writing of the name of the groom, the bride takes care of almost everything to perfec-

You have been patiently sitting through the mehndi application and the hard part is over now you want your mehndi to be dark and bold but have no idea how to do so

These tips might come in handy. You can get the deep dark colour of henna naturally through simple ways and easy steps. Before applying henna, it is important to clean the skin and apply moisturiser. This way, there won't be any effect of chemicals on your

skin. Try to minimise the use of soap on the hands to keep the colour long-lasting.

colour long-lasting.

Leave the henna
for a longer duration

Natural henna is initially light orange and then darkens considerably after a day or two. That is why it is always recommended to get Mehndi done 2 days before the big event. Keeping the henna for a longer duration helps in lock-

ing colour and yields better results. You can even keep it overnight by covering your mehndi with socks or wrapping your hands in cling film to keep the mehndi intact all night. Once you wash off the henna, dip your hands in cold water for two minutes. Cold water closes the skin pores and may seal the colour for a longer time Fumes of clove: Running your hands over the fumes of cloves will help with the penetration of the mehndi on your palms.

Take a few cloves and heat them on the pan over a medium flame. You can take clove smoke to make the colour of Mehndi completely dark. The fumes of the cloves will dry up the lemon and sugar mixture and help lock in the colour of the henna for a long-lasting design. The fumes work wonders when used with the lemon and sugar mixture.

sugar mixture.

Another ingredient which is added to the henna mixture in some parts of India is walnut husk, which also gives a nutty brown colour and adds to the henna colour, making it last longer. All kinds of acidic substances, like tamarind, vinegar, etc., have been added to henna, but lemon juice is the most popular. Using lemon and sugar mixture on your hands and feet post application of mehndi will make the mehndi design richer and dark. Also, be sure not to overuse

the mixture. Boil some water with sugar in it. Add lemon drops to it. Apply your mehndi as it is and once it dries; apply this mixture on top of the mehndi designs at least thrice on your mehndi. The sugar keeps the mehndi in contact with the skin for deeper penetration, while the lemon juice acts as a catalyst for dye release and deep penetration of colour. Lemon juice is added to the henna to bring out the colour. You can mix the henna in a glass, ceramic or plastic bowl, using a plastic spoon. Since henna becomes dry easily and cracks, it tends to fall off in pieces. That is why sugar is added, to make it stick to the skin for a longer time. Apart from lemon juice and sugar, many people also add coffee and tea water, to get a richer colour. The tan in tea is said to help the colour.

These ingredients are added to the henna powder and mixed into a paste with warm water. A few drops of jasmine oil is also added, so that the mixture is not too sticky. After mixing the henna, wrap it and seal it. Keep it in the refrigerator overnight. Henna stains the skin easily. If you wish to apply it on the nails, first clean your nails and trim them. Push back the cuticles. Soak the fingers in warm water for 10 to 15 minutes. This softens the nails and skin around it and the henna paste is better absorbed.

Apply oil
Once the mehndi has dried, rub your hands together gently until all of the mehndi has been removed. Protect your

mehndi with a layer of coconut oil, mustard oil cocoa butter, Vicks or mango pickle oil.

oil.

It will stimulate the henna for deep penetration into the skin. After applying henna, avoid waxing or shaving on that part. Many methods are

used for applying mehndi, starting from toothpicks and match sticks to cones and stencils. After applying the henna, if small bits fall off, just fill in with more of the paste. The longer the paste is kept, the darker the colour. The henna paste should be removed by scraping it off. It should not be washed off.

As far as the designs are concerned, there is immense variety. Fine lines, floral, paisley and highly intricate designs are done, with great detail. The artistry is such that it can only be admired. Sometimes, no designs are followed and the paste is applied to cover the entire hand. During weddings, women in India cover the palms, forearms, feet and even the lower part of the legs with intricate henna designs.

Henna, of course, has several benefits. Research has revealed that it is a natural antiseptic and anti-irritant. It is still used in Ayurveda to soothe and heal heat rashes and skin allergies. It has been used for treating burns, bruises, cuts and skin inflammations. Used on the hair, it has been known to control scalp disorders like dandruff, itching and related conditions. 6 THE HILLS TIMES France becomes the only country to explicitly guarantee abortion as a constitutional right

PARIS, March 5: French lawmakers on Monday overwhelmingly approved a bill to enshrine abortion rights in France's constitution, making it the only country to explicitly guarantee a woman's right to voluntarily terminate a pregnancy

The historic move was proposed by President Emmanuel Macron as a way to prevent the kind of rollback of abortion rights seen in the United States in recent years, and the vote during a special joint session of France's parliament drew a long standing ovation among lawmakers.

The measure was approved in a 780-72 vote in the Palace of Versailles, Abortion enjoys wide support in France across most of the political spectrum, and has been legal since 1975.

Many female legislators in the hall

smiled broadly as they cheered. While a small group of protesters stood outside the joint session, there were jubilant scenes of celebrations all over France as women's rights activists hailed the measure promised by Macron within hours of the Dobbs ruling by the U.S. Supreme Court in 2022.

The U.S. decision has reverberated across Europe's political landscape, forcing the issue back into public debate in some countries at a time when far-right nationalist parties are gaining influence.

Both houses of France's parliament. the National Assembly and Senate, had separately adopted a bill to amend Article 34 of the French Constitution, but the amendment needed final confirmation by a three-fifths majority in the special joint



session. The measure specifies that "the law determines the conditions by which is exercised the freedom of women to have recourse to an abortion, which is guaranteed.'

The French measure is seen as going a step further than was the case in the former Yugoslavia, whose 1974 constitution said that "a person is free to decide on

having children." Yugoslavia dissolved in the early 1990s, and all its successor states have adopted similar measures in their constitutions that legally enable women to have an abortion, though they do not explicitly guarantee it.

In the lead-up to the vote, French Prime Minister Gabriel Attal addressed the more than 900 lawmakers gathered for the joint session in Versailles, and called on them to make France a leader in women's rights and set an example for countries around the world.

"We have a moral debt to women," Attal said. He paid tribute to Simone Veil, a prominent legislator, former health minister and key feminist who in 1975 championed the bill that decriminalized

"We have a chance to change history," Attal said in a moving and determined speech. "Make Simone Veil proud," he said to a standing ovation.

None of France's major political parties have questioned the right to abortion, including Marine Le Pen's far-right National Rally party and the conservative Republicans. Le Pen, who won a record number of seats in the National Assembly two years ago, said on Monday that her party planned to vote in favour of the bill but added that "there is no need to make this a historic day."

A recent poll showed support for abortion rights among the French public at more than 80%, consistent with previous surveys. The same poll also showed that a solid majority of people are in favour of enshrining it in the constitution. A group of about 200 anti-abortion protesters gathered soberly in Versailles ahead of the vote, some holding a banner

reading: "I too was an embryo." A larger crowd of women's rights activists gathered at Trocadero Plaza overlooking the Eiffel Tower, letting out a collective cry of joy as the vote results came in. Others celebrated around France even before the joint parliamentary session began. Sarah Durocher, a leader in the Family Planning movement, said Monday's vote is "a victory for feminists and a defeat for the anti-choice activists."

"We increased the level of protection to this fundamental right," said Anne-Cécile Mailfert of the Women's Foundation.

The country expects to create over 12 million jobs

China retains 5 per cent growth target for 2024 as economy struggles to shake off slowdown

BEIJING, March 5: Grappling with economic slowdown and dwindling business sentiment, China on Tuesday fixed a modest growth target of around five per cent this year with a pledge to create 12 million jobs amid growing concerns over rising unemployment.

The country expects to create over 12 million jobs in urban areas and keep the surveyed urban unemployment rate at around 5.5 per cent this year, Chinese Premier Li Qiang said in his maiden work report presented to the opening session of the country's rubber-stamp parliament, the National People's Congress (NPC).

The week-long NPC annual session at the Great Hall of People was attended among others by Chinese President Xi Jinping besides over two thousand delegates from across the country to deliberate and legislate on key initiatives needed to strengthen the growth of the secondlargest economy, which continued with post COVID-19 slowdown.

A proactive fiscal policy and a prudent monetary policy will be continued, with the ratio of deficit to gross domestic product (GDP) set at three per cent and the government deficit to rise by 180 billion yuan (USD 26 billion) from the 2023 budget figure, Li said in his 39-page work report.

This is the first work report by Li who succeeded Li Keqiang last year. As a staunch Xi loyalist, Li Qiang has discarded the decade-old practice of addressing the media at the end of the annual parliament sessions. Last year China posted 5.2 per cent GDP, exceeding the official target of around five per cent amid mounting market concerns, waning investor confidence, a protracted property market slump, and a weak private sector progress. Significantly, last year the government stopped publishing data on unemployment for the first time amid reports of a deepening

However, in January the National Bureau of Statistics (NBS) said the jobless rate for the 16 to 24 age group

stood at 14.9 per cent in December. Playing down the concerns over the slowdown of the world's second-



largest economy, Li in his work report said, "We secured a smooth tranin epidemic response following a major, decisive victory in the fight against COVID-19".

He said the main goals and tasks for economic and social development in 2023 were accomplished, and the government made steady progress in pursuing high-quality development, maintained overall social stability, and made solid advances in building a modern socialist country in all respects. "Overall economic recovery and growth were boosted. China's gross domestic product (GDP) surpassed 126 trillion yuan (about USD

18 trillion) an increase of 5.2 per cent, ranking China among the fastest-growing major economies in the world," he said. A total of 12.44 million urban jobs were added, and the average surveyed urban unemployment rate stood at 5.2 per cent, he said. "Looking back at 2023, we can see that as we faced an array of interwoven difficulties and challenges, China's economy grew in a wave-like fashion amid twists and turns. Indeed, our achievements did not come easily," Li said. China also has to grapple with sluggish global economic recovery.

"Geopolitical conflicts became

eralism were on the rise, and the external environment exerted a more adverse impact on China's development," he said.

Domestically, owing to the impact of a three-year COVID-19 pandemic, many difficulties facing the country's economic recovery and development had yet to be resolved, he said. While deep-seated, long-standing issues became more pronounced, many new developments and emerged. A drop in external demand coincided with a lack of domestic demand, and both cyclical and struc-

tural issues arose, he said. "Risks and potential dangers in real estate, local government debt, and small and medium financial institutions were acute in some areas," he said, referring to the prevailing crisis in the property sector after some of the top real estate firms like Evergrande which has expanded aggressively to become one of China's biggest companies by borrowing more than USD 300 billion collapsed

1 Indian killed, 2 injured in anti-tank missile attack in Israel's north

JERUSALEM, March 5: An Indian national was killed and another two were injured on Monday when an anti-tank missile fired from Lebanon struck an orchard near Israel's northern border community of Margaliot, officials said.

All three victims hail from the southern state of Kerala.

The missile hit a plantation in Margaliot, a moshav (collective agricultural community), in the Galilee region in the north of Israel around 11 am on Monday, Zaki Heller, spokesperson for rescue services Magen David Adom

Patnibin Maxwell from Kollam in Kerala was killed in the attack. His mortal remains were identified in Ziv hospital, official sources said.

Bush Joseph George and Paul Melvin were injured and taken to hospitals for treatment, they said.

"George was taken to the Beilinson hospital in Petah Tikva after suffering injuries on face and body. He underwent an operation, is recovering well, and has been kept under observation. He could speak with his family in India," an official source told PTI.

Melvin was slightly injured and is hospitalized at Ziv Hosdistrict of Kerala. MDA earlier said one for-

eign worker was killed and seven others were injured in the attack. The attack is believed to

have been carried out by the Shi'ite Hezbollah faction in Lebanon, which has been launching rockets, missiles, and drones at northern Israel daily since October 8 in support of Hamas amid the ongoing war in the Gaza Strip.

MDA said seven foreign workers were injured altogether in the attack, two of them seriously, and were taken to Beilinson, Rambam, and Ziv hospitals in their ambu lances and Israeli Air Force helicopters.

Israel Defence Forces (IDF) on Monday said they responded by shelling the launch site with artillery.

The IDF also said it struck a Hezbollah compound where members of the group were gathered in the southern Lebanon town of Chihine, and another site belonging to Hezbollah in Avta ash-Shab. Hezbollah has been launching attacks on Israel's northern communities and military posts since October 8 saying it is doing so to support Gaza.

Ukraine claims it has sunk another Russian warship in the Black Sea using high-tech sea drones

KYIV, March 5: Ukraine claimed on Tuesday it has sunk another Russian warship in the Black Sea using high-tech sea drones as Kyiv's forces continue to take aim at targets deep behind the war's front line. Russian authorities did not confirm the claim.

The Ukrainian military intelligence agency said a special operations unit destroyed the large patrol ship Sergey Kotov overnight with Magura V5 uncrewed vessels that are designed and built in Ukraine and laden with explosives. The patrol ship, which Ukraine said was hit near the Kerch Strait, reportedly can carry cruise missiles and around 60 crew.

The Ukrainian claim could not immediately be independently verified, and disinformation has been a feature of the fighting that broke out after Russia's full-scale invasion of its neighbour in February 2022.

Kyiv's forces are struggling to keep the better-provisioned Russian army at bay at some points along the largely static 1,500-km (930-mile) front line, but are also taking aim at targets deep beyond the battlefield.

Last month, Ukraine claimed it twice sank Russian warships using drones. On Feb 1, it claimed to have sunk the Russian missile-armed corvette Ivanovets, and on Feb 14 it said it destroyed the Caesar Kunikov landing ship. Russian officials did not confirm those claims. Kviv officials say some 20% of Russian missile at-

tacks on Ukraine are launched from the Black Sea, and hitting Russian ships there is embarrassing for Almost a year ago, the flagship of Russia's Black Sea

Maldives president says no Indian troops to remain on his island, not even in civilian clothing



MALE, March 5: Stepping up his anti-India rhetoric, Maldives President Mohamed Muizzu has affirmed that no Indian military personnel, not even those in civilian clothing, would be present inside his country after May 10, a media report said on Tuesday.

Muizzu's statement comes less than a week after an Indian civilian team reached the Maldives to take charge of one of the three aviation platforms in the island nation, well ahead of the March 10 deadline agreed by the two nations for the withdrawal of Indian military personnel.

Addressing the Baa atoll Eydhafushi residential community during his tour across the atoll, the President stated that due to his government's success in expelling Indian troops from the country, people who spread false rumours, are attempting to twist the situation, a news portal Edition.my reported.

"That these people [Indian military] are not departing, that they are returning after changing their uniforms into civilian clothing. We must not indulge such thoughts that instil doubts in our hearts and spread lies," the portal quoted Muizzu, widely regarded as a pro-China leader, as saying.

"There will be no Indian troops in the country come May 10. Not in uniform and not in civilian clothing. The Indian military will not be residing in this country in any form of clothing. I state this with confidence," he said, on a day when his country signed an agreement with China to receive free military aid.

Earlier last month, after a high-level meeting in Delhi on February 2 between the two sides, the Maldivian foreign ministry said India would replace its military personnel operating the three aviation platforms in the Maldives by May 10 and the first phase of the process would be completed by March 10.

In his maiden address to Parliament on February 5, he made similar remarks. There are 88 military personnel manning the three Indian platforms that have been providing humanitarian and medical evacuation services to the people of the Maldives for the last few years using two helicopters and a Dornier aircraft. Muizzu rode to power last year on an anti-India stance and within hours of taking oath demanded India to remove its personnel from the strategically located archipelago in the Indian Ocean.

Edition.mv further reported that while the first troops to depart the country are the Indian military personnel operating the two helicopters in Addu City, the military personnel present in Haa Dhaalu atoll Hanimaadhoo and Laamu atoll Kahdhoo are also expected to leave ahead of May 10. India had agreed to remove their troops from Maldives under the condition that a number of their civilians equivalent to the military presence are brought to operate the air-

UN envoy says 'reasonable grounds' to believe Hamas committed sexual violence on October 7

UNITED NATIONS, March 5: The UN envoy focusing on sexual violence in conflict said in a new report on Monday that there are "reasonable grounds" to believe Hamas committed rape, "sexualized torture," and other cruel and inhumane treatment of women during its surprise attack in southern Israel on October 7.

There are also "reasonable grounds to believe that such violence may be ongoing," said Pramila Patten, who visited Israel and the West Bank from January 29 to February 14 with a ninemember technical team.

Based on first-hand accounts of released hostages, she said the team 'found clear and convincing information" that some women and children during their captivity were subjected to the same conflict-related sexual violence including rape and "sexualized

The report comes nearly five months after the October 7 attacks, which left about 1,200 people dead and some 250 others taken hostage. Israel's war against Hamas has since laid waste to the Gaza Strip, killing more than 30,000 people, according to Gaza's Health Ministry. The UN says a quarter of Gaza's 2.3 million people face starvation.

Hamas has rejected earlier allega-

tions that its fighters committed sexual assault.

Patten stressed at a press conference launching the report that the team's visit was not to investigate allegations of sexual violence but to gather, analyze and verify information for Secretary-General Antonio Guterres' annual report on sexual violence in conflict and for the UN Security Council.

Her key recommendation is to encourage Israel to grant access to the UN human rights chief and the Independent International Commission of Inquiry on the Palestinian territories and Israel "to carry out full-fledged investigations into the alleged violations" — and she expressed hope the Security Council would do this.

Patten said the team was not able to meet with any victims of sexual violence "despite concerted efforts to encourage them to come forward." While the number of victims remains unknown, she said, "a small number of those who are undergoing treatment are reportedly experiencing severe mental distress and trauma."

However, team members held 33 meetings with Israeli institutions and conducted interviews with 34 people including survivors and witnesses of the October 7 attacks, released hostages, health providers and others.



Based on the information it gathered, Patten said, "there are reasonable grounds to believe that conflict-related sexual violence occurred during the October 7 attacks in multiple locations across Gaza periphery, including rape and gang rape, in at least three loca-

Across various locations, she said, the team found "that several fully naked or partially naked bodies from the waist down were recovered mostly women - with hands tied and shot multiple times, often in the head."

While this is circumstantial, she said the pattern of undressing and restraining victims "may be indicative of some forms of sexual violence."

At the Nova music festival and its surroundings, Patten said, "there are reasonable grounds to believe that multiple incidents of sexual violence

took place with victims being subiected to rape and/or gang rape and then killed or killed while being

"There are further accounts of individuals who witnessed at least two incidents of rape of corpses of women," Patten said. "Other credible sources at the Nova music festival site described seeing multiple murdered individuals. mostly women, whose bodies were found naked from the waist down, some totally naked," some shot in the head, some tied to trees or poles with their hands bound.

On Road 232 - the road to leave the festival - "credible information based on witness accounts describe an incident of the rape of two women by armed elements," Patten said. Other reported rapes and gang rapes couldn't be verified and require investigation.

"Along this road, several bodies were found with genital injuries, along with injuries to other body parts," she said. "Discernible patterns of genital mutilation could not be verified at this time but warrant future investigation.

She said "the mission team also found a pattern of bound naked or partially naked bodies from the waist down, in some cases tied to structures including trees and poles, along Road 232." (AP)

The arrest was made after an FIR was received in Kharkutta police station on February 24. Prior to this, there was also a social media posting on February 7 saying that GNLA has regrouped.

"We have seized mobile phones from their possession, which were used in the crimes. They have demanded ₹ 20,000 from a person in North Garo Hills." Sangma informed.

Stating that more arrests will take place in the coming days, the SP said, "There were around 7-8 members in this regroup so we will not be sparing them, we will be going after them." (NNN)

Drugs worth ₹ 300 crore seized Faculty researcher from in last two years in Meghalaya

SHILLONG, March 5: Drugs worth over ₹ 300 crore have been seized from Meghalava in the last two years even as director general of police (DGP) Dr LR Bishnoi said the problem is still very serious in view of the state's close proximity with the Golden Triangle.

"Nearly ₹ 300 crore drugs have been recovered in the last two years of which ₹ 75 crore drugs were recovered in 2022, ₹ 170 crore in 2023 and ₹ 21 crore during the first two months of 2024," Bishnoi told reporters.

A total of 26 kgs of heroin was seized in the last two years. This includes 7.5 kgs of heroin in 2022, 16.3kgs in 2023 and nearly 1 kg heroin in January-February, 2024.

The recovery and seizure of marijuana has gone to 4,750 kgs in 2024 (the seizure was made by Ri Bhoi police) from 1400 kgs in 2023 and 3987 kgs in 2022.

The DGP also felicitated the Ri Bhoi police for their achievement in seizing first grade ganja on Sunday.

'The operation done by Ri Bhoi police and seizing 4750 kgs pure grade marijuana and mainly the initial point was Tripura and from this it was passing through Meghalaya and we were able to nab the culprits and now the case is under investigation," he said.

The recovery of yaba tablets have also increased during the period in which nearly 19000 tablets were recovered in 2022, 60,000 tablets recovered in 2023 and 2000 tablets in 2024. The seizure of other psy-

USTM discovers new plant in Lohit district



HT Bureau GUWAHATI, March 5: Researchers from the University of Science and Technology Meghalaya (USTM), in association with researchers from CSIR-Northeast Institute of Science and Technology, Jorhat, have recently identified and described a novel flowering plant named "Begonia naraharii B.Hajong, N.Bhat & P.Bharali". This discovery took place in the Lohit district of Arunachal Pradesh.

Hajong, PhD Scholar at CSIR-NEIST have spotted and collected some interesting individuals belonging to the genus Begonia of the family Begoniaceae. They were helped and guided by Dr. Pankaj Bharali, Senior scientist at CSIR-NEIST.The specimens were packed and brought to the laboratory for analysis. After critical evaluation of these specimens and comparing them with all the known species of Begonia in the

Given its restricted habitat and potential threats such as agricultural and urban expansion, habitat loss from fires, and timber extraction, the species requires conservation measures. Additionally, certain species of Begonia contribute to ecological balance by providing habitat and sustenance for various

Tripura CM announces additional 5 per cent DA for state govt employees

AGARTALA, March 5: Tripura chief minister Manik Saha on Tuesday announced an additional 5 per cent dearness allowance for state government employees and pensioners. It will benefit 1,06,932 employees and 82,000 pensioners of the state government, he told the assembly.

Manipur makes renaming places without govt approval punishable offence

IMPHAL, March 5: The Manipur assembly has passed a bill that seeks to make renaming places without approval of the competent authority a punishable offence.

Chief minister N Biren Singh had moved the 'The Manipur Names of Places Bill, 2024' in the assembly on Monday, and it was unani-

mously passed in the House "The Manipur State Government is serious about protecting our history, cultural heritage and the legacy passed down by the ancestors

and forefathers. "We will not tolerate renaming and misusing names of places without consent and those guilty of the offence will be awarded with strict legal punishment," Singh said in a post on X,

after the bill was passed. According to the bill, a punishment of a maximum three-year jail term and a fine of Rs 3 lakh can be awarded to those found guilty of renaming villages/places without approval of

the government. Singh said as per the bill, a committee would be set up, which would be tasked with approving any change in names of places in the northeastern state.

The committee will also look into any change in names of hills, lakes, rivers, historical structures and medical institutions. (PTI)

Pradesh government on Tuesday removed Renuka Mishra as the chairperson of the UP Police Recruitment and Promotion Board amid allegations of the question paper of a constable recruitment examination being leaked.

Mishra has been put on the "wait list" after her removal from the post and Director Vigilance Rajiv Krishna given the additional responsibility of the board, official sources said. Following allegations of paper leak, the state government had on February 24 cancelled the police constable recruitment examination held on February 17 and 18, and ordered a re-test within six months. More than 48 lakh candidates appeared for the examination. The government had also announced that a Special Task Force (STF) of the Uttar Pradesh Police would probe the matter.

In a post in Hindi on X, Uttar Pradesh Chief Minister Yogi Adityanath on February 24 had said, "There can be no compromise with the sanctity of examinations. Those who toy with the hardwork of youngsters will not be spared under any circumstances. Strictest action is certain to be taken against such unruly elements.'

More than 240 people were arrested or detained by police across Uttar Pradesh for allegedly planning to use or adopting unfair means before or during the police recruitment exam -- between Feb-

Rajesh Mishra joins BJP

NEW DELHI, March 5: In a setback to the Congress ahead of the Lok Sabha Sabha polls, its prominent leader from Uttar Pradesh Rajesh Mishra joined the BJP here on Tuesday, hailing Prime Minister Narendra Modi's leadership.

Mishra, a former Congress MP from the Varanasi Lok Sabha seat, joined the BJP here in the presence of senior party leaders, including national general secretary Arun Singh and Ravi Shankar Prasad.

Addressing a joint press conference here, Mishra expressed gratitude towards Prime Minister Modi, home minister Amit Shah, party chief JP Nadda and other leaders for his induction into the BJP and asserted that he will continue to remain with the saffron party for the rest of his political life.

"My efforts will be to ensure that in the forthcoming Lok Sabha elections, the opposition party doesn't even get a polling agent to man the booths in Varanasi seat this time," Mishra told the press conference at the BJP headquarters. "I started politics with the Congress and it is now certain that I will remain with the BJP for the rest of my political life," he added. Prime Minister Modi is contesting the Lok Sabha polls seeking his re-election from the Varanasi seat for a third consecutive term. Welcoming him to the party fold, Singh said Mishra, a "strong" Congress leader from Varanasi, has ioined the BJP accepting the party's policies and also looking at the work done by Prime Minister Modi government in the last ten years for people's welfare and country's progress.

"He is from Banaras (Varanasi) and a strong leader of the Congress. In the recent Congress president's election, Rajesh Mishra was a key member of the party's election committee. He was an MP from Banaras from 2004-09," the BJP national general secretary told reporters. (PTI)

The state home department had earlier said, "On the basis of information and facts pertaining to the police recruitment examination held on February 17 and February 18, the government, while keeping in mind the highest standards of sanc-

tity and transparency, has decided to

cancel the examination. "The government has directed the recruitment board to register an FIR at the level where laxity has been committed and ensure further action. NEW DELHI, March 5: The Congress on Tuesday attacked the Centre over the State Bank of India moving the Supreme Court to seek more time to disclose electoral bond details, alleging that the Modi government is using the country's largest bank as a shield to hide its "dubious dealings".

The State Bank of India (SBI) on Monday moved the Supreme Court seeking an extension till June 30 to disclose details of each electoral bond encashed by political parties. In its verdict last month, the top court directed SBI to furnish the details to the Election Commission of India by March 6.

Congress chief Mallikarjun Kharge said the party's position on the electoral bonds scheme is that it is "opaque, undemocratic and destroyed the level playing field".

"The (Narendra) Modi government is using the largest bank of our country as a shield to hide its dubious dealings through electoral bonds," he said.

No less than the Supreme Court of India had struck down the Modi government's "black money conversion scheme" of electoral bonds, holding it "unconstitutional", "violative of RTI" and "illegal" and asked SBI to furnish donor details by March 6, he said.

But the BJP wants it to be done after the Lok Sabha elections by June 30, Kharge said, adding that



the tenure of the Lok Sabha will end on June 16.

Alleging that the BJP was the main beneficiary of the "fraudulent" electoral bonds scheme, Kharge said. "Isn't the government conveniently hiding the BJP's shady dealings where contracts of highways, ports, airports, power plants etc were handed over to Prime Minister Narendra Modi's cronies in lieu of these opaque electoral bonds?"

"Experts say that the 44,434 automated data entries of donors can be divulged and matched in just 24 hours. Why does SBI then need four more months to collate this information?" he said.

He alleged, "The Congress was crystal clear that the electoral bonds scheme was opaque, undemocratic and destroyed the level playing field. But the Modi government,

PMO (Prime Minister's Office) and the FM (finance ministry) bulldozed every institution -- RBI, Election Commission, Parliament and the opposition to fill the BJP's coffers."

"Now a desperate Modi government, clutching on straws, is trying to use SBI to bulldoze the Supreme Court's judgment!" he said.

Supriya Shrinate, a Congress spokesperson, said during a press conference at the AICC headquarters that the Supreme Court's historic decision was enthusiastically welcomed by the entire country and hailed as the most decisive step against the use of black money in elections and the illegal participation of capitalists in power.

"The ruling BJP, which is the single-largest beneficiary of the electoral bonds scheme, was uneasy after the Supreme Court decision.

All political parties put together received more than ₹ 12,000 crore till last fiscal since the introduction of the electoral bonds scheme in 2017. The BJP alone got ₹ 6,566.11 crore, which is 55 per cent of all electoral bonds, while the Congress got a measly 9 per cent at ₹ 1,123.29 crore," Shrinate said.

She claimed that the BJP has been "afraid" that as soon as the information about its donor friends becomes public, its "unholy nexus with select corporates" will be exposed. "It was apprehensive that details will be out regarding who was donating, what he got in return, which laws were made for their benefit, whether investigations were stopped against those who donated, whether threats of investigation were made to collect donations forcibly," Shrinate said. Citing media reports, she alleged that 30 companies that donated nearly ₹ 335 crore to the BJP between 2018 and 2023 faced action

by agencies during that period. Shrinate questioned why the country's largest and fully computerised bank needs five months to provide information about electoral bonds when complete information can be extracted in five minutes with

Why did the State Bank (of India) ask for more time to provide information only a day before the last date for providing the informaculate exactly how much time it would take?" she said.

SBI, which operates 48 crore accounts, 66,000 ATMs and 23,000 branches, needs five months to provide information about only 22,217 electoral bonds, she said.

The question arises whether people of the country have the right to get the correct information before the Lok Sabha elections and take the right decision during voting, she

Shrinate alleged that SBI has sought time before the Supreme Court not to give the information but to hide the BJP's "misdeeds".

"But people of the country now understand fully well how the truth is being hidden by putting pressure on government agencies or institutions," Shrinate said.

In a landmark judgment that delivered a big blow to the government, the Supreme Court on February 15 annulled the electoral bonds scheme for political funding, saying it violated the constitutional right to freedom of speech and expression as well as the right to infor-

A five-judge Constitution bench directed that SBI must disclose details of each electoral bond encashed by political parties. The information should include the date of encashment and the denomination of the bonds and be submitted to the poll

UP Cong leader PM to flag off Namo Bharat train from Congress condemns ally DMK Muradnagar RRTS station today

NEW DELHI, March 5: Prime Minister Narendra Modi will launch the 17-km long additional section of the Delhi-Ghaziabad-Meerut RRTS corridor from Duhai to Modi Nagar North on Wednesday, NCRTC officials said on Tuesday.

A Namo Bharat train will be flagged off on the new additional section by the prime minister from Muradnagar Regional Rapid Transit System (RRTS) station remotely through video conference from Kolkata. Union Minister Hardeep Singh Puri will also remain present during the in-

With this, an additional 17-km stretch from Duhai to Modi Nagar North on the Delhi-Ghaziabad-Meerut RRTS corridor, beyond the operational priority section, will be ready for operations.

The extension encompasses three stations Murad Nagar, Modi Nagar South and Modi Nagar North.

"With the inauguration of this additional 17-km section, Namo Bharat services will

be seamlessly available on 34 km of the Delhi-Meerut RRTS corridor, incorporating eight stations from Sahibabad to Modinagar North," the National Capital Region Transport Corporation (NCRTC) said.

The foundation stone for India's inaugural RRTS corridor, linking Delhi to Meerut, was laid by the prime minister in March 2019. It was started for passenger operations in October 2023. "The newly-added 17-km

stretch of the Namo Bharat train service extends the coverage of the Delhi-Meerut RRTS corridor beyond its initial operational

priority section. This expansion is poised to boost regional connectivity, making commuting within the area more convenient and seamless," the NCRTC said in a statement. The RRTS boasts a design speed of 180 kmph and operation speed of 160 kmph.

The Delhi-Ghaziabad-Meerut RRTS corridor, stretching over 82 km, is expected to shrink travel time between Delhi and Meerut to less than an hour. (PTI)

NEW DELHI, March 5: The Congress on Tuesday condemned the reported controversial remarks of A Raja, a senior leader of ally DMK, and asserted that one should exercise restraint while speaking.

Stoking a controversy, DMK MP Raja said that India has never been one nation but is a subcontinent, which is home to diverse practices and cultures, even as the BJP slammed him and alleged that it was a call for "Balkanisation" of the nation. In a purported video where he is seen addressing a party-organised meeting, Raja said, "India is not a (one) nation. Understand this well. India has never been one nation. One nation denotes one language, one tradition and one culture and only such characteristics make one nation."

He also reportedly made controversial remarks on Lord Ram that the BJP alleged amounted to humiliation of Hindu gods. Supriya Shrinate, a Congress spokesperson, when asked about Raja's remarks, said, "I 100 per cent disagree with his remarks. From this platform, I condemn such a statement. I believe Ram belongs to everyone and is all en-

"I believe that Ram, who was called Imam-e-Hind, is above communities, religions and castes. Ram is an ideal of living life. Ram is dignity, Ram is ethics, Ram is love. I completely condemn this statement, it could be his (Raja's) statement, I do not support it. I condemn it and I think people should be exercise restraint while talking," she said at a press conference. (PTI)

Karnataka CM flays Centre for not releasing funds to face acute drought

Karnataka reeling under an acute water crisis due to a severe drought situation in most parts of the state, chief minister Siddaramaiah on Tuesday launched a fresh attack against the Centre for not releasing ₹ 18,172 crore to face the challenge.

He charged that the Centre did not heed to the state government's plea to increase the number of man-days under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) from 100 to 150. Siddaramaiah also alleged that

the union government did not release ₹ 1,600 crore towards the payment of wages to those workng under MGNREGS.

We gave the first memorandum to the Centre on October 20, 2023 to release ₹ 18,172 crore for drought mitigation but till now the Centre did not give even a penny," the chief minister said. He alleged that the BJP comes

BENGALURU, March 5: With to fight with the Congress whenever the Karnataka government asks the Centre for funds.

Tejashwi defends Lalu over 'Modi's family' remark

PATNA, March 5: RJD leader Tejashwi Yadav on Tuesday charged the ruling BJP at the Centre with diverting public attention by "Modi ka Parivaar" rhetoric, which came as a response to his father Lalu Prasad's attack on the Prime Minister a couple of days ago.

Yadav told reporters that BJP leaders suffixing "Modi ka Parivar" to their names on their social media profiles reminded him of "Main Bhi Chowkidar" rhetoric ahead of the 2019 Lok Sabha polls, when Congress leader Rahul Gandhi had coined the slogan "chowkidar chor hai".

"I am glad that the words of Lalu ji have so much impact." remarked the former Bihar Deputy CM sarcastically, adding: "But what about issues like poverty and unemployment that he had raised? He spoke of so many things"

Prasad, who is the RJD's founding president, had on Sunday told a rally here that Prime Minister Narendra Modi had "no family" of his own, in a bid to rubbish the latter's criticism of "parivarvad" or dynastic politics.

Yadav said, "The PM claims that he treats the entire nation as his family. If that is so, why did his government try to crush, so brutally, the recent farmers' protests in Delhi?"

He also read out a short Hindi poem, a rough translation of which said: "The country has 80 crore unemployed people

and 120 crore citizens are reeling under price rise. All families are unhappy, yet they claim all are family'

Yadav also defended his father for the remark that Modi is "not a true Hindu" as he did not shave his hair and beard after the death of his mother.

"We are a devout Hindu family with a temple at our home where Aarti is performed every morning and evening. I got my daughter undergo the mundan (tonsure) ceremony. Why the PM chose not to follow the well establishment tradition, is for him to answer," said Yadav.

The RJD leader, who lost his job as Deputy CM when Chief Minister Nitish Kumar, the JD(U) president, snapped ties with his party, also trained his guns at the NDA government in the state.

"When we were sharing power, we ensured job creation and better remuneration for Anganwadi workers. There were many other proposals which have been hanging fire under the NDA, which seems to have no other agenda except abusing me and my family," alleged Yadav.

He also claimed that the budget presented by the state government last month had "many documents signed by leaders from my party and the Congress". "After all, we held most of the Mahagathbandhan ministry

portfolios. The BJP, since coming to power in Bihar, has hardly made any contribution. So problematic has been its hurried alliance with Nitish Kumar that cabinet expansion has been on hold for more than a month," said Yadav.

Replying to a query about Lok Sabha polls, he asserted that the Mahagathbandhan, comprising RJD, Congress and three Left parties, "will win all 40 seats in the state" and a seat-sharing formula will be finalised "very soon, much before the NDA is able to do so".

He claimed that the BJP's "inability to announce a single candidate for Bihar" in its first list which contained close to 200 names, betrayed troubled waters in the NDA.

Yadav, however, ducked queries about Chirag Paswan, who is locked in a fierce battle with uncle and Union minister Pashupati Kumar Paras, whose Lok Sabha seat of Hajipur he wants to claim for himself as the "true heir" to late father Ram Vilas Paswan. The RJD leader, who has been perceptibly soft towards Chirag Paswan, said "I am not going to switch sides. If anybody wants to join us it is for him to say".

Speculations are rife that Chirag, a bete noire of Nitish Kumar, has been uneasy over the latter's return to NDA and if his claim on Hajipur was not accepted by BJP, he might

Study reveals high presence of toxic chemicals in recycled plastic

NEW DELHI, March 5: While India is pushing for plastic recycling to address plastic waste, a study conducted in Delhi has revealed a high presence of toxic chemicals in recycled products such as children's toys and food contact materi-

The study, conducted by the independent research and advocacy organisation Toxic Links, focused on five major chemicals known for their detrimental impact on human health -- phthalates; chlorinated paraffins; heavy metals such as palladium, chromium, cadmium, and arsenic; bisphenol A; and nonylphenol.

"The use of recycled plastic without any regulations is emerging as a major cause for concern across multiple sectors. This is due to the presence of often toxic chemicals in these plastics, which remain through the recycling process and are evident in the finished products," according

to the study, released on Tuesday The field study showed that plastic recycling is extensively carried out in the informal sectors. Toxic Links' previous work on the issue had also shown that such informal plastic recycling

exists in most cities across the country. The recycling units surveyed during the study were not following any established safety norms

or standards related to the recycling process. In molding units, where recycled pellets are used for manufacturing new products, quality and safety checks are not conducted on the possible chemicals in the recycled pellets nor their suitability for manufacturing.

When these units recycle plastic material into pellets, there are no processes to remove chemi-

These pellets are then used to make a range of new consumer products, such as toys, food containers or kitchen utensils.

"This raises serious concern as these products thus contain huge exposure risks. Food contact materials, toys or other products made of these recycled pellets have the possibility of exposing the users to many toxic chemicals, especially when these products have a high likelihood of coming into contact with the mouth," the report

Most of these recycled plastic products are cheaper than branded products of similar nature and, hence, are likely to be bought and used by lower-income groups or marginalised popula-



These populations are more susceptible to health impacts as their nutrition levels might be lower and access to good healthcare limited, said Priti Mahesh, Toxic Links' chief programme coordinator.

The study examined 15 samples, of which more than 60 per cent were found to contain the chemicals. The majority of these products were picked up from various markets, indicating their widespread availability.

Most of the chemicals detected were higher

than the permissible limits (global standards, as India does not have standards for any of the aforementioned chemicals), Toxic Links said. These chemicals have associated human health

impacts, including disruption to endocrine, immune and reproductive systems. Despite the complete ban on certain chemicals such as SCCPs and BPA, their presence in food contact materials poses a high risk of contamina-

tion for both children and adults, raising ques-

tions about the effectiveness of these bans, according to Toxic Links. The presence of chemicals in toys, particularly, is very worrisome as this means exposure to children in their developing years, and many of the chemicals detected are known to cause develop-

ment impacts, it said. Although the presence of these toxic chemicals in food contact materials was found to lower than toys, detection of even minute traces of these substances in contact with food is alarming and

means a risk to a much higher population. Most countries, especially developing ones such as India, are pushing for plastics recycling as the best option for dealing with large amounts of plastic waste. These countries are pushing this as the main measure within the Global Plastic Treaty discussion as well.

The study findings indicate that policymakers should be concerned about the toxic nature of plastics, especially in recycled pellets, Toxic Links said.

Chemical additives and contaminants are not labelled or monitored and, with large amounts of plastic recycling occurring in the informal sector, this is a big concern.

The presence of toxic chemicals also points to the fact that uncontrolled use of toxic chemical additives in plastic products renders plastic recvcling as an unviable option in some cases, especially for making new products with direct human contact, such as toys or food contact materials, Toxic Links said.

These new products can be a cause of exposure to humans and the environment

The study findings also clearly spell out the need for a reevaluation of "recycling" within the circular economy in plastic. The current recycling systems are certainly not safe and need to be monitored. The absence of labels in these lowquality, recycled products also is a reason for concern. (PTI)

Nitish files nomination papers for re-election to legislative council



PATNA, March 5: Bihar Chief Minister Nitish Kumar on Tuesday filed his nomination papers for re-election to the state legislative council.

Kumar, who is running for a fourth consecutive term, filed his nomination papers in the presence of a host of senior leaders of the ruling NDA, including his deputies Samrat Choudhary and Vijay Kumar Sinha, who belong to the BJP, and Rajiv Ranjan Singh "Lalan" whom he succeeded as the JD(U) national president. Besides Kumar, nomination papers were filed by his cabinet colleague Santosh Suman and JD(U) MLC Khalid Anwar. Suman's father Jitan Ram Manjhi, a former chief minister who heads Hindustani Awam Morcha, was also present.

The Election Commission has announced biennial polls for 11 seats of the state legislative council, the terms of which would end in May.

Of these, the JD(U) had held four, though following a diminution in its strength in the assembly, the party has given up its claim on two of the seats. Besides Kumar and Anwar. those from the JD(U) whose terms Kumar Jha, who recently got elected to the Rajya Sabha, and Rameshwar Mahto, who has been dropped.

Meanwhile, Choudhary had cryptically said, "Seven is the minimum number of seats that the NDA will contest. If the need arises, we may fight for more.'

Filing of nominations will come to a close on March 11, and the last date for withdrawal is March 14. Voting is scheduled for March 21. (PTI)

PM Modi launches projects worth ₹7,200 crore in Telangana; highlights Centre's focus on infra push

PM Modi also inaugurated and laid foundation for three National Highway projects

HYDERABAD, March 5: Prime Minister Narendra Modi on Tuesday inaugurated and laid the foundation for development projects worth more than ₹ 7,200 crore at Sangareddy, about 60 km from

Reiterating his commitment for Telangana's progress, the PM said he works with the spirit that states' development is the country's

"I believe in the mantra of rashtra vikas (development of nation) through vikas (development) of the states," the prime minister said, highlighting the government's working ideology.

"Today 140 crore Indians are determined for Viksit Bharat (developed India)," he said at an official event here.

It was essential to have modern infrastructure for a developed India. Therefore, the Centre had allocated Rs 11 lakh crore towards infrastructure in this year's budget and the Centre wanted Telangana to get the maximum benefit from it, he said.

Since the last 10 years, the union government was continuously working to take Telangana to new heights of development, he said.

Recalling that he had launched development projects worth ₹ 56,000 crore from Adilabad in the state on Monday, Modi said development initiatives worth about ₹ 7,000 crore were started at Sangareddy town today.

The projects are related to multi-



ple key sectors such as road, rail, petroleum and natural gas

The Prime Minister, who inaugurated the Civil Aviation Research Organisation (CARO) centre, called it a major gift to Telangana in the aviation sector. This center is the first of its kind and will give new recognition to Telangana in the field. This will provide a research and development platform for aviation startups in the country, he

The CARO center, which was set up at Begumpet Airport, Hyderabad by the Airports Authority of India to upgrade and enhance research and development (R&D) activities in the civil aviation sector, is built at a cost of more than ₹ 350 crore.

"Telangana is known as the gateway to South India," Modi said, and highlighted the government's efforts to improve rail connectivity and services in the state with the electrification and doubling of rail

lines taking place at a fast pace. During the programme, the prime minister inaugurated the doubling and electrification of the Sanathnagar-Moula Ali rail line along with six new station build-

Modi also flagged off the inaugural MMTS (Multi-Modal Transport Service) Train Service from Ghatkesar-Lingampalli via Moula Ali-Sanathnagar. This train service extends the popular suburban train service in the Hyderabad-Secunderabad twin city regions to new areas for the first time.

The PM, who also inaugurated the Indian Oil Paradip-Hyderabad Product Pipeline, said it will carry petroleum products in a cheaper and environmentally sustainable

The 1,212-km product pipeline with a capacity of 4.5 MMTPA traverses through the states of Odisha (329 km), Andhra Pradesh (723 km) and Telangana (160 km). The pipeline will ensure safe and economical transportation of petroleum products from Paradip Refinto delivery stations at Visakhapatnam, Atchutapuram, and Vijayawada (in Andhra Pradesh), and Malkapur near Hyderabad (in Telangana).

Modi also inaugurated and laid the foundation for three National Highway projects.

The two National Highway projects that the prime minister inaugurated include four laning of 40 km long Kandi to Ramsanpalle section of NH-161. The project is a part of Indore - Hyderabad Economic Corridor and will facilitate seamless passenger and freight movement between Telangana, Maharashtra and Madhya Pradesh.

The section will also substantially reduce travel time between Hyderabad and Nanded by about three hours. The prime minister also inaugurated the upgradation of 47 km long Miryalaguda to Kodad Section of NH-167 to two lanes with paved shoulders. The improved connectivity will boost tourism as well as economic activity and industries in the region.

He also laid the foundation stone for the six-laning of the 29 km long Pune-Hyderabad Section of NH-65. The project will provide improved connectivity to major industrial centres in Telangana like Pashamylaram industrial

Delhi HC modifies order on raising income threshold from ₹ 1L to ₹ 5L yearly to admit students under EWS quota

NEW DELHI, March 5: The Delhi High Court on Tuesday ordered that children belonging to families with annual income up to ₹ 2.5 lakh can seek admission to schools in the national capital under the Economically Weaker Sections (EWS) quota, modifying an earlier order passed by a single judge bench of the court.

A bench of Acting Chief Justice Manmohan and Justice Manmeet PS Arora stayed certain directions issued by a single judge of the high court in the December 5, 2023 judgment which had raised the threshold income limit from ₹ 1 Lakh to ₹ 5 lakh annually until the government amended the relevant law.

The high court passed the interim order on an appeal filed by the Delhi government challenging the single

The single judge had also directed the Delhi government to immediately do away with the mechanism of selfdeclaration of income by parents and devise an appropriate framework for continuation of free seats for EWS in schools. The Delhi government's Directorate of Education (DoE) shall frame a Standard Operating Procedure (SOP) for income verification and regular monitoring of the eligibil-

ity criteria, it had said. Delhi government's standing counsel (Civil) Santosh Kumar Tripathi submitted that the sudden increase in the threshold income will adversely impact the deserving candidates from families with income up to ₹ 1 lakh, potentially leading to reduced chances of securing admission under EWS quota. He contended that this arbitrary increase violates the fundamental right to equality and imposes unreasonable restrictions on the right to ed-

Tripathi said the increase of threshold income limit to ₹5 lakh will result in injustice, especially to children of manual labourers, and may hinder the intended purpose of providing free and compulsory education to EWS.

He said the existing policy of relying on self-declaration is appropriate and does not require any change. Even if the directions in the December 5, 2023 judgement have to be implemented, the state would require time to change the system, he added. The single judge had passed the order in a case where a man had managed to secure his son's admission to the city's reputed Sanskriti School under the EWS category by falsifying birth and income certificates.

The court had dismissed the petition moved by the boy challenging cancellation of his admission under the EWS quota. It had, however, allowed him to continue studying there

While dealing with the Delhi government's appeal, the division bench issued notice to the school and the child to respond in the matter and listed it for further hearing in August.

The single judge had said the child, who has been continuing with his studies since 2013, was not at fault and shall not be made to suffer for his father's misdeeds. It had imposed ₹ 10 lakh as costs on the boy's father for securing admission of his son by illicit means thereby denying a deserving candidate an opportunity to study in a school of repute. To ensure the implementation of the Right To Education (RTE) Act, the single judge had said the Delhi government, after assessing

the prevailing economic conditions in the city and other relevant factors, shall expeditiously take a decision to increase the existing threshold income of ₹ 1 lakh annually to a commensurate amount which corresponds to the living standards of the intended beneficiaries of the scheme.

"Needless to observe, the criteria must be scientific and must be based on actual data. Till the aforesaid exercise is done and appropriate amendment is made in the scheme, the required income under Clause 2(c) of 2011 Order shall be considered to be increased to ₹ 5 lakh instead of ₹ 1 lakh as all the other states have the threshold amount in question to the tune of almost ₹ 8 lakhs," the court

Under the Right to Education Act, 25 per cent seats are reserved for the economically poor in private unaided schools, and as per the Delhi School Education (Free seats for Students belonging to Economically Weaker Sections and Disadvantaged Group) Order, 2011, schools are required to admit children belonging to EWS in class one to the extent of at least 25 percent of the strength of that class and provide free and compulsory ele-

mentary education till its completion. The court had also highlighted the need to revisit the income criterion set out for availing the benefits of the EWS reservation scheme in schools and said when the minimum wage of an unskilled labour in Delhi was ₹ 17,494 per month, it was too farfetched to assume that the total parental income of a child seeking admission under EWS category and living in a metropolitan city shall be below ₹ 1 lakh annually. Ayush hospitals be spread across country following bed per population norm: Ministry guidelines

NEW DELHI, March 5: Considering the requirement of quality in-patient care, Ayush hospitals should be spread across the country following the bed per population norm, according to a set of new guidelines issued by the Ayush Ministry.

According to the norm, one hospital bed per 5,000 population is "essential" while 1 bed per 2,000 population is "desirable".

There are 3,844 Ayush hospitals in various categories across the country run by central and state governments. These hospitals together have a bed strength

The "essential" number of beds in Ayush hospitals may be provided through the public health system such as medical colleges, district hospitals, 10-bedded, 30-bedded, 50 or more bedded Ayush hospitals, the Indian Public Health Standards (IPHS) for Ayush healthcare facilities stated.

To achieve the "desirable" number of beds, the contribution of the private sector may also be considered while continuing to strengthen and increase bed provision at public health facilities, the guidelines said. As a thumb rule, all beds available and functional

for a patient for more than 24 hours have been calculated as in-patient hospital beds. The Ayush hospitals, in adherence to IPHS standards, are expected to provide a comprehensive range of essential services that align with the principles of Avurveda, Yoga, Unani, Siddha, SowaRigpa and Ho-

moeopathy, the document said. This includes but is not limited to promotive, preventive, curative, and rehabilitative services catering to a wide spectrum of health conditions.

These facilities are encouraged to integrate traditional and complementary medicine practices with the contemporary healthcare system, fostering a harmonious blend that caters to the diverse healthcare needs of the population, the document said.

The guidelines also stressed ensuring a continuum of care, establishment of assured referral systems along with facility readiness to manage referred cases. All Ayush healthcare facilities should be strategi-

cally situated to ensure convenient access for the rural and urban communities they serve, it stated, adding that adequate space and infrastructure should be allocated to cater to the evolving healthcare needs.

All Ayush hospitals should be resilient to climatic and environmental changes and able to handle sudden healthcare needs during disasters and emergencies, epidemics and pandemics

The IPHS guidelines for Ayush hospitals has emphasized strategic planning for service delivery as a priority, before investing in other components such as infrastructure, human resources, drugs, diagnostics, equipment, and others.

To achieve this, the set of guidelines has categorised healthcare services as either 'essential' or 'desirable' and correspondingly classified human resources in a similar fashion. According to the guidelines, states and Union terri-

tories should conduct Ayush-specific training needs assessment to identify the training requirements of the Ayush healthcare workforce. Apart from this, identify the need for integrating Ayush and modern medicine training for Ayush

healthcare professionals, if required, the document said, adding that a robust grievance redressal mechanism should be established in all such hospitals. Every state and Union Territory should have an occupational safety and health policy for Ayush hospitals, outlining the framework for ensuring the safety, health and well-being of employees, patients, and visitors. Registration for scheme to provide ₹ 1,000 monthly to non-tax paying women to start soon: Kejriwal



NEW DELHI, March 5: Delhi chief minister and AAP supremo Arvind Kejriwal on Tuesday sought the blessings of women for the upcoming Lok Sabha polls as he announced that registration will soon start for a scheme to provide them ₹ 1,000 a month.

While presenting the 2024-25 Delhi budget in the assembly on Monday, finance minister Atishi had announced a new scheme for women under which eligible nonincome tax payers above 18 years will get the amount every month.

The Lok Sabha polls are expected to be held in April-May and Delhi sends seven members to the Lower House of Parliament. The scheme, which will be implemented after the elections, is likely to benefit around 50 lakh women in the national capital.

In a long post on X, Kejriwal said he was getting a lot of phone nouncement of the Mukhya Mantri Mahila Samman Yojna on Monday and they were asking about the registration for the scheme. The chief minister said he was

working on the scheme and registration for it will start soon. Kejriwal, who is the national

convener of the Aam Aadmi Party (AAP), said that whatever he has been able to do was because of the blessings and prayers of women.

"...My opponents have left no stone unturned to crush me but your blessings are foiling all their conspiracies," said Kejriwal, whose AAP in a seat sharing arrangement with the Congress in Delhi is contesting four of the seven Lok Sabha seats.

In an apparent reference to the BJP, Kejriwal said whatever good things he wants to do for women and their families, "they (BJP) get these stalled through the LG (Delhi lieutenant governor) and the Cen-

There are elections next month. Give me your (women) blessings in the elections and also ask your family members to strengthen my hands in the polls so that your brother and son could serve you well and take care of your families," Kejriwal said in the post.

NEW DELHI, March 5: A mere 1.6 per cent of companies listed on the Fortune India 500 have women at the helm, while the figures stand at 5 per cent for the Fortune India Next 500, according to a study.

The study -- 'Enhancing Women Leadership in India Inc' -conducted jointly by Fortune India and SP Jain Institute of Management and Research sheds light on the persistent gender gap in leadership roles within Indian indus-

Supported by the Women and Child Development Ministry and Bill and Melinda Gates Foundation, the study engaged 130 industry leaders, with a representation of 54 per cent female and 46 per cent male CEOs, in 16 roundtable discussions across Delhi-NCR, Mumbai, Kolkata, and Bengaluru.

Additionally, a survey questionnaire was distributed to Fortune 500 companies for their insights.

Women and child development minister Smriti Irani unveiled the findings of the study on Monday. A key finding of this study is the

industry leaders' recognition of the government's decade-long efforts to promote women in the corporate sphere and admitting that the responsibility now lies with the industry to implement measures that foster women's leadership, she

"The study underscores the industry's acknowledgment of gender inequality within corporations, pinpointing organizational policies, career advancement opportunities, work-life balance, and cultural norms and stereotypes as significant obstacles to be addressed.

"I commend the industry's transparency in recognising the challenges that need to be tackled to advance the vision of Womenled Development, which is the cornerstone @narendramodiji's government,"

Irani said in a post on X. Despite advancements in various sectors, the study reveals a stark reality: only a minuscule percentage of companies are led by women MDs/CEOs across different tiers of corporate India.

According to the study, a mere 1.6 per cent of companies listed on the Fortune India 500 have women at the helm, while the figures stand at 5 per cent for The Next 500 and 3.2 per cent for the Fortune India 1000 companies.

Fortune India publishes an annual list of the top 500 corporations in India by revenue. This list is similar to the Fortune 500 but focuses specifically on Indian companies. The Next 500 refers to the companies that follow the top 500 in terms of revenue or other



criteria. These companies are often called 'The Next 500' or 'Fortune India Next 500'

While Fortune India 1000 is an extended list that includes both the Fortune India 500 and The Next 500, encompassing the top 1000 corporations in India by various metrics.

The study identifies several root causes contributing to this gender disparity. One significant factor is the 'leaky pipeline' phenomenon, where a substantial portion of women employees exits the workforce upon entering middle management due familial responsibilities.

"Over 30-40 per cent of women employees guit the workforce by the time they enter middle management. This is the time when they invariably get married or have a family. They take maternity leave

and the return post childbirth gets challenging," it said.

Also, the study said maternity leaves and caregiving duties often disrupt their career progression, leading to a severe shortage of women groomed for leadership

Moreover, inherent biases prevalent in corporate mindset further exacerbate the problem, the study pointed out.

"Organisations shy away from hiring a woman in mid-management roles as they know there could be a six-month 'maternity leave' in the offing. It is paid leave and most organisations don't want — smaller ones can't afford — to make that investment," it said.

Stereotypes regarding women's commitment, willingness to relocate, or capability to handle P&L roles hinder their advancement opportunities, according to the study. 'The next round of losses occur when women leaders have to take a break when their children write board exams. There is also a break in their career, typically in their late forties when they have the responsibility of taking care of parents or in-laws," the study said.

Decision-makers often make assumptions about women's preferences without consulting them directly, perpetuating discriminatory practices, the study said.

The study rejected the idea of quotas but suggested actionable solutions to bridge the gender gap.

"Will a quota system make sense to get the much-needed number of women in the middle management? It was a vehement 'No from the industry. Quotas would impact meritocracy, was the unanimous view," the study said.

However, a section of the industry did feel that a mandate to hire more women on the shop floor of manufacturing units could help to improve the representation at the grassroot level, it said.

The recommendations suggested in the study include tax rebates, enhanced corporate disclosures on diversity, increasing women's representation on boards, fostering a culture of sponsorship, and introducing gender-specific hiring mandates. (*PTI*)

1 killed in accident in Rangapara

The results may not have gone their way on the tour of India but England have had no shortage of fan support and it is set to reach its peak this week in the picturesque town of

VEDNESDAY, MARCH 6, 2024

Dharamsala. The fifth and final Test is still two days away but thousands of English fans have flocked to the hill station. The Barmy Army has provided constant support through the series but the prospect of watching Test cricket amid the stunning backdrop of the Himalayas has attracted even more fans from England.

Three early morning flights from Delhi Airport to Dharamsala were packed with English fans and a handful of locals including Indian captain Rohit

DHARAMSALA, March 5: Sharma, giving the impression that the game was being played in the UK.

Upon their arrival at the Gaggal Airport, the fans were left in awe of the snowcapped mountains in the background. The weather, unusually cold for this time of the year, is also making the English fans feel right at home.

This is the kind of weather we see in England in April and May. It feels like start of the summer for us and we are loving it. The place is absolutely stunning. However, it would have been nicer if teams were locked at 2-2 going into the game," said a fan who has flown in from Liverpool.

England cricketers too can't get enough of spectacular

England's opening practice session here had a very relaxed vibe to it. With 'Paradise City' from Guns N' Roses being played from the speakers kept outside the nets, the England batters went through their paces. In their break time, they were seen marvelling at the majestic mountains.

Jonny Bairstow, who is set to play his 100th Test, rates the Newlands in Cape Town at his favourite venue but on Tuesday, he had to concede that there is nothing more picturesque than the HPCA Stadium in Dharamsala.

"It's absolutely stunning here, I don't think there's a more picturesque ground in the world. Cape Town is one of my favourite places but when you take a moment, look up at the



mountains with the snow and everything that goes with it up here in Dharamsala, it's quite incredible," said Bairstow.

The England batter also commended the groundstaff for fixing the relaid outfield which received scathing criticism during the ODI World

Cup in October-November. They've done a brilliant job with the field for a start, if you look back at the field from the World Cup, the transition that has been made to produce

something like that has been amazing. The surface, which looked

flat 48 hours before the game, has been a topic of intense discussion with the cooler conditions bringing the seamers into the game.

"Obviously, the moisture will be there at the start on all days for the seamers to exploit, that is the nature of the surface here. Spinners will come into play later on," said an HPCA

Bairstow feels the surface will not provide an undue advantage to either side.

"They are favourable for both teams, I don't think there's one side it favours...look at the seam attack India have, world class and the spinners... I think it will be a great game. It's a used pitch from the Ranji trophy, so let's see how it plays out...it looks a nice wicket," he

In the only Test played here in 2017, the spinners played an important role with debutant Kuldeep Yadav picking four wickets in the first innings and Ravichandran Ashwin and Ravindra Jadeja sharing six wickets in the second innings.

Ashwin, who like Bairstow will be featuring in his 100th Test, said both teams are heading into unknown territory.

"It's pretty cold here. It will take a bit of time for the fingers to adjust. This is a little colder than what it usually is in March. We haven't got a lot of practice here. That's the beauty. There are a lot of unknowns. Sometimes even when you are playing in India, it looks like an away game for you," said Ashwin. (PTI)

Inter beat Genoa 2-1 on Monday and extended its lead to 15 points over second-placed Juventus, which lost to Napoli the previous evening. It was a 12th straight win for Inter — a run dating to December and a draw at Genoa.

The Nerazzurri also have the best attack and defense in Europe's top five leagues. Genoa had lost only one of its previous 11 matches and was also one of only four sides not to have lost to Inter this season. In an end-to-end match. Inter broke the deadlock on the half hour mark with a great team move. Nicolò Barella picked out Alexis Sánchez, who sent the ball through to Kristjan Asllani and the Albania midfielder fired powerfully into the roof of the net for his first Nerazzurri goal. Sánchez got on the scoresheet himself eight minutes later when he converted a penalty, which was controversially awarded for a foul by Genoa defender Morten Frendrup

2012 series against England was turning point of my career: Ashwin



DHARAMSALA, March 5: On the cusp of completing 100 Tests, India's premier off-spinner R Ashwin on Tuesday said he would not have become the bowler that he is now without the learnings from an underwhelming home series against England in 2012, at the end of which he was a "bit nervy".

That series loss remains India's last defeat at home and Ashwin's performance in the four-match rubber left a lot to be desired as the likes of Alastair Cook and Kevin Pietersen played him with ease.

Twelve years later, Ashwin looked back at the turning point of his remarkable career, which now features 507 Test wickets. "It is a pretty big occasion. More than the destination, the journey has been very special. It is a journey of ups and downs and a lot of learnings," said Ashwin, who will become only the 14th Indian to reach the 100-Test milestone when the final Test begins here on Thursday.

"One of the turning points of my life was the England series when Cook came here and made all those runs. It has been talked about a lot but to me that and what led to the next home series against Australia (changed a lot for me). "There was lot of noise about me being left out of the team, one of the selectors had a chat with me. At that time I was a bit nervy though I don't know where it came from as I had done well previously," he recalled.

The criticism of his performance --14 wickets at an average of 52.64 in four Tests -- is still fresh in his mind but more importantly, he hasn't forgotten the lessons.

"When I went back and reflected on it after all those articles written about me, it dawned upon me that what was wrong with me. That is a wonderful lesson that has been kept with me all these years down the line.

"When I look back it, it taught me what I had to correct. Some of those questions were raised by me largely," said the 37-year-old.

A majority of Ashwin's 507 wickets (354 to be precise) have come in favourable conditions and perhaps that is why he cherishes his effort in Birmingham on the 2018 tour of England. Ashwin picked up seven wickets in that

Test, including the important ones of England run-machine Alastair Cook and Joe Root.

"It is Test wins that always stand tall. After having given it a thought, one of the finest spells that I have bowled has to be Birmingham, 2018. I bowled in both the innings, I bowled on the morning of day three and got three wickets.

I got seven in the game and thought I had almost bowled India bowled to victory but didn't happen," he said referring to the game India lost by 31

"Then it was a Test match in Bangalore, where I bowled a spell on day two morning not for many rewards. Day one, Centurion in 2018-19 again, got a four for and could have been six for. These are the spells that stand out."

Due to his superior batting skills, Ravindra Jadeja has been preferred over him at times in overseas conditions but the champion spinner has now made peace with the past.

"It's always disappointing to not play a particular game for your country, especially when you were doing well. But you got to make peace with it because it was in the best interest of the team. I don't think any captain or player wants to leave out a player that they feel can be of use in that particular game.

"Not many teams in the world has what India has got. Ravindra Jadeja has been batting pretty well and if you see his averages, you can see that's where he has outscored me. Bowling might not be a big factor given the pitches that we play on in England and South Africa," he reasoned.

Ashwin got emotional while talking about the sacrifices his family has made for him over the years and stressed that numbers don't mean a lot to him.

"Just because I have great memory, people actually think that I value numbers, but I actually don't. It does not mean anything to me. The 100th Test match probably means 10 x 100 to my dad, it means a lot to my wife and my mom. My daughters are more excited

"It's just a number. Zaheer Khan could not play 100 Test, MS Dhoni could have rode on his (success) and played 100 Tests, but he did not," Ash-

It means hell of a lot: Bairstow on playing 100th Test

DHARAMSALA, March 5: Set to complete a century of Test matches, England wicketkeeper-batter Jonny Bairstow on Tuesday said reaching the landmark "means hell of a lot" to him given that he has had to wade through testing times.

The 34-year-old will become the 17th Englishman to get a 100th Test cap when he steps out for the fifth and final Test against India starting here on Thursday and it will be an emotional week for Bairstow, who endured a tough childhood and

a long career-threatening injury. "It means hell of a lot. It will be an emotional week for me," Bairstow said of the marquee

Bairstow was just 8 when his father David, a former England wicketkeeper, died by suicide. His mother Janet kept the family together even as she battled and defeated breast cancer

Speaking about the pitch for the match, he lauded the groundsmen for doing a brilliant job not long after the venue's outfield was criticised during the ODI World Cup.

"The ground staff has done a brilliant job with the outfield considering the state it was in during the ODI World Cup.

"It looks like a good pitch and if you are alluding to the fast bowlers getting help from the surface, it will be favourable to both teams," Bairstow said. Bairstow has also played his 100th ODI in Dharamsala and asked about the venue, he said, "Cape Town is my favourite but don't think there is a more picturesque ground in the world than Dharamsala." India have already sealed an unbeatable 3-1 lead in the series. (PTI)

Centre revises guidelines on recruitment, promotion of sports persons

NEW DELHI, March 5: The Centre has revised its existing guidelines on recruitment and promotion of sports persons in order to include events which have gained importance in recent times and to provide greater incentives to the sports persons performing well in these games.

The Department of Personnel and Training (DoPT) had issued consolidated instructions on recruitment and promotion and other incentives for sports persons in the government of India on October 3, 2013. "These instructions have been reviewed in consultation with the department of sports which is the nodal department for promotion of sports in the country in order to bring more clarity, inclusion of events which have gained importance in the recent times as well as to provide greater incentives to the sports persons per-



forming well in these games," an

order issued by the DoPT said. National championships and tournaments conducted by the recognised national sports federations in individual disciplines, national games conducted by Indian Olympic Associations and Khelo India University, Khelo India Youth Games, Khelo India Winter Games and Khelo India Para Games are recognised as events of national importance, it said.

Appointments can be made of sports persons who have represented a state or the country in the national or international competi-

tion or medal winners in junior national championships, Khelo India Youth Games (age category above 18 years), Khelo India Winter Games, Khelo India Para Games or medal winners in Khelo India University Games, medal winners in School Games Federation of India (SGFI) in any of the games or sports mentioned in its instructions, according to the order.

"For Chess, Grand Master (GM) title, International Master (IM) title, Chess Olympiad... While National Open Chess Championship is treated as National Championships, the medal winning performance in National Team Chess Championship will also be considered for recruitment," read the order dated March 4. It has also mentioned the order of preference for the sports persons as well.

"First preference to those candi-

country in an international competition with the clearance of the Department of Sports, Ministry of Youth Affairs and Sports," said the order issued to all central government ministries and departments.

Next preference may be given to those who have represented a State or Union Territory (UT) in the senior or junior level national championships organised by the National Sports Federations recognised by the Department of Sports, Ministry of Youth Affairs and Sports or National Games organised by Indian Olympics Association and have won medals or positions upto third place, it said.

"Between the candidates participating in senior and junior national championships and games, the candidates having participated and won medals in senior national championship should be given preference," the order added.(PTI)

Sports ministry revokes PCI's suspension with immediate effect

NEW DELHI, March 5: The Sports Ministry on Tuesday revoked the suspension imposed on the Paralympic Committee of India (PCI) after the body initiated the process for its long-pending elections in which multiple-time Paralympic medallist Devendra Jhaiharia is set to be elected President. On February 2, the ministry terminated PCI's recognition for "intentional delay to elect a new executive committee" as per the ational Sports Code.

The PCI had postponed the elections, which should have been held before January 31 this year, to March 28 because of the impending Para Shooting World Cup from March 6-15. After its suspension, the body proposed March 9 as the new date to elect governing body members and began the process of nominations. Most of its top posts are set to be filled without any contest. The ministry said that the "main ground for suspension of government recognition" has been addressed.

..since the election process has reached the stage where the nominated candidates have been deemed to be duly elected unanimously, as well as the important

fact that PCI is hosting 2024 World Shooting Para Sport World Cup from 06-15 March, 2024 at New Delhi, it has been decided to revoke the suspension of PCI, with immediate effect," read a ministry letter to PCI. "The Returning Officer for election of PCI has vide notification dated 04.03.2024, notified the list of unopposed candidates deemed to be duly elected, in terms of Article 9 sub clause (1) of Model Election Guidelines (Annexure-XXXVII of the Sports Code 2011),"it added. The Para Shooting World Cup offers 24 Paris Paralympic quota places, and more than 500 shooters from 52 countries will be seen in action in the event to be held at Delhi's Karni Singh Range.

The 42-year-old Jhajharia, who had won a gold medal each in the 2004 Athens and 2016 Rio Paralympics in the F46 disability category, was the only candidate who filed nomination papers for the PCI chief's post. Returning officer Umesh Sinha issued a list of candidates who had filed nomination papers for various posts, and Jhajharia was the lone name for the president's post. (PTI)

Ashwin is always up for a challenge and two days from his landmark 100th Test, India's premier off-spinner looked back at the onfield battles he has enjoyed in international and domestic cricket.

Ahead of the fifth and final Test against England, the visitors' batting mainstay Joe Root spoke glowingly of Ashwin and on Tuesday, the 37-year-old returned the compliment.

Besides Root, Ashwin said Steve Smith and Kane Williamson also brought the best out of him. "I have loved bowling to Steve

Smith, Williamson and Joe Root. They are some of the finest batters going around the world now," said Ashwin.

"When I played first-class, I had the privilege of bowling to some of the gun batters of spin - I have bowled to S Badrinath at the Tamil Nadu nets and he was one of the finest batters of spin, then Mithun Manhas, Rajat Bhatia (both from Delhi).

"These are some of the greatest batters of spin who I would have not wanted to encounter in international cricket. They were my finishing school before I went on to play international cricket.

"I'd like to take my hat out to them because they gave me some valuable lessons," said Ashwin.

has reinvented his game across formats through his career. He made his white-hall debut for India before playing Test cricket largely due to his exploits for CSK in the IPL.

However, Ashwin insisted he got the opportunity to play for India not only because of his white-ball skills.

"I am treading a very careful line of not making this a punch, but it is more of a lack of understanding when you say that I came through the T20 format. I had a good 30-40 matches in first-class cricket before I made it to the Indian team," he said in response to a question.

Ashwin remains a regular in club cricket when he is not on national duty.

"In the same year I made my Test debut (in 2011), I got a fifer in the Rest of India game for ROI side in the Irani Trophy. I had played 3-4 seasons of club cricket n Chennai.

"You might say there's a standard difference, but I played 3-4 years of club cricket there, probably mentored by seniors, told where I made mistakes, corrected my discipline, bowled long spells.

"It really builds your resolve as a cricketer when you do all those things. T20 happened by accident.

LANNING, JEMIMAH HIT FIFTIES TO TAKE DC TO 29-RUN WIN OVER MI

NEW DELHI, March 5: Skipper Meg Lanning and Jemimah Rodrigues smashed commanding fifties as Delhi Capitals thrashed Mumbai Indians by 29 runs in a top-of-the-table clash of the Women's Premier League (WPL) here on Tuesday. Sent in to bat, Lanning fired at the top with a 38-ball 53, while

Jemimah hit an entertaining 33-ball 69 to provide the late acceleration as DC racked up a massive 192 for 4 after the WPL juggernaut moved to the national capital amid lukewarm response.

Mumbai Indians' chase never took off, ending up with a 163 for 8 despite Amanjot Kaur's 42 off 27 and Hayley Matthews' 29 off 17 as the defending champions crashed to their second defeat in five matches and only second against DC in WPL history. This was Delhi's fourth win on the trot as they moved two points clear of Mumbai with eight points from five matches. DC thus consolidated their position at the top with the win which will act like a balm for the home team, which had suffered a heartbreaking last-ball loss to the MI in the tournament opener.

In contrast to the roaring success in the first leg, the first game of the Delhi leg saw a sparse crowd at the Arun Jaitley Stadium which build up as the match wore on but still couldn't match the 'crowd energy' of Bengaluru. Opener Matthews made a strokeful 17-ball 29 before being caught by Alice Capsey off left-arm spinner Jess Jonassen (3/21), while 19-yearold pacer Titas Sadhu removed Amelia Kerr (17) as MI lost half their side in 9th over. The 23-year-old Amanjot smacked seven fours on way to her 42 to give a tinge of hope but once she was castled by Jonassen, the runrate kept piling up and it became too tall a task.

Earlier, opener Lanning hit the ball across the ropes six times and twice over it en route to her third half-century, and added three useful partnerships to anchor the DC innings for the most part.

Later Jemimah smashed 8 fours and 3 sixes to take DC close to the 200-mark. Shafali Verma (28) and Alice Capsey (19) too chipped in with quick cameos. Pacer Shabnim Ismail, who had missed last two games, was put under the pump by Shafali, who carted her for two fours.

Lanning, on the other hand, blasted the first maximum, flicking Sciver-Brunt over long on, and then hit a four before surviving a LBW appeal in the fourth over which yielded 14 runs.(PTI)
