24: Despite the Foreigners' Tribunal declaring her a bona fide citizen of India in 2015, Anjali Roy of Saidpur village in Assam's Cachar district is unable to exercise her franchise as 'doubtful' voter mark against

her name on electors' list is yet to be removed. Roy got the 'D'

voter tag in 2012. Similar is the case of Banesa Begum, a resident of Chailtakandi village in the district, who had spent two years in the Silchar deten-

tion camp after being declared a foreigner. Though all other members of her family have found their names in the National Register of Citizens (NRC) and have the right to vote, Banesa will not be able to go to a polling station on April 26 to exercise her franchise in the Silchar Lok Sabha constituency.

Anjali and Banesa are among many people, who will not be able to cast their votes due to the 'D' voter tag in Karimganj and Silchar constituencies in Barak valley which

Sabha polls. The concept of 'D' voters was introduced in Assam in 1997 by the Election Commission. It does

not exist anywhere else in India. There are 96,987 'D' or doubtful voters in the state, as stated in the assembly by chief minister Himanta Biswa Sarma. During the ongoing election campaign in the two constituencies in Barak Valley, Sarma announced that the citizenship issue of the Bengali Hindus and the 'D' voter tag would be removed within six months after the polls.

GUWAHATI, April 24: AIUDF chief Badruddin Ajmal has said he will move the Supreme Court against the Assam government's decision to close the state-run madrassas

The sitting Dhubri MP expressed hope that the apex court will order reopening of all closed madrasas in Assam.

"UP government announced the closure of madrasas and later, the Supreme Court condemned them. With this reference, we will go to the Supreme Court and will get the order from there," Ajmal told reporters on the sidelines of an election campaign meeting on Tuesday. In December last year, 1,281 Upper Primary Middle English (ME) Madrassas were converted into general ME schools across Assam.

Earlier in April 2021, all the 610 state-run madrassas under the Madrassa Board were converted into upper primary, high and higher secondary schools with no change of status, pay, allowances and service conditions of teaching and nonteaching staff.(CONTD. ON PAGE-2)

Markets maintain momentum for fourth day; Sensex nears 74k

MUMBAI, April 24: Equity benchmark indices Sensex and Nifty ticked higher for the fourth straight session on Wednesday. helped by buying in metal and commodity stocks amid a positive trend in global equities.

However, intense selling pressure on telecom, IT and tech counters capped the upside, traders said. The 30-share BSE Sensex climbed 114.49 points or 0.16 per cent to settle at 73,852.94. During the day, it jumped 383.16 points or 0.51 per cent to 74,121.61.

The NSE Nifty advanced 34.40 points or 0.15 per cent to 22,402.40. The indices witnessed some selling pressure towards the fag-end of the session that erased some initial gains. "Indian markets lagged the Asian peers as Q4 earnings remained largely subdued with weak results from IT and a few index heavyweights results also disappointed.

"However, buoyed by strong manufacturing and service sectors, the Indian composite PMI hit a multi-year high, reflecting domestic resilience and bringing some buoyancy in the broad market.

MUMBAI, April 24: Cracking down on repeated non-compliance of IT norms, the RBI on Wednesday barred Kotak Mahindra Bank from onboarding new customers through its online and mobile banking channels and issuing fresh credit cards with immediate effect after the regulator found "serious deficiencies" in the lender's IT risk management. These actions, the RBI said, are necessitated based on significant concerns arising out of Reserve Bank's IT examination of the bank for the years 2022 and 2023 and the continued failure on part of the bank to address these concerns in a comprehensive and timely manner.

In an almost similar action, the RBI in December 2020 had barred HDFC Bank from issuing new cards and launching new digital initiatives after repeated instances of technological outages at the

In a statement regarding the supervisory action against Kotak Mahindra Bank, the RBI said: "Serious deficiencies and non-compliances were observed in the areas of IT inventory management, patch and change management, user access management, vendor risk management, data security and data leak prevention strategy, business continuity and disaster recovery rigour and drill, etc."

The Kotak Mahindra Bank has been directed "to cease and desist". with immediate effect, from onboarding of new customers through its online and mobile banking channels and issuing fresh credit cards. The bank shall, however, continue to provide services to its existing customers, including its credit card customers.

"The bank shall, however, continue to provide services to its existing customers, including its credit card customers," RBI said. For two consecutive years, the bank was assessed to be deficient in its IT Risk and Information Sepast two years, it has been in continuous high-level engagement with the bank on all these concerns with a view to strengthening its IT resilience, but the outcomes have been far from satisfactory.

It is also observed that, of late, there has been rapid growth in the volume of the bank's digital transactions, including transactions pertaining to credit cards, which is building further load on the IT systems, the Reserve Bank said.

"The Reserve Bank, therefore, has decided to place certain business restrictions on the bank as mentioned above, in the interest of customers and to prevent any possible prolonged outage which may seriously impact not only the bank's ability to render efficient customer service but also the financial ecosystem of digital banking and payment systems," the statement said. The restrictions imposed will be reviewed upon completion of a comprehensive external audit to be commissioned by the bank with the prior approval of RBI, and remediation of all deficiencies that may be pointed out in the external audit as well as the observations contained in the RBI inspections, to the satisfaction of the Reserve Bank.

Further, these restrictions are without prejudice to any other regulatory, supervisory or enforcement action that may be initiated against the bank by the Reserve Bank, the central bank said.

Kotak Mahindra Bank Limited is scheduled to announce the consolidated and standalone audited financial results for the quarter and financial year ended March 31, 2024, on Saturday (May 4). (PTI)

"One can be a citizen or not but there is no provision for doubtful citizen. A case is still pending in the Supreme Court on whether the 'D' voter should be completely removed or not," he said.

BJP's Silchar candidate Parimal Suklabaidya claimed that once the citizenship issue is resolved under the Citizenship Amendment Act (CAA), the issue of D-voters for the Bengali Hindus will also be addressed.

"It is just a matter of time. The issues of displaced people due to the partition of the country will be resolved with the initiative of the NDA government at the Centre," Suklabaidya told PTI.

His Congress rival Surya Kanta Sarkar said that the chief minister is making it an election issue but 'people are not convinced about his promises".

'If Sarma wanted to resolve the issue of Bengali Hindus, he could have done it earlier. It is also not possible to do it in six months with any government policy. The administration can only ask the EC to withdraw the directive," he added.

Social activist Kamal Chakraborty, who has been working for the removal of the foreigner tag on many people in the Barak valley and also for the release of those detained, said there are around 3,500 'doubtful' voters in the Barak valley and most of them are below the poverty line. "When they were sent to detention centres, their lives were ruined to meet legal costs and most of them suffered from health issues. However, no one is now in the Silchar detention centre," he told PTI.

Fire breaks out in Gossaigaon

The fire personnel were able to douse the fire at 10 am on Wednesday.

At one point when the situation got out of control the sub-divisional administration erected barricades in the larger area and stopped the movement of public including vehicles.

Calcutta HC ruling sparks political storm

The recent verdict by the Calcutta High Court nullifying all appointments stemming from the 2016 School Service Commission (SSC) test has sent shockwaves through West Bengal's political landscape. The ruling, stemming from investigations by the Central Bureau of Investigation (CBI) into alleged irregularities, has left nearly 26,000 teachers and non-teaching staff facing uncertain futures. While the ruling aims to address illegality and bribery within the recruitment process, its sweeping nature risks punishing those who secured their positions through legitimate means. \$95 billion weapons bills will prolong deadly wars in Ukraine and Gaza

S plitting President Joe Biden's bonus war budget bill into several pieces proved to be the winning formula to getting (most of) it passed in the House after months of trying to clear the package as a whole repeatedly hit a wall.

In a series of five separate votes over the weekend, the House approved a total of \$95 billion in fresh military funding for Ukraine Israel and Taiwan along with

first case and a U.S.-backed coup in Kiev in 2014 or an eastward-encroaching NATO military alliance in the second-was absent from his speech. His focus was solely on protecting the State of Israel and shielding Ukraine from Russian aggression. No mention was made of the need to seek a ceasefire and negotiations for a lasting peace in either conflict.

never paired with a critique of U.S. imperialism generally or any analysis of the profiteers who benefit from war. Instead, she tries to manipulate anti-war Americans into supporting the far-right's fascist agenda.

Meanwhile, as the Freedom Caucus uses Ukraine as a political prop, behind the scenes, Trump is already laying the groundwork to also extend the Ukraine-Russia war if he recaptures the White House. Trump did not oppose the Ukraine weapons bill; instead, he asked why Europe wasn't spending more on the effort. He met with Poland's far-right President Andrzej Duda in New York last week. Seeking to wring more money out of the U.S. and Europe, Duda has been constantly amping up the conflict between the West and Russia He has claimed, without proof, that there is a "high probability" of Russia attacking other countries in Europe and has pushed NATO alliance members to increase their war preparations. His government already spends more than 4% of its GDP on the military, most of that going toward the purchase of weapons from U.S. arms compa-The quickest and easiest moneymaking comes from ramping up production of already-existing weapons systems. like the 2000-lb. bombs Israel has used to slaughter Palestinians and the rockets Ukraine uses in its fight against Russia. Industry analysts interviewed by Reuters confirmed it: Stronger demand for these systems "will quickly flow to the corporate bottom line." The final steps required to get the money flowing into the arms companies' bank accounts are approval of the new bills by the U.S. Senate and the signature of Biden. He promised to put pen to paper as soon as the laws arrive on his desk. (IPA Service)

In the wake of the prestigious award bestowed upon the Associated Press (AP) for a deeply disturbing image, the realm of journalism finds itself embroiled in a maelstrom of controversy and grief. The photograph in question, captured by freelance photojournalist Ali Mahmud, depicts the harrowing scene of Hamas terrorists callously parading the near-naked body of Shani Louk through Gaza's streets. This tragic tableau, born from the aftermath of a Hamas terrorist attack, has ignited a firestorm of condemnation and sorrow.

The decision to honor such a distressing image with a top accolade at the Pictures of the Year International awards has sparked widespread outrage and disbelief.

M a n y voices, both within the journalistic community and beyond, have decried the

use of Louk's image as a reprehensible glorification of terrorism. Social media platforms have become a battleground of dissent, with users expressing their anguish and disgust at the perceived insensitivity of awarding such a photograph.

At the heart of this controversy lies the poignant story of Shani Louk, a vibrant 23-year-old German Israeli tattoo artist whose life was tragically cut short amidst the chaos of a terrorist siege. Louk's untimely death and the subsequent desecration of her body stand as a stark reminder of the human cost of terrorism and the profound grief it leaves in its wake.

Despite the outcry, the Associated Press stands by its recognition, affirming their win in the "Team Picture Story of the Year" category. The inclusion of Louk's photo, alongside others, in AP's award-winning collection serves as a contentious assertion of journalistic integrity amidst a storm of controversy.

Ali Mahmud, the freelance photojournalist responsible for capturing the haunting image, finds himself at the center of scrutiny and condemnation. Critics question Mahmud's ethical responsibility in documenting such a deeply distressing scene, arguing that his actions serve to sensationalize and exploit the suffering of innocent victims for personal gain.

In a further twist to the saga, legal action has been initiated against the Associated Press by survivors of terrorist attacks, alleging the organization's complicity in perpetuating terrorist propaganda through its employment of freelance photojournalists with ties to Hamas.

However, the scars of this controversy run deep, serving as a sobering reminder of the ethical responsibilities inherent in the field of photojournalism.

As the dust settles, calls for respect and remembrance ring out, urging us to honor Shani Louk's memory not through the lens of terrorism, but through the vibrant fabric of her life and the indelible mark she left on those who knew and loved her. In the face of tragedy, it is our collective responsibility to tread with compassion and dignity, lest we risk furthering the anguish of those who have already suffered more than words can convey. okraine, Israel, and Talwan, along with new sanctions on Iran and steps toward banning social media app TikTok, a GOP pet cause. by Republicans when it came to Ukraine and progressive Democrats on Israel. Shoehorning Israel's war against the Palestinian people and the Ukraine-Russia war together in his October speech requesting the funds, Biden deployed a narrative that equated "terrorists like Hamas" with "tyrants like Putin."

Biden hoped linking the two fights would make it easier to secure the money. Any background context to the two wars-75 years of Palestinian dispossession in the Mike Johnson equivocating for months. After seeing his predecessor, Kevin Mc-Carthy booted from his seat by the rightwing Freedom Caucus for working to pass a budget measure together with the Democrats, Johnson was reluctant to be seen as cooperating with the opposition.

Iran's military strikes against Israel last week in retaliation for Netanyahu's bombing of its embassy in Syria, however, appeared to have moved Johnson to action. Democrats unanimously approved the \$61 billion Ukraine bill, waving blue and vellow flags as they cast their votes. President Volodymyr Zelensky will now get a backlog of equipment he's been demanding, including artillery shells, air defense missile systems, and deep-strike rockets capable of hitting far inside Russian territory. A large chunk of the money-at least \$23 billion-goes almost immediately to U.S. weapons corporations like Northrup Grumman, Lockheed Martin, and Raytheon. That portion of the funds will be spent "restocking" U.S. arsenals that have already been emptied out and sent to Ukraine. This subsidy to arms companies

NATO consensus in Washington, most socalled "mainstream" Republicans joined the Democrats in passing the Ukraine weapons bill. Dissenting were 40 members of the MAGA faction, the House Freedom Caucus. Much of the liberal corporate media rushed to characterize their "no" votes as proof of the affinity for Vladimir Putin that they supposedly share with Donald Trump.

In truth, however, with a close election coming, the Freedom Caucus is more likely attempting to opportunistically take advantage of widespread anti-war sentiment in the country and the reluctance many American voters feel when it comes to spending billions on overseas wars.

Some 55% of Americans in one recent poll-including majorities of both Democrats and Republicans-oppose allocating money for more weapons in the Ukraine war. Nearly 80% fear the war will drag on for years if there are no serious moves toward a ceasefire and peace negotiations.

"The days are over of the old Republican Party that wants to fund foreign wars and murder people in foreign lands while they stab the American people in their face and refuse to protect Americans and fix our problems," Georgia Rep. Marjorie Taylor-Greene declared on Saturday.

he second phase will be between 'Mangalsutra' and 'Muslim'. Prime Minister Narendra Modi and, to a lesser extent, Congress leader Rahul Gandhi have seen to it. within grasping distance of Modi's "370" target. The BJP/RSS have it all planned out. With that Modi closed the door on any rapprochement with the Muslim community. His differences with the community are now fully out in the open. On Tuesday, Modi taunted Rahul Gandhi for saying the Congress will 'X-ray" to detect wealth for redistribution among minorities and the SC/ST. Someday the Congress will come to power and Rahul Gandhi will become Prime Minister. And then, the "financial and institutional survey" to ensure Muslims got their slice of the "country's wealth" on which they have first claim. It will not happen after this election. But Rahul Gandhi "is young" and has a long political career left, and Rahul has also promised to "get revolutionary" after the "financial and institutional survey". Rahul Gandhi's video has gone viral. Former Prime Minister Manmohan Singh's video has gone viral and Prime Minister Narendra Modi's video has gone viral. (IPA Service)

By 2050, the world will lose \$38,000,000,000,000 to climate change, dragging down average income by 19%

The world is already committed to a 19 per cent permanent average reduction in incomes across countries due to warming and consequent changes in climate by 2050, according to a new study published in the journal Nature by scientists from the Potsdam Institute of Climate Impact Research in Ger-

many. This is in comparison to a baseline world without climate change. The largest economic losses would be in the lower latitude countries in South Asia and Africa, which have contributed the least greenhouse gas (GHG) emissions and have the lowest present-day incomes.

This figure is independent of the choices made henceforth regarding GHG emissions from various human activities that have made the planet warmer by at least 1.1 degree Celsius since the preindustrial period (1850-1900).

These economic damages from climate change would be annually worth \$38 trillion (in 2005 international dollars) in 2049 under a plausible middle-of-theroad GHG emissions sce-

Parallel to the growing history of banality of human induced climatic changes is the increasing number of ways it is being addressed. Global warming transformed to climate change; its causes expanded from carbon dioxide to hydrochlorofluorocarbons (HCFCs), depletion of rainforests, cows farting and fossil fuels.

Suggestions on the ways to combat climate change now encompass renewable and nuclear energy, energy efficiency, electric vehicles (EV), electricity and water conservation, public transport, cycles, lifestyle choices like vegetarianism and socio-economic ideas like net zero, circular economy and degrowth. Financial systems like carbon offset and carbon trading materialised.

Consequences of, and reasons to, prevent climate change now include temperature and sea level rise, glaciers melting, island and coastal submergence, increase in frequency and intensity of weather events, rise in health issues and disease transmission, deaths of humans and flora-fauna, impacts on agriculture from weather fluctuation

and pests, and migration.

Maybe the answer lies in the global value of the fossil fuel market 'USD 7.2 trillion in 2022 and is expected to reach around USD 11.78 trillion by 2032'. Compare that with the global renewable energy market which ranges from \$1085 billion in 2023 to \$1.21 trillion in 2023, which is expected to increase to \$1912.12 billion (or 1.9 trillion) by 2030. Thus the 2023 Conference of Parties on Climate Change was held in oil producing United Arab Emirates.

The problem in climate solutions

Attempts to prevent climate change use the very things, and lifestyle systems, that cause it. Ergo the increasing number and variety of people impacted by, and working to, prevent climate change. Unsurprisingly, annual climate summits have grown bigger. The 2021 COP 26 in Glasgow had 40000 attendees, there were approximately 90,000 attendees at COP 28. There are other small and large conferences on this issue that draw international attendees.

If this is the situation amongst those concerned with climate change what of the lay people? There is a perception that the common person will not support the fight against climate change if told humankind needs a radical makeover.

This existential threat is being fought with an attitude which translates into the perception that EV's can combat climate change. Are EV's a panacea if powered by fossil fuel generated electricity, ore mined for its parts and petrochemical products like plastic used? Similarly, bio-fuels are not alternatives to fossil fuel if sourced from chemical intensive agriculture or if agricultural produce is diverted from mouths to industries

The International Energy Agency (IEA) muddies the water with terms like 'Bioenergy' which is 'is produced from organic material, known as bio mass, which contains carbon absorbed by plants through photosynthesis. When this biomass is used to produce energy, the carbon is released during combustion and returns to the atmosphere. As more biomass is produced an equivalent amount of carbon is absorbed, making modern bioenergy a near zero-emission fuel '. By their logic, fossil fuels are ancient forms of bioenergy. Yes, achievements have been made in combating climate change but these have been undeniably insufficient and even ineffectual. Actually, these raise the hypothetical question – would a person being beaten want the beating to reduce or stop? The consequences of climate change are too vast and egregious to just want to reduce its impact. Given the current system to combat climate change is faulty – it being built on the foundations that are causing the problem - some kind of 'impact reduction' is what may eventually be delivered. The inconvenient truth is, in the current paradigm all climate change action is perceived as a big step forward if not a major victory. This lie lulls us into a false sense of security much like the faith that was reposed on the unsinkability of the Titanic. Thus, we continue charting an iceberg laden course instead of opting for another route. The Covid years decreased pollution, unfortunately people also lost jobs. There is much to learn from those times to combat climate change. Instead of a sudden unplanned stop on all economic activity there can be a staggered reduction in global socio-economic activity. This is not something new, for example, four-day work weeks have been tried out successfully across the globe even before the Covid years. Generating profit and diverting some of it to fund climate action or profit making from climate action are no better than the 'science' of alchemy because it just broadens the scope of normal socioeconomic activity. In the present study conducted to explore the physical characteristics and social organisation within mixedspecies assemblages of Nilgiri langurs and tufted grey langurs discovered at elevations ranging from 300 metres to 800 metres in the Anamalai Tiger Reserve, a significant number of mixed morphotypes were identified within the population.

A morphotype refers to any of a group of different types of individuals of the same species in a population. The research paper indicates that while the dark grey langurs were observed at lower elevations, lighter brown

almost never form multi-male groups. "Nilgiri langurs generally organise into single-male, multi-female groups, with approximately 60% of the group being adults, and the rest consisting of sub-adults and juveniles. Multi-male groups are not observed," highlights principal scientist at Salim Ali Centre for Ornithology and Natural History, Honnavalli N Kumara who was a part of the study.

It is not uncommon to find mixed species organisations among monkeys. Singh points to similar observations made from parts of Bhutan and northeast India. Naturalist specialised in the wild fauna of northeast India, Anwaruddin Choudhury recalls seeing hybrid langurs during his visit to south-central Bhutan in a paper published in 2008.

These "natural" hybrids between capped langurs (Trachypithecus pileatus) and golden langurs (Trachypithe-Hills, and Periyar-Agasthyamalai cus geei) were spotted in the dzongkhag (district) of Zhemgang. He writes: "The hybrid langurs observed ulations. near the town of Zhemgang resemble golden langurs from a distance, but the various shades of grey become evident on closer inspection. Kumara emphasises that the study has crucial implications on the conservation of Nilgiri langurs whose population is on the decline. Listed as "vulnerable" on the IUCN Red List of Threatened Species, forest fragmentation, anthropogenic interventions, poaching, etc. are listed as some of the threats to this species restricted to the Western Ghats.

In a previous paper published in 2023, Singh, Kumara and team assess the distribution, social organisation and management of Nilgiri langurs to find five significant populations in five different regions of the Western Ghats - Nilgiri-Brahmagiri, Siruvani, Anamalai- Parambikulam, Cardamom

Kumara says that there is a misconception that Nilgiri langur is widespread and common which is far from the truth and that if hybridisation is occurring, there is an urgent need to take measures to preserve the original genetic pool of the species. As per the US Department of Defense, water scarcity fuelled by climate change could cause future wars. To catalyse combating climate change, moral arguments were found — the unfairness of rich countries, prime contributors to climate change, demanding poor countries to stop polluting - and poorer countries have to bear the brunt of climate change even when this is something they did not contribute. Understandably climate change has posed challenges for indigenous people, children and future generations as well.

Several studies and researches to understand the effects of climate change have thrown light on new constituencies of climate victims like its impacts on women. This has centred the discussion around concepts like climate justice, climate equity, climate inclusion, climate mitigation, climate adaptation, climate resilience all of which argue for climate action.

Over the years, industries, governments and cities have also started initiatives to thwart this existential threat. Citizens coalesced together, and NGOs were formed, to pressurise governments and industry to do more. To further combat the climate crisis, new forms of non-violent protest were devised, lawsuits were filed, and won, by citizens against their governments as they demanded more focussed attention on the burning issue and some investment, and pension funds, divested off fossil fuels

Notably, distinguished works focussing on the distressing reality of climate change have also been awarded with prestigious awards like the Oscars and Nobel Prizes.

Our predicament and reasons thereof

In the 2015 Paris Agreement, world leaders have promised to 'pursue efforts to limit the temperature increase even further to 1.5 degrees Celsius'. As per the EU climate service, the 1.5C threshold was breached for nearly 50% of 2023.

The National Oceanic and Atmospheric Administration states 'global avage atmospheric carbon dioxide was 417.06 parts per million ("ppm" for short) in 2022, setting a new record high. The increase between 2021 and 2022 was 2.13 ppm — the eleventh year in a row where the amount of carbon dioxide in the atmosphere increased by more than 2 ppm'. 'Asia is world's most disaster-hit region': Breaking down new climate report

Asia is warming faster than the global average. The warming trend has nearly doubled since the 1961–1990 period." This is what the World Meteorological Organization's (WMO) State of the Climate in Asia 2023 report, published on Tuesday, 23 April, says.

The report also states that Asia was the "world's most disaster-hit region" due to climate events in 2023. As many as 79 hydrometeorological hazard events were reported in Asia the same year. Over 2.000 people died due to these climate disasters, and close to nine million people were affected. The Quint breaks down the key findings of the report for you.

Key findings of the report

The WMO, in the 2023 report, found:

• Heatwaves became more severe in Asia in 2023.

• Heat-related deaths were underreported.

• Close to 80 percent of the extreme weather events were floods and storms that led to the most number of deaths and financial losses.

· Droughts occurred in Southwest China nearly every month in the last year.

• At least 20 out of 22 glaciers in Asia had "continued mass loss," and snow cover extent in Asia reduced in 2023 from the 1998-2020 average.

• Sea surfaces in Asia are warming "more than three times faster than the globally averaged sea surface temperature."

• Marine heat waves, spanning several months, were observed.

"The annual mean near-surface temperature over Asia in 2023 was the second highest on record, 0.91

 $^{\circ}C$ [0.84 $^{\circ}C-0.96$ $^{\circ}C$] above the 1991–2020 average and 1.87 $^{\circ}C$ [1.81 $^{\circ}C-1.92$ $^{\circ}C$] above the 1961– 1990 average.

State of the Climate in Asia 2023 report

Speaking to The Quint about the report, Dr Vishwas Chitale, Senior Programme Lead, Council on Energy, Environment & Water (CEEW), said, "The report underscores a worrying trend we're seeing across Asia. These extreme climate events like floods, cyclones and heatwaves, if not met with proper preparedness and policies, have the potential to cause loss of life and economic hardship. This vulnerability highlights the urgent need for a multipronged approach to rapidly accelerating climate change.

Zooming In on India

Highlighting the reality of climate change in India, the report stated that:

· Severe heat waves from April-June led to at least 110 deaths in the country.

• Even as rains in the summer-monsoon were below average in India, floods and storms from July-August "resulted in more than 600 reported deaths across India, Pakistan, and Nepal.'

• As many as six tropical cyclones occurred in the Indian subcontinent, causing widespread destruction across regions.

• The sea level rise in Bay of Bengal in 2023 was the second-highest in the region, "30 percent above the global average.

 The rise in temperatures most affected the northern and eastern regions of India.

The WMO further added, "In India, Yemen, and Pakistan, floods were the natural hazard event which

caused the greatest number of fatalities."

The Quint had reported in June 2023 that close to 68 people in Uttar Pradesh's Ballia and 53 people in Deoria succumbed to heat-related deaths.

In October the same year, the South Lhonak Glacial Lake in Sikkim had burst, which led to the Teesta river flooding and wreaking havoc across four districts in the state - killing more than 40, and causing significant economic loss. Dr Chitale said, "Research shows the need for strengthening critical infrastructure - healthcare, transportation, and power grids - through climate-proofing measures. Upgrading standards and building codes with the changing climate in mind is essential. Additionally, we cannot ignore the rising heat stress in our cities.

What Next?

After the report was released, WMO Secretary-General Celeste Saulo said, "Many countries in the region experienced their hottest year on record in 2023, along with a barrage of extreme conditions, from droughts and heatwaves to floods and storms. Climate change exacerbated the frequency and severity of such events."

Armida Salsiah Alisjahbana, Executive Secretary of the Economic and Social Commission for Asia and the Pacific (ESCAP), an organisation that was also involved in bringing out the report, emphasised on how "vulnerable countries were disproportionately impacted," like Bangladesh and Myanmar that were hit by cyclone Mocha. The researchers suggest, "There is an urgent need to advance efforts and provide more tailored support and services to address strategies and interventions to effectively mitigate rising disaster risks." 

Senate passes bill forcing TikTok's parent company to sell or face ban, sends to Biden for signature

WASHINGTON, April 24: The Senate passed legislation Tuesday that would force TikTok's Chinabased parent company to sell the social media platform under the threat of a ban, a contentious move by U.S. lawmakers that's expected to face legal challenges and disrupt the lives of content creators who rely on the short-form video app for income.

The TikTok legislation was included as part of a larger \$95 billion package that provides foreign aid to Ukraine and Israel and was passed 79-18. It now goes to President Joe Biden, who said in a statement immediately after passage that he will sign it Wednesdav.

A decision made by House Republicans last week to attach the TikTok bill to the high-priority package helped expedite its passage in Congress and came after negotiations with the Senate, where an earlier version of the bill had stalled. That version had given TikTok's parent company, ByteDance, six months to divest its stakes in the platform. But it drew skepticism from some key lawmakers concerned it was too short of a window for a complex deal that could be worth tens of billions of dollars.

The revised legislation extends the deadline, giving ByteDance nine months to sell TikTok, and a possible three-month extension if a sale is in progress. The bill would also bar the company from controlling TikTok's secret sauce: the algorithm that feeds users videos based on their interests and has made the platform a trendsetting phenomenon.

TikTok did not immediately return a request for comment on Tuesday night. The passage of the legislation is a culmination of long-held bipartisan fears in Washington over Chinese threats and the ownership of TikTok, which is used by 170 million Americans. For years, lawmakers and administration officials have expressed concerns that Chinese authorities could force ByteDance to hand over U.S. user data, or influence Americans by suppressing or promoting certain content on TikTok.

"Congress is not acting to punish ByteDance, Tik-

Tok or any other individual company," Senate Commerce Committee Chairwoman Maria Cantwell said. "Congress is acting to prevent foreign adversaries from conducting espionage, surveillance, maligned operations, harming vulnerable Americans, our servicemen and women, and our U.S. government personnel.

Opponents of the bill say the Chinese government could easily get information on Americans in other ways, including through commercial data brokers that traffic in personal information. The foreign aid package includes a provision that makes it illegal for data brokers to sell or rent "personally identifiable sensitive data" to North Korea, China, Russia, Iran or entities in those countries. But it has encountered some pushback, including from the American Civil Liberties Union, which says the language is written too broadly and could sweep in journalists and others who publish personal information.

Many opponents of the TikTok measure argue the best way to protect U.S. consumers is through implementing a comprehensive federal data privacy law that targets all companies regardless of their origin. They also note the U.S. has not provided public evidence that shows TikTok sharing U.S. user information with Chinese authorities, or that Chinese officials have ever tinkered with its algorithm.

"Banning TikTok would be an extraordinary step that requires extraordinary justification," said Becca Branum, a deputy director at the Washington-based Center for Democracy & amp; Technology, which advocates for digital rights. "Extending the divestiture deadline neither justifies the urgency of the threat to the public nor addresses the legislation's fundamental constitutional flaws."

Sen. Ron Wyden, a Democrat who voted for the legislation, said he has concerns about TikTok, but he's also worried the bill could have negative effects on free speech, doesn't do enough to protect consumer privacy and could potentially be abused by a future administration to violate First Amendment rights. China blasts US military aid to Taiwan, saying the island is entering a 'dangerous situation'

BEIJING, April 24: China on Wednesday blasted the latest package of U.S. military assistance to Taiwan on Wednesday, saying that such funding was pushing the self-governing island republic into a "dangerous situation.

The U.S. Senate late Tuesday passed \$95 billion in war aid to Ukraine, Israel and Taiwan after months of delays and contentious debate over how involved the United States should be in foreign wars. The package included \$8 billion for Taiwan, meant to counter the threat of invasion by China, which claims the entire island as its own territory and has threatened to take it by force if necessary

The mainland's Taiwan Affairs Office said the aid "seriously violates" U.S. commitments to China and "sends a wrong signal to the Taiwan independence separatist forces.

Office spokesperson Zhu Fenglian added that Taiwan's ruling pro-independence Democratic Progressive Party, which won a third four-year presidential term in January, is willing to "become a pawn for external forces to use Taiwan to contain China, bringing Taiwan into a dangerous situa-

On Tuesday, Taiwan's President-elect Lai Ching-te told a visiting U.S. Congressional delegation that the aid package would "strengthen the deterrence against authoritarianism in the West Pacific ally chain" and "help ensure peace and stability across the Taiwan Strait and also boost confidence in the region."

The package has had broad congressional support since Biden first requested the money last summer. But congressional leaders had to navigate strong opposition from a growing number of conservatives who question U.S. involvement in foreign wars and argue that Congress should be focused instead on the surge of migration at the U.S.-Mexico border. The package covers a wide range of parts and services aimed at maintaining and and upgrading Taiwan's military hardware.

Separately, Taiwan has signed billions in contracts with the U.S. for latest-generation F-16V fighter jets, M1 Abrams main battle tanks and the HIMARS rocket system, which the U.S. has also supplied to Ukraine

Taiwan has also been expanding its own defense industry, building submarines and trainer jets. (AP)

Arrests follow barricades and encampments as college students nationwide protest Gaza war

JERUSALEM, April 24: Standoffs between pro-Palestinian student protestors and universities grew increasingly tense on both coasts on Wednesday night. Hundreds of protesters at an encampment at Columbia University faced a deadline from the administration to clear out, while dozens barricaded themselves inside two buildings on a Northern California college campus for the second night.

Both are part of intensifying demonstrations over Israel's war with Hamas by university students across the country, leading to dozens of arrests on charges of trespassing or disorderly conduct.

Columbia's President Minouche Shafik in a statement Wednesday set a midnight deadline to reach an agreement with students to clear the encampment, or "we will consider alternative options." That deadline passed without news of an agreement. Videos show some protestors taking down their tents while others doubled down in speeches.

The heightened tension arrived the night before U.S. House Speaker Mike Johnson's trip to Columbia to visit with



Jewish students and address antisemitism on college campuses.

Across the country, protestors at California State Polytechnic University, Humboldt, started using furniture, tents, chains and zip ties to block the building's entrances Monday evening. The defiance was less expected in the conservative region of California, some 300 miles (480 kilometers) north of San Francisco. "We are not afraid of you!" the protestors chanted before officers in riot gear pushed into them at the building's entrance, video shows. Student Peyton McKinzie said she was walking on campus Monday when she saw police grab-

"I think a lot of students are in shock about it," she told The Associated Press. Three students have been arrested, according to a statement from Cal Poly Humboldt, which shutdown the campus

until Wednesday. An unknown number of students had occupied a second campus building Tuesday.

The upwelling of demonstrations has left universities struggling to balance campus safety with free speech rights. Many long tolerated the protests, which largely demanded that schools condemn Israel's assault on Gaza and divest from companies that sell weapons to Israel.

Now, universities are doling out more heavy-handed discipline, citing safety concerns as some Jewish students say criticism of Israel has veered into antisemitism.

Protests had been bubbling for months but kicked into a higher gear after more than 100 pro-Palestinian demonstrators who had camped out on Columbia's upper Manhattan campus were arrested Thursday. (AP)

Former Japanese PM Taro Aso meets Trump

WASHINGTON, April 24: Ex-Japanese prime minister Taro Aso has met former president Donald Trump and both the leaders discussed the enduring importance of the US-Japan alliance to their physical and economic security in the strategic Indo-Pacific region.

Aso, vice president of Japan's ruling Liberal Democratic Party, met Trump on Tuesday at the Trump Tower in Manhattan.

Both the leaders discussed the enduring importance of the US-Japan alliance to both countries' physical and economic security and stability in the Indo-Pacific, according to a statement issued by the Trump Campaign on the meeting with the 83-year-old visiting Japanese leader.

"They also discussed challenges posed by China and North Korea. President Trump praised Japan's increased defence spending, the press release said after the meeting.

"He's a highly respected man in Japan and beyond and somebody that I've liked and I've known through our very dear friend Shinzo," Trump, the 77-year-old presumptive nominee of the Republican Party in the 2024 US presidential race, told reporters in New York.

Indonesia declares Prabowo Subianto president-elect after court rejects rivals' appeal



JAKARTA, April 24: Indonesia's electoral commission formally declared Prabowo Subianto president-elect in a ceremony on Wednesday, after the country's highest court rejected challenges to his landslide victory lodged by two losing presidential candidates

Subianto, who is currently defense minister, won the election with 58.6 per cent of the votes, or more than 96 million ballots, more than twice the amount received by either of the other two candidates. But his rivals alleged that his victory had depended on large-scale fraud and widespread state interference.

Authorities blocked streets leading to the General Election Commission compound, where more than 4,200 police and soldiers were deployed.

Wearing matching long-sleeved white shirts, Subianto and vice president elect Gibran Rakabuming Raka waved to their supporters as they arrived at the building.

'The race has finished ... the tough contest, with sometimes heated debates, is over," Subianto said during the ceremony, attended by the country's political elite, including rival candidate Anies Baswedan and his running mate Muhaimin Iskandar. "And now our people demand that political leaders must work together and collaborate for the people's welfare and to eliminate poverty and corruption in Indonesia," Subianto said.

Subianto will take office in October, succeeding the popular Joko Widodo, the country's first president from outside the Jakarta elite. The General Election Commission certified the election results on March 20, but the formal declaration ceremony was put on hold following legal

challenges from rival candidates, former Jakarta Gov Anies Baswedan and former Central Java Gov Ganjar Pranowo, who sought to annul the result and demand a revote. They also alleged nepotism, challenging the candidacy of outgoing President Joko Widodo's eldest son, Raka, as Subianto's running mate.

Baswedan and Pranowo argued that Raka, 37, should have been disqualified because the minimum age for candidates is 40, and they asked the court to bar him from a revote. Before the election, Raka was granted a controversial exception to that requirement by the Constitutional Court, which was then led by Anwar Usman, Widodo's brother-in-law. Usman was later forced to resign as chief justice for failing to recuse himself.

In a 5-to-3 decision, the Constitutional Court rejected the arguments on Monday, saying the legal teams of the losing candidates had failed to prove allegations that Subianto's victory was the result of widespread fraud. That verdict cannot be appealed.

The case was decided by eight justices instead of the full nine-member court because Usman, who is still on the court as an associate justice, was required to recuse himself.

Baswedan and Iskandar conceded and congratulated Subianto and Raka shortly after the Constitutional Court's decision was read out on Monday, saying they are committed to maintaining the principle of peaceful transfer of power and that "we choose to be part of continuing to build the quality of Indonesian democracy.'

Pranowo and his running mate, Mohammad Mahfud, also congratulated Subianto. "We accept and fully respect the decision of the Constitutional Court," Pranowo said, "Like or dislike, we have to accept it because it's final, legal and binding.

A longtime commander in Indonesia's Kopassus special forces, Subianto was discharged from the military in 1998 after Kopassus soldiers tortured activists who opposed dictator Suharto, his fatherin-law. (AP)

North Korea sends a delegation to Iran in a growing effort to break its diplomatic isolation

SEOUL, April 24: A high-level North Korean economic delegation was on its way to Iran, the North's state media said on Wednesday, for what would be the two countries' first known talks since the start of the COVID-19 pandemic.

Embracing the idea of a "new Cold War," North Korean leader Kim Jong Un is pushing to build up cooperation with countries confronting the United States, as his intensified weapons tests prompted the US and South Korea to expand their military drills.

Pyongyang's delegation led by Yun Jung Ho, North Korea's minister of external economic relations, flew out Tuesday for the trip to Iran, official Korean Central News Agency said Wednesday.

State media did not immediately provide further details. Pyongyang and Tehran are among the

few governments in the world that support Russian President Vladimir Putin's invasion of Ukraine and both have been accused of providing Russia with military equipment.

The last known time North Korea sent senior officials to Iran was in August 2019, when a group led by Pak Chol Min. vice chair of Pyongyang's rubber-stamp parliament, made a weeklong visit. The two countries had active diplomatic exchanges until North Korea sealed its borders in an effort to stave off the pandemic, before a cautious reopening in 2023.

South Korea's Unification Ministry, which handles affairs with the North, did not immediately comment Yun's visit to Iran.

North Korea has made efforts for months to boost the visibility of its ties with Russia and China as Kim attempts to break out of diplomatic isolation and join a united front against the US.

In 2023, Kim visited Russia's Far East for a rare summit with Putin, which highlighted the countries' expanding military cooperation, including the North's alleged

transfers of artillery shells, missiles, and other munitions to Russia.

Earlier this month, Kim hosted top Chinese official Zhao Leji, who heads the ceremonial parliament and ranks third in the ruling Communist Party hierarchy. It was the highest-level meeting between the countries in years.

On Wednesday, Kim Yo Jong, the North Korean leader's powerful sister, slammed the latest rounds of US-South Korean joint military drills and insisted that the allies will never break the North's determination to build up "our overwhelming and most powerful military muscle."

The statement comes a week after US Ambassador to the United Nations Linda Thomas-Greenfield called for the international community to be alert to the possibility of military cooperation between North Korea, Iran and Russia, Iran has been accused of providing drones to Russia for use in the war against Ukraine. (AP)

President Joe Biden hosted Japanese Prime Minister Fumio Kishida earlier this month at the White House for a state visit, during which the president touted the US-Japan alliance as being "stronger than it's ever been" and announced new plans for military cooperation with the country.

The meeting between Trump and Aso took place after the former president's appearance in court for his hush money trial. Trump has in recent weeks increasingly met with foreign leaders, who have sought to bolster ties as polls continue to show a tight race to the White House between him and President Biden when the elections take place in November.

Japan has been at the centre of Biden's alliance-building in the Indo-Pacific region, with Kishida significantly shifting the country's defence posture in recent years and providing ongoing support to Ukraine, CNN reported.

Last week, Trump met with Polish President Andrzej Duda at Trump Tower, where the two discussed NATO spending over dinner, according to the former president's campaign

Earlier this month, Trump also met with British Foreign Secretary David Cameron at his Mar-a-Lago resort in Florida, the report added. (PTI)

China to send three astronauts to Tiangong space station, part of its ambitious program

JIUQUAN SATELLITE LAUNCH CENTER, April 24: China's space agency is making final preparations to send the Shenzhou-18 crew into low-Earth orbit on Thursday as part of its ambitious space program that aims to put people on the moon by 2030.

In a press conference on Wednesday, the China Manned Space Agency (CMSA) introduced the three astronauts; Commander Ye Guangfu, 43, a veteran astronaut who was part of the Shenzhou-13 mission in 2021; and astronauts Li Cong, 34, and Li Guangsu, 36, who will go to space

for the first time. The three-member crew's spacecraft is set for lift-off at 8:59 p.m. (1259 GMT) from the Jiuquan Satellite Launch Center on the edge of the Gobi Desert in the

country's northwest. They will relieve the Shenzhou-17 team, who have manned China's Tiangong space station since last October. The crew will spend about six months on the space station. They will conduct scientific tests, install space debris protection equipment on the space station, carry out payload experiments, and popularize science education, among other things, according to Lin Xiqiang,

deputy director of the CMSA. Lin also said China was working toward eventually offering access to its space station to foreign astronauts and space tourists.

"We will accelerate the research and promotion of the participation of foreign astronauts and space tourists in flights with China's space station," he said. "We definitely expect to see astronauts of different identities on

The U.S. — the only country to have previously put astronauts on the moon — aims to put a crew back on the lunar surface by the end of 2025 as part of a renewed commitment to crewed missions. aided by private sector players such as SpaceX and Blue Origin. Four countries, the U.S., Russia China and India, have landed spacecraft on the moon. (AP)

The total number of registered voters was 4,469 in the eight polling stations where voting began at 6 am and ended at 2 pm.

The repolling was necessitated following reports of violence, including damage to electronic voting machines (EVMs), during the simultaneous Lok Sabha and assembly elections in the state on April 19. the official said.



The Election Commission had ordered repolling in Sario under the Bameng assembly constituency in East Kameng district, Longte Loth in the Nyapin segment in Kurung Kumey, and Bogne and

Molom booths under the Rumgong seat in Siang. Dingser, Bogiya Siyum, Jimbari and Lengi under the Nacho constituency in Upper Subansiri were also on the list of booths where repolling was carried

out, Chief Electoral Officer Pawan Kumar Sain said.

Elaborate security arrangements

were made for the repolling.

"For these eight polling stations, we had extensive deployment of security personnel and we will ensure that this time, if something happens or if anybody tries to snatch or touch the EVMs unlawfully, strict action will be initiated," he said.

An estimated 82.71 per cent of the total 8,92,694 voters had exercised their franchise on April 19 to elect 50 MLAs for the 60-member assembly in the northeastern state. The ruling BJP has already won ten assembly seats unopposed. The

Counting of votes for assembly elections would be held on June 2, while that of Lok Sabha polls would be on June 4. (PTI)

Healing hearts: The compassionate care of unsung heroes of Manipur

GUWAHATI, April 24: In the serene landscapes of Manipur, where the echoes of ethnic strife often drown out the whispers of hope, there exists a beacon of compassion amidst the turmoil the Indian Army.

Far beyond their duty, they stand tall as pillars of support, bringing healing and solace to those in need, embodying the very essence of humanity in the face of adversity. Election a ritual in remote Tripura village with no electricity, mobile connectivity

CHAWMANU (TRIPURA), April **24:** Bikramjoy Tripura, a 'jhumia' (shifting cultivator) residing at a remote village in Tripura's Dhalai district said politicians come to his hamlet during elections and though their promises remain unfulfilled, he casts vote every time with the hope of getting electricity at his home and mobile phone connectivity in the area.

The main problem of Vidya Kumar Roaja Para village, which is located around 62 km away from Ambassa, the district headquarters of Dhalai is connectivity as the village does not have a motorable road from Chawmanu, the block headquarters, he told the PTI reporter who visited this remote village. There is no electricity, mobile connectivity or healthcare facility in our

village, he said. "The Lok Sabha election is coming and we all will vote on April 26 but it remains a five-year ritual for us because it will bring no solution to our problems", the 41-year-old said.

"During monsoon, the village which houses 763 jhumia families, all involved in shifting cultivation, remains cut off from the rest of the state. The road from Chawmanu to Vidya Kumar Roaja Para (Thalcherra) turned into a death trap because of the lack of repair for the past several years. Jhumia families living in 11 villages need to travel 10 to 20 km on foot to collect ration as here is no road from Vidva Kumar Roaja para to their villages," said Bikramjit, a local BJP leader.



"We have not seen our MLA Shambu Lal Chakma for many months. He does visit us when the election comes. Hope he will visit our village soon to seek votes", said the 54-year-old woman. The village falls under East Tripura Lok Sabha constituency which goes to voting on April 26.

We have a ration shop at our doorstep but it opens once a week. The ihumias who come from interior hamlets face trouble if they don't get ration stuff on the scheduled day. There are several people living in remote habitations after Vidya Kumar Roaja Para, who have to travel several kilometres on foot to get rice, salt, kerosene and sugar", said Bishaynna Tripura, husband of Chardene Tripura.



PM slams Cong on Pitroda's 'inheritance tax' remark; says its 'dangerous intentions' coming to fore

AMBIKAPUR (CHHATTIS-GARH), April 24: Prime Minister Narendra Modi on Wednesday attacked the Congress over its leader Sam Pitroda's "inheritance tax" remark, saying that the grand old party's "dangerous intentions" of snatching the assets and rights of people have come to the fore

The Congress will loot and equally distribute people's earnings and properties, he claimed while addressing an election rally in Ambikapur, the headquarter of Surguja district, in Chhattisgarh.

"The dangerous intentions of Congress are coming to forth one by one and now it says it will impose inheritance tax. The advisor of 'shehzada' of the 'shahi parivar', who was also the advisor to the shehzada's father, said that more tax should be imposed on the middle class and those who earn by toiling hard," Modi said, apparently referring to Rahul Gandhi and Pitroda

"He (the advisor) said this publicly. Now they (Congress) have gone a step further and Congress is saying it will impose inheritance tax. It will impose tax on the assets inherited by people from their parents. Now, the 'panja'



(Congress poll symbol) will snatch the assets from your children," he said without taking any name.

Modi was apparently referring to a statement made by Indian Overseas Congress chairperson Sam Pitroda at Chicago in America over the inheritance tax law

The PM said the Congress' mantra is "loot of Congress zindagi ke sath bhi, zindagi ke baad bhi".

"Till you are alive, Congress will impose more tax and after your life ends, it will impose the burden of inheritance tax on you. They (Congress) want to snatch your assets and rights of your children," the PM added.

Congress does not want that common Indians give their property to their children. From values to culture, our country is not a consumerist country. We believe in accumulation, enrichment and preservation, he said.

"Today, our nature and environment is protected because of these values. Our old parents, grandparents keep their small ornaments safe thinking that it will be worn by their grandchildren during their wedding. The people of my country are fond of living life by taking loans. People are hard-working and spend as per their needs and have a tendency to accumulate," he said.

The Congress is going to attack strongly on the fundamental values and culture of India. The reason why they have given this statement yesterday is that this thinking of theirs is very old, he said.

Why did a storm trigger in their camp (Congress). When I said that Urban Naxals and Urban Maoists have taken over the Congress, they felt that they should say something to appease America. When Modi made the allegations, they were pretending to turn towards the other side in a bid to balance. But they want to loot your property and snatch the rights of your children. Do you accept it?" he asked and the people replied in the negative. The PM said that till the Congress

was in power in the country, people's money was being looted, but after the BJP government was formed, people's money is being spent on them.

"The Congress's eyes are not only on your reservation, but also on your earnings, your houses, shops and farms. The 'shehzada' of Congress (apparently referring to Rahul Gandhi) says they will conduct an Xray of the property of every house, cupboard and every family in the country. The little wealth and jew-

ellery that our mothers and sisters have, Congress will also get them examined. In Surguja, our tribals wear tribal ornaments and and mangalsutra. Congress will snatch all this from you and they say that they will equally distribute them," he said.

"Do you know to whom they will

distribute it after looting it from you? Will you allow me to commit this sin?" Modi asked. Meanwhile, early in the morning, Sam Pitroda in a series of posts on his 'X' handle said his statement was twisted by the "Godi media" to divert the attention from the lies the PM was spreading about Congress manifesto. "It is unfortunate that what I said as

year. On November 22, 2023, the collegium of the High Court of Chhattisgarh unanimously made the above recommendation for the appointment of Additional Judge Justice Pandey as a permanent judge of that high court and for further extension of the present term of Rajput and Justice Justice Agrawal. "We have duly taken note of the

views of the Chief Minister and the Governor of the State of Chhattis-

garh in terms of the Memorandum of Procedure, the Judge of the Supreme Court who is conversant with the affairs of the High Court of Chhattisgarh was consulted with a view to ascertain the suitability of one of the above Additional Judges for appointment as permanent Judge and for appointment of the other two as Additional Judges for a fresh term.


"The Committee of two Judges of the Supreme Court constituted by the Chief Justice of India in terms of the Resolution dated October 26, 2017 of the Supreme Court Collegium assessed the judgments of the above Additional Judges," the collegium said.

The collegium scrutinised and evaluated the material placed on record to assess the merit and suitability of the names above.

"Having considered all aspects of the matter and on an overall consideration of the above proposal, the collegium is of the view that Justice Rakesh Mohan Pandey, Additional Judge, is fit and suitable for being appointed as permanent Judge and that Justice Sachin Singh Rajput and Justice Radhakishan Agrawal deserve to be appointed for a fresh term as recommended by the collegium of the High Court," it said. Separately, CPI-M general secretary Sitaram Yechury, in a post on X, also urged the Election Commission to take cognisance of the complaint and launch proceedings against Modi and the BJP.

He also demanded that an FIR be lodged. "Urge the ECI to take cognisance of this latest complaint and immediately launch proceedings against Narendra Modi and the Bharatiya Janata Party (BJP). An FIR needs to be lodged for inciting communal passions and hatred," he said

Congress leader and senior advocate Abhishek Singhvi said it was a "trial of the EC" too and the poll panel risks tarnishing its legacy and abandoning its Constitutional duty by setting a precedent of helpless inaction that will go down in infamy. (PTI)

NEW DELHI, April 24: The Congress on Wednesday distanced itself from Sam Pitroda's "inheritance tax" remarks, saying sensationalising them are attempts at diverting attention from Prime Minister Narendra Modi's "malicious" poll campaign. In new book, Ruchir Sharma discusses what has gone 'wrong' with capitalism

NEW DELHI, April 24: Despite all of India's inherent strengths. from a strong entrepreneurial culture to world-class human capital, it will take longer to become a developed nation than it could have, argues author and investor Ruchir Sharma in his new book.

The reason, he cites, is that too often, Indian politicians sell aid to select businesses or industries as economic reform, when the measures in fact retard competition and growth.

"Pro-business is not the same as pro-capitalism, and the distinction continues to elude us," he adds.

In the book "What Went Wrong With Capitalism", published in the UK and distributed in India by Penguin, Sharma shows how completely the reflexes of government have changed, from hands off to hands on, from offering too little relief in hard times to trying to prevent


anyone suffering any economic pain. ever.

He says, in particular, constant government support and intervention in financial markets have crippled the competition that would break up concentrations of personal and corporate power. were capitalism allowed to function properly.

If frustrated young generations want to correct the growing ills of capitalism, the first step is to get the diagnosis right, he suggests, adding his book reexamines the causes of those ills, and the possible way out.

Sharma says his father had followed the path of opportunity in India at the time, which steered him into the government and a naval career.

Talking about the India of the early nineties, he says the allure of socialism was fading, and pragmatic technocrats were in the ascendant



"(Manmohan) Singh along League team became the toast of with his Oxbridge and Ivy the Davos crowd, praised for imposing budget discipline, thinning the regulatory thicket known as the 'license raj', and opening India to the world," he writes.

Comparing India and China, he says in 1990, the two had similar average incomes: since then, China's has risen fortyfold to USD 12,500, while India's rose just sevenfold to USD 2,400.

"To this day the standard Indian excuse is that the world's largest democracy can't force march development the way Communist China once did. But democracy is not the problem; many democracies have grown much richer than India. It is India's lingering attachment to a state that overpromises and under-delivers," he argues.

According to Sharma, even Congress's successors in the BJP are "steeped in the same ideals".

When Narendra Modi campaigned in 2014 promising "min-

imum government, maximum governance", he criticised Congress for "welfarism" and said the poor want "work not handouts", the book says.

"Then Modi took power and, rather than restrain Congress's welfare programs, he topped them, offering every Indian family a 'pucca' (concrete) home with gas and electricity," it says. Sharma says India's critical mistakes included doing too little to expand economic freedom, and too much to build a welfare

state, too soon. "The government didn't spend more heavily than its Asian rivals, but it did spend less wisely, having introduced free social programs at a much earlier stage of development, before building the

roads and schools that could generate incomes high enough to pay for those programs," he writes. "The imperious Indian state was quick to regulate, officiate, and pick winners, overconfident that its priorities were correct. Though Modi has in recent years tried to restrain welfare overspending, the central government remains notorious for its questionable choices, leaving critical services underfunded and understaffed," he alleges.

Too often, Indian politicians sell aid to select businesses or industries as economic reform, when the measures in fact retard competition and growth, he says.

"The result: despite all of India's inherent strengths, from a strong entrepreneurial culture to world-class human capital, it will take longer to become a developed nation than it could have, Sharma writes.

"In pursuit of the unreachable socialist ideal - equality of outcomes - India long denied itself the very real promise of capitalism: equality of opportunity," he adds. (PTI)

"The high court failed to appreciate the ramification of cancelling the entire selection process leading to straightaway termination of teaching and non-teaching staff from service with immediate effect, without giving sufficient time to the petitioner state to deal with such an exigency, rendering the education system at a stand-still," the plea said.

The Calcutta High Court had on Monday declared the selection process as "null and void" and directed the CBI to probe the appointment process. It had also asked the central agency to submit a report within three months.

The high court said those appointed outside the officially available 24,640 vacancies, appointed after the expiry of the official date of

recruitment, and those who submitted blank Optical Mark Recognition (OMR) sheets but obtained appointment to return all remunerations and benefits received by them with 12 per cent interest per annum within four weeks.

Observing that it has given "anxious consideration to the passionate plea" that persons who had obtained the appointments legally would be prejudiced if the entire selection process is cancelled, the bench said it hardly had any choice left.

The high court held that all appointments involved were violative of Articles 14 (equality before law) and 16 (prohibiting discrimination in employment in any government office) of the Constitution. "It is shocking that, at the level of

the cabinet of the State Government, a decision is taken to protect employment obtained fraudulently in a selection process conducted by SSC for state-funded schools, knowing

fully well that, such appointments were obtained beyond the panel and after expiry of the panel, at the bare minimum," the high court had said.

It said unless "there is a deep connection between the persons perpetuating the fraud and the beneficiaries" with persons involved in the decision-making process, such action to create supernumerary posts to protect illegal appointments is "inconceivable'

The division bench had also rejected a prayer by some appellants, including the West Bengal School Service Commission (SSC), for a stay on the order and asked the commission to initiate a fresh appointment process within a fortnight from the date of the results of the ongoing Lok Sabha elections.

The bench, constituted by the Chief Justice of the high court on a direction of the Supreme Court, had heard 350 petitions and appeals relating to the selection of candidates for appointment by the SSC in the categories of teachers of classes 9, 10, 11 and 12 and group-C and D staffers through the SLST-2016.

In its 282-page judgment, the high court had said retaining appointees selected through "such a dubious process" would be contrary to public interest. (*PTI*)

Stray dogs: Not shying away from dealing with issue, says SC

NEW DELHI, April 24: The Supreme Court on Wednesday said it was not shying away from dealing with the issue relating to orders passed by various civic bodies regarding stray dogs, especially in Kerala and Mumbai, but it will not allow the scope of the matter under consideration to be expanded.

The apex court observed that the parties before it should go through the Animal Birth Control Rules, 2023 as many of the issues raised before it may get resolved.

"Let us also clarify one thing. We are not shying away from dealing with the issue but we will not allow the scope to be expanded." a bench of justices J K Maheshwari and Sanjay Karol said. The bench observed that the 2023 rules are

now in place and should be studied.

One of the lawyers said the bench may give them some time to go through the 2023 rules and they will get back to the court.

"Kindly see, that is the crux of the matter," the bench said.

Another lawyer referred to a recent advisory issued by the Animal Welfare Board of India (AWBI) for the implementation of the 2023 rules and said, "If we all go through it, I can say 90 per cent problem will be resolved".

"You please kindly go through 2023 rules and the advisory," the bench said.

ECIL, BEL refuse to disclose names of manufacturers of EVM, VVPAT components under RTI 18 Naxalites surrender

NEW DELHI, April 24: Electronics Corporation of India Ltd and Bharat Electronics Ltd have refused to disclose the names and contact details of the manufacturers and suppliers of various components of EVMs and VVPATs under the RTI Act citing "commercial confidence", according to RTI responses from the PSUs to an activist.

Activist Venkatesh Nayak had filed two identical Right To Information applications with the ECIL and BEL, seeking the details of the manufacturers and suppliers of various components used in the assembling of the electronic voting machines (EVMs) and voter-verifiable paper audit trail (VVPATs).

The VVPAT is an independent vote verification system which enables electors to see whether their votes have been cast correctly

The ECIL and the BEL, public sector

undertakings under the Ministry of Defence, manufacture EVMs and VVPATs for the Election Commission. Navak also sought a copy of the purchase orders for the components from both PSUs.

"Information sought is in commercial confidence. Hence details cannot be provided under Section 8(1)(d) of the RTI Act," BEL said in its response.

A similar response was sent by ECIL which said the details requested are related to a product which is being manufactured by ECIL, and third party in nature.

"Disclosing of details will affect the Competitive position of ECIL. Hence, Exemption is claimed under section 8(1) (d) of RTI ACT, 2005," it said.

In response to the purchase order copies, ECIL's central public information officer said the information is "voluminous" which would disproportionately divert the

Section 8(1)(d) of the RTI Act exempts from disclosure the information, including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information. Section 7(9) of the Act says the information shall ordinarily be provided in the form in which it is sought unless it would disproportionately divert the resources of the public authority or would be detrimental to the safety or preservation of the

record in question. "I don't know whose interests they are trying to protect against the right to know of close to a billion-strong electorate. ECIL said that disclosure of the purchase orders will reveal the design details of the components and this may pose a danger to the machines produced. ECIL did not upload even a signed copy of its reply on the RTI Online Portal," Navak said

He said it is reasonable to infer that the two companies are not manufacturing every single item of the EVM-VVPAT combo or else the two companies would have replied that they are manufacturing all these components internally without any outsourcing being involved.

"But the electorate is expected to take everything about the voting machines based on what the ECI is claiming in its manuals and FAQs," Nayak said. (PTI)

The three women are identified as Sambati Oyam (23) who was working as a deputy commander of HPMP, Gangi Madkam (28), the vice president of Kakadi Panchayat Krantikari Mahila Adivasi Sangthan (KAMS) of the banned CPI (Maoist), and Hungi Oyam (20), a member of Hurrepal Panchayat.

"The 18 Naxals laid down arms in front of police and CRPF officials. They were part of Bhairamgarh, and Malanger area committees of the Maoists in south Bastar," Rai said.

He said the Naxals surrendered themselves as they were impressed by the police's rehabilitation drive Lon Varratu' and disappointed with the hollow Maoist ideology.

"These cadres were tasked with digging roads, felling trees to block roads and putting up posters and banners during shutdowns called by Naxalites. They will be provided facilities as per the government's surrender and rehabilitation policy," the SP added. (PTI)

Unequal rebound in infra investment post-Covid, developing nations lagging: PK Mishra

NEW DELHI, April 24: Investment in infrastructure suffered setbacks during the Covid-19 pandemic years, and the recent rebound has been highly unequal, with developing countries falling behind, P K Mishra, the principal secretary to the prime minister, said on Wednesday. Addressing the inaugural session of the sixth International Conference on Disaster Resilient Infrastructure here, Mishra said disaster and climate risks are increasing and countries will be forced to divert more funding to recovery and rebuilding if

they do not build resilience in the infrastructure systems. "During the pandemic years, in-

vestment in infrastructure suffered setbacks, and lately, we observe sustained revival. However, this rebound is highly unequal, with developing countries lagging. We must ask ourselves why?" he said.

Mishra said research by Coalition for Disaster Resilient Infrastructure (CDRI) has shown that the annual investment required to address the infrastructure deficit, achieve the Sustainable Development Goals (SDGs), reach net zero and strengthen resilience by 2050

amounts to USD 9.2 trillion. "If we do not design resilience into our project pipelines, it will be increasingly difficult to achieve the high levels of funding needed to close the infrastructure deficit, particularly in the global south," he said.

Mishra said the prime minister has given a clarion call to make India a developed country, and many other countries in the global south are also aiming at becoming developed countries or developing faster.

"In all these cases, a lot of infrastructure is going to be built. Therefore, ensuring disaster and climate resilience of infrastructure systems, particularly in the context of uncertainties posed by a changing climate, is a shared global challenge," he said

Mishra said India recognises that closing the infrastructure deficit and doing so in a manner that all new infrastructure is resilient go hand in hand. He said the investment made in infrastructure in the country over the past two decades has created better livelihood opportunities for millions of citizens, and this progress needs to be sustained. (PTI)

NEW DELHI, April 24: The Indian Railways is unable to assess the completion date of the country's first bullet train project because all work tenders have not been awarded yet.

The National High Speed Rail Corporation Limited (NHSRCL), which is constructing the 508 km long corridor, said this in response to an application under the Right to Information Act. Madhya Pradesh-based Chandra

Shekhar Gaur sought to know if the NHSRCL is in a position to give a final date for the completion of the whole project though an application under the RTI.

Responding to the same, the NHSRCL said, "Completion date for Mumbai-Ahmedabad High Speed Rail Project (MAHSRP) can be assessed after award of all tenders/packages.'

The project was launched in 2017 and initially it was scheduled to be ready by December 2023 but land acquisition issues as well as Covid delayed its progress significantly

Sonali Bendre says she almost 'packed bags and left' films before 'Humma Humma' became a hit

MUMBAI, April 24: Actor Sonali Bendre says she had decided to pack her bags and leave the film industry if she was unable to do a good performance in the song "Humma Humma" from Mani Ratnam's 1995 movie "Bombav"

Bendre, who was barely five films old in the industry, said she was often "slammed" by choreographers for her moves until she got a breakthrough for her stint as the female dancer in the superhit track "Humma Humma" alongside Prabhu Deva's brother Raju Sundaram. According to the actor, it was a common perception at the time that one couldn't become a heroine if they didn't know how to dance. The 49-year-old said she wanted to give dancing a shot as the song was choreographed by the legendary Prabhu Deva. "I'm not a trained dancer. When I got into movies, I really got slammed by dance directors for my dancing. 'Badi heroine banne chali hai, dancing nahi aata'. So, if you couldn't dance, you couldn't be a heroine. I was going through all of that so whatever time I would get before and after the shoot, I started to train in 'Bollywood dancing', as it's called. "This was more like, 'Let's do this'. This is with Prabhu Deva because if I can do it. I have a right to be here and if I can't do it, pack your bags and leave. At that point of time, it was like, '(At least) My team would earn their per-day (money)" Bendre told PTI in an interview here. The actor, who later went on to feature in '90s hits such as "Diljale", "Major Saab", "Sarfarosh", "Zakhm" and "Hum Saath Saath Hain", said Prabhu Deva's father and choreographer master Mugur Sundar was so impressed by her skills that he gave her a reward of Rs 100.

'The best part was I was dancing with Prabhu Deva's brother Raju and Sundar master ji, their father was (also) on the set. Mani Ratnam sir always did huge long shots, so

we did everything in one go. After we did one of the things (shots), Sundar master ji took out 100 bucks and gave it to me and said, 'You did so well'. I was like, 'I don't need a certificate from anybody else, I'm here'." Bendre said she was not even part of the main cast of "Bombay", which was led by Arvind Swamy and Manisha Koirala, and yet "Humma Humma" is remembered as her song. "It had the actors who were fantastic, they had once-in-a lifetime kind of roles, and those actors were part of the song. Today, when I look back, I feel that I had to be stupid and or really ignorant to do a song like this. This turned into something and became what it became. It's not my film song ... and today, it's my song," she added.

The actor is set to reprise her role of Amina Qureshi, editor of Awaz Bharti news channel, in the upcoming second sea

son of ZEE5 series "The Broken News". With new voices coming in, she hopes she is offered more age-appropriate" roles.

"Putting it out in the universe," she added. In cinema, female

actors have to still battle patriarchy in terms of work opportunities and Bendre said change is happening but slowly.

"It's a patriarchal society and that's the reality of life and that's the way it works. I'm happy that things are chang ing slowly

but they are changing from where I've seen it come from.

"Conversations have started. I hope I can do my bit in seeing that this conversation doesn't stop and it just grows. But to expect a 360-degree turn is not realistic and I am a realistic person," she said.

The actor, whose big-screen outing was 2013's "Once Upon a Time in Mumbaai Dobaara", said she has stayed away from films as she didn't want to be stereotyped in glamorous roles.

"It's great to have an image and that brands you and it always puts you out there and you get work. You work hard to make that but there comes a point where that image starts becoming like an anchor and starts pulling you down. No regrets about the image I had, but I had grown (out of it)." Bendre, who is married to producer Goldie

Behl, took a break from work after the birth of her son in 2005 and later appeared as a judge on reality TV shows like "India's Got Talent", "India's Best Dramebaaz" and television series "Ajeeb Daastaan Hai Ye". She went on a seven-year hiatus when she was diagnosed with cancer in 2018 and returned to acting with the first season of "The Broken News", which premiered in 2022. The second chapter of the newsroom drama will premiere on May 3. "I felt that 'The Broken News' was the character where I played my age and the moment you play a woman of my age,

NEW DELHI, April 24: Indian-American star Sendhil Ramamurthy says he loved working with Vidya Balan in "Do Aur Do Pyaar" and hopes the film brings many more opportunities from Bollywood, an industry he stayed away from for over a decade due familial responsibilities.

Impact player rule: Entertaining cricket but takes all-rounders out of game, LSG consultant Voges

CHENNAI, April 24: Joining the raging debate around Impact Players in the IPL, Lucknow Super Giants consultant Adam Voges said he prefers something like the 'Power Surge' rule in the Australian Big Bash League where the batting team gets to decide a twoover phase of fielding restrictions.

The Impact Player substitution rule, introduced last season, has been a heavy topic of debate this season with lot of players, including India captain Rohit Sharma calling it detrimental to the growth of all-rounders.

Voges agreed and said while the rule makes for entertaining cricket, it hurts all-rounders.

'The scores have been going up, and the teams have got genuine batters coming in at number seven or eight, while the batters have gone hard right from the start," the Australian said after the six-wicket win over Chennai Super Kings here on Tuesday night. "Certainly makes for entertaining cricket, but it takes the all-rounders out of the game for a little bit and their effectiveness. The all-rounder always balances the side and perhaps it is

not as important with the Impact Sub," he explained. Asked if the rule is comparable to Power Surge in Australia's Big Bash League, Voges said the latter adds to the contest, and he is a fan of it. Unlike the IPL, which has a six-over power play at the start of the innings, the BBL features a this clash. four-over power play.

Power Surge is then a two-over phase of only two fielders outside the circle, sought by the batting team at any point following the 11th over of its innings. "I like the Power Surge back at

home. It just adds another element to the game. "While chasing, you never feel

like you are out of the game. But we have also seen multiple wickets fall during that period," he said. Marcus Stoinis' unbeaten 124 ensured that Lucknow Super Giants pulled off a double over defending champion Chennai Super Kings in the ongoing edition. Stonis, who has been promising with the bat, was promoted to number three in

The trio of reigning U-18 and senior champion Aditi Swami, Games gold-medallist Asian Jyothi Surekha Vennam and Parneet Kaur dropped just 10 points through the two matches to confirm their superiority.

The Indian men's team created a major upset defeating Korea by just two points at 235-233. Tied at even after two ends, the Indians grabbed a point after the third and

However, neither Theegala nor Bhatia have a possibility of making an Olympic appearance since the top 15 in the world rankings have as many as eight Americans. In 11 starts, Theegala has been a runner-up at the season-opener the Sentry and at the RBC Heritage and was fifth at WM Phoenix Open and tied-sixth at the Arnold Palmer Invitational.



Bhatia, in his 12 starts, has won once at the Texas Open and been in top 20 as many as six times. He also missed cut four times.

The top four Americans are Scottie Scheffler (1), Wyndham Clark (3), defending Olympic champion Xander Schauffele (5) and Patrick Cantlay (8). Two other Americans, Max Homa (9) and Brian Haran (10), are also ahead of Theegala, who is the seventh best American in the world rankings. While only four players can be entered for the Olympic Games, provided they in world's top 15, only US has four or more in the list. All other countries can send a maximum of two players provided both are in top 60 of the Olympic qualifiers.

Meanwhile, in the women's section, Aditi, despite a modest 2024 so far, stays on in top 50.

Diksha, who has been solid form, has been in top 10 thrice in five starts on the Ladies European Tour, and also been tied-26 or better in her two starts on the Epson Tour. (PTI)

Having breached the 250-run mark thrice in this IPL edition itself, Sunrisers Hyderabad are pushing the boundaries of T20 batting with their no holds barred approach.

While Mumbai Indians were the first victim of SRH's new-found batting strength this season, RCB bore the maximum brunt when the Travis Head-led batting line-up powered the 2016 winners to IPL's highestever total of 287/3 in Bengaluru

If this was not enough, SRH's carnage against Delhi Capitals - which included a record 125/0 being scored in the powerplay - brought forth the possibility of the 300run mark being breached for the first time ever in the IPL.

And it won't be surprising if SRH manage to do the unthinkable and that too against a bowling attack as frail as RCB's, whose struggles with in the bowling department could be gauged with the fact that their best bowler, Yash Dayal, is at 24th spot in the overall list with seven wickets.

Placed at the bottom of the pool, RCB have conceded at least 180 in their last five matches. In the last two games, the opponents have raked up totals in excess of 200.



RCB batters have worked hard to make up for their severe shortcomings in bowling, but for such a lopsided squad in terms of balance, the task to produce an all-round performance looks nearly impossible.

To their credit, RCB fought incredibly hard with the bat but were unfortunate to have lost to Kolkata Knight Riders by a mere one run after conceding 222/6. Moreover, a collective batting effort must have pleased the RCB management to a large extent.

Marcus Stoinis eager to play for Australia despite missing CA central contract

Football: Former player Langam Chaoba Devi set to be national women's coach

NEW DELHI, April 24: Former player Langam Chaoba Devi is set to take over as the national women's football coach after the I M Vijayan-led AIFF technical committee recommended her name for the position on Wednesday.

The 51-year-old Devi, who captained the national side in the 1999 Asian Championships in Philippines, has earlier been an assistant coach of the Indian team. The Manipuri has also represented the country in the 1998 Bangkok Asian Games.

"After extensive deliberations, the committee recommended Ms. Langam Chaoba Devi as the head coach of the Indian senior women's national team," the All India Football Federation (AIFF) said in a statement.

Devi is the only female coach from the north-east region to have an AFC 'A' License coaching badge.

CHENNAI, April 24: Chennai Super Kings are not looking for a "quick fix" to their issues in the batting department and head coach Stephen Fleming is ready to give the likes of Daryl Mitchell time to get settled in top-three after their fourth loss in eight games.

CSK have been juggling batters in the top three through the season. On Tuesday against Lucknow Super Giants, Ajinkya Rahane and Ruturaj Gaikwad came to open while Mitchell was promoted to number three from five.

In the previous game, Gaikwad pushed himself down to number three to accommodate Rahane and Rachin Ravindra.

Following their dramatic loss to LSG at home, Fleming said they need to get their batting combinations right.

"It's a mixture of trying to find that (combination) and also form. We're a little bit uncomfortable with some areas, so we're trying to find not a quick fix, but the right combination where players are going to contribute for the back end of this tournament," said Fleming after first loss of the season at home. Mitchell, who was bought for Rs 14 crore at the auction, has totalled 146 runs

in seven innings. Fleming insisted that number three is

the ideal spot for the fellow New Zealander.

"There's a lot of pressure, obviously. Getting up the order is more comfortable for him. Me putting him down the order in the hitting role wasn't his best position.

"So, we've looked to rectify that and get him up the order where he has had his best performances internationally. That might take a little time, but the top three need to contribute the majority of runs.

"Ruturaj did that today, so hopefully, he can continue his form, and the others can pick that up... We're not firing on all cylinders by any means, but we're in each game asking teams to play well to beat us. We just got to get a little bit better," he said referring to skipper's unbeaten hundred in a losing cause.

While Mitchell's promotion did not

yield the desired result, LSG sending Marcus Stoinis to number three proved to be a game changer as he singlehandedly pulled off a memorable win for his team with an unbeaten 124 off 63 balls .

Fleming, who has worked alongside the Aussie all-rounder in the Big Bash League for Melbourne Stars, recalled how impactful he had been at the top, especially as an opener.

"He's got power, but he's also got good batsmanship. For Stars, we got him to open the batting, and he was quite prolific," he remembered.

"Today, we saw the quality of his work. His 50 came up in about mid-20 balls (26), and then he just controlled the innings

"What more could you ask from your top three? They needed someone to answer for what Ruturaj did, and Stoinis did that beautifully."

Though it has been close to four years since the great M S Dhoni retired from international cricket, the unconditional love he gets from his legion of fans remain undiminished.

The World Cup winning captain is batting like the Dhoni of old this season, finding sixes and fours at will. Fleming considers himself among the lucky ones to witness fans' unparalleled admiration for Dhoni across venues.

"It's an experience you like to have in the stadium every time he plays. It's been lucky for me to have this magical experience for 16-17 years.

"The love for him throughout the world is a testimony to the way he has played the game. People talk about MS as a person, but he is also a great player, and he has done some great things for India and Chennai (Super Kings).

"People take time to appreciate it, and we do that every day. We are lucky to have him in our side for so long. So, it's not lost on us, and we enjoy every moment."

The CSK-LSG clash witnessed a huge amount of dew coming and Fleming and his team had anticipated it.

" (Apart from Gaikwad) We saw another great hundred from Marcus Stoinis, and they (GT) answered pretty well. It was a good game of cricket, and we felt we played well given the conditions in the backend, but we did some little things wrong under pressure." (PTI)
