Monetary policy expectations impact stocks more than rate moves: RBI paper

MUMBAI, April 28: Equity markets are impacted more by the expectations of future monetary policy than the policy rate surprises on the day of announcement of the policy by the Reserve Bank, said an analysis.

According to a working paper prepared by RBI officials, the regulatory and development measures which are announced along with the monetary policy too impact the stock markets.

"...equity markets are affected more by the changes in the market's expectations of future monetary policy (path factor) than the policy rate surprise (target factor) which is in agreement with the conventional thinking that equity markets are forward-looking," the paper said.

The volatility in equity markets on the day of policy announcement, it said, "is affected by both target and path factors, as markets digest the policy announcements and traders adjust their portfolios throughout the day".

FIU notifies fresh terror financing reporting alerts for capital markets

NEW DELHI, April 28: A fresh set of 'alert indicators' have been issued by India's financial intelligence unit (FIU) for capital markets, insurance companies, online payment gateway intermediaries and crypto currency service providers for effective checking of suspicious transactions in their channels as part of the anti-money laundering and counter-terrorism financing regime.

These new guidelines have been issued under the provisions of the Prevention of Money Laundering Act (PMLA) during the 2022-23 financial year and published in a recently released report that has been

This is part of the anti-money laundering (AML) and combating the financing of terrorism (CFT) regime followed by the country as part of which financial institutions and intermediaries are mandated to share suspicious transaction reports (STRs) with the FIU which subsequently analyses them and shares them for action with various investigative and intelligence agencies.

FIU proactively engages with the financial sector regulators and reporting entities to understand emerging risks and to undertake immediate mitigating measures, the charter for the federal financial data mining

In the case of capital markets, these supplemental guidelines have led to "a strategic shift in the manner in which FIU received information with respect to securities market transactions," the report said.

These 'alert indicators' will address "emerging risks" in the market infrastructure institutions (MIIs)-- stock exchanges and depositories -- like synchronised and manipulative trade practices, order spoofing, misutilisation of client funds by the stock brokers, suspicious off-market transactions etc.

In light of the growing trading volumes, the role the MIIs becomes "cardinal" in making the AML/CFT architecture more robust, it said.

Though the MIIs have been sending suspicious transaction reports (STRs) to the FIU for years now, the report said there was a lack of alert indicators "specific to them" and this left a lot of scope for improvement in their reporting quality, the report said.

The supplemental guidelines have specified clear areas of focus for the MIIs and it is expected that this would lead to a "marked improvement" in the reporting quality and thus will help FIU to generate meaningful intelligence for law enforcement agencies like the Income-tax department, ED, CBI, DRI etc., it said.

The new alert indicators were issued after a working group of agencies like markets regulator SEBI, FIU, stock exchanges and depositories decided to "comprehensively" revise these guidelines and change the system of only stock brokers and deposi-

For stock exchanges, the fresh alert indicators mandate they consider cases where there is suspicion of mis-utilisation of client funds by the stockbrokers such as frauds and also analyse cases where "serious anomalies" from the perspective of money laundering and terrorism financing are observed during the course of inspections and audit of stock brokers, the report said.

In the case of depositories, the new alert indicators for generating STRs require them to deal with identification of suspicious off-market transfer, a way of transferring shares directly between two accounts without the involvement of an exchange platform.

A similar working group, that included insurance regulator IRDAI, went into issues related to the insurance sector during 2022-23 fiscal and the revised guidelines laid "special stress" for generating alerts in cases of frauds experienced by the insurance firms and analyse these from the AML/CFT perspective and furnish reports to FIU in suitable cases, the report said.

In the case of online payment gateways, a working group comprising banking regulator RBI, National Payments Corporation of India (NPCI) "extensively" studied the business model of these technology-enabled financial services firms as these "new-age" players pose challenges in respect of transparency of the parties involved in transactions facilitated by them and the relative speed with which such transactions are completed, leading to emergence of AML/CFT risks. The agency also issued alert indicators for virtual digital asset (VDA) or crypto currency service providers ranging from directions to register with the FIU to carrying out "enhanced due diligence to implementation of travel rule.'

The travel rule requires crypto currency service providers to share sender and recipient data with each other during transactions.

In the case of credit rating agencies (CRAs), the new guidelines will ensure timely reporting of STRs by them to FIU and help in identifying serious corporate frauds having AML/CFT implications in the early stages and ensure timely action by law enforcement agencies based on such financial intelligence preventing siphoning of funds by delinquent issuers, it said.

A similar set of alert indicators were issued to debenture trustees and they were directed to call for "periodic reports" from issuers of debentures and take appropriate action in the interest of the debenture holders as soon as any breach of trust deed or law comes to their notice even as the FIU said these violations may have implications from the AML/CFT

The FIU has also shared the new alert indicator guidelines for STR reporting with real estate agents categorised as designated non-financial businesses and professions (DNFBP) under PMLA. (PTI)

NEW DELHI, April 28: Mining conglomerate Vedanta Ltd is likely to see less pressure on cash flows after liability management at the holding company level and is now best placed to ride rising commodity prices, analysts said.

Improved performance in aluminium, power and zinc enabled the company to turn in EBITDA of ₹ 87,600 crore in the January-March quarter, up by 4 per cent quarter-on-quarter. The improved performance was attributable to lower cost of production in aluminium and zinc and higher sales volume, partially offset by softer zinc prices.

Despite marginal delays, Vedanta is set to complete its alumina/aluminium/ international zinc expansion during the current fiscal year (FY25), which will provide visibility around volume growth and cost reduction FY26 onwards. The start of coal mines in FY26 shall further lower its alu-

minium cost of production. In a post earnings note, Nuvama Institutional Equities said management is moving ahead to demerge the businesses by end of current fiscal (April 2024 to March 2025). The vertical split of its businesses into six listed entities can yield Vedanta higher-than-the-current value. "We believe Vedanta is best placed to ride rising commodity prices. Rising commodity prices



the valuation multiple too as debt overhang shall subside significantly," it said. Citi said liability management at the holding company gives confidence around Vedanta India's balance sheet as well.

"With less pressure on cash flows, commodity price resilience, potential sale of the steel/iron ore businesses -- management expects this over the course of two quarters, likely restructuring -- NOC is awaited from the lenders to file with the NCLT for the demerger, Vedanta hopes to complete the process by calendar year 2024, our dividend yield estimate of 10 per cent-plus -- we reiterate Buy (on company shares)," it said.

NEW DELHI, April 28: Adani-ConneX, a joint venture equally owned by Adani Enterprises and EdgeConneX that is building data centres, secured India's largest sustainability-linked financing arrangement, raising up to USD 1.44 billion (around Rs 11,520 crore), the company said on Sun-

Adani Enterprises Ltd, the flagship of billionaire Gautam Adanirun conglomerate, is investing around USD 1.5 billion on its fledgling data centre business in the next three years. Its joint venture with EdgeConnex plans to build nine data centres with a total capacity of 1 gigawatt by 2030 to provide infrastructure for the booming digital services demand.

In a statement, the firm said the "financing has an initial commitment of USD 875 million, with an accordion feature to extend commitment up to USD 1.44 billion."

"The transaction elevates AdaniConneX's construction financing pool to USD 1.65 billion, building on the maiden construction facility of USD 213 million executed in June 2023," it said.

AdaniConnex, which has only one operational data centre in Chennai so far, has completed almost two-thirds of the construction in the Noida and Hyderabad facil-

Banks may have to slow down loan growth in FY25: **S&P** Global Ratings

NEW DELHI, April 28: Indian banks' credit growth, profitability and asset quality would remain robust in current fiscal reflecting strong economic growth, but they may be compelled to slow down their loan growth as deposits are not growing at a similar pace, S&P Global Ratings has said.

In the Asia-Pacific 2Q 2024 Banking Update, S&P Global Ratings Director SSEA Nikita Anand said the agency expects the sector's strong credit growth to moderate to 14 per cent in FY25, from 16 per cent in FY24, if deposit growth, especially retail deposits, remain tepid. Anand said there is a deterioration in loan-to-deposit ratio is every bank, with loan growth being 2-3 percentage points higher than deposit growth.

We expect banks to bring down their loan growth in FY25 and bring it in line with deposit growth. If banks do not do that, they would be paying higher to get wholesale funding, which will impact profitability," she said at a recent webinar of S&P Global Ratings. Generally, loan growth has been led by private sector banks which see around 17-18 per cent growth, public sector banks on the other hand see loan growth in the range of 12-14 per cent.

Anand said Indian banks can support loan growth of as high as 15-20 per cent over three years without need for raising capital. The loan growth is 2-3 percentage points higher than deposit growth of the banking sector.

"For India, we expect credit growth, profitability and asset quality to remain robust reflecting strong economic growth. Loan growth is 1.5 times of nominal GDP growth, while deposit growth is in line with nominal GDP growth. "Loan growth should come in line with deposits rather than outpacing deposits. If credit growth doesn't slow, banks will have to fund it from wholesale funding and higher cost of such funding could further strain margins and hurt profitability," Anand said. (PTI)

Corporate earnings, Fed interest rate decision to drive markets: Analysts

NEW DELHI, April 28: Quarterly earnings from corporates, the US Fed interest rate decision and other global trends will be the major driving factors for determining movement in the domestic equity market in a holiday-shortened week ahead, analysts said.

Besides, factors like trading activity of foreign investors, global oil benchmark Brent crude and rupee-dollar trend would also influence trading. Domestic equity markets would remain closed on Wednesday on account of Maharashtra Day.

"Domestically, the next batch of Q4 earnings reports will drive stock-specific movements," said Santosh Meena, Head of Research, Swastika Investmart Ltd. Monthly auto sales figures will be announced at the beginning of May, and the next phase of voting will be significant, he said. "On the global front, the outcome of the US Federal Open Market Committee (FOMC) meeting on May 1st will be important. Economic data releases from China and the US, along with movement in the global currency market, will also be the factors to consider," Meena added.

Major corporate earnings announcements this week are from Tata Chemicals. Central Bank of India, IOC, Adani Power, Adani Enterprises, Adani Green Energy, MRF and Titan. (PTI)

Ballasting was done in the affected portion by removing sleepers and rails. Then packing of ballast was done by using track machine to improve the stability. Senior officials at the site continued monitoring of the restoration works. SC's EVM verdict

The recent Supreme Court ruling dismissing petitions advocating for 100% verification of VVPAT slips has stirred both anticipation and concern within the political landscape of India. Justices Sanjiv Khanna and Dipankar Datta's resolute affirmation of the Electronic Voting Machine (EVM) system as a cornerstone of the electoral process has drawn contrasting reactions. While some view it as a triumph of democracy, others question the potential implications for the legitimacy of election outcomes. The court's decision to uphold the integrity of the electoral process by trusting the existing protocols and technical aspects governing EVM usage is a definitive stance against indiscriminate suspicion. Yet, it also raises pertinent questions about the avenues available for recourse in case of electoral disputes. The directive allowing for the lodging of complaints within 7 days of result declaration, coupled with the scrutiny of EVMs upon written request, underscores a mechanism for addressing concerns post-election.

However, the envisaged scenario of a deluge of complaints, particularly in the event of a landslide victory such as the hypothetical 370 seats for the BJP, raises valid apprehensions about the potential for logistical and credibility challenges. The prospect of prolonged delays in result declaration and lingering doubts regarding the veracity of electoral outcomes looms large, casting a shadow over the democratic process. Justice Khanna's aversion to blanket suspicion of the poll process and his counterpart's concurrence emphasize the need for a balanced approach to electoral oversight. Yet, the specter of strategic manipulation through the lodging of complaints by losing candidates cannot be discounted. The parity in access to recourse between winning and losing factions underscores the delicate balance between ensuring electoral integrity and avoiding undue disruption to the democratic transition of power. The onus now lies on all stakeholders, including political parties, the Election Commission of India, and the judiciary, to navigate this nuanced terrain with vigilance and prudence. The safeguarding of electoral integrity demands a proactive commitment to transparency, accountability, and fairness, transcending partisan interests for the collective good of democracy.

The delineation of responsibilities, from the storage of Symbol Loading Units to the procedural safeguards for lodging complaints, underscores the meticulous framework underpinning the electoral While the Supreme Court's verdict reaffirms the foundational role of tinuous scrutiny and refinement of electoral mechanisms. Karnataka calculations

Ask party head HD Kumaraswamy, a former Karnataka Chief Minister and the son of ex-Prime Minister HD Devegowda, and he says JDS wants Lok Sabha seats to ensure good governance and Karnataka's share of national resources.

But it has been media practice to keep trotting "JDS fighting for survival" headlines whenever there is assembly or Lok Sabha elections. The BJP and the Congress are not seen fighting for "survival", when every five years, one of the two is sent packing by the Karnataka voter. The Congress and BJP take turns at governing and are declared in fine fettle even after losing elections. The same does not apply to the JDS. But if "survival" is criteria, and alliance a distress signal, then the INDI-Alliance must also be for "political survival" of each and every political party in the INDIA bloc. The Janata Dal Secular has been battling the stigma of "fighting for political survival" for nearly two decades.

Kumaraswamy was asked the question "are you in alliance with the Bharatiya Janata for your party's political survival"? The Janata Dal Secular leader said the BJP and JDS share good vibes and mutual interests; that if it was a "matter of existence" people toeing the line were barking up the wrong tree.

He spoke of "a strategic move based on a long-term vision", which does not sound like "Janata Dal (Secular) is fighting for its political survival". Elon Musk's advisers were not fully sure about Narendra Modi's third term in 2024

lon Musk's choice to delay his meeting with In-dian Prime Minister Narendra Modi has raised questions about the real reason behind Musk's s decision to postpone the visit despite Tesla's commitment to establishing a manufacturing base in the country as a priority

According to industry insiders and analysts, the primary reason for the billionaire's decision to postpone his visit is the ongoing elections in India. Prime Minister Narendra Modi is currently focused on campaigning and unable to unveil any new ecopolicies offering incentives to Tesla for its manufacturing programme in India.

It was anticipated that Musk would reveal details about establishing a manufacturing facility in India following Delhi's recent announcement of reduced import duties on specific electric vehicles. This policy applies to companies willing to invest a minimum of US\$500 million in manufacturing plants within a three-year timeframe.

Just before Musk's highly awaited trip to India, he decided to cancel his visit. Election Commission of India degrades itself to Modi's own commission

The Election Commission has forfeited all claims to be the national guardian of constitutional democracy by soft pedalling on the complaints against alleged hate speech by prime minister Narendra Modi in what the whole country was watching as a litmus test for the independence and integrity of the poll body. As was widely feared in polit-

ical circles, the commission has miserably failed the test by tiptoeing around the issue and sending a faceless notice to Modi's party, sparing the PM himself of any blame. To create a semblance of independence, the commission has sent a similar notice to the Congress party as follow-up action on BJP's complaints against some of Rahul Gandhi's speeches as well. In doing so, however, the commission has degraded itself to Modi's Election Commission from its hallowed role as the Election Commission of India

There have been several in-

stances in the past of the commission sucking up to the powers that be after the government progressively tightened its grip on the constitutional body, including the appointment of chief election commissioner and other commissioners. The government steamrolled all protests that the new law on the appointment would lead to the ruling party's 'yes men' occupying the crucial posts and put in place a mechanism that placed complete control of the commission in the hands of the government. The commission's decision in the latest case involving the PM shows how true these fears were.

Modi's remarks at an election rally in Rajasthan had ignited a fierce debate on hate speech, constitutional norms, and the delicate balance between political power and institutional autonomy. Modi's reference to Muslims as 'infiltrators' sparked outrage and accusations of religious polarization, reverberating across the political landscape. He asserted that the Congress party, during its tenure, had declared

that Muslims held the 'first right' over the country's resources.

The prime minister was undeterred by the criticism and in fact, repeated his charge with greater force in subsequent rallies. Furthermore, he warned that if the Congress returned to power, it would redistribute wealth among those with more children, euphemistically referring to Muslims. The crowd applauded, but critics saw this as a dangerous dog whistle, playing on communal sentiments and perpetuating stereotypes. Obviously, Modi and his party know that he has nothing to fear from the election commission.

Modi's controversial remarks are not isolated incidents. They reflect a broader trend—the progressive erosion of constitutional entities' autonomy. Since the BJP assumed power a decade ago, India's tradition of diversity and secularism has come under attack. Critics argue that religious intolerance has surged, and institutions designed to be bulwarks against majoritarianism have faced unprecedented challenges.

Global life expectancy increased by 6.2 years in the past three decades: Lancet study

n overall increase in expectancy \blacksquare worldwide by 6.2 years was observed by a new study published in The Lancet from 1990 to 2021. This progress is owing to a reduction in deaths from enteric infections, lower respiratory infections, ischemic heart disease, and strokes across the globe. COVID-19, however, was a dampener in many countries.

Enteric illnesses are food and waterborne illnesses, that are bacterial, parasitical, and viral diseases, contributed to the highest reduction in deaths. The category of diseases includes typhoid and diarrhea. A reduction in deaths from these diseases increased life expectancy by 1-1 years during 1990-2021. with the increase more striking in the decade between 1990 and 2000 compared with subsequent decades.

Reduced mortality from enteric infectious diseases, contributed to a substantial gain of 3.1 years in life expectancy in South Asia.

"We already know how to save children from dying from enteric infections including diarrheal diseases, and progress in fighting this disease has been tremendous," Mohsen Naghavi, the Director of Subnational Burden of Disease Estimation at the Institute for Health Metsaid in his statement.

"Now, we need to focus on preventing and treating these diseases, strengthening and expanding immunization programs, and developing brand-new vaccines against E. coli, norovirus, and Shigella," Naghavi, the Naghavi, the

study's lead author, added. The researchers found that the second-largest contributing factor towards increasing life expectancy was the reduction in deaths from lower respiratory infections, leading to 0.9 years of gained life expectancy from 1990 to

Similarly, the researchers noted that a drop in chronic respiratory diseases contributed to an increase of 0.5 years in life expectancy. East Asia had a significant role in this, with improvements in mortality in China.

Life expectancy was highly variable between regions. Southeast Asia, east Asia, and Oceania gained 8.3 years of life expectancy overall, the highest worldwide. This is while simultaneously having the smallest reduction in life expectancy due to COVID-19 at 0.4

"The global community must ensure that the lifesaving tools that have cut deaths from ischemic heart disease, stroke, and other non-communicable diseases in most high-income countries are

The study, however, pointed out that digestive diseases and cirrhosis posed significant threats, with a lack of improvement from 2010 to 2019. Further, diabetes and kidney diseases result in a global loss of 0.1 years in life expectancy. COVID-19 spanner

Across all causes, COVID-19, resulted in a decline of 1.6 years between 2019 and 2021, causing the largest dent on global life expectancy estimates.

"The effect of COVID-19 on life expectancy showed varying degrees of severity, ranging from a large loss of 4.9 years in Andean Latin America to almost no change in East Asia," the paper said.

Most people with heart disease consume excessive amounts of sodium, study finds

any people consume more than the daily recom-Mended amount of sodium, particularly those who most need to reduce their intake for their heart

That's according to a new study, which found that people with cardiovascular disease (CVD) were consuming more than double the recommended 1,500 milligrams (mg) of sodium each day.

The average amount of sodium consumed daily was 3,096 mg, with 89% of the study's participants consuming more than the recommended

The findings are being presented April 6–8 at the American College of Cardiology's Annual Scientific Session. The results have not yet been published in a peer-reviewed

People with heart disease should reduce sodium intake

The American Heart Association (AHA) recommends adults who do not have or are not known to be at risk for heart disease consumes no more than 2,300 mg of sodium per day. This is about the equivalent of a teaspoon of table salt.

The average person with heart disease in the present study exceeded that level by nearly 1,000 mg. The study used data from 3,170 participants in the Center for Disease Control's NHANES study. These sample included males and females older than 20 with a cardiovascular disease diagnosis

Of this group, the majority were 65 or older, were white, and had an education level below high school graduate. Males, who accounted for slightly more than half of subjects (56.4%), were overweight with an average intake of 1,862 calories per

While overconsumption of sodium is often considered a result uals with heart disease. of fewer food choices, the study turns that hypothesis on its head.

The group with the greatest sodium intake were people at the higher end of the income scale and with a college degree or higher.

The study authors suggest that individuals with higher levels of education and income could have been better at reporting their sodium intake, which may have contributed to the surprising results.

What happens to the heart if you consume too much sodium?

The chemical name for table salt is sodium chloride. Sodium is a naturally occurring mineral, which is necessary for human health in small

"Sodium helps to balance the water in your body," explained cardiologist Jayne Morgan, MD, clinical director at the Piedmont Healthcare Corporation in Atlanta, GA. "It even supports the proper functioning of muscles and nerves.' (Dr. Morgan was not involved in the study.)

"There is a saying in medicine, 'Where sodium goes, water fol-lows,'" she told Medical News

"This is why salt increases the blood volume in your bodies. The effect of this is an increase in blood pressure. The increased blood pressure then forces your heart to work harder, which then eventually puts you at risk of heart disease," Dr. Morgan said.

Dr. Morgan noted that excess sodium has long been linked with the hardening and stiffening of the arteries and atherosclerosis.

Does the average person consume too much salt?

A significant body of research has investigated why so many people

"The consistent overconsumption of sodium across the socioeconomic spectrum suggests that factors beyond just access to resources may influence sodium intake," Michelle Routhenstein, registered dietitian

EntirelyNourished.com, told MNT. Routhenstein was not involved in the study.

Routhenstein proposed this could imply "widespread availability and marketing of convenient highsodium processed foods, cultural dietary habits that prioritize salty foods, and limited awareness or education about the health risks associated with excessive sodium consumption.3

"This is a great testament to the pervasiveness of the Western diet and cravings for salt and 'flavor'. It also is a reflection of the ease and availability of sodium in many grocery products, even when buying 'healthy' options.'

Dr. Morgan added that packaging and labeling is not easily understood by the average consumer.

She said the Food & Drug Administration (FDA), for instance, could "create a standard rating system for foods that everyone understands where that food choice is on a band spectrum of health. The consumer then can truly make an informed de-

How to reduce dietary sodium intake

Tracking salt intake is the first step to reducing sodium consumption, but it can be difficult to know how much sodium you're actually consuming.

Many food products use sodium for reasons other than a salt flavorTrusted Source. It may be used in baking, thickening, curing meat, moisture retention, and as a preservative. Many foods high in sodium don't taste salty at all.

"Without actively scrutinizing food labels and being attentive to sodium levels, people may inadvertently consume excessive amounts," Routhenstein said.

"Individuals may not be aware of the sodium content in their meals even before considering the use of a salt shaker," Routhenstein added. "For example, a typical restaurant meal can contain upwards of 2,000 mg or more of sodium, surpassing the recommended intake for individ-

Routhenstein recommended the following tips for reducing sodium intake:

"To consume less dietary sodium, focus on cooking at home using fresh ingredients, choosing lowsodium options, using herbs and spices for flavor, reading labels, and being mindful of hidden sodium in processed foods. When dining out, individuals can make lower sodium, heart-healthier choices by asking for sauces and dressings on the side, opting for grilled or steamed options instead of fried ones, and requesting meals to be prepared without added

"These simple adjustments can significantly contribute to reducing overall sodium intake while [you're] still enjoying delicious meals,' Routhenstein noted.

Dr. Morgan offered four simple principles to keep in mind:

• Choose fresh foods.

• Limit side sauces, including salad dressings: barbecue, soy, teriyaki, ketchup, etc.

• Substitute salt for other herbs and spices when cooking.

• For salt cravings, try fresh fruit, dark chocolate, or almonds instead. Common substitutes for salt

Routhenstein suggested a number of ways to replace salt in food and still retain flavor, such as adding small amounts of lemon or grapefruit juices to recipes. "The tangy taste of citrus fruits

can trick taste buds into perceiving more saltiness than is actually present, allowing dishes to remain flavorful with reduced sodium content," she said. Additionally, Routhenstein advo-

cated for spiciness, incorporating chili peppers or hot sauce to your dishes depending on your taste pref-You could also replace the table-

top salt shaker with a shaker of garlic powder (not garlic salt, which has sodium), oregano, or any other favorite powder.

"Dijon mustard, whole grain mustard, or dry mustard powder can add tanginess and depth to dressings, marinades, and sauces. Incorporating mustard into vinaigrettes, sandwich spreads, or rubs offers a flavorful twist without relying on sodium," Routhenstein suggested. (Courtesy: Medical News Today)

Pituitary gland, which is also known as the master gland has the most important function of producing hormones that regulates the critical organs of the body including thyroid, adrenal glands, ovaries and testes. It is a small pea-size gland located behind the eyes and below the front of the brain. Improper functioning of the gland usually results in excess or under production of hormones that leads to a formation of mass called tumor, which can be benign or

malignant. Such tumors in this gland can create numerous serious medical conditions by interfering with the normal functioning of the endocrine system and pituitary gland. Some tumors produce hormones known as functional tumors. and others can cause the glands to secrete too few or too many hormones. Also if the tumor pressed on the nearby structure, for instance the optic nerve,

can also limit a person's vision. Though the occurrence of tumor is more likely after the age of 50 years, it still can impact at an early age. The survival rates of tumor due to its complicated location also depend on other factors like the patient's age, type and

size of tumor. What causes a pituitary gland

Mostly, pituitary gland tumors are non-invasive therapy available for the non cancerous but the exact causes are unknown. Some of them are hereditary and some are caused by a rare genetic disorder called as multiple endocrine neoplasia type 1.

This disorder can also lead to overactivity or enlargement of 3 different endocrine-related glands, which also includes the pituitary gland. Many researches are still underway to know the exact cause of such uncontrolled growth of certain cells that leads to a pi-

What are the symptoms?

Depending upon the hormonal variations in the body, there can be a variety of symptoms. The most common symptoms include Headaches, vision probtiredness, mood changes, irritability, changes in menstrual cycle in women, impotence, infertility, Inappropriate breast growth or production of breast milk, Cushing's syndrome which is a combination of weight gain, high blood pressure, diabetes, and easy bruising, the enlargement of the extremities or limbs, thickening of the skull and jaw caused by too much growth hormone.

Treatment for Pituitary gland

Diagnosis at an early stage can help the treatment procedure to be totally non-invasive with the use of advances technology called as Cyberknife. Cyberknife which is the most advanced radiation therapy is completely treatment of benign as well as malig-

Highlights of the therapy being ease of access to any complex location without the need to use the surgical knife, precision of the beam with high dose radiation to the tumor location, and the safety. It is a day care procedure without pain and risk, and the patient can get back to daily chores as soon as the session gets over which depends on the tumor (30 minutes to 1 hour) and hence eliminates the requirement of any hospital stay. Moreover the procedure makes use of the most sophisticated image guidance technique to focus high doses of radiation directly to the tumor spot which eliminates the chances to damage the healthy cells as in any other

methods of treatment. This therapy works the best for tumors that are upto 1-3

cm in size (for pituitary tumors, this figure is even smaller) and is a very powerful and effective technique for treating patients suffering from early stage primary and medically inoperable tumors.

The treatment is safe to administer and also offers a new option in patients with recurrent pituitary tumors, those that cannot be operated, or those involving the cavernous sinus (an area difficult to reach and completely remove tumors from, without side ef-

lasts for about 30 -50 min and is cost effective with a success rate of 98% in such complicated tumors. Patients with pituitary adenomas receive stereotactic radio surgery with CyberKnife and are followed up for more than 12 months. After 6 months of therapy patients are monitored for positive responses and ensure there is no recurrence of any

routine the same day.

Typically MRI is doing 6 monthly for the first year, and then yearly for at least 5 years.

Top Qatari official urges Israel and Hamas to do more to reach a cease-fire deal

TEL AVIV, April 28: A senior Qatari official has urged both Israel and Hamas to show "more commitment and more seriousness" in cease-fire negotiations in interviews with Israeli media, as pressure builds on both sides to move toward a deal that would set Israeli hostages free and bring potential respite in the nearly 7-month-long war in Gaza.

The interviews with liberal daily Haaretz and Israeli public broadcaster Kan were published and aired Saturday evening.

They came as Israel still promises to invade Gaza's southernmost city of Rafah despite global concern for hundreds of thousands of Palestinians sheltering there, and as the sides are exchanging proposals surrounding a cease-fire deal.

Qatar, which hosts Hamas headquarters in Doha, has been a key intermediary throughout the Israel-Hamas war. Along with the US and Egypt, Qatar was instrumental in helping negotiate a brief halt to the fighting in November that led to the release of dozens of hostages.

The sides have held numerous rounds of negotiations since, none of which produced an additional truce. In a sign of its frustration, Qatar earlier this month said it was reassessing its role as mediator.

In the interviews, Qatar's Foreign Ministry spokesperson Majed al-Ansari expressed disappointment in both Hamas and Israel, saying each side has made its decisions based on political interests and not



with the good of civilians in mind. "We were hoping to see more commit-

ment and more seriousness on both sides,' he told Haaretz.

He did not reveal details of the current state of the talks, other than to say they have "effectively stopped," with "both sides entrenched in their positions."

"If there is a renewed sense of commitment on both sides, I'm sure we can reach a deal." he said.

The second phase would start after the release of civilian and sick hostages, and would include negotiating the release of soldiers, he added. Senior Palestinian prisoners would be released and a reconstruction process launched.

Hamas meanwhile said Saturday it was reviewing a new Israeli proposal for a cease-fire, which came in response to a Hamas proposal from two weeks ago.

Negotiations earlier this month centred on a six-week cease-fire proposal and the release of 40 civilian and sick hostages held by Hamas in exchange for freeing hundreds of Palestinian prisoners in Israeli jails.

Hamas in recent days has released new videos of three hostages it holds, which appear to be meant to push Israel to make con-

Israel meanwhile has massed dozens of tanks and armored vehicles ahead of an expected offensive in Rafah, where more than half of Gaza's 2.3 million population is seeking shelter. The planned incursion has raised global alarm because of concerns over potential harm to civilians. The troop buildup may also be a pressure tactic on Hamas in the truce talks

Israel sees Rafah as Hamas' last major stronghold and has vowed to attack the militant group there in its bid to destroy its military and governing capabilities.

The war was sparked by Hamas' attack on October 7 into southern Israel, which killed 1,200 people, mostly civilians, according to Israeli authorities, who say another 250 people were taken hostage. Hamas and other groups are holding about 130 people, including the remains of about 30, Israeli authorities say.

Israel's retaliatory assault on Hamas has killed more than 34,000 people, most of them women and children, according to health authorities in Gaza, who do not distinguish between civilians and combatants in their tally. The Israeli military says it has killed at least 12,000 militants, without providing evidence to back the claim. (AP)

Munitions explosion at a Cambodian army base kills 20 soldiers

CHBAR MON (CAMBODIA), April 28: Security was tight around a military base in southwestern Cambodia on Sunday, a day after a huge explosion there killed 20 soldiers, wounded others and damaged nearby houses.

Guards sought to keep media away from the site in Kompong Speu

Hun Manet said in a Facebook post on Saturday that he was "deeply shocked" when he received the news of the blast in the province's Chbar Mon district. It was not immediately clear what caused it.

A villager living nearby told The Associated Press on Sunday that he trembled after hearing the blast because he had never before experienced such a loud explosion.

"When the explosion happened, I was fixing my house with some construction workers," said Chim Sothea. "Suddenly there was a loud explosion. causing my house to shake and breaking tiles on my roof. They fell down but luckily they didn't fall inside the

Images from the scene showed several badly damaged buildings on the base, at least one with its roof blown off, and soldiers receiving treatment in a hospital. Other photos showed nearby houses with holes in their roofs.

Four buildings — three for storage and one work facility - were destroyed and several military vehicles damaged, Col. Youeng Sokhon, an army officer at the site, said in a brief report to army chief Gen. Mao Sophan, posted on social media. He added that 25 villagers' homes were damaged as well. Photos of the base showed the damaged structures in a large field, apparently with no civilian structures

Another villager, who asked to be named only as Sophal, told AP he had heard a sharp sound, and when he saw smoke rising from the direction of the army base, he realized it was an explosion at the arms depot. He then ran back to his house from the small shop where he sells food and drink to shelter inside with his wife and two children.

He said the military immediately closed the road to the base and "villagers were in a panic, seeking a safe place." He then moved his family to his parent's home, farther away from the base. When he returned to his own house hours later, he found it undamaged but other villagers' houses had broken windows, doors and roofs, he

Cambodia, like many countries in the region, has been suffering from an extended heat wave, and the province where the blast took place registered a high of 39 C (102 F) on Saturday. While high temperatures normally can't detonate ammunition, they can degrade the stability of explosives over a period of time, with the risk that a single small explosion can set off a fire and a chain

Kiripost, an online English language news service, quoted villager Phens Kimneang as saying a major explosion occurred at about 2:30 p.m., followed by smaller blasts for about another

In March 2005, a nighttime blast at an arms depot in the northwestern provincial town of Battambang triggered an hourslong spray of shells and bullets, killing at least six people and panicking local residents.

Tornado in China's Guangzhou weaves wide devastation; cleanup efforts initiated

BEIJING, April 28: Aerial photos posted by Chinese state media on Sunday showed the wide devastation of a part of the southern city of Guangzhou after a tornado swept through the day before, killing five people, injuring dozens others and damaging over a hundred buildings.

As businesses and residents began cleaning debris, the images showed block upon block of devastation in the hardest hit areas with a few clusters of buildings standing amid the destruction, a truck overturned on its side and cars crushed by rubble. Some buildings had their sheet metal roofs torn off.

The tornado, which knocked out power in the area, also injured 33 people on Saturday, officials said. Guangzhou is the capital of Guangdong province and a manufacturing hub near Hong Kong. The tornado which struck during an afternoon thunderstorm that also brought hail damaged 141 factory buildings, according to au-

Al-Ansari's remarks came after an Elon Musk in Beijing amid efforts to promote Tesla's autonomous driving tech

BEIJING, April 28: Billionaire Elon Musk arrived in Beijing on Sunday amid speculation that he may unveil Tesla's autonomous driving technology in the burgeoning electric vehicle (EV) market in China. The SpaceX and Tesla chief travelled to China at the invitation of the China Council for the Promotion of International Trade, meeting with CCPIT president Ren Hongbin to discuss further cooperation with the country, according to Chinese state-run broadcaster CTGN. Musk is expected to meet senior Chinese officials at the State Council and "old friends" in Beijing, Hong Kong-based South China Morning Post reported.

His Tesla has become a popular EV in China after he set up a USD seven billion factory in Shanghai which went into production in 2020. Musk, who recently skipped a scheduled visit to India to meet Prime Minister Narendra Modi to firm up plans to open a Tesla factory in the country, is visiting Beijing when his Tesla market in China is threatened by the local EVs increasing sales.

The Austin-based (Texas) Tesla as faced fierce competition from Chinese EV makers in the past few years. It has cut the prices of its Shanghai-made vehicles by up to six per cent to maintain its leading position in China's premium EV

Grace Tao, Tesla's vice-president of external relations in China, wrote a commentary piece in China's official newspaper People's Daily on Friday, saying autonomous driving is a key growth driver for the country's new energy vehicle sector, arguing that the technology will hatch new business models such as robotaxis, a vision that Musk has embraced, the Post reported. Musk's latest visit to China coincides with the 2024 Beijing Auto Show, which kicked off on Thursday.

As a stronger backer of Beijing in the US despite concerns over China's rise across the political divide in Washington, Musk enjoys red carpet treatment in China.

In 2019, Tesla was allowed to drive cars into the Zhongnanhai compound, the living and working area of Chinese leaders, when former Premier Li Keqiang hosted the CEO, and during Musk's three-day visit to Beijing last June he was re-

ceived by then foreign minister Qin Gang, according to the Post re-

The trip was warmly received by the Chinese public, with socialmedia posts focusing on the Chinese food Musk ate, and some referring to him as a "pioneer" and "brother Ma".

Tesla, the leader in China's premium EV segment, delivered 603,664 Model 3s and Model Ys made at its Shanghai Gigafactory to buyers in China last year, an increase of 37.3 per cent over 2022.

The growth rate matched the 37 per cent rise in sales recorded in 2022 when it delivered about 440,000 vehicles.

Tesla has sold more than 1.7 million cars in China since it entered the market in 2012 and located its biggest factory in Shanghai, where Musk enjoys high levels of political support for the project. In a sign of its further commitment to China, Tesla bought a parcel of land in Shanghai to build a factory with a planned annual capacity of 10,000 Tesla Megapack batteries, which are used for battery storage stations. LONDON, April 28: British Prime Minister Rishi Sunak on Sunday refused to categorically rule out a July general election amid a damaging defection by one of his Conservative Party MPs to the Opposition Labour Party, just days before local and mayoral elections in the country on May 2.

Dan Poulter, a doctor and Central Suffolk and North Ipswich member of Parliament said he will switch his allegiance to the Opposition benches before standing down as a parliamentarian at the next election because he can no longer defend the Tory government's track record on the National Health Service (NHS).

Against the backdrop of this latest embarrassment, Sunak was

asked during a 'Sky News' interview that his repeated assertion of a general election in the "second half of this year" could also mean

When it comes to a general election, I've been very clear about that multiple times, and again, I'm not going to say anything more than I've already said, I've been very clear about that," said Sunak, who was then pressed five times to rule out an election during what would be a peak summer month

"You're going to try and draw whatever conclusion you want from what I say. I'm going to always try and say the same thing. You should just listen to what I said, [the] same thing I've said all

From Karachi to Chennai: Pakistani teen's journey for a new heart

28: The heartwarming story of a 19-year-old Pakistani girl getting a new lease on life after a successful heart transplant in India highlights how borders can be eased for humanitarian purposes and the challenges faced by heart patients in the neighbouring country.

Ayesha Rashan from Karachi underwent a heart transplant surgery at MGM Healthcare, Chen-

After a suitable brain-dead donor was available, she underwent cardiac transplantation on January 31, 2024. Following procedures, she was discharged this month

Dr K R Balakrishnan, Chairman, Cardiac Sciences Director, Institute of Heart and Lung Transplant and Mechanical Circulatory Support, said Ayesha first came to them in 2019 when she was 14 years of age with severe heart failure and a very poorly functioning

"She became very sick and had

a cardiac arrest and had to be resuscitated with CPR and put on a machine called ECMO to sustain circulation then we put in an artificial heart pump that time and eventually she recovered and went back to her country," he

"Over the next couple of years, she became sick again because one of her valves started leaking...and she developed severe failure on the right side of the heart and developed an infection and it became very difficult to treat her in that country," he

Balakrishnan said getting a visa for her was very difficult.

"Her mother is a single mother, they had no money or resources. We had to take care of the entire expenses including repeated hospitalisation," Dr Balakrishnan told PTI Videos.

Ayesha underwent surgery with the support of Aishwarya Trust, a Chennai-based NGO, and other transplant patients' contributions.



The transplant was done after getting a donor organ from a brain-dead elderly man from

"The biggest challenge was there was no money," he said. The condition required Rs 30 to Rs 40

"The hospital is a private hos-

pital. And so we had to raise money through the trust, through our own resources and generous patients. So that was a huge challenge. And these are high-risk procedures where the outcomes are not predictable. But we had to do it because otherwise, this young girl would not have sur-

Avesha, who aspires to be a fashion designer, thanked the Indian government for giving her a visa to visit the country for the

Ayesha's mother said the problem is that Pakistan does not have such a facility. Ayesha is not the first Pakistani

to get a heart transplant in India. Muhammad Amir, whose name changed on request, was 37 years old in 2014 when cardiologists in Karachi told him that he was suffering from 'dilated cardiomyopathy', a disease in which chambers of the heart become dilated and muscles get weak, impairing the heart's ability to pump blood ef-

fectively to the rest of the body. "Doctors managed my condition with medication, but they told me a transplant was the only cure," Amir, now 46 told The News International, following reports of Ayesha receiving a suc-

cessful heart transplant in India. "Through online research, I disin Chennai, India, where I received a new heart from an anonymous Indian donor in

Amir isn't alone. Qari Zubair,

an imam from Gujrat, was the first Pakistani to travel to Chennai for a heart transplant. Sadly, he developed complications and did not survive. "According to my knowledge,

around six Pakistanis have undergone heart transplants in India," Amir said, preferring to keep per-

sonal details private. "I'm the longest survivor. Four others passed away after their

transplants," he said. Several transplant and cardiac surgeons cite a lack of expertise, high costs, limited post-operative care, and a shortage of deceased donors as the primary reasons for the absence of a heart transplant

programme in Pakistan. The two main reasons we don't perform heart transplants are the lack of deceased donors

covered a heart transplant centre (transplant hearts can only be taken from deceased individuals) and a lack of expertise," said renowned liver transplant surgeon Dr Faisal Saud Dar.

Dr Dar, dean and CEO of the Pakistan Kidney and Liver Institute and Research Center in Lahore. emphasised importance of raising awareness about organ donation after death to save lives.

IMPHAL, April 28: One person was killed and three others injured in a gunfight between village volunteers of two warring communities in ethnic strife-torn Manipur's Kangpokpi district on Sunday, police said.

Dozens of gunmen had attacked Koutruk in Imphal West district on Sunday morning from elevated hilltops of neighbouring Kangpokpi district prompting village volunteers deployed in the fringe village to retaliate, the police said.

Exchange of fire gradually spread to adjacent villages of Kadangband and Senjam Chirang, they said.

Koutruk village has been witness to intense gunfights between village volunteers of two warring communities since ethnic violence broke out on May 3 last year. It has been identified as one of the most vulnerable

More than 200 people have been killed and thousands rendered homeless in ethnic strife between Imphal Valley-based Meiteis and adjoining hills-based Kukis since May 3 last year.



IMPHAL, April 28: Officers of anti-smuggling unit of Imphal Customs Division arrested a person after smuggled gold worth roughly ₹ 45.35 lakh was recovered from a car he was coming with from Singjamei area of Imphal on Friday, an official source said today.

The officers conducted a check to the Maruti car at Singjamei parking area on Friday around 5.40 pm acting on specific information, said a statement of the Imphal cus-

The officers intercepted the smuggled gold packed in three oval shaped plastic packets concealed underneath the handbrake of the car on thorough checking of the vehicle, it also said.

Upon examination of the packets revealed their contents to be yellow coloured paste suspected to contain gold of foreign origin, the statement added.

The recovered items, the vehicle and the driver were taken to the office of the Customs Division, Imphal for further procedures.

The processing of the yellow paste resulted in recovery of 627.53 gm gold, estimated to be ₹ 45,35,159 as per market rate as on April 26, 2024, it further said. A case has been registered against the arrested person under

mittee on Tribal Unity (COTU) has called for a 12-hour total shutdown in Manipur's Kangpokpi district following the death of a Kuki community member.

Reports indicate that one person from the Kuki community was killed and three others injured in a clash with Meitei groups at Bethel village in the Koubru mountain range. The deceased, identified as Pu Lammang Kipgen, was a village volunteer according to COTU.

In a statement, COTU blamed 'unprovoked attacks by secessionist Meitei terrorists and the Arambai Tenggol with tactical and logistical support from the State Police" for the death. They have called for a 12hour shutdown "as a mark of respect" for the deceased.

"The Committee on Tribal Unity calls for 12 Hours Total Shutdown in the entire Sadar Hills Kangpokpi for the unprovoked attack at Kangchup Bethel Area by the secessionist Meitei Terrorist and the Arambai Tenggol along with the tactical and logistical support of the State Police which has resulted in the death of one of our Kuki-Zo Village Volunteer," said COTU in the statement. COTU will also be holding a ceremony at the Martyr Cemetery at Phaijang at 1 pm on Sunday.

Nagaland decides to take strict action extortion, abduction

This amidst the ongoing indefinite shutter down across the state called the Confederation of Nagaland Chamber of Commerce and Industry and the Dimapur Chamber of Commerce and Industry against the illegal and rampant taxes imposed upon the business community, particularly in Dimapur, by various Naga national political groups.

The shutter down entered the third day today. Taking serious note, the state cabinet discussed of

the issue and conveyed its decision to the DGP and commissioner.

Further, the cabinet also directed the DGP to send additional forces immediately to Dimapur to curb such

illegal activities. It was also decided by the cabinet to provide additional required resources to the law enforcing agencies for increased mobility and for operationalising/increasing of CCTVs.

The state police department, in this connection, said all the Naga national political groups may be advised about the complete and absolute adherence to cease-

fire ground rules and to confine their cadres to their designated camps and supervisory offices in letter and in spirit. The supervisory offices/cells may be discontinued from being used to summon civilians/businessman to their office for criminal intimidation, extortion, ransom besides other crimes, it said.

The unauthorised and illegal activities undertaken by the Naga national political groups under the garb of ceasefire with the government of India and violation of ceasefire ground rules have created unrest among the public and business community in the state, a communiqué by the state police stated. It further requested the chairman of CFMG/CFSB to advice the groups to adhere to laid down ceasefire ground rules, and not to vitiate the law

Delhi Cong chief Arvinder Singh Lovely resigns, says party unit was against alliance with AAP

back to the Congress ahead of the Lok Sabha polls, senior leader Arvinder Singh Lovely has resigned as the party's Delhi unit chief, citing the alliance with the AAP as one of the reasons.

He said the Delhi Congress unit was against the alliance but the party high command went ahead with it.

In his resignation letter sent to Congress president Mallikarjun Kharge on Saturday, Lovely also said that he found himself "handicapped" as all unanimous decisions taken by senior Delhi unit leaders have been "unilaterally vetoed" by AICC Delhi in-charge Deepak Babria

This comes days after former Delhi minister and AICC member Rajkumar Chauhan resigned from the party following an altercation with Babria.

Reacting to the development, the Delhi BJP on Sunday said this "explosion" was set in motion when the Congress started naming candidates for the Lok Sabha elections, while the AAP said this is an internal matter of the Congress.

In his letter to Kharge, Lovely said. "It is with a heavy heart that I write the present letter to you finding myself handicapped and un-

the Delhi party unit." "I had gratefully accepted the role as the DPCC President with the sole objective of supporting the local Congress party workers with whom I have an extremely close connection and life-long associa-

"However, since I cannot protect the interests of the party workers, I see no reason to continue in the said post. Therefore, with great regret and an extremely leaden heart, I, Arvinder Singh Lovely, do hereby tender my resignation from the post of DPCC President," he

A minister in the Sheila Dikshit government, Lovely was appointed as the Delhi Congress chief in August last vear.

Lovely said even though the Delhi Congress unit was against the alliance with the AAP, he publicly backed it and made sure that the entire unit "fell in line with the high command's final order".

He said that he even withdrew his name as a potential candidate for the Lok Sabha polls in the interest of the party and so that other senior leaders could get tickets.

"The Delhi Congress unit was against an alliance with a party which was formed on the sole basis

of levelling false, fabricated and malafide corruption charges against the Congress party... half of the cabinet ministers (of the party) are presently in jail on corruption

"Despite that, the party (Congress) made a decision to ally with the AAP in Delhi. We respected the party's final decision... I even went to the extent of visiting Mr Kejriwal's residence on the night of his arrest along with Mr Subash Chopra and Mr Sandeep Dikshit, despite the same being against my position on the matter," he said.

Lovely also criticised Congress North East Delhi candidate Kanhaiya Kumar for heaping praise on Delhi Chief Minister Arvind Kejriwal, who is behind bars in a money laundering case.

"The candidate from North East Delhi has also been giving media bytes falsely praising the Delhi CM, in direct contravention of the party line and the local party work-"In direct contradiction to the

true factual position and the misery of Delhi Citizens, he endorsed the false propaganda of AAP in regard

them in education, health, road and electricity sectors," he said.

"Such ill-thought and factually incorrect statements have not gone down well" with the Delhi Congress unit since "the local party workers had an inherent understanding that the alliance was not done in appreciation of AAP's false propaganda of the development of Delhi," he said.

In fact, he added, the alliance was a "compromise" to improve the chances of victory of the Congress in the Lok Sabha polls.

"Shahzada spoke ill about Raja, Maharajas, but the shahzada's mouth was locked regarding the 'atyachar' that Nawabs, Nizams, Sultans and Badshahs committed in India's history. His mouth was shut on them, but on Raia, Maharajas he speaks ill and insults them," he said.

Noting that Gandhi cannot remember Mughal emperor Aurangzeb's oppressions, Modi said, "he (Aurangzeb) impured a number of our temples and destroyed them. Congress is happily making alliances with parties that praise Aurangzeb...they don't remember people who destroyed our religious places, indulged in killing, killing of cows. They don't remember the Nawab, who played a role in the partition of India.'

He further recalled the contributions of the Raja of Banaras in setting up Banaras Hindu University, and Maharani Ahilyabai Holkar in the reconstruction of temples.

"It was the Maharaja of Baroda who had identified the talent of Ambedkar...the Congress's shehzade doesn't remember the contributions of Rajas and Maharajas. For vote bank they show the guts of speaking against Rajas and Maharajas, but don't have strength to speak against Nawabs, sultans and Badshahs," he said adding that Congress' "appeasement mindset" has come out in the open before the country, and the same reflects in their manifesto.

Veteran BJP leader B S Yediyurappa, party's candidate from Belgaum (Belagavi) and former Chief Minister Jagadish Shettar and Chikkodi candidate Annasaheb Shankar Jolle, were among those

In the first phase of the elections on April 19, there total number of candidates in the fray was 1,625. In the second phase held on April 26, 1,198 candidates contested the elections. Of the 135 women candidates in the first phase, Tamil Nadu had

the highest share at 76. However, that figure accounted for just 8 per cent of the total candidates in the state. Kerala had the maximum number of women candidates at 24 in the second phase.

Partywise, the Congress fielded 44 women in the two phases and the BJP 69. This significant gender imbalance has sparked criticism from political analysts and activists, who asked why parties are waiting for the Women Reservation Act to be implemented instead of proactively fielding women.

Dr Sushila Ramaswamy, an associate professor at Delhi University's Jesus and Mary College, said political parties should take concrete steps to promote women's candidacy. "Political parties should have been more proactive and fielded more women candidates," she underscored, citing the effectiveness of seat reservations for women within party structures, as seen in the UK's Labour Party.

With women constituting nearly half of India's electorate, their under representation in the candidate pool raises broader questions about the barriers hindering women's full participation in the political sphere, said Dr Iftekhar Ahmad Ansari, an associate professor at the Aligarh

Muslim University (AMU).

Beyond the symbolic gestures and promises, he stressed the importance of structural reforms to ensure equal opportunities for women in politics.

He also highlighted the critical role of party leadership in promoting gender diversity.

"Political parties must prioritise gender inclusion in candidate selection and provide adequate support to women aspirants," he emphasised. Farhat Jahan, a retired faculty member at AMU's Abdullah Women's College, said the issue of women's political representation extends beyond numerical quotas to encompass systemic changes in party dynamics and electoral processes. She also emphasised the need for gender-sensitive policies that address challenges faced by women in politics.

"The upcoming phases of the elections present an opportunity for political parties to demonstrate their commitment to gender equality through concrete actions. Initiatives such as mentorship programmes, capacity-building workshops and awareness campaigns can empower women to actively participate in the electoral process and pursue leadership roles," she added.

Prof Mohammad Aftab Alam from the political science depart ment at AMU pointed out the challenges women often face in forming independent political opinions amid societal influences. "Even the ones elected are often relegated to symbolic roles," he remarked, highlighting broader issues of token

Singh, who is in Ahmedabad to campaign for BJP candidates contesting the Lok Sabha elections, said India has become a powerful country from a military standpoint and wants to maintain good relations with its neighbours. "India is no longer a weak

India. India has also become a powerful country from a military point of view. We want to maintain good relations with our neighbouring countries," the minister said when asked about Congress leader Rahul Gandhi's accusation against the Narendra Modi government over Chinese aggression.

Talks between India and China are going on smoothly and in a good environment over whatever issues there are, he said.

"I understand that we should wait for the outcome of the talks. But I want to assure the countrymen that India has not bowed down anywhere, nor will it ever bow down," he said.

Singh also expressed confidence that India's defence exports, which crossed the ₹ 21,000 crore mark in the financial 2023-24, will increase going forward.

"In 2014, we exported ₹ 600 crore defence items, but now the figure has crossed ₹21,000 crore, and I can say that it is going to increase," he said.

The minister said the Modi government is committed to ensuring that defence items, whether missiles and other weapons, bombs or tanks, should be made in India and by Indians

KOLKATA, April 28: A Trinamool Congress worker has been killed, while a local BJP leader has been seriously injured in separate incidents in Kolkata, police

TMC worker Sanjeev Das, who was also known as Potla, was killed in Baguiati area allegedly in a clash between two factions of the party, a police officer said. A confrontation took place in Arjunpur West Para in Baguiati on Saturday night, escalating into brick-batting by both sides, in which Das was severely injured and was taken to a hospital, where doctors declared him brought dead, the police officer said. Eleven cases, including those related to the Arms Act, were earlier registered against Das, she said. A total of 13 people have been arrested in connection with the incident, the officer said, adding further investigation is

workers owing allegiance to the local councilor were behind the incident. They claimed that Das was beaten with rods after being injured in brick-batting. Meanwhile, a woman BJP leader, identified as Saraswati Sarkar, lodged a police complaint alleging that she was assaulted by TMC workers in Anandapur area in south

Kolkata on Saturday night. She claimed that she was attacked with sharp weapons when she and her party workers were putting up election banners and festoons, causing severe injuries to her head. She had registered a police complaint in the local police station.

During the campaigning for the 1989 Lok Sabha elections, Madhavrao waged a battle to prevent the Guna seat from going to his mother - senior BJP leader and matriarch of the Gwalior royal family Vijayaraje Scindia.



FIU notifies fresh money laundering, terror financing reporting alerts for capital markets

NEW DELHI, April 28: A fresh set of 'alert indicators' have been issued by India's financial intelligence unit (FIU) for capital markets, insurance companies, online payment gateway intermediaries and crypto currency service providers for effective checking of suspicious transactions in their channels as part of the anti-money laundering and counter-terrorism financing regime.

These new guidelines have been issued under the provisions of the Prevention of Money Laundering Act (PMLA) during the 2022-23 financial year and published in a recently released report that has been accessed by PTI.

This is part of the anti-money laundering (AML) and combating the financing of terrorism (CFT) regime followed by the country as part of which financial institutions and intermediaries are mandated to share suspicious transaction reports (STRs) with the FIU which subsequently analyses them and shares them for action with various investigative and intelligence agencies

FIU proactively engages with the financial sector regulators and reporting entities to understand emerging risks and to undertake immediate mitigating measures, the charter for the federal financial data mining agency says.

In the case of capital markets, these supplemental guidelines



have led to "a strategic shift in the manner in which FIU received information with respect to securities market transactions," the

These 'alert indicators' will address "emerging risks" in the market infrastructure institutions (MIIs)-- stock exchanges and depositories-- like synchronised and manipulative trade practices, order spoofing, mis-utilisation of client funds by the stock brokers, suspicious off-market transactions etc.

In light of the growing trading volumes, the role the MIIs becomes "cardinal" in making the AML/CFT architecture more ro-

Though the MIIs have been sending suspicious transaction reports (STRs) to the FIU for years now, the report said there was a lack of alert indicators "specific to them" and this left a lot of scope for improvement in their reporting

quality, the report said.

The supplemental guidelines have specified clear areas of focus for the MIIs and it is expected that this would lead to a "marked improvement" in the reporting quality and thus will help FIU to generate meaningful intelligence for law enforcement agencies like the Income-tax department, ED, CBI, DRI etc., it said.

A similar working group, that included insurance regulator IRDAI, went into issues related to the insurance sector during 2022-23 fiscal and the revised guidelines laid "special stress" for generating alerts in cases of frauds experienced by the insurance firms and analyse these from the AML/CFT perspective and furnish reports to FIU in suitable cases, the report said.

In the case of online payment gateways, a working group comprising banking regulator RBI, National Payments Corporation of India (NPCI) "extensively" studied the business model of these technology-enabled financial services firms as these "new-age" players pose challenges in respect of transparency of the parties involved in transactions facilitated by them and the relative speed with which such transactions are completed, leading to emergence of AML/CFT risks.

The agency also issued alert in-

dicators for virtual digital asset (VDA) or crypto currency service providers ranging from directions to register with the FIU to carrying out "enhanced due diligence to implementation of travel rule."

The travel rule requires crypto currency service providers to share sender and recipient data with each other during transactions.

In the case of credit rating agencies (CRAs), the new guidelines will ensure timely reporting of STRs by them to FIU and help in identifying serious corporate frauds having AML/CFT implications in the early stages and ensure timely action by law enforcement agencies based on such financial intelligence preventing siphoning of funds by delinquent issuers, it

A similar set of alert indicators were issued to debenture trustees and they were directed to call for "periodic reports" from issuers of debentures and take appropriate action in the interest of the debenture holders as soon as any breach of trust deed or law comes to their notice even as the FIU said these violations may have implications from the AML/CFT perspective.

The FIU has also shared the new alert indicator guidelines for STR reporting with real estate agents categorised as designated non-financial businesses and professions (DNFBP) under PMLA. (PTI)

U'khand forest fires: IAF helicopter assists in firefighting for 2nd day

DEHRADUN, April 28: The firefighting operation in Uttarakhand's forests with the help of an Indian Air Force (IAF) helicopter continued for the second day on Sunday with the blaze brought under control in several areas, officials said.

Efforts have also intensified to extinguish the raging forest fires in the state, especially in the worst-affected areas of Nainital, Haldwani and Ramnagar forest divisions, forest officials here said on Sunday.

The forest fires are gradually being controlled with the flames already doused in many areas. The fires in Marora and Khanana civil areas in Maniknath range of the Narendranagar forest division have been completely extinguished, they said.

The forest blaze in Nainital and adoining areas is gradually being brought under control after the deployment of an IAF helicopter for the firefighting operations on Saturday morning, Chief Minister Pushkar Singh Dhami said after reviewing the situation in the Kumaon region on Saturday night.

According to the Indian Air Force, a Mi-17 V5 helicopter has been deployed in Nainital and surrounding areas to douse the flames.

Apart from the IAF helicopter and Army personnel, Prantiya Rakshak Dal volunteers and homeguard personnel have also been roped in to help in the firefighting operations, Kumaon Commissioner Deepak Rawat said. Additional government vehicles, two each for the three forest divisions, have been provided to rush firefighting teams to the affected areas, he

Help from locals with the involvement of forest panchayat officials is also being taken as they are the first responders to forest fires, Rawat said.

Forest department personnel are going from village to village in the hills to raise awareness about forest fires, Garhwal DFO Anirudh Swapnil told reporters in Pauri.

Loudspeakers are being used to spread the messages. People are being asked to report any forest blaze immediately to the authorities and not to burn garbage in the open or carelessly throw burning cigarette butts or bidis in the forest areas, Swapni said.

People are also being asked to report to the authorities if they catch someone setting a fire in the forests, he said, adding that any person reporting such a violation will be rewarded by the forest department.

Legal action under the Forest Act 1927 will be taken against anvone caught setting fire to the jungles, he added. Burning forests in order to obtain fresh grass for their cattle is a widely prevalent practice in the hills of Uttarakhand.

The chief minister has cancelled the leaves of forest department officials until the fire situation is completely brought under control.

Leave applications of forest department personnel will be considered only in case of medical emergencies, Dhami said. Forest officials said the IAF helicopter collected water from the Naini and Bhimtal lakes in a Bambi bucket and poured it over the burning forests of the Pines, Bhumiadhar, Jyolikot, Narayan Nagar, Bhawali, Ramgarh and Mukteshwar areas. The bucket can hold up to

5,000 litres of water at a time. As many as 31 fresh incidents of forest fire were reported from various parts of the state on Friday, destroying 33.34 hectares of forest land, accord-

Village defence guard killed in gunfight with terrorists in J&K, search operation underway

JAMMU, April 28: A Village Defence Guard (VDG) member was killed in a gunfight with terrorists in a remote village in Jammu and Kashmir's Udhampur district early Sunday, officials said.

A massive search operation is underway to flush out the terrorists, who are believed to have recently infiltrated from Pakistan, they said. The exchange of fire was reported

from Panara village of Basantgarh when a patrolling party of police and VDGs confronted the suspected terrorists around 7:45 am, the officials said. According to them, following an initial exchange of fire that last over half

an hour, the terrorists fled deep into the forest area and were being chased by the security forces. VDG member Mohd Sharief, a resident of Khaned, was critically injured in the firing and later succumbed to in-

juries, the officials stated. "After receipt of inputs regarding

Drugs worth ₹ 600 crore seized from Pakistani boat off Gujarat coast; 14 crew members held

AHMEDABAD, April 28: The Indian Coast Guard has seized 86 kg of drugs worth ₹ 600 crore from a Pakistani boat and arrested 14 persons on board the vessel off the Gujarat coast, the maritime security agency said on

The overnight operation in the Arabian Sea was carried out in coordination with the Guiarat Anti-terrorism Squad (ATS) and the Narcotics Control Bureau (NCB), it said.

"In a breathtaking overnight operation, Indian Coast Guard undertook an intelligencebased anti-narcotics operation at sea on 28 Apr 24. Approx 86 kg of narcotics worth ₹ 600 crore has been apprehended along with 14 crew from the Pakistani boat," the agency

said in a release. The Coast Guard is yet to

disclose what kind of narcotic substances were recovered from the Pakistani boat. Coast Guard ships and air-

craft were deployed for the operation, it said, adding that ICG ship Rajratan was used to identify the suspect boat with the help of NCB and ATS officials on board. "No amount of evasive ma-

noeuvring tactics employed by the drug-laden boat could save it from the swift and strong ICG ship Rajratan. The ship's specialist team embarked on the suspect boat and, after thorough checks, confirmed the presence of a sizable amount of narcotics," the Coast Guard

Sandeshkhali: West Bengal govt moves Health secretary urges states, UTs to SC against HC order directing CBI probe



NEW DELHI, April 28: The Supreme Court is scheduled to hear on Monday a plea by the West Bengal government challenging the Calcutta High Court order which directed a CBI probe into allegations of crimes against women and land grabbing in Sandeshkhali.

A bench of Justices B R Gavai and Sandeep Mehta is likely to hear the matter.

In its plea before the top court, the state government said the high court's April 10, 2024 order demoralised the entire state machinery, including the police force.

'The high court in a very generic order directed the State to provide the required support to the CBI without any guidelines, which amounts to usurping the powers of the state police to investigate any cognisable offence in the Sandeshkhali area, even if the same is not related to the allegations levelled by the PIL petitioners," the plea said.

The CBI is already investigating the case of attack on Enforcement Directorate officials Sandeshkhali and has registered three FIRs related to incidents on January 5.

Stating that the investigation will be monitored by the court, the high court directed the CBI to file a comprehensive report on the alleged illegal conversion of agricultural land into water bodies for pisciculture after conducting a thorough inspection of revenue records and physical inspection of land alleged to have been converted.

The high court also directed the Central Bureau of Investigation (CBI) to investigate allegations of crimes against women and land grabbing in Sandeshkhali and submit a comprehensive report to it on the next date of hearing.

The high court bench had directed that the matter will be heard again on May 2, the date on which the CBI was asked to file the report. ED officials were attacked on January 5 by a mob when they went to Sandeshkhali to search the premises of now-suspended Trinamool Congress leader Shahjahan Sheikh in connection with a ration distribution scam case.

Passing the judgement, the high court observed that an impartial inquiry is required to be done by an agency which has the power to probe the criminal angle stated to be involved.

Noting that the petitioners had prayed for the constitution of an enquiry committee to be headed by a retired judge, the high court had said that it decided to order an investigation by the CBI considering the nature of allegations involving crimes against women and grabbing of land of locals, including those belonging to Scheduled Tribes and the volume of complaints placed before it by one of

Around 600 complaints in the form of affidavits, including those of alleged sexual atrocities, land grabbing and other crimes such as assault and destruction of property, have been submitted before the high court by petitioner-lawyer Priyanka Tibrewal.

The high court had said it decided to hand over to the CBI the probe with regard to allegations and complaints of people of Sandeshkhali as the central agency is already investigating the attack on ED officials there. (PTI)

However, total beneficiaries linked with ABHA under Non-communicable diseases (NCD), Sickle cell, RCH, NIKSHAY, National Viral Hepatitis Control Program (NVHCP) and Pradhan Mantri Na-Dialysis Programme (PMNDP) are only 827.99 lakhs, 0.89 lakhs, 15.78 lakhs, 2.46 lakhs, 0.056 lakhs and 0.17 lakhs, respectively, he said. "This shows that though the states

have taken huge interest in creation of the IDs but non linking of health records with these IDs is not allowing the stakeholders, including the patients, from reaping the benefits of digital health records," the health secretary said. "You are, therefore, requested to kindly take necessary ac-

tion for linkage of existing beneficiaries with ABHA in the various portals and do regular review of the progress at your level," he stated in a letter to all the state and UT governments. Chandra said the National Digital Health Mission (NDHM) was launched by Prime Minister Narendra Modi on September 27, 2021 and all the health facilities in the country are to take part in this mission. Further, via Health Facility Registry and Health Professional Registry, the ABDM platform has to be utilised to the optimum extent, he said in the letter.

"In this regard, all states and UTs have been requested in the past

through a letter on June 13, 2023 for the 100 per cent compliance in ABHA seeding on various portals. Some states and UTs have shown impressive progress in the creation of ABHA IDs." he said.

Chandra said currently, beneficiaries are being linked with ABHA under various health portals like NCD, Sickle Cell, Reproductive Child Health (RCH), NIKSHAY, NVHCP and PMNDP, etc. Additionally, states and UTs have to link the beneficiaries under the IDSP-IHIP (Integrated Health Information Platform) portal, the health secretary said in the letter.

Want to let world know about 'Chinese repression': Tibetan girl who was jailed for demanding 'Free Tibet'

DHARAMSHALA, April 28: On October 21, 2015, a 15-year-old Tibetan girl along with her sister was picked up by Chinese authorities in the Tibetan county of Ngaba and put behind bars for three years for publicly displaying portraits of the Dalai Lama and demanding a "free" Tibet.

In June last year, the girl, Namkyi, arrived in India weeks after entering Nepal following a 10-day arduous journey on foot with a "firm" resolve to aware people across the world about 'Chinese repression' in Tibet, according to her account.

Namkyi, now 24, says she is currently studying at 'Sherab Gatsel Ling', an educational institution being run by the Tibetan government-in-exile in Himachal Pradesh's Dharamshala.

"What the Chinese government is showing to the entire world about Tibet is in total contrast to the real situation. The Tibetan people are living under increasing fear and repression," she told a small group of journalists.

"China has been trying to undermine Tibet's identity," she alleges. The Tibetan activists have been accusing China of denying religious freedom and trying to stamp out Tibet's cultural heritage and



identity. Beijing has been rejecting the charges.

"I want to tell the world what is happening in Tibet. I want to be the voice of the Tibetan people to let the world know about their pain and anguish, about the Chinese repression," Namkyi said.

The girl, born to a typical nomadic family in Charo village, also recalled her and her sister Tenzin Dolma's detention following their demonstration at a key locality in Ngaba, "calling for 'Free Tibet' and seeking swift return of the Dalai Lama to Tibet".

our march, four or five police offi-

cers came from behind and

Lama) from our hands," she said about the October 21, 2015 protest.

"We did not let the portraits go from our hands and resisted the police action. Finally, the Police dragged us down the road and told us to be silent. But we shouted our slogans continuously," she said.

'They handcuffed our hands, put us into the police van, and took us away to the detention centre of Ngaba County. Then, they took us to another detention centre in Barkam city.' Namkyi said she and her sister

were subjected to severe torture. "We were interrogated in a small room where a heater was switched on with excessive heat. Different members and relatives in view of interrogators asked various questions such as who incited us to hold the protest; where did we get the portraits of the Dalai Lama and whether we had any acquaintances from outside etc," she said.

"Despite mental and physical torture, we only responded that both of us freely decided to hold the protest, and no one incited us, and also that our family members knew nothing about it.'

Namkyi said the trial started nearly a year after the arrest.

"That day (when the trial began), we both saw each other for the first time since our arrest," she remembered, adding the court sent to prisons. "After three months in prison, I

worked in a labour camp where copper wires were produced, and my sister made cigarette boxes at first, and then we were shifted to a wrist-watch manufacturing camp," she said.

"Later, we learned that our family had sent food and clothes for us, but we never got anything from the prison authorities.

"On 21 October 2018, we were released from prison after completing the prison term," she added. Namkyi alleged that the Chinese authorities "troubled" her family

the demonstration held by her and her sister.

"On May 13, 2023, I started my journey of escape with my aunt Tsering Kyi without telling anyone," she said adding they first crossed over to Nepal through a border point

Namkyi said she came to Dharamshala on June 28 last year. In India for close to 10 months, she feared for the safety of her family members.

"I am worried that my family may be targeted," she said. Namkyi said her main aim now

is to "let the world know the real situation in Tibet." "People are living in pathetic conditions in Tibet. I want to be their voice to the world. I want to

visit various countries and spread

and tell them what is going on in Tibet," she added. Namkyi said she had the opportunity to seek blessings of the Dalai Lama last year during which he underlined the need for working towards protecting the identity and

cultural heritage of Tibet. After a failed anti-Chinese uprising in 1959, the 14th Dalai Lama fled Tibet and came to India where he set up the government-


The singer shared a series of pictures and videos from the show on his Instagram page on Sunday.



Hima to return to action after NADA panel's goahead following suspension for whereabout failure



NEW DELHI, April 28: Star India sprinter Hima Das will return to action at the Indian Grand Prix 1 on Tuesday in Bengaluru after a disciplinary panel of the National Anti-Doping Agency (NADA) gave the green signal to her following a hearing last month, according to sources.

The 24-year-old Hima was last year provisionally suspended by the NADA for three whereabout failures in 12 months. Her name figured in the women's 200m race entry list for the IGP 1 on April 30, prepared by the Athletics Federation of India.

'She was set free in a hearing by the NADA Anti-Doping Disciplinary Panel last month," an Indian athletics team source told PTI on conditions of anonymity. The source did not elaborate about how the NADA disciplinary panel cleared her to compete

Hima had won a 400m individual silver at the 2018 Jakarta Asian Games. She was also a part of the gold and silver-winning women's 4x400m and mixed 4x400m relay quartets in Jakarta.

The runner from Assam was not named in the Hangzhou Asian Games team last year due to an injury she had sustained earlier this year.

She last ran a race — a 200m – during the Indian Grand Prix in Bengaluru in April last year,

of 23.77 seconds. After that, she missed the whole of 2023 season. In September last year, it had

come to light that Hima committed three whereabout failures in a one-year period and she was provisionally suspended by the NADA.

At that time also, there was no clarity on whether Hima's whereabouts failure related to filing or missed test.

She had faced a maximum two-year ban if proven guilty, which can be reduced to a minimum of one year depending on the degree of her fault.

Under the World Anti-Doping Agency (WADA) rules, any combination of three whereabouts failures — filing failure and/or missed test — within a period of 12 months constitute an anti-doping rule violation.

Athletes included in the Registered Testing Pool (RTP) must provide full address for their overnight location, the name and full address of each location where they train, work or conduct other regular scheduled activities, as well as the usual time-frames of each activity.

RTP athletes must also identify a 60-minute window and location for each day of the quarter, during which they must be available for testing. Failure to comply with whereabouts and testing obligations will result in a where-

Shooter Maheshwari locks 21st Paris Olympic quota place with silver medal in Doha

NEW DELHI, April 28: Shooter Maheshwari Chauhan on Sunday sealed India's 21st quota place for the Paris Olympics by winning a silver medal in the women's skeet event on the concluding day of the ISSF Final Olympic Qualification Championship Shotgun in Doha.

Maheshwari, competing in her maiden ISSF Final, lost 3-4 to Chile's Francisca Crovetto Chadid in a shoot-off for gold, after both were tied at 54 hits in the 60shot final. It is India's second Paris quota place in the women's skeet.

"I am thrilled. There has been a lot of hard work over the years to get here. I am a bit bummed about the shoot-off, but overall, it has been very satisfying," said Maheshwari after the final.

The day began with the Indian on top of the qualification pile, but a final round score of 23 meant she would qualify for the top-six final in fourth position. Her tally of 121, however, did give her the new

Given Chadid had already secured a quota place in earlier competitions and

China's Jiang Yiting, the sixth qualifier, was ineligible as her nation had already exhausted their quotas in the event, Maheshwari's fight was with three others (Kazakhstan's Assem Orybay, Azerbaijan's Rigina Meftakhetdinova and the top

Shooter Maheshwari clinches silver medal in Doha

NEW DELHI, April 28: Shooter Maheshwari Chauhan on Sunday sealed India's 21st quota place for the Paris Olympics by winning a silver medal in the women's skeet event on the concluding day of the ISSF Final Olympic Qualification Championship Shotgun in Doha.

Maheshwari, competing in her maiden ISSF Final, lost 3-4 to Chile's Francisca Crovetto Chadid in a shoot-off for gold, after both were tied at 54 hits in the 60-shot final. It is India's second Paris quota place in the women's skeet.

"I am thrilled. There has been a lot of hard work over the years to get here. I am a bit bummed about the shoot-off, but overall, it has been very satisfying," said Maheshwari after the final.

The day began with the Indian on top of the qualification pile, but a final round score of 23 meant she would qualify for the top-six final in fourth position. Her tally of 121, however, did give her the new national record.

Given Chadid had already secured a quota place in earlier competitions and China's Jiang Yiting, the sixth qualifier, was ineligible as her nation had already exhausted their quotas in the event, Maheshwari's fight was with three others (Kazakhstan's Assem Orybay, Azerbaijan's Rigina Meftakhetdinova and the top qualifier Sweden's Victoria Larsson).

India should pick two wristspinners for T20 WC: Pathan

MUMBAI, April 28: Former all-rounder Irfan Pathan said India must pick five specialist bowlers along with two wrist-spinners in their squad for the upcoming T20 World Cup to be played in the Caribbean and the USA. With the May 1 deadline for the squad announcement approaching fast, discussions have intensified around the combination of India's squad for the showpiece event starting on June 2. "You need five good bowlers — that's a must. What are your wicket-taking options? When you're talking about Ravindra Jadeja at No. 8 and playing as a spin (all-rounder), I would rather have two wrist-spinners playing," Pathan told Star Sports.

"I would rather have two proper wrist-spinners playing, (Ravi) Bishnoi and Kuldeep (Yadav), in my playing XI. If you look at Bishnoi's numbers, you know, when he played, he was pretty good." Pathan, however, is not in favour of calling up Rajasthan Royals' Yuzvendra Chahal for the World Cup. "Yes, we're talking about Chahal right now because of the IPL performances but don't forget the fielding part of it as well. If you have to balance the fielding, you have to balance where a bowler can bowl at the particular area," he said. Pathan conceded that Jasprit Bumrah is the only automatic selection among the bowlers.

"There's only one player who you can blindly say (certain for selection) is Bumrah. But apart from Bumrah, you need at least two fast bowlers who can be part of the regular XI," the former India cricketer said. "The biggest problem the Indian team has is the combination of fast bowling. It's very important to fix that combination, so go towards experience.

"With Bumrah, you can see (Mohammed) Siraj and Arshdeep (Singh) there, which I don't think is ideal, but this is the only option you have now," he said.

Former India batter K Srikkanth, meanwhile, is not in favour of Siraj being selected for the World Cup. "Bumrah is in the squad. Arshdeep as well. But the third pacer can't be Siraj. He'll bowl well in one game and then not perform in 10 games. He's an erratic bowler, you saw it in the World Cup," he said. (PTI)
