

CM's Rs 10,000 promise to ration card holders a clear violation poll code: Cong candidate

Pradyut moves EC against Himanta

GUWAHATI, April 10: Congress MP and Lok Sabha poll candidate from Nagaon constituency, Pradyut Bordoloi, has filed a complaint against chief minister Himanta Biswa Sarma, alleging that he violated the model code of conduct by offering money to all ration cardholders during the ongoing election campaign.

Bordoloi filed the complaint to the chief election commissioner on Tuesday night, alleging that Sarma, in a public meeting in Lakhimpur during the day, made a promise to transfer Rs 10,000 to the bank accounts of every ration cardholder after the election.

Stating that such assurances are a "clear violation" of MCC, the Congress leader said, "Such promises are not only unethical but also an attempt to influence voters through financial inducements, thereby compromising the integrity of the electoral process".

He urged the ECI to investigate the

Bordoloi also filed another complaint with the chief electoral officer alleging that the BJP was continuing with the controversial socio-economic survey,

promising to include beneficiaries under the 'Orunodoi' cash direct benefit transfer (DBT) scheme," the Congress MP said. Bordoloi claimed that such forms were being distributed in Ward No 1 of Matharboi of Barapujia Gaon Panchayat in Morigaon district on Tuesday.

"I fear that similar activities might be taking place in other locations as well. This blatant disregard for electoral norms and the misuse of government schemes for electoral gains is unacceptable," he added.

Public holiday

IMPHAL: Manipur government has declared public holiday on April 19 and April 26, when voting will take place for all two Lok Sabha seats in the state, as public holidays. An order regarding the declaration of public holiday on these poll days was issued by the General Administration Department (GAD) on Wednesday. The state GAD issued the order in pursuance of a letter of the Election Commission of India coupled with another letter of the chief electoral officer (CEO) Manipur. The order declared a public holiday for all public offices, educational institutions, autonomous bodies, etc., and a paid holiday for commercial and private undertakings in the state located within the area of 47 Assembly segments where the polling will take place on April 19.

Officials said the climate finance problem needs to be fixed by the end of the year UN climate chief presses for faster action, says 2 years left 'to save the world'

OXFORD, April 10: Humanity has only two years left "to save the world" by making dramatic changes in the way it spews heat-trapping emissions and it has even less time to act to get the finances behind such a massive shift, the head of the United Nations climate agency said on Wednesday.

With governments of the world facing a 2025 deadline for new and stronger plans to curb carbon pollution, nearly half of the world's populations voting in elections this year, and crucial global finance meetings later this month in Washington, United Nations executive climate secretary Simon Stiell said he knows his warning may sound melodramatic. But he said action over the next two years is "essential.'

"We still have a chance to make greenhouse gas emissions tumble, with a new generation of national climate plans. But we need these stronger plans, now," Stiell said in a



speech at the Chatham House think tank in London. He suggested that climate action is not just for powerful people to address — in a not-soveiled reference to the electoral calendar this year.

"Who exactly has two years to save the world? The answer is every person on this planet," Stiell said. "More and more people want cli-

mate action right across societies and political spectrums, in large part because they are feeling the impacts of the climate crisis in their everyday lives and their household budg-

Crop-destroying droughts have increased the need for bolder action to curb emissions and help farmers adapt which could boost food security and lessen hunger, he said. "Cutting fossil fuel pollution will mean better health and huge savings for governments and households alike," Stiell said.

Not everyone is convinced such warnings will be helpful.

"Two years to save the world' is meaningless rhetoric — at best, it's likely to be ignored, at worst, it will be counterproductive," said Princeton University climate scientist Michael Oppenheimer, who is also a professor of international affairs. Levels of carbon dioxide and

methane in the air last year hit alltime highs, according to United States government calculations, while scientists calculate that the world's carbon dioxide emissions jumped 1.1 per cent. Last year was the hottest year on record by far, global temperature monitoring groups concluded.

Sensex closes above record 75K mark, Nifty hits new peak as metal, FMCG shares shine

MUMBAI, April 10: Benchmark Sensex climbed 354 points to close above the record 75,000 mark for the first time while broader Nifty scaled a fresh lifetime high on Wednesday on gains in FMCG, energy and metal shares

The 30-share BSE Sensex climbed 354.45 points or 0.47 per cent to settle at an all-time high of 75,038.15. During the day, the index spurted 421.44 points or 0.56 per cent to hit a high of 75,105.14.

Broader Nifty of the NSE advanced by 111.05 points or 0.49 per cent to close at a record peak of 22,753.80. During the day, it jumped 132.95 points or 0.58 per cent to reach a lifetime intra-day peak of 22,775.70.

Key indices hit intra-day lifetime high levels on Tuesday with Sensex scaling the historic 75,000 mark for the first time but closed in the red following profit booking in index major Reliance Industries.

ISLAMABAD, April 10: In its efforts to put the cash-strapped economy back on track, the Pakistan government has decided to formally approach the IMF for a medium-term Extended Fund Facility during the upcoming Annual Spring Meetings of Bretton Woods Institutions next week, a media report said on Wednesday.

Islamabad will make a request for the medium-term Extended Fund Facility (EFF) with the possibility of augmenting through climate finance as Pakistan's delegation led by Finance Minister Muhammad Aurangzeb will attend the meetings to be held from April 15 to 20 in Washington DC, The News International reported.

The Bretton Woods Institutions are the World Bank and the International Monetary Fund (IMF) called so as both were set up at a

meeting of 43 countries in Bretton Woods, New Hampshire, USA in July 1944.

In mid-March, IMF's global team reached a staff-level agreement with the Pakistani authorities on the second and final review of Pakistan's stabilisation programme supported by the global lender's USD 3 billion standby arrange-

ment approved in July last year. On March 26, Prime Minister Shehbaz Sharif too had indicated that his government is planning to approach the IMF for another programme, days after the economic crisis-ridden country struck a stafflevel agreement with the global lender regarding the disbursal of the final tranche of USD 1.1 bil-

lion. With the augmentation of the next bailout package through climate finance, Pakistan is all set to make a formal request to IMF dur-

ing the upcoming annual spring meetings, the report said, quoting top official sources. The size and duration of the upcoming bailout package will be worked out by the IMF's review mission expected to hold talks, probably from the first week of May 2024, to finalise major contours of the upcoming bailout package, it said.

The sources said Pakistan decided to request augmenting the EFF through climate finance, so there was a possibility for securing USD 6 billion to USD 8 billion size of the upcoming programme. We are going to present our ar-

gument before the IMF management that Pakistan faced severe consequences of climate degradation and deserved support from the international community and donor agencies, the report quoted sources as saying.

The sources said there was one IMF instrument under the Resilience and Sustainability Facility (RSF) which provided affordable longterm financing to countries undertaking reforms to reduce risks to prospective balance of payments stability, including those related to climate change and pandemic preparedness.

By reducing prospective balance of payment risks, an RSF arrangement aims to contribute to longerterm Balance of Payment (BoP) stability. (PTI)

natural gas continue to rise or don't start a sharp decline, Stiell said it "will further entrench the gross inequalities between the world's richest and poorest countries and communities" that are being worsened by climate change.

And behind it all is money.

Stiell's speech comes just ahead of meetings of The World Bank and other big multinational development institutions, where poorer nations, led by Barbados Prime Minister Mia Mottley and Kenyan President William Ruto, are pushing for major reforms in the systems that loan money to poor nations, especially those hit by climate-related disasters.

In conjunction with that push, Stiell called for "a quantum leap this year in climate finance." He called for debt relief for the countries that need it the most, saying they are spending USD 400 billion on debt financing instead of preparing for and preventing future climate change.

He called for more financial aid, not just loans, and more money from different groups like banks, the International Maritime Organization, and the G20, the world's 20 most powerful economies. Those countries are responsible for 80 per cent of the world's heat-trapping emissions, he said.

"G20 leadership must be at the core of the solution, as it was during the great financial crisis," Stiell said. "Every day, finance ministers, CEOs, investors, and development bankers direct trillions of dollars. It's time

to shift those dollars from the energy and infrastructure of the past, towards that of a cleaner, more resilient future," Stiell said. "And to ensure that the poorest and most vulnerable countries benefit."

Officials said the climate finance problem needs to be fixed by the end of the year with November's climate negotiations in Baku, Azerbaijan, a crucial point.

Stiell is "absolutely right" that timing and finance are the heart of the matter, said longtime climate analyst Alden Meyer of European think tank E3G. The carbon action plans submitted by next year will "determine whether we can get on the trajectory of sharp emissions reductions needed to avoid much worse climate impacts than those we are already suffering today," he said.

With so many elections and places where democracies are on the brink, "climate finance related to carbon policy is on the line," said Nancy Lindborg, president of the David and Lucille Packard Foundation, at the Skoll World Forum, an ideas conference in Oxford, England.

Climate Analytics CEO Bill Hare said Stiell was "listening to the science" - namely that global emissions must be halved by the end of the decade to meet the Paris climate accord's ambition of capping global temperature increases to 1.5 degrees Celsius (2.7 Fahrenheit). "Governments are nowhere near that, and disastrously many are still supporting new fossil fuel development," Hare said. "We need to see a massive strengthening of action now - faster ramping up of renewables, electric vehicles and batteries - if we're to get serious reductions by 2030. The longer we wait, the more it will cost." (AP)

TEZPUR, April 10: As the whole country prepares for the upcoming 18th General Lok Sabha Elections, anticipation and excitement continue to build among both candidates and voters in the 11-Sonitpur Constituency, erstwhile 9-Tezpur HPC. In a bid to secure voter support, candidates from various political parties have been conducting rallies, road shows, and door-to-door campaigns to win the first phase of the election game slated for April 19. Leaders of different political parties including state chief minister Himanta Biswa Sarma, former central minister and Congress leader Pawan Singh Ghatowar, AAP leader Atishi Marlena, and many others have kept up their pace in the constituency to accelerate the poll campaign

New joining and shifting of members from one political party to another are also continuing during the poll campaigns in the Sonitpur Lok Sabha constituency, which includes nine LACs comprising Bihpuria, Biswanath, Gohpur, Bihali, Tezpur, Naduar, Borchala, Rangapara, and Dhekiajuli, having a total of 16,25,364 voters, including 8,10,112 male voters, 8,15,222 female voters, and 30 transgender voters. Various contenders have been addressing crowds, highlighting their respective agendas and promising development and progress for the constituency. While a triangular contest is anticipated among Premlal Ganju from the Indian National Congress, Ranjit Dutta from

the Bharatiya Janata Party, and Rishiraj Kaundinya from the Aam Aadmi Party, the competition cannot overlook the presence of five other candidates including BPF's Raju Deuri, Alam Ali from Bahujan Maha Party, Kameswar Swargiary from Voters Party International, the sole female contender of the constituency Rinku Roy from Gana Suraksha Party, and Pradip Bhandari, who is independently vying for attention and support from the electorate.

If we peep through the lens of the last Lok Sabha Election, we find the sharing of votes in the last Lok Sabha poll against BJP were 58.21 percent (Pallab Lochan Das-6,81,437), Indian National Congress (MGVK Bhanu- 4,40,461) 37.62 percent, Independent (Bijay Kumar Tiru- 23,626) 2.02 percent, Voters Party International (Mahendra Orang- 7,950) 0.68 percent, Nationalist Congress Party (Mahendra Bhuyan-6,398) 0.55 percent. Among the nine LAC constituencies, Dhekiajuli contributed 98,152 votes to the winner and 48,315 to the Runners-up making a difference of 49,837 votes, Barchala contributed 71,689 and 51,066 with a difference of 20,623 votes, Tezpur contributed 74,055 and 66,696 with a difference of 7,359 votes, Rangapra contributed 73,992 and 43,332 with a difference of 30,660 votes, Sootea contributed 78,404 and 50,737 with a difference of 27,667 votes, Biswanath contributed 69,017 and 54,686 with a difference of 14,331 votes,

Behali contributed 55,339 and 36,965 with a difference of 18,347 votes, Gohpur contributed 95,447 and 49,264 with a difference of 46,183 votes and Bihpuria contributed 65,342 and 39,400 with a difference of 25,942 votes, respectively.

Historically, the constituency has a great legacy as it had been represented by many distinguished MPs like Kamakhya Prasad Tripathy in 1952 from Indian National Congress, Padmabhushan Bijay Chandra Bhagwati, a known companion of Mahatma Gandhi, writer, and journalist, playing on the Indian National Congress card, had been represented the Tezpur constituency three times in 1957, 1962, and 1967 and played a significant role in the politics of the country. On the other hand, the brother of Jyoti Prasad Agarwala, Kamala Prasad Agarwala was elected as an MP from Tezpur representing Indian National Congress in 1971. Dr Purna Narayan Singha, a vocal leader from the constituency, was elected as an MP representing the Janata Dal in 1977. The later MPs representing Indian National Congress from the constituency were Bipinpal Das (1984), Swarup Upadhyay (1991), Iswar Prasanna Hazarika (1996), and Moni Kumar Subba (1999, 2004), Assam Gana Parishad candidate Joseph Toppo (2009), BJP candidate Ram Prasad Sarmah (2014), and Pallab Lochan Das (2019).

Beleaguered Kejriwal

elhi chief minister Arvind Kejriwal knocked on the Supreme Court's door Wednesday and sought "urgent listening". Senior Advocate AM Singhvi, Kejriwal's counsel, asserted that the Delhi chief minister's arrest was based on an" unrelied document" and "suppressed from us". Chief Justice of India DY Chandrachud told Singhvi to "please send an email". The problem is, evidence against Kejriwal is overwhelming and the apex court might be constrained to come to a decision that the "only difference between the saint and the sinner is that every saint has a past and every sinner has a future". That way, Kejriwal and the future of the current Delhi government will be assured. AAP leaders believe Delhi's future is linked intrinsically to Kejriwal remaining chief minister.

AAP guys are simple, and straightforward. They think linearly. They say they care for Delhi and that Delhi needs the firm hand of Kejriwal's leadership to survive Modi rule. They expected the apex court to act immediately, but it might take longer. AAP spokespersons Reena Gupta, Priyanka Kakkar and AAP cabinet minister Saurabh Bharadwaj cited AAP Rajya Sabha MP Sanjay Singh's release on bail by the Supreme Court as a precedent. They were predicting chief minister Arvind Kejriwal would walk free much like Sanjay Singh did, "just you wait and see." They deny AAP's involvement in the liquor policy scam. "It is the BJP's ghotala, not AAP's. Where is the money trail? AAP is being targeted because the AAP government of Kejriwal built schools and mohalla clinics." But it is not easy to defend Kejriwal. Those fasting and demonstrating in London and Washington DC should see the writing on the wall. Arvind Kejriwal is in judicial custody because of a bunch of damning evidence. There's no evident money trail because the money was in cash and was spent in AAP's Goa election campaign.

But those who received the cash for electioneering in Goa have spoken on sworn affidavits. Keiriwal thought he was smarter with his 'Beautiful Mind'. Overconfidence did Kejriwal in. He is now on thin ice. Unless the Supreme Court rules in his favour Kejriwal's career is in the hands of the Supreme Court. Even the future of the AAP is in jeopardy. The High Court on April 9 pretty much closed the door on both Kejriwal and Aam Aadmi Party. Whoever was advising Kejriwal was doing it all wrong. Perhaps Kejriwal thought it up all by himself. Even after all this, AAP spokespersons are talking like they're miles better than other parties' spokespersons. Then again, turning the tables is an AAP specialty. Kejriwal had termed all the ED summons "illegal" The Delhi Court on April 9 overruled and ruled them and his arrest "legal". What we now know is that Kejriwal "conspired with others" to change Delhi's excise policy and it is not just an observation, it is in the order. It is like Arvind Kejriwal went for his own execution.

The High Court also mentioned "kickbacks" that went straight into AAP's safe. But hope springs, wasn't Sanjay Singh let off on bail by the Supreme Court? Sanjay Singh is now a believer and he is confident the Supreme Court will view the "facts" laid out by the High Court and rule fairly. Does it look like two courts are fighting each other and will the Supreme Court overturn judge Swarana Kanta Sharma's ruling once again like it did in the Sanjay Singh case?

For now, the 'Kingpin' of liquor-gate will remain in Tihar till April 15 unless the Supreme Court acts before that and rules in his favour. It looks tough though as the High Court's April 9 verdict had plainly and squarely ruled that Delhi Chief Minister Arvind Kejriwal had "conspired with others" and was "actively involved in using proceeds of crime".

enwa Meyor, 40, and Kunchok Dolma Meyor, 29, are residents of Kibithoo, one of the easternmost villages in Anjaw district of Arunachal Pradesh. Inhabited by the Meyor tribe, it is located about 7-8 km from the Line of Actual Control (LAC), the contested line that separates India and China. Their husbands work as porters with the Indian Army, like many men here.

Demwa has two children, a 13-year-old daughter and a fouryear-old son. Her daughter is in a hostel in Hayuliang, about 135 km away; as Kibithoo's school runs only until Class 8 and English-medium education is limited in the area.

"We want better education (closer home), and in English," says Denwa. The State-run hostel costs ₹ 60,000-70,000 a year and making the monthly trip to see her daughter is expensive. Over the past year, the village of about 130 residents has witnessed its Primary Health Centre and residences of the school teachers being upgraded and concrete tracks being laid under the Central government's Vibrant Villages Programme (VVP).

Nijum Manyu, 32, who came to Kibithoo three years ago as a contractual government teacher, says now, there are four teachers, and the school is being renovated, with a new badminton court as well.

Army's demarcation:

For administrative purposes, the Army classifies Arunachal as Kameng, derived from the name of the river that flows through the State.

Tawang district is part of the Kameng area, while the remaining part of the State is considered separate and was earlier referred to as the Rest of

Arunachal Pradesh (RALP). Of the 3,488-km-long LAC, 1,346 km falls in the eastern sector, comprising Sikkim and Arunachal. While the Tawang and Kameng areas are under the Army's IV Corps, headquartered at Tezpur, RALP is under the III

China possesses. The VVP was approved as a Centrally-sponsored scheme on February 15, 2023, with an outlay of ₹ 4,800 crore for the financial years 2022-23 to 2025-26 for the development of 2,967 villages in the Border States of Arunachal Pradesh, Himachal Pradesh, Sikkim, Uttarakhand, and the Union Territory of Ladakh.

Union Home Minister Amit Shah formally launched the VVP in Kibithoo on April 10, 2023. He also inaugurated nine micro hydel projects of the State government and 14 infrastructure projects for the Indo-Tibetan Border Police (ITBP).

"Captured the beautiful landscapes during my visit to Kibithoo, India's first village. Arunachal Pradesh is blessed with immense natural beauty. I urge all to visit Arunachal Pradesh, especially Kibithoo, to be inspired by its history and stunned by nature's marvels," the Union Minister said in a post on social media platform X (formerly Twitter), after his visit, along with a video of the mountainous landscape.

Just a few metres from where Denwa and Kunchok live, is Kibithu Bakery, staffed with four 20 to 27- year-old women, who draw a monthly salary of ₹ 7,500. It was established in 2022 by the Army with the help of the Pune-based Aseem Foundation, through funds under Operation Sadbhavna, a social welfare scheme spanning the areas of environment, education, and skilling.

In the past, mobile phones at Kibithoo would only connect to Chinese networks. Locals would tell the few tourists here to put their phones on flight mode to avoid international roaming charges.

However, now phones pick up both Indian and Chinese networks. Officials explain that while towers have been set up, optical fibre networking is in progress.

As connectivity improves, efforts are on to promote tourism. Under the Seema Darshan project, the State government, with support from the Indian Army, has approved 12 tourist circuits, including two foreign tourist ones, beyond the Kameng area. Religious tourism to Kepang La, Pasang Sonam Tso Lake, and Taksang Gompa is also being showcased and promoted, an official says, adding that passes for trekking are also being facilitated.

Heed the warnings Sir/Ma'am As most part of the country braces for a scorching summer, the India Meteorological Department (IMD) warns of above-normal temperatures and looming heatwaves in coming months. It's crucial for state governments to heed these warnings, prepare for heatwaves, and address long-term climate

The limits of ice: What a 19th century expedition trapped in sea ice for a year tells us about Antarctica's future

n 1897, the former whaling ship RV Belgica left Antwerp in Belgium and set sail due south. It was the first voyage of what would become known as the Heroic Age of Antarctic exploration. It did not go to plan.

After a six-month voyage, they begin encountering sea ice. Several times the ship is caught in the ice for a day or two. A crew member falls overboard and is lost to the icy waters. But the crew presses on, making measurements as they go. Expedition leader Adrien de Gerlache records the process:

At noon we made a deep sea sounding, with a long series of temperatures at various depths. We lowered five hundred and sixty metres of wire, and brought up a cup of blue clay. The temperature at the surface was at the freezing point, and at the bottom slightly warmer.

Their discovery of deep warmer water was important. It's since been named Circumpolar Deep Water. In our time, this water is getting warmer and warmer, as oceans absorb nearly all the extra heat trapped by burning fossil fuels. Antartica's seemingly impregnable ice is now melting from beneath.

But in 1898, the ice is strong. On March 4, the crew find themselves unable to move. As the southern winter looms, the ice thickens on the surface of the Bellingshausen Sea, to the west of the Antarctic Peninsula. The RV Belgica is trapped.

A winter of permanent night The crew were about to become the first people to spend a winter south of the Antarctic Circle, enduring months of constant night. The expedition was largely unprepared for the bitter cold and darkness. But the first mate, a 25-year-old Norwegian named Roald Amundsen, felt differently. He had joined the expedition in search of adventure. He was not disappointed. "We must no doubt spend the winter here, and that is fine with me," he wrote in his journal. Five days in, he writes: One starts to get familiar with

It is imperative to formulate interventions that promote behavioural changes to curb plastic pollution by encouraging citizens to conduct themselves responsibly by reusing, recycling, reorienting, and diversifying as promoted by the UNEP. This can be achieved through awareness campaigns by educating people about the effects of plastic pollution and incentivising responsible plastic-waste disposal.

On the policy front, local governments should increase investment in waste management infrastructure to ensure safe disposal and avoid plastic leakage. This basic initiative is critical in mitigating health and environmental hazards by reducing mismanaged plastics.

Roads, cycling lanes, and walking pathways using plastic waste have proved to perform better than traditionally asphalted roads. India, which has been involved in building plastic roads, can this efficient promote method of plastic waste management. Several countries have already implemented Extended Producer Responsibility (EPR) to curb plastic pollution as it decreases the cost associated with the disposal of packaging and waste material by the producers.

Under the EPR, charge for collecting and recycling plastic materials are levied on companies, incentivising them to reduce the usage of plastic and shift towards other environment-friendly materials. The EPR's implementation across Europe has contributed towards improved waste collection and

As climate change continues to worsen, this price inflation will mean more and more people around the world don't have a varied and healthy diet, or simply don't have enough food.

The new analysis shows that global warming could cause food price inflation to increase by between 0.9 and 3.2 percentage points per year by 2035. The same warming will cause a smaller rise in overall inflation (between 0.3 and 1.2 percentage points), so a greater proportion of household income would need to be spent on buying food.

Other consequences can include more pest and disease outbreaks that deplete livestock and food reserves, and heat stress to already-poor roads which makes it harder to access rural communities. All of these factors

push prices higher and reduce the purchasing power of affected households. The drivers of food inflation are already worsening food insecurity

The second part of this problem is the rise in inflation itself. A 3% annual price increase would mean households are less able to purchase what they need.

They would likely need to compromise on quality or perhaps even important culturally foods. This in turn makes people more vulnerable to disease and other health issues. Malnutrition is the leading cause of immunodeficiency globally.

In Ghana, we found that those who reported more knowledge of climate change were more likely to be food secure. This is despite few people having any formal education. This is evidence that affected popu-

fects that are causing the lations are very aware of the changing temperatures and unpredictability of the climate, and are perhaps engaging in proactive mitigation practices.

Those without any schooling are more likely to engage in a climatesensitive occupations such as farming, and so would be more immediately exposed. Teaching people about climate change might provide some capacity to adapt to it, and therefore increase food security.

Alterations in the climate are a hunger-risk multiplier for those populations with entrenched vulnerability. In light of this, 134 countries at COP28 signed a declaration to incorporate food systems into their climate action, to ensure everyone has enough to eat in light of climate change. The researchers behind the new study suggest that reducing greenhouse

gas emissions could limit any impacts on the global economy. We also suggest that diversifying economies would serve as some protection for those communities reliant on agriculture for both their food and income.

Government intervention could also ensure financial protection and nutritional aid for those vulnerable to becoming trapped in the poverty cycle by inflation and diminished accessibility to food. (Courtesy: Scroll.in)

Although plastics proved to be an essential element during the health crisis, their harmful effects, particularly their usage of nano- and micro-plastics have not been ignored. Exposure to microplastics and toxic chemicals through inhalation and skin contact has proven to be carcinogenic, capable of inducing brain damage and being potentially fatal. Humans and animals are exposed to the harmful effects of plastic during its production, consumption, and disposal.

the exact Although amount of plastic ingestion by humans is not clear, according to a report by the Wildlife Fund World (WWF), it is estimated that an average human could be ingesting around five grams of plastic weekly. According to a 2019 estimate, plastic pollution-induced diseases have killed 400,000 to one million people in developing countries annually. Thus, there is a need for regulatory intervention to address plastic pollution to protect both human health and the envi-

ronment. In this regard, the United Nations Environment Assembly passed a resolution in March 2022 to develop a legally binding agreement to end plastic pollution. It formed the Intergovernmental Negotiating Committee (INC) on plastic pollution, which aims to complete the agreement draft by 2024 that would cover critical aspects of the lifecycles of plastics and design recyclable and reusable products and materials.

Thus, aiming towards plastic diplomacy based on enhanced international cooperation enables countries to access technologies and scientific knowledge-sharing for a collaborative approach

Council, G7, and G20 summits prove this.

The issues of climate change and plastic pollution have emerged as non-traditional security issues, providing an avenue for research using various theoretical and conceptual frameworks such as the Green Theory in International Relations (IR), Constructivism theory, and the Securitization theory of the Copenhagen School. Barry Buzan has emphasised environmental security as an essential support system for humans. The securitisation of the issue has catalysed the state to respond effectively, by

making it an issue of high politics where political leaders become accountable and responsible for negotiating for human and health security.

With plastic pollution being a major threat to health and climate change, it necessitates a multilevel and collective action that can navigate through the geopolitical complexity of the issue. Issues such as microplastics in oceans are global and would require the consensus of diverse stakeholders along with the active participation of international organisations with the support of subnational entities.

The concern now is if and how the existing intellectual and structural international architecture can cooperate to address global issues like plastic pollution. There is a need for a tailored package—a mixture of policy interventions and legislative instruments, which clearly define the goals and commitments of the stakeholders, individuals, corporations, and states. Therefore, the meetings,

such as the second session of the Intergovernmental Negotiating Committee between 29 May and 2 June 2023, play a vital role in developing regulatory instruments

increased recycling rates. In France, it helped in reducing public spending on waste management, as approximately 15 percent of the cost was collected by EPR schemes.

Companies could be incentivised to adhere to the EPR norms by tagging Environmental, Social and Governance (ESG) ratings with compliance scores. ESG reporting has grown to become one of the crucial indicators for businesses to prove their commitment towards sustainability by providing intuitional measures to manage environmental and social impacts.

Therefore, mandating companies on their compliance with EPR during ESG reporting might lead them to take more proactive actions towards reducing their plastic footprints.

Viewing climate change through the lens of securitisation helps to focus on the associated risks such as triggering cross-boundary conflicts, causing instability to businesses, and affecting the livelihoods of vulnerable groups. Plastic pollution has far-reaching social and economic implications around the world. This year's World Environment Day, which also marks its 50th anniversary, has committed to focusing on "Solutions to Plastic Pollution".

It is a good platform for steering individuals, communities, corporations, and governments towards the shared vision of reducing plastic production, consumption, and waste mismanagement. The visible threat of plastic pollution calls for continuous deliberation to work towards gathering more data on the prevalence and effects of the presence of such materials in the long run, which could help in formulating adequate, efficient, and robust regulations. Israel threatens to strike Iran directly if Iran launches attack from its territory

JERUSALEM, April 10: Israel's foreign minister threatened on Wednesday that its country's forces would strike Iran directly if the Islamic Republic launched an attack from its territory against Israel, as tensions between the rival powers flare following the killings of Iranian generals in a blast at the

Iranian consulate in Syria. "If Iran attacks from its territory, Israel will respond and attack in Iran," Israel Katz said in a post on X in both Farsi and Hebrew. The remarks came after Iran's Supreme Leader Ayatollah Ali Khamenei reiterated early on Wednesday a promise to retaliate against Israel over the attack on its consulate in Damascus earlier this month

Biden says Netanyahu's approach to the war is a mistake, deepening a rift between the two allies

TEL AVIV, April 10: US President Joe Biden called Prime Minister Benjamin Netanyahu's handling of the war in Gaza a mistake and called for his government to flood Gaza with aid, ramping up pressure on Israel to reach a cease-fire and widening a rift between the two staunch allies that has worsened as the war has dragged

Biden has been an outspoken supporter of Israel's war against Hamas since the militant group launched a deadly assault on October 7. But in recent weeks his patience with Netanyahu has appeared to be waning and his administration has taken a more stern line with Israel, rattling the countries' decades-old alliance and deepening Israel's international isolation over the war.

The most serious disagreement has been over Israel's plans for an offensive in the southernmost Gaza city of Rafah and the rift has spiraled since, worsened by an Israeli airstrike last week on an aid convoy, which killed seven workers with the food charity World Central Kitchen (WCK), most of them foreigners.

Israel said the deaths were unintentional but Biden was outraged.

Biden's comments, made in an interview that aired late Tuesday after being recorded two days after the WCK strike, highlight the differences between Israel and the US over humanitarian aid to people in Gaza, where a monthslong war has led to warnings of imminent famine.

"What he's doing is a mistake. I don't agree with his approach," Biden told Spanish-language broadcaster Univision.

He was responding to being asked if Netanyahu is prioritizing his political survival over the national interest. Biden said Israel should agree to a cease-fire, flood

beleaguered Gaza with aid for the next six to eight weeks and allow other countries in the region to help distribute

the aid. "It should be done now," he said. Hunger in Gaza is overshadowing the Muslim holiday of Eid al-Fitr, a typically joyous festival during which families celebrate the end of the holy month of Ramadan.

Israel halted aid deliveries to Gaza in the early days of the war, but under US pressure has slowly increased trucks allowed to enter the territory. Still, aid groups have complained that supplies are not reaching desperate people quickly enough, blaming Israeli restrictions, and countries have attempted other ways to deliver them including air drops and by sea.

Israel says its has steadily ramped up aid throughout the war, opening up more entry points for trucks to enter and to reach especially hard-hit areas like northern Gaza, an early target of Israel's in the war.

Israel blames aid groups for being too slow to deliver aid once it's inside Gaza. Those groups say logistical is-sues and the precarious security situation — underscored



by the WCK strike - complicate aid deliveries.

Israel and Hamas are currently engaged in talks meant to bring about a cease-fire in exchange for the release of hostages captured by Hamas and others who stormed across the border on October 7. But the sides remain far apart on key issues, including the return of Palestinians to hard-hit northern Gaza.

Netanyahu has vowed to achieve "total victory" in the war, pledging to destroy Hamas' military and governing capabilities to prevent a repeat of the October 7 attacks and to return the hostages. He says that victory must include an offensive in Rafah, which Israel says is Hamas' last major stronghold, but more than half of Gaza's 2.3 million people are currently seeking shelter there.

Six months into the war, Israel is growing ever more isolated, with even its closest partner increasingly vocal about its discontent in the war's direction and longtime trading partners like Turkey taking potentially painful economic steps to express dismay.

Netanyahu is under pressure to decide on a postwar vision for Gaza but critics say he is delaying because he doesn't want to anger his ultranationalist governing partners, who support resettling the Gaza Strip, which Israel withdrew from in 2005 and an idea Netanyahu has ruled

Israel launched the war in response to Hamas' crossborder assault, where militants killed 1,200 people, mostly civilians, and took roughly 250 people hostage, according to Israeli authorities.

More than 33,200 Palestinians have been killed in the relentless fighting, according to Gaza's Health Ministry which doesn't differentiate between civilians and combatants in its count but says most of the dead are women and children. Israel says it has killed some 12,000 militants, without providing evidence.

The war has ignited a humanitarian catastrophe. Most of the territory's population has been displaced and with vast swaths of Gaza's urban landscape levelled in the fighting, many areas are uninhabitable. (AP)

SEOUL, April 10: South Korea's liberal opposition parties were expected to win a landslide victory in Wednesday's parliamentary election, initial exit polls suggested, a result that if confirmed would make conservative President Yoon Suk Yeol a lame duck for his remaining three years in office.

The joint exit polls by South Korea's three major TV stations -KBS, MBC and SBS – showed the main opposition Democratic Party and its satellite party were forecast to win combined 178-197 seats in the 300-member National Assembly. They expected anothernew lib-

There was a brief soul-searching about South Korea's divisive politics after Lee was stabbed in the neck in January by a man who, according to police, tried to kill Lee to prevent him from becoming president. But as the parliamentary election approached, the rival parties began churning out abusive rhetoric and crude insults against each other.

Ruling party leader Han Donghoon called Lee "a criminal" and eled his past comments a "trash." Lee's party spokesperson described Han's mouth as a "trash bin." Han accused Lee of using a sexist remark against a female ruling party candidate. During one of his final campaign events on Tuesday, Han argued that giving too many seats to Lee's Democratic Party will throw South Korea into political turmoil. "Tomorrow's 12 hours will determine whether the Republic of Korea will plunge into shocking chaos and despair or overcome a crisis," Han said, using South Korea's official name. Speaking ahead of his corruption trial at a Seoul court, Lee urged voters to punish the Yoon government, which he said has used prosecutors to suppress opponents. "I earnestly ask you to hand out your judgement on a government that betrays and goes against the people," Lee said. (AP)

Russia's second attempt to launch a heavy-lift rocket from Far East is aborted

MOSCOW, April 10: Russia's second attempt to test-launch a new heavy-lift rocket from its Far Eastern space complex was aborted on Wednesday. The launch of the Angara-A5 rocket from the Vostochny spaceport was cancelled about two minutes before its planned time of 0900 GMT. State news agency RIA-Novosti said the cause was failure of the pressurization system of the oxidizer tank of the central block of the rocket.

National space agency Roscosmos said another launch attempt will be postponed for at least one day. The first attempt on Tuesday also failed because the automatic safety system registered a flaw in the oxidizer tank pressurization system, said Roscosmos head Yuri Borisov

The launch was to be the fourth for the Angara-A5, a heavy-lift version of the new Angara family of rockets that has been developed to replace the Soviet-designed Proton rockets. The previous three launches were carried out from the Plesetsk launchpad in northwestern Russia.

After the 1991 breakup of the Soviet Union, Russia leased the Baikonur Cosmodrome from Kazakhstan and continued to use it for most of its space launches. The agreement with Kazakhstan allows Russia to keep leasing Baikonur for \$115 million a year through 2050.

EU lawmakers will decide on migration law overhaul, hoping to deprive the far-right of votes

BRUSSELS, April 10: Lawmakers are to vote later on Wednesday on a major revamp of the European Union's migration laws, aiming to end years of division over how to manage the entry of thousands of people without authorization and deprive the far-right of a vote-winning campaign issue ahead of June elections.

Members of the European Parliament will vote on 10 reform topics that make up the Pact on Migration and Asylum. The regulations and policies lay out who should take responsibility for migrants when they arrive and whether other EU member states should be obliged to help. The plan was drawn up after 1.3 million people, mostly those fleeing war in Syria and Iraq, sought refuge in Europe in 2015. The 27-nation bloc's asylum system collapsed, reception centers were overwhelmed in Greece and Italy, and countries further north built barriers to stop people entering.

But few say they're happy with the new policy response to one of Europe's biggest political crises, and even the lawmakers who drafted parts of the new regulations are not willing to support the entire reform package."I'm not going to open a bottle of champagne after this," Dutch lawmaker Sophie i'nt Veld, who drew up the assembly's position on migrant reception conditions, told reporters on the eve of the plenary session in Brussels. She plans to abstain from some of the 10 votes. In't Veld described the pact as "the bare minimum" in terms of a policy response, but she does not want to torpedo it by voting against. "We will not have another opportunity to come to an agreement," she said. Swedish parliamentarian Malin Bjork, who worked on refugee resettlement, said that the pact does not respond to "any of the questions it was set to solve." She said the reform package "undermines the individual right to seek asylum" in Europe because it would build on plans that some EU countries already have to process migrants abroad. Italy has concluded one such deal with Albania.

"We cannot have a situation where people systematically, in their thousands, die on their way seeking protection and refuge in Europe. This doesn't do anything about that," Bjork told reporters.

Spanish lawmaker Juan Fernando Lopez Aguilar agreed he wasn't satisfied by the negotiations, but said they were an improvement to existing policies. The lawmaker did not say if he might vote against part of the new plan. The new rules include controversial measures: Facial images and fingerprints could be taken from children from the age of 6, and people may be detained during screening. Fast-track deportation could be used on those not permitted to stay.

"The pact will lead to more detention and de facto detention at the EU's external borders, including for families with children, which is in clear violation of international law," said Marta Gionco from Picum, a network of migrant rights defense organizations.

It remains unclear what will happen to the reform package if lawmakers reject parts of it. The EU's 27 member states would need to endorse the parliamentary vote before the regulations could start to enter force. That could happen by the end of the month. (AP)

JAKARTA, April 10: Muslims around the world celebrated the Eid al-Fitr holiday on Wednesday, marking the end of the Islamic holy month with family reunions, new clothes and sweet treats.

But the celebrations were overshadowed by the worsening humanitarian crisis in the Gaza Strip and Israel's expected offensive in the city of Rafah despite efforts from its Western allies to halt the fighting after six months of war.

In Istanbul, thousands of worshippers gathered at the Aya Sofya Mosque for morning Eid prayers, some carrying Palestinian flags and chanting slogans in support of people in Gaza.

Many laid their prayer rugs in the square in front of the former Byzantine cathedral, which was re-converted to a mosque four years ago, as space inside quickly filled.

In a holiday message, Turkish President Recep Tayyip Erdogan sent support to Gaza, which he called a "bleeding wound on the conscience of humanity."

"I hope that the Eid will lead to peace, tranquillity and wellbeing for our country, our nation, the Islamic world and all humanity," he added.

The war in Gaza was also the focus of prayers at the Rahma Mosque in the Kenyan capital, Nairobi

"We should not forget our brothers and sisters in Palestine," Imam Abdulrahman Musa said. "They have been subjected to unjustified aggression and a lot of violence (as) the world is watching in silence."

In Indonesia, the world's most populous Muslim nation, nearly three-quarters of the population were traveling for the annual homecoming known locally as "mudik" that is always welcomed with excitement.

"Mudik is not just an annual ritual or tradition for us," said civil servant Ridho Alfian, who lives in the Jakarta area and was traveling to Lampung province at the southern tip of Sumatra island.

"This is a right moment to reconnect, like recharging energy that has been drained almost a year away from home.'

Before the Eid al-Fitr holiday, markets teemed with shoppers buying clothes, shoes, cookies and sweets. People poured out of major cities to return to villages to celebrate the holiday with their loved ones. Flights were overbooked and anxious relatives weighed down with boxes of gifts formed long lines at bus and train

stations for the journey. For Arini Dewi, Eid al-Fitr is a day of victory from economic difficulties during Ramadan. "I'm happy in celebrating Eid holiday despite the surge of food prices," said the mother of two.

Former Vice President Jusuf Kalla was among Jakarta residents offering prayers at the Al Azhar mosque yard. "Let's celebrate Eid al-Fitr as a day of victory from many difficulties... of course there are many social problems during fasting month of Ramadan, but we can overcome it with faith and piety," Kalla said. On the eve of Eid al-Fitr, Jakarta residents set off firecrack-



ers on streets that were mostly empty after city residents traveled home

On Wednesday morning, Muslims joined communal prayers shoulder-to-shoulder on the streets and inside mosques. Jakarta's Istiqlal Grand Mosque, the largest in Southeast Asia, was flooded with devotees offering morning prayers. Preachers in their sermons

called on people to pray for Muslims in Gaza who were suffering after six months of war.

"This is the time for Muslims and non-Muslims to show humanitarian solidarity, because the conflict in Gaza is not a religious war, but a humanitarian problem," said Jimly Asshiddiqie, who chairs the advisory board of the Indonesian Mosque Council.

In Pakistan, authorities deployed more than 100,000 police and paramilitary forces to maintain security at mosques and marketplaces. People were shopping as usual Tuesday, with women buying bangles, jewelry and clothes for themselves and their children

In Malaysia, ethnic Malay

performed morning Muslims prayers at mosques nationwide just weeks after socks printed with the word "Allah" at a convenience store chain sparked a furor. Many found it offensive to associate the word with feet or for it to be used inappropriately.

Malaysia's Prime Minister Anwar Ibrahim called for unity and reconciliation in his message on the eve of Eid, saying no groups should be sidelined based on religion or any other reason.

"We must be firm, resolute and unwavering in our commitment to foster values and build a dignified nation." he said. "However, let us not take this as a license or opportunity to insult, undermine, or damage the cultural practices and way of life of others.

The owners of the KK Mart chain and representatives from one of its suppliers were charged with offending the religious feelings of Muslims. KK Mart Group said the supplier sent items the company had not agreed to stock. The supply company founder apologized for being careless in the inspection of the imported items. (AP)





LITTLE JOYS OF RELIEF CAMPS INC election agent lodges complaint Over 180 babies born in shelters for displaced in Manipur

IMPHAL/CHURACHANDPUR, April 10: Cradling her newborn, Hatneu says she has named her baby, born in a shelter for the displaced in Manipur, Nganthoibi which means shining light.

Amid the trauma of 11 months of conflict, violence and continuing uncertainty, for nearly 200 displaced women like Hatneu, who is from the Kuki tribe, who have taken shelter in different relief camps across the state, the period is unforgettable for a different reason -- they welcomed their newborns.

"When I held my twins in my arms, all my miseries melted away," a 26-year-old woman at a relief camp in Kakching district told PTI, requesting not to be identified or photographed.

Her twin boys are now four months old. "When they grow up, I will tell them these stories.

"This is an unforgettable period for me for a different reason and I want to remember it that way years later. I don't want any memory of this period to haunt my children when they grow up," she said.

When she landed at the relief camp, she knew it was going to be very tough. "Pregnancy is a period when we are suggested to take extra care of ourselves, not do any heavy-lifting, not take stress, and eat well. However, for me this period was all about survival.'

The hill state has witnessed sporadic, sometimes intense, ethnic clashes since May 3 last year between the majority Meitei community and Kukis, resulting in loss of over 200 lives. While Meiteis population is concentrated in Imphal city, Kukis have shifted to the hills.

The violence displaced thousands of people, with officials saying more than 50,000 people are living in camps following the unrest. Lu Lamva Ngahjemkim, a Kuki-zo woman, was eight-month pregnant when the clashes broke out in May 2023. She and her family landed at a relief camp in Churachandpur, the epicentre of the violence then.

A month later, she gave birth to her daughter Christy who became the "silver lining in these grim times".

"We were having dinner at home when the clashes broke out and everybody started rushing out... We had to hide in the nearby hills for several hours until the forces rescued us. For once, it felt our world was crashing down... bit by bit we had built our house and livelihood and within a day all was gone," she told PTI.

Nine-month-old Christy has now begun

crawling and is a centre of attention at the relief camp.

PTI visited six relief camps in the Meitidominated Imphal Valley and Kuki-zo dominated Churachandpur district.

Among the women who are counting their blessings in form of their newborns at the relief camps are four who gave birth to twins.

Hatneu, who has found shelter at a different camp in Churachandpur, used to run a bamboo goods shop in Imphal valley earlier. She is in an alien set up, but is loving her motherhood.

"I am a Kuki but I have always lived in the Valley only. Now we were forced to relocate here due to circumstances. Last month I gave birth to my baby at a nearby health facility. I have named my baby girl -- Nganthoibi which means shining light," she said. Hatneu said at leat 15 babies have been

born in that camp.

A dedicated camp set up for pregnant women in Imphal valley saw the birth of 168 babies

The facility, which was opened on May 21 last year, hosted 164 women, who were brought there from different relief camps around the state. The camp was winded up in February when no pregnant women were found in the relief camps in the valley.

"Earlier, pregnant women were staying in the same camps as other women and it was felt they will not get the adequate space and care needed during the period. So a dedicated camp was set up...where 168 children were born between May 2023 till February this year," said Manipur BJP President Sharda Devi who spearheaded the initiative. "We allowed one person to stay with each

pregnant or lactating woman to serve as an attendant while the rest of the family members stayed in other camps," she added.

As Manipur goes through a period of uncertainty, there is an anti-poll sentiment in the state among the displaced.

But the elections for the two Lok Sabha seats in Manipur has been announced alongside the general elections.

They will be held in Manipur in two phases on April 19 and 26. While Inner Manipur and some segments of Outer Manipur will vote in the first phase on April 19, the remaining segments of Outer Manipur will vote in Phase 2 on April 26. Ngahjemkim says she wants to remember this period for the gift she got in her baby. "Despite all odds, my daughter was born here and is healthy today. At a time when I thought none of us would survive... this seems like a miracle," Ngahjemkin says. (PTI)

In a complaint lodged to the Imphal East DEO by an election agent of the INC in the fray from the Inner Manipur Parliamentary constituency on April 7, it is alleged the BLO of Chingmeirong Mamang Leikai exerted undue influence while an elderly woman cast her vote under the special provision for aged senior citizens.

The agent alleged that the BLO insisted the 93-year-old woman cast her vote in favour of the candidate listed as sl. No. 2. The said BLO further told her that she would be rewarded with money to buy fish. Pertinently, the candidate in the sl. no. 2 is Thounaojam Basanta Singh of Bharatiya Janata Party

(BJP). The agent, in his complaint, drew the attention of the DEO to take up necessary action to ensure free and fair election.

Meanwhile, Manipur Pradesh Congress Committee (MPCC) has filed a formal complaint with the Election Commission of India as well as the Chief Electoral Officer (CEO) Manipur on violation of election Model Code of Conduct by the incumbent government in the state. In the complaint, the MPCC despite the enforcement of the model code of conduct, the state government continued to issue notification for filling up vacant posts in the government departments.

It alleged that Bishnupur district employment exchange on March 28 issued a notice for sponsoring of filling 1140 posts of pre-primary teachers on contract basis under the Directorate of Education (S) Manipur government.

The Social Welfare department also issued a notice on April 1 regarding extension of last date for application form submission for availing financial assistance under 'Ima Nongthangliema Yaipha Tengbang Scheme" for women, the MPCC pointed out.

BJP changed public perception towards politicians, politics: Rajnath Singh

SAHARANPUR/BULAND-SHAHR (UP), April 10: The BJP has changed the public's perception that politicians speak lies to seek votes, Union defence minister Rajnath Singh said on Wednesday and asserted "it is our character that we do what we say".

Speaking at a campaign rally for the BJP's Saharanpur candidate Raghav Lakhanpal, he said, "A few years ago, there was a perception that politicians speak lies to seek votes and go away. They don't care about the public or the nation. This was the common perception towards politicians and political parties."

"We have changed this perception. It is our character that we do what we say. Earlier, it was the norm to think that a politician would lie but we changed this perception," Singh added.

The defence minister said political parties make big promises in their manifestos but forget those after assuming power.

"We have overcome the crisis of confidence in politics. We had promised to revoke Article 370 and we did it after assuming power. We had promised to abolish triple talaq and we did it after getting a majority in Parliament," he said.

Singh, a former Uttar Pradesh chief minister, said the perception of India has improved under Prime Minister Narendra Modi.



He claimed that Modi "halted" the war between Russia and Ukraine to ensure safe passage for Indian students stuck in the war-torn country.

"In Qatar, retired Navy personnel awarded capital punishment were released after being pardoned by the government there. This shows the stature of India in the world," he added.

Qatar released eight jailed former Indian Navy personnel 46 days after their death sentences, handed out last October, were commuted to jail terms of varying duration. Under Modi's leadership, India --



BJP represents 103 Lok Sabha seats where forests rights is key issue, says report

NEW DELHI, April 10: BJP MPs represent 103 of the 153 Lok Sabha seats in the country where the implementation of the Forest Rights Act 2006 is a major issue, according to a

The Congress, which enacted the FRA, and the Biju Janata Dal represent 11 seats each, Shiv Sena 6, Telangana Rashtra Samithi and YSRCP 5 each, and the National Congress Party 4, the analysis by independent organisation Vasundhara found. Considered a milestone in redressing the historical injustice done to Scheduled Tribes and other traditional forest dwellers, the Forest Rights Act 2006 aims to recognise forest rights of such communities living in forests for generations.

According to the analysis, there are 86 Lok Sabha seats where people demanding forest rights account for over 30 per cent of the electorate.

Similarly, there are 45 seats where FRA eligible voters comprise over 40 per cent of the electorate. These include the Khunti Lok Sabha seat where the Bharatiya Janata Party (BJP) has repeated Tribal Affairs Minister Arjun Munda as its candidate. Out of the 153 core FRA constituencies, the BJP and the Congress ran directly against each other in 74 constituencies in the 2019 Lok Sabha elections, of which the Congress won only 5.

There are 47 ST reserved seats in India, out of which 42 are core FRA constituencies. The BJP won 31 ST seats in 2019 and the Congress only 3. According to government data, the FRA claim disposal rate in the



last five years has come down from 87.72 per cent to 84.44 per cent. While 7,88,948 new claims were filed in the last five years, 5,21,143

titles were distributed, and 5,827 claims were rejected during this period. A total of 50,26,801 claims (48,36,013 individual) have been filed until February 29, 2024. Of this, 24,85,191 titles (49.44 per cent), including 23,70,011 individual titles, have been distributed, the official data showed.

Five years ago, the total number of claims filed stood at 42,37,853 (40,89,035 individual), and the number of titles that had been already distributed stood at 19,64,048 (18,87,894 individual).

While officials say the Covid-19 pandemic hampered the implementation of the Forest Rights Act 2006, which recognises rights of forestdwelling scheduled tribes and other traditional communities, in 2020 and 2021, experts said lack of political will and corruption is the primary out a livelihood. obstacle. Over 50 per cent of the claims filed so far in eight states and Union territories, including Uttarakhand, Uttar Pradesh, Bihar, Karnataka, West Bengal, Jammu and Kashmir, Madhya Pradesh, and Rajasthan, have been rejected, according to the official data.

At 97.23 per cent, the claim rejection rate is the highest in Uttarakhand, where a total of 6,678 claims have been filed so far but only 185 titles distributed. Chhattisgarh has rejected the highest number of claims -- 4,00,649 out of the total 9,41,977 received so far.

Karnataka has rejected 2,53,269 or 86.01 per cent of the 2,94,489 claims filed so far. A Delhi-based organisation which studied the implementation of FRA in five states in the country recently said even where individual forest rights have been recognised in Karnataka, the actual land allocated on average is 0.8 acres - which is too small an area to eke

NEW DELHI, April 10: Delhi minister Raaj Kumar Anand on Wednesday resigned from the cabinet and quit the AAP, alleging Dalits were not given representation in the party.

Addressing a press conference here, Anand, who was holding various portfolios including Social Welfare, alleged that there was no Dalit among the top leaders of the Aam Aadmi Party (AAP).

"This party doesn't respect Dalit MLAs, councillors and ministers. In such circumstances, all Dalits feel cheated. We live in an inclusive society, but it is not wrong to talk about proportion. It is difficult for me to remain in the party with all these things, hence I am resigning from the post." Anand said.

He also took a swipe at Delhi Chief Minister Arvind Kejriwal who is in Tihar jail after being remanded in judicial custody in an excise policy-linked money laundering case and has failed to get any relief from the Delhi High Court.

"From the Jantar Mantar, Arvind Kejriwal had said that the country will change once politics changes. The politics hasn't changed but the politician has changed," Anand, who is an MLA from the Patel Nagar constituency, said.

BJP: CPI(M) threatening Kerala MGNREGA workers to attend rallies

THIRUVANANTHAPURAM, April 10: The BJP on Wednesday accused the ruling CPI(M) in Kerala of denying jobs to MGNREGA labourers for not attending party programmes. Senior BJP leader and former union minister Prakash Javadekar lashed out at the Marxist party, alleging that it was threatening the laborers that their jobs would be taken away if they didn't attend the party's rallies. "CPM politics in Kerala.. It is threatening MNREGA workers that their jobs would go if they don't attend the CPM rally. Such tactics won't work this time. Voters are awakened. They know what Modi is doing for them. Voters are King at the polling station," he posted on 'X'.

Javadekar's criticism came in the wake of reports in a section of the media that nearly 10 women, employed under the MGNREGA, had been denied jobs in Punnapra North village panchayat in Alappuzha. One of the women workers told a television channel that they were asked to attend a meeting held in a nearby house on Sunday.

"We were told that it was a labour meeting. When we reached there, we understood that it was a party programme of the CPI(M). So, nearly 10 of us, including me, didn't attend it," a woman labourer told a TV channel on Wednesday. She also alleged that she and others who didn't attend the meeting were asked by authorities not to come for the daily job, despite being enrolled for it. The woman said they lodged a complaint with the panchayat secretary. The link to the video of the news report was attached to by Javadekar on his post on X. The CPI(M) has not reacted to the allegations. (PTI)

Cong creating north-south divide to break India: Shah

GAYA (BIHAR), April 10: Launching a blistering attack on the opposition INDIA bloc, Union Home Minister Amit Shah on Wednesday accused the Congress of creating a north-south divide to break the country. Addressing an election rally in Guraru block of Gaya district, he also accused the Congress and the RJD of indulging in the politics of appeasement. "The Congress party is creating a north-south divide to break the nation which the NDA-led Central government and people of

the country will not allow. Their leader Rahul Gandhi is maintaining a stoic silence on this," Shah said. People of this country have now made up their mind to give a befitting reply to such divisive forces in the Lok Sabha polls and will ensure 400 plus seats for the NDA, he added. NEW DELHI, April 10: Nationhood is constituted by people who share a "common sense of their history" and a "common vision of their future", National Security Advisor Ajit Doval said as he released an 11volume book series that charts different phases of the history of ancient India and its accomplishments.

Addressing a gathering at the launch event here on Tuesday, the NSA said, "People who have got a different sense of history, 'if my hero is your villain', you and I cannot make a nation. Describing India as a "civilisation

of antiquity" and "civilisation of continuity" spanning thousands of years, Doval also said that it was a "paradox" that the narrative that has

been brought is that probably, "the first chapter about Indian history in any western, this thing ... is that it starts with Alexander". After releasing the series 'History

of Ancient India', published by Vivekananda International Foundation (VIF) and Aryan Books, he said it consists of scholarly papers contributed by a "large body of scholars"

Vol I of the series, which covers a vast array of fields, is titled 'Prehistoric Roots' while Vol IX is on 'Science and Technology, Medicine'. Doval said while discussing the project during its inception phase several years ago with S Gurumurthy, VIF chairperson, he had

shared the "new idea and thinking" to contribute to something that would be able to give a "new sense of identity and pride, not only to our countrymen but also to our coming generations'

"Our self-image, our identity is deeply connected to your own perception of history, and... perception of what you are," the NSA said.

He described the series as not an end, but a "means to an end", and the end objective is to build "a nation on the basis of a sense of common heritage, of common background from which we come from, having pride in our ancestry and achievements of the past, and having a vision for the future"

Earlier in his speech, Doval said nations or members of nationhood are "those people who share a common sense of their history, common sense of our ancestors, common sense of their achievements of their past, and a common vision of their future. All those who believe in that they make one nation. People who have got a different sense of history, 'if my hero is your villain', you and I cannot make a nation".

He said the research papers are of "very high quality" and "great references" have been quoted.

There are a few aspects about Indian history that nobody questions, including "our detractors", he said. "One is its antiquity, that it is one of the oldest civilisations, and probably a human life had evolved, and



society had perfected to a very high (level). Now, who did it? Were they the original people or they came from outside?

"There may be a bias about that but they will all say that this is a civilisation of antiquity. The second is its continuity. It has been continuing for thousands of years without disruption. And, the third feature, its vast expanse, where the footprint of the civilisation was very visible," he added.

On Alexander's connection with India, Doval cited William Jones and

said that he was a big Sanskrit scholar who said that "nowhere in Sanskrit or Pali or Prakrit literature or local dialects, he could find any mention of Alexander". There is "no

mention", the NSA added. It was a "non-event, it was a very small event of history" where some raiders on horseback, probably wanted to plunder, but faced resist-

ance and returned. "But you make such a mountain of it as if the world history has changed with Alexander the great conqueror," he said.

But, there was another reason --Indians' mindset. "For us events and personalities were very secondary.' Doval said.

"Now, this combination of these factors deprived us of our own existence and identity. And history is important for your identity," he said.

Doval said anything that scholars have quoted or any inference drawn in this work is based on a "solid, scientific foundation".

"When we started the project, we said, let it be totally authentic, we don't want to generate propaganda material. The foundation of such kind of intellectualism does not have a long shelf life," he said.

The volume is "bulky and expensive" and so its dissemination is a bit constrained.

He said Prime Minister Narendra Modi was presented this work and told about it, and it has found "a place of prominence in his library".

The prime minister suggested that these can be donated to libraries and that idea is still there.

NEW DELHI, April 10: "We will rip you apart", the Supreme Court warned the Uttarakhand State Licensing Authority on Wednesday slamming it for inaction over misleading advertisements issued by Patanjali Ayurved.

The apex court said the Authority remained in "deep slumber" and there was a clear attempt by it to "pass the buck" and somehow delay the matter despite it being informed about the misleading advertisements.

'Why should we not think that you were in cahoots with the contemnor respondents and you were keeping your eyes shut deliberately?" a bench of justices Hima Kohli and Ahsanuddin Amanullah told the counsel appearing for the

was "equally complicit" in light of the same inaction during his tenure.

It said the Authority has filed a detailed affidavit before the court trying to explain the action taken by it on the central government corresponding with the Authority regarding objectionable advertisements of AYUSH products manufactured by Divya Pharmacy.

"The disdain shown by Divya Pharmacy to the repeated notices of show cause issued by the State Licensing Authority is apparent from the tone and tenor of their reply...," it observed.

The bench said it appeared that if the court would not step in, the Authority would abdicate its duties under the statute and await an order from the apex court for implementation of the Drugs and Magic Remedies (Objectionable Advertisements) Act. 1954.

"Besides the proposed contemnors, we are inclined to issue notices of contempt to the deponent of the affidavit (filed by the Authority) as also his predecessor. However, we are refraining from doing so in the present...," it said.

It said the Centre had clearly told the state Authority in 2020 to stop the objectionable advertisements

It said the predecessor of the incumbent joint director of the authority shall file an affidavit explaining the inaction on his part during his tenure. The bench also directed that the district Ayurvedic and Unani officers, Haridwar, who were posted from 2018 till date shall also file affidavits explaining the inaction on their part.

CBSE to launch pilot for national credit framework for classes 6,9 and 11

NEW DELHI, April 10: The CBSE will launch a pilot of the National Credit Framework for classes 6, 9 and 11 from the 2024-25 academic session and has invited its affiliate schools to participate, officials said on Wednesday.

The government last year launched the National Credit Framework (NCrF) as part of the implementation of the National Education Policy (NEP), 2020, to ensure seamless integration of school, higher and vocational education, and allow students to accumulate their credits from the pre-primary to the PhD level.

Subsequently, the Central Board of Secondary Education (CBSE) also developed its draft guidelines to implement the framework.

'The CBSE developed and circulated draft NCrF implementation guidelines, discussed them in multiple workshops, and received approval from the Union Ministry of Education. To further test, refine and assess their effectiveness in real-world contexts, a pilot implementation of these guidelines has been planned in schools affiliated to CBSE in classes 6, 9 and 11, with effect from session 2024-2025," the board said in a letter to school principals.

"Principals of interested schools for this pilot programme are requested to share their contact details through the link (https://forms.gle/5AB2iuxa1k62r2E3A)," it said.

Various railway unions and drivers' associations say that the vacant posts result in an increase in duty hours of the existing strength of crew as they have to compensate for the vacant posts as well.

"This is increasing work pressure and stress on drivers which is not in the interest of safe train operations," Shiv Gopal Mishra, general secretary, All India Railwaymen's Federation, said.





LOS ANGELES, April 10: British star Kit Harington has revealed that a spinoff series based around his "Game of Thrones" character Jon Snow is no longer in development as the team couldn't find the right story.

Harington rose to global stardom with his performance as Jon Snow, a brooding warrior and one of the pivotal characters, in the HBO epic fantasy show that ended in May 2019 after eight seasons.

It was reported in June 2022 that HBO was developing a Jon Snow spin-off with Harington in talks to reprise the role.

In a new interview with ScreenRant while promoting his movie "Blood for Dust", Kit Harington revealed that the spinoff centered around Jon Show is "off the table" and no longer in development at HBO, Variety reported.

"I hadn't really ever spoken about it, because it was in development," Harington said. "I didn't want it leaked out that it was being developed. I didn't want the thing to happen where people kind of start theorizing, getting either excited about it or hating the idea of it, when it may never happen. Because in development, you look at every angle, and you see whether it's worth it," he said. "And currently, it's not. Currently, it's off the table, because we all couldn't find the right story to tell that we were all excited about enough," he continued. "So, we decided to lay down tools with it for the time being. There may be a time in the future where we return to it, but at the moment, no. It's firmly on the shelf," Harington added.

News broke in June 2022 that Harington was set to return to his iconic "Thrones" role, which earned him two

Emmy nominations (one for supporting actor and another for lead actor in a drama series).

"It was Kit Harrington who brought the idea to us," author George R.R. Martin later confirmed in a blog post. "I cannot tell you the names of the

writers/showrunners, since that has not been cleared for release yet but Kit brought them in too, his own team, and they are terrific."

"Game of Thrones" concluded with Jon Snow's exile from Westeros as he rides into the Haunted Forest with his direwolf Ghost and the Wildlings to begin a new life. Many fans assumed the spinoff series would pick up with Snow's adventures with the Wildlings. (AGENCIES)

Superb Sreejesh fails to save India from losing 1-2 against Australia

PERTH, April 10: Veteran goalkeeper PR Sreejesh's heroics went in vain as India squandered a goal lead to go down 1-2 against Australia in the third men's hockey Test to hand the home team an unassailable 3-0 lead in the five-match series here on Wednesday.

The Indians, who lost 1-5 and 2-4 in the first two Tests, produced a much-better show on Wednesday with the defensive unit leading from the front.

It was a classic battle between the ever-attacking Australians against the Indian defence, which the latter narrowly lost eventually.

India took the lead through Jugraj Singh's penalty corner conversion in the 41st minute, but Jeremy Hayward (44th and 49th) dashed the visitors' hopes by scoring a brace to hand Australia their third win on the trot.

India played cohesively and with a lot more intensity to frustrate the Kookaburras, who secured as many as six penalty corners in the opening quarter but failed to get past the resolute defence of the visitors.

Credit must go to both Indian goalkeepers -- Sreejesh and Krishan Bahadur Pathak -- for their brilliant display in the first half. It was the hosts who had the first scoring chance in the form of a penalty corner in the fourth minute but Sreejesh made a lovely low diving save to his right to keep out Hayward's shot.

Five minutes later, Australia secured three more penalty corners but they failed to get past the 'The Great Indian Wall' in Sreejesh.

MONTERREY (MEXICO), 6 in Tokyo during a preseason April 10: Lionel Messi and Inter Miami will try to overturn a 2-1 deficit from the first leg when they play Monterrey on Wednesday night for a spot in the CONCA-

CAF Champions Cup semifinals. Messi missed last week's first leg of the home-and-home, totalgoals series. The eight-time Ballon d'Or winner returned from a hamstring injury that had sidelined him since a March 13 Champions Cup match against Nashville to play the second half of last Saturday's Major League Soccer game at Colorado, scoring once in a 2-2 draw.

"He is fine. He felt good after playing 45 minutes last Saturday. We still have today's practice, but apparently the injury is behind him," Miami coach Gerardo Martino said Tuesday. "That's the most important thing. Never mind tomorrow's match. The season is just beginning for us, and we need healthy players.'

The match sold out in just a few hours and asking prices for resale

tickets ranged from \$450-\$1,900. "Leo's presence transcends any situation, people love football, and we knew something like this could happen," Martino said. "This is what happens when you have the best player in the world."

Messi did not speak to media. He has held only two media availabilities with Inter Miami since signing with the team last July 15: on Aug. 17 in Florida and on Feb.



Paris Olympics track and field gold winners to get USD 50,000: World Athletics

MONACO, April 10: In a first for an Olympic sport, gold-medallists in 48 athletics events of this year's Paris Games will be awarded USD 50,000 by World Athletics, which will widen the spectrum by giving prize money to all three medal winners at the 2028 Los Angeles edition. India is hoping for a gold medal in Paris

from reigning Olympic champion Neerai Chopra, who finished on top in the Tokyo Games. He became the first Indian track and field athlete and second overall in individual sports to win a gold in the Olympic Games.

With the landmark decision announced on Wednesday, World Athletics (WA) will become the first international federation to award prize money at an Olympic Games.

"World Athletics ... will become the first international federation to award prize money at an Olympic Games, financially rewarding athletes for achieving the pinnacle of sporting success, starting at this summer's Olympic Games in Paris," WA said in a statement. World Athletics President Sebastian Coe said the introduction of prize money for Olympic gold medallists was a "pivotal moment" for the international body and the sport of athletics as a whole.

Self-belief, hard work at domestic level matter a lot: Shashank on unknown players' success in IPL

MULLANPUR, April 10: Self-belief and the rigours of domestic cricket are the reasons behind lesser-known players' success in the ongoing Indian Premier League, said Punjab Kings cricketer Shashank Singh, who made yet another statement with the bat against Sunrisers Hyderabad here.

Chasing 183 for victory, Shashank smashed an unbeaten 46 off 25 deliveries to nearly pull off another heist for PBKS partnering Ashutosh Sharma (33 off 15 balls) but the team fell short by two just runs on Tues-

Shashank's plucky innings came on the back of an unbeaten 61, which had helped PBKS pull off a thrilling three-wicket win against Gujarat Titans on April 4 in a high-scoring match.

Despite the loss, Shashank received praise from all quarters for showing faith in his abilities.

'You can say these players are unknown but they are known players in the domestic circuit. They did well in the domestic circuit and their performances in IPL are a reward of that (hard work). You need to continue your domestic performance here. Cricket is a game of self-belief at this level," he added.

Shashank looked visibly disappointed after the loss.

"We lost the match by two runs but the most painful thing is to lose a match because we play to win. A defeat is a defeat whether it is by two runs or 20 runs. I must credit Ashutosh for turning the match, the way he batted in the last over. We had belief till the second-last ball that it is possible," Shashank said.

"We did a lot of match simulation in the camp before the IPL. We (Ashutosh and I) used to shuffle between 5 and 6 in the batting order. We had been given a lot of scenarios like 60 or 70 off five overs and we chased that target a lot of times. So we always had the belief."

SRH batter Abdul Samad praised Player of the Match Nitish for his effort with both the bat and the ball. The 20-year-old, after scoring a halfcentury, also took the crucial wicket of Jitesh Sharma.

"Last year Nitish played conventional shots but this year he is totally different. He has had a good preparation. Everyone had confidence in him and that's the reason he was promoted," said Samad.

Asked about lesser-known players giving impactful performances, Samad said, "First season for them, so they have got nothing to lose and they are eager to perform. They look very hungry." (PTI)

Was sidelined with three injuries, worked to become better version of myself: Suryakumar

MUMBAI, April 10: India and Mumbai Indians batter Suryakumar Yadav on Wednesday revealed that he battled three different injuries in the past three months but worked hard to become a "better version" of himself while going through a "boring" recovery process.

The world No.1 T20 batter, who made his comeback last week in the Indian Premier League, revealed that apart from sports hernia for which he had to undergo a surgery and an ankle problem, he also endured an injury to his right knee.

"I had two-three niggles together, sports hernia, ankle and then right knee. I had to take one step at a time, follow the small things and here I am, really happy to be on the ground," Yadav said

in a video released by IPL. The 33-year-old said it was "boring" for him to follow the same routine during rehab work at the start but he decided to make the most of the opportunity.

"It's actually a little difficult to describe the last three (or) threeand-a-half months. It was difficult, the first two-three weeks, because I felt (it was) very boring doing the same things again and again (in) the rehab," he said.

"But (by) the fourth-fifth week, I realised that it is important going forward.'

A conversation with his wife was helpful in giving him perspective.

"When I spoke to my wife and all the people at NCA, they said it has to be a second version of yourself, you have to be a little

different when you come back on the field. I started doing all those small things like sleeping on time, following a good diet — that was most important," he added.

Yadav said time away from the game helped him focus on aspects he had neglected and that helped him recover faster. "I (had) never read a book in

my life and I started doing that as well. Getting up in the morning, spending a good quality time at the rehab centre and focusing on everything, connecting myself, my brain and my body with the rehab and it helped me really well to recover a little faster," he said.

"I wanted to be a better version of myself, when I got injured, I realised what were the things I wanted to work on. I got 2-3



months to work on myself in terms of fitness and on my body as well," he said.

'SKY' lauded the coaches and staff at the National Cricket Academy in Bengaluru for understand-

ing and supporting him in his recovery phase, even when he did not like the grind.

"I am really grateful to the support staff at NCA, everyone, right from trainers to physios who took care of me right from the morning. They took everything, whatever I said.

"A few days I was feeling angry to do the rehab but then they took that in their stride and understood really well how I wanted to work," he said.

Yadav, who had faced trouble clearing his fitness tests at NCA at the initial stage of this IPL, said he never felt he was not around the Mumbai Indians' team.

"My whole cricketing journey started from here and when I entered the hotel and the ground, it never felt (like) that I (had) left this place," he said.

"The first day when I did my practice session with the boys and everyone around, it felt that I was here since the IPL started."

However, Yadav admitted he could not watch IPL matches since he followed a strict routine.

"It is always difficult when your team is playing and you are sitting in the room and watching. I cannot say that I did not watch the games, I watched half of the games as I was sleeping on time when I was in Bangalore, at about 10:30pm-10:45pm," he said.

"It was difficult but at the same time, it gave me a lot of motivation and inspiration that yes, they are playing there and I have to work really hard on myself and my recovery and get there as soon as possible," he added. (PTI)
