# 19 traditional crafts, products of Assam get GI tag

13 products linked to Bodo people • A big win for state's heritage: Himanta

GUWAHATI, March 31: As many as 19 traditional products and crafts of Assam, including 'Bihu Dhol', 'Jaapi' and several items of the Bodo community, have been accorded the geographical indication (GI) tag, chief minister Himanta Biswa Sarma said on Sunday.

Thirteen of these products are specifically linked to the Bodos, who form the largest tribal group in the state. Terming it a big win for the state's heritage, Sarma wrote on X: "Six prestigious GI Tags have been granted to traditional crafts with support from NABARD, RO Guwahati, and facilitated by Padma Shri Dr Rajani Kant, GI Expert".

'This includes iconic items like Bihu Dhol, Japi, Sarthebari Metal Craft, and more. These products, deeply rooted in history, support nearly one lakh people directly," he said. Japi is a traditional bamboo

hat and Bihu Dhol a traditional drum played during Bihu festival.

The applications for the GI tags for the six products were filed in the latter part of 2022 and the certifications were announced on Sat-Assam Asharikandi Terracotta Craft, Assam Pani Mateka Craft, Sarthebari Metal

loom Products are the other products that received the GI tags.

In a separate post on X, Sarma said 13 products of the Bodo community have also obtained this unique certification. "What a better day than Bodofa's birth anniversary to receive the GI tags for 13 articles which embody the rich cul-

nity. This recognition will greatly boost the promotion of the items and in taking forward the legacy of these cultural items," he said.

Late Upendranath Brahma, a leader of the community, was honoured with the title of 'Bodofa' (guardian of the Bodos). Sarma also shared a post by Bodoland Territorial Region (BTR) chief Pramod Bodo, which makes mention of the GI tags.

"Today is a day of immense pride for all of Bodoland, as on the birth anniversary of Bodofa U N Brahma, 13 articles that embody Bodo identity have received the prestigious GI Tag from Geographical Indication Registry, Govt of India," he said. The 13 items that have received the GI tag include three agricultural products -Gongar Dunjia, Keradapini and Khardwi – and six musical instruments - Kham, Serja, Thorkha

### Banned UNLF (P) delaying surrender of cadre, weapons despite ceasefire agreement: Officials

NEW DELHI/IMPHAL, March 31: The United National Liberation Front (P), a banned terror group, has failed to surrender weapons or provide a list of its members despite signing a ceasefire agreement with the Centre four months ago, officials said on Sunday, amid concerns by security agencies that its cadre were still carrying out violence in Manipur.

Even after three rounds of talks with state authorities, the UNLF, the first Meitei terror outfit to agree to a ceasefire, has not complied with the agreed terms since the agreement was inked on November 29 last.

Concerns have been raised by security agencies over the ongoing violence in Manipur attributed to UNLF (P) members despite the ceasefire.

Led by Kh Pambei, the UNLF (P) made history by becoming the first Meitei armed group in the Imphal Valley to engage in a ceasefire agreement with the gov-

ernment, pledging to renounce violence.

The UNLF(P)'s demand for camp establishment near Kuki-populated areas was resisted by security agencies, fearing a potential escalation in ethnic conflicts that have already resulted in over 200 casualties in the state. Temporary camp arrangements have been approved in Ingourok in Thoubal district and agriculture town, Kakching Khunou, in Kakching district, the officials said.

Security agencies rejected the UNLF's objection to the presence of central paramilitary forces at the camps as also setting up camps on the foothills. Officials urged the UNLF to surrender weapons and provide a list of members for relocation.

Recent reports indicate that UNLF members are establishing camps near Kuki settlements to target tribal



populations, fostering tensions.

Despite the ceasefire agreement's intent to halt hostilities, recent incidents show UNLF (P) members are carrying out violent activities with impunity, even looting arms from security forces, the officials said.

According to reports, the cadre of the banned terror group were allegedly involved in looting arms and ammunition from the 5th India Reserve Battalion (IRB) at Chingarel in Manipur East on February 13 and opening fire at Moirangpurel on vehicles heading towards Churachandpur last month.

The unrest escalated when reports claimed that a shooting incident in Maphou village, predominantly inhabited by the people of the Kuki ethnicity, was carried out by individuals allegedly associated with the Arambai Tenggol and UNLF (P) cadre. These cadre of UNLF (P) were reportedly providing live updates on social media while claiming to target (CONTD. ON PAGE-2)

The ruling party also hit back at Rahul Gandhi over his "match-fixing" accusation against Prime Minister Narendra Modi as it cited the decision of the then Indira Gandhi government in 1974 to hand over Katchatheevu island to Sri Lanka to accuse the Congress of compromising the interests of Tamil Nadu and the country

BJP spokesperson Shehzad Poonawalla said, "Some people are talkmising the country's national interest and interest of the people of Tamil Nadu, handed over Katchatheevu island to Sri Lanka to benefit the Congress' first family...Rahul Gandhi ji, your family had done a deal-fixing.

Addressing a press conference here, Poonawalla slammed the Congress over Gandhi's claim that the entire country will be on fire if the BJP returns to power as it seems to amend the Constitution. Divisive politics is in the "DNA" of the main opposition, he alleged.

Earlier, another BJP spokesperson and Rajya Sabha member, Sudhanshu Trivedi, attacked the opposition rally as its leaders began

gathering at the famous Ramlila Ground here in a show of unity to galvanise people's support amid investigation agencies' action against several constituents of the INDIA bloc. **NEW DELHI, March 31:** The money trail of the alleged ₹45 crore kickbacks generated from the Delhi ex-

cise policy "scam" and used for the 2022 Goa election campaign by the Aam Aadmi Party (AAP), as claimed by the Enforcement Directorate, has also been "substantiated" by the CBI and the Income-Tax department in their separate investigations, according to documents filed in court.

A wide network of Hawala operators and 'Angadiyas' are also being investigated by the ED in this case where it recently arrested Delhi chief minister Arvind Kejriwal

and claimed he and his political outfit are liable to be prosecuted in the alleged laundering of these funds. Statements of five 'Angadiya' firm operators have

also been recorded by the ED to establish the "money trail" of this alleged ₹ 45 crore bribe amount. 'Angadiyas' are informal courier and bank services like Hawala which are especially used by diamond and jewellery sector businesses to transfer big cash amounts and other valuables by skirting the KYC-based formal banking route in order to avoid government taxes and duties.

Former Telangana chief minister K Chandrashekar Rao's MLC daughter K Kavitha, former Delhi deputy CM and AAP leader Manish Sisodia and AAP Rajya

Sabha MP Sanjay Singh are among the 16 prominent persons arrested in this case by the agency

The AAP and its leaders have repeatedly denied the charges of wrongdoing, with Kejriwal alleging that the case was concocted by the BJP-led Centre to create a "smokescreen" to project AAP as a corrupt party. The party has alleged that statements of other people

KATHMANDU, March 31: Nepalese and Indian Sanskrit scholars have proposed to organise an International Sanskrit Conference every year and set up a study centre to conduct research and arrange publication of Sanskrit scriptures, especially the manuscripts found in the Himalayan nation.

Adopting a five-point resolution at the end of a three-day Nepal-India International Sanskrit Conclave in Kathmandu, the participants also adopted a resolution to provide support for the development of gurukuls in Nepal with the collaboration of Maharshi Sandipani Veda Vidya Pratisthan, Ujjain, according to a press release.

One of the resolutions mentions that Niti Anusandhan Pratisthan Nepal will function as the head of-



fice of the Nepal-India Sanskrit Study Centre.

The centre will conduct joint research and arrange the publication of Sanskrit scriptures from both

Nepal and India and study Sanskrit manuscripts found in Nepal. It is estimated that there are

around five lakh unpublished Sanskrit manuscripts preserved at

Nepal's Department of Archaeology. One of the resolutions mentions organising a training programme for Nepali Sanskrit students in India to enhance their Sanskrit learning capability, according to the release issued by Niti Anusandhan on Sunday.

As per the resolution, Central Sanskrit University, Delhi, will facilitate libraries of Gurukuls in Nepal and provide necessary books to Sanskrit educational institutions

in Nepal. The conclave also adopted a resolution to promote the religion, culture, philosophy, history and archaeology of Nepal and India alongside the preservation of Sanskrit, Pali and Prakrit languages. The three-day conclave organised by the (CONTD. ON PAGE-2)

# Infosys to receive ₹ 6,329 crore tax refund from I-T department

**NEW DELHI, March 31:** Infosys expects a refund of ₹ 6,329 crore from the Income Tax Department, the country's second largest IT services company said.

It also informed the stock exchanges about tax demand to the tune of ₹ 2,763 crore, citing various assessment orders.

Infosys Ltd said it has received orders from the Income Tax Department for assessment years 07-08 to 15-16, 17-18, and 18-19 during the quarter.

"As per the orders, the company expects a refund of ₹ 6,329 crore (including interest). The company is in the process of evaluating the implications of these orders on the financial statements for the quarter and year ending March 31, 2024," Infosys said in a BSE filing.

Infosys, which competes with TCS and Wipro and others in the market for IT services contracts, is scheduled to declare its financial results for the fourth quarter of the



current fiscal year as well as the full FY24 on April 18.

The Bengaluru-headquartered IT company also said it has received an order for assessment year 22-23 with a tax demand of ₹ 2,763 crore, including interest, and for assessment year 11-12 with a tax demand of ₹ 4 crore, interest included.

nfosys has received assessmen

orders for subsidiaries as well, totalling ₹ 277 crore.

These include assessment orders for assessment years 21-22 and 18-19, respectively, with total tax demand of ₹ 145 crore; order for assessment year 22-23 with a tax demand of ₹ 127 crore; and for assessment year 22-23 entailing tax demand of ₹ 5 crore -- all of them inclusive of interest.

"The company is in the process of evaluating the implications of these orders on the financial statements for the quarter and year ending March 31, 2024 and also evaluating filing appeals against these orders," Infosys said.

Further, a subsidiary of the company has received refund orders under Section 254 for assessment years 07-08 and 08-09 and under Section 154 for assessment year 16-17, it said, adding that the refund amount as per these orders is ₹ 14 crore.

"The company is in the process of evaluating the implications of these orders on the financial statements for the quarter and year ending March 31, 2024. As on March 29, 2024, the above orders cumulatively exceed the materiality criteria as prescribed under Regulation 30 of the Listing Regulations (as amended), and accordingly this disclosure is submitted," Infosys said. # Luxury car sales could breach 50K mark for first time ever: Audi India head

NEW DELHI, March 31: Luxury car sales in India could cross the milestone of 50,000 units for the first time in a year in 2024 amid growing demand for such models, according to Audi India head Balbir Singh Dhillon.

The overall domestic luxury car segment grew by 28 per cent annually last year to record sales volume of around 48,500 units.

Luxury car volumes in India currently account for less than 2 per cent of the overall passenger vehicle sales annually and the sector has been more or less at the same level for the past decade.

"Even if the sales grow by around 10 per cent and we do not face issues like disruptions like issues with global supply chain, we (industry) could cross the 50,000 volume mark in a year for the first time ever in 2024," Dhillon told PTI in an interaction.

Audi reported an 89 per cent growth in retail sales in India at 7,931 units last year as compared to a total of 4,187 units in 2022.

Similarly, Mercedes-Benz India recorded its best-ever year in its history in India with sales of 17,408 units, registering a growth of 10 per cent over 15,822 units in

When asked when the industry volume could touch 1 lakh-unit mark annually, Dhillon said: "This year if we cross the 50,000 unit mark and the growth continues to be double digit in the coming years then we could see it happening."

He noted that the industry growth may moderate a bit this year as compared to 28 per cent recorded in 2023 over 2022.

"This year we anticipate the industry to grow as well but not in high double digit, maybe lower double digit," Dhillion said, adding that the industry faced supply chain challenges hampering sales in the January-March quarter.

On Audi's focus areas for the current year, Dhillon stated that the automaker would like to push sales as it now has a very strong product portfolio in the country.

"That is the first area and we are also looking to expand the sales infra of our pre-owned car business vertical. Last year we had 25 showrooms and by the end of this year we aim to take that figure to 30 outlets," he noted. Besides, customer centricity and sustainable business is another focus area for the company this year, Dhillon said. (PTI)

# RBI to set up Digital India Trust Agency to check illegal lending apps NEW DELHI, March 31: As part of its ef-

NEW DELHI, March 31: As part of its efforts to curb growing cyber fraud, the Reserve Bank is considering establishing a Digital India Trust Agency (DIGITA) to stop the mushrooming of illegal lending

apps.

The proposed agency will enable verification of digital lending apps and maintain a public register of verified apps, sources said.

Apps not carrying the 'verified' signature of DIGITA should be considered unauthorised for the purpose of law enforcement, sources said, adding that this will serve as a pivotal checkpoint in the fight against financial crimes in the digital realm.

DIGITA, once in place, would be entrusted with the responsibility of vetting digital lending apps, they noted.

According to sources, a thorough verification process would help instil greater transparency and accountability within the growing digital lending sector, which has witnessed a surge in fraudulent activities and unscriptulous practices in recent times.

Meanwhile, the Reserve Bank of India has shared a list of 442 unique digital lending apps with the IT Ministry to whitelist with Google.

Besides, Google has removed over 2,200 digital lending apps (DLAs) from its app store from September 2022 to August 2023.

The search giant has updated its policy regarding the enforcement of loan apps on the PlayStore, and only those apps are allowed which are published by the RBI's regulated entities (REs) or those working in partnership with REs.

This policy change by Google has happened at the request of the Reserve Bank of India (RBI) and the Department of Financial Services (DFS) under the Finance Ministry. (PTI)

# Lot of 'onion peeling' for attaining global first: SEBI chief on T+0 settlements

**AHMEDABAD, March 31:** Attaining the global first of T+0 settlement involved a lot of problemsolving and personal discomforts, SEBI chairperson Madhabi Puri Buch has said giving the analogy of "onion peeling" for the achievement.

Speaking at the annual convocation of the Indian Institute of Management Ahmedabad (IIMA) on Saturday, Buch also said the current generation of Indians is on its way to seeing the "high noon"

of the new India. "My colleagues often tell me that problemsolving with me is like peeling an onion. It makes everybody cry in the process. But by the time you are done, peeling layer after layer after layer of the onion, you suddenly realise there is no problem left," she said while addressing students of IIMA as the chief guest of the 59th annual convocation.

Stock exchanges BSE and NSE on Thursday launched the beta version of T+0, or same-day trade settlement on an optional basis for select stocks, which will offer investors an option to transact in 25 securities in T+0 settlement.

"When India became the first large market in the world to move to T+1 settlement, and just two days ago when we went live with an optional T+0 settlement, the process felt pretty much the samelots of onion peeling happened to make for a global first," Buch said.

Notably, Buch is the first woman to head the capital markets regulator-Securities and Ex-

change Board of India (SEBI).

Buch said she doggedly followed the mantra of doing what is right, no matter how hard, and leaving no stone unturned, no matter how hard.

"I believe that at a conscious and a subconscious level, my mantra has been very very simple. Do the right thing, no matter how hard. Leave no stone unturned, no matter how hard. The wonderful thing about this mantra is that eight times out of ten you actually succeed. And the two



times that you don't, you have absolutely no re-

gret," she added.

Buch further said the graduates will discover their own mantra for going forward, which will be the "default setting" within which it is effort-

less for them to operate.

"And until you find that mantra, it is as though you have a quiver full of arrows, some sharp, some not so sharp. And as you aim for the goals that you choose, you may find that your sharp arrows were perfectly well, wonderful, or that you need to sharpen some of your arrows," the SEBI chief said.

She also asked students to not overthink if it feels effortless and enjoyable in their journey. "Just go with the flow," she added.

Buch, however, suggested students probe the nature of their mantra if they face a dilemma about the direction they are taking and whether their mantra is a match for the goals that they are aiming for.

"In today's multi-dimensional and multi-varied world, there is an infinite set of combinations of which mantra can help you achieve which goal. You just need to make sure that you find a fit at a point in time." she said

point in time," she said.

Buch said her generation was very fortunate to

participate in the dawn of the new India.

"Your generation, in my view, is even more fortunate. You are on your way to seeing the high noon of the new India." she added (PTI)

# Adani Group shrugs off Hindenburg effect, back to rapid expansion spree

NEW DELHI, March 31: Adani group opened a \$ 1.2 billion copper plant, bought a port in Odisha, raised stakes in a cement company and stitched an alliance with rival Mukesh Ambani's Reliance Industries, all in a matter of one week in signs that the apples-to-airport conglomerate has shrugged off the Hindenburg effect and is back to rapid expansion spree.

In the last one week, Adani group has through regulatory filings and press statements announced expansions and investments in its mainstay ports business, diversification into metal refining, fund infusion into a two-year-old cement foray and continuing progress in the commissioning of its mega solar project.

It started with the March 26 announcement of Adani Ports acquiring a 95 per cent stake in Gopalpur Port for ₹ 3,350 crore, taking the number of seaports under its control to 15 - the highest with any private firm in the country.

This was followed by Adani En

This was followed by Adani Enterprises Ltd - the group's flagship firm and business incubator - announcing on March 28 the first phase of the world's largest single-location copper manufacturing plant at Mundra in Gujarat, marking the conglomerate's foray into metals refining.

metals refining.

The \$ 1.2 billion (about ₹ 10,000 crore) plant helped India join China and other nations that are rapidly expanding production of copper, a metal crucial for transition away from fossil fuels. Technologies critical to the energy transition like electric vehicles (EVs), charging infrastructure, solar photovoltaics (PV), wind and

batteries, all require copper.

On the same day, group promoter Gautam Adani and his family invested ₹ 6,661 crore in Ambuja Cements to raise a stake in the country's second-largest cement company to 66.7 per cent as



it looked well-positioned to benefit from the country's infrastructure

A day later, Adani Green Energy Ltd - the renewable energy arm of the group - announced the start of operation of its 775-megawatt solar power projects in Khavda, Gujarat. Khavda is the site where it is building a vast solar farm to generate 30 gigawatts of electricity from solar rays as part of its plans to reach 45 GW capacity by 2030.

Also happening on March 28 was Adani and his often perceived rival billionaire Mukesh Ambani collaborating for the first time, when Reliance Industries picked up a 26 per cent stake in Adani Power's Madhya Pradesh power project for ₹ 50 crore and signed a pact to use the plants' 500 MW of

electricity for captive use.

The two businessmen hailing from Gujarat have often been pitted by media and commentators against each other, but they have for years tiptoed around each other to reach the top two rungs of Asia's wealth ladder.

With Ambani's interests across oil and gas to retail and telecom and Adani's focus on infrastructure spanning seaports to airports, coal and mining, they rarely crossed each other's path except in the clean energy business, where the two have announced multi-billion investments.

Adani aspires to be the world's largest renewable energy producer by 2030, while Reliance is building four gigafactories at Jamnagar in Gujarat -- one each for solar panels, batteries, green hydrogen, and fuel cells. Adani is also building three giga factories for manufacturing solar modules, wind turbines and hydrogen electrolysers. A clash was also forecast when the Adani group applied to participate in an auction of spectrum or airwaves capable of carrying fifth-generation (5G) data and voice services. However, unlike

which is not for public networks.
On the contrary, the two have been far from rivals. In 2022, a firm with erstwhile links to Ambani sold its stake in news broadcaster NDTV to Adani, paving the way for the takeover.

Ambani, Adani bought a 400 MHz

spectrum in the 26 GHz band,

The announcements in the last one week are signs that Adani is back on an expansion spree, analysts said. These developments took place 14 months after Hindenburg Research accused the Adani Group of "brazen stock manipulation" and accounting fraud, leading to a stock market rout that erased about \$ 150 billion in market value at its lowest point.

The rout in stock prices following the allegations, which the group denied, cost tycoon Gautam

Adani his position as the world's second-richest man.

In the months following the Hindenburg report, the conglomerate redrew its strategy, including trimming debt through prepayments and repayments of borrowings, paring the founder's share pledge and bringing in promoter

and marquee investor equity.

The strategy seems to be paying off, with the share prices of the 10 listed companies recovering all of the Hindenburg losses.

The group's revenues have continued to grow, helping it reduce debt, meet financial obligations, boost stability and make strategic investments to further its growth and expansion plans.

Adani Group has raised over \$ 5 billion (Rs 41,500 crore) in equity and double of that in debt since the Hindenburg report.

Star investor GQG Partners bought stakes worth almost \$ 4.3 billion in five group companies between March and August 2023, while Qatar Investment Authority (QIA) and French energy giant TotalEnergies poured in \$ 770 million in renewable energy firm Adani Green Energy Ltd, according to company filings and stock exchange data.

Parallelly, the promoters infused \$ 4.6 billion to repay loans against shares, servicing loans taken for cement acquisitions and supporting green investments. Even before last week's announcement, it had been doing mergers and acquisitions (M&As), acquiring Sanghi cement for \$ 431 million, 49.38 per cent in Indian Oil Tanking for \$ 128 million, Karaikal port for \$ 181 million, and Coastal Energen for \$ 420 million, filing and stock exchange data showed.

Adani group has planned a ₹ 7 lakh crore capital expenditure over the next decade for expanding its infrastructure business, according to a recent investor presentation by the company management. (PTI)

The agency recorded the statement of an employee of the said 'Angadiya' operator, R Kantilal, where it was found that the Income-Tax department had raided their Goa office in January 2022 and all their documents, notes, chits, and slips were seized by the taxman during these searches.

The ED approached the tax department and retrieved the data of this 'Angadiya' firm and its analysis "shows

that about ₹45 crore has been transferred through Hawala to Goa".

"This Hawala trail of about ₹45 crore was also investigated and substantiated by the predicate agency CBI and the same were duly mentioned by CBI in its second supplementary chargesheet filed before a special court on

08.07.2023," the ED said.

The ED filed its money laundering case to probe alleged irregularities in the Delhi excise policy of 2021-22 on August 22, 2022, taking cognisance of a CBI FIR that was lodged on August 17, 2022.

The agency has charged the AAP, the ruling party of Delhi, of "committing the offence of money laundering

through Arvind Kejriwal", the party's national convenor and chief minister of Delhi.

Stating that AAP being a political party, defined as an association or a body of individual citizens of India under the Representation of People Act, the ED claimed it can be categorised as a "company" as contemplated under section 70 of the PMLA.

As Arvind Kejriwal was "in-charge of and responsible" for the said company i.e. AAP during the time of the offence, he and his party "shall be deemed guilty" of offences mentioned under the anti-money laundering law and liable to be prosecuted and punished, it claimed.

A money trail of cash funds of ₹ 25 crore, transferred allegedly through Hawala by Raghav Magunta, son of Lok Sabha MP Magunta Sreenivasulu Reddy, to BRS leader K Kavitha and her associates in Chennai has also been tracked by the ED.

Magunta Sreenivasulu Reddy is a prominent liquor businessman in south India and the sitting YSRCP MP from

Magunta Sreenivasulu Reddy is a prominent liquor businessman in south India and the sitting YSRCP MP from Ongole seat. He recently joined the TDP and got a ticket to contest the upcoming general elections from the same seat. The Maguntas, K Kavitha and businessman Sarath Reddy are alleged to be part of the 'South Group'. The ED, as per official sources, may also attach assets of the AAP terming them equivalent to the proceeds of crime generated through this claimed scam. (PTI)

Supreme Court-monitored SIT be set to probe the BJP's "extortion" of funds through the electoral bonds scheme. Last month, the Supreme Court annulled the electoral bonds scheme for political funding, saying it violates the Constitutional right to freedom of speech and expression as well as the right to information.

#### Tax terrorism slur

In recent days, India has witnessed a troubling trend that strikes at the heart of democratic principles. Allegations of tax terrorism, Leselective targeting of opposition parties, and the detainment of prominent leaders have raised serious concerns about the state of governance and political fairness in the country. Prime Minister Narendra Modi's government finds itself embroiled in controversy following revelations of coercion and intimidation tactics aimed at extracting funds from businesses and corporations. The recent exposure of undisclosed donors and recipients under the Electoral Bond Scheme, mandated by the Supreme Court, has shed light on the murky depths of political finance in India. Reports of businesses feeling compelled to donate to the ruling BJP under duress from investigating agencies raise troubling questions about the integrity of the electoral process. Furthermore, the actions taken against opposition parties, particularly the detention of leaders like Arvind Kejriwal and the freezing of Congress's bank accounts, smack of political vendetta. These incidents, coupled with exorbitant fines and tax demands conveniently timed on the eve of the Lok Sabha election, paint a picture of a government willing to go to any lengths to maintain its grip on power.

The international community has taken notice, with countries like Germany and the United States, along with the United Nations, expressing concern over the deteriorating state of democratic norms in India. The characterization of these actions as "tax terrorism" by opposition leaders underscores the gravity of the situation. The timing and nature of the penalties imposed on opposition parties raise legitimate questions about the impartiality and competence of the Income Tax Department under the Modi government. The sudden detection of discrepancies, coupled with hefty fines and penalties spanning several years, smacks of political manipulation rather than genuine tax enforcement. The selective targeting of specific parties further erodes public trust in the impartiality of governmental institutions. The detention of Arvind Kejriwal, a prominent opposition figure known for his electoral victories against the BJP in Delhi, is particularly troubling. His incarceration on seemingly dubious charges reeks of political retribution and undermines the principles of democratic governance. The curtailment of his powers as Chief Minister and the centralization of authority in the Lieutenant Governor's office represent a dangerous deviation from established norms of feder-

Moreover, the intertwining of financial penalties with political motives, as evidenced by the pardoning of individuals associated with the ruling party after substantial donations, further underscores the erosion of ethical boundaries within Indian politics. Such actions not only tarnish the reputation of the government but also undermine the very foundations of parliamentary democracy. As we approach the Lok Sabha election, it is imperative that the ECI and the SC uphold the integrity of the electoral process. Political parties must be held accountable for their finances, and transparency should be paramount to ensure a level playing field for all contestants. The allegations of tax terrorism and political oppression must be thoroughly investigated, and those responsible held accountable to restore faith in democratic institutions. The recent developments in Indian politics serve as a stark reminder of the fragility of democratic values in the face of unchecked power. It is incumbent upon all stakeholders, from political leaders to civil society, to safeguard the principles of accountability, transparency, and fairness that form the cornerstone of a vibrant democracy. Anything less would be a disservice to the ideals upon which our nation was founded.

### E-Evidence: Implementing India's new criminal laws

criminal laws - Bharatiya Nyay Sanhita (replacing the Indian Penal Code), Bharatiya Nagarik Suraksha Sanhita (replacing the Code of Procedure), and Bharatiya Sakshya Adhiniyam (replacing the Indian Evidence Act)—are scheduled to take effect on July 1, 2024. Simultaneously, the implementation of Section 106(2) of Bharatiya Nayay Sanhita (BNS), which mandates a 10-year imprisonment for fatal accidents not promptly reported to the police, has been temporarily suspended, as officially notified by the Central government.

The Ministry of Home Affairs (MHA) and various State governments are actively preparing for a seamless transition. Modifications in the Bharatiya Nagarik Suraksha Sanhita (BNSS) pertaining to investigative processes and police operations have been implemented. While a few new offenses and alterations have been introduced in the Bharatiya Nyay Sanhita (BNS), the core content of the Indian Evidence Act, 1872 remains largely unchanged in the context of the Bharatiya Sakshya Adhiniyam (BSA). Noteworthy adjustments include a slight expansion in the scope of secondary evidence and some revisions in the provisions related to electronic evidence within the BSA.

Clear guidance regarding electronic records is provided in the definitions section. As an example accompanying the definition of "document," which encompasses electronic and digital records, it is clarified that items such as emails, server logs, documents stored on computers, laptops, or smartphones, messages, websites, and locational information (the term "information" is suggested instead of "evidence") are all considered as documents. Additionally, voice mail messages stored on digital devices fall within the scope of the defined term.

Likewise, the provision addressing primary (electronic) evidence (Section 57) is elucidated through Explanations, providing clear guidance. One of these four explanations spec-

he three recently enacted ifies that in cases where a video recording is both stored in electronic form and simultaneously transmitted, broadcast, or transferred elsewhere, each of the preserved recordings is considered primary evidence. This could prove beneficial for investigative agencies in establishing the culpability of a cyber-criminal, even if the original electronic record is destroyed to refute allegations. The value of such evidence remains intact when collected from alternative sources, preventing its diminish-

Section 63, addressing the admissibility of electronic records, incorporates terms like 'semiconductor memory' and 'any communication device' for enhanced clarity. It's noteworthy that these inclusions do not alter the provision's impact, as the definition of 'electronic form' outlined in the Information Technology (IT) Act, 2000 encompasses information gener-'computer

network' in the IT Act covers 'communication device.' Therefore, the terms used in Section 63 align seamlessly with the broader definitions provided in

the IT Act. It's important to note that the computer's primary memory, encompassing random access memory (RAM) and cache memory, essentially constitutes semi-conductor memory. This type of memory is vital for the efficient and rapid operation of a computer. Despite its volatile nature, this memory can disclose crucial information when electronic devices are recovered and seized in a 'power-on' condi-

The matter concerning the admissibility of electronic records is well-established. While there are certain alterations in Section 63 of the BSA (equivalent to 65-B of the Indian Evidence Act), the precedent set by the Supreme Court in the case of Arjun Panditrao Khotkar vs Kailash Kushanrao Gorantyal & Ors. (2020) remains equally ap-

plicable to the new provisions. The Court, in this instance, affirmed that the requisite certificate under Section 65-B(4) now Section 63(4) of the BSA is indispensable for admitting electronic records.

Notably, other provisions related to the admissibility of secondary evidence do not apply to electronic records, given that Section 65-B of the IE Act commences with a non-obstante clause, and both Section 65-A and Section 65-B constitute a ated, sent, received, or stored in comprehensive legal framework in themselves.

served in the BSA. The Court emphasized that if obtaining the necessary certificate from the individual in possession of an electronic device proved challenging, an alternative recourse was available. Namely, an application could be submitted to a judge, seeking the production of the required certificate from the person involved, particularly in situations where the individual declined to

provide it willingly. The Court determined that while the certificate should ideally be submitted along with all other documents during the filing of the police report, and at the latest, before the commencement of the trial, any failure to do so in a timely manner is considered a curable defect.

Notably, as Section 65-B (and now Section 63 of the BSA) does not specify the precise stage at which the certificate must be presented to the court, the court retains the discretion, in suitable cases, to permit the prosecution to introduce the cer-

tificate at a later stage without prejudicing the accused during the trial. The Court further emphasized that in cases where compliance with the law is impossible, the alleged disobedience can be excused. In simpler terms, if producing the required certificate is deemed impossible, the court has the authority to waive the mandatory require-

ment for its submission.

Section 63(4) of the Bharatiya Sakshya Adhiniyam stipulates that the certificate must bear the signatures of two individuals, a departure from the Indian Evidence Act's requirement for only one. The first signature is to be provided by the person overseeing the computer, communication device, or relevant activities' management, while the second must come from an expert. The BSA includes a predefined format for the certificate in its Schedule. The expert's verification involves stating that specific hash value is derived by applying a particular hash algorithm.

Here, a hash function refers to an algorithm translating one sequence of bits into another, typically smaller, set known as the 'hash result." This process ensures that an electronic record consistently produces the same result whenever the algorithm is executed using the same electronic record as input. This computational infeasibility prevents the reconstruction of the original electronic record from the algorithm's hash result.

While the Central Government has not issued any notification under the IT Act regarding hash algorithms for encryption in the secure use of the electronic medium, the standard certificate format in the enumerates

(legally acceptable standard)' as applicable hash algorithms.

While MD5 (Message Digest5) and SHA1 (Secure Hash Algorithm1) are acknowledged to have certain vulnerabilities, SHA256 is widely regarded as more secure. Consequently, agencies are encouraged to utilize SHA256 to safeguard the integrity of data.

The introduction of expert certification, while aiding the court in admitting electronic records, poses the potential to escalate the workload for cyber laboratories. Given the pervasive use of smartphones in contemporary crime, where call records and location information play pivotal roles in investigations, the demand for expertsigned certificates may strain cyberlabs with an abrupt surge in workload. Many cyber laboratories, including some in Chhattisgarh, may face challenges as they might lack sufficient manpower.

Additionally, certain cyberlabs may not even be officially notified under the IT Act to provide expert opinions on electronic records.

It would have been a more reasonable approach if expert opinion were required only when the integrity of the seized electronic record is contested by the opposing party during the trial. In such instances, the courts could always seek expert input. The investigating officer could have sufficed by ensuring that one of the hash algorithms was applied and the message digest was attached to the certificate before its collection.

An immediate and comprehensive awareness campaign is essential now to educate the public about encryption modes and methods, especially targeting private agencies utilizing closed-circuit televisions or other electronic devices for security purposes. Concurrently, enforcement agencies should utilize the time leading up to July to establish the necessary infrastructure, ensuring they are well-prepared to shoulder the additional responsibilities that may arise. ### Netanyahu's walls are caving in as he has already lost his public opinion war

On Monday, Israel suffered its most significant international setback since 2016 with the US allowing the United Nations Security Council to call for an immediate ceasefire in Gaza. The United States abstained in a 2016 Council vote that condemned Israeli settlement activity The US Gaza vote strains Israel's relations with the United States, its main backer that prevented the Security Council from demanding a ceasefire for the past six months, as well as Europe, and most of the rest of the international community. US ambassador Linda Thomas-Greenfield controversially attempted to soften the blow by declaring the resolution "non-binding," even though UN Security Council resolutions are legally binding and constitute international law. In doing so, Thomas-Greenfield was also trying to create a buffer against likely pressure on the United States to sanction Israel if it refuses to abide by the resolution.

That did not stop Netanyahu from responding to the US abstention in the UN vote by cancelling a visit to Washington by an Israeli delegation headed by Strategic Affairs Minister Ron Dermer, who lacks a military background, to discuss Israel's planned ground offensive in Rafah, the southern Gazan city that is home to more than

a million Palestinians displaced by the war. With Defence Minister Yoav Gallant already meeting with senior US officials in Washington in a separate visit, Netanyahu's defiance is largely symbolic. Nevertheless, Gallant, responding to the UN vote, warned that Israel "will act against Hamas everywhere, even in areas where we have not been yet."Gallant stopped short of naming potential target countries, but Qatar, the main ceasefire and prisoner exchange mediator, and Turkey are likely to

Israel has accused Qatar, home to several exiled Hamas leaders, of funding Hamas, although the US and Israel acquiesced in their presence in the Gulf state to maintain a back channel with the group. Netanyahu for years solicited Qatari funding in a bid to prevent a breakdown of law and order in Gaza and keep the Palestinian polity, split between Hamas and Palestinian President Mahmoud Abbas's Palestine Authority, divided.

The Middle East Media Research Institute (MEMRI). founded by Yigal Carmon, a former advisor to Israel's West Bank and Gaza occupation authority and Prime Ministers Yitzhak Shamir and Yitzhak Rabin, has produced in recent months a series of reports designed to bolster Israeli denunciations of Qatar. This week, MEMRI took Qatar to task for hosting the Doha-based, Muslim Brotherhood-affiliated International Union of Muslim Scholars (IUMS).

Palestinian and Jordanian members of the Union have called on their compatriots to join the fight against Israel and "the Jews" with protests and uprisings against autocratic rulers who allegedly enable Israel's war, a reference to Arab countries that have diplomatic relations with Israel. The clerics also urged Arab militaries to come to the support of their Palestinian brethren.

Meanwhile, US Assistant Secretary of State William Russo warned in a readout of a phone call with Israeli

> Netanyahu will have been heartened by the insistence, in response to the UN resolution, of Gallant and Benny Gantz, a member of the war cabinet, that Israel will continue the war until its goals have been realised. Nevertheless, the UN resolution weakens Israel's negotiating position in talks mediated by Qatar, the United States, and Egypt to secure a ceasefire and an exchange of the hostages for Palestinians held in Israeli prisons. The resolution, in effect, constitutes an attempt to force negotiating parties to reach agreement in the next two weeks by demanding an immediate ceasefire for the Muslim holy month of Ramadan that would end on April 10, but lead "to a lasting sustainable ceasefire."

> While most Security Council members will read the resolution's demand for "the immediate and unconditional release of all hostages" as a reference to the Hamas-held hostages, it allows Hamas and others to interpret the clause as also including Palestinians in Israeli prisons. The claim would be substantiated by the ongoing ceasefire negotiations and Israel's past willingness to exchange prisoners. (IPA Service)

### India's youth lost a decade, now constitute 83 per cent of the jobless

2014 to provide "work with dignity for every hand", but now after a decade on the eve of Lok Sabha General Election 2024, they find themselves simply misled by a decade of PM Narendra Modi's bluff. which has just been exposed by the India Employment Report 2024 jointly published by International Labour Organisation (ILO) and the Institute for Human Development (IHD). Youth now constitute 83 per cent of the jobless in India, and growth is not employment-intensive.

The promise of "work with dignity for every hand" meant generation of 2 crore jobs every year, since around 7 million youth leave farm sector and migrate in search of employment while about 13 million join workforce every year. Every year 16 million youngsters attain adulthood, while two-third of India's population is below the age of 35. Now with the publication of the India Employment report it is clear that millions of youths could never find job at all, many of they have become overage, and even 90 per cent of those who somehow managed to find job are informally employed, while 82 per cent of the workforce are in the informal sector. Self-employment remains the primary source of employment for 55.8 per cent in 2022, while casual and regular employment accounted for 22.7 and 21.5 per cent respectively. India Employment Report 2024 is the third in the series of publication by IHD (New Delhi) on labour and employment issue. The Report prepared in collaboration with ILO focuses on Youth Employment, Education, and Skills. It is based on the government data of National Sample Surveys (NSS) and Periodic Labour Force Surveys (PLFS) between 2000 and 2022, with a postscript

Other sources of data included the Annual Survey of Industries, the National Account of Statistics, and the Reserve Bank of India-KLEMS database. It is precisely due to this reason Modi government could not refute the findings, rather the government's stand on unemployment found expression in Chief Economic Advisor of the Government of India V A Nageswaran's statement that Government can't really address unemployment problem. The statement is outrageous for several reasons, one of them is a statement made by PM Narendra Modi himself only a week earlier on March 20 in Startup Mahakumbh, New Delhi that India's "youth have opted to become job creators more than job seekers." PM Modi was obviously just downplaying the grim unem-

ployment scenario in the country, a quag-60 per cent of wealth and earning 70 per cent of entire national income.

Modi government did not bring the 'National Employment Policy" recommended by Indian Labour Conference, the top tripartite body in India on labour and employment issues, way back in the 45th session held in May 2013. At that time unemployment rate was around 4.1 per cent. ILC's 46th session held in 2015, and thereafter, Modi government did not convene any other session. Even the four controversial labour codes were brought without consulting ILC and stakeholder Central Trade Unions.

Though PM Modi has been bluffing on providing employment, unemployment reached 45 years high to 6.1 per cent. Modi government has claimed just a few weeks ago that unemployment has declined to 3.1 per cent. However, the India Employment Report 2024 portrays a grim picture on job front especially for Indian Youth. The resentment was obvious when CEA Nageswaran said that government can't really solve unemployment problem.

The most startling confession has been made by the Chief Economic Adviser; former Union Finance Minister P Chidambaram said adding that "Government cannot solve the problem of unemployment". Shocking if that is the official stand of the BJP government, we must boldly tell the BJP "Vacate vour seat". It is worth recalling that Acharya Vinoba Bhave had been advocating employment for all, and R K Patil said how it was possible! Vinoba's answer was that you are holding the rein of the horse and the rider is thrown off, it is your fault. If you can't provide employment for all, you must resign. However, PM Narendra Modi and BJP are seeking for their third term. Congress President Mallikarjun Kharge has said, "Our Youth is bearing the brunt of Modi Government's pathetic apathy, as ever-increasing Unemployment had destroyed their future. ILO & IHD report conclusively says that the unemployment problem is grim in India. They are Conservative; we are sitting on a ticking bomb of joblessness!" He alleged that youth unemployment has tripled under the Modi government compared to 2012. On employment trend and current sce-


nario, the report says that labour force participation rate, the workforce participation rate and the unemployment rate showed long-term deterioration between 2000 and 2019. The gains on employment front halted and even reversed after 2019, and employment conditions remain poor.

Nearly two-thirds of the incremental mire that has been created under his rule employment after 2019 comprised selfndia's youth have lost a decade. They in the last 10 years, since his policies employed workers, among whom unpaid trusted Narendra Modi's promise focus on wealth creation and profit, not on (women) family workers predominate. made during election campaign in employment. Only 20 big companies have The share of regular work, which steadily increased after 2000, started declining after 2018. The real wages of regular workers either remained stagnant or declined during 2012-22, though there was a modest upward trend of wages for casual labourers. Self-employed real earnings also declined after 2019. Overall wages have remained low. As much as 62 per cent of the unskilled casual agriculture workers and 70 per cent of such workers in the construction sector at the all-India level did not receive the prescribed daily minimum wages in 2022. Platform and gig work have been expanding, but it is, to a large extent, the extension of informal work, with hardly any social security provisions, as 90 per cent of the workforce which are informally employed.

During 2000-2012 employment grew by 1.6 per cent while gross value added grew at a much faster rate at 6.2 per cent. However, during 2012-19, employment grew at nearly negligible rate of 0.01 per cent while gross value added grew by 6.7 per cent. The paradox of employment is that it grew after 2019 due to COVID-19 pandemic because growth of agriculture employment after the great returning of migrant workers from cities, which actually was unemployment in disguise, as in the case of self-employment. Shift from non-agriculture employment to agriculture employment was only subsistence activities in agriculture due to the lack of pportunities outside.

Youth employment remains a challenge, since they formed 27 per cent of the population in 2021. Youth employment is. by and large, of poorer quality than employment for adults. Youth unemployment increased nearly threefold, from 5.7 per cent in 2000 to 17.5per cent in 2019 but declined to 12.1 per cent in 2022. The vouth unemployment rate has increased with the level of education, with the highest rates among those with a graduate degree or higher and higher among women than men. In 2022, the unemployment rate among youths was six times greater than among persons with a secondary or higher level of education (at 18.4 percent) and nine times greater among graduates (at 29.1 per cent) than for persons who cannot read and write (at 3.4 per cent). Women not in employment, education or training amounted to a proportion nearly five times larger than among their male counterparts (48.4 per cent versus 9.8 percent) and accounted for around 95 per cent of the total youth population not in employment, education or training in 2022. Or try recalling Geet from Jab We Met, who overlooked all the glaring red flags to paint a rosy picture of her relationship with Anshuman, unaware of its initial one-sidedness.

And then there's Joe Goldberg from You – the American psychological thriller TV series where every woman he "loves" is just a figment of his imagination, his obsession consuming him even before truly knowing them.

Now, you might wonder, what connects these three fictional Well, if you look closely, you'll

find that each of these characters yearns for something unattainable - a fixation on an idealised version of love that may not

They pursue their love interests, fueled by passion yet tinged with a hint of delusion, leaving us to question the true nature of their affection

What Is Limerence? How does it differ from healthy romantic attraction?

According to a US-based psychologist and published researcher Tanya Percy Vasunia, "Limerence is characterised as an intense state of infatuation or ob-

"While both can be powerful, limerence involves extreme fixation, akin to wearing blinders, whereas healthy love empowers and allows for a more balanced perspective. The inability to see beyond the person and an obsessive focus on their perceived perfection define limerence." -Tanya Percy Vasunia.

Elaborating on this, Shahzeen Shivdasani, a relationship expert and author of Love, Lust and Lemons, says that limerence can be best likened to experiencing love at first sight.

"Limerence is an intense emotional state that leaves you craving for the other person. The feelings are akin to those exciting emotions you wallow in when you meet someone for the first time. Essentially, it's a strong attraction where you end up falling for a perfected image of who they could be." - Shahzeen Shivdasani.

According to Shivdasani, people dealing with limerence may prioritise the object of their affection above everything else, even sometimes at the expense of their own well-being and other commitments

"Such hyper-focus on one person can lead one to take impulsive actions to secure the object of their attraction," she adds. **Understanding** the three

stages of Limerence While limerence may initially resemble falling in love, Vasunia explains that it follows a distinct trajectory with three stages: in-

terioration. The initial stage of infatuation is marked by an overwhelming attraction towards another per-

fatuation, crystallisation, and de-

Their unattainability adds allure, fueling an insatiable long-

During this phase, the individual becomes consumed by thoughts of the object of their affection, finding them irresistibly

As the infatuation intensifies, it transitions into the second

crystallisation. Here, the person begins to idealise the object of their infatuation and places them on pedestal, perceiving them as flawless and capable of fulfilling all desires.

However, when fantasy eventually dashes against reality, it leads to the third stage:

deterioration. The individual is confronted with the stark contrast between their love interest's idealised image and the actual person they are. As expectations remain unmet, disappointment ensues, leading to a grieving process for the loss of the fan-

"It is thus worth noting that, unlike limerence, love encompasses a combination of behaviours, congnitions and emotions that permits recognition of imperfections and nuances in the beloved, fostering a holistic perspective rather than an idealised one-dimensional perception." -Tanya Percy Vasunia, psycholo-

She goes on to explains, "Limerence, at its core, is a rollercoaster of emotions that can leave individuals feeling dissonant about their feelings towards someone. This intensity can be so overpowering that it masks any doubts or concerns, both for themselves and those around

However, as time passes, the facade of limerence begins to fade, revealing the stark reality beneath

Why do some people experi-

ence Limerence? Addressing the significance of attachment styles in the onset of limerence, Vasunia explains that attachment theory helps understand how individuals form emotional bonds and relate to others based on childhood experiences.

It primarily sorts people into secure, avoidant, anxious, or disorganized types. For example, an anxious person due to their fear of abandonment may struggle to disengage, even when the relationship lacks reciprocity.

Additionally, there's a growing recognition of inner child work as a significant aspect of understanding limerence.

Inner child work involves exploring one's early relationships, particularly with caregivers, and how they shape perceptions of safety, security, and intimacy.

"Difficulties in forming secure attachments during childhood can predispose individuals to seeking validation and security elsewhere, often sought in idealised romantic partners—a hallmark of limerence-where they idealise their partners as saviours who can alleviate their inner turmoil and provide hope and solace amid tumultuous times." -Tanya Percy Vasunia, psycholo-

Yet Vasunia emphasises, "Blaming parents for attachment difficulties oversimplifies complex dynamics. Instead, it's about acknowledging the interplay between early experiences, individual processing of those specific events, and personal coping mechanisms.

Can Limerence manifest as a trauma response?

Beyond attachment styles and the influence of early relationships, according to Vasunia, limerence, in some cases, can stem from trauma and function as a response to it.

Individuals predisposed to mental health concerns like OCD (obsessive-compulsive disorder), obsessive-compulsive personality disorder (OCPD) or unhealthy attachments may be more vulnerable to experiencing limerence

A 2015 study, Exploring the Lived-Experience of Limerence: A Journey toward Authenticity, conducted by researchers Lynn Willmott and Evie Bentley also linked limerence with conditions such as anxiety, depression, and substance use.

However, Tanya cautions that trauma should be understood within its heavy context, encompassing emotionally jarring events with physical manifesta-

"In cases of profound trauma, where individuals struggle to move past the event, there is a tendency to romanticise or idealise the situation as a coping mechanism," she adds.

"Individuals may convince themselves that the traumatic experience was positive or that things will eventually be fine, even if the reality is far from perfect, contributing to the development of limerence." - Tanya Percy Vasunia. Furthermore, limerence can

also arise following tumultuous experiences in previous relation-

For instance, if someone has endured a particularly damaging relationship, they might seek solace in a subsequent relationship, perceiving it as a perfect antidote to their prior trauma. However, this perception may be flawed. leading to a recurrence of limer-

While limerence occurring as a response to trauma is possible, it's not universal, and individual predispositions play a significant

"Seeking therapy or mental health support is advisable for those experiencing patterns of limerence tied to trauma or challenging experiences," advises

Can limerence fade with time?

While the intensity of limerence may diminish over time, its underlying patterns often persist, tesy: The Quint)

leading individuals to repeat similar emotional cycles with new objects of affection.

To address limerence without therapy, Vasunia suggests starting with first-order changes that can help regulate brain chemistry and mitigate the intensity of limerent feelings.

second-order However. changes involves delving into attachment styles, and object relations, and addressing underlying psychological predispositions, and might need professional intervention.

Additionally, relationship expert Shahzeen Shivdasini emphasises the need for intentional effort to manage and overcome limerence. She underscores the importance of setting boundaries, stating that difficulty in maintaining healthy boundaries can lead to unhealthy codependency

on one's partner. She adds, "For those awaiting reciprocation of their affection, consider shifting your focus to what you can control. Idealising something you don't or can't have may only exacerbate negative feelings. Instead, try cultivating passions and focusing on your other interests in life." Shahzeen Shivdasini.

While cultural narratives often glorify all-consuming love, according to experts, healthy love should be empowering, not debilitating like limerence. (Cour-

eople with bipolar I experience manic episodes, while people with bipolar II experience less severe hypomanic episodes. The two condition types have certain symptoms in common as well as similar symptom frequency.

People with bipolar disorder experience uncommon highs or lows in mood. During a "high," also known as a manic episode, people feel intense energy or excitement.

During a "low" or depressive episode, they experience symptoms of depression, such as feeling down, excessive guilt, frequent tearfulness, and lack of interest in enjoyable activities.

There are four distinct types

of bipolar disorder:

clothymia

· other specified and unspecified bipolar disorder

A doctor can diagnose a person with one of the above types based on the duration and intensity of their symptoms.

Bipolar I and bipolar II are the most widespread forms of bipolar disorder. They are also typically the more severe bipolar disorders, and they share many similar symptoms. However, they are distinct from one another.

In this article, learn about the similarities and differences between bipolar I and bipolar II. We also consider their causes, symptoms, and available treatment options.

Bipolar I vs. bipolar II Bipolar I and II have similar

symptoms and symptom patterns. However, people who have bipolar II typically experience less severe manic episodes than people with bipolar I. Doctors refer to these less se-

vere periods of mania as hypomania. These episodes must last for at least 4 days but no more than 7 days. To receive a diagnosis of bipo-

mania and depression, people who have either of these types of bipolar may experience periods of stable mood. A person may also alternate between symptoms of depression and mania at the same time. This is known as bipolar with mixed features.

### Unhealthy levels of arsenic in water could exacerbate health concerns when used to boil rice

new study underlines the risk of using water contami-⊾nated with arsenic to cook rice, a staple food serving more than half the world's population. It highlighted that 32 per cent of the global population lives in low- and middleincome countries that do not adhere to the World Health Organization's

recommended limits. The study, conducted by the University of Sheffield's Institute for Sustainable Food and the Department of Geography (United Kingdom), pointed out that some countries still follow the outdated WHO standard of 50 parts per billion as a safe threshold for arsenic in drinking water. Professor of soil and environmental science and lead author Manoj Menon mentioned in a statement that there is often very little or no regulation to current WHO

Menon added that India is among 40 other countries that adopted 10 parts per billion as its standard. However, 19 other countries have no evidence of any regulations.

Rice contains more arsenic in comparison to other cereals. The world's most widely consumed grain contains inorganic arsenic (iAs) — a Group 1 carcinogen according to the International Agency for Research on Cancer, a part of WHO. This poses a significant health concern when rice is cooked with water that has unhealthy amounts of arsenic. Prolonged exposure can lead to even diabetes and cardiovascular diseases. The researchers showed how dif-

the absorption of arsenic from the water. When the rice was cooked with excess water with a rice-to-water ratio of 1:6-12 or with percolating cooking water, it was effective at removing arsenic to a significant ex-

#### 'France to deliver hundreds of armoured vehicles to Ukraine'

PARIS. March 31: French Defence Minister Sébastien Lecornu said France is to deliver "hundreds" of armoured vehicles by the beginning of next year to Ukraine as part of a new package of military aid for the country that just entered its third year since the Russian invasion.

In an interview with the French newspaper La Tribune's Sunday edition, Lecornu said that "to hold such an extensive front line, the Ukrainian army needs, for example, our armoured personnel carriers. It's absolutely key for troop mobility".

The French military is currently replacing its old VAB armoured personnel carriers that started being used in 1979 by a new generation of armoured vehicles. "This old equipment, still operational, is going directly to Ukraine in large quantities. We're talking about hundreds (of vehicles) in 2024 and early 2025," Lecornu said.

Lecornu also said France will provide Ukraine with more anti-aircraft missiles. The move comes as France's government is pushing its military industry to boost its production to meet Kyiv's urgent needs for

Lecornu on Tuesday said France will soon be able to deliver 78 Caesar howitzers to Ukraine and will increase its supply of shells. (AP)

the dates for Easter and other religious holidays have so far remained unchanged.

The top U.N. court has ordered Israel to open more land crossings and take other measures to address

Gaza's Health Ministry said Sunday that at least 32,782 Palestinians have been killed since the start of the war, including 77 whose bodies were brought to hospitals over the last 24 hours. The ministry's count does not differentiate between civilians and fighters, but it has said that women and children make up around twothirds of those killed.

Israel says over one-third of the dead are militants, though it has not provided evidence to support that, and it blames Hamas for civilian casualties because the group operates in residential areas.

The United States, Qatar and Egypt have been trying to broker another cease-fire and hostage release since January. Hamas is demanding that any such agreement lead to an end to the war and the withdrawal of all Israeli forces.

Prime Minister Benjamin Netanyahu has rejected those demands and says Israel will keep fighting until it has destroyed Hamas' military and governing capabilities. But he is under growing pressure to reach a deal from families of the hostages, some of whom have joined mass demonstrations calling for early elections to replace him.

The cease-fire talks resumed in Cairo on Sunday, with little expectation of any breakthrough. (AP)

The 15,029-person MRP poll conducted by Survation on behalf of Best for Britain puts the Opposition Labour Party on 45 per cent of the vote share with a 19-point lead over the Conservatives, up three points from the group's previous poll at the end of last year. 'The Sunday Times' analysis of the major seat-by-seat survey claims Tory prospects have hit a record low, which means they are on track for their worst election result, winning fewer than 100 seats. Labour could win 468, giving Opposition leader Sir Keir Starmer's party a whopping 286-seat majority.

"Our MRP forecast shows that, if the election were held tomorrow, Sunak's Conservatives would lose 250 MPs across the country and the Labour Party would win with 468 seats. This would be the worst ever result for the Conservatives at a General Election," claims the Best for Britain analysis.

#### Japan confirms experts met in China to ease concerns over discharge of treated radioactive water

TOKYO, March 31: Japan said Sunday its experts have held talks with their Chinese counterparts to try to assuage Beijing's concerns over the discharge of treated radioactive wastewater from the wrecked Fukushima Daiichi nu-

clear power plant into the sea. The discharges have been opposed by fishing groups and neighbouring countries especially China, which banned all imports of Japanese seafood. China's move has largely affected Japanese scallop growers and exporters to

During the talks held Saturday in the northeastern Chinese city of Dalian, Japanese officials provided "science-based" explanation of how the discharges have been safely carried out as planned, according to the Japanese Foreign Ministry

A 2011 earthquake and tsunami damaged the Fukushima plant's



power supply and reactor cooling functions, triggering meltdowns of three reactors and causing large amounts of radioactive wastewater to accumulate. After more than a decade of storage in tanks taking up much space on the complex, the lant began discharging the water after treating it at least once and diluting it with seawater on August 24, starting a process that's expected to take decades.

Japanese Prime Minister Fumio Kishida and Chinese President Xi Jinping at their summit meeting in November agreed to hold scientific talks by experts, and the countries have since held a number of informal meetings. Sunday's statement from the Japanese Foreign Ministry was its first public acknowledgement of the talks.

The experts exchanged views on "technical matters" involving the discharges, the ministry official said on condition of anonymity due to the sensitivity of the issue. While stressing the importance of transparency, the official declined to give any other details, including what the Chinese side said and whether their differences have been narrowed

The meeting comes just after the International Atomic Energy Agency chief Rafael Mariano Rafael's visit to the plant in mid-March confirming that the ongoing discharges have been safely carried

### Pope presides over a blustery Easter Sunday Mass

ROME, March 31: Rallying from a winter-long bout of respiratory problems, Pope Francis led some 30,000 people in Easter celebrations Sunday, making a strong appeal for a cease-fire in Gaza and a prisoner swap between Russia and Ukraine.

Francis presided over Easter Sunday Mass in a flower-decked St. Peter's Square and then delivered a heartfelt prayer for peace in his annual roundup of global crises delivered from the loggia overlooking the piazza. In between, he made several loops around the piazza in his popemobile, greeting well-wishers.

"Peace is never made with weapons, but with outstretched hands and open hearts," Francis said, to applause from the windswept crowd below.

Francis appeared in good form, despite having celebrated the 2½hour nighttime Easter Vigil just hours before. The pontiff, who had part of one lung removed as a



young man, has been battling respiratory problems all winter.

The Vatican said some 30,000 people attended the Mass, with more packing the Via della Conciliazione boulevard leading to the piazza. At the start of the service, a gust of wind knocked over a large religious icon on the altar just a few feet from the pope; ushers

quickly righted it. Easter Mass is one of the most important dates on the liturgical calendar, celebrating what the faithful believe was Jesus' resurrection after his crucifixion. The

Mass precedes the pope's "Urbi et Orbi" (to the city and the world) blessing, in which the pope traditionally offers a laundry list of the threats afflicting humanity.

This year, Francis said his thoughts went particularly to people in Ukraine and Gaza and all those facing war, particularly the children who he said had "forgotten how to smile."

"In calling for respect for the principles of international law, I express my hope for a general exchange of all prisoners between Russia and Ukraine: all for the sake of all!" he said.

He called for the "prompt" release of prisoners taken from Israel on October 7, an immediate ceasefire in Gaza and for humanitarian access to reach Palestinians.

"Let us not allow the current hostilities to continue to have grave repercussions on the civil population, by now at the limit of its endurance, and above all on the children," he said in a speech that

also touched on the plight of Haitians, the Rohingya and victims of human trafficking.

For the past few weeks, Francis has generally avoided delivering long speeches to avoid the strain on his breathing. He ditched his Palm Sunday homily last week and decided at the last minute to stay home from the Good Friday procession at the Colosseum.

The Vatican said in a brief explanation that the decision was made to "conserve his health."

The decision clearly paid off, as Francis was able to recite the prayers of the lengthy Saturday night Easter Vigil service, including administering the sacraments of baptism and First Communion to eight new Catholics, and preside over Easter Sunday Mass and deliver his speech.

After a busy Holy Week, Francis should have some time to recover as there are no major foreign trips scheduled for several months. (AP)





#### Pakistan over security reasons: Analyst ISLAMABAD, March 31: The recent deadly attack on Chinese

workers in Pakistan has shaken their confidence and some of them are planning to leave the country over security reasons, according to a security analyst. Muhammad Amir Rana in an article published in Dawn newspaper on Sunday wrote that the terrorist

attack on the Chinese engineers' vehicle on Tuesday, which killed five Chinese, is having consequences and Chinese companies have suspended work on at least three critical hydropower projects: the Dasu dam, the Diamer-Basha dam, and the Tarbela 5th Extension. 'The attack has caused signifi-

cant alarm. Apart from disrupting these vital infrastructure projects, it has shaken the confidence of Chinese nationals working in Pakistan. Reports indicate some are considering leaving the country due to safety concerns," he wrote.

Thousands of Chinese personnel are working in Pakistan on several projects being carried out under the aegis of the USD 60 billion China-Pakistan Economic Corridor.

Rana said that the Pakistani government has repeatedly pledged to bring the perpetrators to justice. However, the recent incident has eroded trust and Chinese social media reflects growing anxiety, with calls for stricter security measures to protect Chinese lives.

Whenever a major terrorist incident occurs in the country, the media, security experts, and even state institutions start to make sweeping generalisations and the first and most well-known excuse cited is foreign involvement in the attacks, especially those targeting Chinese nationals or CPEC-related projects. Three names of terrorist groups spring to mind: Tehreek-e-Taliban Pakistan (TTP), Balochistan Liberation Army, and the Islamic State-Khorasan and the same is the case for the recent Shangla attack as the names of all three groups popped up immediately after the attack.

the prime suspect, as one of its commanders was declared the mastermind behind a similar attack on the Chinese in Kohistan in 2021, and the names of a few TTP commanders who may have orchestrated the attack are circulating in the media.

Rana said Pakistan's militant landscape may not be too complex but is diverse, where ideologies, sociopolitical factors, and group dynamics all work within local contexts. In any counterterrorism inquiry, local context and dynamics are more important than broader ideological and political motivations. He said quickly jumping to conclusions distracts investigation and impacts the state's ability to tackle the security situation com-

prehensively. Rana opined that the state's history of compromise with militant groups has emboldened them.

Shangla, upper and lower Kohistan, and Battagram districts of the Hazara region in KP and the adjoining Diamer district in Gilgit-Baltistan share religious, social, tribal, ethnic, and cultural codes. Sangma said on Saturday. This comes amidst simmering tensions at Ichamati in Meghalya's East Khasi Hills, following the brutal murders on Wednesday. The area remains on edge, with residents fearful of retaliation. The Chief Minister's comments follow criticism for his initial silence on the issue. Sangma, known for his social media presence, had not addressed the Ichamati killings despite actively campaigning online.

IMPHAL, March 31: Several self help groups are imparting skill-based training such as making of incense sticks (agarbatti), candles and disinfectants to women displaced by the violence in Manipur and staying in relief camps to help them become economically independent. Kongkham Monica, a displaced woman

in her early thirties from Serou area staying at Wangkhei Relief Camp in Imphal East district said she received skill training in making incense sticks, candles from a women self help group.

"We have been staying at this camp after our homes were burnt in May... and were dependent entirely on donation of others. We didn't have even ten rupees when we first came here. A women self help group Kangleipak Women Multipurpose Cooperative Society Ltd conducted a skill training programme and taught us how to make disinfectants, incense sticks, candles and ways of packaging so that we can use these skills to earn a living", the mother of three

She said the raw materials required to make these items are given by local vol-



unteers who help in running the relief

The profits from the sales are kept by

the displaced persons, Kongkham said. "The skill training programme has helped us to earn a little money. Earlier when we came to the camp, we had nothing but totally depended on donation of

others. But now even though things are still hard we are trying," she said, adding that a market shed was also built by a civil body to sell our items

Similar skill training is being provided by 'Eta: North East Women's Network', a non-profit group, which conducted multiple training programmes to support dis-

ister.

"After violence broke out, we conducted survey in 26 relief camps in Bishnupur district which is one of the worst affected districts in the state," Samom Beerjurekha, trustee of Eta, told PTI.

"We interacted with hundreds of displaced women to assess their skills and explore available opportunities for them to enhance their economic sustainability,' Samom said

She said "Ours is purely a voluntary enterprise. We tied with up individuals with specific handmade goods and took their service. After the programme, we provide the initial capital that is required for procuring raw materials from our own funds. We also urge the inmates to sell their products at their optimal best. However, we go a step further, and assist in selling the items.

Eta has purchased at least 29 looms and distributed it to beneficiaries as part of its mission to improve women's empowerment, she claimed.

A local volunteer, Babyna Maibam, at Palace Compound relief camp where a

similar skill training programme was taker up said "Despite pleas from all, the feasibility of these women returning to their native places in Churachandpur, Moreh, Serou is very low. In the relief camps, there is plenty of time. The skill training by self-help groups has given a new ray of hope for hundreds of these internally displaced women. When these women return to their homes, they can use these newly learnt skills to earn a living in the future.' A majority of over 50,000 internally dis-

placed people are currently staying at relief centres across five valley districts and three hill districts.

At least 219 people have been killed in the ethnic strife in the state that started on May 3 last year after a 'Tribal Solidarity March' was organised in the hill districts to protest against the Meitei community's demand for Scheduled Tribe (ST) status. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley, while tribals, which include Nagas and Kukis, constitute 40 per cent and reside mainly in the hill dis-



Congress leader also accused BJP of destabilising State governments and toppling several governments

INDIA bloc leaders gathered for a show of unity at the Ramlila ground here, the Congress on Sunday accused the Modi government of violating the Constitution by resorting to "confrontational federalism".

The Congress also accused the prime minister of resorting to fiscal centralisation, obstruction of state programs, destabilising state governments, misusing governors and subverting the rights of States.

In a statement, Congress general secretary Jairam Ramesh said as the INDIA Janbandhan's rally at Ramlila Maidan gets underway, it is necessary to recall how the PM is "violating", in letter and spirit, Article 1 of the Constitution of India that states "India, that is Bharat, shall be a Union of States.

He said the Prime Minister started off his innings in May 2014 talking big about cooperative federalism.

Instead, what he has delivered is confrontational federalism. Cooperative federalism is based on consensus, for which the PM has demonstrated a singular unwillingness and incapacity. In contrast, confrontational federalism is based on creating conflict and division, which is the PM's core skill," Ramesh charged in his statement.

The Congress leader said there are five major patterns to the prime minister's "concerted assault" on the



fiscal centralisation, obstruction of state programs, destabilising State governments, misuse of governors and subverting the rights of States.

Alleging fiscal centralisation, Ramesh said every time States get their constitutional share of taxes, or their legitimate entitlement, the PM and the FM make it out as though they are doing the states a big favour. In reality, he said, there are multiple instances which show they are averse to sharing revenue with

He said cess is a type of tax that is not shared with the states and since 2014, the share of tax revenue collected as 'cess' or 'surcharge' has grown, from just around 10 percent to over 26 percent. In the last five years, the revenue collection from Constitution's federal structure -- cessess have risen by over 133 per-

cent, amounting to lakhs of crores withheld from states, he said.

Alleging interference in the Finance Commission, he said, "In a blatantly illegal and unconstitutional move, the prime minister tried to directly interfere in the working of the 14th Finance Commission, pressuring the Chairman to reduce the states' share of Central taxes from 42 percent to 33 percent".

Ramesh also alleged withholding of funds, saying 223 out of 236 taluks of Karnataka are grappling with the effects of drought, with 123 experiencing severe drought condi-

Noting that Karnataka needs ₹ 17,900 crore as compensation, and farmers have lost crops worth ₹ 35,000 crore, he said not a single rupee has been released by the Centre to address this critical situation. The Congress leader also accused the BJP of destabilising State governments and toppling several gov-

"Using its thousands of crores of ill-gotten electoral bond wealth and the intimidation of the ED/CBI/IT, the BJP has illegally attempted and/or successfully brought down many state governments since 2014 by breaking parties and buying MLAs. The list includes Maharashtra, Goa, Manipur, Madhya Pradesh, Puducherry, Uttarakhand, and Arunachal Pradesh," Ramesh charged.

"The ED, IT, and CBI have been rendered the frontal organisations of the BJP, and have been used to intimidate senior leaders of the INDIA bloc in several states. At least two chief ministers, and 11 ministers across the country, have been arrested while in office.

"The Modi government has been continuously inventing new ways for remote-controlled Governors to interfere in states functioning," he alleged. Ramesh said Governors have become the first line of offense for the BJP in their attempts to topple Opposition Governments.

"In states like Maharashtra, even the Supreme Court has censured the Modi-appointed Governors for their unconstitutional attempts to destabilise sitting State Governments. "Modi-appointed Governors are

notorious for interfering in the governance of the state. This has included not giving assent to Bills for months or even years after they are passed in the legislature, facilitating the BJP's mergers and acquisitions department, hindering the appointment of Vice-Chancellors to universities, and refusing to allow the chief minister to decide his own Cabinet," the Congress leader alleged.

Alleging subverting the rights of states, he said the cooperative sector is a State subject, and different states have had huge success managing their own cooperatives, such as dairy in Gujarat or sugar in Maha-

"However, the Modi government has tried to seize control of this sector by making a new Cooperatives Ministry in the Centre," he said.

Ramesh alleged that a stream of Modi-government interventions in education, whether NEP or NEET, takes away states' power to run their own education systems, and strips them of any voice in education pol-

"The myopic Centrally-imposed policies are making medical education inaccessible to state government school students, by setting the syllabus in accordance with the Central government curriculum. The linguistic diversity of India, from Marathi to Bengali, is not respected in these Central systems,"

#### Challenge BJP to cross even 200 seats; won't allow CAA in Bengal: Mamata

KRISHNANAGAR March 31: West Bengal chief minister Mamata Banerjee on Sunday mocked the BJP-led NDA's target of winning 400-plus seats in the Lok Sabha polls and challenged

the saffron party to win at least 200

constituencies. The TMC chief also reaffirmed her refusal to allow the enforcement of the Citizenship Amendment Act in the state and cautioned the people that applying for CAA would turn an applicant into a foreigner and urged them not to apply

"The BJP is saying '400 paar', I challenge them to cross the 200seat benchmark first. In the 2021 West Bengal assembly polls, they aimed for 200 plus seats but had to stop at 77. Some of these 77 have since joined us," she said while campaigning for TMC candidate Mahua Moitra in the Krishnanagar

Dubbing the BJP a 'jumla' party, the TMC supremo accused them of "peddling lies" regarding the CAA, stating "Modi's guarantee on CAA is a zero guarantee.'

"The CAA is a trap to turn legal citizens into foreigners. Once you implement CAA, NRC will follow. We would allow neither CAA nor NRC in West Bengal. Don't fall for the false assurance of the central government. If you apply, you will be designated as a foreigner for 5 years," Banerjee said while addressing her first rally in the election season after her injury earlier

Reaching out to the Matua community, who are expected to benefit most from the implementation of the CAA, the TMC supremo urged the community to have faith in her, stating she would never allow "anyone to snatch your citi-

"Matuas, please have faith in me. I will not allow anyone to snatch your citizenship. Do you want that or want to live peacefully? Through CAA, they will snatch everything from you and keep you in a detention camp," she

Matuas, originally from East Pakistan, are a weaker section of Hindus who migrated to India during the partition and after the creation of Bangladesh following religious persecution.

Since the 90s, political parties have courted the support of the Matuas, whose substantial population and tendency to vote cohesively make them a valuable voting bloc akin to minority groups, particularly in alignment with the BJP's stance on the CAA.

According to the Citizenship Amendment Act (CAA), rules of which were notified on March 13, the government will now start granting Indian nationality to persecuted non-Muslim migrants -Hindus, Sikhs, Jains, Buddhists, Parsis, and Christians - from Pakistan, Bangladesh, and Afghanistan who arrived in India before December 31, 2014. #### **Former Bihar Congress** president Anil Sharma quits

PATNA, March 31: In a setback to the Congress in Bihar ahead of Lok Sabha polls, former state president Anil Sharma on Sunday quit the party, claiming that it was stuck in a "disastrous" partnership with the RJD.

Making the announcement at a press conference here, Sharma also voiced disgust over the recent induction, "with much fanfare", of controversial former MP Rajesh Ranjan alias Pappu Yadav.

Today, the party leadership is busy with a rally in Delhi where it is talking of the need to save democracy. Sadly, though, no democracy can be seen in the Congress where even our duly elected national president can take no step without consulting Rahul Gandhi or his close aide KC Venugopal," alleged Sharma.

Sharma became the fourth former Bihar Congress president to have quit the party in nearly a decade. The latest instance was that of Ashok Chaudhary, who quit the party and joined JD(U) in 2018, a few months after a factional feud caused him to give up

the state president's post. Earlier, in 2015, Ram Jatan Sinha had quit the Congress and after a brief stint in JD(U), he has been in political wilderness. The year before saw Mehboob Ali Kaiser joining late Ram Vilas Paswan's LJP which helped him enjoy two consecutive terms in Lok Sabha from Khagaria.

However, Sharma insisted he was cut from a different cloth, stating, "I joined Congress in 1985. In nearly four decades, I held organisational posts twice, as state general secretary and then as state president. Never did I lobby for a ticket or a legislative council berth

for myself. Nor have I explored possibilities in any other party before quitting the Congress.

About the timing of his step that comes just ahead of the Lok Sabha polls, he said, "I have, since my state president days, been critical of the tie-up with RJD which has helped them thrive at our expense. In the eyes of the people, we have only ended up being held guilty of supporting the jungle raj of Lalu Prasad and Rabri Devi."

Sharma said the last straw came when Pappu Yadav was inducted into the party.

"He was virtually felicitated at the national headquarters. The party is upset that Lalu has thwarted its attempt to give Yadav a ticket. Instead, it should have thought about many better candidates, who are not getting a chance because Congress leadership cannot assert itself before the domi-

neering ally," he said. Notably, out of the 40 Lok Sabha seats in Bihar, the RJD is contesting 26, leaving nine for Congress and five for three Left

parties. Replying to a question, Sharma said the choice of candidates by the RJD showed "tickets have been put up for sale, without taking into account winnability", and that possibility of a "tacit understanding" with BJP, as is speculated by a section of the media in the case of Mayawati's BSP in adjoining Uttar Pradesh, "can certainly not be ruled out"

Meanwhile, state Congress media cell chairman Rajesh Rathore issued a statement slamming Sharma for trying to make "a cowardly escape" and find "an excuse for falling at the feet of Narendra Modi". (PTI)

### Tyranny won't work, can't keep Delhi CM behind bars for long: Sunita Kejriwal at INDIA bloc rally

NEW DELHI, March 31: Tyranny won't work and Delhi chief minister Arvind Kejriwal cannot be kept behind bars for long, said Sunita Kejriwal, reading out her husband's message from Enforcement Directorate custody at the INDIA bloc's 'Loktantra Bachao' rally here on

In her maiden speech at a political rally, Sunita also asked people whether Kejriwal should resign as Chief Minister.

"The BJP is demanding the resignation of Chief Minister Keiriwal. Should he resign? Is his arrest justified? He is a 'sher' (lion). They won't be able to keep him behind bars for long," she said. Sunita thanked people for showering blessings on her husband.

"This tyranny will not work. My husband is getting lots of blessings," she said.

Kejriwal was arrested by the March 21 in a money laundering



case linked to the now-scrapped Delhi excise policy. He is in ED custody till April 1.

Kejriwal's message included six guarantees on behalf of the INDIA bloc -- uninterrupted power supply, free electricity for the poor, government schools, Enforcement Directorate (ED) on Mohalla Clinics and multispeciality hospitals, minimum sup-

port price for farmers, and full statehood for Delhi.

"People of Delhi have faced injustice for the last 75 years. Their government was handicapped. We will make Delhi a full state if the INDIA bloc comes to power.

"If you give an opportunity to Chief Minister Champai Soren the INDIA bloc, we will build a

great nation," Sunita said while reading out her husband's mes-

'Mother India is in pain. She feels pained when people do not get uninterrupted power supply or when someone dies without getting treatment," she added.

NEW DELHI, March 31: Congress leader Rahul Gandhi on Sunday accused Prime Minister Narendra Modi of trying to do "match-fixing" in the Lok Sabha polls and asserted that if the BJP succeeds in its endeavours, the country's Constitution will be changed and people's rights taken away. Addressing the INDIA bloc's 'Save Democracy' rally at the Ramlila Maidan here, the former Congress chief said this is not an ordinary election but one to save the country's democracy and Constitution.

"When pressure is put on umpires and captain, players are bought off and the match is won, in cricket, it is called match-fixing. We have Lok Sabha polls before us. Who selected the umpires? Before the match started, two players were arrested... Narendra Modi is trying to do match-fixing in these polls," Gandhi said. The BJP is raising the slogan of getting 400 seats, but without EVMs, match-fixing, pressure on opposition leaders and buying media, they will not be able to cross even 180 seats, he claimed.

Gandhi said the Congress is the biggest opposition party and all its accounts

have been frozen. "Two chief ministers were arrested. What kind of election is this," Gandhi alleged, adding, "Match-fixing is being done by PM Modi along with three-four billionaires. This is being done to snatch the Constitution from the poor." The Constitution is the voice of the people and the day it is finished, this country will be finished, he asserted, adding if the Constitution goes, the rights of the poor and reservation will also go.

"A BJP MP said 'we will change the Constitution when we get over 400 seats'. It was not said just like that, it was to test the idea," Gandhi said, referring to Anantkumar Hegde's remark about amending the Constitution.

They think the country can be run with the threats and intimidation of police, CBI and ED... You can buy media and suppress them but you cannot suppress the voice of India. No force in this world can suppress this voice of people," the former Congress chief said. He claimed that If the BJP wins the election through match-fixing and changes the Constitution, then the country would not be saved and "there will be fire everywhere". (PTI)

### South will help reach Modi target of 370; BJP has highest TRP in country: Gadkari

NAGPUR, March 31: Avowing abiding confidence in Prime Minister Narendra Modi's goal of 370 seats, BJP leader Nitin Gadkari says the additional seats to its current strength of 288 will come from gains in southern India in the upcoming Lok Sabha elections.

In a wide ranging interview with PTI at his residence in Nagpur, Gadkari said there is "no doubt" in his mind that the BJP-led NDA alliance will cross 400 seats and that Modi will take over as prime minister for a third term because of the solid work done by the government in the last 10 years.

He dismissed allegations that the Modi government is "weaponising" central probe agencies such as the Enforcement Directorate and CBI to weaken the opposition, saying BJP's rivals should make efforts to overcome adversity by winning the confidence of the people.

"Is it our responsibility to make the opposition weak or strong? When we had just two MPs and were weak, we never got any package out of sympathy," Gadkari, who is seeking a third Lok Sabha term from Nagpur, said.

Gadkari launched his campaign with a massive road show on Saturday through Nagpur, his motorcade crawling through a sea of supporters who withstood 40 degrees Celsius temperature to welcome the local hero. The

hours ended four hours later as supporters covered him with gulal and insisted on offering him snacks every time he stopped.

Gadkari said the BJP emerged stronger over the years due to the sheer hard work of its workers and the opposition too has to make efforts to earn the people's confidence.

"The nature of democracy is such that this keeps changing. Whatever role you play, you always have to make efforts and overcome adversity. This is important for any opposition party," he said.

He was also asked to explain the arithmetic of 370 seats for BJP and more than 400 seats for the National Democratic Alliance, given that they have already maxed out in their stronghold states.

"There is no need to make a state-wise analysis. This time we will taste success in the South. The work we have done in the south and the northeast over the last 10 years under Prime Minister Modi's leadership... we have started getting results of the same," he said.

"We have worked hard in Tamil Nadu, Kerala, Telangana, Andhra Pradesh and Karnataka. We had very little presence in these states. This time we will do well in Telangana and Andhra Pradesh. We have been performing well in north India. So, I feel the BJP will alone



get 370 seats and the NDA will

cross 400," Gadkari said. The senior BJP leader said the people of the country want to see development and have faith in the leadership of Modi, which will be

reflected in the elections. To a question on the claims by certain quarters that the BJP will fall short of the majority mark, which in turn could trigger a race for the post of the prime minister, Gadkari responded vehemently:

"Not at all!" "We are completely confident that we will get a complete majority and will also cross the 400 mark and Narendra Modi ii will become the country's prime minister for the third consecutive term. There is no

doubt about this in my mind," he said. Questioned about his personal agenda for the centenary celebrations of the RSS in 2025, the ideological fountainhead of the BJP, Gadkari said his "personal agenda' was only towards his constituency that has elected him.

"I do not have any personal agenda. RSS will spell out its agenda. Whatever their expectations, it is our responsibility to fulfil them," he said.

He was also asked if there is lack of level playing field in the elections due to the arrest of opposition leaders, including Delhi Chief Minister Arvind Kejriwal, and the income tax notices amounting to  $\mathfrak{T}$ . 3,500 crore on the Congress party.

The Union minister said the law was "taking its own course" and the BJP or the government had nothing

"We have not taken any action on our own. The cases have been registered as per the law. This has nothing to do with the BJP or Modi ji. The agencies keep doing their jobs," Gadkari said.

The senior BJP leader dismissed opposition allegations of the government weaponising the ED, CBI and Income Tax department, which were taking action in cases related to opposition leaders.

"This is completely wrong. We are not weaponising anybody. The law takes its own course. Now, if ₹ 300-400 crore are found in anybody's home, people also see it. Then there is an inquiry. If anyone has done wrong, action is taken. If anybody is aggrieved, they have the option to move court," he said.

Gadkari was also dismissive about the uproar over the revelations of donations made through electoral bonds and said it was but natural for the BJP, which is the ruling party, to get a major share in the donations

"Even in television media, those who have greater TRP get a good rate in advertisement. Those who have less TRP, get advertisements at a lower rate. Today, we are the ruling party, hence we got more donations. If tomorrow any other

party comes to power, it will get more donations," he said.

Gadkari said the ground reality was every political party required money and there was need to find a legal way to raise resources.

"I do not wish to say anything as the matter is sub-judice. After the Supreme Court has its say, all political parties should get together. In some countries, the government finances political parties. We will have to look for some options, this is what I feel," he said.

Gadkari said there is no substance in the opposition's claims that the BJP is indulging in "washing machine politics" -- absolving opposition figures facing corruption charges if they agree to join the

"There is no such thing. The law takes its own course. The agencies do their work on the basis of the evidence they gather. This allegation is completely wrong and baseless. No such work takes place," he said, responding to opposition allegations of BJP being a "great washing machine'

On the CBI clean chit to NCP leader Praful Patel in the Air India corruption case, Gadkari said the action had nothing to do with the BJP or the prime minister. "The truth came out in the inquiry," he said. Gadkari recalled former prime minister late Atal Bihari Vajpayee's remarks on remaining true to the ideology and the principles of the party when asked about any advice to the opposition to revive itself.

"Having a difference of opinion is necessary for a democracy. But the real problem is having no opinion. (Aaj hamarey desh mein mat bhinnata yeh loktantra ke liye awashyak bhi hai. Usmey problem nahi hai. Para mat shunyata yeh hamari samasya hai.) Whatever party you are in and its ideology, it is important to stand by it with conviction - in victory or in defeat," he

"I remember when I entered politics against the Emergency and started working with Jayprakash ji, the conditions were not favourable for us. But we kept on working in adverse conditions and one day Atal Bihari Vajpayee became the prime minister. Today, Modi has ruled the country for the last 10 years. Sure, the people give you an opportunity, but you have to have patience and work hard," Gadkari

Gadkari who won with a margin of more than two lakh seats in the 2019 elections said his goal this time is to win by a five lakh margin. He said he is confident of getting minority and Dalit votes this time. Pitted against him is Vikas Thakre of the Congress, a former mayor of Nagpur who also has good grassroots connect with people. ### President Murmu confers Bharat Ratna on LK Advani

NEW DELHI, March 31: President Droupadi Murmu conferred Bharat Ratna, the country's highest civilian honour, on BJP stalwart and former deputy prime minister L K Advani at his residence here on Sunday.

The ceremony was attended by Vice President Jagdeep Dhankhar, Prime Minister Narendra Modi. defence minister Rajnath Singh, home minister Amit Shah and the family members of Advani, the Rashtrapati Bhavan said in a post on X.

Prime Minister Modi sat next to Advani as the President honoured the veteran leader with Bharat

Modi said on X that it was very special to witness the conferring of the Bharat Ratna on Advani and this honour is a recognition of his enduring contributions to the nation's progress.

"His dedication to public service and his pivotal role in shaping modern India have left an indelible mark on our history. I am proud to have got the opportunity to work with him very closely over the last several decades," the prime minister said.

The Rashtrapati Bhavan described Advani as a doyen of Indian politics and said that he has served the nation with unwavering dedication and distinction for over seven decades. As a parliamentarian, his emphasis on dialogue en-



riched parliamentary traditions, it

Whether as home minister or as deputy prime minister, Advani always prioritised national interest above all, earning him respect and admiration from across party lines, it said in a series of posts on X.

"His long and tireless struggle for India's cultural regeneration culminated in the reconstruction of Shri Ram Temple in Ayodhya in 2024," it said.

Among the handful of post-Independence political leaders who succeeded in reshaping the national agenda and placing it on the path of development, Advani's accomplishments provide the best articulation of the genius of India and its inclusive traditions, the Rashtrapati Bhavan said and shared pictures of the ceremony on

Born in Karachi (now in Pakistan) in 1927, Advani migrated to India in 1947 during Partition.

The 96-year-old BJP stalwart served as deputy prime minister from June 2002 to May 2004 and as Union home minister from October 1999 to May 2004. He was BJP president multiple times -from 1986 to 1990, 1993 to 1998, and 2004 to 2005.

The Rashtrapati Bhavan said that with his vision of cultural nationalism, Advani toiled hard for decades, across the length and breadth of the country and brought about a transformation in the socio-political landscape.

"When Emergency put India's democracy at risk, the indefatigable crusader in him helped guard it

against authoritarian tendencies," it said in the post.

As the information and broadcasting minister in the Janata Party government (1977-79), Advani was instrumental in the restoration of democracy by dismantling the Emergency's antidemocratic legal edifice, reads the profile of the veteran leader shared by the Rashtrapati Bhavan.

His contribution at the time was as intellectually inspiring, as politically impactful.

A high point in Advani's political life came when he spearheaded the Ram Janmabhoomi movement in the late 1980s and laid the foundation for the revival of cultural nationalism.

"His struggle culminated in the reconstruction of the magnificent Shri Ram temple in Ayodhya in 2024, thus fulfilling the decadesold aspirations of countless Indians," it said.

During his tenure as India's home minister, Advani brought about the most comprehensive reforms in India's national security system. He took a pro-active and uncompromising approach to counter cross-border terrorism and made sincere as well as consistent efforts to bring peace in Kashmir.

His emphasis on harmonious centre-state relations resulted in the carving out of three new states -- Chhattisgarh, Jharkhand and Ut-

Advani's eventful political life will be remembered for his determined and diligent pursuit of core enduring ideals such as the defence of democracy, cultural nationalism and clean politics, according to the profile of the veteran leader shared by the Rashtrapati Bhavan

During his fight against Emergency (1975-77), Advani spent 19 months in Bangalore's central jail.

His book A Prisoner's Scrap-Book (1977) is praised globally as one of the best works of prison literature, the profile stated, adding that Advani has always set exemplary standards in political ethics.

Regarded as a statesman who combines intellectualism, integrity and mass appeal, Advani has been an avid reader and a prolific writer. For his exceptional service in public life, Advani was conferred Padma Vibhushan, the country's second-highest civilian award, in

This year, the government announced five Bharat Ratna awards -- one to Advani and four posthumously to former prime ministers P V Narasimha Rao and Chaudhary Charan Singh, agriculture scientist M S Swaminathan and two-time former Bihar chief min-

ister Karpoori Thakur. Rao, Singh, Swaminathan and Thakur's kin received the award from the president on Saturday at the Rashtrapati Bhavan. (PTI)

### Court rejects bail plea of PFI Delhi unit chief Parvez Ahmed

NEW DELHI, March 31: A court here has rejected the bail plea of Parvez Ahmed - the chief of the Delhi unit of the banned Popular Front of India (PFI) - who was arrested by the Enforcement Directorate for his alleged role in money laundering in the guise of cash do-

Ahmed contended in his plea that his continued incarceration was unwarranted and there was no likelihood of the trial being concluded shortly.

Noting the evidence before it, Additional Sessions Judge Chander Jit said, "The accused could not overcome the threshold stipulation predicated in section 45 of PMLA. Hence, the present bail application is disposed of as dismissed".

The twin conditions under Section 45 state that when an accused in a money laundering case applies for bail, the court has to first give an opportunity to the public prosecutor to be heard and only when it is satisfied that the accused is not guilty and unlikely to commit a similar offence when released, can bail be granted.

Special Public Prosecutor N K Matta and advocate Mohammed Faizan appeared for the ED.

The council had opposed the bail plea underlining that the accused had been "evasive", besides making "deliberate attempts to mislead the investigation and conceal his role in the offence of money laundering."

Rejecting Ahmed's argument for bail on the grounds that he was not aware of dealing with proceeds of crime, the court said, "Whether applicant (Ahmed) knew or did not know that he was dealing with proceeds of crime and whether the same was tainted money can be ascertained after the evidence has been led."

It also rejected the accused's argument that he did not follow up on the collection of donations and was not directly involved in dealing with accounts, saying being the Delhi unit state president, his "bare denial" will not absolve him of the role played in PFI.

In an order passed on March 18, the court also said that no recovery of cash from the accused was needed to hold him liable under PMI.A.

"The material on record does show that there is an inflow of money through various sources, some of which are stated to be suspicious. There are allegations of raising money from abroad, without accounting for it," the court

"The statements of various accused when juxtaposed with each other do raise contradictions in respect of the entire process of the source of money and eventually indicate that there is layering of money," it added.

The court has reserved its order on the bail of other arrested PFI functionaries, including the general secretary Mohammed Ilias and office secretary Abdul Muqeet.

The agency arrested the three accused on September 22, 2022.

Partnering with the ICMR and a network of 20 NGOs, Svayam is spearheading a national campaign to highlight the critical need for inclusive environments and assistive technologies for a significant portion of the population. #### Clash between two groups after dispute in MP's Sagar; police launch probe

Gyanvapi committee's plea

against allowing puja in cellar

NEW DELHI, March 31: The Supreme Court is scheduled to hear on April 1 a Gyanvapi mosque management committee's plea against an Allahabad High Court decision upholding a lower court's order allowing Hindu prayers in the southern cellar of the mosque.

A bench of Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra will hear the plea of Anjuman Intezamia Masajid Committee, which manages the affairs of the Gyanvapi mosque in Varanasi, challenging the HC's February 26 decision.

The high court had dismissed the committee's plea in which it had challenged the district court's January 31 order allowing Hindus to offer prayers in the cellar.

While dismissing the plea of the mosque committee on February 26, the high court had observed that the Uttar Pradesh government's 1993 decision of stopping worship rituals inside the "Vyas Tehkhana" -- located at the southern cellar of the Gyanvapi -- was

"illegal". It had said that the worship rituals were stopped by "illegal action of the state without there being any order in writing" and rejected two appeals filed by the mosque management committee challenging the Varanasi district judge's January 17 order -- that appointed the district magistrate as the receiver of the "Vyas Tehkhana" -- and the January 31 order by which the judge allowed 'puja' to be performed there.

The high court ordered that wor-

ship will continue in the "Vyas Tehkhana" of the mosque, which stands adjacent to the Kashi Vishwanath temple.

A survey conducted by the Archaeological Survey of India (ASI) on the court's order had suggested that the Gyanvapi mosque was constructed during Mughal emperor Aurangzeb's rule over the remains of a Hindu temple.

The district court had ruled on January 31 that a Hindu priest can perform prayers before the idols in the southern cellar of the mosque.

The prayers are now being conducted by a Hindu priest nominated by the Kashi Vishwanath temple trust and petitioner Shailendra Kumar Pathak, who claimed that his maternal grandfather Somnath Vyas, also a priest, offered prayers in the cellar till December

He had said puja was stopped during the tenure of then Uttar Pradesh chief minister Mulayam Singh Yadav after the Babri masjid in Ayodhya was demolished on December 6, 1992.

During the hearing before the trial court, the Muslim side had contested the petitioner's version. It had said no idols existed in the cellar and hence, there was no question of prayers being offered here till 1993.

The Muslim side had also countered the petitioner's claim that the basement was under his grandfather's control.

The petitioner had claimed that his family had the control of the cellar even during the British rule. (PTI)

### Film music hardly producing big singing stars today, says singer Shaan

MUMBAI, March 31: The Indian music scene is undergoing a change and an artiste today doesn't have to depend on films to become popular, says singer Shaan. The vocalist, who broke onto the indie pop scene in late 1990s with albums Love-ology and Tanha Dil, said it seems to be the age of rappers or musicians like Guru Randhawa, Neha Kakkar and Badshah.

Arijit Singh is the "last big exponent" to come from films, he said. "All the big names today in music, they are either rappers or they have their own brand of music styles. Arijit Singh was probably the last big exponent who came in from film music. But a lot of them first got popular doing their own non-film music, like Guru Randhawa, Honey Singh, Badshah, King. But today, film music is hardly giving you the big singing star," Shaan told PTI in an interview.

The 51-year-old playback singer, known for film songs Musu Musu Haasi Deu, Woh Ladki Hai Kahan, Chand Sifarish, and Jab Se Tere Naina, said it's difficult to make fans listen to his non-

film music. "The only thing is that a singer like me, who's branding has become that of a Bollywood singer, it's very difficult to get out of that and for people to start listening to my non-film songs. But for others like Neha Kakkar, who came in from social media and then started getting their film songs... Today, it's changing, a singer doesn't have to really rely to become popular through film music,"

Shaan also said he feels "underutilised" in Bollywood. "Sadly, in the last 10 to 15 years, I've been much underutilised and not been a part of those big Bollywood songs, like I used to be. But at the same time, this could be of help. When you are constantly on a roll, there's no time to introspect, no time to work on your skills. You tend to keep going with the flow. At some point, you realise you're becoming mechanical, redundant. So I take this break, this little getaway as a good thing, that I get to work on my skill sets.

The singer recalled a recent instance when his song from Rajkumar Hirani's Dunki, starring Shah Rukh Khan, was dropped by the makers.

"I was thrilled that I got to sing a Shah Rukh Khan song, but for some reason, it was replaced by another song. So, these things. The song, O Maahi got on to become the popular song of that soundtrack, which is where my song was

supposed to be slotted in," he said. Instead, Shaan said he got the opportunity to collaborate with renowned percussionist Bickram Ghosh on his latest single Tanhaiyyan. "I sang this beautiful song with Bickram Ghosh da. The music carries on, whether it's a film or not, and

every other day I'm recording a beautiful

Tanhaiyyan, featuring Shaan and Ghosh, is produced under the latter's music label Eternal Sounds. The singer said his goal is to build a memorable discography. "It's a legacy that you leave behind, the idea is to keep making good music... that will hopefully transcend time. I'm glad we have Eternal Sounds. the name eternal itself says it all, it means we got to create something that is timeless and not something that people are listening to at clubs, or are dancing to at parties," he added.

Ghosh described Shaan as a fantastic singer who is in "tremendous" form. "We keep talking and sometimes I vent with him, and a bit of that he does too about what we should do to justify music because music has been under the baton of films for too long. Music should have its own life, and that's happening today with indie music," he

Singing, regardless of platform, brings him happiness, said Shaan. "For a singer, the biggest thrill is when you are behind the mic creating music. Nothing excites me more than that. I'm getting opportunities to do that a dime a dozen. So, I'm happy about it. That childlike passion and excitement, that fire in the belly is now more than ever before.'







### Look yourself in mirror and ask 'did I do my best': Bindra tells Paris-bound shooters

**NEW DELHI, March 31:** "Look yourself in the mirror before going to bed and ask 'did I do my best'?." This is what Olympic champion Abhinav Bindra told shooters aspiring to excel at the upcoming Paris Games during an interactive session here on Sunday.

During the session, India's first ever individual Olympic gold medallist answered queries and shared his experiences about competing at sport's grandest stage.

The session was held at Dr. Karni Singh Shooting Range, as the team entered the crucial final three months of preparation. Bindra reminded the squad that "success is not a one-off event".

"Doing the right things consistently day in and day out is what leads to success.

On a query on how to maintain self-discipline, Bindra said, "You have to be brutally honest with yourself and everyday look yourself in the mirror before you go to sleep and ask yourself - did I do my best? If the answer is yes you will find you will have the result eventually."

India have won a total of 19 quota places in shooting for the Paris Olympic Games across rifle, pistol and shotgun disciplines, their highest quota haul ever. The session was organised by the National Rifle Association of India (NRAI), ahead of the first batch of

shooters departing later in the day, for equipment testing to Europe. Three such batches will leave in succession in April, besides a three-member women's air pistol squad and the shotgun squad competing at the final Olympic qualifiers in Rio and Doha respectively.

Later in April the first of four national Olympic selection trials for rifle and pistol shooters are scheduled at the same venue. This will be the first time a national trial for the sole purpose of picking the rifle and pistol Olympic squads will be conducted.

# Bopanna-Ebden clinch Miami Open title, return to world No. 1 ranking

Indian tennis player Rohan Bopanna rewrote his own record to continue to be the oldest ATP Masters 1000 champion as he and his Australian partner Matt Ebden clinched the men's doubles crown at the Miami Open here.

Continuing their fine run this year, the 44-year-old Bopanna and Ebden fought back from a set down to pull off an exhilarating 6-7(3), 6-3, 10-6 win over Crotia's Ivan Dodig and American Austin Krajicek at the Hard Rock Stadium on Saturday.

With the win, Bopanna surpassed his record created last year when he won the Indian Wells title at the age of 43, and also reclaimed the top spot in the doubles ranking.

"It's amazing. As long as you are doing well in these big events, it's what we play for," Bopanna said after the win.

'I want to do well in the Masters 1000s and the Grand Slams. It's good to keep that record going and keep giving everyone else a run for their money," added Bopanna, who won his maiden doubles Grand Slam title at the Australian Open earlier this year.

This was Bopanna's 14th ATP Masters 1000 final. Overall, it was the veteran Indian player's 63rd ATP Tour level final and

### Mirabai to return to action after 6-month injury layoff with eye on Olympic berth

An appearance at the World Cup on Monday will be enough for her to seal her passage to Paris as the former world champion is ranked second in the

49kg women's Olympic Qualifica-Ranking (OOR) behind China's Jian HuiHua.

Under the 2 0 2 4 Olympics qualification rules. the Champi onships and the 2024 World Cup compulsory

Apart from these two tournaments, a lifter must participate in at least three of the following events - the 2022 World Championships, the 2023 Continental Championships, the 2023 Grand Prix 1, the 2023 Grand Prix II and the 2024 Continental Champi-

Chanu has fulfilled the criteria. She competed at the 2022 World Championship and the 2023 Asian Championships, finishing second and sixth respectively.

At the 2023 Worlds and Grand Prix II, she did not heave the barbell due to her injury but completed all the necessary formalities to remain eligible for the Paris Games. At the end of the World Cup, the top 10 lifters, who have met the criteria, will qualify for The best three performances at

the qualifying events will be taken into account for final assessment and Chanu's came at the 2022 Worlds where she lifted a total of 200kg (87kg+113kg).

The Manipuri lifter, who has struggled with injuries in the past two years, has registered an entry weight of 185kg, far from her perbest (88kg+119kg).

# Struggling Mumbai Indians look for happy homecoming against Rajasthan Royals in IPL



MUMBAI, March 31: IPL's hard ways that come to the perennial slow-starters Mumbai Indians under new captain Hardik Pandya will hope for a happy homecoming when they take on a confident Rajasthan Royals at the Wankhede Stadium here on Mon-

Despite the change at the helm with Pandya replacing five-time title-winning skipper Rohit Sharma - a move that has sparked brutal attack on the former -- Mumbai Indians have once again made a familiar disappointing start to their IPL campaign as they lost their first two matches.

A six-run defeat to Pandya's former team Gujarat Titans was followed by a walloping by Sunrisers Hyderabad who won the record run-fest by 32 runs in Hyderabad, with Mumbai Indians plummeting to the last spot in the 10-team

points table. These are still early days in the 17th edition of the T20 league but Pandya's Mumbai Indians will need to end their losing streak and improve their Net Run Rate which is the worst among all teams at -

Among the odds stacked up against them is the absence of Suryakumar Yadav, who remains on the sidelines as he is recovering from two separate injuries which have kept him away from the MI camp this IPL.

Even though Mumbai Indians enjoy a 4-1 head-to-head record in their last five meetings with Rajasthan Royals, the home side will have a tough task at hand given Sanju Samson's team has turned up all guns blazing to begin their IPL season with two wins.

A big score is due from Rohit who has provided strong starts to Mumbai but what they truly need is Pandya to get his decisions right. Pandya has evidently not used Jasprit Bumrah to the best way possible and Mumbai Indians will have a chance to iron out such flaws.

Bumrah and Piyush Chawla bring the element of experience to the table in the MI bowling attack which has shown trust on local boy Shams Mulani, who is relatively new at the IPL stage but immensely experienced when it comes to playing at the Wankhede Stadium.

The young Kwena Maphaka was at the receiving end of the carnage that SRH handed to Mumbai Indians in their last game but the 17-year-old South African will only learn from experience of the

bowlers' way in such a competitive T20 league.

On their part, Rajasthan Royals will look to keep ticking all the boxes after two wins at the start.

Samson remains dangerous in the early stages of the IPL while the immensely talented Yashasvi Jaiswal, who is yet to fire in this IPL, would be keen to get his first big score of this season.

Jaiswal is returning to his home ground where he had blazed a 62ball 124 albeit for a losing cause in their last meeting here, and he will be eager to stamp his class.

Riyan Parag is primed to continue his ascent as a mature middle-order batter, whereas for Mumbai, Tilak Varma, Tim David and Naman Dhir would aim to make the most of their positive

Apart from having a long batting line-up which also boasts of the dangerous Jos Buttler at the top and Dhruv Jurel to provide finishing touches, it is their all-round bowling attack which puts forth a lot of promise.

While Nandre Burger has teamed up well with Trent Boult for early inroads, the spin duo of Ravichandran Ashwin and Yuzvendra Chahal can control the flow of runs in the middle.

Avesh Khan's control at the death along with Sandeep Sharma is Royals' forte and has been among crucial factors for Rajasthan's fine show so far.

### Babar Azam reappointed as Pakistan's white-ball skipper ahead of T20 World Cup will begin on June 1 in the USA

LAHORE, March 31: Star batter Babar Azam was on Sunday reappointed as Pakistan's white-ball captain, two months ahead of the T20 World Cup.

Babar replaces fast bowler Shaheen Shah Afridi as the T20 captain. The pacer has been removed after just one series which Pakistan lost 1-4 to New Zealand in January.

The decision to reinstate Babar was taken after a unanimous recommendation from the Pakistan Cricket Board's (PCB) selection "Following unanimous recom-

mendation from the PCB's selection committee, Chairman PCB Mohsin Naqvi has appointed Babar Azam as white-ball (ODI and T20I) captain of the Pakistan men's cricket team," the PCB said in a media release.

During a recent meeting in Lahore with PCB Chief Naqvi, Babar allegedly sought assurances about his tenure and asked to be appointed captain of the Test side as well.

However, a reliable source within the PCB disclosed that

**NEW DELHI, March 31:** Mayank Yadav guarantees instant destruction of batting lineups. But growing up with the aspirations and anxieties of ordinary Indians, he had had his fair share of struggles while transforming from a frail 15-year-old to a frighteningly quick fast bowler.

His father Prabhu Yadav was always determined to embrace the struggles usually associated with the middle class, in order to see Mayank excel on the cricket field.


Life has changed overnight for the Yadav family from West Delhi's Punjabi Bagh with the 24 deliveries that their 21-year-old son bowled for Lucknow Super Giants in the IPL game against Punjab Kings on a Saturday evening.

Mayank has become the toast of the nation in 15 minutes flat and every Indian cricket fan would pray that he brings glory to the country for the next 15 years.

"If Ustaadji and Devender bhai had not been around, my son wouldn't have come this far. I wanted him to play cricket but they prepared him for all the big tests," Prabhu couldn't thank the late Tarak Sinha (Ustaadji) and current head coach (Sharma) of the famous Sonnet Club enough for their contribution in his son's development.

The 6 feet 1 inch tall Delhi boy, who faced issues with multiple injuries in his short career, turned heads with a 155.8 kmph delivery, the fastest in this edition of IPL.

'People watch IPL and they only saw Mayank yesterday but those who keep track



had bowled a delivery at 155 clicks. It was unfortunate that he suffered from hamstring injury and had to miss the entire Ranji season. I have been saying for past four years that this boy is special," an elated Devender. the man who also shaped the phenomenon called Rishabh Pant, told PTI.

"Last year, twice he called me before IPL games to say that 'sir, I would make my debut today,' and it didn't happen. Today I am very happy. He has made a start but has a long way to go." The national selection committee led by

Ajit Agarkar was keen on having a look at

him during this year's Ranji Trophy which

he was forced to sit out.

Devender recalled the time when and he will succeed," the proud father said. Mayank's father, a small-time businessman with a shop in Delhi's Okhla, brought his son to the famous Sonnet Club when he was around 14. "He looked very frail and didn't even have

bowling spikes, but in Sonnet, if we find any boy to be special in terms of talent, kit and equipment is never a problem. 'At 15, with that weak physique of his, he could generate above average pace for his

His pace might have sent everyone for a tizzy but Devender recalled how he never allowed Mayank to bowl with 'Kanchaas', colloquial term for hard brick-like locally

manufactured red balls often used in Delhi

"The kind of pace he has, I would always fear if he bowls with Kaanchas, he would end up hurting the batters with his raw pace. I always gave him SG balls, which are slightly softer and you play competitive cricket with SG balls," Devender, the former

Delhi Ranji keeper, said.

Mayank's pace is certainly going to excite the national selectors but with processes in place, he would be integrated into the system after he consistently plays for one whole sea-

"He is an exceptional talent and obviously, he is a candidate for exclusive pace bowling contract like Aakash Deep, Umran Malik or Vijavkumar Vyshak. He has to play the full IPL. But he is injury-prone and has to show that he can last a full season including Ranji

"For the time being he would be seen as a

white ball prospect unless he plays Ranji Trophy. But he needs to play India A and smaller bilateral rubbers first," a senior BCCI source told PTI on the condition of On Mayank, England fast-bowling legend
